# Green's function for cut points of chordal SLE attached with boundary arcs

#### Abstract

A technique of two-curve Green's function is used to study the Green's function of cut points of chordal SLE $_{\kappa}$ for $\kappa \in(4,8)$. In order to apply the technique, we take the union of the SLE curve with two open boundary arcs, which share two boundary points other than the endpoints of the SLE curve. The Green's function of interest is, for any $z_{0}$ in the domain, the limit as $r \downarrow 0$ of the $r^{-\alpha}$ times the probability that $\left\{\left|z-z_{0}\right|<r\right\}$ contains a cut point of the above union, where $\alpha=\frac{3}{8} \kappa-1$. We prove the limit exists, obtain an exact formula up to a multiplicative constant, and derive a rate of convergence.


## 1 Introduction and Main Result

The Schramm-Loewner evolution (SLE), first introduced by Oded Schramm in 1999 ([16]), is a one-parameter $(\kappa \in(0, \infty))$ family of measures on plane curves. The SLE with different parameters have been proved to be scaling limits of various lattice models. We refer the reader to Lawler's textbook [5] for basic properties of SLE.

An SLE $_{\kappa}$ curve is simple for $\kappa \in(0,4]$, space-filling for $\kappa \in[8, \infty)$, and non-simple and non-space-filling for $\kappa \in(4,8)$ (cf. [14]). The Hausdorff dimension of an $\operatorname{SLE}_{\kappa}$ curve is $\min \left\{1+\frac{\kappa}{8}, 2\right\}$ (cf. [14, 2]). Suppose $\kappa \in(0,8)$. Then the probability that a chordal SLE $_{\kappa}$ curve $\eta$ exactly passes through any fixed interior point $z_{0}$ in the domain is zero. People were interested in the decay rate of the probability $\mathbb{P}\left[\operatorname{dist}\left(z_{0}, \eta\right)<r\right]$ as $r \downarrow 0$. Specifically, it is about the limit $\lim _{r \downarrow 0} r^{-\alpha} \mathbb{P}\left[\operatorname{dist}\left(z_{0}, \eta\right)<r\right]$, where $\alpha=1-\frac{\kappa}{8}>0$ equals 2 minus the Hausdorff dimension. The limit is called the Green's function for SLE.

A Green's function problem usually includes two parts: proving the existence of the limit and finding the exact formula of the Green's function. The exact formula of the Green's function of chordal SLE was predicted in [14], and the convergence and the formula were proved later in [6. The paper [6] also proves the convergence of two-point Green's function, i.e., the limit

[^0]of the renormalized probability that an $\mathrm{SLE}_{\kappa}$ curve gets close to two distinct points, and uses the one- and two- point Green's functions to prove the existence of Minkowski content of SLE.

Miller and Wu studied (cf. [11]) the Hausdorff dimensions of the sets of double points and cut points of SLE. Among other results, they proved that the Hausdorff dimension of the set of cut points of $\mathrm{SLE}_{\kappa}$ is $3-\frac{3}{8} \kappa$ for $\kappa \in(4,8)$. They derived a Green's function type estimate: for a chordal $\mathrm{SLE}_{\kappa}$ curve $\eta$ and a point $z_{0}$ in the same domain,

\mathbb{P}\left[\eta \text { has a cut point contained in }\left\{\left|z-z_{0}\right|<r\right\}\right]=r^{\alpha_{0}+o(1)}, \quad \text { as } r \downarrow 0 \tag{1.1}
\end{equation*}
$$

where the exponent $\alpha_{0}$ given by

\alpha_{0}=\frac{3}{8} \kappa-1 \tag{1.2}
\end{equation*}
$$

equals 2 minus the Hausdorff dimension of the cut-set, and $o(1) \rightarrow 0$ as $r \downarrow 0$.
The intention of the current paper is to improve the estimate (1.1). Let $\eta$ be a chordal $\mathrm{SLE}_{\kappa}$ curve in a simply connected domain from $a_{1}$ to $a_{2}$. We expect that the limit

\end{equation*}

should converge to a finite positive number. This is inspired by [4, which studies the one-point and two-point Green's functions for cut points of Brownian motion, and uses them to prove the existence of Minkowski content for the set of cut points.

A new technique was introduced in [20], which studies the Green's function of 2-SLE ${ }_{\kappa}$ for $\kappa \in(0,8)$. A $2-$ SLE $_{\kappa}$ configuration is a pair of random curves $\left(\eta_{1}, \eta_{2}\right)$ in a simply connected domain $D$ connecting four marked boundary points such that when any curve is given, the other curve is a chordal $\mathrm{SLE}_{\kappa}$ in a complement domain of the given curve. The Green's function for such $2-\mathrm{SLE}_{\kappa}$ at $z_{0} \in D$ is the limit $\lim _{r \downarrow 0} r^{-\alpha} \mathbb{P}\left[\eta_{j} \cap\left\{\left|z-z_{0}\right|<r\right\} \neq \emptyset, j=1,2\right]$, where $\alpha>0$ is given by $\frac{(12-\kappa)(\kappa+4)}{8 \kappa}$. Such a limit turns out to converge to a positive number, whose value can be described using a hypergeometric function.

The main idea in [20] is the following. Assume that $D=\mathbb{D}:=\{|z|<1\}$ and $z_{0}=0$ by conformal invariance. Suppose $\eta_{j}$ connects $a_{j}$ with $b_{j}, j=1,2$, and $a_{1}, b_{1}, a_{2}, b_{2}$ are oriented clockwise. After a reduction we may assume that $b_{1}=1$ and $b_{2}=-1$. Then we simultaneously grow $\eta_{1}$ and $\eta_{2}$ respectively from $a_{1}$ and $a_{2}$ with some random speeds such that at any time $t$ before the process stops,
( C 1 ) the conformal radius of the remaining domain viewed from 0 is $e^{-t}$, and
(C2) 1 and -1 equally split the harmonic measure of the remaining domain viewed from 0 .
The process stops at some time $T$ when the two curves together disconnect 0 from any of $b_{1}, b_{2}$. By Koebe's $1 / 4$ theorem and Beurling's estimate, we then know that for any $t \in[0, T)$, $\max \left\{\operatorname{dist}\left(0, \eta_{j}[0, t]\right), j=1,2\right\} \asymp e^{-t}$. After the time $T$, the two curves will not both get closer to 0 , and so $\max \left\{\operatorname{dist}\left(0, \eta_{j}\right), j=1,2\right\} \asymp e^{-T}$.

Thus, the original limit problem is transformed into finding the decay rate of $\mathbb{P}[T>s]$ as $s=-\log (r) \rightarrow \infty$. For any $t \in[0, T)$, one may find a conformal map, which maps the
remaining domain at $t$ conformally onto $\mathbb{D}$, and fixes $0,1,-1$. Then $\eta_{1}(t)$ and $\eta_{2}(t)$ are mapped to $e^{i Z_{1}(t)}$ and $-e^{i Z_{2}(t)}$ for some $Z_{1}(t), Z_{2}(t) \in(0, \pi)$. The $\left(Z_{1}, Z_{2}\right)$ is a two-dimensional diffusion process with lifetime $T$. The explicit transition density of this process was derived in [20] using Itô's calculus and orthogonal polynomials of two variables, which implies the key estimate that there is a function $G$ on $(0, \pi)^{2}$ such that if $\left(Z_{1}, Z_{2}\right)$ starts from $\left(z_{1}, z_{2}\right)$, then $P[T>s]=$ $G\left(z_{1}, z_{2}\right) e^{-\alpha_{1} s}\left(1+O\left(e^{-\beta s}\right)\right)$ for some constant $\beta>0$. Such an estimate was then used to prove the convergence of the Green's function.

The two-curve technique in [20] was later used in [19] to study the existence of Green's function for 2-SLE ${ }_{\kappa}$ at a boundary point. The results of [20, 19] may serve as the first few steps in proving the existence of Minkowski content of double points of $\mathrm{SLE}_{\kappa}$.

In the current paper, we are going to apply the two-curve technique to study the cut point Green's function. Let $D$ be a Jordan domain, and $a_{1} \neq a_{2} \in \partial D$. Let $\kappa \in(4,8)$, and $\gamma_{1}$ be a chordal $\mathrm{SLE}_{\kappa}$ curve in $D$ from $a_{1}$ to $a_{2}$. In order to apply the technique, we introduce two other points $b_{1}, b_{2} \in \partial D$ such that $b_{j}$ lies on the open boundary arc of $D$ from $a_{j}$ to $a_{3-j}$ in the clockwise direction. Let $A_{j}$ be the open boundary arc of $D$ with end points $b_{1}, b_{2}$ that contains $a_{j}, j=1,2$. Instead of considering the Green's function for cut points of $\gamma_{1}$, we study the Green's function for the cut points of the union $\gamma_{1} \cup A_{1} \cup A_{2}$. This is a compromise we have to make now in order to apply the two-curve technique in [20]. Our main theorem is the following.

Theorem 1.1. Let $z_{0} \in D$ and $R=\operatorname{dist}\left(z_{0}, D^{c}\right)$. Let $f$ be a conformal map from $D$ onto $\mathbb{D}$ such that $f\left(z_{0}\right)=0$. Let $w_{j}, v_{j} \in \mathbb{R}$ be such that $e^{i w_{j}}=f\left(a_{j}\right)$ and $e^{i v_{j}}=f\left(b_{j}\right), j=1,2$. Let $\alpha_{0}$ be as in (1.2). Define $G_{D ; a_{1}, b_{1}, a_{2}, b_{2}}\left(z_{0}\right)=\left|f^{\prime}\left(z_{0}\right)\right|^{\alpha_{0}} \widetilde{G}\left(w_{1}, v_{1}, w_{2}, v_{2}\right)$, where

\widetilde{G}\left(w_{1}, v_{1}, w_{2}, v_{2}\right):=\left|\sin \left(\frac{w_{1}-w_{2}}{2}\right)\right|^{\frac{8}{\kappa}-1}\left|\sin \left(\frac{v_{1}-v_{2}}{2}\right)\right|^{\frac{(\kappa-4)^{2}}{2 \kappa}} \prod_{j=1}^{2} \prod_{s=1}^{2}\left|\sin \left(\frac{w_{j}-v_{s}}{2}\right)\right|^{1-\frac{4}{\kappa}} \tag{1.4}
\end{equation*}
$$

Let $\beta_{0}=1-\frac{8}{5 \kappa}$. Then there is a positive constant $C_{0}$ depending only on $\kappa$ such that

\mathbb{P}\left[\gamma_{1} \cup A_{1} \cup A_{2} \text { has a cut point contained in }\left\{\left|z-z_{0}\right|<r\right\}\right] \\
\quad=C_{0} G_{D ; a_{1}, b_{1}, a_{2}, b_{2}}\left(z_{0}\right) r^{\alpha_{0}}\left(1+O(r / R)^{\beta_{0}}\right), \quad \text { as } r / R \downarrow 0 .
\end{gathered}
$$

Here the implicit constants in the $O(\cdot)$ symbol depend only on $\kappa$.
We will basically follow the approach in [20]. First suppose $D=\mathbb{D}, z_{0}=0, b_{1}=1$, and $b_{2}=-1$. Let $\gamma_{2}$ be a time-reversal of $\gamma_{1}$, which by reversibility of $\operatorname{SLE}_{\kappa}$ (cf. [9]) is a chordal $\operatorname{SLE}_{\kappa}$ in $\mathbb{D}$ from $a_{2}$ to $a_{1}$. We then grow $\gamma_{1}$ and $\gamma_{2}$ simultaneously respectively from $a_{1}$ and $a_{2}$ with random speeds such that at any time $t$ before the first time $T$ that $A_{1} \cup \eta_{1}[0, T]$ intersects $A_{2} \cup \eta_{2}[0, T]$, Conditions (C1) and (C2) are both satisfied. By mapping the remaining domain conformally onto $\mathbb{D}$ with $0,1,-1$ fixed, we obtain a two-dimensional diffusion process $\left(Z_{1}(t), Z_{2}(t)\right)$ taking values in $(0, \pi)^{2}$. We then use orthogonal polynomials to derive the transition density of $\left(Z_{1}, Z_{2}\right)$, and use it to prove Theorem 1.1.

This paper can be viewed as the first step of proving the existence of Minkowski content of cut points of SLE. For that purpose, following the approach of [6], we will also need the ordered two-point Green's function, i.e., for $z_{1} \neq z_{2} \in D$, the limit

\lim _{r_{1}, r_{2} \downarrow 0} r_{1}^{-\alpha_{0}} r_{2}^{-\alpha_{0}} \mathbb{P}\left[\gamma_{1} \text { first visits a cut point of } \gamma_{1} \cup A_{1} \cup A_{2} \text { in }\left\{\left|z-z_{1}\right|<r_{1}\right\}\right.
$$

and then visits a cut point of $\gamma_{1} \cup A_{1} \cup A_{2}$ in $\left.\left\{\left|z-z_{2}\right|<r_{2}\right\}\right]$.

The first result on two-point Green's functions was derived in [8], where the ordered twopoint Green's function for a chordal SLE SL $_{\kappa}$ curve $\gamma_{1}$ in $D$ from $a_{1}$ to $a_{2}$ is expressed as

G_{D ; a_{1}, a_{2}}\left(z_{1}\right) \cdot \mathbb{E}\left[G_{D_{\gamma_{*}} ; z_{1}, a_{2}}\left(z_{2}\right)\right]
$$

where $G_{D ; a_{1}, a_{2}}$ is the one-point Green's function for $\gamma_{1}, D_{\gamma_{*}}$ is the complement domain of a random curve $\gamma_{*}$ in $D$ whose boundary contains $a_{2}$, where $\gamma_{*}$ is the first arm of a two-sided radial $\mathrm{SLE}_{\kappa}$ curve in $D$ from $a_{1}$ to $a_{2}$ via $z_{1}$, which is also a radial $\operatorname{SLE}_{\kappa}(2)$ curve in $D$ from $a_{1}$ to $z_{1}$ with the force point at $a_{2}$, and the expectation is with respect to the randomness of $\gamma_{*}$. Here the $\operatorname{SLE}_{\kappa}(2)$ curve $\gamma_{*}$ can be intuitively viewed as the chordal $\operatorname{SLE}_{\kappa}$ curve $\gamma_{1}$ conditioned on the singular event that it passes through $z_{1}$, and $z_{1}$ is a boundary point of $D_{\gamma_{*}}$.

Thus, we expect that the ordered two-point Green's function for cut points of $\gamma_{1} \cup A_{1} \cup A_{2}$ can be expressed as the product

$$
G_{D ; a_{1}, b_{1}, a_{2}, b_{2}}\left(z_{1}\right) \cdot \mathbb{E}\left[G_{D_{\gamma_{*}} ; z_{1}, b_{1}, a_{2}, b_{2}}\left(z_{2}\right)\right]
$$

where $G_{D ; a_{1}, b_{1}, a_{2}, b_{2}}$ is the (one-point) Green's function as in Theorem 1.1, $D_{\gamma_{*}}$ is the complement domain of a random curve $\gamma_{*}$ in $D$ whose boundary contains $a_{2}$, where $\gamma_{*}$ is an $\operatorname{SLE}_{\kappa}(2, \kappa-$ $4, \kappa-4)$ curve in $D$ from $a_{1}$ to $z_{1}$ with force points at $a_{2}, b_{1}, b_{2}$. We will see later in Section 3.2 .3 that such an $\operatorname{SLE}_{\kappa}(2, \kappa-4, \kappa-4)$ curve $\gamma_{*}$ can be intuitively viewed as the chordal SLE $_{\kappa}$ curve $\gamma_{1}$ conditioned on the singular event that $\gamma_{1} \cup A_{1} \cup A_{2}$ has a cut point at $z_{1}$.

One may also consider the boundary Green's function for cut points of SLE. This is the limit of (1.3) in the case that $z_{0}$ is a boundary point. Here $\alpha_{0}$ should be replaced by another exponent $\alpha_{1}$, and $\partial D$ is assumed to be analytic near $z_{0}$. Similarly as in [8], the boundary Green's function for cut points may be used to study the two-point cut point Green's function. While the existence of the boundary Green's function for cut points is beyond reach now, the technique of this paper may be used to prove the convergence of the limit:

\lim _{r \downarrow 0} r^{-1} \mathbb{P}\left[\gamma_{1} \cup A_{1} \cup A_{2} \text { has a cut point contained in }\left\{\left|z-b_{1}\right|<r\right\}\right]
$$

where $b_{1}, b_{2}, A_{1}, A_{2}$ are as before. This means that we set $b_{1}=z_{0}$, and take $\alpha_{1}=1$.
Theorem 1.1 does not immediately imply the convergence of the original limit (1.3), which motivated this paper. We made the problem easier by adding two marked boundary points. One approach to attack the original problem is to add two more marked boundary points, which
means that the attached boundary arcs do not share end points. In that case the formula of the Green's function is expected to be a multivariable special function.

We believe that the limit (1.3) does converge. We may consider the simple case that $D=$ $\mathbb{H}=\{\operatorname{Im} z>0\}, a_{1}=0$ and $a_{2}=\infty$. By the scaling property and reflection symmetry of SLE, there is a positive function $S(\theta)$ on $(0, \pi)$, which is symmetric about $\pi / 2$, such that $G_{\mathbb{H} ; 0, \infty}(z)=|z|^{-\alpha_{0}} S(\arg z)$. To get the explicit formula of $G$, we need to find out the formula of $S$. The boundary exponent $\alpha_{1}=1$ suggests that $\lim _{\theta \downarrow 0} S(\theta) / \theta$ is finite and positive.

Below is a sketch of the rest of the paper. In Section 2, we review Loewner equations and two-time-parameter stochastic processes. In Section 3, we recall the setup and results from [20, Sections $3,4,5$ ] with suitable modifications to fit the setting here. We then prove Theorem 1.1 in Section 4. In the appendix, we give a detailed proof of a two directional domain Markov property for chordal SLE $_{\kappa}$ which satisfies reversibility.

## 2 Preliminary

Let $\mathbb{H}=\{z \in \mathbb{C}: \operatorname{Im} z>0\}$ and $\mathbb{D}=\{z \in \mathbb{C}:|z|<1\}$. Let $J(z)=-1 / z$. By $f: D \xrightarrow{\text { Conf }} E$ we mean that $f$ maps $D$ conformally onto $E$. Let $\cot _{2}, \sin _{2}, \cos _{2}, \tan _{2}$ denote the functions $\cot (\cdot / 2), \sin (\cdot / 2), \cos (\cdot / 2), \tan (\cdot / 2)$, respectively.

### 2.1 Prime ends

For the sake of rigor, we will use the notion of prime ends (cf. [1]). We prefer the description used in [25]. Let $D$ be a simply connected domain. Consider the set of pairs $(f, \zeta)$, where $f: D \xrightarrow{\text { Conf }} \mathbb{D}$, and $\zeta \in \overline{\mathbb{D}}$. Such a set is nonempty by Riemann mapping theorem. Define an equivalence relation " $\sim$ " on this set such that $\left(f_{1}, \zeta_{1}\right) \sim\left(f_{2}, \zeta_{2}\right)$ if (the continuation of) $f_{2} \circ f_{1}^{-1}$ maps $\zeta_{1}$ to $\zeta_{2}$. The set of $(f, \zeta)$ modulo the equivalence relation is called the prime end closure of $D$, which is equipped with a unique metrizable topology such that for any $f: D \xrightarrow{\text { Conf }} \mathbb{D}$, the map $[(f, \zeta)] \mapsto \zeta$ is a homeomorphism from $\widehat{D}$ onto $\overline{\mathbb{D}}$. Note that $z \mapsto[(f, f(z))]$ is an embedding from $D$ into $\widehat{D}$. We identify $D$ as an open subset of $\widehat{D}$ by identifying $z \in D$ with $[(f, f(z))]$, which does not depend on the choice of $f$. We call $\widehat{\partial} D:=\widehat{D} \backslash D$ the prime end boundary of $D$, and every $p \in \widehat{\partial} D$ a prime end of $D$. If $g: D_{1} \xrightarrow{\text { Conf }} D_{2}$, then $g$ induces a homeomorphism $g:[(f, \zeta)] \mapsto\left[\left(f \circ g^{-1}, \zeta\right)\right]$ from $\widehat{D}_{1}$ onto $\widehat{D}_{2}$, which maps $\widehat{\partial} D_{1}$ onto $\widehat{\partial} D_{2}$.

Let $\bar{D}^{\#}$ be the closure of $D$ in the Riemann sphere $\widehat{\mathbb{C}}:=\mathbb{C} \cup\{\infty\}$, and $\partial^{\#} D=\bar{D}^{\#} \backslash D$. Let $\zeta \in \partial^{\#} D$ (a point in $\widehat{\mathbb{C}}$ ) and $p \in \widehat{\partial} D$ (a prime end of $D$ ). If $z \in D$ and $z \rightarrow p$ (w.r.t. the topology of $\widehat{D}$ ) implies that $z \rightarrow \zeta$ (w.r.t. the metric of $\widehat{\mathbb{C}}$ ), then we say that $\zeta$ is determined by $p$. On the other hand, if $z \in D$ and $z \rightarrow \zeta$ implies that $z \rightarrow p$, then we say that $\zeta$ determines $p$. If $p$ and $\zeta$ determine each other, then we do not distinguish them. For example, if $D$ is a Jordan domain in $\widehat{\mathbb{D}}$ such as $\mathbb{D}$ or $\mathbb{H}$, then every $p \in \widehat{D}$ is identified with a point $\zeta \in \partial^{\#} D$.

Suppose $\widetilde{D} \subset D$ are two simply connected domains. Let $p$ be a prime end of $D$. If $\widetilde{D}$ is a neighborhood of $p$ in $D$, i.e., the intersection of $D$ and a neighborhood of $p$ in $\widehat{D}$, then by

Schewarz reflection principle, there is a unique prime end $\widetilde{p}$ of $\widetilde{D}$ such that for $z \in \widetilde{D}, z \rightarrow p$ in $D$ iff $z \rightarrow \widetilde{p}$ in $\widetilde{D}$. When this happens, we do not distinguish $\widetilde{p}$ from $p$, and say that $D$ and $\widetilde{D}$ share the prime end $p$.

### 2.2 Chordal Loewner equations

A relatively closed subset $K$ of $\mathbb{H}$ is called an $\mathbb{H}$-hull if $K$ is bounded and $\mathbb{H} \backslash K$ is a simply connected domain, and $\mathbb{H} \backslash K$ is called an $\mathbb{H}$-domain. For an $\mathbb{H}$-hull $K$, there is a unique $g_{K}: \mathbb{H} \backslash K \xrightarrow{\text { Conf }} \mathbb{H}$ such that $g_{K}(z)=z+\frac{c}{z}+O\left(1 / z^{2}\right)$ as $z \rightarrow \infty$ for some $c \geq 0$. The constant $c$, denoted by hcap $(K)$, is called the $\mathbb{H}$-capacity of $K$, which is zero iff $K=\emptyset$. We write hcap ${ }_{2}$ for hcap $(\cdot / 2)$. For a set $S \subset \mathbb{C}$, if there is an $\mathbb{H}$-hull $K$ such that $\mathbb{H} \backslash K$ is the unbounded connected component of $\mathbb{H} \backslash \bar{S}$, then we say that $K$ is the $\mathbb{H}$-hull generated by $S$, and write $K=\operatorname{Hull}(S)$. In this case we write $\operatorname{hcap}(S)$ and $\operatorname{hcap}_{2}(S)$ respectively for $\operatorname{hcap}(K)$ and $\operatorname{hcap}_{2}(K)$.

Let $\widehat{w} \in C([0, T), \mathbb{R})$ for some $T \in(0, \infty]$. The chordal Loewner equation driven by $\widehat{w}$ is

$$
\partial_{t} g_{t}(z)=\frac{2}{g_{t}(z)-\widehat{w}(t)}, \quad 0 \leq t<T ; \quad g_{0}(z)=z .
$$

For a fixed $z \in \mathbb{C}$, this is an ODE in $t$ with initial value at 0 . Let $\tau_{z} \in(0, \infty]$ be such that $\left[0, \tau_{z}\right)$ is the maximal interval of the solution. For $t \in[0, T)$, let $K_{t}=\left\{z \in \mathbb{H}: \tau_{z} \leq t\right\}$. It turns out that each $K_{t}$ is an $\mathbb{H}$-hull with $\operatorname{hcap}_{2}\left(K_{t}\right)=t$, and each $g_{t}$ agrees with the $g_{K_{t}}$ associated with $K_{t}$. We call $g_{t}$ and $K_{t}$ the chordal Loewner maps and hulls, respectively, driven by $\widehat{w}$.

If for every $t \in[0, T), g_{t}^{-1}$ extends continuously to $\overline{\mathbb{H}}$, and $\eta(t):=g_{t}^{-1}(\widehat{w}(t)), 0 \leq t<T$, is a continuous curve, then we say that $\eta$ is the chordal Loewner curve driven by $\widehat{w}$. Such $\eta$ may not exist in general. When it exists, we have $\eta(0)=\widehat{w}(0) \in \mathbb{R}, \eta(t) \in \overline{K_{t}} \subset \overline{\mathbb{H}}$ and $K_{t}=\operatorname{Hull}(\eta[0, t])$ for all $0 \leq t<T$. On the other hand, if there is a continuous curve $\eta$ such that $K_{t}=\operatorname{Hull}(\eta[0, t])$ for each $0 \leq t<T$, then $\eta$ is the chordal Loewner curve driven by $\widehat{w}$. For every $t_{0} \in[0, T)$, the set $S_{t_{0}}:=\left(t_{0}, T\right) \cap \eta^{-1}\left(\mathbb{H} \backslash K_{t_{0}}\right)$ is dense in $\left[t_{0}, T\right)$, and as $t \rightarrow t_{0}$ along $S_{t_{0}}, g_{t_{0}}(\eta(t)) \rightarrow \widehat{w}\left(t_{0}\right)$, and so $\eta(t)$ tends to the prime end $g_{t_{0}}^{-1}\left(\widehat{w}\left(t_{0}\right)\right)$ of $\mathbb{H} \backslash K_{t_{0}}$. When there is no ambiguity, we also use $\eta(t)$ to denote the prime end $g_{t}^{-1}(\widehat{w}(t))$ of $\mathbb{H} \backslash K_{t}$.

For $\kappa \in(0, \infty)$, chordal SLE $_{\kappa}$ is defined by solving the chordal Loewner equation with the driving function being $\widehat{w}(t)=\sqrt{\kappa} B(t), 0 \leq t<\infty$, where $B$ is a standard linear Brownian motion. It is known (cf. [14, 7]) that a.s. $\widehat{w}$ generates a chordal Loewner curve $\eta$, which satisfies $\eta(0)=\widehat{w}(0)=0$ and $\lim _{t \rightarrow \infty} \eta(t)=\infty$. Such $\eta$ is called a chordal SLE $_{\kappa}$ curve in $\mathbb{H}$ from 0 to $\infty$, or a standard chordal SLE $_{\kappa}$. If $D$ is a simply connected domain with two distinct prime ends $a, b$, then there is a conformal map $f$ from $\mathbb{H}$ onto $D$ such that $f(0)=a$ and $f(\infty)=b$. Then the $f$-image of a standard chordal $\mathrm{SLE}_{\kappa}$, which is a continuous curve in the prime end closure of $D$, is called an $\operatorname{SLE}_{\kappa}$ curve in $D$ from $a$ to $b$. Whenever $\partial^{\#} D$ is locally connected, the chordal $\mathrm{SLE}_{\kappa}$ is also a curve in the spherical closure of $D$.

Chordal SLE $_{\kappa}$ satisfies the following DMP (domain Markov property, cf. [5). Let $\eta$ be a chordal $\mathrm{SLE}_{\kappa}$ curve in $D$ from $a$ to $b$. Let $\mathcal{A}$ be a $\sigma$-algebra independent of $\eta$, and $\mathcal{F}^{\mathcal{A}}$ be the usual (complete and right continuous) augmentation of the filtration $\left(\sigma\left(\eta_{1}(s): s \leq t\right) \vee \mathcal{A}\right)_{t \geq 0}$.

Then for any $\mathcal{F}^{\mathcal{A}}$-stopping time $T$, conditionally on $\mathcal{F}_{T}^{\mathcal{A}}$ and the event $\{T<\infty\}, \eta(T+\cdot)$ is a chordal $\mathrm{SLE}_{\kappa}$ curve from (the prime end) $\eta(T)$ to $b$ in the connected component of $D \backslash \eta[0, T]$ which shares the prime end $b$ with $D$. This follows easily from the Markov property of the (rescaled) Brownian motion $\sqrt{\kappa} B_{t}$.

For $\kappa \in(0,8]$, chordal SLE $_{\kappa}$ satisfies reversibility (cf. [7] for $\kappa=8$, [24] for $\kappa \in(0,4]$, and [9] for $\kappa \in(4,8))$. This means that, if $\eta$ is a chordal SLE $_{\kappa}$ curve in $D$ from $a$ to $b$, then any time-reversal of $\eta$ is a time-change of a chordal SLE $_{\kappa}$ curve in $D$ from $b$ to $a$.

### 2.3 Radial Loewner equations

A relatively closed subset $K$ of $\mathbb{D}$ is called a $\mathbb{D}$-hull if $\mathbb{D} \backslash K$ is a simply connected domain that contains 0 . For an $\mathbb{D}$-hull $K$, there is a unique conformal map $g_{K}$ from $\mathbb{D} \backslash K$ onto $\mathbb{D}$ such that $g_{K}(0)=0$ and $g_{K}^{\prime}(0) \geq 1$. The constant $\log \left|g_{K}^{\prime}(0)\right| \geq 0$ is called the $\mathbb{D}$-capacity of $K$ and is denoted by $\operatorname{dcap}(\underline{K})$. For a set $S \subset \mathbb{C}$, if there is a $\mathbb{D}$-hull $K$ such that $D \backslash K$ is the connected component of $\mathbb{D} \backslash \bar{S}$ that contains 0 , then we say that $K$ is the $\mathbb{D}$-hull generated by $S$, and write $K=\operatorname{Hull}(S), \operatorname{dcap}(S)=\operatorname{dcap}(K)$, and $g_{S}=g_{K}$.

Let $\widehat{w} \in C([0, T), \mathbb{R})$ for some $T \in(0, \infty]$. The radial Loewner equation driven by $\widehat{w}$ is

$$
\partial_{t} g_{t}(z)=g_{t}(z) \frac{e^{i \hat{w}(t)}+g_{t}(z)}{e^{\hat{\widehat{w}}(t)}-g_{t}(z)}, \quad 0 \leq t<T ; \quad g_{0}(z)=z
$$

For $z \in \mathbb{C}$, let $\tau_{z} \in(0, \infty]$ be such that $\left[0, \tau_{z}\right)$ is the maximal interval of the solution. For $t \in[0, T)$, let $K_{t}=\left\{z \in \mathbb{D}: \tau_{z} \leq t\right\}$. It turns out that each $K_{t}$ is an $\mathbb{D}$-hull with dcap $\left(K_{t}\right)=t$, and each $g_{t}$ agrees with the $g_{K_{t}}$ associated with $K_{t}$. We call $g_{t}$ and $K_{t}$ the radial Loewner maps and hulls, respectively, driven by $\widehat{w}$. By the Schwarz lemma and Koebe's $1 / 4$ theorem, we have $e^{-t} / 4 \leq \operatorname{dist}\left(0, K_{t}\right) \leq e^{-t}$ for $0<t<T$.

If for every $t \in[0, T), g_{t}^{-1}$ extends continuously to $\overline{\mathbb{D}}$, and $\eta(t):=g_{t}^{-1}\left(e^{i \widehat{w}(t)}\right), 0 \leq t<T$, is a continuous curve, then we say that $\eta$ is the radial Loewner curve driven by $\widehat{w}$. Such $\eta$ may not exist in general. When it exists, we have $\eta(0)=e^{i \widehat{w}(0)} \in \partial \mathbb{D}, \eta(t) \in \overline{K_{t}} \subset \overline{\mathbb{D}}$, and $K_{t}=\operatorname{Hull}(\eta[0, t])$ for all $0 \leq t<T$. On the other hand, if there is a continuous curve $\eta$ such that $K_{t}=\operatorname{Hull}(\eta[0, t])$ for each $t \in[0, T)$, then $\eta$ is the radial Loewner curve driven by $\widehat{w}$. When there is no ambiguity, we also use $\eta(t)$ to denote the prime end $g_{t}^{-1}\left(e^{i \widehat{w}(t)}\right)$ of $\mathbb{D} \backslash K_{t}$.

We will use covering radial Loewner equations. Let $e^{i}$ denote the map $z \mapsto e^{i z}$, which maps $\mathbb{H}$ onto $\mathbb{D} \backslash\{0\}$. Let $\widehat{w} \in C([0, T), \mathbb{R})$. The covering radial Loewner equation driven by $\widehat{w}$ is

$$
\partial_{t} \widetilde{g}_{t}(z)=\cot _{2}\left(\widetilde{g}_{t}(z)-\widehat{w}(t)\right), \quad \widetilde{g}_{0}(z)=z .
$$

For each $0 \leq t<T$, let $\widetilde{K}_{t}=\left\{z \in \mathbb{H}: \widetilde{\tau}_{z} \leq t\right\}$, where $\widetilde{\tau}_{z}$ is such that $\left[0, \widetilde{\tau}_{z}\right)$ is the maximal interval of the solution. We call $\widetilde{g}_{t}$ and $\widetilde{K}_{t}$ respectively the covering radial Loewner maps and hulls driven by $\widehat{w}$. If $g_{t}$ and $K_{t}$ are respectively the radial Loewner maps and hulls driven by the same $\widehat{w}$, then $\widetilde{K}_{t}=\left(e^{i}\right)^{-1}\left(K_{t}\right)$ and $e^{i} \circ \widetilde{g}_{t}=g_{t} \circ e^{i}$ for all $0 \leq t<T$.

If there is a continuous and strictly increasing function $u$ on $[0, T)$ with $u(0)=0$, such that $K_{u^{-1}(t)}$ and $g_{u^{-1}(t)}, 0 \leq t<u(T)$, are respectively the radial Loewner hulls and maps driven by
$\widehat{w} \circ u^{-1}$, then we say that $K_{t}$ and $g_{t}$ are respectively radial Loewner hulls and maps with speed $d u$ (understood as a measure) driven by $\widehat{w}$. If $u$ is absolutely continuous and $u^{\prime}=q$, we also say that the speed is $q$. We similarly define radial Loewner curve and covering radial Loewner hulls and maps with some speed. If $\eta$ is a radial Loewner curve with some speed, then we also understand $\eta(t)$ as the prime end $g_{\eta[0, t]}^{-1}(\widehat{w}(t))$ of $\mathbb{H} \backslash \operatorname{Hull}(\eta[0, t])$.

We now recall radial $\operatorname{SLE}_{\kappa}(\underline{\rho})$ processes, where $\kappa>0$ and $\underline{\rho}=\left(\rho_{1}, \ldots, \rho_{m}\right) \in \mathbb{R}^{m}$ for some $m \in \mathbb{N} \cup\{0\}$. Let $e^{i w}, e^{i v_{1}}, \ldots, e^{i v_{m}}$ be distinct points on $\partial \mathbb{D}$. A radial $\operatorname{SLE}_{\kappa}(\underline{\rho})$ curve in $\mathbb{D}$ started from $e^{i w}$ aimed at 0 with force points $e^{i v_{1}}, \ldots, e^{i v_{m}}$ is the radial Loewner curve driven by $\widehat{w}(t), 0 \leq t<\widehat{T}$, which solves the SDE:

$$
d \widehat{w}(t)=\sqrt{\kappa} d B_{t}+\sum_{j=1}^{m} \frac{\rho_{j}}{2} \cot _{2}\left(\widehat{w}(t)-\widetilde{g}_{t}^{\widehat{w}}\left(v_{j}\right)\right) d t, \quad \widehat{w}(0)=w
$$

where $B$ is a standard Brownian motion, and $\widetilde{g}_{t}^{\widehat{w}}$ are covering radial Loewner maps driven by $\widehat{w}$. The process stops whenever the solution $t \mapsto \widehat{g}_{t}^{\widehat{w}}\left(v_{j}\right)$ blows up for any $j$. The radial $\operatorname{SLE}_{\kappa}(\underline{\rho})$ curve, whose existence follows from the Girsanov Theorem (cf. [15]), starts from $e^{i w}$, and may or may not end at 0 (depending on $\kappa$ and $\underline{\rho}$ ). The following proposition is [20, Lemma 3.4].

Proposition 2.1. Let $\kappa>0, n \in \mathbb{N}$. Suppose $\underline{\rho}=\left(\rho_{1}, \ldots, \rho_{n}\right) \in \mathbb{R}^{n}$ satisfies $\rho_{1}, \rho_{n} \geq \frac{\kappa}{2}-2$ and $\rho_{k} \geq 0,1 \leq k \leq n$. Let $e^{i w}, e^{i v_{1}}, \ldots, e^{i v_{n}}$ be distinct points on $\mathbb{T}$ such that $w>v_{1}>\cdots>$ $v_{n}>w-2 \pi$. Let $\eta(t), 0 \leq t<T$, be a radial $S L E_{\kappa}(\underline{\rho})$ curve in $\mathbb{D}$ started from $e^{i w}$ aimed at 0 with force points $e^{i v_{1}}, \ldots, e^{i v_{n}}$. Then a.s. $T=\infty, 0$ is a subsequential limit of $\eta(t)$ as $t \rightarrow \infty$, and $\eta$ does not hit the arc $J:=\left\{e^{i \theta}: v_{1} \geq \theta \geq v_{n}\right\}$.

### 2.4 Two-parameter stochastic processes

Now we recall the results in [20, Section 2.3]. We assign a partial order $\leq$ to $\mathbb{R}_{+}^{2}=[0, \infty)^{2}$ such that $\underline{t}=\left(t_{1}, t_{2}\right) \leq\left(s_{1}, s_{2}\right)=\underline{s}$ iff $t_{j} \leq s_{j}, j=1,2$. The minimal element of $\mathbb{R}_{+}^{2}$ is $\underline{0}=(0,0)$. We write $\underline{t}<\underline{s}$ if $t_{j}<s_{j}, j=1,2$. We define $\underline{t} \wedge \underline{s}=\left(t_{1} \wedge s_{1}, t_{2} \wedge s_{2}\right)$. Given $\underline{t}, \underline{s} \in \mathbb{R}_{+}^{2}$, we define $[\underline{t}, \underline{s}]=\left\{\underline{r} \in \mathbb{R}_{+}^{2}: \underline{t} \leq \underline{r} \leq \underline{s}\right\}$. Let $\underline{e}_{1}=(1,0)$ and $\underline{e}_{2}=(0,1)$. So $\left(t_{1}, t_{2}\right)=t_{1} \underline{e}_{1}+t_{2} \underline{e}_{2}$. For a function $X$ defined on a subset $U$ of $\mathbb{R}_{+}^{2}, j \in\{1,2\}$, and $t_{j} \in \mathbb{R}_{+}$, we use $\left.X\right|_{t_{j}} ^{j}(t)$ to denote the function $t \mapsto X\left(t_{j} \underline{e}_{j}+t \underline{e}_{3-j}\right)$, whose domain is those $t \in \mathbb{R}_{+}$such that $t_{j} \underline{e}_{j}+t \underline{e}_{3-j} \in U$.

Definition 2.2. Let $\mathcal{F}_{\underline{t}}, \underline{t} \in \mathbb{R}_{+}^{2}$, be a family of $\sigma$-algebras on a measurable space $\Omega$ such that $\mathcal{F}_{\underline{t}} \subset \mathcal{F}_{\underline{s}}$ whenever $\underline{t} \leq \underline{s}$. Then we call $\left(\mathcal{F}_{\underline{t}}\right)_{\underline{t} \in \mathbb{R}_{+}^{2}}$ an $\mathbb{R}_{+}^{2}$-indexed filtration on $\Omega$, and simply denote it by $\mathcal{F}$.

From now on, we let $\mathcal{F}$ be an $\mathbb{R}_{+}^{2}$-indexed filtration on $\Omega$, and let $\mathcal{F}_{\underline{\infty}}=\vee_{\underline{t} \in \mathbb{R}_{+}^{2}} \mathcal{F}_{\underline{t}}$.
Definition 2.3. A random map $\underline{T}: \Omega \rightarrow[0, \infty]^{2}$ is called an $\mathcal{F}$-stopping time if for any deterministic $\underline{t} \in \mathbb{R}_{+}^{2},\{\underline{T} \leq \underline{t}\} \in \mathcal{F}_{\underline{t}}$. We call $\underline{T}$ finite if it takes values in $\mathbb{R}_{+}^{2}$, and bounded if there is a deterministic $\underline{t} \in \mathbb{R}_{+}^{2}$ such that $\underline{T} \leq \underline{t}$. For an $\mathcal{F}$-stopping time $\underline{T}$, we define $\mathcal{F}_{\underline{T}}=\left\{A \in \mathcal{F}_{\underline{\propto}}: A \cap\{\underline{T} \leq \underline{t}\} \in \mathcal{F}_{\underline{t}}, \forall \underline{t} \in \mathbb{R}_{+}^{2}\right\}$.

Definition 2.4. A relatively open subset $\mathcal{R}$ of $\mathbb{R}_{+}^{2}$ is called a history complete region, or simply an HC region, if for any $\underline{t} \in \mathcal{R}$, we have $[\underline{0}, \underline{t}] \subset \mathcal{R}$. Given an HC region $\mathcal{R}$, for $j \in\{1,2\}$, define $T_{j}^{\mathcal{R}}: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+} \cup\{\infty\}$ by $T_{j}^{\mathcal{R}}(t)=\sup \left\{s \geq 0: s \underline{e}_{j}+t \underline{e}_{3-j} \in \mathcal{R}\right\}$, where we set $\sup \emptyset=0$.

The space of HC regions is naturally equipped with a $\sigma$-algebra, which is generated by the family $\{\mathcal{R}: \underline{t} \in \mathcal{R}\}, \underline{t} \in \mathbb{R}_{+}^{2}$. A map $\mathcal{D}$ from $\Omega$ into the space of HC regions is called an $\mathcal{F}$-stopping region if for any $\underline{t} \in \mathbb{R}_{+}^{2},\{\omega \in \Omega: \underline{t} \in \mathcal{D}(\omega)\} \in \mathcal{F}_{\underline{t}}$. Such a map is clearly measurable. A random function $X(\underline{t})$ defined on $\Omega$ with a random domain $\mathcal{D}$ is called an $\mathcal{F}$ adapted HC process if $\mathcal{D}$ is an $\mathcal{F}$-stopping region, and for every $\underline{t} \in \mathbb{R}_{+}^{2}, X_{\underline{t}}$ restricted to $\{\underline{t} \in \mathcal{D}\}$ is $\mathcal{F}_{\underline{t}}$-measurable.

The following proposition is [20, Lemma 2.7].
Proposition 2.5. Let $\underline{T}$ and $\underline{S}$ be two $\mathcal{F}$-stopping times. Then (i) $\{\underline{T} \leq \underline{S}\} \in \mathcal{F}_{\underline{S}}$; (ii) if $\underline{S}$ is a constant $\underline{s} \in \mathbb{R}_{+}^{2}$, then $\{\underline{T} \leq \underline{S}\} \in \mathcal{F}_{\underline{T}}$; and (iii) if $f$ is an $\mathcal{F}_{\underline{T}}$-measurable function, then $\mathbf{1}_{\{\underline{T} \leq \underline{S}\}} f$ is $\mathcal{F}_{\underline{S}}$-measurable. In particular, if $\underline{T} \leq \underline{S}$, then $\mathcal{F}_{\underline{\underline{T}}} \subset \mathcal{F}_{\underline{S}}$.
Definition 2.6. Suppose that there are two $\mathbb{R}_{+}$-indexed filtrations $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$ such that $\mathcal{F}_{\left(t_{1}, t_{2}\right)}=\mathcal{F}_{t_{1}}^{1} \vee \mathcal{F}_{t_{2}}^{2},\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}$. Then we say that $\mathcal{F}$ is a separable filtration generated by $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$. For such a separable filtration, if $T_{j}$ is an $\mathcal{F}^{j}$-stopping time, $j=1,2$, then $\underline{T}:=\left(T_{1}, T_{2}\right)$ is called a separable stopping time (w.r.t. $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$ ).

The following proposition is [20, Lemma 2.13].
Proposition 2.7. Suppose $\mathcal{F}$ is separable. Let $\underline{T}$ and $\underline{S}$ be two $\mathcal{F}$-stopping times, where $\underline{S}$ is separable. Then $\{\underline{T} \leq \underline{S}\} \in \mathcal{F}_{\underline{T}}$.
Definition 2.8. The right-continuous augmentation of $\mathcal{F}$ is another $\mathbb{R}_{+}^{2}$-indexed filtration $\overline{\mathcal{F}}$ defined by $\overline{\mathcal{F}}_{\underline{t}}=\bigcap_{\underline{s}>\underline{t}} \mathcal{F}_{\underline{s}}, \underline{t} \in \mathbb{R}_{+}^{2}$. We say that $\mathcal{F}$ is right-continuous if $\overline{\mathcal{F}}=\mathcal{F}$.

The following proposition follows from a standard argument.
Proposition 2.9. The right-continuous augmentation $\overline{\mathcal{F}}$ of $\mathcal{F}$ is right-continuous. $A n[0, \infty]^{2}$ valued map $\underline{T}$ on $\Omega$ is an $\overline{\mathcal{F}}$-stopping time if and only if $\{\underline{T}<\underline{t}\} \in \mathcal{F}_{\underline{t}}$ for any $\underline{t} \in \mathbb{R}_{+}^{2}$; and for such $\underline{T}, A \in \overline{\mathcal{F}}_{\underline{T}}$ if and only if $A \cap\{\underline{T}<\underline{t}\} \in \mathcal{F}_{\underline{t}}$ for any $\underline{t} \in \mathbb{R}_{+}^{2}$. If $\mathcal{F}$ is right-continuous, and if $\left(\underline{T}^{n}\right)_{n \in \mathbb{N}}$ is a decreasing sequence of $\mathcal{F}$-stopping times, then $\underline{T}:=\inf _{n} \underline{T}^{n}$ is also an $\mathcal{F}$-stopping time, and $\mathcal{F}_{\underline{T}}=\bigcap_{n} \mathcal{F}_{\underline{T^{n}}}$.

Now we fix a probability measure $\mathbb{P}$ on $\left(\Omega, \mathcal{F}_{\infty}\right)$, and let $\mathbb{E}\left[\cdot \mid \mathcal{F}_{t}\right]$ denote the corresponding conditional expectations.

Definition 2.10. An $\mathcal{F}$-adapted process $\left(X_{\underline{t}}\right)_{\underline{t} \in \mathbb{R}_{+}^{2}}$ is called an $\mathcal{F}$-martingale (w.r.t. $\mathbb{P}$ ) if for any $\underline{s} \leq \underline{t} \in \mathbb{R}_{+}^{2}$, a.s. $\mathbb{E}\left[X_{\underline{t}} \mid \mathcal{F}_{\underline{s}}\right]=X_{\underline{s}}$. If there is $\zeta \in L^{1}\left(\Omega, \mathcal{F}_{\underline{\infty}}, \mathbb{P}\right)$ such that a.s. $X_{\underline{t}}=\mathbb{E}\left[\zeta \mid \mathcal{F}_{\underline{t}}\right]$ for all $\underline{t} \in \mathbb{R}_{+}^{2}$, then we say that $X$ is closed by $\zeta$.

The following is [20, Lemma 2.11].
Proposition 2.11 (Optional Stopping Theorem). Suppose $X$ is a continuous $\mathcal{F}$-martingale. Then the following are true. (i) If $X$ is closed by $\zeta$, then for any finite $\mathcal{F}$-stopping time $\underline{T}$, $X_{T}=\mathbb{E}\left[\zeta \mid \mathcal{F}_{\underline{T}}\right]$. (ii) If $\underline{T} \leq \underline{S}$ are two bounded $\mathcal{F}$-stopping times, then $\mathbb{E}\left[X_{\underline{S}} \mid \mathcal{F}_{\underline{T}}\right]=X_{\underline{T}}$.

## 3 Ensemble of Two Radial Loewner Chains

### 3.1 Deterministic ensemble

Let $m \in \mathbb{N} \cup\{0\}$. Let $w_{1}, w_{2}, v_{1}, \ldots, v_{m} \in \mathbb{R}$ be such that $e^{i w_{1}}, e^{i w_{2}}, e^{i v_{1}}, \ldots, e^{i v_{m}}$ are pairwise distinct. For $j=1,2$, let $\widehat{w}_{j} \in C\left(\left[0, \widehat{T}_{j}\right), \mathbb{R}\right)$ be a radial Loewner driving function with $\widehat{w}_{j}(0)=$ $w_{j}$. Suppose $\widehat{w}_{j}$ generates radial Loewner hulls $K_{j}(t)$, radial Loewner maps $g_{j}(t, \cdot)$, covering radial Loewner hulls $\widetilde{K}_{j}(t)$ and covering radial Loewner maps $\widetilde{g}_{j}(t, \cdot), 0 \leq t<\widehat{T}_{j}$. Let $\mathcal{D}$ denote the set of $\left(t_{1}, t_{2}\right) \in\left[0, \widehat{T}_{1}\right) \times\left[0, \widehat{T}_{2}\right)$ such that $\overline{K_{1}\left(t_{1}\right)} \cap \overline{K_{2}\left(t_{2}\right)}=\emptyset$ and $e^{i v_{1}}, \ldots, e^{i v_{m}} \notin$ $\overline{K_{1}\left(t_{1}\right)} \cup \overline{K_{2}\left(t_{2}\right)}$. Then $\mathcal{D}$ is an HC region as in Definition 2.4, and we may define functions $T_{1}^{\mathcal{D}}$ and $T_{2}^{\mathcal{D}}$. For $\left(t_{1}, t_{2}\right) \in \mathcal{D}$, let $K\left(t_{1}, t_{2}\right)=K_{1}\left(t_{1}\right) \cup K_{2}\left(t_{2}\right)$. Then $K\left(t_{1}, t_{2}\right)$ is also an $\mathbb{D}$-hull. Let $g\left(\left(t_{1}, t_{2}\right), \cdot\right)=g_{K\left(t_{1}, t_{2}\right)}$, and $\mathrm{m}\left(t_{1}, t_{2}\right)=\operatorname{dcap}\left(K\left(t_{1}, t_{2}\right)\right)$. For $\left(t_{1}, t_{2}\right) \in \mathcal{D}$ and $j \neq k \in\{1,2\}$, let $K_{j, t_{k}}\left(t_{j}\right)=g_{k}\left(t_{k}, K_{j}\left(t_{j}\right)\right)$, and $g_{j, t_{k}}\left(t_{j}, \cdot\right)=g_{K_{j, t_{k}}\left(t_{j}\right)}$. Let $\widetilde{K}\left(t_{1}, t_{2}\right), \widetilde{K}_{j, t_{k}}\left(t_{j}\right) \subset \mathbb{H}$ be the preimages of $K\left(t_{1}, t_{2}\right), K_{j, t_{k}}\left(t_{j}\right)$, respectively, under the map $e^{i}$. Let $\widetilde{g}(\underline{t}, \cdot), \underline{t} \in \mathcal{D}$, be the unique family of maps, such that $\widetilde{g}(\underline{t}, z)$ is jointly continuous in $\underline{t}, z, \widetilde{g}(\underline{0}, \cdot)=\mathrm{id}$, and for each $\underline{t} \in \mathcal{D}$, $\widetilde{g}(\underline{t}, \cdot): \mathbb{H} \backslash \widetilde{K}(\underline{t}) \xrightarrow{\text { Conf }} \mathbb{H}$, and $e^{i} \circ \widetilde{g}(\underline{t}, \cdot)=g(\underline{t}, \cdot) \circ e^{i}$. Define $\widetilde{g}_{1, t_{2}}\left(t_{1}, \cdot\right)$ and $\widetilde{g}_{2, t_{1}}\left(t_{2}, \cdot\right),\left(t_{1}, t_{2}\right) \in \mathcal{D}$, similarly. Fix $j \neq k \in\{1,2\}$ and $s \in\{1, \ldots, m\}$. Let $\left(t_{1}, t_{2}\right) \in \mathcal{D}$. We define the following real valued functions on $\mathcal{D}$ :

W_{j}\left(t_{1}, t_{2}\right)=\widetilde{g}_{k, t_{j}}\left(t_{k}, \widehat{w}_{j}\left(t_{j}\right)\right), \quad W_{j, h}\left(t_{1}, t_{2}\right)=\widetilde{g}_{k, t_{j}}^{(h)}\left(t_{k}, \widehat{w}_{j}\left(t_{j}\right)\right) ; \\
W_{j, S}\left(t_{1}, t_{2}\right)=\frac{W_{j, 3}\left(t_{1}, t_{2}\right)}{W_{j, 1}\left(t_{1}, t_{2}\right)}-\frac{3}{2}\left(\frac{W_{j, 2}\left(t_{1}, t_{2}\right)}{W_{j, 1}\left(t_{1}, t_{2}\right)}\right)^{2} .
\end{gathered}

Here the prime and the superscript ( $h$ ) are respectively the partial derivative and $h$-th partial derivative w.r.t. the space variable: $v_{s}$ or $\widehat{w}_{j}\left(t_{j}\right)$.

Let $j \neq k \in\{1,2\}$ and $s \in\{1, \ldots, m\}$. By [20, Section 3.1], for any $t_{k} \geq 0, K_{j, t_{k}}\left(t_{j}\right)$ and $g_{j, t_{k}}\left(t_{j}, \cdot\right), 0 \leq t_{j}<T_{j}^{\mathcal{D}}\left(t_{k}\right)$, are radial Loewner hulls and maps, respectively, driven by $\left.W_{j}\right|_{t_{k}} ^{k}$ with speed $\left(W_{j, 1}| |_{t_{k}}^{k}\right)^{2}$. Moreover, we have the following formulas.

Finally, suppose that $\widehat{w}_{1}$ and $\widehat{w}_{2}$ generate radial Loewner curves $\eta_{1}$ and $\eta_{2}$, respectively. For each $j \neq k \in(1,2)$ and $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}$, we define $\eta_{j}^{t_{k}}\left(t_{j}\right)=g_{k}\left(t_{k}, \eta_{j}\left(t_{j}\right)\right)$. Then we have $K_{j, t_{k}}\left(t_{j}\right)=\operatorname{Hull}\left(\eta_{j}^{t_{k}}\left[0, t_{j}\right]\right)$. So for any $t_{k} \geq 0, \eta_{j}^{t_{k}}\left(t_{j}\right), 0 \leq t_{j}<T_{j}^{\mathcal{D}}\left(t_{k}\right)$, is a radial Loewner curve driven by $\left.W_{j}\right|_{t_{k}} ^{k}$ with speed $\left(\left.W_{j, 1}\right|_{t_{k}} ^{k}\right)^{2}$.

### 3.2 Commutation couplings

### 3.2.1 The statement

We use the setup in the previous subsection. We view $\left(\widehat{w}_{1}(t)\right)_{0 \leq t<\widehat{T}_{1}}$ and $\left(\widehat{w}_{2}(t)\right)_{0 \leq t<\widehat{T}_{2}}$ as elements in $\Sigma:=\bigcup_{0<T \leq \infty} C([0, T), \mathbb{R})$. Now suppose $\widehat{w}_{1}$ and $\widehat{w}_{2}$ are random. Then their laws are probability measures on $\Sigma$. Let $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$ be the $\mathbb{R}_{+}$-indexed filtrations respectively generated by $\widehat{w}_{1}$ and $\widehat{w}_{2}$. More specifically, for $j=1,2$ and $t \in \mathbb{R}_{+}, \mathcal{F}_{t}^{j}$ is the $\sigma$-algebra generated by $\left\{s<\widehat{T}_{j}\right\} \cap\{\widehat{w}(s) \in U\}, 0 \leq s \leq t, U \in \mathcal{B}(\mathbb{R})$. We are going to prove the following.

Proposition 3.1. Let $\kappa \in(0, \infty)$ and $\underline{\rho}=\left(\rho_{1}, \ldots, \rho_{m}\right) \in \mathbb{R}^{m}$. We write $e^{i \underline{v}}$ for $\left(e^{i v_{1}}, \ldots, e^{i v_{m}}\right)$. There is a coupling of two random radial Loewner curves $\eta_{j}(t), 0 \leq t<\widehat{T}_{j}, j=1,2$, with radial Loewner driving functions $\widehat{w}_{j}$ and maps $g_{j}(t, \cdot)$ such that $\widehat{w}_{j}(0)=w_{j}$ and the following holds. For $j=1,2, \eta_{j}$ is a radial $S L E_{\kappa}(2, \rho)$ curve in $\mathbb{D}$ started from $e^{i w_{1}}$ aimed at 0 with force points ( $\left.e^{i w_{2}}, e^{i \underline{v}}\right)$. For any $j \neq k \in\{1,2\}$ and any $\mathcal{F}^{k}$-stopping time $\tau_{k}$ with $\tau_{k}<\widehat{T}_{k}$, conditionally on $\mathcal{F}_{\tau_{k}}^{k}$, the $\eta_{j}^{\tau_{k}}\left(t_{j}\right)=g_{k}\left(\tau_{k}, \eta_{j}\left(t_{j}\right)\right), 0 \leq t_{j}<T_{j}^{\mathcal{D}}\left(\tau_{k}\right)$, has the law of a timechange of a radial $S L E_{\kappa}(2, \underline{\rho})$ curve in $\mathbb{D}$ started from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ aimed at 0 with force points $\left(e^{i \widehat{w}_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i v_{1}}\right), \ldots, g_{k}\left(\tau_{k}, e^{i v_{m}}\right)\right)$ stopped at some stopping time.

The $\eta_{1}$ and $\eta_{2}$ in Proposition 3.1 are said to commute with each other. The idea of the commutation relation between SLE curves is generated in [3]. The chordal counterpart of this proposition, with $e^{i w_{1}}, e^{i w_{2}}, e^{i \underline{v}}, 0$ replaced by $w_{1}, w_{2}, \underline{v}, \infty$, follows easily from the imaginary geometry developed in [10]. In that case, one may construct the two chordal $\operatorname{SLE}_{\kappa}(2, \underline{\rho})$ curves as two flow lines of a GFF in $\mathbb{H}$ with piecewise constant boundary data changing values at $w_{1}, w_{2}, v_{1}, \ldots, v_{m}$, where the constants are determined by $\kappa, \underline{\rho}$. Similarly, Proposition 3.1 could be probably proved by developing a radial version of imaginary geometry theory. We will not develop such theory here. Instead, we give another proof, which provides us some information of the coupling measure, e.g., Lemma 3.8, that will be needed later. The proof in the special case that $m=2$ and $\rho_{1}=\rho_{2}=2$ were given in [20, Section 3]. Here we are interested in the case that $m=2$ and $\rho_{1}=\rho_{2}=\kappa-4$. For the reader's convenience and future reference, we provide a complete proof of Proposition 3.1 here.

For $j=1,2$, let $\Xi_{j}$ denote the space of simple crosscuts of $\mathbb{D}$ that separate $e^{i w_{j}}$ from $e^{i w_{3-j}}, e^{i v_{1}}, \ldots, e^{i v_{m}}, 0$. For $j=1,2$ and $\xi_{j} \in \Xi_{j}$, let $\tau_{\xi_{j}}^{j}$ be the first time that $\eta_{j}$ hits the closure of $\xi_{j}$. Let $\boldsymbol{\Xi}=\left\{\left(\xi_{1}, \xi_{2}\right) \in \Xi_{1} \times \Xi_{2}\right.$, $\left.\operatorname{dist}\left(\xi_{1}, \xi_{2}\right)>0\right\}$. For $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, let $\tau_{\underline{\xi}}=\left(\tau_{\xi_{1}}^{1}, \tau_{\xi_{2}}^{2}\right)$. We may pick a countable subset $\Xi^{*}$ of $\Xi$ such that for every $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, there is $\underline{\xi}^{*}=\left(\xi_{1}^{*}, \xi_{2}^{*}\right)$ such that $\xi_{j}^{*}$ disconnects $\xi_{j}$ from $0, j=1,2$. The significance of $\Xi$ and $\Xi^{*}$ is that $\left[\underline{0}, \tau_{\underline{\xi}}\right] \subset \mathcal{D}$ for any $\underline{\xi} \in \Xi$, and $\mathcal{D}=\bigcup_{\xi \in \Xi^{*}}\left[\underline{0}, \tau_{\underline{\xi}}\right]$.

We call the joint law of $\widehat{w}_{1}$ and $\widehat{w}_{2}$ in Proposition 3.1 a global commutation coupling. Such a measure is unique, if it exists, because the stated property determines the marginal law of $\eta_{2}$ (taking $\tau_{1}=0$ ) and the conditional law of $\eta_{1}$ given the part of $\eta_{2}$ up to any $\mathcal{F}^{2}$-stopping time $\tau_{2}$ that happens before $\eta_{2}$ ends. Let $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$. If $\eta_{1}, \eta_{2}$ satisfy the properties in Proposition 3.1 with the following modifications: (i) $\tau_{k}$ is required to be $\leq \tau_{\xi_{k}}$, and (ii) the time that $\eta_{j}$ hits $\eta_{k}\left[0, \tau_{k}\right]$ is replaced by $\tau_{\xi_{j}}$, then we call the joint law of the driving functions for $\eta_{1}, \eta_{2}$ a local commutation coupling within $\underline{\xi}$. The global commutation coupling is automatically a local commutation coupling within $\underline{\xi}$ for every $\underline{\xi} \in \Xi$. A local commutation coupling within $\underline{\xi}$, when restricted to $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$, is unique.

### 3.2.2 Two-variable local martingale

For $j=1,2$, let $\mathbb{P}_{*}^{j}$ denote the law of the driving function of a radial $\operatorname{SLE}_{\kappa}(2, \rho)$ curve in $\mathbb{D}$ started from $e^{i w_{j}}$ aimed at 0 with force points $\left(e^{i w_{3-j}}, e^{i \underline{v}}\right)$, which is a probability measure on $\Sigma$. Let $\mathbb{P}_{*}^{\mathrm{i}}=\mathbb{P}_{*}^{1} \times \mathbb{P}_{*}^{2}$. The superscript i means "independence". We may prove the existence of the global commutation coupling using the stochastic coupling technique developed in [24, 23]. It suffices to prove that there is a positive continuous process $\widehat{M}_{*}$ defined on $\mathcal{D}$ with the following properties.

- $\widehat{M}_{*}(\cdot, 0)=\widehat{M}_{*}(0, \cdot) \equiv 1$.
- For any $\underline{\xi} \in \Xi, \log \left(\widehat{M}_{*}\right)$ is uniformly bounded on $\left[\underline{0}, \tau_{\underline{\xi}}\right]$.
- For any $\underline{\xi} \in \Xi, \mathbb{R}_{+}^{2} \ni \underline{t} \mapsto \widehat{M}_{*}\left(\underline{t} \wedge \tau_{\underline{\xi}}\right)$ is an $\mathbb{R}_{+}^{2}$-indexed martingale under $\mathbb{P}_{*}^{\mathrm{i}}$.
- For any $\underline{\xi} \in \Xi$, the probability measure $\mathbb{P}_{*}^{\xi}$ on $\Sigma^{2}$ defined by $d \mathbb{P}_{*}^{\xi}=\widehat{M}_{*}\left(\tau_{\underline{\xi}}\right) d \mathbb{P}_{*}^{\mathrm{i}}$ is a local commutation coupling within $\underline{\xi}$.

We have the following proposition (cf. [24, Sections 6 and 7]).
Proposition 3.2. Whenever the above $\widehat{M}_{*}$ exists, there exists a global commutation coupling, denoted by $\mathbb{P}_{*}^{c}$, which agrees with $\mathbb{P}_{*}^{\underline{\xi}}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$ for any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$. In particular, for any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi, \mathbb{P}_{*}^{c}$ is absolutely continuous w.r.t. $\mathbb{P}_{*}^{1}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$, and the Radon-Nikodym derivative is $\widehat{M}_{*}\left(\tau_{\underline{\xi}}\right)$.

For $j=1,2$, let $\mathbb{P}_{B}^{j}$ denote the law of the process $w_{j}+\sqrt{\kappa} B(t), 0 \leq t<\infty$, where $B$ is a standard linear Brownian motion. Let $\mathbb{P}_{B}^{\mathrm{i}}=\mathbb{P}_{B}^{1} \times \mathbb{P}_{B}^{2}$. In order to construct $\widehat{M}_{*}$, it suffices to find another positive continuous process $M_{*}$ on $\mathcal{D}$ with the following properties.

- For any $\underline{\xi} \in \Xi, \log \left(M_{*}\right)$ is uniformly bounded on $\left[\underline{0}, \tau_{\underline{\xi}}\right]$.
- For any $\underline{\xi} \in \Xi, \mathbb{R}_{+}^{2} \ni \underline{t} \mapsto M_{*}\left(\underline{t} \wedge \tau_{\underline{\xi}}\right)$ is an $\mathbb{R}_{+}^{2}$-indexed martingale under $\mathbb{P}_{B}^{\mathrm{i}}$.
- For any $\underline{\xi} \in \Xi$, the probability measure $\mathbb{P}_{*}^{\xi}$ on $\Sigma^{2}$ defined by $d \mathbb{P}_{*}^{\underline{\xi}}=\left(M_{*}\left(\tau_{\underline{\xi}}\right) / M_{*}(\underline{0})\right) d \mathbb{P}_{B}^{\mathrm{i}}$ is a local commutation coupling within $\underline{\xi}$.

If such $M_{*}$ exists, then for any $j \in\{1,2\}$ and $\xi_{j} \in \Xi_{j}, \mathbb{P}_{*}^{j}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{j}$ on $\mathcal{F}_{\tau_{\xi_{j}}^{j}}^{j}$, and the Radon-Nikodym derivative is $\left.M_{*}\right|_{0} ^{3-j}\left(\tau_{\xi_{j}}^{j}\right) / M_{*}(\underline{0})$. So for any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, $\mathbb{P}_{*}^{\mathrm{i}}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{\mathrm{i}}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$, and the Radon-Nikodym derivative is $\frac{M_{*}\left(\tau_{\varepsilon_{1}}^{1}, 0\right) M_{*}\left(0, \tau_{\varepsilon_{2}}^{2}\right)}{M_{*}(0,0) M_{*}(0,0)}$. Thus, the $\widehat{M}_{*}$ defined by $\widehat{M}_{*}\left(t_{1}, t_{2}\right)=\frac{M_{*}\left(t_{1}, t_{2}\right) M_{*}(0,0)}{M_{*}\left(t_{1}, 0\right) M_{*}\left(0, t_{2}\right)}$ satisfies the properties stated in the previous paragraph. Moreover, the global commutation coupling $\mathbb{P}_{*}^{c}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{\mathrm{i}}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$ for any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, and the Radon-Nikodym derivative is $M_{*}\left(\tau_{\underline{\xi}}\right) / M_{*}(\underline{0})$. From now on, we are going to construct such $M_{*}$.

First suppose $\left(\widehat{w}_{1}, \widehat{w}_{2}\right)$ follows the law $\mathbb{P}_{B}^{\mathrm{i}}$. Then for two independent Brownian motions $B_{1}$ and $B_{2}$, we have $\widehat{w}_{j}(t)=w_{j}+\sqrt{\kappa} B_{j}(t), t \geq 0, j=1,2$.

Recall the boundary scaling exponent b and central charge c in the literature:

Fix $j \neq k \in\{1,2\}$. Let $\tau_{k}$ be an $\mathcal{F}^{k}$-stopping time with $\tau_{k}<\widehat{T}_{k}$. Let $\mathcal{F}^{(j, \infty)}$ denote usual augmentation of the $\mathbb{R}_{+}$-indexed filtration $\left(\mathcal{F}_{t}^{j} \vee \mathcal{F}_{\infty}^{k}\right)_{t \geq 0}$. By independence, $B_{j}$ is an $\mathcal{F}^{(j, \infty)}$ Brownian motion. From now on, we will repeatedly apply Itô's formula (cf. [15]), where all SDE are $\mathcal{F}^{(j, \infty)}$-adapted. These statements were all proved in the proof of Lemma 3.1 of [20].

Let $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$. Let $j \neq k \in\{1,2\}$. Let $\tau_{k} \leq \tau_{k}^{\prime}$ be two $\mathcal{F}^{k}$-stopping times such that $\tau_{k} \leq \tau_{\xi_{k}}^{\bar{k}}$. Let $\mathcal{F}$ denote the $\mathbb{R}_{+}^{2}$-indexed filtration generated by $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$. Since $\eta_{j}^{\tau_{k}}\left(t_{j}\right), 0 \leq t_{j}<T_{j}^{\mathcal{D}}\left(\tau_{k}\right)$, is a radial Loewner curve with speed $\left(\left.W_{j, 1}\right|_{\tau_{k}} ^{k}\right)^{2}$ driven by $\left.W_{j}\right|_{\tau_{k}} ^{k}$, the SDE implies that, under $\widetilde{\mathbb{P}}_{*}$, conditionally on $\mathcal{F}_{\tau_{k}}^{k}$, the $\eta_{j}^{\tau_{k}}$ up to $\tau_{\xi_{j}}^{j}$ has the law of a timechange of a radial $\operatorname{SLE}_{\kappa}(2, \underline{\rho})$ curve in $\mathbb{D}$ started from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ aimed at 0 with force points $e^{i w_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i \underline{v}}\right)$. This means that $\widetilde{\mathbb{P}}_{*}$ is a local commutation coupling within $\xi$. Thus, the $M_{*}$ satisfies all required properties. By Proposition 3.2, we then complete the proof of Proposition 3.1. Moreover, we get the following proposition.

Proposition 3.5. For any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, the global coupling measure in Proposition 3.1 is absolutely continuous $\bar{w}$.r.t. $\mathbb{P}_{B}^{\mathrm{i}}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$, and the Radon-Nikodym derivative is $M_{*}\left(\tau_{\underline{\xi}}\right) / M_{*}(\underline{0})$, where $M_{*}$ is defined by (3.17).
Lemma 3.6. Suppose $\kappa>4, m=2$, $\rho_{1}=\rho_{2}=\kappa-4$, and $w_{1}>v_{1}>w_{2}>v_{2}>w_{1}-2 \pi$. Let $\eta_{1}$ and $\eta_{2}$ be given by Proposition 3.1. Let $\mathcal{D}=\left\{\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}: \eta_{1}\left[0, t_{1}\right] \cap \eta_{2}\left[0, t_{2}\right]=\emptyset\right\}$. Then a.s. $\mathcal{D}=\mathbb{R}_{+}^{2}$.

Proof. Let $\widehat{w}_{j}$ be the driving function of $\eta_{j}, j=1,2$. Since the force values $\rho_{1}=\rho_{2}=\kappa-4>$ $\frac{\kappa}{2}-2$, and $2>0$, by Proposition 2.1, a.s. $\eta_{j}$ does not intersect $A_{3-j}$, and so has lifetime $\infty$. Fix a deterministic time $t_{2} \in \mathbb{N}$. Conditionally on $\mathcal{F}_{t_{2}}^{2}$, the $g_{2}\left(t_{2}, \cdot\right)$-image of the part of $\eta_{1}$ before hitting $\eta_{2}\left[0, t_{2}\right]$ has the law of a time-change of a radial $\operatorname{SLE}_{\kappa}(2, \kappa-4, \kappa-4)$ curve in $\mathbb{D}$ started from $g_{2}\left(t_{2}, e^{i w_{1}}\right)$ aimed at 0 with force points $e^{i \widehat{w}_{2}\left(t_{2}\right)}, g_{2}\left(t_{2}, e^{i v_{1}}\right), g_{2}\left(t_{2}, e^{i v_{2}}\right)$. If $\eta_{1}$ does hit $\eta_{2}\left[0, t_{2}\right]$, then the (time-changed) radial $\operatorname{SLE}_{\kappa}(2, \kappa-4, \kappa-4)$ curve $\eta_{1}^{t_{2}}$ hits the arc on $\partial \mathbb{D}$ with endpoints $g_{2}\left(t_{2}, e^{i v_{1}}\right), g_{2}\left(t_{2}, e^{i v_{2}}\right)$ that contains $e^{i \widehat{w}_{2}\left(t_{2}\right)}$. By Proposition 2.1 again, the latter event has probability zero. Thus, $\mathbb{P}_{*}^{c}-$ a.s. $\eta_{1}$ does not intersect $\eta_{2}\left[0, t_{2}\right]$, which implies that $\mathbb{R}_{+} \times\left[0, t_{2}\right] \subset \mathcal{D}$. Since this holds for every $t_{2} \in \mathbb{N}$, we get the conclusion.

We use $\mathbb{P}_{*}^{c}$ to denote the joint law of the driving functions $\widehat{w}_{1}$ and $\widehat{w}_{2}$ of the $\eta_{1}$ and $\eta_{2}$ in Lemma 3.6. The superscript $c$ stands for coupling, and the subscript $*$ means that both curves end at 0 .

For the $w_{j}$ and $v_{j}$ as above, we will need a different kind of commutation coupling as follows. Define $M_{c}$ on $\mathcal{D}$ by

Fix $j \neq k \in\{1,2\}$ and an $\mathcal{F}^{k}$-stopping time $\tau_{k}$ with $\tau_{k} \leq \tau_{\xi_{k}}^{k}$. Using the Girsanov Theorem, one can show that, under $\widetilde{\mathbb{P}}_{c}$, conditionally on $\mathcal{F}_{\tau_{k}}^{k}$, the $g_{k}\left(\tau_{k}, \cdot\right)$ image of the part of $\eta_{j}$ up to $\tau_{\xi_{j}}^{j}$ has the law of a time-change of a radial $\operatorname{SLE}_{\kappa}(\kappa-6,0,0)$ curve in $\mathbb{D}$ started from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ aimed at 0 with force points $e^{i w_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i v_{1}}\right), g_{k}\left(\tau_{k}, e^{i v_{2}}\right)$. So we get the following proposition.

Proposition 3.7. Let $\kappa \in(0, \infty)$. There is a coupling of two random radial Loewner curves $\eta_{j}(t), 0 \leq t<\widehat{T}_{j}, j=1,2$, with radial Loewner driving functions $\widehat{w}_{j}$ and maps $g_{j}(t, \cdot)$ such that $\widehat{w}_{j}(0)=w_{j}$ and the following holds. For $j=1,2, \eta_{j}$ is a radial $S L E_{\kappa}(\kappa-6,0,0)$ curve in $\mathbb{D}$ started from $e^{i w_{j}}$ aimed at 0 with force points $e^{i w_{3-j}}, e^{i v_{1}}, e^{i v_{2}}$. For any $j \neq k \in\{1,2\}$ and any $\mathcal{F}^{k}$-stopping time $\tau_{k}$ with $\tau_{k}<\widehat{T}_{k}$, conditionally on $\mathcal{F}_{\tau_{k}}^{k}$, the $\eta_{j}^{\tau_{k}}\left(t_{j}\right), 0 \leq t_{j}<T_{j}^{\mathcal{D}}\left(\tau_{k}\right)$, has the law of a time-change of a radial $S L E_{\kappa}(\kappa-6,0,0)$ curve in $\mathbb{D}$ started from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ aimed at 0 with force points $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i v_{1}}\right), g_{k}\left(\tau_{k}, e^{i v_{2}}\right)$ stopped at the first time that it separates 0 from any of the three force points in $\mathbb{D}$. Moreover, for any $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, the joint law of $\widehat{w}_{1}$ and $\widehat{w}_{2}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{\mathrm{i}}$ on $\mathcal{F}_{\tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{\tau_{\xi_{2}}^{2}}^{2}$, and the Radon-Nikodym derivative is $M_{c}\left(\tau_{\underline{\xi}}\right) / M_{c}(\underline{0})$, where $M_{c}$ is defined by (3.19).

By [17], for $j=1,2$, the $\eta_{j}$ in Proposition 3.7] is a time-change of a chordal SLE ${ }_{\kappa}$ in $\mathbb{D}$ from $e^{i w_{j}}$ to $e^{i w_{3-j}}$ stopped at the first time that it separates 0 from any of $e^{i w_{3-j}}, e^{i v_{1}}, e^{i v_{2}}$ in $\mathbb{D}$. When $\kappa \in(0,8]$, the coupling of $\eta_{1}$ and $\eta_{2}$ in Proposition 3.7 can be easily constructed using the DMP and reversibility of chordal SLE $_{\kappa}$. For the construction, we start with a chordal SLE $_{\kappa}$ in $\mathbb{D}$ from $e^{i w_{1}}$ to $e^{i w_{2}}$, let $\eta_{1}$ and $\eta_{2}$ be respectively the part of $\eta$ and the reversal of $\eta$ up to the first time that it separates 0 from any of the three force points in $\mathbb{D}$. But such a construction does not provide us the Radon-Nikodym derivative process $M_{c}$.

Let $\mathbb{P}_{c}^{c}$ denote the joint law of the driving functions $\widehat{w}_{1}$ and $\widehat{w}_{2}$ of the $\eta_{1}$ and $\eta_{2}$ obtained from Proposition 3.7. The superscript and subscript respectively stand for coupling and chordal.

We are mostly interested in the case $\kappa \in(4,8)$. In that case, under $\mathbb{P}_{c}^{c}$ the $\eta_{1}$ and $\eta_{2}$ are parts of the same chordal $\operatorname{SLE}_{\kappa}$ curve in $\mathbb{D}$ from $e^{i w_{1}}$ to $e^{i w_{2}}$. Under $\mathbb{P}_{*}^{c}$ the $\eta_{1}$ and $\eta_{2}$ both end at 0 , and $\eta_{1} \cup A_{1}$ is disjoint from $\eta_{2} \cup A_{2}$, where for $j=1,2, A_{j}$ is the connected component of $\mathbb{D} \backslash\left\{e^{i v_{1}}, e^{i v_{2}}\right\}$ that contains $e^{i w_{j}}$. Thus, under $\mathbb{P}_{*}^{c}, 0$ is a cut point of $\eta_{1} \cup \eta_{2} \cup A_{1} \cup A_{2} \cup\{0\}$. Intuitively, we may understand $\mathbb{P}_{*}^{c}$ as the chordal SLE $_{\kappa}$ curve in $\mathbb{D}$ from $e^{i w_{1}}$ to $e^{i w_{2}}$ conditioned on the singular event that 0 is a cut point of $\eta \cup A_{1} \cup A_{2}$. See Figure 3.2.3,

Let $M_{* \rightarrow c}=M_{c} / M_{*}$, which can be expressed in terms of the $\alpha_{0}$ and $\widetilde{G}$ defined in (1.2|1.4):

M_{* \rightarrow c}=e^{-\alpha_{0} \mathrm{~m}} \widetilde{G}\left(W_{1}, W_{2}, V_{1}, V_{2}\right)^{-1} \tag{3.20}
\end{equation*}
$$

Lemma 3.8. Suppose $\kappa \in(4,8)$. For any $\mathcal{F}$-stopping time $\underline{T}$, $\mathbb{P}_{c}^{c}$ restricted to $\mathcal{F}_{\underline{T}} \cap\{\underline{T} \in \mathcal{D}\}$ is absolutely continuous w.r.t. $\mathbb{P}_{*}^{c}$, and the $R N$ derivative is $M_{* \rightarrow c}(\underline{T}) / M_{* \rightarrow c}(\underline{0})$. In other words, if $A \in \mathcal{F}_{\underline{T}}$ and $A \subset\{\underline{T} \in \mathcal{D}\}$, then $\mathbb{P}_{c}^{c}[A]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A} M_{* \rightarrow c}(\underline{T}) / M_{* \rightarrow c}(\underline{0})\right]$.
Proof. Let $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$ and $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}$. By Lemma 3.4. Proposition 3.5, and the facts

$\mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2} \subset \mathcal{F}_{\underline{t}}$ and that $M_{*}\left(\underline{t} \wedge \tau_{\underline{\xi}}\right)$ is $\mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}$-measurable, we see that

$$
\frac{d \mathbb{P}_{*}^{c} \mid \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}}{d \mathbb{P}_{B}^{\mathrm{i}} \mid \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}}=\frac{\mathbb{E}\left[M_{*}\left(\tau_{\underline{\xi}}\right) \mid \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}\right]}{M_{*}(\underline{0})}=\frac{M_{*}\left(\underline{t} \wedge \tau_{\underline{\xi}}\right)}{M_{*}(\underline{0})} .
$$

A similar formula holds with $\mathbb{P}_{c}^{c}$ and $M_{c}$ respectively in place of $\mathbb{P}_{*}^{c}$ and $M_{*}$. So we get

\frac{d \mathbb{P}_{c}^{c} \mid \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau \tau_{\xi_{2}}^{2}}^{2}}{d \mathbb{P}_{*}^{c} \mid \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}}=\frac{M_{* \rightarrow c}\left(\underline{\underline{~}} \wedge \tau_{\underline{\xi}}\right)}{M_{* \rightarrow c}(\underline{0})} . \tag{3.21}
\end{equation*}
$$

Let $\underline{T}=\left(T_{1}, T_{2}\right)$ be an $\mathcal{F}$-stopping time. Let $\underline{\xi} \in \Xi^{*}$. Fix $A \in \mathcal{F}_{\underline{T}}$ with $A \subset\left\{\underline{T}<\tau_{\underline{\xi}}\right\}$. For $n \in \mathbb{N}$, let $\underline{T}^{n}=\left(T_{1}^{n}, T_{2}^{n}\right)$, where $T_{j}^{n}=\frac{\left[2^{n} T\right]}{2^{n}}, j=1,2$. It is easy to see that each $\underline{T}^{n}$ is an $\mathcal{F}$-stopping time, and $\underline{T}^{n} \downarrow \underline{T}$. Let $A_{n}=A \cap\left\{\underline{T}^{n}<\tau_{\underline{\xi}}\right\}, n \in \mathbb{N}$. Then $A_{n} \uparrow A$. Fix $n \in \mathbb{N}$. By

Proposition 2.7, $A_{n} \in \mathcal{F}_{\underline{T}^{n}}$. We know that $\underline{T}^{n}$ takes values in $\frac{1}{2^{n}} \mathbb{Z}_{+}^{2}$. Let $\underline{s}=\left(s_{1}, s_{2}\right) \in \frac{1}{2^{n}} \mathbb{Z}_{+}^{2}$ and $A_{n, \underline{s}}=A_{n} \cap\left\{\underline{T}^{n}=\underline{s}\right\}$. By Proposition [2.5, $A_{n, \underline{s}} \in \mathcal{F}_{\underline{s}}$. Since $\mathcal{F}_{s_{j}}^{j} \cap\left\{s_{j} \leq s_{j} \wedge \tau_{\xi_{j}}^{j}\right\} \subset \mathcal{F}_{s_{j} \wedge \wedge \tau_{\xi_{j}}^{j}}^{j}$, $j=1,2$, by a monotone class argument we get $\mathcal{F}_{\underline{s}} \cap\left\{\underline{s} \leq \underline{s} \wedge \tau_{\underline{\xi}}\right\} \subset \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}$. Since $A_{n, \underline{s}} \in \mathcal{F}_{\underline{s}} \cap\left\{\underline{s}<\tau_{\underline{\xi}}\right\}$, we see that $A_{n, \underline{s}} \in \mathcal{F}_{t_{1} \wedge \tau_{\xi_{1}}^{1}}^{1} \vee \mathcal{F}_{t_{2} \wedge \tau_{\xi_{2}}^{2}}^{2}$. By (3.21),

$$
\mathbb{P}_{c}^{c}\left[A_{n, \underline{s}}\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{n, \underline{s}}} M_{* \rightarrow c}\left(\underline{s} \wedge \tau_{\underline{\xi}}\right) / M_{* \rightarrow c}(\underline{0})\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{n, \underline{s}}} M_{* \rightarrow c}\left(\underline{T}^{n}\right) / M_{* \rightarrow c}(\underline{0})\right]
$$

where the last equality holds because $\underline{T}^{n}=\underline{s} \leq \tau_{\underline{\xi}}$ on $A_{n, \underline{s}}$. Summing up over $\underline{s} \in \frac{1}{2^{n}} \mathbb{Z}_{+}^{2}$, we get $\mathbb{P}_{c}^{c}\left[A_{n}\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{n}} M_{* \rightarrow c}\left(\underline{T}^{n}\right) / M_{* \rightarrow c}(\underline{0})\right]$. Sending $n \rightarrow \infty$ and using dominated convergence theorem, we get $\mathbb{P}_{c}^{c}[A]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A} M_{* \rightarrow c}(\underline{T}) / M_{* \rightarrow c}(\underline{0})\right]$. Here we use the facts that $\underline{T}^{n}<\tau_{\underline{\xi}}$ on $A_{n}$ and that $\log M_{* \rightarrow c}$ is uniformly bounded on $\left[0, \tau_{\xi}\right]$. This means that, for any $\xi \in \Xi^{*}, \mathbb{P}_{c}^{c}$ restricted to $\mathcal{F}_{\underline{T}} \cap\left\{\underline{T}<\tau_{\underline{\xi}}\right\}$ is absolutely continuous w.r.t. $\mathbb{\mathbb { P }}_{*}^{c}$, and the RN derivative is $M_{* \rightarrow c}(\underline{T}) / M_{* \rightarrow c}(\underline{0})$. The conclusion of the lemma then follows since $\bigcup_{\underline{\xi} \in \Xi^{*}}\left\{\underline{T}<\tau_{\underline{\xi}}\right\}=\{\underline{T} \in \mathcal{D}\}$.

### 3.3 A time curve in the time region

Suppose $\eta_{1}$ and $\eta_{2}$ are random radial Loewner curves driven by $\widehat{w}_{1}$ and $\widehat{w}_{2}$, which jointly follow one of the three laws $\mathbb{P}_{B}^{\mathrm{i}}, \mathbb{P}_{*}^{c}, \mathbb{P}_{c}^{c}$. Let $\theta=V_{1}-V_{2}$ and $Z_{j}=W_{j}-V_{j}, j=1,2$. By [20, (4.1)],

$$
\partial_{j} \theta=\frac{-W_{j, 1}^{2} \sin _{2}(\theta)}{\sin _{2}\left(W_{j}-V_{1}\right) \sin _{2}\left(W_{j}-V_{2}\right)} \partial t_{j}, \quad j=1,2
$$

When $j=2$, using $0>\sin _{2}\left(W_{j}-V_{1}\right) \sin _{2}\left(W_{j}-V_{2}\right) \geq-\sin (\theta / 4)^{2}$ and (3.1), we get

$$
\begin{equation*}
\partial_{2} \theta \geq 2 W_{2,1}^{2} \cot (\theta / 4) \partial t_{j}=2 \cot (\theta / 4) \partial_{2} \mathrm{~m} \tag{3.22}
\end{equation*}
$$

Recall that most of the processes we have encountered are defined on the time region $\mathcal{D} \subset$ $\mathbb{R}_{+}^{2}$. From now on, suppose $v_{1}-v_{2}=\pi$. Then $\theta(\underline{0})=\pi$. By [20, Section 4], there exists a continuous increasing curve $\underline{u}=\left(u_{1}, u_{2}\right): \mathbb{R}_{+} \rightarrow \overline{\mathcal{D}}$ with $\underline{u}(0)=\underline{0}$, and an extended number $T^{u} \in(0, \infty]$, such that $\underline{u}$ is strictly increasing and takes values in $\mathcal{D}$ on $\left[0, T^{u}\right)$, takes constant values in $\partial D$ on $\left[T^{u}, \infty\right)$, and for any $t \in\left[0, T^{u}\right), \mathrm{m}(\underline{u}(t))=t$ and $\theta(\underline{u}(t))=\pi$. We use such curve $\underline{u}$ to obtain a one-time-parameter process $X^{u}:=X \circ \underline{u}$ from any two-time-parameter process $X$ on $\mathcal{D}$. We have the following facts.

- For $0 \leq t<T^{u}, \mathrm{~m}^{u}(t)=t, \theta^{u}(t)=\pi$, and $Z_{j}^{u} \in(0, \pi), j=1,2$.
- For any $j \in\{1,2\}$ and $t \geq 0, u_{j}(t) \leq t$.
- $\underline{u}$ is differentiable with positive derivatives on $\left[0, T^{u}\right)$ that satisfy

$$
\begin{equation*}
\left(W_{j, 1}^{u}\right)^{2} u_{j}^{\prime}=\frac{\sin \left(Z_{j}^{u}\right)}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)}, \quad \text { on }\left[0, T^{u}\right), \quad j=1,2 . \tag{3.23}
\end{equation*}
$$

- For any deterministic time $t \in \mathbb{R}_{+}, \underline{u}(t)$ is an $\mathcal{F}$-stopping time.

Using the last property, we define an $\mathbb{R}_{+}$-indexed filtration $\mathcal{F}^{u}$ by $\mathcal{F}_{t}^{u}=\mathcal{F}_{\underline{u}(t)}, t \geq 0$. For $\xi=\left(\xi_{1}, \xi_{2}\right) \in \Xi$, let $\tau_{\underline{\xi}}^{u}$ denote the first $t \geq 0$ such that $u_{1}(t)=\tau_{\xi_{1}}^{1}$ or $u_{2}(t)=\tau_{\xi_{2}}^{2}$, whichever comes first. Then for any $\xi \in \Xi, \tau_{\xi}^{u}$ is an $\mathcal{F}^{u}$-stopping time; $\underline{u}\left(\tau_{\xi}^{u}\right)$ is an $\mathcal{F}$-stopping time; and for every deterministic $t \in \mathbb{R}_{+}, \underline{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)$ is an $\mathcal{F}$-stopping time.

First, suppose ( $\widehat{w}_{1}, \widehat{w}_{2}$ ) follows the law $\mathbb{P}_{B}^{\mathrm{i}}$. Then there are independent Brownian motions $B_{1}$ and $B_{2}$ such that $\widehat{w}_{j}\left(t_{j}\right)=w_{j}+\sqrt{\kappa} B_{j}\left(t_{j}\right), t_{j} \geq 0, j=1,2$. So we get five continuous $\mathcal{F}$-martingales: $\widehat{w}_{j}\left(t_{j}\right), \widehat{w}_{j}\left(t_{j}\right)^{2}-\kappa t_{j}, j=1,2$, and $\widehat{w}_{1}\left(t_{1}\right) \widehat{w}_{2}\left(t_{2}\right)$. Using Proposition 2.11 and the fact that for any $t \in \mathbb{R}_{+}, \underline{u}(t)$ is an $\mathcal{F}$-stopping time bounded by $(t, t)$, we see that $\widehat{w}_{j}^{u}(t)$, $\widehat{w}_{j}^{u}(t)^{2}-\kappa u_{j}(t), j=1,2$, and $\widehat{w}_{1}^{u}(t) \widehat{w}^{u}(t)$ are all $\mathcal{F}^{u}$-martingales. Note that $\widehat{w}_{j}^{u}(t)=\widehat{w}_{j}\left(u_{j}(t)\right)$. So we get quadratic variation and covariation for $\widehat{w}_{j}^{u}, j=1,2$ :

$$
\begin{equation*}
\left\langle\widehat{w}_{j}^{u}\right\rangle_{t}=\kappa u_{j}(t), \quad j=1,2, \quad\left\langle\widehat{w}_{1}^{u}, \widehat{w}_{2}^{u}\right\rangle \equiv 0 . \tag{3.24}
\end{equation*}
$$

Fix $\underline{\xi}=\left(\xi_{1}, \xi_{2}\right) \in \Xi$. Let $M \in\left\{M_{*}, M_{c}\right\}$. We have known that $M\left(\cdot \wedge \tau_{\underline{\xi}}\right)$ is a bounded $\mathcal{F}$-martingale (under $\mathbb{P}_{B}^{\mathrm{i}}$ ). From Proposition [2.11, $M\left(\underline{u}(\cdot) \wedge \tau_{\xi}\right)$ is an $\mathcal{F}^{u}$-martingale. Since $\tau_{\underline{\xi}}^{u}$ is an $\mathcal{F}^{u}$-stopping time, we see that $M\left(\underline{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right) \wedge \tau_{\underline{\xi}}\right)=M\left(\underline{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)\right)=M^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)$ is an $\overline{\mathcal{F}}^{u}$-martingale. Here the first equality holds because $\underline{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right) \leq \tau_{\underline{\xi}}$. Since $\left[0, T^{u}\right)=\bigcup_{\xi \in \Xi^{*}}\left[0, \tau_{\underline{\xi}}^{u}\right]$ and $\Xi^{*}$ is countable, we conclude that $M_{*}^{u}$ and $M_{c}^{u}$ are $\mathcal{F}^{\bar{u}}$-local martingales with lifetime $\bar{T}^{u}$ under the probability measure $\mathbb{P}_{B}^{\mathrm{i}}$.

Next, we compute the SDE for $M_{*}^{u}$ in terms of $\widehat{w}_{1}^{u}$ and $\widehat{w}_{2}^{u}$. By (3.17) we may express $M_{*}^{u}$ as a product of several factors. Among these factors, $\sin _{2}\left(W_{1}^{u}-W_{2}^{u}\right)^{\frac{2}{\kappa}},\left(W_{j, 1}^{u}\right)^{b}$ and $\mid \sin _{2}\left(W_{j}^{u}-\right.$ $\left.V_{s}^{u}\right)\left.\right|^{1-\frac{4}{\hbar}}, j, s \in\{1,2\}$, contribute the diffusion part of $M_{*}^{u}$, and other factors are differentiable in $t$. For $j \neq k \in\{1,2\}$ and $s \in\{1,2\}$, using (3.2]3.513.6), we get the following SDEs:

$$
\begin{gather*}
d W_{j}^{u}=W_{j, 1}^{u} d \widehat{w}_{j}^{u}-\kappa \mathrm{b} W_{j, 2} u_{j}^{\prime} d t+\cot _{2}\left(W_{j}^{u}-W_{k}^{u}\right)\left(W_{k, 1}^{u}\right)^{2} u_{k}^{\prime} d t  \tag{3.25}\\
\frac{d\left(W_{j, 1}^{u}\right)^{\mathrm{b}}}{\left(W_{j, 1}^{u}\right)^{\mathrm{b}}}=\mathrm{b} \frac{W_{j, 2}^{u}}{W_{j, 1}^{u}} d \widehat{w}_{j}^{u}+\text { drift terms } \\
\frac{d \sin _{2}\left(W_{j}^{u}-V_{s}^{u}\right)^{1-\frac{4}{\kappa}}}{\sin _{2}\left(W_{j}^{u}-V_{s}^{u}\right)^{1-\frac{4}{\kappa}}}=\frac{\kappa-4}{2 \kappa} \cot _{2}\left(W_{j}^{u}-V_{s}^{u}\right) W_{j, 1}^{u} d \widehat{w}_{j}^{u}+\text { drift terms } \\
\frac{d \sin _{2}\left(W_{1}^{u}-W_{2}^{u}\right)^{\frac{2}{\kappa}}}{\sin _{2}\left(W_{1}^{u}-W_{2}^{u}\right)^{\frac{2}{\kappa}}}=\frac{1}{\kappa} \cot _{2}\left(W_{j}^{u}-W_{k}^{u}\right)\left[W_{j, 1}^{u} d \widehat{w}_{j}^{u}-W_{k, 1}^{u} d \widehat{w}_{k}^{u}\right]+\text { drift terms. }
\end{gather*}
$$

Since we already know that $M_{*}^{u}, \widehat{w}_{1}^{u}$ and $\widehat{w}_{2}^{u}$ are $\mathcal{F}^{u}$-local martingales, we get the SDE:

\begin{equation*}
\frac{d M_{*}^{u}}{M_{*}^{u}}=\sum_{j=1}^{2}\left[\mathrm{~b} \frac{W_{j, 2}^{u}}{W_{j, 1}^{u}}+\frac{1}{\kappa} \cot _{2}\left(W_{j}^{u}-W_{3-j}^{u}\right) W_{j, 1}^{u}+\sum_{s=1}^{2} \frac{\kappa-4}{2 \kappa} \cot _{2}\left(W_{j}^{u}-V_{s}^{u}\right) W_{j, 1}^{u}\right] d \widehat{w}_{j}^{u} . \tag{3.26}
\end{equation*}
$$

Lemma 3.9. Under $\mathbb{P}_{*}^{c}$, for $j=1,2, \widehat{w}_{j}^{u}$ satisfies the SDE

$$
\begin{equation*}
d \widehat{w}_{j}^{u}=\sqrt{\kappa u_{j}^{\prime}} d B_{j}^{u}+\left[\kappa \mathrm{b} \frac{W_{j, 2}^{u}}{W_{j, 1}^{u}}+\cot _{2}\left(W_{j}^{u}-W_{3-j}^{u}\right) W_{j, 1}^{u}+\sum_{l=1}^{2} \frac{\kappa-4}{2} \cot _{2}\left(W_{j}^{u}-V_{l}^{u}\right) W_{j, 1}^{u}\right] u_{j}^{\prime} d t \tag{3.27}
\end{equation*}
$$

where $B_{j}^{u}(t), j=1,2$, are two independent Brownian motions.
Proof. This lemma is similar to [20, Lemma 4.3], and the proof uses a Girsanov-type argument. Here is a sketch. We first define $\widetilde{w}_{j}^{u}, j=1,2$, such that

\begin{align*}
\widetilde{w}_{j}^{u}(t)=\widehat{w}_{j}^{u}(t)-\int_{0}^{t} & {\left[\kappa \mathrm{~b} \frac{W_{j, 2}^{u}(s)}{W_{j, 1}^{u}(s)}+\cot _{2}\left(W_{j}^{u}(s)-W_{3-j}^{u}(s)\right) W_{j, 1}^{u}(s)\right.} \\
& \left.+\sum_{l=1}^{2} \frac{\kappa-4}{2} \cot _{2}\left(W_{j}^{u}(s)-V_{l}^{u}(s)\right) W_{j, 1}^{u}(s)\right] u_{j}^{\prime}(s) d s \tag{3.28}
\end{align*}
$$

By Lévy's characterization of Brownian motion, it suffices to show that $\widetilde{w}_{1}^{u}$ and $\widetilde{w}_{2}^{u}$ are local martingals under $\mathbb{P}_{*}^{c}, d\left\langle\widetilde{w}_{j}^{u}\right\rangle=d u_{j}, j=1,2$, and $\left\langle\widetilde{w}_{1}^{u}, \widetilde{w}_{2}^{u}\right\rangle \equiv 0$.

Using (3.26[3.28) and Itô's formula, it is straightforward to calculate that $\widetilde{w}_{j}^{u} M_{*}^{u}, j=1,2$, are $\mathcal{F}^{u}$-local martingales under $\mathbb{P}_{B}^{\mathrm{i}}$. Fix $j \in\{1,2\}$. Now we prove that $\widetilde{w}_{j}^{u}$ is a local martingale under $\mathbb{P}_{*}^{c}$. It suffices to prove that, for any $\underline{\xi} \in \Xi, \widetilde{w}_{j}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)$ is an $\mathcal{F}^{u}$-martingale under $\mathbb{P}_{*}^{c}$. Fix $\underline{\xi} \in \Xi$. Using an argument similar to the proof of Lemma 3.3, we can show that $\left|\widetilde{w}_{j}^{u}\right|$ is bounded on $\left[0, \tau_{\underline{\xi}}^{u}\right]$ by a constant depending only on $\kappa, \underline{\xi}, w_{1}, w_{2}, v_{1}, v_{2}$. So we see that $\widetilde{w}_{j}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right) M_{*}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)$, $j=1,2$, are bounded $\mathcal{F}^{u}$-martingales under $\mathbb{P}_{B}^{\mathrm{i}}$.

To prove that $\widetilde{w}_{j}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)$ is a martingale under $\mathbb{P}_{*}^{c}$, we fix $t>s \geq 0$ and $A \in \mathcal{F}_{s}^{u}$, and need to prove that

$$
\begin{equation*}
\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A} \widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A} \widetilde{w}_{j}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)\right] . \tag{3.29}
\end{equation*}
$$

Let $A_{1}=A \cap\left\{\tau_{\underline{\xi}}^{u} \leq s\right\}$ and $A_{2}=A \cap\left\{\tau_{\underline{\xi}}^{u}>s\right\}$. Then (3.29) would follow from

$$
\begin{align*}
& \mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{1}} \widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{1}} \widetilde{w}_{j}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)\right] ;  \tag{3.30}\\
& \mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)\right]=\mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)\right] . \tag{3.31}
\end{align*}
$$

Equality (3.30) is trivially true because $\widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)=\widetilde{w}_{u}^{j}\left(\tau_{\underline{\xi}}^{u}\right)=\widetilde{w}_{j}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)$ on $A_{1}$.
Since $\widetilde{w}_{j}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right) M_{*}^{u}\left(\cdot \wedge \tau_{\underline{\xi}}^{u}\right)$ is an $\mathcal{F}^{u}$-martingale under $\mathbb{P}_{B}^{\mathrm{i}}$ and $A_{2} \in \mathcal{F}_{s}^{u}$, we get

$$
\mathbb{E}_{B}^{\mathrm{i}}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right) M_{*}^{u}\left(t \wedge \tau_{\underline{\xi}}^{u}\right)\right]=\mathbb{E}_{B}^{\mathrm{i}}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right) M_{*}^{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)\right] .
$$

Then (3.31) would follow from the above equality and the equalities

$$
\begin{equation*}
\mathbb{E}_{B}^{\mathrm{i}}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(r \wedge \tau_{\underline{\xi}}^{u}\right) M_{*}^{u}\left(r \wedge \tau_{\underline{\xi}}^{u}\right)\right]=M_{*}(\underline{0}) \mathbb{E}_{*}^{c}\left[\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(r \wedge \tau_{\underline{\xi}}^{u}\right)\right], \quad r \in\{s, t\} \tag{3.32}
\end{equation*}
$$

We now prove (3.32) in the case $r=t$. The case $r=s$ is similar. By Proposition 3.5, $\mathbb{P}_{*}^{c} \mid \mathcal{F}_{\tau_{\underline{\xi}}}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{\mathrm{i}} \mid \mathcal{F}_{\tau_{\underline{\xi}}}$, and the RN derivative is $M_{*}\left(\tau_{\underline{\xi}}\right) / M_{*}(\underline{0})$. Since $M_{*}\left(\cdot \wedge \tau_{\underline{\xi}}\right)$ is a martingale, for any two-dimensional stopping time $\underline{T} \leq \tau_{\underline{\xi}}, \mathbb{P}_{*}^{c} \mid \overline{\mathcal{F}}_{\underline{T}}$ is absolutely continuous w.r.t. $\mathbb{P}_{B}^{\mathrm{i}} \mid \mathcal{F}_{\underline{T}}$, and the RN derivative is $M_{*}(\underline{T}) / M_{*}(\underline{0})$. Let $\underline{T}=\underline{u}\left(t \wedge \tau_{\xi}\right)$. Then $\underline{T}$ is a stopping time $\leq \tau_{\underline{\xi}}$. Since $\left\{\tau_{\underline{\xi}}^{u}>s\right\} \subset\left\{\underline{u}(s) \leq \underline{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)\right\}$ and $A \in \mathcal{F}_{s}^{u}=\overline{\mathcal{F}_{\underline{u}}(s)}$, we get $A_{2} \in \mathcal{F}_{\underline{u}\left(s \wedge \tau_{\underline{\xi}}^{u}\right)} \subset \mathcal{F}_{\underline{u}\left(t \wedge \tau_{\underline{\underline{\xi}}}\right)}=\mathcal{F}_{\underline{T}}$. Thus, $\mathbf{1}_{A_{2}} \widetilde{w}_{j}^{u}\left(t \wedge \tau_{\underline{\underline{\xi}}}^{u}\right)$ is $\mathcal{F}_{\underline{\underline{T}}}$-measurable. So we get (3.32) in the case $r=t$ using the RN derivative between $\mathbb{P}_{*}^{c} \mid \mathcal{F}_{\underline{T}}$ and $\mathbb{P}_{B}^{\mathrm{i}} \mid \mathcal{F}_{\underline{T}}$.

Now we have proved that $\widetilde{w}_{j}^{u}, j=1,2$, are $\mathcal{F}^{u}$-martingales under $\mathbb{P}_{*}^{c}$. Since (3.24) holds for $\widehat{w}_{j}^{u}$ under $\mathbb{P}_{B}^{\mathrm{i}}$, it also holds for $\widetilde{w}_{j}^{u}$ under $\mathbb{P}_{B}^{\mathrm{i}}$. For any $\xi \in \Xi$, using the local absolute continuity between $\mathbb{P}_{*}^{c} \mid \mathcal{F}_{\tau_{\underline{\xi}}}$ and $\mathbb{P}_{B}^{\mathrm{i}} \mid \mathcal{F}_{\tau_{\underline{\xi}}}$, we can then conclude that (3.24) also holds for $\widetilde{w}_{j}^{u}$ under $\mathbb{P}_{*}^{c}$ up to $\tau_{\xi}^{u}$. Since this holds for any $\xi \in \Xi$, we get $d\left\langle\widetilde{w}_{j}^{u}\right\rangle=d u_{j}, j=1,2$, and $\left\langle\widetilde{w}_{1}^{u}, \widetilde{w}_{2}^{u}\right\rangle \equiv 0$ throughout. The proof is then complete.

Now we suppose $\left(\widehat{w}_{1}, \widehat{w}_{2}\right)$ follows the law $\mathbb{P}_{*}^{c}$, and let $B_{1}^{u}$ and $B_{2}^{u}$ be the independent Brownian motions from Lemma 3.9. Combining (3.23|3.25|3.27), we get, for $j=1,2$,

d W_{j}^{u}=W_{j, 1}^{u} \sqrt{\kappa u_{j}^{\prime}} d B_{j}^{u}+\cot _{2}\left(W_{j}^{u}-W_{3-j}^{u}\right) d t+\sum_{s=1}^{2} \frac{\kappa-4}{2} \cot _{2}\left(W_{j}^{u}-V_{s}^{u}\right)\left(W_{j, 1}^{u}\right)^{2} u_{j}^{\prime} d t .
$$

Using (3.2) we get, for $j=1,2$,

$$
d V_{j}^{u}=-\cot _{2}\left(W_{j}^{u}-V_{j}^{u}\right)\left(W_{j, 1}^{u}\right)^{2} u_{j}^{\prime} d t-\cot _{2}\left(W_{3-j}^{u}-V_{j}^{u}\right)\left(W_{3-j, 1}^{u}\right)^{2} u_{3-j}^{\prime} d t .
$$

Since $Z_{j}^{u}=W_{j}^{u}-V_{j}^{u}, W_{3-j}^{u}-V_{j}^{u}=W_{3-j}^{u}-V_{3-j}^{u} \pm \pi=Z_{3-j}^{u} \pm \pi, W_{j}^{u}-W_{3-j}^{u}=Z_{j}^{u}-Z_{3-j}^{u} \mp \pi$, and $W_{j}^{u}-V_{3-j}^{u}=Z_{j}^{u} \mp \pi$, combining the above two displayed formulas with (3.23), we get, for $j=1,2$,

\begin{equation*}
d Z_{j}^{u}=\sqrt{\frac{\kappa \sin \left(Z_{j}^{u}\right)}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)}} d B_{j}^{u}+\frac{(\kappa-2) \cos \left(Z_{j}^{u}\right)}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)} d t . \tag{3.33}
\end{equation*}
$$

Remark 3.10. If the two force values $\kappa-4$ and $\kappa-4$ at $e^{i v_{1}}$ and $e^{i v_{2}}$ are respectively replaced by $\rho_{1}, \rho_{2} \in \mathbb{R}$, then $Z_{j}^{u}, j=1,2$, satisfy the SDE :

d Z_{j}^{u}=\sqrt{\frac{\kappa \sin \left(Z_{j}^{u}\right)}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)}} d B_{j}^{u}+\frac{\left(2+\left(\rho_{1}+\rho_{2}\right) / 2\right) \cos \left(Z_{j}^{u}\right)}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)} d t+\frac{\left(\rho_{j}-\rho_{3-j}\right) / 2}{\sin \left(Z_{1}^{u}\right)+\sin \left(Z_{2}^{u}\right)} d t .
$$

### 3.4 Transition density

We are going to derive the transition density of $\left(Z_{1}^{u}, Z_{2}^{u}\right)$ under $\mathbb{P}_{*}^{c}$ or $\mathbb{P}_{c}^{c}$ following the approach of [20, Section 5]. The idea, originated in [21, Appendix B], is to solve a PDE eigenvalue problem using orthogonal polynomials. First suppose that the underlying probability measure
is $\mathbb{P}_{*}^{c}$. Recall that $\left(Z_{1}^{u}, Z_{2}^{u}\right)$ satisfy (3.33), where $B_{1}^{u}$ and $B_{2}^{u}$ are independent Brownian motions by Lemma 3.9. Define $B_{+}^{u}$ and $B_{-}^{u}$ by

$$
B_{ \pm}^{u}(t)=\int_{0}^{t} \sqrt{\frac{\sin \left(Z_{1}^{u}(s)\right)}{\sin \left(Z_{1}^{u}(s)\right)+\sin \left(Z_{2}^{u}(s)\right)}} d B_{1}^{u}(s) \pm \int_{0}^{t} \sqrt{\frac{\sin \left(Z_{2}^{u}(s)\right)}{\sin \left(Z_{1}^{u}(s)\right)+\sin \left(Z_{2}^{u}(s)\right)}} d B_{1}^{u}(s) .
$$

Then $B_{+}^{u}$ and $B_{-}^{u}$ are standard linear Brownian motions with quadratic covariation

$$
\begin{equation*}
d\left\langle B_{+}^{u}, B_{-}^{u}\right\rangle_{t}=\cot _{2}\left(Z_{1}^{u}+Z_{2}^{u}\right) \tan _{2}\left(Z_{1}^{u}-Z_{2}^{u}\right) d t \tag{3.34}
\end{equation*}
$$

Define $Z_{ \pm}^{u}=\left(Z_{1}^{u} \pm Z_{2}^{u}\right) / 2$. Then $Z_{+}^{u} \in(0, \pi), Z_{-}^{u} \in(-\pi / 2, \pi / 2)$, and they satisfy the SDEs:

$$
\begin{aligned}
& d Z_{+}^{u}=\frac{\sqrt{\kappa}}{2} d B_{+}^{u}+\frac{\kappa-2}{2} \cot \left(Z_{+}^{u}\right) d t ; \\
& d Z_{-}^{u}=\frac{\sqrt{\kappa}}{2} d B_{-}^{u}-\frac{\kappa-2}{2} \tan \left(Z_{-}^{u}\right) d t .
\end{aligned}
$$

Let $X=\cos \left(Z_{+}^{u}\right)$ and $Y=\sin \left(Z_{-}^{u}\right)$. Then $X, Y \in(-1,1)$, and satisfy the SDEs

$$
\begin{aligned}
& d X=-\frac{\sqrt{\kappa}}{2} \sqrt{1-X^{2}} d B_{+}^{u}-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) X d t \\
& d Y=+\frac{\sqrt{\kappa}}{2} \sqrt{1-Y^{2}} d B_{-}^{u}-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) Y d t
\end{aligned}
$$

From (3.34) we have

$$
d\langle X, Y\rangle_{t}=-\frac{\kappa}{4} X Y d t .
$$

We have $(X, Y) \in \mathbb{D}$ because $X^{2}+Y^{2}=1-\sin \left(Z_{1}^{u}\right) \sin \left(Z_{2}^{u}\right)<1$.
Define a second order differential operator $\mathcal{L}$ by

$$
\mathcal{L}:=\frac{\kappa}{8}\left(1-x^{2}\right) \partial_{x}^{2}+\frac{\kappa}{8}\left(1-y^{2}\right) \partial_{y}^{2}-\frac{\kappa}{4} x y \partial_{x} \partial_{y}-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) x \partial_{x}-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) y \partial_{y} .
$$

Using orthogonal polynomials, we may find eigenvectors and eigenvalues of $\mathcal{L}$. Define

$$
\lambda_{s}=-\frac{\kappa}{8} s\left(s+4-\frac{8}{\kappa}\right), \quad s \in \mathbb{Z}_{+}=\{0,1,2,3, \ldots\} .
$$

A straightforward calculation shows that, for any $n, m \in \mathbb{Z}_{+}, \mathcal{L}\left(x^{n} y^{m}\right)$ equals $\lambda_{n+m} x^{n} y^{m}$ plus a polynomial in $x, y$ of degree less than $n+m$. Hence, for each $n, m \in \mathbb{Z}_{+}$, there is a polynomial $P_{(n, m)}(x, y)$ of degree $n+m$, which equals $x^{n} y^{m}$ plus a polynomial in $x, y$ of degree less than $n+m$, such that $\mathcal{L} P_{(n, m)}=\lambda_{n+m} P_{(n, m)}$.

Let $\Psi(x, y)=\left(1-x^{2}-y^{2}\right)^{1-\frac{4}{\kappa}}$, and define $\langle f, g\rangle_{\Psi}:=\iint_{\mathbb{D}} f(x, y) g(x, y) \Psi(x, y) d x d y$. Since $\Psi \equiv 0$ on $\mathbb{T}$, using integration by parts, we can show that for smooth functions $f$ and $g$ on $\overline{\mathbb{D}}$,
$\langle\mathcal{L} f, g\rangle_{\Psi}=\langle f, \mathcal{L} g\rangle_{\Psi}$. In fact, if we let $a_{x x}=\frac{\kappa}{8}\left(1-x^{2}\right), a_{y y}=\frac{\kappa}{8}\left(1-y^{2}\right), a_{x y}=a_{y x}=-\frac{\kappa}{8} x y$, $b_{x}=-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) x$, and $b_{y}=-\left(\frac{\kappa-2}{2}+\frac{\kappa}{8}\right) y$, then both $\langle\mathcal{L} f, g\rangle_{\Psi}$ and $\langle f, \mathcal{L} g\rangle_{\Psi}$ equal

$$
-\iint_{\mathbb{D}}\left[\left(\partial_{x} f\right) a_{x x} \Psi\left(\partial_{x} g\right)+\left(\partial_{x} f\right) a_{x y} \Psi\left(\partial_{y} g\right)+\left(\partial_{y} f\right) a_{y x} \Psi\left(\partial_{x} g\right)+\left(\partial_{y} f\right) a_{y y} \Psi\left(\partial_{y} g\right)\right] d x d y .
$$

Here we use $\partial_{x}\left(a_{x x} \Psi\right)+\partial_{y}\left(a_{x y} \Psi\right)=b_{x} \Psi$ and $\partial_{x}\left(a_{y x} \Psi\right)+\partial_{y}\left(a_{y y} \Psi\right)=b_{y} \Psi$.
Thus, the eigenvectors of $\mathcal{L}$ with different eigenvalues are orthogonal w.r.t. $\langle\cdot\rangle_{\Psi}$, and we may use $P_{(n, m)}, n, m \in \mathbb{Z}_{+}$, to construct an $\langle\cdot\rangle_{\Psi}$-orthonormal family of polynomials $v_{(n, s)}, n \in \mathbb{Z}_{+}$, $s \in\{0,1, \ldots, n\}$, such that $v_{(n, s)}$ is of degree $n$ and $\mathcal{L} v_{(n, s)}=\lambda_{n} v_{(n, s)}$. From [18, Section 1.2.2], we may choose $v_{(n, s)}$ such that for each $n \geq 0, v_{(n, 0)}, v_{(n, 1)}, \ldots, v_{(n, n)}$ are given by

v_{n, j, 1}=h_{n, j, 1} P_{j}^{\left(1-\frac{4}{\kappa}, n-2 j\right)}\left(2 r^{2}-1\right) r^{n-2 j} \cos ((n-2 j) \theta), \quad 0 \leq j \leq\lfloor n / 2\rfloor, \\
v_{n, j, 2}=h_{n, j, 2} P_{j}^{\left(1-\frac{4}{\kappa}, n-2 j\right)}\left(2 r^{2}-1\right) r^{n-2 j} \sin ((n-2 j) \theta), \quad 0 \leq j \leq\lfloor(n-1) / 2\rfloor,
\end{gathered}
$$

where $P_{j}^{\left(1-\frac{4}{\kappa}, n-2 j\right)}$ are Jacobi polynomials of index $\left(1-\frac{4}{\kappa}, n-2 j\right),(r, \theta)$ is the polar coordinate of $(x, y): x=r \cos \theta$ and $y=r \sin \theta$, and $h_{n, j, i}>0$ are normalization constants. Using the polar integration and Formula [12, Table 18.3.1]:

\int_{-1}^{1} P_{j}^{(\alpha, \beta)}(x)^{2}(1-x)^{\alpha}(1+x)^{\beta} d x=\frac{2^{\alpha+\beta+1} \Gamma(j+\alpha+1) \Gamma(j+\beta+1)}{j!(2 j+\alpha+\beta+1) \Gamma(j+\alpha+\beta+1)}
$$

with $\alpha=1-\frac{4}{\kappa}$ and $\beta=n-2 j$, we compute

h_{n, j}:=h_{n, j, 1}=h_{n, j, 2}=\sqrt{\frac{1+\mathbf{1}_{n \neq 2 j}}{\pi} \cdot \frac{j!\left(n+2-\frac{4}{\kappa}\right) \Gamma\left(n-j+2-\frac{4}{\kappa}\right)}{\Gamma\left(j+2-\frac{4}{\kappa}\right) \Gamma(n-j+1)}} .
$$

Using the supremum norm (over $[-1,1])$ of $P_{j}^{(\alpha, \beta)}([12,18.14 .1,18.14 .2])$ :

\left\|P_{j}^{(\alpha, \beta)}\right\|_{\infty}=\frac{\Gamma(\max \{\alpha, \beta\}+j+1)}{j!\Gamma(\max \{\alpha, \beta\}+1)}, \quad \text { if } \max \{\alpha, \beta\} \geq-1 / 2 \text { and } \min \{\alpha, \beta\}>-1,
$$

we get

\left\|v_{n, j, 1}\right\|_{\infty}=\left\|v_{n, j, 2}\right\|_{\infty}=h_{n, j} \max \left\{\frac{\Gamma\left(2-\frac{4}{\kappa}+j\right)}{j!\Gamma\left(2-\frac{4}{\kappa}\right)}, \frac{\Gamma(n-j+1)}{j!\Gamma(n-2 j+1)}\right\} . \tag{3.35}
\end{equation*}
$$

For $t>0,(x, y),\left(x^{*}, y^{*}\right) \in \mathbb{D}$, we define

\begin{equation*}
p_{t}\left((x, y),\left(x^{*}, y^{*}\right)\right)=\sum_{n=0}^{\infty} \sum_{s=0}^{n} \Psi\left(x^{*}, y^{*}\right) v_{(n, s)}(x, y) v_{(n, s)}\left(x^{*}, y^{*}\right) e^{\lambda_{n} t}, \tag{3.36}
\end{equation*}
$$

and $p_{\infty}\left(x^{*}, y^{*}\right)=\frac{1}{\pi}\left(2-\frac{4}{\kappa}\right) \Psi\left(x^{*}, y^{*}\right)$, which is the term in the summation for $n=s=0$. The following propositions are similar to Lemma 5.1, Lemma 5.2 and Corollary 5.3 of [20]. The proofs use the estimate (3.35) and the orthogonality between $v_{n, s}$ w.r.t. $\langle\cdot\rangle_{\Psi}$. The exponent $1-\frac{5}{8} \kappa$ in Lemma 3.11 is the $\lambda_{1}$ here.

Lemma 3.11. For any $t_{0}>0$, the series in (3.36) converges uniformly on $\left[t_{0}, \infty\right) \times \overline{\mathbb{D}} \times \overline{\mathbb{D}}$, and there is $C_{t_{0}} \in(0, \infty)$ depending only on $\kappa$ and $t_{0}$ such that

\left|p_{t}\left((x, y),\left(x^{*}, y^{*}\right)\right)-p_{\infty}\left(x^{*}, y^{*}\right)\right| \leq C_{t_{0}} e^{\left(1-\frac{5}{8} \kappa\right) t} p_{\infty}\left(x^{*}, y^{*}\right), \quad t \geq t_{0}, \quad(x, y),\left(x^{*}, y^{*}\right) \in \overline{\mathbb{D}} .
$$

Moreover, for any $t>0$ and $\left(x^{*}, y^{*}\right) \in \overline{\mathbb{D}}$,

p_{\infty}\left(x^{*}, y^{*}\right)=\iint_{\mathbb{D}} p_{\infty}(x, y) p_{t}\left((x, y),\left(x^{*}, y^{*}\right)\right) d x d y
$$

Lemma 3.12. $(X, Y)$ (under $\left.\mathbb{P}_{*}^{c}\right)$ has transition density $p_{t}$ and invariant density $p_{\infty}$.
Corollary 3.13. $\left(Z_{1}^{u}, Z_{2}^{u}\right)$ under $\mathbb{P}_{*}^{c}$ has transition density

$$
p_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right):=p_{t}\left(\left(\cos _{2}\left(z_{1}+z_{2}\right), \sin _{2}\left(z_{1}-z_{2}\right)\right),\left(\cos _{2}\left(z_{1}^{*}+z_{2}^{*}\right), \sin _{2}\left(z_{1}^{*}-z_{2}^{*}\right)\right)\right) \frac{\sin z_{1}^{*}+\sin z_{2}^{*}}{4}
$$

and invariant density $p_{\infty}^{Z}\left(\underline{z}^{*}\right):=p_{\infty}\left(\cos _{2}\left(z_{1}^{*}+z_{2}^{*}\right), \sin _{2}\left(z_{1}^{*}-z_{2}^{*}\right)\right) \frac{\sin z_{1}^{*}+\sin z_{2}^{*}}{4}$.
We may then use Lemma 3.8 to derive the transition density for $\left(Z_{1}^{u}, Z_{2}^{u}\right)$ under the law $\mathbb{P}_{c}^{c}$. Let $t \in \mathbb{R}_{+}$. Since $\underline{u}(t)$ is an $\mathcal{F}$-stopping time, and $\underline{u}(t) \in \mathcal{D}$ iff $T^{u}>t$, by Lemma 3.8,

\end{equation*}
$$

Let $\widetilde{G}^{u}\left(z_{1}, z_{2}\right):=\widetilde{G}\left(\pi+z_{1}, \pi, z_{2}, 0\right)$. By (3.20), we get $M_{* \rightarrow c}^{u}(t)=e^{-\alpha_{0} t} \widetilde{G}^{u}\left(Z_{1}^{u}(t), Z_{2}^{u}(t)\right)^{-1}$. Combining this with (3.37) and Corollary 3.13, we get the transition density for $\left(Z_{1}^{u}, Z_{2}^{u}\right)$ under the law $\mathbb{P}_{c}^{c}$ in the lemma below, which resembles [20, Lemma 5.4].

Lemma 3.14. Under $\mathbb{P}_{c}^{c}, \underline{Z}^{u}(t):=\left(Z_{1}^{u}(t), Z_{2}^{u}(t)\right), 0 \leq t<T^{u}$, has transition density

\widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right):=e^{-\alpha_{0} t} p_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right) \frac{\widetilde{G}^{u}(\underline{z})}{\widetilde{G}^{u}\left(\underline{z}^{*}\right)} .
$$

Here the meaning of the transition density is: if $\underline{Z}^{u}$ starts with $\underline{z} \in(0, \pi)^{2}$, then for any $t>0$ and any bounded measurable function $f$ on $(0, \pi)^{2}$,

\mathbb{E}_{c}^{c}\left[1_{\left\{T^{u}>t\right\}} f\left(\underline{Z}^{u}(t)\right)\right]=\int_{(0, \pi)^{2}} \widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right) f\left(\underline{z}^{*}\right) d \underline{z}^{*}
$$

We compute that $\frac{p_{\infty}^{z}\left(z_{1}, z_{2}\right)}{\tilde{G}^{u}\left(z_{1}, z_{2}\right)}=C \cos _{2}\left(z_{1}-z_{2}\right)^{2-\frac{8}{\kappa}} \sin _{2}\left(z_{1}+z_{2}\right)$ for some constant $C \in(0, \infty)$ depending only on $\kappa$. Since $2-\frac{8}{\kappa}>0$, we may define

\mathcal{Z}=\int_{(0, \pi)^{2}} \frac{p_{\infty}^{Z}(\underline{z})}{\widetilde{G}^{u}(\underline{z})} d \underline{z} \in(0, \infty) \tag{3.38}

\begin{equation*}
\widetilde{p}_{\infty}^{Z}(\underline{z})=\frac{1}{\mathcal{Z}} \frac{p_{\infty}^{Z}(\underline{z})}{\widetilde{G}^{u}(\underline{z})}, \quad \underline{z} \in(0, \pi)^{2} \tag{3.39}
\end{equation*}
$$

The following lemma resembles [20, Lemma 5.5].
Lemma 3.15. (i) For any $t>0$ and $\underline{z}^{*} \in(0, \pi)^{2}$,

\int_{(0, \pi)^{2}} \widetilde{p}_{\infty}^{Z}(\underline{z}) \widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right) d \underline{z}=\widetilde{p}_{\infty}^{Z}\left(\underline{z}^{*}\right) e^{-\alpha_{0} t} \tag{3.40}
\end{equation*}
$$

(ii) If $\underline{Z}^{u}$ starts from $\underline{z} \in(0, \pi)^{2}$, then as $t \rightarrow \infty$,

\begin{gathered}
\mathbb{P}_{c}^{c}\left[T^{u}>t\right]=\mathcal{Z} \widetilde{G}^{u}(\underline{z}) e^{-\alpha_{0} t}\left(1+O\left(e^{\left(1-\frac{5}{8} \kappa\right) t}\right)\right), \\
\widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right)=\mathbb{P}_{c}^{c}\left[T^{u}>t\right] \widetilde{p}_{\infty}^{Z}\left(\underline{z}^{*}\right)\left(1+O\left(e^{\left(1-\frac{5}{8} \kappa\right) t}\right)\right),
\end{gathered}
$$

where the implicit constant depends only on $\kappa$. The two formulas together imply that

\end{equation*}
$$

## 4 Proof of the Main Theorem

We now start the proof of Theorem 1.1. By conformal invariance, Koebe's distortion theorem and reflection symmetry, we may assume that $D=\mathbb{D}, z_{0}=0$, and $a_{j}=e^{i w_{j}}$ and $b_{j}=e^{i v_{j}}$, $j=1,2$, where $w_{1}>v_{1}>w_{2}>v_{2}>w_{1}-2 \pi$. Then we have $G_{D ; a_{1}, b_{1}, a_{2}, b_{2}}(0)=\widetilde{G}\left(w_{1}, v_{1}, w_{2}, v_{2}\right)$. Let $\gamma_{1}$ be as in the theorem, and let $\gamma_{2}$ be a time-reversal of $\gamma_{1}$. By reversibility, $\gamma_{2}$ is a chordal $\mathrm{SLE}_{\kappa}$ in $\mathbb{D}$ from $e^{i w_{2}}$ to $e^{i w_{1}}$. We may assume that for $j=1,2, \gamma_{j}$ is parametrized by some capacity viewed from $a_{3-j}$. This means that there is a conformal map $f_{j}: \mathbb{D} \xrightarrow{\text { Conf }} \mathbb{H}$, which sends $a_{3-j}$ to $\infty$ such that hcap $f_{j}\left(\gamma_{j}[0, t]\right)=t$ for $t \geq 0$. For $r \in(0,1)$, let $E(r)$ denote the event that $\gamma \cup A_{1} \cup A_{2}$ has a cut point that lies in $\{|z|<r\}$, which also depends on $w_{1}, v_{1}, w_{2}, v_{2}$, and let $P\left(w_{1}, v_{2}, w_{2}, v_{2} ; r\right)=\mathbb{P}[E(r)]$. We need to show that there is a constant $C_{0}>0$ depending only on $\kappa$ such that

\begin{equation*}
P\left(w_{1}, v_{1}, w_{2}, v_{2} ; r\right)=C_{0} \widetilde{G}^{u}\left(w_{1}, v_{1}, w_{2}, v_{2}\right) r^{\alpha_{0}}\left(1+O\left(r^{\beta_{0}}\right)\right), \quad \text { as } r \rightarrow 0 . \tag{4.1}
\end{equation*}
$$

For $j=1,2$, let $\widehat{S}_{j}$ be the first time that $\gamma_{j}$ separates 0 from any of $e^{i w_{3-j}}, e^{i v_{1}}, e^{i v_{2}}$ in $\mathbb{D}$. Let $v_{j}(t)=\operatorname{dcap}\left(\gamma_{j}[0, t]\right), 0 \leq t<\widehat{S}_{j}, \widehat{T}_{j}=v_{j}\left(\widehat{S}_{j}\right), u_{j}=v_{j}^{-1}:\left[0, \widehat{T}_{j}\right) \rightarrow\left[0, \widehat{S}_{j}\right)$, and $\eta_{j}=\gamma_{j} \circ u_{j}$. By [17], $\eta_{j}$ is a radial $\operatorname{SLE}_{\kappa}(\kappa-6,0,0)$ curve in $\mathbb{D}$ started from $e^{i w_{j}}$ with force points $e^{i w_{3-j}}, e^{i v_{1}}, e^{i v_{2}}$. Let $\widehat{w}_{j}$ be a radial Loewner driving function of $\eta_{j}$ with $\widehat{w}_{j}(0)=w_{j}$. We will use the notation in Section 3.1 for the radial Loewner curves $\eta_{1}, \eta_{2}$ in this section.

For $j=1,2$, let $\mathcal{G}^{j}$ and $\mathcal{F}^{j}$ be respectively the filtrations generated by $\gamma_{j}$ and $\eta_{j}$. Then $\widehat{S}_{j}$ is an $\mathcal{G}^{j}$-stopping time. Let $\overline{\mathcal{F}}^{j}$ and $\overline{\mathcal{G}}^{j}$ be respectively the right-continuous augmentation of $\mathcal{F}^{j}$ and $\mathcal{G}^{j}$. We extend $u_{j}$ to $[0, \infty]$ such that $u_{j} \equiv \infty$ on $\left[\widehat{T}_{j}, \infty\right]$. The following is a well-known proposition about time-change.

Proposition 4.1. For $j \in\{1,2\}$, if $\tau$ is an $\overline{\mathcal{F}}^{j}$-stopping time, then $u_{j}(\tau)$ is an $\overline{\mathcal{G}}^{j}$-stopping time, and $\overline{\mathcal{F}}_{\tau}^{j} \subset \overline{\mathcal{G}}_{u_{j}(\tau)}^{j}$.

Fix $j \neq k \in\{1,2\}$. Let $\tau_{k}$ be an $\mathcal{F}^{k}$-stopping time less than $\widehat{T}_{k}$ and let $\sigma_{k}=u_{k}\left(\tau_{k}\right)$, which by Proposition 4.1 is an $\overline{\mathcal{G}}_{\sigma_{k}}^{k}$-stopping time. By DMP of chordal SLE $_{\kappa}$, conditionally on $\overline{\mathcal{G}}_{\sigma_{k}}^{k}$, the part of $\gamma_{k}$ after $\sigma_{k}$ is a chordal $\operatorname{SLE}_{\kappa}$ in $\mathbb{D} \backslash K_{k}\left(\tau_{k}\right)$ from $\gamma_{k}\left(\sigma_{k}\right)=\eta_{k}\left(\tau_{k}\right)$ to $e^{i w_{j}}$. Since $\gamma_{j}$ is a time-reversal of $\gamma_{k}$, by reversibility of chordal $\operatorname{SLE}_{\kappa}$, conditionally on $\overline{\mathcal{G}}_{\sigma_{k}}^{k}$, the part of $\gamma_{j}$ up to the time that it hits $\eta_{k}\left(\tau_{k}\right)$ is a chordal $\operatorname{SLE}_{\kappa}$ in $\mathbb{D} \backslash K_{k}\left(\tau_{k}\right)$ from $e^{i w_{j}}$ to $\eta_{k}\left(\tau_{k}\right)$. Recall that $\eta_{j}$ is a time-change of the part of $\gamma_{j}$ up to the first time that it separates 0 from any of $e^{i w_{k}}, e^{i v_{1}}, e^{i v_{2}}$ in $\mathbb{D}$. So the part of $\eta_{j}$ up to the first time that it hits $\eta_{k}\left[0, \tau_{k}\right]$ is a time-change of the part of $\gamma_{j}$ up to the first time that it separates 0 from any of $e^{i w_{k}}, e^{i v_{1}}, e^{i v_{2}}$ in $\mathbb{D} \backslash K_{k}\left(\tau_{k}\right)$.

Since $g_{k}\left(\tau_{k}, \cdot\right)$ maps $\mathbb{D} \backslash K_{k}\left(\tau_{k}\right)$ conformally onto $\mathbb{D}$, sends $\eta_{k}\left(\tau_{k}\right)$ to $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}$, and is measurable w.r.t. $\mathcal{F}_{\tau_{k}}^{k} \subset \overline{\mathcal{G}}_{\sigma_{k}}^{k}$, by conformal invariance of chordal SLE, we see that, conditionally on $\overline{\mathcal{G}}_{\sigma_{k}}^{k}$, the $g_{k}\left(\tau_{k}, \cdot\right)$-image of the part of $\eta_{j}$ up to the first time that it hits $\eta_{k}\left[0, \tau_{k}\right]$ is a time-change of a chordal $\operatorname{SLE}_{\kappa}$ in $\mathbb{D}$ from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ to $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}$ up to the first time that it separates 0 from any of $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i v_{1}}\right), g_{k}\left(\tau_{k}, e^{i v_{2}}\right)$ in $\mathbb{D}$, which by [17] is a time-change of a radial $\operatorname{SLE}_{\kappa}(\kappa-6,0,0)$ curve in $\mathbb{D}$ started from $g_{k}\left(\tau_{k}, e^{i w_{j}}\right)$ with force points $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}, g_{k}\left(\tau_{k}, e^{i v_{1}}\right), g_{k}\left(\tau_{k}, e^{i v_{2}}\right)$. Since $g_{\tau_{k}}^{k}$ and $e^{i \widehat{w}_{k}\left(\tau_{k}\right)}$ are $\mathcal{F}_{\tau_{k}}^{k}$-measurable, the above statement holds with $\mathcal{F}_{\tau_{k}}^{k}$ in place of $\overline{\mathcal{G}}_{\sigma_{k}}^{k}$. So we obtain the commutation coupling in Proposition [3.7, and the law of $\left(\widehat{w}_{1}, \widehat{w}_{2}\right)$ is $\mathbb{P}_{c}^{c}$.

Let $\mathcal{F}$ and $\mathcal{G}$ be respectively the separable $\mathbb{R}_{+}^{2}$-indexed filtration generated by $\mathcal{F}^{1}, \mathcal{F}^{2}$ and $\mathcal{G}^{1}, \mathcal{G}^{2}$, and let $\overline{\mathcal{F}}$ and $\overline{\mathcal{G}}$ be their right-continuous augmentation. Let $\widehat{\underline{T}}=\left(\widehat{T}_{1}, \widehat{T}_{2}\right)$ and $\underline{\widehat{S}}=$ $\left(\widehat{S}_{1}, \widehat{S}_{2}\right)$. Define $u_{\otimes}$ on $[0, \infty]^{2}$ such that if $\left(t_{1}, t_{2}\right) \in\left[0, \widehat{T}_{1}\right) \times\left[0, \widehat{T_{2}}\right), u_{\otimes}\left(t_{1}, t_{2}\right)=\left(u_{1}\left(t_{1}\right), u_{2}\left(t_{2}\right)\right)$, and otherwise $u_{\otimes}\left(t_{1}, t_{2}\right)=(\infty, \infty)$.

Lemma 4.2. For any $\overline{\mathcal{F}}$-stopping time $\underline{T}, u_{\otimes}(\underline{T})$ is an $\overline{\mathcal{G}}$-stopping time and $\overline{\mathcal{F}}_{\underline{T}} \subset \overline{\mathcal{G}}_{u_{\otimes}(\underline{T})}$.
Proof. Let $A \in \overline{\mathcal{F}}_{\underline{T}}$ and $\underline{s}=\left(s_{1}, s_{2}\right) \in \mathbb{R}_{+}^{2}$. We have

A \cap\left\{u_{\otimes}(\underline{T})<\underline{s}\right\}=\bigcup_{\underline{p} \in \mathbb{Q}_{+}^{2}}\left(A \cap\{\underline{T}<\underline{p}\} \cap\left\{u_{\otimes}(\underline{p})<\underline{s}\right\}\right) . \tag{4.2}
\end{equation*}
$$

By Proposition [2.9, $A \cap\{\underline{T}<\underline{p}\} \in \mathcal{F}_{\underline{p}}$. For any $j=1,2$ and $B_{j} \in \mathcal{F}_{p_{j}}^{j}$, by Proposition 4.1, $B_{j} \cap\left\{u_{j}\left(p_{j}\right)<s_{j}\right\} \in \mathcal{G}_{s_{j}}^{j}$. By a monotone class argument, we get $B \cap\left\{u_{\otimes}(\underline{p})<\underline{s}\right\} \in \mathcal{G}_{\underline{s}}$ for any $B \in \mathcal{F}_{\underline{p}}$. So $A \cap\{\underline{T}<\underline{p}\} \cap\left\{u_{\otimes}(\underline{p})<\underline{s}\right\} \in \mathcal{G}_{\underline{s}}$. By (4.2) we get $A \cap\left\{u_{\otimes}(\underline{T})<\underline{s}\right\} \in \mathcal{G}_{\underline{\mathcal{S}^{\prime}}}$. Since this holds for all $A \in \overline{\mathcal{F}}_{\underline{T}}$ and $\underline{s} \in \mathbb{R}_{+}^{2}$, by Proposition [2.9, we see that $u_{\otimes}(\underline{T})$ is an $\overline{\mathcal{G}}$-stopping time and $\overline{\mathcal{F}}_{\underline{T}} \subset \overline{\mathcal{G}}_{u_{\otimes}(\underline{T})}$.

Lemma 4.3. Let $0<r<1 / 4$. Let $\underline{T}=\left(T_{1}, T_{2}\right)$ be an $\overline{\mathcal{F}}$-stopping time such that $T_{j}<-\log (4 r)$, $j=1,2$, and when $\underline{T} \in \mathcal{D}, \mathrm{~m}(\underline{T})<-\log (4 r)$. On the event $\{\underline{T} \in \mathcal{D}\}$, let $R_{+}>R_{-} \in(0,1)$ be such that $\frac{R_{ \pm}}{\left(1 \pm R_{ \pm}\right)^{2}}=e^{\mathrm{m}(\underline{T})} r$, which exist uniquely because $e^{\mathrm{m}(\underline{T})} r<1 / 4$. Then

\begin{equation*}
\mathbb{P}\left[E(r) \mid \overline{\mathcal{F}}_{\underline{T}}\right] \lesseqgtr \mathbf{1}_{\{\underline{T} \in \mathcal{D}\}} \cdot P\left(W_{1}(\underline{T}), V_{1}(\underline{T}), W_{2}(\underline{T}), V_{2}(\underline{T}) ; R_{ \pm}\right) . \tag{4.3}
\end{equation*}
$$

Here and below the symbol $\lesseqgtr$ means that when we choose + and - in the $\pm$ on the RHS, the inequality holds with $\leq$ and $\geq$, respectively.
Proof. For $j=1,2$, let $\tau_{r}^{j}$ and $\widetilde{\tau}_{r}^{j}$ be respectively the first time that $\eta_{j}$ and $\gamma_{j}$ visits $\{|z| \leq r\}$. First, suppose the event $E(r)$ happens. Then $\gamma_{1}$ and $\gamma_{2}$ do reach $\{|z| \leq r\}$, i.e., $\widetilde{\tau}_{r}^{j}<\infty, j=1,2$. By duality of SLE (cf. [10, Theorem 1.4] and [11, the discussion before Theorem 1.5]), the left boundary and right boundary of $\gamma_{1}$ are two (simple) flow lines, whose intersection is the cut-set of $\eta_{1}$. In fact, the two simple flow lines are $\operatorname{SLE}_{\kappa^{\prime}}\left(\kappa^{\prime}-4, \frac{\kappa^{\prime}}{2}-2\right)$ and $\operatorname{SLE}_{\kappa^{\prime}}\left(\frac{\kappa^{\prime}}{2}-2, \kappa^{\prime}-4\right)$ curves, where $\kappa^{\prime}=16 / \kappa$, starting from $\eta_{1}(0)$ with the force points being $\eta_{1}(0)^{+}$and $\eta_{1}(0)^{-}$. We do not need the laws of these curves. Thus, for $j=1,2, \gamma_{j}\left[0, \widetilde{\tau}_{r}^{\jmath}\right]$ does not intersect $A_{3-j}$ or disconnect 0 from $\partial \mathbb{D}$; and $\gamma_{1}\left[0, \widetilde{\tau}_{r}^{1}\right] \cap \gamma_{2}\left[0, \widetilde{\tau}_{r}^{2}\right]=\emptyset$. The former condition implies that $\widetilde{\tau}_{r}^{j}<\widehat{S}_{j}$, and so $\tau_{r}^{j}=v_{j}\left(\widetilde{\tau}_{r}^{j}\right)<\widehat{T}_{j}$; and the latter implies that $\eta_{1}\left[0, \tau_{r}^{1}\right] \cap \eta_{2}\left[0, \tau_{r}^{2}\right]=\emptyset$. So we get $\left(\tau_{r}^{1}, \tau_{r}^{2}\right) \in \mathcal{D}$. Since $\mathbb{D} \backslash K_{j}\left(\tau_{r}^{j}\right) \supset\{|z|<r\}$, by Koebe's $1 / 4$ theorem, $\tau_{r}^{j} \geq-\log (4 r) \geq T_{j}, j=1,2$. Since $\left(\tau_{r}^{1}, \tau_{r}^{2}\right) \in \mathcal{D}$ and $\mathcal{D}$ is an HC region, we get $\underline{T} \in \mathcal{D}$. Thus, $E(r) \subset\{\underline{T} \in \mathcal{D}\}$.

Now we assume that $\{\underline{T} \in \mathcal{D}\}$ (instead of $E(r)$ ) happens. Let $\widetilde{\gamma}_{1}$ denote the part of $\gamma_{1}$ between $\eta_{1}\left(T_{1}\right)$ and $\eta_{2}\left(T_{2}\right)$. Let $\widetilde{A}_{j}:=A_{j} \cup \eta\left[0, T_{j}\right], j=1,2$. Then $\gamma_{1} \cup A_{1} \cup A_{2}=\widetilde{\gamma}_{1} \cup \widetilde{A}_{1} \cup \widetilde{A}_{2}$. By Lemma4.2, $u_{\otimes}(\underline{T})$ is an $\overline{\mathcal{G}}$-stopping time. By Theorem A.1, conditionally on $\overline{\mathcal{G}}_{u_{\otimes}(\underline{T})}$ and the event $\{\underline{T} \in \mathcal{D}\}, \widetilde{\gamma}$ is a time-change of a chordal $\mathrm{SLE}_{\kappa}$ in $\mathbb{D} \backslash K(\underline{T})$ from $\eta_{1}\left(T_{1}\right)=\gamma_{1}\left(u_{1}\left(T_{1}\right)\right)$ to $\eta_{2}\left(T_{2}\right)=\gamma_{2}\left(u_{2}\left(T_{2}\right)\right)$. Since the event $\{\underline{T} \in \mathcal{D}\}$ and the random elements $\mathbb{D} \backslash K(\underline{T})$ and $\eta_{j}\left(T_{j}\right)$, $j=1,2$, are all $\overline{\mathcal{F}}_{\underline{T}}$-measurable, the above statement holds with $\overline{\mathcal{F}}_{\underline{T}}$ in place of $\overline{\mathcal{G}}_{u_{\otimes}(\underline{T})}$. Since $g(\underline{T}, \cdot)$ is $\overline{\mathcal{F}}_{\underline{T}}$-measurable, and sends $\eta_{1}\left(T_{1}\right)$ and $\eta_{2}\left(T_{2}\right)$ respectively to $e^{i W_{1}(\underline{T})}$ and $e^{i \bar{W}_{2}(\underline{T})}$, we conclude that, conditionally on $\overline{\mathcal{F}}_{\underline{T}}$ and the event $\{\underline{T} \in \mathcal{D}\}, g(\underline{T}, \widetilde{\gamma})$ is a time-change of a chordal $\mathrm{SLE}_{\kappa}$ in $\mathbb{D}$ from $e^{i W_{1}(\underline{T})}$ to $e^{i W_{2}(\underline{\underline{T}})}$.

For $j=1,2$, let $A_{j}(\underline{T})$ be the boundary arc of $\mathbb{D}$ connecting $e^{i V_{1}(\underline{T})}$ and $e^{i V_{2}(\underline{T})}$ which contains $e^{i W_{j}(\underline{T})}$. Since $g(\underline{T}, \cdot)$ sends $e^{i v_{1}}$ and $e^{i v_{2}}$ respectively to $e^{i V_{1}(\underline{T})}$ and $e^{i V_{2}(\underline{T})}$, that $\widetilde{\gamma}_{1} \cup \widetilde{A}_{1} \cup \widetilde{A}_{2}$ contains a cut point in $\{|z|<r\}$ is then equivalent to that $g\left(\underline{T}, \widetilde{\gamma}_{1}\right) \cup A_{1}(\underline{T}) \cup A_{2}(\underline{T})$ has a cut point contained in $g(\underline{T},\{|z|<r\})$. Recall that $g(\underline{T}, \cdot)$ maps $\mathbb{D} \backslash K(\underline{T})$ conformally onto $\mathbb{D}$, fixes 0 , and has derivative $e^{\mathrm{m}(\underline{T})}$ at 0 . By Koebe's distortion theorem applied to $e^{\mathrm{m}(\underline{T})} g(\underline{T}, \cdot)^{-1}$,

$$
\left\{|z|<\frac{e^{-\mathrm{m}(\underline{T})} R}{(1+R)^{2}}\right\} \subset g(\underline{T}, \cdot)^{-1}(\{|z|<R\}) \subset\left\{|z|<\frac{e^{-\mathrm{m}(\underline{T})} R}{(1-R)^{2}}\right\}, \quad \forall R \in(0,1) .
$$

Taking $R=R_{ \pm}$, we get $\left\{|z|<R_{-}\right\} \subset g(\underline{T},\{|z|<r\}) \subset\left\{|z|<R_{+}\right\}$. Then (4.3) follows immediately.

For $z_{1}, z_{2} \in(0, \pi)$, we write $P^{u}\left(z_{1}, z_{r} ; r\right)$ for $P\left(\pi+z_{1}, \pi, z_{2}, 0 ; r\right)$. By rotation symmetry, if $v_{1}-v_{2}=\pi$, then $P\left(w_{1}, v_{1}, w_{2}, v_{2} ; r\right)=P^{u}\left(w_{1}-v_{1}, w_{2}-v_{2} ; r\right)$.
Lemma 4.4. Let $\widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right), t \in(0, \infty), \underline{z}, \underline{z}^{*} \in(0, \pi)^{2}$, be the transition density given by Lemma 3.14. Let $r \in(0,1 / 4)$ and $t_{0} \in(0,-\log (4 r))$. Let $R_{+}, R_{-} \in(0,1)$ be such that $\frac{R_{ \pm}}{\left(1 \pm R_{ \pm}\right)^{2}}=e^{t_{0}} r$. Then for any $\underline{z} \in(0, \pi)^{2}$,

$$
\begin{equation*}
P^{u}(\underline{z} ; r) \lesseqgtr \int_{(0, \pi)^{2}} P^{u}\left(\underline{z}^{*}, R_{ \pm}\right) \widetilde{p}_{t_{0}}^{Z}\left(\underline{z}, \underline{z}^{*}\right) d \underline{z}^{*} . \tag{4.4}
\end{equation*}
$$

Proof. Fix $\underline{z}=\left(z_{1}, z_{2}\right) \in(0, \pi)^{2}$. Let $w_{1}=\pi+z_{1}, v_{1}=\pi, w_{2}=z_{2}, v_{2}=0$. Then $\mathbb{P}[E(r)]=$ $P^{u}(\underline{z}, r)$. Since $v_{1}-v_{2}=\pi$, we may define the curve $\underline{u}=\left(u_{1}, u_{2}\right)$ as in Section 3.3. If $\underline{u}\left(t_{0}\right) \in \mathcal{D}$, then $u_{j}\left(t_{0}\right) \leq \mathrm{m}\left(\underline{u}\left(t_{0}\right)\right)=t_{0}, j=1,2$. If $\underline{u}\left(t_{0}\right) \notin \mathcal{D}$, then $t_{0} \geq T^{u}$ and $\underline{u}\left(t_{0}\right)=\underline{u}\left(T^{u}\right)=$ $\lim _{t \uparrow T^{u}} \underline{u}(t) \leq T^{u} \leq t_{0}$ because for $0 \leq t<T^{u}$, we have $\underline{u}(t) \in \mathcal{D}$, and so $u_{j}(t) \leq t \leq T^{u}$, $j=1,2$. Thus, in any case we have $u_{j}\left(t_{0}\right) \leq t_{0}, j=1,2$.

Apply Lemma 4.3 to the $\mathcal{F}$-stopping time $\underline{u}\left(t_{0}\right)$. Since $m\left(\underline{u}\left(t_{0}\right)\right)=t_{0}$ when $\underline{u}\left(t_{0}\right) \in \mathcal{D}$, the $R_{ \pm}$here agree with the $R_{ \pm}$in Lemma 4.3. From $V_{1}^{u}\left(t_{0}\right)-V_{2}^{u}\left(t_{0}\right)=\pi$, we then get

$$
\mathbb{P}\left[E(r) \mid \mathcal{F}_{t_{0}}^{u}\right] \lesseqgtr \mathbf{1}_{\underline{u}\left(t_{0}\right) \in \mathcal{D}} P^{u}\left(Z_{1}^{u}\left(t_{0}\right), Z_{2}^{u}\left(t_{0}\right) ; R_{ \pm}\right) .
$$

By integration we get

$$
\begin{equation*}
P^{u}(\underline{z} ; r)=\mathbb{P}[E(r)] \lesseqgtr \mathbb{E}\left[\mathbf{1}_{\underline{u}}\left(t_{0}\right) \in \mathcal{D} P^{u}\left(\underline{Z}^{u}\left(t_{0}\right) ; R_{ \pm}\right)\right] . \tag{4.5}
\end{equation*}
$$

Since $\left(\widehat{w}_{1}, \widehat{w}_{2}\right)$ follows the law $\mathbb{P}_{c}^{c}, \widetilde{p}_{t}^{Z}\left(\underline{z}, \underline{z}^{*}\right)$ is the transition density of the process $\left(\underline{Z}^{u}(t)\right)$. So the density of $\underline{Z}^{u}\left(t_{0}\right)$ is $\widetilde{p}_{t_{0}}^{Z}(\underline{z}, \cdot)$, and the RHS of (4.5) agrees with the RHS of (4.4).

Let $\widetilde{p}_{\infty}^{Z}$ be given by (3.39). Define $\bar{P}(r)=\int_{(0, \pi)^{2}} P^{u}(\underline{z}, r) \widetilde{p}_{\infty}^{Z}(\underline{z}) d \underline{z}, r \in(0,1)$.
Lemma 4.5. We have $\bar{P}(r)=\widehat{c} r^{\alpha_{0}}(1+O(r))$ as $r \downarrow 0$, where $\widehat{c} \geq 0$ is a constant depending only on $\kappa$, and the implicit constants in $O(r)$ depend only on $\kappa$.

Proof. Let $r, t_{0}, R_{ \pm}$be as in Lemma 4.4. By integrating both sides of (4.4) against $\widetilde{p}_{\infty}^{Z}(\underline{z})$ and using (3.40), we get $\bar{P}(r) \lesseqgtr e^{-\alpha_{0} t_{0}} \bar{P}\left(R_{ \pm}\right)$. Let $Q(r)=r^{-\alpha_{0}} \bar{P}(r)$. Since $\frac{R_{ \pm}}{\left(1 \pm R_{ \pm}\right)^{2}}=e^{t_{0}} r$, we get

Q(r) \lesseqgtr\left(1 \pm R_{ \pm}\right)^{2 \alpha_{0}} Q\left(R_{ \pm}\right) . \tag{4.6}
\end{equation*}
$$

Let $R \in\left(0, \frac{1}{6}\right]$ and $r \in\left(0, \frac{R}{2}\right]$. Then $r<\frac{R}{(1+R)^{2}}<\frac{R}{(1-R)^{2}}<\frac{1}{4}$. So there are $t_{+}, t_{-} \in$ $(0,-\log (4 r))$ such that $\frac{R}{(1 \pm R)^{2}}=e^{t_{ \pm}} r$. By (4.6) (which does not contain $\left.t_{0}\right)$,

$$
\begin{equation*}
Q(r) \lesseqgtr(1 \pm R)^{2 \alpha_{0}} Q(R), \quad \text { if } 0<r \leq R / 2<R \leq 1 / 6 . \tag{4.7}
\end{equation*}
$$

Thus, for any $a \in\left(0, \frac{1}{12}\right]$ and $r_{1}, r_{2} \in(0, a]$, we have $(1+2 a)^{-2 \alpha_{0}} Q\left(r_{1}\right) \leq(1-2 a)^{-2 \alpha_{0}} Q\left(r_{2}\right)$. This implies that $\lim _{r \downarrow 0} Q(r)$ converges. Let the limit be denoted by $\widehat{c}$, which is nonnegative and depends only on $\kappa$. Letting $r \downarrow 0$ in (4.7), we get $Q(R) \gtreqless \widehat{c}(1 \pm R)^{-2 \alpha_{0}}$, if $R \leq 1 / 6$. This immediately implies the conclusion.

Recall the $\mathcal{Z}$ defined in (3.38). Let $C_{0}=\widehat{c \mathcal{Z}}$. Then $C_{0}$ is a nonnegative constant depending only on $\kappa$. We are now ready to prove that (4.1) holds for such $C_{0}$. First suppose $v_{1}-v_{2}=\pi$. Then $P\left(w_{1}, v_{1}, w_{2}, v_{2} ; r\right)=P^{u}\left(z_{1}, z_{2} ; r\right)$ and $\widetilde{G}\left(w_{1}, v_{1}, w_{2}, v_{2}\right)=\widetilde{G}^{u}\left(z_{1}, z_{2}\right)$, where $z_{j}=w_{j}-v_{j}$.

Recall that $\beta_{0}=1-\frac{8}{5 \kappa}$. Let $R=r^{\beta_{0}}$. When $r$ is small enough (depending on $\beta_{0}$ ), we may choose $t_{+}, t_{-} \in(0,-\log (4 r))$ such that $\frac{R}{(1 \pm R)^{2}}=e^{t_{ \pm} r}$. By (3.41) and Lemmas 4.4 and 4.5),

\begin{gathered}
P^{u}(\underline{z} ; r) \lesseqgtr \int_{(0, \pi)^{2}} P^{u}\left(\underline{z}^{*}, R\right) \widetilde{p}_{t_{ \pm}}^{Z}\left(\underline{z}, \underline{z}^{*}\right) d \underline{z}^{*}=\mathcal{Z} \widetilde{G}^{u}(\underline{z}) e^{-\alpha_{0} t_{ \pm}} \bar{P}(R)\left(1+O\left(e^{\left(1-\frac{5}{8} \kappa\right) t_{ \pm}}\right)\right) \\
=C_{0} \widetilde{G}^{u}(\underline{z}) e^{-\alpha_{0} t_{ \pm}} R^{\alpha_{0}}\left(1+O(R)+O\left(e^{\left(1-\frac{5}{8} \kappa\right) t_{ \pm}}\right)\right)=C_{0} \widetilde{G}^{u}(\underline{z}) r^{\alpha_{0}}\left(1+O(R)+O\left(e^{\left(1-\frac{5}{8} \kappa\right) t_{ \pm}}\right)\right) .
\end{gathered}
$$

Since $O(R)=O\left(e^{\left(1-\frac{5}{8} \kappa\right) t_{ \pm}}\right)=O\left(r^{\beta_{0}}\right)$, the above formula implies that

$$
\begin{equation*}
P^{u}(\underline{z} ; r)=C_{0} \widetilde{G}^{u}(\underline{z}) r^{\alpha_{0}}\left(1+O\left(r^{\beta_{0}}\right)\right), \quad \text { as } r \downarrow 0 \tag{4.8}
\end{equation*}
$$

So we have finished the proof of (4.1) in the case $v_{1}-v_{2}=\pi$.
Now suppose $\theta(\underline{0})=v_{1}-v_{2}<\pi$. By (3.22), $\theta$ is increasing in $t_{2}$. Let $\tau_{2}$ be the first $t_{2} \in\left(0, \widehat{T}_{2}\right)$ such that $\theta\left(0, \tau_{2}\right)=\pi$, if this time exists; otherwise let $\tau_{2}=\widehat{T}_{2}$. From (3.22) and that $\mathrm{m}(0, t)=t$, we see that $\cos (\theta(0, t) / 4) \leq e^{-t / 2} \cos (\theta(\underline{0}) / 4) \leq e^{-t / 2}, 0 \leq t<\widehat{T}_{2}$. Then for $0 \leq t<\tau_{2}, t \leq-2 \log \cos (\theta(0, t) / 4) \leq \log (2)$, which implies that $\tau_{2} \leq \log (2)$. Suppose $r \in(0,1 / 8)$. Then $\tau_{2} \leq-\log (4 r)$. Let $R_{ \pm} \in(0,1)$ be such that $\frac{R_{ \pm}}{\left(1 \pm R_{ \pm}\right)^{2}}=e^{\tau_{2}} r$. Then $R_{ \pm}=e^{\tau_{2}} r(1+O(r))$ as $r \downarrow 0$. We now apply Lemma 4.3 to $\underline{T}=\left(0, \tau_{2}\right)$. Since $\theta\left(0, \tau_{2}\right)=\pi$ when $\left(0, \tau_{2}\right) \in \mathcal{D}$, using (4.8), we get, as $r \downarrow 0$,

\begin{aligned}
& \mathbb{P}\left[E(r) \mid \mathcal{F}_{\left(0, \tau_{2}\right)}\right] \lesseqgtr \\
& \mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} P^{u}\left(\underline{Z}\left(0, \tau_{2}\right) ; R_{ \pm}\right)=\mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} P^{u}\left(\underline{Z}\left(0, \tau_{2}\right) ; e^{\tau_{2}} r(1+O(r))\right) \\
&=C_{0} \mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} e^{\alpha_{0} \tau_{2}} \widetilde{G}^{u}\left(\underline{Z}\left(0, \tau_{2}\right)\right) r^{\alpha_{0}}\left(1+O\left(r^{1-\frac{8}{5 k}}\right)\right),
\end{aligned}
$$

which together with (3.20) implies that

$$
\begin{aligned}
\mathbb{P}[E(r)] & =C_{0} r^{\alpha_{0}}\left(1+O\left(r^{1-\frac{8}{5 \kappa}}\right)\right) \mathbb{E}\left[\mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} e^{\alpha_{0} \mathrm{~m}\left(0, \tau_{2}\right)} \widetilde{G}^{u}\left(\underline{Z}\left(0, \tau_{2}\right)\right)\right] \\
& =C_{0} r^{\alpha_{0}}\left(1+O\left(r^{1-\frac{8}{5 \kappa}}\right)\right) \mathbb{E}\left[\mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} M_{* \rightarrow c}\left(0, \tau_{2}\right)^{-1}\right]
\end{aligned}
$$

Since $\mathbb{E}=\mathbb{E}_{c}^{c}$, by Lemmas 3.6 and 3.8,

$$
\mathbb{E}\left[\mathbf{1}_{\left\{\left(0, \tau_{2}\right) \in \mathcal{D}\right\}} M_{* \rightarrow c}\left(0, \tau_{2}\right)^{-1}\right]=M_{* \rightarrow c}(\underline{0})^{-1} \mathbb{P}_{*}^{c}[(0, \tau) \in \mathcal{D}]=M_{* \rightarrow c}(\underline{0})^{-1}=\widetilde{G}\left(w_{1}, v_{1}, w_{2}, v_{2}\right)
$$

The last two displayed formulas together imply that (4.1) holds in the case $v_{1}-v_{2}<\pi$.
The case that $v_{1}-v_{2}>\pi$ can be handled in a similar way. By (3.22), $\theta$ is decreasing in $t_{1}$. We may apply Lemma 4.3 to $\underline{T}=\left(\tau_{1}, 0\right)$, where $\tau_{1}$ is the first $t_{1} \in\left[0, \widehat{T}_{1}\right)$ such that $\theta\left(t_{1}, 0\right)=\pi$, if this time exists; and $\tau_{1}=\widehat{T_{1}}$ otherwise. Thus, (4.1) holds in all cases.

It remains to show that $C_{0}>0$. Suppose $C_{0}=0$. Then for any $z_{0} \in D$, we have $\mathbb{P}\left[E_{z_{0}}(r)\right]=$ 0 when $r>0$ is small enough, which implies that a.s. $\gamma_{1} \cup A_{1} \cup A_{2}$ does not have a cut point. However, since $\kappa \in(4,8), \gamma_{1}$ does have a cut point, and when this happens, one can always find $b_{1}$ and $b_{2}$ in some deterministic countable dense subset of $\partial D \backslash\left\{a_{1}, a_{2}\right\}$ such that $\gamma_{1} \cup A_{1} \cup A_{2}$ contains a cut point, where for $j=1,2, A_{j}$ is the connected component of $\partial \mathbb{D} \backslash\left\{b_{1}, b_{2}\right\}$ that
contains $a_{j}$. This implies that for some choice of $b_{1}, b_{2}$, the probability that $\gamma_{1} \cup A_{1} \cup A_{2}$ has a cut point is positive. The contradiction shows that $C_{0}>0$. The proof is now complete.

## Appendices

## A Domain Markov Property in Two Directions

Let $\kappa \in(0,8]$. In this appendix, we combine the reversibility of chordal SLE $_{\kappa}$ with the usual (one-directional) DMP to derive a two-directional DMP.

Let $D$ be a simply connected domain with locally connected boundary. Let $a_{1}, a_{2}$ be distinct prime ends of $D$. For $j=1,2$, let $\gamma_{j}$ be a chordal $\operatorname{SLE}_{\kappa}$ curve in $D$ from $a_{j}$ to $a_{3-j}$, parametrized by the capacity viewed from $a_{3-j}$, such that $\gamma_{1}$ and $\gamma_{2}$ are time-reversal of each other. Such $\gamma_{1}, \gamma_{2}$ exist by reversibility of $\operatorname{SLE}_{\kappa}$. Let $\phi_{2}$ be the decreasing auto-homeomorphism of $[0, \infty]$ such that $\gamma_{1} \circ \phi_{2}=\gamma_{2}$. For $j=1,2$ and $t \geq 0$, let $D_{t}^{j}$ be the connected component of $D \backslash \gamma_{j}[0, t]$, which shares the prime end $a_{3-j}$ with $D$. We may view $\gamma_{j}(t)$ as a prime end of $D_{t}^{j}$. For $j=1,2$, let $\mathcal{D}_{j}=\left\{\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}: \gamma_{j}\left(t_{j}\right) \notin \gamma_{3-j}\left[0, t_{3-j}\right]\right\}$ and $\mathcal{D}_{\cap}=\mathcal{D}_{1} \cap \mathcal{D}_{2}$. When $t_{1}<\phi_{2}\left(t_{2}\right)$, let $D_{\underline{t}}$ denote the connected component of $D \backslash \bigcup_{j=1,2} \gamma_{j}\left[0, t_{j}\right]$ whose closure contains $\gamma_{1}\left[t_{1}, \phi_{2}\left(t_{2}\right)\right]$. If $\underline{t} \in \mathcal{D}_{\cap}, D_{\underline{t}}$ shares the prime end $\gamma_{j}\left(t_{j}\right)$ with $D_{t_{j}}^{j}, j=1,2$. For $j=1,2$, let $\mathcal{G}^{j}$ be the $\mathbb{R}_{+}$-indexed filtration generated by $\gamma_{j}$. Let $\mathcal{G}$ be the separable $\mathbb{R}_{+}^{2}$-indexed filtration generated by $\mathcal{G}^{1}$ and $\mathcal{G}^{2}$, and $\overline{\mathcal{G}}$ be the right-continuous augmentation of $\mathcal{G}$. We are going to prove the following theorem, which has been used in Lemma 4.3.

Theorem A.1. If $\underline{T}=\left(T_{1}, T_{2}\right)$ is an $\overline{\mathcal{G}}$-stopping time, then conditionally on $\overline{\mathcal{G}}_{\underline{T}}$ and the event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\},\left.\gamma_{1}\right|_{\left[T_{1}, \phi_{2}\left(T_{2}\right)\right]}$ is a time-change of a chordal $S L E_{\kappa}$ curve from the prime end $\gamma_{1}\left(T_{1}\right)$ to the prime end $\gamma_{2}\left(T_{2}\right)$ in $D_{\underline{T}}$.

Remark A.2. A more specific statement of the theorem is the following. The event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$ is $\overline{\mathcal{G}}_{\underline{T}}$-measurable, and on this event, there are

- an $\overline{\mathcal{G}}_{\underline{T}}$-measurable conformal map $h_{\underline{T}}$ from $\mathbb{H}$ onto $D_{\underline{T}}$, which has continuation to $\overline{\mathbb{H}}^{\#}$, and sends 0 and $\infty$ respectively to the prime ends $\gamma_{1}\left(T_{1}\right)$ and $\gamma_{2}\left(T_{2}\right)$,
- a standard chordal SLE $_{\kappa}$ curve $\beta_{1}^{\underline{T}}$ conditionally independent of $\overline{\mathcal{G}}_{\underline{T}}$, and
- an increasing homeomorphism $u_{1}^{T}$ from $[0, \infty]$ onto $\left[T_{1}, \phi_{2}\left(T_{2}\right)\right]$,
such that $\gamma_{1} \circ u^{\frac{T}{1}}=h_{\underline{T}} \circ \beta^{\frac{T}{1}}$ a.s. on $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$.
The random curve $\beta_{1}^{T}$ is only defined on the event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$. By saying that $\beta_{1}^{T}$ is a standard chordal $\operatorname{SLE}_{\kappa}$ curve conditionally independent of $\overline{\mathcal{G}}_{\underline{T}}$, we mean that under the new probability measure $\mathbb{P}\left[\cdot \mid\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}\right]$, where $\mathbb{P}$ is the original underlying probability measure, $\beta^{\underline{T}}$ has the law of a standard chordal $\mathrm{SLE}_{\kappa}$ curve and is independent of $\overline{\mathcal{G}}_{\underline{T}}$.

Remark A.3. In the statement of the theorem, we condition on the $\sigma$-algebra $\overline{\mathcal{G}}_{\underline{T}}$ and an event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$, which is $\overline{\mathcal{G}}_{\underline{T}}$-measurable. The bigger the event, the stronger the statement is. For the application of Theorem A.1 in Lemma 4.3, we only need a weaker result, in which $\mathcal{D}_{\cap}$ is replaced by $\mathcal{D}_{0}=\left\{\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}: \gamma_{1}\left[0, t_{1}\right] \cap \gamma_{2}\left[0, t_{2}\right]=\emptyset\right\}$, which is a proper subset of $\mathcal{D}_{\cap}$ in the case $\kappa \in(4,8]$. The strongest possible form of the theorem for $\kappa \in(4,8)$ is when $\mathcal{D}_{\cap}$ is replaced by the bigger set $\left\{\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}: t_{1}<\phi_{2}\left(t_{2}\right)\right\}$. In that case, the statement has to be modified since $D_{\underline{T}}$ may not share the prime end $\gamma_{j}\left(T_{j}\right)$ with $D_{T_{j}}^{j}$, and so we may not view $\gamma_{j}\left(T_{j}\right)$ as a prime end of $D_{\underline{\underline{T}}}$. The proof of such a strong statement remains open to the author.

Remark A.4. Theorem A. 1 is intuitively correct, but still requires a proof, which we could not find in the literature. We make a complete (nontrivial) proof of the theorem here because it is a solid step in the development of the multi-time-parameter framework.

The essential property of the chordal $\mathrm{SLE}_{\kappa}$ curve for $\kappa \in(0,8)$ used in the proof is the fact that such a curve commutes with its time reversal, which is also a chordal SLE $_{\kappa}$ curve. Thus, the argument can be easily extended to any commuting pair of SLE-type curves. Taking the $\eta_{1}$ and $\eta_{2}$ in Proposition 3.1 for example, we have the following result. Let $\mathcal{D}$ be as defined in Section [3.1. Let $\mathcal{F}^{j}$ be the $\mathbb{R}_{+}$-indexed filtration generated by $\eta_{j}, j=1,2$, and let $\overline{\mathcal{F}}$ be the right-continuous augmentation of the separable $\mathbb{R}_{+}^{2}$-indexed filtration generated by $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$. Then for any $\overline{\mathcal{F}}$-stopping time $\underline{T}=\left(T_{1}, T_{2}\right)$, conditionally on $\overline{\mathcal{F}}_{\underline{T}}$ and $\{\underline{T} \in \mathcal{D}\}$, for $j=1,2$, the $g(\underline{T}, \cdot)$-images of $\eta_{j}\left(T_{j}+\cdot\right)$ is a time-change of a radial $\operatorname{SLE}_{\kappa}(2, \underline{\rho})$ curve in $\mathbb{D}$ started from $e^{i W_{j}(\underline{T})}$ aimed at 0 with force points $e^{i W_{3-j}(\underline{T})}, e^{i V_{1}(\underline{T})}, \ldots, e^{i V_{m}(\underline{T})}$. In addition, the two new curves $\widehat{\eta}_{1}$ and $\widehat{\eta}_{2}$ commute in the same way as in $\eta_{1}$ and $\eta_{2}$ do. A similar result has been used in [19, Lemma 4.1].

We now give a sketch of the proof. Recall that the one-directional DMP follows from the strong Markov property of Brownian motion and the definition of chordal Loewner equation. The standard way to prove the strong Markov property of Brownian motion at an arbitrary stopping time $T$ is to approximate $T$ by a decreasing sequence of stopping times $\left(T_{n}\right)$ taking countably many values and apply the Markov property of Brownian motion at deterministic times to prove that the strong Markov property holds for each $T_{n}$.

To prove Theorem A.1, we could also approximate $\underline{T}$ using a decreasing sequence of stopping times $\left(\underline{T}^{n}\right)$ such that each $\underline{T}^{n}$ takes countably many values. Using the one-directional DMP and reversibility of chordal $\mathrm{SLE}_{\kappa}$, it is easy to prove that the theorem holds for a deterministic times $\underline{t}=\left(t_{1}, t_{2}\right)$, which means that, conditionally on $\overline{\mathcal{G}}_{\underline{t}}$ and the event $\left\{\underline{t} \in \mathcal{D}_{\cap}\right\},\left.\gamma_{1}\right|_{\left[t_{1}, \phi_{2}\left(t_{2}\right)\right]}$ is a time-change of a chordal SLE $_{\kappa}$ curve from $\gamma_{1}\left(t_{1}\right)$ to $\gamma_{2}\left(t_{2}\right)$ in the domain $D_{\underline{t}}$. Since each $\underline{T}^{n}$ takes countably many values, the statement also holds for $\underline{T}^{n}$.

Extending the results from $\underline{T}^{n}$ to $\underline{T}$ takes significant amount of work. We observe that, for each $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}_{\cap}$, there exists at least one conformal map from $\mathbb{H}$ onto $D_{\underline{t}}$, which sends 0 and $\infty$ respectively to the prime ends $\gamma_{1}\left(t_{1}\right)$ and $\gamma_{2}\left(t_{2}\right)$, but such conformal maps are not unique. We will prove Lemma A.13, which says that we may choose the conformal maps $f_{\underline{t}}^{1}, \underline{t} \in \mathcal{D}_{\cap}$, such that $f_{\underline{t}}^{1}(z)$ is jointly continuous in $\underline{t}$ and $z$. The continuity fact implies that $f_{\underline{T}}^{1}=\lim _{n \rightarrow \infty} f_{\underline{T}^{n}}^{1}$ is $\overline{\mathcal{G}}_{\underline{T^{\prime}}}-$ measurable.

Fix $\underline{t} \in \mathcal{D}_{\cap}$. By DMP and reversibility of chordal SLE $_{\kappa}$, there is a random Loewner curve $\eta_{\underline{t}}$ in $\mathbb{H}$, which is a time-change of a standard SLE $_{\kappa}$ such that $f_{\underline{\underline{t}}}^{1} \circ \eta_{\underline{t}}=\left.\eta_{1}\right|_{\left[t_{1}, \phi_{2}\left(t_{2}\right)\right]}$. Suppose $\eta_{\underline{t}}$ is driven by $\widehat{w}_{\underline{t}}$ with speed $u_{\underline{\underline{t}}}$. Let $\widehat{v}_{\underline{\underline{t}}}=\widehat{w}_{\underline{t}} \circ u_{\underline{t}}^{-1}$. Then $\left(\widehat{v}_{\underline{\underline{t}}}\right) \underline{\text { has }}$ the law of $\left(\sqrt{\kappa} B_{t}\right)$. Since $\underline{T}^{n}$ takes countably many values, $\left(\widehat{v}_{\underline{T}^{n}}(t)\right)$ also has the law of $\left(\sqrt{\kappa} B_{t}\right)$. We will prove Lemma A.12, which will imply that $\widehat{w}_{\underline{t}}(t)$ and $u_{\underline{t}}(t)$ both have versions that are jointly continuous in $\underline{t}$ and $t$, and so the same is true for $\widehat{v}_{\underline{t}}(t)$, which then implies that $\widehat{v}_{\underline{T}}(t)=\lim _{n \rightarrow \infty} \widehat{v}_{\underline{T}^{n}}(t)$ has the law of $\left(\sqrt{\kappa} B_{t}\right)$. This fact shows that $\eta_{\underline{T}}(t)$ is a time-change of a standard SLE $\bar{\kappa}$. Since $f_{\underline{t}}^{1} \circ \eta_{\underline{t}}=\left.\eta_{1}\right|_{\left[t_{1}, \phi_{2}\left(t_{2}\right)\right]}$ and $f_{\underline{T}}^{1}$ is $\overline{\mathcal{G}}_{\underline{T}}$-measurable, we arrive at the conclusion.

The proofs of Lemmas A. 12 and A. 13 use the Carathéodory topology for the convergence of domains developed in [25, Sections 5.1-5.2], whose definition and basic properties will be recalled in Definition A. 6 and Propositions A. 7 and A.9. We will further develop this topology to include one prime end and derive some of its properties in Lemma A. 10 .

The above description of the proof gives the basic idea but is very sketchy and not precise. Here are some examples. We will not go directly from $\underline{T}^{n}$ to $\underline{T}$. Instead, we will first approximate $\underline{T}=\left(T_{1}, T_{2}\right)$ using $\left(T_{1}^{n}, T_{2}\right)$, where $T_{1}^{n}$ takes countably many values (but ( $T_{1}^{n}, T_{2}$ ) does not), and then approximate each ( $T_{1}^{n}, T_{2}$ ) using stopping times taking countably many values. Lemma A. 12 will appear before Lemma A. 13 and be used in the proof of the latter lemma. The precise statement about the law of $\left(\widehat{v}_{\underline{T}^{n}}(t)\right)$ should be: conditionally on $\overline{\mathcal{G}}_{\underline{T}^{n}}$ and the event $\left\{\underline{T}^{n} \in \mathcal{D}_{\cap}\right\}$, $\left(\widehat{v}_{\underline{T}^{n}}(t)\right)$ has the law of $\left(\sqrt{\kappa} B_{t}\right)$.

Two groups of intertwined factors contribute to the significant length of the proof of Theorem A.1. The factors on the Probability side is the treatment of two-time-variable filtration, stopping times and stochastic processes; the factors on the Complex Analysis side is the argument involving Loewner's equation, prime ends, Carathéodory topology and extremal length. In addition, we have to deal with the annoying random time-changes and the fact that many random elements are not defined on the whole probability space.

Now we start the proof of Theorem A.1. By conformal invariance, it suffices to work on standard chordal SLE $_{\kappa}$ curves. Let $J(z)=-1 / z$. By reversibility of chordal SLE $_{\kappa}$, there are two standard chordal SLE $_{\kappa}$ curves $\eta_{1}$ and $\eta_{2}$, and a decreasing auto-homeomorphism $\phi_{2}$ of $[0, \infty]$ such that $\eta_{1} \circ \phi_{2}=J \circ \eta_{2}$. For $j=1,2$, let $\widehat{w}_{j}$ be the chordal Loewner driving function for $\eta_{j}, K_{t}^{j}, 0 \leq t<\infty$, be the chordal Loewner hulls driven by $\widehat{w}_{j}, \eta_{j}^{J}=J \circ \eta_{j}$, and $K_{t}^{j, J}=J\left(K_{t}^{j}\right)$. We also view $\eta_{j}(t)$ and $\eta_{j}^{J}(t)$ as prime ends of $\mathbb{H} \backslash K_{t}^{j}$ and $\mathbb{H} \backslash K_{t}^{j, J}$, respectively. For $j=1,2$, let $\mathcal{F}^{j}$ be the filtration generated by $\widehat{w}_{j}$. Let $\mathcal{F}$ be the separable $\mathbb{R}_{+}^{2}$-indexed filtration generated by $\mathcal{F}^{1}$ and $\mathcal{F}^{2}$, and $\overline{\mathcal{F}}$ be the right-continuous augmentation of $\mathcal{F}$. Let $\mathcal{D}_{j}=\left\{\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}: \eta_{j}^{J}\left(t_{j}\right) \notin \eta_{3-j}\left[0, t_{3-j}\right]\right\}, j=1,2$, and $\mathcal{D}_{\cap}=\mathcal{D}_{1} \cap \mathcal{D}_{2}$. For $\underline{t} \in \mathcal{D}_{\cap}$, there is a unique connected component of $\mathbb{H} \backslash\left(\eta_{1}\left[0, t_{1}\right] \cup \eta_{2}^{J}\left[0, t_{2}\right]\right)$, which shares the prime end $\eta_{1}\left(t_{1}\right)$ with $\mathbb{H} \backslash K_{t_{1}}^{1}$ and the prime end $\eta_{2}^{J}\left(t_{2}\right)$ with $\mathbb{H} \backslash K_{t_{2}}^{2, J}$. Let this component be denoted by $H_{\underline{\underline{t}}}^{1}$. Theorem A. 1 is equivalent to the following theorem.
Lemma A.5. Let $\underline{T}=\left(T_{1}, T_{2}\right)$ be an $\overline{\mathcal{F}}$-stopping time. Then the event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\} \in \overline{\mathcal{F}}_{\underline{T}}$, and on this event there are

- an $\mathcal{F}_{\underline{T}}$-measurable random conformal map $f_{\underline{T}}$ from $\mathbb{H}$ onto $H_{\underline{T}}^{1}$, which sends 0 and $\infty$ to
the prime ends $\eta_{1}\left(T_{1}\right)$ and $\eta_{2}^{J}\left(T_{2}\right)$, respectively,
- a standard chordal $S L E_{\kappa}$ curve $\zeta_{1}^{\underline{T}}$ conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$, and
- an increasing homeomorphism $u_{1}^{\frac{T}{1}}$ from $[0, \infty]$ onto $\left[T_{1}, \phi_{2}\left(T_{2}\right)\right]$,
such that $\eta_{1} \circ u_{1}^{\frac{T}{1}}=f_{\underline{T}} \circ \zeta_{1}^{\frac{T}{1}}$ a.s. on $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$.
The rest of the appendix is devoted to the proof of Lemma A.5. We first review some revised Carathéodory topology introduced in [25], which is similar to but different from the Carathéodory kernel convergence in [13, Section 1.4].

Definition A.6. Let $\left(D_{n}\right)_{n \in \mathbb{N}}$ and $D$ be domains in $\mathbb{C}$. We say that $\left(D_{n}\right)$ converges to $D$ in the Carathéodory topology, and write $D_{n} \xrightarrow{\text { Cara }} D$, if
(i) for every compact set $K \subset D$, there exists $n_{0} \in \mathbb{N}$ such that $K \subset D_{n}$ if $n \geq n_{0}$;
(ii) for every $z_{0} \in \partial D$ there exists $z_{n} \in \partial D_{n}$ for each $n$ such that $z_{n} \rightarrow z_{0}$.

Let $\left(D_{n}\right)$ and $D$ be as in the definition. Suppose $f_{n}: D_{n} \rightarrow \mathbb{C}$ and $f: D \rightarrow \mathbb{C}$. By $f_{n} \xrightarrow{\text { l.u. }} f$ in $D$ we mean that $f_{n}$ converges to $f$ locally uniformly in $D$, i.e., uniformly on every compact subset of $D$. The following is [25, Lemma 5.1].

Proposition A.7. Let $D_{n}, n \in \mathbb{N}$, and $D$ be domains in $\mathbb{C}$ such that $D_{n} \xrightarrow{\text { Cara }} D$. Let $f_{n}$ : $D_{n} \xrightarrow{\text { Conf }} E_{n}$ for some domain $E_{n} \subset \mathbb{C}, n \in \mathbb{N}$. Suppose $f_{n} \xrightarrow{\text { l.u. }} f$ in $D$ for some nonconstant $f: D \rightarrow \mathbb{C}$. Then $f$ is a conformal map, $E_{n} \xrightarrow{\text { Cara }} E:=f(D)$, and $f_{n}^{-1} \xrightarrow{\text { l.u. }} f^{-1}$ in $E$.

The following proposition is well known (cf. [19, Proposition 2.3]).
Proposition A.8. If $K$ is an $\mathbb{H}$-hull with $K \subset\left\{\left|z-x_{0}\right| \leq r\right\}$ for some $x_{0} \in \mathbb{R}$ and $r>0$, then $\left|g_{K}(z)-z\right| \leq 3 r$ for any $z \in \mathbb{C} \backslash K^{\text {doub }}$.

For a nonempty $\mathbb{H}$-hull $K$, we write $a_{K}=\min (\bar{K} \cap \mathbb{R}), b_{K}=\max (\bar{K} \cap \mathbb{R}), B_{K}=\left[a_{K}, b_{K}\right]$, and $K^{\text {doub }}=K \cup\{\bar{z}: z \in K\} \cup B_{K}$. For $K \subset L \in \mathcal{H}$ with $L \neq \emptyset$, by Schwarz reflection principle, $g_{K}$ extends to a conformal map from $\mathbb{C} \backslash\left(K^{\text {doub }} \cup B_{L}\right)$ conformally onto $\mathbb{C} \backslash S_{K}^{L}$ for some compact interval $S_{K}^{L}$. We write $S_{K}$ for $S_{K}^{K}$. Let $c_{K}^{L}<d_{K}^{L}$ and $c_{K}<d_{K}$ be such that $S_{K}^{L}=\left[c_{K}^{L}, d_{K}^{L}\right]$ and $S_{K}=\left[c_{K}, d_{K}\right]$. Then $g_{K}$ maps $\left(-\infty, a_{K}\right)$ and $\left(b_{K}, \infty\right)$ respectively onto $\left(-\infty, c_{K}\right)$ and $\left(d_{K}, \infty\right)$, and satisfies that

$$
\begin{equation*}
g_{K}(x)<x, \quad \forall x \in\left(-\infty, a_{K}\right) ; \quad g_{K}(x)>x, \quad \forall x \in\left(b_{K}, \infty\right) . \tag{A.1}
\end{equation*}
$$

Let $f_{K}=g_{K}^{-1}$. Then $f_{K}: \mathbb{H} \xrightarrow{\text { Conf }} \mathbb{H} \backslash K$ and $f_{K}: \mathbb{C} \backslash S_{K} \xrightarrow{\text { Conf }} \mathbb{C} \backslash K^{\text {doub }}$.
Let $\mathcal{H}$ denote the space of $\mathbb{H}$-hulls. There is a metric $d_{\mathcal{H}}$ on $\mathcal{H}$ such that $K_{n} \rightarrow K$ w.r.t. $d_{\mathcal{H}}$ iff $f_{K_{n}} \xrightarrow{\text { l.u. }} f_{K}$ in $\mathbb{H}$. By Proposition A.7, this implies that $\mathbb{H} \backslash K_{n} \xrightarrow{\text { Cara }} \mathbb{H} \backslash K$. But the converse is not true. For $K \in \mathcal{H}$, let $\mathcal{H}(K)=\{L \in \mathcal{H}: L \subset K\}$. The following is [25, Lemma 5.4 (i)].

Proposition A.9. For any $K \in \mathcal{H}$ with $K \neq \emptyset, \mathcal{H}(K)$ is compact w.r.t. $d_{\mathcal{H}}$. This means that every sequence $\left(K_{n}\right)$ in $\mathcal{H}(K)$ contains a convergent subsequence w.r.t. $d_{\mathcal{H}}$ with limit in $\mathcal{H}(K)$. Moreover, if $K_{n} \rightarrow K_{0}$ in $\mathcal{H}(K)$, then $f_{K_{n}} \xrightarrow{\text { l.u. }} f_{K_{0}}$ in $\mathbb{C} \backslash S_{K}, \mathbb{C} \backslash\left(K_{n}^{\text {doub }} \cup B_{K}\right) \xrightarrow{\text { Cara }}$ $\mathbb{C} \backslash\left(K_{0}^{\text {doub }} \cup B_{K}\right)$, and $g_{K_{n}} \xrightarrow{\text { l.u. }} g_{K_{0}}$ in $\mathbb{C} \backslash\left(K_{0}^{\text {doub }} \cup B_{K}\right)$.

Let $\mathcal{P}$ denote the space of pairs $(K, p)$, where $K$ is an $\mathbb{H}$-hull, and $p$ is a prime end of $\mathbb{H} \backslash K$ other than $\infty$. Note that $g_{K}(p) \in \mathbb{R}$ for $(K, p) \in \mathcal{P}$. Equip $\mathcal{P}$ with the metric

$$
d_{\mathcal{P}}\left(\left(K_{1}, p_{1}\right),\left(K_{2}, p_{2}\right)\right)=d_{\mathcal{H}}\left(K_{1}, K_{2}\right)+\left|g_{K_{1}}\left(p_{1}\right)-g_{K_{2}}\left(p_{2}\right)\right| .
$$

For $(K, p) \in \mathcal{P}$, let $g_{K, p}=g_{K}-g_{K}(p)$ and $f_{K, p}=g_{K, p}^{-1}$. If $\left(K_{n}, p_{n}\right) \rightarrow(K, p)$ w.r.t. $d_{\mathcal{P}}$, then $g_{K_{n}, p_{n}} \xrightarrow{\text { l.u. }} g_{K, p}$ in $\mathbb{H} \backslash K$ and $f_{K_{n}, p_{n}} \xrightarrow{\text { l.u. }} f_{K, p}$ in $\mathbb{H}$. For a nonempty $\mathbb{H}$-hull $L$, let $\mathcal{P}(L)$ denote the set of $(K, p) \in \mathcal{P}$ such that $K \in \mathcal{H}(L)$, and $p \notin\left(-\infty, a_{L}\right) \cup\left(b_{L}, \infty\right)$. Then $g_{K}(p) \in S_{K}^{L}$. Let $S_{K, p}^{L}=S_{K}^{L}-g_{K}(p)$. Then $0 \in S_{K, p}^{L}$ and $g_{K, p}: \mathbb{C} \backslash\left(K^{\text {doub }} \cup B_{L}\right) \xrightarrow{\text { Conf }} \mathbb{C} \backslash S_{K, p}^{L}$.

The following example is important. Suppose $K_{t}, 0 \leq t<T$, are chordal Loewner hulls driven by $\widehat{w}$. For $0 \leq t<T$, let $p_{t}$ be the prime end $g_{K_{t}}^{-1}(\widehat{w}(t))$ of $\mathbb{H} \backslash K_{t}$. Then $\left(K_{t}, p_{t}\right)$, $0 \leq t<T$, is a continuous curve in $\mathcal{P}$. The corresponding maps $g_{K_{t}, p_{t}}$ and $f_{K_{t}, p_{t}}$ are called centered Loewner maps in the literature.

Let $\Xi$ denote the set of pairs $\left(L^{1}, L^{2}\right) \in \mathcal{H}^{2}$ such that $L^{j}$ contains a neighborhood of 0 in $\mathbb{H}, j=1,2$, and $\operatorname{dist}\left(\left(L^{1}\right)^{\text {doub }}, J\left(\left(L^{2}\right)^{\text {doub }}\right)\right)>0$. For each $\underline{L}=\left(L^{1}, L^{2}\right) \in \Xi$, let $\mathcal{P} \mathcal{P}(\underline{L})=$ $\mathcal{P}\left(L^{1}\right) \times \mathcal{P}\left(L^{2}\right)$. Let $\mathcal{P} \mathcal{P}=\bigcup_{\underline{L} \in \Xi} \mathcal{P} \mathcal{P}(\underline{L})$. Suppose $\left(K_{1}, p_{1} ; K_{2}, p_{2}\right) \in \mathcal{P} \mathcal{P}$. Define $H_{K_{1} ; K_{2}}^{1}=$ $\mathbb{H} \backslash\left(K_{1} \cup J\left(K_{2}\right)\right)$. Then $H_{K_{1} ; K_{2}}^{1}$ is simply connected and shares the prime ends $p_{1}$ and $J\left(p_{2}\right)$ respectively with $\mathbb{H} \backslash K_{1}$ and $\mathbb{H} \backslash J\left(K_{2}\right)$. Let $g_{K_{2}, p_{2}}^{J}=J \circ g_{K_{2}, p_{2}} \circ J$ and $f_{K_{2}, p_{2}}^{J}=\left(g_{K_{2}, p_{2}}^{J}\right)^{-1}$. Let $\widetilde{K}_{1}, \widetilde{p}_{1}$ be respectively the $g_{K_{2}, p_{2}}^{J}$-images of $K_{1}, p_{1}$. Since $g_{K_{2}, p_{2}}^{J}: H_{K_{1} ; K_{2}}^{1} \xrightarrow{\text { Conf }} \mathbb{H} \backslash \widetilde{K}_{1}$, we see that $\mathbb{H} \backslash \widetilde{K}_{1}$ is also simply connected. Since $J\left(p_{2}\right)$ is a prime end of $H_{K_{1}, K_{2}}^{1}$ bounded away from $K_{1}$, and is sent to $\infty$ by $g_{K_{2}, p_{2}}^{J}$, we see that $\mathbb{H} \backslash \widetilde{K}_{1}$ shares the prime end $\infty$ with $\mathbb{H}$. Thus, $\widetilde{K}_{1} \in \mathcal{H}$. Since $p_{1}$ and $J\left(p_{2}\right)$ are distinct prime ends of $\mathbb{H}_{K_{1}, K_{2}}$, we have $\widetilde{p}_{1}=g_{K_{2}, p_{2}}^{J}\left(p_{1}\right) \neq g_{K_{2}, p_{2}}^{J}\left(J\left(p_{2}\right)\right)=\infty$ in terms of prime ends. So $\left(\widetilde{K}_{1}, \widetilde{p}_{1}\right) \in \mathcal{P}$.

Lemma A.10. Let $\left(L^{1}, L^{2}\right) \in \Xi$. For $j=1,2$, let $\left(K_{n}^{j}, p_{n}^{j}\right), n \in \mathbb{N}$, be a convergent sequence in $\mathcal{P}\left(L^{j}\right)$ with limit $\left(K_{\infty}^{j}, p_{\infty}^{j}\right) \in \mathcal{P}\left(L_{j}\right)$. For $n \in \overline{\mathbb{N}}:=\mathbb{N} \cup\{\infty\}$, let $\widetilde{K}_{n}^{1}, \widetilde{p}_{n}^{1}$ be respectively the $g_{K_{n}^{2}, p_{n}^{2}}^{J}$-images of $K_{n}^{1}, p_{n}^{1}$. Then $\left(\widetilde{K}_{n}^{1}, \widetilde{p}_{n}^{1}\right) \rightarrow\left(\widetilde{K}_{\infty}^{1}, \widetilde{p}_{\infty}^{1}\right)$ w.r.t. $d_{\mathcal{P}}, g_{\widetilde{K}_{n}^{1}} \xrightarrow{\text { l.u. }} g_{\widetilde{K}_{\infty}^{1}}$ in $\mathbb{C} \backslash\left(\left(\widetilde{K}_{\infty}^{1}\right)^{\text {doub }} \cup\right.$ $g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)$, and $g_{\widetilde{K}_{n}^{1}}^{-1} \xrightarrow{\text { l.u. }} g_{\widetilde{K}_{\infty}^{1}}^{-1}$ in $\mathbb{C} \backslash\left(S_{\widetilde{K}_{\infty}^{1}} \cup g_{\widetilde{K}_{\infty}^{1}} \circ g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)$.
Proof. From $K_{n}^{j} \rightarrow K_{\infty}^{j}, j=1,2$, we know that $H_{K_{n}^{1} ; K_{n}^{2}}^{1} \xrightarrow{\text { Cara }} H_{K_{\infty}^{1} ; K_{\infty}^{2}}^{1}$. Since $g_{K_{n}^{2}, p_{n}^{2}}^{J} \xrightarrow{\text { l.u. }} g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}$ in $H_{K_{\infty}^{1}, K_{\infty}^{2}}^{1}$, by Proposition A.7, $\mathbb{H} \backslash \widetilde{K}_{n}^{1} \xrightarrow{\text { Cara }} \mathbb{H} \backslash \widetilde{K}_{\infty}^{1}$. Let $\Lambda=\Lambda\left(L^{1}, L^{2}\right) \in(0, \infty)$ be the extremal distance (cf. [1) between $\left(L^{2}\right)^{\text {doub }}$ and $J\left(\left(L^{1}\right)^{\text {doub }}\right)$. By comparison principle, for any $n \in \mathbb{N}$, the extremal distance between $\left(K_{n}^{2}\right)^{\text {doub }} \cup B_{L^{2}}$ and $J\left(\left(K_{n}^{1}\right)^{\text {doub }} \cup B_{L^{1}}\right)$ is at least $\Lambda$. By conformal invariance, the extremal distance between $S_{K_{n}^{2}, p_{n}^{2}}^{L^{2}}$ and $g_{K_{n}^{2}, p_{n}^{2}} \circ J\left(\left(K_{n}^{1}\right)^{\text {doub }}\right)$ is at least
$\Lambda$. Since $S_{K_{n}^{2}, p_{n}^{2}}^{L_{n}^{2}}$ contains 0 and has length $\geq b_{L^{2}}-a_{L^{2}}>0$ by (A.1), there is $r=r\left(L^{1}, L^{2}\right)>0$ such that $\operatorname{dist}\left(0, g_{K_{n}^{2}, p_{n}^{2}} \circ J\left(K_{n}^{1}\right)\right) \geq r$, which implies that $\widetilde{K}_{n}^{1} \subset\{|z| \leq 1 / r\}$. By Proposition A.9, $\left\{\widetilde{K}_{n}^{1}\right\}$ is pre-compact. Since $\mathbb{H} \backslash \widetilde{K}_{n}^{1} \xrightarrow{\text { Cara }} \mathbb{H} \backslash \widetilde{K}_{\infty}^{1}$, we get $\widetilde{K}_{n}^{1} \rightarrow \widetilde{K}_{\infty}^{1}$ w.r.t. $d_{\mathcal{H}}$.

For each $n \in \overline{\mathbb{N}}, g_{n}:=g_{\widetilde{K}_{n}^{1}} \circ g_{K_{n}^{2}, p_{n}^{2}}^{J} \circ f_{K_{n}^{1}}$ is a conformal map from $\mathbb{C} \backslash\left(S_{K_{n}^{1}} \cup g_{K_{n}^{1}} \circ J\left(\left(K_{n}^{2}\right)^{\text {doub }}\right)\right)$ onto $\mathbb{C} \backslash\left(S_{\widetilde{K}_{n}^{1}} \cup g_{\widetilde{K}_{n}^{1}} \circ J\left(S_{K_{n}^{2}}^{n}\right)\right)$, and maps a neighborhood of $S_{K_{n}^{1}}$ to a neighborhood of $S_{\widetilde{K}_{n}^{1}}$. By Schwarz reflection principle, it extends to a conformal map on $\mathbb{C} \backslash g_{K_{n}^{1}} \circ J\left(\left(K_{n}^{2}\right)^{\text {doub }}\right)$, and maps $S_{K_{n}^{1}}$ onto $S_{\widetilde{K}_{n}^{1}}$. From $K_{n}^{1} \rightarrow K_{\infty}^{1}, \widetilde{K}_{n}^{1} \rightarrow \widetilde{K}_{\infty}^{1}$ and $\left(K_{n}^{2}, p_{n}^{2}\right) \rightarrow\left(K_{\infty}^{2}, p_{\infty}^{2}\right)$, we know that $g_{n} \xrightarrow{\text { l.u. }} g_{0}$ in $\mathbb{C} \backslash\left(S_{K_{\infty}^{1}}^{L_{1}} \cup g_{K_{\infty}^{1}} \circ J\left(\left(K_{\infty}^{2}\right)^{\text {doub }}\right)\right)$. By maximum principle, we get $g_{n} \xrightarrow{\text { l.u. }} g_{0}$ in $\mathbb{C} \backslash g_{K_{\infty}^{1}} \circ J\left(\left(K_{\infty}^{2}\right)^{\text {doub }}\right)$. Since $g_{\widetilde{K}_{n}^{1}}\left(\widetilde{p}_{n}^{1}\right)=g_{n} \circ g_{K_{n}^{1}}\left(p_{n}^{1}\right)$ for $n \in \overline{\mathbb{N}}$, and $g_{K_{n}^{1}}\left(p_{n}^{1}\right) \rightarrow g_{K_{\infty}^{1}}\left(p_{\infty}^{1}\right) \in$ $\mathbb{C} \backslash g_{K_{\infty}^{1}} \circ J\left(\left(K_{\infty}^{2}\right)^{\text {doub }}\right)$, we get $\left.g_{\widetilde{K}_{n}^{1}} \widetilde{p}_{n}^{1}\right) \rightarrow g_{\widetilde{K}_{\infty}^{1}}\left(\widetilde{p}_{\infty}^{1}\right)$. Thus, $\left(\widetilde{K}_{n}^{1}, \widetilde{p}_{n}^{1}\right) \rightarrow\left(\widetilde{K}_{\infty}^{1}, \widetilde{p}_{\infty}^{1}\right)$.

Since $K_{n}^{1} \rightarrow K_{\infty}^{1}$ in $\mathcal{H}\left(L^{1}\right)$, we get $\mathbb{C} \backslash\left(\left(K_{n}^{1}\right)^{\text {doub }} \cup B_{L^{1}}\right) \xrightarrow{\text { Cara }} \mathbb{C} \backslash\left(\left(K_{\infty}^{1}\right)^{\text {doub }} \cup B_{L^{1}}\right)$. By Proposition A.7, we get $\mathbb{C} \backslash\left(\left(\widetilde{K}_{n}^{1}\right)^{\text {doub }} \cup g_{K_{n}^{2}, p_{n}^{2}}^{J}\left(B_{L^{2}}\right)\right) \xrightarrow{\text { Cara }} \mathbb{C} \backslash\left(\left(\widetilde{K}_{\infty}^{1}\right)^{\text {doub }} \cup g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)$. From the first paragraph of the proof, there is $R \in(0, \infty)$ such that $\widetilde{K}_{n}^{1} \subset\{|z|<R\}$ for all $n \in \overline{\mathbb{N}}$. By Proposition A.8, $\left|g_{\widetilde{K}_{n}^{1}}(z)-z\right| \leq 3 R$ for all $n \in \overline{\mathbb{N}}$ and $z \in \mathbb{C} \backslash\left(\widetilde{K}_{n}^{1}\right)^{\text {doub }}$. Thus, any subsequence of $\left\{g_{\widetilde{K}_{n}^{1}}\right\}$ contains a further subsequence, which converges locally uniformly in $\mathbb{C} \backslash\left(\left(\widetilde{K}_{\infty}^{1}\right)^{\text {doub }} \cup g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)$. The limit must be $g_{\widetilde{K}_{\infty}^{1}}$ since we already know that $g_{\widetilde{K}_{n}^{1}} \xrightarrow{\text { l.u. }} g_{\widetilde{K}_{\infty}^{1}}$ in $\mathbb{H} \backslash \widetilde{K}_{\infty}^{1}$. So we get $g_{\widetilde{K}_{n}^{1}} \xrightarrow{\text { l.u. }} g_{\widetilde{K}_{\infty}^{1}}$ in $\mathbb{C} \backslash\left(\left(\widetilde{K}_{\infty}^{1}\right)^{\text {doub }} \cup g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)$. By Proposition A.7, $g_{\widetilde{K}_{n}^{1}}^{-1} \xrightarrow{\text { l.u. }} g_{\widetilde{K}_{\infty}^{1}}^{-1}$ in $\left.g_{\widetilde{K}_{\infty}^{1}}\left(\mathbb{C} \backslash\left(\left(\widetilde{K}_{\infty}^{1}\right)^{\text {doub }} \cup g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)\right)=\mathbb{C} \backslash\left(S_{\widetilde{K}_{\infty}^{1}} \cup g_{\widetilde{K}_{\infty}^{1}} \circ g_{K_{\infty}^{2}, p_{\infty}^{2}}^{J}\left(B_{L^{1}}\right)\right)\right)$.

If $\eta(t), 0 \leq t<T$, is a continuous curve in $\overline{\mathbb{H}}$, and there are a continuous function $\widehat{w}$ on $[0, T)$ and a continuous and strictly increasing function $u$ on $[0, T)$ with $u(0)=0$, such that $\eta \circ u^{-1}(t), 0 \leq t<u(T)$, is the chordal Loewner curve driven by $\widehat{w} \circ u^{-1}$, then we say that $\eta$ is a chordal Loewner curve with speed $d u$ driven by $\widehat{w}$. For each $0 \leq t<T$, we also understand $\eta(t)$ as the prime end $g_{\eta[0, t]}^{-1}(\widehat{w}(t))$ of $\mathbb{H} \backslash \operatorname{Hull}(\eta[0, t])$. The following proposition is a well-known result in the Loewner theory, and so we omit its proof.

Proposition A.11. Suppose $\eta(t), 0 \leq t<T$, is a chordal Loewner curve. Let I be an open real interval, which contains $\eta \cap \mathbb{R}$. Let $U$ be a subdomain of $\mathbb{H}$, which is a neighborhood of $I$ in $\mathbb{H}$, and contains $\bigcup_{0 \leq t<T} \operatorname{Hull}(\eta[0, t])$. Let $\psi$ be a conformal map from $U$ into $\mathbb{H}$, which extends continuously to $U \cup I$, and maps $I$ into $\mathbb{R}$. Then $\psi \circ \eta(t), 0 \leq t<T$, is a chordal Loewner curve with some speed, and for each $t \in[0, T)$, $\psi$ sends the prime end $\eta(t)$ of $\mathbb{H} \backslash \operatorname{Hull}(\eta[0, t])$ to the prime end $\psi \circ \eta(t)$ of $\mathbb{H} \backslash \operatorname{Hull}(\psi \circ \eta[0, t])$.

Now we come back to the proof of Lemma A.5, For $j=1,2$ and $t \geq 0$, let $g_{t}^{j}$ denote the centered Loewner map for $\eta_{j}$ at time $t$, i.e., $g_{t}^{j}=g_{K_{t}^{j}}-\widehat{w}_{j}(t)$. Let $f_{t}^{j}=\left(g_{t}^{j}\right)^{-1}$ and $f_{t}^{j, J}=J \circ f_{t}^{j} \circ J$. Fix $t_{2} \geq 0$. By DMP of SLE, conditionally on $\mathcal{F}_{t_{2}}^{2}, \eta_{2}\left(t_{2}+\cdot\right)$ is a chordal SLE $\kappa \kappa$ in $\mathbb{H} \backslash K_{t_{2}}^{2}$ from $\eta_{2}\left(t_{2}\right)$ to $\infty$. Since $f_{t}^{2}$ maps $\mathbb{H}$ conformally onto $\mathbb{H} \backslash K_{t}^{2}$, extends continuously
to $\overline{\mathbb{H}^{\#}}$, and sends 0 and $\infty$ respectively to $\eta_{2}(t)$ and $\infty$, there is a standard chordal SLE $_{\kappa}$ curve $\eta_{2}^{t_{2}+}$ independent of $\mathcal{F}_{t_{2}}^{2}$ such that a.s. $\eta_{2}\left(t_{2}+\cdot\right)=f_{t_{2}}^{2} \circ \eta_{2}^{t_{2}+}$. The $\eta_{2}^{t_{2}+}$ is the chordal Loewner curve driven by $\widehat{w}_{2}^{t_{2}+}:=\widehat{w}_{2}\left(t_{2}+\cdot\right)-\widehat{w}_{2}\left(t_{2}\right)$. Let $K_{t}^{2, t_{2}+}=\operatorname{Hull}\left(\eta_{2}^{t_{2}+}[0, t]\right)$ and $g_{t}^{2, t_{2}+}$ be the centered Loewner map for $\eta_{2}^{t_{2}+}$, i.e., $g_{K_{t}^{2, t_{2}+}}-\widehat{w}_{2}^{t_{2}+}(t)$. Then $f_{t_{2}}^{2}=f_{t_{2}+t}^{2} \circ g_{t}^{2, t_{2}+}, t \geq 0$.

Since $\eta_{1}(t), 0 \leq t \leq \phi_{2}\left(t_{2}\right)$, is a time-reversal of $\eta_{2}^{J}(t), t_{2} \leq t \leq \infty$, by reversibility of $\operatorname{SLE}_{\kappa}$, conditionally on $\mathcal{F}_{t_{2}}^{2}, \eta_{1}(t), 0 \leq t \leq \phi_{2}\left(t_{2}\right)$, is a time-change of a chordal $\operatorname{SLE}_{\kappa}$ in $\mathbb{H} \backslash K_{t_{2}}^{2, J}$ from 0 to $\eta_{2}^{J}\left(t_{2}\right)$. Since $f_{t_{2}}^{2, J}:(\mathbb{H} ; 0, \infty) \xrightarrow{\text { Conf }}\left(\mathbb{H} \backslash K_{t_{2}}^{2, J} ; 0, \eta_{2}^{J}\left(t_{2}\right)\right)$, there is a standard chordal $\mathrm{SLE}_{\kappa}$ curve $\zeta_{1}^{t_{2}}$ independent of $\mathcal{F}_{t_{2}}^{2}$, and an increasing homeomorphism $u_{1}^{t_{2}}$ from $\left[0, \phi_{2}\left(t_{2}\right)\right]$ onto $[0, \infty]$, such that a.s. $\eta_{1}=f_{t_{2}}^{2, J} \circ \zeta_{1}^{t_{2}} \circ u_{1}^{t_{2}}$ on $\left[0, \phi_{2}\left(t_{2}\right)\right]$. Let $\widehat{v}_{1}^{t_{2}}$ be the driving function for $\zeta_{1}^{t_{2}}$. Let $\eta_{1}^{t_{2}}=\zeta_{1}^{t_{2}} \circ u_{1}^{t_{2}}$ and $\widehat{w}_{1}^{t_{2}}=\widehat{v}_{1}^{t_{2}} \circ u_{1}^{t_{2}}$. Then $\eta_{1}^{t_{2}}$ is the chordal Loewner curve with speed $d u_{1}^{t_{2}}$ driven by $\widehat{w}_{1}^{t_{2}}$, and a.s. $\eta_{1}=f_{t_{2}}^{2, J} \circ \eta_{1}^{t_{2}}$ on $\left[0, \phi_{2}\left(t_{2}\right)\right]$.

Lemma A.12. The functions $\eta_{1}^{t_{2}}\left(t_{1}\right), u_{1}^{t_{2}}\left(t_{1}\right), \widehat{w}_{1}^{t_{2}}\left(t_{1}\right)$ all have continuous versions on $\mathcal{D}_{2}=$ $\left\{\left(t_{1}, t_{2}\right): \eta_{2}^{J}\left(t_{2}\right) \notin \eta_{1}\left[0, t_{1}\right]\right\}$. More specifically, there are continuous processes $\eta_{1}^{*}: \mathcal{D}_{2} \rightarrow \overline{\mathbb{H}}$, $u_{1}^{*}: \mathcal{D}_{2} \rightarrow \mathbb{R}_{+}$and $\widehat{w}_{1}^{*}: \mathcal{D}_{2} \rightarrow \mathbb{R}$ such that for any fixed $t_{2} \in \mathbb{R}_{+}, \eta_{1}^{*}\left(\cdot, t_{2}\right)$ is the chordal Loewner curve with speed $d u_{1}^{*}\left(\cdot, t_{2}\right)$ driven by $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$; and a.s. $\eta_{1}^{*}\left(\cdot, t_{2}\right), u_{1}^{*}\left(\cdot, t_{2}\right)$ and $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$ are respectively equal to $\eta_{1}^{t_{2}}, u_{1}^{t_{2}}$ and $\widehat{w}_{1}^{t_{2}}$, which further implies that a.s. $\left.\eta_{1}\right|_{\left[0, \phi_{2}\left(t_{2}\right)\right)}=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, t_{2}\right)$. Here for two functions to be equal, they must have the same domain.

Proof. Let $\mathcal{A}$ denote the set of triples $\left(t_{1}^{0} ; t_{2}^{0}, t_{2}^{1}\right)$, where $t_{1}^{0}, t_{2}^{0}, t_{2}^{1} \in \mathbb{Q}_{+}$and $t_{2}^{0}<t_{2}^{1}$. For each $\underline{v}=\left(t_{1}^{0} ; t_{2}^{0}, t_{2}^{1}\right) \in \mathcal{A}$, define $R_{\underline{v}}=\left[0, t_{1}^{0}\right] \times\left[t_{2}^{0}, t_{2}^{1}\right]$ and $E_{\underline{v}}=\left\{R_{\underline{v}} \subset \mathcal{D}_{2}\right\}$. We make the following claim: for any $\underline{v}=\left(t_{1}^{0} ; t_{2}^{0}, t_{2}^{1}\right) \in \mathcal{A}$, on the event $E_{\underline{v}}$, there are continuous processes $\eta_{1}^{*}: R_{\underline{v}} \rightarrow \overline{\mathbb{H}}$, $u_{1}^{*}: R_{\underline{v}} \rightarrow \mathbb{R}_{+}$and $\widehat{w}_{1}^{*}: R_{\underline{v}} \rightarrow \mathbb{R}$ such that for any $t_{2} \in\left[t_{2}^{0}, t_{2}^{1}\right], \eta_{1}^{*}\left(\cdot, t_{2}\right)$ is the chordal Loewner curve with speed $d u_{1}^{*}\left(\cdot, t_{2}\right)$ driven by $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$; and a.s. $\eta_{1}^{*}\left(\cdot, t_{2}\right), u_{1}^{*}\left(\cdot, t_{2}\right)$ and $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$ are respectively equal to the restrictions of $\eta_{1}^{t_{2}}, u_{1}^{t_{2}}$ and $\widehat{w}_{1}^{t_{2}}$ to $\left[0, t_{1}^{0}\right]$.

Fix $\underline{v}=\left(t_{1}^{0} ; t_{2}^{0}, t_{2}^{1}\right) \in \mathcal{A}$. Let $\Delta t_{2}=t_{2}^{1}-t_{2}^{0}$. Suppose $E_{\underline{v}}$ happens. Then $\eta_{2}^{J}\left[t_{2}^{0}, t_{2}^{1}\right] \cap$ $\eta_{1}\left[0, t_{1}^{0}\right]=\emptyset$. Since $\eta_{2}^{J}\left[t_{2}^{0}, t_{2}^{1}\right]=f_{t_{2}^{0}}^{2, J} \circ J \circ \eta_{2}^{t_{2}^{0}}\left[0, \Delta t_{2}\right]$ and $\eta^{1}\left[0, t_{1}^{0}\right]=f_{t_{2}^{0}}^{2, J} \circ \eta_{1}^{t_{1}^{0}}\left[0, t_{1}^{0}\right]$, we get $\left(J \circ \eta_{2}^{t_{2}^{0+}}\left[0, \Delta t_{2}\right]\right) \cap \eta_{1}^{t_{2}^{0}}\left[0, t_{1}^{0}\right]=\emptyset$. Since both $\eta_{1}^{t_{2}}$ and $\eta_{2}^{t_{2}^{0}+}$ start from 0 , we can find a (random) pair $\underline{L}=\left(L^{1}, L^{2}\right) \in \Xi$ such that $K_{t_{1}^{0}}^{1, t_{2}^{0}} \subset L^{1}$ and $K_{\Delta t_{2}}^{2, t_{2}^{0}+} \subset L^{2}$. Then $\left(K_{t_{1}}^{1, t_{2}^{0}}, \eta_{1}^{t_{2}^{0}}\left(t_{1}\right)\right), 0 \leq t_{1} \leq t_{1}^{0}$, and $\left(K_{t_{2}}^{2, t_{2}^{0+}}, \eta_{2}^{t_{2}^{0+}}\left(t_{2}\right)\right), 0 \leq t_{2} \leq \Delta t_{2}$, are respectively continuous curves in $\mathcal{P}\left(L^{1}\right)$ and $\mathcal{P}\left(L^{2}\right)$.

Let $g_{t}^{2, t_{2}^{0}+, J}=J \circ g_{t}^{2, t_{2}^{0}+} \circ J$. Let $t_{2} \in\left[t_{2}^{0}, t_{2}^{1}\right]$. We have a.s., for all $t_{1} \in\left[0, t_{1}^{0}\right]$,

f_{t_{2}}^{2, J} \circ \eta_{1}^{t_{2}}\left(t_{1}\right)=\eta_{1}\left(t_{1}\right)=f_{t_{2}^{0}}^{2, J} \circ \eta_{1}^{t_{2}^{0}}\left(t_{1}\right)=f_{t_{2}}^{2, J} \circ g_{t_{2}-t_{2}^{0}}^{2, t_{0}^{0}+, J} \circ \eta_{1}^{t_{2}^{0}}\left(t_{1}\right),
$$

which implies that a.s. for all $t_{1} \in S_{1}:=\left[0, t_{1}^{0}\right] \cap\left(\eta_{1}^{t_{2}^{0}}\right)^{-1}(\mathbb{H}), \eta_{1}^{t_{2}}\left(t_{1}\right)=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+J} \circ \eta_{1}^{t_{2}^{0}}\left(t_{1}\right)$. Since $S_{1}$ is dense in $\left[0, t_{1}^{0}\right]$, both $\eta_{1}^{t_{2}}$ and $\eta_{1}^{t_{2}^{0}}$ are continuous on $\left[0, t_{1}^{0}\right]$, and $g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+, J}$ is continuous on $\overline{\mathbb{H}} \backslash J\left(\overline{K_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+}}\right) \supset \overline{\mathbb{H}} \backslash J\left(\overline{L^{2}}\right) \supset \overline{L^{1}} \supset \eta_{1}^{t_{2}^{0}}\left[0, t_{1}^{0}\right]$, we get a.s. $\eta_{1}^{t_{2}}=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+, J} \circ \eta_{1}^{t_{2}^{0}}$ on $\left[0, t_{1}^{0}\right]$.

Define $\eta_{1}^{*}$ and $u_{1}^{*}$ by $\eta_{1}^{*}\left(t_{1}, t_{2}\right)=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+J} \circ \eta_{1}^{t_{2}^{0}}\left(t_{1}\right)$ and $u_{1}^{*}\left(t_{1}, t_{2}\right)=\operatorname{hcap}_{2}\left(\eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)\right)$ for $\left(t_{1}, t_{2}\right) \in R_{\underline{v}}$. Then $\eta_{1}^{*}$ and $u_{1}^{*}$ are continuous on $R_{\underline{v}}$ by Proposition A.9, By the last paragraph, for any $t_{2} \in\left[t_{2}^{0}, t_{2}^{1}\right]$, a.s. $\eta_{1}^{*}\left(\cdot, t_{2}\right)=\eta_{1}^{t_{2}}$ and $\eta_{1}=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, t_{2}\right)$ on $\left[0, t_{1}^{0}\right]$. So $\eta_{1}^{*}$ and $u_{1}^{*}$ are continuous versions of $\eta_{1}^{t_{2}}\left(t_{1}\right)$ and $u_{1}^{t_{2}}\left(t_{1}\right)$ on $R_{\underline{v}}$. By the continuity of $\eta_{1}, \eta_{1}^{*}$, and $f_{t_{2}}^{2, J}$, we then get a.s. $\eta_{1}\left(t_{1}\right)=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(t_{1}, t_{2}\right)$ for any $\left(t_{1}, t_{2}\right) \in R_{v}$. By Proposition A.11, $\eta_{1}^{*}\left(\cdot, t_{2}\right)$ is a chordal Loewner curve with speed $d u_{1}^{*}\left(\cdot, t_{2}\right)$. Define $\widehat{w}_{1}^{*} \overline{:} R_{\underline{v}} \rightarrow \mathbb{R}$ such that for every $t_{2} \in\left[t_{2}^{0}, t_{2}^{1}\right]$, $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$ is the driving function for $\eta_{1}^{*}\left(\cdot, t_{2}\right)$. For any $t_{2} \in\left[t_{2}^{0}, t_{2}^{1}\right]$, since a.s. $\eta_{1}^{*}\left(\cdot, t_{2}\right)=\eta_{1}^{t_{2}}$ on $\left[0, t_{1}^{0}\right]$, and $\widehat{w}_{1}^{t_{2}}$ is the driving function for $\eta_{1}^{t_{2}}$, we find that a.s. $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)=\widehat{w}_{1}^{t_{2}}$ on $\left[0, t_{1}^{0}\right]$. To prove the claim, it remains to prove that $\widehat{w}_{1}^{*}$ is a.s. continuous on $R_{v}$.

From $\eta_{1}=f_{t_{2}}^{2, J}\left(\eta_{1}^{*}\left(\cdot, t_{2}\right)\right)=f_{t_{2}^{0}}^{2, J}\left(\eta_{1}^{*}\left(\cdot, t_{2}^{0}\right)\right)$, we get $\eta_{1}^{*}\left(\cdot, t_{2}\right)=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+J} \circ \eta_{1}^{*}\left(\cdot, t_{2}^{0}\right), t_{2} \geq t_{2}^{0}$. For $\underline{t}=\left(t_{1}, t_{2}\right) \in R_{\underline{v}}$, let $K_{t_{1}}^{1, t_{2}}=\operatorname{Hull}\left(\eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)\right)$. Then we have $K_{t_{1}}^{1, t_{2}}=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+, J}\left(K_{t_{1}}^{1, t_{2}^{0}}\right)$ and $\widehat{w}_{1}^{*}(\underline{t})=g_{K_{t_{1}}^{1, t, t_{2}}}\left(\eta_{1}^{*}(\underline{t})\right)$. Define $G_{\underline{t}}=g_{K_{t_{1}}^{1, t_{2}}} \circ g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+J} \circ g_{K_{t_{1}}^{1, t_{2}^{0}}}^{-1}$, which maps $\mathbb{H} \backslash\left(g_{K_{t_{1}}^{1, t_{2}^{\prime}}} \circ J\left(K_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+}\right)\right.$ conformally onto $\mathbb{H}$, and extends to a conformal map from $\mathbb{C} \backslash\left(g_{K_{t_{1}}^{1, t_{2}^{0}}} \circ J\left(\left(K_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+}\right)^{\text {doub }}\right)\right)$, which contains $\widehat{w}_{1}^{*}\left(t_{1}^{0}, t_{2}\right)$, into $\mathbb{C}$. From $\widehat{w}_{1}^{*}(\underline{t})=g_{K_{t_{1}}^{1, t_{2}}}\left(\eta_{1}^{*}(\underline{t})\right), \widehat{w}_{1}^{*}\left(t_{1}, t_{2}^{0}\right)=g_{K_{t_{1}}^{1, t_{2}^{0}}}\left(\eta_{1}^{*}\left(t_{1}, t_{2}^{0}\right)\right)$, and $\eta_{1}^{*}\left(\cdot, t_{2}\right)=g_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+J} \circ \eta_{1}^{*}\left(\cdot, t_{2}^{0}\right)$, we get $w_{1}^{*}(\underline{t})=G_{\underline{t}}\left(w_{1}^{*}\left(t_{1}, t_{2}^{0}\right)\right)$. Since $w_{1}^{*}\left(\cdot, t_{2}^{0}\right)=w_{1}^{t_{2}^{0}}$, which is continuous in $t_{1}$, to show that $w_{1}^{*}$ is continuous in $\underline{t}$, it suffices to show that $G_{\underline{t}}(x)$ is jointly continuous in $\underline{t}$ and $x$ on a domain that contains $\left\{(\underline{t}, x): \underline{t} \in R_{\underline{v}}, x \in S_{K_{t_{1}}^{1, t_{2}}}\right\}$.

Since $G_{\underline{t}}$ is a conformal map for each $\underline{t} \in \underline{v}$, to prove the joint continuity, by maximum principle, it suffices to show that, for any fixed $\underline{t}^{*}=\left(t_{1}^{*}, t_{2}^{*}\right) \in R_{\underline{v}}$, there is a Jordan curve $\xi$, whose interior domain contains $S_{K_{t_{1}^{*}}^{1, t_{2}^{\prime}}}$, and is contained in $\mathbb{C} \backslash\left(g_{K_{t_{1}^{1}}^{1, t_{2}^{0}}} \circ J\left(\left(K_{t_{2}-t_{2}^{0}}^{2, t_{2}^{0}+}\right)^{\text {doub }}\right)\right)$, such that as $R_{\underline{v}} \ni \underline{t}^{n} \rightarrow \underline{t}^{*}, G_{\underline{t}^{n}} \rightarrow G_{\underline{t}^{*}}$ uniformly on $\xi$. To choose such $\xi$, we may first find a Jordan curve $\xi^{\prime}$, which separates $\left(L^{1}\right)^{\text {doub }}$ from $J\left(\left(L^{2}\right)^{\text {doub }}\right)$, and then let $\xi=g_{K_{t_{1}^{1, t_{2}^{0}}}}\left(\xi^{\prime}\right)$. Then we use Lemma A. 10 to conclude that $G_{\underline{t}^{n}} \rightarrow G_{\underline{t}^{*}}$ uniformly on $\xi$ if $R_{\underline{v}} \ni \underline{t}^{n} \rightarrow \underline{t}^{*}$.

Now we have proved the claim. Since $\mathcal{D}_{2}$ is the union of $R_{\underline{v}}$ over those $\underline{v} \in \mathcal{A}$ such that $R_{\underline{v}} \subset \mathcal{D}_{2}$, from the claim we conclude the existence of continuous maps $\eta_{1}^{*}, u_{1}^{*}$ and $\widehat{w}_{1}^{*}$ defined on $\mathcal{D}_{2}$ with all properties described in the statement except that now we can only say that a.s. $\eta_{1}^{*}\left(\cdot, t_{2}\right), u_{1}^{*}\left(\cdot, t_{2}\right)$ and $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right)$ are respectively equal to the restrictions of $\eta_{1}^{t_{2}}, u_{1}^{t_{2}}$ and $\widehat{w}_{1}^{t_{2}}$ to $\left[0, T_{2}\left(t_{2}\right)\right)$, where $T_{2}\left(t_{2}\right):=\inf \left\{t_{1}: \eta_{1}\left(t_{1}\right)=\eta_{2}^{J}\left(t_{2}\right)\right\}$. From $\left.\eta_{1}\right|_{\left[0, \phi_{2}\left(t_{2}\right)\right)}=f_{t_{2}}^{2, J} \circ \eta_{1}^{t_{2}}$ we know that a.s. $f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, t_{2}\right)$ equals $\left.\eta_{1}\right|_{\left[0, T_{2}\left(t_{2}\right)\right)}$. We know that $\eta_{1}^{t_{2}}, u_{1}^{t_{2}}$ and $\widehat{w}_{1}^{t_{2}}$ are defined on $\left[0, \phi_{2}\left(t_{2}\right)\right)$. To conclude the proof, it suffices to show that a.s. $T_{2}\left(t_{2}\right)=\phi_{2}\left(t_{2}\right)$.

Since $\left.\eta_{1}\right|_{\left[0, \phi_{2}\left(t_{2}\right)\right]}$ is a time-change of a chordal $\mathrm{SLE}_{\kappa}$ in $\mathbb{H} \backslash J\left(K_{t_{2}}^{2, J}\right)$ from 0 to the prime end $\eta_{2}^{J}\left(t_{2}\right), \eta_{1}$ first visits the prime end $\eta_{2}^{J}\left(t_{2}\right)$ at the time $\phi_{2}\left(t_{2}\right)$. We claim that a.s. $\eta_{2}^{J}\left(t_{2}\right)$ is the only prime end of $\mathbb{H} \backslash J\left(K_{t_{2}}^{2, J}\right)$, which determines the boundary point $\eta_{2}^{J}\left(t_{2}\right)$. When $\kappa \leq 4$ this is true since $\eta_{2}^{J}$ is simple. When $\kappa>4$, this follows from [22, Theorem 6.1]. Thus, a.s. $\eta_{1}$ first
visits the point $\eta_{2}^{J}\left(t_{2}\right)$ at the time $\phi_{2}\left(t_{2}\right)$. So we get a.s. $T_{2}\left(t_{2}\right)=\phi_{2}\left(t_{2}\right)$, as desired.
By discarding a null event we may assume that $\eta_{1}\left(t_{1}\right)=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(t_{1}, t_{2}\right)$ for every $\left(t_{1}, t_{2}\right) \in \mathcal{D}_{2}$. For $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}_{2}$, let $K_{t_{1}}^{1, t_{2}}=\operatorname{Hull}\left(\eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)\right)$ and $f_{t_{1}}^{1, t_{2}}$ be the centered Loewner map $f_{K_{t_{1}}^{1, t_{2}}, \eta_{1}^{*}\left(t_{1}, t_{2}\right)}$. Let $f_{\underline{t}}^{1}=f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}$. It is clear that $\left\{\underline{t} \in \mathcal{D}_{2}\right\}=\left\{\eta_{2}^{J}\left(t_{2}\right) \notin \eta_{1}\left[0, t_{1}\right]\right\} \in \mathcal{F}_{\underline{t}}$, and $f_{t_{2}}^{2, J}$ is $\mathcal{F}_{t_{2}}^{2}$-measurable. Since $\eta_{1}^{*}\left(t, t_{2}\right), 0 \leq t \leq t_{1}$, are determined by $\left.\eta_{1}\right|_{\left[0, t_{1}\right]}$ and $\left.\eta_{2}\right|_{\left[0, t_{2}\right]}$, $f_{t_{1}}^{1, t_{2}}$ defined on the event $\left\{\underline{t} \in \mathcal{D}_{2}\right\}$ is $\mathcal{F}_{\underline{t}}$-measurable, and so is $f_{\underline{t}}^{1}=f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}$. Since $\eta_{1}^{*}$ is continuous on $\mathcal{D}_{2}$, by Proposition A.9, $\left(t_{1}, t_{2} ; z\right) \mapsto f_{t_{1}}^{1, t_{2}}(z)$ is jointly continuous on $\mathcal{D}_{2} \times \mathbb{H}$. Since the same is obviously true for $f_{t_{2}}^{2, J}(z), f_{\underline{t}}^{1}(z)$ is also jointly continuous on $\mathcal{D}_{2} \times \mathbb{H}$.

Lemma A.13. (i) For every $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}_{2}, f_{\underline{t}}^{1}$ is a conformal map on $\mathbb{H}$, has continuation on $\overline{\mathbb{H}}^{\#}$, and maps 0 and $\infty$ respectively to the points $\eta_{1}\left(t_{1}\right)$ and $\eta_{2}^{J}\left(t_{2}\right)$. Moreover, $f_{\underline{t}}^{1}(\mathbb{H})$ is the connected component of $\mathbb{H} \backslash\left(\eta_{1}\left[0, t_{1}\right] \cup \eta_{2}^{J}\left[0, t_{2}\right]\right)$ which shares the prime end $\eta_{2}^{J}\left(t_{2}\right)$ with $\mathbb{H} \backslash K_{t_{2}}^{2, J}$; and $f_{\underline{t}}^{1}$ sends the prime end $\infty$ to the prime end $\eta_{2}^{J}\left(t_{2}\right)$.
(ii) If $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}_{\cap}$, then besides the results in (i), $f_{\underline{t}}^{1}(\mathbb{H})$ also shares the prime end $\eta_{1}\left(t_{1}\right)$ with $\mathbb{H} \backslash K_{t_{1}}^{1}$, and $f_{\underline{t}}^{1}$ sends the prime end 0 to the $\bar{p}$ rime end $\eta_{1}\left(t_{1}\right)$.
Proof. (i) Let $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathcal{D}_{2}$. Since $f_{t_{2}}^{2, J}$ and $f_{t_{1}}^{1, t_{2}}$ are both conformal maps from $\mathbb{H}$ into $\mathbb{H}$, and have continuation on $\bar{H}^{\#}$, the same is true for $f_{\underline{t}}^{1}=f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}$. Since $f_{t_{1}}^{1, t_{2}}(0)=\eta_{1}^{*}(\underline{t})$, we get $f_{\underline{t}}^{1}(0)=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}(\underline{t})=\eta_{1}\left(t_{1}\right)$. Since $f_{t_{1}}^{1, t_{2}}(\mathbb{H})=\mathbb{H} \backslash K_{t_{1}}^{1, t_{2}}$ is a connected component of $\mathbb{H} \backslash \eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right), f_{\underline{t}}^{1}(\mathbb{H})$ is a connected component of $f_{t_{2}}^{2, J}(\mathbb{H}) \backslash f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)=\mathbb{H} \backslash\left(K_{t_{2}}^{2, J} \cup\right.$ $\left.\eta_{1}\left[0, t_{1}\right]\right)$, which is also a connected component of $\mathbb{H} \backslash\left(\eta_{2}^{J}\left[0, t_{2}\right] \cup \eta_{1}\left[0, t_{1}\right]\right)$.

Since $f_{t_{1}}^{1, t_{2}}(\mathbb{H})=\mathbb{H} \backslash K_{t_{1}}^{1, t_{2}}$ is the connected component of $\mathbb{H} \backslash \eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)$ that shares the prime end $\infty$ with $\mathbb{H}$, we see that $f_{\underline{t}}^{1}(\mathbb{H})=f_{t_{2}}^{2, J}\left(\mathbb{H} \backslash K_{t_{1}}^{1, t_{2}}\right)$ is contained in and shares the prime end $f_{t_{2}}^{2, J}(\infty)=\eta_{2}^{J}\left(t_{2}\right)$ with $f_{t_{2}}^{2, J}(\mathbb{H})=\mathbb{H} \backslash K_{t_{2}}^{2, J}$. Moreover, in terms of prime ends, we have

f_{\underline{t}}^{1}(\infty)=J \circ f_{t_{2}}^{2} \circ J \circ f_{t_{1}}^{1, t_{2}}(\infty)=J \circ f_{t_{2}}^{2} \circ J(\infty)=J \circ f_{t_{2}}^{2}(0)=\eta^{J}\left(t_{2}\right)
$$

(ii) Suppose now $\underline{t} \in \mathcal{D}_{\cap}$. Then $\eta_{1}\left(t_{1}\right) \notin \eta_{2}^{J}\left[0, t_{2}\right]$. So there is a connected component of $\mathbb{H} \backslash\left(\eta_{1}\left[0, t_{1}\right] \cup \eta_{2}^{J}\left[0, t_{2}\right]\right)$, which is contained in and shares the prime end $\eta_{1}\left(t_{1}\right)$ with $\mathbb{H} \backslash K_{t_{1}}^{1}$. Let the domain be denoted by $D_{\underline{t}}^{1}$. There is $\delta>0$ such that $\eta_{1}\left[t_{1}, t_{1}+\delta\right] \cap \eta_{2}^{J}\left[0, t_{2}\right]=\emptyset$. Let $S=\left\{t \in\left[t_{1}, t_{1}+\delta\right]: \eta_{1}(t) \in \underline{\mathbb{H}} \backslash K_{t_{1}}^{1}\right\}$. Then $\eta_{1}(S) \subset D_{\underline{t}}^{1}$, and $S$ is dense in $\left[t_{1}, t_{1}+\delta\right]$. Since $\eta_{1}=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, t_{2}\right)$, we get $\eta_{1}^{*}\left(S, t_{2}\right) \subset \mathbb{H} \backslash \eta_{1}^{*}\left(\left[0, t_{1}\right], t_{2}\right)$, which implies that $\eta_{1}^{*}\left(S, t_{2}\right) \subset$ $\mathbb{H} \backslash K_{t_{1}}^{1, t_{2}}=f_{t_{1}}^{1, t_{2}}(\mathbb{H})$. So $\eta_{1}(S) \subset f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}(\mathbb{H})=f_{\underline{t}}^{1}(\mathbb{H})$. Now $f_{\underline{t}}^{1}(\mathbb{H})$ and $D_{\underline{t}}^{1}$ are both some connected component of $\mathbb{H} \backslash\left(\eta_{1}\left[0, t_{1}\right] \cup \eta_{2}^{J}\left[0, t_{2}\right]\right)$, and have nonempty intersection: $\eta_{1}(S)$. So they must agree. Thus, $f_{\underline{t}}^{1}(\mathbb{H})$ is contained in and shares the prime end $\eta_{1}\left(t_{1}\right)$ with $\mathbb{H} \backslash K_{t_{1}}^{1}$.

As $t \downarrow t_{1}$ along $S, \eta_{1}^{*}\left(\bar{t}, t_{2}\right)$ and $\eta_{1}(t)=f_{t_{2}}^{2, J} \circ \eta_{1}^{*}\left(t, t_{2}\right)$ respectively approach the prime ends $\eta_{1}^{*}\left(t_{1}, t_{2}\right)$ of $\mathbb{H} \backslash K_{t_{1}}^{1, t_{2}}$ and $\eta_{1}\left(t_{1}\right)$ of $D_{\underline{t}}^{1}$. So $f_{t_{2}}^{2, J}$ sends the prime end $\eta_{1}^{*}(\underline{t})$ to the prime end $\eta_{1}\left(t_{1}\right)$. Thus, in terms of prime ends, $f_{\underline{t}}^{1}(0)=f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}(0)=f_{t_{2}}^{2, J}\left(\eta_{1}^{*}(\underline{t})\right)=\eta_{1}\left(t_{1}\right)$.

Lemma A.14. For any $\overline{\mathcal{F}}$-stopping time $\underline{T}$, the event $\left\{\underline{T} \in \mathcal{D}_{2}\right\}$ is $\overline{\mathcal{F}}_{\underline{T}^{-}}$-measurable, and $f_{\underline{T}}^{1}$ is an $\overline{\mathcal{F}}_{\underline{T}}$-measurable random conformal map defined on the event $\left\{\underline{T} \in \mathcal{D}_{2}\right\}$.

Proof. Let $\underline{T}=\left(T_{1}, T_{2}\right)$ be an $\overline{\mathcal{F}}$-stopping time. For each $n \in \mathbb{N}$ and $j=1,2$, define $T_{j}^{\lfloor n\rfloor}=$ $2^{-n}\left\lfloor 2^{n} T_{j}\right\rfloor$ and $T_{j}^{n}=T_{j}^{\lfloor n\rfloor}+2^{-n}$. Let $\underline{T}^{\lfloor n\rfloor}=\left(T_{1}^{\lfloor n\rfloor}, T_{2}^{\lfloor n\rfloor}\right)$ and $\underline{T}^{n}=\left(T_{1}^{n}, T_{2}^{n}\right)$. Then $\underline{T}^{\lfloor n\rfloor} \leq$ $T \leq \underline{T}^{n}, \underline{T}^{n}$ is an $\mathcal{F}$-stopping time, $\underline{T}^{\lfloor n\rfloor} \uparrow \underline{T}$, and $\underline{T}^{n} \downarrow \underline{T}$. For each $n \in \mathbb{N}$ and $\underline{t} \in\left(2^{-n} \mathbb{N}\right)^{2}$, by Proposition 2.5

\left.\left\{\underline{[\underline{L}}^{\lfloor n\rfloor}, \underline{T}^{n}\right] \subset \mathcal{D}_{2}\right\} \cap\left\{\underline{T}^{n}=\underline{t}\right\}=\left\{\left[\underline{t}-\left(2^{-n}, 2^{-n}\right), \underline{t}\right] \subset \mathcal{D}_{2}\right\} \cap\left\{\underline{T}^{n}=\underline{t}\right\} \\
=\left\{\eta_{2}^{J}\left[t_{2}-2^{-n}, t_{2}\right] \cap \eta_{1}\left[0, t_{1}\right]=\emptyset\right\} \in \mathcal{F}_{\underline{t}} \cap\left\{\underline{T}^{n}=\underline{t}\right\} \subset \mathcal{F}_{\underline{T}^{n}} .
\end{gathered}
$$

Thus, $\left\{\left[\underline{T}^{\lfloor n\rfloor}, \underline{T}^{n}\right] \subset \mathcal{D}_{2}\right\}=\bigcup_{\underline{t} \in\left(2^{-n} \mathbb{N}\right)^{2}}\left(\left\{\left[\underline{T}^{\lfloor n\rfloor}, \underline{T}^{n}\right] \subset \mathcal{D}_{2}\right\} \cap\left\{\underline{T}^{n}=\underline{t}\right\}\right) \in \mathcal{F}_{\underline{\underline{T}}^{n}}$. Similarly, for each $\underline{t} \in\left(2^{-n} \mathbb{N}\right)^{2}, f_{\underline{T}^{n}}^{1}$ restricted to $\left\{\underline{T}^{n} \in \mathcal{D}_{2}\right\} \cap\left\{\underline{T}^{n}=\underline{t}\right\}$ is measurable w.r.t. $\mathcal{F}_{\underline{t}} \cap\left\{\underline{T}^{n}=\underline{t}\right\} \subset \mathcal{F}_{\underline{T}^{n}}$, and so $f_{\underline{T}^{n}}^{1}$ is $\mathcal{F}_{\underline{T}^{n}}$-measurable on $\left\{\underline{T}^{n} \in \mathcal{D}_{2}\right\}$.

Since $\mathcal{D}_{2}$ is open, by Proposition [2.9, $\left\{\underline{T} \in \mathcal{D}_{2}\right\}=\bigcup_{m \geq l} \bigcap_{n \geq m}\left\{\left[\underline{T}^{\lfloor n\rfloor}, \underline{T}^{n}\right] \subset \mathcal{D}_{2}\right\} \in \mathcal{F}_{\underline{T}^{l}}$ for any $l \in \mathbb{N}$. Thus, $\left\{\underline{T} \in \mathcal{D}_{2}\right\} \in \bigcap_{l} \mathcal{F}_{\underline{T}^{l}}=\overline{\mathcal{F}}_{\underline{T}}$. Since $f_{\underline{t}}^{1}(z)$ is jointly continuous on $\mathcal{D}_{2} \times \mathbb{H}$, $f_{\underline{T}^{n}}^{1} \xrightarrow{\text { l.u. }} f_{\underline{T}}^{1}$ in $\mathbb{H}$ on $\left\{\underline{T} \in \mathcal{D}_{2}\right\}$. By Proposition 2.9, $f_{\underline{T}}^{1}$ is $\overline{\mathcal{F}}_{\underline{T}^{\text {-measurable. }} \text {. }}$
Lemma A.15. Let $\mathcal{F}_{n}, n \in \mathbb{N}$, and $\mathcal{F}_{0}$ be sub- $\sigma$-algebras of a probability space $(\Omega, \mathcal{F}, \mathbb{P})$ such that $\mathcal{F}_{0} \subset \bigcap_{n} \mathcal{F}_{n}$. Let $E_{n} \in \mathcal{F}_{n}, n \in \mathbb{N} \cup\{0\}$, be such that $E_{0} \subset \liminf E_{n}$. For $n \in \mathbb{N} \cup\{0\}$, let $X_{n}(t), t \geq 0$, be a continuous process defined on the event $E_{n}$ such that a.s. on $E_{0}, X_{n} \rightarrow X_{0}$ pointwise on $\mathbb{R}_{+}$. Let $\mu$ be a probability measure on $C\left(\mathbb{R}_{+}\right)$. Suppose for each $n \in \mathbb{N}$, the conditional law of $X_{n}$ given $\mathcal{F}_{n}$ and $E_{n}$ is $\mu$. Then the conditional law of $X_{0}$ given $\mathcal{F}_{0}$ and $E_{0}$ is also $\mu$.

Proof. Let $S=\left\{t_{1}<\cdots<t_{m}\right\}$ be a nonempty finite subset of $\mathbb{R}_{+}$, and $\mu_{S}$ be the finite dimensional distribution for $\mu$ on $S$. Then for any $n \in \mathbb{N}$, the conditional law of $\left(X_{n}\left(t_{1}\right), \ldots, X_{n}\left(t_{m}\right)\right)$ given $\mathcal{F}_{n}$ and $E_{n}$ is $\mu_{S}$. It suffices to show that the same is true for $X_{0}, \mathcal{F}_{0}$ and $E_{0}$. Let $f \in C_{b}\left(\mathbb{R}^{m}, \mathbb{R}\right)$ and $A_{0} \in \mathcal{F}_{0} \cap E_{0}$. Then for every $n \in \mathbb{N}, A_{0} \cap E_{n} \in \mathcal{F}_{n} \cap E_{n}$, and so

\mathbb{E}\left[\mathbf{1}_{A_{0} \cap E_{n}} f\left(X_{n}\left(t_{1}\right), \ldots, X_{n}\left(t_{m}\right)\right)\right]=\mathbb{P}\left[A_{0} \cap E_{n}\right] \int f d \mu_{S} .
$$

Since $E_{0} \subset \liminf E_{n}$, we have $\mathbf{1}_{A_{0} \cap E_{n}} \rightarrow \mathbf{1}_{A_{0}}$. By the continuity of $f$ and that $X_{n} \rightarrow X$, we get $f\left(X_{n}\left(t_{1}\right), \ldots, X_{n}\left(t_{m}\right)\right) \rightarrow f\left(X_{0}\left(t_{1}\right), \ldots, X_{0}\left(t_{m}\right)\right)$. Letting $n \rightarrow \infty$ and applying the dominated convergence theorem, we get $\mathbb{E}\left[\mathbf{1}_{A_{0}} f\left(X_{0}\left(t_{1}\right), \ldots, X_{0}\left(t_{m}\right)\right)\right]=\mathbb{P}\left[A_{0}\right] \int f d \mu_{S}$. Since this holds for any $f \in C_{b}\left(\mathbb{R}^{m}\right)$, the conditional law of $\left(X_{0}\left(t_{1}\right), \ldots, X_{0}\left(t_{m}\right)\right)$ given $\mathcal{F}_{0}$ and $E_{0}$ is $\mu_{S}$.

Proof of Lemma A.5. By Lemma A.14, $\left\{\underline{T} \in \mathcal{D}_{2}\right\} \in \overline{\mathcal{F}}_{\underline{T}}$ and $f_{\underline{T}}^{1}$ is $\overline{\mathcal{F}}_{\underline{T}}$-measurable. Symmetrically, $\left\{\underline{T} \in \mathcal{D}_{1}\right\} \in \overline{\mathcal{F}}_{\underline{T}}$. So $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\} \in \overline{\mathcal{F}}_{\underline{T}}$. We are going to show that Lemma A.5 holds with $f_{\underline{T}}:=f_{\underline{T}}^{1}=f_{T_{2}}^{2, J} \circ f_{T_{1}}^{1, \bar{T}_{2}}$. By Lemma A.13, on the event $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}, f_{\underline{T}}^{1}$ maps $\mathbb{H}$ conformally onto $H_{\underline{T}}^{1}$, and sends 0 and $\infty$ respectively to $\eta_{1}\left(t_{1}\right)$ and $\eta_{2}^{J}\left(t_{2}\right)$.

We first consider four special cases. In the first three cases we prove a stronger result, where $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$ is replaced by a bigger event $\left\{\underline{T} \in \mathcal{D}_{2}\right\}$.

Case 1. The $\underline{T}$ is a deterministic point $\underline{t}=\left(t_{1}, t_{2}\right) \in \mathbb{R}_{+}^{2}$. This is not completely trivial because we have to handle the right-continuous augmentation. We prove Case 1 in two steps.

Step 1. We prove that the statement holds with $\overline{\mathcal{F}}$ replaced by $\mathcal{F}$ (without right-continuous augmentation). We give a complete proof for this simpler statement, which also prepares us for the proof in Step 2. We write $E$ for the event $\left\{\underline{t} \in \mathcal{D}_{2}\right\}$.

Recall that $\zeta_{1}^{t_{2}}$ is a standard chordal SLE $_{\kappa}$ curve independent of $\mathcal{F}_{t_{2}}^{1}, u_{1}^{t_{2}}$ is an increasing homeomorphism from $\left[0, \phi_{2}\left(t_{2}\right)\right]$ onto $[0, \infty]$, and $\eta_{1}=f_{t_{2}}^{2, J} \circ \zeta_{t_{2}}^{1} \circ u_{t_{2}}^{1}$ on $\left[0, \phi_{2}\left(t_{2}\right)\right]$. Let $\mathcal{F}_{t}^{1, t_{2}}=$ $\sigma\left(\sigma\left(\zeta_{1}^{t_{2}}(s): s \leq t\right) \cup \mathcal{F}_{t_{2}}^{2}\right), t \geq 0$. We extend $u_{1}^{t_{2}}$ from $\left[0, \phi_{2}\left(t_{2}\right)\right)$ to $[0, \infty]$ such that it equals $\infty$ on $\left[\phi_{2}\left(t_{2}\right), \infty\right]$. For any $a \geq 0,\left\{u_{1}^{t_{2}}\left(t_{1}\right) \leq a\right\}=\left\{\operatorname{hcap}_{2}\left(f_{t_{2}}^{2, J} \circ \zeta_{1}^{t_{2}}[0, a]\right) \geq t\right\} \in \mathcal{F}_{a}^{1, t_{2}}$. Thus, $u_{1}^{t_{2}}\left(t_{1}\right)$ is an $\mathcal{F}^{1, t_{2}}$-stopping time. Applying the usual DMP to the standard chordal SLE $_{\kappa}$ curve $\zeta_{1}^{t_{2}}$ at the time $u_{1}^{t_{2}}\left(t_{1}\right)$, we get a standard chordal SLE $_{\kappa}$ curve $\zeta_{1}^{t}$ defined on the event $E$, which is conditionally independent of $\mathcal{F}_{u_{1}^{1, t_{2}}\left(t_{1}\right)}^{1,}$, such that $\zeta_{1}^{t_{2}}\left(u_{1}^{t_{2}}\left(t_{1}\right)+\cdot\right)=f_{t_{1}}^{1, t_{2}} \circ \zeta_{1}^{\frac{t}{1}}$ a.s on $E$. Let $u_{1}^{\frac{t}{1}}=\left(u_{1}^{t_{2}}\right)^{-1}\left(u_{1}^{t_{2}}\left(t_{1}\right)+\cdot\right)$. Then $u_{1}^{t}$ is an increasing homeomorphism from $[0, \infty]$ onto $\left[t_{1}, \phi_{2}\left(t_{2}\right)\right]$. Combining $f_{\underline{t}}^{1}=f_{t_{2}}^{2, J} \circ f_{t_{1}}^{1, t_{2}}, \eta_{1}=f_{t_{2}}^{2, J} \circ \zeta_{1}^{t_{2}} \circ u_{1}^{t_{2}}$ and $\zeta_{1}^{t_{2}}\left(u_{1}^{t_{2}}\left(t_{1}\right)+\cdot\right)=f_{t_{1}}^{1, t_{2}} \circ \zeta_{\frac{t}{1}}^{\underline{t}}$, we get $\eta_{1} \circ u_{1}^{t}=f_{\underline{t}}^{1} \circ \zeta_{\frac{t}{1}}$ a.s. on $E$.

Since $\mathcal{F}_{t_{2}}^{2} \subset \mathcal{F}_{u_{1}^{t_{2}\left(t_{1}\right)}}^{1, t_{2}}$, and on the event $E$, for $0 \leq t \leq t_{1}, \eta_{1}(t)=f_{t_{2}}^{2, J} \circ \zeta_{1}^{t_{2}} \circ u_{1}^{t_{2}}(t)$, we have $\mathcal{F}_{\underline{\underline{t}}} \cap E \subset \mathcal{F}_{u_{1}^{t_{2}\left(t_{1}\right)}}^{1, t_{2}}$. Since given $E, \zeta_{1}^{\frac{t}{t}}$ is conditionally independent of $\mathcal{F}_{u_{1}^{t_{2}}\left(t_{1}\right)}^{1, t_{2}}$, it is also conditionally independent of $\mathcal{F}_{\underline{t}}$. So we have finished Step 1 of Case 1.

Step 2. We prove that the $\zeta_{\overline{1}}^{\underline{t}}$ in Step 1 is conditionally independent of $\overline{\mathcal{F}}_{\underline{t}}$. When this is done, the proof of Case 1 is complete.

Let $\Omega_{2}=\left\{\left(u_{1}^{*}\left(s_{1}, s_{2}\right), s_{2}\right):\left(s_{1}, s_{2}\right) \in \mathcal{D}_{2}\right\}$. Define $u_{1}^{*-1}, \zeta_{1}^{*}, \widehat{v}_{1}^{*}$ on $\Omega_{2}$ such that for any $s_{2} \in$ $\mathbb{R}_{+}, u_{1}^{*-1}\left(\cdot, s_{2}\right)=u_{1}^{*}\left(\cdot, s_{2}\right)^{-1}, \zeta_{1}^{*}\left(\cdot, s_{2}\right)=\eta_{1}^{*}\left(u_{1}^{*-1}\left(\cdot, s_{2}\right), s_{2}\right)$, and $\widehat{v}_{1}^{*}\left(\cdot, s_{2}\right)=\widehat{w}_{1}^{*}\left(u_{1}^{*-1}\left(\cdot, s_{2}\right), s_{2}\right)$. Then $\zeta_{1}^{*}$ and $\widehat{v}_{1}^{*}$ are continuous on $\Omega_{2}$. For any $s_{2} \geq 0, \zeta_{1}^{*}\left(\cdot, s_{2}\right)$ is the chordal Loewner curve driven by $\widehat{v}_{1}^{*}\left(\cdot, s_{2}\right)$, and $\zeta_{1}^{*}\left(\cdot, s_{2}\right)$ and $\widehat{v}_{1}^{*}\left(\cdot, s_{2}\right)$ are respectively equal to $\zeta_{1}^{s_{2}}$ and $\widehat{v}_{1}^{s_{2}}$.

From the construction of $\zeta_{1}^{t}(t), t \geq 0$, its driving function, say $\widehat{v}_{1}^{t}(t)$, is given by $\widehat{v}_{1}^{t}(t):=$ $\widehat{v}_{1}^{t_{2}}\left(u_{1}^{t_{2}}\left(t_{1}\right)+t\right)-\widehat{v}_{1}^{t_{2}}\left(u_{1}^{t_{2}}\left(t_{1}\right)\right), t \geq 0$. By discarding a null event, we may assume that $\widehat{v}_{1}^{t}=$ $\widehat{v}_{1}^{*}\left(u_{1}^{*}\left(t_{1}, t_{2}\right)+\cdot, t_{2}\right)-\widehat{v}_{1}^{*}\left(u_{1}^{*}\left(t_{1}, t_{2}\right), t_{2}\right)$. Similarly, we may assume that $u_{1}^{t}=u_{1}^{*-1}\left(u_{1}^{*}\left(t_{1}, t_{2}\right)+\cdot, t_{2}\right)$. Then $\widehat{v}_{1}^{t}$ and $u_{1}^{t}$ are both continuous in $\underline{t}$ by continuity of $\widehat{v}_{1}^{*}, u_{1}^{*}, u_{1}^{*-1}$.

Choose $\underline{t}^{n} \downarrow \underline{t}$. Then $\overline{\mathcal{F}}_{\underline{t}} \subset \bigcap_{n} \mathcal{F}_{\underline{t}^{n}}$. Let $E_{n}=\left\{\underline{t}^{n} \in \mathcal{D}_{2}\right\} \in \mathcal{F}_{\underline{t}^{n}}$. Since $\mathcal{D}_{2}$ is open, we have $E \subset \lim \inf E_{n}$. For any $n \in \mathbb{N}$, by the result of Step 1 , conditionally on $\mathcal{F}_{\underline{t}^{n}}$ and $E_{n}, \widehat{v}_{1}^{t^{n}} / \sqrt{\kappa}$ has the law of a standard Brownian motion. By the continuity of $\widehat{v}_{1}^{t}$ in $\underline{t}, \widehat{v}^{\underline{t}} \rightarrow \widehat{v}^{\underline{t}}$ pointwise. By Lemma A.15, $\widehat{v}_{1}^{t}$ is conditionally independent of $\overline{\mathcal{F}}_{\underline{t}}$ given $E$. The same is true for $\zeta_{1}^{t}$ since it is the chordal Loewner curve determined by $\widehat{v}_{1}^{t}$. This finishes Step 2.

Case 2. $\underline{T}$ takes values in a countable set $S$. This follows easily from Case 1.
Case 3. $T_{2}$ takes values in a countable set $S_{2}$. For $n \in \mathbb{N}$, define $\underline{T}^{n}=\left(T_{1}^{n}, T_{2}\right)$ such that $T_{1}^{n}=2^{-n}\left\lceil 2^{n} T_{1}\right\rceil$. Then each $\underline{T}^{n}$ is an $\overline{\mathcal{F}}$-stopping time taking values in a countable set. By the
results of Cases 1 and 2 , for each $n$, on the event $E_{n}:=\left\{\underline{T}^{n} \in \mathcal{D}_{2}\right\}$ there are a chordal Loewner curve $\zeta_{1}^{T^{n}}$, whose driving function is given by $\widehat{v}_{1}^{T^{n}}:=\widehat{v}_{1}^{*}\left(u_{1}^{*}\left(\underline{T}^{n}\right)+\cdot, T_{2}\right)-\widehat{v}_{1}^{*}\left(u_{1}^{*}\left(\underline{T}^{n}\right), T_{2}\right)$, and an increasing homeomorphism $u_{1}^{T^{n}}:=u_{1}^{*-1}\left(u_{1}^{*}\left(\underline{T}^{n}\right)+\cdot, T_{2}\right)$ from $[0, \infty]$ onto $\left[T_{1}^{n}, \phi_{2}\left(T_{2}\right)\right]$, such that a.s. $\eta_{1} \circ u_{1}^{T^{n}}=f_{\underline{T}^{n}}^{1} \circ \zeta_{1}^{T^{n}}$ on $E_{n}$, and $\widehat{v}_{1}^{T^{n}} / \sqrt{\kappa}$ is a standard Brownian motion conditionally independent of $\overline{\mathcal{F}}_{\underline{T}^{n}}$ given the event $E_{n}$. Using the same argument as in Step 2 of Case 1 , we know that $\widehat{v}_{1}^{T}:=\widehat{v}_{1}^{*}\left(u_{1}^{*}(\underline{T})+\cdot, T_{2}\right)-\widehat{v}_{1}^{*}\left(u_{1}^{*}(\underline{T}), T_{2}\right)$ is conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$ with the law of $\sqrt{\kappa} B$ given $E:=\left\{\underline{T} \in \mathcal{D}_{2}\right\}=\bigcup_{n} E_{n}$. Thus, $\widehat{v}_{1}^{T}$ a.s. generates a chordal Loewner curve $\zeta_{1}^{T}$, which has the law of a standard chordal $\mathrm{SLE}_{\kappa}$, and is conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$ given $E$. Since $\widehat{v}_{1}^{*}\left(\cdot, T_{2}\right)$ is the driving function for $\zeta_{1}^{*}\left(\cdot, T_{2}\right)$, from the definitions of $\widehat{v}_{1}^{T}$ and $f_{T_{1}}^{\overline{1}, T_{2}}$ we know that $\zeta_{1}^{*}\left(u_{1}^{*}(\underline{T})+\cdot, T_{2}\right)=f_{T_{1}}^{1, T_{2}} \circ \zeta_{1}^{T}$. Combining this with $\eta_{1}^{*}\left(\cdot, T_{2}\right)=\zeta_{1}^{*}\left(\cdot, T_{2}\right) \circ u_{1}^{*}\left(\cdot, T_{2}\right)$, $\eta_{1}=f_{T_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, T_{2}\right), u_{1}^{\underline{T}}=u_{1}^{*-1}\left(u_{1}^{*}(\underline{T})+t, T_{2}\right)$, and $f_{\underline{T}}^{1}=f_{T_{2}}^{2, J} \circ f_{T_{1}}^{1, T_{2}}$, we get $\eta_{1} \circ u_{1}^{T}=f_{\underline{T}}^{1} \circ \zeta_{\underline{1}}^{T}$ a.s. on $\left\{\underline{T} \in \mathcal{D}_{2}\right\}$.

Case 4. $T_{1}$ takes values in a countable set $S_{1}$. Swapping indices " 1 " and " 2 " and using the result of Case 3, we know that on the event $\left\{\underline{T} \in \mathcal{D}_{1}\right\}$, there are

- an $\overline{\mathcal{F}}_{\underline{T}}$-measurable conformal map $f_{\underline{T}}^{2}$ on $\mathbb{H}$ with continuation on $\overline{\mathbb{H}^{\#}}$,
- a standard chordal SLE $_{\kappa}$ curve $\zeta_{2}^{\frac{T}{2}}$ conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$, and
- an increasing homeomorphism $u_{2}^{\frac{T}{2}}$ from $[0, \infty]$ onto $\left[T_{2}, \phi_{1}\left(T_{1}\right)\right]$,
such that $\eta_{2} \circ u^{\underline{T}}=f_{\underline{T}}^{2} \circ \zeta_{2}^{T}$ a.s. on $\left\{\underline{T} \in \mathcal{D}_{1}\right\}$. Moreover, on the event $E_{\cap}:=\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}, f_{\underline{T}}^{2}$ maps $\mathbb{H}$ conformally onto the connected component $D_{\underline{T}}^{2}$ of $\mathbb{H} \backslash\left(\eta_{2}\left[0, T_{2}\right] \cup J \circ \eta_{1}\left[0, T_{1}\right]\right)$ which shares the prime ends $\eta_{2}\left(T_{2}\right)$ and $J \circ \eta_{1}\left(T_{1}\right)$ respectively with $\mathbb{H} \backslash K_{T_{2}}^{2}$ and $\mathbb{H} \backslash J\left(K_{T_{1}}^{1}\right)$, and sends 0 and $\infty$ respectively to the prime ends $\eta_{2}\left(T_{2}\right)$ and $J \circ \eta_{1}\left(T_{1}\right)$.

Suppose $E_{\cap}$ happens. We have $J\left(D_{\underline{T}}^{2}\right)=D_{\underline{T}}^{1}$ since they are both a connected component of $\mathbb{H} \backslash\left(\eta_{1}\left[0, T_{1}\right] \cup \eta_{2}^{J}\left[0, T_{2}\right]\right)$ that shares the prime ends $\eta_{1}\left(T_{1}\right)$ and $\eta_{2}^{J}\left(T_{2}\right)$ respectively with $\mathbb{H} \backslash K_{T_{1}}^{1}$ and $\mathbb{H} \backslash K_{T_{2}}^{2, J}$. Let $f_{\underline{T}}^{2, J}=J \circ f_{\underline{T}}^{2} \circ J$. Then both $f_{\underline{T}}^{2, J}$ and $f_{\underline{T}}^{1}$ map $\mathbb{H}$ conformally onto $J\left(D_{\underline{T}}^{2}\right)=D_{\underline{T}}^{1}$, send 0 and $\infty$ respectively to the same prime ends $\eta_{1}\left(T_{1}\right)$ and $\eta_{2}^{J}\left(T_{2}\right)$, and are $\overline{\mathcal{F}}_{\underline{T}}$-measurable. So there is an $\overline{\mathcal{F}}_{\underline{T}}$-measurable random variable $a>0$ such that $f_{\underline{T}}^{2, J}=f_{\underline{T}}^{1}(\cdot / a)$.

Applying the reversibility of SLE to $\zeta_{2}^{T}$, we get another standard chordal $\operatorname{SLE}_{\kappa}$ curve $\widetilde{\zeta}_{1}^{\underline{T}}$, which is also conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$, and a decreasing auto-homeomorphism $\widehat{\phi}_{2}$ of $[0, \infty]$, such that a.s. $J \circ \zeta_{2}^{\frac{T}{2}}=\widetilde{\zeta}_{1}^{T} \circ \widehat{\phi}_{2}$. Let $u^{\frac{T}{1}}(t)=\phi_{2} \circ u^{\frac{T}{2}} \circ \widehat{\phi}_{2}^{-1}\left(a^{2} t\right)$. Then $u^{\frac{T}{1}}$ is an increasing homeomorphism from $[0, \infty]$ onto $\left[T_{1}, \phi_{2}\left(T_{2}\right)\right]$. Let $\zeta_{1}^{\frac{T}{1}}(t)=\widetilde{\zeta}_{1}^{\frac{T}{1}}\left(a^{2} t\right) / a$. Since $a$ is
 curve conditionally independent of $\overline{\mathcal{F}}_{\underline{T}}$. Moreover, on $\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$, a.s.

$$
\begin{gathered}
J \circ \eta_{1} \circ u_{1}^{\underline{T}}=\eta_{2} \circ \phi_{2}^{-1} \circ u_{1}^{\frac{T}{1}}=\eta_{2} \circ u_{2}^{\frac{T}{2} \circ \widehat{\phi}_{2}^{-1}\left(a^{2} \cdot\right)=f_{\underline{T}}^{2} \circ \zeta_{2}^{\frac{T}{2}} \circ \widehat{\phi}_{2}^{-1}\left(a^{2} \cdot\right)} \\
\quad=f_{\underline{T}}^{2} \circ J \circ \widetilde{\zeta}_{1}^{\underline{T}}\left(a^{2} \cdot\right)=f_{\underline{T}}^{2} \circ J\left(a \zeta_{\underline{1}}^{T}\right)=J \circ f_{\underline{T}}^{2, J}\left(a \zeta_{1}^{T}\right)=J \circ f_{\underline{T}}^{1} \circ \zeta_{\underline{1}}^{T},
\end{gathered}
$$

which implies that $\eta_{1} \circ u_{1}^{T}=f_{T}^{1} \circ \zeta_{1}^{\frac{T}{1}}$. This completes Case 4.
General Case. For $n \in \mathbb{N}$, define $\underline{T}^{n}=\left(T_{1}^{n}, T_{2}\right)$ such that $T_{1}^{n}=2^{-n}\left\lceil 2^{n} T_{1}\right\rceil$. Then each $\underline{T}^{n}$ is an $\overline{\mathcal{F}}$-stopping time with the first variable taking values in a countable set. Let $E_{0}=\left\{\underline{T} \in \mathcal{D}_{\cap}\right\}$ and $E_{n}=\left\{\underline{T}^{n} \in \mathcal{D}_{\cap}\right\}, n \in \mathbb{N}$. By Case 4 , for each $n$, on the event $E_{n}$, there are a standard chordal $\operatorname{SLE}_{\kappa}$ curve $\zeta_{1}^{T^{n}}$, which is conditionally independent of $\overline{\mathcal{F}}_{\underline{T}^{n}}$ given $E_{n}$, and an increasing homeomorphism $u_{1}^{T^{n}}$ from $[0, \infty]$ onto $\left[T_{1}^{n}, \phi_{2}\left(T_{2}\right)\right]$, such that $\eta_{1} \circ u_{1}^{T^{n}}=f_{\underline{T}^{n}}^{1} \circ \zeta_{1}^{T^{n}}$ a.s. on $E_{n}$.

Suppose $E_{n}$ happens. Then $T_{1}^{n}<\phi_{2}\left(T_{2}\right)$. Let $u_{1}^{n}=\left(u_{1}^{T^{n}}\right)^{-1}\left(\cdot+T_{1}^{n}\right)$, which is an increasing homeomorphism from $\left[0, \phi_{2}\left(T_{2}\right)-T_{1}^{n}\right]$ onto $[0, \infty]$. Let $\widehat{v}_{1}^{T^{n}}$ be the driving function for $\zeta_{1}^{T^{n}}$. Let $\eta_{1}^{T^{n}}=\zeta_{1}^{T^{n}} \circ u_{1}^{n}$ and $\widehat{w}_{1}^{T^{n}}=\widehat{v}_{1}^{T^{n}} \circ u_{1}^{n}$. Then $\eta_{1}^{T^{n}}$ is the chordal Loewner curve with speed $d u_{1}^{n}$ driven by $\widehat{w}_{1}^{T^{n}}$. From a.s. $\eta_{1} \circ u_{1}^{T^{n}}=f_{\underline{T}^{n}}^{1} \circ \zeta_{1}^{T^{n}}$ we get a.s. $\eta_{1}\left(T_{1}^{n}+\cdot\right)=f_{T^{n}}^{1} \circ \eta_{1}^{T^{n}}$.

Define $\eta_{1}^{T_{2}, n}, u_{1}^{T_{2}, n}, \widehat{w}_{1}^{T_{2}, n}$ on $\left[0, \phi_{2}\left(\bar{T}_{2}\right)\right)$ such that, for $0 \leq t_{1}<T_{1}^{n}, \eta_{1}^{T_{2}, n}\left(t_{1}\right)=\eta_{1}^{*}\left(t_{1}, T_{2}\right)$, $u_{1}^{T_{2}, n}\left(t_{1}\right)=u_{1}^{*}\left(t_{1}, T_{2}\right)$, and $\widehat{w}_{1}^{T_{2}, n}\left(t_{1}\right)=\widehat{w}_{1}^{*}\left(t_{1}, T_{2}\right)$; and for $T_{1}^{n} \leq t_{1}<\phi_{2}\left(T_{2}\right), \eta_{1}^{T_{2}, n}\left(t_{1}\right)=$ $f_{T_{1}^{n}}^{1, T_{2}}\left(\eta_{1}^{T^{n}}\left(t_{1}-T_{1}^{n}\right)\right), u_{1}^{T_{2}, n}\left(t_{1}\right)=u_{1}^{*}\left(\underline{T}^{n}\right)+u_{1}^{n}\left(t_{1}-T_{1}^{n}\right)$, and $\widehat{w}_{1}^{T_{2}, n}\left(t_{1}\right)=\widehat{w}_{1}^{*}\left(\underline{T}^{n}\right)+\widehat{w}_{1}^{T^{n}}\left(t_{1}-T_{1}^{n}\right)$. Since $\eta_{1}^{*}\left(\cdot, t_{2}\right)$ is the chordal Loewner curve with speed $d u_{1}^{*}\left(\cdot, t_{2}\right)$ driven by $\widehat{w}_{1}^{*}\left(\cdot, t_{2}\right), f_{T_{1}^{n}}^{1, T_{2}}$ is the centered Loewner map for $\eta_{1}^{*}\left(\cdot, t_{2}\right)$ at the time $T_{1}^{n}$, and $\eta_{1}^{T^{n}}$ is the chordal Loewner curve with speed $d u_{1}^{n}$ driven by $\widehat{w}_{1}^{T^{n}}$, we see that $\eta_{1}^{T_{2}, n}$ is the chordal Loewner curve with speed $d u_{1}^{T_{2}, n}$ driven by $\widehat{w}_{1}^{T_{2}, n}$. From a.s. $\eta_{1}=f_{T_{2}}^{2, J} \circ \eta_{1}^{*}\left(\cdot, T_{2}\right), \eta_{1}\left(T_{1}^{n}+\cdot\right)=f_{\underline{T}^{n}}^{1} \circ \eta_{1}^{\frac{T^{n}}{n}}$, and $f_{\underline{T}^{n}}^{1}=f_{T_{2}}^{2, J} \circ f_{T_{1}^{n}}^{1, T_{2}}$, we get $\eta_{1}(t)=f_{T_{2}}^{2, J} \circ \eta_{1}^{T_{2}, n}(t), 0 \leq t<\phi_{2}\left(T_{2}\right)$, a.s. on $E_{n}$.

Let $\zeta_{1}^{T_{2}, n}=\eta_{1}^{T_{2}, n} \circ\left(u_{1}^{T_{2}, n}\right)^{-1}$ and $\widehat{v}_{1}^{T_{2}, n}=\widehat{w}_{1}^{T_{2}, n} \circ\left(u_{1}^{T_{2}, n}\right)^{-1}$. Then $\zeta_{1}^{T_{2}, n}$ is the chordal Loewner curve driven by $\widehat{v}_{1}^{T_{2}, n}$, and $\left.\eta_{1}\right|_{\left[0, \phi_{2}\left(T_{2}\right)\right)}=f_{T_{2}}^{2, J} \circ \zeta_{1}^{T_{2}, n} \circ u_{1}^{T_{2}, n}$ a.s. on $E_{n}$. The last equality implies that a.s. $\zeta_{1}^{T_{2}, n}=\zeta_{1}^{T_{2}, m}$ and $u_{1}^{T_{2}, n}=u_{1}^{T_{2}, m}$ on $E_{n} \cap E_{m}$ for any $n, m \in \mathbb{N}$. Since $E_{0} \subset \liminf E_{n}$, we may define a Loewner curve $\zeta_{1}^{T_{2}}$ and a time-change function $u_{1}^{T_{2}}$ on $E_{0}$ such that for every $n \in \mathbb{N}, \zeta_{1}^{T_{2}}=\zeta_{1}^{T_{2}, n}$ and $u_{1}^{T_{2}}=u_{1}^{T_{2}, n}$ a.s. on $E_{0} \cap E_{n}$. Then we have $\left.\eta_{1}\right|_{\left[0, \phi_{2}\left(T_{2}\right)\right)}=f_{T_{2}}^{2, J} \circ \zeta_{1}^{T_{2}} \circ u_{1}^{T_{2}}$ a.s. on $E_{0}$. Let $\widehat{v}_{1}^{T_{2}}$ be the driving function for $\zeta_{1}^{T_{2}}$. Then $v_{1}^{T_{2}}=v_{1}^{T_{2}, n}$ a.s. on $E_{0} \cap E_{n}$.

By the definition of $u_{1}^{T_{2}, n},\left(u_{1}^{T_{2}, n}\right)^{-1}\left(u_{1}^{*}\left(\underline{T}^{n}\right)+t_{1}\right)=T_{1}^{n}+\left(u_{1}^{n}\right)^{-1}\left(t_{1}\right)$. By the definition of $\widehat{w}_{1}^{T_{2}, n}, \widehat{w}_{1}^{T_{2}, n}\left(T_{1}^{n}+\left(u_{1}^{n}\right)^{-1}\left(t_{1}\right)\right)=\widehat{w}_{1}^{*}\left(\underline{T}^{n}\right)+\widehat{w}_{1}^{\bar{T}^{n}} \circ\left(u_{1}^{n}\right)^{-1}\left(t_{1}\right)$. By these two equalities and the definition of $\widehat{v}_{1}^{T_{2}, n}$ and that $\widehat{w}_{1}^{T^{n}}=\widehat{v}_{1}^{T^{n}} \circ u_{1}^{n}$ we get $\widehat{v}_{1}^{T^{n}}=\widehat{v}_{1}^{T_{2}, n}\left(u_{1}^{*}\left(\underline{T}^{n}\right)+\cdot\right)-v_{1}^{T_{2}, n}\left(u_{1}^{*}\left(\underline{T}^{n}\right)\right)$. From the independence property of $\zeta \frac{T^{n}}{}$, we see that, conditionally on $\overline{\mathcal{F}}_{\underline{T}^{n}}$ and the event $E_{n}, \widehat{v}_{1}^{T^{n}}$ has the law of $\left(\sqrt{\kappa} B_{t}\right)$. It is clear that, a.s. on $E_{0}, \widehat{v}_{1}^{T^{n}} \rightarrow \widehat{v}_{1}^{T}:=\widehat{v}_{1}^{T_{2}}\left(u_{1}^{*}(\underline{T})+\cdot\right)-\widehat{v}_{1}^{T_{2}}\left(u_{1}^{*}(\underline{T})\right)$ pointwise on $\mathbb{R}_{+}$since $\widehat{v}_{1}^{T_{2}, n}=\widehat{v}_{1}^{T_{2}}$ and $u_{1}^{T_{2}, n}=\widehat{u}_{1}^{T_{2}}$ for $n$ big enough. By Lemma A.15, conditionally on $\overline{\mathcal{F}}_{\underline{T}}$ and the event $E_{0}, \widehat{v}_{1}^{T}$ also has the law of $\left(\sqrt{\kappa} B_{t}\right)$. Thus, $\widehat{v}_{1}^{T}$ generates a chordal Loewner curve $\zeta_{1}^{T}$ defined on $E_{0}$, which has the law of a standard chordal $\operatorname{SLE}_{\kappa}$ conditionally on $\overline{\mathcal{F}}_{\underline{T}}$ and $E_{0}$. Since $\left(f_{t}^{1, T_{2}}\right)_{t \geq 0}$ are the centered Loewner maps for $\eta_{1}^{T_{2}}=\zeta_{1}^{T_{2}} \circ u_{1}^{*}\left(\cdot, T_{2}\right)$, we have $\zeta_{1}^{T_{2}}\left(u_{1}^{*}(\underline{T})+\cdot\right)=f_{T_{1}}^{1, T_{2}} \circ \zeta_{1}^{\underline{T}}$. Let $u_{1}^{\frac{T}{1}}(s)=\left(u_{1}^{T_{2}}\right)^{-1}\left(s+u_{1}^{*}(\underline{T})\right), s \geq 0$. Then $u_{1}^{T}$ is an increasing homeomorphism from $[0, \infty]$ onto $\left[T_{1}, \phi_{2}\left(T_{2}\right)\right]$. Since $\eta_{1}=f_{T_{2}}^{2, J} \circ \zeta_{1}^{T_{2}} \circ u_{1}^{T_{2}}$ a.s. on $E_{0}$ and $f_{\underline{T}}^{1}=f_{T_{2}}^{2, J} \circ f_{T_{1}}^{1, T_{2}}$, we then get $\eta_{1} \circ u_{1}^{\frac{T}{1}}=f_{\underline{T}}^{1} \circ \zeta_{\underline{1}}^{\underline{T}}$ a.s. on $E_{0}$, as desired.
