Torsion functions and the Cheeger problem: a fractional approach

Abstract: Let Ω be a Lipschitz bounded domain of \mathbb{R}^N , $N \geq 2$. The fractional Cheeger constant $h_s(\Omega)$, 0 < s < 1, is defined by $h_s(\Omega) = \inf_{E \subset \Omega} \frac{P_s(E)}{|E|}$, where $P_s(E) = \int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|\chi_E(x) - \chi_E(y)|}{|x-y|^{N+s}} dxdy$ with χ_E denoting the characteristic function of the smooth subdomain E. The main purpose of this paper is to show that $\lim_{p \to 1^+} |\phi_p^s|_{L^{\infty}(\Omega)}^{1-p} = h_s(\Omega) = \lim_{p \to 1^+} |\phi_p^s|_{L^1(\Omega)}^{1-p}$, where ϕ_p^s is the fractional (s, p)-torsion function of Ω , that is, the solution of the Dirichlet problem for the fractional p-Laplacian: $-(\Delta)_p^s u = 1$ in Ω , u = 0 in $\mathbb{R}^N \setminus \Omega$. For this, we derive suitable bounds for the first eigenvalue $\lambda_{1,p}^s(\Omega)$ of the fractional p-Laplacian operator in terms of ϕ_p^s . We also show that ϕ_p^s minimizes the (s, p)-Gagliardo seminorm in \mathbb{R}^N , among the functions normalized by the L^1 -norm.

Key words: Fractional Cheeger problem, fractional *p*-Laplacian, fractional torsion functions. **MSC 2010**: Primary 35P15, 35R11; Secondary 47A75.

1 Introduction

The Cheeger constant $h(\Omega)$ of a bounded domain $\Omega \subset \mathbb{R}^N$ (N > 1) is defined by

$$h(\Omega) = \inf_{E \subset \Omega} \frac{P(E)}{|E|},\tag{1.1}$$

where E is a smooth subset of Ω and the nonnegative values P(E) and |E| denote, respectively, the distributional perimeter and the N-dimensional Lebesgue measure of E. A subset E that minimizes the quotient is a Cheeger set of Ω .

In [7] Kawohl and Fridman proved that

$$h(\Omega) = \lim_{p \to 1^+} \lambda_{1,p}(\Omega),$$

where $\lambda_{1,p}(\Omega)$ is the first eigenvalue of the Dirichlet *p*-Laplacian operator, that is, the least real number λ such that the Dirichlet problem

$$\begin{cases} -\Delta_p u = \lambda |u|^{p-2} u & \text{in } \Omega \\ u = 0 & \text{on } \partial \Omega \end{cases}$$

has a nontrivial solution. (Let us recall that the *p*-Laplacian operator is defined by $\Delta_p u := \operatorname{div}(|\nabla u|^{p-2}\nabla u)$, p > 1.)

The first eigenvalue $\lambda_{1,p}(\Omega)$ is also variationally characterized by

$$\lambda_{1,p}(\Omega) := \min\left\{ |\nabla u|_p^p \, : \, u \in W_0^{1,p}(\Omega), |u|_p = 1 \right\},\,$$

with $|\cdot|_r$ standing for the usual norm of $L^r(\Omega)$, $1 \le r \le \infty$ (this notation will be adopted from now on).

In [2] a different characterization of the Cheeger constant of Ω was obtained:

$$\lim_{p \to 1^+} \frac{1}{|\phi_p|_{\infty}^{p-1}} = h(\Omega) = \lim_{p \to 1^+} \frac{1}{|\phi_p|_1^{p-1}}$$

where ϕ_p denotes the *p*-torsion function of Ω , that is, the solution of the Dirichlet problem

$$\begin{cases} -\Delta_p u = 1 & \text{in } \Omega \\ u = 0 & \text{on } \partial \Omega \end{cases}$$

which is known as the p-torsional creep problem (see [6]).

We remark that

$$\frac{1}{\phi_p|_1^{p-1}} = \min\left\{ |\nabla u|_p^p : u \in W_0^{1,p}(\mathbb{R}^N), \ |u|_1 = 1 \right\},\$$

since the minimum is attained at $\phi_p / |\phi_p|_1$.

The fractional version of problem $(1.\overline{1})$ consists in minimizing that quotient when P(E) is substituted by $P_s(E)$, given by

$$P_s(E) = \int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|\chi_E(x) - \chi_E(y)|}{|x - y|^{N+s}} \mathrm{d}x \mathrm{d}y,$$

where χ_E stands for the characteristic function of the smooth subdomain E. The value $P_s(E)$ is called the (nonlocal) s-perimeter of E. So, the fractional Cheeger problem is the minimization problem

$$h_s(\Omega) = \inf_{E \subset \Omega} \frac{P_s(E)}{|E|},$$

and $h_s(\Omega)$ is called the s-Cheeger constant of Ω .

For $1 and <math>s \in (0, 1)$, the fractional (s, p)-Laplacian $(-\Delta)_p^s$ is the nonlinear nonlocal operator defined by

$$(-\Delta)_{p}^{s} u(x) = \lim_{\epsilon \to 0^{+}} \int_{\mathbb{R}^{N} \setminus B_{\epsilon}(x)} \frac{|u(x) - u(y)|^{p-2} (u(x) - u(y))}{|x - y|^{N+sp}} \mathrm{d}y$$

This definition is consistent, up to a normalization constant depending on p, s and N, with the usual p-Laplacian operator.

The first (fractional) eigenvalue $\lambda_{1,p}^s(\Omega)$ of $(-\Delta)_p^s$ is the least number λ such that the problem

$$\begin{cases} (-\Delta)_p^s u = \lambda |u|^{p-2} u & \text{in } \Omega \\ u = 0 & \text{on } \mathbb{R}^N \setminus \Omega, \end{cases}$$

has a nontrivial weak solution (see [8, 4]). Its variational characterization is given by (see [1]):

$$\lambda_{1,p}^{s}(\Omega) := \min\left\{ \left[u \right]_{s,p}^{p} : u \in W_{0}^{s,p}(\Omega), \ |u|_{p} = 1 \right\},$$
(1.2)

where

$$[u]_{s,p} := \left(\int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|u(x) - u(y)|^p}{|x - y|^{N + sp}} \mathrm{d}x \mathrm{d}y \right)^{\frac{1}{p}}$$
(1.3)

is the (s, p)-seminorm of Gagliardo in \mathbb{R}^N of a measurable function u and $W_0^{s,p}(\Omega)$ is a suitable fractional Sobolev space defined in the sequel (see Definition 2.1).

In [1] Brasco, Lindgren and Parini proved the s-Cheeger version of the result originally obtained by Kawohl and Friedman [7] for the Cheeger problem:

$$h_s(\Omega) = \lim_{p \to 1^+} \lambda_{1,p}^s(\Omega).$$
(1.4)

In this paper, by assuming that Ω is a Lipschitz bounded domain, we show, in the spirit of the paper [2], that the fractional version of the torsional creep problem,

$$\begin{cases} (-\Delta)_p^s u = 1 & \text{in } \Omega \\ u = 0 & \text{on } \mathbb{R}^N \setminus \Omega \end{cases}$$

is intrinsically connected to both the s-Cheeger problem and the first eigenproblem for the fractional Dirichlet p-Laplacian, as p goes to 1.

This connection will be developed in Section 2, where we introduce the (s, p)-torsion function of Ω , that is, the weak solution ϕ_p^s of (1). We will derive the estimates

$$\frac{1}{\left|\phi_{p}^{s}\right|_{\infty}^{p-1}} \leq \lambda_{1,p}^{s}(\Omega) \leq \left(\frac{\left|\Omega\right|}{\left|\phi_{p}^{s}\right|_{1}}\right)^{p-1}$$
(1.5)

and

$$\frac{\left|\phi_{p}^{s}\right|_{\infty}}{\left|\phi_{p}^{s}\right|_{1}} \leq \frac{1}{\left|B_{1}\right|} \left(\frac{sp+N(p-1)}{sp}\right)^{\frac{sp+N(p-1)}{sp}} \left(\frac{\lambda_{1,p}^{s}(\Omega)}{\lambda_{1,p}^{s}(B_{1})}\right)^{\frac{N}{sp}},\tag{1.6}$$

where B_1 denotes the unit ball of \mathbb{R}^N .

Then, taking (1.4) into account, we will combine (1.5) with (1.6) in order to conclude the main result of this paper:

$$\lim_{p \to 1^+} \frac{1}{\left|\phi_p^s\right|_{\infty}^{p-1}} = h_s(\Omega) = \lim_{p \to 1^+} \frac{1}{\left|\phi_p^s\right|_1^{p-1}}.$$

Still in Section 2 we prove that ϕ_p^s minimizes, in $W_0^{s,p}(\Omega) \setminus \{0\}$, the Rayleigh quotient $[u]_{s,p}^p / |u|_1^p$. As an immediate consequence of this fact, we show that ϕ_p^s is a radial function when Ω is a ball.

$\mathbf{2}$ The main results

From now on Ω denotes a Lipschitz bounded domain of \mathbb{R}^N , $N \ge 2$, and $0 < s < 1 < p < \frac{N}{s}$.

Definition 2.1 The Sobolev space $W_0^{s,p}(\Omega)$ is the closure of $C_0^{\infty}(\Omega)$ with respect to the norm

$$\|u\| := [u]_{s,p} + |u|_p, \qquad (2.1)$$

where $[u]_{s,p}$ is defined by (1.3).

Functions in $W_0^{s,p}(\Omega)$ have a natural extension to \mathbb{R}^N and, although u = 0 in $\mathbb{R}^N \setminus \Omega$, the identity

$$[u]_{s,p}^p = \int_{\Omega} \int_{\Omega} \frac{|u(x) - u(y)|^p}{|x - y|^{N + sp}} \mathrm{d}x \mathrm{d}y + 2 \int_{\mathbb{R}^N \setminus \Omega} \int_{\Omega} \frac{|u(x)|^p}{|x - y|^{N + sp}} \mathrm{d}x \mathrm{d}y$$

shows dependence on values in $\mathbb{R}^N \setminus \Omega$.

It is worth mentioning that $W_0^{s,p}(\Omega)$ is a reflexive Banach space and that this space coincides with the closure of $C_0^{\infty}(\Omega)$ relative to the norm

$$u \longmapsto \left(\int_{\Omega} \int_{\Omega} \frac{|u(x) - u(y)|^p}{|x - y|^{N + sp}} \mathrm{d}x \mathrm{d}y \right)^{\frac{1}{p}} + |u|_p \,,$$

if $\partial \Omega$ is Lipschitz, (see [1, Proposition B.1]).

Moreover, thanks the fractional Poincaré inequality (see [1, Lemma 2.4])

$$|u|_p^p \le C_{N,s,p,\Omega} \left[u \right]_{s,p}^p, \quad \forall \, u \in C_0^\infty(\Omega),$$

 $\begin{array}{l} [\cdot]_{s,p} \text{ is also a norm in } W^{s,p}_0(\Omega), \text{ equivalent to norm defined in (2.1).} \\ \text{ We refer the reader to [3] for fractional Sobolev spaces.} \end{array}$

Definition 2.2 We say that a function $u \in W_0^{s,p}(\Omega)$ is a weak solution of the fractional Dirichlet problem

$$\begin{cases} (-\Delta)_p^s u = f & \text{in } \Omega\\ u = 0 & \text{on } \mathbb{R}^N \setminus \Omega, \end{cases}$$
(2.2)

 $i\!f$

$$\left\langle (-\Delta)_p^s \, u, \varphi \right\rangle = \int_{\Omega} f\varphi \, \mathrm{d}x, \quad \forall \, \varphi \in W_0^{s, p}(\Omega), \tag{2.3}$$

where

$$\left\langle (-\Delta)_p^s \, u, \varphi \right\rangle := \int_{\mathbb{R}^N} \int_{\mathbb{R}^N} \frac{|u(x) - u(y)|^{p-2} (u(x) - u(y))(\varphi(x) - \varphi(y))}{|x - y|^{N+sp}} \mathrm{d}x \mathrm{d}y,$$

a notation that will be used from now on.

Existence of a weak solution of (2.2), when $f \in L^1(\Omega)$ follows from direct minimization in $W_0^{s,p}(\Omega)$ of the functional

$$\frac{1}{p} \left[u \right]_{s,p}^p - \int_{\Omega} f(x) u(x) \, \mathrm{d}x,$$

whereas uniqueness comes from, for instance, the comparison principle for the fractional *p*-Laplacian (see [8, Lemma 9]). The same principle shows that if f is nonnegative then the weak solution u is nonnegative as well. When $f \in L^{\infty}(\Omega)$ and Ω is sufficiently smooth, say with boundary at least of class $C^{1,1}$, the weak solutions are α -Hölder continuous up to the boundary for some $\alpha \in (0, 1)$, see [5].

When $f \equiv 1$ the Dirichlet problem (2.2) will be referred to as the (s, p)-fractional torsional creep problem and its unique weak solution will be called (s, p)-torsion function. Let us denote this function by ϕ_p^s . We have $\phi_p^s \ge 0$ and

$$\left\langle (-\Delta)_p^s \phi_p^s, \varphi \right\rangle = \int_{\Omega} \varphi \, \mathrm{d}x, \quad \forall \, \varphi \in W_0^{s,p}(\Omega).$$
 (2.4)

In particular, by taking $\varphi = \phi_p^s$ we obtain

$$\left\langle (-\Delta)_{p}^{s}\,\phi_{p}^{s},\phi_{p}^{s}\right\rangle =\left[\phi_{p}^{s}\right]_{s,p}^{p}=\left|\phi_{p}^{s}\right|_{1}$$

Theorem 2.1 We have

$$\frac{1}{\left|\phi_{p}^{s}\right|_{1}^{p-1}} = \min\left\{\left[v\right]_{s,p}^{p} : v \in W_{0}^{s,p}(\Omega), \left|v\right|_{1} = 1\right\} = \left\lfloor\frac{\phi_{p}^{s}}{\left|\phi_{p}^{s}\right|_{1}}\right\rfloor_{s,p}.$$
(2.5)

Moreover, $\frac{\phi_p^s}{|\phi_p^s|_1}$ is the only nonnegative function attaining the minimum.

Proof. Since the functional $v \mapsto |v|_1$ is not differentiable, we will first consider the minimization problem

$$m := \inf\left\{ [v]_{s,p}^{p} : v \in W_{0}^{s,p}(\Omega), \int_{\Omega} v \, \mathrm{d}x = 1 \right\}$$
(2.6)

and show that it is uniquely solved by the positive function $\frac{\phi_p^s}{|\phi_p^s|_1}$.

Thus, let us take a sequence $(u_n) \subset W_0^{s,p}(\Omega)$ such that

$$\int_{\Omega} u_n \, \mathrm{d}x = 1 \quad \text{and} \quad [u_n]_{s,p}^p \to m.$$

We observe that the sequence (u_n) is bounded in $L^1(\Omega)$:

$$|u_n|_1^p \le |\Omega|^{p-1} |u_n|_p^p \le |\Omega|^{p-1} \lambda_{1,p}^s(\Omega)^{-1} [u_n]_{s,p}^p.$$

Since $W_0^{s,p}(\Omega)$ is reflexive, the L^1 -boundedness of (u_n) implies the existence of $u \in W_0^{s,p}(\Omega)$ such that, up to a subsequence, $u_n \rightharpoonup u$ (weak convergence) in $W_0^{s,p}(\Omega)$ and $u_n \rightarrow u$ in $L^1(\Omega)$. The convergence in $L^1(\Omega)$ implies that $\int_{\Omega} u \, dx = 1$, so that $m \leq [u]_{s,p}^p$. On its turn, the weak convergence guarantees that

$$[u]_{s,p} + 1 = ||u|| \le \liminf ||u_n|| = \liminf \left([u_n]_{s,p} + 1 \right) = m^{\frac{1}{p}} + 1.$$

It follows that $m = [u]_{s,p}^p$, so that the infimum in (2.6) is attained by the weak limit u.

By applying Lagrange multipliers, we infer the existence of a real number λ such that

$$\left\langle (-\Delta)_p^s u, \varphi \right\rangle = \lambda \int_{\Omega} \varphi \, \mathrm{d}x, \quad \forall \varphi \in W_0^{s,p}(\Omega).$$
 (2.7)

Taking $\varphi = u$ we conclude that $\lambda = m > 0$, since $m = [u]_{s,p}^p$ and $\int_{\Omega} u \, dx = 1$.

This fact and (2.7) imply that u is a weak solution of the Dirichlet problem

$$\begin{cases} (-\Delta)_p^s u = m & \text{in } \Omega \\ u = 0 & \text{on } \mathbb{R}^N \setminus \Omega. \end{cases}$$

By uniqueness, we have $u = m^{\frac{1}{p-1}} \phi_p^s \ge 0$. Since $\int_{\Omega} u \, dx = 1$ we conclude that

$$m = \frac{1}{\left|\phi_p^s\right|_1^{p-1}} \quad \text{and} \quad u = \frac{\phi_p^s}{\left|\phi_p^s\right|_1}.$$

We remark that

$$\frac{1}{|\phi_p^s|_1^{p-1}} \le [|v|]_{s,p}^p \le [v]_{s,p}^p$$

for every $v \in W_0^{s,p}(\Omega)$ such that $|v|_1 = 1$. This finishes the proof since

$$\frac{1}{\left|\phi_p^s\right|_1^{p-1}} = \left[\frac{\phi_p^s}{\left|\phi_p^s\right|_1}\right]_{s,p} \quad \text{and} \quad \left|\frac{\phi_p^s}{\left|\phi_p^s\right|_1}\right|_1 = 1.$$

The next result recovers Lemma 4.1 of [5]:

Corollary 2.1 The (s, p)-torsion function is radial when Ω is a ball.

Proof. Let $(\phi_p^s)^* \in W_0^{s,p}(\Omega)$ be the Schwarz symmetrization of ϕ_p^s , that is, the radially decreasing function such that

$$\left\{\phi_p^s > t\right\}^* = \left\{(\phi_p^s)^* > t\right\}, \ t > 0,$$

where, for any $D \subset \mathbb{R}^N$, D^* stands for the N-dimensional ball with the same volume of D. It is well-known that $(\phi_p^s)^* \ge 0$, $[(\phi_p^s)^*]_{s,p} \le [\phi_p^s]_{s,p}$ and $|(\phi_p^s)^*|_1 = |\phi_p^s|_1$. Therefore, $(\phi_p^s)^* / |(\phi_p^s)^*|_1$ attains the minimum in (2.5) and by uniqueness we have $(\phi_p^s)^* = \phi_p^s$.

It is also well-known that the first eigenfunctions of the fractional p-Laplacian belong to $L^{\infty}(\Omega)$ and are either positive or negative almost everywhere in Ω . Moreover, they are scalar multiple each other. So, let us denote by e_p^s the positive and L^{∞} -normalized first eigenfunction. It follows that $|e_p^s|_{\infty} = 1$ and

$$\begin{cases} (-\Delta)_p^s e_p^s &= \lambda_{1,p}^s(\Omega)(e_p^s)^{p-1} & \text{in } \Omega \\ e_p^s &= 0 & \text{on } \mathbb{R}^N \setminus \Omega \end{cases}$$

meaning that

$$\left\langle (-\Delta)_p^s \, e_p^s, \varphi \right\rangle = \lambda_{1,p}^s(\Omega) \int_{\Omega} (e_p^s)^{p-1} \varphi \, \mathrm{d}x, \quad \forall \, \varphi \in W_0^{s,p}(\Omega).$$
(2.8)

Of course, by taking $\varphi = e_p^s$ in (2.8) we obtain

$$\left\langle (-\Delta)_p^s \, e_p^s, e_p^s \right\rangle = \left[e_p^s \right]_{s,p}^p = \lambda_{1,p}^s(\Omega) \left| e_p^s \right|_p^p.$$

As mentioned in the introduction, $\lambda_{1,p}^s(\Omega)$ is variationally characterized by (1.2).

Proposition 2.1 Let $u \in W_0^{s,p}(\Omega)$ be the weak solution of (2.2) with $f \in L^{\infty}(\Omega) \setminus \{0\}$. Then,

$$|f|_{\infty}^{-\frac{1}{p-1}} u \le \phi_p^s \quad a.e. \text{ in } \Omega$$

$$(2.9)$$

and

$$\lambda_{1,p}^{s}(\Omega) \le \left|f\right|_{\infty} \left(\frac{\left|\Omega\right|}{\left|u\right|_{1}}\right)^{p-1}.$$
(2.10)

Proof. Since u and ϕ_p^s are both equal zero in $\mathbb{R}^N \setminus \Omega$ and

$$\begin{split} \left\langle (-\Delta)_p^s \left(|f|_{\infty}^{-\frac{1}{p-1}} u \right), \varphi \right\rangle &= |f|_{\infty}^{-1} \left\langle (-\Delta)_p^s u, \varphi \right\rangle \\ &= |f|_{\infty}^{-1} \int_{\Omega} f\varphi \, \mathrm{d}x \\ &\leq \int_{f \ge 0} \varphi \, \mathrm{d}x \le \int_{\Omega} \varphi \, \mathrm{d}x \le \left\langle (-\Delta)_p^s \, \phi_p^s, \varphi \right\rangle \end{split}$$

holds for every nonnegative $\varphi \in W_0^{s,p}(\Omega)$, (2.9) follows from the comparison principle (see [8, Lemma 9]).

In order to prove (2.10) we use (1.2) and Hölder inequality:

$$\begin{split} \lambda_{1,p}^{s}(\Omega) &\leq \frac{[u]_{s,p}^{p}}{|u|_{p}^{p}} \\ &= \frac{\int_{\Omega} f u \, \mathrm{d}x}{|u|_{p}^{p}} \leq \frac{|f|_{\infty} |u|_{1}}{|u|_{p}^{p}} \leq \frac{|f|_{\infty} |u|_{1}}{|u|_{1}^{p}} |\Omega|^{p-1} = \|f\|_{\infty} \left(\frac{|\Omega|}{|u|_{1}^{p}}\right)^{p-1}. \end{split}$$

Corollary 2.2 It holds

$$e_p^s \le \lambda_{1,p}^s(\Omega)^{\frac{1}{p-1}} \phi_p^s \quad a.e. \ in \ \Omega \tag{2.11}$$

and

$$\frac{1}{|\phi_p^s|_{\infty}^{p-1}} \le \lambda_{1,p}^s(\Omega) \le \frac{|\Omega|^{p-1}}{|\phi_p^s|_1^{p-1}}.$$
(2.12)

Proof. Taking $u = e_p^s$ and $f = \lambda_{1,p}(\Omega)(e_p^s)^{p-1}$ in (2.9) we readily obtain (2.11). Hence, passing to maxima, we arrive at the first inequality in (2.12). The second inequality, on its turn, follows from (2.10) with $u = \phi_p^s$ and $f \equiv 1$.

We would like to emphasize the following consequence of (2.11): $\phi_p^s > 0$ almost everywhere in Ω . A Faber-Krahn inequality also holds true for the first fractional eigenvalue. **Lemma 2.1 (Theorem 3.5 of [1])** Let p > 1 and $s \in (0, 1)$. For every bounded domain $D \subset \mathbb{R}^N$ we have

$$|B_1|^{\frac{sp}{N}}\lambda_{1,p}^s(B_1) = |B|^{\frac{sp}{N}}\lambda_{1,p}^s(B) \le |D|^{\frac{sp}{N}}\lambda_{1,p}^s(D)$$
(2.13)

where B is any N-dimensional ball and B_1 denotes the unit ball of \mathbb{R}^N .

Remark 2.1 Since $h_s(D) = \lim_{p \to 1^+} \lambda_{1,p}^s(D)$ one has, immediately,

$$|B_1|^{\frac{s}{N}} h_s(B_1) = |B|^{\frac{s}{N}} h_s(B) \le |D|^{\frac{s}{N}} h_s(D).$$
(2.14)

The next estimate is obtained by applying standard set-level techniques; however, the bounds obtained are adequate to study the asymptotic behavior as $p \to 1^+$.

Proposition 2.2 Let $u \in W_0^{1,p}(\Omega) \setminus \{0\}$ be a nonnegative, weak solution of (2.2) with $f \in L^{\infty}(\Omega)$. Then $u \in L^{\infty}(\Omega)$ and

$$\frac{|u|_{\infty}}{|u|_{1}} \le \frac{1}{|B_{1}|} \left(\frac{sp + N(p-1)}{sp}\right)^{\frac{sp + N(p-1)}{sp}} \left(\frac{|f|_{\infty}}{\lambda_{1,p}^{s}(B_{1}) |u|_{\infty}^{p-1}}\right)^{\frac{N}{sp}}.$$
(2.15)

Proof. For each k > 0 we set

$$A_k = \{x \in \Omega : u(x) > k\}$$

Since $u \in W_0^{s,p}(\Omega)$ and $u \ge 0$ in Ω , the function

$$(u-k)^+ = \max\{u-k, 0\} = \begin{cases} u-k, & \text{if } u > k \\ 0, & \text{if } u \le k \end{cases}$$

belongs to $W_0^{s,p}(\Omega)$. Therefore, choosing $\varphi = (u-k)^+$ in (2.3) we obtain

$$\left\langle (-\Delta)_p^s u, (u-k)^+ \right\rangle = \int_{A_k} f(x)(u-k) \,\mathrm{d}x.$$

It is not difficult to check that

$$[(u-k)^+]_{s,p}^p \le \langle (-\Delta)_p^s u, (u-k)^+ \rangle.$$

Thus, we have

$$[(u-k)^+]_{s,p}^p \le \int_{A_k} (u-k) f \, \mathrm{d}x \le |f|_\infty \int_{A_k} (u-k) \, \mathrm{d}x.$$
(2.16)

We now consider k > 0 such that $|A_k| > 0$. In order to estimate $[(u-k)^+]_{s,p}^p$ from below, let us fix a ball $B \subset \mathbb{R}^N$ and apply Lemma 2.1 to obtain

$$|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1) |A_k|^{-\frac{sp}{N}} \le \lambda_{1,p}^s(A_k) \le \frac{[(u-k)^+]_{s,p}^p}{\int_{A_k} (u-k)^p \, \mathrm{d}x}$$

Hence, Hölder's inequality yields

$$\left(\int_{A_k} (u-k) \,\mathrm{d}x\right)^p \le |A_k|^{p-1} \int_{A_k} (u-k)^p \,\mathrm{d}x \le |A_k|^{p-1} \frac{|A_k|^{\frac{sp}{N}} [(u-k)^+]_{s,p}^p}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}.$$

Thus, it follows from (2.16) that

$$|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)|A_k|^{-\frac{sp+N(p-1)}{N}} \left(\int_{A_k} (u-k) \, \mathrm{d}x \right)^p \le [(u-k)^+]_{s,p}^p$$
$$\le |f|_{\infty} \int_{A_k} (u-k) \, \mathrm{d}x,$$

what yields

$$\left(\int_{A_k} (u-k) \,\mathrm{d}x\right)^{p-1} \le \frac{|f|_{\infty} |A_k|^{\frac{sp+N(p-1)}{N}}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}$$

and so

$$\left(\int_{A_k} (u-k) \,\mathrm{d}x\right)^{\frac{N(p-1)}{sp+N(p-1)}} \le \left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp+N(p-1)}} |A_k|.$$
(2.17)

Define

$$g(k) := \int_{A_k} (u-k) \,\mathrm{d}x = \int_k^\infty |A_k| \,\mathrm{d}t,$$

the last equality being a consequence of Cavalieri's principle. Combining the definition of g(k) with (2.17), we have

$$[g(k)]^{\frac{N(p-1)}{sp+N(p-1)}} \le -\left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}}\lambda_{1,p}^s(B_1)}\right)^{\frac{N(p-1)}{sp+N(p-1)}}g'(k).$$

Therefore,

$$1 \le -\left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp+N(p-1)}} [g(k)]^{-\frac{N(p-1)}{sp+N(p-1)}} g'(k).$$
(2.18)

Integration of (2.18) from 0 to k produces

$$\begin{split} k &\leq \left(\frac{sp+N(p-1)}{sp}\right) \left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp+N(p-1)}} [g(0)^{\frac{sp}{sp+N(p-1)}} - g(k)^{\frac{sp}{sp+N(p-1)}}] \\ &\leq \left(\frac{sp+N(p-1)}{sp}\right) \left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp+N(p-1)}} (|u|_1)^{\frac{sp}{sp+N(p-1)}}, \end{split}$$

since $g(k) \ge 0$ and $g(0) = |u|_1$.

Let c denote, just for a moment, the right-hand side of the latter inequality. We have proved that $k \leq c$ whenever $|A_k| > 0$. Since c does not depend on k this implies that $|A_k| = 0$ for every k > c, thus allowing us to conclude that $u \in L^{\infty}(\Omega)$ and also that $|u|_{\infty} \leq c$. So,

$$|u|_{\infty} \leq \left(\frac{sp + N(p-1)}{sp}\right) \left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp+N(p-1)}} |u|_1^{\frac{sp}{sp+N(p-1)}}$$

or, what is the same,

$$|u|_{\infty}^{1+\frac{N(p-1)}{sp}} \le \left(\frac{sp+N(p-1)}{sp}\right)^{\frac{sp+N(p-1)}{sp}} \left(\frac{|f|_{\infty}}{|B_1|^{\frac{sp}{N}} \lambda_{1,p}^s(B_1)}\right)^{\frac{N}{sp}} |u|_1,$$

from what follows (2.15). \blacksquare

Corollary 2.3 The (s,p)-torsion function ϕ_p^s belongs to $L^{\infty}(\Omega)$ and, in addition,

$$\frac{1}{|\Omega|} \le \frac{\left|\phi_{p}^{s}\right|_{\infty}}{\left|\phi_{p}^{s}\right|_{1}} \le \frac{1}{|B_{1}|} \left(\frac{sp + N(p-1)}{sp}\right)^{\frac{sp + N(p-1)}{sp}} \left(\frac{\lambda_{1,p}^{s}(\Omega)}{\lambda_{1,p}^{s}(B_{1})}\right)^{\frac{N}{sp}}.$$
(2.19)

Proof. The first inequality is obvious. Proposition 2.2 with $u = \phi_p^s$ and $f \equiv 1$ yields

$$\frac{\left|\phi_{p}^{s}\right|_{\infty}}{\left|\phi_{p}^{s}\right|_{1}} \leq \frac{1}{|B_{1}|} \left(\frac{sp + N(p-1)}{sp}\right)^{\frac{sp + N(p-1)}{sp}} \left(\frac{1}{\lambda_{1,p}^{s}(B_{1}) \left|\phi_{p}^{s}\right|_{\infty}^{p-1}}\right)^{\frac{N}{sp}}.$$

Now, the second inequality in (2.19) follows from the first inequality in (2.12).

Theorem 2.2 One has

$$\lim_{p \to 1^+} \frac{1}{\left|\phi_p^s\right|_{\infty}^{p-1}} = h_s(\Omega) = \lim_{p \to 1^+} \frac{1}{\left|\phi_p^s\right|_1^{p-1}}$$

Proof. Taking (1.4) into account, we have

$$\lim_{p \to 1^+} \frac{\lambda_{1,p}^s(\Omega)}{\lambda_{1,p}^s(B_1)} = \frac{h_s(\Omega)}{h_s(B_1)} \in (0,\infty).$$

Hence, it follows from (2.19) that

$$\lim_{p \to 1^+} \left(\frac{\left| \phi_p^s \right|_\infty}{\left| \phi_p^s \right|_1} \right)^{p-1} = 1.$$

Thus, by making p go to 1 in (2.12) we have

$$\lim_{p \to 1^{+}} \lambda_{1,p}^{s}(\Omega) \leq \lim_{p \to 1^{+}} \frac{|\Omega|^{p-1}}{|\phi_{p}^{s}|_{1}^{p-1}} \\
= \lim_{p \to 1^{+}} \frac{1}{|\phi_{p}^{s}|_{1}^{p-1}} \\
= \lim_{p \to 1^{+}} \left(\frac{|\phi_{p}^{s}|_{\infty}}{|\phi_{p}^{s}|_{1}}\right)^{p-1} \lim_{p \to 1^{+}} \frac{1}{|\phi_{p}^{s}|_{\infty}^{p-1}} = \lim_{p \to 1^{+}} \frac{1}{|\phi_{p}^{s}|_{\infty}^{p-1}} \leq \lim_{p \to 1^{+}} \lambda_{1,p}^{s}(\Omega).$$

Since $\lim_{p\to 1^+} \lambda_{1,p}(\Omega) = h_s(\Omega)$, we are done.

In [1], the authors also proved that

$$h_s(\Omega) = \inf \left\{ [v]_{s,1}^p : v \in W_0^{s,1}(\Omega), |v|_1 = 1 \right\}.$$

Since $W_0^{s,1}(\Omega)$ is not reflexive, they were able to prove that the minimum $h_s(\Omega)$ is attained on the larger Sobolev space

$$\mathcal{W}_0^{s,1}(\Omega) := \left\{ v \in L^1(\Omega) : \left[v \right]_{s,1}^p < \infty, \ u = 0 \text{ a.e. in } \mathbb{R}^N \setminus \Omega \right\}$$

For completeness, we state the following result on the behavior of the L^1 -normalized family $\left\{\frac{\phi_p^s}{\left|\phi_p^s\right|_1}\right\}$ as $p \to 1$.

It corresponds to [1, Theorem 7.2], which was proved for the family $\left\{\frac{e_p^s}{|e_p^s|_1}\right\}$. Its proof follows the same script and will be omitted.

Theorem 2.3 Let $u_p := \frac{\phi_p^s}{|\phi_p^s|_1}$. There exists a sequence (p_n) such that $p_n \to 1^+$ and $u_{p_n} \to u$ in $L^q(\Omega)$, for every $q < \infty$. The limit function u is a solution of the minimization problem

$$h_s(\Omega) = \min_{v \in \mathcal{W}_0^{s,1}(\Omega)} \left\{ [v]_{s,1} : u \ge 0, \ |u|_1 = 1 \right\}$$

Moreover, $u \in L^{\infty}(\Omega)$ and

$$\frac{1}{|\Omega|} \le |u|_{\infty} \le \frac{1}{|B_1|} \left(\frac{h_s(\Omega)}{h_s(B_1)}\right)^{\frac{N}{s}}.$$
(2.20)

The upper bound that appears in the statement of Theorem 7.2 of [1] is

$$\left[\frac{|B|^{\frac{N-s}{N}}}{P_s(B)}\right]^{\frac{N}{s}}h_s(\Omega)^{\frac{N}{s}}$$

However, it is very simple to check, by applying (2.14), that it is equal to the upper bound in (2.20).

We remark that, once obtained the convergence in $L^q(\Omega)$ stated above, the upper bound in (2.20) follows from (2.19). Indeed, since

$$|u|_{q} = \lim_{n \to \infty} |u_{p_{n}}|_{q} \le |\Omega|^{\frac{1}{q}} \lim_{n \to \infty} |u_{p_{n}}|_{\infty}$$

(2.19) implies that

$$\left|\Omega\right|^{-\frac{1}{q}}\left|u\right|_{q} \le \lim_{n \to \infty} \left|u_{p_{n}}\right|_{\infty} \le \frac{1}{\left|B_{1}\right|} \left(\frac{h_{s}(\Omega)}{h_{s}(B_{1})}\right)^{\frac{n}{s}}$$

Hence, the upper bound in (2.20) follows, since $|u|_{\infty} = \lim_{q \to \infty} |\Omega|^{-\frac{1}{q}} |u|_{q}$.

The lower bound in (2.20), which does not appear in the statement of Theorem 7.2 of [1], follows by taking q = 1, since

$$1 = \lim_{n \to \infty} |u_{p_n}|_1 = |u|_1 \le |u|_{\infty} |\Omega|$$

It is interesting to note that, as it happens with the standard *p*-torsion functions, $|u|_{\infty} = |\Omega|^{-1}$ when Ω is a ball. In fact, in this case (2.14) yields

$$\frac{1}{|B_1|} \left(\frac{h_s(\Omega)}{h_s(B_1)} \right)^{\frac{N}{s}} = \frac{1}{|\Omega|}$$
