# Log ordinarity and log plurigenera of a proper SNCL scheme over a $\log$ point in characterisitic $p>0$ 

Yukiyoshi Nakkajima *


#### Abstract

In this article we give two applications of the spectral sequence of the log HodgeWitt cohomology of a proper SNCL scheme over the log point of a perfect field of characterisitic $p>0$.


## 1 Introduction

This article consists of two parts. One is a criterion of the log ordinarity of a proper SNCL (=simple normal crossing log) scheme over a family of log points in characteristic $p>0$ and the other is the lower semi-continuity of the $\log$ geometric plurigenera and the log Iitaka-Kodaira dimension of a proper SNCL scheme over a log point of any characteristic. Though arithmetic geometers have not yet shown their interest in $\log$ geometric plurigenera and $\log$ Iitaka-Kodaira dimensions, it seems that they are important notions as in the theory of log geometric plurigenera and log Iitaka-Kodaira dimensions for the case of the "horizontal" log structure developed in [ii] and [ii2].

Let $g: Y \longrightarrow T$ be a morphism of fine log schemes in the sense of Fontaine-Illusie-Kato ( $(\underline{\mathrm{K}})$. Let $\Omega_{Y / T}^{\bullet}$ be the log de Rham complex of $Y / T$ (this was denoted by $\omega_{Y / T}^{\bullet}$ in [K] and [HK]. Let $Y$ be the underlying scheme of $Y$. Set $B \Omega_{Y / T}^{i}:=$ $\operatorname{Im}\left(d: \Omega_{Y / T}^{i-1} \longrightarrow \Omega_{Y / T}^{i}\right)\left(B \Omega_{Y / T}^{i}\right.$ is only an abelian sheaf on $\left.\stackrel{\circ}{Y}\right)$. Assume that $T$ is of characteristic $p>0$ and that $g$ is proper and $\log$ smooth. In this article, we say that $g$ (or simply $Y / T$ ) is log ordinary (in the sense of Bloch-Kato-Illusie) if $R^{j} g_{*}\left(B \Omega_{Y / T}^{i}\right)=0$ for any $i, j \in \mathbb{Z}_{\geq 0}$. This is the variation of the log ordinarity defined in [H1, [I2], Nakk1] and [L. (The log ordinarity in [loc. cit.] is the log version of the ordinarity defined in [BK and [IR].)

Let $\kappa$ be a perfect field of characteristic $p>0$. Let $B$ be the spectrum of a (complete) discrete valuation ring of mixed characteristics with perfect residue field $\kappa$. Let $\mathcal{X} / B$ be a proper strict semistable family. Let $X / s$ be the log special fiber of $\mathcal{X} / B$ with canonical $\log$ structure. Let $\mathcal{W} \Omega_{X}^{\bullet}$ be the $\log$ de Rham-Witt complex of $X / s$. Let $k$ be a nonnegative integer. Let ${ }_{X}^{(k)}$ be the disjoint union of the $(k+1)$ fold intersections of the different irreducible components of $\stackrel{\circ}{X}$. In H1 Hyodo has claimed the following theorem without the proof of it in the case where $B$ is of mixed characteristics:

[^0]Theorem $1.1([\mathbf{H 1}],[\mathbf{I l 2}])$. If $\stackrel{\circ}{X}^{(k)} / \kappa$ is ordinary for all $k \in \mathbb{Z}_{\geq 0}$, then $X / s$ is $\log$ ordinary.

This theorem has an important role in several articles, e. g., in RX] (of course in [I12]) by using Illusie's result in [Il2]: the blow up of an ordinary proper smooth subscheme in an ordinary proper smooth scheme is ordinary. Following [Il2, we call this theorem Hyodo's criterion. In I12] Illusie has given a proof of this fact including the case where $B$ is of equal characteristic. He has stated another very simple method to prove Hyodo's criterion under the assumption of the existence of the " $p$-adic weight spectral sequence" of $H^{h}\left(X, \mathcal{W} \Omega_{X}^{i}\right)\left(h, i \in \mathbb{Z}_{\geq 0}\right)$ which is compatible with the operator $F$, which was not constructed at that time. In the special case $i=0$, this is classically well-known (cf. [RZS, §2]): for a proper $\mathrm{SNC}(=$ simple normal crossing) scheme $Z / \kappa$, there exists the following spectral sequence:

E_{1}^{-k, h+k}=H^{h+k}\left(Z^{(-k+1)}, \mathcal{W}\left(\mathcal{O}_{Z^{(-k+1)}}\right)\right) \Longrightarrow H^{h}\left(Z, \mathcal{W}\left(\mathcal{O}_{Z}\right)\right) \quad\left(-k, h \in \mathbb{Z}_{\geq 0}\right) \tag{1.1.1}
\end{equation*}
$$

In the general $i$, the spectral sequence has been already constructed in Nakk3. (cf. Mo ):

Theorem 1.2 ([Nakk3, (4.1.1)]). Let $s$ be the log point of $\kappa$, that is, $s=(\operatorname{Spec}(\kappa), \mathbb{N} \oplus$ $\left.\kappa^{*} \longrightarrow \kappa\right)$. Here $1 \in \mathbb{N}$ goes to $0 \in \kappa$ by the morphism $\mathbb{N} \oplus \kappa^{*} \longrightarrow \kappa$. Let $X /$ s be $a$ proper SNCL scheme defined in Nakk5, (1.1.15)] (cf. Nakk2, (1.1.10.2)]). Let $i$ be $a$ nonnegative fixed integer. Then there exists the following spectral sequence:

E_{1}^{-k, h+k}= & \bigoplus_{j \geq \max \{-k, 0\}} H^{h-i-j}\left(\stackrel{\circ}{X}^{(2 j+k)}, \mathcal{W} \Omega_{X^{(2 j+k)}}^{i-j-k}\right)(-j-k)  \tag{1.2.1}\\
& \Longrightarrow H^{h-i}\left(X, \mathcal{W} \Omega_{X}^{i}\right) \quad(q \in \mathbb{N}) .
\end{align*}
$$

Here $(-j-k)$ means the usual Tate twist with respect to the Frobenius endomorphism of $X$.
(In Nakk3, (4.7)] we have proved that this spectral sequence degenerates at $E_{2}$.) Because this spectral sequence is compatible with the operator $F$, we can prove Hyodo's criterion in a very simple way as follows by following Illusie's idea.

By a fundamental theorem in [IR, a proper smooth scheme $Y / \kappa$ is ordinary if and only if the operator $F$ on $H^{h}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right)$ is bijective. Hence $F$ is bijective on $H^{h-i}\left(X, \mathcal{W} \Omega_{X}^{i}\right)$ by (1.2.1). Furthermore, by the $\log$ version of this fundamental theorem due to Lorenzon ( $\lfloor\boxed{L}]$, this implies that $X / s$ is log ordinary. This is the first proof of Hyodo's criterion in this article. We also give the proof of Hyodo's criterion by following Illusie's original proof in Il2 as possible. This is the second proof of Hyodo's criterion in this article. In this article we simplify his proof and generalize it. We give the three proofs of the following theorem (the variation of Hyodo's criterion):

Theorem 1.3. Let $S$ be a family of log points in characteristic $p>0$ defined in Nakk5, (1.1)]. Let $f: X \longrightarrow S$ be a proper $S N C L$ scheme defined in Nakk5, (1.1.15)]. Let $T \longrightarrow S$ be a morphism of fine log schemes. Set $X_{T}:=X \times{ }_{S} T$ and let $f_{T}: X_{T} \longrightarrow$ $T$ be the base change of $f$. Let $\stackrel{\circ}{X}^{(k)}\left(k \in \mathbb{Z}_{\geq 0}\right)$ be a scheme over $\stackrel{\circ}{S}$ defined in [loc. cit.]. If $\stackrel{\circ}{X}^{(k)} / \stackrel{\circ}{S}$ is ordinary for all $k$, then $f_{T}$ is log ordinary.
In the case $S=s$, the $\stackrel{\circ}{X}^{(k)}$ in (1.3) is equal to the $\stackrel{\circ}{X}^{(k)}$ in (1.1). Hence (1.3) is a generalization of (1.1). In [112] Illusie has defined a nonstandard Poincaré residue
isomorphism for $\Omega_{X / S}^{\bullet}$ in the case $S=s$ and he has used this isomorphism for the proof of (1.1) (see (7.0.1) below for the generalization of his isomorphism). In this article we prefer to use only a standard Poincaré residue isomorphism for $\Omega_{X / S}^{\bullet}$ in [Nakk5, (1.3.14)] when we give the second proof of Hyodo's criterion. The key lemma for the second and the third proofs of (1.3) is the following simple one:

Lemma 1.4 (Key lemma). Let $\theta$ be a global section of $\Omega_{X / S}^{1}$ defined in Nakk5, (1.3)]. Then the following sequence

0 \longrightarrow B \Omega_{X / S}^{i-1} \xrightarrow{\theta \wedge} B \Omega_{X / S}^{i} \longrightarrow B \Omega_{X / S}^{i} \longrightarrow 0 \quad(i \in \mathbb{N})
$$

of $f^{-1}\left(\mathcal{O}_{S}\right)$-modules is exact.
The proof of this lemma is very easy. The second proof of (1.3) consists of the following two steps. By using the assumption in (1.3), the standard Poincaré residue isomorphism for $\Omega_{X / S}^{\bullet}$ and a variant of the $\log$ Cartier isomorphism, we first prove that $R^{j} f_{*}\left(B \Omega_{X / S}^{i}\right)=0$ for $\forall i, j \in \mathbb{N}$. Using induction on $i$, we next see that $R^{j} f_{*}\left(B \Omega_{X / S}^{i}\right)=0\left(\right.$ and $\left.R^{j} f_{T *}\left(B \Omega_{X_{T} / T}^{i}\right)=0\right)$ very immediately.

Let $\mathcal{W} \widetilde{\Omega}_{X}^{\bullet}$ be the log de Rham-Witt complex of $X /_{s}^{\circ}$ in the case $S=s$ defined in (M0) and Nakk3. The third proof of (1.3) uses (1.4) for the case $S=s$ and uses a spectral sequence of $H^{j}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i}\right)$ instead of (1.2.1). (This spectral sequence has been constructed in Nakk5 and it is compatible with the operator F.) The third proof is the shortest one and makes us feel that the proof of (1.3) is obvious if we notice (1.4).

Set $X_{\stackrel{\circ}{T}}:=X \times{ }_{S} \stackrel{\circ}{T}$. By generalizing the second proof of (1.3), we can generalize (1.3) for a certain integrable connection

$$
\nabla: \mathcal{E} \longrightarrow \mathcal{E} \otimes_{\mathcal{O}_{X_{\circ}}} \Omega_{X_{\circ} / T}^{1}
$$

where $\mathcal{E}$ is a flat quasi-coherent $\mathcal{O}_{X_{\mathrm{o}}}$-module such that $\mathcal{E}$ is "locally generated by horizontal sections of $\nabla "$, ( (1.3) is a special case of the generalized theorem for the case where $(\mathcal{E}, \nabla)$ is the usual derivative $d: \mathcal{O}_{X_{\circ}} \longrightarrow \Omega_{X_{\circ} / T}^{1}$.) See (3.4) and (3.18) below for this generalized statement. An example of our $\mathcal{E}^{T}$,s is given in the following way. For a $\log$ scheme $Y$ of characteristic $p>0$, let $F_{Y}: Y \longrightarrow Y$ be the Frobenius
 morphism by $F_{X_{\dot{O}}}$. Let $\mathcal{E}^{\prime}$ be a quasi-coherent $\mathcal{O}_{X_{T}^{[p]} \text {-module. }}$ Set $\mathcal{E}:=F^{*}\left(\mathcal{E}^{\prime}\right)(=$
 of $f^{-1}\left(\mathcal{O}_{T}\right)$-modules. It is easy to check that $\operatorname{id}_{F^{-1}\left(\mathcal{E}^{\prime}\right)} \otimes d$ is an integrable connection on $\mathcal{E}$. The connction $\left(\mathcal{E}, \operatorname{id}_{F^{-1}\left(\mathcal{E}^{\prime}\right)} \otimes d_{X_{\odot} / \stackrel{\circ}{T}}\right)$ is an example of the integrable connection in our mind.

In the second part of this article, we introduce new invariants of a proper SNCL scheme $X$ over the $\log$ point $s$ of $\kappa$ of pure dimension $d$ : the $\log$ (geometric) plurigenera of $X / s$ and the $\log$ Iitaka-Kodaira dimension of it.

Set $p_{g}(X / s, n, 1):=\operatorname{length}_{\mathcal{W}_{n}} H^{0}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right)$. We call this the log geometric genus of $X / s$ of level $n$. By using the finite length version of (1.2.1), we prove the following:

Theorem 1.5. $p_{g}\left(\stackrel{\circ}{X}^{(1)} / \kappa, n, 1\right) \leq p_{g}(X / s, n, 1)$.
We call this inequality the lower semi-continuity of the log geometric genus of $X / s$. This inequality bounds the number of the irreducible components $\stackrel{\circ}{X}_{\lambda}$ 's of $\stackrel{\circ}{X}$ such that $p_{g}\left(\stackrel{\circ}{X}_{\lambda}, n\right) \geq 1$.

More generally, set $p_{g}(X / s, n, r):=\operatorname{length}_{\mathcal{W}_{n}} H^{0}\left(X,\left(\mathcal{W}_{n} \Omega_{X}^{d}\right)^{\otimes r}\right)\left(r \in \mathbb{Z}_{\geq 1}\right)$. We call this the $\log$ (geometric) plurigenus of $X / s$ of level $n$. (In the following, we omit to say the adjective "geometric" in the terminology "log geometric plurigenus".) In the case where the characteristic of the base field of $\kappa$ is 0 , we set $p_{g}(X / s, r):=$ $\operatorname{dim}_{\kappa} H^{0}\left(X,\left(\Omega_{X / s}^{d}\right)^{\otimes r}\right)$ and we also call this the $\log$ plurigenus of $X / s$. We would like to prove the following lower semi-continuity of the $\log$ plurigenus of $X / s$ of level $n$ :
Conjecture 1.6.

$$
\begin{cases}p_{g}\left(\stackrel{\circ}{X}^{(1)} / \kappa, n, r\right) \leq p_{g}(X / s, n, r) & \text { if } \operatorname{ch}(k)=p>0 \\ p_{g}\left(\stackrel{\circ}{\left.X^{(1)} / \kappa, r\right) \leq p_{g}(X / s, r)}\right. & \text { if } \operatorname{ch}(k)=0\end{cases}
$$

It is clear that the finite length version of (1.2.1) itself is not useful for the proof of this lower semi-continuity in the case $r \geq 2$. To prove this, we need a new idea: we construct the following canonical morphism of $\mathcal{W}_{n}\left(\mathcal{O}_{X}\right)$-modules:

\begin{equation*}
\Psi_{X, n, r}: a_{*}\left(\left(\mathcal{W}_{n} \Omega_{X^{(1)}}^{d}\right)^{\otimes r}\right) \longrightarrow\left(\mathcal{W}_{n} \Omega_{X}^{d}\right)^{\otimes r} \quad\left(n, r \in \mathbb{Z}_{\geq 1}\right) \tag{1.6.1}
\end{equation*}
$$

Here $a: \stackrel{\circ}{X}(1) \longrightarrow \stackrel{\circ}{X}$ is the natural morphism. (One may think that this morphism is a strange morphism at first glance.) We prove that $\Psi_{X, 1, r}$ is injective. However we do not know whether $\Psi_{X, n, r}$ is injective for any $n \in \mathbb{Z}_{\geq 2}$. In the case $\operatorname{ch}(\kappa)=0$, we also construct the following canonical morphism of $\mathcal{O}_{X}$-modules:

\begin{equation*}
\Psi_{X, r}: a_{*}\left(\left(\Omega_{X^{(1)}}^{d}\right)^{\otimes r}\right) \longrightarrow\left(\Omega_{X / s}^{d}\right)^{\otimes r} \quad\left(r \in \mathbb{Z}_{\geq 1}\right) \tag{1.6.2}
\end{equation*}
$$

and we prove that this morphism is injective. Consequently we obtain the following:
Theorem 1.7. Let $\kappa$ be a field of any characteristic. Let s be the log point of $\kappa$. Let $X / s$ be a proper $S N C L$ scheme of pure dimension $d$. Let $r$ be a positive integer. Then

$$
\begin{equation*}
p_{g}\left(\stackrel{\circ}{X}^{(1)} / \kappa, 1, r\right) \leq p_{g}(X / s, 1, r) \quad \text { if } \operatorname{ch}(\kappa)=p>0 \tag{1.7.1}
\end{equation*}
$$

and

$$
\begin{equation*}
p_{g}\left(\stackrel{\circ}{X}^{(1)} / \kappa, r\right) \leq p_{g}(X / s, r) \quad \text { if } \operatorname{ch}(\kappa)=0 \tag{1.7.2}
\end{equation*}
$$

We can also construct the obvious analogue of the morphism (1.6.2) for the analytic case and can prove the obvious analogue of the inequality (1.7.1) in this case.

This should be compared with the works of Noboru Nakayama (Nakay1), Siu ([S]) and Hajime Tsuji ([T]) using non-algebraic methods. They have conjectured and H. Tsuji has claimed that the following holds, though he has not given the detail of the proof of the following theorem:
Theorem $1.8([\mathbf{T}])$. Let $\Delta$ be the unit disk. Let $\mathcal{X} \longrightarrow \Delta$ be the analytification of $a$ projective strict semistable family. Let $t$ be an element of $\Delta \backslash\{O\}$. Let $X$ and $\mathcal{X}_{t}$ be the special fiber and the generic fiber of this family, respectively. Then

$$
\begin{equation*}
p_{g}\left(\stackrel{\circ}{X}^{(1)} / \mathbb{C}, r\right) \leq p_{g}\left(\mathcal{X}_{\mathrm{t}} / \mathbb{C}, r\right) \quad\left(r \in \mathbb{Z}_{\geq 1}\right) \tag{1.8.1}
\end{equation*}
$$

An algebraic proof of (1.8) has not been known.
Because the log plurigenera is upper semi-continuous, this implies the smooth deformation invariance of the log plurigenera of a proper smooth algebraic family in the case $\operatorname{ch}(\kappa)=0$. On the other hand, the smooth deformation invariance of the log plurigenera of a proper smooth analytic case does not necessarily hold by Nakam, [Ni] and [U1] and our result for the analytic case.

In the case where the proper or projective SNCL scheme is the log special fiber of a proper or projective strict semifamily over a (complete) discrete valuation ring, we would like to raise the following problem:

Problem 1.9. Let $\mathcal{V}$ be a (complete) discrete valuation ring of mixed characteristics or equal characteristic $p>0$. Let $K$ be the fraction field of $\mathcal{V}$. Let $\mathcal{X} / \mathcal{V}$ be a proper or projective strict semistable family. Let $X / s$ and $\mathcal{X}_{K}$ be the $\log$ special fiber of $\mathcal{X} / B$ and the generic fiber of $\mathcal{X} / B$, respectively. When does the following equality hold?

$$
\begin{equation*}
p_{g}(X / s, n, r)=p_{g}\left(\mathcal{X}_{K} / K, n, r\right) \quad\left(n, r \in \mathbb{Z}_{\geq 1}\right) \tag{1.9.1}
\end{equation*}
$$

We think that nothing nontrivial about (1.9) has been known. In the analytic case, the analogous equality to (1.9.1) does not hold in general by Nakam,

The contents of this article are as follows.
In $\S_{2}$ we prove (1.3) quickly by using (1.2.1). We also prove the analogue of (1.3) for an open log scheme.

In $\S 3$ we prove (1.3) in a similar way to that in [112. However we do not use Illusie's Poincaré residue isomorphism. We simplify his proof by using the Key lemma. In addition, we prove the Hyodo's criterion for the integrable connection $(\mathcal{E}, \nabla)$ as already stated.

In 4 we prove (1.3) without using (1.2.1) nor Illusie's Poincaré residue isomorphism. Instead we use the sheaf $\mathcal{W} \widetilde{\Omega}_{X}^{i}$ in Mo and Nakk3 and a spectral sequence constructed in Nakk5].

In $\$ 5$ we prove the lower semi-continuity of the $\log$ genus by using the finite length version of (1.2.1).

In 86 we prove the lower semi-continuity of the $\log$ plurigenus of level 1 . It is a future problem to show whether the lower semi-continuity of the log plurigenera of level $n$ holds for any $n$.

In $\$ 7$ we generalize Illusie's Poincaré residue isomorphism.
In $\mathbb{C}_{8}$ we give an easy criterion for the quasi- $F$-splitness for an SNCL scheme.
In 99 we give an easy remark about the ordinarity at 0 defined in Nakk6.

Notations. (1) For a complex $\left(\mathcal{F}^{\bullet}, d^{\bullet}\right)$ of sheaves on a topological space, we denote $\operatorname{Ker}\left(d^{i}: \mathcal{F}^{i} \longrightarrow \mathcal{F}^{i+1}\right)$ (resp. $\operatorname{Im}\left(d^{i-1}: \mathcal{F}^{i-1} \longrightarrow \mathcal{F}^{i}\right)$ ) mainly by $Z^{i}\left(\mathcal{F}^{\bullet}\right)$ and sometimes by $Z \mathcal{F}^{i}$ (resp. mainly by $B^{i}\left(\mathcal{F}^{\bullet}\right)$ and sometimes by $B \mathcal{F}^{i}$ ) depending on the length of the letter $\mathcal{F}$.
(2) For a $\log$ scheme $Z$, we denote by $\stackrel{\circ}{Z}$ the underlying scheme of $Z$.

## 2 The first proof of (1.3)

In this section we give the first proof of (1.3) by using the $p$-adic weight spectral (1.2.1) ( Nakk3), cf. MO]). The idea of the proof in this section is Illusie's one ([Il2, Appendice (2.8)]).

Let $\kappa$ be a perfect field of characteristic $p>0$. Let $s$ be a fine log smooth scheme such that ${ }^{\circ}=\operatorname{Spec}(\kappa)$. Let $Y / s$ be a $\log$ smooth scheme of Cartier type. Let $\mathcal{W}_{\star} \Omega_{Y}^{\bullet}$ ( $\star=n \in \mathbb{Z}_{\geq 1}$ or nothing) be the log de Rham-Witt complex defined in [HK, (4.1)]. Let $\mathcal{W}_{n}(Y)$ be the canonical lift of $Y$ over $\mathcal{W}_{n}(\kappa)$. Identify $\mathcal{O}_{\mathcal{W}_{n}(Y)}=\mathcal{W}_{n}\left(\mathcal{O}_{Y}\right)$ with $\mathcal{W}_{n} \Omega_{Y}^{0}$ via the canonical isomorphism $s_{n}: \mathcal{W}_{n}\left(\mathcal{O}_{Y}\right) \xrightarrow{\sim} \mathcal{W}_{n} \Omega_{Y}^{0}$ ([Nakk3, (7.5)]). First let us recall the following result. This is the log version of [II1, I (3.11)] if one forgets the structure of $\mathcal{W}_{n+1}\left(\mathcal{O}_{Y}\right)$-modules of sheaves in (2.1.1) below. A variant of the following will be used in $\mathbb{4}$.

Proposition $2.1\left(\left[\right.\right.$ Nakk6, (3.10)]). Let $F_{\mathcal{W}_{n}(Y)}: \mathcal{W}_{n}(Y) \longrightarrow \mathcal{W}_{n}(Y)$ be the Frobenius endomorphism of $\mathcal{W}_{n}(Y)$. Let $i$ be a nonnegative integer. Let $C^{-1}: \Omega_{Y / s}^{i} \xrightarrow{\sim}$ $F_{Y *}\left(\mathcal{W}_{1} \Omega_{Y}^{i}\right)=F_{Y *}\left(\mathcal{H}^{i}\left(\Omega_{Y / s}^{\bullet}\right)\right)$ be the log inverse Cartier isomorphism due to Kato ( K ). Let $R: \mathcal{W}_{n+1} \Omega_{Y}^{i} \longrightarrow \mathcal{W}_{n} \Omega_{Y}^{i}$ be the projection. Then the following hold:
(1) The following sequence

$$
\begin{equation*}
\mathcal{W}_{n+1} \Omega_{Y}^{i} \xrightarrow{F} F_{\mathcal{W}_{n}(Y) *}\left(\mathcal{W}_{n} \Omega_{Y}^{i}\right) \xrightarrow{F_{\mathcal{W}_{n}(Y) *}\left(F^{n-1} d\right)} B_{n} \mathcal{W}_{1} \Omega_{Y}^{i+1} \longrightarrow 0 \tag{2.1.1}
\end{equation*}
$$

is an exact sequence of $\mathcal{W}_{n+1}\left(\mathcal{O}_{Y}\right)$-modules. Here $B_{n} \mathcal{W}_{1} \Omega_{Y}^{i+1}=C^{-1}\left(B_{n} \Omega_{Y / s}^{i+1}\right)$, where $B_{n} \Omega_{Y / s}^{i+1}$ is an $F_{Y *}^{n}\left(\mathcal{O}_{Y}\right)$-module defined inductively by the following isomorphism $C^{-1}: B_{n} \Omega_{Y / s}^{i+1} \xrightarrow{\sim} B_{n+1} \Omega_{Y / s}^{i+1} / F_{Y *}^{n}\left(B_{1} \Omega_{Y / s}^{i+1}\right)$ and $B_{1} \Omega_{Y / s}^{i+1}:=F_{Y *}\left(d \Omega_{Y / s}^{i}\right)$.
(2) Let $C: B_{n+1} \mathcal{W}_{1} \Omega_{Y}^{i+1} \longrightarrow B_{n} \mathcal{W}_{1} \Omega_{Y}^{i+1}$ be the following composite morphism:

Then the following diagram is commutative:


Proposition 2.2. Let $\kappa$ be a perfect field of characteristic $p>0$. Then (1.3) holds in the case where $S$ is the log point $s$ of $\kappa$.

Proof. By using (2.1.1) and noting that $R: \mathcal{W}_{n+1} \Omega_{Y}^{i} \longrightarrow \mathcal{W}_{n} \Omega_{Y}^{i}$ is surjective, we have the following exact sequence:

0 \longrightarrow \mathcal{W} \Omega_{Y}^{i} \longrightarrow F_{\mathcal{W}\left(\mathcal{O}_{Y}\right) *}\left(\mathcal{W} \Omega_{Y}^{i}\right) \longrightarrow{\underset{n}{n}}_{\lim _{n}} B_{n} \mathcal{W}_{1} \Omega_{Y}^{i+1} \longrightarrow 0
$$

Hence, by the $\log$ version of [IR, IV (4.11.6), (4.13)], $X / s$ is log ordinary if and only if the operator $F: H^{j}\left(X, \mathcal{W} \Omega_{X}^{i}\right) \longrightarrow H^{j}\left(X, \mathcal{W} \Omega_{X}^{i}\right)$ is bijective for any $i$ and $j$. (This has also been obtained in [L, (4.1)].) Let $\left\{E_{1}^{i j}\right\}_{i, j \in \mathbb{Z}}$ be the $E_{1}$-terms of the spectral
sequence (1.2.1). Here we ignore the Tate twist $(-j-k)$. Let $\left(\mathcal{W}_{n} A_{X}^{\bullet \bullet}, P\right)\left(n \in \mathbb{Z}_{\geq 1}\right)$ be the filtterd double complex defined in Nakk3, $\S 2$ ] and denoted by $\left(W_{n} A_{X}^{\bullet \bullet}, P\right)$ (cf. Mo]). By the definition of the operator $F$ and by considering a local log smooth lift $X / s$ over $\mathcal{W}_{n}(s)$, the following two diagrams are commutative:


Because the spectral sequence (1.2.1) is obtained by these commutative diagrams, it is compatible with $F$ 's. By the assumption, the operator $F: E_{1}^{-k, h+k} \longrightarrow E_{1}^{-k, h+k}$ is bijective. Hence the operator $F: H^{j}\left(X, \mathcal{W} \Omega_{X}^{i}\right) \longrightarrow H^{j}\left(X, \mathcal{W} \Omega_{X}^{i}\right)$ is bijective. We complete the proof of (2.2).

Proposition 2.3 ([Il2, Appendice (1.2), (1.9)]). Let $g: Y \longrightarrow T$ be a proper log smooth scheme of fine log schemes. Let $i$ be an integer. Then the following are equivalent:
(1) $R^{j} g_{*}\left(B \Omega_{Y / T}^{i}\right)=0$ for $\forall j \geq 0$.
(2) For any exact closed point $t \in T$ ( $t$ is a closed point of $\stackrel{\circ}{T}$ endowed with the inverse image of the log structure of $T), H^{j}\left(Y_{t}, B \Omega_{Y_{t} / t}^{i}\right)=0$ for $\forall j \geq 0$. Here $Y_{t}:=Y \times_{T} t$.

Proof. Set $Y^{\prime}:=Y \times_{T, F_{T}} T$ and let $F_{Y / T}: Y \longrightarrow Y^{\prime}$ be the relative Frobenius morphism of $Y / T$. Let $g^{\prime}: Y^{\prime} \longrightarrow T$ be the structural morphism. For an exact closed point $t \in T^{\prime}$, let $g_{t}^{\prime}: Y_{t}^{\prime} \longrightarrow t$ be the base change morphism of $g^{\prime}$. Set $B_{1} \Omega_{Y / T}^{i}:=F_{Y / T *}\left(B \Omega_{Y / T}^{i}\right)$. Then $B_{1} \Omega_{Y / T}^{i}$ is an $\mathcal{O}_{Y^{\prime}-\text { module }}$

Because $\stackrel{\circ}{F}_{Y / T}$ is a homeomorphism of topological spaces (SGA 5, XV Proposition $2 \mathrm{a})]$ ), it suffices to prove that the following are equivalent:
(1) $)^{\prime} R^{j} g_{*}^{\prime}\left(B_{1} \Omega_{Y / T}^{i}\right)=0$ for $\forall j \geq 0$.
(2) $)^{\prime}$ For any exact closed point $t \in T, H^{j}\left(Y_{t}^{\prime}, B_{1} \Omega_{Y_{t} / t}^{i}\right)=0$ for $\forall j \geq 0$. By [L, (1.13)] the sheaf $B_{1} \Omega_{Y / T}^{i}(m, i \in \mathbb{N})$ is a locally free sheaf of $\mathcal{O}_{Y^{\prime}-\text { modules of finite }}$ rank. By the log Künneth formula ([K, (6.12)]), we have the following isomorphism

R g_{*}^{\prime}\left(B_{1} \Omega_{Y / T}^{i}\right) \otimes_{\mathcal{O}_{T}}^{L} \kappa_{t} \xrightarrow{\sim} R g_{t *}^{\prime}\left(B_{1} \Omega_{Y_{t} / t}^{i}\right)
$$

The rest of the proof is the same as that of [112, Appendice (1.2), (1.9)]. Indeed, the implication $(2)^{\prime} \Longrightarrow(1)^{\prime}$ follows from the fact that $R g_{*}^{\prime}\left(B_{1} \Omega_{Y / T}^{i}\right)$ is a perfect complex of $\mathcal{O}_{T}$-modules (since $g^{\prime}$ is proper). The implication $(1)^{\prime} \Longrightarrow(2)^{\prime}$ follows from this perfectness and Nakayama's lemma.

We prove (1.3). Let the notations be as in (1.3). Set $S_{\circ}^{\circ}:=S \times_{\stackrel{\circ}{\circ}} \stackrel{\circ}{T}$ and $X_{\circ}:=$ $X \times{ }_{S} S_{\stackrel{\circ}{ }}$. Let $f_{\stackrel{\circ}{ }}: X_{\stackrel{\circ}{ }} \longrightarrow S_{\stackrel{\circ}{\circ}}$ be the structural morphism. Because $B \Omega_{X_{\mathrm{O}}}^{i} / S_{\mathrm{o}}$
commutes with the base change morphism $T \longrightarrow S_{\stackrel{\circ}{ }}([\underline{L},(1.13)])$,

R^{j} f_{T *}\left(B \Omega_{X_{T} / T}^{i}\right)=R^{j} f_{T *}\left(B \Omega_{X_{\mathrm{T}} / S_{\circ}}^{i} \otimes_{\mathcal{O}_{T}} \mathcal{O}_{T}\right)=R^{j} f_{T *}\left(B \Omega_{X_{\mathrm{T}} / S_{\mathrm{T}}}^{i}\right) \tag{2.3.1}
\end{equation*}
$$

(To obtain (2.3.1), one may use a fact that $B \Omega_{X_{\mathrm{C}} / S_{\circ}}^{i}=B \Omega_{X_{T} / T}^{i}\left(\right.$ since $\Omega_{X_{\mathrm{o}} / S_{\circ}}^{j}=$ $\Omega_{X_{T} / T}^{j}$ for $\left.j=i, i+1\right)$.) Hence we may assume that $T=S_{\circ_{T}}$ and in fact, $T=S$. By (2.3) we can assume that $S$ is the log point. Consider the perfection $\kappa^{\mathrm{pf}}$ of $\kappa$ and let $s^{\mathrm{pf}}$ be the $\log$ point whose underlying scheme is $\operatorname{Spec}\left(\kappa^{\mathrm{pf}}\right)$ and whose $\log$ structure is the inverse image of the log structure of $s$ by the natural morphism $\operatorname{Spec}\left(\kappa^{\mathrm{pf}}\right) \longrightarrow$ $\operatorname{Spec}(\kappa)$. Set $X_{s^{\mathrm{pf}}}:=X \times_{s} s^{\mathrm{pf}}$. By (2.2), $H^{j}\left(X_{s^{\mathrm{pf}}}, B \Omega_{X_{s^{\mathrm{pf}}}^{i} / s^{\mathrm{pf}}}\right)=0$ for $\forall i$ and $\forall j$. Because $H^{j}\left(X_{s^{\text {pf }}}, B \Omega_{X_{s \text { pf }} / s^{\text {pf }}}^{i}\right)=H^{j}\left(X, B \Omega_{X / s}^{i}\right) \otimes_{\kappa} \kappa^{\mathrm{pf}}, H^{j}\left(X, B \Omega_{X / s}^{i}\right)=0$. By (2.3), $R^{j} f_{*}\left(B \Omega_{X / S}^{i}\right)=0$ for $\forall i$ and $\forall j$. We complete the proof of (1.3).

We can also obtain the Hyodo's criterion for an open smooth scheme as follows.
Theorem 2.4. Let $S$ be a scheme of characteristic $p>0$. Let $f:(X, D) \longrightarrow S$ be a proper smooth scheme with relative $S N C D([\mathbb{N S},(2.1 .7)])$. Let $D^{(i)}\left(i \in \mathbb{Z}_{\geq 0}\right)$ be a scheme defined in [loc. cit., (2.2.13.2)]. Then if $D^{(i)}$ is ordinary for all $i$, then $f$ is log ordinary.

To prove this theorem, we have only to use the following spectral sequence ( Nakk3, (5.7.1)]):

\end{equation*}

instead of the spectral sequence (1.2.1) in the case $S=\operatorname{Spec}(\kappa)$.
We say that $f$ is log ordinary with compact suppport if $R^{j} f_{*}\left(d \Omega^{i}(-\log D)\right)=0$ for $\forall i, j$. We can also obtain the following theorem:

Theorem 2.5. Let the notations be as in (2.4). If $D^{(i)}$ is ordinary for all $i$, then $f$ is log ordinary with compact suppport.

To prove this theorem, we have only to use the following spectral sequence ( Nakk3, (5.7.2)]):

in the case $S=\operatorname{Spec}(\kappa)$.

## 3 The second proof of (1.3)

In this section we prove (1.3), (2.4) and (2.5) without using the $p$-adic weight spectral sequences (1.2.1), (2.4.1) and (2.5.1), respectively. The proof of (1.3) in this section includes a simplification of the proof of Hyodo's criterion in [II2, Appendice] as already stated in the Introduction: the filtration $P$ on $\Omega_{X / S}^{\bullet}$ induced by the filtration $P$ on $\Omega_{X / S}^{\bullet}$ defined in Nakk5] nor a generalization of the residue map in [loc. cit., (2.1.3)] is unnecessary; we use only the filtration $P$ on $\Omega_{X / S}^{\bullet}$. The filtration $P$ on $\Omega_{X / S}^{\bullet}$. is more directly related with the complex $\Omega_{X^{(j)} / S}^{\bullet}(j \in \mathbb{N})$ than the filtration $P$ on $\Omega_{X / S}^{\bullet}$. From the earlier part of this section, we consider a certain integrable connection without
$\log$ poles including the derivative $d: \mathcal{O}_{X} \longrightarrow \Omega_{X / S}^{1}$. The main result in this section is (3.18) below. This includes (1.3).

Let $S$ be a family of $\log$ points ([Nakk5, (1.1)]) and let $Y / S$ be a $\log$ smooth scheme. Let $g: Y \longrightarrow S$ be the structural morphism. Let $e$ be a local section of $M_{S}$ such that the image of $e$ in $M_{S} / \mathcal{O}_{S}^{*}$ is the local generator. Set $\theta_{S}:=d \log e \in$ $\Omega_{S / S}^{1}$. Then this section is independent of the choice of $e$ and it is globalized. Set $S / S$
$\theta:=g^{*}(d \log e) \in \underset{Y / S}{\Omega^{1}}$. Let $\pi^{\bullet}: \Omega_{Y / S}^{\bullet} \longrightarrow \Omega_{Y / S}^{\bullet}$ be the natural projection. Because $Y / S$ is $\log$ smooth, the following sequence

\begin{equation*}
0 \longrightarrow g^{*}\left(\Omega_{S / \stackrel{\circ}{S}}^{1}\right) \xrightarrow[Y / S]{\Omega_{S}^{1}} \stackrel{\pi^{1}}{\longrightarrow} \Omega_{Y / S}^{1} \longrightarrow 0 \tag{3.0.1}
\end{equation*}
$$

is locally split ([K, (3.12)]). By a very special case of [Nakk5, (1.7.20.1)], the following sequence is exact:

0 \longrightarrow \Omega_{Y / S}^{\bullet}[-1] \xrightarrow{\theta \wedge} \Omega_{Y / S}^{\bullet} \stackrel{\pi^{\bullet}}{\longrightarrow} \Omega_{Y / S}^{\bullet} \longrightarrow 0 \tag{3.0.2}
\end{equation*}
$$

The following lemma is a key lemma which enables us to simplify Illusie's proof for Hyodo's criterion in [112].
Lemma 3.1. For each $i$, the resulting sequences of (3.0.2) by the operations $B^{i}, Z^{i}$ and $\mathcal{H}^{i}\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact.
Proof. We have only to prove that the following sequences are exact:

0 \longrightarrow Z \Omega_{Y / S}^{i-1} \xrightarrow{\theta \wedge} Z \Omega_{Y / S}^{i} \longrightarrow Z \Omega_{Y / S}^{i} \longrightarrow 0 \tag{3.1.2}
\end{equation*}
$$

Because the problem is local, we may assume that there exists a basis $\left\{\theta,\left\{\omega_{i}\right\}_{i=1}^{d}\right\}$ of $\Omega_{Y / \stackrel{\circ}{1}}^{1}$. Then $\left\{\pi^{1}\left(\omega_{i}\right)_{i=1}^{d}\right\}$ is a basis of $\Omega_{Y / S}^{1}$. Let $\iota: \Omega_{Y / S}^{1} \longrightarrow \Omega_{Y / S}^{1}\left(\pi^{1}\left(\omega_{i}\right) \longmapsto \omega_{i}\right)$ be the splitting of the projection $\pi^{1}: \Omega_{Y / S}^{1} \longrightarrow \Omega_{Y / S}^{1}$. Let $\Omega_{Y / S}^{i} \longrightarrow \Omega_{Y / S}^{i}\left(i \in \mathbb{Z}_{\geq 1}\right)$ be the induced splitting by $\iota$ above and denote it by $\iota: \Omega_{Y / S}^{1} \longrightarrow \Omega_{Y / S}^{1}$ again. Then $\Omega_{Y / S}^{i}=\iota\left(\Omega_{Y / S}^{i}\right) \oplus \theta \wedge\left(\Omega_{Y / S}^{i-1}\right)$. Let $d: \Omega_{Y / S}^{i} \longrightarrow \Omega_{Y / S}^{i+1}$ and $d_{Y / S}: \Omega_{Y / S}^{i} \longrightarrow \Omega_{Y / S}^{i+1}$ be the standard differentials. By expressing a local section of $\Omega_{Y / S}^{i}$ by the basis $\left\{\theta,\left\{\omega_{i}\right\}_{i=1}^{d}\right\}$ of $\Omega_{Y / S}^{i}$ (cf. the first proof of (3.3) below), it is obvious that the following diagram is commutative:

\Omega_{Y / S}^{i}=\iota\left(\Omega_{Y / S}^{i}\right) \oplus \theta \wedge\left(\Omega_{Y / S}^{i-1}\right)  \tag{3.1.3}\\

\Omega_{Y / S}^{i+1}= \\
\qquad \iota\left(d_{Y / S}\right) \oplus\left(-\theta \wedge d_{Y / S}\right) \\
=
\end{gather*}

Hence

B \Omega_{Y / S}^{i}=\iota\left(B \Omega_{Y / S}^{i}\right) \oplus \theta \wedge\left(B \Omega_{Y / S}^{i-1}\right)
$$

and

Z \Omega_{Y / S}^{i}=\iota\left(Z \Omega_{Y / S}^{i}\right) \oplus \theta \wedge\left(Z \Omega_{Y / S}^{i-1}\right)
$$

This implies that the sequences (3.1.1) and (3.1.2) are exact. We complete the proof of (3.1).

More generally, let $\mathcal{E}$ be a quasi-coherent $\mathcal{O}_{Y}$-module and let

be the induced integrable connection by $\nabla$. Then we have the following morphism of complexes of $g^{-1}\left(\mathcal{O}_{S}\right)$-modules:

which induces the following morphism of complexes of $g^{-1}\left(\mathcal{O}_{S}\right)$-modules:

Indeed, because we have the following equalities

= & \nabla(e) \wedge \theta \wedge \omega+\theta \wedge \nabla(e) \wedge \omega=0 \\
& \left(e \in \mathcal{E}, \omega \in \Omega_{Y / S}^{i}(i \in \mathbb{N})\right)
\end{align*}
$$

$\nabla \theta \wedge=\theta \wedge(-\nabla)$. Because the exact sequence (3.0.2) is locally split, the following sequence of complexes of $g^{-1}\left(\mathcal{O}_{S}\right)$-modules is exact:

Definition 3.2. We say that $\mathcal{E}$ is locally generated by horizontal sections of $\nabla$ if there exist local sections $e_{0}, \ldots, e_{m}(m \in \mathbb{N})$ which generate $\mathcal{E}$ locally as an $\mathcal{O}_{Y}$-module such that $\nabla\left(e_{j}\right)=0$ for $0 \leq \forall j \leq m$. We say that the set $\left\{e_{j}\right\}_{j=0}^{m}$ a set of local horizontal generators of $\mathcal{E}$.

We can generalize (3.1) as follows:
Lemma 3.3. Assume that $\mathcal{E}$ is locally generated by horizontal sections. Then, for each $i$, the resulting sequences of (3.1.9) by the operations $B^{i}, Z^{i}$ and $\mathcal{H}^{i}\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact.

Proof. First we give the elementary and direct two proof of this lemma. Later we give another proof it when $Y / S$ is of Cartier type and $(\mathcal{E}, \nabla)$ is a certain connection (see (3.6) below).

We claim that the following sequences are exact:

& 0 \longrightarrow B^{i-1}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \xrightarrow{\theta \wedge} B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow 0  \tag{3.3.1}\\
& 0 \longrightarrow Z^{i-1}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \xrightarrow{\theta \wedge} Z^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow Z^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow 0 \tag{3.3.2}
\end{align*}
$$

The problem is local. We give the two proofs of the exactness of (3.3.1).
The first proof:
Let $M_{Y}$ be the log structure of $Y$. Because the problem, we can fix a set $\left\{e_{j}\right\}_{j=0}^{d}$ of horizontal generators of $\mathcal{E}$ and fix a base $\left\{\theta, \omega_{1}, \ldots, \omega_{d}\right\}$ of $\Omega_{Y / S}^{1}\left(\omega_{i}=d \log m_{i}\right.$ for some $\left.m_{i} \in M_{Y}\right)$. For a nonnegative integer $k$, set $\mathcal{P}_{k}:=\{I \subset\{1, \ldots, d\} \mid \sharp I=k\}$. For a nonnegative integer $k$ and an element $I:=\left\{i_{1}, \ldots, i_{k}\right\} \in \mathcal{P}_{k}$, set $\omega_{I}:=\omega_{i_{1}} \wedge \cdots \wedge \omega_{i_{k}}$, where $i_{1}<\cdots<i_{k}$. For an empty set $\phi$, set $\omega_{\phi}=1 \in \mathcal{O}_{Y}$. Any local section $e$ of $\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{i-1}$ can be expressed as follows:

\nabla(e)=\sum_{j=0}^{m}\left\{e_{j} \otimes\left(\sum_{I \in \mathcal{P}_{i-1}} d f_{I} \wedge \omega_{I}+\sum_{J \in \mathcal{P}_{i-2}} d g_{J} \wedge \theta \wedge \omega_{J}\right)\right\}
$$

Hence the following diagram is commutative:

& \nabla \downarrow \downarrow\left(\nabla_{Y / S}\right) \oplus\left(\theta \wedge \nabla_{Y / S}\right)  \tag{3.3.3}\\
& \mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{i+1}=\left\{\iota\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{i+1}\right)\right\} \oplus\left\{\theta \wedge\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{i}\right)\right\} .
\end{align*}

Consequently

B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right. & =\iota\left(B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right)\right) \oplus \theta \wedge\left(B^{i-1}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right)\right) \\
Z^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / \stackrel{\circ}{S}}^{\bullet}\right) & =\iota\left(Z^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right)\right) \oplus \theta \wedge\left(Z^{i-1}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right)\right)
\end{aligned}
$$

This implies that the sequences (3.3.1) and (3.3.2) are exact.
The second proof in the case where $\mathcal{E}$ is a flat quasi-coherent $\mathcal{O}_{Y}$-module:
Here we give the exactness of only (3.3.1). We can prove the exactness of (3.3.2) similarly. It suffices to prove that

To prove the inclusion (3.3.4), by the assumption we have only to prove that the following inclusion holds:

Because $\mathcal{E}$ is a flat $\mathcal{O}_{Y}$-module, it suffices to prove that

By taking a local basis $\left\{\omega_{1}, \ldots, \omega_{d}, \theta\right\}$ of $\Omega_{Y / S_{S}^{1}}^{1}$, by describing a local section of $\Omega_{Y /{ }^{i-1}}^{i}$ with the use of this basis and by noting that $d \theta=0$, (3.3.6) is an obvious inclusion. We complete the first proof of (3.3).

Definition 3.4. Let $h: Z \longrightarrow T$ be a proper $\log$ smooth morphism of fine $\log$ schemes. Let $\nabla: \mathcal{M} \longrightarrow \mathcal{M} \otimes_{\mathcal{O}_{Y}} \Omega_{Z / T}^{1}$ be an integrable connection. We say that the connection $\nabla$ is log ordinary if $R^{j} h_{*}\left(B^{i}\left(\mathcal{M} \otimes_{\mathcal{O}_{Z}} \Omega_{Z / T}^{\bullet}\right)\right)=0$ for $\forall i, j \in \mathbb{N}$. If $\nabla$ is the derivative $d: \mathcal{O}_{Z} \longrightarrow \Omega_{Z / T}^{1}$ and if $d$ is log ordinary in the sense above, then we say that $h$ or $Z / T$ is $\log$ ordinary.

The following is a first step of the proof of Hyodo's criterion for the case of an integrable connection.

Corollary 3.5. Assume that $\mathcal{E}$ is locally generated by horizontal sections. The connection (3.1.5) is log ordinary if and only if $R^{j} g_{*}\left(B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right)\right)=0$ for $\forall i$ and $\forall j$.

Proof. The implication $\Longrightarrow$ follows from (3.3). The converse implication also follows from the exact sequence (3.3.1) and induction on $i$.

Remark 3.6. (1) If $\mathcal{E}$ is not locally generated by horizontal sections of $\nabla$, (3.3.1) is not necessarily exact. Indeed, consider the case $i=0$ and consider a log scheme $Y$ whose underlying scheme is $\operatorname{Spec}(\kappa[x, y] /(x y))$ and whose $\log$ structure is associated to a morphism $\mathbb{N}^{2} \longrightarrow \kappa[x, y] /(x y)$ defined by $(1,0) \longmapsto x$ and $(0,1) \longmapsto y$. The diagonal immersion $\mathbb{N} \longrightarrow \mathbb{N}^{2}$ induces a morphism $Y \longrightarrow s$ of $\log$ schemes. Let $\mathcal{E}$ be a free $\mathcal{O}_{Y}$-module of rank 1 with basis $e$. Let $\nabla: \mathcal{E} \longrightarrow \mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{1}$. be an integrable connection defined by the following equalities: $\nabla(e)=e \otimes \theta, \nabla(f e)=f \nabla(e)+e \otimes d f$ $\left(f \in \mathcal{O}_{Y}\right)$. Then $\nabla_{Y / S}(e)=0$. Hence the sequence (3.3.1) for $i=1$ is not exact.
(2) We give the third proof of (3.3) in the following case.

Assume that $Y / S$ is of Cartier type. Set $Y^{\prime}:=Y \times_{S, F_{S}} S$. Let $F: Y \longrightarrow Y^{\prime}$ be the relative Frobenius morphism over $S$. Let $\mathcal{E}^{\prime}$ be a quasi-coherent flat $\mathcal{O}_{Y^{\prime}}$-module. Set $(\mathcal{E}, \nabla):=\left(F^{*}\left(\mathcal{E}^{\prime}\right), \operatorname{id}_{\mathcal{E}^{\prime}} \otimes d\right)$. Here $d: \mathcal{O}_{Y} \longrightarrow \Omega_{Y / S}^{1}$ ois the usual derivative. It is obvious that $\mathcal{E}$ is locally generated by horizontal sections of $\nabla$. By a special case of [02, V (4.1.1)] and by [01, (1.2.5)], there exists a morphism

\end{equation*}

of $\mathcal{O}_{Y^{\prime}}$-modules fitting into the following commutative diagram:


Note that $C^{-1}(\theta)=\theta$. Hence the morphism (3.6.1) is an isomorphism. By [SGA 5, XV Proposition 2 a) $], \stackrel{\circ}{F}$ is a homeomorphism. Hence the following sequence

$$

is exact. Using induction on $i$, we see that the following sequences are exact:

0 \longrightarrow B^{i-1}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \xrightarrow{\theta \wedge} B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{\bullet}\right) \longrightarrow 0 .

We complete the second proof of (3.3) in the case above.
Let $Z$ be a fine $\log$ (formal) scheme over a fine $\log$ (formal) scheme $T$. Let $g: Z \longrightarrow$ $\stackrel{\circ}{T}$ be the structural morphism. Let us recall the increasing filtration $P$ on the sheaf $\Omega_{Z / \overparen{T}}^{i}(i \in \mathbb{N})$ of $\log$ differential forms on $Z_{\text {zar }}($ Nakk5, (1.3.0.1)], cf. [Nakk4, (4.0.2)]):

In Nakk5 we have called this filtration $P$ the preweight filtration on $\Omega_{Z / T}^{\bullet}$. For a flat quasi-coherent $\mathcal{O}_{Z}$-module $\mathcal{F}$, set

That is, $\nabla$ is a morphism of $g^{-1}\left(\mathcal{O}_{T}\right)$-modules, $\nabla(a \omega)=$ $\omega \otimes d a+a \nabla(\omega)\left(a \in \mathcal{O}_{Z}, \omega \in \mathcal{F}\right)$ and the iteration of $\nabla: \nabla^{2}: \mathcal{F} \longrightarrow \mathcal{F} \otimes \mathcal{O}_{Z} P_{0} \Omega_{Z / T}^{2}$ is zero. By abuse of notation, we denote the induced morphism $\mathcal{F} \longrightarrow \mathcal{F} \otimes_{\mathcal{O}_{Z}} \Omega^{1}{ }_{Z / \Gamma}$ by (3.6.4) also by

be the induced integrable connection by (3.6.5). Then we have complexes $\mathcal{F} \otimes_{\mathcal{O}_{Z}} \Omega^{\bullet}{ }_{Z / T}^{\circ}$ and $\mathcal{F} \otimes_{\mathcal{O}_{Z}} \Omega_{Z / T}^{\bullet}$. Set

By (3.6.4) we indeed the complex $P_{k}\left(\mathcal{F} \otimes_{\mathcal{O}_{Z}} \Omega_{Z / \stackrel{\circ}{T}}^{\bullet}\right)$. Consequently we have a filtered complex $\left(\mathcal{F} \otimes_{\mathcal{O}_{Z}} \Omega_{Z / \stackrel{\circ}{\bullet}}^{\bullet}, P\right)$ of $g^{-1}\left(\mathcal{O}_{T}\right)$-modules.

Remark 3.7. Though $Z / \stackrel{\circ}{T}$ is not necessarily $\log$ smooth, let us define a sheaf $R_{Z / \stackrel{\circ}{T}}$ on $\stackrel{\circ}{Z}$ as $\operatorname{Coker}\left(\Omega_{\stackrel{\circ}{\circ} / \stackrel{\circ}{T}}^{1} \longrightarrow \Omega_{Z / \stackrel{\circ}{T}}^{1}\right)$ following [O1, (1.3.0.1)]. Let $\mathcal{F}^{\prime}$ be a quasi-coherent $\mathcal{O}_{Z}$-module. Then it is obvious that an integrable connection

\nabla: \mathcal{F}^{\prime} \longrightarrow \mathcal{F}^{\prime} \otimes_{\mathcal{O}_{Z}} \Omega_{Z / \overparen{T}}^{1} \tag{3.7.1}

induces a connection (3.6.4) if and only if the induced morphism

by (3.7.1) is zero.
Let $h: Z \longrightarrow W$ be a morphism of $\log$ schemes over $\stackrel{\circ}{T}$. Let $\mathcal{G}$ be a flat quasicoherent $\mathcal{O}_{W}$-module and let

be an integrable connection fitting into the following commutative diagram


Then we have the following morphism of filtered complexes:

Now let $X$ be an SNCL scheme over $S$. Let $\left\{\stackrel{\circ}{X}_{\lambda}\right\}_{\lambda \in \Lambda}$ be a decomposition of $\stackrel{\circ}{X}$ by smooth components of $\stackrel{\circ}{X}$ over $\stackrel{\circ}{S}\left(\right.$ Nakk5, (1.1.8)]). Then the set $\left\{\stackrel{\circ}{X}_{\lambda}\right\}_{\lambda \in \Lambda}$ gives the orientation sheaf $\varpi_{\mathrm{zar}}^{(k)}(\stackrel{\circ}{X} / \stackrel{\circ}{S})(k \in \mathbb{N})$ as in [NS, p. 81] ([Nakk5, (1.1)]). Let $f: X \longrightarrow S$ and $\stackrel{\circ}{f}^{(k)}: \stackrel{\circ}{X}(k) \longrightarrow \stackrel{\circ}{S}$ be the structural morphisms. For a nonnegative integer $k$, set

For a negative integer $k$, set $\stackrel{\circ}{X^{(k)}}=\emptyset$. In [Nakk5, (1.1.11)] we have proved that $\stackrel{\circ}{X}^{(k)}$ is independent of the choice of the set $\left\{\stackrel{\circ}{X}_{\lambda}\right\}_{\lambda \in \Lambda}$. Denote the natural local closed immersion $\stackrel{\circ}{X}_{\lambda_{0} \cdots \lambda_{k}} \xrightarrow{\subset} \stackrel{\circ}{X}$ by $a_{\lambda_{0} \cdots \lambda_{k}}$. Let $a^{(k)}: \stackrel{\circ}{X}^{(k)} \longrightarrow \stackrel{\circ}{X}(k \in \mathbb{N})$ be the morphism induced by the $a_{\lambda_{0} \cdots \lambda_{k}}$ 's.

The following Poincaré residue isomorphism is a special case of [Nakk5, (1.3.14)]:
Proposition 3.8. Let $x$ be an exact closed point of $X$. Let $r$ be a nonnegative integer such that $M_{X, x} / \mathcal{O}_{X, x}^{*} \simeq \mathbb{N}^{r}$. Consequently the morphism $F_{*} \mathcal{H}^{i}\left(P_{0}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right) \longrightarrow F_{*} \mathcal{H}^{i}\left(P_{1}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}}\right.\right.$ $\left.\Omega_{X / S}^{\bullet}\right)$ ) is injective for $\forall i$. Consequently the upper horizontal sequence is exact. By SGA 5, XV Proposition 2 a)], $\stackrel{\circ}{F}$ is a homeomorphism. Hence the following sequence $0 \longrightarrow \mathcal{H}^{i}\left(P_{0}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right) \longrightarrow \mathcal{H}^{i}\left(P_{1}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right) \longrightarrow \mathcal{H}^{i}\left(\operatorname{gr}_{1}^{P}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right) \longrightarrow 0$

Then the following hold:
(1) (a) and (b) are equivalent.
(2) (b) implies (c).
(3) (c) and (d) are equivalent.

Consequently (a) implies (d).
Proof. (1): Let us prove the implication $(\mathrm{a}) \Longrightarrow(\mathrm{b})$. of $\mathcal{W}_{n}\left(\mathcal{O}_{Y}\right)^{\star}$-modules, which is the inverse of $\check{F}^{r}$. The morphism $\check{C}^{r}$ satisfies a relation $\mathbf{p}^{r} \circ \check{C}^{r}=\check{V}^{r}$. In particular, there exist the following isomorphisms

\end{equation*}

and

\end{equation*}

of $\mathcal{W}_{n}\left(\mathcal{O}_{Y}\right)^{\star}$-modules, which are the inverse of another.
Proposition 3.21. There exist morphisms (3.11.3) and (3.11.5) satisfying I, II, III and IV for the case $\mathcal{E}=\mathcal{F}=E_{1}$.

Proof. We define an isomorphism

$$

This composite morphism preserve the filtration $P$. Because $\check{F}$ is the induced morphism by "id", the commutativity of the diagrams (3.11.7) and (3.11.8) are obvious.

In the rest of this section, we give the open analogue of (3.18).
Lemma 3.22. Let the notations be as in (2.4). Let $\mathcal{E}$ be a quasi-coherent flat $\mathcal{O}_{X^{-}}$ module. Let $\nabla: \mathcal{E} \longrightarrow \mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{(X, D) / S}^{1}$ be an integrable connection. (Note that $\left.\Omega_{(X, D) / S}^{1}=\Omega_{X / S}^{1}(\log D)\right)$. For $k \in \mathbb{Z}_{\geq 0}$, let $D^{(k)}$ be the closed subscheme of $X$ defined in [NS, (2.2.13.2)] and let $a^{(k)}: D^{(k)} \longrightarrow X$ be the natural morphism. Assume that $\mathcal{E}$ is locally generated by horizontal sections of $\nabla$. Set $P_{k}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{(X, D) / S}^{\bullet}\right):=$ $\mathcal{E} \otimes_{\mathcal{O}_{X}} P_{k} \Omega_{(X, D) / S}^{\bullet}$. Set

\Omega_{k}^{i}(\mathcal{E}):=a_{*}^{(k)}\left(a^{(k) *}(\mathcal{E}) \otimes_{\mathcal{O}_{D^{(k)}}} \Omega_{D^{(k)} / S}^{i} \otimes_{\mathbb{Z}} \varpi_{\mathrm{zar}}^{(k)}(D / S)\right) \quad\left(k \in \mathbb{Z}_{\geq 0}\right)
$$

for each $i$. Then the following hold:
(1) There exists the following Poincaré residue isomorphism of complexes:

of complexes of $f^{-1}\left(\mathcal{O}_{S}\right)$-modules is exact.
Proof. (1): By [NS, (2.2.21.3)] we have the following Poincaré residue isomorphism:

(3.22.1) immediately follows from this isomorphism.
(2): By [DI, (4.2.2) (a), (c)] the sequence (3.22.2) for the case $\mathcal{E}=\mathcal{O}_{X}$ is exact. Now we see that the sequence (3.22.2) for the general case is exact.

Definition 3.23. We say that $(\mathcal{E}, \nabla)$ is $\log$ ordinary with compactly support if $R^{j} f_{*}\left(B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{(X, D) / S}^{\bullet}(-D)\right)\right)=0$ for any $i \in \mathbb{Z}_{\geq 0}$ and $j \in \mathbb{Z}_{\geq 0}$.

The following (1) is the open analogue of (3.18).
Theorem 3.24. Let the notations be as in (2.4). Let $F:(X, D) \longrightarrow\left(X^{\prime}, D^{\prime}\right)$ be the relative Frobenius morphism over $S$. Let $\mathcal{E}^{\prime}$ be a quasi-coherent $\mathcal{O}_{X^{\prime}}$-module. For $k \in \mathbb{Z}_{\geq 0}$, let $a^{\prime(k)}: D^{\prime(k)} \longrightarrow X^{\prime}$ be the natural morphism. Set

for each $i$. Assume that the following two conditions (I) and (II) are satisfied:
(I): There exists an isomorphism

Then the following hold:
(1) If $a^{(k) *}(\mathcal{E}, \nabla)$ for $\forall k \in \mathbb{N}$ is ordinary, then $(\mathcal{E}, \nabla)$ is log ordinary.
(2) If $a^{(k) *}(\mathcal{E}, \nabla)$ for $\forall k \in \mathbb{N}$ is ordinary, then $(\mathcal{E}, \nabla)$ is log ordinary with compact support.

Proof. (1): Because the proof of (1) by using (3.22) (1) is easier than that of (3.18), we leave the detail of the proof to the reader.
(2): Because the proof of (2) by using (3.22) (2) is easier than that of (3.18), we leave the detail of the proof to the reader.

## 4 The third proof of (1.3)

In this section we give the proof of (1.3) without using the $p$-adic weight spectral sequence (1.2.1) nor the filtration $P$ on $\Omega_{X / S}^{\bullet}$. Instead we use the $p$-adic weight spectral sequence for $\mathcal{W} \widetilde{\Omega}_{X}^{i}$ in the case $S=s$. To obtain this spectral sequence, we use the filtration $P$ on $\mathcal{W} \widetilde{\Omega}_{X}^{i}$.

First assume that $S=s$. Then we have proved the following in Nakk5 as a very special case of [Nakk5, (2.3.37)].

Theorem 4.1. Let $i$ be a nonnegative integer. Set

$$

Then there exists the following spectral sequence

The spectral sequences (4.1.1) and (4.1.2) are compatible with the operator $F$.
Proposition $4.2([\mathbf{N a k k 6}, ~(3.4)])$. The obvious analogue of (2.1) holds for $\mathcal{W} \widetilde{\Omega}_{X}^{i}$.
Now we give the third proof of (1.3) as follows.
First assume that $S=s$. By (4.1) the operator $F: H^{j}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i}\right) \longrightarrow H^{j}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i}\right)$ is bijective for any $i$ and $j$. By (4.2) the operator $F: H^{j}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i}\right) \longrightarrow H^{j}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i}\right)$ is bijective for any $i$ and $j$ if and only if $H^{j}\left(X, B \mathcal{W} \widetilde{\Omega}_{X}^{i}\right)=0$ (cf. [IR, IV (4.13)]). Let $R$ be the Cartier-Dieudonné-Raynaud algebra of $\kappa\left([\right.$ IR $)$. Set $R_{n}:=R /\left(V^{n} R+d V^{n} R\right)$. Then the following three facts hold by [Nakk3, (6.21.1), (6.16.1), (6.27)]:
(i) $\operatorname{Im}\left(F^{n}: \mathcal{W}_{2 n} \widetilde{\Omega}_{X}^{i} \longrightarrow \mathcal{W}_{n} \widetilde{\Omega}_{X}^{i}\right)=\operatorname{Ker}\left(d: \mathcal{W}_{n} \widetilde{\Omega}_{X}^{i} \longrightarrow \mathcal{W}_{n} \widetilde{\Omega}_{X}^{i}\right)$,
(ii) $d^{-1}\left(p^{n} \mathcal{W} \widetilde{\Omega}_{X}^{i+1}\right)=F^{n} \mathcal{W} \widetilde{\Omega}_{X}^{i}$,
(iii) $R_{n} \otimes_{R} \mathcal{W} \widetilde{\Omega}_{X}^{\bullet}=\mathcal{W}_{n} \widetilde{\Omega}_{X}^{\bullet}$.

As noted in the proof of [ L , (4.1)] (for the case $\mathcal{W}_{n} \Omega_{Y}^{\bullet}$ for a log smooth scheme over a fine $\log$ scheme $Y$ whose underlying scheme is $\operatorname{Spec}(\kappa))$, these imply that the following sequence

& \longrightarrow\left(V^{n}\right)^{-1} F^{n} H^{j+1}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i-1}\right) / F^{n} H^{j+1}\left(X, \mathcal{W} \widetilde{\Omega}_{X}^{i-1}\right) \longrightarrow 0
\end{aligned}
$$

is exact by the argument of the log version of [IR, IV (4.13)]. Hence $H^{j}\left(X, B \mathcal{W}_{n} \widetilde{\Omega}_{X}^{i}\right)=$ 0 for any $i, j$ and $n$. In particular, $H^{j}\left(X, B \mathcal{W}_{1} \widetilde{\Omega}_{X}^{i}\right)=0$ for any $i$ and $j$. This is equivalent to the vanishing of $H^{j}\left(X, B \Omega_{X / s}^{i}\right)=0$. By (3.3), $H^{j}\left(X, B \Omega_{X / s}^{i}\right)=0$ for any $i$ and $j$.

In the case of the general $S$, the rest of the proof is the same as the proof after (2.3).

Let $n$ be a positive integer. Let $Y / s$ be a $\log$ smooth scheme. By [Nakk5, (2.2.3.1)] we have the following exact sequence:

Proposition 4.3. For each $i$, the resulting sequences of (4.2.1) by the operations $B^{i}$, $Z^{i}$ and $\mathcal{H}^{i},\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact. Consequently the resulting sequences of (4.2.2) by the operations $B^{i}, Z^{i}$ and $\mathcal{H}^{i}\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact.

Proof. This is a local problem. We may assume that there exists a log smooth lift $\mathcal{Y}$ of $Y$ over $\mathcal{W}_{2 n}(s)$. Because we have the following commutative diagram

we have the following commutative diagram of exact sequences:

& B \mathcal{H}^{i}\left(\Omega_{\mathcal{X} / \mathcal{W}_{n}}^{\bullet}\right)=\iota\left(B \mathcal{H}^{i}\left(\Omega_{\mathcal{X} / \mathcal{W}_{n}(s)}^{\bullet}\right)\right) \oplus \theta \wedge\left(B \mathcal{H}^{i-1}\left(\Omega_{\mathcal{X} / \mathcal{W}_{n}(s)}^{\bullet}\right)\right)
\end{aligned}
$$

and

## 5 Lower semi-continuity of log genera

In this section we give applications of the finite length version of the spectral sequence (1.2.1). This has been proved in (Nakk3:

Theorem $5.1([\mathbf{N a k k 3},(4.1 .1 ; \mathbf{n})])$. Let $i$ be a nonnegative fixed integer. Then there exists the following spectral sequence:

& \Longrightarrow H^{h-i}\left(X, \mathcal{W}_{n} \Omega_{X}^{i}\right) \quad(h \in \mathbb{N})
\end{align*}
$$

Let $X$ be a proper $\log$ smooth scheme over $s$ of pure dimension $d$. Let $K_{0}$ be the fraction field of $\mathcal{W}$. Let $(\mathcal{T}, \mathcal{A})$ be a ringed topos. For an $\mathcal{A}$-module $\mathcal{F}$ of $\mathcal{T}$ and for a positive integer $r$, denote $\underbrace{\mathcal{F} \otimes_{\mathcal{A}} \cdots \otimes_{\mathcal{A}} \mathcal{F}}_{r \text { pieces }}$ by $\stackrel{r}{\mathcal{A}}_{\stackrel{r}{\otimes} \mathcal{F}}$.

Definition 5.2. (1) (cf. [ii2, §11.2]) We call

p_{g}(X / s, n, r):=\operatorname{length}_{\mathcal{W}_{n}}\left(H^{0}\left(X, \underset{\mathcal{W}_{n}\left(\mathcal{O}_{X}\right)}{\stackrel{r}{\otimes}} \mathcal{W}_{n} \Omega_{X}^{d}\right)\right) \tag{5.2.1}
\end{equation*}
$$

the $\log$ plurigenus of $X / s$ of level $n$. When $n=1$, we call $p_{g}(X / s, n, r)$ the $\log$ plurigenus of $X / s$. When $r=1$, we call $p_{g}(X / s, n, r)$ the $\log$ genus of $X / s$ of level $n$. When $r=1$ and $n=1$, we call $p_{g}(X / s, n, r)$ the log genus of $X / s$.
(2) (the "vertical" log version of the Iitaka-Kodaira dimension defined in [ii] and [Ii2, $\S 10.5, \S 11.2])$ Set

\kappa(X / s, n):=\varlimsup_{r \longrightarrow \infty} \frac{\log p_{g}(X, n, r)}{\log r} .
$$

We call $\kappa(X / s, n)$ the log Iitaka-Kodaira dimension of $X / s$ of level $n$. We call $\kappa(X / s, 1)$ the $\log$ Iitaka-Kodaira dimension of $X / s$ and we denote it by $\kappa(X / s)$.
(3) We call

p_{g}(X / \mathcal{W}(s), r):=\operatorname{rank}_{\mathcal{W}}\left(H^{0}\left(X, \underset{\mathcal{W}\left(\mathcal{O}_{X}\right)}{\stackrel{r}{\otimes}} \mathcal{W} \Omega_{X}^{d}\right)\right) \tag{5.2.2}
\end{equation*}
$$

the log Witt plurigenus of $X / s$. When $r=1$, we call $p_{g}(X / \mathcal{W}(s), r)$ the log Witt genus of $X / s$.
(4) Set

$$
\kappa(X / \mathcal{W}(s)):=\varlimsup_{r \longrightarrow \infty} \frac{\log p_{g}(X, \infty, r)}{\log r}
$$

We call $\kappa(X / \mathcal{W}(s))$ the log Witt-Iitaka-Kodaira dimension of $X / \mathcal{W}(s)$.
First we check that $p_{g}(X / \mathcal{W}(s), r) \neq \infty$. To prove this, we recall the following:
Proposition 5.3 ([Nakk6, (3.10)]). Let $t$ be a fine log scheme whose underlying scheme is $\operatorname{Spec}(\kappa)$. Let $Z / t$ be a log smooth scheme of Cartier type. Let $F_{\mathcal{W}_{n}(Z)}: \mathcal{W}_{n}(Z) \longrightarrow$ $\mathcal{W}_{n}(Z)$ be the Frobenius endomorphism of $\mathcal{W}_{n}(Z)$. Then the following hold:
(1) The following sequence

F_{\mathcal{W}_{n}(Z) *}\left(\mathcal{W}_{n} \Omega_{Z}^{i}\right) \xrightarrow{V} \mathcal{W}_{n+1} \Omega_{Z}^{i} \xrightarrow{F^{n}} Z_{n} \mathcal{W}_{1} \Omega_{Z}^{i} \longrightarrow 0 \tag{5.3.1}
\end{equation*}
$$

is an exact sequence of $\mathcal{W}_{n+1}\left(\mathcal{O}_{Z}\right)^{\prime}$-modules.
(2) The following sequence

$$
\begin{equation*}
\mathcal{W}_{n+1} \Omega_{Z}^{i} \xrightarrow{F} F_{\mathcal{W}_{n}(Z) *}\left(\mathcal{W}_{n} \Omega_{Z}^{i}\right) \xrightarrow{F_{\mathcal{W}_{n}(Z) *\left(F^{n-1} d\right)}} B_{n} \mathcal{W}_{1} \Omega_{Z}^{i+1} \longrightarrow 0 \tag{5.3.2}
\end{equation*}
$$

is an exact sequence of $\mathcal{W}_{n+1}\left(\mathcal{O}_{Z}\right)^{\prime}$-modules.
The following is a log version of [II1, II (2.16)]:
Corollary 5.4. Let $i, j$ be nonnegative integers. If $\operatorname{dim}_{\kappa} H^{j}\left(Y, Z_{n} \Omega_{Y / t}^{i}\right)\left(n \in \mathbb{Z}_{\geq 0}\right)$ is bounded, then $\operatorname{dim}_{\kappa} H^{j}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right) / V H^{j}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right)<\infty$. Furthermore, $\operatorname{dim}_{\kappa} H^{j}\left(Y, B_{n} \Omega_{Y / t}^{i+1}\right)$ $\left(n \in \mathbb{Z}_{\geq 0}\right)$ is bounded, then $H^{j}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right) / V H^{j}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right)$ is a finitely generated $\mathcal{W}$ module.
Proof. The proof is the same as that of [II1, II (2.16)] by using (5.3).
Corollary 5.5. Let $i$ be a nonnegative integer. Then $H^{0}\left(Y, \mathcal{W} \Omega_{Y}^{i}\right)$ is a free $\mathcal{W}$-module of finite type.
Proof. The proof is the same as that of [II1, II (2.17)] by using (5.4).
Consider the spectral sequence (5.1.1) for the case $i=d$ :

Let $\Gamma(\stackrel{\circ}{X})$ be the dual graph of the simple normal crossing vareity $\stackrel{\circ}{X} / \kappa$.

Theorem 5.6. (1) The following inequalities hold:

& p_{g}\left(\stackrel{\circ}{X}^{(0)} / \kappa, n, 1\right) \leq p_{g}(X / s, n, 1) \leq p_{g}\left(\stackrel{\circ}{X}^{(0)} / \kappa, n, 1\right)+\sum_{k=1}^{d} \operatorname{length}_{\mathcal{W}_{n}} \operatorname{Ker}\left(H^{0}\left(\stackrel{\circ}{X}^{(k)}, \mathcal{W}_{n} \Omega_{\stackrel{\circ}{(k)}}^{d-k}\right)(-k)\right.  \tag{5.6.1}\\
& \left.\longrightarrow H^{1}\left(\stackrel{\circ}{X}^{(k-1)}, \mathcal{W}_{n} \Omega_{\stackrel{\circ}{X^{(k-1)}}}^{\stackrel{(k+1}{(1)}}\right)(-k+1)\right) \\
& \leq \sum_{s=0}^{d} p_{g}\left(\stackrel{\circ}{X}^{(s)} / \kappa, n, 1\right) . \\
& \text { (2) Let } n \text { be a positive integer. If } \operatorname{dim} \stackrel{\circ}{X}=1 \text {, then } p_{g}(X / s, n, 1)=p_{g}\left(\stackrel{\circ}{X}^{(0)} / \kappa, n, 1\right)+ \\
& \operatorname{length}_{\mathcal{W}_{n}}\left(H^{1}\left(\Gamma(\stackrel{\circ}{X}), \mathcal{W}_{n}\right)\right) \text {. }
\end{align*}
$$

(3) Let $n$ be a positive integer. Set

\Psi^{1}(\stackrel{\circ}{X}, n):=\operatorname{length}_{\mathcal{W}_{n}} \operatorname{Coker}\left(H^{1}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n}\left(\mathcal{O}_{X^{(0)}}\right)\right) \longrightarrow H^{1}\left(\stackrel{\circ}{X}^{(1)}, \mathcal{W}_{n}\left(\mathcal{O}_{X^{(1)}}\right)\right)\right)
$$

If $\operatorname{dim} \stackrel{\circ}{X}=2$ and if the boundary map $d_{2}^{-2,4}: E_{2}^{-2,4} \longrightarrow E_{2}^{0,3}$ of (5.5.1) is zero, then the following formula holds:

p_{g}(X / s, n, 1)=p_{g}\left(\stackrel{\circ}{X}^{(0)} / \kappa, n, 1\right)+\Psi^{1}(\stackrel{\circ}{X}, n)+\operatorname{length}_{\mathcal{W}_{n}}\left(H^{2}\left(\Gamma(\stackrel{\circ}{X}), \mathcal{W}_{n}\right)\right)
$$

Proof. (1): Let $\left\{E_{\infty}^{-k, k+d}\right\}_{k \in \mathbb{Z}_{\geq 0}}$ be the set of the $E_{\infty}$-terms of the spectral sequence (5.5.1). It is clear that $p_{g}(X / s, n, 1)=\sum_{k=0}^{d} \operatorname{length}_{\mathcal{W}_{n}}\left(E_{\infty}^{-k, d+k}\right)$. Because $\operatorname{dim} \stackrel{\circ}{X}^{(2 j+k)}=d-(2 j+k)$, the non-vanishing term $H^{h-d-j}\left({ }_{X}^{(2 j+k)}, \mathcal{W}_{n} \Omega_{\stackrel{\circ}{(2 j+k)}}^{d-j-k}\right)(-j-$ $k$ ) can arise only in the case $d-(2 j+k) \geq d-j-k$. This inequality implies that $j=0$. Hence the spectral sequence (5.5.1) is equal to the following spectral sequence

E_{1}^{-k, h+k}=H^{h-d}\left(\stackrel{\circ}{X}^{(k)}, \mathcal{W}_{n} \Omega_{X^{(k)}}^{d-k}\right)(-k) \Longrightarrow H^{h-d}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right) \quad(h \in \mathbb{N}) \tag{5.6.2}
\end{equation*}
$$

If $k<0$ or $h<d$, then $E_{1}^{-k, h+k}=0$. Hence $E_{\infty}^{-k, d+k}(k \geq 0)$ is a submodule of

E_{2}^{-k, d+k}=\operatorname{Ker}\left(H^{0}\left(\stackrel{\circ}{X^{(k)}}, \mathcal{W}_{n} \Omega_{X^{(k)}}^{d-k}\right)(-k) \longrightarrow H^{1}\left(\stackrel{\circ}{X^{(k-1)}}, \mathcal{W}_{n} \Omega_{\stackrel{\circ}{(k-1)}}^{d-k+1}\right)(-k+1)\right) \tag{5.6.3}
\end{equation*}
$$

Furthermore, $E_{\infty}^{0, d}=E_{1}^{0, d}=H^{0}\left({ }_{( }^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right)$. Hence the following natural morphism

\begin{equation*}
H^{0}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right) \longrightarrow H^{0}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right) \tag{5.6.4}
\end{equation*}
$$

is surjective. In conclusion, we obtain the inequalities in (5.6.1).
(2): By (5.6.2) we have the following exact sequence

& \longrightarrow \operatorname{Ker}\left(H^{0}\left(X^{(1)}, \mathcal{W}_{n} \mathcal{O}_{X^{(1)}}\right)(-1) \longrightarrow H^{1}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{1}\right)\right) \longrightarrow 0
\end{aligned}
$$

The boundary morphism $H^{0}\left(X^{(1)}, \mathcal{W}_{n} \mathcal{O}_{X^{(1)}}\right)(-1) \longrightarrow H^{1}\left(X^{(0)}, \mathcal{W}_{n} \Omega_{\dot{\circ}}^{1}{ }^{(0)}\right)$ is the Čech Gysin morphism ([M0, 4.9]). Note that $H^{0}\left(X^{(1)}, \mathcal{W}_{n} \mathcal{O}_{X^{(1)}}\right)=H_{\text {crys }}^{0}\left(X^{(1)} / \mathcal{W}_{n}\right)$ and $H^{1}\left({ }^{\circ}{ }^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{1}\right)=H_{\text {crys }}^{2}\left({ }^{(0)} / \mathcal{W}_{n}\right)$. Hence
$\operatorname{Ker}\left(H^{0}\left(X^{(1)}, \mathcal{W}_{n} \mathcal{O}_{X^{(1)}}\right)(-1) \longrightarrow H^{1}\left({ }^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{1}\right)\right)=H^{1}\left(\Gamma\left(\stackrel{\circ}{X}^{\prime}\right), \mathcal{W}_{n}\right)(-1)$
(cf. [loc. cit. 5.3]). Thus we can complete the proof of (1).
(3): Because $\operatorname{dim}{ }^{\circ}=2$, we obtain the following equalities:

& E_{1}^{0,2}=H^{0}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{2}\right), \quad E_{1}^{-1,3}=H^{0}\left(\stackrel{\circ}{X}^{(1)}, \mathcal{W}_{n} \Omega_{X^{(1)}}^{1}\right)(-1), \\
& E_{1}^{0,3}=H^{1}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n} \Omega_{\dot{X}^{(0)}}^{2}\right), \quad E_{1}^{-2,4}=H^{0}\left(\stackrel{\circ}{X}^{(2)}, \mathcal{W}_{n}\left(\mathcal{O}_{X^{(2)}}\right)\right)(-2), \\
& E_{1}^{-1,4}=H^{1}\left(\stackrel{( }{X}^{(1)}, \mathcal{W}_{n} \Omega_{\dot{X}^{(1)}}^{1}\right)(-1), \quad E_{1}^{0,4}=H^{2}\left(\stackrel{\circ}{X}^{(0)}, \mathcal{W}_{n} \Omega_{\dot{X}^{(0)}}^{2}\right) .
\end{aligned}
$$

The other $E_{1}$-terms of (5.6.2) are zero. Hence $E_{\infty}^{-1,3}=E_{2}^{-1,3}$. By the assumption, $E_{\infty}^{-2,4}=E_{2}^{-2,4}=H^{2}\left(\Gamma(\stackrel{\circ}{X}), \mathcal{W}_{n}\right)(-2)$. By the duality of Ekedahl (Ek, (2.2.23)]), $E_{2}^{-1,3}$ is the dual of $\operatorname{Coker}\left(H^{1}\left(X^{(0)}, \mathcal{W}_{n}\left(\mathcal{O}_{X^{(0)}}\right)\right) \longrightarrow H^{1}\left(X^{(1)}, \mathcal{W}_{n}\left(\mathcal{O}_{X^{(1)}}\right)\right)\right)$. Hence (3) follows.

Corollary 5.7. The natural morphism

is surjective. In particular,

\end{equation*}
$$

Proof. Set $K_{n}:=\operatorname{Ker}\left(H^{0}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right) \longrightarrow H^{0}\left(\dot{X}^{(0)}, \mathcal{W}_{n} \Omega_{\dot{X^{(0)}}}^{d}\right)\right)$. By the surjectivity of the morphism (5.6.4), we obtain the following exact sequence

0 \longrightarrow K_{n} \longrightarrow H^{0}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right) \longrightarrow H^{0}\left(\dot{X}^{(0)}, \mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right) \longrightarrow 0 \tag{5.7.3}
\end{equation*}
$$

of $\mathcal{W}_{n}$-modules. Because $H^{0}\left(X, \mathcal{W}_{n} \Omega_{X}^{d}\right)$ is an artrinian $\mathcal{W}_{n}$-modules, so is $K_{n}$, and hence the projective system $\left\{K_{n}\right\}_{n=1}^{\infty}$ satisfies the Mittag-Leffler condition. Hence the following sequence $0 \longrightarrow \lim _{\ddagger} K_{n} \longrightarrow H^{0}\left(X, \mathcal{W} \Omega_{X}^{d}\right) \longrightarrow H^{0}\left({ }_{( }^{(0)}, \mathcal{W} \Omega_{\dot{X}(0)}^{d}\right) \longrightarrow 0$ is exact.

Remark 5.8. (1) As in (5.6), even if $\kappa$ is any field of any characteristic, there is the following spectral sequence of abelian groups

$$
E_{1}^{-k, h+k}=H^{h-d}\left(X^{(k+1)}, \Omega_{X^{(k+1)} / \kappa}^{d-k}\right) \Longrightarrow H^{h-d}\left(X, \Omega_{X / \kappa}^{d}\right) .
$$

Thus $p_{g}(X / s, 1,1)=\sum_{k=0}^{d} \operatorname{dim}_{\kappa} E_{\infty}^{-k, k+d}$. In particular, the inequalities (5.6.1) for the case $n=1$ holds.
(2) Assume that $\stackrel{\circ}{s}=\operatorname{Spec}(\mathbb{C})$ and that $X / s$ is a proper log analytic SNCL space. Let $i$ be a nonnegative fixed integer. Then we have the following spectral sequence by using the Poincaré residue isomorphism (cf. (3.8.1)):

& \Longrightarrow H^{h-i}\left(X, \Omega_{X / s}^{i}\right) \quad(h \in \mathbb{N})
\end{align*}
$$

Here $(-j-k)$ is the usual Tate twist. Assume that each irreducible components of $\stackrel{\circ}{X}$ is Kähler or the analytification of a proper scheme over $\mathbb{C}$. By using theory of mixed Hodge structures in ([D1], [D2]) and by [FN, this spectral sequence degenerates at $E_{2}$. In particular, the following equality holds:

p_{g}(X / s, 1)=p_{g}\left(\stackrel{\circ}{X}^{(0)} / \mathbb{C}, 1\right)+\sum_{k=1}^{d} \operatorname{dim}_{\mathbb{C}} \operatorname{Ker} & \left(H^{0}\left(\stackrel{\circ}{X}^{(k)}, \Omega_{\stackrel{\circ}{(k)}}^{d-k}\right)(-k)\right.  \tag{5.8.2}\\
& \longrightarrow H^{1}\left(\stackrel{\circ}{X}_{(k-1)}^{\left.\left(k-\Omega_{\dot{X}(k-1)}^{d-k+1}\right)(-k+1)\right)}\right.
\end{align*}
$$

Using the Lefschetz' principle, we obtain the following:
Corollary 5.9. Assume that the characteristic of the base field $\kappa$ is 0 . Let $X / s$ be $a$ proper $S N C L$ scheme. Then

p_{g}(X / s, 1)=p_{g}\left(\stackrel{\circ}{X}^{(0)} / \kappa, 1\right)+\sum_{k=1}^{d} \operatorname{dim}_{\kappa} \operatorname{Ker} & \left(H^{0}\left(\stackrel{\circ}{X^{(k)}}, \Omega_{\stackrel{X^{(k)}}{d-k}}^{\operatorname{don}}\right)\right.  \tag{5.9.1}\\
& \longrightarrow H^{1}\left(\stackrel{\circ}{X}_{(k-1)}^{\left(\Omega_{\stackrel{\circ}{(k-1)}}^{d-k+1}\right)}\right)
\end{align*}
$$

Corollary 5.10. Let the notations be as in (5.6). Set $d:=\operatorname{dim} \stackrel{\circ}{X}$. Let $\stackrel{\circ}{X}_{\lambda}$ be an irreducible component of $\stackrel{\circ}{X}$. Assume that the spectral sequence (5.6.2) for the case $n=1$ degenerates at $E_{2}$. Then, if $p_{g}(X / s, 1,1)=1$ and if $H^{d}(\Gamma(\stackrel{\circ}{X}), \kappa) \neq 0$, then $p_{g}\left(\stackrel{\circ}{X}_{\lambda}, 1,1\right)=0$ and $H^{d}(\Gamma(\stackrel{\circ}{X}), \kappa) \simeq \kappa$.
Proof. Consider the spectral sequence (5.6.1). By (5.6.3),

## 6 Lower semi-continuity of log plurigenera

Let $\left\{\stackrel{\circ}{X}_{i}\right\}_{i \in I}$ be a finite set of the irreducible component of $\stackrel{\circ}{X}$. Next we would like to prove that the following inequality

holds. However, for general $n$, I have not been able to prove this inequality. What I have been able to prove is (6.0.1) only in the case $n=1$ for the case $r \geq 2$ (see (6.3) below). Even in the case $n=1$, because we do not know whether the following induced morphism by (5.6.4)

is surjective for general $r \geq 2$, we need a new argument to prove this inequality. Let $r$ be a positive integer. Set $a:=a^{(0)}: \stackrel{\circ}{X}^{(0)} \longrightarrow \stackrel{\circ}{X}$. Let $n$ be a positive integer or nothing. The key for the proof of this inequality is to construct the following morphism and to prove that it is injective:

Proof. For the time being, we do not assume that $n=1$. Let $\stackrel{\circ}{X}_{i}$ be an irreducible component of $\stackrel{\circ}{X}$. Let $X_{\mathrm{sm}}$ be the smooth locus of $\stackrel{\circ}{X} / \kappa$. We claim that the morphism (6.1.1) is an isomorphism on the nonsingular points $X_{\mathrm{sm}}$ of $\stackrel{\circ}{X}$. We may assume that there is a local isomorphism $X_{\mathrm{sm}} \simeq \operatorname{Spec} \kappa\left[t, x_{1}, \ldots, x_{d}\right] /(t)$ and we have a local admissible lift $\overline{\mathcal{X}}:=\operatorname{Spec} \mathcal{W}\left[t, x_{1}, \ldots, x_{d}\right]$ of $X_{\mathrm{sm}}$ over $\mathcal{W}[t]$. Set $\mathcal{X}_{n}:=\overline{\mathcal{X}} \times_{\mathcal{W}[t]} \mathcal{W}_{n}$. Then $\theta \in \mathcal{W}_{n} \widetilde{\Omega}_{X}^{1}=\mathcal{H}^{0}\left(\Omega_{\mathcal{X}_{n}}\right)$ is the class $[d \log t]$ of $d \log t$. The inverse of the Poincaré residue isomorphism $a_{*}\left(\mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right) \xrightarrow{\simeq} \operatorname{gr}_{1}^{P} \mathcal{W}_{n} \tilde{\Omega}_{X}^{d+1}$ is defined by $\omega \longmapsto \omega[d \log t]$. Because $\left.a_{*}\left(\mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right)\right|_{X_{\mathrm{sm}}}=\mathcal{W}_{n} \Omega_{X_{\mathrm{sm}}}^{d}=\left.\mathcal{W}_{n} \Omega_{X}^{d}\right|_{X_{\mathrm{sm}}}$, the restriction of (6.1.1) to $X_{\mathrm{sm}}$ is equal to the identity $\operatorname{id}_{\mathcal{W}_{n} \Omega_{X_{\mathrm{sm}}}^{d}}$. Thus we have proved that our claim holds.

In the rest of this section, we give the compatibility with fundamental operators. (This may be useful for checking whether $\Psi_{X, n, r}$ is injective.)

(2): The proof of (2) is similar to that of (1).

To state the contravariant functoriality, let us recall the following:

Proposition 6.8 ([ Nakk4, (4.3)]). Let $g: Y \longrightarrow Y^{\prime}$ be a morphism of fs $\log$ (formal) schemes satisfying the condition

for any point $y$ of $\stackrel{\circ}{Z}$ and for some $r \in \mathbb{N}$ depending on $y$. Let $b^{\star(k)}: \stackrel{\circ}{D}^{(k)}\left(M_{Y^{\star}}\right) \longrightarrow \stackrel{\circ}{Y^{\star}}$ $(k \in \mathbb{Z})\left(\star=\right.$ nothing or $\left.{ }^{\prime}\right)$ be the morphism defined before [Nakk4, (4.3)]. Assume that, for each point $y \in \stackrel{\circ}{Y}$ and for each member $m$ of the minimal generators of $M_{Y, y} / \mathcal{O}_{Y, y}^{*}$, there exists a unique member $m^{\prime}$ of the minimal generators of $M_{Y^{\prime}, \dot{g}(y)} / \mathcal{O}_{Y^{\prime}, \dot{g}(y)}^{*}$ such that $g^{*}\left(m^{\prime}\right) \in m^{\mathbb{Z}}{ }^{>0}$. Then there exists a canonical morphism $\stackrel{\circ}{g}^{(k)}: \stackrel{\circ}{D}^{(k)}\left(M_{Y}\right) \longrightarrow$ $\stackrel{\circ}{D}^{(k)}\left(M_{Y^{\prime}}\right)$ fitting into the following commutative diagram of schemes:


The following has been proved in [Nakk5, (1.3.20)] (cf. [Nakk4, (4.8)]):
Proposition 6.9 (The contravariant functoriality of the Poincaré residue morphism). Let $S$ be as above and let $u: S \longrightarrow S^{\prime}$ be a morphism of family of log points. Let $X^{\prime} / S^{\prime}$ be an $S N C L$ scheme. Let $X^{\prime} \xrightarrow{\subset} \mathcal{P}^{\prime}$ be an immersion into a log smooth scheme over $S^{\prime}$ fitting into the following commutative diagram over the morphism $S \longrightarrow S^{\prime}:$


Let $\mathcal{P}^{\text {ex }}$ and $\mathcal{P}^{\prime \text { ex }}$ be the exactification of the immersions $X \xrightarrow{\subset} \mathcal{P}$ and $X^{\prime} \xrightarrow{\subset} \mathcal{P}^{\prime}$, respectively. Let $g^{\mathrm{ex}}: \mathcal{P}^{\mathrm{ex}} \longrightarrow \mathcal{P}^{\prime \text { ex }}$ be the induced morphism by $g$. Let $a^{\prime(k)}: \stackrel{\circ}{X}^{\prime(k)} \longrightarrow$ $\stackrel{\circ}{X}^{\prime}(k \in \mathbb{N})$ be the natural morphism of schemes over $\stackrel{\circ}{S_{0}^{\prime}}$. Assume that, for each point $x \in \stackrel{\circ}{\mathcal{P}}^{\mathrm{ex}}$ and for each member $m$ of the minimal generators of $M_{\mathcal{P}^{\mathrm{ex}}, x} / \mathcal{O}_{\mathcal{P}^{\mathrm{ex}}, x}^{*}$, there exists a unique member $m^{\prime}$ of the minimal generators of $M_{\mathcal{P}^{\prime \mathrm{ex}}, g(x)} / \mathcal{O}_{\mathcal{P}^{\prime \text { ex }}, g(x)}^{*}$ such that $g^{*}\left(m^{\prime}\right)=m$ and such that the image of the other minimal generators of $M_{\mathcal{P}^{\prime \text { ex }}, g(x)} / \mathcal{O}_{\mathcal{P}^{\prime \text { ex }}, \stackrel{\circ}{g}(x)}^{*}$ by $g^{*}$ are the trivial element of $M_{\mathcal{P}^{\text {ex }}, x} / \mathcal{O}_{\mathcal{P}^{\text {ex }}, x}^{*}$. Let $a^{\prime(k)}: \stackrel{\circ}{X}^{\prime(k)} \longrightarrow$ $\stackrel{\circ}{X}^{\prime}$ be an analogous morphism to $a^{(k)}$ for $X^{\prime}$. Then the following diagram is commutative:

& {a^{\prime}}^{\prime(k-1)}\left(\Omega_{\stackrel{\mathcal{P}^{\prime} \text { ex },(k-1)}{\bullet} / \stackrel{\circ}{S}^{\prime}} \otimes_{\mathbb{Z}} \varpi_{\mathrm{zar}}^{(k-1)}\left(\stackrel{\circ}{X^{\prime}} / \stackrel{\circ}{S_{0}^{\prime}}\right)\{-k\}\right) .
\end{aligned}
$$

Proposition 6.10. Let $s \longrightarrow t$ be a morphism of the log points of perfect fields of characteristic $p>0$. Let $Y / t$ is a proper $S N C L$ scheme and let $b: \stackrel{\circ}{Y}^{(0)} \longrightarrow \stackrel{\circ}{Y}$ be an analogue of $a: \stackrel{\circ}{X}{ }^{(0)} \longrightarrow \stackrel{\circ}{X}$. Let $g: X \longrightarrow Y$ be a morphism of log schemes satisfying the assumption in (6.8). Then the following diagram is commutative:

& g_{*} a_{*}\left(\underset{\mathcal{W}_{n}\left(\mathcal{O}_{\mathcal{X}^{(0)}}\right)}{\stackrel{r}{8}} \mathcal{W}_{n} \Omega_{X^{(0)}}^{d}\right) \xrightarrow{g_{*}\left(\Psi_{X, n, r}\right)} g_{*}\left(\stackrel{r}{\mathcal{W}_{n}\left(\mathcal{O}_{X}\right)} \mathcal{W}_{n} \Omega_{X}^{d}\right) \tag{6.10.1}
\end{align*}
$$

Proof. This immediately follows from the following functoriality of the Poincaré residue isomorphism.

## 7 Generalization of Illusie's Poincaré residue isomorphism

Let the notations be as in the beginning of 93 . Especially let $\mathcal{E}$ be a locally generated by horizontal sections of $\nabla: \mathcal{E} \longrightarrow \mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}$, satisfying the conditions (I) $\sim($ IV $)$. Set

$$

In this section we generalize Illusie's Poincaré residue isomorphism in Il2, Appendix (2.2)]. That is, we prove that there exists the following isomorphism:

\end{equation*}

We also generalize [Il2, Appendice (2.6)]. First we begin with the following proposition:

Proposition 7.1 (cf. [Il2, p. 399]). Let $Y / S$ be as in the beginning of \$3, Let $\mathcal{G}$ be a flat quasi-coherent $\mathcal{O}_{Y}$-module. Then the following morphism

of $\mathcal{O}_{Y}$-modules is strictly compatible with $P$ 's in the following sense: for nonnegative integers $i$ and $k$,

(\theta \wedge)\left(\mathcal{G} \otimes \otimes_{\mathcal{O}_{Y}} \underset{Y / \stackrel{\circ}{\circ}}{\Omega^{i-1}}\right) \cap P_{k}\left(\mathcal{G} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / \stackrel{\circ}{i}}^{i}\right)=(\theta \wedge)\left(P_{k-1}\left(\mathcal{G} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / \stackrel{\circ}{i-1}}^{i-1}\right)\right) \tag{7.1.2}
\end{equation*}
$$

Proof. It suffices to prove the inclusion " $\subset$ " in (7.1.2). The problem is local. Let $m_{1}, \ldots, m_{r}$ be local sections of $M_{Y}$ such that $\left\{\theta, d \log m_{1}, \ldots, d \log m_{r}\right\}$ is a local basis of $\Omega_{Y / S}^{1}$ over $\mathcal{O}_{Y}$. Let $\omega$ be a local section of $\Omega_{Y / S}^{i-1}$ such that $\theta \wedge \omega \in P_{k} \Omega_{Y / S}^{i}$. Express $\omega=\theta \wedge \eta+\omega^{\prime}$, where $\omega^{\prime} \notin(\theta \wedge)\left(\begin{array}{c}\Omega_{Y / S}^{i-1}\end{array}\right)$ and $\eta \in \Omega_{Y / \stackrel{\circ}{S}}^{i-1}$. Then $\theta \wedge \omega=\theta \wedge \omega^{\prime}$. Because $\theta \wedge \omega^{\prime} \in P_{k} \Omega_{Y / S}^{i}$ and $\omega^{\prime} \notin(\theta \wedge)\left(\Omega_{Y / S}^{i-1}\right), \omega^{\prime} \in P_{k-1} \Omega_{Y / S}^{i}$. . Hence we obtain the following equality:

of $\mathcal{O}_{Y}$-modules is exact. Because $\mathcal{G}$ is a flat $\mathcal{O}_{Y}$-module, the following sequence
$0 \longrightarrow \mathcal{G} \otimes \mathcal{O}_{Y} P_{k-1} \Omega_{Y / S}^{i-1} \xrightarrow{\theta \wedge} \mathcal{G} \otimes \mathcal{O}_{Y} \Omega_{Y / S}^{i} \longrightarrow \mathcal{G} \otimes_{\mathcal{O}_{Y}}\left[\Omega_{Y / S}^{i} /\left((\theta \wedge)\left(\Omega_{Y / S}^{i-1}\right) \cap P_{k}\left(\Omega_{Y / S}^{i}\right)\right)\right] \longrightarrow 0$
is exact. Because

$$
\mathcal{G} \otimes_{\mathcal{O}_{Y}}\left((\theta \wedge)\left(\Omega_{Y / S}^{i-1}\right) \cap P_{k}\left(\Omega_{Y / S}^{i}\right)\right)=(\theta \wedge)\left(\mathcal{G} \otimes_{\mathcal{O}_{Y}} \Omega_{Y / S}^{i-1}\right) \cap\left(\mathcal{G} \otimes_{\mathcal{O}_{Y}} P_{k} \Omega_{Y / S}^{i}\right),
$$

the exact sequence (7.1.4) implies the equality (7.1.2).
Corollary 7.2. Let $k$ be an integer. The following sequences

P_{k-1}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / \stackrel{\circ}{\bullet}}^{\bullet}\right)[-1] \xrightarrow{\theta \wedge} P_{k}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right) \longrightarrow P_{k}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right) \longrightarrow 0 \tag{7.2.1}
\end{equation*}
$$

$$
\begin{equation*}
0 \longrightarrow P_{k-1}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)[-1] \xrightarrow{\theta \wedge} P_{k}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right) \longrightarrow P_{k}\left(\mathcal{G} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right) \longrightarrow 0 \tag{7.2.2}
\end{equation*}
$$

of complexes of $f^{-1}\left(\mathcal{O}_{S}\right)$-modules are exact.
Proposition 7.3. For each $i$, the resulting sequences of (7.2.2) by the operations $Z^{i}$, $B^{i}$ and $\mathcal{H}^{i}\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact.
Proof. The analogous proof to the first proof of (3.3) works.
Proposition 7.4 (cf. [Il2, Appendice (2.2)]). There exists the isomorphism (7.0.1).
Proof. First assume that $k=0$. Then $\operatorname{gr}_{0}^{P}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)=P_{0}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)=$ $P_{0}\left(\mathcal{E} \otimes \mathcal{O}_{X} \Omega_{X / S}^{\bullet}\right)=K_{0}^{\bullet}(\mathcal{E})$.

Next assume that $k \geq 1$. By (7.2.2) we see that the following upper sequence

\text { Res, } \simeq \downarrow \\
\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{k-2}^{\bullet-(k-1)}(\mathcal{E})[-1] \xrightarrow{\operatorname{Res}^{(k-1) *}, \simeq} \\
\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{k-1}^{\bullet-k}(\mathcal{E})
\end{gather*}
$$

is exact. Because the sequence (3.10.1) is exact,

\operatorname{gr}_{k}^{P}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)=\operatorname{Coker}\left(\iota^{(k-1) *}: \Omega_{k-2}^{\bullet-(k-1)}(\mathcal{E})[-1] \longrightarrow \Omega_{k-1}^{\bullet-k}(\mathcal{E})\right)=K_{k}^{\bullet-k}(\mathcal{E})
$$

Definition 7.5. We call the isomorphism (7.0.1) the relative Poincaré residue isomorphism of $\mathcal{E}$ for $X / S$. This is a generalization of [II2, Appendice (2.1.4)]. (Note that we do not need the local description of the isomorphism (7.0.1) unlike in [loc. cit.] to obtain the isomorphism (7.0.1).)

Proposition 7.6. (cf. [Il2, Appendice (2.5)]) The resulting sequences of the following sequence by the operations $\mathcal{H}^{i}, B^{i}$ and $Z^{i}\left(i \in \mathbb{Z}_{\geq 0}\right)$ are exact:

Proof. The proof is the same as that of (3.12).
Proposition 7.7. Let $\mathcal{F}$ be as in $\S 3$, The isomorphism $C^{-1}: \mathcal{F} \otimes_{\mathcal{O}_{X^{\prime}}} \Omega_{X^{\prime} / S^{[p]}} \xrightarrow{\sim}$ $F_{*} \mathcal{H}^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)$ induce the following isomorphism

C^{-1}: \mathcal{F} \otimes_{\mathcal{O}_{X^{\prime}}} P_{k} \Omega_{X^{\prime} / S}^{i} \xrightarrow{\sim} F_{*} \mathcal{H}^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} P_{k} \Omega_{X / S}^{\bullet}\right) \quad(i, k \in \mathbb{N}) \tag{7.7.1}
\end{equation*}
$$

Proof. By (7.2.1) and induction on $k$, we obtain (7.7).
Proposition 7.8 (cf. [Il2, Appendice (2.6)]). Consider the following conditions:
(a) $R^{j} f_{*}\left(B^{i} K_{k}^{\bullet}(\mathcal{E})\right)=0$ for $\forall i, \forall j, \forall n$.
(b) $R^{j} f_{*}\left(B^{i} \Omega_{k}^{\bullet}(\mathcal{E})\right)=0$ for $\forall i, \forall j, \forall n$.
(c) $R^{j} f_{*}\left(B^{i} \operatorname{gr}_{k}^{P}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right)=0$ for $\forall i, \forall j, \forall k$.
(d) $R^{j} f_{*}\left(B^{i}\left(P_{k}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right)\right)=0$ and $R^{j} f_{*}\left(B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right)=0$ for $\forall i, \forall j, \forall k$.
(e) $R^{j} f_{*}\left(B^{i}\left(P_{k}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right)\right)=0$ and $R^{j} f_{*}\left(B^{i}\left(\mathcal{E} \otimes_{\mathcal{O}_{X}} \Omega_{X / S}^{\bullet}\right)\right)=0$ for $\forall i, \forall j, \forall k$.

Then the following hold:
(1) (a), (b) and (c) are equivalent.
(2) (c), (d) and (e) are equivalent.
(Consequently (a), (b), (c), (d) and (e) are equivalent.)
Proof. (1): (1) follows from (3.12), (7.3) and (7.4).
(2): Set $T:=S$ or $\stackrel{\circ}{S}$. Note that the sheaf is the associated sheaf to the following presheaf for open sub-log scheme $U$ of $B: U \longmapsto R^{j} f_{U *}\left(B \Omega_{X \times_{T} U / U}^{i}\right)$, where $f_{U}: X \times_{B}$ $U \longrightarrow U$ is the structural morphism. Hence, to prove that $R^{j} f_{*}\left(B \Omega_{X / T}^{i}\right)=0$, it suffices to assume that $B \Omega_{X / T}^{i}=P_{k} B \Omega_{X / T}^{i}$ for some $k \in \mathbb{N}$. Now (2) follows from (7.6) and (7.3).

## 8 An analogue of Hyodo's criterion for quasi-F-split schemes

In this section we give an analogue of Hyodo's criterion for quasi-F-split schemes. This answers Illusie's question stated in the Introduction.

Let $Y$ be a closed subvariety of an $F$-split variety $X$. Let $\mathcal{I}$ be the ideal sheaf of $Y$ in $X$. Recall that $Y$ is compatibly split if there exists a splitting $\rho: F_{*}\left(\mathcal{O}_{X}\right) \longrightarrow$
$\mathcal{O}_{X}$ of the operator $F: \mathcal{O}_{X} \longrightarrow F_{*}\left(\mathcal{O}_{X}\right)$ such that $\rho\left(F_{*}(\mathcal{I})\right) \subset \mathcal{I}$. It is clear that this is equivalent to the existence of a splitting $\rho: F_{*}\left(\mathcal{O}_{X}\right) \longrightarrow \mathcal{O}_{X}$ of the operator $F: \mathcal{O}_{X} \longrightarrow F_{*}\left(\mathcal{O}_{X}\right)$ which induces a splitting $\rho: F_{*}\left(\mathcal{O}_{Y}\right) \longrightarrow \mathcal{O}_{Y}$ of the operator $F: \mathcal{O}_{Y} \longrightarrow F_{*}\left(\mathcal{O}_{Y}\right)$.

Definition 8.1. Let $Y$ be an SNC scheme. We say that $Y$ is compatibly quasi-$F$-split if there exists a splitting $\rho: F_{*}\left(\mathcal{W}_{n}\left(\mathcal{O}_{Y^{(0)}}\right)\right) \longrightarrow \mathcal{W}_{n}\left(\mathcal{O}_{Y^{(0)}}\right)$ of the operator $F: \mathcal{W}_{n}\left(\mathcal{O}_{Y^{(0)}}\right) \longrightarrow F_{*}\left(\mathcal{W}_{n}\left(\mathcal{O}_{Y^{(0)}}\right)\right)$ for some $n \in \mathbb{Z}_{\geq 1}$ which induces a splitting $\rho: F_{*}\left(\mathcal{W}_{n}\left(\mathcal{O}_{Y^{(1)}}\right)\right) \longrightarrow \mathcal{W}_{n}\left(\mathcal{O}_{Y^{(1)}}\right)$ of the operator $F: \mathcal{W}_{n}\left(\mathcal{O}_{Y^{(1)}}\right) \longrightarrow F_{*}\left(\mathcal{W}_{n}\left(\mathcal{O}_{Y^{(1)}}\right)\right)$.

Proposition 8.2. Let $Y$ be an SNC scheme. Then $Y$ is quasi-F-split if and only if $Y$ is compatibly quasi-F-split.

Proof. By [RS, Theorem 1] the following sequence

$$
\begin{equation*}
0 \longrightarrow \mathcal{W}_{n}\left(\mathcal{O}_{X}\right) \longrightarrow \mathcal{W}_{n}\left(\mathcal{O}_{X^{(0)}}\right) \longrightarrow \mathcal{W}_{n}\left(\mathcal{O}_{X^{(1)}}\right) \longrightarrow \cdots \quad\left(n \in \mathbb{Z}_{\geq 1}\right) \tag{8.2.1}
\end{equation*}
$$

is exact. Hence (8.2) follows.

## 9 Ordinarity at 0 of proper SNC schemes

Let $S$ be a scheme of characteristic $p>0$. In this section let $X$ be a proper SNC(=simple normal crossing) scheme over $S$. Let $f: X \longrightarrow S$ be the structural morphism. In this section we consider only trivial log structures. Let $F: X \longrightarrow X$ be the Frobenius endomorphism. We say that $X / S$ is ordinary at 0 if $F^{*}: R^{h} f_{*}\left(\mathcal{O}_{X}\right) \longrightarrow$ $R^{h} f_{*}\left(\mathcal{O}_{X}\right)$ is bijective for any $h \in \mathbb{N}$. When $S$ is the underlying scheme of a family of $\log$ points and when $X / S$ is the underlying morphism of a morphism of SNCL schemes $Y / T$ with structural morphism $g: Y \longrightarrow T$, this definition is equivalent to the variation of the ordinarity at 0 defined in Nakk6, (6.1)]: $R^{h} g_{*}\left(B \Omega_{Y / T}^{1}\right)=0$. This follows from the following tautological exact sequence

$$
0 \longrightarrow \mathcal{O}_{Y} \longrightarrow F_{*}\left(\mathcal{O}_{Y}\right) \xrightarrow{d} B_{1} \Omega_{Y / T}^{1} \longrightarrow 0 .
$$

The following proposition may be of independent interest (cf. [ST, Conjecture $\left.\mathrm{N}_{n}\right]$ ):
Proposition 9.1. If $X^{(i)} / S$ is ordinary at 0 for all $i$, then $X / S$ is ordinary at 0 .
Proof. Because the following sequence

$$
0 \longrightarrow \mathcal{O}_{X} \longrightarrow \mathcal{O}_{X^{(0)}} \longrightarrow \mathcal{O}_{X^{(1)}} \longrightarrow \cdots
$$

is exact and this exact sequence is compatible with the operator $F$, we have the following sequence

$$
\begin{equation*}
E_{1}^{-k, h+k}=R^{h+k} f_{*}\left(\mathcal{O}_{X^{(-k+1)}}\right) \Longrightarrow R^{h} f_{*}\left(\mathcal{O}_{X}\right) \quad\left(-k, q \in \mathbb{Z}_{\geq 0}\right) \tag{9.1.1}
\end{equation*}
$$

By the assumption $F: E_{1}^{-k, h+k} \longrightarrow E_{1}^{-k, h+k}$ is bijective. Hence $F: R^{h} f_{*}\left(\mathcal{O}_{X}\right) \longrightarrow$ $R^{h} f_{*}\left(\mathcal{O}_{X}\right)$ is bijective.
