# DENSITY OF STATES AND DELOCALIZATION FOR DISCRETE MAGNETIC RANDOM SCHRÖDINGER OPERATORS

#### Abstract

We study discrete magnetic random Schrödinger operators on the square and honeycomb lattice. For the non-random magnetic operator on the hexagonal lattice with any rational magnetic flux, we show that the middle two dispersion surfaces exhibit Dirac cones. We then derive an asymptotic expansion for the density of states on the honeycomb lattice for oscillations of arbitrary rational magnetic flux. This allows us, as a corollary, to rigorously study the quantum Hall effect and conclude dynamical delocalization close to the conical point under disorder. We obtain similar results for the discrete random Schrödinger operator on the $\mathbb{Z}^{2}$-lattice with weak magnetic fields, close to the bottom and top of its spectrum.


## 1. Introduction and statement of results

In this article, we study discrete random Schrödinger operators, the tight-binding limits of continuous random Schrödinger operators, under weak disorder in weak magnetic fields on the $\mathbb{Z}^{2}$ lattice $\Lambda_{■}$ and in addition for magnetic fluxes close to rationals on the honeycomb lattice $\Lambda_{0}$ :

where $V_{\omega}$ is an i.i.d. random potential on the respective lattice $\Lambda$. For precise definitions of these operators, we refer to Section 2.2.

The spectral properties of the discrete magnetic Laplacian (DML) on $\mathbb{Z}^{2}$, and of the almost Mathieu operator (AMO), have been extensively studied over the past forty years, see for instance a survey [MJ17] and some recent advancements [AYZ17, JL18, JK19]. Significant progress on the location of the spectrum has been made for magnetic Schrödinger operators using semiclassical analysis [HS88, HS89, HS90b, W94]. In two preceding articles [BHJ18, BZ19], by the authors, this study was extended to spectral
properties and the density of states (DOS) of the magnetic Schrödinger operator on the honeycomb lattice -but without disorder. It was shown in [BZ19, Theorem 1] that the DOS for the magnetic Schrödinger operator on the honeycomb quantum graphclose to the conical point- is concentrated at so-called relativistic Landau levels.

The spectral analysis in [BHJ18] showed that for the DML on the hexagonal lattice, close to the conical point, there is no point spectrum, as the analogy to the magnetic two-dimensional Dirac operator suggests. Instead, the spectrum of the DML on the honeycomb lattice is either absolutely continuous (a.c.) band spectrum or singular continuous (s.c.) and a Cantor set of Lebesgue measure zero, depending on the arithmetic properties of the magnetic flux through a single honeycomb.

Next let us introduce our results. We start with the non-random operator on the hexagonal lattice $H_{0, \lambda=0}^{h}$. The part of the energy spectrum of graphene, modeled here by the discrete operator $H_{0, \lambda=0}^{h}$ that is relevant for most of its remarkable physical properties, is the energy spectrum close to the conical points, the so-called Dirac points at energy zero, see Fig. 3. The existence of Dirac points for the tight-binding graphene model in the absence of magnetic field is known since [W47]. In the absence of magnetic fields, the operator can be reduced to a $2 \times 2$ matrix via Floquet-Bloch theory. Hence the only two dispersion surfaces can be computed explicitly, whence conical touching of the two surfaces is evident. It is natural to ask the question if Dirac points still exist for arbitrary rational magnetic flux, where the operator is still periodic. Indeed, for flux $h=2 \pi p / q$, the operator can be reduced to a $2 q \times 2 q$ matrix. The dispersion surfaces thus have to be analyzed implicitly and hence making it much harder to prove conical structures. Our first result is to prove the existence of Dirac cones at energy zero for the tight-binding model for any rational magnetic flux.

Theorem 1. For any rational flux $h=2 \pi \frac{p}{q} \in 2 \pi \mathbb{Q}$, the operator $H_{0, \lambda=0}^{h}$ possesses Dirac points at energy zero.

Using the conical structures as a starting point, we are able to carry out the semiclassical analysis and obtain the expansion of the density of states (DOS) near the energy zero for flux $2 \pi p / q+h$ with $h$ being the semi-classical parameter, see Theorems $3^{1}$ and 4. This in particular allows us to prove the localization of the spectrum in Landau bands near the zero energy, characterized by the Bohr-Sommerfeld condition, and the existence of spectral gaps between any two consecutive Landau bands. Our framework follows [HS90a], but uses independent arguments for the derivation of the density of states and the presence of spectral gaps in between Landau bands. In addition to the study of the discrete magnetic Laplacian on the honeycomb lattice, we also derive the expansion of DOS for the operator $H_{■, \lambda, \omega}^{h}$ on the $\mathbb{Z}^{2}$ lattice with small flux near the top and bottom of the spectrum, which is included in Theorem 3.

[^0]By combining the expansion of DOS with the Středa formula, we are able to compute the Hall conductivity explicitly in each of the aforementioned spectral gaps for the nonrandom operators $H_{0, \lambda=0}^{h}$ and $H_{\square, \lambda=0}^{h}$, thus giving a rigorous derivation of the Quantum Hall effect (QHE). We then argue using the index-theoretic formulation that the Hall conductivity is invariant under a random perturbation in the spectral gaps between any two consecutive disorder-broaden Landau bands. The study of the quantum Hall effect of the continuous Laplacian in a homogeneous magnetic field is much simpler, as the (infinitely-degenerate) eigenfunctions are fully explicit and so all computations can be done analytically. In contrast to this, the discrete magnetic Laplacian, does not have point spectrum and closed-form describing it are also not available. This is a major difficulty in the discrete setting, which can be partly overcome by gap-labelling methods techniques as in [AEG14]. However, we would like to emphasize that such methods are usually not quantitative in the sense that they do not specify the Hall conductivity at prescribed energies. From our refined study of the density of states with error bounds, we are able to solve this problem and get precise information on the Hall conductivity in the gaps between Landau bands that are quantitative. For the cleanness of the presentation, we present below the QHE for small magnetic fields, and refer the readers to Theorem 4 for $H_{\circ, \lambda, \omega}^{h}$ with fluxes close to rationals.

Proposition 1.1 (QHE under weak disorder; Small magnetic fields). For sufficiently small magnetic flux $h>0$, there are spectral gaps between disorder-broadened Landau bands up to some magnetic-dependent disorder parameter $\lambda_{0}(h)>0$. In the spectral gap between two consecutive disorder-broadened Landau bands $B_{\circ, \lambda, n}^{h}$ and $B_{0, \lambda, n+1}^{h}$, the Hall conductivity $c_{H}$ with Fermi energy $\mu$ is quantized with its value given below.

Using the jump of Hall conductivity in each disorder-broadened Landau band, we then show that the discrete magnetic random Schrödinger operators undergo metal/insulator transitions, using the framework of Germinet-Klein [GK01] and Klein-Germinet-Schenker [GKS04]. More precisely, we prove the existence of (at least one) mobility edge near the Landau levels. Again, we only present the small magnetic fields case here, and refer the readers to Theorem 4 for $H_{0, \lambda, \omega}^{h}$ with perturbations of rational fluxes.

Theorem 2 (Dyn. Delocalization; Small fields). Under the same assumptions as Proposition 1.1, there exists in each disorder-broadened Landau band (at least) one energy that belongs to the region of dynamical delocalization.

The paper is structured as follows: Section 2 serves as preliminary and background, the study of DOS is presented in Section 3, QHE is studied in Section 4, dynamical
delocalization is proved in Section 5, the proof of Theorem 1 is presented in Section 6 , and finally the semiclassical analysis together with the proofs of Theorems 3 and 4 are presented in Section 7.

Here, $p_{x}:=-i \frac{d}{d x}$. Conversely, we write $\sigma\left(\operatorname{Op}_{h}^{w}(a)\right):=a$ to denote the Weyl symbol of a $\Psi \mathrm{DO}$ and $\sigma_{0}\left(\mathrm{Op}_{h}^{w}(a)\right)$ for the principal symbol. Analogously, higher order symbols are denoted by $\sigma_{k}$, respectively. The semiclassical wavefront set is denoted by $\mathrm{WF}_{h}$, see $\left[\mathrm{Zw} 12\right.$, Sec.8.4]. We also write $\mathbb{Z}_{*}^{2}:=(2 \pi \mathbb{Z})^{2}$. For a subset $I \subset \mathbb{R}$ we denote by $\oint_{I}$ a contour integral over a path in the complex plane that encloses $I$ sufficiently close.

The spectrum of an operator $T$ is denoted by $\Sigma(T)$. We sometimes use the convention $\hbar:=\frac{h}{2 \pi}$ where $h$ is the magnetic flux (thus this notation should not be confused with Planck's constant). The $p$-th Schatten class is denoted by $\mathcal{L}^{p}$. The symplectic form on $\mathbb{R}^{2}$ is denoted by $\sigma_{\text {symp }}(\gamma, \delta):=\gamma_{1} \delta_{2}-\delta_{1} \gamma_{2}$. derivative of a holomorphic function $f$. In particular, holomorphic functions satisfy $D_{\bar{z}} f=0$ by the Cauchy-Riemann equations. $\mathscr{S}\left(\mathbb{Z}^{2}\right)$ are the sequences that decay faster than any polynomial power. We also write $\mathscr{S}\left(\mathbb{R}^{n}\right)$ or $\mathscr{S}\left(\mathbb{C}^{n}\right)$ for the Schwartz functions on $\mathbb{R}^{n}$ or $\mathbb{C}^{n}$. We also define for one of the two lattices $\Lambda$ we study in this article, the truncated sets

where $\vec{b}_{1}$ and $\vec{b}_{2}$ are the basis vectors of the lattice and $W_{\Lambda}$ a fundamental domain.

## 2. Lattices and discrete random Schrödinger operators

2.1. Geometry of lattices. The $\mathbb{Z}^{2}$ lattice $\square$, see Fig. 1a. The square lattice $\Lambda_{\mathbf{\bullet}}:=\mathbb{Z}^{2}$ is spanned by basis vectors $\vec{b}_{\mathbf{\square}, 1}:=(1,0), \vec{b}_{\mathbf{\square}, 2}:=(0,1)$ and its fundamental cell $W_{\Lambda}$ consists of just the vertex $r_{0}:=(0,0)$. Although we do not study operators on the associated graph, we also introduce the set of edges $\mathcal{E}_{\square}$ on the square graph consisting of the two edges

and translations thereof by basis vectors $\vec{b}_{\mathbf{\bullet}, 1}, \vec{b}_{\mathbf{\bullet}, 2}$, where conv denotes the convex hull. To orient the graph, we also define a map $i: \mathcal{E}_{\boldsymbol{\square}} \rightarrow \Lambda_{■}$ by $i\left(\vec{f}_{\uparrow}\right):=i\left(\vec{f}_{\rightarrow}\right):=r_{0}$ and extend it to all edges by translation

Let us now turn to the hexagonal lattice:
The hexagonal lattice $\bigcirc$, see Fig. 1b. The hexagonal lattice $\Lambda_{\bigcirc}$ is obtained by translating its fundamental cell $W_{\Lambda_{\bigcirc}}$, consisting of vertices

along the basis vectors of the lattice. The basis vectors are

As in the case of the $\mathbb{Z}^{2}$ lattice, we also introduce auxiliary edges

and define the set of all edges $\mathcal{E}_{\circ}$ as the set of all translates of these three edges along the basis vectors $\vec{b}_{0,1}, \vec{b}_{\bigcirc, 2}$ of the hexagonal lattice.

We call translates of $r_{0}$ by basis vectors $\vec{b}_{\bigcirc, 1}, \vec{b}_{\bigcirc, 2}$ initial vertices $\Lambda_{\bigcirc}^{i}$ whereas translates of $r_{1}$ will be referred to as terminal vertices $\Lambda_{\bigcirc}^{t}$. Moreover, we consider maps $i: \mathcal{E}_{\bigcirc} \rightarrow$ $\Lambda_{\bigcirc}$ and $t: \mathcal{E}_{\bigcirc} \rightarrow \Lambda_{\bigcirc}$ that map edges to the respective initial or terminal vertex they contain.

In the sequel, we will use the isomorphism $\ell^{2}\left(\Lambda_{\bigcirc}\right) \simeq \ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{2}\right)$ as the honeycomb has two basis vectors and two vertices in its fundamental domain. More generally, any lattice with $\Lambda$ spanned by two basis vectors with $n$ vertices in its fundamental domain satisfies $\ell^{2}(\Lambda) \simeq \ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{n}\right)$.
2.2. Discrete random Schrödinger operators. We consider a constant magnetic field. The vector potential $\mathbf{A}$ is a one form on $\mathbb{R}^{2}$ and the magnetic field is given by $\mathbf{B}=d \mathbf{A}$. For homogeneous magnetic fields

we can choose a symmetric gauge for the vector potential $\mathbf{A}$ such that

The discrete magnetic Laplacians (DMLs) with single-site disorder are then defined as follows: First, we take the scalar potential $A_{\vec{e}} \in C^{\infty}(\vec{e})$ along edges $\vec{e}=e_{1} d x_{1}^{*}+e_{2} d x_{2}^{*}$ of the respective graph, where $d x_{j}\left(d x_{i}^{*}\right)=\delta_{i, j}$ is defined by evaluating the 1 -form on the graph along the vector field generated by the respective edge $\vec{e}$ :

From this point on, we may suppress the dependence on the lattices in some notations if there is no ambiguity or if the results hold for both lattices.

We now define the discrete magnetic random Schrödinger operators:
Definition 2.1 (Discrete magnetic Schrödinger operators). We define discrete magnetic random Schrödinger operators $H_{■}^{h} \in \mathcal{L}\left(\ell^{2}\left(\Lambda_{■}\right)\right)$ and $H_{\circ}^{h} \in \mathcal{L}\left(\ell^{2}\left(\Lambda_{\odot}\right)\right)$ on the square $■$, using (2.8), and hexagonalolattice, using (2.9), respectively

\left(H_{\oslash, \lambda, \omega}^{h} u\right)(v):= & \frac{1}{3}\left(\sum_{\vec{e} \in \mathcal{E}_{\odot}, i(\vec{e})=v} e^{-i A_{\vec{e}}} u(t(\vec{e}))+\sum_{\vec{e} \in \mathcal{E}_{\bigotimes}, t(\vec{e})=v} e^{i A_{\vec{e}}} u(i(\vec{e}))\right)+\lambda V_{\omega}(v) u(v) \tag{2.11}
\end{align*}
$$

where the parameter $\lambda>0$ measures the disorder strength. The random potential satisfies $V_{\omega}(v)=\omega(v)$, where $\{\omega(v)\}_{v \in \Lambda}$ is a family of i.i.d with common probability distribution $\nu$ of compact support on $\mathbb{R}$. We write $(\Omega, \mathbb{P})$ the underlying probability space, and $\mathbb{E}$ the expectation.

We will write $(\Omega, \mathbb{P})$ for the underlying probability space, hence $\Omega=\times_{v \in \Lambda} \mathbb{R}$, and $\mathbb{P}=\times_{v \in \Lambda} \nu$. We define the shifts operators $\left\{T_{\delta}^{\Omega}\right\}_{\delta \in \mathbb{Z}^{2}}$ on $\Omega$ by

The sample space $\Omega$ of the configuration space of impurities $(\Omega, \mathbb{P})$ is, without loss of generality, assumed to be compact, cf. [C94, p. 372f.] for details.

We then write $H^{h}:=H_{\lambda=0, \omega}^{h}$ for the non-random DML.

2.3. Magnetic translations, regularized traces, and the density of states measure. We start our analysis by introducing discrete translation operators $T_{\gamma}$ with $\gamma \in \mathbb{Z}^{2}$ for $\psi \in \ell^{2}(\Lambda)$

The magnetic Schrödinger operator $H^{h}$ does, in general, not commute with standard lattice translations $T_{\gamma}$, but with magnetic translations $T_{\gamma}^{h}$ instead. These operators and powers of them, do not commute with each other, if $T_{(0,1)}^{h}$ and $T_{(1,0)}^{h}$ generate the irrational $(\hbar \in \mathbb{R} \backslash \mathbb{Q})$ rotation algebra. Magnetic translations $T_{\gamma}^{h}: \ell^{2}(\Lambda) \rightarrow \ell^{2}(\Lambda)$ are unitary operators of the form

that satisfy the commutation relation

On the square lattice we define magnetic translations as

\end{equation*}

and set then $T_{\gamma}^{h}:=\left(T_{(1,0)}^{h}\right)^{\gamma_{1}}\left(T_{(0,1)}^{h}\right)^{\gamma_{2}}$.
On the hexagonal lattice, the magnetic translations $T_{\gamma}^{h}: \ell^{2}\left(\Lambda_{\bigcirc}\right) \rightarrow \ell^{2}\left(\Lambda_{\bigcirc}\right)$ are unitary operators of the above form (2.14) with prefactors $\left(u^{h}(\gamma)_{v}\right)_{v \in \Lambda_{\bigcirc}}$ defined as follows: Let $\alpha(\gamma)=\frac{h}{6}\left(\gamma_{1}-\gamma_{2}\right)$, then we can define $u^{B}(\gamma)_{r_{*}-\delta_{1} \vec{b}_{1}-\delta_{2} \vec{b}_{2}}=e^{i \frac{h}{2} \sigma_{\text {symp }}(\gamma, \delta)} u^{B}(\gamma)_{r_{*}}$ with $* \in\{0,1\}$ where $u^{B}(\gamma)_{r_{0}}=1$ and $u^{B}(\gamma)_{r_{1}}=e^{i \alpha(\gamma)}$. This way, the magnetic translations on both lattices satisfy

f\left(H_{\lambda, \omega}^{h}\right)[x, x]=f\left(H_{\lambda, T_{\gamma}^{\Omega} \omega}^{h}\right)\left[x-\gamma_{1} \vec{b}_{1}-\gamma_{2} \vec{b}_{2}, x-\gamma_{1} \vec{b}_{1}-\gamma_{2} \vec{b}_{2}\right] . \tag{2.19}
\end{equation*}

To study the density of states (DOS) of the model, we define, for a lattice $\Gamma \subset \mathbb{R}^{2}$ and operators $A \in \mathcal{L}\left(\ell^{2}\left(\Gamma, \mathbb{C}^{n}\right)\right)$ given by $A(s)(\gamma):=\sum_{\beta \in \Gamma} A[\gamma, \beta] s(\beta)$ with possibly matrix-valued kernel $A[\gamma, \beta]^{2} \in \mathbb{C}^{n \times n}$, the regularized trace

$$
\begin{equation*}
\tilde{\operatorname{tr}}_{\Gamma}(A):=\lim _{r \rightarrow \infty} \frac{1}{\left|B_{0}(r)\right|} \sum_{\gamma \in \Gamma \cap B_{0}(r)} \operatorname{tr}_{\mathbb{C}^{n}} A[\gamma, \gamma] \tag{2.20}
\end{equation*}

provided the limit exists.
Birkhoff's ergodic theorem implies the a.s. existence of the regularized trace

\tilde{\operatorname{tr}}_{\Lambda}\left(f\left(H_{\lambda, \omega}^{h}\right)\right)=\mathbb{E}\left(\frac{\sum_{x \in W_{\Lambda}} f\left(H_{\lambda, \omega}^{h}\right)[x, x]}{| | \vec{b}_{1} \wedge \vec{b}_{2} \mid}\right)=\frac{\mathbb{E} \operatorname{tr} \mathbf{1}_{W_{\Lambda}} f\left(H_{\lambda, \omega}^{h}\right)}{\left|\vec{b}_{1} \wedge \vec{b}_{2}\right|}, \tag{2.21}
\end{equation*}

where $\left|\vec{b}_{1} \wedge \vec{b}_{2}\right|^{-1}$ normalizes the number of vertices per unit volume. By Riesz's theorem one can then associate to the regularized trace a Radon measure $\rho_{H_{\lambda, \omega}^{h}}$, the DOS measure, and by the preceding discussion, this measure is a.s. non-random. Thus $\rho_{H_{\lambda, \omega}^{h}}=: \rho_{H_{\lambda}^{h}}$ a.s. and therefore $\int_{\mathbb{R}} f(x) d \rho_{H_{\lambda}^{h}}(x)=\widetilde{\operatorname{tr}}_{\Lambda}\left(f\left(H_{\lambda, \omega}^{h}\right)\right)$ a.s..

## 3. The semiclassical expansion of the DOS

We study the DOS by investigating operators $f\left(H_{\lambda, \omega}^{h}\right)$ using the functional calculus of Helffer-Sjöstrand [HS88]. We first recall that any function $f \in C_{\mathrm{c}}^{\infty}(\mathbb{R})$ can be extended to functions $\widetilde{f} \in \mathscr{S}(\mathbb{C})$ such that $\left.\widetilde{f}\right|_{\mathbb{R}}=f$ and $D_{\bar{z}} \widetilde{f}=\mathcal{O}\left(|\operatorname{Im} z|^{\infty}\right)$. Such functions $\tilde{f}$ are then called almost analytic extensions of $f$. One possible way of defining $\tilde{f}$ is by

& \tilde{f}(x+i y)=\frac{1}{2 \pi} \chi(y) \psi(x) \int_{\mathbb{R}} \chi(y \xi) \widehat{f}(\xi) e^{i(x+i y) \xi} d \xi,  \tag{3.1}\\
& \chi, \psi \in C_{\mathrm{c}}^{\infty}(\mathbb{R}),\left.\quad \psi\right|_{\operatorname{supp} f+(-1,1)}=1,\left.\quad \chi\right|_{(-1,1)}=1,
\end{align*}

[DS99, see Chapter 8] for details. A more pedestrian, but also more restrictive, way of defining almost-analytic extensions, for smooth functions $f \in C_{c}^{\infty}(\mathbb{R})$, is for $n \in \mathbb{N}$ by

Differentiating (3.2), one finds that $\left|D_{\bar{z}} \widetilde{f}(z)\right|=\mathcal{O}\left(|\operatorname{Im} z|^{n}\right)$ which follows from

A similar computation shows that the quasi-analytic extension satisfies

The almost-analytic extension enters then in the Helffer-Sjöstrand formula which states that for any self-adjoint operator $P$,

\end{equation*}

### 3.1. Magnetic matrices.

Definition 3.1 (Magnetic matrices). Let $f_{\omega}(\gamma) \in C_{c}\left(\Omega \times \mathbb{Z}^{2} ; \mathbb{C}^{n \times n}\right)$ at first, where $\omega \in \Omega$ and $\gamma \in \mathbb{Z}^{2}$. We define magnetic matrices as discrete operatorsas

$$
\begin{equation*}
A^{h}\left(f_{\omega}\right) \in \mathcal{L}\left(\ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{n \times n}\right)\right), \quad A^{h}\left(f_{\omega}\right):=\left(e^{-i \frac{h}{2} \sigma_{s y m p}(\gamma, \delta)} f_{T_{\gamma}^{\Omega} \omega}(\gamma-\delta)\right)_{\gamma, \delta \in \mathbb{Z}^{2}} \tag{3.7}
\end{equation*}
$$

These matrices act on $\ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{n}\right)$ by matrix-like multiplication

$$
\begin{equation*}
\left(A^{h}\left(f_{\omega}\right) u\right)_{\gamma}=\sum_{\delta \in \mathbb{Z}^{2}}\left(A^{h}\left(f_{\omega}\right)\right)_{\gamma, \delta} u_{\delta} . \tag{3.8}
\end{equation*}

For yet another set of discrete magnetic translation operators $\tau_{\gamma}^{h}$ on the $\mathbb{Z}^{2}$-lattice

we find, in analogy to (2.17), that magnetic matrices are covariant with respect to discrete magnetic translations (3.9)

For $f, g \in C_{c}\left(\Omega \times \mathbb{Z}^{2} ; \mathbb{C}^{n \times n}\right)$ we introduce the product

\left(f \#_{h} g\right)_{\omega}(\gamma) & :=\sum_{z \in \mathbb{Z}^{2}} f_{\omega}(\gamma-z) g_{T_{\gamma-z}^{\Omega}}(z) e^{-i \frac{h}{2} \sigma_{\text {symp }}(\gamma, z)} \\
& =\sum_{z \in \mathbb{Z}^{2}} f_{\omega}(z) g_{T_{z}^{\Omega} \omega}(\gamma-z) e^{-i \frac{h}{2} \sigma_{\text {symp }}(\gamma, z)} . \tag{3.12}
\end{align*}
$$

This product is reconcilable with multiplication of magnetic matrices

$$
\begin{equation*}
A^{h}\left(f \#_{h} g\right)_{\omega} u(\xi)=A^{h}\left(f_{\omega}\right)\left(A^{h}\left(g_{\omega}\right)(u)\right)(\xi) \tag{3.13}
\end{equation*}
$$

Moreover, defining the involution

f_{\omega}^{*}(\gamma):=\overline{f_{T_{-\gamma}^{\Omega} \omega}(-\gamma)} \tag{3.14}
\end{equation*}
$$

we see that the adjoint of a magnetic matrix is again given by a magnetic matrix

\left\langle A^{h}\left(f_{\omega}\right)(g), h\right\rangle=\left\langle g, A^{h}\left(f_{\omega}^{*}\right)(h)\right\rangle . \tag{3.15}
\end{equation*}

Remark 1. The preceding computations show that magnetic matrices are the *-representation of a $C^{*}$-algebra $\mathcal{C}_{h}$ which is the closure of functions $f \in C_{c}(\Omega \times$ $\mathbb{Z}^{2} ; \mathbb{C}^{n \times n}$ ) with composition (3.12) and involution (3.14) under the norm $\|f\|_{\mathcal{C}_{h}}:=$ $\sup _{\omega \in \Omega}\left\|A^{h}(f)\right\|$. This defines a continuous field (as a function of $h$ ) of $C^{*}$-algebra $\mathcal{C}_{h}$, $c f$. [BES94, Sec. F],[ST12].

To connect operators $H_{\lambda, \omega}^{h}$ with magnetic matrices, we define symbols $a_{■}(1,0)=a_{\bullet}(0,1)=a_{\bullet}(-1,0)=a_{\bullet}(0,-1)=\frac{1}{4}$, and for the hexagonal lattice $a_{\circ}(0,0):=\frac{1}{3}\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right), \quad a_{\circ}(1,0):=a_{\circ}(0,1):=\frac{1}{3}\left(\begin{array}{ll}0 & 1 \\ 0 & 0\end{array}\right)$, $a_{\diamond}(-1,0):=a_{\diamond}(0,-1):=\frac{1}{3}\left(\begin{array}{ll}0 & 0 \\ 1 & 0\end{array}\right)$,
and $a(\eta)=0$ otherwise. The random symbols are then defined as $a_{\lambda, \omega, \mathbf{m}}(\gamma)=a_{\mathbf{\bullet}}(\gamma)+$ $\lambda \delta_{0}(\gamma) V_{\omega}(0)$ or $a_{\lambda . \omega, \bigcirc}(\gamma)=a_{\odot}(\gamma)+\lambda \delta_{0}(\gamma) \operatorname{diag}\left(V_{\omega}\left(r_{0}\right), V_{\omega}\left(r_{1}\right)\right)$.

Lemma 3.2. There exist unitary multiplication operators $U_{\mathbf{\bullet}}: \ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}\right) \rightarrow \ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}\right)$ and $U_{\bigcirc}: \ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{2}\right) \rightarrow \ell^{2}\left(\Lambda_{\bigcirc} ; \mathbb{C}\right)$ such that

H_{\lambda, \omega, \llbracket}^{h}=U_{\mathbf{\bullet}} A^{h}\left(a_{\lambda, \omega, \amalg}\right) U_{\bullet}^{*} \text { and } H_{\lambda, \omega, \bigcirc}^{h}=U_{\diamond} A^{h}\left(a_{\lambda, \omega, \bigcirc}\right) U_{\bigcirc}^{*} . \tag{3.17}
\end{equation*}
$$

In particular, since operators $U$ are multiplication operators, we find

\tilde{\operatorname{tr}}_{\Lambda}\left(\left(H_{\lambda, \omega}^{h}-z\right)^{-1}\right)=\left|\vec{b}_{1} \wedge \vec{b}_{2}\right|^{-1} \tilde{\operatorname{tr}}_{\mathbb{Z}^{2}}\left(\left(A^{h}\left(a_{\lambda, \omega}\right)-z\right)^{-1}\right) . \tag{3.18}
\end{equation*}

Proof. The first equivalence on the $\mathbb{Z}^{2}$ lattice in (3.17) is obtained by first passing from the symmetric to the Landau gauge and then conjugating this operator by $W u(\gamma):=$ $e^{-i \frac{h}{2} \gamma_{1} \gamma_{2}} u(\gamma)$. For the hexagonal lattice, the transformation is slightly more involved. We start by defining two unitary maps: The first one is $U_{1} z:=\left(\zeta_{v} z(v)\right)_{v \in \mathcal{V}\left(\Lambda_{0}\right)}$ with recursively defined factors

\zeta_{\left(\gamma_{1}+1\right) \overrightarrow{b_{1}}+\gamma_{2} \overrightarrow{b_{2}}+r_{0}}:=e^{i\left(-A_{\left(\gamma_{1}+1\right) \overrightarrow{b_{1}}+\gamma_{2} \overrightarrow{b_{2}}+\vec{g}}+A_{\gamma_{1} \overrightarrow{b_{1}}+\gamma_{2} \overrightarrow{b_{2}}+\vec{f}}\right)} \zeta_{\gamma_{1} \overrightarrow{b_{1}}+\gamma_{2} \overrightarrow{b_{2}}+r_{0}} \text { and }  \tag{3.19}\\
\zeta_{\gamma_{1} \overrightarrow{b_{1}}+\left(\gamma_{2}+1\right) \overrightarrow{b_{2}}+r_{0}}:=e^{i\left(-A_{\left.\gamma_{1} \overrightarrow{b_{1}}+\left(\gamma_{2}+1\right) \overrightarrow{b_{2}}+\vec{h}-h \gamma_{1}+A_{\gamma_{1}} \overrightarrow{b_{1}+\gamma_{2}} \overrightarrow{b_{2}}+\vec{f}\right)}^{\zeta_{\gamma_{1}} \overrightarrow{b_{1}}+\gamma_{2} \overrightarrow{b_{2}}+r_{0}}\right.} .
\end{gather*}
$$

and $U_{2}: \ell^{2}\left(\mathcal{V}\left(\Lambda_{\bigcirc}\right)\right) \rightarrow \ell^{2}\left(\mathbb{Z}^{2}, \mathbb{C}^{2}\right), U_{2}(z)(\gamma):=\left(z\left(r_{0}+\gamma_{1} \vec{b}_{1}+\gamma_{2} \vec{b}_{2}\right), z\left(r_{1}+\gamma_{1} \vec{b}_{1}+\gamma_{2} \vec{b}_{2}\right)\right)^{T}$.
The unitary transform is then $A^{h}\left(a_{\lambda, \omega, \bigcirc}\right)=\left(U_{1} U_{2}^{*} W^{*}\right)^{*} H_{\lambda, \omega, \mathrm{\circ}}^{h}\left(U_{1} U_{2}^{*} W^{*}\right)$, see also [BZ19, Lemma 3.3, 3.5].
3.2. Reduction of DOS. We now continue with the derivation of the DOS. For this, we consider a $\Psi D O$ representation of (non-random) magnetic matrices. To start, we observe the following expansion of the regularized trace of the resolvent of the random operators in terms of the deterministic one. Recall that we write $H^{h}:=H_{\lambda=0, \omega}^{h}$ for the non-random DML.

Lemma 3.3. The resolvent of the discrete random Schrödinger operator $H_{\lambda, \omega}^{h}$ satisfies

Using $D_{\bar{z}} \tilde{f}=\mathcal{O}\left(|\operatorname{Im}(z)|^{4}\right)$, as in (3.3) for the almost-analytic extension, we can compensate the $|\operatorname{Im}(z)|^{-4}$ singularity. To express the right-hand side in terms of $\Psi$ DOs, rather than $H^{h}$, we use (3.18) and (3.30) which upon integration by parts yields (3.31).

Our main result on the DOS for small magnetic fields is stated in the following Theorem:

Theorem 3 (Semiclassical expansion of DOS). For small magnetic fields $h>0$ and small disorder $\lambda$ the DOS satisfies:

The proof of Theorem 3 is given at the end of this article in Section 7.
Remark 2. The different prefactor $h / 2 \pi$ for the square lattice compared with $h / \pi$ for the hexagonal lattice is due to the two-fold degeneracy of quasimodes on the hexagonal lattice (two Dirac cones and therefore two potential wells), cf. Fig. 3.

In particular, for functions $f$ whose first and second derivative vanishes at the Landau levels, the randomness only causes a shift of the Landau levels by $\lambda \mathbb{E}(V)$. This can be thought of as a semiclassical universality result for the integrated density of states, if one takes $f$ to be (a smooth approximation of) an indicator function. By this we mean that the leading-order contribution in the semiclassical parameter $\lambda>0$ in the second line of (3.35) vanishes.

Figure 4. Energy bands for magnetic flux $h=2 \pi \frac{4}{30}$ on $\Lambda_{\bigcirc}$ close to the zero energy level. Bands concentrate around certain energies which are precisely the Landau levels defined in Theorem 3.

We start by showing that for small enough magnetic fields without disorder there exist spectral gaps between the Landau levels stated in Theorem 3, cf. Figure 4. The presence of spectral gaps is crucial for the study of the quantum Hall effect, as the Hall conductivity remains unchanged as long as the Fermi energy stays inside a spectral gap.

From the Bohr-Sommerfeld condition stated in Theorem 3 in the absence of disorder, i.e. $\lambda \equiv 0$, we obtain to leading-order approximative Landau levels $z^{(1)}(h)$

where $F_{0}$ is the respective normalized phase space area in the Brillouin zone as stated in (3.34) and (3.36), and $I$ is the respective region of interest, i.e. the respective interval defined in Theorem 3. While approximate Landau levels $z_{\mathbf{l}, n}^{(1)}(h)$ for the square lattice are uniquely defined by the first of the equations in (3.37), there are two solutions for the hexagonal lattice (because of the upper and lower cone, see Figure 3): Let us recall from Theorem 3 that the asymptotic expansion yields

z_{\mathbf{Q}, n}^{(1)}(h)=\frac{\left(n-\frac{1}{2}\right) h}{2}+\mathcal{O}\left(n^{2} h^{2}\right), \quad n \in \mathbb{N} .
$$

For the hexagonal lattice, we use that $\left|1+e^{i x}+e^{i \xi}\right|^{2} / 9$ vanishes at $(x, \xi) \in \mathbb{Z}_{*}^{2} \pm$ $\left(\frac{2 \pi}{3},-\frac{2 \pi}{3}\right)$, that is, at the Dirac points, see Figure 3.

In small neighbourhoods of $\pm\left(\frac{2 \pi}{3},-\frac{2 \pi}{3}\right)$ we can make a symplectic (and thus areapreserving) change of variables

and find that

where $c=3^{\frac{1}{4}} 2^{-\frac{1}{2}}$ by choosing $a= \pm 2^{-\frac{1}{2}} 3^{-\frac{1}{4}}$ and $b= \pm 2^{-\frac{1}{2}} 3^{\frac{1}{4}}$. We thus conclude that for a Fermi velocity $v_{F}:=\sqrt{2} c / 3=3^{-3 / 4}$

Proposition 3.6 (Spectral gaps between Landau levels). For small $h>0$, the intersection of the region of interest I, in Theorem 3, with the spectrum of $H^{h}:=H_{\lambda=0, \omega}^{h}$, $\Sigma\left(H^{h}\right) \cap I$, is contained in disjoint intervals defined by constants $C_{\mathbf{\square}, n}, C_{\mathrm{O}, n}>0$

& B_{\bigcirc, n}(h):=\left[z_{\bigcirc, n}^{(1)}(h)-C_{\bigcirc, n} h^{\frac{5}{2}}, z_{\bigcirc, n}^{(1)}(h)+C_{\bigcirc, n} h^{\frac{5}{2}}\right], n \in\left[-N_{\bigcirc}(h), \ldots, N_{\bigcirc}(h)\right] .
\end{align*}

Moreover, numbers $N(h)$ have the property that $\lim _{h \downarrow 0} N(h)=\infty$.
Proof. Since the density of states measure is supported exactly where spectrum is, we conclude that the contribution to the DOS from the Landau levels, i.e. the first term on the right hand side of (3.33) and (3.35) is contained in closed Landau bands

\end{align*}

It remains to exclude spectrum of $\mathcal{O}\left(h^{\infty}\right)$-size, see the error bounds in (3.33) and (3.35), outside intervals $B_{n}$, possibly after modifying constants $C_{n}$. This can be shown, using semiclassical techniques as in [BZ19, Prop.5.2]. To be precise, the Proposition in [BZ19] states that there exists an operator $Q_{0}^{\mathrm{w}}\left(x, h p_{x}\right)$ whose point spectrum for the hexagonal lattice around zero coincides with the Landau levels, such that if for $z \in \operatorname{nbhd}(0)$, and some fixed $N_{0}$,

then the operator $Q_{0}^{\mathrm{w}}\left(x, h p_{x}\right)$, that is isospectral to $H_{\circ}^{h}$, cf. [Sj89][Theo. 6.2], is also invertible for such $z$. Hence, $H_{\circ}^{h}$ does not possess any spectrum between the Landau bands. The same argument applies to the square lattice in a neighbourhood of $\pm 1$.

The preceding Proposition implies that under small disorder, the closed Landau bands in the region of interest will broaden but are still non-overlapping since the decomposition $H_{\lambda, \omega}^{h}=H^{h}+\lambda V_{\omega}$ implies

It follows from Proposition 3.6 and (3.44) that for sufficiently weak magnetic fields $h>0$ and small disorder $\lambda \in\left(0, \lambda_{0}(h)\right)$ there exist for $H_{\lambda, \omega}^{h}$ finitely many (disorderbroadened) disjoint intervals $\mathcal{B}_{n, \lambda}(h) \supset B_{n}(h)$ with $n \in\left\{1, . ., N_{\square, \lambda}(h)\right\}$, for the square lattice, or with $n \in\left\{-N_{\mathrm{O}, \lambda}(h), . ., N_{\mathrm{O}, \lambda}(h)\right\}$, in case of the hexagonal lattice, such that

where the union of $n$ is taken over the respective sets.
Moreover, we assume without loss of generality that the disorder-broadened Landau bands are nested, i.e. for $\nu \leq \lambda$ we have $\mathcal{B}_{n, \nu}(h) \subset \mathcal{B}_{n, \lambda}(h)$.

## 4. Quantum Hall effect

4.1. The QHE without disorder. We start by studying the Quantum Hall effect in the absence of disorder using the DOS stated in Theorem 3 (we assume $\hbar \in \mathbb{R} \backslash \mathbb{Q}$ in the following paragraph). We take Středa's formula [S82] as the definition of the Hall conductivity:
Definition 4.1 (Středa formula). For (possibly random) Schrödinger operators $H_{\lambda, \omega}^{h}$ with Fermi energy $\mu$ inside a gap $d\left(\mu, \Sigma\left(H_{\lambda, \omega}^{h}\right)\right)>0$ a.s. we define the Hall conductivity by the Středa formula

c_{H}\left(H_{\lambda, \omega}^{h}, \mu\right):=\left|\vec{b}_{1} \wedge \vec{b}_{2}\right| D_{h} \widetilde{\operatorname{tr}}_{\Lambda}\left(\mathbb{1}_{(-\infty, \mu]}\left(H_{\lambda, \omega}^{h}\right)\right) . \tag{4.1}
\end{equation*}
$$

The DOS is differentiable, since by (2.21) the right-hand side of

is differentiable. This follows from holomorphic functional calculus

$$

as $H_{\lambda, \omega}^{h}$ depends analytically on $h$, i.e. $h \mapsto \mathbb{1}_{I}\left(H_{\lambda, \omega}^{h}\right)$ is differentiable as long as $\partial I$ is in a spectral gap. Thus, $h \mapsto \tilde{\operatorname{tr}}_{\Lambda}\left(\mathbb{1}_{I}\left(H_{\lambda, \omega}^{h}\right)\right)$ is differentiable as well.

On $\ell^{2}\left(\mathbb{Z}^{2}\right)$ we define the rotation algebra $\mathcal{A}_{\hbar}$ as the operator norm closure

\mathcal{A}_{\hbar}:=\overline{\left\{T \in \mathcal{L}\left(\ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{n}\right)\right) ; \exists k \in \mathbb{N}, c_{\gamma} \in \mathbb{C}: T=\sum_{|\gamma| \leq k} c_{\gamma} \tau_{\gamma}^{h}\right\}^{\|\bullet\|} .} \tag{4.2}
\end{equation*}

Magnetic matrices introduced in Definition 3.1 form a $*$-representation of the irrational rotation algebra. We then focus on the subalgebra $\mathcal{A}_{\hbar}^{\infty} \subset \mathcal{A}_{\hbar}$ of magnetic matrices with rapidly decaying symbols, i.e. with coefficients in (4.2) that satisfy $\left(c_{\gamma}\right) \in \mathscr{S}\left(\mathbb{Z}^{2} ; \mathbb{C}\right)$. The set $\mathcal{A}_{\hbar}^{\infty}$ is still a locally convex algebra equipped with standard seminorms inducing decay faster than any polynomial power $\left|\left(c_{\gamma}\right)\right|_{i}:=\sup _{\gamma \in \mathbb{Z}^{2}}\left|(1+|\gamma|)^{i} c_{\gamma}\right|_{\mathbb{C}^{n \times n}}$. Moreover, the inverse of a magnetic matrix $A^{h}(a) \in \mathcal{A}_{-\hbar}^{\infty}$ is again a magnetic matrix [HS88, Prop. 5.1], i.e. we have for $z \notin \Sigma\left(A^{h}(a)\right)$ that $\left(A^{h}(a)-z\right)^{-1} \in \mathcal{A}_{-\hbar}^{\infty}$, again. ${ }^{5}$

The smooth subalgebra $\mathcal{A}_{\hbar}^{\infty}$ is stable under holomorphic functional calculus [C94, Ch. 3 App.C] which implies that Fermi projections of $A^{h}(a)$, are again elements of $\mathcal{A}_{-\hbar}^{\infty}$, as long as $\mu \notin \Sigma\left(A^{h}(a)\right)$

\mathbb{1}_{(-\infty, \mu]}\left(A^{h}(a)\right)=(2 \pi i)^{-1} \oint_{\Sigma\left(A^{h}(a)\right)}\left(z-A^{h}(a)\right)^{-1} d z \in \mathcal{A}_{-\hbar}^{\infty} .

The irrational rotation algebra $\mathcal{A}_{\hbar}^{\infty}$ possesses a unique normalized trace ${ }^{6}$ [Sh94, Prop. 2.3,2.4] which therefore agrees with the trace $\widetilde{\operatorname{tr}}$ we use in this article. The $K_{0}$ group of the irrational rotation algebra is given by $K_{0}\left(\mathcal{A}_{\hbar}\right)=\mathbb{Z}+\hbar \mathbb{Z}$ [PV80a, PV80b]. Moreover, there exists a distinguished projection [R81], the so-called Powers-Rieffel projection $\mathrm{P}_{R}$, which together with the identity generate the $K_{0}$ group. The inclusion of $K_{0}$ groups of the dense subalgebra $\mathcal{A}_{\hbar}^{\infty}$ into the one of $\mathcal{A}_{\hbar}$ is an isomorphism [C85, App. 3, Prop. 2a] which implies that the above results remain true for $\mathcal{A}_{\hbar}^{\infty}$ as well.

This implies that for any projection $P \in \mathcal{A}_{\hbar}^{\infty}$

In the language of noncommutative geometry our trace $\tau_{0}:=\widetilde{\operatorname{tr}}_{\mathbb{Z}^{2}}$ is called the 0-cocycle. For the quantum Hall effect the 2 -cocycle $\tau_{2}$ with $a_{0}, a_{1}, a_{2} \in \mathcal{A}_{\hbar}^{\infty}$ is of particular importance

In particular, we write $\Theta\left(a_{0}\right):=\tau_{2}\left(a_{0}, a_{0}, a_{0}\right)$ and will revisit $\Theta$ in the Kubo-Chern formula for the Hall conductance. It follows then from [C94, Cor. 16 in Ch. III Sec. 3] (see also [C94, p. 359]) that for any $a_{0} \in K_{0}\left(\mathcal{A}_{\hbar}^{\infty}\right)$ one has

where $\gamma_{2} \in \mathbb{Z}$ coincides with the eponymous integer in (4.3).
The semiclassical description of the DOS in Theorem 3 implies together with the results from the previous paragraph, the following Proposition ${ }^{7}$ :

Proposition 4.2 (Quantum Hall effect). Let $h>0$ be small enough and consider zero disorder, i.e. $\lambda=0$. The Hall conductivity is then in the spectral gaps between closed Landau bands (3.42) for the discrete Schrödinger operators $H^{h}$ given by

& c_{H}\left(H^{h}\left(a_{\bigcirc}\right), \mu\right)=\left\{\begin{array}{l}
\frac{2 n+1}{2 \pi}, \mu \text { between } B_{\bigcirc, n} \& B_{\bigcirc, n+1} \text { with } 0 \leq n \leq N_{\circ}(h) \\
\frac{2 n-1}{2 \pi}, \mu \text { between } B_{\bigcirc, n-1} \& B_{\bigcirc, n} \text { with } 0 \geq n \geq-N_{\circ}(h) .
\end{array}\right. \tag{4.7}
\end{align*}

Proof. We just have to find the integer-valued coefficients in (4.3) which we can obtain from the semiclassical expressions for the DOS in Theorem 3. Since Theorem 3 does not allow us immediately to study spectral projections $\mathbb{1}_{I}\left(H_{\lambda, \omega}^{h}\right)$ we use smooth cutoff functions $\widetilde{\mathbb{1}}_{I}\left(H_{\lambda, \omega}^{h}\right)$ that coincide with the indicator function in the Landau bands and decay to zero in the spectral gaps (the DOS is supported on the spectrum, only). Theorem 3 implies that for Fermi energies $\mu$ between Landau bands

& \tilde{\operatorname{tr}}_{\Lambda}\left(\mathbb{1}_{[0, \mu]}\left(H_{\bigcirc}^{h}\right)\right)=\frac{h}{\pi\left|\vec{b}_{1} \wedge \vec{b}_{2}\right|} \sum_{n \in \mathbb{Z}} \mathbb{1}_{[0, \mu]}\left(z_{n}(h)\right)+\mathcal{O}\left(h^{\infty}\right) .

Since the Hall conductivity is constant in spectral gaps and continuous in the magnetic field, the $\mathcal{O}\left(h^{\infty}\right)$ error term in Theorem 3 does not contribute to (4.3). We therefore find in (4.3) that $\gamma_{1}=0$ and

[^5]Let us recall how the Hall conductivity relates to the geometric framework of condensed matter physics [B84], see also [S83], following the construction in [C94, p.237+238]: We study the algebra $\Omega^{*}:=\mathcal{A}_{\hbar}^{\infty} \otimes \wedge^{*} \mathbb{C}^{2}$. Using derivations (4.5), we can define the differentials

For forms of top degree there is the trace $\int: \Omega^{* 2} \rightarrow \mathbb{C}$ given by $\int a \otimes\left(\vec{e}_{1} \wedge \vec{e}_{2}\right)=a_{00}$. Let $p \in \mathcal{A}_{\hbar}^{\infty}$ be a projection with module $M^{\infty}:=p \mathcal{A}_{\hbar}^{\infty}$. For $m \in M^{\infty}$ and $a \in \mathcal{A}_{\hbar}^{\infty}$ we define connections (Berry connections) $\nabla_{i}: M^{\infty} \rightarrow M^{\infty}$

The curvature tensor (Berry curvature), is then defined as $R:=\left[\nabla_{1}, \nabla_{2}\right] \otimes\left(\vec{e}_{1} \wedge \vec{e}_{2}\right)$.
The first Chern number (Berry phase) is an invariant of the module, independent of the connection, defined by $\operatorname{Ch}(p):=(2 \pi i)^{-1} \int R=(2 \pi i)^{-1} \Theta(p)$.

With this vocabulary at hand, we now come to an equivalent second definition of the Hall conductivity:

Definition 4.3 (Kubo-Chern formula). Let $\mu$ be an energy in an a.s. spectral gap of $A^{h}\left(a_{\lambda, \omega}\right)$ with associated spectral projection $P_{A}:=\mathbb{1}_{(-\infty, \mu]}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)$, then the conductivity tensor $\left(\sigma_{j k}\right)_{j k} \in \mathbb{C}^{2 \times 2}$ satisfies

The following Proposition states that the definitions of the Hall conductivity by the Kubo-Chern and Strreda formula yield the same result and are the same for all equivalent versions of the (random) DML:

Let $I$ be an interval such that $\partial I$ is in an a.s. spectral gap of $A^{h}\left(a_{\lambda, \omega}\right)$ and let $P_{A}:=\mathbb{1}_{I}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)$, then the Středa formula agrees with the off-diagonal conductivity in the Kubo-Chern formula

& =\mathbb{E} \operatorname{tr}\left(\left\langle U^{*} \delta_{0}, P_{H}\left[\left[P_{H}, X_{1}\right],\left[P_{H}, X_{2}\right]\right] U^{*} \delta_{0}\right\rangle\right)  \tag{4.12}\\
& =\mathbb{E} \operatorname{tr}_{\mathbb{C}^{n}}\left(\left\langle\delta_{0}, P_{A}\left[\left[P_{A}, x_{1}\right],\left[P_{A}, x_{2}\right]\right] \delta_{0}\right\rangle\right) \\
& =\widetilde{\operatorname{tr}}_{\mathbb{Z}^{2}}\left(P_{A}\left[\left[P_{A}, x_{1}\right],\left[P_{A}, x_{2}\right]\right]\right) .
\end{align*}
$$
\]

Finally, we shall use a third way of expressing the Hall conductivity using the relative index of projections. This representation is due to Avron, Seiler, and Simon [ASS94]. The version used here can be found in [AW15, Ch.14.5].

Definition 4.5 (Index-theoretic formulation). Let $P_{\lambda, \omega}$ be an orthogonal projection on $\ell^{2}\left(\mathbb{Z}^{2}\right)$ satisfying the covariance relation $\tau_{\gamma}^{h} P_{\lambda, T_{\gamma} \omega}=P_{\lambda, \omega} \tau_{\gamma}^{h}$ with translations (3.9) such that

Using unitary operators $\left(U_{a} \psi\right)(x):=e^{-i \theta_{a}(x)} \psi(x)$ with $\theta_{a}(x):=\arg (x-a) \in(-\pi, \pi],{ }^{9}$ the off-diagonal component of the conductivity tensor $\sigma_{1,2}$ is given by the almost sure and $a \in \mathbb{T}_{2}^{*}$ independent value of the relative index

$$
2 \pi \sigma_{1,2}=\operatorname{ind}\left(P_{\lambda, \omega}, U_{a} P_{\lambda, \omega} U_{a}^{*}\right)=\mathbb{E} \operatorname{tr}\left(P_{\lambda, \omega}-U_{a} P_{\lambda, \omega} U_{a}^{*}\right)^{3}
$$

and coincides, if $P_{\lambda, \omega}$ is a spectral projection satisfying the conditions of Proposition 4.4, with the value given by the Kubo-Chern formula in Definition 4.3.

Remark 3. The index theoretic formulation implies that the Hall conductivity is integer-valued (up to the prefactor $(2 \pi)^{-1}$ ) under disorder, too. This follows of course also from the Kubo-Chern formula using the approach presented in [BES94].

The index theoretic formulation of the Hall conductivity implies that the Hall conductivity is invariant, see Proposition 4.2, under mild disorder in the spectral gaps between closed disorder-broadened Landau bands:

Proof of Proposition 1.1. Consider a Fermi level $\mu$ between disorder-broadened Landau bands $\mathcal{B}_{n, \lambda}$ and $\mathcal{B}_{n+1, \lambda}$, i.e. $\mu$ is in a spectral gap of $A^{h}\left(a_{\lambda, \omega}\right)$. We need to show that for Fermi projections $P_{\lambda, \omega}:=\mathbb{1}_{(-\infty, \mu]}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)$ and $\lambda$ sufficiently close to zero, we have almost sure equality

\begin{equation*}
\operatorname{ind}\left(P_{\lambda, \omega}, U_{a} P_{\lambda, \omega} U_{a}^{*}\right)=\operatorname{ind}\left(P_{0, \omega}, U_{a} P_{0, \omega} U_{a}^{*}\right) \tag{4.14}
\end{equation*}
$$

[^7]By the resolvent identity and holomorphic functional calculus we find for the difference

which implies that $\lim _{\lambda \downarrow 0} P_{\lambda, \omega} x=P_{0, \omega} x$ by dominated convergence, which can be argued using the usual Combes-Thomas estimate for the pointwise bound.

Let $T_{\lambda, \omega}=P_{\lambda, \omega}-U_{a} P_{\lambda, \omega} U_{a}^{*}$ be the difference operator, we then find

& \left|\operatorname{ind}\left(P_{\lambda, \omega}, U_{a} P_{\lambda, \omega} U_{a}^{*}\right)-\operatorname{ind}\left(P_{0, \omega}, U_{a} P_{0, \omega} U_{a}^{*}\right)\right|=\left|\operatorname{tr}\left(T_{\lambda, \omega}^{3}\right)-\operatorname{tr}\left(T_{0, \omega}^{3}\right)\right| \\
& \leq\left|\sum_{|\gamma| \leq n} \operatorname{tr}_{\mathbb{C}^{n}}\left\langle\delta_{\gamma},\left(T_{\lambda, \omega}^{3}-T_{0, \omega}^{3}\right) \delta_{\gamma}\right\rangle\right|+\left|\sum_{|\gamma|>n} \operatorname{tr}_{\mathbb{C}^{n}}\left\langle\delta_{\gamma},\left(T_{\lambda, \omega}^{3}-T_{0, \omega}^{3}\right) \delta_{\gamma}\right\rangle\right| . \tag{4.15}
\end{align*}

It suffices to argue that for $\lambda$ small, the difference of indices is less than one almost surely to show (4.14). The first term on the right hand side is continuous in $\lambda$ by strong convergence and can therefore (for any fixed threshold $n$ ) be made arbitrarily small by taking $\lambda$ small enough. Thus, by Hölder's inequality we find for the second term

We can then use the elementary identity

see [AW15, (14.24)], to estimate [AW15, Lemma 14.3 and (14.27)]

\mathbb{E}\left\|T_{\lambda, \omega} \delta_{|\gamma|>n}\right\|_{\mathcal{L}^{3}} & \lesssim \sum_{y \in \mathbb{Z}^{2}} \mathbb{E}\left(\sum_{|x|>n}\left|T_{\lambda, \omega}[x+y, x]\right|^{3}\right)^{1 / 3} \\
& \lesssim \sum_{y \in \mathbb{Z}^{2}}\left(\sum_{|x|>n} \mathbb{E}\left|P_{\lambda, \omega}[x+y, x]\right|^{3}\left|e^{-i \theta_{\alpha}(x+y)}-e^{-i \theta_{\alpha}(x)}\right|^{3}\right)^{1 / 3} \\
& \lesssim \sum_{y \in \mathbb{Z}^{2}}\left(\mathbb{E}\left|P_{\lambda, \omega}[y, 0]\right|^{3}\right)^{1 / 3}\left(\sum_{|x|>n}\left|e^{-i \theta_{\alpha}(x+y)}-e^{-i \theta_{\alpha}(x)}\right|^{3}\right)^{1 / 3}<\infty . \tag{4.17}
\end{align*}

The standard Combes-Thomas estimate implies that (4.13) is uniformly bounded for $\lambda \in\left(0, \lambda_{0}\right)$. This implies that the summand in (4.17) is uniformly bounded and by the dominated convergence theorem, this expression goes to zero as $n \rightarrow \infty$.

## 5. The metal/insulator transition

5.1. Measures of transport. For our discussion of metal/insulator transitions, we first recall the definition of transport coefficients stated in [GK04]. Even though the results in that article are stated for non-magnetic Schrödinger operators, the results still apply to(discrete) magnetic Schrödinger operators as the authors state in the beginning of Section 4 in [GKS04]. Dynamical properties are studied using weighted norms

where $\zeta \in C_{c,+}^{\infty}(\mathbb{R})$ localizes to a fixed energy window. In particular, we say that at energies $E, H_{\lambda, \omega}^{h}$ exhibits Hilbert-Schmidt localization if there is an open interval $I \ni E$ such that for all $\zeta \in C_{c,+}^{\infty}(I)$ and all $p>0$

The union of all such energies comprises the set $\Sigma_{\lambda}^{h, \text { loc }}$. We also define expected timeCésaro averages

M_{\lambda}^{h}(p, \zeta, T)=\frac{1}{T} \int_{0}^{\infty} \mathbb{E}\left(M_{\lambda, \omega}^{h}(p, \zeta, t)\right) e^{-t / T} d t
$$

The (lower) transport exponent is defined by

$$
\beta_{\lambda}^{h}(p, \zeta)=\liminf _{T \rightarrow \infty} \frac{\log _{+} M_{\lambda}^{h}(p, \zeta, T)}{p \log (T)}, \text { for } p>0, \zeta \in C_{c,+}^{\infty}(\mathbb{R})
$$

and from this one defines the $p$-th local transport exponent

$$
\beta_{\lambda}^{h}(p, E)=\inf _{I \ni E} \sup _{\zeta \in C_{c,+}^{\infty}(I)} \beta_{\lambda}^{h}(p, \zeta) \in[0,1] .
$$

The local lower transport exponent is then defined as $\beta_{\lambda}^{h}(E):=\sup _{p>0} \beta_{\lambda}^{h}(p, E)$. The exponent $\beta_{\lambda}^{h}(E)$ is a measure of transport at energy $E$. This coefficient allows us to define two complementary regions, the (relatively open) region of dynamical localization or insulator region

\Sigma_{\lambda}^{h, \mathrm{DL}}=\left\{E \in \mathbb{R} ; \beta_{\lambda}^{h}(E)=0\right\} \tag{5.1}
\end{equation*}
$$

that coincides with $\Sigma_{\lambda}^{h, \text { loc }}$ [GK04, Theorem 2.8], and the (relatively closed) region of dynamical delocalization or metallic transport region

$$
\begin{equation*}
\Sigma_{\lambda}^{h, \mathrm{DD}}=\left\{E \in \mathbb{R} ; \beta_{\lambda}^{h}(E)>0\right\} \tag{5.2}
\end{equation*}
$$

An energy $E$ at which the transport coefficient $\beta_{\lambda}^{h}$ jumps from zero to a non-zero value is called a mobility edge.

Remark 4. [GK04, Theorem 2.10] implies that in two dimensions, the random Schrödinger operator $H_{\lambda, \omega}^{h}$ has the property that for all $E \in \mathbb{R}$ for which the transport exponent is positive $\beta_{\lambda}^{h}(E)>0$, the coefficient satisfies already $\beta_{\lambda}^{h}(E)>1 / 4$.

Fix $\varepsilon>0$ and let $K$ be the multiplication operator by $\langle x\rangle^{1+\varepsilon}$. The random measure of $H_{\lambda, \omega}^{h}$ is defined for Borel sets $B \subset \mathbb{R}$ by $\mu_{\lambda, \omega}(B):=\left\|K^{-1} \mathbb{1}_{B}\left(H_{\lambda, \omega}^{h}\right)\right\|_{\mathcal{L}^{2}}^{2}$, is supported on the spectrum of $H_{\lambda, \omega}^{h}$, such that $\mu_{\lambda, \omega}(B)<\infty$ if $B \subset \Sigma\left(H_{\lambda, \omega}^{h}\right)$ is bounded.

Whenever the multiscale analysis in [GK06], which applies to magnetic Schrödinger operators, as explained in the beginning of their Section 2, applies to energies in the region of dynamical localization, this has a strong implication on the eigenfunctions that the authors call summable uniform decay of eigenfunction correlations (SUDEC), see [GK06, Cor. 3], which we recall in the following Definition:

Definition 5.1 (SUDEC). For a bounded interval I with $\bar{I} \subset \Sigma_{\lambda}^{h, D L}\left(H_{\lambda, \omega}^{h}\right)$, we say that $H_{\lambda, \omega}^{h}$ exhibits SUDEC in I if the spectrum of $H_{\lambda, \omega}^{h}$ is a.s. pure point and for each eigenvalue $E_{n, \omega, \lambda} \in I$ there is an $\operatorname{ONB}\left(\phi_{n, j, \lambda, \omega}\right)_{j \in\left\{1, \ldots, \nu_{n, \lambda, \omega}\right\}}$ of the finite-dimensional eigenspace $\operatorname{ker}\left(H_{\lambda, \omega}^{h}-E_{n, \omega, \lambda}\right)$ such that for any $\xi \in(0,1)$ there is $C_{I, \lambda, \omega, \xi}>0$ such that

$$
\begin{equation*}
\left\|\phi_{n, i, \lambda, \omega}(x)\right\|\left\|\phi_{n, j, \lambda, \omega}(y)\right\| \leq C_{I, \xi, \omega, \lambda} \sqrt{\alpha_{n, i, \lambda, \omega}} \sqrt{\alpha_{n, j, \lambda, \omega}}\langle x\rangle^{1+\varepsilon}\langle y\rangle^{1+\varepsilon} e^{-|x-y|^{\xi}} \tag{5.3}
\end{equation*}
$$

Moreover, $\sum_{n \in \mathbb{N}, j \in\left\{1,2, \ldots, \nu_{n, \lambda, \omega}\right\}} \alpha_{n, j, \lambda, \omega}=\mu_{\lambda, \omega}(I)$.
It follows from standard arguments that the operator $H_{\lambda, \omega}^{h}$, and equivalently $A^{h}\left(a_{\lambda, \omega}\right)$ satisfy SUDEC in the regime of dynamical localization.
5.2. Dynamical delocalization. We now turn to the proof of Theorem 2 showing that between disjoint disorder-broadened Landau bands there exists a mobility edge.

We study covariant projections that satisfy the following condition:
Definition $5.2(\mathbf{P})$. A covariant projection on $\ell^{2}\left(\mathbb{Z}^{2} ; \mathbb{C}^{n}\right)$ is said to satisfy condition (P) if for constants $\xi \in(0,1), k>0$, and $K_{P}<\infty$ the following bound holds

$$
\|P[0, x]\|=\left\|\left\langle\delta_{0}, P \delta_{x}\right\rangle\right\| \leq K_{P}\langle x\rangle^{k} e^{-|x|^{\xi}}
$$

Clearly, for covariant eigenprojections $P_{\lambda, \omega}:=\mathbb{1}_{E_{n, \omega, \lambda}}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)$ on a single energy, (SUDEC) implies $(P)$ with $k=1+\varepsilon$ and $K_{P}:=C_{I, \xi, \omega, \lambda} \sum_{i=1}^{\nu_{n, \lambda, \omega}} \alpha_{n, i, \lambda, \omega}$.

The index formulation of the Hall conductivity implies immediately by the cyclicity of the trace that if $P$ is a covariant finite-rank projection satisfying (4.13) then

\begin{equation*}
\operatorname{ind}\left(P_{\lambda, \omega}, U_{a} P_{\lambda, \omega} U_{a}^{*}\right)=\operatorname{tr}\left(P_{\lambda, \omega}-U_{a} P_{\lambda, \omega} U_{a}^{*}\right)=0 \tag{5.4}
\end{equation*}
$$

Moreover, for two orthogonal covariant projections satisfying sufficient decay properties one finds that [BES94, Sec.E Lem.12] for $\Theta$ as in Definition 4.3

\begin{equation*}
\Theta(P+Q)=\Theta(P)+\Theta(Q) \tag{5.5}
\end{equation*}
$$

Lemma 5.3. Let $P$ be a covariant projection satisfying condition $(\mathrm{P})$. Then the quantity $\Theta(P)$ is finite and is bounded for any $\xi \in(0,1)$ by a finite constant $C_{\xi, \kappa}>0$

\left\|\mathbb{E}\left\langle\delta_{0}, P\left[\left[P, x_{1}\right],\left[P, x_{2}\right]\right] \delta_{0}\right\rangle\right\| \leq K_{P} C_{\xi, \kappa} .
$$

Proof. Condition $(P)$ implies the following bound

& \left\|\mathbb{E}\left\langle\delta_{0}, P\left[\left[P, x_{1}\right],\left[P, x_{2}\right]\right] \delta_{0}\right\rangle_{\ell^{2}}\right\|_{\mathbb{C}^{n}}=\|\left\langle\mathbb{E}\left\langle\left[\left[x_{1}, P\right], P\right] \delta_{0},\left[x_{2}, P\right] \delta_{0}\right\rangle_{\ell^{2}} \|_{\mathbb{C}^{n}}\right. \\
& \quad \leq \sqrt{\mathbb{E}\left\|\left[\left[x_{1}, P\right], P\right] \delta_{0}\right\|_{\ell^{2}}^{2} \sqrt{\mathbb{E}\left\|x_{2} P \delta_{0}\right\|_{\ell^{2}}^{2}} \lesssim \sqrt{\mathbb{E}\left\|x_{1} P \delta_{0}\right\|_{\ell^{2}}^{2}} \sqrt{\mathbb{E}\left\|x_{2} P \delta_{0}\right\|_{\ell^{2}}^{2}}} \begin{array}{l}
\quad \lesssim \mathbb{E}\left\|x_{1} P \delta_{0}\right\|_{\ell^{2}}^{2}+\mathbb{E}\left\|x_{2} P \delta_{0}\right\|_{\ell^{2}}^{2} \lesssim \sum_{x \in \mathbb{Z}^{2}}\|x\|_{\mathbb{C}^{n}}^{2} \mathbb{E}\left\|\left\langle\delta_{0}, P \delta_{x}\right\rangle_{\ell^{2}}\right\|^{2} \\
\quad \lesssim K_{P}^{2} \sum_{x \in \mathbb{Z}^{2}}\|x\|_{\mathbb{C}^{n}}^{2(1+k)} e^{-2\|x\|^{\xi}} \lesssim K_{P}^{2} C_{\xi, \kappa}^{2} .
\end{array} .
\end{align*}
$$

We can now finish the proof of Theorem 2:

Proof of Theorem 2. Let us assume that $H_{\lambda, \omega}^{h}$ would have only spectrum belonging to the region of dynamical localization. For an interval $I=\left[\lambda_{1}, \lambda_{2}\right]$ where $\lambda_{1}$ is in one spectral gap between disorder-broadened Landau bands and $\lambda_{2}$ in another such gap, it follows for $\mathcal{E}_{\lambda, \omega}$ the set of eigenvalues of $H_{\lambda, \omega}^{h}$ in $I$ and $\mathcal{E}_{\lambda, \omega}=\bigcup_{m \in \mathbb{N}} \mathcal{M}_{m}$ with $\mathcal{M}_{m}$ a subset of $\mathcal{E}_{\lambda, \omega}$ of cardinality $\min \left\{m, \operatorname{dim}\left(\operatorname{ran}\left(\mathbb{1}_{I}\left(H_{\lambda, \omega}^{h}\right)\right)\right\}\right.$

$$
\begin{equation*}
\Theta\left(\mathbb{1}_{I}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)\right)=\underbrace{\sum_{E_{n, \lambda, \omega} \in \mathcal{M}_{m}} \Theta\left(\mathbb{1}_{E_{n, \lambda, \omega}}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)\right)}_{=0}+\Theta\left(\mathbb{1}_{\mathcal{E}_{\lambda, \omega} \backslash \mathcal{M}_{m}}\left(A^{h}\left(a_{\lambda, \omega}\right)\right)\right) \tag{5.7}
\end{equation*}
$$

which vanishes by letting $m \rightarrow \infty$ due to (SUDEC) and Definition 5.2. Hence, the Hall conductivity must not jump for operators $H_{\lambda, \omega}^{h}$ which contradicts the findings of Proposition 1.1.

Remark 5. To prove delocalization, the type of disorder was in so far irrelevant, as we only assumed the disorder to be small. Other discrete models to which this argument applies are discussed in [GK01, Remark 3.13].

## 6. Honeycomb structures with flux close to a rational

Hitherto, we studied the case of small magnetic flux $h>0$ on both the square and hexagonal lattice. We will now continue by studying small magnetic perturbations of rational magnetic fluxes $2 \pi p / q$ for the hexagonal lattice, see [HS88] for a similar analysis in case of Harper's model.

We start by showing the existence of Dirac cones for rational flux $\phi=2 \pi p / q$ for $H_{\circ}^{\phi}$ at energy level 0 . In the sequel, we write $\phi$ for the magnetic flux and use the variable $h$ to denote small perturbations thereof.
6.1. Dirac points. For magnetic flux $\phi=2 \pi p / q, H_{\circ}^{\phi}$ is a periodic operator. Let $k=\left(k_{1}, k_{2}\right) \in \mathbb{T}_{2}^{*}$, and let $H_{\circ}^{\phi}(k)$ be the operator $H_{\circ}^{\phi}$ on $\ell^{2}(\Lambda)$ subject to the pseudoperiodic condition:

$$
z\left(\gamma+q \vec{b}_{l}, r_{j}\right)=e^{i k_{l}} z\left(\gamma, r_{j}\right), \quad j, l=1,2
$$

where $\left\{\vec{b}_{1}, \vec{b}_{2}\right\}$ is the basis vector of $\Lambda$ and $\left\{r_{0}, r_{1}\right\}$ are the vertices in the fundamental domain $W_{\Lambda}$.

We say that an energy $E$ corresponding to some quasi-momentum $\tilde{k}$ in the dispersion surface of $H_{\circ}^{\phi}$ is a Dirac point, if in a neighbourhood of such quasi-momentum, for some positive $c>0$, there are two distinct branches of eigenvalues $F_{ \pm}\left(H_{\circ}^{\phi}(k)\right)$ such that

\begin{align*}
& F_{ \pm}\left(H_{\bigcirc}^{\phi}(\tilde{k})\right)=E \quad \text { and } \\
& F_{ \pm}\left(H_{\bigcirc}^{\phi}(k)\right)-E= \pm c|k-\tilde{k}|+\mathcal{O}\left(|k-\tilde{k}|^{2}\right) . \tag{6.1}
\end{align*}
$$

Next we will present the proof of Theorem 1.


Figure 5. Dispersion surface of $H_{\emptyset}^{\phi}$. The Dirac cones at energy level zero persist for magnetic flux $\phi=\pi$.

Proof of Theorem 1. The proof is built on some results of [HKL16]. Recall $H_{\circ}^{\phi}$ is a tight-binding Schrödinger operator with flux $\phi$ on the hexagonal lattice, acting on $\ell^{2}\left(\mathbb{Z}^{2}, \mathbb{C}^{2}\right)$.

The Floquet matrix of $H_{\circ}^{\phi}(k)$ is

\end{array}\right)=:\left(\begin{array}{cc}
0 & \mathcal{A} \\
\mathcal{A}^{*} & 0
\end{array}\right)

where $J_{p, q}$ and $K_{q}$ are $q \times q$ matrices, which are defined as

Proposition 6.1. We have

- $\left\{B_{j}\right\}_{j=1}^{2 q}$ are non-overlapping.
- $B_{q} \cap B_{q+1}=\{0\}$.

The set $S_{j}:=\left\{\left(k, F_{j}(k)\right): k \in \mathbb{T}_{2}^{*}\right\}$ is called the $j$-th dispersion surface.
Taking the square of $M_{\odot}(k)$, we arrive at

& +e^{i\left(k_{1}-k_{2}\right)} K_{q}^{*} J_{p, q}+e^{-i\left(k_{1}-k_{2}\right)} J_{p, q}^{*} K_{q}, \tag{6.6}
\end{align*}

and for $M_{T}(k)$ one just exchanges $J_{p, q}$ and $K_{q}$. Furthermore, $M_{T}(k)$ and $\widehat{M}_{T}(k)$ have the same non-zero eigenvalues. Let us denote the eigenvalues of $M_{T}(k)$ by $\left\{E_{j}(k)\right\}_{j=1}^{p}$, where each $E_{j}$ is an analytic function in $k$, note that we do not arrange them in increasing order here. Clearly we have

Differentiating (6.20) again w.r.t. $k_{j}, j=1,2$, we have

& \left\{\begin{aligned}
& 2 q^{2} \cos q\left(k_{1}-k_{2}\right)=\sum_{\substack{m, \ell=1 \\
m \neq \ell}}^{q} \frac{\partial E_{m}}{\partial k_{1}}(k) \frac{\partial E_{\ell}}{\partial k_{2}}(k) \prod_{\substack{j=1, \ell \\

& 2 q^{2}(-1)^{q+1}\left(-\cos q k_{2}+(-1)^{q} \cos q\left(k_{1}-k_{2}\right)\right)=\sum_{\substack{m, \ell=1 \\
m \neq \ell}}^{q} \frac{\partial E_{m}}{\partial k_{2}}(k) \frac{\partial E_{\ell}}{\partial k_{2}}(k) \prod_{\substack{j=1 \\
j \neq m, \ell}}^{q}\left(E_{j}(k)-\lambda\right) \\
& +\sum_{m=1}^{q} \frac{\partial^{2} E_{m}}{\partial k_{2}^{2}}(k) \prod_{\substack{j=1 \\
j \neq m}}^{q}\left(E_{j}(k)-\lambda\right) \tag{6.21}
\end{align*}

We plug in $k=\tilde{k}$ and $\lambda=-3$. Using (6.9) and (6.10), we have

2 q^{2} \cos q\left(\tilde{k}_{1}-\tilde{k}_{2}\right)=\frac{\partial^{2} E_{1}}{\partial k_{1} \partial k_{2}}(\tilde{k}) \prod_{j=2}^{q}\left(E_{j}(\tilde{k})+3\right) \\
2 q^{2}(-1)^{q+1}\left(-\cos q \tilde{k}_{2}+(-1)^{q} \cos q\left(\tilde{k}_{1}-\tilde{k}_{2}\right)\right)=\frac{\partial^{2} E_{1}}{\partial k_{2}^{2}}(\tilde{k}) \prod_{j=2}^{q}\left(E_{j}(\tilde{k})+3\right)
\end{array}\right.

Hence the Hessian matrix

clearly $\tilde{y}:=y(\tilde{k})=0$ and $\tilde{\eta}:=\eta(\tilde{k})=0$. Let $\widetilde{E}_{1}(y, \eta):=E_{1}\left(k_{1}, k_{2}\right)$. One then checks that using (6.24)

1 & 0 \\
0 & 1
\end{array}\right)  \tag{6.26}\\
& \text { with }\left(\frac{\partial\left(k_{1}, k_{2}\right)}{\partial(y, \eta)}(0,0)\right)=\left(\begin{array}{ll}
2^{-1 / 2} 3^{1 / 4} & 2^{-1 / 2} 3^{-1 / 4} \\
2^{-1 / 2} 3^{1 / 4} & -2^{1 / 2} 3^{-1 / 4}
\end{array}\right) .

6.2. Semiclassical analysis close to any rational. In this subsection, we use variables $(x, \xi)$ instead of $k=\left(k_{1}, k_{2}\right)$ to emphasize the underlying phase space structure. This will generalise magnetic matrices in Def.3.7 and their connection to pseudodifferential operators as in Def.3.4. For the study of magnetic fluxes $\phi=2 \pi \frac{p}{q}+h$ with $\operatorname{gcd}(p, q)=1$, we use that [HS90a, Sec.1] there is a $C^{*}$-homomorphism mapping scalarvalued $\Psi$ DOs with $\mathbb{Z}_{*}^{2}$-periodic Weyl symbol

to matrix-valued $\Psi \mathrm{DOs} \mathrm{Op}_{h}^{\mathrm{w}}\left(\widehat{\Phi\left(a_{\odot}\right)}\right)$ on $L^{2}\left(\mathbb{R}, \mathbb{C}^{2} \otimes \mathbb{C}^{q}\right)$ with symbols that are the Fourier transform of

\Phi\left(a_{\odot}\right)=\left(e^{-i \gamma_{1} \gamma_{2} h / 2} a_{\odot}(\gamma) \otimes\left[\left(J_{p, q}\right)^{\gamma_{1}}\left(K_{q}^{*}\right)^{\gamma_{2}}\right]\right)_{\gamma \in \mathbb{Z}^{2}}

with $J_{p, q}$ and $K_{q}$ as in (6.3) and (6.4). Note that $\gamma_{1} \gamma_{2}=0$ for any $a_{\oslash}(\gamma) \neq 0$, hence

and, as follows by combining [KL14, Theo. 2.1] with [HS90a, 1.2], also spectra

Recall that $M_{\bigcirc}=\widehat{\Phi\left(a_{\odot}\right)}$, see (6.2). We conclude by (3.16),(3.18),(3.30), and (6.29) that for $M_{\bigcirc}^{\mathrm{w}}\left(x, h p_{x}\right)=\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}$,

We are concerned with the analysis of this operator close to the Dirac energy $E=0$. To analyze the spectrum of $M_{\circ}^{\mathrm{w}}\left(x, h p_{x}\right)$ close to energies $E=0$, we want to focus on the two bands touching at $E=0$, first.

The obstruction to do so, is that for rational flux $2 \pi \underset{q}{p}$ the two bands touching at $E=0$ may not be isolated from the rest of the spectrum, cf. Fig. 5. At first glance, this creates an obstruction to block-diagonalize the operator $\mathrm{Op}_{h}^{\mathrm{w}} M_{\circ}$ at zero energy to leading order. A way to overcome this issue is explained in the following remark:

Remark 6 (Isolating bands touching at Dirac energies). We recall that $M_{0}$ vanishes only at points $z_{0}:=\left(x_{0}, \xi_{0}\right)$ as defined in (6.16) or (6.17), respectively. To analyze the operator $\mathrm{Op}_{h}^{w} M_{\bigcirc}$ in a neighbourhood of zero energy, it suffices therefore to consider an auxiliary operator with symbol

where $\chi \in C^{\infty}\left(\mathbb{R}^{2}\right)$ and $\chi(z)=1$ in a neighbourhood of $z_{0}$ and 0 outside. The parameter $\varepsilon$ is chosen small enough such that the two eigenvalues of $M_{\bigcirc}\left(2 \varepsilon \frac{\left(z-z_{0}\right)}{\left\|z-z_{0}\right\|}\right)$ that belong to the two bands which touch at the Dirac energies are distinct from all remaining eigenvalues of $M_{\bigcirc}\left(2 \varepsilon \frac{\left(z-z_{0}\right)}{\left\|z-z_{0}\right\|}\right)$. Such a parameter $\varepsilon>0$ exists since the remaining bands of $M_{\circ}$ are possible touching the two bands that make up the Dirac cones, but they are not intersecting, cf. Fig. 5.

This way, $\operatorname{Op}_{h}^{w}\left(\widetilde{M}_{\circ}\right)$ and $\operatorname{Op}_{h}^{w}\left(M_{\circ}\right)$ coincide microlocally, i.e for any $\chi \in C_{c}^{\infty}\left(\operatorname{nbhd}\left(z_{0}\right)\right)$ we have

see e.g. [Zw12, Theo. 4.25]. For our subsequent analysis, we may therefore just assume without loss of generality that the two touching bands of $M_{\bigcirc}$ at zero energy are gapped from the rest of its spectrum.

To analyze $\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}$, we recall a few properties about the matrix-valued symbol $M_{\bigcirc}$ first. Clearly, $\cup_{(x, \xi) \in \mathbb{T}_{*}^{2}} M_{\odot}(x, \xi)$ has band spectrum $B_{\ell}=\left[\gamma_{\ell}, \delta_{\ell}\right], 1 \leq \ell \leq 2 q$, and we denote associated energy eigenvalues by $\mu_{\ell}(x, \xi)$. The $q$-th and $q+1$-st band always touch at the Dirac point, i.e. $\delta_{q}=\gamma_{q+1}=0$ by Theorem 1. The phase space coordinates at which the $q$-th and $q+1$-st band touch are denoted by $z_{j}:=\left(x_{j}, \xi_{j}\right) \in \mathbb{T}_{*}^{2}$, where $j \in\left\{1, . ., 2 q^{2}\right\}$, i.e. $\mu_{q}\left(z_{j}\right)=\mu_{q+1}\left(z_{j}\right)=0$. There are by (6.16) and (6.17) precisely $2 q^{2}$ such points in a single fundamental domain $\mathbb{T}_{*}^{2}$. For the analysis close to individual conical points, we fix a sufficiently small $\varepsilon>0$ and consider energies $E \in I_{\varepsilon}=(-\varepsilon, \varepsilon)$. We define for such energies the phase space level set $\Sigma_{j}(E):=\left.\mu_{\ell}\right|_{\text {nhhd }\left(z_{j}\right)} ^{-1}(E) \subset \mathbb{T}_{*}^{2}$ for $\ell \in\{q, q+1\}$ here, close to a single potential well centred at $z_{j}$ and the phase space area $V_{j, \varepsilon}:=\bigcup_{E \in I_{\varepsilon}} \Sigma_{j}(E)$ of all energies in the interval $I_{\varepsilon}$.

Remark 6 allows us to make two simplifying coordinate changes near the conical points which we discuss now:

There exists a unitary operator $U$ such that ${ }^{10}$ [HS90a, Prop.3.1.1 \& Cor.3.1.2]

\end{array}\right)+\mathcal{O}(h) . \tag{6.32}
\end{align*}

The subscript $D$ stands for Dirac and $R$ for rest, and the symbol $b$ satisfies $b(x, \xi)=$ $\frac{v_{F}}{2}(\xi+i x)+\mathcal{O}\left(\|(x, \xi)\|^{2}\right)$ where the Fermi velocity $v_{F}$ satisfies by (6.8) and (6.28)

For the pseudodifferential operator $\mathrm{Op}_{h}^{\mathrm{w}} M_{\circ}=\left(\begin{array}{cc}\mathbf{0} & \mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A} \\ \mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A}^{*} & \mathbf{0}\end{array}\right)$, with $\mathcal{A}$ as in (6.2), we obtain by squaring the operator

By supersymmetry it follows that away from 0 both operators $\mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A} \mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A}^{*}$ and $\mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A}^{*} \mathrm{Op}_{h}^{\mathrm{w}} \mathcal{A}$ have the same spectrum. The principal symbols are

with the notation as in (6.5). Let $Z(x, \xi)$ now be either $M_{T}(x, \xi)+3 I_{q}$ or $\widehat{M_{T}}(x, \xi)+3 I_{q}$. The lowest eigenvalue of $Z(x, \xi)$ is given by a smooth scalar function $(x, \xi) \mapsto \nu(x, \xi)=$ $\left|\mu_{q+1}(x, \xi)\right|^{2}$, see Remark 6. Thus, there are analytic unitary matrices $V$ separating the lowest eigenvalue from the rest of the matrix

where by Remark 6 we may assume that $\inf _{(x, \xi) \in T^{*} \mathbb{R}}|\Sigma(B(x, \xi))-\nu(x, \xi)|>0$ and $B(x, \xi) \in \mathbb{C}^{(q-1) \times(q-1)}$.

Thus, as for the Dirac-type operator above, [HS90a, Prop. 3.1.1 \& Corr. 3.1.2] imply since the lowest band of $Z$, described by $\nu$, is gapped from the rest of the spectrum, there is a unitary operator $U$ and symbols $\widetilde{\nu}, \widetilde{B}$ with asymptotic expansions in $\mathcal{S}$, such that

where $\sigma_{0}(\widetilde{\nu})=\nu$ and $\sigma_{0}(\widetilde{B})=B$.

[^8]The main result of this section, a semiclassical trace formula close to rational flux, is then stated in the following Theorem:

Theorem 4 (Semiclassical DOS and QHE close to a rational). For small $h>0$ sufficiently small, with respect to $p, q$, and magnetic flux $\phi=2 \pi \frac{p}{q}+h$, the DOS of $H_{\square}^{\phi}$ admits the following expansion:
Let $I$ be an interval $I \subset(-\delta, \delta)$ for some $\delta>0$ sufficiently small ${ }^{11}$ and $f \in C_{\mathrm{c}}^{\alpha}(I)$, then

With the Fermi velocity $v_{F}$ defined in (6.33), $z_{n}$ satisfies

In addition, the spectrum of the magnetic Schrödinger operator around zero $\Sigma\left(H_{\circ}^{\phi}\right) \cap I$ is contained in disjoint closed Landau bands $B_{\bigcirc, n}(h, p, q) \ni z_{n}(h, p, q)$ with spectral gaps

An illustration of the Hall conductivities is given in Figure 6.
Remark 7 (Dynamical delocalization). In particular, using the results from Subsection 5.2, we conclude from (6.41) that for sufficiently weak disorder, such that the (disorderbroadened) Landau bands remain non-overlapping, there exists at least one mobility edge inside each Landau band at which delocalization occurs.

## 7. Proofs

We now state the proof of Theorems 3 and 4 with several references to details that are already discussed in [BZ19, HS88].

Proof of Thm. 3 G Thm. 4. Step 1: Quasimodes and Landau levels. Quasimodes and Landau levels are constructed as eigenfunctions and eigenvalues to localized operators, i.e. operators that coincide microlocally, up to a constant shift of the spectrum, with $\Psi$ DOs (3.28) in a neighbourhood of a single potential well. For the square lattice, such a localized operator with discrete spectrum at the bottom of the potential well, see Fig. 2, is defined by the Weyl symbol

0, & \|(x, \xi)-(\pi, \pi)\|_{\infty}>\frac{1}{5} .\end{cases} \tag{7.1}

Thus, $\mathrm{Op}_{h}^{\mathrm{w}} Q_{\square}^{0}-z$ is elliptic [Zw12, Sec. 4.7] for $z$ in a small neighbourhood of zero and $(x, \xi) \notin \operatorname{nbhd}(\pi, \pi)$ where the neighbourhood depends on $z$.

On the hexagonal lattice such a localized operator with discrete spectrum close to zero energy, the energy level of the Dirac points, see Fig. 3, is defined by the symbol

where $\chi_{0}(x, \xi)=1$ on all $\cup_{j \in\left\{1, ., 2 q^{2}\right\}} V_{j, \delta}$ for some $\delta>0$ sufficiently small and vanishes outside of $\mathbb{T}_{*}^{2}$.

Next, we argue that the spectrum of both $\mathrm{Op}_{h}^{\mathrm{w}} Q_{\square}^{0}$ and $\mathrm{Op}_{h}^{\mathrm{w}} M_{\circ}^{0}$ is indeed contained in discrete intervals around zero. To do so, we define another pair of symbols

The two associated operators with upper index 1 are invertible close to zero and we have

for some compact operators

& K_{\bullet}(z)=\left(\mathrm{Op}_{h}^{\mathrm{w}} Q_{\curvearrowleft}^{1}-z\right)^{-1} \chi_{0}^{\mathrm{w}} \text { for } z \notin \Sigma\left(\mathrm{Op}_{h}^{\mathrm{w}} Q_{\square}^{1}\right) \text { and } \\
& K_{\bigcirc}(z)=\left(\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}^{1}-z\right)^{-1} \operatorname{diag}\left(\chi_{0}^{\mathrm{w}},-\chi_{0}^{\mathrm{w}}\right) \text { for } z \notin \Sigma\left(\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}^{1}\right) . \tag{7.5}

By analytic Fredholm theory [Zw12, Theorem D.4] this implies the discreteness of the spectrum of $Q_{\square}^{0}$ and $M_{\circ}^{0}$ close to zero. Thus, there exists a family of eigenvalues and orthonormal eigenfunctions such that

Localized operators with upper index 0 have the property that their spectra for energies close to zero stay close to the spectra of operators $\mathrm{Op}_{h}^{\mathrm{w}} Q_{\mathbf{\bullet}}$ and $\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}$, respectively. In fact, an immediate adaptation of the proof of [BZ19, Lemma 5.2] shows that after possibly shrinking the energy window around zero to some $\varepsilon_{1}$ with $0<\varepsilon_{1}<\varepsilon$ and $z \in\left[0, \varepsilon_{1}\right]-i[-1,1]$ such that $d\left(z, \Sigma\left(\mathrm{Op}_{h}^{\mathrm{w}} Q_{\mathbf{\square}}^{0}\right)\right)>h^{n}$, for some arbitrary but fixed $n \in \mathbb{N}$, there is $h_{0}$ such that for $h \in\left(0, h_{0}\right)$,

Since $\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}$ and $\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}^{0}$ in $\cup_{j \in\left\{1, . ., 2 q^{2}\right\}} V_{j, \delta}$ coincide microlocally we infer from (7.6) that

Thus, one has to find all such microlocal solutions with $\mathrm{WF}_{h}\left(u_{n, \odot}\right) \subset \cup_{j \in\left\{1, \ldots, 2 q^{2}\right\}} V_{j, \delta}$. Microlocal solutions $\left(\mathrm{Op}_{h}^{\mathrm{w}} M_{\bigcirc}-z\right) u=\mathcal{O}\left(h^{\infty}\right)$ for $z \geq c \sqrt{h}$ are in one-to-one correspondence with microlocal solutions $v \in \mathrm{WF}_{h}\left(u_{n, \bigcirc}\right) \subset \cup_{j \in\left\{1, \ldots, 2 q^{2}\right\}} V_{j, \delta}$ such that by (6.34)

Since 0 is in the spectrum of $H_{\circ}^{h}$ for all $h \in[0,2 \pi]$ [BHJ18, Lemma 5.1], we have that $0 \in \Sigma\left(\mathrm{Op}_{h}^{\mathrm{w}} M_{\circ}\right)$ for all $h$ by (6.30). Invoking now (7.7) for the hexagonal lattice, implies that there exists an eigenvalue $\mathcal{O}\left(h^{\infty}\right)$ to the localized operator $\mathrm{Op}_{h}^{\mathrm{w}} M_{\circ}^{0}$.

We can now apply the following Bohr-Sommerfeld condition [HR84, HS90a, CdV05]:
Let $H: T^{*} \mathbb{R} \rightarrow \mathbb{R}$ be a classical symbol with expansion $H \sim \sum_{i=0}^{\infty} H_{i} h^{i}$ Moreover, we assume the principal symbol $H_{0}$ to satisfy
(1) $H_{0}(z)=0$ and $\left(D^{2} H_{0}\right)(z)>0$,
(2) The set $\left\{\nu \in \mathbb{R}^{2}: H_{0}(\nu)<\delta\right\}$ is compact and connected for some $\delta>0$ sufficiently small.
(3) $H_{0}$ is strictly positive and does not possess any other critical points, apart from $z$ in a sufficiently small nbhd of $z$.

Then, the spectrum of $\mathrm{Op}_{h}^{\mathrm{w}}(H)$ close to zero is given by the Bohr-Sommerfeld condition

where the leading-order term is the Bohr-Sommerfeld term

Expressions for higher-order terms $F_{j}$ with $j \geq 2$ can be found in [CdV05].
This immediately yields the Bohr-Sommerfeld condition for the square lattice (3.34), by applying it to the microlocally equivalent symbol $Q_{\mathbf{a}}^{0}$ in (7.1), since the subprincipal is zero and therefore $F_{1}(E)=\frac{1}{2}$.

In case of the hexagonal lattice, we use that by (7.9) and (6.37) it suffices to study the quasimodes to the symbol $\widetilde{\nu}$. Clearly, $\widetilde{\nu}$ satisfies both assumptions (1) and (3) of the Bohr-Sommerfeld condition.

By using cut-off functions $\chi_{j, \circ}$ that are localized to neighbourhoods $V_{j, \delta}$ of a single well, the localized symbol

When $q=1$ and $\mathcal{A}$ is scalar, a direct computation of (7.10) shows that $F_{1}=0$ [BZ19-2]. This yields the Bohr-Sommerfeld condition stated in Theorem 3.

Finally for the analysis close to rationals, the asymptotics of Landau levels (6.40) and the presence of gaps (6.41) follow immediately from both (6.32) and (6.33), and the explicit spectral analysis of the $2 D$-magnetic Dirac operator, cf. [HS90a][Prop 3.6.1 and (3.6.22)].

Step 2: The Grushin problem. To prove the trace formulae, we fix one Landau level and take $z_{1}$ and $\varepsilon_{0}$ with

\tilde{\operatorname{tr}}_{\Lambda_{\bigcirc}}(P)=\left|\vec{b}_{1} \wedge \vec{b}_{2}\right|^{-1}\left(\gamma_{1}+\gamma_{2}\left(\frac{p}{q}+\frac{h}{2 \pi}\right)\right) . \tag{7.27}
\end{equation*}
$$

The trace formula (6.38) on the other hand yields that

$$
\begin{equation*}
\tilde{\operatorname{tr}}_{\Lambda_{\circlearrowright}}(P)=\frac{h q}{\left|\vec{b}_{1} \wedge \vec{b}_{2}\right| \pi} \sum_{n \in \mathbb{Z}} \mathbb{1}_{J}\left(z_{n}(h, p, q)\right)+\mathcal{O}\left(h^{\infty}\right) . \tag{7.28}
\end{equation*}
$$

Comparing coefficients (4.1) implies that the Hall conductivity, when gauged to be zero at zero energy, is given by (6.42) for sufficiently small $h$.
