# STABLE PAIR INVARIANTS OF LOCAL CALABI-YAU 4-FOLDS 

YALONG CAO, MARTIJN KOOL, AND SERGEJ MONAVARI


#### Abstract

In 2008, Klemm-Pandharipande defined Gopakumar-Vafa type invariants of a Calabi-Yau 4-fold $X$ using Gromov-Witten theory. Recently, Cao-Maulik-Toda proposed a conjectural description of these invariants in terms of stable pair theory.

When $X$ is the total space of the sum of two line bundles over a surface $S$, and all stable pairs are scheme theoretically supported on the zero section, we express stable pair invariants in terms of intersection numbers on Hilbert schemes of points on $S$. As an application, we obtain new verifications of the Cao-Maulik-Toda conjectures for low degree curve classes and find connections to Carlsson-Okounkov numbers. Some of our verifications involve genus zero Gopakumar-Vafa type invariants recently determined in the context of the log-local principle by Bousseau-Brini-van Garrel.

Finally, using the vertex formalism, we provide a few more verifications of the Cao-MaulikToda conjectures when thickened curves contribute and also for the case of local $\mathbb{P}^{3}$.


## 1. Introduction

1.1. GW/GV invariants of Calabi-Yau 4-folds. Gromov-Witten invariants are rational numbers, which are virtual counts of stable maps from curves to a fixed algebraic variety. Due to multiple cover contributions, they are in general not integers. For Calabi-Yau 4 -folds, KlemmPandharipande KP] defined Gopakumar-Vafa type invariants using Gromov-Witten theory and conjectured their integrality. More specifically, let $X$ be a smooth projective Calabi-Yau 4 -fold. Gromov-Witten invariants vanish for genus $g \geqslant 2$ for dimensional reasons and one only needs to consider the genus zero and one cases.

The genus zero Gromov-Witten invariants of $X$ for class $\beta \in H_{2}(X, \mathbb{Z})$ are defined using an insertion. Consider the evaluation map ev : $\bar{M}_{0,1}(X, \beta) \rightarrow X$. For $\gamma \in H^{4}(X, \mathbb{Z})$, one defines

The genus zero Gopakumar-Vafa type invariants

n_{0, \beta}(\gamma) \in \mathbb{Q} \tag{1.1}
\end{equation*}

are defined in KP by the identity

\sum_{\beta>0} \mathrm{GW}_{0, \beta}(\gamma) q^{\beta}=\sum_{\beta>0} n_{0, \beta}(\gamma) \sum_{d=1}^{\infty} d^{-2} q^{d \beta}
$$

where the sum is over all non-zero effective classes in $H_{2}(X, \mathbb{Z})$. For the genus one case, the virtual dimension of $\bar{M}_{1,0}(X, \beta)$ is zero and one defines

The genus one Gopakumar-Vafa type invariants

are defined in KP by the identity

\sum_{\beta>0} \mathrm{GW}_{1, \beta} q^{\beta}= & \sum_{\beta>0} n_{1, \beta} \sum_{d=1}^{\infty} \frac{\sigma(d)}{d} q^{d \beta}+\frac{1}{24} \sum_{\beta>0} n_{0, \beta}\left(c_{2}(X)\right) \log \left(1-q^{\beta}\right) \\
& -\frac{1}{24} \sum_{\beta_{1}, \beta_{2}} m_{\beta_{1}, \beta_{2}} \log \left(1-q^{\beta_{1}+\beta_{2}}\right)
\end{aligned}
$$

where $\sigma(d)=\sum_{i \mid d} i$ and $m_{\beta_{1}, \beta_{2}} \in \mathbb{Z}$ are called meeting invariants, which can be inductively determined by the genus zero Gromov-Witten invariants of $X$. In KP, both of the invariants (1.1), (1.2) are conjectured to be integers. Using localization techniques and mirror symmetry, they calculate the Gromov-Witten invariants of $X$ in numerous examples in support of their
integrality conjecture. The genus zero integrality conjecture has been proved by Ionel-Parker using symplectic geometry [IP, Thm. 9.2].
1.2. Stable pair invariants of Calabi-Yau 4-folds. Stable pairs were introduced in general by Le Potier LeP and used by Pandharipande-Thomas to define virtual invariants of smooth projective threefolds PT1, PT2, PT3. Stable pair invariants of threefolds are related to GromovWitten invariants by the celebrated GW/PT correspondence MNOP, PT1, which has been proved in many cases by Pandharipande-Pixton $\mathrm{PP} 1, \mathrm{PP} 2$.

In CMT2, Cao-Maulik-Toda studied stable pair theory of a smooth projective Calabi-Yau 4 -fold $X$. They used stable pair invariants of $X$ to give a sheaf theoretical interpretation of the Gopakumar-Vafa type invariants (1.1) and (1.2) ${ }^{1}$.

Let $P_{n}(X, \beta)$ be the moduli space of stable pairs $\left\{s: \mathcal{O}_{X} \rightarrow F\right\}$ with $\operatorname{ch}(F)=(0,0,0, \beta, n)$. There exists a virtual class

in the sense of Borisov-Joyce [BJ], which depends on the choice of an orientation of a certain (real) line bundle over $P_{n}(X, \beta)$ CGJ. For $\gamma \in H^{4}(X, \mathbb{Z})$, we define primary insertions

\tau: H^{4}(X, \mathbb{Z}) \rightarrow H^{2}\left(P_{n}(X, \beta), \mathbb{Z}\right), \quad \tau(\gamma)=\pi_{P *}\left(\pi_{X}^{*} \gamma \cup \operatorname{ch}_{3}(\mathbb{F})\right)
$$

where $\pi_{X}, \pi_{P}$ are projections from $X \times P_{n}(X, \beta)$ to the corresponding factors and

$$
\mathbb{I}^{\bullet}=\{\mathcal{O} \rightarrow \mathbb{F}\}
$$

is the universal stable pair on $X \times P_{n}(X, \beta)$. Note that $\operatorname{ch}_{3}(\mathbb{F})$ is Poincaré dual to the fundamental cycle of $\mathbb{F}$. The stable pair invariants of $X$ with primary insertions are defined by

\end{equation*}

When $n=0$, we simply denote this invariant by $P_{0, \beta}$. We set $P_{0,0}:=1$ and $n_{0,0}(\gamma):=0$.
Conjecture 1.1. (CMT2]) Let $X$ be a smooth projective Calabi-Yau 4-fold, $\beta \in H_{2}(X, \mathbb{Z})$, $\gamma \in H^{4}(X, \mathbb{Z})$, and $n \geqslant 1$. Then there exist choices of orientations such that

P_{n, \beta}(\gamma)=\sum_{\substack{\beta_{0}+\beta_{1}+\cdots+\beta_{n}=\beta \\ \beta_{0}, \beta_{1}, \ldots, \beta_{n} \geqslant 0}} P_{0, \beta_{0}} \cdot \prod_{i=1}^{n} n_{0, \beta_{i}}(\gamma)
$$

where the sum is over all effective decompositions of $\beta$.
Conjecture 1.2. ([CMT2]) Let $X$ be a smooth projective Calabi-Yau 4-fold. Then there exist choices of orientations such that

\sum_{\beta \geqslant 0} P_{0, \beta} q^{\beta}=\prod_{\beta>0} M\left(q^{\beta}\right)^{n_{1, \beta}}
$$

where $M(q)=\prod_{k \geqslant 1}\left(1-q^{k}\right)^{-k}$ denotes the MacMahon function.
Conjecture 1.1 can be interpreted as a wall-crossing formula in the category of D0-D2-D8 bound states in Calabi-Yau 4-folds CT1], while Conjecture 1.2 seems to be more mysterious. In CMT2, these conjectures were verified in the following cases (modulo some minor assumptions in some of the cases). In each case, Conjecture 1.1 was only verified for $n=1$.

- $X$ is a general sextic and $\beta=[\ell], 2[\ell]$, where $\ell \subseteq X$ is a line.
- $X$ is a Weierstrass elliptic fibration and $\beta=r[F]$, where $[F]$ is the fibre class and $r>0$ (in the case of Conjecture 1.1 only for $r=1$ ).
- $X=Y \times E$, where $Y$ is a smooth projective Calabi-Yau threefold, $E$ is an elliptic curve, and $\beta$ is the push-forward of an irreducible class on $Y \times\{\mathrm{pt}\}$.
- $X=Y \times E$, where $Y$ is a smooth projective Calabi-Yau threefold, $E$ is an elliptic curve, and $\beta=r[E]$, where $[E]$ is the fibre class and $r>0$ (Conjecture 1.2 only).
When $X$ is either the total space of a smooth projective Fano threefold, or the total space of $\mathcal{O}(-1) \oplus \mathcal{O}(-2)$ on $\mathbb{P}^{2}$, or $\mathcal{O}(-1,-1) \oplus \mathcal{O}(-1,-1)$ on $\mathbb{P}^{1} \times \mathbb{P}^{1}$, the moduli spaces $P_{n}(X, \beta)$ are projective and it makes sense to consider Conjectures 1.1 and 1.2 In this setting, the conjectures were verified in some cases for irreducible curve classes in CMT2.

One of the main goals of this paper is to provide more verifications for these local geometries for more general low degree curve classes.

[^0]1.3. Stable pair invariants of local surfaces. Let $S$ be a smooth projective surface and let $L_{1}, L_{2}$ be two line bundles on $S$ satisfying $L_{1} \otimes L_{2} \cong K_{S}$. Then the total space $X$ of $L_{1} \oplus L_{2}$ over $S$ is a non-proper Calabi-Yau 4 -fold, which we refer to as a local surface. Consider the moduli space $P_{n}(X, \beta)$ of stable pairs $(F, s)$ with $\chi(F)=n$ and such that $F$ has proper scheme theoretic support in class $\beta \in H_{2}(X, \mathbb{Z})$. Although $P_{n}(X, \beta)$ is in general non-proper, it can be proper in several interesting cases (Propositions (3.1) (3.8). Then we can define virtual classes (1.3) and corresponding stable pair invariants (1.4).
Example 1.3. For $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right)$ and $\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right)$, the moduli space $P_{n}(X, \beta)$ is projective for all $n, \beta$ (see Proposition 3.1).
Example 1.4. For $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right), P_{n}(X, \beta)$ is in general nonproper. E.g. let $H_{1}:=\{\mathrm{pt}\} \times \mathbb{P}^{1}$, take $\beta=\left[H_{1}\right]$, and $n=\chi\left(\mathcal{O}_{H_{1}}\right)=1$. Then $N_{H_{1} / X} \cong$ $\mathcal{O} \oplus \mathcal{O} \oplus \mathcal{O}(-2)$ has sections in the first fibre direction, so $H_{1} \subseteq \mathbb{P}^{1} \times \mathbb{P}^{1} \subseteq X$ can move off the zero section $\mathbb{P}^{1} \times \mathbb{P}^{1} \subseteq X$ and $P_{1}\left(X,\left[H_{1}\right]\right)$ is non-proper. On the other hand, for $H_{2}:=\mathbb{P}^{1} \times\{\mathrm{pt}\}$ and $\beta=\left[H_{2}\right]$, we have $\beta \cdot L_{1}<0$ and $\beta \cdot L_{2}<0$, so $P_{1}\left(X,\left[H_{2}\right]\right)$ is projective by Proposition 3.1,

When $S$ is toric, the local surface $X$ is toric and the vertex formalism for calculating stable pair invariants of $X$ has been developed in CK2, CKM in analogy with PT2. Let $T \subseteq\left(\mathbb{C}^{*}\right)^{4}$ denote the 3-dimensional subtorus preserving the Calabi-Yau volume form, then the fixed locus $P_{n}(X, \beta)^{T}$ consists of finitely many isolated reduced points [CK2, Sect. 2.2], though the number of fixed points is typically very large making calculations using the vertex formalism cumbersome.

Although we perform a few new calculations using the vertex formalism as well, we mainly focus on another approach, where we use the global geometry of $S$. We consider the case when all stable pairs on $X$ are scheme theoretically supported on the zero section $\iota: S \hookrightarrow X$, i.e. we have an isomorphism

Under this isomorphism, we have (Proposition 4.2)

\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}=(-1)^{\beta \cdot L_{2}+n} \cdot e\left(-\mathbf{R} \mathcal{H o m}_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)\right) \cdot\left[P_{n}(S, \beta)\right]^{\mathrm{vir}} \tag{1.5}
\end{equation*}
$$

where $\left[P_{n}(S, \beta)\right]^{\text {vir }}$ is the virtual class of the pairs obstruction theory on $S, e(\cdot)$ denotes Euler class, $\pi_{P_{S}}: S \times P_{n}(S, \beta) \rightarrow P_{n}(S, \beta)$ is the projection, $\mathbf{R} \mathcal{H o m} \pi_{\pi_{P_{S}}}=\mathbf{R} \pi_{P_{S^{*}}} \circ \mathbf{R} \mathcal{H} o m$, and $\mathbb{F}$ is the universal 1-dimensional sheaf on $S \times P_{n}(S, \beta)$. The $\operatorname{sign}(-1)^{\beta \cdot L_{2}+n}=(-1)^{\beta \cdot c_{1}(Y)+n}$, where $Y=\operatorname{Tot}_{S}\left(L_{1}\right)$, comes from a preferred choice of orientation on $P_{n}(X, \beta)$ which was discussed in a similar situation in CaO .

In order to use (1.5) for calculations, we need the fact that $P_{n}(S, \beta)$ is isomorphic to a relative Hilbert scheme. More precisely, assume $b_{1}(S)=0$ and denote by $|\beta|$ the linear system determined by $\beta$. Denote by $\mathcal{C} \rightarrow|\beta|$ the universal curve, then [PT3, Prop. B.8] gives

P_{n}(S, \beta) \cong \operatorname{Hilb}^{m}(\mathcal{C} /|\beta|),
$$

where $\operatorname{Hilb}^{m}(\mathcal{C} /|\beta|)$ denotes the relative Hilbert scheme of $m$ points on the fibres of $\mathcal{C} \rightarrow|\beta|$ and

$$
m=n+g(\beta)-1=n+\frac{1}{2} \beta\left(\beta+K_{S}\right)
$$

This isomorphism was exploited in order to determine the surface contribution to stable pair invariants of local surfaces $\operatorname{Tot}_{S}\left(K_{S}\right)$ in [KT2]. The relative Hilbert scheme $\operatorname{Hilb}^{m}(\mathcal{C} /|\beta|)$ is an incidence locus in a smooth ambient space

$$
\operatorname{Hilb}^{m}(\mathcal{C} /|\beta|) \subseteq S^{[m]} \times|\beta|,
$$

where $S^{[m]}$ denotes the Hilbert scheme of $m$ points on $S$. More precisely, $\operatorname{Hilb}^{m}(\mathcal{C} /|\beta|)$ is cut out tautologically by a section of a vector bundle on $S^{[m]} \times|\beta|$ as we recall in Section 4.1. This allows us to express the stable pair invariants of $X$ in terms of intersection numbers on $S^{[m]} \times|\beta|$, or more precisely, on the "virtual" ambient space $S^{[m]} \times \mathbb{P}^{\chi(\beta)-1}$, where

\chi(\beta):=\chi\left(\mathcal{O}_{S}(\beta)\right)
$$

In what follows, $\mathcal{Z} \subseteq S \times S^{[m]}$ denotes the universal subscheme and $\mathcal{I}$ is the corresponding ideal sheaf. For any line bundle $\mathcal{L}$ on $S$, the corresponding tautological bundle is defined by

\mathcal{L}^{[m]}:=p_{*} q^{*} \mathcal{L}
$$

where $p: \mathcal{Z} \rightarrow S^{[m]}$ and $q: \mathcal{Z} \rightarrow S$ are projections. Moreover, we consider the "twisted tangent bundle" CO12

$$
\begin{equation*}
T_{S^{[m]}}(\mathcal{L}):=\mathbf{R} \Gamma(S, \mathcal{L}) \otimes \mathcal{O}-\mathbf{R} \mathcal{H o m} m_{\pi}(\mathcal{I}, \mathcal{I} \boxtimes \mathcal{L}) \tag{1.6}
\end{equation*}
$$

where $\pi: S \times S^{[m]} \rightarrow S^{[m]}$ denotes projection. Finally, we denote the total Chern class by $c$ and the tautological line bundle on $\mathbb{P}^{\chi(\beta)-1}$ by $\mathcal{O}(1)$. We prove the following result (Theorem 4.4).

Theorem 1.5. Let $S$ be a smooth projective surface with $b_{1}(S)=p_{g}(S)=0$ and $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$. Suppose $\beta \in H_{2}(S, \mathbb{Z})$ and $n \geqslant 0$ are chosen such that $P_{n}(X, \beta) \cong$ $P_{n}(S, \beta)$ for $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Denote by $[\mathrm{pt}] \in H^{4}(X, \mathbb{Z})$ the pull-back of the Poincaré dual of the point class on $S$. Let $P_{n}(X, \beta)$ be endowed with the orientation as in (1.5). Then
$P_{n, \beta}([\mathrm{pt}])=(-1)^{\beta \cdot L_{2}+n} \int_{S^{[m]} \times \mathbb{P}^{\chi(\beta)-1}} c_{m}\left(\mathcal{O}_{S}(\beta)^{[m]}(1)\right) \frac{h^{n}(1+h)^{\chi\left(L_{1}(\beta)\right)}(1-h)^{\chi\left(L_{2}(\beta)\right)} c\left(T_{S^{[m]}}\left(L_{1}\right)\right)}{c\left(L_{1}(\beta)^{[m]}(1)\right) \cdot c\left(\left(L_{2}(\beta)^{[m]}(1)\right)^{\vee}\right)}$,
when $\beta^{2} \geqslant 0$. Here $m:=n+g(\beta)-1$ and $h:=c_{1}(\mathcal{O}(1))$. Moreover, $P_{n, \beta}([\mathrm{pt}])=0$ when $\beta^{2}<0$.
The main assumption in this theorem is $P_{n}(X, \beta) \cong P_{n}(S, \beta)$. For $\left(S, L_{1}, L_{2}\right)$ with $S$ minimal and toric, $L_{1} \otimes L_{2} \cong K_{S}$ with $L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef, we classify all cases for which $n \geqslant 0$, $P_{n}(X, \beta) \cong P_{n}(S, \beta)$, and $P_{n}(S, \beta)$ is non-empty (Proposition 3.9. Remark 3.10). Note that $P_{n}(X, \beta) \cong P_{n}(S, \beta)$ more or less forces $p_{g}(S)=0$, because as soon as $L_{1}$ or $L_{2}$ has non-zero sections this isomorphism does not hold. See Remark 4.5 for an extension to the case $b_{1}(S)>0$.
1.4. Verifications. In this paper, we apply Theorem 1.5 to examples for which $S$ is in addition toric $2^{2}$. Then the integrals on $S^{[m]}$ of Theorem 1.5 can be calculated using Atiyah-Bott localization for the lift of the 2-dimensional torus action from $S$ to $S^{[m]}$ as described in Section 4.4. This leads to the tables for stable pair invariants in Appendix A.

Denote by $[H] \in H_{2}\left(\mathbb{P}^{2}, \mathbb{Z}\right)$ the class of a line and let $\left[H_{1}\right],\left[H_{2}\right] \in H_{2}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathbb{Z}\right)$ be as in Example 1.4. In [KP, Sect. 3], Klemm-Pandharipande determined the Gromov-Witten invariants of $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ for $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right)$ and $\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right)$. They tabulated the corresponding values of the Gopakumar-Vafa type invariants for $\beta=d[H]$ with $d \leqslant 10$ resp. $\beta=d_{1}\left[H_{1}\right]+d_{2}\left[H_{2}\right]$ with $d_{1}, d_{2} \leqslant 6$. Combining their calculations and the tables in Appendix A we deduce the following:
Corollary 1.6. In the following cases, Conjectures 1.1 and 1.2 are true for $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$.

- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=1$, and any $n \geqslant 0$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=2,3,4$, and $n=0,1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=2,3$, and $n=2$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(1,0),(0,1),(1,1)$, any $n \geqslant 0$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(0, d),(d, 0)$ with $d \geqslant 2$, and $0 \leqslant n \leqslant d$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(1, d),(d, 1)$ with $d \geqslant 2$, and $n=0,1,2$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(2,2),(2,3),(3,2),(2,4)$, $(4,2),(3,3)$, and $n=0$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(2,2),(2,3),(3,2)$, and $n=1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(2,2)$, and $n=2$.

Remark 1.7. In all these cases $P_{n}(X, \beta) \cong P_{n}(S, \beta)$. In fact, these are all $\left(S, L_{1}, L_{2}\right)$ with $L_{1} \otimes L_{2} \cong K_{S}$ for which $L_{1}^{-1}, L_{2}^{-1}$ are ample, $n \geqslant 0$, and $P_{n}(X, \beta) \cong P_{n}(S, \beta)$ by Propositions 3.2 and 3.9. Calculations based on Theorem 1.5 are often more efficient than the vertex formalism CK2, CKM. For instance, for $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(2,4)$ and $n=0, P_{n}(X, \beta)$ has $182 T$-fixed points, whereas Theorem 1.5 only involves an integral over $S^{[2]} \times \mathbb{P}^{14}$.

Bousseau-Brini-van Garrel BBG recently determined the genus zero Gromov-Witten (and hence Gopakumar-Vafa type) invariants of several local surfaces for their verifications of the loglocal principle conjectured in general in [GGR]. Combining their numbers with the tables for stable pair invariants in Appendix A allows us to provide some further verifications of Conjecture 1.1 as we will now describe. For any $a \geqslant 1$, consider the Hirzebruch surface

$$
\mathbb{F}_{a}=\mathbb{P}\left(\mathcal{O}_{\mathbb{P}^{1}} \oplus \mathcal{O}_{\mathbb{P}^{1}}(a)\right)
$$

We denote by $[F]$ the class of a fibre and by $[B]$ the class of the unique section satisfying $B^{2}=-a$. We write $\mathcal{O}(m, n):=\mathcal{O}(m B+n F)$ and consider curve classes $\beta:=d_{1}[B]+d_{2}[F], d_{1}, d_{2} \geqslant 0$.
Corollary 1.8. In the following cases, Conjecture 1.1 is true for $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$.

- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$, and any $n \geqslant 1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0, d)$ with $d \geqslant 2$, and $n=d$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(2,2),(2,3),(1, d),(d, 1)$ with $d \geqslant 1$, and $n=1$.

[^1]- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(1, d)$ with $d \geqslant 2$, and $n=2$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$, and any $n \geqslant 1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0, d)$ with $d \geqslant 2$, and $n=d$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(2,2),(2,3),(2,4),(1, d)$ with $d \geqslant 1$, and $n=1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(1, d)$ with $d \geqslant 2$, and $n=2$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(0,-1), \mathcal{O}(-2,-2)\right),\left(d_{1}, d_{2}\right)=(2,2),(2,3),(1, d)$ with $d \geqslant 1, n=1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$, and any $n \geqslant 1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0, d)$ with $d \geqslant 2$, and $n=d$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(2,3),(2,4),(2,5),(1, d)$ with $d \geqslant 1$, and $n=1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(1, d)$ with $d \geqslant 2$, and $n=2$.

In all these cases $P_{n}(X, \beta) \cong P_{n}(S, \beta)$ and $n>0$. Since Bousseau-Brini-van Garrel only determined the genus zero Gopakumar-Vafa type invariants for the above geometries, we can only verify Conjecture 1.1 in these cases. In fact, in Proposition 3.9 and Remark 3.10 we classify all cases $\left(S, L_{1}, L_{2}\right)$ such that $S$ is minimal toric, $L_{1} \otimes L_{2} \cong K_{S}, L_{1}^{-1}, L_{2}^{-1}$ are non-trivial and nef, $n \geqslant 0, P_{n}(X, \beta) \cong P_{n}(S, \beta)$, and $P_{n}(S, \beta)$ is non-empty. Using Theorem 1.5, we determined the stable pair invariants in all these cases, including the $n=0$ case (see Appendix A).

Remark 1.9. For all calculations done in Appendix for which $P_{n}(X, \beta) \cong P_{n}(S, \beta)$ and the invariant is non-zero, we have

$$
\begin{equation*}
P_{n, \beta}([\mathrm{pt}])= \pm \int_{S^{[m]}} e\left(T_{S^{[m]}}\left(L_{1}\right)\right) . \tag{1.7}
\end{equation*}
$$

These numbers were calculated by Carlsson-Okounkov CO12 and are determined by the formula

$$
\sum_{m=0}^{\infty} q^{m} \int_{S^{[m]}} e\left(T_{S^{[m]}}\left(L_{1}\right)\right)=\prod_{m=1}^{\infty}\left(1-q^{m}\right)^{-c_{2}\left(T_{S} \otimes L_{1}\right)}
$$

where $c_{2}\left(T_{S} \otimes L_{1}\right)=c_{2}(S)-L_{1} L_{2}$. We do not know whether (1.7) is a mere coincidence.
1.5. Vertex calculations. Although most calculations in this paper are based on Theorem 1.5 , we also did some computations using the vertex formalism.
Proposition 1.10. For the following cases, Conjectures 1.1 and 1.2 are true.

- $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right), d=1$, and any $n \geqslant 0$.
- $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right), d=2,3$, and $n=0,1$.
- $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right), d=2$, and $n=2$.

For the following cases Conjecture 1.1 is true for $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$.

- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=2$, and $n=3$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(0,2),(2,0),(1,2),(2,1)$, and $n=3$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,2)$, and $n=3$.

The invariants in this proposition are defined by localization on the fixed locus CK2, CKM. In the cases above where $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right)$, we have $P_{n}(X, \beta) \cong P_{n}\left(\mathbb{P}^{3}, \beta\right)$ and

$$
\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}=(-1)^{\beta \cdot c_{1}\left(\mathbb{P}^{3}\right)+n} \cdot\left[P_{n}\left(\mathbb{P}^{3}, \beta\right)\right]_{\mathrm{pair}}^{\mathrm{vir}},
$$

where $\left[P_{n}\left(\mathbb{P}^{3}, \beta\right)\right]_{\text {pair }}^{\text {vir }}$ is the virtual class of the pairs perfect obstruction theory on $\mathbb{P}^{3}$ (discussed in (4.9), see also CMT2, Lem. 3.1] in a similar setting). The sign in this formula is a preferred choice of orientation on $P_{n}(X, \beta)$ similar to (1.5). Then the Graber-Pandharipande virtual localization formula GP can be applied to the right hand side to show that the local invariants of Proposition 1.10 are equal to the global invariants (1.4). The same method works for the local surface case $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=2, n=3$, because then all stable pairs are scheme theoretically supported in the threefold $\operatorname{Tot}_{S}\left(L_{1}\right) .3$ See Remark A. 2 for more details.

We remark that most stable pair invariants of local surfaces calculated in this paper are small (see Section A.1). For $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right)$, the numbers are rather big:

$$
P_{0,3[\ell]}=11200, \quad P_{1,2[\ell]}([\ell])=-820, \quad P_{1,3[\ell]}([\ell])=-68060, \quad P_{2,2[\ell]}([\ell])=400,
$$

where $[\ell] \in H_{2}\left(\mathbb{P}^{3}, \mathbb{Z}\right) \cong H_{2}(X, \mathbb{Z})$ denotes the class of a line $\ell \subseteq \mathbb{P}^{3}$ and we also write $[\ell] \in$ $H^{4}(X, \mathbb{Z})$ for the pull-back of its Poincaré dual from $\mathbb{P}^{3}$ to $X$. This provides further good evidence for Conjectures 1.1 and 1.2

## 2. Background

2.1. DT invariants of Calabi-Yau 4-folds. Let $X$ be a smooth projective Calabi-Yau 4-fold with ample divisor $\omega$ and take a cohomology class $v \in H^{*}(X, \mathbb{Q})$. The coarse moduli space $M_{\omega}(v)$ of $\omega$-Gieseker semistable sheaves $E$ on $X$ with $\operatorname{ch}(E)=v$ is a projective scheme. We always assume that $M_{\omega}(v)$ is a fine moduli space, i.e. any point $[E] \in M_{\omega}(v)$ is stable and there exists a universal family $\mathcal{E}$ on $X \times M_{\omega}(v)$ flat over $M_{\omega}(v)$. For instance, the moduli space of 1dimensional stable sheaves $E$ with $[E]=\beta, \chi(E)=1$ and Hilbert schemes of closed subschemes satisfy this assumption CK1, CK2, CMT1, CT2.

Borisov-Joyce [BJ] (in general) and Cao-Leung [CL1] (in special cases) constructed a virtual fundamental class

$$
\begin{equation*}
\left[M_{\omega}(v)\right]^{\mathrm{vir}} \in H_{2-\chi(v, v)}\left(M_{\omega}(v), \mathbb{Z}\right) \tag{2.1}
\end{equation*}
$$

where $\chi(\cdot, \cdot)$ denotes the Euler pairing. In order to construct the above virtual class (2.1) with coefficients in $\mathbb{Z}$ (instead of $\mathbb{Z}_{2}$ ), we need an orientability result for $M_{\omega}(v)$, which can be stated as follows. Let

$$
\mathcal{L}:=\operatorname{det}\left(\mathbf{R} \mathcal{H} o m_{\pi_{M}}(\mathcal{E}, \mathcal{E})\right) \in \operatorname{Pic}\left(M_{\omega}(v)\right), \quad \pi_{M}: X \times M_{\omega}(v) \rightarrow M_{\omega}(v)
$$

be the determinant line bundle of $M_{\omega}(v)$, which is equipped with the nondegenerate symmetric pairing $Q$ induced by Serre duality. An orientation of $(\mathcal{L}, Q)$ is a reduction of its structure group from $\mathrm{O}(1, \mathbb{C})$ to $\mathrm{SO}(1, \mathbb{C})=\{1\}$. In other words, we require a choice of square root of the isomorphism

$$
\begin{equation*}
Q: \mathcal{L} \otimes \mathcal{L} \rightarrow \mathcal{O}_{M_{\omega}(v)} \tag{2.2}
\end{equation*}
$$

Existence of orientations was first proved when the Calabi-Yau 4-fold $X$ satisfies $\operatorname{Hol}(X)=\mathrm{SU}(4)$ and $H^{\text {odd }}(X, \mathbb{Z})=0$ in CL2], and was recently generalized to arbitrary Calabi-Yau 4-folds in CGJ, Cor. 1.17]. Notice that the collection of orientations forms a torsor for $H^{0}\left(M_{\omega}(v), \mathbb{Z}_{2}\right)$. The virtual class (2.1) depends on the choice of orientation, but we suppress it from the notation.

Roughly speaking, in order to construct (2.1), one chooses at every point $[E] \in M_{\omega}(v)$, a half-dimensional real subspace

$$
\operatorname{Ext}_{+}^{2}(E, E) \subseteq \operatorname{Ext}^{2}(E, E)
$$

of the usual obstruction space $\operatorname{Ext}^{2}(E, E)$, on which the quadratic form $Q$ defined by Serre duality is real and positive definite. Then one glues local Kuranishi-type models of the form

$$
\kappa_{+}=\pi_{+} \circ \kappa: \operatorname{Ext}^{1}(E, E) \rightarrow \operatorname{Ext}_{+}^{2}(E, E),
$$

where $\kappa$ is the Kuranishi map for $M_{\omega}(v)$ at $[E]$ and $\pi_{+}$denotes projection on the first factor of the decomposition $\operatorname{Ext}^{2}(E, E)=\operatorname{Ext}_{+}^{2}(E, E) \oplus \sqrt{-1} \cdot \operatorname{Ext}_{+}^{2}(E, E)$.

In CL1, local models are glued in three special cases:
(1) when $M_{\omega}(v)$ consists of locally free sheaves only,
(2) when $M_{\omega}(v)$ is smooth,
(3) when $M_{\omega}(v)$ is a shifted cotangent bundle of a quasi-smooth derived scheme.

In each case, the corresponding virtual classes are constructed using either gauge theory or algebro-geometric perfect obstruction theory.

The general gluing construction, due to Borisov-Joyce [BJ], is based on Pantev-Töen-VaquiéVezzosi's theory of shifted symplectic geometry PTVV and Joyce's theory of derived $C^{\infty}{ }_{-}$ geometry. The corresponding virtual class is constructed using Joyce's D-manifold theory (a machinery similar to Fukaya-Oh-Ohta-Ono's theory of Kuranishi space structures used for defining Lagrangian Floer theory).

Examples computed in this paper only involve virtual class constructions in (2) and (3) mentioned above. We briefly review them:

- When $M_{\omega}(v)$ is smooth, the obstruction sheaf $\mathrm{Ob} \rightarrow M_{\omega}(v)$ is a vector bundle endowed with a quadratic form $Q$ via Serre duality. Then the virtual class is given by

$$
\left[M_{\omega}(v)\right]^{\mathrm{vir}}=\operatorname{PD}(e(\mathrm{Ob}, Q)),
$$

where $\operatorname{PD}(\cdot)$ denotes Poincaré dual and $e(\mathrm{Ob}, Q)$ is the half-Euler class of $(\mathrm{Ob}, Q)$, i.e. the Euler class of its real form $\mathrm{Ob}_{+}$. In this case, a choice of orientation (2.2) is equivalent to a choice of orientation of $\mathrm{Ob}_{+}$. The half-Euler class satisfies

$$
\begin{aligned}
e(\mathrm{Ob}, Q)^{2} & =(-1)^{\frac{\mathrm{rk}(\mathrm{Ob})}{2}} e(\mathrm{Ob}), & & \text { if } \mathrm{rk}(\mathrm{Ob}) \text { is even } \\
e(\mathrm{Ob}, Q) & =0, & & \text { if } \mathrm{rk}(\mathrm{Ob}) \text { is odd }
\end{aligned}
$$

- Suppose $M_{\omega}(v)$ is the classical truncation of the shifted cotangent bundle of a quasismooth derived scheme. Roughly speaking, this means that at any closed point $[E] \in$ $M_{\omega}(v)$, we have a Kuranishi map of the form

$$
\kappa: \operatorname{Ext}^{1}(E, E) \rightarrow \operatorname{Ext}^{2}(E, E)=V_{E} \oplus V_{E}^{*}
$$

where $\kappa$ factors through a maximal isotropic subspace $V_{E}$ of $\left(\operatorname{Ext}^{2}(E, E), Q\right)$. Then the virtual class of $M_{\omega}(v)$ is essentially the virtual class of the perfect obstruction theory formed by $\left\{V_{E}\right\}_{[E] \in M_{\omega}(v)}$. When $M_{\omega}(v)$ is furthermore smooth as a scheme, then it is simply the Euler class of the vector bundle $\left\{V_{E}\right\}_{[E] \in M_{\omega}(v)}$ over $M_{\omega}(v)$.
2.2. Stable pair invariants of Calabi-Yau 4-folds. As in PT1, a stable pair $(F, s)$ on a smooth projective Calabi-Yau 4-fold $X$ consists of

- a pure dimension 1 sheaf $F$ on $X$,
- a section $s \in H^{0}(X, F)$ with 0-dimensional or trivial cokernel.

For $\beta \in H_{2}(X, \mathbb{Z})$ and $n \in \mathbb{Z}$, denote by $P_{n}(X, \beta)$ be the moduli space of stable pairs $(F, s)$ on $X$ such that $F$ has scheme theoretic support with class $\beta$ and $\chi(F)=n$. By [PT1, it can alternatively be seen as the moduli space parametrizing 2 -term complexes

$$
I^{\bullet}=\left\{\mathcal{O}_{X} \xrightarrow{s} F\right\} \in D^{b}(\operatorname{Coh}(X))
$$

in the bounded derived category of coherent sheaves on $X$. This viewpoint produces an obstruction theory on $P_{n}(X, \beta)$, which is however not perfect because $\operatorname{Ext}^{2}\left(I^{\bullet}, I^{\bullet}\right)_{0}$ is in general non-vanishing. Nonetheless, using the methods of Borisov-Joyce [BJ], one can construct a virtual class (see CMT2, Thm. 1.4])

$$
\left[P_{n}(X, \beta)\right]^{\mathrm{vir}} \in H_{2 n}\left(P_{n}(X, \beta), \mathbb{Z}\right)
$$

depending on a choice of orientation. Existence of orientations was proved in [CGJ, Cor. 1.17].

## 3. Moduli Spaces

3.1. Compactness I. In the previous section, we assumed $X$ is a smooth projective Calabi-Yau 4 -fold. As we will discuss in more detail in Section 4.2, the previous section also applies to certain cases where $X$ is a smooth quasi-projective Calabi-Yau 4 -fold and $P_{n}(X, \beta)$ is proper.

Suppose $S$ is a smooth projective surface and $L_{1}, L_{2} \in \operatorname{Pic}(S)$ satisfy

$$
L_{1} \otimes L_{2} \cong K_{S}
$$

Then $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ is a smooth quasi-projective Calabi-Yau 4 -fold, which we refer to as a local surface. One way to ensure the properness of $P_{n}(X, \beta)$ is as follows.

Proposition 3.1. Suppose $S$ is a smooth projective surface with $L_{1}, L_{2} \in \operatorname{Pic}(S)$ satisfying $L_{1} \otimes L_{2} \cong K_{S}$ and let $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Let $\beta \in H_{2}(S, \mathbb{Z})$ and suppose for any $0 \neq \beta^{\prime} \leqslant \beta$ we have $\beta^{\prime} \cdot L_{i}<0$ for $i=1,2$. Then $P_{n}(X, \beta)$ is projective for any $n \in \mathbb{Z}$.
Proof. Let $[(F, s)] \in P_{n}(X, \beta)$. We first show that $F$ is set theoretically supported on the zero section $S \subseteq X$. Let $D$ be an irreducible component of the scheme theoretic support of $F$, then we want to show $D_{\text {red }} \subseteq S$. Let $Y=\operatorname{Tot}_{S}\left(L_{1}\right)$ and consider the projection $p: X=\operatorname{Tot}_{Y}\left(L_{2}\right) \rightarrow Y$ (here and below, we suppress the pull-back of $L_{2}$ along the projection $Y \rightarrow S$ ). Since $D_{\text {red }}$ is a proper irreducible reduced curve, $\mathcal{O}_{D_{\text {red }}}$ is stable. By the spectral construction, it corresponds to a stable Higgs pair $\left(p_{*} \mathcal{O}_{D_{\text {red }}}, \phi\right)$, where

$$
\phi: p_{*} \mathcal{O}_{D_{\mathrm{red}}} \rightarrow p_{*} \mathcal{O}_{D_{\mathrm{red}}} \otimes L_{2}
$$

Denote the curve class of the scheme theoretic support of $p_{*} \mathcal{O}_{D_{\text {red }}}$ by $\beta^{\prime} \in H_{2}(Y, \mathbb{Z}) \cong H_{2}(S, \mathbb{Z})$. Then $0 \neq \beta^{\prime} \leqslant \beta$, so $\beta^{\prime} \cdot L_{2}<0$. Combined with stability of the Higgs pairs $\left(p_{*} \mathcal{O}_{D_{\text {red }}}, \phi\right)$ and

[^3]$\left(p_{*} \mathcal{O}_{D_{\text {red }}} \otimes L_{2}, \phi \otimes \mathrm{id}_{L_{2}}\right)$, this implies $\phi=0$ so $D_{\text {red }} \subseteq Y=\operatorname{Tot}_{S}\left(L_{1}\right)$ (see [TT, Prop. 7.4] for a similar argument). Reversing the roles of $L_{1}, L_{2}$, we deduce $D_{\text {red }} \subseteq Y=\operatorname{Tot}_{S}\left(L_{2}\right)$, so $D_{\text {red }} \subseteq S$.

Since each element of $P_{n}(X, \beta)$ is set theoretically supported on $S$, we conclude that $P_{n}(X, \beta)$ is projective. Indeed, there is a $d \gg 0$ such that every element of $P_{n}(X, \beta)$ is scheme theoretically supported in $d S$, where $d S$ denotes the $d$ times thickening of the zero section $S \subseteq X$, i.e. the closed subscheme of $X$ defined by $I^{d} \subseteq \mathcal{O}_{X}$, where $I \subseteq \mathcal{O}_{X}$ denotes the ideal of the zero section. Therefore $P_{n}(X, \beta) \cong P_{n}(d S, \beta)$,

Suppose $L_{1}^{-1}$ and $L_{2}^{-1}$ are ample. Then $K_{S}^{-1}$ is ample, i.e. $S$ is del Pezzo, and $P_{n}(X, \beta)$ is projective for all $\beta, n$ by Proposition [3.1. As noted in [CMT2, Sect. 4.2], there are only two possibilities:

Proposition 3.2. Let $S$ be a smooth projective surface and $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes$ $L_{2} \cong K_{S}$. Suppose $L_{1}^{-1}$ and $L_{2}^{-1}$ are ample. Then, up to permutating $L_{1}, L_{2}$, we only have $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right)$ or $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right)$.

Proof. Suppose $S$ contains a ( -1 )-curve $C$. Then the Nakai criterion and adjunction imply

$$
-2 \geqslant \operatorname{deg}\left(\left.L_{1}\right|_{C}\right)+\operatorname{deg}\left(\left.L_{2}\right|_{C}\right)=\operatorname{deg}\left(\left.K_{S}\right|_{C}\right)=-1
$$

so $S$ does not contain ( -1 -curves. The classification of del Pezzo surfaces yields the result.
For both geometries of this proposition, the Gromov-Witten (and hence Gopakumar-Vafa type) invariants were determined in [KP, Sect. 3].

Let us go back to an arbitrary smooth projective surface $S$ with $L_{1}, L_{2} \in \operatorname{Pic}(S)$ satisfying $L_{1} \otimes L_{2} \cong K_{S}$. Consider the moduli space $P_{n}(S, \beta)$ of stable pairs $(F, s)$ on $S$ with $\chi(F)=n$ and scheme theoretic support of $F$ in class $\beta \in H_{2}(S, \mathbb{Z})$. Any stable pair $I^{\bullet}=\left\{\mathcal{O}_{S} \rightarrow F\right\}$ gives rise to a stable pair

$$
\left\{\mathcal{O}_{X} \rightarrow \iota_{*} \mathcal{O}_{S} \rightarrow \iota_{*} F\right\}
$$

on $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$, where $\iota: S \hookrightarrow X$ denotes inclusion of the zero section. This gives a closed embedding

$$
\begin{equation*}
P_{n}(S, \beta) \hookrightarrow P_{n}(X, \beta) \tag{3.1}
\end{equation*}
$$

We refer to elements of $P_{n}(X, \beta)$ in the image as "stable pairs which are scheme theoretically supported on $S^{\prime \prime}$. Requiring $P_{n}(X, \beta)$ to be proper poses restrictions on $n, \beta$. The following result is very useful for finding "candidates" for proper moduli spaces $P_{n}(X, \beta)$ (as we will see later in this section in Proposition (3.8).

Proposition 3.3. Let $S$ be a smooth projective surface, $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$ and let $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Let $\beta \in H_{2}(S, \mathbb{Z})$ and $n \in \mathbb{Z}$ such that $P_{n}(X, \beta)$ is proper and $P_{n}(S, \beta) \neq \varnothing$. Suppose $C_{1}, C_{2} \subseteq S$ are effective divisors satisfying

- $C_{1} \cong \mathbb{P}^{1}$ and $\left[C_{1}+C_{2}\right]=\beta$,
- $L_{i} \cdot C_{1}=0$ for $i=1$ or $i=2$.

Then

$$
-\frac{1}{2} \beta\left(\beta+K_{S}\right) \leqslant n \leqslant-\frac{1}{2} C_{2}\left(C_{2}+K_{S}\right)
$$

Proof. Suppose $P_{n}(S, \beta) \neq \varnothing, P_{n}(X, \beta)$ is proper, and let $C_{1}, C_{2} \subseteq S$ be as stated. Then for any element $[(F, s)] \in P_{n}(S, \beta)$ with underlying scheme theoretic support $C$, we have

$$
n=\chi(F) \geqslant \chi\left(\mathcal{O}_{C}\right)=-\frac{1}{2} \beta\left(\beta+K_{S}\right)
$$

Suppose

$$
n \geqslant 1-\frac{1}{2} C_{2}\left(C_{2}+K_{S}\right) .
$$

Since $C_{1} \cong \mathbb{P}^{1}$ and $\operatorname{deg}\left(\left.L_{i}\right|_{C_{1}}\right)=L_{i} \cdot C_{1}=0$, for $i=1$ or $i=2$, the line bundle $\left.L_{i}\right|_{C_{1}}$ is trivial. Hence we can take a nowhere vanishing section $D_{1}$ of the line bundle $\left.L_{i}\right|_{C_{1}} \cong \mathbb{P}^{1} \times \mathbb{C}$. In particular, $D_{1}$ and $C_{2}$ are disjoint. Therefore

$$
\begin{aligned}
\chi\left(\mathcal{O}_{D_{1} \sqcup C_{2}}\right) & =\chi\left(\mathcal{O}_{D_{1}}\right)+\chi\left(\mathcal{O}_{C_{2}}\right) \\
& =1-\frac{1}{2} C_{2}\left(C_{2}+K_{S}\right)
\end{aligned}
$$

Twisting $\mathcal{O}_{D_{1} \sqcup C_{2}}$ by an effective divisor of appropriate length, we obtain a stable pair $[(F, s)] \in$ $P_{n}(X, \beta) \backslash P_{n}(S, \beta)$ with underlying scheme theoretic support $D_{1} \sqcup C_{2}$. Since $D_{1}$ does not lie in the zero-section, using the $\mathbb{C}^{*}$-scaling action on $L_{i}$, we get a family of stable pairs with part of the support (i.e. $D_{1}$ ) moving off to infinity, contradicting properness of $P_{n}(X, \beta)$.

We want to apply this proposition to smooth projective surfaces $S$ with $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$ and $L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef. These surfaces were recently studied in the context of the log-local principle by Bousseau-Brini-van Garrel [BBG]. In particular, they determined the genus zero Gromov-Witten (and hence Gopakumar-Vafa type) invariants of $\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ in many new cases.

Smooth projective surfaces $S$ with $K_{S}^{-1}$ nef and big are called weak del Pezzo surfaces. The weak toric del Pezzo surfaces are: $\mathbb{P}^{2}, \mathbb{P}^{1} \times \mathbb{P}^{1}, \mathbb{F}_{1}, \mathbb{F}_{2}$, or certain repeated toric blow-ups of $\mathbb{P}^{2}$ in at most 6 points as specified in Sat. In this paper, we only consider the minimal cases, i.e. the first four cases. Using the notation for Hirzebruch surfaces from the introduction, the only possibilities for $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$ with $L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef are (up to permutations of $L_{1}, L_{2}$ ):

- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right)$,
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right)$ or $\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right)$,
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right)$ or $\left(\mathbb{F}_{1}, \mathcal{O}(0,-1), \mathcal{O}(-2,-2)\right)$,
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right)$.

Example 3.4. Suppose $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right)$. Let $H_{1}=\{\mathrm{pt}\} \times \mathbb{P}^{1}$ and $H_{2}=\mathbb{P}^{1} \times\{\mathrm{pt}\}$. We define $\left(d_{1}, d_{2}\right):=d_{1} H_{1}+d_{2} H_{2}$. For all $d_{1}, d_{2} \in \mathbb{Z},\left(d_{1}, d_{2}\right)$ is effective if and only if $d_{1}, d_{2} \geqslant 0$. For $(0, d)$ with $d \geqslant 1$, the moduli space $P_{n}(X,(0, d))$ is projective for all $n$ by Proposition 3.1. Now suppose $d_{1}>0, d_{2} \geqslant 0$, and $n \geqslant 0$. Let $C_{1} \in\left|H_{1}\right|$ and $C_{2} \in\left|\left(d_{1}-1\right) H_{1}+d_{2} H_{2}\right|$. Then $L_{1} \cdot C_{1}=0$ and the inequalities of Proposition 3.3 reduce to

$$
d_{1}+d_{2}-d_{1} d_{2} \leqslant n \leqslant d_{1}+2 d_{2}-d_{1} d_{2}-1
$$

These inequalities have the following solutions:

- $\left(d_{1}, d_{2}\right)=(3,2),(2, d)$ with $d \geqslant 2$ and $n=0$,
- $\left(d_{1}, d_{2}\right)=(d, 1),(1, d)$ with $d \geqslant 1$ and $n=1$, or $\left(d_{1}, d_{2}\right)=(2, d)$ with $d \geqslant 1$ and $n=1$,
- $(1, d)$ with $2 \leqslant n \leqslant d$.

Example 3.5. Suppose $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right)$ and use the notation for Hirzebruch surfaces from the introduction, so $\left(d_{1}, d_{2}\right):=d_{1} B+d_{2} F$ for all $d_{1}, d_{2} \in \mathbb{Z}$. Then $\left(d_{1}, d_{2}\right)$ is effective if and only if $d_{1}, d_{2} \geqslant 0$ (this holds for all Hirzebruch surfaces). For $(0, d)$ with $d \geqslant 1$, the moduli space $P_{n}(X,(0, d))$ is projective for all $n$ by Proposition 3.1. Suppose $d_{1}>0, d_{2} \geqslant 0$, and $n \geqslant 0$. Let $C_{1} \in|B|$ and $C_{2} \in\left|\left(d_{1}-1\right) B+d_{2} F\right|$. Then $L_{1} \cdot C_{1}=0$ and the inequalities of Proposition 3.3 reduce to

$$
\frac{1}{2} d_{1}\left(d_{1}+1\right)-d_{2}\left(d_{1}-1\right) \leqslant n \leqslant \frac{1}{2} d_{1}\left(d_{1}-1\right)-d_{2}\left(d_{1}-2\right)
$$

These inequalities have the following solutions:

- $\left(d_{1}, d_{2}\right)=(3,3),(2, d)$ with $d \geqslant 3$ and $n=0$,
- $\left(d_{1}, d_{2}\right)=(2, d)$ with $d \geqslant 2$ and $n=1$,
- $(1, d)$ with $1 \leqslant n \leqslant d$.

Example 3.6. Suppose $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(0,-1), \mathcal{O}(-2,-2)\right)$. Suppose $d_{1}>0, d_{2} \geqslant 0$, and $n \geqslant 0$. Taking $C_{1}, C_{2}$ as in Example 3.5 leads to the same list. Additionally, we can take $d_{1} \geqslant 0$, $d_{2}>0, n \geqslant 0, C_{1} \in|F|$ and $C_{2} \in\left|d_{1} B+\left(d_{2}-1\right) F\right|$. Then $L_{1} \cdot C_{1}=0$ and the inequalities of Proposition 3.3 reduce to

$$
\frac{1}{2} d_{1}\left(d_{1}+1\right)-d_{2}\left(d_{1}-1\right) \leqslant n \leqslant \frac{1}{2} d_{1}\left(d_{1}+1\right)-\left(d_{2}-1\right)\left(d_{1}-1\right)
$$

The solutions to these inequalities and the ones from Example 3.5 are:

- $\left(d_{1}, d_{2}\right)=(2,3),(2,4),(3,3)$ and $n=0$,
- $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(1, d)$ with $d \geqslant 1$ and $n=1$.

Example 3.7. Suppose $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right)$. For $(0, d)$ with $d \geqslant 1$, the moduli space $P_{n}(X,(0, d))$ is projective for all $n$ by Proposition 3.1. Suppose $d_{1}>0, d_{2} \geqslant 0$, and $n \geqslant 0$. Let $C_{1} \in|B|$ and $C_{2} \in\left|\left(d_{1}-1\right) B+d_{2} F\right|$. Then $L_{1} \cdot C_{1}=0$ and the inequalities of Proposition 3.3 reduce to

$$
d_{1}^{2}-d_{2}\left(d_{1}-1\right) \leqslant n \leqslant\left(d_{1}-1\right)^{2}-d_{2}\left(d_{1}-2\right)
$$

These inequalities have the following solutions:

- $\left(d_{1}, d_{2}\right)=(2, d), d \geqslant 4$, and $n=0$,
- $\left(d_{1}, d_{2}\right)=(2, d), d \geqslant 3$, and $n=1$,
- $(1, d)$ with $1 \leqslant n \leqslant d$.

In these examples we listed, for given $\left(S, L_{1}, L_{2}\right)$, all the cases for which $n \geqslant 0$ and potentially $P_{n}(X, \beta)$ is proper and $P_{n}(S, \beta) \neq \varnothing$ (Proposition 3.3). For $\beta=(0, d)$ with $d \geqslant 1, P_{n}(S, \beta) \neq \varnothing$ if and only if $n \geqslant d$, and $P_{n}(X, \beta)$ is proper by Proposition 3.1. For all other cases listed, $P_{n}(S, \beta)$ is also non-empty since $|\beta| \neq \varnothing$ and $n \geqslant \chi\left(\mathcal{O}_{C}\right)$ for any $C \in|\beta|$. Indeed adding sufficiently many points to $C$ one obtains a stable pair $(F, s)$ on $S$ with $\chi(F)=n$. We now prove that in each of the cases listed, $P_{n}(X, \beta)$ is indeed proper.

Proposition 3.8. In each of the cases listed in Examples 3.4 3.7, $P_{n}(X, \beta)$ is projective.
Proof. We write out the proof for Example 3.4 The other cases are analogous. Recall that $H_{1}:=\{\mathrm{pt}\} \times \mathbb{P}^{1}, H_{2}:=\mathbb{P}^{1} \times\{\mathrm{pt}\}, L_{1}:=\mathcal{O}\left(-H_{1}\right), L_{2}:=\mathcal{O}\left(-H_{1}-2 H_{2}\right)$, and $\beta:=d_{1} H_{1}+d_{2} H_{2}$. Suppose $n, \beta$ are as listed in Example 3.4. As in Proposition 3.1, it is enough to show that all elements of $P_{n}(X, \beta)$ are set theoretically supported on $S$. Suppose $[(F, s)] \in P_{n}(X, \beta)$ has scheme theoretic support $C$ and let $D$ be an irreducible component of $C$ which is not set theoretically supported on $S$. Then we claim $D_{\text {red }}$ is a proper irreducible reduced curve with class $\left[D_{\text {red }}\right] \in H_{2}(X, \mathbb{Z}) \cong H_{2}(S, \mathbb{Z})$ satisfying $\left[D_{\text {red }}\right] \cdot L_{1} \geqslant 0$ or $\left[D_{\text {red }}\right] \cdot L_{2} \geqslant 0$. Indeed suppose [ $\left.D_{\text {red }}\right] \cdot L_{1}<0$ and $\left[D_{\text {red }}\right] \cdot L_{2}<0$. Using the spectral construction as in the proof of Proposition 3.1. stability of $\mathcal{O}_{D_{\text {red }}}$, then implies $D_{\text {red }} \subseteq S$ contrary to our assumption.

The only non-zero effective curve classes $\beta^{\prime}$ on $S$ such that $\beta^{\prime} \cdot L_{1} \geqslant 0$ or $\beta^{\prime} \cdot L_{2} \geqslant 0$ are $\beta^{\prime}=m H_{1}$ for some $m>0$. Hence there exists a $\Sigma \in\left|H_{1}\right|$ such that

$$
\left.p\right|_{D_{\text {red }}}: D_{\text {red }} \rightarrow \Sigma \subseteq S,
$$

where $p: X \rightarrow S$ denotes the projection. Note that $\left.L_{1}\right|_{\Sigma} \cong \mathcal{O}$ and $\left.L_{2}\right|_{\Sigma} \cong \mathcal{O}(-2)$. Since $\left[D_{\text {red }}\right] \cdot L_{2}<0$, a similar argument as above shows that $D_{\text {red }} \subseteq \operatorname{Tot}_{\Sigma}\left(L_{1}\right) \cong \mathbb{P}^{1} \times \mathbb{C}$. Therefore $D_{\text {red }}$ is a non-zero section of $\operatorname{Tot}_{\Sigma}\left(L_{1}\right) \cong \mathbb{P}^{1} \times \mathbb{C}$.

Denote the irreducible components of $C$ which are not set theoretically supported on $S$ by $D_{1}, \ldots, D_{\ell}$ and let $D^{\prime}$ be the union of the remaining components. Above, we showed each $D_{i, \text { red }} \cong \mathbb{P}^{1}$ and $D_{i, \text { red }}$ is a non-zero section of $\operatorname{Tot}_{\Sigma_{i}}\left(L_{1}\right) \cong \mathbb{P}^{1} \times \mathbb{C}$ for some $\Sigma_{i} \in\left|H_{1}\right|$. It follows that $D_{1, \text { red }}, \ldots, D_{\ell, \text { red }}, D_{\text {red }}^{\prime}$ are mutually disjoint. Denote the multiplicity of $D_{i}$ at $D_{i, \text { red }}$ by $\delta_{i} \geqslant 1$. Consider the classes $p_{*}\left[D_{i}\right], p_{*}\left[D^{\prime}\right] \in H_{2}(S, \mathbb{Z})$, where $p: X \rightarrow S$ is the projection. Then

$$
p_{*}\left[D_{i}\right]:=\delta_{i} H_{1}, \quad p_{*}\left[D^{\prime}\right]:=\beta-\delta H_{1},
$$

where $\delta:=\sum_{i=1}^{\ell} \delta_{i}$. We claim

$$
\begin{equation*}
\chi\left(\mathcal{O}_{D_{i}}\right) \geqslant 1, \quad \chi\left(\mathcal{O}_{D^{\prime}}\right) \geqslant 1-g\left(p_{*}\left[D^{\prime}\right]\right)=-\frac{1}{2}\left(\beta-\delta H_{1}\right)\left(\beta-\delta H_{1}+K_{S}\right), \tag{3.2}
\end{equation*}
$$

for all $i=1, \ldots, \ell$, where the last equality is by the Riemann-Roch formula. When $D_{i}$ (resp. $D^{\prime}$ ) are reduced, these inequalities are equalities. In general, since $N_{D_{i, \text { red }} / X} \cong \mathcal{O} \oplus \mathcal{O} \oplus \mathcal{O}(-2)$ and $N_{S / X} \cong L_{1} \oplus L_{2}$ with $L_{1}^{-1}, L_{2}^{-1}$ nef, we have inequalities as stated5. From (3.2) and the fact that $D_{1}, \ldots, D_{\ell}, D^{\prime}$ are mutually disjoint, we deduce

$$
\begin{aligned}
n=\chi(F) \geqslant \chi\left(\mathcal{O}_{C}\right) & =\sum_{i=1}^{\ell} \chi\left(\mathcal{O}_{D_{i}}\right)+\chi\left(\mathcal{O}_{D^{\prime}}\right) \\
& \geqslant \delta-\frac{1}{2}\left(\beta-\delta H_{1}\right)\left(\beta-\delta H_{1}+K_{S}\right) \\
& =\delta-\frac{1}{2}\left(d_{1}-\delta\right)\left(d_{2}-2\right)-\frac{1}{2} d_{2}\left(d_{1}-\delta-2\right)
\end{aligned}
$$

However, for each of the cases listed in Example 3.4, it is easy to see that $n \leqslant \delta-1-\frac{1}{2}\left(d_{1}-\right.$ $\delta)\left(d_{2}-2\right)-\frac{1}{2} d_{2}\left(d_{1}-\delta-2\right)$ for all $1 \leqslant \delta \leqslant d_{1}$ by explicit calculation. We have reached a contradiction.

Conclusion. For any ( $S, L_{1}, L_{2}$ ) with $L_{1} \otimes L_{2} \cong K_{S}, L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef, $S$ minimal and toric, we classified all $n \geqslant 0, \beta \in H_{2}(S, \mathbb{Z})$ such that $P_{n}(X, \beta)$ is proper and $P_{n}(S, \beta) \neq \varnothing$.
3.2. Compactness II. In the previous section, we studied properness of $P_{n}(X, \beta)$ for local surfaces. In particular, for $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right)$ or $\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right)$, the moduli space $P_{n}(X, \beta)$ is always proper (Proposition 3.1). We are now interested in the cases where $P_{n}(X, \beta) \cong P_{n}(S, \beta)$, i.e. the embedding (3.1) is an isomorphism. For the 3 -fold $\operatorname{Tot}\left(K_{\mathbb{P}^{2}}\right)$, this question was considered by Choi-Katz-Klemm in CKK, Prop. 2]. In the proof of the following proposition, we use some of their techniques (adapted to the 4 -fold setting).

[^4]Proposition 3.9. Let $X=\operatorname{Tot}_{\mathbb{P}^{2}}(\mathcal{O}(-1) \oplus \mathcal{O}(-2)), \beta=d[H]$ with $d \geqslant 1$, and $n \geqslant 0$. Then

$$
P_{n}(X, \beta) \cong P_{n}\left(\mathbb{P}^{2}, \beta\right)
$$

if and only if
(1) $d=1$ and any $n \geqslant 0$ or
(2) $d=2,3,4$ and $n=0,1$, or
(3) $d=2,3$ and $n=2$.

Let $X=\operatorname{Tot}_{\mathbb{P}^{1} \times \mathbb{P}^{1}}(\mathcal{O}(-1,-1) \oplus \mathcal{O}(-1,-1)), \beta=d_{1}\left[H_{1}\right]+d_{2}\left[H_{2}\right] \neq 0$ with $d_{1}, d_{2} \geqslant 0$, and $n \geqslant 0$. Then

$$
P_{n}(X, \beta) \cong P_{n}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \beta\right),
$$

if and only if
(1) $\left(d_{1}, d_{2}\right)=(1,0),(0,1),(1,1)$ and any $n \geqslant 0$, or
(2) $\left(d_{1}, d_{2}\right)=(0, d),(d, 0)$ with $d \geqslant 2$ and $0 \leqslant n \leqslant d$, or
(3) $\left(d_{1}, d_{2}\right)=(1, d),(d, 1)$ with $d \geqslant 2$ and $n=0,1,2$, or
(4) $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(3,2),(2,4),(4,2),(3,3)$ and $n=0$, or
(5) $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(3,2)$ and $n=1$, or
(6) $\left(d_{1}, d_{2}\right)=(2,2)$ and $n=2$.

Proof. Let $[(F, s)] \in P_{n}(X, \beta)$ be a stable pair with scheme theoretic support $C:=\operatorname{supp}(F)$. The stable pair $(F, s)$ is set theoretically supported on the zero section $S \subseteq X$ by Proposition 3.1] Let $Y_{i}=\operatorname{Tot}_{S}\left(L_{i}\right)$ for $i=1,2$. We consider the ideals of $C \subseteq X$ and $Y_{1} \subseteq X$ :

$$
J:=I_{C \subseteq X} \subseteq \mathcal{O}_{X}, \quad I_{2}:=I_{Y_{1} \subseteq X} \subseteq \mathcal{O}_{X}
$$

Note that $I_{2}$ is a line bundle on $X$. Since $(F, s)$ is set theoretically supported on $S \subseteq X$ (and therefore $Y_{1} \subseteq X$ ), there exists an $\ell \geqslant 0$ such that $J+I_{2}^{\ell+1}=J$ and we have

$$
\begin{equation*}
\chi\left(\mathcal{O}_{C}\right)=\sum_{j=0}^{\ell} \chi\left(\frac{J+I_{2}^{j}}{J+I_{2}^{j+1}}\right) . \tag{3.3}
\end{equation*}
$$

For each $j$, we have a surjective map

$$
p^{*} L_{2}^{-j} \cong \frac{I_{2}^{j}}{I_{2}^{j+1}} \rightarrow \frac{J+I_{2}^{j}}{J+I_{2}^{j+1}}
$$

where $p: Y_{1} \rightarrow S$ denotes projection. Hence $\frac{J+I_{2}^{j}}{J+I_{2}^{j+1}} \cong \mathcal{O}_{C_{j}} \otimes p^{*} L_{2}^{-j}$ for some closed subscheme $C_{j} \subseteq Y_{1}$ of dimension $\leqslant 1$. Moreover, we have $C_{j} \supseteq C_{j+1}$ for all $j 6$ From the fact that $C$ is Cohen-Macaulay, it also follows that, when non-empty, $C_{j}$ is not 0-dimensional.

For a fixed $j$, we consider the ideals of $C_{j} \subseteq Y_{1}$ and $S \subseteq Y_{1}$ :

$$
J_{j}:=I_{C_{j} \subseteq Y_{1}} \subseteq \mathcal{O}_{Y_{1}}, \quad I_{1}:=I_{S \subseteq Y_{1}} \subseteq \mathcal{O}_{Y_{1}}
$$

Note that $I_{1}$ is a line bundle on $Y_{1}$. As above, there exists an $\ell_{j} \geqslant 0$ such that $J_{j}+I_{1}^{\ell_{j}+1}=J_{j}$ and we have

$$
\chi\left(\mathcal{O}_{C_{j}}\right)=\sum_{i=0}^{\ell_{j}} \chi\left(\frac{J_{j}+I_{1}^{i}}{J_{j}+I_{1}^{i+1}}\right)
$$

As above, for all $i$, we have $\frac{J_{j}+I_{i}^{i}}{J_{j}+I_{1}^{i+1}} \cong \mathcal{O}_{C_{i j}} \otimes L_{1}^{-i}$ for some closed subscheme $C_{i j} \subseteq S$ of dimension $\leqslant 1$. As above, we also have $C_{i j} \supseteq C_{i+1, j}$ for all $i$. This time, we leave open the possibility that $C_{i j}$ is 0-dimensional, because $C_{j}$ need not be Cohen-Macaulay. Nonetheless, denoting $\beta_{i j}:=\left[C_{i j}\right]$, we have

$$
\beta=\sum_{j=0}^{\ell} \sum_{i=0}^{\ell_{j}} \beta_{i j} \in H_{2}(S, \mathbb{Z})
$$

Consider the torsion filtration

$$
0 \rightarrow \mathcal{T}_{0} \rightarrow \mathcal{O}_{C_{i j}} \rightarrow \mathcal{O}_{C_{i j}^{\text {pure }}} \rightarrow 0
$$

and the exact sequence

$$
0 \rightarrow \mathcal{O}_{S}\left(-C_{i j}^{\text {pure }}\right) \rightarrow \mathcal{O}_{S} \rightarrow \mathcal{O}_{C_{i j}^{\text {pure }}} \rightarrow 0
$$

[^5]The support of $\mathcal{T}_{0}$ is 0-dimensional. Applying the Hirzebruch-Riemann-Roch formula gives

$$
\begin{aligned}
\chi\left(\frac{J_{j}+I_{1}^{i}}{J_{j}+I_{1}^{i+1}} \otimes p^{*} L_{2}^{-j}\right)=\chi\left(\mathcal{O}_{C_{i j}} \otimes L_{1}^{-i} \otimes L_{2}^{-j}\right) & \geqslant \chi\left(\mathcal{O}_{C_{i j}^{\text {pure }}} \otimes L_{1}^{-i} \otimes L_{2}^{-j}\right) \\
& =-\frac{1}{2} \beta_{i j}\left(\beta_{i j}+K_{S}\right)-\left(i L_{1}+j L_{2}\right) \beta_{i j}
\end{aligned}
$$

Combining with (3.3), we obtain

$$
\begin{align*}
\chi(F) \geqslant \chi\left(\mathcal{O}_{C}\right) \geqslant & -\sum_{j=0}^{\ell} \sum_{i=0}^{\ell_{j}}\left(\frac{1}{2} \beta_{i j}\left(\beta_{i j}+K_{S}\right)+\left(i L_{1}+j L_{2}\right) \beta_{i j}\right) \\
\geqslant & -\frac{1}{2} \beta\left(\beta+K_{S}\right)-\beta\left(L_{1}+L_{2}\right)  \tag{3.4}\\
& +\frac{1}{2} \sum_{\substack{\left((i, j),\left(i^{\prime}, j^{\prime}\right)\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} \beta_{i j} \beta_{i^{\prime} j^{\prime}}+\beta_{00}\left(L_{1}+L_{2}\right)+L_{1} \sum_{j=1}^{\ell} \beta_{0 j}+L_{2} \sum_{i=1}^{\ell_{0}} \beta_{i 0},
\end{align*}
$$

where we used that $L_{1}$ and $L_{2}$ are nef line bundles.
Case 1. Let $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), \beta=d[H]$ with $d \geqslant 1$, and $n \geqslant 0$. Suppose there exists an element $[(F, s)] \in P_{n}(X, \beta) \backslash P_{n}(S, \beta)$. We use the notation above for its scheme theoretic support $C$ and the associated schemes $C_{i j}$. Let $\beta_{i j}=d_{i j}[H]$, then (3.4) gives

$$
\begin{aligned}
\chi(F) & \geqslant-\frac{1}{2} d^{2}+\frac{9}{2} d-3 d_{00}-\sum_{j=1}^{\ell} d_{0 j}-2 \sum_{i=1}^{\ell_{0}} d_{i 0}+\frac{1}{2} \sum_{\substack{\left((i, j),\left(i^{\prime}, j^{\prime} \prime^{\prime}\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)\right.}} d_{i j} d_{i^{\prime} j^{\prime}} \\
& \geqslant-\frac{1}{2} d^{2}+\frac{5}{2} d-d_{00}+\frac{1}{2} \sum_{\substack{\left((i, j),\left(i^{\prime}, j^{\prime}\right)\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} d_{i j} d_{i^{\prime} j^{\prime}} \\
& \geqslant-\frac{1}{2} d^{2}+\frac{5}{2} d
\end{aligned}
$$

where the last inequality uses that there exists an $(i, j) \neq(0,0)$ with $d_{i j} \geqslant 1$, because we assumed $C$ is not scheme theoretically supported in the zero section $S \subseteq X$. Hence $n \leqslant-\frac{1}{2} d^{2}+\frac{5}{2} d-1$ implies $P_{n}(S, \beta) \cong P_{n}(X, \beta)$. In particular, we find that for the cases (1)-(3) we have $P_{n}(S, \beta) \cong$ $P_{n}(X, \beta)$. For case (1) this is obvious from Proposition 3.1 and the fact that $\beta$ is irreducible.

For $\beta, n$ other than (1)-(3), it is easy to construct a $\left(\mathbb{C}^{*}\right)^{4}$-fixed stable pair in

$$
P_{n}(X, \beta) \backslash P_{n}(S, \beta)
$$

using the combinatorial description of stable pairs in PT2, CK2, where $\left(\mathbb{C}^{*}\right)^{4}$ denotes the torus of the toric Calabi-Yau 4-fold $X$.

Case 2. Let $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right), \beta=d_{1}\left[H_{1}\right]+d_{2}\left[H_{2}\right]$ for some $d_{1}, d_{2} \geqslant$ 0 not both zero, and $n \geqslant 0$. Suppose there exists an element $[(F, s)] \in P_{n}(X, \beta) \backslash P_{n}(S, \beta)$. We use the notation above for its scheme theoretic support $C$ and the associated schemes $C_{i j}$. Let $\beta_{i j}=d_{1, i j}\left[H_{1}\right]+d_{2, i j}\left[H_{2}\right]$, then (3.4) gives

$$
\begin{align*}
& \chi(F) \geqslant 3 d_{1}+3 d_{2}-d_{1} d_{2}-2 d_{1,00}-2 d_{2,00}-\sum_{j=1}^{\ell}\left(d_{1,0 j}+d_{2,0 j}\right)-\sum_{i=1}^{\ell_{0}}\left(d_{1, i 0}+d_{2, i 0}\right) \\
& +\frac{1}{2} \sum_{\substack{(i, j),\left(i, i^{\prime}, j^{\prime}\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}}\left(d_{1, i j} d_{2, i^{\prime} j^{\prime}}+d_{1, i^{\prime} j^{\prime} j^{\prime}} d_{2, i j}\right)  \tag{3.5}\\
& \geqslant 2 d_{1}+2 d_{2}-d_{1} d_{2}-d_{1,00}-d_{2,00}+\sum_{\substack{(i, j),\left(i^{\prime} i^{\prime} j^{\prime}\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} d_{1, i j} d_{2, i^{\prime} j^{\prime}} \\
& \geqslant d_{1}+d_{2}-d_{1} d_{2}+1+\sum_{\substack{\left.\left((, i, j),\left(i^{\prime}, i^{\prime}\right)^{\prime}\right)\right) \\
(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} d_{1, i j} d_{2, i^{\prime} j^{\prime}},
\end{align*}
$$

where the last inequality uses that $C$ does not lie scheme theoretically in $S$. Suppose $d_{1}, d_{2} \geqslant 2$, then

$$
\begin{equation*}
\sum_{\substack{\left.(i, j),\left(i^{\prime}, j^{\prime}\right)\right) \\(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} d_{1, i j} d_{2, i^{\prime} j^{\prime}} \geqslant 2 . \tag{3.6}
\end{equation*}
$$

Therefore $n \leqslant d_{1}+d_{2}-d_{1} d_{2}+2$ implies $P_{n}(S, \beta) \cong P_{n}(X, \beta)$. In particular, for $\beta, n$ as in (4)-(6), except for $\left(d_{1}, d_{2}\right)=(3,3)$ and $n=0(!)$, we deduce that $P_{n}(S, \beta) \cong P_{n}(X, \beta)$. Cases (1)-(3) can be found from (3.5) by a similar reasoning.

For $\left(d_{1}, d_{2}\right)=(3,3)$, we still use (3.5), but we need to sharpen (3.6). Recall that the schemes $C_{j}$ and $C_{i j}$ constructed in the first part of the proof are nested. This implies $d_{1, i j} \geqslant d_{1, i+1 j}$ and $d_{2, i j} \geqslant d_{2, i+1 j}$ for all $i, j$. Using these inequalities for $\left(d_{1}, d_{2}\right)=(3,3)$, one can show that

$$
\sum_{\substack{\left.(i, j),\left(i^{\prime}, j^{\prime}\right)\right) \\(i, j) \neq\left(i^{\prime}, j^{\prime}\right)}} d_{1, i j} d_{2, i^{\prime} j^{\prime}} \geqslant 3 .
$$

It follows that for $[(F, s)] \in P_{n}(X,(3,3)) \backslash P_{n}(S,(3,3))$, we have $\chi(F) \geqslant 1$. Hence $P_{0}(S,(3,3)) \cong$ $P_{0}(X,(3,3))$.

For $\beta, n$ other than $(1)-(6)$, it is easy to construct a $\left(\mathbb{C}^{*}\right)^{4}$-fixed stable pair in $P_{n}(X, \beta) \backslash$ $P_{n}(S, \beta)$ using the combinatorial description of stable pairs in PT2, CK2.

Remark 3.10. For $\left(S, L_{1}, L_{2}\right)$ as in Examples 3.4 3.7, we found all cases for which $n \geqslant 0$, $P_{n}(X, \beta)$ is proper, and $P_{n}(S, \beta) \neq \varnothing$ (Propositions 3.3 and 3.8). A similar reasoning as in the proof of Proposition 3.9 (using (3.4)) can be applied to find out when $P_{n}(X, \beta) \cong P_{n}(S, \beta)$. In the following cases, we have $n \geqslant 0, P_{n}(X, \beta) \cong P_{n}(S, \beta)$ :

- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,0), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$ and any $n \geqslant 0$, or $\left(d_{1}, d_{2}\right)=(0, d)$ for any $d \geqslant 2$ and $n=d$, or $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(3,2),(2,4)$ and $n=0$, or $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(1, d),(d, 1)$ for any $d \geqslant 1$ and $n=1$, or $\left(d_{1}, d_{2}\right)=(1, d)$ for any $d \geqslant 2$ and $n=2$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$ and any $n \geqslant 0$, or $\left(d_{1}, d_{2}\right)=$ $(0, d)$ for any $d \geqslant 2$ and $n=d$, or $\left(d_{1}, d_{2}\right)=(2,3),(2,4),(3,3),(2,5)$ and $n=0$, or $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(2,4)$ and $n=1$, or $\left(d_{1}, d_{2}\right)=(1, d)$ for $n=1,2$ and any $d \geqslant n$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{1}, \mathcal{O}(0,-1), \mathcal{O}(-2,-2)\right),\left(d_{1}, d_{2}\right)=(2,3),(2,4),(3,3)$ and $n=0$, or $\left(d_{1}, d_{2}\right)=(2,2),(2,3),(1, d)$ with $d \geqslant 1$ and $n=1$.
- $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{F}_{2}, \mathcal{O}(-1,-2), \mathcal{O}(-1,-2)\right),\left(d_{1}, d_{2}\right)=(0,1)$ and any $n \geqslant 0$, or $\left(d_{1}, d_{2}\right)=$ $(0, d)$ for any $d \geqslant 2$ and $n=d$, or $\left(d_{1}, d_{2}\right)=(2,4),(2,5),(2,6)$ and $n=0$, or $\left(d_{1}, d_{2}\right)=$ $(2,3),(2,4),(2,5)$ and $n=1$, or $\left(d_{1}, d_{2}\right)=(1, d)$ for $n=1,2$ and any $d \geqslant n$.
Furthermore, in all cases listed in Examples 3.4 3.7 but not in the above list, one can easily construct a $\left(\mathbb{C}^{*}\right)^{4}$-fixed stable pair in $P_{n}(X, \beta) \backslash P_{n}(S, \beta)$ using the combinatorial description of stable pairs on toric varieties PT2, CK2.

Conclusion. For any $\left(S, L_{1}, L_{2}\right)$ with $L_{1} \otimes L_{2} \cong K_{S}, L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef, and $S$ minimal and toric, we have classified all $\beta \in H_{2}(S, \mathbb{Z})$ and $n \geqslant 0$ such that $P_{n}(X, \beta) \cong P_{n}(S, \beta) \neq \varnothing$.

In the next section, we develop a method to determine the stable pair invariants $P_{n, \beta}([\mathrm{pt}])$ in all of these cases (tabulated in Appendix (A).

## 4. Invariants

4.1. Virtual classes of relative Hilbert schemes. For $S$ a smooth projective surface, $\beta \in$ $H_{2}(S, \mathbb{Z})$, and $n \in \mathbb{Z}$, the moduli space $P_{n}(S, \beta)$ has a nice description in terms of relative Hilbert schemes due to Pandharipande-Thomas [PT3]. Given a stable pair $[(F, s)] \in P_{n}(S, \beta)$, one has a short exact sequence

$$
0 \rightarrow \mathcal{O}_{C} \rightarrow F \rightarrow Q \rightarrow 0
$$

where $C$ is the scheme theoretic support of $F$. Dualizing on $C$ yields a short exact sequence

$$
0 \rightarrow F^{*} \rightarrow \mathcal{O}_{C} \rightarrow \mathcal{E} x t^{1}\left(Q, \mathcal{O}_{C}\right) \rightarrow 0
$$

where we used $\mathcal{E} x t^{1}\left(F, \mathcal{O}_{C}\right)=0$ by [PT3, Lem. B.2]. Hence $\mathcal{E} x t^{1}\left(Q, \mathcal{O}_{C}\right) \cong \mathcal{O}_{Z}$ for some 0 -dimensional subscheme $Z \subseteq C$ of length

$$
m=n+g(\beta)-1=n+\frac{1}{2} \beta\left(\beta+K_{S}\right)
$$

As shown in [PT3, Prop. B.8.], the family version of this argument gives an isomorphism

$$
\begin{equation*}
P_{n}(S, \beta) \cong \operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right) \tag{4.1}
\end{equation*}
$$

where $\operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)$ denotes the relative Hilbert scheme of $m$ points on the fibres of the universal curve $\mathcal{C} \rightarrow H_{\beta}$ and $H_{\beta}$ denotes the Hilbert scheme of effective divisors on $S$ in class $\beta$. The description in terms of relative Hilbert schemes helps to establish smoothness. Although we do not need it for this paper, we include the following observation.

Proposition 4.1. In all the cases listed in Proposition 3.9 and Remark 3.10, $P_{n}(S, \beta)$ is smooth.
Proof. The method in this proof was also used in KST. Let $S=\mathbb{P}^{2}$, then for any $\beta=d[H]$ with $d \geqslant 1$, and any $n \in \mathbb{Z}$, we have a morphism

$$
\begin{equation*}
P_{n}(S, \beta) \cong \operatorname{Hilb}^{m}(\mathcal{C} /|\mathcal{O}(d)|) \rightarrow S^{[m]} \tag{4.2}
\end{equation*}
$$

where $m=n+\frac{1}{2} d(d-3)$. The fibre over $Z \in S^{[m]}$ is the projectivization of the kernel of the evaluation map $H^{0}\left(\mathbb{P}^{2}, \mathcal{O}(d)\right) \rightarrow H^{0}\left(Z,\left.\mathcal{O}(d)\right|_{Z}\right)$. It suffices to show that for $n$ and $d \neq 1$ as in Proposition 3.9, this map is surjective. Then it follows that the fibres of (4.2) are equidimensional projective spaces and $P_{n}(S, \beta)$ is smooth, because $S^{[m]}$ is also smooth. Surjectivity of the evaluation map for all $Z \in S^{[m]}$ is equivalent to ( $m-1$ )-very ampleness of $\mathcal{O}(d)$ (by definition, $\overline{\mathrm{BS}})$. Beltrametti-Sommese showed that $\mathcal{O}(d)$ is $(m-1)$-very ample if and only if $m-1 \leqslant d$, i.e.

$$
n \leqslant d-\frac{1}{2} d(d-3)+1
$$

This inequality is satisfied for all $n$ and $d \neq 1$ in Cases (2), (3) of Proposition 3.9, Smoothness of $P_{n}(S, \beta)$ for $d=1$ and any $n$ is clear, because in this case the fibres of (4.2) are $\operatorname{Sym}^{m}\left(\mathbb{P}^{1}\right) \cong \mathbb{P}^{m}$.

For $S=\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}\left(d_{1} H_{1}+d_{2} H_{2}\right)$ is $k$-very ample if and only if $k \leqslant \min \left\{d_{1}, d_{2}\right\}$ [BS]. For $S=\mathbb{F}_{a}($ for any $a \geqslant 1), \mathcal{O}\left(d_{1} B+d_{2} F\right)$ is $k$-very ample if and only if $k \leqslant \min \left\{d_{1}, d_{2}-a d_{1}\right\}$ BS]. The proof in the remaining cases of Proposition 3.9 and Remark 3.10 then follows similarly.

Let $\mathcal{Z} \subseteq S \times S^{[m]}$ be the universal subscheme and denote the pull-back of $\mathcal{Z}$ to $S \times S^{[m]} \times H_{\beta}$ by the same symbol (and similarly for $\mathcal{C} \subseteq S \times H_{\beta}$ ). Consider the rank $m$ vector bundle

$$
\mathcal{O}(\mathcal{C})^{[m]}:=\pi_{*}\left(\left.\mathcal{O}(\mathcal{C})\right|_{\mathcal{Z}}\right)
$$

on $S^{[m]} \times H_{\beta}$, where $\pi: S \times S^{[m]} \times H_{\beta} \rightarrow S^{[m]} \times H_{\beta}$ is the projection. By [KT1, App. A], there exists a tautological section $s$ of $\mathcal{O}(\mathcal{C})^{[m]}$ cutting out $\operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)$ from its ambient space

$$
s^{-1}(0) \cong \operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right) \stackrel{\mathcal{O}(\mathcal{C})^{[m]}}{ } \stackrel{\downarrow}{l}^{[m]} \times H_{\beta} .
$$

In general $H_{\beta}$ is not smooth (or smooth but not of expected dimension). Therefore, this construction only provides a relative perfect obstruction theory on $\operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right) \rightarrow H_{\beta}$. The Hilbert scheme of divisors $H_{\beta}$ has a natural perfect obstruction theory

$$
\left(\mathbf{R} p_{*} \mathcal{O}_{\mathcal{C}}(\mathcal{C})\right)^{\vee} \rightarrow \mathbb{L}_{H_{\beta}}
$$

where $p: S \times H_{\beta} \rightarrow H_{\beta}$ denotes projection. This is the perfect obstruction theory used to define the Poincaré/Seiberg-Witten invariants of $S$ in DKO, CK. Taken together, these provide an absolute perfect obstruction theory on $P_{n}(S, \beta) \cong \operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)$ by [KT1, App. A.3]. The virtual tangent bundle of this absolute perfect obstruction theory is

$$
\mathbf{R} \mathcal{H o m} \pi_{\pi_{S}}\left(\mathbb{I}_{S}, \mathbb{F}\right)
$$

where $\mathbb{I}_{S}^{\bullet}=\{\mathcal{O} \rightarrow \mathbb{F}\}$ denotes the universal stable pair on $S \times P_{n}(S, \beta)$ and $\pi_{S}: S \times P_{n}(S, \beta) \rightarrow$ $P_{n}(S, \beta)$ is the projection. By [Koo, Prop. 2.1], the resulting virtual class satisfies

$$
\begin{equation*}
\jmath_{*}\left[\operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)\right]^{\mathrm{vir}}=\left(S^{[m]} \times\left[H_{\beta}\right]^{\mathrm{vir}}\right) \cdot e\left(\mathcal{O}(\mathcal{C})^{[m]}\right) \tag{4.3}
\end{equation*}
$$

The corresponding virtual class on $P_{n}(S, \beta)$, via the isomorphism (4.1), is denoted by $\left[P_{n}(S, \beta)\right]^{\text {vir }}$.
4.2. Comparison of virtual classes. Let $S$ be a smooth projective surface and $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$. We consider the local surface $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$, which is a Calabi-Yau 4 -fold. Fix $n \in \mathbb{Z}$ and $\beta \in H_{2}(S, \mathbb{Z})$ such that $P_{n}(X, \beta)$ is proper. Then it has a virtual class

$$
\begin{equation*}
\left[P_{n}(X, \beta)\right]^{\mathrm{vir}} \in H_{2 n}\left(P_{n}(X, \beta), \mathbb{Z}\right) \tag{4.4}
\end{equation*}
$$

in the sense of Borisov-Joyce [BJ], which depends on a choice of orientation on $P_{n}(X, \beta)$. In order to apply [BJ] to our case, we need the existence of a $(-2)$-shifted symplectic structure on $P_{n}(X, \beta)$ and an orientability result as reviewed in Section 2.1. The existence of a $(-2)$-shifted symplectic structure on $P_{n}(X, \beta)$ was shown in Bus, Thm. 7.3.2] and [Pre, Thm. 4.0.8]. By CMT2, Thm. 5.3], the existence of orientations on $P_{n}(X, \beta)$ can be reduced to the existence of orientations on the moduli stack $\mathfrak{M}_{n}(X, \beta)$ of coherent sheaves $F$ on $X$ with 1-dimensional proper support of class $\beta$ and $\chi(F)=n$. Taking $Y=\operatorname{Tot}_{S}\left(L_{1}\right)$, we have $X=\operatorname{Tot}_{Y}\left(K_{Y}\right)$. By considering the derived enhancement of $\mathfrak{M}_{n}(X, \beta)$, it is the $(-2)$-shifted cotangent bundle of a
derived moduli stack of sheaves on $Y$. Therefore $\mathfrak{M}_{n}(X, \beta)$ has an orientation (see e.g. Tod, Lem. 4.3] for a similar argument in the case of Calabi-Yau threefolds).

We denote by $[\mathrm{pt}] \in H^{4}(X, \mathbb{Z})$ the pull-back along $\pi: X \rightarrow S$ of the Poincaré dual of the point class on $S$. Using the same notation as in Section 1.2, we define stable pair invariants

$$
\begin{equation*}
P_{n, \beta}([\mathrm{pt}]):=\int_{\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}} \tau([\mathrm{pt}])^{n} \in \mathbb{Z} \tag{4.5}
\end{equation*}
$$

When $n=0$, we simply write $P_{0, \beta}:=P_{0, \beta}([\mathrm{pt}])$.
Assuming $P_{n}(X, \beta) \cong P_{n}(S, \beta)$, we can compare the virtual class (4.4) to the virtual class on the relative Hilbert scheme (4.3) studied in KT1, KT2. In Proposition 3.9 and Remark 3.10 we gave a list of examples where this assumption is satisfied.
Proposition 4.2. Let $S$ be a smooth projective surface, $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$ and let $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Suppose $\beta \in H_{2}(S, \mathbb{Z})$ and $n \geqslant 0$ are chosen such that $P_{n}(X, \beta) \cong$ $P_{n}(S, \beta)$. Then there exists a choice of orientation such that

$$
\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}=(-1)^{\beta \cdot L_{2}+n} \cdot e\left(-\mathbf{R} \mathcal{H o m}_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)\right) \cdot\left[P_{n}(S, \beta)\right]^{\mathrm{vir}}
$$

Here $\left[P_{n}(S, \beta)\right]^{\text {vir }}$ is the virtual class induced from the relative Hilbert scheme (Section 4.1), $\mathbb{I}_{S}^{\bullet}=$ $\{\mathcal{O} \rightarrow \mathbb{F}\}$ denotes the universal stable pair on $S \times P_{n}(S, \beta)$, and $\pi_{P_{S}}: S \times P_{n}(S, \beta) \rightarrow P_{n}(S, \beta)$ is the projection. The sign results from a preferred choice of orientation.
Proof. Let $Y=\operatorname{Tot}_{S}\left(L_{1}\right)$. Then $X=\operatorname{Tot}_{Y}\left(K_{Y}\right)$ is the total space of the canonical bundle of $Y$. By the assumption, we have isomorphisms of moduli spaces

$$
\begin{equation*}
P_{n}(S, \beta) \cong P_{n}(Y, \beta) \cong P_{n}(X, \beta) \tag{4.6}
\end{equation*}
$$

Let $\iota: S \hookrightarrow Y$ denote the zero section. A stable pair $I_{S}^{\bullet}=\left\{s: \mathcal{O}_{S} \rightarrow F\right\} \in P_{n}(S, \beta)$ on $S$ induces a stable pair

$$
I_{Y}^{\bullet}=\left\{\mathcal{O}_{Y} \rightarrow \iota_{*} \mathcal{O}_{S} \xrightarrow{\iota_{*} s} \iota_{*} F\right\}
$$

on $Y$. Consider the distinguished triangle

$$
\begin{equation*}
I_{Y}^{\bullet} \rightarrow \mathcal{O}_{Y} \rightarrow \iota_{*} F \tag{4.7}
\end{equation*}
$$

Applying $\mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, \cdot\right)$ and taking out trace gives a distinguished triangle

$$
\mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow \mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, I_{Y}^{\bullet}\right)_{0}[1] \rightarrow \mathbf{R} \operatorname{Hom}_{Y}\left(\iota_{*} F, \mathcal{O}_{Y}\right)[2]
$$

Applying adjunction and the isomorphism

$$
\begin{equation*}
\mathbf{L} \iota^{*} I_{Y}^{\bullet} \cong I_{S}^{\bullet} \oplus F \otimes L_{1}^{-1} \tag{4.8}
\end{equation*}
$$

gives a long exact sequence

$$
\cdots \rightarrow \operatorname{Ext}_{S}^{i}\left(I_{S}^{\bullet}, F\right) \oplus \operatorname{Ext}_{S}^{i}\left(F, F \otimes L_{1}\right) \rightarrow \operatorname{Ext}_{Y}^{i+1}\left(I_{Y}^{\bullet}, I_{Y}^{\bullet}\right)_{0} \rightarrow \operatorname{Ext}_{Y}^{i+2}\left(\iota_{*} F, \mathcal{O}_{Y}\right) \rightarrow \cdots
$$

Note that $\operatorname{Ext}_{Y}^{1}\left(\iota_{*} F, \mathcal{O}_{Y}\right) \cong \operatorname{Ext}_{Y}^{2}\left(\mathcal{O}_{Y}, \iota_{*} F \otimes K_{Y}\right)^{\vee}=0$. Furthermore, the isomorphism (4.6) induces an isomorphism on Zariski tangent spaces

$$
\operatorname{Ext}_{S}^{0}\left(I_{S}^{\bullet}, F\right) \cong \operatorname{Ext}_{Y}^{1}\left(I_{Y}^{\bullet}, I_{Y}^{\bullet}\right)_{0}
$$

Therefore, we deduce $\operatorname{Hom}_{S}\left(F, F \otimes L_{1}\right)=0\left(\right.$ similarly $\left.\operatorname{Hom}_{S}\left(F, F \otimes L_{2}\right)=0\right)$. This vanishing allows us to conclude that the natural (Le Potier) pair obstruction theory

$$
\begin{equation*}
\left(\mathbf{R} \mathcal{H o m}_{\pi_{P_{Y}}}\left(\mathbb{I}_{Y}, \iota_{P_{Y} *} \mathbb{F}\right)\right)^{\vee} \rightarrow \mathbb{L}_{P_{n}(Y, \beta)} \tag{4.9}
\end{equation*}
$$

is perfect, i.e. 2-term, as we will now show ${ }^{7}$. Here $\mathbb{I}_{Y}=\left\{\mathcal{O} \rightarrow \iota_{P_{Y} *} \mathbb{F}\right\}$ denotes the universal stable pair on $Y \times P_{n}(Y, \beta), \iota_{P_{Y}}: S \times P_{n}(Y, \beta) \hookrightarrow Y \times P_{n}(Y, \beta)$ is the base change of the zero section, and $\pi_{P_{Y}}: Y \times P_{n}(Y, \beta) \rightarrow P_{n}(Y, \beta)$ denotes the projection.

From the distinguished triangle

$$
\begin{equation*}
\mathbf{R H o m}_{Y}\left(\iota_{*} F, \iota_{*} F\right) \rightarrow \mathbf{R H o m}_{Y}\left(\mathcal{O}_{Y}, \iota_{*} F\right) \rightarrow \mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \tag{4.10}
\end{equation*}
$$

we obtain an exact sequence

$$
0=H^{2}\left(Y, \iota_{*} F\right) \rightarrow \operatorname{Ext}_{Y}^{2}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow \operatorname{Ext}_{Y}^{3}\left(\iota_{*} F, \iota_{*} F\right) \rightarrow 0 \rightarrow \operatorname{Ext}_{Y}^{3}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow 0
$$

Moreover, by adjunction and $\mathbf{L} \iota^{*} F \cong F \oplus F \otimes L_{1}^{-1}[1]$, we have

$$
\operatorname{Ext}_{Y}^{3}\left(\iota_{*} F, \iota_{*} F\right) \cong \operatorname{Ext}_{S}^{3}(F, F) \oplus \operatorname{Ext}_{S}^{2}\left(F, F \otimes L_{1}\right) \cong \operatorname{Hom}_{S}\left(F, F \otimes L_{2}\right)^{\vee}=0
$$

Hence $\operatorname{Ext}_{Y}^{2}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \cong \operatorname{Ext}_{Y}^{3}\left(\iota_{*} F, \iota_{*} F\right)=0$. Also note that $\operatorname{Hom}_{Y}\left(\iota_{*} F, \iota_{*} F\right) \rightarrow \operatorname{Hom}_{Y}\left(\mathcal{O}_{Y}, \iota_{*} F\right)$ is injective. Therefore $\operatorname{Ext}_{Y}^{i}\left(I_{Y}^{\bullet}, \iota_{*} F\right)=0$ unless $i=0,1$ and the complex (4.9) is 2 -term. We denote the corresponding virtual class by $\left[P_{n}(Y, \beta)\right]$ pair v.

[^6]We can now use the argument of [CMT2, Prop. 4.3] to deduce that the 4 -fold virtual class $\left[P_{n}(X, \beta)\right]^{\text {vir }}$ of (4.4) equals the pairs virtual class $\left[P_{n}(Y, \beta)\right]_{\text {pair }}^{\text {vir }}$. For completeness, we repeat the argument. Just like pushing forward from $S$ to $Y$ gives (4.7) and (4.8), pushing forward further to $X$ gives

\mathbf{R H o m}_{X}\left(I_{X}^{\bullet}, \jmath_{*} \iota_{*} F\right) \rightarrow & \mathbf{R H o m}_{X}\left(I_{X}^{\bullet}, I_{X}^{\bullet}\right)_{0}[1] \rightarrow \mathbf{R H o m}_{X}\left(\jmath_{*} \iota_{*} F, \mathcal{O}_{X}\right)[2] \\
& \mathbf{L} \jmath^{*} I_{X}^{\bullet} \cong I_{Y}^{\bullet} \oplus \iota_{*} F \otimes K_{Y}^{-1}
\end{aligned}
$$

where

$$
I_{X}^{\bullet}=\left\{\mathcal{O}_{X} \rightarrow \jmath_{*} \iota_{*} \mathcal{O}_{S} \xrightarrow{J_{*} \iota_{*} s} \jmath_{*} \iota_{*} F\right\}
$$

and we denote the zero section by $\jmath: Y \hookrightarrow X$. Let $T$ be the cone of the composition

$$
\mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow \mathbf{R H o m}_{X}\left(I_{X}^{\bullet}, \jmath_{*} \iota_{*} F\right) \rightarrow \mathbf{R H o m}_{X}\left(I_{X}^{\bullet}, I_{X}^{\bullet}\right)_{0}[1] .
$$

Then $T$ fits in the distinguished triangles

$$
\begin{align*}
& \mathbf{R H o m}_{Y}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow \mathbf{R} \operatorname{Hom}_{X}\left(I_{X}^{\bullet}, I_{X}^{\bullet}\right)_{0}[1] \rightarrow T \\
& \mathbf{R} \operatorname{Hom}_{Y}\left(\iota_{*} F, \iota_{*} F \otimes K_{Y}\right) \rightarrow T \rightarrow \mathbf{R} \operatorname{Hom}_{X}\left(\jmath_{*} \iota_{*} F, \mathcal{O}_{X}\right)[2] \tag{4.11}
\end{align*}
$$

Applying Serre duality to the first and third term of the second distinguished triangle, dualizing, and shifting gives the following distinguished triangle

$$
\mathbf{R H o m}_{Y}\left(\iota_{*} F, \iota_{*} F\right)[2] \rightarrow \mathbf{R H o m}_{X}\left(\mathcal{O}_{X}, \jmath_{*} \iota_{*} F\right)[2] \rightarrow T^{\vee}
$$

Comparing to (4.10), we obtain $T \cong \mathbf{R H o m}_{Y}\left(I_{\dot{Y}}, \iota_{*} F\right)^{\vee}[-2]$. Hence from (4.11) we get a short exact sequence

$$
0 \rightarrow \operatorname{Ext}_{Y}^{1}\left(I_{Y}^{\bullet}, \iota_{*} F\right) \rightarrow \operatorname{Ext}_{X}^{2}\left(I_{X}^{\bullet}, I_{X}^{\bullet}\right)_{0} \rightarrow \operatorname{Ext}_{Y}^{1}\left(I_{Y}^{\bullet}, \iota_{*} F\right)^{\vee} \rightarrow 0
$$

where we crucially used $\operatorname{Ext}_{Y}^{2}\left(I_{Y}^{\bullet}, \iota_{*} F\right)=0$ which was shown above. This way, we obtain a half-dimensional subspace $\operatorname{Ext}_{Y}^{1}\left(I_{Y}^{\bullet}, \iota_{*} F\right)$ of $\operatorname{Ext}_{X}^{2}\left(I_{X}^{\bullet}, I_{X}^{\bullet}\right)_{0}$. One can show that it is isotropic by the exact same argument as in the proof of CMT2, Prop. 3.3, Prop. 2.11]. From this, it is concluded in loc. cit. that

$$
\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}=(-1)^{\beta \cdot L_{2}+n} \cdot\left[P_{n}(Y, \beta)\right]_{\text {pair }}^{\mathrm{vir}}
$$

Here the sign comes from a choice of preferred orientation discussed in a similar setting in CaO.
Finally, we express the pairs virtual class on $Y$ in terms of the pairs virtual class on $S$. By adjunction, we have

$$
\begin{aligned}
\mathbf{R} \mathcal{H o m}_{\pi_{P_{Y}}}\left(\mathbb{I}_{Y}^{\bullet}, \iota_{P_{Y} *} \mathbb{F}\right) & \cong \mathbf{R} \mathcal{H o m} \pi_{\pi_{P_{S}}}\left(\mathbf{L}_{P_{Y}}^{*} \mathbb{I}_{Y}^{\bullet}, \mathbb{F}\right) \\
& \cong \mathbf{R H o m}{\pi_{P_{S}}}\left(\mathbb{I}_{S}^{\bullet}, \mathbb{F}\right) \oplus \mathbf{R} \mathcal{H o m}{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right),
\end{aligned}
$$

where $\pi_{P_{S}}: S \times P_{n}(S, \beta) \rightarrow P_{n}(S, \beta) \cong P_{n}(Y, \beta)$ denotes the projection. From the vanishing $\operatorname{Hom}_{S}\left(F, F \otimes L_{1}\right)=\operatorname{Hom}_{S}\left(F, F \otimes L_{2}\right)=0$, for all $[(F, s)] \in P_{n}(S, \beta)$, we deduce that

$$
-\mathbf{R} \mathcal{H o m} \pi_{{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right) \cong \mathcal{E} x t_{\pi_{P_{S}}}^{1}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)
$$

is locally free on $P_{n}(Y, \beta) \cong P_{n}(S, \beta)$. Hence the two virtual tangent bundles on $P_{n}(Y, \beta) \cong$ $P_{n}(S, \beta)$ differ by a locally free sheaf (in degree 1). Therefore, by [Sie, Thm. 4.6], we have

$$
\left[P_{n}(Y, \beta)\right]_{\text {pair }}^{\mathrm{vir}}=e\left(-\mathbf{R} \mathcal{H o m}_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)\right) \cdot\left[P_{n}(S, \beta)\right]^{\mathrm{vir}}
$$

Remark 4.3. Let $S$ be a smooth projective surface satisfying $b_{1}(S)=p_{g}(S)=0$. Let $L_{1}, L_{2} \in$ $\operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$ and $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Suppose $P_{n}(X, \beta)$ is proper. Once the virtual localization formula for stable pair theory on Calabi-Yau 4-folds is established 8 , we expect that it will induce a virtual class on each of the connected components of $P_{n}(X, \beta)^{\mathbb{C}^{*}}$, where $\mathbb{C}^{*}$ is the 1-dimensional subtorus, preserving the Calabi-Yau volume form, inside the torus $\mathbb{C}^{*} \times \mathbb{C}^{*}$ acting on the fibres of $X$. When $P_{n}(S, \beta) \subseteq P_{n}(X, \beta)^{\mathbb{C}^{*}}$ is open and closed, this gives a virtual class, which we expect to be given by (for an appropriate choice of orientation)

$$
\begin{equation*}
(-1)^{\beta \cdot L_{2}+n} \cdot e\left(-\mathbf{R} \mathcal{H o m} \pi_{P_{S}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right) \otimes \mathfrak{t}_{1}\right) \cdot\left[P_{n}(S, \beta)\right]^{\mathrm{vir}}, \tag{4.12}
\end{equation*}
$$

where $\left[P_{n}(S, \beta)\right]^{\text {vir }}$ is the virtual class induced from the relative Hilbert scheme (Section 4.1), $\mathfrak{t}_{1}$ is a primitive character corresponding to the first component of the action of $\mathbb{C}^{*} \times \mathbb{C}^{*}$, and $e(\cdot)$ denotes equivariant Euler class. When $P_{n}(X, \beta)$ is non-proper, one could define the contribution of $P_{n}(S, \beta)$ to the stable pair invariants of $X$ by (4.12) (capped with appropriate insertions).

[^7]4.3. Main theorem. We are now ready to prove the theorem of the introduction. Recall from (1.6) that we denote by $T_{S^{[m]}}(\mathcal{L})$ the twisted (by $\mathcal{L}$ ) tangent bundle of $S^{[m]}$.

Theorem 4.4. Let $S$ be a smooth projective surface with $b_{1}(S)=p_{g}(S)=0$ and $L_{1}, L_{2} \in \operatorname{Pic}(S)$ such that $L_{1} \otimes L_{2} \cong K_{S}$. Suppose $\beta \in H_{2}(S, \mathbb{Z})$ and $n \geqslant 0$ are chosen such that $P_{n}(X, \beta) \cong$ $P_{n}(S, \beta)$ for $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$. Denote by $[\mathrm{pt}] \in H^{4}(X, \mathbb{Z})$ the pull-back of the Poincaré dual of the point class on $S$. Let $P_{n}(X, \beta)$ be endowed with the orientation as in (1.5). Then
$P_{n, \beta}([\mathrm{pt}])=(-1)^{\beta \cdot L_{2}+n} \int_{S^{[m]} \times \mathbb{P} \chi(\beta)-1} c_{m}\left(\mathcal{O}_{S}(\beta)^{[m]}(1)\right) \frac{h^{n}(1+h)^{\chi\left(L_{1}(\beta)\right)}(1-h)^{\chi\left(L_{2}(\beta)\right)} c\left(T_{S[m]}\left(L_{1}\right)\right)}{c\left(L_{1}(\beta)^{[m]}(1)\right) \cdot c\left(\left(L_{2}(\beta)^{[m]}(1)\right)^{\vee}\right)}$,
when $\beta^{2} \geqslant 0$. Here $m:=n+g(\beta)-1$ and $h:=c_{1}(\mathcal{O}(1))$. Moreover, $P_{n, \beta}([\mathrm{pt}])=0$ when $\beta^{2}<0$.
Proof. Suppose $\beta$ is an effective divisor and $m \geqslant 0$, otherwise $P_{n}(S, \beta) \cong \operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)=\varnothing$ and $P_{n, \beta}([\mathrm{pt}])=0$. Consider the closed embedding

$$
\jmath: \operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right) \hookrightarrow S^{[m]} \times H_{\beta}
$$

as in Section 4.1 Below, we will show that there exists a class $\psi \in K_{0}\left(S^{[m]} \times H_{\beta}\right)$ restricting to $e\left(-\mathbf{R} \mathcal{H} m_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)\right) \cdot \tau([\mathrm{pt}])^{n}$ on $\operatorname{Hilb}^{m}\left(\mathcal{C} / H_{\beta}\right)$. By Proposition 4.2 it follows that

$$

P_{n, \beta}([\mathrm{pt}])=\int_{S^{[m]} \times\left[H_{\beta}\right]^{\mathrm{vir}}} c_{m}\left(\mathcal{O}(\mathcal{C})^{[m]}\right) \cdot \psi \tag{4.13}
\end{equation*}
$$

Since $b_{1}(S)=p_{g}(S)=0$, we have DKO, KT2

$$
\left[H_{\beta}\right]^{\mathrm{vir}}=|\beta|^{\mathrm{vir}}=h^{h^{1}(\mathcal{O}(\beta))} \cap|\beta| \in H_{2 \chi(\beta)-2}(|\beta|)
$$

where $h$ denotes the class of the hyperplane on $H_{\beta}=|\beta|$. Furthermore, we have

$$
\mathcal{O}(\mathcal{C})^{[m]}:=\pi_{*}(\mathcal{O}(\mathcal{C}) \mid \mathcal{Z}) \cong \mathcal{O}(\beta)^{[m]}(1)
$$

which follows from the isomorphism $\mathcal{O}(\mathcal{C}) \cong \mathcal{O}_{S}(\beta) \boxtimes \mathcal{O}(1)$ on $S \times|\beta|$. Therefore $P_{n, \beta}([\mathrm{pt}])=0$, unless $\chi(\beta) \geqslant 1$, which we assume from now on.

Recall from the proof of Proposition 4.2 that $-\mathbf{R H} \operatorname{Hom}_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right) \cong \mathcal{E} x t_{\pi_{P_{S}}}^{1}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)$ is locally free on $P_{n}(S, \beta)$ and its rank is $\beta^{2}$. Therefore $P_{n, \beta}([\mathrm{pt}])=0$ unless $\beta^{2} \geqslant 0$, which we assume from now on. Next, we extend the complex $-\mathbf{R} \mathcal{H} \boldsymbol{H}_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)$ from $P_{n}(S, \beta)$ to $S^{[m]} \times|\beta|$. In $K$-theory, we have $\mathbb{I}_{S}^{\bullet}=\mathcal{O}-\mathbb{F}$ and

$$
\begin{aligned}
& -\mathbf{R H o m}{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)=-\chi\left(L_{1}\right) \otimes \mathcal{O}+\mathbf{R} \mathcal{H o m}_{\pi_{P_{S}}}\left(\mathcal{O}, \mathbb{I}_{S}^{\bullet} \boxtimes L_{1}\right) \\
& +\mathbf{R} \mathcal{H o m} \pi_{{P_{S}}_{S}}\left(\mathbb{I}_{S}, L_{1}\right)-\mathbf{R} \mathcal{H o m} \pi_{P_{S}}\left(\mathbb{I}_{S}, \mathbb{I}_{S}^{\bullet} \boxtimes L_{1}\right) \\
& =-\chi\left(L_{1}\right) \otimes \mathcal{O}+\mathbf{R} \mathcal{H} \text { om }_{\pi_{P_{S}}}\left(\left(\mathbb{I}_{S}^{\bullet}\right)^{\vee}, L_{1}\right) \\
& \left.+\mathbf{R} \mathcal{H o m} \pi_{P_{S}}\left(\mathcal{O},\left(\mathbb{I}_{S}\right)^{\vee} \boxtimes L_{1}\right)-\mathbf{R} \mathcal{H o m} \pi_{\pi_{P_{S}}}\left(\left(\mathbb{I}_{S}\right)^{\vee},\left(\mathbb{I}_{S}\right)^{\vee} \boxtimes L_{1}\right)\right),
\end{aligned}
$$

where we suppressed some obvious pull-backs. On $S \times|\beta| \times S^{[m]}$, we have the sheaf $\mathcal{I} \boxtimes \mathcal{O}_{S}(\beta) \boxtimes$ $\mathcal{O}(1)$, where we use the notation from the introduction. By [KT1, Lem. A.4], we have

$$
\left.\left(\mathbb{I}_{S}^{\bullet}\right)^{\vee} \cong \mathcal{I} \boxtimes \mathcal{O}_{S}(\beta) \boxtimes \mathcal{O}(1)\right|_{\operatorname{Hilb}^{m}(\mathcal{C} /|\beta|) \times S}
$$

Next we can replace $\mathcal{I}$ by $\mathcal{O}-\mathcal{O}_{\mathcal{Z}}$ in $K$-theory. Then $-\mathbf{R H o m}{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)$ is the restriction of the following element in the $K$-group of $S^{[m]} \times|\beta|$

\begin{align*}
- & \chi\left(L_{1}\right) \otimes \mathcal{O}+\mathbf{R} \mathcal{H o m}_{\pi}\left(\left(\mathcal{O}-\mathcal{O}_{\mathcal{Z}}\right) \boxtimes\left(\mathcal{O}_{S}(\beta) \otimes L_{1}^{-1}\right) \boxtimes \mathcal{O}(1), \mathcal{O}\right) \\
& +\mathbf{R} \mathcal{H o m}_{\pi}\left(\mathcal{O},\left(\mathcal{O}-\mathcal{O}_{\mathcal{Z}}\right) \boxtimes\left(\mathcal{O}_{S}(\beta) \otimes L_{1}\right) \boxtimes \mathcal{O}(1)\right)-\mathbf{R H o m} \operatorname{Hom}_{\pi}\left(\mathcal{I}, \mathcal{I} \boxtimes L_{1}\right) \\
= & -\chi\left(L_{1}\right) \otimes \mathcal{O}+\chi\left(L_{1}(\beta)\right) \otimes \mathcal{O}(1)+\chi\left(L_{2}(\beta)\right) \otimes \mathcal{O}(-1)  \tag{4.14}\\
& -\left(L_{1}(\beta)\right)^{[m]} \boxtimes \mathcal{O}(1)-\left(\left(L_{2}(\beta)\right)^{[m]}\right)^{\vee} \boxtimes \mathcal{O}(-1)-\mathbf{R H o m} \mathcal{H}_{\pi}\left(\mathcal{I}, \mathcal{I} \boxtimes L_{1}\right),
\end{align*}
$$

where $\pi: S \times S^{[m]} \times|\beta| \rightarrow S^{[m]} \times|\beta|$ denotes the projection and we used Serre duality, $L_{1} \otimes L_{2} \cong$ $K_{S}$, and $L_{i}(\beta):=\mathcal{O}_{S}(\beta) \otimes L_{i}$.

Finally, we consider primary insertions

$$
\tau: H^{4}(X, \mathbb{Z}) \rightarrow H^{2}\left(P_{n}(X, \beta), \mathbb{Z}\right), \quad \tau(\gamma)=\pi_{P *}\left(\pi_{X}^{*} \gamma \cup \operatorname{ch}_{3}\left(\iota_{*} \mathbb{F}\right)\right)
$$

where $\pi_{X}, \pi_{P}$ are projections from $X \times P_{n}(X, \beta)$ to corresponding factors, and $\iota: S \times P_{n}(S, \beta) \hookrightarrow$ $X \times P_{n}(S, \beta) \cong X \times P_{n}(X, \beta)$ is the base change of the inclusion of the zero section. Note that $\operatorname{ch}_{3}\left(\iota_{*} \mathbb{F}\right)$ is Poincaré dual to the fundamental class of the scheme theoretic support of $\iota_{*} \mathbb{F}$, which we denote by $\left[\iota_{*} \mathbb{F}\right]$. The fundamental class of the scheme theoretic support of $\mathbb{F}$, which we
denote by $[\mathbb{F}]$, equals $\jmath^{*}[\mathcal{C}]$ where $\mathcal{C} \subseteq S \times S^{[m]} \times|\beta|$ is the pullback of the universal curve over $|\beta|$. Consider the commutative diagram


For $\gamma:=p^{*}[\mathrm{pt}] \in H^{4}(X, \mathbb{Z})$, where $[\mathrm{pt}]$ denotes the Poincaré dual of the point class on $S$, we work our way through the diagram

$$
\begin{align*}
\tau(\gamma) & =\pi_{P *}\left(\pi_{X}^{*} \gamma \cup\left[\iota_{*} \mathbb{F}\right]\right) \\
& =\pi_{P *} p_{*}\left(p^{*} \pi_{S}^{*}[\mathrm{pt}] \cup \iota_{*}[\mathbb{F}]\right) \\
& =\pi_{P *}\left(\pi_{S}^{*}[\mathrm{pt}] \cup[\mathbb{F}]\right)  \tag{4.15}\\
& =\jmath^{*}\left(\pi_{*}\left(\pi_{S}^{*}[\mathrm{pt}] \cup[\mathcal{C}]\right)\right) .
\end{align*}
$$

Using, once more, that on $S \times|\beta|$ we have $\mathcal{O}(\mathcal{C}) \cong \mathcal{O}_{S}(\beta) \boxtimes \mathcal{O}(1)$, we conclude

$$
\pi_{*}\left(\pi_{S}^{*}[\mathrm{pt}] \cup[\mathcal{C}]\right)=h \int_{S} \mathrm{pt}=h
$$

Therefore $\tau([\mathrm{pt}])^{n}$ is simply the restriction of the class $h^{n}$ on $S^{[m]} \times|\beta|$.
Since $\operatorname{rk}\left(-\mathbf{R} \mathcal{H} m_{\pi_{P_{S}}}\left(\mathbb{F}, \mathbb{F} \boxtimes L_{1}\right)\right)=\beta^{2}=2 m+\chi(\beta)-1-m-n$, we can replace Euler class by total Chern class. The result now follows from (4.13), (4.14), and (4.15).

Remark 4.5. For surfaces with $p_{g}(S)=0$ and $b_{1}(S)>0$, we can still use the formula for the virtual class from Proposition4.2. Suppose $h^{2}(L)=0$ for all $L \in \operatorname{Pic}_{\beta}(S)$. Then the virtual class $\left[H_{\beta}\right]^{\text {vir }}$ can be calculated by fixing a sufficiently ample effective divisor $A$ on $S$ and considering the embedding $H_{\beta} \hookrightarrow H_{[A]+\beta}$ as in DKO. (see also [KT1, Prop. A.2], [KT2]). Therefore the invariant can be expressed as an integral over $S^{[m]} \times H_{[A]+\beta}$, where $H_{[A]+\beta}$ is a projective bundle over $\operatorname{Pic}_{[A]+\beta}(S)$ via the Abel-Jacobi map. Pushing forward along the Abel-Jacobi map, the invariant can be expressed as an integral over $S^{[m]} \times \operatorname{Pic}_{A+\beta}(S)$.
4.4. Atiyah-Bott localization. In Corollary 3.9 Remark 3.10, we gave examples of ( $S, L_{1}, L_{2}$ ) for which the assumptions of Theorem 4.4 are satisfied. In all of these cases, $S$ is a toric surface. As a consequence, $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ is also toric, so in principle one could calculate the invariant $P_{n, \beta}([\mathrm{pt}])$ using the vertex formalism for stable pair invariants on toric Calabi-Yau 4 -folds developed in CK2, CKM ${ }^{9}$. However, the number of $\left(\mathbb{C}^{*}\right)^{4}$-fixed points is typically very large. For instance, for $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{1} \times \mathbb{P}^{1}, \mathcal{O}(-1,-1), \mathcal{O}(-1,-1)\right),\left(d_{1}, d_{2}\right)=(2,4)$, and $n=0$, we have 182 fixed points, whereas Theorem 4.4 only involves an integral over $S^{[2]} \times \mathbb{P}^{14}$.

The calculation of intersection numbers on Hilbert schemes of points on toric surfaces is a classical subject (see e.g. [ES]). Let $S$ be a smooth projective toric surface with torus $T=\left(\mathbb{C}^{*}\right)^{2}$. The action of $T$ on $S$ lifts to an action of $T$ on $S^{[m]}$ for any $m$. Let $P$ be a polynomial expression in Chern classes of

$$
\begin{equation*}
\mathbf{R} \Gamma(\mathcal{L}) \otimes \mathcal{O}-\mathbf{R} \mathcal{H} m_{\pi}(\mathcal{I}, \mathcal{I} \boxtimes \mathcal{L}), \quad \mathcal{L}^{[m]} \tag{4.16}
\end{equation*}
$$

for various choices of $T$-equivariant line bundles $\mathcal{L}$ on $S$ and where $\pi: S \times S^{[m]} \rightarrow S^{[m]}$ denotes the projection. Note that this includes Chern classes of the tangent bundle, which can be expressed as $-\mathbf{R} \mathcal{H} m_{\pi}(\mathcal{I}, \mathcal{I})_{0}\left(\right.$ since $\operatorname{Ext}^{i}\left(I_{Z}, I_{Z}\right)_{0}=0$ for $Z \in S^{[m]}$ and $\left.i \neq 1\right)$. Suppose also that the degree of $P$, as a class in the Chow ring $A^{*}\left(S^{[m]}\right)$, equals $\operatorname{dim} S^{[m]}=2 m$. By the Atiyah-Bott localization formula AB , we have

$$
\int_{S^{[m]}} P=\int_{\left(S^{[m]}\right)^{T}} \frac{\left.P\right|_{\left(S^{[m]}\right)^{T}}}{e\left(N_{\left.\left(S^{[m]}\right)^{T} / S^{[m]}\right)}\right.},
$$

where $e(\cdot)$ denotes the $T$-equivariant Euler class and $N_{\left(S^{[m]}\right)^{T} / S^{[m]}}$ is the normal bundle of the fixed point locus $\left(S^{[m]}\right)^{T} \subseteq S^{[m]}$. Furthermore, in this formula one has to choose a $T$-equivariant

[^8]lift of $P$. More precisely, one can choose a $T$-equivariant structure on all (complexes of) sheaves appearing in $P$ and replace all Chern classes appearing in $P$ by $T$-equivariant Chern classes.

The fixed point locus consists of isolated reduced points, which can be described combinatorially. Consider a cover by maximal $T$-invariant affine open subsets:

$$
\left\{U_{\sigma} \cong \operatorname{Spec} \mathbb{C}\left[x_{\sigma}, y_{\sigma}\right]\right\}_{\sigma=1}^{e(S)}
$$

Then the fixed locus $\left(S^{[m]}\right)^{T}$ precisely consists of the closed subschemes of $S$ defined by collections of monomial ideals

$$
\left\{I_{\sigma} \subseteq \mathbb{C}\left[x_{\sigma}, y_{\sigma}\right]\right\}_{\sigma=1}^{e(S)}
$$

of total colength $m$. The monomial ideals of finite colength in $\mathbb{C}[x, y]$ are in bijective correspondence with partitions. Explicitly, $\lambda=\left(\lambda_{1} \geqslant \cdots \geqslant \lambda_{\ell}\right)$ corresponds to the ideal

$$
\left(y^{\lambda_{1}}, x y^{\lambda_{2}}, \ldots, x^{\ell-1} y^{\lambda_{\ell}}, x^{\ell}\right)
$$

where $\ell(\lambda)=\ell$ is the length of $\lambda$. Hence we can index the points of the fixed locus $\left(S^{[m]}\right)^{T}$ by collections of partitions

$$
\boldsymbol{\lambda}=\left\{\lambda^{(\sigma)}\right\}_{\sigma=1}^{e(S)}
$$

of total size

$$
\sum_{\sigma=1}^{e(S)}\left|\lambda^{(\sigma)}\right|=\sum_{\sigma=1}^{e(S)} \sum_{i=1}^{\ell\left(\lambda^{(\sigma)}\right)} \lambda_{i}^{(\sigma)}=m .
$$

Denote the closed subscheme corresponding to $\boldsymbol{\lambda}$ by $Z_{\boldsymbol{\lambda}}$.
In order to calculate integrals such as the one in Theorem4.4by Atiyah-Bott localization, we need to consider Chern classes of

$$
\begin{align*}
\left.\mathcal{L}^{[m]}\right|_{Z_{\lambda}} & =H^{0}\left(\left.\mathcal{L}\right|_{Z_{\lambda}}\right) \in K_{0}^{T}(\mathrm{pt})=\mathbb{Z}\left[t_{1}^{ \pm 1}, t_{2}^{ \pm 1}\right]  \tag{4.17}\\
\left.\left(\mathbf{R} \Gamma(\mathcal{L}) \otimes \mathcal{O}-\mathbf{R} \mathcal{H} m_{\pi}(\mathcal{I}, \mathcal{I} \boxtimes \mathcal{L})\right)\right|_{Z_{\lambda}} & =\mathbf{R} \Gamma\left(\left.\mathcal{L}\right|_{Z_{\lambda}}\right)-\mathbf{R H o m}_{S}\left(I_{Z_{\lambda}}, I_{Z_{\lambda}} \otimes \mathcal{L}\right) \in K_{0}^{T}(\mathrm{pt})
\end{align*}
$$

where $t_{1}, t_{2}$ are the equivariant parameters of $T$.
Suppose $Z_{\boldsymbol{\lambda}}$ is a 0 -dimensional $T$-equivariant subscheme supported entirely on a maximal $T$-invariant affine open subset $U_{\sigma}$ and set $\lambda:=\lambda^{(\sigma)}$. Suppose we choose coordinates such that $U_{\sigma}=\operatorname{Spec} \mathbb{C}[x, y]$ and the torus action (on coordinate functions) is given by $\left(t_{1}, t_{2}\right) \cdot(x, y)=$ $\left(t_{1} x, t_{2} y\right)$. Denote the character corresponding to $\left.\mathcal{L}\right|_{U_{\sigma}}$ by $\chi\left(t_{1}, t_{2}\right)$. Then

$$
\begin{align*}
H^{0}\left(\left.\mathcal{L}\right|_{Z_{\lambda}}\right) & =\chi\left(t_{1}, t_{2}\right) \cdot Z_{\lambda} \\
\text { where } \quad Z_{\lambda} & :=\sum_{i=1}^{\ell(\lambda)} \sum_{j=1}^{\lambda_{i}} t_{1}^{i-1} t_{2}^{j-1} \tag{4.18}
\end{align*}
$$

Now suppose $W_{\mu}$ is a second 0 -dimensional $T$-equivariant subscheme supported entirely on $U_{\sigma}$ and write $\mu:=\mu^{(\sigma)}$. The following formula can be deduced from a well-known calculation using Čech cohomology (e.g. see [GK, Prop. 4.1]):

\begin{align*}
\mathbf{R H o m}_{S}\left(\mathcal{O}_{W_{\mu}}, \mathcal{O}_{Z_{\lambda}} \otimes \mathcal{L}\right) & =\chi\left(t_{1}, t_{2}\right) W_{\mu}^{*} Z_{\lambda} \frac{\left(1-t_{1}\right)\left(1-t_{2}\right)}{t_{1} t_{2}} \in K_{0}^{T}(\mathrm{pt}) \\
\text { where } \quad W_{\mu} & :=\sum_{i=1}^{\ell(\mu)} \sum_{j=1}^{\mu_{i}} t_{1}^{i-1} t_{2}^{j-1} \tag{4.19}
\end{align*}
$$

Here $(\cdot)^{*}$ is the involution defined by dualizing.
For arbitrary $Z_{\boldsymbol{\lambda}}$, the $K$-group classes of (4.17) can be determined from (4.18) and (4.19) by using the following equalities in $K$-theory

$$
\begin{aligned}
\mathcal{O}_{Z_{\lambda}} & =\sum_{\sigma=1}^{e(S)} \mathcal{O}_{Z_{\lambda}(\sigma)} \\
I_{\mathcal{O}_{Z_{\lambda}}} & =\mathcal{O}_{S}-\mathcal{O}_{Z_{\lambda}}
\end{aligned}
$$

where $Z_{\lambda^{(\sigma)}}$ denotes the 0-dimensional closed subscheme supported on $U_{\sigma}$ determined by $\lambda^{(\sigma)}$.
Consider Theorem 4.4 for the examples of $\left(S, L_{1}, L_{2}\right)$ listed in Proposition 3.9 and Remark 3.10. In each case, we calculated the invariant $P_{n, \beta}([\mathrm{pt}])$ by first integrating out the linear system $\mathbb{P}^{\chi(\beta)-1}$. This amounts to expanding the integrand in powers of $h=c_{1}(\mathcal{O}(1))$ and taking the coefficient of $h^{\chi(\beta)-1}$. This gives a polynomial expression $P$ in Chern classes of complexes of the
form (4.16). The integral $\int_{S^{[m]}} P$ is then calculated by Atiyah-Bott localization as described. The resulting stable pair invariants are tabulated in Appendix A.

With the numbers of Appendix A, we are able to do various new checks of the Cao-MaulikToda conjectures (Conjectures 1.1 and 1.2). Combining our tables in Appendix A with the tables for $n_{0, \beta}([\mathrm{pt}]), n_{1, \beta}$ in [KP, Sect. 3] gives Corollary 1.6 of the introduction.

Bousseau-Brini-van Garrel BBG determined all the genus zero Gromov-Witten (and therefore Gopakumar-Vafa type) invariants of $X=\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ with ( $S, L_{1}, L_{2}$ ) as in Remark 3.10 (as well as for other cases). Note that the method of Bousseau-Brini-van Garrel does not produce genus one Gopakumar-Vafa type invariants, so we can only do verifications of Conjecture 1.1 in these cases. Combining the tables in Appendix A with the values for genus zero Gopakumar-Vafa type invariants provided to us by Bousseau-Brini-van Garrel gives Corollary 1.8 of the introduction.

Recall that for ( $S, L_{1}, L_{2}$ ) with $L_{1} \otimes L_{2} \cong K_{S}, L_{1}^{-1}, L_{2}^{-1}$ non-trivial and nef, and $S$ minimal and toric, we classified all values of $n \geqslant 0$ for which $P_{n}(S, \beta) \cong P_{n}(X, \beta)$, and $P_{n}(S, \beta) \neq \varnothing$ (Remark 3.10). In these cases we therefore calculated all stable pair invariants $P_{n, \beta}([\mathrm{pt}])$.

## Appendix A. Tables

A.1. Local surfaces. In this section, we list the stable pair invariants $P_{n, \beta}([\mathrm{pt}])$ of $X=$ $\operatorname{Tot}_{S}\left(L_{1} \oplus L_{2}\right)$ for the cases mentioned in Proposition 3.9 and Remark 3.10, and for a few additional cases. We use the following conventions and notation:

- $P_{0,0}:=1$ and $P_{n, 0}([\mathrm{pt}])=0$ for all $n>0$.
- Entries decorated with $\star$ were defined by a virtual localization formula on the fixed locus and have been calculated using the vertex formalism as discussed in [CK2, CKM]. In these cases $P_{n}(X, \beta) \backslash P_{n}(S, \beta) \neq \varnothing$. See Remark A. 2 for a comparison to the globally defined invariants. All other entries have been computed using Theorem 4.4,
- Zeroes decorated with $\dagger$ have non-empty underlying moduli space $P_{n}(X, \beta)$. In this sense, they are "non-trivial" zeroes.

Remark A.1. Denoting the exceptional curve of $\mathbb{F}_{1}$ by $B$, we have $N_{B / X}=\mathcal{O}(-1) \oplus \mathcal{O} \oplus \mathcal{O}(-1)$, which has sections in the direction of $L_{1}$. Therefore $P_{1}(X,[B])$ is non-proper, which explains the gap in the table for $P_{1,(1,0)}([\mathrm{pt}])$.

A.2. Local $\mathbb{P}^{3}$. Consider $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right)$. Let $P_{0, d}:=P_{0, d[\ell]}$ and $P_{n, d}([\ell]):=P_{n, d[\ell]}([\ell])$ (for $n>0)$, where $[\ell] \in H_{2}\left(\mathbb{P}^{3}, \mathbb{Z}\right) \cong H_{2}(X, \mathbb{Z})$ denotes the class of a line $\ell \subseteq \mathbb{P}^{3}$ and we also write $[\ell] \in H^{4}(X, \mathbb{Z})$ for the pull-back of its Poincaré dual from $\mathbb{P}^{3}$ to $X$. Obviously, $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right)$ is not a local surface so Theorem 4.4 does not apply. All stable pair invariants in this section have been calculated using the vertex formalism of [CK2, CKM] (this is stressed by decorating the invariants with $\star)$. We determined the following values of $P_{0, d}$ and $P_{n, d}([\ell])$.

Remark A.2. For $X=\operatorname{Tot}_{\mathbb{P}^{3}}\left(K_{\mathbb{P}^{3}}\right)$ and all the cases in this table, we have $P_{n}\left(\mathbb{P}^{3}, \beta\right) \cong P_{n}(X, \beta)$. This can be deduced from a filtration argument similar to Proposition 3.9 combined with the fact that all degree 2 Cohen-Macaulay curves $C$ on $\mathbb{P}^{3}$ satisfy $\chi\left(\mathcal{O}_{C}\right) \geqslant 1$ (see also [CT2, p. 20]). Therefore, the reasoning of Proposition 4.2 yields

\left[P_{n}(X, \beta)\right]^{\mathrm{vir}}=(-1)^{\beta \cdot c_{1}\left(\mathbb{P}^{3}\right)+n} \cdot\left[P_{n}\left(\mathbb{P}^{3}, \beta\right)\right]_{\mathrm{pair}}^{\mathrm{vir}}, \tag{A.1}
\end{equation*}
$$

where $\left[P_{n}\left(\mathbb{P}^{3}, \beta\right)\right]_{\text {pair }}^{\text {vir }}$ is the virtual class of the pair perfect obstruction theory (4.9) on $\mathbb{P}^{3}$ (see also CMT2, Lem. 3.1] in a similar setting). The sign in this formula is a preferred choice of orientation on $P_{n}(X, \beta)$ as for (1.5). Now we are in the world of "ordinary" perfect obstruction theories and the torus action on $\mathbb{P}^{3}$ can be used to apply the Graber-Pandharipande virtual localization formula GP to the right hand side of (A.1). Similar to the argument for CK2, Thm. A.1], it then follows that the invariants in this table (defined by localization on the fixed locus CK2, CKM ) are equal to the global invariants (4.5). This reasoning also works for the local surface case $\left(S, L_{1}, L_{2}\right)=\left(\mathbb{P}^{2}, \mathcal{O}(-1), \mathcal{O}(-2)\right), d=2, n=3$, because then all stable pairs are scheme theoretically supported in the threefold $Y=\operatorname{Tot}_{S}\left(L_{1}\right)$.
