

# Carleman estimates and some inverse problems for the coupled quantitative thermoacoustic equations by boundary data. Part I: Carleman estimates

**Abstract.** In this paper, we consider Carleman estimates and inverse problems for the coupled quantitative thermoacoustic equations. In Part I, we establish Carleman estimates for the coupled quantitative thermoacoustic equations by assuming that the coefficients satisfy suitable conditions and taking the usual weight function  $\varphi(x, t) = e^{\lambda\psi(x, t)}$ ,  $\psi(x, t) = |x - x_0|^2 - \beta(t - t_0)^2 + \beta t_0^2$  for  $x$  in a bounded domain in  $\mathbb{R}^n$  with  $C^3$ -boundary and  $t \in (0, T)$ , where  $t_0 = T/2$ . We will discuss applications of the Carleman estimates to some inverse problems for the coupled quantitative thermoacoustic equations in the succeeding Part II paper [6].

**Keywords.** Carleman estimates, thermoacoustic equations, coupled, inverse problems.

## 1 Introduction and main results

We investigate the so called quantitative thermoacoustic tomography process (e.g. [1, 5, 23, 25] and their references). According to [5], assuming that the variations in temperature and pressure are weak and neglecting the nonlinear effects, we

obtain the system

$$\begin{cases} \partial_t^2 p - \rho v_s^2 \operatorname{div} \left( \frac{1}{\rho} \nabla p \right) - \Gamma \partial_t \{ \operatorname{div} (\kappa \nabla \theta) \} = \Gamma \partial_t \Pi_a, \\ \partial_t \theta - \frac{1}{\rho C_p} \operatorname{div} (\kappa \nabla \theta) - \frac{\theta_0 \varsigma}{\rho C_p} \partial_t p = \frac{\Pi_a}{\rho C_p}, \end{cases} \quad \text{in } Q, \quad (1.1)$$

for the temperature rise  $\theta$  and the pressure perturbation  $p$  from the equilibrium steady state depending on  $(x, t) = (x_1, \dots, x_n, t) \in Q \triangleq \Omega \times (0, T)$ . Here  $n \in \mathbb{N}^*$  and  $\Omega$  is a bounded domain in  $\mathbb{R}^n$  with the boundary  $\partial\Omega \in C^3$ . Throughout this paper, we set  $\partial_j = \frac{\partial}{\partial x_j}$ ,  $\partial_t = \frac{\partial}{\partial t}$ ,  $\partial_j^2 = \frac{\partial^2}{\partial x_j^2}$ ,  $\partial_j \partial_k = \frac{\partial^2}{\partial x_j \partial x_k}$ ,  $\Delta = \sum_{j=1}^n \frac{\partial^2}{\partial x_j^2}$ ,  $\partial_t^2 = \frac{\partial^2}{\partial t^2}$ ,  $1 \leq j, k \leq n$ . We assume that the mass density at steady state  $\rho$ , the thermal conductivity  $\kappa$ , the acoustic wave velocity  $v_s$  and the isobar specific heat capacity  $C_p$  are given strictly positive functions of  $x$  and independent of  $t$ , the Grüneisen parameter  $\Gamma$ , the background temperature  $\theta_0$  and the volume thermal expansivity  $\varsigma$  are given non-negative functions of  $x$  and independent of  $t$ , and the absorbed energy  $\Pi_a$  is an unknown function of  $x$  and  $t$ .

We set

$$\Theta(x, t) = \partial_t \theta(x, t). \quad (1.2)$$

Differentiating the second equation in (1.1) with respect to  $t$ , we obtain

$$\begin{cases} \partial_t^2 p - \rho_1(x) \operatorname{div} (q(x) \nabla p) - \rho_2(x) \operatorname{div} (\kappa(x) \nabla \Theta) = \Gamma(x) \partial_t \Pi_a, \\ \partial_t \Theta - \rho_3(x) \operatorname{div} (\kappa(x) \nabla \Theta) - \rho_4(x) \partial_t^2 p = \rho_3(x) \partial_t \Pi_a, \end{cases} \quad \text{in } Q, \quad (1.3)$$

where  $\rho_1(x) = \rho(x) v_s^2(x)$ ,  $q(x) = \frac{1}{\rho(x)}$ ,  $\rho_2(x) = \Gamma(x)$ ,  $\rho_3(x) = \frac{1}{\rho(x) C_p(x)}$ , and  $\rho_4(x) = \frac{\theta_0(x) \varsigma(x)}{\rho(x) C_p(x)}$ . Let  $a_1(x) = \rho_1(x) q(x)$ ,  $a_2(x) = \rho_2(x) \kappa(x)$ ,  $a_3(x) = \rho_3(x) \kappa(x)$ , and  $a_4(x) = \rho_4(x)$ .

Therefore, in this paper, we consider Carleman estimates for the following strongly coupled hyperbolic-parabolic system

$$\begin{cases} \partial_t^2 p(x, t) - a_1(x) \Delta p(x, t) - a_2(x) \Delta \Theta(x, t) = f(x, t), \\ \partial_t \Theta(x, t) - a_3(x) \Delta \Theta(x, t) - a_4(x) \partial_t^2 p(x, t) = g(x, t), \end{cases} \quad \text{in } Q, \quad (1.4)$$

where  $f(x, t)$ ,  $g(x, t) \in L^2(Q)$ ,  $a_j(x) \in C^2(\bar{\Omega})$  ( $j = 1, 2, 3, 4$ ) are real-valued functions.

In order to state our main results, we introduce more notations. Let  $(x \cdot x')$  denote the scalar product in  $\mathbb{R}^n$ . Let  $\nu = \nu(x) = (\nu_1(x), \dots, \nu_n(x))$  denote the outward unit normal vector to  $\partial\Omega$  at  $x$ . We assume that  $\omega \subset \Omega$  is a subdomain of  $\Omega$  satisfy

$$\overline{\partial\Omega \setminus \partial\omega} \subset \{x \in \partial\Omega \mid ((x - x_0) \cdot \nu(x)) < 0\} \quad (1.5)$$

with some  $x_0 = (x_0^1, x_0^2, \dots, x_0^n) \in \mathbb{R}^n \setminus \overline{\Omega}$ . Let  $T > 0$  be given. We shall establish a Carleman estimate with the measurement in a subboundary layer

$$\Theta(x, t), \quad (x, t) \in Q_\omega \triangleq \omega \times (0, T).$$

We introduce two sets which are concerned with the coefficients  $a_j(x)$ ,  $j = 1, 2, 3, 4$ :

$$\begin{aligned} \mathcal{U} = \mathcal{U}_{\sigma_0, \sigma_1, M_0, M_1, M_2} &= \left\{ (a_1(x), a_2(x), a_3(x), a_4(x)) \in (C^2(\overline{\Omega}))^4 \mid \right. \\ &a_1(x) \geq \sigma_1, \quad a_3(x) \geq \sigma_1, \quad a_2(x) \geq 0, \quad a_4(x) \geq 0, \quad \forall x \in \overline{\Omega}, \\ &\|a_j\|_{C(\overline{\Omega})} \leq M_0, \quad \|a_j\|_{C^1(\overline{\Omega})} \leq M_1, \quad \|a_j\|_{C^2(\overline{\Omega})} \leq M_2, \quad j = 1, 2, 3, 4, \\ &\left. 3a_1 - 2((x - x_0) \cdot \nabla a_1) + \frac{a_1}{(1 + \frac{a_2 a_4}{a_3})} \left( 2(x - x_0) \cdot \nabla \left( \frac{a_2 a_4}{a_3} \right) \right) \geq \sigma_0 \right\} \quad (1.6) \end{aligned}$$

where the constants  $M_0 > 1$ ,  $M_1 > 0$ ,  $M_2 > 0$ ,  $\sigma_0 > 0$ ,  $M_0 > \sigma_1 > 0$  are given. Denote

$$m = \inf_{x \in \overline{\Omega}} |x - x_0|^2, \quad M = \sup_{x \in \overline{\Omega}} |x - x_0|^2, \quad \text{and} \quad \mathcal{D} = \sqrt{M - m}. \quad (1.7)$$

We assume that  $(a_1(x), a_2(x), a_3(x), a_4(x)) \in \mathcal{U} = \mathcal{U}_{\sigma_0, \sigma_1, M_0, M_1, M_2}$ . Denote

$$\begin{aligned} \alpha_1 &= 228nM_0^3M_1M^{\frac{1}{2}} + 20M_0^4 - 8\sigma_1^2, \quad \alpha_2 = \left( 132nM_1M^{\frac{1}{2}} + 16M_0 \right) M_0^3, \\ \alpha_3 &= \min \left\{ \frac{\sigma_0\sigma_1}{\left( \frac{2M_0^4\alpha_1}{\sigma_1^2} + \alpha_2 \right)}, \frac{\sigma_1}{8M}, \frac{\sigma_1^4}{16M_0^8} \right\}, \\ \alpha_4 &= 6M_0^2\alpha_3 + \frac{2M_0^2}{\sigma_1}, \quad \alpha_5 = 2M_0^2\alpha_3 + 2 \left( 1 + \frac{M_0^2}{\sigma_1} + \frac{3M_0^3}{\sigma_1^2} \right) M_1 + \frac{2M_0^2}{\sigma_1}, \\ \alpha_6 &= \frac{4M_0^3\alpha_3}{\sigma_1} + 2 \left( 1 + \frac{M_0^2}{\sigma_1} + \frac{3M_0^3}{\sigma_1^2} \right) nM_1, \\ \alpha_7 &= \frac{16M_0^8}{\sigma_1^7} \left( 1 + \frac{M_0^2}{\sigma_1} \right)^2, \quad \alpha_8 = 2 \left( 1 + \frac{M_0^2}{\sigma_1} \right)^2, \\ \alpha_9 &= \frac{-\mathcal{D}\alpha_6 + \sqrt{\mathcal{D}^2\alpha_6^2 + \sigma_1(\mathcal{D}^2\alpha_7 + \alpha_8)}}{4(\mathcal{D}^2\alpha_7 + \alpha_8)}. \end{aligned} \quad (1.8)$$

We choose  $\beta > 0$  such that

$$0 < \beta < \min \left\{ \alpha_9^2, \frac{\alpha_1^2\alpha_3^2}{16\alpha_4^2\mathcal{D}^2}, \frac{\sigma_0^2\sigma_1^2}{16\alpha_5^2\mathcal{D}^2}, \frac{m^2\sigma_1^3}{2M_0(\sigma_1 + M_0^2)\mathcal{D}^2} \right\}. \quad (1.9)$$

Denote  $t_0 = \frac{T}{2}$ . We will prove a Carleman estimate for (1.4) with the exponential weight function  $e^{2s\varphi}$  where

$$\varphi(x, t) = e^{\lambda\psi(x, t)}, \quad \psi(x, t) = |x - x_0|^2 - \beta(t - t_0)^2 + \beta t_0^2, \quad \forall (x, t) \in Q, \quad (1.10)$$

and  $\lambda > 0$  is a suitably large constant.

We set  $\nabla = (\partial_1, \dots, \partial_n)$ ,  $\nabla_{x,t} = (\partial_1, \dots, \partial_n, \partial_t)$ ,  $|\nabla w|^2 = \sum_{k=1}^n |\partial_k w|^2$ ,  $|\nabla_{x,t} w|^2 = |\nabla w|^2 + |\partial_t w|^2$ , and so on.  $L^2(Q)$ ,  $H^2(\Omega)$ , etc. denote usual Sobolev spaces. We further set

$$\begin{aligned} \mathcal{H}^{2,1}(Q) &= \{u \in L^2(Q); \partial_j u, \partial_j^2 u, \partial_j \partial_k u, \partial_t u \in L^2(Q), j, k = 1, \dots, n\}, \\ \mathcal{H}^{2,2}(Q) &= \{u \in L^2(Q); \partial_j u, \partial_j^2 u, \partial_j \partial_k u, \partial_t u, \partial_t^2 u \in L^2(Q), j, k = 1, \dots, n\}, \end{aligned}$$

and  $\mathcal{W} = \mathcal{H}^{2,1}(Q) \times \mathcal{H}^{2,2}(Q)$ .

**Theorem 1.1.** *Let  $(\Theta, p) \in \mathcal{W}$  satisfy (1.4) and*

$$\Theta(x, t) = 0, \quad p(x, t) = 0, \quad (x, t) \in \Sigma \triangleq \partial\Omega \times (0, T) \quad (1.11)$$

$$\Theta(x, 0) = \Theta(x, T) = 0, \quad \partial_t^j p(x, 0) = \partial_t^j p(x, T) = 0, \quad x \in \overline{\Omega}, \quad j = 0, 1. \quad (1.12)$$

We assume that  $(a_1, a_2, a_3, a_4) \in \mathcal{U}$ , and that (1.9) holds. Then there exists a constant  $\eta(\beta) > 0$  such that for any  $T \in \left(0, \frac{2(D+\eta)}{\sqrt{\beta}}\right)$ , there exists a constant  $\lambda_0 > 0$  such that for all  $\lambda > \lambda_0$ , there exist constants  $s_0(\lambda) > 0$  and  $K_1 = K_1(s_0, \lambda_0, \beta, \Omega, T, m, M, M_0, M_1, M_2, \sigma_0, \sigma_1) > 0$  such that

$$\begin{aligned} &\int_Q \left( s^3 \lambda^4 \varphi^3 \Theta^2 + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi |\nabla \Theta|^2 + s^3 \lambda^4 \varphi^3 p^2 + s\lambda\varphi |\nabla_{x,t} p|^2 \right) e^{2s\varphi} dx dt \\ &\leq K_1 \int_Q (f^2 + g^2) e^{2s\varphi} dx dt \\ &\quad + K_1 \int_{Q_\omega} \left\{ s^3 \lambda^4 \varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s^3 \lambda^3 \varphi^3 |\partial_t p|^2 \right\} e^{2s\varphi} dx dt, \end{aligned} \quad (1.13)$$

for all  $s \geq s_0$ .

Let  $\Gamma_0 \subset \partial\Omega$  satisfy

$$\overline{\partial\Omega \setminus \Gamma_0} \subset \{x \in \partial\Omega \mid ((x - x_0) \cdot \nu(x)) < 0\} \quad (1.14)$$

Let  $\frac{\partial u}{\partial \nu}$  denote the normal derivative:  $\frac{\partial u}{\partial \nu}(x) = \sum_{j=1}^n \nu_j(x) \partial_j u(x)$ ,  $x \in \partial\Omega$ . The following Carleman estimate plays an important role in the proof of Theorem 1.1:

**Theorem 1.2.** *Let  $(\Theta, p) \in \mathcal{W}$  satisfy (1.4), (1.11) and (1.12). We assume that  $(a_1, a_2, a_3, a_4) \in \mathcal{U}$ , and that (1.9) holds. Then there exists a constant  $\eta(\beta) > 0$  such that for any  $T \in (0, \frac{2(D+\eta)}{\sqrt{\beta}})$ , there exists a constant  $\lambda_0 > 0$  such that for all  $\lambda > \lambda_0$ , there exist constants  $s_0(\lambda) > 0$  and  $K_2 = K_2(s_0, \lambda_0, \beta, \Omega, T, m, M, M_0, M_1, M_2, \sigma_0, \sigma_1, \epsilon) > 0$  such that*

$$\begin{aligned} & \int_Q \left( s^3 \lambda^4 \varphi^3 \Theta^2 + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi |\nabla \Theta|^2 + s^3 \lambda^4 \varphi^3 p^2 + s\lambda\varphi |\nabla_{x,t} p|^2 \right) e^{2s\varphi} dx dt \\ & \leq K_2 \int_Q (f^2 + g^2) e^{2s\varphi} dx dt + K_2 s \lambda \int_{\Gamma_0 \times (0,T)} \varphi \left( \left| \frac{\partial \Theta}{\partial \nu} \right|^2 + \left| \frac{\partial p}{\partial \nu} \right|^2 \right) d\sigma dt, \end{aligned} \quad (1.15)$$

for all  $s \geq s_0$ .

The Carleman estimate was first introduced by Carleman [3] in 1939 for the purpose of proving uniqueness in the general Cauchy problem of first-order systems in two dimensions with simple characteristics. After that the Carleman estimate and applications were greatly developed. We refer to Bellassoued and Yamamoto [2], Chae, Imanuvilov and Kim [4], Egorov [7], Eller and Isakov [8], Fursikov and Imanuvilov [9], Hörmander [10, 11], Imanuvilov [12], Imanuvilov and Yamamoto [13], Isakov [14]–[18], Klibanov [19], Klibanov and Timonov [20], Lavrent'ev, Romanov and Shishatskii [21], Li [22], Romanov [24], Tataru [26], Trèves [27], Yamamoto [28], Yuan and Yamamoto [29], and related references in them. In these references, Carleman estimates are proved by general methods or direct methods.

In this paper, we concentrate on the proof of Carleman estimates for (1.4), that is, Theorem 1.1 and 1.2, by a direct method. We will discuss applications of Theorem 1.1 to several inverse problems in the domain of thermoacoustic tomography (TAT) in the succeeding Part II paper [6]. To our best knowledge, inverse problems in the domain of TAT are very few addressed until now because the models of the literature do not consider the heating process.

The paper consists of three sections. In Section 2, we will give a direct derivation of Theorem 1.2 by applying the argument in e.g. [20, 21, 24, 28]. In Section 3, we will derive Theorem 1.1 by applying Theorem 1.2 and the argument in [12].

## 2 Proof of Theorem 1.2

By a usual density argument, we can assume that  $(\Theta, p) \in C^\infty(Q) \times C^\infty(Q)$ . Let  $\lambda > 1$  and  $s > 1$ . Eliminating  $\partial_t^2 p$  from the two equations in (1.4), we have

$$\partial_t \Theta - a_5 \Delta \Theta - a_6 \Delta p = a_4 f + g, \quad (2.1)$$

where

$$a_5 = a_3 + a_2 a_4 \quad \text{and} \quad a_6 = a_1 a_4. \quad (2.2)$$

Denote

$$L_0(\Theta, p) = \partial_t \Theta - a_5 \Delta \Theta - a_6 \Delta p. \quad (2.3)$$

We set  $(\vartheta, w) = e^{s\varphi}(\Theta, p)$ ,  $\mathcal{L}(\vartheta, w) = e^{s\varphi} L_0(e^{-s\varphi}(\vartheta, w))$ . By (1.10), we have

$$\begin{aligned} \partial_t \psi &= -2\beta(t - t_0), \quad \partial_t^2 \psi = -2\beta, \quad \partial_j \psi = 2(x_j - x_0^j), \quad \partial_j \partial_k \psi = 2\delta_{jk}, \\ \partial_t \varphi &= \lambda \varphi (\partial_t \psi), \quad \partial_t^2 \varphi = \lambda \varphi (\partial_t^2 \psi) + \lambda^2 \varphi (\partial_t \psi)^2, \quad \partial_j \varphi = \lambda \varphi (\partial_j \psi), \\ \partial_j \partial_k \varphi &= \lambda \varphi (\partial_j \partial_k \psi) + \lambda^2 \varphi (\partial_j \psi)(\partial_k \psi), \quad \text{for all } j, k = 1, \dots, n. \end{aligned} \quad (2.4)$$

By direct calculations, we have

$$\begin{aligned} e^{s\varphi} (a_4 f + g) &= \mathcal{L}(\vartheta, w) = e^{s\varphi} \{ \partial_t (e^{-s\varphi} \vartheta) - a_5 \Delta (e^{-s\varphi} \vartheta) - a_6 \Delta (e^{-s\varphi} w) \} \\ &= -a_5 \Delta \vartheta - a_6 \Delta w - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_5 \vartheta - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_6 w + \partial_t \vartheta \\ &\quad + 2s \lambda \varphi (\nabla \psi \cdot (a_5 \nabla \vartheta + a_6 \nabla w)) + A(\vartheta, w), \quad \text{in } Q, \end{aligned}$$

where

$$A(\vartheta, w) = s \lambda^2 \varphi |\nabla \psi|^2 (a_5 \vartheta + a_6 w) + 2ns \lambda \varphi (a_5 \vartheta + a_6 w) - s \lambda \varphi (\partial_t \psi) \vartheta. \quad (2.5)$$

Then taking into consideration the orders of  $(s, \lambda, \varphi)$ , we divide  $\mathcal{L}(\vartheta, w)$  as follows:

$$\mathcal{L}(\vartheta, w) = L_1(\vartheta, w) + L_2(\vartheta, w), \quad (2.6)$$

where

$$\begin{aligned} L_1(\vartheta, w) &= -a_5 \Delta \vartheta - a_6 \Delta w - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_5 \vartheta - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_6 w, \\ L_2(\vartheta, w) &= \partial_t \vartheta + 2s \lambda \varphi (\nabla \psi \cdot (a_5 \nabla \vartheta + a_6 \nabla w)) + A(\vartheta, w). \end{aligned} \quad (2.7)$$

Therefore we have

$$\begin{aligned} \|(a_4 f + g) e^{s\varphi}\|_{L^2(Q)}^2 &= \|\mathcal{L}(\vartheta, w)\|_{L^2(Q)}^2 = \|L_1(\vartheta, w) + L_2(\vartheta, w)\|_{L^2(Q)}^2 \\ &= \|L_1(\vartheta, w)\|_{L^2(Q)}^2 + 2 \int_Q L_1(\vartheta, w) L_2(\vartheta, w) dx dt + \|L_2(\vartheta, w)\|_{L^2(Q)}^2. \end{aligned} \quad (2.8)$$

Direct calculations yeild

$$\begin{aligned} L_1(\vartheta, w) L_2(\vartheta, w) &= -a_5 (\Delta \vartheta) (\partial_t \vartheta) - 2a_5 s \lambda \varphi (\Delta \vartheta) (\nabla \psi \cdot (a_5 \nabla \vartheta + a_6 \nabla w)) \\ &\quad - a_5 (\Delta \vartheta) A(\vartheta, w) - a_6 (\Delta w) (\partial_t \vartheta) - 2s \lambda \varphi a_6 (\Delta w) (\nabla \psi \cdot (a_5 \nabla \vartheta + a_6 \nabla w)) \\ &\quad - a_6 (\Delta w) A(\vartheta, w) - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_5 \vartheta (\partial_t \vartheta) \\ &\quad - 2s^3 \lambda^3 \varphi^3 |\nabla \psi|^2 a_5 (\nabla \psi \cdot (a_5 \nabla \vartheta + a_6 \nabla w)) \vartheta - s^2 \lambda^2 \varphi^2 |\nabla \psi|^2 a_5 \vartheta A(\vartheta, w) \end{aligned}$$

$$\begin{aligned}
& -s^2\lambda^2\varphi^2|\nabla\psi|^2a_6w(\partial_t\vartheta) - 2s^3\lambda^3\varphi^3|\nabla\psi|^2a_6(\nabla\psi \cdot (a_5\nabla\vartheta + a_6\nabla w))w \\
& - s^2\lambda^2\varphi^2|\nabla\psi|^2a_6wA(\vartheta, w) \triangleq \sum_{k=1}^{12} J_k.
\end{aligned} \tag{2.9}$$

We integrate  $J_k$ ,  $k = 1, 2, \dots, 12$  over  $Q$ . We calculate them by applying the integration by parts and apply the conditions (1.11), (1.12), and  $(a_1, a_2, a_3, a_4) \in \mathcal{U}$ .

$$\begin{aligned}

where  $\gamma_0 = \gamma_0(x)$  and  $\gamma_j = \gamma_j(x) \in C^2(\overline{\Omega})$ , ( $j = 1, \dots, n$ ) are functions of  $x$ , but are independent of  $t$ ,  $s$ ,  $\lambda$ ,  $\varphi$ , and will be suitably chosen later. We divide  $\mathcal{L}_*(\vartheta, w)$  as follows:

& \quad + 2s\lambda^2 \int_Q \varphi (\partial_t \psi) a_1 a_8 (\nabla \psi \cdot \nabla w) \vartheta dx dt \\
& \geq -2s\lambda \int_Q \varphi a_1 a_8 (\nabla \psi \cdot \nabla \vartheta) (\partial_t w) dx dt \\
& \quad - C_{40} s^2 \lambda^4 \int_Q \varphi^2 \vartheta^2 dx dt - C_{40} \int_Q (|\nabla w|^2 + |\partial_t w|^2) dx dt. \tag{2.71}

& + C_{51} \int_Q (|\nabla \vartheta|^2 + s^2 \lambda^4 \varphi^2 \vartheta^2 + s^2 \lambda^6 \varphi^2 w^2) dxdt. \tag{2.92}
\end{aligned}$$

We multiply (2.54) by  $\alpha_3$  and then add it to (2.92). By the definition of  $\alpha_3$  in (1.8), the second, third and fourth terms in the right hand side of (2.54) can be absorbed by the left hand side of (2.92), so that we arrive at

& - 2 s \lambda \int_\Sigma \varphi (\nabla \psi \cdot \nu) a_1^2 \left| \frac{\partial w}{\partial \nu} \right|^2 d\sigma dt + 2 \int_\Sigma a_1 (\nabla a_1 \cdot \nu) \left| \frac{\partial w}{\partial \nu} \right|^2 d\sigma dt \\
& \leq C_{52} \int_Q (f^2 + g^2) e^{2s\varphi} dx dt + C_{52} s \lambda \int_Q \varphi |a_5 (\nabla \psi \cdot \nabla \vartheta) + a_6 (\nabla \psi \cdot \nabla w)|^2 dx dt \\

for all  $s > s_1$ . We note that  $4m \leq |\nabla \psi|^2 \leq 4M$  on  $\bar{\Omega}$ . By (1.8) and (1.9), we have

$$2(\mathcal{D} + \eta) \alpha_6 \sqrt{\beta} + 4(\mathcal{D} + \eta)^2 \alpha_7 \beta + 4\alpha_8 \beta < \frac{1}{4}\sigma_1,$$

$$0 < \beta (\mathcal{D} + \eta)^2 < \frac{m^2 \sigma_1^3}{2M_0 (\sigma_1 + M_0^2)}.$$

For any  $T \in \left(0, \frac{2(\mathcal{D} + \eta)}{\sqrt{\beta}}\right)$ , we have  $0 < \beta T < 2\sqrt{\beta}(\mathcal{D} + \eta)$ . Therefore, the fourth, fifth, sixth and seventh terms in the right hand side of (2.93) can be absorbed by the left hand side of it. Hence we arrive at

$$\begin{aligned}
& + C_{53} s \lambda^{\frac{1}{2}} \int_Q \varphi (|\nabla \vartheta|^2 + |\nabla w|^2 + |\partial_t w|^2) dxdt + C_{53} s^3 \lambda^{\frac{7}{2}} \int_Q \varphi^3 (\vartheta^2 + w^2) dxdt \\
& + C_{53} \int_Q \frac{1}{s \lambda \varphi} |\partial_t \vartheta|^2 dxdt + C_{53} s^2 \lambda^6 \int_Q \varphi^2 (\vartheta^2 + w^2) dxdt,

for all  $s > s_1$ . By (1.14), there exists a constant  $\epsilon > 0$  such that  $-(\nabla \psi \cdot \nu) \geq \epsilon$  on  $\overline{\partial\Omega \setminus \Gamma_0}$ . Therefore, there exists a constant  $\lambda_0 > 1$  such that for any  $\lambda \geq \lambda_0$ , the fourteenth term in the left hand side can be absorbed by the thirteenth term in the left hand side, and the terms from the fifth to the ninth in the right hand side can be absorbed by the left hand side. Moreover, for any fixed  $\lambda \geq \lambda_0$ , there exists a constant  $s_0 = s_0(\lambda) > s_1$  such that for any  $s \geq s_0(\lambda)$ , the tenth term in the right hand side can be absorbed by the left hand side. We further note that the twelfth term in the left hand side is positive. Thus there exists a constant  $K_0 = K_0(s_0, \lambda_0, \beta, \Omega, T, m, M, M_0, M_1, M_2, \sigma_0, \sigma_1, \epsilon) > 0$  such that

& + s \lambda^2 \int_Q \varphi |a_5 (\nabla \psi \cdot \nabla \vartheta) + a_6 (\nabla \psi \cdot \nabla w)|^2 dxdt \\
& + s \lambda^2 \int_Q \varphi |a_7 (\partial_t \psi) (\partial_t w) - a_1 (\nabla \psi \cdot \nabla w)|^2 dxdt + \|\mathcal{L}_*(\vartheta, w)\|_{L^2(Q)}^2 \\
& + \|\mathcal{L}_{2*}(w)\|_{L^2(Q)}^2 + \|L_1(\vartheta, w)\|_{L^2(Q)}^2 + \epsilon s \lambda \int_{(\partial\Omega \setminus \Gamma_0) \times (0, T)} \varphi \left| \frac{\partial w}{\partial \nu} \right|^2 d\sigma dt \\
& \leq K_0 \int_Q (f^2 + g^2) e^{2s\varphi} dxdt + K_0 s \lambda \int_{\Gamma_0 \times (0, T)} \varphi \left( \left| \frac{\partial \vartheta}{\partial \nu} \right|^2 + \left| \frac{\partial w}{\partial \nu} \right|^2 \right) d\sigma dt,
\end{aligned}$$

for all  $\lambda \geq \lambda_0$  and  $s \geq s_0(\lambda)$ . Noting  $(\vartheta, w) = e^{s\varphi} (\Theta, p)$ , we complete the proof of Theorem 1.2.

### 3 Proof of Theorem 1.1

We prove Theorem 1.1 by applying Theorem 1.2 and the argument in [12]. By a usual density argument, it is sufficient to prove (1.15) for  $(\Theta, p) \in C^\infty(Q) \times C^\infty(Q)$ . Let  $G_\varepsilon = \{x \in \omega \mid \text{dist}(x, \partial\omega \cap \Omega) \leq \varepsilon\}$  and  $\omega_\varepsilon = \omega \setminus G_\varepsilon$ . Let  $Q_{\omega_\varepsilon} = \omega_\varepsilon \times (0, T)$ . By (1.5), there exists  $\varepsilon > 0$  such that

$$\overline{\partial\Omega \setminus \partial\omega_{4\varepsilon}} \subset \{x \in \partial\Omega \mid ((x - x_0) \cdot \nu(x)) < 0\}. \quad (3.1)$$

We take  $\Gamma_0 = \partial\omega_{4\varepsilon} \cap \partial\Omega$ . By (3.1),  $\Gamma_0$  satisfies (1.14). In order to apply Theorem 1.2, we take a cut-off function  $\chi_1(x) \in C^\infty(\overline{\Omega})$  such that  $0 \leq \chi_1(x) \leq 1$  for

all  $x \in \overline{\Omega}$ ,  $\chi_1(x) = 1$  for all  $x \in \Omega \setminus \omega_{2\varepsilon}$ , and  $\chi_1(x) = 0$  for all  $x \in \omega_{3\varepsilon}$ . Let  $u(x, t) = \chi_1(x)p(x, t)$  and  $v(x, t) = \chi_1(x)\Theta(x, t)$ . By (1.4), (1.11) and (1.12), we have

$$\begin{cases} \partial_t^2 u - a_1 \Delta u - a_2 \Delta v = \chi_1 f - a_1 (\Delta \chi_1) p - 2a_1 (\nabla \chi_1 \cdot \nabla p) \\ \quad - a_2 (\Delta \chi_1) \Theta - 2a_2 (\nabla \chi_1 \cdot \nabla \Theta), \\ \partial_t v - a_3 \Delta v - a_4 \partial_t^2 u = \chi_1 g - a_3 (\Delta \chi_1) \Theta - 2a_3 (\nabla \chi_1 \cdot \nabla \Theta), \quad \text{in } Q, \end{cases}$$

$v(x, t) = u(x, t) = 0$  for  $(x, t) \in \Sigma$ , and  $v(x, 0) = v(x, T) = \partial_t^j u(x, 0) = \partial_t^j u(x, T) = 0$  for  $x \in \overline{\Omega}$  and  $j = 0, 1$ . Furthermore, by the definition of  $\chi_1$ , we have  $\nabla v = \nabla u = 0$  in some neighborhood of  $\Gamma_0 \times (0, T)$ . By Theorem 1.2, there exists a constant  $\eta(\beta) > 0$  such that for any  $T \in (0, \frac{2(\mathcal{D}+\eta)}{\sqrt{\beta}})$ , there exists a constant  $\lambda_0 > 0$  such that for all  $\lambda > \lambda_0$ , there exist constants  $s_0(\lambda) > 0$  and  $K = K(s_0, \lambda_0, \beta, \Omega, T, m, M, M_0, M_1, M_2, \sigma_0, \sigma_1) > 0$  such that

$$\begin{aligned} & \int_Q \left( s^3 \lambda^4 \varphi^3 v^2 + \frac{1}{s\varphi} |\partial_t v|^2 + s\lambda\varphi |\nabla v|^2 + s^3 \lambda^4 \varphi^3 u^2 + s\lambda\varphi |\nabla_{x,t} u|^2 \right) e^{2s\varphi} dx dt \\ & \leq K \int_Q (f^2 + g^2) e^{2s\varphi} dx dt + K \int_{(\omega_{2\varepsilon} \setminus \omega_{3\varepsilon}) \times (0, T)} \{ |(\Delta \chi_1) p|^2 + |(\nabla \chi_1 \cdot \nabla p)|^2 \\ & \quad + |(\Delta \chi_1) \Theta|^2 + |(\nabla \chi_1 \cdot \nabla \Theta)|^2 \} e^{2s\varphi} dx dt, \quad \text{for all } s \geq s_0. \end{aligned}$$

Therefore we have

$$\begin{aligned} & \int_Q \left\{ s^3 \lambda^4 \varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi (|\nabla \Theta|^2 + |\nabla_{x,t} p|^2) \right\} e^{2s\varphi} dx dt \\ & = \int_{Q \setminus Q_{\omega_{2\varepsilon}}} \left\{ s^3 \lambda^4 \varphi^3 (v^2 + u^2) + \frac{1}{s\varphi} |\partial_t v|^2 + s\lambda\varphi (|\nabla v|^2 + |\nabla_{x,t} u|^2) \right\} e^{2s\varphi} dx dt \\ & \quad + \int_{Q_{\omega_{2\varepsilon}}} \left\{ s^3 \lambda^4 \varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi (|\nabla \Theta|^2 + |\nabla_{x,t} p|^2) \right\} e^{2s\varphi} dx dt \\ & \leq K \int_Q (f^2 + g^2) e^{2s\varphi} dx dt + K \int_{(\omega_{2\varepsilon} \setminus \omega_{3\varepsilon}) \times (0, T)} \{ |(\Delta \chi_1) p|^2 + |(\nabla \chi_1 \cdot \nabla p)|^2 \\ & \quad + |(\Delta \chi_1) \Theta|^2 + |(\nabla \chi_1 \cdot \nabla \Theta)|^2 \} e^{2s\varphi} dx dt \\ & \quad + \int_{Q_{\omega_{2\varepsilon}}} \left\{ s^3 \lambda^4 \varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi (|\nabla \Theta|^2 + |\nabla_{x,t} p|^2) \right\} e^{2s\varphi} dx dt \\ & \leq K \int_Q (f^2 + g^2) e^{2s\varphi} dx dt + C_{54} \int_{Q_{\omega_{2\varepsilon}}} \left\{ s^3 \lambda^4 \varphi^3 (\Theta^2 + p^2) + \frac{1}{s\lambda\varphi} |\partial_t \Theta|^2 \right. \\ & \quad \left. + s\lambda\varphi (|\nabla \Theta|^2 + |\nabla_{x,t} p|^2) \right\} e^{2s\varphi} dx dt, \quad \text{for all } s \geq s_0. \end{aligned} \tag{3.2}$$

Next we estimate  $s\lambda \int_{Q_{\omega_{2\varepsilon}}} \varphi (|\nabla \Theta|^2 + |\nabla p|^2) e^{2s\varphi} dxdt$  in (3.2). We take a cut-off function  $\chi_2(x) \in C^\infty(\overline{\Omega})$  such that  $0 \leq \chi_2(x) \leq 1$  for all  $x \in \overline{\Omega}$ ,  $\chi_2(x) = 0$  for all  $x \in \Omega \setminus \omega_\varepsilon$ , and  $\chi_2(x) = 1$  for all  $x \in \overline{\omega_{2\varepsilon}}$ . We multiply the second equation in (1.4) by  $s\lambda \varphi \chi_2 \Theta e^{2s\varphi}$  and integrate it over  $Q$ . Integrating by parts and using (1.11) and (1.12), we have

&= -\frac{1}{2} s\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 (\partial_t \psi) \Theta^2 e^{2s\varphi} dxdt - s^2 \lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 (\partial_t \psi) \chi_2 \Theta^2 e^{2s\varphi} dxdt \\
&\quad + s\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 a_3 (\nabla \psi \cdot \nabla \Theta) \Theta e^{2s\varphi} dxdt \\
&\quad + s\lambda \int_{Q_{\omega_\varepsilon}} \varphi (\nabla (\chi_2 a_3) \cdot \nabla \Theta) \Theta e^{2s\varphi} dxdt \\
&\quad + s\lambda \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 a_3 |\nabla \Theta|^2 e^{2s\varphi} dxdt + 2s^2 \lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 \chi_2 a_3 (\nabla \psi \cdot \nabla \Theta) \Theta e^{2s\varphi} dxdt \\
&\quad + s\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi (\partial_t \psi) \chi_2 a_4 (\partial_t p) \Theta e^{2s\varphi} dxdt + s\lambda \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 a_4 (\partial_t p) (\partial_t \Theta) e^{2s\varphi} dxdt \\
&\quad + 2s^2 \lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 (\partial_t \psi) \chi_2 a_4 (\partial_t p) \Theta e^{2s\varphi} dxdt \triangleq \sum_{k=1}^{10} \tilde{J}_k, \quad \text{for all } s \geq s_0. \quad (3.3)
\end{aligned}$$

We recall  $s > s_0 \geq 1$  and  $\lambda > 1$ . Thus we have

By the Cauchy-Schwarz inequality, we have

\end{aligned}$$

for all  $s \geq s_0$ . Integrating by parts, we have

&= -\frac{1}{2}s\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi (\nabla(\chi_2 a_3) \cdot \nabla \psi) \Theta^2 e^{2s\varphi} dxdt \\
&\quad - \frac{1}{2}s\lambda \int_{Q_{\omega_\varepsilon}} \varphi \{\Delta(\chi_2 a_3)\} \Theta^2 e^{2s\varphi} dxdt \\
&\quad - s^2\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 (\nabla(\chi_2 a_3) \cdot \nabla \psi) \Theta^2 e^{2s\varphi} dxdt \\
&\geq -C_{58}s^2\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 \Theta^2 e^{2s\varphi} dxdt.
\end{aligned}$$

$$\tilde{J}_5 \geq s\lambda\sigma_1 \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 |\nabla \Theta|^2 e^{2s\varphi} dxdt, \text{ for all } s \geq s_0.$$

By the Cauchy-Schwarz inequality, we have

$$\begin{aligned}
\tilde{J}_6 &\geq -C_{59} \int_{Q_{\omega_\varepsilon}} \chi_2 \left( \frac{1}{2}s^{\frac{1}{2}}\lambda^{\frac{1}{2}}\sigma_1^{\frac{1}{2}}\varphi^{\frac{1}{2}}|\nabla \Theta| \right) \left( 2s^{\frac{3}{2}}\lambda^{\frac{3}{2}}\sigma_1^{-\frac{1}{2}}\varphi^{\frac{3}{2}}|\Theta| \right) e^{2s\varphi} dxdt \\
&\geq -\frac{1}{4}s\lambda\sigma_1 \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 |\nabla \Theta|^2 e^{2s\varphi} dxdt - C_{60}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 \chi_2 \Theta^2 e^{2s\varphi} dxdt,
\end{aligned}$$

$$\tilde{J}_7 + \tilde{J}_9 \geq -C_{61}s^2\lambda^2 \int_{Q_{\omega_\varepsilon}} \varphi^2 \chi_2 (|\partial_t p|^2 + \Theta^2) e^{2s\varphi} dxdt,$$

$$\begin{aligned}
\tilde{J}_8 &\geq -C_{62} \int_{Q_{\omega_\varepsilon}} \chi_2 \left( s^{\frac{3}{2}}\lambda^{\frac{3}{2}}\varphi^{\frac{3}{2}}|\partial_t p| \right) \left( \frac{1}{s^{\frac{1}{2}}\lambda^{\frac{1}{2}}\varphi^{\frac{1}{2}}} |\partial_t \Theta| \right) e^{2s\varphi} dxdt \\
&\geq -C_{63}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 \chi_2 |\partial_t p|^2 e^{2s\varphi} dxdt - \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} |\partial_t \Theta|^2 e^{2s\varphi} dxdt,
\end{aligned}$$

$$\begin{aligned}
s\lambda \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 g \Theta e^{2s\varphi} dxdt &\leq C_{64} \int_{Q_{\omega_\varepsilon}} \chi_2 \left( \frac{1}{s^{\frac{1}{2}}\lambda^{\frac{1}{2}}\varphi^{\frac{1}{2}}} |g| \right) \left( s^{\frac{3}{2}}\lambda^{\frac{3}{2}}\varphi^{\frac{3}{2}}|\Theta| \right) e^{2s\varphi} dxdt \\
&\leq \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} g^2 e^{2s\varphi} dxdt + C_{65}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 \chi_2 \Theta^2 e^{2s\varphi} dxdt,
\end{aligned}$$

for all  $s \geq s_0$ . Therefore, we obtain

$$\begin{aligned}
&\frac{1}{2}s\lambda\sigma_1 \int_{Q_{\omega_\varepsilon}} \varphi \chi_2 |\nabla \Theta|^2 e^{2s\varphi} dxdt \\
&\leq \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} |\partial_t \Theta|^2 e^{2s\varphi} dxdt + \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} g^2 e^{2s\varphi} dxdt \\
&\quad + C_{66}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 (|\partial_t p|^2 + \Theta^2) e^{2s\varphi} dxdt, \text{ for all } s \geq s_0. \tag{3.4}
\end{aligned}$$

By (1.4), we can get (2.55) where  $a_7$  and  $a_8$  are given by (2.56). Similarly to (3.3)–(3.4), we multiply (2.55) by  $s\lambda\varphi\chi_2 p e^{2s\varphi}$  and integrate it over  $Q$ , so that, by the integration by parts and the Cauchy-Schwarz inequality, we have

$$\begin{aligned} s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 (f - a_8 g) p e^{2s\varphi} dx dt &= s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 a_7 (\partial_t^2 p) p e^{2s\varphi} dx dt \\ &\quad - s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 a_1 (\Delta p) p e^{2s\varphi} dx dt - s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 a_8 (\partial_t \Theta) p e^{2s\varphi} dx dt \\ &\geq -C_{67}s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 |\partial_t p|^2 e^{2s\varphi} dx dt - C_{67}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 p^2 e^{2s\varphi} dx dt \\ &\quad + \frac{1}{2}s\lambda\sigma_1 \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 |\nabla p|^2 e^{2s\varphi} dx dt - C_{67}s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 \Theta^2 e^{2s\varphi} dx dt, \end{aligned}$$

for all  $s \geq s_0$ . Then we have

$$\begin{aligned} \frac{1}{2}s\lambda\sigma_1 \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 |\nabla p|^2 e^{2s\varphi} dx dt \\ \leq \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} (f^2 + g^2) e^{2s\varphi} dx dt + C_{68}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 p^2 e^{2s\varphi} dx dt \\ + C_{68}s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 |\partial_t p|^2 e^{2s\varphi} dx dt + C_{68}s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 \Theta^2 e^{2s\varphi} dx dt, \end{aligned} \quad (3.5)$$

for all  $s \geq s_0$ . Adding (3.4) and (3.5) and noting  $\omega_{2\varepsilon} \subseteq \omega_\varepsilon \subseteq \omega$  and  $\chi_2(x) = 1$  for all  $x \in \overline{\omega_{2\varepsilon}}$ , we obtain

$$\begin{aligned} s\lambda \int_{Q_{\omega_{2\varepsilon}}} \varphi (|\nabla \Theta|^2 + |\nabla p|^2) e^{2s\varphi} dx dt &\leq s\lambda \int_{Q_{\omega_\varepsilon}} \varphi\chi_2 (|\nabla \Theta|^2 + |\nabla p|^2) e^{2s\varphi} dx dt \\ &\leq \frac{2}{\sigma_1} \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} |\partial_t \Theta|^2 e^{2s\varphi} dx dt + \frac{4}{\sigma_1} \int_{Q_{\omega_\varepsilon}} \frac{\chi_2}{s\lambda\varphi} (f^2 + g^2) e^{2s\varphi} dx dt \\ &\quad + C_{69}s^3\lambda^3 \int_{Q_{\omega_\varepsilon}} \varphi^3 (|\partial_t p|^2 + p^2 + \Theta^2) e^{2s\varphi} dx dt, \text{ for all } s \geq s_0. \end{aligned} \quad (3.6)$$

Substituting (3.6) into (3.2), we obtain

$$\begin{aligned} \int_Q \left\{ s^3\lambda^4\varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s\lambda\varphi (|\nabla \Theta|^2 + |\nabla_{x,t} p|^2) \right\} e^{2s\varphi} dx dt \\ \leq C_{70} \int_Q (f^2 + g^2) e^{2s\varphi} dx dt \\ + C_{70} \int_{Q_{\omega_\varepsilon}} \left\{ s^3\lambda^4\varphi^3 (\Theta^2 + p^2) + \frac{1}{s\varphi} |\partial_t \Theta|^2 + s^3\lambda^3\varphi^3 |\partial_t p|^2 \right\} e^{2s\varphi} dx dt, \end{aligned} \quad (3.7)$$

for all  $s \geq s_0$ . Noting  $\omega_\varepsilon \subseteq \omega$ , we obtain (1.13). The proof of Theorem 1.1 is complete.
