# Applications of Grothendieck's inequality to linear symplectic geometry

#### Abstract

Recently in symplectic geometry there arose an interest in bounding various functionals on spaces of matrices. It appears that Grothendieck's theorems about factorization are a useful tool for proving such bounds. In this note we present two such applications.


Linear symplectic geometry concerns a non-degenerate anti-symmetric bilinear form, called a symplectic bilinear form, and matrices that preserve this form, called symplectic matrices. Note that such forms exist only on even dimensional linear spaces. A standard example for this setting is the form defined on $\mathbb{R}^{2 n}$ by $(u, v) \mapsto\langle u, J v\rangle$ where $J$ (or $J_{2 n}$ ) is the $2 n \times 2 n$ matrix corresponding to multiplication by $i$ under the identification $\mathbb{R}^{2 n} \cong$ $\mathbb{C}^{n}$,

$$
J:=\left(\begin{array}{cc}
0 & -\mathbb{1}_{n \times n} \\
\mathbb{1}_{n \times n} & 0
\end{array}\right) .
$$

A matrix $S$ preserves this bilinear form if and only if it satisfies the following relation:

$$
\begin{equation*}
S^{T} J S=J . \tag{1}
\end{equation*}
$$

The space of such matrices is denoted by $\operatorname{Sp}(2 n)$.
More generally, given an even dimensional Euclidean vector space $E$, we denote by $J$ or $J_{E}$ a linear orthogonal transformation whose square equals to minus the identity on $E, J^{2}=-\mathbb{1}_{E}$. In this case, matrices satisfying the relation (11) with respect to $J_{E}$ preserve the form $(u, v) \mapsto\left\langle u, J_{E} v\right\rangle$ and the space of such matrices is denoted by $\operatorname{Sp}\left(E ; J_{E}\right)$.

In [1. Appendix A], Buhovsky, Logunov and Tanny proved that there exists a constant $c(n)$, depending on the dimension, such that for any finite
collection of vectors $v_{1}, \ldots, v_{N} \in \mathbb{R}^{2 n}$,

$$
\begin{equation*}
\sum_{i, j=1}^{N}\left|\left\langle v_{i}, J v_{j}\right\rangle\right| \leq c(n) \cdot \max _{\left|s_{i}\right|,\left|t_{j}\right| \leq 1}\left\langle\sum_{i=1}^{N} t_{i} v_{i}, J \sum_{j=1}^{N} s_{j} v_{j}\right\rangle \tag{2}
\end{equation*}
$$

where the constant $c(n)$ grows exponentially in $n$. In this paper it is shown that, using Grothendieck's inequality [2], the growth of the constant $c(n)$ in the above inequality can be improved to be $\sqrt{n}$. This result is stated in Corollary 4 below, and in Theorem 2 in a more general setting. Example 3 shows that the growth of $c(n) \propto \sqrt{n}$ is sharp. The second main result concerns the orbit of a finite collection of vectors under the action of the group of symplectic matrices. Grothendieck's inequality can be used to prove a sharp upper-bound for the minimal sum of norms of given vectors under the action of symplectic matrices, as stated in Theorem 5 below.

We use some basic facts and notations from operator theory. Denote by $\ell_{p}^{N}$ the space $\mathbb{R}^{N}$ equipped with the norm:

\begin{aligned}
\|u\|_{\ell_{p}^{N}} & :=\left(\sum_{i=1}^{N}\left|u_{i}\right|^{p}\right)^{\frac{1}{p}}, \quad 1 \leq p<\infty \\
\|u\|_{\ell_{\infty}^{N}} & :=\max _{1 \leq i \leq N}\left|u_{i}\right|,
\end{aligned}
$$

for $u=\left(u_{1}, \ldots, u_{N}\right) \in \mathbb{R}^{N}$. The space of linear operators from $\mathbb{R}^{n}$ to $\mathbb{R}^{m}$ is denoted by $\mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$. We identify an operator $A \in \mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$ with its matrix $A=\left(a_{i j}\right)_{i=1}^{m},{ }_{j=1}^{n}$. For such a matrix, one denotes by $A^{T} \in \mathcal{L}\left(\mathbb{R}^{m}, \mathbb{R}^{n}\right)$ its transpose. For a vector $\Lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$ we denote by $D_{\Lambda}$ the diagonal matrix corresponding to $\Lambda$, namely, $\left(D_{\Lambda}\right)_{i i}=\lambda_{i}$ and $\left(D_{\Lambda}\right)_{i j}=0$ for $i \neq j$.

For $1 \leq p, q \leq \infty$ one denotes by $\mathcal{L}\left(\ell_{p}^{n}, \ell_{q}^{m}\right)$ the linear space $\mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$ equipped with the operator norm from $\ell_{p}^{n}$ to $\ell_{q}^{m}$ :

$$
\|A\|_{\mathcal{L}\left(\ell_{p}^{n}, \ell_{q}^{m}\right)}=\max _{\|u\|_{p}^{n}=1}\|A u\|_{\ell_{q}^{m}} .
$$

For $A \in \mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$ let $\lambda_{0} \geq \lambda_{1} \geq \cdots \geq \lambda_{n-1}$ be the sequence of all eigenvalues $\lambda_{j}=\lambda_{j}\left(A^{T} A\right)$ of the operator $A^{T} A$ with multiplicities. The $j$-singular value of $A$ is defined as

$$
s_{j}(A):= \begin{cases}\sqrt{\lambda_{j}\left(A^{T} A\right)}, & j=0, \ldots, n-1, \\ 0, & j \geq n .\end{cases}
$$

Recall that $s_{0}(A)$ coincides with the operator norm $\|A\|_{\mathcal{L}\left(\ell_{2}^{n}, \ell_{2}^{m}\right)}$. The HilbertSchmidt norm of $A \in \mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$ is defined as

$$
\begin{equation*}
\|A\|_{H S}:=\sqrt{\sum_{j=0}^{\infty} s_{j}(A)^{2}} . \tag{3}
\end{equation*}
$$

If $\left(a_{i j}\right)_{i=1}^{m},{ }_{j=1}^{n}$ is the matrix representing $A$ then

$$
\begin{equation*}
\|A\|_{H S}=\sqrt{\sum_{i=1}^{m} \sum_{j=1}^{n} a_{i j}^{2}} . \tag{4}
\end{equation*}
$$

For an operator $A \in \mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{m}\right)$ such that $\operatorname{rank}(A)=k$, one has $s_{j}(A)=$ 0 for all $j \geq k$. Consequently,

$$
\begin{equation*}
\|A\|_{H S}=\sqrt{\sum_{j=0}^{k-1} s_{j}(A)^{2}} \leq \sqrt{k} \cdot s_{0}(A)=\sqrt{\operatorname{rank}(A)} \cdot\|A\|_{\mathcal{L}\left(\ell_{2}^{n}, \ell_{2}^{m}\right)} \tag{5}
\end{equation*}
$$

The following reformulation of Grothendieck's theorem [2] is a special case of Theorem 2.1 in [3], where the compact sets $S$ and $T$ are finite.

Theorem (see [3]). Let $\left(a_{i j}\right)_{i=1}^{m},{ }_{j=1}^{n}$ be an $m \times n$ real matrix. Then, there exist vectors $\Lambda_{0}=\left(\lambda_{1}^{0}, \ldots, \lambda_{m}^{0}\right)$ and $\Lambda_{1}=\left(\lambda_{1}^{1}, \ldots, \lambda_{n}^{1}\right)$ with non-negative entries $\lambda_{i}^{0} \geq 0, \lambda_{i}^{1} \geq 0$ and Euclidean norms bounded by $1,\left\|\Lambda_{0}\right\|_{\ell_{2}^{m}} \leq 1$, $\left\|\Lambda_{1}\right\|_{\ell_{2}^{n}} \leq 1$, and there exists an $m \times n$ matrix $B$ such that

$$
\begin{equation*}
A=D_{\Lambda_{0}} B D_{\Lambda_{1}} \tag{6}
\end{equation*}
$$

and

$$
\begin{equation*}
\|B\|_{\mathcal{L}\left(\ell_{2}^{n}, \ell_{2}^{m}\right)} \leq K \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{n}, \ell_{1}^{m}\right)} \tag{7}
\end{equation*}
$$

where $K$ is an absolute constant.
The smallest value of the constant $K$ is called Grothendieck's constant and is denoted by $K_{G}$. Its exact value is still unknown, Grothendieck himself proved that $\pi / 2 \leq K_{G} \leq \sinh (\pi / 2)$. The following consequence of Grothendieck's inequality is well known to the experts.

Lemma 1. For any $A \in \mathcal{L}\left(\mathbb{R}^{n}, \mathbb{R}^{n}\right)$ there exists a vector with strictly positive coordinates $\Lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$, $\lambda_{i}>0$ for all $1 \leq i \leq n$, such that $\|\Lambda\|_{\ell_{2}^{n}} \leq 1$ and

$$
\begin{equation*}
\left\|D_{\Lambda}^{-1} A D_{\Lambda}^{-1}\right\|_{\mathcal{L}\left(\ell_{2}^{n}, \ell_{2}^{n}\right)} \leq 3 K_{G} \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{n}, \ell_{1}^{n}\right)} . \tag{8}
\end{equation*}
$$

Proof. Let $\Lambda_{0}=\left(\lambda_{1}^{0}, \ldots, \lambda_{n}^{0}\right), \Lambda_{1}=\left(\lambda_{1}^{1}, \ldots, \lambda_{n}^{1}\right)$ and $B$ be the vectors and matrix from Grothendieck's theorem. Let us define

$$
\lambda_{i}:=\frac{1}{\sqrt{3}}\left(\frac{\sqrt{3}-\sqrt{2}}{\sqrt{n}}+\max \left\{\lambda_{i}^{0}, \lambda_{i}^{1}\right\}\right)>0 .
$$

Then, for $\Lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right)$, it is clear that $\|\Lambda\|_{\ell_{2}^{n}} \leq 1$ and that $\left\|D_{\Lambda}^{-1} D_{\Lambda_{j}}\right\|_{\mathcal{L}\left(\ell_{2}^{n}, \ell_{2}^{n}\right)} \leq$ $\sqrt{3}$. Inequality (8) easily follows.

The following result provides an asymptotically sharp bound for the constant $c(n)$ from (2).

Theorem 2. For any $N \times N$ matrix $A=\left(a_{i j}\right)_{i, j=1}^{N}$,

$$
\begin{equation*}
\sum_{i, j=1}^{N}\left|a_{i j}\right| \leq 3 K_{G} \cdot \sqrt{\operatorname{rank} A} \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)} \tag{9}
\end{equation*}
$$

Proof. Let $\Lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ be the vector from Lemma 1 corresponding to the matrix $A$. Denoting $B:=D_{\Lambda}^{-1} A D_{\Lambda}^{-1}, b_{i j}=\frac{1}{\lambda_{i} \lambda_{j}} a_{i j}$, we have

$$
\sum_{i, j=1}^{N}\left|a_{i j}\right|=\sum_{i, j=1}^{N}\left|b_{i j}\right| \cdot\left|\lambda_{i} \lambda_{j}\right| .
$$

By the Cauchy-Schwarz inequality,

$$
\begin{aligned}
\sum_{i, j=1}^{N}\left|b_{i j}\right| \cdot\left|\lambda_{i} \lambda_{j}\right| & \leq\left(\sum_{i, j=1}^{N} b_{i j}^{2}\right)^{\frac{1}{2}} \cdot\left(\sum_{i, j=1}^{N} \lambda_{i}^{2} \lambda_{j}^{2}\right)^{\frac{1}{2}} \\
& \leq\left(\sum_{i, j=1}^{N} b_{i j}^{2}\right)^{\frac{1}{2}}=\|B\|_{H S}
\end{aligned}
$$

and by (51) one has $\|B\|_{H S} \leq \sqrt{\operatorname{rank} B} \cdot\|B\|_{\mathcal{L}\left(\ell_{2}^{N}, \ell_{2}^{N}\right)}$. Since $B$ is a multiplication of $A$ by invertible matrices, $\operatorname{rank} B=\operatorname{rank} A$. Moreover, by Lemma 1 the $\mathcal{L}\left(\ell_{2}^{N}, \ell_{2}^{N}\right)$-norm of $B$ is bounded by $3 K_{G} \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}$. Overall we obtain

$$
\sum_{i, j=1}^{N}\left|a_{i j}\right| \leq\|B\|_{H S} \leq \sqrt{\operatorname{rank} B} \cdot\|B\|_{\mathcal{L}\left(\ell_{2}^{N}, \ell_{2}^{N}\right)} \leq \sqrt{\operatorname{rank} A} \cdot 3 K_{G} \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}
$$

The following example shows that the dependence on $\operatorname{rank} A$ in Theorem 2 is sharp.

Example 3. Let $k \leq N$ and take

$$
A=\left(\begin{array}{cc}
U_{k \times k} & 0 \\
0 & 0
\end{array}\right)
$$

where $U=\left(u_{i j}\right)_{i j}$ is a $k \times k$ orthogonal matrix whose entries satisfy

$$
\begin{equation*}
\left|u_{i j}\right| \leq \frac{C}{\sqrt{k}} \tag{10}
\end{equation*}
$$

For example, when $k=2 m$, one can consider the following matrix, related to the discrete Fourier transform, which is given in a block form by

$$
U=\frac{1}{\sqrt{m}}\left(\left[\begin{array}{rr}
\cos \left(\frac{2 \pi j \ell}{m}\right) & -\sin \left(\frac{2 \pi j \ell}{m}\right) \\
\sin \left(\frac{2 \pi j \ell}{m}\right) & \cos \left(\frac{2 \pi j \ell}{m}\right)
\end{array}\right]\right)_{j, \ell=1}^{m} .
$$

The above matrix satisfies condition (10) for $C=\sqrt{2}$.
For any such $A$, the orthogonality of $U$ implies that $\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)} \leq k$ and $\sum_{j, \ell=1}^{N} a_{j \ell}^{2}=k$. Therefore,

$$
\sum_{j, \ell=1}^{N}\left|a_{j \ell}\right| \geq \frac{\sum_{j, \ell=1}^{N} a_{j \ell}^{2}}{\max _{j, \ell}\left|a_{j \ell}\right|} \geq \frac{k \sqrt{k}}{C} \geq \frac{1}{C} \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)} \cdot \sqrt{\operatorname{rank} A}
$$

where the middle inequality follows from the assumption (10).
Corollary 4. For any finite collection of vectors $v_{1}, \ldots, v_{N}$ in $\mathbb{R}^{2 n}$,

$$
\begin{equation*}
\sum_{i, j=1}^{N}\left|\left\langle v_{i}, J v_{j}\right\rangle\right| \leq 3 K_{G} \cdot \sqrt{2 n} \cdot \max _{\left|t_{i}\right|,\left|s_{j}\right| \leq 1}\left\langle\sum_{i=1}^{N} t_{i} v_{i}, J \sum_{j=1}^{N} s_{j} v_{j}\right\rangle \tag{11}
\end{equation*}
$$

Proof. Consider the matrix $A=\left(a_{i j}\right)_{i, j=1}^{N}$ defined by $a_{i j}:=\left\langle v_{i}, J v_{j}\right\rangle$. Then, $\operatorname{rank} A \leq 2 n$ and

$$
\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}=\max _{\left|t_{i}\right|,\left|s_{j}\right| \leq 1} \sum_{i, j=1}^{N} t_{i} s_{j}\left\langle v_{i}, J v_{j}\right\rangle
$$

Applying Theorem 2 to the matrix $A$ gives the desired inequality.

The next result gives an upper-bound for the infimum of the sum of norms of vectors $v_{1}, \ldots, v_{N} \in \mathbb{R}^{2 n}$ under the action of $\mathrm{Sp}(2 n)$, by means of the rank and the $\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)$-norm of the matrix $\left(\left\langle v_{i}, J v_{j}\right\rangle\right)_{i, j=1}^{N}$. We remark that this matrix is invariant under the action of $\operatorname{Sp}(2 n)$ on the vectors $\left\{v_{i}\right\}_{i=1}^{N}$ (as follows easily from (11)).

Theorem 5. Let $v_{1}, \ldots, v_{N} \in \mathbb{R}^{2 n}$ and consider the $N \times N$ matrix defined by $A:=\left(\left\langle v_{i}, J v_{j}\right\rangle\right)_{i, j=1}^{N}$. Then,

$$
\begin{equation*}
\inf _{S \in \operatorname{Sp}(2 n)}\left(\sum_{i=1}^{N}\left\|S v_{i}\right\|_{\ell_{2}^{2 n}}\right)^{2} \leq 3 K_{G} \cdot \operatorname{rank} A \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)} \tag{12}
\end{equation*}
$$

Proof. By homogeneity, we may assume that $\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)} \leq 1$. Denoting by $V$ the $2 n \times N$ matrix whose columns are the vectors $\left\{v_{i}\right\}_{i=1}^{N}$, we can write

$$
\begin{equation*}
A=V^{T} J_{2 n} V \tag{13}
\end{equation*}
$$

We split the proof into cases, with respect to the rank of $A$ :
Case 1: Assume that $\operatorname{rank} A=2 n$, then $V$ must be of full rank, which means that the vectors $\left\{v_{i}\right\}_{i=1}^{N}$ span $\mathbb{R}^{2 n}$. By Lemma $\mathbb{1}$, there exists a vector $\Lambda=\left(\lambda_{1}, \ldots, \lambda_{N}\right) \in \mathbb{R}^{N}$ such that $\lambda_{i}>0$ for all $i,\|\Lambda\|_{\ell_{2}^{N}} \leq 1$, and such that the matrix $B:=D_{\Lambda}^{-1} A D_{\Lambda}^{-1}$ satisfies $\|B\|_{\mathcal{L}\left(\ell_{2}^{N}, \ell_{2}^{N}\right)} \leq 3 K_{G}$. Since $J$ is an anti-symmetric operator, it follows from (13) that

$$
B^{T}=D_{\Lambda}^{-1} V^{T} J_{2 n}^{T} V D_{\Lambda}^{-1}=-B,
$$

namely, $B$ is an anti-symmetric matrix of rank $2 n$. By the spectral theorem there exists a $2 n \times N$ matrix $Q$, which is a part of an $N \times N$ orthogonal matrix, such that $B=Q^{T} R Q$, where $R$ is a $2 n \times 2 n$ matrix of the form

$$
R=\left(\begin{array}{ccccc}
0 & -\mu_{1} & & & \\
\mu_{1} & 0 & & & \\
& & \ddots & & \\
& & & 0 & -\mu_{n} \\
& & & \mu_{n} & 0
\end{array}\right),
$$

for some $0<\mu_{i} \leq 3 K_{G}$. Denoting

$$
M:=\left(\sqrt{\mu_{1}}, \sqrt{\mu_{1}}, \sqrt{\mu_{2}}, \sqrt{\mu_{2}}, \ldots, \sqrt{\mu_{n}}, \sqrt{\mu_{n}}\right) \in \mathbb{R}^{2 n}
$$

we have $R=D_{M} R_{0} D_{M}$ where

$$
R_{0}=\left(\begin{array}{ccccc}
0 & -1 & & & \\
1 & 0 & & & \\
& & \ddots & & \\
& & & 0 & -1 \\
& & & 1 & 0
\end{array}\right)
$$

and is equal, up to a change of order of the basis elements, to $J$. Namely, $R_{0}=P^{T} J P$, where $P$ is a permutation matrix. We conclude that

$$
A=D_{\Lambda} B D_{\Lambda}=W^{T} J W,
$$

where $W$ is the $2 n \times N$ matrix defined by

$$
W:=P \cdot D_{M} \cdot Q \cdot D_{\Lambda} .
$$

By (13) we obtain

$$
\begin{equation*}
V^{T} J V=A=W^{T} J W \tag{14}
\end{equation*}
$$

Let us show that $\operatorname{ker} V=\operatorname{ker} W$. Indeed, $v \in \operatorname{ker} V$ if and only if for any $u \in \mathbb{R}^{2 n},\langle u, V v\rangle=0$. Since $J$ is invertible, this is equivalent to $\langle u, J V v\rangle=0$ for all $u \in \mathbb{R}^{2 n}$. Moreover, $V$ is of full rank and so its image is $\mathbb{R}^{2 n}$. Therefore, the latter condition is equivalent to $\left\langle w, V^{T} J V v\right\rangle=\langle V w, J V v\rangle=0$ for all $w \in \mathbb{R}^{N}$. We conclude that $\operatorname{ker} V=\operatorname{ker} V^{T} J V$. Arguing the same for $W$ and using (14) yields $\operatorname{ker} V=\operatorname{ker} W$.

Now, as both matrices $V, W$ are of full rank and have the same kernel, there exists a $2 n \times 2 n$ matrix $S$ such that

$$
W=S V
$$

Plugging this back in (14) yields

$$
V^{T} S^{T} J S V=V^{T} J V,
$$

which implies (since $V$ is of full rank) that $S^{T} J S=J$ and hence $S \in \operatorname{Sp}(2 n)$. Finally, let us bound the sum of norms of the vectors $\left\{S v_{i}\right\}_{i=1}^{N}$. Denoting by $\left\{e_{i}\right\}_{i=1}^{N}$ the standard basis of $\mathbb{R}^{N}$, we have $S v_{i}=W e_{i}$. In addition,

$$
\begin{aligned}
\left\|W e_{i}\right\|_{\ell_{2}^{2 n}} & =\left\|P \cdot D_{M} \cdot Q \cdot D_{\Lambda} e_{i}\right\|_{2}^{2 n} \\
& \leq\|P\|_{\mathcal{L}\left(\ell_{2}^{2 n}, \ell_{2}^{2 n}\right)} \cdot\left\|D_{M}\right\|_{\mathcal{L}\left(\ell_{2}^{2 n}, \ell_{2}^{2 n}\right)} \cdot\left\|Q e_{i}\right\|_{\ell_{2}^{2 n}} \cdot\left|\lambda_{i}\right| .
\end{aligned}
$$

Since $P$ is an orthogonal matrix, $\|P\|_{\mathcal{L}\left(\ell_{2}^{2 n}, \ell_{2}^{2 n}\right)}=1$. In addition,

$$
\left\|D_{M}\right\|_{\mathcal{L}\left(\ell_{2}^{2 n}, \ell_{2}^{2 n}\right)}=\max _{i} \sqrt{\mu_{i}} \leq \sqrt{3 K_{G}} .
$$

Therefore,

$$
\begin{aligned}
\sum_{i=1}^{N}\left\|S v_{i}\right\|_{\ell_{2}^{2 n}} & \leq \sqrt{3 K_{G}} \cdot \sum_{i=1}^{N}\left\|Q e_{i}\right\|_{\ell_{2}^{2 n}} \cdot\left|\lambda_{i}\right| \\
& \leq \sqrt{3 K_{G}} \cdot\left(\sum_{i=1}^{N}\left\|Q e_{i}\right\|_{\ell_{2}^{2 n}}^{2}\right)^{\frac{1}{2}} \cdot\left(\sum_{i=1}^{N} \lambda_{i}^{2}\right)^{\frac{1}{2}} \\
& \leq \sqrt{3 K_{G}} \cdot\left(\sum_{i=1}^{N}\left\|Q e_{i}\right\|_{\ell_{2}^{2 n}}^{2}\right)^{\frac{1}{2}} \\
& \leq \sqrt{3 K_{G}} \cdot \sqrt{2 n}
\end{aligned}
$$

where the last inequality follows from the fact that $Q$ is a part of an $N \times N$ orthogonal matrix. Since $2 n=\operatorname{rank} A$, this concludes the proof of the theorem for this case.

Case 2: Assume that $\operatorname{rank} A<2 n$. Set $E:=\operatorname{span}\left\{v_{1}, \ldots, v_{N}\right\} \subset \mathbb{R}^{2 n}$. Denote by $\ell$ the dimension of the kernel of the restriction of the bilinear form $\langle\cdot, J \cdot\rangle$ to $E$. By a well known fact from symplectic linear algebra, $\operatorname{dim} E-\ell=: 2 k$ is even, we have $k+\ell \leqslant n$, and moreover there exists a linear symplectic matrix $T \in \operatorname{Sp}(2 n)$ such that $T(E)=\operatorname{span}\left\{e_{1}, \ldots, e_{k}, e_{n+1}, \ldots, e_{n+k+\ell}\right\}$. Since both sides of the inequality (5) are invariant under the action of $\operatorname{Sp}(2 n)$ on vectors $v_{1}, \ldots, v_{N}$, we may assume without loss of generality that

$$
E=\operatorname{span}\left\{e_{1}, \ldots, e_{k}, e_{n+1}, \ldots, e_{n+k+\ell}\right\} .
$$

Denote

$$
\begin{gathered}
E_{0}=\operatorname{span}\left\{e_{1}, \ldots, e_{k}, e_{n+1}, \ldots, e_{n+k}\right\}, \\
E_{1}=\operatorname{span}\left\{e_{n+k+1}, \ldots, e_{n+k+\ell}\right\}, \\
E_{2}=\operatorname{span}\left\{e_{k+1}, \ldots, e_{k+\ell}\right\}, \\
E_{3}=\operatorname{span}\left\{e_{k+\ell+1}, \ldots, e_{n}, e_{n+k+\ell+1}, \ldots, e_{2 n}\right\} .
\end{gathered}
$$

We have the orthogonal decompositions $E=E_{0} \oplus E_{1}$ and $\mathbb{R}^{2 n}=$ $E_{0} \oplus E_{1} \oplus E_{2} \oplus E_{3}$. Consider the orthogonal projections $\pi_{i}: \mathbb{R}^{2 n} \rightarrow E_{i}$ for $i=0,1,2,3$. For any $u, v \in E$ we have

$$
\langle v, J u\rangle=\left\langle\pi_{0} v, J \pi_{0} u\right\rangle .
$$

Therefore, the matrix $A$ defined by $a_{i j}=\left\langle v_{i}, J v_{j}\right\rangle$ does not change when we replace $\left\{v_{i}\right\}$ by $\left\{\pi_{0} v_{i}\right\}$. Thus

$$
\operatorname{rank} A=\left.\operatorname{rank}\langle\cdot, J \cdot\rangle\right|_{E_{0}}=\operatorname{dim} E_{0}=2 k
$$

and we may apply Case 1 to the vectors $\left\{\pi_{0} v_{i}\right\}$ in $\left(E_{0},\left.J\right|_{E_{0}}\right)$. We conclude that there exists a matrix $S_{0}: E_{0} \rightarrow E_{0}$ such that $\left.S_{0}^{T} J\right|_{E_{0}} S_{0}=$ $\left.J\right|_{E_{0}}$ and

$$
\sum_{i=1}^{N}\left\|S_{0} \pi_{0} v_{i}\right\|_{\ell_{2}^{2 k}} \leq \sqrt{3 K_{G}} \cdot \sqrt{2 k}
$$

For any given $\varepsilon>0$ consider the operator

$$
S_{\varepsilon}:=S_{0} \pi_{0}+\varepsilon \pi_{1}+\frac{1}{\varepsilon} \pi_{2}+\pi_{3} .
$$

One can check that $S_{\varepsilon}$ satisfies relation (11) and therefore belongs to $\operatorname{Sp}(2 n)$. Finally, the sum of norms of $\left\{S_{\varepsilon} v_{i}\right\}$ is bounded as follows:

$$
\begin{aligned}
\sum_{i=1}^{N}\left\|S_{\varepsilon} v_{i}\right\|_{\ell_{2}^{2 n}} & =\sum_{i=1}^{N}\left\|S_{\varepsilon} \pi_{0} v_{i}+S_{\varepsilon} \pi_{1} v_{i}\right\|_{\ell_{2}^{2 n}} \\
& \leq \sum_{i=1}^{N}\left\|S_{0} \pi_{0} v_{i}\right\|_{\ell_{2}^{2 n}}+\sum_{i=1}^{N}\left\|\varepsilon \cdot \pi_{1} v_{i}\right\|_{\ell_{2}^{2 n}} \\
& \leq \sqrt{3 K_{G}} \cdot \sqrt{2 k}+\varepsilon \sum_{i=1}^{N}\left\|v_{i}\right\|_{\ell_{2}^{2 n}}
\end{aligned}
$$

Taking $\varepsilon \rightarrow 0$ we conclude that

$$
\inf _{S \in \operatorname{Sp}(2 n)} \sum_{i=1}^{N}\left\|S v_{i}\right\|_{2_{2}^{2 n}} \leq \sqrt{3 K_{G}} \cdot \sqrt{2 k}=\sqrt{3 K_{G}} \cdot \sqrt{\operatorname{rank} A}
$$

Example 6. Let us show that for any $k \leq 2 n$ there exist vectors $v_{1}, \ldots, v_{N} \in$ $\mathbb{R}^{2 n}$ with dim $\operatorname{span}\left\{v_{1}, \ldots, v_{N}\right\} \leq k$ such that for any matrix $S \in \operatorname{Sp}(2 n)$,

$$
\left(\sum_{j=1}^{N}\left\|S v_{j}\right\|_{\ell_{2}^{2 n}}\right)^{2} \geq C \cdot k \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}
$$

where $A:=\left(\left\langle v_{i}, J_{2 n} v_{j}\right\rangle\right)_{i, j=1}^{N}$. Notice that it is enough to consider the case where $k=2 m$ is even. In this case, take the vectors $v_{j}$ to be zero for $j>k=$ $2 m$ and $\left\{v_{1}, \ldots, v_{2 m}\right\}=\left\{e_{1}, \ldots, e_{m}, e_{n+1}, \ldots, e_{n+m}\right\}$. The corresponding matrix is

$$
A=\left(\begin{array}{cc}
J_{2 m} & 0 \\
0 & 0
\end{array}\right)
$$

and $\left(\sum_{j=1}^{N}\left\|v_{j}\right\|_{\ell_{2}^{2 n}}\right)^{2}=k^{2}=\operatorname{rank} A \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}$. Let $S \in \operatorname{Sp}(2 n)$ and set $w_{j}:=S v_{j}$ for all $1 \leq j \leq N$. Denote by $W$ the $2 n \times N$ matrix whose columns are the vectors $w_{j}$. Then, it follows from (11) that $A=W^{T} J_{2 n} W$. Let $\tilde{W}$ be the $2 n \times 2 m$ matrix whose columns are the first $2 m$ columns of $W$, then $\tilde{W}^{T} J_{2 n} \tilde{W}=J_{2 m}$.

Given a $k \times \ell$ matrix $P$ whose columns are the vectors $\left\{p_{1}, \ldots, p_{\ell}\right\} \subset \mathbb{R}^{k}$, we denote by $\Pi(P):=\prod_{i=1}^{\ell}\left\|p_{i}\right\|_{\ell_{2}^{k}}$ the product of the Euclidean norms of the columns of $P$. A generalized version of Hadamard's inequality states that for any pair of $k \times \ell$ matrices $P$ and $Q$, the determinant of $P^{T} Q$ is bounded by the product of $\ell_{2}$-norms of the columns of $P$ and $Q$, $\operatorname{det}\left(P^{T} Q\right) \leq \Pi(P) \cdot \Pi(Q)$. Applying this to $P=\tilde{W}, Q=J_{2 n} \tilde{W}$, we have

$$
1=\operatorname{det}\left(J_{2 m}\right)=\operatorname{det}\left(\tilde{W}^{T} \cdot J_{2 n} \tilde{W}\right) \leq \Pi(\tilde{W}) \cdot \Pi\left(J_{2 n} \tilde{W}\right)=\Pi(\tilde{W})^{2} .
$$

Using the inequality of arithmetic and geometric means we conclude that

$$
1 \leq \prod_{j=1}^{2 m}\left\|w_{j}\right\|_{\ell_{2}^{2 n}} \leq \frac{1}{2 m} \sum_{j=1}^{2 m}\left\|w_{j}\right\|_{\ell_{2}^{2 n}},
$$

and so

$$
\sum_{j=1}^{N}\left\|w_{j}\right\|_{\ell_{2}^{2 n}}=\sum_{j=1}^{2 m}\left\|w_{j}\right\|_{\ell_{2}^{2 n}} \geq 2 m=k=\sqrt{\operatorname{rank} A \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}} .
$$

Remark 7. In the above example we actually proved the following stronger statement: For any collection of vectors $v_{1}, \ldots, v_{N} \in \mathbb{R}^{2 n}$ that satisfy

$$
V^{T} J_{2 n} V=\left(\begin{array}{cc}
J_{2 m} & 0 \\
0 & 0
\end{array}\right)=: A
$$

for some $m \leq n$, where $V$ is the matrix whose columns are $\left\{v_{j}\right\}_{j=1}^{N}$, we have

$$
\begin{equation*}
\sum_{j=1}^{N}\left\|v_{j}\right\|_{\ell_{2}^{N}} \geq 2 m=\sqrt{\operatorname{rank}(A) \cdot\|A\|_{\mathcal{L}\left(\ell_{\infty}^{N}, \ell_{1}^{N}\right)}} \tag{15}
\end{equation*}
$$
