SIMULTANEOUS ACTION OF FINITELY MANY INTERVAL MAPS: SOME DYNAMICAL AND STATISTICAL PROPERTIES

Abstract

In this paper, we consider finitely many interval maps simultaneously acting on the unit interval I = [0, 1] in the real line \mathbb{R} ; each with utmost finitely many jump discontinuities and study certain important statistical properties. Even though we use the symbolic space on N letters to reduce the case of simultaneous dynamics to maps on an appropriate space, our aim in this paper remains to resolve ergodicity, rates of recurrence, decay of correlations and invariance principles leading up to the central limit theorem for the dynamics that evolves through simultaneous action. In order to achieve our ends, we define various Ruelle operators, normalise them by various means and exploit their spectra.

1 Introduction

Various dynamical properties and statistical properties help us understand the behaviour of dynamics caused by the action of a transformation T on some phase space X. Important among such properties include the Birkhoff's pointwise ergodic theorem, asymptotic estimates on rates of recurrence of typical orbits, decay of correlations, invariance principles, central limit theorem, law of iterated logarithms etc. Each of these theorems provide us a deeper glimpse into the structure, the dynamics builds in its phase space of action or an invariant subset, thereof.

Birkhoff's pointwise ergodic theorem observes a considered dynamical system through a real-valued continuous function and states that the sequence of local time averages along the orbit of any typical point converges to the global space average, whenever the transformation T acting on X is ergodic. Though the result is extremely strong, it does allow some points (though negligible, meaning with collective measure zero) to fluctuate from this mean behaviour. Thus, an interesting study in the dynamics of such ergodic systems is to obtain a good understanding of the set of points that violate the Birkhoff's ergodic conditions. An easy way to approach this subject locally is to work out the ergodic sums of the observables and consider the cardinality of the set of points whose ergodic sum calculated at various times remain inside some chosen interval $[a, b] \subset \mathbb{R}$. However, on a global scale, an alternate way to understand the deviation from the average behaviour of typical orbits is achieved by formalising the central limit theorem.

The central limit theorem is an important tool in mathematics that distributes the random variables along a bell-curve (normal distribution), as more and more independent random variables are appropriately included under the ambit of study. This is a central object of investigation in understanding deterministic dynamical systems, owing to its natural appeal, when we consider the various orbits in the phase space. However, as important as the central limit theorem is, we see that they are subsumed by more general invariance principles. A sequence of random variables $\{X_n\}_{n\geq 1}$ is said to satisfy an almost sure invariance principle if the sequence can be approximated almost surely by another sequence, preferably with certain desired properties and with a relatively small margin of error.

Several mathematicians have studied these properties in many deterministic dynamical systems, where the phase space is a compact interval of the real line, [12, 8, 25, 34, 10, 11], the Julia set of some rational map that occurs as a compact subset of the Riemann sphere, [15, 14, 40, 41], etc., however, with a single transformation acting on the appropriate space, based on which the dynamics evolves. Examples of continuous time dynamical systems that has remained in the focus of the dynamics community include expanding flows restricted on a compact subset of the Riemannian manifold, [13, 24, 31] or some mixing Axiom A diffeomorphism restricted on a basic set, [35, 22, 39, 1, 33]. A particularly desirable feature of all the above-mentioned maps restricted on their respective sets is that they can be studied through an associated symbolic model [4, 35]. There are also various studies carried out by several mathematicians that analyse statistical results in various settings of dynamical systems. Prominent among them include [30, 19, 9, 29, 32, 45, 21, 18, 44, 27, 20].

What we intend to investigate in this paper is slightly richer in dynamics, than what is explained so far. In this paper, we consider the compact unit interval $[0, 1] \subset \mathbb{R}$; however

with finitely many maps acting on the space simultaneously. Thus, the dynamics evolves along the multiple branches provided by each of these maps. In fact, we work with finitely many interval maps defined on [0, 1]; each of which has a discrete set of utmost finitely many discontinuities. As an expert reader may realise, these results are readily transferable to various settings including the simultaneous action of finitely many rational maps restricted on the appropriate Julia set, as defined in [42] or to the action of a holomorphic correspondence restricted on the support of its Dinh-Sibony measure, as defined in [3]. We shall explain our claim of transferability of the main theorems of this paper, as written above, in the final section, (14).

This paper is structured as follows: In the next two introductory sections (2) and (3), we narrate the basic settings of this paper and develop certain notations and dynamical notions, however only as skeletal to enable us to state the main theorems of this paper in section (4). The main results of this paper describe the ergodicity of the system in theorems (4.1) and (4.6), the rates of recurrence in theorems (4.2) and (4.7), the exponential decay of correlations in theorems (4.3) and (4.8), almost sure invariance principles in theorems (4.4) and (4.9) and a few more statistical properties such as the central limit theorems and the laws of iterated logarithms in theorems (4.5) and (4.10). The reason why each theorem appears twice in the list above will be clear, by the time we reach section (4). In section (5), we recall the setting of symbolic dynamics that comes in handy as a book-keeping mechanism in our study. In sections (6), (7) and (8), we define three kinds of Ruelle operators on the appropriate Banach space of continuous functions and Hölder continuous functions defined on the phase spaces that interest us, compare their spectra and normalise them in different ways in order that they help us in proving our main theorems. Having achieved these, we embark on writing the proofs of the main theorems in sections (9), (10), (11), (12) and (13). We conclude the paper with a few remarks in section (14).

2 Preliminaries and the pressure function

In this section, we explain the setting of our paper and define certain basic terminologies that help us in constructing the necessary notions to state our main results.

Let I denote the unit interval on the real line, i.e., I = [0, 1]. We are interested in studying the dynamics of finitely many interval maps acting simultaneously on I, i.e., given $N \in \mathbb{N}$ and $1 \le d \le N$, we consider the interval maps $T_d: I \longrightarrow I$ of degree (d+1) given by

$$T_d(x) := (d+1) x \pmod{1}.$$

The simultaneous action is explained as follows: For any $x_0 \in I$, its forward orbit at times $t = 0, 1, 2, \dots, n, \dots$ is defined as

$$\left\{ x_0, x_1 \in \bigcup_{d=1}^N T_d(x_0), x_2 \in \bigcup_{d=1}^N T_d(x_1), \dots, x_n \in \bigcup_{d=1}^N T_d(x_{n-1}), \dots \right\}.$$
 (2.1)

Thus, at every stage, we have N many maps to choose from to move forward and the totality of all these branches describe the forward orbit. Observe that the dynamics that arises out

of such a process can also be described by the action of a semigroup generated by the same interval maps, $\mathscr{S} = \langle T_1, T_2, \dots, T_N \rangle$, or as a correspondence on $I \times I$, appropriately defined.

Suppose $\mathcal{C}(V, \mathbb{F})$ denotes the space of all continuous functions defined on the space V that takes values on the field \mathbb{F} . Then, for any $f \in \mathcal{C}(I, \mathbb{C})$, the set of all complex-valued continuous functions defined on I, we define a *composition operator*, \mathscr{O} by

$$\mathscr{O}(f) \in \bigcup_{d=1}^{N} (f \circ T_d).$$

Along every orbit of the point x_0 , as described in (2.1), this composition operator chooses the map T_d every time in such a fashion that $T_d(x_{k-1}) = x_k$. Hence, even though $\mathcal{O}(f)$ is not single-valued, we have by definition that $(\mathcal{O}(f))(x_0)$ to be single-valued along every chosen orbit of x_0 . We further describe this idea in section (3).

To assist us in this study, we will make use of the space consisting of infinitely long words on N symbols, i.e., suppose $S = \{1, 2, \dots, N\}$, we consider

$$\Sigma_N^+ := S^{\mathbb{Z}_+} = \{ w = (w_1 \, w_2 \, \cdots \, w_n \, \cdots) : w_i \in S \}.$$

As we shall explain in section (5), Σ_N^+ is a compact measurable metric space equipped with the Bernoulli measure, where the shift map σ defined by $(\sigma(w))_n = w_{n+1}$ is continuous and non-invertible, but a local homeomorphism.

From now on, we denote by X the product phase space given by $X := \Sigma_N^+ \times I$, where we define a skew-product map T as

$$T(w, x) := (\sigma w, T_{w_1} x), \text{ where } w = (w_1 w_2 \cdots).$$
 (2.2)

By a standard argument due to Tychonoff, as may be found in [28], we consider the natural product topology on X that gives rise to the metric $d_X(\cdot, \cdot)$ on X. Further, we also have the product sigma-algebra and the product measure defined on X. Let μ denote some T-invariant measure supported on X. For example, the appropriate product measure of the Bernoulli measure on cylinder sets of Σ_N^+ and the Lebesgue measure on open intervals of I is a T-invariant probability measure on X.

The definition of the skew-product map T entails that the forward orbit of (w, x) at times $t = 0, 1, 2, \dots, n, \dots$ under T is given by

$$\{(w, x), (\sigma w, T_{w_1}x), (\sigma^2 w, (T_{w_2} \circ T_{w_1})x), \cdots, (\sigma^n w, (T_{w_n} \circ T_{w_{n-1}} \cdots \circ T_{w_1})x), \cdots\}$$

Thus, for a chosen w in Σ_N^+ , the natural projection on the second co-ordinate $\mathbf{Proj}_2: X \longrightarrow I$ captures the sectional idea behind the orbit of $x \in I$ as described in (2.1). Taking the union over all possible $w \in \Sigma_N^+$ captures the idea in its entirety.

For ease of notations, we fix little letters like f, g, h, etc. to represent functions defined on the interval, I and use big letters like F, G, H etc. to represent functions defined on the product space $X = \Sigma_N^+ \times I$. Although one may think of f as being a restriction of F on the interval, $i.e., F = f \circ \mathbf{Proj}_2$ that yields F((w, x)) = f(x), it need not be the case always.

The space X now facilitates us to redefine the composition operator, in this setting denoted by \mathcal{Q} defined on $\mathcal{C}(X,\mathbb{C})$ given by

$$\mathscr{Q}(F) := F \circ T.$$

Let $\mathscr{F}_{\alpha}(X,\mathbb{C})$ denote the space of all complex-valued α -Hölder continuous functions defined on X. For $F \in \mathscr{F}_{\alpha}(X,\mathbb{C})$, we define the following norm,

$$||F||_{\alpha} := |F|_{\alpha} + ||F||_{\infty},$$

where

$$|F|_{\alpha} := \sup_{(w,x) \neq (v,y)} \left\{ \frac{|F((w,x)) - F((v,y))|}{(d_X((w,x),(v,y)))^{\alpha}} : (w,x), (v,y) \in X \right\}$$

denotes the α -Hölder semi-norm and $||F||_{\infty}$ denotes the usual supremum norm. Then, $\mathscr{F}_{\alpha}(X,\mathbb{C})$ is a Banach space under the norm $||\cdot||_{\alpha}$.

Given any function $F \in \mathcal{C}(X,\mathbb{R})$, its *pressure* is defined as

$$\mathfrak{P}(F) := \sup \left\{ h_{\mu}(T) + \int F d\mu \right\}, \tag{2.3}$$

where the supremum is taken over all T-invariant probability measures supported on X. Further, $h_{\mu}(T)$ is the measure theoretic entropy of T with respect to μ . An equilibrium measure for the function F denoted by μ_F is defined as that measure for which the supremum is attained in the definition of pressure, as stated in (2.3). The unique existence of μ_F for every $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ is assured by Denker and Urbanski in [15] and Sumi and Urbanski in [43], for an analogous setting.

The pressure function and the equilibrium measure have respective analogues for dynamics under simultaneous actions of the interval maps. We will establish the same later in section (8). However, for the sake of stating the results, we mention the following properties. Given $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$, its *pressure* under simultaneous dynamics that we denote by $\mathbb{P}(f)$ coincides with the quantity $\mathfrak{P}(f \circ \mathbf{Proj}_2)$. Similarly, the measure \mathfrak{m}_f on I, whose relation with $\mu_{f \circ \mathbf{Proj}_2}$, which will be an easy observation once defined, is given by,

$$\int g \, d\mathfrak{m}_f = \int (g \circ \mathbf{Proj}_2) \, d\mu_{f \circ \mathbf{Proj}_2}, \quad \forall g \in \mathscr{F}_{\alpha}(I, \mathbb{R}).$$

3 Periodic points and other dynamical notions

A point $(w, x) \in X$ is said to be a *periodic point* of period p for T iff $\sigma^p w = w$ and $(T_{w_p} \circ T_{w_{p-1}} \circ \cdots \circ T_{w_1}) x = x$. We denote the set of all p-periodic points by $\operatorname{Fix}_p(T)$. Once we determine the periodic points of T, it becomes easier for us to identify the periodic orbits of simultaneous action of the N many interval maps.

We first introduce a few notations here. For any $x_1 \in I$, let $\mathcal{R}_n(x_1)$ denote the set of all rays starting from x_1 that describe the initial n-long itinerary of the trajectory of x_1 in the order that the point visits, *i.e.*,

$$\mathscr{R}_n(x_1) := \left\{ (x_1, x_2, \cdots, x_n) \in I^n : \forall 2 \le k \le n, \exists 1 \le d \le N \text{ such that } T_d(x_{k-1}) = x_k \right\}.$$

Further, we denote by $\mathscr{R}(x_1) = \mathscr{R}_{\infty}(x_1)$ the set of all infinite rays starting from x_1 , where we produce each point in $\mathscr{R}_n(x_1)$ to an infinitely long sequence, as allowed by the dynamics, *i.e.*,

$$\mathscr{R}(x_1) := \Big\{ (x_1, x_2, \cdots) \in I^{\mathbb{Z}_+} : \forall k \ge 2, \exists 1 \le d \le N \text{ for which } T_d(x_{k-1}) = x_k \Big\}.$$

For any $m \leq n < \infty$, we define the following projection operators on the set $\mathcal{R}_n(x_1)$ as follows:

$$\Pi_m: \mathscr{R}_n(x_1) \longrightarrow \mathscr{R}_m(x_1)$$
 defined by $\Pi_m((x_1, x_2, \cdots, x_n)) = (x_1, x_2, \cdots, x_m);$
 $\pi_m: \mathscr{R}_n(x_1) \longrightarrow I$ defined by $\pi_m((x_1, x_2, \cdots, x_n)) = x_m.$

Allowing a slight abuse of notations, for any $m < \infty$, analogous definitions can be written for the projection operators Π_m and π_m defined on $\mathcal{R}(x_1)$.

$$\begin{array}{llll} \Pi_m & : & \mathscr{R}(x_1) & \longrightarrow & \mathscr{R}_m(x_1) & \text{defined by} & \Pi_m\left((x_1,\,x_2,\,\cdots)\right) & = & (x_1,\,x_2,\,\cdots,\,x_m)\,; \\ \pi_m & : & \mathscr{R}(x_1) & \longrightarrow & I & \text{defined by} & \pi_m\left((x_1,\,x_2,\,\cdots)\right) & = & x_m. \end{array}$$

We say $x_1 \in I$ is a *periodic point* of period p with *periodic orbit* $(x_1, x_2, \dots, x_p) \in \mathcal{R}_p(x_1)$ pertaining to the combinatorial data given by some p-lettered word $w = (w_1 w_2 \cdots w_p)$ on N letters (the length of w denoted by |w| = p), if

- 1. $\pi_1((x_1, x_2, \cdots)) = \pi_{p+1}((x_1, x_2, \cdots));$
- 2. p is the least such positive integer for which the first condition is true, *i.e.*, $\pi_1((x_1, x_2, \cdots)) \neq \pi_q((x_1, x_2, \cdots)) \forall q \leq p$; and
- 3. there does not exist any distinct $1 \leq q, r \leq p$ for which $\pi_q((x_1, x_2, \dots, x_p)) = \pi_r((x_1, x_2, \dots, x_p)).$

We identify such a periodic point $x_1 \in I$ with period p and periodic orbit (x_1, x_2, \dots, x_p) by looking for periodic blocks of points in $\mathcal{R}(x_1)$ that satisfy,

$$\Pi_p((x_1, x_2, \cdots)) = \Pi_p((x_{mp+1}, x_{mp+2}, \cdots)) \quad \forall m \in \mathbb{Z}_+.$$

It is a simple observation that corresponding to any p-periodic point $x \in I$, there exists a p-lettered word $w = (w_1 w_2 \cdots w_p)$ on N letters such that

$$T_w x := (T_{w_p} \circ \cdots \circ T_{w_1}) x = x.$$

For any *n*-lettered word $w = (w_1 w_2 \cdots w_n)$, we collect the points satisfying $T_w x = x$ in the set $Fix(T_w)$.

For any T-invariant probability measure μ supported on X, let F, G be any two complexvalued integrable functions defined on X, the appropriate space denoted by $L^1(\mu)$. We say the functions F and G are cohomologous to each other if there exists a function $H \in L^1(\mu)$ such that $F - G = \mathcal{Q}(H) - H$. If F is cohomologous to the constant function $\mathbf{0}$, then F is called a coboundary. For any $F \in \mathcal{C}(X, \mathbb{C})$, we denote and define its n-th ergodic sum by

$$F^n := F + \mathcal{Q}(F) + \mathcal{Q}^2(F) + \dots + \mathcal{Q}^{n-1}(F).$$
 (3.1)

Hence, for any two cohomologous functions F and G, it is obvious that their n-th ergodic sums evaluated at a periodic point of period n must be the same, i.e.,

$$F^n((w, x)) = G^n((w, x)) \quad \forall (w, x) \in \operatorname{Fix}_n(T).$$

Let $F, G \in \mathscr{F}_{\alpha}(X, \mathbb{R})$ with F not being cohomologous to any constant function. Then, by a result due to Ruelle in [37], the function $t \mapsto \mathfrak{P}(F + tG)$, where $t \in \mathbb{R}$, is convex and real analytic. Further, from [9] and [29], we have

$$\frac{d}{dt}\Big(\mathfrak{P}(F+tG)\Big)\bigg|_{t=0} = \int G \,d\mu_F \tag{3.2}$$

$$\left. \frac{d^2}{dt^2} \Big(\mathfrak{P}(F + tG) \Big) \right|_{t=0} = \lim_{n \to \infty} \frac{1}{n} \int \left(G^n - n \int G \, d\mu_F \right)^2 \, d\mu_F > 0. \tag{3.3}$$

For simultaneous action of N interval maps at a point $x \in I$, the n-th order ergodic sum of any $f \in \mathcal{C}(I,\mathbb{C})$ must be calculated over its appropriate orbit, *i.e.*, given a n-lettered word $w = (w_1 w_2 \cdots w_n)$ on N letters, we define the composition operator \mathcal{O}_w by

$$\mathscr{O}_w(f) := f \circ T_w, \quad \text{where } T_w := T_{w_n} \circ \cdots \circ T_{w_1}.$$

Then, the n-th order ergodic sum of the function f with respect to the given n-lettered word w, or (by a slight abuse of notations) the n-th order ergodic sum of the function f with respect to any given infinite-lettered word $w = (w_1 w_2 \cdots w_n \cdots)$ on N letters that agree with our n-lettered word on the initial n positions is given by

$$f_w^n(x) := (f + \mathcal{O}_{(w_1)}(f) + \dots + \mathcal{O}_{(w_1 \, w_2 \, \dots \, w_{n-1})}(f))(x)$$

= $(f + f(T_{w_1}) + \dots + f(T_{w_{n-1}} \circ \dots \circ T_{w_2} \circ T_{w_1}))(x).$

For a given n-lettered word $w = (w_1 w_2 \cdots w_n)$ on N letters, we say that two Lebesgue integrable functions $f, g \in L^1(\lambda)$ defined on I are w-cohomologous to each other if there exists an integrable function $h \in L^1(\lambda)$, also defined on I such that $f - g = \mathcal{O}_w h - h$. Hence, for any two w-cohomologous functions f and g, we observe that the values of the function evaluated at a periodic point x_1 of period n with periodic orbit (x_1, x_2, \cdots, x_n) pertaining to the combinatorial data given by the n-lettered word w, necessarily agree; and so do their n-th order ergodic sums. Further, if f is w-cohomologous to the constant function $\mathbf{0}$, then f is called a w-coboundary.

4 Statements of results

In this section, we state the main theorems of this paper. The first five results concern the setting of the dynamics of the skew-product map T defined on $X = \Sigma_N^+ \times I$, while the next

five results concern the setting of simultaneous dynamics of the concerned interval maps on I; thus generalising the situation to maps that evolve with multiple branches.

Theorem 4.1 (Ergodicity) The action of T on the product space X is necessarily ergodic with respect to the product measure μ . In other words, the measure of any subset $B \subseteq X$, in the product sigma-algebra of X that satisfies $T^{-1}B = B$, is necessarily 0 or 1.

Theorem 4.2 (Rates of recurrence) Consider $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ that satisfies the approximability condition, i.e., there exists distinct points $(w_1, x_1) \in \operatorname{Fix}_{p_1}(T)$, $(w_2, x_2) \in \operatorname{Fix}_{p_2}(T)$ and $(w_3, x_3) \in \operatorname{Fix}_{p_3}(T)$ with $p_i \neq p_j$ for $i \neq j$ for which

$$\frac{F^{p_2}((w_2, x_2)) - F^{p_1}((w_1, x_1))}{F^{p_3}((w_3, x_3)) - F^{p_1}((w_1, x_1))} =: \mathfrak{d}_1$$

$$(4.1)$$

is a Diophantine number, i.e., there exists l > 2 and m > 0 such that we have

$$\left|\mathfrak{d}_{1} - \frac{p}{q}\right| \geq \frac{m}{q^{l}}, \quad \forall p, q \in \mathbb{Z}_{+}. \tag{4.2}$$

Further, suppose that there exists a unique real number κ such that

$$\int F d\mu_{\kappa F} = 0.$$

Then, for every $n \in \mathbb{Z}_+$, $a, b \in \mathbb{R}$ with a < b, there exists a positive real constant $C_1 > 0$ such that

$$\#\Big\{(w,\,x)\in\operatorname{Fix}_n(T):a\leq F^n((w,\,x))\leq b\Big\} \sim C_1\frac{e^{n\mathfrak{P}(\kappa F)}}{\sqrt{n}}\int_a^b e^{-\kappa t}\,dt. \tag{4.3}$$

Here, in equation (4.3), by $a_n \sim b_n$, we mean that $\lim_{n \to \infty} \frac{a_n}{b_n} = 1$.

Theorem 4.3 (Exponential decay of correlations) For any $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ whose equilibrium measure is denoted by μ_F , there exists a constant $\vartheta \in (0,1)$ such that for all $G, H \in \mathscr{F}_{\alpha}(X,\mathbb{R})$, we have $C_2 > 0$ (depending on G and H) that satisfies

$$\left| \int \mathcal{Q}^n(G)H \, d\mu_F - \int G \, d\mu_F \int H \, d\mu_F \right| \leq C_2 \vartheta^n; \quad \forall n \geq 1.$$
 (4.4)

The preceding theorem defines the exponential decay of correlations of the distributions $\mathcal{Q}^n(G)$ and H with respect to the measure μ_F as $n \to \infty$. The exponential nature of the decay is evident in the statement of the theorem. The next theorem relates the ergodic sum of $G \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ to what is known as the Brownian motion on some richer probability space.

Theorem 4.4 (Almost sure invariance principle) For any $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ whose equilibrium measure is denoted by μ_F , consider $G \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ satisfying

$$\int G d\mu_F = 0.$$

Suppose the variance of $H \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ is defined as

$$(\varsigma(H))^2 := \lim_{n \to \infty} \frac{1}{n} \int \left(H^n - n \int H d\mu_F\right)^2 d\mu_F.$$

Then, there exists a Hölder continuous function $\Phi \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ cohomologous to G, a one-dimensional Brownian motion $\left\{\mathfrak{B}(t)\right\}_{t\geq 0}$ with variance $t\left(\varsigma(G)\right)^2$ and a sequence of random variables $\left\{\mathfrak{Y}_n:\Omega\longrightarrow\mathbb{R}\right\}_{n\geq 0}$ such that $\left\{\mathfrak{Y}_n\right\}_{n\geq 0}$ and $\left\{\Phi^n\right\}_{n\geq 0}$ are equal in distribution and given any $\delta>0$,

$$\mathfrak{Y}_{|t|}(\omega) = \mathfrak{B}(t)(\omega) + O(t^{\frac{1}{4}+\delta}), \quad \forall t \geq 0, \quad \mu_F\text{-a.e.},$$

provided G is not a coboundary.

The almost sure invariance principle leads to a few important corollaries such as the central limit theorem and the law of iterated logarithms.

Theorem 4.5 (Central limit theorem and law of iterated logarithms) For any $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ whose equilibrium measure is denoted by μ_F , consider $G \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ satisfying

$$\int G d\mu_F = 0.$$

Suppose G is not a coboundary. Then,

- 1. G satisfies the central limit theorem, i.e., $\frac{1}{\sqrt{n}}G^n$ converges in distribution to a normal distribution with mean zero and variance $(\varsigma(G))^2$ as $n \to \infty$.
- 2. G satisfies the law of iterated logarithms, i.e.,

$$\limsup_{n \to \infty} \frac{G^n((w, x))}{\varsigma(G)\sqrt{2n \log \log n}} = 1 \quad \mu_F\text{-a.e.}$$

In the next five theorems, we state theorems captioned under the same titles, however, by suppressing the first co-ordinate of X and looking at a genuine simultaneous action of the finitely many interval maps under consideration.

Theorem 4.6 (Ergodicity) Consider the interval maps T_1, T_2, \dots, T_N that act simultaneously on the interval I. Let λ denote the Lebesgue measure on \mathbb{R} . Then, for any real-valued Lebesgue integrable function $f \in L^1(\lambda)$, for λ -a.e. $x \in I$, we have

$$\lim_{n \to \infty} \frac{1}{n} \frac{1}{N^n} \sum_{w: |w| = n} \left[f + \mathcal{O}_{(w_1)}(f) + \dots + \mathcal{O}_{(w_1 w_2 \dots w_{n-1})}(f) \right] (x) = \int_0^1 f \, d\lambda. \quad (4.5)$$

Theorem 4.7 (Rates of recurrence) Consider $f \in \mathscr{F}_{\alpha}(I, \mathbb{R})$ that satisfies the approximability condition, i.e., there exists distinct periodic points x, y and z in I with distinct periods p_x , p_y and p_z , pertaining to the combinatorial data given by w_x , w_y and w_z such that

$$\frac{f_{w_y}^{p_y}(y) - f_{w_x}^{p_x}(x)}{f_{w_x}^{p_z}(z) - f_{w_x}^{p_x}(x)} = \mathfrak{d}_2 \tag{4.6}$$

is a Diophantine number. Further, suppose there exists unique $\kappa > 0$ such that

$$\int f d\mathfrak{m}_{\kappa f} = 0.$$

Then, for every $n \in \mathbb{Z}_+$, $a, b \in \mathbb{R}$ with a < b, there exists a positive real constant $C_3 > 0$ such that

$$\sum_{w:|w|=n} \# \left\{ x \in \operatorname{Fix}(T_w) : a \le f_w^n(x) \le b \right\} \sim C_3 \frac{e^{n\mathbb{P}(\kappa f)}}{\sqrt{n}} \int_a^b e^{-\kappa t} dt.$$

Theorem 4.8 (Exponential decay of correlations) Let λ denote the Lebesgue measure on I. Then, there exist a constant $\vartheta \in (0,1)$ such that for all α -Hölder continuous functions $g, h \in \mathscr{F}_{\alpha}(I,\mathbb{R})$, we have $C_4 > 0$ (depending on g, h and some n-lettered word w) that satisfies

$$\left| \int \mathscr{O}_w(g) h \, d\lambda - \int g \, d\lambda \, \int h \, d\lambda \right| \leq C_4 \vartheta^n; \quad \forall n \geq 1.$$
 (4.7)

Theorem 4.9 (Almost sure invariance principle) Let λ denote the Lebesgue measure on I. For any $g \in \mathscr{F}_{\alpha}(I,\mathbb{R})$ with

$$\int g \, d\lambda = 0,$$

and $w = (w_1 w_2 \cdots) \in \Sigma_N^+$, assume that the variance of g with respect to the word w denoted by $(\varsigma_w(g))^2$ and defined by

$$\left(\varsigma_w(g)\right)^2 := \lim_{n \to \infty} \frac{1}{n} \int (g_w^n)^2 d\lambda > 0.$$

Then, there exists a probability space $(\Omega, \mathscr{A}, \nu)$, a sequence of random variables $\{Y_w^n\}_{n\geq 0}$ and a standard Brownian motion $\{\mathfrak{B}^*(t)\}_{t\geq 0}$ such that g_w^n and Y_w^n are equal in distribution and given any $\delta>0$,

$$Y_w^n(\omega) - \mathfrak{B}^* \left(\left(\varsigma_w^{(n)}(g) \right)^2 \right) (\omega) = O\left(n^{\frac{1}{4} + \delta} \right), \quad \nu\text{-a.e. where } \left(\varsigma_w^{(n)}(g) \right)^2 = \int (g_w^n)^2 d\lambda, \tag{4.8}$$

provided $g_{\Pi_n(w)}$ is not a $\Pi_n(w)$ -coboundary for any $n \geq 1$.

Theorem 4.10 (Central limit theorem and law of iterated logarithms) For a function $g \in \mathscr{F}_{\alpha}(I, \mathbb{R})$ that satisfies

$$\int g \, d\lambda = 0,$$

suppose $w \in \Sigma_N^+$ is such that the variance $(\varsigma_w(g))^2 > 0$ and $g_{\Pi_n(w)}$ is not a $\Pi_n(w)$ -coboundary for any $n \geq 1$. Then,

- 1. g satisfies the central limit theorem i.e., $\frac{1}{\sqrt{n}}g_w^n$ converges in distribution to a normal distribution with mean zero and variance $(\varsigma_w(g))^2$ as $n \to \infty$.
- 2. g satisfies the law of iterated logarithms, i.e.,

$$\limsup_{n \to \infty} \frac{g_w^n(x)}{\varsigma_w(g)\sqrt{2n\log\log n}} = 1 \quad \lambda\text{-a.e.}$$

5 A book-keeping mechanism, Σ_N^+

In this section, we define the space Σ_N^+ and discuss certain properties that will be useful in the sequel. Interested readers may refer to [23], for more details on this space. Recall the definition of Σ_N^+ from section (2),

$$\Sigma_N^+ := S^{\mathbb{Z}_+} = \{1, 2, \cdots, N\}^{\mathbb{Z}_+} = \{w = (w_1 w_2 \cdots w_n \cdots) : w_i \in \{1, 2, \cdots, N\}\}.$$

Observe that one can define the maps Π_m and π_m on the symbolic space S^n as well as Σ_N^+ , analogous to its definitions on I^n and $I^{\mathbb{Z}_+}$. We make use of the same to define a metric between any words $v, w \in \Sigma_N^+$. Fix any $\theta \in (0, 1)$, and define

$$d_{\Sigma_N^+}(v, w) := \theta^{n(v, w)}, \text{ where } n(v, w) := \sup \{k \in \mathbb{Z}_+ : \Pi_k(v) = \Pi_k(w)\}.$$

Here, we define $n(v,v) := \infty$, thereby $d_{\Sigma_N^+}(v,v) = 0$. Thus, it is clear that we have a family of metrics on the space Σ_N^+ . The discrete topology that separates any two distinct symbols

on the set $\{1, 2, \dots, N\}$ accords a product topology on Σ_N^+ with which the above described family of metrics is compatible. We shall fix a value of θ , according to our need in a later section. In this topology, the cylinder sets given by fixing a finite set of co-ordinates, are the sets that are both closed and open. For ease of explanations, we shall always consider cylinder sets whose co-ordinates are fixed from the first co-ordinate onwards, for example, a cylinder set of length m looks like

$$[v_1 v_2 \cdots v_m] = \{ w \in \Sigma_N^+ : \Pi_m(w) = (v_1 v_2 \cdots v_m) \}.$$

These cylinder sets form a basis for the σ -algebra on Σ_N^+ on which one could define a measure for Σ_N^+ . An easily describable measure on the space, Σ_N^+ is the Bernoulli measure defined thus. For any fixed probability vector $p = (p_1, p_2, \dots, p_N)$, the measure is defined as

$$\mu\Big(\big[v_1\,v_2\,\cdots\,v_m\big]\Big) = p_{v_1}\,p_{v_2}\,\cdots\,p_{v_m}.$$

Observe that the shift map σ defined on Σ_N^+ satisfies the properties asked for with respect to the topology defined on Σ_N^+ . Further, Σ_N^+ is a compact metric space with topological dimension 0.

We now appeal to Tychonoff and accord some structure on X. For any two points (w, x) and (v, y) in X, we define a metric

$$d_X((w, x), (v, y)) := \max \{d_{\Sigma_N^+}(w, v), |x - y|\}.$$

Thus, we work with the appropriate product topology and the product σ -algebra and the product measure, while we work with X.

6 Various Ruelle operators

Making use of the Ruelle operator, as given in [29] for every $1 \le d \le N$, we define a Ruelle operator for the skew-product map in this section. Later, we consider each of these Ruelle operators to define a collective Ruelle operator for the case of simultaneous action of all these maps.

For every $1 \leq d \leq N$, fix $f \in \mathcal{C}(I,\mathbb{C})$, consider $\mathcal{L}_f^{(d)} : \mathcal{C}(I,\mathbb{C}) \longrightarrow \mathcal{C}(I,\mathbb{C})$ given by

$$\left(\mathcal{L}_f^{(d)}g\right)(x) := \sum_{T_d y = x} e^{f(y)}g(y). \tag{6.1}$$

Observe that this definition entails the following iterative formula given by,

$$\left(\left(\mathcal{L}_f^{(d)}\right)^{\circ n}g\right)(x) := \sum_{T_d^n y = x} e^{f_{(dd\cdots d)}^n(y)}g(y). \tag{6.2}$$

This is the usual Ruelle operator, as defined in [29]. For such an operator $\mathcal{L}_f^{(d)}$, we have the Ruelle operator theorem, as stated in [29].

Theorem 6.1 ([29, 15]) Suppose $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$. Then, the Ruelle operator $\mathcal{L}_f^{(d)}$ has a simple maximal positive eigenvalue, $\rho^{(d)}$. The remainder of the spectrum lies in a disc of radius strictly smaller than $\rho^{(d)}$. The eigenfunction ϕ_d corresponding to the maximal eigenvalue is strictly positive. Further, there exists an eigenmeasure corresponding to the maximal eigenvalue, in the space of all T_d -invariant probability measures supported on I, for the dual operator $\left(\mathcal{L}_f^{(d)}\right)^*$.

Appealing to variational principles studied by several authors including Bowen in [4], Ruelle in [37] and Parry and Pollicott in [29], we know that the maximal eigenvalue for the Ruelle operator $\mathcal{L}_f^{(d)}$, for $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$ can also be described using the *d*-pressure function, *i.e.*, $\rho^{(d)} = e^{\mathcal{P}^{(d)}(f)}$, where

$$\mathcal{P}^{(d)}(f) := \sup \left\{ h_{m^{(d)}}(T_d) + \int f \, dm^{(d)} \right\}.$$

The supremum in the above definition is taken over all T_d -invariant probability measures supported on I and $h_{m^{(d)}}(T_d)$ is the measure theoretic entropy of T_d with respect to the measure $m^{(d)}$. Then, the existence of the unique equilibrium measure, denoted by $m_f^{(d)}$, that realises the supremum in the definition of d-pressure is assured by Denker and Urbanskii in [15]. Further, the variational principle states that this unique equilibrium measure, $m_f^{(d)}$ is equivalent to the eigenmeasure corresponding to the maximal eigenvalue $\rho^{(d)}$ for the dual operator $\left(\mathcal{L}_f^{(d)}\right)^*$, as given in theorem (6.1).

Taking cue from definition (6.1), we define the Ruelle operator for the skew-product setting as follows: Fix $F \in \mathcal{C}(X,\mathbb{C})$ and consider $\mathfrak{L}_F : \mathcal{C}(X,\mathbb{C}) \longrightarrow \mathcal{C}(X,\mathbb{C})$ given by

$$(\mathfrak{L}_F G)((w, x)) := \sum_{T((v, y)) = (w, x)} e^{F((v, y))} G((v, y)). \tag{6.3}$$

It is a simple observation that the iterates of the Ruelle operator \mathfrak{L}_F agrees with the appropriate iterative formula given in (6.2). We merely state the same here.

$$((\mathfrak{L}_F)^{\circ n} G)((w, x)) := \sum_{T^n((v, y)) = (w, x)} e^{F^n((v, y))} G((v, y)).$$

Further, the operator \mathfrak{L}_F satisfies the properties mentioned in the Ruelle operator theorem, as mentioned in theorem (6.1), whenever $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$. We include the statement of the theorem, in the context of the skew-product map, for readers' convenience.

Theorem 6.2 Suppose $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$. Then, the Ruelle operator \mathfrak{L}_F has a simple maximal eigenvalue at $\varrho = e^{\mathfrak{P}(F)}$. The remainder of the spectrum lies in a disc of radius strictly smaller than $e^{\mathfrak{P}(F)}$. The eigenfunction Φ corresponding to the maximal eigenvalue is strictly positive. Further, the eigenmeasure corresponding to the maximal eigenvalue for the dual operator $(\mathfrak{L}_F)^*$ is equivalent to the equilibrium measure μ_F , that realises the supremum in the definition of pressure, as stated in equation (2.3).

Fixing $f \in \mathcal{C}(I,\mathbb{C})$, we now define a third Ruelle operator, denoted by

$$\mathbb{L}_f : \mathcal{C}(I, \mathbb{C}) \longrightarrow \mathcal{C}(I, \mathbb{C}),$$

that captures the idea of simultaneous action of interval maps. Making sense of the n-th iterate of the Ruelle operators $\mathcal{L}_f^{(d)}$ and \mathcal{L}_F that captures the set of all n-th order pre-images of the point where the operator acts and taking the n-th ergodic sum over each of those orbits, we are inclined to define the n-th iterate of the Ruelle operator \mathbb{L}_f acting on a point x by considering those points that would reach x in n steps, by the action of a combination of n many maps from the collection $\{T_1, T_2, \dots, T_N\}$ and taking the n-th ergodic sum dictated by all such n-lettered words. The same can be expressed as

$$((\mathbb{L}_{f})^{\circ n} g)(x) = \sum_{w:|w|=n} \sum_{(T_{w_{n}} \circ T_{w_{n-1}} \circ \cdots \circ T_{w_{1}})y=x} e^{f_{w}^{n}(y)} g(y)$$

$$= \sum_{w_{n}=1}^{N} \cdots \sum_{w_{1}=1}^{N} \sum_{(T_{w_{n}} \circ T_{w_{n-1}} \circ \cdots \circ T_{w_{1}})y=x} e^{f(y)+f(T_{w_{1}}y)+\cdots+f(T_{w_{n-1}} \circ \cdots \circ T_{w_{1}}y)} g(y).$$

This understanding paves the way for us to define the Ruelle operator, in this case as

$$\mathbb{L}_f g(x) := \sum_{d=1}^N \sum_{T_d y = x} e^{f(y)} g(y) = \sum_{d=1}^N \mathcal{L}_f^{(d)} g(x). \tag{6.4}$$

7 Spectrum of the operators \mathfrak{L}_F and \mathbb{L}_f

In this section, we establish a relationship between the Ruelle operators \mathfrak{L}_F and \mathbb{L}_f , as defined in equations (6.3) and (6.4).

Let

$$Q: \mathscr{F}_{\alpha}(I,\mathbb{C}) \longrightarrow \mathscr{F}_{\alpha}(X,\mathbb{C})$$
 be defined as $(Q(f))(w,x) := f(x)$. (7.1)

Then, for any Hölder continuous function $f \in \mathscr{F}_{\alpha}(I, \mathbb{C})$,

$$\begin{aligned}
|Q(f)((w, x)) - Q(f)((v, y))| &= |f(x) - f(y)| \\
&\leq M_f |x - y|^{\alpha} \\
&\leq M_f \left[d_X((w, x), (v, y)) \right]^{\alpha},
\end{aligned}$$

for some $M_f > 0$ and for any $0 < \theta < 1$, on which the metric on Σ_N^+ depends. Thus, the map Q is well defined. Further, the above inequality also proves that the Hölder constant M_f remains unperturbed for the function Q(f) in the product space as well, i.e., $M_f \equiv M_{Q(f)}$. Moreover, it is clear from the definition of the various Ruelle operators that

$$Q(\mathbb{L}_f g) = \mathfrak{L}_{Q(f)}Q(g), \ \forall f, g \in \mathscr{F}_{\alpha}(I,\mathbb{C}).$$

Thus, the action of \mathbb{L}_f is similar to that of the action of $\mathfrak{L}_{Q(f)}$ restricted to the subspace, $\operatorname{Image}(Q) \subseteq \mathscr{F}_{\alpha}(X,\mathbb{C})$. As a consequence, we can relate the spectrum of \mathbb{L}_f and $\mathfrak{L}_{Q(f)}$. The following lemma narrates the same.

Lemma 7.1 For some fixed $f \in \mathscr{F}_{\alpha}(I,\mathbb{C})$, let $\Phi \in \mathscr{F}_{\alpha}(X,\mathbb{C})$ be an eigenfunction of $\mathfrak{L}_{Q(f)}$ with corresponding eigenvalue ϱ , i.e., $\mathfrak{L}_{Q(f)}\Phi = \varrho \Phi$. Then, $\Phi \in \operatorname{Image}(Q) \subset \mathscr{F}_{\alpha}(X,\mathbb{C})$.

Proof: In order to prove this lemma, it is sufficient to prove that the eigenfunction Φ is independent of the first co-ordinate, *i.e.*, $\Phi((v, x)) = \Phi((w, x))$, $\forall v, w \in \Sigma_N^+$ and $x \in [0, 1]$. In fact, we prove that given any $\epsilon > 0$, there exists $M_{\epsilon} \in \mathbb{Z}_+$ such that

$$\left| \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((v, x)) - \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((w, x)) \right| \leq \varrho^{n} \epsilon, \quad \forall n \geq M_{\epsilon}.$$

A mere application of the eigenfunction equation to the above inequality, then yields

$$\varrho^n \Big| \Phi((v, x)) - \Phi((w, x)) \Big| \leq \varrho^n \epsilon, \quad \forall n \geq M_{\epsilon},$$

implying

$$\left| \Phi((v, x)) - \Phi((w, x)) \right| \le \epsilon.$$

The proof is then complete, appealing to the arbitrary choice that we can make for ϵ . Using the definition of the Ruelle operator, we have

$$\left| \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((v, x)) - \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((w, x)) \right|$$

$$= \left| \sum_{u: |u| = n} \left(\sum_{T^{n}((uv, y)) = (v, x)} e^{(Q(f))^{n}(uv, y)} \Phi((uv, y)) - \sum_{T^{n}((uw, y)) = (w, x)} e^{(Q(f))^{n}(uw, y)} \Phi((uw, y)) \right) \right|$$

$$\leq \sum_{u: |u| = n} \sum_{T_{u_{n}} \circ \cdots \circ T_{u_{1}} y = x} \left| e^{f_{u}^{n}(y)} \right| \left| \Phi((uv, y)) - \Phi((uw, y)) \right|$$

$$\leq e^{n \|f\|_{\infty}} M_{\Phi} N^{n} \theta^{n\alpha}$$

$$= \varrho^{n} M_{\Phi} \left(\frac{e^{\|f\|_{\infty}} N \theta^{\alpha}}{\varrho} \right)^{n}.$$

Once we choose the functions f and Φ , observe that the quantities $||f||_{\infty}$ and M_{Φ} are determined. Thus, we can only rely on our choice of θ to make the above estimate, as small as necessary. We therefore fix θ in such fashion that

$$\frac{e^{\|f\|_{\infty}} N \theta^{\alpha}}{\rho} < 1.$$

Further, we remark that we shall use the same θ , so fixed to suit our purpose in the above inequality, in the remainder of this paper. Now, it is clear that we have some threshold, say M_{ϵ} such that

$$\left| \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((v, x)) - \left(\mathfrak{L}_{Q(f)} \right)^{\circ n} \Phi((w, x)) \right| \leq \varrho^{n} \epsilon, \quad \forall n \geq M_{\epsilon}.$$

A careful reader may observe that lemma (7.1) is merely the statement of the Ruelle operator theorem stated for the simultaneous dynamics of finitely many interval maps. In particular, $\Phi \in \operatorname{Image}(Q)$ implies that there exists $\phi \in \mathscr{F}_{\alpha}(I,\mathbb{C})$ such that $Q(\phi) = \Phi$ and $\mathbb{L}_f \phi = \varrho \phi$. Thus, the set of eigenvalues of $\mathfrak{L}_{Q(f)}$ and \mathbb{L}_f remains equal. In particular, the simple maximal eigenvalue ϱ of $\mathfrak{L}_{Q(f)}$ is also the simple maximal eigenvalue of \mathbb{L}_f .

8 Normalising the operators $\mathcal{L}_f^{(d)}, \; \mathfrak{L}_F$ and \mathbb{L}_f

For technical convenience, we normalise the Ruelle operators $\mathcal{L}_f^{(d)}$, $\mathfrak{L}_{Q(f)}$ and \mathbb{L}_f , in different ways that would suit our purposes to prove the main theorems.

For any $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$, we define the normalised Ruelle operator by considering the Ruelle operator, as defined in (6.1), corresponding to the function

$$\widetilde{f}_d := f + \log \phi_d - \log \phi_d \circ T_d - \mathcal{P}^{(d)}(f),$$

where ϕ_d is the eigenfunction corresponding to the maximal eigenvalue of the operator $\mathcal{L}_f^{(d)}$. Thus,

$$\widetilde{\mathcal{L}}_f^{(d)} \mathbf{1}(x) := \mathcal{L}_{\widetilde{f}_d}^{(d)} \mathbf{1}(x) = \mathbf{1}(x).$$

For any $f \in \mathscr{F}_{\alpha}(I, \mathbb{R})$, we define the normalised Ruelle operator in the skew-product setting by considering the Ruelle operator, as defined in (6.3), corresponding to the function

$$\widetilde{Q(f)} := Q(f) + \log \Phi - \log \Phi \circ T,$$

where Φ is the eigenfunction corresponding to the maximal eigenvalue $\varrho = e^{\mathfrak{P}(Q(f))}$ of the operator $\mathfrak{L}_{Q(f)}$. Thus, this normalisation effects the eigenfunction of the normalised operator to be equal to the constant function 1, however, leaves the maximal eigenvalue ϱ unchanged, *i.e.*,

$$\widetilde{\mathfrak{L}}_{Q(f)} \mathbf{1}((w, x)) := \mathfrak{L}_{\widetilde{Q(f)}} \mathbf{1}((w, x)) = \varrho \mathbf{1}((w, x)).$$

In particular, the operator $\varrho^{-1}\widetilde{\mathfrak{L}}_{Q(f)}$ has 1 as its maximal eigenvalue with corresponding eigenfunction 1. Further, since by definition, Q(f) and $\widetilde{Q(f)}$ are cohomologous to each other, their ergodic sums are preserved.

Further, once we normalise the operators $\mathcal{L}_f^{(d)}$ and $\mathfrak{L}_{Q(f)}$ as prescribed, we also observe that the equilibrium measure with respect to the Hölder continuous functions $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$ for the map T_d and $Q(f) \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ for the skew-product map T, namely $m_f^{(d)}$ and $\mu_{Q(f)}$ are nothing but the eigenmeasures corresponding to the maximal eigenvalues of the normalised operators $\widetilde{\mathcal{L}}_f^{(d)}$ and $\varrho^{-1}\widetilde{\mathfrak{L}}_{Q(f)}$ respectively. Thus, we use the notations $m_f^{(d)}$ and $\mu_{Q(f)}$ for the equilibrium measure, as well as the eigenmeasure corresponding to the maximal eigenvalue of the normalised operators $\widetilde{\mathcal{L}}_f^{(d)}$ as well as $\varrho^{-1}\widetilde{\mathfrak{L}}_{Q(f)}$, respectively.

Moreover, we define the normalised operator in the setting of simultaneous dynamics thus: For any $f \in \mathscr{F}_{\alpha}(I, \mathbb{R})$, let

$$\widetilde{\mathbb{L}}_f g(x) := \frac{1}{\phi(x)} \mathbb{L}_{f + \log \phi} g(x) = \frac{1}{\phi(x)} \sum_{d=1}^N \sum_{T_d y = x} e^{f(y) + \log \phi(y)} g(y),$$

where ϕ is the strictly positive eigenfunction corresponding to the maximal eigenvalue of the operator \mathbb{L}_f , that we denote by $e^{\mathbb{P}(f)}$, where $\mathbb{P}(f)$ is the *pressure* of the function f, in this setting. It must be noted that this normalisation does not change the maximal eigenvalue, but has an effect on the corresponding eigenfunction, making it to be 1. Further, this normalisation also takes a toll in this setting; $\widetilde{\mathbb{L}}_f$ is no longer a Ruelle operator, but merely a bounded linear operator.

The operator $Q: \mathcal{C}(I,\mathbb{C}) \longrightarrow \mathcal{C}(X,\mathbb{C})$, as defined in (7.1), has a natural transpose

$$Q^* : \mathcal{C}^*(X,\mathbb{C}) \longrightarrow \mathcal{C}^*(I,\mathbb{C}).$$

On a restricted space, this transpose gives us the map,

 $Q^*: \{\mu : \mu \text{ is a probability measure on } X\} \longrightarrow \{\mathfrak{m} : \mathfrak{m} \text{ is a probability measure on } I\},$ defined by

$$\int f d(Q^* \mu) := \int Q(f) d\mu, \quad \forall f \in \mathcal{C}(I, \mathbb{C}).$$

For $f \in \mathscr{F}_{\alpha}(X,\mathbb{R})$, we define $\mathfrak{m}_f := Q^*(\mu_{Q(f)})$, thereby,

$$\int_{I} g \, d\mathfrak{m}_{f} = \int_{X} Q(g) \, d\mu_{Q(f)}, \quad \forall g \in \mathscr{F}_{\alpha}(I, \mathbb{R}).$$

Thus, it is an easy observation that as a consequence of the definitions of \mathfrak{m}_f and $\widetilde{\mathbb{L}}_f$, \mathfrak{m}_f coincides with the eigenmeasure corresponding to maximal eigenvalue of the operator $e^{-\mathbb{P}(f)}\left(\widetilde{\mathbb{L}}_f\right)^*$.

In the sequel, we will be interested in a complex perturbation of the operators $\widetilde{\mathfrak{L}}_{Q(f)}$ and $\widetilde{\mathbb{L}}_f$ for $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$, *i.e.*, for $\zeta = \kappa + i\xi \in \mathbb{C}$, we consider the operators $\mathfrak{L}_{\kappa Q(f)}$ and $\mathbb{L}_{\kappa f}$, normalise the same as explained above respectively and then perturb the operator. We denote them respectively by $\widetilde{\mathfrak{L}}_{\zeta Q(f)}$ and $\widetilde{\mathbb{L}}_{\zeta f}$. We conclude this section with a few lemmas that provide a bound on the operator norm for the iterates of the normalised, yet perturbed operators.

Lemma 8.1 ([29]) For any $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$, there exists a positive constant $C_5 > 0$, such that for every $n \geq 0$, and any $G \in \mathscr{F}_{\alpha}(X,\mathbb{C})$, we have

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_{\zeta F} \right)^{\circ n} G \right\|_{\alpha} \geq C_5 |\xi| \left\| G \right\|_{\infty} + \alpha^n |G|_{\alpha}.$$

Lemma 8.2 ([33]) Let $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ satisfy the approximability condition, as mentioned in equations (4.1) and (4.2) of theorem (4.2). Then, there exists positive constants C_6 , C_7 and C_8 such that

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_{\zeta F} \right)^{\circ (2nR)} \right\| \leq C_6 |\xi| \left(1 - \frac{1}{|\xi|^{C_7}} \right)^{n-1}, \quad \forall n \geq 1,$$

where $|\xi|$ is sufficiently large and R is the greatest integer contained in $C_8 \log |\xi|$.

We conclude this section with a lemma that provides a bound on the operator norm for the iterates of the normalised, but perturbed operator $\widetilde{\mathbb{L}}_{\zeta f}$, for some $f \in \mathscr{F}_{\alpha}(I,\mathbb{R})$. We also include a short proof of the same, for readers' convenience.

Lemma 8.3 Let $f \in \mathscr{F}_{\alpha}(I, \mathbb{R})$ satisfy the approximability condition, as mentioned in equation (4.6) of theorem (4.7). Let $\zeta = \kappa + i\xi \in \mathbb{C}$. Then, there exists positive constants C_9 , C_{10} and C_{11} such that

$$\left\| \left(e^{-\mathbb{P}(\kappa f)} \widetilde{\mathbb{L}}_{\zeta f} \right)^{\circ (2nR)} \right\| \leq C_9 |\xi| \left(1 - \frac{1}{|\xi|^{C_{10}}} \right)^{n-1}, \quad \forall n \geq 1,$$

where $|\xi|$ is sufficiently large and R is the greatest integer contained in $C_{11} \log |\xi|$.

Proof: Given $f \in \mathscr{F}_{\alpha}(I, \mathbb{R})$ that satisfies the approximability condition, it is an easy observation that $Q(f) \in \mathscr{F}_{\alpha}(X, \mathbb{R})$ satisfies the appropriate approximability condition. Thus, lemma (8.2) comes to our rescue. Further, from the definitions of the operators as stated in (6.3) and (6.4), we obtain that

$$\left\| \left(\widetilde{\mathbb{L}}_{\zeta f} \right)^{\circ n} \right\| \leq \left\| \left(\widetilde{\mathfrak{L}}_{\zeta Q(f)} \right)^{\circ n} \right\| \quad \forall n \geq 1.$$
 (8.1)

9 Proof of the ergodicity theorems

In this section, we prove the ergodicity theorems as stated in (4.1) for the skew-product setting and (4.6) for the simultaneous dynamics setting.

Proof of Theorem (4.1): Let $B \subseteq X$ be a completely T-invariant set in the σ -algebra of X with strictly positive measure, i.e., $\mu(B) > 0$. As said earlier in section (2), a natural candidate for μ is the product measure of the Bernoulli measure on cylinder sets of Σ_N^+ and the Lebesgue measure on open intervals of I. Since we have assumed that the set B is completely T-invariant, i.e., $T^{-1}B = B$ with strictly positive measure, it is sufficient for us to show that $\mu(B) = 1$, to prove the theorem.

It is easy to observe that, in its most general form, the set B can be expressed as

$$B = \bigcup_{j \ge 1} (U_j \times V_j),$$

Page 18

where U_j 's are cylinder sets in Σ_N^+ and V_j 's are open subsets of I. Let $U \times V \subseteq B$ be a product set in this collection where $U = \begin{bmatrix} v_1 v_2 \cdots v_n \end{bmatrix}$ and $V \subseteq I$ is an open set. Since B is completely T-invariant, we have $U \times V \subseteq T^{-1}B$. Thus, there exists B' in the σ -algebra of X such that $B' \subseteq B$ and $U \times V \subseteq T^{-1}(B')$. For the smallest such subset B', the countably many possibilities for the form of B' are given by

$$(0) \left[v_2 \, v_3 \, \cdots \, v_n \right] \times V';$$

$$(1) \bigcup_{d=1}^{N} \left(\left[v_2 \, v_3 \, \cdots \, v_n \, d \right] \times V_d' \right);$$

(2)
$$\bigcup_{d_1=1}^{N} \bigcup_{d_2=1}^{N} \left(\left[v_2 \, v_3 \, \cdots \, v_n \, d_1 \, d_2 \right] \times V'_{(d_1 \, d_2)} \right);$$

$$(\cdot)$$
 \cdots .

It is clear that in the above enumeration of possibilities, the cylinder sets in all cases starting from (1) onwards are subsumed by the cylinder set in case (0). Suppose we also prove that the appropriate open subsets of I in each of the possibilities starting from case (1) are subsumed by the open subset of I in case (0), it is sufficient to merely work with case (0). For the same purpose, we consider the general case (m), as listed in the above possibilities, namely,

(m)
$$\bigcup_{d_1=1}^{N} \bigcup_{d_2=1}^{N} \cdots \bigcup_{d_m=1}^{N} \left(\left[v_2 \, v_3 \, \cdots \, v_n \, d_1 \, d_2 \, \cdots \, d_m \right] \times V'_{(d_1 \, d_2 \, \cdots \, d_m)} \right).$$

Observe that

$$U \times V \subseteq T^{-1}B'$$

$$= T^{-1} \left(\bigcup_{d_{1}=1}^{N} \bigcup_{d_{2}=1}^{N} \cdots \bigcup_{d_{m}=1}^{N} \left(\left[v_{2} v_{3} \cdots v_{n} d_{1} d_{2} \cdots d_{m} \right] \times V'_{(d_{1} d_{2} \cdots d_{m})} \right) \right)$$

$$= \bigcup_{d_{1}=1}^{N} \bigcup_{d_{2}=1}^{N} \cdots \bigcup_{d_{m}=1}^{N} \left(T^{-1} \left(\left[v_{2} v_{3} \cdots v_{n} d_{1} d_{2} \cdots d_{m} \right] \times V'_{(d_{1} d_{2} \cdots d_{m})} \right) \right)$$

$$= \bigcup_{d_{1}=1}^{N} \bigcup_{d_{2}=1}^{N} \cdots \bigcup_{d_{m}=1}^{N} \left(\bigcup_{d=1}^{N} \left(\left[d v_{2} v_{3} \cdots v_{n} d_{1} d_{2} \cdots d_{m} \right] \times T_{d}^{-1} V'_{(d_{1} d_{2} \cdots d_{m})} \right) \right). \tag{9.1}$$

However, since $U = [v_1 \ v_2 \cdots v_n]$, the only possibility in the right hand side of the countable union in equation (9.1) where $U \times V$ can be a subset reduces to

$$U \times V \subseteq \bigcup_{d_1=1}^{N} \bigcup_{d_2=1}^{N} \cdots \bigcup_{d_m=1}^{N} \left(\left[v_1 \, v_2 \, v_3 \, \cdots \, v_n \, d_1 \, d_2 \, \cdots \, d_m \right] \times T_{v_1}^{-1} V'_{(d_1 \, d_2 \, \cdots \, d_m)} \right).$$

The above union is over sets that are disjoint with respect to their first component and thus $V \subseteq T_{v_1}^{-1}V'_{(d_1\,d_2\,\cdots\,d_m)}$, for any *m*-lettered word $(d_1\,d_2\,\cdots\,d_m)$. Now using minimality of

the set B', we observe that the set $V'_{(d_1 d_2 \cdots d_m)}$ remains independent of the m-lettered word $(d_1 d_2 \cdots d_m)$. Hence, $B' = [v_2 v_3 \cdots v_n] \times V'$, as mentioned in case (0).

Based on our observation that for every $U \times V = U_0 \times V_0 \subseteq B$, there exists a $B_1 = U_1 \times V_1 \subseteq B$ that satisfies $U_0 \times V_0 \subseteq T^{-1}(U_1 \times V_1)$, we obtain a sequence of sets $(U_k \times V_k)$ that satisfy, $(U_{k-1} \times V_{k-1}) \subseteq T^{-1}(U_k \times V_k)$. However, this process must end in a finite number of steps, precisely n, since U_0 is a cylinder set that fixes only n many positions. Thus, after those finitely many steps, we obtain $\Sigma_N^+ \times V_n \subseteq B$ for some open subset $V_n \subseteq I$ with strictly positive Lebesgue measure, i.e., $\lambda(V_n) > 0$.

Choose the maximal subset $V \subseteq I$ such that $\Sigma_N^+ \times V \subseteq B$, *i.e.*, suppose there exists a subset $V' \subseteq I$ such that $\Sigma_N^+ \times V' \subseteq B$ then, $V' \subseteq V$. For such a maximal subset $V \subseteq I$, consider $[w] \times V$ for some choice of $w \in \{1, 2, \dots, N\}$. It is obvious that $[w] \times V \subseteq \Sigma_N^+ \times V$. Then, there exists a $V' \subseteq I$ such that

$$[w] \times V \subseteq T^{-1}(\Sigma_N^+ \times V') = \bigcup_{d=1}^N ([d] \times T_d^{-1}V'). \tag{9.2}$$

Arguing as earlier, we reduce the countable union in the right hand side of equation (9.2) to

$$[w] \times V \subseteq [w] \times T_w^{-1} V'.$$

However, owing to the maximality of V, we have $V' \subseteq V$ that implies $T_w^{-1}V' \subseteq T_w^{-1}V$. Thus,

$$[w] \times V \subseteq [w] \times T_w^{-1} V' \subseteq [w] \times T_w^{-1} V.$$

This implies $V \subseteq T_w^{-1}V$ for any choice of $w \in \{1, 2, \dots, N\}$. However, each of these interval maps preserves the Lebesgue measure, *i.e.*, $\lambda(V) = \lambda(T_w^{-1}V)$ for all $w \in \{1, 2, \dots, N\}$. Thus, by eliminating an appropriate set of Lebesgue measure zero from V, we obtain \widetilde{V} that satisfies $\widetilde{V} = T_w^{-1}\widetilde{V}$ for all $w \in \{1, 2, \dots, N\}$. Finally, we appeal to the ergodicity of each of these interval maps T_w to conclude that the completely T_w -invariant set \widetilde{V} for all w of strictly positive measure must be of Lebesgue measure 1.

Thus, the completely T-invariant set B that satisfies $\mu(B) > 0$ has measure 1, thereby completing the proof of theorem (4.1).

Remark 9.1 The above proof, in fact provides a stronger result than is stated in theorem (4.1), namely, for any set B in the σ -algebra of X that is completely T-invariant, meaning $T^{-1}B = B$, we have either $\mu(B) = 0$ or B can be expressed as $\Sigma_N^+ \times \widetilde{V}$ where \widetilde{V} is a set of full Lebesgue measure in I, i.e., $\lambda\left(\widetilde{V}\right) = 1$.

We now prove the ergodic theorem for simultaneous action of finitely many interval maps, as stated in theorem (4.6).

Proof of Theorem (4.6): For a Lebesgue integrable real-valued function f defined on I, define $F := Q(f) \in L^1(\mu)$, where μ is the product measure of the Bernoulli measure on the

cylinder sets of Σ_N^+ and the Lebesgue measure on the open intervals of I. Define

$$E := \left\{ (w, x) \in X : \liminf_{n \to \infty} \frac{1}{n} \sum_{j=0}^{n-1} \mathscr{Q}^j(F)(w, x) = \limsup_{n \to \infty} \frac{1}{n} \sum_{j=0}^{n-1} \mathscr{Q}^j(F)(w, x) = \int F d\mu \right\}.$$

One can easily observe that E is a T-invariant subset of X. Thus, $\mu(E)$ is either zero or one, by theorem (4.1). The set of points collected in E is the set of all points in X that satisfies the Birkhoff's pointwise ergodic theorem to the dynamical system T acting on X. Hence, $\mu(E) = 1$. Further, from remark (9.1), we have that $E = \Sigma_N^+ \times E'$, where $\lambda(E') = 1$. Hence, we now have for λ -almost every $x \in I$ and for every $w \in \Sigma_N^+$,

$$\lim_{n \to \infty} \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(w, x) = \int F d\mu.$$

Claim 9.2 For a fixed $x_0 \in E'$, given $\epsilon > 0$, there exists $M_{\epsilon} \in \mathbb{N}$, independent of w, such that for all $n \geq M_{\epsilon}$, we have

$$\left| \lim_{n \to \infty} \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(w, x_{0}) - \int F d\mu \right| < \epsilon, \quad \forall w \in \Sigma_{N}^{+}.$$

We initially prove the theorem, assuming claim (9.2) to be true. We shall prove the claim immediately thereafter. From the definition of the composition operators, we have for any arbitrary $\epsilon > 0$, there exists $M_{\epsilon} \in \mathbb{N}$ such that for every $n \geq M_{\epsilon}$,

$$\left| \frac{1}{n} f_w^n(x) - \int_0^1 f \, d\lambda \right| \le \epsilon$$
, for λ -a.e. $x \in I$ and $\forall w = (w_1 \, w_2 \, \cdots \, w_n)$.

This implies

$$\left| \sum_{w: |w|=n} \left(\frac{1}{n} f_w^n(x) - \int_0^1 f \, d\lambda \right) \right| \leq N^n \epsilon.$$

Thus,

$$\left| \frac{1}{n} \frac{1}{N^n} \sum_{w : |w| = n} f_w^n(x) - \int_0^1 f \, d\lambda \right| \leq \epsilon, \text{ for } \lambda \text{-a.e. } x \in I,$$

proving the theorem.

We now complete this section, by proving the claim in (9.2).

Proof of Claim (9.2): For a fixed $x_0 \in E'$, consider the sequence $\left\{\frac{1}{n}\sum_{j=0}^{n-1}\mathcal{Q}^j(F)(w, x_0)\right\}_{n\geq 1}$

of functions defined on the compact space Σ_N^+ , converging to the constant $\int F d\mu$. This convergence is uniform over $w \in \Sigma_N^+$, *i.e.*, given any $\epsilon > 0$, there exists $M_1 = M_1(\epsilon)$ such that for all $n > M_1$, we have

$$\left| \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(w, x_{0}) - \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(v, x_{0}) \right| \leq \frac{\epsilon}{2}, \quad \forall w, v \in \Sigma_{N}^{+}.$$
 (9.3)

We already know that for some fixed $v \in \Sigma_N^+$, there exists $M_2 = M_2(\epsilon, v)$ such that for all $n > M_2$, we have

$$\left| \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^j(F)(v, x_0) - \int F d\mu \right| \leq \frac{\epsilon}{2}. \tag{9.4}$$

Taking $M_3 := \max\{M_1, M_2\}$ where M_1 and M_2 are the quantities prescribed by equations (9.3) and (9.4), we get for all $n > M_3$ and $w \in \Sigma_N^+$,

$$\left| \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(w, x_{0}) - \int F d\mu \right|$$

$$\leq \left| \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(w, x_{0}) - \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(v, x_{0}) \right| + \left| \frac{1}{n} \sum_{j=0}^{n-1} \mathcal{Q}^{j}(F)(v, x_{0}) - \int F d\mu \right|$$

$$\leq \epsilon.$$

It is clear from the definition that M_3 is independent of the word w and only dependent on ϵ and x_0 .

10 Rates of recurrence

In this section, we write the proofs of theorems (4.2) and (4.7). Throughout this section, we work with a fixed $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$, along with the corresponding normalised operator $\varrho^{-1}\widetilde{\mathfrak{L}}_F$ with equilibrium measure μ_F . We know that the iterates of this operator obey the result given in lemma (8.2). Further, for some $\zeta = \kappa + i\xi \in \mathbb{C}$, we note that the pressure function associated with the operator $\mathfrak{L}_{\zeta F}$ and its normalised version $\widetilde{\mathfrak{L}}_{\zeta F}$ are one and the same, owing to the definition of pressure and the method of normalisation.

The following lemma gives an approximation for the eigenvalue of the normalised yet perturbed operator, $\widetilde{\mathfrak{L}}_{\zeta F}$. We urge the reader to observe that the statement of the lemma and hence, its proof, are merely mentioned for a change of variables along the imaginary variable, even though more is true, as one may obtain from, say [32].

Lemma 10.1 For $\zeta = \kappa + i\xi$, there exists a change of variables $\Upsilon = \Upsilon(\xi)$ such that for $|\xi| < \delta$, we can expand

$$e^{\mathfrak{P}(\zeta F)} = e^{\mathfrak{P}(\kappa F)} \left(1 - \Upsilon^2 + i \Theta(\Upsilon) \right),$$

where Θ is a real-valued function that satisfies $\Theta(\Upsilon) = O(|\Upsilon|^3)$.

Proof: By perturbation theory, we know that there exists $\delta > 0$ such that, for $G \in \mathscr{F}_{\alpha}(X,\mathbb{C})$ satisfying $\|G - \kappa F\|_{\alpha} < \delta$,

$$G \longmapsto \mathfrak{P}(G)$$
 is an analytic map. (10.1)

The analyticity of the above map from the Banach space $\mathscr{F}_{\alpha}(X,\mathbb{C})$ to \mathbb{C} , in a neighbourhood of κF assures the existence of a linear map, say $\mathfrak{D}:\mathscr{F}_{\alpha}(X,\mathbb{C})\longrightarrow\mathbb{C}$ such that

$$\lim_{G \to \kappa F} \frac{\mathfrak{P}(G) - \mathfrak{P}(\kappa F) - \mathfrak{D}(G - \kappa F)}{\|G - \kappa F\|_{\alpha}} = 0,$$

where \mathfrak{D} is the differential of \mathfrak{P} at κF . From equation (3.2), we have for $\xi \in \mathbb{R}$,

$$\lim_{\xi \to 0} \frac{\mathfrak{P}((\kappa + \xi)F) - \mathfrak{P}(\kappa F) - \mathfrak{D}(\xi F)}{\|\xi F\|_{\alpha}} = 0,$$

for the choice

$$\frac{\mathfrak{D}(F)}{\|F\|_{\alpha}} = \frac{d}{d\xi} \mathfrak{P}((\kappa + \xi)F) \Big|_{\xi = 0} = \int F \, d\mu_{\kappa F}.$$

Since \mathfrak{D} is linear, we get

$$\frac{d}{d\xi}\mathfrak{P}\big((\kappa+i\xi)F\big)\bigg|_{\xi=0} = \lim_{\xi\to 0} \frac{\mathfrak{D}\big(i\xi F\big)}{\|i\xi F\|_{\alpha}} = i\lim_{\xi\to 0} \frac{\mathfrak{D}\big(\xi F\big)}{\|\xi F\|_{\alpha}} = \int iF \,d\mu_{\kappa F} = 0.$$

Similarly from equation (3.3) we have for $\xi \in \mathbb{R}$,

$$\left.\frac{d^2}{d\xi^2}\mathfrak{P}\big((\kappa+\xi)F\big)\right|_{\xi\,=\,0} \ = \ \lim_{n\,\to\,\infty}\frac{1}{n}\int\!\Big(F^n((w,\,x))\Big)^2\,d\mu_{\kappa F}.$$

This implies

$$\left. \frac{d^2}{d\xi^2} \mathfrak{P} \big((\kappa + i\xi) F \big) \right|_{\xi = 0} = \lim_{n \to \infty} \frac{1}{n} \int \left(iF^n \right)^2 d\mu_{\kappa F} = \lim_{n \to \infty} \frac{-1}{n} \int \left(F^n \right)^2 d\mu_{\kappa F} < 0.$$

Since $G \mapsto \mathfrak{P}(G)$ is an analytic map, as mentioned in (10.1), we have the map $\zeta \mapsto \mathfrak{P}(\zeta F)$ to be analytic too in a neighbourhood of κ , where $\zeta = \kappa + i\xi \in \mathbb{C}$. This implies that $\operatorname{Im}(\mathfrak{P}(\zeta F))$ is a harmonic function around κ , *i.e.*, for $\xi \in \mathbb{R}$,

$$\left. \frac{d^2}{d\xi^2} \mathrm{Im} \big(\mathfrak{P}((\kappa + \xi)F) \big) \right|_{\xi = 0} = \left. \frac{d^2}{d\xi^2} \mathrm{Im} \big(\mathfrak{P}((\kappa + i\xi)F) \big) \right|_{\xi = 0}.$$

We know that for $\xi \in \mathbb{R}$, $\mathfrak{P}((\kappa + \xi)F) \in \mathbb{R}$, *i.e.*,

$$\frac{d^2}{d\xi^2} \operatorname{Im} (\mathfrak{P}((\kappa + \xi)F)) \Big|_{\xi = 0} = 0 \implies \frac{d^2}{d\xi^2} \operatorname{Im} (\mathfrak{P}((\kappa + i\xi)F)) \Big|_{\xi = 0} = 0.$$

Thus we have

$$\frac{d}{d\xi} \mathfrak{P}((\kappa + i\xi)F) \Big|_{\xi=0} = 0;$$

$$\frac{d^2}{d\xi^2} \operatorname{Re} \left(\mathfrak{P}((\kappa + i\xi)F) \right) \Big|_{\xi=0} < 0;$$

$$\frac{d^2}{d\xi^2} \operatorname{Im} \left(\mathfrak{P}((\kappa + i\xi)F) \right) \Big|_{\xi=0} = 0.$$

Thus, the map $\xi \longmapsto \operatorname{Re} \left(\mathfrak{P} \left((\kappa + i \xi) F \right) \right)$ satisfies the hypothesis of Morse lemma for non degenerate critical points. Thus, similar to lemma (4) in [32] that has been derived in an analogous context as lemma (6) in [40], we obtain a change of variables $\Upsilon = \Upsilon(\xi)$ for $-\delta < \xi < \delta$ such that

$$e^{\mathfrak{P}((\kappa+i\xi)F)} = e^{\mathfrak{P}(\kappa F)}(1 - \Upsilon^2 + i\Theta(\Upsilon)),$$

where $\Theta(\Upsilon(\xi)) = e^{-\mathfrak{P}(\kappa F)} \operatorname{Im}\left(e^{\mathfrak{P}\left((\kappa + i\xi)F\right)}\right)$ and $\Theta(\Upsilon) = O(|\Upsilon|^3)$, thus proving the lemma.

We now start by considering the left hand side of equation (4.3), as mentioned in theorem (4.2), that measures the cardinality of the set

$$\Big\{(w, x) \in \operatorname{Fix}_n(T) : a \le F^n((w, x)) \le b\Big\}.$$

It is clear that it can be expressed in terms of the indicator function, $\chi_{[a,b]}$, i.e.,

$$\#\Big\{(w, x) \in \operatorname{Fix}_n(T) : a \leq F^n((w, x)) \leq b\Big\} = \sum_{(w, x) \in \operatorname{Fix}_n(T)} \chi_{[a, b]}\Big(F^n((w, x))\Big).$$

Since we know that any characteristic function can be approximated by a sequence of smooth functions with compact support under the integral norm, we initially prove a slightly modified result, as stated in proposition (10.2), where the indicator function $\chi_{[a,b]}$ is replaced by some smooth function with compact support, say $\tau : \mathbb{R} \longrightarrow \mathbb{R}$.

Proposition 10.2 Suppose $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ satisfies the hypothesis in theorem (4.2), i.e., F satisfies the approximability condition and there exists a unique real number κ such that $\int F d\mu_{\kappa F} = 0$. Then, there exists a positive constant $C_{12} > 0$ such that

$$F_{\tau}(n) := \sum_{(w,x) \in \operatorname{Fix}_{n}(T)} \tau \Big(F^{n}((w,x)) \Big) \sim C_{12} \frac{e^{n \mathfrak{P}(\kappa F)}}{\sqrt{n}} \int_{\mathbb{R}} \tau(t) e^{-\kappa t} dt.$$

Proof: For $y \in \mathbb{R}$ and κ as in the hypothesis, define

$$\tau_{\kappa}(y) := \tau(y)e^{-\kappa y}, \tag{10.2}$$

in order that $F_{\tau}(n)$ can now be expressed as

$$F_{\tau}(n) = \sum_{(w,x) \in \operatorname{Fix}_{n}(T)} \tau_{\kappa} \left(F^{n}((w,x)) \right) e^{\kappa F^{n}((w,x))}. \tag{10.3}$$

Using inverse Fourier transform and Fubini's theorem, we rewrite equation (10.3) as

$$F_{\tau}(n) = \sum_{(w,x) \in \operatorname{Fix}_{n}(T)} \int_{\mathbb{R}} \widehat{\tau}_{\kappa}(\xi) e^{(\kappa + i\xi) F^{n}((w,x))} d\xi$$
$$= \int_{\mathbb{R}} \widehat{\tau}_{\kappa}(\xi) \sum_{(w,x) \in \operatorname{Fix}_{n}(T)} e^{(\kappa + i\xi) F^{n}((w,x))} d\xi.$$

By definition, τ_{κ} lives inside a compact support. Hence, by an application of the Paley-Wiener theorem, we deduce that it is sufficient to estimate

$$\sum_{(w,x)\in \operatorname{Fix}_n(T)} e^{(\kappa+i\xi) F^n((w,x))}, \text{ for some } \xi \in \mathbb{R}.$$

The following lemma, from [36] helps us approximate this sum in terms of the iterates of the appropriate normalised operator such that

$$\widetilde{\mathfrak{L}}_{\kappa F} \mathbf{1} = \varrho \mathbf{1}$$
 where we recall $\varrho = e^{\mathfrak{P}(\kappa F)}$.

Lemma 10.3 Let $\kappa \in \mathbb{R}$ be the unique real number that satisfies $\int F d\mu_{\kappa F} = 0$. Then, there exists $0 < \eta < \varrho^{-1}$ such that for every point $(w, x) \in \operatorname{Fix}_n(T)$, we have

$$\sum_{(v,y)\in\operatorname{Fix}_n(T)} e^{(\kappa+i\xi)F^n((v,y))} = \left(\left(\widetilde{\mathfrak{L}}_{(\kappa+i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w,x)) \left(1 + O\left(n\eta^n \max\left\{1, |\xi|\right\}\right) \right).$$

Using the above lemma, we write $F_{\tau}(n)$ as

$$F_{\tau}(n) = \int_{\mathbb{R}} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa + i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) \left(1 + O\left(n\eta^{n} \max\left\{ 1, |\xi| \right\} \right) \right) d\xi. \quad (10.4)$$

The second term in the above equation is dominated by $(\varrho\eta)^n$, which converges to zero faster than any polynomial of n. In the remainder of the proof, we estimate the first term of equation (10.4).

If $\Xi_{\zeta F}: \mathscr{F}_{\alpha}(X,\mathbb{C}) \longrightarrow \mathscr{F}_{\alpha}(X,\mathbb{C})$ is the one-dimensional eigenprojection associated with $\widetilde{\mathfrak{L}}_{\zeta F}$, for $-\delta < \xi < \delta$, we know by perturbation theory that $\Xi_{\zeta F}(\mathbf{1}) = \mathbf{1} + O(|\Upsilon|)$. Thus, by perturbation theory and lemma (10.1), for $-\delta < \xi < \delta$ and some $0 < \vartheta < 1$, we obtain

$$\left(\widetilde{\mathfrak{L}}_{\zeta F}\right)^{\circ n} \mathbf{1} = e^{n\mathfrak{P}(\zeta F)} \left(1 + O\left(\left|\Upsilon\right|\right)\right) + O(\vartheta^{n})
= e^{n\mathfrak{P}\left(\kappa F\right)} \left(1 - \Upsilon^{2} + i\Theta\left(\Upsilon\right)\right)^{n} \left(1 + O\left(\left|\Upsilon\right|\right)\right) + O(\vartheta^{n}).$$

The above equation facilitates the splitting of the integral in equation (10.4) into two integrals given by,

$$\int_{\mathbb{R}} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa+i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) d\xi = \int_{|\xi| < \delta} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa+i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) d\xi + \int_{|\xi| \ge \delta} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa+i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) d\xi. \tag{10.5}$$

We first estimate the first integral in equation (10.5), using the change in variables from lemma (10.1).

$$\int_{|\xi| < \delta} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa + i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) d\xi$$

$$= \int_{|\xi| < \delta} e^{n\mathfrak{P}(\kappa F)} \left(1 - \Upsilon^{2} + i\Theta(\Upsilon) \right)^{n} \left(1 + O(|\Upsilon|) \right) \left(\widehat{\tau_{\kappa}}(\xi(\Upsilon)) \right) \frac{d\xi}{d\Upsilon} d\Upsilon + O(\vartheta^{n})$$

$$= C_{13} \widehat{\tau_{\kappa}}(0) e^{n\mathfrak{P}(\kappa F)} \int_{|\xi| < \delta} \left(1 - \Upsilon^{2} + i\Theta(\Upsilon) \right)^{n} \left(1 + O(|\Upsilon|) \right) d\Upsilon + O(n^{-1}) + O(\vartheta^{n}), \tag{10.6}$$

where $C_{13} > 0$ is a constant dependent on τ_{κ} and the Jacobian of change of variables. We now apply binomial expansion to the expression in the integral of equation (10.6), thus splitting it into three parts and define them as follows:

$$I_{0}(n) := \int_{-\delta}^{\delta} (1 - \Upsilon^{2})^{n} d\Upsilon;$$

$$\sum_{j=1}^{n} I_{j}(n) := \left| \sum_{j=1}^{n} \binom{n}{j} \int_{-\delta}^{\delta} (1 - \Upsilon^{2})^{n-j} (i\Theta(\Upsilon))^{j} (1 + O(|\Upsilon|)) d\Upsilon \right|;$$

$$J(n) := \int_{-\delta}^{\delta} (1 - \Upsilon^{2})^{n} O(|\Upsilon|) d\Upsilon.$$

Using techniques from [32], we estimate the above integrals to get the following inequalities.

$$I_{0}(n) = C_{14} \frac{\Gamma(n+1)}{\Gamma(n+1+\frac{1}{2})} + O((1-\delta^{2})^{n})$$

$$\sum_{j=1}^{n} I_{j}(n) \leq C_{15} \frac{\Gamma(n+1)}{\Gamma(n+1+\frac{1}{2})} \frac{1}{\sqrt{n}}$$

$$|J(n)| \leq C_{16} \frac{\Gamma(n+1)}{\Gamma(n+2)},$$

for some positive constants C_{14} , C_{15} and C_{16} . We now use the identity,

$$\lim_{n \to \infty} \frac{\Gamma(n+\beta)}{\Gamma(n)n^{\beta}} = 1,$$

to conclude that $I_0(n) \sim \frac{1}{\sqrt{n}}C_{14}$ and that the rest of the terms inside the integral in equation (10.6) converge to zero faster than $\frac{1}{\sqrt{n}}$.

What remains now is the integral in equation (10.5) over $|\xi| \geq \delta$. For that, we make use of the following lemma, which is a standard result in the theory of Fourier transforms.

Lemma 10.4 Let $\chi : \mathbb{R} \longrightarrow \mathbb{R}$ be a compactly supported C^r function. Then the Fourier transform $\widehat{\chi}(\xi) = O(|\xi|^{-r})$ as $\xi \to \infty$.

Since τ_{κ} is smooth, we may suppose that τ_{κ} is a compactly supported \mathcal{C}^r function, for any arbitrary $r \in \mathbb{N}$. Now using lemma (8.2) and lemma (10.4), we obtain the following expression.

$$\int_{|\xi| \ge \delta} \widehat{\tau_{\kappa}}(\xi) \left(\left(\widetilde{\mathfrak{L}}_{(\kappa + i\xi)F} \right)^{\circ n} \mathbf{1} \right) ((w, x)) d\xi = O\left(e^{n\mathfrak{P}(\kappa F)} \int_{\delta}^{\infty} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi \right),$$

where $R = [C_8 \log \xi]$. We now prove that the integral in the right hand side of the above quantity approaches zero faster than $\frac{1}{\sqrt{n}}$ as n goes to ∞ , using techniques from [32]. In order to achieve the same, we further split the integral into two parts, as

$$\int_{\delta}^{\infty} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi = \int_{\delta}^{n^{\delta'}} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi + \int_{n^{\delta'}}^{\infty} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi,$$

where $\delta < \delta' < \frac{1}{C_7}$. Thus, by our choice of δ' , we have $C_7\delta' < 1$. Hence, we get the following estimates. The convergence rate of the first term to zero is faster than any polynomial while the second part converges to zero at a polynomial rate dependent on r.

$$\int_{\delta}^{n^{\delta'}} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi = O\left(n^{\delta'} \left(1 - \frac{1}{n^{C_7 \delta'}} \right)^{\frac{n}{2\delta' \beta \log n}} \right)$$

$$(10.7)$$

$$\int_{n^{\delta'}}^{\infty} \left(1 - \frac{1}{\xi^{C_7}} \right)^{\frac{n}{2R}} \xi^{-r} d\xi = O\left(n^{(1-r)\delta'} \right)$$
 (10.8)

Using the bounds in equations (10.7) and (10.8), we now estimate the remaining part of equation (10.5) to be the following.

$$\int_{|\xi| > \delta} \widehat{\tau_{\kappa}}(\xi) \Big(\widetilde{\mathfrak{L}}_{(\kappa + i\xi)F} \Big)^{\circ n} \mathbf{1}((w, x)) \, d\xi = O\Big(e^{n\mathfrak{P}(\kappa F)} n^{(1-r)\delta'} \Big).$$

Since $\widehat{\tau}_{\kappa}$ is smooth, we prove that the rate of growth of the second term in equation (10.5) is smaller than $\frac{1}{\sqrt{n}}e^{n\mathfrak{P}(\kappa F)}$, by considering $r > 1 + \frac{1}{2\delta'}$. Thus, we obtain the following asymptotic relation.

$$F_{\tau}(n) \sim C_{12} \frac{e^{n\mathfrak{P}(\kappa F)}}{\sqrt{n}} \widehat{\tau_{\kappa}}(0).$$

Proof of Theorem (4.2): The proof of theorem (4.2) now follows from proposition (10.2) where we replace the function F by the characteristic function $\chi_{[a,b]}$.

We now proceed to prove theorem (4.7), using techniques similar to those used in the above proof. Hence, we only highlight the important steps to complete this proof.

Proof of Theorem (4.7): As earlier, we begin with a generalisation of the left hand side of the assertion of theorem (4.7) for a compactly supported function and define $\widetilde{F}_{\tau}(n)$ as

$$\widetilde{F}_{\tau}(n) := \sum_{w:|w|=n} \sum_{x \in \operatorname{Fix}T_w} \tau(f_w^n(x)).$$

Clearly, $\widetilde{F}_{\chi_{[a,b]}}(n)$ coincides with the expression we need to estimate. By replacing τ by τ_{κ} , as defined in equation (10.2) and applying Fourier transforms we get the following:

$$\widetilde{F}_{\tau}(n) = \int_{\mathbb{R}} \widehat{\tau}_{\kappa}(\xi) \sum_{w: |w|=n} \sum_{x \in \operatorname{Fix}(T_w)} e^{((\kappa+i\xi)f_w^n(x))} d\xi.$$

Thus, in order to estimate $\widetilde{F}_{\tau}(n)$, we first estimate the sum inside the integral, namely

$$\sum_{w: |w| = n} \sum_{x \in \text{Fix}(T_w)} e^{((\kappa + i\xi) f_w^n(x))} \text{ for } \xi \in \mathbb{R}.$$

The following lemma gives a relation between the sum to be estimated and the iterates of the normalised Ruelle operator, $\widetilde{\mathbb{L}}_{(\kappa+i\xi)f}$. By observing the relation between $(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f})^{\circ n}$ and $(\widetilde{\mathfrak{L}}_{(\kappa+i\xi)Q(f)})^{\circ n}$, as prescribed in equation (8.1), we write the following lemma which is nothing but an easy corollary of lemma (10.3).

Lemma 10.5 Let $\kappa \in \mathbb{R}$ be the unique real number that satisfies $\int f d\mathfrak{m}_{\kappa f} = 0$. Then, there exists $0 < \eta < e^{-\mathbb{P}(\kappa f)}$ such that for every point x that satisfies $T_w^n x = x$ for some n-lettered word w, we have

$$\sum_{v:|v|=n} \sum_{y\in \operatorname{Fix}(T_v)} e^{(\kappa+i\xi)f_v^n(y)} = \left(\left(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) \left(1 + O\left(n\eta^n \max\left\{ 1, |\xi| \right\} \right) \right).$$

Using the above lemma, we rewrite $\widetilde{F}_{\tau}(n)$ as,

$$\widetilde{F}_{\tau}(n) = \int_{\mathbb{R}} \widehat{\tau}_{\kappa}(\xi) \left(\left((\widetilde{\mathbb{L}}_{(\kappa+i\xi)f})^{\circ n} \mathbf{1} \right) (x) \left(1 + O(n\eta^{n} \max\{1, |\xi|\}) \right) \right) d\xi.$$
(10.9)

The second term in the above integral is dominated by $(\eta e^{\mathbb{P}(\kappa f)})^n$ and thus goes to zero, faster than polynomial of n, as n tends to infinity. Using the definition of $\mathbb{P}((\kappa + i\xi)f)$, theorem (6.2) and lemma (7.1), we conclude that the pressure functions $\mathbb{P}((\kappa + i\xi)f)$ and $\mathfrak{P}((\kappa + i\xi)Q(f))$ coincide. Further, since $\int Q(f) d\mu_{\kappa Q(f)} = \int f d\mathfrak{m}_{\kappa f} = 0$, we obtain the following lemma as a corollary of lemma (10.1).

Lemma 10.6 For $\zeta = \kappa + i\xi$, there exists a change of variables $\Upsilon = \Upsilon(\xi)$ such that for $|\xi| < \delta$, we can expand

$$e^{\mathbb{P}(\zeta f)} = e^{\mathbb{P}(\kappa f)} \left(1 - \Upsilon^2 + i \Theta(\Upsilon) \right),$$

where Θ is a real-valued function that satisfies $\Theta(\Upsilon) = O(|\Upsilon|^3)$.

By perturbation theory, the one dimensional eigenprojection associated with $\widetilde{\mathbb{L}}_{(\kappa+i\xi)f}$ is of the form

$$\Xi_{(\kappa+i\xi)f}\mathbf{1} = \mathbf{1} + O(|\Upsilon|).$$

Thus for $-\delta < \xi < \delta$ and for some $0 < \vartheta < 1$, we have

$$\left(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f}\right)^{\circ n}\mathbf{1} = e^{n\mathbb{P}\left((\kappa+i\xi)f\right)}\left(\mathbf{1} + O\left(\left|\Upsilon\right|\right)\right) + O(\vartheta^n).$$

The integral in the equation (10.9) can now be split accordingly to get

$$\int_{\mathbb{R}} \widehat{\tau}_{\kappa}(\xi) \left(\left(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) d\xi = \int_{|\xi| < \delta} \widehat{\tau}_{\kappa}(\xi) \left(\left(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) d\xi + \int_{|\xi| \ge \delta} \widehat{\tau}_{\kappa}(\xi) \left(\left(\widetilde{\mathbb{L}}_{(\kappa+i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) d\xi. \tag{10.10}$$

We then apply change of variables to the first integral in the above equation to get

$$\int_{|\xi| < \delta} \widehat{\tau}_{\kappa}(\xi) \left(\left(\widetilde{\mathbb{L}}_{(\kappa + i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) d\xi$$

$$= C_{17} \widehat{\tau}_{\kappa}(0) e^{n\mathfrak{P}(\kappa f)} \int_{|\xi| < \delta} \left(1 - \Upsilon^{2} + i\Theta(\Upsilon) \right)^{n} \left(1 + O(|\Upsilon|) \right) d\Upsilon + O(n^{-1}) + O(\vartheta^{n}),$$

where the expression inside the integral is the same as in equation (10.6). Thus, the techniques used in the proof of theorem (4.2) can be used again to obtain

$$\int_{|\xi| < \delta} \widehat{\tau}_{\kappa}(\xi) \left(\left(\widetilde{\mathbb{L}}_{(\kappa + i\xi)f} \right)^{\circ n} \mathbf{1} \right) (x) d\xi \sim \frac{1}{\sqrt{n}} C_{18} e^{n\mathbb{P}(\kappa f)} \widehat{\tau}_{\kappa}(0).$$

Now what remains is to prove that the second integral in equation (10.10) grows at a rate strictly smaller than $\frac{1}{\sqrt{n}}e^{n\mathbb{P}(\kappa f)}$, as $n \to \infty$, to complete the proof. This can be achieved again using lemma (8.3), as earlier.

11 Decay of correlations

In this section, we prove theorems pertaining to the decay of correlations in the skew-product setting and in the setting of simultaneous action of finitely many interval maps, namely theorems (4.3) and (4.8).

Fix $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ and consider the normalised Ruelle operator $\widetilde{\mathfrak{L}}_F$ along with its corresponding equilibrium measure μ_F . Denote by $\mathscr{F}_{\alpha}^F(X,\mathbb{R})$, the set of all α -Hölder continuous functions whose integral with respect to μ_F is zero, *i.e.*,

$$\mathscr{F}_{\alpha}^{F}(X,\mathbb{R}) := \left\{ G \in \mathscr{F}_{\alpha}(X,\mathbb{R}) : \int G \, d\mu_{F} = 0 \right\}.$$

It is easily verifiable that $\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$ is a subspace of $\mathscr{F}_{\alpha}(X,\mathbb{R})$. Further, the space $\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$ is preserved by the action of the operator $\widetilde{\mathfrak{L}}_{F}$, *i.e.*, $\widetilde{\mathfrak{L}}_{F}:\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})\longrightarrow\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$. The Ruelle operator theorem states that the action of $\widetilde{\mathfrak{L}}_{F}$ on $\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$ has a spectral radius strictly smaller than $\varrho=e^{\mathfrak{P}(F)}$. Equivalently one may consider the operator $\varrho^{-1}\widetilde{\mathfrak{L}}_{F}$ on $\mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$ that has a spectral radius, say $\varrho_{F}<1$.

We first state and prove a lemma, that will be useful to prove our main results in this section.

Lemma 11.1 For any $\vartheta \in (\varrho_F, 1)$, there exists a positive constant $C_{19} > 0$ such that

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} G \right\|_{\alpha} \leq C_{19} \, \vartheta^n \, \left\| G \right\|_{\alpha} \, \forall n \geq 0 \, \text{ and } \, \forall G \in \mathscr{F}_{\alpha}^F(X, \mathbb{R}).$$

Proof: Fix a number $\vartheta \in (\varrho_F, 1)$. Choose $\epsilon > 0$ such that $\varrho_F + \epsilon < \vartheta$. For this ϵ , there exists $M_{\epsilon} \in \mathbb{Z}_+$ such that

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} \right\|^{\frac{1}{n}} < \varrho_F + \epsilon, \quad \forall n \geq M_{\epsilon}, \quad \text{since } \varrho_F = \inf_{n \geq 1} \left\| \left(\widetilde{\mathfrak{L}}_F \right)^{\circ n} \right\|^{\frac{1}{n}},$$

where we only consider the action of $\varrho^{-1}\widetilde{\mathfrak{L}}_F$ on $\mathscr{F}^F_{\alpha}(X,\mathbb{R})$. This implies

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} G \right\|_{\alpha} < (\varrho_F + \epsilon)^n \left\| G \right\|_{\alpha} < \vartheta^n \left\| G \right\|_{\alpha}, \ \forall n \geq M_{\epsilon}, \ \text{and} \ \forall G \in \mathscr{F}_{\alpha}^F (X, \mathbb{R}).$$

Further, since $\widetilde{\mathfrak{L}}_F$ is a bounded operator, there exists a positive constant $D_0 > 0$ such that

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} G \right\|_{\alpha} \leq D_0 \left\| G \right\|_{\alpha}, \quad \forall n \geq 1.$$

Now, an application of the Archimedean property of \mathbb{R} results in finitely many finite constants $D_1, D_2, \dots, D_{M_{\epsilon}}$ that satisfy $D_n \vartheta^n > D_0$ for $1 \leq n \leq M_{\epsilon}$. Hence,

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} G \right\|_{\alpha} \leq D_n \vartheta^n \left\| G \right\|_{\alpha}, \text{ for } 1 \leq n \leq M_{\epsilon}.$$

The result now follows by taking $C_{19} = \max\{1, D_1, D_2, \cdots, D_{M_{\epsilon}}\}.$

We are now ready to prove theorem (4.3) that states the decay of correlations result for the skew-product map T.

Proof of Theorem (4.3): For any $G \in \mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$, the left hand side of equation (4.4) in theorem (4.3) can be written as

$$\int \mathcal{Q}^{n}(G)H \, d\mu_{F} - \int G \, d\mu_{F} \int H \, d\mu_{F} = \int \mathcal{Q}^{n}(G)H \, d\mu_{F} - \int \mathcal{Q}^{n}(G) \, d\mu_{F} \int H \, d\mu_{F}$$
$$= \int \mathcal{Q}^{n}(G) \left(H - \int H \, d\mu_{F}\right) \, d\mu_{F}.$$

Suppose we denote $\widetilde{H} := \left(H - \int H d\mu_F\right)$, then it is easy to see that $\widetilde{H} \in \mathscr{F}_{\alpha}^F(X,\mathbb{R})$. Further, on the space of μ_F -square integrable real-valued functions defined on X denoted by $L^2(\mu_F)$, the operator $\widetilde{\mathfrak{L}}_F$ has a natural extension, with its adjoint given by the operator \mathscr{Q} , i.e.,

$$\langle \mathcal{Q}\Phi, \Psi \rangle = \langle \Phi, \widetilde{\mathfrak{L}}_F \Psi \rangle, \ \forall \Phi, \Psi \in L^2(\mu_F).$$

Hence,

$$\int \mathcal{Q}^n(G)\widetilde{H} d\mu_F = \int G \left(\varrho^{-1}\widetilde{\mathfrak{L}}_F\right)^{\circ n} \widetilde{H} d\mu_F.$$

Therefore,

$$\left| \int G \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} \widetilde{H} d\mu_F \right| \leq \int \left| G \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} \widetilde{H} \right| d\mu_F \leq \|G\|_2 \left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F \right)^{\circ n} \widetilde{H} \right\|_2.$$

Further,

$$\left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_{F} \right)^{\circ n} \widetilde{H} \right\|_{2} \leq \left\| \left(\varrho^{-1} \widetilde{\mathfrak{L}}_{F} \right)^{\circ n} \widetilde{H} \right\|_{\alpha}$$

$$\leq C_{19} \vartheta^{n} \left\| \widetilde{H} \right\|_{\alpha} \qquad \text{(using lemma (11.1))}$$

$$\leq C_{19} \vartheta^{n} \left(\left\| H \right\|_{\alpha} + \left| \int H \, d\mu_{F} \right| \right) \qquad \text{(using definition of } \widetilde{H})$$

$$\leq 2C_{19} \vartheta^{n} \left\| H \right\|_{\alpha}.$$

Thus, we obtain the result with the constant $C_2 = 2C_{19} \|G\|_2 \|H\|_{\alpha}$ to complete the proof of theorem (4.3).

To prove theorem (4.8), we start by considering the functions $f_d = -\log |T'_d| \in \mathscr{F}_{\alpha}(I,\mathbb{R})$, for $1 \leq d \leq N$. By the definition of the Ruelle operator $\mathcal{L}_{f_d}^{(d)}$, as stated in equation (6.1), we know that

$$\left(\mathcal{L}_{f_d}^{(d)}g\right)(x) = \sum_{T_d y = x} \frac{g(y)}{|T'_d(y)|}.$$

Observe that $\mathcal{L}_{f_d}^{(d)} = \widetilde{\mathcal{L}}_{f_d}^{(d)}$, *i.e.*, the operator $\mathcal{L}_{f_d}^{(d)}$ has eigenvalue 1, with corresponding eigenfunction 1. Further, it is evident from Boyarsky and Góra ([5], section (4.3)) that the dual operator $\left(\mathcal{L}_{f_d}^{(d)}\right)^*$ fixes the Lebesgue measure λ *i.e.*, $\left(\mathcal{L}_{f_d}^{(d)}\right)^*$ $\lambda = \lambda$. Moreover, for every $1 \leq d \leq N$, the operator \mathcal{O}_d defined by $\mathcal{O}_d g = g \circ T_d$ satisfies $\mathcal{L}_{f_d}^{(d)} \mathcal{O}_d = \mathrm{id}$, the identity operator in $\mathcal{C}(I, \mathbb{R})$.

Denoting by $\mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R})$, the set of all real-valued α -Hölder continuous functions on I whose Lebesgue integral is equal to 0, *i.e.*,

$$\mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R}) := \left\{ f \in \mathscr{F}_{\alpha}(I,\mathbb{R}) : \int f \, d\lambda = 0 \right\},$$
 (11.1)

and observing that $\mathcal{L}_{f_d}^{(d)}$ preserves the space $\mathscr{F}_{\alpha}^{\lambda}(I,\mathbb{R})$ for all $1 \leq d \leq N$, we now state a lemma whose proof runs *mutatis mutandis* as the proof of lemma (11.1). We know that the action of $\mathcal{L}_{f_d}^{(d)}$ on $\mathscr{F}_{\alpha}^{\lambda}(I,\mathbb{R})$ has a spectral radius, say $\rho_{\lambda}^{(d)} < 1$, owing to theorem (6.1).

Lemma 11.2 For any $\vartheta^{(d)} \in (\rho_{\lambda}^{(d)}, 1)$, there exists a constant $C_{20}^{(d)} > 0$ such that

$$\left\| \left(\mathcal{L}_{f_d}^{(d)} \right)^{\circ n} g \right\|_{\alpha} \leq C_{20}^{(d)} \left(\vartheta^{(d)} \right)^{n} \left\| g \right\|_{\alpha} \ \forall n \geq 1 \ \text{and} \ \forall g \in \mathscr{F}_{\alpha}^{\lambda}(I, \mathbb{R}), \ \text{for} \ 1 \leq d \leq N.$$

We are now thoroughly equipped to prove theorem (4.8).

Proof of Theorem (4.8): For any $g \in \mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R})$, the left hand side of equation (4.7) in theorem (4.8) can be written as

$$\int \mathscr{O}_{w}(g)h \, d\lambda - \int g \, d\lambda \int h \, d\lambda = \int \mathscr{O}_{w}(g)h \, d\lambda - \int \mathscr{O}_{w}(g) \, d\lambda \int h \, d\lambda$$
$$= \int \mathscr{O}_{w}(g) \left(h - \int h \, d\lambda\right) \, d\lambda.$$

Let $\widetilde{h} = h - \int h \, d\lambda \in \mathscr{F}^{\lambda}_{\alpha}(I, \mathbb{R})$. Then, since $\mathcal{L}^{(d)}_{f_d}$ is the adjoint of \mathscr{O}_d in the space of Lebesgue square integrable real-valued functions defined on I, $L^2(I, \mathbb{R})$, we have

$$\left| \int (\mathscr{O}_w g) \widetilde{h} \, d\lambda \right| = \left| \int g \left(\mathcal{L}_{f_{w_n}}^{(w_n)} \mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_1}}^{(w_1)} \right) \widetilde{h} \, d\lambda \right|$$

$$\leq \|g\|_2 \left\| \mathcal{L}_{f_{w_n}}^{(w_n)} \mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_1}}^{(w_1)} \widetilde{h} \right\|_2.$$

Now making use of the inequality

$$\left\| \left(\mathcal{L}_{f_{w_n}}^{(w_n)} \mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_1}}^{(w_1)} \right) \widetilde{h} \right\|_2 \leq \left\| \left(\mathcal{L}_{f_{w_n}}^{(w_n)} \mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_1}}^{(w_1)} \right) \widetilde{h} \right\|_{\alpha},$$

and redistributing the operators for $1 \leq d \leq N$, we obtain

$$\left\| \left(\mathcal{L}_{f_{w_{n}}}^{(w_{n})} \mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_{1}}}^{(w_{1})} \right) \widetilde{h} \right\|_{\alpha} = \left\| \left(\left(\mathcal{L}_{f_{1}}^{(1)} \right)^{\gamma_{1}} \left(\mathcal{L}_{f_{2}}^{(2)} \right)^{\gamma_{2}} \cdots \left(\mathcal{L}_{f_{N}}^{(N)} \right)^{\gamma_{N}} \right) \widetilde{h} \right\|_{\alpha} \\
\leq C_{20}^{(1)} C_{20}^{(2)} \cdots C_{20}^{(N)} \left(\vartheta^{(1)} \right)^{\gamma_{1}} \left(\vartheta^{(2)} \right)^{\gamma_{2}} \cdots \left(\vartheta^{(N)} \right)^{\gamma_{N}} \left\| \widetilde{h} \right\|_{\alpha},$$

appealing to lemma (11.2).

Finally, defining $C_{20} := C_{20}^{(1)} C_{20}^{(2)} \cdots C_{20}^{(N)}$ and $\vartheta := \max \{ \vartheta^{(1)}, \vartheta^{(2)}, \cdots, \vartheta^{(N)} \}$, we obtain

$$\left| \int \mathscr{O}_{w}(g)h \, d\lambda - \int g \, d\lambda \int h \, d\lambda \right| \leq C_{20} \vartheta^{n} \|g\|_{2} \|\widetilde{h}\|_{\alpha} \leq 2C_{20} \vartheta^{n} \|g\|_{2} \|h\|_{\alpha},$$

thus completing the proof.

12 Almost sure invariance principles

In this section, we prove the almost sure invariance principles as stated in theorems (4.4) and (4.9) for both the settings, that we focus in this paper. As in section (11), we begin by fixing a real-valued Hölder continuous function $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ and considering the corresponding normalised Ruelle operator $\varrho^{-1}\widetilde{\mathfrak{L}}_F$ along with its equilibrium measure μ_F and the subspace $\mathscr{F}_{\alpha}^F(X,\mathbb{R}) \subseteq \mathscr{F}_{\alpha}(X,\mathbb{R})$. The proof closely follows the method of proof given by Pollicott and Sharp in [34] and Sridharan in [41].

For any function $G \in \mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$, define

$$H := \sum_{n>1} \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F\right)^{\circ n} G.$$

Observe that the infinite series that defines H converges, owing to lemma (11.1). Then,

$$\widetilde{\mathfrak{L}}_F\Big(G+H-\mathscr{Q}(H)\Big) = \widetilde{\mathfrak{L}}_FG+\widetilde{\mathfrak{L}}_FH-\varrho H = \mathbf{0}.$$

Thus, defining $\Phi := G + H - \mathcal{Q}(H)$, we observe that

$$\begin{vmatrix} G^n((w, x)) - \Phi^n((w, x)) \end{vmatrix} = \begin{vmatrix} \mathcal{Q}^n H((w, x)) - H((w, x)) \end{vmatrix} \\
\leq \begin{vmatrix} \mathcal{Q}^n H((w, x)) \end{vmatrix} + \begin{vmatrix} H((w, x)) \end{vmatrix} \\
\leq 2 \|H\|_{\alpha}.$$

Thus, we have proved:

Lemma 12.1 (c.f.[34], Lemma 2) For any function $G \in \mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$, there exists a function $H \in \mathscr{F}_{\alpha}^{F}(X,\mathbb{R})$ such that $\Phi = G + (H - \mathcal{Q}(H))$ satisfies

$$\widetilde{\mathfrak{L}}_F \Phi = 0$$
 and $G^n((w, x)) = \Phi^n((w, x)) + O(1)$.

Given that Φ and G are cohomologous to each other, we have

$$\varsigma(G)^{2} = \int \Phi((w, x))^{2} d\mu_{F} + 2 \sum_{n \geq 0} \int \Phi((w, x)) \Phi(T^{n}((w, x))) d\mu_{F}.$$
 (12.1)

Since $\widetilde{\mathfrak{L}}_f \Phi = 0$, we obtain

$$\int \Phi((w, x)) \Phi(T^n((w, x))) d\mu_F = \int \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F\right)^{\circ n} \left(\Phi((w, x)) \Phi(T^n((w, x)))\right) d\mu_F$$

$$= \int \left(\varrho^{-1} \widetilde{\mathfrak{L}}_F\right)^{\circ n} \Phi((w, x)) \Phi((w, x)) d\mu_F$$

$$= 0.$$

Therefore, equation (12.1) becomes

$$\varsigma(G)^2 = \int \Phi((w, x))^2 d\mu_F.$$

Let

$$\widehat{X} := \{(w_n, x_n)_{n \le 0} \in X^{-\mathbb{N}} : T((w_{n-1}, x_{n-1})) = (w_n, x_n)\}.$$

For the purposes of proofs in this section, we fix the following notations. Elements in \widehat{X} will be represented as $\overline{(w,x)} = (w_n, x_n)_{n \leq 0}$. Making use of the canonical projection

$$\Pr: \widehat{X} \longrightarrow X$$
 defined by $\Pr\left(\overline{(w, x)}\right) = (w_0, x_0),$

we denote and define the natural extension of the map $T: X \longrightarrow X$ on \widehat{X} by

$$\widehat{T}: \widehat{X} \longrightarrow \widehat{X}$$
 such that $\Pr\left(\widehat{T}\left(\overline{(w,x)}\right)\right) = T((w_0,x_0)).$

Given a function $\Phi \in \mathcal{C}(X,\mathbb{R})$, let $\widehat{\Phi}$ be its natural extension on \widehat{X} given by

$$\widehat{\Phi}\left(\overline{(w,x)}\right) = \Phi\left(\Pr\left(\overline{(w,x)}\right)\right) = \Phi((w_0,x_0)). \tag{12.2}$$

Thus, the function $F \in \mathscr{F}_{\alpha}(X,\mathbb{R})$ that we fixed in the beginning of this section along with its equilibrium measure μ_F are written as \widehat{F} and $\widehat{\mu_F}$ on the space \widehat{X} . Since μ_F is a T-invariant probability measure on X, it is clear that $\widehat{\mu_F}$ is a \widehat{T} -invariant probability measure on \widehat{X} . Suppose \mathscr{B} is a σ -algebra on X, define a sequence of σ -algebras on \widehat{X} by

$$\mathscr{B}_0 := \operatorname{Pr}^{-1}\mathscr{B} \quad \text{and} \quad \mathscr{B}_n := \left(\widehat{T}\right)^n (\mathscr{B}_0) \text{ for } n \in \mathbb{N}.$$

On a probability space (Ω, ν) , let $\{\mathscr{B}_n\}_{n\geq 0}$ be an increasing sequence of σ -algebras and $\{\Psi_n:\Omega\longrightarrow\mathbb{R}\}_{n\geq 0}$ be a collection of functions. Then, $\{\Psi_n,\mathscr{B}_n\}_{n\geq 0}$ is called an *increasing martingale* if Ψ_n is \mathscr{B}_n -measurable and $\mathrm{E}\left[\Psi_{n+1}\mid\mathscr{B}_n\right]=\Psi_n$ for $n\geq 0$.

Thus, defining

$$\left(\widehat{\Phi}\right)^{n}\left(\overline{(w,x)}\right) := \widehat{\Phi}\left(\left(\widehat{T}\right)^{-1}\left(\overline{(w,x)}\right)\right) + \widehat{\Phi}\left(\left(\widehat{T}\right)^{-2}\left(\overline{(w,x)}\right)\right) + \dots + \widehat{\Phi}\left(\left(\widehat{T}\right)^{-n}\left(\overline{(w,x)}\right)\right),$$

that captures the *n*-th ergodic sum $\Phi^n((w, x))$, as defined in equation (3.1), on the base space, helps us form an increasing martingale on \widehat{X} , related to Φ^n .

Lemma 12.2 [34] The sequence $\left\{ \left(\widehat{\Phi}\right)^n, \mathscr{B}_n \right\}_{n \geq 1}$ forms an increasing martingale on \widehat{X} .

Before we embark on the proof of theorem (4.4), we state the Skorokhod embedding theorem, as in Appendix I of [19]. The statement of this theorem will come in handy, in writing the proof.

Theorem 12.3 (Skorokhod embedding theorem) Let $\{\widehat{\Psi}_n, \mathscr{B}_n\}_{n\geq 0}$ be a zero mean and square integrable martingale on \widehat{X} . Then, there exists a probability space $(\Omega, \mathcal{A}, \nu)$ that supports a Brownian motion \mathfrak{B} such that $\mathfrak{B}(t)$ has variance t, an increasing sequence of σ -algebras $\{\mathcal{F}_n\}_{n\geq 0}$ and a sequence of non negative random variables $\{\mathfrak{X}_n\}_{n\geq 1}$ such that if $\mathcal{S}_0 = 0$ and $\mathcal{S}_n = \sum_{i=1}^n \mathfrak{X}_i$ for $n \geq 1$, then

1.
$$\mathfrak{Y}_n := \mathfrak{B}(\mathcal{S}_n) \stackrel{\mathrm{d}}{=} \widehat{\Psi}_n$$
,
where $\stackrel{\mathrm{d}}{=}$ represents equality in distribution, i.e., for any Borel measurable set V in \mathbb{R} ,
 $\widehat{\mu_F}\left(\left\{\overline{(w,x)}\in\widehat{X}:\widehat{\Psi}_n\left(\overline{(w,x)}\right)\in V\right\}\right) = \nu\left(\left\{\omega\in\Omega:\mathfrak{Y}_n(\omega)\in V\right\}\right)$;

2. \mathfrak{Y}_n and \mathcal{S}_n are \mathcal{F}_n -measurable;

3.
$$\mathrm{E}\left[\mathfrak{X}_{n}\mid\mathcal{F}_{n-1}\right] = \mathrm{E}\left[\left(\mathfrak{Y}_{n}-\mathfrak{Y}_{n-1}\right)^{2}\mid\mathcal{F}_{n-1}\right], \ \nu\text{-a.e. for } n\geq1.$$

We now make use of the Skorokhod embedding theorem and prove theorem (4.4).

Proof of Theorem (4.4): Since $(\widehat{\Phi})^n$ is a square integrable function with mean zero, we can apply the Skorokhod embedding theorem. Further, making use of the definition of $\widehat{\Phi}$, as given in equation (12.2), we obtain

$$\mathfrak{Y}_n \stackrel{\mathrm{d}}{=} \left(\widehat{\Phi}\right)^n \stackrel{\mathrm{d}}{=} \Phi^n.$$

Thus, in order to complete the proof of theorem (4.4), we make the following claim.

Claim 12.4 Given any $\delta > 0$,

$$\mathfrak{Y}_n(\omega) = \mathfrak{B}(n)(\omega) + O\left(n^{\frac{1}{4} + \delta}\right) \quad \forall n \ge 0, \quad \nu\text{-a.e.}$$

Pending proof of claim (12.4), it follows from the properties of Brownian motion that

$$\mathfrak{Y}_{\lfloor t \rfloor} = \mathfrak{B}(t) + O\left(t^{\frac{1}{4} + \delta}\right) \quad \forall t \geq 0, \quad \nu\text{-a.e.}$$

This proves the theorem.

We now prove our claim (12.4).

Proof of Claim (12.4): Since $\mathfrak{Y}_n = \mathfrak{B}(\mathcal{S}_n)$, we approximate \mathcal{S}_n by $n\varsigma(G)^2$, as follows.

$$S_{n} - n\varsigma(G)^{2} = \sum_{j=1}^{n} \left(\mathfrak{X}_{j} - \mathrm{E} \left[\mathfrak{X}_{j} \mid \mathcal{F}_{j-1} \right] \right)$$

$$+ \sum_{j=1}^{n} \left(\mathrm{E} \left[\left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} \mid \mathcal{F}_{j-1} \right] - \left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} \right)$$

$$+ \sum_{j=1}^{n} \left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} - n\varsigma(G)^{2}.$$

$$(12.3)$$

Given any sequence $\{\widehat{\Psi}_n\}_{n\geq 0}$ of functions and an increasing sequence of σ -algebras $\{\mathcal{F}_n\}_{n\geq 0}$ such that $\widehat{\Psi}_n$ is \mathcal{F}_n measurable for all $n\geq 0$, the sequence defined by

$$\left\{\widehat{\Psi}_n := \sum_{j=1}^n \left(\widehat{\Psi}_j - \mathrm{E}\big[\widehat{\Psi}_j \mid \mathcal{F}_{j-1}\big]\right), \; \mathcal{F}_n\right\}_{n \geq 1}$$

forms a martingale. Hence, the first and the second terms on the right hand side of equation (12.3) are martingales. By the strong law of large numbers for martingales, as can be found in [17], we can see that for every $\delta > 0$

$$\sum_{j=1}^{n} \left(\mathfrak{X}_{j} - \mathrm{E} \left[\mathfrak{X}_{j} \mid \mathcal{F}_{j-1} \right] \right) = O \left(n^{\frac{1}{2} + \delta} \right);$$

$$\sum_{j=1}^{n} \left(\mathrm{E} \left[\left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} \mid \mathcal{F}_{j-1} \right] - \left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} \right) = O \left(n^{\frac{1}{2} + \delta} \right).$$

We can therefore write equation (12.3) as

$$S_n - n\varsigma(G)^2 = \sum_{j=1}^n \left(\mathfrak{Y}_j - \mathfrak{Y}_{j-1} \right)^2 - n\varsigma(G)^2 + O\left(n^{\frac{1}{2} + \delta}\right). \tag{12.4}$$

We estimate the sum on the right hand side of equation (12.4) with the help of the following series.

$$\sum_{j>1} \frac{1}{j^{\frac{1}{2}+\delta}} \left[\left(\mathfrak{Y}_j - \mathfrak{Y}_{j-1} \right)^2 - \varsigma(G)^2 \right].$$

Lemma 12.5 The following integrals are equal.

$$\mathfrak{I}(\delta) := \int \left(\sum_{j\geq 1} \frac{1}{j^{\frac{1}{2}+\delta}} \left[\left(\mathfrak{Y}_j - \mathfrak{Y}_{j-1} \right)^2 - \varsigma(G)^2 \right] \right)^2 d\nu$$
$$= \int \left(\sum_{j\geq 1} \frac{1}{j^{\frac{1}{2}+\delta}} \left[\Phi \left(T^j((w,x)) \right)^2 - \int \Phi^2 d\mu_F \right] \right)^2 d\mu_F.$$

Proof: We already have that $\mathfrak{Y}_n \stackrel{\mathrm{d}}{=} \Phi^n$. Thus, from a proposition of Brieman, L. as in [7], we deduce that for any measurable function $\Theta : \mathbb{R}^{\mathbb{N}} \longrightarrow \mathbb{R}$,

$$\int \Theta\left(\left(\mathfrak{Y}_{j}(\omega)\right)_{j=0}^{\infty}\right) d\nu = \int \Theta\left(\left(\Phi^{j}((w,x))\right)_{j=0}^{\infty}\right) d\mu_{F}.$$

The result follows from an appropriate choice of the function Θ , say

$$\Theta\left(\left(y_{j}\right)_{j\geq0}\right) = \left(\sum_{j\geq1}\frac{1}{j^{\frac{1}{2}+\delta}}\left[\left[y_{j+1}-y_{j}\right]^{2}-\int\Phi^{2}d\mu\right]\right)^{2}.$$

A simple calculation now yields that for any $\delta > 0$, $\Im(\delta) < \infty$. Hence,

$$\sum_{j>1} \frac{1}{j^{\frac{1}{2}+\delta}} \left[\left(\mathfrak{Y}_j - \mathfrak{Y}_{j-1} \right)^2 - \varsigma(G)^2 \right] < \infty, \quad \nu\text{-a.e.}$$

Applying the Kronecker lemma as in [19], we deduce that

$$\sum_{j=1}^{n} \left[\left(\mathfrak{Y}_{j} - \mathfrak{Y}_{j-1} \right)^{2} - n\varsigma(G)^{2} \right] = O\left(n^{\frac{1}{2} + \delta} \right). \tag{12.5}$$

Thus, from equations (12.4)) and (12.5), we have $S_n - n\varsigma(G)^2 = O\left(n^{\frac{1}{2}+\delta}\right)$, ν -a.e.

Finally, defining $\mathfrak{B}(t) := \mathfrak{B}(t\varsigma(G)^2)$, we have for $n \geq 0$,

$$\mathfrak{B}(\mathcal{S}_n) = \mathfrak{B}\left(n\varsigma(G)^2\right) + O\left(n^{\frac{1}{4}+\delta}\right) = \widetilde{\mathfrak{B}}(n) + O\left(n^{\frac{1}{4}+\delta}\right), \quad \nu\text{-a.e.}$$

This proves the equation in claim (12.4), namely,

$$\mathfrak{Y}_n = \widetilde{\mathfrak{B}}(n) + O\left(n^{\frac{1}{4}+\delta}\right), \quad \nu\text{-a.e.}$$

We now proceed to prove the next theorem on almost sure invariance principles for simultaneous action of the interval maps, as stated in theorem (4.9). We draw motivation from the proof of a similar result in an article by Haydn, Nicol, Török and Vaienti in [20] and achieve a better bound. We first state a theorem due to Cuny and Merlévede as in [11], that would be helpful in our proof.

Theorem 12.6 [11] Let $\{U_n\}_{n\geq 0}$ be a sequence of square integrable random variables adapted to some non-increasing sequence of σ -algebras $\{\mathscr{A}_n\}_{n\geq 0}$ on \mathbb{R} . Assume that

$$\mathbf{E}\big[U_n \mid \mathscr{A}_{n+1}\big] = 0 \text{ a.s.}; \quad \varsigma_n^2 = \sum_{k=0}^{n-1} \mathbf{E}\big[U_k^2\big] \rightarrow \infty; \quad \sup_{n \geq 0} \mathbf{E}\big[U_n^2\big] < \infty.$$

Let $\{a_n\}_{n\geq 0}$ be a non-decreasing sequence of positive numbers such that

$$\left\{\frac{a_n}{\varsigma_n}\right\}_{n\geq 0}$$
 is non-decreasing and $\left\{\frac{a_n}{\varsigma_n^2}\right\}_{n\geq 0}$ is non-increasing.

Further, assume that

1.
$$\sum_{k=0}^{n-1} \left(\mathbb{E} \left[U_k^2 \mid \mathscr{A}_{k+1} \right] - \mathbb{E} \left[U_k^2 \right] \right) = o(a_n), \ \lambda \text{-a.s.};$$

2.
$$\sum_{n>0} a_n^{-r} \mathbb{E}\left[|U_n|^{2r}\right] < \infty \text{ for some } 1 \le r \le 2.$$

Then enlarging our probability space, if necessary, it is possible to find a sequence $\{\mathcal{U}_n\}_{n\geq 0}$ of independent centered Gaussian variables with $\mathrm{E}\big[\mathcal{U}_n^2\big] = \mathrm{E}\big[U_n^2\big]$ such that

$$\sup_{0 \le k \le n-1} \left| \sum_{j=0}^{k} U_j - \sum_{j=0}^{k} U_j \right| = o\left(\left[a_n \left(\left| \log \left(\frac{\varsigma_n^2}{a_n} \right) \right| + \log \log a_n \right) \right]^{\frac{1}{2}} \right), \quad \lambda\text{-a.s.}$$

Note that the assertion of theorem (12.6) can be rewritten by considering another probability space $(\Omega, \mathscr{A}, \nu)$ and a sequence of random variables, say $\{\mathcal{V}_n\}_{n\geq 0}$ such that $U_n \stackrel{\mathrm{d}}{=} \mathcal{V}_n$. Then,

$$\sup_{0 \le k \le n-1} \left| \sum_{j=0}^k \mathcal{V}_j - \sum_{j=0}^k \mathcal{U}_j \right| = o\left(\left[a_n \left(\left| \log \left(\frac{\varsigma_n^2}{a_n} \right) \right| + \log \log a_n \right) \right]^{\frac{1}{2}} \right), \quad \nu\text{-a.s.}$$

We will now prove theorem (4.9).

Proof of Theorem (4.9): Recall the definition of the space $\mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R})$ from equation (11.1),

$$\mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R}) := \left\{ f \in \mathscr{F}_{\alpha}(I,\mathbb{R}) : \int f \, d\lambda = 0 \right\},$$

and the property that for $f_d = -\log |T'_d|$, the operator $\mathcal{L}_{f_d}^{(d)}$ preserves the space $\mathscr{F}_{\alpha}^{\lambda}(I,\mathbb{R})$ for all $1 \leq d \leq N$.

Let $g \in \mathscr{F}^{\lambda}_{\alpha}(I,\mathbb{R})$ and $w \in \Sigma_{N}^{+}$. Then, define a sequence of σ -algebras

$$\mathscr{B}_w^n := (\mathscr{O}_{(w_1 \, w_2 \, \cdots \, w_n)})^{-1} \mathscr{B} \quad \text{for } n \ge 0,$$

where \mathscr{B} is the Borel σ -algebra on I.

Suppose for all $n \geq 1$, we denote by \mathfrak{g}_w^n , the sum

$$\mathfrak{g}_{w}^{n} := \left(\mathcal{L}_{f_{w_{n}}}^{(w_{n})}\right)g + \left(\mathcal{L}_{f_{w_{n}}}^{(w_{n})}\mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})}\right)g + \cdots + \left(\mathcal{L}_{f_{w_{n}}}^{(w_{n})}\mathcal{L}_{f_{w_{n-1}}}^{(w_{n-1})} \cdots \mathcal{L}_{f_{w_{1}}}^{(w_{1})}\right)g$$

and $\mathfrak{g}_w^0 = 0$ for all $w \in \Sigma_N^+$. It is easy to see that

$$\mathcal{L}_{f_{w_{n+1}}}^{(w_{n+1})} \mathfrak{g}_{w}^{n} = 0, \text{ where } \mathfrak{g}_{w}^{n} = g + \mathfrak{g}_{w}^{n} - T_{w_{n+1}} \mathfrak{g}_{w}^{n+1}.$$

Defining $\mathbb{h}_{w}^{n} = \mathscr{O}_{(w_{1} w_{2} \cdots w_{n})}(\mathbb{g}_{w}^{n})$, one can observe that \mathbb{h}_{w}^{n} agrees with the definition of a reverse martingale difference sequence for the sequence of σ -algebras \mathscr{B}_{w}^{n} , as defined in Conze and Raugi [10], as given below.

Given a sequence of random variables $\{X_n\}_{n\in\mathbb{N}}$ adapted to a non-increasing sequence of σ - algebras $\{\mathscr{A}_n\}_{n\in\mathbb{N}}$, $\{X_n,\mathscr{A}_n\}_{n\in\mathbb{N}}$ is a reverse martingale or equivalently, $\{X_n\}_{n\in\mathbb{N}}$ is a reverse martingale adapted to $\{\mathscr{A}_n\}_{n\in\mathbb{N}}$ if $\{\widetilde{X}_n,\widetilde{\mathscr{A}_n}\}_{n\leq -1}$ forms a martingale, where $\widetilde{X}_n=X_{-n}$ and $\widetilde{\mathscr{A}}_n=\mathscr{A}_{-n}$ for each $n\in -\mathbb{N}$. Now,

$$\sum_{k=0}^{n-1} \mathbb{h}_{w}^{k} = \sum_{k=0}^{n-1} \left(\mathscr{O}_{(w_{1} w_{2} \cdots w_{k})} g + \mathscr{O}_{(w_{1} w_{2} \cdots w_{k})} \mathfrak{g}_{w}^{k} - \mathscr{O}_{(w_{1} w_{2} \cdots w_{k+1})} \mathfrak{g}_{w}^{k+1} \right) \\
= \sum_{k=0}^{n-1} \mathscr{O}_{(w_{1} w_{2} \cdots w_{k})} g - \mathscr{O}_{(w_{1} w_{2} \cdots w_{n})} \mathfrak{g}_{w}^{n}.$$

Further, $\|\mathfrak{g}_w^n\|_{\alpha}$ is uniformly bounded. Hence,

$$\operatorname{E}\left[\left(\sum_{k=0}^{n-1} \mathbb{h}_{w}^{k}\right)^{2}\right] = \operatorname{E}\left[\left(\sum_{k=0}^{n-1} \mathscr{O}_{(w_{1}w_{2}\cdots w_{k})}g\right)^{2}\right] + \operatorname{E}\left[\left(\mathscr{O}_{(w_{1}w_{2}\cdots w_{n})}\mathfrak{g}_{w}^{n}\right)^{2}\right] - 2\operatorname{E}\left[\left(\sum_{k=0}^{n-1} \mathscr{O}_{(w_{1}w_{2}\cdots w_{k})}g\right)\left(\mathscr{O}_{(w_{1}w_{2}\cdots w_{n})}\mathfrak{g}_{w}^{n}\right)\right] \\
= \left(\varsigma_{w}^{(n)}(g)\right)^{2} + o\left(\left(\varsigma_{w}^{(n)}(g)\right)\right),$$

where we recall the definition of $\varsigma_w^{(n)}(g)$ from equation (4.8) as

$$\left(\varsigma_w^{(n)}(g)\right)^2 = \int (g_w^n)^2 d\lambda.$$

Haydn, Nicol, Török and Vaienti in [20] show us that $\mathrm{E}\left[\mathbb{h}_w^j\mathbb{h}_w^k\right]=0$, for $j\neq k$ and therefore

$$\sum_{k=0}^{n-1} \mathrm{E}\left[\left(\mathbb{h}_w^k\right)^2\right] = \mathrm{E}\left[\left(\sum_{k=0}^{n-1} \mathbb{h}_w^k\right)^2\right] = \left(\varsigma_w^{(n)}(g)\right)^2 + o\left(\left(\varsigma_w^{(n)}(g)\right)\right),$$

which implies, $\sum_{k=0}^{n-1} \mathrm{E}\left[\left(\mathbb{h}_w^k\right)^2\right] \to \infty$.

Thus, we have constructed a sequence of square integrable random variables $\{\mathbb{h}^n_w\}_{n\geq 0}$ adapted to a non-increasing sequence of σ -algebras $\{\mathscr{B}^n_w\}_{n\geq 0}$ that satisfies

$$\mathrm{E}\big[\mathbb{h}^n_w \mid \mathscr{B}^{n+1}_w\big] = 0 \text{ a.s.}; \quad \sum_{k=0}^{n-1} \mathrm{E}\big[\left(\mathbb{h}^k_w\right)^2\big] \to \infty; \quad \sup_{n\geq 0} \mathrm{E}\big[\left(\mathbb{h}^n_w\right)^2\big] < \infty.$$

Further, defining a sequence $\left\{a_n := \left(\varsigma_w^{(n)}(g)\right)^{1+\epsilon}\right\}_{n\geq 0}$ for some sufficiently small $\epsilon>0$, we observe that the sequences satisfy

$$\left\{\frac{a_n}{\left(\varsigma_w^{(n)}(g)\right)}\right\}_{n\geq 0} \text{ is non-decreasing and } \left\{\frac{a_n}{\left(\varsigma_w^{(n)}(g)\right)^2}\right\}_{n\geq 0} \text{ is non-increasing.}$$

Thus, in order to appeal to theorem (12.6) and exploit the assertions there, we only need to verify the two enumerated assumptions in the statement. We will, for now take the relevant assumptions to be true and proceed to complete the proof of theorem (4.9). Once the proof is complete, we will complete the verifications of the enumerated statements.

By theorem (12.6), we have that there exist sequences $\{\mathcal{Y}_w^n\}_{n\geq 0}$ and $\{Z_w^n\}_{n\geq 0}$ such that

$$\sup_{0 \le k \le n-1} \left| \sum_{j=0}^{k} \mathcal{Y}_{w}^{j} - \sum_{j=0}^{k} Z_{w}^{j} \right| = o \left(\left[a_{n} \left(\left| \log \left(\frac{\varsigma_{n}^{2}}{a_{n}} \right) \right| + \log \log a_{n} \right) \right]^{\frac{1}{2}} \right)$$

$$= o \left(\left(n^{\frac{1}{2} + \epsilon} \left(\left| \log \left(n^{\frac{1}{2} - \epsilon} \right) \right| + \log \log n^{\frac{1}{2} + \epsilon} \right) \right)^{\frac{1}{2}} \right)$$

$$= O \left(n^{\frac{1}{4} + \delta} \right), \quad \nu\text{-a.s., for some } \delta > 0.$$

Further, by the result due to Cuny and Merlevede [11], we know that

$$\sum_{j=0}^{n-1} \mathrm{E}\left[\left(Z_{w}^{j}\right)^{2}\right] = \left(\varsigma_{w}^{(n)}(g)\right)^{2} + O\left(\varsigma_{w}^{(n)}(g)\right) = \left(\varsigma_{w}^{(n)}(g)\right)^{2} + o\left(n^{\frac{1}{2} + \delta'}\right),$$

for some $\delta' > 0$. Hence, we can replace the random variables with a standard Brownian motion $\{\mathfrak{B}^*(t)\}_{t\geq 0}$ such that

$$\sup_{0 \le k \le n-1} \left| \sum_{j=0}^{k} Z_w^j - \mathfrak{B}^* \left(\left(\varsigma_w^{(k)}(g) \right)^2 + o \left(k^{\frac{1}{2} + \delta'} \right) \right) \right| = 0, \quad \nu\text{-a.s.}$$

which implies that

$$\sup_{0 \le k \le n-1} \left| \sum_{j=0}^{k} Z_w^j - \mathfrak{B}^* \left(\left(\varsigma_w^{(k)}(g) \right)^2 \right) \right| = o\left(n^{\frac{1}{4} + \delta'} \right), \quad \nu\text{-a.s.}$$

Page 40

Therefore, if we replace the independent centered Gaussian variables with the standard Brownian motion, we get

$$\sum_{j=0}^{n-1} \mathcal{Y}_w^j - \mathfrak{B}^* \left(\left(\varsigma_w^{(n)}(g) \right)^2 \right) = O\left(n^{\frac{1}{4} + \delta} \right), \quad \nu\text{-a.s.}$$

Further, it is easy to see that there exist a sequence of random variables $\{Y_w^n\}_{n\geq 0}$ such that

$$\left| Y_w^n - \sum_{j=0}^n \mathcal{Y}_w^j \right| = O(1),$$

and g_w^n and Y_w^n are equal in distribution, thus proving theorem (4.9).

We now complete the verifications of the enumerated conditions in theorem (12.6).

Claim 12.7 The first of the enumerated condition in theorem (12.6) looks like

$$\sum_{k=0}^{n-1} \left(\mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \mid \mathscr{B}_w^{k+1} \right] - \mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \right] \right) = o(a_n).$$

Claim 12.8 The second of the enumerated conditions in theorem (12.6) looks like

$$\sum_{n\geq 0} a_n^{-r} \mathrm{E} \left[\left| \mathbb{h}_w^n \right|^{2r} \right] \quad < \quad \infty, \quad \text{for some } 1 \leq r \leq 2.$$

Proof of Claim (12.7): From Conze and Raugi [10], we get that

$$\mathrm{E}\left[\left(\mathbb{h}_{w}^{n}\right)^{2}\mid\mathscr{B}_{w}^{n+1}\right] = \mathscr{O}_{\left(w_{1}\,w_{2}\,\cdots\,w_{n}\right)}\left(\mathcal{L}_{f_{w_{n+1}}}^{\left(w_{n+1}\right)}\left(\mathbb{g}_{w}^{n}\right)^{2}\right) \text{ and }$$

$$\int \left| \sum_{k=0}^{n-1} \left(\mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \mid \mathscr{B}_w^{k+1} \right] - \mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \right] \right) \right|^2 d\lambda \leq C_{21} \sum_{k=0}^{n-1} \mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \right] \leq C_{22} \left(\varsigma_w^{(n)}(g) \right)^2,$$

for some positive constants C_{21} and C_{22} . Hence, by Gal Koksma Theorem as in [46, 38], we have

$$\sum_{k=0}^{n-1} \left(\mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \mid \mathscr{B}_w^{k+1} \right] - \mathbb{E}\left[\left(\mathbb{h}_w^k \right)^2 \right] \right) = O\left(\left(\varsigma_w^{(n)}(g) \right) + \log^{\frac{3}{2} + \epsilon} \left(\left(\varsigma_w^{(n)}(g) \right)^2 \right) \right)$$

$$= O\left(\left(\varsigma_w^{(n)}(g) \right)^{1 + \epsilon'} \right)$$

$$= O(a_n),$$

where ϵ' is some small positive quantity, possibly less than or equal to ϵ .

Proof of Claim (12.8): Here, we begin with an easy observation that $\left(\varsigma_w^{(n)}(g)\right)^2 = O(n)$. Thus given $\delta > 0$, there exists a threshold $M_{\delta} \in \mathbb{N}$ and a positive real number $C_{23} > 0$ such that

$$\left| \frac{\varsigma_w^{(n)}(g)}{\sqrt{n}} - C_{23} \right| \leq \delta, \quad \forall n \geq M_{\delta}.$$

Suppose $m < M_{\delta}$. Then, by the Archimedean property of the reals, we have

$$\varsigma_w^{(m)}(g) \geq \sqrt{m} D_m$$

Choosing $C_{24} = \min \{C_{23} - \delta, D_1, D_2, \dots, D_{N_{\delta}}\}$, we have

$$\varsigma_w^{(n)}(g) \ge \sqrt{n}C_{24}, \quad \forall n \in \mathbb{N}.$$

For r=2 in condition (2) in the enumerated statement of theorem (12.6), we have

$$\sum_{n\geq 0} a_n^{-2} \mathbf{E} \left[|\mathbb{h}_w^n|^4 \right] = \sum_{n\geq 0} \left(\varsigma_w^{(n)}(g) \right)^{-(2+\epsilon)} \mathbf{E} \left[|\mathbb{h}_w^n|^4 \right] \\
\leq C_{25} + \sum_{n\geq 1} \frac{1}{C_{24}^{2+\epsilon} n^{1+2\epsilon}} \mathbf{E} \left[|\mathbb{h}_w^n|^4 \right] \\
\leq C_{25} + C_{26} \sum_{n\geq 1} \frac{1}{n^{1+2\epsilon}} \\
< \infty,$$

since $\sup_{n>0} \mathrm{E}\left[\left|\mathbb{h}_w^n\right|^4\right] < \infty.$

Finally, when we replace the standard Brownian motion with a Brownian motion $\{\widetilde{\mathfrak{B}}^*(t)\}_{t\geq 0}$ such that $\widetilde{\mathfrak{B}}^*(t)$ has variance $t(\varsigma_w(g))^2$, we get

$$Y_w^n - \widetilde{\mathfrak{B}}^*((n)) = O\left(n^{\frac{1}{2}-\gamma}\right), \quad \nu\text{-a.s., for some } \gamma > 0.$$

13 Proofs of other statistical properties

In this section, we write the proofs of the other statistical properties such as the central limit theorem, weak invariance principles and the law of iterated logarithms, as mentioned in theorems (4.5) and (4.10).

Proof of Theorem (4.5):

1. Proof of the central limit theorem: Recall from the proof of theorem (4.4) that

(a)
$$\mathfrak{Y}_n \stackrel{\mathrm{d}}{=} \Phi^n \ \forall n \ge 1$$
 and

(b)
$$\mathfrak{Y}_n = \mathfrak{B}(n) + O\left(n^{\frac{1}{4}+\delta}\right)$$
, ν -a.e.

Further, owing to condition (b) above, we have that for some $\epsilon > 0$,

$$\frac{1}{\sqrt{n}}\mathfrak{Y}_n = \frac{1}{\sqrt{n}}\mathfrak{B}(n) + O(n^{-\epsilon}), \quad \nu\text{-a.e.}$$

and therefore, $\frac{1}{\sqrt{n}}(\mathfrak{Y}_n - \mathfrak{B}(n)) \stackrel{\text{p}}{\longrightarrow} 0$, *i.e.*, converges in probability to 0 as $n \to \infty$. But $\frac{1}{\sqrt{n}}\mathfrak{B}(n)$ is a normal distribution with mean zero and variance $\varsigma(G)^2$ for all $n \ge 1$. Further, owing to condition (a), we have that

$$\frac{1}{\sqrt{n}}\mathfrak{Y}_n \stackrel{\mathrm{d}}{=} \frac{1}{\sqrt{n}}\Phi^n \quad \forall n \ge 1.$$

Making use of both the conditions, we have

$$\frac{1}{\sqrt{n}}\Phi^n \stackrel{\mathrm{d}}{\longrightarrow} \mathcal{N}\left(0,\,\varsigma(G)^2\right),$$

where $\mathcal{N}(0, \varsigma^2)$ denotes the normal distribution with mean 0 and variance ς^2 . The result follows since $G^n((w, x)) = \Phi^n((w, x)) + O(1)$.

2. Proof of the law of iterated logarithms: If Φ in theorem (4.4) satisfies the law of iterated logarithms, then so does G, since

$$\limsup_{n \to \infty} \left[\frac{G^n((w,x)) - \Phi^n((w,x))}{\varsigma(G)\sqrt{2n\log\log n}} \right] \stackrel{p}{\longrightarrow} 0 \quad \text{as } n \to \infty.$$

The following lemma is the key to proving the law of iterated logarithms for the given function Φ .

Lemma 13.1 Any Brownian motion with variance ζ^2 satisfies the law of iterated logarithms *i.e.*,

$$\limsup_{t \to \infty} \frac{\mathfrak{B}(t)(\omega)}{\varsigma \sqrt{2t \log \log t}} = 1, \quad \nu\text{-a.e.}$$

Since we have a Brownian motion which by condition (b) in the proof of the central limit theorem is equal to $\mathfrak{Y}_n + O\left(n^{\frac{1}{4} + \delta}\right)$, we have by theorem (4.4) that

$$\limsup_{n \to \infty} \frac{\mathfrak{Y}_n(\omega)}{\varsigma \sqrt{2n \log \log n}} = 1, \quad \nu\text{-a.e.}$$

Since \mathfrak{Y}_n and Φ^n have the same distribution with the latter having variance $(\varsigma(G))^2$, we conclude that

$$\limsup_{n \to \infty} \frac{\Phi^n((w, x))}{\varsigma(G)\sqrt{2n \log \log n}} = 1, \quad \mu_F\text{-a.e.}$$

We now prove theorem (4.10) to conclude the proofs of all the theorems in this paper.

Proof of Theorem (4.10): The proofs of both the statements run *mutatis mutandis* as the proofs of their analogous statements in theorem (4.5). Hence, we merely highlight the following for readers' convenience.

(a)
$$Y_w^n \stackrel{\mathrm{d}}{=} g_w^n \quad \forall n \ge 1.$$

(b)
$$Y_w^n = \widetilde{\mathfrak{B}}^*(n) + O\left(n^{\frac{1}{2}-\gamma}\right)$$
, ν -a.e.

Further,

$$\limsup_{n \to \infty} \frac{g_w^n(x)}{\varsigma_w(g)\sqrt{2n\log\log n}} = 1, \quad \lambda\text{-a.e.}$$

14 Concluding remarks

As stated in the introductory section, the theorems proved in this paper are easily transferable to several other analogous settings of dynamical systems. We conclude this paper by merely pointing to some of those.

- Instead of working with the specified interval maps $T_d: I \longrightarrow I$ of degree (d+1) for $1 \le d \le N$ given by $T_d(x) = (d+1)x \pmod{1}$, one may well consider the action of any N (piecewise) linear interval maps, $S_d: I \longrightarrow I$; $1 \le d \le N$, each with integer degree at least 2. The measure, in this case still remains Lebesgue.
- One might as well consider the simple monomial maps P_d ; $1 \leq d \leq N$, defined on the Riemann sphere $\overline{\mathbb{C}} = \mathbb{C} \cup \{\infty\}$ and given by $P_d(z) = z^{k_d}$ where $k_d \geq 2$ for all $1 \leq d \leq N$. We know from, say [2], that the Julia set $\mathbb{J}(P_d)$ of the monomial map P_d is the unit circle \mathbb{S}^1 in \mathbb{C} . In such a case, the Julia set $\mathbb{J}(P)$ of the skew-product map P appropriately defined analogous to equation (2.2) is also the unit circle, as one may find from [42]. Owing to the Julia set $\mathbb{J}(P)$ being completely P-invariant, one may undertake an analogous study, as done in this paper, to the dynamics generated by the monomial maps P_d ; $1 \leq d \leq N$ restricted on the Julia set $\mathbb{J}(P) = \mathbb{S}^1 \subset \mathbb{C}$ and obtain analogous results, employing the Haar measure on \mathbb{S}^1 .
- Let R_d ; $1 \le d \le N$ be a collection of rational maps acting on the Riemann sphere $\overline{\mathbb{C}}$; each with degree $k_d \ge 2$. We suppose that the rational maps are so chosen that the Julia set $\mathbb{J}(R_d)$ of the map R_d is topologically connected. Then, defining the skew-product map R appropriately and restricting its action on the R-invariant Julia set $\mathbb{J}(R)$, as one may obtain from [42], it is possible to investigate analogous results for Boyd's measure, as defined in [6]. It must be borne in mind that the Boyd's measure is a generalisation of the Lyubich's measure, as in [26].

- Finally, we consider the dynamical system obtained by iterating certain relations on \mathbb{C} . The relation can be explained as the zero set of a polynomial, say $Q \in \mathbb{C}[\zeta, \omega]$ of a certain form such that:
 - $-Q(\cdot,\omega)$ and $Q(\zeta,\cdot)$ are generically multiple-valued;
 - if \mathscr{G}_Q denotes the biprojective completion of $\{Q = 0\}$ in $\overline{\mathbb{C}} \times \overline{\mathbb{C}}$, then no irreducible component of \mathscr{G}_Q is of the form $\{a\} \times \overline{\mathbb{C}}$ or $\overline{\mathbb{C}} \times \{a\}$, where $a \in \overline{\mathbb{C}}$.

Such dynamical systems have been studied by Dinh and Sibony in [16] and Bharali and Sridharan in [3]. Upon satisfying certain technical conditions, one may study analogous dynamical and statistical properties with respect to the Dinh-Sibony measure, when the action of the holomorphic correspondence $Q(\zeta, \omega)$ is restricted on the support of the Dinh-Sibony measure, as defined in [16, 3].
