# THE CAUCHY PROBLEM FOR NON-ISENTROPIC COMPRESSIBLE NAVIER-STOKES/ALLEN-CAHN SYSTEM WITH DEGENERATE HEAT-CONDUCTIVITY

#### Abstract

The Cauchy problem for non-isentropic compressible Navier-Stokes/AllenCahn system with degenerate heat-conductivity $\kappa(\theta)=\tilde{\kappa} \theta^{\beta}$ in $1-\mathrm{d}$ is discussed in this paper. This system is widely used to describe the motion of immiscible two-phase flow in numerical simulation. The wellposedness for strong solution of this problem is established with the $H^{1}$ initial data for density, temperature, velocity, and the $H^{2}$ initial data for phase field. The result shows that no discontinuity of the phase field, vacuum, shock wave, mass or heat concentration will be developed at any finite time in the whole space. From the hydrodynamic point of view, this means that no matter how complex the interaction between the hydrodynamic and phase-field effects, phase separation will not occur, but the phase transition is possible.


## 1. Introduction

Coolant in nuclear power systems is usually operated at high temperature and pressure, therefore, compressible two-phase flow is often encountered, for example, the saturated water-vapor systems, etc. The similar phenomenon occurs in the flow of multipolymers in chemical industries. In this paper, we study the Cauchy problem for compressible nonisentropic Navier-Stokes/Allen-Cahn system proposed by Heida-Málek-Rajagopal [10] (or see Blesgen [2]). This system is an important mathematical model for the numerical simulation of compressible immiscible two-phase flow, an important feature of this model is that the diffusion interface between phases represents the free boundary between phases, described as following:

where $\tilde{\mathbf{x}} \in \mathbb{R}^{N}$ is the spatial variable, $\tilde{t}$ the time, $N$ the spatial dimension. The unknown functions $\rho(\tilde{\mathbf{x}}, \tilde{t}), \mathbf{u}(\tilde{\mathbf{x}}, \tilde{t}), \theta(\tilde{\mathbf{x}}, \tilde{t}), \phi(\tilde{\mathbf{x}}, \tilde{t})$ denote the total density, the velocity, the absolute temperature and the phase field of the immiscible two-phase flow respectively. $\mu(\tilde{\mathbf{x}}, \tilde{t})$ is the

[^0]chemical potential, $f$ the phase-phase interfacial free energy density, here we consider its common form as following (see Lowengrub-Truskinovsky [24], Heida-Málek-Rajagopal [10])

where $\epsilon>0$ the thickness of the interface between the phases. The Cauchy stress-tensor $\mathbb{T}$ is represented by

In the expression (1.3), $\mathbb{I}$ is the unit matrix, $\mathbb{D} \mathbf{u}$ is the so-called deformation tensor

here the superscript $T$ denotes the transpose and all vectors are column ones. The positive constants $\tilde{\nu}>0, \tilde{\lambda}>0$ are viscosity coefficients, satisfying

The total energy density $\rho E$ is given by

where $\rho e$ is the internal energy, $\frac{\rho \mathbf{u}^{2}}{2}$ the kinetic energy. The pressure $p$, entropy $s$ and $\rho$, $e, f$ obey the second law of thermodynamics

Throughout this paper, we consider the ideal polytropic gas, that is,

where $c_{v}$ is the specific heat capacity. $\kappa(\theta)$ is the heat conductivity satisfying

with positive constants $\tilde{\kappa}>0$ and $\beta>0$.
Remark 1.1. The assumption (1.11) is based on the following reason: the heat conductivity $\kappa$ of compressible immiscible two-phase flow vary with temperature under very high temperature and density environment. Strictly speaking, the Chapman-Enskog expansion for the first order approximation tells us, the coefficient of heat conduction depends on temperature (see Chapman-Colwing [3]).

Substituting (1.2), (1.3), (1.6), (1.9) and (1.10) into (1.1), then (1.1) is simplified as

In order to study the wellposedness of Cauchy problems for (1.12), we start with the one-dimensional case for the system (1.12) in this paper. Without loss of generality, we define

and we assume that $\nu=R=c_{v}=\tilde{\kappa}=1$. By using Lagrange coordinate transformation

then the Cauchy problem for system (1.12) in 1-D can be rewritten as

Remark 1.2. What we want to point out here is that, (1.16) implies that initial concentration difference $\phi_{0}$ of the immiscible two-phase flow is 1 or -1 at far fields.

Before giving the main theorem, we will briefly review the relevant work of (1.15) that has been done. For the Cauchy problem of compressible non-isentropic Navier-Stokes equations with constant coefficient of heat conduction ( $\beta=0$ in (1.11)) in 1-d (that is $\phi \equiv 1$ in (1.15)), Kanel [19] obtained the solvability and the behavior of the solution as $t \rightarrow \infty$ under the assumption that the initial functions are small perturbations of the constants. Kazhikhov [18] presented the global existence of solutions without any restrictions on the smallness of the initial data. Jiang [17] proved that in any bounded interval, the specific volume is pointwise bounded from below and above for all $t \geq 0$ and a generalized solution is convergent as $t \rightarrow \infty$. Li-Liang [22] got the boundedness of the temperature from below and above independently of both time and space, and they shown that the global solution is asymptotically stable as time tends to infinity for large initial perturbations.

For higher dimensional problems of non-isentropic compressible Navier-Stokes equations, Matsumura-Nishada [25] proved that there exists a unique global solution for the small initial data in 3-d. For the isentropic case, Lions [23] obtained global existence
of finite energy weak solutions when the exponent $\gamma$ is suitably large, Huang-Li-Xin [13] established the global existence and uniqueness of classical solutions with smooth initial data which are of small energy but possibly large oscillations with constant state as far field which could be vacuum.

When the coefficient of heat conduction $\kappa$ depend on temperature, Kawohl [20], Jiang $[15,16]$ and Wang [27] established the global existence of smooth solutions for the compressible non-isentropic Navier-Stokes equations in 1-d bounded domain. However, the methods they used rely heavily on the non-degeneracy of the heat conductivity $\kappa$ and cannot be applied directly to the degenerate and nonlinear case $(\beta>0$ in (1.11)). Under the assumption that $\beta \in(0,3 / 2)$, Jenssen-Karper [14] proved the global existence of weak solutions. Later, for $\beta \in(0, \infty)$, Pan-Zhang [26] obtain the global strong solutions. In $[14,26]$, they only consider the case of non-slip and heat insulated boundary conditions. For the case of stress-free and heat insulated boundary condition, Duan-Guo-zhu [7] obtain the global strong solutions under the condition that $\left(v_{0}, u_{0}, \theta_{0}\right) \in H^{1} \times H^{2} \times H^{2}$. Recently, Huang-Shi-Sun [11], Huang-Shi [12] obtained the existence, uniqueness and the large time behavior of the global strong solutions for $\beta>0$ with the conditions on the initial data $\left(v_{0}, u_{0}, \theta_{0}\right) \in H^{1}$.

For the non-isentropic compressible Navier-Stokes/Allen-Cahn system (1.1), Kotschote [21] obtained the existence and uniqueness of local strong solutions in bounded domain recently. For about the isentropic Navier-Stokes/Allen-Cahn problem, Feireisl-Petzeltová-Rocca-Schimperna [8] presented the global existence of a weak solution based on the renormalization weak solution framework introduced by Lions [23]. Ding-Li-Lou [6] established the existence and uniqueness of global strong solution for initial boundary problem in 1-D. Moreover, Chen-Guo [5] extend the result of [6] to the case where the initial value contains vacuum.

It should be noted that all known works about (1.1) are concentrated on isentropic problems over bounded regions, and the coefficient of heat conduction is assumed constant ( $\beta=0$ in (1.11)). The purpose of this paper is to gain an in-depth understanding of phase transition and phase separation phenomena for immiscible two-phase flow. We will study the existence and uniqueness of global strong solutions for Cauchy problem of (1.15)-(1.16) for $\beta>0$. The following Theorem is our main result:

Theorem 1.1. Assume that

Then, the Cauchy problem (1.15)-(1.16) has a unique strong solution $(v, u, \theta, \phi)$ such that for fixed $T>0$, satisfying

Moreover, there exists a positive constant $C$ depending on the initial data and $T$, satisfying

Remark 1.3. Theorem 1.1 shows that no discontinuity of the phase field, vacuum, shock wave, mass or heat concentration will be developed in finite time as the initial data ( $v_{0}, u_{0}$, $\left.\theta_{0},\left|\phi_{0}\right|\right)(x) \xrightarrow{x \rightarrow \pm \infty}(1,0,1,1)$. Which means that no matter how complex the interaction between the hydrodynamic and phase-field effects, as well as the the the motion of the compressible two-phase immiscible flow has large oscillations, there is no separation of the phase field in the finite time.

Now we briefly describe some key points of proof for Theorem 1.1. The most important of the proof is to get the positive upper bound and the lower bound of $v, \theta$ and $\phi$. Otherwise the system (1.15) will degenerate. For this purpose, firstly, inspired by the idea of Kazhikhov [18] and Jiang [17], we obtain a key expression of $v$ (see (2.11)). Secondly, using the expression of $v$, combining with the basic energy estimate (2.2), the truncation function method, and the convexity of $y-\ln y-1$, we get the lower bound of $v$ and $\theta$ (see (2.18)). Further, after observing the key inequality (see (2.34))

the upper bound of $v$ can be derived. Finally, with the help of the key inequality as following (see (2.43)),

the higher order energy estimates for $\phi$ and $v$ can be achieved through the tedious energy estimates, (see (2.37), (2.54)). In particular, the upper bound of $\left\|\theta_{x}\right\|_{L^{\infty}\left(0, T ; L^{2}\right)}$ is derived (see (2.69)), and thus the upper bound of temperature $\theta$ is achieved. The whole procedure of the proof will be carried out in the next section.

## 2. The Proof of Theorem

The local existence and uniqueness for strong solutions of (1.15)-(1.16) is presented as following which can be proved by the fixed point method, the details are omitted here.

Lemma 2.1. Let (1.17) and (1.18) hold, then there exists some $T_{*}>0$ such that, the Cauchy problem (1.15)-(1.16) has a unique strong solution ( $v, u, \theta, \phi$ ) satisfying

With the existence of a local solution, Theorem 1.1 can be achieved by extending the local solutions globally in time from the following series of prior estimates. Without loss of generality, in the following prior estimates, we assume that $\nu=R=c_{v}=\tilde{\kappa}=1$, and

From here to the end of this paper, $C>0$ denotes the generic positive constant depending only on $\left\|v_{0}-1, u_{0}, \theta_{0}-1\right\|_{H^{1}(\mathbb{R})},\left\|\phi_{0}^{2}-1\right\|_{L^{2}(\mathbb{R})},\left\|\phi_{0 x}\right\|_{H^{1}(\mathbb{R})}, \inf _{x \in \mathbb{R}} v_{0}(x)$, and $\inf _{x \in \mathbb{R}} \theta_{0}(x)$.

Lemma 2.2. Let $(v, u, \theta, \phi)$ be a smooth solution of (1.15)-(1.16) on $(-\infty,+\infty) \times[0, T]$.

Integrating (2.7) over $(-\infty,+\infty) \times[0, T]$ by parts, (2.3) is obtained, the proof of Lemma 2.2 is finished.

& \theta\left(b_{n}(t), t\right) \stackrel{\text { def }}{=} \bar{\theta}_{n}(t)=\int_{n}^{n+1} \theta(x, t) d x \in\left[\alpha_{1}, \alpha_{2}\right],
\end{align*}
$$

where $0<\alpha_{1}<\alpha_{2}$ are the two roots of the following algebraic equation

& \leq \frac{1}{2} \int_{-\infty}^{+\infty} \frac{u_{x}^{2}}{v \theta^{p}} \varphi_{n} d x+\frac{1}{2} \int_{-\infty}^{+\infty} \frac{1}{v \theta^{p-2}} \varphi_{n} d x+\frac{p}{2} \int_{-\infty}^{+\infty} \frac{\theta^{\beta} \theta_{x}^{2}}{v \theta^{p+1}}\left|\varphi_{n x}\right| d x+\frac{1}{2 p} \int_{-\infty}^{+\infty} \frac{\theta^{\beta}}{v \theta^{p-1}}\left|\varphi_{n x}\right| d x \\

\frac{\theta^{\beta} \theta_{x x}}{v}=\theta_{t}-\frac{\beta \theta^{\beta-1} \theta_{x}^{2}}{v}+\frac{\theta^{\beta} \theta_{x} v_{x}}{v^{2}}+\frac{\theta u_{x}}{v}-\frac{u_{x}^{2}+(v \mu)^{2}}{v}, \tag{2.78}
\end{equation*}
$$

which yields that

$$
\int_{0}^{T} \int_{-\infty}^{+\infty} \theta_{x x}^{2} d x d t \leq C \int_{0}^{T} \int_{-\infty}^{+\infty}\left(\theta_{x}^{2} v_{x}^{2}+\theta_{x}^{4}+u_{x}^{4}+\mu^{4}+u_{x}^{2}+\theta_{t}^{2}\right) d x d t
$$

$$
\begin{align*}
& \leq C(\delta)+C \delta \int_{0}^{T} \sup _{x \in \mathbb{R}} \theta_{x}^{2} d t \\
& \leq C(\delta)+C \delta \int_{0}^{T} \int_{-\infty}^{+\infty} \theta_{x x}^{2} d x d t \tag{2.79}
\end{align*}
$$

Furthermore, by using maximum principle, we obtain $-1 \leq \phi \leq 1$. The proof of Lemma 2.10 is completed.

So far, from the a priori estimates of solutions (see Lemma 2.1-Lemma 2.10), Theorem 1.1 can be obtained by extending the local solutions globally in time. For details, please refer to [6], [11], and the references therein.
