# Hawkes process and Edgeworth expansion with application to maximum likelihood estimator

#### Abstract

We provide a rigorous mathematical foundation of the theory for the higher-order asymptotic behavior of the one-dimensional Hawkes process with an exponential kernel. As an important application, we give the second-order asymptotic distribution for the maximum likelihood estimator of the exponential Hawkes process.


## 1 Introduction

The Hawkes process was introduced by Hawkes(1971). It has a self-exciting property and has been used to model earthquakes and their aftershocks, events in social media, infectious diseases and so on. Furthermore, in the field of finance, the multivariate Hawkes process has also been used for modeling the whole limit order book; for example, see Abergel et al.(2016)Abergel, Anane, Chakraborti, Jedidi, and Toke.

Regarding statistical inference for the Hawkes process, the quasi maximum likelihood estimator (QMLE) and the quasi Bayesian estimator (QBE) are practical. Clinet and Yoshida(2017) established the consistency, the asymptotic normality and the convergence of moments of these estimators for the multivariate Hawkes process with exponential kernels. Roughly, the asymptotic normality of an estimator $\hat{\theta}_{T}$ is characterized as follows.

for some appropriate functions $f$, where $g$ is the Fisher information matrix, $\phi\left(x ; g^{-1}\right)$ is the probability density function of the normal distribution $N\left(0, g^{-1}\right)$ and $\theta_{0}$ is the true parameter.

As a real problem, there are often situations where we can not obtain data with sufficient observation time. In such cases, it is not appropriate to approximate the error distribution of an estimator by the normal distribution. Then, the derivation of confidence intervals and hypothesis testing cannot be performed accurately. If we establish a theory of Edgeworth expansion for the distribution of an estimator $\hat{\theta}_{T}$, we get an improved error evaluation. Edgeworth expansion is obtained by formally expanding the characteristic function and applying the inverse Fourier transform. Roughly, we may have the following evaluation in the case of the second-order expansion.

for some appropriate functions $f$, where $q_{T, 3}(x) d x$ is some signed measure.

[^0]In this paper, we deal with the one-dimensional Hawkes process with an exponential kernel and establish the Edgeworth expansion for the distribution of its maximum likelihood estimator (MLE). The outline of the concrete proofs is as follows.

In the case of independent identical distribution, the validity of the Edgeworth expansion for an MLE is reduced to the expansion of a log-likelihood process. Same as the i.i.d. case, [Sakamoto and Yoshida(2004)] gave the asymptotic expansion for an M-estimator of a functional of an $\epsilon$-Markov process with a mixing property. In the case of MLE, the essence of the theory of the asymptotic expansion lies in the analysis of a log-likelihood process. With this background, we deal with the asymptotic expansion for the class of functionals of the Hawkes process containing the derivatives of the log-likelihood process.

To prove the validity of (1.1), we prepare the theory of Edgeworth expansion for the distribution of a functional of a geometric mixing process. For discrete-time processes, the scheme of this theory was established by Götze and Hipp(1983). It was extended to a continuous-time case in Kusuoka and Yoshida(2000). Moreover, Yoshida(2004)] dealt with a more general framework. We will reduce their theory to a simple framework without the Cramér-condition. Furthermore, we have developed a framework that is not confined to the non-degeneracy of variance by appropriately modifying the variance of the random variables.

Second, we will apply the theory of the Edgeworth expansion to the derivatives of the log-likelihood process of the exponential Hawkes process. In this application, we introduce the Hawkes core process. In the proof of this theory, it is essential to confirm the conditions regarding the mixing property and the finiteness of moments of the Hawkes core process. The mixing property of the Hawkes core process follows from its Markovian property and geometric ergodicity. It is known that the exponential Hawkes intensity process has the Markovian property, see Oakes(1975). However, we introduce a new proof including a method applicable to the Hawkes core process. We investigate these properties by using the idea of the extended generator.

Finally, we give the second-order asymptotic distribution for the MLE of the exponential Hawkes process. In this regard, we confirm some conditions for the log-likelihood process.

Numerical calculations of the asymptotic distribution using the Monte Carlo method are also presented. Furthermore, the results of the simulations with R confirm that the asymptotic distribution we introduced is a better approximation than the approximation by the normal distribution.

Section 2 presents a theory of the Edgeworth expansion for the distribution of a functional of a geometric mixing process. It also describes how to apply the Edgeworth expansion to an MLE. In Section 3, we see the properties of the one-dimensional Hawkes process with an exponential kernel. It is difficult to directly express the derivative of the log-likelihood process as a functional of the Hawkes intensity. Therefore, we introduce the Hawkes core process and also investigate its properties. In Section 4, we will apply the theory of the Edgeworth expansion to a functional of the Hawkes core process. In particular, we give the concrete form of the second-order asymptotic distribution for the MLE of the exponential Hawkes process. Finally, Section 5 shows the simulation results about the second-order asymptotic distribution for the MLE of the exponential Hawkes process. The details of the proofs in each section are summarized in Appendix.

## 2 Asymptotic expansion

### 2.1 Asymptotic expansion under geometric mixing condition

In this section, we introduce the theory of Edgeworth expansion for the distribution of a functional of a geometric mixing process. The following framework is given by Theorem 2.10 in Götze and Hipp(1983)] for discrete-time processes. It is extended to a continuous-time case under the conditional Cramér-condition in Yoshida(2004). In this paper, we rewrite this theory without using the Cramér-condition, referring to Götze and Hipp(1978).

Let $(\Omega, \mathscr{F}, P)$ be a probability space. Assume that we are given $\sigma$-fields $\left\{\mathscr{B}_{I}\right\}$ indexed by intervals $I \subset \mathbb{R}_{+}$. We consider a process $Z=\left(Z_{t}\right)_{t \in \mathbb{R}_{+}}: \Omega \times \mathbb{R}_{+} \rightarrow \mathbb{R}^{d}$ whose increment is adapted to $\mathscr{B}_{I}$, namely $Z_{I}=Z_{t}-Z_{s} \in$ $\mathscr{F} \mathscr{B}_{1}^{1]}$ for every closed interval $I=[s, t] \subset \mathbb{R}_{+}$with $s<t$ and $Z_{0} \in \mathscr{F} \mathscr{B}_{\{0\}}$. We will derive the asymptotic expansion for the distribution of the normalized process $S_{T}=Z_{T} / \sqrt{T}$. For this purpose, we assume that the following two conditions hold.

[^1][A1](Geometric mixing property)
There exists a positive constant $a$ such that for any $s, t \in \mathbb{R}_{+}$with $s \leq t$, and for any $f \in \mathscr{F}_{[0, s]}$ and $g \in \mathscr{F} \mathscr{B}_{[t, \infty)}$ with $\|f\|_{\infty} \leq 1$ and $\|g\|_{\infty} \leq 1$,

[A2](Moment property)
$\sup _{t \in \mathbb{R}_{+}, 0 \leq h \leq \Delta}\left\|Z_{[t, t+h]}\right\|_{L^{p}(P)}<\infty$ and $E\left[Z_{[t, t+\Delta]}\right]=0$ for any $\Delta>0$ and $p>0$. Moreover, $Z_{0} \in$ $\bigcap_{p>1} L^{p}(P)$ and $E\left[Z_{0}\right]=0$.

These conditions [A1] and [A2] are needed for the validity of the formal Edgeworth expansion. Before starting the statement of the asymptotic expansion, we prepare some notation under the condition [A2]. The $r$-th cumulant functions $\chi_{T, r}(u)$ of $S_{T}$ are defined by

where $u^{\prime}$ represents the transpose of $u$. Then, since $\chi_{T, 1}(u)=E\left[i u^{\prime} S_{T}\right]=0$, the characteristic function of $S_{T}$ is formally expressed as

Next, we define functions $\tilde{P}_{T, r}(u)$ by the formal Taylor expansion at $\epsilon=0$ :

Let $\hat{\Psi}_{T, p}(u)$ be the partial sum of the right-hand side of (2.1) with $\epsilon=1$ :

We want to define a signed measure $\Psi_{T, p}$ as the Fourier inversion of $\hat{\Psi}_{T, p}(u)$. However, when $\chi_{T, 2}(u)$ is not negative definite, $\Psi_{T, p}$ does not have the density function. To overcome this problem, we set $\Sigma_{T, D}=$ $\operatorname{Var}\left[S_{T}\right]+T^{-D} I$ for a positive constant $D$, where $I$ is an identity matrix. Then, we define

where $\phi(x ; \Sigma)$ is the probability density function of the normal distribution $N(0, \Sigma)$. We define a signed measure $\Psi_{T, p, D}$ as the Fourier inversion of $\hat{\Psi}_{T, p, D}(u)$. Then, from (2.4), (2.5), (2.6) and (2.7), the density function $p_{T, p, D}(z)$ of $\Psi_{T, p, D}$ is written as

where $A_{k}$ represents the index sequence $a_{1} \cdots a_{k}$ and if there are same index sequences, summing up them with respect to $a_{1} \cdots a_{k}$ in accordance with the Einstein summation convention. Furthermore if there are different multiple index sequences, we distinguish them, for example,

For positive constants $\Gamma, L_{1}, L_{2}$, we denote by $\mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$ a set of functions $f \in C^{\Gamma}\left(\mathbb{R}^{d}\right)$ with $\sup _{|\alpha| \leq \Gamma}\left|\partial^{\alpha} f(x)\right| \leq$ $L_{2}(1+|x|)^{L_{1}}$ for every $x \in \mathbb{R}^{d}$. The following theorem is the main statement in this subsection. A proof can be found in Appendix.

Theorem 2.1. Let $p \in \mathbb{N}$ with $p \geq 2$ and $L_{1}, L_{2}>0$. Suppose that the conditions [A1] and [A2] are satisfied. Then, there exist $D>0$ and $\Gamma \in \mathbb{N}$ such that for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$,

### 2.2 Asymptotic expansion for maximum likelihood estimator

Applying Theorem 2.1, we consider getting the asymptotic expansion for a maximum likelihood estimator (MLE) up to the second order. We refer to [Sakamoto and Yoshida(2004)] to construct the following framework.

Let $(\Omega, \mathscr{F}, P)$ be a probability space, $\Theta \subset \mathbb{R}^{p}$ be an open bounded convex set and $N_{t}(\theta)$ be a $\mathbb{R}^{d}$-valued stochastic process parameterized by $\theta \in \Theta$. We assume that the log-likelihood process of $N_{t}\left(\theta_{0}\right)$ is given by $l_{T}: \Theta \times \Omega \rightarrow \mathbb{R}$, where $\theta_{0} \in \Theta$ is the true parameter. Then, the MLE $\hat{\theta}_{T}$ is defined by

If there is no confusion, we write $l_{T}(\theta)=l_{T}(\theta, \omega)$. For $r \in \mathbb{N}$ and a sequence of indexes $\mathbb{a}=\left(a_{1}, \ldots, a_{r}\right) \in$ $\{1, \ldots, p\}^{r}$, we write

where $\theta^{a}$; is the $a$-th component of $\theta \in \Theta$. Moreover, $\partial_{\theta}$ denotes the vector differential operator (the gradient operator). Let $l_{a_{1} \ldots a_{k}}(\theta)=\mathbb{D}^{\left(a_{1}, \ldots, a_{k}\right)} l_{T}(\theta)$ and $\nu_{a_{1} \ldots a_{k}}(\theta)=E\left[\frac{1}{T} l_{a_{1} \ldots a_{k}}(\theta)\right]$. We write $g_{T}=\left(g_{a b}\right)_{a, b=1, \ldots, p}=$ $\left(-\nu_{a b}\left(\theta_{0}\right)\right)_{a, b=1, \ldots, p}$. We assume that
[A3] $\left|g_{T}-g\right| \rightarrow 0$ as $T \rightarrow \infty$, where the norm $|\cdot|$ is the Frobenius norm and $g$ is a non-singular matrix.
[B0] $l_{T}(\theta)$ satisfies the following conditions.
(i) $l_{T} \in C^{4}(\Theta)$ a.s.
(ii) the score function $\partial_{\theta} l_{T}(\theta)$ satisfies $E\left[\partial_{\theta} l_{T}\left(\theta_{0}\right)\right]=0$.
(iii) $\operatorname{Var}\left[\frac{1}{\sqrt{T}} \partial_{\theta} l_{T}\left(\theta_{0}\right)\right]=g_{T}$.

Under the condition [A1], $g_{T}$ is non-singular for sufficiently large $T$. We write $g_{T}^{-1}=\left(g^{a b ;}\right)_{a, b=1, \ldots, p}$. The following conditions are assumed for some positive constants $q_{1}, q_{2}, q_{3}$ and $\gamma$.

To get the asymptotic expansion of an MLE, we approximate the MLE with the sum of $\log$-likelihood processes. Let

\end{equation*}

We consider applying the transformation formula for the asymptotic expansion. Let

and we write $\bar{Z}_{T}^{(1)}=\left(Z^{1 ;}, \ldots, Z^{p ;}\right)$ and $\bar{Z}_{T}^{(2)}=\left(Z_{1}^{1 ;}, \ldots, Z_{p}^{p ;}\right)$. We define the polynomial $Q_{1}(z)$ for a $p+p^{2}$ dimensional vector $z=\left(z^{1 ;}, \ldots, z^{p ;}, z_{1}^{1 ;}, \ldots, z_{p}^{p ;}\right)$ such that $a$-th element of $Q_{1}(z)$ is

From (2.13), we can give the asymptotic expansion for the MLE by using the transformation formula. However, it is complicated to calculate the concrete form of the density function $q_{T, 3, D}$ described later. In order to simplify this calculation, the orthogonalization of $\bar{Z}_{T}$ is convenient. We put $\bar{\Sigma}_{T}^{(i, j)}=\operatorname{Cov}\left[\bar{Z}_{T}^{(i)}, \bar{Z}_{T}^{(j)}\right]$ for $i, j=$ 1,2. Remark that $g_{T}^{-1}+T^{-D}\left(g_{T}^{-1}\right)^{2}$ is non-singular for sufficiently large $T>0$. Thus, we can define $\tilde{g}_{T}^{-1}=$ $\left(\tilde{g}^{a b ;}\right)_{a, b=1, \ldots, p}=g_{T}^{-1}+T^{-D}\left(g_{T}^{-1}\right)^{2}$ and $\tilde{g}_{T}=\left(\tilde{g}_{a b}\right)_{a, b=1, \ldots, p}=\left(\tilde{g}_{T}^{-1}\right)^{-1}$. Let

Then an elementary calculation yields

Focus on the main part of (2.14). We set $\tilde{S}_{T}=\tilde{Z}_{T}^{(1)}+T^{-\frac{1}{2}} \tilde{Q}_{1}\left(\tilde{Z}_{T}^{(1)}, \tilde{Z}_{T}^{(2)}\right)$. The following proposition holds, see Appendix for a proof.
Proposition 2.2. Let $L_{1}, L_{2}>0$. Suppose that the conditions [A1]-[A3] and [B0] hold. Then, there exist $D>0$ and $\Gamma \in \mathbb{N}$ such that for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$,

& \left.+\tilde{\mu}_{b_{1} b_{2}}^{a_{1} ;} \tilde{g}^{b_{1} b_{2} ;} h_{a_{1}}\left(z^{(1)} ; \tilde{g}_{T}^{-1}\right)\right\} \phi\left(z^{(1)} ; \tilde{g}_{T}^{-1}\right)

We need to evaluate the remainder term $\check{R}_{2}$ in (2.14). The conditions [B0]-[B4] lead to the following proposition. We will give a proof in Appendix.
Proposition 2.3. Let $L>1, \gamma \in(0,1)$ and $q_{1}, q_{2}, q_{3}>0$ with

For these constants, we assume that the conditions [B0]-[B4] hold. Then, there exist $C>0$ and $\epsilon^{\prime} \in(1,0)$ such that

From Proposition 2.2 and Proposition 2.3 we get the asymptotic expansion for the distribution of the MLE. Remark that, since $g_{T}^{-1}$ is non-singular for large $T>0$ under the condition [A3], we can get rid of a constant $D$. Let $V_{b c}^{a ;}=\operatorname{Cov}\left[Z_{b}^{a ;}, Z^{a_{1} ;}\right] g_{a_{1} c}$ and $\mu_{a_{1} a_{2}}^{a ;}=\left(V_{a_{1} a_{2}}^{a ;}+V_{a_{2} a_{1}}^{a ;}+\nu_{a_{1} a_{2}}^{a ;}\right) / 2$. The following theorem is the conclusion of this section.
Theorem 2.4. Let $L_{1}, L_{2}>0$. Suppose that the conditions [A1]-[A3] and [C1] are satisfied. Moreover, assume that there exist $L>1, \gamma \in(0,1)$ and $q_{1}, q_{2}, q_{3}>0$ such that $[\mathrm{B} 0]-[\mathrm{B} 4]$ with (2.15) hold. Then, there exists $\Gamma \in \mathbb{N}$ such that for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$,

## 3 Hawkes process with an exponential kernel

In this section, we will define the Hawkes process with an exponential kernel whose intensity process starts from a point $x+\mu$. Furthermore, we will see its properties. In the second half, we define the Hawkes core process and investigate its properties. Let $(\Omega, \mathscr{F}, P)$ be a probability space and $\left\{\mathscr{F}_{t}\right\}_{t \in \mathbb{R}_{+}}$be a filtration that satisfies the usual conditions.

### 3.1 Definition

First, we define a point process and its intensity. A sequence of stopping times $\left\{\tau_{n}\right\}_{n \in \mathbb{N}}$ with respect to $\left\{\mathscr{F}_{t}\right\}_{t \in \mathbb{R}_{+}}$ is called a point process, if it satisfies the following properties:
(i) $\tau_{1}>0$ a.s.
(ii) $\tau_{n}<\tau_{n+1}$ on $\left\{\tau_{n}<\infty\right\}$ a.s ${ }^{2}$
(iii) $\tau_{n}=\tau_{n+1}$ on $\left\{\tau_{n}=\infty\right\}$ a.s.

Let $\tau_{\infty}=\lim _{n \rightarrow \infty} \tau_{n}$. Define a stochastic process $N_{t}$ by $N_{t}=\sum_{n \geq 1} 1_{\left\{\tau_{n} \leq t\right\}} 1_{\left\{\tau_{\infty}>t\right\}}$. Then, $\left(N_{t}, \mathscr{F}_{t}\right)$ is also called a point process. Define the intensity process of $\left(N_{t}, \mathscr{F}_{t}\right)$ as a nonnegative $\mathscr{F}_{t}$-progressively measurable process $\lambda_{t}$ such that $\int_{0}^{t} \lambda_{s} d s$ is the compensator of $\left(N_{t}, \mathscr{F}_{t}\right)$. The filtration $\mathscr{F}_{t}$ is called the history of $N_{t}$, in the sense that $\sigma\left(N_{s} ; s \leq t\right) \subset \mathscr{F}_{t}$.

Definition 3.1 (Hawkes process with an exponential kernel). A Hawkes process with an exponential kernel (whose intensity starts from $x+\mu$ ) is a point process $\left(N_{t}^{x}, \mathscr{F}_{t}\right)$ with the $\mathscr{F}_{t}$-predictable intensity

$$
\begin{equation*}
\lambda_{t}^{x}=\mu+x e^{-\beta t}+\int_{(0, t)} \alpha e^{-\beta(t-s)} d N_{s}^{x} \tag{3.1}
\end{equation*}
$$

where $\mu, \alpha$ and $\beta$ are positive constants with $\alpha / \beta<1$ and $x \geq 0$.
The following remarks are fundamental. Let $\mathscr{F}_{t}^{x}=\sigma\left(N_{s}^{x} ; s \leq t\right)$.
Remark 3.2. There exists a Hawkes process with an exponential kernel $N_{t}^{x}$ with the history $\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$. One may prove this existence in the same fashion as the proof of Theorem 1(a) in Brémaud and Massoulié(1996). Moreover, in this construction, the measurability of $x \mapsto N_{t}^{x}$ and $x \mapsto \lambda_{t}^{x}$ are brought about spontaneously.
Remark 3.3. Denote the $n$-th jump time of $N^{x}$ by $\tau_{n}^{x}$ and let $\tau_{\infty}^{x}=\lim _{n \rightarrow \infty} \tau_{n}^{x}$. Then $\tau_{\infty}^{x}=\infty$ a.s. In particular, $N_{t}^{x}$ and $\lambda_{t}^{x}$ have finite paths.

Proof of Remark 3.3. Fix $t \geq 0$ arbitrarily. From the definition of $N_{t}^{x}$, we have

$$
\begin{aligned}
E\left[N_{t \wedge \tau_{n}^{x}}^{x}\right]=E\left[\int_{\left(0, t \wedge \tau_{n}^{x}\right]} \lambda_{s}^{x} d s\right] & =\mu E\left[t \wedge \tau_{n}^{x}\right]+\frac{x}{\beta} E\left[1-e^{-\beta\left(t \wedge \tau_{n}^{x}\right)}\right]+\frac{\alpha}{\beta} E\left[\int_{\left(0, t \wedge \tau_{n}^{x}\right]}\left(1-e^{-\beta\left(t \wedge \tau_{n}^{x}-u\right)}\right) d N_{u}^{x}\right] \\
& \leq \mu t+\frac{x}{\beta}+\frac{\alpha}{\beta} E\left[N_{t \wedge \tau_{n}^{x}}^{x}\right]
\end{aligned}
$$

Thus,

$$
E\left[N_{t \wedge \tau_{n}^{x}}^{x}\right] \leq \frac{\beta \mu t+x}{\beta-\alpha}
$$

However, if $P\left[\tau_{\infty}^{x} \leq t\right]>0$ holds, the above inequality and the monotone convergence theorem imply that $N_{\tau_{\infty}^{x}-}^{x}<\infty$ on $\left\{\tau_{\infty}^{x} \leq t\right\}$ a.s. and it contradict the definition of $\tau_{\infty}^{x}$. Therefore, $\tau_{\infty}^{x}>t$ a.s. Since $t$ is arbitrarily, $\tau_{\infty}^{x}=\infty$ holds almost surely.

### 3.2 Markovian property of exponential Hawkes intensity

The main purpose of this subsection is revealing the Markovian property of the Hawkes process with an exponential kernel. This property is well-known, see Oakes(1975). However, in Oakes(1975), the way of definition of the Hawkes process is somewhat different from ours. Therefore, to strictly handle the Markovian property under our settings and to make this paper self-contained, we will give another proof via the extended generator of the intensity process $\lambda_{t}^{x}$ that is defined later. In this subsection, we deal with the outline only. The detail of proofs can be found in Appendix.

Before getting into the main topic, we define some symbols used throughout this and the next Subsection. Let $N_{t}^{x}$ be a Hawkes process as defined in Definition 3.1 and set $\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$as the history of $N^{x}$. By considering a sufficiently rich $\Omega,\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$is regarded as a right-continuous filtration, see Lemma 18.4 in Liptser and Shiryaev(2000). Moreover, we regard that $\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$is augmented and use the same notation $\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$. Then, $\left\{\mathscr{F}_{t}^{x}\right\}_{t \in \mathbb{R}_{+}}$satisfies the usual condition.

First, we see that $\lambda_{t}^{x}$ has the finiteness of its moment. To show this property, we prepare the following lemma that is shown in the proof of Proposition4.5 in Clinet and Yoshida(2017).

Lemma 3.4. Let $\alpha, \beta$ and $\mu$ be parameters of the Hawkes process $N_{t}^{x}$. For a differentiable function $f$, we define the operator $\mathscr{A}$ by

$$

\mathscr{A} f(y)=y(f(y+\alpha)-f(y))-\beta(y-\mu) \frac{d}{d y} f(y) \tag{3.2}
\end{equation*}
$$

Then, there exist positive constants $M_{1}, K_{1}$ and $K_{2}$ such that for $V(y)=e^{M_{1} y}$

\mathscr{A} V(y) \leq-K_{1} V(y)+K_{2} .
$$

Lemma 3.4 ensures the existence of the moment-generating function of $\lambda_{t}^{x}$ on a neighborhood of the origin:
Proposition 3.5. There exists a positive constant $M_{1}$ such that

\sup _{t \in \mathbb{R}_{+}} E\left[e^{M_{1} \lambda_{t}^{x}}\right]<\infty
$$

Second, we see the Markov property of the exponential Hawkes intensity. To show this property, we use the idea of the extended generator that is an extension of the infinitesimal generator. It can be found, for instance, by Meyn and Tweedie(1993b).

Definition 3.6. Let $\left(X_{t}, \mathscr{F}_{t}\right)$ be a d-dimensional adapted process. We denote by $\operatorname{Dom}(\mathscr{A})$ the set of all measurable functions $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$ for which there exists a measurable function $U: \mathbb{R}^{d} \rightarrow \mathbb{R}$ such that $f\left(X_{t}\right)-f\left(X_{0}\right)-\int_{(0, t]} U\left(X_{s}\right) d s$ is a $\mathscr{F}_{t}$-martingale. Then, we write $U=\mathscr{A} f$ and call $\mathscr{A}$ as the extended generator of $\left(X_{t}, \mathscr{F}_{t}\right)$.

For a differentiable function $f: \mathbb{R} \rightarrow \mathbb{R}$, we define the operator $\mathscr{A}$ by (3.2) as one of the extended generator of $\left(\lambda_{t}^{x}, \mathscr{F}_{t}^{x}\right)$. We investigate the domain of $\mathscr{A}$. Let $\mathscr{P}=\{$ polynomial functions on $\mathbb{R}\}$. Then, the next lemma follows.

Lemma 3.7. $\mathscr{P} \subset \operatorname{Dom}(\mathscr{A})$.
From Lemma 3.7 and the definition of $\mathscr{A}, \mathscr{A}^{k} p \in \operatorname{Dom}(\mathscr{A})$ holds for any $p \in \mathscr{P}$ and $k \in \mathbb{N}$. Therefore, for any
$p \in \mathscr{P}$, an inductive calculation yields

E\left[p\left(\lambda_{t}^{x}\right)-p\left(\lambda_{s}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] & =E\left[\int_{(s, t]} \mathscr{A} p\left(\lambda_{u_{1}}^{x}\right) d u_{1} \mid \mathscr{F}_{s}^{x}\right]=\int_{(s, t]} E\left[\mathscr{A} p\left(\lambda_{u_{1}}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] d u_{1} \\
& =(t-s) \mathscr{A} p\left(\lambda_{s}^{x}\right)+\int_{(s, t]} E\left[\mathscr{A} p\left(\lambda_{u_{1}}^{x}\right)-\mathscr{A} p\left(\lambda_{s}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] d u_{1} \\
& =(t-s) \mathscr{A} p\left(\lambda_{s}^{x}\right)+\int_{(s, t]} E\left[\int_{\left(s, u_{1}\right]} \mathscr{A}^{2} p\left(\lambda_{u_{2}}^{x}\right) d u_{2} \mid \mathscr{F}_{s}^{x}\right] d u_{1} \\
& =(t-s) \mathscr{A} p\left(\lambda_{s}^{x}\right)+\int_{(s, t]} \int_{\left(s, u_{1}\right]} E\left[\mathscr{A}^{2} p\left(\lambda_{u_{2}}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] d u_{2} d u_{1} \\
& =\cdots=\sum_{k=1}^{n-1} \frac{(t-s)^{k}}{k!} \mathscr{A}^{k} p\left(\lambda_{s}^{x}\right)+\int_{(s, t]} \int_{\left(s, u_{1}\right]} \ldots \int_{\left(s, u_{n-1}\right]} E\left[\mathscr{A}^{n} p\left(\lambda_{u_{n}}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] d u_{n} \ldots d u_{2} d u_{1},
\end{aligned}
$$

where $\mathscr{A}^{k} p\left(\lambda_{t}^{x}\right)$ means $\left.\mathscr{A}^{k} p(y)\right|_{y=\lambda_{t}^{x}}$. Furthermore, the remainder term converges to 0 in $L^{1}$-sense, that is;
Lemma 3.8. For any $p \in \mathscr{P}$,

\int_{(s, t]} \int_{\left(s, u_{1}\right]} \cdots \int_{\left(s, u_{n-1}\right]} E\left[\mathscr{A}^{n} p\left(\lambda_{u_{n}}^{x}\right) \mid \mathscr{F}_{s}^{x}\right] d u_{n} \ldots d u_{2} d u_{1} \rightarrow 0 \quad \text { as } n \rightarrow \infty \text { in } L^{1} .
$$

Set the operator $e^{(t-s) \mathscr{A}} f\left(\lambda_{s}^{x}\right)=\sum_{k=0}^{\infty} \frac{(t-s)^{k}}{k!} \mathscr{A}^{k} f\left(\lambda_{s}^{x}\right)$ for a function $f$. From Lemma3.8, we have $E\left[p\left(\lambda_{t}^{x}\right) \mid \mathscr{F}_{s}^{x}\right]=$ $e^{(t-s) \mathscr{A}} p\left(\lambda_{s}^{x}\right)$ a.s. for any $p \in \mathscr{P}$. Then, since $e^{(t-s) \mathscr{A}} p\left(\lambda_{s}^{x}\right)$ is $\sigma\left(\lambda_{s}^{x}\right)$-measurable, we immediately get the Markovian property only for $p \in \mathscr{P}$, i.e.

For the sake of Proposition 3.5 the equation (3.3) can be extended to the Markovian property for any bounded function. We summarize this statement as the following theorem.
Theorem 3.9. For any bounded measurable function $f, E\left[f\left(\lambda_{t}^{x}\right) \mid \mathscr{F}_{s}^{x}\right]=E\left[f\left(\lambda_{t}^{x}\right) \mid \lambda_{s}^{x}\right]$ a.s.

### 3.3 Markovian property and Ergodicity of Hawkes core process

To consider the asymptotic expansion for the MLE of the Hawkes process, we have to deal with the derivatives of the log-likelihood process of the Hawkes process with respect to its parameters. Moreover, these derivatives are represented as functionals of the derivatives of the Hawkes intensity process with respect to time. First, we introduce the concept of the Hawkes core process. For $x_{1} \in \mathbb{R}_{+}$, let $N_{t}^{x_{1}}$ be an exponential Hawkes process with intensity $\lambda_{t}^{x_{1}}=\mu+x_{1} e^{-\beta t}+\int_{(0, t)} \alpha e^{-\beta(t-u)} d N_{u}^{x_{1}}$ defined as in Definition 3.1.

Definition 3.10. For $n \in \mathbb{N}$ and $x=\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}$, we define

$$
X_{t}^{x,(n)}=e^{-\beta t} \sum_{k=1}^{n}\binom{n-1}{k-1} x_{k} t^{n-k}+\int_{(0, t)} \alpha(t-u)^{n-1} e^{-\beta(t-u)} d N_{u}^{x_{1}} .
$$

We call $X_{t}^{x,(n)}$ as the $n$-th Hawkes core process of $N_{t}^{x_{1}}$.
Remark that $X_{t}^{x,(n)}$ is obviously $\sigma\left(X_{u}^{x_{1},(1)} ; u \leq t\right)$-measurable for any $n \in \mathbb{N}$. However, $X_{t}^{x,(n)}-X_{s}^{x,(n)}$ is not $\sigma\left(X_{u}^{x_{1},(1)} ; s<u \leq t\right)$-measurable for $0 \leq s<t$ and $n \geq 2$. When we consider the second order derivative of the Hawkes intensity $\lambda_{t}^{x_{1}}$, the following process is essential:

X_{t}^{x}=\left(X_{t}^{x,(1)}, X_{t}^{x,(2)}, X_{t}^{x,(3)}\right)^{\prime} \tag{3.4}
\end{equation*}
$$

where $x=\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}_{+}^{3} 3$ The detailed reason why we consider $X_{t}^{x}$ is explained in Section 4. Here, we reveal the properties of $X_{t}^{x}$. In this subsection, we deal only with the overview. The detail of proofs can be found in Appendix.

We can also deduce the Markovian property of the process $X_{t}^{x}$.
Proposition 3.11. For any bounded measurable function $f$, $E\left[f\left(X_{t}^{x}\right) \mid \mathscr{F}_{s}^{x}\right]=E\left[f\left(X_{t}^{x}\right) \mid X_{s}^{x}\right]$ a.s. where $\mathscr{F}_{t}^{x}=$ $\sigma\left(X_{s}^{x} ; s \leq t\right)$.

Second, we see the time-homogeneous Markovian property. We define the Markov kernel as below. For $x \in \mathbb{R}_{+}^{3}$ and $A \in \mathscr{B}\left(\mathbb{R}_{+}^{3}\right)$,

P^{t}(x, A)=P\left[X_{t}^{x} \in A\right] . \tag{3.5}
\end{equation*}
$$

For this Markov kernel, the time-homogeneous property holds, i.e.;
Proposition 3.12. For any bounded measurable function $f$,

E\left[f\left(X_{t}^{x}\right) \mid \mathscr{F}_{s}^{x}\right]=\int_{\mathbb{R}_{+}^{3}} f(y) P^{t-s}\left(X_{s}^{x}, d y\right) \quad \text { a.s. }
$$

We concretely give the invariant measure of $X_{t}^{x}$ under our settings. On some probability space $(\bar{\Omega}, \overline{\mathscr{F}}, \bar{P})$, there exists a stationary multivariate Hawkes process $\left(\bar{N}=\left(\bar{N}^{(1)}, \bar{N}^{(2)}, \bar{N}^{(3)}\right), \mathscr{F}_{t}^{\bar{N}}\right)$ with the $\mathscr{F}_{t}^{\bar{N}}$-intensity $\bar{\lambda}_{t}=\left(\bar{\lambda}_{t}^{(1)}, \bar{\lambda}_{t}^{(2)}, \bar{\lambda}_{t}^{(3)}\right)$ such that

$$
\begin{aligned}
\bar{\lambda}_{t}^{(1)}=\mu+\int_{(-\infty, t)} \alpha e^{-\beta(t-s)} d \bar{N}_{s}^{(1)}, & \bar{\lambda}_{t}^{(2)}=\mu+\int_{(-\infty, t)} \alpha(t-s) e^{-\beta(t-s)} d \bar{N}_{s}^{(1)} \\
\text { and } \quad \bar{\lambda}_{t}^{(3)} & =\mu+\int_{(-\infty, t)} \alpha(t-s)^{2} e^{-\beta(t-s)} d \bar{N}_{s}^{(1)},
\end{aligned}
$$

where $\mathscr{F}_{t}^{\bar{N}}=\vee_{i=1}^{3} \mathscr{F}_{t}^{\bar{N}^{(i)}}$ and $\mathscr{F}_{t}^{\bar{N}^{(i)}}=\sigma\left(\bar{N}^{(i)}[C] ; C \in \mathscr{B}(\mathbb{R}), C \subset(-\infty, t]\right)$, see Theorem 7 in Brémaud and Massoulié(1996) We write $\bar{N}=\bar{N}^{(1)}$, allowing the abuse of the notation. Then, the following process $\bar{X}$ is stationary:

Denote the distribution of $\bar{X}_{t}$ by $P^{\bar{X}}$
Proposition 3.13. $P^{\bar{X}}$ is the invariant probability measure for $X_{t}^{x}$, i.e. for any $t \geq 0$ and $A \in \mathscr{B}\left(\mathbb{R}_{+}^{3}\right)$,

P^{\bar{X}}[A]=\int_{\mathbb{R}_{+}^{3}} P^{t}(x, A) P^{\bar{X}}(d x)
$$

Furthermore, $X_{t}^{x}$ has a strong finiteness of moments same as $\lambda_{t}^{x}$
Proposition 3.14. There exists a positive constant vector $M=\left(M_{1}, M_{2}, M_{3}\right)$ such that

$$
\sup _{t \in \mathbb{R}_{+}} E\left[e^{M X_{t}^{x}}\right]<\infty
$$

Finally, similarly to Proposition 4.5 in Clinet and Yoshida(2017)], it is ensured that $X_{t}^{x}$ has the geometric ergodicity in the following meaning.
Proposition 3.15. There exist a positive constant vector $M=\left(M_{1}, M_{2}, M_{3}\right)$ and positive constants $B>0$ and $r \in(0,1)$ such that

Here, for a measurable function $V \geq 1,\|\cdot\|_{V}$ designates the $V$-variation norm, i.e. for any signed measure $\mu$ on a measurable space $(S, \mathscr{S})$,

## 4 Edgeworth expansion for functionals related the Hawkes process

As mentioned in Introduction, both computation of the maximum likelihood estimator (MLE) and simulation methods for the one-dimensional exponential Hawkes process was revealed in Ogata(1979). Furthermore, it was proved that the quasi maximum likelihood estimator (QMLE) of the multi-dimensional exponential Hawkes process has the asymptotic normality and the convergence of moments, see [Clinet and Yoshida(2017)]. In this section, we apply Theorem [2.4 to the MLE of the one-dimensional exponential Hawkes process whose intensity starts from $\mu_{0}$ and we will give the second order asymptotic expansion for the distribution of the MLE. Proofs of each statement are given in Appendix. First, we prepare the necessary notation and establish the conditions.

Let $(\Omega, \mathscr{F}, P)$ be a probability space. As in Definition 3.1. let $N_{t}$ be an exponential Hawkes process with the $\mathscr{F}_{t}=\sigma\left(N_{s} ; s \leq t\right)$-predictable intensity

$$
\lambda_{t}=\mu_{0}+\int_{(0, t)} \alpha_{0} e^{-\beta_{0}(t-s)} d N_{s}
$$

Moreover, we define parametrized intensity process by

$$
\lambda_{t}(\theta)=\mu+\int_{(0, t)} \alpha e^{-\beta(t-s)} d N_{s} \quad \text { for } \theta=(\mu, \alpha, \beta)
$$

Furthermore, we define $X_{t}(\theta)$ by referring (3.4):

$$
X_{t}(\theta)=\left(\int_{(0, t)} \alpha e^{-\beta(t-u)} d N_{u}, \quad \int_{(0, t)} \alpha(t-u) e^{-\beta(t-u)} d N_{u}, \quad \int_{(0, t)} \alpha(t-u)^{2} e^{-\beta(t-u)} d N_{u}\right)^{\prime}
$$

for $\theta=(\mu, \alpha, \beta)$. We consider a relatively compact and open parameter set $\Theta \subset \mathbb{R}_{+}^{3}$. Assume that $\theta_{0}=$ $\left(\mu_{0}, \alpha_{0}, \beta_{0}\right) \in \Theta$ is the true parameter. If there is no confusion, we often omit the true parameter, i.e. write $\lambda_{t}\left(\theta_{0}\right)=\lambda_{t}, X_{t}\left(\theta_{0}\right)=X_{t}$ and so on. The log-likelihood process of $\lambda_{t}(\theta)$ is defined by

$$
l_{T}(\theta)=\int_{0}^{T} \log \left(\lambda_{s}(\theta)\right) d N_{s}-\int_{0}^{T} \lambda_{s}(\theta) d s
$$

for $\theta \in \Theta$. Since Lemma A. 5 in Clinet and Yoshida(2017) guarantees a verification of the permutation of the symbols $\partial_{\theta}$ and $\int_{0}^{T}$, the derivative of the log-likelihood process with respect to their parameter can be calculated as below.

$$
\begin{equation*}
\left.\partial_{\theta} l_{T}(\theta)\right|_{\theta=\theta_{0}}=\int_{0}^{T} \frac{\partial_{\theta} \lambda_{s}}{\lambda_{s}} d \tilde{N}_{s} \tag{4.1}
\end{equation*}
$$

where $\tilde{N}_{t}=N_{t}-\int_{0}^{t} \lambda_{s} d s$. Moreover,

$$
\left.\partial_{\theta}^{2} l_{T}(\theta)\right|_{\theta=\theta_{0}}=\int_{0}^{T} \frac{\partial_{\theta}^{2} \lambda_{s}-\left(\partial_{\theta} \lambda_{s}\right)^{\otimes 2}}{\lambda_{s}^{2}} d \tilde{N}_{s}-\int_{0}^{T} \frac{\left(\partial_{\theta} \lambda_{s}\right)^{\otimes 2}}{\lambda_{s}} d s
$$

where, for a vector $x \in \mathbb{R}^{k}, x^{\otimes 2}$ stands for the product of $x$ and its transpose, i.e. $x^{\otimes 2}=x x^{\prime} \in \mathbb{R}^{k \times k}$. Let the operator $\mathbb{D}$ be as in (2.9), for example, $\mathbb{D}^{2}=\frac{\partial}{\partial \alpha}, \mathbb{D}^{(1,2)}=\frac{\partial^{2}}{\partial \mu \partial \alpha}$, etc. Note that, when we write $X_{t}=\left(X_{t}^{(1)}, X_{t}^{(2)}, X_{t}^{(3)}\right)$, then $\partial_{\theta} \lambda_{s}$ and $\partial_{\theta}^{2} \lambda_{s}$ are computed as
$\partial_{\theta} \lambda_{s}=\left(\begin{array}{c}\mathbb{D}^{1} \lambda_{s} \\ \mathbb{D}^{2} \lambda_{s} \\ \mathbb{D}^{3} \lambda_{s}\end{array}\right)=\left(\begin{array}{c}1 \\ \alpha_{0}^{-1} X_{t}^{(1)} \\ -X_{t}^{(2)}\end{array}\right) \quad$ and $\quad \partial_{\theta}^{2} \lambda_{s}=\left(\mathbb{D}^{(i, j)} \lambda_{s}\right)_{i, j=1,2,3}=\left(\begin{array}{ccc}0 & 0 & 0 \\ 0 & 0 & -\alpha_{0}^{-1} X_{t}^{(2)} \\ 0 & -\alpha_{0}^{-1} X_{t}^{(2)} & X_{t}^{(3)}\end{array}\right)$
respectively. Corresponding to Subsection 2.2, we introduce some notation. Let $l_{a_{1} \cdots a_{k}}(\theta)=\mathbb{D}^{\left(a_{1}, \ldots, a_{k}\right)} l_{T}(\theta)$ and $\nu_{a_{1} \cdots a_{k}}(\theta)=E\left[\frac{1}{T} l_{a_{1} \cdots a_{k}}(\theta)\right]$ for integers $a_{1}, \ldots, a_{k}$. We have the following representations:

$$
\partial_{\theta} l_{T}=\left(l_{1}, l_{2}, l_{3}\right)^{\prime}=\left(\int_{0}^{T} \frac{1}{\lambda_{s}} d \tilde{N}_{s}, \quad \int_{0}^{T} \frac{X_{s}^{(1)}}{\alpha_{0} \lambda_{s}} d \tilde{N}_{s}, \quad-\int_{0}^{T} \frac{X_{s}^{(2)}}{\lambda_{s}} d \tilde{N}_{s}\right)^{\prime}
$$

and $\partial_{\theta}^{2} l_{T}=\left(l_{i j}\right)_{i, j=1,2,3}$, where $l_{i j}$ is symmetric with respect to $i, j$ and each component has the following representation:

& l_{11}=-\left(\int_{0}^{T} \frac{1}{\lambda_{s}^{2}} d \tilde{N}_{s}+\int_{0}^{T} \frac{1}{\lambda_{s}} d s\right), \quad l_{12}=-\frac{1}{\alpha_{0}}\left(\int_{0}^{T} \frac{X_{s}^{(1)}}{\lambda_{s}^{2}} d \tilde{N}_{s}+\int_{0}^{T} \frac{X_{s}^{(1)}}{\lambda_{s}} d s\right) \\
& l_{13}=\int_{0}^{T} \frac{X_{s}^{(2)}}{\lambda_{s}^{2}} d \tilde{N}_{s}+\int_{0}^{T} \frac{X_{s}^{(2)}}{\lambda_{s}} d s, \quad l_{22}=-\frac{1}{\alpha_{0}^{2}}\left(\int_{0}^{T} \frac{\left(X_{s}^{(1)}\right)^{2}}{\lambda_{s}^{2}} d \tilde{N}_{s}+\int_{0}^{T} \frac{\left(X_{s}^{(1)}\right)^{2}}{\lambda_{s}} d s\right) \\

Put $\mathscr{B}_{I}=\bigcap_{\epsilon>0} \sigma\left(X_{u} ; u \in[s, t+\epsilon]\right) \vee \mathscr{N}$ for $I=[s, t] \subset \mathbb{R}_{+}$, where $\mathscr{N}$ is the $\sigma$-field generated by null sets in $\mathscr{F}$. Let

Z_{a}=\frac{1}{\sqrt{T}} l_{a} \quad \text { and } \quad Z_{a b}=\sqrt{T}\left(\frac{1}{T} l_{a b}-\nu_{a b}\right)
$$

Moreover, we write

$$
Z_{T}^{(1)}=T^{\frac{1}{2}}\left(Z_{1}, Z_{2}, Z_{3}\right) \quad \text { and } \quad Z_{T}^{(2)}=T^{\frac{1}{2}}\left(Z_{11}, Z_{12}, Z_{13}, Z_{21}, Z_{22}, Z_{23}, Z_{31}, Z_{32}, Z_{33}\right)
$$

Finally, we set $Z_{T}=\left(Z_{T}^{(1)}, Z_{T}^{(2)}\right)$. Then, $Z_{t}-Z_{s}$ is $\mathscr{B}_{[s, t]}$-measurable for every $s, t \in \mathbb{R}_{+}, 0 \leq s \leq t$ and $Z_{0} \in \mathscr{F} \mathscr{B}_{[0]}$. About the definition of $\mathscr{B}_{I}$, note the following points.

Remark 4.1. Obviously, $\sigma\left(X_{s}^{(1)} ; s \in I\right)=\sigma\left(\lambda_{s} ; s \in I\right)$ holds for any interval $I$.
Remark 4.2. For any $s \geq 0, \sigma\left(X_{s} ; s \in[0, t]\right) \subset \sigma\left(\lambda_{s} ; s \in[0, t]\right)$ holds. However, for a general interval $I$ and $s \in I, X_{s}^{(2)}$ and $X_{s}^{(3)}$ are not always measurable with respect to $\sigma\left(\lambda_{t} ; t \in I\right)$. Thus, if we consider the expansion of the distribution of $Z_{T}$, we have to extend $\sigma\left(\lambda_{t} ; t \in I\right)$. In this reason, we introduced the process $X_{t}$ and defined $\mathscr{B}_{I}$ as above.

Remark 4.3. $\sigma\left(X_{t} ; t \in[u, v]\right)$, in particular $\sigma\left(X_{t}^{(1)} ; t \in[u, v]\right)$, has almost all the information of $\sigma\left(N_{t}-N_{s} ; s, t, \in\right.$ $[u, v])$. However, the information of the jump at $v$ is not contained in $\left.\sigma\left(X_{t} ; t \in[u, v]\right)\right)$. Therefore, we need to consider the right-continuous $\sigma$-fields.

A functional of the process $X_{t}$ has the geometric mixing property.
Proposition 4.4. $\mathscr{B}_{I}$ satisfies the condition [A1].
From Proposition 4.4 and Theorem[2.1] we immediately obtain the asymptotic expansion for the distribution of a functional of the Hawkes core process.

Theorem 4.5. Let $p \in \mathbb{N}$ with $p \geq 2$ and $L_{1}, L_{2}>0$. Assume that a $\mathscr{B}_{I}$-adapted stochastic process $Y_{T}$ satisfies the condition [A2]. Then, there exist $D>0$ and $\Gamma \in \mathbb{N}$ such that for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$,

$$
\left|E\left[f\left(\frac{Y_{T}}{\sqrt{T}}\right)\right]-\int_{\mathbb{R}^{d}} f(z) p_{T, p, D}(z) d z\right|=o\left(T^{-(p-2) / 2}\right)
$$

where $p_{T, p, D}(z)$ is defined as in (2.8) with replaced $Z_{T}$ by $Y_{T}$.

We may also apply Theorem [2.4. Write $g_{T}=\left(g_{a b}\right)_{a, b=1,2,3}=\left(-\nu_{a b}\left(\theta_{0}\right)\right)_{a, b=1,2,3}$. As proved in Appendix, the exponential Hawkes process satisfies the condition [A3]. Thus, we can also define $g_{T}^{-1}=\left(g^{a b ;}\right)_{a, b=1,2,3}$. The following statement is the main theorem of this article. (For the definition of each symbol, see Section 2.)
Theorem 4.6. Let $L_{1}, L_{2}>0$. The conditions [A1]-[A3] and [C1] are satisfied. Moreover, there exist $L>1$, $\gamma \in(0,1)$ and $q_{1}, q_{2}, q_{3}>0$ such that [B0]-[B4] with (2.15) hold. Thus, there exists $\Gamma \in \mathbb{N}$ such that for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$,

- $V_{b c}^{a ;}=\operatorname{Cov}\left[Z_{b}^{a ;}, Z^{a_{1} ;}\right] g_{a_{1} c}$ and $\mu_{a_{1} a_{2}}^{a ;}=\left(V_{a_{1} a_{2}}^{a ;}+V_{a_{2} a_{1}}^{a ;}+\nu_{a_{1} a_{2}}^{a ;}\right) / 2$.


## 5 Simulation

In this section, we show the result of a simulation for Theorem 4.6. We need to compute $g_{T}^{-1}, \tilde{\kappa}_{T}^{a_{1} a_{2} a_{3} ;}$ and $\mu_{a_{1} a_{2}}^{a ;}$ in Theorem 4.6 However, it is difficult to get their expressions for the true parameter. Here, we approximate these values numerically using the Monte Carlo method. It must be emphasized that the simulation here is not exact in this sense. Furthermore, when we model real data by the Hawkes process, of course, we do not know the true parameter. One solution to this problem is to use an estimator instead of the true parameter. This is nothing but the bootstrap method. An error evaluations of the bootstrap method are for further study. All experiments are done by using R. The code can be found on GitHub page https://github.com/goda235/Edgeworth_expansion_for_Hawkes_MLE

By using the algorithm in Ogata(1981), we simulate the values of the Hawkes process for $M C$ times. From these data, we can get $M C$ number of values for the Hawkes core process $X_{s}^{(1)}, X_{s}^{(2)}$ and $X_{s}^{(3)}$, in particular, $M C$ values for $Z_{T}$. From these data, we can get the unbiased estimator of $\operatorname{Var}\left[Z_{T}\right]$. With the help of the condition [B0] (iii), we can compute the value of $g_{T}^{-1}$ from $\operatorname{Var}\left[Z_{T}\right]$. Since $\nu_{a_{1} a_{2} a_{3}}$ have the following representation;

then we can compute an approximated value of $\mu_{a_{1} a_{2}}^{a ;}$ by taking mean. From the representation of cumulants by moment, $\tilde{\kappa}^{a_{1} a_{2} a_{3} ;}$ is computed from means of $Z_{a_{1}} Z_{a_{2}} Z_{a_{3}}$.

We set an exponential Hawkes process $N_{t}$ with its parameters $\mu=0.5, \alpha=1.0$ and $\beta=1.3$, i.e. its intensity $\lambda_{t}$ has the representation

We set an observation time $T=30$. For this model, we compute the MLE for 3000 times and obtain histograms for each parameter. In addition, we add the density function curves for the marginal distribution of $\phi\left(z ; g_{T}^{-1}\right)$ and the marginal distribution of $q_{T, 3}(z)$. Here, $q_{T, 3}(z)$ is computed by the above method with $M C=5000$. The curve of $\phi\left(z ; g_{T}^{-1}\right)$ is described by a broken line, and $q_{T, 3}(z)$ is described by a solid line. The simulation results are as follows.


Figure 1: Histogram of MLE in the case of $T=30$.

We can see that the curve of $q_{T, 3}(z)$ fits the histogram better than the normal distribution. The next figure is $\mathrm{Q}-\mathrm{Q}$ plot for each marginal distribution.


Figure 2: Q-Q plots of each distribution in the case of $T=30$.
The Q-Q plots also shows that $q_{T, 3}(z)$ better fits the data than the normal distribution. Change only the observation time to $T=300$ and try the simulation in the same situation. The result is as follows.


Figure 3: Histogram of MLE in the case of $T=300$.


Figure 4: Q-Q plots of each distribution in the case of $T=300$.

When the observation time is sufficiently large, the approximation by $q_{T, 3}(z)$ is close to the approximation by normal distribution.

## 6 Appendix

Hereafter, when we write as $X(T) \lesssim T^{a}$ for $a \in \mathbb{R}$, it means that there exist positive constants $C$ and $T^{\prime}$ such that $X(T) \leq C T^{a}$ holds for any $T>T^{\prime}$.

### 6.1 Proofs of Subsection 2.1

To prove Theorem 2.1, we should give the asymptotic expansion for the characteristic function of $S_{T}$. The following discussion is a rework of Götze and Hipp(1983)] and Yoshida(2004)] to a form allowed when the variance is non-degenerate.

First, we introduce some notations. Let $N(T)=\lfloor T\rfloor+1$ and divide the interval $[0, T]$ into intervals $\left\{I_{i}\right\}_{i=0, \ldots, N(T)}$ such that $I_{0}=[0,0], I_{i}=[i-1, i]$ for $i=1, \ldots, N(T)-1$ and $I_{N(T)}=[N(T)-1, T]$. Denote $Z_{I_{i}}$ as $Z_{i}$ for any $i=0, \ldots, N(T)^{5}$. There exists a smooth function $\phi: \mathbb{R}^{d} \rightarrow[0,1]$ such that $\phi(x)=1$ if $|x| \leq 1 / 2$, and $\phi(x)=0$ if $|x| \geq 1$. Choose a positive constant $\beta \in\left(0, \frac{1}{2}\right)$ and put $\phi_{T}(x)=x \phi\left(x / 2 T^{\beta}\right)$. Then $\phi_{T}(x)=x$ if $|x| \leq T^{\beta}$ and $\phi_{T}(x)=0$ if $|x| \geq 2 T^{\beta}$. Let $Z_{i}^{*}=\phi_{T}\left(Z_{i}\right)-E\left[\phi_{T}\left(Z_{i}\right)\right]$ for any $i=0, \ldots, N(T)$ and $S_{T}^{*}=T^{-\frac{1}{2}} \sum_{i=0}^{N(T)} Z_{i}^{*}$. Write the characteristic function of $S_{T}^{*}$ by $H_{T}(u)=E\left[e^{i u^{\prime} S_{T}^{*}}\right]$ for $u \in \mathbb{R}^{d}$. For random variables $X$ and $V$, we define $E[X](V)=E\left[X e^{i V}\right] / E\left[e^{i V}\right]$. Define the cumulant of real-valued random variables $X_{1}, \ldots, X_{r}$ shifted by a random variable $V$ as

From the concrete form of $C_{T}$ and $M_{T, D}$, they are clearly non-degenerate and $f \circ M_{T, D} \circ C_{T} \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$ holds for any $f \in \mathscr{E}\left(\Gamma, L_{1}, L_{2}\right)$. Owing to the variable transformation and the multi-linearity of the cumulant, the following inequality is immediately obtained. f\left(\tilde{S}_{T}+T^{-1} \check{R}_{2}\right)-f\left(\tilde{S}_{T}\right)=\sum_{|\alpha|=1} T^{-1} \check{R}_{2} \int_{0}^{1} \partial^{\alpha} f\left(\tilde{S}_{T}+u T^{-1} \check{R}_{2}\right) d u \lesssim T^{-1}\left|\check{R}_{2}\right|\left(1+\left|\tilde{S}_{T}\right|+\left|T^{-1} \check{R}_{2}\right|\right)^{L_{1}}

Hence, $\operatorname{ASS}(\mathrm{k})$ leads $\operatorname{ASS}(\mathrm{k}+1)$ and we have completed the proof.

To prove Theorem 3.9, we prepare the following lemmas.
Lemma 6.6. For any $u \in \mathbb{R}$ and $t \geq s \geq 0, E\left[e^{i u \lambda_{t}^{x}} \mid \mathscr{F}_{s}^{x}\right]=E\left[e^{i u \lambda_{t}^{x}} \mid \lambda_{s}^{x}\right]$ a.s.
Proof. Fix $s$ and $t$ with $t \geq s \geq 0$. It is sufficient to show that for any bounded $\mathscr{F}_{s}^{x}$-measurable function $g: \Omega \rightarrow \mathbb{R}$,

$$

Let $D=\left\{z \in \mathbb{C} ; \operatorname{Re} z<\frac{M_{1}}{2}\right\}$, where $M_{1}$ is the positive constant chosen in Proposition 3.5. First, we will prove that $f(z)=E\left[e^{z \lambda_{t}^{x}} g\right]$ is holomorphic on $D$ for any $\mathscr{F}_{s}^{x}$-measurable function $g$. Let $z=a+i b$, where $a, b \in \mathbb{R}$ with $a<\frac{M_{1}}{2}$. Then, we have

Write $\partial_{a}=\frac{\partial}{\partial a}$ and $\partial_{b}=\frac{\partial}{\partial b} .\left|\partial_{a}\left(\cos \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right)\right|,\left|\partial_{b}\left(\cos \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right)\right|,\left|\partial_{a}\left(\sin \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right)\right|$ and $\left|\partial_{b}\left(\sin \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right)\right|$ are dominated by an integrable random variable $\left|\lambda_{t}^{x} e^{\frac{M_{1}}{2} \lambda_{t}^{x}} g\right|$ on $D$. Hence, the permutation of differential and integral is permitted, and thus we have

$$
\partial_{a} u(a, b)=\partial_{b} v(a, b)=E\left[\lambda_{t}^{x} \cos \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right] \text { and } \partial_{b} u(a, b)=-\partial_{a} v(a, b)=-E\left[\lambda_{t}^{x} \sin \left(b \lambda_{t}^{x}\right) e^{a \lambda_{t}^{x}} g\right]
$$

The Lebesgue's theorem guarantees that $\partial_{a} u(a, b), \partial_{b} u(a, b), \partial_{a} v(a, b)$ and $\partial_{b} v(a, b)$ are continuous with respect to $a$ and $b$. In particular, they are total differentiable. Then, the Cauchy-Riemann relations lead that $f(z)$ is holomorphic on $D$. Completely similarly, we can prove that $z \mapsto E\left[e^{z \lambda_{t}^{x}} E\left[g \mid \lambda_{s}^{x}\right]\right]$ is also holomorphic on $D$.

Second, we will confirm that $E\left[e^{z \lambda_{t}^{x}} g\right]=E\left[e^{z \lambda_{t}^{x}} E\left[g \mid \lambda_{s}^{x}\right]\right]$ for $z \in\left(-\frac{M_{1}}{2}, \frac{M_{1}}{2}\right)$. Let $p_{N}(x)=\sum_{n=0}^{N} \frac{(z x)^{n}}{n!}$. Then, (3.3) leads

E\left[\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} g\right] & =E\left[E\left[\left.\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} g \right\rvert\, \mathscr{F}_{s}^{x}\right]\right]=E\left[E\left[\left.\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} \right\rvert\, \mathscr{F}_{s}^{x}\right] g\right] \\
& =E\left[E\left[\left.\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} \right\rvert\, \lambda_{s}^{x}\right] g\right]=E\left[\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} E\left[g \mid \lambda_{s}^{x}\right]\right]
\end{aligned}
$$

On the other hand, since $\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} \rightarrow e^{z \lambda_{t}^{x}}$ as $N \rightarrow \infty$ and $\left|\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!}\right| \leq\left|\sum_{n=0}^{N} \frac{\left(\frac{M_{1}}{2} \lambda_{t}^{x}\right)^{n}}{n!}\right| \leq e^{\frac{M_{1}}{2} \lambda_{t}^{x}}$ hold for every $z \in\left(-\frac{M_{1}}{2}, \frac{M_{1}}{2}\right)$, we have

$$
\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} g \rightarrow e^{z \lambda_{t}^{x}} g \quad \text { as } N \rightarrow \infty \text { in } L^{1} \text {-sence }
$$

and

$$
\sum_{n=0}^{N} \frac{\left(z \lambda_{t}^{x}\right)^{n}}{n!} E\left[g \mid \lambda_{s}^{x}\right] \rightarrow e^{z \lambda_{t}^{x}} E\left[g \mid \lambda_{s}^{x}\right] \quad \text { as } N \rightarrow \infty \text { in } L^{1} \text {-sence }
$$

by the Lebesgue's theorem. Therefore, we get the desired equation

E\left[e^{z \lambda_{t}^{x}} g\right]=E\left[e^{z \lambda_{t}^{x}} E\left[g \mid \lambda_{s}^{x}\right]\right] \quad \text { for } z \in\left(-\frac{M_{1}}{2}, \frac{M_{1}}{2}\right)

Now, the identity theorem guarantees the conclusion.

P\left[\lambda_{t}^{x} \in(a, b] \mid \lambda_{s}^{x}\right]=\lim _{A \rightarrow \infty} \frac{1}{2 \pi} \int_{-A}^{A} \frac{e^{-i u a}-e^{-i u b}}{i u} E\left[e^{i u \lambda_{t}^{x}} \mid \lambda_{s}^{x}\right] d u \quad \text { a.s. } \tag{6.15}
\end{equation*}
$$

However, by considering a probability measure $P_{F}(d \omega)=P[d \omega \cap F] / P[F]$, the Lévy's inversion formula gives

P\left[\left\{\lambda_{t}^{x} \in(a, b]\right\} \cap F\right]=\lim _{A \rightarrow \infty} \frac{1}{2 \pi} \int_{-A}^{A} \frac{e^{-i u a}-e^{-i u b}}{i u} E\left[e^{i u \lambda_{t}^{x}} 1_{F}\right] d u
$$

for any set $F \in \mathscr{F}_{s}^{x}$. Moreover, we know

$$
\frac{1}{2 \pi} \int_{-A}^{A} \frac{e^{-i u a}-e^{-i u b}}{i u} E\left[e^{i u \lambda_{t}^{x}} 1_{F}\right] d u=E\left[E\left[\left.\frac{1}{\pi}\left\{D_{A}\left(\lambda_{t}^{x}-a\right)-D_{A}\left(\lambda_{t}^{x}-b\right)\right\} \right\rvert\, \mathscr{F}_{s}^{x}\right] 1_{F}\right]
$$

where $D_{A}$ is the Dirichlet integral, i.e.

D_{A}(\alpha)=\int_{0}^{A} \frac{\sin (u \alpha)}{u} d u
$$

Then, as is well known, we can apply the Lebesgue's theorem and get

\lim _{A \rightarrow \infty} \frac{1}{2 \pi} \int_{-A}^{A} \frac{e^{-i u a}-e^{-i u b}}{i u} E\left[e^{i u \lambda_{t}^{x}} 1_{F}\right] d u=E\left[\left(\lim _{A \rightarrow \infty} \frac{1}{2 \pi} \int_{-A}^{A} \frac{e^{-i u a}-e^{-i u b}}{i u} E\left[e^{i u \lambda_{t}^{x}} \mid \mathscr{F}_{s}^{x}\right] d u\right) 1_{F}\right]
$$

Thus, (6.14) holds. In the same way, (6.15) also holds. Then, from Lemma [6.6, we get $P\left[\lambda_{t}^{x} \in(a, b] \mid \mathscr{F}_{s}^{x}\right]=$ $P\left[\lambda_{t}^{x} \in(a, b] \mid \lambda_{s}^{x}\right]$ a.s. for almost every $a, b \in \mathbb{R}$ with $a<b$. With the help of the monotone class theorem, $E\left[f\left(\lambda_{t}^{x}\right) \mid \mathscr{F}_{s}^{x}\right]=E\left[f\left(\lambda_{t}^{x}\right) \mid \lambda_{s}^{x}\right]$ a.s. holds for any bounded measurable function $f$.

= & \left\{(t-s)\left(x_{1} e^{-\beta s}+\int_{(0, s)} \alpha e^{-\beta(s-u)} d N_{u}^{x_{1}}\right)+\left(\left(x_{1} s+x_{2}\right) e^{-\beta s}+\int_{(0, s)} \alpha(s-u) e^{-\beta(s-u)} d N_{u}^{x_{1}}\right)\right\} e^{-\beta(t-s)} \\
& +\int_{[s, t)} \alpha(t-u) e^{-\beta(t-u)} d N_{u}^{x_{1}} \\
= & \left(X_{s}^{x,(1)}(t-s)+X_{s}^{x,(2)}\right) e^{-\beta(t-s)}+\int_{[s, t)} \alpha(t-u) e^{-\beta(t-u)} d N_{u}^{x_{1}}
\end{aligned}
$$

and similarly,

$$
X_{t}^{x,(3)}=\left(X_{s}^{x,(1)}(t-s)^{2}+2 X_{s}^{x,(2)}(t-s)+X_{s}^{x,(3)}\right) e^{-\beta(t-s)}+\int_{[s, t)} \alpha(t-u)^{2} e^{-\beta(t-u)} d N_{u}^{x_{1}}
$$

Therefore, $X_{t}^{x}$ is $\sigma\left(X_{u}^{x,(1)}, X_{s}^{x,(2)}, X_{s}^{x,(3)} ; u \in[s, t]\right)$-measurable for any $t \geq s \geq 0$.
Let $g_{1}, g_{2}$ and $g_{3}$ be $\sigma\left(X_{u}^{x,(1)} ; u \in[s, t]\right), \sigma\left(X_{s}^{x,(2)}\right)$ and $\sigma\left(X_{s}^{x,(3)}\right)$ measurable bounded functions respectively. Then, (6.16) and the monotone class theorem lead

E\left[g_{1} g_{2} g_{3} \mid \mathscr{F}_{s}^{x}\right]=g_{2} g_{3} E\left[g_{1} \mid \mathscr{F}_{s}^{x}\right]=g_{2} g_{3} E\left[g_{1} \mid X_{s}^{x}\right]=E\left[g_{1} g_{2} g_{3} \mid X_{s}^{x}\right] \quad \text { a.s. }
$$

By the monotone class theorem, we get the conclusion.
Before we prove the homogeneous Markov property of process $X$, we prepare the following technical lemma.
Lemma 6.7. For any bounded function $f$ defined on the path space of $X_{u}^{x,(1)}, u \in[s, t]$,

From Theorem 3.9 and the monotone class theorem, $E\left[f\left(X_{u}^{x,(1)} ; u \in[s, t]\right) \mid \mathscr{F}_{s}^{x}\right]=E\left[f\left(X_{u}^{x,(1)} ; u \in\right.\right.$ $\left.[s, t]) \mid X_{s}^{x,(1)}\right]$ a.s. holds. Therefore, we only have to prove the statement replaced $\mathscr{F}_{s}^{x}$ by $\sigma\left(X_{s}^{x,(1)}\right)$. For any $p \in \mathscr{P}$, we know that for almost every $\omega \in \Omega$ and $s \leq t$,

& =e^{(t-s) \mathscr{A}} p\left(\lambda_{s}^{x_{1}}(\omega)-\mu\right) \\
& =e^{(t-s) \mathscr{A}} p\left(\lambda_{0}^{X_{s}^{x,(1)}(\omega)}(\tilde{\omega})-\mu\right) \\
& =\left.E\left[p\left(\lambda_{t-s}^{y}-\mu\right)\right]\right|_{y=X_{s}^{x,(1)}(\omega)} \\
& =\left.E\left[p\left(X_{t-s}^{y,(1)}\right)\right]\right|_{y=X_{s}^{x,(1)}(\omega)},
\end{aligned}
$$

where the operator $e^{(t-s) \mathscr{A}}$ is defined in Subsection 3.2. In particular, for $u \in \mathbb{R}$ with $|u| \leq \frac{M_{1}}{2}$ and $p_{N}(y)=$ $\sum_{n=0}^{N} \frac{(u y)^{n}}{n!} \in \mathscr{P}$,

Moreover, Proposition 3.5 and the Lebesgue's theorem give

& =E\left[g_{1}\left(X_{u_{1}}^{x,(1)}\right) E\left[g_{2}\left(X_{u_{2}}^{x,(1)}\right) \mid X_{u_{1}}^{x,(1)}\right] \mid X_{s}^{x,(1)}\right] \\
& =E\left[\left.g_{1}\left(X_{u_{1}}^{x,(1)}\right) E\left[g_{2}\left(X_{u_{2}-u_{1}}^{y_{1},(1)}\right)\right]\right|_{y_{1}=X_{u_{1}}^{x,(1)}} \mid X_{s}^{x,(1)}\right] \\
& =\left.E\left[\left.g_{1}\left(X_{u_{1}-s}^{y_{2},(1)}\right) E\left[g_{2}\left(X_{u_{2}-u_{1}}^{y_{1},(1)}\right)\right]\right|_{y_{1}=X_{u_{1}-s}^{y_{2},(1)}}\right]\right|_{y_{2}=X_{s}^{x,(1)}} \\
& =\left.E\left[g_{1}\left(X_{u_{1}-s}^{y_{2},(1)}\right) E\left[g_{2}\left(X_{u_{2}-s}^{y_{2},(1)}\right) \mid X_{u_{1}-s}^{y_{2},(1)}\right]\right]\right|_{y_{2}=X_{s}^{x,(1)}} \\
& =\left.E\left[g_{1}\left(X_{u_{1}-s}^{y,(1)}\right) g_{2}\left(X_{u_{2}-s}^{y,(1)}\right)\right]\right|_{y=X_{s}^{x,(1)}} a . s .
\end{aligned}
$$

Inductively, we also get for any $k \in \mathbb{N}, s \leq u_{1} \leq \cdots \leq u_{k} \leq t$ and bounded functions $g_{1}, \ldots, g_{k}$,

E\left[g_{1}\left(X_{u_{1}}^{x,(1)}\right) \cdots g_{k}\left(X_{u_{k}}^{x,(1)}\right) \mid X_{s}^{x,(1)}\right]=\left.E\left[g_{1}\left(X_{u_{1}-s}^{y,(1)}\right) \cdots g_{k}\left(X_{u_{k}-s}^{y,(1)}\right)\right]\right|_{y=X_{s}^{x,(1)}} \text { a.s. }
$$

By considering cylinder sets in $\sigma\left(X_{u}^{x,(1)} ; u \in[s, t]\right)$, the monotone class theorem gives the conclusion.
Proof of Proposition 3.12, Let $h_{1}$ be a bounded function defined on the path space of $X_{u}^{x,(1)}, u \in[s, t]$. Moreover, let $h_{2}$ and $h_{3}$ be bounded functions on $\mathbb{R}$. Lemma 6.7 leads

E\left[h_{1}\left(X_{u}^{x,(1)} ; u \in[s, t]\right) h_{2}\left(X_{s}^{x,(2)}\right) h_{3}\left(X_{s}^{x,(3)}\right) \mid X_{s}^{x}\right] & =h_{2}\left(X_{s}^{x,(2)}\right) h_{3}\left(X_{s}^{x,(3)}\right) E\left[h_{1}\left(X_{u}^{x,(1)} ; u \in[s, t]\right) \mid X_{s}^{x}\right] \\
& =h_{2}\left(X_{s}^{x,(2)}\right) h_{3}\left(X_{s}^{x,(3)}\right) E\left[h_{1}\left(X_{u}^{x,(1)} ; u \in[s, t]\right)\left|\mathscr{F}_{s}^{x}\right| X_{s}^{x}\right] \\
& =\left.h_{2}\left(X_{s}^{x,(2)}\right) h_{3}\left(X_{s}^{x,(3)}\right) E\left[h_{1}\left(X_{u_{k}-s}^{y,(1)} ; u \in[s, t]\right)\right]\right|_{y=X_{s}^{x,(1)}} \\
& =\left.E\left[h_{1}\left(X_{u_{k}-s}^{y_{1},(1)} ; u \in[s, t]\right) h_{2}\left(y_{2}\right) h_{3}\left(y_{3}\right)\right]\right|_{\left(y_{1}, y_{2}, y_{3}\right)=X_{s}^{x}} \text { a.s. }
\end{aligned}
$$

Therefore, the monotone class theorem yields that

### 6.4.2 Ergodicity

The $V$-geometric ergodicity has been proved for the process $X^{(1)}$, see Proposition 4.5 in Clinet and Yoshida(2017). For the Hawkes core process $X=\left(X^{(1)}, X^{(2)}, X^{(3)}\right)$, we can also prove it in a similar way. That is, we apply Theorem 6.1 in [Meyn and Tweedie(1993b)]. First, we again consider the extended generator and the drift criterion. The following lemma is proved by the same method as Proof of Proposition 4.5. in Clinet and Yoshida(2017).
Lemma 6.9. Let $\alpha, \beta$ and $\mu$ be the parameters of the Hawkes process $N_{t}^{x_{1}}$. For a differentiable function $f: \mathbb{R}^{3} \rightarrow \mathbb{R}$, we define the operator $\mathscr{A}_{X}$ by

Second, we need to show that every compact set is petite for some skeleton chain, i.e. there exists $\delta>0$ such that for any compact set $C \in \mathscr{B}\left(\mathbb{R}^{3}\right)$, we can choose a probability measure $a$ on $\mathbb{Z}_{+}$and a non-trivial measure $\phi_{a}$ on $\mathbb{R}^{3}$ such that

Moreover, we call $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is a $T$-chain, if there exist $k \in \mathbb{Z}_{+}$and non-trivial kernel $T$ such that

- $T\left(x, \mathbb{R}^{3}\right)>0$ for any $x \in \mathbb{R}_{+}^{3}$,
- $x \mapsto T(x, A)$ is lower semi-continuous for any $A \in \mathscr{B}\left(\mathbb{R}^{3}\right)$,
- $P^{\delta k}(x, A) \geq T(x, A)$ for any $x \in \mathbb{R}_{+}^{3}$ and $A \in \mathscr{B}\left(\mathbb{R}^{3}\right)$.

We consider a relation between the existence of petite compact sets and T-chain properties. The following lemma is well known, see Theorem 3.2 in Meyn and Tweedie(1992).
Lemma 6.10. Suppose that $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is an irreducible $T$-chain. Then, every compact set is petite.
Furthermore, we call $x^{*} \in \mathbb{R}^{3}$ is reachable, if for any open set $G \in \mathscr{B}\left(\mathbb{R}^{3}\right)$ with $x^{*} \in G$,

Proof of Proposition 3.15. We only have to prove that there exists $\delta>0$ such that $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is an irreducible $T$-chain. First, we check the $T$-chain property.

Denote the $i$-th jump time of $N_{t}^{x}$ by $\tau_{i}^{x}$. Let $\Delta \tau_{i}^{x}$ be the interval time between the ( $i-1$ )-th and $i$-th jump of $N_{t}^{x}$, i.e. $\Delta \tau_{i}^{x}=\tau_{i}^{x}-\tau_{i-1}^{x}$. As mentioned in Lemma A. 4 of Clinet and Yoshida(2017), $\Delta \tau_{i}^{x}$ has the conditional probability density (with respect to Lebesgue measure)

in Proof of Lemma A. 3 of Clinet and Yoshida(2017). Denote the Jacobian matrix of $H_{x, \delta}$ at $\left(t_{1}, t_{2}, t_{3}\right)$ by $J_{\delta}\left(t_{1}, t_{2}, t_{3}\right)$. Then, completely elementary calculations leads

It is a Vandermonde determinant and thus not zero if $\left(t_{1}, t_{2}, t_{3}\right)=(\tau, \tau, \tau)$ for $\tau \in(0, \delta / 3)$. We consider a neighborhood at the such point $\left(t_{1}, t_{2}, t_{3}\right)=(\tau, \tau, \tau)$. Set $B\left(t_{1}, t_{2}, t_{3}, t_{4}\right)=\left\{T_{(1,3)}<\delta\right\} \cap\left\{T_{(1,4)}>\delta\right\} \cap$ $\left\{\left(t_{1}, t_{2}, t_{3}\right) \in(\tau-\epsilon, \tau+\epsilon)^{3}\right\}$ for sufficient small $\epsilon>0$. Then, we get a non-trivial component $T(x, A)$ as below.

Since $B\left(t_{1}, t_{2}, t_{3}, t_{4}\right)$ is a countable union of open intervals, continuity of $H_{x, \delta}^{-1}$ in $x$ leads that $x \mapsto T(x, A)$ is lower semi-continuous. Thus, $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is a $T$-chain.

Finally, we prove that $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is irreducible. Since $\left\{X_{\delta n}^{x}\right\}_{n \in \mathbb{Z}_{+}}$is a $T$-chain, we only have show that there exists a reachable point $x^{*} \in \mathbb{R}_{+}^{3}$, i.e. for any open set $O \in \mathscr{B}\left(\mathbb{R}^{3}\right)$ containing $x^{*}$,

see Proposition 6.2.1 in Meyn and Tweedie(1993a). However, we can easily show that $(0,0,0)$ is a reachable point. Indeed, if a jump will never occur, for any neighborhood $O$ of $(0,0,0), X_{\delta n}^{x} \in O$ for sufficient large $n \in \mathbb{N}$. By the form of $f^{\Delta \tau_{1}^{x}}(t \mid x)$, the probability there is no jump on $[0, \delta n]$ is positive. Thus, we get the conclusion.

### 6.5 Proofs of Section 4

In this subsection, we will prove Theorem 4.6 For this purpose, it is enough to confirm that there exist some constants satisfying (2.15) and the conditons [A1]-[A3], [B0]-[B4], [C1] hold. We explain each condition separately by dividing each small section.

### 6.5.1 Proof of Proposition 4.4 (Condition [A1])

In Markovian framework, as mentioned in Kusuoka and Yoshida(2000)] and Yoshida(2004), the mixing property is derived from the ergodicity. Concretely, the geometric mixing property is reduced to the following property;
[A1'] There exists a positive constant $a$ such that

Proposition 6.11. The Markovian property in Proposition 3.11 and [A1'] lead [A1].
Proof. For any $f \in \mathscr{F} \mathscr{B}_{[0, s]}$ and $g \in \mathscr{F} \mathscr{B}_{[t, \infty)}$ with $\|f\|_{\infty} \leq 1$ and $\|g\|_{\infty} \leq 1$,

|E[f g]-E[f] E[g]| & =|E[f(g-E[g])]|=\left|E\left[f E\left[g-E[g] \mid \mathscr{B}_{[0, s]}\right]\right]\right| \\
& \leq\left\|E\left[g-E[g] \mid \mathscr{B}_{[0, s]}\right]\right\|_{L^{1}(P)}=\left\|E\left[g \mid X_{s}\right]-E[g]\right\|_{L^{1}(P)} \leq a^{-1} e^{-a(t-s)}
\end{aligned}
$$

Proof of Proposition 4.4. We confirm that [A1'] follows from Proposition 3.15. Let $s \leq t$ and $f \in \mathscr{F} \mathscr{B}_{[t, \infty)}$ with $\|f\|_{\infty} \leq 1$. From the Markovian property, we have

There exists a measurable function $g$ such that $E\left[f \mid X_{t}\right]=g\left(X_{t}\right)$ and $\|g\|_{\infty} \leq 1$. From Proposition 3.12, we get

\leq & \sup _{g:\|g\|_{\infty} \leq 1}\left\|\int_{\mathbb{R}^{3}} g(y) P^{t-s}\left(X_{s}, d y\right)-\int_{\mathbb{R}_{+}} g(y) P^{t}\left(X_{0}, d y\right)\right\|_{L^{1}(P)} \\
\leq & \sup _{g:\|g\|_{\infty} \leq 1}\left\{\left\|\int_{\mathbb{R}^{3}} g(y)\left(P^{t-s}\left(X_{s}, d y\right)-P^{\bar{X}}(d y)\right)\right\|_{L^{1}(P)}+\left\|\int_{\mathbb{R}^{3}} g(y)\left(P^{t}\left(X_{0}, d y\right)-P^{\bar{X}}(d y)\right)\right\|_{L^{1}(P)}\right\} \\
\leq & E\left[\left\|P^{t-s}\left(X_{s}, \cdot\right)-P^{\bar{X}}\right\|_{e^{M .}}\right]+E\left[\left\|P^{t}\left(X_{0}, \cdot\right)-P^{\bar{X}}\right\|_{e^{M .}}\right] \\
\leq & E\left[B\left(e^{M X_{s}}+1\right) r^{t-s}\right]+E\left[B\left(e^{M X_{0}}+1\right) r^{t}\right] \\
= & r^{t-s} B\left(E\left[e^{M X_{s}}\right]+1+2 r^{s}\right) .
\end{aligned}
$$

Finally, from Proposition 3.14 we may choose sufficient small $a>0$ that satisfies [A1'].

### 6.5.2 Condition [A2]

$Z_{0} \in \bigcap_{p>1} L^{p}(P)$ and $P\left[Z_{0}\right]=0$ are obvious. We can write each component of $Z_{t+h}^{t}$ as

where $p_{1}$ and $p_{2}$ are 3 -variable polynomial functions. From Proposition 3.14 we have $\sup _{t}\left\|X_{t}\right\|_{L^{p}(P)}<\infty$ for any $p>1$. By considering $t \in[0, T]$ for an arbitrary $T>0, \int_{0}^{t} p_{1}\left(X_{s}\right) / \lambda_{s}^{2} d \tilde{N}_{s}$ is a square integrable martingale,
see Theorem 18.8 in Liptser and Shiryaev(2000). Thus, we immediately get $E\left[Z_{t+\Delta}^{t}\right]=0$ for any $\Delta>0$ and $t>0$.

The rest of the proof is $\sup _{t \in \mathbb{R}_{+}, 0 \leq h \leq \Delta}\left\|Z_{t+h}^{t}\right\|_{L^{p}(P)}<\infty$. When we consider the $L^{p}$ boundedness, it is enough to consider the form of $p=2^{k}$ for $k \in \mathbb{N}$. We get

Moreover, since $h^{-1} d s$ is a probability measure on $[t, t+h]$, by the Jensen's inequality,

\left\|\int_{t}^{t+h} \frac{p_{2}\left(X_{s}\right)}{\lambda_{s}^{2}} d s\right\|_{L^{p}(P)} & \leq\left(E\left[\int_{t}^{t+h}\left(\frac{p_{2}\left(X_{s}\right)}{\lambda_{s}^{2}} h\right)^{p} h^{-1} d s\right]\right)^{\frac{1}{p}} \\
& \leq \frac{\sup _{s}\left\|p_{2}\left(X_{s}\right)\right\|_{L^{p}(P)}}{\mu_{0}^{2}} h
\end{aligned}
$$

On the other hand,

\mathscr{M}_{h}=\int_{t}^{t+h} \frac{p_{1}\left(X_{s}\right)}{\lambda_{s}^{2}} d \tilde{N}_{s}

is also a square integrable martingale. Then, the Burkholder-Davis-Gundy inequality leads that there exists a positive constant $C_{k}$ (take again new $C_{k}$ in the last step) such that

& \leq C_{k}\left(E\left[\left|\int_{t}^{t+h}\left(\frac{p_{1}\left(X_{s}\right)}{\lambda_{s}^{2}}\right)^{2} d \tilde{N}_{s}\right|^{2^{k-1}}\right]+E\left[\left|\int_{t}^{t+h}\left(\frac{p_{1}\left(X_{s}\right)}{\lambda_{s}^{2}}\right)^{2} \lambda_{s} d s\right|^{2^{k-1}}\right]\right)
\end{aligned}
$$

where $[\mathscr{M}]_{h}$ represents the quadratic variation of $\mathscr{M}_{h}$. We used the Jensen's inequality in the last estimation. By induction, one gets some constant $Q_{k}$ (take again new $Q_{k}$ in the last step) such that

& \leq Q_{k} \sum_{j=1}^{k} E\left[\int_{t}^{t+h}\left(\frac{p_{1}\left(X_{s}\right)}{\lambda_{s}^{2}}\right)^{2^{k}} \lambda_{s}^{2^{k-j}} h^{2^{k-j}} h^{-1} d s\right] \\
& \leq Q_{k}(h+1)^{2^{k-1}} \tag{6.17}
\end{align*}
$$

Therefore, for any $\Delta>0$ and $p>0, \sup _{t \in \mathbb{R}_{+}, 0 \leq h \leq \Delta}\left\|Z_{t+h}^{t}\right\|_{L^{p}(P)}<\infty$ holds. Then, the conditon [A2] is verified.

### 6.5.3 Condition [A3]

The conditon [A3] follows from Lemma 3.15. and the proof of Lemma A.7. in Clinet and Yoshida(2017).

### 6.5.4 Condition [B0]

(i), (ii) and (iv) are obvious. (iii) immediately follows a square integrable martingale property:

\operatorname{Cov}\left[\int_{0}^{t} \frac{p_{1}\left(X_{s}\right)}{\lambda_{s}} d \tilde{N}_{s}, \int_{0}^{t} \frac{p_{2}\left(X_{s}\right)}{\lambda_{s}} d \tilde{N}_{s}\right]=E\left[\int_{0}^{t} \frac{p_{1}\left(X_{s}\right) p_{2}\left(X_{s}\right)}{\lambda_{s}^{2}} d[\tilde{N}]_{s}\right]=E\left[\int_{0}^{t} \frac{p_{1}\left(X_{s}\right) p_{2}\left(X_{s}\right)}{\lambda_{s}} d s\right]
$$

for any 3 -variable polynomial functions $p_{1}$ and $p_{2}$.

### 6.5.5 Condition [B1]

We take any constant $L>1$. From (4.1) and (6.17), we immediately deduce that for any $k \in \mathbb{N}$

Therefore, the conditon [B1] holds for any $q_{1}>1$. In particular, we can choose $q_{1}$ satisfying $q_{1}>3 L$.

### 6.5.6 Condition [B2]

Let $L, q_{1}$ and $q_{3}$ be positive constants with $L>1, q_{1}>3 L$ and $q_{3}>\frac{q_{1} L}{q_{1}-3 L}$. We arbitrary set a positive constant $q_{2}$ with $q_{2}>\max \left(3, \frac{3 q_{1} L}{q_{1}-3 L}\right)$ for given constants $L$ and $q_{1}$. Let $Y_{t}(\theta)=\left(X_{t}^{(1)}\left(\theta_{0}\right), X_{t}^{(1)}(\theta), X_{t}^{(2)}(\theta), X_{t}^{(3)}(\theta), X_{t}^{(4)}(\theta)\right)$ for $\theta=(\mu, \alpha, \beta)$. From the relation

\partial_{\theta} X_{t}^{n}(\theta)=\left(\begin{array}{c}
0 \\
\alpha^{-1} X_{t}^{n}(\theta) \\
-X_{t}^{n+1}(\theta)
\end{array}\right)
$$

and a verification of the permutation rule of the symbol $\partial_{\theta}$ and $\int_{0}^{T}$, we can write, for both of the case $k=2$ and $k=3$,

& T^{\frac{\gamma}{2}}\left(T^{-1} l_{a_{1} \cdots a_{k}}(\theta)-\nu_{a_{1} \cdots a_{k}}(\theta)\right) \\
= & T^{\frac{\gamma}{2}-1} \int_{0}^{T} \frac{p_{1}\left(Y_{s}(\theta)\right)}{\lambda_{s}^{4}(\theta)} d \tilde{N}_{s}+T^{\frac{\gamma}{2}}\left\{\frac{1}{T} \int_{0}^{T} \frac{p_{2}\left(Y_{s}(\theta)\right)}{\lambda_{s}^{4}(\theta)} d s-E\left[\frac{1}{T} \int_{0}^{T} \frac{p_{2}\left(Y_{s}(\theta)\right)}{\lambda_{s}^{4}(\theta)} d s\right]\right\}
\end{aligned}
$$

with some polynomial functions $p_{1}$ and $p_{2}$. Lemma A.5. in Clinet and Yoshida(2017) guarantees

\sup _{t} \sum_{i=0}^{4}\left\|\sup _{\theta \in \Theta} \partial_{\theta}^{i} \lambda_{t}(\theta)\right\|_{L^{p}(P)}<\infty \tag{6.18}
\end{equation*}

for any $p>1$. Thus, we have $\sup _{t}\left\|\sup _{\theta \in \Theta} Y_{t}(\theta)\right\|_{L^{p}(P)}<\infty$ for any $p>1$. Moreover, $Y_{t}(\theta)$ is $\sigma\left(N_{s} ; s \leq t\right)-$ predictable. From the restriction of (2.15), $\frac{\gamma}{2}-1<-\frac{1}{2}$ holds. Then, in the same method of the proof of the conditon [A2], we can see that

& \left.\int_{(s, t)} \alpha(t-u)^{2} e^{-\beta(t-u)} d N_{u}^{x_{1}}, \int_{(s, t)} \alpha(t-u)^{3} e^{-\beta(t-u)} d N_{u}^{x_{1}}\right)
\end{aligned}
$$

Denote $D_{\uparrow}\left(\mathbb{R}_{+}^{5}, \mathbb{R}\right)$ as the set of functions $\psi: \mathbb{R}_{+}^{5} \rightarrow \mathbb{R}$ that satisfy:

- $\psi$ are of class $C^{1}\left(\mathbb{R}_{+}^{5}\right)$.
- $\psi$ and $|\nabla \psi|$ are polynomial growth.

By replacing $X^{\alpha}(t, \theta)$ by $Y_{t}(\theta)$ and $\tilde{X}^{\alpha}(s, t, \theta)$ by $\tilde{Y}(s, t, \theta)$ in the proof of Lemma A.6. and using Lemma 3.16. in Clinet and Yoshida(2017), we can get the following ergodicity property: There exist a mapping $\pi: D_{\uparrow}\left(\mathbb{R}_{+}^{5}, \mathbb{R}\right) \times \Theta \rightarrow \mathbb{R}$ and a constant $\gamma^{\prime} \in\left(0, \frac{1}{2}\right)$ such that for any $\psi \in D_{\uparrow}\left(\mathbb{R}_{+}^{5}, \mathbb{R}\right)$ and for any $p>1$,

However, in the case of the exponential Hawkes process, we can choose $\gamma^{\prime} \in\left(0, \frac{1}{2}\right)$ arbitrarily. This arbitrariness follows from the fact $\left\|Y_{t}(\theta)-\bar{Y}_{t}(\theta)\right\|_{L_{1}(P)}$ is exponentially decreasing uniformly in $\theta$ for some stationary process $\bar{Y}_{t}(\theta)$, see the proof of the stability condition part in Lemma A.6. of Clinet and Yoshida(2017). Therefore, by taking $\gamma^{\prime} \in\left(0, \frac{1}{2}\right)$ and $\gamma=2 \gamma^{\prime}$ satisfying $\frac{2}{3}+\max \left(\frac{L}{q_{2}}, \frac{L}{3 q_{3}}\right)<\gamma<1-\frac{L}{q_{1}}$, we get

for any $p>1$. It means that the conditon [B2] holds for any $q_{2}>\max \left(3, \frac{3 q_{1} L}{q_{1}-3 L}\right)$ and some $\gamma$ with $\frac{2}{3}+$ $\max \left(\frac{L}{q_{2}}, \frac{L}{3 q_{3}}\right)<\gamma<1-\frac{L}{q_{1}}$.

### 6.5.7 Condition [B3]

We only have to show that there exist an open set $\tilde{\Theta}$ including $\theta_{0}$ and a positive constant $T_{0}$ such that

With the help of (6.18), for the first term, we have

\left|g_{T}-E\left[\frac{1}{T} \int_{0}^{T} \frac{\left(\partial_{\theta} \lambda_{s}(\theta)\right)^{\otimes 2}}{\lambda_{s}^{2}(\theta)} \lambda_{s}\left(\theta_{0}\right) d s\right]\right| \leq \frac{\left|\theta_{0}-\theta\right|}{T} E\left[\int_{0}^{T} \sup _{\theta \in \Theta}\left|\partial_{\theta} \frac{\left(\partial_{\theta} \lambda_{s}(\theta)\right)^{\otimes 2}}{\lambda_{s}^{2}(\theta)}\right| \lambda_{s}\left(\theta_{0}\right) d s\right] \leq C_{\Theta, 1}\left|\theta_{0}-\theta\right|,
$$

where $C_{\Theta, 1}$ is a positive constant that does not depend on $T$. For the second term, we also get
$\left|E\left[\frac{1}{T} \int_{0}^{T} \frac{\partial_{\theta}^{2} \lambda_{s}(\theta)}{\lambda_{s}(\theta)}\left(\lambda_{s}\left(\theta_{0}\right)-\lambda_{s}(\theta)\right) d s\right]\right| \leq \frac{\left|\theta_{0}-\theta\right|}{T} E\left[\int_{0}^{T} \sup _{\theta \in \Theta}\left|\frac{\partial_{\theta}^{2} \lambda_{s}(\theta)}{\lambda_{s}^{2}(\theta)}\right| \sup _{\theta \in \Theta}\left|\partial_{\theta} \lambda_{s}(\theta)\right| d s\right] \leq C_{\Theta, 2}\left|\theta_{0}-\theta\right|$,
where $C_{\Theta, 2}$ is a positive constant independent of $T$. Since we have assumed $g_{T}$ is non-singular for large $T$ in the conditon [A3], we may choose $\tilde{\Theta}$ and $T_{0}>0$ such that

& -\sup _{T>T_{0}, \theta \in \tilde{\Theta}}\left|E\left[\frac{1}{T} \int_{0}^{T} \frac{\partial_{\theta}^{2} \lambda_{s}(\theta)}{\lambda_{s}(\theta)}\left(\lambda_{s}\left(\theta_{0}\right)-\lambda_{s}(\theta)\right) d s\right]\right|>0 .
\end{aligned}

Let $L$ and $q_{1}$ be positive constants with $L>1$ and $q_{1}>3 L$. We apply Sobolev's inequality (see Theorem 4.12 of Adams and Fournier(2003) $)$. We take any integer $q_{3}>\max \left(3, \frac{q_{1} L}{q_{1}-3 L}\right)$ and some constant $K\left(\Theta, q_{3}\right)$ such that

& \lesssim \sum_{k=1}^{4} \sup _{\theta \in \Theta} E\left[\left|\frac{1}{T} l_{a_{1} \cdots a_{4}}(\theta)\right|^{q_{3}}\right]
\end{aligned}
$$

Let $Y_{t}^{\prime}(\theta)=\left(X_{t}^{(1)}\left(\theta_{0}\right), X_{t}^{(1)}(\theta), X_{t}^{(2)}(\theta), X_{t}^{(3)}(\theta), X_{t}^{(4)}(\theta), X_{t}^{(5)}(\theta)\right)$. We may easily confirm that

$$
\frac{1}{T} l_{a_{1}, \ldots, a_{4}}(\theta)=\frac{1}{T} \int_{0}^{T} \frac{p_{1}\left(Y_{s}^{\prime}(\theta)\right)}{\lambda_{s}^{8}(\theta)} d \tilde{N}_{s}+\frac{1}{T} \int_{0}^{T} \frac{p_{2}\left(Y_{s}^{\prime}(\theta)\right)}{\lambda_{s}^{8}(\theta)} d s
$$

with some polynomial functions $p_{1}$ and $p_{2}$. In a similar way as Lemma A.5 in Clinet and Yoshida(2017), we can prove that $\sup _{t}\left\|\sup _{\theta \in \Theta} Y_{t}^{\prime}(\theta)\right\|_{L^{p}(P)}<\infty$ for any $p>1$. Then, like (6.17), we have

$$
\sup _{T>0, \theta \in \Theta} E\left[\left|\frac{1}{T} \int_{0}^{T} \frac{p_{1}\left(Y_{s}^{\prime}(\theta)\right)}{\lambda_{s}^{8}(\theta)} d \tilde{N}_{s}\right|^{2^{k}}\right]<\infty
$$

for any $k \in \mathbb{N}$. On the other hand, by the Jensen's inequality,

$$
\sup _{T>0, \theta \in \Theta} E\left[\left|\frac{1}{T} \int_{0}^{T} \frac{p_{2}\left(Y_{s}^{\prime}(\theta)\right)}{\lambda_{s}^{8}(\theta)} d s\right|^{p}\right] \leq \sup _{T>0} \frac{1}{T} \int_{0}^{T} E\left[\sup _{\theta \in \Theta}\left|\frac{p_{2}\left(Y_{s}^{\prime}(\theta)\right)}{\lambda_{s}^{8}(\theta)}\right|^{p}\right] d s<\infty
$$

for any $p>1$. Therefore, the condition [B4] holds for any constant $q_{3}>\max \left(3, \frac{q_{1} L}{q_{1}-3 L}\right)$.

### 6.5.9 Condition [C1]

In Theorem 4.6 of Clinet and Yoshida(2017), the convergence of moments is proved for $\sqrt{T}\left(\hat{\theta}_{T}-\theta_{0}\right)$. The conditon [C1] directly follows from this statement.
