# Some improved Gaussian correlation inequalities for symmetrical n-rectangles extended to some multivariate gamma distributions and some further probability inequalities

#### Abstract

The Gaussian correlation inequality (GCI) for symmetrical n-rectangles is improved if the absolute components have a joint cumulative distribution function (cdf) which is $\mathrm{MTP}_{2}$ (multivariate totally positive of order 2). Inequalities of the here given type hold at least for all $\mathrm{MTP}_{2}$ - cdfs on $\mathbb{R}^{n}$ or $\mathbb{R}_{+}^{n}$ with everywhere positive smooth densities. In particular, at least some infinitely divisible multivariate chi-square distribution functions (gamma distributions in the sense of Krishnamoorthy and Parthasarathy) with any positive real "degree of freedom" are shown to be MTP $_{2}$. Moreover, further numerically calculable probability inequalities for a broad class of multivariate gamma distributions are derived and a different improvement for inequalities of the GCI-type - and of a similar type with three instead of two groups of components - with more special correlation structures. The main idea behind these inequalities is to find for a given correlation matrix with positive correlations a further correlation matrix with smaller correlations whose inverse is an M-matrix and where the corresponding multivariate gamma distribution function is numerically available.


## 1. Introduction

Let $\left(X_{1}, \ldots, X_{n}\right)$ be a random vector on $\mathbb{R}^{n}$ or $\mathbb{R}_{+}^{n}=(0, \infty)^{n}$ with a continuous everywhere positive probability density function (pdf) and a distribution function (cdf)

F\left(x_{1}, \ldots, x_{n}\right)=P\left(\bigcap_{i=1}^{n} A_{i}\right), A_{i}=\left\{X_{i} \leq x_{i}\right\}

which satisfies the inequality

$$
\begin{equation*}
P\left(\bigcap_{i=1}^{n} A_{i}\right) \geq P\left(\bigcap_{i \in I} A_{i}\right) P\left(\bigcap_{i \notin I} A_{i}\right), \varnothing \neq I \subset\{1, \ldots, n\}, \tag{1.1}
\end{equation*}
$$

for all values $x_{i}$. Such a random vector is called here "completely positively lower orthant-dependent" (CPLOD), whereas "PLOD" means only the special case of (1.1) with $I$ of size 1 (or $n-1$ ), which entails only the inequality

Alternatively, the CPLOD-property can also be denoted by MPQD, i.e. "multivariate positively quadrant dependent".

The inequality (1.1) is in particular the Gaussian correlation inequality for symmetrical n-rectangles (GCI) if the $X_{i}$ are the absolute values of the components of a centered normal random vector. This inequality was after some earlier essential steps - completely proved in [21]. This GCl implies the general form of the GCl for

centrally symmetrical convex regions, but this paper deals only with inequalities for rectangular regions. For an MTP 2 - density ("multivariate totally positive of order 2 ", for the definition see section 3 ) the inequality (1.1) is always satisfied since (1.1) holds for "positively associated" random variables and since MTP2 implies positive association. However, a little bit more can be said if the cdf of $\left(X_{1}, \ldots, X_{n}\right)$ is MTP 2 . In section 3 a very simple proof is given for the following inequality for right-truncated $X_{i}$ :

\end{equation*}

with $A_{i}=\left\{X_{i} \leq x_{i}\right\}, B_{i}=\left\{X_{i} \leq b_{i}\right\}, x_{i} \leq b_{i}, \varnothing \neq I \subset\{1, \ldots, n\}$. This is an improvement of the inequality (1.1) within the region $B_{1} \times \ldots \times B_{n}$ if the last fraction in (1.2) is greater than 1. E.g. for the GCI with a non-singular irreducible covariance matrix $\Sigma=\left(\sigma_{i j}\right)$ (i.e. $\operatorname{rank}\left(\sigma_{i j}\right)_{i \in I, j \notin I}$ is always positive) this holds for all positive numbers $b_{i}$.

The GCl can be equivalently considered as an inequality for a chi-square or gamma random vector ( $X_{1}, \ldots, X_{n}$ ) with $X_{i}=\frac{1}{2} Z_{i}^{2}$, where $\left(Z_{1}, \ldots, Z_{n}\right)$ has an $N_{n}(0, \Sigma)$-distribution. The multivariate gamma distribution in the sense of Krishnamoorthy and Parthasarathy [13] coincides, apart from a scale factor 2, with the distribution of the diagonal of a Wishart $W_{n}(v, \Sigma)$-matrix with the "degree of freedom" $v=2 \alpha \in \mathbb{N}$ or $v>n-1$. This $\Gamma_{n}(\alpha, \Sigma)$-distribution has the Laplace transform (Lt)

with the ( $n \times n$ ) - identity matrix $I_{n}$, the "associated" covariance matrix $\Sigma$ (not to confuse with the covariance matrix of the components $\left.X_{i}\right)$ and $T=\operatorname{Diag}\left(t_{1}, \ldots, t_{n}\right), t_{i} \geq 0$. In this paper $\Sigma$ is always supposed to be nonsingular. Formula (1.3) provides too the Lt of a pdf ( $\Gamma_{n}(\alpha, \Sigma)$-density per definition) at least for all non-integer values $2 \alpha>[(n-1) / 2]$ (see [24]).

In [21] the inequality (1.1) for the absolute Gaussian random variables was extended to $\Gamma_{n}(\alpha, \Sigma)$-distributions with $2 \alpha \in \mathbb{N} \cup(n-2, \infty)$ and the same proof holds now for all non-integer values $2 \alpha>[(n-1) / 2]$ too.

For some special structures of $\Sigma$ the $\Gamma_{n}(\alpha, \Sigma)$-distribution exists for smaller values of $\alpha$ (see (2.9) in section 2). All $\alpha>0$ are admissible iff there exists a signature matrix $S=\operatorname{Diag}\left(s_{1}, \ldots, s_{n}\right), s_{i}= \pm 1$, for which $S \Sigma^{-1} S$ is an M-matrix (see [1] and for an equivalent condition [7]), i.e. all the off-diagonal elements of $S \Sigma^{-1} S$ are non-positive and all elements of $S \Sigma S$ are non-negative. The Lt in (1.3) shows the invariance of the $\Gamma_{n}(\alpha, \Sigma)$-distribution under the transformation $\Sigma \rightarrow S \Sigma S$.

If $\left(Z_{1}, \ldots, Z_{n}\right)$ has an $N_{n}(0, \Sigma)$-distribution, then $\left(\left|Z_{1}\right|, \ldots,\left|Z_{n}\right|\right)$ is MTP 2 iff there exists a signature matrix $S$, which generates an M-matrix $S \Sigma^{-1} S$, (see [11]), and MTP ${ }_{2}$ for $\left(\left|Z_{1}\right|, \ldots,\left|Z_{n}\right|\right)$ is equivalent to MTP $_{2}$ for the $\Gamma_{n}\left(\frac{1}{2}, \Sigma\right)$-distribution. Therefore, we have the remarkable fact, that a $\Gamma_{n}\left(\frac{1}{2}, \Sigma\right)$-distribution is infinitely divisible (inf. div.) iff it is $\mathrm{MTP}_{2}$. This might seduce to the (very optimistic) conjecture that all inf. div. $\Gamma_{n}(\alpha, \Sigma)$-distributions are $\mathrm{MTP}_{2}$ too (or at least positively associated). The inf. div. gamma distribution with the density from (2.12) is shown to be $\mathrm{MTP}_{2}$ in section 4, where also two further examples with inf. div. $\mathrm{MTP}_{2} \Gamma_{n}(\alpha, \Sigma)$-distribution functions are given. On the other hand, the inequality (1.1) for general inf. div. $\Gamma_{n}(\alpha, \Sigma)$-distributions with non-in-
teger values $2 \alpha$ is proved until now for $2 \alpha>[(n-1) / 2]$, but for $2 \alpha \in(0,[(n-1) / 2)])$ only for an index set $I \subset\{1, \ldots, n\}$ of size 1 (or $(n-1)$ ), which entails only PLOD (see [22], [24]).
In the proof of (1.1) in [21] for a $\Gamma_{n}(\alpha, \Sigma)$-distribution with $\Sigma=\binom{\Sigma_{11} \Sigma_{12}}{\Sigma_{21} \Sigma_{22}}$ it is supposed that $\left|I_{n}+\Sigma_{9} T\right|^{-(\alpha+1)}$ is the $L$ t of a $\Gamma_{n}\left(\alpha+1, \Sigma_{\vartheta}\right)$ - pdf for all $\Sigma_{\vartheta}=\left(\begin{array}{cc}\Sigma_{11} & \vartheta \Sigma_{12} \\ \vartheta \Sigma_{21} & \Sigma_{22}\end{array}\right), \vartheta \in(0,1)$. Furthermore, it was proved that the $\Gamma_{n}\left(\alpha, \Sigma_{\vartheta}\right)$ - cdf is strictly increasing in $\vartheta \in(0,1)$ for all positive fixed numbers $x_{1}, \ldots, x_{n}$ if $\operatorname{rank}\left(\Sigma_{12}\right)>0$. But if $\Sigma^{-1}$ is an M-matrix, then frequently $\Sigma_{\theta}^{-1}$ is no M-matrix for some $\vartheta \in(0,1)$, and then, it is not sure if $\left|I_{n}+\Sigma_{g} T\right|^{-(\alpha+1)}$ is the Lt of a pdf with a non-integer value $2(\alpha+1)<[(n-1) / 2], n>6$. All these difficulties would disappear if $\left|I_{n}+\Sigma T\right|^{-\alpha}$ would be the Lt of a pdf for all $\alpha>1$ and all $\Sigma$.

In section 5 , some different improvements of (1.1) are derived for some $\Gamma_{n}(\alpha, \Sigma)$-distributions by means of inf. div. gamma distributions and the here cited theorem 4 from [22], which provides an essential generalization of a theorem of Bølviken and Joag-Dev in [3] for absolute normal Gaussian random vectors. In particular, some improvements for the corresponding GCl are obtained with $\alpha=\frac{1}{2}$. In some cases, the given positive lower bound for the "excess" $P\left(\bigcap_{i=1}^{n} A_{i}\right)-P\left(\bigcap_{i \in I} A_{i}\right) P\left(\bigcap_{i \notin I} A_{i}\right)$ is numerically available.

Furthermore, an approximation for the excess is recommended, which is in particular useful for small "p-values" $p=1-P\left\{\max X_{i} \leq x\right\}$. This can be applied to many simultaneous or sequentially rejective statistical tests with multivariate chi-square test-statistics.

Formulas from the handbook of mathematical functions are cited by HMF and their numbers. $A>B$ for $(n \times n)$ matrices $\left(a_{i j}\right),\left(b_{i j}\right)$ means here $a_{i j} \geq b_{i j}$ for all $i, j$ and $A \neq B$. $\Sigma_{(k)}$ means a summation over all decompositions $k=k_{1}+\ldots+k_{p}$ with $k_{j} \in \mathbb{N}_{0}$.

## 2. Some formulas for multivariate gamma distributions

Here some formulas are compiled, which are used in the subsequent sections. The most comprehensive collection for integral and series representations and approximations for $\Gamma_{n}(\alpha, R)$ - cdfs is possibly found in the appendix of [5], (see also [14],..,,[20]). For non-central multivariate gamma distributions see [23]. Since the scaling is irrelevant for the aims of this paper, all the following formulas for $\Gamma_{n}(\alpha, \Sigma)$-distributions are given for the standardized case, i.e. $\Sigma$ is now a non-singular correlation matrix $R=\left(r_{i j}\right)$. The required scale factors can be easily inserted in applications with corresponding $\chi_{n}^{2}(2 \alpha, \Sigma)$-distributions.

The probability density $x^{\alpha-1} \mathrm{e}^{-x} / \Gamma(\alpha), \alpha>0, x>0$, of a univariate standard gamma distribution is denoted by $g_{\alpha}(x)$ and the corresponding cdf by $G_{\alpha}(x)$. The non-central gamma-cdf with non-centrality parameter $y$ is given by

For integer values $2 \alpha$ we have

with the modified Bessel functions $I_{k-1 / 2}$, which are elementary functions (HMF 10.49.(ii)), and

(see section 2 in [16]).
The functions $G_{\alpha}(x ; y)$ can be extended to holomorphic functions of $y \in \mathbb{C}$. According to [4], the cdf $G_{\alpha}(x ; y)$ is a strict log-concave function of $x$ for all $\alpha>1, y>0$ (for $0<\alpha \leq 1$ see theorem 3.4 in [6]), and $G_{\alpha}(x ; y)$ is strict $\mathrm{TP}_{2}$ for all $\alpha>0$, which is equivalent to

The $2^{\text {nd }}$ fact is an easy consequence of the first one, because

The char. function of $g_{\alpha}(x ; y)$ is $\hat{g}_{\alpha}(t ; y)=(1-i t)^{-\alpha} \exp (i t y /(1-i t))$.
From $\lim _{\varepsilon \rightarrow 0} \hat{g}_{\alpha}\left(\varepsilon t ; \varepsilon^{-1} y\right)=\exp ($ ity $)$ it follows

A correlation matrix $R_{n \times n}$ is called (positively) " m -factorial", if m is the lowest integer allowing a representation

with a pos. def. $D=\operatorname{Diag}\left(d_{1}, \ldots, d_{n}\right)$ and an $(n \times m)$ - matrix $A$ of rank $m<n$.
With $D^{-1 / 2} R D^{-1 / 2}=I_{n}+B B^{\prime}$ and the columns $\vec{b}_{j}$ of $B^{\prime}$ we have for the $\Gamma_{n}(\alpha, R)$ - cdf the integral representation

if $B$ is real, where the expectation refers to the random $W_{m}\left(2 \alpha, I_{m}\right)$ - Wishart (or pseudo-Wishart) matrix $S$, (see [16] or [18]). If there are one or more pure imaginary columns in $B$, caused by some negative eigenvalues of $D^{-1 / 2} R D^{-1 / 2}-I_{n}$, the $\Gamma_{n}(\alpha, R)-$ cdf is obtained at least for $2 \alpha \in \mathbb{N}$ or $2 \alpha>\max \left(\left[\frac{n-1}{2}\right], m-1\right)$. The veri--fication of (2.9) uses the Lt of non-central univariate gamma densities, followed by integration over $S$.

The most simple case arises for a "one-factorial" correlation matrix

with a real or imaginary column $\vec{a}=\left(a_{1}, \ldots, a_{n}\right)^{\prime}$ and $\max a_{j}^{2}<1$. Then

if $\vec{a}$ is real. This cdf satisfies the inequality (1.1) and the corresponding inequality where all the $A_{i}$ are replaced by their complements $\bar{A}_{i}$ due to Kimball's inequality (see e.g. [25]). Because of (2.7) the limit case with $a_{k}^{2}=$ $\max a_{j}^{2}=1>\max _{j \neq k} a_{j}^{2}$ is admissible. With an imaginary column $\vec{a}$ this distribution is not infinitely divisible, i.e. not all $\alpha>0$ are admissible. For the extension to $\max a_{j}^{2}>1$ see [5] or [18].

Besides, there is a simple formula for the $\Gamma_{n}(\alpha, R)$ - pdf if $R^{-1}=\left(r^{i j}\right)$ is of a "tree type". This means that the graph with the vertices $\{1, \ldots, n\}$ and $n-1$ edges, exactly corresponding to the $n-1$ off-diagonal elements $r^{i j} \neq 0$ in $R^{-1}$, is a "spanning tree", i.e. connected without any cycles. The special case with a tridiagonal $R^{-1}$ and $2 \alpha \in \mathbb{N}$ goes back to [2] and was generalized later in [15]. Such a $\Gamma_{n}(\alpha, R)$ - pdf is given by

## 3. Some properties of MTP $_{2}$ - distributions

In this section the inequality (1.2) is shown for $\mathrm{MTP}_{2}$ - cdfs with a smooth density $f>0$ on $\mathbb{R}^{n}$ or on $\mathbb{R}_{+}^{n}$. To make this paper more self-contained, some here used well known facts on MTP ${ }_{2}$ - functions are compiled with simple proofs, which are possibly of some interest for the non-specialized reader. For more theorems on MTP $_{2}$ see e.g. [10] and [11].

Let $F(\vec{x})=F\left(x_{1}, \ldots, x_{n}\right)$ be an everywhere positive function on $D=D_{1} \times \ldots \times D_{n} \subseteq \mathbb{R}^{n}$ with any intervals $D_{i}$. For any pair $(\vec{x}, \vec{y}) \in D \times D$ the notation $\vec{x} \vee \vec{y}$ stands for $\left(\max \left(x_{1}, y_{1}\right), \ldots, \max \left(x_{n}, y_{n}\right)\right.$ ) and $\vec{x} \wedge \vec{y}$ for $\left(\min \left(x_{1}, y_{1}\right), \ldots, \min \left(x_{n}, y_{n}\right)\right) . F$ is per definition MTP ${ }_{2}$ on $D$ if

F(\vec{x} \vee \vec{y}) F(\vec{x} \wedge \vec{y}) \geq F(\vec{x}) F(\vec{y}) \text { for all }(\vec{x}, \vec{y}) \in D \times D .

$F$ is $\mathrm{MTP}_{2}$ on $D$ iff $F$ is " $\mathrm{TP}_{2}$ in pairs", i.e. $F$ as a function of $\left(x_{i}, x_{j}\right) \in D_{i} \times D_{j}, i \neq j$, is always $\mathrm{TP}_{2}$ on $D_{i} \times D_{j}$ with any fixed values $x_{k} \in D_{k}, k \neq i, j$.

Now let $D$ be an open (bounded or unbounded) n-rectangle and $F \in \mathrm{C}^{2}(D)$ an everywhere positive function. Then $F$ is $\mathrm{MTP}_{2}$ on $D$ iff

which is verified by integration over $x_{i}$ and $x_{j}$. A simple consequence is
Theorem 1. If the cdf $F \in \mathbf{C}^{2}\left(\mathbb{R}^{n}\right)$ (or $F \in \mathbf{C}^{2}\left(\mathbb{R}_{+}^{n}\right)$ ) is $\mathrm{MTP}_{2}$ with an everywhere positive density $f$ on $\mathbb{R}^{n}$ (or $f$ on $\mathbb{R}_{+}^{n}$ ), then $F$ satisfies the inequality (1.2).

Proof. The inequality (1.2) holds if $P\left(\bigcap_{k=1}^{n} A_{k}\right)\left(P\left(\bigcap_{k \in I} A_{k}\right) P\left(\bigcap_{k \neq I} A_{k}\right)\right)^{-1}$ is non-increasing on $x_{1} \leq b_{1}, \ldots$, $x_{n} \leq b_{n}$ for every $I \subset\{1, \ldots, n\}$. With the above assumptions this is equivalent to

Since $\lim _{\min x_{j} \rightarrow \infty, j \neq I} P\left(\bigcap_{k=1}^{n} A_{k}\right)=P\left(\bigcap_{k \in I} A_{k}\right)$,
the inequality (3.2) is satisfied and therefore the inequality (1.2) too.

For three events $A=\bigcap_{k=1}^{n_{1}} A_{k}, B=\bigcap_{k=n_{1}+1}^{n_{1}+n_{2}} A_{k}, C=\bigcap_{k>n_{1}+n_{2}} A_{k}, n_{1}+n_{2}+n_{3}=n$, it follows e.g. with $\min x_{k} \rightarrow \infty, k>n_{1}+n_{2}$, the "cancelling inequalitiy"

The $\mathrm{MPT}_{2}$ - condition for the cdf is sufficient for the inequalities in (3.3), (3.4) and (3.5) but not necessary. On the other hand these inequalities do not hold for the example with $A=\left\{Z_{1}^{2} \leq 5,2\right\}, B=\left\{Z_{2}^{2} \leq 5,6\right\}, C=\left\{Z_{3}^{2} \leq 6\right\}$, where $\left(Z_{1}, Z_{2}, Z_{3}\right)$ is an $N(0, R)$-vector with the correlations $r_{12}=\frac{3}{4}, r_{13}=\frac{1}{2}, r_{23}=0$.

If $f\left(x_{1}, \ldots, x_{n}\right)$ is an $\mathrm{MTP}_{2}$ - pdf on $D$ then all m-dimensional marginal densities, $2 \leq m \leq n-1$, are $\mathrm{MTP}_{2}$ too (see e.g. (1.16) in [10]). A short proof is also found in chapter 2 in [9]. (Obviously, $f$ can be replaced by $c f$ with any constant $c>0$.) If $f$ is a continuous $\mathrm{MTP}_{2}$ - pdf on $D$ then the corresponding $\operatorname{cdf} F$ is $\mathrm{MTP}_{2}$ on $D$ too. This is a direct consequence of the following known fact, which is established here formally as a theorem. It is proved here for simplicity only for the important cases $D=\mathbb{R}^{n}$ or $D=\mathbb{R}_{+}^{n}$, but the proof can be extended to different n rectangles $D$ too. For more general versions see also [12].

Let $F \in \boldsymbol{C}^{2}\left(\mathbb{R}^{n}\right)$ or $F \in \boldsymbol{C}^{2}\left(\mathbb{R}_{+}^{n}\right)$ be a mixture-cdf of one of the following two types:
(a) $F\left(x_{1}, \ldots, x_{n}\right)=\int_{D}\left(\prod_{k=1}^{n} G_{k}\left(x_{k} ; y\right)\right) g(y) d y$,
where the $G_{k}$ are here any cdfs with everywhere positive pdfs $g_{k}$ on $\mathbb{R}$ for all $k$, or $g_{k}$ only positive on $\mathbb{R}_{+}$ for all $k$, additionally depending on a random parameter $Y$ with the density $g(y)$ on any interval $D \subset \mathbb{R}$.
(b) $F\left(x_{1}, \ldots, x_{n}\right)=\int_{D}\left(\prod_{k=1}^{n} G_{k}\left(x_{k} ; y_{k}\right)\right) g\left(y_{1}, \ldots, y_{n}\right) d y_{1} \ldots d y_{n}$, with any cdfs as before, but now depending on the values $y_{k}$ of a random parameter-vector $\left(Y_{1}, . ., Y_{n}\right)$ with an MTP $_{2}$ - pdf $g$ on any rectangular region $D=$ $D_{1} \times \ldots \times D_{n}$.

Theorem 2. The cdf $F$ from (a) is $\mathrm{MTP}_{2}$ on $\mathbb{R}^{n}$ (or $\mathbb{R}_{+}^{n}$ ) if all the derivatives $\frac{\partial}{\partial y} \frac{g_{k}(x ; y)}{G_{k}(x ; y)}$ are simultaneously not negative or simultaneously not positive for all $x$ and for all $y \in D$.

The cdf from (b) is $\mathrm{MTP}_{2}$ on $\mathbb{R}^{n}$ (or $\mathbb{R}_{+}^{n}$ ) if all the derivatives $\frac{\partial}{\partial y_{k}} \frac{g_{k}\left(x_{k} ; y_{k}\right)}{G_{k}\left(x_{k} ; y_{k}\right)}$ are simultaneously not negative or simultaneously not positive for all $x$ and for all $y_{k} \in D_{k}$.

Proof. (a) With a change of the notations $y, z$ in the following double integral we find

& \frac{1}{2} \iint_{D \times D}\left(\frac{g_{j}\left(x_{j} ; y\right)}{G_{j}\left(x_{j} ; y\right)}-\frac{g_{j}\left(x_{j} ; z\right)}{G_{j}\left(x_{j} ; z\right)}\right)\left(\frac{g_{i}\left(x_{i} ; y\right)}{G_{i}\left(x_{i} ; y\right)}-\frac{g_{i}\left(x_{i} ; z\right)}{G_{i}\left(x_{i} ; z\right)}\right)\left(\prod_{k=1}^{n} G_{k}\left(x_{k} ; y\right) G_{k}\left(x_{k} ; z\right)\right) g(y) g(z) d y d z \geq 0,
\end{aligned}

and the inequality is strict if the integrand does not vanish identically. $F$ is $\mathrm{MTP}_{2}$ follows now from (3.1).
(b) Only for simplicity of notation the inequality $F \frac{\partial^{2} F}{\partial x_{j} \partial x_{i}}-\frac{\partial F}{\partial x_{i}} \frac{\partial F}{\partial x_{j}} \geq 0$ is shown here only for $i=1$ and $j=2$.

For the left side we obtain

& h\left(y_{1}, y_{2}\right)=\int_{X_{k=3}^{n} D_{k}} \prod_{k=1}^{n} G_{k}\left(x_{k} ; y_{k}\right) g\left(y_{1}, \ldots, y_{n}\right) d y_{3} \ldots d y_{n} .

Since the following step holds for all fixed values $x_{k}$, the dependence of $h$ on $x_{1}, \ldots, x_{n}$ is not explicitely noted. The function $h\left(y_{1}, y_{2}\right)$ is $\mathrm{TP}_{2}$ on $D_{1} \times D_{2}$. Therefore, we can write the integral in (3.3) as an integral over the region $D_{1,2}^{+}$, defined by $\left(y_{1}-z_{1}\right)\left(y_{2}-z_{2}\right)>0$. This leads to

As a by-product it follows from (2.7) with the non-central gamma $\operatorname{cdf} G_{k}\left(x_{k} ; y_{k}\right)=G_{\alpha}\left(\varepsilon^{-1} x_{k} ; \varepsilon^{-1} y\right), \varepsilon \rightarrow 0$, and any continuous $\mathrm{MTP}_{2}$ - density $g\left(y_{1}, \ldots, y_{n}\right)$ on $\mathbb{R}_{+}^{n}$ that the cdf $G$ with the density $g$ is $\mathrm{MTP}_{2}$ on $\mathbb{R}_{+}^{n}$ too. In a similar way, we can use $G_{k}\left(x_{k} ; y_{k}\right)=\Phi\left(\varepsilon^{-1}\left(x_{k}-y_{k}\right)\right)$ with the $\operatorname{cdf} \Phi$ of the $N(0,1)$-distribution, to show that the cdf $G$ of an $\mathrm{MTP}_{2}$ - density $\Gamma_{n}(\alpha, R)$ on $\mathbb{R}^{n}$ is always $\mathrm{MTP}_{2}$ on $\mathbb{R}^{n}$.

## 4. Some examples for infinitely divisible MTP $_{2}$ gamma distributions

All the three examples of inf. div. $\Gamma_{n}(\alpha, R)$ - densities in this section can be shown to be $\mathrm{MTP}_{2}$ using corollary 2.1 in [12], which is a theorem for mixture densities similar to the here given theorem 2(b), and the proof in the $2^{\text {nd }}$ example, where ${ }_{0} F_{1}(\alpha ; c x y), \alpha, c>0$, is shown to be $\mathrm{TP}_{2}$ on $(x, y) \in(0, \infty)^{2}$. But here, we are only interested in MTP ${ }_{2}$ - cdfs in view of theorem 1 and its consequences. For that, we need only theorem 2.

Because of (2.5) the $\Gamma_{n}(\alpha, R)$ - cdf $F$ from (2.11) with $a_{i} \in(0,1), i=1, \ldots, n$, satisfies the conditions (a) from theorem 2. Therefore, $F$ is $\mathrm{MTP}_{2}$ and satisfies the inequality (1.2). This can also be shown without to use the MTP $_{2}$ - property by a direct verification of the inequality (3.2). If $Y_{1}, Y_{2}$ are positive random variables with everywhere positive pdfs $f_{1}$ and $f_{2}=f_{1} w$ on $\mathbb{R}_{+}$and $\frac{\partial}{\partial y} w(y)>0$ on $\mathbb{R}_{+}$, then it follows for the corresponding cdfs $1-F_{2}(y)>1-F_{1}(y)$ for all $y>0$, and we find for every increasing function $\psi(y)$ on $\mathbb{R}_{+}$with $E\left(\psi\left(Y_{i}\right)\right)$ $<\infty, i=1,2$,

With the functions

\end{aligned}

and $f_{2}(y)$ as $f_{1}(y)$, but only with the indices $k \in I, w(y)$ proportional to the increasing factor $\left(\prod_{k \neq I} G_{k}\left(x_{k} ; y\right)\right)^{-1}$ with the suitable norming factor and $\psi(y)=\frac{\partial}{\partial x_{i}} \log G\left(x_{i} ; y\right), i \in I$, the inequality (3.2) is satisfied and consequently (1.2) too.

Now the $\Gamma_{n}(\alpha, R)-$ pdf from (2.12) is shown to be $\mathrm{MTP}_{2}$. The function

has the derivative $F^{\prime}(\alpha ; z)=F(\alpha+1 ; z)$. To prove $\frac{\partial^{2}}{\partial x_{i} \partial x_{j}} \log f\left(x_{1}, \ldots, x_{n} ; \alpha, R\right) \geq 0, i \neq j$, it is sufficient to show that

This is equivalent to

With HMF 10.31.3 we find with the modified Bessel functions $I_{\mu}(z)=\left(\frac{1}{2} z\right)^{\mu} F\left(\mu+1 ; \frac{1}{4} z^{2}\right)$ the multiplication formula

Thus, the corresponding $\Gamma_{n}(\alpha, R)$ - cdf is $\mathrm{MTP}_{2}$ too and satisfies the inequality (1.2). More on total positivity of hypergeometric functions of $x_{1} x_{2}$ is found in [8].

The third example is a generalization of the first one. We consider a $\Gamma(\alpha, R)$ - distribution with the correlation matrix

is an M-matrix if $\vartheta \in\left[0,\left(\min \left(1+q_{1}^{-1}, 1+q_{2}^{-1}\right)\right)^{1 / 2}\right)$, (see also sec. 4 in [11]]). Therefore, with these values $\vartheta$ the $\Gamma_{n}\left(\alpha, R_{g}\right)$ - cdf exists for all $\alpha>0$ and the same is true for all the corresponding $\Gamma_{n}\left(\alpha, S R_{g} S\right)$ - cdfs with any signature matrix $S$ or, with other words, for all the corresponding $\Gamma_{n}\left(\alpha, R_{g}\right)-\operatorname{cdfs}$ with $|\vartheta| \leq \min \left(\left(1+q_{1}^{-1}\right)^{1 / 2}\right.$, $\left.\left(1+q_{2}^{-1}\right)^{1 / 2}\right)$ and $a_{i} \in(-1,1)$. But by the following theorem these $\Gamma_{n}\left(\alpha, R_{夕}\right)$ - cdfs are shown to be MTP 2 if $|\vartheta| \leq 1$, and therefore they satisfy the inequality (1.2) too. It remains here an open question if this holds too for the admissible values $|\vartheta|>1$. Furthermore, by means of these distributions and theorem 4 in [22], we shall obtain a different improvement of the inequality (1.1) for some correlation structures in section 5 .

Theorem 3. The $\Gamma_{n}\left(\alpha, R_{\vartheta}\right)$ - cdf with the correlation matrix $R_{\vartheta}$ from (4.1) and $\alpha>0$ is given by

## 5. A further improvement of the inequality (1.1) for some multivariate gamma distributions and some related inequalities and approximations

With the here cited Theorem 4 from [22] some positive lower bounds for the excess in the inequality (1.1) can be derived for some $\Gamma_{n}(\alpha, R)$-distributions. After a permutation of the random components we can choose the index set $I=\left\{1, \ldots n_{1}\right\}, 1<n_{1}<n-1$, in (1.1) and consider only correlation matrices $\Sigma=R$ since the scaling is irrelevant.

Theorem 4. Let $R=\left(r_{i j}\right)$ and $R_{0}=\left(r_{0, i j}\right)$ be two different non-singular $(n \times n)$-correlation matrices with $r_{i j} \geq$ $r_{0, i j}>0$ for all $i \neq j$ and $r_{0}^{i j} \leq 0$ for all off-diagonal elements of $R_{0}^{-1}$. Then the $\Gamma_{n}\left(\alpha, R_{0}+\tau\left(R-R_{0}\right)\right)$-cdfs are strictly increasing in $\tau \in[0,1]$ for all positive numbers $x_{1}, \ldots, x_{n}$ and $2 \alpha \in \mathbb{N} \cup([(n-1) / 2], \infty)$.
This implies

Remarks. This holds too if there exists any signature matrix $S$ for which $S R_{0} S$ and $S R S$ satisfy the above conditions. A similar inequality was proved in [3] for absolute Gaussian random vectors (here included with $\left.\alpha=\frac{1}{2}\right)$ under the additional restriction that all the matrices $\left(R_{0}+\tau\left(R-R_{0}\right)\right)^{-1}$ are M-matrices too, whereas this condition is here only required for $R_{0}^{-1}$.
As an immediate consequence of theorem 4 and (4.2) we obtain with the correlation matrices $R_{g}$ from (4.1), $\vartheta \in\left[0, \min \left(\sqrt{1+\left(\vec{a}_{1}^{\prime} D_{1}^{-1} \vec{a}_{1}\right)^{-1}}, \sqrt{1+\left(\vec{a}_{2}^{\prime} D_{2}^{-1} \vec{a}_{2}\right)^{-1}}\right)\right]$ and $R=\left(r_{i j}\right)=D+\left(\begin{array}{cc}\vec{a}_{1} \vec{a}_{1}^{\prime} & R_{12}, \\ R_{21} & \vec{a}_{2} \vec{a}_{2}^{\prime}\end{array}\right) \neq R_{\vartheta}$ with $r_{i j} \geq \vartheta a_{i} a_{j}$, $i \leq n_{1}, j>n_{1}$, the inequality

The here given lower bound in (5.3) for the excess in [5.2] is numerically available by the formula (2.11) if $\vartheta=$ 1 , by the formulas (4.3) or (4.4) if $\vartheta \in(0,1)$ and by (4.9) if $\vartheta>1$.

Now we consider a decomposition of the components $X_{\mu}$ into $p$ successive blocks with the sizes $n_{i}$, $n_{1}+\ldots+n_{p}=n$, and $(n \times n)$ - correlation matrices

It would be easy to write down the corresponding formulas for more blocks, based on the binomial series for $|\tilde{\Theta}|^{-\alpha}$, but the computing effort for the resulting multivariate series would be very high.

The binomial series for $|\tilde{\Theta}|^{-\alpha}=(1-\tilde{\vartheta})^{-\alpha}$ is abs. convergent, but if the char. function (cf) is used instead of the Lt , an additional condition is required for more than two blocks. The binomial series is used now with complex numbers with absolute values $\rho$. The simple computation of $\sup \rho^{2}$ is described in the appendix by the solution of the equations (A7), (A8) with only one positive bounded variable $x$, and the additional condition is

Theorem 5. Let $R_{\Theta}$ be a correlation matrix with $p=3$ blocks as described in (5.4). With the notation $\vartheta_{j}=\vartheta_{i k}$ for the correlations of $\Theta$ the $\Gamma_{n}\left(\alpha, R_{\Theta}\right)$-cdf is given by

for all indices $\mu<v$ of block $I_{j}$. Finally, suitable numbers $\vartheta_{i j} \in(0,1)$ are determined. (Obviously, this provides better inequalities than the trivial choice with identical values $a_{\mu} a_{\nu}=\min r_{\mu \nu}$.)

Generally, it is difficult to find for a given $R$ with positive correlations an M-matrix $R_{0}^{-1}$ with $R_{0}<R$ in such a way that good positive and numerically available lower bounds are obtained for the difference $P_{R}\left(\bigcap_{i=1}^{n} A_{i}\right)$ $P_{R_{0}}\left(\bigcap_{i=1}^{n} A_{i}\right)$. Theorem 3 and theorem 5 in conjecture with theorem 4 give some examples for this goal.

In particular, let $R_{\Theta}$ be a correlation matrix as in (5.4) with $p=3$ and $R>R_{\Theta}$ any correlation matrix with the same three one-factorial diagonal blocks $R_{i i}$ as in $R_{\Theta}$. If $R_{0}$ is obtained from $R_{\Theta}$ by replacing the three numbers $\vartheta_{i}=\vartheta_{j k}$ by zeros then $R>R_{\Theta}>R_{0}$ and

If we get after a transformation with a suitable signature matrix a correlation matrix with only positive correlations and - possibly after a suitable permutation of the indices - a correlation matrix $R=\left(R_{j k}\right)$ with nine $(3 \times 3)$ - blocks $R_{j k}$ and one-factorial diagonal blocks ( $R_{j j}$ ) with factors $a_{\mu} \in(0,1)$, then we have to find the correlations $\vartheta_{j k} \in(0,1), 1 \leq j<k \leq 3$, which satisfy the conditions

If an $(n \times n)$-correlation matrix with only positive correlations is written as a $(2 \times 2)$ - block matrix $\left(R_{i k}\right)$ with ( $n_{i} \times n_{i}$ ) - matrices $R_{i i}$ and if $R_{\rho}$ is obtained from $R$ by replacing all the correlations within $R_{12}$ and $R_{21}$ by their minimum $\rho$ (or by a smaller value $\rho$ ) then we can obtain further inequalities for the excess in (1.1) if $R_{\rho}^{-1}$ is an M-matrix, but actual computations require much effort even for moderate dimensions (apart from simulations). If the $R_{i i}^{-1}$ are diagonal dominant M-matrices with only negative off-diagonal elements then we obtain with $R_{12}=\rho \overrightarrow{1}_{1} \overrightarrow{1}_{2}^{\prime}$ and $q_{i}:=\overline{1}_{i}^{\prime} R_{i i}^{-1} \overrightarrow{1}_{i}$ the inverse matrix

Many $(4 \times 4)$-correlation matrices are 2factorial. With 2-factorial $R_{i i}$ we can compute the derivatives of $F\left(\vec{x}_{i} ; \alpha+k, R_{i i}\right)$ by means of formula (2.9) with $m=2$ and $\frac{\partial}{\partial x} g_{\alpha+k}(x ; y)=g_{\alpha+k-1}(x ; y)-g_{\alpha+k}(x ; y)$. Therefore, formula (5.18) is possibly useful for $n \leq$ 8.

For inf. div. $\Gamma_{n}(\alpha, R)$ - distributions, the following probability inequalities are derived from the GCI. Today, Gaussian probabilities for symmetrical n-rectangles can be computed for rather high dimensions, and therefore for the $\Gamma_{n}\left(\frac{1}{2}, R\right)$ - cdf too. For a $\Gamma_{n}\left(\frac{1}{2}, R\right)$-distributed random vector $\left(X_{1}, \ldots, X_{n}\right)$ let be

For the $\Gamma_{n}(\alpha, R)$ - distributed random vectors with $2 \alpha \in \mathbb{N}$ we find for the corresponding events $A_{i}$ inductively by successive convolutions

For the computation of a $\Gamma_{n}(\alpha, R)$ - cdf with $n \leq 4$ and very accurate approximations for $n=5$ see the appendix in [5]. If $n_{1}>5$ and (or) $n_{2}>5$ then $P\left(\bigcap_{i \leq n_{1}} A_{i}\right), P\left(\bigcap_{i>n_{1}} A_{i}\right)$ can be approximated in a similar way under the corresponding assumptions. Numerical examples seem to show that the absolute error of these (frequently conservative) approximations is often smaller than the deviations with refined Bonferroni inequalities of third or even fourth order. The latter ones are inequalities of the form

In theorem 3 in [19] the following only local inequality for $\Gamma_{n}(\alpha, R)$ - cdfs with identical values $x_{i}=x$ was proved. We consider the set of all $(n \times n)$ - correlation matrices $R$ with the same mean correlation $r \geq 0$. Then for any fixed values $x>0, n \geq 3$, and any admissible $\alpha \geq \frac{1}{2}$ the function $\psi: R \rightarrow P\left\{\max X_{i} \leq x ; \alpha, R\right\}$ has a local minimum within this set at the correlation matrix $R_{r}$ with identical correlations $r$ if

Frequently, $\lambda>0$ is recognized already by a plot of the integrand of $\lambda$. This result was obtained by an analysis of the Taylor polynomial of $2^{\text {nd }}$ degree for $\psi\left(R_{r}+H\right)$ with small "correlation deviations" $h_{i j}$ in $H$ and $\sum_{i<j} h_{i j}=0$.
It seems that a corresponding global inequality is hardly available, but further investigations are recommended.

The char. function is

\left|I_{n}-i R_{\Theta} T\right|^{-\alpha}=\left(\prod_{\mu=1}^{n} z_{\mu}^{\alpha}\right)\left(\prod_{i=1}^{3} \delta_{i}^{-\alpha}\right)\left(1-\left(\vartheta_{12}^{2} \zeta_{1} \zeta_{2}+\vartheta_{13}^{2} \zeta_{1} \zeta_{3}+\vartheta_{23}^{2} \zeta_{2} \zeta_{3}-2 \vartheta_{12} \vartheta_{13} \vartheta_{23} \zeta_{1} \zeta_{2} \zeta_{3}\right)\right)^{-\alpha} \tag{A1}
\end{equation*}
$$

with complex values $\zeta_{j}=1-\delta_{j}^{-1}$ and $z_{\mu}=\left(1-i\left(1-a_{\mu}^{2}\right) t_{\mu}\right)^{\alpha}$. The values $z_{\mu}$ and $u_{\mu}=1-z_{\mu}$ lie on the circle defined by $e^{i \gamma} \cos \gamma,|\gamma| \leq \frac{1}{2} \pi$. The values $\zeta_{j}$ lie within the circles given by

\begin{equation*}
d_{j} e^{i \gamma} \cos (\gamma), d_{j}=\left|\zeta_{j}\right|=\left(\sum_{\mu \in I_{j}} \frac{a_{\mu}^{2}}{1-a_{\mu}^{2}}\right)\left(1+\sum_{\mu \in I_{j}} \frac{a_{\mu}^{2}}{1-a_{\mu}^{2}}\right)^{-1}, j=1,2,3 . \tag{A2}
\end{equation*}
$$

For the convergence of the binomial series for the last factor in (A1) we need with $\tilde{\vartheta}_{i}=\vartheta_{j k} \sqrt{d_{j} d_{k}}$ and $c_{j}=$ $\cos \gamma_{j}, s_{j}=\sin \gamma_{j}, t_{j}=\tan \gamma_{j}$ the condition

$$
\begin{align*}
& \rho^{2}= \\
& \left|\vartheta_{12}^{2} d_{1} d_{2} c_{1} c_{2} e^{i\left(\gamma_{1}+\gamma_{2}\right)}+\vartheta_{13}^{2} d_{1} d_{3} c_{1} c_{3} e^{i\left(\gamma_{1}+\gamma_{3}\right)}+\vartheta_{23}^{2} d_{2} d_{3} c_{2} c_{3} e^{i\left(\gamma_{2}+\gamma_{3}\right)}-2 \vartheta_{12} \vartheta_{13} \vartheta_{23} d_{1} d_{2} d_{3} c_{1} c_{2} c_{3} e^{i\left(\gamma_{1}+\gamma_{2}+\gamma_{3}\right)}\right|^{2}= \\
& \left|\tilde{\vartheta}_{3}^{2} c_{1} c_{2} e^{-i \gamma_{3}}+\tilde{\vartheta}_{2}^{2} c_{1} c_{3} e^{-i \gamma_{2}}+\tilde{\vartheta}_{1}^{2} c_{2} c_{3} e^{-i \gamma_{1}}-2 \tilde{\vartheta}_{1} \tilde{\vartheta}_{2} \tilde{\vartheta}_{3} c_{1} c_{2} c_{3}\right|^{2}= \\
& \frac{\tilde{\vartheta}^{2}+\left(\sum_{j=1}^{3} \tilde{\vartheta}_{j}^{2} t_{j}\right)^{2}}{\prod_{j=1}^{3}\left(1+t_{j}^{2}\right)}<1 \text {, where } \tilde{\vartheta}=1-|\tilde{\Theta}|=\sum_{j=1}^{3} \tilde{\vartheta}_{j}^{2}-2 \tilde{\vartheta}_{1} \tilde{\vartheta}_{2} \tilde{\vartheta}_{3} \in(0,1) . \tag{A3}
\end{align*}

This inequality is not always satisfied, in particular for larger values of the correlations $\tilde{\vartheta}_{j}$. The difference between the denominator and the nominator of $\rho^{2}$ is

$$
1-\tilde{\theta}^{2}+\sum_{j=1}^{3}\left(1-\tilde{\vartheta}_{j}^{4}\right) t_{j}^{2}-2 \sum_{i<j} \tilde{\vartheta}_{i}^{2} \tilde{\vartheta}_{j}^{2} t_{i} t_{j}+\sum_{i<j} t_{i}^{2} t_{j}^{2}+\left(t_{1} t_{2} t_{3}\right)^{2} .
$$

The here appearing quadratic form is positive semi-definite iff

$$
\begin{equation*}
\sum_{j=1}^{3} \tilde{\vartheta}_{j}^{4} \leq 1 . \tag{A4}
\end{equation*}
$$

Thus, (A4) is a sufficient (but not necessary) condition for max $\rho^{2}<1$.
If (A4) fails, then stationary points of $\rho^{2}$ (or equivalently of $\log \rho^{2}$ ) can be found by the necessary condition of identical values

$$
\begin{equation*}
s_{j} c_{j} \tilde{\vartheta}_{j}^{-2}=\tau, j=1,2,3 . \tag{A5}
\end{equation*}
$$

Therefore, with $c_{j}^{2}=\frac{1}{2}\left(1+\sqrt{1-4 \tau^{2} \tilde{\vartheta}_{j}^{4}}\right)$ (negative signs before the root don't lead to a maximum) and

$$
\begin{equation*}
\Sigma_{\tau}=\sum_{j} \tilde{\vartheta}_{j}^{2} t_{j}=2 \tau \sum_{j} \tilde{\vartheta}_{j}^{4}\left(1+\sqrt{1-4 \tau^{2} \tilde{\vartheta}_{j}^{4}}\right)^{-1}=\frac{1}{2 \tau}\left(3-\sum_{j} \sqrt{1-4 \tau^{2} \tilde{\vartheta}_{j}^{4}}\right) \tag{A6}
\end{equation*}
$$

we find $\Sigma_{\tau}=\tau\left(\tilde{\vartheta}^{2}+\Sigma_{\tau}^{2}\right)$ and consequently

$$
\tilde{\vartheta}^{2}+\Sigma_{\tau}^{2}=\tau^{-1} \Sigma_{\tau}=\frac{1}{2 \tau^{2}}\left(1 \mp \sqrt{1-4 \tau^{2} \tilde{\vartheta}^{2}}\right)=\frac{1}{2 \tau^{2}}\left(3-\sum_{j} \sqrt{1-4 \tau^{2} \tilde{\vartheta}_{j}^{4}}\right) .
$$

Therefore, we have to look for a solution of the equation

$$
\begin{equation*}
2-\sum_{j=1}^{3} \sqrt{1-4 \tilde{\vartheta}_{j}^{4} x}-\operatorname{sgn}\left(x-x_{0}\right) \sqrt{1-4 \tilde{\vartheta}^{2} x}=0 \tag{A7}
\end{equation*}
$$

for $x=\tau^{2} \in\left(0, x_{1}\right]$ with the solution $x_{0}$ of $\sum_{j=1}^{3} \sqrt{1-4 \tilde{\vartheta}_{j}^{4} x}=2$ and $x_{1}=\frac{1}{4} \tilde{\vartheta}^{-2}$ (it is always $\left.\tilde{\vartheta}^{2}>\max \tilde{\vartheta}_{j}^{4}\right)$. If max $\rho^{2}$ is attained with $t_{k}=0$, where $\tilde{\vartheta}_{k}^{2}=\min \tilde{\vartheta}_{j}^{2}$, then

$$
\begin{equation*}
1-\sum_{j \neq k} \sqrt{1-4 \tilde{\vartheta}_{j}^{4} x}-\operatorname{sgn}\left(x-x_{0}\right) \sqrt{1-4 \tilde{\vartheta}^{2} x}=0 \tag{A8}
\end{equation*}
$$

has to be solved with $\sum_{j \neq k} \sqrt{1-4 \tilde{\vartheta}_{j}^{4} x_{0}}=1$. The equations (A7) and (A8) have at most one solution. Only one $t_{k} \neq 0$ implies $\rho^{2} \leq \tilde{\vartheta}^{2}<1$.
