# Conditional Independence Beyond Domain Separability Discussion of Engelke and Hitz (2020)

## 1 A general definition of conditional independence

We congratulate Engelke and Hitz on a thought-provoking paper on graphical models for extremes. A key contribution of the paper is the introduction of a novel definition of conditional independence for a multivariate Pareto distribution. Here, we outline a proposal for independence and conditional independence of general random variables whose support is a general set $\Omega$ in $\mathbb{R}^{d}$. Our proposal includes the authors' definition of conditional independence, and the analogous definition of independence as special cases. By making our proposal independent of the context of extreme value theory, we highlight the importance of the authors' contribution beyond this particular context.

Definition 1: Suppose that $\mathbf{Y}=\left(\mathbf{Y}_{A}, \mathbf{Y}_{B}, \mathbf{Y}_{C}\right)$ is a random vector with support $\Omega$ in $\mathbb{R}^{d}$, where $A, B, C$ are disjoint sets whose union is $\{1, \ldots, d\}$. Let $U \times V$ denote the Cartesian product of $U$ and $V$.
(a) We say $\mathbf{Y}_{A}$ is conditionally outer independent of $\mathbf{Y}_{C}$ given $\mathbf{Y}_{B}$ if there exists a random vector $\mathbf{W}=\left(\mathbf{W}_{A}, \mathbf{W}_{B}, \mathbf{W}_{C}\right)$ with support $L_{A} \times L_{B} \times L_{C}$ in $\mathbb{R}^{d}$ such that (i) $\Omega \subset L_{A} \times L_{B} \times L_{C}$; (ii) $(\mathbf{W} \mid \mathbf{W} \in \Omega) \stackrel{d}{=} \mathbf{Y}$; (iii) $\mathbf{W}_{A \Perp} \mathbf{W}_{C} \mid \mathbf{W}_{B}$. In this case, we write $\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$.
If $B=\emptyset$, we say $\mathbf{Y}_{A}$ is outer independent of $\mathbf{Y}_{C}$, denoted as $\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C}$.
(b) We say $\mathbf{Y}_{A}$ is conditionally inner independent of $\mathbf{Y}_{C}$ given $\mathbf{Y}_{B}$ if for any $S_{A} \times S_{B} \times S_{C} \subset \Omega$ such that $S_{k}$ is a measurable subset of $\mathbb{R}^{\operatorname{dim}\left(Y_{k}\right)}, k \in\{A, B, C\}$ and $P\left(\mathbf{Y} \in S_{A} \times S_{B} \times S_{C}\right)>0$, we have $\mathbf{Y}_{A} \Perp \mathbf{Y}_{C} \mid\left(\mathbf{Y}_{B}, \mathbf{Y} \in S_{A} \times S_{B} \times S_{C}\right)$. In this case, we write $\mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$.
If $B=\emptyset$, we say $\mathbf{Y}_{A}$ is inner independent of $\mathbf{Y}_{C}$, denoted as $\mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C}$.
Proposition 1: Suppose $\Omega=[0, \infty)^{d} \backslash[0,1]^{d}$ as in EH's case. Then

$$
\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C}\left|\mathbf{Y}_{B} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C}\right| \mathbf{Y}_{B} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C} \mid \mathbf{Y}_{B} .
$$

where $\Perp_{e}$ denotes the notion of conditional independence introduced by Engelke and Hitz (2020). In particular, if $B=\emptyset$, then

$$
\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C}
$$

Remark 1: We do not place any distributional assumptions on $\mathbf{Y}$ in Proposition 1.

[^0]Engelke and Hitz showed that if $\mathbf{Y}$ is multivariate Pareto and admits a positive and continuous density, then $\mathbf{Y}_{A} \nVdash_{e} \mathbf{Y}_{C}$. This does not rule out the possibility of $\mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C}$ for general Pareto distributions. For example, consider two independent standard Pareto distributions $X_{1}$ and $X_{2}$. Following eqn. (6) in Engelke and Hitz (2020), all the probability mass of $\mathbf{Y}$ lies on $(1, \infty) \times\{0\}$ and $\{0\} \times(1, \infty)$ so that it does not admit a density with respect to Lebesgue measure. Nevertheless $Y_{1} \Perp_{e} Y_{2}$. This observation is generalized in Proposition 2.

Proposition 2: Suppose $\Omega=\left[\left([0, \infty)^{|A|} \backslash[0,1]^{|A|}\right) \times\{0\}^{|B|} \times\{0\}^{|C|}\right] \cup\left[\{0\}^{|A|} \times\left([0, \infty)^{|B|} \backslash[0,1]^{|B|}\right) \times\{0\}^{|C|}\right]$ $\cup\left[\{0\}^{|A|} \times\{0\}^{|B|} \times\left([0, \infty)^{|C|} \backslash[0,1]^{|C|}\right)\right]$, where $|A|$ is the cardinality of set $A$. Then

$$
\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C}\left|\mathbf{Y}_{B} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C}\right| \mathbf{Y}_{B} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}
$$

In particular, if $B=\emptyset$, then

$$
\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \quad \Leftrightarrow \quad \mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C} .
$$

## 2 Proofs of propositions

### 2.1 Proof of Proposition 1 in the case where $B=\emptyset$

Proof. We need to show

$$
\begin{equation*}
\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \Rightarrow \mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \Rightarrow \mathbf{Y}_{A} \Perp_{e} \mathbf{Y}_{C} \Rightarrow \mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} . \tag{1}
\end{equation*}
$$

The first two claims are straightforward. We now prove the third claim in (1).
Let $H_{k}^{1} \subset L_{k}^{1}=[0,1]^{|k|}, H_{k}^{2} \subset L_{k}^{2}=[0, \infty)^{|k|} \backslash[0,1]^{|k|}, H_{k}=H_{k}^{1} \cup H_{k}^{2}, L_{k}=L_{k}^{1} \cup L_{k}^{2}, k \in\{A, C\}$. Obviously, $H_{k}^{1} \cap H_{k}^{2}=\emptyset$ and $L_{k}^{1} \cap L_{k}^{2}=\emptyset$. Besides, $\Omega=[0, \infty)^{d} \backslash[0,1]^{d} \subset L_{A} \times L_{C}$.

We let

$$
\begin{equation*}
P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{1}\right)=\frac{P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right) P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)} \tag{2}
\end{equation*}
$$

and

$$
P\left(\mathbf{W}_{A} \in H_{A}^{i}, \mathbf{W}_{C} \in H_{C}^{j}\right)=\lambda P\left(\mathbf{Y}_{A} \in H_{A}^{i}, \mathbf{Y}_{C} \in H_{C}^{j}\right), \quad(i, j) \neq(1,1)
$$

where $\lambda$ is a normalizing constant. Simple calculation yields

$$
\lambda=\frac{1}{1+\frac{P\left(\mathbf{Y}_{A} \in L_{A}^{1}, \mathbf{Y}_{C} \in L_{C}^{2}\right) P\left(\mathbf{Y}_{A} \in L_{A}^{2}, \mathbf{Y}_{C} \in L_{C}^{1}\right)}{P\left(\mathbf{Y}_{A} \in L_{A}^{2}, \mathbf{Y}_{C} \in L_{C}^{2}\right)}}
$$

It is easy to see that $(\mathbf{W} \mid \mathbf{W} \in \Omega) \stackrel{d}{=} \mathbf{Y}$. We then prove

$$
\mathbf{W}_{A} \Perp \mathbf{W}_{C} .
$$

If $k \in A$ and $\left\{\mathbf{W}_{A} \in H_{A}\right\} \cap\left\{\mathbf{W}_{A}: W_{k}>1\right\}=\emptyset$, then

$$
\begin{equation*}
P\left(\mathbf{W}_{A} \in H_{A}, \mathbf{W}_{C} \in H_{C} \mid W_{k}>1\right)=P\left(\mathbf{W}_{A} \in H_{A} \mid W_{k}>1\right) P\left(\mathbf{W}_{C} \in H_{C} \mid W_{k}>1\right)=0 . \tag{3}
\end{equation*}
$$

If $k \in A$ and $\left\{\mathbf{W}_{A} \in H_{A}\right\} \cap\left\{\mathbf{W}_{A}: W_{k}>1\right\} \neq \emptyset$, then $\left\{\mathbf{W}_{A} \in H_{A}\right\} \cap\left\{\mathbf{W}_{A}: W_{k}>1\right\}=\left\{\mathbf{W}_{A} \in\right.$ $\left.H_{A}^{2}, W_{k}>1\right\}$ and

$$
\begin{aligned}
& P\left(\mathbf{W}_{A} \in H_{A}, \mathbf{W}_{C} \in H_{C}, W_{k}>1\right) \\
= & \lambda P\left(\mathbf{Y}_{A} \in H_{A}, \mathbf{Y}_{C} \in H_{C}, Y_{k}>1\right) \\
= & \lambda P\left(\mathbf{Y}_{C} \in H_{C} \mid \mathbf{Y}_{A} \in H_{A}, Y_{k}>1\right) P\left(\mathbf{Y}_{A} \in H_{A}, Y_{k}>1\right) \\
= & P\left(\mathbf{Y}_{C} \in H_{C} \mid Y_{k}>1\right) P\left(\mathbf{W}_{A} \in H_{A}, W_{k}>1\right) \quad\left(\mathbf{Y}_{A} \Perp \mathbf{Y}_{C} \mid Y_{k}>1\right) .
\end{aligned}
$$

So we have

$$
\begin{align*}
P\left(\mathbf{W}_{C} \in H_{C} \mid \mathbf{W}_{A} \in H_{A}, W_{k}>1\right) & =P\left(\mathbf{Y}_{C} \in H_{C} \mid Y_{k}>1\right) \\
& =\frac{P\left(\mathbf{Y}_{C} \in H_{C}, Y_{k}>1\right)}{P\left(Y_{k}>1\right)} \\
& =\frac{P\left(\mathbf{W}_{C} \in H_{C}, W_{k}>1\right) / \lambda}{P\left(W_{k}>1\right) / \lambda}  \tag{4}\\
& =\frac{P\left(\mathbf{W}_{C} \in H_{C}, W_{k}>1\right)}{P\left(W_{k}>1\right)} \\
& =P\left(\mathbf{W}_{C} \in H_{C} \mid W_{k}>1\right) .
\end{align*}
$$

Thus, from (3) and (4), we have for any $k \in A, \mathbf{W}_{A} \Perp \mathbf{W}_{C} \mid W_{k}>1$. Similarly, we have for any $k \in C$, $\mathbf{W}_{A} \Perp \mathbf{W}_{C} \mid W_{k}>1$. In summary,

$$
\begin{equation*}
\forall k \in\{1, \ldots, d\}: \mathbf{W}_{A} \Perp \mathbf{W}_{C} \mid W_{k}>1 \tag{5}
\end{equation*}
$$

We then show that for any $H_{A}^{1}, H_{C}^{1}, H_{A}^{2}, H_{C}^{2}$, we have

$$
\begin{equation*}
\frac{P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}=\frac{P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{2}\right)} \tag{6}
\end{equation*}
$$

To prove (6), note that

$$
\begin{aligned}
& \frac{P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right) \\
= & \frac{P\left(\mathbf{W}_{A} \in H_{A}^{1} \mid \mathbf{W}_{C} \in H_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2} \mid \mathbf{W}_{C} \in H_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right) \\
= & \frac{P\left(\mathbf{W}_{A} \in H_{A}^{1} \mid \mathbf{W}_{C} \in H_{C}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2} \mid \mathbf{W}_{C} \in H_{C}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right) \\
= & \frac{P\left(\mathbf{W}_{A} \in H_{A}^{1} \mid \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2} \mid \mathbf{W}_{C} \in L_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right) \quad \text { due to (5) } \\
= & \frac{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right) \\
= & \frac{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{2}, \mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right) \\
= & \frac{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)} P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right) \quad \text { due to (5) } \\
= & P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{1}\right) \quad \text { due to (2). }
\end{aligned}
$$

We then show that

$$
\begin{equation*}
P\left(\mathbf{W}_{C} \in L_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{2}\right)=P\left(\mathbf{W}_{C} \in L_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right) . \tag{7}
\end{equation*}
$$

To prove (7), note that due to (6),

\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{1}\right)}=\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)}
$$

Then

$$
\begin{aligned}
\text { LHS of (7) } & =\frac{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}\right)} \\
& =\frac{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)+P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{1}\right)} \\
& =\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)+P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{1}\right)} \\
& =\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{1}\right)} \\
& =P\left(\mathbf{W}_{C} \in L_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right)=\text { RHS of }(7) .
\end{aligned}
$$

Similarly we have

P\left(\mathbf{W}_{C} \in L_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{2}\right)=P\left(\mathbf{W}_{C} \in L_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{1}\right) .
$$

We then show that

$$
P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{2}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right) .
$$

To see this, due to (6),

\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in H_{C}^{1}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in H_{C}^{1}\right)}=\frac{P\left(\mathbf{W}_{A} \in L_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)}{P\left(\mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C} \in L_{C}^{2}\right)}
$$

Furthermore, due to (7),

$$
\frac{P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{1}\right)}{P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{2}\right)}=\frac{P\left(\mathbf{W}_{C} \in L_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right)}{P\left(\mathbf{W}_{C} \in L_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{2}\right)}=1
$$

Due to (5) and (6), it follows directly that

\begin{align*}
P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid\right. & \left.\mathbf{W}_{A} \in L_{A}^{2}\right) \\
& =P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in H_{A}^{2}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{2}\right) . \tag{8}
\end{align*}
$$

Similarly we have

\begin{equation*}
P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{1}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in H_{A}^{2}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{1}\right) . \tag{9}
\end{equation*}
$$

We still need to show

$$
\begin{align*}
& P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in H_{A}^{1}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in L_{A}^{1}\right),  \tag{10}\\
& P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in H_{A}^{1}\right)=P\left(\mathbf{W}_{C} \in H_{C}^{1} \mid \mathbf{W}_{A} \in L_{A}^{1}\right) . \tag{11}
\end{align*}
$$

To show (10), note that due to (5) and (6),

& P\left(\mathbf{W}_{C} \in H_{C}^{2} \mid \mathbf{W}_{A} \in H_{A}^{1}\right) \\
& =\frac{P\left(\mathbf{W}_{C} \in H_{C}^{2}, \mathbf{W}_{A} \in H_{A}^{1}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{1}\right)} \\
& =\frac{\lambda P\left(\mathbf{Y}_{C} \in H_{C}^{2}, \mathbf{Y}_{C} \in L_{C}^{2}, \mathbf{Y}_{A} \in H_{A}^{1}\right)}{P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{1}\right)+P\left(\mathbf{W}_{A} \in H_{A}^{1}, \mathbf{W}_{C} \in L_{C}^{2}\right)} \\

Thus, from $f\left(\mathbf{w}_{1}, \mathbf{w}_{2}\right)$, we have the support of $\mathbf{W}=\left(\mathbf{W}_{A}, \mathbf{W}_{C}\right)$ is $[0, \infty)^{|A|+|C|}$, which contains $\Omega$. Based on the definition of conditional density in Shorack (2017, §7.4), we have that the conditional density at ( $\mathbf{w}_{A}, \mathbf{0}_{C}$ ), $\left(\mathbf{w}_{A} \in L_{A}^{2}\right)$ and $\left(\mathbf{0}_{A}, \mathbf{w}_{C}\right),\left(\mathbf{w}_{C} \in L_{C}^{2}\right)$ given that all the points are on the curve of $\Omega$ are

Thus, we can define $P\left(\mathbf{W}_{A} \leq \mathbf{w}_{A}, \mathbf{W}_{C} \leq \mathbf{w}_{C} \mid \mathbf{W}_{A} \in L_{A}^{2}, \mathbf{W}_{C}=\mathbf{0}_{C}\right.$ or $\left.\mathbf{W}_{A}=\mathbf{0}_{A}, \mathbf{W}_{C} \in L_{C}^{2}\right)$ as that in (29). Given $\mathbf{Y}_{B}=\mathbf{0}_{B}$, since $\mathbf{Y}_{A}=\mathbf{0}_{A}$ regardless of the value of $\mathbf{Y}_{C}$, then $\mathbf{Y}_{A} \Perp \mathbf{Y}_{C} \mid\left(\mathbf{Y}_{B}, \mathbf{Y} \in S_{A} \times S_{B} \times S_{C}\right)$. Thus, based on the definition of $\mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$, we have $\mathbf{Y}_{A} \Perp_{i} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$.

Second, we show (32). When $\mathbf{w}_{A} \in L_{A}^{2}, \mathbf{w}_{B} \in L_{B}^{2}, \mathbf{w}_{C} \in L_{C}^{1}$, due to $P\left(\mathbf{Y}_{A} \leq \mathbf{w}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)=P\left(\mathbf{Y}_{A} \leq\right.$ $\left.\mathbf{w}_{A}, \mathbf{Y}_{B}=\mathbf{0}_{B}, \mathbf{Y}_{C}=\mathbf{0}_{C}\right)+P\left(\mathbf{Y}_{A}=\mathbf{0}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C}=\mathbf{0}_{C}\right)$,

&= \frac{\left.\int_{\left[\mathbf{0}_{A}, \mathbf{w}_{A}\right] \backslash[0,1]}\right]^{A \mid} \mid}{} f\left(\mathbf{t}, \mathbf{0}_{B}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{t}+\int_{\left[\mathbf{0}_{B}, \mathbf{w}_{B}\right] \backslash[0,1]|B|} f\left(\mathbf{0}_{A}, \mathbf{t}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{t} \\

&= \frac{\left\{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right) \alpha_{2}-\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right) \alpha_{1}\right\} P\left(\mathbf{Y}_{A} \leq \mathbf{w}_{A}, \mathbf{Y}_{B}=\mathbf{0}_{B}, \mathbf{Y}_{C}=\mathbf{0}_{C}\right)}{\alpha_{1} \alpha_{2}\left\{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right)+\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right)+\left(1-p_{A}\right)\left(1-p_{B}\right) p_{C}\right\}} \\
&+\frac{\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right) P\left(\mathbf{Y}_{A} \leq \mathbf{w}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)}{\alpha_{2}\left\{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right)+\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right)+\left(1-p_{A}\right)\left(1-p_{B}\right) p_{C}\right\}} .

When $\mathbf{w}_{A} \in L_{A}^{2}, \mathbf{w}_{B} \in L_{B}^{2}, \mathbf{w}_{C} \in L_{C}^{2}$, due to $P\left(\mathbf{Y}_{A} \leq \mathbf{w}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)=P\left(\mathbf{Y}_{A} \leq\right.$ $\left.\mathbf{w}_{A}, \mathbf{Y}_{B}=\mathbf{0}_{B}, \mathbf{Y}_{C}=\mathbf{0}_{C}\right)+P\left(\mathbf{Y}_{A}=\mathbf{0}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C}=\mathbf{0}_{C}\right)+P\left(\mathbf{Y}_{A}=\mathbf{0}_{A}, \mathbf{Y}_{B}=\mathbf{0}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)$,

& =\frac{\int_{\left[\mathbf{0}_{A}, \mathbf{w}_{A}\right] \backslash[0,1]^{|A|}} f\left(\mathbf{t}, \mathbf{0}_{B}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{t}+\int_{\left.\left[\mathbf{0}_{B}, \mathbf{w}_{B}\right] \backslash 0,1\right]^{B \mid} \mid} f\left(\mathbf{0}_{A}, \mathbf{t}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{t}+\int_{\left.\left[\mathbf{0}_{C}, \mathbf{w}_{C}\right] \backslash 0,1\right]|C|} f\left(\mathbf{0}_{A}, \mathbf{0}_{B}, \mathbf{t}\right) \mathrm{d} \mathbf{t}}{\int_{L_{A}^{2}} f\left(\mathbf{w}_{A}, \mathbf{0}_{B}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{w}_{A}+\int_{L_{B}^{2}} f\left(\mathbf{0}_{A}, \mathbf{w}_{B}, \mathbf{0}_{C}\right) \mathrm{d} \mathbf{w}_{B}+\int_{L_{C}^{2}} f\left(\mathbf{0}_{A}, \mathbf{0}_{B}, \mathbf{w}_{C}\right) \mathrm{d} \mathbf{w}_{C}} \\

By comparison, we can find that $P\left(\mathbf{W}_{A} \leq \mathbf{w}_{A}, \mathbf{W}_{B} \leq \mathbf{w}_{B}, \mathbf{W}_{C} \leq \mathbf{w}_{C} \mid \mathbf{W} \in \Omega\right)=P\left(\mathbf{Y}_{A} \leq\right.$ $\left.\mathbf{w}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)$ if and only if

$$
\left\{\begin{array}{l}
\alpha_{1}=\frac{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right)}{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right)+\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right)+\left(1-p_{A}\right)\left(1-p_{B}\right) p_{C}},  \tag{34}\\
\alpha_{2}=\frac{\left(1-p_{A}\right)_{B}\left(1-p_{C}\right)}{p_{A}\left(1-p_{B}\right)\left(1-p_{C}\right)+\left(1-p_{A}\right) p_{B}\left(1-p_{C}\right)+\left(1-p_{A}\right)\left(1-p_{B}\right) p_{C}} .
\end{array}\right.
$$

We have hence shown that under condition (34), $(\mathbf{W} \mid \mathbf{W} \in \Omega) \stackrel{d}{=} \mathbf{Y}$ if the density function of $F\left(\mathbf{w}_{A}, \mathbf{w}_{B}, \mathbf{w}_{C}\right)$ exists.

If the density function of $F\left(\mathbf{w}_{A}, \mathbf{w}_{B}, \mathbf{w}_{C}\right)$ does not exist, from the definition of conditional probability in Shorack (2017, §7.4), we know that the above formulas for $P\left(\mathbf{W}_{A} \leq \mathbf{w}_{A}, \mathbf{W}_{B} \leq \mathbf{w}_{B}, \mathbf{W}_{C} \leq\right.$ $\left.\mathbf{w}_{C} \mid \mathbf{W} \in \Omega\right)$ still satisfy the condition for conditional probability. Thus, we still can define $P\left(\mathbf{W}_{A} \leq\right.$ $\mathbf{w}_{A}, \mathbf{W}_{B} \leq \mathbf{w}_{B}, \mathbf{W}_{C} \leq \mathbf{w}_{C} \mid \mathbf{W} \in \Omega$ ) in the same way as before. Under condition (34), we also have $P\left(\mathbf{W}_{A} \leq \mathbf{w}_{A}, \mathbf{W}_{B} \leq \mathbf{w}_{B}, \mathbf{W}_{C} \leq \mathbf{w}_{C} \mid \mathbf{W} \in \Omega\right)=P\left(\mathbf{Y}_{A} \leq \mathbf{w}_{A}, \mathbf{Y}_{B} \leq \mathbf{w}_{B}, \mathbf{Y}_{C} \leq \mathbf{w}_{C}\right)$. Then $(\mathbf{W} \mid \mathbf{W} \in \Omega) \stackrel{d}{=} \mathbf{Y}$.

In summary, according to the definition of $\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$, we have $\mathbf{Y}_{A} \Perp_{o} \mathbf{Y}_{C} \mid \mathbf{Y}_{B}$.
