On a linearized Mullins-Sekerka/Stokes system for two-phase flows

Abstract

We study a linearized Mullins-Sekerka/Stokes system in a bounded domain with various boundary conditions. This system plays an important role to prove the convergence of a Stokes/Cahn-Hilliard system to its sharp interface limit, which is a Stokes/Mullins-Sekerka system, and to prove solvability of the latter system locally in time. We prove solvability of the linearized system in suitable L^2 -Sobolev spaces with the aid of a maximal regularity result for non-autonomous abstract linear evolution equations.

1 Introduction

We study the following linearized Mullins-Sekerka/Stokes system

$$D_{t,\Gamma}h + \mathbf{b} \cdot \nabla_{\Gamma}h - bh + \frac{1}{2}X_0^* \left((\mathbf{v}^+ + \mathbf{v}^-) \cdot \mathbf{n}_{\Gamma_t} \right) + \frac{1}{2}X_0^* \left(\left[\partial_{\mathbf{n}_{\Gamma_t}} \mu \right] \right) = g \quad \text{on } \Sigma \times (0,T) ,$$
$$h(.,0) = h_0 \quad \text{in } \Sigma,$$

where for every $t \in [0,T]$, the functions $\mathbf{v}^{\pm} = \mathbf{v}^{\pm}(x,t)$, $p^{\pm} = p^{\pm}(x,t)$ and $\mu^{\pm} = \mu^{\pm}(x,t)$ for $(x,t) \in \Omega_T^{\pm}$ with $\mathbf{v}^{\pm} \in H^2(\Omega^{\pm}(t))^d$, $p^{\pm} \in H^1(\Omega^{\pm}(t))$ and $\mu^{\pm} \in H^2(\Omega^{\pm}(t))$

are the unique solutions to

$$\Delta \mu^{\pm} = a_1 \qquad \qquad \text{in } \Omega^{\pm}(t), \tag{1}$$

$$\mu^{\pm} = X_0^{*,-1} \left(\sigma \Delta_{\Gamma} h \pm a_2 h \right) + a_3 \qquad \text{on } \Gamma_t, \qquad (2)$$

$$\mathbf{n} \cdot \nabla \mu^{-} = a_{4} \qquad \qquad \text{on } \Gamma_{\mu,1}, \qquad (3)$$
$$\mu^{-} = a_{4} \qquad \qquad \text{on } \Gamma_{\mu,2}, \qquad (4)$$

$$\operatorname{div} \mathbf{v}^{\pm} = 0 \qquad \qquad \text{in } \Omega^{\pm}(t), \tag{6}$$

$$[\mathbf{v}] = \mathbf{a}_2 \qquad \qquad \text{on } \Gamma_t, \tag{7}$$

$$[2D_s \mathbf{v} - p\mathbf{I}] \mathbf{n}_{\Gamma_t} = X_0^{*,-1} (\mathbf{a}_3 h + \mathbf{a}_4 \Delta_{\Gamma} h + a_5 \nabla_{\Gamma} h + \mathbf{a}_5) \quad \text{on } \Gamma_t, \tag{8}$$
$$B_j(\mathbf{v}^-, p^-) = \mathbf{a}_6 \quad \text{on } \Gamma_{S,j}, j = 1, 2, 3. \tag{9}$$

Here $\Omega \subseteq \mathbb{R}^d$, d = 2, 3, is a bounded domain with smooth boundary, which is the disjoint union of $\Omega^+(t)$, $\Omega^-(t)$ and Γ_t , where $\Gamma_t = \partial \Omega^+(t)$ is a smoothly evolving (d-1)-dimensional orientable hypersurface. We assume that $\Gamma_t \subseteq \Omega$ for all $t \in (0,T)$, i.e., there is no boundary contact and contact angle. Moreover, Γ_t is given for $t \in [0,T]$ as well as $a_1, \ldots, a_4, \mathbf{a}_1, \ldots, \mathbf{a}_6$ are given for some $T > 0, \sigma > 0$ is the surface tension constant and $D_s \mathbf{v} = \frac{1}{2} (\nabla \mathbf{v} + \nabla \mathbf{v}^T)$. Furthermore,

$$[g](p,t) := \lim_{h \searrow 0} \left[g^+(p + \mathbf{n}_{\Gamma_t}(p)h, t) - g^-(p - \mathbf{n}_{\Gamma_t}(p)h, t) \right] \text{ for } p \in \Gamma_t$$

for suitable functions g^{\pm} and $X_0: \Sigma \times [0,T] \to \Gamma := \bigcup_{t \in [0,T]} \Gamma_t \times \{t\}$ is a suitable diffeomorphism, which is described in Section 2 below. For $a: \Sigma \times [0,T] \to \mathbb{R}^N$, $N \in \mathbb{N}$, we define $X_0^{*,-1}a: \Gamma \to \mathbb{R}^N$ by

$$(X_0^{*,-1}a)(p,t) = a(X_0^{-1}(p,t))$$
 for all $(p,t) \in \Gamma$

and for $b \colon \Gamma \to \mathbb{R}^N$, $N \in \mathbb{N}$, we define $X_0^* b \colon \Sigma \times [0, T] \to \mathbb{R}^N$ by

$$(X_0^*b)(s,t) = b(X_0(s,t)) \quad \text{for all } (s,t) \in \Sigma \times [0,T].$$

This system arises in the construction of approximate solutions in the proof of convergence of a Stokes/Cahn-Hilliard system to its sharp interface limit, which is a Stokes/Mullins-Sekerka system, cf. [2]-[3]. Here $\mathbf{v}^{\pm} : \bigcup_{t \in [0,T]} \Omega^{\pm}(t) \times \{t\} \to \mathbb{R}^d$ and $p^{\pm} : \bigcup_{t \in [0,T]} \Omega^{\pm}(t) \times \{t\} \to \mathbb{R}$ are the velocity and pressure incompressible viscous Newtonian fluids filling the domains $\Omega^{\pm}(t)$ at time t, which are separated by the (fluid) interface Γ_t . Furthermore, $h: \Sigma \times [0,T] \to \mathbb{R}$ is a linearized height function that describes the evolution of the interface at a certain order and $\mu^{\pm} : \bigcup_{t \in [0,T]} \Omega^{\pm}(t) \times$ $\{t\} \to \mathbb{R}$ is a linearized chemical potential related to the fluids in $\Omega^{\pm}(t)$. If one neglects the terms related to $\mathbf{v}^{\pm}, p^{\pm}$, a similar linearized system arises in the study of the sharp interface limit of the Cahn-Hilliard equation, cf. [6]. Moreover, similar systems arise in the construction of strong solutions for a Navier-Stokes/Mullins-Sekerka system locally in time, cf. [4]. We consider different kinds of boundary conditions for \mathbf{v}^- and μ^- simultaneously. More precisely, we assume that

$$\partial \Omega = \Gamma_{\mu,1} \cup \Gamma_{\mu,2} = \Gamma_{S,1} \cup \Gamma_{S,2} \cup \Gamma_{S,3}$$

where $\Gamma_{\mu,1}, \Gamma_{\mu,2}$ and $\Gamma_{S,1}, \Gamma_{S,2}, \Gamma_{S,3}$ are disjoint and closed. Moreover, we have

$$B_{1}(\mathbf{v}^{-}, p^{-}) = \mathbf{v}^{-} \qquad \text{on } \Gamma_{S,1}$$
$$(B_{2}(\mathbf{v}^{-}, p^{-}))_{\tau} = \left(\left(2D_{s}\mathbf{v}^{-} - p^{-}\right)\mathbf{n}_{\partial\Omega}\right)_{\tau} + \alpha_{2}\mathbf{v}_{\tau}^{-} \qquad \text{on } \Gamma_{S,2}$$
$$\mathbf{n}_{\partial\Omega} \cdot B_{2}(\mathbf{v}^{-}, p^{-}) = \mathbf{n}_{\partial\Omega} \cdot \mathbf{v}^{-} \qquad \text{on } \Gamma_{S,2}$$
$$B_{3}(\mathbf{v}^{-}, p^{-}) = \left(2D_{s}\mathbf{v}^{-} - p^{-}\right)\mathbf{n}_{\partial\Omega} + \alpha_{3}\mathbf{v}^{-} \qquad \text{on } \Gamma_{S,3},$$

where $\mathbf{n}_{\partial\Omega}$ denotes the exterior normal on $\partial\Omega$. To avoid a non-trivial kernel in the following we assume that one of the following cases holds true:

$$|\Gamma_{S,1}| + \alpha_2 |\Gamma_{S,2}| + \alpha_3 |\Gamma_{S,3}| > 0$$

Then Korn's inequality yields

$$\|\mathbf{v}\|_{H^{1}(\Omega)} \leq C \left(\|D_{s}\mathbf{v}\|_{L^{2}(\Omega)} + \alpha_{2} \|\mathbf{v}_{\tau}\|_{L^{2}(\Gamma_{S,2})} + \alpha_{3} \|\mathbf{v}\|_{L^{2}(\Gamma_{S,3})} \right)$$
(10)

for all $\mathbf{v} \in H^1(\Omega)^d$ with $\mathbf{v}|_{\Gamma_{S,1}} = 0$, $\mathbf{n}_{\partial\Omega} \cdot \mathbf{v}|_{\Gamma_{S,2}} = 0$, cf. [5, Corollary 5.9].

The structure of this contribution is as follows: In Section 2 we summarize some preliminaries on the parametrization of the interface Γ_t and non-autonomuous evolution equations. In Section 3 we present and prove our main results on existence and smoothness of solutions to the linearized Mullins-Sekerka system. Finally, in the appendix we prove an auxilliary result on the existence of a pressure.

The results of this paper are extensions of results in the second author's PhD Thesis.

2 Preliminaries

2.1 Notation

Throughout this manuscript we denote by $\xi \in C^{\infty}(\mathbb{R})$ a cut-off function such that

 $\xi(s) = 1 \text{ if } |s| \le \delta, \ \xi(s) = 0 \text{ if } |s| > 2\delta, \text{ and } 0 \ge s\xi'(s) \ge -4 \text{ if } \delta \le |s| \le 2\delta.$ (11)

2.2 Coordinates

We parametrize $(\Gamma_t)_{t \in [0,T_0]}$ with the aid of a family of smooth diffeomorphisms $X_0: \Sigma \times [0,T_0] \to \Gamma = \bigcup_{t \in [0,T_0]} \Gamma_t \times \{t\}$. Here either $\Sigma \subseteq \mathbb{R}^d$ is a smooth (d-1)-dimensional compact, orientable manifold without boundary, where $d \geq 2$ is allowed, or d = 2 and

 $\Sigma = \mathbb{T}^1$. We have included the latter case to cover the setting in [1, 2, 3]. Moreover, $\mathbf{n}_{\Gamma_t}(x)$ denotes the exterior normal of Γ_t in x with respect to $\Omega^-(t)$ and we denote

$$\mathbf{n}(s,t) := \mathbf{n}_{\Gamma_t}((X_0(s,t))_1) \quad \text{for all } s \in \Sigma, t \in [0,T_0],$$

where $(X_0(s,t))_1 \in \mathbb{R}^d$ denote the spatial components of $X_0(s,t)$. In the following we will need a tubular neighborhood of Γ_t : For $\delta > 0$ sufficiently small, the orthogonal projection $P_{\Gamma_t}(x)$ of all

$$x \in \Gamma_t(3\delta) = \{y \in \Omega : \operatorname{dist}(y, \Gamma_t) < 3\delta\}$$

is well-defined and smooth. Moreover, we choose δ so small that $\operatorname{dist}(\partial\Omega, \Gamma_t) > 3\delta$ for every $t \in [0, T_0]$. Every $x \in \Gamma_t(3\delta)$ has a unique representation

$$x = P_{\Gamma_t}(x) + r\mathbf{n}_{\Gamma_t}(P_{\Gamma_t}(x))$$

where $r = \text{sdist}(\Gamma_t, x)$. Here

$$d_{\Gamma}(x,t) := \operatorname{sdist}(\Gamma_t, x) = \begin{cases} \operatorname{dist}(\Omega^-(t), x) & \text{if } x \notin \Omega^-(t), \\ -\operatorname{dist}(\Omega^+(t), x) & \text{if } x \in \Omega^-(t). \end{cases}$$

For the following we define for $\delta' \in (0, 3\delta]$

$$\Gamma(\delta') = \bigcup_{t \in [0,T_0]} \Gamma_t(\delta') \times \{t\}.$$

We introduce new coordinates in $\Gamma(3\delta)$ which we denote by

$$X \colon (-3\delta, 3\delta) \times \Sigma \times [0, T_0] \mapsto \Gamma(3\delta) \text{ by } X(r, s, t) := X_0(s, t) + r\mathbf{n}(s, t),$$

where

$$r = \text{sdist}(\Gamma_t, x), \qquad s = (X_0^{-1}(P_{\Gamma_t}(x), t))_1 =: S(x, t),$$

where $(X_0^{-1}(P_{\Gamma_t}(x), t))_1$ denote the components in Σ of $X_0^{-1}(P_{\Gamma_t}(x), t)$.

In the case that h is twice continuously differentiable with respect to s and continuously differentiable with respect to t, we introduce the notations

$$D_{t,\Gamma}h(s,t) := \partial_t \left(h(S(x,t),t) \right) |_{x=X_0(s,t)}, \quad \nabla_{\Gamma}h(s,t) := \nabla \left(h(S(x,t),t) \right) |_{x=X_0(s,t)},$$
$$\Delta_{\Gamma}h(s,t) := \Delta \left(h(S(x,t),t) \right) |_{x=X_0(s,t)},$$

where ∇ and Δ act with respect to x. We note that in the case that d = 2 and $\Sigma = \mathbb{T}^1$ we have

$$\begin{split} D_{t,\Gamma}h(s,t) &= \left(\partial_t + \partial_t S(X_0(s,t)) \cdot \partial_s\right) h(s,t),\\ \nabla_{\Gamma}h(s,t) &= \nabla S\left(X_0(s,t)\right) \partial_s h(s,t),\\ \Delta_{\Gamma}h(s,t) &= \Delta S\left(X_0(s,t)\right) \partial_s h(s,t) + |\nabla S\left(X_0(s,t)\right)|^2 \partial_s^2 h(s,t) \end{split}$$

as in [1, 2, 3].

2.3 Maximal Regularity for Non-autonomous Equations

In order to prove our main result we use of the theory of maximal regularity for non-autonomous abstract evolution equations. Therefore, we give a short overview of the basic definitions and results which we will use. These are taken from [7] and all the proofs of the statements can be found in that article.

In this subsection let X and D be two Banach spaces such that D is continuously and densely embedded in X.

Definition 2.1 (L^p -maximal regularity). Let $p \in (1, \infty)$.

1. Let $A \in \mathcal{L}(D, X)$. Then A has L^p -maximal regularity and we write $A \in \mathcal{MR}_p$ if for some bounded interval $(t_1, t_2) \subset \mathbb{R}$ and all $f \in L^p(t_1, t_2; X)$ there exists a unique $u \in W^{1,p}(t_1, t_2; X) \cap L^p(t_1, t_2; D)$ such that

$$\partial_t u + Au = f$$
 a.e. on (t_1, t_2) ,
 $u(t_1) = 0$.

2. Let T > 0 and $A : [0,T] \to \mathcal{L}(D,X)$ be a bounded and strongly measurable function. Then A has L^p -maximal regularity and we write $A \in \mathcal{MR}_p(0,T)$ if for all $f \in L^p(0,T;X)$ there exists a unique $u \in W^{1,p}(0,T;X) \cap L^p(0,T;D)$ such that

$$\partial_t u + A(t) u = f$$
 a.e. on $(0,T)$,
 $u(0) = 0.$

It can be shown that if $A \in \mathcal{MR}_p$ for some $p \in (1, \infty)$ then $A \in \mathcal{MR}_p$ for all $p \in (1, \infty)$. Hence, we often simply write $A \in \mathcal{MR}$.

Definition 2.2 (Relative Continuity).

We say that $A : [0,T] \to \mathcal{L}(D,X)$ is relatively continuous if for each $t \in [0,T]$ and all $\epsilon > 0$ there exist $\delta > 0$, $\eta \ge 0$ such that for all $x \in D$ and for all $s \in [0,T]$ with $|s-t| \le \delta$ the inequality

$$||A(t)x - A(s)x||_X \le \epsilon \, ||x||_D + \eta \, ||x||_X$$

holds.

Theorem 2.3. Let T > 0 and $A : [0,T] \to \mathcal{L}(D,X)$ be a strongly measurable and relatively continuous function. If $A(t) \in \mathcal{MR}$ for all $t \in [0,T]$, then $A \in \mathcal{MR}_p(0,t)$ for every $0 < t \leq T$ and every $p \in (1,\infty)$.

Proof. See [7, Theorem 2.7].

A very important tool for proving maximal regularity properties of differential operators are perturbation techniques. Employing these can often help to show maximal regularity for a variety of operators by separating them into a main part (for which maximal regularity can be readily shown) and a perturbation.

In the following we give a perturbation result which is key to many results in the next chapter.

Definition 2.4 (Relatively Close).

Let Y be a Banach space such that

$$D \hookrightarrow Y \hookrightarrow X.$$

We say Y is close to X compared with D, if for each $\epsilon > 0$ there exists $\eta \ge 0$ such that

$$\|x\|_{Y} \le \epsilon \|x\|_{D} + \eta \|x\|_{X} \quad \text{for all } x \in D.$$

Proposition 1. Let Y be as in Definition 2.4 and let the inclusion $D \hookrightarrow Y$ be compact. Then Y is close to X compared with D.

Proof. See [7, Example 2.9 (d)].

Theorem 2.5. Let T > 0 and Y be a Banach space that is close to X compared with D. Furthermore, let $A: [0,T] \to \mathcal{L}(D,X)$ be relatively continuous and $B: [0,T] \to \mathcal{L}(Y,X)$ be strongly measurable and bounded. If $A(t) \in \mathcal{MR}$ for every $t \in [0,T]$ then $A + B \in \mathcal{MR}_p(0,T)$.

Proof. See [7, Theorem 2.11].

3 Main Results

3.1 Parabolic Equations on Evolving Surfaces

We introduce the space

$$X_T = L^2(0,T; H^{\frac{7}{2}}(\Sigma)) \cap H^1(0,T; H^{\frac{1}{2}}(\Sigma))$$
(12)

for $T \in (0, \infty)$, where we equip X_T with the norm

$$\|h\|_{X_T} = \|h\|_{L^2\left(0,T; H^{\frac{7}{2}}(\Sigma)\right)} + \|h\|_{H^1\left(0,T; H^{\frac{1}{2}}(\Sigma)\right)} + \|h\|_{t=0}\|_{H^2(\Sigma)}.$$

Theorem 3.1. Let $T \in (0, T_0]$. Let $\mathbf{b} \colon \Sigma \times [0, T] \to \mathbb{R}^d$ and $b_1, b_2 \colon \Sigma \times [0, T] \to \mathbb{R}$ be smooth given functions. For every $g \in L^2(0, T; H^{\frac{1}{2}}(\Sigma))$ and $h_0 \in H^2(\Sigma)$, there is a unique solution $h \in X_T$ of

$$D_{t,\Gamma}h + \mathbf{b} \cdot \nabla_{\Gamma}h - b_1h + X_0^* ([\partial_{\mathbf{n}_{\Gamma_t}}\mu]) = g \qquad on \ \Sigma \times (0,T), \qquad (13)$$
$$h(.,0) = h_0 \qquad on \ \Sigma,$$

where $\mu|_{\Omega^{\pm}(t)} \in H^2(\Omega^{\pm}(t))$, for $t \in [0, T]$, is determined by

$$\Delta \mu^{\pm} = 0 \qquad \qquad in \ \Omega^{\pm}(t), \tag{14a}$$

$$\mu^{\pm} = X_0^{*,-1}(\sigma \Delta_{\Gamma} h \pm b_2 h) \qquad on \ \Gamma_t, \tag{14b}$$

$$\mathbf{n}_{\partial\Omega} \cdot \nabla \mu^{-} = 0 \qquad \qquad on \ \Gamma_{\mu,1}, \tag{14c}$$

$$\mu^- = 0 \qquad \qquad on \ \Gamma_{\mu,2}. \tag{14d}$$

Furthermore, the estimates

$$\sum_{\pm} \|\mu^{\pm}\|_{L^{2}(0,T;H^{2}(\Omega^{\pm}(t)))\cap L^{6}(0,T;H^{1}(\Omega^{\pm}(t)))} \leq C \|h\|_{X_{T}}, \qquad (15)$$

hold for some constant C > 0 independent of μ and h.

Proof. We may write (13) in abstract form as

$$\partial_t h + \mathcal{A}(t)h = g$$
 in $\Sigma \times [0, T],$
 $h(., 0) = h_0$ in $\Sigma,$

where $\mathcal{A}(t): H^{\frac{7}{2}}(\Sigma) \to H^{\frac{1}{2}}(\Sigma)$ depends on $t \in [0, T]$. Now we fix $t_0 \in [0, T]$ and analyze the operator $\mathcal{A}(t_0)$, where we replace t with the fixed t_0 in all time dependent coefficients.

In order to understand this operator we define

$$\begin{aligned} \mathfrak{D}_{t_0} &: H^{\frac{7}{2}}(\Sigma) \to H^{\frac{3}{2}}(\Gamma_{t_0}) : h \mapsto \left(X_0^{*,-1}(\sigma \Delta_{\Gamma} h) \right)(.,t_0), \\ S_{t_0}^N &: H^{\frac{3}{2}}(\Gamma_{t_0}) \to H^2(\Omega^+(t_0)) \times H^2(\Omega^-(t_0)) : f \mapsto (\Delta_N)^{-1} f, \\ B_{t_0} &: H^2(\Omega^+(t_0)) \times H^2(\Omega^-(t_0)) \to H^{\frac{1}{2}}(\Sigma) : (\mu^+,\mu^-) \mapsto \left(X_0^*([\nabla \mu \cdot \mathbf{n}_{\Gamma_{t_0}}]) \right)(.,t_0), \end{aligned}$$

where $(\Delta_N)^{-1}f$ is the unique solution (μ_N^+, μ_N^-) to

$$\Delta \mu_N^{\pm} = 0 \qquad \qquad \text{in } \Omega^{\pm}(t_0), \qquad (16a)$$

$$\mu_N^{\pm} = f \qquad \qquad \text{on } \Gamma_{t_0}, \tag{16b}$$

$$\nabla \mu_N^- \cdot \mathbf{n}_{\partial\Omega} = 0 \qquad \text{on } \partial\Omega. \qquad (16c)$$

In the literature the concatenation $B_{t_0} \circ S_{t_0}^N$ is often referred to as the *Dirichlet-to-Neumann* operator and $A_0(t_0) := B_{t_0} \circ S_{t_0}^N \circ \mathfrak{D}_{t_0}$ is called the *Mullins-Sekerka* operator. It can be shown that

$$A_0: [0,T] \to \mathcal{L}\left(H^{\frac{7}{2}}(\Sigma), H^{\frac{1}{2}}(\Sigma)\right)$$

has L^p -maximal regularity, i.e., $A_0 \in \mathcal{MR}_p(0,T)$. We will not prove this in detail but just give a short sketch describing the essential ideas: first, a reference surface $\tilde{\Sigma} \subset \subset \Omega$ is fixed such that Γ_t can be expressed as a graph over $\tilde{\Sigma}$ for t in some time interval $[\tilde{t}, \tilde{t} + \epsilon] \subset [0, T]$. e.g. one may choose $\tilde{\Sigma} := \Gamma_0$ and then determine $\epsilon_0 > 0$ such that Γ_t may be written as graph over Γ_0 for all $t \in [0, \epsilon_0]$, which is possible since Γ is a smoothly evolving hypersurface. Next, a Hanzawa transformation is applied, enabling us to consider (16c) as a system on fixed domains Ω^{\pm} and $\tilde{\Sigma}$, but with time dependent coefficients (see e.g. [4, Chapter 2.2] or and [12, Chapter 4]). Here, Ω^+ , Ω^- and $\tilde{\Sigma}$ denote disjoint sets such that $\partial \Omega^+ = \tilde{\Sigma}$ and $\Omega = \Omega^+ \cup \Omega^- \cup \tilde{\Sigma}$ holds and we assume in the following that $t_0 \in [0, \epsilon_0]$. To be more specific, the Hanzawa transformation results in a system of the form

$$\begin{aligned} a\left(x,t,\nabla_{x}\right)\bar{\mu}^{\pm} &= 0 & \text{in } \Omega^{\pm}, \\ \bar{\mu}^{\pm} &= \tilde{f} & \text{on } \tilde{\Sigma}, \\ \nabla\bar{\mu}^{-}\cdot\mathbf{n}_{\partial\Omega} &= 0 & \text{on } \partial\Omega, \end{aligned}$$

where *a* is the transformed Laplacian, depending smoothly on *t* and \tilde{f} is the transformation of *f*. Applying the Hanzawa transformation (and the diffeomorphism X_0) also to the operators \mathfrak{D}_{t_0} and B_{t_0} , we end up with a transformed operator $\tilde{A}_0(t_0) \in \mathcal{L}\left(H^{\frac{7}{2}}(\Sigma), H^{\frac{1}{2}}(\Sigma)\right)$ and [11, Corollary 6.6.5] implies that $\tilde{A}_0(t_0)$ has L^p maximal regularity. As all involved differential operators and coefficients depend smoothly on *t*, it is possible to show that $\tilde{A}_0: [0, \epsilon_0] \to \mathcal{L}\left(H^{\frac{7}{2}}(\Sigma), H^{\frac{1}{2}}(\Sigma)\right)$ is relatively continuous. Therefore Theorem 2.3 implies $\tilde{A}_0 \in \mathcal{MR}_p(0, \epsilon_0)$ and, transforming back, also $A_0 \in \mathcal{MR}_p(0, \epsilon_0)$. Repeating this procedure with a new reference surface $\Sigma := \Gamma_{\epsilon_0}$ and iteratively continuing the argumentation, we end up with $A_0 \in \mathcal{MR}_p(0, T)$.

We proceed by showing that $\mathcal{A}(t_0) = A_0(t_0) + \mathcal{B}(t_0)$ holds for some lower order perturbation \mathcal{B} . We introduce

$$S_{t_0}^{DN} \colon H^{\frac{3}{2}}(\Gamma_{t_0}) \to H^2(\Omega^+(t_0)) \times H^2(\Omega^-(t_0)) \colon f \mapsto (\Delta_{DN})^{-1}f,$$

where $(\mu_{DN}^+, \mu_{DN}^-) := (\Delta_{DN})^{-1} f$ is the unique solution to (16), replacing $\nabla \mu_N^- \cdot \mathbf{n}_{\partial\Omega} = 0$ on $\Gamma_{\mu,2}$ by $\mu_D^- = 0$ on $\Gamma_{\mu,2}$. Moreover, we write $S_{t_0}^{\Delta} := S_{t_0}^{DN} - S_{t_0}^N$ and observe that the equality

$$B_{t_0} \circ S_{t_0}^{DN} \circ \mathfrak{D}_{t_0} = A_0(t_0) + \mathcal{B}_0(t_0)$$
(17)

is satisfied, where $\mathcal{B}_0(t_0) := B_{t_0} \circ S_{t_0}^{\Delta} \circ \mathfrak{D}_{t_0}$. Let $f \in H^{\frac{3}{2}}(\Gamma_{t_0})$ be fixed, $(\mu_{DN}^+, \mu_{DN}^-) := S_{t_0}^{DN} f$, $(\mu_N^+, \mu_N^-) := S_{t_0}^N f$ and $\tilde{\mu}^{\pm} := \mu_{DN}^{\pm} - \mu_N^{\pm}$, implying $(\tilde{\mu}^+, \tilde{\mu}^-) = S_{t_0}^{\Delta} f$. Then $\tilde{\mu}^{\pm} \in H^2(\Omega^{\pm}(t_0))$ solves

$$\begin{split} \Delta \tilde{\mu}^{\pm} &= 0 & \text{in } \Omega^{\pm} \left(t_0 \right), \\ \tilde{\mu}^{\pm} &= 0 & \text{on } \Gamma_{t_0}, \\ \mathbf{n}_{\partial\Omega} \cdot \nabla \tilde{\mu}^- &= 0 & \text{on } \Gamma_{\mu,1} \\ \tilde{\mu}^- &= \mu_N^- & \text{on } \Gamma_{\mu,2} \end{split}$$

and elliptic regularity theory implies

$$\left\|\tilde{\mu}^{-}\right\|_{H^{2}(\Omega^{-}(t_{0}))} \leq C \left\|\mu_{N}^{-}\right\|_{H^{\frac{3}{2}}(\Gamma_{\mu,2})}$$
(18)

and $\tilde{\mu}^+ \equiv 0$ in $\Omega^+(t_0)$. For the further argumentation, we show

$$\left\|\mu_{N}^{-}\right\|_{H^{\frac{3}{2}}(\partial\Omega)} \le C \left\|\mu_{N}^{-}\right\|_{H^{\frac{1}{2}}(\Gamma_{t_{0}})}.$$
(19)

To this end let $\gamma(x) := \xi(4d_{\mathbf{B}}(x))$ for all $x \in \Omega$, where ξ is a cut-off function satisfying (11). In particular supp $\gamma \cap \Gamma_t = \emptyset$ for all $t \in [0, T_0]$ by our assumptions and $\gamma \equiv 1$ in $\partial \Omega(\frac{\delta}{4})$. Denoting $\hat{\mu} := \gamma \mu_N^- \in H^2(\Omega^-(t_0))$, we compute using $\Delta \mu_N^- = 0$ in $\Omega^-(t_0)$ that $\hat{\mu}$ is a solution to

$$\begin{aligned} \Delta \hat{\mu} &= 2\nabla \gamma \cdot \nabla \mu_N^- + (\Delta \gamma) \mu_N^- & \text{ in } \Omega^-(t_0), \\ \hat{\mu} &= 0 & \text{ on } \Gamma_{t_0}, \\ \nabla \hat{\mu} \cdot \mathbf{n}_{\partial \Omega} &= 0 & \text{ on } \partial \Omega, \end{aligned}$$

which, again regarding elliptic regularity theory, implies $\|\hat{\mu}\|_{H^2(\Omega^-(t_0))} \leq C \|\mu_N^-\|_{H^1(\Omega^-(t_0))}$. This is essential in view of (19) as it leads to

$$\begin{aligned} \|\mu_N^-\|_{H^{\frac{3}{2}}(\partial\Omega)} &= \|\hat{\mu}\|_{H^{\frac{3}{2}}(\partial\Omega)} \le C \|\hat{\mu}\|_{H^2(\Omega^-(t_0))} \\ &\le C \|\mu_N^-\|_{H^1(\Omega^-(t_0))} \le \tilde{C} \|\mu_N^-\|_{H^{\frac{1}{2}}(\Gamma_{t_0})}, \end{aligned}$$

where we used the continuity of the trace operator tr: $H^2(\Omega^-(t_0)) \to H^{\frac{3}{2}}(\partial\Omega^-(t_0))$ in the first inequality (cf. [10, Theorem 3.37]) and standard estimates for elliptic equations in the second and third inequality.

Let now $h \in H^{\frac{7}{2}}(\Sigma)$ and $(\tilde{\mu}^+, \tilde{\mu}^-) := S_{t_0}^{\Delta} \circ \mathfrak{D}_{t_0} h$. Our prior considerations enable us to estimate

$$\begin{aligned} \left\| B_{t_0} \circ S_{t_0}^{\Delta} \circ \mathfrak{D}_{t_0} h \right\|_{H^{\frac{1}{2}}(\Sigma)} &\leq C \left\| \tilde{\mu}^- \right\|_{H^2(\Omega^-(t_0))} \leq C \left\| \mu_N^- \right\|_{H^{\frac{3}{2}}(\partial\Omega)} \\ &\leq C \left\| \mu_N^- \right\|_{H^{\frac{1}{2}}(\Gamma_{t_0})} \leq C \left\| \sigma \Delta_{\Gamma} h \right\|_{H^{\frac{1}{2}}(\Sigma)} \leq C \left\| h \right\|_{H^{\frac{5}{2}}(\Sigma)}, \end{aligned}$$

where we employed the continuity of the trace in the first line, (18) in the second, (19) in the third and the definition of μ_N^- in the fourth. As $H^{\frac{7}{2}}(\Sigma)$ is dense in $H^{\frac{5}{2}}(\Sigma)$, we may extend $\mathcal{B}_0(t_0)$ to an operator

$$\mathcal{B}_0(t_0) \colon H^{\frac{5}{2}}(\Sigma) \to H^{\frac{1}{2}}(\Sigma), \tag{20}$$

which shows in regard to (17) that we may view $B_{t_0} \circ S_{t_0}^{\Delta} \circ \mathfrak{D}_{t_0}$ as a lower order perturbation of $A_0(t_0)$.

Next we take care of the term involving b_2 in (14b). For this we consider the operator

$$\mathcal{B}_1(t_0)\colon H^{\frac{7}{2}}(\Sigma)\to H^{\frac{1}{2}}(\Sigma)\colon h\mapsto X_0^*\big(\big[\partial_{\mathbf{n}_{\Gamma_{t_0}}}\mu_1\big]\big),$$

where $\mu_1^{\pm} \in H^2(\Omega^{\pm}(t_0))$ is the solution to

$$\mu_1^{-} = 0 \qquad \text{on } \Gamma_{\mu,2}.$$

We estimate

$$\begin{aligned} \|\mathcal{B}_{1}(t_{0})h\|_{H^{\frac{1}{2}}(\Sigma)} &\leq C \left\| \left[\partial_{\mathbf{n}_{\Gamma_{t_{0}}}} \mu_{1} \right] \right\|_{H^{\frac{1}{2}}(\Gamma_{t_{0}})} \\ &\leq C \left(\|\mu_{1}^{+}\|_{H^{2}(\Omega^{+}(t_{0}))} + \|\mu_{1}^{-}\|_{H^{2}(\Omega^{-}(t_{0}))} \right) \leq C \|h\|_{H^{\frac{3}{2}}(\Sigma)}, \end{aligned}$$
(21)

where C > 0 can be chosen independent of h and $t_0 \in [0, T]$. Here we again employed the continuity of the trace operator and elliptic theory.

Defining

$$\mathcal{B}(t_0) \colon H^{\frac{7}{2}}(\Sigma) \to H^{\frac{1}{2}}(\Sigma) \colon h \mapsto \mathcal{B}(t_0)h := \tilde{\mathbf{b}}(.,t_0) \cdot \nabla_{\Gamma} h - b_1(.,t_0)h + (\mathcal{B}_0(t_0) + \mathcal{B}_1(t_0))h,$$

where $\tilde{\mathbf{b}}$ is chosen such that $\partial_t h + \tilde{\mathbf{b}} \cdot \nabla_{\Gamma} h = D_{t,\Gamma} h + \mathbf{b} \cdot \nabla_{\Gamma} h$, and using (21) and (20), we find that

$$\|\mathcal{B}(t_0)h\|_{H^{\frac{1}{2}}(\Sigma)} \le C\|h\|_{H^{\frac{5}{2}}(\Sigma)}.$$

Thus, we can extend $\mathcal{B}(t_0)$ to a bounded operator $\mathcal{B}(t_0): H^{\frac{5}{2}}(\Sigma) \to H^{\frac{1}{2}}(\Sigma)$. Since $H^{\frac{5}{2}}(\Sigma)$ is close to $H^{\frac{1}{2}}(\Sigma)$ compared to $H^{\frac{7}{2}}(\Sigma)$ as the embedding $H^{\frac{7}{2}}(\Sigma) \hookrightarrow H^{\frac{5}{2}}(\Sigma)$ is compact, we get due to Theorem 2.5, that $\mathcal{A} = A_0 + \mathcal{B}$ has L^p -maximal regularity for all $t \in [0, T]$.

By elliptic theory

$$\left\|\mu^{\pm}\right\|_{H^{1}(\Omega^{\pm}(t))} \leq C \left\|X_{0}^{*,-1}\left(\sigma\Delta_{\Gamma}h + b_{2}h\right)\right\|_{H^{\frac{1}{2}}(\Gamma_{t})} \leq C \left\|h\right\|_{H^{\frac{5}{2}}(\Sigma)}$$

for almost all $t \in [0, T]$ and thus

$$\left\|\mu^{\pm}\right\|_{L^{6}(0,T;H^{1}(\Omega^{\pm}(t)))} \leq C \left\|h\right\|_{L^{6}\left(0,T;H^{\frac{5}{2}}(\Sigma)\right)} \leq C \left\|h\right\|_{X_{T}}.$$

Theorem 3.2. Let $T \in (0, T_0]$ and $t \in [0, T]$. For every $\mathbf{f} \in L^2(\Omega)^d$, $\mathbf{s} \in H^{\frac{3}{2}}(\Gamma_t)^d$, $\mathbf{a} \in H^{\frac{1}{2}}(\Gamma_{t})^{d} \text{ and } \mathbf{g} \colon \partial\Omega \to \mathbb{R}^{d} \text{ such that } \mathbf{g}|_{\Gamma_{S,1}} \in H^{\frac{3}{2}}(\Gamma_{S,1})^{d}, \ \mathbf{n}_{\partial\Omega} \cdot \mathbf{g}|_{\Gamma_{S,2}} \in H^{\frac{3}{2}}(\Gamma_{S,2}), \\ (I - \mathbf{n}_{\partial\Omega} \otimes \mathbf{n}_{\partial\Omega})\mathbf{g}|_{\Gamma_{S,2}} \in H^{\frac{1}{2}}(\Gamma_{S,2})^{d}, \ \mathbf{g}|_{\Gamma_{S,3}} \in H^{\frac{1}{2}}(\Gamma_{S,3})^{d} \text{ satisfying the compatibility}$ condition

has a unique solution $(\mathbf{v}^{\pm}, p^{\pm}) \in H^2(\Omega^{\pm}(t))^d \times H^1(\Omega^{\pm}(t))$ satisfying $\int_{\Omega} p \, dx = 0$ if $\Gamma_{S,3} = \emptyset$. Moreover, there is a constant C > 0 independent of $t \in [0, T_0]$ such that

$$\|(\mathbf{v},p)\|_{H^{2}(\Omega^{\pm}(t))\times H^{1}(\Omega^{\pm}(t))} \leq C\left(\|\mathbf{f}\|_{L^{2}(\Omega)} + \|\mathbf{s}\|_{H^{\frac{3}{2}}(\Gamma_{t})} + \|\mathbf{a}\|_{H^{\frac{1}{2}}(\Gamma_{t})} + \|\mathbf{g}_{1}\|_{H^{\frac{3}{2}}(\Gamma_{S,1})} + \|\mathbf{g}_{2,\mathbf{n}}\|_{H^{\frac{3}{2}}(\Gamma_{S,2})} + \|\mathbf{g}_{2,\tau}\|_{H^{\frac{1}{2}}(\Gamma_{S,2})} + \|\mathbf{g}_{3}\|_{H^{\frac{1}{2}}(\Gamma_{S,3})}\right)$$

Proof. We can assume for simplicity that $\mathbf{g} = 0$ on $\Gamma_{S,1}$ and $\mathbf{n}_{\partial\Omega} \cdot \mathbf{g} = 0$ on $\Gamma_{S,2}$. Otherwise we substract a suitable extension of \mathbf{g} . As a first step, we reduce the system (23)–(27) to the case $\mathbf{s} = 0$. Elliptic theory implies that the equation

has a unique solution $q \in H^3(\Omega^-(t))$ with $\int_{\Omega^-(t)} q \, dx = 0$ if $\Gamma_{S,3} = \emptyset$ since $\mathbf{s} \in H^{\frac{3}{2}}(\Gamma_t)^d$ and $\mathbf{n}_{\partial\Omega} \cdot \mathbf{g}_2 \in H^{\frac{3}{2}}(\Gamma_{S,1} \cup \Gamma_{S,2})$. Here, if $\Gamma_{S,3} = \emptyset$, the necessary compatibility condition is satisfied because of (22). Moreover, we have the estimate

$$||q||_{H^{3}(\Omega^{-}(t))} \leq C\left(||\mathbf{s}||_{H^{\frac{3}{2}}(\Gamma_{t})} + ||\mathbf{n}_{\partial\Omega} \cdot \mathbf{g}_{2}||_{H^{\frac{3}{2}}(\Gamma_{S,1} \cup \Gamma_{S,2})}\right).$$

Regarding the tangential part of \mathbf{s} , we may solve the stationary Stokes system

We may find a solution $(\mathbf{w}, \tilde{p}) \in H^2(\Omega^-(t))^d \times H^1(\Omega^-(t))$ (made unique by the normalization $\int_{\Omega^-(t)} \tilde{p} \, dx = 0$) and also get the estimate

$$\|\mathbf{w}\|_{H^{2}(\Omega^{-}(t))} + \|\tilde{p}\|_{H^{1}(\Omega^{-}(t))} \leq C\left(\|\mathbf{s}\|_{H^{\frac{3}{2}}(\Gamma_{t})} + \|\mathbf{n}_{\partial\Omega} \cdot \mathbf{g}_{2}\|_{H^{\frac{3}{2}}(\Gamma_{S,1} \cup \Gamma_{S,2})}\right).$$

Thus, defining $\tilde{\mathbf{w}} := \mathbf{w} + \nabla q$, the couple $(\tilde{\mathbf{w}}, \tilde{p})$ solves

$$\begin{aligned} -\Delta \tilde{\mathbf{w}} + \nabla \tilde{p} &= 0 & \text{in } \Omega^{-}(t), \\ \text{div } \tilde{\mathbf{w}} &= 0 & \text{in } \Omega^{-}(t), \\ \tilde{\mathbf{w}} &= \mathbf{s} & \text{on } \Gamma_t, \\ \tilde{\mathbf{w}} &= 0 & \text{on } \partial\Omega, \end{aligned}$$

and may be estimated by \mathbf{s} in strong norms. Next, let

$$\tilde{\mathbf{g}} := \mathbf{g}_j + B_j(\tilde{\mathbf{w}}, \tilde{p})$$
 on $\Gamma_{S,j}, j = 1, 2, 3$

and $\tilde{\mathbf{a}} := \mathbf{a} - (2D_s \tilde{\mathbf{w}} - \tilde{p}\mathbf{I}) \mathbf{n}_{\Gamma_t} \in H^{\frac{1}{2}}(\Gamma_t)^d$, where the regularity is due to the properties of the trace operator. Then, for every strong solution $(\hat{\mathbf{v}}^{\pm}, \hat{p}^{\pm})$ of (23)-(27), with $\mathbf{s} \equiv 0$ and \mathbf{g}, \mathbf{a} substituted by $\tilde{\mathbf{g}}, \tilde{\mathbf{a}}$, the functions

$$(\mathbf{v}^+, p^+) := (\hat{\mathbf{v}}^+, \hat{p}^+) \text{ and } (\mathbf{v}^-, p^-) := (\hat{\mathbf{v}}^- - \tilde{\mathbf{w}}, \hat{p}^- - \tilde{p})$$

are solutions to the original system (23)-(27). So, we will consider $s \equiv 0$ in the following and show existence of strong solutions in that case.

As a starting point, we construct a solution $(\mathbf{v}, p) \in V(\Omega) \times L^2(\Omega)$ to the weak formulation

$$= \int_{\Omega} \mathbf{f} \cdot \boldsymbol{\psi} \, dx + \int_{\Gamma_{t}} \mathbf{a} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) - \int_{\partial\Omega} \mathbf{g} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s), \tag{29}$$

for all $\boldsymbol{\psi} \in H^1(\Omega)^d$ with $\boldsymbol{\psi}|_{\Gamma_{S,1}} = 0$, $\mathbf{n} \cdot \boldsymbol{\psi}|_{\Gamma_{S,2}} = 0$, where

$$V(\Omega) = \{ \mathbf{u} \in H^1(\Omega)^d : \operatorname{div} \mathbf{u} = 0, \mathbf{u}|_{\Gamma_{S,1}} = 0, \mathbf{n} \cdot \mathbf{u}|_{\Gamma_{S,2}} = 0 \}.$$

Considering first $\psi \in V(\Omega)$ and the right hand side as a functional $\mathbf{F} \in (V(\Omega))'$, the Lemma of Lax-Milgram implies the existence of a unique $\mathbf{v} \in V(\Omega)$ solving (29) for all $\psi \in V(\Omega)$, where the coercivity of the involved bilinear form is a consequence of (10).

Next consider the functional

$$F(\boldsymbol{\psi}) := -\int_{\Omega} 2D_{s}\mathbf{v} : D_{s}\boldsymbol{\psi} \, dx - \int_{\Gamma_{S,2}} \alpha_{2}\mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) - \int_{\Gamma_{S,3}} \alpha_{3}\mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) + \int_{\Omega} \mathbf{f} \cdot \boldsymbol{\psi} \, dx + \int_{\Gamma_{t}} \mathbf{a} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) - \int_{\partial\Omega} \mathbf{g} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s),$$

for all $\boldsymbol{\psi} \in H^1(\Omega)^d$ with $\boldsymbol{\psi}|_{\Gamma_{S,1}} = 0$, $\mathbf{n} \cdot \boldsymbol{\psi}|_{\Gamma_{S,2}} = 0$. Then F vanishes on $V(\Omega)$ and by Lemma A.1 in Appendix A there is a unique $p \in L^2(\Omega)$ with $\int_{\Omega} p \, dx = 0$ if $\Gamma_{S,3} = \emptyset$ such that

$$F(\boldsymbol{\psi}) = -\int_{\Omega} p \operatorname{div} \boldsymbol{\psi} \, dx \quad \text{for all} \ \boldsymbol{\psi} \in H^1(\Omega)^d \text{ with } \boldsymbol{\psi}|_{\Gamma_{S,1}} = 0, \mathbf{n} \cdot \boldsymbol{\psi}|_{\Gamma_{S,2}} = 0.$$

Hence (\mathbf{v}, p) solve (29). Moreover, we obtain the estimate

$$\|(\mathbf{v},p)\|_{H^{1}(\Omega)\times L^{2}(\Omega)} \leq C\left(\|\mathbf{f}\|_{L^{2}(\Omega)} + \|\mathbf{a}\|_{H^{\frac{1}{2}}(\Gamma_{t})} + \|\mathbf{g}\|_{H^{\frac{1}{2}}(\partial\Omega)}\right).$$
 (30)

We now show higher regularity of (\mathbf{v}, p) by localization.

Let $\eta^{\pm} \in C^{\infty}(\overline{\Omega})$ be a partition of unity of Ω , such that the inclusions $\Omega^{+}(t) \cup \Gamma_{t}(\delta) \subset \{x \in \Omega | \eta^{+}(x) = 1\}$ and $\partial \Omega(\delta) \subset \{x \in \Omega | \eta^{-}(x) = 1\}$ hold. We choose η^{\pm} such that $\{x \in \Omega : \eta^{\pm}(x) = 1\}$ has smooth boundary and define $U^{\pm} := \operatorname{supp}(\eta^{\pm}), \partial U_{0}^{-} := \partial U^{-} \setminus \partial \Omega$ and

$$\dot{U} := \left\{ x \in \Omega | \eta^+(x) \in (0,1) \right\} = \left\{ x \in \Omega | \eta^-(x) \in (0,1) \right\}.$$

Moreover, we set $\dot{p}^- := p\eta^-$ and $\tilde{\mathbf{v}}^- := \mathbf{v}\eta^-$ in Ω and we correct the divergence of $\tilde{\mathbf{v}}^-$ with the help of the Bogovskii-operator: Let $\varphi \in C_c^{\infty}(\Omega)$ with $\operatorname{supp}(\varphi) \subset U^+ \setminus \dot{U}$ and $\int_{\Omega} \varphi \, dx = 1$ and set

$$\hat{g} := \operatorname{div}\left(\tilde{\mathbf{v}}^{-}\right) - \varphi \int_{U^{+}} \operatorname{div}\left(\tilde{\mathbf{v}}^{-}\right) \, dx$$

in U^+ . As $\mathbf{v} \in V(\Omega)$, we have div $(\tilde{\mathbf{v}}^-) = \mathbf{v} \cdot \nabla \eta^-$ and thus $\hat{g} \in H_0^1(U^+)$, $\int_{U^+} \hat{g} \, dx = 0$. Consequently, [9, Theorem III.3.3] implies that there is $\hat{\mathbf{v}}^- \in H_0^2(U^+)$, which we extend onto Ω by 0, satisfying

$$\operatorname{div} \hat{\mathbf{v}}^{-} = \hat{g} \text{ in } U^{+},$$
$$\left\| \hat{\mathbf{v}}^{-} \right\|_{H^{2}(\Omega)} \leq C \left\| \mathbf{v} \right\|_{H^{1}(\Omega)}.$$
(31)

Therefore, $\dot{\mathbf{v}}^- := \tilde{\mathbf{v}}^- - \hat{\mathbf{v}}^-$ fulfills div $\dot{\mathbf{v}}^- = 0$ in U^- since $\varphi \equiv 0$ in that domain. Let now

$$\boldsymbol{\psi} \in \left\{ \mathbf{w} \in H^1(U^-)^d : \mathbf{w} = 0 \text{ on } \partial U_0^-, \mathbf{w}|_{\Gamma_{S,1}} = 0, \mathbf{n} \cdot \mathbf{w}|_{\Gamma_{S,2}} = 0 \right\},\$$

then

$$\begin{split} \int_{U^{-}} 2D_{s} \dot{\mathbf{v}}^{-} &: D_{s} \boldsymbol{\psi} - \dot{p}^{-} \operatorname{div} \boldsymbol{\psi} \, dx + \int_{\Gamma_{S,2}} \alpha_{2} \mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) + \int_{\Gamma_{S,3}} \alpha_{3} \mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) \\ &= \int_{U^{-}} 2D_{s} \tilde{\mathbf{v}}^{-} : D_{s} \boldsymbol{\psi} - p \operatorname{div} \left(\boldsymbol{\psi} \eta^{-} \right) + \left(p \nabla \eta^{-} \right) \cdot \boldsymbol{\psi} \, dx + \int_{\Gamma_{S,2}} \alpha_{2} \mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) \\ &+ \int_{\Gamma_{S,3}} \alpha_{3} \mathbf{v} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) - \int_{U^{-}} 2D_{s} \hat{\mathbf{v}}^{-} : D_{s} \boldsymbol{\psi} \, dx \\ &= \int_{U^{-}} \mathbf{f} \cdot \boldsymbol{\psi} \eta^{-} \, dx - \int_{\partial \Omega} \mathbf{g} \cdot \boldsymbol{\psi} \, d\mathcal{H}^{d-1}(s) + \left(p \nabla \eta^{-} \right) \cdot \boldsymbol{\psi} \, dx \\ &+ \int_{U^{-}} 2 \operatorname{div} \left(D_{s} \hat{\mathbf{v}} \right) \cdot \boldsymbol{\psi} + \left(2D_{s} \mathbf{v} \nabla \eta^{-} - \operatorname{div} \left(\mathbf{v} \otimes \nabla \eta^{-} + \nabla \eta^{-} \otimes \mathbf{v} \right) \right) \cdot \boldsymbol{\psi} \, dx, \end{split}$$

where we used the definition of $\dot{\mathbf{v}}^-$ and \dot{p}^- in the first equality and integration by parts together with $\hat{\mathbf{v}}^- \in H_0^2(U^+)$ and $\nabla \eta^- = 0$ on U^- in the second equality. Additionally, we employed the fact that (\mathbf{v}, p) is the weak solution to (29). Hence, $(\dot{\mathbf{v}}^-,\dot{p}^-)$ are a weak solution to the system

$$-\Delta \dot{\mathbf{v}}^{-} + \nabla \dot{p}^{-} = \tilde{\mathbf{f}} \qquad \text{in } U^{-},$$

$$\operatorname{div} \dot{\mathbf{v}}^{-} = 0 \qquad \text{in } U^{-},$$

$$\dot{\mathbf{v}}^{-} = \hat{\mathbf{v}}^{-} \qquad \text{on } \partial U_{0}^{-},$$

$$B_{j}(\mathbf{v}^{-}, \dot{p}^{-}) = \mathbf{g} \qquad \text{on } \Gamma_{S,j}, j = 1, 2, 3, \qquad (32)$$

where

$$\tilde{\mathbf{f}} := \mathbf{f}\eta^- + p\nabla\eta^- + 2\operatorname{div}(D_s\hat{\mathbf{v}}) + 2D_s\mathbf{v}\nabla\eta^- - \operatorname{div}\left(\mathbf{v}\otimes\nabla\eta^- + \nabla\eta^-\otimes\mathbf{v}\right) \in L^2(U^-)$$

and $\hat{\mathbf{v}}^- \in H^{\frac{3}{2}}(\partial U_0^-)$ by the properties of the trace operator. Writing

$$\tilde{\mathbf{g}} := \begin{cases} \mathbf{g} & \text{on } \Gamma_{S,1}, \\ \alpha_j \dot{\mathbf{v}}^- + \mathbf{g} & \text{on } \Gamma_{S,j}, j = 2, 3, \end{cases}$$

using localization techniques and results for strong solutions of the stationary Stokes equation in one phase with inhomogeneous do-nothing boundary condition (cf. Theorem 3.1 in [14]), with Dirichlet boundary condition (cf. [9]) and slip-boundary conditions (cf. Solonnikov and Ščadilov [15, Theorem 2]), we find that $(\dot{\mathbf{v}}^-, \dot{p}^-) \in$ $H^2(U^-) \times H^1(U^-)$. Moreover, regarding (31), (30) and the definition of $\tilde{\mathbf{f}}$, we get

$$\left\| \left(\dot{\mathbf{v}}^{-}, \dot{p}^{-} \right) \right\|_{H^{2}(U^{-}) \times H^{1}(U^{-})} \leq C \left(\left\| \mathbf{f} \right\|_{L^{2}(\Omega)} + \left\| \mathbf{a} \right\|_{H^{\frac{1}{2}}(\Gamma_{t})} + \left\| \mathbf{g} \right\|_{H^{\frac{1}{2}}(\partial\Omega)} \right)$$

Analogously, we define $\tilde{\mathbf{v}}^+ := \mathbf{v}\eta^+$ and $\hat{\mathbf{v}}^+ \in H^2_0(\dot{U})$ as a solution to div $\hat{\mathbf{v}}^+ = \operatorname{div} \tilde{\mathbf{v}}^+$. Here, we do not need to correct the mean value, since

$$\int_{\dot{U}} \operatorname{div} \tilde{\mathbf{v}}^+ dx = \int_{\partial \dot{U}} \mathbf{v} \cdot \mathbf{n}_{\partial \dot{U}} \eta^+ d\mathcal{H}^{d-1}(s) = -\int_{\{\eta^+=1\}} \operatorname{div} \mathbf{v} \, dx = 0.$$

We set $\dot{\mathbf{v}}^+ := \tilde{\mathbf{v}}^+ - \hat{\mathbf{v}}^+$ and $\dot{p}^+ := p\eta^+$ and get after similar calculations as before that $(\dot{\mathbf{v}}^+, \dot{p}^+)$ is a weak solution to the two phase stationary Stokes system

$$-\Delta \dot{\mathbf{v}}^{+} + \nabla \dot{p}^{+} = \mathbf{\hat{f}} \qquad \text{in } U^{+}, \qquad (33)$$

$$\operatorname{div} \dot{\mathbf{v}}^+ = 0 \qquad \qquad \operatorname{in} U^+, \qquad (34)$$

$$\dot{\mathbf{v}}^+ = 0 \qquad \qquad \text{on } \partial U^+, \qquad (35)$$

$$\left[\dot{\mathbf{v}}^{+}\right] = 0 \qquad \qquad \text{on } \Gamma_t, \tag{36}$$

$$\left[2D_s \dot{\mathbf{v}}^+ - \dot{p}^+ \mathbf{I}\right] \mathbf{n}_{\Gamma_t} = \mathbf{a} \qquad \text{on } \Gamma_t, \qquad (37)$$

where $\hat{\mathbf{f}} \in L^2(U^+)$. Then [13, Theorem 1.1] implies $\dot{\mathbf{v}}^+|_{\Omega^+(t)} \in H^2(\Omega^+(t))$ and $\dot{\mathbf{v}}^+|_{U^+\setminus\Omega^+(t)} \in H^2(U^+\setminus\Omega^+(t))$, and also that the pressure satisfies $\dot{p}^+|_{\Omega^+(t)} \in H^1(\Omega^+(t))$ and $\dot{p}^+|_{U^+\setminus\Omega^+(t)} \in H^1(U^+\setminus\Omega^+(t))$ with estimates in the associated norms. In particular, $\mathbf{v} = \dot{\mathbf{v}}^+$ in $\Omega^+(t)$ and $\mathbf{v} = \dot{\mathbf{v}}^+ + \dot{\mathbf{v}}^- + \hat{\mathbf{v}}^+ + \hat{\mathbf{v}}^-$ in $\Omega^-(t)$, yielding the desired regularity and (28). To show that C > 0 may be chosen independently of $t \in [0, T_0]$, one may make use of extension arguments, see e.g. the proof of [1, Lemma 2.10]. \Box

Theorem 3.3. Let $T \in (0, T_0]$. Let $\mathbf{b} \colon \Sigma \times [0, T] \to \mathbb{R}^d$, $b \colon \Sigma \times [0, T] \to \mathbb{R}$, $a_1 \colon \Omega \times [0, T] \to \mathbb{R}$, $a_2, a_3, a_5 \colon \Gamma \to \mathbb{R}$, $a_4 \colon \partial\Omega \times [0, T] \to \mathbb{R}$, $\mathbf{a}_1 \colon \Omega \times [0, T] \to \mathbb{R}^d$, $\mathbf{a}_2, \mathbf{a}_3, \mathbf{a}_4, \mathbf{a}_5 \colon \Gamma \to \mathbb{R}^d$ and $\mathbf{a}_6 \colon \partial\Omega \times [0, T] \to \mathbb{R}^d$ be smooth given functions such that

$$\int_{\Gamma_t} \mathbf{n}_{\Gamma_t} \cdot \mathbf{a}_2 \, d\mathcal{H}^{d-1} + \int_{\partial \Omega} \mathbf{n}_{\partial \Omega} \cdot \mathbf{a}_6 \, d\mathcal{H}^{d-1} = 0 \qquad \text{if } \Gamma_{S,3} = \emptyset.$$

For every $g \in L^2(0,T; H^{\frac{1}{2}}(\Sigma))$ and $h_0 \in H^2(\Sigma)$ there exists a unique solution $h \in X_T$ of

$$D_{t,\Gamma}h + \mathbf{b} \cdot \nabla_{\Gamma}h - bh + \frac{1}{2}X_0^* \left((\mathbf{v}^+ + \mathbf{v}^-) \cdot \mathbf{n}_{\Gamma_t} \right) + \frac{1}{2}X_0^* \left(\left[\partial_{\mathbf{n}_{\Gamma_t}} \mu \right] \right) = g \quad in \ \Sigma \times (0,T) ,$$
$$h (.,0) = h_0 \quad in \ \Sigma,$$

where for every $t \in [0,T]$, the functions $\mathbf{v}^{\pm} = \mathbf{v}^{\pm}(x,t)$, $p^{\pm} = p^{\pm}(x,t)$ and $\mu^{\pm} = \mu^{\pm}(x,t)$ for $(x,t) \in \Omega_T^{\pm}$ with $\mathbf{v}^{\pm} \in H^2(\Omega^{\pm}(t))$, $p^{\pm} \in H^1(\Omega^{\pm}(t))$ and $\mu^{\pm} \in H^2(\Omega^{\pm}(t))$ are the unique solutions to

$$\Delta \mu^{\pm} = a_1 \qquad \qquad in \ \Omega^{\pm}(t), \tag{38}$$

$$\mu^{\pm} = X_0^{*,-1} \left(\sigma \Delta_{\Gamma} h \pm a_2 h \right) + a_3 \qquad on \ \Gamma_t, \tag{39}$$

$$\mathbf{n}_{\partial\Omega} \cdot \nabla \mu^{-} = a_4 \qquad \qquad on \ \Gamma_{\mu,1}, \tag{40}$$

$$\mu^{-} = a_4 \qquad \qquad on \ \Gamma_{\mu,2}, \qquad (41)$$
$$-\Delta \mathbf{v}^{\pm} + \nabla p^{\pm} = \mathbf{a}_1 \qquad \qquad in \ \Omega^{\pm}(t), \qquad (42)$$

$$[\mathbf{v}] = \mathbf{a}_2 \qquad on \ \Gamma_t, \qquad (44)$$

$$\begin{bmatrix} 2D_s \mathbf{v} - p\mathbf{I} \end{bmatrix} \mathbf{n}_{\Gamma_t} = X_0^{*,-1} \left(\mathbf{a}_3 h + \mathbf{a}_4 \Delta_{\Gamma} h + a_5 \nabla_{\Gamma} h + \mathbf{a}_5 \right) \quad on \ \Gamma_t, \tag{45}$$
$$B_j (\mathbf{v}^-, p^-) = \mathbf{a}_6 \qquad on \ \Gamma_{S,j}, j = 1, 2, 3. \tag{46}$$

Moreover, if g, h_0 and b, \mathbf{b} , a_i , and \mathbf{a}_j are smooth on their respective domains for $i \in \{1, \ldots, 5\}$, $j \in \{1, \ldots, 6\}$, then h is smooth and p^{\pm} , \mathbf{v}^{\pm} and μ^{\pm} are smooth on $\Omega^{\pm}(t)$.

Proof. We show this by a perturbation argument. First of all note that we may without loss of generality assume that a_1 , a_3 , a_4 , \mathbf{a}_1 , \mathbf{a}_2 , \mathbf{a}_5 , $\mathbf{a}_6 = 0$ on their respective domains. The above system may be reduced to this case by solving

$$\Delta \hat{\mu}^{\pm} = a_1 \qquad \text{in } \Omega^{\pm}(t),$$
$$\hat{\mu}^{\pm} = a_3 \qquad \text{on } \Gamma_t,$$

$$\hat{\mu}^- = a_4 \qquad \text{on } \Gamma_{\mu,2}$$

with the help of standard elliptic theory and

$$\begin{aligned} -\Delta \hat{\mathbf{v}}^{\pm} + \nabla \hat{p}^{\pm} &= \mathbf{a}_{1} & \text{in } \Omega^{\pm}(t), \\ \text{div } \hat{\mathbf{v}}^{\pm} &= 0 & \text{in } \Omega^{\pm}(t), \\ [\hat{\mathbf{v}}] &= \mathbf{a}_{2} & \text{on } \Gamma_{t}, \\ [2D_{s}\hat{\mathbf{v}} - p] \mathbf{n} &= \mathbf{a}_{5} & \text{on } \Gamma_{t}, \\ B_{j}(\hat{\mathbf{v}}^{-}, \hat{p}^{-}) &= \mathbf{a}_{6} & \text{on } \Gamma_{s,j}, j = 1, 2, 3, \end{aligned}$$

with the help of Theorem 3.2 and setting

$$\hat{g} = g - \frac{1}{2} X_0^* \left([\partial_{\mathbf{n}_{\Gamma_t}} \hat{\mu}] + (\hat{\mathbf{v}}^+ + \hat{\mathbf{v}}^-) \cdot \mathbf{n}_{\Gamma_t} \right).$$

Now let $t \in [0,T]$, $h \in H^{\frac{7}{2}}(\Sigma)$ and let $\mathbf{v}_h^{\pm} \in H^2(\Omega^{\pm}(t))^d$, $p_h^{\pm} \in H^1(\Omega^{\pm}(t))$ be the solution to (42)–(46). Multiplying (42) by \mathbf{v}_h^{\pm} and integrating in $\Omega^{\pm}(t)$ together with integration by parts and the consideration of the boundary values (45) and (46) allows us to deduce

$$\int_{\Omega^{+}(t)} 2|D_{s}\mathbf{v}_{h}^{+}|^{2} dx + \int_{\Omega^{-}(t)} 2|D_{s}\mathbf{v}_{h}^{-}|^{2} dx + \sum_{j=2,3} \int_{\Gamma_{S,j}} \alpha_{j}|\mathbf{v}_{h}^{-}|^{2} d\mathcal{H}^{d-1}(s)$$
$$= \int_{\Gamma_{t}} X_{0}^{*,-1} \left(\mathbf{a}_{3}h + \mathbf{a}_{4}\Delta_{\Gamma}h + a_{5}\nabla_{\Gamma}h\right) \cdot \mathbf{v}_{h}^{-} d\mathcal{H}^{d-1}(s).$$
(47)

Hence, by [5, Corollary 5.8] and the continuity of the trace we find

$$\|\mathbf{v}_{h}^{-}\|_{H^{1}(\Omega^{-}(t))} \le C \|h\|_{H^{2}(\Sigma)}$$
(48)

for C independent of h and t. [5, Corollary 5.8], also implies

$$\int_{\Omega^+(t)} 2|D_s \mathbf{v}_h^+|^2 \, dx + \int_{\Gamma_t} |\mathbf{v}_h^+|^2 \, d\mathcal{H}^{d-1}(s) \ge C \|\mathbf{v}_h^+\|_{H^1(\Omega^+(t))}^2,$$

leading to

$$\|\mathbf{v}_{h}^{+}\|_{H^{1}(\Omega^{-}(t))} \le C \|h\|_{H^{2}(\Sigma)}$$
(49)

due to $\mathbf{v}_h^+ = \mathbf{v}_h^-$ on Γ_t , (48) and (47). Defining

$$\mathcal{B}(t)\colon H^{\frac{7}{2}}(\Sigma)\to H^{\frac{1}{2}}(\Sigma)\colon h\mapsto \mathcal{B}(t)h=\frac{1}{2}X_0^*\big((\mathbf{v}_h^++\mathbf{v}_h^-)\cdot\mathbf{n}_{\Gamma_t}\big),$$

we may use (48) and (49) to confirm

$$\|\mathcal{B}(t)h\|_{H^{\frac{1}{2}}(\Sigma)} \le C\|h\|_{H^{2}(\Sigma)}$$

for C > 0 independent of h and t. As $H^{\frac{7}{2}}(\Sigma)$ is dense in $H^{2}(\Sigma)$ we can extend $\mathcal{B}(t)$ to an operator $\mathcal{B}(t) : H^{2}(\Sigma) \to H^{\frac{1}{2}}(\Sigma)$ and $H^{2}(\Sigma)$ is close to $H^{\frac{1}{2}}(\Sigma)$ compared with $H^{\frac{7}{2}}(\Sigma)$.

The existence of a unique solution $h \in X_T$ with the properties stated in the theorem is now a consequence of Theorem 2.5. Higher regularity may be shown by localization and e.g. the usage of difference quotients.

Then there is a unique $p \in L^2(\Omega)$ with $\int_{\Omega} p \, dx = 0$ if $\Gamma_{S,3} = \emptyset$ such that

$$F(\boldsymbol{\psi}) = -\int_{\Omega} p \operatorname{div} \boldsymbol{\psi} \, dx \qquad \text{for all } \boldsymbol{\psi} \in H^1(\Omega)^d \text{ with } \boldsymbol{\psi}|_{\Gamma_{S,1}} = 0, \mathbf{n}_{\partial\Omega} \cdot \boldsymbol{\psi}|_{\Gamma_{S,2}} = 0.$$

Proof. We will apply the closed range theorem. To this end let

$$X = \{ \boldsymbol{\psi} \in H^1(\Omega)^d : \boldsymbol{\psi}|_{\Gamma_{S,1}} = 0, \mathbf{n}_{\partial\Omega} \cdot \boldsymbol{\psi}|_{\Gamma_{S,2}} = 0 \},$$
$$Y = \left\{ g \in L^2(\Omega) : \int_{\Omega} g(x) \, dx = 0 \text{ if } \Gamma_{S,3} = \emptyset \right\}$$

and consider

$$T: X \to Y: \psi \mapsto -\operatorname{div} \psi.$$

Then T is onto, which can be seen as follows: Let $g \in Y$.

If $\Gamma_{S,3} \neq \emptyset$, then there is a unique solution $q \in H^1(\Omega)$ of

$$\begin{aligned} \Delta q &= g & \text{in } \Omega, \\ q|_{\Gamma_{S,3}} &= 0 & \text{on } \Gamma_{S,3}, \\ \mathbf{n}_{\partial\Omega} \cdot \nabla q|_{\Gamma_{S,1} \cup \Gamma_{S,2}} &= 0 & \text{on } \Gamma_{S,1} \cup \Gamma_{S,2}. \end{aligned}$$

Moreover, using the solvability of the stationary Stokes equation with non-homogenoues Dirichlet boundary conditions, we find some $\mathbf{w} \in H^1(\Omega)^d$ with div $\mathbf{w} = 0$ and

$$\mathbf{w}|_{\Gamma_{S,1}} = \nabla q|_{\Gamma_{S,1} \cup \Gamma_{S,2}}, \qquad \mathbf{w}|_{\Gamma_{S,3}} = 0.$$

Then $\boldsymbol{\psi} = \mathbf{w} - \nabla q \in X$ with $-\operatorname{div} \boldsymbol{\psi} = g$.

If $\Gamma_{S,3} = \emptyset$, we have $\int_{\Omega} g(x) dx = 0$ and can use the well-known Bogovskii operator to obtain some $\psi \in H_0^1(\Omega)$ with $-\operatorname{div} \psi = g$.

Now the closed range theorem implies that $T' \colon Y' \to X'$ is injective and

$$\mathcal{R}(T') = \mathcal{N}(T)^{\circ} = \{ F \in X' : F(\psi) = 0 \text{ for all } \psi \in V(\Omega) \}.$$

This proves the statement of the lemma.
