# AN EXAMPLE IN THE VANISHING DISCOUNT PROBLEM FOR MONOTONE SYSTEMS OF HAMILTON-JACOBI EQUATIONS

#### Abstract

In recent years, there have been many contributions to the vanishing discount problem for Hamilton-Jacobi equations. In the case of the scalar equation, B. Ziliotto [Convergence of the solutions of the discounted Hamilton-Jacobi equation: a counterexample. J. Math. Pures Appl. (9) 128 (2019), 330-338] has given an example of the Hamilton-Jacobi equation having non-convex Hamiltonian in the gradient variable, for which the full convergence of the solutions does not hold as the discount factor tends to zero. We give an example of the nonlinear monotone system of Hamilton-Jacobi equations having convex Hamiltonians in the gradient variable, for which the whole family convergence of the solutions does not hold.

## 1. Introduction

We consider the system of Hamilton-Jacobi equations

$$
\begin{cases}\lambda u_{1}(x)+H_{1}\left(D u_{1}(x)\right)+B_{1}\left(u_{1}(x), u_{2}(x)\right)=0 & \text { in } \mathbb{T}^{n},  \tag{1}\\ \lambda u_{2}(x)+H_{2}\left(D u_{2}(x)\right)+B_{2}\left(u_{1}(x), u_{2}(x)\right)=0 & \text { in } \mathbb{T}^{n},\end{cases}
$$

where $\lambda>0$ is a given constant, called the discount factor, and the functions $H_{i}: \mathbb{R}^{n} \rightarrow \mathbb{R}$ and $B_{i}: \mathbb{R}^{2} \rightarrow R$, with $i=1,2$, are given continuous functions.

In a recent paper [5, the authors have investigated the vanishing discount problem for a nonlinear monotone system of Hamilton-Jacobi equations

$$
\left\{\begin{array}{cc}
\lambda u_{1}(x)+G_{1}\left(x, D u_{1}(x), u_{1}(x), u_{2}(x), \ldots, u_{m}(x)\right)=0 & \text { in } \mathbb{T}^{n}  \tag{2}\\
\vdots \\
\lambda u_{m}(x)+G_{m}\left(x, D u_{m}(x), u_{1}(x), u_{2}(x), \ldots, u_{m}(x)\right)=0 & \text { in } \mathbb{T}^{n}
\end{array}\right.
$$

and established under some hypotheses on $G_{i} \in C\left(\mathbb{T}^{n} \times \mathbb{R}^{n} \times \mathbb{R}^{m}\right)$ that, when $u^{\lambda}=\left(u_{1}^{\lambda}, \ldots, u_{m}^{\lambda}\right) \in$ $C\left(\mathbb{T}^{n}\right)^{m}$ denoting the (viscosity) solution of (2), the whole family $\left(u^{\lambda}\right)_{\lambda>0}$ converges in $C\left(\mathbb{T}^{n}\right)^{m}$ to some $u^{0} \in C\left(\mathbb{T}^{n}\right)^{m}$ as $\lambda \rightarrow 0+$. The constant $\lambda>0$ in the above system is the so-called discount factor.

The hypotheses on $G_{i}$ are the convexity, coercivity, and monotonicity of $G_{i}$ as well as the solvability of (22), with $\lambda=0$. Here the convexity of $G_{i}$ is meant that the functions $\mathbb{R}^{n} \times \mathbb{R}^{m} \ni$ $(p, u) \mapsto G_{i}(x, p, u)$ are convex. We refer to [5] for the precise statements of the hypotheses.

Before [5], there have been many contributions to the question about the full convergence in the vanishing discount problem, which we refer to [1, 3-8] and the references therein.

In the case of the scalar equation, B. Ziliotto [9] has recently shown an example of the Hamilton-Jacobi equation having non-convex Hamiltonian in the gradient variable for which the whole family convergence does not hold.

Our purpose in this paper is that, by adapting the idea of Ziliotto [9] to the system (2), we give an example of $B_{i}$ such that, if $H_{1}(0)=H_{2}(0)=0$, then the solutions of the system (2), with $\lambda>0$, are bounded but do not converge to a single point as $\lambda \rightarrow 0+$.

Motivated by 9], we fix $d>1$, set

\gamma=\frac{d}{1+d}
$$

choose $K \in \mathbb{N}$ so that

$$
\gamma+4^{-K}<1
$$

and write

$$
\mathbb{I}=\{1,2\}, \quad \mathbb{N}_{K}=\{k \in \mathbb{N}: k \geq K\}, \quad \mathcal{A}=\left\{\gamma+4^{-k}: k \in \mathbb{N}_{K}\right\} \cup\{\gamma\}, \quad \mathcal{B}=\{0,1\}
$$

and set for $\alpha, \beta \in \mathbb{R}$,

$$
\begin{aligned}
C(\alpha, \beta) & =\left(c_{i j}(\alpha, \beta)\right)_{i, j \in \mathbb{I}} \\
& :=\left(\begin{array}{cc}
\alpha+\beta-2 \alpha \beta & -(\alpha+\beta-2 \alpha \beta) \\
-(\alpha+\beta-2 \alpha \beta) & \alpha+\beta-2 \alpha \beta
\end{array}\right)
\end{aligned}
$$

Moreover, we define $L_{i}: \mathbb{R}^{2} \rightarrow \mathbb{R}$, with $i \in \mathbb{I}$, by

$$
L_{1}(\alpha, \beta)=\alpha \beta+d^{2}(1-\alpha)(1-\beta), \quad L_{2}(\alpha, \beta)=-\alpha \beta-d^{2}(1-\alpha)(1-\beta) .
$$

Note that $\mathcal{A} \subset(0,1)$ and $\mathcal{A}, \mathcal{B}$ are compact subsets of $\mathbb{R}$ and that for all $(\alpha, \beta) \in \mathbb{R} \times \mathbb{R}$,

$$
\left\{\begin{array}{l}
c_{11}(\alpha, \beta)+c_{12}(\alpha, \beta)=c_{21}(\alpha, \beta)+c_{22}(\alpha, \beta)=0  \tag{3}\\
c_{11}(\alpha, \beta)=c_{22}(\alpha, \beta)>0 \quad \text { if }(\alpha, \beta) \in(0,1) \times[0,1]
\end{array}\right.
$$

Let $\lambda \in(0,1)$. Consider the problem of finding $u=\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$ such that

$$
\left\{\begin{array}{l}
\lambda u_{1}+B_{1}\left(u_{1}, u_{2}\right)=0  \tag{4}\\
\lambda u_{2}+B_{2}\left(u_{1}, u_{2}\right)=0
\end{array}\right.
$$

where $B_{i}: \mathbb{R}^{2} \rightarrow \mathbb{R}$, with $i \in \mathbb{I}$, are the continuous functions given by

$$
\begin{equation*}
B_{i}\left(u_{1}, u_{2}\right)=\max _{\alpha \in \mathcal{A}} \min _{\beta \in \mathcal{B}}\left(c_{i 1}(\alpha, \beta) u_{1}+c_{i 2}(\alpha, \beta) u_{2}-L_{i}(\alpha, \beta)\right) \tag{5}
\end{equation*}
$$

For later convenience, we set for $(i, \alpha, \beta) \in \mathbb{I} \times[0,1] \times[0,1]$ and $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$,

$$
b_{i}\left(\alpha, \beta, u_{1}, u_{2}\right)=c_{i 1}(\alpha, \beta) u_{1}+c_{i 2}(\alpha, \beta) u_{2}-L_{i}(\alpha, \beta)
$$

It is clear that the functions $b_{i}$ are continuous on $[0,1] \times[0,1] \times \mathbb{R} \times \mathbb{R}$.
Although our main concern is the system (4), for the argument below we need to treat a more general form of (4), that is, the system

$$
\left\{\begin{array}{l}
\lambda u_{1}+A_{1}\left(u_{1}, u_{2}\right)=g_{1}  \tag{6}\\
\lambda u_{2}+A_{2}\left(u_{1}, u_{2}\right)=g_{2}
\end{array}\right.
$$

where $\left(g_{1}, g_{2}\right) \in \mathbb{R}^{2}$ is a given vector, $A_{i}$, with $i \in \mathbb{I}$, are defined by

$$
A_{i}\left(u_{1}, u_{2}\right)=\max _{\alpha \in \mathcal{A}_{i}} \min _{\beta \in \mathcal{B}_{i}} b_{i}\left(\alpha, \beta, u_{1}, u_{2}\right)
$$

and $\mathcal{A}_{i}, \mathcal{B}_{i}$, with $i \in \mathbb{I}$, are given compact subsets of $[0,1]$, If we take $g_{i}=0, \mathcal{A}_{i}=\mathcal{A}$, and $\mathcal{B}_{i}=\mathcal{B}$ for all $i \in \mathbb{I}$, (6) is exactly the system (4).

We note that the mapping $A:\left(u_{1}, u_{2}\right) \mapsto\left(A_{1}\left(u_{1}, u_{2}\right), A_{2}\left(u_{1}, u_{2}\right)\right)$ is monotone in the sense that for any $\left(u_{1}, u_{2}\right),\left(v_{1}, v_{2}\right) \in \mathbb{R}^{2}$, if $u_{j}-v_{j} \geq u_{k}-v_{k}$, where $j \neq k$, then $A_{j}\left(u_{1}, u_{2}\right) \geq A_{j}\left(v_{1}, v_{2}\right)$. Indeed, assuming, for instance, that $u_{1}-v_{1} \geq u_{2}-v_{2}$, we observe that for any $\alpha \in \mathcal{A}_{1}$ and some $\bar{\beta}(\alpha) \in \mathcal{B}_{1}$,

$$
A_{1}\left(u_{1}, u_{2}\right) \geq \min _{\beta \in \mathcal{B}} b_{1}\left(\alpha, \beta, u_{1}, u_{2}\right)=b_{1}\left(\alpha, \bar{\beta}(\alpha), u_{1}, u_{2}\right)
$$

while for some $\bar{\alpha} \in \mathcal{A}_{1}$,

$$
A_{1}\left(v_{1}, v_{2}\right)=\min _{\beta \in \mathcal{B}} b_{1}\left(\bar{\alpha}, \beta, v_{1}, v_{2}\right) \leq b_{1}\left(\bar{\alpha}, \bar{\beta}(\bar{\alpha}), v_{1}, v_{2}\right)
$$

Combining the above two, using (3), and writing $\bar{\beta}=\bar{\beta}(\bar{\alpha})$, we deduce that

$$
\begin{aligned}
A_{1}\left(u_{1}, u_{2}\right)-A_{1}\left(v_{1}, v_{2}\right) & \geq b_{1}\left(\bar{\alpha}, \bar{\beta}, u_{1}, u_{2}\right)-b_{1}\left(\bar{\alpha}, \bar{\beta}, v_{1}, v_{2}\right) \\
& =c_{11}(\bar{\alpha}, \bar{\beta})\left(u_{1}-v_{1}\right)+c_{12}(\bar{\alpha}, \bar{\beta})\left(u_{2}-v_{2}\right) \\
& \geq c_{11}(\bar{\alpha}, \bar{\beta})\left(u_{1}-v_{1}\right)+c_{12}(\bar{\alpha}, \bar{\beta})\left(u_{1}-v_{1}\right)=0 .
\end{aligned}
$$

This shows that $A$ is monotone.
With the fact that $A$ is monotone, the following proposition is well-known.
Proposition 1. There exists a unique solution $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$ of (6). Moreover, if $\left(v_{1}, v_{2}\right) \in \mathbb{R}^{2}$ satisfies

$$
\begin{equation*}
\lambda v_{1}+A_{1}\left(v_{1}, v_{2}\right) \leq g_{1} \quad \text { and } \quad \lambda v_{2}+A_{2}\left(v_{1}, v_{2}\right) \leq g_{2} \tag{7}
\end{equation*}
$$

(resp.,

$$
\begin{equation*}
\left.\lambda v_{1}+A_{1}\left(v_{1}, v_{2}\right) \geq g_{1} \quad \text { and } \quad \lambda v_{2}+A_{2}\left(v_{1}, v_{2}\right) \geq g_{2}\right) \tag{8}
\end{equation*}
$$

then $v_{1} \leq u_{1}$ and $v_{2} \leq u_{2}$ (resp., $u_{1} \leq v_{1}$ and $u_{2} \leq v_{2}$ ).
For completeness, we provide below proof of the above proposition.
Proof. We first show the second claim in Proposition [1, that is, the comparison claim. Let $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$ be a solution of (6) and let $\left(v_{1}, v_{2}\right) \in \mathbb{R}^{2}$ satisfy either (7) or (8).

We treat only the case of (7); the proof of the other case is similar. We argue by contradiction, and hence suppose that either $v_{1}>u_{1}$ or $v_{2}>u_{2}$. Assume, for instance, that $v_{1}-u_{1} \geq v_{2}-u_{2}$. By the monotonicity of $A$, we have $A_{1}\left(v_{1}, v_{2}\right) \geq A_{1}\left(u_{1}, u_{2}\right)$. Hence, by (6) and (7), we deduce that

$$
0 \geq \lambda\left(v_{1}-u_{1}\right)+A_{1}\left(v_{1}, v_{2}\right)-A_{1}\left(u_{1}, u_{2}\right) \geq \lambda\left(v_{1}-u_{1}\right)
$$

which contradicts that $v_{1}>u_{1}$. Thus, we have $v_{1} \leq u_{1}$ and $v_{2} \leq u_{2}$. The uniqueness of the solution of (6) is now evident.

Next, we show that there exists a solution of (6). We choose a constant $R>0$ such that $\max _{i \in \mathbb{I}}\left(\left\|L_{i}\right\|_{\infty}+\left|g_{i}\right|\right) \leq \lambda R$, where $\|\cdot\|_{\infty}$ denotes the sup-norm, and deduce with the help of (3) that $\left(v_{1}, v_{2}\right)=-(R, R)$ (resp., $\left.\left(v_{1}, v_{2}\right)=(R, R)\right)$ satisfies (7) (resp., (8)). It is easily seen that
$A: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ is Lipschitz continuous. Let $M \geq 0$ be a Lipschitz constant of $A$, and consider the problem of finding $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$ that satisfies

$$
\begin{equation*}
(\lambda+M) u_{1}+A_{1}\left(u_{1}, u_{2}\right)=f_{1} \quad \text { and } \quad(\lambda+M) u_{2}+A_{2}\left(u_{1}, u_{2}\right)=f_{2} \tag{9}
\end{equation*}
$$

where $\left(f_{1}, f_{2}\right) \in \mathbb{R}^{2}$ is a fixed vector. By the Banach fixed-point theorem, (19) has a unique solution.

We define inductively a sequence of points $\left(u_{1}^{(j)}, u_{2}^{(j)}\right) \in \mathbb{R}^{2}$, with $j \in \mathbb{N}$, by setting $\left(u_{1}^{(1)}, u_{2}^{(1)}\right)=$ $-(R, R)$ and, when $\left(u_{1}^{(j-1)}, u_{2}^{(j-1)}\right)$ is given, solving (9) for $\left(u_{1}, u_{2}\right)$, with

$$
\left(f_{1}, f_{2}\right)=\left(g_{1}, g_{2}\right)+M\left(u_{1}^{(j-1)}, u_{2}^{(j-1)}\right)
$$

to set $\left(u_{1}^{(j)}, u_{2}^{(j)}\right):=\left(u_{1}, u_{2}\right)$.
Note that $\left(v_{1}, v_{2}\right)=(R, R)$ (resp., $\left.\left(v_{1}, v_{2}\right)=-(R, R)\right)$ satisfies

$$
(\lambda+M) v_{1}+A_{1}\left(v_{1}, v_{2}\right) \geq g_{1}+M R \quad \text { and } \quad(\lambda+M) v_{2}+A_{2}\left(v_{1}, v_{2}\right) \geq g_{2}+M R
$$

( resp., $\quad(\lambda+M) v_{1}+A_{1}\left(v_{1}, v_{2}\right) \leq g_{1}-M R \quad$ and $\left.\quad(\lambda+M) v_{2}+A_{2}\left(v_{1}, v_{2}\right) \leq g_{2}-M R.\right)$
Applying the comparison assertion of Proposition [1 with $\lambda$ and $g_{i}$ replaced respectively by $\lambda+M$ and $g_{i}+M u_{i}^{(1)}$, we obtain $-R \leq u_{1}^{(2)} \leq R$ and $-R \leq u_{2}^{(2)} \leq R$. It is easily seen by induction that $-R \leq u_{1}^{(j)} \leq R$ and $-R \leq u_{2}^{(j)} \leq R$ for all $j \in \mathbb{N}$.

Moreover, if we assume that $u_{1}^{(j+1)} \geq u_{1}^{(j)}$ and $u_{2}^{(j+1)} \geq u_{2}^{(j)}$ for some $j \in \mathbb{N}$, then

$$
\begin{aligned}
& (\lambda+M) u_{1}^{(j+2)}+A_{1}\left(u_{1}^{(j+2)}, u_{2}^{(j+2)}\right)=g_{1}+M u_{1}^{(j+1)} \geq g_{1}+M u_{1}^{(j)}, \\
& (\lambda+M) u_{2}^{(J+2)}+A_{2}\left(u_{1}^{(j+2)}, u_{2}^{(j+2)}\right)=g_{2}+M u_{2}^{(j+1)} \geq g_{2}+M u_{2}^{(j)}
\end{aligned}
$$

and, by the comparison argument as above, we deduce that $u_{1}^{(j+2)} \geq u_{1}^{(j+1)}$ and $u_{2}^{(j+2)} \geq u_{2}^{(j+1)}$. By induction, we conclude that $u_{1}^{j+1} \geq u_{1}^{(j)}$ and $u_{2}^{(j+1)} \geq u_{2}^{(j)}$ for all $j \in \mathbb{N}$.

We now know that the sequences $\left(u_{1}^{(j)}\right)_{j \in \mathbb{N}}$ and $\left(u_{2}^{(j)}\right)_{j \in \mathbb{N}}$ are convergent. Let $u_{1}$ and $u_{2}$ denote the respective limits, and we note that

$$
(\lambda+M) u_{1}+A_{1}\left(u_{1}, u_{2}\right)=M u_{1} \quad \text { and } \quad(\lambda+M) u_{2}+A_{2}\left(u_{1}, u_{2}\right)=M u_{2}
$$

to conclude that $\left(u_{1}, u_{2}\right)$ is a solution of (6).
We note that if $\left(X_{\lambda}, Y_{\lambda}\right) \in \mathbb{R}^{2}$ is the unique solution of (4) and if $H_{1}(0)=H_{2}(0)=0$, the pair of constant functions $u_{1}(x)=X_{\lambda}$ and $u_{2}(x)=Y_{\lambda}$ is a solution of (11). As is well-known (see, for instance, [5] and the references therein), (1) has a unique (viscosity) solution, and hence, the pair $\left(X_{\lambda}, Y_{\lambda}\right)$ is the unique solution of (11).

The main result of this paper is the following two theorems.

Theorem 2. For any $\lambda>0$, let $\left(X_{\lambda}, Y_{\lambda}\right) \in \mathbb{R}^{2}$ be the solution of (41). Then (i) the set of points $\left(X_{\lambda}, Y_{\lambda}\right)$, with $\lambda>0$, is bounded in $\mathbb{R}^{2}$. (ii) We have

$$
\liminf _{\lambda \rightarrow 0+} X_{\lambda} \leq \frac{d}{2}<\limsup _{\lambda \rightarrow 0+} X_{\lambda}, \quad \text { and } \quad \liminf _{\lambda \rightarrow 0+} Y_{\lambda} \leq-\frac{d}{2}<\limsup _{\lambda \rightarrow 0+} Y_{\lambda}
$$

In particular, the family of the pairs $\left(X_{\lambda}, Y_{\lambda}\right)$ does not converge as $\lambda \rightarrow 0+$.

As noted before the theorem, the following is an immediate consequence of Theorem 2,

Theorem 3. Assume that $H_{1}(0)=H_{2}(0)=0$. For any $\lambda>0$, let $\left(u_{\lambda, 1}, u_{\lambda, 2}\right)$ be the (viscosity) solution of (1). Then, the functions $u_{\lambda, i}$ are constants, the family of the points $\left(u_{\lambda, 1}, u_{\lambda, 2}\right)$ in $\mathbb{R}^{2}$ is bounded, and it does not converge as $\lambda \rightarrow 0+$.

Notice that the convexity of $H_{i}$ in the above theorem is irrelevant, and, for example, one may take $H_{i}(p)=|p|^{2}$ for $i \in \mathbb{I}$, which are convex functions.

We remark that a claim similar to Theorem 3 is valid when one replaces $H_{i}(p)$ by degenerate elliptic operators $F_{i}(p, M)$ (see [2] for an overview on the viscosity solution approach to fully nonlinear degenerate elliptic equations), where $M$ is the variable corresponding to the Hessian matrices of unknown functions.

In the next and final section, we give the proof of Theorem 2,

## 2. Proof of Theorem 2

This section is entirely devoted to the proof of Theorem 2,
For any $\lambda>0$, let $\left(X_{\lambda}, Y_{\lambda}\right)$ denote the solution of (4).
Proof of Theorem 2, (i). We show first that $(d / 2,-d / 2)$ is a solution of

$$
B_{1}\left(u_{1}, u_{2}\right)=0 \quad \text { and } \quad B_{2}\left(u_{1}, u_{2}\right)=0
$$

To see this, we observe that for any $\alpha \in \mathcal{A}$,

$$
\begin{aligned}
& b_{1}(\alpha, 0, d / 2,-d / 2)=\left(d+d^{2}\right)(\alpha-\gamma) \\
& b_{1}(\alpha, 1, d / 2,-d / 2)=-(1+d)(\alpha-\gamma) \\
& b_{2}(\alpha, 0, d / 2,-d / 2)=-\left(d+d^{2}\right)(\alpha-\gamma) \\
& b_{2}(\alpha, 1, d / 2,-d / 2)=(1+d)(\alpha-\gamma)
\end{aligned}
$$

and hence, we get

$$
B_{1}(d / 2,-d / 2)=0 \quad \text { and } \quad B_{2}(d / 2,-d / 2)=0
$$

By (3), we see that $B_{i}\left(u_{1}+r, u_{2}+r\right)=B_{i}\left(u_{1}, u_{2}\right)$ for all $i \in \mathbb{I},\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$ and $r \in \mathbb{R}$. Hence, we have

$$
B_{i}(d, 0)=B_{i}(0,-d)=0 \quad \text { for } i \in \mathbb{I},
$$

which shows that for any $\lambda>0$, if $\left(v_{1}, v_{2}\right)=(d, 0)$ (resp., $\left(v_{1}, v_{2}\right)=(0,-d)$ ) satisfies

$$
\lambda v_{i}+B_{i}\left(v_{1}, v_{2}\right) \geq 0 \quad\left(\text { resp. }, \quad \lambda v_{i}+B_{i}\left(v_{1}, . v_{2}\right) \leq 0\right) \quad \text { for all } i \in \mathbb{I} .
$$

By the comparison assertion of Proposition 1, we deduce that

$$
0 \leq X_{\lambda} \leq d \quad \text { and } \quad-d \leq Y_{\lambda} \leq 0 \quad \text { for all } \lambda>0
$$

which proves that the set of $\left(X_{\lambda}, Y_{\lambda}\right)$, with $\lambda>0$, is bounded in $\mathbb{R}^{2}$.
Lemma 4. We have

$$
\lim _{\lambda \rightarrow 0+}\left(X_{\lambda}-Y_{\lambda}\right)=d
$$

Proof. Set $Z_{\lambda}=X_{\lambda}-Y_{\lambda}$ and

$$
B(u)=\max _{\alpha \in \mathcal{A}} \min _{\beta \in \mathcal{B}}\left(c_{11}(\alpha, \beta) u-L_{1}(\alpha, \beta)\right)-\max _{\alpha \in \mathcal{A}} \min _{\beta \in \mathcal{B}}\left(-c_{22}(\alpha, \beta) u-L_{2}(\alpha, \beta)\right) .
$$

Noting that for any $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$,

we find that $B_{1}\left(u_{1}, u_{2}\right)-B_{2}\left(u_{1}, u_{2}\right)=B\left(u_{1}-u_{2}\right)$ for all $\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}$, and

Thanks to the claim (i) of Theorem 2, the family $\left(Z_{\lambda}\right)_{\lambda>0}$ has a limit point $Z_{0} \in \mathbb{R}$ as $\lambda \rightarrow 0+$. It follows from (10) and the continuity of $B$ that

\mu_{n} \widehat{Y}_{n}+b_{2}\left(\hat{\alpha}_{n, 2}, \hat{\beta}_{n, 2}, \widehat{X}_{n}, \widehat{Y}_{n}\right)=0
\end{array}\right.
$$

Accordingly, we have

$$
\widehat{X}_{n}=X\left(\mu_{n}, \hat{\alpha}_{n, 1}, \hat{\alpha}_{n, 2}, \hat{\beta}_{n, 1}, \hat{\beta}_{n, 2}\right) \quad \text { and } \quad \widehat{Y}_{n}=X\left(\mu_{n}, \hat{\alpha}_{n, 1}, \hat{\alpha}_{n, 2}, \hat{\beta}_{n, 1}, \hat{\beta}_{n, 2}\right)
$$

Note that $q\left(\mu_{n} / 2\right), q\left(2 \mu_{n}\right) \in \mathcal{A}$ and that if $t \in\left(q\left(\mu_{n} / 2\right), q\left(2 \mu_{n}\right)\right.$, then $t \notin \mathcal{A}$. The monotonicity of $X$ (see (141)) shows that for any $\alpha_{1}, \alpha_{2} \in \mathcal{A}$, if $\alpha_{1} \geq q\left(\mu_{n}\right)$ and $\alpha_{2} \geq q\left(\mu_{n}\right)$, then

$$
X\left(\mu_{n}, \alpha_{1}, \alpha_{2}, 1,0\right) \geq X\left(\mu_{n}, q\left(2 \mu_{n}\right), q\left(2 \mu_{n}\right), 1,0\right) \geq x_{n}
$$

if $\alpha_{1}>q\left(\mu_{n}\right)$ and $\alpha_{2} \leq q\left(\mu_{n}\right)$, then

$$
X\left(\mu_{n}, \alpha_{1}, \alpha_{2}, 1,1\right) \geq X\left(\mu_{n}, q\left(2 \mu_{n}\right), q\left(\mu_{n} / 2\right), 1,1\right) \geq x_{n}
$$

if $\alpha_{1} \leq q\left(\mu_{n}\right)$ and $\alpha_{2} \geq q\left(\mu_{n}\right)$, then

$$
X\left(\mu_{n}, \alpha_{1}, \alpha_{2}, 0,0\right) \geq X\left(\mu_{n}, q\left(\mu_{n} / 2\right), q\left(2 \mu_{n}\right), 0,0\right) \geq x_{n}
$$

and, if $\alpha_{1} \leq q\left(\mu_{n} / 2\right)$ and $\alpha_{2} \leq q\left(\mu_{n} / 2\right)$, then

$$
X\left(\mu_{n}, \alpha_{1}, \alpha_{2}, 0,1\right) \geq X\left(\lambda, q\left(\mu_{n} / 2\right), q\left(\mu_{n} / 2\right), 0,1\right) \geq x_{n}
$$

Hence, we deduce that

$$
\widehat{X}_{n}=X\left(\mu_{n}, \hat{\alpha}_{n, 1}, \hat{\alpha}_{n, 2}, \hat{\beta}_{n, 1}, \hat{\beta}_{n, 2}\right) \geq x_{n}
$$

From these, we conclude that

$$
\liminf _{n \rightarrow \infty} \widehat{X}_{n} \geq \liminf _{n \rightarrow \infty} x_{n}>\frac{d}{2}
$$

which ensures that

$$
\limsup _{\lambda \rightarrow 0+} X_{\lambda}>\frac{d}{2}
$$

The proof is now complete.
Proposition 5. We have

$$
\liminf _{\lambda \rightarrow 0+} X_{\lambda}=\frac{d}{2} \quad \text { and } \quad \liminf _{\lambda \rightarrow 0+} Y_{\lambda}=-\frac{d}{2}
$$

Proof. As in the proof of (13), we set

$$
\theta=\frac{4(d+1)}{d-1}, \quad \text { and } \quad p(\rho)=\gamma+\rho \quad \text { for } \rho>0
$$

Let $X\left(\alpha_{1}, \alpha_{2}, \beta_{1}, \beta_{2}\right)$ be the function as in the proof of Theorem 2, (ii) for $\alpha_{1}, \alpha_{2} \in(0,1)$ and $\beta_{1}, \beta_{2} \in \mathcal{B}$. Noting that $p(\rho)=\gamma+\rho \in(0,1)$ and that

$$
\begin{aligned}
d^{2}\left(p(\rho)^{2}-2 p(\rho)+1\right)-p(\rho)^{2} & =d^{2}\left(2(\gamma-1) \rho+\rho^{2}\right)-2 \gamma \rho-\rho^{2} \\
& =-2 d \rho+\rho^{2}\left(d^{2}-1\right),
\end{aligned}
$$

we compute that

$$
\begin{aligned}
\lim _{\rho \rightarrow 0+} X(\theta \rho, p(\rho), p(\rho), 0,0) & =-\lim _{\rho \rightarrow 0+} \frac{d^{2} \theta \rho(p(\rho)-1)}{\theta \rho(2 p(\rho)+\theta \rho)}=-\frac{d^{2}(\gamma-1)}{2 \gamma}=\frac{d}{2} \\
\lim _{\rho \rightarrow 0+} X(\theta \rho, p(\rho), p(\rho), 0,1) & =\lim _{\rho \rightarrow 0+} \frac{-p(\rho)^{2}+d^{2}\left((1-p(\rho)) \theta \rho+p(\rho)^{2}-2 p(\rho)+1\right)}{\theta \rho} \\
& =d^{2}(1-\gamma)-\frac{2 d}{\theta}=\frac{d}{2}, \\
\lim _{\rho \rightarrow 0+} X(\theta \rho, p(\rho), p(\rho), 1,0) & =\lim _{\rho \rightarrow 0+} \frac{p(\rho) \theta \rho+p(\rho)^{2}-d^{2}\left(p(\rho)^{2}-2 p(\rho)+1\right)}{\theta \rho} \\
& =\gamma-\lim _{\rho \rightarrow 0+} \frac{d^{2}\left(p(\rho)^{2}-2 p(\rho)+1\right)-p(\rho)^{2}}{\theta \rho}
\end{aligned}
$$

$$
\begin{aligned}
& =\gamma+2 \theta^{-1} d=\frac{d}{2} \\
\lim _{\rho \rightarrow 0+} X(\theta \rho, p(\rho), p(\rho), 1,1) & =\lim _{\rho \rightarrow 0+} \frac{p(\rho) \theta \rho}{\theta \rho(-2 p(\rho)+\theta \rho+2)}=\frac{\gamma}{2(1-\gamma)}=\frac{d}{2} .
\end{aligned}
$$

Thus, setting

$$
\begin{aligned}
& x(\rho)=\min \{ X(\theta \rho, p(\rho), p(\rho), 1,0), X(\theta \rho, p(\lambda), p(\lambda), 1,1) \\
&X(\theta \rho, p(\rho), p(\rho), 0,0), X(\theta \rho, p(\rho), p(\rho), 0,1)\}
\end{aligned}
$$

we have

$$
\lim _{\rho \rightarrow 0+} x(\rho)=\frac{d}{2} .
$$

For any $\lambda>0$, we select $\alpha_{\lambda, 1}, \alpha_{\lambda, 2} \in \mathcal{A}$ and $\beta_{\lambda, 1}, \beta_{\lambda, 2} \in \mathcal{B}$ so that

$$
\left\{\begin{array}{l}
\lambda X_{\lambda}+b_{1}\left(\alpha_{\lambda, 1}, \beta_{\lambda, 1}, X_{\lambda}, Y_{\lambda}\right)=0 \\
\lambda Y_{\lambda}+b_{2}\left(\alpha_{\lambda, 2}, \beta_{\lambda, 2}, X_{\lambda}, Y_{\lambda}\right)=0
\end{array}\right.
$$

Accordingly, we have

$$
X_{\lambda}=X\left(\lambda, \alpha_{\lambda, 1}, \alpha_{\lambda, 2}, \beta_{\lambda, 1}, \beta_{\lambda, 2}\right) \quad \text { and } \quad Y_{\lambda}=X\left(\lambda, \alpha_{\lambda, 1}, \alpha_{\lambda, 2}, \beta_{\lambda, 1}, \beta_{\lambda, 2}\right)
$$

The monotonicity of $X$ (see (14)) shows that for any $\alpha_{1}, \alpha_{2} \in \mathcal{A}$, if $\alpha_{1} \geq p(\rho)$ and $\alpha_{2} \geq p(\rho)$, then

$$
X\left(\theta \rho, \alpha_{1}, \alpha_{2}, 1,0\right) \geq X(\theta \rho, p(\rho), p(\rho), 1,0) \geq x(\rho)
$$

if $\alpha_{1}>p(\rho)$ and $\alpha_{2} \leq p(\rho)$, then

$$
X\left(\theta \rho, \alpha_{1}, \alpha_{2}, 1,1\right) \geq X(\theta \rho, p(\lambda), p(\lambda), 1,1) \geq x(\rho)
$$

if $\alpha_{1} \leq p(\rho)$ and $\alpha_{2} \geq p(\rho)$, then

$$
X\left(\theta \rho, \alpha_{1}, \alpha_{2}, 0,0\right) \geq X(\theta \rho, p(\rho), p(\rho), 0,0) \geq x(\rho)
$$

and, if $\alpha_{1} \leq p(\rho)$ and $\alpha_{2} \leq p(\rho)$, then

$$
X\left(\theta \rho, \alpha_{1}, \alpha_{2}, 0,1\right) \geq X(\theta \rho, p(\rho), p(\rho), 0,1) \geq x(\rho)
$$

Hence, we deduce that

$$
X_{\theta \rho}=X\left(\theta \rho, \alpha_{\rho, 1}, \alpha_{\rho, 2}, \beta_{\rho, 1}, \beta_{\rho, 2}\right) \geq x(\rho),
$$

and conclude that

$$
\liminf _{\lambda \rightarrow 0+} X_{\lambda} \geq \lim _{\rho \rightarrow 0+} x(\rho)=\frac{d}{2},
$$

which finishes the proof.
