# Construction of Banach frames and atomic decompositions of anisotropic Besov spaces

#### Abstract

We construct generalised shift-invariant systems of functions of several real variables for anisotropic Besov spaces that can be generated by the decomposition method using any given expansive matrix and establish the conditions on those systems under which they will constitute Banach frames or sets of atoms for the anisotropic homo- or inhomogeneous Besov spaces.

## 1. Introduction

Besov spaces, originally constructed by the approximation method [1], play an extremely important role in the theory of differentiable functions of several real variables as they, on the one hand, constitute a closed system with respect to embedding theorems and are, on the other hand, closely related to Sobolev spaces [13]. Along with Sobolev, Besov spaces are an integral part of the embedding theory, which studies connexions between differential properties of functions in different metrics [13, 12, 2]. Harmonic analysis uses either bases or frames and sets of atoms to decompose functions of a function space into basic building blocks or synthesise them from those blocks. The isotropic Besov spaces are known [14] to have orthonormal bases made of wavelets [7]. Herein we shall use the innovative approach reported in [15, 16] to construct Banach frames and sets of atoms for the anisotropic homoand inhomogeneous Besov spaces introduced in [4] as decomposition spaces [8]. Similar results, although formulated and achieved rather differently, were reported in [4] and [3]. The work [4] was, in its turn, an ingenious generalisation of the ideas developed in [9] and [10].

This report is structured as follows. The elements of the decomposition method essential to the present work are outlined at the beginning of Section 2. The definitions of the anisotropic homo- and inhomogeneous Besov spaces viewed as decompositions spaces follow in Subsections 2.1 and 2.2. The notion of the Banach frame and that of the set of atoms for the decomposition space are reminded at the beginning of Section 3 In the same section we give the statements of the two theorems that we shall use to construct Banach frames and atomic decompositions of anisotropic Besov spaces. In Subsection 4.1 of Section 4 the set of anisotropic homogeneous Besov wavelets is defined as a generalised shiftinvariant system and the conditions are established under which this set will form a Banach frame or a set of atoms for the anisotropic homogeneous Besov space. Finally anisotropic inhomogeneous wavelets are defined in Subsection 4.2, along with the conditions under which they will be a Banach frame or a set of atoms for the anisotropic inhomogeneous Besov space.

Throughout this report the information is provided as it is first needed. All definitions and propositions borrowed from other works are supplied with corresponding references. All the new propositions are followed by their proofs.

## 2. Construction of anisotropic Besov spaces by the decomposition method

In this study we shall concern ourselves with the anisotropic Besov spaces as they were defined in [4] by the decomposition method, initially reported in [8] and further developed in [3]. This definition involves three basic building blocks, namely an almost structured cover $\mathcal{Q}$ of the open subset of the frequency space, a regular partition of unity on the subset subordinate to the covering $\mathcal{Q}$ and a $\mathcal{Q}$-moderate weight. Here are the definitions of these three notions and those of the decomposition space and its reservoir.

Definition 2.1. The set $\mathcal{Q}=\left\{Q_{i}\right\}_{i \in I}$ is called an almost structured cover of the open subset $O$ of $\mathbb{R}^{d}$ where $d \in \mathbb{N}$, if

1. $\mathcal{Q}$ is admissible, i.e. the number of elements in the sets $\left\{i^{\prime} \in I: Q_{i^{\prime}} \cap Q_{i} \neq \emptyset\right\}$ is uniformly bounded for all $i \in I$;
2. there is a set $\left\{T_{i} \bullet+b_{i}\right\}_{i \in I}$ of invertible affine-linear maps and finite sets $\left\{Q_{n}^{\prime}\right\}_{n=1}^{N}$ and $\left\{P_{n}\right\}_{n=1}^{N}$ of non-empty open and bounded subsets $Q_{i}^{\prime}$ and $P_{i}$ of $\mathbb{R}^{d}$ such that
(a) $\overline{P_{n}} \subset Q_{n}^{\prime}$ for all $1 \leqslant n \leqslant N$;
(b) for each $i \in I$ there is such an $n_{i} \in\{1, \ldots, N\}$ that $Q_{i}=T_{i} Q_{n_{i}}^{\prime}+b_{i}$;
(c) there is such a constant $C>0$ that $\left\|T_{i}^{-1} T_{i^{\prime}}\right\| \leqslant C$ for all such $i$ and $i^{\prime} \in I$ that $Q_{i} \cap Q_{i^{\prime}} \neq \emptyset$; and
(d) $O \subset \bigcup_{i \in I}\left(T_{i} P_{n_{i}}+b_{i}\right)$.

Definition 2.2. Let $\mathcal{Q}=\left\{Q_{i}\right\}_{i \in I}$ and $\left\{T_{i} \bullet+b_{i}\right\}_{i \in I}$ be an almost structured cover of the open subset $O$ of $\mathbb{R}^{d}$ and the set of invertible affine-linear maps associated with it respectively. The set of functions $\Phi=\left\{\phi_{i}\right\}_{i \in I}$ is called regular partition of unity subordinate to $\mathcal{Q}$, if

1. $\phi_{i} \in C_{c}^{\infty}(O)$ with $\operatorname{supp} \phi_{i} \subset Q_{i}$ for all $i \in I$;
2. $\sum_{i \in I} \phi_{i} \equiv 1$ on $O$; and
3. $\sup _{i \in I}\left\|\partial^{\alpha} \phi_{i}^{\natural}\right\|_{L^{\infty}}<\infty$ for all $\alpha \in \mathbb{N}_{0}^{2}$, where $\phi^{\natural}: \mathbb{R}^{d} \rightarrow \mathbb{C}, \xi \mapsto \phi_{i}\left(T_{i} \xi+b_{i}\right)$.

Definition 2.3. The sequence $w=\left\{w_{i}\right\}_{i \in I}$ of positive numbers is called weight. The weight is called $\mathcal{Q}$-moderate where $\mathcal{Q}=\left\{Q_{i}\right\}_{i \in I}$ stands for an almost structured cover of the open subset $O$ of $\mathbb{R}^{d}$, if there is such a positive number $C$ that $w_{i} \leqslant C \cdot w_{i^{\prime}}$ for all such $i$ and $i^{\prime} \in I$ that $Q_{i} \cap Q_{i^{\prime}} \neq \emptyset$.

Definition 2.4. The topological dual $Z^{\prime}$ of the space $Z:=\mathcal{F}\left(C_{c}^{\infty}\left(\mathbb{R}^{d}\right)\right) \subset \mathcal{S}\left(\mathbb{R}^{d}\right)$ equipped with the unique topology that makes the Fourier transform $\mathcal{F}: C_{c}^{\infty}\left(\mathbb{R}^{d}\right) \rightarrow Z$ into a homeomorphism will be referred to as reservoir.

Such a definition of the reservoir ensures that the decomposition space that we shall construct with its aid will be complete [5].

Definition 2.5. Let $\mathcal{Q}=\left\{Q_{i}\right\}_{i \in I}, \Phi=\left\{\phi_{i}\right\}_{i \in I}, w=\left\{w_{i}\right\}_{i \in I}$ and $Z^{\prime}$ be an almost structured cover of the open subset $O$ of $\mathbb{R}^{d}$, a regular partition of unity on $O \subset \mathbb{R}^{d}$ subordinate to $\mathcal{Q}$, a $\mathcal{Q}$-moderate weight and the reservoir, respectively, and let $p$ and $q \in(0, \infty]$. The set

equipped with the quasi-norm

is called the decomposition space.
We shall now specify covers, regular partitions of unity subordinate to them and moderate weights for the anisotropic homo- and inhomogeneous Besov spaces.

### 2.1. Construction of anisotropic homogeneous Besov spaces

Definition 2.6. The matrix $A$ whose elements are real numbers and whose spectrum $\sigma(A)$ is such that

is called expansive.
Definition 2.7. Let $Q_{0}$ be such be a compact subset of $[-1,1]^{d} \backslash\{0\}$ and $A$ such a $d \times d$ expansive matrix that

where $Q_{i}:=A^{i} Q_{0}$, then the set $\dot{Q}_{B}:=\left\{Q_{i}\right\}_{i \in \mathbb{Z}}$ will be referred to as anisotropic homogeneous cover of $\mathbb{R}^{d} \backslash\{0\}$.

The proof of existence of such a set $\dot{Q}_{B}:=\left\{Q_{i}\right\}_{i \in \mathbb{Z}}$ and its being indeed an almost structured cover of $\mathbb{R}^{d} \backslash\{0\}$ can be found in Lemma 5.2 in [6].
Definition 2.8. Let $\phi \in C^{\infty}\left(\mathbb{R}^{d} \backslash\{0\}\right)$ and $\operatorname{supp} \phi \subset Q_{0}$ with $Q_{0}$ as in Definition [2.7, then the set $\dot{\Phi}_{B}:=\left\{\phi_{i}\right\}_{i \in \mathbb{Z}}$ where

as $\xi \in \mathbb{R}^{d}$ and $i \in \mathbb{Z}$ will be referred to as anisotropic homogeneous partition of unity.
From Remark 2.3 in [6] can be inferred that $\dot{\Phi}_{B}$ is a regular partition of unity on $\mathbb{R}^{d} \backslash\{0\}$ subordinate to $\dot{Q}_{B}$.

Definition 2.9. Let $s \in \mathbb{Z}$. Then the set $\dot{w}_{B}:=\left\{w_{i}\right\}_{i \in \mathbb{Z}}$ where

for any $i \in \mathbb{Z}$ will be referred to as anisotropic homogeneous weight.
Lemma 2.10. The weight $\dot{w}_{B}$ is $\dot{Q}_{B}$-moderate.
Proof. In Lemma 5.2 of [6] it was proved that $Q_{i} \cap Q_{i^{\prime}}=\emptyset$ where $Q_{i}$ and $Q_{i^{\prime}} \in \dot{Q}_{B}$ if $\left|i-i^{\prime}\right|$ exceeds a certain finite integer $\Delta i$. Therefore

as $Q_{i} \cap Q_{i^{\prime}} \neq \emptyset$ and $|\operatorname{det} A|^{|s| \Delta i}$ can be taken as the positive number $C$ mentioned in Definition 2.3 of the moderate weight.

Definition 2.11. The decomposition space as defined by (II) with the almost structured cover $\dot{Q}_{B}$, partition of unity $\dot{\Phi}_{B}$ subordinate to $\dot{Q}_{B}$ and $\dot{Q}_{B}$-moderate weight $\dot{w}_{B}$ will be referred to as anisotropic homogeneous Besov space and denoted by $\dot{B}_{p, q}^{\alpha}$.

From this definition one can deduce that the fact that a function $g$ belongs to the space $\dot{B}_{p, q}^{\alpha}$ does not, generally speaking, imply that the composition of functions $g \circ R$ where $R$ stands for a rotation matrix will also belong to it, which justifies the attributive anisotropic in the name of the space. Only if we choose to use a scalar expansive matrix $A$ for generating the space $\dot{B}_{p, q}^{\alpha}$, the latter will be isotropic. This remark, as it will transpire later, also applies to anisotropic inhomogeneous Besov spaces to whose definition we now turn.

### 2.2. Construction of anisotropic inhomogeneous Besov spaces

Definition 2.12. Let $Q_{0}$ be such a subset of $[-1,1]^{d}, Q_{1}$ such a compact subset of $[-1,1]^{d} \backslash\{0\}$ and $A$ be such a $d \times d$ expansive matrix that

where $Q_{i}:=A^{i-1} Q_{1}$ as $i \in \mathbb{N}$, then the set $Q_{B}:=\left\{Q_{i}\right\}_{i \in \mathbb{N}_{0}}$ will be referred to as anisotropic inhomogeneous cover of $\mathbb{R}^{d}$.

The proof of existence of such a set $Q_{B}:=\left\{Q_{i}\right\}_{i \in \mathbb{N}_{0}}$ and its being indeed an almost structured cover of $\mathbb{R}^{d}$ can be found in Lemma 5.2 in [6].

Definition 2.13. Let $\phi_{0}$ and $\phi_{1} \in C^{\infty}\left(\mathbb{R}^{d} \backslash\{0\}\right)$, supp $\phi_{0} \subset Q_{0}$ and $\operatorname{supp} \phi_{1} \subset Q_{1}$ with $Q_{0}$ and $Q_{1}$ as in Definition [2.12, then the set $\Phi_{B}:=\left\{\phi_{i}\right\}_{i \in \mathbb{N}_{0}}$ where

as $\xi \in \mathbb{R}^{d}$ and $i \in \mathbb{N}$ will be referred to as anisotropic inhomogeneous partition of unity.
From Remark 2.3 in [6] can be inferred that $\Phi_{B}$ is a regular partition of unity on $\mathbb{R}^{d}$ subordinate to $Q_{B}$.

Definition 2.14. Let $s \in \mathbb{Z}$. Then the set $\dot{w}_{B}:=\left\{w_{i}\right\}_{i \in \mathbb{N}_{0}}$ where $w_{0}:=1$ and

for any $i \in \mathbb{N}$ will be referred to as anisotropic inhomogeneous weight.
Lemma 2.15. The weight $w_{B}$ is $Q_{B}$-moderate.
The proof of this lemma is almost identical to that of 2.10 .
Definition 2.16. The decomposition space as defined by (11) with the almost structured cover $Q_{B}$, partition of unity $\Phi_{B}$ subordinate to $Q_{B}$ and $Q_{B}$-moderate weight $w_{B}$ will be referred to as anisotropic inhomogeneous Besov space and denoted by $B_{p, q}^{\alpha}$.

## 3. Construction of Banach frames for and atomic decompositions of the decomposition spaces

The decomposition space is a example of the quasi-Banach space, i. e. the complete quasi-normed vector space. Banach frames and sets of atoms provide the quasi-Banach space with those basic building blocks into which any of the element of the space can be decomposed or from which an element of the space can be synthesised. Here are the definitions of these two notions [11], along with one axillary definition.

Definition 3.1. Let $A \subset \mathbb{C}^{I}$ where $\mathbb{C}^{I}$ stands for the quasi-Banach space consisting of sequences of complex numbers indexed by $i \in I$ and let $a=\left\{a_{i}\right\}_{i \in I} \in A$. If $\left|a_{i}^{\prime}\right| \leqslant\left|a_{i}\right|$ for all $i \in I$ implies that $a^{\prime}=\left\{a_{i}^{\prime}\right\}_{i \in I} \in A$ and $\left\|a^{\prime}\right\|_{\mathbb{C}^{I}} \leqslant\|a\|_{\mathbb{C}^{I}}$, then $A$ is called solid.

Definition 3.2. A set $\left\{\psi_{i}\right\}_{i \in I}$ in the dual space $X^{\prime}$ of a quasi-Banach space $X$ is called Banach frame for $X$ if there is a well-defined bounded map, called analysis operator, $A: X \rightarrow x, f \mapsto\left\{\left\langle\psi_{i}, f\right\rangle\right\}_{i \in I}$ where $x:=\left\{\left\{\left\langle\psi_{i}, f\right\rangle\right\}_{i \in I}: f \in X\right\}$ is a solid quasi-Banach subspace of $\mathbb{C}^{I}$ and there is such a bounded linear map $A_{l}^{-1}: x \rightarrow X$ that $A_{l}^{-1} \circ A=I_{X}$ where $I_{X}$ stands for an identity operator on $X$.

Definition 3.3. A set $\left\{\phi_{i}\right\}_{i \in I}$ in a quasi-Banach space $X$ is called set of atoms in $X$ if there is a well-defined bounded map, called synthesis operator, $S: x \rightarrow X,\left\{c_{i}\right\}_{i \in I} \mapsto \sum_{i \in I} c_{i} \phi_{i}$ where the coefficient space $x:=\left\{c_{i}\right\}_{i \in I}$ associated with $\left\{\phi_{i}\right\}_{i \in I}$ is a solid subspace of $\mathbb{C}^{I}$ and there is such a bounded linear map $S_{r}^{-1}: X \mapsto x$ that $S \circ S_{r}^{-1}=I_{X}$ where $I_{X}$ stands for an identity operator on $X$. The series expansion $g=\sum_{i \in I} c_{i} \phi_{i}$ of a given function $g \in X$ where $\left\{\phi_{i}\right\}_{i \in I}$ is a set of atoms is called atomic decomposition of $g$.

To construct Banach frames and sets of atoms for the anisotropic Besov spaces $\dot{B}_{p, q}^{\alpha}$ and $B_{p, q}^{\alpha}$ we shall use the following two concepts and two theorems.

Definition 3.4. Let $\delta>0,\left\{T_{i} \bullet+b_{i}\right\}_{i \in I}$ be a denumerable set of invertible affine-linear maps on $\mathbb{R}^{d}$ and $\left\{\phi_{n}\right\}_{n=1}^{N}$ a finite set of square integrable functions on $\mathbb{R}^{d}$. Then

where $M_{s} f(z):=e^{2 \pi i s z} f(z)$ and $\phi_{n_{i}} \in\left\{\phi_{n}\right\}_{n=1}^{N}$ is called generalised shift-invariant system.
Definition 3.5. Let $p$ and $q \in(0, \infty]$ and $w=\left\{w_{i}\right\}_{i \in I}$ be a weight. Then

is called coef ficient space associated with $\Psi$.
The functions $\left\{\phi_{n}\right\}_{n=1}^{N}$ in Definition 3.4 can be regarded as prototypes of all the functions in $\Psi$. The next two theorems specify the conditions on the prototypes under which $\Psi$ will constitute a Banach frame or a set of atoms for the decomposition space $\mathcal{D}\left(\mathcal{Q}, L^{p}, \ell_{w}^{q}\right)$ respectively.
Theorem 3.6. Let $\epsilon, p_{0}$ and $q_{0} \in(0,1], p \in\left[p_{0}, \infty\right], q \in\left[q_{0}, \infty\right]$ and $\Phi=\left\{\phi_{i}\right\}_{i \in I}$ and $w=\left(w_{i}\right)_{i \in I}$ be respectively a regular partition of unity subordinate to $\mathcal{Q}$ and a $\mathcal{Q}$-moderate weight where $\mathcal{Q}$ stands for the almost structured cover of an open subset $O$ of $\mathbb{R}^{d}$ whose elements $\left\{Q_{i}\right\}_{i \in I}$ are generated by having the invertible affine-linear transformations $\left\{T_{i} \bullet+b_{i}\right\}_{i \in I}$ act on elements of the finite set $\left\{Q_{n}^{\prime}\right\}_{n=1}^{N}$ of non-empty open and bounded subsets $Q_{i}^{\prime}$ of $\mathbb{R}^{d}$. Cf Definition 2.1, 2.2 and 2.3. Furthermore let all the elements of the finite set $\left\{\phi_{n}\right\}_{n=1}^{N}$ of square integrable functions on $\mathbb{R}^{d}$, introduced in Definition 3.4, satisfy the following conditions :
. $\hat{\phi}_{n} \in C^{\infty}\left(\mathbb{R}^{d}\right)$;
2. $\hat{\phi}_{n}$ and all its partial derivatives are of polynomial growth at most;
3. $\hat{\phi}_{n}(\xi) \neq 0$ as $\xi \in \overline{Q_{n}^{\prime}}$;
4. $\phi_{n} \in C^{1}\left(\mathbb{R}^{d}\right)$ and $\nabla \phi_{n} \in L^{1}\left(\mathbb{R}^{d}\right) \cap L^{\infty}\left(\mathbb{R}^{d}\right)$; and

## 4. Construction of Banach frames and atomic decompositions of the anisotropic Besov spaces

### 4.1. Banach frames and atomic decompositions of anisotropic homogeneous Besov spaces

First of all we define shift-invariant systems for the anisotropic homogeneous spaces and coefficient spaces associated with them. Here are these definitions.

Under this condition the sum of the first series in (47) was estimated in (42). Since $n \leqslant 0$ using the substitution $m^{\prime}:=m-n$ in the second series in (47) results in

\sum_{m=0}^{\infty} M_{m n}=M_{0 n}+\sum_{m=1}^{n} M_{m n}+\sum_{m=n+1}^{\infty} M_{m n} \tag{72}
\end{equation*}
$$

and deal with them separately. We use (59) to change the set over witch the integration in $M_{0 n}$ is done from $Q_{n}$ to $Q_{1}$ and obtain

$$
M_{0 n}=a^{-\tau n}\left(1+\left\|A^{n-1}\right\|\right)^{\sigma}\left[\frac{1}{\left|Q_{1}\right|} \int_{Q_{1}}\left|\hat{\phi}\left(A^{n-1} \xi\right)\right| d \xi\right]^{\tau}
$$

and then combine it with (61) and (22) to obtain

$$
\begin{align*}
M_{0 n} & \leqslant a^{-\tau n} \cdot\left(1+\left\|A^{n-1}\right\|\right)^{\sigma} \cdot\left[\frac{C}{\left|Q_{1}\right|} \int_{Q_{1}} \frac{d \xi}{\left(1+\left|A^{n-1} \xi\right|\right)^{K}}\right]^{\tau} \\
& \left.\leqslant a^{-\tau n} \cdot\left(1+b \lambda_{+}^{n-1}\right)^{\sigma} \cdot\left[\frac{C}{\left|Q_{1}\right|} \int_{Q_{1}} \frac{d \xi}{\left(1+\frac{\lambda_{-}^{n-1}|\xi|}{b}\right)^{K}}\right]^{\tau}\right]^{\tau}  \tag{73}\\
& \leqslant a^{-\tau n} \cdot\left(1+b \lambda_{+}^{n-1}\right)^{\sigma} \cdot\left[\frac{C}{\left(1+\frac{\lambda_{-}^{n-1} r}{b}\right)^{K}}\right]^{-\tau n} \cdot\left(1+b \lambda_{+}^{n-1}\right)^{\sigma} \cdot\left[\frac{C}{\left(\frac{\lambda_{-}^{n-1} r}{b}\right)^{K}}\right]^{\tau} \\
& \leqslant\left(\frac{1+b}{\lambda_{+}}\right)^{\sigma} \cdot C^{\tau}\left(\frac{b \lambda_{-}}{r}\right)^{K \tau} \cdot\left[\frac{\lambda_{+}^{\sigma}}{\left(a \lambda_{-}^{K}\right)^{\tau}}\right]^{n}=: M_{n}
\end{align*}
$$

The $M_{n}$ function in (73) is bounded for any finite $K$ and $n$. Therefore we only have to find the condition on $K$ under which $M_{n}$ stays bounded as $n$ grows unlimitedly. We shall achieve this by finding such a $K$ that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} M_{n}=0 . \tag{74}
\end{equation*}
$$

This holds if, as assumed in this lemma, (60) does. Under this condition

$$
\begin{equation*}
M_{0 n} \leqslant \sum_{n=1}^{\infty} M_{0 n} \leqslant \sum_{n=1}^{\infty} M_{n}=\left(\frac{1+b}{\lambda_{+}}\right)^{\sigma} \cdot C^{\tau} \cdot\left(\frac{b \lambda_{-}}{r}\right)^{K \tau} \cdot \frac{1}{1-\frac{\lambda_{+}^{\sigma}}{\left(a \lambda_{-}^{K}\right)^{\tau}}} . \tag{75}
\end{equation*}
$$

Now we deal with the rest of the series (72). Changing the set over which the integration in $M_{m n}$ is done from $Q_{n}$ to $Q_{1}$ results in expression identical to (33). Combining it with (28) gives the estimate $M_{m n}$ from above identical to that in (34). Using (22), the general term in the second part of (72), in which $n \geqslant m$, results in its estimate identical to that in (35). Making the substitution $m^{\prime}:=n-m$ and changing the order of summation leads to

\sum_{m=1}^{n} M_{m n} \leqslant \sum_{m^{\prime}=0}^{n-1} M_{m^{\prime}} \leqslant \sum_{m^{\prime}=0}^{\infty} M_{m^{\prime}} \tag{76}
\end{equation*}
$$

where $M_{m^{\prime}}$ as defined in (39). Therefore the series in the second term of (72) will converge if, as assumed in this lemma, (27) holds. Its sum was already estimated in (42). Using (23), the general term in the third part of (72), in which $n \leqslant m$, results in its estimate identical to that in (36). Making the substitution $m^{\prime}:=m-n$ leads to

$$
\begin{equation*}
\sum_{m=n+1}^{\infty} M_{m n}=\sum_{m^{\prime}=1}^{\infty} M_{m^{\prime}} \leqslant \sum_{m^{\prime}=0}^{\infty} M_{m^{\prime}} \tag{77}
\end{equation*}
$$

where $M_{m^{\prime}}$ as difined in (44). Therefore the series in the third term of (72) will converge if, as assumed in this lemma, (26) holds. Its sum was already estimated in (46). Combining (75), (42) and (46) leads to (65)) as the upper bound of the whole series in (72) as $n \neq 0$.

Now we investigate the series (63). If $m=0$ we divide it into two parts, i.e.

$$
\begin{equation*}
\sum_{n=0}^{\infty} M_{0 n}=M_{00}+\sum_{n=1}^{\infty} M_{0 n} \tag{78}
\end{equation*}
$$

where $M_{00}$ and $M_{0 n}$ were already estimated in (68) and (73) respectively. Therefore the series (78) will converge if, as assumed in this lemma, (60) holds. Under this condition combining (68) and (73) results in (66) as $m=0$.

If $m \neq 0$ we divide the series (63) into three parts

$$
\begin{equation*}
\sum_{n=0}^{\infty} M_{m n}=M_{m 0}+\sum_{n=1}^{m} M_{m n}+\sum_{n=m+1}^{\infty} M_{m n} \tag{79}
\end{equation*}
$$

The term $M_{m 0}$ was already estimated in (71) and will be bounded as long as the condition on $L$ in (26) holds. The second term in (79) was estimated in (36) and can be converted into a finite sum over $m^{\prime}$ whose general term is identical to that of the series in (77) by using the substitution $m^{\prime}:=m-n$. The finite sum being smaller than the sum of the corresponding series, it leads us again to the condition on $L$ identical to that in (266). Thus the upper bound of the second term in (79) is given by (46). Similarly the third part in (79) can be converted into the series whose general term is identical to that in (39) by using the substitution $m^{\prime}:=n-m$. This leads to the condition on $N$ identical to that in (27). The upper bound of the third part in (79) is given by (42). Combining (69), (46) and (42) results in (66) as $m \neq 0$.

The next theorem establishes the conditions on $\Psi_{B}$ under which it will be a Banach frame for $B_{p, q}^{\alpha}$.
Theorem 4.10. Let $\epsilon$, $p_{0}$ and $q_{0} \in(0,1]$. Moreover let $\phi_{1}$ and $\phi_{2} \in L^{1}\left(\mathbb{R}^{d}\right)$ satisfy the following conditions :

1. $\hat{\phi}_{1}$ and $\hat{\phi}_{2} \in C^{\infty}\left(\mathbb{R}^{d}\right)$;
2. $\hat{\phi}_{1}$ and $\hat{\phi}_{2}$ and all its partial derivatives are of polynomial growth at most;
3. $\hat{\phi}_{1}(\xi) \neq 0$ as $\xi \in \bar{Q}_{0}$ and $\hat{\phi}_{2}(\xi) \neq 0$ as $\xi \in \bar{Q}_{1}$ where $Q_{0}$ and $Q_{1}$ as in Definition 2.12;
$\phi \in C^{1}\left(\mathbb{R}^{d}\right)$ and $\nabla \phi \in L^{1}\left(\mathbb{R}^{d}\right) \cap L^{\infty}\left(\mathbb{R}^{d}\right) ;$ and
4. 

$$
\begin{equation*}
\left|\partial^{\alpha} \widehat{\partial^{\beta} \phi_{1}}(\xi)\right| \leqslant C(1+|\xi|)^{-K_{4}} \tag{80}
\end{equation*}
$$

with $C$ standing for a constant and

$$
\begin{equation*}
K_{4}>\log _{\lambda_{-}}\left(\frac{\lambda_{+}^{\sigma / \tau}}{|\operatorname{det} A|^{s-\theta}}\right) \tag{81}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\partial^{\alpha} \widehat{\partial^{\beta} \phi_{2}}(\xi)\right| \leqslant C \min \left\{1,|\xi|^{L_{4}}\right\}(1+|\xi|)^{-N_{4}} \tag{82}
\end{equation*}
$$

with $C$ standing for a constant,

$$
\begin{equation*}
L_{4}>(s-\theta) \log _{\lambda_{-}}(|\operatorname{det} A|) \tag{83}
\end{equation*}
$$

and

$$
\begin{equation*}
N_{4}>\log _{\lambda_{-}}\left(\frac{\lambda_{+}^{\sigma / \tau}}{|\operatorname{det} A|^{s-\theta}}\right) \tag{84}
\end{equation*}
$$

as $\xi \in \mathbb{R}^{d}$ and $l \in\{1,2\}$ and for all such $\alpha$ and $\beta \in \mathbb{N}_{0}^{d}$ that $|\alpha| \leqslant N$ and $|\beta| \leqslant 1$.
Then there is such a $\delta_{0}=\delta_{0}\left(\epsilon, p_{0}, q_{0}, d, A, \phi\right)>0$ that the anisotropic heterogeneous Besov wavelets $\Psi_{B}$ with the coefficient space $C_{B s}^{p, q}$ constitutes a Banach frame for the anisotropic heterogeneous Besov space $B_{p, q}^{\alpha}(A)$ as long as $\delta \in\left(0, \delta_{0}\right]$.
Proof. The first four assumptions of this theorem are nothing but those of Theorem 3.6 formulated for the generalised shift-invariant system $\Psi_{B}$ with the coefficient space $C_{B s}^{p, q}$ pertaining to the cover $Q_{B}$ of $\mathbb{R}^{d}$ and weight $w_{B}$ that form the space $B_{p, q}^{\alpha}$. Furthermore we recollect that $T_{0}=I_{d},\left\{T_{i}\right\}_{i \in \mathbb{N}}=\left\{A^{i-1}\right\}_{i \in \mathbb{N}}$ and $\left\{b_{i}\right\}_{i \in \mathbb{N}_{0}}=0$ as $\Psi=\Psi_{B}$ and that $w_{0}=1$ and $\left\{w_{i}\right\}_{i \in \mathbb{N}}=\left\{|\operatorname{det} A|^{(i-1) s}\right\}_{i \in \mathbb{N}}$ with $s \in \mathbb{Z}$ as
$C_{w}^{p, q}=C_{B s}^{p, q}$. Therefore $N_{i j}^{1}$ defined by (12) becomes

N_{i j}^{1} \leqslant\left\{\begin{array}{l}
2^{\sigma} \cdot \max _{|\beta| \leqslant 1}\left(\frac{2^{d}}{\left|Q_{0}\right|} \int_{Q_{0}} \max _{|\alpha| \leqslant N}\left|\left[\partial^{\alpha} \widehat{\partial^{\beta} \phi_{1}}\right](\xi)\right| d \xi\right)^{\tau}, \quad(i=j=0)  \tag{85}\\
\left(|\operatorname{det} A|^{s}\right)^{\tau(i-1)} \cdot\left(1+\left\|A^{-(i-1)}\right\|\right)^{\sigma} \\
\\
\cdot \max _{|\beta| \leqslant 1}\left(\frac{2^{d}}{\left|Q_{0}\right|} \int_{Q_{0}} \max _{|\alpha| \leqslant N}\left|\left[\partial^{\alpha} \widehat{\partial^{\beta} \phi_{2}}\right]\left(A^{-(i-1)} \xi\right)\right| d \xi\right)^{\tau}, \quad(i \neq 0, j=0) \\
\left(|\operatorname{det} A|^{s}\right)^{\tau(1-j)} \cdot\left(1+\left\|A^{j-1}\right\|\right)^{\sigma} \\
\cdot \max _{|\beta| \leqslant 1}\left(\frac{2^{d}}{\left|Q_{j}\right|} \int_{Q_{j}} \max _{|\alpha| \leqslant N}\left|\left[\partial^{\alpha} \widehat{\partial^{\beta} \phi_{1}}\right](\xi)\right| d \xi\right)^{\tau}, \quad(i=0, j \neq 0) \\
\left(|\operatorname{det} A|^{s}\right)^{\tau(i-j)} \cdot\left(1+\left\|A^{j-i}\right\|\right)^{\sigma} \\
\cdot \max _{|\beta| \leqslant 1}\left(\frac{2^{d}}{\left|Q_{j}\right|} \int_{Q_{j}} \max _{|\alpha| \leqslant N}\left|\left[\partial^{\alpha} \widehat{\partial^{\beta} \phi_{2}}\right]\left(A^{-(i-1)} \xi\right)\right| d \xi\right)^{\tau}, \quad(i \neq 0, j \neq 0)
\end{array}\right.
$$

where we also noted that $\left|Q_{0}\right| \leqslant 2^{d}$ and $\left|Q_{j}\right|=\left|A^{j-1} Q_{1}\right|=\left|\operatorname{det} A^{j-1}\right| \cdot\left|Q_{1}\right| \leqslant|\operatorname{det} A|^{j-1} \cdot 2^{d}$ as $j \in \mathbb{N}$. The expressions on the right hand of (85) can be further estimated to conclude that, for any $i$ and $j \in \mathbb{N}_{0}$,

\begin{equation*}
N_{i j}^{1} \leqslant 2^{d} \cdot|\operatorname{det} A|^{|s| \tau} \cdot M_{m n} \tag{86}
\end{equation*}
$$

with $M_{m n}$ defined by (64) if $m=i, n=j$ and $a=|\operatorname{det} A|^{s}$ and as long as $K_{3}$ in (87) and $L_{3}$ and $N_{3}$ in (89) are not smaller than $K$ in (61) and $L$ and $N$ in (28) respectively. According to Lemma 4.9 the series (62) and (63) converge on the assumption (28) about $\hat{\psi}(\xi)$ with $L$ defined by (26), $N$ defined by (27) and $K$ defined by (60). Therefore the series (11) converge on the assumption (87) about $\rho_{1}(\xi)$ with $K_{3}$ defined by (88) and the assumption (89) about $\rho_{2}(\xi)$ with $L_{3}$ defined by (90) and $N_{3}$ defined by (91). In other words the fifth assumption of Theorem 3.6 follows from the fifth assumption of the present theorem.

The next theorem establishes the conditions on $\Psi_{B}$ under which it will be a set of atoms for $B_{p, q}^{\alpha}$.
Theorem 4.11. Let $\epsilon$, $p_{0}$ and $q_{0} \in(0,1]$. Moreover let $\phi_{1}$ and $\phi_{2} \in L^{1}\left(\mathbb{R}^{d}\right)$ satisfy the following conditions :

1. $\hat{\phi}_{1}$ and $\hat{\phi}_{2} \in C^{\infty}\left(\mathbb{R}^{d}\right)$;
2. $\hat{\phi}_{1}$ and $\hat{\phi}_{2}$ and all its partial derivatives are of polynomial growth at most;
3. $\hat{\phi}_{1}(\xi) \neq 0$ as $\xi \in \bar{Q}_{0}$ and $\hat{\phi}_{2}(\xi) \neq 0$ as $\xi \in \bar{Q}_{1}$ where $Q_{0}$ and $Q_{1}$ as in Definition 2.12;
4. for each $l \in\{1,2\}$

\sup _{t \in \mathbb{R}^{d}}\left[(1+|t|)^{\Lambda} \cdot\left|\phi_{l}(t)\right|\right]<\infty
$$

where $\Lambda:=1+d / p_{0}$; and
5.

$$
\left|\partial^{\alpha} \hat{\phi}_{l}(\xi)\right| \leqslant \rho_{l}(\xi) \cdot(1+|\xi|)^{-(d+1+\epsilon)}
$$

where

\begin{equation*}
\rho_{1}: \mathbb{R}^{d} \rightarrow(0, \infty), \xi \mapsto C(1+|\xi|)^{-K_{3}} \tag{87}
\end{equation*}

with $C$ standing for a constant and

K_{3}>\log _{\lambda_{-}}\left(\frac{\lambda_{+}^{\sigma / \tau}}{|\operatorname{det} A|^{s}}\right) \tag{88}
\end{equation*}

and

\rho_{2}: \mathbb{R}^{d} \rightarrow(0, \infty), \quad \xi \mapsto C \min \left\{1,|\xi|^{L_{3}}\right\}(1+|\xi|)^{-N_{3}} \tag{89}
\end{equation*}

with $C$ standing for a constant,

\begin{equation*}
L_{3}>s \log _{\lambda_{-}}(|\operatorname{det} A|) \tag{90}
\end{equation*}
$$

and

\begin{equation*}
N_{3}>\log _{\lambda_{-}}\left(\frac{\lambda_{+}^{\sigma / \tau}}{|\operatorname{det} A|^{s}}\right) \tag{91}
\end{equation*}
$$

as $\xi \in \mathbb{R}^{d}$ and for all such $\alpha \in \mathbb{N}_{0}^{d}$ that $|\alpha| \leqslant N$ where

N:=\left\lceil\frac{d+\epsilon}{p_{0}}\right\rceil .
$$

Then there is such a $\delta_{0}=\delta_{0}\left(\epsilon, p_{0}, q_{0}, d, A, \phi\right)>0$ that the anisotropic heterogeneous Besov wavelets $\Psi_{B}$ with the coefficient space $C_{B s}^{p, q}$ constitutes a set of atoms for the anisotropic heterogeneous Besov space $B_{p, q}^{\alpha}(A)$ as long as $\delta \in\left(0, \delta_{0}\right]$.

Proof. The first four assumptions of this theorem are nothing but those of Theorem 3.7 formulated for the generalised shift-invariant system $\Psi_{B}$ with the coefficient space $C_{B s}{ }^{p, q}$ pertaining to the cover $Q_{B}$ of $\mathbb{R}^{d}$ and weight $w_{B}$ that form the space $B_{p, q}^{\alpha}$. Therefore $N_{i j}^{2}$ defined by (17) becomes

\left(|\operatorname{det} A|^{s-\theta}\right)^{\tau(i-1)} \cdot\left(1+\left\|A^{i-1}\right\|\right)^{\sigma} \cdot\left(\frac{2^{d}}{\left|Q_{i}\right|} \int_{Q_{i}} \rho_{1}(\xi) d \xi\right)^{\tau}, \quad(i \neq 0, j=0) \\
\left(|\operatorname{det} A|^{s-\theta}\right)^{\tau(1-j)} \cdot\left(1+\left\|A^{-(j-1)}\right\|\right)^{\sigma} \cdot\left(\frac{2^{d}}{\left|Q_{0}\right|} \int_{Q_{0}} \rho_{2}\left(A^{-(j-1)} \xi\right) d \xi\right)^{\tau}, \quad(i=0, j \neq 0) \\

where we also noted that $\left|Q_{0}\right| \leqslant 2^{d}$ and $\left|Q_{j}\right|=\left|A^{j-1} Q_{1}\right|=\left|\operatorname{det} A^{j-1}\right| \cdot\left|Q_{1}\right| \leqslant|\operatorname{det} A|^{j-1} \cdot 2^{d}$ as $j \in \mathbb{N}$. The expressions on the right hand of (92) can be further estimated to conclude that, for any $i$ and $j \in \mathbb{N}_{0}$,

N_{i j}^{1} \leqslant 2^{d} \cdot|\operatorname{det} A|^{|s-\theta| \tau} \cdot M_{m n} \tag{93}
\end{equation*}
$$

with $M_{m n}$ defined by (64) if $m=j, n=i$ and $a=|\operatorname{det} A|^{s-\theta}$ and as long as $K_{4}$ in (80) and $L_{4}$ and $N_{4}$ in (82) are not smaller than $K$ in (61) and $L$ and $N$ in (28) respectively. According to Lemma 4.9 the series (62) and (63) converge on the assumption (28) about $\hat{\psi}(\xi)$ with $L$ defined by (26), $N$ defined by (27) and $K$ defined by (60). Therefore the series (11) converge on the assumption (80) about $\phi_{1}(\xi)$ with $K_{4}$ defined by (81) and the assumption (82) about $\phi_{2}(\xi)$ with $L_{4}$ defined by (83) and $N_{4}$ defined by (84). In other words the fifth assumption of Theorem 3.7 follows from the fifth assumption of the present theorem.
