# TRAVELLING HELICES AND THE VORTEX FILAMENT CONJECTURE IN THE INCOMPRESSIBLE EULER EQUATIONS

Abstract. We consider the Euler equations in $\mathbb{R}^{3}$ expressed in vorticity form

A classical question that goes back to Helmholtz is to describe the evolution of solutions with a high concentration around a curve. The work of Da Rios in 1906 states that such a curve must evolve by the so-called binormal curvature flow. Existence of true solutions concentrated near a given curve that evolves by this law is a long-standing open question that has only been answered for the special case of a circle travelling with constant speed along its axis, the thin vortex-rings. We provide what appears to be the first rigorous construction of helical filaments, associated to a translating-rotating helix. The solution is defined at all times and does not change form with time. The result generalizes to multiple polygonal helical filaments travelling and rotating together.

## 1. Introduction

We consider the 3-dimensional Euler equations for an ideal incompressible homogeneous fluid in a time interval $(0, T)$ and a smooth initial condition $u_{0}$ given by

\mathbf{u}(\cdot, 0) & =u_{0} & & \text { in } \mathbb{R}^{3} .
\end{align*}

For a solution $\mathbf{u}$ of (1.1), its vorticity is defined as $\vec{\omega}=$ curl $\mathbf{u}$. Then $\vec{\omega}$ solves the Euler system in vorticity form (1.1),

\vec{\omega}(\cdot, 0)=\operatorname{curl} u_{0} & \text { in } \mathbb{R}^{3}
\end{align*}

We are interested in solutions of the Euler equations whose vorticities are large and uniformly concentrated near an evolving smooth curve $\Gamma(t)$ embedded in entire $\mathbb{R}^{3}$ and so that the associated velocity field vanishes as the distance to the curve goes to infinity. This type of solutions, vortex filaments, are classical objects of study in fluid dynamics, whose analysis traces back to Helmholtz and Kelvin. In 1867 Helmholtz considered with great attention the situation where the vorticity is concentrated in a circular vortex filament with small section. He detected that these vortex rings have an approximately steady form and travel with a large constant velocity along the axis of the ring. In 1894, Hill found an explicit axially symmetric solution of (1.2) supported in a sphere (Hill's vortex ring).

In 1970, Fraenkel [14] provided the first construction of a vortex ring concentrated around a torus with fixed radius with a small, nearly singular section $\varepsilon>0$, travelling with constant speed $\sim|\log \varepsilon|$, rigorously establishing the behaviour predicted by Helmholtz. Vortex rings have been analyzed in larger generality in [13, 25, 1, (9).

Da Rios [5] in 1906, and Levi-Civita [22] in 1908, formally found the general law of motion of a vortex filament with a thin section of radius $\varepsilon>0$, uniformly distributed around an evolving curve $\Gamma(t)$. Roughly speaking, he demonstrated that under suitable assumptions on the solution, the curve evolves by its binormal flow, with a large velocity of order $|\log \varepsilon|$. More precisely, if $\Gamma(t)$ is parametrized as $x=\gamma(s, t)$ where $s$ designates its arclength parameter, then $\gamma(s, t)$ asymptotically obeys a law of the form

as $\varepsilon \rightarrow 0$, or scaling $t=|\log \varepsilon|^{-1} \tau$,

$$
\begin{equation*}
\gamma_{\tau}=2 c\left(\gamma_{s} \times \gamma_{s s}\right)=2 c \kappa \mathbf{b}_{\Gamma(\tau)} \tag{1.4}
\end{equation*}

Here $c$ corresponds to the circulation of the velocity field on the boundary of sections to the filament, which is assumed to be a constant independent of $\varepsilon$. For the curve $\Gamma(\tau)$ parametrized as $x=\gamma(\tau, s)$, we designate by $\mathbf{t}_{\Gamma(\tau)}, \mathbf{n}_{\Gamma(\tau)}, \mathbf{b}_{\Gamma(\tau)}$ the usual tangent, normal and binormal unit vectors, $\kappa$ its curvature.

The law (1.3) was formally rediscovered several times during the 20th century, see the survey paper by Ricca [26].

In [16], Jerrad and Seis gave a precise form to Da Rios' computation under the weakest known conditions on a solution to (1.2) which remains suitably concentrated around an evolving curve. Their result considers a solution $\vec{\omega}_{\varepsilon}(x, t)$ under a set of conditions that imply that as $\varepsilon \rightarrow 0$

where $\Gamma(\tau)$ is a sufficiently regular curve and $\delta_{\Gamma(\tau)}$ denotes a uniform Dirac measure on the curve. They prove that $\Gamma(\tau)$ does indeed evolve by the law (1.4). See [18] and its references for results on the flow (1.4).

The existence of a true solution of (1.2) satisfying (1.5) near a given curve $\Gamma(\tau)$ that evolves by the binormal flow (1.4) is an outstanding open question called the vortex filament conjecture. This statement is unknown except for very special cases. A basic example is given by a circle $\Gamma(\tau)$ with radius $R$ translating with constant speed along its axis parametrized as

We check that

$$
\gamma_{s} \times \gamma_{s s}=R^{-1}\left(\begin{array}{l}

and hence $\gamma$ satisfies equation (1.4). Fraenkel's result [14] on thin vortex rings yields existence of a solution $\vec{\omega}_{\varepsilon}(x, t)$ without change of form, such that the asymptotic behavior (1.5) holds for this curve. In other words, the statement of the vortex filament conjecture holds true for the case of the traveling circle. The vortex filament conjecture is also true in the case of a straight line. It suffices to consider
a concentrated steady state constrained to a plane normal to the line and then trivially extending it in the remaining variable.

Another known solution of the binormal flow (1.4) that does not change its form in time is the rotating-translating helix, the curve $\Gamma(\tau)$ parametrized as

\frac{h s+b_{1} 1}{\sqrt{h^{2}+R^{2}}}
\end{array}\right), \quad a_{1}=\frac{2 c h}{h^{2}+R^{2}}, \quad b_{1}=\frac{2 c R^{2}}{h^{2}+R^{2}} .

Here $R>0, h \neq 0$ are constants that are in correspondence with the curvature and torsion of the helix, the numbers respectively given by $\frac{R}{h^{2}+R^{2}}$ and $\frac{h}{h^{2}+R^{2}}$. We readily check that the parametrization (1.7) satisfies equation (1.4). This helix degenerates into the the traveling circle (1.6) when $h \rightarrow 0$ and to a straight line when $|h| \rightarrow+\infty$.

The helices (1.7) were observed to possibly describe vortex filaments in the sense (1.5) more than 100 years ago by Joukowsky [20, Da Rios [6] and Levi-Civita [23]. Their no-change in form can be described by using the rotation matrices

Then $\gamma(s, \tau)$ has can be recovered from $\gamma(s, 0)$ by a rotation and a vertical translation by means of the sense that

a_{2}=\frac{2 c h}{\left(h^{2}+R^{2}\right)^{\frac{3}{2}}}, \quad b_{2}=\frac{2 c R^{2}}{\left(h^{2}+R^{2}\right)^{\frac{3}{2}}} . \tag{1.9}
\end{gather*}

Renewed interest in helical filaments has risen in the last two decades, see [29] for a recent survey. However, there has been no proof of their existence.

The purpose of this paper is to construct a true helical filament $\vec{\omega}_{\varepsilon}(x, t)$ satisfying (1.5). This solution does not change of form and goes along the helix in the sense that the vector field

satisfies

\begin{align*}
& F(x, \tau)=Q_{a_{2} \tau} F\left(P_{-a_{2} \tau} x^{\prime}, x_{3}+b_{2} \tau, 0\right) \\
& F(x, \tau)=F\left(x^{\prime}, x_{3}+2 \pi h, \tau\right) \tag{1.11}
\end{align*}
$$

with $a_{2}, b_{2}$ given by (1.9), $x=\left(x^{\prime}, x_{3}\right), x^{\prime}=\left(x_{1}, x_{2}\right)$.
Theorem 1. Let $\Gamma(\tau)$ be the helix parametrized by equation (1.4). Then there exists a smooth solution $\vec{\omega}_{\varepsilon}(x, t)$ to (1.2), defined for $t \in(-\infty, \infty)$ that does not change form and follows the helix in the sense (1.10)-(1.11), such that for all $\tau$,

\vec{\omega}_{\varepsilon}\left(x, \tau|\log \varepsilon|^{-1}\right) \rightharpoonup c \delta_{\Gamma(\tau)} \mathbf{t}_{\Gamma(\tau)} \quad \text { as } \quad \varepsilon \rightarrow 0
$$

This result extends to the situation of several helices symmetrically arranged. Let us consider the curve $\Gamma(\tau)$ parametrized by $\gamma(\tau, s)$ in (1.7). Let us define for $j=1, \ldots, k$ the curves $\Gamma_{j}(\tau)$ parametrized by

\gamma_{j}(s, \tau)=Q_{2 \pi \frac{j-1}{k}} \gamma(s, \tau) \tag{1.12}
\end{equation*}
$$

The following result extends that of Theorem 1 .
Theorem 2. Let $\Gamma_{j}(\tau)$ be the helices parametrized by equation (1.12), for $j=$ $1, \ldots, k$. Then there exists a smooth solution $\vec{\omega}_{\varepsilon}(x, t)$ to (1.2), defined for $t \in$ $(-\infty, \infty)$ that does not change form and follows the helix in the sense (1.10)-(1.11), such that for all $\tau$,

\vec{\omega}_{\varepsilon}\left(x, \tau|\log \varepsilon|^{-1}\right) \rightharpoonup c \sum_{j=1}^{k} \delta_{\Gamma_{j}(\tau)} \mathbf{t}_{\Gamma_{j}(\tau)} \quad \text { as } \quad \varepsilon \rightarrow 0
$$

Our construction takes advantage of a screw-driving symmetry invariance enjoyed by the Euler equations observed by Dutrifoy [10] and Ettinger-Titi [12], see also the more recent results in [2, 19]. From the analysis in the latter reference, it follows that a function of the form

\vec{\omega}(x, t)=\frac{1}{h} w\left(P_{-\frac{x_{3}}{h}} x^{\prime}, t\right)\binom{P_{\frac{\pi}{2}} x^{\prime}}{h}, \quad x^{\prime}=\left(x_{1}, x_{2}\right)
$$

solves (1.2) if the scalar function $w\left(x^{\prime}, t\right)$ satisfies the transport equation

$$
\left\{\begin{align*}
w_{t}+\nabla^{\perp} \psi \cdot \nabla w=0 & \text { in } \quad \mathbb{R}^{2} \times(0, T)  \tag{1.13}\\
-\operatorname{div}(K \nabla \psi)=w & \text { in } \quad \mathbb{R}^{2} \times(0, T)
\end{align*}\right.
$$

where $(a, b)^{\perp}=(b,-a)$ and $K\left(x_{1}, x_{2}\right)$ is the matrix

$$
K\left(x_{1}, x_{2}\right)=\frac{1}{h^{2}+x_{1}^{2}+x_{2}^{2}}\left(\begin{array}{cc}
h^{2}+x_{2}^{2} & -x_{1} x_{2}  \tag{1.14}\\
-x_{1} x_{2} & h^{2}+x_{1}^{2}
\end{array}\right) .
$$

For completeness we prove this fact in Section 2
The proof of Theorems 1 and 2 is reduced to finding solutions of (1.13) concentrated at the vertices of a rotating $k$-regular polygon, which do not change form. We devote the rest of the paper to build such a solution by means of elliptic singular perturbation techniques.

Solutions concentrated near helices in other PDE settings have have been built in 44, 3, 7, 17, 31. Construction of vortex filaments with small vorticities around general sets has been achieved in 11. Connected with Theorem 2, the formal law for the dynamics of nearly parallel interacting filaments in the Euler equation has been found in [21, which is the same law governing almost parallel vortex filaments for the Gross-Pitaevskii equation, see [17. The filaments in Theorem 2 are not nearly parallel. The motion of vortex filaments is the natural generalization of the motion of point vortices for the 2D incompressible Euler equations. Their desingularization has been rigorously analyzed in [24, 27, 28, 30] and [8. Nonlinear stability of point vortices has been recently established in 15 .

## 2. Solutions with helical symmetry

In this section we recall how to find solutions of the incompressible Euler equations in 3d with helical symmetry, following Dutrifoy [10] and Ettinger-Titi [12].

Let $h>0$. We say that a scalar function $f: \mathbb{R}^{3} \rightarrow \mathbb{R}$ has helical symmetry if

f\left(P_{\theta} x^{\prime}, x_{3}+h \theta\right)=f\left(x^{\prime}, x_{3}\right) \quad \text { for all } \quad \theta \in \mathbb{R}, \quad x=\left(x^{\prime}, x_{3}\right) \in \mathbb{R}^{3} \tag{2.1}
\end{equation*}
$$

where $P_{\theta}$ is defined in (1.8). For a scalar function satisfying (2.1) we have $f(x)=$ $f\left(P_{-\frac{x_{3}}{h}} x^{\prime}, 0\right)$, and so $f$ is determined by its values on the horizontal plane

\left\{x=\left(x^{\prime}, x_{3}\right) \mid x_{3}=0\right\} .
$$

Also, if $f$ is $C^{1}$, then $f$ satisfies (2.1) if and only if $\nabla f \cdot \vec{\xi}=0$ where $\vec{\xi}$ is the vector field

\vec{\xi}(x)=\left(-x_{2}, x_{1}, h\right), \quad x=\left(x_{1}, x_{2}, x_{3}\right)
$$

A vector field $F: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ is said to have helical symmetry if

$$
\begin{equation*}
F\left(P_{\theta} x^{\prime}, x_{3}+h \theta\right)=Q_{\theta} F\left(x^{\prime}, x_{3}\right), \quad \forall \theta \in \mathbb{R}, \quad \forall x=\left(x^{\prime}, x_{3}\right) \in \mathbb{R}^{3} \tag{2.2}
\end{equation*}
$$

where $Q_{\theta}$ is the matrix defined in (1.8). If $F$ satisfies (2.2) then

F(x)=R_{\frac{x_{3}}{h}} F\left(P_{-\frac{x_{3}}{h}} x^{\prime}, 0\right),
$$

so that $F$ is determined by its values on the plane $\left\{x=\left(x^{\prime}, x_{3}\right) \mid x_{3}=0\right\}$. Again, if $F=\left(F_{1}, F_{2}, F_{3}\right)$ is $C^{1}$, then it satisfies (2.2) if and only if

\nabla F_{1} \cdot \vec{\xi}=-F_{2}, \quad \nabla F_{2} \cdot \vec{\xi}=F_{1}, \quad \nabla F_{3} \cdot \vec{\xi}=0 \tag{2.3}
\end{equation*}

The following result is a consequence from the analysis in [12].
Lemma 2.1. Suppose that $w\left(x^{\prime}, t\right)$ satisfies the transport equation (1.13). Then there exists a vector field $\mathbf{u}$ with helical symmetry (2.2) such that

\vec{\omega}(x, t)=\frac{1}{h} w\left(P_{-\frac{x_{3}}{h}} x^{\prime}, t\right) \vec{\xi}(x), \quad x=\left(x^{\prime}, x_{3}\right) \tag{2.4}
\end{equation*}
$$

satisfies the Euler equation (1.2).
Proof. We note that the vorticity $\vec{\omega}$ defined by (2.4) has the helical symmetry (2.2). Moreover the scalar function $w$ is satisfies (2.1) and hence $\nabla w \cdot \vec{\xi}=0$.

The velocity vector field $\mathbf{u}$ associated to $\omega$ will be constructed such that it has the helical symmetry (2.2) and satisfies in addition

\end{equation*}

This condition and (2.4) say that $\vec{\omega}$ and $\mathbf{u}$ are always orthogonal.
To construct $\mathbf{u}=\left(u_{1}, u_{2}, u_{3}\right)$, we first define $u_{1}\left(x^{\prime}, 0\right)$, and $u_{2}\left(x^{\prime}, 0\right)$ by the following relation

\binom{u_{1}}{u_{2}}=\frac{1}{h^{2}+x_{1}^{2}+x_{2}^{2}}\left(\begin{array}{cc}
-x_{1} x_{2} & h^{2}+x_{1}^{2}  \tag{2.6}\\
-h^{2}-x_{2}^{2} & x_{1} x_{2}
\end{array}\right)\binom{\partial_{x_{1}} \psi}{\partial_{x_{2}} \psi} .
$$

Next we define $u_{3}\left(x^{\prime}, 0\right)$ using (2.5):

u_{3}=\frac{1}{h}\left(x_{2} u_{1}-x_{1} u_{2}\right) .
$$

In this way $\mathbf{u}\left(x^{\prime}, 0\right)$ is defined for all $x^{\prime} \in \mathbb{R}^{2}$ and then we extend $\mathbf{u}$ to $\mathbb{R}^{3}$ imposing that (2.2) is satisfied.

Let us explain formula (2.6). The incompressibility condition $\nabla \cdot \mathbf{u}=0$ is rewritten as

0=\partial_{x_{1}} u_{1}+\partial_{x_{2}} u_{2}+\partial_{x_{3}} u_{3}=\partial_{x_{1}} u_{1}+\partial_{x_{2}} u_{2}+\frac{y}{h} \partial_{x_{1}} u_{3}-\frac{x}{h} \partial_{x_{2}} u_{3}
$$

where we have used that $-x_{2} u_{1}+x_{1} u_{2}+h u_{3}=0$ (third formula in (2.3)). Then from (2.5) we get

0 & =\partial_{x_{1}} u_{1}+\partial_{x_{2}} u_{2}+\frac{y}{h^{2}} \partial_{x_{1}}\left(x_{2} u_{1}-x_{1} u_{2}\right)-\frac{x}{h^{2}} \partial_{x_{2}}\left(x_{2} u_{1}-x_{1} u_{2}\right) \\
& =\frac{1}{h^{2}} \partial_{x_{1}}\left[\left(h^{2}+x_{2}^{2}\right) u_{1}-x_{1} x_{2} u_{2}\right]+\frac{1}{h^{2}} \partial_{x_{2}}\left[\left(-x_{1} x_{2} u_{1}+\left(h^{2}+x_{1}^{2}\right) u_{2}\right] .\right.
\end{aligned}
$$

This motivates to take $\psi: \mathbb{R}^{2} \rightarrow \mathbb{R}$ such that

$$
\begin{align*}
& \psi_{x_{1}}=\frac{1}{h^{2}}\left[-x_{1} x_{2} u_{1}+\left(h^{2}+x_{1}^{2}\right) u_{2}\right] \\
& \psi_{x_{2}}=-\frac{1}{h^{2}}\left[\left(h^{2}+x_{2}^{2}\right) u_{1}-x_{1} x_{2} u_{2}\right] \tag{2.7}
\end{align*}
$$

This is equivalent to (2.6). Later on we verify that $\psi$ satisfies $-\operatorname{div}(K \nabla \psi)=w$.
We claim that $\omega$, u satisfy the Euler equations (1.2). We check the first equation component by component and on the plane $x_{3}=0$. The equality for all $x_{3}$ follows from the helical symmetry. First we note that

(\vec{\omega} \cdot \nabla) \mathbf{u}=\frac{1}{h} w\left(\begin{array}{r}
-u_{2}  \tag{2.8}\\
u_{1} \\

\end{array}\right)
$$

by the form of $\omega$ in (2.4) and the equations (2.3) satisfied by $\mathbf{u}$. Using (2.7) and (1.13) we get

$$
w_{t}-\frac{1}{h^{2}}\left[-\left(h^{2}+x_{2}^{2}\right) u_{1}+x_{1} x_{2} u_{2}\right] w_{x_{1}}+\frac{1}{h^{2}}\left[-x_{1} x_{2} u_{1}+\left(h^{2}+x_{1}^{2}\right) u_{2}\right] w_{x_{2}}=0
$$

which gives, using that $\nabla w \cdot \vec{\xi}=0$ and $\mathbf{u} \cdot \xi=0$, that

$$
w_{t}+u_{1} w_{x_{1}}+u_{2} w_{x_{2}}+u_{3} w_{x_{3}}=0
$$

By (2.8) this is the third component in the first equation in (1.2). The first and second components are handled similarly.

Next we verify that $\vec{\omega}=$ curl $\mathbf{u}$. Indeed, we look first at the third component of $\operatorname{curl} \mathbf{u}$, which is

\partial_{x_{1}} u_{2}-\partial_{x_{2}} u_{1}= & \partial_{x_{1}}\left[\frac{1}{h^{2}+x_{1}^{2}+x_{2}^{2}}\left(-\left(h^{2}+x_{2}^{2}\right) \psi_{x_{1}}+x_{1} x_{2} \psi_{x_{2}}\right)\right] \\
& -\partial_{x_{2}}\left[\frac{1}{h^{2}+x_{1}^{2}+x_{2}^{2}}\left(-x_{1} x_{2} \psi_{x_{1}}+\left(h^{2}+x_{1}^{2}\right) \psi_{x_{2}}\right)\right] \\
= & -\operatorname{div}(K \nabla \psi) \\
= & w
\end{aligned}
$$

The first and second component of curl $\mathbf{u}$ are computed similarly.

## 3. Equation (1.13) in a rotational frame

To find a solution $\vec{\omega}_{\varepsilon}(x, t)$ as described in Theorem 1 , of the form

$$

we need to find a solution $w\left(x^{\prime}, t\right)$ of (1.13) such that, with the change of variable $t=|\log \varepsilon|^{-1} \tau$, it is concentrated near a single point in the plane that is rotating
with constant speed around the origin. Here $P$ is the matrix defined in (1.8). In terms of $\tau$, equation (1.13) becomes

|\log \varepsilon| w_{\tau}+\nabla^{\perp} \psi \cdot \nabla w=0 & \text { in } \mathbb{R}^{2} \times(-\infty, \infty)  \tag{3.1}\\
-\operatorname{div}(K \nabla \psi)=w & \text { in } \mathbb{R}^{2} \times(-\infty, \infty),
\end{align*}\right.
$$

where $K$ was defined in (1.14).
For notational simplicity, in what follows we will restrict ourselves to the case

$$

Let $\alpha$ be a fixed constant. We look for rotating solutions to problem (3.1) of the form

w\left(x^{\prime}, \tau\right)=W\left(P_{\alpha \tau} x^{\prime}\right), \quad \psi\left(x^{\prime}, \tau\right)=\Psi\left(P_{\alpha \tau} x^{\prime}\right) \tag{3.2}
\end{equation*}

where $P_{\theta}$ is defined in (1.8).
Let $\tilde{x}=P_{\alpha \tau} x^{\prime}$. For the rest of this computation we will denote differential operators with respect to $\tilde{x}$ with a subscript $\tilde{x}$, and differential operators with respect to $x^{\prime}$ without any subscript. In terms of $(W, \Psi)$, the second equation in (3.1) becomes

Let us see how the first equation gets transformed. Observe that

Let $J=P_{\frac{\pi}{2}}$. Since $\nabla \psi^{\perp} \cdot \nabla w=(\nabla w)^{T} J \nabla \psi$, and $P_{\alpha \tau} J P_{\alpha \tau}^{T}=J$, we have

\end{aligned}

We conclude that equation $|\log \varepsilon| w_{\tau}+\nabla^{\perp} \psi \cdot \nabla w=0$ becomes

Now, if $W(\tilde{x})=F\left(\Psi(\tilde{x})-\alpha|\log \varepsilon| \frac{|\tilde{x}|^{2}}{2}\right)$, for some function $F$, then automatically (3.3) holds. We conclude that if $\Psi$ is a solution to

\end{equation*}
$$

for some function $F$, and $W$ is given by

W(\tilde{x})=F\left(\Psi(\tilde{x})-\alpha|\log \varepsilon| \frac{|\tilde{x}|^{2}}{2}\right)
$$

then $(w, \psi)$ defined by (3.2) is a solution for (3.1).
In (3.4) we take

F(s)=\varepsilon^{2} f(s), \quad f(s)=e^{s}
$$

where $\varepsilon>0$. In the sequel we write $\tilde{x}$ as $x=\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}$ and consider the equation

## 4. Construction of an approximate solution

The rest of the paper is devoted to find a solution to

$$
\begin{equation*}
-\nabla \cdot(K \nabla \Psi)=\varepsilon^{2} e^{\left(\Psi-\frac{\alpha}{2}|\log \varepsilon \| x|^{2}\right)} \quad \text { in } \quad \mathbb{R}^{2} \tag{4.1}
\end{equation*}
$$

where $\varepsilon>0$ is small, and such that the solution is concentrated near a fixed point $q_{0}=\left(x_{0}, 0\right)$ with $x_{0}>0$. The parameter $x_{0}$ is fixed and corresponds to $R$ in the definition of the helices (1.7). The number $\alpha$ corresponds to the angular velocity of the rotating solution described in Section 3, and will be adjusted suitably in the course of the proof.

We start with the construction of a global approximate solution to 4.1). Towards this end, consider the change of variables

For a fixed $\delta>0$, we define

\Psi_{1 \varepsilon}(x)=\frac{\alpha}{2}|\log \varepsilon| x_{0}^{2}-\log \left(1+x_{0}^{2}\right)+\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}\right) \tag{4.4}
\end{equation*}
$$

in the region $|z|<\delta$. Here $c_{1}$ is a constant to be determined later on.
For a function $\Psi$, we define the error-function as

\end{equation*}

where

L \Psi=\operatorname{div}(K \nabla \Psi) \tag{4.6}
\end{equation*}

We would like to describe explicitly the error function $S[\Psi]$, for $\Psi=\Psi_{1 \varepsilon}$, in the region $|z|<\delta$. Using the notation $K=\left(\begin{array}{ll}K_{11} & K_{12} \\ K_{12} & K_{22}\end{array}\right)$, we compute in the original variables

\end{aligned}
$$

Letting $r^{2}=|x|^{2}$, we get that

& +\left(\partial_{x_{1}}\left(\frac{1+x_{2}^{2}}{1+r^{2}}\right)-\partial_{x_{2}}\left(\frac{x_{1} x_{2}}{1+r^{2}}\right)\right) \partial_{x_{1}}  \tag{4.7}\\
& +\left(\partial_{x_{2}}\left(\frac{1+x_{1}^{2}}{1+r^{2}}\right)-\partial_{x_{1}}\left(\frac{x_{1} x_{2}}{1+r^{2}}\right)\right) \partial_{x_{2}} .
\end{align*}
$$

Since

\partial_{x_{1}}\left(\frac{1+x_{2}^{2}}{1+r^{2}}\right)-\partial_{x_{2}}\left(\frac{x_{1} x_{2}}{1+r^{2}}\right)=-\frac{x_{1}}{1+r^{2}}\left(\frac{2}{1+r^{2}}+1\right)
$$

and

\partial_{x_{2}}\left(\frac{1+x_{1}^{2}}{1+r^{2}}\right)-\partial_{x_{1}}\left(\frac{x_{1} x_{2}}{1+r^{2}}\right)=-\frac{x_{2}}{1+r^{2}}\left(\frac{2}{1+r^{2}}+1\right)
$$

formula (4.7) simplifies to

$$
\begin{align*}
L & =\frac{1+x_{2}^{2}}{1+r^{2}} \partial_{x_{1} x_{1}}+\frac{1+x_{1}^{2}}{1+r^{2}} \partial_{x_{2} x_{2}}-2 \frac{x_{1} x_{2}}{1+r^{2}} \partial_{x_{1} x_{2}}  \tag{4.8}\\
& -\frac{x_{1}}{1+r^{2}}\left(\frac{2}{1+r^{2}}+1\right) \partial_{x_{1}}-\frac{x_{2}}{1+r^{2}}\left(\frac{2}{1+r^{2}}+1\right) \partial_{x_{2}}
\end{align*}
$$

In the $z$-variable, from (4.8) we read the operator $L$

L=\frac{1}{1+x_{0}^{2}}\left[\partial_{z_{1} z_{1}}+\partial_{z_{2} z_{2}}+B_{0}\right] \tag{4.9}
\end{equation*}

where

B_{0}[\phi]=\partial_{z_{i}}\left(b_{i j}^{0} \partial_{z_{j}} \phi\right), \quad \text { and } \quad b_{i j}^{0}(z)=\left(K_{i j}-\frac{1}{1+x_{0}^{2}} \delta_{i j}\right)
$$

For later purpose, we observe that, in a region where $z$ is bounded, say $|z|<\delta$, for a fixed $\delta$ small, the operator $B_{0}$ has the form

Using (4.9) and the explicit form of the nonlinearity $f$, we obtain the explicit expression for the error function $S[\Psi]$ defined in (4.5) is

& +\varepsilon^{2}\left(1+x_{0}^{2}\right) e^{-\frac{\alpha}{2}|\log \varepsilon| x_{0}^{2}} e^{\Psi} e^{-\frac{\alpha}{2}|\log \varepsilon| \ell_{0}(z)}
\end{aligned}
$$

where $\ell_{0}(z)$ is defined by

\ell_{0}(z)=2 x_{0} z_{1}+z_{1}^{2}+\left(1+x_{0}^{2}\right) z_{2}^{2} . \tag{4.11}
\end{equation*}
$$

Using (4.2) and (4.3), we have that

\left(\partial_{z_{1} z_{1}}+\partial_{z_{2} z_{2}}\right)\left(\Gamma_{\varepsilon}\right)+\varepsilon^{2}\left(1+x_{0}^{2}\right) e^{-\frac{\alpha}{2}|\log \varepsilon| x_{0}^{2}} e^{\Gamma_{\varepsilon}+\frac{\alpha}{2}|\log \varepsilon| x_{0}^{2}-\log \left(1+x_{0}^{2}\right)}=0, \quad \text { in } \quad \mathbb{R}^{2} .
$$

Thus, if for a moment we take

where $\ell_{0}$ is defined in (4.11). Using (4.10), we write $B_{0}\left[\Gamma_{\varepsilon}\right]$ as follows

where $E_{1}$ is a smooth function, uniformly bounded for $\varepsilon$ small, in a bounded region for $z$. The constant $c_{1}$ in (4.4) will be chosen to partially cancel the part of the error
given by $-\frac{2 x_{0}}{1+x_{0}^{2}} z_{1} \partial_{z_{1} z_{1}} \Gamma_{\varepsilon}-2 x_{0} z_{2} \partial_{z_{1} z_{2}} \Gamma_{\varepsilon}-x_{0}\left(1+\frac{2}{1+x_{0}^{2}}\right) \partial_{z_{1}} \Gamma_{\varepsilon}$. Using the explicit expression of $\Gamma_{\varepsilon}$,

\partial_{1} \Gamma_{\varepsilon}(z)=-\frac{4 z_{1}}{\varepsilon^{2}+|z|^{2}}, \quad z_{1} \partial_{11} \Gamma_{\varepsilon}(z)=-\frac{4 z_{1}}{\varepsilon^{2}+|z|^{2}}+\frac{8 z_{1}^{3}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} \\
z_{2} \partial_{12} \Gamma_{\varepsilon}(z)=\frac{8 z_{2}^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}
\end{gathered}
$$

and the identity

$$
z_{1} z_{2}^{2}=\frac{|z|^{2} z_{1}}{4}-\frac{\operatorname{Re}\left(z^{3}\right)}{4}
$$

we obtain

$$
\begin{aligned}
& -\frac{2 x_{0}}{1+x_{0}^{2}} z_{1} \partial_{z_{1} z_{1}} \Gamma_{\varepsilon}-2 x_{0} z_{2} \partial_{z_{1} z_{2}} \Gamma_{\varepsilon}-x_{0}\left(1+\frac{2}{1+x_{0}^{2}}\right) \partial_{z_{1}} \Gamma_{\varepsilon} \\
& \quad=4 x_{0}\left(1+\frac{4}{1+x_{0}^{2}}\right) \frac{z_{1}}{\varepsilon^{2}+|z|^{2}}-4 x_{0}\left(1+\frac{3}{1+x_{0}^{2}}\right) \frac{|z|^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} \frac{\operatorname{Re}\left(z^{3}\right)}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} \\
& \quad=\frac{4 x_{0}}{1+x_{0}^{2}} \frac{z_{1}}{\varepsilon^{2}+|z|^{2}}+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} \frac{\operatorname{Re}\left(z^{3}\right)}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}+\frac{4 x_{0}\left(4+x_{0}^{2}\right)}{1+x_{0}^{2}} \frac{\varepsilon^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}
\end{aligned}
$$

We shall choose the constant $c_{1}$ to eliminate the first term of the last line in the error, using the fact that

We take $c_{1}$ in (4.4) to be

With this choice of $c_{1}$ in the definition of $\Psi_{1 \varepsilon}$ in (4.4), we get

\left(1+x_{0}^{2}\right) S\left[\Psi_{1 \varepsilon}\right](z)= & -\left(8 c_{1}-\frac{4 x_{0}\left(4+x_{0}^{2}\right)}{1+x_{0}^{2}}\right) \frac{\varepsilon^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} \frac{\operatorname{Re}\left(z^{3}\right)}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} \\
& +E_{1}+B_{0}\left[c_{1} z_{1} \Gamma_{\varepsilon}\right] \\
& +\frac{8 \varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}\left[e^{-\frac{\alpha}{2}|\log \varepsilon| \ell_{0}(z)+c_{1} z_{1} \Gamma_{\varepsilon}}-1\right]
\end{aligned}
$$

where $E_{1}$ is the explicit smooth and bounded function, given by (4.12), and $\ell_{0}$ is defined in (4.11). A careful look at $B_{0}\left(c_{1} z_{1} \Gamma_{\varepsilon}\right)$ gives that

B_{0}\left(c_{1} z_{1} \Gamma_{\varepsilon}\right)=-c_{1} x_{0}\left(1+\frac{2}{1+x_{0}^{2}}\right) \Gamma_{\varepsilon}(z)+E_{2}
$$

where $E_{2}$ is smooth in the variable $z$ and uniformly bounded, as $\varepsilon \rightarrow 0$. We conclude that, taking $c_{1}$ in (4.4) as defined in (4.13)

\left(1+x_{0}^{2}\right) S\left[\Psi_{1 \varepsilon}\right](z)=-c_{1} x_{0}\left(1+\frac{2}{1+x_{0}^{2}}\right) \Gamma_{\varepsilon}(z)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} \frac{\operatorname{Re}\left(z^{3}\right)}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} \\
-\left(8 c_{1}-\frac{4 x_{0}\left(4+x_{0}^{2}\right)}{1+x_{0}^{2}}\right) \frac{\varepsilon^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}+E_{1}+E_{2}  \tag{4.14}\\
+\frac{8 \varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}\left[e^{-\frac{\alpha}{2}|\log \varepsilon| \ell_{0}(z)+c_{1} z_{1} \Gamma_{\varepsilon}}-1\right]
\end{gather*}
$$

Observe that the first term in (4.14) has size $|\log \varepsilon|$, while the second term decays, in the expended variable $z=\varepsilon y$, as $\frac{1}{1+|y|}$. We introduce a further modification to our approximate solution $\Psi_{1 \varepsilon}$ in (4.4) to eliminate those two terms in the error.

To eliminate the first term, we let $c_{2}$ be the constant defined by

To correct the second term, we introduce $h_{\varepsilon}(|z|)$ the solution to

defined by

h_{\varepsilon}(s)=s^{3} \int_{s}^{1} \frac{d x}{x^{7}} \int_{0}^{x} \frac{\eta^{7}}{\left(\varepsilon^{2}+\eta^{2}\right)^{2}} d \eta
$$

The function $h_{\varepsilon}$ is smooth and uniformly bounded as $\varepsilon \rightarrow 0$, and $h_{\varepsilon}(s)=O(s)$, as $s \rightarrow 0$. Writing $z=|z| e^{i \theta}$, we have that

H_{1 \varepsilon}(z):=h_{\varepsilon}(|z|) \cos 3 \theta \quad \text { solves } \quad \Delta_{z}\left(H_{1 \varepsilon}\right)+\frac{\operatorname{Re}\left(z^{3}\right)}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}=0 \tag{4.16}

We define the following improved approximation

& +\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)
\end{aligned}
$$

with $H_{1 \varepsilon}$ defined in (4.16) and $c_{2}$ as in (4.15). The new error function becomes

\left(1+x_{0}^{2}\right) S\left[\Psi_{2 \varepsilon}\right](z)= & E_{3}-\left(8 c_{1}-\frac{4 x_{0}\left(4+x_{0}^{2}\right)}{1+x_{0}^{2}}\right) \frac{\varepsilon^{2} z_{1}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} \\
& +\frac{8 \varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}}\left[e^{f_{x_{0}}(z)}-1\right]
\end{aligned}
$$

where

$$
\begin{align*}
f_{x_{0}}(z) & =-\frac{\alpha}{2}|\log \varepsilon| \ell_{0}(z)+\left(c_{1} z_{1}+c_{2}|z|^{2}\right) \Gamma_{\varepsilon}+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z) \\
& =\left(-\alpha x_{0}+4 c_{1}\right)|\log \varepsilon| z_{1}+c_{1} z_{1} \log \frac{8}{\left(1+\left|\frac{z}{\varepsilon}\right|^{2}\right)^{2}}+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)  \tag{4.17}\\
& -\frac{\alpha}{2}|\log \varepsilon|\left(z_{1}^{2}+\left(1+x_{0}^{2}\right) z_{2}^{2}\right)+c_{2}|z|^{2}\left(-4|\log \varepsilon|+\log \frac{8}{\left(1+\left|\frac{z}{\varepsilon}\right|^{2}\right)^{2}}\right)
\end{align*}
$$

with $\ell_{0}$ given by (4.11) and $H_{1 \varepsilon}$ in (4.16). As before, the term $E_{3}$ in (4.14) is a smooth function, which is uniformly bounded as $\varepsilon \rightarrow 0$.

Finally we introduce a global correction to cancel the bounded term $E_{3}$ in the error. Our global final approximation is

\eta_{\delta}(x)=\eta\left(\frac{|z|}{\delta}\right) \tag{4.19}
\end{equation*}
$$

with $\eta$ a fixed smooth function with

$$
\begin{equation*}
\eta(s)=1, \quad \text { for } \quad s \leq \frac{1}{2}, \quad \eta(s)=0, \quad \text { for } \quad s \geq 1 \tag{4.20}
\end{equation*}
$$

Let $g$ be the function with compact support defined by

g(x) & =\eta_{\delta}(x) E_{3}+2 \nabla \eta_{\delta} \nabla\left(\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right) \\
& +\left(\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right) \Delta \eta_{\delta} \\
& +B_{0}\left[\eta_{\delta}\left(\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right)\right] \\
& -\eta_{\delta} B_{0}\left[\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right]
\end{aligned}
$$

It is easy to check that

\|g(x)\|_{L^{\infty}} \leq C_{\delta}
$$

for some positive constant which depends on $\delta$. Proposition 7.1 guarantees the existence of a solution to problem

\Delta H_{2 \varepsilon}+B_{0}\left[H_{2 \varepsilon}\right]+g=0, \quad \text { in } \quad \mathbb{R}^{2}
$$

satisfying

\left|H_{2 \varepsilon}(x)\right| \leq C_{\delta}\left(1+|x|^{2}\right)
$$

The solution is given up to the addition of a constant. We define the function $H_{2 \varepsilon}(x)$ in (4.18) to be the one which furthermore satisfies

With this choice for our final approximation $\Psi_{\alpha}$ in (4.18), the error function takes the form

& +\left(1-\eta_{\delta}\right) \frac{8 \varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} e^{f_{x_{0}}(z)} e^{\left(\eta_{\delta}-1\right)\left(\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right)+H_{2 \varepsilon}} \\
& +\eta_{\delta} \frac{8 \varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} e^{f_{x_{0}}(z)}\left(e^{\left(\eta_{\delta}-1\right)\left(\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)\right)+H_{2 \varepsilon}}-1\right)
\end{aligned}
$$

where $\eta_{\delta}$ is given in (4.19) and $f_{x_{0}}$ in (4.17).
When $1-\eta_{\delta}=0$, it is important to realize that one has

In the complementary region, where $1-\eta_{\delta} \neq 0$, we have that

We conclude that, the error $S\left[\Psi_{\alpha}\right]$ of the approximate solution $\Psi_{\alpha}$ defined in (4.18), can be estimated as follows: in the region $|z|<\delta$ it has the form

& +\frac{\varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} O\left(|z| \log \left(2+\left|\frac{z}{\varepsilon}\right|\right)\right) \tag{4.21}
\end{align*}
$$

and in the region $|z|>\delta$,

\left|\left(1+x_{0}^{2}\right) S\left[\Psi_{\alpha}\right](z)\right| \leq C \frac{\varepsilon^{2}}{\left(\varepsilon^{2}+|z|^{2}\right)^{2}} e^{-|z|^{2}} \tag{4.22}
\end{equation*}
$$

for some constant $C>0$.

## 5. The inner-outer gluing system

We consider the approximate solution $\Psi_{\alpha}(x)$ we have built in Section 4 and look for a solution $\Psi(x)$ of the equation

$$

We look for $\Psi$ of the form

\end{equation*}

Observe that, by construction, the function $\Psi_{\alpha}$ is symmetric with respect to $x_{2}$, in the sense that $\Psi_{\alpha}\left(x_{1}, x_{2}\right)=\Psi_{\alpha}\left(x_{1},-x_{2}\right)$. We thus also ask $\Psi(x)$ to belong to the class of functions that symmetric with respect to $x_{2}$.

Here $\varphi(x)$ is a smaller perturbation of the first approximation, which we choose of the form

\varphi(x)=\eta_{\delta}(x) \phi\left(\frac{z}{\varepsilon}\right)+\psi(x) \tag{5.3}
\end{equation*}
$$

We recall that

with $\eta$ fixed in 4.20). Thus, our aim is to find $\varphi(x)$ so that

\begin{aligned}
E_{\alpha} & =S\left(\Psi_{\alpha}\right) \\
\mathcal{L}_{\Psi_{\alpha}}[\varphi] & =L[\varphi]+\varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right) \varphi \\
N_{\Psi_{\alpha}}(\varphi) & =\varepsilon^{2}\left[f\left(\Psi_{\alpha}-\mu|x|^{2}+\varphi\right)-f\left(\Psi_{\alpha}-\mu|x|^{2}\right)-f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right) \varphi\right]
\end{aligned}
$$

The following expansion holds.

$$
\begin{aligned}
S\left(\Psi_{\alpha}+\varphi\right)= & \eta_{\delta}\left[L_{x}[\phi]+\varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right)(\phi+\psi)+E_{\alpha}+N_{\Psi_{\alpha}}\left(\eta_{\delta} \phi+\psi\right)\right] \\
& +L_{x}[\psi]+\left(1-\eta_{\delta}\right)\left[\varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right) \psi+E_{\alpha}+N_{\Psi_{\alpha}}\left(\eta_{\delta} \phi+\psi\right)\right] \\
& +L_{x}\left[\eta_{\delta}\right] \phi+K_{i j}(x) \partial_{x_{i}} \eta_{\delta} \partial_{x_{j}} \phi .
\end{aligned}
$$

Thus $\Psi$ given by (5.2)-(5.3) solves (5.1) if the pair $(\phi, \psi)$ satisfies the system of equations

$$

L_{x}[\phi]+\varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right)(\phi+\psi)+E_{\alpha}+N_{\Psi_{\alpha}}\left(\eta_{\delta} \phi+\psi\right)=0, \quad|z|<2 \delta \tag{5.4}
\end{equation*}
$$

and

$$
\begin{align*}
L_{x}[\psi] & +\left(1-\eta_{\delta}\right)\left[\varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right) \psi+N_{\Psi_{\alpha}}\left(\eta_{\delta} \phi+\psi\right)+E_{\alpha}\right] \\
& +L_{x}\left[\eta_{\delta}\right] \phi+K_{i j}(x) \partial_{x_{i}} \eta_{\delta} \partial_{x_{j}} \phi=0 \quad \text { in } \mathbb{R}^{2}, \tag{5.5}
\end{align*}
$$

which we respectively call the "inner" and "outer" problems.
Let us write (5.4) in terms of the variable $y=\frac{z}{\varepsilon}$. First we recall that for a function $\varphi=\varphi(z)$ we have

for smooth functions $b_{i j}^{0}(z)$ with $b_{i j}^{0}(0)=0$. Hence for $\phi(y)=\varphi(\varepsilon y)$ we have

We notice that, in terms of the variable $y$ we can write

$$

where

\Gamma_{0}(y)=\log \frac{8}{\left(1+|y|^{2}\right)^{2}}
$$

and $\mathcal{R}(y)$ can be bounded as

At this point we make the following choice for the parameter $\alpha$. We set

\end{equation*}

In the expanded variable $y$ and with this choice of $\alpha$, estimates (4.21) and 4.22) for $E_{\alpha}=S\left[\Psi_{\alpha}\right]$ we obtain, in the region $|y|<\frac{\delta}{\varepsilon}$,

for $a \in(0,1)$. Indeed, we first observe that

\varepsilon^{4}\left(1+x_{0}\right)^{2} f^{\prime}\left(\Psi_{\alpha}(x)-\mu|x|^{2}\right)=e^{\Gamma_{0}(y)} e^{-\varepsilon y_{1}|\log \varepsilon| \alpha_{1} x_{0}+\mathcal{R}(y)}
$$

with $\mathcal{R}$ as in (5.6). For $|y|<\frac{1}{\varepsilon \mid \log \varepsilon}$ we can expand

e^{-\varepsilon y_{1}|\log \varepsilon| \alpha_{1} x_{0}+\mathcal{R}(y)}=\left(1-\varepsilon y_{1}|\log \varepsilon| \alpha_{1} x_{0}+O\left(\varepsilon|y| \log (2+|y|)+\varepsilon^{2} \alpha_{1}^{2}|y|^{2} \log ^{2} \varepsilon\right) .\right.
$$

Hence

\varepsilon^{4}\left(1+x_{0}\right)^{2} f^{\prime}\left(\Psi_{\alpha}(x)-\mu|x|^{2}\right)=e^{\Gamma_{0}}+b_{0}(y), \quad \text { with } \\
b_{0}(y)=e^{\Gamma_{0}}\left(-\varepsilon y_{1}|\log \varepsilon| \alpha_{1} x_{0}\right)+O\left(\frac{\varepsilon}{1+|y|^{3}} \log (2+|y|)\right) .
\end{array}
$$

For $\frac{1}{\varepsilon|\log \varepsilon|}<|y|<\frac{\delta}{\varepsilon}$ we have

$$
\varepsilon^{4}\left(1+x_{0}\right)^{2} f^{\prime}\left(\Psi_{\alpha}(x)-\mu|x|^{2}\right)=e^{\Gamma_{0}(y)} \varepsilon^{-c \delta}=O\left(\frac{\varepsilon}{1+|y|^{3-a}}\right)
$$

for some small $0<a<1$. Hence we globally have

\varepsilon^{4}\left(1+x_{0}\right)^{2} f^{\prime}\left(\Psi_{\alpha}(x)-\mu|x|^{2}\right)=e^{\Gamma_{0}(y)}+b_{0}(y)
$$

where

$$
\begin{equation*}
b_{0}(y)=-\frac{8 \alpha_{1} \varepsilon y_{1}|\log \varepsilon|}{\left(1+|y|^{2}\right)^{2}}+O\left(\frac{\varepsilon}{1+|y|^{3-a}}\right) \tag{5.9}
\end{equation*}
$$

Expansion (5.8) readily follows. Similarly, for $b_{0}$ of this type we get the expansion

\mathcal{N}(\varphi):=\varepsilon^{2}\left(1+x_{0}\right)^{2} N_{\Psi_{\alpha}}(\varphi)=\left(e^{\Gamma_{0}(y)}+b_{0}\right)\left(e^{\varphi}-1-\varphi\right) \tag{5.10}
\end{equation*}
$$

Then, the inner problem (5.4) becomes

\Delta_{y} \phi+f^{\prime}\left(\Gamma_{0}\right) \phi+B[\phi]+\mathcal{N}\left(\psi+\eta_{\delta} \phi\right)+\tilde{E}_{\alpha}+\left(f^{\prime}\left(\Gamma_{0}\right)+b_{0}\right) \psi=0 \quad \text { in } B_{R} \tag{5.11}
\end{equation*}
$$

where $R=\frac{2 \delta}{\varepsilon}$ and

$$
\begin{equation*}
B[\phi]=\partial_{y_{i}}\left(b_{i j}^{0}(\varepsilon y) \partial_{j} \phi\right)+b_{0}(y) \phi \tag{5.12}
\end{equation*}
$$

The idea is to solve this equation, coupled with the outer problem (5.5) in such a way that $\phi$ has the size of the error $\tilde{E}_{\alpha}$ with two powers less of decay in $y$, say

$$
(1+|y|)\left|D_{y} \phi(y)\right|+|\phi(y)| \leq \frac{C \varepsilon|\log \varepsilon|}{1+|y|^{1-a}}
$$

We write the outer problem as

L_{x}[\psi]+G(\psi, \phi, \alpha)=0 \quad \text { in } \mathbb{R}^{2} \tag{5.13}
\end{equation*}
$$

where

$$
\begin{equation*}
G(\psi, \phi, \alpha)=V(x) \psi+N\left(\eta_{\delta} \phi+\psi\right)+E^{o}(x)+A[\phi] \tag{5.14}
\end{equation*}
$$

with

$$
\begin{aligned}
V(x) & =\left(1-\eta_{\delta}\right) \varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right) \\
N(\varphi) & =\left(1-\eta_{\delta}\right) N_{\Psi_{\alpha}}(\varphi) \\
E^{o}(x) & =\left(1-\eta_{\delta}\right) E_{\alpha} \\
A[\phi] & =L_{x}\left[\eta_{\delta}\right] \phi+K_{i j}(x) \partial_{x_{i}} \eta_{\delta} \partial_{x_{j}} \phi
\end{aligned}
$$

We observe that for $|z|>\frac{\delta}{2}$ we have

\Psi_{\alpha}(x)-\frac{\alpha}{2}\left|\operatorname { l o g } \varepsilon \left\|\left.x\right|^{2}=O(1)+\frac{\alpha}{2}\left|\operatorname { l o g } \varepsilon \left\|\left.x_{0}\right|^{2}-\frac{\alpha}{2}|\log \varepsilon \| x|^{2}\right.\right.\right.\right.
$$

An important point is that from the choice of $\alpha$ in (5.7) we have that

\frac{\alpha}{2}\left|x_{0}\right|^{2}<\frac{x_{0}^{2}+\sigma^{\prime}}{1+x_{0}^{2}}
$$

for some $\sigma^{\prime}>0$ arbitrarily small. It follows that there exists $0<b<1, b=\frac{1-\sigma^{\prime}}{1+x_{0}^{2}}$ which depends on $x_{0}$,

\varepsilon^{2} \exp \left(\Psi_{\alpha}(x)-\frac{\alpha}{2}|\log \varepsilon \| x|^{2}\right)=O\left(\varepsilon^{1+b} e^{-|\log \varepsilon \| x|^{2}}\right)

Hence the following bounds hold.

\left|N\left(\eta_{\delta} \phi+\psi\right)\right| & \leq \varepsilon^{1+b} e^{-|x|^{2}}\left(|\phi|^{2} \eta_{\delta}^{2}+|\psi|^{2}\right)  \tag{5.15}\\
\left|E_{\alpha}^{o}(x)\right| & \leq \varepsilon^{1+b} e^{-|x|^{2}}
\end{align*}
$$

In the next two sections we will establish linear results that are the basic tools to solve system (5.11)-(5.13) by means of a fixed point scheme.

## 6. Linerized inner problem

In this section we consider the problem

$$

\end{equation*}

We want to solve this problem in a topology of decaying functions in Hölder sense. For numbers $m>2,0<\alpha<1$ we consider the following norms

\end{align*}
$$

where we use the standard notation

[h]_{A, \alpha}=\sup _{z_{1}, z_{2} \in A} \frac{\left|h\left(z_{1}\right)-h\left(z_{2}\right)\right|}{\left|z_{1}-z_{2}\right|^{\alpha}}
$$

We consider the functions $Z_{i}(y)$ defined as

Z_{i}(y)=\partial_{y_{i}} \Gamma_{0}(y)=-4 \frac{y_{i}}{|y|^{2}+1}, \quad i=1,2, \quad Z_{0}(y)=2+y \cdot \nabla \Gamma_{0}(y)=2 \frac{1-2|y|^{2}}{|y|^{2}+1}
$$

Lemma 6.1. Given $m>2$ and $0<\alpha<1$, there exists a $C>0$ and a solution $\phi=\mathcal{T}[h]$ of problem (6.1) for each $h$ with $\|h\|_{m}<+\infty$ that defines a linear operator of $h$ and satisfies the estimate

$$
\begin{align*}
& (1+|y|)|\nabla \phi(y)|+|\phi(y)| \\
& \leq C\left[\log (2+|y|)\left|\int_{\mathbb{R}^{2}} h Z_{0}\right|+(1+|y|) \sum_{i=1}^{2}\left|\int_{\mathbb{R}^{2}} h Z_{i}\right|+(1+|y|)^{2-m}\|h\|_{m}\right] \tag{6.3}
\end{align*}
$$

In addition, if $\|h\|_{m, \alpha}<+\infty$, we have

$$
\begin{align*}
& \left(1+|y|^{2+\alpha}\right)\left[D_{y}^{2} \phi\right]_{B_{1}(y), \alpha}+\left(1+|y|^{2}\right)\left|D_{y}^{2} \phi(y)\right| \\
& \leq C\left[\log (2+|y|)\left|\int_{\mathbb{R}^{2}} h Z_{0}\right|+(1+|y|) \sum_{i=1}^{2}\left|\int_{\mathbb{R}^{2}} h Z_{i}\right|+(1+|y|)^{2-m}\|h\|_{m, \alpha}\right] \tag{6.4}
\end{align*}
$$

Proof. The existence of this inverse is essentially known, we provide a proof. We assume that $h$ is complex-valued. Setting $y=r e^{i \theta}$. We write

$$
h(y)=\sum_{k=-\infty}^{\infty} h_{k}(r) e^{i k \theta}, \quad \phi(y)=\sum_{k=-\infty}^{\infty} \phi_{k}(r) e^{i k \theta}
$$

The equation is equivalent to

$$
\begin{equation*}
\mathcal{L}_{k}\left[\phi_{k}\right]+h_{k}(r)=0, \quad r \in(0, \infty) \tag{6.5}
\end{equation*}
$$

where

$$
\mathcal{L}_{k}\left[\phi_{k}\right]=\phi_{k}^{\prime \prime}+\frac{1}{r} \phi_{k}^{\prime}+e^{\Gamma_{0}} \phi_{k}-\frac{k^{2}}{r^{2}} \phi_{k}
$$

Using the formula of variation of parameters, the following formula (continuously extended to $r=\frac{1}{\sqrt{2}}$ defines a smooth solution of (6.5) for $k=0$ :

$$
\phi_{0}(r)=-z(r) \int_{\frac{1}{\sqrt{2}}}^{r} \frac{d s}{s z(s)^{2}} \int_{0}^{s} h_{0}(\rho) z(\rho) \rho d s, \quad z(r)=\frac{2 r^{2}-1}{1+r^{2}}
$$

Noting that $\int_{0}^{\infty} h_{0}(\rho) z(\rho) \rho d s=\frac{1}{2 \pi} \int_{\mathbb{R}^{2}} h(y) Z_{0}(y) d y$ we see that this function satisfies

$$
\left|\phi_{0}(r)\right| \leq C\left[\log (2+r)\left|\int_{\mathbb{R}^{2}} h(y) Z_{0}(y) d y\right|+(1+r)^{2-m}\|h\|_{m}\right]
$$

Now we observe that

$$
\phi_{k}(r)=-z(r) \int_{0}^{r} \frac{d s}{s z(s)^{2}} \int_{0}^{s} h_{k}(\rho) z(\rho) \rho d s, \quad z(r)=\frac{4 r}{1+r^{2}}
$$

solves (6.5) for $k=-1,1$ and satisfies

$$
\left|\phi_{k}(r)\right| \leq C\left[(1+r) \sum_{j=1}^{2}\left|\int_{\mathbb{R}^{2}} h(y) Z_{j}(y) d y\right|+(1+r)^{2-m}\|h\|_{m}\right]
$$

For $k=2$ there is a function $z(r)$ such that $\mathcal{L}_{2}[z]=0, z(r) \sim r^{2}$ as $r \rightarrow 0$ and as $r \rightarrow \infty$. For $|k| \geq 2$ we have that

$$
\bar{\phi}_{k}(r)=\frac{4}{k^{2}} z(r) \int_{0}^{r} \frac{d s}{s z(s)^{2}} \int_{0}^{s}\left|h_{k}(\rho)\right| z(\rho) \rho d s
$$

is a positive supersolution for equation (6.5), hence the equation has a unique solution $\phi_{k}$ with $\left|\phi_{k}(r)\right| \leq \bar{\phi}_{k}(r)$. Thus

$$
\left|\phi_{k}(r)\right| \leq \frac{C}{k^{2}}(1+r)^{2-m}\|h\|_{m}, \quad|k| \geq 2 .
$$

Thus, for the functions $\phi_{k}$ defined

$$
\phi(y)=\sum_{k=-\infty}^{\infty} \phi_{k}(r) e^{i k \theta}
$$

defines a linear operator of functions $h$ which is a solution of equation (6.1) which, adding up the individual estimates above, it satisfies the estimate

$$
\begin{equation*}
|\phi(y)| \leq C\left[\log (2+|y|)\left|\int_{\mathbb{R}^{2}} h Z_{0}\right|+(1+|y|) \sum_{i=1}^{2}\left|\int_{\mathbb{R}^{2}} h Z_{i}\right|+(1+|y|)^{2-m}\|h\|_{m}\right] \tag{6.6}
\end{equation*}
$$

As a corollary we find that similar bounds are obtained for first and second derivatives. In fact, let us set for a large $y=R e, R=|y| \gg 1, \phi_{R}(z)=R^{m-2} \phi(R(e+z))$. Then we find

$$
\Delta_{z} \phi_{R}+R^{-2} W(R(e+z)) \phi_{R}+h_{R}(z)=0, \quad|z|<\frac{1}{2}
$$

where $h_{R}(z)=R^{-m} h(R(e+z))$. Let us set,

$$
\delta_{i}=\left|\int_{\mathbb{R}^{2}} h Z_{i}\right|, \quad i=0,1,2
$$

Then from (6.6), and a standard elliptic estimate we find

$$
\left\|\nabla_{z} \phi_{R}\right\|_{L^{\infty}\left(B_{\frac{1}{4}}(0)\right)}+\left\|\phi_{R}\right\|_{L^{\infty}\left(B_{\frac{1}{2}}(0)\right)} \leq C\left[\delta_{0} \log R+\sum_{i=1}^{2} \delta_{i} R+\|h\|_{m}\right]
$$

Clearly we have

$$
\left\|h_{R}\right\|_{L^{\infty}\left(B_{\frac{1}{2}}(0)\right)} \leq C\|h\|_{m}, \quad\left[h_{R}\right]_{B_{\frac{1}{2}}(0)} \leq C\|h\|_{m, \alpha}
$$

From interior Schauder estimates and the bound for $\phi_{R}$ we then find

$$
\left\|D_{z}^{2} \phi_{R}\right\|_{L^{\infty}\left(B_{\frac{1}{4}}(0)\right)}+\left[D_{z}^{2} \phi_{R}\right]_{B_{\frac{1}{4}}(0), \alpha} \leq C\left[\delta_{0} \log R+\sum_{i=1}^{2} \delta_{i} R+\|h\|_{m, \alpha}\right]
$$

From these relations, estimates (6.3) and (6.4) follow.
We consider now the problem for a fixed number $\delta>0$ and a sufficiently large $R>0$ we consider the equation

$$
\begin{equation*}
\Delta \phi+e^{\Gamma_{0}} \phi+B[\phi]+h(y)=\sum_{j=0}^{2} c_{i} e^{\Gamma_{0}} Z_{i} \quad \text { in } B_{R} \tag{6.7}
\end{equation*}
$$

where $c_{i}$ are real numbers,

$$
\begin{equation*}
B[\phi]=\partial_{i}\left(b_{i j}(y) \partial_{j} \phi\right)+b_{0}(y) \phi \tag{6.8}
\end{equation*}
$$

and the coefficients satisfy the bounds

$$
\begin{align*}
& (1+|y|)^{-1}\left|b_{i j}(y)\right|+\left|D_{y} b_{i j}(y)\right| \\
+ & (1+|y|)^{2}\left|b_{0}(y)\right|+(1+|y|)^{3}\left|D_{y} b_{0}(y)\right|  \tag{6.9}\\
\leq & \delta R^{-1} \text { in } B_{R}
\end{align*}
$$

For a function $h$ defined in $A \subset \mathbb{R}^{2}$ we denote by $\|h\|_{m, \alpha, A}$ the numbers defined in (6.2) but with the sup taken with elements in $A$ only, namely
$\left.\|h\|_{m, A}=\sup _{y \in A}\left|(1+|y|)^{m} h(y)\right|\right], \quad\|h\|_{m, \alpha, A}=\sup _{y \in A}(1+|y|)^{m+\alpha}[h]_{B(y, 1) \cap A}+\|h\|_{m, A}$
Let us also define, for a function of class $C^{2, \alpha}(A)$,

$$
\begin{equation*}
\|\phi\|_{*, m-2, A}=\left\|D^{2} \phi\right\|_{m, \alpha, A}+\|D \phi\|_{m-1, A}+\|D \phi\|_{m-2, A} \tag{6.10}
\end{equation*}
$$

In this notation we omit the dependence on $A$ when $A=\mathbb{R}^{2}$. The following is the main result of this section.

Proposition 6.1. There are numbers $\delta, C>0$ such that for all sufficiently large $R$ and any differential operator $B$ as in (6.8) with bounds (6.9), Problem (6.7) has a solution $\phi=T[h]$ for certain scalars $c_{i}=c_{i}[h]$, that defines a linear operator of $h$ and satisfies

$$
\|\phi\|_{*, m-2, B_{R}} \leq C\|h\|_{m, \alpha, B_{R}}
$$

In addition, the linear functionals $c_{i}$ can be estimated as

$$
\begin{aligned}
& c_{0}[h]=\gamma_{0} \int_{B_{R}} h Z_{0}+O\left(R^{2-m}\right)\|h\|_{m, \alpha, B_{R}}, \\
& c_{i}[h]=\gamma_{i} \int_{B_{R}} h Z_{i}+O\left(R^{1-m}\right)\|h\|_{m, \alpha, B_{R}}, \quad i=1,2
\end{aligned}
$$

where $\gamma_{i}^{-1}=\int_{\mathbb{R}^{2}} e^{\Gamma_{0}} Z_{i}^{2}, i=0,1,2$.

Proof. We consider a standard linear extension operator $h \mapsto \tilde{h}$ to entire $\mathbb{R}^{2}$, in such a way that the support of $\tilde{h}$ is contained in $B_{2 R}$ and $\|\tilde{h}\|_{m, \alpha} \leq C\|h\|_{m, \alpha, B_{R}}$ with $C$ independent of all large $R$. In a similar way, we assume with no loss of generality that the coefficients of $B$ are of class $C^{1}$ in entire $\mathbb{R}^{2}$, have compact support in $B_{2 R}$ and globally satisfy bounds (6.9). Then we consider the auxiliary problem in entire space

$$
\begin{equation*}
\Delta \phi+e^{\Gamma_{0}} \phi+B[\phi]+\tilde{h}(y)=\sum_{j=0}^{2} c_{i} e^{\Gamma_{0}} Z_{i} \quad \text { in } \mathbb{R}^{2} \tag{6.11}
\end{equation*}
$$

where, assuming that $\|h\|_{m}<+\infty$ and $\phi$ is of class $C^{2}, c_{i}=c_{i}[h, \phi]$ are the scalars defined as so that

$$
\gamma_{i} \int_{\mathbb{R}^{2}}(B[\phi]+\tilde{h}(y)) Z_{i}=c_{i}, \quad \gamma_{i}^{-1}=\int_{\mathbb{R}^{2}} e^{\Gamma_{0}} Z_{i}^{2}
$$

For a function $\phi$ of class $C^{2, \alpha}\left(\mathbb{R}^{2}\right)$ we define

$$
\|\phi\|_{*, m-2, \alpha}=\left\|D_{y}^{2} \phi\right\|_{m, \alpha}+\left\|D_{y} \phi\right\|_{m-1}+\|\phi\|_{m-2}
$$

Since $B\left[Z_{i}\right]=O\left((1+|y|)^{-2}\right)$ and $\int_{\mathbb{R}^{2}} \frac{d y}{1+|y|^{m}}<+\infty$ we get

$$
\int_{\mathbb{R}^{2}} B[\phi] Z_{i}=\int_{\mathbb{R}^{2}} \phi B\left[Z_{i}\right]=O\left(\|\phi\|_{m-2}\right) R^{-1}
$$

In addition, we readily check that

$$
\|B[\phi]\|_{m, \alpha} \leq C \delta\|\phi\|_{*, m-2, \alpha}
$$

Let us consider the Banach space $X$ of all $C^{2, \alpha}\left(\mathbb{R}^{2}\right)$ functions with $\|\phi\|_{*, m-2, \alpha}<$ $+\infty$. We find a solution of (6.11) if we solve the equation

$$
\begin{equation*}
\phi=\mathcal{A}[\phi]+\mathcal{H}, \quad \phi \in X \tag{6.12}
\end{equation*}
$$

where

$$
\mathcal{A}[\phi]=\mathcal{T}\left[B[\phi]-\sum_{i=0}^{2} c_{i}[0, \phi] e^{\Gamma_{0}} Z_{i}\right], \quad \mathcal{H}=\mathcal{T}\left[\tilde{h}-\sum_{i=0}^{2} c_{i}[\tilde{h}, 0] e^{\Gamma_{0}} Z_{i}\right]
$$

and $\mathcal{T}$ is the operator built in Lemma 6.1. We observe that

$$
\|\mathcal{A}[\phi]\|_{*, m-2, \alpha} \leq C \delta\|\phi\|_{*, m-2, \alpha}, \quad\|\mathcal{H}\|_{*, m-2, \alpha} \leq C\|h\|_{m, \alpha, B_{R}}
$$

Fixing $\delta$ so that $\delta C<1$, we find that Equation (6.12) has a unique solution, that defines a linear operator of $h$, and satisfies

$$
\|\phi\|_{*, m-2, \alpha} \leq C\|h\|_{m, \alpha, B_{R}}
$$

The result of the proposition follows by just setting $T[h]=\left.\phi\right|_{B_{R}}$. The proof is concluded.

## 7. The linear outer problem

Let us recall $L$ defined by (4.6)

$$
L[\psi]=\operatorname{div}(K \nabla \psi)
$$

where $K=K\left(x_{1}, x_{2}\right)$ is the matrix

$$
K\left(x_{1}, x_{2}\right)=\frac{1}{1+x_{1}^{2}+x_{2}^{2}}\left(\begin{array}{ll}
1+x_{2}^{2} & -x_{1} x_{2} \\
-x_{1} x_{2} & 1+x_{1}^{2}
\end{array}\right)
$$

that is, the same matrix (1.14) with $h=1$.
In this section we consider the Poisson equation for the operator $L$

$$
\begin{equation*}
L[\psi]+g(x)=0 \quad \text { in } \mathbb{R}^{2} \tag{7.1}
\end{equation*}
$$

for a bounded function $g$.
It is sufficient to restrict our attention to the case of functions $g(x)$ that satisfy the decay condition

$$
\|g\|_{\nu}:=\sup _{x \in \mathbb{R}^{2}}(1+|x|)^{\nu}|g(x)|<+\infty
$$

where $\nu>2$. We have the validity of the following result
Proposition 7.1. There exists a solution $\psi(x)$ to problem (7.1), which is of class $C^{1, \alpha}\left(\mathbb{R}^{2}\right)$ for any $0<\alpha<1$, that defines a linear operator $\psi=\mathcal{T}^{o}(g)$ of $g$ and satisfies the bound

$$
\begin{equation*}
|\psi(x)| \leq C\|g\|_{\nu}\left(1+|x|^{2}\right) \tag{7.2}
\end{equation*}
$$

for some positive constant $C$.
Proof. To solve Equation (7.1) we decompose $g$ and $\psi$ into Fourier modes as

$$
g(x)=\sum_{j=-\infty}^{\infty} g_{j}(r) e^{j i \theta}, \quad \psi(x)=\sum_{j=-\infty}^{\infty} \psi_{j}(r) e^{j i \theta}, \quad x=r e^{i \theta}
$$

It is useful to derive an expression of the operator $L[\psi]$ expressed in polar coordinates. With some abuse of notation we write $\psi(r, \theta)=\psi(x)$ with $x=r e^{i \theta}$. The following expression holds:

$$
\begin{equation*}
L[\psi]=\frac{1}{1+r^{2}}\left(\frac{1}{r^{2}}+1\right) \partial_{\theta}^{2} \psi+\frac{1}{r} \partial_{r}\left(\frac{r}{1+r^{2}} \partial_{r} \psi\right) \tag{7.3}
\end{equation*}
$$

To prove this, recall that for a vector field $\vec{F}=F_{r} \hat{r}+F_{\theta} \hat{\theta}$ where

$$
\hat{r}=\frac{1}{r}\left(x_{1}, x_{2}\right), \quad \hat{\theta}=\frac{1}{r}\left(-x_{2}, x_{1}\right)
$$

we have

$$
\operatorname{div}(\vec{F})=\frac{1}{r} \partial_{r}\left(r F^{r}\right)+\frac{1}{r} \partial_{\theta} F^{\theta}, \quad \nabla \psi=\psi_{r} \hat{r}+\frac{\psi_{\theta}}{r} \hat{\theta}
$$

Then

$$
\begin{aligned}
L[\psi] & =\operatorname{div}(K \nabla \psi)=\operatorname{div}\left(\frac{1}{1+x_{1}^{2}+y_{1}^{2}}\left(\begin{array}{cc}
\kappa^{2}+x_{2}^{2} & -x_{1} x_{2} \\
-x_{1} x_{2} & \kappa^{2}+x_{1}^{2}
\end{array}\right) \nabla \psi\right) \\
& =\operatorname{div}\left(\frac{1}{1+x_{1}^{2}+x_{2}^{2}}\left(\begin{array}{cc}
x_{2}^{2} & -x_{1} x_{2} \\
-x_{1} x_{2} & x_{1}^{2}
\end{array}\right) \nabla \psi\right)+\operatorname{div}\left(\frac{1}{1+x_{1}^{2}+x_{2}^{2}} \nabla \psi\right) \\
& =L_{1}[\psi]+L_{2}[\psi] .
\end{aligned}
$$

Using the polar coordinates formalism, we get

$$
\begin{aligned}
L_{1}[\psi] & =\operatorname{div}\left(\frac{r^{2}}{1+r^{2}}\left[\begin{array}{cc}
\sin ^{2} \theta & -\sin \theta \cos \theta \\
-\sin \theta \cos \theta & \cos ^{2} \theta
\end{array}\right]\left(\psi_{r} \hat{r}+\frac{\psi_{\theta}}{r} \hat{\theta}\right)\right) \\
& =\operatorname{div}\left(\frac{r^{2}}{1+r^{2}}\left[\begin{array}{c}
-\sin \theta \hat{\theta}^{T} \\
\cos \theta \hat{\theta}^{T}
\end{array}\right]\left(\psi_{r} \hat{r}+\frac{\psi_{\theta}}{r} \hat{\theta}\right)\right) \\
& =\operatorname{div}\left(\psi_{\theta} \frac{r}{1+r^{2}} \hat{\theta}\right)=\frac{1}{1+r^{2}} \psi_{\theta \theta} .
\end{aligned}
$$

Similarly,

$$
L_{2}[\psi]=\frac{1}{r}\left(\frac{r}{r^{2}+1} \psi_{r}\right)_{r}+\frac{1}{1+r^{2}} \frac{\psi_{\theta \theta}}{r^{2}}
$$

Combining the above relations, expression (7.3) follows. A nice feature of this operator is that it decouples the Fourier modes. In fact, equation (7.1) becomes equivalent to the following infinite set of ODEs:

$$
\begin{align*}
& L_{k}\left[\psi_{k}\right]+g_{k}(r)=0, \quad r \in(0, \infty), \\
& L_{k}\left[\psi_{k}\right]:=\frac{1}{r}\left(\frac{r}{r^{2}+1} \psi_{k}^{\prime}\right)^{\prime}-\frac{k^{2}}{1+r^{2}}\left(\frac{1}{r^{2}}+1\right) \psi_{k}, \quad k \in \mathbb{Z} \tag{7.4}
\end{align*}
$$

The operator $L_{k}$ when $r \rightarrow 0$ or $r \rightarrow+\infty$ resembles

$$
\begin{aligned}
& L_{k}[p] \sim \frac{1}{r}\left(r p^{\prime}\right)-\frac{k^{2} p}{r^{2}} \quad \text { as } \quad r \rightarrow 0 \\
& L_{k}[p] \sim \frac{1}{r}\left(\frac{1}{r} p^{\prime}\right)-\frac{k^{2} p}{r^{2}} \quad \text { as } \quad r \rightarrow+\infty
\end{aligned}
$$

For $k \geq 1$, thanks to the maximum principle, this implies that the existence of a positive function $z_{k}(r)$ with $L_{k}\left[z_{k}\right]=0$ with

$$
\begin{array}{r}
z_{k}(r) \sim r^{k} \quad \text { as } \quad r \rightarrow 0 \\
z_{k}(r) \sim r^{\frac{1}{2}} e^{k r} \quad \text { as } \quad r \rightarrow+\infty
\end{array}
$$

Let us consider the equation (for a barrier) for $k=1$,

$$
L_{1}[\bar{\psi}]+\frac{1}{1+r^{\nu}}=0
$$

A solution of this equation is given by

$$
\bar{\psi}(r)=z_{1}(r) \int_{r}^{\infty} \frac{d s}{s z_{1}(s)^{2}} \int_{0}^{s} \frac{1}{1+\rho^{\nu}} z_{1}(\rho) \rho d \rho
$$

and we have

$$
\begin{gathered}
\bar{\psi}(r)=O\left(r^{2}\right) \quad \text { as } \quad r \rightarrow 0 \\
\bar{\psi}(r)=O\left(r^{\nu-2}\right) \quad \text { as } \quad r \rightarrow+\infty
\end{gathered}
$$

We also observe that for $k \geq 2$ this function works as a barrier. In fact we have

$$
\left|g_{k}(r)\right| \leq \frac{\|g\|_{\nu}}{1+r^{\nu}}
$$

hence (7.4) for $|k| \geq 2$ admits as a positive barrier. Using the maximum principle, the function

$$
\psi_{k}(r)=z_{k}(r) \int_{r}^{\infty} \frac{d s}{s z_{k}(s)^{2}} \int_{0}^{s} h_{k}(\rho) z_{k}(\rho) \rho d \rho
$$

which is the unique decaying solution (7.4), satisfies the estimate

$$
\left|\psi_{k}(r)\right| \leq \frac{4}{k^{2}}\|g\|_{\nu} \bar{\psi}(r)
$$

Finally, let us consider the case $k=0$. In that case, the following explicit formula yields a solution

$$
\psi_{0}(r)=-\int_{0}^{r} \frac{1+s^{2}}{h^{2} s} d s \int_{0}^{s} g_{0}(\rho) \rho d \rho
$$

In this case we get the bound

$$
\left|\psi_{0}(r)\right| \leq C\|g\|_{\nu}\left(1+r^{2}\right)
$$

The function

$$
\psi(x):=\sum_{j=-\infty}^{\infty} \psi_{j}(r) e^{j i \theta}
$$

with the $\psi_{k}$ being the functions built above, clearly defines a linear operator of $g$ and satisfies estimate (7.2). The proof is concluded.

## 8. Solving the inner-OUTER GLUING System

In this section we will formulate System (5.11)-(5.13) (for an appropriate value of the parameter $\alpha$ in (5.7)) in a fixed point formulation that involves the linear operators defined in the previous sections.

We let $X^{o}$ be the Banach space of all functions $\psi \in C^{2, \alpha}\left(\mathbb{R}^{2}\right)$ such that

$$
\|\psi\|<+\infty
$$

and formulate the outer equation (5.13) as the fixed point problem in $X^{o}$,

$$
\psi=\mathcal{T}^{o}[G(\psi, \phi, \alpha)], \quad \psi \in X^{o}
$$

where $\mathcal{T}^{o}$ is defined in Proposition (7.1, while $G$ is the operator given by (5.14). We decompose the inner problem (5.11) as follows: consider

$$
\Delta_{y} \phi+f^{\prime}\left(\Gamma_{0}\right) \phi+B[\phi]+H(\phi, \psi, \alpha)=0 \quad \text { in } B_{R}
$$

where $R=\frac{2 \delta}{\varepsilon}$ and

$$
H(\phi, \psi, \alpha)=\mathcal{N}\left(\psi+\eta_{\delta} \phi\right)+\tilde{E}_{\alpha}+\left(f^{\prime}\left(\Gamma_{0}\right)+b_{0}\right) \psi
$$

Let $X_{*}$ be the Banach space of functions $\phi \in C^{2, \alpha}\left(B_{R}\right)$ such that

\|\phi\|_{*, m-2, B_{R}}<\infty
$$

(see 6.10)). We introduce constants $c_{i}$

$$
\begin{equation*}
\Delta_{y} \phi_{1}+f^{\prime}\left(\Gamma_{0}\right) \phi_{1}+B\left[\phi_{1}\right]+B\left[\phi_{2}\right]+H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)-\sum_{i=0}^{2} c_{i} e^{\Gamma_{0}} Z_{i}=0 \quad \text { in } B_{R} \tag{8.1}
\end{equation*}
$$

and formulate this problem using the operator $T$ in Proposition 6.1 with $c_{i}=$ $c_{i}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right], i=0,1,2$, and $\phi_{1} \in X_{*}$

\phi_{1}=T\left(H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left[\phi_{2}\right]\right)
$$

and we require that $\phi_{2}$ solves

\Delta_{y} \phi_{2}+f^{\prime}\left(\Gamma_{0}\right) \phi_{2}+c_{0} e^{\Gamma_{0}} Z_{0}=0 \quad \text { in } \mathbb{R}^{2} .
$$

We solve Problem (8.2) by using the operator $\mathcal{T}$ in Lemma 6.1 We write

\phi_{2}=\mathcal{T}\left[c_{0}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right] e^{\Gamma_{0}} Z_{0}\right] \tag{8.2}
\end{equation*}
$$

Having in mind the a-priori bound in (6.3), (6.4) in Lemma 6.1) it is natural to ask that $\phi_{2} \in C^{2, \alpha}$,

\begin{aligned}
\left(1+|y|^{2+\alpha}\right)\left[D_{y}^{2} \phi\right]_{B_{1}(y), \alpha} & +\left(1+|y|^{2}\right)\left|D_{y}^{2} \phi(y)\right|+(1+|y|)|\nabla \phi(y)|+|\phi(y)| \\
& \leq C \log (1+|y|)
\end{aligned}
$$

We call $\|\phi\|_{* *, m-2, \alpha}$ the infimum of the constants $C$ that satisfy the above inequality, and denote by $X_{* *}$ the Banach space of functions $\phi \in C^{2, \alpha}$ with $\|\phi\|_{* *, m-2, \alpha}<$ $\infty$.

We couple equations (5.13), (8.1) and (8.2) with the relations

c_{1}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right]=0, \quad c_{2}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right]=0

The second equation $c_{2}=0$ is automatically satisfied thanks to the fact that all functions are even in the variable $y_{2}$ (or equivalently in the variable $z_{2}$, and in $x_{2}$ ). The first equation $c_{1}=0$ becomes an equation in the parameter $\alpha_{1}$. Recall that $\alpha_{1}$ is chosen in (5.7) as

\alpha=\frac{4 c_{1}}{x_{0}}+\alpha_{1}=\frac{2}{1+x_{0}^{2}}+\alpha_{1}, \quad\left|\alpha_{1}\right| \leq \frac{1}{|\log \varepsilon|^{\frac{1}{2}}} .

Equation $c_{1}=0$ becomes

F\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) & =\gamma_{1} \int_{B_{R}}\left[\mathcal{N}\left(\psi+\eta_{\delta} \phi\right)+\left(f^{\prime}\left(\Gamma_{0}\right)+b_{0}\right) \psi+B\left(\phi_{2}\right)\right] Z_{i} \\
& +O\left(R^{1-m}\right)\left\|\mathcal{N}\left(\psi+\eta_{\delta} \phi\right)+\tilde{E}_{\alpha}+\left(f^{\prime}\left(\Gamma_{0}\right)+b_{0}\right) \psi+B\left(\phi_{2}\right)\right\|_{m, \alpha, B_{R}}, \tag{8.3}
\end{align*}
$$

and $\beta$

$$
\beta=-8 \gamma_{1}\left(\int_{B_{R}} \frac{y_{1}}{\left(1+|y|^{2}\right)^{2}} Z_{1}+O\left(\frac{1}{|\log \varepsilon|^{\frac{1}{2}}}\right)\right) .
$$

The final step to conclude the proof of our result is to find $\psi, \phi_{1}, \phi_{2}$ and $\alpha_{1}$ solution of the fixed point problem

\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right)=\mathcal{A}\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) \tag{8.4}
\end{equation*}

given by

\psi & =\mathcal{T}^{o}\left[G\left(\psi, \phi_{1}+\phi_{2}, \alpha\right)\right], \quad \psi \in X^{o} \\
\phi_{1} & =T\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right] \\
\phi_{2} & =\mathcal{T}\left[c_{0}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right] e^{\Gamma_{0}} Z_{0}\right]  \tag{8.5}\\
\alpha_{1} & =\frac{1}{\varepsilon|\log \varepsilon| \beta} F\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) .
\end{align*}
$$

Let $b \in(0,1)$ the number introduced in (5.15), $m>2$ and define

$$
\begin{align*}
& B_{M}=\left\{\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) \in X^{o} \times X_{*} \times X_{* *} \times \mathbb{R}:\right. \\
& \quad\|\psi\|_{\infty} \leq M \varepsilon^{1+b},\left\|\phi_{1}\right\|_{*, m-2, B_{R}} \leq M \varepsilon|\log \varepsilon|^{\frac{1}{2}}  \tag{8.6}\\
& \left.\quad\left\|\phi_{2}\right\|_{* *, m-2, \alpha} \leq M \varepsilon|\log \varepsilon|^{\frac{1}{2}},\left|\alpha_{1}\right| \leq \frac{M}{|\log \varepsilon|^{\frac{1}{2}}}\right\}
\end{align*}
$$

for some positive constant $M$ independent of $\varepsilon$. We shall solve (8.4)-(8.5) in $B$.

We first show that $\mathcal{A}(B) \subset B$. Assume that $\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) \in B$. We first want to show that $\mathcal{A}\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) \in B$. From (5.14) and (5.15), we get that

\left|G\left(\psi, \phi_{1}+\phi_{2}, \alpha_{1}\right)\right| & \leq \frac{C}{1+|x|^{\nu}} \varepsilon^{1+b}\left(1+\left|\phi_{1}+\phi_{2}\right|^{2} \eta_{\delta}+|\psi|^{2}\right) \\
& +\frac{C}{1+|x|^{\nu}} \varepsilon^{2-m}\left(\left\|\phi_{1}\right\|_{*, m-2, B_{R}}+\left\|\phi_{2}\right\|_{* *, m-2, \alpha}\right)
\end{aligned}
$$

for some $\nu>2$. From Proposition 7.1 we get that

$$
\begin{equation*}
\|\psi\|_{\infty}=\left\|\mathcal{T}^{o}\left(G\left(\psi, \phi_{1}+\phi_{2}, \alpha_{1}\right)\right)\right\|_{\infty} \leq C \varepsilon^{1+b} \tag{8.7}
\end{equation*}
$$

From (5.10), (5.8), (5.9), we get, for some $a \in(0,1)$,

$$
\begin{aligned}
\left|H\left(\phi_{1}+\phi_{2}, \psi, \alpha_{1}\right)\right| & \leq C\left(\frac{\alpha_{1} \varepsilon|\log \varepsilon|}{\left(1+|y|^{2}\right)^{2}}+\frac{\varepsilon}{(1+|y|)^{3-a}}\right) \\
& +\frac{C}{1+|y|^{3-a}}\left(\frac{1}{(1+|y|)^{1+a}}+\frac{\alpha_{1} \varepsilon|\log \varepsilon|}{(1+|y|)^{a}}+\varepsilon\right)|\psi| \\
& +\frac{C}{(1+|y|)^{4}}\left(|\psi|^{2}+\left|\eta_{\delta} \phi_{1}\right|^{2}+\left|\eta_{\delta} \phi_{2}\right|^{2}\right) .
\end{aligned}
$$

Using the assumptions on $\psi, \phi_{1}$ and $\phi_{2}$, we get that

\begin{equation*}
\left\|H\left(\phi_{1}+\phi_{2}, \psi, \alpha_{1}\right)\right\|_{m, \alpha, B_{R}} \leq C \varepsilon|\log \varepsilon|^{\frac{1}{2}} \tag{8.8}
\end{equation*}
$$

From (5.12), we get

\left|B\left[\phi_{2}\right]\right| \leq C \frac{\varepsilon^{2}|\log \varepsilon|}{1+|y|}\left\|\phi_{2}\right\|_{* *, m-2, \alpha}
$$

and

$$
\begin{equation*}
\left\|B\left(\phi_{2}\right)\right\|_{m, \alpha, B_{R}} \leq C \varepsilon^{3-m}|\log \varepsilon|\left\|\phi_{2}\right\|_{* *, m-2, \alpha} \leq\left(C \varepsilon^{3-m} M|\log \varepsilon|\right) \varepsilon|\log \varepsilon|^{\frac{1}{2}} \tag{8.9}
\end{equation*}
$$

Observe also that $c_{0}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right]$

$$
\begin{equation*}
\left|c_{0}\left[H\left(\phi_{1}+\phi_{2}, \psi, \alpha\right)+B\left(\phi_{2}\right)\right]\right| \leq C \varepsilon|\log \varepsilon|^{\frac{1}{2}}\left(1+\varepsilon^{3-m}|\log \varepsilon|\left\|\phi_{2}\right\|_{* *, m-2, \alpha}\right) \tag{8.10}
\end{equation*}
$$

From Propositions 6.1, (8.8)-(8.9) we conclude that

$$
\begin{equation*}
\left\|\phi_{1}\right\|_{*, m-2, B_{R}} \leq C \varepsilon|\log \varepsilon|^{\frac{1}{2}} \tag{8.11}
\end{equation*}
$$

while from Lemma 6.1 and (8.10) we get

\left\|\phi_{2}\right\|_{* *, m-2, \alpha} \leq C \varepsilon|\log \varepsilon|^{\frac{1}{2}} \tag{8.12}
\end{equation*}

Moreover, using (8.3), we get that

Combining (8.7)-(8.11)-(8.12)-(8.13), we conclude that $\mathcal{A}\left(\psi, \phi_{1}, \phi_{2}, \alpha_{1}\right) \in B$ if we choose $M$ large enough (but independently of $\varepsilon$ ) in the definition of the set $B_{M}$ in (8.6).

We next show that $\mathcal{A}$ is a contraction map in $B_{M}$. Let $\varphi_{i}=\eta_{\delta}\left(\phi_{1}^{i}+\phi_{2}^{i}\right)+\psi^{i}$, and $\alpha_{1}^{i}$ for $i=1,2$ such that $\left(\psi^{i}, \phi_{1}^{i}, \psi_{2}^{i}, \alpha_{1}^{i}\right) \in B_{M}$. Let $G\left(\varphi^{i}, \alpha_{1}^{i}\right)=G\left(\psi^{i}, \phi_{1}^{i}+\phi_{2}^{i}, \alpha_{1}^{i}\right)$
and observe that

$$
\begin{align*}
\left|G\left(\varphi^{1}, \alpha_{1}^{1}\right)-G\left(\varphi^{2}, \alpha_{1}^{2}\right)\right| & \leq\left|V_{\alpha_{1}}(x)\left(\psi^{1}-\psi^{2}\right)\right| \\
& +\left|V_{\alpha_{1}}(x)-V_{\alpha_{2}}(x)\right|\left|\psi^{1}\right|+\left(1-\eta_{\delta}\right)\left|N_{\Psi_{\alpha_{1}}}\left(\varphi^{1}\right)-N_{\Psi_{\alpha_{2}}}\left(\varphi^{1}\right)\right| \\
& +\left(1-\eta_{\delta}\right)\left|N_{\Psi_{\alpha_{2}}}\left(\varphi^{1}\right)-N_{\Psi_{\alpha_{2}}}\left(\varphi^{2}\right)\right| \\
& +\left|A\left[\phi_{1}^{1}-\phi_{1}^{2}\right]\right|+\left|A\left[\phi_{2}^{1}-\phi_{2}^{2}\right]\right| \tag{8.14}
\end{align*}
$$

where $V_{\alpha}(x)=\left(1-\eta_{\delta}\right) \varepsilon^{2} f^{\prime}\left(\Psi_{\alpha}-\mu|x|^{2}\right), \mu=\frac{\alpha}{2}|\log \varepsilon|$, and the other terms are defined in (5.14). A direct computation gives that

\begin{aligned}
&\left|V_{\alpha_{1}}(x)-V_{\alpha_{2}}(x)\right|\left|\psi^{1}\right|+\left(1-\eta_{\delta}\right)\left|N_{\Psi_{\alpha_{1}}}\left(\varphi^{1}\right)-N_{\Psi_{\alpha_{2}}}\left(\varphi^{1}\right)\right| \\
& \leq \varepsilon^{1+b} e^{-|x|^{2}}\left|\alpha_{1}-\alpha_{2}\right|\left(\left|\psi^{1}\right|+\left|\varphi^{1}\right|\right) \\
&\left|V_{\alpha_{1}}(x)\left(\psi^{1}-\psi^{2}\right)\right|+\left(1-\eta_{\delta}\right)\left|N_{\Psi_{\alpha_{2}}}\left(\varphi^{1}\right)-N_{\Psi_{\alpha_{2}}}\left(\varphi^{2}\right)\right| \\
& \leq \varepsilon^{1+b} e^{-|x|^{2}}\left(\left|\psi^{1}-\psi^{2}\right|+\eta_{\delta}^{2}\left(\left|\phi_{1}^{1}-\phi_{1}^{2}\right|^{2}+\left|\phi_{2}^{1}-\phi_{2}^{2}\right|^{2}\right)\right)
\end{aligned}
$$

and

$$
\begin{aligned}
\left|A\left[\phi_{1}^{1}-\phi_{1}^{2}\right]\right| & \leq C\left(\left|L_{x}\left(\eta_{\delta}\right)\right| \phi_{1}^{1}-\phi_{1}^{2}\left|+\left|K_{i j} \partial_{i} \eta_{\delta} \partial_{j}\left(\phi_{1}^{2}-\phi_{1}^{2}\right)\right|\right)\right. \\
& \leq \frac{C \varepsilon}{1+|x|^{\nu}}\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{*, m-2, B_{R}}
\end{aligned}
$$

In order to estimate $A\left[\phi_{2}^{1}-\phi_{2}^{2}\right]$, we observe that

$$
\Delta_{y}\left[\phi_{2}^{1}-\phi_{2}^{2}\right]+f^{\prime}\left(\Gamma_{0}\right)\left[\phi_{2}^{1}-\phi_{2}^{2}\right]+c_{0}^{12} e^{\Gamma_{0}} Z_{0}=0 \quad \text { in } \mathbb{R}^{2}
$$

$$
\text { where } \quad c_{0}^{12}=c_{0}\left[H\left(\phi_{1}+\phi_{2}^{1}, \psi, \alpha\right)+B\left(\phi_{2}^{1}\right)\right]-c_{0}\left[H\left(\phi_{1}+\phi_{2}^{2}, \psi, \alpha\right)+B\left(\phi_{2}^{2}\right)\right] .
$$

By definition,

$$
c_{0}^{12}=\int_{B_{R}}\left[B\left[\phi_{2}^{1}-\phi_{2}^{1}\right]+\mathcal{N}\left(\psi+\eta_{\delta}\left(\phi_{1}+\phi_{2}^{1}\right)\right)-\mathcal{N}\left(\psi+\eta_{\delta}\left(\phi_{1}+\phi_{2}^{2}\right)\right)\right] Z_{0}
$$

Using (5.12) and (5.10), we get

$$
\left|c_{0}^{12}\right| \leq C\left(\int_{B_{R}} \frac{\varepsilon}{1+|y|^{2}} d y\right)\left\|\phi_{2}^{1}-\phi_{2}^{2}\right\|_{* *, \alpha}+C\left\|\phi_{2}^{1}-\phi_{2}^{2}\right\|_{* *, \alpha}^{2}
$$

Thus we can conclude that

$$
\begin{aligned}
\left|A\left[\phi_{2}^{1}-\phi_{2}^{2}\right]\right| & \leq C\left(\left|L_{x}\left(\eta_{\delta}\right)\right| \phi_{2}^{1}-\phi_{2}^{2}\left|+\left|K_{i j} \partial_{i} \eta_{\delta} \partial_{j}\left(\phi_{2}^{2}-\phi_{2}^{2}\right)\right|\right)\right. \\
& \leq \frac{C \varepsilon^{\sigma}}{1+|x|^{\nu}}\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{* *, \alpha}
\end{aligned}
$$

for some $\sigma>0$. Combining all these estimates in (8.14), we obtain that

$$
\begin{aligned}
\left|G\left(\varphi^{1}, \alpha_{1}^{1}\right)-G\left(\varphi^{2}, \alpha_{1}^{2}\right)\right| & \leq \frac{C \varepsilon^{\sigma}}{1+|x|^{\nu}}\left(\left\|\psi^{1}-\psi^{2}\right\|_{\infty}+\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{*, m-2, B_{R}}\right. \\
& \left.+\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{* *, \alpha}+\left|\alpha_{1}^{1}-\alpha_{1}^{2}\right|\right)
\end{aligned}
$$

which, in view of Proposition 7.1 gives

$$
\begin{aligned}
\left\|\mathcal{T}^{o}\left[G\left(\varphi^{1}, \alpha_{1}^{1}\right)\right]-\mathcal{T}^{o}\left[G\left(\varphi^{2}, \alpha_{1}^{2}\right)\right]\right\|_{\infty} & \leq C \varepsilon^{\sigma}\left(\left\|\psi^{1}-\psi^{2}\right\|_{\infty}+\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{*, m-2, B_{R}}\right. \\
& \left.+\left\|\phi_{1}^{1}-\phi_{1}^{2}\right\|_{* *, \alpha}+\left|\alpha_{1}^{1}-\alpha_{1}^{2}\right|\right)
\end{aligned}
$$

for some $\sigma>0$. Carrying out a similar analysis for each one of the operators in (8.5), we get that $\mathcal{A}$ is a contraction mapping in $B_{M}$.

As a consequence, Problem (8.4)-(8.5) has a fixed point, which concludes the proof of Theorem 1 .

## 9. Proof of Theorem 2

The proof of Theorem 2 is similar to that of Theorem (1) by employing the spherical symmetry of the equation (4.1), which can be written in polar coordinates as

$$
\begin{equation*}
\frac{1}{h^{2}+r^{2}}\left(\frac{h^{2}}{r^{2}}+1\right) \partial_{\theta}^{2} \Psi+\frac{h^{2}}{r} \partial_{r}\left(\frac{r}{h^{2}+r^{2}} \partial_{r} \Psi\right)=\varepsilon^{2} e^{\left(\Psi-\frac{\alpha}{2}|\log \varepsilon \| x|^{2}\right)} \quad \text { in } \quad \mathbb{R}^{2} . \tag{9.1}
\end{equation*}
$$

It is clear that equation (9.1) is invariant under rotational symmetry $\theta \rightarrow \theta+\frac{2 \pi}{k}$ and even symmetry $\theta \rightarrow-\theta$.

To construct multiple concentration solutions with polygonal symmetry, we work in the following space

$$
\begin{equation*}
\mathcal{X}_{k}=\left\{\Psi \in L_{l o c}^{\infty}\left(\mathbb{R}^{2}\right) \left\lvert\, \Psi\left(z e^{\sqrt{-1} \frac{2 \pi}{k}}\right)=\Psi(z)\right., \Psi(\bar{z})=\Psi(z), z=\left(z_{1}, z_{2}\right) \in \mathbb{R}^{2}\right\} \tag{9.2}
\end{equation*}
$$

where $k \geq 2$ is an integer.
As in the proof of Theorem 1 we modify the approximate solution as follows: let $\bar{H}_{1 \varepsilon}(z)=\Gamma_{\varepsilon}(z)\left(1+c_{1} z_{1}+c_{2}|z|^{2}\right)+\frac{4 x_{0}^{3}}{1+x_{0}^{2}} H_{1 \varepsilon}(z)$, where $\Gamma_{\varepsilon}(z), c_{1}, c_{2}, x_{0}, H_{1 \varepsilon}(z)$ are defined in Section 3. Then the new approximate solution is

$$
\begin{aligned}
\Psi_{\alpha}(x)= & \frac{\alpha}{2}|\log \varepsilon| x_{0}^{2}-\log \left(1+x_{0}^{2}\right) \\
& +\sum_{j=1}^{k} \eta_{\delta}\left(x-x_{0} e^{\sqrt{-1} \frac{2(j-1) \pi}{k}}\right) \hat{H}_{1 \varepsilon}\left(z e^{\sqrt{-1} \frac{2(j-1) \pi}{k}}\right)+H_{2 \varepsilon}(x) \in \mathcal{X}_{k} .
\end{aligned}
$$

Using the symmetry assumption (9.2), the rest of the proof is exactly the same as in that of Theorem 1. We omit the details.
