# EXISTENCE AND DIFFERENTIABILITY IN PARAMETER OF THE MEASURE SOLUTION TO A PERTURBED NON-LINEAR TRANSPORT EQUATION

#### Abstract

We consider a perturbation in the non-linear transport equation on measures i.e. both initial condition $\mu_{0}$ and the solution $\mu_{t}^{h}$ are bounded Radon measures $\mathcal{M}\left(\mathbb{R}^{d}\right)$. The perturbations occur in the velocity field and also in the right-hand side scalar function. It is shown that the solution is differentiable with respect to the perturbation parameter $h$ i.e. that derivative is an element of a proper Banach space. This result extends [23] which considered the linear transport equation. The proof exploits approximation of the non-linear problem which is based on the study of the linear equation.


## 1. Introduction

Dependence of the solution of a partial differential equation (PDE) on coefficients of the equation is a natural question to consider which is commonly investigated when a solution remains unknown. Lipschitz dependence on initial conditions in the space of measures were investigated in structured population models [12, 24, 25, 14, 15], dynamics of system [13, 11, 17, 20, 4] and vehicular traffic flow [7, 18, 22, 21]. All of mentioned applications involve a transport equation on measures, and have been widely investigated.

Differentiability with respect to perturbation parameters in PDE systems is important in the context of e.g. application in optimal control theory or linear stability - Lipschitz dependence is not enough. Previous considerations concerning the transport equation in the space of measures did not allow to analyze the differentiability of solutions with respect to a perturbation of the system [5, 34, 30, 29], see Example 1.

In this paper we consider the initial value problem for the non-linear transport equation in conservative form

where $t \mapsto \mu_{t}$ is unknown.

[^0]Notation: By $\mathcal{M}\left(\mathbb{R}^{d}\right)$ we denote the vector space of bounded signed Radon measures on $\mathbb{R}^{d}$ and by $\mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$ the space of non-negative bounded Radon measures. By $(\cdot)^{*}$ we denote the topological dual to $(\cdot)$, when the latter is equipped with a suitable locally convex or norm topology. The space $\mathcal{C}_{c}^{1}$ consists of continuously differentiable functions with compact support.
Cristiani, Piccoli and Tosin considered in [16] the homogeneous version of (1.1) $\left(m\left(\mu_{t}\right) \equiv 0\right)$ on measures to model crowd dynamics, which can be applied to evacuation simulation. Measure $\mu_{t}(x)$ was interpreted as a number of individuals at moment $t$ at position $x$.

In [16] the authors consider the following form of the velocity field

where $K: \mathbb{R}_{+} \rightarrow \mathbb{R}$. It was assumed that $K$ is compactly supported and describes how the individuals at $x$ position reacts to his neighbours, which are at $y$ position. The value $\alpha_{x y}$ is an angle between vector $y-x$ and a vector describing the direction of individual at $x$. A fact that when a human does not have eyes around the head and reacts only on surroundings in the field of vision, is described by the function $g:[-\pi, \pi] \rightarrow[0,1]$. It is a known phenomenon that a strategically placed obstacle near an exit can speed evacuations [19]. It means that wideopen exits are not always the most efficient at speeding pedestrians through. This is because a wide-open space in front of exit is that individuals can approach from all sides, allowing the maximum number of pedestrians to enter into conflict at the exit. Reducing exit access with an obstacle can pare down the severity of those conflicts. One can introduce perturbation into the velocity field and consider to minimize time needed to evacuate all pedestrians. For studying such optimization problem it is highly convenient to have differentiable dependence of the (measure) solution on the perturbation parameter. It is one of the main results of this paper, next to existence of solution, that such differentiability holds indeed, in a suitable Hölder space, see Theorem 1.1.

The list of references on optimal control problems concerning transport equation is steadily growing [11, 9, 2, 6, 3, 10]. Solving optimal control problem when a solution is not differentiable with respect to the control parameter, we can proceed twofold. The first approach is to use non-smooth analysis. The other way to go is to concentrate on regularity of solutions and discuss what regularity of coefficients can provide sufficient regularity of solutions to use smooth analysis methods anyway. In particular, in this case there are developed significantly more tools, which are less numerically complex than non-smooth methods.

At the problem (1.1) we can expect that $\mu_{t}$ (solution at fixed moment $t$ ) is a measure. This suspicion will prove to be true; see Corollary 4.9, By the velocity field $v$ and scalar right-hand side function $m$ we mean, similar to (1.2):

where $K_{v}(y, x), K_{m}(y, x): \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ and $v: \mathbb{R} \rightarrow \mathbb{R}^{d}, m: \mathbb{R} \rightarrow \mathbb{R}$. Let us denote

Since assumptions on $K_{v}, K_{m}$ will be the same, we will not distinguish them in the notation $k_{\mu}$. Instead of $v(\mu)$ and $m(\mu)$ we will write $v\left(k_{\mu}\right)(x)$ and $m\left(k_{\mu}\right)(x)$, if the structure (1.3) need to be emphasized.
Notation: Space $\mathcal{C}_{b}$ means continuous and bounded functions. Space $\mathcal{C}^{m+\alpha}$ consists of bounded functions whose partial derivatives up to order $m$ are bounded and continuous and additionally the derivative of order $m$ is also Hölder continuous with exponent $\alpha$, where $0<\alpha \leq 1$.
Recall that a function $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is Hölder continuous if the Hölder supremum

The Hölder space $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ is a Banach space with the norm

Moreover, one has

A mapping $t \mapsto \mu_{t}:[0,+\infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ is narrowly continuous if $t \mapsto \int_{\mathbb{R}^{d}} f \mathrm{~d} \mu_{t}$ is a continuous function for all $f \in \mathcal{C}_{b}\left(\mathbb{R}^{d}\right)$.
Definition 1.1 (Weak solution to non-linear problem). We say that a narrowly continuous curve $[0,+\infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right): t \mapsto \mu_{t}$ is a weak solution to (1.1) if

holds for all test functions $\varphi \in \mathcal{C}_{c}^{1}\left([0,+\infty) \times \mathbb{R}^{d}\right)$.
Let us consider the following perturbation of the coefficients, for the real perturbation parameter $h$ :

The perturbed problem corresponding to (1.1) has the form

\mu_{t=0}^{h}=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.

In this paper we investigate existence of weak solution $t \mapsto \mu_{t}^{h}$ and then differentiability of the mapping $h \mapsto \mu_{t}^{h}$. Notice that the initial condition in (1.9) is not perturbed.

The duality of $\mathcal{M}\left(\mathbb{R}^{d}\right)$ with $W^{1, \infty}\left(\mathbb{R}^{d}\right)$ is a natural setting when considering the transport equation in the space of bounded Radon measures [24], [25]. The metric $\rho_{F}$ on $\mathcal{M}\left(\mathbb{R}^{d}\right)$, called the flat metric (or bounded Lipschitz distance), is defined as follows:

Below we present a counterexample, that motivates why differentiability in parameter $h$ of the weak solution cannot be obtained in $\left(\mathcal{M}\left(\mathbb{R}^{d}\right), \rho_{F}\right)$.
Example 1. [32] Consider one-dimensional linear transport equation, i.e. $x \in \mathbb{R}$ :

where by $\delta_{x}$ we denote the Dirac measure concentrated at point $x$. It can be easily checked that $\mu_{t}^{h}=\delta_{(1+h) t}$ is a weak solution to (1.10) in the sense of Definition 1.1] Note that the map $h \mapsto \mu_{t}^{h}$ is Lipschitz continuous i.e.

However, it is not differentiable for $\rho_{F}$. If $\frac{\mu_{t}^{h}-\mu_{t}^{0}}{h}$ were convergent as $h \rightarrow 0$, it would satisfy the Cauchy condition with respect to $\rho_{F}$. One obtains

If we choose a test function from $W^{1, \infty}(\mathbb{R})$ such that

then for $h_{1}>0$ and $h_{2}<0$, we get $\rho_{F}\left(\frac{\mu_{t}^{h_{1}}-\mu_{t}^{0}}{h_{1}}, \frac{\mu_{t}^{h_{2}}-\mu_{t}^{0}}{h_{2}}\right) \geq 2 t$. Thus $\frac{\mu_{t}^{h}-\mu_{t}^{0}}{h}$ does not converge. Therefore, differentiability in parameter requires a topology defined by test functions that must be more regular than $W^{1, \infty}(\mathbb{R})$.

A class of functions more regular than $W^{1, \infty}$, that suffices for our needs is $\mathcal{C}^{1+\alpha}$. Now, we need to introduce a space which contains the derivative of $\mu_{t}^{h}$ at fixed $h$ and $t$. Following [23] let us define a space $\mathcal{Z}$ as a predual to $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$. It will turn out that $\left.\partial_{h} \mu_{t}^{h}\right|_{h=h_{0}}$ exits in $\mathcal{Z}$. The space of Radon measures $\mathcal{M}\left(\mathbb{R}^{d}\right)$ inherits the dual norm of $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$ by means of embedding the former into the latter, where a measure is identified with the functional defined by integration against the measure. Throughout we identify the former with the subspace of $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$. Let then

\mathcal{Z}:={\overline{\mathcal{M}\left(\mathbb{R}^{d}\right)}}^{\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}} \tag{1.11}

which is a Banach space equipped with the dual norm $\|\cdot\|_{\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}}$. Unless stated otherwise we equip $\mathcal{M}\left(\mathbb{R}^{d}\right)$ with the topology induced by $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$.
The main result of this paper concerns the regularity of mapping $h \mapsto\left(t \mapsto \mu_{t}^{h}\right)$ and for this we need to introduce a proper class of regularity. It will turn out that the solution $t \mapsto \mu_{t}^{h}$ is of a class $\mathcal{C}\left([0, \infty) ; \mathcal{M}\left(\mathbb{R}^{d}\right)\right.$ ), where $\mathcal{M}\left(\mathbb{R}^{d}\right)$ is equipped with a relative topology of $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$. The boundedness of the mapping $t \mapsto \mu_{t}^{h}$ will be necessary. Unfortunately $t \mapsto\left\|\mu_{t}^{h}\right\|_{\mathcal{Z}}$ is not bounded. However, the growth of $\mu_{t}^{h}$ can be controlled in time by an exponential function; see Proposition 2.7. It means that $\left\|\mu_{t}\right\|_{\mathcal{Z}} \leq \exp (g t)\left\|\mu_{0}\right\|_{\mathrm{TV}}$ for some constant $g>0$, and hence the value $\sup _{t \geq 0} \exp (-g t)\left\|\mu_{t}\right\|_{\mathcal{Z}}$ is bounded.
For every $f:[0,+\infty) \rightarrow X$, where $\left(X,\|\cdot\|_{X}\right)$ is normed vector space, we define the $\omega$-weighted norm as

where $\omega(t)>0$ is called a weight (this condition is necessary for (1.12) to be a norm). By $\mathcal{C}_{\omega}([0,+\infty) ; X)$ we denote the space of continuous functions valued in $X$ on $[0, \infty)$, such that the norm $\|f\|_{X_{\omega}}<\infty$. When $\omega(t)=e^{-g t}$ and $g>0$ is a constant, then (1.12) is called the Bielecki norm [27]. The norm involved in the space $\mathcal{C}([0, \infty) ; \mathcal{Z})$ will not be the Bielecki norm, but it is closely related; see weight (1.14).

The appropriate weight (which will be necessary not only for controlling growth of $\mu_{t}$ in time) is

where the constant $g_{N}$ are positive for all $N \in \mathbb{N} \backslash\{0\}$. The reason for such a form of $\omega_{1}$ follows from Proposition 4.7 and Proposition 5.1. The weight $\omega_{2}$ results from Theorem 2.12.
Now, we are ready to state the main result of this paper.
Theorem 1.1. Assume that for $i=0,1$
A1: $v_{i}(\cdot) \in \mathcal{C}^{3+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$,
A2: $m_{i}(\cdot) \in \mathcal{C}^{3+\alpha}(\mathbb{R} ; \mathbb{R})$,
A3: $\left(x \mapsto K_{v_{i}}(\cdot, x)\right),\left(x \mapsto K_{m_{i}}(\cdot, x)\right) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$,
A4: $y \mapsto K_{v_{i}}(y, \cdot), y \mapsto K_{m_{i}}(y, \cdot): \mathbb{R}^{d} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ are weakly continuous and bounded.
Let the coefficients be defined by (1.8). Then problem (1.9) has a unique weak solution $t \mapsto \mu_{t}^{h}$ and the mapping

where $\tilde{\omega}(t)$ is defined by (1.13). In particular, for fixed the derivative $\left.\partial_{h} \mu_{t}^{h}\right|_{h=h_{0}} \in \mathcal{Z}$.
Remark. In fact, the parameter $h$ can be considered in any bounded interval and Theorem 1.1remains true. The reason why only bounded intervals can be taken into account is that in the proof of Theorem 1.1 we exploit the supremum norm of $m^{h}\left(k_{\mu_{t}^{h}}\right)$. If the parameter $h$ is not bounded, then for fixed $h$ the scalar function $m^{h}\left(k_{\mu_{t}^{h}}\right)$ is bounded if $m_{0}, m_{1}$ satisfy assumption $\mathbf{A 2}$, but the family of these functions is not uniformly bounded. This uniformly boundedness is necessary later.

Above theorem can be naturally extended for the velocity field explicitly dependent also on $x$ and $t$ i.e. $v\left(t, x, \mu_{t}\right)$, analogously $m\left(t, x, \mu_{t}\right)$. We investigate a dependency only on the solution $\mu_{t}$, in order to clarify the line of reasoning and the way estimates are made.

The proof of Theorem 1.1 is based on a scheme approximating the solution $t \mapsto \mu_{t}^{h}$. As we will see in Section 4 the approximating scheme involves a linear transport equation. Therefore, in Section 2 some results concerning a linear transport equation are recalled. We consider

\nu_{t=0}=\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right),
\end{array}\right.

where $b:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $w:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}$. By $\nu_{t}$ we always denote the solution to the linear problem, in contrast to $\mu_{t}$ which refers to the non-linear equation. In Section 2.3, two types of perturbation are studied. The first one is linear $b_{0}(t, x)+h b_{1}(t, x)$ and $w_{0}(t, x)+$ $h w_{1}(t, x)$. And the second one is non-linear

b_{0}(t, x)+h b_{1}(t, x)+C(t) \mathcal{O}(h) \quad \text { and } \quad w_{0}(t, x)+h w_{1}(t, x)+C(t) \mathcal{O}(h) \tag{1.16}
\end{equation*}
$$

Differentiability of the solution $t \mapsto \nu_{t}$ with respect to the perturbing parameter $h$ is discussed (in both types of the perturbation). In Section 2.2 some properties of the space $\mathcal{Z}$ are presented.

In Section 3, the regularity of a mapping

$$
\left(t \mapsto \mu_{t}\right) \mapsto\left(t \mapsto u\left(\int_{\mathbb{R}^{d}} K_{u}(y, x) \mathrm{d} \mu(y)\right)(\cdot)\right)
$$

is investigated, where $u \in\{v, m\}$. It is concluded by stating that under assumptions A1, $\mathbf{A 2}$, $\mathbf{A 3}$ of Theorem 1.1 this mapping is of a class $\mathcal{C}^{1}\left(\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z}) ; \mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)\right)$ for $u \in\left\{v_{0}, v_{1}\right\}$ and analogously for $m_{0}, m_{1}$. This is necessary further on and allows us treating perturbations (1.8) as a much simpler case. Using an approximating scheme, the non-linear problem is essentially reduced to the linear equation with perturbation (1.16).

Later on, in Section 4, the scheme approximating the weak solution $\mu_{t}^{h}$ is constructed. By contraction argument we conclude that (1.9) has a weak solution. It is also argued that if $\mu_{0} \in$ $\mathcal{M}\left(\mathbb{R}^{d}\right)$, then the solution $\mu_{t}^{h}$ is also a signed Radon measure - this is not obvious, since $\mathcal{M}\left(\mathbb{R}^{d}\right)$ is not complete with the norm $\|\cdot\|_{\mathcal{Z}}$. In Section 5a simple modification of the approximating scheme introduced in Section 4 is described, which is convenient to investigate quotients $\frac{\mu_{t}^{h}-\mu_{t}^{0}}{h}$.

Finally, in Section 6 all elements are combined to complete the proof of Theorem 1.1 ,

## 2. Preparation

This section is a brief overview of results concerning differentiability with respect to parameter of the solution to linear transport equation on measures. By $\nu_{t}$ we denote the solution to linear transport equation, in contrast to $\mu_{t}$ which is a solution to non-linear problem.

First, we state some facts about the non-perturbed linear transport equation, in particular the explicit formula for its solution. Then, a brief review of [23] is made i.e. linear perturbation in the linear transport equation. In contrast to [23] we present the dependence of the derivative $\partial_{h} \nu_{t}^{h}$ on time. We also discuss some properties of the space $\mathcal{Z}$ and the weighted space $\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z})$. At the end of this section, a non-linear perturbation in the transport equation is discussed, see Theorem 2.12, which has not been studied in [23].
2.1. Linear equation with no perturbation. Consider the linear transport equation (1.15).

Definition 2.1 (Weak solution to linear problem). We say that the narrowly continuous curve $[0,+\infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right): t \mapsto \mu_{t}$ is a weak solution to (1.15) if

& \int_{0}^{\infty} \int_{\mathbb{R}^{d}}\left(\partial_{t} \varphi(t, x)+b(t, x) \nabla_{x} \varphi(t, x)\right) \mathrm{d} \nu_{t}(x) \mathrm{d} t+\int_{\mathbb{R}^{d}} \varphi(0, \cdot) \mathrm{d} \nu_{0}(x)= \\
= & \int_{0}^{\infty} \int_{\mathbb{R}^{d}} w(t, x) \varphi(t, x) \mathrm{d} \nu_{t}(x) \mathrm{d} t
\end{aligned}
$$

holds for all test functions $\varphi \in \mathcal{C}_{c}^{\infty}\left([0, \infty) \times \mathbb{R}^{d}\right)$.
A standard method to solve the transport equation in a classical sense is the method of characteristics. When the initial condition $\nu_{0} \in \mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$, and if the velocity field $b$ and right-hand side $w$ are sufficiently regular, then the method of characteristics can be applied in the measure setting too. The characteristic system associated to equation (1.15) has the form

$$
\left\{\begin{array}{l}
\dot{X}_{b}(t, x)=b\left(t, X_{b}(t, x)\right),  \tag{2.17}\\
X_{b}\left(t_{0}, x\right)=x \in \mathbb{R}^{d}
\end{array}\right.
$$

A solution to (2.17), $X_{b}$ is called a flow map. Note that if $b$ is Lipschitz continuous, the flow maps $X_{b}$ are defined for all $t \in \mathbb{R}$ and thus $x \mapsto X_{b}(t, x)$ is a one-parameter family of diffeomorphisms on $\mathbb{R}^{d}$ (dependent on the variable $b$ ).

Let us define the push-forward operator [5], which is needed to formulate an explicit formula for solution to (1.15). If $Y_{1}, Y_{2}$ are separable metric spaces, $\nu \in \mathcal{M}^{+}\left(Y_{1}\right)$, and $r: Y_{1} \rightarrow Y_{2}$ is a $\nu$-measurable map, we denote by $\nu \mapsto r \# \nu \in \mathcal{M}^{+}\left(Y_{2}\right)$ the push-forward of $\nu$ through $r$, defined by

r \# \nu(\mathbf{B}):=\nu\left(r^{-1}(\mathbf{B})\right), \quad \text { for all } \mathbf{B} \in \mathcal{B}\left(Y_{2}\right) . \tag{2.18}
\end{equation*}

Consequently, one can also consider signed measures. Since Hahn-Jordan Decomposition Theorem push-forward can work separately on positive and negative parts of a signed measure and gives as a result sum of positive and negative measures.

The following lemma yields existence and uniqueness of a weak solution to (1.15).

Lemma 2.1 (A representation formula for the linear equation). [28, Proposition 3.6] Let the mapping $t \mapsto b(t, \cdot)$ be a Borel velocity field in $L^{1}\left([0, T] ; W^{1, \infty}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)$, $w(t, x)$ be a Borel measurable function, bounded and for fixed $t$ locally Lipschitz continuous with respect to $x$. Let $\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$. Then there exists a unique, narrowly continuous family of finite Borel measures solving (in the distributional sense) the initial value problem (1.15) and it is given by the explicit formula

$$
\begin{equation*}
\nu_{t}=X_{b}(t, \cdot) \#\left(e^{\int_{0}^{t} w\left(s, X_{b}(s,)\right) \mathrm{d} s} \nu_{0}\right), \quad \text { for all } t \in[0, T] \tag{2.19}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
\nu_{t}=X(t, 0, \cdot) \# \nu_{0}+\int_{0}^{t} X(t, s, \cdot) \#\left(w(s, \cdot) \nu_{s}\right) \mathrm{d} s \quad \text { for all } t \in[0, T] \tag{2.20}
\end{equation*}
$$

provides an implicit formula for $\nu_{t}$.
Lemma 2.1 states in particular that the solution $\nu_{t}$ is an element of $\mathcal{M}\left(\mathbb{R}^{d}\right)$. Notice that the representation formula yields that sign is preserved i.e. if $\nu_{0} \in \mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$ then $\nu_{t} \in \mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$.

Remark. Representation formula proposed in [28, Proposition 3.6] has identical form as (2.19) but it was originally formulated for a problem when initial condition $\nu_{0}$ is an element of $\mathcal{P}\left(\mathbb{R}^{d}\right)$. The proof of Lemma 2.1]remains essentially the same as in [28, Proposition 3.6].

Corollary 2.2. If $\nu_{0}$ is a weak solution to the linear transport equation (1.15) with $b$ and $w$ as in Lemma 2.1] then $\nu_{\bullet}:[0, \infty) \rightarrow \mathcal{Z}$ is a locally Lipschitz mapping. In particular, it is continuous.

Proof. The mapping $\nu_{\bullet}$, as a weak solution to the linear problem, has the explicit representation (2.19). Let us denote $\psi(t, \cdot):=\exp \left(\int_{0}^{t} w\left(s, X_{b}(s, \cdot)\right) \mathrm{d} s\right)$. Let $\varphi \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ and take $\bar{t} \in[0, \infty)$. If $t \in[0, \infty)$ and $t \neq \bar{t}$ then

& \left|\left\langle\nu_{t}-\nu_{t}, \varphi\right\rangle\right|=\left|\int_{\mathbb{R}^{d}} \varphi\left(X_{b}(t, x)\right) \psi(t, x)-\varphi\left(X_{b}(\bar{t}, x)\right) \psi(\bar{t}, x) \mathrm{d} \nu_{0}(x)\right| \\
& \leq \int_{\mathbb{R}^{d}}\left|\varphi\left(X_{b}(t, x)\right)-\varphi\left(X_{b}(\bar{t}, x)\right)\right| \psi(t, x) \mathrm{d} \nu_{0}(x)+\int_{\mathbb{R}^{d}}\left|\varphi\left(X_{b}(\bar{t}, x)\right)\right||\psi(t, x)-\psi(\bar{t}, x)| \mathrm{d} \nu_{0}(x)
\end{aligned}
$$

Without lost of generality we may assume that $|t-\bar{t}|<1$. Then one has

and hence, writing $\int_{0}^{T}\|b\|_{\infty} \mathrm{d} s$ as a shortcut for $\int_{0}^{T}\|b(s, \cdot)\|_{\infty} \mathrm{d} s$,

& \leq\left\|\nu_{0}\right\|_{T V}\left(C_{1}\left\|\varphi\left(X_{b}(t, \cdot)\right)-\varphi\left(X_{b}(\bar{t}, \cdot)\right)\right\|_{\infty}+\|\varphi\|_{\infty}\|\psi(t, \cdot)-\psi(\bar{t}, \cdot)\|_{\infty}\right) \\
& \leq\left\|\nu_{0}\right\|_{T V}\left(C_{1}\|\nabla \varphi\|_{\infty}\left\|X_{b}(t, \cdot)-X_{b}(\bar{t}, \cdot)\right\|_{\infty}+\|\varphi\|_{\infty}\|\psi(t, \cdot)-\psi(\bar{t}, \cdot)\|_{\infty}\right) \\
& \leq\left\|\nu_{0}\right\|_{T V}\left(C_{1} \int_{0}^{T}\|b\|_{\infty} \mathrm{d} s\|\nabla \varphi\|_{\infty}|t-\bar{t}|+\|\varphi\|_{\infty}\|\psi(t, \cdot)-\psi(\bar{t}, \cdot)\|_{\infty}\right) \\
& \leq\left\|\nu_{0}\right\|_{T V}\left(C_{1} \int_{0}^{T}\|b\|_{\infty} \mathrm{d} s\|\nabla \varphi\|_{\infty}|t-\bar{t}|+\exp \left(\|w\|_{\infty} \max \{t, \bar{t}\}\right)\|w\|_{\infty}\|\varphi\|_{\infty}|t-\bar{t}|\right)
\end{aligned}
$$

Thus, taking supremum over $\varphi$ in the unit ball of $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$, one obtains

\left\|\nu_{t}-\nu_{\bar{t}}\right\|_{\mathcal{Z}} \leq\left(C_{1} \int_{0}^{T}\|b\|_{\infty} \mathrm{d} s+\exp \left(\|w\|_{\infty} \max \{t, \bar{t}\}\right)\|w\|_{\infty}\right)\left\|\nu_{0}\right\|_{T V}|t-\bar{t}| \tag{2.21}
\end{equation*}
$$

what means that $\nu_{0}$ is a locally Lipschitz continuous. In particular, it is continuous mapping.

Let us assume that

$$
\begin{align*}
(t \mapsto b(t, \cdot)) & \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right), \\
(t \mapsto w(t, \cdot)) & \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}\right)\right) \tag{2.22}
\end{align*}
$$

These assumptions are necessary to assume that the solution is differentiable with respect to the perturbating parameter (see Theorem 2.10 and Theorem 2.11). Under assumption (2.22) the velocity field $b$ is globally Lipschitz and hence there exists a global unique solution to (2.17) what implies that (1.15) also has unique solution.

Let us notice the following dependence of $X_{b}$ on $b$.
Lemma 2.3. Let $b(t, \cdot), \bar{b}(t, \cdot) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$ and let $X_{b}$ and $X_{\bar{b}}$ be the solution to problem (2.17) corresponding to $b$ and $\bar{b}$. Then the following estimates holds

\left|X_{b}(t, x)-X_{\bar{b}}(t, x)\right| \leq \exp \left(t C_{t}[b, \bar{b}]\right) \int_{0}^{t}\|b(s, \cdot)-\bar{b}(s, \cdot)\|_{\infty} \mathrm{d} s

where

\begin{equation*}
C_{t}[b, \bar{b}]:=\min \left\{\sup _{0 \leq s \leq t}\left\|\nabla_{x} b(s, \cdot)\right\|_{\infty}, \sup _{0 \leq s \leq t}\left\|\nabla_{x} \bar{b}(s, \cdot)\right\|_{\infty}\right\} . \tag{2.23}
\end{equation*}
$$

Proof. One has

\begin{aligned}
& \left|X_{b}(t, x)-X_{\bar{b}}(t, x)\right|= \\
& =\left|x+\int_{0}^{t} b\left(s, X_{b}(s, x)\right) \mathrm{d} s-x-\int_{0}^{t} \bar{b}\left(s, X_{\bar{b}}(s, x)\right) \mathrm{d} s\right| \\
& \leq \int_{0}^{t}\left|b\left(s, X_{b}(s, x)\right)-\bar{b}\left(s, X_{\bar{b}}(s, x)\right)\right| \mathrm{d} s \\
& \leq \int_{0}^{t}\left|b\left(s, X_{b}(s, x)\right)-\bar{b}\left(s, X_{b}(s, x)\right)\right| \mathrm{d} s+\int_{0}^{t}\left|\bar{b}\left(s, X_{b}(s, x)\right)-\bar{b}\left(s, X_{\bar{b}}(s, x)\right)\right| \mathrm{d} s \\
& \leq \int_{0}^{t}\|b(s, \cdot)-\bar{b}(s, \cdot)\|_{\infty} \mathrm{d} s+\int_{0}^{t}\left\|\nabla_{x} \bar{b}(s, \cdot)\right\|_{\infty}\left|X_{b}(s, x)-X_{\bar{b}}(s, x)\right| \mathrm{d} s \\
& \leq \int_{0}^{t}\|b(s, \cdot)-\bar{b}(s, \cdot)\|_{\infty} \mathrm{d} s+\sup _{0 \leq s \leq t}\left\|\nabla_{x} \bar{b}(s, \cdot)\right\|_{\infty} \int_{0}^{t}\left|X_{b}(s, x)-X_{\bar{b}}(s, x)\right| \mathrm{d} s .
\end{aligned}
$$

By Gronwall Lemma and observing that the roles of $b$ and $\bar{b}$ can be interchanged, the proof is completed.
2.2. Space $\mathcal{Z}$ and weighted space. Recall the definition of the space $\mathcal{Z}$ in (1.11), following [23]. Throughout we identify $\mathcal{M}\left(\mathbb{R}^{d}\right)$ with the subspace of $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$. The norm on $\mathcal{Z}$ (and on $\mathcal{M}\left(\mathbb{R}^{d}\right)$ ) is $\|\cdot\|_{\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}}$, which will be denoted by $\|\cdot\|_{\mathcal{Z}}$. Below some properties of the space $\mathcal{Z}$ are presented.
Proposition 2.4. [23, Proposition 4.1] The set $\operatorname{span}_{\mathbb{Q}}\left\{\delta_{x}: x \in \mathbb{Q}^{d}\right\}$ is dense in $\mathcal{Z}$ with respect to the $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$-topology, i.e.

$$
\mathcal{Z}=\overline{\operatorname{span}_{\mathbb{Q}}\left\{\delta_{x}: x \in \mathbb{Q}^{d}\right\}}\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*} .
$$

Consequently, $\mathcal{Z}$ is a separable space.
Proposition 2.5. [23, Proposition 4.3] The space $\mathcal{Z}^{*}$ is linearly isomorphic to $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ under the map $\phi \mapsto T \phi$, where $T \phi(x):=\phi\left(\delta_{x}\right), T: \mathcal{Z}^{*} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$.

The following result was not stated in [23]:
Proposition 2.6. $\mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$ is closed in $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$.
Proof. Let $\nu_{n} \in \mathcal{M}^{+}\left(\mathbb{R}^{d}\right)$ such that $\nu_{n} \rightarrow F$ in $\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$. Then for every $f \in \mathcal{C}_{c}^{1}\left(\mathbb{R}^{d}\right) \subset$ $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ and $f \geq 0$ one has $\left\langle f, \nu_{n}\right\rangle \geq 0$. This implies that $\langle f, F\rangle \geq 0$. A well-known result concerning distributions says: if a distribution $F$ is non-negative (in the sense that $\langle f, F\rangle \geq 0$ for all $f \in \mathcal{C}_{c}^{\infty}$ such that $f \geq 0$ ), then $F$ is a non-negative Radon measure (see [33, Lemma 37.2]).

For the investigation of the mapping $h \mapsto\left(t \mapsto \nu_{t}^{h}\right)$, we need a weighted space. A motivation for this is that $t \mapsto \nu_{t}$ is a continuous mapping i.e. $t \mapsto \nu_{t} \in \mathcal{C}\left([0, \infty) ; \mathcal{M}\left(\mathbb{R}^{d}\right)\right)$ with $\|\cdot\|_{\mathcal{Z}}$, but it is not bounded with respect to time, generally. Boundedness of this mapping will play a key role in the result concerning non-linear transport equation. Hence, we introduce a new norm which makes this mapping bounded. Following proposition says about evolution of $\nu_{t}$ in time.
Proposition 2.7. Let $\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$, velocity field $b$ satisfies (2.22) and $w \in \mathcal{C}_{b}\left([0, \infty) \times \mathbb{R}^{d}\right)$. Then for every weak solution $\nu_{t}$ to (1.15) the following estimate holds

$$
\left\|\nu_{t}\right\|_{T V} \leq e^{t\left\|w^{+}(\cdot, \cdot)\right\|_{\infty}}\left\|\nu_{0}\right\|_{T V}, \quad \text { for all } t \in[0, \infty)
$$

where $w^{+}$is the positive part of $w$.
Proof. By the definition of $T V$-norm and using representation formula (2.19) one has

\left\|\nu_{t}\right\|_{T V} & =\sup _{f \in \mathcal{C}_{b}\left(\mathbb{R}^{d}\right)}\left\{\int_{\mathbb{R}^{d}} f \mathrm{~d} \nu_{t}:\|f\|_{\infty} \leq 1\right\} \\
& \leq \exp \left(\left\|w^{+}(\cdot, \cdot)\right\|_{\infty} t\right) \sup _{f \in \mathcal{C}_{b}\left(\mathbb{R}^{d}\right)}\left\{\int_{\mathbb{R}^{d}} f\left(X_{b}(t, \cdot)\right) \mathrm{d} \nu_{0}:\|f\|_{\infty} \leq 1\right\} \\
& \leq \exp \left(\left\|w^{+}(\cdot, \cdot)\right\|_{\infty} t\right) \sup _{f \in \mathcal{C}_{b}\left(\mathbb{R}^{d}\right)}\left\{\int_{\mathbb{R}^{d}} f \mathrm{~d} \nu_{0}:\|f\|_{\infty} \leq 1\right\} \\
& \leq \exp \left(\left\|w^{+}(\cdot, \cdot)\right\|_{\infty} t\right)\left\|\nu_{0}\right\|_{T V}
\end{aligned}
$$

what finishes the proof.

Corollary 2.8. Since for any $\nu \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ one has $\|\nu\|_{\mathcal{Z}} \leq\|\nu\|_{T V}$, therefore

\begin{equation*}
\left\|\nu_{t}\right\|_{\mathcal{Z}} \leq \exp \left(\left\|w^{+}(\cdot, \cdot)\right\|_{\infty} t\right)\left\|\nu_{0}\right\|_{T V}, \quad \text { for all } t \in[0, \infty) \tag{2.24}
\end{equation*}
$$

Corollary 2.9. Under assumptions of Lemma 2.1] the weak solutions $t \mapsto \nu_{t}$ of linear problem (1.15) are of a class $\mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{M}\left(\mathbb{R}^{d}\right)\right)$, where $\omega(t)=\exp \left(-\|w\|_{\infty} t\right)$.

Proof. The fact that $\nu_{t}$ are bounded Radon measures follows by Lemma 2.1. By Corollary 2.2 one has that the solution is locally Lipschitz continuous with respect to time, hence in particular it is continuous. By assumption $\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ and estimate (2.24) one has, that the value $\left\|\nu_{t}\right\|_{\mathcal{Z}_{\omega}}$ is bounded.

Remark. The space $\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z})$ is complete for any weight function $\omega(t)$ such that for all $t_{0} \in[0, \infty)$, there exists $\sigma>0$ and closed interval $\left[t_{1}, t_{2}\right]$ containing $t_{0}$ with $t_{1}<t_{2}$, such that $w(t)>\sigma$ for all $t \in\left[t_{1}, t_{2}\right]$.
2.3. Linear transport equation with perturbation. A brief review of [23] is presented i.e. linear perturbation in the linear transport equation. We extend the results of [23] in Theorem 2.11 and Theorem 2.12, Let us introduce a perturbation to the velocity field $b$ and into $w$ as follows:

b^{h}(t, x):=b_{0}(t, x)+h b_{1}(t, x), \quad \text { and } \quad w^{h}(t, x):=w_{0}(t, x)+h w_{1}(t, x) \tag{2.25}
\end{equation*}
$$

where $b_{i}:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $w_{i}:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ for $i=0,1$ and parameter $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$. The perturbed problem has the form

$$
\left\{\begin{array}{l}
\partial_{t} \nu_{t}^{h}+\operatorname{div}_{x}\left(b^{h}(t, x) \nu_{t}^{h}\right)=w^{h}(t, x) \nu_{t}^{h} \quad \text { in }\left(\mathcal{C}_{c}^{1}\left([0,+\infty) \times \mathbb{R}^{d}\right)\right)^{*}  \tag{2.26}\\
\nu_{t=0}^{h}=\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.
$$

Notice that the initial condition in (2.26) is not perturbed. Proposition 2.7 remains true for solution $\nu_{t}^{h}$. The following theorem addresses the differentiability of $t \mapsto \nu_{t}^{h}$ with respect to parameter $h$.

Theorem 2.10. [23, Theorem 1.2] Assume that $\left(t \mapsto b_{i}(t, \cdot)\right) \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)$ and $\left(t \mapsto w_{i}(t, \cdot)\right) \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}\right)\right)$ for $i=0,1$. Let $\nu_{t}^{h}$ be the weak solution to problem (2.26) where $b^{h}$ and $w^{h}$ are defined by (2.25). Then the mapping

\left(-\frac{1}{2}, \frac{1}{2}\right) \ni h \mapsto \nu_{t}^{h} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
$$

is differentiable in $\mathcal{Z}$, i.e. for fixed the derivative $\left.\partial_{h} \nu_{t}^{h}\right|_{h=h_{0}} \in \mathcal{Z}$.
Lemma 2.1 provides that (2.26) has a unique global weak solution, which is a measure. Theorem 2.10 is an analogue to [23, Theorem 1.2] - it was originally formulated for $\nu_{0} \in \mathcal{P}\left(\mathbb{R}^{d}\right)$, where the linear perturbation occurred only in $b$, not in $w$. However, the proof can be easily extended to our settings. The proof of [23, Theorem 1.2] is based on the fact that $\mathcal{Z}$ is a complete space. Thus it is enough to show that a proper sequence of differential quotients is a Cauchy sequence. The proof is presented in Appendix B on page 40, In contrast to [23] we will point out a dependence of constants on time, which helps us to obtain a stronger result, concerning continuous differentiability.

Theorem 2.11. Let $\nu_{\bullet}^{h}: t \mapsto \nu_{t}^{h}$ be the weak solution to problem (2.26) with coefficients $b^{h}$ and $w^{h}$ defined by (2.25). Moreover, let coefficients $b^{h}$, $w^{h}$ satisfy assumptions of Theorem [2.10] Then

\left(h \mapsto \nu_{\bullet}^{h}\right) \in \mathcal{C}^{1}\left(\left(-\frac{1}{2}, \frac{1}{2}\right) ; \mathcal{C}_{\widehat{\omega}}([0, \infty) ; \mathcal{Z})\right)

where $\widehat{\omega}(t)$ is of order $\mathcal{O}\left(\frac{1}{t} \exp (-g t)\right)$ for some constant $g>0$ independent of $h$.
The constant $g$ depends on the size of the interval $(-\xi, \xi)$ in which $h$ is considered. The proof is presented in Appendix Con page 46, Note that Theorem 2.11 implies Theorem 2.10 for fixed $t$. Explicit weight $\widehat{\omega}(t)$ is given in the Appendix by formula (C.92).

Let us investigate a different perturbation than (2.25):

where $C(t)$ is a constant dependent on time. As before coefficients $b_{i}:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $w_{i}:[0, \infty) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ for $i=0,1$ and parameter $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$. The perturbed problem has the form

\nu_{t=0}^{h}=\nu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.
$$

The following extension of Theorem 2.11remains true.
Theorem 2.12. Let the mapping $\nu_{\bullet}^{h}: t \mapsto \nu_{t}^{h}$ be the weak solution to problem (2.28) with coefficients defined by (2.27). Assume that $\left(t \mapsto b_{i}(t, \cdot)\right) \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)$ and $\left(t \mapsto w_{i}(t, \cdot)\right) \in \mathcal{C}_{b}\left([0,+\infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}\right)\right)$ for $i=0,1$ and let $C(t)=\mathcal{O}\left(t e^{g t}\right)$. Then the mapping $\left(-\frac{1}{2}, \frac{1}{2}\right) \ni h \mapsto \nu_{t}^{h} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ is differentiable in $\mathcal{Z}$. Moreover,

\left(h \mapsto \nu_{\bullet}^{h}\right) \in \mathcal{C}^{1}\left(\left(-\frac{1}{2}, \frac{1}{2}\right) ; \mathcal{C}_{\omega_{2}}([0, \infty) ; \mathcal{Z})\right)
$$

where weight $\omega_{2}(t)=\mathcal{O}\left(\frac{1}{t^{2}} \exp (-g t)\right)$ and constant $g>0$.
The proof follows exactly the same lines of reasoning as the proof of Theorem 2.11, and hence is omitted. Theorem 2.12 will be used in the final part of the proof of the Theorem 1.1 (see page 35).

## 3. Properties of the superposition operators

The density dependent velocity field $v\left(\mu_{t}\right)$ and production rate $m\left(\mu_{t}\right)$ are formed from a combination of a kernel operator $\mu_{t} \mapsto k_{\mu_{t}}$ (equation (1.4)) and a superposition operator: $v\left(\mu_{t}\right)=$ $v \circ k_{\mu_{t}}$. In the literature, few results can be found on such operators in Hölder spaces, even less in relation to measures. This section provides the required results. In particular, in the proof of Theorem 1.1 we will approximate the weak solution to the non-linear equation by solutions to the linear equation. We will then use properties of the linear equation; see Theorem 2.11 and Theorem 2.12. Recall that by $\mu_{\bullet}$ we mean the mapping $t \mapsto \mu_{t}$. This section is one of
steps in arguing that coefficients $v\left(k_{\mu_{\bullet}}\right)$ and $m\left(k_{\mu_{\bullet}}\right)$ of equation (1.9) satisfy assumptions of Theorem 2.11.

First, we will show that the mapping

$$
\mu \mapsto u\left(\int_{\mathbb{R}^{d}} K_{u}(y, x) \mathrm{d} \mu(y)\right) \quad \text { is of a class } \quad \mathcal{C}^{1}\left(\mathcal{Z} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)
$$

for $u \in\left\{v_{0}, v_{1}\right\}$ and analogously for $u \in\left\{m_{0}, m_{1}\right\}$. Then we will prove that

\mu_{\bullet} \mapsto\left(t \mapsto u\left(\int_{\mathbb{R}^{d}} K_{u}(y, x) \mathrm{d} \mu_{t}(y)\right)(\cdot)\right)
$$

is of class $\mathcal{C}^{1}\left(\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z}) ; \mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)\right)$ for $u \in\left\{v_{0}, v_{1}\right\}$ and analogously for $u \in\left\{m_{0}, m_{1}\right\}$. Since we fix $u$, we simply write $K$ instead of $K_{u}$.

The function $k_{\mu}(x):=\int_{\mathbb{R}^{d}} K(y, x) \mathrm{d} \mu(y)$ is well-defined for any measure $\mu \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ as an integral. However, $\int_{\mathbb{R}^{d}} K(y, x) \mathrm{d} \mu(y)$ is not well-defined for $\mu \in \mathcal{Z} \backslash \mathcal{M}\left(\mathbb{R}^{d}\right)$. For fixed $x$, the kernel $K(\cdot, x) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ by assumption $\mathbf{A 3}$ of Theorem 1.1. Hence, $\langle K(\cdot, x), \phi\rangle_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right), \mathcal{Z}}$ is defined for every $x \in \mathbb{R}^{d}$ as the value of $\phi \in \mathcal{Z} \subset\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$ on $K(\cdot, x) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$.

We will always write integral instead of $\langle\cdot, \cdot\rangle$ also when $\mu \in \mathcal{Z} \backslash \mathcal{M}\left(\mathbb{R}^{d}\right)$, realizing the slight abuse of notation. One of the reasons why we do not distinguish notation is that in fact solution to (1.9) is a measure (see Corollary 4.9).

Lemma 3.1. Let $(x \mapsto K(\cdot, x)) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$. Then for any $\mu \in \mathcal{Z}$ the mapping $\mu \mapsto k_{\mu}: \mathcal{Z} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ is well-defined and linear. Moreover, this mapping is continuous.

Proof. Notice that $k_{\mu}$ is differentiable, since $\nabla_{x} k_{\mu}=\int_{\mathbb{R}^{d}} \nabla_{x} K(y, \cdot) \mathrm{d} \mu(y)$. The linearity of the mapping $\mu \mapsto k_{\mu}$ is obvious, thus we concentrate on showing boundedness as a linear map $\mathcal{Z} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$. By definition

We will estimate each term separately

& \sup _{x \in \mathbb{R}^{d}}\left|k_{\mu}(x)\right|=\sup _{x \in \mathbb{R}^{d}}\left|\int_{\mathbb{R}^{d}} K(y, x) \mathrm{d} \mu(y)\right| \leq \sup _{x \in \mathbb{R}^{d}}\|K(\cdot, x)\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}\|\mu\|_{\mathcal{Z}},  \tag{3.29}\\
& \sup _{x \in \mathbb{R}^{d}}\left|\nabla_{x} k_{\mu}(x)\right|=\sup _{x \in \mathbb{R}^{d}}\left|\int_{\mathbb{R}^{d}} \nabla_{x} K(y, x) \mathrm{d} \mu(y)\right| \leq \sup _{x \in \mathbb{R}^{d}}\left\|\nabla_{x} K(\cdot, x)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}\|\mu\|_{\mathcal{Z}} . \tag{3.30}
\end{align*}
$$

We need to argue that $\sup _{x \in \mathbb{R}^{d}}\left\|\nabla_{x} K(\cdot, x)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}$ is bounded. By assumption $(x \mapsto K(\cdot, x)) \in$ $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$ one has that $\nabla_{x} K \in \mathcal{C}^{0+\alpha}\left(\mathbb{R}^{d}\right)$, hence in particular $\nabla_{x} K$ is bounded. One has also, that for any $x$ value $\left\|\nabla_{x} K(\cdot, x)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}$ (the norm $\|\cdot\|_{\mathcal{C}^{1+\alpha}}$ concerns $y$ ) is bounded.

And next

\left|\nabla_{x} k_{\mu}(x)\right|_{\alpha} & =\sup _{\substack{x_{1} \neq x_{2} \\
x_{1}, x_{2} \in \mathbb{R}^{d}}} \frac{\left|\int_{\mathbb{R}^{d}}\left(\nabla_{x} K\left(y, x_{1}\right)-\nabla_{x} K\left(y, x_{2}\right)\right) \mathrm{d} \mu(y)\right|}{\left|x_{1}-x_{2}\right|^{\alpha}}  \tag{3.31}\\
& \leq \sup _{\substack{x_{1} \neq x_{2} \\
x_{1}, x_{2} \in \mathbb{R}^{d}}}\left(\frac{\left.\left\|\nabla_{x}\left(K\left(\cdot, x_{1}\right)-K\left(\cdot, x_{2}\right)\right)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}\right)\|\mu\|_{\mathcal{Z}}}{\left|x_{1}-x_{2}\right|^{\alpha}} .\right.
\end{align*}
$$

The last inequality holds by assumption that $(x \mapsto K(\cdot, x)) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$, which implies that $\nabla_{x} K(\cdot, x) \in \mathcal{C}^{0+\alpha}\left(\mathbb{R}^{d}\right)$. Using (3.29)-(3.31) one obtains that $k_{\mu} \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ and

Therefore, the mapping $\mu \mapsto k_{\mu}$ is continuous linear transformation of $\mathcal{Z}$ into $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$.
Lemma 3.2. If $v \in \mathcal{C}^{1+\alpha}(\mathbb{R})$ and $f, g \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$, then $v \circ f$ and $v \circ g$ are in $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ and moreover

Knowing that $\frac{\partial}{\partial x_{j}}(v \circ f)=\left(v^{\prime} \circ f\right) \frac{\partial f}{\partial x_{j}}$ and making use of estimations (1.6) and (1.7) one obtains

& \leq\left|v^{\prime}\right|_{\alpha}\|\nabla f\|_{\infty}^{\alpha}\left\|\frac{\partial f}{\partial x_{j}}\right\|_{\infty}+\left\|v^{\prime}\right\|_{\infty}\left|\frac{\partial f}{\partial x_{j}}\right|_{\alpha}<\infty
\end{aligned}
$$

Note that for any $\psi \in \mathcal{C}^{1}\left(\mathbb{R}^{d}\right)$ the following holds $|\psi|_{\alpha} \leq \max \left\{2\|\psi\|_{\infty},\|\nabla \psi\|_{\infty}\right\}$ and hence

Proof. Let $f, g \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$. Then, with $v(s)=\left(v_{1}(s), \ldots, v_{d}(s)\right)$ one obtains $\left\|v_{i} \circ f-v_{i} \circ g\right\|_{\infty} \leq\left\|v_{i}^{\prime}\right\|_{\infty}\|f-g\|_{\infty}$

& \quad \leq\left\|\frac{\partial v_{i}}{\partial x_{j}} \circ f-\frac{\partial v_{i}}{\partial x_{j}} \circ g\right\|_{\infty}\left\|\frac{\partial f}{\partial x_{j}}\right\|_{\infty}+\left\|\frac{\partial v_{i}}{\partial x_{j}} \circ g\right\|_{\infty}\left\|\frac{\partial f}{\partial x_{j}}-\frac{\partial g}{\partial x_{j}}\right\|_{\infty}
\end{aligned}
$$

and also

\begin{aligned}
& \left|\frac{\partial}{\partial x_{j}}\left(v_{j} \circ f\right)-\frac{\partial}{\partial x_{j}}\left(v_{i} \circ g\right)\right|_{\alpha} \leq \underbrace{\left|\left(\frac{\partial v_{i}}{\partial x_{j}} \circ f-\frac{\partial v_{i}}{\partial x_{j}} \circ g\right) \frac{\partial f}{\partial x_{j}}\right|_{\alpha}+\left|\left(\frac{\partial v_{i}}{\partial x_{j}} \circ g\right)\left(\frac{\partial f}{\partial x_{j}}-\frac{\partial g}{\partial x_{j}}\right)\right|_{\alpha}}_{\text {according to }} \\
& \leq \underbrace{\left|\frac{\partial v_{i}}{\partial x_{j}} \circ f-\frac{\partial v_{i}}{\partial x_{j}} \circ g\right|_{\alpha}}_{\text {according to Lemma }{ }^{(3.2}}\left\|\frac{\partial f}{\partial x_{j}}\right\|_{\infty}+\left\|\frac{\partial v_{i}}{\partial x_{j}} \circ f-\frac{\partial v_{i}}{\partial x_{j}} \circ g\right\|_{\infty}\left|\frac{\partial f}{\partial x_{j}}\right|_{\alpha} \\

& \leq \max \left\{2\left\|v_{i}^{\prime \prime}\right\|_{\infty}\|f-g\|_{\infty}, \quad\left\|v_{i}^{\prime \prime}\right\|_{\infty}\|\nabla f-\nabla g\|_{\infty}+\left|v^{\prime \prime}\right|_{\alpha}\|f-g\|_{\infty}^{\alpha}\|\nabla g\|_{\infty}\right\}\left\|\frac{\partial f}{\partial x_{j}}\right\|_{\infty} \\
& \quad+\left\|v^{\prime \prime}\right\|_{\infty}\|f-g\|_{\infty}\left|\frac{\partial f}{\partial x_{j}}\right|_{\alpha}+\left(\left|v^{\prime}\right|_{\alpha}\|g\|_{\infty}+\left\|v^{\prime}\right\|_{\infty}|g|_{\alpha}\right)\left\|\frac{\partial f}{\partial x_{j}}-\frac{\partial g}{\partial x_{j}}\right\|_{\infty} \\
& \quad+\left\|v^{\prime}\right\|_{\infty}\left|\frac{\partial f}{\partial x_{j}}-\frac{\partial g}{\partial x_{j}}\right|_{\alpha} .
\end{aligned}
$$

These estimates yields the continuity of $f \mapsto v \circ f$ on $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$.
Corollary 3.4. If $v \in \mathcal{C}^{2+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$ and $S \subset \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ is a separable subset, then $v(S) \subset$ $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$ is a separable subset.

We use this to observe the following:
Corollary 3.5. Let $v \in \mathcal{C}^{2+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$, then $\left\{v\left(k_{\mu}(\cdot)\right): \mu \in \mathcal{Z}\right\}$ is a separable subset of $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$.

Proof. The mapping $\mu \mapsto k_{\mu}: \mathcal{Z} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$ is continuous (see Lemma 3.1). Hence, $S=$ $\left\{k_{\mu}: \mu \in \mathcal{Z}\right\}$ is separable, because $\mathcal{Z}$ is separable (according to Proposition 2.4) Corollary 3.4 implies that $\left\{v\left(k_{\mu}\right): \mu \in \mathcal{Z}\right\}$ is separable.

Lemma 3.6. Under assumptions A1, A2 and A3 of Theorem 1.11 the mapping $\mu \mapsto u\left(k_{\mu}\right)(\cdot)$ is of class $\mathcal{C}^{1}\left(\mathcal{Z} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)$ for $u \in\left\{v_{0}, v_{1}\right\}$ and of class $\mathcal{C}^{1}\left(\mathcal{Z} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}\right)\right)$ for $u \in$ $\left\{m_{0}, m_{1}\right\}$. Moreover, there exist constants $C_{u, K_{u}}, C_{u, K_{u}}^{\prime}>0$ such that

\left\|u\left(k_{\mu}\right)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)} \leq C_{u, K_{u}}\left(1+\|\mu\|_{\mathcal{Z}}+\|\mu\|_{\mathcal{Z}}^{2}\right) \tag{3.33}
\end{equation*}
$$

$$
\text { and } \quad\left\|\partial u\left(k_{\bullet}\right)(\mu)\right\|_{\mathcal{L}\left(\mathcal{Z} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)} \leq C_{u, K_{u}}^{\prime}\left(1+\|\mu\|_{\mathcal{Z}}+\|\mu\|_{\mathcal{Z}}^{1+\alpha}\right)
$$

Remark. Proof of the above lemma requires $u \in \mathcal{C}^{3+\alpha}\left(\mathbb{R}^{d}\right)$ (assumption A1 and A2 of Theorem 1.1), and this is the only place in this paper where such a strong assumption on coefficients is needed. The differentiability of this map is necessary further for the differentiability in parameter. Notice that when $v$ and $m$ are $C^{2+\alpha}$ then Lemma 3.3 holds.

Proof of Lemma 3.6 can be found in the Appendix . Now we present a stronger statement.
Lemma 3.7. For any weight $\omega(t)>0$, under the assumptions A1, A2, A3 of Theorem 1.1] the mapping $\mu_{\bullet} \mapsto u\left(k_{\mu_{\bullet}}\right)(\cdot)$ is of class

\mathcal{C}^{1}\left(\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z}) ; \mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)\right)
$$

for $u \in\left\{v_{0}, v_{1}\right\}$ and similarly for $u \in\left\{m_{0}, m_{1}\right\}$.
Proof of Lemma 3.7 We need to show that the following norm

$$
\sup _{t \geq 0} \omega(t)\left\|u\left(k_{\mu_{t}}\right)-u\left(k_{\bar{\mu}_{t}}\right)-\partial u\left(k_{\bar{\mu}_{t}}\right)\left(\mu_{t}-\bar{\mu}_{t}\right)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)}
$$

can be estimated from above by $\left\|\mu_{\bullet}-\bar{\mu}_{\bullet}\right\|_{\mathcal{Z}_{\omega}}$. We will directly use estimations from proof of Lemma 3.6. Since constants in (3.33) do not depend on time, thus immediately one obtains

& \sup _{t \geq 0} \omega(t)\left\|u\left(k_{\mu_{t}}\right)-u\left(k_{\bar{\mu}_{t}}\right)-\partial u\left(k_{\bar{\mu}_{t}}\right)\left(\mu_{t}-\bar{\mu}_{t}\right)\right\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)} \leq \\
& \leq \sup _{t \geq 0} \omega(t)\left\{\left\|u\left(k_{\mu_{t}}\right)-u\left(k_{\bar{\mu}_{t}}\right)-\partial u\left(k_{\bar{\mu}_{t}}\right)\left(\mu_{t}-\bar{\mu}_{t}\right)\right\|_{\infty}\right\} \\
& +\sup _{t \geq 0} \omega(t)\left\{\left\|\nabla_{x}\left(u\left(k_{\mu_{t}}\right)-u\left(k_{\bar{\mu}_{t}}\right)-\partial u\left(k_{\bar{\mu}_{t}}\right)\left(\mu_{t}-\bar{\mu}_{t}\right)\right)\right\|_{\infty}\right\} \\
& +\sup _{t \geq 0} \omega(t)\left\{\left|\nabla_{x}\left(u\left(k_{\mu_{t}}\right)-u\left(k_{\bar{\mu}_{t}}\right)-\partial u\left(k_{\bar{\mu}_{t}}\right)\left(\mu_{t}-\bar{\mu}_{t}\right)\right)\right|_{\alpha}\right\} \\
& \leq c_{1}\left\|\mu_{\bullet}-\bar{\mu}_{\bullet}\right\|_{\mathcal{Z}_{\omega}}+c_{2}\left\|_{\mu_{\bullet}}-\bar{\mu}_{\bullet}\right\|_{\mathcal{Z}_{\omega}}^{1+\alpha}+c_{3}\left\|\mu_{\bullet}-\bar{\mu}_{\bullet}\right\|_{\mathcal{Z}_{\omega}}^{2} .
\end{aligned}
$$

This finishes the proof.
Since the parameter $h$ is considered in a bounded interval and since $v^{h}=v_{0}+h v_{1}$ and analogously $m^{h}=m_{0}+h m_{1}$ (see (1.8)), the regularity of perturbed coefficients $v^{h}$ and $m^{h}$ can be easily stated.

Corollary 3.8. Under assumption A1, A2, A3 of Theorem [1.1] for any fixed value of parameter $h$ the mapping $\mu_{\bullet} \mapsto u^{h}\left(k_{\mu_{\bullet}}\right)(\cdot)$ is of class

$$
\mathcal{C}^{1}\left(\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z}) ; \mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)\right)
$$

for $u \in\left\{v_{0}, v_{1}\right\}$ and analogously for $u \in\left\{m_{0}, m_{1}\right\}$.
Notice that in the above lemma nothing was assumed about weight $\omega$. We now first compute the Fréchet derivative of $\mu \mapsto u\left(k_{\mu}\right)$ at $\mu_{0}$, assuming that it exists. If it does, then it equals the
directional derivative (Gateaux derivative):

where the limit is in $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$. If it exists, then the limit must also exists pointwise at $x \in \mathbb{R}^{d}$.
In the following, we will omit the evaluation at $x$ in $D_{\bar{\mu}} u\left(k_{\mu}\right), k_{\mu}$ and $k_{\bar{\mu}}$. Then

D_{\bar{\mu}} u\left(k_{\mu}\right) & =\lim _{h \rightarrow 0} \frac{u \circ\left(k_{\mu}+h k_{\bar{\mu}}\right)-u \circ k_{\mu}}{h} \\
& \text { (using Taylor expansion) } \\
& =\lim _{h \rightarrow 0} \frac{u \circ k_{\mu}+h\left(u^{\prime} \circ k_{\mu}\right) k_{\bar{\mu}}+R_{1}\left[u, k_{\mu}\right]\left(k_{\mu}+h k_{\bar{\mu}}\right)-u \circ k_{\mu}}{h}  \tag{3.34}\\
& =\left(u^{\prime} \circ k_{\mu}\right) k_{\bar{\mu}}+\lim _{h \rightarrow 0} \frac{R_{1}\left[u, k_{\mu}\right]\left(k_{\mu}+h k_{\bar{\mu}}\right)}{h}=\left(u^{\prime} \circ k_{\mu}\right) k_{\bar{\mu}},
\end{align*}
$$

where $R_{n+1}\left[f, x_{0}\right](x)$ is the remainder term when expanding a function $x \mapsto f(x)$ in Taylor series at $x_{0}$ up to order $n$. The vanishing of the limit with the remainder term $R_{1}\left[u, k_{\mu}\right]$ follows from the following proposition.

Proposition 3.9. Let $\Omega \subset \mathbb{R}^{d}$ be an open domain and let $f \in \mathcal{C}^{n+\alpha}(\Omega)$, with $n \in \mathbb{N}_{0}, 0<\alpha \leq 1$. Then for any $x, x_{0} \in \Omega$

\left|R_{n}\left[f ; x_{0}\right](x)\right| \leq C_{n, \alpha} \max _{\beta \in \mathbb{N}_{0}^{d},|\beta|=n}\left|D^{\beta} f\right|_{\alpha}\left\|x-x_{0}\right\|^{n+\alpha},
$$

where $C_{n, \alpha}:=\frac{d^{n}}{\alpha(\alpha+1) \cdot \ldots \cdot(\alpha+n-1)}$.
The $D^{\beta}$ is a multi-index notation for vector $\beta$. Hence,

$$
\left|R_{1}\left[u, k_{\mu}\right]\left(k_{\mu}+h k_{\bar{\mu}}\right)(x)\right| \leq C_{1, \alpha}\left|u^{\prime}\right|_{\alpha}|h|^{1+\alpha}\left\|k_{\bar{\mu}}\right\|_{\infty}^{1+\alpha} .
$$

A weak solution $\mu_{\bullet}$ to the non-linear problem (1.1) (or (1.9)) is a weak solution to the linear problem (1.15), where the velocity field $b(t, x)=v_{0}\left(k_{\mu_{t}}(x)\right)$ and production rate $w(t, x)=$ $m_{0}\left(k_{\mu_{t}}(x)\right)$. In order to be able to apply the crucial representation results for the solution to the linear equation (Lemma 2.1) we need to verify that $b$ and $w$ defined by $t \mapsto \mu_{t}$ satisfy the assumptions of this lemma. This is assured by the following.

Lemma 3.10. Let $v_{0} \in \mathcal{C}^{2+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$, $m_{0} \in \mathcal{C}^{2+\alpha}(\mathbb{R})$. Assume moreover, that $x \mapsto K_{u}(\cdot, x)$ is in $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$ for $u \in\left\{v_{0}, m_{0}\right\}$ and that for any $\phi \in\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$ the mapping

$$
y \mapsto\left\langle K_{u}(y, \cdot), \phi\right\rangle \quad \text { is continuous and bounded. }
$$

Then for any narrowly continuous map $\nu_{\bullet}: \mathbb{R}_{+} \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$, the following holds:
(i) $w(t, x):=m_{0}\left(k_{\nu_{t}}(x)\right)($ see notation (1.8)) is separately continuous, bounded and for each $t \geq 0, w(t, \cdot) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$.
(ii) $b(t, x):=v_{0}\left(k_{\nu_{t}}(x)\right)$ is such that $t \mapsto b(t, \cdot): \mathbb{R}_{+} \rightarrow \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$ is weakly continuous. It is Bochner measurable and essentially bounded $t \mapsto b(t, \cdot) \in L^{\infty}\left(\mathbb{R}_{+} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)$.

Proof. For fixed $x \in \mathbb{R}^{d}$, the mapping $y \mapsto K_{u}(y, x)$ is continuous and bounded, hence $t \mapsto$ $k_{\nu_{t}}(x)=\int_{\mathbb{R}^{d}} K_{u}(y, x) \mathrm{d} \nu_{t}(y)$ is also continuous and bounded (by assumption that $t \mapsto \nu_{t}$ is narrowly continuous).
For fixed $t$, the mapping $x \mapsto k_{\nu_{t}}(x) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$. Hence, $x \mapsto w(t, x)$ is $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$, in particular it is Lipschitz. Coefficient $w$ is bounded because $m_{0}$ is bounded. Thus, $w$ satisfies the conditions of Lemma 2.1. Next, $b(t, \cdot) \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right) \subset W^{1, \infty}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$. Moreover, one has

$$
\{b(t, \cdot): t \in[0, T]\} \subset\left\{v_{0}\left(k_{\mu}\right): \mu \in \mathcal{M}\left(\mathbb{R}^{d}\right)\right\} .
$$

The latter set is a separable subset of $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$ according to Corollary 3.5, Furthermore, for any $\phi \in\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)^{*}$, which can be indicated with $\left(\phi_{1}, \ldots, \phi_{d}\right) \in\left[\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)^{*}\right]^{d}$, we have

\left\langle v_{0}\left(k_{\nu_{t}}\right), \phi\right\rangle=\sum_{i=1}^{d}\left\langle v_{0 i}\left(k_{\nu_{t}}\right), \phi_{i}\right\rangle=\sum_{i=1}^{d}\left\langle k_{\nu_{t}}, \phi_{i} \circ v_{0 i}\right\rangle .
$$

Each $\psi_{i}=\phi_{i} \circ v_{0 i} \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)^{*}$. So,

$$
t \mapsto\left\langle v_{0}\left(k_{\nu_{t}}\right), \phi\right\rangle=\sum_{i=1}^{d} \int_{\mathbb{R}^{d}}\left\langle K_{v_{0}}(y, \cdot), \psi_{i}\right\rangle \mathrm{d} \nu_{t}(y)
$$

The functions $y \mapsto\left\langle K_{v_{0}}(y, \cdot), \psi_{i}\right\rangle$ are continuous and bounded by assumption $t \mapsto \nu_{t}$ is narrowly continuous, so $t \mapsto\left\langle v_{0}\left(k_{\nu_{t}}\right), \phi\right\rangle$ is continuous for every $\phi$, hence Borel measurable.

Pettis Measurability Theorem implies that $t \mapsto b(t, \cdot)=v_{0}\left(k_{\nu_{t}}\right)$ is Bochner measurable. As it is bounded,

t \mapsto b(t, \cdot) \in L^{\infty}\left([0, T] ; W^{1, \infty}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right) \subset L^{1}\left([0, T] ; W^{1, \infty}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right)
$$

So, $b$ and $w$ satisfy the conditions of Lemma 2.1 ,
Corollary 3.11. Under conditions of Lemma 3.10 the coefficients $w(t, \cdot)=m_{0}\left(k_{\nu_{t}}\right)$ and $b(t, \cdot)=v_{0}\left(k_{\nu_{t}}\right)$ satisfy the conditions of Lemma [2.1] when restricted to $t \in[0, T], T>0$.

Proof. What is left to prove is that $w$ is (jointly) Borel measurable. This follows from separate continuous in $t$ and $x$, see e.g. [8, Lemma 6.4.6, page 16].

## 4. Existence of weak solution to non-perturbed non-Linear equation

In this section we argue that the non-perturbed, non-linear problem (1.1) has a weak solution. This solution will be denoted by $\mu_{\bullet}^{0}$, to underline that $h=0$. An approximation scheme will be introduced - let us denote by $\nu_{\bullet}^{0, n}$ an approximate solution in $n$-th step of approximation. To obtain the existence of a unique solution we need to show that:
A: The approximation scheme is convergent in $\mathcal{Z}_{\tilde{\omega}}$ i.e. $\lim _{n \rightarrow \infty} \nu_{\bullet}^{0, n}=: \bar{\nu}_{\bullet}^{0}$ exists for every

$$
t \in[0, \infty)
$$

B: The limit $\bar{\nu}_{t}^{0}$ in $\mathcal{Z}$ is in fact a measure - convergence is shown in $\mathcal{Z}$ and the space $\mathcal{M}\left(\mathbb{R}^{d}\right) \subset$ $\mathcal{Z}$ is not complete with the norm $\|\cdot\|_{\mathcal{Z}}$. Hence, an additional argument is needed to establish that $\bar{\nu}_{t}^{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$;
$\mathbf{C}$ : The mapping $t \mapsto \bar{\nu}_{t}^{0}$ is narrowly continuous, so $\bar{\nu}_{\bullet}^{0}$ is a weak solution to (1.1).
D: There is no other solution to (1.1) in the sense of Definition 1.1, when $v_{0} \in \mathcal{C}^{2+\alpha}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)$ and $m_{0} \in \mathcal{C}^{2+\alpha}\left(\mathbb{R}^{d}\right)$, in the space $C_{\omega}([0, \infty) ; \mathcal{Z})$.

In this section we concentrate on showing $\mathbf{A}$.
Using the notation for the superposition operator (introduced in the previous section), non-linear and non-perturbed transport equation can be written as

$$
\left\{\begin{array}{l}
\partial_{t} \mu_{t}^{0}+\operatorname{div}_{x}\left(v_{0}\left(k_{\mu_{t}^{0}}\right) \mu_{t}^{0}\right)=m_{0}\left(k_{\mu_{t}^{0}}\right) \mu_{t}^{0}  \tag{4.35}\\
\mu_{t=0}^{0}=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.
$$

We claim that a solution $t \mapsto \mu_{t}^{0}$ can be obtained as a limit of a sequence $\lim _{n \rightarrow \infty} \nu_{\bullet}^{0, n}$ defined by the following scheme. Recall Lemma 2.1 and Corollary 2.2.
Step 0: A unique continuous mapping $\nu_{\bullet}^{0,0}:[0, \infty) \rightarrow \mathcal{Z}$ solves the equation

$$
\left\{\begin{array}{l}
\partial_{t} \nu_{t}^{0,0}+\operatorname{div}_{x}\left(v_{0}\left(k_{\mu_{0}}\right) \nu_{t}^{0,0}\right)=m_{0}\left(k_{\mu_{0}}\right) \nu_{t}^{0,0},  \tag{4.36}\\
\nu_{0}^{0,0}=\mu_{0}
\end{array}\right.
$$

and $\nu_{t}^{0,0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ and $t \mapsto \nu_{t}^{0,0}$ is narrowly continuous.
Step 1: For $n \geq 1$, a unique continuous mapping $\nu_{\bullet}^{0, n}:[0, \infty) \rightarrow \mathcal{Z}$ solves the equation

$$
\left\{\begin{array}{l}
\partial_{t} \nu_{t}^{0, n}+\operatorname{div}_{x}\left(v_{0}\left(k_{\nu_{t}^{0, n-1}}\right) \nu_{t}^{0, n}\right)=m_{0}\left(k_{\nu_{t}^{0, n-1}}\right) \nu_{t}^{0, n},  \tag{4.37}\\
\nu_{0}^{0, n}=\mu_{0},
\end{array}\right.
$$

and $\nu_{t}^{0, n} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ and $t \mapsto \nu_{t}^{0,0}$ is narrowly continuous.
Note that in every step of approximation $\nu_{\bullet}^{0, n}$ solves the linear problem i.e. the coefficients do not depend on the solution. Moreover, notice that if only the mappings $\left(t \mapsto v_{0}\left(k_{\nu_{t}}\right)(\cdot)\right)$, $\left(t \mapsto m_{0}\left(k_{\nu_{t}}\right)(\cdot)\right)$ of $[0, \infty)$ into $\mathcal{C}^{1+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$ and respectively $\mathcal{C}^{1+\alpha}(\mathbb{R}, \mathbb{R})$ are continuous and bounded, then immediately according to Lemma 2.1 (representation formula) one has existence and uniqueness of weak solution $\nu_{0}$ to the problem

$$
\left\{\begin{array}{l}

Indeed, according to Lemma 3.7 one has that for any $\nu_{\bullet} \in \mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{M}\left(\mathbb{R}^{d}\right)\right)$, coefficients $v_{0}\left(k_{\nu_{\mathbf{\bullet}}}\right)$ and $m_{0}\left(k_{\nu_{\mathbf{0}}}\right)$ are of the class $\mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)\right)$ and $\mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{C}^{1+\alpha}(\mathbb{R} ; \mathbb{R})\right)$ respectively. Hence, (4.38) has unique weak solution in a class of mappings $\mathcal{C}_{\omega}\left([0, \infty) ; \mathcal{M}\left(\mathbb{R}^{d}\right)\right)$.
The approximation scheme makes that a sequence $\left\{\nu_{t}^{0, n}\right\}_{n \in \mathbb{N}}$ can be viewed as realised by repeated application of a suitable operator $\mathcal{T}$ on a subset of $\mathcal{C}([0, \infty) ; \mathcal{Z})$. To make this precise, consider $T>0$ and

Proposition 4.1. Let $v_{0} \in \mathcal{C}^{2+\alpha}\left(\mathbb{R} ; \mathbb{R}^{d}\right)$ and $m_{0} \in \mathcal{C}^{2+\alpha}(\mathbb{R} ; \mathbb{R})$. Assume moreover, that $x \mapsto$ $K_{v_{0}}(\cdot, x)$ and $x \mapsto K_{m_{0}}(\cdot, x)$ are in $\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)$, while for every $\psi \in\left(\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)^{*}$, the mapping $y \mapsto\left\langle K_{u}(y, \cdot), \psi\right\rangle$ is continuous and bounded. Then a mapping $\nu_{\bullet}:[0, \infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ is a weak solution to the non-linear problem (1.1) with initial condition $\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ if and only if $\nu_{\bullet} \in \mathcal{C}([0, \infty) ; \mathcal{Z}), \nu_{0}=\mu_{0}$ and $\nu_{\bullet}$ is a fixed point of $\mathcal{T}: \mathcal{T}\left(\nu_{\bullet}\right)=\nu_{\bullet}$.

Proof. If $\nu_{\bullet}:[0, \infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ is a weak solution to (1.1) with initial condition $\mu_{0}$, then $\nu_{\bullet}$ is a weak solution to the linear equation (1.15) with coefficients (see notation (1.8)):

Corollary 2.2 yields, that $\nu_{\bullet}:[0, \infty) \rightarrow \mathcal{Z}$ is continuous, $\nu_{0}=\mu_{0}, B(b, w)$ and $S(b, w)=\nu_{\bullet}$. Hence, one has $\nu_{\bullet}=\mathcal{T}\left(\nu_{\bullet}\right)$.
For the other implication, let $\nu_{\bullet} \in \mathcal{C}([0, \infty) ; \mathcal{Z})$ be a fixed point for $\mathcal{T}$ with $\nu_{0}=\mu_{0}$. By construction, $\nu_{\bullet}=\mathcal{T}\left(\nu_{\bullet}\right)=S\left(B\left(\nu_{\bullet}\right)\right)$ then is weak solution to the linear equation with $b(t, \cdot)=$ $v_{0}\left(k_{\nu_{t}}\right)$ and $w(t, \cdot)=m_{0}\left(k_{\nu_{t}}\right)$. Thus it is a weak solution to the non-linear equation (1.1).

We shall now construct a (unique) fixed point of $\mathcal{T}$, in a suitable subset of $\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z})$ of $\mathcal{C}([0, \infty) ; \mathcal{Z})$. We cannot exclude existence of fixed points of $\mathcal{T}$ outside $\mathcal{C}_{\omega}([0, \infty) ; \mathcal{Z})$. To that end, let us define

Recall the later condition implies that $\mathcal{Z}_{\omega}^{T}$ is complete. Moreover, assume that

Let us notice that $\mathcal{B}_{\omega}^{\mu_{0}, T}$ is a closed bounded subset of $\mathcal{Z}_{\omega}^{T}$, hence complete. It is non-empty as it contains the constant function $t \mapsto \mu_{0}$. Because of (4.40), $\mathcal{T}$ maps $\mathcal{B}_{\omega}^{\mu_{0}, T}$ into itself.

Proposition 4.2. For any finite $T>0$ and any $0 \leq c<1$, there exists a constant $g \geq$ $\left\|m_{0}\right\|_{\infty}>0$, such that the weight $\omega(t)=e^{-g t}$ makes the operator $\mathcal{T}=S \circ B: \mathcal{B}_{\omega}^{\mu_{0}, T} \rightarrow \mathcal{B}_{\omega}^{\mu_{0}, T}$ a contraction, where the Lipschitz constant of contraction of $\mathcal{T}$ is less or equal to $c$.

To prove above lemma we need to first show some properties of operators $S$ and $B$. The proof of Proposition 4.2 will be conducted on page 24, Let us argue that indeed operators $B$ and $S$ act between proper function spaces.

Observe that for a given $\nu_{\bullet}^{0, n}$ the operators $v_{0}\left(k_{\nu_{\bullet}, n}\right)$ and $m_{0}\left(k_{\nu!, n}^{0, n}\right)$ can be seen as functions $b(t, x)$ and $w(t, x)$ in linear problem. According to Lemma3.7 coefficients $b$ and $w$ satisfy assumptions of Theorem 2.11.

In particular, the mapping $v_{0} \mapsto\left\|B\left(\nu_{\mathbf{\bullet}}\right)\right\|_{\infty}$ and $v_{0} \mapsto\left\|\nabla B\left(\nu_{\mathbf{\bullet}}\right)\right\|_{\infty}$ are bounded on $\mathcal{B}_{\omega}^{\mu_{0}, T}$.

Function $C_{s}[b, \bar{b}]$ is also non-deceasing, thus $C_{s}[b, \bar{b}] \leq C_{t}[b, \bar{b}]$, and hence

$$

Estimate for $I_{3}$. One gets

& \leq \max \left\{e^{t\|w(\cdot, \cdot)\|_{\infty}}, e^{t\|\bar{w}(\cdot, \cdot)\|_{\infty}}\right\} \int_{0}^{t}\|\bar{w}(s, \cdot)-w(s, \cdot)\|_{\infty} \mathrm{d} s

Combining estimates for $I_{1}, I_{2}$ and $I_{3}$ and taking supremum over $f \in \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)$, such that $\|f\|_{\mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)} \leq 1$ one obtains

& \quad+\int_{\mathbb{R}^{d}}\left(\exp \left(t\left(\|\bar{w}(\cdot, \cdot)\|_{\infty}+C_{t}[b, \bar{b}]\right)\right) t\left\|\nabla_{x} \bar{w}\right\|_{t, \infty} \int_{0}^{t}\|b(s, \cdot)-\bar{b}(s, \cdot)\|_{\infty} \mathrm{d} s\right) \mathrm{d} \nu_{0}(x) \\
& \quad+\int_{\mathbb{R}^{d}}\left(\max \left\{\exp \left(t\|w(\cdot, \cdot)\|_{\infty}, \exp \left(t\|\bar{w}(\cdot, \cdot)\|_{\infty}\right)\right\} \int_{0}^{t}\|w(s, \cdot)-\bar{w}(s, \cdot)\|_{\infty} \mathrm{d} s\right) \mathrm{d} \nu_{0}(x)\right.
\end{aligned}

\begin{aligned}
& \leq \exp \left(t\left(\max \left\{\|w\|_{\infty},\|\bar{w}\|_{\infty}\right\}+C_{t}[b, \bar{b}]\right)\right)\left(1+t C_{t}[w, \bar{w}]\right)\left\|\nu_{0}\right\|_{T V} \\
& \quad\left(\int_{0}^{t}\|b(s, \cdot)-\bar{b}(s, \cdot)\|_{\infty} \mathrm{d} s+\int_{0}^{t}\|w(s, \cdot)-\bar{w}(s, \cdot)\|_{\infty} \mathrm{d} s\right)
\end{aligned}

This finishes the proof.

Let us go back to operator $B$.
Lemma 4.6. Assume that $M_{0}:=\max \left\{\left\|K_{v_{0}}\right\|_{\mathcal{C}_{b}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)},\left\|K_{m_{0}}\right\|_{\mathcal{C}_{b}\left(\mathbb{R}^{d} ; \mathcal{C}^{1+\alpha}\left(\mathbb{R}^{d}\right)\right)}\right\}<\infty$. Then for any $\nu_{\bullet}, \bar{\nu}_{\bullet} \in \mathcal{C}([0,+\infty) ; \mathcal{Z})$ the following estimate holds

\end{gather*}

by definition of $L_{0}$ one obtains

+L_{0}\left\|\int_{\mathbb{R}^{d}} K_{m_{0}}(y, \cdot) \mathrm{d} \nu_{t}(y)-\int_{\mathbb{R}^{d}} K_{m_{0}}(y, \cdot) \mathrm{d} \bar{\nu}_{t}(y)\right\|_{\infty}
\end{gathered}

Finally, according to Lemma 3.1 for $u \in\left\{v_{0}, m_{0}\right\}$

Now we are going back to the operator $\mathcal{T}$ as a composition of $S$ and $B$ and we want to show that it is a contraction on $\mathcal{B}_{\omega}^{\mu_{0}, T}$ for a suitable weight $\omega(t)$.

Proof of Proposition4.2 Let $\nu_{\bullet}, \bar{\nu}_{\bullet} \in \mathcal{B}_{\omega}^{\mu_{0}, T}$. Then for any $g>0$

Use Lemma4.6 and denote $2 L_{0} M_{0}=: D$ (occurs in Lemma4.6)

& =e^{-g t+A_{1}(t)} A_{2}(t) D \int_{0}^{t} e^{g s} e^{-g s}\left\|\nu_{s}-\bar{\nu}_{s}\right\|_{\mathcal{Z}} \mathrm{d} s \\
& \leq e^{A_{1}(t)} A_{2}(t) D \int_{0}^{t} e^{-g(t-s)} \sup _{0 \leq s \leq t} e^{-g s}\left\|\nu_{s}-\bar{\nu}_{s}\right\|_{\mathcal{Z}} \mathrm{d} s \\
& \leq e^{A_{1}(t)} A_{2}(t) D\left\|\nu_{s}-\bar{\nu}_{s}\right\|_{\mathcal{Z}_{\omega}} \int_{0}^{t} e^{-g s} \mathrm{~d} s \\
& \leq \frac{A_{2}(t) D}{g} e^{A_{1}(t)}\left\|\nu_{t}-\bar{\nu}_{t}\right\|_{\mathcal{Z}_{\omega}}

Notice that for any $t \in[0, T]$ functions $A_{2}(t)$ and $e^{A_{1}(t)}$ are bounded because of Lemma 4.4, This bound is independent of $\nu_{\bullet}$ and $\bar{\nu}_{\bullet}$ (but dependent on $\left\|\mu_{0}\right\|_{T V}$ ). The constant $D$ is independent of time. Thus for any finite $T$ one can establish appropriate value of $g \geq\left\|m_{0}\right\|_{\infty}$ providing $\frac{A_{2}(t) D}{g} e^{A_{1}(t)} \leq c<1$ for all $t \in[0, T]$. Therefore one obtains

Remark. A conclusion from Proposition4.2 is that for any bounded interval $\left[t_{1}, t_{2}\right]$ there exists a constant $g>0$, such that $\omega(t)=e^{-g t}$ and the operator $\mathcal{T}$ is contraction on $\mathcal{C}_{\omega}\left(\left[t_{1}, t_{2}\right] ; \mathcal{Z}\right)$.

Now we would like to extend Proposition 4.2 on the interval $[0,+\infty)$. It is impossible to state that $\mathcal{T}$ is contraction on $[0, \infty)$ with weight $\omega(t)=e^{-g t}$ for a single fixed $g \geq\left\|m_{0}\right\|_{\infty}$. Let us take

where $g_{n} \geq\left\|m_{0}\right\|_{\infty}$ is a positive constant for $n \in \mathbb{N}$ such that for fixed $0<c<1$ and $M_{n} \equiv 1$ for all $n$, the following estimate holds

for all

\begin{equation*}
\nu_{\bullet}, \bar{\nu}_{\bullet} \in \widehat{\mathcal{B}}_{\omega}^{\mu_{0}}:=\left\{f \in \mathcal{Z}_{\omega}: f(0)=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right),\|f\|_{\mathcal{Z}_{\omega}} \leq\left\|\mu_{0}\right\|_{T V}\right\} \tag{4.48}
\end{equation*}

see notation (4.42). Thus, summarizing:
Proposition 4.7. Let $0 \leq c<1$ and the weight $\omega_{1}: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$be defined by (4.46). Then the operator $\mathcal{T}=S \circ B: \widehat{\mathcal{B}}_{\omega_{1}}^{\mu_{0}} \rightarrow \widehat{\mathcal{B}}_{\omega_{1}}^{\mu_{0}}$ is a contraction

Proposition 4.8. Let coefficients $v_{0}, m_{0}$ satisfy assumptions of Theorem 1.1 and let weight be defined by (4.46). Then according to Proposition 4.7 and Banach Fixed-Point Theorem one has, that the approximate scheme described by (4.36) and (4.37) is convergent. It means that there exists $\bar{\nu}_{\bullet}:[0, \infty) \rightarrow \mathcal{Z}$ such that

Notice that the weight defined in (4.46) is the same as in (1.14). Recall that the weight used in Theorem 1.1 is defined by (1.13). Since $\tilde{\omega}(t) \leq \omega_{1}(t)$ for all $t \in[0, \infty)$, above argumentation stays true for $\tilde{\omega}$.

Corollary 4.9. Note that by the fixed point of $\mathcal{T}$, the mapping $t \mapsto \bar{\nu}_{t}^{0}$ in $\mathcal{Z}_{\omega_{1}}$ solves the problem (1.1), where $t \mapsto \bar{\nu}_{t}^{0}$ is the limit of approximation scheme given by (4.36) and (4.37). Being a fixed point of $\mathcal{T}$, the mapping $\bar{\nu}_{\bullet}^{0}$ solves the linear equation with coefficients $b(t, x)=v_{0}\left(k_{\bar{\nu}_{t}}\right)$, $w(t, x)=m_{0}\left(k_{\bar{\nu}_{t}}\right)$, hence $\bar{\nu}_{t}^{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$ for all $t \geq 0$. Moreover $t \mapsto \bar{\nu}_{t}^{0}$ is narrowly continuous.

## 5. APROXIMATION SCHEME FOR PERTURBED EQUATION

Recall the perturbed equation (1.9) and its solution $\mu_{\bullet}^{h}$ for $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$. The existence of a unique weak solution in the sense of Definition 1.1 has been established in the previous section for $h=0$ by means of exhibiting $\mu_{\bullet}^{0}$ as the limit in $\mathcal{Z}_{\omega_{1}}$ of a sequence of approximate solutions $\left\{\nu_{\bullet}^{0, n}\right\}_{n}$. In a similar way one can show the existence of a unique weak solution $\mu_{\bullet}^{h}$ for general $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$ by changing the velocity fields and production rates. The resulting sequence of approximation to $\mu_{\bullet}^{h}$ is not convenient for showing the continuous differentiability of $h \mapsto \mu_{\bullet}^{h}$ in $\mathcal{Z}_{\omega_{1}}$. For reaching this main objective we prefer another approximation scheme that we shall now introduce.

Problem (1.9) can be written as

$$

\partial_{t} \mu_{t}^{h}+\operatorname{div}_{x}\left(\left(v_{0}\left(k_{\mu_{t}^{h}}\right)+h v_{1}\left(k_{\mu_{t}^{h}}\right)\right) \mu_{t}^{h}\right)=\left(m_{0}\left(k_{\mu_{t}^{h}}\right)+h m_{1}\left(k_{\mu_{t}^{h}}\right)\right) \mu_{t}^{h}  \tag{5.49}\\
\mu_{t=0}^{h}=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right) .
\end{array}\right.
$$

We assume that coefficients satisfy the assumptions of Theorem 1.1. A solution $\mu_{\bullet}^{h}$ can be approximated by a sequence $\left\{\nu_{\bullet}^{h, n}\right\}_{n}$ defined by the following scheme. Recall that $\mathcal{M}\left(\mathbb{R}^{d}\right)$ is equipped with the topology of $\mathcal{Z}$.

Step 0: A unique continuous mapping $\mu_{\bullet}^{0}:[0, \infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ solves the non-perturbed, nonlinear equation

\partial_{t} \mu_{t}^{0}+\operatorname{div}_{x}\left(v_{0}\left(k_{\mu_{t}^{0}}\right) \mu_{t}^{0}\right)=m_{0}\left(k_{\mu_{t}^{0}}\right) \mu_{t}^{0}  \tag{5.50}\\
\mu_{t=0}^{0}=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.
$$

From previous section one has that there exists a unique weak solution to (5.50) such that $\mu_{t}^{0}$ is a bounded Radon measure; see Corollary 4.9. Recall that one has $\lim _{n \rightarrow \infty}\left\|\mu_{\bullet}^{0}-\nu_{\bullet}^{0, n}\right\|_{\mathcal{E}_{\omega_{1}}}=0$. Define $\nu_{t}^{h, 0}:=\mu_{t}^{0}$.

Step 1: For $n \geq 1$, a unique continuous mapping $\nu_{\bullet}^{h, n}:[0, \infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ solves the linear equation

\partial_{t} \nu_{t}^{h, n}+\operatorname{div}_{x}\left[\left(v_{0}\left(k_{\nu_{t}^{h, n-1}}\right)+h v_{1}\left(k_{\nu_{t}^{h, n-1}}\right)\right) \nu_{t}^{h, n}\right]=\left[m_{0}\left(k_{\nu_{t}^{h, n-1}}\right)+h m_{1}\left(k_{\nu_{t}^{h, n-1}}\right)\right] \nu_{t}^{h, n} \\
\nu_{0}^{h, n}=\mu_{0} .
\end{array}\right.
$$

Notice that for $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$ and for every solution to the linear equation $\nu_{\bullet}^{h, n}$, the coefficients

v_{0}\left(k_{\nu_{\bullet}^{h, n}}\right)+h v_{1}\left(k_{\nu_{\bullet}^{h, n}}\right) \quad \text { and } \quad m_{0}\left(k_{\nu_{\bullet}^{h, n}}\right)+h m_{1}\left(k_{\nu_{\bullet}^{h, n}}\right)
$$

satisfy the assumptions of Lemma 2.1, see Corollary 3.11. By Corollary (4.9) one has that $\mu_{t}^{0}$ is bounded Radon measure. For $n=1$, the problem (5.51) is the linear equation with measure initial condition $\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)$. Hence by Lemma 2.1 solution $\nu_{t}^{h, 1}$ also is a bounded Radon measure and $t \mapsto \nu_{t}^{h, 1}$ is the unique solution in the class of narrowly continuous mapping. Identically for every $\nu_{t}^{h, n}$, where $n \in \mathbb{N}$. Also note that $\nu_{t}^{0,0}=\mu_{t}^{0}$ for all $n$ in this approximation scheme, which differs from that in Section4for $h=0$.
Let us consider the following problem, where $\mu_{\bullet}:[0, \infty) \rightarrow \mathcal{M}\left(\mathbb{R}^{d}\right)$ is given:

\widehat{\mu}_{t=0}=\mu_{0} \in \mathcal{M}\left(\mathbb{R}^{d}\right)
\end{array}\right.
$$

Define an operator $\mathcal{T}_{h}\left(\mu_{\bullet}\right):=\widehat{\mu}_{\bullet}$. Similar to Section 4 and Proposition 4.1 for the case $h=0$ any fixed point of this operator is a solution to problem (5.49). Similarly to previous reasoning (i.e. as in the case for $\mathcal{T}$ ) the operator $\mathcal{T}_{h}$ can be regarded as a composition of two operators $\mathcal{T}_{h}=B_{h} \circ S$; see page 20, Operator $S$ is identical to the previously considered operator. Second operator $B_{h}$ describes how the approximated solution influences the velocity field $v_{0}\left(k_{\nu_{t}^{h, m}}\right)$ and the function $m_{0}\left(k_{\nu_{t}^{h, m}}\right)$, which will be used in the $(m+1)$-th step of approximation scheme (as before like in the case of operator $B$ ). Now, the operator $B_{h}$ depends also on parameter $h$, hence

Since $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$, thus the domain and values of operator $B_{h}$ are identical as for operator $B$

see page 20, All reasoning concerning operator $B$ described in Section 4 can be conducted also for the operator $B_{h}$. In particular, the direct analogy of Proposition 4.7 is the following proposition.

Proposition 5.1. Let $0<c<1$ and the weight $\omega_{1}$ be defined by (4.46) with $\mathcal{T}_{h}=S \circ B_{h}$ replacing $\mathcal{T}$, such that (4.47) holds for all $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$. Then $T_{h}: \widehat{\mathcal{B}}_{\omega_{1}}^{\mu_{0}} \rightarrow \widehat{\mathcal{B}}_{\omega_{1}}^{\mu_{0}}$ is contraction with contraction constant c for any $h \in\left(-\frac{1}{2} ; \frac{1}{2}\right)$; see notation (4.48).
The unique fixed point of operator $\mathcal{T}_{h}$ in $\widehat{\mathcal{B}}_{\omega_{1}}^{\mu_{0}}$ (which is $\mu_{\bullet}^{h}$ ) has such the property that

$$
\lim _{n \rightarrow \infty}\left\|\mu_{\bullet}^{h}-\nu_{\bullet}^{h, n}\right\|_{\mathcal{Z}_{\omega_{1}}}=0
$$

Moreover $t \mapsto \mu_{t}^{h}$ is the unique weak solution to problem (1.9).

## 6. Proof of Theorem 1.1

In this section we finally provide a proof of the main result, Theorem 1.1. Thus, under assumption A1-A4 of that theorem we now want to show that $\lim _{\lambda \rightarrow 0} \frac{\mu_{\bullet}^{h+\lambda}-\mu_{\bullet}^{h}}{\lambda}$ exists in $\mathcal{Z}_{\tilde{\omega}}$ for any fixed $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$, where the weight $\tilde{\omega}$ is defined by (1.13). Moreover, we prove that the mapping $h \mapsto \mu_{\bullet}^{h}:\left(-\frac{1}{2} ; \frac{1}{2}\right) \rightarrow \mathcal{Z}_{\tilde{\omega}}$ is $\mathcal{C}^{1}$. First, we consider differentiability at $h=0$, hence the limit

\end{equation*}
$$

is investigated. Using Proposition5.1we know that for fixed $\lambda \in\left(-\frac{1}{2}, \frac{1}{2}\right)$ one has $\lim _{n \rightarrow \infty} \| \mu_{\bullet}^{\lambda}-$ $\nu_{\bullet}^{\lambda, n} \|_{\mathcal{Z}_{\bar{\omega}}}=0$. Hence, instead of (6.53) the double limit

\lim _{\lambda \rightarrow 0}\left(\lim _{n \rightarrow \infty} \frac{\nu_{\bullet}^{\lambda, n}-\mu_{\bullet}^{0}}{\lambda}\right)

is considered. We proceed by arguing that the order of limits can be changed. Then we can make use of results concerning the linear transport equation, in particular Theorem 2.11. The following theorem will be involved.

Theorem 6.1. Let $E$ be a set in a metric space and $\lambda_{0}$ be a limit point of $E$. Suppose that $(Y, d)$ is a complete metric space. Let $f_{n}, f: E \rightarrow Y$ such that $f_{n} \rightarrow f$ uniformly on $E$ and

\lim _{\lambda \rightarrow \lambda_{0}} f_{n}(\lambda)=A_{n}, \quad(n=1,2,3, \ldots)
$$

exists. Then the sequence $A_{n}$ converges in $Y$ and $\lim _{\lambda \rightarrow \lambda_{0}} f(\lambda)=\lim _{n \rightarrow \infty} A_{n}$.
Above theorem is an analog of Theorem 7.11 in [31, page 149]. The proof remains essentially the same as in [31].

In our case $E=\left(-\frac{1}{2}, \frac{1}{2}\right) \backslash\{0\}$. Set $Y=\mathcal{Z}_{\tilde{\omega}}$, let $\lambda_{0}=0$ and

f_{n}(\lambda):=\frac{\nu_{\bullet}^{\lambda, n}-\mu_{\bullet}^{0}}{\lambda} \quad \text { and } \quad f(\lambda):=\lim _{n \rightarrow \infty} f_{n}(\lambda)=\frac{\mu_{\bullet}^{\lambda}-\mu_{\bullet}^{0}}{\lambda} .
$$

Each $f_{n}(\lambda)$ is a $\mathcal{M}\left(\mathbb{R}^{d}\right)$-valued function on $[0, \infty)$ which can be evaluated at $t$. In other words, to state that

\lim _{\lambda \rightarrow \lambda_{0}} \lim _{n \rightarrow \infty} f_{n}(\lambda)=\lim _{n \rightarrow \infty} \lim _{\lambda \rightarrow \lambda_{0}} f_{n}(\lambda),
$$

we need to argue that $f_{n}$ converges uniformly to $f$ in $E$ (1st Step of the proof) and also show that for all $n$ the limit $\lim _{\lambda \rightarrow \lambda_{0}} f_{n}(\lambda)$ exists in $\mathcal{Z}_{\tilde{\omega}}$ (2nd Step). Both limits are considered in $\mathcal{Z}_{\tilde{\omega}}$. In 3rd Step we will show that the result remains true for any $h \in\left(-\frac{1}{2}, \frac{1}{2}\right)$.

Step 1. Recall that the space $\mathcal{Z}_{\tilde{\omega}}$ is complete. We investigate uniform convergence $\left\{\frac{\nu_{\bullet}^{\lambda, n}-\mu_{\bullet}^{0}}{\lambda}\right\}_{n}$ in $\mathcal{Z}_{\tilde{\omega}}$ for $\lambda \in E$ to $\frac{\mu_{\dot{\circ}}-\mu_{0}^{0}}{\lambda}$. We want to argue that it is a Cauchy sequence, then as a sequence in complete space $\mathcal{Z}_{\tilde{\omega}}$ its limit also is in $\mathcal{Z}_{\tilde{\omega}}$. Using a property of approximating scheme this limit will be then $\frac{\mu_{\bullet}^{\lambda}-\mu_{\dot{0}}^{0}}{\lambda}$. To show that the norm $\left\|\frac{\nu_{\dot{\prime}, n}^{\lambda}-\mu_{0}^{0}}{\lambda}-\frac{\nu_{\bullet}^{\lambda, m}-\mu_{\bullet}^{0}}{\lambda}\right\|_{\mathcal{Z}_{\tilde{\omega}}}$ can be made arbitrary small when $n, m \rightarrow \infty$ uniformly for $\lambda \in E$, we will need a few additional estimates.

Proposition 6.2. If the coefficients satisfy the assumptions of Theorem 1.1] then the limit

$$
\lim _{\lambda \rightarrow 0} \frac{\nu_{\bullet}^{\lambda, 1}-\mu_{\bullet}^{0}}{\lambda}
$$

exists and is an element of $\mathcal{Z}_{\tilde{\omega}}$. Moreover, the following estimate holds

$$
\begin{equation*}
\left\|\frac{\nu_{t}^{\lambda, 1}-\mu_{t}^{0}}{\lambda}\right\|_{\mathcal{Z}} \leq C(t)\left\|\left.\partial_{\lambda} \nu_{t}^{\lambda, 1}\right|_{\lambda=0}\right\|_{\mathcal{Z}} \tag{6.54}
\end{equation*}
$$

where $C(t)=\mathcal{O}\left(t e^{g t}\right)$ and $g>0$ can be chosen to hold for all $\lambda \in E$.
Notice that in estimation (6.54) on the one hand the weight $\tilde{\omega}$ needs to reduce $C(t)$ but also it reduces the growth of $\partial_{\lambda} \nu_{t}^{\lambda, 1}$ in time. That is why $\omega_{2}$ occurs in the construction of weight $\tilde{\omega}$ in (1.13).

Proof. The mapping $\mu_{\bullet}^{0}$ is a solution to

\partial_{t} \nu_{t}^{\lambda, 1}+\operatorname{div}_{x}\left[\left(v_{0}\left(k_{\mu_{t}^{0}}\right)+\lambda v_{1}\left(k_{\mu_{t}^{0}}\right)\right) \nu_{t}^{\lambda, 1}\right]=\left[m_{0}\left(k_{\mu_{t}^{0}}\right)+\lambda m_{1}\left(k_{\mu_{t}^{0}}\right)\right] \nu_{t}^{\lambda, 1}  \tag{6.56}\\
\nu_{0}^{\lambda, 1}=\mu_{0} .
\end{array}\right.
$$

Solution $\mu_{\bullet}^{0}$ can be obtained using approximating scheme. The coefficients $v_{0}\left(k_{\mu_{t}^{0}}\right), v_{1}\left(k_{\mu_{t}^{0}}\right)$, $m_{0}\left(k_{\mu_{t}^{0}}\right), m_{1}\left(k_{\mu_{t}^{0}}\right)$ in the above problems are fixed i.e. coefficients does not depend on solution. It means that the problem (6.55) can be seen as the linear one

\end{array}\right.

and similarly (6.56) can be rewritten into a form

\partial_{t} \nu_{t}^{\lambda, 1}+\operatorname{div}_{x}\left(\left(\bar{b}_{0}(t, x)+\lambda \bar{b}_{1}(t, x)\right) \nu_{t}^{\lambda, 1}\right)=\left(\bar{w}_{0}(t, x)+\lambda \bar{w}_{1}(t, x)\right) \nu_{t}^{\lambda, 1}  \tag{6.56}\\
\nu_{0}^{\lambda, 1}=\mu_{0}
\end{array}\right.
$$

where $\bar{b}_{i}(t, x):=v_{i}\left(k_{\mu_{t}^{0}}\right)$ and $\bar{w}_{i}(t, x):=m_{i}\left(k_{\mu_{t}^{0}}\right)$ for $i=0,1$. By Lemma 3.6 we know that these coefficients satisfy assumptions of Theorem 2.10. Thus, the limit $\lim _{\lambda \rightarrow 0} \frac{\nu_{t}^{\lambda, 1}-\mu_{t}^{0}}{\lambda}$ is the derivative of the solution to linear equation (2.26) with perturbation (2.25). Theorem 2.11 states that this derivative exists and is an element of $\mathcal{Z}$. Hence estimate (6.54) is true for fixed $t$. By Theorem 2.11 one has $\lim _{\lambda \rightarrow 0} \frac{\nu_{\bullet}^{\lambda, 1}-\mu_{\bullet}^{0}}{\lambda} \in \mathcal{Z}_{\widehat{\omega}}$. Since $\widehat{\omega}(t)<\tilde{\omega}(t)$ for all $t \in[0, \infty)$, hence this limit is an element of $\mathcal{Z}_{\tilde{\omega}}$.
Proposition 6.3. For any fixed $t$ and any $n$ the following estimates holds on $\left(-\frac{1}{2}, \frac{1}{2}\right) \backslash\{0\}$

\left\|\frac{\nu_{t}^{\lambda, n+1}-\nu_{t}^{\lambda, n}}{\lambda}\right\|_{\mathcal{Z}} \leq C(t) c^{n}\left\|\left.\partial_{\lambda} \nu_{t}^{\lambda, 1}\right|_{\lambda=0}\right\|_{\mathcal{Z}}
$$

where constant $c<1$, and $C(t)=\mathcal{O}\left(t e^{g t}\right)$ are independent of $n$ and can be chosen to hold uniformly for $\lambda \in E$.

Proof. First, let us recall that the operator $\mathcal{T}_{h}$ is a contraction in $\mathcal{Z}_{\omega_{1}}$ with a contraction constant $c<1$ (cf. Proposition 5.1). Hence it is contraction also in $\mathcal{Z}_{\tilde{\omega}}$ with the same contraction constant. One obtains

& =c\left\|\frac{\mathcal{T}_{h}\left(\nu_{\bullet}^{\lambda, n-1}\right)-\mathcal{T}_{h}\left(\nu_{\bullet}^{\lambda, n-2}\right)}{\lambda}\right\|_{\mathcal{Z}_{\tilde{\omega}}} \leq c^{2}\left\|\frac{\nu_{\bullet}^{\lambda, n-1}-\nu_{\bullet}^{\lambda, n-2}}{\lambda}\right\|_{\mathcal{Z}_{\tilde{\omega}}} \leq \cdots \leq c^{n}\left\|\frac{\nu_{\dot{\bullet}}^{\lambda, 1}-\mu_{\bullet}^{0}}{\lambda}\right\|_{\mathcal{Z}_{\tilde{\omega}}},
\end{align*}
$$

where $c<1$. Making use of Proposition 6.2 and estimates (6.57) we have

Note that $C(t)$ is independent of $n$ and can be established to hold uniformly for $\lambda \in E$. The growth of $C(t)$ is described by Theorem 2.11 i.e. it is reduced by $\omega_{2}(t)$. Hence, it is reduced also by weight $\tilde{\omega}(t) \leq \omega_{2}(t)$.

Now, it will be argued that $\left\{\frac{\nu_{\bullet}^{\lambda, n}-\mu_{\bullet}^{0}}{\lambda}\right\}_{n}$ is a Cauchy sequence.
Lemma 6.4. The sequence $\left\{\frac{\nu_{\stackrel{\lambda}{\lambda}, n}^{\lambda}-\mu_{0}^{0}}{\lambda}\right\}_{n}$ converges uniformly for $\lambda \in\left(-\frac{1}{2}, \frac{1}{2}\right)$ to $\frac{\mu_{0}^{\lambda}-\mu_{0}^{0}}{\lambda}$ in the space $\mathcal{Z}_{\tilde{\omega}}$, where $\tilde{\omega}(t)$ is defined by (1.13).

Proof. It will be first shown that $\left\{\frac{\nu_{\bullet}^{\lambda, n}-\mu_{\bullet}^{0}}{\lambda}\right\}_{n}$ is Cauchy sequence. Let us assume that $n \geq m$. By the definition of the norm $\|\cdot\|_{\mathcal{Z}_{\tilde{\omega}}}$ one obtains

& =\sup _{t \geq 0} \tilde{\omega}(t)\left\|\sum_{\ell=m+1}^{n} \frac{\nu_{t}^{\lambda, \ell}-\nu_{t}^{\lambda, \ell-1}}{\lambda}\right\|_{\mathcal{Z}} \leq \sup _{t \geq 0} \tilde{\omega}(t) \sum_{\ell=m+1}^{n} \underbrace{\left\|\frac{\nu_{t}^{\lambda, \ell}-\nu_{t}^{\lambda, \ell-1}}{\lambda}\right\|_{\mathcal{Z}}}_{\text {(using Proposition区.6.) }}  \tag{6.58}\\
& \leq \sup _{t \geq 0} \tilde{\omega}(t) \sum_{\ell=m+1}^{n} C(t) c^{\ell-1}\left\|\left.\partial_{\lambda} \nu_{t}^{\lambda, 1}\right|_{\lambda=0}\right\|_{\mathcal{Z}}=\sup _{t \geq 0} \tilde{\omega}(t) C(t)\left\|\left.\partial_{\lambda} \nu_{t}^{\lambda, 1}\right|_{\lambda=0}\right\|_{\mathcal{Z}} \sum_{\ell=m+1}^{n} c^{\ell-1} \\
& =\sup _{t \geq 0} \tilde{\omega}(t) C(t)\left\|\left.\partial_{\lambda} \nu_{t}^{\lambda, 1}\right|_{\lambda=0}\right\| \|_{\mathcal{Z}} c^{m}\left(\frac{1-c^{n-m}}{1-c}\right) .

Theorem 2.11 states that the growth of $\partial_{\lambda} \nu_{t}^{\lambda, 1}$ in $\mathcal{Z}$ is controlled in time by a function $\mathcal{O}\left(t e^{g t}\right)$ uniformly for $\lambda \in\left(-\frac{1}{2} ; \frac{1}{2}\right)$. It means that the weight $\tilde{\omega}(t)$ needs to be of order $\mathcal{O}\left(\frac{1}{t^{2}} e^{-2 g t}\right)$. By

Proposition 6.3 we know that $c<1$ and that the constant $C(t)$ is independent on parameter $\lambda$. Hence, one has

since function $\tilde{\omega}(t) C(t)$ is bounded in time and reduce the growth of $\partial_{\lambda} \mu_{t}^{\lambda, 1}$. It means that $\left\{\frac{\nu_{\cdot}^{\lambda, n}-\mu_{\dot{0}}^{0}}{\lambda}\right\}_{n}$ is a Cauchy sequence in space $\mathcal{Z}_{\tilde{\omega}}$. Moreover, the convergence is uniform on $\lambda \in$ $\left(-\frac{1}{2}, \frac{1}{2}\right) \backslash\{0\}$. Since the space $\mathcal{Z}_{\tilde{\omega}}$ is complete, the limit of this sequence also is in the same space. Moreover, the estimate (6.58) is independent of $\lambda \in E$, thus one obtains

2nd Step. Now, $\lim _{\lambda \rightarrow 0} \frac{\nu_{l}^{\lambda, n}-\mu_{0}^{0}}{\lambda}$ will be investigated.
Lemma 6.5. For any $n \in \mathbb{N}$, the limit $\lim _{\lambda \rightarrow 0} \frac{\nu_{,}^{\lambda, n}-\mu_{\dot{0}}^{0}}{\lambda}$ exists in $\mathcal{Z}_{\tilde{\omega}}$.
A short proof of lemma will appear on page 34, For this proof, we need the following property.
Proposition 6.6. For any $\ell \geq 2$ the limit $\lim _{\lambda \rightarrow 0} \frac{\nu^{\lambda, \ell}-\nu_{\boldsymbol{\lambda}}^{\lambda_{0}, \ell-1}}{\lambda}$ exists in $\mathcal{Z}_{\tilde{\omega}}$.
Proof of Proposition6.6 It will be shown by induction. Introduce the notation $\bar{u}^{\lambda}(\cdot):=u_{0}(\cdot)+$ $\lambda u_{1}(\cdot)$ for $u \in\{v, m\}$. The mapping $\nu_{\bullet}^{\lambda, \ell}$ is the unique solution to the linear equation

where for $\nu_{t}^{\lambda, 0}$ we take $\nu_{t}^{0}$. Similarly for $\nu_{t}^{\lambda, \ell-1}$. In the problem (6.59) expand coefficients $\bar{u}^{\lambda}\left(k_{\nu_{t}^{\lambda, \ell-1}}\right)$ into Taylor series at $k_{\nu_{t}^{\lambda, \ell-2}}$ for $u \in\{v, m\}$ - from Lemma 3.6, we know that coefficients can be expanded. Then problem (6.59) has the form (6.59)

& =\left[\bar{m}^{\lambda}\left(k_{\nu_{t}^{\lambda, \ell-2}}\right)+\nabla_{\nu} \bar{m}^{\lambda}\left(k_{\nu_{t}^{\lambda, \ell-2}}\right) \cdot\left(k_{\nu_{t}^{\lambda, \ell-1}}-k_{\nu_{t}^{\lambda, \ell-2}}\right)+o\left(\left\|k_{\nu_{t}^{\lambda, \ell-1}}-k_{\nu_{t}^{\lambda, \ell-2}}\right\|_{\infty}\right)\right] \nu_{t}^{\lambda, \ell} \\

It means that $h \mapsto \mu_{\bullet}^{h}$ is of a class $\mathcal{C}^{1}\left(\left(-\frac{1}{2}, \frac{1}{2}\right) ; \mathcal{C}_{\tilde{\omega}}([0, \infty) ; \mathcal{Z})\right)$.
This finally finishes the proof of Theorem 1.1.

Knowing that the space $\mathcal{Z}$ is complete, it is enough to show that a proper sequence of quotients is a Cauchy sequence. Let as consider a weak solutions to (2.26) for different values of parameter $h$. By $\nu_{t}^{0}$ let us denote the solution for $h=0$ and by $\nu_{t}^{\lambda_{1}}, \nu_{t}^{\lambda_{2}}$ the solution for parameters $\lambda_{1} \neq \lambda_{2}$ and such that $\lambda_{1} \neq 0$ and $\lambda_{2} \neq 0$. Solutions $t \mapsto \nu_{t}^{0}, t \mapsto \nu_{t}^{\lambda_{1}}, t \mapsto \nu_{t}^{\lambda_{2}}$ are unique; see representation formula (2.19).

Let us notice that for any fixed $h, \lambda \in \mathbb{R}$ and any $t \in[0,+\infty)$ quotient $\frac{\nu_{t}^{h+\lambda}-\nu_{t}^{h}}{\lambda}$ is an element of space $\mathcal{M}\left(\mathbb{R}^{d}\right) \subseteq \mathcal{Z}$. Hence $\nu_{t}^{h}$ which is the solution to (2.26) is differentiable with respect $h$ at $h=0$.

First, it will be shown that $\left(h \mapsto \nu_{\bullet}^{h}\right) \in \mathcal{C}\left(\left(-\frac{1}{2}, \frac{1}{2}\right) ; \mathcal{C}_{\widehat{\omega}}([0, \infty) ; \mathcal{Z})\right)$, it is the 0th Step of the proof. In 1st Step we will show that $\lim _{\lambda \rightarrow 0} \frac{\nu_{-}^{h}+\lambda^{2}-\nu_{\dot{\bullet}}^{h}}{\lambda}$ converges uniformly in $t$ for fixed $h$ as $\lambda \rightarrow 0$, so the mapping $t \mapsto \partial_{h} \nu_{t}^{h}$ is continuous and is bounded in norm $\|\cdot\|_{\mathcal{Z}_{\hat{\omega}}}$. In 2nd Step we will show that the limit $\lim _{\lambda \rightarrow 0} \frac{\nu_{\dot{\circ}+\lambda}-\nu_{\dot{-}}^{h}}{\lambda}$ is continuous with respect to $h$.
We will use a few different weights, proper for a current estimation. Based on those weights we will establish the final one; see (C.92) on page 49. Notice that if the term $\sup _{t \geq 0} \omega_{1}(t) f(t)$ is bounded, then for any weight $\omega_{2}(t)$, such that $\omega_{2}(t) \leq \omega_{1}(t)$ for all $t$, the following estimate is true

=\int_{t_{0}}^{t}(\mathbf{A})+(\mathbf{B})+(\mathbf{C}) \mathrm{d} s
\end{array}
$$

Hence

$$
\begin{aligned}
& \left|\partial_{h} X(t, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(t, y ; h)\right|_{h=h_{2}}\left|\leq C_{1} \int_{t_{0}}^{t}\right| X\left(s, y ; h_{1}\right)-\left.X\left(s, y ; h_{2}\right)\right|^{\alpha} \mathrm{d} s \\
& \quad+C_{2} \int_{t_{0}}^{t}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right| \mathrm{d} s+C_{3} \int_{t_{0}}^{t}\left|\partial_{h} X(s, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(s, y ; h)\right|_{h=h_{2}} \mid \mathrm{d} s \\
& \quad+C_{4}\left|h_{1}-h_{2}\right|\left(t-t_{0}\right) .
\end{aligned}
$$

Our goal is to conclude that $\partial_{h} X\left(t, y ; h_{1}\right)-\partial_{h} X\left(t, y ; h_{2}\right)$ is of order $\left|h_{1}-h_{2}\right|^{\alpha}$. To close these estimations (using again Gronwall's Inequality) we need to estimate $\left|X\left(t, y ; h_{1}\right)-X\left(t, y ; h_{2}\right)\right|$. From (B.77)

$$
\begin{aligned}
\partial_{t} X\left(t, y ; h_{1}\right)-\partial_{t} X\left(t, y ; h_{2}\right) & =b\left(t, X\left(t, y ; h_{1}\right)\right)-b\left(t, X\left(t, y ; h_{2}\right)\right) \\
& +h_{1} b_{1}\left(t, X\left(t, y ; h_{1}\right)\right)-h_{2} b_{1}\left(t, X\left(t, y ; h_{2}\right)\right) .
\end{aligned}
$$

after integration, we obtain

$$
\begin{aligned}
\int_{t_{0}}^{t}\left(\partial_{s} X\left(s, y ; h_{1}\right)-\partial_{s} X\left(s, y ; h_{2}\right)\right) \mathrm{d} s & =\int_{t_{0}}^{t}\left(b\left(s, X\left(s, y ; h_{1}\right)\right)-b\left(s, X\left(s, y ; h_{2}\right)\right)\right. \\
& \left.+h_{1} b_{1}\left(s, X\left(s, y ; h_{1}\right)\right)-h_{2} b_{1}\left(s, X\left(s, y ; h_{2}\right)\right)\right) \mathrm{d} s \\
\left|X\left(t, y ; h_{1}\right)-X\left(t, y ; h_{2}\right)\right| & \leq \int_{t_{0}}^{t} \mid b\left(s, X\left(s, y ; h_{1}\right)\right)-b\left(s, X\left(s, y ; h_{2}\right)\right) \\
& +h_{1} b_{1}\left(s, X\left(s, y ; h_{1}\right)\right)-h_{2} b_{1}\left(s, X\left(s, y ; h_{2}\right)\right) \mid \mathrm{d} s \\
& \leq \int_{t_{0}}^{t} \underbrace{\left|b\left(s, X\left(s, y ; h_{1}\right)\right)-b\left(s, X\left(s, y ; h_{2}\right)\right)\right|}_{\text {(D) }} \mathrm{d} s \\
& +\int_{t_{0}}^{t} \underbrace{\left|h_{1} b_{1}\left(s, X\left(s, y ; h_{1}\right)\right)-h_{2} b_{1}\left(s, X\left(s, y ; h_{2}\right)\right)\right|}_{\text {(E) }} \mathrm{d} s
\end{aligned}
$$

Now, we need to estimate (D) and (E) separately

$$
\begin{aligned}
(\mathrm{D}) & \leq c_{1}^{\prime}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right|, \\
(\mathrm{E}) & =\left|h_{1}\left[b_{1}\left(s, X\left(s, y ; h_{1}\right)\right)-b_{1}\left(s, X\left(s, y ; h_{2}\right)\right)\right]+b_{1}\left(s, X\left(s, y ; h_{2}\right)\right)\left(h_{1}-h_{2}\right)\right| \\
& \leq\left|h_{1}\right| \cdot\left|b_{1}\left(s, X\left(s, y ; h_{1}\right)\right)-b_{1}\left(s, X\left(s, y ; h_{2}\right)\right)\right|+\mid b_{1}\left(s, X\left(s, y ; h_{2}\right)|\cdot| h_{1}-h_{2} \mid\right. \\
& \leq c_{2}^{\prime} \cdot\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right|+c_{3}^{\prime} \cdot\left|h_{1}-h_{2}\right| .
\end{aligned}
$$

Estimations (D) and (E) combined give

$$
\begin{aligned}
\left|X\left(t, y ; h_{1}\right)-X\left(t, y ; h_{2}\right)\right| & \leq \int_{t_{0}}^{t} c_{3}^{\prime}\left|h_{1}-h_{2}\right| \mathrm{d} s+\int_{t_{0}}^{t} c_{4}^{\prime}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right| \mathrm{d} s= \\
& =c_{3}^{\prime}\left|h_{1}-h_{2}\right|\left(t-t_{0}\right)+\int_{t_{0}}^{t} c_{4}^{\prime}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right| \mathrm{d} s
\end{aligned}
$$

Using Gronwall's Inequality we obtain

$$
\left|X\left(t, y ; h_{1}\right)-X\left(t, y ; h_{2}\right)\right| \leq c_{3}^{\prime}\left|h_{1}-h_{2}\right|\left(t-t_{0}\right) e^{c_{4}^{\prime}\left(t-t_{0}\right)}
$$

Let us go back to $\partial_{t}\left(\left.\partial_{h} X(t, y ; h)\right|_{h=h_{1}}\right)-\partial_{t}\left(\left.\partial_{h} X(t, y ; h)\right|_{h=h_{2}}\right)$

$$
\left|\int_{t_{0}}^{t} \partial_{s}\left(\left.\partial_{h} X(s, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(s, y ; h)\right|_{h=h_{2}}\right) \mathrm{d} s\right| \leq \int_{t_{0}}^{t}|(\mathbf{A})+(\mathbf{B})+(\mathbf{C})| \mathrm{d} s
$$

and thus

$$
\begin{aligned}
& \left|\partial_{h} X(t, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(t, y ; h)\right|_{h=h_{2}} \mid \leq \int_{t_{0}}^{t}\left[C_{1}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right|^{\alpha}\right. \\
& \left.\quad+C_{2}\left|X\left(s, y ; h_{1}\right)-X\left(s, y ; h_{2}\right)\right|+C_{3}\left|\partial_{h} X(s, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(s, y ; h)\right|_{h=h_{2}}\left|+C_{4}\right| h_{1}-h_{2} \mid\right] \mathrm{d} s \\
& \leq C_{1} \int_{t_{0}}^{t}\left|h_{1}-h_{2}\right|^{\alpha}\left|s-t_{0}\right|^{\alpha} e^{\alpha c_{4}^{\prime}\left(s-t_{0}\right)} \mathrm{d} s+C_{2} \int_{t_{0}}^{t}\left|h_{1}-h_{2}\right|\left|s-t_{0}\right| e^{c_{4}^{\prime}\left(s-t_{0}\right)} \mathrm{d} s \\
& \quad+C_{3} \int_{t_{0}}^{t}\left|\partial_{h} X(s, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(s, y ; h)\right|_{h=h_{1}}\left|\mathrm{~d} s+C_{4} \int_{t_{0}}^{t}\right| h_{1}-h_{2} \mid \mathrm{d} s \\
& \leq C_{1}\left|h_{1}-h_{2}\right|^{\alpha} \gamma_{\alpha}\left(t-t_{0}\right)+C_{2}\left|h_{1}-h_{2}\right| \gamma_{1}\left(t-t_{0}\right) \\
& \quad+C_{3} \int_{t_{0}}^{t}\left|\partial_{h} X(s, y ; h)\right|_{h=h_{1}}-\left.\partial_{h} X(s, y ; h)\right|_{h=h_{2}}\left|\mathrm{~d} s+C_{4}\right| h_{1}-h_{2} \mid\left(t-t_{0}\right)
\end{aligned}
$$

where $\gamma_{\alpha}(t):=\int_{t_{0}}^{t} s^{\alpha} e^{c_{4}^{\prime} \alpha s} \mathrm{~d} s$. Gronwall's Inequality then shows that $\partial_{h} X$ is Hölder continuous of order $\alpha$.
