# Kerr Analogue of Kinnersley's Field of an Arbitrarily Accelerating Point Mass

#### Abstract

We construct the field of an arbitrarily accelerating and rotating point mass which specializes to the Kerr solution when the acceleration vanishes and specializes to Kinnersley's arbitrarily accelerating point mass when the rotation vanishes.

## I. INTRODUCTION

Although Kinnersley's [1] field of an arbitrarily accelerating point mass has been known for some time, and extensions of it to include charge have been given by Bonnor and Vaidya [2], there does not appear to be an extension that specializes to the Kerr solution [3] when the acceleration vanishes. There exist "radiating Kerr metrics" due to Vaidya and Patel (4] and, more generally, due to Herlt [5] (see [6] for a full description of what is available) but none appear to supply Kinnersley's field with spin included. The original solution by Kinnersley was also extensively studied in subsequent works on particles which accelerate by photon emission, so-called photon rockets, in the context of General Relativity, see for example [7-13].

The geometrical construction of Kinnersley's field is described in detail in [6]. We require a modification of this construction to include spin. Since we are primarily interested in introducing acceleration of the source we will leave the mass and angular momentum per unit mass constant throughout. The construction here of the Kerr analogue of Kinnersley's model is a spin-off from the study of the equations of motion of a small, slowly rotating Kerr particle moving in an external gravitational field 14]. In particular the geometrical construction in the present work is motivated by a construction of the Kerr solution with three components of angular momentum in (15].

The structure of the paper is as follows: In section $\Pi$ we give a description of the construction of Kinnersley's field of an arbitrarily accelerating mass point as important background for our construction and to establish our notations and sign conventions. In section III) we describe the geometrical construction of the Kerr analogue of Kinnersley's field and properties of the new model are given in section IV Our results are concisely summarized in section V .

## II. KINNERSELY'S FIELD

We start with the Minkowskian line element in rectangular Cartesian coordinates and time $X^{i}=(X, Y, Z, T)$ for $i=1,2,3,4$ (and we will use units for which the speed of light in a vacuum $c=1$ and the gravitational constant $G=1$ ):
$d s_{0}^{2}=-(d X)^{2}-(d Y)^{2}-(d Z)^{2}+(d T)^{2}=\eta_{i j} d X^{i} d X^{j}$.
The Schwarzschild solution [16] of Einstein's vacuum field equations is given, in Kerr-Schild form [17], by the metric tensor

\end{equation*}

with $k_{i} d X^{i}=d T-d R$, and $R=\left(X^{2}+Y^{2}+Z^{2}\right)^{1 / 2}$. Here $m$ (= constant) is the mass of the spherically symmetric source. With $k^{i}=\eta^{i j} k_{j}\left(\right.$ and $\eta^{i j}$ defined by $\left.\eta^{i j} \eta_{j k}=\delta_{k}^{i}\right)$ we have $k^{i} k_{i}=0$. Also the inverse of the metric tensor (21) (denoted $g^{i j}$ with $g^{i j} g_{j k}=\delta_{k}^{i}$ ) is given by

and thus $k^{i}=\eta^{i j} k_{j}=g^{i j} k_{j}$ so that $k^{i}$ is a null vector field in the flat space-time with metric tensor $\eta_{i j}$ and in the curved space-time with metric tensor $g_{i j}$. We see that in the flat space-time with line element (1) $R=$ $0 \Leftrightarrow X=Y=Z=0$ is a time-like geodesic (the $T$ axis). Effectively Kinnersley's [1] construction replaces this geodesic with an arbitrary time-like world line. To achieve this let $X^{i}=w^{i}(u)$ be an arbitrary time-like world line in Minkowskian space-time with $u$ arc length or proper-time along it. Then $v^{i}(u)=d w^{i} / d u$ is the unit time-like tangent to this world line satisfying $\eta_{i j} v^{i} v^{j}=$ $v_{j} v^{j}=+1$. Thus $v^{i}$ is the 4 -velocity of the particle with world line $X^{i}=w^{i}(u)$. The corresponding 4 -acceleration is $a^{i}(u)=d v^{i} / d u$ and satisfies $a_{i} v^{i}=0$ since $v_{i} v^{i}=$ 1. The position 4 -vector of any point of Minkowskian space-time relative to the world line $X^{i}=w^{i}(u)$ may be written in the form

for $0 \leq r<+\infty$ with $k^{i} k_{i}=0$ and $k^{i} v_{i}=+1$. Thus $k^{i}$ is a normalized future pointing null vector field defined along the world line $X^{i}=w^{i}(u)$ and so $k^{i}$ is tangent to the future null-cones with vertices on $X^{i}=w^{i}(u)$. The direction of $k^{i}$ is parametrized by two real parameters $\xi$, $\eta$ (say) so that we can write

for $-\infty<\xi, \eta<+\infty$ and with $P_{0}$ determined by the normalization $k^{i} v_{i}=1$ of $k^{i}$ to read

P_{0}= & v^{1}(u) \xi+v^{2}(u) \eta+v^{3}(u)\left(1-\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)\right) \\
& +v^{4}(u)\left(1+\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)\right) \tag{6}
\end{align*}

We note that

& \left.+a^{3}(u)\left(1-\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)\right)+a^{4}(u)\left(1+\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)\right)\right\} \\
& =\frac{\partial}{\partial u}\left(\log P_{0}\right) \tag{7}
\end{align*}

and thus the propagation law for $k^{i}$ along $X^{i}=w^{i}(u)$ is

\frac{\partial k^{i}}{\partial u}=-h_{0} k^{i} \tag{8}
\end{equation*}
$$

From (4) we have

d X^{i}=\left(v^{i}-r h_{0} k^{i}\right) d u+k^{i} d r+r \frac{\partial k^{i}}{\partial \xi} d \xi+r \frac{\partial k^{i}}{\partial \eta} d \eta \tag{9}
\end{equation*}

Hence, in particular,

\end{equation*}

with the comma denoting partial differentiation with respect to $X^{i}$. Noting that

\frac{\partial k^{i}}{\partial \xi} \frac{\partial k_{i}}{\partial \xi}=-P_{0}^{-2}=\frac{\partial k^{i}}{\partial \eta} \frac{\partial k_{i}}{\partial \eta} \quad \text { and } \quad \frac{\partial k^{i}}{\partial \xi} \frac{\partial k_{i}}{\partial \eta}=0 \tag{11}
\end{equation*}
$$

we have

d s_{0}^{2}=\eta_{i j} d X^{i} d X^{j}= & -r^{2} P_{0}^{-2}\left(d \xi^{2}+d \eta^{2}\right)+2 d u d r \\
& +\left(1-2 h_{0} r\right) d u^{2} \tag{12}
\end{align*}
$$

If we now generalize the metric tensor (3) to provide the line element, in coordinates $x^{i}=(\xi, \eta, r, u)$,

\begin{align*}
d s^{2}=g_{i j} d x^{i} d x^{j}= & -r^{2} P_{0}^{-2}\left(d \xi^{2}+d \eta^{2}\right)+2 d u d r \\
& +\left(1-2 h_{0} r-\frac{2 m}{r}\right) d u^{2}, \tag{13}
\end{align*}
$$

we arrive at Kinnersley's line element which reduces to the Eddington-Finkelstein form of the Schwarzschild
line element when $a^{i}=0$ (i.e. when the world line $X^{i}=w^{i}(u)$ in Minkowskian space-time is a time-like geodesic). For this special case we may take $v^{i}=\delta_{4}^{i}$ and so $P_{0}=1+\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)=p_{0}$ (say). Then (13) becomes the Schwarzschild line element

\end{equation*}

Here $\xi, \eta$ are stereographic coordinates on the unit $2-$ sphere, related to the polar angles $\theta, \phi$ for $0 \leq \theta \leq \pi, 0 \leq$ $\phi<2 \pi$ via $\eta / \xi=\tan \phi$ and $\cos \theta=\left(4-\xi^{2}-\overline{\eta^{2}}\right) /(4+$ $\xi^{2}+\eta^{2}$ ). We can write (13) in terms of basis 1 -forms $\vartheta^{(a)}$ with $a=1,2,3,4$ as

& \vartheta^{(4)}=d r+\left(\frac{1}{2}-h_{0} r-\frac{m}{r}\right) d u=\vartheta_{(3)} \tag{16}

and $\vartheta_{(a)}=g_{(a)(b)} \vartheta^{(b)}$. The 1-forms define a half null tetrad and the components $R_{(a)(b)}$ of the Ricci tensor on this tetrad vanish with the exception of

Hence if $R_{i j}$ are the components of the Ricci tensor in coordinates $x^{i}=(\xi, \eta, r, u)$ then we can write

R_{i j}=-\frac{6 m h_{0}}{r^{2}} n_{i} n_{j} \quad \text { with } \quad n_{i} d x^{i}=d u \tag{18}
\end{equation*}

We note that $g^{i j} n_{i} n_{j}=0$.
In preparation for consideration of the axially symmetric Kerr case it is useful to specialize the Kinnersley model to the case for which the world line $X^{i}=w^{i}(u)$ is the history of a particle performing rectilinear motion. For this we take the 4 -velocity $v^{i}$ to be restricted by requiring $v^{1}(u)=0=v^{2}(u)$. Then writing $\lambda=v^{4}+v^{3}$ and $\mu=v^{4}-v^{3}$ we have $\lambda \mu=1$ and, with a dot denoting differentiation with respect to $u$, we see that if

Now $P_{0}$ and $h_{0}$ in (6) and (7) read

We introduce polar coordinates $\theta, \phi$ by writing

& \eta=2 \lambda\left(\frac{1-\cos \theta}{1+\cos \theta}\right)^{1 / 2} \sin \phi \tag{22}
\end{align*}

and thus

\frac{\eta}{\xi}=\tan \phi \quad \text { and } \quad \frac{\lambda^{2}-\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)}{\lambda^{2}+\frac{1}{4}\left(\xi^{2}+\eta^{2}\right)}=\cos \theta \tag{23}
\end{equation*}
$$

This results in $h_{0}=A(u) \cos \theta$,

$$
\begin{align*}
& P_{0}^{-1} d \xi=-\sin \theta \sin \phi d \phi+(d \theta+A(u) \sin \theta d u) \cos \phi \\
& P_{0}^{-1} d \eta=\sin \theta d \phi \cos \phi+(d \theta+A(u) \sin \theta d u) \sin \phi \tag{24}
\end{align*}
$$

and thus the line element (13) takes the form

d s^{2}= & -r^{2}\left\{(d \theta+A(u) \sin \theta d u)^{2}+\sin ^{2} \theta d \phi^{2}\right\}+2 d u d r \\
& +\left(1-2 A(u) r \cos \theta-\frac{2 m}{r}\right) d u^{2} \\
= & \left(g_{i j}-\frac{2 m}{r} n_{i} n_{j}\right) d x^{i} d x^{j} \\
= & g_{i j} d x^{i} d x^{j} \tag{26}
\end{align*}
$$

Here the Minkowskian metric tensor components in the curvilinear coordinates $x^{i}=(\theta, \phi, r, u)$ are denoted $g_{i j}$. The Minkowskian metric tensor components in (0)
the rectangular Cartesian coordinates and time $X^{i}=$ $(X, Y, Z, T)$ are denoted $\eta_{i j}$ and thus $g_{i j} d x^{i} d x^{j}=$ (0)
$\eta_{i j} d X^{i} d X^{j}$. We note that $g_{i j}=\underset{(0)}{g_{i j}}-(2 m / r) n_{i} n_{j}$ has
Kerr-Schild form. Also $n^{i}=g_{(0)}^{i j} n_{j}=g^{i j} n_{j}=\delta_{3}^{i}$. The Kerr-Schild form of the metric tensor has the important algebraic property of the equality of determinants:

\end{equation*}

Hence, if covariant differentiation with respect to the Riemannian connection calculated with the metric tensor $g_{i j}$ is denoted by a stroke, we have

\left.n_{\mid i}^{i}=\frac{1}{2 g} \frac{\partial g}{\partial r}=\frac{1}{2 g} \frac{\partial}{\partial r} \underset{(0)}{g}\right)=\frac{2}{r} \tag{28}
\end{equation*}

and so, for future reference, we see that the metric tensor above has the form

We note that the optical scalar describing the expansion of the congruence of null geodesic integral curves of the vector field $n^{i}$ is $(1 / 2) n^{i}{ }_{\mid i}$.

## III. KERR ANALOGUE OF KINNERSLEY'S FIELD

To introduce rotation or spin into the Kinnersley field we proceed by modifying (4) to read

with

U^{i}(\xi, \eta, u)=P_{0}^{2}\left(\frac{\partial k^{i}}{\partial \xi} \frac{\partial F}{\partial \eta}-\frac{\partial k^{i}}{\partial \eta} \frac{\partial F}{\partial \xi}\right) \tag{31}
\end{equation*}
$$

Here $k^{i}$ and $P_{0}$ are given by (5) and (6) and

$$
\begin{equation*}
F=s^{i}(u) k_{i} \quad \text { with } \quad s^{i} v_{i}=0 \quad \text { and } \quad \frac{d s^{i}}{d u}=-\left(a_{j} s^{j}\right) v^{i} \tag{32}
\end{equation*}

The space-like vector $s^{i}(u)$ is here defined along the world line $X^{i}=w^{i}(u)$ by Fermi transport. We note the useful formulas:

\frac{\partial U^{i}}{\partial u}= & P_{0}^{2}\left(\frac{\partial h_{0}}{\partial \eta} \frac{\partial F}{\partial \xi}-\frac{\partial h_{0}}{\partial \xi} \frac{\partial F}{\partial \eta}\right) k^{i} \\
& +F P_{0}^{2}\left(\frac{\partial h_{0}}{\partial \xi} \frac{\partial k^{i}}{\partial \eta}-\frac{\partial h_{0}}{\partial \eta} \frac{\partial k^{i}}{\partial \xi}\right) \tag{35}
\end{align*}

We now, for simplicity, specialize the world line $X^{i}=$ $w^{i}(u)$ by requiring $v^{1}(u)=0=v^{2}(u)$ as we did at the end of the previous section. Then one can solve the propagation law (32) for $s^{i}$ along $X^{i}=w^{i}(u)$ with

with $\lambda(u)=v^{4}+v^{3}$ as before and $\underset{(0)}{S}=$ constant. We then find that

and $P_{0}, h_{0}$ are given by (20). Now introducing the polar angles $\theta, \phi$ via (22) we have $h_{0}=A(u) \cos \theta$ as before and $F=\underset{(0)}{S} \cos \theta$ and we obtain from (31)

& +\left(d r-r A \cos \theta d u-\underset{(0)}{S} \sin ^{2} \theta d \phi\right) k^{i} \\
& +\left(\lambda^{(1)} \cos \phi-\lambda^{(2)} \sin \phi\right) P_{0} \frac{\partial k^{i}}{\partial \xi} \\
& +\left(\lambda^{(1)} \sin \phi+\lambda^{(2)} \cos \phi\right) P_{0} \frac{\partial k^{i}}{\partial \eta}, \tag{38}
\end{align*}
$$

with the 1 -forms $\lambda^{(1)}, \lambda^{(2)}$ given by

& \lambda^{(1)}=r(d \theta+A(u) \sin \theta d u)-\underset{(0)}{S} \sin \theta \cos \theta d \phi,  \tag{39}\\
& \lambda^{(2)}=r \sin \theta d \phi+\underset{(0)}{S} \cos \theta d \theta . \tag{40}

We note that

k_{i} d X^{i}=d u+\underset{(0)}{S} \sin ^{2} \theta d \phi=n_{i} d x^{i} \tag{41}
\end{equation*}
$$

defining $n_{i}$ in coordinates $x^{i}=(\theta, \phi, r, u)$ and, using the Minkowskian scalar products (11),

\eta_{i j} d X^{i} d X^{j}= & -\left(\lambda^{(1)}\right)^{2}-\left(\lambda^{(2)}\right)^{2}+2\left(d u+\underset{(0)}{S} \sin ^{2} \theta\right) \\
& \times\left\{d r-r A \cos \theta d u-\underset{(0)}{S} \sin ^{2} \theta d \phi\right. \\
& \left.+\frac{1}{2}\left(d u+\underset{(0)}{S} \sin ^{2} \theta d \phi\right)\right\} \\
= & g_{i j} d x^{i} d x^{j} \tag{42}
\end{align*}
$$

When $\underset{(0)}{S}=0$ this line element coincides with (26) when $m=0$. When $A=0$ in (42) the line element is the Minkowskian background for the Kerr solution with angular momentum per unit mass $\underset{(0)}{S}$. The constant $\underset{(0)}{S}$ is thus playing the role of the constant $a$ in the standard form of the Kerr solution. We are using $\underset{(0)}{S}$ to denote the angular momentum per unit mass or spin rather than the more familiar $a$ to avoid any confusion with the acceleration. We now form the Kerr-Schild metric tensor (29) in this case with $n_{i}$ given by (41). Once again we have $n^{i}=\delta_{3}^{i}$ and using (28) we find that

n^{i}{ }_{\mid i}=\frac{2 r+A \underset{(0)}{S^{2}} \sin ^{2} \theta \cos \theta}{r^{2}+\underset{(0)}{S^{2}} \cos ^{2} \theta+r A \underset{(0)}{S^{2}} \sin ^{2} \theta \cos \theta} \tag{43}
\end{equation*}
$$

Substituting (42) and (43) into (29) we arrive at the Kerr analogue of Kinnersley's model which can be written

d s^{2} & =g_{i j} d x^{i} d x^{j}=-\left(\lambda^{(1)}\right)^{2}-\left(\lambda^{(2)}\right)^{2}+2 \lambda^{(3)} \lambda^{(4)} \\
& =g_{(a)(b)} \lambda^{(a)} \lambda^{(b)} \tag{44}
\end{align*}
$$

with $\lambda^{(1)}, \lambda^{(2)}$ given by (39) and (40) and

$$
\begin{align*}
\lambda^{(3)}= & d u+\underset{(0)}{S} \sin ^{2} \theta d \phi  \tag{45}\\
\lambda^{(4)}= & d r-r A(u) \cos \theta d u-\underset{(0)}{S} \sin ^{2} \theta d \phi \\
& +\left(\frac{1}{2}-\frac{m \varphi^{\prime}}{2 \varphi}\right) \lambda^{(3)}, \tag{46}
\end{align*}
$$

with

\varphi=r^{2}+\underset{(0)}{S^{2}} \cos ^{2} \theta+r A \underset{(0)}{S^{2}} \sin ^{2} \theta \cos \theta \tag{47}
\end{equation*}

and $\varphi^{\prime}=\partial \varphi / \partial r$. We emphasize that $A(u)$ is an arbitrary function of its argument while $m$ and $S$ are constants.

Writing the basis 1 -forms $\lambda^{(a)}$ given by (39), (40), (45) and (46) in the form

Here the dependence of the tetrad components of the Ricci tensor on the radial coordinate $r$ is explicit, remembering that $\varphi$ is given by (47) and since $\underset{(0)}{\sigma}, \underset{(0)}{\omega}$ are independent of $r$. The Ricci tensor components $R_{i j}$, in coordinates $x^{i}=(\theta, \phi, r, u)$, have the exact algebraic form given in (49). We have noted following (49) that the Ricci scalar $R=g^{i j} R_{i j}$ vanishes exactly and so the Ricci tensor $R_{i j}$ and the Einstein tensor $G_{i j}=R_{i j}-\frac{1}{2} g_{i j} R$ coincide. We now also note that the basis vector fields $f^{i}, e^{i}, l^{i}, n^{i}$ are parallel transported along the futuredirected null geodesic integral curves of the vector field $n^{i}$ and thus

The leading $r^{-2}$-term in the energy-momentum-stress tensor here does not involve the spin parameter of the Kerr solution and coincides with the Kinnersley energy-momentum-stress tensor. It is algebraically identical to Kinnersley's energy-momentum-stress tensor if, instead of using the affine parameter distance $r$, we use the parallax distance $r_{P}$ defined by [18]

## IV. PROPERTIES OF THE KERR ANALOGUE OF KINNERSLEY'S FIELD

To identify a curvature singularity in the Kerr analogue of Kinnersley's field a convenient approach is to calculate the Kretschmann scalar. This is given in our case by

with $\varphi$ given by (47). Thus the Kretschmann scalar is singular when $\varphi=0$ and this occurs, in particular, at $r=0, \theta=\pi / 2$. When (31) is specialized to the axially symmetric case we have

But this condition by itself excludes Kinnersley's model as a special case. Consequently we can say that the Kerr analogue of Kinnersely's field of an arbitrarily accelerating point mass has a curvature singularity on a ring of radius $|\underset{(0)}{S}|$ undergoing rectilinear motion with arbitrary acceleration.

From the foregoing we see that asymptotically the matter distribution created by the accelerating, spinning source is qualitatively similar to that of Kinnersley's accelerating point mass except that the propagation direction of the light-like matter in the spinning case has shear on account of the acceleration/spin interaction. A further manifestation of the asymptotic similarity between the spinning case and Kinnersley's non-spinning case is displayed by comparing the formulas (4) and (30) for large values of $r$. We begin by writing (30) as

N^{i}=n^{i}-\frac{1}{r} \underset{(0)}{S} \sin \theta e^{i} \tag{107}
\end{equation*}
$$

and thus it is immaterial whether we use $n^{i}$ or $N^{i}$ in the leading term in the energy-momentum-stress tensor components.

## V. CONCLUSIONS

We have shown how to construct an exact solution for the gravitational field of an arbitrarily accelerating and rotating point mass in General Relativity. This Kerr-like analogue of Kinnersely's field of an arbitrarily accelerating point mass has a curvature singularity on a ring of radius $|\underset{(0)}{S}|$ undergoing rectilinear motion with arbitrary acceleration. Asymptotically the matter distribution created by the accelerating, spinning source is qualitatively similar to that of Kinnersley's accelerating point mass except that the propagation direction of the light-like matter in the spinning case has shear on account of the acceleration/spin interaction. The uniqueness of the solution given here is a topic for further study and is related to the uniqueness of the Kerr solution.
