THE GENERALIZED SPECTRA IN C*-ALGEBRAS OF **OPERATORS OVER** C*-ALGEBRAS

ABSTRACT. In this paper we consider shift operators, self-adjoint, unitary and normal operators on the standard module over a unital C^* -algebra \mathcal{A} . We define various generalized spectra in \mathcal{A} of these operators, give description of such spectra of these operators and investigate their further properties.

1. INTRODUCTION

Hilbert C^* -modules are natural generalizations of Hilbert spaces when the field of scalars is replaced by an arbitrary C^* -algebra. In this paper we let \mathcal{A} be a unital C^{*}-algebra and $H_{\mathcal{A}}$ denote the standard module over \mathcal{A} , that is $H_{\mathcal{A}} = l_2(\mathcal{A})$. Moreover, we let $B^{a}(H_{\mathcal{A}})$ be the C^{*}-algebra of all \mathcal{A} -linear, bounded, adjointable operators on $H_{\mathcal{A}}$.

Our starting question is the following: If \mathcal{A} is a C^* -algebra, then for $\alpha \in \mathcal{A}$ could we define in a suitable way the operator αI on $H_{\mathcal{A}}$ and the generalized spectra in \mathcal{A} of operators in $B^a(H_{\mathcal{A}})$ by setting for every $F \in B^a(H_{\mathcal{A}}) \sigma^{\mathcal{A}}(F) =$ $\{\alpha \in \mathcal{A} \mid F - \alpha I \text{ is not invertible in} B^a(H_{\mathcal{A}})\}$?

For $a \in \mathcal{A}$ we may let αI be the operator on $H_{\mathcal{A}}$ given by $\alpha I(x_1, x_2, \cdots) =$ $(\alpha x_1, \alpha x_2, \cdots)$. It is straightforward to check that αI is an \mathcal{A} -linear operator on $H_{\mathcal{A}}$. Moreover, αI is bounded and $\|\alpha I\| = \|\alpha\|$. Finally, αI is adjointable and its adjoint is given by $(\alpha I)^* = \alpha^* I$.

We introduce then the following notion:

 $\sigma^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid F - \alpha I \text{ is not invertible in} B^{a}(H_{\mathcal{A}}) \}; \\ \sigma^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid \ker(F - \alpha I) \neq \{0\} \};$

$$\sigma_p^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid \ker(F - \alpha I) \neq \{0\} \}$$

 $\sigma_{rl}^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid F - \alpha I \text{ is bounded below, but not surjective on } H_{\mathcal{A}} \} \};$

 $\sigma_{cl}^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid Im(F - \alpha I) \text{ is } \underline{\text{not}} \text{ closed } \}. \text{ (where } F \in B^{a}(H_{\mathcal{A}})) \text{)}.$

Recall that not all closed submodules of $H_{\mathcal{A}}$ are orthogonally complementable in $H_{\mathcal{A}}$ which differs from the situation of Hilbert spaces. It may happen that $\overline{Im(F-\alpha I)} \oplus Im(F-\alpha I)^{\perp} \subseteq H_{\mathcal{A}}$. However, if $Im(F-\alpha I)$ is closed, then $Im(F^* - \alpha^*I)$ is closed and we also have $H_{\mathcal{A}} = Im(F - \alpha I) \oplus \ker(F^* - \alpha^*I) = \ker(F - \alpha I) \oplus Im(F^* - \alpha^*I)$ whenever $F \in B^a(H_{\mathcal{A}})$.

Therefore, it is more convinient in this setting to work with $\sigma_{rl}^{\mathcal{A}}(F)$ and $\sigma_{cl}^{\mathcal{A}}(F)$ for $F \in B^a(H_{\mathcal{A}})$ instead of the residual and the continuous spectrum.

Note that we have obviously $\sigma^{\mathcal{A}}(F) = \sigma_p^{\mathcal{A}}(F) \cup \sigma_{rl}^{\mathcal{A}}(F) \cup \sigma_{cl}^{\mathcal{A}}(F)$ and $\sigma^{\mathcal{A}}(F^*) = (\sigma^{\mathcal{A}}(F))^*$.

The challenges which arise are the following:

1) \mathcal{A} may be non commutative;

2) Not all non-zero elements in \mathcal{A} are invertible. Moreover, even if $\alpha \in \mathcal{A} \cap G(\mathcal{A})$, we do not have in general that $\| \alpha^{-1} \| = \frac{1}{\| \alpha \|}$. Therefore $\sigma^{\mathcal{A}}(F)$ may be unbounded. (However $\sigma^{\mathcal{A}}(F)$ is always closed in \mathcal{A}).

The notion of generalized spectra has originally been introduced in [1]. In this paper we give description of the generalized spectra of shift operators, unitary, self-adjoint and normal operators on $H_{\mathcal{A}}$ and investigate some further properties of these spectra. Most of the results in this paper are generalizations of the results from [2].

2. Main results

We start with the following proposition.

Proposition 2.1. Let \mathcal{A} be a unital C^* -algebra $\{e_k\}_{k\in\mathbb{N}}$ denote the standard orthonormal basis of $H_{\mathcal{A}}$ and S be the operator defined by $Se_k = e_{k+1}, k \in \mathbb{N}$, that is S is unilateral shift and $S^*e_{k+1} = e_k$ for all $k \in \mathbb{N}$. If $\mathcal{A} = L^{\infty}((0,1))$ or if $\mathcal{A} = C([0,1])$, then $\sigma^{\mathcal{A}}(S) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$, (where in the case when $\mathcal{A} = L^{\infty}((0,1))$, we set $\inf |\alpha| = \inf\{C > 0 \mid \mu(|\alpha|^{-1}[0,C]) > 0\} = \sup\{K > 0 \mid |\alpha| > K)$ a.e. on $(0,1)\}$). Moreover, $\sigma_p^{\mathcal{A}}(S) = \emptyset$ in both cases.

Proof. We have two cases. Case 1: In this case we consider $\mathcal{A} = C([0,1])$. Let $\alpha \in \mathcal{A}$ and suppose that $\inf |\alpha| < 1$. Since $|\alpha|$ is continuous, we may find an open interval $(t_1, t_2) \subseteq (0, 1)$ such that $|\alpha(t)| < 1 - \epsilon$ for all $t \in (t_1, t_2)$, where $0 < \epsilon < 1 - \inf |\alpha|$. We may find some $g \in \mathcal{A}$ sunce that $\sup p g \subseteq (t_1, t_2)$ and $0 \leq g \leq 1$. Consider $x_{\alpha} = (g, \overline{\alpha}g, \overline{\alpha}^2g, \cdots)$. Then $\langle (\alpha I - S)e_k, x_{\alpha} \rangle = \overline{\alpha}^k g - \overline{\alpha}^k g = 0$. Hence $x_{\alpha} \in Im(\alpha I - S)^{\perp}$ and $x_{\alpha} \neq 0$, which gives that $\alpha \in \sigma^{\mathcal{A}}(S)$. Hence $\{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1\} \subseteq \sigma^{\mathcal{A}}(S)$. Since $\sigma^{\mathcal{A}}(S)$ is closed in the norm topolgy in \mathcal{A} it follows that $\inf \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\} \subseteq \sigma^{\mathcal{A}}(S)$. On the other hand, if $\alpha \in \mathcal{A}$ and $\inf |\alpha| > 1$, then α is invertible and $\sup |\alpha^{-1}| = || \alpha^{-1} || < 1$. It follows that $|| \alpha^{-1}S || \leq || \alpha^{-1} || || S || < 1$, so $\alpha I - S = \alpha (I - \alpha^{-1}S)$ is invertible in $B^{\alpha}(H_{\mathcal{A}})$.

Next, suppose that $(\alpha I - S)(x) = 0$ for some $\alpha \in \mathcal{A}$ and $x \in H_{\mathcal{A}}$. This gives the following system of equations coordinatewise: $\alpha x_1 = 0, \alpha x_2 - x_1 = 0, \alpha x_3 - x_2 = 0, \cdots$. Since $\alpha x_1 = 0$, we deduce that $x_{1|\text{supp }\alpha} = 0$. However, since $\alpha x_2 - x_1 = 0$, it follows that $x_{1|(\text{supp }\alpha)^c} = 0$ also. Hence $x_1 = 0$. But then $\alpha x_2 = 0$ and $\alpha x_3 - x_2 = 0$. Using the same argument we obtain that $x_2 = 0$. Proceeding inductively we obtain that $x_k = 0$ for all k, so x = 0. Since $\alpha \in \mathcal{A}$ was arbitrary chosen, we conclude that $\sigma_p^{\mathcal{A}}(S) = \emptyset$.

Case 2: In this case we consider $\mathcal{A} = L^{\infty}((0,1))$. Let $\alpha \in \mathcal{A}$ and assume that inf $|\alpha| < 1$. This means that $\mu(|\alpha|^{-1}((0,1-\epsilon)) > 0)$. Set $M_{\epsilon} = |\alpha|^{-1}((0,1-\epsilon))$, there exists on $\epsilon \in (0, 1 - inf |\alpha|)$ such that $\chi_{M_{\epsilon}} \neq 0$. Letting $\chi_{M_{\epsilon}}$ play the role of the function g in the previous proof, we deduce by the same arguments that $\sigma^{\mathcal{A}}(S) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$. Next, assume that $(\alpha I - S)(x) = 0$ for some $\alpha \in \mathcal{A}$ and $x \in H_{\mathcal{A}}$. As in the previous proof we get the system of equations $\alpha x_1 = 0, \alpha x_2 - x_1 = 0, \alpha x_3 - x_2 = 0, \cdots$. The first equation gives that $x_1 = 0$ a.e. on $|\alpha|^{-1}(0, \infty)$ whereas the second equation gives $x_1 = 0$ a.e. on $\alpha^{-1}(\{0\})$. Hence $x_1 = 0$. Proceeding inductively as in the previous proof we get x = 0, hence $\sigma_p^{\mathcal{A}}(S)$ is empty also in this case. \Box

Lemma 2.2. Let $T \in B(H)$ and suppose that T is invertible. Then the equation (TI - S)x = y has a solution in $H_{\mathcal{A}}$ for all $e_k, k \in \mathbb{N}$ if and only if the sequence $(T^{-1}, T^{-2}, \cdots, T^{-k}, \cdots)$ is in $H_{\mathcal{A}}$.

Proof. For k = 1, if $(TI - S)x = e_1$ we must have $TB_1 = I$ where $x = (B_1, B_2, \cdots)$. Hence $B_1 = T^{-1}$. Next $TB_2 - B_1 = 0$, so $TB_2 = B_1 = T^{-1}$ which gives $B_2 = T^{-2}$. Proceeding inductively, we obtain that $B_k = T^{-k}$ for all k. So the equation $(TI - S)x = e_1$ has a solution in $H_{\mathcal{A}}$ if and only if the sequence T^{-1}, T^{-2}, \cdots belongs to $H_{\mathcal{A}}$.

Now, if $T^{-1}, T^{-2}, \dots \in H_{\mathcal{A}}$ then the sequence $x^{(k)}$ in $H_{\mathcal{A}}$ given by $x_n^{(k)} = \begin{cases} 0 & \text{if } n \in \{1, \dots, k-1\} \\ T^{-(n-k+1)} & \text{for } n \in \{k, k+1, \dots\} \end{cases}$ is the solution of the equation $(TI - S)x = e_k$ for each $k \in \mathbb{N}$.

For each $T \in B(H)$ let N_T denote the set of all right annihilators of T. For each right invertible T, let B_T denote right inverse of T and W be the set of all right invertible $T \in B(H)$ such that there exists a non zero sequence $\{Y_n\} \subseteq N_T$ with the property that the sequence $\{Y_1, B_TY_1 + Y_2, B_T^2Y_1 + B_TY_2 + Y_3, \cdots\}$ belongs to $l_2(B(H))$.

In addition, let Z be the set of all right invertible T such that there is <u>no</u> sequence $\{Y_n\}$ in N_T with the property that the sequence $\{B_T + Y_1, B_T^2 + B_T Y_1 + Y_2, B_T^3 + B_T^2 Y_1 + B_T Y_2 + Y_3, \cdots\}$ belongs to $l_2(B(H))$. Then we have the following proposition.

Proposition 2.3. Let $\mathcal{A} = B(H)$ and S be the unilateral shift on $H_{\mathcal{A}}$. Then $\sigma^{\mathcal{A}}(S) = Z \cup W \cup \{T \in B(H) | T \text{ is not right invertible}\}.$

Proof. If (TI - S)x = y should have a solution for each e_k , then, by the similar calculations as in the proof of Lemma 2.2 we must have that T is right invertible and belongs to $B(H) \setminus Z$. Now, suppose that T is right invertible and that (TS - I)y = 0 for some $y = \{Y_1, Y_2, \cdots\} \in H_A$. We get coordinatewise the system of equations $TY_1 = 0, TY_2 = Y_1, TY_3 = Y_2, \cdots$. It is easily seen that (TS - I)y = 0 has a non trivial solution if and only if T belongs to W. The proposition follows.

Corollary 2.4. Let \mathcal{A} be a commutative unital C^* -algebra. Then $\sigma^{\mathcal{A}}(S) = \mathcal{A} \setminus G(\mathcal{A}) \cup \{\alpha \in G(\mathcal{A}) | (\alpha^{-1}, \alpha^{-2}, \cdots, \alpha^{-k}, \cdots) \notin H_{\mathcal{A}} \}.$

Proof. Since \mathcal{A} is commutative, then the set of right invertible elements is $G(\mathcal{A})$. Hence we can apply the arguments from the proof of Lemma 2.2.

Corollary 2.5. Let \mathcal{A} be a unital C^* -algebra. If $1_{\mathcal{A}}$ denotes the unit in \mathcal{A} , then $1_{\mathcal{A}} \in \sigma^{\mathcal{A}}(S)$.

Proof. We have obviously that the sequence $(1_{\mathcal{A}}, 1_{\mathcal{A}}, 1_{\mathcal{A}}, \cdots) = (1_{\mathcal{A}}^{-1}, 1_{\mathcal{A}}^{-2}, 1_{\mathcal{A}}^{-3}, \cdots)$ is not an element of $H_{\mathcal{A}}$. Then apply the arguments from the proof of Lemma 2.2.

Example 2.6. We may also consider a weighted shift S_w on $H_{\mathcal{A}}$ given by $S_w(x)_{j+1} = w_j x_j$ where $w = (w_1, w_2, \cdots)$ is a bounded sequence in \mathcal{A} . In this case, if α has a common right annihilator as w_j for some $j \in \mathbb{N}$, then the sequence having this right annihilator in its *j*-th coordinate and 0 elsewhere belongs to the kernel of $\alpha I - S_w$. Hence $\alpha \in \sigma^{\mathcal{A}}(S_w)$ in this case.

Remark 2.7. Notice that Proposition 2.3 can be generalized to arbitrary unital C^* -algebras.

Example 2.8. Let $\mathcal{A} = L^{\infty}((0,1))$. Set $\tilde{S}(f_1, f_2, \cdots) = (f_1\chi_{(0,\frac{1}{2})}, f_2\chi_{(0,\frac{1}{2})} + f_1\chi_{(\frac{1}{2},1)}, f_3\chi_{(0,\frac{1}{2})} + f_2\chi_{(\frac{1}{2},1)}, \cdots)$. Then \tilde{S} has the matrix $\begin{bmatrix} 1 & 0 \\ 0 & S \end{bmatrix}$ w.r.t. the decomposition $(H_{\mathcal{A}} \cdot \chi_{(0,\frac{1}{2})}) \oplus (H_{\mathcal{A}} \cdot \chi_{(\frac{1}{2},1)})$. It follows that $\sigma^{\mathcal{A}}(\tilde{S}) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \cdot \chi_{(\frac{1}{2},1)} \leq 1\} \cup \{\alpha \in \mathcal{A} \mid \mu(\{t \mid t \in (0,\frac{1}{2}) \text{ and } \alpha(t) = 1\}) > 0\}.$

Proposition 2.9. Let $\alpha \in \mathcal{A}$. We have

1. If $\alpha I - F$ is bounded below, and $F \in B^a(H_A)$ then $\alpha \in \sigma_{rl}^{\mathcal{A}}(F)$ if and only if $\alpha^* \in \sigma_n^{\mathcal{A}}(F^*)$.

2. If $F, D \in B^a(H_A)$ and $D = U^*FU$ for some unitary operator U, then $\sigma^{\mathcal{A}}(F) = \sigma^{\mathcal{A}}(D), \sigma^{\mathcal{A}}_p(F) = \sigma^{\mathcal{A}}_p(D), \sigma^{\mathcal{A}}_{cl}(F) = \sigma^{\mathcal{A}}_{cl}(D)$ and $\sigma^{\mathcal{A}}_{rl}(F) = \sigma^{\mathcal{A}}_{rl}(D)$.

Proof. 1) Suppose first that $F - \alpha I$ is bounded below and $\alpha \in \sigma_{rl}^{\mathcal{A}}(F)$. Then $Im(F - \alpha I)$ is closed and $Im(F - \alpha I)^{\perp} \neq \{0\}$. Since Im $Im(F - \alpha I)^{\perp} = \ker(F^* - \alpha^* I)$, it follows that $\alpha^* \in \sigma_p^{\mathcal{A}}(F^*)$. Conversely, suppose that $\alpha^* \in \sigma_p^{\mathcal{A}}(F^*)$ and $F - \alpha I$ is bounded below. Then, again Im $Im(F - \alpha I)$ is closed and moreover $Im(F - \alpha I)^{\perp} = \ker(F^* - \alpha^* I) \neq \{0\}$. It follows that $\alpha \in \sigma_{rl}^{\mathcal{A}}(F)$. It is straightforward to prove the statement in 2.

Proposition 2.10. Let $U \in B^{a}(H_{\mathcal{A}})$ be unitary. Then $\sigma^{\mathcal{A}}(U) \subseteq \{\alpha \in \mathcal{A} \mid || \alpha || \geq 1\}$ 1} and $\sigma^{\mathcal{A}}(U) \cap G(\mathcal{A}) \subseteq \{\alpha \in G(\mathcal{A}) \mid || \alpha^{-1} ||, || \alpha || \geq 1\}.$

Proof. We have $\alpha I - V = (\alpha V^* - I)V$ and $||V^*|| = ||V|| = 1$.

Consider again the orthonormal basis $\{e_k\}_{k\in\mathbb{N}}$ for $H_{\mathcal{A}}$. We may enumerate this basis by indexes in \mathbb{Z} . Then we get orthonormal basis $\{e_j\}_{j\in\mathbb{Z}}$ for $H_{\mathcal{A}}$ and we can consider bilateral shift operator V w.r.t. this basis i.e. $Ve_k = e_{k+1}$ all $k \in \mathbb{Z}$, which gives $V^*e_k = e_{k-1}$ for all $k \in \mathbb{Z}$.

Proposition 2.11. Let V be bilateral shift operator. Then the following holds 1) If $\mathcal{A} = C([0,1])$, then $\sigma^{\mathcal{A}}(V) = \{f \in \mathcal{A} \mid |f|([0,1]) \cap \{1\} \neq \emptyset\}$ 2) If $\mathcal{A} = L^{\infty}([0,1])$, then $\sigma^{\mathcal{A}}(V) = \{f \in \mathcal{A} \mid \mu(|f|^{-1}((1-\epsilon, 1+\epsilon)) > 0 \ \forall \epsilon > 0\}$. In both cases $\sigma_p^{\mathcal{A}}(V) = \emptyset$.

Proof. Case 1:

In this case we consider $\mathcal{A} = C([0,1])$. Suppose that $\alpha \in \mathcal{A}$ and $|\alpha(\tilde{t})| = 1$ for some $\tilde{t} \in [0,1]$. Choose a function $y \in \mathcal{A}$ such that $y(\tilde{t}) = 1$. If $\alpha I - V$ is surjective, then there exists an $x \in H_A$ such that $(\alpha I - V)x = e_1 \cdot y$ Now $x(\tilde{t}) \in l_2$ since $x \in H_A$. It we let \tilde{V} denote the ordinary bilateral shift on l_2 we get that $\alpha(\tilde{t})x(\tilde{t}) - \tilde{V}(x(\tilde{t})) = (1, 0, 0, \cdots)$, as $y(\tilde{t}) = 1$. But this is not possible since $|\alpha(\tilde{t})| = 1$ (for more details, see [2, Propozicija 19]. We conclude that $\alpha I - V$ can not be surjective, so $\alpha \in \sigma^{\mathcal{A}}(V)$. On the other hand, if $\alpha \in \mathcal{A}$ and $|\alpha|([0,1]) \cap \{1\} = \emptyset$, then either $|\alpha(t)| \geq C > 1$ or $|\alpha(t)| \leq K < 1$ for all $t \in [0,1]$ and some constants C and K (here we muse that $|\alpha|$ is continuous, hence $|\alpha|([0,1])$ must be connected). If $|\alpha(t)| \ge C > 1$ for all $t \in [0,1]$, then α is invertible in \mathcal{A} and $\| \alpha^{-1} \| \leq \frac{1}{C} < 1$. Since $\| V \| = 1$ it follows that $\alpha \notin \sigma^{\mathcal{A}}(V)$ then. If $|\alpha(t)| \leq K < 1$ $t \in [0, 1]$, then $\| \alpha \| \leq K < 1$, so again using that $\alpha I - V = V(\alpha V^* - I)$ it follows that $\alpha \notin \sigma^{\mathcal{A}}(V)$ then. Hence $\sigma^{\mathcal{A}}(V) = \{\alpha \in \mathcal{A}\}$ $\mathcal{A} \mid |\alpha|([0,1]) \cap \{1\} \neq \emptyset\}$ Next, if $(\alpha I - V)(x) = 0$ for some $x \in H_{\mathcal{A}}$, then we must have $\alpha(t)x(t) - \tilde{V}x(t) = 0$ for all $t \in [0, 1]$. This means that x(t) = 0 for all $t \in [0, 1].$ \square

Case 2:

Let now $\mathcal{A} = L^{\infty}((0,1))$ and $\alpha \in \mathcal{A}$ be such that $\mu(|\alpha|^{-1}((1-\epsilon,1+\epsilon))) > 0$ for all $\epsilon > 0$. If $(\alpha I - V)x = e_0$ for some $x \in H_{\mathcal{A}}$, then we must have $\alpha x_k - x_{k-1} = 0$ for all $k \neq 0$ and $\alpha x_0 - x_{-1} = 1$. For small $\epsilon > 0$ set $M_{\epsilon} = |\alpha|^{-1}((1-\epsilon,1+\epsilon))$, $M_{\epsilon}^- = |\alpha|^{-1}((1-\epsilon,1)), M_{\epsilon}^+ = |\alpha|^{-1}((1,1+\epsilon))$, so $M_{\epsilon} = M_{\epsilon}^- \cup M_{\epsilon}^+, \chi_{M_{\epsilon}} \neq 0$. From the equations above we get $x_k = \alpha^{-(k+1)}x_{-1}$ for all $k \leq -1$ and $x_k = \alpha^{-k}x_0$ for all $k \geq 1$ on any subset of (0,1) on which α is bounded below, thus in particular on M_{ϵ} . It follows that $x_k\chi_{M_{\epsilon}^+} = 0$ for all $k \leq -1$ and $x_k\chi_{M_{\epsilon}^-} = 0$ for all $k \geq 0$. Setting this into the second equation above, we get $\alpha x_0\chi_{M_{\epsilon}^+} - x_1\chi_{M_{\epsilon}^-} = \chi_{M_{\epsilon}}$ which gives $x_0 = \alpha^{-1}\chi_{M_{\epsilon}^+}$ and $x_1 = -\chi_{M_{\epsilon}^-}$. Hence $x_k = \alpha^{-(k+1)}\chi_{M_{\epsilon}^+}$ for all $k \geq 0$ and $x_k = -\alpha^{-(k+1)}\chi_{M_{\epsilon}^-}$ for all $k \leq -1$. This gives $|x_k| \geq (1+\epsilon)^{-(k+1)}\chi_{M_{\epsilon}^+}$ for all $k \geq 0$ and $|x_k| \geq (1-\epsilon)^{-(k+1)}\chi_{M_{\epsilon}^-}$ for all $k \leq -1$. Since this holds for all $\epsilon > 0$ and moreover, we have that either $\chi_{M_{\epsilon}^-}$ or $\chi_{M_{\epsilon}^+}$ is non zero (because $\chi_{M_{\epsilon}}$ for all $\epsilon > 0$), we get that the infinite sum $\sum_{k \in \mathbb{Z}} x_k^* x_k$ diverge in \mathcal{A} , so x can not be an element of $H_{\mathcal{A}}$. We conclude that $e_0 \notin Im(\alpha I - V)$, so $\alpha \in \sigma^{\mathcal{A}}(V)$ in this case.

On the other hand, if $\mu(|\alpha|^{-1}((1-\epsilon, 1+\epsilon))) = 0$ for some $\alpha \in \mathcal{A}$ and some $\epsilon > 0$, then $(0, 1) = N_{\epsilon}^{-} \cup N_{\epsilon}^{+}$ where $N_{\epsilon}^{-} = |\alpha|^{-1}((0, 1-\epsilon))$ and $N_{\epsilon}^{+} = |\alpha|^{-1}((1+\epsilon, \|\alpha\|))$. Since the submodules $H_{\mathcal{A}} \cdot \chi_{N_{\epsilon}^{-}}$ and $H_{\mathcal{A}} \cdot \chi_{N_{\epsilon}^{+}}$ clearly reduce the operator V and the restrictions of $\alpha I - V$ on both these submodules are invertible, it follows that $\alpha I - V$ is invertible, so $\alpha \notin \sigma^{\mathcal{A}}(V)$.

Example 2.12. Let $\{\alpha_1, \alpha_2, \cdots\}$ be a sequence in a unital C^* -algebra \mathcal{A} s.t. each α_k is a unitary element of \mathcal{A} . Then the operator V defined by $V(x_1, x_2, \cdots) = (\alpha_1 x_1, \alpha_2 x_2, \cdots)$ is a unitary operator on $H_{\mathcal{A}}$. We have $\sigma^{\mathcal{A}}(V) = \{\beta \in \mathcal{A} \mid \beta - \alpha_k \text{ is not right invertible in } \mathcal{A} \text{ or that } (\beta - \alpha_k)\gamma_k = 0 \text{ for some } \gamma_k \in \mathcal{A}\}$. If $\mathcal{A} = C([0, 1])$ or if $\mathcal{A} = L^{\infty}((0, 1))$ and J_1, J_2 are two closed subintervals of (0, 1) such that $J_1 \cap J_2 = \emptyset$, then we may easily find a function $\beta \in \mathcal{A}$ such that $\beta = \alpha_1$ on

 J_1 and $|\beta(t)| > 1$ for all $t \in J_2$. Hence $||\beta|| > 1$, but we also have $\beta \in \sigma^{\mathcal{A}}(V)$. Similarly, if $\mathcal{A} = B(H)$ where H is a Hilbert space, then we may easily find two closed suspaces H_1 and H_2 such that $H_1 \perp H_2$ and $T \in B(H)$ is such that $T_{|H_1} = \alpha_{1|_{H_1}}$ and $||T_{|_{H_2}}|| > 1$. Hence again $T \in \sigma^{\mathcal{A}}(V)$ and ||T|| > 1. So, if V is a unitary operator on $H_{\mathcal{A}}$, we do <u>not</u> have in general that $\sigma^{\mathcal{A}}(V) \subseteq \{\alpha \in \mathcal{A} \mid ||\alpha|| = 1\}$.

Lemma 2.13. If F is a self-adjoint operator on $H_{\mathcal{A}}$, then $\sigma_p^{\mathcal{A}}(F)$ is a self-adjoint subset of \mathcal{A} , that is $\alpha \in \sigma_p^{\mathcal{A}}(F)$ if and only if $\alpha^* \in \sigma_p^{\mathcal{A}}(F)$ in the case when \mathcal{A} is a commutative C^* -algebra.

Proof. Since $F - \alpha I$ and $F - \alpha^* I = F^* - \alpha^* I$ mutually commute, we can deduce that $|| (F - \alpha I)x || = || (F - \alpha^* I)x ||$ for all $x \in H_A$.

Example 2.14. Let $\mathcal{A} = C([0,1])$ or $\mathcal{A} = L^{\infty}((0,1))$. If G is the operator on $H_{\mathcal{A}}$ given by $G(f_1, f_2, \cdots) = (g_1f_1, g_2f_2, \cdots)$, where $\{g_1, g_2, \cdots\}$ is a bounded sequence of real valued functions in \mathcal{A} , then G is a self-adjoint operator. Suppose that there are two mutually disjoint, closed subintervals J_1 and J_2 of (0,1) such that $g_{1|_{J_1}} \neq 0$ and $g_{1|_{J_2}} = 0$. Set $\tilde{g} = ig_1$. Then, if we choose a function f in \mathcal{A} such that supp $f \subseteq J_2$, we get that $(\tilde{g}I - G)(f, 0, 0, \cdots) = 0$. However $\tilde{g} \neq \tilde{g}$, so we do <u>not</u> have that $\sigma_p^{\mathcal{A}}(G)$ is included in the set of self-adjoint elements of \mathcal{A} .

Example 2.15. Let $\mathcal{A} = B(H)$ where H is a Hilbert space and let $\{e_j\}_{j \in \mathbb{N}}$ be an orthonormal basis for H. If P denotes the orthogonal projection onto $Span\{e_1\}$, then the operator $P \cdot I$ is a self-adjoint operator on $H_{\mathcal{A}}$. Now, if S is the unilateral shift operator on H w.r.t. to the orthonormal basis $\{e_j\}$, then S - P is injective whereas $S^* - P$ is <u>not</u> injective because $(S^* - P)(e_1 + e_2) = 0$. It follows that $(S - P) \cdot I$ is an injective operator whereas $(S^* - P) \cdot I = ((S - P) \cdot I)^*$ is **not** an injective operator. Hence, if $\mathcal{A} = B(H)$ where H is a Hilbert space, we do not have in general that $\sigma_p^{\mathcal{A}}(F)$ is a self-adjoint subset of \mathcal{A} when $F = F^*$.

Lemma 2.16. Let \mathcal{A} be a commutative C^* -algebra. If F is a self-adjoint operator on $H_{\mathcal{A}}$ and $\alpha \in \mathcal{A} \setminus \sigma_p^{\mathcal{A}}(F)$, then $\overline{R(F - \alpha I)}^{\perp} = \{0\}$. Hence, if $\alpha \in \mathcal{A} \setminus \sigma_p^{\mathcal{A}}(F)$ and in addition $F - \alpha I$ is bounded below, then $\alpha \in \mathcal{A} \setminus \sigma^{\mathcal{A}}(F)$.

Proof. Suppose now that $\alpha \in \mathcal{A} \setminus \sigma_p^{\mathcal{A}}(F)$. If $y \in \overline{Im(F - \alpha I)}^{\perp}$, then for all $x \in H_{\mathcal{A}}$ we have $\langle (F - \alpha I)x, y \rangle = 0$. This gives $\langle x, (F - \alpha^* I)y \rangle = 0$. for all $x \in H_{\mathcal{A}}$. It follows that $(F - \alpha^* I)y = 0$ in this case. By the arguments above we obtain the $(F - \alpha I)y = 0$. Since $\alpha \notin \sigma_p^{\mathcal{A}}(F)$ by the choice of α , we get that y = 0. Thus $\overline{Im(F - \alpha I)}^{\perp} = \{0\}$, when $\alpha \in \mathcal{A} \setminus \sigma_p^{\mathcal{A}}(F)$.

Suppose next that $\alpha \in \mathcal{A}$ is such that $F - \alpha I$ is bounded below. Then $\alpha \in \mathcal{A} \setminus \sigma_p^{\mathcal{A}}(F)$ so from the previous arguments we deduce that $Im(F - \alpha I)^{\perp} = \{0\}$. Moreover, since $Im(F - \alpha I)$ is then closed and $F - \alpha I \in B^a(H_{\mathcal{A}})$, from [3, Theorem 2.3.3] it follows that $Im(F - \alpha I)$ is orthogonally complementable in $H_{\mathcal{A}}$. But, since $Im(F - \alpha I)^{\perp} = \{0\}$, we must have that $Im(F - \alpha I) = H_{\mathcal{A}}$. Hence $F - \alpha I$ is invertible in $B^a(H_{\mathcal{A}})$, so α is in $\mathcal{A} \setminus \sigma^{\mathcal{A}}(F)$.

Corollary 2.17. Let \mathcal{A} be a unital commutative C^* -algebra and F be a selfadjoint operator on $H_{\mathcal{A}}$. If $\alpha \in \mathcal{A}$ and $\alpha - \alpha^* \in G(\mathcal{A})$, then $F - \alpha I$ is invertible. In this case $\parallel (F - \alpha I)^{-1} \parallel \leq 2 \parallel (\alpha - \alpha^*)^{-1} \parallel$. Proof. If $\alpha \in \mathcal{A}$ and $\alpha - \alpha^* \in G(\mathcal{A})$, we have $\langle Fx - \alpha Ix, x \rangle - \langle x, Fx - \alpha Ix \rangle = \langle x, x \rangle \alpha - \alpha^* \langle x, x \rangle = (\alpha - \alpha^*) \langle x, x \rangle$ (here we use that \mathcal{A} is commutative). From the triangle inequality and the Cauchy-Schwartz inequality for the inner product we obtain $\|(\alpha - \alpha^*) \langle x, x \rangle\| \leq 2 \|x\| \|Fx - \alpha Ix\|$. Since $(\alpha - \alpha^*)$ is invertible by assumption, we get that $\|(\alpha - \alpha^*)\|\langle x, x \rangle \geq \frac{1}{\|(\alpha - \alpha^*)^{-1}\|} \|\langle x, x \rangle\|$. It follows that $\|(F - \alpha I)(x)\| \geq \frac{1}{2\|(\alpha - \alpha^*)^{-1}\|} \|\langle x, x \rangle\|$ for all $x \in H_{\mathcal{A}}$.

Remark 2.18. Let $\mathcal{A} = C([0,1])$ or $\mathcal{A} = L^{\infty}((0,1))$. As we have seen in Example 2.14 the operator $\tilde{g}I - G$ is not invertible, whereas $\tilde{g} - \overline{\tilde{g}} = 1ig_1 \neq 0$. Therefore, the requirement that $a - a^*$ is invertible is indeed necessary in Corollary 2.17.

Example 2.19. Let $\mathcal{A} = M_2(\mathbb{C})$ and $T_1, T_2 \in \mathcal{A}$ be given as $T_1 = \begin{bmatrix} 2 & 1 \\ 1 & 0 \end{bmatrix}$, $T_2 = \begin{bmatrix} 0 & i \\ i & i \end{bmatrix}$. Then T_1 is self-adjoint and $T_2 - T_2^* = 2i \begin{bmatrix} 0 & 1 \\ 1 & 1 \end{bmatrix}$, so $T_2 - T_2^*$ is invertible. Now $T_1 - T_2 = \begin{bmatrix} 1 & 1-i \\ 1-i & -i \end{bmatrix}$, so $det(T_1 - T_2) = 0$ which gives $T_1 - T_2$ is not invertible. Hence the operator $F := T_1 \cdot I$ is a self-adjoint operator on $H_{\mathcal{A}}$, but $F - T_2 \cdot I = (T_1 - T_2) \cdot I$ is <u>not</u> invertible. This shows that the assumption that \mathcal{A} is commutative in Corollary 2.17 is indeed necessary.

For a self-adjoint operator F on $H_{\mathcal{A}}$, set $M(F) = \sup\{\|\langle Fx, x \rangle \| \| \|x\| = 1\}$ and $m(F) = \inf\{\|\langle Fx, x \rangle \| \| \|x\| = 1\}$. We have the following corollary.

Corollary 2.20. If $\mathcal{A} = C([0,1])$ and F is a self-adjoint operator on $H_{\mathcal{A}}$, then $\sigma^{\mathcal{A}}(F) \subseteq \{f \in \mathcal{A} \mid |f|(0,1) \cap [m,M] \neq \emptyset\}$. If $\mathcal{A} = L^{\infty}((0,1))$ and F is a self-adjoint operator on $H_{\mathcal{A}}$ then $\sigma^{\mathcal{A}}(F) \subseteq \{f \in \mathcal{A} \mid \mu(|f|^{-1}[m-\epsilon, M+\epsilon]) > 0$ for some $\epsilon = \epsilon(f) > 0\}$.

Proof. Let F be a self-adjoint operator on $H_{\mathcal{A}}$ where $\mathcal{A} = L^{\infty}((0, 1))$ and let $\alpha \in \mathcal{A}$ be such that there exists an $\epsilon = \epsilon(\alpha)$ with the property that $\mu(|f|^{-1}((m-\epsilon, M+\epsilon)) = 0$. Then $(0,1) = M_1 \cup M_2$ where M_1 and M_2 are Borel measurable, mutually disjoint subsets of (0,1) satisfying $|\alpha|\chi_{M_1} \geq M + \epsilon$ and $|\alpha|\chi_{M_2} \leq m - \epsilon$ a.e. Then, for all $x \in H_{\mathcal{A}}$ we have $\langle (F - \alpha I)x, x \rangle = \langle (F - \alpha I)x, x \rangle \cdot \chi_{M_1} + \langle (F - \alpha I)x, x \rangle \cdot \chi_{M_2}$

Now, we have

$$\| \langle (F - \alpha I)x, x \rangle \| \geq$$

$$\| \langle (F - \alpha I)x, x \rangle \chi_{M_1} \| \geq \| \overline{\alpha} \langle x, x \rangle \chi_{M_1} \| - \| \langle Fx \cdot \chi_1, x \cdot \chi_{M_1} \rangle \| \geq$$

$$\geq (M + \epsilon) \| \langle x, x \rangle \chi_{M_1} \| - \| \langle F(x \cdot \chi_{M_1}), x \cdot \chi_{M_1} \rangle \| \geq$$

$$\geq (M + \epsilon) \| \langle x, x \rangle \chi_{M_1} \| - M \| \langle x \cdot \chi_{M_1}, x \cdot \chi_{M_1} \rangle \| =$$

 $= (M + \epsilon) \parallel \langle x, x \rangle \chi_{M_1} \parallel -M \parallel \chi_{M_1} \langle x, x \rangle \chi_{M_1} \parallel = \epsilon \parallel \langle x, x \rangle \chi_{M_1} \parallel$ (where we have used that

$$\|\langle Fy,y\rangle = \|y\|^2 \|\langle F(\frac{y}{\|y\|}), \frac{y}{\|y\|}\rangle \|\leq \|\langle y,y\rangle \|M\rangle.$$

Next

$$\parallel \langle (F - \alpha I)x, x \rangle \parallel \geq$$

$$\geq \parallel \langle (F - \alpha I)x, x \rangle \chi_{M_2} \parallel \geq \parallel \langle Fx, x \rangle \chi_{M_2} \parallel - \parallel \tilde{\alpha} \langle x, x \rangle \chi_{M_2} \parallel =$$

$$= \| \langle F(x\chi_{M_2}), x\chi_{M_2} \rangle \| - \| \tilde{\alpha} \langle x, x \rangle \chi_{M_2} \| \ge m \| \langle x \cdot \chi_{M_2}, x \cdot \chi_{M_2} \rangle \| - (m - \epsilon) \| \langle x, x \rangle \chi_{M_2} \| = \epsilon \| \langle x, x \rangle \chi_{M_2} \|.$$

Hence $\|\langle (F - \alpha I)x, x \rangle \| \ge \epsilon \max\{\|\langle x, x \rangle \chi_{M_2}\|, \|\langle x, x \rangle M_2 \rangle \| = \epsilon \|\langle x, x \rangle \rangle \|.$

Thus $|| (F - \alpha I)x || || x || \ge || \langle (F - \alpha I)x, x \rangle || \ge \epsilon || x ||^2$ for a $x \in H_A$. It follows that $F - \alpha I$ is bounded below, hence from the previous result we deduce that $F - \alpha I$ is invertible in $B^a(H_A)$.

The proof in the case when $\mathcal{A} = C([0, 1])$ is similar, but more simple, because if $\alpha \in \mathcal{A}$ and $|\alpha|(0, 1) \cap [m, M] = \emptyset$, then by continuity of $|\alpha|$ we must either have that $|\alpha| < m$ or $|\alpha| > M$ that on the whole interval [0, 1]. Moreover, there exist then $\epsilon > 0$ such that $|\alpha|m - \epsilon$ or $|\alpha| \ge M + \epsilon$ on the whole [0, 1] (since $|\alpha|$ reaches its maximum and minimum on [0, 1]). Then we may proceed in the same way as in the proof above.

Lemma 2.21. Let \mathcal{A} be a commutative unital C^* -algebra and F be a normal operator on $H_{\mathcal{A}}$, that is $FF^* = F^*F$. If $\alpha_1, \alpha_2 \in \sigma_p^{\mathcal{A}}(F)$ and $\alpha_1 - \alpha_2$ is invertible in \mathcal{A} , then ker $(F - \alpha_1 I) \perp \text{ker}(F - \alpha_2 I)$.

Proof. Since F commutes with F^* and \mathcal{A} is a commutative unital C^* -algebra, then $F - \alpha_2 I$ and $F^* - \alpha_2^* I$ commute. Hence $\ker(F - \alpha_2 I) = \ker(F^* - \alpha_2^* I)$. For $x_1 \in \ker(F - \alpha_2 I)$ and $x_2 \in \ker(F - \alpha_2 I) = \ker(F^* - \alpha_2^* I)$ we get $\langle x_2 - x_1 \rangle \langle \alpha_1 - \alpha_2 \rangle = \langle x_2 - x_1 \rangle \alpha_1 - \alpha_2 \langle x_2 - x_1 \rangle = \langle x_2, Fx_1 \rangle - \langle F^*x_2, x_1 \rangle = 0$. Since $(\alpha_1 - \alpha_2)$ is invertible by assumption, it follows that $\langle x_2, x_1 \rangle = 0$.

Example 2.22. Let $\mathcal{A} = C([0,1])$ or $\mathcal{A} = L^{\infty}((0,1))$, consider the self-adjoint operator G from the previous example. For any function f in \mathcal{A} with the support contained in J_2 , we have $(f, 0, 0, \cdots) \in \ker G \cap \ker(\tilde{g}I - G)$. However $\tilde{g} = ig_1 \neq 0$ and $f \neq 0$, but \tilde{g} is <u>not</u> invertible in \mathcal{A} .

Example 2.23. Let $\mathcal{A} = B(H)$ and $T \in \mathcal{A}$ be a normal and invertible operator. If H_1 and H_2 are two closed subspaces of H such that $H = H_1 \oplus H_2$ and $H_1 \neq H_2^{\perp}$ (that is H_1 and H_2 are not mutually orthogonal), then $T\Pi$ and $T(1 - \Pi)$ are elements of $\sigma_p^{\mathcal{A}}(T \cdot I)$, where Π stands for the skew projection onto H_1 along H_2 . Moreover, the operator $T \cdot I$ is normal operator on $H_{\mathcal{A}}$ and $T\Pi - T(1 - \Pi)$ is invertible in \mathcal{A} . However, if P_1 and P_2 denote the orthogonal projections onto H_1 and H_2 , respectively, then $e_j \cdot P_1 \in \ker(T\Pi \cdot I - T \cdot I), e_j \cdot P_2 \in \ker(T(I - \Pi) \cdot I - T \cdot I)$ for all j and $P_1P_2 \neq 0$. So the assumption that \mathcal{A} is commutative is indeed necessary in Lemma 2.21.

Lemma 2.24. Let \mathcal{A} be a commutative C^* -algebra and F be a normal operator on $H_{\mathcal{A}}$. Then $\sigma_{rl}^{\mathcal{A}}(F) = \emptyset$, hence $\sigma^{\mathcal{A}}(F) = \sigma_p^{\mathcal{A}}(F) \cup \sigma_{cl}^{\mathcal{A}}(F)$.

Proof. Suppose that $\alpha \in \sigma_{rl}^{\mathcal{A}}(F)$. Then $F - \alpha I$ is bounded below. Again, since $F - \alpha I$ and $F^* - \alpha^* I$ commute (because \mathcal{A} is commutative, so αI commutes with $\alpha^* I$.) we get that $\ker(F - \alpha I) = \ker(F^* - \alpha^* I) = \{0\}$. Next, since $Im(F - \alpha I)$ is closed,

by [3, Theorem 2.3.3], we have $H_{\mathcal{A}} = \ker(F^* - \alpha^* I) \oplus Im(F - \alpha I) = Im(F - \alpha I)$. So $F - \alpha I$ is surjective, thus invertible, which gives that $\sigma_{rl}^{\mathcal{A}}(F) = \emptyset$. \Box

Example 2.25. Let $\mathcal{A} = B(H)$ and S, P be as in Example 2.15. Then $P \cdot I$ is a normal operator on $H_{\mathcal{A}}$ being self-adjoint and $(S - P) \cdot I$ is bounded below on $H_{\mathcal{A}}$. Indeed, $\parallel (S - P)x \parallel \geq \parallel x \parallel$ for all $x \in H$, hence $m(S - P) \geq 1$ so $T^*(S - P)^*(S - P)T \geq m(S - P)^2T^*T$ for all $T \in B(H)$ which gives that $(S - P) \cdot I$ is bounded below on $H_{\mathcal{A}}$. However, $Im((S - P) \cdot I)^{\perp} = \ker((S^* - P) \cdot I)$. and $\ker((S^* - P) \cdot I) \neq \{0\}$ as we have seen in Example 2.15. Hence $P \cdot I$ is a normal operator on $H_{\mathcal{A}}$ and $S \in \sigma_{rl}^{\mathcal{A}}(P \cdot I)$ which shows that the assumption that \mathcal{A} is commutative is indeed necessary in Lemma 2.24.

Next, for $F \in B^a(H_A)$, set $\sigma_a^{\mathcal{A}}(F) = \{ \alpha \in \mathcal{A} \mid F - \alpha I \text{ is not bounded below } \}$. The next two propositions can be proved in exactly the same way same way as for operators on Hilbert spaces.

Proposition 2.26. For $F \in B^a(H_A)$, we have that $\sigma_a^A(F)$ is a closed subset of \mathcal{A} in the norm topology and $\sigma^A(F) = \sigma_a^A(F) \cup \sigma_{rl}^A(F)$.

Proposition 2.27. If $F \in B^a(H_A)$, then $\delta\sigma^{\mathcal{A}}(F) \subseteq \sigma_a^{\mathcal{A}}(F)$. Moreover, if M is a closed submodule of H_A and invariant with respect to F, and $F_0 = F_{|_M}$, then we have $\partial\sigma^{\mathcal{A}}(F_0) \subseteq \sigma_a^{\mathcal{A}}(F)$, $\sigma^{\mathcal{A}}(F_0) \cap \sigma^{\mathcal{A}}(F) = \sigma_{rl}^{\mathcal{A}}(F_0)$.

Example 2.28. We may also consider the operators on $H_{\mathcal{A}}$ when \mathcal{A} is a unital C^* -algebra defined as $W'(e_k) = e_{2k}$ and $W''(e_k) = e_{2k-1} \ \forall k \in \mathbb{N}$. Also for these operators we have $\sigma^{\mathcal{A}}(W') = \sigma^{\mathcal{A}}(W'') = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$ in the case when $\mathcal{A} = C([0,1])$ or when $\mathcal{A} = L^{\infty}((0,1))$. Suppose now that $\mathcal{A} = L^{\infty}((0,1))$ and consider the operator F on $H_{\mathcal{A}}$ given by $F(f_1, f_2, f_3, \cdots) = (\chi_{(0,\frac{1}{2})})f_1, \chi_{(\frac{1}{2},1)}f_1, \chi_{(0,\frac{1}{2})})f_2, \chi_{(\frac{1}{2},1)}f_2, \cdots)$. It follows that F has the matrix $\begin{bmatrix} W'' & 0 \\ 0 & W' \end{bmatrix}$ w.r.t the decomposition $(H_{\mathcal{A}} \cdot \chi_{(0,\frac{1}{2})}) \oplus (H_{\mathcal{A}} \cdot \chi_{(\frac{1}{2},1)})$. Therefore $\sigma^{\mathcal{A}}(F) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$. Next $\sigma_p^{\mathcal{A}}(W') = \emptyset, \sigma_p^{\mathcal{A}}(W'') = \{\alpha \in \mathcal{A} \mid \alpha = 1 \text{ on some closed subinterval } J \subseteq [0,1] \}$ in the case when $\mathcal{A} = C([0,1])$ and $\sigma_p^{\mathcal{A}}(W'') = \{\alpha \in \mathcal{A} \mid \mu(\{t \in (0,1) \mid \alpha(t) = 1\}) > 0\}$ in the case $\mathcal{A} = L^{\infty}((0,1))$. Hence $\sigma_p^{\mathcal{A}}(F) = \{\alpha \in \mathcal{A} \mid \mu(\{t \in (0,1) \mid \alpha(t) = 1\}) > 0\}$.

Consider now the operators

$$Z(e_j) = \begin{cases} e_k & \text{when } j = 2k \\ 0 & \text{else} \end{cases}, \ k \in \mathbb{N}$$
$$Z'(e_j) = \begin{cases} e_k & \text{when } j = 2k - 1 \\ 0 & \text{else} \end{cases}, \ k \in \mathbb{N}$$

Then $\sigma^{\mathcal{A}}(Z) = \sigma^{\mathcal{A}}(Z') = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$. This follows since $Z = W'^*$ and $Z' = W''^*$. Moreover, we have $\sigma_p^{\mathcal{A}}(Z) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1\}$ in both cases. In the case $\mathcal{A} = L^{\infty}((0,1))$ we have $\sigma_p^{\mathcal{A}}(Z') = \{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1 \text{ or } \mu(\{t \in (0,1) \mid \alpha(t) = 1)\} > 0\}$ and in the case when $\mathcal{A} = C([0,1])$ we have $\sigma_p^{\mathcal{A}}(Z') = \{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1 \text{ or } \alpha = 1 \text{ on some closed subinterval } J \subseteq [0,1]\}$. Let operator D on $H_{\mathcal{A}}$ be given by $D(g_1, g_2, g_3, \cdots) = (g_1\chi_{(0,\frac{1}{2})} + g_2\chi_{(\frac{1}{2},1)}, g_3\chi_{(0,\frac{1}{2})}) + g_4\chi_{(\frac{1}{2},1)}, \cdots)$

when $\mathcal{A} = L^{\infty}((0,1))$. Then $D = F^*$ and D has the matrix $\begin{bmatrix} Z' & 0 \\ 0 & Z \end{bmatrix}$ w.r.t. the decomposition $H_{\mathcal{A}\chi_{(0,\frac{1}{2})}} \oplus H_{\mathcal{A}\chi_{(\frac{1}{2},1)}}$ It follows that $\sigma^{\mathcal{A}}(D) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1\}$ and $\sigma_p^{\mathcal{A}}(D) = \{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1 \text{ or } \mu(\{t \in (0,\frac{1}{2}) \mid \alpha(t) = 1\}) > 0\}.$

Now we are going to prove the statements in this example. Again, we consider two cases.

Case 1: $\mathcal{A} = L^{\infty}(0,1)$. If $\inf |\alpha| < 1$ for $\alpha \in \mathcal{A}$, then there exist an $\epsilon > 0$ such that $\mu(|\alpha|^{-1}((0,1-\epsilon))) > 0$. Set $M_{\epsilon} = |\alpha|^{-1}((0,1-\epsilon))$ and put $x_{\alpha} =$ $\sum_{K=0}^{\infty} e_{2^k} \cdot \chi_{M_{\epsilon}} \overline{\alpha}^k$. Then it is easily seen that x_{α} indeed is an element of $H_{\mathcal{A}}$ and moreover $\langle (\alpha I - W')e_k, x_{\alpha I} \rangle = 0$ for all k, so $x_{\alpha} \in Im(\alpha I - W')^{\perp}$. Therefore, $\alpha \in \sigma^{\mathcal{A}}(W')$. On the other hand, we have ||W'|| = 1, hence if $inf|\alpha| > 1$, it follows by the same arguments as before that $\alpha I - W' = \alpha (I - \alpha^{-1})W'$ is invertible in $B^{a}(H_{\mathcal{A}})$. Hence, using that $\sigma^{\mathcal{A}}(W')$ is closed in the norm topology of \mathcal{A} , we obtain that $\sigma^{\mathcal{A}}(W') = \{ \alpha \in \mathcal{A} \mid inf | \alpha | \leq 1 \}$. Next, if $(\alpha I - W')(x) = 0$, then we must have $\alpha x_{2k} - x_k = 0$ for all $k \in \mathbb{N}$ which gives $x_k = 0$ a.e. on $\{t \in (0,1) \mid \alpha(t) = 0\}$ for all $k \in \mathbb{N}$. Moreover, $\alpha x_m = 0$ for all odd m. All this together implies that x_m for all odd m. Now, if $j = 2^k m$ where m is odd, we get $x_m = \alpha^k x_j$. Since $x_m = 0$, it follows that $x_j = 0$ a.e. on $\{t \in (0,1) \mid \alpha(t) \neq 0\}$. But since $x_n = 0$ a.e. on $\{t \in (0,1) \mid \alpha(t) = 0\}$. for all $n \in \mathbb{N}$, we must have $x_i = 0$. In particular $x_2 = 0$. Then, from the arguments above it also follows that $x_{2^k} = x_{2^{k-1} \cdot 2} = 0$ for all k. Thus x = 0, so $\sigma^{\mathcal{A}}(W') = \emptyset$. The proof for the case when $\mathcal{A} = C([0, 1])$ is similar.

Next, we consider the operator W''. If $\inf |\alpha| < 1$ for some $\alpha \in \mathcal{A} = L^{\infty}((0, 1))$, we let $M_{\epsilon} \subseteq (0,1)$ be the same set as before. Put $y_{\alpha} = \sum e_{r_k} \chi_{M_{\epsilon}} \overline{\alpha}^{(k-1)}$, where $\{r_k\}$ is the strictly increasing sequence of positive integers recursively defined by $r_{k+1} = 2r_k - 1$ for $k \in \mathbb{N}$ and $r_1 = 2$. Then we have $\langle (\alpha I - W'')e_k, y_\alpha \rangle$ for all $k \in \mathbb{N}$, so $y_{\alpha} \in Im(\alpha I - W'')^{\perp}$. By the same arguments as before using that || W'' || = 1, we obtain that $\sigma^{\mathcal{A}}(W'') = \{ \alpha \in \mathcal{A} \mid \inf |\alpha| \leq 1 \}$. Again, the proof for the case when $\mathcal{A} = C([0,1])$ is similar. Suppose next that $(\alpha I - W'')x = 0$ for some $x \in H_A$. Then for all $k \in \mathbb{N}$ we must have $\alpha x_{2k-1} - x_k = 0$ which gives $x_k = 0$ a.e. on $\{t \in (0,1) \mid \alpha(t) = 0\}$ for all $k \in \mathbb{N}$. Moreover $\alpha x_{2k} = 0$ for all k and all this together implies that $x_{2k} = 0$ for all k. If $\alpha \neq 1$ a.e. on (0,1), then the equation $\alpha x_1 - x_1 = 0$ gives $x_1 = 0$. Assume now that $x_{2j-1} = 0$ for $j \in \{1, \dots, m\}$. We have $\alpha x_{2m+1} - x_{m+1} = 0$. If m+1 is even, then we already have that $x_{m+1} = 0$. If m + 1 is odd, then by induction hypothesis we must have $x_{m+1} = 0$ since $m+1 \leq 2m-1$ in this case (we assume that $m \in \mathbb{N}$, so if m+1is odd, then $m \geq 2$). Hence $\alpha x_{2m+1} = 0$. Combining this together with the fact that $x_{2m+1} = 0$ a.e. on $\{t \in (0,1) \mid \alpha(t) = 0\}$, we deduce that $x_{2m+1} = 0$. By induction we obtain that $x_{2k-1} = 0$ for all $k \in \mathbb{N}$. Hence x = 0. So, if $\alpha \in \mathcal{A}$ is such that $\alpha \neq 1$ a.e. then $\alpha \notin \sigma_p^{\mathcal{A}}(W'')$. On the other hand, if $\alpha \in \mathcal{A}$ is such that $\mu(\{t \in (0,1) \mid \alpha(t) = 1\}) > 0$, then if we let $M = \alpha^{-1}(\{1\})$, we have $\chi_M \neq 0$. Hence $(\alpha I - W'')(\chi_M, 0, 0, 0, \cdots) = 0$ so $\alpha \in \sigma_p^{\mathcal{A}}(W'')$ in this case. The proof for the case when $\mathcal{A} = C([0, 1])$ is similar.

Indeed, the equation $\alpha x_1 - x_1$ gives that $x_1 = 0$ on supp $(\alpha - 1)$. If supp $(\alpha - 1) \neq [0, 1]$, then there exists an open interval $J_0 \subseteq$ supp $(\alpha - 1)^c$, since supp $(\alpha - 1)^c$ is open. On J_0 we have that $\alpha - 1 = 0$, hence by continuity of $\alpha - 1$, we must have that $\alpha - 1 = 0$ on $\overline{J_0}$, which is a closed interval. Hence, if there is no closed subinterval of [0, 1] on which $\alpha = 1$, we must have that $\sup(\alpha - 1) = [0, 1]$, which gives $x_1 = 0$. Then we can proceed in the same way as above. On the other hand, if $\alpha = 1$ on some subinterval $[t_1, t_2] \subseteq [0, 1]$, then we may choose an $x \in C([0, 1])$ such that supp $x \subseteq [t_1, t_2]$. Then, $e_1 \cdot x \in \ker(\alpha I - W'')$.

Now we consider the operators Z and Z'. Suppose that $\alpha \in \mathcal{A} = L^{\infty}((0,1))$ and $\inf |\alpha| < 1$.

Let $\epsilon > 0$ be s.t. $\chi_{M_{\epsilon}} \neq 0$, where $M_{\epsilon} = |\alpha|^{-1}((0, 1 - \epsilon))$. Set $x_{\alpha} = \sum_{k=1}^{\infty} e_{2^k}$. $\chi_{M_{\epsilon}}\alpha^{k-1}$, then $x_{\alpha} \in H_{\mathcal{A}}, x_{\alpha} \neq 0$ and $(\alpha I - Z)x_{\alpha} = 0$. Hence $\alpha \in \sigma_p^{\mathcal{A}}(Z)$. Let now $x \in H_{\mathcal{A}}$ be such that $\inf |\alpha| = 1$. Then, if $(\alpha I - Z)x = 0$ for some $x \in H_{\mathcal{A}}$, we must have $\alpha x_k - x_{2k} = 0$ for all $k \in \mathbb{N}$. If $x_j \neq 0$ for some $j \in \mathbb{N}$, then $x_{2^k j}$ for all $k \in \mathbb{N}$. Hence $|x_{2^k j}| \geq |x_j|$ for all $k \in \mathbb{N}$ (since $\inf |\alpha| = 1$). This is improve since $x_j \neq 0$, so we deduce that $x_j = 0$ for all $j \in \mathbb{N}$, hence x = 0. Therefore $\sigma_p^{\mathcal{A}}(Z) =$ $\{\alpha \in \mathcal{A} \mid \inf |\alpha| < 1\}$. Next, we consider the operator Z'. Suppose that $\alpha \in \mathcal{A}$ and inf $\| \alpha \| < 1$. Let M_{ϵ} and $\chi_{M_{\epsilon}}$ be as before. Set $x_{\alpha} = \sum_{k=1}^{\infty} e_{r_k} \cdot \chi_{M_{\epsilon}} \alpha^{k-1}$, where $\{r_k\}$ is the strictly increasing sequence of positive integers recursively defined by $r_1 = 2, r_{k+1} = 2r_k - 1$. Then $(\alpha I - Z')x_{\alpha} = 0$. Hence $\alpha \in \sigma_p^{\mathcal{A}}(Z')$. Assume now that $\alpha \in \mathcal{A}$ and $\mu(\{t \in (0,1) \mid \alpha(t) = 1\}) > 0$. Set $M = \alpha^{-1}(\{1\})$, then $\chi_M \neq 0$ and $(\alpha I - Z')(\chi_M, 0, 0, 0, \cdots) = 0$, so $\alpha \in \sigma_p^{\mathcal{A}}(Z')$ in this case. On the other hand, if $\alpha \in \mathcal{A}$ is such that $\alpha \neq 1$ a.e on (0,1) then $x_1 = 0$ for all $x \in H_{\mathcal{A}}$ satisfying $(\alpha I - Z')x = 0$. This is because $\alpha x_1 - x_1 = 0$ then. Assume in addition that inf $|\alpha| = 1$. If $(\alpha I - Z')x = 0$ for some $x \in H_A$ and $x_j \neq 0$ for some $j \geq 2$ then we must have $x_{\tilde{r}_k} = \alpha^{k-1} x_j$ where $\{\tilde{r}_k\}$ is the strictly increasing sequence of positive integers recursively defined by $\tilde{r}_1 = j, \tilde{r}_{k+1} = 2\tilde{r}_k - 1$. This gives $|x\tilde{r}_k| \ge x_j$ for all k, which is improssible since $x \in H_{\mathcal{A}}$. Hence x = 0, so we deduce that $\alpha \notin \sigma_n^{\mathcal{A}}(Z')$ if $\inf |\alpha| \ge 1$ and $\alpha \ne 1$ a.e. on (0,1). The proof for the case when $\mathcal{A} = C([0,1])$ is similar.

Indeed, if $|\alpha| < 1$, then we can find a closed subinterval $[t_1, t_2] \subseteq [0, 1]$ such that $|\alpha(t)| \leq 1 - \epsilon$ for all $t \in [t_1, t_2]$, where $\epsilon \in (0, 1 - \inf |\alpha|)$. Let $g \in \mathcal{A}$ be such that supp $g \subseteq [t_1, t_2]$. Letting g play the role of $\chi_{M_{\epsilon}}$ in the arguments above, we can show that $\{\alpha \in \mathcal{A} | \inf |\alpha| < 1\} \subseteq \sigma_p^{\mathcal{A}}(Z')$.

Next, the equation $\alpha x_1 - x_1 = 0$ has a nontrivial solution in $\mathcal{A} = C([0, 1])$ if and only if supp $(\alpha - 1) \neq [0, 1]$ which holds if and only if $\alpha = 1$ on some closed subinterval $J \subseteq [0, 1]$. In this case we choose an $h \in \mathcal{A}$ such that supp $h \subseteq J$, then $(h, 0, 0, 0, ...) \in \ker(\alpha I - Z')$.
