# Technical Note - Exact simulation of the first passage time of Brownian motion to a symmetric linear boundary

#### Abstract

We state an exact simulation scheme for the first passage time of a Brownian motion to a symmetric linear boundary. This note summarizes a part of Chapter 4 in [1] which is the unpublished doctoral dissertation of Jong Mun Lee.


Keywords: Brownian motion, hitting time simulation, exact simulation, linear boundary

## 1 Theoretical Results

Let $\tau_{a, b}$ be the first hitting time of Brownian motion to a symmetric and linear boundary $\pm(a+b t)$ with given nonnegative coefficients $a, b$. The following theorem from [2] provides an explicit expression for the distribution of $\tau_{a, b}$ including the probability $\mathbb{P}\left[\tau_{a, b}=\infty\right]$.

Theorem 1.1 (Abundo [2]) For any $a, b>0$, the distribution of $\tau_{a, b}$ is given by

$$
\begin{aligned}
\mathbb{P}\left[\tau_{a, b} \leq t\right] & =1-\sum_{k \in \mathbb{Z}}(-1)^{k} e^{-2 k^{2} a b} \int_{(-(a+b t)+2 a k) / \sqrt{t}}^{(a+b t+2 a k) / \sqrt{t}} \frac{e^{-x^{2} / 2}}{\sqrt{2 \pi}} d x \\
\mathbb{P}\left[\tau_{a, b}<\infty\right] & =2 \sum_{k=1}^{\infty}(-1)^{k+1} e^{-2 k^{2} a b}
\end{aligned}
$$

We suggest an algorithm based on the Acceptance \& Rejection (AR) method motivated by [3] which solves the same problem under the restriction $b=0$. We first calculate the conditional density function $f_{a, b}(t)$ under the condition

$$
\left[\tau_{a, b}<\infty\right]
$$

$$
\begin{align*}
f_{a, b}(t) & =\frac{d}{d t} \mathbb{P}\left[\tau_{a, b} \leq t \mid \tau_{a, b}<\infty\right]  \tag{1}\\
& =-\frac{1}{C_{a, b}} \sum_{k \in \mathbb{Z}} \frac{(-1)^{k} e^{-2 k^{2} a b}}{\sqrt{8 \pi t^{3}}}\left((-a+b t-2 a k) e^{-\frac{(a+b t+2 a k)^{2}}{2 t}}-(a-b t-2 a k) e^{-\frac{(-a-b t+2 a k)^{2}}{2 t}}\right) \\
& =\frac{1}{C_{a, b}}\left[\frac{a-b t}{\sqrt{2 \pi t^{3}}} e^{-\frac{(a+b t)^{2}}{2 t}}+\sum_{k=1}^{\infty} \frac{(-1)^{k} e^{-2 k^{2} a b}}{\sqrt{2 \pi t^{3}}}\left((-a+b t-2 a k) e^{-\frac{(a+b t+2 a k)^{2}}{2 t}}-(a-b t-2 a k) e^{-\frac{(-a-b t+2 a k)^{2}}{2 t}}\right)\right]
\end{align*}
$$

where $C_{a, b}=\mathbb{P}\left[\tau_{a, b}<\infty\right]=2 \sum_{k=1}^{\infty}(-1)^{k+1} e^{-2 k^{2} a b}$.
To apply the AR method, we need a density whose scale-up dominates the true density $f_{a, b}$. The following theorem shows that the gamma distribution can be used.

Theorem 1.2 For any $\alpha \geq \frac{1}{2}$, there exist a constant $M$ such that

$$
\begin{equation*}
f_{a, b}(t) \leq M \cdot g\left(t ; \alpha, b^{2} / 2\right) \tag{2}
\end{equation*}
$$

for all $t \geq 0$, where $g(t: \alpha, \lambda)$ is the density function of gamma distribution given by

$$
\begin{equation*}
g(t ; \alpha, \lambda)=\frac{\lambda^{\alpha} t^{\alpha-1 e^{-\lambda t}}}{\Gamma(\alpha)} \tag{3}
\end{equation*}
$$

Proof To prove Theorem 1.2 we analyze the tail asymptotic of $f_{a, b}(t)$. The following two lemmas analyze the left tail asymptotic and the right tail asymptotic, respectively.

Lemma 1.1 (Left tail asymptotic) For any $n \geq 1$

$$
f_{a, b}(t)=o\left(t^{n}\right) \text { as } t \rightarrow 0
$$

Proof Taking the positive terms and using the fact that $e^{-x} \leq m!/ x^{m}$ for any $m \geq 0$ and $x \geq 0$, we have for $0 \leq t<a /(2 b)$ and $m \geq 2$

$$
\begin{aligned}
C_{a, b} \cdot f_{a, b}(t) \leq & \frac{a-b t}{\sqrt{2 \pi} \sqrt{t^{3}}} e^{-(a+b t)^{2} /(2 t)} \\
& +\sum_{k: o d d} e^{-2 k^{2} a b} \frac{1}{\sqrt{2 \pi} \sqrt{t^{3}}}(-a+b t+2 a k) e^{-(-(a+b t)+2 a k)^{2} /(2 t)} \\
& +\sum_{k: e v e n} e^{-2 k^{2} a b} \frac{1}{\sqrt{2 \pi} \sqrt{t^{3}}}(a-b t+2 a k) e^{-(a+b t+2 a k)^{2} /(2 t)} \\
\leq & \frac{e^{-(a-b t)^{2} /(2 t)}}{\sqrt{2 \pi} \sqrt{t^{3}}} \sum_{k \geq 0} e^{-2 k^{2} a b} a(2 k+1) \\
\leq & \frac{m!2^{m} t^{m}}{(a-b t)^{2 m}} \frac{1}{\sqrt{2 \pi} \sqrt{t^{3}}} \sum_{k \geq 0} e^{-2 k^{2} a b} a(2 k+1)=c_{m} t^{m-3 / 2},
\end{aligned}
$$

where $c_{m}$ is some constant depends on $a, b, m$ only.

## Lemma 1.2 (Right tail asymptotic)

$$
f_{a, b}(t)=O\left(t^{-\frac{1}{2}} e^{-\frac{b^{2}}{2} t}\right) \text { as } t \rightarrow \infty
$$

Proof For large enough $t$

$$
\begin{aligned}
C_{a, b} \cdot f_{a, b}(t) & \leq \sum_{k=1}^{\infty} e^{-2 k^{2} a b} \frac{2}{\sqrt{2 \pi} \sqrt{t^{3}}}\left((a+b t+2 a k) e^{-(-(a+b t)+2 a k)^{2} /(2 t)}\right) \\
& =\frac{2 e^{-(a+b t)^{2} /(2 t)}}{\sqrt{2 \pi} \sqrt{t^{3}}} \sum_{k=1}^{\infty}(a+b t+2 a k) \exp \left(-\frac{4 a^{2} k^{2}-4(a+b t) a k}{2 t}-2 k^{2} a b\right) \\
& =\frac{2 e^{-(a+b t)^{2} /(2 t)}}{\sqrt{2 \pi} \sqrt{t^{3}}} \sum_{k=1}^{\infty}(a+b t+2 a k) \exp \left(-2 a b\left(k^{2}-k\right)\right) \\
& =O\left(t^{-\frac{1}{2}} e^{-\frac{b^{2}}{2} t}\right) .
\end{aligned}
$$

From Lemma 1.1] we have $\lim _{t \rightarrow 0} \frac{f_{a, b}(t)}{g\left(t ; \alpha, b^{2} / 2\right)}=0$ for any $\alpha, b>0$. And from Lemma 1.2 we have $\lim _{\sup }^{t \rightarrow \infty} \frac{f_{a, b}(t)}{g\left(t ; \alpha, b^{2} / 2\right)}<$ $\infty$ for $\alpha \geq 1 / 2$ and thus Theorem 1.2 is proved.

Now we propose a prototype of our algorithm to sample $\tau_{a, b}$. We call Algorithm 1 a prototype since the evaluation of

$C_{a, b}$ and $f_{a, b}(t)$ cannot be done in finite time. Though we cannot evaluate $C_{a, b}$ and $f_{a, b}(t)$ exactly, it is possible to determine the corresponding inequalities exactly in finite time. We explore some special feature of the quantities $C_{a, b}$ and $f_{a, b}(t)$ first.

Definition 1.1 (Oscillating sequence and series) A sequence of numbers $\left\{a_{n}\right\}_{n=1}^{\infty}$ is called an oscillating sequence
if there exists a positive integer $N$ such that for $k \geq N$,

$$
-1<\frac{a_{k+1}-a_{k}}{a_{k}-a_{k-1}}<0
$$

And we call an infinite series $\sum_{n=1}^{\infty} a_{n}$ is an oscillating series if its partial sum $s_{n}=\sum_{k=1}^{n} a_{k}$ is an oscillating sequence.

Lemma 1.3 shows that the inequality $[S>s]$ can be determined exactly in finite time for an oscillating series $S=$ $\sum_{n=1}^{\infty} a_{n}$ and a constant $s \in \mathbb{R}$. The same technique is used in [4] which suggests an exact simulation scheme for a solution of SDE.

Lemma 1.3 Let $S=\sum_{n=1}^{\infty} a_{n}$ be an oscillating series where its oscillating property holds for $k \geq N$ and $S_{n}$ be its partial sum. We have $S>s$ if and only if

$$
\begin{equation*}
S_{k} \wedge S_{k+1}>s \tag{4}
\end{equation*}
$$

for some $k \geq N$. Conversely, We have $S<s$ if and only if

$$
\begin{equation*}
S_{k} \wedge S_{k+1}<s \tag{5}
\end{equation*}
$$

for some $k \geq N$.

The following two lemmas shows that the series $C_{a, b}$ and $f_{a, b}(t)$ used in Algorithm 1 are oscillating series.

Lemma 1.4 $C_{a, b}=2 \sum_{k=1}^{\infty}(-1)^{k+1} e^{-2 k^{2} a b}$ is an oscillating series.

Proof Let $a_{k}=(-1)^{k+1} e^{-2 k^{2} a b}$. Then we have

$$
0<-\frac{a^{(n+1)}-a^{(n)}}{a^{(n)}-p^{(n-1)}}=\frac{e^{-2(n+1)^{2} a b}}{e^{-2 n^{2} a b}}=e^{-2(2 n+1) a b}<1 .
$$

Lemma 1.5 For any $t>0, f_{a, b}(t)$ is an oscillating series with $N(t)=\max \left(\log \frac{6}{4 a b}, \frac{b t}{2 a}, 1\right)+1$

Proof Let

$$
h_{n}(t):=e^{-2 n^{2} a b}\left((-a+b t+2 a n) e^{-(-(a+b t)+2 a n)^{2} / 2 t}-(a-b t+2 a n) e^{-(a+b t+2 a n)^{2} / 2 t}\right)
$$

Then

$$
-\frac{q^{(n+1)}(t)-q^{(n)}(t)}{q^{(n)}(t)-q^{(n-1)}(t)}=\frac{h_{n+1}(t)}{h_{n}(t)} .
$$

First, we have

$$
\begin{aligned}
h_{n}(t)>0 & \Leftrightarrow(-a+b t+2 a n) e^{-(-(a+b t)+2 a n)^{2} / 2 t}>(a-b t+2 a n) e^{-(a+b t+2 a n)^{2} / 2 t} \\
& \Leftrightarrow e^{4 a^{2} n / t+4 a b n}>\frac{(a-b t+2 a n)}{(-a+b t+2 a n)} \\
& \Leftrightarrow e^{4 a b n}>\frac{(a+2 a n)}{(-a+2 a n)} .
\end{aligned}
$$

For $n>1,(a+2 a n) /(-a+2 a n)$ is strictly bounded above by 3. Thus, $h_{n}(t)$ is strictly positive when $n>$ $\max \{\log 3 / 4 a b, 1\}$. Next, we have that for $n>\max \{\log 3 / 4 a b, 1\} \vee(b / 2 a) t$,

$$
\begin{aligned}
\frac{h_{n+1}(t)}{h_{n}(t)}<1 \Leftrightarrow & e^{-2(n+1)^{2} a b} e^{-\left((a+b t)^{2}+4 a^{2}(n+1)^{2}\right) / 2 t} \\
& \times\left((-a+b t+2 a(n+1)) e^{4(a+b t) a(n+1) / 2 t}-(a-b t+2 a(n+1)) e^{-4(a+b t) a(n+1) / 2 t}\right) \\
& <e^{-2 n^{2} a b} e^{-\left((a+b t)^{2}+4 a^{2} n^{2}\right) / 2 t}\left((-a+b t+2 a n) e^{4(a+b t) a n / 2 t}-(a-b t+2 a n) e^{-4(a+b t) a n / 2 t}\right) \\
\Leftrightarrow & (-a+b t+2 a(n+1)) e^{4(a+b t) a(n+1) / 2 t}-(a-b t+2 a(n+1)) e^{-4(a+b t) a(n+1) / 2 t} \\
& <(-a+b t+2 a n) e^{4(a+b t) a(3 n+1) / 2 t}-(a-b t+2 a n) e^{4(a+b t) a(n+1) / 2 t} \\
\Leftarrow & 2 a(2 n+1) e^{4(a+b t) a(n+1) / 2 t}<(-a+b t+2 a n) e^{4(a+b t) a(3 n+1) / 2 t} \\
\Leftrightarrow & \frac{2 a(2 n+1)}{(-a+b t+2 a n)}<e^{4(a+b t) a n / t} \\
\Leftarrow & \frac{2(a+2 a n)}{(-a+2 a n)}<e^{4 a b n} .
\end{aligned}
$$

The left-hand side of the last inequality is bounded above by 6. And to conclude, we have that

$$
0<-\frac{q^{(n+1)}(t)-q^{(n)}(t)}{q^{(n)}(t)-q^{(n-1)}(t)}=\frac{h_{n+1}(t)}{h_{n}(t)}<1
$$

for $n \geq N(t):=\max \left\{\frac{\log 6}{4 a b}, \frac{b t}{2 a}, 1\right\}+1$.

Since $C_{a, b}, f_{a, b}(t)$ are oscillating, from lemma 1.3, we can determine the inequalities in Algorithm 1 in finite time.

## 2 Algorithm

Now we write down our algorithm to sample $\tau_{a, b}$. We divide our algorithm into two phases. In Algorithm 2 we decide whether $\tau_{a, b}$ is finite or not. And in Algorithm 3] we sample $\tau_{a, b}$ under the condition $\left[\tau_{a, b}<\infty\right]$. In Algorithm 2 and Algorithm 3, we write $C^{(N)}, F^{(N)}$ to denote the partial sums of $C_{a, b}$ and $f_{a, b}(t)$, respectively.
