# Alon - Tarsi numbers of direct products

#### Abstract

We provide a general framework on the coefficients of the graph polynomials of graphs which are Cartesian products. As a corollary, we prove that if $G=(V, E)$ is a graph with degrees of vertices $2 d(v), v \in V$, and the graph polynomial $\prod_{(i, j) \in E}\left(x_{j}-x_{i}\right)$ contains an "almost central" monomial (that means a monomial $\prod_{v} x_{v}^{c_{v}}$, where $\left|c_{v}-d(v)\right| \leqslant 1$ for all $v \in V$ ), then the Cartesian product $G \square C_{2 n}$ is $(d(\cdot)+2)$-choosable.


## 1 Introduction

Let $\mathbb{F}$ be a field, $\mathbf{x}=\left(x_{1}, \ldots, x_{n}\right)$ a set of variables. For $A \subset \mathbb{F}$ and $a \in A$ denote

$$
D(A, a):=\prod_{b \in A \backslash a}(a-b) .
$$

For a multi-index $\mathbf{d}=\left(d_{1}, \ldots, d_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n}$ denote $|\mathbf{d}|=d_{1}+\ldots+d_{n}$, $\mathbf{x}^{\mathbf{d}}=$ $\prod_{i=1}^{n} x_{i}^{d_{i}}$. For a polynomial $f \in \mathbb{F}[\mathbf{x}]$ denote by $\left[\mathbf{x}^{\mathbf{d}}\right] f$ the coefficient of monomial $\mathbf{x}^{\mathbf{d}}$ in polynomial $f$.

Theorem 1 (Combinatorial Nullstellensatz [1]). Choose arbitrary subsets $A_{i} \subset$ $\mathbb{F},\left|A_{i}\right|=d_{i}+1$ for $i=1, \ldots, n$. Denote $A=A_{1} \times A_{2} \times \ldots \times A_{n}$. For any polynomial $f \in \mathbb{F}[\mathbf{x}]$ such that $\operatorname{deg} f \leqslant|\mathbf{d}|$, if $\left[\mathbf{x}^{\mathbf{d}}\right] f \neq 0$, then there exists $\mathbf{a} \in A$ for which $f(\mathbf{a}) \neq 0$.

Alon and Tarsi [2] suggested to use Combinatorial Nullstellensatz for list graph colorings. Namely, if $G=(V, E)$ is a non-directed graph with the vertex set $V=\left\{v_{1}, \ldots, v_{n}\right\}$ and the edge set $E$, we define its graph polynomial in $n$ variables $x_{1}, \ldots, x_{n}$ as

$$
F_{G}(\mathbf{x})=\prod_{(i, j) \in E}\left(x_{j}-x_{i}\right)
$$

[^0]Here each edge corresponds to one linear factor $x_{j}-x_{i}$, so the whole $F_{G}$ is defined up to a sign. Assume that each vertex $v_{i}$ has a list $A_{i}$ consisting of $d_{i}+1$ colors, which are real numbers. A proper list coloring of $G$ subordinate to lists $\left\{A_{i}\right\}_{1 \leqslant i \leqslant n}$ is a choice of colors $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right) \in A_{1} \times \ldots \times A_{n}=A$ for which neighbouring vertices have different colors: $a_{i} \neq a_{j}$ whenever $(i, j) \in E$. In other words, a proper list coloring is a choice of $\mathbf{a} \in A$ for which $F_{G}(\mathbf{a}) \neq 0$. If $|\mathbf{d}|=|E|$, the existence of a proper list coloring follows from $\left[\mathbf{x}^{\mathbf{d}}\right] F_{G} \neq 0$.

Define the chromatic number $\chi(G)$ of the graph $G$ as the minimal $m$ such that there exists a proper list coloring of $G$ subordinate to equal lists of size $m$ : $A_{i}=\{1, \ldots, m\}$. Define the list chromatic number $\operatorname{ch}(G)$ of the graph $G$ as the minimal $m$ such that for arbitrary lists $A_{i},\left|A_{i}\right| \geqslant m$, there exists a proper list coloring of $G$ subordinate to these lists. Define the Alon-Tarsi number $A T(G)$ of the graph $G$ as the minimal $k$ for which there exists a monomial $\mathbf{x}^{\mathbf{d}}$ such that $\max \left(d_{1}, \ldots, d_{n}\right)=k-1$ and $\left[\mathbf{x}^{\mathbf{d}}\right] F_{G} \neq 0$.

From above we see that the list chromatic number does not exceed the AlonTarsi number:

$$
\begin{equation*}
\operatorname{ch}(G) \leqslant \operatorname{AT}(G) \tag{1}
\end{equation*}
$$

Further we consider the Alon-Tarsi numbers for the graphs which are direct products $G_{1} \square G_{2}$ of simpler graphs $G_{1}=\left(V_{1}, E_{1}\right)$ and $G_{2}=\left(V_{2}, E_{2}\right)$. Recall that the vertex set of $G_{1} \square G_{2}$ is $V_{1} \times V_{2}$ and two pairs $\left(v_{1}, v_{2}\right)$ and $\left(u_{1}, u_{2}\right)$ are joined by an edge if and only if either $v_{1}=u_{1}$ and $\left(v_{2}, u_{2}\right) \in E_{2}$ or $v_{2}=u_{2}$ and $\left(v_{1}, u_{1}\right) \in E_{1}$.

It is well known (Lemma 2.6 in [9]) that $\chi\left(G_{1} \square G_{2}\right)=\max \left(\chi\left(G_{1}\right), \chi\left(G_{2}\right)\right)$. Much less is known about the list chromatic number (and the Alon-Tarsi number) of the Cartesian product of graphs. Borowiecki, Jendrol, Král, and Miškuf [3] gave the following bound:

Theorem 2 ([3]). For any two graphs $G$ and $H$,

$$
\operatorname{ch}(G \square H) \leqslant \min (\operatorname{ch}(G)+\operatorname{col}(H), \operatorname{col}(G)+\operatorname{ch}(H))-1
$$

Here $\operatorname{col}(G)$ is the coloring number of $G$, i.e. the smallest integer $k$ for which there exists an ordering of vertices $v_{1}, \ldots, v_{n}$ of $G$ such that each vertex $v_{i}$ is adjacent to at most $k-1$ vertices among $v_{1}, \ldots, v_{i-1}$.

Here we continue the previous work [6] where the toroidal grid $C_{n} \square C_{m}$ (here $C_{n}$ is a simple cycle with $n$ edges) was considered and it was proved that $\operatorname{AT}\left(C_{n} \square C_{2 k}\right)=3$.

An explicit form of Combinatorial Nullstellensatz (the coefficient formula) was used in [6], such approach does not seem to work in the more general setting of the present paper.

We call a coefficient $\left[\mathbf{x}^{\xi}\right] F_{G}(\mathbf{x})$ of the graph polynomial $F_{G}$ central, if $\xi_{i}=$ $\operatorname{deg}_{G}\left(v_{i}\right) / 2$ for all $i$, and almost central, if $\left|\xi_{i}-\operatorname{deg}_{G}\left(v_{i}\right) / 2\right| \leqslant 1$ for all $i$.

Our main result is the following
Theorem 3. Let $G$ be a graph, all vertices in which have even degree. Suppose that the graph polynomial $F_{G}$ has at least one non-zero almost central coefficient.

Then for $H=G \square C_{2 k}$ the central coefficient is non-zero. In particular, $H$ is $\left(\operatorname{deg}_{H} / 2+1\right)$-choosable and

$$
\operatorname{ch}(H) \leqslant \operatorname{AT}(H) \leqslant \frac{\Delta(H)}{2}+1=\frac{\Delta(G)}{2}+2
$$

Note that Theorem 2 gives the bound $\operatorname{ch}(H) \leqslant \min (\operatorname{ch}(G)+2, \operatorname{col}(G)+1)$ under the same conditions. When $\operatorname{ch}(G)($ or $\operatorname{col}(G))$ is small, this bound is stronger. But it can also be weaker when $\operatorname{ch}(G)$ and $\operatorname{col}(G)$ are close to $\Delta(G)$. For example, if $G=C_{2 l+1}$ is an odd cycle, then $F_{G}$ obviously has a non-zero almost central coefficient, so, by Theorem $3, \operatorname{ch}\left(C_{2 l+1} \square C_{2 k}\right) \leqslant 3$ (this was also proved in [6] by a different argument). On the other hand, Theorem 2 gives only $\operatorname{ch}\left(C_{2 l+1} \square C_{2 k}\right) \leqslant 4$.

## 2 Coefficients as traces

Let $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right), \mathbf{b}=\left(b_{1}, \ldots, b_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n}$; denote $a_{1}+\cdots+a_{n}=|\mathbf{a}|$. Consider a polynomial

$$
P(\mathbf{x}, \mathbf{y})=Q(\mathbf{x}) R(\mathbf{x}, \mathbf{y}) \in \mathbb{F}[\mathbf{x}, \mathbf{y}]
$$

in variables $\mathbf{x}=\left(x_{1}, \ldots, x_{n}\right), \mathbf{y}=\left(y_{1}, \ldots, y_{n}\right)$, where $Q$ is of degree at most $|\mathbf{a}|$, $R$ is homogeneous of degree $|\mathbf{b}|$.

Consider $n k$ variables $\left(\mathbf{x}^{1}, \mathbf{x}^{2}, \ldots, \mathbf{x}^{k}\right), \mathbf{x}^{i}=\left(x_{1}^{i}, \ldots, x_{n}^{i}\right)$; for convenience, denote $\mathbf{x}^{k+1} \equiv \mathbf{x}^{1}$. Define

$$
P_{k}\left(\mathbf{x}^{1}, \mathbf{x}^{2}, \ldots, \mathbf{x}^{k}\right)=\prod_{1 \leqslant j \leqslant k} P\left(\mathbf{x}^{j}, \mathbf{x}^{j+1}\right)
$$

We are interested in the coefficient

$$
M_{k}:=\left[\prod_{j=1}^{k}\left(\mathbf{x}^{j}\right)^{\mathbf{a}+\mathbf{b}}\right] P_{k}
$$

It is easy to see that this coefficient is equal to

$$
\sum \prod_{j=1}^{k}\left[\left(\mathbf{x}^{j}\right)^{\mathbf{p}^{j}}\left(\mathbf{x}^{j+1}\right)^{\mathbf{q}^{j}}\right] R\left(\mathbf{x}^{j}, \mathbf{x}^{j+1}\right) \cdot\left[\left(\mathbf{x}^{j}\right)^{\mathbf{a}+\mathbf{b}-\mathbf{p}^{j}-\mathbf{q}^{j-1}}\right] Q\left(\mathbf{x}^{j}\right)=\operatorname{tr} \Phi^{k}
$$

where the sum is over all $\left(\mathbf{p}^{1}, \ldots, \mathbf{p}^{k}\right),\left(\mathbf{q}^{1}, \ldots, \mathbf{q}^{k}\right)$ such that

$$
\mathbf{p}^{j}=\left(p_{1}^{j}, \ldots, p_{n}^{j}\right), \mathbf{q}^{j}=\left(q_{1}^{j}, \ldots, q_{n}^{j}\right) \in \mathbb{Z}_{\geqslant 0}^{n}, \quad\left|\mathbf{p}^{j}\right|+\left|\mathbf{q}^{j}\right|=|\mathbf{b}| ;
$$

for $\alpha=\left(\alpha^{1}, \alpha^{2}\right)$ and $\beta=\left(\beta^{1}, \beta^{2}\right) ; \alpha^{i}, \beta^{i} \in \mathbb{Z}_{\geqslant 0}^{n} ;\left|\alpha^{1}\right|+\left|\alpha^{2}\right|=\left|\beta^{1}\right|+\beta^{2}|=|\mathbf{b}|$,

$$
\Phi(\alpha, \beta)=\left[(\mathbf{x})^{\alpha^{1}}(\mathbf{y})^{\alpha^{2}}\right] R(\mathbf{x}, \mathbf{y}) \cdot\left[(\mathbf{x})^{\mathbf{a}+\mathbf{b}-\alpha^{1}-\beta^{2}}\right] Q(\mathbf{x})
$$

If $Q$ is homogeneous, then $\Phi(\alpha, \beta) \neq 0$ only if $\left|\alpha^{1}\right|+\left|\beta^{2}\right|=|\mathbf{b}|$, i.e. if $\left|\alpha^{1}\right|=\left|\beta^{1}\right|,\left|\alpha^{2}\right|=\left|\beta^{2}\right|$; the same is true for $\Phi(\beta, \alpha)$.

## 3 Cartesian product of a graph and an even cycle

Let $G$ be a graph, all vertices in which have even degree. Denoting $V(G)=$ $\left\{v_{1}, \ldots, v_{n}\right\}$, we take $a_{i}=\operatorname{deg}\left(v_{i}\right) / 2, Q(\mathbf{x})=F_{G}(\mathbf{x}), R(\mathbf{x}, \mathbf{y})=\prod_{j}\left(y_{j}-x_{j}\right)$, $b_{i}=1$, and let $k$ be even.

Then $\Phi(\alpha, \beta) \neq 0$ only if $\alpha_{j}^{1}=1-\alpha_{j}^{2} \leq 1, \beta_{j}^{1}=1-\beta_{j}^{2} \leq 1$ for all $j$, $\left|\alpha^{1}\right|=\left|\beta^{1}\right|$; if this is the case, then

$$
\Phi(\alpha, \beta)=(-1)^{\left|\alpha^{1}\right|}\left[(\mathbf{x})^{\mathbf{a}+\mathbf{b}-\alpha^{1}-\left(\mathbf{b}-\beta^{1}\right)}\right] F_{G}(\mathbf{x})=(-1)^{\left|\alpha^{1}\right|}\left[(\mathbf{x})^{\mathbf{a}+\beta^{1}-\alpha^{1}}\right] F_{G}(\mathbf{x})
$$

Note that

$$
\begin{equation*}
\left[\mathbf{x}^{\mathbf{a}+\beta^{1}-\alpha^{1}}\right] F_{G}(\mathbf{x})=(-1)^{|E(G)|}\left[\mathbf{x}^{\mathbf{a}+\alpha^{1}-\beta^{1}}\right] F_{G}(\mathbf{x}) \tag{2}
\end{equation*}
$$

since simultaneously changing the choice in each linear factor $x_{i}-x_{j}$ of $F_{G}$ we get one of these monomials from the other. Thus, matrix $\Phi$ is (skew-)symmetric; therefore all eigenvalues of the matrix are real (or all are imaginary). Then the $k$-th powers of all non-zero eigenvalues are real and have the same sign. It follows that $\operatorname{tr} \Phi^{k} \neq 0$ if at least one of the coefficients of the form

$$
\left[\mathbf{x}^{\mathbf{a}+\beta^{1}-\alpha^{1}}\right] F_{G}(\mathbf{x})
$$

is non-zero; in other words, if there is at least one non-zero coefficient $\left[\mathbf{x}^{\xi}\right] F_{G}(\mathbf{x})$ with $\left|\xi_{i}-\operatorname{deg}\left(v_{i}\right) / 2\right| \leqslant 1$ for all $i$. Theorem 3 is proved.
Remark 1. Define a generalized graph polynomial $Q$ for a graph or multigraph $G=(V, E)$ with even degrees, $V=\left\{v_{1}, \ldots, v_{n}\right\}$, as a product of factors $x_{i} \pm x_{j}$ for all edges $v_{i} v_{j} \in E$ (one multiple for each edge). Note that it satisfies the symmetry or antisymmetry property (2), with some multiple $\pm 1$ on the place of $(-1)^{|E(G)|}$. Therefore the same argument shows that if $Q$ has a non-zero almost central coefficient, then the polynomial

$$
\begin{equation*}
\prod_{i=1}^{2 k} Q\left(\mathbf{x}^{i}, \mathbf{x}^{i+1}\right) \prod_{i=1}^{2 k} \prod_{j=1}^{n}\left(x_{j}^{i}-x_{j}^{i+1}\right), \text { where } \mathbf{x}^{2 k+1} \equiv \mathbf{x}^{1} \tag{3}
\end{equation*}
$$

has a non-zero central coefficient (that is, a coefficient of $\left.\prod_{i, j}\left(x_{j}^{i}\right)^{\operatorname{deg}\left(v_{j}\right) / 2+1}\right)$.

## 4 Applications

### 4.1 Cartesian product of several cycles

Consider a Cartesian product of odd cycles $G=C_{2 k_{1}+1} \square \ldots \square C_{2 k_{n}+1}$, such that

$$
\frac{1}{k_{1}}+\cdots+\frac{1}{k_{n}} \leqslant 1 .
$$

Our goal is to show that the graph polynomial $F_{G}$ has a non-zero almost central coefficient. We employ the Alon-Tarsi method:

Theorem 4 (see Corollary 1.2, Corollary 2.3 in [2]). Let $G$ be a non-directed graph on vertices $v_{1}, \ldots, v_{n}$. Suppose $G$ has an orientation $D$ with outdegrees $d_{\text {out }}\left(v_{i}\right)=d_{i}$, and there are no odd directed cycles in $D$. Then the coefficient $\left[\mathbf{x}^{\mathbf{d}}\right] F_{G}\left(\right.$ where $\left.\mathbf{d}=\left(d_{1}, \ldots, d_{n}\right)\right)$ is non-zero.

We are going to build an orientation of $G$, such that the outdegree of any vertex lies in $\{n-1, n, n+1\}$, and there are no odd directed cycles. We are going to denote vertices of $G$ by $v=\left(v_{1}, \ldots, v_{n}\right), 0 \leqslant v_{i} \leqslant 2 k_{i}$.

We divide $G$ into $2^{n}$ boxes $H_{i}, 0 \leqslant i<2^{n}$ : if the binary notation of $i$ is $\overline{b_{i, 1} \ldots b_{i, n}}$, then

$$
H_{i}=\left\{\left(v_{1}, \ldots, v_{n}\right) \mid 0 \leqslant v_{j} \leqslant k, \text { if } b_{i, j}=0 ; k<v_{j} \leqslant 2 k \text { otherwise }\right\}
$$

These boxes may be colored alternately white and black (in a chess order). We direct all edges sticking out of black boxes outward, and from white boxes inward. Note that any directed cycle is contained is some box $H_{i}$ and has therefore even length.

The remaining task is to obtain the orientation of the box of dimension $n$ with outdegree of any vertex lying in $\{n-1, n\}$. We will use this orientation for all white boxes $H_{i}$ 's, for the black boxes use the reversed orientation. This guarantees that in white boxes all outdegrees are in $\{n-1, n\}$; in black boxes the indegrees are in $\{n-1, n\}$, therefore the outdegrees are in $\{n, n+1\}$.

To prove the existence of such orientation we are going to use the following theorem (see, for example, Theorem 3 in [4]):

Theorem 5. There exists an orientation of $G=(V, E)$ with $l_{v} \leqslant d_{o u t}(v) \leqslant u_{v}$ for any $v$, if and only if for any $W \subset V$ the following two conditions hold:

1. $|E(W)| \leqslant \sum_{v \in W} u_{v}$;
2. $|\bar{E}(W)| \geqslant \sum_{v \in W} l_{v}$,
where $\bar{E}(W)=E(V) \backslash E(V \backslash W)$ is the set of edges incident to at least one vertex of $W$.

Proposition 6. Let $H=P_{k_{1}} \square \ldots \square P_{k_{n}}$ ( $P_{i}$ is a path of length $i$ ). There exists an orientation of $H$ with outdegrees of all vertices lying in $\{n-1, n\}$ if and only if

$$
\begin{equation*}
\frac{1}{k_{1}}+\cdots+\frac{1}{k_{n}} \leqslant 1 \tag{4}
\end{equation*}
$$

Proof. First of all, note that the condition (4) is necessary: the sum of outdegrees of all vertices does not exceed the number of edges in a graph, so

$$
\begin{equation*}
(n-1) \prod_{i=1}^{n} k_{i} \leqslant \sum_{i=1}^{n}\left(k_{i}-1\right) \prod_{\substack{1 \leqslant j \leqslant n \\ j \neq i}} k_{i}=\prod_{i=1}^{n} k_{i} \cdot \sum_{i=1}^{n}\left(1-\frac{1}{k_{i}}\right), \tag{5}
\end{equation*}
$$

which is equivalent to (4). To show that the condition (4) is sufficient, we are going to verify two conditions from Theorem 5 with $l(v)=n-1, u(v)=n$ for each $v$. The first condition holds:

$$
|E(W)| \leqslant \frac{1}{2} \sum_{v \in W} d(v) \leqslant n|W|
$$

The second condition looks like

$$
|E(V)|-|E(V \backslash W)| \geqslant(n-1)|W|
$$

Denoting $U=V \backslash W$, it is equivalent to

$$
|E(U)|-(n-1)|U| \leqslant|E(V)|-(n-1)|V|
$$

for each $U \subset V$. Thus, to prove that the second condition holds, it is sufficient to show that the function

$$
f(U)=|E(U)|-(n-1)|U|
$$

reaches its maximum value at $U=V$.
For $1 \leqslant i \leqslant n, p=\left(p_{1}, \ldots, p_{i-1}, p_{i+1}, \ldots, p_{n}\right), 1 \leqslant p_{j} \leqslant k_{j}$, denote

$$
U(i, p)=\left\{v \in U \mid v_{j}=p_{j} \text { for any } j \neq i\right\}
$$

Then

$$
|E(U)| \leqslant n|U|-\sum_{i, p} \chi(|U(i, p)|>0)
$$

Denote $l=1-\sum_{i=1}^{n} \frac{1}{k_{i}} \geqslant 0$; then

$$
|U|=\left(\sum_{i=1}^{n} \frac{1}{k_{i}}+l\right)|U|=l|U|+\sum_{i, p} \frac{|U(i, p)|}{k_{i}} .
$$

It follows that

$$
f(U) \leqslant l|U|+\sum_{i, p} g(U, i, p)
$$

where

$$
g(U, i, p)= \begin{cases}0, & \text { if }|U(i, p)|=0 \\ \frac{|U(i, p)|}{k_{i}}-1, & \text { otherwise }\end{cases}
$$

In conclusion, note that

$$
f(U) \leqslant l|U|+\sum_{i, p} g(U, i, p) \leqslant l|U| \leqslant l|V|=f(V) .
$$

Corollary 7. Let $G=C_{2 k_{1}+1} \square \ldots \square C_{2 k_{m}+1} \square C_{2 k_{m+1}} \square \ldots \square C_{2 k_{n}}, 0 \leqslant m<n$, and, additionally,

$$
\frac{1}{k_{1}}+\cdots+\frac{1}{k_{m}} \leqslant 1
$$

Then

$$
\operatorname{ch}(G) \leqslant \operatorname{AT}(G)=n+1
$$

Proof. The upper bound follows from the construction described above; the lower bound is obvious: in each monomial of the graph polynomial $F_{G}$ there is a variable of degree at least $n$.

Note that even though the result is sharp for the Alon-Tarsi number, it is far from sharp for the list chromatic number when $n$ is large enough. For example, if $k_{i} \geqslant 2$ for all $i=1, \ldots, m$ (it is so for sure if $m \geqslant 2$ and $\sum 1 / k_{i} \leqslant 1$ ), then graph $G$ is triangle free and has maximum degree $2 n$, which yields $\operatorname{ch}(G) \leqslant$ $(2+o(1)) \frac{n}{\log n}$ by a result of Molloy [7], a recent improvement of the $O\left(\frac{n}{\log n}\right)$ bound first given by Johansson [5].

### 4.2 Powers of cycles

Proposition 8. Let $C_{n}^{p}$ be $p$-th power of a cycle $C_{n}$, i.e. a graph on the vertex set $\left\{v_{1}, \ldots, v_{n}\right\}$, in which $v_{i}$ and $v_{j}$ are adjacent if and only if $j \in\{i-p, \ldots, i-$ $1, i+1, \ldots i+p\}$ (the indices are modulo $n$ ). Suppose $p+1$ divides $n$ or $n \geqslant$ $p(p+1)$. Then

$$
\operatorname{ch}\left(C_{n}^{p} \square C_{2 k}\right) \leqslant \operatorname{AT}\left(C_{n}^{p} \square C_{2 k}\right) \leqslant p+2 .
$$

Proof. In [8] the Alon-Tarsi number AT for powers of cycles is estimated. If $p+1$ divides $n$, it is shown that the central coefficient of $F_{C_{n}^{p}}$ is non-zero; if $p+1$ does not divide $n$, but $n \geqslant p(p+1)$, then it is shown that for a graph $H_{n}^{p}$, obtained by adding some matching to the graph $C_{n}^{p}$, there is a non-zero coefficient of $F_{H_{n}^{p}}$ with degree of each variable in $\{p, p+1\}$. This coefficient is a linear combination of almost central coefficients of $F_{C_{n}^{p}}$, so at least one of them is also non-zero.

### 4.3 Multigraphs

Note that Theorem 3 can be applied to multigraphs. In particular, non-trivial bounds can be obtained for graphs with large choice number by adding multiple edges to them. To give an example, we prove the following proposition:

Proposition 9. Let $G$ be a graph, all vertices of maximum degree in which may be covered by some vertex-disjoint cycles. Then

$$
\operatorname{AT}\left(G \square C_{2 k}\right) \leqslant \Delta(G)+1=\Delta\left(G \square C_{2 k}\right)-1 .
$$

Proof. Denote the set of edges contained in these cycles as $F$. Consider a graph $G^{\prime}$, which can be obtained from $G$ by adding a multiple edge to every edge from
the set $E(G) \backslash F$. Obviously, $\operatorname{AT}\left(G \square C_{2 k}\right) \leqslant \operatorname{AT}\left(G^{\prime} \square C_{2 k}\right)$. If we show that $F_{G^{\prime}}$ has a non-zero almost central coefficient, then

$$
\operatorname{AT}\left(G^{\prime} \square C_{2 k}\right) \leqslant \frac{\Delta\left(G^{\prime}\right)}{2}+2=\Delta(G)+1
$$

Consider another graph $G^{\prime \prime}$, which can be obtained from $G$ by adding a multiple edge to every edge. Note that the central coefficient of $F_{G^{\prime \prime}}=F_{G}^{2}$ is non-zero: the central coefficient of $F_{G}$ " is the sum of products of "opposite" coefficients of $F_{G}$, each summand in this sum has the same sign (which depends on the parity of the number of edges in $G$, cf. (2)). But the central coefficient of $F_{G^{\prime \prime}}$ is a linear combination of almost central coefficients of $F_{G^{\prime}}$; it follows that at least one of them is also non-zero.

## Corollary 10.

$$
\operatorname{AT}\left(K_{n} \square C_{2 k}\right)=\operatorname{ch}\left(K_{n} \square C_{2 k}\right)=n
$$

Proof. We have

$$
n \geqslant \operatorname{AT}\left(K_{n} \square C_{2 k}\right) \geqslant \operatorname{ch}\left(K_{n} \square C_{2 k}\right) \geqslant \operatorname{ch}\left(K_{n}\right) \geqslant n
$$

where the first inequality follows from Proposition 9, the second from (1), the third and fourth are clear. So all inequalities turn into equalities.

Next proposition is a generalization of Theorem 3 for arbitrary graphs (not necessarily with even degrees, not necessarily with a non-zero almost central coefficient.) Roughly speaking, it bounds the choosability in dependence on how not-so-far-from-central coefficient does the graph polynomial have. It also gives Corollary 10 (we skip the details).

Proposition 11. Let $G=(V, E)$ be a graph; denote $V=\left\{v_{1}, \ldots, v_{n}\right\}$. For any $\eta=\left(\eta_{1}, \ldots, \eta_{n}\right)$ denote $l_{G}(\eta, i)=\left|\eta_{i}-\operatorname{deg}_{G}\left(v_{i}\right) / 2\right|$. Consider a non-zero coefficient $\left[\mathbf{x}^{\tau}\right] F_{G}(\mathbf{x})$ of the graph polynomial $F_{G}$. Partition the set $\{1, \ldots, n\}$ onto sets

$$
\begin{aligned}
N & =\left\{i: \tau_{i}=\operatorname{deg}_{G}\left(v_{i}\right) / 2\right\}, \\
A_{1} & =\left\{i: \tau_{i} \leqslant \operatorname{deg}_{G}\left(v_{i}\right) / 2-1\right\}, \\
A_{2} & =\left\{i: \tau_{i}=\operatorname{deg}_{G}\left(v_{i}\right) / 2-1 / 2\right\}, \\
B_{1} & =\left\{i: \tau_{i} \geqslant \operatorname{deg}_{G}\left(v_{i}\right) / 2+1\right\}, \\
B_{2} & =\left\{i: \tau_{i}=\operatorname{deg}_{G}\left(v_{i}\right) / 2+1 / 2\right\} .
\end{aligned}
$$

Additionally, let $A_{3}$ be an arbitrary subset of $A_{1}$ of size $\max \left(0,\left|A_{1}\right|-\left|B_{1}\right|\right)$; let $B_{3}$ be an arbitrary subset of $B_{1}$ of size $\max \left(0,\left|B_{1}\right|-\left|A_{1}\right|\right)$. Then $G \square C_{2 k}$ is $f$-choosable, where

$$
f\left(v_{i}\right)= \begin{cases}\operatorname{deg}_{G}\left(v_{i}\right) / 2+2, & \text { if } i \in N \\ \operatorname{deg}_{G}\left(v_{i}\right) / 2+l_{G}(\tau, i)+1, & \text { if } i \in A_{1} \cup B_{1} \backslash A_{3} \backslash B_{3} \\ \operatorname{deg}_{G}\left(v_{i}\right) / 2+l_{G}(\tau, i)+2, & \text { if } i \in A_{2} \cup B_{2} \cup A_{3} \cup B_{3}\end{cases}
$$

Proof. Define a multiset $A$ as follows:

- each $i \in A_{1} \backslash A_{3}$ occurs $2\left(l_{G}(\tau, i)-1\right)$ times in $A$;
- each $i \in A_{2} \cup A_{3}$ occurs $2 l_{G}(\tau, i)$ times in $A$.

Multiset $B$ is defined similarly. Note that

$$
|A|=\sum_{i \in A_{1} \cup A_{2}} 2 l_{G}(\tau, i)-2 \min \left(\left|A_{1}\right|,\left|B_{1}\right|\right)
$$

Similarly,

$$
|B|=\sum_{i \in B_{1} \cup B_{2}} 2 l_{G}(\tau, i)-2 \min \left(\left|A_{1}\right|,\left|B_{1}\right|\right)
$$

It follows that $|A|=|B|=: m$. Let $A=\left\{a_{1}, \ldots, a_{m}\right\}, B=\left\{b_{1}, \ldots, b_{m}\right\}$.
Consider $2^{m}$ polynomials

$$
Q_{\varepsilon}(\mathbf{x})=F_{G}(\mathbf{x}) \cdot \prod_{j=1}^{m}\left(x_{a_{j}} \pm x_{b_{j}}\right)
$$

indexed by the choice $\varepsilon$ of $m$ signs. Using the relation $x_{a_{j}}=\frac{1}{2}\left(\left(x_{a_{j}}+x_{b_{j}}\right)+\right.$ $\left.\left(x_{a_{j}}-x_{b_{j}}\right)\right)$ we see that the polynomial $Q:=F_{G}(\mathbf{x}) \cdot \prod x_{a_{i}}$ is a linear combination of $Q_{\varepsilon}$ 's. Note that

$$
\left[\mathbf{x}^{\tau} \cdot \prod x_{a_{i}}\right] Q=\left[\mathbf{x}^{\tau}\right] F_{G} \neq 0
$$

therefore there exists $\varepsilon$ such that

$$
\left[\mathbf{x}^{\tau} \cdot \prod x_{a_{i}}\right] Q_{\varepsilon} \neq 0
$$

Note that $Q_{\varepsilon}$ is a generalized graph polynomial of a certain multigraph on the ground set $V$ with degree function $2 f\left(v_{i}\right)-4$. The coefficient of $\mathbf{x}^{\tau} \cdot \prod x_{a_{i}}$ is almost central for $Q_{\varepsilon}$.

Now it follows from the Remark 1 that the polynomial (3) (for $Q=Q_{\varepsilon}$ ) has a non-zero central coefficient.

Finally, since the graph polynomial $F_{G \square C_{2 k}}$ divides this polynomial, graph $G \square C_{2 k}$ is $f$-choosable.
