# AS-REGULAR ALGEBRAS FROM ACYCLIC SPHERICAL HELICES 

SHINNOSUKE OKAWA AND KAZUSHI UEDA


#### Abstract

We discuss a construction of AS-regular algebras from acyclic spherical helices, generalizing works of Bondal and Polishchuk BP93 and Van den Bergh VdB11.


Let $\mathcal{C}$ be an idempotent-complete pretriangulated dg category over a field k. See e.g. [Kel06] and references therein for basic definitions on dg categories. For $X, Y \in \mathfrak{O b}(\mathcal{C})$, we write the dg vector space of morphisms in $\mathcal{C}$ and its $i$-th cohomology as $\operatorname{hom}(X, Y)$ and $\operatorname{Hom}^{i}(X, Y)$ respectively.

A $\mathcal{C}$-module is a dg functor $\mathcal{C}^{\text {op }} \rightarrow \operatorname{Mod} \mathbf{k}$ to the dg category of dg vector spaces. A dg functor $F: \mathcal{C} \rightarrow \mathcal{C}^{\prime}$ will be identified with its graph bimodule $\Gamma_{F} \in \operatorname{Mod}\left(\mathcal{C}^{\mathrm{op}} \otimes \mathcal{C}^{\prime}\right)$.

Assume that $\mathcal{C}$ is proper in the sense that $\operatorname{hom}(X, Y) \in \operatorname{per} \mathbf{k}$ for any $X, Y \in \mathfrak{O b}(\mathcal{C})$. Assume further that $\mathcal{C}$ has a Serre functor $\mathbb{S}$ in the sense of [BK89]. The graph of the Serre functor is given by

\operatorname{hom}(Y, \mathbb{S}(X))=\operatorname{hom}(X, Y)^{*} \tag{1}
\end{equation*}
$$

where $(-)^{*}:=\operatorname{hom}_{\mathbf{k}}(-, \mathbf{k}):(\operatorname{Mod} \mathbf{k})^{\mathrm{op}} \rightarrow \operatorname{Mod} \mathbf{k}$.
A prototypical example of an idempotent-complete proper pretriangulated dg category admitting a Serre functor is the category of perfect complexes on a proper Gorenstein scheme $X$. The Serre functor is the tensor product with the canonical bundle followed by the shift by the dimension of $X$; $\mathbb{S}(-)=(-) \otimes \omega_{X}[\operatorname{dim} X]$.

Let $d$ be a natural number. An object $S$ of $\mathcal{C}$ is said to be spherical of dimension $d$ if $\mathbb{S}(S) \simeq S[d]$ and

$$
\operatorname{Hom}^{i}(S, S) \cong \begin{cases}\mathbf{k} & i=0, d  \tag{2}\\ 0 & \text { otherwise }\end{cases}
$$

The spherical twist along $S$ is the functorial cone $T_{S}$ over the evaluation morphism ev: hom $(S,-) \otimes$ $S \rightarrow \mathrm{id}_{\mathcal{C}}$. It is an autoequivalence of the dg category per $\mathcal{C}$ of perfect $\mathcal{C}$-modules, whose inverse is given by the dual twist $T_{S}^{\vee}$ defined as the cone over the coevaluation morphism coev: $\mathrm{id}_{\mathcal{C}} \rightarrow \mathrm{hom}(-, S)^{\vee} \otimes S$ shifted by -1 [ST01].

Given a sequence $\mathbf{S}=\left(S_{i}\right)_{i=1}^{\ell}$ of spherical objects, let $\mathcal{B}=\mathcal{B}_{\mathbf{S}}$ be the full subcategory of $\mathcal{C}$ consisting of $\left\{S_{i}\right\}_{i=1}^{\ell}$. We identify per $\mathcal{B}$ with the full idempotent-complete pretriangulated subcategory of $\mathcal{C}$ generated by $\mathcal{B}$.
Definition 1. A sequence $\mathbf{S}=\left(S_{i}\right)_{i=1}^{\ell}$ of spherical objects is a spherical collection if the Serre functor of $\mathcal{C}$ preserves per $\mathcal{B}$ and acts as the shift functor there; $\left.\mathbb{S}_{\mathcal{C}}\right|_{\text {per } \mathcal{B}} \simeq[d]$.

The number $\ell$ of objects in the collection is called the length of the collection.
The directed subcategory $\mathcal{A}=\mathcal{A}_{\mathbf{S}}$ of $\mathcal{B}$ is the dg category whose set of objects is $\left\{E_{i}\right\}_{i=1}^{\ell}$ and whose dg vector spaces of morphisms are given by

$$
\operatorname{hom}_{\mathcal{A}}\left(E_{i}, E_{j}\right):= \begin{cases}\operatorname{hom}_{\mathcal{B}}\left(S_{i}, S_{j}\right) & i<j,  \tag{3}\\ \mathbf{k} \cdot \operatorname{id}_{E_{i}} & i=j, \\ 0 & i>j\end{cases}
$$

The differentials and the compositions of morphisms in $\mathcal{A}$ are inherited from that of $\mathcal{B}$ in the obvious way.

Since the collection S is spherical, the $\mathcal{A}$-bimodule $\mathcal{B} / \mathcal{A}$, defined as the cone of the natural morphism $\mathcal{A} \rightarrow \mathcal{B}$ of $\mathcal{A}$-bimodules, is isomorphic to the shift $\mathcal{A}^{*}[-d]$ of the graph $\mathcal{A}^{*}:=\operatorname{hom}_{\mathbf{k}}(\mathcal{A}, \mathbf{k})$ of the Serre functor. In other words, the category $\mathcal{B}$ is a noncommutative anticanonical divisor of $\mathcal{A}$ in the sense of Sei17.

The sequence $\left(E_{i}\right)_{i=1}^{\ell}$ is a full exceptional collection of per $\mathcal{A}$. The existence of a full exceptional collection implies that per $\mathcal{A}$ is proper and smooth (in the sense that the diagonal bimodule is perfect), so that $\operatorname{per} \mathcal{A}$ has a Serre functor.

Let $\iota_{*}: \operatorname{per} \mathcal{B} \rightarrow \operatorname{per} \mathcal{A}$ be the dg functor sending a $\mathcal{B}$-module to the same module considered as an $\mathcal{A}$-module by the embedding $\mathcal{A} \hookrightarrow \mathcal{B}$. The graph of the left adjoint functor $\iota^{*}$ : per $\mathcal{A} \rightarrow \operatorname{per} \mathcal{B}$ is $\mathcal{B}$ considered as an $\mathcal{A}^{\mathrm{op}} \otimes \mathcal{B}$-module. The right adjoint functor is given by $\iota^{!}=\mathbb{S}_{\mathcal{B}} \circ \iota^{*} \circ \mathbb{S}_{\mathcal{A}}^{-1} \simeq \iota^{*} \circ \mathbb{S}_{\mathcal{A}}^{-1}[d]$.

The dual twist $T_{\iota_{*}}^{\vee}$ along $\iota_{*}$ is defined as the shift by -1 of the cone over the unit id $\mathcal{A}_{\mathcal{A}} \rightarrow \iota_{*} \circ \iota^{*}$ of the adjunction. The graph of the functor $\iota_{*} \circ \iota^{*}$ is $\mathcal{B}$ considered as an $\mathcal{A}$-bimodule, so that the graph of the dual twist is the $\mathcal{A}$-bimodule $\mathcal{B} / \mathcal{A}[-1]$, which is the graph of $\mathbb{S}[-d-1]$. The twist $T_{\iota_{*}}$ along $\iota_{*}$, defined as the cone over the counit $\iota_{*} \circ \iota^{!} \rightarrow \operatorname{id}_{\mathcal{A}}$ of the adjunction, is right adjoint to $T_{\iota_{*}}^{\vee}$ by AL17, Proposition 5.3], and hence is quasi-isomorphic to $\mathbb{S}^{-1}[d+1]$.

The dual cotwist $C_{\iota *}^{\vee}$ along $\iota_{*}$, defined as the cone over the counit $\iota^{*} \circ \iota_{*} \rightarrow \operatorname{id}_{\mathcal{B}}$, is described explicitly as the (iterated) cone of

\begin{align*}
& \operatorname{hom}\left(S_{\ell},-\right) \otimes \operatorname{hom}\left(S_{\ell-1}, S_{\ell}\right) \otimes \cdots \otimes \operatorname{hom}\left(S_{1}, S_{2}\right) \otimes S_{1} \rightarrow \cdots  \tag{4}\\
& \quad \rightarrow \bigoplus_{1 \leq i_{1}<i_{2} \leq \ell} \operatorname{hom}\left(S_{i_{2}},-\right) \otimes \operatorname{hom}\left(S_{i_{1}}, S_{i_{2}}\right) \otimes S_{i_{1}} \rightarrow \bigoplus_{i=1}^{\ell} \operatorname{hom}\left(S_{i},-\right) \otimes S_{i} \rightarrow \operatorname{id}_{\mathcal{B}},
\end{align*}
$$

which is quasi-isomorphic to the composition of spherical twists;

$$
\begin{equation*}
C_{\iota_{*}}^{\vee} \simeq T_{S_{1}} \circ T_{S_{2}} \circ \cdots \circ T_{S_{\ell}} \tag{5}
\end{equation*}
$$

Since both $T_{\iota_{*}}$ and $C_{\iota_{*}}^{\vee}$ are equivalences, the functor $\iota_{*}$ is spherical in the sense of AL17, Theorem 1.1]. We expect that $\iota_{*}$ has a relative Calabi-Yau structure in the sense of [BD19, which is a slight strengthening of an identification of the spherical twist with a shift of the inverse Serre functor.

For $1 \leq i \leq \ell-1$, the right mutation of a spherical collection $\mathbf{S}=\left(S_{j}\right)_{j=1}^{\ell}$ at position $i$ is defined by

R_{i}(\mathbf{S}):=\left(S_{1}, \ldots, S_{i-1}, S_{i+1}, T_{S_{i+1}}^{\vee} S_{i}, S_{i+2}, \ldots, S_{\ell}\right) \tag{6}
\end{equation*}
$$

The inverse operation is the left mutation defined by

$$
\begin{equation*}
L_{i}(\mathbf{S}):=\left(S_{1}, \ldots, S_{i-1}, T_{S_{i}} S_{i+1}, S_{i}, S_{i+2}, \ldots, S_{\ell}\right) \tag{7}
\end{equation*}
$$

The left mutation $L_{i}(\mathcal{A})$ of $\mathcal{A}$ at position $i$ is the full subcategory of per $\mathcal{A}$ consisting of $E_{j}$ for $j \neq i+1$ and

$$
\begin{equation*}
L_{E_{i}} E_{i+1}:=\operatorname{Cone}\left(\operatorname{hom}\left(E_{i}, E_{i+1}\right) \otimes E_{i} \xrightarrow{\mathrm{ev}} E_{i+1}\right) . \tag{8}
\end{equation*}
$$

The passage to the directed subcategory commutes with mutations; $\mathcal{A}_{L_{i}(\mathbf{S})} \simeq L_{i}\left(\mathcal{A}_{\mathbf{S}}\right)$.
The helix generated by an exceptional collection $\left(E_{i}\right)_{i=1}^{\ell}$ is the sequence $\left(E_{i}\right)_{i \in \mathbb{Z}}$ of exceptional objects of per $\mathcal{A}$ satisfying

$$
\begin{equation*}
E_{i-\ell}=L_{E_{i-\ell+1}} \circ L_{E_{i-\ell+2}} \circ \cdots \circ L_{E_{i-1}}\left(E_{i}\right)[-d-1] \tag{9}
\end{equation*}
$$

for any $i \in \mathbb{Z}$. The shift is chosen in such a way that $E_{i-\ell} \cong \mathbb{S}\left(E_{i}\right)[-d-1]$, so that if per $\mathcal{A} \simeq D^{b} \operatorname{coh} X$ for a smooth projective variety $X$ of dimension $d+1$, then one has $E_{i-\ell} \cong E_{i} \otimes \omega_{X}$. The length $\ell$ of the exceptional collection generating the helix is called the period of the helix. For any $i \in \mathbb{Z}$, the exceptional collection $\left(E_{j}\right)_{j=i}^{i+\ell-1}$ consisting of $\ell$ consecutive objects in the helix is called a foundation of the helix. We say that a helix $\left(E_{i}\right)_{i \in \mathbb{Z}}$ is acyclic if $\operatorname{Hom}^{\neq 0}\left(E_{i}, E_{j}\right)=0$ for any $-\infty<i<j<\infty$.

Given an invertible $\mathcal{A}$-bimodule $\theta$, the tensor algebra over $\mathcal{A}$ is defined by

$$
\begin{align*}
T_{\mathcal{A}}(\theta) & :=\bigoplus_{i=0}^{\infty} \theta^{\otimes_{\mathcal{A}} i}  \tag{10}\\
& =\mathcal{A} \oplus \theta \oplus\left(\theta \otimes_{\mathcal{A}} \theta\right) \oplus \cdots  \tag{11}\\
& \simeq \bigoplus_{i=0}^{\infty} \bigoplus_{j, k=1}^{\ell} \operatorname{hom}\left(E_{j}, \theta^{i}\left(E_{k}\right)\right) \tag{12}
\end{align*}
$$

In addition to the cohomological grading coming from that of $\mathcal{A}$ and $\theta$, the tensor algebra $T_{\mathcal{A}}(\theta)$ has an additional grading such that $\theta^{\otimes_{\mathcal{A}} i}$ has degree $i$. The positively graded part $T_{\mathcal{A}}(\theta)^{+}:=\bigoplus_{i=1}^{\infty} \theta^{\otimes_{\mathcal{A}} i} \simeq$ $\theta \otimes_{\mathcal{A}} T_{\mathcal{A}}(\theta)$ is the kernel (the cone shifted by -1 ) of the natural morphism $\sigma^{\sharp}: T_{\mathcal{A}}(\theta) \rightarrow \mathcal{A}$.

The category $\operatorname{per} T_{\mathcal{A}}(\theta)$ is a generalization of the derived category of coherent sheaves on the total space of a line bundle, and the pull-back $\sigma_{*}: \operatorname{per} \mathcal{A} \rightarrow \operatorname{per} T_{\mathcal{A}}(\theta)$ along $\sigma^{\sharp}$ is a generalization of the push-forward along the zero section. Its left adjoint $\sigma^{*}: \operatorname{per} T_{\mathcal{A}}(\theta) \rightarrow \operatorname{per} \mathcal{A}$ is given by tensoring $\mathcal{A}$ over $T_{\mathcal{A}}(\theta)$. Since the graph of $\sigma^{*} \circ \sigma_{*}$ is

$$
\begin{equation*}
\operatorname{Cone}\left(\theta \otimes_{\mathcal{A}} T_{\mathcal{A}}(\theta) \rightarrow T_{\mathcal{A}}(\theta)\right) \otimes_{T_{\mathcal{A}}(\theta)} \mathcal{A} \simeq \operatorname{Cone}(\theta \rightarrow \mathcal{A}) \tag{13}
\end{equation*}
$$

the dual cotwist along $\sigma_{*}$ is the autoequivalence $\theta[1]$ of $\operatorname{per} \mathcal{A}$. See also $\operatorname{Seg} 18$ for a related construction.

The push-forward $\pi^{*}:=(-) \otimes_{\mathcal{A}} T_{\mathcal{A}}(\theta): \operatorname{per} \mathcal{A} \rightarrow \operatorname{per} T_{\mathcal{A}}(\theta)$ along the structure morphism $\pi^{\sharp}: \mathcal{A} \rightarrow$ $T_{\mathcal{A}}(\theta)$ of the tensor algebra is a generalization of the pull-back along the projection to the base space. For any pair $(E, F)$ of objects of per $\mathcal{A}$, one has

$$
\begin{align*}
\operatorname{hom}\left(\sigma_{*} E, \pi^{*} F\right) & \simeq \operatorname{hom}\left(\pi^{*} E \otimes_{T_{\mathcal{A}}(\theta)} \operatorname{Cone}\left(\theta \otimes_{\mathcal{A}} T_{\mathcal{A}}(\theta) \rightarrow T_{\mathcal{A}}(\theta)\right), \pi^{*} F\right)  \tag{14}\\
& \simeq \operatorname{hom}\left(\pi^{*} E, \pi^{*} F \otimes_{T_{\mathcal{A}}(\theta)} \operatorname{Cone}\left(T_{\mathcal{A}}(\theta) \rightarrow \theta^{-1} \otimes_{\mathcal{A}} T_{\mathcal{A}}(\theta)\right)[-1]\right)  \tag{15}\\
& \simeq \operatorname{hom}\left(\pi^{*} E, \sigma_{*}\left(\theta^{-1}(F)\right)\right)[-1]  \tag{16}\\
& \simeq \operatorname{hom}\left(E, \theta^{-1}(F)\right)[-1] . \tag{17}
\end{align*}
$$

The dg category $\operatorname{gr} T_{\mathcal{A}}(\theta)$ of graded perfect $T_{\mathcal{A}}(\theta)$-modules is a generalization of the derived category of equivariant coherent sheaves on the total space of a line bundle with respect to the $\mathbb{G}_{m}$-action by fiberwise dilation. The dg $\mathbb{Z}$-algebra $A=\bigoplus_{i, j=-\infty}^{\infty} A_{i j}$ defined by

$$
\begin{equation*}
A_{i+k \ell, j+m \ell}=\operatorname{hom}\left(\theta^{m}\left(E_{j}\right), \theta^{k}\left(E_{i}\right)\right) \tag{18}
\end{equation*}
$$

for $1 \leq i, j \leq \ell$ and $-\infty<m \leq k<\infty$ is $\ell$-periodic, and the 1-periodic dg $\mathbb{Z}$-algebra $A^{\prime}=$ $\bigoplus_{i, j=-\infty}^{\infty} A_{i j}^{\prime}$ defined by

$$
\begin{equation*}
A_{k m}^{\prime}=\bigoplus_{i=(k-1) \ell+1}^{k \ell} \bigoplus_{j=(m-1) \ell+1}^{m \ell} A_{i j} \tag{19}
\end{equation*}
$$

is the dg $\mathbb{Z}$-algebra associated to the $\mathbb{Z}$-graded algebra $T_{\mathcal{A}}(\theta)$. One has quasi-equivalences

$$
\begin{equation*}
\operatorname{gr} T_{\mathcal{A}}(\theta) \simeq \bmod A^{\prime} \simeq \bmod A \tag{20}
\end{equation*}
$$

of dg categories.
Let $\left(F_{i}\right)_{i=\ell}^{1}$ be the exceptional collection in per $\mathcal{A}$ right dual to $\left(E_{i}\right)_{i=1}^{\ell}$ so that $\operatorname{hom}\left(E_{i}, F_{j}\right) \simeq \mathbf{k}$ if $i=j$ and 0 otherwise [Bon89, Section 7]. Then $E_{i}$ (resp. $F_{i}$ ) represents the $i$-th projective (resp. simple) $\mathcal{A}$-module, and $\pi^{*} E_{i}$ (resp. $\sigma_{*} F_{i}$ ) represents the $i$-th projective (resp. simple) $T_{\mathcal{A}}(\theta)$-module.

The dg algebra $T_{\mathcal{A}}(\theta)$ in the case $\theta=\mathbb{S}^{-1}[d+1]$ is known as the derived $(d+1)$-preprojective algebra, which is a model of the trivial Calabi-Yau completion Kel11;

\begin{equation*}
\Pi_{d+1}(\mathcal{A}):=T_{\mathcal{A}}\left(\mathbb{S}^{-1}[d+1]\right) . \tag{21}
\end{equation*}
$$

It is given explicitly as

$$
\begin{equation*}
\bigoplus_{i=0}^{\infty} \bigoplus_{j, k=1}^{\ell} \operatorname{hom}\left(E_{j}, \mathbb{S}^{-i}\left(E_{k}\right)[i(d+1)]\right) \simeq \bigoplus_{j=1}^{\ell} \bigoplus_{k=1}^{\infty} \operatorname{hom}\left(E_{j}, E_{k}\right) \tag{22}
\end{equation*}
$$

and also known as the rolled-up helix dg algebra. The dg $\mathbb{Z}$-algebra $A$ in this case will be called the helix dg algebra.

For $1 \leq i, j \leq \ell$, one has

$$
\begin{align*}
\operatorname{hom}\left(\sigma_{*} F_{i}, \pi^{*} E_{j}\right) & \simeq \operatorname{hom}\left(F_{i}, \mathbb{S}\left(E_{j}\right)[-d-1]\right)[-1]  \tag{23}\\
& \simeq \operatorname{hom}\left(E_{j}, F_{i}\right)[-d-2]  \tag{24}\\
& \simeq \begin{cases}\mathbf{k}[-d-2] & i=j, \\
0 & \text { otherwise }\end{cases} \tag{25}
\end{align*}
$$

An object of $\operatorname{gr} T_{\mathcal{A}}(\theta)$ is said to be a torsion if the grading is bounded. Let tor $T_{\mathcal{A}}(\theta)$ be the full subcategory of $\operatorname{gr} T_{\mathcal{A}}(\theta)$ consisting of torsion modules, and $\operatorname{qgr} T_{\mathcal{A}}(\theta):=\operatorname{gr} T_{\mathcal{A}}(\theta) / \operatorname{tor} T_{\mathcal{A}}(\theta)$ be the dg quotient.
Proposition 2. One has an equivalence $\operatorname{qgr} T_{\mathcal{A}}(\theta) \simeq \operatorname{per} \mathcal{A}$.
Proof. One has a semiorthogonal decomposition

$$
\begin{equation*}
\operatorname{tor} T_{\mathcal{A}}(\theta)=\left\langle\mathcal{S}_{i}\right\rangle_{i \in \mathbb{Z}} \tag{26}
\end{equation*}
$$

where $\mathcal{S}_{i} \simeq \operatorname{per} \mathcal{A}$ is the admissible subcategory consisting of graded modules concentrated in degree $i$. One has

$$
\begin{equation*}
\operatorname{gr} T_{\mathcal{A}}(\theta)=\left\langle\ldots, \mathcal{S}_{-2}, \mathcal{S}_{-1},\left(\operatorname{gr} T_{\mathcal{A}}(\theta)\right)_{\geq 0}\right\rangle \tag{27}
\end{equation*}
$$

just as in Orl09, Lemma 14], where $\left(\operatorname{gr} T_{\mathcal{A}}(\theta)\right)_{\geq 0}$ is the full subcategory of $\operatorname{gr} T_{\mathcal{A}}(\theta)$ consisting of non-negatively graded modules. It follows from the quasi-isomorphism

$$
\begin{equation*}
\mathcal{A} \simeq \operatorname{Cone}\left(T_{\mathcal{A}}(\theta)^{+} \rightarrow T_{\mathcal{A}}(\theta)\right) \tag{28}
\end{equation*}
$$

of graded $T_{\mathcal{A}}(\theta)$-modules that the free module $T_{\mathcal{A}}(\theta)$ is right orthogonal to $\left\langle\mathcal{S}_{i}\right\rangle_{i \geq 0}$, and that its shift $T_{\mathcal{A}}(\theta)(i)$ for any $i<0$ is in the full pretriangulated subcategory generated by $T_{\mathcal{A}}(\theta)$ and $\left\langle\mathcal{S}_{i}\right\rangle_{i \geq 0}$. Hence $T_{\mathcal{A}}(\theta)$ generates the right orthogonal to $\left\langle\mathcal{S}_{i}\right\rangle_{i \geq 0}$ in $\left(\operatorname{gr} T_{\mathcal{A}}(\theta)\right)_{\geq 0}$, so that qgr $T_{\mathcal{A}}(\theta)$ is equivalent to the full subcategory $\left\langle T_{\mathcal{A}}(\theta)\right\rangle$ of $\operatorname{gr} T_{\mathcal{A}}(\theta)$, which in turn is equivalent to per $\mathcal{A}$.

Definition 3. A spherical helix generated by a spherical collection $\left(S_{i}\right)_{i=1}^{\ell}$ is a sequence $\left(S_{i}\right)_{i \in \mathbb{Z}}$ of spherical objects of $\mathcal{C}$ satisfying

$$
\begin{equation*}
S_{i-\ell}=T_{S_{i-\ell+1}} \circ T_{S_{i-\ell+2}} \circ \cdots \circ T_{S_{i-1}}\left(S_{i}\right)[-d-1] \tag{29}
\end{equation*}
$$

for any $i \in \mathbb{Z}$.
The length $\ell$ of the spherical collection generating the spherical helix is called the period of the spherical helix. For any $i \in \mathbb{Z}$, the spherical collection $\left(S_{j}\right)_{j=i}^{i+\ell-1}$ consisting of $\ell$ consecutive objects in the spherical helix is called a foundation of the spherical helix $\mathcal{H}$.
Definition 4. A spherical helix $\left(S_{i}\right)_{i \in \mathbb{Z}}$ is acyclic if $\operatorname{Hom}^{\neq 0}\left(S_{i}, S_{j}\right)=0$ for any $-\infty<i<j<\infty$.
One has

$$
\begin{align*}
\operatorname{hom}\left(S_{i}, S_{j}\right) & \simeq \operatorname{hom}\left(\iota^{*} E_{i}, \iota^{*} E_{j}\right)  \tag{30}\\
& \simeq \operatorname{hom}\left(E_{i}, \iota_{*} \iota^{*} E_{j}\right)  \tag{31}\\
& \simeq \operatorname{hom}\left(E_{i}, \operatorname{Cone}\left(E_{j-\ell} \rightarrow E_{j}\right)\right) \tag{32}
\end{align*}
$$

which immediately yields the following:
Theorem 5. If the spherical helix $\left(S_{i}\right)_{i \in \mathbb{Z}}$ is acyclic, then the helix $\left(E_{i}\right)_{i \in \mathbb{Z}}$ is acyclic.
Recall that a connected $\mathbb{Z}$-algebra $A=\bigoplus_{i, j=-\infty}^{\infty} A_{i j}$ over $\mathbf{k}$ is said to be $A S$-Gorenstein if

$$
\begin{equation*}
\sum_{j, k=-\infty}^{\infty} \operatorname{dim} \operatorname{Hom}^{k}\left(S_{i, A}, P_{j, A}\right)=1 \tag{33}
\end{equation*}
$$

for any $i \in \mathbb{Z}$, where $S_{i, A}$ and $P_{i, A}$ are the $i$-th simple and projective $A$-modules respectively. It follows from (25) that the acyclicity of the helix $\left(E_{i}\right)_{i \in \mathbb{Z}}$ implies the AS-Gorenstein property of the helix $\mathbb{Z}$-algebra $A$. Since $\mathcal{A}$ is smooth and $\theta$ is perfect, the tensor algebra $T_{\mathcal{A}}(\theta)$ is smooth, so
that $A$ has finite global dimension (see e.g. KKel11, Theorem 4.8]). The Hilbert polynoimal of $A$ is determined by the projective resolutions of the simples.
