# SPLIT METACYCLIC ACTIONS ON SURFACES

#### Abstract

Let $\operatorname{Mod}\left(S_{g}\right)$ be the mapping class group of the closed orientable surface $S_{g}$ of genus $g \geq 2$. In this paper, we derive necessary and sufficient conditions under which two torsion elements in $\operatorname{Mod}\left(S_{g}\right)$ will have conjugates that generate a finite split nonabelian metacyclic subgroup of $\operatorname{Mod}\left(S_{g}\right)$. As applications of the main result, we give a complete characterization of the finite dihedral and the generalized quaternionic subgroups of $\operatorname{Mod}\left(S_{g}\right)$ up to a certain equivalence that we will call weak conjugacy. Furthermore, we show that any finite-order mapping class whose corresponding orbifold is a sphere, has a conjugate that lifts under certain finite-sheeted regular cyclic covers of $S_{g}$. Moreover, for $g \geq 5$, we show the existence of an infinite dihedral subgroup of $\operatorname{Mod}\left(S_{g}\right)$ that is generated by the hyperelliptic involution and a root of a bounding pair map of degree 3. Finally, we provide a complete classification of the weak conjugacy classes of the non-abelian finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{3}\right)$ and $\operatorname{Mod}\left(S_{5}\right)$.


## 1. Introduction

Let $S_{g}$ be the closed orientable surface of genus $g \geq 0, \mathrm{Homeo}^{+}\left(S_{g}\right)$ be the group of orientation-preserving homeomorphisms on $S_{g}$, and let $\operatorname{Mod}\left(S_{g}\right)$ be the mapping class group of $S_{g}$. Given $F, G \in \operatorname{Mod}\left(S_{g}\right)$ of finite order, a pair of conjugates $F^{\prime}, G^{\prime}$ (of $F, G$ resp.) may (or may not) generate a subgroup isomorphic to $\langle F, G\rangle$. For example, consider the periodic mapping classes $F, G \in \operatorname{Mod}\left(S_{7}\right)$ represented by homeomorphisms $\mathcal{F}, \mathcal{G} \in \mathrm{Homeo}^{+}\left(S_{g}\right)$ (see [18 for details), as shown in the first subfigure of Figure 1 below.


Figure 1. Split metacyclic subgroups of $\operatorname{Mod}\left(S_{7}\right)$ with conjugate generators.

[^0]From Figure 1, it is apparent that $\langle F, G\rangle \cong D_{8}$ (i.e. the dihedral group of order 8). For $1 \leq i \leq 3$, we consider the conjugates $G_{i}$ of $G$, represented by the $\mathcal{G}_{i} \in \operatorname{Homeo}^{+}\left(S_{7}\right)$ and for $1 \leq j \leq 2$, we consider the conjugates $\mathcal{F}_{j}$ of $\mathcal{F}$ indicated in the (second and third) subfigures. In the second subfigure, we have marked the fixed points of a conjugate $\mathcal{F}_{1}$ of $\mathcal{F}$ (with the same local rotation angles as $\mathcal{F}$ ). Also, note that the third subfigure is different from the first (as an imbedding $S_{7} \rightarrow \mathbb{R}^{3}$ ), since has four pairs of tubes connecting the spheres, where in each pair, the tubes are aligned one behind the other. As it turns out, $\left\langle F_{1}, G_{1}\right\rangle \cong\left\langle F_{2}, G_{2}\right\rangle \cong D_{8}$, but since $\mathcal{F}_{1}$ and $\mathcal{G}_{3}$ commute, we have $\left\langle F_{1}, G_{3}\right\rangle \cong \mathbb{Z}_{4} \times \mathbb{Z}_{2}$. This example motivates the following natural question: Given $F^{\prime}, G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ of orders $n, m$ (resp.), can one derive equivalent conditions under which there exist conjugates $F, G$ (of $F^{\prime}, G^{\prime}$ resp.) such that $\langle F, G\rangle$ is a finite nonabelian split metacyclic subgroup of order $m \cdot n$ and twist factor $k$ admitting the presentation

$$
\left\langle F, G \mid F^{n}=G^{m}=1, G^{-1} F G=F^{k}\right\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}
$$

Considering that the finite abelian subgroups of $\operatorname{Mod}\left(S_{g}\right)$ have been extensively studied [6, 8, 11, 16], in the main result of this paper, we answer this question in the affirmative for $k \neq 1$.

Given a finite split (nonabelian) metacyclic subgroup $H=\langle F, G\rangle$ of $\operatorname{Mod}\left(S_{g}\right)$ as above, the Nielsen realization theorem [13, 17] asserts that we may also view $H$ as a subgroup of $\mathrm{Homeo}^{+}\left(S_{g}\right)$ with an associated $H$-action on $S_{g}$ inducing the branched cover $S_{g} \rightarrow S_{g} / H$. In order to establish the main result, we develop a notion of equivalence involving the finite split (nonabelian) metacyclic subgroups of $\operatorname{Mod}\left(S_{g}\right)$ called weak conjugacy. Two isomorphic finite split metacyclic subgroups $H_{1}=\left\langle F_{1}, G_{1}\right\rangle$ and $H_{2}=\left\langle F_{2}, G_{2}\right\rangle$ of $\operatorname{Mod}\left(S_{g}\right)$ are said to be weakly conjugate if $\left(F_{1}, G_{1}\right)$ is pairwise conjugate to $\left(F_{2}, G_{2}\right)$, and the associated $H_{i}$-actions on $S_{g}$ satisfy a certain equivalence (see Definition 2.10 for a rigorous definition). Even though this notion of equivalence of subgroups is (in general) weaker than conjugacy, it does provide us with an effective way of differentiating between isomorphic split metacyclic subgroups of $\operatorname{Mod}\left(S_{g}\right)$ by virtue of their topological realizations (i.e. by understanding how the associated topological actions on $S_{g}$ differ from each other.)

The main ingredient in the proof of the main result is the derivation necessary and sufficient conditions for the weak conjugacy of split metacyclic subgroups by establishing a correspondence between these weak conjugacy classes and certain abstract tuples of integers called split metacyclic data sets (see Section (3). Furthermore, we note that the isomorphism class of a finite split metacyclic subgroup $H$ is the union of the weak conjugacy classes that $H$ represents. Consequently, we obtain equivalent conditions under which two torsion elements in $\operatorname{Mod}\left(S_{g}\right)$ will have conjugates that generate a finite split metacyclic subgroup of $\operatorname{Mod}\left(S_{g}\right)$. This result is a generalization of an analogous result from [8] for two-generator finite abelian subgroups. Moreover, given such a data set, these conditions also provide an immediate way of recovering the conjugacy classes of the pair of generators associated with the weak conjugacy class. The proof integrates ideas from the theory of group actions on surfaces [13, 15] with elements of Thurston's orbifold theory [20, Chapter 13]. In view of the Nielsen realization theorem, consider
representatives $\mathcal{F}, \mathcal{G} \in \mathrm{Homeo}^{+}\left(S_{g}\right)$ of $F, G$ (resp.) with the same orders. Another key idea in the proof (of the main result) is the analysis of the geometric properties of the automorphism induced by $\mathcal{G}$ in $S_{g} /\langle\mathcal{F}\rangle$.

In Section 4, we provide several applications of our main theorem. The first application concerns the finite dihedral subgroups of $\operatorname{Mod}\left(S_{g}\right)$. Let $D_{2 n}=\mathbb{Z}_{n} \rtimes_{-1} \mathbb{Z}_{2}$ be the dihedral group of order $2 n$. We derive the following characterization of dihedral subgroups of $\operatorname{Mod}\left(S_{g}\right)$ in Subsection 4.1.

Proposition 1. Let $F \in \operatorname{Mod}\left(S_{g}\right)$ be of order $n$. Then there exists an involution $G \in \operatorname{Mod}\left(S_{g}\right)$ such that $\langle F, G\rangle \cong D_{2 n}$ if and only if $F$ and $F^{-1}$ are conjugate in $\operatorname{Mod}\left(S_{g}\right)$.

It is worth mentioning here that dihedral actions on Riemann surfaces have been classified in [7]. Furthermore, for $g \geq 2$, in Subsection 4.2, we describe a special family of split metacyclic actions on $S_{2 g-1}$ that yield, and also correspond to generalized quaternionic actions on $S_{g}$ (see Proposition 4.7). We plan to undertake the generalization of this result to arbitrary finite metacyclic groups in future works.

Let $S_{g, r}$ be the surface of genus $g$ with $r$ punctures. Let $p: S_{\tilde{g}} \rightarrow S_{g, r}$ be a branched cover with deck transformation group $\langle\mathcal{F}\rangle$, where $\mathcal{F}$ is periodic. Let $\operatorname{LMod}_{p}\left(S_{g, r}\right)\left(\right.$ resp. $\left.\operatorname{SMod}_{p}\left(S_{\tilde{g}}\right)\right)$ be the liftable (resp. symmetric) mapping class groups of $p$. In Subsection 4.3, we analyze the cyclic subgroups of $\operatorname{Mod}\left(S_{g, r}\right)$ that lift to finite split metacyclic groups under certain covers of type $p$. For a periodic mapping class $F \in \operatorname{Mod}\left(S_{g}\right)$, let $\mathcal{O}_{\langle\mathcal{F}\rangle}:=S_{g} /\langle\mathcal{F}\rangle$ denote the corresponding orbifold of $F$. It is known 10 that $F$ is irreducible if and only if $\mathcal{O}_{\langle\mathcal{F}\rangle} \approx S_{0,3}$. An irreducible mapping class $F \in \operatorname{Mod}\left(S_{g}\right)$ of order $n$ is said to be of Type 1 if $\mathcal{O}_{\langle\mathcal{F}\rangle}$ has a cone point of order $n$. In the following application, we describe how finite cyclic subgroups of $\operatorname{Mod}\left(S_{0,3}\right)$ can lift (under $p$ ) to finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{\tilde{g}}\right)$, when $F$ is irreducible.

Corollary 1. $p: S_{\tilde{g}} \rightarrow S_{0,3}$ be a branched cover with deck transformation group $\langle\mathcal{F}\rangle$, where $F$ is an irreducible mapping class of order $n$. Suppose that a non-trivial element $G^{\prime} \in \operatorname{Mod}\left(S_{0,3}\right)$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{0,3}\right)$. Then:
(i) $F$ is of Type 1,
(ii) $|G|=2$ or 3 , and
(iii) $G$ has lift $\tilde{G} \in \operatorname{SMod}\left(S_{\tilde{g}}\right)$ such that either $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{2}$ or $\langle F, \tilde{G}\rangle \cong$ $\mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{3}$, for some $k \in \mathbb{Z}_{n}^{\times}$.
When $p$ is a regular cyclic cover (i.e the $\langle\mathcal{F}\rangle$-action on $S_{\tilde{g}}$ is free), we have $r=0$ and $\tilde{g}=n(g-1)+1$. In this context, we show the following.
Proposition 2. For $g, n \geq 2$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular cover with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Then any involution $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ has a conjugate $G \in \operatorname{LMod}\left(S_{g}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}\left(S_{n(g-1)+1}\right)$ such that $\langle F, \tilde{G}\rangle \cong D_{2 n}$.

Moreover, we provide sufficient conditions for the liftability (under $p$ ) of a periodic mapping class whose corresponding orbifold is a sphere (see Propositions 4.14-4.15). As a consequence, we obtain the following corollary.

Corollary 2. For $g \geq 2$ and prime $n$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular $n$-sheeted with deck transformation group $\langle\mathcal{F}\rangle \cong \mathbb{Z}_{n}$. Let $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ be of order $m$ such that the genus of $\mathcal{O}_{\left\langle\mathcal{G}^{\prime}\right\rangle}$ is zero. Then $G^{\prime}$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{g}\right)$ such that $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{m} \rtimes_{k} \mathbb{Z}_{n}$ if there exists $k \in \mathbb{Z}_{n}^{\times}$such that $|k|=m$.

An infinite dihedral group is a group that admits a presentation of the form

$$
\left\langle x, y \mid y^{2}=1, y^{-1} x y=x^{-1}\right\rangle .
$$

By a root of a mapping class $F \in \operatorname{Mod}\left(S_{g}\right)$ of degree $n$, we mean a $G \in$ $\operatorname{Mod}\left(S_{g}\right)$ such that $G^{n}=F$. As a final application, in Subsection 4.4, we use the theory developed in [19], to construct roots of bounding pair maps in $\operatorname{Mod}\left(S_{g}\right)$ of degree 3, for $g \geq 5$, which together with the hyperelliptic involution, generate infinite dihedral subgroups of $\operatorname{Mod}\left(S_{g}\right)$.
Proposition 3. For $g \geq 5$, there exists an infinite dihedral subgroup of $\operatorname{Mod}\left(S_{g}\right)$ that is generated by the hyperelliptic involution and a root of a bounding pair map of degree 3 .

In Section 5, we give complete classifications of the weak conjugacy classes of finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{3}\right)$ and $\operatorname{Mod}\left(S_{5}\right)$. It may be noted that similar classifications for $2 \leq g \leq 4$ can also be obtained through the techniques developed in [3, 5, 14]. Finally, we apply the results in [18] to provide an algorithm for determining the hyperbolic structures that realize split metacylic subgroups as groups of isometries. We conclude the paper by giving nontrivial geometric realizations of some finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{3}\right)$ and $\operatorname{Mod}\left(S_{5}\right)$.

## 2. Preliminaries

2.1. Fuchsian groups. Let $\mathrm{Homeo}^{+}\left(S_{g}\right)$ denote the group of orientationpreserving homeomorphisms on $S_{g}$, and let $H<\operatorname{Homeo}^{+}\left(S_{g}\right)$ be a finite group. A faithful and properly discontinuous $H$-action on $S_{g}$ induces a branched covering

$$
S_{g} \rightarrow \mathcal{O}_{H}:=S_{g} / H
$$

with $\ell$ cone points $x_{1}, \ldots, x_{\ell}$ on the quotient orbifold $\mathcal{O}_{H} \approx S_{g_{0}}$ (which we will call the corresponding orbifold) of orders $n_{1}, \ldots, n_{\ell}$, respectively. Then the orbifold fundamental group $\pi_{1}^{\text {orb }}\left(\mathcal{O}_{H}\right)$ of $\mathcal{O}_{H}$ has a presentation given by

$$
\begin{equation*}
\left\langle\alpha_{1}, \beta_{1}, \ldots, \alpha_{g_{0}}, \beta_{g_{0}}, \xi_{1}, \ldots, \xi_{\ell} \mid \xi_{1}^{n_{1}}, \ldots, \xi_{\ell}^{n_{\ell}}, \prod_{i=1}^{\ell} \xi_{i} \prod_{i=1}^{g_{0}}\left[\alpha_{i}, \beta_{i}\right]\right\rangle . \tag{1}
\end{equation*}
$$

In classical parlance, $\pi_{1}^{\text {orb }}\left(\mathcal{O}_{H}\right)$ is also known as a Fuchsian group [12, 15] with signature

$$
\Gamma\left(\mathcal{O}_{H}\right):=\left(g_{0} ; n_{1}, \ldots, n_{\ell}\right),
$$

and the relation $\prod_{i=1}^{\ell} \xi_{i} \prod_{i=1}^{g_{0}}\left[\alpha_{i}, \beta_{i}\right]$ appearing in its presentation is called the long relation. From Thurston's orbifold theory [20, Chapter 13], we obtain exact sequence

$$
\begin{equation*}
1 \rightarrow \pi_{1}\left(S_{g}\right) \rightarrow \pi_{1}^{\mathrm{orb}}\left(\mathcal{O}_{H}\right) \xrightarrow{\phi_{H}} H \rightarrow 1 . \tag{2}
\end{equation*}
$$

In this context, we will require the following result due to Harvey [11.

Lemma 2.1. A finite group $H$ acts faithfully on $S_{g}$ with $\Gamma\left(\mathcal{O}_{H}\right)=\left(g_{0} ; n_{1}, \ldots, n_{\ell}\right)$ if and only if it satisfies the following two conditions:
(i) $\frac{2 g-2}{|H|}=2 g_{0}-2+\sum_{i=1}^{\ell}\left(1-\frac{1}{n_{i}}\right)$, and
(ii) there exists a surjective homomorphism $\phi_{H}: \pi_{1}^{\mathrm{orb}}\left(\mathcal{O}_{H}\right) \rightarrow H$ that preserves the orders of all torsion elements of $\Gamma$.
2.2. Cyclic actions on surfaces. For $g \geq 1$, let $F \in \operatorname{Mod}\left(S_{g}\right)$ be of order $n$. The Nielsen-Kerckhoff theorem [13, 17] asserts that $F$ is represented by a standard representative $\mathcal{F} \in \operatorname{Homeo}^{+}\left(S_{g}\right)$ of the the same order. We refer to both $\mathcal{F}$ and the group it generates, interchangeably, as a $\mathbb{Z}_{n}$-action on $S_{g}$. Each cone point $x_{i} \in \mathcal{O}_{\langle\mathcal{F}\rangle}$ lifts to an orbit of size $n / n_{i}$ on $S_{g}$, and the local rotation induced by $\mathcal{F}$ around the points in each orbit is given by $2 \pi c_{i}^{-1} / n_{i}$, where $\operatorname{gcd}\left(c_{i}, n_{i}\right)=1$ and $c_{i} c_{i}^{-1} \equiv 1\left(\bmod n_{i}\right)$. Further, it is known (see [11] and the references therein) that the exact sequence in 2.2 takes the following form

$$
1 \rightarrow \pi_{1}\left(S_{g}\right) \rightarrow \pi_{1}^{\text {orb }}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right) \xrightarrow{\phi_{\langle\mathcal{F}\rangle}}\langle\mathcal{F}\rangle \rightarrow 1,
$$

where $\phi_{\langle\mathcal{F}\rangle}\left(\xi_{i}\right)=\mathcal{F}^{\left(n / n_{i}\right) c_{i}}$, for $1 \leq i \leq \ell$. We will now introduce a tuple of integers that encodes the conjugacy class of a $\mathbb{Z}_{n}$-action on $S_{g}$.

Definition 2.2. A data set of degree $n$ is a tuple

$$
D=\left(n, g_{0}, r ;\left(c_{1}, n_{1}\right), \ldots,\left(c_{\ell}, n_{\ell}\right)\right),
$$

where $n \geq 2, g_{0} \geq 0$, and $0 \leq r \leq n-1$ are integers, and each $c_{i} \in \mathbb{Z}_{n_{i}}^{\times}$such that:
(i) $r>0$ if and only if $\ell=0$ and $\operatorname{gcd}(r, n)=1$, whenever $r>0$,
(ii) each $n_{i} \mid n$,
(iii) $\operatorname{lcm}\left(n_{1}, \ldots \widehat{n_{i}}, \ldots, n_{\ell}\right)=N$, for $1 \leq i \leq \ell$, where $N=n$, if $g_{0}=0$, and
(iv) $\sum_{j=1}^{\ell} \frac{n}{n_{j}} c_{j} \equiv 0(\bmod n)$.

The number $g$ determined by the Riemann-Hurwitz equation

$$
\begin{equation*}
\frac{2-2 g}{n}=2-2 g_{0}+\sum_{j=1}^{\ell}\left(\frac{1}{n_{j}}-1\right) \tag{3}
\end{equation*}
$$

is called the genus of the data set, denoted by $g(D)$.
Note that quantity $r$ (in Definition (2.2) will be non-zero if and only if $D$ represents a free rotation of $S_{g}$ by $2 \pi r / n$, in which case, $D$ will take the form $\left(n, g_{0}, r ;\right)$. We will not include $r$ in the notation of a data set, whenever $r=0$.

By the Nielsen-Kerckhoff theorem, the canonical projection $\mathrm{Homeo}^{+}\left(S_{g}\right) \rightarrow$ $\operatorname{Mod}\left(S_{g}\right)$ induces a bijective correspondence between the conjugacy classes of finite-order maps in $\mathrm{Homeo}^{+}\left(S_{g}\right)$ and the conjugacy classes of finite-order mapping classes in $\operatorname{Mod}\left(S_{g}\right)$. This leads us to the following lemma (that follows from [19, Theorem 3.8] and [11), which allows us to use data sets to describe the conjugacy classes of cyclic actions on $S_{g}$.

Lemma 2.3. For $g \geq 1$ and $n \geq 2$, data sets of degree $n$ and genus $g$ correspond to conjugacy classes of $\mathbb{Z}_{n}$-actions on $S_{g}$.

We will denote the data set corresponding to the conjugacy class of a periodic mapping class $F$ by $D_{F}$. For compactness of notation, we also write a data set $D$ (as in Definition 2.2) as

$$
D=\left(n, g_{0}, r ;\left(\left(d_{1}, m_{1}\right), \alpha_{1}\right), \ldots,\left(\left(d_{\ell^{\prime}}, m_{\ell^{\prime}}\right), \alpha_{\ell^{\prime}}\right)\right)
$$

where $\left(d_{i}, m_{i}\right)$ are the distinct pairs in the multiset $S=\left\{\left(c_{1}, n_{1}\right), \ldots,\left(c_{\ell}, n_{\ell}\right)\right\}$, and the $\alpha_{i}$ denote the multiplicity of the pair $\left(d_{i}, m_{i}\right)$ in the multiset $S=$ $\left\{\left(c_{1}, n_{1}\right), \ldots,\left(c_{\ell}, n_{\ell}\right)\right\}$. Further, we note that every cone point $[x] \in \mathcal{O}_{\langle\mathcal{F}\rangle}$ corresponds to a unique pair in the multiset $S$ appearing in $D_{F}$, which we denote by $\mathcal{P}_{x}:=\left(c_{x}, n_{x}\right)$.

Given $u \in \mathbb{Z}_{m}^{\times}$and $\mathcal{G} \in H \leq \operatorname{Homeo}^{+}\left(S_{g}\right)$ be of order $m$, let $\mathbb{F}_{\mathcal{G}}(u, m)$ denote the set of fixed points of $\mathcal{G}$ with induced rotation angle $2 \pi u^{-1} / \mathrm{m}$. Let $C_{H}(\mathcal{G})$ be the centralizer of an $\mathcal{G} \in H$ and $\sim$ denote the conjugation relation between any two elements in $H$. We conclude this subsection by stating the following result from the theory of Riemann surfaces [4], which we will use in the proof of our main theorem.

Lemma 2.4. Let $H<\operatorname{Homeo}^{+}\left(S_{g}\right)$ with $\Gamma\left(\mathcal{O}_{H}\right)=\left(g_{0} ; n_{1}, \ldots, n_{\ell}\right)$, and let $\mathcal{G} \in H$ be of order $m$. Then for $u \in \mathbb{Z}_{m}^{\times}$, we have

$$
\left|\mathbb{F}_{\mathcal{G}}(u, m)\right|=\left|C_{H}(\mathcal{G})\right| \cdot \sum_{\substack{1 \leq i \leq \ell \\ m \mid n_{i} \\ \mathcal{G} \sim \phi_{H}\left(\xi_{i}\right)^{n_{i} u / m}}} \frac{1}{n_{i}}
$$

2.3. Hyperbolic structures realizing cyclic actions. Given a finite subgroup $H<\operatorname{Mod}\left(S_{g}\right)$, let $\operatorname{Fix}(H)$ denote the subspace of fixed points in the Teichm̈uller space Teich $\left(S_{g}\right)$ under the action of $H$. When $H$ is cyclic, a method for constructing the hyperbolic metrics representing the points in $\operatorname{Fix}(H)$ was described in [1] and [18, thereby yielding explicit solutions to the Nielsen realization problem [13, 17]. This method involved the decomposition of an arbitrary periodic element in $\operatorname{Mod}\left(S_{g}\right)$ (that is not realizable as a rotation of $S_{g}$ ) into irreducible Type 1 components, which are uniquely realized as rotations of certain special hyperbolic polygons with side-pairings.

A mapping class that is not reducible is called irreducible. Let $F \in$ $\operatorname{Mod}\left(S_{g}\right)$ be of order $n$. Gilman [10] showed that $F$ is irreducible if and only if $\Gamma\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ has the form $\left(0 ; n_{1}, n_{2}, n_{3}\right)$ (i.e. the quotient orbifold $\mathcal{O}_{\langle\mathcal{F}\rangle}$ is a sphere with three cone points.) Following the nomenclature in [1, 18], $F$ is rotational if $\mathcal{F}$ is a rotation of $S_{g}$ about an axis under an appropriate isometric embedding of $S_{g} \hookrightarrow \mathbb{R}^{3}$. A non-rotational $F$ is said to be of Type 1 if $\Gamma\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)=\left(g_{0} ; n_{1}, n_{2}, n\right)$, otherwise, it is called a Type 2 action. The following result describes the unique hyperbolic structure that realizes an irreducible Type 1 action.

Theorem 2.5. For $g \geq 2$, consider a irreducible Type 1 action $F \in \operatorname{Mod}\left(S_{g}\right)$ with

$$
D_{F}=\left(n, 0 ;\left(c_{1}, n_{1}\right),\left(c_{2}, n_{2}\right),\left(c_{3}, n\right)\right)
$$

Then $F$ can be realized explicitly as the rotation $\theta_{F}=\frac{2 \pi c_{3}^{-1}}{n}$ of a hyperbolic polygon $\mathcal{P}_{F}$ with a suitable side-pairing $W\left(\mathcal{P}_{F}\right)$, where $\mathcal{P}_{F}$ is a hyperbolic $k(F)$-gon with

$$
k(F):= \begin{cases}2 n, & \text { if } n_{1}, n_{2} \neq 2, \text { and } \\ n, & \text { otherwise }\end{cases}
$$

and for $0 \leq m \leq n-1$,

$$
W\left(\mathcal{P}_{F}\right)= \begin{cases}\prod_{i=1}^{n} a_{2 i-1} a_{2 i} \text { with } a_{2 m+1}^{-1} \sim a_{2 z}, & \text { if } k(F)=2 n, \text { and } \\ \prod_{i=1}^{n} a_{i} \text { with } a_{m+1}^{-1} \sim a_{z}, & \text { otherwise }\end{cases}
$$

where $z \equiv m+q j(\bmod n)$ with $q=\left(n / n_{2}\right) c_{3}^{-1}$ and $j=n_{2}-c_{2}$.
Further, it was shown that the process of realizing an arbitrary nonrotational action $F$ of order $n$ using these unique hyperbolic structures realizing irreducible Type 1 components involved two broad types of processes.
(a) $k$-compatibility. In this process, for $i=1$, 2 , we take a pair of irreducible Type 1 mapping classes $F_{i} \in \operatorname{Mod}\left(S_{g_{i}}\right)$ such that the $\left\langle\mathcal{F}_{i}\right\rangle$-action on $S_{g_{i}}$ induces a pairs of compatible orbits of size $k$ (where the induced local rotation angles add upto 0 modulo $2 \pi$ ). We remove (cyclically permuted) $\left\langle\mathcal{F}_{i}\right\rangle$-invariant disks around points in the compatible orbits and then identify the resulting boundary components realizing a periodic mapping class $F \in \operatorname{Mod}\left(S_{g_{1}+g_{2}+k-1}\right)$. An analogous construction can also be performed using a pair of orbits induced by a single $\left\langle\mathcal{F}^{\prime}\right\rangle$-action on $S_{g}$ to realize a periodic mapping class $F \in \operatorname{Mod}\left(S_{g+k}\right)$.
(b) Permutation additions and deletions. The addition of a permutation component involves the removal of (cyclically permuted) invariant disks around points in an orbit of size $n$ induced by an $\langle\mathcal{F}\rangle$-action on $S_{g}$ and then pasting $n$ copies of $S_{g^{\prime}}^{1}$ (i.e. $S_{g^{\prime}}$ with one boundary component) to the resultant boundary components. This realizes a action on $S_{g+n g^{\prime}}$ with the same fixed point and orbit data as $F$. The reversal of this process is called a permutation deletion.
Thus, in summary, we have the following:
Theorem 2.6. For $g \geq 2$, a non-rotational periodic mapping class in $\operatorname{Mod}\left(S_{g}\right)$ can be realized through finitely many $k$-compatibilities, permutation additions, and permutation deletions on the unique structures of type $\mathcal{P}_{F}$ realizing irreducible Type 1 mapping classes.

A final, but yet vital ingredient in the realization of split metacyclic actions is the following elementary lemma, which is a direct generalization of [8, Lemma 6.1].

Lemma 2.7. Let $H=\langle F, G\rangle$ be a finite metacyclic subgroup of $\operatorname{Mod}\left(S_{g}\right)$. Then

$$
\operatorname{Fix}(H)=\operatorname{Fix}(\langle F\rangle) \cap \operatorname{Fix}(\langle G\rangle)
$$

2.4. Split metacyclic actions on surfaces. Given integers $m, n \geq 2$, and $k \in \mathbb{Z}_{n}^{\times}$such that $k^{m} \equiv 1(\bmod n)$, a finite split metacyclic action of order $m n$ (written as $m \cdot n$ ) on $S_{g}$ is a tuple $\left(H,(\mathcal{G}, \mathcal{F})\right.$ ), where $H<\operatorname{Homeo}^{+}\left(S_{g}\right)$, and

$$
H=\left\langle\mathcal{F}, \mathcal{G} \mid \mathcal{F}^{n}=\mathcal{G}^{m}=1, \mathcal{G}^{-1} \mathcal{F} \mathcal{G}=\mathcal{F}^{k}\right\rangle .
$$

We will call the multiplicative class $k$ the twist factor of the split metacyclic action $(H,(\mathcal{G}, \mathcal{F}))$. As we are only interested in nonabelian split metacyclic subgroups, we will assume from here on that $k \neq 1$. Note that in classical notation $H \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$. As $\langle\mathcal{F}\rangle \triangleleft H$, it is known [4, (21] that $\mathcal{G}$ would induce a $\overline{\mathcal{G}} \in \mathrm{Homeo}^{+}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ that preserves the set of cone points in $\mathcal{O}_{\langle\mathcal{F}\rangle}$ along with their orders. We will call $\overline{\mathcal{G}}$, the induced automorphism on $\mathcal{O}_{\langle\mathcal{F}\rangle}$ by $\mathcal{G}$, and we formalize this notion in the following definition.
Definition 2.8. Let $H<\operatorname{Homeo}^{+}\left(S_{g}\right)$ be a finite cyclic group with $|H|=n$. We say an $\overline{\mathcal{F}} \in \operatorname{Homeo}^{+}\left(\mathcal{O}_{H}\right)$ is an automorphism of $\mathcal{O}_{H}$ if for $[x],[y] \in \mathcal{O}_{H}$, $k \in \mathbb{Z}_{n}^{\times}$and $\overline{\mathcal{F}}([x])=[y]$, we have:
(i) $n_{x}=n_{y}$, and
(ii) $k c_{x}=c_{y}$.

We denote the group of automorphisms of $\mathcal{O}_{H}$ by $\operatorname{Aut}_{k}\left(\mathcal{O}_{H}\right)$.
We note that the concept of an induced orbifold automorphism in Definition [2.8 is more general than the one that was used in [8], which required a more rigid condition that $c_{x}=c_{y}$. The following lemma, which provides some basic properties of the induced map $\overline{\mathcal{G}}$, is a split metacyclic analog of [8, Lemma 3.1].

Lemma 2.9. Let $\mathcal{G}, \mathcal{F} \in \operatorname{Homeo}^{+}\left(S_{g}\right)$ be maps of orders $m, n$, respectively, such that $\mathcal{G}^{-1} \mathcal{F G}=\mathcal{F}^{k}$, and let $H=\langle\mathcal{F}\rangle$. Then:
(i) $\mathcal{G}$ induces a $\overline{\mathcal{G}} \in \operatorname{Aut}_{k}\left(\mathcal{O}_{H}\right)$ such that

$$
\mathcal{O}_{H} /\langle\overline{\mathcal{G}}\rangle=S_{g} /\langle\mathcal{F}, \mathcal{G}\rangle,
$$

(ii) $|\overline{\mathcal{G}}|$ divides $|\mathcal{G}|$, and
(iii) $|\overline{\mathcal{G}}|<m$ if and only if $\mathcal{F}^{l}=\mathcal{G}^{k}$, for some $0<l<n$ and $0<k<m$.

We will now formalize the notion of weak conjugacy from Section 1 .
Definition 2.10. Two finite split metacyclic actions $\left(H_{1},\left(\mathcal{G}_{1}, \mathcal{F}_{1}\right)\right)$ and $\left(H_{2},\left(\mathcal{G}_{2}, \mathcal{F}_{2}\right)\right)$ of order $m \cdot n$ and twist factor $k$ are said to be weakly conjugate if there exists an isomorphism, $\psi: \pi_{1}^{\text {orb }}\left(\mathcal{O}_{H_{1}}\right) \cong \pi_{1}^{\text {orb }}\left(\mathcal{O}_{H_{2}}\right)$ and an isomorphism $\chi: H_{1} \rightarrow H_{2}$ such that the following conditions hold.
(i) $\chi\left(\left(\mathcal{G}_{1}, \mathcal{F}_{1}\right)\right)=\left(\mathcal{G}_{2}, \mathcal{F}_{2}\right)$.
(ii) For $i=1,2$, let $\phi_{i}: \pi_{1}^{\text {orb }}\left(\mathcal{O}_{H_{i}}\right) \rightarrow H_{i}$ be the surface kernel (appearing in the exact sequence (2.2) in Section (22). Then $\left(\chi \circ \phi_{H_{1}}\right)(g)=\left(\phi_{H_{2}} \circ\right.$ $\psi)(g)$, whenever $g \in \pi_{1}^{\mathrm{orb}}\left(\mathcal{O}_{H_{1}}\right)$ is of finite order.
(iii) The pair $\left(\mathcal{G}_{1}, \mathcal{F}_{1}\right)$ is conjugate (component-wise) to the pair $\left(\mathcal{G}_{2}, \mathcal{F}_{2}\right)$ in Homeo ${ }^{+}\left(S_{g}\right)$.
The notion of weak conjugacy defines an equivalence relation on split metacyclic actions on $S_{g}$ and the equivalence classes thus obtained will be called weak conjugacy classes.

Remark 2.11. By virtue of the Nielsen-Kerckhoff theorem, the notion of weak conjugacy in Definition 2.10 naturally extends to an analogous notion in $\operatorname{Mod}\left(S_{g}\right)$ via the natural association

$$
(\langle\mathcal{F}, \mathcal{G}\rangle,(\mathcal{G}, \mathcal{F})) \leftrightarrow(\langle F, G\rangle,(G, F))
$$

For simplicity, we will now introduce the following notation.
Definition 2.12. Let $F, G \in \operatorname{Mod}\left(S_{g}\right)$ be of finite order. Then for some $k \in \mathbb{Z}_{n}^{\times} \backslash\{1\}$, we say (in symbols) that $\llbracket F, G \rrbracket_{k}=1$ if there exists conjugates $F^{\prime}, G^{\prime}$ (of $F, G$ resp.) such that $\left(F^{\prime}\right)^{-1} G^{\prime} F^{\prime}=\left(G^{\prime}\right)^{k}$.

We conclude this subsection with the following crucial remark.
Remark 2.13. Let $H<\operatorname{Mod}\left(S_{g}\right)$ be a finite split metacyclic subgroup, and let $I(H)$ denote the isomorphism class of $H$. By Remark 2.11, we have $I(H)=\left\{H^{\prime}: H^{\prime} \cong H\right.$ and $\left(H^{\prime},\left(G^{\prime}, F^{\prime}\right)\right)$ represents a weak conjucacy class for some $F^{\prime}, G^{\prime} \in H^{\prime}$ such that $\left.H=\left\langle F^{\prime}, G^{\prime}\right\rangle\right\}$.
Consequently, periodic mapping classes $F, G \in \operatorname{Mod}\left(S_{g}\right)$ satisfy $\llbracket F, G \rrbracket_{k}=1$ if and only if there exists conjugates $F^{\prime}, G^{\prime}$ (of $F, G$ resp.) such that the triple ( $\left\langle F^{\prime}, G^{\prime}\right\rangle, G^{\prime}, F^{\prime}$ ) represents a weak conjugacy class of a finite split metacyclic subgroups (of twist factor $k$ ) of $\operatorname{Mod}\left(S_{g}\right)$.

## 3. Main theorem

In this section, we establish the main result of the paper by deriving equivalent conditions under which torsion elements $F, G \in \operatorname{Mod}\left(S_{g}\right)$ would satisfy $\llbracket F, G \rrbracket_{k}=1$. We will introduce an abstract tuple of integers that will capture the weak conjugacy class of a finite split metacyclic subgroup of $\operatorname{Mod}\left(S_{g}\right)$.

Definition 3.1. A split metacyclic data set of degree $m \cdot n$, twist factor $k$, and genus $g \geq 2$ is a tuple

$$
\left((m \cdot n, k), g_{0} ;\left[\left(c_{11}, n_{11}\right),\left(c_{12}, n_{12}\right), n_{1}\right], \cdots,\left[\left(c_{\ell 1}, n_{\ell 1}\right),\left(c_{\ell 2}, n_{\ell 2}\right), n_{\ell}\right]\right)
$$

where $m, n \geq 2$, the $n_{i j}$ are positive integers for $1 \leq i \leq \ell, 1 \leq j \leq 2$, the $c_{i j} \in \mathbb{Z}_{n_{i j}}^{\times}$, and $k \in \mathbb{Z}_{n}^{\times}$such that $k^{m} \equiv 1(\bmod n)$, satisfying the following conditions.
(i) $\frac{2 g-2}{m n}=2 g_{0}-2+\sum_{i=1}^{\ell}\left(1-\frac{1}{n_{i}}\right)$.
(ii) (a) For each $i, j, n_{i 1}\left|m, n_{i 2}\right| n$, either $\operatorname{gcd}\left(c_{i j}, n_{i j}\right)=1$ or $c_{i j}=0$, and $c_{i j}=0$ if and only if $n_{i j}=1$.
(b) For each $i, n_{i}=n_{i 1} \cdot \beta_{i}$, where $\beta_{i}$ is least positive integer such that

$$
\sum_{i^{\prime}=0}^{\gamma_{i}} k^{c_{i 1} \frac{m}{n_{i 1}} i^{\prime}} \equiv 0 \quad(\bmod n)
$$

where $\gamma_{i}=c_{i 2} \frac{n}{n_{i 2}} n_{i 1} \beta_{i}-1$.
(iii) $\sum_{i=1}^{\ell} c_{i 1} \frac{m}{n_{i 1}} \equiv 0(\bmod m)$.
(iv) Defining $A:=\sum_{i=1}^{\ell} c_{i 2} \frac{n}{n_{i 2}} \prod_{s=i+1}^{\ell} k^{c_{s 1} \frac{m}{n_{s 1}}}$ and $d:=(n, k-1)$, we have

$$
A \equiv \begin{cases}0 & (\bmod n), \\ d \theta \quad(\bmod n), \text { for } \theta \in \mathbb{Z}_{n}, & \text { if } g_{0}=0, \text { and }\end{cases}
$$

(v) If $g_{0}=0$, there exists $\left(p_{1}, \ldots, p_{\ell v}\right),\left(q_{1}, \ldots, q_{\ell v}\right) \in \mathbb{Z}^{\ell v}$ and $v \in \mathbb{N}$ such that the following conditions hold.
(a) $\sum_{i^{\prime}=1}^{\ell v} p_{i^{\prime}} c_{i 1} \frac{m}{n_{i 1}} \equiv 1(\bmod m)$ and $\sum_{i^{\prime}=1}^{\ell v} c_{i 2} \frac{n}{n_{i 2}}\left(\sum_{s=1}^{p_{i^{\prime}}} k^{c_{i 1} \frac{m}{n_{i 1}}\left(p_{i^{\prime}}-s\right)}\right)\left(\prod_{t^{\prime}=i^{\prime}+1}^{\ell v} k^{c_{t 1} \frac{m}{n_{t 1}}}\right) \equiv 0 \quad(\bmod n)$.
(b) $\sum_{i^{\prime}=1}^{\ell v} q_{i^{\prime}} c_{i 1} \frac{m}{n_{i 1}} \equiv 0(\bmod m)$ and $\sum_{i^{\prime}=1}^{\ell v} c_{i 2} \frac{n}{n_{i 2}}\left(\sum_{s=1}^{q_{i^{\prime}}} k^{c_{i 1} \frac{m}{n_{i 1}}\left(q_{i^{\prime}}-s\right)}\right)\left(\prod_{t^{\prime} i^{\prime}+1}^{\ell v} k^{c_{11} \frac{m}{n_{t 1}}}\right) \equiv 1 \quad(\bmod n)$, where $i \equiv\left\{\begin{array}{ll}i^{\prime}(\bmod \ell), & \text { if } i^{\prime} \neq a \ell, \\ \ell & \text { otherwise },\end{array} t \equiv \begin{cases}t^{\prime}(\bmod \ell), & \text { if } t^{\prime} \neq a \ell, \text { and } \\ \ell, & \text { otherwise. }\end{cases}\right.$
(vi) If $g_{0}=1$, there exists $\left(p_{1}, \ldots, p_{\ell v}\right),\left(q_{1}, \ldots, q_{\ell v}\right) \in \mathbb{Z}^{\ell v}$ and $m^{\prime}, n^{\prime} \in$ $\mathbb{Z}, v \in \mathbb{N}$ such that $m^{\prime} \mid m$ and $n^{\prime} \mid n$, satisfying the following conditions.

$$
\begin{aligned}
& \text { (a) } \sum_{i^{\prime}=1}^{\ell v} p_{i^{\prime}} c_{i 1} \frac{m}{n_{i 1}} \equiv m^{\prime}(\bmod m) \text { and } \\
& \sum_{i^{\prime}=1}^{\ell v} c_{i 2} \frac{n}{n_{i 2}}\left(\sum_{s=1}^{p_{i^{\prime}}} k^{c_{i 12} \frac{m}{n_{i 1}}\left(p_{i^{\prime}}-s\right)}\right)\left(\prod_{t^{\prime}=i^{\prime}+1}^{\ell v} k^{c_{t 1} \frac{m}{n_{t 1}}}\right) \equiv 0 \quad(\bmod n) .
\end{aligned}
$$

(b) $\sum_{i^{\prime}=1}^{\ell v} q_{i^{\prime}} c_{i 1} \frac{m}{n_{i 1}} \equiv 0(\bmod m)$,
$\sum_{i^{\prime}=1}^{\ell v} c_{i 2} \frac{n}{n_{i 2}}\left(\sum_{s=1}^{q_{i^{\prime}}} k^{c_{i 1} \frac{m}{n_{i 1}}\left(q_{i^{\prime}}-s\right)}\right)\left(\prod_{t^{\prime}=i^{\prime}+1}^{\ell v} k^{c_{t 1} \frac{m}{n_{t 1}}}\right) \equiv n^{\prime} \quad(\bmod n)$,
where
$i \equiv\left\{\begin{array}{ll}i^{\prime} & (\bmod \ell), \\ \ell, & \text { if } i^{\prime} \neq a \ell, \\ \ell, & \text { otherwise },\end{array} t \equiv\left\{\begin{array}{lll}t^{\prime}(\bmod \ell) & \text { if } t^{\prime} \neq a \ell, \text { and } \\ \ell & \text { otherwise. }\end{array}\right.\right.$
(c) Denoting $d_{1}=\operatorname{gcd}\left(m / m^{\prime}, m^{\prime}\right)$ and $d_{2}=\operatorname{gcd}\left(n / n^{\prime}, n^{\prime}\right)$, we have $A \equiv-\beta k^{\alpha}+\beta(\bmod n)$, where $\alpha\left|\frac{m}{m^{\prime} d_{1}}, \beta\right| \frac{n}{n^{\prime} d_{2}}$, and we take $\alpha=1$, when $m^{\prime}=0$, and $\beta=1$, when $n^{\prime}=0$.

We will now show that the split metacyclic data sets of genus $g$ are in one-to-one with the weak conjugacy classes of split metacyclic subgroups of $\operatorname{Mod}\left(S_{g}\right)$.

Proposition 3.2. For integers $n, m, g \geq 2$, the split metacyclic data sets of degree $m \cdot n$ with twist factor $k$ and genus $g$ correspond to the weak conjugacy classes of $\mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$-actions on $S_{g}$.

Proof. Let $\mathcal{D}$ be a split metacyclic data set of degree $m \cdot n$ with twist factor $k$ and genus $g$ (as in Definition 3.1 above). We need to show that $\mathcal{D}$ corresponds to the weak conjugacy class of a $\mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$-action on $S_{g}$ represented by $(H,(\mathcal{G}, \mathcal{F}))$. To this effect, we first establish the existence of a order-preserving epimorphism $\phi_{H}: \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H$. Let the presentations of $H$ and $\Gamma\left(\mathcal{O}_{H}\right)$ be given by

$$
\begin{gathered}
\mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}=\left\langle\mathcal{F}, \mathcal{G} \mid \mathcal{F}^{n}=\mathcal{G}^{m}=1, \mathcal{G}^{-1} \mathcal{F} \mathcal{G}=\mathcal{F}^{k}\right\rangle \text { and } \\
\left\langle\alpha_{1}, \beta_{1}, \cdots, \alpha_{g_{0}}, \beta_{g_{0}}, \xi_{1}, \cdots, \xi_{\ell} \mid \xi_{1}^{n_{1}}=\cdots=\xi_{\ell}^{n_{\ell}}=\prod_{i=1}^{\ell} \xi_{i} \prod_{i=1}^{g_{0}}\left[\alpha_{i}, \beta_{i}\right]=1\right\rangle
\end{gathered}
$$

respectively. We consider the map

$$
\xi_{i} \stackrel{\phi_{H}}{\longrightarrow} \mathcal{G}^{c_{i 1} \frac{m}{n_{i 1}}} \mathcal{F}^{c_{i 2} \frac{n}{n_{i 2}}}, \text { for } 1 \leq i \leq \ell .
$$

As $\left|\mathcal{G}^{c_{i 1} \frac{m}{n_{i 1}}}\right|=n_{i 1}$ and $\left|\mathcal{F}^{c_{i 2} \frac{n}{n_{i 2}}}\right|=n_{i 2}$, condition (ii) of Definition 3.1 would imply that $\phi_{H}$ is an order-preserving map. For clarity, we break the argument for the surjectivity of $\phi_{H}$ into three cases.

First, we consider the case when $g_{0}=0$. Conditions (iii) and (iv) show that $\phi_{H}$ satisfies the long relation $\prod_{i=1}^{\ell} \xi_{i}=1$ and the surjectivity of $\phi_{H}$ follows from condition (v).

When $g_{0} \geq 2, \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right)$ has additional hyperbolic generators (viewing them as isometries of the hyperbolic plane), namely the $\alpha_{i}$ and the $\beta_{i}$. Extending $\phi_{H}$ by mapping $\alpha_{1} \xrightarrow{\phi_{H}} G, \beta_{1} \xrightarrow{\phi_{H}} F$ yields an epimorphism. Moreover, by carefully choosing the $\alpha_{i}$ and the $\beta_{i}$, for $i \geq 2$, conditions (iii) and (iv) would together ensure that the long relation $\prod_{i=1}^{\ell} \xi_{i} \prod_{i=1}^{g_{0}}\left[\alpha_{i}, \beta_{i}\right]=1$ is satisfied.

When $g_{0}=1, \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right)$ has two additional hyperbolic generators, namely the $\alpha_{1}$ and the $\beta_{1}$. We extend $\phi_{H}$ by defining $\alpha_{1} \stackrel{\phi_{H}}{\longmapsto} G^{\alpha}$ and $\beta_{1} \stackrel{\phi_{H}}{\longmapsto} \mathcal{F}^{\beta}$, and apply conditions (iv) and (vi) to obtain the desired epimorphism.

It remains to show that $\mathcal{D}$ determines $\mathcal{F}, \mathcal{G} \in \operatorname{Homeo}^{+}\left(S_{g}\right)$ up to conjugacy (i.e. condition (iii) of Definition 2.10). Let $D_{\bar{G}}=\left(m, g_{0} ;\left(c_{11}, n_{11}\right), \ldots,\left(c_{\ell 1}, n_{\ell 1}\right)\right)$ represent the conjugacy class of the action $\overline{\mathcal{G}}$ induced on the orbifold $\mathcal{O}_{\langle\mathcal{F}\rangle}$ by the action $\mathcal{G} \in \operatorname{Homeo}^{+}\left(S_{g}\right)$. We note that by Lemma 2.9, $\Gamma\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ has the form

$$
(g_{1} ; \underbrace{\frac{n_{1}}{n_{11}}, \ldots \frac{n_{1}}{n_{11}}}_{\frac{m}{n_{11}} \text { times }}, \ldots, \underbrace{\frac{n_{r}}{n_{r 1}}, \ldots, \frac{n_{\ell}}{n_{\ell 1}}}_{\frac{m}{n_{\ell 1}} \text { times }})
$$

where if $n_{i} / n_{i 1}=1$, for some $1 \leq i \leq \ell$, then we exclude it from the signature, and $g_{1}=g\left(D_{\bar{G}}\right)$ is determined by Equation (3) of Definition 2.2,

So, we get

$$
\begin{gathered}
D_{F}=\left(n, g_{1} ;\left(d_{11}, \frac{n_{1}}{n_{11}}\right), \ldots,\left(d_{1 \frac{m}{n_{11}}}, \frac{n_{1}}{n_{11}}\right), \ldots,\right. \\
\left.\left(d_{\ell 1}, \frac{n_{\ell}}{n_{\ell 1}}\right), \ldots,\left(d_{\ell \frac{m}{n_{11}}}, \frac{n_{\ell}}{n_{\ell 1}}\right)\right)
\end{gathered}
$$

where

$$
\begin{gathered}
d_{i 1} n_{i 1} \equiv c_{i 2} \frac{n}{n_{i 2}} \sum_{j^{\prime}=1}^{n_{i 1}} k^{c_{i 1} \frac{m}{n_{i 1}}\left(j^{\prime}-1\right)}(\bmod n), \\
d_{i j_{i}} \equiv d_{i 1} k^{\gamma\left(j_{i}-1\right)} \quad\left(\bmod \frac{n_{i}}{n_{i 1}}\right) 1 \leq i \leq l, 1 \leq j_{i} \leq \frac{m}{n_{i 1}},
\end{gathered}
$$

and $\gamma$ is the least positive integer such that $|k| \left\lvert\, \gamma \frac{m}{n_{i 1}}\right.$. Moreover, by applying Lemma 2.4, we see that

D_{G}=\left(m, g_{2} ;\left(\left(u_{i j}, m_{i}\right), \frac{m_{i}\left|\mho_{\mathcal{G}}^{\frac{m}{m_{i}}}\left(u_{i j}, m_{i}\right)\right|}{m}\right): u_{i j} \in \mathbb{Z}_{m_{i}}^{\times}, m_{i} \mid m,\right. \\
\text { and } \left.\operatorname{gcd}\left(u_{i j}, m_{i}\right)=1\right),
\end{gathered}
$$

where

$$
\left|\mho_{\mathcal{G}^{\frac{m}{m_{i}}}}\left(u_{i j}, m_{i}\right)\right|=\left|\mathbb{F}_{\mathcal{G}^{\frac{m}{m_{i}}}}\left(u_{i j}, m_{i}\right)\right|-\sum_{\substack{m_{i^{\prime}} \in \mathbb{N} \\ m_{i^{\prime}} \prime m_{i} \\ m_{i}\left|m_{i}\right| u_{i j}}} \sum_{\substack{\left(u_{i j}=u^{\prime} j^{\prime}, m_{i^{\prime}}, j^{\prime}\right)=1 \\ i^{\prime}}}\left|\mathcal{m o d}_{\left.\mathcal{G}^{\prime}\right)} \frac{m}{m_{i^{\prime}}}\left(u_{i^{\prime} j^{\prime}}, m_{i^{\prime}}\right)\right|
$$

and $g_{2}$ is determined by Equation (3) of Definition 2.2.
Conversely, consider the weak conjugacy class of $\mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$-actions on $S_{g}$ represented by $(H,(G, F))$, where $H=\langle\mathcal{F}, \mathcal{G}\rangle$. So, Lemma 2.1 would imply that there exists a surjective homomorphism

$$
\phi_{H}: \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H: \xi_{i} \xrightarrow{\phi_{H}} \mathcal{G}^{c_{i 1} \frac{m}{n_{i 1}}} \mathcal{F}^{c_{i 2} \frac{n}{n_{i 2}}}, \text { for } 1 \leq i \leq \ell,
$$

which is order-preserving on the torsion elements. This yields a split metacyclic data set of degree $m \cdot n$ with twist factor $k$ and genus $g$ as in Definition 3.1. By Lemma 2.1, this tuple satisfies condition (i) of Definition 3.1, while condition (ii) follows from the fact that $\phi_{H}$ is order-preserving on torsion elements. Conditions (iii)-(iv) follow from the long relation satisfied by $\pi_{1}^{\text {orb }}\left(\mathcal{O}_{H}\right)$, and condition (v)-(vi) are implied by the surjectivity of $\phi_{H}$. Thus, we obtain the split metacyclic data set of degree $m \cdot n$ with twist factor $k$ and genus $g$, and the result follows.

We denote the data sets $D_{F}$ and $D_{G}$ (representing the cyclic factors of $H)$ derived from the split metacyclic data set $\mathcal{D}$ appearing in the proof of Proposition 3.2 by $\mathcal{D}_{1}$ and $\mathcal{D}_{2}$, respectively. Thus, our main theorem will now follow from Remark 2.13 and Proposition 3.2,
Theorem 3.3 (Main theorem). Let $F, G \in \operatorname{Mod}\left(S_{g}\right)$ be of orders $n, m$, respectively. Then $[[F, G]]_{k}=1$ if and only if there exists a split metacyclic data set $\mathcal{D}$ of degree $m \cdot n$, twist factor $k$, and genus $g$ such that $\mathcal{D}_{1}=D_{F}$ and $\mathcal{D}_{2}=D_{G}$.

We conclude this section with an example of a split metacyclic action of order 16 on $S_{5}$.

Example 3.4. The split metacyclic data set $\mathcal{D}=((4 \cdot 4,-1), 1 ;[(0,1),(1,2), 2])$ encodes the weak conjugacy class of a $\mathbb{Z}_{4} \rtimes_{-1} \mathbb{Z}_{4}$-action on $S_{5}$ represented by $(\langle\mathcal{F}, \mathcal{G}\rangle,(\mathcal{G}, \mathcal{F}))$, where

$$
D_{F}=(4,1 ;(1,2),(1,2),(1,2),(1,2)) \text { and } D_{G}=(4,2,1 ;)
$$

The geometric realization of this action is illustrated in Figure 2 below.


Figure 2. Realization of a $\mathbb{Z}_{4} \rtimes_{-1} \mathbb{Z}_{4}$-action in $\operatorname{Mod}\left(S_{5}\right)$.

Note that the pairs of integers appearing in Figure 2 represent the compatible orbits involved in the realization of $\mathcal{F}$. Here, the action $\mathcal{F}$ is realized via two 1-compatibilities between the action $\mathcal{F}^{\prime}$ on two copies of $S_{2}$ with $D_{F^{\prime}}=(4,0 ;((1,2), 2),(1,4),(3,4))$. Furthermore, the action $\mathcal{F}^{\prime}$ is realized by a 1 -compatibility between the action $\mathcal{F}^{\prime \prime}$ on two copies of $S_{1}$ with $D_{F^{\prime \prime}}=(4,0 ;(1,2),(1,4),(3,4))$.

## 4. Applications

4.1. Dihedral groups. Let $D_{2 n}=\mathbb{Z}_{n} \rtimes_{-1} \mathbb{Z}_{2}$ be the dihedral group of order $2 n$. We will call a split metacyclic data set of degree $2 \cdot n$ and twist factor -1 a dihedral data set. A simple computation reveals that a dihedral data set

$$
\left((2 \cdot n,-1), g_{0} ;\left[\left(c_{11}, n_{11}\right),\left(c_{12}, n_{12}\right), n_{1}\right], \cdots,\left[\left(c_{\ell 1}, n_{\ell 1}\right),\left(c_{\ell 2}, n_{\ell 2}\right), n_{\ell}\right]\right)
$$

would have the property that $\left(c_{j 1}, n_{j 1}\right) \in\{(0,1),(1,2)\}$, for $1 \leq j \leq \ell$. The following is an immediate consequence of Proposition 3.2.

Corollary 4.1. For $g \geq 2$ and $n \geq 3$, dihedral data sets of degree $2 \cdot n$ and genus $g$ correspond to the weak conjugacy classes of $D_{2 n}$-actions on $S_{g}$.

The following proposition provides an alternative characterization of a $D_{2 n^{-}}$ action in terms of the generator of its factor subgroup of order $n$.

Proposition 4.2. Let $F \in \operatorname{Mod}\left(S_{g}\right)$ be of order $n$. Then there exists an involution $G \in \operatorname{Mod}\left(S_{g}\right)$ such that $\langle F, G\rangle \cong D_{2 n}$ if and only if $D_{F}$ has the form

$$
\begin{equation*}
\left(n, g_{0}, r ;\left(\left(c_{1}, n_{1}\right),\left(-c_{1}, n_{1}\right), \ldots,\left(c_{s}, n_{s}\right),\left(-c_{s}, n_{s}\right)\right)\right. \tag{*}
\end{equation*}
$$

Proof. Suppose that $D_{F}$ has the form (*). Then $\mathcal{O}_{\langle\mathcal{F}\rangle}$ is an orbifold of genus $g_{0}$ with $2 s$ cone points $\left[x_{1}\right],\left[y_{1}\right], \ldots,\left[x_{s}\right],\left[y_{s}\right]$, where $\mathcal{P}_{x_{i}}=\left(c_{i}, n_{i}\right)$ and $\mathcal{P}_{y_{i}}=\left(-c_{i}, n_{i}\right)$, for $1 \leq i \leq s$. Up to conjugacy, let $\overline{\mathcal{G}} \in \operatorname{Aut}_{k}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ be the hyperelliptic involution so that $\overline{\mathcal{G}}\left(\left[x_{i}\right]\right)=\left[y_{i}\right]$, for $1 \leq i \leq s$. To prove our assertion, it would suffice to show the existence of an involution $\mathcal{G} \in \mathrm{Homeo}^{+}\left(S_{g}\right)$ that induces $\bar{G}$. This amounts to showing that there exists a split metacyclic data set $\mathcal{D}$ of degree $2 \cdot n$ with twist factor -1 encoding the weak conjugacy class $(H,(\mathcal{G}, \mathcal{F}))$ so that $D_{G}$ has degree 2 . Consider the tuple

$$
\begin{gathered}
\mathcal{D}=((2 \cdot n,-1), 0 ; \underbrace{[(1,2),(0,1), 2], \ldots,[(1,2),(0,1), 2]}_{t-2 \text { times }},\left[(1,2),\left(c_{(t-1) 2}, n_{(t-1) 2}\right), 2\right] \\
\left.\left[(1,2),\left(c_{t 2}, n_{t 2}\right), 2\right],\left[(0,1),\left(c_{1}, n_{1}\right), n_{1}\right], \ldots,\left[(0,1),\left(c_{s}, n_{s}\right), n_{s}\right]\right)
\end{gathered}
$$

where $t=2 g_{0}+2$,
$\left(\left(c_{(t-1) 2}, n_{(t-1) 2}\right),\left(c_{t 2}, n_{t 2}\right)\right)= \begin{cases}\left((0,1),\left(1,-\sum_{i=1}^{s} c_{i} \frac{n}{n_{i}}(\bmod n)\right)\right), & \text { if } g_{0}=0, \text { and } \\ \left((1, n),\left(1,1-\sum_{i=1}^{s} c_{i} \frac{n}{n_{i}}(\bmod n)\right)\right), & \text { if } g_{0}>0 .\end{cases}$
It follows immediately that $\mathcal{D}$ satisfies conditions (i)-(iv) of Definition 3.1. As $t \geq 2$, by taking $v=1$, we may choose $\left(p_{1}, \ldots, p_{t+s}\right)=(1,0, \ldots, 0)$ to conclude that $\mathcal{D}$ also satisfies condition (v)(a). Since $t=2 \Longleftrightarrow g_{0}=0$, and when $g_{0}=0$, we have that $\operatorname{lcm}\left(n_{1}, \ldots, n_{s}\right)=n$, from which condition $(\mathrm{v})(\mathrm{b})$ follows. Finally, for the case when $g_{0} \neq 0,(\mathrm{v})(\mathrm{b})$ follows by choosing $\left(q_{1}, \ldots, q_{t-2}, q_{t-1}, \ldots, q_{t+s}\right)=(0, \ldots,-1,1, \ldots, 0)$. Thus, it follows that $\mathcal{D}$ is a split metacyclic data set. Further, a direct application of Theorem 3.3 would show that $\mathcal{D}$ indeed encodes the weak conjugacy represented by $(H,(\mathcal{G}, \mathcal{F}))$, as desired.

The converse follows immediately from Remark 2.11 and Proposition 3.2,

We now provide a couple of examples of dihedral actions along with their realizations.

Example 4.3. Consider the $\mathbb{Z}_{3} \rtimes_{-1} \mathbb{Z}_{2}$-action $\langle\mathcal{F}, \mathcal{G}\rangle$ on $S_{3}$ illustrated in Figure 3 below, where

D_{F}=(3,1 ;(1,3),(2,3)) \text { and } D_{G}=(2,1 ;(1,2),(1,2),(1,2),(1,2))
$$



Figure 3. Realization of a $D_{6}$-action in $\operatorname{Mod}\left(S_{3}\right)$.

The weak conjugacy class of the action $(\langle\mathcal{F}, \mathcal{G}\rangle,(\mathcal{G}, \mathcal{F}))$ is encoded by

$$
\begin{gathered}
\mathcal{D}=((2 \cdot 3,-1), 0 ;[(1,2),(0,1), 2],[(1,2),(0,1), 2],[(1,2),(0,1), 2], \\
[(1,2),(1,3), 2],[(0,1),(2,3), 3]) .
\end{gathered}
$$

Example 4.4. Consider the $\mathbb{Z}_{4} \rtimes_{-1} \mathbb{Z}_{2}$-actions $\langle\mathcal{F}, \mathcal{G}\rangle$ and $\left\langle\mathcal{F}, \mathcal{G}^{\prime}\right\rangle$ on $S_{3}$ illustrated in Figure 4 below, where $D_{F}=(4,0 ;(1,4),(3,4),(1,4),(3,4))$, $D_{G}=(2,1 ;(1,2),(1,2),(1,2),(1,2))$, and $D_{G^{\prime}}=(2,2,1 ;)$.


Figure 4. Realization of a $D_{8}$-action in $\operatorname{Mod}\left(S_{3}\right)$.

The weak conjugacy classes $(\langle\mathcal{F}, \mathcal{G}\rangle,(\mathcal{G}, \mathcal{F}))$ (resp. $\left(\left\langle\mathcal{F}, \mathcal{G}^{\prime}\right\rangle,\left(\mathcal{G}^{\prime}, \mathcal{F}\right)\right)$ ) are encoded by
$((2 \cdot 4,-1), 0 ;[(1,2),(0,1), 2],[(1,2),(0,1), 2],[(0,1),(1,4), 4],[(0,1),(3,4), 4])$ and
$((2 \cdot 4,-1), 0 ;[(1,2),(1,4), 2],[(1,2),(1,4), 2],[(0,1),(1,4), 4],[(0,1),(3,4), 4])$, respectively.
4.2. Generalized quaternions. For $n \geq 2$, the generalized quaternion group $Q_{2^{n+1}}$ is a metacyclic group of order $2^{n+1}$ that admits the presentation

$$
\left\langle x, y \mid x^{2^{n}}=y^{4}=1, x^{2^{n-1}}=y^{2}, y^{-1} x y=x^{-1}\right\rangle .
$$

Remark 4.5. Let $\mathcal{D}$ be a split metacyclic data set of genus $g$, degree $4 \cdot 2^{n}$ and twist factor -1 (as in Definition (3.1) encoding a weak conjugacy class represented by $(H,(\mathcal{G}, \mathcal{F}))$. Suppose that $\mathcal{D}$ has the property that $\left[\left(c_{j 1}, n_{j 1}\right),\left(c_{j 2}, n_{j 2}\right), n_{j}\right]=[(1,2),(1,2), 2]$, for some $1 \leq j \leq \ell$. Then it follows from the proof of Proposition 3.2 that under the order-preserving epimorphism $\phi_{H}: \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H$, the tuple $[(1,2),(1,2), 2]$ would correspond to an involution $\mathcal{G}^{2} \mathcal{F}^{2^{n-1}} \in H$ which defines a non-free action on $S_{g}$.

Remark 4.5 motivates the following definition.

Definition 4.6. A quaternionic data set is a split metacyclic data set of degree $2^{n+2}$ that has the form

$$
\mathcal{D}=\left(\left(4 \cdot 2^{n},-1\right), g_{0} ;\left[\left(c_{11}, n_{11}\right),\left(c_{12}, n_{12}\right), n_{1}\right], \ldots,\left[\left(c_{\ell 1}, n_{\ell 1}\right),\left(c_{\ell 2}, n_{\ell 2}\right), n_{\ell}\right]\right)
$$

such that $\left[\left(c_{j 1}, n_{j 1}\right),\left(c_{j 2}, n_{j 2}\right), n_{j}\right] \neq[(1,2),(1,2), 2]$, for $1 \leq j \leq \ell$.
Proposition 4.7. For $g, n \geq 2$, quaternionic data sets of genus $2 g-1$ correspond to $Q_{2^{n+1}-a c t i o n s ~ o n ~} S_{g}$.
Proof. Suppose that there exists an action of $H=Q_{2^{n+1}}$ on $S_{g}$. By Lemma 2.1, there exists an epimorphism $\pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H$

$$
\xi_{i} \stackrel{\phi_{H}}{\longrightarrow} y^{c_{i 1} \frac{m}{n_{i 1}}} x^{c_{i 2} \frac{n}{n_{i 2}}}, \text { for } 1 \leq i \leq \ell
$$

that is order-preserving on torsion elements. Let $H^{\prime}=\mathbb{Z}_{2^{n}} \rtimes_{-1} \mathbb{Z}_{4}$. Since the canonical projection $q: H^{\prime} \rightarrow H\left(\cong H^{\prime} / \mathbb{Z}_{2}\right)$ is order-preserving on $H^{\prime} \backslash \operatorname{ker} q$, the map $\phi_{H}$ naturally factors via $q$. Thus, we obtain two possible choices for an order-preserving epimorphism $\pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H^{\prime}$, of which exactly one yields an action $H^{\prime}$ on $S_{g^{\prime}}$ (for some $g^{\prime}>g$ ). The weak conjugacy class of this action is encoded by a split metacyclic data set of genus $g^{\prime}$ and degree $2^{n+2}=4 \cdot 2^{n}$, which has one of the following forms

$$
\begin{gathered}
\left(\left(4 \cdot 2^{n},-1\right), g_{0} ;\left[\left(c_{11}, n_{11}\right),\left(c_{12}, n_{12}\right), n_{1}\right], \ldots,\left[\left(c_{\ell 1}, n_{\ell 1}\right),\left(c_{\ell 2}, n_{\ell 2}\right), n_{\ell}\right]\right) \\
\text { or } \\
\left.\left(4 \cdot 2^{n},-1\right), g_{0} ;\left[\left(c_{11}, n_{11}\right),\left(c_{12}, n_{12}\right), n_{1}\right], \ldots,\left[\left(c_{\ell 1}^{\prime}, n_{\ell 1}^{\prime}\right),\left(c_{\ell 2}^{\prime}, n_{\ell 2}^{\prime}\right), n_{\ell}\right]\right)
\end{gathered}
$$

where $c_{\ell 1}^{\prime} \frac{4}{n_{\ell 1}^{\prime}} \equiv c_{\ell 1} \frac{4}{n_{\ell 1}}+2(\bmod 4)$ and $c_{\ell 2}^{\prime} \frac{2^{n}}{n_{\ell 2}^{\prime}} \equiv c_{\ell 2} \frac{2^{n}}{n_{\ell 2}}+2^{n-1}\left(\bmod 2^{n}\right)$. Further, since $\operatorname{ker} q \cong \mathbb{Z}_{2}$ and $q$ preserves the orders of all $x \in H^{\prime} \backslash \operatorname{ker} q$, it follows that $\operatorname{ker} q$ acts freely on $S_{g^{\prime}}$. Hence, it follows that $g^{\prime}=2 g-1$ and further by Remark 4.5, both (possible) tuples cannot contain a triple of the type $[(1,2),(1,2), 2]$.

Conversely, if there exists a quaternionic data set $\mathcal{D}$ of genus $g^{\prime}=2 g-1$ as in Definition 4.6. Then we obtain an order-preserving epimorphism $\phi_{H^{\prime}}$ : $\pi_{1}^{o r b}\left(\mathcal{O}_{H^{\prime}}\right) \rightarrow H^{\prime}$, which when composed with canonical projection $q: H^{\prime} \rightarrow$ $H$, yields an order-preserving epimorphism $\phi_{H}: \pi_{1}^{o r b}\left(\mathcal{O}_{H}\right) \rightarrow H$. Further, as $\mathcal{D}$ does not contain a triple of type $[(1,2),(1,2), 2]$, $\operatorname{ker} q$ acts freely on $S_{g^{\prime}}$, thereby yielding an action of $Q_{2^{n+1}}$ on $S_{g}$, where $g^{\prime}=2 g-1$.

Example 4.8. The split metacyclic data set in Example 3.4 is quaternionic. Hence, this represents the weak conjugacy class of an induced $Q_{8}$-action on $S_{3}$.
4.3. Lifting cyclic subgroups of mapping classes to split metacyclic groups. For $n, g \geq 2$, let $p: S_{\tilde{g}} \rightarrow S_{g}$ be a covering map (that is possibly branched) with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Let $\operatorname{LMod}_{p}\left(S_{g}\right)$ (resp. $\operatorname{SMod}\left(S_{g}\right)$ ) denote the liftable (resp. symmetric) mapping class groups of $S_{g}$ under $p$.

Remark 4.9. The Birman exact sequence [2] in this setting takes the form

$$
\begin{equation*}
1 \rightarrow\langle F\rangle \rightarrow \operatorname{SMod}_{p}\left(S_{\tilde{g}}\right) \rightarrow \operatorname{LMod}_{p}\left(S_{g}\right) \rightarrow 1 \tag{B}
\end{equation*}
$$

Let $G \in \operatorname{Mod}\left(S_{g}\right)$ be of finite order. Then $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ if and only if $G$ has a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{\tilde{g}}\right)$ of finite order so that the sequence $(B)$ yields a sequence of the form

$$
1 \rightarrow\langle F\rangle \rightarrow\langle F, \tilde{G}\rangle \rightarrow\langle G\rangle \rightarrow 1
$$

Thus, $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ if and only if for any lift $\tilde{G}$ of $G,\langle G\rangle$ lifts under $p$ to a metacyclic group $\langle F, \tilde{G}\rangle$.
In the following corollary, we characterize the periodic elements in $\operatorname{Mod}\left(S_{0,3}\right)$ that generate cyclic groups that lift to finite split metacyclic groups under branched covers induced by irreducible cyclic actions.
Corollary 4.10. For $g, n \geq 2$, let $p: S_{g} \rightarrow S_{0,3}$ be a cover with deck transformation group $\langle\mathcal{F}\rangle$ with $D_{F}=\left(n, 0 ;\left(c_{1}, n_{1}\right),\left(c_{2}, n_{2}\right),\left(c_{3}, n_{3}\right)\right)$. Then a $G^{\prime} \in \operatorname{Mod}\left(S_{0,3}\right)$ of order $m$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{0,3}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{g}\right)$ such that $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$ if and only if one of the following conditions hold.
(a) $D_{F}=\left(n, 0 ;\left(c_{1}, n_{1}\right),\left(c_{2}, n\right),\left(c_{2} k, n\right)\right)$ for some $k \in \mathbb{Z}_{n}^{\times}$such that $k^{2} \equiv 1$ $(\bmod n)$.
(b) $D_{F}=\left(n, 0 ;\left(c_{1}, n\right),\left(c_{1} k, n\right),\left(c_{1} k^{2}, n\right)\right)$ for some $k \in \mathbb{Z}_{n}^{\times}$such that $k^{3} \equiv 1$ $(\bmod n)$.
Proof. Suppose that $G^{\prime} \in \operatorname{Mod}\left(S_{0,3}\right)$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{0,3}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{g}\right)$ such that $H=\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$. First, we claim that the $n_{i}$, for $1 \leq i \leq 3$, are not distinct. Suppose that we assume on the contrary that the $n_{i}$ are indeed distinct. Since $\mathcal{G}^{\prime} \in \operatorname{Aut}_{k}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ and $\left|\mathcal{G}^{\prime}\right|>1$, it would have to fix all three cone points of $\mathcal{O}_{\langle\mathcal{F}\rangle}$, which contradicts the fact that any homeomorphism on a sphere can fix at most two points. Thus, the following two cases arise.

Case 1: $n_{2}=n_{3}=n \neq n_{1}$. In this case, $\mathcal{G}^{\prime}$ fixes the cone point, say of order $n_{1}$, and should permute the remaining 2 cone points of orders $n_{2}$ and $n_{3}$. This implies that $D_{F}$ takes the form in condition (a) in our hypothesis (by Definition [2.8), and hence $H=\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{2}$.

Case 2: $n_{i}=n, 1 \leq i \leq 3$. In this case, if $\mathcal{G}^{\prime}$ permutes all the three cone points cyclically, then $D_{F}$ takes the form in condition (b) in our hypothesis, and hence $H \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{3}$. Alternatively, $\mathcal{G}^{\prime}$ could also fix a cone point of order $n$ and permute the remaining 2 cone points, in which case, $D_{F}$ will take the form in condition (a).

Conversely, if $D_{F}=\left(n, 0 ;\left(c_{1}, n_{1}\right),\left(c_{2}, n\right),\left(c_{2} k, n\right)\right)$ for some $k \in \mathbb{Z}_{n}^{\times}$such that $k^{2} \equiv 1(\bmod n)$. Up to conjugacy, let $\mathcal{G}^{\prime} \in \operatorname{Aut}_{k}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ be an involution so that $\mathcal{G}^{\prime}$ maps the cone point represented by $\left(c_{2}, n\right)$ to the cone point represented by $\left(c_{2} \cdot k, n\right)$. To prove our assertion, it would suffice show the existence of an involution $\mathcal{G} \in \operatorname{Homeo}^{+}\left(S_{g}\right)$ that induces $\mathcal{G}^{\prime}$. This amounts to showing that there exists a split metacyclic data set $\mathcal{D}$ of degree $2 \cdot n$ with twist factor $k$ encoding the weak conjugacy class $(H,(\mathcal{G}, \mathcal{F}))$ so that $D_{G}$ has degree 2. Consider the tuple $((2 \cdot n, k), 0 ;[(1,2),(0,1), 2],[(1,2),(n-$ $\left.\left.\left.c_{2}, n\right), 2 n_{1}\right],\left[(0,1),\left(c_{2}, n\right), n\right]\right)$. By simple computation would reveal that conditions (i) - (iv) of Definition 3.1 hold true. Condition (v) is true by taking $v=1,\left(p_{1}, p_{2}, p_{3}\right)=(1,0,0)$ and $\left(q_{1}, q_{2}, q_{3}\right)=(0,0, w)$ such that $w c_{2} \equiv 1$ $(\bmod n)$, which proves our claim.

For the case when $D_{F}=\left(n, 0 ;\left(c_{1}, n\right),\left(c_{1} k, n\right),\left(c_{1} k^{2}, n\right)\right)$ for some $k \in \mathbb{Z}_{n}^{\times}$ such that $k^{3} \equiv 1(\bmod n)$, let $\mathcal{G}^{\prime} \in \operatorname{Aut}_{k}\left(\mathcal{O}_{\langle\mathcal{F}\rangle}\right)$ be of order 3 so that for $1 \leq i \leq 2, \mathcal{G}^{\prime i}$ maps the cone point represented by $\left(c_{1}, n\right)$ to the cone point represented by $\left(c_{1} k^{i}, n\right)$. By similar argument as above, we can show that the tuple $\left((3 \cdot n, k), 0 ;[(1,3),(0,1), 3],\left[(2,3),\left(n-c_{1}, n\right), 3\right],\left[(0,1),\left(c_{1}, n\right), n\right]\right)$ forms a split metacyclic data set of degree $3 \cdot n$ with twist factor $k$ upto equivalence.

Example 4.11. For $i=1,2$, consider the branched cover $p: S_{3} \rightarrow \mathcal{O}_{\left\langle\mathcal{F}_{i}\right\rangle}(\approx$ $\left.S_{0,3}\right)$, where $D_{F_{1}}=(8,0 ;(1,4),(1,8),(5,8))$ and $D_{F_{2}}=(8,0 ;(3,4),(3,8),(7,8))$. Then (up to conjugacy) the order-2 mapping class $G \in \operatorname{LMod}_{p}\left(S_{0,3}\right)$ represented by an automorphism $\mathcal{G} \in \operatorname{Aut}_{5}\left(S_{0,3}\right)$, that permutes two cone points of order 8 and fixes order 4 cone point, lifts to a $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{3}\right)$ with $D_{\tilde{G}}=(2,1 ;((1,2), 4))$ such that $\left\langle F_{i}, \tilde{G}\right\rangle \cong \mathbb{Z}_{8} \rtimes_{5} \mathbb{Z}_{2}$. Moreover, the weak conjugacy class of $\left(\left\langle\mathcal{F}_{i}, \tilde{\mathcal{G}}\right\rangle,\left(\mathcal{G}, \mathcal{F}_{i}\right)\right)$, for $i=1,2$, is encoded by

$$
\begin{aligned}
& ((2 \cdot 8,5), 0 ;[(1,2),(0,1), 2],[(1,2),(7,8), 8],[(0,1),(1,8), 8]) \text { and } \\
& \quad((2 \cdot 8,5), 0 ;[(1,2),(0,1), 2],[(1,2),(1,8), 8],[(0,1),(7,8), 8]),
\end{aligned}
$$

respectively. The geometric realization of these actions is illustrated in Figure 5 below, where for each $i$, the action $\mathcal{F}_{i}$ is realized by the rotation of a polygon of type $\mathcal{P}_{F_{i}}$ described in Theorem [2.5.


Figure 5. The realizations of two distinct $\mathbb{Z}_{8} \rtimes_{5} \mathbb{Z}_{2}$-actions on $S_{3}$.

Proposition 4.12. For $g, n \geq 2$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular cover with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Then any involution $G^{\prime} \in$ $\operatorname{Mod}\left(S_{g}\right)$ has a conjugate $G \in \operatorname{LMod}\left(S_{g}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}\left(S_{n(g-1)+1}\right)$ such that $\langle F, \tilde{G}\rangle \cong D_{2 n}$.

Proof. Let $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ be an involution with $D_{G^{\prime}}=\left(2, g_{0} ;((1,2), t)\right)$. By Theorem 3.3 and Remark 4.9, it suffices to show that there exists a dihedral data set $\mathcal{D}$ degree $2 \cdot n$ and genus $n(g-1)+1$ representing the weak conjugacy class of $(\langle F, \tilde{G}\rangle, \tilde{G}, F)$. When $g_{0} \geq 1$, we take $\mathcal{D}$ to be the tuple

$$
((2 n,-1), g_{0} ; \underbrace{[(1,2),(0,1), 2], \ldots,[(1,2),(0,1), 2]}_{t \text { times }},
$$

and when $g_{0}=0, t \geq 4$, and so we take $\mathcal{D}$ to be the tuple

$$
\begin{gathered}
((2 n,-1), g_{0} ; \underbrace{[(1,2),(0,1), 2], \ldots,[(1,2),(0,1), 2]}_{t-2} \\
[(1,2),(1, n), 2],[(1,2),(1, n), 2]) .
\end{gathered}
$$

It is an easy computation to check that $\mathcal{D}$ satisfies conditions (i)-(iv) of Definition 3.1 in both cases. When $g_{0}=0$, taking $v=1$,

$$
\left(p_{1}, \ldots, p_{\ell}\right)=(1,0, \ldots, 0), \text { and }\left(q_{1}, \ldots, q_{\ell}\right)=(0, \ldots, 0,1,1,0)
$$

we obtain condition (v). Moreover, when $g_{0}=1$, we take $v=1$,

$$
\left(p_{1}, \ldots, p_{\ell}\right)=(1,0, \ldots, 0), \text { and }\left(q_{1}, \ldots, q_{\ell}\right)=(0, \ldots, 0)
$$

thereby verifying condition (vi). Thus, we have shown that $\mathcal{D}$ is a dihedral data set as desired. Finally, it follows from Theorem 3.3 that $\mathcal{D}$ encodes the weak conjugacy class of $(\langle F, \tilde{G}\rangle, \tilde{G}, F)$.
Note that the same $\mathbb{Z}_{2}$-action can lift to multiple non-isomorphic groups under a regular cyclic cover. We illustrate this phenomenon in the following example.
Example 4.13. Let $p: S_{5} \rightarrow S_{2}$ be a regular 4-sheeted cover with deck transformation group $\mathbb{Z}_{4}=\langle\mathcal{F}\rangle$ as illustrated in Figure 6 below.


Figure 6. Two distinct lifts $\tilde{G}_{1}, \tilde{G}_{2} \in \operatorname{SMod}\left(S_{5}\right)$ of an involution in $G \in \operatorname{Mod}\left(S_{2}\right)$.

The involution $G \in \operatorname{Mod}\left(S_{2}\right)$ with $D_{G}=(2,1 ;(1,2),(1,2))$ has two distinct lifts $\tilde{G}_{1}, \tilde{G}_{2} \in \operatorname{SMod}\left(S_{5}\right)$ (as indicated) such that $\left\langle F, \tilde{G}_{1}\right\rangle \cong D_{8}$ and $\left\langle F, \tilde{G}_{2}\right\rangle \cong \mathbb{Z}_{2} \times \mathbb{Z}_{4}$. Note that the weak conjugacy classes of $\left(\left\langle\mathcal{F}, \tilde{\mathcal{G}}_{1}\right\rangle, \tilde{\mathcal{G}}_{1}, \mathcal{F}\right)$ is represented by $((2 \cdot 4,-1), 1 ;[(1,2),(0,1), 2],[(1,2),(0,1), 2])$.
The following proposition provides a sufficient condition for the liftability of $\mathbb{Z}_{m}$-actions whose corresponding orbifolds are spheres with a cone point of order $m$.

Proposition 4.14. For $g, n \geq 2$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular $n$ sheeted cover with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Let $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ of be order $m$ such that $D_{G^{\prime}}=\left(m, 0 ;\left(c_{1}, m_{1}\right), \ldots,\left(c_{\ell}, m_{\ell}\right)\right)$ with $m_{\ell}=m$ (say). Then $G^{\prime}$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{g}\right)$ such that $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$ if the following conditions hold.
(a) There exists $a_{1}, \ldots, a_{\ell-1} \in \mathbb{Z}$, and $k \in \mathbb{Z}_{n}^{\times}, k^{m} \equiv 1(\bmod n)$ such that

$$
\sum_{i=1}^{\ell-1} a_{i}\left(k^{c_{i} \frac{m}{m_{i}}}-1\right) \prod_{s=i+1}^{\ell-1} k^{c_{s} \frac{m}{m_{s}}} \equiv 0 \quad(\bmod n)
$$

(b) Let $d_{i} \frac{n}{n_{i}} \equiv a_{i}\left(k^{c_{i} \frac{m}{m_{i}}}-1\right)(\bmod n)$, for $1 \leq i \leq \ell-1$, where $\operatorname{gcd}\left(d_{i}, n_{i}\right)=1$ and $n_{i} \mid n$. Then we have

$$
\operatorname{lcm}\left(n_{1}, n_{2}, \ldots, n_{\ell-1}\right)=n
$$

Proof. By Theorem 3.3 and Remark 4.9, it suffices to show that the tuple

$$
\begin{gathered}
\mathcal{D}=\left((m \cdot n, k), 0 ;\left[\left(c_{1}, m_{1}\right),\left(d_{1}, n_{1}\right), m_{1}\right], \ldots\right. \\
\left.\left[\left(c_{\ell-1}, m_{\ell-1}\right),\left(d_{\ell-1}, n_{\ell-1}\right), m_{\ell-1}\right],\left[\left(c_{\ell}, m_{\ell}\right),(0,1), m_{\ell}\right]\right)
\end{gathered}
$$

forms a split metacyclic data set of genus $n(g-1)+1$ that represents the weak conjugacy class of $(\langle F, \tilde{G}\rangle, \tilde{G}, F)$ for some lift $\tilde{G}$ of $G$ under $p$. It can be verified easily that $\mathcal{D}$ satisfies conditions (i)-(iii) of Definition 3.1, and further, condition (iv) follows from condition (a) in our hypothesis. By taking $v=1,\left(p_{1}, \ldots, p_{\ell}\right)=(0, \ldots, 0, w)$ such that $w c_{\ell} \equiv 1(\bmod m)$, we see that condition (v)(a) holds. Finally, condition (v)(b) follows from condition (b) in our hypothesis, and our assertion follows.

Using similar arguments, we can show the following.
Proposition 4.15. For $g, n \geq 2$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular $n$ sheeted cover with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Let $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ of be order $m$ such that $D_{G^{\prime}}=\left(m, 0 ;\left(c_{1}, m_{1}\right), \ldots,\left(c_{\ell}, m_{\ell}\right)\right)$ with $m_{i} \neq m$, for $1 \leq i \leq \ell$. Then $G^{\prime}$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ with a lift $\tilde{G} \in$ $\operatorname{SMod}_{p}\left(S_{g}\right)$ such that $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$ if following conditions hold.
(i) There exists $a_{1}, \ldots, a_{\ell} \in \mathbb{Z}$, and $k \in \mathbb{Z}_{n}^{\times}, k^{m} \equiv 1(\bmod n)$ such that

$$
\sum_{i=1}^{\ell} a_{i}\left(k^{c_{i} \frac{m}{m_{i}}}-1\right) \prod_{s=i+1}^{\ell} k^{c_{s} \frac{m}{m_{s}}} \equiv 0 \quad(\bmod n)
$$

(ii) There exists $\left(p_{1}, \ldots, p_{\ell v}\right),\left(q_{1}, \ldots, q_{\ell v}\right) \in \mathbb{Z}^{\ell v}$ and $v \in \mathbb{N}$ such that condition $(v)(b)$ of Definition 3.1 holds, where for $1 \leq i \leq \ell$, we have

$$
c_{i 1} \frac{m}{n_{i 1}} \equiv c_{i} \frac{m}{m_{i}} \quad(\bmod m) \text { and } c_{i 2} \frac{n}{n_{i 2}} \equiv a_{i}\left(k^{c_{i} \frac{m}{m_{i}}}-1\right) \quad(\bmod n)
$$

A consequence of Propositions 4.14 4.15 is the following.
Corollary 4.16. For $g \geq 2$ and prime $n$, let $p: S_{n(g-1)+1} \rightarrow S_{g}$ be a regular $n$-sheeted with deck transformation group $\mathbb{Z}_{n}=\langle\mathcal{F}\rangle$. Let $G^{\prime} \in \operatorname{Mod}\left(S_{g}\right)$ of be order $m$ such that the genus of $\mathcal{O}_{\left\langle\mathcal{G}^{\prime}\right\rangle}$ is zero. Then $G^{\prime}$ has a conjugate $G \in \operatorname{LMod}_{p}\left(S_{g}\right)$ with a lift $\tilde{G} \in \operatorname{SMod}_{p}\left(S_{g}\right)$ such that $\langle F, \tilde{G}\rangle \cong \mathbb{Z}_{n} \rtimes_{k} \mathbb{Z}_{m}$ if there exists $k \in \mathbb{Z}_{n}^{\times}$such that $|k|=m$.
Proof. Let $D_{G^{\prime}}=\left(m, 0 ;\left(c_{1}, m_{1}\right), \ldots,\left(c_{\ell}, m_{\ell}\right)\right)$. First, let us assume (without loss of generality) that $m_{\ell}=m$. By choosing

$$
\left(a_{1}, \ldots, a_{\ell-1}\right)=\left(0, \ldots, 0,1,-\left(k^{c_{\ell-2} \frac{m}{m_{\ell-2}}}-1\right) \cdot k^{c_{\ell-1} \frac{m}{m_{\ell-1}}} \cdot\left(k^{c_{\ell-1} \frac{m}{m_{\ell-1}}}-1\right)^{-1}\right)
$$

we see that condition (i) of Proposition 4.14 holds true. Moreover, since $|k|=m$, we have $\operatorname{gcd}\left(\left(k^{c_{\ell-2} \frac{m}{m_{\ell-2}}}-1\right), n\right)=1$, and so condition (ii) also holds, and our assertion follows.

Similarly, for the case when each $m_{\ell}<m$, the result follows by taking

$$
\left(a_{1}, \ldots, a_{\ell}\right)=\left(0, \ldots, 0,1,-\left(k^{c_{\ell-1} \frac{m}{m_{\ell-1}}}-1\right) \cdot k^{c_{\ell} \frac{m}{m_{\ell}}} \cdot\left(k^{c_{\ell} \frac{m}{m_{\ell}}}-1\right)^{-1}\right)
$$

and applying Proposition 4.15.
4.4. Infinite split dihedral group. By an infinite dihedral group, we mean a group that is isomorphic to $\mathbb{Z} \rtimes_{-1} \mathbb{Z}_{2}$ and admits a presentation of the form

$$
\left\langle x, y \mid y^{2}=1, y^{-1} x y=x^{-1}\right\rangle
$$

In this subsection, we give an explicit construction of an infinite dihedral subgroup of $\operatorname{Mod}\left(S_{g}\right)$ when $g \geq 5$. Let $T_{c} \in \operatorname{Mod}\left(S_{g}\right)$ denote the left-handed Dehn twist about a simple closed curve $c$ in $S_{g}$. A root of $T_{c}$ of degree $s$ is a $G \in \operatorname{Mod}\left(S_{g}\right)$ such that $G^{s}=T_{c}$. In the following lemma, by using some basic properties of Dehn twists [9, Chapter 3], we show that a root of Dehn twist cannot generate an infinite dihedral group.
Lemma 4.17. For $g \geq 2$, no root of $T_{c}$ is a generator of any infinite dihedral subgroup of $\operatorname{Mod}\left(S_{g}\right)$.
Proof. Let $G$ be a root of $T_{c}$ of degree $s$. Suppose we assume on the contrary that for some $g \geq 2$, there exists an infinite dihedral subgroup $H \cong \mathbb{Z} \rtimes_{-1} \mathbb{Z}_{2}$ of $\operatorname{Mod}\left(S_{g}\right)$ that admits the presentation

$$
H=\left\langle F, G \mid F^{2}=1, F^{-1} G F=G^{-1}\right\rangle
$$

First, we consider the case when $s=1$, that is, $G=T_{c}$. Then we have that

$$
F^{-1} T_{c} F=T_{c}^{-1} \Longrightarrow T_{F^{-1}(c)}=T_{c}^{-1}
$$

which is impossible. Thus, we have that $H \neq\left\langle F, T_{c}\right\rangle$, which contradicts our assumption.

For $s>1$, suppose that $H=\langle F, G\rangle$. Then the subgroup $\left\langle F, G^{s}\right\rangle$ of $H$ would also be a split metacyclic group. Since $G^{s}=T_{c}$, this would contradict our conclusion in the previous case, and so our assertion follows.

Considering Lemma 4.17, a natural question is whether product of commuting Dehn twists can generate an infinite dihedral group. In the following example, we answer this question in the affirmative.

Example 4.18. Let $F^{\prime} \in \operatorname{Mod}\left(S_{2}\right)$ be of order 3 with

$$
D_{F^{\prime}}=(3,0 ;((1,3), 2),((2,3), 2))
$$

First, we note that $\mathcal{F}$ has four fixed points on $S_{2}$. Further, it induces a local rotation angle of $2 \pi / 3$ around two of these points (corresponding to the two $(1,3)$ pairs in $D_{F^{\prime}}$ ) and rotation angle of $4 \pi / 3$ around the remaining two points (corresponding to the two $(2,3)$ pairs in $D_{F^{\prime}}$ ), as indicated in Figure 7. Considering this action on two distinct copies of $S_{2}$, we remove invariant disks around a distinguished (1,3)-type fixed point and a distinguished (2,3)-type fixed point in each of the two copies. We now attach
two annuli connecting the resulting boundary components across the two surfaces so that:
(a) each annulus connects a pair of boundary components where the induced rotation angle is the same, as shown in Figure 7 below, and further,
(b) the annulus connecting the boundary components with rotation $4 \pi / 3$ (with the nonseparating curve $c$ ) has a $1 / 3^{r d}$ twist, while the other (with the nonseparating curve $d$ ) has a $-1 / 3^{\text {rd }}$ twist.


Figure 7. Realization of an infinite dihedral subgroup of $\operatorname{Mod}\left(S_{5}\right)$.

Thus, by applying the theory developed in [19], we obtain an $F \in \operatorname{Mod}\left(S_{5}\right)$, which is a root of the bounding pair map $T_{c} T_{d}^{-1}$ of degree 3 . Now, we consider the hyperelliptic involution $G \in \operatorname{Mod}\left(S_{5}\right)$ with $D_{G}=(2,0 ;((1,2), 12))$ (also indicated in Figure 71). By our construction, it follows that $G F G^{-1}=$ $F^{-1}$, and so we have $\langle F, G\rangle \cong \mathbb{Z} \rtimes_{-1} \mathbb{Z}_{2}$.

Generalizing the construction in Example 4.18, we have the following.
Proposition 4.19. For $g \geq 5$, there exists an infinite dihedral subgroup of $\operatorname{Mod}\left(S_{g}\right)$ that is generated by the hyperelliptic involution and a root of a bounding pair map of degree 3 .

## 5. Hyperbolic structures Realizing split metacyclic actions

We begin this section by providing an algorithm for obtaining the hyperbolic structures that realize finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{g}\right)$ (up to weak conjugacy) as groups of isometries.

Step 1. Consider a weak conjugacy class represented by $(H,(\mathcal{G}, \mathcal{F}))$.
Step 2. Use Theorem 3.3 to determine the conjugacy classes $D_{F}\left(\right.$ resp. $\left.D_{G}\right)$ of the generators $F$ (resp. $G$ ).
Step 3. We apply Lemma 2.7, and Theorems 2.5-2.6, to obtain the hyperbolic structures that realize $H$ as a group of isometries.

We now describe the geometric realizations of some split metacyclic actions on $S_{3}$ and $S_{5}$ represented by the split metacyclic data sets listed in Tables 1 and 2 in Section 6.

The action $\mathcal{F}$ is realized through two 1-compatibilities between two actions $F^{\prime}$ and $F^{\prime \prime}$ on $S_{1}$ with $D_{F^{\prime}}=(3,0 ;((1,3), 3))$ and $\left.D_{F^{\prime \prime}}=(3,0 ;((2,3), 3))\right)$. The weak conjugacy class of $(\langle\mathcal{F}, \mathcal{G}\rangle, \mathcal{G}, \mathcal{F})$ is encoded by the first split metacyclic data set in Table 1 .

The weak conjugacy classes of $\left(\left\langle\mathcal{F}, \mathcal{G}_{1}\right\rangle, \mathcal{G}_{1}, \mathcal{F}\right)$ and $\left(\left\langle\mathcal{F}, \mathcal{G}_{2}\right\rangle, \mathcal{G}_{2}, \mathcal{F}\right)$ are encoded by split metacyclic data sets nos 3 and 6 , respectively, in Table 1.

The action $\mathcal{F}$ is realized via two 1 -compatibilities between the action $\mathcal{F}^{\prime}$ on two copies of $S_{2}$ with $D_{F^{\prime}}=(4,0 ;((1,2), 2),(1,4),(3,4))$. Furthermore, the action $\mathcal{F}^{\prime}$ is realized by a 1 -compatibility between the action $\mathcal{F}^{\prime \prime}$ on two copies of $S_{1}$ with $D_{F^{\prime \prime}}=(4,0 ;(1,2),(1,4),(3,4))$. The weak conjugacy class of $(\langle\mathcal{F}, \mathcal{G}\rangle, \mathcal{G}, \mathcal{F})$ is encoded by the split metacyclic data set no 13 in Table 2.

The action $\mathcal{F}$ is realized via two 1-compatibilities between two actions $\mathcal{F}^{\prime}$ and $\mathcal{F}^{\prime \prime}$ on $S_{2}$ where $D_{F^{\prime}}=(8,0 ;(1,2),(1,8),(3,8))$ and $D_{F^{\prime \prime}}=$ $(8,0 ;(1,2),(5,8),(7,8))$. The weak conjugacy class of $\left(\left\langle\mathcal{F}, \mathcal{G}_{i}\right\rangle, \mathcal{G}_{i}, \mathcal{F}\right) 1 \leq i \leq 3$ is encoded by the split metacyclic data set no 25, 24, and 21, respectively, in Table 2.

## 6. CLASSIFICATION OF THE WEAK CONJUGACY CLASSES IN $\operatorname{Mod}\left(S_{3}\right)$ And $\operatorname{Mod}\left(S_{5}\right)$

In this section, we will use Theorem 3.3 to classify the weak conjugacy classes in $\operatorname{Mod}\left(S_{3}\right)$ and $\operatorname{Mod}\left(S_{5}\right)$. For brevity, we will further assume the following equivalence of the split metacyclic data sets (i.e. the weak conjugacy classes).

Definition 6.1. Two split metacyclic data sets

\text { and } \\
\mathcal{D}^{\prime}=\left((m \cdot n, k), g_{0} ;\left[\left(c_{11}^{\prime}, n_{11}^{\prime}\right),\left(c_{12}^{\prime}, n_{12}^{\prime}\right), n_{1}^{\prime}\right], \cdots,\left[\left(c_{\ell 1}^{\prime}, n_{\ell 1}^{\prime}\right),\left(c_{\ell 2}^{\prime}, n_{\ell 2}^{\prime}\right), n_{\ell}^{\prime}\right]\right)
\end{gathered}
$$

are said to be equivalent if for each tuple $\left[\left(c_{i 1}^{\prime}, n_{i 1}^{\prime}\right),\left(c_{i 2}^{\prime}, n_{i 2}^{\prime}\right), n_{i}^{\prime}\right]$, there exists a unique tuple $\left[\left(c_{j 1}, n_{j 1}\right),\left(c_{j 2}, n_{j 2}\right), n_{j}\right]$ satisfying the following conditions:
(i) $\left(c_{i 1}^{\prime}, n_{i 1}^{\prime}\right)=\left(c_{j 1}, n_{j 1}\right)$,
(ii) $n_{i}^{\prime}=n_{j}$, and
(iii) $c_{i 2}^{\prime} \frac{n}{n_{i 2}^{\prime}} \equiv c_{j 2} \frac{n}{n_{j 2}} k^{a_{i}}+b_{i}\left(k^{c_{j 1} \frac{m}{n_{j 1}}}-1\right)(\bmod n)$ for some $a_{i}, b_{i} \in \mathbb{Z}$.

Note that equivalent data sets $\mathcal{D}$ and $\mathcal{D}^{\prime}$ as in Definition 6.1 satisfy $\mathcal{D}_{i}^{\prime}=\mathcal{D}_{i}$, for $i=1,2$. We will now provide a classification of the weak conjugacy classes of finite split metacyclic subgroups of $\operatorname{Mod}\left(S_{3}\right)$ and $\operatorname{Mod}\left(S_{5}\right)$ (up to this equivalence) in Tables 1 and 2, respectively,
