# Rational pullbacks of toric foliations

#### Abstract

This article is dedicated to the study of singular codimension 1 foliations $\mathcal{F}$ on a simplicial complete toric variety $X$ and their pullbacks by dominant rational maps $\varphi: \mathbb{P}^{n} \rightarrow X$. First, we describe the singularities of $\mathcal{F}$ and $\varphi^{*} \mathcal{F}$ for a generic pair $(\varphi, \mathcal{F})$. Then we show that the first order deformations of $\varphi^{*} \mathcal{F}$ arising from first order unfoldings are the families of the form $\varphi_{\varepsilon}^{*} \mathcal{F}$, where $\varphi_{\varepsilon}$ is a perturbation of $\varphi$. We also prove that the deformations of the form $\varphi^{*} \mathcal{F}_{\varepsilon}$ consist exactly of the families which are tangent to the fibers of $\varphi$. In order to do so, we state some results of independent interest regarding the Kupka singularities of these foliations.

## 1. Introduction

The study of first order perturbations of codimension one foliations has shown to be an effective tool for finding new irreducible components of the space of codimension one foliations in $\mathbb{P}^{n}$, see the works of $[14,13,12]$. Also the study of foliations in normal varieties has been gaining growing interest in the area, see for instance [1, 2]. In this

[^0]article we study first order perturbations, i.e., first order unfoldings and first order deformations of foliations on $\mathbb{P}^{n}$ which are pullbacks of foliations on a normal toric variety. Let us now introduce some notations and definitions to make a clearer exposition.

Let $X$ be a normal compact complex variety and $j: X_{r} \rightarrow X$ the inclusion of its smooth locus. A singular codimension 1 foliation $\mathcal{F}$ on $X$ can be defined as a foliation on $X_{r}$ and is induced by a unique element $[\omega] \in \mathbb{P} H^{0}\left(X, j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$ for some element $\mathcal{D} \in C l(X)$ satisfying the Frobenius integrability condition $\omega \wedge d \omega=0$ and whose zero locus $\operatorname{Sing}(\omega)$ is of codimension greater than one. One can then define the moduli space of foliations of codimension one and degree $\mathcal{D}$ as the quasi-projective variety
$\mathcal{F}^{1}(X, \mathcal{D})=\left\{[\omega] \in \mathbb{P} H^{0}\left(X, j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right): \omega \wedge d \omega=0\right.$ and $\left.\operatorname{codim}(\operatorname{Sing}(\omega)) \geq 2\right\}$.
We will use $[\omega]$ or $\mathcal{F}_{\omega}$ indistinctly when no confusion arises. Let $\mathcal{F}_{\omega}$ be the foliation corresponding to an element $[\omega] \in \mathcal{F}^{1}(X, \mathcal{D})$ and $X[\varepsilon]$ be the scheme $X \times \mathcal{N}$ where $\mathcal{N}=$ $\operatorname{Spec}\left(\mathbb{C}[\varepsilon] /\left(\varepsilon^{2}\right)\right)$ is the scheme of dual numbers. Let us also denote by $j[\varepsilon]: X_{r}[\varepsilon] \rightarrow X[\varepsilon]$ the natural inclusion and $\pi_{1}: X[\varepsilon] \rightarrow X$ the projection. A first order deformation of $\mathcal{F}_{\omega}$ is a family of foliations on $X$ parameterized by $\mathcal{N}$. This is, an integrable element $\omega_{\varepsilon} \in H^{0}\left(X[\varepsilon], j[\varepsilon]_{*}\left(\Omega_{X_{r}[\varepsilon] \mid \mathcal{N}}^{1} \otimes \mathcal{L}_{\varepsilon}\right)\right.$ ) (unique up to multiplication by units in $\mathbb{C}[\varepsilon] /\left(\varepsilon^{2}\right)$ ) such that $\mathcal{L}_{\varepsilon}$ is a family of line bundles on $X_{r}$ and $\omega_{\varepsilon}$ restricts to [ $\omega$ ] on the central fiber. We say that $\omega_{\varepsilon}$ is a deformation of degree $\mathcal{D}$ if $\mathcal{L}_{\varepsilon}=\pi_{1}^{*}\left(\left.\mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)$. Of course, the space of degree $\mathcal{D}$ first order deformation of $\mathcal{F}_{\omega}$ is canonically isomorphic to the tangent space $\mathcal{T}_{[\omega]} \mathcal{F}^{1}(X, \mathcal{D})$ to the space of foliations at $[\omega]$. These elements can be expressed as $\omega_{\varepsilon}=\omega+\varepsilon \eta$ for some $\eta \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right.$ such that $\omega_{\varepsilon} \wedge d \omega_{\varepsilon}=0$. We refer the reader to Section 4 for more details on this definition.

A first order unfolding of $\mathcal{F}_{\omega}$ on the other hand corresponds to a twisted differential form $\widetilde{\omega}_{\varepsilon} \in H^{0}\left(X[\varepsilon], j[\varepsilon]_{*}\left(\Omega_{X_{r}[\varepsilon]}^{1} \otimes \mathcal{L}_{\varepsilon}\right)\right)$ restricting to $[\omega]$ on the central fiber and satisfying $\widetilde{\omega}_{\varepsilon} \wedge d \widetilde{\omega}_{\varepsilon}=0$, where $\mathcal{L}_{\varepsilon}$ is a family of line bundles on $X_{r}$. Over a normal base $S$ this would correspond to a foliation on $X \times S$ extending $\mathcal{F}_{\omega}$. Just as in the previous paragraph, every first order unfolding of degree $\mathcal{D}$ admits a description of the form $\widetilde{\omega}_{\varepsilon}=\omega+\varepsilon \eta+h d \varepsilon$ where $\eta \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$ and $h \in H^{0}\left(X, \mathcal{O}_{X}(\mathcal{D})\right)$. Observe that every degree $\mathcal{D}$ first order unfolding induces a degree $\mathcal{D}$ first order deformation via the natural projection. Along the literature one can find many works where unfoldings are used in order to get a better understanding of the singularities and the deformations of a given foliation, see for instance [29, 28, 20, 23].

A toric variety $X$ is an algebraic variety with a Zariski open $T \simeq\left(\mathbb{C}^{*}\right)^{q}$ such that the natural product on $T$ extends to an action on $X$. Along this work, every toric variety will be assumed to be a normal orbifold (simplicial). The geometry of these spaces can be encoded in a combinatorial object, namely its fan. Moreover, one can use this connection between toric and simplicial geometry in order to construct a geometric quotient $\left(\mathbb{C}^{m} \backslash Z\right) / G \simeq X$ for some reductive group $G$. The morphism inducing this isomorphism will be denoted $\pi_{X}: \mathbb{C}^{m} \backslash Z \rightarrow X$. The homogeneous coordinate ring $S_{X}$ of $\mathbb{C}^{m} \backslash Z$ is therefore equipped with a $C l(X)=\operatorname{Hom}\left(G, \mathbb{C}^{*}\right)$-grading and can be used to describe many geometrical objects on $X$.

Let $\mathcal{F}_{\omega}$ be a foliation on $X$ and $\varphi: Y \rightarrow X$ be a generic rational map from a smooth variety $Y$ to $X$. The pullback $\varphi^{*} \mathcal{F}_{\omega}$ of $\mathcal{F}_{\omega}$ under $\varphi$ is defined as the foliation defined by
the differential form $\varphi^{*} \omega \in H^{0}\left(Y, \Omega_{Y}^{1} \otimes \mathcal{O}_{Y}\left(\varphi^{*} \mathcal{D}\right)\right)$. These type of foliations have played a central role in the theory of singular foliations, just as in [8, 25].

The main topic of this article is the study of foliations on the projective space $\mathbb{P}^{n}$ of the form $\varphi^{*} \mathcal{F}$, where $X$ is a toric variety and $\varphi: \mathbb{P}^{n} \rightarrow X$ is a dominant rational map. Pullback foliations admit two canonical types of deformations, namely the ones of the form $\varphi^{*} \mathcal{F}_{\varepsilon}$ or $\varphi_{\varepsilon}^{*} \mathcal{F}$ where $\mathcal{F}_{\varepsilon}$ and $\varphi_{\varepsilon}$ are first order deformations of $\mathcal{F}$ and $\varphi$ respectively. We characterize these deformations in terms of the first order unfoldings of $\varphi^{*} \mathcal{F}$ and the fibers of $\varphi$ under some generic conditions on the pair $(\varphi, \alpha)$ which are properly stated in Definition 3.15. In order to do so, we prove some results of independent interest: we give a proper description of both the set of rational maps $\mathbb{P}^{n} \rightarrow X$ and the singularities of a generic foliation $\mathcal{F}$ on $X$ and its pullback $\varphi^{*} \mathcal{F}$.

The content of this work is organized as follows:
In Section 2 we discuss the notions on toric varieties and foliations that will be necessary in the rest of the article. Regarding rational maps $\phi: \mathbb{P}^{n} \rightarrow X$, we show that every such application satisfying $\operatorname{codim}\left(\varphi^{-1}(\operatorname{Sing}(X))\right) \geq 2$ admits a polynomial lifting in homogeneous coordinates making the follow diagram commute

and having the right base locus, i.e., such that the maximal Zariski open where $\varphi$ is defined is exactly $\mathbb{P}^{n} \backslash \pi_{\mathbb{P}^{n}}\left(F^{-1}(Z)\right)$.

Section 3 is advocated to the study of the singularities of a generic foliation on $X$ and its pullback under a generic rational map. A Kupka singularity of $\mathcal{F}_{\omega}$ is a point $p \in X$ such that $\omega(p)=0$ and $d \omega(p) \neq 0$. Around these points the structure of $\mathcal{F}_{\omega}$ is well understood. First, we analyze the singularities of a foliation on a toric surface and determine which are the elements $\mathcal{D} \in C l(X)$ such that a generic $[\alpha] \in \mathcal{F}^{1}(X, \mathcal{D})$ has only reduced Kupka singularities. Then we describe the singularities (both Kupka and nonKupka) of a generic pullback $\varphi^{*} \alpha$ in terms of $\varphi^{-1}(\operatorname{Sing}(\alpha))$ and different loci associated to the map $\varphi$. For more details see Lemma 3.18, Theorem 3.21 and Corollary 3.24.

In Section 4 we discuss first order deformations and unfoldings and prove the facts that were mentioned above. For a rational $\operatorname{map} \varphi: \mathbb{P}^{n} \rightarrow X$ we will denote by $X_{r}^{*}$ the intersection of the smooth locus of $X$ and the non-critical values of $\varphi$. The results regarding the canonical types of deformations are the following, see Theorem 4.6 and Theorem 4.14:

Theorem A. Let $Y$ be a smooth projective variety with discrete Picard group, $X$ be a normal projective variety of dimension $q \geq 2, \mathcal{D} \in C l(X)$ and $\varphi: Y \rightarrow X$ a dominant rational map with connected fibers such that $\operatorname{codim}\left(X_{r} \backslash X_{r}^{*}\right) \geq 2$. Let $\alpha \in \mathcal{F}^{1}(X, \mathcal{D})$, $\omega=\varphi^{*}(\alpha)$ and let $\omega_{\varepsilon}$ be a first order deformation of $\omega$. The following conditions are equivalent:

1) The fibers of the map $\bar{\varphi}=\varphi \otimes 1: Y[\varepsilon] \rightarrow X[\varepsilon]$ are tangent to $\operatorname{ker}\left(\omega_{\varepsilon}\right)$, i.e., at a generic point $p$ the relative tangent sheaf satisfies

$$
\mathcal{T}_{\bar{\varphi}} Y[\varepsilon]_{p} \subseteq \operatorname{ker}\left(\omega_{\varepsilon}\right)_{p} \subseteq \mathcal{T}_{\mathcal{N}} Y[\varepsilon]_{p}
$$

2) There exists a degree $\mathcal{D}$ first order deformation $\alpha_{\varepsilon}$ of $\alpha$ such that $\omega_{\varepsilon}=\bar{\varphi}^{*}\left(\alpha_{\varepsilon}\right)$.

Theorem B. Let $X$ be a normal complete toric surface, $\mathcal{D} \in C l(X),[\alpha] \in \mathcal{F}^{1}(X, \mathcal{D})$, $\varphi: \mathbb{P}^{n} \rightarrow X$ be a rational map, such that $\alpha$ and $\varphi$ are generic. Let $\omega_{\varepsilon}$ be a first order deformation of $\omega:=\varphi^{*} \alpha$. Then $\omega_{\varepsilon}$ is induced by a first order unfolding if and only if there is a map $\varphi_{\varepsilon}: \mathbb{P}^{n}[\varepsilon] \rightarrow X$ such that

$$
\omega_{\varepsilon}=\varphi_{\varepsilon}^{*}(\alpha)
$$

## 2. Toric varieties, foliations and rational maps

In this section we give definitions and basic properties of our main objects of study, namely toric varieties, rational maps $\mathbb{P}^{n} \rightarrow X$ and foliations.

### 2.1. Toric varieties and homogeneous coordinates.

In the following we will review some facts regarding toric varieties that will be used in the rest of the article. For a complete treatment of this topic and complete proofs we refer the reader to [11]. We will follow the notation in loc. cit. as well.

Let $X=X_{\Sigma}$ be the toric variety of dimension $q$ associated to the fan $\Sigma$ in $N \simeq \mathbb{Z}^{q}$. We will denote by $\Sigma(1)=\left\{\sigma_{1}, \ldots, \sigma_{m}\right\}$ the set of one-dimensional cones in $\Sigma$. For each $\sigma_{i} \in \Sigma(1)$ there is a unique element $v_{i} \in N$ generating $\sigma_{i}$. Unless stated otherwise, we will assume that $X$ is complete and simplicial. In terms of its cones, this is equivalent to requiring $\Sigma$ to cover $\mathbb{R}^{q}=N \otimes_{\mathbb{Z}} \mathbb{R}$ and that the set of rays of every cone in $\Sigma$ can be extended to a basis of $\mathbb{R}^{q}$. We will now recall the main insights of the construction of homogeneous coordinates for $X$.

The action of the open torus $T=N \otimes_{\mathbb{Z}} \mathbb{C}^{*}$ on $X$ induces an action on the group $\operatorname{Div}(X)$ of divisors of $X$. The subgroup $\operatorname{Div}_{T}(X)$ of elements which are fixed by this action is freely generated by some Weil divisors $D_{1}, \ldots, D_{m}$ which are in correspondence with the elements in $\Sigma(1)$. Let $M=\operatorname{Hom}_{\mathbb{Z}}\left(T, \mathbb{C}^{*}\right) \subseteq K(X)$ be the character lattice of $T$. The morphism $M \rightarrow \operatorname{Div}_{T}(X)$ sending $m \mapsto \operatorname{div}(m)$ together with the restriction of the quotient map into the class group $\operatorname{Div}_{T}(X) \rightarrow C l(X)$ fit together in an exact sequence

$$
\begin{equation*}
0 \rightarrow M \rightarrow \operatorname{Div}_{T}(X) \rightarrow C l(X) \rightarrow 0 \tag{2.1}
\end{equation*}
$$

Applying the functor $\operatorname{Hom}_{\mathbb{Z}}\left(-, \mathbb{C}^{*}\right)$, we get a presentation of $T$ as a quotient

$$
\left(\mathbb{C}^{*}\right)^{m} / G \simeq T
$$

where $G=\operatorname{Hom}_{\mathbb{Z}}\left(C l(X), \mathbb{C}^{*}\right)$.
Remark 2.1. Let us now fix an isomorphism $C l(X) \simeq \mathbb{Z}^{m-q} \times H$ for a finite group $H$. By duality, this induces an isomorphism $G \simeq\left(\mathbb{C}^{*}\right)^{m-q} \times \operatorname{Hom}_{\mathbb{Z}}\left(H, \mathbb{C}^{*}\right)$.

If $v_{k}=\left(v_{1}^{k}, \ldots, v_{q}^{k}\right)$ are the coordinates of the $k$-th ray of $\Sigma$, then the inclusion morphism $G \hookrightarrow\left(\mathbb{C}^{*}\right)^{m}$ is given by the equations

$$
G=\left\{\left(g_{1}, \ldots, g_{m}\right) \in\left(\mathbb{C}^{*}\right)^{m} \mid \prod_{k=1}^{m} g_{k}^{v_{i}^{k}}=1 \forall 1 \leq i \leq q\right\}
$$

see for instance [11, Lemma 5.1.1, p. 206]. It is worth mentioning that this implies that an element $t=\left(t^{a_{1}}, \ldots, t^{a_{m}}\right) \in\left(\mathbb{C}^{*}\right)^{m}$ lies in $G$ if and only if $a_{1} v_{1}+\cdots+a_{m} v_{m}=0$. The construction of homogeneous coordinates consists of a geometric quotient

$$
\pi_{X}:\left(\mathbb{C}^{m} \backslash Z\right) / G \xrightarrow{\sim} X,
$$

where $Z$ is a union of subspaces of codimension equal or greater than 2 which extends the previous presentation. The action of $G$ in $S:=\mathbb{C}\left[\mathbb{C}^{m} \backslash Z\right]=\mathbb{C}\left[z_{1}, \ldots, z_{m}\right]$ induces a $C l(X)=\operatorname{Hom}_{\mathbb{Z}}\left(G, \mathbb{C}^{*}\right)$-grading

$$
S=\bigoplus_{\mathcal{D} \in C l(X)} S_{\mathcal{D}}
$$

This graded ring is called the homogeneous coordinate ring of $X$. Just as in the projective case, this grading satisfies

$$
H^{0}\left(X, \mathcal{O}_{X}(\mathcal{D})\right)=S_{\mathcal{D}}
$$

for every $\mathcal{D} \in C l(X)$. The coordinate functions are of course homogeneous and satisfy $\operatorname{deg}\left(z_{i}\right)=\left[D_{i}\right]$. The irrelevant ideal of $X$ is the ideal

$$
I_{Z}=\left\langle\widehat{z}_{\sigma}=\prod_{i \notin \sigma(1)} z_{i}\right\rangle_{\sigma \in \Sigma}
$$

Remark 2.2. If $X$ is a surface, then either $m=3$ and therefore $Z=\{0\}(X$ is a weighted projective plane) or $Z$ is equidimensional of codimension 2. In the latter case, if we index the rays in a clock-wise manner we have

$$
Z=\bigcup_{\substack{i, j=1 \\ i, j \text { non-consecutive }}}^{m} Z_{i j}
$$

where $Z_{i j}=\left\{z_{i}=z_{j}=0\right\}$. For simplicity, we will use the notation $I_{i j}=I\left(Z_{i j}\right)$ in Section 3.1 and Section 4.

Remark 2.3. Just as in the projective case, every homogeneous ideal $I \subseteq S$ defines a closed subscheme $\mathcal{V}(I) \subseteq X$. Moreover, every closed subscheme arises this way (see [11, Proposition 5.2.7, p. 222]]).

Let $j: X_{r} \hookrightarrow X$ be the inclusion of the smooth locus of $X$. Recall that the sheaf of Zariski differential $p$-forms is

$$
\widehat{\Omega}_{X}^{p}=\left(\Omega_{X}^{p}\right)^{\vee \vee}=j_{*}\left(\Omega_{X_{r}}^{p}\right) .
$$

The action of $G$ induces $C l(X)$-grading in the algebra of polynomial differential forms $\Omega_{S}^{\bullet}$ (resp. the algebra of polynomial vector fields $\left.\wedge^{\bullet} \operatorname{Der}(S, S)\right)$ such that the exterior derivative has degree zero, i.e., $\operatorname{deg}\left(d z_{i}\right)=\left[D_{i}\right]$ (resp. $\left.\operatorname{deg}\left(\frac{\partial}{\partial z_{i}}\right)=-\left[D_{i}\right]\right)$.

We will make use of the generalized Euler sequence

$$
\begin{equation*}
0 \longrightarrow \widehat{\Omega}_{X}^{1} \longrightarrow \bigoplus_{i=1}^{m} \mathcal{O}_{X}\left(-D_{i}\right) \longrightarrow C l(X) \otimes_{\mathbb{Z}} \mathcal{O}_{X} \longrightarrow 0 \tag{2.2}
\end{equation*}
$$

and its dual

$$
\begin{equation*}
0 \longrightarrow \mathcal{O}_{X}^{\oplus m-q} \longrightarrow \bigoplus_{i=1}^{m} \mathcal{O}_{X}\left(D_{i}\right) \longrightarrow \mathcal{T} X \longrightarrow 0 \tag{2.3}
\end{equation*}
$$

where $\mathcal{T} X$ is the Zariski tangent sheaf of $X$ (see [4]). The first arrow in the second sequence corresponds to the radial vector fields. These homogeneous polynomial vector fields (of degree zero) generate the tangent space to every $G$-orbit in $\mathbb{C}^{m}$ and are of the form

$$
R_{j}=\sum_{i=1}^{m} a_{i}^{j} z_{i} \frac{\partial}{\partial z_{i}} \quad 1 \leq j \leq m-q
$$

where the coefficients $a_{i}^{j} \in \mathbb{Z}$ satisfy $\operatorname{deg}\left(z_{i}\right)=\left(a_{i}^{1}, \ldots, a_{i}^{m-q}, h_{i}\right) \in C l(X)$.
The smooth locus $X_{r} \hookrightarrow X$ corresponds to the subfan $\Sigma_{r}$ consisting of the smooth cones in $\Sigma$. In particular, we have $\Sigma(1)=\Sigma_{r}(1)$ and therefore by (2.1) the map

$$
\begin{align*}
C l(X) & \rightarrow C l\left(X_{r}\right)=\operatorname{Pic}\left(X_{r}\right)  \tag{2.4}\\
\quad[\mathcal{D}] & \mapsto\left[\left.\mathcal{D}\right|_{X_{r}}\right]
\end{align*}
$$

is an isomorphism. The construction of homogeneous coordinates for $X_{r}$ coincides with the (co)restriction of $\pi_{X}$, i.e.,

$$
X_{r} \simeq\left(\mathbb{C}^{m} \backslash Z^{\prime}\right) / G
$$

where $Z^{\prime}=Z \cup \pi_{X}^{-1}\left(X \backslash X_{r}\right)$. At the level of coordinates rings,

$$
j^{*}: S_{X_{r}}=\mathbb{C}\left[z_{1}, \ldots, z_{m}\right] \rightarrow S_{X}=\mathbb{C}\left[z_{1}, \ldots, z_{m}\right]
$$

is the identity.
Remark 2.4. Let $\mathcal{D}$ be a Weil divisor on $X$ and $\mathcal{L}=\left.\mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}$ be the line bundle given by the restriction of the reflexive sheaf $\mathcal{O}_{X}(\mathcal{D})$ to $X_{r}$. If we tensorize the Euler sequence and take cohomology we can conclude that every $\omega \in H^{0}\left(X_{r}, \Omega_{X_{r}}^{1} \otimes \mathcal{L}\right)$ can be described in homogeneous coordinates as a polynomial differential form

$$
\begin{equation*}
\omega=\sum_{i=1}^{m} A_{i}(z) d z_{i} \tag{2.5}
\end{equation*}
$$

where $A_{i} \in S_{X}$ is homogeneous of degree $\mathcal{L}-\left[D_{i}\right] \in \operatorname{Pic}\left(X_{r}\right)$ and $\imath_{R_{j}}\left(\sum_{i=1}^{m} A_{i}(z) d z_{i}\right)=0$ for every $1 \leq j \leq m-q$.

Now, being $\Omega_{X_{r}}^{1} \otimes \mathcal{L}$ locally free we have

$$
j_{*}\left(\Omega_{X_{r}}^{1} \otimes \mathcal{L}\right) \simeq\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}
$$

see [11, Proposition 8.0.1, p. 347] or [17, Cor. 1.7, p. 127] as well. This implies

$$
H^{0}\left(X_{r}, \Omega_{X_{r}}^{1} \otimes \mathcal{L}\right) \simeq H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)
$$

As a consequence, every $\omega \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)$ admits a description like (2.5) where $\operatorname{deg}\left(A_{i}\right)=\left[\mathcal{D}-\mathcal{D}_{i}\right] \in C l(X)$ and $\imath_{R_{j}}\left(\sum_{i=1}^{m} A_{i}(z) d z_{i}\right)=0$ for every $1 \leq j \leq m-q$.

Definition 2.5. We will use the notation

$$
\widehat{\Omega}_{S}^{1}=\bigoplus_{\mathcal{D} \in C l(X)} \widehat{\Omega}_{S}^{1}(\mathcal{D})=\bigoplus_{\mathcal{D} \in C l(X)} H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right) \subseteq \Omega_{S}^{1}
$$

for the $C l(X)$-graded $S$-module whose associated sheaf is $\widehat{\Omega}_{X}^{1}$, see [11, Corollary 8.1.5, p. 362].

Remark 2.6. For vector fields on the other hand, we can repeat the process of the previous remark on the sequence (2.3) applied to $X_{r}$ in order to get

$$
\begin{align*}
& 0 H^{0}\left(X_{r}, \mathcal{L}^{\oplus m-q}\right) \longrightarrow H^{0}\left(X_{r}, \bigoplus_{i=1}^{m}\left(\mathcal{L}+\mathcal{L}_{i}\right)\right) \xrightarrow{\rho}  \tag{2.6}\\
& \stackrel{\rho}{\longrightarrow} H^{0}\left(X_{r}, \mathcal{T} X_{r} \otimes \mathcal{L}\right) \longrightarrow H^{1}\left(X_{r}, \mathcal{L}^{\oplus m-q}\right) \longrightarrow
\end{align*}
$$

By the arguments above the elements in the image of $\rho$ are exactly the sections

$$
\mathfrak{X} \in H^{0}\left(X_{r}, \mathcal{T} X_{r} \otimes \mathcal{L}\right) \simeq H^{0}\left(X,\left(\mathcal{T} X \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)
$$

that admit a homogeneous lifting to $\mathbb{C}^{m}$, i.e. a description of the form

$$
\mathfrak{X}=\sum_{j=1}^{m} B_{j}(z) \frac{\partial}{\partial z_{j}}
$$

where $B_{j} \in \mathbb{C}\left[z_{1}, \ldots z_{m}\right]$ is homogeneous of degree $\left[\mathcal{D}+\mathcal{D}_{j}\right] \in C l(X)$. This description is unique up to linear combinations of the radial vector fields.

Remark 2.7. The canonical sheaf of a toric variety $X$ is given by $\omega_{X} \simeq \mathcal{O}_{X}\left(-\sum_{i=1}^{m} \mathcal{D}_{i}\right)$, see [11, Theorem 8.2.3, p. 366]. This isomorphism can be explicited via the section

$$
\Omega_{X}:=\imath_{R_{1}} \cdots \imath_{R_{m-q}} d z_{1} \wedge \cdots \wedge d z_{m} \in H^{0}\left(X,\left(\Omega_{X}^{q} \otimes \mathcal{O}_{X}\left(\sum_{i=1}^{m} \mathcal{D}_{i}\right)\right)^{\vee \vee}\right)
$$

2.2. Rational maps $\mathbb{P}^{n} \rightarrow X$. Since we are interested in studying pullbacks of foliations under dominant rational maps $\mathbb{P}^{n} \rightarrow X$, we will now present a description of these maps that will make our calculations more feasible. We will denote by

$$
\pi: \mathbb{C}^{n+1} \backslash\{0\} \rightarrow \mathbb{P}^{n}
$$

the standard quotient.
Lemma 2.8. Let $e_{1} v_{1}+\cdots+e_{m} v_{m}=0$ be an equation with integer coefficients for the rays $\left\{v_{i}\right\}_{i=1}^{m}$ in the fan of $X$. Then, every $F=\left(F_{1}, \ldots, F_{m}\right) \in \mathbb{C}\left(x_{0}, \ldots, x_{n}\right)^{m}$, with $F_{i}$
homogeneous of degree $e_{i}$, induces a rational map $\tilde{F}: \mathbb{P}^{n} \rightarrow X$ such that the diagram

is commutative.
Proof. For every $t \in \mathbb{C}^{*}$ and every $x \in \mathbb{C}^{n+1}$ we have

$$
\begin{aligned}
F(t \cdot x) & =\left(t^{e_{1}} F_{1}(x), \ldots, t^{e_{m}} F_{m}(x)\right) \\
& =\left(t^{e_{1}}, \ldots, t^{e_{m}}\right) \cdot F(x)
\end{aligned}
$$

The hypothesis on the degrees assures that the point $g(t)=\left(t^{e_{1}}, \ldots, t^{e_{m}}\right) \in\left(\mathbb{C}^{*}\right)^{m}$ satisfies the equations

$$
\prod_{k=1}^{m} g(t)_{k}^{v_{i}^{k}}=1 \quad \forall 1 \leq i \leq q
$$

and therefore is an element of $G$. Therefore, the map $F: \mathbb{C}^{n+1} \backslash 0 \rightarrow \mathbb{C}^{m} \backslash Z$ descends to a rational map $\tilde{F}: \mathbb{P}^{n} \rightarrow X$ with base locus $\pi\left(F^{-1}(Z)\right)$.

Under suitable assumptions every rational map admits a lifting in homogeneous coordinates $F: \mathbb{C}^{n+1} \backslash\{0\} \rightarrow \mathbb{C}^{m} \backslash Z$.

Lemma 2.9. Assume $\Sigma$ has a smooth cone of maximal dimension. Then for every rational map $\varphi: \mathbb{P}^{n} \rightarrow X$ and every relation $e_{1} v_{1}+\cdots+e_{m} v_{m}=0$ there exist $F=$ $\left(F_{1}, \ldots, F_{m}\right)$ such that $\operatorname{deg}\left(F_{i}\right)=\lambda e_{i}$, for some $\lambda \in \mathbb{N}$, and $\varphi=\tilde{F}$.

Proof. Let $\sigma \in \Sigma$ be a smooth cone with $\operatorname{dim}(\sigma)=q$. Without loss of generality, we can assume that $\sigma(1)=\left\{v_{1}, \ldots, v_{q}\right\}$. Recall we have a smooth open set $U_{\sigma} \subseteq X$ with $U_{\sigma} \simeq \mathbb{C}^{q}$. Moreover, by [11, Proposition 5.2.10, p. 223] the restriction of $\pi_{X}$ to the variety $V=\left\{x_{q+1}=\cdots=x_{m}=1\right\}$ induces an isomorphism with $U_{\sigma}$. Via this isomorphism, we consider $\varphi: \mathbb{P}^{n} \rightarrow V$. This map can be described as

$$
\varphi=\left(\frac{h_{1}}{g_{1}}, \ldots, \frac{h_{q}}{g_{q}}, 1, \ldots, 1\right)
$$

where $h_{i}$ and $g_{i}$ are homogeneous polynomials of the same degree. If we write $g=\prod g_{i}$, then for a generic point $x \in \mathbb{C}^{n+1}$ we get $\left(g^{e_{1}}, \ldots, g^{e_{m}}\right)(x) \in G$. Finally

$$
\varphi=\left(g^{e_{1}}, \ldots, g^{e_{m}}\right) \cdot\left(\frac{h_{1}}{g_{1}}, \ldots, \frac{h_{q}}{g_{q}}, 1, \ldots, 1\right)=\left(g^{e_{1}} \frac{h_{1}}{g_{1}}, \ldots, g^{e_{q}} \frac{h_{q}}{g_{q}}, g^{e_{q+1}}, \ldots, g^{e_{m}}\right)
$$

Clearly, the lifting $F=\left(g^{e_{1}} \frac{h_{1}}{g_{1}}, \ldots, g^{e_{q}} \frac{h_{q}}{g_{q}}, g^{e_{q+1}}, \ldots, g^{e_{m}}\right)$ satisfies $\operatorname{deg}\left(F_{i}\right)=\operatorname{deg}(g) e_{i}$ and $\varphi=\tilde{F}$.

Remark 2.10. As in the case of projective spaces, the lifting $F$ fails to be unique. Moreover, different liftings give rise to different base loci.

The problem of deciding whether a rational map between toric varieties admits a complete lifting to their respective homogeneous coordinate rings was addressed in [6]. Here the word 'complete' indicates that the lifting has the right base locus. That is,

$$
\operatorname{Reg}(\varphi)=\mathbb{P}^{n} \backslash \pi\left(F^{-1}(Z)\right),
$$

where $\operatorname{Reg}(\varphi)$ is the maximal Zariski open subset on which $\varphi$ is well defined as a regular map. In order to guarantee the existence of such liftings it is necessary to introduce multi-valued maps. Each coordinate of such map is a multi-valued section according to the following.

Definition 2.11. A multi-valued section on $X$ is an element $\gamma$ in the algebraic closure of $\mathbb{C}\left(z_{1}, \ldots, z_{m}\right)$. We say $\gamma$ is homogeneous if $\gamma^{r}=f \in \mathbb{C}\left(z_{1}, \ldots, z_{m}\right)$ for some integer $r \geq 1$. In this case, we say that $\gamma$ is regular at $p \in \mathbb{C}^{m}$ if $f$ is regular at $p$.

For our purposes it will be highly convenient to restrict ourselves to the set of rational maps admitting a complete polynomial lifting. The following proposition shows that this is the case for a general map $\mathbb{P}^{n} \rightarrow X$.
Proposition 2.12. Let $X$ be a complete toric variety and $\varphi: \mathbb{P}^{n} \rightarrow X$ be a dominant rational map satisfying $\operatorname{codim}\left(\varphi^{-1}(\operatorname{Sing}(X))\right) \geq 2$. Then $\varphi$ admits a complete polynomial lifting.
Proof. By [6, Theorem 4.19, p. 255] we know that a multi-valued complete lifting $F=$ $\left(F_{1}, \ldots, F_{m}\right)$ exists. We will now prove that if $\operatorname{codim}\left(\varphi^{-1}(\operatorname{Sing}(X))\right) \geq 2$ then $F$ is actually polynomial. Since $X$ is complete and $\operatorname{codim}\left(\varphi^{-1}(\operatorname{Sing}(X))\right) \geq 2$ it follows that both $\varphi$ and $\varphi_{r}:=\left.\varphi\right|_{\varphi^{-1}\left(X_{r}\right)}$ are regular in codimension 1. Using [6, Proposition 5.1, p. 259] we can write

$$
F_{i}=G_{i} \gamma_{i},
$$

where $G_{i}$ is a rational function and $\gamma_{i}$ is a multi-valued homogeneous section on $\mathbb{P}^{n}$, which is also invertible on $\operatorname{Reg}\left(\varphi_{r}\right)$. Our hypothesis on $\varphi^{-1}(\operatorname{Sing}(X))$ implies that $\gamma_{i}$ has no zeros or poles in $\mathbb{P}^{n}$ and therefore $\gamma_{i} \in \mathbb{C}$. In case $G_{i}$ had poles, $\varphi$ would not be regular in codimension 1. Then it follows that $F_{i}$ is in fact a polynomial.
Remark 2.13. The hypothesis on $\varphi^{-1}(\operatorname{Sing}(X))$ is necessary. For instance, the map $\mathbb{P}^{2} \rightarrow \mathbb{P}(1,1,2)$ defined by $F=\left(z_{0}^{2}, z_{0} z_{1}, z_{0} z_{2}^{3}\right)$ contracts the divisor $\left\{z_{0}=0\right\}$ into the singular point $[0: 0: 1]$ and does not admit a complete polynomial lifting.

Remark 2.14. If $F$ is a complete polynomial lifting and $g \in G$, then $g \cdot F$ is again a complete polynomial lifting. In fact, if $\varphi$ is regular in codimension 1 then the complete polynomial lifting is unique up to multiplication by elements of $G$. Its corresponding degree $\bar{e}$ can be computed by looking at the line bundles $\varphi^{*}\left(\mathcal{O}_{X}\left(D_{i}\right)\right)$. Indeed, each coordinate of $F$ satisfies $F_{i} \in H^{0}\left(\mathbb{P}^{n}, \varphi^{*}\left(\mathcal{O}_{X}\left(D_{i}\right)\right)\right)$.

From now on we will only consider rational maps admitting complete polynomial liftings. If no confusion arises, we will use the same notation $F$ for both the rational map and its complete polynomial lifting.

We end this section by showing that if $n \geq m$, then for a generic map $F: \mathbb{P}^{n} \rightarrow X$ the associated morphism of Cox rings $F^{*}=S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat. This condition will be used later in order to deal with generic pullbacks of foliations.

Proposition 2.15. Let $F_{1}, \ldots, F_{m}$ be homogeneous elements defining a regular sequence in $\mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$. If $n \geq m$, then the morphism $F^{*}: \mathbb{C}\left[z_{1}, \ldots, z_{m}\right] \rightarrow \mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$ such that $z_{i} \mapsto F_{i}$ is flat.

Proof. Let $F_{1}, \ldots, F_{m}$ be an homogeneous regular sequence in $\mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$. Since we are assuming $n \geq m$, there must exist some homogeneous polynomials $F_{m+1}, \ldots, F_{n+1}$ such that the sequence $F_{1}, \ldots F_{n+1}$ is an homogeneous system of parameters. In particular, these elements are algebraically independent and therefore $\mathbb{C}\left[F_{1}, \ldots, F_{n+1}\right]$ is a polynomial ring. Also, by $[26$, Theorem 5.9, p. 35$]$ we know that $\mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$ is a free $\mathbb{C}\left[F_{1}, \ldots, F_{n+1}\right]$-module. Since the map

$$
\begin{aligned}
\mathbb{C}\left[z_{1}, \ldots, z_{m}\right] & \rightarrow \mathbb{C}\left[F_{1}, \ldots, F_{m}\right] \\
z_{i} & \mapsto F_{i}
\end{aligned}
$$

is an isomorphism, we can conclude that $\mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$ is a flat $\mathbb{C}\left[z_{1}, \ldots, z_{m}\right]$-module and the proposition follows.
2.3. Foliations and moduli spaces. Let $X$ be a complete normal variety, $X_{r}$ be the smooth locus of $X$ and $j: X_{r} \rightarrow X$ its natural inclusion.

Definition 2.16. A singular foliation $\mathcal{F}$ of codimension 1 on $X$ is a singular foliation of codimension 1 on $X_{r}$.

Being $X_{r}$ a smooth complex algebraic variety, a singular foliation $\mathcal{F}$ of codimension 1 on $X_{r}$ is induced by a twisted differential form $\omega_{r} \in H^{0}\left(X_{r}, \Omega_{X_{r}}^{1}(\mathcal{L})\right)$, unique up to multiplication by elements in $H^{0}\left(X_{r}, \mathcal{O}_{X_{r}}^{*}\right)$, for some line bundle $\mathcal{L} \in \operatorname{Pic}\left(X_{r}\right)$ satisfying the integrability condition $\omega_{r} \wedge d \omega_{r}=0$ and vanishing in codimension at least 2.

Following [11, Theorem 8.0.4, p. 348], we get $j_{*} \mathcal{L}=\mathcal{O}_{X}(\mathcal{D})$, for some Weil divisor $\mathcal{D}$ on $X$. Then, by [17, Cor. 1.7, p. 127] and [11, Theorem 8.0.1, p. 347] we have

$$
j_{*}\left(\Omega_{X_{r}}^{1} \otimes \mathcal{L}\right)=\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}
$$

Thus, a foliation $\mathcal{F}$ on $X$ gives rise to a nonzero global section $\omega_{\mathcal{F}} \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes\right.\right.$ $\left.\left.\mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)$ such that

$$
\begin{equation*}
\omega_{\mathcal{F}} \wedge d \omega_{\mathcal{F}}=0 \tag{2.7}
\end{equation*}
$$

as an element of $H^{0}\left(X,\left(\Omega_{X}^{3} \otimes \mathcal{O}_{X}(\mathcal{D})^{\otimes 2}\right)^{\vee \vee}\right)$ and whose zero locus has codimension greater or equal than 2 .

Recall from the previous sections that in the case $X$ is a toric variety every element $\omega \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee V}\right)$ admits a description in homogeneous coordinates of the form

$$
\begin{equation*}
\omega=\sum_{i=1}^{m} A_{i}(z) d z_{i} \tag{2.8}
\end{equation*}
$$

where $A_{i}$ is homogeneous of degree $\left[\mathcal{D}-\mathcal{D}_{i}\right] \in C l(X)$, satisfying $\imath_{R_{k}}\left(\sum_{i=1}^{m} A_{i}(z) d z_{i}\right)$ for every $1 \leq k \leq m-q$.

We will use the notation $\omega$ for both the differential form and the foliation induced by it when no confusion arises.

Definition 2.17. The singular scheme $\operatorname{Sing}\left(\mathcal{F}_{\omega}\right)$ of a foliation $\mathcal{F}_{\omega}$ is defined as the zerolocus of the global section $\omega \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)$. We will denote by $\operatorname{Sing}\left(\mathcal{F}_{\omega}\right)_{\text {set }}$ its support. In the case $X$ is a toric variety and $\omega$ is as in Eq. (2.8), $\operatorname{Sing}\left(\mathcal{F}_{\omega}\right)$ is the closed subscheme defined by the homogeneous ideal $J(\omega)=\left\langle A_{1}, \ldots, A_{m}\right\rangle$.

Remark 2.18. Consequently, every foliation of codimension 1 on a toric variety $X$ can be described by a homogeneous differential form $\omega \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$, for some $\mathcal{D} \in C l(X)$, satisfying in homogeneous coordinates the equation (2.7) and $\operatorname{codim}(\mathcal{V}(J(\omega))) \geq 2$.

Moreover, two such forms $\omega$ and $\omega^{\prime}$ define the same foliation if and only if there exists an element $\lambda \in H^{0}\left(X, \mathcal{O}_{X}^{*}\right)$ such that $\omega=\lambda \omega^{\prime}$. We can thus present the spaces parameterizing singular foliations on $X$.

Definition 2.19. Let $X$ be a normal variety and $\mathcal{D} \in C l(X)$. The moduli space of codimension 1 singular foliations of degree $\mathcal{D} \in C l(X)$ on $X$ is the quasi-projective variety
$\mathcal{F}^{1}(X, \mathcal{D})=\left\{[\omega] \in \mathbb{P} H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right): \omega \wedge d \omega=0\right.$ and $\left.\operatorname{codim}(\operatorname{Sing}(\omega)) \geq 2\right\}$.
Remark 2.20. When $X$ is a surface, the integrability condition is trivial and therefore the moduli space of degree $\mathcal{D}$ foliations is a Zariski open in $\mathbb{P} H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)$.

On the other hand, by duality every codimension 1 foliation on a surface $X$ is induced by a twisted vector field $Y \in H^{0}\left(X,\left(\mathcal{T} X \otimes \mathcal{O}_{X}\left(\mathcal{D}^{\prime}\right)\right)^{\vee v}\right)$ for some $\mathcal{D}^{\prime} \in C l(X)$. In case $X$ is a toric surface, the differential form defining the foliation is

$$
\alpha_{Y}=\imath_{Y} \Omega_{X} \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}\left(\mathcal{D}^{\prime}-\omega_{X}\right)\right)^{\vee \vee}\right),
$$

where $\imath_{Y}$ denotes the contraction with $Y$ and $\Omega_{X}$ is defined in Remark 2.7.

## 3. The singular and the Kupka schemes

We will now define a certain type of singularities that will be central for our analysis, namely Kupka singularities. Throughout this section, unless stated otherwise, we will denote by $X$ a complete simplicial toric variety.

Definition 3.1. Let $X$ be a normal variety, $\mathcal{D} \in C l(X)$ and $\alpha \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes\right.\right.$ $\left.\mathcal{O}_{X}(\mathcal{D})\right)^{\mathrm{VV}}$ ) defining a foliation on $X$. We say that $p \in \operatorname{Sing}(\omega)_{\text {set }}$ is a Kupka point if $d \alpha(p) \neq 0$.

Remark 3.2. Around a Kupka singularity $p \in X_{r}$ the foliation can be described as the pullback of a germ of foliation on $\left(\mathbb{C}^{2}, 0\right)$ having an isolated singularity at the origin. In particular, the set of smooth Kupka points of a foliation is equidimensional of codimension 2, see [18] or [22, Fundamental Lemma, p. 406].

Definition 3.3. We define the Kupka set $\mathcal{K}_{\text {set }}(\alpha)$ as the Zariski closure of the set of Kupka points, that is

$$
\mathcal{K}_{\text {set }}(\alpha)=\overline{\left\{p \in \operatorname{Sing}(\alpha)_{\text {set }}: d \alpha(p) \neq 0\right\}} .
$$

We extend the definitions of [20, Section 4.2, p. 1035] related to the Kupka singularities of $\alpha$ to this context.

Definition 3.4. The Kupka scheme $\mathcal{K}(\alpha)$ is the schematic support of d $\alpha$ at $\Omega_{S}^{2} \otimes_{S}$ $(S / J(\alpha))$. Then, $\mathcal{K}(\alpha) \subseteq X$ is the scheme associated to the homogeneous ideal

$$
K(\alpha)=\operatorname{ann}(\overline{d \alpha})+J(\alpha) \subseteq S, \text { where } \overline{d \alpha} \in \Omega_{S}^{2} \otimes_{S}(S / J(\alpha))
$$

Let us recall the notion of ideal quotient of two $S$-modules $M$ and $N$

$$
(N: M):=\{a \in S: a . M \subseteq N\} .
$$

See [3, Exercise 1.12 , p. 8 and Corollary 3.15, p. 43] for basic properties. In the case of two ideals $I, J \subseteq S$ the saturation of $J$ with respect to $I$ is defined as

$$
\left(J: I^{\infty}\right):=\bigcup_{d \geq 1}\left(J: I^{d}\right)
$$

Then it is also possible to describe $K(\alpha)$ as

$$
K(\alpha)=\left(J \cdot \Omega_{S}^{2}: d \alpha\right)
$$

Let us denote the ideal of polynomial coefficients of a differential form $\eta \in \Omega_{S}^{r}$ by $\mathscr{C}(\eta)$. With this notation, we have $J(\alpha)=\mathscr{C}(\alpha)$. Since $\Omega_{S}^{2}$ is a free module, we also get

$$
\begin{equation*}
K(\alpha)=(J(\alpha): \mathscr{C}(d \alpha)) \tag{3.1}
\end{equation*}
$$

As for the Kupka set, its homogeneous ideal coincides with the saturation of $J(\alpha)$ with respect to $\mathscr{C}(d \alpha)$, i.e.,

$$
\begin{equation*}
K_{\text {set }}(\alpha)=\sqrt{\left(J(\alpha): \mathscr{C}(d \alpha)^{\infty}\right)} \tag{3.2}
\end{equation*}
$$

Remark 3.5. The reduced structure of the Kupka scheme may be supported on a bigger space than the Kupka set. See for instance [20, Example 4.5, p. 1034]. However, when the singular locus is reduced we have the following.
Lemma 3.6. If $p$ is a reduced point of $\operatorname{Sing}(\alpha)$, i.e. $J(\alpha)_{p}=\sqrt{J(\alpha)}_{p}$, then

$$
K(\alpha)_{p}=K_{s e t}(\alpha)_{p}
$$

Proof. This follows immediately from the equalities

$$
K(\alpha)_{p}=\left(J(\alpha)_{p}: \mathscr{C}(d \alpha)_{p}\right)=\left(J(\alpha)_{p}: \mathscr{C}(d \alpha)_{p}^{\infty}\right)=K_{\text {set }}(\alpha)_{p}
$$

3.1. Singularities of foliations in toric surfaces. The aim of this section is to describe the singular scheme of a generic foliation on a toric surface $X$. Recall that every foliation on $X$ is induced by a twisted vector field $Y \in H^{0}\left(X, H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}(\mathcal{D})\right)^{\vee \vee}\right)\right.$ for some $\mathcal{D} \in C l(X)$. In this case, the Zariski differential form defining the foliation is $\alpha_{Y}=\imath_{Y} \Omega_{X} \in H^{0}\left(X,\left(\Omega_{X}^{1} \otimes \mathcal{O}_{X}\left(\mathcal{D}-\omega_{X}\right)\right)^{\vee \vee}\right)$.

We will begin by analyzing the singularities that are contained in $X_{r}$. A similar approach has also been used in [10, Section 2.3, p. 6].

Proposition 3.7. Let $X$ be a toric surface, $\mathcal{D} \in \operatorname{Pic}(X)$ a very ample line bundle and $\mathcal{D}^{\prime} \in C l(X)$ such that the natural map

$$
H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right) \otimes_{\mathbb{C}} \mathcal{O}_{X} \rightarrow\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}^{\prime}\right)\right)^{\vee \vee}
$$

is non-zero at every fiber over $X_{r}$. Then for a generic $Y \in H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right)$, the scheme Sing $\left(\alpha_{Y}\right) \cap X_{r}$ is reduced and consists only of Kupka singularities.

Proof. Let $d=\operatorname{dim}\left(\mathbb{P} H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right)\right)$ and

$$
\mathcal{W} \subseteq \mathbb{P} H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right) \times X_{r}
$$

be the incidence variety defined by

$$
\mathcal{W}=\left\{(Y, p): \alpha_{Y}(p)=d\left(\alpha_{Y}\right)(p)=0 \text { or } p \text { is a non-reduced point of } \operatorname{Sing}\left(\alpha_{Y}\right)\right\}
$$

and equipped with both projections $\mathbb{P} H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right) \stackrel{\pi_{1}}{\leftarrow} \mathcal{W} \xrightarrow{\pi_{2}} X_{r}$. For every $p \in X$ the space of sections $Z$, where $Z(p)=0$, identifies with the kernel of the evaluation $e v_{p}$ of vector fields at $p$. Therefore, it determines a codimension 2 linear space in $\mathbb{P} H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee V}\right)$. Our hypotheses on $\mathcal{D}$ and $\mathcal{D}^{\prime}$ are in order to guarantee that for each $p \in X_{r}$ there exists an element $Y \in H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right)$ such that $p$ is a reduced Kupka singularity of the foliation induced by $Y$. Indeed, if $Z$ is a global section of $\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}^{\prime}\right)\right)^{\vee V}$ not vanishing at a point $p$ and $f \in \mathcal{O}_{X}(\mathcal{D})$ such that $\{f=0\}$ is reduced and not tangent to $Y$ at $p$, then $Y=f Z$ satisfies the above. This implies that the fiber $\pi_{2}^{-1}(p)$ has dimension $\leq d-3$. By the Fiber Dimension Theorem [24, Theorem 3, p. 49]

$$
\operatorname{dim}(\mathcal{W}) \leq d-3+2=d-1
$$

In particular, a generic $Y \in \mathbb{P} H^{0}\left(X,\left(T X \otimes \mathcal{O}_{X}\left(\mathcal{D}+\mathcal{D}^{\prime}\right)\right)^{\vee \vee}\right)$ is not in the image of $\pi_{1}(\mathcal{W})$ and hence the claim.

Remark 3.8. The proposition above shows that under the right hypotheses on $\mathcal{D}$ the non-Kupka points of a generic foliation of degree $\mathcal{D}$ are contained in the singular points of $X$. In order to assure that every singularity of a generic foliation is a Kupka singularity, it would be sufficient to assure that $\operatorname{Sing}(\mathcal{F}) \cap \operatorname{Sing}(X)=\emptyset$. This is an arithmetical condition on $\mathcal{D}$ : it is equivalent to requiring that not every homogeneous element in $\widehat{\Omega}_{S}^{1}$ of degree $\mathcal{D}$ vanishes on each of the orbits in $\pi_{X}^{-1}(\operatorname{Sing}(X))$.

Example 3.9. Let $X=\mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right)$. We will always assume that the weights $a_{i}$ are coprime by pairs. Let $\alpha=\sum_{i=0}^{2} A_{i}(z) d z_{i} \in \widehat{\Omega}_{S}^{1}(d)$ and $Z$ an homogeneous polynomial vector field. We recall the Cartan formula

$$
\imath_{Z} d \alpha+d \imath_{Z} \alpha=L_{Z}(\alpha)
$$

where $L_{Z}(\alpha)$ denotes the Lie derivative of $\alpha$ with respect to the vector field $Z$. Using this equation in the case $Z=R=\sum_{i=0}^{2} a_{i} z_{i} \frac{\partial}{\partial z_{i}}$ we get

$$
\begin{equation*}
\imath_{R} d \alpha+d \imath_{R} \alpha=\operatorname{deg}(\alpha) \alpha \tag{3.3}
\end{equation*}
$$

Following [15, Theorem (ii) p. 39] every twisted vector field in $\mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right)$ admits a description as an homogeneous polynomial vector field. For an element

$$
Y=\sum_{i=0}^{2} B_{i} \frac{\partial}{\partial z_{i}}
$$

of degree $\ell$, let $\alpha_{Y}=\imath_{Y} \Omega_{X} \in \widehat{\Omega}_{S}^{1}\left(\ell+a_{0}+a_{1}+a_{2}\right)$ and $\operatorname{div}(Y)=\sum_{i=0}^{2} \frac{\partial B_{i}}{\partial z_{i}}$ be its divergence. Using Eq. (3.3) straightforward computation shows

$$
\begin{equation*}
d \alpha_{Y}=\operatorname{div}(Y) \Omega_{X}-\left(\ell+a_{0}+a_{1}+a_{2}\right) \imath_{Y} d z_{0} \wedge d z_{1} \wedge d z_{2} \tag{3.4}
\end{equation*}
$$

The vector $Y-\frac{\operatorname{div}(Y)}{\ell+a_{0}+a_{1}+a_{2}} R$ defines the same element in $H^{0}\left(X,\left(\mathcal{T} X \otimes \mathcal{O}_{X}(\ell)\right)^{\vee \vee}\right)$ as $Y$ and satisfies $\operatorname{div}(Y)=0$. Thus we can assume that the foliation is induced by an homogeneous polynomial vector field with zero divergence. From Eq. (3.4) we can deduce

$$
\operatorname{Sing}\left(d \alpha_{Y}\right)_{\text {set }}=\left\{z \in \mathbb{C}^{3}: B_{0}(z)=B_{1}(z)=B_{2}(z)=0\right\}
$$

Recall that the singularities of $\mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right)$ are of the form $p_{0}=[1: 0: 0], p_{1}=[0: 1: 0]$ or $p_{2}=[0: 0: 1]$, depending on whether the corresponding $a_{i}>1$. The degrees $\ell$ such that a generic foliation satisfies $\operatorname{Sing}(\mathcal{F}) \cap \operatorname{Sing}(X)=\emptyset$ must then coincide with the $\ell \in \mathbb{Z}$ admitting at least one vector field $Y=\sum_{i=0}^{2} B_{i} \frac{\partial}{\partial z_{i}}$ of degree $\ell$ with

$$
\left\{p \in \mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right): B_{0}(p)=B_{1}(p)=B_{2}(p)=0\right\} \cap \operatorname{Sing}\left(\mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right)\right)=\emptyset
$$

Straightforward calculation shows that this are exactly the degrees satisfying

$$
\ell+a_{0} \equiv 0 \bmod \left(a_{i}\right) \quad \text { or } \quad \ell+a_{1} \equiv 0 \bmod \left(a_{i}\right) \quad \text { or } \quad \ell+a_{2} \equiv 0 \bmod \left(a_{i}\right)
$$

for every $0 \leq i \leq 2$ such that $a_{i}>1$.
Let us now state the genericity conditions that will be needed in the following sections.
Definition 3.10. Let $\mathcal{D} \in C l(X)$ and $\alpha \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$. We say that $\alpha$ is generic if every singularity is a reduced Kupka singularity, i.e., if

$$
\left(J(\alpha): I_{Z}^{\infty}\right)=\left(K(\alpha): I_{Z}^{\infty}\right)
$$

is radical, where $I_{Z}$ is the irrelevant ideal of $X$.
Remark 3.11. Let $X$ be a toric surface other than $\mathbb{P}^{2}\left(a_{0}, a_{1}, a_{2}\right)$ and $\mathcal{D} \in C l(X)$. Then for a general $\alpha \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$, the ideal $J(\alpha)$ could have components supported on primes of $I_{Z}$ that appear outside the ideal of the Kupka set and even the Kupka scheme.

Let $\mathcal{D} \in C l(X)$ and $\mathcal{F}$ be the foliation on $X$ induced by a differential form $\alpha=$ $\sum_{i=1}^{m} A_{i}(z) d z_{i} \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$. Its pullback by $\pi_{X}$ induces a foliation on $\mathbb{C}^{m} \backslash Z$ (and therefore on the affine space $\mathbb{C}^{m}$ ) satisfying

$$
\omega_{\pi_{X}^{*} \mathcal{F}}=\alpha=\sum_{i=1}^{m} A_{i}(z) d z_{i}
$$

Proposition 3.12. Let $X$ be a toric surface and $\mathcal{F}$ a foliation on $X$. Then $\operatorname{Sing}\left(\pi_{X}^{*} \mathcal{F}\right)$ is equidimensional of codimension 2. In particular, if the polynomial differential form $d \alpha$ does not vanish in codimension 2 , then $\sqrt{J(\alpha)}=\sqrt{K(\alpha)}$.

Proof. Since $\pi_{X}^{*} \mathcal{F}$ is a codimension 1 foliation whose tangent sheaf splits as a sum of line bundles we can proceed as in the proof of [30, Proposition 12, p. 11].

If $\mathcal{F}$ is generic then every singularity $p \in \mathbb{C}^{m} \backslash Z$ of $\pi_{X}^{*} \mathcal{F}$ is reduced and of Kupka type. It could be the case, however, that other type of singularities appear inside $Z$. To have control over such a situation, we fix the following:

Definition 3.13. When $m=|\Sigma(1)|>3$, we define

$$
\begin{aligned}
& \Gamma_{\alpha}=\left\{\text { non-consecutive pairs }(i, j): i<j, J(\alpha) \subset I_{i j}\right\} \\
& \Gamma_{\alpha, \mathcal{K}}=\left\{(i, j) \in \Gamma_{\alpha, \mathcal{K}}: K(\alpha) \subset I_{i j}\right\} \text { and } \\
& \Gamma_{\alpha, \mathcal{K}}^{s e t}=\left\{(i, j) \in \Gamma_{\alpha, \mathcal{K}}: K_{\text {set }}(\alpha) \subset I_{i j}\right\}
\end{aligned}
$$

where $I_{i j}$ is defined in Remark 2.2. If $m=3$, we consider $\Gamma_{\alpha}=\Gamma_{\alpha, \mathcal{K}}=\Gamma_{\alpha, \mathcal{K}}^{\text {set }}=\emptyset$.
Definition 3.14. Let $\mathcal{D} \in C l(X)$ and $\alpha \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$. We say that $\alpha$ is affinely generic if $\operatorname{Sing}\left(\pi^{*} \mathcal{F}\right)$ is reduced and every irreducible component of $\operatorname{Sing}\left(\pi_{X}^{*} \mathcal{F}\right)$ consists generically of Kupka points, i.e., if $J(\alpha)=K(\alpha)$ is radical.
3.2. The singular scheme of a pullback foliation. Let $X$ be a simplicial complete toric surface, $\alpha \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$ and $F: \mathbb{P}^{n} \longrightarrow X$ be a dominant rational map with a complete polynomial lifting of degree $\bar{e}$. We will write $\omega=F^{*} \alpha$ and suppose that $n>m$. This hypothesis guarantees that the first condition in the following definition is indeed generic in the corresponding space.

Definition 3.15. We say that the pair $(F, \alpha)$ is generic if $\alpha$ is generic and
I) the critical points $C(F)$ of the morphism $F: \mathbb{C}^{n+1} \rightarrow \mathbb{C}^{m}$ are of codimension at least three and
II) the scheme $\operatorname{Sing}(\omega)$ is reduced along

$$
C(F, \alpha):=\overline{\left\{p \in C(F): \alpha(F(p)) \neq 0 \text { and } \operatorname{Im}\left(d_{p} F\right) \subseteq \operatorname{ker}(\alpha(F(p))\}\right.}
$$

and has no embedded components supported at $\operatorname{Sing}(\omega) \cap C(F)$.
Definition 3.16. A generic pair $(F, \alpha)$ is said to be affinely generic if $\alpha$ is affinely generic and the scheme associated to the ideal $F^{*} K(\alpha)=\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle$ has no embedded components supported at the origin $0 \in \mathbb{C}^{n+1}$.

Remark 3.17. The conditions above define a Zariski open set in the space of pairs

$$
\{(F, \alpha): \operatorname{deg}(F)=\bar{e} \text { and } \operatorname{deg}(\alpha)=\mathcal{D}\}
$$

We refer to [16, Théorème (12.2.4), p. 183] for this property on condition $I I$ ).
Lemma 3.18. The singular set of $\omega$ is

$$
\operatorname{Sing}(\omega)_{\text {set }}=\overline{F^{-1}\left(\operatorname{Sing}_{\text {set }}(\alpha)\right)} \cup \bigcup_{(i, j) \in \Gamma_{\alpha}}\left\{F_{i}=F_{j}=0\right\} \cup C(F, \alpha)
$$

where each of these varieties do not share irreducible components and $C(F, \alpha)$ consists of non-Kupka points.

Proof. Recall from Proposition 3.12 that the zero locus of $\alpha$ in $\mathbb{C}^{m}$ is equidimensional of codimension 2. In particular, its irreducible components contained in $Z$ are of the form $\left\{z_{i}=z_{j}\right\}=0$ for $(i, j) \in \Gamma_{\alpha}$. Then every singular point $p$ of $\omega$ such that $\alpha(F(p))=0$ must lie in the first two elements of the above union.

Now let $p \in \operatorname{Sing}(\omega)_{\text {set }}$ be such that $\alpha(F(p)) \neq 0$. Being $p$ a singularity of $\omega$, the image of $d_{p} F$ is contained in $\operatorname{ker}(\alpha(F(p))$ ), i.e., $p \in C(F, \alpha)$. It follows from the integrability
condition $\alpha \wedge d \alpha=0$ that $d \alpha(v, w)(F(p))=0$ for every $v, w \in \operatorname{ker}(\alpha(F(p)))$. Indeed, if $v, w \in \operatorname{ker}(\alpha)$ then

$$
\imath_{v \wedge w}(\alpha \wedge d \alpha)=\imath_{v \wedge w}(d \alpha) \alpha=0
$$

and therefore $d \alpha(v, w)=0$. Since $F^{*}(d \alpha)=d \omega$, we get $d \omega(p)=0$.
As for the Kupka set, we have
Lemma 3.19. If $(F, \alpha)$ is generic, then

$$
\mathcal{K}_{\text {set }}(\omega)=\overline{F^{-1}\left(\operatorname{Sing}_{s e t}(\alpha)\right)} \cup \bigcup_{(i, j) \in \Gamma_{\alpha, \mathcal{K}}^{s e t}}\left\{F_{i}=F_{j}=0\right\} .
$$

Proof. It follows from the above proof that for every Kupka point $p$ of $\omega$ its image $F(p)$ must satisfy $\alpha(F(p))=0$ and $d \alpha(F(p)) \neq 0$. Being $\alpha$ generic, its Kupka set in $\mathbb{C}^{m}$ is the union of $\pi_{X}^{-1}\left(\operatorname{Sing}(\alpha)_{\text {set }}\right)$ and $\left\{z_{i}=z_{j}=0\right\}$ for $(i, j) \in \Gamma_{\alpha, \mathcal{K}}^{s e t}$. On the other hand, being $(F, \alpha)$ generic we can assure that every element in

$$
F^{-1}\left(\operatorname{Sing}_{\text {set }}(\alpha)\right) \cup \bigcup_{(i, j) \in \Gamma_{\alpha, \mathcal{K}}^{s e t}}\left\{F_{i}=F_{j}=0\right\}
$$

is generically of Kupka type and the lemma follows.
We shall now describe the Kupka and singular schemes of a generic pullback foliation.
Remark 3.20. Let $\alpha=\sum_{i=1}^{m} A_{i}(z) d z_{i}$. Observe that the ideal $J(\omega)$ is generated by

$$
\sum_{i=1}^{m} A_{i}(F) \frac{\partial F_{i}}{\partial x_{j}},
$$

for $j=0 \ldots, n$. Let $J_{F}$ be the Jacobian matrix of the polynomial lifting $F: \mathbb{C}^{n+1} \rightarrow \mathbb{C}^{m}$. Then, $J(\omega)$ is in fact generated by the entries of the vector

$$
J_{F}^{t} \cdot\left(A_{1}(F), \ldots, A_{m}(F)\right) .
$$

Also, the coefficients of the differential form $d \omega$ are the entries of

$$
J_{F}^{t} \cdot\left(A_{i j}(F)\right) \cdot J_{F},
$$

where $A_{i j}$ satisfies $A_{i j}=-A_{j i}$ and $d \alpha=\sum_{i, j=1}^{m} A_{i j} d z_{i} \wedge d z_{j} \in \Omega_{S}^{2}$. In particular, for a point $p \in \mathbb{P}^{n}$ outside $C(F)$ we have

$$
J(\omega)_{p}=F^{*}(J(\alpha))_{p}
$$

and

$$
\mathscr{C}(d \omega)_{p}=F^{*}(\mathscr{C}(d \alpha))_{p} .
$$

Theorem 3.21. Let $(F, \alpha)$ be generic. Suppose further that the ring homomorphism $F^{*}: S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat. Then $\mathcal{K}(\omega)$ is the closed subscheme defined by the ideal $F^{*} K(\alpha)$.

Proof. Being $(F, \alpha)$ generic we know that $\operatorname{Sing}(\omega)$ is reduced along $C(F, \alpha)$. Since these points are not of Kupka type, $\mathcal{K}(\omega)$ has no irreducible component supported at $C(F, \alpha)$ (because by Lemma 3.6 such irreducible component would actually lie in $\mathcal{K}_{\text {set }}(\omega)$ ).

By conditions I) and II) in Definition 3.15, the Jacobian matrix $J_{F}$ has maximal rank at a generic point of an irreducible component of $\operatorname{Sing}(\omega)$ supported at

$$
\overline{F^{-1}\left(\operatorname{Sing}_{\text {set }}(\alpha)\right)} \cup \bigcup_{(i, j) \in \Gamma_{\alpha}}\left\{F_{i}=F_{j}=0\right\}
$$

By the above remark, if $p$ is the generic point of an irreducible component of the Kupka scheme $\mathcal{K}(\omega)$ we have

$$
K(\omega)_{p}=\left(J(\omega)_{p}: \mathscr{C}(d \omega)_{p}\right)=\left(F^{*}(J(\alpha))_{p}: F^{*}(\mathscr{C}(d \alpha))_{p}\right)
$$

Since $F^{*}$ is flat, by [5, Chap. 1, $\S 2$, Remarque, p. 41], we can conclude that $K(\omega)_{p}=$ $F^{*} K(\alpha)_{p}$ and hence the claim.
Lemma 3.22. Let $\alpha \in \widehat{\Omega}_{S}^{1}(\mathcal{D})$ of the form $\alpha=\sum_{i=1}^{m} A_{i}(z) d z_{i}$ and $\omega=F^{*} \alpha$. Then $A_{k}(F) d \omega=\omega \wedge \eta_{k}$ where $\eta_{k}=F^{*}\left(\imath \frac{\partial}{\partial z_{k}} d \alpha\right) \in \Omega_{S}^{1}$.
Proof. Contracting the equation $\alpha \wedge d \alpha=0$ with the vector field $\frac{\partial}{\partial z_{k}}$ we get

$$
A_{k} d \alpha=\alpha \wedge\left(\imath \frac{\partial}{\partial z_{k}} d \alpha\right)
$$

Since the pullback commutes with the exterior differential we have

$$
A_{k}(F) d \omega=\omega \wedge \eta_{k}
$$

where $\eta_{k}=F^{*}\left(\imath \frac{\partial}{\partial z_{k}} d \alpha\right) \in \Omega_{S}^{1}$.
In the case where $(F, \alpha)$ is affinely generic, this easily implies the following.
Corollary 3.23. If $(F, \alpha)$ is affinely generic and $F^{*}: S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat, then

$$
K(\omega)=\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle
$$

Proof. Recall that $K(\omega)=\left(J(\omega) \cdot \Omega_{S}^{2}: d \omega\right)$. Since $\alpha$ is affinely generic, by Lemma 3.22 above we have

$$
F^{*} K(\alpha)=\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle \subseteq K(\omega)
$$

By Theorem 3.21 and our hypothesis on $(F, \alpha)$ being affinely generic we know that

$$
\left(K(\omega):\left\langle x_{0}, \ldots, x_{n}\right\rangle^{\infty}\right)=\left(F^{*} K(\alpha):\left\langle x_{0}, \ldots, x_{n}\right\rangle^{\infty}\right)=F^{*} K(\alpha)
$$

In particular, $K(\omega) \subseteq F^{*} K(\alpha)$ and therefore $K(\omega)=\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle$.
Corollary 3.24. If $(F, \alpha)$ is affinely generic and $F^{*}: S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat, then $\operatorname{Sing}(\omega)$ is reduced and

$$
\operatorname{Sing}(\omega)=\mathcal{K}_{\text {set }}(\omega) \cup C(F, \alpha)
$$

Proof. Recall that the support of $\operatorname{Sing}(\omega)$ is

$$
\operatorname{Sing}(\omega)_{\text {set }}=\overline{F^{-1}\left(\operatorname{Sing}_{\text {set }}(\alpha)\right)} \cup \bigcup_{(i, j) \in \Gamma_{\alpha}}\left\{F_{i}=F_{j}=0\right\} \cup C(F, \alpha)
$$

Being $\alpha$ affinely generic we can assure that $\Gamma_{\alpha}=\Gamma_{\alpha, \mathcal{K}}^{s e t}$. By Lemma 3.19, the equality

$$
\mathcal{K}_{\text {set }}=\overline{F^{-1}\left(\operatorname{Sing}_{\text {set }}(\alpha)\right)} \cup \bigcup_{(i, j) \in \Gamma_{\alpha}}\left\{F_{i}=F_{j}=0\right\}
$$

also holds.
By hypothesis $\operatorname{Sing}(\omega)$ is reduced along $C(F, \alpha)$. On the other hand, being $\alpha$ affinely generic we know that $J(\alpha)=K(\alpha)$ is radical. Since the morphism $F^{*}$ is flat, by Theorem 3.21 we can also conclude that $\operatorname{Sing}(\omega)$ is reduced along $\mathcal{K}_{\text {set }}(\omega)$.

## 4. First order unfoldings and deformations

This section is dedicated to the study of first order deformations and unfoldings of pullback foliations by dominant rational maps $F: \mathbb{P}^{n} \rightarrow X$.

Let $\mathcal{N}=\operatorname{Spec}\left(\mathbb{C}[\varepsilon] /\left(\varepsilon^{2}\right)\right)$ be the spectrum of the dual numbers. For a variety $X$ with smooth locus $X_{r}$ we will use the notation $X[\varepsilon]=X \times \mathcal{N}, \pi_{1}: X[\varepsilon] \rightarrow X$ for the first projection and $j[\varepsilon]: X_{r}[\varepsilon] \hookrightarrow X[\varepsilon]$ the natural inclusion.
Definition 4.1. Let $X$ be a normal variety, $\mathcal{D} \in C l(X)$ and $\alpha \in H^{0}\left(X, j_{*}\left(\Omega_{X_{r}}^{1} \otimes\right.\right.$ $\left.\left.\mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)$ ) a differential form defining a foliation on $X$. A first order deformation of $\mathcal{F}_{\alpha}$ is a family of foliations on $X$ parameterized by $\mathcal{N}$. This is induced by a unique integrable element $\alpha_{\varepsilon} \in H^{0}\left(X[\varepsilon], j[\varepsilon]_{*}\left(\Omega_{X_{r}[\varepsilon] \mid \mathcal{N}}^{1} \otimes \mathcal{L}_{\varepsilon}\right)\right.$ ) (up to multiplication of global sections of $\mathcal{O}_{X[\varepsilon]}^{*}$ ), where $\mathcal{L}_{\varepsilon}$ is a family of line bundles on $X_{r}$ and $\alpha_{\varepsilon}$ restricts to $\alpha$ on the central fiber. We say that $\alpha_{\varepsilon}$ is of degree $\mathcal{D}$ if $\mathcal{L}_{\varepsilon}=\pi_{1}^{*}\left(\mathcal{O}_{X}(\mathcal{D})\right)$.
Remark 4.2. Observe that a degree $\mathcal{D}$ first order deformation is (up to multiplication by units) an integrable global section of $\pi_{1}^{*}\left(j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right.$. This naturally identifies with the Zariski tangent space $\mathcal{T}_{[\alpha]} \mathcal{F}^{1}(X, \mathcal{D})$ to the space of foliations at $[\alpha]$. In particular such a deformation admits a unique description of the form $\alpha_{\varepsilon}=\alpha+\varepsilon \eta$ for some $[\eta] \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right) /\langle\alpha\rangle$ satisfying the integrability condition

$$
\begin{equation*}
\alpha \wedge d \eta+\eta \wedge d \alpha=0 \tag{4.1}
\end{equation*}
$$

Let us now move on to a different type of first order perturbation. Following [21, 2nd. paragraph, p. 11] for a global version or [27, (6.9), p. 201] for a local one, a first order unfolding of degree $\mathcal{L}$ of a foliation $\mathcal{F}_{\alpha}$ on a smooth variety $Y$ induced by some $\alpha \in H^{0}\left(Y, \Omega_{Y}^{1} \otimes \mathcal{L}\right)$ is given by an element $\widetilde{\alpha}_{\varepsilon} \in H^{0}\left(Y[\varepsilon], \Omega_{Y[\varepsilon]}^{1} \otimes \mathcal{L}_{\varepsilon}\right)$ satisfying $\widetilde{\alpha}_{\varepsilon} \wedge d \widetilde{\alpha}_{\varepsilon}=0$, where $\mathcal{L}_{\varepsilon}$ is a first order deformation of $\mathcal{L}$. In the case $\mathcal{L}_{\varepsilon}=\pi_{1}^{*} \mathcal{L}$, such an element must be of the form

$$
\widetilde{\alpha}_{\varepsilon}=\alpha+\varepsilon \eta+h d \varepsilon
$$

for some $\eta \in H^{0}\left(Y, \Omega_{Y}^{1} \otimes \mathcal{L}\right)$ and $h \in H^{0}(Y, \mathcal{L})$. In terms of these sections, the integrability condition $\widetilde{\alpha}_{\varepsilon} \wedge d \widetilde{\alpha}_{\varepsilon}=0$ is guaranteed by the equations

$$
\left\{\begin{array}{l}
\alpha \wedge d \eta+d \alpha \wedge \eta=0  \tag{4.2}\\
h d \alpha=\alpha \wedge(\eta-d h)
\end{array} \quad \Longleftrightarrow \quad h d \alpha=\alpha \wedge(\eta-d h)\right.
$$

This last equivalence will be detailed in the proof of Lemma 4.5. Over a normal variety, it is natural to define the following:
Definition 4.3. Let $X$ be a normal variety, $\mathcal{D} \in C l(X)$ and $\mathcal{F}_{\alpha}$ a foliation induced by some element $\alpha \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$. A first order unfolding of $\mathcal{F}_{\alpha}$ is a first order unfolding of $\left.\mathcal{F}_{\alpha}\right|_{X_{r}}$, i.e., an integrable element $\widetilde{\alpha}_{\varepsilon} \in H^{0}\left(X[\varepsilon], j[\varepsilon]_{*}\left(\Omega_{X_{r}[\varepsilon]}^{1} \otimes \mathcal{L}_{\varepsilon}\right)\right)$ restricting to $\alpha$ on the central fiber, where $\mathcal{L}_{\varepsilon}$ is a family of line bundles on $X_{r}$. We say that $\alpha_{\varepsilon}$ is of degree $\mathcal{D}$ if $\mathcal{L}_{\varepsilon}=\pi_{1}^{*} \mathcal{O}_{X}(\mathcal{D})$.

Just as in the smooth case, if $\alpha \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$ is an element defining a foliation $\mathcal{F}_{\alpha}$ on $X$ then every degree $\mathcal{D}$ first order unfolding of $\mathcal{F}_{\alpha}$ admits a description

$$
\widetilde{\alpha}_{\varepsilon}=\alpha+\varepsilon \eta+h d \varepsilon
$$

for some $\eta \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$ and $h \in H^{0}\left(X, \mathcal{O}_{X}(\mathcal{D})\right)$ satisfying Eq. (4.2). These elements are of course the natural extensions of the corresponding elements in $X_{r}$.

Definition 4.4. The space of degree $\mathcal{D}$ first order unfoldings of $\alpha$ is

$$
U(\alpha)=\left\{(h, \eta) \in H^{0}\left(X, \mathcal{O}_{X}(\mathcal{D}) \oplus j_{*}\left(\left.\Omega_{X}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right): h d \alpha=\alpha \wedge(\eta-d h)\right\} /\langle(0, \alpha)\rangle
$$

Lemma 4.5. Every element $(h, \eta) \in U(\alpha)$ induces a degree $\mathcal{D}$ first order deformation $\alpha_{\varepsilon}=\alpha+\varepsilon \eta$. Then, we have a well-defined map

$$
\begin{aligned}
& U(\alpha) \xrightarrow{\pi_{2}} \mathcal{T}_{[\alpha]} \mathcal{F}^{1}(X, \mathcal{D}) \\
& (h, \eta) \longmapsto[\eta]
\end{aligned}
$$

Proof. See [23, Proposition 2.6].
Now let $X$ be a toric variety, $F: \mathbb{P}^{n} \rightarrow X$ be a dominant rational map with a complete polynomial lifting of degree $\bar{e}$ and $\alpha$ be a twisted differential form defining a foliation on $X$. Its pullback $\omega:=F^{*}(\alpha)$ admits non-trivial canonical deformations: if $F_{\varepsilon}=F+\varepsilon G: \mathbb{P}^{n} \rightarrow X[\varepsilon]$ and $\alpha_{\varepsilon}=\alpha+\varepsilon \eta$ are first order deformations of $F$ and $\alpha$ respectively, then one can consider the family $\omega_{\varepsilon}:=F_{\varepsilon}^{*}\left(\alpha_{\varepsilon}\right)$. We aim to describe these deformations in a more explicit manner.

The following theorem is a version of [1, Lemma 6.7, p. 89] and [9, Lemma 2.2, p. 162] for first order deformations. For a dominant rational map $F: Y \rightarrow X$ from a smooth variety into a normal (not necessarily toric) $X$ we will denote by $X_{r}^{*}$ the intersection of the smooth locus of $X$ and the non-critical values of $F$.

Theorem 4.6. Let $Y$ be a smooth projective variety of dimension $n$ with discrete Picard group, $X$ be a normal projective variety of dimension $q \geq 2, \mathcal{D} \in C l(X)$ and $F: Y \rightarrow X$ a dominant rational map with connected fibers such that $\operatorname{codim}\left(X_{r} \backslash X_{r}^{*}\right) \geq 2$. Let $\alpha \in \mathcal{F}^{1}(X, \mathcal{D}), \omega=F^{*}(\alpha)$ and let $\omega_{\varepsilon}$ be a first order deformation of $\omega$. The following conditions are equivalent:

1) The fibers of the map $\bar{F}=F \otimes 1: Y[\varepsilon] \rightarrow X[\varepsilon]$ are tangent to $\operatorname{ker}\left(\omega_{\varepsilon}\right)$, i.e., at a generic point $p$ the relative tangent sheaf satisfies

$$
\mathcal{T}_{\bar{F}} Y[\varepsilon]_{p} \subseteq \operatorname{ker}\left(\omega_{\varepsilon}\right)_{p} \subseteq \mathcal{T}_{\mathcal{N}} Y[\varepsilon]_{p}
$$

2) There exists a degree $\mathcal{D}$ first order deformation $\alpha_{\varepsilon}$ of $\alpha$ such that $\omega_{\varepsilon}=\bar{F}^{*}\left(\alpha_{\varepsilon}\right)$.

Proof. It follows from the definitions that 2) implies 1). We shall now prove the other implication. For the sake of clarity we will denote by $p_{1}: Y[\varepsilon] \rightarrow Y$ and $\pi_{1}: X[\varepsilon] \rightarrow X$ the respective naturals projections. Observe that the hypothesis on the Picard group of $Y$ implies that $\omega_{\varepsilon}$ is of degree $F^{*} \mathcal{D}$. Let us first show that there exists a deformation $\alpha_{\varepsilon}$ of $\alpha$ on the open set $\mathcal{W}=X_{r}^{*} \backslash \operatorname{Sing}(\alpha)$ such that $\omega_{\varepsilon}=\bar{F}^{*}\left(\alpha_{\varepsilon}\right)$.

Let $p \in Y$ be a smooth point of $F$ such that $F(p)$ is a smooth point of $X$ and consider a trivialization of $F$ around $p$, i.e., open analytic neighborhoods $\mathcal{U}$ and $\mathcal{V}$ with $p \in \mathcal{U}$ and $F(p) \in \mathcal{V}$ together with local coordinates $\left(x_{1}, \ldots, x_{n}\right)$ such that $F\left(x_{1}, \ldots, x_{n}\right)=$ $\left(x_{1}, \ldots, x_{q}\right)$. Suppose further that $p$ is not a singular point of $\omega$. Let us also choose
compatible trivializations $\left.\mathcal{O}_{X}(\mathcal{D})\right|_{\mathcal{V}} \simeq{ }^{\phi} \mathcal{O}_{X}$ and $\left.p_{1}^{*} \mathcal{O}_{Y}\left(F^{*} \mathcal{D}\right)\right|_{\mathcal{U}[\varepsilon]} \simeq{ }^{\psi} \mathcal{O}_{Y[\varepsilon]}$, i.e. such that $\left.\psi\right|_{Y}=F^{*} \phi$. In these coordinates, condition 1) implies $\omega_{\varepsilon} \mid \mathcal{U} \wedge d x_{1} \wedge \ldots d x_{q}=0$. Applying Malgrange's Theorem, [19, Proposition (1.1), p. 67], we can get a description of $\left.\omega_{\varepsilon}\right|_{\mathcal{U}}$ as

$$
\omega_{\varepsilon} \mid \mathcal{U}=\sum_{i=1}^{q} h_{i}^{\varepsilon}(x) d x_{i}
$$

for some functions $h_{i}^{\varepsilon}$ on $\mathcal{U}[\varepsilon]$. The integrability condition $\omega_{\varepsilon} \wedge d \omega_{\varepsilon}$ implies that

$$
0=h_{i}^{\varepsilon} \frac{\partial h_{k}^{\varepsilon}}{\partial x_{j}}-h_{k}^{\varepsilon} \frac{\partial h_{i}^{\varepsilon}}{\partial x_{j}}=\frac{\partial}{\partial x_{j}}\left(\frac{h_{i}^{\varepsilon}}{h_{k}^{\varepsilon}}\right) \quad \forall j>q, \forall 1 \leq i, k \leq q
$$

Since $\omega(p) \neq 0$, we may assume that $h_{1}^{\varepsilon} \in \mathcal{O}_{Y[\varepsilon]}^{*}$. Setting $k=1$ in the equation above, we get $h_{i}^{\varepsilon}=h_{1}^{\varepsilon} g_{i}^{\varepsilon}\left(x_{1}, \ldots, x_{q}\right)$ for some functions $g_{1}^{\varepsilon}, \ldots, g_{q}^{\varepsilon}$. Setting $\alpha_{\varepsilon}=\sum_{i=1}^{q} g_{i}^{\varepsilon} d x_{i}$ on $\mathcal{V}$, this implies

$$
\begin{equation*}
h_{\varepsilon}^{1} \bar{F}^{*} \alpha_{\varepsilon}=\omega_{\varepsilon} \tag{4.3}
\end{equation*}
$$

Being $F$ dominant, $\alpha_{\varepsilon}$ is also integrable and therefore defines a local deformation of $\alpha$. Observe further that the subsheaf $\left(\alpha_{\varepsilon}\right) \subseteq \Omega_{X[\varepsilon] \mid \mathcal{N}}^{1}(\mathcal{V})$ does not depend on the choice of $\mathcal{U}$ : if $\mathcal{U}^{\prime} \rightarrow \mathcal{V}$ is another trivialization and $\alpha_{\varepsilon}^{1}, \alpha_{\varepsilon}^{2}$ are the elements arising from the construction above, then on $\mathcal{U}^{\prime \prime}=\mathcal{U} \cap \mathcal{U}^{\prime}$ we have

$$
\bar{F}^{*}\left(\alpha_{\varepsilon}^{1}\right)=u_{\varepsilon} \bar{F}^{*}\left(\alpha_{\varepsilon}^{2}\right)
$$

for some unit $u_{\varepsilon}$. Since $F$ has connected fibers, we may assume that this intersection is non-empty. The equation above implies that $u=\bar{F}^{*}(v)$ for some unit $v$ in $F\left(\mathcal{U}^{\prime \prime}\right)$ and therefore both differential forms define the same submodule. This construction yields a locally free rank one subsheaf of $\left.\mathcal{L}_{\varepsilon}^{-1} \subseteq \Omega_{X_{r}[\varepsilon] \mid \mathcal{N}}^{1}\right|_{\mathcal{W}[\varepsilon]}$, which is induced by a section $\alpha_{\varepsilon} \in H^{0}\left(\mathcal{W}[\varepsilon], \Omega_{X_{r}[\varepsilon] \mid \mathcal{N}}^{1} \otimes \mathcal{L}_{\varepsilon}\right)$.

We will now show that this deformation extends to $X$. Recall that $\omega_{\varepsilon}$ is of degree $F^{*} \mathcal{D}$. Moreover, since $\bar{F}^{*}\left(\alpha_{\varepsilon}\right)=\omega_{\varepsilon}$ on $F^{-1}(\mathcal{W})$, we have

$$
\begin{equation*}
\left.\bar{F}^{*} \mathcal{L}_{\varepsilon}\right|_{F^{-1}(\mathcal{W})[\varepsilon]} \simeq p_{1}^{*} \mathcal{O}_{Y}\left(F^{*} \mathcal{D}\right) \tag{4.4}
\end{equation*}
$$

Now let us consider the blow-up $\pi: Y^{\prime} \rightarrow Y$ along the base locus of $F$, equipped with a regular extension $F^{\prime}: Y^{\prime} \rightarrow X$. We will also denote by $\bar{\pi}$ and $\overline{F^{\prime}}$ the respective trivial deformations. It follows from Eq. (4.4) that the pullback under $\overline{F^{\prime}}$ of $\mathcal{L}_{\varepsilon}$ along $\left(F^{\prime}\right)^{-1}(\mathcal{W})$ is also a trivial deformation, i.e.,

$$
\left.\left.\left.{\overline{F^{\prime}}}^{*}\left(\mathcal{L}_{\varepsilon}\right)\right|_{\left(F^{\prime}\right)^{-1}(\mathcal{W})[\varepsilon]} \simeq\left(\bar{\pi}^{*} p_{1}^{*} \mathcal{O}_{Y}\left(F^{*} \mathcal{D}\right)\right)\right|_{\left(F^{\prime}\right)^{-1}(\mathcal{W})[\varepsilon]} \simeq{\overline{F^{\prime}}}^{*} \pi_{1}^{*} \mathcal{O}_{X}(\mathcal{D})\right|_{\left(F^{\prime}\right)^{-1}(\mathcal{W})[\varepsilon]}
$$

Being the morphism $\overline{F^{\prime}}:\left(F^{\prime}\right)^{-1}(\mathcal{W})[\varepsilon] \rightarrow \mathcal{W}[\varepsilon]$ proper, by projection formula this implies that $\mathcal{L}_{\varepsilon} \simeq \pi_{1}^{*} \mathcal{O}_{X}(\mathcal{D})$. This is, $\alpha_{\varepsilon}$ is in fact a section of $\Omega_{X_{r}[\varepsilon] \mid \mathcal{N}}^{1} \otimes \pi_{1}^{*} \mathcal{O}_{X}(\mathcal{D})$ on $\mathcal{W}[\varepsilon]$ of the form $\alpha_{\varepsilon}=\alpha+\varepsilon \eta$ for some $\eta \in H^{0}\left(\mathcal{W}, j_{*}\left(\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right)\right)$. Since $\operatorname{codim}(X \backslash \mathcal{W}) \geq 2$, we can extend $\alpha_{\varepsilon}$ to a degree $\mathcal{D}$ first order deformation of $\alpha$ on $X$ and the theorem follows.

Now we shall characterize the deformations of the form $F_{\varepsilon}^{*}(\alpha)$. For this, we recall from [23, Section 3.1, p. 1598] the definition of the module of graded projective unfoldings. Unless stated otherwise, we consider $\omega \in \mathcal{F}_{1}\left(\mathbb{P}^{n}, \ell\right)$.

Definition 4.7. We define the $S$-module of graded projective unfoldings of $\omega$ as

$$
\mathbb{U}(\omega)=\left\{(h, \eta) \in S \oplus \Omega_{S}^{1}: L_{R}(h) d \omega=L_{R}(\omega) \wedge(\eta-d h)\right\} / S .(0, \omega)
$$

For $r \in \mathbb{N}$, the homogeneous component of degree $r$ can be written as

$$
\begin{equation*}
\mathbb{U}(\omega)(r)=\left\{(h, \eta) \in S_{r} \oplus \Omega_{S}^{1}(r): r h d \omega=\ell \omega \wedge(\eta-d h)\right\} / S_{r-\ell} \cdot(0, \omega) \tag{4.5}
\end{equation*}
$$

For $(h, \eta) \in \mathbb{U}(\omega)(r)$ and $f \in S_{s}$, the graded $S$-module structure is defined by

$$
f \cdot(h, \eta)=\left(f h, \frac{(r+s)}{r} f \eta+\frac{1}{r}(r h d f-s f d h)\right) \in \mathbb{U}(\omega)(r+s)
$$

Remark 4.8. By [23, Proposition 3.2, p. 1598] every pair $(h, \eta) \in \mathbb{U}(\omega)(r)$ belongs to $H^{0}\left(\mathbb{P}^{n},\left(\mathcal{O}_{\mathbb{P}^{n}} \oplus \Omega_{\mathbb{P}^{n}}^{1}\right)(r)\right)$. Then $\mathbb{U}(\omega)(\ell)$ coincides with $U(\omega)$, see Definition 4.4.

Definition 4.9. Let $\pi_{1}: \mathbb{U}(\omega) \rightarrow S$ be the projection to the first coordinate. We define the unfoldings ideal associated to $\omega$ as

$$
I(\omega)=\pi_{1}(\mathbb{U}(\omega))=\left\{h \in S: h d \omega=\omega \wedge \widetilde{\eta} \text { for some } \widetilde{\eta} \in \Omega_{S}^{1}\right\}
$$

Remark 4.10. It is shown in [23, Proposition 3.6, p. 1599] that $\pi_{1}$ is actually an isomorphism between the graded modules $\mathbb{U}(\omega)$ and $I(\omega)$ whenever $\operatorname{codim}(\operatorname{Sing}(\omega)) \geq 2$. Then, the space of unfoldings of $\omega$ is completely determined by its ideal.

By [20, Proposition 4.7, p. 1035] we get the following chain of inclusions.
Proposition 4.11. With the notations above, we have $J(\omega) \subseteq I(\omega) \subseteq K(\omega)$.
Let $X$ be a simplicial complete toric surface, $\alpha \in H^{0}\left(X, j_{*}\left(\left.\Omega_{X_{r}}^{1} \otimes \mathcal{O}_{X}(\mathcal{D})\right|_{X_{r}}\right)\right)$ of the form $\alpha=\sum_{i=1}^{m} A_{i}(z) d z_{i}$ and $F: \mathbb{P}^{n} \rightarrow X$ be a dominant rational map with a complete polynomial lifting of degree $\bar{e}$. In the following proposition we compute the unfoldings ideal $I(\omega)$ for $\omega=F^{*}(\alpha) \in \mathcal{F}_{1}\left(\mathbb{P}^{n}, \ell\right)$ under certain generic assumptions.

Lemma 4.12. With the notation above, we have

$$
\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle \subseteq I(\omega)
$$

Proof. This follows directly from Lemma 3.22.
Proposition 4.13. Suppose $(F, \alpha)$ is affinely generic and $F^{*}: S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat. Then

$$
I(\omega)=K(\omega)=\left\langle A_{1}(F), \ldots, A_{m}(F)\right\rangle
$$

Proof. Just combine Corollary 3.23, the lemma above and Proposition 4.11.
Theorem 4.14. Suppose $(F, \alpha)$ is a affinely generic and $F^{*}: S_{X} \rightarrow S_{\mathbb{P} n}$ is flat. Let $\omega_{\varepsilon}$ be a first order deformation of $\omega$. Then, $\omega_{\varepsilon}$ is induced by a first order unfolding if and only if there exist homogeneous polynomials $G_{j}$ of degrees $\operatorname{deg}\left(G_{j}\right)=\operatorname{deg}\left(F_{j}\right)$ such that

$$
\omega_{\varepsilon}=(F+\varepsilon G)^{*}(\alpha)
$$

Proof. First, observe that for any $G_{1}, \ldots, G_{m}$ by straightforward calculation the first order deformation $(F+\varepsilon G)^{*}(\alpha)$ can be expressed as
$(F+\varepsilon G)^{*}(\alpha)=\omega+\varepsilon\left(\sum_{i=1}^{m} \sum_{j=1}^{m} \frac{\partial A_{i}}{\partial z_{j}}(F) G_{j} d F_{i}+\sum_{i=1}^{m} A_{i}(F) d G_{i}\right) \in H^{0}\left(\mathbb{P}^{n}[\varepsilon], \Omega_{\mathbb{P}^{n}[\varepsilon] \mid \mathcal{N}}^{1}(\ell)\right)$.

Notice that a first order deformation $\omega_{\varepsilon}=\omega+\varepsilon \eta$ is induced by a first order unfolding, in the sense of Lemma 4.5, if and only if there exists some $G \in S_{\mathbb{P}^{n}}$ of degree $\ell$ such that $(G, \eta) \in U(\omega)=\mathbb{U}(\omega)(\ell)$. Recall from Remark 4.10 that $\mathbb{U}(\omega) \simeq I(\omega)$ as graded $S_{\mathbb{P}^{n}}$ modules. Since $(F, \alpha)$ is affinely generic, by Proposition 4.13 we have $I(\omega)=\left\langle A_{k}(F)\right\rangle_{k=1}^{m}$.

We proceed to find $\eta_{k}$ such that $\left(A_{k}(F), \eta_{k}\right) \in \mathbb{U}\left(\ell-e_{k}\right)$. By Lemma 3.22, if

$$
\widetilde{\eta}_{k}=F^{*}\left(\imath_{\partial / \partial z_{k}} d \alpha\right)=\sum_{j \neq k}\left(\frac{\partial A_{j}}{\partial z_{k}}(F)-\frac{\partial A_{k}}{\partial z_{j}}(F)\right) d F_{j}
$$

then we have $A_{k}(F) d \omega=\omega \wedge \widetilde{\eta}_{k}$. Now we need to determine $\eta_{k}$ satisfying the equation

$$
\left(\ell-e_{k}\right) A_{k}(F) d \omega=\ell \omega \wedge\left(\eta_{k}-d A_{k}(F)\right)
$$

Thereby, the relation between $\widetilde{\eta}_{k}$ and $\eta_{k}$ is given by $\eta_{k}=\frac{\ell-e_{k}}{\ell} \widetilde{\eta}_{k}+d A_{k}(F)$. This implies

$$
\eta_{k}=\frac{\ell-e_{k}}{\ell} \sum_{j \neq k}\left(\frac{\partial A_{j}}{\partial z_{k}}(F)-\frac{\partial A_{k}}{\partial z_{j}}(F)\right) d F_{j}+d A_{k}(F)
$$

Since $\mathbb{U}(\omega) \simeq I(\omega)$ as graded $S_{\mathbb{P}^{n}}$-modules, it follows that $\omega_{\varepsilon}$ is induced by a first order unfolding if and only if

$$
\eta=\sum_{k=1}^{m} \pi_{2}\left(G_{k} \cdot\left(A_{k}(F), \eta_{k}\right)\right)
$$

for some $G_{k} \in S_{\mathbb{P}^{n}}$ of degree $e_{k}$. Finally, using the module structure of Definition 4.7 the following calculation implies our claim:

$$
\begin{array}{r}
\pi_{2}\left(G_{k} \cdot\left(A_{k}(F), \eta_{k}\right)\right)=\frac{\ell}{\ell-e_{k}} G_{k} \eta_{k}+\frac{1}{\ell-e_{k}}\left(\left(\ell-e_{k}\right) A_{k}(F) d G_{k}-e_{k} G_{k} d A_{k}(F)\right)= \\
=\frac{\ell}{\ell-e_{k}} G_{k}\left(\frac{\ell-e_{k}}{\ell} \eta_{k}+d A_{k}(F)\right)+\frac{1}{\ell-e_{k}}\left(\left(\ell-e_{k}\right) A_{k}(F) d G_{k}-e_{k} G_{k} d A_{k}(F)\right)= \\
=G_{k} \eta_{k}+G_{k} d A_{k}(F)+A_{k}(F) d G_{k}=\sum_{j=1}^{m} \frac{\partial A_{j}}{\partial z_{k}}(F) G_{k} d F_{j}+A_{k}(F) d G_{k}
\end{array}
$$

We end this section by describing some properties of $I(\omega)$ under less restrictive assumptions on the pair $(F, \alpha)$. We refer the reader to [21, Remark 3.4, p. 8] for a sheaftheoretic version of the following definition.

Definition 4.15. Let $X$ be a simplicial complete toric variety and $\alpha \in \mathcal{F}_{1}(X, \mathcal{D})$. We define the unfoldings ideal of $\alpha$ as

$$
I(\alpha)=\left(\alpha \wedge \Omega_{S}^{1}: d \alpha\right)=\left\{h \in S: h d \alpha=\alpha \wedge \widetilde{\eta}, \text { for some } \widetilde{\eta} \in \Omega_{S}^{1}\right\}
$$

Remark 4.16. As in Proposition 4.11, we have that $J(\alpha) \subset I(\alpha) \subset K(\alpha)$. Consequently, straightforward computation shows

$$
\begin{equation*}
J(\omega) \subset F^{*}(J(\alpha)) \subset F^{*}(I(\alpha)) \subset I(\omega) \subset K(\omega) \tag{4.6}
\end{equation*}
$$

Now, we introduce a slight variant of [20, Definition 4.8, p. 1035].
Definition 4.17. We say that a prime ideal $\mathfrak{p} \subset S$ is a division point of $\alpha$ if $1 \in I(\alpha)_{\mathfrak{p}}$.

These points are exactly the primes $\mathfrak{p}$ around which $d \omega_{\mathfrak{p}}$ is divisible by $\omega_{\mathfrak{p}}$, i.e., there exists a local 1 form $\eta$ around $\mathfrak{p}$ such that $d \omega_{\mathfrak{p}}=\omega_{\mathfrak{p}} \wedge \eta$. Following [20, Remark 4.11, p. 1035] it is reasonable to assume that every $\mathfrak{p}$ outside $\mathcal{K}(\omega)$ is a division point of $\omega$. The next result provides further information on the inclusions in Eq. (4.6) under weaker hypotheses on the differential form $\alpha$.
Proposition 4.18. Let $X$ be a simplicial complete toric surface. With the notation above, suppose the pair $(F, \alpha)$ is generic, $F^{*}: S_{X} \rightarrow S_{\mathbb{P}^{n}}$ is flat and $I_{i j}$ is a division point of $\alpha$ for every $(i, j) \in \Gamma_{\alpha} \backslash \Gamma_{\alpha}, \mathcal{K}$. Then,

1) $\left(I(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right)=\left(K(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right)$ defines the same closed subscheme as $\left(F^{*}(J(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right)$ and
2) $\sqrt{F^{*}(I(\alpha))}=\sqrt{I(\omega)}=\sqrt{K(\omega)}$.

Proof. Since $(F, \alpha)$ is generic, we have $\left(J(\alpha): I_{Z}^{\infty}\right)=\left(I(\alpha): I_{Z}^{\infty}\right)=\left(K(\alpha): I_{Z}^{\infty}\right)$. Being $F^{*}$ flat and using again [5, Chap. 1, 2, Remarque, p. 41], it follows that

$$
\begin{equation*}
\left(F^{*}(J(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right)=\left(F^{*}(I(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right)=\left(F^{*}(K(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right) \tag{4.7}
\end{equation*}
$$

Let $I$ be the irrelevant ideal of $\mathbb{P}^{n}$. By [7, Proposition 3.1, p. 863] we know that $(I(\omega)$ : $\left.I^{\infty}\right)=I(\omega)$. Then by Eq. (4.6) we also get

$$
\begin{array}{r}
\left(\left(F^{*}(J(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right): I^{\infty}\right) \subset\left(I(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right) \subset\left(K(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right) \subset  \tag{4.8}\\
\subset\left(\left(K(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right): I^{\infty}\right) .
\end{array}
$$

Recall from Theorem 3.21 that $F^{*}(K(\alpha))$ and $K(\omega)$ define the same closed subscheme. This fact combined with Eq. (4.7) implies that

$$
\left(\left(F^{*}(J(\alpha)): F^{*}\left(I_{Z}\right)^{\infty}\right): I^{\infty}\right)=\left(\left(K(\omega): F^{*}\left(I_{Z}\right)^{\infty}\right): I^{\infty}\right),
$$

and then our first claim follows from Eq. (4.8).
Finally, since $I_{i j}$ is a division point of $\alpha$ for every $(i, j) \in \Gamma_{\alpha} \backslash \Gamma_{\alpha, \mathcal{K}}$, the associated primes of $I(\alpha)$ and $K(\alpha)$ containing $I_{Z}$ are the same. Therefore, by Lemma 3.18 the primes in the support of $F^{*}(I(\alpha)), I(\omega)$ and $K(\omega)$ containing $F^{*}\left(I_{Z}\right)$ coincide as well, which implies our second claim.
