# Multivariate sparse clustering for extremes

#### Abstract

Identifying directions where extreme events occur is a major challenge in multivariate extreme value analysis. In this paper, we use the concept of sparse regular variation introduced by Meyer and Wintenberger (2021) to infer the tail dependence of a random vector $\mathbf{X}$. This approach relies on the Euclidean projection onto the simplex which better exhibits the sparsity structure of the tail of $\mathbf{X}$ than the standard methods. Our procedure based on a rigorous methodology aims at capturing clusters of extremal coordinates of $\mathbf{X}$. It also includes the identification of the threshold above which the values taken by $\mathbf{X}$ are considered as extreme. We provide an efficient and scalable algorithm called MUSCLE and apply it on numerical examples to highlight the relevance of our findings. Finally we illustrate our approach with financial return data.


Keywords: Euclidean projection onto the simplex, model selection, multivariate extremes, regular variation

## 1 Introduction

The aim of this article is to study the tail dependence of a random vector $\mathbf{X} \in \mathbb{R}_{+}^{d}$ with continuous marginals. In this context it is customary to assume that $\mathbf{X}$ is regularly varying (see e.g. Resnick (1987), Resnick (2007), Hult and Lindskog (2006)), i.e. that there exist $a_{n} \rightarrow \infty$ and a non-zero Radon measure $\mu$ on the Borel $\sigma$-field of $\mathbb{R}_{+}^{d} \backslash\{\mathbf{0}\}$ such that

$$
\begin{equation*}
n \mathbb{P}\left(a_{n}^{-1} \mathbf{X} \in \cdot\right) \xrightarrow{v} \mu(\cdot), \quad n \rightarrow \infty, \tag{1.1}
\end{equation*}
$$

where $\xrightarrow{v}$ denotes the vague convergence in the space of nonnegative Radon measures on $[0, \infty]^{d} \backslash\{\mathbf{0}\}$. The limit measure $\mu$ is called the tail measure of the regularly varying vector $\mathbf{X}$. It satisfies the homogeneity property $\mu(t B)=t^{-\alpha} \mu(B)$, for any set $B$ in $\mathbb{R}_{+}^{d} \backslash\{\mathbf{0}\}$ and any $t>0$. The parameter $\alpha$ is called the tail index of $\mathbf{X}$. It highlights the intensity of the extremes. The smaller this index is, the heaviest the tail of $\mathbf{X}$ is likely to be.

It is often more convenient to decompose the former convergence into a radial and an angular part (see for instance Beirlant et al. (2006), Section 8.2.3): the regular variation property is equivalent to the convergence

\mathbb{P}((|\mathbf{X}| / t, \mathbf{X} /|\mathbf{X}|) \in \cdot||\mathbf{X}|>t) \xrightarrow{w} \mathbb{P}((Y, \mathbf{\Theta}) \in \cdot), \quad t \rightarrow \infty, \tag{1.2}
\end{equation*}
$$

where $\xrightarrow{w}$ denotes weak convergence, and where $\boldsymbol{\Theta}$ is a random vector on the positive unit sphere $\left\{\mathbf{x} \in[0, \infty)^{d}:|\mathbf{x}|=1\right\}$ independent of the random variable $Y$ which satisfies $\mathbb{P}(Y>y)=y^{-\alpha}, y>1$. The random vector $\Theta$ is called the spectral vector and its distribution $\mathbb{P}(\boldsymbol{\Theta} \in \cdot)$ the spectral measure. Its support indicates the directions supported by large events. The subspaces of the positive unit sphere on which the spectral vector puts mass correspond to the directions where large events are likely to appear. Note that the choice of the norm $|\cdot|$ in Equation (1.2) is arbitrary. In this article we choose the $\ell^{1}$-norm and thus focus on the simplex $\mathbb{S}_{+}^{d-1}:=\left\{\mathbf{x} \in[0, \infty)^{d}: x_{1}+\cdots+x_{d}=1\right\}$.

In order to study the support of the spectral measure we partition the simplex in terms of the nullity of some coordinates (Chautru (2015), Goix et al. (2017), Simpson et al. (2020)). For $\beta \subset\{1, \ldots, d\}$ the subspace $C_{\beta}$ is defined as

$$
\begin{equation*}
C_{\beta}=\left\{\mathbf{x} \in \mathbb{S}_{+}^{d-1}: x_{i}>0 \text { for } i \in \beta, x_{i}=0 \text { for } i \notin \beta\right\} \tag{1.3}
\end{equation*}
$$

This partition highlights the extremal structure of $\mathbf{X}$. For a given $\beta \subset\{1, \ldots, d\}$ the inequality $\mathbb{P}\left(\Theta \in C_{\beta}\right)>0$ implies that the marginals $X_{j}, j \in \beta$, are likely to take simultaneously large values while the ones for $j \in \beta^{c}$ are of smaller order. Hence the identification of clusters of directions $\beta$ which concentrate the mass of the spectral measure brings out groups of coordinates which can be large together.

Highlighting such groups is at the core of several recent papers on multivariate extremes, all of them relying on some hyperparameters (Chiapino and Sabourin (2016), Goix et al. (2017), Chiapino et al. (2019), Simpson et al. (2020)). This approach faces a crucial issue, namely the difference of support between $\Theta$ and $\mathbf{X} /|\mathbf{X}|$. Indeed, the spectral measure is likely to place mass on low-dimensional subspaces $C_{\beta}, \beta \neq\{1, \ldots, d\}$. We say that this measure is sparse when the number of coordinates in the associated clusters $\beta$ is small. Conversely, the distribution of the self-normalized vector $\mathbf{X} /|\mathbf{X}|$ only concentrates on the subset $C_{\{1, \ldots, d\}}$ since $\mathbf{X}$ has continuous marginals.

All the existing approaches proposed in the literature rely on nonstandard regular variation for which $\alpha=1$ and all marginals are tail equivalent, possibly after a standardization. However, sparsity arises all the more for standard regular variation (1.2). In this case, it is possible that the marginals of $\mathbf{X}$ are not tail equivalent so that the support of the spectral measure is included in $\mathbb{S}_{+}^{r-1}$ for $r \ll d$. This is the approach we use in this article. For a comparison of standard and nonstandard regular variation we refer to Resnick (2007), Section 6.5.6.

In this article we provide a method which highlights the sparsity of the tail structure by exhibiting sparse clusters of extremal directions. By sparse clusters we mean groups of coordinates $\beta$ which contain a reduced number of directions compared to $d$. We refer to this method as sparse clustering. The statistical procedure we propose to achieve this clustering relies on the framework of Meyer and Wintenberger (2021) which allows to circumvent the estimation's issue that arises with the spectral measure. The angular component $\mathbf{X} /|\mathbf{X}|$ in (1.2) is replaced by $\pi(\mathbf{X} / t)$, where $\pi$ denotes the Euclidean projection onto $\mathbb{S}_{+}^{d-1}$ (Duchi et al. (2008), Kyrillidis et al. (2013), Condat (2016)). This substitution leads to the concept of sparse regular variation. A random vector $\mathbf{X}$ is said to be sparsely regularly varying if

$$
\begin{equation*}
\mathbb{P}((|\mathbf{X}| / t, \pi(\mathbf{X} / t)) \in \cdot||\mathbf{X}|>t) \xrightarrow{w} \mathbb{P}((Y, \mathbf{Z}) \in \cdot), \quad t \rightarrow \infty, \tag{1.4}
\end{equation*}
$$

where $\mathbf{Z}$ is a random vector on the simplex $\mathbb{S}_{+}^{d-1}$ and $\mathbb{P}(Y>y)=y^{-\alpha}, y>1$. Meyer and Wintenberger (2021) proved that under mild assumptions both concepts of regular variation (1.2) and (1.4) are equivalent (see Theorem 1 in their article). In particular, the relation $\mathbf{Z}=\pi(Y \mathbf{\Theta})$ holds.

Similarly to the existing approaches with $\boldsymbol{\Theta}$, we are willing to capture the tail dependence of $\mathbf{X}$ via the identification of the clusters $\beta$ which satisfy $\mathbb{P}\left(\mathbf{Z} \in C_{\beta}\right)>0$. We call such $\beta$ 's the extremal clusters. They can be identified via the study of $\pi(\mathbf{X} / t)$ since the convergence $\mathbb{P}\left(\pi(\mathbf{X} / t) \in C_{\beta}| | \mathbf{X} \mid>t\right) \rightarrow \mathbb{P}\left(\mathbf{Z} \in C_{\beta}\right)$ holds for any $\beta \subset\{1, \ldots, d\}$ (see Meyer and Wintenberger (2021), Proposition 2). This encourages to consider for any $\beta$ the quantity

$$
\begin{equation*}
T_{n, k}(\beta)=\sum_{j=1}^{k} \mathbb{1}\left\{\pi\left(\mathbf{X}_{(j)} /\left|\mathbf{X}_{(k+1)}\right|\right) \in C_{\beta}\right\} \tag{1.5}
\end{equation*}
$$

where $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$ is a sample of iid sparsely regularly varying random vectors, $k=k_{n}$ is an intermediate sequence called level which satisfies $k \rightarrow \infty$ and $k / n \rightarrow 0$, and $\mathbf{X}_{(j)}$ denotes
the observation with $j$-th largest norm: $\left|\mathbf{X}_{(1)}\right| \geq \cdots \geq\left|\mathbf{X}_{(n)}\right|$.
It turns out that the number of positive $T_{n, k}(\beta)$ often overestimates the total number of extremal clusters. We call the clusters which satisfy $T_{n, k}(\beta)>0$ and $\mathbb{P}\left(\mathbf{Z} \in C_{\beta}\right)=0$ the biased clusters. The approach we propose to reduce this bias relies on model selection. It consists in fitting a multinomial model to the data and to compare the Kullback-Leibler divergence between the data and this theoretical model. We obtain a minimization criterion based on a penalized likelihood similarly to Akaike's criterion (Akaike (1973)). This approach provides a way to select the appropriate number of extremal clusters for a given level $k$. This is the first step of our procedure, which we call the bias selection.

The second step then consists in extending the procedure in order to automatically select an appropriate level $k$. We call this step the level selection. Several authors have pointed out that choosing a reasonable level, or equivalently a reasonable threshold above which the data are considered as extreme, is a challenging task in practice. This issue is tackled in a few articles (Stărică (1999), Abdous and Ghoudi (2005), Kiriliouk et al. (2019), Wan and Davis (2019), see also the review on marginals threshold selection by Caiero and Gomes (2015)). It turns out that in the sparse regular variation framework the choice of such a level and the identification of the extremal clusters are closely related. Therefore our approach consists in extending the bias selection by including $k$ as a parameter to tune. Since Akaike's procedure only holds for a constant sample size we have to adapt the standard approach to an extreme setting where the number of extremes varies. Therefore we include the non-extreme values in the model and separate the data into an extreme group and a non-extreme one. The procedure then provides a level $k$ for which this separation is reasonable. To the best of our knowledge, our work is the first one which simultaneously tackles this issue with the study of tail dependence.

Outline of the paper The paper is organized as follows. Section 2 introduces the theoretical background on sparse regular variation and level selection that is needed throughout the paper. In Section 3 we introduce the statistical framework of our method and establish asymptotic results for the estimators of the probabilities $\mathbb{P}\left(\mathbf{Z} \in C_{\beta}\right)$. Section 4 details the methodology of our approach. We develop the two steps of the model selection, the bias selection and the level selection. In Section 5 we illustrate our findings on numerical results and compare our approach with the existing procedures proposed by Goix et al. (2017) and Simpson et al. (2020). Finally we illustrate our approach on financial data in Section 6. The proofs are given in the Supplementary Material.

## 2 Preliminaries

### 2.1 Notation

Symbols in bold such as $\mathbf{x} \in \mathbb{R}^{d}$ are column vectors with components denoted by $x_{j}, j \in$ $\{1, \ldots, d\}$. Operations and relationships involving such vectors are meant componentwise. If $\mathbf{x}=\left(x_{1}, \ldots, x_{d}\right)^{\top} \in \mathbb{R}^{d}$, then $\operatorname{Diag}(\mathbf{x})$ or $\operatorname{Diag}\left(x_{1}, \ldots, x_{d}\right)$ denotes the diagonal matrix whose diagonal is $\mathbf{x}$. We denote by $I d_{s}$ the identity matrix of $\mathbb{R}^{s}$. We define $\mathbb{R}_{+}^{d}:=\left\{\mathbf{x} \in \mathbb{R}^{d}\right.$ : $\left.x_{1} \geq 0, \ldots, x_{d} \geq 0\right\}, \mathbf{0}:=(0, \ldots, 0)^{\top} \in \mathbb{R}^{d}$, and $\mathbf{1}:=(1, \ldots, 1)^{\top} \in \mathbb{R}^{d}$. For $j=1, \ldots, d, \mathbf{e}_{j}$ denotes the $j$-th vector of the canonical basis of $\mathbb{R}^{d}$. In all the paper we denote the $\ell^{1}$-norm by $|\cdot|$. For $d \geq 1$ we denote by $\mathcal{P}_{d}$ the power set of $\{1, \ldots, d\}$ and by $\mathcal{P}_{d}^{*}$ the set $\mathcal{P}_{d} \backslash\{\emptyset\}$. If $\beta \in \mathcal{P}_{d}$ we denote by $|\beta|$ the number of coordinates in $\beta$.

### 2.2 Sparse regular variation

We consider a sparsely regularly varying random vector $\mathbf{X} \in \mathbb{R}_{+}^{d}$ as defined in (1.4) and focus on its angular component $\pi(\mathbf{X} / t)$ :

$$
\begin{equation*}
\mathbb{P}(\pi(\mathbf{X} / t) \in \cdot||\mathbf{X}|>t) \xrightarrow{w} \mathbb{P}(\mathbf{Z} \in \cdot), \quad t \rightarrow \infty \tag{2.1}
\end{equation*}
$$

The orthogonal projection on the simplex enjoys many sparsity properties which justifies its use to study high-dimensional data. The vector $\pi(\mathbf{X} / t)$ may put mass in every subspace $C_{\beta}$ even if $\mathbf{X}$ is almost surely positive. This is a key difference with the self-normalized vector $\mathbf{X} /|\mathbf{X}|$ which shares the same sparsity properties as $\mathbf{X}$, and therefore always concentrates on the interior $C_{\{1, \ldots, d\}}$ of the simplex.

Remark 1. Our statistical methodology exhibits the choice of a level $k$ which corresponds to the number of vectors among a sample $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$ which are considered as extreme. This is achieved by studying also the $n-k$ non-extreme vectors. In terms of the convergence (2.1) the latter vectors correspond to vectors whose norm is below the threshold $t=\left|\mathbf{X}_{(k+1)}\right|$. In order to propose a consistent methodology based on these non-extreme vectors we need to slightly modify the projection and to consider $\pi$ as the Euclidean projection onto the unit positive $\ell^{1}$-ball $\mathcal{B}_{+}^{d}=\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: x_{1}+\ldots+x_{d} \leq 1\right\}$. It does not change the theory of sparse regular variation since projecting onto the sphere or the ball is equivalent for vectors with norm larger than 1 . The only difference is that a vector $\mathbf{v}$ such that $|\mathbf{v}|<1$ now satisfies $\pi(\mathbf{v})=\mathbf{v}$.

Our aim is to infer the distribution of the angular vector $\mathbf{Z}$ in order to identify the extremal directions of $\mathbf{X}$. This is achieved by focusing on the probabilities $p^{*}(\beta):=\mathbb{P}(\mathbf{Z} \in$ $C_{\beta}$ ) for $\beta \in \mathcal{P}_{d}^{*}$. We define the set of extremal clusters

$$
\begin{equation*}
\mathcal{S}^{*}(\mathbf{Z}):=\left\{\beta: p^{*}(\beta)>0\right\} \tag{2.2}
\end{equation*}
$$

and denote by $s^{*}$ its cardinality. Meyer and Wintenberger (2021) proved that for any $\beta$ we have the convergence

$$
\begin{equation*}
\mathbb{P}\left(\pi(\mathbf{X} / t) \in C_{\beta}| | \mathbf{X} \mid>t\right) \rightarrow p^{*}(\beta), \quad t \rightarrow \infty \tag{2.3}
\end{equation*}
$$

This convergence allows one to study the behavior of $\mathbf{Z}$ on the subsets $C_{\beta}$ via the one of $\pi(\mathbf{X} / t)$. The aim of this paper is to build a statistical procedure to identify the extremal clusters $\beta \in \mathcal{S}^{*}(\mathbf{Z})$.

Example 1 (Discrete spectral measure). For $\beta \in \mathcal{P}_{d}^{*}$, we denote by $\mathbf{e}(\beta)$ the sum $\sum_{j \in \beta} \mathbf{e}_{j}$ so that the vector $\mathbf{e}(\beta) /|\beta|$ belongs to the simplex $\mathbb{S}_{+}^{d-1}$ (recall that $|\beta|$ corresponds to the length of the cluster $\beta$ ). We consider the following family of discrete distributions on the simplex:

$$
\begin{equation*}
\sum_{\beta \in \mathcal{P}_{d}^{*}} c(\beta) \delta_{\mathbf{e}(\beta) /|\beta|}, \tag{2.4}
\end{equation*}
$$

where $(c(\beta))_{\beta}$ is a probability vector on $\mathbb{R}^{2^{d}-1}$ (see Segers (2012), Example 3.3). Meyer and Wintenberger (2021) proved that in this case we have $\mathbf{Z}=\boldsymbol{\Theta}$ a.s. and that the family of distribution in (2.4) is the only possible discrete distributions for Z. For this type of distributions we have $\mathcal{S}^{*}(\mathbf{Z})=\{\beta: c(\beta)>0\}$.

If we choose $c(\beta)=0$ for all $\beta$ 's except the ones of length 1 then the spectral measure becomes $\sum_{j=1}^{d} c_{j} \delta_{\mathbf{e}_{j}},\left(c_{j}\right)_{1 \leq j \leq d} \in \mathbb{S}_{+}^{d-1}$. This corresponds to asymptotic independence (see e.g. Ledford and Tawn (1996), Heffernan and Tawn (2004), de Haan and Ferreira (2006), Section 6.2).

If $\Theta$ places mass on a subset $C_{\beta}$ then so does $\mathbf{Z}$, but the converse is not true. Thus the set of clusters we identify with our method includes the usual ones on which $\Theta$ puts mass. However, the notion of maximal cluster (an extremal cluster which is not included
in another extremal one) defined by Meyer and Wintenberger (2021) coincide for $\boldsymbol{\Theta}$ and $\mathbf{Z}$ and links both types of clusters.

Example 2. Consider a spectral measure in dimension 2 with $\Theta_{1} \sim \mathcal{U}(0,1)$. Then the distribution of $\mathbf{Z}$ is given by $Z_{1}=\frac{1}{4} \delta_{0}+\frac{1}{2} \mathcal{U}(0,1)+\frac{1}{4} \delta_{1}$, see Meyer and Wintenberger (2021), Example 1. In this case the clusters $\{1\}$ and $\{2\}$ are extremal clusters for $\mathbf{Z}$ but not for $\boldsymbol{\Theta}$. The only maximal cluster for $\mathbf{Z}$ and $\boldsymbol{\Theta}$ is $C_{\{1,2\}}$.

### 2.3 Impact of the level on the sparsity structure

We briefly explain in this section how the choice of a threshold $t>0$ influences the sparsity of the projected vector $\pi(\mathbf{x} / t)$ for $\mathbf{x} \in \mathbb{R}_{+}^{d}$. For $t>0$, let us denote by $\pi_{t}$ the Euclidean projection onto the positive sphere $\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: x_{1}+\cdots+x_{d}=t\right\}$. The relation $\pi_{t}(\mathbf{x})=$ $t \pi(\mathbf{x} / t)$ implies that the sparsity structures of $\pi_{t}(\mathbf{x})$ and $\pi(\mathbf{x} / t)$ are the same. The number of null coordinates of the projected vector $\pi_{t}(\mathbf{x})$ strongly depends on the choice of $t$. Indeed, if $t$ is close to $|\mathbf{x}|$, then $\pi_{t}(\mathbf{x})$ has only non-null coordinates (as soon as $\mathbf{x}$ itself has non-null coordinates). On the contrary, the vector $\pi_{t}(\mathbf{x})$ is sparse if $t \ll|\mathbf{x}|$.

Moving on to a statistical framework, we consider a sample $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$ of iid random vectors in $\mathbb{R}_{+}^{d}$. It is common in extreme value theory to define a level $k=k_{n}$ satisfying $k \rightarrow \infty$ and $k / n \rightarrow 0$ (see e.g. de Haan and Ferreira (2006), Beirlant et al. (2006), Resnick (2007)). It leads to the choice of a threshold $t=u_{n} \rightarrow \infty$ such that

$$
\begin{equation*}
\frac{n}{k} \mathbb{P}\left(|\mathbf{X}|>u_{n}\right) \rightarrow 1, \quad n \rightarrow \infty \tag{2.5}
\end{equation*}
$$

The level $k$ must be seen as the number of extreme vectors used for the statistical analysis. It is therefore natural to consider the $k$-largest vectors in terms of their norm, i.e. the vectors $\mathbf{X}_{(1)}, \cdots, \mathbf{X}_{(k)}$ where $\left|\mathbf{X}_{(j)}\right|$ denotes the $j$-th largest norm $\left|\mathbf{X}_{(1)}\right| \geq \cdots \geq\left|\mathbf{X}_{(n)}\right|$. Note
that since we assumed the marginals of $\mathbf{X}$ to be continuous, these inequalities are strict almost surely. This encourages to work with the random threshold $\left|\mathbf{X}_{(k+1)}\right|$. By Vervaat's Lemma (see Lemma 1.0.2 in de Haan and Ferreira (2006)), the assumption (2.5) implies that $\left|\mathbf{X}_{(k+1)}\right| / u_{n}$ converges to 1 in probability as $n \rightarrow \infty$.

(a) For $k=12$ the points in the blue area are projected on the interior of the positive sphere $\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: y_{1}+\cdots+y_{d}=u_{n}\right\}$ while the ones in the red area are projected on the edges of this sphere.

(b) For $k=8$ all points in the blue area are projected on the interior of the positive sphere

$$
\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: y_{1}+\cdots+y_{d}=u_{n}\right\}
$$

Figure 1: Influence of the level $k$ on the sparsity structure of the data. The threshold $u_{n}$ corresponds to the norm of the vector $\mathbf{X}_{(k+1)}$ which is represented by a bullet.

A small $k$ corresponds to a large threshold $u_{n}$ and vice versa. In this case only a few extreme vectors are kept for the statistical analysis and they are close to the threshold. Thus, these vectors are projected on subsets $C_{\beta}$ with large $|\beta|$ 's which means that the projected vectors are not very sparse. On the other hand, choosing a large $k$ means choosing a low threshold $u_{n}$ so that we move away from the extreme region. In this case the largest
vectors are projected on subsets $C_{\beta}$ with small $|\beta|$ 's, i.e. the projected vectors are sparse. We refer to Figure 1 for an illustration of these two cases. Following these remarks we have to make a balanced choice between providing a sparse structure for the data and staying in the extreme region.

## 3 Asymptotic analysis of the extremal clusters

We consider a sequence of iid sparsely regularly varying random vectors $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$ with generic distribution $\mathbf{X}$ and angular limit vector $\mathbf{Z}$. We also consider a level $k$ satisfying $k \rightarrow \infty$ and $k / n \rightarrow 0$ and a threshold $u_{n}$ such that (2.5) is satisfied. In order to identify the set $\mathcal{S}^{*}(\mathbf{Z})$ defined in $(2.2)$ we provide suitable estimators for the probabilities $p^{*}(\beta)$, $\beta \in \mathcal{P}_{d}^{*}$. We define the estimators

$$
T_{n}(x, \beta)=\sum_{j=1}^{n} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \beta)\right\}}, \quad \beta \in \mathcal{P}_{d}^{*}, \quad x>0
$$

where $A(x, \beta)=\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: x|\mathbf{y}|>1, \pi(x \mathbf{y}) \in C_{\beta}\right\}$ so that the estimator $T_{n, k}(\beta)$ defined in (1.5) satisfies $T_{n, k}(\beta)=T_{n}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|, \beta\right)$. An empirical version of $\mathcal{S}^{*}(\mathbf{Z})$ is then given by

$$
\begin{equation*}
\widehat{\mathcal{S}}_{n}:=\left\{\beta \in \mathcal{P}_{d}^{*}: T_{n, k}(\beta)>0\right\} \tag{3.1}
\end{equation*}
$$

We denote by $\hat{s}_{n}$ the cardinality of this set. Finally, we define

$$
p_{n}(\beta)=\mathbb{P}\left(\pi\left(\mathbf{X} / u_{n}\right) \in C_{\beta}| | \mathbf{X} \mid>u_{n}\right), \quad \beta \in \mathcal{P}_{d}^{*}
$$

which converges to $p^{*}(\beta) \in \mathcal{P}_{d}^{*}$ for any $\beta$, see Equation (2.3).

### 3.1 The bias between $\widehat{\mathcal{S}}_{n}$ and $\mathcal{S}^{*}(\mathbf{Z})$

In this section we compare the set $\mathcal{S}^{*}(\mathbf{Z})$ with its empirical counterpart $\widehat{\mathcal{S}}_{n}$. We first establish the consistency of our estimator.

Proposition 1. For any $\beta \in \mathcal{P}_{d}^{*}$,

$$
\begin{equation*}
\frac{T_{n, k}(\beta)}{k}=\frac{1}{k} \sum_{j=1}^{k} \mathbb{1}_{\left\{\pi\left(\mathbf{X}_{(j)} /\left|\mathbf{X}_{(k+1)}\right|\right) \in C_{\beta}\right\}} \rightarrow p^{*}(\beta), \quad n \rightarrow \infty \tag{3.2}
\end{equation*}
$$

in probability.
The proof relies on Proposition 2.2 of de Haan and Resnick (1993). It suffices to prove that $\mathbf{Z}$ does not put any mass on the boundary of $\{|\mathbf{x}|>1\} \cap \pi^{-1}\left(C_{\beta}\right)$, which has already been established in Proposition 2 of Meyer and Wintenberger (2021).

Proposition 1 implies that if $p^{*}(\beta)=0$, i.e. if $\mathbf{Z}$ does not place mass on the subset $C_{\beta}$, then $T_{n, k}(\beta) / k$ becomes smaller and smaller as $n$ increases. Actually as soon as the dimension $d$ is large a lot of $T_{n, k}(\beta)$ 's are even equal to 0 since the number of extreme vectors, that is $k$, is far below the number of clusters, that is $2^{d}-1$.

In order to study the bias between $\widehat{\mathcal{S}}_{n}$ and $\mathcal{S}^{*}(\mathbf{Z})$ we focus on the speed of convergence of $\mathbb{P}\left(T_{n, k}(\beta)=0\right)$, and thus on the one of $\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)=\mathbb{P}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: x|\mathbf{y}|>1, \pi(x \mathbf{y}) \in\right.\right.$ $\left.C_{\beta}\right\}$ ). Meyer and Wintenberger (2021) established the equivalence

$$
\pi(\mathbf{x}) \in C_{\beta} \quad \text { if and only if } \quad \forall i \in \beta^{c}, \forall j \in \beta, x_{i} \leq \frac{\left|\mathbf{x}_{\beta}\right|}{|\beta|}<x_{j}
$$

In other words, all $x_{j}, j \in \beta$, should be of the same order, while the $x_{i}, i \in \beta^{c}$, should be of smaller order. We set $\mathbf{x}_{\beta, i}=\sum_{j \in \beta}\left(x_{j}-x_{i}\right)$ for any $i$ and define

$$
\mathbb{C}_{\beta}=\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: \min _{i \in \beta^{c}} \mathbf{x}_{\beta, i} \geq 0\right\}=\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: \sum_{j \in \beta}\left(x_{j}-\max _{i \in \beta^{c}} x_{i}\right) \geq 0\right\}
$$

which forms a cone of $\mathbb{R}_{+}^{d}$. Studying the convergence of $\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)$ then boils down to studying the asymptotic behavior of $\mathbf{X}$ on the cone $\mathbb{C}_{\beta}$. Based on the theory of hidden regular variation (HRV) by Lindskog et al. (2014), we make the following assumption on X .

Assumption (HRV). For every $\beta \in \mathcal{P}_{d}^{*}$ the vector $\mathbf{X}$ is regularly varying on $\mathbb{R}_{+}^{d} \backslash \mathbb{C}_{\beta}$ with tail index $\alpha(\beta)$ and exponent measure $\mu_{\beta}$ satisfying

$$
\mu_{\beta}\left(\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{x}_{\beta, i}<1, \min _{i \in \beta^{c}} \mathbf{x}_{\beta, i} \geq 1\right\}\right)>0
$$

This assumption allows one to deal with the asymptotic behavior of $\mathbb{P}\left(T_{n, k}(\beta)=0\right)$ even when $p^{*}(\beta)=0$, as stated in the following lemma.

Lemma 1. Under Assumption (HRV) we have for every $\beta \in \mathcal{P}_{d}^{*}$,

$$
\frac{\log \mathbb{P}\left(T_{n, k}(\beta)=0\right)}{-k p_{n}(\beta)} \rightarrow 1, \quad n \rightarrow \infty
$$

Lemma 1 encourages to focus on the quantity $k p_{n}(\beta)$ and to consider the set

$$
\begin{equation*}
\mathcal{S}_{\infty}=\left\{\beta \in \mathcal{P}_{d}^{*}: k p_{n}(\beta) \rightarrow \infty \text { as } n \rightarrow \infty\right\} \tag{3.3}
\end{equation*}
$$

We denote by $s_{\infty}$ its cardinality. This set contains $\mathcal{S}^{*}(\mathbf{Z})$ so that we have the inequality $s^{*} \leq s_{\infty}$. Subsequently, Lemma 1 implies that

$$
\mathbb{P}\left(\mathcal{S}_{\infty} \subset \widehat{\mathcal{S}}_{n}\right)=1-\mathbb{P}\left(\exists \beta \in \mathcal{S}_{\infty}, \beta \notin \widehat{\mathcal{S}}_{n}\right) \geq 1-\sum_{\beta \in \mathcal{S}_{\infty}} \mathbb{P}\left(T_{n, k}(\beta)=0\right) \rightarrow 1
$$

as $n \rightarrow \infty$. This leads to the following proposition.
Proposition 2. Under Assumption (HRV) the inclusions

$$
\mathcal{S}^{*}(\mathbf{Z}) \subset \mathcal{S}_{\infty} \subset \widehat{\mathcal{S}}_{n}
$$

hold true with probability converging to 1 .

These inclusions highlight the fact that the observations $T_{n, k}(\beta)$ tend to overestimate the number of clusters $\beta$ in $\mathcal{S}^{*}(\mathbf{Z})$. They imply that we only have a "one-side bias" composed of clusters that appear empirically but which theoretically do not contain any mass. One of the main challenge of our study is the derivation of the asymptotic properties of $T_{n, k}(\beta)$ for biased clusters $\beta \in \widehat{\mathcal{S}}_{n} \backslash \mathcal{S}^{*}(\mathbf{Z})$.

By Lemma 1 the inclusion $\widehat{\mathcal{S}}_{n} \subset \mathcal{S}_{\infty}$ means that we only observe faces $C_{\beta}$ for which $\mathbb{P}\left(T_{n, k}(\beta)=0\right)$ does not decrease super-exponentially fast with $n$. We define the sets of admissible sequences $\left(k_{n}\right)$ by

$$
K=\left\{\left(k_{n}\right): k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0, \mathcal{S}_{\infty}=\widehat{\mathcal{S}}_{n} \text { a.s. for all } n \text { large enough }\right\}
$$

That $K$ is non empty is a strong assumption equivalent to the fact that $\widehat{\mathcal{S}}_{n}$ converges a.s. to $\mathcal{S}_{\infty}$ for some sequence of levels $\left(k_{n}\right)$. Combining the definition of $K$ with Assumption (HRV) we can rely on the statistics $T_{n, k}(\beta),\left(k_{n}\right) \in K$, which are non-null sufficiently often even when $p_{n}(\beta) \rightarrow p^{*}(\beta)=0$, in order to quantify the bias.

### 3.2 Asymptotic normality

We now establish a convergence result for the joint distribution of $T_{n, k}(\beta)$ for $\beta \in \mathcal{S}_{\infty}$. This is achieved via the study of the joint distribution of $T_{n}(x, \beta)$ for $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$, $\tau>0$. Having in mind the model selection proposed in Section 4 we consider for any $0 \leq s<r \leq s_{\infty}$ and any disjoint clusters $\beta_{1}, \ldots, \beta_{r} \in \mathcal{S}_{\infty}$ the vectors

$$
\mathbf{T}_{n}^{s, r}(x)=\left(T_{n}\left(x, \beta_{1}\right), \ldots, T_{n}\left(x, \beta_{s}\right), \sum_{j=s+1}^{r} T_{n}\left(x, \beta_{j}\right)\right)^{\top} \in \mathbb{R}^{s+1}
$$

and

$$
\mathbf{P}_{n}^{s, r}(x)=\left(x^{\alpha\left(\beta_{1}\right)} p_{n}\left(\beta_{1}\right), \ldots, x^{\alpha\left(\beta_{s}\right)} p_{n}\left(\beta_{s}\right), \sum_{j=s+1}^{r} x^{\alpha\left(\beta_{j}\right)} p_{n}\left(\beta_{j}\right)\right)^{\top} \in \mathbb{R}^{s+1}
$$

For $\tau>0$ we denote by $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ the set of functions defined and bounded on $\left[\frac{1}{1+\tau}, 1+\tau\right]$.

Theorem 1. Let Assumption (HRV) hold. Assume that there exists $\left(k_{n}\right) \in K$ and choose $u_{n}$ such that $k \sim n \mathbb{P}\left(|\mathbf{X}|>u_{n}\right)$ as $n \rightarrow \infty$.

1. The following convergence holds in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ as $n \rightarrow \infty$ :

$$
\begin{align*}
\left\{\sqrt{k} \operatorname{Diag}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}(x)}{k}-\mathbb{E}\left[\frac{\mathbf{T}_{n}^{s, r}(x)}{k}\right]\right) ;(1+\tau)^{-1}\right. & \leq x \leq 1+\tau\}_{s<r} \\
& \xrightarrow{d}\left(\mathbf{N}^{s, r}\right)_{s<r} \tag{3.4}
\end{align*}
$$

where the constant limit process is identified to $\mathbf{N}^{s, r}$, a standard centered multivariate Gaussian vector in $\mathbb{R}^{s+1}$.
2. If we assume moreover that for any $\beta \in \mathcal{S}_{\infty}$,

$$
\begin{equation*}
\sup _{x \in\left[\frac{1}{1+\tau}, 1+\tau\right]} \sqrt{\frac{k}{p_{n}(\beta)}}\left|\frac{n}{k} \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)-x^{\alpha(\beta)} p_{n}(\beta)\right| \rightarrow 0, \quad n \rightarrow \infty \tag{3.5}
\end{equation*}
$$

then we have
$\left\{\sqrt{k} \operatorname{Diag}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}(x)}{k}-\mathbf{P}_{n}^{s, r}(x)\right) ;(1+\tau)^{-1} \leq x \leq 1+\tau\right\}_{s<r} \xrightarrow{d}\left(\mathbf{N}^{s, r}\right)_{s<r}$,
in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ as $n \rightarrow \infty$.
Based on Theorem 1, we establish the asymptotic behavior of the estimators $T_{n, k}(\beta)$. We define

$$
\mathbf{T}_{n, k}^{s, r}=\mathbf{T}_{n}^{s, r}\left(u_{n} /|\mathbf{X}|_{(k+1)}\right)=\left(T_{n, k}\left(\beta_{1}\right), \ldots, T_{n, k}\left(\beta_{s}\right), \sum_{j=s+1}^{r} T_{n, k}\left(\beta_{j}\right)\right)^{\top} \in \mathbb{R}^{s+1}
$$

Proposition 3. Under the assumptions of Theorem 1, under (3.5), and under the bias assumption

$$
\begin{equation*}
\sqrt{k}\left(p_{n}(\beta)-p^{*}(\beta)\right) \rightarrow 0, \quad n \rightarrow \infty, \quad \beta \in \mathcal{S}_{\infty} \tag{3.7}
\end{equation*}
$$

we have the convergence

$$
\begin{equation*}
\sqrt{k} \operatorname{Diag}\left(\mathbf{P}_{n}^{s, r}(1)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n, k}^{s, r}}{k}-\mathbf{P}_{n}^{s, r}(1)\right) \xrightarrow{d}\left(I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \cdot \sqrt{\mathbf{P}^{s, r}}{ }^{\top}\right) \mathbf{N}, \quad n \rightarrow \infty \tag{3.8}
\end{equation*}
$$

where $\mathbf{N} \in \mathbb{R}^{s+1}$ is a standard centered multivariate Gaussian vector, and where $\mathbf{P}^{s, r}$ is the limit vector of $\mathbf{P}_{n}^{s, r}(1)$ :

$$
\mathbf{P}^{s, r}=\left(p^{*}\left(\beta_{1}\right), \ldots, p^{*}\left(\beta_{s}\right), \sum_{j=s+1}^{r} p^{*}\left(\beta_{j}\right)\right)^{\top}=\lim _{n \rightarrow \infty}\left(p_{n}\left(\beta_{1}\right), \ldots, p_{n}\left(\beta_{s}\right), \sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right)\right)^{\top}
$$

Remark 2. The bias assumption (3.7) holds for $\beta \in \mathcal{S}_{\infty} \backslash \mathcal{S}^{*}(\mathbf{Z})$ if $k=o\left(n^{\kappa}\right)$ as $n \rightarrow \infty$ where $\kappa>\frac{2(\alpha(\beta)-\alpha)}{2 \alpha(\beta)-\alpha}$ for every $\beta \in \mathcal{S}_{\infty} \backslash \mathcal{S}^{*}(\mathbf{Z})$. We refer to the Supplementary Material for a proof.

Remark 3. For $r=s_{\infty}$ the matrix $I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \cdot{\sqrt{\mathbf{P}^{s, r}}}^{\top}$ is symmetric and satisfies

$$
\begin{aligned}
\left(I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \cdot{\sqrt{\mathbf{P}^{s, r}}}^{\top}\right)^{2} & =I d_{s+1}-2 \sqrt{\mathbf{P}^{s, r}} \cdot{\sqrt{\mathbf{P}^{s, r}}}^{\top}+\left(\sqrt{\mathbf{P}^{s, r}} \cdot{\sqrt{\mathbf{P}^{s, r}}}^{\top}\right)^{2} \\
& =I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \cdot{\sqrt{\mathbf{P}^{s, r}}}^{\top}
\end{aligned}
$$

since ${\sqrt{\mathbf{P}^{s, r}}}^{\top} \cdot \sqrt{\mathbf{P}^{s, r}}=\sum_{j=1}^{r} p^{*}\left(\beta_{j}\right)=1$. Therefore it corresponds to an orthogonal projection with rank $s$. Cochran's theorem then ensures that the $\ell^{2}$-norm of the vector $\left(I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \sqrt[\mathbf{P}^{s, r}]{ }{ }^{\top}\right) \mathbf{N}$ follows a chi-squared distribution with $s$ degrees of freedom.

Going back to Proposition 3 we obtain the following convergence:

$$
\begin{equation*}
k \sum_{j=1}^{s} \frac{\left(T_{n, k}\left(\beta_{j}\right) / k-p_{n}\left(\beta_{j}\right)\right)^{2}}{p_{n}\left(\beta_{j}\right)}+k \frac{\left[\sum_{j=s+1}^{r}\left(T_{n, k}\left(\beta_{j}\right) / k-p_{n}\left(\beta_{j}\right)\right)\right]^{2}}{\sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right)} \xrightarrow{d} \psi(s), \tag{3.9}
\end{equation*}
$$

where $\psi(s)$ follows a chi-squared distribution with $s$ degrees of freedom. This convergence is useful to identify the parameter $s$ in the bias selection, see Lemma 4 in the Supplementary Material.

## 4 Methodology

We develop in this section our methodology to estimate the set $\mathcal{S}^{*}(\mathbf{Z})$. We use the same notation as in Section 3.

### 4.1 Bias selection

We consider the vector $\mathbf{T}_{n, k} \in \mathbb{R}^{2^{d}-1}$ with components $T_{n, k}(\beta)$ whose distribution $\mathbf{P}_{k}$ is multinomial with probability weights $\left(p_{n}(\beta)\right)_{\beta \in \mathcal{P}_{d}^{*}}$, and adding up to $k$. We propose a bias selection which consists in comparing the distribution $\mathbf{P}_{k}$ with the theoretical multinomial model $\mathbf{M}_{k}$ with $2^{d}-1$ outcomes adding up to $k$ and a probability vector $\left(p_{1}, \ldots, p_{s}, p, \ldots, p, 0, \ldots, 0\right)^{\top} \in[0,1]^{2^{d}-1}$, with $p_{1} \geq \cdots \geq p_{s}>p$ and $r-s$ components $p$ satisfying $p_{1}+\cdots+p_{s}+(r-s) p=1$. The parameters $p_{j}$ model the probability that $\mathbf{Z}$ belongs to the associated subsets $C_{\beta}$ while the parameter $p$ models the probability that a biased cluster appears. We denote by $\mathbf{p}$ the vector $\left(p_{1}, \ldots, p_{s}\right)^{\top} \in \mathcal{B}_{+}^{s}(0,1)$. The likelihood $L_{\mathbf{M}_{k}}$ of the model $\mathbf{M}_{k}$ is given by

$$
\begin{equation*}
L_{\mathbf{M}_{k}}(\mathbf{p} ; \mathbf{y})=\frac{k!}{\prod_{i=1}^{2^{d}-1} y_{i}!} \prod_{i=1}^{s} p_{i}^{y_{i}} \prod_{i=s+1}^{r}\left(\frac{1-\sum_{j=1}^{s} p_{j}}{r-s}\right)^{y_{i}} \mathbb{1}_{\left\{y_{r+1}=\cdots=y_{2^{d}-1}=0\right\}}, \tag{4.1}
\end{equation*}
$$

for any vector $\mathbf{p} \in \mathcal{B}_{+}^{s}(0,1)=\left\{\mathbf{u} \in \mathbb{R}_{+}^{s}: u_{1}+\cdots+u_{s} \leq 1\right\}$ and any $\mathbf{y} \in \mathbb{N}_{0}^{2^{d}-1}$ adding up to $k$, where $\mathbb{N}_{0}$ denotes the sets of non-negative integers.

The identification of the extremal clusters $\beta$ in $\mathcal{S}^{*}(\mathbf{Z})$ is achieved by choosing the model $\mathbf{M}_{k}$ which best fits the sample $\mathbf{T}_{n, k}$. Following the AIC approach of Akaike (1973), we select the multinomial model which minimizes the expectation of the Kullback-Leibler (KL) divergence (see Kullback and Leibler (1951)) between the true distribution $\mathbf{P}_{k}$ and the model $\mathbf{M}_{k}$ evaluated at $\hat{\mathbf{p}}$, where $\hat{\mathbf{p}}$ denotes the maximum-likelihood estimator of $\mathbf{p}$. Hence we consider the quantity

$$
\begin{equation*}
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]=\mathbb{E}\left[\log L_{\mathbf{P}_{k}}\left(\mathbf{T}_{n, k}\right)\right]-\mathbb{E}\left[\left.\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n, k}\right)\right]\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right] \tag{4.2}
\end{equation*}
$$

where $L_{\mathbf{P}_{k}}$ denotes the likelihood of the distribution $\mathbf{P}_{k}$. Theorem 2 below provides an asymptotic expansion of this quantity.

Before stating this result we compute the maximum likelihood estimator of the model $\mathbf{M}_{k}$. The first components of the model $\mathbf{M}_{k}$ being associated to the extremal clusters, we reorder the coordinates of the vector $\mathbf{T}_{n, k}$ so that its components are ordered in the decreasing order. Hence we define $T_{n, k, 1}=\max _{\beta} T_{n, k}(\beta)$ and

$$
T_{n, k, j}=\max \left\{T_{n, k}(\beta), \beta \in \mathcal{P}_{d}^{*}\right\} \backslash\left\{T_{n, k, 1}, \ldots, T_{n, k, j-1}\right\}, \quad j=2, \ldots, 2^{d}-1
$$

The expression in (4.1) is also maximal when $r$ corresponds to the number $\hat{s}_{n}$ of clusters that appear empirically. This leads to the following expression of the log-likelihood $\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n, k}\right):$

$$
\begin{equation*}
\log (k!)-\sum_{i=1}^{2^{d}-1} \log \left(T_{n, k, i}!\right)+\sum_{i=1}^{s} T_{n, k, i} \log \left(p_{i}\right)+\left(\sum_{i=s+1}^{r} T_{n, k, i}\right) \log \left(\frac{1-\sum_{j=1}^{s} p_{j}}{r-s}\right) . \tag{4.3}
\end{equation*}
$$

The optimization of this quantity then provides the maximum likelihood estimator $\hat{\mathbf{p}} \in \mathbb{R}^{s}$ with components $\hat{p}_{j}:=T_{n, k, j} / k$ for $1 \leq j \leq s$.

Theorem 2. Under the assumptions of Proposition 3 the following convergence holds:

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]-\mathbb{E}\left[\log L_{\mathbf{P}_{k}}\left(\mathbf{T}_{n, k}\right)\right]+\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n, k}\right)\right] \rightarrow s, \quad n \rightarrow \infty
$$

Based on Theorem 2 we choose the model $\mathbf{M}_{k}$ which minimizes the quantity

$$
\begin{equation*}
-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n, k}\right)+s \tag{4.4}
\end{equation*}
$$

Therefore for a given sequence $\left(k_{n}\right) \in K$ the bias selection procedure consists in choosing the parameter $\hat{s}(k)$ which minimizes this penalized log-likelihood.

### 4.2 Level selection

The second step of the model selection consists in considering $k$ as a parameter which has to be estimated and tuned. It is therefore necessary to consider all observations $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$ and not only the extreme ones. We consider a vector $\mathbf{T}_{n}^{\prime} \in \mathbb{R}^{2^{d}}$ such that

$$
\mathcal{L}\left(\left(T_{n, 1}^{\prime}, \ldots, T_{n, 2^{d}-1}^{\prime}\right) \mid T_{n, 2^{d}}^{\prime}=n-k\right)=\mathbf{T}_{n, k}
$$

The last component $T_{n, 2^{d}}^{\prime}$ corresponds to the number of non-extreme values of the sample. We assume that this vector follows a multinomial distribution $\mathbf{P}_{n}^{\prime}$ with parameter $n$ and probability vector $\mathbf{p}_{n}^{\prime}=\left(q_{n} p_{n, 1}, \ldots, q_{n} p_{n, 2^{d}-1}, 1-q_{n}\right)^{\top} \in \mathbb{R}^{2^{d}}$.

Similarly to Section 4.1 we consider a multinomial model $\mathbf{M}_{n}^{\prime}$ with probability vector given by $\left(q^{\prime} p_{1}^{\prime}, \ldots, q^{\prime} p_{s^{\prime}}^{\prime}, q^{\prime} p^{\prime}, \ldots, q^{\prime} p^{\prime}, 0, \ldots, 0,1-q^{\prime}\right)^{\top} \in \mathbb{R}^{2^{d}}$ with $p_{1}^{\prime} \geq \ldots \geq p_{s^{\prime}}^{\prime}>p^{\prime}$ and $r^{\prime}-s^{\prime}$ components $q^{\prime} p^{\prime}$ satisfying the relation $p_{1}^{\prime}+\ldots+p_{s}^{\prime}+\left(r^{\prime}-s^{\prime}\right) p^{\prime}=1$. Here $q^{\prime}$ models the proportion of extreme vectors. We denote by $\mathbf{p}^{\prime}$ the vector $\left(p_{1}^{\prime}, \ldots, p_{s^{\prime}}^{\prime}, q^{\prime}\right)^{\top} \in \mathcal{B}_{+}^{s^{\prime}} \times(0,1)$.

We consider the Kullback-Leibler divergence between $\mathbf{P}_{n}^{\prime}$ and $\mathbf{M}_{n}^{\prime}$ given by

$$
\begin{equation*}
K L\left(\mathbf{P}_{n}^{\prime} \| \mathbf{M}_{n}^{\prime}\right)=\mathbb{E}\left[\log \left(\frac{L_{\mathbf{P}_{n}^{\prime}}\left(\mathbf{T}_{n}^{\prime}\right)}{L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime} ; \mathbf{T}_{n}^{\prime}\right)}\right)\right]=\mathbb{E}\left[\log L_{\mathbf{P}_{n}^{\prime}}\left(\mathbf{T}_{n}^{\prime}\right)\right]-\mathbb{E}\left[\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime} ; \mathbf{T}_{n}^{\prime}\right)\right] \tag{4.5}
\end{equation*}
$$

where $L_{\mathbf{P}_{n}^{\prime}}\left(\right.$ resp. $L_{\mathbf{M}_{n}^{\prime}}$ ) denotes the likelihood of the distribution $\mathbf{P}_{n}^{\prime}$ (resp. $\mathbf{M}_{n}^{\prime}$ ). Following the same ideas as in Section 4.1 and similarly to an AIC procedure we estimate the KullbackLeibler divergence in Equation (4.5) by the estimator $\left.K L\left(\mathbf{P}_{n}^{\prime} \| \mathbf{M}_{n}^{\prime}\right)\right|_{\mathbf{p}^{\prime}}$ where $\widehat{\mathbf{p}^{\prime}}$ denotes the maximum likelihood estimator of $\mathbf{p}^{\prime}$.

We make the following assumptions.
(B1) For $k \in K$ and $\beta_{j} \in \mathcal{S}_{\infty}$ we have

$$
\frac{\mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right]}{n-T_{n, 2^{d}}^{\prime}}=\frac{\mathbb{E}\left[T_{n, k, j}\right]}{k}+O(1), \quad n \rightarrow \infty .
$$

(B2) For $n$ sufficiently large, $k \in K$, there exist $c, C>0$ such that $c n q_{n} \leq k \leq C n q_{n}$.
Assumptions (B1) and (B2) allow one to control the bias between $T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}$ and $T_{n, k, j}$, and between $k$ and $n q_{n}$ respectively.

The following theorem provides an asymptotic expansion of the expectation of this estimator.

Theorem 3. Under (B1), (B2) and the assumptions of Proposition 3 we have

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{n}^{\prime} \| \mathbf{M}_{n}^{\prime}\right)\right|_{\hat{\mathbf{p}^{\prime}}}\right]=n q_{n}\left(\frac{\mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n}\right)\right]+s}{k}+\log (k / n)\right)+O\left(n q_{n}\right), \quad n \rightarrow \infty
$$

Theorem 3 encourages to choose a level $k$ which minimizes the penalized log-likelihood

$$
\frac{-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n}\right)+s}{k}+\log \left(\frac{k}{n}\right) .
$$

It turns out that the additive penalization term $\log (k / n)$ leads to numerical instability as $k / n$ is small. To cope with this issue we upper bound it by $k / n-1$. The level $k$ which minimizes the criterion is then smaller than the one that appears with $\log (k / n)$. Thus it
satisfies more likely the bias assumptions (B1), (B2). So in practice we choose a level $k$ which minimizes the following penalized $\log$-likelihood

$$
\begin{equation*}
\frac{-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n}\right)+s}{k}+\frac{k}{n} . \tag{4.6}
\end{equation*}
$$

Note that the two steps of our procedure are clearly identified in the penalized loglikelihood. The term $-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n}\right)+s$ corresponds to the bias selection and the multiplicative factor and the additional term to the level one.

### 4.3 Algorithm: MUltivariate Sparse CLustering for Extremes (MUSCLE)

In practice we choose a large range $\mathcal{K}$ of $k$ (often between $0.5 \%$ and $10 \%$ of $n$ ) and we compute the value of (4.6) for these $k$ and for $s=1, \ldots, \hat{s}_{n}$, where $\hat{s}_{n}$ depends on the chosen level $k$. We choose $\hat{k}$ which minimizes the penalized log-likelihood (4.6) and then choose $\hat{s}(\hat{k})$ which minimizes (4.6) for $k=\hat{k}$. Then we define $\widehat{\mathcal{S}^{*}}$ as the set gathering the $\hat{s}(\hat{k})$ clusters corresponding to the largest $T_{n, \hat{k}}(\beta)$ 's. Finally we consider the probability vector $\hat{\boldsymbol{\zeta}}$ defined by

$$
\hat{\zeta}(\beta):=\frac{T_{n, \hat{k}}(\beta)}{\sum_{\gamma \in \hat{\mathcal{S}}^{*}} T_{n, \hat{k}}(\gamma)}
$$

for $\beta \in \widehat{\mathcal{S}^{*}}$ and 0 elsewhere, as an estimator of $\mathbf{p}^{*}$. Our procedure entails the following parameter-free algorithm called MUSCLE for MUltivariate Sparse CLustering for Extremes.

Remark 4. While our procedure leads to the choice of a unique $\hat{k}$, we expect that this approach is not too sensitive to this choice. Therefore, it is relevant to plot the function $k \mapsto \hat{s}(k)$ which provides the chosen value of $s$ for every $k \in \mathcal{K}$. We expect that this function is approximately constant around the chosen value $\hat{k}$.

## 5 Numerical results

### 5.1 Overview

The aim of the numerical results is to compare the extremal clusters given by MUSCLE with the theoretical ones in $\mathcal{S}^{*}(\mathbf{Z})$. To this end we compare the estimated probability vector $\hat{\boldsymbol{\zeta}}$ with the theoretical one $\mathbf{p}^{*}$ via the Hellinger distance

$$
\begin{equation*}
h\left(\mathbf{p}^{*}, \hat{\boldsymbol{\zeta}}\right)=\frac{1}{\sqrt{2}}\left[\sum_{\beta \in \mathcal{P}_{d}^{*}}\left(p^{*}(\beta)^{1 / 2}-\hat{\zeta}(\beta)^{1 / 2}\right)^{2}\right]^{1 / 2} . \tag{5.1}
\end{equation*}
$$

The closer $h\left(\mathbf{p}^{*}, \hat{\boldsymbol{\zeta}}\right)$ is to 0 , the better $\hat{\boldsymbol{\zeta}}$ estimates $\mathbf{p}^{*}$. In order to compare our method with some existing ones, we also compute the Hellinger distance between the true probabilities $\mathbb{P}\left(\boldsymbol{\Theta} \in C_{\beta}\right)$ and the estimated ones given by the algorithm called DAMEX of Goix et al. (2017) and the two methods of Simpson et al. (2020). We represent the mean Hellinger distance over $N=100$ simulations. The parameters in the method of Goix et al. (2017) are chosen to be $\epsilon=0.1, k=\sqrt{n}$, and $p=0.1$, see the notation in their paper. Regarding the methods of Simpson et al. (2020) we use the parameters given by the authors in Section 4.2 of their paper, i.e. we set $\pi=0.01$, and $p=0.5$ and $u_{\beta}$ to be the 0.75 quantile of observed $Q$ values in region $C_{\beta}$ for the first method, and $\delta=0.5$ and $u_{\beta}$ to be the 0.85 quantile of observed $Q$ values in region $C_{\beta}$ for the first method. We refer to Simpson et al. (2020) for more insights on these parameters.

Remark 5. Contrary to the aforementioned methods, we recall that MUSCLE does not require any hyperparameter. This is a main advantage from a statistical and computational point of view. On the contrary, for the other methods these values could be tuned via crossvalidation. For the numerical results we do not choose this approach and keep the values fixed by the authors of the cited papers.

In the following section we develop the example of a max-mixture distribution. The code related to this article can be found at https://drive.google.com/drive/folders/ 11 TvhbVMPXcSkxmdnnAySvZt641pMKZqL?usp=sharing. Another example related to asymptotic independence is given in the Supplementary Material.

### 5.2 Max-mixture distribution

For any $\beta \in \mathcal{P}_{d}^{*}$, let $\mathbf{A}_{\beta} \in \mathbb{R}_{+}^{|\beta|}$ be a random vector with standard Fréchet marginal distributions and with dependence structure given below, and let $\left\{\mathbf{A}_{\beta}: \beta \in \mathcal{P}_{d}^{*}\right\}$ be independent random vectors. Then the vector $\mathbf{X}=\left(X_{1}, \ldots, X_{d}\right)^{\top}$ whose components are defined via $X_{j}=\max _{\beta \in \mathcal{P}_{d}^{*}: i \in \beta} \lambda_{i, \beta} X_{j, \beta}$, with $\lambda_{i, \beta} \in[0,1]$ and $\sum_{\beta \in \mathcal{P}_{d}^{*}: i \in \beta} \lambda_{i, \beta}=1$, has also standard Fréchet marginal distributions and is regularly varying.

For our simulations we consider the five-dimensional example introduced by Simpson et al. (2020) which we recall for completeness. We consider two bivariate Gaussian copulas with correlation parameter $\rho$ and Fréchet marginals $\mathbf{A}_{\{1,2\}}$ and $\mathbf{A}_{\{4,5\}}$, and three extremevalue logistic copulas with dependence parameter $\alpha$ and Fréchet marginals $\mathbf{A}_{\{1,2,3\}}, \mathbf{A}_{\{3,4,5\}}$, and $\mathbf{A}_{\{1,2,3,4,5\}}$. For $\rho<1$, the Gaussian copula is asymptotically independent (see Example 1 for more insights on this notion) and thus the spectral measure defined in (1.2) concentrates on the subsets $C_{\{1\}}, C_{\{2\}}, C_{\{4\}}$, and $C_{\{5\}}$. For $\alpha \in(0,1)$ the logistic distribution is asymptotically dependent so that the spectral measure also places mass on the subsets $C_{\{1,2,3\}}, C_{\{3,4,5\}}$, and $C_{\{1,2,3,4,5\}}$. Following Simpson et al. (2020), we set

$$
\begin{gathered}
\lambda_{\{1,2\}}=(5,5) / 7, \quad \lambda_{\{4,5\}}=(5,5) / 7 \\
\lambda_{\{1,2,3\}}=(1,1,3) / 7, \quad \lambda_{\{3,4,5\}}=(3,1,1) / 7, \quad \lambda_{\{1,2,3,4,5\}}=(1,1,1,1,1) / 7,
\end{gathered}
$$

so that equal mass is assigned to each of the seven aforementioned subsets. In order to compute the mass the distribution of $\mathbf{Z}$ assigns to every subset $C_{\beta}$ we start from the distribution of $\Theta$ and use Monte-Carlo simulation. We then compare these probabilities with their estimated ones $\hat{\boldsymbol{\zeta}}$ given by MUSCLE.

We run our algorithm for different values of $\rho \in\{0,0.25,0.5,0.75\}$ and $\alpha \in\{0.1,0.2, \ldots, 0.9\}$. Figures 2 and 3 shows the average mean Hellinger distance for our method, the one of Goix
et al. (2017), and the two of Simpson et al. (2020) over 100 simulations. Our method provides a mean Hellinger distance which stabilizes between 0.2 and 0.3 for all values of $\rho$ and $\alpha$. For $\alpha \leq 0.7$ the distance slightly decreases with alpha, while it increases for $\alpha \geq 0.8$. The standard deviation is quite small for $\alpha \leq 0.7$ and then increases with $\alpha$. Regarding the approach of Goix et al. (2017), the mean Hellinger distance tends to increase with $\alpha$ and with $\rho$. The smallest values is obtained for $\rho \in\{0,0.25\}$ and for small $\alpha$. The estimation particularly deteriorates for $\rho=0.75$. Finally both methods proposed by Simpson et al. (2020) provide a mean Hellinger distance which increases with $\alpha$ and $\rho$. The second one seems to provide almost always better results than the first one.

While all methods provided by Goix et al. (2017) and Simpson et al. (2020) deteriorate when $\rho$ or $\alpha$ increase, our procedure provides results which stabilize around a mean Hellinger distance of 0.2 . This distance is the smallest one for $\rho=0.5$ and $\rho=0.75$ for all $\alpha$ compared to the one of the three other methods. For small $\rho$, MUSCLE better performs for large $\alpha$. For small $\alpha$ the second method of Simpson et al. (2020) provides better results than our approach, while its standard deviation is larger. It turns out that except for small $\alpha$ with $\rho=0$ and $\rho=0.25$ our algorithm better detects the extremal clusters.

## 6 Application to real-world data

### 6.1 Preprocessing for real-world data

In Section 5 we considered an example with standard Fréchet marginal distributions so that the tail index (see Equation (1.2)) of the considered vectors is equal to 1 . The influence of this index on the extremal clusters has been studied on some numerical results by Meyer and Wintenberger (2021). It turns out that a large tail index does not provide accurate

results while a small one highlights one-dimensional clusters, see Remark 11 in their article. A tail index of $\alpha=1$ seems to provide the best results.

For real-world data the estimation of the tail index of a sample $\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}$ is achieved with a Hill plot (Hill (1975)). It consists in plotting

$$
\widehat{\alpha}(k)=\left(\frac{1}{k} \sum_{j=1}^{k} \log \left(|\mathbf{x}|_{(j)}\right)-\log \left(|\mathbf{x}|_{(k)}\right)\right)^{-1}, \quad k=2, \ldots, n
$$

where $|\mathbf{x}|_{(j)}$ denotes the order statistics of the norms $\left|\mathbf{x}_{1}\right|, \ldots,\left|\mathbf{x}_{n}\right|$, i.e. $|\mathbf{x}|_{(1)} \geq \ldots \geq|\mathbf{x}|_{(n)}$, and to choose $\hat{\alpha}$ as the value around which the plot stabilizes. Then, we consider the power transform $\mathbf{x}_{j}^{\prime}=\left(\mathbf{x}_{j}\right)^{\hat{\alpha}}$. This transformation highlights the tail structure of the data without modifying the support of the spectral measure, see Meyer and Wintenberger (2021), Remark 8. It differs from the standardization discussed in the introduction for which the vectors are normalized via a rank transform.

In the following section we apply MUSCLE to financial data. An application on wind speed data can be found in the Supplementary Material.

### 6.2 Extreme variability for financial data

The data set we use corresponds to the value-average daily returns of 49 industry portfolios compiled and posted as part of the Kenneth French Data Library. They are available at https://mba.tuck.dartmouth.edu/pages/faculty/ken.french/data_library.html. A related study on a similar dataset has been conducted by Cooley and Thibaud (2019). We restrict our study to the period 1970-2019 which provides $n=12613$ observations denoted by $\mathbf{x}_{1}^{\text {obs }}, \ldots \mathrm{x}_{n}^{\text {obs }} \in \mathbb{R}^{49}$. Our goal is to study the variability of these returns so that we take the componentwise absolute value $\mathbf{x}_{j}=\left|\mathbf{x}_{j}^{\mathrm{obs}}\right|$ of the data. Thus, we study the non-negative
vectors $\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}$ in $\mathbb{R}_{+}^{d}$ with $n=12613$ and $d=49$. Following Section 6.1, we consider the vectors $\mathbf{x}_{j}^{\prime}=\left(\mathbf{x}_{j}\right)^{\hat{\alpha}}$, where $\hat{\alpha}=2.99$ is the Hill estimator of the sample $\left|\mathbf{x}_{1}\right|, \ldots,\left|\mathbf{x}_{n}\right|$.

Following Remark 4, we plot the evolution of the estimator of the Kullback-Leibler divergence in (4.6) as a function of $k$. We see on Figure 4 that this estimator decreases until it reaches a minimal value for $\hat{k}=441$, before increasing for $k \geq \hat{k}$. The level $\hat{k}$ corresponds to a proportion $\hat{k} / n=3 \%$ and leads to a number of extremal clusters $\hat{s}(\hat{k})=14$. Contrary to the numerical results, we do not observe a range of $k$ for which the minimal value $\hat{s}(k)$ remains approximately constant.

MUSCLE provides $\hat{s}(\hat{k})=14$ extremal clusters which gather 12 portfolios. These clusters and their inclusions are represented in Figure 5. The number of identified clusters is much smaller compared to the total number $2^{49} \approx 10^{15}$. Besides these clusters are at most three-dimensional so that our procedure drastically reduces the dimension of the study. Most of the extremal portfolios which appear in the clusters correspond to "office/executive" sectors, such as Health, Software, Hardware, Banks, Finance, Electronic Equipment (Chips), Real Estate. Some other clusters group portfolios related to heavy
industries, such as Steel, Coal, and Gold. The only clusters gathering a heavy industry and service sectors are $\{$ Coal, Banks $\}$ and \{Coal, Banks, Fin $\}$. The tail dependence of the variability of these different kinds of portfolios may result from the financing of the coal industry by several big banks, see Raval et al. (2020).

We conclude that the aforementioned 14 clusters given by MUSCLE correspond to subsets $C_{\beta}$ which gather the mass of $\mathbf{Z}$. Among them, eight gather some mass of $\mathbf{Z}$ and are not included in larger subsets on which $\mathbf{Z}$ places mass. Following Meyer and Wintenberger (2021), Theorem 2, these maximal subsets also concentrate the mass of the spectral measure. We refer to Meyer and Wintenberger (2021), Section 3.2, for a discussion on maximal and non-maximal subsets. Standard approaches which hold for low-dimensional extremes can then be applied to these subsets, see Einmahl et al. (1993), Einmahl et al. (1997), Einmahl and Segers (2009).

After removing the 12 extremal components we reapply MUSCLE to obtain the depen-
dence structure of the non-extremal portfolios. The algorithm provides a unique cluster with all 37 remaining portfolios. Hence these portfolios tend to have a dependent tail structure: their extreme variability is strongly correlated.

## 7 Conclusion

The statistical analysis introduced in this article provides a new approach to detect the extremal directions of a multivariate random vector $\mathbf{X}$. This method relies on the notion of sparse regular variation which better highlights the tail dependence of X. Several convergence results are established in Section 3 and are used to build a rigorous statistical method based on model selection. This approach provides not only the clusters of directions on which the extremes of $\mathbf{X}$ gather but also a reasonable threshold above which the data are considered as extreme values. The latter issue has always been challenging and no theoretical-based procedure has been provided in a multivariate setting yet, even if it has been the subject of much attention in the literature. The choice of the directions is achieved with an AIC-type minimization whose penalization allows to reduce the number of selected subsets. Including the choice of the level $k$ of the random threshold $|\mathbf{X}|_{(k)}$ then entails multiplicative and additive penalization terms. This approach leads to the parameter-free algorithm MUSCLE whose purpose is to recover the extremal clusters of a sample of iid sparsely regularly varying random vectors $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$.

The absence of any hyperparameter is a main difference with the existing methods (Goix et al. (2017), Simpson et al. (2020), Chiapino and Sabourin (2016), Chiapino et al. (2019)). Another main advantage of our procedure is that it is still efficient for large $d$. This follows from the expected linear-time algorithm introduced by Duchi et al. (2008) to
compute the Euclidean projection.
The numerical experiments on max-mixture distributions provide promising results. Our algorithm provides better results than the ones of Goix et al. (2017) and Simpson et al. (2020) for $\rho$ close to 1 , or small $\rho$ and $\alpha$ close to 1 . Moreover the results do not vary a lot with $\rho$ and $\alpha$. Finally, the application of our algorithm on financial data highlights sparse clusters and thus reduces the dimension of the study. We obtain a sparse tail dependence structure for for the extreme variability of several industry portfolios. This reinforces the relevance of our approach for reducing the dimension in Extreme Value Theory.

## 1 Proofs

This section contains the proofs of the results introduced in the main text. We start by a result which will be of constant use in what follows.

### 1.1 A consequence of Assumption ??

Assumption ?? allows us to deal with the limit of $\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)$ as $n \rightarrow \infty$. Indeed, this assumption implies the following uniform convergence over $x \in\left[\frac{1}{1+\tau}, 1+\tau\right], \tau>0$ :

$$
\begin{equation*}
\frac{n}{k} \frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{p_{n}(\beta)} \rightarrow x^{\alpha(\beta)}, \quad n \rightarrow \infty \tag{1.1}
\end{equation*}
$$

To prove this convergence we use the equivalence established by Meyer and Wintenberger (2021):

$$
\pi(\mathbf{x}) \in C_{\beta} \quad \text { if and only if } \quad\left\{\begin{array}{l}
\max _{i \in \beta} \mathbf{x}_{\beta, i}<1  \tag{1.2}\\
\min _{i \in \beta^{c}} \mathbf{x}_{\beta, i} \geq 1
\end{array}\right.
$$

where $\mathbf{x}_{\beta, i}=\sum_{j \in \beta}\left(x_{j}-x_{i}\right)$. The regular variation assumption and the homogeneity property of $\mu_{\beta}$ then yield

\frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{\mathbb{P}\left(\min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} \geq u_{n}\right)} & =\frac{\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i}<u_{n}, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} \geq u_{n}\right)}{\mathbb{P}\left(\min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} \geq u_{n}\right)} \\
& \xrightarrow[n \rightarrow \infty]{\longrightarrow} \mu_{\beta}\left(\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} x \mathbf{x}_{\beta, i}<1, \min _{i \in \beta^{c}} x \mathbf{x}_{\beta, i} \geq 1\right\}\right) \\
& =x^{\alpha(\beta)} \mu_{\beta}\left(\left\{\mathbf{x} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{x}_{\beta, i}<1, \min _{i \in \beta^{c}} \mathbf{x}_{\beta, i} \geq 1\right\}\right)
\end{aligned}
$$

and this limit is positive by Assumption ??. This implies in particular that the function $t \mapsto \mathbb{P}(\mathbf{X} / t \in A(1, \beta))=\mathbb{P}\left(\mathbf{X} \in A\left(t^{-1}, \beta\right)\right)$ is regularly varying with index $-\alpha(\beta)$. We conclude by writing down

\frac{n}{k} \frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{p_{n}(\beta)} \sim \frac{\mathbb{P}\left(x \mathbf{X} / u_{n} \in A(1, \beta)\right)}{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(1, \beta)\right)} \rightarrow x^{\alpha(\beta)}, \quad n \rightarrow \infty
$$

Remark. For $\beta \in \mathcal{S}^{*}(\mathbf{Z})$, the convergence is automatically satisfied since

\frac{n}{k} \frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{p_{n}(\beta)}=\frac{\mathbb{P}\left(\pi\left(x \mathbf{X} / u_{n}\right) \in C_{\beta}|x| \mathbf{X} \mid>u_{n}\right)}{p_{n}(\beta)} \frac{\mathbb{P}\left(x|\mathbf{X}|>u_{n}\right)}{\mathbb{P}\left(|\mathbf{X}|>u_{n}\right)} \underset{n \rightarrow \infty}{\longrightarrow} \frac{p^{*}(\beta)}{p^{*}(\beta)} x^{\alpha}=x^{\alpha},
$$

where $\alpha$ is the tail index of $\mathbf{X}$, see Equation (??) in the main text.

### 1.2 Proof of Lemma??

In order to prove the convergence

\frac{\log \mathbb{P}\left(T_{n, k}(\beta)=0\right)}{-k p_{n}(\beta)} \rightarrow 1, \quad n \rightarrow \infty

we prove that for $\tau>0$,

\end{equation*}
$$

Then, letting $x=x_{n}=u_{n} /|\mathbf{X}|_{(k+1)}$ in (1.3) gives the desired result since $x_{n} \rightarrow 1$ in probability.

First we notice that

& =\left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]^{n} \\
& =\exp \left(n \log \left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]\right)
\end{aligned}
$$

Therefore, the convergence (1.3) is equivalent to

\begin{equation*}
\sup _{x \in\left[\frac{1}{1+\tau}, 1+\tau\right]}\left|\frac{n \log \left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]}{-k p_{n}(\beta)}-x^{\alpha(\beta)}\right| \rightarrow 0, \quad n \rightarrow \infty . \tag{1.4}
\end{equation*}

We decompose this quantity as follows:

& \left|\frac{n \log \left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]}{-k p_{n}(\beta)}-x^{\alpha(\beta)}\right| \\
& \quad \leq\left|\frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{k p_{n}(\beta)}-x^{\alpha(\beta)}\right|\left|\frac{-\log \left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]}{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}\right| \\
& \quad+\left|\frac{-\log \left[1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)\right]}{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}-1\right|\left|x^{\alpha(\beta)}\right|
\end{aligned}

Regarding the second term, we first notice that on $\left[\frac{1}{1+\tau}, 1+\tau\right]$ we have $\left|x^{\alpha(\beta)}\right| \leq(1+\tau)^{\alpha(\beta)}$. Besides, Taylor's inequality ensures that $|\log (1+x)-x| \leq|x|^{2} / 6$ for any $x>-1$. This implies that

Consequently, for $\mathrm{C}=C_{\beta_{1}} \cup \cdots \cup C_{\beta_{l}} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)$ the set $A(x, \mathrm{C}):=\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: x|\mathbf{y}|>1, \pi(x \mathbf{y}) \in \mathrm{C}\right\}$ satisfies

T_{n}(x, \mathrm{C}):=\sum_{j=1}^{n} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}}=\sum_{j=1}^{n} \mathbb{1}_{\left\{x|\mathbf{X}|>u_{n}\right\}}\left(\sum_{j=1}^{l} \mathbb{1}_{\left\{\pi\left(x \mathbf{X} / u_{n}\right) \in C_{\beta_{j}}\right\}}\right)

since the unions which appear in C are disjoint ones. We also define

p_{n}(\mathrm{C})=\mathbb{P}\left(\pi\left(\mathbf{X} / u_{n}\right) \in \mathrm{C}| | \mathbf{X} \mid>u_{n}\right) .

With such definitions if $\mathrm{C}=C_{\beta}$ then we get $T_{n}(x, \mathrm{C})=T_{n}(x, \beta)$ and $p_{n}(\mathrm{C})=p_{n}(\beta)$.
In order to prove Theorem ?? we establish the convergence in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ of the process

\end{equation*}

under a suitable normalization. Theorem ?? is then just a consequence of this convergence with a specific choice of subsets C.

To prove the convergence of the process (1.5) we proceed as usual by first establishing the convergence of all finite dimensional marginal distributions and then the asymptotic equicontinuity of the process.

1. Convergence of the marginals

We prove the convergence of (1.5) under a suitable normalization for a fixed $x \in\left[\frac{1}{1+\tau}, 1+\right.$ $\tau]$. We consider the triangular array $\mathbf{V}_{n}^{1}(x), \ldots, \mathbf{V}_{n}^{n}(x)$, with generic distribution $\mathbf{V}_{n}(x) \in$ $\mathbb{R}^{2^{s} \infty-1}$, where $\mathbf{V}_{n}^{i}(x)$ has components

\frac{\sqrt{n} \mathbb{1}_{\left\{\mathbf{X}_{\left.i / u_{n} \in A(x, \mathrm{C})\right\}}\right.}^{\sqrt{k p_{n}(\mathrm{C})}}, \quad \mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right) . . . . . . . .}{}
$$

Let $\boldsymbol{\Sigma}\left(\mathbf{V}_{n}(x)\right) \in \mathbb{R}^{2^{s \infty}-1} \times \mathbb{R}^{2^{s} \infty-1}$ be the covariance matrix of $\mathbf{V}_{n}(x)$. For $\mathrm{C}, \mathrm{C}^{\prime} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)$, we have

\begin{aligned}
\Sigma & \left(\mathbf{V}_{n}(x)\right)_{\mathrm{C}, \mathrm{C}^{\prime}} \\
& =\operatorname{Cov}\left(\frac{\sqrt{n} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}}}{\sqrt{k p_{n}(\mathrm{C})}}, \frac{\sqrt{n} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A\left(x, \mathrm{C}^{\prime}\right)\right\}}}{\sqrt{k p_{n}\left(\mathrm{C}^{\prime}\right)}}\right) \\
& =\frac{n}{k} \frac{\mathbb{E}\left[\mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A\left(x, \mathrm{C}^{\prime}\right)\right\}}\right]}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}}-\frac{n}{k} \frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right) \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \mathrm{C}^{\prime}\right)\right)}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}} .
\end{aligned}
$$

If we write $\mathrm{C}=C_{\beta_{1}} \cup \cdots \cup C_{\beta_{l}}$ and $\mathrm{C}^{\prime}=C_{\beta_{1}^{\prime}} \cup \cdots \cup C_{\beta_{l}^{\prime}}$, with disjoint unions, then the convergence (1.1) ensures that

\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right)=\sum_{j=1}^{l} \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)=\frac{k}{n} \sum_{j=1}^{l} p_{n}\left(\beta_{j}\right) x^{\alpha\left(\beta_{j}\right)}(1+o(1))
$$

and similarly for $\mathbf{C}^{\prime}$. This implies that the second term in the decomposition of $\boldsymbol{\Sigma}\left(\mathbf{V}_{n}(x)\right)_{\mathrm{c}, \mathrm{C}^{\prime}}$ satisfies
$\frac{n}{k} \frac{\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right) \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \mathrm{C}^{\prime}\right)\right)}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}}=\frac{k}{n} \frac{\sum_{j=1}^{l} p_{n}\left(\beta_{j}\right) x^{\alpha\left(\beta_{j}\right)} \sum_{i=1}^{l^{\prime}} p_{n}\left(\beta_{i}\right) x^{\alpha\left(\beta_{i}^{\prime}\right)}}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}}(1+o(1))$.
Regarding the first term, it is non-null if and only if there are common subsets in C and $\mathrm{C}^{\prime}$. We use again (1.1) and obtain

\frac{n}{k} \frac{\mathbb{E}\left[\mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A\left(x, \mathrm{C}^{\prime}\right)\right\}}\right]}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}} & =\frac{n}{k} \frac{\sum_{\beta: C_{\beta} \subset \mathrm{C} \cap \mathrm{C}^{\prime}} \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}} \\
& =\frac{\sum_{\beta: C_{\beta} \subset \mathrm{C} \cap \mathrm{C}^{\prime}} p_{n}(\beta) x^{\alpha(\beta)}}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}}(1+o(1))
\end{aligned}

where the sum is equal to zero if the intersection $C \cap C^{\prime}$ is empty. This proves that the covariance matrix $\boldsymbol{\Sigma}\left(\mathbf{V}_{n}(x)\right)$ has the same asymptotic behavior as the matrix $\widetilde{\mathbf{S}}_{n}(x)$ defined by

\widetilde{\mathbf{S}}_{n}(x)_{\mathrm{C}, \mathrm{C}^{\prime}}=\left\{\begin{array}{cc}
\frac{\sum_{\beta: C_{\beta} \subset \mathrm{C} \cap \mathrm{C}^{\prime}} p_{n}(\beta) x^{\alpha(\beta)}}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}} & \text { for } \mathrm{C} \cap \mathrm{C}^{\prime} \neq \emptyset  \tag{1.6}\\
-\frac{k}{n} \frac{\sum_{\beta: C_{\beta} \subset \mathrm{C}} p_{n}(\beta) x^{\alpha(\beta)} \sum_{\beta^{\prime}: C_{\beta^{\prime}} \subset \mathrm{C}^{\prime}} p_{n}\left(\beta^{\prime}\right) x^{\alpha\left(\beta^{\prime}\right)}}{\sqrt{p_{n}(\mathrm{C})} \sqrt{p_{n}\left(\mathrm{C}^{\prime}\right)}} & \text { for } \mathrm{C} \cap \mathrm{C}^{\prime}=\emptyset
\end{array}\right.
$$

Since we assume that the $\beta$ 's are in $\mathcal{S}_{\infty}$, the Lindeberg-Feller's condition is satisfied:

& \frac{1}{n} \sum_{i=1}^{n} \mathbb{E}\left[\left|\mathbf{V}_{n}^{i}(x)-\mathbb{E}\left[\mathbf{V}_{n}^{i}(x)\right]\right|_{\infty}^{2} \mathbb{1}_{\left|\mathbf{V}_{n}^{i}(x)-\mathbb{E}\left[\mathbf{V}_{n}^{i}(x)\right]\right| \infty>\epsilon \sqrt{n}}\right] \\
& =\mathbb{E}\left[\left|\mathbf{V}_{n}(x)-\mathbb{E}\left[\mathbf{V}_{n}(x)\right]\right|_{\infty}^{2} \mathbb{1}\left\{\sup _{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)}\left|\mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}}-\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right)\right|>\epsilon \sqrt{k p_{n}(\mathrm{C})}\right\}\right] \\
& \rightarrow 0
\end{aligned}
$$

where $|\cdot|_{\infty}$ denotes the $\ell^{\infty}$-norm. Indeed, the inequality in the indicator function is never satisfied for $n$ large enough since the left-hand side is bounded by 1 while the right-hand side diverges to infinity for any $\epsilon>0$ as all clusters belong to $\mathcal{S}_{\infty}$.

By Lindeberg-Feller's theorem we obtain the weak convergence

where $(N(\mathrm{C}))_{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)}$ is a standard centered Gaussian random vector. This convergence can be rewritten as

\sqrt{k}\left(\widetilde{\mathbf{S}}_{n}(x)\right)^{-1 / 2}\left(\frac{T_{n}(x, \mathrm{C})}{k \sqrt{p_{n}(\mathrm{C})}}-\frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right)}{k \sqrt{p_{n}(\mathrm{C})}}\right)_{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)} \xrightarrow{d}(N(\mathrm{C}))_{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)} . \tag{1.8}
\end{equation*}
$$

2. Equicontinuity

In order to prove that the convergence in (1.8) holds uniformly over $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$ it suffices to establish the equicontinuity of the process $\left\{T_{n}(x, \mathrm{C})\right\}_{x, \mathrm{C}}$ in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right] \times \mathcal{U}_{\infty}\right)$, see Theorem 2.11 .9 by Van der Vaart and Wellner (1996). We consider the totally bounded semi-metric space $\left[\frac{1}{1+\tau}, 1+\tau\right] \times \mathcal{U}_{\infty}$ equipped with the semi-metric $\rho$ defined by

We check that the three assumptions given in Theorem 2.11.9 in Van der Vaart and Wellner (1996) are satisfied.
2.a. The Lindeberg condition: It is similar to the one established in the first part of the proof.
2.b. The bracketing condition: Recall that the vector $\mathbf{V}_{n}(x) \in \mathbb{R}^{2^{s \infty}-1}$ has components

We consider a sequence $\left(\delta_{n}\right)_{n \geq 1}$ decreasing to zero. For $n$ large enough the condition $\rho\left((x, \mathrm{C}),\left(x^{\prime}, \mathrm{C}^{\prime}\right)\right)<\delta_{n}$ is then satisfied only for $\mathrm{C}=\mathrm{C}^{\prime}$. This leads to the following relations:

=\frac{n}{k p_{n}(\mathrm{C})} \mathbb{E}\left[\left(\mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right\}}-\mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A\left(x^{\prime}, \mathrm{C}\right)\right\}}\right)^{2}\right]
$$

$$
=\frac{n}{k p_{n}(\mathrm{C})}\left[\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C}) \cap A\left(x^{\prime}, \mathrm{C}\right)^{c}\right)+\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})^{c} \cap A\left(x^{\prime}, \mathrm{C}\right)\right)\right]
$$

where $A(x, \mathrm{C})^{c}$ denotes the complementary of the set $A(x, \mathrm{C})$. Since the set $A(x, \mathrm{C})$ consists of disjoint unions of $A(x, \beta)$ it can be decomposed as

If $\beta$ is such that $C_{\beta} \subset \mathrm{C}^{\prime}$ then we have the inclusion $A\left(x^{\prime}, \mathrm{C}\right)^{c} \subset A\left(x^{\prime}, \beta\right)^{c}$. This gives the inequality
$\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C}) \cap A\left(x^{\prime}, \mathrm{C}\right)^{c}\right) \leq \sum_{\beta: C_{\beta} \subset \mathrm{C}} \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta) \cap A\left(x^{\prime}, \beta\right)^{c}\right)=: \sum_{\beta: C_{\beta} \subset C} v_{n}\left(\beta, x, x^{\prime}\right)$.
Similarly we set $w_{n}\left(\beta, x, x^{\prime}\right)=\mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)^{c} \cap A\left(x^{\prime}, \beta\right)\right)$ and the same arguments applied to $A(x, \mathrm{C})^{c} \cap A\left(x^{\prime}, \mathrm{C}\right)$ entail that

\mathbb{E}\left[\left(V_{n}(x, \mathrm{C})-V_{n}\left(x^{\prime}, \mathrm{C}\right)\right)^{2}\right] & \leq \frac{n}{k p_{n}(\mathrm{C})}\left(\sum_{\beta: C_{\beta} \subset \mathrm{C}} v_{n}\left(\beta, x, x^{\prime}\right)+\sum_{\beta \subset \mathrm{C}} w_{n}\left(\beta, x, x^{\prime}\right)\right) \\
& \leq \sum_{\beta: C_{\beta} \subset \mathrm{C}}\left(\frac{n v_{n}\left(\beta, x, x^{\prime}\right)}{k p_{n}(\beta)}+\frac{n w_{n}\left(\beta, x, x^{\prime}\right)}{k p_{n}(\beta)}\right) \tag{1.9}
\end{align*}
$$

where we used that $p_{n}(\beta) \leq p_{n}(\mathrm{C})$ for any $\beta$ such that $C_{\beta} \subset \mathrm{C}$.
We deal with the term $v_{n}\left(\beta, x, x^{\prime}\right)$ (the calculations with $w_{n}\left(\beta, x, x^{\prime}\right)$ are similar). Since we assumed the marginals of $\mathbf{X}$ to be continuous the event $\left\{x^{\prime}|\mathbf{X}|=u_{n}\right\}$ has zero probability. Moreover we recall that we project onto the $\ell^{1}$-ball (see Remark ?? in the main text), therefore if $\pi\left(x^{\prime} \mathbf{X} / u_{n}\right) \in C_{\beta}$ then $x^{\prime}|\mathbf{X}|>u_{n}$. Both considerations entail that

& +\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i} / u_{n}<1, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} / u_{n} \geq 1, \min _{i \in \beta} x^{\prime} \mathbf{X}_{\beta, i} / u_{n}<1\right) . \tag{1.10}
\end{align*}
$$

Note that the first (resp. second) probability is non-null only if $x<x^{\prime}$ (resp. $x^{\prime}<x$ ). The first term in (1.10) multiplied by $\frac{n}{k p_{n}(\beta)}$ is equivalent to

& =\frac{\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i} / u_{n}<1, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} / u_{n} \geq 1, \max _{i \in \beta} x^{\prime} \mathbf{X}_{\beta, i} / u_{n} \geq 1\right)}{\mathbb{P}\left(\max _{i \in \beta} \mathbf{X}_{\beta, i} / u_{n}<1 \min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} / u_{n} \geq 1\right)} \\
& \underset{n \rightarrow \infty}{\longrightarrow} \frac{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} x \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} x \mathbf{y}_{\beta, i}(\beta) \geq 1, \max _{i \in \beta} x^{\prime} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)}{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)},
\end{aligned}
$$

where we used the regular variation property of $\mathbf{X}$ on $\mathbb{R}_{+}^{d} \backslash \mathbb{C}_{\beta}$. By regular variation of the function

x \mapsto \frac{\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i} / u_{n}<1, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} / u_{n} \geq 1, \max _{i \in \beta} x^{\prime} \mathbf{X}_{\beta, i} / u_{n} \geq 1\right)}{\mathbb{P}\left(\max _{i \in \beta} \mathbf{X}_{\beta, i} / u_{n}<1 \min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} / u_{n} \geq 1\right)}
$$

(see the arguments in Section 1.1 of the Supplementary Material), the former convergence actually holds uniformly on $\left[\frac{1}{1+\tau}, 1+\tau\right]$, see Bingham et al. (1987), Section 1.2. Finally,
the homogeneity property of the limit implies that the previous limit is bounded by

\left.\left.\mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right) \\
\quad=\frac{\mu\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta) \geq 1 / x^{\prime}\right\}\right)-\mu\left(\left\{\mathbf{y}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta) \geq 1 / x\right\}\right)}{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)} \\
\quad=\left(x^{\prime \alpha(\beta)}-x^{\alpha(\beta)}\right) \frac{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)}{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)} \\
\quad=:\left(x^{\prime \alpha(\beta)}-x^{\alpha(\beta)}\right) C_{1}(\beta) .
\end{array} .
\end{aligned}
$$

Similar arguments allow us to deal with the second term in (1.10). This quantity multiplied by $\frac{n}{k p_{n}(\beta)}$ is equivalent to

& =\frac{\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i} / u_{n}<1, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} / u_{n} \geq 1, \min _{i \in \beta^{c}} x^{\prime} \mathbf{X}_{\beta, i} / u_{n}<1\right)}{\mathbb{P}\left(\max _{i \in \beta} \mathbf{X}_{\beta, i} / u_{n}<1 \min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} / u_{n} \geq 1,\right)} \\
& =\frac{\mathbb{P}\left(\max _{i \in \beta} x \mathbf{X}_{\beta, i} / u_{n}<1, \min _{i \in \beta^{c}} x \mathbf{X}_{\beta, i} / u_{n} \geq 1, \min _{i \in \beta} x^{\prime} \mathbf{X}_{\beta, i} / u_{n}<1\right)}{\mathbb{P}\left(\max _{i \in \beta} \mathbf{X}_{\beta, i} / u_{n}<1 \min _{i \in \beta^{c}} \mathbf{X}_{\beta, i} / u_{n} \geq 1\right)} .
\end{aligned}
$$

Assumption ?? combined with Bingham et al. (1987), Section 1.2, then ensures the uniform convergence of the former term to

\frac{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} x \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} x \mathbf{y}_{\beta, i}(\beta) \geq 1, \min _{i \in \beta^{c}} x^{\prime} \mathbf{y}_{\beta, i}(\beta)<1\right\}\right)}{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)} .
$$

We conclude by using the homogeneity of the measure $\mu_{\beta}$ which entails the following bound
for the limit:

& \quad=\frac{\mu\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1 / x\right\}\right)-\mu\left(\left\{\mathbf{y}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta) \geq 1 / x^{\prime}\right\}\right)}{\mu_{\beta}\left(\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: \max _{i \in \beta} \mathbf{y}_{\beta, i}(\beta)<1, \min _{i \in \beta^{c}} \mathbf{y}_{\beta, i}(\beta) \geq 1\right\}\right)} \\

& \quad=\left(x^{\alpha(\beta)}-x^{\prime \alpha(\beta)}\right) C_{2}(\beta) .

Similar calculations give the same bound for the term $w_{n}\left(x, x^{\prime}\right)$ in (1.9). Going back to Equation (1.9), we obtain

& \leq \lim _{n \rightarrow \infty} \sup _{\rho\left((x, B),\left(x^{\prime}, B\right)\right)<\delta_{n}} \sum_{\beta \subset B} 2\left(C_{1}(\beta)+C_{2}(\beta)\right)\left(x^{\alpha(\beta)} \vee x^{\prime \alpha(\beta)}-x^{\alpha(\beta)} \wedge x^{\prime \alpha(\beta)}\right) \\
& \leq C \lim _{n \rightarrow \infty} \sup _{\rho\left((x, B),\left(x^{\prime}, B\right)\right)<\delta_{n}}\left(x^{\alpha(\beta)} \vee x^{\prime \alpha(\beta)}-x^{\alpha(\beta)} \wedge x^{\prime \alpha(\beta)}\right) \\
& \leq C \lim _{n \rightarrow \infty} \delta_{n} \\
& =0,
\end{array}
$$

where we used in the penultimate line the definition of the semi-metric $\rho$. This concludes the proof of the bracketing condition.
2.c. The entropy condition: By a standard inequality (see for instance Theorem 2.6.4 in Van der Vaart and Wellner (1996)), it suffices to prove that the Vapnik-Chervonenkis (VC) dimension of the family of sets

\mathcal{A}=\left\{A(x, \mathrm{C}): x \in\left[\frac{1}{1+\tau}, 1+\tau\right], \mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)\right\}
$$

is finite. Since $\mathcal{U}\left(\mathcal{S}_{\infty}\right)$ is a finite set it suffices to focus on the family $\{A(x, \mathrm{C}): x \in$ $\left.\left[\frac{1}{1+\tau}, 1+\tau\right]\right\}$ for a fixed C. Moreover, by Lemma 2.6.17 in Van der Vaart and Wellner (1996) it suffices to prove that the family $\left\{A(x, \beta): x \in\left[\frac{1}{1+\tau}, 1+\tau\right]\right\}$ for a fixed $\beta \in \mathcal{S}_{\infty}$ has a finite VC dimension.

In virtue of the equivalence (1.2) the set $A(x, \beta)$ can be rewritten as the intersection of the $|\beta|$ affine hyperplans $\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: x \sum_{j \in \beta} y_{j}<x|\beta| y_{i}+1\right\}$ for $i \in \beta$ and the $\left|\beta^{c}\right|$ ones $\left\{\mathbf{y} \in \mathbb{R}_{+}^{d}: x \sum_{j \in \beta} y_{j} \geq x|\beta| y_{i}+1\right\}$ for $i \in \beta^{c}$. It is well known that the family of affine hyperplans in $\mathbb{R}^{d}$ has VC dimension $d+1$. Using again Lemma 2.6.17 in Van der Vaart and Wellner (1996), we obtain that the family $\left\{A(x, \beta): x \in\left[\frac{1}{1+\tau}, 1+\tau\right]\right\}$ forms a class of sets with finite VC dimension. This concludes the third point of the proof.

## 3. Conclusion

We have proved that the convergence

$$
\begin{align*}
& \left\{\sqrt{k}\left(\widetilde{\mathbf{S}}_{n, x}\right)^{-1 / 2}\left(\frac{T_{n}(x, \mathrm{C})}{k \sqrt{p_{n}(\mathrm{C})}}-\frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \mathrm{C})\right)}{k \sqrt{p_{n}(\mathrm{C})}}\right)_{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)} ; x \in\left[\frac{1}{1+\tau}, 1+\tau\right]\right\}  \tag{1.11}\\
& \xrightarrow{d}(N(\mathrm{C}))_{\mathrm{C} \in \mathcal{U}\left(\mathcal{S}_{\infty}\right)},
\end{align*}
$$

holds in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$, where the limit process is constant in $x$. We identify it to a standard Gaussian random vector in $\mathbb{R}^{2^{s \infty}-1}$.

Now let $1 \leq s \leq r \leq s_{\infty}$ and $\beta_{1}, \ldots, \beta_{r}$ distinct clusters in $\mathcal{S}_{\infty}$. Recall that the vector $\mathbf{T}_{n}^{s, r}(x) \in \mathbb{R}^{s+1}$ is defined by

$$
\mathbf{T}_{n}^{s, r}(x)=\left(T_{n}\left(x, \beta_{1}\right), \ldots, T_{n}\left(x, \beta_{s}\right), \sum_{j=s+1}^{r} T_{n}\left(x, \beta_{j}\right)\right)^{\top}
$$

Since the $C_{\beta}$ 's are disjoint sets of the simplex, the last component of $\mathbf{T}_{n}^{s, r}(x)$ can be rewritten as

$$
\sum_{j=s+1}^{r} T_{n}\left(x, \beta_{j}\right)=T_{n}\left(x, \cup_{j=s+1}^{r} C_{\beta_{j}}\right) .
$$

We use the convergence (1.11) with $\mathrm{C}_{1}=C_{\beta_{1}}, \ldots, \mathrm{C}_{s}=C_{\beta_{s}}, \mathrm{C}_{s+1}=C_{\beta_{s+1}} \cup \cdots \cup C_{\beta_{r}}$. In this case, the matrix $\widetilde{\mathbf{S}}_{n}(x)$ has the same asymptotic behavior as the diagonal matrix whose diagonal vector is given by

$$
\left(x^{\alpha\left(\beta_{1}\right)}, \ldots, x^{\alpha\left(\beta_{s}\right)}, \frac{\sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right) x^{\alpha\left(\beta_{j}\right)}}{\sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right)}\right)^{\top}
$$

Then the reformulation of the convergence in (1.11) becomes

$$
\left\{\sqrt{k}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}(x)}{k}-\mathbb{E}\left[\frac{\mathbf{T}_{n}^{s, r}(x)}{k}\right]\right) ;(1+\tau)^{-1} \leq x \leq 1+\tau\right\}_{s<r} \xrightarrow{d}\left(\mathbf{N}^{s, r}\right)_{s<r},
$$

in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$, where the constant limit process is identified to

$$
\mathbf{N}^{s, r}=\left(N\left(\mathrm{C}_{1}\right), \ldots, N\left(\mathrm{C}_{s+1}\right)\right)^{\top}
$$

and where

$$
\mathbf{P}_{n}^{s, r}(x)=\left(x^{\alpha\left(\beta_{1}\right)} p_{n}\left(\beta_{1}\right), \ldots, x^{\alpha\left(\beta_{s}\right)} p_{n}\left(\beta_{s}\right), \sum_{j=s+1}^{r} x^{\alpha\left(\beta_{j}\right)} p_{n}\left(\beta_{j}\right)\right)^{\top} \in \mathbb{R}^{s+1}
$$

This concludes the proof of the convergence (??) of Theorem ??.
Finally, in order to prove the convergence in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ of the process

$$
\begin{equation*}
\left\{\sqrt{k} \operatorname{Diag}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}(x)}{k}-\mathbf{P}_{n}^{s, r}(x)\right) ;(1+\tau)^{-1} \leq x \leq 1+\tau\right\}_{s<r} \xrightarrow{d}\left(\mathbf{N}^{s, r}\right)_{s<r}, \tag{1.12}
\end{equation*}
$$

it suffices to prove that

$$
\sup _{x \in\left[\frac{1}{1+\tau}, 1+\tau\right]} \sqrt{k}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left|\mathbb{E}\left[\frac{\mathbf{T}_{n}^{s, r}(x)}{k}\right]-\mathbf{P}_{n}^{s, r}(x)\right| \rightarrow 0
$$

The last convergence holds true if for any $\beta \in \mathcal{S}_{\infty}$ we have

$$
\sup _{x \in\left[\frac{1}{1+\tau}, 1+\tau\right]} \sqrt{\frac{k}{p_{n}(\beta) x^{\alpha(\beta)}}}\left|\frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A(x, \beta)\right)}{k}-x^{\alpha(\beta)} p_{n}(\beta)\right| \rightarrow 0 .
$$

This is clearly implied by the bias assumption (??).

### 1.4 Proof of Proposition??

Recall that we work with a level $\left(k_{n}\right) \in K$ so that the identity $\mathcal{S}_{\infty}=\widehat{\mathcal{S}}_{n}$ holds true almost surely for $n$ large enough. Under this condition we get

$$
\sum_{\beta \in \mathcal{S}_{\infty}} T_{n}(x, \beta)=\sum_{j=1}^{n} \mathbb{1}\left\{x\left|\mathbf{X}_{j}\right|>u_{n}\right\}
$$

Then the convergence (1.11) with $\mathrm{C}=\cup_{\beta \in \mathcal{S}_{\infty}} C_{\beta}$ gives

$$
\left\{\sqrt{k} \frac{\frac{\sum_{j=1}^{n} \mathbb{1}\left\{x\left|\mathbf{X}_{j}\right|>u_{n}\right\}}{k}-\sum_{\beta \in \mathcal{S}_{\infty}} x^{\alpha(\beta)} p_{n}(\beta)}{\sqrt{\sum_{\beta \in \mathcal{S}_{\infty}} x^{\alpha(\beta)} p_{n}(\beta)}} ;(1+\tau)^{-1} \leq x \leq 1+\tau\right\} \xrightarrow{d} \mathbf{N}^{0, s_{\infty}}
$$

in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$, with $\mathbf{N}^{0, s_{\infty}}$ a standard Gaussian random variable. Since $p^{*}(\beta)$ is null for $\beta \notin \mathcal{S}^{*}(\mathbf{Z})$ and $\alpha(\beta)=\alpha$ for $\beta \in \mathcal{S}^{*}(\mathbf{Z})$ we obtain that

$$
\sum_{\beta \in \mathcal{S}_{\infty}} x^{\alpha(\beta)} p^{*}(\beta)=x^{\alpha} \sum_{\beta \in \mathcal{S}^{*}(\mathbf{Z})} p^{*}(\beta)=x^{\alpha}
$$

After multiplying both sides of the previous convergence by $x^{\alpha / 2}$ and using Slutsky's lemma we get

$$
\sqrt{k}\left(\frac{\sum_{j=1}^{n} \mathbb{1}\left\{x\left|\mathbf{X}_{j}\right|>u_{n}\right\}}{k}-\sum_{\beta \in \mathcal{S}_{\infty}} x^{\alpha(\beta)} p_{n}(\beta)\right) \xrightarrow{d} x^{\alpha / 2} \mathbf{N}^{0, s_{\infty}} .
$$

The bias assumption (??) allows one to replace the centering term by $\sum_{\beta \in \mathcal{S}_{\infty}} x^{\alpha(\beta)} p^{*}(\beta)=$ $x^{\alpha}$. Applying Vervaat's Lemma (see for instance Lemma A.0.2 in de Haan and Ferreira (2006)) to the nondecreasing function $f_{n}(x)=k^{-1} \sum_{j=1}^{n} \mathbb{1}\left\{x\left|\mathbf{X}_{j}\right|>u_{n}\right\}$ we obtain

$$
\sqrt{k}\left(\frac{u_{n}}{\left|\mathbf{X}_{(\lceil x k\rceil+1)}\right|}-x^{1 / \alpha}\right) \xrightarrow{d}-\frac{1}{\alpha} x^{1 / \alpha-1} x^{1 / 2} \mathbf{N}^{0, s_{\infty}}, \quad n \rightarrow \infty,
$$

where we used that $f_{n}^{\leftarrow}(x)=|\mathbf{X}|_{(\lceil x k]+1)} / u_{n}$. We fix $x=1$ in the previous convergence and use the Delta-method with $g(t)=t^{\alpha(\beta)}$ for a fixed $\beta \in \mathcal{S}_{\infty}$ which gives the convergence

$$
\sqrt{k}\left\{\left(\frac{u_{n}}{\left|\mathbf{X}_{(k+1)}\right|}\right)^{\alpha(\beta)}-1\right\} \xrightarrow{d}-\frac{\alpha(\beta)}{\alpha} \mathbf{N}^{0, s_{\infty}}, \quad n \rightarrow \infty .
$$

The relation $\alpha(\beta)=\alpha$ for any $\beta \in \mathcal{S}^{*}(\mathbf{Z})$ then yields

$$
\sqrt{k}\left\{\left(\frac{u_{n}}{\left|\mathbf{X}_{(k+1)}\right|}\right)^{\alpha(\beta)}-1\right\} \sqrt{p_{n}(\beta)} \xrightarrow{d} \begin{cases}-\sqrt{p^{*}(\beta)} \mathbf{N}^{0, s_{\infty}}, & \text { for } \beta \in \mathcal{S}(\mathbf{Z})  \tag{1.13}\\ 0, & \text { for } \beta \in \mathcal{S}_{\infty} \backslash \mathcal{S}(\mathbf{Z})\end{cases}
$$

Now we start from the decomposition

$$
\begin{align*}
& \sqrt{k}\left(\mathbf{P}_{n}^{s, r}(1)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)}{k}-\mathbf{P}_{n}^{s, r}(1)\right)  \tag{1.14}\\
& =\left.\left(\mathbf{P}_{n}^{s, r}(1)\right)^{-1 / 2}\left(\mathbf{P}_{n}^{s, r}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)\right)^{1 / 2}\left\{\sqrt{k}\left(\mathbf{P}_{n}^{s, r}(x)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}(x)}{k}-\mathbf{P}_{n}^{s, r}(x)\right)\right\}\right|_{x=u_{n} /\left|\mathbf{X}_{(k+1)}\right|} \\
& \quad+\sqrt{k}\left(\mathbf{P}_{n}^{s, r}(1)\right)^{-1 / 2}\left(\mathbf{P}_{n}^{s, r}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)-\mathbf{P}_{n}^{s, r}(1)\right)
\end{align*}
$$

Since $u_{n} /\left|\mathbf{X}_{(k+1)}\right| \rightarrow 1$ in probability, the uniform convergence in (1.12) combined with Slutsky's lemma ensures that the first term converges in distribution to $\mathbf{N}^{s, r}$. Regarding the second term Equation (1.13) ensures that it converges to $-\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}$ where we recall that

$$
\mathbf{P}^{s, r}=\left(p^{*}\left(\beta_{1}\right), \ldots, p^{*}\left(\beta_{s}\right), \sum_{j=s+1}^{r} p^{*}\left(\beta_{j}\right)\right)^{\top}
$$

The covariance matrix of $\mathbf{N}^{s, r}-\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}$ can be decomposed as follows:

$$
\begin{align*}
\Sigma\left(\mathbf{N}^{s, r}\right. & \left.-\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}\right)  \tag{1.15}\\
& =\Sigma\left(\mathbf{N}^{s, r}\right)-\Sigma\left(\mathbf{N}^{s, r}, \sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}\right)-\Sigma\left(\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}, \mathbf{N}^{s, r}\right)+\Sigma\left(\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}\right) \\
& =I d_{s+1}-\Sigma\left(\mathbf{N}^{s, r}, \sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}\right)-\Sigma\left(\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}, \mathbf{N}^{s, r}\right)+\sqrt{\mathbf{P}^{s, r}} \sqrt{\mathbf{P}^{s, r}}
\end{align*}
$$

where we used the fact that $\mathbf{N}^{s, r}$ (resp. $\mathbf{N}^{0, s_{\infty}}$ ) is a centered Gaussian random vector (resp. variable). Here we have denoted by $\Sigma(\mathbf{X}, \mathbf{Y})$ the matrix $\mathbb{E}\left[\mathbf{X} \cdot \mathbf{Y}^{\top}\right]$ for any centered random vectors $\mathbf{X}$ and $\mathbf{Y}$. Regarding the middle terms, we start from the covariance matrix defined in (1.6) with $x=1$ and restricted to the sets

$$
\mathrm{C}_{1}=C_{\beta_{1}}, \ldots, \mathrm{C}_{s}=C_{\beta_{s}}, \mathrm{C}_{s+1}=C_{\beta_{s+1}} \cup \cdots \cup C_{\beta_{r}}, \mathrm{C}_{s+2}=\cup_{\beta \in \mathcal{S}_{\infty}} C_{\beta}
$$

This gives the following covariance matrix in $\mathbb{R}^{s+2} \times \mathbb{R}^{s+2}$ :

$$
\left(\begin{array}{ccccc}
1 & b_{1,2}^{n} & \cdots & b_{1, s+1}^{n} & \sqrt{\frac{p_{n}\left(\beta_{1}\right)}{\sum_{\beta \in \mathcal{S}_{\infty} p_{n}(\beta)}}} \\
\vdots & \ddots & & & \vdots \\
b_{s+1,1}^{n} & \cdots & b_{s, s+1}^{n} & 1 & \sqrt{\frac{\sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right)}{\sum_{\beta \in \mathcal{S}_{\infty}} p_{n}(\beta)}} \\
\sqrt{\frac{p_{n}\left(\beta_{1}\right)}{\sum_{\beta \in \mathcal{S}_{\infty} p_{n}(\beta)}}} & \cdots & \cdots & \sqrt{\frac{\sum_{j=s+1}^{r} p_{n}\left(\beta_{j}\right)}{\sum_{\beta \in \mathcal{S}_{\infty}} p_{n}(\beta)}} & 1
\end{array}\right)
$$

with

$$
b_{i, j}^{n}=-\frac{k}{n} \sqrt{p_{n}\left(\mathrm{C}_{i}\right) p_{n}\left(\mathrm{C}_{j}\right)} .
$$

It converges to the covariance matrix of the vector $\left(\mathbf{N}^{s, r^{\top}}, \mathbf{N}^{0, s_{\infty}}\right)^{\top}$ :

$$
\Sigma\left(\left(\mathbf{N}^{s, r \top}, \mathbf{N}^{0, s_{\infty}}\right)^{\top}\right)=\left(\begin{array}{ccccc}
1 & 0 & \cdots & 0 & \sqrt{p^{*}\left(\beta_{1}\right)} \\
\vdots & \ddots & & \vdots & \vdots \\
0 & \cdots & 0 & 1 & \sqrt{\sum_{j=s+1}^{r} p^{*}\left(\beta_{j}\right)} \\
\sqrt{p^{*}\left(\beta_{1}\right)} & \cdots & \cdots & \sqrt{\sum_{j=s+1}^{r} p^{*}\left(\beta_{j}\right)} & 1
\end{array}\right)
$$

We deduce that

$$
\Sigma\left(\mathbf{N}^{s, r}, \sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}\right)=\Sigma\left(\mathbf{N}^{s, r}, \mathbf{N}^{0, s_{\infty}}\right) \sqrt{\mathbf{P}^{s, r}}{ }^{\top}=\sqrt{\mathbf{P}^{s, r}}{\sqrt{\mathbf{P}^{s, r}}}^{\top}
$$

Moving back to (1.15), we conclude that the covariance matrix of $\mathbf{N}^{s, r}-\sqrt{\mathbf{P}^{s, r}} \mathbf{N}^{0, s_{\infty}}$ is equal to $I d_{s+1}-\sqrt{\mathbf{P}^{s, r}} \sqrt{\mathbf{P}^{s, r}}{ }^{\top}$.

All in all the decomposition in (1.14) leads to the convergence

$$
\sqrt{k}\left(\boldsymbol{\Sigma}_{n}(1)\right)^{-1 / 2}\left(\frac{\mathbf{T}_{n}^{s, r}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)}{k}-\mathbf{P}_{n}^{s, r}(1)\right) \rightarrow\left(I d_{s+1}-\sqrt{\mathbf{P}^{s, r}}{\sqrt{\mathbf{P}^{s, r}}}^{\top}\right) \mathbf{N}, \quad n \rightarrow \infty
$$

with $\mathbf{N}$ a standard centered Gaussian vector.

### 1.5 Proof of Remark ??

Section 1.1 ensures that the function $t \mapsto \mathbb{P}(\mathbf{X} / t \in A(1, \beta))$ is regularly varying with index $\alpha(\beta)$. It follows that $\mathbb{P}\left(\mathbf{X} / u_{n} \in A(1, \beta)\right)=u_{n}^{-\alpha(\beta)} l\left(u_{n}\right)$, where $l$ is a slowly varying function, ie $l(t x) / l(t) \rightarrow 1$ as $t \rightarrow \infty$, for all $x>0$. Combining this relation with the asymptotic expansion $k \sim n \mathbb{P}\left(|\mathbf{X}|>u_{n}\right) \sim n u_{n}^{-\alpha}$, we get

$$
p_{n}(\beta)=\frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A(1, \beta)\right)}{n \mathbb{P}\left(|\mathbf{X}|>u_{n}\right)} \sim \frac{n u_{n}^{-\alpha(\beta)} l\left(u_{n}\right)}{k} \sim \frac{n}{k}\left(\frac{k}{n}\right)^{\alpha(\beta) / \alpha} l\left(u_{n}\right)
$$

This leads to the following equivalences, as $n \rightarrow \infty$,

$$
\sqrt{k} p_{n}(\beta) \rightarrow 0 \Longleftrightarrow \sqrt{k} \frac{k^{\frac{\alpha(\beta)-\alpha}{\alpha}}}{n^{\frac{\alpha(\beta)-\alpha}{\alpha}}} l\left(u_{n}\right) \rightarrow 0 \Longleftrightarrow \frac{k^{\frac{2 \alpha(\beta)-\alpha}{2 \alpha}}}{n^{\frac{\alpha(\beta)-\alpha}{\alpha}}} l\left(u_{n}\right) \rightarrow 0 .
$$

After raising the latter expression to the power $2 \alpha /(2 \alpha(\beta)-\alpha)$, we get

$$
\sqrt{k} p_{n}(\beta) \rightarrow 0 \Longleftrightarrow \frac{k}{n^{\frac{2(\alpha(\beta)-\alpha)}{2 \alpha(\beta)-\alpha}} l\left(u_{n}\right)^{\frac{2 \alpha}{2 \alpha(\beta)-\alpha}} \rightarrow 0 . . . ~ . ~ . ~}
$$

Since $l$ is slowly varuing we have $\left(u_{n}\right)^{-\epsilon} l\left(u_{n}\right) \rightarrow 0$ for any $\epsilon>0$. Therefore, if $\kappa>\frac{2(\alpha(\beta)-\alpha)}{2 \alpha(\beta)-\alpha}$ then the assumption $k=o\left(n^{\kappa}\right)$ implies that $\sqrt{k} p_{n}(\beta) \rightarrow 0$.

### 1.6 Proof of Theorem ??

In order to prove the convergence

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}_{k}}\right]-\mathbb{E}\left[\log L_{\mathbf{P}_{k}}\left(\mathbf{T}_{n, k}\right)\right]+\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n, k}\right)\right] \rightarrow s
$$

we prove that

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}_{k}(x)}\right]-\mathbb{E}\left[\log L_{\mathbf{P}_{k}(x)}\left(\mathbf{T}_{n}(x)\right)\right]+\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)\right]=\mathbb{E}\left[\psi_{n}(x)\right],
$$

where $\mathbf{T}_{n}(x)$ denotes the vector of $\mathbb{R}^{2^{d}-1}$ with ordered components

$$
T_{n, i}(x)=\sum_{j=1}^{n} \mathbb{1}_{\left\{\mathbf{X} / u_{n} \in A\left(x, \beta_{i}\right)\right\}}
$$

$\mathbf{P}_{k}(x)$ denotes its distribution, $\hat{\mathbf{p}}(x)$ the maximum likelihood estimator of the model $\mathbf{M}_{k}$ for the vector $\mathbf{T}_{n}(x)$, and $\psi_{n}(x)$ satisfies

$$
\psi_{n}(x) \xrightarrow{d} \chi^{2}(s), \quad n \rightarrow \infty .
$$

uniformly over $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$.
We recall the expression of the $\log$-likelihood $\log L_{\mathbf{M}_{k}}$ as a function of $\mathbf{p}:=\left(p_{1}, \ldots, p_{s}\right)^{\top} \in$ $\mathcal{B}_{+}^{s}(0,1)$ :

$$
\begin{aligned}
\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)=\log (k!)-\sum_{i=1}^{2^{d}-1} \log \left(T_{n, i}(x)!\right) & +\sum_{i=1}^{s} T_{n, i}(x) \log \left(p_{i}\right) \\
& +\left(\sum_{i=s+1}^{r} T_{n, i}(x)\right) \log \left(\frac{1-\sum_{j=1}^{s} p_{j}}{r-s}\right) .
\end{aligned}
$$

The expectation of $T_{n, j}(x)$ is given by $\mathbb{E}\left[T_{n, j}(x)\right]=p_{n, j}(x) a_{n}(x)$, where

$$
p_{n, j}(x)=\mathbb{P}\left(\pi\left(x \mathbf{X} / u_{n}\right) \in C_{\beta_{j}}|x| \mathbf{X} \mid>u_{n}\right),
$$

and

$$
a_{n}(x)=n \mathbb{P}\left(x|\mathbf{X}|>u_{n}\right)=n \mathbb{P}\left(|\mathbf{X}|>u_{n}\right) \frac{\mathbb{P}\left(x|\mathbf{X}|>u_{n}\right)}{\mathbb{P}\left(|\mathbf{X}|>u_{n}\right)} \sim k x^{\alpha}, \quad n \rightarrow \infty
$$

This gives the following expression for the expectation of the log-likelihood:

$$
\begin{align*}
\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)\right]=\log (k!)-\mathbb{E} & {\left[\sum_{i=1}^{2^{d}-1} \log \left(T_{n, i}(x)!\right)\right]+a_{n}(x) \sum_{i=1}^{s} p_{n, i}(x) \log \left(p_{i}\right) }  \tag{1.16}\\
& +a_{n}(x)\left(\sum_{i=s+1}^{r} p_{n, i}(x)\right) \log \left(\frac{1-\sum_{j=1}^{s} p_{j}}{r-s}\right) .
\end{align*}
$$

A similar computation as for the maximum likelihood estimator entails that this expectation is maximized for

$$
\mathbf{p}=\tilde{\mathbf{p}}(x):=\left(\frac{p_{n, 1}(x)}{\sum_{j=1}^{r} p_{n, j}(x)}, \ldots, \frac{p_{n, s}(x)}{\sum_{j=1}^{r} p_{n, j}(x)}\right)^{\top} \in \mathcal{B}_{+}^{s}(0,1) .
$$

Note that since $n$ is large enough so that the event $\mathcal{S}_{\infty}=\widehat{\mathcal{S}}_{n}$ holds true almost surely, we have $r=\hat{s}_{n} \geq s^{*}$ and thus $\sum_{j=1}^{\hat{s}_{n}} p_{n, j} \geq \sum_{j=1}^{s^{*}} p_{n, j} \rightarrow 1$. This means that asymptotically we have $\tilde{p}_{j}(x) \sim p_{n, j}(x)$.

The first step of the bias selection consists in establishing a Taylor expansion for the estimator

$$

Lemma 1. There exists $c_{n, 1}(x) \in(0,1)$ such that

$$
\begin{align*}
& \left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}(x)}=\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}  \tag{1.17}\\
& \quad+\left.\frac{1}{2}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n}(x)\right)\right]\right|_{c_{n, 1}(x) \hat{\mathbf{p}}(x)+\left(1-c_{n, 1}(x)\right) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))
\end{align*}
$$

Since the quantity $\tilde{\mathbf{p}}(x)$ is deterministic, the first term of the right-hand side in (1.17) can be written as

$$
\begin{equation*}
\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}=\mathbb{E}\left[\log L_{\mathbf{P}_{k}(x)}\left(\mathbf{T}_{n}(x)\right)\right]-\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\tilde{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)\right] . \tag{1.18}
\end{equation*}
$$

The idea is then to provide a Taylor expansion of $\log L_{\mathbf{M}_{k}}\left(\tilde{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)$ around the vector $\hat{\mathbf{p}}(x)$. This is the purpose of the following lemma.

Lemma 2. There exists $c_{n, 2}(x) \in(0,1)$ such that

& \quad+\frac{1}{2}(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \log L_{\mathbf{M}_{k}}\left(c_{n, 2}(x) \tilde{\mathbf{p}}(x)+\left(1-c_{n, 2}(x)\right) \hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x))
\end{align*}
$$

Lemmas 1 and 2 are a consequence of the following result known as "Cauchy's MeanValue Theorem" (see Hille (1964) for a proof).

Lemma 3. Let $f$ and $g$ be two continuous functions on the closed interval $[a, b], a<b$, and differentiable on the open interval $(a, b)$. Then there exists some $c \in(a, b)$ such that

Proof of Lemma 1. Let $f$ be the function defined as $f(t)=h(t \hat{\mathbf{p}}(x)+(1-t) \tilde{\mathbf{p}}(x))$ for $t \in[0,1]$, where $h$ is defined as

$$

Some short calculations give the following relations:

f(1) & =h(\hat{\mathbf{p}}(x))=\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}(x)}, \\
f(0) & =h(\tilde{\mathbf{p}}(x))=\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}+\left.\frac{\partial}{\partial \mathbf{p}} K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x)) \\
& =\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}-\underbrace{\left.\frac{\partial}{\partial \mathbf{p}} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)\right]\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))}_{=0} \\
& =\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)}, \\
f^{\prime}(t) & =\frac{\partial h}{\partial \mathbf{p}(x)}(t \hat{\mathbf{p}}(x)+(1-t) \tilde{\mathbf{p}}(x))(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x)) \\
& =\left.(\hat{\mathbf{p}}(x)-[t \hat{\mathbf{p}}(x)+(1-t) \tilde{\mathbf{p}}(x)])^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{t \hat{\mathbf{p}}(x)+(1-t) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x)) \\
& =\left.(1-t)(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)\right]\right|_{t \hat{\mathbf{p}}(x)+(1-t) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))
\end{aligned}
$$

We apply Lemma 3 to the functions $f$ and $g: t \mapsto(t-1)^{2}$. There exists $c_{n, 1}(x) \in(0,1)$
such that $(f(1)-f(0)) g^{\prime}\left(c_{n, 1}(x)\right)=(g(1)-g(0)) f^{\prime}\left(c_{n, 1}(x)\right)$, i.e.

\begin{aligned}
K L\left(\mathbf{P}_{k}(x) \|\right. & \left.\mathbf{M}_{k}\right)\left.\right|_{\mathbf{p}=\hat{\mathbf{p}}(x)}-\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\tilde{\mathbf{p}}(x)} \\
& =-\left.\frac{1}{2}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{T}_{n}(x)\right)\right]\right|_{c_{n, 1}(x) \hat{\mathbf{p}}(x)+\left(1-c_{n, 1}(x)\right) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x)) .
\end{aligned}
$$

This concludes the proof.
Proof of Lemma 2. We consider $f(t)=h(t \tilde{\mathbf{p}}(x)+(1-t) \hat{\mathbf{p}}(x))$, for $t \in[0,1]$ where $h$ is defined as

After some calculations we obtain

& f(0)=h(\hat{\mathbf{p}}(x))=\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)+\underbrace{\frac{\partial}{\partial \mathbf{p}} \log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)}_{=0 \text { by definition of } \hat{\mathbf{p}}(x)}(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x)), \\
& f^{\prime}(t)=\frac{\partial h}{\partial \mathbf{p}}(t \tilde{\mathbf{p}}(x)+(1-t) \hat{\mathbf{p}}(x))(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x)) \\
& =(\tilde{\mathbf{p}}(x)-[t \tilde{\mathbf{p}}(x)+(1-t) \hat{\mathbf{p}}(x)])^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \log L_{\mathbf{M}_{k}}\left(t \tilde{\mathbf{p}}(x)+(1-t) \hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x)) \\
& =(1-t)(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \log L_{\mathbf{M}_{k}}\left(t \tilde{\mathbf{p}}(x)+(1-t) \hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x)) .
\end{aligned}
$$

We apply Lemma 3 to the functions $f$ and $g: t \mapsto(t-1)^{2}$. There exists $c_{n}^{2}(x) \in(0,1)$ such that $(f(1)-f(0)) g^{\prime}\left(1-c_{n, 2}(x)\right)=(g(1)-g(0)) f^{\prime}\left(1-c_{n, 2}(x)\right)$, i.e.

& \log L_{\mathbf{M}_{k}}\left(\tilde{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right) \\
& \quad=\frac{1}{2}(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \log L_{\mathbf{M}_{k}}\left(c_{n, 2}(x) \hat{\mathbf{p}}(x)+\left(1-c_{n, 2}(x)\right) \tilde{\mathbf{p}}(x) ; \mathbf{T}_{n}(x)\right)(\tilde{\mathbf{p}}(x)-\hat{\mathbf{p}}(x))
\end{aligned}
$$

This concludes the proof.

Combining Equations (1.17), (1.18), and (1.19), we obtain the following expression for the KL between $\mathbf{P}_{k}(x)$ and $\mathbf{M}_{k}$ evaluated at $\mathbf{p}=\hat{\mathbf{p}}(x)$ :

\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k}(x) \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}(x)}\right]=\mathbb{E}\left[\log L_{\mathbf{P}_{k}(x)}\left(\mathbf{T}_{n}(x)\right)\right]+\mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n}(x)\right]+\mathbb{E}\left[\psi_{n}(x)\right]\right.
$$

with $\psi_{n}(x)$ given by

$$
\begin{aligned}
\psi_{n}(x)= & -\left.\frac{1}{2}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)\right]\right|_{c_{n, 1}(x) \hat{\mathbf{p}}(x)+\left(1-c_{n, 1}(x)\right) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \\
& -\left.\frac{1}{2}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} \frac{\partial^{2}}{\partial \mathbf{p}^{2}} \log L_{\mathbf{M}_{k}}\left(\mathbf{p} ; \mathbf{T}_{n}(x)\right)\right|_{c_{n, 2}(x) \hat{\mathbf{p}}(x)+\left(1-c_{n, 2}(x)\right) \tilde{\mathbf{p}}(x)}(\hat{\mathbf{p}}(x)-\tilde{\mathbf{p}}(x))^{\top} .
\end{aligned}
$$

In order to prove Theorem ?? we establish the uniform convergence of $\psi_{n}(x)$ to a constant process following a chi-square distribution with $s$ degrees of freedom.

Lemma 4. Under the assumptions of Proposition ?? the following convergence holds in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right):$

where $\psi$ is a constant process over $x$ following a chi-square distribution with $s$ degrees of freedom.

$$

where $\mathbf{1}=(1, \ldots, 1)^{\top} \in \mathbb{R}^{s}$. This gives the expression

\begin{equation*}
\psi_{n}(x)=k \sum_{j=1}^{s} \frac{\left(T_{n, j}(x) / k-\tilde{p}_{j}(x)\right)^{2}}{p_{n, j}(x)} A_{n, j}(x)+\left(\frac{\sum_{j=s+1}^{r}\left(T_{n, j}(x) / k-\tilde{p}_{j}(x)\right)}{\sum_{j=s+1}^{r} p_{n, j}(x)}\right)^{2} B_{n}(x), \tag{1.20}
\end{equation*}
$$

where $A_{n, j}(x)$ corresponds to

$$
\frac{p_{n, j}(x) T_{n, j}(x) / k}{2\left(c_{n, 2}(x) T_{n, j}(x) / k+\left(1-c_{n, 2}(x)\right) \tilde{p}_{j}(x)\right)^{2}}+\frac{p_{n, j}(x)^{2}}{2\left(c_{n, 1}(x) T_{n, j}(x) / k+\left(1-c_{n, 1}(x)\right) \tilde{p}_{j}(x)\right)^{2}},
$$

and

$$
\begin{aligned}
B_{n}(x)= & \frac{\sum_{j=s+1}^{r} p_{n, j}(x) \sum_{j=s+1}^{r} T_{n, j}(x) / k}{2\left(c_{n, 2}(x) \sum_{j=s+1}^{r} T_{n, j}(x) / k+\left(1-c_{n, 2}(x)\right) \sum_{j=s+1}^{r} \tilde{p}_{j}(x)\right)^{2}} \\
& \quad+\frac{\left(\sum_{j=s+1}^{r} p_{n, j}(x)\right)^{2}}{2\left(c_{n, 1}(x) \sum_{j=s+1}^{r} T_{n, j}(x) / k+\left(1-c_{n, 1}(x)\right) \sum_{j=s+1}^{r} \tilde{p}_{j}(x)\right)^{2}} .
\end{aligned}
$$

Recall that $\tilde{p}_{j}(x) \sim p_{n, j}(x)$. Then, by Slutsky's lemma and convergence (??) in the main text it suffices to prove that $A_{n, j}$ and $B_{n}$ converges to 1 in probability uniformly in $x$.

The uniform convergence established in Theorem ?? entails that for any $j$ such that $\beta_{j} \in \mathcal{S}_{\infty}$ we have the convergence in probability

uniformly over $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$. Therefore, for any $c_{n}(x) \in(0,1)$ we have

\begin{align*}
& \left|\frac{c_{n}(x) T_{n, j}(x) / k+\left(1-c_{n}(x)\right) \tilde{p}_{j}(x)}{p_{n, j}(x)}-1\right| \\
& \quad=\left|c_{n}(x)\left(\frac{T_{n, j}(x)}{k p_{n, j}(x)}-1\right)+\left(1-c_{n}(x)\right)\left(\frac{\tilde{p}_{j}(x)}{p_{n, j}(x)}-1\right)\right| \\
& \quad \leq\left|\frac{T_{n, j}(x)}{k p_{n, j}(x)}-1\right|+\left|\frac{\tilde{p}_{j}(x)}{p_{n, j}(x)}-1\right| \rightarrow 0, \tag{1.22}
\end{align*}
$$

uniformly over $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$. The uniform convergence (1.21) and (1.22) imply the uniform convergence of $A_{n, j}(x)$ to 1 . Similar arguments provide the uniform convergence of $B_{n}(x)$ to 1 .

This proves the weak convergence in $\ell^{\infty}\left(\left[\frac{1}{1+\tau}, 1+\tau\right]\right)$ of $\psi_{n}(x)$ to a constant process following a chi-square distribution with $s$ degrees of freedom.

Taking $x=u_{n} /\left|\mathbf{X}_{(k+1)}\right|$ we obtain

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]-\mathbb{E}\left[\log L_{\mathbf{P}_{k}}\left(\mathbf{T}_{n, k}\right)\right]+\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n, k}\right)\right]=\mathbb{E}\left[\psi_{n}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)\right],
$$

with $\psi_{n}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right) \xrightarrow{d} \psi$ as $n \rightarrow \infty$, where $\psi$ follows a chi-square distribution with $s$ degrees of freedom.

We now prove that the former convergence holds in expectation. For any $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$ the vector $\mathbf{T}_{n}^{s, r}(x)$ satisfies Lindeberg condition after a normalization and therefore is uniformly integrable. In order to prove that $\psi_{n}(x)$ converges in expectation it suffices to prove that the variables $A_{n, j}(x)$ and $B_{n}(x)$ have bounded second order moments.

We deal with the terms in $A_{n, j}(x)$. If $c_{n, 2}(x) \geq 1 / 2$ we write

c_{n, 2}(x) \frac{T_{n, j}(x)}{k}+\left(1-c_{n, 2}(x)\right) \tilde{p}_{j}(x) \geq c_{n, 2}(x) \frac{T_{n, j}(x)}{k} \geq \frac{1}{2} \frac{T_{n, j}(x)}{k}
$$

while if $c_{n, 2}(x)<1 / 2$ we write

$$
c_{n, 2}(x) \frac{T_{n, j}(x)}{k}+\left(1-c_{n, 2}(x)\right) \tilde{p}_{j}(x) \geq\left(1-c_{n, 2}(x)\right) \tilde{p}_{j}(x) \geq \frac{1}{2} \tilde{p}_{j}(x) .
$$

This leads to the following bound for $A_{n, j}(x)$ :

$$
\begin{aligned}
A_{n, j}(x) \leq & \frac{p_{n, j}(x) T_{n, j}(x) / k}{2\left[(1 / 2) T_{n, j}(x) / k\right]^{2}} \mathbb{1}_{\left\{c_{n, 2}(x) \geq 1 / 2\right\}}+\frac{p_{n, j}(x) T_{n, j}(x) / k}{2\left[(1 / 2) \tilde{p}_{j}(x)\right]^{2}} \mathbb{1}_{\left\{c_{n, 2}(x)>1 / 2\right\}} \\
& \quad+\frac{p_{n, j}(x)^{2}}{2\left[(1 / 2) T_{n, j}(x) / k\right]^{2}} \mathbb{1}_{\left\{c_{n, 2}(x) \geq 1 / 2\right\}}+\frac{p_{n, j}(x)^{2}}{2\left[(1 / 2) \tilde{p}_{j}(x)\right]^{2}} \mathbb{1}_{\left\{c_{n, 2}(x)>1 / 2\right\}} \\
\leq & \frac{2 p_{n, j}(x)}{T_{n, j}(x) / k}+\frac{2 T_{n, j}(x) / k}{p_{n, j}(x)}+\frac{2 p_{n, j}(x)^{2}}{\left(T_{n, j}(x) / k\right)^{2}}+2=: K_{1}+K_{2}+K_{3}+2 .
\end{aligned}
$$

where we used that

$$
\frac{p_{n, j}}{\tilde{p}_{j}}=\frac{p_{n, j}}{\frac{p_{n, j}}{\sum_{j=1}^{r} p_{n, j}}}=\sum_{j=1}^{r} p_{n, j} \leq 1 .
$$

We use the bound established by Cribari et al. (2000) which gives for any integer $l$,

$$
\mathbb{E}\left[\left(\frac{2 p_{n, j}(x)}{T_{n, j}(x) / k}\right)^{l}\right]=2 k^{l} p_{n, j}(x)^{l} \mathbb{E}\left[\frac{1}{T_{n, j}(x)^{l}}\right] \leq C_{1} \frac{k^{l} p_{n, j}(x)^{l}}{n^{l} \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)^{l}}=C_{1} \frac{k^{l}}{a_{n}^{l}(x)},
$$

where $C_{1}$ is a constant and where we recall that $a_{n}(x)=n \mathbb{P}\left(x|\mathbf{X}|>u_{n}\right)$. Karamata's theory on regular variation ensures that the ratio $k / a_{n}(x)$ converges uniformly to $x^{\alpha}$, and thus
that it is bounded. Using this bound with $l=1$ and $l=2$ entails that $\mathbb{E}\left[K_{1}^{2}\right]$ and $\mathbb{E}\left[K_{3}^{2}\right]$ are bounded.

Regarding the term $K_{2}$, its second moment satisfies

$$
\begin{aligned}
\mathbb{E}\left[K_{2}^{2}\right] & =\frac{4 \mathbb{E}\left[T_{n, j}(x)^{2}\right]}{k^{2} p_{n, j}(x)^{2}} \\
& =4 \frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)\left(1-\mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)\right)+n^{2} \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)^{2}}{k^{2} p_{n, j}(x)^{2}} \\
& \leq 4 \frac{n \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)+n^{2} \mathbb{P}\left(\mathbf{X} / u_{n} \in A\left(x, \beta_{j}\right)\right)^{2}}{k^{2} p_{n, j}(x)^{2}} \\
& =4 \frac{a_{n}(x) p_{n, j}(x)+a_{n}(x)^{2} p_{n, j}(x)^{2}}{k^{2} p_{n, j}(x)^{2}} \\
& =4\left(\frac{a_{n}(x)}{k^{2} p_{n, j}(x)}+\frac{a_{n}(x)^{2}}{k^{2}}\right) .
\end{aligned}
$$

We know that $k p_{n, j}(x) \rightarrow \infty$ since we assume $\beta_{j} \in \mathcal{S}_{\infty}$ and that $a_{n}(x) / k$ converges uniformly to $x^{\alpha}$. Using again Karamata's theory on regular variation we obtain that $\mathbb{E}\left[K_{2}^{2}\right]$ is bounded by a constant $C_{2}$.

Therefore, we have proved that $\mathbb{E}\left[\left|A_{n, j}(x)\right|^{2}\right]$ is bounded. Similar arguments ensure that $\mathbb{E}\left[\left|B_{n}(x)\right|^{2}\right]$ is also bounded. This holds for any $x \in\left[\frac{1}{1+\tau}, 1+\tau\right]$ and therefore we obtain the uniform integrability of $\psi_{n}\left(u_{n} /\left|\mathbf{X}_{(k+1)}\right|\right)$ which gives the convergence in expectation

$$
\mathbb{E}\left[\left.K L\left(\mathbf{P}_{k} \| \mathbf{M}_{k}\right)\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]-\mathbb{E}\left[\log L_{\mathbf{P}_{k}}\left(\mathbf{T}_{n, k}\right)\right]+\mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\hat{\mathbf{p}} ; \mathbf{T}_{n, k}\right)\right] \rightarrow s, \quad n \rightarrow \infty
$$

This concludes the proof of Theorem ??.

### 1.7 Level selection

We recall the assumptions ??, ??, and ?? of the main text.
(B1) For $k \in K$ and $\beta_{j} \in \mathcal{S}_{\infty}$ we have

The likelihood $L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime} ; \mathbf{T}_{n}^{\prime}\right)$ of the model $\mathbf{M}_{n}^{\prime}$ is given by

\frac{n!}{\prod_{j=1}^{2^{d}} T_{n, j}^{\prime}!}\left[\prod_{j=1}^{s^{\prime}}\left(p_{j}^{\prime} q^{\prime}\right)^{T_{n, j}^{\prime}}\right]\left[\prod_{j=s^{\prime}+1}^{r^{\prime}}\left(p^{\prime} q^{\prime}\right)^{T_{n, j}^{\prime}}\right]\left(1-q^{\prime}\right)^{T_{n, 2^{d}}^{\prime}}
$$

The likelihood is maximal when $r^{\prime}=\hat{s}_{n}$ and when the $\left(T_{n, j}^{\prime}\right)_{1 \leq j \leq 2^{d}-1}$ are ordered. We will work under these conditions hereafter without changing the notation for simplicity. Using the relation $\sum_{j=1}^{r^{\prime}} T_{n, j}^{\prime}=n-T_{n, 2^{d}}^{\prime}$ we obtain the following expression for the log-likelihood $\log L_{\mathbf{M}_{n}^{\prime}}$ :

\begin{align*}
\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime} ; \mathbf{T}_{n}^{\prime}\right) & =\log (n!)-\sum_{j=1}^{2^{d}} \log \left(T_{n, j}^{\prime}!\right)+\sum_{j=1}^{s^{\prime}} T_{n, j}^{\prime} \log \left(p_{j}^{\prime}\right)+\left(\sum_{j=s^{\prime}+1}^{r^{\prime}} T_{n, j}^{\prime}\right) \log \left(p^{\prime}\right) \\
& +T_{n, 2^{d}}^{\prime} \log \left(1-q^{\prime}\right)+\left(n-T_{n, 2^{d}}^{\prime}\right) \log \left(q^{\prime}\right) \\
& =: \log L_{\mathbf{M}_{n-T_{n, 2^{d}}^{\prime}}\left(\mathbf{p}, \mathbf{T}_{n, n-T_{n, 2^{d}}^{\prime}}\right)+\log L_{\mathbf{B}_{n}}\left(q^{\prime}, T_{n, 2^{d}}^{\prime}\right)} \tag{1.23}
\end{align*}
$$

introducing the likelihood of a binomial model

$$
L_{\mathbf{B}_{n}}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)=\binom{n}{T_{n, 2^{d}}^{\prime}} q^{\prime n-T_{n, 2^{d}}^{\prime}}\left(1-q^{\prime}\right)^{T_{n, 2^{d}}^{\prime}}
$$

Similarly to Akaike's procedure our aim is to study the expectation of the KullbackLeibler divergence

$$
\mathbb{E}\left[\left.K L\left(\mathbf{M}_{n}^{\prime} \| \mathbf{T}_{n}^{\prime}\right)\right|_{\hat{\mathbf{p}^{\prime}}}\right]=\mathbb{E}\left[\log L_{\mathbf{P}_{n}^{\prime}}\left(T_{n}^{\prime}\right)\right]+\mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime}, T_{n}^{\prime}\right)\right]\right|_{\mathbf{p}^{\prime}=\hat{\mathbf{p}^{\prime}}}\right]
$$

where we recall that $\widehat{\mathbf{p}^{\prime}}$ denotes the maximum likelihood estimator of $\mathbf{p}^{\prime}$. This encourages us to look at

$$
\begin{aligned}
& \mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime}, T_{n}^{\prime}\right)\right]\right|_{\mathbf{p}^{\prime}=\widehat{\mathbf{p}^{\prime}}}\right] \\
& \quad=\mathbb{E}\left[\mathbb { E } \left[-\log L_{\left.\left.\mathbf{M}_{n-T_{n, 2^{d}}^{\prime}}\left(\mathbf{p}, \mathbf{T}_{n, n-T_{n, 2^{d}}^{\prime}}\right) \mid T_{n, 2^{d}}^{\prime}\right]\left.\right|_{\mathbf{p}^{\prime}=\widehat{\mathbf{p}^{\prime}}}\right]+\mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{B}_{n}}\left(q^{\prime}, T_{n, 2^{d}}^{\prime}\right)\right]\right|_{q^{\prime}=\hat{q}}\right]} \quad=E_{1}+E_{2}\right.\right.
\end{aligned}
$$

where we condition with respect to $T_{n, 2^{d}}^{\prime}$ and use the decomposition (1.23).
For the term $E_{1}$, we write

$$
\begin{align*}
& \mathbb{E}\left[\log L_{\mathbf{M}_{n-T_{n, 2^{d}}^{\prime}}}\left(\mathbf{p}, \mathbf{T}_{n, n-T_{n, 2^{d}}^{\prime}}\right) \mid T_{n, 2^{d}}^{\prime}\right]  \tag{1.24}\\
&=\log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)-\sum_{j=1}^{2^{d}-1} \mathbb{E}\left[\log \left(T_{n, n-T_{n, 2^{d}}^{\prime}, j^{\prime}}!\right) \mid T_{n, 2^{d}}^{\prime}\right] \\
&+\sum_{j=1}^{s^{\prime}} \mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right] \log \left(p_{j}\right)+\sum_{j=s^{\prime}+1}^{r^{\prime}} \mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right] \log (p)
\end{align*}
$$

and the following lemma provides an asymptotic expansion of this term.
Lemma 5. Under Assumption (B1) we have

&=\log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)+\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right] \\
&+\left(n-T_{n, 2^{d}}^{\prime}\right)\left(\log \left(n-T_{n, 2^{d}}^{\prime}\right)+1\right)-2\left(n-T_{n, 2^{d}}^{\prime}\right) \log (k)+O\left(n-T_{n, 2^{d}}^{\prime}\right)
\end{aligned}
$$

Proof. The assumption implies that the last two terms of the right-hand side in (1.24) satisfy

and

$$
\sum_{j=s^{\prime}+1}^{r^{\prime}} \mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right] \log (p)=\frac{n-T_{n, 2^{d}}^{\prime}}{k} \sum_{j=s^{\prime}+1}^{r^{\prime}} \mathbb{E}\left[T_{n, k, j}\right] \log (p)+O\left(n-T_{n, 2^{d}}^{\prime}\right)
$$

In order to deal with the second term in in (1.24) we recall the following Taylor expansions:

& \log (m!)=m \log (m)-m+O(\log m) \\
& \mathbb{E}[X \log (X)]=\mathbb{E}[X] \log (\mathbb{E}[X])+O(1)
\end{aligned}

where the second one holds for any random variable $X$ following a binomial distribution with parameters $n$ and $p_{n}$ satisfying $n p_{n} \rightarrow \infty$. We remind that $T_{n, n-T_{n, 2^{d}}^{\prime}, j}>0$ for all $1 \leq j \leq r^{\prime}=r=\hat{s}_{n}$ which ensures that the previous expansions can be applied with $m=T_{n, n-T_{n, 2^{d}}^{\prime}, j}$ or $X=T_{n, n-T_{n, 2^{d}}^{\prime}, j}$. Using that $n p_{n, j} \rightarrow \infty$ and therefore that $\mathbb{E}\left[T_{n, n-T_{n, d^{\prime}}^{\prime}, j}^{-1}\right]=o(1)$ by dominated convergence, we obtain

& \mathbb{E}\left[\log \left(T_{n, n-T_{n, 2^{d}}^{\prime}, j^{\prime}}!\right) \mid T_{n, 2^{d}}^{\prime}\right] \\
& \quad=\mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right] \log \mathbb{E}\left[T_{n, n-T_{n, d^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right]-\mathbb{E}\left[T_{n, n-T_{n, 2^{d}}^{\prime}, j} \mid T_{n, 2^{d}}^{\prime}\right]+O(1) \\
& \quad=\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[T_{n, k, j}\right] \log \left(\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[T_{n, k, j}\right]\right)-\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[T_{n, k, j}\right]+O(1) .
\end{aligned}
$$

for any fixed $1 \leq j \leq r$, where we used (B1). Using the same approximation for $\mathbb{E}\left[\log \left(T_{n, k, j}!\right)\right]$ we get

& \mathbb{E}\left[\log \left(T_{n, n-T_{n, 2^{d}}^{\prime},}!\right) \mid T_{n, 2^{d}}^{\prime}\right] \\
& \quad=\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[\log \left(T_{n, k, j}!\right)\right]+\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[T_{n, k, j}\right] \log \left(\frac{n-T_{n, 2^{d}}^{\prime}}{k}\right)+O\left(n-T_{n, 2^{d}}^{\prime}\right) .
\end{aligned}
$$

Summing these relations for $j=1, \ldots, 2^{d}-1$ such that $T_{n, k, j}>0$ we obtain the following
expression for (1.24):

\begin{aligned}
& \mathbb{E}\left[\log L_{\mathbf{M}_{n-T_{n, 2^{d}}^{\prime}}}\left(\mathbf{p}, \mathbf{T}_{n, n-T_{n, 2^{d}}^{\prime}}\right) \mid T_{n, 2^{d}}^{\prime}\right] \\
&=\log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)+\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right] \\
&-\frac{n-T_{n, 2^{d}}^{\prime}}{k} \log (k!)+\frac{n-T_{n, 2^{d}}^{\prime}}{k} \sum_{j=1}^{2^{d}-1} \mathbb{E}\left[T_{n, k, j}\right] \log \left(\frac{n-T_{n, 2^{d}}^{\prime}}{k}\right)+O\left(n-T_{n, 2^{d}}^{\prime}\right)
\end{aligned}
$$

The relation $\sum_{j=1}^{2^{d}-1} \mathbb{E}\left[T_{n, k, j}\right]=k$ yields

\begin{aligned}
& \mathbb{E}\left[\log L_{\mathbf{M}_{n-T_{n, 2^{d}}^{\prime}}}\left(\mathbf{p}, \mathbf{T}_{n, n-T_{n, 2^{d}}^{\prime}}\right) \mid T_{n, 2^{d}}^{\prime}\right] \\
&=\log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)+\frac{n-T_{n, 2^{d}}^{\prime}}{k} \mathbb{E}\left[\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right] \\
&-\frac{n-T_{n, 2^{d}}^{\prime}}{k} \log (k!)+\left(n-T_{n, 2^{d}}^{\prime}\right) \log \left(\frac{n-T_{n, 2^{d}}^{\prime}}{k}\right)+O\left(n-T_{n, 2^{d}}^{\prime}\right) .
\end{aligned}
$$

Using Stirling's formula as $k$ and $n-T_{n, 2^{d}}^{\prime}$ diverge (a.s. for the second) to infinity with $n$, we obtain

\begin{aligned}
& \log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)-\frac{n-T_{n, 2^{d}}^{\prime}}{k} \log (k!)+\left(n-T_{n, 2^{d}}^{\prime}\right) \log \left(\frac{n-T_{n, 2^{d}}^{\prime}}{k}\right) \\
& =\log \left(\left(n-T_{n, 2^{d}}^{\prime}\right)!\right)+\left(n-T_{n, 2^{d}}^{\prime}\right)\left(\log \left(n-T_{n, 2^{d}}^{\prime}\right)+1\right)-2\left(n-T_{n, 2^{d}}^{\prime}\right) \log (k)+O\left(n-T_{n, 2^{d}}^{\prime}\right)
\end{aligned}
$$

This lemma proves that the quantity $E_{1}$ is equal to

$$
\begin{aligned}
E_{1}=\frac{n q_{n}}{k} \mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right]\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right] & -\mathbb{E}\left[\log \left(n-T_{n, 2^{d}}^{\prime}\right)!\right] \\
& -n q_{n}\left(\log \left(n q_{n}\right)+1\right)+2 n q_{n} \log (k)+O\left(n q_{n}\right) .
\end{aligned}
$$

Moving on to term $E_{2}$, we apply similar arguments than in the proof of Theorem 2.

Lemma 6. For $k \in K$ such that (B2) holds we have

$$
\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(n q_{n}, T_{n, 2^{d}}^{\prime}\right)\right]=-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n, T_{n, 2^{d}}^{\prime}\right)\right]+\left(\frac{k}{n}-q_{n}\right)^{2} \frac{n}{k / n}+O(k)
$$

Proof. In order to apply Lemmas 1 and 2 we introduce artificially the Kullback-Leibler divergence

$$
K L\left(D \| \mathbf{B}_{n}\right)=\mathbb{E}\left[\log L_{D}\right]-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right]
$$

where $L_{D}$ corresponds to the likelihood of the distribution of the data, that is the distribution of $n-T_{n, 2^{d}}^{\prime}$. The derivatives of $\log L_{\mathbf{B}_{n}\left(q^{\prime}, T_{n, 2^{d}}^{\prime}\right)}$ are

$$
\frac{\partial}{\partial q^{\prime}} \log L_{\mathbf{B}_{n}}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)=\frac{n-T_{n, 2^{d}}^{\prime}}{q^{\prime}}-\frac{T_{n, 2^{d}}^{\prime}}{1-q^{\prime}}
$$

and

$$
\frac{\partial^{2}}{\partial q^{\prime 2}} \log L_{\mathbf{B}_{n}}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)=-\frac{n-T_{n, 2^{d}}^{\prime}}{q^{\prime 2}}-\frac{T_{n, 2^{d}}^{\prime}}{\left(1-q^{\prime}\right)^{2}}
$$

We adapt Lemmas 1 and 2 in this context. Lemma 1 applied with $K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)$ between $q^{\prime}=\widehat{q^{\prime}}$ and $q^{\prime}=q_{n}=\mathbb{E}\left[T_{n, 2^{d}}^{\prime}\right] / n$ gives

$$
\begin{aligned}
\left.K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=\widehat{q^{\prime}}}=K L & \left.\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=q_{n}} \\
& +\left.\frac{1}{2}\left(\frac{k}{n}-q_{n}\right)^{2} \frac{\partial^{2}}{\partial q^{\prime 2}} K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q=c_{n} \widehat{q^{\prime}}+\left(1-c_{n}\right) q_{n}},
\end{aligned}
$$

which gives

$$
\left.K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=\widehat{q^{\prime}}}=\left.K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=q_{n}}+\frac{1}{2}\left(\widehat{q^{\prime}}-q_{n}\right)^{2} \kappa_{n}\left(c_{n}\right),
$$

with

$$
\kappa_{n}(c)=\left(\frac{n q_{n}}{\left(c \widehat{q^{\prime}}+(1-c) q_{n}\right)^{2}}+\frac{n\left(1-q_{n}\right)}{\left[1-\left(c \widehat{q^{\prime}}+(1-c) q_{n}\right)\right]^{2}}\right), \quad c \in(0,1)
$$

We now mimic Lemma 2 with $\log L_{\mathbf{B}_{n}}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)$ between $q^{\prime}=k / n$ and $q^{\prime}=q_{n}$ gives

$$
\begin{aligned}
& \log L_{\mathbf{B}_{n}}\left(q_{n} ; T_{n, 2^{d}}^{\prime}\right)=\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)+\left(\frac{k}{n}-q_{n}\right) \frac{\partial}{\partial q^{\prime}} \log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right) \\
&+O\left(\left(\frac{k}{n}-q_{n}\right)^{2}\right)
\end{aligned}
$$

and the first order term appears since the optimum of the log-likelihood is not $k / n$. We obtain

$$
\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(q_{n} ; T_{n, 2^{d}}^{\prime}\right)\right]=\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)\right]+\left(\frac{k}{n}-q_{n}\right)\left(\frac{n q_{n}}{k / n}-\frac{n\left(1-q_{n}\right)}{1-k / n}\right) .
$$

Gathering together both results leads to

$$
\begin{aligned}
& \left.K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=\widehat{q^{\prime}}} \\
& =\left.K L\left(D \| \mathbf{B}_{n}\left(q^{\prime} ; T_{n, 2^{d}}^{\prime}\right)\right)\right|_{q^{\prime}=q_{n}}+\frac{1}{2}\left(\widehat{q^{\prime}}-q_{n}\right)^{2} \kappa_{n}\left(c_{n}\right) \\
& =\mathbb{E}\left[\log L_{D}\right]-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)\right]-\left(\frac{k}{n}-q_{n}\right)\left(\frac{n q_{n}}{k / n}-\frac{n\left(1-q_{n}\right)}{1-k / n}\right)+O\left(\left(\frac{k}{n}-q_{n}\right)^{2}\right) .
\end{aligned}
$$

The second order term is of smaller order than the first order one since $k / n$ converge to zero and so does $q_{n}$ by assumption (B2). So all in all the variations with respect to $k$ of the KL are the same as the ones of

$$
\begin{aligned}
-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)\right] & -\left(\frac{k}{n}-q_{n}\right)\left(\frac{n q_{n}}{k / n}-\frac{n\left(1-q_{n}\right)}{1-k / n}\right) \\
& =-\mathbb{E}\left[\log L_{\mathbf{B}_{n}\left(q^{\prime}, T_{n, 2^{d}}^{\prime}\right)}(k / n)\right]+\left(\frac{k}{n}-q_{n}\right)^{2} \frac{n}{k / n}+O(k),
\end{aligned}
$$

after using the asymptotic expansion

$$
\frac{n q_{n}}{k / n}-\frac{n\left(1-q_{n}\right)}{1-k / n}=\frac{n q_{n}}{k / n}-n+O(k)=\left(q_{n}-\frac{k}{n}\right) \frac{n}{k / n}+O(k)
$$

as $q_{n}$ and $k / n$ converge to 0 . This gives the desired result.

Going back to the whole model, we get

\begin{aligned}
& \mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime}, T_{n}^{\prime}\right)\right]\right|_{\mathbf{p}^{\prime}=\widehat{\mathbf{p}^{\prime}}}\right]=E_{1}+E_{2} \\
& \quad=\frac{n q_{n}}{k} \mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right]\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]-\mathbb{E}\left[\log \left(n-T_{n, 2^{d}}^{\prime}\right)!\right]-n q_{n}\left(\log \left(n q_{n}\right)+1\right)+2 n q_{n} \log (k) \\
& \quad-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)\right]+\left(\frac{k}{n}-q_{n}\right)^{2} \frac{n}{k / n}+O(k),
\end{aligned}
$$

where we recall that

$$
\begin{aligned}
-\mathbb{E}\left[\log L_{\mathbf{B}_{n}}\left(k / n ; T_{n, 2^{d}}^{\prime}\right)\right] & =-\log (n!)+\mathbb{E}\left[\log \left(n-T_{n, 2^{d}}^{\prime}\right)!\right] \\
& +\mathbb{E}\left[\log \left(T_{n, 2^{d}}^{\prime}!\right)\right]-n q_{n} \log (k / n)-n\left(1-q_{n}\right) \log (1-k / n) .
\end{aligned}
$$

The terms $\mathbb{E}\left[\log \left(n-T_{n, 2^{d}}^{\prime}\right)!\right]$ vanish and the terms depending on $k$ which remain are

$$
n\left[q_{n} \log (k / n)-\left(1-q_{n}\right) \log (1-k / n)+\left(\frac{k}{n}-q_{n}\right)^{2} \frac{n}{k}\right]
$$

Under Assumption (B2) the previous terms can then be simplified as

$$
\begin{aligned}
q_{n} \log (k / n)-\left(1-q_{n}\right) \log (1-k / n)+\left(\frac{k}{n}-q_{n}\right)^{2} \frac{n}{k} & =q_{n} \log (k / n)+\frac{k}{n}+\frac{k}{n}-2 q_{n}+q_{n}^{2} \frac{n}{k} \\
& =q_{n} \log (k / n)+O\left(q_{n}\right)
\end{aligned}
$$

All in all we have proved that

$$
\begin{array}{r}
\mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{n}^{\prime}}\left(\mathbf{p}^{\prime}, T_{n}^{\prime}\right)\right]\right|_{\mathbf{p}^{\prime}=\hat{\mathbf{p}}^{\prime}}\right]=\frac{n q_{n}}{k} \mathbb{E}\left[\left.\mathbb{E}\left[-\log L_{\mathbf{M}_{k}}\left(\mathbf{p}, \mathbf{T}_{n, k}\right)\right]\right|_{\mathbf{p}=\hat{\mathbf{p}}}\right]+n q_{n} \log (k / n) \\
+O\left(n q_{n}\right)
\end{array}
$$

## 2 Numerical examples with asymptotic independence

The example we develop here is related to asymptotic independence. The code can be found at https://drive.google.com/drive/folders/11TvhbVMPXcSkxmdnnAySvZt64lpMKZqL? usp=sharing.

Let $\mathbf{X}=\left(X_{1}, \ldots, X_{d}\right)^{\top}$ be a random vector with a Gaussian copula with a common correlation parameter $\rho<1$ and marginal distributions satisfying $\mathbb{P}\left(X_{j}>x\right)=x^{-1}$. Then $\mathbf{X}$ is regularly varying with tail index -1 and its marginals are asymptotically independent, see Resnick (1987), Corollary 5.28. The spectral measure only places mass on the subsets $C_{\beta}$ such that $|\beta|=1$, and so does the distribution of $\mathbf{Z}$, see Example 1 in the main text. The aim of our procedure is then to recover these $d$ directions among the $2^{d}-1$ clusters. These directions are all the more identifiable as the parameter $\rho$ is close to 0 (no dependence).

We first consider $d=40$, a sample size $n=30000$, and a correlation parameter $\rho=0.5$. We plot the evolution of the penalized log-likelihood for a given sample $\mathbf{X}_{1}, \ldots, \mathbf{X}_{n}$. Figure 1 shows that this quantity first decreases for small values of $k$ before it slightly increases with $k$. The minimum is reached for $\hat{k}=1050$ which corresponds to a proportion of extreme values of $\hat{k} / n=3.5 \%$. Regarding the evolution of $\hat{s}(k)$, we observe that the value of $\hat{s}(k)$ remains constant for $k$ close to $\hat{k}$. It stabilizes around an optimal value of $\hat{s}(\hat{k})=41$. Recall that in this example the true clusters corresponds to the $d=40$ one-dimensional ones. In turns out that the algorithm identifies the 40 one-dimensional clusters. The extra cluster which appears is $\{1, \ldots, d\}$.

We then compare the estimated probabilities $\hat{\boldsymbol{\zeta}}$ given by our algorithm with the true ones $p^{*}(\beta)=1 / d$ for $|\beta|=1$ and zero elsewhere. To do so, we still consider $d=40$ and $n=30000$. We apply our procedure for different correlation parameters $\rho \in\{0,0.25,0.5,0.75\}$ and repeat our procedure over $N=100$ simulations. Then we compute the Hellinger distance and we compare ourselves with the approach of Goix et al. (2017). For the two methods proposed by Simpson et al. (2020) it is necessary to compute the empirical mass on all $2^{d}-1$ subsets $C_{\beta}$ which can not be achieved for such a high dimension. This is why for this example we restrict our comparison with DAMEX.


Figure 1: Evolution of the penalized $\log$-likelihood (left) and of $\hat{s}(k)$ (right) with respect to $k$. Here $\rho=0.5$ and $n=30000$.

Figure 2 shows the mean Hellinger distance achieved by our method and the one of Goix et al. (2017) over 100 simulations. We observe that the performance of both methods deteriorates as the value of the parameter $\rho$ increases. For any $\rho \in\{0,0.25,0.5,0.75\}$ our approach leads to better results than the one of Goix et al. (2017).

## 3 Application to wind speed data

The data correspond to the daily-average wind speed for 1961-1978 at 12 synoptic meteorological stations in the Republic of Ireland ( $n=6574, d=12$ ). They are available at http://lib.stat.cmu.edu/datasets/ and have been analyzed in detail by Haslet and Raftery (1989). The stations are the following ones: Malin Head (Mal), Belmullet (Bel), Clones (Clo), Claremorris (Cla), Mullingar (Mul), Dublin (Dub), Shannon (Sha), Birr

(Bir), Kilkenny (Kil), Valentia (Val), Roche's Pt. (Rpt), Rosslare (Ros). Seven of these stations are along the sea: Belmullet (west), Dublin (east), Malin Head (north), Roche's Pt. (south), Rosslare (east), Shannon (west), and Valentia (southwest). The five other stations are more than 50 kilometers away from the coast. We refer to Haslet and Raftery (1989) for a map of the stations.

The preprocessing of the data provides a Hill estimator of $\hat{\alpha}=10.7$. Before applying

MUSCLE we plot the evolution of the penalized log-likelihood as a function of $k$. The optimal value $\hat{k}=460$ is clearly identified and corresponds to a proportion $\hat{k} / n=7 \%$. This choice of $\hat{k}$ leads to a number of clusters $\hat{s}(\hat{k})=11$. Note that contrary to the numerical examples the value of $\hat{s}(k)$ does not stabilize when $k$ is close to $\hat{k}$.


Figure 3: Evolution of the penalized log-likelihood (left) and of $\hat{s}_{n}(k)$ (right) with respect to $k$ for the wind speed data.

MUSCLE provides 11 extremal clusters which correspond to 6 stations: Belmullet, Malin Head, Roche's Pt., Rosslare, Dublin, and Shannon. All of these stations are located close to the sea, where wind speed is likely to be higher than in inland cities. The only coastal city which does not appear in the extremal clusters is Valentia which is located more than 200 kilometers away from the other stations.

The 11 clusters and their inclusions are illustrated on Figure 4. The algorithm exhibits low-dimensional clusters as the largest ones are of dimension 3. The northern station Malin Head appears in all multivariate clusters. Most of the clusters are related to a specific localization: $\{$ Sha, Bel, Mal\} and $\{$ Bel, Mal\} correspond to stations in the north/west, \{Mal, Dub\} and \{Mal, Ros\} to stations in the north/east. Three extremal clusters gather the northern station Malin Head and the southern one Roche's Pt.

We conclude that the aforementioned 11 clusters correspond to subsets $C_{\beta}$ which gather the mass of the angular vector $\mathbf{Z}$. In particular, the subsets related to the clusters $\{$ Sha, Bel, Mal\}, $\{$ Rpt, Bel, Mal\}, $\{$ Rpt, Ros, Mal\}, and $\{\mathrm{Dub}, \mathrm{Mal}\}$ gather some mass of $\mathbf{Z}$ and are not included in larger subsets on which $\mathbf{Z}$ places mass. Following Meyer and Wintenberger (2021), Theorem 2, these maximal subsets also concentrate the mass of the spectral measure. The remaining clusters, which correspond to non-extremal subsets, contain almost all the station Malin Head. We interpret this as follows: among the maximal subsets the wind speed in Malin Head is likely to be larger than in the other stations. We also refer to Meyer and Wintenberger (2021), Section 3.2, for a discussion on maximal and non-maximal subsets. A separate study can then be conducted on each group of stations for which standard methods for low-dimensional extremes can be applied, see Coles and Tawn (1991), Einmahl et al. (1993), Einmahl et al. (1997), Einmahl and Segers (2009).


Figure 4: Representation of the 11 clusters and their inclusions.

In order to study the remaining stations, we remove the 6 extremal stations and reapply our procedure. MUSCLE then provides 16 clusters:

- Four one-dimensional clusters: Val, Clo, Cla, Mul.
- Five two-dimensional clusters: $\{$ Val, Cla $\},\{$ Val, Clo $\},\{$ Val, Mul $\},\{\mathrm{Mul}, \mathrm{Clo}\},\{\mathrm{Cla}, \mathrm{Clo}\}$.
- Two three-dimensional clusters: \{Val, Cla, Clo\}, \{Val, Mul, Clo\}.
- and other clusters: \{Val, Cla, Mul, Clo\}, \{Val, Bir, Cla, Clo\}, \{Val, Bir, Cla, Mul, Clo\}, \{Val, Kil, Bir, Cla, Mul, Clo\}.

The station Valentia appears in almost all of these clusters. It is the only remaining coastal station, the other ones are inland ones. No particular tail dependence structure appears for these non-extremal stations. In particular, the largest clusters \{Val, Kil, Bir, Cla, Mul, Clo\} indicates that it is likely that the wind speed in all of these six stations is simultaneously large.
