# SUPER-CATALAN NUMBERS OF THE THIRD AND FOURTH KIND 

IRINA GHEORGHICIUC AND GIDON ORELOWITZ


#### Abstract

The Super-Catalan numbers are a generalization of the Catalan numbers defined as $T(m, n)=\frac{(2 m)!(2 n)!}{2 m!n!(m+n)!}$. It is an open problem to find a combinatorial interpretation for $T(m, n)$. We resolve this for $m=3,4$ using a common form; no such solution exists for $m=5$.


## 1. Introduction

1.1. Main Results. The Super-Catalan numbers, first described by Catalan in 1874, are

$$
\begin{equation*}
T(m, n):=\frac{\binom{2 m}{m}\binom{2 n}{n}}{2\binom{m+n}{m}}=\frac{1}{2} \cdot \frac{(2 m)!(2 n)!}{m!n!(m+n)!} . \tag{1}
\end{equation*}
$$

In [3], Gessel shows that $T(m, n)$ is a positive integer for all $(m, n) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{>0}$. It is natural to ask if a combinatorial interpretation of $T(m, n)$ exists. $T(0, n)=\binom{2 n-1}{n}$ by observation, and $T(1, n)=C_{n}$, the Catalan numbers. This sequence has numerous combinatorial interpretations; see, e.g., Stanley's [5]. The one that this paper will use is that $C_{n}$ is the number of Dyck paths of length $2 n$.

A Dyck path is a sequence $\pi=(\pi(1), \pi(2), \ldots, \pi(2 n))$ such that

$$
\pi(k)= \pm 1, \sum_{i=1}^{2 n} \pi(i)=0, \text { and } \sum_{i=1}^{k} \pi(i) \geq 0 \text { for all } 1 \leq k \leq 2 n
$$

The length of $\pi$, denoted $|\pi|$, is the number of elements in the sequence. The total length of a tuple of Dyck paths $\left(\pi^{(1)}, \ldots, \pi^{(n)}\right)$ is $\sum_{i=1}^{n}\left|\pi^{(i)}\right|$. The height of a Dyck path $\pi$ is

$$
h(\pi):=\max _{k} \sum_{i=1}^{k} \pi(i),
$$

and say $h(\epsilon)=0$, where $\epsilon$ is the unique Dyck path of length 0 .
Let

$$
\begin{equation*}
G_{n}(m, k):=\left|\left\{\left(\pi^{(1)}, \ldots, \pi^{(m)}\right): \sum_{i=1}^{m}\left|\pi^{(i)}\right|=2 n,\left|h\left(\pi^{(i)}\right)-h\left(\pi^{(j)}\right)\right| \leq k\right\}\right| . \tag{2}
\end{equation*}
$$

## Theorem 1.

$$
\begin{equation*}
T(3, n)=G_{n}(3,1)+2 G_{n-1}(3,0) \tag{3}
\end{equation*}
$$

Theorem 1 is used to prove:

## Theorem 2.

$$
\begin{equation*}
T(4, n)=G_{n}(4,1)+10 G_{n-1}(4,0)+4 G_{n-2}(5,0) \tag{4}
\end{equation*}
$$

Since $G_{n}(m, k)$ is defined combinatorially in (2), (3) and (4) immediately imply a combinatorial interpretation for $T(3, n)$ and $T(4, n)$.

Vacuously,

$$
G_{n}(1, k)=C_{n} \text { for all } k, n \in \mathbb{Z}_{\geq 0}
$$

so in particular

$$
\begin{equation*}
T(1, n)=G_{n}(1,1) \tag{5}
\end{equation*}
$$

In [4], Gessel and Xin show that

$$
\begin{equation*}
T(2, n)=G_{n}(2,1) \tag{6}
\end{equation*}
$$

Each of (5), (6), (3), and (4) are of the form

$$
\begin{equation*}
T(m, n)=G_{n}(m, 1)+\sum_{k=1}^{m-2} a_{k, m} G_{n-k}(m+k-1,0) \tag{7}
\end{equation*}
$$

for some $a_{k, m} \in \mathbb{Z}_{>0}$. However, there are no choices for $a_{1,5}, a_{2,5}$, and $a_{3,5}$ in $\mathbb{R}$ that simultaneously satisfy (7) when $m=5$ and $n=1,2,3$. Therefore, (7) is not true for $m=5$.
1.2. Comparison to Literature. Theorem 1 in [1] shows that

$$
T(m, n)=P(m, n)-N(m, n)
$$

where $P(m, n)$ and $N(m, n)$ are the number of $m$-positive and $m$-negative Dyck paths of length $2 m+2 n-2$ respectively. A Dyck path $\pi$ is $m$-positive (respectively m-negative) if

$$
\begin{equation*}
\sum_{i=1}^{2 m-1} \pi(i) \equiv 1 \bmod 4(3 \bmod 4 \text { respectively }) \tag{8}
\end{equation*}
$$

A second identity, proved in [2], says that

$$
2 T(m, n)=(-1)^{m} \sum_{\pi \in \mathcal{P}_{m+n}}(-1)^{h_{2 n}(\pi)} .
$$

Here, $\mathcal{P}_{m+n}$ is the set of Dyck paths of length $2 m+2 n$ and

$$
\begin{equation*}
h_{n}(\pi)=|\{i: \pi(i)=1, i>n\}| . \tag{9}
\end{equation*}
$$

The most relevant identity of the Super-Catalan numbers for this paper is that

$$
\begin{equation*}
T(m+1, n)=4 T(m, n)-T(m, n+1) \tag{10}
\end{equation*}
$$

which is attributed to Rubenstein in [3].

## 2. The Path-Height Function

In [1], Allen and Gheorghiciuc give a number of useful definitions for a non-empty Dyck path $\pi$. In their paper, the $R$-point is defined as

$$
\begin{equation*}
R(\pi):=\max \left\{k: h(\pi)=\sum_{i=1}^{k} \pi(i)\right\} \tag{11}
\end{equation*}
$$

and the $X$-point is

$$
\begin{equation*}
X(\pi):=\max \left\{k \leq R(\pi): \sum_{i=1}^{k} \pi(i)=1\right\} \tag{12}
\end{equation*}
$$

Additionally, they define

$$
\begin{equation*}
h_{-}(\pi):=\max _{1 \leq k \leq X(\pi)}\left(\sum_{i=1}^{k} \pi(i)\right) . \tag{13}
\end{equation*}
$$

Lemma 3. Let $\pi$ be a non-empty Dyck path.
(1) $\pi(1)=1$ and $\pi(|\pi|)=-1$.
(2) $\pi(R(\pi))=1$ and $\pi(R(\pi)+1)=-1$.
(3) $1 \leq h_{-}(\pi) \leq h(\pi)$.
(4) If $h(\pi)>1$, then $\pi(X(\pi)+1)=1$, and if $h(\pi)>2$, then $\pi(X(\pi)+2)=1$.

Proof. These follow from the definitions of Dyck path, $R$-point, and $X$-point.
Define the path-height function to be

$$
\begin{equation*}
P_{n}\left(a_{1}, \ldots, a_{m}\right):=\left|\left\{\left(\pi^{(1)}, \ldots, \pi^{(m)}\right): h\left(\pi^{(i)}\right)=a_{i}, \sum_{i=1}^{m}\left|\pi^{(i)}\right|=2 n\right\}\right| \tag{14}
\end{equation*}
$$

when $a_{1}, \ldots, a_{m} \in \mathbb{Z}_{\geq 0}$, and $P_{n}\left(a_{1}, \ldots, a_{m}\right)=0$ otherwise. Notice that $P_{n}\left(a_{1}, \ldots, a_{m}\right)$ is symmetric in $a_{1}, \ldots, a_{m}$. The function also has the recursive formulation

$$
\begin{equation*}
P_{n}\left(a_{1}, \ldots, a_{m}\right)=\sum_{n_{1}+\ldots n_{m}=n}\left(\prod_{i=1}^{m} P_{n_{i}}\left(a_{i}\right)\right) \tag{15}
\end{equation*}
$$

which provides a fast way to compute $P_{n}\left(a_{1}, \ldots, a_{m}\right)$ electronically. Since the empty path is the unique Dyck path of height 0 , and has length 0 ,

$$
\begin{equation*}
P_{n}\left(a_{1}, \ldots, a_{m}\right)=P_{n}\left(a_{1}, \ldots, a_{m}, 0\right) . \tag{16}
\end{equation*}
$$

$G_{n}(m, k)$ can be written as the sum of path-height functions as follows:

$$
\begin{equation*}
G_{n}(m, k)=\sum_{\left|a_{i}-a_{j}\right| \leq k} P_{n}\left(a_{1}, \ldots, a_{m}\right) . \tag{17}
\end{equation*}
$$

To proceed further, it is necessary to prove two lemmas and several corollaries related to the path-height function.
Lemma 4. For $a_{m} \geq 1$,

$$
\begin{equation*}
P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right)=\sum_{y=1}^{a_{m}} P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, y\right) \tag{18}
\end{equation*}
$$

Proof. If $a_{m}=1$, then the lemma follows from Equation 16 and the symmetry of $P_{n}$.
Now assume $a_{m}>1$. For any $h_{-}, h, n \in \mathbb{Z}_{>0}$ with $1 \leq h_{-} \leq h, h \geq 2$, [1, Theorem 2] provides a bijection between the set $\left\{\pi: h_{-}(\pi)=h_{-}, h(\pi)=h,|\pi|=2 n\right\}$ and the set $\left\{\left(\pi^{(1)}, \pi^{(2)}\right): h\left(\pi^{(1)}\right)=h_{-}, h\left(\pi^{(2)}\right)=h-1,\left|\pi^{(1)}\right|+\left|\pi^{(2)}\right|=2 n\right\}$. As a result, there is a bijection between

$$
\bigcup_{h-=1}^{h}\left\{\pi: h_{-}(\pi)=h_{-}, h(\pi)=h,|\pi|=2 n\right\}=\{\pi: h(\pi)=h,|\pi|=2 n\}
$$

and

$$
\begin{aligned}
& \bigcup_{h-=1}^{h}\left\{\left(\pi^{(1)}, \pi^{(2)}\right): h\left(\pi^{(1)}\right)=h_{-}, h\left(\pi^{(2)}\right)=h-1,\left|\pi^{(1)}\right|+\left|\pi^{(2)}\right|=2 n\right\} \\
= & \left\{\left(\pi^{(1)}, \pi^{(2)}\right): 1 \leq h\left(\pi^{(1)}\right) \leq h, h\left(\pi^{(2)}\right)=h-1,\left|\pi^{(1)}\right|+\left|\pi^{(2)}\right|=2 n\right\} .
\end{aligned}
$$

And so, as a result,

$$
\begin{aligned}
P_{n}(h) & =|\{\pi: h(\pi)=h,|\pi|=2 n\}| \\
& =\left|\left\{\left(\pi^{(1)}, \pi^{(2)}\right): 1 \leq h\left(\pi^{(1)}\right) \leq h, h\left(\pi^{(2)}\right)=h-1,\left|\pi^{(1)}\right|+\left|\pi^{(2)}\right|=2 n\right\}\right|=\sum_{y=1}^{h} P_{n}(y, h-1) .
\end{aligned}
$$

Combining this with Equation 15 and the fact that the path-height function is symmetric completes the proof.

## Corollary 5.

$$
\begin{align*}
P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}+1\right)= & P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}, a_{m}\right) \\
& +P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}, a_{m}+1\right) \tag{19}
\end{align*}
$$

Proof.

$$
\begin{aligned}
& P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}+1\right) \\
& \qquad \quad=\sum_{y=1}^{a_{m}+1} P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}, y\right) \\
& \quad=P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}, a_{m}+1\right)+\sum_{y=1}^{a_{m}} P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}, y\right) \\
& \quad=P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1, a_{m}, a_{m}+1\right)+P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}, a_{m}\right)
\end{aligned}
$$

Lemma 6. For $n, a_{m} \in \mathbb{Z}_{>0}$,

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right)= & P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}, a_{m}-1\right) \\
& +2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}, a_{m}\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}+1\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}, a_{m}+1\right) .
\end{aligned}
$$

Proof. This proof is broken up into three cases depending on whether $a_{m}=1, a_{m}=2$, or $a_{m} \geq 3$.

Case 1: $\left(a_{m}=1\right)$ Consider an arbitrary tuple of Dyck paths $\left(\pi^{(1)}, \ldots, \pi^{(m)}\right)$ with total length $2 n$ and respective heights $a_{1}, \ldots, a_{m}$ such that $a_{m}=1$. Since $h\left(\pi^{(m)}\right)=1, \pi^{(m)}(1)=$

1 and $\pi^{(m)}(2)=-1$, so removing the first two steps of $\pi^{(m)}$ results in a new Dyck path, denoted $\pi^{(m)^{\prime}}$, with the properties that $\left|\pi^{(m)^{\prime}}\right|=\left|\pi^{(m)}\right|-2$ and $h\left(\pi^{(m)^{\prime}}\right)=0$ or 1 . This process is an injection, and it is reversible, as any path of height 0 or 1 can have $(1,-1)$ prepended to it to result in a unique path of length 1 . Since the map $\pi^{(m)} \mapsto \pi^{(m)^{\prime}}$ is a bijection, so is $\left(\pi^{(1)}, \ldots, \pi^{(m-1)}, \pi^{(m)}\right) \mapsto\left(\pi^{(1)}, \ldots, \pi^{(m-1)}, \pi^{(m)^{\prime}}\right)$, and so there is a bijection between

$$
\left\{\left(\pi^{(1)}, \ldots, \pi^{(m)}\right): \sum_{i=1}^{m}\left|\pi^{(i)}\right|=2 n, h\left(\pi^{(i)}\right)=a_{i}, h\left(\pi^{(m)}\right)=1\right\}
$$

and

$$
\left\{\left(\pi^{(1)}, \ldots, \pi^{(m-1)}, \pi^{(m)^{\prime}}\right): \sum_{i=1}^{m-1}\left|\pi^{(i)}\right|+\left|\pi^{(m)^{\prime}}\right|=2 n-2, h\left(\pi^{(i)}\right)=a_{i}, 0 \leq h\left(\pi^{(m)^{\prime}}\right) \leq 1\right\}
$$

By definition, the size of the first set is $P_{n}\left(a_{1}, \ldots, a_{m-1}, 1\right)$, and the size of the second set is $P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 0\right)$. As a result,

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, 1\right)= & P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}\right) \\
= & P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 0\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right) .
\end{aligned}
$$

Applying Lemma 4 to the last term results in

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, 1\right)= & P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 0\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 0,1\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right) \\
& -\left(P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1,1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1,2\right)\right) \\
= & 2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 0\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right) \\
& -P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1,0\right) \\
& -P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1,1\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1,2\right),
\end{aligned}
$$

which proves this case.
Case 2 : $\left(a_{m}=2\right)$ Consider an arbitrary tuple of Dyck paths $\left(\pi^{(1)}, \ldots, \pi^{(m)}\right)$ with total length $2 n$ and respective heights $a_{1}, \ldots, a_{m}$ such that $a_{m}=2$. Since $h\left(\pi^{(m)}\right)=2$, $\left(\pi^{(m)}(1), \pi^{(m)}(2), \pi^{(m)}(3)\right)=(1,-1,1)$ or $(1,1,-1)$. If $\left(\pi^{(m)}(1), \pi^{(m)}(2), \pi^{(m)}(3)\right)=(1,-1,1)$, then as in Case 1, removing the first two steps of $\pi^{(m)}$ is a bijection between these Dyck paths and Dyck paths with length $\left|\pi^{(m)}\right|-2$ and height 2 . If instead $\left(\pi^{(m)}(1), \pi^{(m)}(2), \pi^{(m)}(3)\right)$ is $(1,1,-1)$, then the bijection is $\pi^{(m)} \mapsto\left(1, \pi^{(m)}(4), \ldots, \pi^{(m)}\left(\left|\pi_{m}\right|\right)\right)$. In this case, the image of this bijection is Dyck paths of length $\left|\pi^{(m)}\right|-2$ and height 1 or 2 . Clearly, if $\pi^{(m)}$ is the
last element of an $m$-tuple, the mapping is still bijective, so

$$
\begin{aligned}
& \left|\left\{\left(\pi^{(1)}, \ldots, \pi^{(m-1)}, \pi^{(m)}\right): \sum_{i=1}^{m}\left|\pi^{(i)}\right|=2 n, h\left(\pi^{(i)}\right)=a_{i}, h\left(\pi^{(m)}\right)=2\right\}\right| \\
& =\left|\left\{\left(\pi^{(1)}, \ldots, \pi^{(m-1)}, \pi^{(m)^{\prime}}\right): \sum_{i=1}^{m-1}\left|\pi^{(i)}\right|+\left|\pi^{(m)^{\prime}}\right|=2 n-2, h\left(\pi^{(i)}\right)=a_{i}, h\left(\pi^{(m)^{\prime}}\right)=2\right\}\right| \\
& \quad+\left|\left\{\left(\pi^{(i)}, \ldots, \pi^{(m-1)}, \pi^{(m)^{\prime}}\right): \sum_{i=1}^{m-1}\left|\pi^{(i)}\right|+\left|\pi^{(m)^{\prime}}\right|=2 n-2, h\left(\pi^{(i)}\right)=a_{i}, 1 \leq h\left(\pi^{(m)^{\prime}}\right) \leq 2\right\}\right|
\end{aligned}
$$

which by definition means that

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, 2\right)= & 2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right) \\
= & 2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 3\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 3\right) .
\end{aligned}
$$

Applying Lemma 4 to the last term of this expression results in:

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, 2\right)= & 2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2\right)+P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 1\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 3\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2,1\right) \\
& -P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2,2\right)-P_{n-1}\left(a_{1}, \ldots, a_{m-1}, 2,3\right)
\end{aligned}
$$

which completes this case.
Case 3 : $\left(a_{m} \geq 3\right)$ Let $\pi^{(m)}$ be an arbitrary Dyck path such that $h\left(\pi^{(m)}\right)=a_{m} \geq 3$. There are three possiblities for $\left(\pi^{(m)}(1), \pi^{(m)}(2), \pi^{(m)}(3)\right)$ : either $(1,-1,1),(1,1,-1)$ or $(1,1,1)$.

For the first option, removing the first two steps results in a Dyck path that has height $h\left(\pi^{(m)}\right)$ and has length $\left|\pi^{(m)}\right|-2$. Likewise, for the second option, removing the second and third steps also results a Dyck path that has the same height $h\left(\pi^{(m)}\right)$ and has length $\left|\pi^{(m)}\right|-2$. Both of these processes are reversible, and so just as in the previous two cases, the number of $m$-tuples of paths $\left(\pi^{(1)}, \ldots, \pi^{(m)}\right)$ such that for each $1 \leq i \leq m, h\left(\pi^{(i)}\right)=a_{i}$ and $\pi^{(m)}$ starts with either $(1,1,-1)$ or $(1,-1,1)$ is equal to $2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right)$.

Now consider an arbitrary $m$-tuple of paths $\left(\pi^{(1)}, \ldots, \pi^{(m)}\right)$ such that for each $1 \leq i \leq m$, $h\left(\pi^{(i)}\right)=a_{i}$ and $\pi^{(m)}(1)=\pi^{(m)}(2)=\pi^{(m)}(3)=1$. There are two possibilities here to consider: either $X\left(\pi^{(m)}\right)=1$, or $X\left(\pi^{(m)}\right) \geq 5$. In the former of these two cases, [1, Theorem 3] has a bijection between these Dyck paths and Dyck paths of height $h\left(\pi^{(m)}\right)-1$ and length $\left|\pi^{(m)}\right|-2$, so the number of $m$-tuples of Dyck paths in this case is $P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1\right)$.

In the final case, [1, Theorem 3] provides a bijection between Dyck paths $\pi$ such that $\pi(1)=\pi(2)=\pi(3)=1$ and $X(\pi) \geq 5$ to paths $\pi^{\prime}$ such that $\left|\pi^{\prime}\right|=|\pi|-2, h\left(\pi^{\prime}\right)=h(\pi)+1$, and $h_{-}\left(\pi^{\prime}\right)<h\left(\pi^{\prime}\right)-2$.

As a result, the number of $m$-tuples in this case equals $P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}+1\right)$ minus the the number of $m$-tuples of Dyck paths counted by $P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}+1\right)$ such that $h\left(\pi^{(m)}\right)-2 \leq h_{-}\left(\pi^{(m)}\right) \leq h\left(\pi^{(m)}\right)$. According to the bijection mentioned in the proof for Lemma 4, the number of Dyck paths that are being subtracted is equal to
$\sum_{y=a_{m}-1}^{a_{m}+1} P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}, y\right)$, and so in total

$$
\begin{aligned}
P_{n}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right)= & 2 P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}-1\right) \\
& +P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}+1\right) \\
& -\sum_{y=a_{m}-1}^{a_{m}+1} P_{n-1}\left(a_{1}, \ldots, a_{m-1}, a_{m}, y\right)
\end{aligned}
$$

Note that because the Path-Height function is symmetric, either of the above lemmas or the related corollaries can be applied to any value in the argument, rather than just the final value. For example, $P_{n}(3,4)=\sum_{z=1}^{4} P_{n}(3,3, z)=\sum_{y=1}^{3} P_{n}(2, y, 4)$.

## 3. The Grouped Path-Height Function

Sometimes when discussing tuples of Dyck paths, the heights of the Dyck paths are less important than the relative values of the heights. To that end, for $a_{0}, \ldots a_{k} \in \mathbb{Z}_{\geq 0}$, define the the following intermediary function:

$$
\begin{equation*}
Q_{n}^{(x)}\left(a_{0}, \ldots, a_{k}\right):=P_{n}(x, \ldots, x, x+1, \ldots, x+1, \ldots, x+k, \ldots, x+k) \tag{20}
\end{equation*}
$$

where the first $a_{0}$ inputs on the right-hand side are $x$, the next $a_{1}$ inputs are $x+1$, and so on. If $a_{i} \notin \mathbb{Z}_{\geq 0}$ for some $0 \leq i \leq k$, say the function is zero. From here, define the grouped path-height function to be

$$
\begin{equation*}
Q_{n}\left(a_{0}, \ldots, a_{k}\right)=\sum_{x=0}^{\infty} Q_{n}^{(x)}\left(a_{0}, \ldots, a_{k}\right) \tag{21}
\end{equation*}
$$

For example, $Q_{n}(1,0,2)=\sum_{x=0}^{\infty} P_{n}(x, x+2, x+2)$. Many of the results that for $P_{n}$ can be extended to $Q_{n}$ :

Lemma 7.

$$
\begin{equation*}
Q_{n}\left(a_{0}, \ldots, a_{k}, 0\right)=Q_{n}\left(a_{0}, \ldots, a_{k}\right) \tag{1}
\end{equation*}
$$

$$
\begin{equation*}
Q_{n}\left(0, a_{0}, \ldots, a_{k}\right)=\sum_{x=1}^{\infty} Q_{n}^{(x)}\left(a_{0}, \ldots, a_{k}\right)=Q_{n}\left(a_{0}, \ldots, a_{k}\right)-Q_{n}^{(0)}\left(a_{0}, \ldots, a_{k}\right) \tag{2}
\end{equation*}
$$

(3)

$$
Q_{n}^{(0)}\left(a_{0}, a_{1}, \ldots\right)=Q_{n}^{(0)}\left(0, a_{1}, \ldots\right)=Q_{n}^{(1)}\left(a_{1}, \ldots\right)
$$

Proof. These follow from the definition of the grouped path-height function.
Lemma 8. For $i>0$ and $a_{i-1}, a_{i+1}>0$,
(22) $Q_{n}\left(a_{0}, \ldots\right)=Q_{n}\left(a_{0}, \ldots, a_{i-1}-1, a_{i}+2, a_{i+1}-1, \ldots\right)+Q_{n}\left(a_{0}, \ldots, a_{i-1}, a_{i}+1, a_{i+1}, \ldots\right)$.

Proof. This follows from Corollary 5 ,
Lemma 9. Fix $i, x \geq 0$ and let $a_{i}>0$.
(1) If $i>0$,

$$
\begin{aligned}
Q_{n}^{(x)}\left(a_{0}, \ldots\right)= & 2 Q_{n-1}^{(x)}\left(a_{0}, \ldots\right) \\
& +Q_{n-1}^{(x)}\left(\ldots, a_{i-1}+1, a_{i}-1, \ldots\right)+Q_{n-1}^{(x)}\left(\ldots, a_{i}-1, a_{i+1}+1, \ldots\right) \\
& -Q_{n-1}^{(x)}\left(\ldots, a_{i-1}+1, \ldots\right)-Q_{n-1}^{(x)}\left(\ldots, a_{i}+1, \ldots\right)-Q_{n-1}^{(x)}\left(\ldots, a_{i+1}+1, \ldots\right)
\end{aligned}
$$

(2) If $i=0$ and $x>0$,

$$
\begin{aligned}
Q_{n}^{(x)}\left(a_{0}, \ldots\right)= & 2 Q_{n-1}^{(x)}\left(a_{0}, \ldots\right) \\
& +Q_{n-1}^{(x-1)}\left(1, a_{0}-1, \ldots\right)+Q_{n-1}^{(x)}\left(a_{0}-1, a_{1}+1, \ldots\right) \\
& -Q_{n-1}^{(x-1)}\left(1, a_{0}, \ldots\right)-Q_{n-1}^{(x)}\left(a_{0}+1, \ldots\right)-Q_{n-1}^{(x)}\left(a_{0}, a_{1}+1, \ldots\right)
\end{aligned}
$$

Proof. This follows from Lemma6,
Corollary 10. If $i, a_{i}>0$,

$$
\begin{aligned}
Q_{n}\left(a_{0}, \ldots\right)= & 2 Q_{n-1}\left(a_{0}, \ldots\right) \\
& +Q_{n-1}\left(\ldots, a_{i-1}+1, a_{i}-1, \ldots\right)+Q_{n-1}\left(\ldots, a_{i}-1, a_{i+1}+1, \ldots\right) \\
& -Q_{n-1}\left(\ldots, a_{i-1}+1, \ldots\right)-Q_{n-1}\left(\ldots, a_{i}+1, \ldots\right)-Q_{n-1}\left(\ldots, a_{i+1}+1, \ldots\right)
\end{aligned}
$$

Proof. This follows from the definition of $Q_{n}$ and Lemma 9
Corollary 11. If $a>0$,

$$
\begin{aligned}
Q_{n}(a)= & 2 Q_{n-1}(a)+Q_{n-1}(1, a-1)+Q_{n-1}(a-1,1) \\
& -Q_{n-1}(1, a)-Q_{n-1}(a+1)-Q_{n-1}(a, 1)
\end{aligned}
$$

Proof. $Q_{n}(a)=Q_{n}^{(0)}(a)+Q_{n}(0, a)=Q_{n}(0, a, 0)$, so applying Corollary 10 results in

$$
\begin{aligned}
Q_{n}(a)= & Q_{n}(0, a, 0) \\
= & 2 Q_{n-1}(0, a, 0)+Q_{n-1}(1, a-1,0)+Q_{n-1}(0, a-1,1) \\
& -Q_{n-1}(1, a, 0)-Q_{n-1}(0, a+1,0)-Q_{n-1}(0, a, 1) \\
= & 2 Q_{n-1}(a)+Q_{n-1}(1, a-1)+Q_{n-1}(0, a-1,1) \\
& -Q_{n-1}(1, a)-Q_{n-1}(a+1)-Q_{n-1}(0, a, 1) \\
= & 2 Q_{n-1}(a)+Q_{n-1}(1, a-1)+\left(Q_{n-1}(a-1,1)-Q_{n-1}^{(0)}(a-1,1)\right) \\
& -Q_{n-1}(1, a)-Q_{n-1}(a+1)-\left(Q_{n-1}(a, 1)-Q_{n-1}^{(0)}(a, 1)\right) \\
= & 2 Q_{n-1}(a)+Q_{n-1}(1, a-1)+Q_{n-1}(a-1,1)-Q_{n-1}^{(0)}(0,1) \\
& -Q_{n-1}(1, a)-Q_{n-1}(a+1)-Q_{n-1}(a, 1)+Q_{n-1}^{(0)}(0,1) \\
= & 2 Q_{n-1}(a)+Q_{n-1}(1, a-1)+Q_{n-1}(a-1,1) \\
& -Q_{n-1}(1, a)-Q_{n-1}(a+1)-Q_{n-1}(a, 1)
\end{aligned}
$$

Lemma 12. If $a, b>0$,

$$
\begin{aligned}
Q_{n}(a, b)= & 2 Q_{n-1}(a, b)+Q_{n-1}(a-1, b+1)+Q_{n-1}(a+1, b-1) \\
& -Q_{n-1}(a+1, b)-Q_{n-1}(a, b+1)
\end{aligned}
$$

Proof. Applying Corollary 10 to $b$ results in

$$
\begin{aligned}
Q_{n}(a, b)= & 2 Q_{n-1}(a, b)+Q_{n-1}(a+1, b-1)+Q_{n-1}(a, b-1,1) \\
& -Q_{n-1}(a+1, b)-Q_{n-1}(a, b+1)-Q_{n-1}(a, b, 1) \\
= & 2 Q_{n-1}(a, b)+Q_{n-1}(a+1, b-1)+\left(Q_{n-1}(a, b-1,1)-Q_{n-1}(a, b, 1)\right) \\
& -Q_{n-1}(a+1, b)-Q_{n-1}(a, b+1) \\
= & 2 Q_{n-1}(a, b)+Q_{n-1}(a+1, b-1)+\left(Q_{n-1}(a-1, b+1)\right) \\
& -Q_{n-1}(a+1, b)-Q_{n-1}(a, b+1)
\end{aligned}
$$

Where the last step is by Lemma 8 .

This result can be reformulated in a different way.
Lemma 13. If $\left(a_{k}\right)$ is cyclic with period $m$, then

$$
\begin{aligned}
\sum_{k=1}^{m} a_{k} Q_{n}(k, m-k)= & \sum_{k=1}^{m}\left(2 a_{k}+a_{k-1}+a_{k+1}\right) Q_{n-1}(k, m-k)-\left(a_{k}+a_{k-1}\right) Q_{n-1}(k, m+1-k) \\
& -a_{m} Q_{n-1}(m+1)
\end{aligned}
$$

Proof. Applying Corollary 10 and Lemma 12 to the appropriate terms in the summation on the left side results in

$$
\begin{aligned}
\sum_{k=1}^{m} a_{k} Q_{n}(k, m-k)= & a_{m} Q_{n}(m)+\sum_{k=1}^{m-1} a_{k} Q_{n}(k, m-k) \\
= & 2 a_{m} Q_{n-1}(m)+a_{m} Q_{n-1}(1, m-1)+a_{m} Q_{n-1}(m-1,1) \\
& -a_{m} Q_{n-1}(1, m)-a_{m} Q_{n-1}(m+1)-a_{m} Q_{n-1}(m, 1) \\
& +\sum_{k=1}^{m-1} 2 a_{k} Q_{n-1}(k, m-k) \\
& +\sum_{k=1}^{m-1} a_{k} Q_{n-1}(k+1, m-k-1)+\sum_{k=1}^{m-1} a_{k} Q_{n-1}(k-1, m-k+1) \\
& -\sum_{k=1}^{m-1} a_{k} Q_{n-1}(k+1, m-k)-\sum_{k=1}^{m-1} a_{k} Q_{n-1}(k, m+1-k)
\end{aligned}
$$

Re-indexing the summations so that they have the same summands produces

$$
\sum_{k=1}^{m} a_{k} Q_{n}(k, m-k)=2 a_{m} Q_{n-1}(m)+a_{m} Q_{n-1}(1, m-1)+a_{m} Q_{n-1}(m-1,1)
$$

$$
\begin{aligned}
& -a_{m} Q_{n-1}(1, m)-a_{m} Q_{n-1}(m+1)-a_{m} Q_{n-1}(m, 1) \\
& +\sum_{k=1}^{m-1} 2 a_{k} Q_{n-1}(k, m-k) \\
& +\sum_{k=2}^{m} a_{k-1} Q_{n-1}(k, m-k)+\sum_{k=0}^{m-2} a_{k+1} Q_{n-1}(k, m-k) \\
& -\sum_{k=2}^{m} a_{k-1} Q_{n-1}(k, m+1-k)-\sum_{k=1}^{m-1} a_{k} Q_{n-1}(k, m+1-k)
\end{aligned}
$$

Grouping together like terms results in

$$
\begin{aligned}
\sum_{k=1}^{m} a_{k} Q_{n}(k, m-k)= & -a_{m} Q_{n}(m+1)+\sum_{k=1}^{m} 2 a_{k} Q_{n}(k, m-k) \\
& +\sum_{k=1}^{m} a_{k-1} Q_{n-1}(k, m-k)+\sum_{k=1}^{m} a_{k+1} Q_{n-1}(k, m-k) \\
& -\sum_{k=1}^{m} a_{k-1} Q_{n-1}(k, m+1-k)-\sum_{k=1}^{m} a_{k} Q_{n-1}(k, m+1-k)
\end{aligned}
$$

And so

$$
\begin{aligned}
\sum_{k=1}^{m} a_{k} Q_{n}(k, m-k)= & \sum_{k=1}^{m}\left(2 a_{k}+a_{k-1}+a_{k+1}\right) Q_{n-1}(k, m-k) \\
& -\sum_{k=1}^{m}\left(a_{k}+a_{k-1}\right) Q_{n-1}(k, m+1-k) \\
& -a_{m} Q_{n-1}(m+1)
\end{aligned}
$$

Corollary 14. For m even,

$$
\begin{equation*}
\sum_{k=1}^{m}(-1)^{k+1} Q_{n}(k, m-k)=G_{n-1}(m+1,0) \tag{23}
\end{equation*}
$$

Proof. Clearly, $\left((-1)^{k+1}\right)_{k \in \mathbb{Z}}$ is cyclic with period $m$ for $m$ even. Therefore, applying Lemma 13 to the left hand side results in

$$
\begin{aligned}
\sum_{k=1}^{m}(-1)^{k+1} Q_{n}(k, m-k)= & \sum_{k=1}^{m}\left(2(-1)^{k+1}+(-1)^{k}+(-1)^{k+2}\right) Q_{n-1}(k, m-k) \\
& -\sum_{k=1}^{m}\left((-1)^{k+1}+(-1)^{k}\right) Q_{n-1}(k, m+1-k) \\
& -(-1)^{m+1} Q_{n-1}(m+1) \\
= & Q_{n-1}(m+1) \\
= & G_{n-1}(m+1,0)
\end{aligned}
$$

which is the desired equality
$G_{n}(m, k)$ can also be expressed in terms of this new function.

## Lemma 15.

$$
\begin{equation*}
G_{n}(m, k)=\sum_{\substack{m_{0}>0 \\ \sum m_{i}=m}}\binom{m}{m_{0}, \ldots, m_{k}} Q_{n}\left(m_{0}, \ldots, m_{k}\right) \tag{24}
\end{equation*}
$$

Proof. $G_{n}(m, k)=\sum_{\left|a_{i}-a_{j}\right| \leq k} P_{n}\left(a_{1}, \ldots, a_{m}\right)=\sum_{x=0}^{\infty} \sum_{\substack{a_{i} \leq x+k \\ \min \left(a_{i}\right)=x}} P_{n}\left(a_{1}, \ldots, a_{m}\right)$
For each $x \in \mathbb{Z}_{\geq 0}, \sum_{\substack{a_{i} \leq x+k \\ \min \left(a_{i}\right)=x}} P_{n}\left(a_{1}, \ldots, a_{m}\right)$ can be partitioned into the path-height functions with the same parameters up to rearrangement. In this sum, there are $\binom{m}{m_{0}, \ldots, m_{k}}$ path-height functions that are equal to $Q_{n}^{(x)}\left(m_{0}, \ldots, m_{k}\right)$, and so

$$
\begin{aligned}
G_{n}(m, k)=\sum_{x=0}^{\infty} \sum_{\substack{a_{i} \leq x+k \\
\min \left(a_{i}\right)=x}} P_{n}\left(a_{1}, \ldots, a_{m}\right) & =\sum_{x=0}^{\infty} \sum_{\substack{m_{0}>0 \\
\sum m_{i}=m}}\binom{m}{m_{0}, \ldots, m_{k}} Q_{n}^{(x)}\left(m_{0}, \ldots, m_{k}\right) \\
& =\sum_{\substack{m_{0}>0 \\
\sum m_{i}=m}}\binom{m}{m_{0}, \ldots, m_{k}} Q_{n}\left(m_{0}, \ldots, m_{k}\right)
\end{aligned}
$$

Corollary 16. For $n \geq 1$,

$$
\begin{aligned}
4 G_{n}(m, 1)-G_{n+1}(m, 1)= & G_{n}(m+1,1)-2(m-1) Q_{n}(m) \\
& +\sum_{k=1}^{m-1}\left(2\binom{m}{k}-\binom{m}{k+1}-\binom{m}{k-1}\right) Q_{n}(k, m-k)
\end{aligned}
$$

Proof. By Lemma 15,

$$
G_{n+1}(m, 1)=\sum_{k=1}^{m}\binom{m}{k} Q_{n+1}(k, m-k)
$$

Letting $a_{k}:=\binom{m}{k^{\prime}}$, where $0 \leq k^{\prime}<m$ and $k \equiv k^{\prime}(\bmod m)$, Lemma 13 turns the above into

$$
\begin{aligned}
G_{n+1}(m, 1) & =\sum_{k=1}^{m}\left(2 a_{k}+a_{k-1}+a_{k+1}\right) Q_{n}(k, m-k) \\
& -\sum_{k=1}^{m}\left(a_{k}+a_{k-1}\right) Q_{n}(k, m+1-k)-a_{m} Q_{n}(m+1)
\end{aligned}
$$

Pulling out $Q_{n}(m)$ and plugging in for $a_{k}$ results in

$$
G_{n+1}(m, 1)=(2 m+2) Q_{n}(m)+\sum_{k=1}^{m-1}\left(2\binom{m}{k}+\binom{m}{k-1}+\binom{m}{k+1}\right) Q_{n}(k, m-k)
$$

$$
\begin{aligned}
& -\sum_{k=1}^{m}\left(\binom{m}{k}+\binom{m}{k-1}\right) Q_{n}(k, m+1-k)-Q_{n}(m+1) \\
= & (2 m+2) Q_{n}(m)+\sum_{k=1}^{m-1}\left(2\binom{m}{k}+\binom{m}{k-1}+\binom{m}{k+1}\right) Q_{n}(k, m-k) \\
& -\sum_{k=1}^{m+1}\binom{m+1}{k} Q_{n}(k, m+1-k)
\end{aligned}
$$

Which by Lemma 15 means that

$$
\begin{aligned}
G_{n+1}(m, 1)= & (2 m+2) Q_{n}(m)+\sum_{k=1}^{m-1}\left(2\binom{m}{k}+\binom{m}{k-1}+\binom{m}{k+1}\right) Q_{n}(k, m-k) \\
& -G_{n}(m+1,1)
\end{aligned}
$$

As a result,

$$
\begin{aligned}
4 G_{n}(m, 1)-G_{n+1}(m, 1)= & 4 \sum_{k=1}^{m}\binom{m}{k} Q_{n}(k, m-k)-(2 m+2) Q_{n}(m) \\
& -\sum_{k=1}^{m-1}\left(2\binom{m}{k}+\binom{m}{k-1}+\binom{m}{k+1}\right) Q_{n}(k, m-k)+G_{n}(m+1,1) \\
= & G_{n}(m+1,1)-(2 m-2) Q_{n}(m) \\
& +\sum_{k=1}^{m-1}\left(2\binom{m}{k}-\binom{m}{k-1}-\binom{m}{k+1}\right) Q_{n}(k, m-k)
\end{aligned}
$$

## 4. Proof of Theorem 1 AND 2

Proof of Theorem 1 .

$$
\begin{aligned}
T(3, n) & =4 T(2, n)-T(2, n+1) \\
& =4 G_{n}(2,1)-G_{n+1}(2,1) \\
& =G_{n}(3,1)+\left(\sum_{k=1}^{1}\left(2\binom{2}{k}-\binom{2}{k-1}-\binom{2}{k+1}\right) Q_{n}(k, 2-k)\right)+(2-2 * 2) Q_{n}(2) \\
& =G_{n}(3,1)+2 Q_{n}(1,1)-2 Q_{n}(2) \\
& =G_{n}(3,1)+2\left(\sum_{k=1}^{2}(-1)^{k+1} Q_{n}(k, 2-k)\right) \\
& =G_{n}(3,1)+2 G_{n-1}(3,0)
\end{aligned}
$$

where the last step is by Corollary 14 .
Proof of Theorem 2

$$
T(4, n)=4 T(3, n)-T(3, n+1)
$$

$$
\begin{aligned}
= & 4\left(G_{n}(3,1)+2 G_{n-1}(3,0)\right)-\left(G_{n+1}(3,1)+2 G_{n}(3,0)\right) \\
= & \left(4 G_{n}(3,1)-G_{n+1}(3,1)\right)+8 G_{n-1}(3,0)-2 G_{n}(3,0) \\
= & \left(G_{n}(4,1)+\left(\sum_{k=1}^{2}\left(2\binom{3}{k}-\binom{3}{k-1}-\binom{3}{k+1}\right) Q_{n}(k, 3-k)\right)\right. \\
& \left.+(2-3 * 2) Q_{n}(3)\right)+8 Q_{n-1}(3)-2 Q_{n}(3) \\
= & G_{n}(4,1)+8 Q_{n-1}(3)+2 Q_{n}(1,2)+2 Q_{n}(2,1)-6 Q_{n}(3)
\end{aligned}
$$

Applying Corollary 12 to the third and fourth terms and Corollary 11 to the last term results in

$$
\begin{aligned}
T(4, n)= & G_{n}(4,1)+8 Q_{n-1}(3) \\
& +2\left(2 Q_{n-1}(1,2)+Q_{n-1}(2,1)+Q_{n-1}(3)-Q_{n-1}(2,2)-Q_{n-1}(1,3)\right) \\
& +2\left(2 Q_{n-1}(2,1)+Q_{n-1}(3)+Q_{n-1}(1,2)-Q_{n-1}(3,1)-Q_{n-1}(2,2)\right) \\
& -6\left(2 Q_{n-1}(3)+Q_{n-1}(1,2)+Q_{n-1}(2,1)-Q_{n-1}(1,3)-Q_{n-1}(4)-Q_{n-1}(3,1)\right) \\
= & G_{n}(4,1)-4 Q_{n-1}(2,2)+4 Q_{n-1}(1,3)+6 Q_{n-1}(4)+4 Q_{n-1}(3,1) \\
= & G_{n}(4,1)+10 Q_{n-1}(4)+4\left(Q_{n-1}(1,3)-Q_{n-1}(2,2)+Q_{n-1}(3,1)-Q_{n-1}(4)\right) \\
= & G_{n}(4,1)+10 G_{n-1}(4,0)+4 G_{n-2}(5,0) .
\end{aligned}
$$

Where the last step is by Corollary 14 ,
The proofs for the above theorems extend to the following for $m=5$ :

$$
\begin{equation*}
T(5, n)=G_{n}(5,1)+37 G_{n-1}(5,0)+35 G_{n-2}(6,0)+10 G_{n-3}(7,0)-14 G_{n-2}(5,0) \tag{25}
\end{equation*}
$$

Notice that, due to the last term, the above equation is not in the form of Equation 7 , and is not even a positively weighted combinatorial interpretation.
