A REFINEMENT OF BAILLON'S THEOREM ON MAXIMAL REGULARITY

ABSTRACT. By Baillon's result, it is known that maximal regularity with respect to the space of continuous functions is rare; it implies that either the involved semigroup generator is a bounded operator or the considered space contains c_0 . We show that the latter alternative can be excluded under a refined condition resembling maximal regularity with respect to L^{∞} .

1. Introduction

The question whether the solutions to an abstract Cauchy problem

$$\frac{\mathrm{d}}{\mathrm{d}t}x(t) = Ax(t) + f(t), \qquad t \in [0, \tau],$$

$$x(0) = 0,$$
(1.1)

where A generates a strongly continuous semigroup $\mathbf{S} = (S(t))_{t\geq 0}$ on a Banach space X, preserve the regularity of the inhomogeneity $f:[0,\tau]\to X$ is omnipresent in the study of parabolic equations. They turn out to be particularly useful for investigating nonlinear equations, see e.g. [1, 19, 31, 35] and the references therein. More precisely, maximal regularity of the semigroup (or, equivalently, the generator) requires that $\frac{d}{dt}x$ and Ax have the same regularity as f, e.g. that $\frac{d}{dt}x$ and Ax are well-defined in $L^p((0,\tau),X)$ for any $f\in L^p((0,\tau),X)$, $\tau>0$, where $x:[0,\tau]\to X$ refers to the mild solution to (1.1). This property is equivalent to an inequality of the form

$$\left\| A \int_0^{\cdot} S(\cdot - s) f(s) ds \right\|_{L^p((0,\tau),X)} \le \kappa_{\tau} \| f \|_{L^p((0,\tau),X)}, \tag{1.2}$$

for some constant $\kappa_{\tau} > 0$ and all $f \in L^{p}((0,\tau),X)$. The theory on maximal regularity has started with the works by de Simon and Sobolevskii [18, 39],

who showed that analyticity of the semigroup is a sufficient condition on Hilbert spaces when $p \in (1, \infty)$. In fact, also on general Banach spaces, analyticity is necessary for maximal regularity and the property is independent of the particular choice $p \in (1, \infty)$, [10, 12, 20], see also [32] for the case of continuous functions. However, this characterization fails to be true for general non-Hilbert spaces, as was shown by Kalton-Lancien [29], see also [23, 24]. The appropriate replacement for UMD spaces was found by Weis to be the property that A is R-sectorial, [44].

On the other hand, the cases p=1 and $p=\infty$ are exotic in a way. In 1980, Baillon [4] proved that maximal regularity with respect to the space of the continuous functions—i.e. replacing "L^p((0, τ), X)" by "C([0, τ], X)" in (1.2)—implies that A must be bounded when X does not contain an isomorphic copy of the sequence space c_0 . A rather simple example, due to T. Kato, of an unbounded operator A on c_0 —which had been known prior to Baillon's work—shows that the latter assumption on X cannot be dropped in general. Note that a simplified proof of Baillon's result can be found in [21] and that the case $X=L^2$ had even been treated earlier in [13]. Moreover, it is not hard to see that in Baillon's result "C-maximal regularity" may be replaced by "L[∞]-maximal regularity", see also [25]. The dual situation of L¹-maximal regularity was covered by Guerre-Delabrière [25]. In [41], see also the comments in [11], Travis (implicitly) showed that C-maximal regularity is equivalent to the property that S is of bounded semivariation on some interval $[0, \tau]$, i.e.,

$$\operatorname{var}_{0}^{\tau}(\mathbf{S}) := \sup_{\|x_{i}\| \leq 1, \ 0 = t_{1} < t_{2} < \dots < t_{n} = \tau, \ n \in \mathbb{N}} \left\| \sum_{i=1}^{n-1} (S(t_{i}) - S(t_{i+1})) x_{i} \right\| < \infty, \quad (1.3)$$

and, moreover, that this is equivalent to the property that every weak solution of (1.1) is in fact a classical solution. Travis' proof yet reveals another characterization of C-maximal regularity; namely that

$$\Phi_{\tau}: C([0,\tau],X) \to X, f \mapsto A \int_0^{\tau} S(\tau-s)f(s)ds$$

is a well-defined bounded operator. In the present work we investigate the consequence of sharpening the condition of C-maximal regularity by refining this latter property. More precisely, we study the assumption that Φ_{τ} is even bounded from $L^{\infty}((0,\tau),X)$ to X, which—as should be emphasized—is stronger than plain L^{∞} -maximal regularity. Indeed, Kato's example satisfies L^{∞} -maximal regularity, but fails to have the refined property of Φ_{τ} being bounded from $L^{\infty}((0,\tau),X)$ to X, see Example 2.3 below. This is not accidental; our main result, Theorem 2.9, states that this condition always implies that A is bounded, independent of whether X contains c_0 or not. Therefore, our contribution can be seen as a refinement of Baillon's result. Moreover, since any bounded generator is easily seen to imply that $\Phi_{\tau} \in \mathcal{L}(L^{\infty}((0,\tau),X),X)$, the result establishes yet another characterization of when a strongly continuous semigroups is in fact uniformly continuous, or, equivalently, when the generator A is a bounded operator. Results of this type often rest on dichotomy laws on norm bounds for S(t) - I or

tAS(t) as $t \to 0^+$, see e.g. Lotz [3, 33], Hille [26] or [5]. A related argument indeed shows that in order to prove our main theorem, it would suffice to show that the norm of Φ_{τ} tends to 0 as $\tau \to 0^+$, Proposition 1.3. Note that also here the crucial difference between bounds of Φ_{τ} on $C([0,\tau],X)$ and $L^{\infty}((0,\tau),X)$ becomes apparent: Whereas in the former case Kato's example on $X = c_0$ shows that $\limsup_{\tau \to 0^+} \|\Phi_{\tau}\| > 0$, an analogous construction for a potential counterexample in the latter case would require $X = \ell^{\infty}$. But then, by Lotz's result [33], A was bounded trivially. Unfortunately, this sufficient (and necessary) condition on norm convergence of Φ_{τ} seems to be hard to access. Therefore, our proof approach follows a different path, which exploits both Baillon's result as well as information on the Favard space of the semigroup, Theorem 2.6. These ingredients are then combined by using a remarkable characterization of isomorphisms $R: c_0 \to Y$ due to Lotz-Peck-Porta [34] and Bourgain-Rosenthal [9], which was previously applied by van Neerven [42, Theorem 3.2.10] to characterize uniformly continuous semigroups on c_0 by properties of the respective Favard spaces.

It is natural to investigate the dual condition of Φ_{τ} being bounded from L^{∞} to X, which reduces to boundedness of the mapping

$$\Psi_{\tau}: X \to \mathrm{L}^1((0,\tau),X), x \mapsto AS(\cdot)x,$$

which, a-priori, is well-defined on the domain of A. However, by means of examples it is not hard to see that this condition, which is in fact equivalent to L^1 -maximal regularity, see [30, Theorem 3.6] and Proposition 2.1, does not imply boundedness of A in general. Nevertheless, L^1 -maximal regularity pertains to the study of existence and stability of nonlinear equations such as in mathematical fluid flow [14, 15, 16]. However, there the space X in (1.2) is replaced by some interpolation space between X and the domain of A, which is common for results on maximal regularity. We also refer to [38], where such an abstract L^1 -case is in turn deduced from a classical C-maximal regularity result due to Da Prato-Grisvard [13].

In Section 3 we discuss the discrete-time analogs of the previously derived results and show that the difference in maximal regularity and its refined notion vanishes in this situation, which makes this case less interesting. In the following subsection we give a brief recap on the notions of maximal regularity and the above mentioned conditions on Φ_{τ} and Ψ_{τ} , which can be conveniently phrased in terms of *admissible* operators, a notion borrowed from infinite-dimensional systems theory [45].

1.1. Notions and basic properties. In the following $\mathbf{S} = (S(t))_{t\geq 0}$ always refers to a strongly continuous semigroup on a Banach space X with generator A. All normed spaces considered in this paper are assumed to be complex. For normed spaces X and Y, $\mathcal{L}(X,Y)$ denotes the space of bounded linear operators from X to Y, with the convention $\mathcal{L}(X) = \mathcal{L}(X,X)$. The domain and range of a linear, possibly unbounded, operator B will be denoted by D(B) and ran B respectively. Furthermore, let $\rho(B)$ refer to the resolvent set of B and for $\lambda \in \rho(B)$ we write $R(\lambda, B) = (\lambda - B)^{-1}$ for the resolvent operator. We associate the following abstract Sobolev spaces with

the semigroup \mathbf{S} ; the space $X_1 = (D(A), \|\cdot\|_{D(A)})$, where $\|\cdot\|_{D(A)}$ refers to the graph norm of A, and X_{-1} , which is the completion of X with respect to the norm $\|R(\lambda,A)\cdot\|$ for some fixed $\lambda\in\rho(A)$. It is well-known that \mathbf{S} can be uniquely extended to a strongly continuous semigroup \mathbf{S}_{-1} on X_{-1} whose generator A_{-1} extends A and has domain $D(A_{-1}) = X$. For an interval $I\subseteq\mathbb{R}_+:=[0,\infty),\,p\in[1,\infty]$ and some Banach space U, let $L^p(I,U)$, $\mathrm{Reg}(I,U)$ and $\mathrm{C}(I,U)$ refer to the spaces of Lebesgue-Bochner p-integrable (equivalence classes of) functions, the regulated functions and the continuous functions, $f:I\to U$, respectively, with the usual convention for $p=\infty$. We equip both $\mathrm{C}(I,U)$ and $\mathrm{Reg}(I,U)$ with the supremum norm. Sometimes we will use the place holder F in $\mathrm{F}(I,U)$ to formulate a statement for either of the above spaces.

Definition 1.1. Let F be either L^p , $p \in [1, \infty]$, or C or Reg. A strongly continuous semigroup $\mathbf{S} := (S(t))_{t \geq 0}$ (or its generator A) is said to satisfy the maximal regularity property with respect to F or F-maximal regularity, if for some $\tau > 0$ and all $f \in F([0, \tau], X)$, it holds that $(\mathbf{S} * f)(t) \in D(A)$ for almost every $t \in (0, \tau)$ and

$$A(\mathbf{S} * f) \in \mathcal{F}([0, \tau], X),$$

where

$$(\mathbf{S} * f)(t) := \int_0^t S(t-s)f(s)\mathrm{d}s. \tag{1.4}$$

It is easy to see that **S** has the C-maximal-regularity property if and only if $\mathbf{S} * f \in C([0, \tau], X_1)$, see also [21]. Furthermore, whenever **S** has the C-maximal-regularity for some $\tau > 0$, then this holds for every $\tau > 0$.

The following notions are central for this work.

Definition 1.2. Let U, Y be Banach spaces and F be either L^p , Reg or C.

(1) An operator $B \in \mathcal{L}(U, X_{-1})$ is called an F-admissible control operator or F-admissible for S, if for some (hence all) $\tau > 0$ the mapping

$$\Phi_{\tau} \colon \mathrm{F}([0,\tau],U) \to X_{-1}, \quad u \mapsto \int_0^{\tau} S_{-1}(\tau-t)Bu(t)\mathrm{d}t$$

has range in X, i.e. $ran(\Phi_{\tau}) \subset X$.

(2) We call $C \in \mathcal{L}(X_1, Y)$ an F-admissible observation operator or F-admissible for S, if for some (hence all) $\tau > 0$ the operator

$$\Psi_{\tau} \colon X_1 \to \mathcal{F}([0,\tau],Y), \quad x \mapsto CS(\cdot)x$$

has a bounded extension to X, again denoted by Ψ_{τ} .

If $\limsup_{\tau\to 0^+} \|\Phi_{\tau}\|_{\mathcal{L}(\mathrm{F}([0,\tau],U),X)} = 0$ or $\limsup_{\tau\to 0^+} \|\Psi_{\tau}\|_{\mathcal{L}(X,\mathrm{F}([0,\tau],Y))} = 0$, we say that B or C are zero-class F -admissible, respectively.

The above notion of admissible operators, first coined by G. Weiss [45, 46], plays an important role in the context of infinite-dimensional linear systems theory, and particularly, in the context of boundary control and observation, see also [40]. Note that by the Closed-Graph Theorem, $B \in$

 $\mathcal{L}(U, X_{-1})$ is F-admissible if and only if Φ_{τ} is bounded from $F([0, \tau], U)$ to X, i.e. there exists $K_{\tau} > 0$ such that

$$\left\| \int_0^{\tau} S_{-1}(\tau - s) Bu(s) ds \right\| \leqslant K_{\tau} \|u\|_{\mathcal{F}([0,\tau],U)}, \quad u \in \mathcal{F}([0,\tau],U).$$

This also shows that in the definition the norm $\|\Phi_{\tau}\|_{\mathcal{L}(F([0,\tau],U),X)}$ in the above definition of zero-class admissibility is well-defined. Since for $p \in (1,\infty)$,

$$C(I, U) \subset Reg(I, U) \subset L^{\infty}(I, U) \subset L^{p}(I, U) \subset L^{1}(I, U)$$

for bounded intervals $I \subset \mathbb{R}_+$, with continuous embeddings, there is a natural chain of implications for the property of admissible operators. In particular, B being a C-admissible control operator is the weakest property in the the scale of F-admissibility. Dually, any F-admissible observation operator is L^1 -admissible. In the following we will only be interested in the cases where $B = A_{-1}$ is an admissible control operator or C = A is an admissible observation operator.

The following result, which is a slight extension of [28, Proposition 16], marks the point of departure for Section 2. The proof follows the same lines as in the cited reference and is therefore omitted.

Proposition 1.3. Let A be the generator of a strongly continuous semigroup **S**. If either

- A is a zero-class L¹-admissible observation operator, or
- A_{-1} is a zero-class C-admissible control operator,

then A is bounded.

In Example 2.3 below we will show that the assumption of zero-class admissibility cannot be dropped in the above proposition (in either case). We conclude this preparatory section with a result that gives an indication how the seemingly strong condition of A_{-1} being an admissible control operator relates to admissibility of general control operators.

Proposition 1.4. Let S be a strongly continuous semigroup on a Banach space X with generator A. Let F be a placeholder for either C, Reg or L^{∞} . The following assertions are equivalent.

- (1) For every Banach space U, every operator $B \in \mathcal{L}(U, X_{-1})$ is F-admissible.
- (2) A_{-1} is F-admissible.

Proof. Without loss of generality assume that $0 \in \rho(A)$ and fix t > 0. Note that the mapping $f \mapsto A_{-1}f(\cdot)$ is an isomorphism from $L^{\infty}((0,t),X)$ to $L^{\infty}((0,t),X_{-1})$. Assume that A_{-1} is L^{∞} -admissible and consider $B \in \mathcal{L}(U,X_{-1})$ for some Banach space U. Since for any $u \in L^{\infty}((0,t),U)$ it holds that $Bu(s) = A_{-1}\tilde{u}(s)$ where $\tilde{u} = A_{-1}^{-1}Bu \in L^{\infty}((0,t),X)$, we conclude that B is L^{∞} -admissible. The converse is clear since $A_{-1} \in \mathcal{L}(X,X_{-1})$.

Note that the variant of Proposition 1.4 for $F = L^p$, $p < \infty$, is trivial, since, by Hölder's inequality, Proposition 1.3 implies that A_{-1} is L^p -admissible if and only if A is bounded.

2. Maximal regularity and admissible generators

The following two propositions show that maximal regularity and admissibility with respect to continuous, regulated functions and L¹-functions are closely related.

Proposition 2.1. Let S be a strongly continuous semigroup on a Banach space X with generator A. Then the following assertions hold:

- (1) **S** satisfies L^1 -maximal-regularity if and only if A is L^1 -admissible.
- (2) A_{-1} is L^p -admissible for some $p \in (1, \infty)$ if and only if $A \in \mathcal{L}(X)$.

Proof. The first assertion was proved in [30, Theorem 3.6] (without explicitly using the notion of admissible operators) by rescaling the semigroup. Assertion (2) is immediate from Proposition 1.3 and Hölder's inequality. \Box

Note that by Guerre-Delabrière's result it holds that if **S** satisfies L¹-maximal-regularity and A is unbounded, then X must contain a complemented copy of ℓ^1 , see [25] and [30].

Proposition 2.2. Let S be a strongly continuous semigroup on a Banach space X with generator A. Then the following assertions are equivalent:

- (1) S satisfies C-maximal-regularity,
- (2) A_{-1} is C-admissible,
- (3) **S** is of bounded semivariation, i.e. (1.3) holds for all $\tau > 0$,
- (4) S satisfies Reg-maximal-regularity,
- (5) A_{-1} is Reg-admissible.

Proof. The equivalences $(1)\Leftrightarrow(2)\Leftrightarrow(3)$ are shown in [41, Lemma 3.1 and Proposition 3.1]. The implication $(4)\Rightarrow(5)$ is easy to see from the definitions and $(5)\Rightarrow(4)$ is a consequence of [40, Theorem 4.3.1], which even implies that Ax is continuous for any $f\in \text{Reg}([0,\tau],X)$, where x is the mild solution to equation (1.1). Since (5) trivially implies (2), it follows that $(5)\Rightarrow(3)$. It remains to show that $(3)\Rightarrow(5)$. Let $f:[0,\tau]\to X,\,\tau>0$, be an arbitrary regulated function and suppose that \mathbf{S} is of bounded semivariation on $[0,\tau]$. Then there exists a sequence of step functions $(f_n)_{n\in\mathbb{N}}$ represented by

$$f_n(s) := \sum_{i=1}^n f(d_i^n) \chi_{(d_{i-1}^n, d_i^n)}(s), \qquad s \in [0, \tau],$$

which converges uniformly to f and where $0 = d_0^n < d_1^n < \cdots < d_n^n = \tau$. Define $g_n(s) = S(\tau - s)f(d_i^n)$ for $d_{i-1}^n < s \leq d_i^n$, $i = 1, \ldots, n$, and $g_n(0) = S(\tau)f(0)$. Because f is bounded and \mathbf{S} is strongly continuous, we have that $(g_n)_{n \in \mathbb{N}}$ is uniformly bounded and converges uniformly to $s \mapsto S(\tau - s)f(s)$ for $n \to \infty$. Therefore,

$$\lim_{n\to\infty} \int_0^{\tau} g_n(s) ds = \int_0^{\tau} S(\tau - s) f(s) ds.$$

Because $\int_0^\tau g_n(s) ds \in D(A)$ we can calculate,

$$A \int_0^{\tau} g_n(s) ds = A \sum_{i=1}^n \int_{d_{i-1}^n}^{d_i^n} g_n(s) ds$$
$$= \sum_{i=1}^n \left[S(\tau - d_i^n) - S(\tau - d_{i-1}^n) \right] f_n(d_i^n)$$
$$=: h_n.$$

Since **S** is of bounded semivariation, we have for $n, m \in \mathbb{N}$ that

$$||h_n - h_m||_X \leqslant \operatorname{var}_0^{\tau}(\mathbf{S})||f_n - f_m||_{\infty},$$

where $\operatorname{var}_0^{\tau}(\mathbf{S})$ is defined as in (1.3). Since $(f_n)_{n\in\mathbb{N}}$ is a Cauchy sequence, it follows that $(h_n)_{n\in\mathbb{N}}$ is a Cauchy sequence of X and thus converges to a limit in X. Hence, as A is closed,

$$\int_0^{\tau} S(\tau - s) f(s) ds \in D(A),$$

and therefore,

$$\int_0^{\tau} S_{-1}(\tau - s) A_{-1} f(s) ds = A \int_0^{\tau} S(\tau - s) f(s) ds \in X. \quad \Box$$

The following example has been used in the context of C-maximal regularity several times, [4, 21], and seems to go back T. Kato¹. We use it to show that an analogous statement as Proposition 2.2 for L^{∞} does not hold.

Example 2.3. Let $X = c_0(\mathbb{N})$ and $Ax = \sum_{n=1}^{\infty} -nx_n e_n$ with $D(A) = \{x \in X : \sum_{n=1}^{\infty} -nx_n e_n \in c_0(\mathbb{N})\}$ and where $(e_n)_{n \in \mathbb{N}}$ refers to the canonical basis. It is easy to see that A generates an exponentially stable strongly continuous semigroup $\mathbf{S} = (S(t))_{t \geq 0}$ given by

$$S(t)x = \sum_{n=1}^{\infty} e^{-nt} x_n e_n$$

(see e.g. [22, Example 4.7 iii), Chapter I]). Let now $B = -A_{-1} \in \mathcal{L}(X, X_{-1})$. Define $u \in L^{\infty}([0, \tau], c_0(\mathbb{N}))$ by $u(s) = \sum_{n=1}^{\infty} (u(s))_n e_n$, where

$$(u(s))_n := \begin{cases} 1 & \text{if } s \in \left[\tau - \frac{1}{n}, \tau - \frac{1}{2n}\right] \text{ and } \frac{1}{n} < \tau, \\ 0 & \text{otherwise.} \end{cases}$$

The element $f = \int_0^{\tau} S_{-1}(\tau - s)Bu(s)ds = \int_0^{\tau} S_{-1}(s)Bu(\tau - s)ds$ in X_{-1} can be represented by a sequence $(f_n)_n$ and we can calculate for all $n \in \mathbb{N}$ with $\frac{1}{n} < \tau$,

$$f_n = \int_0^{\tau} e^{-ns} n(u(\tau - s))_n ds = \int_{\frac{1}{2n}}^{\frac{1}{n}} n e^{-ns} ds = -(e^{-1} - e^{-\frac{1}{2}}) > \frac{1}{5}.$$

This shows $f \notin c_0(\mathbb{N})$ and therefore B is not L^{∞}-admissible. On the other hand, it is easy to see that **S** satisfies F-maximal-regularity for F = C, Reg

and L^{∞} , see e.g. [21], and thus $B = -A_{-1}$ is Reg-admissible and hence C-admissible by Proposition 2.2. Since A is obviously unbounded, Proposition 1.3 shows that B is not zero-class F-admissible with F equal to Reg or C.

Remark 2.4. It seems to have been unnoticed in the literature that the simple Example 2.3 answers an old question posed by G. Weiss in [46, Remark 6.10] about whether L^1 -admissibility of B^* with respect to the dual semigroup S^* implies that B is L^{∞} -admissible for S for general $B \in \mathcal{L}(U, X_{-1})$ and where B^* is to be understood as an admissible observation operator. In the setting of the example, the dual semigroup on $X^* = \ell^1(\mathbb{N})$ is given by $S^*(t)x = \sum_n e^{-nt}x_n e_n$ for any $x = \sum_n x_n e_n$ and where $(e_n)_{n \in \mathbb{N}}$ (again) refers to the canonical basis of ℓ^1 . It is easy to check that $A^* = (A_{-1})^*$ is an L¹admissible observation operator for S^* . On the other hand, $B = A_{-1}$ is not L^{∞} -admissible for **S** as shown above. Furthermore, the example shows that Reg-admissibility does not imply zero-class Reg admissibility. Therefore, the assumption of "zero class admissibility" in Proposition 1.3 cannot be relaxed to plain "admissibility". On the other hand, the existence of a Reg-admissible operator B which is not zero-class Reg-admissible also establishes a counterexample in the context of *input-to-state stability* for infinite-dimensional linear systems, see e.g. [36, 27]: By [27, Proposition 2.10], it shows that there exists a system (A, B) which is input-to-state stable, but not integral input-to-state stable both with respect to respect to Reg-input functions.

In order to proceed to our main result, we need to discuss Baillon's theorem on maximal regularity with respect to C in more detail. The following proposition was derived within the proof of Baillon's theorem [4], see also [21]. Since we need it formulated explicitly, we sketch a short argument based on a classical characterization of spaces containing c_0 due to Bessaga–Pełcyński [6], see also [21].

Proposition 2.5 (Baillon's theorem and Baillon spaces). Let A generate a strongly continuous semigroup S on a Banach space X. If S satisfies C-maximal-regularity and A is unbounded, then X contains an isomorphic copy of c_0 . More precisely, there exists a sequence $(z_n)_{n\in\mathbb{N}}$ in X with the following properties:

- (1) $Z := \overline{\operatorname{span}}(z_n)_{n \in \mathbb{N}}$ is isomorphic to c_0 ,
- (2) $(z_n)_{n\in\mathbb{N}}$ is a Schauder basis of Z,
- (3) $0 < \inf_n ||z_n|| \le \sup_n ||z_n|| < \infty$,
- (4) $\lim_{n\to\infty} R(\lambda, A)z_n = 0$ for any $\lambda \in \rho(A)$.

We call such a space Z a Baillon space.

Proof. To show the existence of a sequence $(z_n)_{n\in\mathbb{N}}$ satisfying (2)–(3), it suffices to find a sequence $(x_n)_{n\in\mathbb{N}}$ and a constant M>0 such that

$$\inf_{n} ||x_n|| > 0 \quad \text{and} \quad \left\| \sum_{j=0}^{m} x_{n_j} \right\| \le M, \qquad m \in \mathbb{N},$$

for any increasing sequence $(n_j)_j$ of positive integers, see [21, Theorem 0.1]. Following [4] or [21]—using that A is unbounded and that S satisfies C-maximal-regularity—a possible choice is given by $x_n = t_n AS(t_n)y_n$ with

suitably chosen sequences $(t_n)_{n\in\mathbb{N}}$ in (0,1) and $(y_n)_{n\in\mathbb{N}}$ in X with $\sum_{n=1}^{\infty} t_n < \infty$ and $||y_n|| = 1$, $n \in \mathbb{N}$. By [6, Cor. 1 and Lemma 3], see also [2, Lemma D.2 and Theorem D.3], the sequence $(z_n)_{n\in\mathbb{N}}$ can then be derived as a block basis from $(x_n)_{n\in\mathbb{N}}$, i.e. there exists an increasing sequence of positive integers $(p_k)_{k\in\mathbb{N}}$ and a sequence of positive numbers $(s_k)_{k\in\mathbb{N}}$ such that

$$z_k = \sum_{n=p_k+1}^{p_{k+1}} s_n x_n, \qquad k \in \mathbb{N},$$

satisfies (2)–(3). By the proof of Lemma D.2 in [2], the sequence $(s_k)_{k\in\mathbb{N}}$ can be chosen to be bounded. To see Assertion (4), fix $\lambda \in \rho(A)$ and note that

$$||R(\lambda, A)z_n|| \leqslant \sum_{n=p_k+1}^{p_{k+1}} t_n ||(\lambda R(\lambda, A) - I)S(t_n)y_n|| \longrightarrow 0 \quad (n \to \infty). \quad \Box$$

In particular, Baillon's result shows that if A_{-1} is L^{∞} -admissible and A is unbounded, then X must contain c_0 and therefore, e.g., fails to be reflexive. This, however, does not exploit the difference between L^{∞} -admissibility and C-admissibility. A step towards this is achieved in the following result.

Theorem 2.6. Let **S** be a strongly continuous semigroup on a Banach space X. If A_{-1} is L^{∞} -admissible then

$$Fav(\mathbf{S}) = D(A),$$

where $Fav(\mathbf{S}):=\{x\in X\colon \limsup_{t\to 0^+}\frac{1}{t}\|S(t)x-x\|<\infty\}$ refers to the Favard space of \mathbf{S} .

Proof. Without loss of generality we may assume that $0 \in \rho(A)$. Let $x \in Fav(\mathbf{S})$. It is well-known, e.g. [42, Theorem 3.2.8], that there exists a bounded sequence $(y_n)_{n\in\mathbb{N}}$ in X such that $\lim_{n\to\infty} A^{-1}y_n = x$. Let $(t_n)_{\in\mathbb{N}}$ be a strictly decreasing sequence of positive numbers with $t_0 = 1$ and $\lim_{n\to\infty} t_n = 0$. Define $u: [0,1) \to X$ by

$$u(s) = y_n$$
 for $s \in [1 - t_n, 1 - t_{n+1}), n \in \mathbb{N}_0$.

Clearly, $u \in L^{\infty}((0,1),X)$ since (y_n) is bounded. We have by assumption that

$$\int_{0}^{1} S_{-1}(1-s)A_{-1}u(s)ds = \int_{0}^{1} A_{-1}S_{-1}(s)u(1-s)ds$$

$$= \sum_{n=0}^{\infty} \int_{t_{n+1}}^{t_n} A_{-1}S_{-1}(s)u(1-s)ds$$

$$= \sum_{n=0}^{\infty} \int_{t_{n+1}}^{t_n} \frac{d}{ds}S_{-1}(s)u(1-s)ds$$

$$= \sum_{n=0}^{\infty} (S(t_n)y_n - S(t_{n+1})y_n),$$

where the involved integrals and sums converge in X_{-1} with limit in X. Upon considering a subsequence, assume that $\sum_{n=0}^{\infty} t_n^{-1} ||y_{n+1} - y_n||_{-1} < \infty$.

Without loss of generality we can set $y_0 = 0$. By using that the semi-group is in fact analytic, which follows from the assumption that A_{-1} is L^{∞} -admissible, e.g. by [28, Proposition 9] and Proposition 1.4,

$$||S(t_{n+1})(y_n - y_{n+1})|| \le ||AS(t_{n+1})|| ||y_n - y_{n+1}||_{-1}$$

$$\le Ct_{n+1}^{-1} ||y_n - y_{n+1}||_{-1},$$

and thus $\sum_{n=0}^{\infty} S(t_{n+1})(y_n-y_{n+1})$ converges in X absolutely. Combining this with the above shows that

$$S(t_N)y_N = \sum_{n=0}^{N-1} S(t_{n+1})y_{n+1} - S(t_n)y_n$$

$$= \sum_{n=0}^{N-1} (S(t_{n+1})y_n - S(t_n)y_n) - \sum_{n=0}^{N-1} S(t_{n+1})(y_n - y_{n+1})$$

converges for $N \to \infty$ in the X_{-1} -norm with a limit in X. Since

$$||S(t_N)y_N - A_{-1}x||_{-1} \le ||S(t_N)y_N - S(t_N)A_{-1}x||_{-1} + ||(S(t_N) - I)A_{-1}x||_{-1}$$
$$\le M||y_N - A_{-1}x||_{-1} + ||S(t_N)A_{-1}x - A_{-1}x||_{-1},$$

we have that the X_{-1} -limit of $S(t_N)y_N$ equals $A_{-1}x$ which is the X_{-1} -limit of the sequence (y_n) . Thus, $A_{-1}x \in X$, and therefore $x = A^{-1}A_{-1}x \in D(A)$. Hence, $Fav(\mathbf{S}) = D(A)$ since the other inclusion holds trivially. \square

Note that the assumption of L^{∞}-admissibility in Theorem 2.6 cannot be relaxed to C-admissibility; see Example 2.3 where $Fav(\mathbf{S}) \neq D(A)$, which can be checked directly, or by Theorem 2.9 below.

For what follows it will be crucial to use the sun-dual space

$$X^{\odot} = \{x^* \in X^* : \lim_{t \to 0^+} \|S^*(t)x^* - x^*\| = 0\}$$

associated with the semigroup S and which is a closed subspace of X^* . This allows us to define the following norm,

$$|||x||| = \sup_{x^{\odot} \in X^{\odot}, ||x^{\odot}||_{X^{*}} \le 1} |\langle x, x^{\odot} \rangle|, \quad x \in X,$$

$$(2.1)$$

which is known to be equivalent to $\|\cdot\|$ on X, see e.g. [42, p. 7]. Furthermore, it is clear that the mapping

$$j: X \to X^{\odot *}, x \mapsto (x^{\odot} \mapsto \langle x^{\odot}, x \rangle)$$
 (2.2)

is an isometry when X is equipped with $|||\cdot||||$. Note that j is in general not isometric when the norm $||\cdot||$ is considered on X. However, if $X^{\odot} = X^*$, then j equals the canonical isometry from X in its bidual.

By a result due to van Neerven, [43, Theorem 3.2], see also [42, Theorem 3.2.9], the property that $Fav(\mathbf{S}) = D(A)$ is equivalent to the condition that the set $R(\lambda, A)K_{(X,|||\cdot|||)}$ is closed in X for some (hence all) $\lambda \in \rho(A)$, where $K_{(X,|||\cdot|||)}$ refers to $\{x \in X : |||x||| \le 1\}$. We will employ this fact in the following. We emphasize that the use of the $|||\cdot|||$ -norm is crucial here as the corresponding statement involving the $||\cdot||$ -norm does not hold in general, see [42, Example 3.2.11].

It is not hard to see that $Fav(\mathbf{S}) = D(A)$ is satisfied for all semigroups

whenever X is reflexive, see e.g. [42] and [22, Corollary II.5.21]. This also shows that the converse of Theorem 2.6 is not true. Furthermore, the case $X = c_0$ is special as $Fav(\mathbf{S}) = D(A)$ implies that \mathbf{S} is uniformly continuous then, [42, Theorem 3.2.10]. The latter result rests on non-trivial fact of the geometry on c_0 , which, loosely speaking, guarantees that a given operator $R: c_0 \to Y$, with some arbitrary Banach space Y, is an isomorphism under comparably little information on R. To make this more explicit, let us introduce the following notions, which will be used subsequently.

Definition 2.7 (Semi-embeddings and G_{δ} -embeddings). Let X and Y be Banach spaces. An injective bounded linear operator $R: X \to Y$ is called

- a semi-embedding if $R(\{x \in X : ||x|| \le 1\})$ is closed in Y; or
- a G_{δ} -embedding if R(M) is a G_{δ} -set for any closed bounded set M in X.

Semi-embeddings were first studied by Lotz, Peck and Porta in [34] and further investigated by Bourgain and Rosenthal in [9], who introduced the notion of a G_{δ} -embedding. The latter was partially motivated by the fact that the property of R being a semi-embedding is neither inherited by restrictions to closed subspaces nor invariant under isomorphisms. We collect the following facts for later reference.

Lemma 2.8 (Bourgain–Rosenthal [9]). Let X, Y be Banach spaces and $R \in \mathcal{L}(X,Y)$. Then the following assertions hold.

- (1) If R is a semi-embedding and X is separable then R is a G_{δ} -embedding.
- (2) If R is a G_{δ} -embedding, then $R|_Z: Z \to Y$ and RS are G_{δ} -embeddings, for any closed subspace $Z \subset X$ and any isomorphism $S: W \to X$.
- (3) If $X = c_0$ and R is a G_{δ} -embedding, then R is bounded from below, i.e. there exists C > 0 such that

$$||Rx|| \geqslant C||x||, \qquad x \in X.$$

The proofs of (1) and (3) can be found in [9, Prop. 1.8 and Prop. 2.2]. The other assertion is clear by definition.

We are now able to prove our main result.

Theorem 2.9. Let S be a strongly continuous semigroup on a Banach space X with generator A. Then the following assertions are equivalent

- (1) A_{-1} is L^{∞} -admissible,
- (2) Fav(S) = D(A) and S satisfies C-maximal-regularity,
- (3) A is a bounded operator.

Proof. The implication $(3)\Rightarrow(1)$ is clear as admissibility of $A_{-1}=A$ is trivial when A is bounded. Furthermore, $(1)\Rightarrow(2)$ follows by Theorem 2.6 and since L^{∞} -admissibility implies C-admissibility of A_{-1} which is equivalent to S satisfying C-maximal-regularity, Proposition 2.2.

Hence, it remains to show $(2)\Rightarrow(3)$. We assume that $Fav(\mathbf{S}) = D(A)$ and that **S** satisfies C-maximal-regularity. Suppose that A is unbounded. Thus we may consider the Baillon space Z as given in Proposition 2.5. Let \tilde{Z} be

the smallest closed S-invariant subspace containing Z. Since

$$\tilde{Z} = \overline{\{S(t)z \colon z \in Z, t \ge 0\}},$$

it is easy to see that \tilde{Z} is separable, since Z is separable. Let $\tilde{\mathbf{S}}$ denote the restricted semigroup on \tilde{Z} whose generator \tilde{A} is given by $D(\tilde{A}) = D(A) \cap \tilde{Z}$ and $\tilde{A}z = Az$ for $z \in D(\tilde{A})$. Since by assumption $D(A) = Fav(\mathbf{S})$, it holds that $D(\tilde{A}) = Fav(\tilde{\mathbf{S}})$ and thus, by [42, Theorem 3.2.9], $R(\lambda, \tilde{A})K = R(\lambda, A)K$ is $\|\cdot\|$ -norm-closed in X, where $K = \{x \in \tilde{Z} : |||x||| \leq 1\}$. Therefore, $R(\lambda, A)|_{\tilde{Z}}$ is a semi-embedding from the separable space $(\tilde{Z}, |||\cdot|||)$ to X and, hence, a G_{δ} -embedding by Lemma 2.8(1). Since the property of being a G_{δ} -embedding is inherited by restrictions on closed subspaces and invariant under isomorphisms, Lemma 2.8(2), we infer that also $R(\lambda, A)|_{Z} : Z \to X$ is a G_{δ} -embedding, where Z is now equipped with the norm $\|\cdot\|$, which is equivalent to $|||\cdot|||$. Since Z is isomorphic to c_0 , we conclude by Bourgain–Rosenthal, Lemma 2.8(3) and 2.8(2), that $R(\lambda, A)|_{Z}$ is bounded from below. Hence, there exists a constant C > 0 such that

$$||R(\lambda, A)x|| \geqslant C||x||, \qquad x \in Z.$$

This, however, contradicts the property of a Baillon space that $R(\lambda, A)z_n$ tends to 0 as $n \to \infty$, Proposition 2.5(4), where $(z_n)_{n \in \mathbb{N}}$ is the sequence spanning Z, for which it holds that $\inf_n ||z_n|| > 0$, Proposition 2.5(3).

In the study of adjoint semigroups (on non-reflexive spaces), the notion of sun-reflexivity—linking the space and the semigroup—is classical. Recall that X is sun-reflexive (or " \odot -reflexive") for a given strongly continuous semigroup \mathbf{S} on X if the isometry j defined in (2.2) maps X onto $X^{\odot\odot} = (X^{\odot})^{\odot}$. Obviously, if X is reflexive, then X is sun-reflexive with respect to any strongly continuous semigroup \mathbf{S} on X. Also note that by de Pagter's result [17], sun-reflexivity can be reformulated by the condition that the resolvent is weakly compact. In the following we show that if X is non-reflexive, but sun-reflexive with respect to \mathbf{S} , then A_{-1} cannot be L^{∞} -admissible.

Corollary 2.10. Let **S** be a strongly continuous semigroup such that X is sun-reflexive. If A_{-1} is L^{∞} -admissible, then A is bounded and X is reflexive.

Proof. By Theorem 2.9, we only have to show that X is reflexive. This, however, is clear since **S** is uniformly continuous which implies that $X^{\odot \odot} = X^{**}$ and that j defined in (2.2) equals the canonical embedding of X in X^{**} .

We point out that Corollary 2.10 can also be proved without referring to Theorem 2.9. Indeed, by Theorem 2.6, we know that $Fav(\mathbf{S}) = D(A)$. Since X is sun-reflexive, this fact together with [42, Theorem 6.2.14] implies that X must have the Radon-Nikodym property. Now A must be bounded because otherwise Baillon's theorem shows that X contains c_0 which contradicts that X has the Radon-Nikodym property. That X is reflexive now follows in the same way as in the other proof of the corollary.

3. Comments on the discrete-time case

The study of discrete-time versions of maximal regularity was initiated by Blunck [7, 8] and, with a focus on the extremal cases ℓ^{∞} and ℓ^{1} , further studied by Kalton and Portal in [37] and [30]. For a power-bounded operator $T \in \mathcal{L}(X)$, we consider the solutions to

$$x_n = Tx_{n-1} + Bu_n, \qquad n \in \mathbb{N},$$

$$x_0 = 0,$$
(3.1)

where $(u_n)_{n\in\mathbb{N}}$ is in $\ell^{\infty}(\mathbb{N},X)$, the space of X-valued bounded sequences.

Definition 3.1 (discrete-time admissibility). Let $T \in \mathcal{L}(X)$ be power-bounded, and $p \in [1, \infty]$. We say that $B \in \mathcal{L}(U, X)$ is an ℓ^p -admissible control operator for T if there exists $\kappa > 0$ such that

$$\left\| \sum_{k=1}^{n} T^{n-k} B u_k \right\| \leqslant \kappa \|u\|_{\ell^p(\{1,\dots,n\},U)}, \quad \forall n \in \mathbb{N}, u \in \ell^p(\mathbb{N},U).$$

Furthermore, $C \in \mathcal{L}(X,Y)$ is called an ℓ^p -admissible observation operator for T if there exists $\tilde{\kappa} > 0$ such that

$$\left\| \left(CT^k x \right)_{k \in \mathbb{N}} \right\|_{\ell^p(\mathbb{N}, X)} \leqslant \tilde{\kappa} \|x\|, \qquad x \in X.$$

We will always explicitly state whether an operator is ℓ^p -admissible as observation or control operator in order to avoid confusion. This is contrast to the notation Section 2, where this was clear from the context.

Remark 3.2. • Note that by a uniform boundedness principle argument, if $p \in [1, \infty)$, an operator $B \in \mathcal{L}(U, X)$ is an ℓ^p -admissible control operator if and only if the limit $\lim_{n\to\infty} \sum_{k=1}^n T^{n-k} Bu_k$ exists and

$$\left\| \lim_{n \to \infty} \sum_{k=1}^n T^{n-k} B u_k \right\| \leqslant \kappa \|u\|_{\ell^p}, \quad u \in \ell^p(\mathbb{N}, X).$$

For $p = \infty$, an analogous statement holds with ℓ^{∞} replaced by c_0 .

• Comparing the definitions of discrete-time and continuous-time admissibility leads to the following observation. Whereas our definition for continuous-time deals with fixed (and finite) times $\tau > 0$, the property in the discrete case is connected to uniform estimates in n. We point out that, without loss of generality, we could have restricted ourselves to infinite-time admissible operators in Section 2 as well.

On the other hand, the operator T is said to satisfy ℓ^p -maximal regularity for $p \in [1, \infty]$ if for B = I the solution $(x_n)_{n \in \mathbb{N}}$ to (3.1) satisfies

$$(x_n - x_{n-1})_{n \in \mathbb{N}} \in \ell^p(\mathbb{N}, X), \quad \forall (u_n)_{n \in \mathbb{N}} \in \ell^p(\mathbb{N}, X).$$

Note that this is equivalent to the existence of some constant $\kappa > 0$ such that

$$\left\| \left(\sum_{k=1}^{n} T^{n-k} (I-T) u_k \right)_{n \in \mathbb{N}} \right\|_{\ell^p(\mathbb{N}, X)} \leqslant \kappa \|u\|_{\ell^p(\mathbb{N}, X)}, \quad u \in \ell^p(\mathbb{N}, X). \quad (3.2)$$

The following result was implicitly shown in [30] without using the notion of admissibility.

Proposition 3.3. Let $T \in \mathcal{L}(X)$ be power-bounded. Then the following assertions are equivalent.

- (1) T satisfies ℓ^{∞} -maximal regularity,
- (2) T^* satisfies ℓ^1 -maximal regularity,
- (3) I-T is an ℓ^{∞} -admissible control operator,
- (4) $I T^*$ is an ℓ^1 -admissible observation operator.

Proof. The equivalences $(1)\Leftrightarrow(2)\Leftrightarrow(4)$ follow from [30, Proposition 2.3 and Theorem 3.1]. The proof of $(1)\Leftrightarrow(3)$ is clear from the definitions.

The duality in Proposition 3.3 between maximal-regularity and admissibility with respect to ℓ^1 and ℓ^{∞} may come as a surprise when compared to the continuous-time situation, where such a result does not hold. The reason for this rests on the fact that there is no difference between c_0 -maximal regularity (replacing ℓ^{∞} by c_0 in (3.2)) and ℓ^{∞} -maximal regularity.

In [30, Theorem 3.5] Kalton and Portal show a version of Baillon's result for discrete-time. More precisely, they prove that if X does not contain c_0 and T satisfies ℓ^{∞} -maximal regularity, then $X = X_1 + X_2$ for T-invariant closed subspaces X_1 and X_2 such that $T|_{X_1} = I_{X_1}$ and $r(T|_{X_2}) < 1$, where $r(\cdot)$ refers to the spectral radius. The following example demonstrates that the assumption on X cannot be dropped and an analogous result as Theorem 2.9 does not hold in the discrete-time case.

Example 3.4. Let $X = c_0(\mathbb{N})$ and let $(e_n)_{n \in \mathbb{N}}$ refer to the canonical basis. It is easy to see that the operator T defined by $Ty = \sum_{m=1}^{\infty} (1 - \frac{1}{m}) y_m e_m$ for $y = \sum_{n=1}^{\infty} y_n e_n$, satisfies ℓ^{∞} -maximal regularity. Indeed, to see this, let $x_k = \sum_{m=1}^{\infty} x_{k,m} e_m \in X$ and consider, for $n \in \mathbb{N}$,

$$\left\| \sum_{k=1}^{n} T^{n-k} (I - T) x_{k} \right\| = \left\| \sum_{k=1}^{n} \sum_{m=1}^{\infty} \left(1 - \frac{1}{m} \right)^{n-k} \frac{1}{m} x_{k,m} e_{m} \right\|$$

$$= \sup_{m} \frac{1}{m} \left| \sum_{k=1}^{n} \left(1 - \frac{1}{m} \right)^{n-k} x_{k,m} \right|$$

$$\leqslant \sup_{k=1,\dots,n} \|x_{k}\|.$$

On the other hand, it is obvious that there is no decomposition of X into T-invariant closed subspaces X_1 and X_2 such that $T|_{X_1} = I$ and such that the spectral radius of $T|_{X_2}$ is less than 1.

4. An alternative proof for Theorem 2.9

We sketch an alternative argument for showing Theorem 2.9 which avoids the notion of G_{δ} -embeddings and the fact that $Fav(\mathbf{S}) = D(A)$ under the additional assumption that the dual semigroup \mathbf{S}^* is strongly continuous. The key is the following lemma which can be proved by carefully studying Baillon's space.

Lemma 4.1. Let **S** be a strongly continuous semigroup with unbounded generator A. Suppose that A_{-1} is L^{∞} -admissible and let $(z_n)_{n\in\mathbb{N}}$ be the elements spanning the Baillon space Z from Proposition 2.5. Then $\sum_{n=1}^{\infty} z_n$ converges to an element $z \in X$ in the norm $||R(\lambda, A) \cdot ||$, i.e.

$$\lim_{N \to \infty} R(\lambda, A) \sum_{n=1}^{N} z_n = R(\lambda, A) z$$
(4.1)

for $\lambda \in R(\lambda, A)$.

Alternative proof of Theorem 2.9, (2) \Longrightarrow (3), if \mathbf{S}^* is strongly continuous. As in the main proof of the theorem, we suppose by contradiction that A is unbounded. Observe that (4.1) from Lemma 4.1 implies that the series $\sum_{n=1}^{\infty} z_n$ converges to z in the $\sigma(X, X^*)$ -topology since $X^* = X^{\odot}$ by the assumption that \mathbf{S}^* is strongly continuous. Indeed, this follows easily from the fact that for all $f \in X^*$,

$$\langle \sum_{n=1}^{N} z_n, R(\lambda, A)^* f \rangle \to \langle R(\lambda, A) z, f \rangle, \qquad N \to \infty,$$

and the fact that $(\sum_{n=1}^N z_n)_{N\in\mathbb{N}}$ is bounded. Therefore, $z\in Z$ since Z is weakly-closed as a norm-closed space. Finally, let $f_n:Z\to\mathbb{C}$ denote the coefficient functionals of the Schauder basis $(z_n)_{n\in\mathbb{N}}$ of Z, which can be continuously extended to functionals on X by the Hahn-Banach theorem. It follows that for fixed $n\in\mathbb{N}$,

$$f_n\left(\sum_{m=1}^N z_m\right) = \langle \sum_{m=1}^N z_m, f_n \rangle \to f_n(z), \qquad (N \to \infty),$$

which implies that $f_n(z) = 1$ for all $n \in \mathbb{N}$. This contradicts $z \in \mathbb{Z}$.
