# Integral formulas for a Riemannian manifold with several orthogonal complementary distributions

#### Abstract

In the paper we prove integral formulae for a Riemannian manifold endowed with $k>2$ orthogonal complementary distributions, which generalize well-known formula for $k=2$, and give applications to splitting and isometric immersions of Riemannian manifolds, in particular, multiply warped products, and to hypersurfaces with $k>2$ distinct principal curvatures of constant multiplicities.


Keywords: Almost $k$-product manifold, distribution, foliation, mean curvature vector, mixed scalar curvature, isometric immersion, multiply warped product, Dupin hypersurface

## Introduction

Distributions on a manifold (i.e., subbundles of the tangent bundle) are used to build up notions of integrability, and specifically of a foliated manifold. Distributions and foliations on Riemannian manifolds appear in various situations, e.g., [3, 9, 13], among them warped products are fruitful generalizations of the direct product playing important role in mathematics and physics, e.g., [7].

Integral formulae are useful for many problems in the theory of foliations, e.g. [2, 13, 17]:
a) the existence and characterizing of foliations, whose leaves have a given geometric property;
b) prescribing the higher mean curvatures of the leaves of a foliation;
c) minimizing functionals like volume and energy defined for tensor fields on a manifold.

The first known integral formula for a closed Riemannian manifold endowed with a codimension one foliation tells us that the integral mean curvature of the leaves vanishes, see [12]. The second formula in the series of total $\sigma_{k}$ 's - elementary symmetric functions of principal curvatures of the leaves - says that for a codimension one foliation with a unit normal $N$ to the leaves the total $\sigma_{2}$ is a half of the total Ricci curvature in the $N$-direction, e.g., [2]:

\int_{M}\left(2 \sigma_{2}-\operatorname{Ric}_{N, N}\right) \mathrm{d} \mathrm{vol}=0, \tag{1}
\end{equation*}

which is a consequence of Stokes' theorem applied to $\nabla_{N} N+\sigma_{1} N$. One can see directly that (11) implies nonexistence of totally umbilical foliations on a closed manifold of negative curvature: if the integrand is strictly positive, so is the value of the integral. The mixed scalar curvature $\mathrm{S}_{\text {mix }}$ is one of the simplest curvature invariants of a pseudo-Riemannian almost-product structure, which can be defined as an averaged sum of sectional curvatures of planes that non-trivially intersect with both of the distributions. The following integral formula for a closed Riemannian manifold ( $M, g$ ) endowed with two complementary orthogonal distributions, see [17] (and 11] for foliations), generalizes (1) and has many interesting global corollaries (e.g., decomposition criteria using the sign of the mixed scalar curvature, [14):

\int_{M}\left(\mathrm{~S}_{\text {mix }}+\left\|h_{1}\right\|^{2}+\left\|h_{2}\right\|^{2}-\left\|H_{1}\right\|^{2}-\left\|H_{2}\right\|^{2}-\left\|T_{1}\right\|^{2}-\left\|T_{2}\right\|^{2}\right) \mathrm{d} \operatorname{vol}_{g}=0 . \tag{2}
\end{equation*}
$$

[^0]Here and $h_{i}, H_{i}=\operatorname{Tr}_{g} h_{i}$ and $T_{i}$ are the second fundamental form, the mean curvature vector field and the integrability tensor of distributions $\mathcal{D}_{1}$ and $\mathcal{D}_{2}$ on $(M, g)$. The formula (2) was obtained by calculation of the divergence of the vector field $H_{1}+H_{2}$,

\operatorname{div}\left(H_{1}+H_{2}\right)=\mathrm{S}_{\mathrm{mix}}+\left\|h_{1}\right\|^{2}+\left\|h_{2}\right\|^{2}-\left\|H_{1}\right\|^{2}-\left\|H_{2}\right\|^{2}-\left\|T_{1}\right\|^{2}-\left\|T_{2}\right\|^{2} \tag{3}
\end{equation*}

and then applying Stokes' theorem.
Recently, the notion of warped products was naturally extended to multiply warped products, e.g., [7]. The notion of multiply warped product, in turn, is a special case of a Riemannian almost $k$-product structure with $k \in\{2, \ldots, n\}$ foliations. This structure can be also viewed in the theory of webs composed of foliations of different dimensions, see [1]. A Riemannian almost $k$-product structure appears also on a proper Dupin hypersurface of a real space-form, i.e., the number $k$ of distinct principal curvatures is constant and each principal curvature function is constant along its corresponding surface of curvature, see [6].

Thus, the problem of generalizing (2) to the case of $(M, g)$ with $k>2$ distributions is actual. In Section 1, we solve this problem for arbitrary $k>2$. In Sections 2 and 3 we give applications to splitting and isometric immersions of manifolds, in particular, multiply warped products, and to hypersurfaces with $k>2$ distinct principal curvatures of constant multiplicities.

## 1 New integral formulas

Let an $n$-dimensional Riemannian manifold $(M, g)$ with the Levi-Civita connection $\nabla$ and the curvature tensor $R$ be endowed with $k>2$ orthogonal $n_{i}$-dimensional distributions $\mathcal{D}_{i}(1 \leq i \leq k)$ with $\sum n_{i}=\operatorname{dim} M$. There exists on $M$ a local adapted orthonormal frame $\left\{E_{1}, \ldots, E_{n}\right\}$, where

$$
\left\{E_{1}, \ldots, E_{n_{1}}\right\} \subset \mathcal{D}_{1}, \quad\left\{E_{n_{i-1}+1}, \ldots, E_{n_{i}}\right\} \subset \mathcal{D}_{i}, \quad 2 \leq i \leq k
$$

Such $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ is called a Riemannian almost $k$-product manifold, see [9] for $k=2$. A plane in $T M$ spanned by two vectors belonging to different distributions, say, $\mathcal{D}_{i}$ and $\mathcal{D}_{j}$ is called mixed. We will generalize the well-known concept of almost-product manifolds.

Definition 1. The function on $(M, g)$ with $k \geq 2$ non-degenerate distributions,

\begin{equation*}
\mathrm{S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)=\sum_{i<j} \mathrm{~K}\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right) \tag{4}
\end{equation*}
$$

will be called the mixed scalar curvature of $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$, where

$$
\mathrm{K}\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right)=\sum_{n_{i-1}<a \leq n_{i}, n_{j-1}<b \leq n_{j}}\left\langle R\left(E_{a}, E_{b}\right) E_{a}, E_{b}\right\rangle, \quad i \neq j
$$

Let $P_{i}: T M \rightarrow \mathcal{D}_{i}$ be the orthoprojector, and $\widehat{P}_{i}=\mathrm{id}_{T M}-P_{i}$ be the orthoprojector onto $\mathcal{D}_{i}^{\perp}$. The second fundamental form $h_{i}: \mathcal{D}_{i} \times \mathcal{D}_{i} \rightarrow \mathcal{D}_{i}^{\perp}$ (symmetric) and the integrability tensor $T_{i}: \mathcal{D}_{i} \times \mathcal{D}_{i} \rightarrow \mathcal{D}_{i}^{\perp}$ (skew-symmetric) of $\mathcal{D}_{i}$ are defined by

h_{i}(X, Y)=\frac{1}{2} \widehat{P}_{i}\left(\nabla_{X} Y+\nabla_{Y} X\right), \quad T_{i}(X, Y)=\frac{1}{2} \widehat{P}_{i}\left(\nabla_{X} Y-\nabla_{Y} X\right)=\frac{1}{2} \widehat{P}_{i}[X, Y]
$$

Let $h_{i j}, H_{i j}=\operatorname{Tr}_{g} h_{i j}, T_{i j}$ be the second fundamental forms, mean curvature vector fiels and the integrability tensors of distributions $\mathcal{D}_{i, j}=\mathcal{D}_{i} \oplus \mathcal{D}_{j}$ in $M$, and $P_{i j}: T M \rightarrow \mathcal{D}_{i, j}$ be orthoprojectors, etc. Note that

$$
H_{i}=\sum_{j \neq i} P_{j} H_{i}, \quad H_{1 \ldots r}=P_{r+1 \ldots k}\left(H_{1}+\ldots+H_{r}\right), \quad \text { etc. }
$$

Recall that a distribution $\mathcal{D}_{i}$ is called integrable if $T_{i}=0$, and $\mathcal{D}_{i}$ is called totally umbilical, harmonic, or totally geodesic, if $h_{i}=\left(H_{i} / n_{i}\right) g, H_{i}=0$, or $h_{i}=0$, respectively.

Let $S(r, k)$ be the set of all $r$-combinations (i.e., subsets of $r$ distinct elements) of $\{1, \ldots, k\}$. The $S(r, k)$ contains $C_{k}^{r}=\frac{k!}{r!(k-r)!}$ elements (where $C_{k}^{r}$ denote binomial coefficients). For example, $S(k-1, k)$ contains $k$ elements. For any $\boldsymbol{q} \in S(r, k)$ we may assume $q_{1}<\ldots<q_{r}$. Set $h_{\boldsymbol{q}}=h_{q_{1}, \ldots, q_{r}}$ and $T_{\boldsymbol{q}}=T_{q_{1}, \ldots, q_{r}}$.

Our main goal is the following formula for $k \in\{2, \ldots, n\}$, which generalizes (3)).

Theorem 1. For a Riemannian almost $k$-product manifold $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ we have

$$
\begin{equation*}
\operatorname{div} X=2 \mathrm{~S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}-\left\|T_{\boldsymbol{q}}\right\|^{2}\right), \tag{5}
\end{equation*}
$$

where $X=\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)} H_{\boldsymbol{q}}$.
Proof. For $k=2$ we have (3). To illustrate the proof for $k>2$, first consider the case of $k=3$. Using (3) for the distributions $\mathcal{D}_{1}$ and $\mathcal{D}_{1}^{\perp}=\mathcal{D}_{2} \oplus \mathcal{D}_{3}$, we get

$$
\begin{equation*}
\operatorname{div}\left(H_{1}+H_{23}\right)=2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \mathcal{D}_{1}^{\perp}\right)+\left(\left\|h_{1}\right\|^{2}-\left\|H_{1}\right\|^{2}-\left\|T_{1}\right\|^{2}\right)+\left(\left\|h_{23}\right\|^{2}-\left\|H_{23}\right\|^{2}-\left\|T_{23}\right\|^{2}\right), \tag{6}
\end{equation*}
$$

and similarly for $\left(\mathcal{D}_{2}, \mathcal{D}_{2}^{\perp}\right)$ and $\left(\mathcal{D}_{3}, \mathcal{D}_{3}^{\frac{1}{3}}\right)$. Summing 3 copies of (6), we obtain (5) for $k=3$ :

$$
\begin{align*}
& \operatorname{div}\left(\sum_{i} H_{i}+\sum_{i<j} H_{i j}\right)=2 \mathrm{~S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \mathcal{D}_{2}, \mathcal{D}_{3}\right) \\
& +\sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}-\left\|T_{i}\right\|^{2}\right)+\sum_{i<j}\left(\left\|h_{i j}\right\|^{2}-\left\|H_{i j}\right\|^{2}-\left\|T_{i j}\right\|^{2}\right) . \tag{7}
\end{align*}
$$

Next, for arbitrary $k>2$, we apply (3) for pairs of distributions $\left(\mathcal{D}_{i}, \mathcal{D}_{i}^{\perp}\right)$ and get $k$ equalities. Summing these equations and using Lemma 1 below, we get (5).

Lemma 1. We have

$$
2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)=\sum_{i} \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{i}, \mathcal{D}_{i}^{\perp}\right)
$$

Proof. This directly follows from definitions (4).
Remark 1. Just the particular case of (5) for $k=3$, see (7), can find many geometrical applications, because an almost 3 -product structure appears naturally in several topics:

1) almost para- $f$-manifolds, e.g., (15).
2) lightlike manifolds, i.e., $(M, g)$ with degenerate metric $g$ of constant rank and index, see [8].

3 ) on orientable 3 -manifolds, since they admits 3 linearly independent vector fields, i.e., $n_{i}=1$.
4) the theory of 3 -webs composed of three generic foliations of different dimensions, e.g., [16].
5) minimal hypersurfaces in the sphere with 3 distinct principal curvatures, see [10.
6) tubes over a standard embeddings of a projective plane $F P^{2}$, for $F=\mathbb{R} ; \mathbb{C} ; \mathbb{H}$ or $\mathbb{O}$ (Cayley numbers), in $S^{4} ; S^{7} ; S^{13}$, and $S^{25}$, respectively, see [6].

Example 1. For $k=4$ (next to $k=2,3$ ), formula (5) reads as

\begin{aligned}
& \operatorname{div}\left(\sum_{i} H_{i}+\sum_{i<j<s} H_{i j s}\right)=2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{4}\right) \\
& +\sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}-\left\|T_{i}\right\|^{2}\right)+\sum_{i<j<s}\left(\left\|h_{i j s}\right\|^{2}-\left\|H_{i j s}\right\|^{2}-\left\|T_{i j s}\right\|^{2}\right)
\end{aligned}
$$

Using Stokes' theorem for (5) on a closed manifold ( $M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}$ ) yields the novel integral formula for any $k \in\{2, \ldots, n\}$, which for $k=2$ coincides with (2).

Corollary 1. On a closed Riemannian almost $k$-product manifold we have

$$
\begin{equation*}
\int_{M}\left(2 \mathrm{~S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}-\left\|T_{\boldsymbol{q}}\right\|^{2}\right)\right) \mathrm{d} \operatorname{vol}_{g}=0 \tag{8}
\end{equation*}
$$

Example 2. For few initial values of $k, k=3,4$, the integral formula (8) reads as follows:

$$
\begin{aligned}
& \int_{M}\left(2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \mathcal{D}_{2}, \mathcal{D}_{3}\right)+\sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}-\left\|T_{i}\right\|^{2}\right)+\sum_{i<j}\left(\left\|h_{i j}\right\|^{2}-\left\|H_{i j}\right\|^{2}-\left\|T_{i j}\right\|^{2}\right)\right) \mathrm{d} \operatorname{vol}_{g}=0, \\
& \int_{M}\left(2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{4}\right)+\sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}-\left\|T_{i}\right\|^{2}\right)+\sum_{i<j<s}\left(\left\|h_{i j s}\right\|^{2}-\left\|H_{i j s}\right\|^{2}-\left\|T_{i j s}\right\|^{2}\right)\right) \mathrm{d} \operatorname{vol}_{g}=0,
\end{aligned}
$$

In order to simplify the LHS of (5) to the shorter view $\operatorname{div}\left(\sum_{i} H_{i}\right)$, we reorganize the terms $\operatorname{div}\left(\sum_{\boldsymbol{q} \in S(k-1, k)} H_{\boldsymbol{q}}\right)$ for $r>1$ and obtain new (auxiliary) integral formulae.

Theorem 2. For $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ and any $r \in\{2, \ldots, k-1\}$, we have

$$
\begin{equation*}
\operatorname{div} X=\sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|H_{\boldsymbol{q}}\right\|^{2}+\left\langle\sum_{i=1}^{r} H_{q(i)}-r H_{\boldsymbol{q}}, \sum_{j \notin \boldsymbol{q}} H_{j}\right\rangle\right) \tag{9}
\end{equation*}
$$

where $X=\sum_{\boldsymbol{q} \in S(r, k)} H_{\boldsymbol{q}}-C_{k-2}^{r-1} \sum_{i} H_{i}$.
Proof. Using equality $H_{1 \ldots r}=P_{r+1 \ldots k}\left(H_{1}+\ldots+H_{r}\right)$ for $\boldsymbol{q}=\{1, \ldots, r\}$, we find

$$
\begin{aligned}
\operatorname{div} H_{1 \ldots r} & =\operatorname{div}_{r+1 \ldots k} H_{1 \ldots r}-\left\|H_{1 \ldots . r}\right\|^{2} \\
& =\operatorname{div}_{r+1 \ldots k}\left(H_{1}+\ldots+H_{r}\right)+\left\langle H_{1}+\ldots+H_{r}, H_{r+1 \ldots k}\right\rangle-\left\|H_{1 \ldots r}\right\|^{2},
\end{aligned}
$$

and similarly for all $C_{k}^{r}$ cases of $\boldsymbol{q} \in S(r, k)$. Summing the above, we use equalities

$$
\operatorname{div}_{r+1 \ldots k} H_{1}=\sum_{j>r} \operatorname{div}_{j} H_{1}, \quad \operatorname{div}_{2 \ldots k} H_{1}=\operatorname{div} H_{1}+\left\|H_{1}\right\|^{2}, \quad \text { etc. }
$$

We apply (9) with $k-1$ for the distributions $\mathcal{D}_{1}, \ldots, \mathcal{D}_{k-2}$ and $\mathcal{D}_{k-1, k}$, and then obtain similar formulas for other choices of a pair of distributions. Summing these $C_{k}^{2}$ equations, we get equation of the form (9) with $k$, comparing coefficients yield the claim.

Corollary 2. The following integral formulae for $r \in\{2, \ldots, k-1\}$ take place on a closed Riemannian almost $k$-product manifold:

\begin{equation*}
\int_{M} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|H_{\boldsymbol{q}}\right\|^{2}+\left\langle\sum_{i=1}^{r} H_{q(i)}-r H_{\boldsymbol{q}}, \sum_{j \notin \boldsymbol{q}} H_{j}\right\rangle\right) \mathrm{d} \operatorname{vol}_{g}=0 . \tag{10}
\end{equation*}
$$

Example 3. For $k=3$ and $r=2$, the formula (10) reads as

$$
\int_{M}\left(\sum_{i}\left\|H_{i}\right\|^{2}+\sum_{i<j}\left(2\left\langle H_{i}, H_{j}\right\rangle-\left\|H_{i j}\right\|^{2}\right)\right) \mathrm{d} \operatorname{vol}_{g}=0
$$

and for $k=4$ and $r=2$, the formula (10) reads as

$$
\int_{M}\left(2 \sum_{i}\left\|H_{i}\right\|^{2}+\sum_{i, j<s}\left\langle H_{i}, H_{j s}\right\rangle-\sum_{i<j}\left\|H_{i j}\right\|^{2}\right) \mathrm{d} \operatorname{vol}_{g}=0
$$

The reader can easily find the integral formula corresponding to (10) with $k=4$ and $r=3$.
From Theorem 1 and Theorem 2 for $r=k-1$, we obtain the following companion of (5).
Theorem 3. For a Riemannian almost $k$-product manifold ( $M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}$ ) we have

$$
\begin{aligned}
& 2 \operatorname{div}\left(\sum_{i} H_{i}\right)=2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}-\left\|T_{\boldsymbol{q}}\right\|^{2}\right) \\
& \quad-\sum_{\boldsymbol{q} \in S(k-1, k)}\left(\left\|H_{\boldsymbol{q}}\right\|^{2}+\left\langle\sum_{i=1}^{k-1} H_{q(i)}-(k-1) H_{\boldsymbol{q}}, \sum_{j \notin \boldsymbol{q}} H_{j}\right\rangle\right) .
\end{aligned}
$$

Corollary 3. The following integral formula takes place on a closed $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ :

$$
\begin{aligned}
& \int_{M}\left(2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(k-1, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}-\left\|T_{\boldsymbol{q}}\right\|^{2}\right)\right. \\
& \left.-\sum_{\boldsymbol{q} \in S(k-1, k)}\left(\left\|H_{\boldsymbol{q}}\right\|^{2}+\left\langle\sum_{i=1}^{k-1} H_{q(i)}-(k-1) H_{\boldsymbol{q}}, \sum_{j \notin \boldsymbol{q}} H_{j}\right\rangle\right)\right) \mathrm{d} \mathrm{vol}_{g}=0 .
\end{aligned}
$$

Example 4. For particular case of $k=3$, the integral formula of Corollary 3 reads as

$$
\begin{aligned}
& \int_{M}\left(\mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \mathcal{D}_{2}, \mathcal{D}_{3}\right)-\sum_{i}\left\|H_{i}\right\|^{2}-\sum_{i<j}\left\langle H_{i}, H_{j}\right\rangle+\frac{1}{2} \sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|T_{i}\right\|^{2}\right)\right. \\
& \left.\quad+\frac{1}{2} \sum_{i<j}\left(\left\|h_{i j}\right\|^{2}-\left\|T_{i j}\right\|^{2}\right)\right) \mathrm{d} \operatorname{vol}_{g}=0
\end{aligned}
$$

The above formula was obtained in [4 by long direct calculations of $\operatorname{div}\left(H_{1}+H_{2}+H_{3}\right)$.

## 2 Splitting and isometric immersions of manifolds

Here, we use results of Section 1 to prove some splitting and non-existence of immersions results for Riemannian almost $k$-product manifolds with $k>2$. We say that $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ splits if all distributions $\mathcal{D}_{i}$ are integrable and $M$ is locally the direct product $M_{1} \times \ldots \times M_{k}$ with foliations tangent to $\mathcal{D}_{i}$. Recall that if a simply connected manifold splits then it is the direct product.

We apply the submanifolds theory to Riemannian almost $k$-product manifolds.
Definition 2. A pair $\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right)$ with $i \neq j$ of distributions on $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ with $k>2$ is called
a) mixed totally geodesic, if $h_{i j}(X, Y)=0$ for all $X \in \mathcal{D}_{i}$ and $Y \in \mathcal{D}_{j}$.
b) mixed integrable, if $T_{i j}(X, Y)=0$ for all $X \in \mathcal{D}_{i}$ and $Y \in \mathcal{D}_{j}$.

Lemma 2. If each pair $\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right)$ on $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ with $k>2$ is
a) mixed totally geodesic, then $h_{\boldsymbol{q}}(X, Y)=0 \quad$ b) mixed integrable, then $T_{\boldsymbol{q}}(X, Y)=0$
for all $\boldsymbol{q} \in S(r, k), 2<r<k$ and $X \in \mathcal{D}_{q(1)}, Y \in \mathcal{D}_{q(2)}$.
Proof. This follows by mathematical induction.
The next our results generalize [14, Theorem 6] and [17, Theorem 2] on case $k=2$.
Theorem 4. Let a Riemannian almost $k$-product manifold $\left(M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)$ with $k>2$ has integrable harmonic distributions $\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}$. If $\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right) \geq 0$, and each pair $\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right)$ is mixed integrable, then M splits.

Proof. From the equality $H_{1 \ldots r}=P_{r+1 \ldots k}\left(H_{1}+\ldots+H_{r}\right)$ follows that $H_{i}=0$ for all $i \in\{1, \ldots, k\}$, then $H_{\boldsymbol{q}}=0$ for all $\boldsymbol{q} \in S(r, k)$ and $2 \leq r<k$. Similarly (by Lemma 2), if $T_{i j}=0$ for all $i \in\{1, \ldots, k\}$, then $T_{\boldsymbol{q}}=0$ for all $\boldsymbol{q} \in S(r, k)$ and $2 \leq r<k$. By conditions and (5),

$$
2 \mathrm{~S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}=0\right.
$$

Thus, $h_{\boldsymbol{q}}=0$ for all $\boldsymbol{q} \in S(r, k)$ with $r \in\{1, k-1\}$, in particular, $h_{i}=0(1 \leq i \leq k)$. By wellknown de Rham decomposition theorem, $(M, g)$ splits.

Theorem 5. Let a complete open Riemannian almost $k$-product manifold ( $M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}$ ) with $k>2$ has totally umbilical distributions such that each pair $\left(\mathcal{D}_{i}, \mathcal{D}_{j}\right)$ is mixed totally geodesic and $\left\langle H_{i}, H_{j}\right\rangle=0$ for $i \neq j$. If $\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right) \leq 0$ and $\left\|H_{i}\right\| \in \mathrm{L}^{1}(M, g)$ for $1 \leq i \leq k$, then M splits.

Proof. By assumptions, from (5) we get

$$
\begin{equation*}
\operatorname{div} \xi=2 \mathrm{~S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)+\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left(\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}-\left\|T_{\boldsymbol{q}}\right\|^{2}\right) \tag{11}
\end{equation*}
$$

where $\xi=\sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)} H_{\boldsymbol{q}}$. By conditions, and since $\left\|H_{\boldsymbol{q}}\right\| \leq \sum_{i=1}^{k}\left\|H_{q(i)}\right\|$, we get $\left\|H_{\boldsymbol{q}}\right\| \in \mathrm{L}^{1}(M, g)$. Since $\|\xi\| \leq \sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)}\left\|H_{\boldsymbol{q}}\right\|$, then also $\|\xi\| \in \mathrm{L}^{1}(M, g)$. Next, by conditions, for any $\boldsymbol{q}=(q(1), \ldots, q(r)) \in S(r, k)$ with $r \geq 1$ we have

$$
\left\|h_{\boldsymbol{q}}\right\|^{2}-\left\|H_{\boldsymbol{q}}\right\|^{2}=-\sum_{i=1}^{r} \frac{n_{q(i)}-1}{n_{q(i)}}\left\|\widehat{P}_{\boldsymbol{q}} H_{q(i)}\right\|^{2} \leq 0
$$

where $\widehat{P}_{\boldsymbol{q}}$ is the orthoprojector on the distribution $\bigoplus_{j \notin \boldsymbol{q}} \mathcal{D}_{j}$. Hence, from $\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right) \leq 0$ and (11) we get $\operatorname{div} \xi \leq 0$. By conditions and Lemma 3 below, $\operatorname{div} \xi=0$. Thus, see (11), $\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)=0$ and $T_{i}$ and $h_{i}$ vanish. By de Rham decomposition theorem, $(M, g)$ splits.

Modifying Stokes' theorem on a complete open manifold $(M, g)$ yields the following.

Lemma 3 (see Proposition 1 in [5]). Let $\left(M^{n}, g\right)$ be a complete open Riemannian manifold endowed with a vector field $\xi$ such that $\operatorname{div} \xi \geq 0$. If the norm $\|\xi\|_{g} \in \mathrm{~L}^{1}(M, g)$ then $\operatorname{div} \xi \equiv 0$.
Example 5. Totally umbilical integrable distributions appear on multiply warped products. Let $F_{1}, \ldots, F_{k}$ be $k$ Riemannian manifolds and let $M=F_{1} \times \ldots \times F_{k}$ be their direct product. A multiply warped product $F_{1} \times{ }_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k}$ is $M$ with the metric $g=g_{F_{1}} \oplus u_{2}^{2} g_{F_{2}} \oplus \ldots \oplus u_{k}^{2} g_{F_{k}}$, where $u_{i}: F_{1} \rightarrow(0, \infty)$ for $i=2, \ldots, k$ are smooth functions. Let $\mathcal{D}_{i}$ be the distribution on $M$ obtained from the vectors tangent to (the horizontal lifts of) $F_{i}$, e.g., [7]. The leaves (i.e., tangent to $\mathcal{D}_{i}, i \geq 2$ ) are totally umbilical submanifolds, with

$$
H_{i}=-n_{i} \nabla\left(\log u_{i}\right)
$$

and the fibers (i.e., tangent to $\mathcal{D}_{1}$ ) are totally geodesic submanifolds. Since

$$
\operatorname{div} H_{i}=-n_{i}\left(\Delta u_{i}\right) / u_{i}-\left(n_{i}^{2}-n_{i}\right)\left\|P_{\hat{i}} \nabla u_{i}\right\|^{2} / u_{i}^{2}
$$

where $\Delta=-\operatorname{div} \circ \nabla$ is the Laplacian on $C^{2}\left(F_{1}\right)$, and we have

$$
\begin{equation*}
\mathrm{S}_{\mathrm{mix}}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right)=\sum_{i \geq 2} n_{i}\left(\Delta u_{i}\right) / u_{i} \tag{12}
\end{equation*}
$$

Corollary 4. Let a multiply warped product $(M, g)$ be complete open and $\left\langle H_{i}, H_{j}\right\rangle=0$ for $i \neq j$. If $\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \ldots, \mathcal{D}_{k}\right) \leq 0$ and $\left\|H_{i}\right\| \in \mathrm{L}^{1}(M, g)$ for $1 \leq i \leq k$, then $M$ is the direct product.

The following theorem on isometric immersions of multiply warped products, see [7, Theorem 10.2], is related to the question by B.-Y. Chen: "What can we conclude from an arbitrary isometric immersion of a warped product into a Riemannian manifold with arbitrary codimension?"

Theorem A Let $f: F_{1} \times_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k} \rightarrow \tilde{M}$ be an isometric immersion of a multiply warped product $(M, g):=F_{1} \times_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k}$ into an arbitrary Riemannian manifold. Then

$$
\begin{equation*}
\sum_{i=2}^{k} n_{i}\left(\Delta u_{i}\right) / u_{i} \leq \frac{n^{2}(k-1)}{2 k} H^{2}+n_{1}\left(n-n_{1}\right) \max \tilde{K}, \quad n=\sum_{j=1}^{k} n_{j} \tag{13}
\end{equation*}
$$

where $H^{2}=\langle\underset{\sim}{H}, H\rangle$ is the squared mean curvature of $f, \max \tilde{K}(x)$ is the maximum of the sectional curvature of $\tilde{M}$ restricted to 2-plane sections of the tangent space $T_{x} M$ of $M$ at $x=\left(x_{1}, \ldots, x_{k}\right)$. The equality sign of (13) holds identically if and only if the following two statements hold:

1) $f$ is a mixed totally geodesic immersion satisfying equalities $\operatorname{Tr}_{g} h_{1}=\ldots=\operatorname{Tr}_{g} h_{k}$;
2) at each point $x \in M$, the sectional curvature function $\tilde{K}$ of $\tilde{M}$ satisfies $\tilde{K}(X, Y)=$ $\max \tilde{K}(x)$ for each unit vector $X \in T_{x_{1}}\left(F_{1}\right)$ and each unit vector $Y$ in $T\left(x_{2}, \ldots, x_{k}\right)\left(F_{2} \times \ldots \times F_{k}\right)$.

On a multiply warped product with $k>2$ each pair of distributions is mixed totally geodesic. Indeed, such manifold is diffeomorphic to the direct product and the Lie bracket does not depend on metric. Thus, using Theorem A and our results above, we obtain the following.
Theorem 6 (Non-existence of immersions). Let $f: F_{1} \times_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k} \rightarrow \tilde{M}$ be an isometric immersion of a closed multiply warped product $(M, g):=F_{1} \times_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k}$ into an arbitrary Riemannian manifold. Let, in addition, $\left\langle\underset{\sim}{\underset{\sim}{H}}, H_{j}\right\rangle=0$ for $i \neq j$. Then there are no isometric immersions $f: F_{1} \times_{u_{2}} F_{2} \times \ldots \times_{u_{k}} F_{k} \rightarrow \tilde{M}$ satisfying the inequality

$$
\begin{equation*}
\frac{n^{2}(k-1)}{2 k} H^{2}<-n_{1}\left(n-n_{1}\right) \max \tilde{K} \tag{14}
\end{equation*}
$$

in particular, there are no minimal isometric immersions $f$ when $\tilde{K}<0$.
Proof. From (12), (11) and (13), applying the Stokes' Theorem, we get

$$
\begin{align*}
0 \leq & (1 / 2) \int_{M} \sum_{r \in\{1, k-1\}} \sum_{\boldsymbol{q} \in S(r, k)} \sum_{i=1}^{r} \frac{n_{q(i)}-1}{n_{q(i)}}\left\|\widehat{P}_{\boldsymbol{q}} H_{q(i)}\right\|^{2} \mathrm{~d} \operatorname{vol}_{g} \\
& \leq \frac{n^{2}(k-1)}{2 k} \int_{M} H^{2}{\mathrm{~d} \operatorname{vol}_{g}+n_{1}\left(n-n_{1}\right) \max \tilde{K} \cdot \operatorname{Vol}(M, g)} . \tag{15}
\end{align*}
$$

The equality in (15) holds if and only if conclusions 1)-2) of Theorem $A$ are satisfied. If such isometric immersion exists, then the inequality (14) yields a contradiction

Remark 2. Theorem 6 can be improved replacing max $\tilde{K}$ by $\bar{S}\left(n_{1}, \ldots, n_{k}\right)$ (with certain factor) defined below. Let $L_{i}(i=1,2)$ be two subspaces of $T_{x} \bar{M}$ at some point $x \in \bar{M}$, and $\left\{E_{i}^{\prime}\right\}$ and $\left\{\mathcal{E}_{j}^{\prime}\right\}$ some orthonormal frames of these subspaces. The following quantity:

$$
\bar{S}\left(L_{1}, L_{2}\right)=\sum_{i, j}\left\langle\bar{R}\left(E_{i}^{\prime}, \mathcal{E}_{j}^{\prime}\right) E_{i}^{\prime}, \mathcal{E}_{j}^{\prime}\right\rangle
$$

does not depend on the choice of frames. For any $n_{1}, \ldots, n_{k} \in \mathbb{N}$ with $\sum_{i} n_{i} \leq \operatorname{dim} \bar{M}$, let $\Gamma_{x}\left(n_{1}, \ldots, n_{k}\right)$ be the set of $k$-tuples of pairwise orthogonal subspaces $\left(L_{1}, \ldots, L_{k}\right)$ with $\operatorname{dim} L_{i}=$ $n_{i}(1 \leq i \leq k)$ of $T_{x} \bar{M}$ at some point $x \in \bar{M}$. Set $\bar{S}\left(n_{1}, \ldots, n_{k}\right)=\sup _{x \in \bar{M}} \bar{S}_{x}\left(n_{1}, \ldots, n_{k}\right)$, where

$$
\bar{S}_{x}\left(n_{1}, \ldots, n_{k}\right)=\max \left\{\sum_{i<j} \bar{S}\left(L_{i}, L_{j}\right):\left(L_{1}, \ldots, L_{k}\right) \in \Gamma_{x}\left(n_{1}, \ldots, n_{k}\right)\right\} .
$$

## 3 Hypersurfaces with $k$ distinct principal curvatures

Let $M^{n}$ be a transversely orientable hypersurface in a Riemannian manifold $\bar{M}$. Denote by $A$ the shape operator of $M$ with respect to a unit normal vector field $N$, and let $\lambda_{1} \leq \ldots \leq \lambda_{n}$ be the principal curvatures (eigenvalues of $A$ ) - continuous functions on $M$. If at any point of $M$ all principal curvatures are equal, then $M$ is totally umbilical.

Suppose that there exists $k \geq 2$ distinct principal curvatures $\left(\mu_{i}\right)$ on $M$ of multiplicities $n_{i}$, and let $\mathcal{D}_{i}(1 \leq i \leq k)$ be corresponding eigen-distributions - subbundles of $T M$.

$$
\mu_{1}:=\lambda_{1}=\ldots=\lambda_{n_{1}}<\ldots<\mu_{k}:=\lambda_{n-n_{k}+1}=\ldots=\lambda_{n} .
$$

Such hypersurface is a Riemannian almost $k$-product manifold ( $M, g ; \mathcal{D}_{1}, \ldots, \mathcal{D}_{k}$ ), see Section $\mathbb{1}$.
For a hypersurface $M$ in a Riemannian manifold $\bar{M}(c)$ of constant curvature $c$, it is known the following, see [6]: if $n_{i}>1$ for some $i$, then the function $\mu_{i}: M \rightarrow \mathbb{R}$ is differentiable and $\mathcal{D}_{i}$ is integrable and its leaves are totally umbilical in $\bar{M}(c)$.

The curvature tensor $\bar{R}$ of $\bar{M}(c)$ has the well-known view

$$
\bar{R}(X, Y) Z=c(\langle X, Z\rangle Y-\langle Y, Z\rangle X) .
$$

Denote by $X_{i} \in \mathfrak{X}_{i}$ local unit vector fields on $\mathcal{D}_{i}(i \leq k)$. For the sectional curvature of $M$ we get

$$
\begin{equation*}
K\left(X_{i}, X_{j}\right)=c+\mu_{i} \mu_{j}, \quad i \neq j . \tag{16}
\end{equation*}
$$

Example 6. For a hypersurface $M$ in $\bar{M}(c)$ with $k=2$, using equalities

$$
\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}=n_{i}\left(1-n_{i}\right) \frac{\left\|\nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{j}\right)^{2}}, \quad \mathrm{~S}_{\operatorname{mix}}\left(\mathcal{D}_{1}, \mathcal{D}_{2}\right)=n_{1} n_{2}\left(c+\mu_{1} \mu_{2}\right)
$$

formula (3) can be rewritten in terms of $A$ and $\mu_{i}(i=1,2)$ as follows, see [17:

$$
\begin{equation*}
\operatorname{div}\left(H_{1}+H_{2}\right)=n_{1} n_{2}\left(c+\mu_{1} \mu_{2}\right)+\frac{n_{1}\left(1-n_{1}\right)\left\|\nabla \mu_{1}\right\|^{2}+n_{2}\left(1-n_{2}\right)\left\|\nabla \mu_{2}\right\|^{2}}{\left(\mu_{2}-\mu_{1}\right)^{2}} \tag{17}
\end{equation*}
$$

The next problem was posed by P. Walczak [17]: "To search for formulae analogous to (17) in the case of a hypersurface in $\bar{M}(c)$ of $k>2$ distinct principal curvatures of constant multiplicities". By symmetry of $A$ and the Codazzi equation for a hypersurface in $\bar{M}(c)$,

$$
\begin{equation*}
\left(\nabla_{X} A\right)(Y)=\left(\nabla_{Y} A\right)(X), \tag{18}
\end{equation*}
$$

the following tensor $\mathcal{A}$ of rank 3 is totally symmetric:

$$
\mathcal{A}(X, Y, Z)=\left\langle\left(\nabla_{X} A\right)(Y), Z\right\rangle, \quad X, Y, Z \in \mathfrak{X}_{M} .
$$

Remark 3. A submanifold $M$ in $\bar{M}$ is called curvature-invariant if $R(X, Y) Z \in T_{x} M$ for any $X, Y, Z \in T_{x} M$ and any $x \in M$, e.g., [13]. Examples are arbitrary submanifolds in $\bar{M}(c)$. For a curvature-invariant hypersurface $M \subset \bar{M}$, Codazzi equation (18) is satisfied, thus, results of this section on a hypersurface in $\bar{M}(c)$ can be extended for curvature-invariant hypersurfaces.

Lemma 4. For a hypersurface $M$ in $\bar{M}(c)$ with $k>2$ distinct principal curvatures, we have

$$
\begin{align*}
& \mathcal{A}\left(X_{i}, X_{j}, X_{l}\right)=\left(\mu_{j}-\mu_{l}\right)\left\langle\nabla_{X_{i}} X_{j}, X_{l}\right\rangle, \quad j \neq l, \\
& \mathcal{A}\left(X_{i}, X_{j}, X_{j}\right)=X_{i}\left(\mu_{j}\right), \quad \forall i, j . \tag{19}
\end{align*}
$$

Proof. After derivation of equality $A X_{j}=\mu_{j} X_{j}$ and using symmetry of $A$, we obtain

$$
\begin{aligned}
\left\langle\nabla_{X_{i}}\left(A X_{j}\right), X_{l}\right\rangle & =\left\langle\left(\nabla_{X_{i}} A\right)\left(X_{j}\right), X_{l}\right\rangle+\left\langle A \nabla_{X_{i}} X_{j}, X_{l}\right\rangle \\
& =\mathcal{A}\left(X_{i}, X_{j}, X_{l}\right)+\mu_{l}\left\langle\nabla_{X_{i}} X_{j}, X_{l}\right\rangle, \\
\left\langle\nabla_{X_{i}}\left(\mu_{j} X_{j}\right), X_{l}\right\rangle & =\mu_{j}\left\langle\nabla_{X_{i}} X_{j}, X_{l}\right\rangle+X_{i}\left(\mu_{j}\right) \delta_{j l} .
\end{aligned}
$$

From this equalities in (19) follow.
Corollary 5. For a hypersurface $M$ in $\bar{M}(c)$ with $k>2$ distinct principal curvatures, we have

$$
\begin{equation*}
\left(\mu_{j}-\mu_{l}\right)\left\langle\nabla_{X_{i}} X_{j}, X_{l}\right\rangle=\left(\mu_{i}-\mu_{l}\right)\left\langle\nabla_{X_{j}} X_{i}, X_{l}\right\rangle, \quad i \neq j \neq l . \tag{20}
\end{equation*}
$$

Proof. This follows from (19) and symmetry of $\mathcal{A}$. Alternatively, one can use direct derivation,

$$
\begin{aligned}
0=\left\langle\bar{R}\left(X_{i}, X_{j}\right) N, X_{l}\right\rangle & =\left\langle\mu_{X_{i}}\left(\mu_{j} X_{j}\right)-\nabla_{X_{j}}\left(\mu_{i} X_{i}\right)-\left\langle\left[X_{i}, X_{j}\right], X_{l}\right\rangle\left\langle\mu_{l} X_{l}, X_{l}\right\rangle\right. \\
& =\left(\mu_{j}-\mu_{l}\right)\left\langle\nabla_{X_{i}} X_{j}, X_{l}\right\rangle-\left(\mu_{i}-\mu_{l}\right)\left\langle\nabla_{X_{j}} X_{i}, X_{l}\right\rangle,
\end{aligned}
$$

from which (20) follows.
Theorem 5.13 in [6, which states that each point of a hypersurface $M^{n}$ in $\bar{M}(c)$ with 2, 3, 4 or 6 distinct principal curvatures has a principal coordinate neighborhood if and only if each $\mathcal{D}_{i}^{\perp}$ is integrable. We complete this result by the following.

Proposition 1. Let $M^{n}$ be a hypersurface in $\bar{M}(c)$ with $k>2$ distinct principal curvatures at each point. Then each $\mathcal{D}_{i}^{\perp}$ is integrable if and only if $\mathcal{A}\left(X_{i}, X_{j}, X_{l}\right)=0$ for $X_{i} \in \mathcal{D}_{i}, X_{j} \in \mathcal{D}_{j}$ and $X_{l} \in \mathcal{D}_{l}$ with $i<j<l$ on $M^{n}$.

Next, we study the problem (posed in [17) for $k=3$ (the case of $k>3$ is similar).
Theorem 7. For a hypersurface $M$ in $\bar{M}(c)$ with $k=3$ distinct principal curvatures, we have

$$
\begin{align*}
& \operatorname{div} \sum_{i} n_{i}\left(\frac{P_{j} \nabla \mu_{i}}{\mu_{i}-\mu_{j}}+\frac{P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}\right) \\
& \quad=\frac{1}{2} \sum_{i<j} n_{i} n_{j}\left(c+\mu_{i} \mu_{j}\right)+\sum_{i} n_{i}\left(1-n_{i}\right)\left(\frac{\left\|P_{j} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{j}\right)^{2}}+\frac{\left\|P_{l} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{l}\right)^{2}}\right), \tag{21}
\end{align*}
$$

where $(j, l) \in\{1,2,3\} \backslash\{i\}$ and $j<l$.
Proof. By (7) and $T_{i}=0$, we have

$$
\begin{align*}
\operatorname{div}\left(\sum_{i} H_{i}+\sum_{i<j} H_{i j}\right) & =2 \mathrm{~S}_{\text {mix }}\left(\mathcal{D}_{1}, \mathcal{D}_{2}, \mathcal{D}_{3}\right)+\sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}\right) \\
& +\sum_{i<j}\left(\left\|h_{i j}\right\|^{2}-\left\|H_{i j}\right\|^{2}-\left\|T_{i j}\right\|^{2}\right) \tag{22}
\end{align*}
$$

By (16), the mixed scalar curvature of $M$ with $k=3$ is

$$
\mathrm{S}_{\text {mix }}\left(\mathcal{D}_{1}, \mathcal{D}_{2}, \mathcal{D}_{3}\right)=\sum_{i<j} n_{i} n_{j}\left(c+\mu_{i} \mu_{j}\right)
$$

Note that $\left\|h_{i}\right\|^{2}=\left\|H_{i}\right\|^{2} / n_{i}$, where

$$
h_{i}(X, Y)=\langle X, Y\rangle\left(\frac{P_{j} \nabla \mu_{i}}{\mu_{i}-\mu_{j}}+\frac{P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}\right), \quad H_{i}=n_{i}\left(\frac{P_{j} \nabla \mu_{i}}{\mu_{i}-\mu_{j}}+\frac{P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}\right)
$$

Thus (similarly to Example (6), we obtain

$$
\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}=n_{i}\left(1-n_{i}\right)\left(\frac{\left\|P_{j} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{j}\right)^{2}}+\frac{\left\|P_{l} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{l}\right)^{2}}\right)
$$

Next, we consider $\left\|h_{i j}\right\|^{2}$ and $\left\|T_{i j}\right\|^{2}$ for $i \neq j$ along three subsets of $T M \oplus T M: \mathcal{D}_{i} \oplus \mathcal{D}_{i}, \mathcal{D}_{j} \oplus \mathcal{D}_{j}$ and $V_{i j}=\left(\mathcal{D}_{i} \oplus \mathcal{D}_{j}\right) \cup\left(\mathcal{D}_{j} \oplus \mathcal{D}_{i}\right)$. Using $h_{i j}=\frac{n_{i} P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}+\frac{n_{j} P_{l} \nabla \mu_{j}}{\mu_{j}-\mu_{l}}$ for $i \neq j \neq l$, we obtain

$$
\left\|h_{i j}\right\|^{2}-\left\|H_{i j}\right\|^{2}=n_{i}\left(1-n_{i}\right) \frac{\left\|P_{l} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{l}\right)^{2}}+n_{j}\left(1-n_{j}\right) \frac{\left\|P_{l} \nabla \mu_{j}\right\|^{2}}{\left(\mu_{j}-\mu_{l}\right)^{2}}+\left\|\left.h_{i j}\right|_{V_{i j}}\right\|^{2}
$$

Since $\mathcal{D}_{i}$ are integrable, we have $\left\|T_{i j}\right\|^{2}=\left\|T_{i j} \mid V_{i j}\right\|^{2}$. Given $i \neq j \neq l$, let $\left(e_{\alpha}\right),\left(\varepsilon_{\beta}\right),\left(E_{\gamma}\right)$ be local orthonormal frames of $\mathcal{D}_{i}, \mathcal{D}_{j}$ and $\mathcal{D}_{l}$, respectively. Using (19), and

$$
\left\|h_{i j}\left|V_{i j}\left\|^{2}=\frac{1}{4} \sum_{\alpha, \beta, \gamma}\left\langle\nabla_{e_{\alpha}} \varepsilon_{\beta}+\nabla_{\varepsilon_{\beta}} e_{\alpha}, E_{\gamma}\right\rangle^{2}, \quad\right\| T_{i j}\right|_{V_{i j}}\right\|^{2}=\frac{1}{4} \sum_{\alpha, \beta, \gamma}\left\langle\nabla_{e_{\alpha}} \varepsilon_{\beta}-\nabla_{\varepsilon_{\beta}} e_{\alpha}, E_{\gamma}\right\rangle^{2}
$$

we find for $(i, j) \in\{(1,2),(1,3),(2,3)\}$ the equality

$$
\left\|h_{i j}\left|V_{i j}\left\|^{2}-\right\| T_{i j}\right| V_{i j}\right\|^{2}=\sum_{\alpha, \beta, \gamma}\left\langle\nabla_{e_{\alpha}} \varepsilon_{\beta}, E_{\gamma}\right\rangle\left\langle\nabla_{\varepsilon_{\beta}} e_{\alpha}, E_{\gamma}\right\rangle=\frac{\sum_{\alpha, \beta, \gamma}\left\|\mathcal{A}\left(e_{\alpha}, \varepsilon_{\beta}, E_{\gamma}\right)\right\|^{2}}{\left(\mu_{i}-\mu_{l}\right)\left(\mu_{j}-\mu_{l}\right)}
$$

Since

$$
\frac{1}{\left(\mu_{2}-\mu_{3}\right)\left(\mu_{1}-\mu_{3}\right)}+\frac{1}{\left(\mu_{1}-\mu_{2}\right)\left(\mu_{3}-\mu_{2}\right)}+\frac{1}{\left(\mu_{2}-\mu_{1}\right)\left(\mu_{3}-\mu_{1}\right)}=0
$$

the sum $\sum_{i<j}\left(\left\|\left.h_{i j}\right|_{V_{i j}}\right\|^{2}-\left\|\left.T_{i j}\right|_{V_{i j}}\right\|^{2}\right)$ vanishes. From the above, we have

$$
\begin{aligned}
& \sum_{i}\left(\left\|h_{i}\right\|^{2}-\left\|H_{i}\right\|^{2}\right)+\sum_{i<j}\left(\left\|h_{i j}\right\|^{2}-\left\|H_{i j}\right\|^{2}-\left\|T_{i j}\right\|^{2}\right)=2 n_{1}\left(1-n_{1}\right)\left(\frac{\left\|P_{2} \nabla \mu_{1}\right\|^{2}}{\left(\mu_{1}-\mu_{2}\right)^{2}}+\frac{\left\|P_{3} \nabla \mu_{1}\right\|^{2}}{\left(\mu_{1}-\mu_{3}\right)^{2}}\right) \\
& \quad+2 n_{2}\left(1-n_{2}\right)\left(\frac{\left\|P_{1} \nabla \mu_{2}\right\|^{2}}{\left(\mu_{2}-\mu_{1}\right)^{2}}+\frac{\left\|P_{3} \nabla \mu_{2}\right\|^{2}}{\left(\mu_{2}-\mu_{3}\right)^{2}}\right)+2 n_{3}\left(1-n_{3}\right)\left(\frac{\left\|P_{1} \nabla \mu_{3}\right\|^{2}}{\left(\mu_{3}-\mu_{1}\right)^{2}}+\frac{\left\|P_{2} \nabla \mu_{3}\right\|^{2}}{\left(\mu_{3}-\mu_{2}\right)^{2}}\right)
\end{aligned}
$$

Note that the terms under the divergence in (221) are

$$
\begin{aligned}
& \sum_{i} H_{i}+\sum_{i<j} H_{i j}=\sum_{i} n_{i}\left(\frac{P_{j} \nabla \mu_{i}}{\mu_{i}-\mu_{j}}+\frac{P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}\right)+\sum_{i<j}\left(n_{i} \frac{P_{l} \nabla \mu_{i}}{\mu_{i}-\mu_{l}}+n_{j} \frac{P_{l} \nabla \mu_{j}}{\mu_{j}-\mu_{l}}\right) \\
& =2 n_{1}\left(\frac{P_{2} \nabla \mu_{1}}{\mu_{1}-\mu_{2}}+\frac{P_{3} \nabla \mu_{1}}{\mu_{1}-\mu_{3}}\right)+2 n_{2}\left(\frac{P_{1} \nabla \mu_{2}}{\mu_{2}-\mu_{1}}+\frac{P_{3} \nabla \mu_{2}}{\mu_{2}-\mu_{3}}\right)+2 n_{3}\left(\frac{P_{1} \nabla \mu_{3}}{\mu_{3}-\mu_{1}}+\frac{P_{2} \nabla \mu_{3}}{\mu_{3}-\mu_{2}}\right) .
\end{aligned}
$$

From the above (21) follows.
Using Stokes' theorem to (21) on a closed $M$, we obtain the following integral formula.
Corollary 6. In conditions of Theorem 7, for a closed hypersurface $M \subset \bar{M}(c)$, we have

$$
\int_{M}\left[\sum_{i<j} n_{i} n_{j}\left(c+\mu_{i} \mu_{j}\right)+2 \sum_{i} n_{i}\left(1-n_{i}\right)\left(\frac{\left\|P_{j} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{j}\right)^{2}}+\frac{\left\|P_{l} \nabla \mu_{i}\right\|^{2}}{\left(\mu_{i}-\mu_{l}\right)^{2}}\right)\right] \mathrm{d} \operatorname{vol}_{g}=0
$$

where $(j, l) \in\{1,2,3\} \backslash\{i\}$ and $j<l$.
