# RESOLUTIONS OF LOCALLY ANALYTIC PRINCIPAL SERIES REPRESENTATIONS OF $GL_2$

ABSTRACT. For a finite field extension  $F/\mathbb{Q}_p$  we associate a coefficient system attached on the Bruhat-Tits tree of  $G := \operatorname{GL}_2(F)$  to a locally analytic representation V of G. This is done in analogy to the work of Schneider and Stuhler for smooth representations. This coefficient system furnishes a chain-complex which is shown, in the case of locally analytic principal series representations V, to be a resolution of V.

## 1. INTRODUCTION

Let  $F/\mathbb{Q}_p$  be a finite field extension and  $G = \mathbf{G}(F)$  the group of F-valued points of a connected reductive group  $\mathbf{G}$  over F. In [5] Peter Schneider and Ulrich Stuhler associated to a smooth representation V of G (over the complex numbers) coefficient systems on the Bruhat-Tits building  $BT = BT(\mathbf{G})$  of  $\mathbf{G}$  (and also defined sheaves associated to V on BT). These coefficient systems were shown to furnish resolutions of V. The purpose of this paper is to define analogous coefficient systems for locally analytic representations of  $\operatorname{GL}_2(F)$  and to show that they too give rise to resolutions if the representation V is a locally analytic principal series representation.

We quickly recall the coefficient system construction of Schneider and Stuhler for the general linear group, cf. [4].

For each vertex v of  $BT = BT(\operatorname{GL}_{n,F})$  let  $G_v(0) := \operatorname{Stab}(v) \subset \operatorname{GL}_n(F)$ , and let  $G_v(k)$  be the  $k^{\text{th}}$  congruence subgroup of  $G_v(0)$  for some  $k \geq 1$ . The coefficient system on BT attached to a smooth representation V of  $\operatorname{GL}_n(F)$  is defined as follows

- To each vertex  $v \in BT$  we associate  $V_v := V^{G_v(k)}$ , the space of  $G_v(k)$ -fixed vectors of V. And to each simplex  $\sigma := \{v_0, v_1, \cdots, v_d\}$  we associate  $V_{\sigma} = V^{G_{\sigma}(k)}$  where  $G_{\sigma}(k) := \langle G_{v_0}(k), \cdots, G_{v_d}(k) \rangle$ , is the group generated by  $G_{v_i}(k)$ 's.
- If  $\sigma \subseteq \tau$  are two simplices, then  $G_{\sigma}(k) \subset G_{\tau}(k)$ , and there is hence an inclusion  $r_{\sigma}^{\tau}: V_{\tau} \to V_{\sigma}$ . These transition maps satisfy the conditions  $r_{\sigma}^{\sigma} =$  id, and,  $r_{\sigma}^{\tau} \circ r_{\tau}^{\xi} = r_{\sigma}^{\xi}$  for simplices  $\sigma \subseteq \tau \subseteq \xi$ .

This coefficient system naturally gives rise to a chain-complex. One of the key results of [4, 5] is that this complex is exact.

In section 2 of this paper we associate an analogous coefficient system to a locally analytic representation V of  $G := \operatorname{GL}_2(F)$ , replacing  $G_v(k)$ -fixed vectors by the rigid-analytic vectors  $V_{\mathbb{G}_v(k)-\operatorname{an}}$  for the corresponding rigid analytic group  $\mathbb{G}_v(k)$ and construct a chain complex [2.2.1] associated to it. In fact, the construction of the coefficient system and the associated chain-complex can be generalized to locally analytic representations of any (connected) *p*-adic reductive group. It is natural to ask, when is this chain complex a resolution of V?

In section 3 we show that under some assumptions on k,

**Theorem 1.1.1** (see 3.1.3). For the locally analytic principal series  $V := Ind_B^G(\chi)$ , the chain-complex 2.2.1 is a resolution of V.

Notation. We denote by  $F/\mathbb{Q}_p$  a finite field extension of  $\mathbb{Q}_p$ , by  $\mathcal{O}$  its ring of integers, by  $\varpi$  a uniformizer, and by  $\mathbb{F}_q$  its residue field of cardinality q. We will denote by E/F a finite field extension (the 'coefficient field'), and all locally analytic representations will be over E. Throughout this paper G will denote the group  $\mathrm{GL}_2(F)$ . For a locally F-analytic manifold X, we denote by  $C^{\mathrm{la}}(X, E)$  the the space of E-valued locally F-analytic functions on X as defined in [6] (in the reference, the authors use  $C^{\mathrm{an}}(X, E)$  for this space).

## 2. A COEFFICIENT SYSTEM AND COMPLEX

## 2.1. The Bruhat-Tits tree and associated subgroups.

**2.1.1.** The building. Recall that the semisimple Bruhat-Tits building BT of  $GL_2$  over F is a one-dimensional simplicial complex whose set of vertices  $BT_0$  we can identify with the set of homothety classes of  $\mathcal{O}$ -lattices  $\Lambda \subset F^2$ . We write  $[\Lambda]$  for the homothety class of  $\Lambda$ . Two vertices v and v' are adjacent (or form an edge) if and only if there are representing lattices  $\Lambda$  of v and  $\Lambda'$  of v', such that  $\varpi\Lambda \subsetneq \Lambda' \subsetneq \Lambda$ . The set of edges of BT will be denoted by  $BT_1$ , and we write  $e = \{v, v'\}$  if the vertices v and v' form an edge. We define the distance function  $d: BT_0 \times BT_0 \to \mathbb{Z}_{\geq 0}$  as follows: d(v, v') = 0, if v = v', and d(v, v') = n, if there is a sequence of vertices  $v = v_0, v_1, v_2, \ldots, v_n = v'$  such that  $\{v_i, v_{i+1}\}$  is an edge for all  $i \in \{0, \ldots, n-1\}$ , and  $v_{i+1} \neq v_{i-1}$  for  $i \in \{1, \ldots, n-1\}$ . We further recall

that BT is a homogeneous tree of degree q + 1, in particular the distance function is well-defined.

An oriented edge is an ordered pair (v, v') of adjacent vertices. An orientation of BT is a set  $BT_1^{\text{or}} \subset BT_0 \times BT_0$  consisting of oriented edges, and such that the map  $BT_1^{\text{or}} \to BT_1, (v, v') \mapsto \{v, v'\}$ , is bijective. For a vertex v and an edge  $e = \{v_1, v_2\}$ , or an oriented edge  $e = (v_1, v_2)$ , we set  $d(e, v) = \max\{d(v_1, v), d(v_2, v)\}$ .

The group  $G = \operatorname{GL}_2(F)$  acts on BT by  $g[\Lambda] = [g[\Lambda]]$ , and by  $g[v, v'] = \{g[v, g[v]]\}$ . The action of G on  $BT_0$  and  $BT_1$  are well known to be transitive. In 3.4.7 we will need the following transitivity of G-action.

**Lemma 2.1.2.** Let v, v' and w, w' be two pairs of vertices with d(v, v') = d(w, w') = $n \geq 0$ , and let  $v = v_0, v_1, v_2, \ldots, v_n = v'$  and  $w = w_0, w_1, w_2, \ldots, w_n = w'$  be the unique paths connecting v with v' and w with w', respectively. Then there exists  $g \in G$  such that for all  $i \in \{0, \ldots, n\}$  one has  $g.v_i = w_i$ , i.e., the action of G on paths of length  $n \ge 0$  is transitive.

*Proof.* The proof proceeds by induction on n. The assertion is true in the case when  $n \leq 1$  because of the transitivity of the G-action on  $BT_0$  and  $BT_1$ , as mentioned above. We thus assume that  $n \ge 2$  in the following. Furthermore, it is enough to prove the assertion under the assumption that  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$  and  $v_i = [(\varpi^i) \oplus \mathcal{O}]$ for  $0 \le i \le n$ . By induction, there this  $h \in G$  such that  $h \cdot v_i = w_i$  for  $0 \le i \le n-1$ . Then  $h^{-1}.w_n$  is adjacent to  $v_{n-1} = h^{-1}.w_{n-1}$  and is different from  $v_{n-2}$ . The vertices which have this property are of the form  $v_{\alpha,n} := [\langle (\varpi^n, 0), ([\alpha], 1) \rangle]$ , the homo-thety class of  $\mathcal{O}$ -lattice generated by  $(\varpi^n, 0)$  and  $([\alpha], 1)$  where  $\alpha \in (\varpi)^{n-1}/(\varpi)^n$ . Then  $h' := \begin{bmatrix} 1 & \alpha \\ 0 & 1 \end{bmatrix}$  takes  $v_{\alpha,n}$  to  $v_n$  while fixing  $v_i$  for  $0 \le i \le n-1$ . The element  $g = h(h')^{-1}$  has then the desired property.

**2.1.3.** The groups  $G_{\sigma}(k)$ . Given a vertex  $v = [\Lambda]$  we set  $G_v(0) = \operatorname{Stab}_G(\Lambda) =$  $\{g \in G \mid g : \Lambda = \Lambda\}$ , and for a positive integer k we put

$$G_v(k) = \{g \in G_v(0) \mid \forall x \in \Lambda : g \cdot x \equiv x \mod \varpi^k \Lambda \}$$

Given an edge  $e = \{v, v'\}$  (or an oriented edge e = (v, v')) and  $k \in \mathbb{Z}_{>0}$  we let  $G_e(k) = \langle G_v(k), G_{v'}(k) \rangle$  be the subgroup of G generated by  $G_v(k)$  and  $G_{v'}(k)$ . As G acts transitively on  $BT_0$  and  $BT_1$ , G acts transitively on  $\{G_v(k) \mid v \in BT_0\}$  as well as on  $\{G_e(k) \mid e \in BT_1\}$  by conjugation.

For later purposes it will be useful to describe some of the groups  $G_v(k)$  and  $G_e(k)$ explicitly.

**Lemma 2.1.4.** Fix  $k \in \mathbb{Z}_{>0}$ . If  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$ , then

(2.1.5) 
$$G_{v_0}(k) = \left\{ \begin{bmatrix} 1 + \varpi^k a & \varpi^k b \\ \varpi^k c & 1 + \varpi^k d \end{bmatrix} \middle| a, b, c, d \in \mathcal{O} \right\} ,$$

and if  $e = \{v_0, v_1\}$  with  $v_1 = [(\varpi) \oplus \mathcal{O}]$ , then

(2.1.6) 
$$G_e(k) = \left\{ \begin{bmatrix} 1 + \varpi^k a & \varpi^k b \\ \varpi^{k-1} c & 1 + \varpi^k d \end{bmatrix} \middle| a, b, c, d \in \mathcal{O} \right\} .$$

*Proof.* The first assertion is well-known and straightforward to verify. For the second assertion we note that  $v_1 = \text{diag}(\varpi, 1) \cdot v_0$  and therefore

$$G_{v_1}(k) = \operatorname{diag}(\varpi, 1)G_{v_0}(k)\operatorname{diag}(\varpi, 1)^{-1} = \left\{ \begin{bmatrix} 1 + \varpi^k a & \varpi^{k+1}b \\ \varpi^{k-1}c & 1 + \varpi^k d \end{bmatrix} \middle| a, b, c, d \in \mathcal{O} \right\} ,$$

By definition,  $G_e(k) = \langle G_{v_0}(k), G_{v_1}(k) \rangle$ . Let H be the group on the right hand side of 2.1.6. An easy computation shows that

(i) 
$$G_{v_0}(k).G_{v_1}(k) = G_{v_1}(k).G_{v_0}(k)$$
, and hence  $G_e(k) = G_{v_0}(k).G_{v_1}(k)$ , and that  
(ii)  $G_{v_0}(k).G_{v_1}(k) \subset H$ .

Now we observe that for any  $a, b, c, d \in \mathcal{O}_F$  we have

$$\begin{bmatrix} 1 + \varpi^k a & \varpi^k b \\ \varpi^{k-1} c & 1 + \varpi^k d \end{bmatrix} = \begin{bmatrix} 1 + \varpi^k a & 0 \\ \varpi^{k-1} c & 1 \end{bmatrix} \cdot \begin{bmatrix} 1 & \varpi^k \frac{b}{1 + \varpi^k a} \\ 0 & 1 + \varpi^k \left( d - \varpi^{k-1} \frac{cb}{1 + \varpi^k a} \right) \end{bmatrix}$$
finishes the proof.

This finishes the proof.

**2.1.7.** A Coefficient System on BT. We choose  $k \in \mathbb{Z}_{>0}$  such that for any simplex (edge or vertex)  $\sigma$  of BT the group  $G_{\sigma}(k)$  as defined above is a uniform pro-p group [1]. Under this assumption we can associate to  $G_{\sigma}(k)$  a rigid analytic subgroup  $\mathbb{G}_{\sigma}(k)$  of the analytification  $\mathrm{GL}_{2}^{\mathrm{rig}}$  of the algebraic group  $\mathrm{GL}_{2}$  over F. See [3, 3.5] for a description of this process.

Given a locally analytic representation V of G, we define a coefficient system  $\mathcal{C}_{V}^{(k)}$ on BT as follows.

- To each simplex  $\sigma \subset BT$  we associate  $V_{\sigma} := V_{\mathbb{G}_{\sigma}(k)-\mathrm{an}}$ , the space of  $\mathbb{G}_{\sigma}(k)$ analytic vectors<sup>1</sup> of V.
- If  $\sigma \subseteq \tau$  are two simplices, then  $G_{\sigma}(k) \subset G_{\tau}(k)$ , and there is hence an inclusion  $r_{\sigma}^{\tau}: V_{\tau} \to V_{\sigma}$ . These transition maps satisfy the conditions  $r_{\sigma}^{\sigma} =$ id, and therefore,  $r_{\sigma}^{\tau} \circ r_{\tau}^{\xi} = r_{\sigma}^{\xi}$  for simplices  $\sigma \subseteq \tau \subseteq \xi$ .

2.2. The chain complex associated to a coefficient system on BT. We associate to  $\mathcal{C}_V^{(k)}$  the following complex

(2.2.1) 
$$0 \to \bigoplus_{e \in BT_1^{\text{or}}} V_e \xrightarrow{\partial_1} \bigoplus_{v \in BT_0} V_v \xrightarrow{\partial_0} V \to 0$$

Where there maps are defined as follows: given an oriented edge  $e = (v_1, v_2) \in BT_1^{\text{or}}$ the map  $\partial_1|_{V_e}$  is defined by

$$\begin{array}{cccc} \partial_1|_{V_e}: V_e & \longrightarrow & \bigoplus_{v \in BT_0} V_v \\ f & \longmapsto & (f_v)_v \end{array}, \end{array}$$

where  $f_{v_1} = f$ ,  $f_{v_2} = -f$ , and  $f_v = 0$  for all  $v \notin \{v_1, v_2\}$ . The map  $\partial_0$  is defined by

$$\partial_0: \bigoplus_{v \in BT_0} V_v \longrightarrow V$$
$$(f_v)_v \to \sum_v f_v$$

where the sum is taken inside V using the vector space embeddings  $V_v \hookrightarrow V$ .

## 3. Locally analytic principal series representations

#### 3.1. Locally analytic induction.

**3.1.1.** Let  $T \subset G$  be the maximal torus comprising of diagonal matrices and B with,  $T \subset B \subset G$  be the standard Borel subgroup of upper triangular matrices. We also fix once and for all a finite extension E/F. For a locally *F*-analytic character  $\chi: T \to E^{\times}$  we consider the locally analytic principal series representation

$$\begin{split} V &:= & \mathrm{Ind}_B^G(\chi) \\ &= & \left\{ f: G \to E \text{ locally } F\text{-analytic} \middle| \, \forall g \in G \; \forall \; b \in B: \; f(bg) = \chi(b)f(g) \right\} \,. \end{split}$$

The action of G on V is given by  $g.f(x) = f(x.g^{-1})$ . We will consider  $\operatorname{Ind}_B^G(\chi)$  as a topological vector space as follows. Set  $G_0 = \operatorname{GL}_2(\mathcal{O})$  and  $B_0 = B \cap G_0$ . Then  $G = B \cdot G_0$  and the canonical map of quotients  $B_0 \setminus G_0 \to B \setminus G$  is an isomorphism of locally F-analytic manifolds. Therefore, restricting locally F-analytic functions from G to  $G_0$  gives an isomorphism of vector spaces  $\operatorname{Ind}_B^G(\chi) \to \operatorname{Ind}_{B_0}^{G_0}(\chi)$ . Since  $G_0$  is compact, the space  $C^{\operatorname{la}}(G_0, E)$  of E-valued locally F-analytic functions on  $G_0$  naturally carries the structure of an E-vector space of compact type [6, Lemma 2.1]. We equip  $\operatorname{Ind}_B^G(\chi) \to \operatorname{Ind}_{B_0}^{G_0}(\chi)$  becomes an isomorphism of topological vectors spaces.

**3.1.2.** For a simplex  $\sigma \in BT$  (or an oriented edge  $e \in BT_1^{\text{or}}$ ), let

$$\Omega_{\sigma,k} = B \backslash G / G_{\sigma}(k)$$

be the set of B- $G_{\sigma}(k)$  double cosets in G, which is finite because  $B \setminus G$  is compact and  $G_{\sigma}(k)$  open in G. As  $G_{\sigma}(k)$  is an open subgroup, so is any double coset  $\Delta \in \Omega_{\sigma,k}$ . Given  $\Delta \in \Omega_{\sigma,k}$ , we set

$$I(\Delta,\chi) = \left\{ \Delta \xrightarrow{f} E \mid f \text{ is loc. } F \text{-analytic, } \forall \ b \in B, x \in \Delta, f(bx) = \chi(b)f(x) \right\}$$

Note that by extending functions in  $I(\Delta, \chi)$  by zero outside  $\Delta$ , we obtain an embedding  $I(\Delta, \chi) \hookrightarrow V$ , and the image of this map, which we will henceforth identify with  $I(\Delta, \chi)$ , is stable under the action of  $G_{\sigma}(k)$  on V. Because  $G = \coprod_{\Delta \in \Omega_{\sigma,k}} \Delta$ , we have

$$V_{\mathbb{G}_{\sigma}(k)-\mathrm{an}} = \bigoplus_{\Delta \in \Omega_{\sigma,k}} I(\Delta, \chi)_{\mathbb{G}_{\sigma}(k)-\mathrm{an}} +$$

The main result of this article is

**Theorem 3.1.3.** There exists an integer  $k_0 \ge 1$  such that for all  $k \ge k_0$  the chain complex 2.2.1 is a resolution when applied to  $V = \text{Ind}_B^G(\chi)$ .

The rest of the article is dedicated to the proof of 3.1.3. A crucial role in our proof will be played by the following sets of vertices and edges:

$$BT_{0,n} = \left\{ v \in BT_0 \mid d(v, v_0) \le n \right\},$$
  
$$BT_{1,n}^{\text{or}} = \left\{ e = (v, v') \in BT_1^{\text{or}} \mid d(e, v_0) \le n \right\}$$

where  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$  is as above.

3.2. Injectivity of  $\partial_1$ .

**Proposition 3.2.1.** The map  $\partial_1 : \bigoplus_{e \in BT_1^{\text{or}}} V_e \longrightarrow \bigoplus_{v \in BT_0} V_v$  is injective.

Proof. Let  $f = (f_e)_e \neq 0$  be supported on  $BT_{1,n}^{\text{or}}$  but not on  $BT_{1,n-1}^{\text{or}}$  for some  $n \geq 1$   $(BT_{1,0}^{\text{or}}$  is the empty set), i.e., there is  $e = (v_1, v_2) \in BT_1^{\text{or}}$  such that  $d(e, v_0) = n$  and  $f_e \neq 0$ , and  $f_{e'} = 0$  for all edges e' with  $d(e', v_0) > n$ . If then  $i \in \{1, 2\}$  is such that  $d(v_i, v_0) = n$ , we have  $\partial_1(f)_{v_i} = \pm f_e \neq 0$ .

3.3. The action of G on  $\mathbb{P}^1(F)$ . In the rest of the paper we will let  $\infty$  be a symbol different from all elements in F and put  $\mathbb{P}^1(F) = F \cup \{\infty\}$ . We equip  $\mathbb{P}^1(F)$  with an action from the right by G via Möbius transformations. Explicitly, the action of  $g = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in G$  on  $z \in \mathbb{P}^1(F)$  is given by

(3.3.1) 
$$z.g = \begin{cases} \frac{az+c}{bz+d} &, z \neq \infty \\ \frac{a}{b} &, z = \infty \end{cases}$$

where  $\frac{az+c}{bz+d}$  (resp.  $\frac{a}{b}$ ) is  $\infty$  if the denominator vanishes. The stabilizer of the point  $0 \in \mathbb{P}^1(F)$  is B, and the map

$$\iota: B \backslash G \longrightarrow \mathbb{P}^1(F) , \quad Bg \mapsto 0.g ,$$

is bijective and G-equivariant, if we consider the right translation action of G on  $B \setminus G$ . The quotient  $B \setminus G$  inherits the structure of a locally F-analytic manifold from G, and we equip  $\mathbb{P}^1(F)$  with the structure of a locally F-analytic manifold via  $\iota$  (so that  $\iota$  becomes an isomorphism of locally F-analytic manifolds). Each  $g \in G$  acts as a locally F-analytic automorphism on  $\mathbb{P}^1(F)$ .

We denote by  $P\Omega_{\sigma,k}$  the set of  $G_{\sigma}(k)$ -orbits on  $\mathbb{P}^1(F)$ . By the discussion in the preceding paragraph, there is a canonical bijection between B- $G_{\sigma}(k)$  double cosets of G and orbits of (right) action of  $G_{\sigma}(k)$  on  $\mathbb{P}^1(F)$ , given by

$$\Omega_{\sigma,k} \xrightarrow{1:1} \mathrm{P}\Omega_{\sigma,k} , \ \Delta \mapsto \mathrm{P}\Delta := B \backslash \Delta .$$

For  $z_0 \in F \subset \mathbb{P}^1(F)$  and  $r \in \mathbb{R}_{>0}$  we then set  $\mathbf{B}_z(z_0, r) = \{x \in F \mid |x - z_0| \leq r\}$ , which is a closed disc of radius r around  $z_0$ . Similarly, for  $r \in \mathbb{R}_{>0}$  and  $w_0 \in \mathbb{R}_{>0}$   $\mathbb{P}^{1}(F) \setminus \{0\} \text{ we set } \mathbf{B}_{w}(w_{0}, r) = \{x \in F^{\times} \cup \{\infty\} \mid \left|\frac{1}{x} - \frac{1}{w_{0}}\right| \leq r\}, \text{ where we interpret} \\ \frac{1}{\infty} \text{ as zero. In particular, } \mathbb{P}^{1}(F) = \mathbf{B}_{z}(0, 1) \sqcup \mathbf{B}_{w}(\infty, |\varpi|).$ 

**Proposition 3.3.2.** For  $v_0 = [\mathcal{O} \oplus \mathcal{O}], v_1 = [(\varpi) \oplus \mathcal{O}]$  and  $e_0 = \{v, v_1\}$ , the orbits of  $G_{v_0}(k), G_{v_1}(k)$  and  $G_{e_0}(k)$  can be described as follows

(i) The orbits of  $G_{v_0}(k)$  on  $\mathbb{P}^1(F)$  are discs of radius  $|\varpi|^k$  of the form  $\mathbf{B}_z(z_0, |\varpi|^k)$ on  $\mathbf{B}_z(0,1)$  with  $z_0 \in \mathbf{B}_z(0,1)$  and are of the form  $\mathbf{B}_w(w_0, |\varpi|^k)$  on  $\mathbf{B}_w(\infty, |\varpi|)$ with  $w_0 \in \mathbf{B}_w(\infty, |\varpi|)$ .

(ii) The orbits of  $G_{v_1}(k)$  are discs of radius  $|\varpi|^{k-1}$  of the form  $\mathbf{B}_z(z_0, |\varpi|^{k-1} \text{ on } \mathbf{B}_z(0,1)$  with  $z_0 \in \mathbf{B}_z(0,1)$  and discs of radius  $|\varpi|^{k+1}$  of the form  $\mathbf{B}_w(w_0, |\varpi|^{k+1})$  on  $\mathbf{B}_w(\infty, |\varpi|)$  with  $w_0 \in \mathbf{B}_w(\infty, |\varpi|)$ .

(iii) The orbits  $G_{e_0}(k)$ -orbits on  $\mathbf{B}_z(0,1)$  are of the form  $\mathbf{B}_z(z_0, |\varpi|^{k-1})$  (i.e., same as orbits of of  $G_{v_1}(k)$ ) with  $z_0 \in \mathbf{B}_z(0,1)$  and on  $\mathbf{B}_w(\infty, |\varpi|)$  they are of the form  $\mathbf{B}_w(w_0, |\varpi|^k)$  (i.e., same as orbits of of  $G_{v_0}(k)$ ) with  $w_0 \in \mathbf{B}_w(\infty, |\varpi|)$ .

*Proof.* (i) and (ii) To compute the orbits of  $G_{v_0}(k)$  on  $\mathbf{B}_z(0,1)$  we use the description of  $G_{v_0}(k)$  from 2.1.5 and the description of the action in 3.3.1 to get for  $z_o \in \mathbf{B}_z(0,1)$ 

$$\frac{az_0 + c}{bz_0 + d} = (z_0 + O(\varpi^k))(1 + O(\varpi^k)) = z_0 + O(\varpi^k)$$

for  $g = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in G_{v_0}(k)$ . This shows that the orbit of  $z_0$  is contained in  $\mathbf{B}_z(z_0, |\varpi|^k)$ . Via the translation  $z_0 \to z_0$ .  $\begin{bmatrix} 1 & 0 \\ c & 1 \end{bmatrix} = z_0 + c$ , we conclude that the orbit is indeed  $\mathbf{B}_z(z_0, |\varpi|^k)$ . A similar computation shows that the orbit of  $w_0 \in \mathbf{B}_w(\infty, |\varpi|)$  is  $\mathbf{B}_w(w_0, |\varpi|^k)$ .

For 
$$g = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in G_{v_1}(k)$$
 we have,  
$$\frac{az_0 + c}{bz_0 + d} = (z_0 + O(\varpi^{k-1}))(1 + O(\varpi^k)) = z_0 + O(\varpi^{k-1})$$

And again by using matrices of the form  $\begin{bmatrix} 1 & 0 \\ c & 1 \end{bmatrix}$  we obtain that the orbits on  $\mathbf{B}_{z}(0,1)$  are  $\mathbf{B}_{z}(z_{0},|\varpi|^{k-1})$ . On the other hand, on  $\mathbf{B}_{w}(\infty,|\varpi|)$  we have,

$$\frac{1}{w_0.g} = \frac{bw_0 + d}{aw_0 + c} = \frac{b + d\frac{1}{w_0}}{a + c\frac{1}{w_0}} = (\frac{1}{w_0} + O(\varpi^{k+1}))(1 + O(\varpi^k)) = \frac{1}{w_0} + O(\varpi^{k+1})$$

thus the orbits on  $\mathbf{B}_w(\infty, |\varpi|)$  of  $G_{v_1}(k)$  are disjoint discs  $\mathbf{B}_w(w_0, |\varpi|^{k+1})$  and  $\mathbf{B}_w(\infty, |\varpi|^{k+1})$ . This shows assertion (ii).

(iii) Using 2.1.6, we can show via an analogous computation that the orbits of  $G_{e_0}(k)$  on  $\mathbf{B}_z(0,1)$  are of the form  $\mathbf{B}_z(z_0, |\varpi|^{k-1})$  (i.e., orbit of of  $G_{v_1}(k)$ ) and on  $\mathbf{B}_w(\infty, |\varpi|)$  they are of the form  $\mathbf{B}_w(w_0, |\varpi|^k), w_0 \in \mathbf{B}_w(\infty, |\varpi|)$  (i.e., orbits of  $G_{v_0}(k)$ ).

We can make a more general statement based on the previous proposition.

**Proposition 3.3.3.** Let  $v, v' \in BT_0$  and  $e = \{v, v'\} \in BT_1$ . We have,

(i)  $\Omega_{v,k} \cap \Omega_{v',k} = \emptyset$ .

(ii) For every  $\Delta \in \Omega_{v,k}$  there is  $\Delta' \in \Omega_{v',k}$  such that  $\Delta \subset \Delta'$  or  $\Delta' \subset \Delta$ . Furthermore,  $\Omega_{v,k}^{v'} := \{\Delta \in \Omega_{v,k} \mid \exists \Delta' \in \Omega_{v',k} : \Delta' \subset \Delta\}$  has cardinality  $q^{k-1}$  and each  $\Delta \in \Omega_{v,k}^{v'}$  contains q orbits of  $\Omega_{v',k}$ .

(iii) If  $\Delta \in \Omega_{e,k}$  then  $\Delta \in \Omega_{v,k}$  or  $\Delta \in \Omega_{v',k}$ .

(iv) If  $\Delta \in \Omega_{v,k} \cap \Omega_{e,k}$  then there exists  $\Delta' \in \Omega_{v',k}$  such that  $\Delta' \subset \Delta$  and similarly, if  $\Delta' \in \Omega_{v',k} \cap \Omega_{e,k}$  then there exists  $\Delta \in \Omega_{v,k}$  such that  $\Delta \subset \Delta'$ .

(v) If  $\Delta' \subset \Delta$  for double-cosets in  $\Omega_{v',k}$  and  $\Omega_{v,k}$ , respectively, then  $\Delta \in \Omega_{v,k} \cap \Omega_{e,k}$ .

*Proof.* Via the canonical bijection  $\Delta \leftrightarrow P\Delta$  it is enough to show the corresponding assertions for orbits on  $\mathbb{P}^1(F)$ .

Since the action of G on  $BT_0$  and  $BT_1$  is transitive it is enough to prove the statements for  $v_0, v_1$  and  $e_0 = \{v_0, v_1\}$ , where  $v_0$  and  $v_1$  are as in 3.3.2.

(i), (ii) and (iii) Follows directly from 3.3.2.

(iv) If  $\mathbf{P}\Delta = \mathbf{B}_w(w_0, |\varpi|^k) \subset \mathbf{B}_w(\infty, |\varpi|) \in \mathbf{P}\Omega_{v_0,k} \cap \mathbf{P}\Omega_{e_0,k}$  then we can take  $\mathbf{P}\Delta' = \mathbf{B}_w(w_0, |\varpi|^{k+1}) \in \Omega_{v_1,k}$ . And if  $\mathbf{P}\Delta = \mathbf{B}_z(z_0, |\varpi|^{k-1}) \subset \mathbf{B}_z(0, 1) \in \mathbf{P}\Omega_{v_1,k} \cap \mathbf{P}\Omega_{e_0,k}$  then we can take  $\mathbf{P}\Delta' = \mathbf{B}_z(z_0, |\varpi|^k)$ .

(v) The only orbits for which the relation  $P\Delta' \subset P\Delta$  with  $P\Delta' \in P\Omega_{v_1,k}, P\Delta \in P\Omega_{v_0,k}$  holds are of the form  $\mathbf{B}_w(w_0, |\varpi|^{k+1}) \subset \mathbf{B}_w(w_0, |\varpi|^k)$ . And any such  $\mathbf{B}_w(w_0, |\varpi|^k) \in P\Omega_{v_0,k}$  also belongs to  $P\Omega_{e_0,k}$ .

**Remark 3.3.4.** Let  $\sigma', \sigma$  be two simplices in BT with  $\sigma' = g.\sigma$  for  $g \in G$ . The map

defines a bijection between  $\Omega_{\sigma,k}$  and  $\Omega_{\sigma',k}$  and between  $\Omega_{\sigma,k}$  and  $\Omega_{\sigma',k}$  respectively.

**Lemma 3.3.5.** Let  $v_{\alpha,1} := [\langle (1,\alpha), (0,\varpi) \rangle]$ ,  $\alpha \in \mathcal{O}/(\varpi)$ , be the vertex corresponding to the homothety class of the  $\mathcal{O}$ -lattice  $\langle (1, [\alpha]), (0, \varpi) \rangle \subset F^{\oplus 2}$ . Then the orbits of  $G_{v_{\alpha,1}}(k)$  on  $\mathbf{B}_z([\alpha], |\varpi|) \subset \mathbf{B}_z(0, 1)$  are of the form  $\mathbf{B}_z(\beta, |\varpi|^{k+1})$ , for  $\beta \in \mathbf{B}_z([\alpha], |\varpi|)$ . Moreover each of the orbits of  $G_{v_{\alpha,1},k}$  of the form  $\mathbf{B}_z(\beta, |\varpi|^{k+1})$  on  $\mathbf{B}_z([\alpha], |\varpi|)$  is contained in an orbit of the form  $\mathbf{B}_z(0, |\varpi|^k)$  of  $G_{v_0,k}$ .

Each of the other orbits of  $G_{v_{\alpha,1}}(k)$  contains q orbits of  $G_{v_0}(k)$ .

*Proof.* Note that  $v_{\alpha,1} = g_{\alpha}.v_0$ , where  $g_{\alpha} = \begin{bmatrix} 1 & 0 \\ [\alpha] & \varpi \end{bmatrix}$  and  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$  as in 3.3.3. Thus by 3.3.4 we have  $P\Omega_{v_{\alpha,1},k} = P\Omega_{v_0,k}.g_{\alpha}^{-1}$ . Now

$$\beta \cdot g_{\alpha}^{-1} = \beta \cdot \begin{bmatrix} 1 & 0\\ -\frac{[\alpha]}{\varpi} & \varpi^{-1} \end{bmatrix} = \frac{\beta - \frac{[\alpha]}{\varpi}}{\varpi^{-1}} = \varpi \cdot \beta - [\alpha].$$

This transformation takes  $\mathbf{B}_z(0, |\varpi|^k) \cdot g_{\alpha}^{-1} = \mathbf{B}_z([\alpha], |\varpi|^{k+1})$  and very similarly we can compute the other orbits. The containment relation is clear from the radius of the respective orbits.

**3.3.6.** We also introduce the following notation for the rest of the paper

$$\begin{split} \Omega_{0,k} &= \bigsqcup_{v \in BT_0} \Omega_{v,k} , \qquad P\Omega_{0,k} &= \bigsqcup_{v \in BT_0} P\Omega_{v,k} \\ \Omega_{0,k,n} &= \bigsqcup_{v \in BT_{0,n}} \Omega_{v,k} , \qquad P\Omega_{0,k,n} &= \bigsqcup_{v \in BT_{0,n}} P\Omega_{v,k} \\ \Omega_{1,k} &= \bigsqcup_{e \in BT_1^{\text{or}}} \Omega_{e,k} , \qquad P\Omega_{1,k} &= \bigsqcup_{e \in BT_1^{\text{or}}} P\Omega_{e,k} \\ \Omega_{1,k,n} &= \bigsqcup_{e \in BT_{1,n}^{\text{or}}} \Omega_{e,k} , \qquad P\Omega_{1,k,n} &= \bigsqcup_{e \in BT_{1,n}^{\text{or}}} P\Omega_{e,k} \\ \overline{\Omega}_{0,k} &= \bigsqcup_{v \in BT_0} \Omega_{v,k} , \qquad \overline{P\Omega}_{0,k} &= \bigsqcup_{v \in BT_0} P\Omega_{v,k} \\ \overline{\Omega}_{0,k,n} &= \bigsqcup_{v \in BT_{0,n}} \Omega_{v,k} , \qquad \overline{P\Omega}_{0,k,n} &= \bigsqcup_{v \in BT_{0,n}} P\Omega_{v,k} \\ \overline{\Omega}_{1,k} &= \bigsqcup_{e \in BT_1^{\text{or}}} \Omega_{e,k} , \qquad \overline{P\Omega}_{1,k} &= \bigsqcup_{e \in BT_{1,n}^{\text{or}}} P\Omega_{e,k} \\ \overline{\Omega}_{1,k,n} &= \bigsqcup_{e \in BT_{1,n}^{\text{or}}} \Omega_{e,k} , \qquad \overline{P\Omega}_{1,k,n} &= \bigsqcup_{e \in BT_{1,n}^{\text{or}}} P\Omega_{e,k} \end{split}$$

**Remark 3.3.7.** Note that, (iii) of 3.3.3 says, If  $\Delta \in \Omega_{e,k}$  for  $e = \{v, v'\}$  then  $\Delta \in \Omega_{v,k}$  or  $\Delta \in \Omega_{v',k}$ . From this it is clear that we can think of  $\Omega_{1,k}$  as a subset of  $\Omega_{0,k}$ . And we can similarly conclude  $P\Omega_{1,k} \subset P\Omega_{0,k}, \overline{\Omega}_{1,k} \subset \overline{\Omega}_{1,k}$  and  $\overline{P\Omega}_{1,k} \subset \overline{P\Omega}_{0,k}$ .

We equip  $\overline{\Omega}_{0,k}$  (and  $\overline{P\Omega}_{0,k}$ ) with the partial order via inclusion.

**Remark 3.3.8.** Note that  $\Omega_{0,k,n}$  and  $\overline{\Omega}_{0,k,n}$  (and by extension  $\Omega_{0,k}$  and  $\overline{\Omega}_{0,k}$ ) are not the same. For example, by 3.3.5,  $\mathbf{B}_w(\infty, |\varpi|)$  is in both  $\Omega_{v_{1,1},2}$  and  $\Omega_{v_{0,1},2}$ , where  $v_{0,1}$  and  $v_{1,1}$  are as in 3.3.5. There is an obvious map  $\mathrm{pr} : \Omega_{0,k} \to \overline{\Omega}_{0,k}$  which restricts to a map from  $\mathrm{pr} : \Omega_{0,k,n} \to \overline{\Omega}_{0,k,n}$ , taking every orbit in  $\overline{\Omega}_{0,k}$  that are same as sets to the same set in  $\overline{\Omega}_{0,k}$ . We will use the same notation for the map  $\mathrm{pr} : \mathrm{P}\Omega_{0,k} \to \overline{\mathrm{P}\Omega}_{0,k}$ .

For sake of clarity, from now on let  $\overline{\Delta} = \operatorname{pr}(\Delta)$  and  $\overline{\mathrm{P}\Delta} = \operatorname{pr}(\mathrm{P}\Delta)$ . When we want to emphasize that the double coset  $\Delta \in \Omega_{v,k}$  (resp. the orbit  $\mathrm{P}\Delta \in \mathrm{P}\Omega_{v,k}$ ) is just considered as a subset of G (resp. a subset of  $\mathbb{P}^1(F)$ ), then we write  $\overline{\Delta}$  (resp.  $\overline{\mathrm{P}\Delta}$ ) for it.

**Proposition 3.3.9.** For  $G_v(k)$ -orbits on  $\mathbb{P}^1(F)$  we have the following:

(i) Given any  $z \in \mathbb{P}^1(F)$  and  $k \in \mathbb{Z}_{>0}$ , the set

$$\{\overline{\mathrm{P}\Delta} \mid v \in BT_0, \ \mathrm{P}\Delta \in \mathrm{P}\Omega_{v,k}, \ z \in \overline{\mathrm{P}\Delta}\}$$

is a fundamental system of open compact neighborhoods of z.

(ii) Given any covering  $\mathcal{U}$  of  $\mathbb{P}^1(F)$  there is a finite subset of  $\overline{\mathrm{P}\Omega}_{0,k}$  that refines  $\mathcal{U}$ .

Proof. (i) Without loss of generality we may assume that z = 0. Consider the vertices  $v_n := [\mathcal{O} \oplus (\varpi^n)], n \ge 1$ . We have  $g_n.v_0 = v_n$ , where  $g_n = \begin{bmatrix} 1 & 0 \\ 0 & \varpi^n \end{bmatrix}$ . Let  $P\Delta_0 := \mathbf{B}_z(0, |\varpi|^k) \in P\Omega_{v_0,k}$ , then we can compute that  $P\Delta_n := P\Delta_0.g_n^{-1} = \mathbf{B}_z(0, |\varpi|^{n+k}) \in P\Omega_{v_n,k}$ . And,  $\{\overline{P\Delta}_n\}_{n\ge 1} \subset \{\overline{P\Delta} \in P\Omega_{v,k} \mid v \in BT_0, z \in \overline{P\Delta}\}$  forms a fundamental neighborhood around z = 0 of compact open subsets of  $\mathbb{P}^1(F)$ .

(ii) This is an immediate corollary of (i).

# 3.4. Containment relations between the orbits.

**3.4.1.** Another description of  $\operatorname{Ind}_B^G(\chi)$ . We define an locally *F*-analytic embedding  $s: \mathbb{P}^1(F) \to G$  by

$$s(z) = \begin{pmatrix} 1 & 0 \\ z & 1 \end{pmatrix}, \text{ if } |z| \le 1, \ s(z) = \begin{pmatrix} 0 & -1 \\ 1 & \frac{1}{z} \end{pmatrix}, \text{ if } |z| > 1.$$

Then, for every  $z \in \mathbb{P}^1(F)$  and  $g \in G$ , one has  $\xi(z,g) := s(z)gs(z.g)^{-1} \in B$  and

(3.4.2) 
$$g = \xi(0,g)s(0,g), \text{ and } \xi(z,gg') = \xi(z,g)\xi(z,g,g')$$

Lemma 3.4.3. The map

$$\zeta: \mathrm{Ind}_B^G(\chi) \longrightarrow C^{\mathrm{la}}(\mathbb{P}^1(F), E), \; \zeta(f)(z) = f(s(z))$$

is an isomorphism of topological vector spaces.

Proof. Because s and f are locally F-analytic, so is  $\zeta(f)$ . We define another map  $\tilde{\zeta} : C^{\operatorname{la}}(\mathbb{P}^1(F), E)) \to \operatorname{Ind}_B^G(\chi)$  by  $\tilde{\zeta}(f_1)(g) = \chi(\xi(0,g))f_1(s(0,g))$ . We leave it to the reader to check that these maps are continuous when  $\operatorname{Ind}_B^G(\chi)$  is equipped with the structure of a compact inductive limit, as explained in 3.1.1, and  $C^{\operatorname{la}}(\mathbb{P}^1(F), E)$  is also considered as a vector space of compact type, cf. [6, Lemma 2.1]. And it is easy to see that  $\zeta$  and  $\tilde{\zeta}$  are inverses of each other.

Using  $\zeta$  we equip  $C^{\text{la}}(\mathbb{P}^1(F), E)$  with a *G*-action. Explicitly, on  $f \in C^{\text{la}}(\mathbb{P}^1(F), E)$ , the group action is given by

(3.4.4) 
$$(g_{\chi}f)(z) = \chi(\xi(z,g))f(z.g)$$

If we write  $\chi(\operatorname{diag}(a,d)) = \chi_1(ad)\chi_2(d)$ , and if  $g = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$ , then 3.4.4 becomes

(3.4.5) 
$$(g_{\chi}f)(z) = \chi_1(ad - bc)\chi_2(bz + d)f\left(\frac{az + c}{bz + d}\right).$$

**Lemma 3.4.6.** Let v be a vertex in BT, then for every orbit  $P\Delta$  of  $G_v(k)$  there is an edge  $e = \{v, v'\}$  and an orbit  $P\Delta'$  of  $G_{v'}(k)$  which is contained properly in  $\Delta$ .

*Proof.* Without loss of generality we can assume that  $v = v_0 := [\mathcal{O} \oplus \mathcal{O}]$ . Then let  $P\Delta = \mathbf{B}_z(z_0, |\varpi|^k) \in P\Omega_{v_0,k}$ , if  $z_0 \in \mathbf{B}_z([\alpha], |\varpi|)$  for some  $\alpha \in \mathbf{F}_q$ , then  $G_{v_{\alpha,1}}(k)$  has as an orbit  $\mathbf{B}_z(z_0, |\varpi|^{k+1})$  where  $v_{\alpha,1}$  is as in 3.3.5. If  $P\Delta = \mathbf{B}_w(w_0, |\varpi|^k) \subset \mathbf{B}(\infty, |\varpi|)$  then by 3.3.3 we have  $P\Delta' = \mathbf{B}_w(w_0, |\varpi|^{k+1})$  as an orbit of  $G_{v_1}(k)$ .

**Lemma 3.4.7.** We have the following relations between  $G_v(k)$ -orbits for varying  $v \in BT_0$ .

(i) Let  $\{v, v'\} \in BT_1$  be an edge. Suppose there are  $P\Delta \in P\Omega_{v,k}$  and  $P\Delta' \in P\Omega_{v',k}$ such that  $\overline{P\Delta} \subset \overline{P\Delta}'$ . Then for any edge  $\{v'', v'\} \in BT_1$  with d(v, v'') = 2 there is  $P\Delta'' \in P\Omega_{v'',k}$  with  $\overline{P\Delta} \subset \overline{P\Delta}' \subset \overline{P\Delta}''$ .

(ii) Let  $\{v', v''\} \in BT_1$  be an edge. Suppose there are  $P\Delta' \in P\Omega_{v',k}$  and  $P\Delta'' \in P\Omega_{v'',k}$  such that  $\overline{P\Delta}' \subset \overline{P\Delta}''$ . Then there exists some  $\{v, v'\} \in BT_1$  with d(v, v'') = 2 and  $P\Delta \in P\Omega_{v,k}$  such that  $\overline{P\Delta} \subset \overline{P\Delta}' \subset \overline{P\Delta}''$ .

(iii) Let  $\{v', v''\} \in BT_1$  be an edge. Suppose that for some  $P\Delta' \in P\Omega_{v',k}$  and  $P\Delta'' \in P\Omega_{v'',k}$  we have  $\overline{P\Delta}' \subset \overline{P\Delta}''$ . Then

$$\overline{\mathbf{P}\Delta}' = \bigcup_{\substack{\{v',v\} \in BT_1, v \neq v'' \\ \mathbf{P}\Delta \in \mathbf{P}\Omega_{v,k} \\ \overline{\mathbf{P}\Delta} \subset \overline{\mathbf{P}\Delta'}}} \overline{\mathbf{P}\Delta}$$

*Proof.* (i) By 2.1.2 we can assume that  $v'' = v_0, v' = v_1$  and  $v = v_2$  where  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$  and  $v_1 = [(\varpi) \oplus \mathcal{O}]$  as before and  $v_2$  is defined as  $v_2 := [(\varpi^2) \oplus \mathcal{O}]$ .

We have already shown that the orbits of  $G_{v_0}(k)$  on  $\mathbb{P}^1(F)$  are discs of radius  $|\varpi|^k$ . On the other hand, the orbits of  $G_{v_1}(k)$  are discs of radius  $|\varpi|^{k-1}$  on  $\mathbf{B}_z(0,1)$  and discs of radius  $|\varpi|^{k+1}$  on  $\mathbf{B}_w(\infty, |\varpi|)$ . Similarly, orbits of  $G_{v_2}(k)$  on  $\mathbf{B}_z(0, |\varpi|^{-1})$  are discs of radius  $|\varpi|^{k-2}$  and on  $\mathbf{B}_w(\infty, |\varpi|^2)$  they are discs of radius  $|\varpi|^{k+2}$ .

Therefore, if for  $P\Delta \in P\Omega_{v_2,k}$ ,  $\overline{P\Delta}$  is contained in  $\overline{P\Delta}'$  for  $P\Delta' \in P\Omega_{v_1,k}$ , then  $\overline{P\Delta}$  is a disc of radius  $|\varpi|^{k+2}$  and  $\overline{P\Delta}'$  is a disc of  $|\varpi|^{k+1}$  containing it. But any such disc of radius  $|\varpi|^{k+1}$  is contained in a disc of radius  $|\varpi|^k$  which is an orbit of  $G_{v_0}(k)$ . This proves our claim.

(ii) For computational ease we pick  $v'' = v_0 = [\mathcal{O} \oplus \mathcal{O}]$  and  $v' = v_1 = [(\varpi) \oplus \mathcal{O}]$ . From 3.3.2 we see that if  $\overline{P\Delta}' \subset \overline{P\Delta}''$  with  $P\Delta' \in P\Omega_{v',k}$  and  $P\Delta'' \in P\Omega_{v'',k}$ then  $\overline{P\Delta}'$  is a disc of radius  $|\varpi|^{k+1}$  inside  $\mathbf{B}_w(\infty, |\varpi|)$ . Let  $a \in F$  belong to  $\overline{P\Delta}'$ , then choosing  $v = [(\varpi^2, 0), (a, 1)]$  and noting  $v = \begin{bmatrix} \varpi^2 & a \\ 0 & 1 \end{bmatrix} \cdot v_0$ , we can see that  $\begin{bmatrix} \varpi^2 & a \\ 0 & 1 \end{bmatrix}^{-1}$  transforms  $\mathbf{B}_w(\infty, |\varpi|^k)$  to  $P\Delta \in P\Omega_{v,k}$ , a disc of radius  $|\varpi|^{k+2}$  such that  $\overline{P\Delta} \subset \overline{P\Delta}' \subset \overline{P\Delta}''$ .

(iii) This is an extension of calculations of (ii), and it can be seen that the any disc of radius  $|\varpi|^{k+1}$  that is an orbit of  $G_{v_1}(k)$  is covered by a subset of discs of radius  $|\varpi|^{k+2}$  which are orbits of various  $G_v(K)$  with  $\{v_1, v\} \in BT_{1,2}$ .

**3.4.8.** Minimal Orbits. Recall that we partially order  $\overline{\Omega}_{0,k,n}$  and  $\overline{P\Omega}_{0,k,n}$  via inclusion. Then we define

$$\overline{\Omega}_{0,k,n}^{\min} := \left\{ \overline{\Delta} \in \overline{\Omega}_{0,k,n} \middle| \overline{\Delta} \text{ minimal w.r.t. the partial ordering of } \overline{\Omega}_{0,k,n} \right\}$$

and

 $\overline{\mathrm{P}\Omega}_{0,k,n}^{\min} := \left\{ \overline{\mathrm{P}\Delta} \in \overline{\mathrm{P}\Omega}_{0,k,n} \middle| \ \overline{\mathrm{P}\Delta} \ \text{ minimal w.r.t. the partial ordering of } \overline{\mathrm{P}\Omega}_{0,k,n} \right\} \,.$ 

**Lemma 3.4.9.** Fix  $P\Delta \in P\Omega_{v,k}$  with  $v \in BT_{0,n}$ , let  $n \ge 1$ .

(a)  $\overline{P\Delta} \in \overline{P\Omega}_{0,k,n}$  belongs to  $\overline{P\Omega}_{0,k,n}^{\min}$  iff both of the following conditions hold

(*i*)  $d(v, v_0) = n$ 

(ii) Let  $v_1$  be the unique vertex of BT such that  $\{v, v_1\} \in BT_{1,n}$ . Then there exists  $P\Delta_1 \in P\Omega_{v_1,k}$  such  $\overline{P\Delta} \subset \overline{P\Delta}_1$ .

(b) Condition (ii) above is equivalent to the condition

(ii)' For every vertex  $v' \in BT_{0,n}$  if  $v = v_1, \cdots, v_m = v'$  is the path connecting vand v' there exists  $P\Delta_i \in P\Omega_{v_i,k}$  such that  $\overline{P\Delta} = \overline{P\Delta}_1 \subset \cdots \subset \overline{P\Delta}_m$ .

*Proof.* (b) To see the equivalence of (ii)' and (ii) we first note that (ii)' definitely implies (ii).

Now assume (ii) holds, i.e., there are orbits  $P\Delta \in P\Omega_{v,k}$  and  $P\Delta_1 \in P\Omega_{v_1,k}$  such that  $\overline{P\Delta} \subset \overline{P\Delta}_1$ , where  $v_1$  is the unique neighboring vertex of v in  $BT_{0,n}$ . For any vertex  $v' \in BT_{0,n}$  let the path connecting v, v' be  $v, v_1, \dots, v_m = v'$ . Then by 3.4.7 we can find an orbit  $P\Delta_2$  in  $P\Omega_{v_2,k}$  such that  $\overline{P\Delta} \subset \overline{P\Delta}_1 \subset \overline{P\Delta}_2$ . Continuing .this process we get a chain of nested orbits as in (ii)'

(a) We give a proof of (i) and (ii)' below.

First, suppose  $\overline{P\Delta}$  is minimal in  $\overline{P\Omega}_{0,k,n}$ . Then,  $d(v_0, v) = n$ , because otherwise all adjacent vertices v' with d(v, v') = 1 are also in  $BT_{0,n}$ , and hence, by 3.4.6, any orbit of  $G_v(k)$  properly contains an orbit of  $G_{v'}(k)$  for some such v'. And thus is not minimal in  $\Omega_{0,k,n}$ . We thus have  $d(v_0, v) = n$ .

Let  $v_2$  be the unique vertex adjacent to  $v = v_1$  and contained in  $BT_{0,n}$ . Then every orbit of  $G_v(k)$  is contained in an orbit of  $G_{v_2}(k)$ , or contains an orbit of  $G_{v_2}(k)$ . Since  $\overline{P\Delta} = \overline{P\Delta}_1$  is minimal,  $\overline{P\Delta}$  is contained in  $\overline{P\Delta}_2$  for an orbit  $\overline{P\Delta}_2$  of  $G_{v_2}(k)$ . Now let  $v' \neq v$  be any vertex in  $BT_{0,n}$  (the assertion is trivial for v' = v). Let  $v = v_1, v_2, ..., v_m = v'$  be the path from v to v'. As we have seen,  $\overline{P\Delta}_1$  is contained in  $\overline{P\Delta}_2$  for an orbit  $P\Delta_2$  of  $v_2$ . By 3.4.7 we then find an orbit  $P\Delta_3$  of  $G_{v_3}(k)$  such that  $\overline{P\Delta}_2 \subset \overline{P\Delta}_3$ , and repeatedly applying 3.4.7 in the same way we conclude that (ii)' holds true.

Conversely, assume that  $P\Delta$  satisfies assumption (ii)'. Suppose  $\overline{P\Delta}$  properly contains  $\overline{P\Delta}'$  for an orbit  $P\Delta'$  of some  $G_{v'}(k)$  with v' in  $BT_{0,n}$ . Let  $v = v_1, ..., v_m = v'$  and  $\overline{P\Delta} = \overline{P\Delta}_1 \subset \overline{P\Delta}_2 \subset ... \subset \overline{P\Delta}_m$  be as in (ii). Then  $\overline{P\Delta}' \subsetneq \overline{P\Delta} \subset \overline{P\Delta}_m$  is a contradiction, because  $P\Delta'$  and  $P\Delta_m$  are both orbits of  $G_{v'}(k)$ . Hence  $P\Delta$  is minimal.

**Proposition 3.4.10.** If  $v, v' \in BT_{0,n}$ , and if  $P\Delta \in P\Omega_{v,k}$  and  $P\Delta' \in P\Omega_{v',k}$  are such that their images in  $\overline{P\Omega}_{0,k,n}$  are minimal and (whose underlying sets) are equal, then v = v'.

*Proof.* Let  $P\Delta \in P\Omega_{v,k}$  and  $P\Delta' \in P\Omega_{v',k}$  belong to  $\overline{P\Omega}_{0,k,n}$  and assume  $\overline{P\Delta} = \overline{P\Delta'}$ . Let  $v = v_1, v_2, ..., v_m = v'$  be the path from v to v'. By 3.4.9 there exists  $P\Delta_i \in P\Omega_{v_i,k}$  such that  $\overline{P\Delta} = \overline{P\Delta}_1 \subset \cdots \subset \overline{P\Delta}_m$ . Note that  $\overline{P\Delta}_1 \neq \overline{P\Delta}$  since by 3.3.3  $P\Omega_{v,k} \cap P\Omega_{v_1,k} = \emptyset$ . Hence, in particular  $\overline{P\Delta'} \subseteq \overline{P\Delta}_m \in P\Omega_{v',k}$ . Which is a contradiction.

**Lemma 3.4.11.**  $\overline{P\Omega}_{0,k,n}^{\min}$  forms a disjoint covering of  $\mathbb{P}^1(F)$  for all  $n \geq 1$ .

*Proof.* This is evidently true for n = 0.

Assuming it is true for n-1,  $n \ge 1$ , observe that it is enough to prove  $\overline{P\Omega}_{0,k,n}^{\min}$  forms a covering of  $\overline{P\Omega}_{0,k,n-1}^{\min}$ . Let  $\overline{P\Delta}' \in \overline{P\Omega}_{0,k,n-1}^{\min}$  then there exists a  $P\Delta'' \in P\Omega_{v'',k}$ with  $\{v',v''\} \in BT_1$  such that  $\overline{P\Delta}' \subset \overline{P\Delta}''$  (this is true for n = 1 by 3.3.3 and 3.3.5). Then by 3.4.7  $\overline{P\Delta}'$  is covered by disjoint sets  $\overline{P\Delta} \in P\Omega_{v,k}$  with  $\overline{P\Delta} \subset \overline{P\Delta}' \subset \overline{P\Delta}''$ where v ranges over all vertices of BT such that  $\{v,v'\} \in BT_1, v \neq v''$ . But such a  $\overline{P\Delta} \in \overline{P\Omega}_{0,k,n}^{\min}$  by 3.4.9. This proves our claim.

**Remark 3.4.12.** The bijection between  $\Omega_{v,k}$  and  $P\Omega_{v,k}$  naturally extends to  $\Omega_{0,k,n}$ and  $P\Omega_{0,k,n}$ , and the containment relations stated in this section about elements of  $P\Omega_{0,k,n}$  can be applied exactly in the same way to elements of  $\Omega_{0,k,n}$ . With this remark we will shift to working with  $\Omega_{0,k,n}$  in the subsequent sections. Further, let

$$\Omega_{0,k,n}^{\min} = \mathrm{pr}^{-1}(\overline{\Omega}_{0,k,n}^{\min})$$

Note that 3.4.10 applies to  $\Omega_{0,k,n}$  and  $\overline{\Omega}_{0,k,n}$  as well and pr :  $\Omega_{0,k,n}^{\min} \to \overline{\Omega}_{0,k,n}^{\min}$  is a bijection.

Remark 3.4.13. We record the following containment relations

(i) From 3.4.9 we see that for any  $v \in BT_{0,n-1}$  we have

$$\Omega_{v,k} \cap \Omega_{0,k,n}^{\min} = \emptyset$$

(ii) From (iv) of 3.3.3 and 3.4.9 it follows that for any  $\Delta \in \Omega_{e,k}$  with  $e = \{v, v'\}$  and  $d(e, v_0) = n$ ,

$$\Omega_{e,k} \cap \Omega_{0,k,n}^{\min} = \emptyset$$

3.5. **Detailed description of rigid analytic vectors.** We will need the following lemma to prove an important detail in the subsequent lemma.

**Lemma 3.5.1.** Let  $\mathbb{H}$  be an affinoid rigid analytic group over F, and assume that  $\mathbb{H}$  is isomorphic as a rigid analytic space to  $\mathbb{B}^d$  via a chart  $x : \mathbb{H} \to \mathbb{B}^d$ . Let  $\mathbb{U}$  be an affinoid rigid analytic space which is equipped with a rigid analytic action of  $\mathbb{H}$  from the right. Furthermore, we assume that there is  $z_0 \in U = \mathbb{U}(F)$  and a closed rigid analytic subgroup  $\mathbb{H}' \subset \mathbb{H}$  such that the map  $\mathbb{H}' \to \mathbb{U}$ ,  $h \mapsto z_0.h$ , is an isomorphism of rigid analytic spaces.

We let H act on  $V = C^{\mathrm{la}}(U, E)$  by (g.f)(z) = f(zg). Then  $f \in V$  is  $\mathbb{H}$ -analytic if and only if  $f \in \mathcal{O}(\mathbb{U})$ .

*Proof.* (i) If  $f \in \mathcal{O}(\mathbb{U})$ , then we consider f as a rigid analytic morphism  $f : \mathbb{U} \to \mathbb{A}^{1,\mathrm{rig}}$ . Because the group action  $\mu : \mathbb{U} \times \mathbb{H} \to \mathbb{U}$  is a rigid analytic morphism, so is  $f \circ \mu$ , and hence  $f \circ \mu \in \mathcal{O}(\mathbb{U} \times \mathbb{H}) = \mathcal{O}(\mathbb{U}) \widehat{\otimes}_F \mathcal{O}(\mathbb{H}) = \mathcal{O}(\mathbb{U}) \langle x_1, \ldots, x_d \rangle$ , where the latter is the ring of strictly convergent power series over the Banach algebra  $\mathcal{O}(\mathbb{U})$ . Then, for  $h \in \mathbb{H}$  and  $z \in \mathbb{U}$  we have

$$(h.f)(z) = f(z.h) = (f \circ \mu)(z,h) = \sum_{\nu \in \mathbb{N}^d} f_{\nu}(z)x(h)^{\nu}$$

And hence f is  $\mathbb{H}$ -analytic.

(ii) Conversely, if f is  $\mathbb{H}$ -analytic, then we can write

$$h.f = \sum_{\nu \in \mathbb{N}^d} f_{\nu} x(h)^{\nu}$$

where all functions  $f_{\nu}$  are in a single BH-subspace of  $C^{\text{la}}(U, E)$ . This means that there is a finite covering  $(U_i)_{i=1}^n$  of U consisting of disjoint compact open subsets. After refining this covering, we may assume that each  $U_i$  is the set of F-valued points of an afinoid subspace  $\mathbb{U}_i \subset \mathbb{U}$ . Put  $\mathbb{U}' = \prod_{i=1}^n \mathbb{U}_i$ , which is again an affinoid subdomain of  $\mathbb{U}$ , and which has the property that  $\mathbb{U}'(F) = \mathbb{U}(F) (= U)$ . The functions  $f_{\nu}$  are then all in  $\mathcal{O}(\mathbb{U}')$ , and we have

$$||f_{\nu}||_{\mathbb{U}'} \cdot \sup\{|x(h)^{\nu}| \mid h \in \mathbb{H}\} \longrightarrow 0 \text{ as } |\nu| \to \infty.$$

If  $z_0 \in U = \mathbb{U}'(F)$  is as in the statement of the lemma, we find for all  $h \in H$ :

(3.5.1) 
$$f(z_0h) = \sum_{\nu} f_{\nu}(z_0) x(h)^{\nu}$$

The right hand side of 3.5.1 makes sense and converges for all  $h \in \mathbb{H}$ , and is thus a rigid analytic function on  $\mathbb{H}$ . When we restrict the right hand side of 3.5.1 to  $\mathbb{H}'$  it is hence rigid analytic on  $\mathbb{H}'$ . Let  $\alpha : \mathbb{H}' \to \mathbb{U}$ , be defined by  $h \mapsto z_0.h$ . Then we find that  $f \circ \alpha$  is a rigid analytic map on  $\mathbb{H}'$ , and  $f = (f \circ \alpha) \circ \alpha^{-1}$  is rigid analytic on  $\mathbb{U}$ .

**Lemma 3.5.2.** There exists  $k_0 = k_0(\chi) \in \mathbb{Z}_{\geq 1}$  such that for all  $k \geq k_0$  the following statements holds. If  $e = \{v, v'\}$  is a vertex and  $\Delta \in \Omega_{e,k} \cap \Omega_{v,k}$ , then

$$I(\Delta, \chi)_{\mathbb{G}_e(k)-\mathrm{an}} = I(\Delta, \chi)_{\mathbb{G}_v(k)-\mathrm{an}}$$

Proof. Let  $\Delta \leftrightarrow P\Delta$  be the bijection  $\Omega_{v,k} \leftrightarrow P\Omega_{v,k}$ , as in 3.3.6. We set  $I(P\Delta) = C^{\text{la}}(P\Delta, E)$ . Under the bijection  $\zeta$  of 3.4.3, the space  $I(\Delta, \chi)$  gets mapped isomorphically to  $I(P\Delta)$ . The latter carries the action of  $G_e(k)$  (and hence of  $G_v(k) \subset G_e(k)$ ) defined by 3.4.5. With respect to this group action, it suffices to show that

(3.5.3) 
$$I(P\Delta)_{\mathbb{G}_e(k)-\mathrm{an}} = I(P\Delta)_{\mathbb{G}_v(k)-\mathrm{an}}$$

From the transitivity of the G-action on  $BT_0$  and  $BT_1$  it is easy to see given any two pairs  $(v_1, e_1), (v_2, e_2)$  with  $v_i \in BT_0$  and  $e_i \in BT_1$  there is a  $g \in G$  such that  $(g.v_2, g.e_2) = (v_1, e_1)$ . It follows that  $G_{e_1}(k) = gG_{e_2}(k)g^{-1}$  and  $G_{v_1}(k) =$  $gG_{v_2}(k)g^{-1}$ . From [2, 3.5.1] it follows that for  $P\Delta \in \Omega_{e_1,k} \cap \Omega_{v_1,k}$  one has

(3.5.4) 
$$g.\left(I(\mathbf{P}\Delta)_{\mathbb{G}_{e_1}(k)-\mathrm{an}}\right) = I(\mathbf{P}\Delta.g)_{\mathbb{G}_{e_2}(k)-\mathrm{an}}$$

(3.5.5) 
$$g.\left(I(\mathbf{P}\Delta)_{\mathbb{G}_{v_1}(k)-\mathrm{an}}\right) = I(\mathbf{P}\Delta.g)_{\mathbb{G}_{v_2}(k)-\mathrm{an}}$$

In particular, it suffices to show 3.5.3 for a single pair (v, e) which we are free to choose. The following choice is particularly convenient:  $e = \{v, v'\}$  with  $v = [\mathcal{O} \oplus \mathcal{O}]$  and  $v' = [(\varpi) \oplus \mathcal{O}]$ . By computations in 3.3.3 any  $P\Delta \in P\Omega_{v,k} \cap P\Omega_{e,k}$  is of the form  $\mathbf{B}_z(a, |\varpi|^k)$  with  $|a| \leq 1$ . Now action of  $G_e(k)$  and  $G_v(k)$  on  $I(P\Delta)$  is given by

$$(g_{\chi}f)(x) = \chi_1(\det g)\chi_2(bx+d)f(z.g)$$

Note that for all  $g \in G_e(k)$  one has  $|\det g - 1| \leq |\varpi|^k$ , (and automatically for  $g \in G_v(k)$ , since  $G_v(k) \subset G_e(k)$ ) and for all  $|x| \leq 1$  and for all  $g \in G_e(k)$  one has  $|bx+d-1| \leq |\varpi|^k$ . Thus for large enough k by local analyticity of  $\chi_1$  and  $\chi_2$  we can make sure that both  $\chi_1(\det g)$  and  $\chi_2(bx+d)$  are expressible as a power series for  $x \in \mathbf{B}_z(a, |\varpi|^k)$  and  $g \in G_e(k)$ . Now we see from 3.5.1 that both  $I(\mathrm{P}\Delta, \chi)_{\mathbb{G}_e(k)-\mathrm{an}}$  and  $I(\mathrm{P}\Delta, \chi)_{\mathbb{G}_v(k)-\mathrm{an}}$  are same as  $\mathcal{O}(\mathrm{P}\Delta)$ . Here we have used 3.5.1 twice with  $\mathbb{H} = \mathbb{G}_e(k)$  and  $\mathbb{H} = \mathbb{G}_v(k)$ , respectively. This finishes the proof.

## 3.6. Surjectivity of $\partial_0$ .

**Proposition 3.6.1.** There exists  $k_0 = k_0(\chi) \in \mathbb{Z}_{\geq 1}$  such that for all  $k \geq k_0$ , the map  $\partial_0 : \bigoplus_{v \in BT_0} V_v \longrightarrow V$  is surjective.

Proof. Let  $f \in C^{\mathrm{la}}(\mathbb{P}^1(F), E)$ . Let us partition  $\mathbb{P}^1(F)$  into finitely many discs such that f restricted to each of these discs is a rigid analytic function on that disc. Let  $\alpha \in \mathbb{P}^1(F)$  and  $\mathbf{B}_{\alpha}$  be the disc containing  $\alpha$  such that  $f|_{\mathbf{B}_{\alpha}} \in \mathcal{O}(\mathbf{B}_{\alpha})$ . Let  $g \in G$  be such that  $\alpha = 0.g$  and let  $0 \in U$  be a neighborhood around 0 such that  $U.g = \mathbf{B}_{\alpha}$ . For  $v_n := [\mathcal{O} \oplus (\varpi^n)]$  we can show that  $\mathbf{B}_z(0, |\varpi|^{k+n}) \in \mathrm{P}\Omega_{v_n,k}$ . Thus for any  $k \geq 0$  there exists  $n \geq 0$  such that  $\mathbf{B}_z(0, |\varpi|^{k+n}) \subset U$ . By 3.4.5 the group action is given by the formula

$$(g_{\chi}f)(z) = \chi_1(\det g)\chi_2(bz+d)f(z.g)$$

Note that for all  $g \in G_{v_n}(k)$  and for all  $z \in \mathbf{B}(0, |\varpi|^{k+n})$  one has  $|\det g - 1| \le |\varpi|^k$ , and  $|bz + d - 1| \le |\varpi|^k$ .

Since f(z.g) is rigid analytic in  $\mathbf{B}(0, |\varpi|^{k+n})$ , by 3.5.1 we see that for large enough  $k = k_0(\chi)$  we have  $(g_{\cdot\chi}f)|_{\mathbf{B}(0,|\varpi|^{k+n})} \in V_{v_n}$ , note that  $k_0(\chi)$  depends only on  $\chi$  and not on the choice of f. Let  $U_{\alpha} = \mathbf{B}_z(0, |\varpi|^{k+n}).g$ , then it is clear that  $U_{\alpha} \in P\Omega_{g.v_n,k}$  and by 3.5.5 it follows that  $f|_{U_{\alpha}} \in V_{g.v_n}$ . For each  $\alpha \in \mathbb{P}^1(F)$  we find such a neighborhood  $U_{\alpha}$  and assign a unique vertex  $v_{\alpha}$  using the process above with  $f|_{U_{\alpha}} \in V_{v_{\alpha}}$ . With this setup, for the covering  $\mathbb{P}^1(F) = \bigcup_{\alpha} U_{\alpha}$ , there is a disjoint finite sub-covering  $\mathcal{D}$  such that if we define

(3.6.2) 
$$f_v = \begin{cases} f|_{U_\alpha} &, v = v_\alpha, U_\alpha \in \mathcal{D} \\ 0 &, \text{ otherwise.} \end{cases}$$

Then we have

$$\partial_0((f_v)_v) = f$$

and

## 3.7. Counting Arguments.

**Lemma 3.7.1.** For any  $v \in BT_0$  and  $e \in BT_1$  (or  $BT_1^{\text{or}}$ ) we have

$$|\Omega_{v,k}| = q^{k-1} + q^k = (q+1)q^{k-1}, \ |\Omega_{e,k}| = 2q^{k-1}$$

Proof. By 3.3.4, the sets  $\Omega_{v,k}$  and  $\Omega_{v',k}$ , for any two vertices  $v, v' \in BT_0$ , have the same cardinality. By 3.3.6,  $\Omega_{v,k}$  and  $P\Omega_{v,k}$  have the same cardinality, hence it is enough to find  $|P\Omega_{v_0,k}|$  where  $v_0 = [\mathcal{O} \oplus \mathcal{O}]$  as above. From the descriptions as given in 3.3.3 we see that the orbits of  $G_{v_0}(k)$  in both  $\mathbf{B}_z(0,1)$  and  $\mathbf{B}_w(\infty,|\varpi|)$  are balls of radius  $|\varpi|^k$ . Thus  $|P\Omega_{v_0,k}| = \frac{1}{|\varpi|^k} + \frac{|\varpi|}{|\varpi|^k} = q^k + q^{k-1}$ . Similarly, we compute  $|P\Omega_{e,k}|$ , where  $e = \{v_0, v_1\}$  with  $v_1 = [(\varpi) \oplus \mathcal{O}]$  by the explicit description in 3.3.3.

**Lemma 3.7.2.** Given a vertex  $v \in BT_0$  with  $d(v, v_0) = n$ ,

$$|\Omega_{v,k} \cap \Omega_{0,k,n}^{\min}| = q^k$$

Proof. Given such a vertex v, let v' be the unique vertex in  $BT_{0,n-1}$  such that  $\{v,v'\} \in BT_{1,n}$ . Then by 3.4.9  $\Delta \in \Omega_{v,k}$  belongs to  $\Omega_{0,k,n}^{\min}$  iff  $\overline{\Delta} \subset \overline{\Delta}'$  for some  $\Delta' \in \Omega_{v',k}$ . By transitivity of G-action on  $BT_1$ , we can look at the vertices  $v_0, v_1$  constituting the edge  $e = \{v_0, v_1\}$  where  $v_0, v_1$  are as in 2.1.4. By 3.3.3 (ii),  $\Omega_{v',k}^v := \{\Delta' \in \Omega_{v',k} \mid \exists \Delta \in \Omega_{v,k} : \Delta \subset \Delta'\}$  has cardinality  $q^{k-1}$  and each  $\Delta' \in \Omega_{v',k}^v$  contains q orbits of  $\Omega_{v,k}$ .

Recall that we have remarked in 3.3.7 that  $\Omega_{1,k} \subset \Omega_{0,k}$  and in fact it is easy to see that this induces an inclusion  $\Omega_{1,k,n} \subset \Omega_{0,k,n}$  on these subsets. With this identification in place we claim,

## Proposition 3.7.3.

$$\Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min} = \Omega_{1,k,n}$$

*Proof.* Recall that from 3.4.13 it follows that  $\Omega_{1,k,n} \cap \Omega_{0,k,n}^{\min} = \phi$ . Thus, from the remark just before the proposition, it is enough to prove  $|\Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min}| = |\Omega_{1,k,n}|$ . First we compute  $|\Omega_{1,k,n}|$ .

$$\begin{aligned} |\{e \in BT_1^{\text{or}} | d(v_0, e) = i\}| &= (q+1).q^{i-1} \\ |BT_{1,n}^{\text{or}}| &= \sum_{i=1}^n |\{e \in BT_1^{\text{or}} | d(v_0, e) = i\}| \\ &= (q+1).q^0 + \dots + (q+1)q^{n-1} \\ &= (q+1)\frac{q^n - 1}{q-1} \\ |\Omega_{e,k}| &= 2q^{k-1} \\ |\Omega_{1,k,n}| &= |\Omega_{e,k}| \times |BT_{1,n}^{\text{or}}| = 2q^{k-1}(q+1)\frac{q^n - 1}{q-1} \end{aligned}$$

where the last but one formula is 3.7.1. To find  $|\Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min}|$  first we collect the following (where here  $i \ge 1$  in the first formula)

$$\begin{aligned} |\{v \in BT_0 | d(v_0, v) = i\}| &= (q+1).q^{i-1} \\ |BT_{0,n-1}| &= 1 + (q+1)q^0 + \dots + (q+1)q^{n-2} \\ |\Omega_{0,k,n}^{\min} \cap \Omega_{v,k}| &= 0 \quad \text{if} \quad d(v_0, v) \le n-1 \quad (3.4.13 \text{ (i)}) \\ |\Omega_{0,k,n}^{\min} \cap \Omega_{v,k}| &= q^k \quad \text{if} \quad d(v_0, v) = n \quad (3.7.2) \end{aligned}$$

Putting all these together we get

$$\begin{aligned} & \left| \Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min} \right| = (q+1)q^{k-1} |BT_{0,n-1}| + q^{k-1}| \{ v \in BT_0 | d(v_0, v) = n \} | \\ & = (q+1)q^{k-1}(1 + (q+1)q^0 + \dots + (q+1)q^{n-2}) + q^{k-1}.(q+1).q^{n-1} \\ & = (q+1)q^{k-1}(1 + q + 1 + q^2 + q + \dots + q^{n-1} + q^{n-2} + q^{n-1}) \\ & = 2q^{k-1}(q+1)\frac{q^n - 1}{q-1} \end{aligned}$$

## 3.8. Exactness in the middle. Let,

$$\begin{split} C_{0,n,k} &= \bigoplus_{\substack{\Delta \in \Omega_{v,k} \\ v \in BT_{0,n}}} I(\Delta,\chi)_{\mathbb{G}_v(k)-\mathrm{an}}, \\ C_{1,n,k}^{\mathrm{or}} &= \bigoplus_{\substack{\Delta \in \Omega_{e,k} \\ e \in BT_{1,n}^{\mathrm{or}}}} I(\Delta,\chi)_{\mathbb{G}_e(k)-\mathrm{an}} \end{split}$$

In order to show that the sequence 2.2.1 is exact in the middle, it is enough to show that

$$0 \to C_{1,n,k}^{\mathrm{or}} \xrightarrow{\partial_1} C_{0,n,k} \xrightarrow{\partial_0} V \to 0$$

is exact in the middle for every  $n \ge 1$ , where  $\partial_1$  and  $\partial_0$  denote what technically are restrictions of those maps to  $C_{1,n,k}^{\text{or}}$  and  $C_{0,n,k}$  respectively.

**3.8.1.** Some sub-spaces of  $C_{0,n,k}$ . We put

$$C_{0,n,k}^{\min} = \bigoplus_{\Delta \in \Omega_{0,k,n}^{\min}} I(\Delta, \chi)_{\mathbb{G}_v(k) - \mathrm{an}}$$

and

$$C_{0,n,k}^{\mathrm{non-min}} = \bigoplus_{\Delta \in \Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\mathrm{min}}} I(\Delta,\chi)_{\mathbb{G}_v(k)-\mathrm{an}} \; .$$

In the following, we write an element

$$f_v \in V_v = \bigoplus_{\Delta' \in \Omega_{v,k}} I(\Delta', \chi)_{\mathbb{G}_v(k)-\mathrm{and}}$$

as  $f_v = (f_{\Delta',v})_{\Delta' \in \Omega_{v,k}}.$ 

**Lemma 3.8.2.** Given k > 0 let v, v' be vertices in  $BT_{0,n}$  and let  $\Delta \in \Omega_{v,k}$  and  $\Delta' \in \Omega_{v',k}$  be such that  $\overline{\Delta} \subset \overline{\Delta}'$  and  $\Delta \in \Omega_{0,k,n}^{\min}$ . Then for  $f \in I(\Delta', \chi)_{\mathbb{G}'_v(k)-\mathrm{an}}$  we have  $f|_{\Delta} \in I(\Delta, \chi)_{\mathbb{G}_v(k)-\mathrm{an}}$ 

*Proof.* Let us first note that for an edge  $e = \{v, v'\} \in BT_1$  such that  $\overline{\Delta} \subset \overline{\Delta}'$  with  $\Delta' \in \Omega_{v',k}$  and  $\Delta \in \Omega_{v,k}$  we have  $\Delta' \in \Omega_{e,k}$  (by 3.3.3 (v)). Now by 3.5.2 we have  $I(\Delta', \chi)_{\mathbb{G}'_v(k)-\mathrm{an}} = I(\Delta', \chi)_{\mathbb{G}_e(k)-\mathrm{an}}$ . For  $f \in I(\Delta', \chi)_{\mathbb{G}_{v'}(k)-\mathrm{an}} = I(\Delta, \chi)_{\mathbb{G}_e(k)-\mathrm{an}} \subset V_e$  we have  $f|_{\Delta} \in I(\Delta, \chi)_{\mathbb{G}_v(k)-\mathrm{an}}$ , since  $V_e \hookrightarrow V_v$ .

Now let d(v, v') > 1 and let  $v = v_0, \dots, v_m = v'$  be the path from v to v'. By 3.4.9 we have, for  $\Delta \in \Omega_{0,k,n}^{\min}$  a nested sequence of double cosets (seen as a subset of G)  $\overline{\Delta} = \overline{\Delta}_0 \subset \overline{\Delta}_1 \subset \overline{\Delta}_{n-1} \subset \cdots \subset \overline{\Delta}_m = \overline{\Delta}'$  with  $\Delta_i \in \Omega_{v_i,k}$ . Let  $e_i := \{v_i, v_{i+1}\} \in BT_1$ . Since  $\overline{\Delta}_i \subset \overline{\Delta}_{i+1}$  by 3.3.3 (v) we have that  $\Delta_{i+1} \in \Omega_{e_i,k}$ . Thus

 $I(\Delta_{i+1}, \chi)_{\mathbb{G}_{v_i}(k)-\mathrm{an}} = I(\Delta_{i+1}, \chi)_{\mathbb{G}_{v_{i+1}(k)}-\mathrm{an}}$  and we successively get that  $f|_{\Delta_i} \in I(\Delta_i, \chi)_{\mathbb{G}_{v_i}(k)-\mathrm{an}}$  for each *i*. Proving our claim.  $\Box$ 

Lemma 3.8.3. The projection of

(3.8.4) 
$$C_{0,n,k} = C_{0,n,k}^{\min} \oplus C_{0,n,k}^{\text{non-min}}$$

onto  $C_{0,n,k}^{\text{non-min}}$  maps  $\operatorname{Ker}(C_{0,n,k} \xrightarrow{\partial_0} V)$  isomorphically onto  $C_{0,n,k}^{\text{non-min}}$ .

*Proof.* By 3.4.11 the union of the minimal orbit in  $\overline{P\Omega}_{0,k,n}$  is equal to  $\mathbb{P}^1(F)$ . Hence, the union of the minimal double cosets in  $\Omega_{0,k,n}$  is equal to G. Now, if  $(f_v)_{v \in BT_{0,n}}$  is in ker $(\partial_0)$ , then  $\sum_{v \in BT_{0,n}} \sum_{\Delta' \in \Omega_{v,k}} f_{\Delta',v} = 0$ . Now we restrict both sides of this equation to a minimal double coset  $\Delta \in \Omega_{0,k,n}^{\min}$  and obtain

$$\sum_{\Delta' \in \Omega_{0,k,n}} \sum_{\Delta' \supset \Delta} f_{\Delta',v} |_{\Delta} = 0 ,$$

equivalently

$$f_{\Delta,v} = -\sum_{\Delta' \in \Omega_{0,k,n}} \sum_{\Delta' \supsetneq \Delta} f_{\Delta',v'}|_{\Delta} \ .$$

This shows that the components  $f_{\Delta,v}$  with  $\Delta \in \Omega_{v,k}$  and in  $\Omega_{0,k,n}^{\min}$  are uniquely determined by the other components. Note that by 3.8.2 we see that  $f_{\Delta',v'}|_{\Delta} \in I(\Delta,\chi)_{\mathbf{G}_v(k)-\mathrm{an}}$  for any  $\Delta \in \Omega_{v,k}$  such that  $\Delta \in \Omega_{0,k,n}^{\min}$  and  $\overline{\Delta} \subset \overline{\Delta}'$ . So the equation is well-defined in particular. Conversely, for any element

$$(f_{\Delta',v})_{\Delta'\in\Omega_{0,k,n}\setminus\Omega_{0,k,n}^{\min}}\in C_{0,n,k}^{\operatorname{non-m}}$$

we obtain an element  $(f_v)_v$  of ker $(\partial_0)$  by defining the components  $f_{\Delta,v}$  for  $\Delta \in \Omega_{v,k}$ and in  $\Omega_{0,k,n}^{\min}$  by the previous equation, the equation being well defined by 3.8.2. This proves our claim.

Let  $p: C_{0,n,k} \to \ker(\partial_0)$  be the projection on to the second summand as in 3.8.4. With these identifications we write the composition map as

$$C_{1,n,k}^{\mathrm{or}} \xrightarrow{\partial_1} C_{0,n,k} \xrightarrow{p} \ker(\partial_0)$$

and call it,  $\overline{\partial}_1 := p \circ \partial_1$ .

**Proposition 3.8.5.** There exists some  $k_0(\chi) \in \mathbb{Z}_{>0}$  such that for all  $k \ge k_0(\chi)$  the composite map  $\overline{\partial}_1 = p \circ \partial_1$  is an isomorphism from  $C_{1,k,n}^{\text{or}}$  onto  $\ker(\partial_0)$ .

*Proof.* We refine the partial ordering on  $\overline{\Omega}_{0,k,n}$  to a total ordering on  $\Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min}$ . By 3.5.2 and 3.7.3  $C_{1,k,n}$  maps isomorphically onto  $C_{0,k,n}^{\text{non-min}}$  for all  $k \geq k_0(\chi)$  for some  $k_0(\chi) \in \mathbb{Z}_{>0}$ . Thus we can view (for  $k \geq k_0(\chi)$ )  $\overline{\partial}_1$  explicitly as a map between

$$\left[\bigoplus_{\Delta\in\Omega_{0,k,n}\backslash\Omega_{0,k,n}^{\min}}I(\Delta,\chi)_{\mathbb{G}_v(k)-\mathrm{an}}\right]\xrightarrow{\overline{\partial}_1}\left[\bigoplus_{\Delta\in\Omega_{0,k,n}\backslash\Omega_{0,k,n}^{\min}}I(\Delta,\chi)_{\mathbb{G}_v(k)-\mathrm{an}}\right]$$

Let us define for  $e = \{v_1, v_2\} \in BT_1$ ,  $\operatorname{sgn}_{v_i}^e = \begin{cases} 1 & \text{if } (v_i, v_j) \in BT_1^{\operatorname{or}} \\ -1 & \text{if } (v_j, v_i) \in BT_1^{\operatorname{or}} \end{cases}$ 

Given  $f_{\Delta,v} \in I(\Delta,\chi)_{\mathbb{G}_e-\mathrm{an}} = I(\Delta,\chi)_{\mathbb{G}_v-\mathrm{an}}$  for some  $e = \{v,v'\} \in BT_{1,n}$  and  $\Delta \in \Omega_{e,k} \cap \Omega_{v,k}$  indexing elements of  $\bigoplus_{\Delta \in \Omega_{0,k,n} \setminus \Omega_{0,k,n}^{\min}} I(\Delta,\chi)_{\mathbb{G}_v(k)-\mathrm{an}}$  as  $(f_{\Delta,v})_{\Delta,v}$  we see that,

$$\overline{\partial}_1(0,\cdots,f_{\Delta,v},\cdots,0)$$

 $= (g_{\Delta_{\alpha},v_{\alpha}})_{\Delta_{\alpha},v_{\alpha}}$ 

(3.8.6)

$$= \begin{cases} \operatorname{sgn}_{v}^{e} f_{\Delta,v} &, \text{ if } \Delta_{\alpha} = \Delta, v_{\alpha} = v, \\ \operatorname{sgn}_{v}^{e} f_{\Delta,v}|_{\Delta'} &, \text{ if } \Delta_{\alpha} = \Delta', v_{\alpha} = v', \overline{\Delta}' \subset \overline{\Delta} \\ 0 &, \text{ otherwise} \end{cases}$$

This shows that  $\overline{\partial}_1$  can be expressed as a lower triangular  $r \times r$  matrix with  $\pm Id$ on the diagonal and  $\pm \operatorname{res}_{\Delta'}^{\Delta}$  maps on the off-diagonal elements which corresponds to  $((\Delta, v), (\Delta', v'))$  such that  $\Delta' \subset \Delta$  and  $\{v, v'\} \in BT_1$  and 0 elsewhere, where  $r = 2q^{k-1}(q+1)\frac{q^n-1}{q-1}$  and  $\operatorname{res}_{\Delta'}^{\Delta'}(f_{\Delta,v}) := g_{\Delta',v'} = f_{\Delta}|_{\Delta'}$ . Thus  $\overline{\partial}_1$  is an isomorphism as claimed.  $\Box$ 

The exactness of the chain complex 2.2.1 for  $V := \text{Ind}_B^G(\chi)$  now follows from 3.2.1, 3.6.1 and 3.8.5.

3.9. An example of the matrix of  $\overline{\partial}_1$ . We give an example of the matrix of  $\overline{\partial}_1$  in the case of n = 1, k = 1. Let  $v^0, v^1, v^\infty$  be the vertices adjacent to  $v_0$ . Let  $\Delta_0, \Delta_1, \Delta_\infty$  be the B- $G_{v_0}(1)$  double cosets. Let  $e_0, e_1, e_\infty$  be the oriented edges connecting  $v_0$  (origin) with  $v^0, v^1, v^\infty$ , respectively. We may assume that  $\Delta_i$  and  $\Delta_{j\cup k} := \Delta_j \cup \Delta_k$  are the two B- $G_{e_i}(1)$  double cosets of  $G_{e_i}(1)$ , where  $\{i, j, k\} = \{0, 1, \infty\}$ . The group  $G_{v^i}(1)$  has then the B- $G_{v^i}(1)$  double cosets  $\Delta_0^i, \Delta_1^i$ , whose union is  $\Delta_i$ , and the double coset  $\Delta_{j\cup k}$  for  $j \neq i, k \neq i$  (and  $j \neq k$ ). We then have

$$\Omega_{0,1,1}^{\min} = \{ \Delta_0^0, \Delta_1^0, \Delta_0^1, \Delta_1^1, \Delta_0^\infty, \Delta_1^\infty \}$$

and

$$\Omega_{0,1,1}^{\text{non-min}} = \{\Delta_0, \Delta_1, \Delta_{\infty}, \Delta_{0\cup 1}, \Delta_{0\cup \infty}, \Delta_{1\cup \infty}\}$$

Let p be the projection from  $C_{0,n,k}$  to  $C_{0,n,k}^{\text{non-min}}$ , and set  $\overline{\partial}_1 = p \circ \partial_1$ . We write

$$C_{1,1,1}^{\text{or}} = I(\Delta_{1\cup\infty}, \chi)_{G_{e_0}-\text{an}} \oplus I(\Delta_{0\cup\infty}, \chi)_{G_{e_1}-\text{an}} \oplus I(\Delta_{0\cup1}, \chi)_{G_{e_{\infty}}-\text{an}} \oplus I(\Delta_0, \chi)_{G_{e_0}-\text{an}} \oplus I(\Delta_1, \chi)_{G_{e_1}-\text{an}} \oplus I(\Delta_\infty, \chi)_{G_{e_{\infty}}-\text{an}}$$

$$C_{0,1,1}^{\text{non-min}} = I(\Delta_{1\cup\infty},\chi)_{G_{v_{0,0}}-\text{an}} \oplus I(\Delta_{0\cup\infty},\chi)_{G_{v_{0,1}}-\text{an}} \oplus I(\Delta_{0\cup1},\chi)_{G_{v_{0,\infty}}-\text{an}} \oplus I(\Delta_{0,\chi})_{G_{v_{0}}-\text{an}} \oplus I(\Delta_{1,\chi})_{G_{v_{0}}-\text{an}} \oplus I(\Delta_{\infty},\chi)_{G_{v_{0}}-\text{an}}$$

The the matrix of  $\overline{\partial}_1$  is given by

$$\begin{pmatrix} -1 & 0 & 0 & 0 & 0 & 0 \\ 0 & -1 & 0 & 0 & 0 & 0 \\ 0 & 0 & -1 & 0 & 0 & 0 \\ 0 & \operatorname{res}_{0}^{0\cup\infty} & \operatorname{res}_{0}^{0\cup1} & 1 & 0 & 0 \\ \operatorname{res}_{1}^{1\cup\infty} & 0 & \operatorname{res}_{1}^{0\cup1} & 0 & 1 & 0 \\ \operatorname{res}_{\infty}^{1\cup\infty} & \operatorname{res}_{\infty}^{0\cup\infty} & 0 & 0 & 0 & 1 \end{pmatrix}$$

where  $\operatorname{res}_{i}^{i\cup j}(f_{\Delta_{i\cup j,v^{k}}}) := g_{\Delta_{i},v_{0}} = f_{\Delta_{i\cup j}}|_{\Delta_{i}}.$
