# UNIFORM RECTIFIABILITY AND ELLIPTIC OPERATORS SATISFYING A CARLESON MEASURE CONDITION

#### Abstract

The present paper establishes the correspondence between the properties of the solutions of a class of PDEs and the geometry of sets in Euclidean space. We settle the question of whether (quantitative) absolute continuity of the elliptic measure with respect to the surface measure and uniform rectifiability of the boundary are equivalent, in an optimal class of divergence form elliptic operators satisfying a suitable Carleson measure condition. The result can be viewed as a quantitative analogue of the Wiener criterion adapted to the singular $L^{p}$ data case.

The first step is taken in Part I, where we considered the case in which the desired Carleson measure condition on the coefficients holds with sufficiently small constant, using a novel application of techniques developed in geometric measure theory. In Part II we establish the final result, that is, the "large constant case". The key elements are a powerful extrapolation argument, which provides a general pathway to self-improve scale-invariant small constant estimates, and a new mechanism to transfer quantitative absolute continuity of elliptic measure between a domain and its subdomains.

## 1. Introduction

1.1. Background and Previous Results. The present paper, together with its converse in [KP] (see also [DJ]), culminate many years of activity at the intersection of harmonic analysis, geometric measure theory, and PDEs, devoted to the complete understanding of necessary and sufficient conditions on the operator and the geometry of the domain guaranteeing absolute continuity of the elliptic measure with respect to the surface measure of the boundary.

The celebrated 1924 Wiener criterion [Wie] provided the necessary and sufficient conditions on the geometry of the domain responsible for the continuity of the harmonic functions at the boundary. In the probabilistic terms, it characterized the points of the boundary which are "seen" by the Brownian travelers coming from the interior of the domain.

The question of finding necessary and sufficient geometric conditions which could guarantee adequate regularity, so that, roughly speaking, the pieces of the boundary are seen by the Brownian travelers according to their surface measure, turned out to be much more intricate. Curiously, already in 1916 F. \& M. Riesz correctly identified the key geometric notion in this context: rectifiability of the boundary $\partial \Omega$, i.e., the existence of tangent planes almost everywhere with respect to arc length $\sigma$ on $\partial \Omega$. In particular, they showed in [RR] that harmonic measure is (mutually) absolutely continuous with respect to $\sigma$ for a simply connected domain in the plane with rectifiable boundary. It took more than a hundred years to establish the converse of the F. \& M. Riesz theorem and its higher dimensional analogues. The first such result appeared in 2016 [AHM+], and the question was fully settled for the harmonic functions in 2018 [AHMMT].

The question of what happens in the general PDE setting has been puzzling from the beginning. The Wiener criterion is universal: it applies to all uniformly elliptic divergence form operators with bounded coefficients and characterizes points of continuity of the solution at the boundary. It was realized early on that no such general criterion exists for determining the absolute continuity of elliptic measure with respect to the surface measure to the boundary of a domain. Some of the challenges that arise when considering this question were highlighted by the counterexamples in [CFK], [MM]. In 1984 Dahlberg formulated a conjecture concerning optimal conditions on a matrix of coefficients which guarantee absolute continuity of elliptic measure with respect to Lebesgue measure in a half-space. This question was a driving force of a thread of outstanding developments in harmonic analysis in the 80 s and 90 s due to Dahlberg, Jerison, Kenig, Pipher, and others, stimulating some beautiful and far-reaching new techniques in the theory of weights and singular integral operators, to mention only a few approaches. In [KP], Kenig and Pipher proved Dahlberg's conjecture, they showed that whenever the gradient of coefficients satisfies a Carleson measure condition (to be defined below in (1.2)) the elliptic measure and the Lebesgue measure are mutually absolutely continuous on a half-space and, by a change of variables argument, above a Lipschitz graph.

Given the aforementioned developments, it was natural to conjecture that the equivalence of rectifiability and regularity of elliptic measure should be valid in the full generality of Dahlberg-Kenig-Pipher (DKP) coefficients. Despite numerous attempts this question turned out to be notoriously resistant to existing methods. The passage from the regularity of the solutions to partial differential equations to rectifiability, or to any geometric information on the boundary, is generally referred to as free boundary problems. This in itself is, of course, a well-studied and rich subject. Unfortunately, the typical techniques arising from minimization of the functionals are both too qualitative and too rigid to treat structural irregularities of rectifiable sets and such weak assumptions as absolute continuity of harmonic measure. The latter became accessible only recently, with the development of the analysis of singular integrals and similar objects on uniformly rectifiable sets. In particular, the first converse of the F. \& M. Riesz theorem, [AHM+], directly relies on the 2012 solution of the David-Semmes conjecture regarding the boundedness of the Riesz transforms in $L^{2}$ [NTV]. At the same time, the techniques stemming from such results for the harmonic functions are not amenable to more general operators of the DKP type, again, due to simple yet
fundamental algebraic deficiencies: the derivatives of the coefficients do not offer sufficient cancellations.

The main goal of the present paper is to addresses the conjecture in full generality. We establish the equivalence of the absolute continuity of the elliptic measure with respect to the surface measure and the uniform rectifiability of the boundary of a domain under the DKP condition on the coefficients, thus providing the final, optimal geometric results (given the assumed background hypotheses).

We now describe our goal and relevant previous results more precisely. Throughout the paper we shall work under the assumptions that the domain $\Omega$ is uniform, i.e., open and connected in a quantitative way, and that its boundary is $(n-1)$-Ahlfors regular, that is, ( $n-1$ )-dimensional in a quantitative way (see Section 2.1). Under these conditions one can, for instance, show that scale-invariant absolute continuity of harmonic measure is related to the uniform rectifiability of the boundary and even to the non-tangential accessibility of the exterior domain:

Theorem 1.1. Let $\Omega \subset \mathbb{R}^{n}, n \geq 3$, be a uniform domain (bounded or unbounded) with Ahlfors regular boundary (see Definitions 2.8 and 2.1), set $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$ and let $\omega_{-\Delta}$ denote its associated harmonic measure. The following statements are equivalent:
(a) $\omega_{-\Delta} \in A_{\infty}(\sigma)($ Definition 2.10).
(b) $\partial \Omega$ is uniformly rectifiable (Definition 2.2).
(c) $\Omega$ satisfies the exterior corkscrew condition (see Definition 2.3), hence, in particular, it is a chord-arc domain (Definition 2.9).

Postponing all the rigorous definitions to Section 2.1, we remark for the moment that uniform rectifiability is a quantitative version of the notion of rectifiability of the boundary and the Muckenhoupt condition $\omega \in A_{\infty}(\sigma)$ is, respectively, a quantitative form of the mutual absolute continuity of $\omega$ with respect to $\sigma$. Thus, Theorem 1.1 above is a quantitative form of the rigorous connection between the boundary behavior of harmonic functions and geometric properties of sets that we alluded to above. Returning to the ties with Wiener criterion, we point out that the property of the scale invariant absolute continuity of harmonic measure with respect to surface measure, at least in the presence of Ahlfors regularity of $\partial \Omega$, is equivalent to the solvability of the Dirichlet problem with data in some $L^{p}(\partial \Omega)$, with $p<\infty^{*}$; thus, such a characterization is in some sense an analogue of Wiener's criterion for singular, rather than continuous data.

Theorem 1.1 in the present form appears in [AHMNT, Theorem 1.2]. That (a) implies (b) is the main result in [HMU] (see also [HM2, HLMN]); that (b) yields (c) is [AHMNT, Theorem 1.1]; and the fact that (c) implies (a) was proved in [DJ], and independently in [Sem].

[^1]Theorem 1.1 and other recent results ${ }^{\dagger}$ illuminate how the $A_{\infty}$ condition ${ }^{\ddagger}$ of harmonic measure is related to the geometry of the domain $\Omega$. Unfortunately, as we pointed out above, their proofs do not extend to the optimal class of operators with variable coefficients. Indeed, the best known results in this direction pertain to the "direct" rather than the "free boundary" problem. A description of the elliptic measure in a given geometric environment, is essentially due to C. Kenig and J. Pipher. In 2001 [KP] C. Kenig and J. Pipher proved what they referred to as a 1984 Dahlberg conjecture: if $\Omega \subset \mathbb{R}^{n}$ is a bounded Lipschitz domain and the elliptic matrix $\mathcal{A}$ satisfies the following Carleson measure condition:

\end{equation*}

where here and elsewhere we write $\delta(\cdot)=\operatorname{dist}(\cdot, \partial \Omega)$, then the corresponding elliptic measure $\omega_{L} \in A_{\infty}(\sigma)$. As observed in [HMT1], one may carry through the proof in [KP], essentially unchanged, with a slightly weakened reformulation of (1.2), namely by assuming, in place of (1.2), the following properties:
(H1) $\mathcal{A} \in \operatorname{Lip}_{\text {loc }}(\Omega)$ and $|\nabla \mathcal{A}| \delta(\cdot) \in L^{\infty}(\Omega)$, where $\delta(\cdot):=\operatorname{dist}(\cdot, \partial \Omega)$.
(H2) $|\nabla \mathcal{A}|^{2} \delta(\cdot)$ satisfies the Carleson measure assumption:

\|\mathcal{A}\|_{\text {Car }}:=\sup _{\substack{q \in \partial \Omega \\ 0<r<\operatorname{diam}(\Omega)}} \frac{1}{r^{n-1}} \iint_{B(q, r) \cap \Omega}|\nabla \mathcal{A}(X)|^{2} \delta(X) d X<\infty . \tag{1.3}
\end{equation*}
$$

We shall refer to these hypotheses (jointly) as the Dahlberg-Kenig-Pipher (DKP) condition. Note that each of (H1) and (H2) is implied by (1.2).

Since properties (H1) and (H2) are preserved in subdomains, one can use the method of [DJ] to extend the result of [KP] to chord-arc domains, and hence the analogue of (c) implies (a) (in Theorem 1.1) holds for operators satisfying the DKP condition.

An attempt to address the "free boundary" part of the problem that is to prove that (a) implies (b) or (c) led, the first, second and fourth authors of the present paper (see [HMT1]) to show that under the same background hypothesis as in Theorem 1.1, (a) implies (c) (and hence also (b)) for elliptic operators with variable-coefficient matrices $\mathcal{A}$ satisfying (H1) and the Carleson measure estimate

We observe that, in the presence of hypothesis (H1), (1.4) implies (1.3). The weighted $W^{1,2}$ Carleson measure estimate (1.3) is both weaker, and more natural than the $W^{1,1}$ version (1.4). For example, operators verifying (1.3) arise as pullbacks of constant coefficient

[^2]operators (see [KP, Introduction]), and also in the linearization of " $A$-harmonic" (i.e., generalized $p$-harmonic) operators (see [LV, Section 4]). We also mention in passing that a qualitative version of the results in [HMT1] was obtained in [ABHM]. There are also related (quantitative) results in [HMM1] and [AGMT] that are valid in the absence of any connectivity hypothesis.
1.2. Main Result and Proof Techniques. From the geometric measure theory point of view the main motivation for this paper is to understand whether the elliptic measure of a DKP divergence form elliptic operator distinguishes between a rectifiable and a purely unrectifiable boundary. As in Theorem 1.1, we make the background assumption that $\Omega \subset$ $\mathbb{R}^{n}, n \geq 3$, is a uniform domain (see Definition 2.8) with an Ahlfors regular boundary (Definition 2.1). Analytically we consider second order divergence form elliptic operators, that is, $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$, where $\mathcal{A}=\left(a_{i j}\right)_{i, j=1}^{n}$ is a (not necessarily symmetric) real matrixvalued function on $\Omega$, satisfying the usual uniform ellipticity condition

\]

for uniform constants $0<\lambda \leq \Lambda<\infty$, and for a.e. $X \in \Omega$. We further assume that $\mathcal{A}$ satisfies the Dahlberg-Kenig-Pipher condition, that is, (H1) and (H2), and, additionally, that the associated elliptic measure is an $A_{\infty}$ weight (see Definition 2.10) with respect to the surface measure $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$. Our goal is to understand how this analytic information yields insight on the geometry of the domain and its boundary.

Our main result is as follows:
Theorem 1.6. Let $\Omega \subset \mathbb{R}^{n}, n \geq 3$, be a uniform domain with Ahlfors regular boundary and set $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$. Let $\mathcal{A}$ be a (not necessarily symmetric) uniformly elliptic matrix on $\Omega$ satisfying $(\mathrm{H} 1)$ and $(\mathrm{H} 2)$. Then the following are equivalent:
(1) The elliptic measure $\omega_{L}$ associated with the operator $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ is of class $A_{\infty}$ with respect to the surface measure.
(2) $\partial \Omega$ is uniformly rectifiable.
(3) $\Omega$ is a chord-arc domain.

Remark 1.7. In Corollary 10.3 we show that Theorem 1.6 remains true when we replace the assumptions (H1) and (H2) by a slightly weaker assumption involving the oscillation of the elliptic matrix in place of its gradient.

The equivalence of (2) and (3) (under the stated background hypotheses) was previously known: that $(3) \Longrightarrow$ (2) follows from the main geometric result of [DJ] (namely, that chord-arc domains can be approximated in a big pieces sense by Lipschitz subdomains), and the converse (2) $\Longrightarrow$ (3) is proved in [AHMNT]. Moreover, as mentioned above, it was also known that $(3) \Longrightarrow$ (1), and the proof comprises two main ingredients: first, that the properties $(\mathrm{H} 1)$ and $(\mathrm{H} 2)$ are preserved in subdomains, and therefore by the result of $[\mathrm{KP}]^{\S}, \omega_{L} \in A_{\infty}(\sigma)$ in a Lipschitz subdomains of $\Omega$; and second, by the aforementioned

[^3]big piece approximation result of [DJ], that the $A_{\infty}$ property may be passed from Lipschitz subdomains to the original chord-arc domain, by use of the maximum principle and a change of pole argument (see [DJ] or, originally, [JK]). In this paper we close the circle by proving the implication $(1) \Longrightarrow(2)$, thus providing a characterization of chord-arc domains in terms of the properties of the elliptic measure.

We first prove the implication $(1) \Longrightarrow(2)$ in the "small constant case", that is, when the Carleson condition (H2) holds with a sufficiently small constant (i.e, $\|\mathcal{F l}\|_{\text {Car }}$ is small, see (1.3)). To finish the proof of Theorem 1.6, we then utilize a bootstrapping argument to pass from the case of small Carleson norm to the "large constant case", in which the Carleson condition (H2) is assumed merely to be finite. The arguments we use to treat the small and large constant cases are quite different in nature, and each is of independent interest in its own right. (For example, what we prove in the small constant case is stronger than what is necessary for Theorem 1.6.) Therefore we divide the proof into two parts, and deal with the small and large constant cases in Parts I and II, respectively. In the end of Part II we also discuss the optimality of the above theorem.

Throughout this paper, and unless otherwise specified, by allowable constants, we mean the dimension $n \geq 3$; the constants involved in the definition of a uniform domain, that is, $M, C_{1}>1$ (see Definition 2.8); the Ahlfors regular constant $C_{A R}>1$ (see Definition 2.1); the ratio of the ellipticity constants $\Lambda / \lambda \geq 1$ (see (1.5)), and the $A_{\infty}$ constants $C_{0}>1$ and $\theta \in(0,1)$ (see Definition 2.10).

In Part I, we develop an approach which combines, or rather interlaces, the "classical" free boundary blow-up and compactness arguments (originated in geometric measure theory) with the scale-invariant harmonic analysis methods. This allows us to take advantage of the appropriate amelioration of the coefficients obtained via a compactness approach to show that the desired uniform rectifiability follows from regularity of elliptic measure whenever the coefficients of the underlying equation exhibit small oscillations, in the appropriate Carleson measure sense (see Theorem 1.8 and Corollary 1.13). The smallness condition, while obviously suboptimal, could not be removed directly, for it is essentially built in the nature of the compactness arguments. To be precise, we prove the following:

Theorem 1.8. Given the values of allowable constants $n \geq 3, M, C_{1}, C_{A R}>1, \Lambda \geq \lambda=1$, $C_{0}>1$, and $0<\theta<1$, there exist $N$ and $\epsilon>0$ depending on the allowable constants, such that the following holds. Let $\Omega \subset \mathbb{R}^{n}$ be a bounded uniform domain with constants $M, C_{1}$ and whose boundary $\partial \Omega$ is Ahlfors regular with constant $C_{A R}$ and set $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$. Let $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ be an elliptic operator with real symmetric matrix $\mathcal{A}$ satisfying (1.5) with ellipticity constants $1=\lambda \leq \Lambda$ such that the corresponding elliptic measure satisfies $\omega_{L} \in A_{\infty}(\sigma)$ with constants $C_{0}$ and $\theta$. If $\mathcal{A}$ verifies

\begin{equation*}
\operatorname{osc}(\Omega, \mathcal{A}):=\sup _{X \in \Omega} f_{B(X, \delta(X) / 2)}\left|\mathcal{A}(Y)-\langle\mathcal{A}\rangle_{B(X, \delta(X) / 2)}\right| d Y<\epsilon, \tag{1.9}
\end{equation*}
$$

where $\delta(\cdot)=\operatorname{dist}(\cdot, \partial \Omega)$ and $\langle\mathcal{A}\rangle_{B(X, \delta(X) / 2)}$ denotes the average of $\mathcal{A}$ on $B(X, \delta(X) / 2)$, then $\Omega$ satisfies the exterior corkscrew condition with constant $N$, and hence $\Omega$ has uniformly rectifiable boundary.

Remark 1.10.
(i) Given $\mathcal{A} \in W_{\text {loc }}^{1,1}(\Omega)$ we introduce

C(\Omega, \mathcal{A}):=\sup _{X \in \Omega} f_{B(X, \delta(X) / 2)}|\nabla \mathcal{A}(Y)| \delta(Y) d Y . \tag{1.11}
\end{equation*}
$$

Poincaré's inequality easily yields that $\operatorname{osc}(\Omega, \mathcal{A}) \leq C_{n} C(\Omega, \mathcal{A})$ with $C_{n}$ depending just on dimension. Hence, one can formulate a version of Theorem 1.8 (with a slightly different $\epsilon$ ) with $\mathcal{C}(\Omega, \mathcal{A})<\epsilon$ replacing (1.9).
(ii) We note that our assumption (1.9) on the matrix $\mathcal{A}$ is much weaker than the smallness of the relaxed DKP condition (1.3). To see this, given $X \in \Omega$, let $q_{X} \in \partial \Omega$ be such that $\left|X-q_{X}\right|=\delta(X)$. Then by Hölder's inequality

f_{B(X, \delta(X) / 2)}|\nabla \mathcal{A}(Y)| \delta(Y) d Y \lesssim\left(\frac{1}{\delta(X)^{n-1}} \int_{B\left(q_{X}, 3 \delta(X) / 2\right) \cap \Omega}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y\right)^{\frac{1}{2}} .
$$

Hence (1.3) with sufficiently small constant gives smallness of $\mathcal{C}(\Omega, \mathcal{A})$ (and hence (1.9)). On the other hand, it is easy to see that the latter is much weaker. Assume for instance that $|\nabla \mathcal{A}| \delta \sim \epsilon$ in $\Omega$ in which case $C(\Omega, \mathcal{A}) \sim \epsilon$ but (1.3) fails since every integral is infinity.
(iii) In the hypothesis of Theorem 1.8, boundedness of the domain and symmetry of the operator might seem restrictive and it is very likely that the proof can be modified to remove those restrictions. Nevertheless, Theorem 1.8 as stated is enough to prove Theorem 1.6 and we leave the details to the interested reader.

As a consequence we immediately obtain the "small constant" case of Theorem 1.6:
Corollary 1.13. Under the same background hypothesis as in Theorem 1.8 if $\mathcal{A}$ is a symmetric uniformly elliptic matrix on $\Omega$ satisfying $(\mathrm{H} 1)$ and $(\mathrm{H} 2)$ with $\|\mathcal{A}\|_{\text {Car }}<\epsilon$ and $\omega_{L} \in A_{\infty}(\sigma)$ then $\partial \Omega$ is uniformly rectifiable.
Remark 1.14. We note that the $A_{\infty}$ constants for $\omega_{L}$ are not affected by the normalization $\lambda=1$, however, the small parameter $\epsilon$ in (1.9) clearly depends upon this normalization.

Remark 1.15. Having fixed the desired ellipticity constants $\lambda=1$ and $\Lambda$ and the geometric parameters $M, C_{1}, C_{A R}>1$, one may ask whether operators $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ such that $\omega_{L} \in A_{\infty}(\sigma)$ and $\mathcal{A}$ satisfies (1.9) with small constant $\epsilon$ exist. Choosing a matrix for which the left-hand side of (1.2) is small (e.g., a constant coefficient matrix), we can guarantee that (1.9) holds with a desired $\epsilon$, see Remark 1.10. It is a consequence of the work in [KP] that on a chord arc domain (see Definition 2.9) the $A_{\infty}$ constants of $\omega_{L}$ only depend on the ellipticity constants, the norm (1.2) and the geometric parameters (which include $\left.M, C_{1}, C_{A R}>1\right)$. Thus in this case there exist constants $C_{0}>1$ and $\theta \in(0,1)$ such that all the conditions of Theorem 1.8 are satisfied.

The proof in Part II is based on the method of "extrapolation of Carleson measures", by means of which we bootstrap the small constant case treated in Part I. This method was first introduced in the work of Lewis and Murray [LM], based on the Corona construction which has its origins in the work of Carleson [Car], and Carleson and Garnett [CG]. In order to carry out this procedure, we go back and forth between the original domain $\Omega$ and certain
sawtooth domains, taking advantages of the scale-invariant nature of Carleson measures. In particular we need to transfer the $A_{\infty}$ property of elliptic measures, from the original domain to its sawtooth subdomains. This last step is really the heart of the proof.

## 2. Preliminaries

In this section we state the definitions and some auxiliary results that will be used throughout the paper.

### 2.1. Definitions.

Definition 2.1. We say a closed set $E \subset \mathbb{R}^{n}$ is Ahlfors regular with constant $C_{A R}>1$ if for any $q \in E$ and $0<r<\operatorname{diam}(E)$,

C_{A R}^{-1} r^{n-1} \leq \mathcal{H}^{n-1}(B(q, r) \cap E) \leq C_{A R} r^{n-1}
$$

There are many equivalent characterizations of a uniformly rectifiable set, see [DS2]. Since uniformly rectifiability is not the main focus of our paper, we only state one of the geometric characterizations as its definition.

Definition 2.2. An Ahlfors regular set $E \subset \mathbb{R}^{n}$ is said to be uniformly rectifiable, if it has big pieces of Lipschitz images of $\mathbb{R}^{n-1}$. That is, there exist $\theta, M>0$ such that for each $q \in E$ and $0<r<\operatorname{diam}(E)$, there is a Lipschitz mapping $\rho: B_{n-1}(0, r) \rightarrow \mathbb{R}^{n}$ such that $\rho$ has Lipschitz norm $\leq M$ and

\mathcal{H}^{n-1}\left(E \cap B(q, r) \cap \rho\left(B_{n-1}(0, r)\right)\right) \geq \theta r^{n-1}
$$

Here $B_{n-1}(0, r)$ denote a ball of radius $r$ in $\mathbb{R}^{n-1}$.
Definition 2.3. An open set $\Omega \subset \mathbb{R}^{n}$ is said to satisfy the (interior) corkscrew condition (resp. the exterior corkscrew condition) with constant $M>1$ if for every $q \in \partial \Omega$ and every $0<r<\operatorname{diam}(\Omega)$, there exists $A=A(q, r) \in \Omega\left(\right.$ resp. $\left.A \in \Omega_{\mathrm{ext}}:=\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ such that

\begin{equation*}
B\left(A, \frac{r}{M}\right) \subset B(q, r) \cap \Omega \quad\left(\operatorname{resp} . B\left(A, \frac{r}{M}\right) \subset B(q, r) \cap \Omega_{\mathrm{ext}} .\right) \tag{2.4}
\end{equation*}
$$

The point $A$ is called a Corkscrew point (or a non-tangential point) relative to $\Delta(q, r)=$ $B(q, r) \cap \partial \Omega$ in $\Omega\left(\right.$ resp. $\left.\Omega_{\mathrm{ext}}\right)$.
Definition 2.5. An open connected set $\Omega \subset \mathbb{R}^{n}$ is said to satisfy the Harnack chain condition with constants $M, C_{1}>1$ if for every pair of points $A, A^{\prime} \in \Omega$ there is a chain of balls $B_{1}, B_{2}, \ldots, B_{K} \subset \Omega$ with $K \leq M\left(2+\log _{2}^{+} \Pi\right)$ that connects $A$ to $A^{\prime}$, where

\begin{equation*}
\Pi:=\frac{\left|A-A^{\prime}\right|}{\min \left\{\delta(A), \delta\left(A^{\prime}\right)\right\}} \tag{2.6}
\end{equation*}
$$

Namely, $A \in B_{1}, A^{\prime} \in B_{K}, B_{k} \cap B_{k+1} \neq \emptyset$ and for every $1 \leq k \leq K$

$$
\begin{equation*}
C_{1}^{-1} \operatorname{diam}\left(B_{k}\right) \leq \operatorname{dist}\left(B_{k}, \partial \Omega\right) \leq C_{1} \operatorname{diam}\left(B_{k}\right) \tag{2.7}
\end{equation*}
$$

We note that in the context of the previous definition if $\Pi \leq 1$ we can trivially form the Harnack chain $B_{1}=B(A, 3 \delta(A) / 5)$ and $B_{2}=B\left(A^{\prime}, 3 \delta\left(A^{\prime}\right) / 5\right)$ where (2.7) holds with $C_{1}=3$. Hence the Harnack chain condition is non-trivial only when $\Pi>1$.

Definition 2.8. An open connected set $\Omega \subset \mathbb{R}^{n}$ is said to be a uniform domain with constants $M, C_{1}$, if it satisfies the interior corkscrew condition with constant $M$ and the Harnack chain condition with constants $M, C_{1}$.

Definition 2.9. A uniform domain $\Omega \subset \mathbb{R}^{n}$ is said to be NTA if it satisfies the exterior corkscrew condition. If one additionally assumes that $\partial \Omega$ is Ahlfors regular, the $\Omega$ is said to be a chord-arc domain.

For any $q \in \partial \Omega$ and $r>0$, let $\Delta=\Delta(q, r)$ denote the surface ball $B(q, r) \cap \partial \Omega$, and let $T(\Delta)=B(q, r) \cap \Omega$ denote the Carleson region above $\Delta$. We always implicitly assume that $0<r<\operatorname{diam}(\Omega)$. We will also write $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$.

Given an open connected set $\Omega$ and an elliptic operator $L$ we let $\left\{\omega_{L}^{X}\right\}_{X \in \Omega}$ be the associated elliptic measure. In the statement of Theorem 1.8 we assume that $\omega_{L} \in A_{\infty}(\sigma)$ in the following sense:

Definition 2.10. The elliptic measure associated with $L$ in $\Omega$ is said to be of class $A_{\infty}$ with respect to the surface measure $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$, which we denote by $\omega_{L} \in A_{\infty}(\sigma)$, if there exist $C_{0}>1$ and $0<\theta<\infty$ such that for any surface ball $\Delta(q, r)=B(q, r) \cap \partial \Omega$, with $x \in \partial \Omega$ and $0<r<\operatorname{diam}(\Omega)$, any surface ball $\Delta^{\prime}=B^{\prime} \cap \partial \Omega$ centered at $\partial \Omega$ with $B^{\prime} \subset B(q, r)$, and any Borel set $F \subset \Delta^{\prime}$, the elliptic measure with pole at $A(q, r)$ (a corkscrew point relative to $\Delta(q, r))$ satisfies

$$
\begin{equation*}
\frac{\omega_{L}^{A(q, r)}(F)}{\omega_{L}^{A(q, r)}\left(\Delta^{\prime}\right)} \leq C_{0}\left(\frac{\sigma(F)}{\sigma\left(\Delta^{\prime}\right)}\right)^{\theta} \tag{2.11}
\end{equation*}
$$

Since $\sigma$ is a doubling measure, it is well-known that the condition $\omega_{L} \in A_{\infty}(\sigma)$ is equivalent to the fact that $\omega_{L} \in R H_{q}(\sigma)$ for some $q>1$ in the following sense: $\omega_{L} \ll \sigma$ and the Radon-Nikodym derivative $\mathbf{k}_{L}:=d \omega_{L} / d \sigma$ satisfies the reverse Hölder estimate

\begin{equation*}
\left(f_{\Delta^{\prime}}\left(\mathbf{k}_{L}^{A(q, r)}\right)^{q} d \sigma\right)^{\frac{1}{q}} \lesssim f_{\Delta^{\prime}} \mathbf{k}_{L}^{A(q, r)} d \sigma=\frac{\omega_{L}^{A(q, r)}\left(\Delta^{\prime}\right)}{\sigma\left(\Delta^{\prime}\right)} \tag{2.12}
\end{equation*}
$$

for all $\Delta(q, r)=B(q, r) \cap \partial \Omega$, with $x \in \partial \Omega$ and $0<r<\operatorname{diam}(\Omega)$, any surface ball $\Delta^{\prime}=B^{\prime} \cap \partial \Omega$ centered at $\partial \Omega$ with $B^{\prime} \subset B(q, r)$.

Definition 2.13. A domain $\Omega \subset \mathbb{R}^{n}$ with $n \geq 3$ is said to satisfy the capacity density condition (CDC) if there exists a constant $c_{0}>0$ such that

$$
\begin{equation*}
\frac{\operatorname{cap}_{2}\left(B_{r}(q) \backslash \Omega\right)}{\operatorname{cap}_{2}\left(B_{r}(q)\right)} \geq c_{0}, \quad \text { for any } q \in \partial \Omega \text { and } 0<r<\operatorname{diam}(\Omega) \tag{2.14}
\end{equation*}
$$

where for any set $K \subset \mathbb{R}^{n}$, the capacity is defined as

$$
\operatorname{cap}_{2}(K)=\inf \left\{\int|\nabla \varphi|^{2} d X: \varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right), K \subset \operatorname{int}\{\varphi \geq 1\}\right\} .
$$

It was proved in [Zha, Section 3] and [HLMN, Lemma 3.27] that a domain in $\mathbb{R}^{n}, n \geq 3$, with ( $n-1$ )-Ahlfors regular boundary satisfies the capacity density condition with constant $c_{0}$ depending only on $n$ and the Ahlfors regular constant $C_{A R}$. In particular such a domain is Wiener regular and hence for any elliptic operator $L$, and any function $f \in C(\partial \Omega)$, we can define

\begin{equation*}
u(X)=\int_{\partial \Omega} f(q) d \omega_{L}^{X}(q), \quad X \in \Omega, \tag{2.15}
\end{equation*}
$$

and obtain that $u \in W_{\operatorname{loc}}^{1,2}(\Omega) \cap C(\bar{\Omega}),\left.u\right|_{\partial \Omega}=f$ on $\partial \Omega$ and $L u=0$ in $\Omega$ in the weak sense. Moreover, if additionally $f \in \operatorname{Lip}(\Omega)$ then $u \in W^{1,2}(\Omega)$.
2.2. Properties of solutions and elliptic measures. For following lemmas, we always assume that $\Omega$ is a uniform domain with Ahlfors regular boundary (in fact they hold under the weaker assumption that $\Omega$ is a uniform domain the $\operatorname{CDC})$. Let $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ be a real uniformly elliptic operator, and we write $\omega=\omega_{L}$ for the corresponding elliptic measure. Although in our main result we consider non necessarily symmetric uniformly elliptic matrices, we will reduce matters to the symmetric case, in particular all the following properties will be used in that case, hence during this section we assume that $\mathcal{A}$ is symmetric. All constants will only depend on the allowable constants, that is, those involved in the fact that the domain in question is uniform and has Ahlfors regularity boundary, and also in the uniform ellipticity of $\mathcal{A}$. (Note that we may assume $\mathcal{A}$ has been normalized so that $\lambda=1$ in (1.5).) In Part II we will apply these lemmas to $\Omega$ as well as its sawtooth domains $\Omega_{\mathcal{F}, Q}$.

Under the above assumptions, one can construct the associated elliptic measure $\omega_{L}$ and Green function $G$. For the latter the reader is referred to the work of Grüter and Widman [GW], while the existence of the corresponding elliptic measures is an application of the Riesz representation theorem. The behavior of $\omega$ and $G$, as well as the relationship between them, depends crucially on the properties of $\Omega$, and assuming that $\Omega$ is a uniform domain with the CDC one can follow the program carried out in [JK]. We summarize below the results which will be used later in this paper. For a comprehensive treatment of the subject and the proofs we refer the reader to the forthcoming monograph [HMT2] (see also [Ken] for the case of NTA domains).

Theorem 2.16. There is a unique non-negative function $G: \Omega \times \Omega \rightarrow \mathbb{R} \cup\{\infty\}$, the Green function associated with $L$, and a positive, finite constant $C$, depending only on dimension, and (given the normalization) $\Lambda$, such that the following hold:
(2.17) $G(\cdot, Y) \in W^{1,2}(\Omega \backslash B(Y, s)) \cap W_{0}^{1,1}(\Omega) \cap W_{0}^{1, r}(\Omega), \quad \forall Y \in \Omega, \forall s>0, \forall r \in\left[1, \frac{n}{n-1}\right)$;

$$
\begin{gather*}
\int\left\langle\mathcal{A}(X) \nabla_{X} G(X, Y), \nabla \varphi(X)\right\rangle d X=\varphi(Y), \quad \text { for all } \varphi \in C_{c}^{\infty}(\Omega) ;  \tag{2.18}\\
\|G(\cdot, Y)\|_{L^{n} \frac{n}{n-2}, \infty}(\Omega)+\|\nabla G(\cdot, Y)\|_{L^{\frac{n}{n-1}, \infty}(\Omega)} \leq C, \quad \forall Y \in \Omega ; \tag{2.19}
\end{gather*}
$$

$$
\begin{equation*}
G(X, Y) \leq C|X-Y|^{2-n} \tag{2.20}
\end{equation*}
$$

and

$$
\begin{equation*}
G(X, Y) \geq C|X-Y|^{2-n}, \quad \text { if }|X-Y| \leq \frac{7}{8} \delta(Y) \tag{2.21}
\end{equation*}
$$

Furthermore, if $\Omega$ is a uniform domain satisfying the $C D C$, for any $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ and for almost all $Y \in \Omega$

\begin{equation*}
-\int_{\Omega}\left\langle\mathcal{A}(X) \nabla_{X} G(X, Y), \nabla \varphi(X)\right\rangle d X=\int_{\partial \Omega} \varphi d \omega^{Y}-\varphi(Y) \tag{2.22}
\end{equation*}
$$

where $\left\{\omega^{Y}\right\}_{Y \in \Omega}$ is the associated elliptic measure.
We observe that (2.19) and Kolmogorov's inequality give that for every $1 \leq r<\frac{n}{n-1}$

\begin{equation*}
\|G(\cdot, Y)\|_{L^{r}(\Omega)} \leq C C_{3}^{\frac{1}{r}}|\Omega|^{\frac{1}{r}-\frac{n-2}{n}}, \quad\|\nabla G(\cdot, Y)\|_{L^{r}(\Omega)} \leq C C_{4}^{\frac{1}{4}}|\Omega|^{\frac{1}{r}-\frac{n-1}{n}}, \tag{2.23}
\end{equation*}
$$

where $C$ is the constant in (2.19), $C_{4}=\left(\frac{n}{(n-2) r}\right)^{\prime}$, and $C_{4}=\left(\frac{n}{(n-1) r}\right)^{\prime}$.
Lemma 2.24 (Boundary Hölder regularity). There exist constants $C, \beta>0$ (depending on the allowable constants) such that for $q \in \partial \Omega$ and $0<r<\operatorname{diam}(\partial \Omega)$, and $u \geq 0$ with $L u=0$ in $B(q, 2 r) \cap \Omega$, if $u$ vanishes continuously on $\Delta(q, 2 r)=B(q, 2 r) \cap \partial \Omega$, then

$$
\begin{equation*}
u(X) \leq C\left(\frac{|X-q|}{r}\right)^{\beta} \sup _{B(q, 2 r) \cap \Omega} u, \quad \text { for any } X \in \Omega \cap B(q, r) . \tag{2.25}
\end{equation*}
$$

Lemma 2.26 (Comparison principle). Let $u$ and $v$ be non-negative solutions to $L u=L v=0$ in $B(q, 4 r) \cap \Omega$ which vanish continuously on $\Delta(q, 4 r)$. Let $A=A(q, r)$ be a corkscrew point relative to $\Delta(q, r)$. Then

\begin{equation*}
\frac{u(X)}{v(X)} \approx \frac{u(A)}{v(A)} \quad \text { for any } X \in B(q, r) \cap \Omega \tag{2.27}
\end{equation*}
$$

Lemma 2.28 (Non-degeneracy of elliptic measure). There exists $m_{0} \in(0,1)$ depending on the allowable constants such that for any $q \in \partial \Omega$ and $0<r<\operatorname{diam}(\partial \Omega)$,

$$
\begin{equation*}
\omega^{X}(\Delta(q, r)) \geq m_{0} \quad \text { for } X \in B(q, r / 2) \cap \Omega \tag{2.29}
\end{equation*}
$$

Lemma 2.30 (Boundary Harnack inequality). Let $\Omega$ be a uniform domain satisfying the CDC. There exists a constant $C$ (depending on the allowable constants) such that for $q \in \partial \Omega$ and $0<r<\operatorname{diam}(\partial \Omega)$. If $u \geq 0$ with $L u=0$ in $\Omega \cap B(q, 2 r)$ and $u$ vanishes continuously on $\Delta(q, 2 r)$, then

\begin{equation*}
u(X) \leq C u(A(q, r)), \quad \text { for any } X \in \Omega \cap B(q, r) . \tag{2.31}
\end{equation*}
$$

Lemma 2.32 (Change of pole formula). Let $q \in \partial \Omega$ and $0<r<\operatorname{diam}(\partial \Omega)$ be given, and let $A=A(q, r)$ be a corkscrew point relative to $\Delta(q, r)$. Let $F, F^{\prime} \subset \Delta(q, r)$ be two Borel subsets such that $\omega^{A}(F)$ and $\omega^{A}\left(F^{\prime}\right)$ are positive. Then

\frac{\omega^{X}(F)}{\omega^{X}\left(F^{\prime}\right)} \approx \frac{\omega^{A}(F)}{\omega^{A}\left(F^{\prime}\right)}, \quad \text { for any } X \in \Omega \backslash B(q, 2 r) \tag{2.33}
\end{equation*}
$$

In particular with the choice $F=\Delta(q, r)$, we have

\begin{equation*}
\frac{\omega^{X}\left(F^{\prime}\right)}{\omega^{X}(\Delta(x, r))} \approx \omega^{A}\left(F^{\prime}\right) \quad \text { for any } X \in \Omega \backslash B(q, 2 r) . \tag{2.34}
\end{equation*}
$$

Lemma 2.35 (CFMS estimate). There exists a constant $C \geq 1$, such that for any $q \in \partial \Omega$, $0<r<\operatorname{diam}(\partial \Omega) / M$, and $A=A(q, r)$, a corkscrew point relative to $\Delta(q, r)$, the Green's function $G=G_{L}$ satisfies

$$
\begin{equation*}
C^{-1} \frac{G\left(X_{0}, A\right)}{r} \leq \frac{\omega^{X_{0}}(\Delta(q, r))}{r^{n-1}} \leq C \frac{G\left(X_{0}, A\right)}{r} \tag{2.36}
\end{equation*}
$$

for any $X_{0} \in \Omega \backslash B(q, 2 r)$.

Lemma 2.37 (Doubling property of the elliptic measure). For every $q \in \partial \Omega$ and $0<r<$ $\operatorname{diam}(\partial \Omega) / 4$, we have

$$
\begin{equation*}
\omega^{X}(\Delta(q, 2 r)) \leq C \omega^{X}(\Delta(q, r)) \tag{2.38}
\end{equation*}
$$

for any $X \in \Omega \backslash B(q, 4 r)$.
Remark 2.39. The following simple observation will be useful. If $M$ denotes the corkscrew constant for $\Omega$, it follows easily from the previous result, Lemma 2.29 and Harnack's inequality that

\omega^{X}(\Delta(q, 2 r)) \leq C_{2} \omega^{X}(\Delta(q, r)) \tag{2.40}
\end{equation*}

for every $q \in \partial \Omega, 0<r<\operatorname{diam}(\partial \Omega) / 4$ and for all $X \in \Omega$ with $\delta(X) \geq r /(2 M)$. Here $C_{2}$ is a constant that depends on the allowable parameters associated with $\Omega$ and the ellipticity constants of $L$.

Our next result establishes that if a domain satisfies the Harnack chain condition then we can modify the chain of balls so that they avoid a non-tangential balls inside:

Lemma 2.41. Let $\Omega \subset \mathbb{R}^{n}$ be an open set satisfying the Harnack chain condition with constants $M, C_{1}>1$. Given $X_{0} \in \Omega$, let $B_{X_{0}}=B\left(X_{0}, \delta\left(X_{0}\right) / 2\right)$. For every $X, Y \in \Omega \backslash$ $\overline{B_{X_{0}}}$, if we set $\Pi=|X-Y| / \min \{\delta(X), \delta(Y)\}$, then there is a chain of open Harnack balls $B_{1}, B_{2}, \ldots, B_{K} \subset \Omega$ with $K \leq 100\left(M+C_{1}^{2}\right)\left(2+\log _{2}^{+} \Pi\right)$ that connects $X$ to $Y$. Namely, $X \in B_{1}, Y \in B_{K}, B_{k} \cap B_{k+1} \neq \emptyset$ for every $1 \leq k \leq K-1$ and for every $1 \leq k \leq K$

$$
\begin{equation*}
\left(100 C_{1}\right)^{-2} \operatorname{diam}\left(B_{k}\right) \leq \operatorname{dist}\left(B_{k}, \partial \Omega\right) \leq 100 C_{1}^{2} \operatorname{diam}\left(B_{k}\right) \tag{2.42}
\end{equation*}
$$

Moreover, $B_{k} \cap \frac{1}{2} B_{X_{0}}=\emptyset$ for every $1 \leq k \leq K$.
Proof. Fix $X, Y$ as in the statement and without loss of generality we assume that $\delta(X) \leq$ $\delta(Y)$. Use the Harnack chain condition for $\Omega$ to construct the chain of balls $B_{1}, \ldots, B_{K}$ as in Definition 2.5. If none of $B_{k}$ meets $B_{X_{0}}$ then there is nothing to do as this original chain satisfies all the required condition. Hence we may suppose that some $B_{k}$ meets $B_{X_{0}}$. The main idea is that then we can modify the chain of balls by adding some small balls that surround $X_{0}$. To be more precise, we let $k_{-}$and $k_{+}$be respectively the first and last ball in the chain meeting $B_{X_{0}}$. Note that $1 \leq k_{-} \leq k_{+} \leq K$.

We pick $X_{-} \in B_{k_{-}} \backslash \overline{B_{X_{0}}}$ : If $k_{-}=1$ we let $X_{-}=X$ or if $k_{-}>1$ we pick $X_{-} \in B_{k_{-}-1} \cap B_{k_{-}}$. Since $B_{k_{-}}$meets $B_{X_{0}}$ then we can find $Y_{-} \in B_{k_{-}} \cap \partial B_{X_{0}}$ such that the open segment joining $X_{-}$ and $Y_{-}$is contained in $B_{k_{-}} \backslash \overline{B_{X_{0}}}$. Analogously we can find $X_{+} \in B_{k_{+}} \backslash \overline{B_{X_{0}}}$ and $Y_{+} \in B_{k_{+}} \cap \partial B_{X_{0}}$ such that the open segment joining $X_{+}$and $Y_{+}$is contained in $B_{k_{+}} \backslash \overline{B_{X_{0}}}$.

Next set $r=\delta(X) /\left(16 C_{1}\right)$ and let $N_{ \pm} \geq 0$ be such that $N_{ \pm} \leq\left|X_{ \pm}-Y_{ \pm}\right| / r<N_{ \pm}+1$. For $j=0, \ldots, N_{ \pm}$, let

$$
B_{ \pm}^{j}=B\left(X_{ \pm}^{j}, r\right), \quad \text { where } \quad X_{ \pm}^{j}=X_{ \pm}+j r \frac{Y_{ \pm}-X_{ \pm}}{\left|Y_{ \pm}-X_{ \pm}\right|}
$$

Straightforward arguments show that $N_{ \pm} \leq 32 C_{1}^{2}, X_{ \pm} \in B_{ \pm}^{0}, Y_{ \pm} \in B_{ \pm}^{N_{ \pm}}, B_{ \pm}^{j} \cap B_{ \pm}^{j+1} \neq \emptyset$ for every $0 \leq j \leq N_{ \pm}-1$, and

$$
\left(32 C_{1}^{2}\right)^{-1} \operatorname{diam}\left(B_{ \pm}^{j}\right) \leq \operatorname{dist}\left(B_{ \pm}^{j}, \partial \Omega\right) \leq 32 C_{1}^{2} \operatorname{diam}\left(B_{ \pm}^{j}\right), \quad B_{ \pm}^{j} \cap \frac{1}{2} B_{X_{0}}=\emptyset,
$$

for every $0 \leq j \leq N_{ \pm}-1$.
Next, since $X_{ \pm} \in \partial B_{X_{0}}$ we can find a sequence of balls $B^{0}, \ldots, B^{N}$ centered at $\partial B_{X_{0}}$ and with radius $\delta(X) / 16$ (hence $B^{j} \cap \frac{1}{2} B_{X_{0}}=\emptyset$ ) so that $N \leq 64, Y_{-} \in B^{0}, Y_{+} \in B^{N}, B^{j} \cap B^{j+1} \neq \emptyset$ for $0 \leq j \leq N-1$ and $32^{-1} \leq \operatorname{dist}\left(B^{j}, \partial \Omega\right) / \operatorname{diam}\left(B^{j}\right) \leq 32$.

Finally, to form the desired Harnack chain we concatenate the sub-chains $\left\{B_{1}, \ldots B_{k_{-}-1}\right\}$, $\left\{B_{-}^{0}, \ldots B_{-}^{N_{-}}\right\},\left\{B^{0}, \ldots B^{N}\right\},\left\{B_{+}^{N}, \ldots, B_{+}^{0}\right\},\left\{B_{k_{+}+1}, \ldots B_{K}\right\}$ and the resulting chain have all the desired properties. To complete the proof we just need to observe that the length of the chain is controlled by $K+N_{-}+N+N_{+}+3 \leq 100\left(M+C_{1}^{2}\right)\left(2+\log _{2}^{+} \Pi\right)$.
2.3. Compactness of closed sets and Radon measures. The reader may be familiar with the notion of convergence of compact sets in the Hausdorff distance; for general closed sets, not necessarily compact, we use the following notion of convergence, see [DS1, Section 8.2] for details. (It was pointed out to us that this notion is also referred to as the Attouch-Wets topology, see for example [Bee, Chapter 3].)

Definition 2.43 (Convergence of closed sets). Let $\left\{E_{j}\right\}$ be a sequence of non-empty closed subsets of $\mathbb{R}^{n}$, and let $E$ be another non-empty closed subset of $\mathbb{R}^{n}$. We say that $E_{j}$ converges to $E$, and write $E_{j} \rightarrow E$, if

$$
\lim _{j \rightarrow \infty} \sup _{x \in E_{j} \cap B(0, R)} \operatorname{dist}(x, E)=0
$$

and

$$
\lim _{j \rightarrow \infty} \sup _{x \in E \cap B(0, R)} \operatorname{dist}\left(x, E_{j}\right)=0
$$

for all $R>0$. By convention, these suprema are interpreted to be zero when the relevant sets are empty.

We remark that in the above definition, we may replace the balls $B(0, R)$ by arbitrary balls in $\mathbb{R}^{n}$. The following compactness property has been proved in [DS1, Lemma 8.2]:

Lemma 2.44 (Compactness of closed sets). Let $\left\{E_{j}\right\}$ be a sequence of non-empty closed subsets of $\mathbb{R}^{n}$, and suppose that there exists an $r>0$ such that $E_{j} \cap B(0, r) \neq \emptyset$ for all $j$.

Then there is a subsequence of $\left\{E_{j}\right\}$ that converges to a nonempty closed subset $E$ of $\mathbb{R}^{n}$ in the sense defined above.

Given a Radon measure $\mu$ on $\mathcal{R}^{n}$ (i.e., a non-negative Borel such that the measure of any compact set is finite) we define

$$
\operatorname{spt} \mu=\overline{\left\{x \in \mathbb{R}^{n}: \mu(B(x, r))>0 \text { for any } r>0\right\}} .
$$

Definition 2.45. We say that a Radon measure $\mu$ on $\mathcal{R}^{n}$ is Ahlfors regular with constant $C \geq 1$, if there exits a constant $C \geq 1$ such that for any $x \in E$ and $0<r<\operatorname{diam}(E)$,

$$
C^{-1} r^{n-1} \leq \mu(B(q, r)) \leq C r^{n-1}, \quad \forall x \in \operatorname{spt} \mu, 0<r<\operatorname{diam}(\operatorname{spt} \mu) .
$$

Definition 2.46. Let $\left\{\mu_{j}\right\}$ be a sequence of Radon measures on $\mathbb{R}^{n}$. We say $\mu_{j}$ converge weakly to a Radon measure $\mu_{\infty}$ and write $\mu_{j} \rightharpoonup \mu_{\infty}$, if

$$
\int f d \mu_{j} \rightarrow \int f d \mu_{\infty}
$$

for any $f \in C_{c}\left(\mathcal{R}^{n}\right)$.
We finish this section by stating a compactness type lemma for Radon measures which are uniformly doubling and "bounded below".

Lemma 2.47 ([TZ, Lemma 2.19]). Let $\left\{\mu_{j}\right\}_{j}$ be a sequence of Radon measures. Let $A_{1}, A_{2}>$ 0 be fixed constants, and assume the following conditions:
(i) $0 \in \operatorname{spt} \mu_{j}$ and $\mu_{j}(B(0,1)) \geq A_{1}$ for all $j$,
(ii) For all $j \in \mathbb{N}, q \in \operatorname{spt} \mu_{j}$ and $r>0$,

$$
\begin{equation*}
\mu_{j}(B(q, 2 r)) \leq A_{2} \mu_{j}(B(q, r)) \tag{2.48}
\end{equation*}
$$

If there exists a Radon measure $\mu_{\infty}$ such that $\mu_{j} \rightarrow \mu_{\infty}$, then $\mu_{\infty}$ is doubling and

$$
\begin{equation*}
\operatorname{spt} \mu_{j} \rightarrow \operatorname{spt} \mu_{\infty}, \tag{2.49}
\end{equation*}
$$

in the sense of Definition 2.43.

## Part I. Small constant case

The plan of Part I is as follows. We prove Theorem 1.8 by contradiction using a compactness argument. More precisely, we assume that there is a family of bounded uniform domains with Ahlfors regular boundaries and a family of divergence form elliptic operators with associated elliptic measures in the class $A_{\infty}$ and with all the implicit constants uniformed controlled. We also have that the oscillations of the coefficients convergence to 0 and that the exterior corkscrew condition fails for each domain in the family. This is all detailed in Section 3. The goal is to reach a contradiction and with that goal in mind we show in Section 4 that passing to a subsequence there are a limiting domain which is uniform and has Ahlfors regular boundary and a limiting constant coefficient elliptic operator in that limiting domain whose associated elliptic measure belongs to the class $A_{\infty}$. With this in
hand in Section 5 we are in a position to apply Theorem 1.1 to obtain that the limiting domain satisfies the exterior corkscrew. This in turn leads us to a contradiction since the exterior corkscrew condition fails for any of the domains in the family.

## 3. Compactness argument

To prove Theorem 1.8 we will proceed by contradiction. First we discuss the constant $N$. Recall that, as noted above, the assertion that (a) implies (c) in Theorem 1.1 extends routinely to all constant coefficient second order elliptic operators; alternatively, this fact follows from the results of [HMT1] as (1.4) and (H1) holds trivially in the constant coefficient case. Thus given values of the allowable constants $M, C_{1}, C_{A R}, \Lambda / \lambda, C_{0}, \theta$, let $\Omega \subset \mathbb{R}^{n}$, $n \geq 3$, be a uniform domain with constants $M, C_{1}$, whose boundary is Ahlfors regular with constant $C_{A R}$, and let $L=-\operatorname{div}\left(\mathcal{A}_{0} \nabla\right)$ be a constant coefficient elliptic operator where the constant real symmetric matrix $\mathcal{A}_{0}$ satisfies (1.5) with ellipticity constants $\lambda, \Lambda$, and such that the corresponding elliptic measure $\omega_{L} \in A_{\infty}(\sigma)$ with constants $C_{0}$ and $\theta$. Then there exists a constant $N_{0}=N_{0}\left(M, C_{1}, C_{A R}, \Lambda / \lambda, C_{0}, \theta\right)$ such that $\Omega$ satisfies the exterior corkscrew condition with constant $N_{0}$. We underline that this $N_{0}$ depends on the ratio of the ellipticity constants rather than the matrix $\mathcal{A}_{0}$ per se.

With this in mind, set

$$
\begin{equation*}
N=4 N_{0}\left(4 M, 2 C_{1}, 2^{5(n-1)} C_{A R}^{2}, \Lambda / \lambda, C_{0} C_{2} C_{A R}^{4 \theta} 2^{8(n-1) \theta}, \theta\right) \tag{3.1}
\end{equation*}
$$

where the constant $C_{2}=C_{2}\left(M, C_{1}, C_{A R}, \Lambda / \lambda\right)$ can be found in Remark 2.39.
We now state the contradiction hypothesis: for fixed $n \geq 3$, we suppose that there exists a set of allowable constants $M, C_{1}, C_{A R}>1, \Lambda \geq \lambda=1, C_{0}>1$ and $0<\theta<1$, and a sequence $\epsilon_{j}$ (with $\epsilon_{j} \rightarrow 0$ as $j \rightarrow \infty$ ), so that the following holds:

Assumption (a): For each $j$ there is a bounded domain $\Omega_{j} \subset \mathbb{R}^{n}$, which is uniform with constants $M, C_{1}$ and whose boundary is Ahlfors regular with constant $C_{A R}$. Also, there is an elliptic matrix $\mathcal{A}_{j}$ defined on $\Omega_{j}$, with ellipticity constants $\lambda=1$ and $\Lambda$, and we write $L_{j}=-\operatorname{div}\left(\mathcal{A}_{j} \nabla\right)$.
Assumption (b): $\operatorname{osc}\left(\Omega_{j}, \mathcal{A}_{j}\right)<\epsilon_{j}$ (see (1.9)).
Assumption (c): The elliptic measure of the operator $L_{j}$ in $\Omega_{j}$ is of class $A_{\infty}$ with respect to the surface measure $\sigma_{j}=\mathcal{H}^{n-1} \mid \partial_{\Omega_{j}}$ with constants $C_{0}$ and $\theta$ (see Definition 2.10).
Contrary to conclusion: For each $j$ there is $q_{j} \in \partial \Omega_{j}$ and $0<r_{j}<\operatorname{diam}\left(\partial \Omega_{j}\right)$ such that $\Omega_{j}$ has no exterior corkscrew point with constant $N$ (as in (3.1)). That is, there is no ball of radius $r_{j} / N$ contained in $B\left(q_{j}, r_{j}\right) \backslash \overline{\Omega_{j}}$.

Our goal is to obtain a contradiction and as a consequence our main result Theorem 1.8 will be proved. Without loss of generality we may assume $q_{j}=0$ and $r_{j}=1$ for all $j$, hence $\operatorname{diam}\left(\partial \Omega_{j}\right)>1$. Otherwise, we just replace the domain $\Omega_{j}$ by $\left(\Omega_{j}-q_{j}\right) / r_{j}$, and replace the elliptic matrix $\mathcal{A}_{j}(\cdot)$ by $\mathcal{A}_{j}\left(q_{j}+r_{j}\right)$. Note that the new domain and matrix have the same allowable constants, in particular the corresponding $A_{\infty}$ constants stay the same by the scaleinvariant nature of Definition 2.10; moreover after rescaling, the above Assumption (b) is
still satisfied:

$$
\operatorname{osc}\left(\frac{\Omega_{j}-q_{j}}{r_{j}}, \mathcal{A}_{j}\left(q_{j}+r_{j^{\prime}}\right)\right)=\operatorname{osc}\left(\Omega_{j}, \mathcal{A}_{j}\right)<\epsilon_{j}
$$

## 4. Limiting domains

We want to use a compactness argument similar to the blow-up argument in [TZ]. The crucial difference is that in [TZ], the elliptic operator tends to a constant-coefficient operator as we zoom in on the boundary and blow up the given domain; whereas here we need to work with a sequence of domains and their associated elliptic operators. In particular the geometric convergence of domains does not come for free, and more work is needed to analyze the limiting domain.

To be more precise, getting to the point where we can apply Theorem 1.1 (more precisely, its extension to the elliptic operators with constants coefficients or alternatively [HMT1] applied again to constant coefficient operators) requires showing first that if $\Omega_{\infty}$ is a "limiting domain" of the domains $\left\{\Omega_{j}\right\}$ 's, then $\Omega_{\infty}$ is an unbounded or bounded uniform domain with Ahlfors regular boundary. To accomplish this we also need to find the limit of the Green functions. Once we have this, to show that $\omega_{L_{\infty}} \in A_{\infty}\left(\sigma_{\infty}\right)$ for the limiting domain $\Omega_{\infty}$ and the limiting operator $L_{\infty}$, we need to construct the elliptic measure $\omega_{L_{\infty}}^{Z}$ for any $Z \in \Omega_{\infty}$ as a limiting measure compatible with the procedure. We will also show that $L_{\infty}$ is an elliptic operator with constants coefficients.

Throughout the rest of paper we follow the following conventions in terms of notations:

- For any $Z \in \Omega_{j}$ we write $\delta_{j}(Z)=\operatorname{dist}\left(Z, \partial \Omega_{j}\right)$.
- For any $q \in \partial \Omega_{j}$ and $r \in\left(0, \operatorname{diam}\left(\partial \Omega_{j}\right)\right)$, we use $A_{j}(q, r)$ to denote a corkscrew point in $\Omega_{j}$ relative to $B(q, r) \cap \partial \Omega_{j}$, i.e.,

$$
\begin{equation*}
B\left(A_{j}(q, r), \frac{r}{M}\right) \subset B(q, r) \cap \Omega_{j} \tag{4.1}
\end{equation*}
$$

4.1. Geometric limit. Since $\operatorname{diam}\left(\partial \Omega_{j}\right)>1$, modulo passing to a subsequence, one of the following two scenarios occurs:

Case I: $\operatorname{diam}\left(\Omega_{j}\right)=\operatorname{diam}\left(\partial \Omega_{j}\right) \rightarrow \infty$ as $j \rightarrow \infty$.
Case II: $\operatorname{diam}\left(\Omega_{j}\right)=\operatorname{diam}\left(\partial \Omega_{j}\right) \rightarrow R_{0} \in[1, \infty)$ as $j \rightarrow \infty$.
Therefore if $\Omega_{j}$ "converges" to a limiting domain $\Omega_{\infty}$, respectively Case I and Case II indicate that $\Omega_{\infty}$ is unbounded or bounded.

Let $X_{j} \in \Omega_{j}$ be a corkscrew point relative to $B\left(0, \operatorname{diam}\left(\Omega_{j}\right) / 2\right) \cap \partial \Omega_{j}$, then

$$
\begin{equation*}
\left|X_{j}\right| \sim \delta_{j}\left(X_{j}\right) \sim \operatorname{diam}\left(\Omega_{j}\right) \tag{4.2}
\end{equation*}
$$

with constants depending on the uniform constant $M$. Let $G_{j}$ be the Green function associated with $\Omega_{j}$ and the operator $L_{j}=-\operatorname{div}\left(\mathcal{A}_{j} \nabla\right)$, and $\left\{\omega_{j}^{X}\right\}_{X \in \Omega_{j}}$ be the corresponding elliptic measure. In Case I we have

$$
\begin{equation*}
\left|X_{j}\right| \sim \delta_{j}\left(X_{j}\right) \sim \operatorname{diam}\left(\Omega_{j}\right) \rightarrow \infty \tag{4.3}
\end{equation*}
$$

i.e., the poles $X_{j}$ tend to infinity eventually. We let

$$
\begin{equation*}
u_{j}(Z)=\frac{G_{j}\left(X_{j}, Z\right)}{\omega_{j}^{X_{j}}(B(0,1))} . \tag{4.4}
\end{equation*}
$$

In Case II, we may assume that $\operatorname{diam}\left(\Omega_{j}\right) \sim R_{0}$ for all $j$ sufficiently large (one could naively rescale again so that $R_{0}=1$, should that be the case one may lose the property that $r_{j}=1$ for all $j$ ). Hence, there are constants $0<c_{1}<c_{2}$ such that

$$
\begin{equation*}
c_{1} R_{0} \leq \delta_{j}\left(X_{j}\right) \leq\left|X_{j}\right| \leq c_{2} R_{0} \quad \text { for all } j \text { sufficiently large. } \tag{4.5}
\end{equation*}
$$

Thus modulo passing to a subsequence, $X_{j}$ converges to some point $X_{0}$ satisfying

$$
\begin{equation*}
c_{1} R_{0} \leq\left|X_{0}\right| \leq c_{2} R_{0} . \tag{4.6}
\end{equation*}
$$

Note that (4.5) and (4.6) in particular imply that for any $\rho$ sufficiently small (depending on $R_{0}$ and $c_{1}, c_{2}$ ), the ball $B\left(X_{0}, \rho\right)$ is contained in $\Omega_{j}$ and $\operatorname{dist}\left(B\left(X_{0}, \rho\right), \partial \Omega_{j}\right) \geq c_{1} R_{0} / 2$. In this case we let

$$
\begin{equation*}
u_{j}(Z)=G_{j}\left(X_{j}, Z\right) \tag{4.7}
\end{equation*}
$$

Our next goal is to describe what happens with the objects in question as we let $j \rightarrow \infty$. This is done in Theorems 4.8, 4.78, 4.86 below.

Theorem 4.8. Under Assumption (a), and using the notation above, we have the following properties (modulo passing to a subsequence which we relabel):
(1) Case I: there is a function $u_{\infty} \in C\left(\mathcal{R}^{n}\right)$ such that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets; moreover $\nabla u_{j} \rightharpoonup \nabla u_{\infty}$ in $L_{\mathrm{loc}}^{2}\left(\mathcal{R}^{n}\right)$.
(2) Case II: there is a function $u_{\infty} \in C\left(\mathcal{R}^{n} \backslash\left\{X_{0}\right\}\right)$ such that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets in $\mathcal{R}^{n} \backslash\left\{X_{0}\right\}$ and $\nabla u_{j} \rightharpoonup \nabla u_{\infty}$ in $L_{\text {loc }}^{2}\left(\mathcal{R}^{n} \backslash\left\{X_{0}\right\}\right)$.
(3) Let $\Omega_{\infty}=\left\{Z \in \mathcal{R}^{n}: u_{\infty}>0\right\}^{\text {II. }}$. Then $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ and $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$, in the sense of Definition 2.43. Moreover, $\Omega_{\infty}$ is an unbounded set with unbounded boundary in Case I, and it is bounded with diameter $R_{0} \geq 1$ in Case II .
(4) $\Omega_{\infty}$ is a nontrivial uniform domain with constants $4 M$ and $2 C_{1}$.
(5) There is an Ahlfors regular measure $\mu_{\infty}$ with constant $2^{2(n-1)} C_{A R}$ such that $\sigma_{j} \rightarrow$ $\mu_{\infty}$. Moreover, $\operatorname{spt} \mu_{\infty}=\partial \Omega_{\infty}$. In particular, this implies that

$$
2^{-3(n-1)} C_{A R}^{-1} \mu_{\infty} \leq \mathcal{H}^{n-1} \mid \partial \Omega_{\infty} \leq 2^{3(n-1)} C_{A R} \mu_{\infty}
$$

and hence $\partial \Omega_{\infty}$ is Ahlfors regular with constant $2^{5(n-1)} C_{A R}^{2}$.
Remark 4.10. Note that this result is purely geometric. The proof only uses Assumption (a), which states the geometric characters of domains $\Omega_{j}$ (i.e., they are uniform domains with Ahlfors regular boundaries) and the ellipticity of the matrix operator $\mathcal{A}_{j}$. The other assumptions are irrelevant for this.

[^4]Proof of (1) in Theorem 4.8. Let $R>1$ and note that for $j$ large enough (depending on $R$ ) we have that $X_{j} \notin B(0,4 R)$ since by (4.3)

$$
\left|X_{j}\right|=\left|X_{j}-0\right| \geq \delta_{j}\left(X_{j}\right) \sim \operatorname{diam}\left(\Omega_{j}\right) \rightarrow \infty, \quad \text { as } j \rightarrow \infty .
$$

In particular, $L_{j} u_{j}=0$ in $B(0,4 R) \cap \Omega_{j}$ in the weak sense. Recall that all our domains $\Omega_{j}$ have Ahlfors regular boundary and hence all boundary points are Wiener regular. This in turn implies that $u_{j}$ is a non-negative $L$-solution on $B(0,4 R) \cap \Omega_{j}$ which vanishes continuously on $B(0,4 R) \cap \partial \Omega_{j}$.

On the other hand, $0 \in \partial \Omega_{j}$ and, using our convention (4.1), $A_{j}(0,1)$ is a corkscrew point relative to $B(0,1) \cap \partial \Omega_{j}$ in the domain $\Omega_{j}$. Thus, by Lemma 2.35

$$
\begin{equation*}
u_{j}\left(A_{j}(0,1)\right) \sim 1 . \tag{4.11}
\end{equation*}
$$

We can then invoke Lemma 2.30, the fact that $A_{j}(0,2 R) \in \Omega_{j}$ is a corkscrew point relative to $B(0,2 R) \cap \partial \Omega_{j}$ for the domain $\Omega_{j}$, Harnack's inequality, and (4.11) to obtain

$$
\begin{equation*}
\sup _{Z \in \Omega_{j} \cap B(0,2 R)} u_{j}(Z) \leq C u_{j}\left(A_{j}(0,2 R)\right) \leq C_{R} u_{j}\left(A_{j}(0,1)\right) \leq C_{R} . \tag{4.12}
\end{equation*}
$$

Extending $u_{j}$ by 0 outside of $\Omega_{j}$ we conclude that the sequence $\left\{u_{j}\right\}_{j_{\geq j}}$ is uniformly bounded in $\overline{B(0, R)}$ for some $j_{0}$ large enough. Since for each $j, \mathcal{A}_{j}$ has ellipticity constants bounded below by $\lambda=1$ and above by $\Lambda$, and $\Omega_{j}$ is uniform and satisfies the $\operatorname{CDC}$ (as $\partial \Omega_{j}$ is Ahlfors regular) with the same constants as $\Omega_{j}$, then combining Lemma 2.24 with the DeGiorgi-Nash-Moser estimates we conclude that the sequence $\left\{u_{j}\right\}_{j}$ is equicontinuous on $\overline{B(0, R)}$ (in fact uniformly Hölder continuous with same exponent). Using Arzela-Ascoli combined with a diagonalization argument applied on a sequence of balls with radii going to infinity, we produce $u_{\infty} \in C\left(\mathcal{R}^{n}\right)$ and a subsequence (which we relabel) such that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$.

As observed before, $u_{j}$ is a non-negative $L$-solution on $B(0,4 R) \cap \Omega_{j}$ which vanishes continuously on $B(0,4 R) \cap \partial \Omega_{j}$ and which has been extended by 0 outside of $\Omega_{j}$. Thus it is a positive $L$-subsolution on $B(0,4 R)$ and we can use Caccioppoli's inequality along with (4.12) to conclude that

$$
\begin{equation*}
\int_{B(0, R)}\left|\nabla u_{j}\right|^{2} d Z \leq C R^{-2} \int_{B(0,2 R)}\left|u_{j}\right|^{2} d Z \leq C_{R} \tag{4.13}
\end{equation*}
$$

This and (4.12) allow us to conclude that

$$
\begin{equation*}
\sup _{j}\left\|u_{j}\right\|_{W^{1,2}(B(0, R))} \leq C_{R}<\infty . \tag{4.14}
\end{equation*}
$$

Thus, there exists a subsequence (which we relabel) which converges weakly in $W_{\mathrm{loc}}^{1,2}\left(\mathbb{R}^{n}\right)$. Since we already know that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$, we can use again (4.12) to easily see that $u_{\infty} \in W_{\text {loc }}^{1,2}\left(\mathbb{R}^{n}\right)$, and $\nabla u_{j} \rightharpoonup \nabla u_{\infty}$ in $L_{\text {loc }}^{2}\left(\mathbb{R}^{n}\right)$. This completes the proof of (1) in Theorem 4.8.

Proof of (2) in Theorem 4.8. Recall that in this case $X_{j} \rightarrow X_{0}$ as $j \rightarrow \infty$. For any $0<\rho \leq$ $c_{1} R_{0} / 2$ and for all $j$ large enough we have

$$
\begin{equation*}
B\left(X_{j}, \frac{\rho}{2}\right) \subset B\left(X_{0}, \rho\right) \subset B\left(X_{j}, 2 \rho\right) \subset \overline{B\left(X_{j}, 2 \rho\right)} \subset \overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right)} \subset \Omega_{j}, \tag{4.15}
\end{equation*}
$$

where we have used (4.5). Moreover, for $j$ sufficiently large,

$$
\begin{equation*}
\operatorname{dist}\left(B\left(X_{j}, 2 \rho\right), \partial \Omega_{j}\right)>\frac{c_{1} R_{0}}{2} \tag{4.16}
\end{equation*}
$$

For any $Z \in \Omega_{j} \backslash B\left(X_{j}, \rho / 4\right)$, using (4.7) and (2.20) it follows that

$$
\begin{equation*}
u_{j}(Z) \leq \frac{C}{\left|Z-X_{j}\right|^{n-2}} \leq \frac{4^{n-2} C}{\rho^{n-2}} \tag{4.17}
\end{equation*}
$$

Extending $u_{j}$ by 0 outside $\Omega_{j}$ the previous estimate clearly holds for every $Z \in \mathcal{R}^{n} \backslash \Omega_{j}$. Thus $\sup _{j}\left\|u_{j}\right\|_{L^{\infty}\left(\mathcal{R}^{n} \backslash B\left(X_{0}, \rho\right)\right)} \leq C(\rho)$. Moreover, as in Case I, the sequence is also equicontinuous (in fact uniformly Hölder continuous). Using Arzela-Ascoli theorem with a diagonalization argument, we can find $u_{\infty} \in C\left(\mathcal{R}^{n} \backslash\left\{X_{0}\right\}\right)$ and a subsequence (which we relabel) such that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets of $\mathcal{R}^{n} \backslash\left\{X_{0}\right\}$.

Let $0<R \leq \sup _{j \gg 1} \operatorname{diam}\left(\Omega_{j}\right) \sim R_{0}$. We claim that

$$
\begin{equation*}
\int_{B(0, R) \backslash B\left(X_{0}, \rho\right)}\left|\nabla u_{j}\right|^{2} d Z \leq C(R, \rho)<\infty \tag{4.18}
\end{equation*}
$$

To prove this, we first take arbitrary $q \in \partial \Omega_{j}$ and $s$ such that $0<s \leq \delta_{j}\left(X_{j}\right) / 5 \sim R_{0}$. In particular, if $0<\rho<c_{1} R_{0} / 10 \leq \delta_{j}\left(X_{j}\right) / 10$ it follows that $B(q, 4 s) \subset \mathcal{R}^{n} \backslash B\left(X_{j}, 2 \rho\right) \subset$ $\mathcal{R}^{n} \backslash B\left(X_{0}, \rho\right)$. Thus, proceeding as in Case $\mathbf{I}, u_{j}$ is non-negative subsolution on $B(q, 2 s)$ and we can use Caccioppoli's inequality and (4.17) to obtain

$$
\begin{equation*}
\int_{B(q, s) \backslash B\left(X_{0}, \rho\right)}\left|\nabla u_{j}\right|^{2} d Z=\int_{B(q, s)}\left|\nabla u_{j}\right|^{2} d Z \leq \frac{C}{s^{2}} \int_{B(q, 2 s)}\left|u_{j}(Z)\right|^{2} d Z \lesssim \frac{s^{n-2}}{\rho^{2(n-2)}} \tag{4.19}
\end{equation*}
$$

Note that the previous estimate, with $q=0$ and $s=R$, gives our claim (4.18) when $0<R \leq \delta_{j}\left(X_{j}\right) / 5$.

Consider next the case $R_{0} \sim \delta_{j}\left(X_{j}\right) / 5<R \leq \sup _{j \gg 1} \operatorname{diam}\left(\Omega_{j}\right) \sim R_{0}$. Note first that the set $\Theta_{j}:=\left\{Z \in \Omega_{j}: \delta_{j}(Z)<\delta_{j}\left(X_{j}\right) / 25\right\}$ can be covered by a family of balls $\left\{B\left(q_{i}, \delta_{j}\left(X_{j}\right) / 5\right)\right\}_{i}$ with $q_{i} \in \partial \Omega$ and whose cardinality is uniformly bounded (here we recall that $\delta_{j}\left(X_{j}\right) \sim$ $\operatorname{diam}\left(\Omega_{j}\right)$ ), Thus, (4.19) applied to these each ball in the family yields

$$
\begin{equation*}
\int_{\left(B(0, R) \backslash B\left(X_{0}, \rho\right)\right) \cap \Theta_{j}}\left|\nabla u_{j}\right|^{2} d Z \leq \sum_{i} \int_{B\left(q_{i}, \delta_{j}\left(X_{j}\right) / 5\right) \backslash B\left(X_{0}, \rho\right)}\left|\nabla u_{j}\right|^{2} d Z \leq C(R, \rho)<\infty . \tag{4.20}
\end{equation*}
$$

On the other hand, the set $\left\{Z \in \Omega_{j} \backslash B\left(X_{j}, \rho / 2\right): \delta_{j}(Z) \geq \delta_{j}\left(X_{j}\right) / 25\right\}$ can be covered by a family of balls $\left\{B_{i}\right\}_{i}$ so that $r_{B_{i}}=\rho / 16,4 B_{i} \subset \Omega_{j} \backslash B\left(X_{j}, \rho / 4\right)$. Moreover, the cardinality of the family is uniformly bounded depending on dimension and the ratio $\operatorname{diam}\left(\Omega_{j}\right) / \rho \sim R_{0} / \rho$. Using (4.15), Caccioppoli's inequality in each $B_{i}$ since $4 B_{i} \subset \Omega_{j} \backslash B\left(X_{j}, \rho / 4\right)$, and (4.17) we obtain

$$
\begin{equation*}
\int_{\left(B(0, R) \backslash B\left(X_{0}, \rho\right)\right) \backslash \Theta_{j}}\left|\nabla u_{j}\right|^{2} d Z \leq \sum_{i} \int_{B_{i}}\left|\nabla u_{j}\right|^{2} d Z \lesssim \sum_{i} \frac{1}{r_{B_{i}}^{2}} \int_{2 B_{i}}\left|u_{j}(Z)\right|^{2} d Z \leq C(R, \rho) \tag{4.21}
\end{equation*}
$$

Combining (4.20) and (4.21) we obtain the desired estimate and hence proof of the claim (4.18) is complete.

Next, we combine (4.18) with the fact that $\sup _{j}\left\|u_{j}\right\|_{L^{\infty}\left(\mathcal{R}^{n} \backslash B\left(X_{0}, \rho\right)\right)} \leq C(\rho)$ to obtain that $\sup _{j}\left\|u_{j}\right\|_{W^{1,2}\left(B(0, R) \backslash B\left(X_{0}, \rho\right)\right)} \leq C(R, \rho)<\infty$. Thus, there exists a subsequence (which we relabel) which converges weakly in $W_{\mathrm{loc}}^{1,2}\left(\mathbb{R}^{n} \backslash B\left(X_{0}, \rho\right)\right)$. Since we already know that $u_{j} \rightarrow u_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n} \backslash B\left(X_{0}, \rho\right)$, we can easily see that $u_{\infty} \in W_{\text {loc }}^{1,2}\left(\mathbb{R}^{n} \backslash B\left(X_{0}, \rho\right)\right)$, and $\nabla u_{j} \rightharpoonup \nabla u_{\infty}$ in $L_{\text {loc }}^{2}\left(\mathbb{R}^{n} \backslash B\left(X_{0}, \rho\right)\right)$. This completes the proof of (2) in Theorem 4.8.

Remark 4.22. In the Case II scenario the following remarks will become useful later. In what follows we assume that $0<\rho \leq c_{1} R_{0} / 2$ and $j$ is large enough.
(i) Let us pick $Y \in \partial B\left(X_{j}, 3 \delta_{j}\left(X_{j}\right) / 4\right)$ and note that (4.5) gives $Y, A_{j}\left(0, c_{1} R_{0} / 2\right) \in \Omega_{j} \backslash$ $\overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right)},\left|Y-A_{j}\left(0, c_{1} R_{0} / 2\right)\right|<\left(c_{1}+2 c_{2}\right) R_{0}$, and $\delta_{j}(Y) \geq c_{1} R_{0} / 4$. Recalling that $\Omega_{j}$ satisfies the interior corkscrew condition with constant $M$, it follows by definition that $\delta_{j}\left(A_{j}\left(0, c_{1} R_{0} / 2\right)\right) \geq c_{1} R_{0} /(2 M)$. All these allow us to invoke Lemma 2.41 to then use (2.21) and (4.5) and eventually show

$$
u_{j}\left(A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right)\right) \sim u_{j}(Y) \gtrsim\left|Y-X_{j}\right|^{2-n} \sim \delta_{j}\left(X_{j}\right)^{2-n} \sim R_{0}^{2-n},
$$

where the implicit constants are independent of $j$.
(ii) The set $\partial B\left(X_{0}, \rho\right)$ is compact and away from $X_{0}$, so $u_{j} \rightarrow u_{\infty}$ uniformly in $\partial B\left(X_{0}, \rho\right)$. Since $X_{j} \rightarrow X_{0}$, for any $Z \in \partial B\left(X_{0}, \rho\right)$ we have $\rho / 2<\left|Z-X_{j}\right|<2 \rho$ for $j$ sufficiently large. In particular by choosing $\rho<R_{0} /(16 M)$, we have for $j$ large enough

$$
\begin{equation*}
\left|Z-X_{j}\right|<2 \rho<\frac{R_{0}}{8 M} \leq \frac{\operatorname{diam}\left(\Omega_{j}\right)}{4 M} \leq \frac{\delta_{j}\left(X_{j}\right)}{2}, \tag{4.24}
\end{equation*}
$$

where the last estimate uses that $X_{j} \in \Omega_{j}$ is a corkscrew point relative to the surface ball $B\left(0, \operatorname{diam}\left(\Omega_{j}\right) / 2\right) \cap \partial \Omega_{j}$ with constant $M$. Thus by (2.21) if $j$ is large enough

$$
u_{j}(Z) \gtrsim\left|Z-X_{j}\right|^{2-n} \gtrsim \rho^{2-n}, \quad \forall Z \in \partial B\left(X_{0}, \rho\right)
$$

with implicit constants which are independent of $j$. Therefore,

$$
\begin{equation*}
u_{\infty}(Z)=\lim _{j \rightarrow \infty} u_{j}(Z) \gtrsim \rho^{2-n}, \quad \forall Z \in \partial B\left(X_{0}, \rho\right) \tag{4.25}
\end{equation*}
$$

For this reason it is natural to extend the definition of $u_{\infty}$ to all of $\mathcal{R}^{n}$ by simply letting $u_{\infty}\left(X_{0}\right)=+\infty$.
(iii) Since $u_{j}$ is the Green function in $\Omega_{j}$ for $L_{j}$, an elliptic operator with uniform ellipticity constants $\lambda=1$ and $\Lambda$, by (2.23) we know for any $1<r<\frac{n}{n-1}$,

$$
\left\|\nabla u_{j}\right\|_{L^{r}\left(\Omega_{j}\right)} \lesssim\left|\Omega_{j}\right|^{\frac{1}{r}-\frac{n-1}{n}} \lesssim R_{0}^{\frac{n}{r}-n+1}<\infty,
$$

provided $j$ is large enough and where the implicit constants depend on dimension, $r$, and $\Lambda$, but are independent of $j$. Note that $\nabla u_{j} \equiv 0$ outside of $\Omega_{j}$ by construction. Thus, one can easily show that passing to a subsequence (and relabeling) $\nabla u_{j} \rightharpoonup$ $\nabla u_{\infty}$ in $L_{\text {loc }}^{r}\left(\mathbb{R}^{n}\right)$ for $1<r<n /(n-1)$.

Proof of (3) in Theorem 4.8: Case I. It is clear that $\Omega_{\infty}$ is an open set in Case I since $u \in$ $C^{\infty}\left(\mathcal{R}^{n}\right)$. On the other hand, since $0 \in \partial \Omega_{j}$ for all $j$, by Lemma 2.44 and modulo passing to a subsequence (which we relabel) we have that there exist non-empty closed sets $\Gamma_{\infty}, \Lambda_{\infty}$ such that $\overline{\Omega_{j}} \rightarrow \Gamma_{\infty}$ and $\partial \Omega_{j} \rightarrow \Lambda_{\infty}$ as $j \rightarrow \infty$, where the convergence is in the sense of Definition 2.43.

We are left with obtaining

$$
\begin{equation*}
\Lambda_{\infty}=\partial \Omega_{\infty} \quad \text { and } \quad \Gamma_{\infty}=\bar{\Omega}_{\infty} \tag{4.27}
\end{equation*}
$$

We first show that $\Lambda_{\infty} \subset \partial \Omega_{\infty}$. To that end we take $p \in \Lambda_{\infty}$, and there is a sequence $p_{j} \in \partial \Omega_{j}$ such that $\lim _{j \rightarrow \infty} p_{j}=p$. Note that $u_{\infty}(p)=\lim _{j \rightarrow \infty} u_{j}(p)$. On the other hand since the $u_{j}$ 's are uniformly Hölder continuous on compact sets (see the Proof of (1) in Theorem 4.8) and $u_{j}\left(p_{j}\right)=0$ as $p_{j} \in \partial \Omega_{j}$ we have

$$
0 \leq u_{\infty}(p) \leq\left|u_{\infty}(p)-u_{j}(p)\right|+\left|u_{j}(p)-u_{j}\left(p_{j}\right)\right| \lesssim\left|u_{\infty}(p)-u_{j}(p)\right|+\left|p-p_{j}\right|^{\alpha} \rightarrow 0,
$$

as $j \rightarrow \infty$. Thus $u_{\infty}(p)=0$, that is, $p \in \mathcal{R}^{n} \backslash \Omega_{\infty}$.
Our goal is to show that $p \in \partial \Omega_{\infty}$. Suppose that $p \notin \partial \Omega_{\infty}$, then $p \in \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$ and there exists $\epsilon \in(0,1)$ such that $B(p, \epsilon) \subset \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$, that is, $u_{\infty} \equiv 0$ on $\overline{B(p, \epsilon)}$. In $\Omega_{j}$ we have

$$
\left|A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)-A_{j}(0,1)\right| \leq \frac{\epsilon}{2}+\left|p_{j}\right|+1 \leq 2(|p|+1)
$$

and

$$
\delta_{j}\left(A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right) \geq \frac{1}{M} \frac{\epsilon}{2}, \quad \delta_{j}\left(A_{j}(0,1)\right) \geq \frac{1}{M} .
$$

Note also that

$$
\frac{\delta_{j}\left(A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right)}{\delta_{j}\left(X_{j}\right)}+\frac{\delta_{j}\left(A_{j}(0,1)\right)}{\delta_{j}\left(X_{j}\right)} \sim \frac{1}{\operatorname{diam}\left(\Omega_{j}\right)} \rightarrow 0, \quad \text { as } j \rightarrow \infty,
$$

hence for $j$ large enough, $\left.A_{j}(0,1), A_{j}\left(p_{j}, \frac{\epsilon}{2}\right) \notin \overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right.}\right)$.
We can then apply Lemma 2.41 and Harnack's inequality along the constructed chain in $\Omega_{j}$ to obtain

$$
G_{j}\left(X_{j}, A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right) \sim G_{j}\left(X_{j}, A_{j}(0,1)\right),
$$

where the implicit constants depend on the allowable parameters, $\epsilon$ and $|p|$, but are uniform on $j$. Hence by (4.11),

$$
\begin{equation*}
u_{j}\left(A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right)=\frac{G_{j}\left(X_{j}, A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right)}{\omega_{j}^{X_{j}}(B(0,1))} \gtrsim C \frac{G_{j}\left(X_{j}, A_{j}(0,1)\right)}{\omega_{j}^{X_{j}}(B(0,1))}=u_{j}\left(A_{j}(0,1)\right) \geq C_{0} \tag{4.28}
\end{equation*}
$$

where $C_{0}$ is independent of $j$.
Note that since $u_{j} \rightarrow u_{\infty}$ on compact sets it follows from our assumption that for $j$ large enough depending on $C_{0}$

$$
\begin{equation*}
u_{j}(Z)=u_{j}(Z)-u_{\infty}(Z)<\frac{C_{0}}{2}, \quad \forall Z \in \overline{B(p, \epsilon)} . \tag{4.29}
\end{equation*}
$$

However, for $j$ large enough $A_{j}\left(p_{j}, \epsilon / 2\right) \in B\left(p_{j}, \epsilon / 2\right) \subset B(p, \epsilon)$ and then (4.29) contradicts (4.28). Thus, we have shown that necessarily $p \in \partial \Omega_{\infty}$ and consequently $\Lambda_{\infty} \subset \partial \Omega_{\infty}$.

Let us next show that $\partial \Omega_{\infty} \subset \Lambda_{\infty}$. Assume that $p \notin \Lambda_{\infty}$. Since $\Lambda_{\infty}$ is a closed set, there exists $\epsilon>0$ such that $B(p, 2 \epsilon) \cap \Lambda_{\infty}=\emptyset$. Since $\Lambda_{\infty}$ is the limit of $\partial \Omega_{j}$, by Definition 2.43 we have that for $j$ large enough $B(p, \epsilon) \cap \partial \Omega_{j}=\emptyset$. Hence, by passing to a subsequence (and relabeling) either $B(p, \epsilon) \subset \Omega_{j}$ for all $j$ large enough or $B(p, \epsilon) \subset \mathcal{R}^{n} \backslash \overline{\Omega_{j}}$ for all $j$ large enough.

We first consider the case $B(p, \epsilon) \subset \Omega_{j}$. Hence, $\delta_{j}(p) \geq \epsilon$ and $\left|A_{j}(0,1)-p\right| \leq 1+|p|$. Thus there exists a Harnack chain joining $A_{j}(0,1)$ and $p$ whose length is independent of $j$ and depends on $\epsilon$ and $|p|$. We next observe that for $j$ large enough $\left|p-X_{j}\right|>\delta_{j}\left(X_{j}\right) / 2$. Indeed, if we take $j$ large enough, using that $0 \in \partial \Omega_{j}$ and (4.3) we clearly have

$$
1 \leq \frac{\left|X_{j}\right|}{\delta_{j}\left(X_{j}\right)} \leq \frac{\left|X_{j}-p\right|}{\delta_{j}\left(X_{j}\right)}+\frac{|p|}{\delta_{j}\left(X_{j}\right)}<\frac{\left|X_{j}-p\right|}{\delta_{j}\left(X_{j}\right)}+\frac{1}{2},
$$

and we just need to hide to obtain the desired estimate. Once we know that $\left|p-X_{j}\right|>$ $\delta_{j}\left(X_{j}\right) / 2$, we also note that $\left|\delta_{j}\left(A_{j}(0,1)\right)\right| \leq 1 \ll \operatorname{diam}\left(\Omega_{j}\right) \sim \delta_{j}\left(X_{j}\right)$ and hence $A_{j}(0,1) \notin$ $\left.\overline{B\left(X_{j}, \delta\left(X_{j}\right) / 2\right.}\right)$ for $j$ large enough.

We can now invoke Lemma 2.41 and Harnack's inequality along the constructed chain in $\Omega_{j}$ to obtain that $G_{j}\left(X_{j}, p\right) \sim G_{j}\left(X_{j}, A_{j}(0,1)\right)$, which combined with (4.4) and (4.11), yields

$$
\begin{equation*}
u_{j}(p) \sim u_{j}\left(A_{j}(0,1)\right) \sim 1, \tag{4.30}
\end{equation*}
$$

where the implicit constants depend on the allowable parameters, $p$ and $\epsilon$, but are uniform on $j$. Letting $j \rightarrow \infty$ we obtain that $u_{\infty}(p) \sim 1$ which implies that $p \in \Omega_{\infty}$, and since we have already shown that $\Omega_{\infty}$ is open, it follows that $p \notin \partial \Omega_{\infty}$.

We next consider now the case $B(p, \epsilon) \subset \mathcal{R}^{n} \backslash \overline{\Omega_{j}}$ for all $j$ large enough which implies that by construction $u_{j}(X)=0$ for all $X \in B(p, \epsilon)$. By uniform convergence of $u_{j}$ in compact sets we have that $u_{\infty}(X)=0$ for $X \in B(p, \epsilon / 2)$, which implies $B(p, \epsilon / 2) \subset\left\{u_{\infty}=0\right\}$ and therefore $p \notin \partial \Omega_{\infty}$.

In both cases we have shown that if $p \notin \Lambda_{\infty}$ then $p \notin \partial \Omega_{\infty}$, or, equivalently, $\partial \Omega_{\infty} \subset \Lambda_{\infty}$. This together with the converse inclusion completes the proof of $\Lambda_{\infty}=\partial \Omega_{\infty}$.

Our next goal is to show that $\Gamma_{\infty}=\bar{\Omega}_{\infty}$. Note that if $Z \in \Omega_{\infty}$, then $u_{\infty}(Z)>0$ and this implies that $u_{j}(Z)>0$ for $j$ large enough. The latter forces $Z \in \Omega_{j}$ for all $j$ large enough. This implies that $Z \in \Gamma_{\infty}$, and we have shown that $\Omega_{\infty} \subset \Gamma_{\infty}$. Moreover since $\Gamma_{\infty}$ is closed, we conclude that $\bar{\Omega}_{\infty} \subset \Gamma_{\infty}$.

To obtain the converse inclusion we take $X \in \Gamma_{\infty}$. Assume that there is $\epsilon>0$ such that $\overline{B(X, 2 \epsilon)} \subset \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$, in particular $B(X, 2 \epsilon) \cap \partial \Omega_{\infty}=\emptyset$. Since we have already shown that $\partial \Omega_{\infty}$ is the limit of $\partial \Omega_{j}$ 's, for $j$ large enough $B(X, \epsilon) \cap \partial \Omega_{j}=\emptyset$. By the definition of $\Gamma_{\infty}$, there is a sequence $\left\{Y_{j}\right\} \subset \overline{\Omega_{j}}$ with $Y_{j} \rightarrow X$ as $j \rightarrow \infty$. Thus, for all $j$ large enough $B(X, \epsilon)$ is a neighborhood of $Y_{j}$; and in particular $\Omega_{j} \cap B(X, \epsilon) \neq \varnothing$ since $Y_{j} \in \overline{\Omega_{j}}$. On the other hand, since $B(X, \epsilon) \cap \partial \Omega_{j}=\emptyset$ we conclude that $B(X, \epsilon) \subset \Omega_{j}$. At this point we follow a similar argument to the one used to obtain (4.30) replacing $p$ by $X$ and obtain for all $j$ large enough

$$
u_{j}(X) \sim u_{j}\left(A_{j}(0,1)\right) \sim 1,
$$

where the implicit constants depend on the allowable parameters, $|X|$ and $\epsilon$, but are uniform on $j$. Letting $j \rightarrow \infty$ it follows that $u_{\infty}(X)>0$ and hence $X \in \Omega_{\infty}$, contradicting the
assumption that there is $\epsilon>0$ such that $\overline{B(X, 2 \epsilon)} \subset \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$. In sort, we have shown that $\overline{B(X, 2 \epsilon)} \cap \overline{\Omega_{\infty}} \neq \emptyset$ for every $\epsilon>0$, that is, $X \in \overline{\Omega_{\infty}}$. We have eventually proved that $\Gamma_{\infty} \subset \bar{\Omega}_{\infty}$ this completes the proof of (4.27) in the Case I scenario.

Since $\operatorname{diam}\left(\Omega_{j}\right) \rightarrow \infty$ and $0 \in \overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ uniformly on compact set, $\Omega_{\infty}$ is unbounded. Otherwise we would have $\overline{\Omega_{\infty}} \subset B(0, R)$, and for sufficiently large $j$ one would see that $\overline{\Omega_{j}} \subset B(0,2 R)$, which is a contradiction.

On the other hand, it is possible that $\operatorname{diam}\left(\partial \Omega_{j}\right) \nrightarrow \operatorname{diam}\left(\partial \Omega_{\infty}\right)$, hence we do not know whether $\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\infty$. However, under the assumption that the $\partial \Omega_{j}$ 's are Ahlfors regular with uniform constant, we claim that $\partial \Omega_{\infty}$ is also unbounded. Assume not, then there is $R>0$ such that $\partial \Omega_{\infty} \subset B(0, R)$. Let $k$ be a large integer, and notice that $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$ uniformly on the compact set $\overline{B(0, k R)}$. Thus for $j$ sufficiently large (depending on $k$ )

$$
\begin{equation*}
\partial \Omega_{j} \cap \overline{B(0, k R)} \subset B(0,2 R) \tag{4.31}
\end{equation*}
$$

Since $\operatorname{diam}\left(\partial \Omega_{j}\right) \rightarrow \infty$ we can also guarantee that $\operatorname{diam}\left(\partial \Omega_{j}\right)>k R$ for $j$ sufficiently large. Recalling that $0 \in \partial \Omega_{j}$, we can then consider the surface ball $\Delta_{j}(0, k R)=B(0, k R) \cap \partial \Omega_{j}$. By (4.31) and the Ahlfors regularity of $\partial \Omega_{j}$,

$$
\begin{equation*}
C_{A R}^{-1}(k R)^{n-1} \leq \sigma_{j}\left(\Delta_{j}(0, k R)\right) \leq \sigma_{j}\left(B(0,2 R) \cap \partial \Omega_{j}\right) \leq C_{A R}(2 R)^{n-1} \tag{4.32}
\end{equation*}
$$

Letting $k$ large readily leads to a contradiction.

Proof of (3) in Theorem 4.8: Case II. Take $X \in \Omega_{\infty}$, that is, $u_{\infty}(X)>0$. If $X \neq X_{0}$ then $u_{\infty}$ is continuous at $X$ and hence $u_{\infty}(Z)>0$ for every $Z \in B\left(X, r_{x}\right)$ for some $r_{x}$ small enough. On the other hand, if $X=X_{0}$, by Remark 4.22 part (ii) we have that $u_{\infty}(Z)>0$ for all $Z \in B\left(X_{0}, \rho\right)$ with $\rho$ sufficiently small (here we use the convention that $\left.+\infty>0\right)$. Note that this argument show in particular that $B\left(X_{0}, \rho\right) \subset \Omega_{\infty}$.

On the other hand, since $0 \in \partial \Omega_{j}$ for all $j$, by Lemma 2.44 and modulo passing to a subsequence (which we relabel), there exist closed sets $\Gamma_{\infty}, \Lambda_{\infty}$ such that $\overline{\Omega_{j}} \rightarrow \Gamma_{\infty}$ and $\partial \Omega_{j} \rightarrow \Lambda_{\infty}$ as $j \rightarrow \infty$ in the sense of Definition 2.43. We are going to obtain that

$$
\begin{equation*}
\Lambda_{\infty}=\partial \Omega_{\infty} \quad \text { and } \quad \Gamma_{\infty}=\bar{\Omega}_{\infty} \tag{4.33}
\end{equation*}
$$

Let $p \in \Lambda_{\infty}$, there is a sequence $\left\{p_{j}\right\} \subset \partial \Omega_{j}$ such that $p_{j} \rightarrow p$ as $j \rightarrow \infty$. Note that by (4.5)

$$
c_{1} R_{0} \leq \delta_{j}\left(X_{j}\right) \leq\left|X_{j}-p_{j}\right| \leq\left|X_{j}-p\right|+\left|p-p_{j}\right|
$$

Thus, for $j$ large enough, $\left|X_{j}-p\right|>\delta_{j}\left(X_{j}\right) / 2>c_{1} R_{0} / 2$. In particular, $X_{0} \neq p$ and $u_{j}(p) \rightarrow$ $u_{\infty}(p)$ as $j \rightarrow \infty$. On the other hand since the $u_{j}$ 's are uniformly Hölder continuous on compact sets as observed above, $\left|u_{j}(p)\right|=\left|u_{j}(p)-u_{j}\left(p_{j}\right)\right| \leq C\left|p-p_{j}\right|^{\alpha}$, thus $u_{j}(p) \rightarrow 0$ as $j \rightarrow \infty$. Therefore $u_{\infty}(p)=0$, that is, $p \in \mathcal{R}^{n} \backslash \Omega_{\infty}$.

Suppose now that $p \notin \partial \Omega_{\infty}$. Then, there exists $0<\epsilon<\delta_{j}\left(X_{j}\right) / 4$ such that $\overline{B(p, \epsilon)} \subset$ $\mathcal{R}^{n} \backslash \Omega_{\infty}$, or, equivalently, $u_{\infty} \equiv 0$ on $B(p, \epsilon)$. Note that

$$
\left|A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)-A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right)\right| \leq \frac{\epsilon}{2}+\left|p_{j}\right|+\frac{c_{1} R_{0}}{2} \leq C\left(\epsilon,|p|, R_{0}\right) .
$$

Also,

$$
\frac{\epsilon}{2 M} \leq \delta_{j}\left(A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right)<\frac{\epsilon}{2}<\frac{\delta_{j}\left(X_{j}\right)}{2}
$$

and, by (4.5),

$$
\begin{equation*}
\frac{c_{1} R_{0}}{2 M} \leq \delta_{j}\left(A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right)\right)<\frac{c_{1} R_{0}}{2} \leq \frac{\delta_{j}\left(X_{j}\right)}{2} \tag{4.34}
\end{equation*}
$$

Notice that in particular $A_{j}\left(p_{j}, \frac{\epsilon}{2}\right), A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right) \notin \overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right)}$. We can now invoke Lemma 2.41, Harnack's inequality along the constructed chain in $\Omega_{j}$, and (4.23) to see that

$$
\begin{equation*}
u_{j}\left(A_{j}\left(p_{j}, \frac{\epsilon}{2}\right)\right) \sim u_{j}\left(A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right)\right) \gtrsim 1 \tag{4.35}
\end{equation*}
$$

with implicit constant depending on the allowable parameters, $\epsilon,|p|, R_{0}$ but independent of $j$. On the other hand, for all $j$ large enough

$$
\begin{equation*}
A_{j}\left(p_{j}, \frac{\epsilon}{2}\right) \in B\left(p_{j}, \frac{\epsilon}{2}\right) \subset \overline{B(p, \epsilon)} \subset \mathcal{R}^{n} \backslash B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 4\right) \tag{4.36}
\end{equation*}
$$

hence $u_{j} \rightarrow u_{\infty}$ uniformly on $\overline{B(p, \epsilon)}$ with $u_{\infty} \equiv 0$ on $\overline{B(p, \epsilon)}$. This and (4.36) contradict (4.35) and therefore we conclude that $p \in \partial \Omega_{\infty}$, and we have eventually obtained that $\Lambda_{\infty} \subset$ $\partial \Omega_{\infty}$.

To show that $\partial \Omega_{\infty} \subset \Lambda_{\infty}$, we assume that $p \notin \Lambda_{\infty}$. If $p=X_{0}$, then since we observed above that $B\left(X_{0}, \rho\right) \subset \Omega_{\infty}\left(\right.$ see (4.25)) then $X_{0} \notin \partial \Omega_{\infty}$.

Assume next that $p \neq X_{0}$. Since $\Lambda_{\infty}$ is a closed set and since $X_{j} \rightarrow X_{0}$ as $j \rightarrow \infty$, there exists $\epsilon>0$ such that $B(p, 2 \epsilon) \cap \Lambda_{\infty}=\emptyset$ and $X_{0}, X_{j} \notin B(p, 2 \epsilon)$ for all $j$ large enough. Moreover, since $\Lambda_{\infty}$ is the limit of $\partial \Omega_{j}$, by Definition 2.43 we have that for all $j$ large enough $B(p, \epsilon) \cap \partial \Omega_{j}=\emptyset$. Hence, passing to a subsequence (and relabeling) either $B(p, \epsilon) \subset \Omega_{j}$ for $j$ large enough or $B(p, \epsilon) \subset \mathcal{R}^{n} \backslash \overline{\Omega_{j}}$ for $j$ large enough.

Assume first that $B(p, \epsilon) \subset \Omega_{j}$ for all $j$ large enough. We consider two subcases. Assume first that $p \notin \overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right.}$. Then, proceeding as before, by (4.34) we can apply Lemma 2.41 and Harnack's inequality along the constructed chain in $\Omega_{j}$ to get

$$
\begin{equation*}
u_{j}(p) \sim u_{j}\left(A_{j}\left(0, \frac{c_{1} R_{0}}{2}\right)\right) \gtrsim 1 \tag{4.37}
\end{equation*}
$$

with implicit constant depending on the allowable parameters, $\epsilon,|p|, R_{0}$ but independent of $j$. Suppose next that $p \in \overline{B\left(X_{j}, \delta_{j}\left(X_{j}\right) / 2\right)}$. In that case we can use (4.7), (2.21), and (4.5) to see that for all $j$ large enough

$$
\begin{equation*}
u_{j}(p) \gtrsim\left|p-X_{j}\right|^{2-n} \gtrsim \delta_{j}\left(X_{j}\right)^{2-n} \gtrsim\left(c_{2} R_{0}\right)^{2-n} \tag{4.38}
\end{equation*}
$$

with implicit constants which are uniform on $j$. Combining the two cases together we have shown that $u_{j}(p) \gtrsim 1$ uniformly on $j$. Letting $j \rightarrow \infty$ we conclude that $u_{\infty}(p) \gtrsim 1$ and hence $p \in \Omega_{\infty}$, and since we have already shown that $\Omega_{\infty}$ is an open set we conclude that $p \notin \partial \Omega_{\infty}$

We now tackle the second case on which $B(p, \epsilon) \subset \mathcal{R}^{n} \backslash \overline{\Omega_{j}}$ for all $j$ large enough. In this scenario $u_{j}(X)=0$ for all $X \in B(p, \epsilon)$. Since $X_{0} \notin B(p, 2 \epsilon)$, by uniform convergence of $u_{j}$
in $\overline{B(p, \epsilon / 2)}$ we have that $u_{\infty}(X)=0$ for $X \in B(p, \epsilon / 2)$, which implies $B(p, \epsilon / 2) \subset \mathcal{R}^{n} \backslash \Omega_{\infty}$ and eventually $p \notin \partial \Omega_{\infty}$.

In both cases we have shown that if $p \notin \Lambda_{\infty}$ then $p \notin \partial \Omega_{\infty}$, or, equivalently, $\partial \Omega_{\infty} \subset \Lambda_{\infty}$. This together with the converse inclusion completes the proof of $\Lambda_{\infty}=\partial \Omega_{\infty}$.

Our next task is to show that $\Gamma_{\infty}=\bar{\Omega}_{\infty}$. Let $Z \in \Omega_{\infty}$ and assume first that $Z=X_{0}$. By (4.15) and since $X_{j} \rightarrow X_{0}$ as $j \rightarrow \infty$ we have that $X_{0} \in B\left(X_{j}, 2 \rho\right) \subset \Omega_{j}$ for all $j$ large enough, thus $Z=X_{0} \in \Gamma_{\infty}$. On the other hand, if $Z \neq X_{0}$ since $u_{\infty}(Z)>0$ we have that $u_{j}(Z)>0$ for all $j$ large enough. This forces as well that $Z \in \Omega_{j}$ for $j$ all large enough and again $Z \in \Gamma_{\infty}$. With this we have shown that $\Omega_{\infty} \subset \Gamma_{\infty}$. Moreover, since $\Gamma_{\infty}$ is closed we conclude as well that $\bar{\Omega}_{\infty} \subset \Gamma_{\infty}$.

Next we look at the converse inclusion and take $X \in \Gamma_{\infty}$. Assume that $X \in \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$. Thus, there is $\epsilon>0$ such that $\overline{B(X, 2 \epsilon)} \subset \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$. In particular $B(X, 2 \epsilon) \cap \partial \Omega_{\infty}=\emptyset$ and $B\left(X_{0}, \rho\right) \cap B(X, 2 \epsilon)=\emptyset$ (recall that we showed that $\left.B\left(X_{0}, \rho\right) \subset \Omega_{\infty}\right)$. Since we have already shown that $\partial \Omega_{\infty}$ is the limit of $\partial \Omega_{j}$ 's, for $j$ large enough $B(X, \epsilon) \cap \partial \Omega_{j}=\emptyset$. By the definition of $\Gamma_{\infty}$, there is a sequence $\left\{Y_{j}\right\} \subset \overline{\Omega_{j}}$ so that $Y_{j} \rightarrow X$ as $j \rightarrow \infty$. Thus, for all $j$ large enough $B(X, \epsilon)$ is a neighborhood of $Y_{j}$, and, in particular, $\Omega_{j} \cap B(X, \epsilon) \neq \emptyset$ since $Y_{j} \in \overline{\Omega_{j}}$. Besides, since $B(X, \epsilon) \cap \partial \Omega_{j}=\emptyset$ we conclude that $B(X, \epsilon) \subset \Omega_{j}$. Using a similar argument to the one used to obtain (4.37) and (4.38) we have (replacing $p$ by $X$ ) that

$$
u_{j}(X) \gtrsim 1
$$

independently of $j$ and with constants that depend on the allowable parameters, $\epsilon,|X|, R_{0}$. Since $u_{j}(X) \rightarrow u_{\infty}(X)$ we conclude that $u_{\infty}(X)>0$ and thus $X \in \Omega_{\infty}$, contradicting the assumption that $X \in \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}$. Eventually, $X \in \bar{\Omega}_{\infty}$ and we have obtained that $\Gamma_{\infty} \subset \bar{\Omega}_{\infty}$.

Since $\operatorname{diam}\left(\Omega_{j}\right) \rightarrow R_{0}$ is finite and $0 \in \partial \Omega_{j}$, we have $\Omega_{j}, \Omega_{\infty} \subset \overline{B\left(0,2 R_{0}\right)}$ for $j$ sufficiently large. Hence $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ uniformly, and thus $\operatorname{diam}\left(\Omega_{\infty}\right)=\lim _{j \rightarrow \infty} \operatorname{diam}\left(\Omega_{j}\right)=R_{0} \geq 1$.

For later use let us remark that in the Case II scenario the fact that $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ and $\partial \Omega_{j} \rightarrow$ $\partial \Omega_{\infty}$ as $j \rightarrow \infty$ in the sense of Definition 2.43 yields

$$
\begin{align*}
\operatorname{diam}\left(\Omega_{\infty}\right)= & \operatorname{diam}\left(\overline{\Omega_{\infty}}\right)=\lim _{j \rightarrow \infty} \operatorname{diam}\left(\overline{\Omega_{j}}\right)=\lim _{j \rightarrow \infty} \operatorname{diam}\left(\Omega_{j}\right)=R_{0}  \tag{4.39}\\
& \operatorname{diam}\left(\partial \Omega_{\infty}\right)=\lim _{j \rightarrow \infty} \operatorname{diam}\left(\partial \Omega_{j}\right)=R_{0} \tag{4.40}
\end{align*}
$$

Proof of (4) in Theorem 4.8. Notice that $\Omega_{\infty} \neq \emptyset$ since $0 \in \partial \Omega_{\infty}$. Next we show that $\Omega$ satisfies the interior corkscrew and the Harnack chain. Let us sketch the argument. For the interior corkscrew condition, fixed $p \in \partial \Omega_{\infty}$ and $0<r<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$, we take a sequence $p_{j} \in \partial \Omega_{j}$ so that $p_{j} \rightarrow p$ and for each $j$ we let $A_{j}$ be an interior corkscrew relative to $B\left(p_{j}, r / 2\right) \cap \partial \Omega_{j}$ in $\Omega_{j}$. All the $A_{j}$ 's are contained in $B(p, 3 r / 4)$, hence, passing to a subsequence, they converge to some point $A$. Using that the interior corkscrew condition holds for all $\Omega_{j}$ with the same constant $M$, it follows that each $A_{j}$ is uniformly away from $\partial \Omega_{j}$ and so will be $A$ from $\partial \Omega_{\infty}$ since $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$. I turn, this means that $A$ is an interior corkscrew relative to $B(p, r) \cap \partial \Omega_{\infty}$ in $\Omega_{\infty}$. Regarding the Harnack chain condition we proceed in a similar fashion. Fixed $X, Y \in \Omega_{\infty}$ for some fixed $j$ large enough we will have that $X, Y \in \Omega_{j}$
with $\delta_{j}(X) \approx \delta_{\infty}(X)$ and $\delta_{j}(Y) \approx \delta_{\infty}(Y)$. We can then construct a Harnack chain to join $X$ and $Y$ within $\Omega_{j}$ (whose implicit constants are independent of $j$ ). Again, since each ball in the constructed Harnack chain is uniformly away from $\partial \Omega_{j}$, it will also be uniformly away from $\partial \Omega_{\infty}$ allowing us to conclude that this chain of balls is indeed a Harnack chain within $\Omega_{\infty}$.
Interior corkscrew condition. Recall that each $\Omega_{j}$ is a uniform domain with constants $M, C_{1}>1$. Hence, for all $q \in \partial \Omega_{j}$ and $r \in\left(0, \operatorname{diam}\left(\partial \Omega_{j}\right)\right)$ there is a point $A_{j}(q, r) \in \Omega_{j}$ such that

$$
\begin{equation*}
B\left(A_{j}(q, r), \frac{r}{M}\right) \subset B(q, r) \cap \Omega_{j} . \tag{4.41}
\end{equation*}
$$

Let $p \in \partial \Omega_{\infty}$ and $0<r<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$. In Case III, by (4.40) we get that $r<\operatorname{diam}\left(\partial \Omega_{j}\right)$ for all $j$ sufficiently large. In Case I, either $\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\infty$ or $\operatorname{diam}\left(\partial \Omega_{\infty}\right)<\infty$, but we still have $r<\operatorname{diam}\left(\partial \Omega_{j}\right)$ for all $j$ sufficiently large (note that in the latter case diam $\left(\partial \Omega_{j}\right) \nrightarrow$ $\operatorname{diam}\left(\partial \Omega_{\infty}\right)$ ). Since $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$, we can find $p_{j} \in \partial \Omega_{j}$ converging to $p$. For each $j$ there exists $A_{j}\left(p_{j}, r / 2\right)$ such that

$$
\begin{equation*}
B\left(A_{j}\left(p_{j}, \frac{r}{2}\right), \frac{r}{2 M}\right) \subset B\left(p_{j}, \frac{r}{2}\right) \cap \Omega_{j} . \tag{4.42}
\end{equation*}
$$

In particular we deduce that (4.43)

$$
B\left(A_{j}\left(p_{j}, \frac{r}{2}\right), \frac{r}{3 M}\right) \subset \Omega_{j} \quad \text { and } \quad \operatorname{dist}\left(B\left(A_{j}\left(p_{j}, \frac{r}{2}\right), \frac{r}{2 M}\right), \partial \Omega_{j}\right) \geq \frac{r}{6 M} .
$$

Note that for $j$ large enough

$$
\begin{equation*}
A_{j}\left(p_{j}, \frac{r}{2}\right) \in B\left(p_{j}, \frac{r}{2}\right) \subset \overline{B\left(p, \frac{3 r}{4}\right)} . \tag{4.44}
\end{equation*}
$$

Modulo passing to a subsequence (which we relabel) $A_{j}\left(p_{j}, r / 2\right)$ converges to some point, which we denote by $A(p, r)$, and for all $j$ sufficiently large (depending on $r$ )

$$
\begin{equation*}
B\left(A(p, r), \frac{r}{4 M}\right) \subset B\left(A_{j}\left(p_{j}, \frac{r}{2}\right), \frac{r}{3 M}\right) \subset B(p, r) \cap \Omega_{j} . \tag{4.45}
\end{equation*}
$$

The fact that $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$, the first inclusion in (4.45), and (4.43) give for all $j$ large enough

$$
\begin{equation*}
B\left(A(p, r), \frac{r}{4 M}\right) \subset \overline{\Omega_{\infty}} \quad \text { and } \quad \operatorname{dist}\left(B\left(A(p, r), \frac{r}{4 M}\right), \partial \Omega_{j}\right) \geq \frac{r}{6 M} . \tag{4.46}
\end{equation*}
$$

This and the fact that $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$ yield that $\operatorname{dist}\left(B(A(p, r), r / 4 M), \partial \Omega_{\infty}\right) \geq r / 6 M$, hence $B(A(p, r), r / 4 M)$ misses $\partial \Omega_{\infty}$. Combining this with (4.46) and the second inclusion in (4.45), we conclude that

$$
\begin{equation*}
B\left(A(p, r), \frac{r}{4 M}\right) \subset \Omega_{\infty} \cap B(p, r) . \tag{4.47}
\end{equation*}
$$

Hence, $\Omega_{\infty}$ satisfies the interior corkscrew condition with constant $4 M$.
Harnack chain condition. Fix $X, Y \in \Omega_{\infty}$ and pick $q_{X}, q_{Y} \in \partial \Omega_{\infty}$ such that $\left|X-q_{X}\right|=$ $\delta_{\infty}(X),\left|Y-q_{Y}\right|=\delta_{\infty}(Y)$. Without loss of generality we may assume that $\delta(X) \geq \delta(Y)$
(otherwise we switch the roles of $X$ and $Y$ ). Let us recall that every $\Omega_{j}$ satisfies the Harnack chain condition with constants $M, C_{1}>1$. Set

$$
\begin{equation*}
\Theta:=M\left(2+\log _{2}^{+}\left(\frac{|X-Y|}{\min \left\{\delta_{\infty}(X), \delta_{\infty}(Y)\right\}}\right)\right)=M\left(2+\log _{2}^{+}\left(\frac{|X-Y|}{\delta_{\infty}(Y)}\right)\right) . \tag{4.48}
\end{equation*}
$$

Choose $R \geq$ large enough (depending on $X, Y$ ) so that

$$
\begin{equation*}
B\left(q_{X}, \delta_{\infty}(X) / 2\right), B\left(X,\left(2 C_{1}^{2}\right)^{4 \Theta} \delta_{\infty}(X)\right) \subset B(0, R) \tag{4.49}
\end{equation*}
$$

and

$$
\begin{equation*}
B\left(q_{Y}, \delta_{\infty}(Y) / 2\right), B\left(Y,\left(2 C_{1}^{2}\right)^{4 \Theta} \delta_{\infty}(Y)\right) \subset B(0, R) \tag{4.50}
\end{equation*}
$$

Take also $d=2^{-1} C_{1}^{-2 \Theta} \leq 1$ which also depends on $X, Y$. Then, by (3) in Theorem 4.8 we can take $j$ large enough (depending on $R$ and $d$ ) so that

$$
\begin{equation*}
D\left[\partial \Omega_{j} \cap \overline{B(0, R)}, \partial \Omega_{\infty} \cap \overline{B(0, R)}\right], D\left[\overline{\Omega_{j}} \cap \overline{B(0, R)}, \overline{\Omega_{\infty}} \cap \overline{B(0, R)}\right] \leq \frac{d}{2} \delta_{\infty}(Y) \leq \frac{d}{2} \delta_{\infty}(X), \tag{4.51}
\end{equation*}
$$

By (4.51), (4.49), and (4.50) we have that $X, Y \in \Omega_{j}$, and

$$
\begin{equation*}
\frac{\delta_{\infty}(X)}{2} \leq \delta_{j}(X) \leq \frac{3 \delta_{\infty}(X)}{2} \quad \text { and } \quad \frac{\delta_{\infty}(Y)}{2} \leq \delta_{j}(Y) \leq \frac{3 \delta_{\infty}(Y)}{2} . \tag{4.52}
\end{equation*}
$$

Since $\Omega_{j}$ satisfies the Harnack chain condition with constants $M, C_{1}>1$, there exists a collection of balls $B_{1}, \ldots, B_{K}$ (the choice of balls depend on the fixed $j$ ) connecting $X$ to $Y$ in $\Omega_{j}$ and such that

\begin{equation*}
C_{1}^{-1} \operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right) \leq \operatorname{diam}\left(B_{k}\right) \leq C_{1} \operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right), \tag{4.53}
\end{equation*}
$$

for $k=1,2, \ldots, K$ where

$$
\begin{equation*}
K \leq M\left(2+\log _{2}^{+}\left(\frac{|X-Y|}{\min \left\{\delta_{j}(X), \delta_{j}(Y)\right\}}\right)\right) \leq 2 \Theta . \tag{4.54}
\end{equation*}
$$

Combining (4.53) and (4.54), one can see that for every $k=1,2, \ldots, K$

$$
\begin{equation*}
\operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right) \geq d \delta_{\infty}(X), \quad \operatorname{diam}\left(B_{k}\right) \leq\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(Y) \tag{4.55}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{dist}\left(X, B_{k}\right) \leq 2\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(X), \quad \operatorname{dist}\left(Y, B_{k}\right) \leq 2\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(Y) \tag{4.56}
\end{equation*}
$$

Given an arbitrary $q_{j} \in \partial \Omega_{j} \backslash \overline{B(0, R)}$, by (4.49), (4.55), and (4.56) it follows that

$$
\begin{align*}
\left(2 C_{1}^{2}\right)^{4 \Theta} \delta_{\infty}(X) \leq\left|q_{j}-X\right| \leq \operatorname{dist}\left(q_{j}, B_{k}\right)+\operatorname{diam}( & \left.B_{k}\right)  \tag{4.57}\\
& +\operatorname{dist}\left(X, B_{k}\right) \\
& \leq \operatorname{dist}\left(q_{j}, B_{k}\right)+3\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(X) .
\end{align*}
$$

Hiding the last term, using that $\Theta>2$ and taking the infimum over the $q_{j}$ as above we conclude that

$$
\begin{equation*}
4 C_{1}\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(X)<\operatorname{dist}\left(B_{k}, \partial \Omega_{j} \backslash \overline{B(0, R)}\right) . \tag{4.58}
\end{equation*}
$$

On the other hand, by (4.53) and (4.55)

$$
\operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right) \leq C_{1} \operatorname{diam}\left(B_{k}\right) \leq C_{1}\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(Y) \leq C_{1}\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(X),
$$

which eventually leads to $\operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right)=\operatorname{dist}\left(B_{k}, \partial \Omega_{j} \cap \overline{B(0, R)}\right)$. Analogously, replacing $q_{j}$ by $q \in \partial \Omega_{\infty} \backslash \overline{B(0, R)}$ in (4.57) we can easily obtain that (4.58) also holds for $\Omega_{\infty}$ :

4 C_{1}\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(X)<\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty} \backslash \overline{B(0, R)}\right) \tag{4.59}

But, (4.56) yields

\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right) \leq \delta_{\infty}(X)+\operatorname{dist}\left(X, B_{k}\right) \leq \delta_{\infty}(X)+2\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(Y) \leq 3\left(2 C_{1}^{2}\right)^{2 \Theta} \delta_{\infty}(Y),
$$

which eventually leads to $\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right)=\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty} \cap \overline{B(0, R)}\right)$. Using all these, (4.51), the triangular inequality and (4.51) we can obtain

&\left|\operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right)-\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right)\right|=\left|\operatorname{dist}\left(B_{k}, \partial \Omega_{j} \cap \overline{B(0, R)}\right)-\operatorname{dist}\left(B_{k}, \partial \Omega_{\infty} \cap \overline{B(0, R)}\right)\right| \\
& \leq D\left[\partial \Omega_{j} \cap \overline{B(0, R)}, \partial \Omega_{\infty} \cap \overline{B(0, R)}\right] \leq \frac{d}{2} \delta_{\infty}(X) \leq \frac{1}{2} \operatorname{dist}\left(B_{k}, \Omega_{j}\right) .
\end{aligned}
$$

Thus,

$$
\begin{equation*}
\frac{2}{3} \operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right) \leq \operatorname{dist}\left(B_{k}, \partial \Omega_{j}\right) \leq 2 \operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right) . \tag{4.60}
\end{equation*}
$$

and moreover $B_{k} \cap \partial \Omega_{\infty}=\emptyset$. Note that the latter happens for all $k=1, \ldots, K$. Recall also that $X \in B_{1} \cap \Omega_{\infty}$ and that $B_{k} \cap B_{k+1} \neq \emptyset$. Consequently, we necessarily have that $B_{k} \subset \Omega_{\infty}$ for all $k=1, \ldots, K$. Furthermore, (4.60) and (4.53) give

\frac{2}{3} C_{1}^{-1} \operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right) \leq \operatorname{diam}\left(B_{k}\right) \leq 2 C_{1} \operatorname{dist}\left(B_{k}, \partial \Omega_{\infty}\right) \tag{4.61}
\end{equation*}
$$

To summarize, we have found a chain of balls $B_{1}, \ldots, B_{K}$, all contained in $\Omega_{\infty}$, which verify (4.61), and connect $X$ to $Y$. Also, $K$ satisfies (4.54) with $\Theta$ given in (4.48). Therefore $\Omega_{\infty}$ satisfies the Harnack chain condition with constants $2 M$ and $2 C_{1}$. This completes the proof of (4) in Theorem 4.8.

Proof of (5) in Theorem 4.8. We first recall that for every $j, \sigma_{j}=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{j}}$ is an Ahlfors regular measure with constant $C_{A R}$ and hence spt $\sigma_{j}=\partial \Omega_{j}$. In particular the sequence $\left\{\sigma_{j}\right\}$ satisfies conditions (i) and (ii) of Lemma 2.47.

On the other hand, the fact that $\partial \Omega_{j}$ is Ahlfors regular easily yields, via a standard covering argument, that $\mathcal{H}^{n-1}\left(\partial \Omega_{j}\right) \leq 2^{n-1} C_{A R} \operatorname{diam}\left(\Omega_{j}\right)^{n}$. Hence, using again that $\partial \Omega_{j}$ is Ahlfors regular we conclude that for every $R>0$

$$
\sup _{j} \sigma_{j}(B(0, R))=\sup _{j} \mathcal{H}^{n-1}\left(\partial \Omega_{j} \cap B(0, R)\right) \leq 2^{n-1} C_{A R} R^{n-1} .
$$

Therefore modulo passing to a subsequence (which we relabel), there exists a Radon measure $\mu_{\infty}$ such that $\sigma_{j} \rightarrow \mu_{\infty}$ as $j \rightarrow \infty$. Using Lemma 2.47, $\partial \Omega_{j}=\operatorname{spt} \sigma_{j} \rightarrow \operatorname{spt} \mu_{\infty}$ as $j \rightarrow \infty$ in the sense of Definition 2.43. This and (3) in Theorem 4.8 lead to spt $\mu_{\infty}=\partial \Omega_{\infty}$.

To show that $\mu_{\infty}$ is Ahlfors regular take $q \in \partial \Omega_{\infty}$. Let $q_{j} \in \partial \Omega_{j}$ be such that $q_{j} \rightarrow q$ as $j \rightarrow \infty$. For any $r>0$, using [Mat, Theorem 1.24] and that $\sigma_{j}$ is Ahlfors regular with constant $C_{A R}$ we conclude that

$$
\begin{equation*}
\mu_{\infty}(B(q, r)) \leq \liminf _{j \rightarrow \infty} \sigma_{j}(B(q, r)) \leq \liminf _{j \rightarrow \infty} \sigma_{j}\left(B\left(q_{j}, 2 r\right)\right) \leq 2^{n-1} C_{A R} r^{n-1} . \tag{4.62}
\end{equation*}
$$

On the other hand, let $0<r<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$. In Case II, by (4.40) we get that $r<\operatorname{diam}\left(\partial \Omega_{j}\right)$ for all $j$ sufficiently large. In Case I, either $\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\infty$ or $\operatorname{diam}\left(\partial \Omega_{\infty}\right)<\infty$, but we still have $r<\operatorname{diam}\left(\partial \Omega_{j}\right)$ for all $j$ sufficiently large. Hence, using again [Mat, Theorem 1.24] and that $\sigma_{j}$ is Ahlfors regular with constant $C_{A R}$ we obtain

\begin{align*}
\mu_{\infty}(B(q, r)) \geq \mu_{\infty}\left(\overline{B\left(q, \frac{r}{2}\right)}\right) \geq & \geq \limsup _{j \rightarrow \infty} \sigma_{j}\left(\overline{B\left(q, \frac{r}{2}\right)}\right)  \tag{4.63}\\
& \geq \limsup _{j \rightarrow \infty} \sigma_{j}\left(B\left(q_{j}, \frac{r}{4}\right)\right) \geq 4^{-(n-1)} C_{R}^{-1} r^{n-1} .
\end{align*}
$$

These estimates guarantee that $\mu_{\infty}$ is Ahlfors regular with constant $2^{2(n-1)} C_{A R}$. Moreover by [Mat, Theorem 6.9],

$$
\begin{equation*}
2^{-2(n-1)} C_{A R}^{-1} \mu_{\infty} \leq\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{\infty}} \leq 2^{3(n-1)} C_{A R} \mu_{\infty} . \tag{4.64}
\end{equation*}
$$

and consequently $\partial \Omega_{\infty}$ is Ahlfors regular with constant $2^{5(n-1)} C_{A R}^{2}$. This completes the proof of (5) and hence that of Theorem 4.8.
4.2. Convergence of elliptic matrices. Our next goal is to show that there exists a constant coefficient real symmetric elliptic matrix $\mathcal{A}^{*}$ with ellipticity constants $1=\lambda \leq \Lambda<\infty$ (as in (1.5)) so that for any $0<R<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$ and for any $1 \leq p<\infty$.

$$
\begin{equation*}
\int_{B(0, R) \cap \Omega_{j}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z \rightarrow 0, \quad \text { as } j \rightarrow \infty \tag{4.65}
\end{equation*}
$$

Fix $Z_{0} \in \Omega_{\infty}$ and set $B_{0}=B\left(Z_{0}, 3 \delta_{\infty}\left(Z_{0}\right) / 8\right)$. Since $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$ and $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ as $j \rightarrow \infty$, for all sufficiently large $j$, we can see that $Z_{0} \in \Omega_{j}$,

$$
\begin{equation*}
\frac{3}{4} \delta_{\infty}\left(Z_{0}\right) \leq \delta_{j}\left(Z_{0}\right) \leq \frac{5}{4} \delta_{\infty}\left(Z_{0}\right), \tag{4.66}
\end{equation*}
$$

and

$$
\begin{equation*}
B_{0} \subset B\left(Z_{0}, \frac{\delta_{j}\left(Z_{0}\right)}{2}\right) \subset \frac{5}{3} B_{0} \subset \Omega_{j} \quad \text { for all } j . \tag{4.67}
\end{equation*}
$$

All these, an the oscillation assumption (1.9), yield

$$
\begin{align*}
& f_{B_{0}}\left|\mathcal{A}_{j}(Z)-\left\langle\mathcal{A}_{j}\right\rangle_{B_{0}}\right| d Z \lesssim f_{B\left(Z_{0}, \delta_{j}\left(Z_{0}\right) / 2\right)}\left|\mathcal{A}_{j}(Z)-\left\langle\mathcal{A}_{j}\right\rangle_{B\left(Z_{0}, \delta_{j}\left(Z_{0}\right) / 2\right)}\right| d Z  \tag{4.68}\\
& \leq \operatorname{osc}\left(\Omega_{j}, \mathcal{A}_{j}\right)<\epsilon_{j} .
\end{align*}
$$

Note that all the matrices $\mathcal{A}_{j}$ are uniformly elliptic (i.e., all of them satisfy (1.5)), with the same constants $1=\lambda \leq \Lambda<\infty$, and in particular $\left\{\left\langle\mathcal{A}_{j}\right\rangle_{B_{0}}\right\}_{j}$ is a bounded sequence of constant real matrices. Hence, passing to a subsequence and relabeling $\left\langle\mathcal{A}_{j}\right\rangle_{B_{0}}$ converges to some constant elliptic matrix, denoted by $\mathcal{A}^{*}\left(B_{0}\right)$. Combining this with (4.68), the dominated convergence theorem yields

$$
\begin{equation*}
f_{B_{0}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\left(B_{0}\right)\right| d Z \rightarrow 0 \quad \text { as } j \rightarrow \infty, \tag{4.69}
\end{equation*}
$$

that is, $\mathcal{A}_{j}$ converges in $L^{1}\left(B_{0}\right)$ to a constant elliptic matrix $\mathcal{A}^{*}\left(B_{0}\right)$. Moreover, passing to a further subsequence an relabeling $\mathcal{A}_{j} \rightarrow \mathcal{A}^{*}\left(B_{0}\right)$ almost everywhere in $B_{0}$. In particular, $\mathcal{A}^{*}\left(B_{0}\right)$ is a real symmetric elliptic matrix (i.e., it satisfies (1.5)), with ellipticity constants $1=\lambda \leq \Lambda<\infty$. It is important to highlight that all the previous subsequences and relabeling only depends on the choice of $Z_{0} \in \Omega_{\infty}$. In any case, since $\mathcal{A}^{*}\left(B_{0}\right)$ is a constant coefficient matrix we set $\mathcal{A}^{*}:=\mathcal{A}^{*}\left(B_{0}\right)$.

Let us pick a countable collection of points $\left\{Z_{k}\right\} \subset \Omega_{\infty}$ so that $\Omega_{\infty}=\cup_{k} B_{k}$ with $B_{k}=$ $B\left(Z_{k}, 3 \delta_{\infty}\left(Z_{k}\right) / 8\right)$. We can repeat the previous argument with any $Z_{k}$ and define $\mathcal{A}^{*}\left(B_{k}\right)$, a constant real symmetric elliptic matrix satisfying (1.5) so that for some subsequence depending on $k$, we obtain that $\mathcal{A}_{j} \rightarrow \mathcal{A}^{*}\left(B_{k}\right)$ in $L^{1}\left(B_{k}\right)$ and a.e in $B_{k}$ as $j \rightarrow \infty$. In particular, $\mathcal{A}^{*}\left(B_{k_{1}}\right)=\mathcal{A}^{*}\left(B_{k_{2}}\right)$ a.e. in $B_{k_{1}} \cap B_{k_{2}}$ (in case it is non-empty). Note that $\Omega_{\infty}$ is path connected (since it satisfies the Harnack chain condition), hence for any $k$ we can find a path joining $Z_{k}$ and $Z_{0}$ and cover this path with a finite collection of the previous balls to easily see that $\mathcal{A}^{*}\left(B_{k}\right)=\mathcal{A}^{*}=\mathcal{A}^{*}\left(B_{0}\right)$. Moreover, using a diagonalization argument, we can show that there exists a subsequence, which we relabel, so that for all $k$, we have that $\mathcal{A}_{j} \rightarrow \mathcal{A}^{*}$ in $L^{1}\left(B_{k}\right)$ and a.e in $B_{k}$ as $j \rightarrow \infty$. From this, and since the matrices concerned are all uniformly bounded, one can prove that for any $1 \leq p<\infty$ and for all $Z \in \Omega_{\infty}$

$$
\begin{equation*}
f_{B_{Z}}\left|\mathcal{A}_{j}(Y)-\mathcal{A}^{*}\right|^{p} d Y \rightarrow 0 \quad \text { as } j \rightarrow \infty, \tag{4.70}
\end{equation*}
$$

where $B_{Z}=B(Z, \delta(Z) / 2)$.
We are now ready to start proving our claim (4.65). Recalling that $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}, \partial \Omega_{j} \rightarrow$ $\partial \Omega_{\infty}$ in the sense of Definition 2.43, and that $\partial \Omega_{j}, \partial \Omega_{\infty}$ have zero Lebesgue measure since they are Ahlfors regular sets, one can see that

$$
\begin{equation*}
B(0, R) \cap\left(\Omega_{j} \Delta \Omega_{\infty}\right) \subset B(0, R) \cap\left(\left(\overline{\Omega_{j}} \Delta \overline{\Omega_{\infty}}\right) \cup\left(\overline{\Omega_{j}} \cap \partial \Omega_{\infty}\right) \cup\left(\overline{\Omega_{\infty}} \cap \partial \Omega_{j}\right)\right) \tag{4.71}
\end{equation*}
$$

and hence the Lebesgue measure of the set on the left hand side tends to zero as $j \rightarrow \infty$. This and the fact that $\left\|\mathcal{A}_{j}\right\|_{\infty},\left\|\mathcal{A}^{*}\right\|_{\infty} \leq \Lambda$ give

$$
\begin{equation*}
\int_{B(0, R) \cap\left(\Omega_{j} \Delta \Omega_{\infty}\right)}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z \rightarrow 0, \quad \text { as } j \rightarrow \infty . \tag{4.72}
\end{equation*}
$$

On the other hand, let $\varrho>0$ be arbitrarily small and let $\epsilon=\epsilon(\varrho)>0$ be a small constant to be determined later. Set

$$
\Omega_{\infty}^{\epsilon, 1}:=B(0, R) \cap\left\{Z \in \Omega_{\infty}: \delta_{\infty}(Z)<\epsilon\right\} \quad \text { and } \quad \Omega_{\infty}^{\epsilon, 2}:=B(0, R) \cap\left\{Z \in \Omega_{\infty}: \delta_{\infty}(Z) \geq \epsilon\right\} .
$$

Using the notation $\Delta(q, r):=B(q, r) \cap \partial \Omega_{\infty}$ with $q \in \partial \Omega_{\infty}$ and $r>0$, Vitali's covering lemma allows us to find a finite collection of balls $B\left(q_{i}, \epsilon\right)$ with $q_{i} \in \Delta(0, R+\epsilon)$, such that

\begin{equation*}
\Omega_{\infty}^{\epsilon, 1} \subset \bigcup_{i} B\left(q_{i}, 5 \epsilon\right) \tag{4.73}
\end{equation*}
$$

Calling the number of balls $L_{1}$ we get the following estimate

$$
\begin{equation*}
L_{1} \epsilon^{n-1} \lesssim \sum_{i} \sigma_{\infty}\left(\Delta\left(q_{i}, \epsilon\right)\right)=\sigma_{\infty}\left(\bigcup_{i} \Delta\left(q_{i}, \epsilon\right)\right) \leq \sigma_{\infty}(\Delta(0, R+2 \epsilon)) \lesssim(R+2 \epsilon)^{n-1} \tag{4.74}
\end{equation*}
$$

where we have used that $\partial \Omega_{\infty}$ is Ahlfors regular and also that $\Delta\left(q_{i}, \epsilon\right) \subset \Delta(0, R+2 \epsilon)$ since $q_{i} \in \Delta(0, R+\epsilon)$. If we assume that $0<\epsilon<R$ we conclude that $L_{1} \lesssim(R / \epsilon)^{n-1}$ and moreover by (4.73) we conclude that $\left|\Omega_{\infty}^{\epsilon, 1}\right| \lesssim \epsilon$ (here the implicit constant depend on $R$ ). This and $\left\|\mathcal{A}_{j}\right\|_{\infty},\left\|\mathcal{A}^{*}\right\|_{\infty} \leq \Lambda$ give at once that for every $j$

$$
\begin{equation*}
\int_{\Omega_{\infty}^{\epsilon \cdot 1} \cap \Omega_{j}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z \lesssim \Lambda^{p} \epsilon<\frac{\varrho}{2}, \tag{4.75}
\end{equation*}
$$

provided $\epsilon$ is taken small enough which is fixed from now on.
On the other hand, note that $\overline{\Omega_{\infty}^{\epsilon, 2}}$ is compact, hence we can find $Z_{1}, \ldots, Z_{L_{2}} \in \overline{\Omega_{\infty}^{\epsilon, 2}}$ so that $\Omega_{\infty}^{\epsilon, 2} \subset \bigcup_{i=1}^{L_{2}} B_{Z_{i}}$ where $L_{2}$ depends on $\epsilon$ and $R$ which have been fixed already. Hence, by (4.70)

\int_{\Omega_{\infty}^{\epsilon_{\infty}^{2}} \cap \Omega_{j}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z \leq \sum_{i=1}^{L_{2}} \int_{B_{Z_{i}}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z \rightarrow 0, \quad \text { as } j \rightarrow \infty .
$$

In particular, we can find an integer $j_{0}=j_{0}(R, \epsilon)$ such that

\begin{equation*}
\int_{\Omega_{\infty}^{\epsilon_{\infty}^{2} \cap \Omega_{j}}}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z<\frac{\varrho}{2}, \quad \text { for any } j \geq j_{0} \tag{4.76}
\end{equation*}
$$

Combining (4.75) and (4.76), we conclude that

$$
\begin{equation*}
\int_{B(0, R) \cap\left(\Omega_{j} \cap \Omega_{\infty}\right)}\left|\mathcal{A}_{j}(Z)-\mathcal{A}^{*}\right|^{p} d Z<\varrho, \quad \text { for any } j \geq j_{0} \tag{4.77}
\end{equation*}
$$

This combined with (4.72) proves the claim (4.65).

### 4.3. Convergence of operator.

Theorem 4.78. The function $u_{\infty}$ solves the Dirichlet problem

$$
\left\{\begin{align*}
-\operatorname{div}\left(\mathcal{A}^{*} \nabla u_{\infty}\right)=0 & \text { in } \Omega_{\infty},  \tag{4.79}\\
u_{\infty}>0 & \text { in } \Omega_{\infty}, \\
u_{\infty}=0 & \text { on } \partial \Omega_{\infty},
\end{align*}\right.
$$

in Case I, and solves the Dirichlet problem

$$
\left\{\begin{align*}
-\operatorname{div}\left(\mathcal{A}^{*} \nabla u_{\infty}\right)=\delta_{\left\{X_{0}\right\}} & \text { in } \Omega_{\infty},  \tag{4.80}\\
u_{\infty}>0 & \text { in } \Omega_{\infty}, \\
u_{\infty}=0 & \text { on } \partial \Omega_{\infty},
\end{align*}\right.
$$

in Case II. Hence, $u_{\infty}$ is a Green function in $\Omega_{\infty}$ for a constant-coefficient elliptic operator $L_{\infty}=-\operatorname{div}\left(\mathcal{H}^{*} \nabla\right)$ with pole at $\infty$ in Case I or at $X_{0} \in \Omega_{\infty}$ in Case II.

Proof. Let $\psi \in C_{c}^{\infty}\left(\Omega_{\infty}\right)$. Since $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$ and $\partial \Omega_{j} \rightarrow \partial \Omega_{\infty}$, it follows that $\psi \in C_{c}^{\infty}\left(\Omega_{j}\right)$ for $j$ sufficiently large. In Case I, using (4.4) and (2.22) we have

$$
\begin{equation*}
\int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla u_{j}, \nabla \psi\right\rangle d Z=\frac{1}{\omega_{j}^{X_{j}}(B(0,1))} \int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla G_{j}\left(X_{j}, \cdot\right), \nabla \psi\right\rangle d Z=\frac{\psi\left(X_{j}\right)}{\omega_{j}^{X_{j}}(B(0,1))} \rightarrow 0 \tag{4.81}
\end{equation*}
$$

as $j \rightarrow \infty$ since $X_{j} \rightarrow \infty$ by (4.3). Analogously, in Case II, by (4.7) and (2.22) we obtain

$$
\begin{equation*}
\int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla u_{j}, \nabla \psi\right\rangle d Z=\int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla G_{j}\left(X_{j}, \cdot\right), \nabla \psi\right\rangle d Z=\psi\left(X_{j}\right) \rightarrow \psi\left(X_{0}\right) . \tag{4.82}
\end{equation*}
$$

as $j \rightarrow \infty$ since $X_{j} \rightarrow X_{0}$.
Suppose next that spt $\psi \subset B(0, R)$. Let $r=2$ for Case $\mathbf{I}$, and pick $r \in[1, n /(n-1))$ for Case III. By (1) in Theorem 4.8 in Case I and (iii) in Remark 4.22 in Case II it follows that $\nabla u_{j} \rightharpoonup \nabla u_{\infty}$ in $L^{r}(B(0, R))$. On the other hand,

$$
\begin{align*}
&\left|\int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla u_{j}, \nabla \psi\right\rangle d Z-\int_{\Omega_{\infty}}\left\langle\mathcal{A}^{*} \nabla u_{\infty}, \nabla \psi\right\rangle d Z\right|  \tag{4.83}\\
& \leq\|\nabla\|_{L^{\infty}}\left(\int_{\Omega_{j} \cap B(0, R)}\left|\mathcal{A}_{j}-\mathcal{A}^{*}\right|^{r^{\prime}} d Z\right)^{\frac{1}{\gamma}}\left(\int_{\Omega_{j} \cap B(0, R)}\left|\nabla u_{j}\right|^{r}\right)^{\frac{1}{r}} \\
&+\left|\int_{\Omega_{j} \cap B(0, R)}\left\langle\mathcal{A}^{*} \nabla u_{j}, \nabla \psi\right\rangle d Z-\int_{\Omega_{\infty} \cap B(0, R)}\left\langle\mathcal{A}^{*} \nabla u_{\infty}, \nabla \psi\right\rangle d Z\right| .
\end{align*}
$$

Using (4.14) in Case I or (4.26) in Case II, and (4.65) with $p=r^{\prime}$, the term in the second line of (4.83) tends to zero as $j \rightarrow \infty$. Concerning the last term, since $\mathcal{A}^{*}$ is a constant-coefficient matrix, it follows that $\mathcal{A}^{*} \nabla u_{j} \rightharpoonup \mathcal{A}^{*} \nabla u_{\infty}$ in $L^{r}(B(0, R))$. Moreover $\overline{\Omega_{j}}=\overline{\left\{u_{j}>0\right\}} \rightarrow \overline{\Omega_{\infty}}=\overline{\left\{u_{\infty}>0\right\}}$, thus

$$
\lim _{j \rightarrow \infty} \int_{\Omega_{j}}\left\langle\mathcal{A}^{*} \nabla u_{j}, \nabla \psi\right\rangle=\int_{\Omega_{\infty}}\left\langle\mathcal{A}^{*} \nabla u_{\infty}, \nabla \psi\right\rangle .
$$

Combining these with (4.81)-(4.83) we eventually conclude that

$$
\begin{equation*}
\int_{\Omega_{\infty}} \mathcal{A}^{*} \nabla u_{\infty} \cdot \nabla \psi=0 \quad \text { for all } \psi \in C_{c}^{\infty}\left(\Omega_{\infty}\right) \tag{4.84}
\end{equation*}
$$

in Case I, i.e., $-\operatorname{div}\left(\mathcal{A}^{*} \nabla u_{\infty}\right)=0$ in $\Omega_{\infty}$; and in Case II,

$$
\begin{equation*}
\int_{\Omega_{\infty}} \mathcal{A}^{*} \nabla u_{\infty} \cdot \nabla \psi=\psi\left(X_{0}\right) \quad \text { for all } \psi \in C_{c}^{\infty}\left(\Omega_{\infty}\right), \tag{4.85}
\end{equation*}
$$

i.e., $-\operatorname{div}\left(\mathcal{A}^{*} \nabla u_{\infty}\right)=\delta_{\left\{X_{0}\right\}}$ in $\Omega_{\infty}$.
4.4. Analytic properties of the limiting domains. As mentioned in Section 4, in order to apply Theorem 1.1 we need to study the elliptic measures of the limiting domain with finite poles. In this section we construct these measures by a limiting procedure which is compatible with the procedure used to produce the limiting domain $\Omega_{\infty}$.

Theorem 4.86. Under Assumption (a), Assumption (b), Assumption (c), and using the notation from Theorems 4.8 and 4.78 , the elliptic measure $\omega_{L_{\infty}} \in A_{\infty}\left(\sigma_{\infty}\right)$ (see Definition 2.10) with constants $\widetilde{C}_{0}=C_{2} C_{A R}^{4 \theta} 2^{8(n-1) \theta}$ and $\widetilde{\theta}=\theta$, here $C_{2}$ is the constant in Remark 2.39.

Proof. Our goal is to show that the elliptic measures of $L_{\infty}$ with finite poles can be recovered as a limit of the elliptic measures of $L_{j}=-\operatorname{div}\left(\mathcal{A}_{j}(Z) \nabla\right)$, and the $A_{\infty}$ property of elliptic measures is preserved when passing to a limit.

To set the stage we start with $0 \leq f \in \operatorname{Lip}\left(\partial \Omega_{\infty}\right)$ with compact support. Let $R_{0}>0$ be large enough so that spt $f \subset B\left(0, R_{0} / 2\right)$. We are going to take a particular solution to the following Dirichlet problem

$$
\begin{cases}L_{\infty} v=0, & \text { in } \Omega_{\infty}  \tag{4.87}\\ v=f, & \text { on } \partial \Omega_{\infty}\end{cases}
$$

In Case II, where the domain $\Omega_{\infty}$ is bounded, the Dirichlet problem (4.87) has a unique solution satisfying the maximum principle, then we let $v_{\infty}$ be that unique solution.

In Case I, where $\Omega_{\infty}$ is unbounded, we follows the construction in [HM1] using Perron's method (see [HM1, pg. 588] for details, which is done the Laplacian but holds for any constant coefficient operator, for the general case see also [HMT2]). We denote the solution constructed in [HM1] by

$$
v_{\infty}(Z)=\int_{\partial \Omega_{\infty}} f(q) d \omega_{L_{\infty}}^{Z}(q)
$$

For later use we need to sketch how it is constructed. For every $R>4 R_{0}$ define $f_{R}=f \eta(\cdot / R)$, where $\eta \in C_{c}^{\infty}\left(B(0,2 R)\right.$ verifies $0 \leq \eta \leq 1, \eta=1$ for $|Z|<1$. Let $v_{R}$ be the unique solution to $L_{\infty} v_{R}=0$ in the bounded open set $\Omega_{R}=\Omega_{\infty} \cap B(0,2 R)$ with boundary value $f_{R}$. Then one shows that $v_{R} \rightarrow v_{\infty}$ uniformly on compacta as $R \rightarrow \infty$, and also that $v_{\infty} \in C\left(\overline{\Omega_{\infty}}\right)$ satisfies the maximum principle $0 \leq \max _{\Omega_{\infty}} v_{\infty} \leq \max _{\partial \Omega_{\infty}} f$.

Once the solution $v_{\infty}$ is defined we observe that since $\partial \Omega_{\infty}$ is Ahlfors regular we can use the Jonsson-Wallin trace/extension theory [JW] to extend $f$ (abusing the notation we call the extension $f$ ) so that $0 \leq f \in C_{c}\left(\mathcal{R}^{n}\right) \cap W^{1,2}\left(\mathcal{R}^{n}\right)$ with spt $f \subset B\left(0, R_{0}\right)$. For every $j$ we let $h_{j} \in W_{0}^{1,2}\left(\Omega_{j}\right)$ be the unique Lax-Milgram solution to the problem $L_{j} h_{j}=L_{j} f$. Initially, $h_{j}$ is only defined in $\Omega_{j}$ but we can clearly extend it by 0 outside so that the resulting function, which we call again $h_{j}$, belongs to $W^{1,2}\left(\mathcal{R}^{n}\right)$. If we next set $v_{j}=f-h_{j} \in W^{1,2}\left(\mathcal{R}^{n}\right)$ we obtain that $L_{j} v_{j}=0$ in $\Omega_{j}$ and indeed

$$
\begin{equation*}
v_{j}(Z)=\int_{\partial \Omega_{j}} f d \omega_{j}^{Z}, \quad Z \in \Omega_{j} \tag{4.88}
\end{equation*}
$$

see [HMT2]. Here $\omega_{j}^{Z}$ is the elliptic measure of $L_{j}$ in $\Omega_{j}$ with pole $Z$ and, as observed above, the fact that $\partial \Omega_{j}$ is Ahlfors regular implies in particular that $v_{j} \in C\left(\overline{\Omega_{j}}\right)$ with $\left.v_{j}\right|_{\partial \Omega_{j}}=f$. Note also that $v_{j}=f \in C\left(\mathcal{R}^{n}\right)$ on $\mathcal{R}^{n} \backslash \Omega_{j}$, hence $v_{j} \in C\left(\mathcal{R}^{n}\right)$. Moreover, by the maximum principle

$$
\begin{equation*}
0 \leq \sup _{\Omega_{j}} v_{j} \leq\|f\|_{L^{\infty}\left(\partial \Omega_{j}\right)} \leq\|f\|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \tag{4.89}
\end{equation*}
$$

thus the sequence $\left\{v_{j}\right\}$ is uniformly bounded.
Our next goal is to show that $\left\{v_{j}\right\}$ is equicontinuous. Given an arbitrary $\varrho>0$ let $0<\gamma<$ $\frac{1}{32}$ to be chosen. Since $f \in C_{c}\left(\mathcal{R}^{n}\right)$, it is uniformly continuous, hence letting $\gamma$ small enough (depending on $f$ ) we can guarantee that

$$
\begin{equation*}
|f(X)-f(Y)|<\frac{\varrho}{8}, \quad \text { provided }|X-Y|<\gamma^{\frac{1}{4}} \tag{4.90}
\end{equation*}
$$

Our first claim is that if $\gamma$ is small enough depending on $n, C_{A R}, \Lambda$ (recall that $\lambda=1$ ), and $\|f\|_{L^{\infty}\left(\mathcal{R}^{n}\right)}$, there holds

$$
\begin{equation*}
\left|v_{j}(X)-v_{j}(Y)\right|<\frac{\rho}{2}, \quad \forall X \in \Omega_{j}, Y \in \partial \Omega_{j},|X-Y|<\sqrt{\gamma} \tag{4.91}
\end{equation*}
$$

To see this we recall that $\partial \Omega_{j}$ is Ahlfors regular with a uniform constant (independent of $j$ ), it satisfies the CDC with a uniform constant and [HKM, Theorem 6.18] (see also [HMT2]) yields that for some $\beta>0$ and $C$ depending on $n, C_{A R}$, and $\Lambda$, but independent of $j$ (indeed this is the same $\beta$ as in Lemma 2.24), the following estimate holds:

$$
\underset{B\left(Y_{j}, \sqrt{\gamma}\right) \cap \Omega_{j}}{\operatorname{osc}} v_{j} \leq \underset{B\left(Y_{j}, \gamma^{1 / 4}\right) \cap \partial \Omega_{j}}{\operatorname{osc}} f+C\|f\|_{L^{\infty}\left(\mathcal{R}^{n}\right)} \eta^{\beta}<\frac{\varrho}{2}
$$

where in the last estimate we have used (4.90) and $\gamma$ has been chosen small enough so that $C\|f\|_{L^{\infty}\left(\mathcal{R}^{n}\right)} \eta^{\beta}<\varrho / 4$.

We now fix $X, Y \in \mathcal{R}^{n}$ so that $|X-Y|<\gamma$ and consider several cases.
Case 1: $X, Y \in \Omega_{j}$ with $\max \left\{\delta_{j}(X), \delta_{j}(Y)\right\}<\sqrt{\gamma} / 2$.
In this case, we take $\hat{x} \in \partial \Omega_{j}$ so that $|X-\hat{x}|=\delta_{j}(X)$. Note that $|Y-\hat{x}|<\sqrt{\gamma}$ and we can use (4.91) to obtain

$$
\left|v_{j}(X)-v_{j}(Y)\right| \leq\left|v_{j}(X)-v_{j}(\widehat{x})\right|+\left|v_{j}(\widehat{x})-v_{j}(Y)\right|<\rho
$$

Case 2: $X, Y \in \Omega_{j}$ with $\max \left\{\delta_{j}(X), \delta_{j}(Y)\right\} \geq \sqrt{\gamma} / 2$.
Assuming without loss of generality that $\delta_{j}(X) \geq \sqrt{\gamma} / 2$, necessarily $Y \in B\left(X, \delta_{j}(X) / 2\right) \subset$ $\Omega_{j}$. Then, by the interior Hölder regularity of $v_{j}$ in $\Omega_{j}$ (here $\alpha$ and $C$ depend only on $\Lambda$ and are independent of $j$ ) we conclude that

$$
\left|v_{j}(X)-v_{j}(Y)\right| \leq C\left(\frac{|X-Y|}{\delta_{j}(X)}\right)^{\alpha}\left\|v_{j}\right\|_{L^{\infty}\left(\Omega_{j}\right)} \leq C 2^{\alpha} \gamma^{\frac{\alpha}{2}}\|f\|_{L^{\infty}\left(\mathcal{R}^{n}\right)}<\varrho
$$

provided $\varrho$ is taken small enough (again independently of $j$ ).
Case 3: $X, Y \notin \Omega_{j}$.
Here we just need to use (4.90) and the fact that $v_{j}=f$ on $\mathcal{R}^{n} \backslash \Omega_{j}$ :

$$
\left|v_{j}(X)-v_{j}(Y)\right|=|f(X)-f(Y)|<\rho
$$

Case 4: $X \in \Omega_{j}$ and $Y \notin \Omega_{j}$.
Pick $Z \in \partial \Omega_{j}$ in the line segment joining $X$ and $Y$ (if $Y \in \partial \Omega_{j}$ we just take $Z=Y$ ) so that $|X-Z|,|Y-Z| \leq|X-Y|<\gamma$. Using (4.91), the fact that $v_{j}=f$ on $\mathcal{R}^{n} \backslash \Omega_{j}$, and (4.90) we obtain

$$
\left|v_{j}(X)-v_{j}(Y)\right| \leq\left|v_{j}(X)-v_{j}(Z)\right|+\left|v_{j}(Z)-v_{j}(Y)\right|<\frac{\varrho}{2}+|f(Z)-f(Y)|<\varrho
$$

If we now put all the cases together we have shown that, as desired, $\left\{v_{j}\right\}$ is equicontinuous.
On the other hand, recalling that $h_{j} \in W_{0}^{1,2}\left(\Omega_{j}\right)$ satisfies $L_{j} h_{j}=L_{j} f$ in the weak sense in $\Omega_{j}$, that $f \in W^{1,2}\left(\mathcal{R}^{n}\right)$, and that $\lambda=1$, we see that

$$
\left\|\nabla h_{j}\right\|_{L^{2}\left(\Omega_{j}\right)}^{2} \leq \int_{\Omega_{j}}\left\langle\mathcal{A}_{j} \nabla h_{j}, \nabla h_{j}\right\rangle d X=\int_{\Omega_{j}}\left\langle\mathcal{A} j \nabla f, \nabla h_{j}\right\rangle d X \leq \Lambda\|\nabla f\|_{L^{2}\left(\Omega_{j}\right)}\left\|\nabla h_{j}\right\|_{L^{2}\left(\Omega_{j}\right)} .
$$

We next absorb the last term, use that $v_{j}=f-h_{j}$ and that $h_{j}$ has been extended as 0 outside of $\Omega_{j}$ :

$$
\left\|\nabla v_{j}\right\|_{L^{2}\left(\mathcal{R}^{n}\right)} \leq\|\nabla f\|_{L^{2}\left(\mathcal{R}^{n}\right)}+\left\|\nabla h_{j}\right\|_{L^{2}\left(\mathcal{R}^{n}\right)}=\|\nabla f\|_{L^{2}\left(\mathcal{R}^{n}\right)}+\left\|\nabla h_{j}\right\|_{L^{2}\left(\Omega_{j}\right)} \leq(1+\Lambda)\|\nabla f\|_{L^{2}\left(\mathcal{R}^{n}\right)} .
$$

This along with (4.89) yield

$$
\begin{equation*}
\sup _{j}\left\|\nabla v_{j}\right\|_{L^{2}\left(\mathbb{R}^{n}\right)} \leq(1+\Lambda)\|\nabla f\|_{L^{2}\left(\mathbb{R}^{n}\right)}, \quad \text { and } \sup _{j}\left\|v_{j}\right\|_{L^{2}(B(0, R))} \leq C_{R} . \tag{4.92}
\end{equation*}
$$

We notice that all these estimates hold for the whole sequence and therefore, so it does for any subsequence.

Let us now fix an arbitrary subsequence $\left\{v_{j_{k}}\right\}_{k}$. By (4.92) there are a further subsequence and $v \in C\left(\mathcal{R}^{n}\right) \cap W_{\text {loc }}^{1,2}\left(\mathbb{R}^{n}\right)$ with $\nabla v \in L^{2}\left(\mathbb{R}^{n}\right)$, such that $v_{j_{k_{l}}} \rightarrow v$ uniformly on compact sets of $\mathbb{R}^{n}$ (hence $v \geq 0$ ) and $\nabla v_{j_{k}} \rightharpoonup \nabla v$ in $L^{2}\left(\mathbb{R}^{n}\right)$ as $l \rightarrow \infty$. Here it is important to emphasize that the choice of the subsequence may depend on the boundary data $f$ and the fixed subsequence, and the same happens with $v$, and this could be problematic, later we will see that this is not the case.

To proceed we next see that $v$ agrees with $f$ in $\partial \Omega_{\infty}$. Given $p \in \partial \Omega_{\infty}$, there exist $p_{j_{k_{l}}} \in$ $\partial \Omega_{j_{k_{l}}}$ with $p_{j_{k_{l}}} \rightarrow p$ as $l \rightarrow \infty$. Using the continuity of $v$ and $f$ at $p$, the uniform convergence of $v_{j_{k_{l}}}$ to $v$ on $\overline{B(p, 1)}$ and the fact that $v_{j_{k_{l}}}=f$ on $\partial \Omega_{j_{k_{l}}}$, we have

$$
\begin{aligned}
|v(p)-f(p)| & \leq\left|v(p)-v\left(p_{j_{k_{l}}}\right)\right|+\left|v\left(p_{j_{k_{l}}}\right)-v_{j_{k_{l}}}\left(p_{j_{k_{l}}}\right)\right|+\left|f\left(p_{j_{k_{l}}}\right)-f(p)\right| \\
& \leq\left|v(p)-v\left(p_{j_{k_{l}}}\right)\right|+\left|\left|v-v_{j_{k_{l}}} \|_{L^{\infty}(\bar{B}(\overline{B(p, 1)})}+\left|f\left(p_{j_{k_{l}}}\right)-f(p)\right| \rightarrow 0, \quad \text { as } l \rightarrow \infty,\right.\right.
\end{aligned}
$$

thus $v(p)=f(p)$ as desired.
Next, we claim the function $v$ solves the Dirichlet problem (4.87). We know that $v \in$ $C\left(\mathcal{R}^{n}\right)$ with $v=f$ in $\partial \Omega_{\infty}$. Hence, we only need to show that $L_{\infty} v=0$ in $\Omega_{\infty}$. To this aim, let us take $\psi \in C_{c}^{1}\left(\Omega_{\infty}\right)$ and let $R>0$ be large enough so that spt $\psi \subset B(0, R)$. Since $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$, for all $l$ large enough we have that $\psi \in C_{c}^{1}\left(\Omega_{j_{k}}\right)$ in which case

$$
\begin{equation*}
\int_{\mathcal{R}^{n}}\left\langle\mathcal{A}_{j_{k_{l}}} \nabla v_{j_{k_{l}}}, \nabla \psi\right\rangle d Z=0, \tag{4.93}
\end{equation*}
$$

since $L_{j_{k_{l}}} v_{j_{k_{l}}}=0$ in $\Omega_{j_{k_{l}}}$ in the weak sense. Then, by (4.92) and the fact that spt $\psi \subset$ $\Omega_{\infty} \cap \Omega_{j_{k_{l}}} \cap B(0, R)$,

$$
\begin{aligned}
& \left|\int_{\mathcal{R}^{n}}\left\langle\mathcal{A}^{*} \nabla v, \nabla \psi\right\rangle d Z\right|=\left|\int_{\Omega_{j_{k}}}\left\langle\mathcal{A}_{j_{k}} \nabla v_{j_{k_{l}},}, \nabla \psi\right\rangle d Z-\int_{\Omega_{\infty}}\left\langle\mathcal{A}^{*} \nabla v, \nabla \psi\right\rangle d Z\right| \\
& \leq(1+\Lambda)\|\nabla f\|_{L^{2}\left(\mathcal{R}^{n}\right)}\|\nabla \psi\|_{L^{\infty}}\left(\int_{\Omega_{j} \cap B(0, R)}\left|\mathcal{A}_{j_{k_{l}}}-\mathcal{A}^{*}\right|^{2} d Z\right)^{\frac{1}{2}} \\
& \quad+\left|\int_{\mathcal{R}^{n}}\left\langle\mathcal{A}^{*} \nabla v_{j_{k_{l}}}, \nabla \psi\right\rangle d Z-\int_{\mathcal{R}^{n}}\left\langle\mathcal{A}^{*} \nabla v, \nabla \psi\right\rangle d Z\right| \rightarrow 0, \quad \text { as } l \rightarrow \infty,
\end{aligned}
$$

where we have used (4.65) with $p=2$ for the term in the second line, and the fact that since $\mathcal{A}^{*}$ is a constant-coefficient matrix, it follows that $\mathcal{A}^{*} \nabla v_{j_{k l}} \rightharpoonup \mathcal{A}^{*} \nabla v$ in $L^{2}\left(\mathcal{R}^{n}\right)$ as $l \rightarrow \infty$. This eventually shows that $L_{\infty} \mathcal{V}=0$ in $\Omega_{\infty}$.

In Case II when the domain $\Omega_{\infty}$ is bounded, the Dirichlet problem (4.87) has a unique solution, and it satisfies the maximum principle, hence we must have that $v=v_{\infty}$. Therefore, we have shown that given any subsequence $\left\{v_{j_{k}}\right\}_{k}$ there is a further subsequence $\left\{v_{j_{k_{l}}}\right\}_{l}$ so that $v_{j_{k_{l}}} \rightarrow v_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$ and $\nabla v_{j_{k_{l}}} \rightharpoonup \nabla v_{\infty}$ in $L^{2}\left(\mathbb{R}^{n}\right)$ as $l \rightarrow \infty$. This eventually shows that entire sequence $\left\{v_{j}\right\}$ satisfies $v_{j} \rightarrow v_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$ and $\nabla v_{j} \rightharpoonup \nabla v_{\infty}$ in $L^{2}\left(\mathbb{R}^{n}\right)$ as $j \rightarrow \infty$.

In Case I where the limiting domain $\Omega_{\infty}$ is unbounded, we need more work to show the solution $v$ is indeed $v_{\infty}$. Recall that $f \in C_{c}\left(\mathcal{R}^{n}\right)$ with $\operatorname{spt} f \subset B\left(0, R_{0}\right)$. Given $\epsilon>0$, there is an integer $j_{0}=j_{0}\left(\epsilon, R_{0}\right) \in \mathbb{N}$ such that for $j \geq j_{0}$ and for any $p_{j}^{\prime} \in \partial \Omega_{j} \cap B\left(0,4 R_{0}\right)$, there is $p^{\prime} \in \partial \Omega_{\infty} \cap B\left(0,5 R_{0}\right)$ close enough to $p_{j}^{\prime}$ so that $\left|f\left(p^{\prime}\right)-f\left(p_{j}^{\prime}\right)\right|<\epsilon$. Consequently,

\sup _{\partial \Omega_{j}}|f|=\sup _{\partial \Omega_{j} \cap B\left(0,4 R_{0}\right)}|f| \leq \sup _{\partial \Omega_{\infty} \cap B\left(0,5 R_{0}\right)}|f|+\epsilon=\sup _{\partial \Omega_{\infty}}|f|+\epsilon . \tag{4.94}
\end{equation*}
$$

For any $Z \in \Omega_{\infty}$ there exists a sequence $Z_{j} \in \Omega_{j}$ such that $Z_{j} \rightarrow Z$ and $Z_{j} \in \overline{B\left(Z, \delta_{\infty}(Z) / 2\right)}$ for all $j$ large enough. Since $v \in C\left(\mathcal{R}^{n}\right)$ it follows that for $j$ large enough $\left|v(Z)-v\left(Z_{j}\right)\right|<\epsilon$. All these together with (4.89) and the fact that $v_{j_{k_{l}}} \rightarrow v$ uniformly on compact sets of $\mathbb{R}^{n}$ as $l \rightarrow \infty$ give that for all $l$ large enough

\begin{equation*}
0 \leq v(Z) \leq\left|v(Z)-v\left(Z_{j_{k_{l}}}\right)\right|+\left|v\left(Z_{j_{k_{l}}}\right)-v_{j_{k_{l}}}\left(Z_{j_{k_{l}}}\right)\right|+\left|v_{j_{k_{l}}}\left(Z_{j_{k_{l}}}\right)\right| \leq 2 \epsilon+\sup _{\partial \Omega_{j}}|f| \leq 3 \epsilon+\sup _{\partial \Omega_{\infty}}|f| \tag{4.95}
\end{equation*}
$$

Letting $\epsilon \rightarrow 0$ we get $0 \leq \sup _{\Omega_{\infty}} \nu \leq \sup _{\partial \Omega_{\infty}}|f|$.
Let us recall that $\Omega_{R}=\Omega_{\infty} \cap B(0,2 R) \subset \Omega_{\infty}$. Since $v \in C\left(\mathcal{R}^{n}\right)$ with $\left.v\right|_{\partial \Omega_{\infty}}=f$, and since spt $f \subset B\left(0, R_{0}\right)$, for every $R>4 R_{0}$ we have that $\left.f_{R}\right|_{\partial \Omega_{\infty}}=f \eta(\cdot / R) \leq\left. v\right|_{\partial \Omega_{\infty}}$. Hence the maximum principle implies that $v_{R} \leq v$ in $\Omega_{R}$, and taking limits we conclude that $v_{\infty} \leq v$ on $\Omega_{\infty}$. Write $0 \leq \widetilde{v}=v-v_{\infty} \in C\left(\overline{\Omega_{\infty}}\right)$ so that $L_{\infty} \widetilde{v}=0$ in $\Omega_{\infty}$ and $\widetilde{\mathcal{v}} \partial_{\Omega_{\infty}}=0$. For any $Z \in \Omega_{\infty}$, since $\Omega_{\infty}$ is a uniform domain with Ahlfors regular boundary, by Lemma 2.24 for any $\delta_{\infty}(Z)<R^{\prime}<\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\infty$ (see (3) in Theorem 4.8)

$$
\begin{equation*}
0 \leq \widetilde{v}(Z) \lesssim\left(\frac{\delta_{\infty}(Z)}{R^{\prime}}\right)^{\beta} \sup _{\Omega_{\infty}} \widetilde{v} \leq 2\left(\frac{\delta_{\infty}(Z)}{R^{\prime}}\right)^{\beta} \sup _{\partial \Omega_{\infty}} f, \tag{4.96}
\end{equation*}
$$

Letting $R^{\prime} \rightarrow \infty$ we conclude that $\widetilde{v}(Z)=0$ and hence $v=v_{\infty}$. Therefore, we have shown that given a subsequence $\left\{v_{j_{k}}\right\}_{k}$ there is a further subsequence $\left\{v_{j_{k}}\right\}_{l}$ so that $v_{j_{k_{l}}} \rightarrow v_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$ and $\nabla v_{j_{k_{l}}} \rightharpoonup \nabla v_{\infty}$ in $L^{2}\left(\mathbb{R}^{n}\right)$ as $l \rightarrow \infty$. This eventually shows that entire sequence $\left\{v_{j}\right\}$ satisfies $v_{j} \rightarrow v_{\infty}$ uniformly on compact sets of $\mathbb{R}^{n}$ and $\nabla v_{j} \rightharpoonup \nabla v_{\infty}$ in $L^{2}\left(\mathbb{R}^{n}\right)$ as $j \rightarrow \infty$.

Hence, in both Case I and Case III, if $0 \leq f \in \operatorname{Lip}\left(\partial \Omega_{\infty}\right)$ has compact support then

\begin{equation*}
\lim _{j \rightarrow \infty} \int_{\partial \Omega_{j}} f(q) d \omega_{j}^{Z}(q)=\lim _{j \rightarrow \infty} v_{j}(Z)=v_{\infty}(Z)=\int_{\partial \Omega_{\infty}} f(q) d \omega_{L_{\infty}}^{Z}(q), \tag{4.97}
\end{equation*}
$$

for any $Z \in \Omega_{\infty}$. A standard approximation argument and splitting each function on its positive and negative parts lead to shows that (4.97) holds for all $f \in C_{c}\left(\mathbb{R}^{n}\right)$, hence $\omega_{j}^{Z} \rightharpoonup$ $\omega_{L_{\infty}}^{Z}$ as Radon measures for any $Z \in \Omega_{\infty}$.

Our next goal is to see that $\omega_{L_{\infty}} \in A_{\infty}\left(\sigma_{\infty}\right)$ (where $\sigma_{\infty}=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{\infty}}$ ). Fix $p \in \partial \Omega_{\infty}$ and $0<r<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$. Recall that whether $\operatorname{diam}\left(\partial \Omega_{\infty}\right)$ is finite or infinite, we always have $r<\operatorname{diam}\left(\Omega_{j}\right)$ for all $j$ sufficiently large. Let $\Delta^{\prime}=B(m, s) \cap \partial \Omega_{\infty}$ with $m \in \partial \Omega_{\infty}$ and $B(m, s) \subset B(p, r) \cap \partial \Omega_{\infty}$. Let $A(p, r) \in \Omega_{\infty}$ be a corkscrew point relative to $\Delta(p, r)$ (whose existence is guaranteed by (4) in Theorem 4.8). We can then find $p_{j} \in \partial \Omega_{j}$ such that $p_{j} \rightarrow p$. Thus, for all $j$ large enough $B(p, r) \subset B\left(p_{j}, 2 r\right)$ and $\delta_{j}(A(p, r)) \geq r /(2 M)$. Hence, $A(p, r)$ is also a corkscrew point relative to $B\left(p_{j}, 2 r\right) \cap \partial \Omega_{j}$ in $\Omega_{j}$ with constant $4 M$. Since $m \in \partial \Omega_{\infty}$, we can also find $m_{j} \in \partial \Omega_{j}$ such that $m_{j} \rightarrow m$. In particular, for $j$ sufficiently large

\begin{equation*}
\left|m_{j}-m\right|<\frac{s}{5} . \tag{4.98}
\end{equation*}
$$

Note also that since all the $\Omega_{j}$ 's are uniform and satisfy the CDC with the same constants, and all the operators $L_{j}$ 's have ellipticity constants bounded below and above by $\lambda=1$ and $\Lambda$, we can conclude from Remark 2.39 that there is a uniform constant $C_{2}$ depending on $M, C_{1}, C_{A R}>1$, and $\Lambda$, such that (2.40) holds for all $\omega_{j}$ with the appropriate changes. Using this and [Mat, Theorem 1.24] we obtain

\begin{align*}
& \omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s)) \geq \omega_{L_{\infty}}^{A(p, r)}\left(\overline{B\left(m, \frac{4}{5} s\right)}\right) \geq \underset{j \rightarrow \infty}{\limsup } \omega_{j}^{A(p, r)}\left(\overline{B\left(m, \frac{4}{5} s\right)}\right)  \tag{4.99}\\
& \geq \limsup _{j \rightarrow \infty} \omega_{j}^{A(p, r)}\left(\overline{B\left(m_{j}, \frac{3}{5} s\right)}\right) \geq C_{2}^{-1} \limsup _{j \rightarrow \infty} \omega_{j}^{A(p, r)}\left(B\left(m_{j}, \frac{6}{5} s\right)\right),
\end{align*}
$$

where we have used that $\delta_{j}(A(p, r)) \geq r /(2 M) \geq \frac{3}{5} s /(2 M)$.
Let $V$ be an arbitrary open set in $B(m, s)$, and note that by (4.98)

V \subset B(m, s) \subset B\left(m_{j}, \frac{6}{5} s\right) .
$$

Using again [Mat, Theorem 1.24], we see that (4.99) yields

\begin{align*}
& \frac{\omega_{L_{\infty}}^{A(p, r)}(V)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))} \leq C_{2} \frac{\liminf _{j \rightarrow \infty} \omega_{j}^{A(p, r)}(V)}{\lim \sup _{j \rightarrow \infty} \omega_{j}^{A(p, r)}\left(B\left(m_{j}, \frac{6}{5} s\right)\right)}  \tag{4.100}\\
& \leq C_{2} \liminf _{j \rightarrow \infty}\left(\frac{\omega_{j}^{A(p, r)}(V)}{\omega_{j}^{A(p, r)}\left(B\left(m_{j}, \frac{6}{5} s\right)\right)}\right)
\end{align*}
$$

The assumption $B(m, s) \subset B(p, r)$ implies $|m-p| \leq r-s$. Using this and that $m_{j} \rightarrow m$, $p_{j} \rightarrow p$ as $j \rightarrow \infty$ one can easily see that $\left|m_{j}-p_{j}\right|<r-\frac{s}{5}$ for all $j$ large enough and hence

\begin{equation*}
B\left(m_{j}, \frac{6}{5} s\right) \cap \partial \Omega_{j} \subset B\left(p_{j}, 2 r\right) \cap \partial \Omega_{j} . \tag{4.101}
\end{equation*}
$$

As mentioned above $A(p, r)$ is a corkscrew point relative to $B\left(p_{j}, 2 r\right) \cap \partial \Omega_{j}$ in $\Omega_{j}$. This, (4.101) and the fact that by assumption, $\omega_{j} \in A_{\infty}\left(\sigma_{j}\right)$ with uniform constants $C_{0}, \theta$ allow us to conclude that

$$
\begin{equation*}
\frac{\omega_{j}^{A(p, r)}(V)}{\omega_{j}^{A(p, r)}\left(B\left(m_{j}, \frac{6}{5} s\right)\right)} \leq C_{0}\left(\frac{\sigma_{j}(V)}{\sigma_{j}\left(B\left(m_{j}, \frac{6}{5} s\right)\right)}\right)^{\theta} \leq C_{0} C_{A R}^{\theta}\left(\frac{\sigma_{j}(V)}{s^{n-1}}\right)^{\theta}, \tag{4.102}
\end{equation*}
$$

where in the last estimate we have used that $\partial \Omega_{j}$ is Ahlfors regular with constants $C_{A R}$. Combining (4.100), (4.102), the fact that $\sigma_{j} \rightarrow \mu_{\infty}$, [Mat, Theorem 1.24], and (5) in Theorem 4.8 , we finally arrive at

& \frac{\omega_{L_{\infty}}^{A(p, r)}(V)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))} \leq C_{0} C_{A R}^{\theta}\left(\liminf _{j \rightarrow \infty} \frac{\sigma_{j}(V)}{s^{n-1}}\right)^{\theta} \\
& \leq C_{0} C_{A R}^{\theta}\left(\frac{\mu_{\infty}(\bar{V})}{s^{n-1}}\right)^{\theta} \leq C_{0} C_{A R}^{4 \theta} 2^{8(n-1) \theta}\left(\frac{\sigma_{\infty}(\bar{V})}{\sigma_{\infty}(\Delta(m, s))}\right)^{\theta}
\end{aligned}
$$

and therefore we have shown that for any open set $V \subset B(m, s)$ there holds

$$
\begin{equation*}
\frac{\omega_{L_{\infty}}^{A(p, r)}(V)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))} \leq C_{0} C_{A R}^{4 \theta} 8^{8(n-1) \theta}\left(\frac{\sigma_{\infty}(\bar{V})}{\sigma_{\infty}(\Delta(m, s))}\right)^{\theta} . \tag{4.103}
\end{equation*}
$$

Consider next an arbitrary Borel set $E \subset B(m, s)$. Since $\sigma_{\infty}$ and $\omega_{L_{\infty}}^{A(p, r)}$ are Borel regular, given any $\epsilon>0$ there is an open set $U$ and a compact set $F$ so that $F \subset E \subset U \subset B(m, s)$ and $\omega_{L_{\infty}}^{A(p, r)}(U \backslash F)+\sigma_{\infty}(U \backslash F)<\epsilon$. Note that for any $x \in F$, there is $r_{x}>0$ such that $B\left(x, 2 r_{x}\right) \subset U$. Using that $F$ is compact we can then show there exists a finite collection of points $\left\{x_{i}\right\}_{i=1}^{m} \subset F$ such that $F \subset \bigcup_{i=1}^{m} B\left(x_{i}, r_{i}\right)=: V$ and $B\left(x_{i}, 2 r_{i}\right) \subset U$ for $i=1, \ldots, m$. Consequently, $F \subset V \subset \bar{V} \subset U$ and $\sigma_{\infty}(\bar{V} \backslash F) \leq \sigma_{\infty}(U \backslash F)<\epsilon$. We next use (4.103) with $V$ to see that

$$
\begin{aligned}
\frac{\omega_{L_{\infty}}^{A(p, r)}(E)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))} & \leq \frac{\epsilon+\omega_{L_{\infty}}^{A(p, r)}(F)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))}
\end{aligned} \leq \frac{\epsilon+\omega_{L_{\infty}}^{A(p, r)}(V)}{\omega_{L_{\infty}}^{A(p, r)}(\Delta(m, s))} .
$$

Letting $\epsilon \rightarrow 0$ we obtain as desired that $\omega_{L_{\infty}} \in A_{\infty}\left(\sigma_{\infty}\right)$ with constants $C_{0} C_{A R}^{4 \theta} 2^{8(n-1) \theta}$ and $\theta$ and the proof is complete.

## 5. Proof of Theorem 1.8

Applying Theorem 4.8, we obtain that $\Omega_{\infty}$ is a uniform domain with constants $4 M$ and $2 C_{1}$, whose boundary is Ahlfors regular with constant $2^{5(n-1)} C_{A R}^{2}$. Moreover, Theorem 4.86 gives that $\omega_{L_{\infty}} \in A_{\infty}\left(\sigma_{\infty}\right)$ with constants $\widetilde{C}_{0}=C_{2} C_{A R}^{4 \theta} 2^{8(n-1) \theta}$ and $\widetilde{\theta}=\theta$. Here $L_{\infty}=$
$-\operatorname{div}\left(\mathcal{A}^{*} \nabla\right)$ with $\mathcal{A}^{*}$ a constant-coefficient real symmetric uniformly elliptic matrix with ellipticity constants $1=\lambda \leq \Lambda<\infty$. We can then invoke Theorem 1.1, to see that $\Omega_{\infty}$ satisfies the exterior corkscrew condition with constant

$$
N_{0}=N_{0}\left(4 M, 2 C_{1}, 2^{5(n-1)} C_{A R}^{2}, \Lambda, C_{0} C_{2} C_{A R}^{4 \theta} 2^{8(n-1) \theta}, \theta\right)
$$

(see introduction to Section 3). Therefore, since $0 \in \partial \Omega_{\infty}, 0<\frac{1}{2}<\operatorname{diam}\left(\partial \Omega_{\infty}\right)$ (recall that $\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\infty$ in Case I , and $\operatorname{diam}\left(\partial \Omega_{\infty}\right)=\operatorname{diam}\left(\Omega_{\infty}\right)=R_{0} \geq 1$ ) there exists $A_{0}=A^{-}\left(0, \frac{1}{2}\right)$ so that

$$
\begin{equation*}
B\left(A_{0}, \frac{1}{2 N_{0}}\right) \subset B\left(0, \frac{1}{2}\right) \backslash \overline{\Omega_{\infty}} \tag{5.1}
\end{equation*}
$$

Hence

$$
\begin{equation*}
\operatorname{dist}\left(B\left(A_{0}, \frac{1}{4 N_{0}}\right), \mathcal{R}^{n} \backslash \overline{\Omega_{\infty}}\right) \geq \frac{1}{4 N_{0}} . \tag{5.2}
\end{equation*}
$$

Since $\overline{\Omega_{j}} \rightarrow \overline{\Omega_{\infty}}$, it follows that for all $j$ large enough

$$
\begin{equation*}
B\left(A_{0}, \frac{1}{4 N_{0}}\right) \subset B\left(0, \frac{1}{2}\right) \backslash \overline{\Omega_{j}} \subset B(0,1) \backslash \overline{\Omega_{j}} . \tag{5.3}
\end{equation*}
$$

Hence for all $j$ large enough $A_{0}$ is a corkscrew point relative to $B(0,1) \cap \partial \Omega_{j}$ for $\mathcal{R}^{n} \backslash \overline{\Omega_{j}}$ with constant $4 N_{0}$. This contradicts our assumption that $\Omega_{j}$ has no exterior corkscrew point with constant $N=4 N_{0}$ for the surface ball $B(0,1) \cap \partial \Omega_{j}$ and the proof is complete.

## Part II. Large constant case

The extrapolation argument to augment small Carleson norm is in essence an inductive process combined with delicate stopping time arguments. It requires us to construct the socalled sawtooth domains on which we have better control of the Carleson measure norm. We explain the construction of these sawtooth domains and auxiliary definitions in Section 6 , to set the stage for the extrapolation argument. In Section 7 we first state several key ingredients to be used in the proof, namely: the framework of the extrapolation argument in Theorem 7.1 proved in [HMM1]; and Theorem 7.7, a criterion for uniform rectifiability proven as a combination of [HMM1], [GMT]. We then outline the proof of Theorem 1.6 using these ingredients and the small constant result proven in Part I (i.e. Corollary 1.13), and in the process reduce matters to two main steps, which are then carried out in two separate sections. In Section 8, we prove a technical estimate showing that a continuous parameter Carleson measure, restricted to a sawtooth subdomain, may be controlled quantitatively by a discretized version of itself. Section 9 contains the most delicate technical part of the proof, involving transference of the $A_{\infty}$ property to sawtooth subdomains. Finally in Section 10 we discuss the optimality of Theorem 1.6 and present an important corollary.
6. Construction of sawtooth domains and Discrete Carleson measures

Lemma 6.1 (Dyadic decomposition of Ahlfors regular set, [DS1, DS2, Chr]). Let $E \subset \mathbb{R}^{n}$ be an Ahlfors regular set. Then there exist constants $a_{0}, A_{1}, \gamma>0$, depending only on $n$ and the constants of Ahlfors regularity, such that for each $k \in \mathbb{Z}$, there is a collection of Borel sets ("dyadic cubes")

\mathbb{D}_{k}:=\left\{Q_{j}^{k} \subset E: j \in \mathscr{J}_{k}\right\},
$$

where $\mathscr{J}_{k}$ denotes some index set depending on $k$, satisfying the following properties.
(i) $E=\bigcup_{j \in \mathscr{f}_{k}} Q_{j}^{k}$ for each $k \in \mathbb{Z}$.
(ii) If $m \geq k$ then either $Q_{i}^{m} \subset Q_{j}^{k}$ or $Q_{i}^{m} \cap Q_{j}^{k}=\emptyset$.
(iii) For each pair $(j, k)$ and each $m<k$, there is a unique $i \in \mathscr{J}_{m}$ such that $Q_{j}^{k} \subset Q_{i}^{m}$.
(iv) $\operatorname{diam} Q_{j}^{k} \leq A_{1} 2^{-k}$.
(v) Each $Q_{j}^{k}$ contains some surface ball $\Delta\left(x_{j}^{k}, a_{0} 2^{-k}\right):=B\left(x_{j}^{k}, a_{0} 2^{-k}\right) \cap E$.
(vi) For all $(j, k)$ and all $\rho \in(0,1)$

\begin{align*}
\mathcal{H}^{n-1}\left(\left\{q \in Q_{j}^{k}:\right.\right. & \left.\left.\operatorname{dist}\left(q, E \backslash Q_{j}^{k}\right) \leq \rho 2^{-k}\right\}\right)  \tag{6.2}\\
& +\mathcal{H}^{n-1}\left(\left\{q \in E \backslash Q_{j}^{k}: \operatorname{dist}\left(q, Q_{j}^{k}\right) \leq \rho 2^{-k}\right\}\right) \leq A_{1} \rho^{\gamma} \mathcal{H}^{n-1}\left(Q_{j}^{k}\right) .
\end{align*}
$$

We shall denote by $\mathbb{D}=\mathbb{D}(E)$ the collection of all relevant $Q_{j}^{k}$, i.e.,

\mathbb{D}=\bigcup_{k} \mathbb{D}_{k}, \tag{6.3}
\end{equation*}
$$

where, if $\operatorname{diam}(E)$ is finite, the union runs over those $k$ such that $2^{-k} \lesssim \operatorname{diam}(E)$.
Remark 6.4. For a dyadic cube $Q \in \mathbb{D}_{k}$, we shall set $\ell(Q)=2^{-k}$, and we shall refer to this quantity as the "length" of $Q$. Evidently, $\ell(Q) \approx \operatorname{diam}(Q)$. We will also write $x_{Q}$ for the "center" of $Q$, that is, the center of the ball appearing in (v).

Assume from now on that $\Omega$ is a uniform domain with Ahlfors regular boundary and set $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$. Let $\mathbb{D}=\mathbb{D}(\partial \Omega)$ be the associated dyadic grid from the previous result. We first make a simple observation:

Corollary 6.5 (Doubling property of the kernel). Let $Q \in \mathbb{D}$ be a dyadic cube, and $\widetilde{Q} \in \mathbb{D}$ be such that $C_{1}^{-1} \ell(Q) \leq \ell(\widetilde{Q}) \leq C_{1} \ell(Q)$ and $\operatorname{dist}(Q, \widetilde{Q}) \leq C_{1} \ell(Q)$ for some $C_{1} \geq 1$. Suppose $\omega \in R H_{p}(\sigma)$ for some $p>1$, then for $X_{Q}$ the corkscrew relative to $Q$ we have

$$
\begin{equation*}
\int_{\widetilde{Q}}\left(\mathbf{k}^{X_{Q}}\right)^{p} d \sigma \leq C \int_{Q}\left(\mathbf{k}^{X_{Q}}\right)^{p} d \sigma, \tag{6.6}
\end{equation*}
$$

with a constant $C$ depending on $C_{1}$ and the allowable constants and where $\mathbf{k}=d \omega / d \sigma$.

The proof is a simple corollary of the doubling property of the elliptic measure (see Lemma 2.37):

$$
\left(f_{\widetilde{Q}}\left(\mathbf{k}^{X_{Q}}\right)^{p} d \sigma\right)^{\frac{1}{p}} \leq \frac{\omega^{X_{Q}}(\widetilde{Q})}{\sigma(\widetilde{Q})} \approx \frac{\omega^{X_{Q}}(Q)}{\sigma(Q)}=f_{Q} \mathbf{k}^{X_{Q}} d \sigma \leq\left(f_{Q}\left(\mathbf{k}^{X_{Q}}\right)^{p} d \sigma\right)^{\frac{1}{p}} .
$$

Let $\mathcal{W}=\mathcal{W}(\Omega)$ denote a collection of (closed) dyadic Whitney cubes of $\Omega$ (just dyadically divide the standard Whitney cubes from [Ste, Chapter VI] into cubes with side length $1 / 8$ as large), so that the boxes in $\mathcal{W}$ form a covering of $\Omega$ with non-overlapping interiors, and which satisfy

$$
\begin{equation*}
4 \operatorname{diam}(I) \leq \operatorname{dist}(4 I, \partial \Omega) \leq \operatorname{dist}(I, \partial \Omega) \leq 40 \operatorname{diam}(I) \tag{6.7}
\end{equation*}
$$

Let $X(I)$ denote the center of $I$, let $\ell(I)$ denote the side length of $I$, and write $k=k_{I}$ if $\ell(I)=2^{-k}$. We will use "boxes" to refer to the Whitney cubes as just constructed, and "cubes" for the dyadic cubes on $\partial \Omega$. Then for each pair $I, J \in \mathcal{W}$,

$$
\begin{equation*}
\text { if } I \cap J \neq \emptyset \text {, then } 4^{-1} \leq \frac{\ell(I)}{\ell(J)} \leq 4 \text {. } \tag{6.8}
\end{equation*}
$$

Since $I, J$ are dyadic boxes, then $I \cap J$ is either contained in a face of $I$, or contained in a face of $J$. By choosing $\tau_{0}<2^{-10}$ sufficiently small (depending on $n$ ), we may also suppose that there is $t \in\left(\frac{1}{2}, 1\right)$ so that if $0<\tau<\tau_{0}$, for every distinct pair $I, J \in \mathcal{W}(\Omega)$,

$$
\begin{equation*}
(1+4 \tau) I \cap(1+4 \tau) J \neq \emptyset \Longleftrightarrow I \cap J \neq \emptyset ; \tag{6.9}
\end{equation*}
$$

and

$$
\begin{equation*}
t J \cap(1+4 \tau) I=\emptyset . \tag{6.10}
\end{equation*}
$$

Also, $J \cap(1+\tau) I$ contains an $(n-1)$-dimensional cube with side length of the order of $\min \{\ell(I), \ell(J)\}$. This observation will become useful in Section 9 . For such $\tau \in\left(0, \tau_{0}\right)$ fixed, we write $I^{*}=(1+\tau) I, I^{* *}=(1+2 \tau) I$, and $I^{* *}=(1+4 \tau) I$ for the "fattening" of $I \in \mathcal{W}$.

Following [HM1, Section 3] we next introduce the notion of Carleson region and discretized sawtooth. Given a cube $Q \in \mathbb{D}$, the discretized Carleson region $\mathbb{D}_{Q}$ relative to $Q$ is defined by

$$
\mathbb{D}_{Q}=\left\{Q^{\prime} \in \mathbb{D}: Q^{\prime} \subset Q\right\} .
$$

Let $\mathcal{F}$ be family of disjoint cubes $\left\{Q_{j}\right\} \subset \mathbb{D}$. The global discretized sawtooth region relative to $\mathcal{F}$ is the collection of cubes $Q \in \mathbb{D}$ that are not contained in any $Q_{j} \in \mathcal{F}$;

$$
\mathbb{D}_{\mathcal{F}}:=\mathbb{D} \backslash \bigcup_{Q_{j} \in \mathcal{F}} \mathbb{D}_{Q_{j}} .
$$

For a given $Q \in \mathbb{D}$ the local discretized sawtooth region relative to $\mathcal{F}$ is the collection of cubes in $\mathbb{D}_{Q}$ that are not in contained in any $Q_{j} \in \mathcal{F}$;

$$
\begin{equation*}
\mathbb{D}_{\mathcal{F}, Q}:=\mathbb{D}_{Q} \backslash \bigcup_{Q_{j} \in \mathcal{F}} \mathbb{D}_{Q_{j}}=\mathbb{D}_{\mathcal{F}} \cap \mathbb{D}_{Q} . \tag{6.11}
\end{equation*}
$$

We also introduce the "geometric" Carleson and sawtooth regions. For any dyadic cube $Q \in \mathbb{D}$, pick two parameters $\eta \ll 1$ and $K \gg 1$, and define

$$
\begin{equation*}
\mathcal{W}_{Q}^{0}:=\left\{I \in \mathcal{W}: \eta^{\frac{1}{4}} \ell(Q) \leq \ell(I) \leq K^{\frac{1}{2}} \ell(Q), \operatorname{dist}(I, Q) \leq K^{\frac{1}{2}} \ell(Q)\right\} . \tag{6.12}
\end{equation*}
$$

Taking $K \geq 40^{2} n$, if $I \in \mathcal{W}$ and we pick $Q_{I} \in \mathbb{D}$ so that $\ell\left(Q_{I}\right)=\ell(I)$ and $\operatorname{dist}(I, \partial \Omega)=$ $\operatorname{dist}\left(I, Q_{I}\right)$, then $I \in \mathcal{W}_{Q_{I}}^{0}$. Let $X_{Q}$ denote a corkscrew point for the surface ball $\Delta\left(x_{Q}, r_{Q} / 2\right)$. We can guarantee that $X_{Q}$ is in some $I \in \mathcal{W}_{Q}^{0}$ provided we choose $\eta$ small enough and $K$ large enough. For each $I \in \mathcal{W}_{Q}^{0}$, there is a Harnack chain connecting $X(I)$ to $X_{Q}$, we call it $\mathcal{H}_{I}$. By the definition of $\mathcal{W}_{Q}^{0}$ we may construct this Harnack chain so that it consists of a bounded number of balls (depending on the values of $\eta, K$ ). We let $\mathcal{W}_{Q}$ denote the set of all $J \in \mathcal{W}$ which meet at least one of the Harnack chains $\mathcal{H}_{I}$, with $I \in \mathcal{W}_{Q}^{0}$, i.e.

$$
\begin{equation*}
\mathcal{W}_{Q}:=\left\{J \in \mathcal{W}: \text { there exists } I \in \mathcal{W}_{Q}^{0} \text { for which } \mathcal{H}_{I} \cap J \neq \emptyset\right\} \tag{6.13}
\end{equation*}
$$

Clearly $\mathcal{W}_{Q}^{0} \subset \mathcal{W}_{Q}$. Besides, it follows from the construction of the augmented collections $\mathcal{W}_{Q}$ and the properties of the Harnack chains that there are uniform constants $c$ and $C$ such that

$$
\begin{equation*}
c \eta^{\frac{1}{2}} \ell(Q) \leq \ell(I) \leq C K^{\frac{1}{2}} \ell(Q), \quad \operatorname{dist}(I, Q) \leq C K^{\frac{1}{2}} \ell(Q) \tag{6.14}
\end{equation*}
$$

for any $I \in \mathcal{W}_{Q}$. In particular once $\eta, K$ are fixed, for any $Q \in \mathbb{D}$ the cardinality of $\mathcal{W}_{Q}$ is uniformly bounded. Finally, for every $Q$ we define its associated Whitney region

$$
\begin{equation*}
U_{Q}:=\bigcup_{I \in \mathcal{W}_{Q}} I^{*} \tag{6.15}
\end{equation*}
$$

We refer the reader to [HM1, Section 3] or [HMM2, Section 2] for additional details.
For a given $Q \in \mathbb{D}$, the Carleson box relative to $Q$ is defined by

$$
\begin{equation*}
T_{Q}:=\operatorname{int}\left(\bigcup_{Q^{\prime} \in \mathbb{D}_{Q}} U_{Q^{\prime}}\right) \tag{6.16}
\end{equation*}
$$

For a given family $\mathcal{F}$ of disjoint cubes $\left\{Q_{j}\right\} \subset \mathbb{D}$ and a given $Q \in \mathbb{D}$ we define the local sawtooth region relative to $\mathcal{F}$ by

$$
\Omega_{\mathcal{F}, Q}:=\operatorname{int}\left(\bigcup_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}} U_{Q^{\prime}}\right)=\operatorname{int}\left(\bigcup_{I \in \mathcal{W}_{\mathcal{F}, Q}} I^{*}\right)
$$

where $\mathcal{W}_{\mathcal{F}, Q}:=\bigcup_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}} \mathcal{W}_{Q^{\prime}}^{*}$. Analogously, we can slightly fatten the Whitney boxes and use $I^{* *}$ to define new fattened Whitney regions and sawtooth domains. More precisely,

$$
\begin{equation*}
T_{Q}^{*}:=\operatorname{int}\left(\bigcup_{Q^{\prime} \in \mathbb{D}_{Q}} U_{Q^{\prime}}^{*}\right), \quad \Omega_{\mathcal{F}, Q}^{*}:=\operatorname{int}\left(\bigcup_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}} U_{Q^{\prime}}^{*}\right), \quad U_{Q^{\prime}}^{*}:=\bigcup_{I \in \mathcal{W}_{Q^{\prime}}^{*}} I^{* *} \tag{6.17}
\end{equation*}
$$

Similarly, we can define $T_{Q}^{* *}, \Omega_{\mathcal{F}, Q}^{* *}$ and $U_{Q}^{* *}$ by using $I^{* * *}$ in place of $I^{* *}$.
One can easily see that there is a constant $\kappa_{0}>0$ (depending only on the allowable parameters, $\eta$, and $K$ ) so that

$$
\begin{equation*}
T_{Q} \subset T_{Q}^{*} \subset T_{Q}^{* *} \subset \overline{T_{Q}^{* *}} \subset \kappa_{0} B_{Q} \cap \bar{\Omega}=: B_{Q}^{*} \cap \bar{\Omega}, \quad \forall Q \in \mathbb{D} \tag{6.18}
\end{equation*}
$$

Given a pairwise disjoint family $\mathcal{F} \subset \mathbb{D}$ (we also allow $\mathcal{F}$ to be the null set) and a constant $\rho>0$, we derive another family $\mathcal{F}(\rho) \subset \mathbb{D}$ from $\mathcal{F}$ as follows. Augment $\mathcal{F}$ by adding cubes
$Q \in \mathbb{D}$ whose side length $\ell(Q) \leq \rho$ and let $\mathcal{F}(\rho)$ denote the corresponding collection of maximal cubes with respect to the inclusion. Note that the corresponding discrete sawtooth region $\mathbb{D}_{\mathcal{F}(\rho)}$ is the union of all cubes $Q \in \mathbb{D}_{\mathcal{F}}$ such that $\ell(Q)>\rho$. For a given constant $\rho$ and a cube $Q \in \mathbb{D}$, let $\mathbb{D}_{\mathcal{F}(\rho), Q}$ denote the local discrete sawtooth region and let $\Omega_{\mathcal{F}(\rho), Q}$ denote the local geometric sawtooth region relative to disjoint family $\mathcal{F}(\rho)$.

Given $Q \in \mathbb{D}$ and $0<\epsilon<1$, if we take $\mathcal{F}_{0}=\emptyset$, one has that $\mathcal{F}_{0}(\epsilon \ell(Q))$ is the collection of $Q^{\prime} \in \mathbb{D}$ such that $\epsilon \ell(Q) / 2<\ell\left(Q^{\prime}\right) \leq \epsilon \ell(Q)$. We then introduce $U_{Q, \epsilon}=\Omega_{\mathcal{F}_{0}(\epsilon \ell(Q)), Q}$, which is a Whitney region relative to $Q$ whose distance to $\partial \Omega$ is of the order of $\epsilon \ell(Q)$. For later use, we observe that given $Q_{0} \in \mathbb{D}$, the sets $\left\{U_{Q, \epsilon}\right\}_{Q \in \mathbb{D}_{Q_{0}}}$ have bounded overlap with constant that may depend on $\epsilon$. Indeed, suppose that there is $X \in U_{Q, \epsilon} \cap U_{Q^{\prime}, \epsilon}$ with $Q$, $Q^{\prime} \in \mathbb{D}_{Q_{0}}$. By construction $\ell(Q) \approx_{\epsilon} \delta(X) \approx_{\epsilon} \ell\left(Q^{\prime}\right)$ and

$$
\operatorname{dist}\left(Q, Q^{\prime}\right) \leq \operatorname{dist}(X, Q)+\operatorname{dist}\left(X, Q^{\prime}\right) \lesssim_{\epsilon} \ell(Q)+\ell\left(Q^{\prime}\right) \approx_{\epsilon} \ell(Q)
$$

The bounded overlap property follows then at once.
Lemma 6.19 ([HM1, Lemma 3.61]). Let $\Omega \subset \mathbb{R}^{n}$ be a uniform domain with Ahlfors regular boundary. Then all of its Carleson boxes $T_{Q}$ and sawtooth domains $\Omega_{\mathcal{F}, Q}, \Omega_{\mathcal{F}, Q}^{*}$ are uniform domains with Ahlfors regular boundaries. In all the cases the implicit constants are uniform, and depend only on dimension and on the corresponding constants for $\Omega$.

We say that $\mathbb{P}$ is a fundamental chord-arc subdomain of $\Omega$ if there is $I \in \mathcal{W}$ and $m_{1}$ such that

$$
\begin{equation*}
\mathbb{P}=\operatorname{int}\left(\bigcup_{j=1}^{m_{1}} I_{j}^{*}\right) \text { where } I_{j} \in \mathcal{W} \text { and } I \cap I_{j} \neq \emptyset . \tag{6.20}
\end{equation*}
$$

Note that the fact that $I \cap I_{j} \neq \emptyset$ ensures that $\ell(I) \approx \ell\left(I_{j}\right)$. Moreover $\mathbb{P}$ is a chord-arc domain with constants that only depend on $n, \tau$ and the constants used in the construction of $\mathbb{D}$ and $\mathcal{W}$ (see [HMU, Lemma 2.47] for a similar argument).

Given a sequence of non-negative numbers $\alpha=\left\{\alpha_{Q}\right\}_{Q \in \mathbb{D}}$ we define the associated discrete "measure" $m=m_{\alpha}$ :

$$
\begin{equation*}
m\left(\mathbb{D}^{\prime}\right):=\sum_{Q \in \mathbb{D}^{\prime}} \alpha_{Q}, \quad \mathbb{D}^{\prime} \subset \mathbb{D} \tag{6.21}
\end{equation*}
$$

Definition 6.22. Let $E \subset \mathbb{R}^{n}$ be an Ahlfors regular set, and let $\sigma$ be a dyadically doubling Borel measure on $E$ (not necessarily equal to $\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$ ). We say that $m$ as defined in (6.21) is a discrete Carleson measure with respect to $\sigma$, if

$$
\begin{equation*}
\|m\|_{C}:=\sup _{Q \in \mathbb{D}} \frac{m\left(\mathbb{D}_{Q}\right)}{\sigma(Q)}<\infty . \tag{6.23}
\end{equation*}
$$

Also, fixed $Q_{0} \in \mathbb{D}$ we say that $m$ is a discrete Carleson measure with respect to $\sigma$ in $Q_{0}$ if

$$
\begin{equation*}
\|m\|_{C\left(Q_{0}\right)}:=\sup _{Q \in \mathbb{D}_{Q_{0}}} \frac{m\left(\mathbb{D}_{Q}\right)}{\sigma(Q)}<\infty . \tag{6.24}
\end{equation*}
$$

## 7. Proof by extrapolation

In this section we present some powerful tools which will be key in the proof of our main result. After that we outline the roadmap to pass from the small constant case to the large constant case and thus finish proving Theorem 1.6.

We start with [HMM1, Lemma 4.5], an extrapolation for Carleson measure result which in a nutshell describes how the relationship between a discrete Carleson measure $m$ and another discrete measure $\widetilde{m}$ yields information about $\widetilde{m}$.

Theorem 7.1 (Extrapolation, [HMM1, Lemma 4.5]). Let $\sigma$ be a dyadically doubling Borel measure on $\partial \Omega$ (not necessarily equal to $\left.\mathcal{H}^{n-1}\right|_{\partial \Omega}$ ), and let $m$ be a discrete Carleson measure with respect to $\sigma$ (defined as in (6.21) and Definition 6.22), with constant $M_{0}$, that is

$$
\begin{equation*}
\|m\|_{C}:=\sup _{Q \in \mathbb{D}} \frac{m\left(\mathbb{D}_{Q}\right)}{\sigma(Q)} \leq M_{0} \tag{7.2}
\end{equation*}
$$

Let $\widetilde{m}$ be another discrete non-negative measure on $\mathbb{D}$ defined as in (6.21), by

$$
\tilde{m}\left(\mathbb{D}^{\prime}\right):=\sum_{Q \in \mathbb{D}^{\prime}} \beta_{Q}, \quad \mathbb{D}^{\prime} \subset \mathbb{D}
$$

Assume there is a constant $M_{1}$ such that

$$
\begin{equation*}
0 \leq \beta_{Q} \leq M_{1} \sigma(Q) \text { for any } Q \in \mathbb{D} \tag{7.3}
\end{equation*}
$$

and that there is a positive constant $\gamma$ such that for every $Q \in \mathbb{D}$ and every family of pairwise disjoint dyadic subcubes $\mathcal{F}=\left\{Q_{j}\right\} \subset \mathbb{D}_{Q}$ verifying

$$
\begin{equation*}
\left\|m_{\mathcal{F}}\right\|_{C(Q)}:=\sup _{Q^{\prime} \in \mathbb{D}_{Q}} \frac{m\left(\mathbb{D}_{\mathcal{F}}, Q^{\prime}\right)}{\sigma\left(Q^{\prime}\right)} \leq \gamma \tag{7.4}
\end{equation*}
$$

we have that $\tilde{m}$ satisfies

$$
\begin{equation*}
\widetilde{m}\left(\mathbb{D}_{\mathcal{F}}, Q\right) \leq M_{1} \sigma(Q) \tag{7.5}
\end{equation*}
$$

Then $\widetilde{m}$ is a discrete Carleson measure, with

$$
\begin{equation*}
\|\widetilde{m}\|_{C}:=\sup _{Q \in \mathbb{D}} \frac{\widetilde{m}\left(\mathbb{D}_{Q}\right)}{\sigma(Q)} \leq M_{2} \tag{7.6}
\end{equation*}
$$

for some $M_{2}<\infty$ depending on $n, M_{0}, M_{1}, \gamma$ and the doubling constant of $\sigma$.
Theorem 7.7 ([HMM1], [GMT]). Let $\mathcal{D}$ be an open set satisfying an interior corkscrew condition with Ahlfors regular boundary. Then the following are equivalent:
(a) $\partial \mathcal{D}$ is uniformly rectifiable.
(b) There exists a constant $C$ such that for every bounded harmonic function $u$ in $\mathcal{D}$, i.e. $-\Delta u=0$ in $\mathcal{D}$, and for any $x \in \partial \mathcal{D}$ and $0<r \lesssim \operatorname{diam}(\mathcal{D})$, there hold

$$
\begin{equation*}
\frac{1}{r^{n-1}} \iint_{B(x, r) \cap \mathcal{D}}|\nabla u(Y)|^{2} \operatorname{dist}(Y, \partial \mathcal{D}) d Y \leq C\|u\|_{\infty}^{2} \tag{7.8}
\end{equation*}
$$

Remark 7.9. Condition (7.8) is sometimes referred to as the Carleson measure estimate (CME) for bounded, harmonic functions.

The direction (a) $\Longrightarrow(b)$ is proved by the first three authors of the present paper [HMM1, Theorem 1.1], and the converse direction is proved by Garnett, Mourgoglou, and Tolsa [GMT, Theorem 1.1]. As we have noted above, see Theorem 1.1, under the uniform domain assumption, the statements (a) and/or (b) are equivalent to the fact that $\mathcal{D}$ is a chord-arc domain.

The proof of Theorem 1.6 is rather involved thus we sketch below the plan of the proof.
Proof of Theorem 1.6. We first reduce matters to the case on which $\mathcal{A}$ is symmetric. To do so we observe that by [CHMT, Theorem 1.6], under the assumptions (H1) and (H2), if $\omega_{L} \in A_{\infty}(\sigma)$ then $\omega_{L}$ sym $\in A_{\infty}(\sigma)$ where $L^{\text {sym }}=-\operatorname{div}\left(\mathcal{A}^{\text {sym }} \nabla\right)$ and $\mathcal{A}^{\text {sym }}=\left(\frac{a_{i j}+a_{j i}}{2}\right)_{i, j=1}^{n}$ is the symmetric part of $\mathcal{A}$. Note that, clearly, $\mathcal{A}^{\text {sym }}$ is a symmetric uniformly elliptic matrix in $\Omega$ with the same ellipticity constants as $\mathcal{A}$. It also satisfies (H1) and (H2) with constants which are controlled by those of $\mathcal{A}$. Hence we only need to show (1) $\Longrightarrow$ (2) for $L^{\text {sym }}$ which is associated to the symmetric matrix $\mathcal{A}^{\text {sym }}$. That is, we may assume to begin with, and we do so, that $\mathcal{A}$ is symmetric.

Our main goal is to use the above extrapolation theorem with $m$ and $\widetilde{m}$ two discrete measures associated respectively with the sequences $\alpha=\left\{\alpha_{Q}\right\}_{Q \in \mathbb{D}}$ and $\beta=\left\{\beta_{Q}\right\}_{Q \in \mathbb{D}}$ defined by

$$
\begin{equation*}
\alpha_{Q}:=\iint_{U_{Q}^{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y, \quad \beta_{Q} ;=\iint_{U_{Q}}|\nabla u(Y)|^{2} \delta(Y) d Y, \tag{7.10}
\end{equation*}
$$

where $u$ is an arbitrary bounded, harmonic function in $\Omega$, such that $\|u\|_{L^{\infty}(\Omega)} \leq 1$; and $U_{Q}$ and $U_{Q}^{*}$ are as defined in (6.15) and (6.17) respectively. We would like to observe that by the interior Caccioppoli inequality, $\beta_{Q}$ clearly satisfies the assumption (7.3):

$$
\begin{aligned}
\beta_{Q}=\iint_{U_{Q}}|\nabla u(Y)|^{2} \delta(Y) d Y \lesssim \sum_{I \in \mathcal{W}_{Q}} \ell(I) & \iint_{I^{*}}|\nabla u(Y)|^{2} d Y \lesssim \sum_{I \in \mathcal{W}_{Q}} \ell(I)^{-1} \iint_{I^{* *}}|u(Y)|^{2} d Y \\
& \lesssim \ell(Q)^{-1} \iint_{U_{Q}^{*}}|u(Y)|^{2} \delta(Y) d Y \leq \ell(Q)^{n} \approx \sigma(Q),
\end{aligned}
$$

where we have used that (6.14), the bounded overlap of the family $\left\{I^{* *}\right\}_{I \in \mathcal{W}}$, and (6.18). We will take any family of pairwise disjoint dyadic subcubes $\mathcal{F}=\left\{Q_{j}\right\} \subset \mathbb{D}_{Q}$ so that (7.4) holds for sufficiently small $\gamma \in(0,1)$ to be chosen and the goal is to obtain (7.5). To achieve this we will carry out the following steps:

Step 1: We first observe that (7.2) is equivalent to the Carleson measure assumption (H2). This is a simple calculation which uses the fact that the Whitney boxes $I^{* *}$ which form $U_{Q}^{*}$ have finite overlap and the definition of $T_{Q}$ in (6.16), details are left to the reader.

Step 2: Given $\epsilon>0$ we verify that the small Carleson hypothesis (7.4) implies that if $\gamma=$ $\gamma(\epsilon)$ is small enough $\mathcal{A}$ satisfies the small Carleson assumption (with constant $\epsilon$ ) in the sawtooth domain $\Omega_{\mathcal{F}, Q}^{*}$. This is done in Section 8.
Step 3: We verify that under the hypotheses (H1) and (H2), the assumption $\omega \in A_{\infty}(\sigma)$ in $\Omega$ is transferable to any sawtooth domain, in particular, if we write $\omega_{*}$ for the elliptic
measure associated with $L$ in $\Omega_{\mathcal{F}, Q}^{*}$ then $\omega_{*} \in A_{\infty}\left(\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{\mathcal{F}, Q}^{*}}\right)$ and the implicit constants are uniformly controlled by the allowable constants. See Theorem 9.1 and Corollary 9.3.
Step 4: We combine Step 2 and Step 3 with Corollary 1.13 applied to the domain $\Omega_{\mathcal{F}, Q}^{*}$ and obtain that $\Omega_{\mathcal{F}, Q}^{*}$ is a chord-arc domain. More precisely, note first that $\Omega_{\mathcal{F}, Q}^{*}$ is a bounded uniform domain with Ahlfors regular boundary (see Lemma 6.19) and all the implicit constants are uniformly controlled by those of $\Omega$, that is, they do not depend on $Q$ or the family $\mathcal{F}$. Also, Step 3 says that $\omega_{*} \in A_{\infty}\left(\mathcal{H}^{n-1} \mid \partial \Omega_{\mathcal{F}, Q}^{*}\right)$ and the implicit constants are uniformly controlled by the allowable constants. Hence for the parameter $\epsilon$ given by Corollary 1.13 (recall that we have assumed that $\mathcal{A}$ is symmetric), which only depends on the allowable constants and is independent of $Q$ or the family $\mathcal{F}$, we can find the corresponding $\gamma=\gamma(\epsilon)$ from Step 2 so that $\mathcal{A}$ satisfies the small Carleson assumption (with constant $\epsilon$ ) in the sawtooth domain $\Omega_{\mathcal{F}, Q}^{*}$. Thus Corollary 1.13 applied to the domain $\Omega_{\mathcal{F}, Q}^{*}$ yields that $\Omega_{\mathcal{F}, Q}^{*}$ is a chordarc domain with constants that only depend on the allowable constants.
Step 5: We next apply Theorem 7.7 with $\mathcal{D}=\Omega_{\mathcal{F}, Q}^{*}$ to obtain that (7.8) holds with $\mathcal{D}=$ $\Omega_{\mathcal{F}, Q}^{*}$. Seeing that the latter implies (7.5) is not difficult. Indeed, note that any $Y \in \Omega_{\mathcal{F}, Q}$ satisfies $\delta_{*}(Y):=\operatorname{dist}\left(Y, \partial \Omega_{\mathcal{F}, Q}^{*}\right) \approx_{\tau} \delta(Y)$ (here we would like to remind the reader that $\Omega_{\mathcal{F}, Q}$ is comprised of fattened Whiney boxes $I^{*}=(1+\tau) I$ while for $\Omega_{\mathcal{F}, Q}^{*}$ we use the fatter versions $\left.I^{* *}=(1+2 \tau) I\right)$. Thus by (7.8), the fact that $u$ is harmonic and bounded by 1 in $\Omega$, and so in $\Omega_{\mathcal{F}, Q}^{*}$, and a simple covering argument, we can conclude that

$$
\begin{aligned}
\widetilde{m}\left(\mathbb{D}_{\mathcal{F}, Q}\right) \lesssim \iint_{\Omega_{\mathcal{F}, Q}}|\nabla u|^{2} \delta(Y) d Y & \approx \iint_{\Omega_{\mathcal{F}, Q}}|\nabla u|^{2} \delta_{*}(Y) d Y \\
& \lesssim \iint_{\Omega_{\mathcal{F}, Q}^{*}}|\nabla u|^{2} \delta_{*}(Y) d Y \lesssim \operatorname{diam}\left(\Omega_{\mathcal{F}, Q}^{*}\right)^{n-1} \approx \ell(Q)^{n-1} \approx \sigma(Q),
\end{aligned}
$$

which is (7.5).

After all these steps have been carried out the extrapolation for Carleson measures in Theorem 7.1 allows us to conclude that $\widetilde{m}$ is a discrete Carleson measure. In other words, we have proved that any bounded harmonic function in $\Omega$ satisfies (7.8) with $\mathcal{D}=\Omega$. As a result, and by another use of Theorem 7.7 this time with $\mathcal{D}=\Omega$, we derive that $\partial \Omega$ is uniformly rectifiable. This completes the proof of Theorem 1.6 modulo establishing Step 2 and Step 3 and this will be done in the following sections.

Remark 7.11. For convenience, we augment $\mathcal{F}$ by adding all subcubes of $Q$ of length $2^{-N} \ell(Q)$, and let $\mathcal{F}_{N}$ denote the maximal cubes in the resulting augmented collection. Note that for each $N \geq 2$, the sawtooth domain $\Omega_{\mathcal{F}_{N}, Q}$ is compactly contained in $\Omega$ (indeed is $2^{-N} \ell(Q)$-away from $\left.\partial \Omega\right)$. Note that $\mathbb{D}_{\mathcal{F}_{N}, Q} \subset \mathbb{D}_{\mathcal{F}_{N^{\prime}}, Q} \subset \mathbb{D}_{\mathcal{F}, Q}$ for every $2 \leq N \leq N^{\prime}$. In particular, $m_{\mathcal{F}_{N}} \leq m_{\mathscr{F}_{N^{\prime}}} \leq m_{\mathcal{F}}$ and thus
$m_{\mathcal{F}}$ satisfies $(7.4) \Longrightarrow m_{\mathcal{F}_{N}}$ also satisfies the (7.4) with a constant independent of $N$.

We are going to prove Step 2 and Step 3 for the sawtooth domain $\Omega_{\mathcal{F}_{N}, Q}$, with constants independent of $N$. Then by Step 4 and Step 5, we will have

$$
\begin{equation*}
\widetilde{m}\left(\mathbb{D}_{\mathcal{F}_{N}, Q}\right) \leq M_{1} \sigma(Q), \tag{7.12}
\end{equation*}
$$

with a constant $M_{1}$ independent of $N$, and thus (7.5) follows from monotone convergence theorem by letting $N \rightarrow \infty$. To simplify the notations we drop from the index $N$ from now on and write $\mathcal{F}=\mathcal{F}_{N}$ but we keep in mind that the corresponding sawtooth domain $\Omega_{\mathcal{F}, Q}$ is compactly contained in $\Omega$.

## 8. Consequences of the small Carleson hypothesis in the extrapolation theorem.

Set $\Omega_{*}:=\Omega_{\mathcal{F}, Q}^{*}$ and let $\epsilon$ be given. The goal is to see that we can find $\gamma=\gamma(\epsilon) \in(0,1)$ so that (7.4) implies

$$
\begin{equation*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta_{*}(Y) d Y \leq \epsilon r^{n-1}, \tag{8.1}
\end{equation*}
$$

for any $x \in \partial \Omega_{*}$ and any $0<r<\operatorname{diam}\left(\partial \Omega_{*}\right)$. To see this we fix $x \in \partial \Omega_{*}$ and $0<r<$ $\operatorname{diam}\left(\partial \Omega_{*}\right) \approx \ell(Q)$. Using that $\Omega_{*} \subset \Omega$ one has that $\delta_{*}(Y) \leq \delta(Y)$ and therefore (8.1) follows at once from

$$
\begin{equation*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \leq \epsilon r^{n-1} . \tag{8.2}
\end{equation*}
$$

To show (8.2), we let $c \in(0,1)$ be a small constant and $\widetilde{M} \geq 1$ be a large constant to be determined later, depending on the values of $\eta, K$ used in the definition of $\mathcal{W}_{Q}^{0}$ in (6.12). We consider two cases depending on the size of $r$ with respect to $\delta(x)$ for $x \in \partial \Omega^{*}$. Recall that $\Omega_{*}$ is compactly contained in $\Omega$, thus $\delta(x)>0$ for any $x \in \partial \Omega_{*}$.
Case 1. $r \leq c \delta(x)$. Since $x \in \partial \Omega_{*}=\partial \Omega_{\mathcal{F}, Q}^{*}$ there exist $Q_{x} \in \mathbb{D}_{\mathcal{F}, Q}$ and $I_{x} \in \mathcal{W}_{Q_{x}}$ such that $x \in \partial I_{x}^{* *}$. We choose and fix $c$ sufficiently small (depending just on dimension), so that $B(x, r)$ is contained in $2 I_{x}$. We consider two sub-cases. First if $r \leq \gamma^{\frac{1}{n}} \delta(x)$ then we can invoke (H1) to obtain

$$
\begin{align*}
& \iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \leq \iint_{B(x, r) \cap 2 I_{x}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \lesssim \iint_{B(x, r) \cap 2 I_{x}} \delta(Y)^{-1} d Y  \tag{8.3}\\
& \approx \ell\left(I_{x}\right)^{-1} r^{n}
\end{aligned} \begin{aligned}
& \\
& \delta(x)^{-1} r^{n} \\
& \delta \gamma^{\frac{1}{n}} r^{n-1} .
\end{align*}
$$

On the other hand, if $\gamma^{\frac{1}{n}} \delta(x) \leq r$ we note that

$$
B(x, r) \cap \Omega_{*} \subset 2 I_{x} \cap \Omega_{*} \subset \bigcup_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}}\left(U_{Q}^{*} \cap 2 I_{x}\right) .
$$

It is clear that from construction if $U_{Q^{\prime}}^{*} \cap 2 I_{x} \neq \emptyset$ then $\ell\left(Q^{\prime}\right) \approx \ell\left(I_{x}\right) \approx \delta(x)$. Note also that $\#\left\{I \in \mathcal{W}: I \cap 2 I_{x} \neq \emptyset\right\} \lesssim C_{n}$ hence $\#\left\{Q^{\prime} \in \mathbb{D}: U_{Q^{\prime}}^{*} \cap 2 I_{x} \neq \emptyset\right\} \lesssim C_{n, \eta, K}$. Thus, observing that $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q^{\prime}}$ for every $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}$ we obtain from (7.4)

$$
\begin{gather*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \leq \sum_{\substack{Q^{\prime} \in \mathbb{D}_{\mathcal{F}}, Q \\
U_{Q^{*}}^{*}, 22 I_{x} \neq \varnothing}} \iint_{U_{Q}^{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y=\sum_{\substack{Q^{\prime} \in \mathbb{D}_{\mathcal{F}}, Q \\
U_{Q^{\prime}}^{*}, 2 I_{x} \neq \varnothing}} \alpha_{Q^{\prime}}  \tag{8.4}\\
\leq \sum_{\substack{Q^{\prime} \in \mathbb{D}_{\mathcal{F}}, Q \\
U_{Q^{\prime}}^{*}, \cap 2 I_{x} \neq \varnothing}} m\left(\mathbb{D}_{\mathcal{F}}, Q^{\prime}\right) \leq \gamma \sum_{\substack{Q^{\prime} \in \mathbb{D}_{\mathcal{F}}, Q \\
U_{Q^{\prime}}^{*}, 2 I_{x} \neq \varnothing}} \sigma\left(Q^{\prime}\right) \lesssim \gamma \delta(x)^{n-1} \lesssim \gamma^{\frac{1}{n}} r^{n-1} .
\end{gather*}
$$

Case 2. $\widetilde{M}^{-1} \ell(Q)<r<\operatorname{diam}\left(\partial \Omega_{*}\right) \approx \ell(Q)$. This is a trivial case since by construction and (7.4) we obtain

$$
\begin{align*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y & \leq \sum_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}} \iint_{U_{Q^{\prime}}^{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y  \tag{8.5}\\
& =\sum_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}} \alpha_{Q^{\prime}}=m\left(\mathbb{D}_{\mathcal{F}, Q}\right) \leq \gamma \sigma(Q) \approx \gamma \ell(Q)^{n-1} \approx \gamma r^{n-1} .
\end{align*}
$$

Case 3. $c \delta(x)<r \leq \widetilde{M}^{-1} \ell(Q)$. Pick $\hat{x} \in \partial \Omega$ such that $|x-\hat{x}|=\delta(x)$ and note that $B(x, r) \subset B\left(\hat{x},\left(1+c^{-1}\right) r\right)$. Note also that if $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}$ is so that $U_{Q^{\prime}}^{*} \cap B(x, r) \neq \emptyset$ then we can find $I \in \mathcal{W}_{Q^{\prime}}$ and $Y \in I^{* *} \cap B(x, r)$ so that by (6.14)

$$
\eta^{\frac{1}{2}} \ell\left(Q^{\prime}\right) \lesssim \ell(I) \approx \delta(Y) \leq|Y-x|+\delta(x)<\left(1+c^{-1}\right) r .
$$

and for every $y \in Q^{\prime}$

$$
\begin{aligned}
|y-\hat{x}| \leq \operatorname{diam}\left(Q^{\prime}\right)+\operatorname{dist}\left(Q^{\prime}, I\right)+\operatorname{diam}(I)+ & |Y-x|+|x-\hat{x}| \\
& \lesssim K^{\frac{1}{2}} \ell\left(Q^{\prime}\right)+r+\delta(x) \lesssim K^{\frac{1}{2}} \eta^{-\frac{1}{2}}\left(1+c^{-1}\right) r .
\end{aligned}
$$

Consequently, if we write $\widetilde{M}^{\prime}=C K^{\frac{1}{2}} \eta^{-\frac{1}{2}}\left(1+c^{-1}\right)$ and choose $\widetilde{M}>\widetilde{M}^{\prime}$, it follows that $\ell\left(Q^{\prime}\right)<\widetilde{M}^{\prime} r<\ell(Q)$ and $Q^{\prime} \subset \Delta\left(\hat{x}, \widetilde{M}^{\prime} r\right)=: \Delta^{\prime}$.

We can then find a pairwise disjoint family of dyadic cubes $\left\{Q_{k}\right\}_{k=1}^{\widetilde{N}}$ with uniform cardinality $\widetilde{N}$ (depending on $C_{A R}$ and $n$ ) so that $2^{-1} \widetilde{M}^{\prime} r \leq \ell\left(Q_{k}\right)<\widetilde{M}^{\prime} r, Q_{k} \cap \Delta^{\prime} \neq \emptyset$ for every $1 \leq k \leq \widetilde{N}$, and $\Delta^{\prime} \subset \bigcup_{k=1}^{\widetilde{N}} Q_{k}$. Relabeling if necessary, we can assume that there exists $\widetilde{N}^{\prime} \leq \widetilde{N}$ so that $\Delta^{\prime} \cap Q \subset \bigcup_{k=1}^{N^{\prime}} Q_{k}$ and each $Q_{k}$ meets $\Delta^{\prime} \cap Q$ for $1 \leq k \leq \widetilde{N}^{\prime}$. We would like to observe that necessarily $N^{\prime} \geq 1$ since we have shown that $Q^{\prime} \subset \Delta^{\prime}$ for every $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}$ so that $U_{Q^{\prime}}^{*} \cap B(x, r) \neq \emptyset$. Also $Q_{k} \subset Q$ for $1 \leq k \leq \widetilde{N}^{\prime}$ since $\ell\left(Q_{k}\right)<\widetilde{M}^{\prime} r<\ell(Q)$ and $Q_{k}$ meets $Q$. Moreover, for every such a $Q^{\prime}$ we necessarily have $Q^{\prime} \subset Q_{k}$ for some $1 \leq k \leq \widetilde{N}^{\prime}$ since $Q^{\prime} \subset \Delta^{\prime} \cap Q$, hence $Q^{\prime}$ meets some $Q_{k}$ and also $\ell\left(Q^{\prime}\right)<\widetilde{M}^{\prime} r \leq 2 \ell\left(Q_{k}\right)$ which forces $Q^{\prime} \subset Q_{k}$. All these and (7.4) readily imply

$$
\begin{equation*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \leq \sum_{\substack{Q^{\prime} \in \mathbb{D}_{f, Q} \\ U_{Q^{\prime}}^{*} \cap B(x, r) \neq \varnothing}} \iint_{U_{Q^{\prime}}^{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y=\sum_{\substack{Q^{\prime} \in \in \mathbb{D}_{\mathcal{F}}, Q \\ U_{Q^{\prime}}^{*} \cap B(x, r) \neq \varnothing}} \alpha_{Q^{\prime}} \tag{8.6}
\end{equation*}
$$

$$
\leq \sum_{k=1}^{\widetilde{N}^{\prime}} \sum_{\substack{Q^{\prime} \in \mathbb{D}_{\mathcal{F}}, Q \\ Q^{\prime} \subset Q_{k} \subset Q}} \alpha_{Q^{\prime}}=\sum_{k=1}^{\widetilde{N^{\prime}}} \sum_{Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q_{k}}} \alpha_{Q^{\prime}}=\sum_{k=1}^{\widetilde{N}^{\prime}} m\left(\mathbb{D}_{\mathcal{F}}, Q_{k}\right) \leq \gamma \sum_{k=1}^{\widetilde{N}^{\prime}} \sigma\left(Q_{k}\right) \lesssim \gamma r^{n-1} .
$$

Combining what we have obtained in all the cases we see that (8.3), (8.4), (8.5), and (8.6) give, since $0<\gamma<1$, that

$$
\frac{1}{r^{n-1}} \iint_{B(x, r) \cap \Omega_{*}}|\nabla \mathcal{A}(Y)|^{2} \delta(Y) d Y \leq C_{0} \gamma^{\frac{1}{n}}
$$

for some constant $C_{0} \geq 1$ depending on the allowable constants and where we recall that $\gamma$ is at our choice. Hence we just need to pick $\gamma<\left(C_{0}^{-1} \epsilon\right)^{n}$ to conclude as desired (8.2).

## 9. Transference of the $A_{\infty}$ property to sawtooth domains

In this section we show that the $A_{\infty}$ property for the elliptic operator $L$ in $\Omega$ can be transferred to sawtooth subdomains with constants that only depend on the allowable constants. We first work with sawtooth subdomains which are compactly contained in $\Omega$ and then we consider the general case using that interior sawtooth subdomains exhaust general sawtooth domains.

Theorem 9.1. Let $\Omega \subset \mathbb{R}^{n}$ be a uniform domain with Ahlfors regular boundary. Let $\mathcal{A}$ be a symmetric uniformly elliptic matrix on $\Omega$ and $L=-\operatorname{div}(\mathcal{F} \nabla)$. Assume the following two properties:
(1) The elliptic measure $\omega_{L}$ associated with the operator $L$ relative to the domain $\Omega$ is of class $A_{\infty}$ with respect to the surface measure.
(2) For every fundamental chord-arc subdomain $\mathbb{P}$ of $\Omega$, see (6.20), the elliptic measure associated with $L$ relative to the domain $\mathbb{P}$ is also of class $A_{\infty}$ with respect to the surface measure of $\mathbb{P}$, with uniform $A_{\infty}$ constants.

For every $Q \in \mathbb{D}$ and every family of pairwise disjoint dyadic subcubes $\mathcal{F}=\left\{Q_{j}\right\} \subset \mathbb{D}_{Q}$, let $\Omega_{*}=\Omega_{\mathcal{F}, Q}\left(\right.$ or $\left.\Omega_{*}=\Omega_{\mathcal{F}, Q}^{*}\right)$ be the associated sawtooth domain, and $\omega_{*}$ and $\sigma_{*}=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{*}}$ be the elliptic measure for $L$ and the surface measure of $\Omega_{*}$. Then $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$, with the $A_{\infty}$ constants independent of $Q$ and $\mathcal{F}$.

Note that if $\mathcal{A}$ is a non necessarily symmetric matrix satisfying hypotheses (H1) and (H2) in $\Omega$, we can easily verify it also satisfies the Kenig-Pipher condition relative to every fundamental chord-arc subdomain. Indeed, since $\mathbb{P} \subset \Omega$ then $\delta_{\mathbb{P}}(\cdot) \leq \delta(\cdot)$ and (H1) in $\mathbb{P}$ is automatic. On the other hand, let $\mathbb{P}=\operatorname{int}\left(\bigcup_{j=1}^{m_{1}} I_{j}^{*}\right)$ with $I_{j} \in \mathcal{W}$ and $I \cap I_{j} \neq \emptyset$ and take $x \in \partial \mathbb{P}$ and $r \leq \operatorname{diam} \mathbb{P} \lesssim \ell(I)$. Note that (H1) implies $|\nabla \mathcal{A}(Y)|^{2} \lesssim \ell(I)^{-2}$ for every $Y \in \mathbb{P}$ since $\delta(Y) \approx \ell(I)$, hence

$$
\begin{equation*}
\frac{1}{r^{n-1}} \iint_{B(x, r) \cap \mathbb{P}}|\nabla \mathcal{A}(Y)|^{2} \delta_{\mathbb{P}}(Y) d Y \lesssim \frac{1}{r^{n-1} \ell(I)^{2}} \iint_{B(x, r) \cap \mathbb{P}} \delta_{\mathbb{P}}(Y) d Y \lesssim \frac{r^{n+1}}{r^{n-1} \ell(I)^{2}} \lesssim 1 . \tag{9.2}
\end{equation*}
$$

That is, (H1) in $\mathbb{P}$ holds as well. Thus by [KP] (and the slight improvement in [HMT1]), and the fact that chord-arc domains can be approximated by Lipschitz domains, one obtains that the elliptic measure for $L$ relative to $\mathbb{P}$ is also of class $A_{\infty}$ with respect to the surface measure of $\mathbb{P}$ and (2) in the previous result holds. On the other hand, [CHMT, Theorem 1.6] asserts that for any uniform domain $\Omega$, and under the assumptions (H1) and (H2), one has that $\omega_{L} \in A_{\infty}(\sigma)$ if and only if $\omega_{L^{\text {sym }}} \in A_{\infty}(\sigma)$ where $L^{\text {sym }}$ is the operator associated with the symmetric matrix $\mathcal{A}^{\text {sym }}=\left(\frac{a_{i j}+a_{j i}}{2}\right)_{i, j=1}^{n}$. Note that $\mathcal{A}^{\text {sym }}$ is also a uniformly elliptic matrix in $\Omega$ with the same ellipticity constants as $\mathcal{A}$ and satisfies (H1) and (H2) with constants which are controlled by those of $\mathcal{A}$. With all these observations we immediately get the following corollary:

Corollary 9.3. Let $\Omega \subset \mathbb{R}^{n}$ be a uniform domain with Ahlfors regular boundary. Suppose that $\mathcal{A}$ is a (non necessarily symmetric) uniformly elliptic matrix on $\Omega$ satisfying the hypotheses $(\mathrm{H} 1)$ and $(\mathrm{H} 2)$, and that the elliptic measure $\omega_{L}$ associated with the operator $L$ relative to the domain $\Omega$ is of class $A_{\infty}$ with respect to the surface measure. Then the elliptic measure associated with $L$ relative to any sawtooth domain is of class $A_{\infty}$, with uniform constants.

Proof of Theorem 9.1. The proof Theorem 9.1 has several steps. We work with $\Omega_{*}=\Omega_{\mathcal{F}, Q}$ as the proof with $\Omega_{\mathcal{F}, Q}^{*}$ is identical. We first assume that the sawtooth domain $\Omega_{*}=\Omega_{\mathcal{F}, Q}$ is compactly contained in $\Omega$ and show that $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$, with the $A_{\infty}$ constants independent of $Q$ and $\mathcal{F}$. Here we use $\omega_{*}$ to denote the elliptic measure associated with $L$ relative to $\Omega_{*}$.

Under the assumption that $\Omega_{*}$ is compactly contained in $\Omega$, for $Q$ fixed, let $N$ be an integer such that $\operatorname{dist}\left(\Omega_{*}, \partial \Omega\right) \approx 2^{-N} \ell(Q)$. Then $\Omega_{*}$ if formed by a union of fattened Whitney boxes of side length controlled from below by $c 2^{-N} \ell(Q)$ hence $\Omega_{*}$ clearly satisfies a qualitative exterior corkscrew condition, that is, it satisfies the exterior corkscrew condition for surface balls up to a scale of the order of $2^{-N} \ell(Q)$. In the case of the Kenig-Pipher operators, this information alone does not suffice to derive the desired $A_{\infty}$ property, with constant independent of $N$; however this does give us the qualitative absolute continuity $\omega_{*}^{X} \ll \sigma_{*}$ for any $X \in \Omega_{*}$ (since $\Omega_{*}$ is a chord-arc domain with constants depending on $N$ ). Note that Theorem 9.1 is nonetheless written for a more general class and it is not obvious whether we can automatically have the desired absolute continuity. This will be shown in the course of the proof.

Our main task is to then show that $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$ with constants that depend only on the allowable constants. If we write $\mathbf{k}_{*}:=d \omega_{*} / d \sigma_{*}$ for the Radon-Nikodym derivative, by the change of pole formula Lemma 2.32, obtaining $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$, it is equivalent to prove the following: there exists an exponent $p \in(1, \infty)$ and a constant $C$ depending only on the allowable constants such that for any surface ball $\Delta_{*}=B_{*} \cap \partial \Omega_{*}$ centered at $\partial \Omega_{*}$, with radius smaller than the diameter of $\partial \Omega_{*}$, and for $X=X_{\Delta_{*}} \in \Omega_{*} \cap B_{*}$, a corkscrew point relative to $\Delta_{*}$, the following holds

\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \leq C \sigma_{*}\left(\Delta_{*}\right)^{1-p} \tag{9.4}
\end{equation*}
$$

Since $\operatorname{diam}\left(\Omega_{*}\right) \approx \ell(Q)$, it is easy to see by a standard covering argument and Harnack's inequality that it suffices to prove (9.4) for $r_{*} \leq M_{1}^{-1} \ell(Q)$, where $M_{1}$ is a suitably large
fixed constant. By hypothesis (1), $\omega_{L} \in A_{\infty}(\sigma)$, hence it belongs to the reverse Hölder class with some exponent $p_{1}>1$ (see (2.12)). Also, by hypothesis (2) we know that the elliptic measure relative to any fundamental chord-arc subdomain $\mathbb{P}$ satisfies an $A_{\infty}$ condition with respect to the corresponding surface measure with uniform bounds. In turn, there exists $p_{2}>1$ and a uniform constant so that any of these elliptic measures belong to the reverse Hölder class with this exponent $p_{2}$ and with the same uniform constant (see (2.12)). We shall henceforth set $p:=\min \left\{p_{1}, p_{2}\right\}$, and it is for this $p$ that we shall prove (9.4).

To start with the proof, recall that as observed above, $\operatorname{since} \operatorname{dist}\left(\Omega_{*}, \partial \Omega\right) \approx 2^{-N} \ell(Q)$, it follows that all the dyadic cubes $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}$ have length $\ell\left(Q^{\prime}\right) \gtrsim 2^{-N} \ell(Q)$, and the cardinality of $\mathbb{D}_{\mathcal{F}, Q}$ is bounded by a constant $C(N)$. Hence $\Omega_{*}=\Omega_{\mathcal{F}, Q}$ is formed by the finite union of Whitney regions $U_{Q^{\prime}}$ with $Q^{\prime} \in \mathbb{D}_{\mathcal{F}, Q}$ satisfying $\ell\left(Q^{\prime}\right) \gtrsim 2^{-N} \ell(Q)$. In turn each $U_{Q^{\prime}}$ is a polyhedral domain consisting of a finite number of fattened Whitney boxes with side length of the order of $\ell\left(Q^{\prime}\right)$. In particular there exists a finite index set $\mathcal{N}_{*}$ so that

\partial \Omega_{*} \subset \bigcup_{i \in \mathcal{N}_{*}} \partial\left(\left(I^{i}\right)^{*}\right) \cap \partial \Omega_{*}=: \bigcup_{i \in \mathcal{N}_{*}} S_{*}^{i} . \tag{9.5}
\end{equation*}
$$

where $S_{*}^{i} \neq \emptyset$ for each $i \in \mathcal{N}_{*}, \operatorname{int}\left(\left(I^{i}\right)^{*}\right) \subset \Omega_{*}$, and $\ell\left(I^{i}\right) \gtrsim 2^{-N}$. For each $I^{i}$, with $i \in \mathcal{N}_{*}$, we pick $Q^{i} \in \mathbb{D}_{\mathcal{F}, Q}$ such that $\mathcal{W}_{Q^{i}} \ni I^{i}$ (there could be more than one such a $Q^{i}$ in which case we just select one). Note that different $I^{i}$,s may correspond to the same $Q^{i}$, but each $Q^{i}$ may only repeat up to a finitely many times, depending only on the allowable constants. Since $S_{*}^{i}$ is contained in the boundary of a fattened Whitney box $\left(I^{i}\right)^{*}$,

\operatorname{diam}\left(S_{*}^{i}\right) \lesssim \ell\left(I^{i}\right) \approx \ell\left(Q^{i}\right), \text { and } \operatorname{dist}\left(S_{*}^{i}, \partial \Omega\right) \geq \operatorname{dist}\left(\left(I^{i}\right)^{*}, \partial \Omega\right) \approx \ell\left(Q^{i}\right) . \tag{9.6}
\end{equation*}
$$

On the other hand, the fact that $S_{*}^{i} \subset \partial \Omega_{*}$ means that $I^{i}$ intersects some $J^{i} \in \mathcal{W}$ so that if $J^{i} \in$ $\mathcal{W}_{Q^{\prime \prime}}$ then $Q^{\prime \prime} \notin \mathbb{D}_{\mathcal{F}, Q}$. If we pick $\widetilde{Q}^{i} \in \mathbb{D}$ so that $\ell\left(\widetilde{Q}^{i}\right)=\ell\left(J^{i}\right)$ and $\operatorname{dist}\left(J^{i}, \partial \Omega\right)=\operatorname{dist}\left(J^{i}, \widetilde{Q}^{i}\right)$ then as mentioned right below (6.12) we have that $J^{i} \in \mathcal{W}_{\widetilde{Q}^{i}}^{0} \subset \mathcal{W}_{\widetilde{Q}^{i}}$, therefore $\widetilde{Q}^{i} \notin \mathbb{D}_{\mathcal{F}, Q}$. Recalling (6.10) and the comments after it, we know that $t J^{i} \subset \Omega \backslash \Omega_{*}$ and $\partial\left(\left(I^{i}\right)^{*}\right) \cap \partial \Omega_{*}$ contains an $(n-1)$-dimensional ball with radius of the order of $\min \left\{\ell\left(I^{i}\right), \ell\left(J^{i}\right)\right\} \approx \ell\left(I^{i}\right)$. Denote that ( $n-1$ )-dimensional ball by $\Delta_{*}^{i} \subset S_{*}^{i}$. This implies, combined with (9.6), that

r\left(\Delta_{*}^{i}\right) \approx \operatorname{diam}\left(S_{*}^{i}\right) \approx \ell\left(I^{i}\right) \approx \ell\left(Q^{i}\right) \text { and } \operatorname{dist}\left(S_{*}^{i}, \partial \Omega\right) \approx \operatorname{dist}\left(\Delta_{*}^{i}, \partial \Omega\right) \approx \ell\left(I^{i}\right) \approx \ell\left(Q^{i}\right) \tag{9.7}
\end{equation*}
$$

At this stage we consider several cases. In the Base case, see Lemma 9.9, we treat surface balls $\Delta_{*}$ with small radii so that $\Delta_{*}$ is contained in a uniformly bounded union of Whitney cubes of comparable sides. In the case when $\Delta_{*}$ is large we decompose the intersection of $\Delta_{*}$ in small pieces to which the base case can be applied (Step 1). We then put all the local estimates together to obtain a global one (Step 2). This requires Lemma 9.33 and to consider several cases to account for all the small pieces.

Let $\Delta_{*}=B^{*} \cap \partial \Omega_{*} \subset \Omega$, with $B_{*}=B\left(x_{*}, r_{*}\right), x_{*} \in \partial \Omega_{*}$ and $0<r_{*}<\operatorname{diam}\left(\partial \Omega_{*}\right)$. Since $\Omega_{*}$ is a uniform domain (see Lemma 6.19), we can pick $X_{\Delta_{*}} \subset B_{*} \cap \Omega_{*}$, a Corkscrew point relative to $\Delta_{*}$ in $\Omega_{*}$, so that $\delta_{*}(X):=\operatorname{dist}\left(X, \partial \Omega_{*}\right) \approx r_{*}$. Write

\Delta_{*} \subset \bigcup_{i \in \mathcal{N}_{\Delta_{*}}} S_{*}^{i}, \quad \text { where } \mathcal{N}_{\Delta_{*}}:=\left\{i: \in \mathcal{N}_{*}: \Delta_{*} \cap S_{*}^{i} \neq \emptyset\right\} . \tag{9.8}
\end{equation*}
$$

Lemma 9.9 (Base case). Using the notation above we have that $\omega_{*} \ll \sigma_{*}$ in $\partial \Omega_{*}$. Moreover if there exists $i \in \mathcal{N}_{\Delta_{*}}$ such that $r_{*} \leq \frac{\tau}{8} \ell\left(I^{i}\right)$ then

\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X_{\Delta_{*}}}\right)^{p} d \sigma_{*} \lesssim \sigma_{*}\left(\Delta_{*}\right)^{1-p}, \tag{9.10}
\end{equation*}
$$

where $\mathbf{k}_{*}:=d \omega_{*} / d \sigma_{*}, p$ is as above, and the implicit constant only depends on the allowable constants.

Proof. We first claim that

2 \Delta_{*} \subset \bigcup_{\substack{i^{\prime} \in \mathcal{N}_{*} \\ I^{\prime} \cap I^{\prime} \neq \varnothing}} S_{*}^{i^{\prime}} \quad \text { and } \quad 2 B_{*} \cap \Omega_{*} \subset \bigcup_{\substack{i^{\prime} \in \mathcal{N}_{*} \\ I^{\prime} \cap I^{\prime} \neq \varnothing}}\left(I^{i^{\prime}}\right)^{*} . \tag{9.11}
\end{equation*}

In fact, for any $i^{\prime} \in \mathcal{N}_{*}$, if $S_{*}^{i^{\prime}}$ intersects $2 \Delta_{*}$, or if $2 B_{*} \cap \Omega_{*}$ intersects $\left(I^{i^{\prime}}\right)^{*}$, then our current assumption gives

$$

and thus

By the choice of $\tau$, i.e., by (6.9), we then have $I^{i} \cap I^{i^{\prime}} \neq \emptyset$ and the claim is proved. Next, let $m_{1}$ denote the maximal number of Whitney boxes intersecting $I^{i}$. Note that $m_{1}$ only depends on the constructions of the Whitney cubes, hence just on dimension. By relabeling (9.11) we write

Moreover by (9.7), for each $i^{\prime}=1, \ldots, m_{1}$, we have $\operatorname{diam}\left(S_{*}^{i^{\prime}}\right) \approx \ell\left(I^{\prime}\right) \approx \ell\left(I^{i}\right)$. Set then

\mathbb{P}:=\operatorname{int}\left(\bigcup_{i^{\prime}=1}^{m_{1}}\left(I^{i^{\prime}}\right)^{*}\right) \subset \Omega_{*},

which by construction is a fundamental chord-arc subdomain $\mathbb{P}$ of $\Omega$, see (6.20). Note that since $2 B_{*} \cap \Omega_{*}$ is open then (9.12) says that $2 B_{*} \cap \Omega_{*} \subset \mathbb{P}$ and hence $2 B_{*} \cap \Omega_{*}=2 B_{*} \cap \mathbb{P}$. This and the fact that $\Omega_{*}$ and $\mathbb{P}$ are open readily implies that $2 B_{*} \cap \partial \Omega_{*}=2 B_{*} \cap \partial \mathbb{P}$. Moreover, $X_{\Delta_{*}} \in \mathbb{P}$ (since $X \in B_{*} \cap \Omega_{*}$ ) and

\operatorname{dist}\left(X_{\Delta_{*}}, \partial \mathbb{P}\right) \approx \delta_{*}\left(X_{\Delta_{*}}\right) \approx r_{*} \leq \frac{\tau}{8} \ell\left(I^{i}\right) \leq \frac{\tau}{8} \operatorname{diam}(\mathbb{P}) \leq \operatorname{diam}(\mathbb{P}) . \tag{9.13}
\end{equation*}

Let $X_{\mathbb{P}}$ be a Corkscrew point for the domain $\mathbb{P}$, at the scale $\ell\left(I^{i}\right) \approx \operatorname{diam}(\mathbb{P})$, i.e., $X_{\mathbb{P}}$ is a Corkscrew point in $\mathbb{P}$ relative to the surface ball consisting of the entire boundary of $\mathbb{P}$. Thus in particular, $\operatorname{dist}\left(X_{\mathbb{P}}, \partial \mathbb{P}\right) \approx \operatorname{diam}(\mathbb{P}) \geq \frac{8}{\tau} r_{*}$, hence $\operatorname{dist}\left(X_{\mathbb{P}}, \partial \mathbb{P}\right) \geq 2 c_{0} r_{*}$ for some uniform $0<c_{0}<1 / 4$.

Set $u_{1}(\cdot):=G_{*}\left(X_{\mathbb{P}}, \cdot\right)$ and $u_{2}(\cdot):=G_{\mathbb{P}}\left(X_{\mathbb{P}}, \cdot\right)$ in $2 B_{*} \cap \Omega_{*}=2 B_{*} \cap \mathbb{P}$ where $G_{*}$ and $G_{\mathbb{P}}$ are the Green functions for the operator $L$ and for the domains $\Omega_{*}$ and $\mathbb{P}$ respectively, and
where as observed above $X_{\mathbb{P}} \in \mathbb{P} \subset \Omega_{*}$. Fix $y \in \frac{3}{2} B_{*} \cap \partial \Omega_{*}=\frac{3}{2} B_{*} \cap \partial \mathbb{P}$ and note that $B\left(y, c_{0} r_{*}\right) \subset 2 B_{*}$. Note that if $Z \in B\left(y, c_{0} r_{*}\right)$ then

2 c_{0} r_{*} \leq \operatorname{dist}\left(X_{\mathbb{P}}, \partial \mathbb{P}\right) \leq\left|X_{\mathbb{P}}-y\right| \leq\left|X_{\mathbb{P}}-Z\right|+|Z-y|<\left|X_{\mathbb{P}}-Z\right|+c_{0} r_{*}
$$

and $\left|X_{\mathbb{P}}-Z\right|>c_{0} r_{*}$. As a consequence, $B\left(y, c_{0} r_{*}\right) \subset 2 B_{*} \backslash B\left(X_{\mathbb{P}}, c_{0} r_{*}\right)$. Hence, $L u_{1}=0$ and $L u_{2}=0$ in we weak sense in $B\left(y, c_{0} r_{*}\right) \cap \Omega_{*}=B\left(y, c_{0} r_{*}\right) \cap \mathbb{P}$ and both are continuous in $B\left(y, c_{0} r_{*}\right) \cap \overline{\Omega_{*}}=B\left(y, c_{0} r_{*}\right) \cap \overline{\mathbb{P}}$. In particular both vanish continuously in $B\left(y, c_{0} r_{*}\right) \cap \partial \Omega_{*}=$ $B\left(y, c_{0} r_{*}\right) \cap \partial \mathbb{P}$. This means that we can use Lemma 2.26 in $\mathcal{D}=\mathbb{P}$ to obtain that for every $Z \in B\left(y, c_{0} r_{*} / 8\right)$

where $X_{\Delta_{\mathbb{P}}\left(y, c_{0} r_{*} / 2\right)}^{\mathbb{P}}$ is a corkscrew relative to $B\left(y, c_{0} r_{*} / 2\right) \cap \overline{\mathbb{P}}$ for the fundamental chord-arc domain $\mathbb{P}$. On the other hand Lemma 2.35 applied in $\Omega_{*}$ (which is uniform with Ahlfors regular boundary and the implicit constants are uniformly controlled, see Lemma 6.19) and $\mathbb{P}$ (a fundamental chord-arc domain) gives for any $0<s \leq c_{0} r_{*} / 2$

u_{1}\left(X_{\Delta_{*}}^{*}(y, s)\right) \approx \omega_{*}^{X_{\mathbb{P}}}\left(\Delta_{*}(y, s)\right) s^{n-2}, \quad u_{2}\left(X_{\Delta_{\mathbb{P}}(y, s)}^{\mathbb{P}}\right) \approx \omega_{\mathbb{P}}^{X_{\mathbb{P}}}\left(\Delta_{\mathbb{P}}(y, s)\right) s^{n-2} \tag{9.15}

where $X_{\Delta_{*}(y, s)}^{*}$ is the corkscrew point relative to $\Delta_{*}(y, s)=B(y, s) \cap \partial \Omega_{*}$ for the uniform domain $\Omega_{*}, X_{\Delta_{\mathbb{P}}(y, s)}^{\mathbb{P}}$ is the corkscrew point relative to $\Delta_{\mathbb{P}}(y, s)=B(y, s) \cap \partial \mathbb{P}$ for the fundamental chord-arc uniform domain $\mathbb{P}$, and $\omega_{\mathbb{P}}$ stands for the elliptic measure associated with the operator $L$ relative to $\mathbb{P}$. Note that from the definition of corkscrew condition and the fact that $B(y, s) \cap \Omega_{*}=B(y, s) \cap \mathbb{P}$ it follows that $X_{\Delta_{*}(y, s)}^{*}, X_{\Delta_{\mathbb{P}}(y, s)}^{*} \in B(y, s) \cap \Omega_{*}=B(y, s) \cap \mathbb{P}$ and also

Consequently $u_{1}\left(X_{\Delta_{*}(y, s)}^{*}\right) \approx u_{1}\left(X_{\Delta_{\mathbb{P}}(y, s)}^{\mathbb{P}}\right)$ and $u_{1}\left(X_{\Delta_{\mathbb{P}}\left(y, c_{0} r_{*} / 2\right)}^{\mathbb{P}}\right) \approx u_{1}\left(X_{\Delta_{*}\left(y, c_{0} r_{*} / 2\right)}^{*}\right)$. All these, together with (9.14), (9.15), and Lemma 2.28, give for every $0<s \leq c_{0} r_{*} / 8$

& \approx \frac{u_{1}\left(X_{\Delta_{*}\left(y, c_{0} r_{*} / 2\right)}^{*}\right)}{\left.u_{2}\left(X_{\Delta_{\mathbb{P}}\left(y, c_{0} r_{*} / 2\right)}^{\mathbb{P}}\right)\right)} \approx \frac{\omega_{*}}{X_{\Delta_{*}\left(y, c_{0} r_{*} / 2\right)}\left(\Delta_{*}\left(y, c_{0} r_{*} / 2\right)\right)} \omega_{\mathbb{P}}^{X_{\Delta_{\mathbb{P}}\left(y, c_{0} r_{*} / 2\right)}\left(\Delta_{\mathbb{P}}\left(y, c_{0} r_{*} / 2\right)\right)} \approx 1
\end{align*}
$$

With this in hand, we note that since $y \in \Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)=\frac{3}{2} B_{*} \cap \partial \Omega_{*}=\frac{3}{2} B_{*} \cap \partial \mathbb{P}=\Delta_{\mathbb{P}}\left(x_{*}, \frac{3}{2} r_{*}\right)$ and $0<s \leq c_{0} r_{*} / 8$ are arbitrary we can easily conclude, using a Vitali covering argument and the fact that both $\omega_{*}^{X_{\mathbb{P}}}$ and $\omega_{\mathbb{P}}^{X_{\mathbb{P}}}$ are outer regular and doubling in $\Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)=$ $\Delta_{\mathbb{P}}\left(x_{*}, \frac{3}{2} r_{*}\right)$, that $\omega_{*}^{X_{\mathbb{P}}}(F) \approx \omega_{\mathbb{P}}^{X_{\mathbb{P}}}(F)$ for any Borel set $F \subset \Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)=\Delta_{\mathbb{P}}\left(x_{*}, \frac{3}{2} r_{*}\right)$. Hence $\omega_{*}^{X_{\mathbb{P}}} \ll \omega_{\mathbb{P}}^{X_{\mathbb{P}}} \ll \omega_{*}^{X_{\mathbb{P}}}$ in $\Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)=\Delta_{\mathbb{P}}\left(x_{*}, \frac{3}{2} r_{*}\right)$. From hypothesis (2) in Theorem 9.1 we know that $\omega_{\mathbb{P}} \ll \sigma_{\mathbb{P}}:=\left.\mathcal{H}^{n-1}\right|_{\partial \mathbb{P}}$, hence in particular $\omega_{*} \ll \sigma_{*}$ in $\Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)$. This, (9.16), and Lebesgue's differentiation theorem readily imply that

$$
\begin{equation*}
\mathbf{k}_{*}^{X_{\mathbb{P}}}(y) \approx \mathbf{k}_{\mathbb{P}}^{X_{\mathbb{P}}}(y), \quad \text { for } \mathcal{H}^{n-1} \text {-almost all } y \in \Delta_{*}\left(x_{*}, r_{*}\right)=\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right), \tag{9.17}
\end{equation*}
$$

where $\mathbf{k}_{\mathbb{P}}:=d \omega_{\mathbb{P}} / d \sigma_{\mathbb{P}}$ and $\mathbf{k}_{*}:=d \omega_{*} / d \sigma_{\mathbb{P}}$.

We next observe that Lemma 2.32 applied with $\mathcal{D}=\Omega_{*}$ (along with Harnack's inequality for the case $r_{*} \approx \ell\left(I^{i}\right)$ ) and Lebesgue's differentiation theorem yield

\begin{equation*}
\mathbf{k}_{*}^{X_{\Delta_{*}}}(y) \approx \frac{1}{\omega_{*}^{X_{P}}\left(\Delta_{*}\right)} \mathbf{k}_{*}^{X_{P}}(y) \quad \text { for } \sigma_{*} \text {-almost all } y \in \Delta_{*} . \tag{9.18}
\end{equation*}
$$

Since $\mathbb{P}$ is a fundamental chord-arc subdomain $\mathbb{P}$ of $\Omega$, see (6.20), as observed above $\omega_{\mathbb{P}}$ belongs to the reverse Hölder class with exponent $p_{2}>1$ and so with exponent $p=$ $\min \left\{p_{1}, p_{2}\right\}$. We find that since $\sigma_{*}=\sigma_{\mathbb{P}}$ in $\Delta_{*}=\Delta_{*}\left(x_{*}, r_{*}\right)=\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)$

\begin{aligned}
\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X_{\Lambda_{*}}}\right)^{p} d \sigma_{*} \lesssim \frac{1}{\left(\omega_{*}^{X_{\mathbb{P}}}\left(\Delta_{*}\right)\right)^{p}} & \int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X_{\mathbb{P}}}\right)^{p} d \sigma_{*} \approx \frac{\sigma_{\mathbb{P}}\left(\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)\right)}{\left(\omega_{*}^{X_{\mathbb{P}}}\left(\Delta_{*}\right)\right)^{p}} f_{\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)}\left(\mathbf{k}_{\mathbb{P}}^{X_{\mathbb{P}}}\right)^{p} d \sigma_{\mathbb{P}} \\
& \lesssim \frac{\sigma_{\mathbb{P}}\left(\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)\right)}{\left(\omega_{*}^{X_{\mathbb{P}}}\left(\Delta_{*}\right)\right)^{p}}\left(\frac{\omega_{\mathbb{P}}^{X_{\mathbb{P}}}\left(\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)\right)}{\sigma_{\mathbb{P}}\left(\Delta_{\mathbb{P}}\left(x_{*}, r_{*}\right)\right)}\right)^{p} \approx \sigma_{*}\left(\Delta_{*}\right)^{1-p},
\end{aligned}
$$

where we have used (9.18), (9.17), that $\sigma_{*}=\sigma_{\mathbb{P}}$, the reverse Hölder estimate with exponent $p$ for $\mathbf{k}_{\mathbb{P}}$, and that both $\partial \Omega_{*}$ and $\partial \mathbb{P}$ are Ahlfors regular sets with uniform bounds.

To complete our proof we need to see that $\omega_{*} \ll \sigma_{*}$ in $\partial \Omega_{*}$. Let us observe that we have already obtained that $\omega_{*} \ll \sigma_{*}$ in $\Delta_{*}\left(x_{*}, \frac{3}{2} r_{*}\right)$ where $x_{*} \in \partial \Omega_{*}$ is arbitrary and $r_{*} \leq \frac{\tau}{8} \ell\left(I^{i}\right)$ for some $i \in \mathcal{N}_{\Delta_{*}}$. We may cover $\partial \Omega_{*}$ by a finite union of surface balls $\Delta_{*}\left(x_{j}, r_{j}\right)$, with $r_{j}=$ $\frac{2^{-N}}{\bar{M}} \ell(Q)$, where $\widetilde{M}$ is large enough to be chosen, whose cardinality may depend on $N$ and $\widetilde{M}$. Note that for every $i \in \mathcal{N}_{*}$ we have, as observed before, that $\ell\left(I^{i}\right) \gtrsim 2^{-N} \ell(Q)>\frac{8}{\tau} \frac{2^{-N}}{\tilde{M}} \ell(Q)$ if we pick $\widetilde{M}$ large enough. Hence, for every $j$, it follows that $r_{j}<\frac{\tau}{8} \ell\left(I^{i}\right)$ for every $i \in \mathcal{N}_{*}$ and in particular for every $i \in \mathcal{N}_{\Delta_{*}\left(x_{j}, r_{j}\right)}$. Hence the previous argument yields that $\omega_{*} \ll \sigma_{*}$ in $\Delta_{*}\left(x_{j}, \frac{3}{2} r_{j}\right)$ for every $j$ and consequently $\omega_{*} \ll \sigma_{*}$ in $\partial \Omega_{*}$.
Remark 9.19. We would like to emphasize that the fact that $\omega_{*} \ll \sigma_{*}$ in $\partial \Omega_{*}$ is automatic for the Kenig-Pipher operators. In fact as observed above $\Omega_{*}$ is a chord-arc domain and hence $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$ (albeit with constants which may depend on $N$ ). The previous argument proves that the more general hypothesis (2) in Theorem 9.1 also yields $\omega_{*} \ll \sigma_{*}$ in $\partial \Omega_{*}$.

Once the Base case has been established we can focus on proving the $A_{\infty}$ property for the sawtooth. With this goal in mind we fix a surface ball $\Delta_{*}=B_{*} \cap \partial \Omega_{*} \subset \Omega$, with $B_{*}=B\left(x_{*}, r_{*}\right), x_{*} \in \partial \Omega_{*}$ and $0<r_{*}<\operatorname{diam}\left(\partial \Omega_{*}\right)$. Let $X:=X_{\Delta_{*}} \subset B_{*} \cap \Omega_{*}$ be a Corkscrew point relative to $\Delta_{*}$ in $\Omega_{*}$, so that $\delta_{*}(X) \approx r_{*}$. Our goal is to show (9.4). As explained above we may assume that $r_{*} \leq M_{1}^{-1} \ell(Q)$, for some $M_{1}$ large enough to be chosen. The Base case (Lemma 9.9) yields (9.4) when $r_{*}<\frac{\tau}{8} \ell\left(I^{i}\right)$ for some $i \in \mathcal{N}_{\Delta_{*}}$. Hence we may assume from now on that $r_{*} \geq \frac{\tau}{8} \ell\left(I^{i}\right)$ for every $i \in \mathcal{N}_{\Delta_{*}}$.
Step 1. Show that

$$
\begin{equation*}
\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \lesssim \sum_{i \in \mathcal{N}_{\Delta_{*}}} \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma, \tag{9.20}
\end{equation*}
$$

where we recall that $Q^{i} \in \mathbb{D}_{\mathcal{F}, Q}$ is so that $I^{i} \in \mathcal{W}_{Q^{i}}$ for every $i \in \mathcal{N}_{*}$, and where $\mathbf{k}=d \omega_{L} / d \sigma$.

To see this, by (9.8), it suffices to obtain

\begin{equation*}
\int_{S_{*}^{i}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \lesssim \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma \tag{9.21}
\end{equation*}
$$

for each $i \in \mathcal{N}_{\Delta_{*}}$. Fix then such an $i$ and cover $S_{*}^{i}$ by a uniformly bounded number of surface balls centered at $\partial \Omega_{*}$ with small radius $\Delta_{*}^{i, l}=B_{*}^{i, l} \cap \partial \Omega_{*}$ where $S_{*}^{i} \cap \Delta_{*}^{i, l} \neq \emptyset$ and $r\left(\Delta_{*}^{i, l}\right) \approx c \operatorname{diam}\left(S_{*}^{i}\right) \approx c \ell\left(I^{i}\right)$, the constant $c$ is chosen sufficiently small (depending on $\tau$ ), so that $r\left(\Delta_{*}^{i, l}\right) \ll(\tau / 8) \ell\left(I^{i}\right)$. Hence in the present scenario,

$$
\begin{equation*}
\delta_{*}(X) \approx r_{*} \gg r\left(\Delta_{*}^{i, l}\right) \tag{9.22}
\end{equation*}
$$

We further choose $c$ small enough so that

$$
\begin{equation*}
2 \Delta_{*}^{i, l} \subset \bigcup_{\substack{i^{\prime} \in \mathcal{N}_{*} \\ I^{i^{\prime}} \cap I^{i} \neq \varnothing}} S_{*}^{i^{\prime}} \quad \text { and } \quad 2 B_{*}^{i, l} \cap \Omega_{*} \subset \bigcup_{\substack{i^{\prime} \in \mathcal{N}_{*} \\ I^{\prime} \cap I^{i} \neq \varnothing}}\left(I^{i^{\prime}}\right)^{*} \tag{9.23}
\end{equation*}
$$

Note that there are at most a uniformly bounded number of such $i^{\prime}$, for each $l$. In each $\Delta_{*}^{i, l}$ we can use the Base Case, Lemma 9.9, since by construction $r\left(\Delta_{*}^{i, l}\right) \ll(\tau / 8) \ell\left(I^{i}\right)$ and hence (9.10) implies that

\int_{\Delta_{*}^{i, l}}\left(\mathbf{k}_{*}^{X_{*}^{\Delta_{*}^{i, l}}}\right)^{p} d \sigma_{*} \lesssim \sigma_{*}\left(\Delta_{*}^{i, l}\right)^{1-p} \tag{9.24}
\end{equation*}
$$

where $X_{\Delta_{*}^{i, l}}$ is a corkscrew point relative to $\Delta_{*}^{i, l}$ in $\Omega_{*}$. Using Lemma 2.32 applied with $\mathcal{D}=\Omega_{*}$ and Lebesgue's differentiation theorem we have that $\mathbf{k}_{*}^{X}(y) \approx \omega_{*}^{X}\left(\Delta_{*}^{i, l}\right) \mathbf{k}_{*}{ }^{D_{*}^{i, l}}(y)$ for $\sigma_{*}$-a.e. $y \in \Delta_{*}^{i, l}$. As a result, using (9.24)

$$
\begin{align*}
& \int_{\Delta_{*}^{i, l}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \approx\left(\omega_{*}^{X}\left(\Delta_{*}^{i, l}\right)\right)^{p} \int_{\Delta_{*}^{i, l}}\left(\mathbf{k}_{*}^{X} \Delta_{*}^{i, l}\right)^{p} d \sigma_{*} \lesssim\left(\omega_{*}^{X}\left(\Delta_{*}^{i, l}\right)\right)^{p} \sigma_{*}\left(\Delta_{*}^{i, l}\right)^{1-p}  \tag{9.25}\\
&=\sigma_{*}\left(\Delta_{*}^{i, l}\right)\left(\frac{\omega_{*}^{X}\left(\Delta_{*}^{i, l}\right)}{\sigma_{*}\left(\Delta_{*}^{i, l}\right)}\right)^{p} \lesssim \sigma_{*}\left(\Delta_{*}^{i}\right)\left(\frac{\omega_{*}^{X}\left(\Delta_{*}^{i}\right)}{\sigma_{*}\left(\Delta_{*}^{i}\right)}\right)^{p}
\end{align*}
$$

where we used the Ahlfors regularity of $\sigma_{*}$ and the doubling properties of $\omega_{*}$. We claim that

$$
\begin{equation*}
\frac{\omega_{*}^{X}\left(\Delta_{*}^{i}\right)}{\sigma_{*}\left(\Delta_{*}^{i}\right)} \lesssim \frac{\omega^{X}\left(Q^{i}\right)}{\sigma\left(Q^{i}\right)} \tag{9.26}
\end{equation*}
$$

To see this write $u_{1}(Y)=\omega_{*}^{Y}\left(\Delta_{*}^{i}\right)$ and $u_{2}(Y)=\omega^{Y}\left(Q^{i}\right)$ for every $Y \in \Omega_{*}$ and note that $L u_{1}=L u_{2}=0$ in $\Omega_{*} \subset \Omega$. For $Y \in \Delta_{*}^{i} \subset \overline{\Omega_{*}} \subset \Omega$ we have $u_{2}(Y) \gtrsim 1$ by Lemma 2.28 applied in $\mathcal{D}=\Omega$, Harnack's inequality, (9.7), and (6.14). Thus the maximum principle applied in the bounded open set $\Omega_{*}$ yields that $u_{1}(Y) \lesssim u_{2}(Y)$ for every $Y \in \Omega_{*}$, hence in particular for $Y=X$. This and the fact that $\partial \Omega$ and $\partial \Omega_{*}$ are Ahlfors regular (see Lemma 6.19) give at desired (9.26).

Combining (9.25) and (9.26), and using Hölder's inequality and Ahlfors regularity of $\sigma, \sigma_{*}$, we get

\begin{equation*}
\int_{\Delta_{*}^{i, l}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \lesssim \sigma\left(Q^{i}\right)\left(\frac{\omega^{X}\left(Q^{i}\right)}{\sigma\left(Q^{i}\right)}\right)^{p} \lesssim \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma . \tag{9.27}
\end{equation*}
$$

We recall that $S_{*}^{i}$ is covered by a uniformly bounded number of surface balls $\Delta_{*}^{i, l}$. Thus summing in $l$ we conclude (9.21) as desired. This completes Step 1.
Step 2. Study the interaction of the elements of the family $\left\{Q^{i}: i \in \mathcal{N}_{\Delta_{*}}\right\}$.
We first note that for every $i \in \mathcal{N}_{\Delta_{*}}$

\begin{equation*}
\operatorname{dist}\left(\Delta_{*}, Q\right) \leq \operatorname{dist}\left(S_{*}^{i} \cap \Delta_{*}, Q\right) \lesssim \ell\left(Q^{i}\right) \approx \ell\left(I^{i}\right) \lesssim r_{*} \tag{9.28}
\end{equation*}
$$

Pick $\hat{x} \in \bar{Q}$ such that $\operatorname{dist}\left(\hat{x}, \Delta_{*}\right)=\operatorname{dist}\left(Q, \Delta_{*}\right)$. If $\hat{x} \in \bar{Q} \backslash Q$, we replace it by a point, which we call again $\hat{x}$, belonging to $B\left(\hat{x}, r_{*} / 2\right) \cap Q$, so that $\hat{x} \in Q$ and $\operatorname{dist}\left(\hat{x}, \Delta_{*}\right) \lesssim r_{*}$. We claim that there is a large constant $C>1$ such that $Q^{i} \subset \Delta_{1}$ where $\Delta_{1}:=B\left(\hat{x}, C r_{*}\right) \cap \partial \Omega$. Indeed if $y \in Q^{i}$ then

$$
|y-\hat{x}| \leq \operatorname{diam}\left(Q^{i}\right)+\operatorname{dist}\left(Q^{i}, I^{i}\right)+\operatorname{diam}\left(I^{i}\right)+\left|y^{i}-\hat{x}\right| \lesssim r_{*},
$$

where we have picked $y^{i} \in S_{*}^{i} \cap \Delta_{*}$ for each $i \in \mathcal{N}_{\Delta_{*}}$.
Consider next the covering $\Delta_{1} \subset \cup_{k=1}^{N_{1}} P_{k}$, where $N_{1}$ depends on Ahlfors regularity and dimension, and $\left\{P_{k}\right\}_{k=1}^{N_{1}}$ is a pairwise disjoint collection of dyadic cubes on $\partial \Omega$, of the same generation, with length $\ell\left(P_{k}\right) \approx r_{*}$. Since in the present scenario, $\ell\left(Q^{i}\right) \lesssim r_{*}$, we may further suppose that $\ell\left(P_{k}\right) \geq \ell\left(Q^{i}\right)$ for every $i$. Moreover, since we have assumed that $r_{*} \leq M_{1}^{-1} \ell(Q)$, taking $M_{1}$ large enough we may assume that $\ell\left(P_{k}\right) \leq \ell(Q)$ for every $1 \leq k \leq N_{1}$.

Note that

$$
\bigcup_{i \in \mathcal{N}_{\Delta_{*}}} Q^{i} \subset \Delta_{1} \subset \bigcup_{k=1}^{N_{1}} P_{k}
$$

By relabeling if needed, we may assume that there exists $N_{2}, 1 \leq N_{2} \leq N_{1}$, such that $P_{k}$ meets some $Q^{i}, i \in \mathcal{N}_{\Delta_{*}}$, for each $1 \leq k \leq N_{2}$. Hence $\bigcup_{i \in \mathcal{N}_{\Delta_{*}}} Q^{i} \subset \bigcup_{k=2}^{N_{2}} P_{k}$ and, necessarily, $Q^{i} \subset P_{k} \subset Q$, and since $Q^{i} \in \mathbb{D}_{\mathcal{F}, Q}$, it follows that $P_{k} \in \mathbb{D}_{\mathcal{F}, Q}$ for $1 \leq k \leq N_{2}$.

For future reference, we record the following observation. Recall that $X$ is a Corkscrew point relative to $\Delta_{*}=B_{*} \cap \partial \Omega_{*}$, for the domain $\Omega_{*}$; i.e., $X \in B_{*} \cap \Omega_{*}$, with $\delta_{*}(X) \approx r_{*}$. By (9.28) and for every $1 \leq k \leq N_{2}$ if we pick some $i$ so that $Q^{i} \subset P_{k}$ we have

$$
r_{*} \approx \delta_{*}(X) \leq \delta(X) \leq \operatorname{dist}\left(X, P_{k}\right) \leq \operatorname{dist}\left(X, Q^{i}\right) \leq\left|X-x_{*}\right|+2 r_{*}+\operatorname{dist}\left(\Delta_{*}, Q_{i}\right) \lesssim r_{*} \approx \ell\left(P_{k}\right)
$$

Recalling that $X_{P_{k}}$ denotes a corkscrew point relative to the dyadic cube $P_{k}$ we then have that $\delta(X) \approx \ell\left(P_{k}\right) \approx \delta\left(X_{P_{k}}\right)$ and also $\left|X-X_{P_{k}}\right| \lesssim \ell\left(P_{k}\right)$, hence by Harnack's inequality $\omega^{X} \approx \omega^{X_{P_{k}}}$ and eventually $\mathbf{k}^{X} \approx \mathbf{k}^{X_{P_{k}}}, \sigma$-a.e. in $\partial \Omega$. On the other hand, we have already mentioned that hypothesis (1) in Theorem 9.1 says that $\omega \in R H_{p_{1}}(\sigma)$, which clearly implies $\omega \in R H_{p}(\sigma)$ since $p \leq p_{1}$. Note that this reverse Hölder condition is written for surface balls, but it is straightforward to see, using Lemmas 6.1 and 2.37, that the same reverse Hölder estimates hold for any dyadic cube. All these, and the fact that both $\partial \Omega$ and $\partial \Omega_{*}$ are Ahlfors regular (see Lemma 6.19) lead to

\int_{P_{k}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sigma\left(P_{k}\right)\left(\frac{\omega^{X_{P_{k}}\left(P_{k}\right)}}{\sigma\left(P_{k}\right)}\right)^{p} \leq \sigma\left(P_{k}\right)^{1-p} \approx \sigma_{*}\left(\Delta_{*}\right)^{1-p}, \tag{9.29}
\end{equation*}
$$

for each $k$, with uniform implicit constants.

As mentioned above, for every $i \in \mathcal{N}_{*}$, there exists $J^{i} \in \mathcal{W}$ so that $I^{i} \cap J^{i} \neq \varnothing$ and so that if we pick $\widetilde{Q}^{i} \in \mathbb{D}$ with $\ell\left(\widetilde{Q}^{i}\right)=\ell\left(J^{i}\right)$ and $\operatorname{dist}(J, \partial \Omega)=\operatorname{dist}\left(J^{i}, \widetilde{Q}^{i}\right)$ then $\widetilde{Q}^{i} \notin \mathbb{D}_{\mathcal{F}, Q}$. In particular

$$
\begin{equation*}
\ell\left(\widetilde{Q}^{i}\right) \approx \ell\left(Q^{i}\right) \quad \text { and } \quad \operatorname{dist}\left(\widetilde{Q}^{i}, Q^{i}\right) \lesssim \ell\left(Q^{i}\right) . \tag{9.30}
\end{equation*}
$$

By the definition of $\mathbb{D}_{\mathcal{F}, Q}, \widetilde{Q}^{i} \notin \mathbb{D}_{\mathcal{F}, Q}$ means either $\widetilde{Q}^{i} \subset \partial \Omega \backslash Q$, or $\widetilde{Q}^{i} \subset Q_{j}$, for some $Q_{j} \in \mathcal{F}$. Given $1 \leq k \leq N_{2}$, for each $i \in \mathcal{N}_{\Delta_{*}}$, we say $i \in \mathcal{N}_{0}(k)$, if the first case happens, with $Q^{i} \subset P_{k}$; and if the second case happens with $Q_{j} \in \mathcal{F}$, and with $Q^{i} \subset P_{k}$, we say $i \in \mathcal{N}_{j}(k)$. For the second case we remark that

$$
\begin{equation*}
\operatorname{dist}\left(Q_{j}, P_{k}\right) \leq \operatorname{dist}\left(\widetilde{Q}^{i}, Q^{i}\right) \lesssim \ell\left(Q^{i}\right) \leq \ell\left(P_{k}\right) . \tag{9.31}
\end{equation*}
$$

For each $k, 1 \leq k \leq N_{2}$, we set

$$
\mathcal{F}_{1}(k):=\left\{Q_{j} \in \mathcal{F}: \exists i \in \mathcal{N}_{j}(k), \ell\left(Q_{j}\right) \geq \ell\left(P_{k}\right)\right\}
$$

and

$$
\mathcal{F}_{2}(k):=\left\{Q_{j} \in \mathcal{F}: \exists i \in \mathcal{N}_{j}(k), \ell\left(Q_{j}\right)<\ell\left(P_{k}\right)\right\} .
$$

With the previous notation, (9.20), and the fact that $\bigcup_{i \in N_{\Delta *}} Q^{i} \subset \bigcup_{k=2}^{N_{2}} P_{k}$ we obtain

$$
\begin{align*}
\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} & \lesssim  \tag{9.32}\\
\leqslant & \sum_{i \in \mathcal{N}_{\Delta_{*}}} \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma \\
\leq & \sum_{k=1}^{N_{2}}\left(\sum_{i \in \mathcal{N}_{0}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma+\sum_{Q_{j} \in \mathcal{F}} \sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X}\right)^{p} d \sigma\right) \\
\leq & \sum_{k=1}^{N_{2}}\left(\sum_{i \in \mathcal{N}_{0}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma+\sum_{Q_{j} \in \mathcal{F}_{1}(k)} \sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma\right. \\
& \left.+\sum_{Q_{j} \in \mathcal{F}_{2}(k)} \sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma\right),
\end{align*}
$$

where we have used that $\mathbf{k}^{X} \approx \mathbf{k}^{X P_{k}}, \sigma$-a.e. in $\partial \Omega$.
At this stage we need the following lemma. We defer its proof until later.
Lemma 9.33. Let $\mathcal{D}$ be an open set with Ahlfors regular boundary and write $\sigma=\left.\mathcal{H}^{n-1}\right|_{\partial \mathcal{D}}$. Let $Q \in \mathbb{D}=\mathbb{D}(\partial \mathcal{D})$ and suppose that $\mathbb{D}^{\prime} \subset \mathbb{D}$ is such that each $Q^{\prime} \in \mathbb{D}^{\prime}$ satisfies one of the following conditions for some $C_{1} \geq 1$ :

- $Q^{\prime} \subset Q$ and $\operatorname{dist}\left(Q^{\prime}, \partial \Omega \backslash Q\right) \leq C_{1} \ell\left(Q^{\prime}\right)$.
- $Q^{\prime} \cap Q=\emptyset, \ell\left(Q^{\prime}\right) \leq C_{1} \ell(Q)$ and $\operatorname{dist}\left(Q^{\prime}, Q\right) \leq C_{1} \ell\left(Q^{\prime}\right)$.

Then there is a subcollection of distinct cubes $\left\{\widetilde{Q}_{m}\right\}_{m=1}^{N_{2}}$, all of the same generation, with $N_{2}=N_{2}\left(n, C_{A R}, C_{1}\right)$, satisfying $\ell(Q) \leq \ell\left(\widetilde{Q}_{m}\right) \leq C_{2} \ell(Q)$ and $\operatorname{dist}\left(\widetilde{Q}_{m}, Q\right) \leq C_{2} \ell(Q)$, with
$C_{2}=C_{2}\left(n, C_{A R}, C_{1}\right)$, for every $m$, such that for any $s>1$ if $0 \leq h \in L_{\mathrm{loc}}^{s}(\partial \mathcal{D}, \sigma)$ then

$$
\begin{equation*}
\sum_{Q^{\prime} \in \mathbb{D}^{\prime}} \int_{Q^{\prime}} h d \sigma \leq C_{3} \sigma(Q) \sum_{m=1}^{N_{2}}\left(f_{\widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} \tag{9.34}
\end{equation*}
$$

where $C_{3}=C_{3}\left(n, C_{A R}, C_{1}, s\right)$.
As a consequence, if there exists $C_{1}^{\prime}$ so that for each $m, 1 \leq m \leq N_{2}$, there holds

$$
\begin{equation*}
\left(f_{\widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} \leq C_{1}^{\prime} f_{\widetilde{Q}_{m}} h d \sigma \tag{9.35}
\end{equation*}
$$

then

$$
\begin{equation*}
\sum_{Q^{\prime} \in \mathbb{D}^{\prime}} \int_{Q^{\prime}} h d \sigma \leq C_{3}^{\prime} \sum_{m=1}^{N_{2}} \int_{\widetilde{Q}_{m}} h d \sigma \tag{9.36}
\end{equation*}
$$

with $C_{3}^{\prime}=C_{3}^{\prime}\left(n, C_{A R}, C_{1}, s, C_{1}^{\prime}\right)$.
Remark 9.37. It follows from the proof of that if $Q^{\prime} \subset Q$ for all $Q^{\prime} \in \mathbb{D}^{\prime}$ (i.e., we only consider the first case), then there is only one $\widetilde{Q}_{m}$, namely the unique one containing $Q$ satisfying the given conditions.

Remark 9.38. Suppose that we are under the assumptions of the previous result. Assume further that $\mathcal{D}$ is a uniform domain with Ahlfors regular boundary and that $\omega_{L} \in R H_{p}(\sigma)$. Then, if $\mathbf{k}_{L}=d \omega_{L} / d \sigma$ it follows that

$$
\begin{equation*}
\sum_{Q^{\prime} \in \mathbb{D}^{\prime}} \int_{Q^{\prime}}\left(\mathbf{k}_{L}^{X_{Q}}\right)^{p} d \sigma \lesssim \int_{Q}\left(\mathbf{k}^{X_{Q}}\right)^{p} d \sigma \tag{9.39}
\end{equation*}
$$

with an implicit constant depending on the allowable constants of $\mathcal{D}, C_{1}, p$, and the implicit constant in the condition $\omega_{L} \in R H_{p}(\sigma)$.

To see this we recall that from Gehring's Lemma it follows that there exists $s>1$ such that $\omega_{L} \in R H_{p s}(\sigma)$. This, combined with Harnack's inequality, implies that (9.35) holds with $h=\left(\mathbf{k}_{L}^{X_{Q}}\right)^{p}$. As a result (9.36) readily gives (9.39):

& \sum_{Q^{\prime} \in \mathbb{D}^{\prime}} \int_{Q^{\prime}}\left(\mathbf{k}_{L}^{X_{Q}}\right)^{p} d \sigma \lesssim \sum_{m=1}^{N_{2}} \int_{\widetilde{Q}_{m}}\left(\mathbf{k}_{L}^{X_{Q}}\right)^{p} d \sigma \approx \sum_{m=1}^{N_{2}} \int_{\widetilde{Q}_{m}}\left(\mathbf{k}_{L}^{X_{\widetilde{Q}_{m}}}\right)^{p} d \sigma \\
& \lesssim \sum_{m=1}^{N_{2}} \sigma\left(\widetilde{Q}_{m}\right)^{1-p} \lesssim \sigma(Q)^{1-p}
\end{aligned}
$$

where we have used Harnack's inequality (to change the pole of the elliptic measure from $X_{Q}$ to $X_{\widetilde{Q}_{m}}$ and the fact that $N_{2}$ is uniformly bounded).

We will use the previous remark to estimate (9.32). Fixed then $1 \leq k \leq N_{2}$ and we split the proof in three different steps.
Step 2.1. Estimate for $\mathcal{N}_{0}(k)$.

If $i \in \mathcal{N}_{0}(k)$ we have $\widetilde{Q}^{i} \subset \partial \Omega \backslash Q \subset \partial \Omega \backslash P_{k}$ and

$$
\operatorname{dist}\left(Q^{i}, \partial \Omega \backslash P_{k}\right) \leq \operatorname{dist}\left(Q^{i}, \widetilde{Q}^{i}\right) \lesssim \ell\left(Q^{i}\right)
$$

Since $Q^{i} \subset P_{k}$, we may apply Lemma 9.33 to $P_{k}$ and the collection $\mathbb{D}^{\prime}:=\left\{Q^{i}: i \in \mathcal{N}_{0}(k)\right\}$ (note that we are in the first scenario), to obtain by Remark 9.38

\begin{equation*}
\sum_{i \in \mathcal{N}_{0}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \int_{P_{k}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sigma_{*}\left(\Delta_{*}\right)^{1-p} \tag{9.40}
\end{equation*}
$$

where in the last inequality we have used (9.29).
Step 2.2. Estimate for $Q_{j} \in \mathcal{F}_{1}(k)$.
By (9.31), the cardinality of $\mathcal{F}_{1}(k)$ is uniformly bounded. Moreover, for each $Q_{j} \in \mathcal{F}_{1}(k)$ we necessarily have $Q_{j} \cap P_{k}=\emptyset$, since otherwise, the condition $\ell\left(Q_{j}\right) \geq \ell\left(P_{k}\right)$ guarantees that $P_{k} \subset Q_{j}$, and thus $Q^{i} \subset P_{k} \subset Q_{j} \in \mathcal{F}$. This contradicts that $Q^{i} \in \mathbb{D}_{\mathcal{F}, Q}$. On the other hand $Q_{j} \cap P_{k}=\emptyset$ implies $\widetilde{Q}^{i} \subset Q_{j} \subset \partial \Omega \backslash P_{k}$, for each $i \in \mathcal{N}_{j}(k)$. Combined with (9.30), this yields

$$
\operatorname{dist}\left(Q^{i}, \partial \Omega \backslash P_{k}\right) \leq \operatorname{dist}\left(Q^{i}, \widetilde{Q}^{i}\right) \lesssim \ell\left(Q^{i}\right)
$$

Applying Lemma 9.33 to $P_{k}$ and the collection $\mathbb{D}^{\prime}=\left\{Q^{i}: i \in \mathcal{N}_{j}(k)\right\}$ (note that we are in the first scenario), we obtain from (9.39)

$$
\begin{equation*}
\sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \int_{P_{k}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sigma_{*}\left(\Delta_{*}\right)^{1-p}, \tag{9.41}
\end{equation*}
$$

where again we have used (9.29). The above estimate holds for each $Q_{j} \in \mathcal{F}_{1}(k)$, which as uniformly bounded cardinality, hence

$$
\begin{equation*}
\sum_{Q_{j} \in \mathcal{F}_{1}(k)} \sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sigma_{*}\left(\Delta_{*}\right)^{1-p} \tag{9.42}
\end{equation*}
$$

Step 2.3. Estimate for $Q_{j} \in \mathcal{F}_{2}(k)$.
For each $Q_{j} \in \mathcal{F}_{2}(k)$ we claim that

$$
\begin{equation*}
\sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \int_{Q_{j}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma . \tag{9.43}
\end{equation*}
$$

In fact, for each $i \in \mathcal{N}_{j}(k)$, by (9.30) and $\widetilde{Q}^{i} \subset Q_{j}$, we have

$$
\begin{equation*}
\ell\left(Q^{i}\right) \approx \ell\left(\widetilde{Q}^{i}\right) \leq \ell\left(Q_{j}\right) \tag{9.44}
\end{equation*}
$$

Since $Q^{i} \in \mathbb{D}_{\mathcal{F}}, Q$, we either have $Q^{i} \cap Q_{j}=\emptyset$, or $Q_{j} \subsetneq Q^{i}$. In the first case, note that

$$
\left.\operatorname{dist}\left(Q^{i}, Q_{j}\right) \leq \operatorname{dist}\left(Q^{i}, \widetilde{Q}^{i}\right)\right) \lesssim \ell\left(Q^{i}\right)
$$

hence $Q^{i} \cup Q_{j} \subset \Delta\left(x_{Q_{j}}, C \ell\left(Q_{j}\right)\right)$ which $x_{Q_{j}}$ being the center of $Q_{j}$ an a uniform constant $C$. By Lemma 2.32 applied with $\mathcal{D}=\Omega$ (or Harnack's inequality if $\ell\left(Q_{j}\right) \approx \ell\left(P_{k}\right)$ ), Lebesgue's differentiation theorem, Lemma 2.37, and Harnack's inequality one can see that

$$
\mathbf{k}^{X_{P_{k}}}(y) \approx \omega^{X_{P_{k}}}\left(Q_{j}\right) \mathbf{k}^{X_{Q_{j}}}(y), \quad \text { for } \sigma \text {-a.e. } y \in \Delta\left(x_{Q_{j}}, C \ell\left(Q_{j}\right)\right)
$$

This, Lemma 9.33 with $Q_{j}$ and the collection $\mathbb{D}^{\prime}:=\left\{Q^{i}: i \in \mathcal{N}_{j}(k), Q^{i} \cap Q_{j}=\emptyset\right\}$ (we are in the second scenario), and Remark 9.38 lead to

$$
\begin{align*}
& \sum_{\substack{i \in \mathcal{N}_{j}(k) \\
Q^{i} \cap Q_{j}=\varnothing}} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \approx\left(\omega^{X_{P_{k}}}\left(Q_{j}\right)\right)^{p} \sum_{\substack{i \in \mathcal{N}_{j}(k) \\
Q^{i} \cap Q_{j}=\varnothing}} \int_{Q^{i}}\left(\mathbf{k}^{X_{Q_{j}}}\right)^{p} d \sigma  \tag{9.45}\\
& \\
& \quad \lesssim\left(\omega^{X_{P_{k}}}\left(Q_{j}\right)\right)^{p} \int_{Q_{j}}\left(\mathbf{k}^{X_{Q_{j}}}\right)^{p} d \sigma \approx \int_{Q_{j}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma .
\end{align*}
$$

On the other hand, if $Q_{j} \subsetneq Q^{i}$, then (9.44) gives $\ell\left(Q_{j}\right) \approx \ell\left(Q^{i}\right)$, hence the cardinality of $\left\{Q^{i}: i \in \mathcal{N}_{j}(k), Q_{j} \subsetneq Q^{i}\right\}$ is uniformly bounded. On the other hand, by Lemma 2.32 applied with $\mathcal{D}=\Omega$ (or Harnack's inequality if $\ell\left(Q^{i}\right) \approx \ell\left(P_{k}\right)$ ), Lebesgue's differentiation theorem, Lemma 2.37, and Harnack's inequality we readily obtain

$$
\mathbf{k}^{X_{P_{k}}}(y) \approx \omega^{X_{P_{k}}}\left(Q_{j}\right) \mathbf{k}^{X_{Q_{j}}}(y), \quad \text { for } \sigma \text {-a.e. } y \in Q^{i} .
$$

Thus, using Corollary 6.5 we have

\begin{align*}
\sum_{\substack{i \in \mathcal{N}_{j}(k) \\
Q^{i} \supsetneq Q_{j}}} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma & \approx\left(\omega^{X_{P_{k}}}\left(Q_{j}\right)\right)^{p} \sum_{\substack{i \in \mathcal{N}_{j}(k) \\
Q^{i} \supsetneq Q_{j}}} \int_{Q^{i}}\left(\mathbf{k}^{X_{Q_{j}}}\right)^{p} d \sigma  \tag{9.46}\\
& \lesssim\left(\omega^{X_{P_{k}}}\left(Q_{j}\right)\right)^{p} \sum_{\substack{i \in \mathcal{N}_{j}(k) \\
Q^{i} \geq Q_{j}}} \int_{Q_{j}}\left(\mathbf{k}^{X_{Q_{j}}}\right)^{p} d \sigma \\
& \lesssim\left(\omega^{X_{P_{k}}}\left(Q_{j}\right)\right)^{p} \int_{Q_{j}}\left(\mathbf{k}^{X_{Q_{j}}}\right)^{p} d \sigma \\
& \approx \int_{Q_{j}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma .
\end{align*}
$$

The claim (9.43) now follows from (9.45) and (9.46).
To continue, let us recall that for each $Q_{j} \in \mathcal{F}_{2}(k)$,

$$
\ell\left(Q_{j}\right)<\ell\left(P_{k}\right) \quad \text { and } \quad \operatorname{dist}\left(Q_{j}, P_{k}\right) \leqslant \ell\left(P_{k}\right),
$$

where the second inequality is (9.31). Consequently, each $Q_{j} \in \mathcal{F}_{2}(k)$, is contained in some $P \in \mathbf{N}\left(P_{k}\right):=\left\{P \in \mathbb{D}: \ell(P)=\ell\left(P_{k}\right), \operatorname{dist}\left(P, P_{k}\right) \lesssim \ell\left(P_{k}\right)\right\}$ and, clearly, the cardinality of $\mathbf{N}\left(P_{k}\right)$ is uniformly bounded. Recalling that $\mathcal{F}=\left\{Q_{j}\right\}_{j}$ is a pairwise disjoint family of cubes, by (9.43), Corollary 6.5, and (9.29), we arrive at

$$
\begin{align*}
& \sum_{Q_{j} \in \mathcal{F}_{2}(k)} \sum_{i \in \mathcal{N}_{j}(k)} \int_{Q^{i}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sum_{Q_{j} \in \mathcal{F}_{2}(k)} \int_{Q_{j}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma  \tag{9.47}\\
& =\int_{Q_{j} \in \mathcal{F}_{2}(k)} Q_{j}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \leq \sum_{P \in \mathbf{N}\left(P_{k}\right)} \int_{P}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \int_{P_{k}}\left(\mathbf{k}^{X_{P_{k}}}\right)^{p} d \sigma \lesssim \sigma_{*\left(\Delta_{*}\right)^{1-p} .}
\end{align*}
$$

Step 2.4. Final estimate.

We finally combine (9.32) with (9.40), (9.42), and (9.47), and use the fact that $N_{2} \leq N_{1}=$ $N_{1}\left(n, C_{A R}\right)$ to conclude that

\int_{\Delta_{*}}\left(\mathbf{k}_{*}^{X}\right)^{p} d \sigma_{*} \lesssim \sum_{k=1}^{N_{2}} \sigma_{*}\left(\Delta_{*}\right)^{1-p} \lesssim \sigma_{*}\left(\Delta_{*}\right)^{1-p} \tag{9.48}
\end{equation*}
$$

Hence, we have obtained the desired estimate (9.4), and therefore the proof of Theorem 9.1 is complete, provided that the sawtooth domain $\Omega_{*}$ is compactly contained in $\Omega$ and modulo the proof of Lemma 9.33.

To consider the general case we need the following theorem which generalizes [KKPT, Theorem 4.1] and [DJK] (see also [DKP, Zha]):

Theorem 9.49 ([CHMT, Theorem 1.1]). Let $\mathcal{D}$ be uniform domain $\mathcal{D}$ Ahlfors regular boundary, and let $\mathcal{A}$ be a real (non necessarily symmetric) uniformly elliptic matrix on $\mathcal{D}$. The following are equivalent:
(1) The elliptic measure $\omega_{L}$ associated with the operator $L=-\operatorname{div}(\mathcal{A} \nabla)$ is of class $A_{\infty}$ with respect to the surface measure.
(2) Any bounded weak solution to Lu $=0$ satisfies the Carleson measure estimate

$$
\begin{equation*}
\sup _{\substack{x \in \partial \mathcal{D} \\ 0<r<\infty}} \frac{1}{r^{n}} \iint_{B(x, r) \cap \mathcal{D}}|\nabla u(Y)|^{2} \operatorname{dist}(Y, \partial \mathcal{D}) d Y \leq C\|u\|_{L^{\infty}(\mathcal{D})}^{2} \tag{9.50}
\end{equation*}
$$

The involved constants depend on the allowable constants and the constant appearing in the corresponding hypothesis of the implication in question.

Consider next a general sawtooth domain $\Omega_{*}=\Omega_{\mathcal{F}, Q}$ which, although bounded, is not necessarily compactly contained in $\Omega$. By $(2) \Longrightarrow(1)$ in Theorem 9.49 with $\mathcal{D}=\Omega$, in order to obtain that the elliptic measure associated with $L$ relative to $\Omega_{*}$ belongs to $A_{\infty}$ with respect to the surface measure, we just need to see that (2) holds with $\mathcal{D}=\Omega_{*}$. With this goal in mind we take $u$, a bounded weak solution to $L u=0$ in $\Omega_{*}$, and let $x \in \partial \Omega$ and $0<r<\infty$.

Given $N \geq 1$ we recall the definition of $\mathcal{F}_{N}:=\mathcal{F}\left(2^{-N} \ell(Q)\right)$ in Section 6 and write $\Omega_{*}^{N}:=\Omega_{\mathcal{F}_{N}, Q}$. Note that by construction $\ell\left(Q^{\prime}\right)>2^{-N} \ell(Q)$ for every $Q^{\prime} \in \mathbb{D}_{\mathcal{F}_{N}, Q}$, hence $\Omega_{*}^{N}$ is compactly contained in $\Omega$ (indeed is at distance of the order $2^{-N} \ell(Q)$ to $\partial \Omega$ ). Then we can apply the previous case to obtain that for each $N$, the associated elliptic measure associated with $L$ relative to $\Omega_{*}^{N}$ satisfies the $A_{\infty}$ property with respect to the surface measure of $\partial \Omega_{*}^{N}$, and the implicit constants depend only on the allowable constants. Hence (1) $\Longrightarrow(2)$ in Theorem 9.49 with $\mathcal{D}=\Omega_{*}^{N}$ implies

$$
\begin{equation*}
\sup _{\substack{z \in \partial \Omega_{*}^{N} \\ 0<s<\infty}} \frac{1}{s^{n}} \iint_{B(z, s) \cap \Omega_{*}^{N}}|\nabla u(Y)|^{2} \delta_{*}^{N}(Y) d Y \lesssim\|u\|_{L^{\infty}\left(\Omega_{N}^{*}\right)}^{2} \leq C\|u\|_{L^{\infty}\left(\Omega_{*}\right)}^{2} \tag{9.51}
\end{equation*}
$$

since $u$ is a bounded weak solution to $L u=0$ in $\Omega_{*}$ and so in each $\Omega_{N}^{*}$, where $\delta_{*}^{N}=$ $\operatorname{dist}\left(\cdot, \partial \Omega_{*}^{N}\right)$ and where the implicit constants depend only on the allowable constants.

Let $\omega_{*}$ and $\omega_{*}^{N}$ denote the elliptic measures to $L$ relative to $\Omega_{*}$ and $\Omega_{*}^{N}$ respectively, and let $\sigma_{*}^{N}:=\left.\mathcal{H}^{n-1}\right|_{\partial \Omega_{*}^{N}}$ denote the surface measure of $\partial \Omega_{*}^{N}$. By construction $\left\{\Omega_{*}^{N}\right\}_{N \geq 1}$ is an increasing sequence of sets with $\Omega_{*}=\cup_{N \geq 1} \Omega_{*}^{N}$. Hence, for any $Y \in \Omega_{*}$ there is $N_{Y} \geq 1$ such that $Y \in \Omega_{*}^{N}$ for all $N \geq N_{Y}$. Clearly $\delta_{*}^{N}(Y) \nearrow \delta_{*}(Y)$ as $N \rightarrow \infty$ and

$$
|\nabla u(Y)|^{2} \delta_{*}^{N}(Y) \chi_{\Omega_{*}^{N}}(Y) \nearrow|\nabla u(Y)|^{2} \delta_{*}(Y) \chi_{\Omega_{*}}(Y), \quad \text { as } N \rightarrow \infty .
$$

On the other hand since $x \in \partial \Omega_{*}$, using the Corkscrew condition we can find a sequence $\left\{x_{N}\right\}_{N \geq 1}$ with $x_{N} \in \partial \Omega_{*}^{N}$ such that $x_{N} \rightarrow x$. In particular, $B(x, r) \subset B\left(x_{N}, 2 r\right)$ for sufficiently large $N$. By Fatou's Lemma and (9.51) it then follows

$$
\begin{align*}
\iint_{B(x, r) \cap \Omega_{*}}|\nabla u(Y)|^{2} \delta_{*}(Y) d Y & \leq \liminf _{N \rightarrow \infty} \iint_{B(x, r) \cap \Omega_{*}^{N}}|\nabla u(Y)|^{2} \delta_{*}^{N}(Y) d Y  \tag{9.52}\\
& \leq \liminf _{N \rightarrow \infty} \iint_{B\left(x_{N}, 2 r\right) \cap \Omega_{*}^{N}}|\nabla u|^{2} \delta_{*}^{N}(y) d Y \lesssim r^{n}\|u\|_{L^{\infty}\left(\Omega_{*}\right)}^{2},
\end{align*}
$$

where the implicit constant depend only on the allowable constants. Since $x, r$, and $u$ are arbitrary we have obtained as desired (2) in Theorem 9.49 for $\mathcal{D}=\Omega_{*}$ and as a result we conclude that $\omega_{*} \in A_{\infty}\left(\sigma_{*}\right)$. This completes the proof for an arbitrary sawtooth domain $\Omega_{*}$, and therefore the proof of Theorem 9.1 modulo the proof of Lemma 9.33.

Proof of Lemma 9.33. For fixed $k \in \mathbb{Z}$, write $\mathbb{D}_{k}^{\prime}:=\left\{Q^{\prime} \in \mathbb{D}^{\prime}: \ell\left(Q^{\prime}\right)=2^{-k} \ell(Q)\right\}$, which is a pairwise disjoint family. In the first case since $Q^{\prime} \subset Q$, we have that $k \geq 0$; in the second case since $\ell\left(Q^{\prime}\right) \leq C_{2} \ell(Q)$, we may assume that $k \geq-\log _{2} C_{2}$. Set then $k_{0}=0$ in the first case and $k_{0}$ the integer part of $\log _{2} C_{1}$. We define for $k \geq-k_{0}$

$$
A_{k}^{+}=\left\{x \in Q: \operatorname{dist}(x, \partial \Omega \backslash Q) \lesssim 2^{-k} \ell(Q)\right\}, \quad A_{k}^{-}=\left\{x \in \partial \Omega \backslash Q: \operatorname{dist}(x, Q) \lesssim 2^{-k} \ell(Q)\right\},
$$

so that for appropriate choices of the implicit constants, each $Q^{\prime} \in \mathbb{D}_{k}^{\prime}$ is contained in either $A_{k}^{+}$(the first case) or $A_{k}^{-}$(the second case). Recall that by the thin boundary property of the dyadic decomposition $\mathbb{D}$ (cf. (6.2)), there is $\gamma \in(0,1)$ such that for all $k$ under consideration,

$$
\sigma\left(A_{k}^{+}\right) \lesssim 2^{-k \gamma} \sigma(Q), \quad \sigma\left(A_{k}^{-}\right) \lesssim 2^{-k \gamma} \sigma(Q) .
$$

Set

$$
\mathcal{F}_{-}:=\left\{Q^{\prime} \subset \partial \Omega \backslash Q: \ell\left(Q^{\prime}\right) \leq C_{1} \ell(Q), \operatorname{dist}\left(Q^{\prime}, Q\right) \leq C_{1} \ell\left(Q^{\prime}\right)\right\} .
$$

Observe that each $Q^{\prime} \in \mathcal{F}_{-}$is contained in some dyadic cube $\widetilde{Q}$, with $\ell(\widetilde{Q}) \approx \ell(Q)$ and $\operatorname{dist}(\widetilde{Q}, Q) \lesssim \ell(Q)$ depending on $C_{1}$. We may therefore define a collection of distinct cubes $\mathcal{F}_{*}:=\left\{\widetilde{Q}_{m}\right\}_{m=1}^{N_{2}}$, all of the same dyadic generation, one of which (say, $\widetilde{Q}_{1}$ ) contains $Q$, with $\ell\left(\widetilde{Q}_{m}\right) \approx \ell(Q)$, and with $\operatorname{dist}\left(\widetilde{Q}_{m}, Q\right) \lesssim \ell(Q)$ for every $m$, such that each $Q^{\prime} \in \mathcal{F}_{-}$is contained in some $\widetilde{Q}_{m} \in \mathcal{F}_{*}$, and

$$
\bigcup_{k} A_{k}^{+} \subset Q \subset \widetilde{Q}_{1}, \quad \text { and } \quad \bigcup_{k} A_{k}^{-} \subset \bigcup_{m=2}^{N} \widetilde{Q}_{m} .
$$

Clearly, we have $\# \mathscr{F}_{*}=N_{2}=N_{2}\left(n, C_{A R}, C_{1}\right)$. Using all the previous observations we get for any $s>1$

$$
\begin{align*}
\sum_{Q^{\prime} \in \mathbb{D}^{\prime}} \int_{Q^{\prime}} h d \sigma & =\sum_{k=-k_{0}}^{\infty} \sum_{Q^{\prime} \in \mathbb{D}_{k}^{\prime}} \int_{Q^{\prime}} h d \sigma  \tag{9.53}\\
& \leq \sum_{k=-k_{0}}^{\infty} \int_{A_{k}^{+} \cup A_{k}^{-}} h d \sigma \\
& \leq \sum_{k=-k_{0}}^{\infty} \sigma\left(A_{k}^{+} \cup A_{k}^{-}\right)^{1-\frac{1}{s}}\left(\int_{U_{m} \widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} \\
& \lesssim \sum_{k=-k_{0}}^{\infty}\left(2^{-k \gamma} \sigma(Q)\right)^{1-\frac{1}{s}}\left(\int_{U_{m} \widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} \\
& \lesssim \sigma(Q)\left(\sum_{m} f_{\widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} \\
& \lesssim \sigma(Q) \sum_{m}\left(f_{\widetilde{Q}_{m}} h^{s} d \sigma\right)^{\frac{1}{s}} .
\end{align*}
$$

This shows (9.34). To obtain (9.36) we combine (9.53) together with (9.35) and the fact that $\sigma(Q) \approx \sigma\left(Q_{m}\right)$ for every $1 \leq m \leq N_{2}$ by the Ahlfors regular property and the construction of the family $\mathcal{F}_{*}$.

## 10. Optimality

As we mentioned in the introduction, the class of elliptic operators we consider is optimal to guarantee the $A_{\infty}$ property. In this section we illustrate the optimality from two different points of view. See Proposition 10.2 and Theorem 10.7.

As mentioned right after Definition 2.10, one has that $\omega_{L} \in A_{\infty}(\sigma)$ if and only if $\omega_{L} \in$ $R H_{q}(\sigma)$ for some $q>1$ in the following sense: $\omega_{L} \ll \sigma$ and the Radon-Nikodym derivative $\mathbf{k}_{L}:=d \omega_{L} / d \sigma$ satisfies the reverse Hölder estimate (2.12). We can then define the $R H_{q}(\sigma)$ characteristic of $\omega_{L}$ as folows

$$
\begin{equation*}
\left[\omega_{L}\right]_{R H_{q}}:=\sup \left(f_{\Delta^{\prime}}\left(\mathbf{k}_{L}^{A(q, r)}\right)^{q} d \sigma\right)^{\frac{1}{q}}\left(f_{\Delta^{\prime}} \mathbf{k}_{L}^{A(q, r)} d \sigma\right)^{-1}, \tag{10.1}
\end{equation*}
$$

where the sup runs over all $q \in \partial \Omega, 0<r<\operatorname{diam}(\Omega)$, and all surface balls $\Delta^{\prime}=B^{\prime} \cap \partial \Omega$ centered at $\partial \Omega$ with $B^{\prime} \subset B(q, r)$.

The following example, based on the work in [MM] and communicated to us by Bruno Guiseppe Poggi Cevallos, illustrates the relationship between the size of the constant in the DKP condition and the $R H_{q}(\sigma)$-characteristic of elliptic measure.

Proposition 10.2 ([MM, Pog]). There exist $\mathcal{A}$ and a sequence $\left\{\mathcal{A}_{j}\right\}_{j}$ of diagonal elliptic matrices with smooth, bounded, real coefficients in $\mathbb{R}_{+}^{n}$, uniformly continuous on $\overline{\mathbb{R}_{+}^{n}}$, such that $\mathcal{A}_{j}$ converges to $\mathcal{A}$ uniformly on $\overline{\mathbb{R}_{+}^{n}}$ and the following hold:
(1) $\sup _{\substack{q \in \mathbb{R}^{n-1} \\ 0<r<\infty}} \frac{1}{r^{n-1}} \iint_{B(q, r) \cap \mathbb{R}_{+}^{n}}\left(\sup _{Y \in B\left(X, \frac{\delta(x)}{2}\right)}\left|\nabla \mathcal{A}_{j}(Y)\right|^{2} \delta(Y)\right) d X \gtrsim j$.
(2) For each $q>1$, one has $\omega_{j} \in R H_{q}(\sigma)$ with $\lim _{j \rightarrow \infty}\left[\omega_{j}\right]_{R H_{q}}=\infty$, where $\omega_{j}$ denotes the elliptic measure associated with the operator $L_{j}=-\operatorname{div}\left(\mathcal{A}_{j}(\cdot) \nabla\right)$.
(3) The elliptic measure associated with the operator $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ is singular with respect to the Lebesgue measure on $\partial \mathbb{R}_{+}^{n}=\mathbb{R}^{n-1}$.

On the other hand, we can immediately extend Theorem 1.6 to a larger and optimal class of elliptic operators, pertaining to the condition on the oscillation of the coefficient matrix:

Corollary 10.3. Let $\Omega \subset \mathbb{R}^{n}, n \geq 3$, be a uniform domain with Ahlfors regular boundary. Let $\mathcal{A}$ be a (not necessarily symmetric) uniformly elliptic matrix on $\Omega$ such that

$$
\begin{equation*}
\sup _{\substack{q \in \partial \Omega \\ 0<r<\operatorname{diam}(\Omega)}} \frac{1}{r^{n-1}} \iint_{B(q, r) \cap \Omega} \frac{\operatorname{osc}(\mathcal{A}, X)^{2}}{\delta(X)} d X<\infty . \tag{10.4}
\end{equation*}
$$

where $\operatorname{osc}(\mathcal{A}, X):=\sup _{Y, Z \in B(X, \delta(X) / 2)}|\mathcal{A}(Y)-\mathcal{A}(Z)|$. Then the following are equivalent:
(a) The elliptic measure $\omega_{L}$ associated with the operator $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ is of class $A_{\infty}$ with respect to the surface measure.
(b) $\partial \Omega$ is uniformly rectifiable.
(c) $\Omega$ is a chord-arc domain.

Proof. Let $\varphi$ be a non-negative radial, smooth bump function supported in the unit ball, such that $\int_{\mathbb{R}^{n}} \varphi d X=1$. We define for $X \in \Omega$ and $t \in(0, \delta(X))$

$$
P_{t} \mathcal{A}(X):=\varphi_{t} * \mathcal{A}(X)=\iint_{\mathbb{R}^{n}} \frac{1}{t^{n}} \varphi\left(\frac{X-Y}{t}\right) \mathcal{A}(Y) d Y,
$$

and write for $X \in \Omega$

$$
\begin{equation*}
\mathcal{A}(X)=P_{\frac{\delta(X)}{4}} \mathcal{A}(X)+\left(\operatorname{Id}-P_{\frac{\delta(X)}{4}}\right) \mathcal{A}(X)=: \tilde{\mathcal{A}}(X)+(\mathcal{A}(X)-\tilde{\mathcal{A}}(X)) . \tag{10.5}
\end{equation*}
$$

It is easy to see that $\tilde{\mathcal{A}}$ is uniformly elliptic with the same constants as $\mathcal{A}$ and also that for every $X \in \Omega$
(10.6) $\quad|\nabla \widetilde{\mathcal{A}}(X)| \leq C \frac{\operatorname{osc}(\mathcal{A}, X)}{\delta(X)} \quad$ and $\quad \sup _{Y \in B(X, \delta(X) / 4)}|\mathcal{A}(Y)-\widetilde{\mathcal{A}}(Y)| \leq \operatorname{osc}(\mathcal{A}, X)$.

Note that under assumption (10.4), the second estimate in (10.6) allows us to invoke [CHMT, Theorem 1.3] to obtain that $\omega_{L_{\mathcal{A}}} \in A_{\infty}(\sigma)$ if and only if $\omega_{L_{\tilde{\mathcal{A}}}} \in A_{\infty}(\sigma)$. On the other hand, the first estimate in (10.6) readily implies that $\tilde{\mathcal{A}}$ satisfies (H1) and (H2). Hence, Theorem 1.6
applied to $\tilde{\mathcal{A}}$ gives at once the desired equivalences. We remark that the direction $(c) \Longrightarrow$ (a) was also proved earlier in [Rio, Theorem 2.4].

Corollary 10.3 is sharp in terms of the class of operators satisfying (10.4). We recall the following examples that illustrate this fact.

Theorem 10.7. [FKP, Theorem 4.11] Suppose $\alpha$ is a non-negative function defined on $\mathbb{R}_{+}^{2}$ satisfying the doubling condition: $\alpha(X) \leq C \alpha\left(X_{0}\right)$ for any $X_{0} \in \mathbb{R}_{+}^{2}$ and $X \in B\left(X_{0}, \delta\left(X_{0}\right) / 2\right)$. Assume that $\alpha^{2}(x, t) d x d t / t$ is not a Carleson measure in the unit square. Then there exists an elliptic operator $L=-\operatorname{div}(\mathcal{A}(\cdot) \nabla)$ on $\mathbb{R}_{+}^{2}$, such that
(1) For any interval $I \subset \mathbb{R}$ and $T(I)=I \times[0, \ell(I)]$,

$$
\begin{equation*}
\frac{1}{|I|} \iint_{T(I)} \frac{\operatorname{osc}^{2}(\mathcal{A}(x, t))}{t} d x d t \leq C\left[\frac{1}{|I|} \iint_{T(2 I)} \frac{\alpha^{2}(x, t)}{t} d x d t+1\right] \tag{10.8}
\end{equation*}
$$

(2) The elliptic measure $\omega_{L}$ is not of class $A_{\infty}(d x)$ on the unit interval $[0,1]$.

Remarks 10.9. The examples above are constructed using quasi-conformal maps in $\mathbb{R}^{2}$. In [FKP] the authors show the estimate (10.8) holds when $\operatorname{osc}(\mathcal{A},(x, t))$ is replaced by the oscillation of elliptic matrix $\mathcal{A}(X)$ minus the identity matrix, i.e., $a(X):=\sup _{Y \in B(X, \delta(X) / 2)} \mid \mathcal{A}(Y)-$ Id $\mid$. It is easy to see that for those examples (10.8) follows. As in [CFK, Theorem 3], one can extend the 2 dimensional examples to $\mathbb{R}_{+}^{n}$ with $n \geq 3$ by using the Laplacian operator in the remaining tangential directions.
