# Higher order derivative of self-intersection local time for fractional Brownian motion

#### Abstract

We consider the existence and Hölder continuity conditions for the $k$-th order derivatives of selfintersection local time for $d$-dimensional fractional Brownian motion, where $k=\left(k_{1}, k_{2}, \cdots, k_{d}\right)$. Moreover, we show a limit theorem for the critical case with $H=\frac{2}{3}$ and $d=1$, which was conjectured by Jung and Markowsky [7].

## 1 Introduction

Fractional Brownian motion (fBm) on $\mathbb{R}^{d}$ with Hurst parameter $H \in(0,1)$ is a $d$-dimensional centered Gaussian process $B^{H}=\left\{B_{t}^{H}, t \geq 0\right\}$ with covariance function given by

$$
\mathbb{E}\left[B_{t}^{H} B_{s}^{H}\right]=\frac{1}{2}\left[t^{2 H}+s^{2 H}-|t-s|^{2 H}\right] .
$$

Note that $B_{t}^{\frac{1}{2}}$ is a classical standard Brownian motion. Let $D=\{(r, s): 0<r<s<t\}$. The self-intersection local time (SLT) of fBm was first investigated in Rosen [11] and formally defined as

$$
\alpha_{t}(y)=\int_{D} \delta\left(B_{s}^{H}-B_{r}^{H}-y\right) d r d s
$$

where $B^{H}$ is a fBm and $\delta$ is the Dirac delta function. It was further investigated in $\mathrm{Hu}[3], \mathrm{Hu}$ and Nualart [4]. In particular, Hu and Nualart [4] showed its existence whenever $H d<1$. Moreover, $\alpha_{t}(y)$ is Hölder continuous in time of any order strictly less than $1-H$ which can be derived from Xiao [14].

The derivative of self-intersection local time (DSLT) for fBm was first considered in the works by Yan et al. [15] [16], where the ideas were based on Rosen [12]. The DSLT for fBm has two versions. One is extended by the Tanaka formula (see in Jung and Markowsky [7]):

$$

The other is from the occupation-time formula (see Jung and Markowsky [8]):

\widehat{\alpha}_{t}^{\prime}(y)=-\int_{D} \delta^{\prime}\left(B_{s}^{H}-B_{r}^{H}-y\right) d r d s
$$

[^0]Motivated by the 1st order DSLT for fBm in Jung and Markowsky [8] and the $k$-th order derivative of intersection local time (ILT) for fBm in Guo et al. [1], we will consider the following $k$-th order DSLT for fBm in this paper,

\widehat{\alpha}^{(k)}(y) & =\frac{\partial^{k}}{\partial y_{1}^{k_{1}} \cdots \partial y_{d}^{k_{d}}} \int_{D} \delta\left(B_{s}^{H}-B_{r}^{H}-y\right) d r d s \\
& =(-1)^{|k|} \int_{D} \delta^{(k)}\left(B_{s}^{H}-B_{r}^{H}-y\right) d r d s
\end{aligned}
$$

where $k=\left(k_{1}, \cdots, k_{d}\right)$ is a multi-index with all $k_{i}$ being nonnegative integers and $|k|=k_{1}+k_{2}+$
 partial derivative of $\delta$.

Set

$$
f_{\varepsilon}(x)=\frac{1}{(2 \pi \varepsilon)^{\frac{d}{2}}} e^{-\frac{|x|^{2}}{2 \varepsilon}}=\frac{1}{(2 \pi)^{d}} \int_{\mathbb{R}^{d}} e^{i\langle p, x\rangle} e^{-\varepsilon \frac{|p|^{2}}{2}} d p
$$

where $\langle p, x\rangle=\sum_{j=1}^{d} p_{j} x_{j}$ and $|p|^{2}=\sum_{j=1}^{d} p_{j}^{2}$.
Since the Dirac delta function $\delta$ can be approximated by $f_{\varepsilon}(x)$, we approximate $\delta^{(k)}$ and $\widehat{\alpha}_{t}^{(k)}(y)$ by

f_{\varepsilon}^{(k)}(x)=\frac{i^{|k|}}{(2 \pi)^{d}} \int_{\mathbb{R}^{d}} p_{1}^{k_{1}} \cdots p_{d}^{k_{d}} e^{i\langle p, x\rangle} e^{-\varepsilon \frac{|p|^{2}}{2}} d p
$$

and

$$
\begin{equation*}
\widehat{\alpha}_{t, \varepsilon}^{(k)}(y)=(-1)^{|k|} \int_{D} f_{\varepsilon}^{(k)}\left(B_{s}^{H}-B_{r}^{H}-y\right) d r d s, \tag{1.1}
\end{equation*}
$$

respectively.
If $\widehat{\alpha}_{t, \varepsilon}^{(k)}(y)$ converges to a random variable in $L^{p}$ as $\varepsilon \rightarrow 0$, we denote the limit by $\widehat{\alpha}_{t}^{(k)}(y)$ and call it the $k$-th DSLT of $B^{H}$.

Theorem 1.1 For $0<H<1$ and $\widehat{\alpha}_{t, \varepsilon}^{(k)}(y)$ defined in (1.1), let $\#:=\#\left\{k_{i}\right.$ is odd, $\left.i=1,2, \cdots d\right\}$ denotes the odd number of $k_{i}$, for $i=1,2, \cdots, d$. If $H<\min \left\{\frac{2}{2|k|+d}, \frac{1}{|k|+d-\#}, \frac{1}{d}\right\}$ for $|k|=\sum_{j=1}^{d} k_{j}$, then $\widehat{\alpha}_{t}^{(k)}(0)$ exists in $L^{2}$.

Theorem 1.2 If $H(|k|+d)<1$, then $\widehat{\alpha}_{t}^{(k)}(0)$ exists in $L^{p}$, for all $p \in(0, \infty)$.
Note that, if $d=1$ and $|k|=1$, the condition for the existence of $\widehat{\alpha}_{t}^{(k)}(y)$ in Theorems 1.1 and 1.2 are consistent with that in Jung and Markowsky [8]. If $d=2$ and $|k|=1$ in Theorems 1.1, we can see $H<\frac{1}{2}$ is the best possible, since a limit theorem for threshold $H=\frac{1}{2}$ studied in Markowsky [9].

Theorem 1.3 Assume that $H(|k|+d)<1$ and $t, \tilde{t} \in[0, T]$. Then $\widehat{\alpha}_{t}^{(k)}(y)$ is Hölder continuous in $y$ of any order strictly less than $\min \left(1, \frac{1-H d-H|k|}{H}\right)$ and Hölder continuous in $t$ of any order strictly less than $1-H|k|-H d$,

$$
\begin{equation*}
\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t}^{(k)}(x)-\widehat{\alpha}_{t}^{(k)}(y)\right)^{n}\right]\right| \leq C|x-y|^{n \lambda} \tag{1.2}
\end{equation*}

where $\lambda<\min \left(1, \frac{1-H d-H|k|}{H}\right)$ and

$$
\begin{equation*}
\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t}^{(k)}(y)-\widehat{\alpha}_{\tilde{t}}^{(k)}(y)\right)^{n}\right]\right| \leq C|t-\tilde{t}|^{n \beta} \tag{1.3}
\end{equation*}
$$

where $\beta<1-H|k|-H d$.

Note that, if $d=1$ and $k=1$. The results of (1.2) and (1.3) in Theorem 1.3 are consistent with the results in Jung and Markowsky [8]. When $d=1$ and $k=0$, the corresponding Hölder continuous in time of any order less than $1-H$, which is the condition obtained in Xiao [14]. Moreover, we believe that our methodology also works well for $k$-th order DSLT of stochastic differential equation (SDE) driven by fBm, if the solution of SDE driven by fBm satisfy the property of local nondeterminism. For example, the special linear SDE, i.e. fractional Ornstein-Uhlenbeck processes.

Jung and Markowsky [7] proved that $\widehat{\alpha}_{t}^{(k)}(0)$ exists in $L^{2}$ for $d=1$ and $k=1$ with $0<H<2 / 3$, and conjectured that for the case $H>2 / 3, \varepsilon^{-\gamma(H)} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0)$ converges in law to a Gaussian distribution for some suitable constant $\gamma(H)>0$, and at the critical point $H=\frac{2}{3}$, the variable $\log \left(\frac{1}{\varepsilon}\right)^{-\gamma} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0)$ converges in law to a Gaussian distribution for some $\gamma>0$. Later, Jaramillo and Nualart [5] proved the case of $H>2 / 3$ as

$$
\varepsilon^{\frac{3}{2}-\frac{1}{H}} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0) \xrightarrow{l a w} N\left(0, \sigma_{0}^{2}\right), \quad \varepsilon \rightarrow 0 .
$$

By the proof of Lemma 2.1 in Section 2, we can see the multinomial terms $\left(p_{i 1}-\frac{\mu p_{i 2}}{\rho}\right)^{k_{i}}$ for $i=1,2, \ldots, d$, are taken into account. But we are not sure if $k_{i}$ is odd or even, there are many difficulties in the integral of $\int\left(p_{i 1}-\frac{\mu p_{i 2}}{\rho}\right)^{k_{i}} e^{-\frac{\rho p_{i 1}^{2}}{2}} d p_{i 1}$, thus we only consider the case $d=1$ and $k=1$ below.

Inspired by the results conjectured in [7] and the functional limit theorem for SLT of fBm given in Jaramillo and Nualart [6]. We will show a limit theorem of the critical case $H=\frac{2}{3}$.

Theorem 1.4 For $\widehat{\alpha}_{t, \varepsilon}^{(k)}(y)$ defined in (1.1) with $y=0$. Suppose that $H=\frac{2}{3}, d=1$ and $k=1$, then as $\varepsilon \rightarrow 0$, we have

$$
(\log 1 / \varepsilon)^{-1} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0) \xrightarrow{l a w} N\left(0, \sigma^{2}\right)
$$

where $\sigma^{2}=\frac{t^{\frac{4}{3}}}{8 \pi} B(2,1 / 3)$ and $B(\cdot, \cdot)$ is a Beta function.

The study of DSLT for fBm has a strong degree of heat, see in [5]-[8], [17] and references therein. However, the corresponding results for higher order derivative have not been studied, except for the higher order derivative of ILT for two independent fBms and some general Gaussian processes in [1] and [2]. As we all know, SLT and ILT have different integral structures in form. In particular, the independence of two fBms is required for ILT. So that the nondeterminism property which used for higher order derivative of ILT can not be used directly here.

To obtain the main results, we would use the methods of sample configuration given in Jung and Markowsky [8] and chaos decomposition provided in Jaramillo and Nualart [5]. Chaos decomposition is more and more mature for the asymptotic properties of SLT (see in Hu [4], Jaramillo and Nualart [5] and the references therein). The sample configuration method gives a way to apply nondeterminism property and it is very powerful to prove the Hölder regularity. But the corresponding results of higher order DSLT for $d$-dimensional fBm still has certain difficulty. The main difficulty lies in the computational complexity of multiple stochastic integrals. Moreover, the
related results can be extended to the general cases. By the Theorem 4.1 in Jaramillo and Nualart [5] and Theorem 1.4 here, two limit theorems of the case $H>\frac{2}{2|k|+d}$ and critical case $H=\frac{2}{2|k|+d}$, with general $k=\left(k_{1}, \cdots, k_{d}\right)$ are left open. Extending these limit theorems to general cases will be worked in the future.

The paper has the following structure. We present some preliminary properties of $d$-dimensional fBm and some basic lemmas in Section 2. Section 3 is to prove the main results. To be exact, we will split this section into four subsections to prove the four theorems given in Section 1. Throughout this paper, if not mentioned otherwise, the letter $C$, with or without a subscript, denotes a generic positive finite constant and may change from line to line.

## 2 Preliminaries

In this section, we first give some properties of $d$-dimensional $\mathrm{fBm} B^{H}$. It is well known that $d$-dimensional fBm has self-similarity, stationary increments and Hölder continuity. When Hurst parameter $H>1 / 2, B^{H}$ exhibits long memory. When $H<1 / 2$, it has short memory. But in this paper, we need the following nondeterminism property.

By Nualart and $\mathrm{Xu}[10]$ (see also in Song, Xu and $\mathrm{Yu}[13]$ ), we can see that for any $n \in \mathbb{N}$, there exists two constants $\kappa_{H}$ and $\beta_{H}$ depending only on $n$ and $H$, such that for any $0=s_{0}<s_{1}<$ $\cdots<s_{n}, 1 \leq i \leq n$, we have

$$
\kappa_{H} \sum_{i=1}^{n}\left|x_{i}\right|^{2}\left(s_{i}-s_{i-1}\right)^{2 H} \leq \operatorname{Var}\left(\sum_{i=1}^{n} x_{i} \cdot\left(B_{s_{i}}^{H}-B_{s_{i-1}}^{H}\right)\right) \leq \beta_{H} \sum_{i=1}^{n}\left|x_{i}\right|^{2}\left(s_{i}-s_{i-1}\right)^{2 H} .
$$

Next, we present two basic lemmas, which will be used in Section 3.
Lemma 2.1 For any $\lambda, \mu, \rho \in \mathbb{R}$ with $\lambda>0, \rho>0$ and $\lambda \rho-\mu^{2}>0$. For $k \in \mathbb{Z}^{+}$, there exists a constant $C$ only depending on $k$, such that
(i) if $k$ is odd,

$$
\left|\int_{\mathbb{R}^{2}} x^{k} y^{k} e^{-\frac{1}{2}\left(\lambda x^{2}+\rho y^{2}+2 \mu x y\right)} d x d y\right| \leq \begin{cases}\frac{C|\mu|^{k}}{\left(\lambda \rho-\mu^{2}\right)^{k+\frac{1}{2}}}, & \text { if } \frac{\mu^{2}}{\lambda \rho-\mu^{2}} \geq 1,  \tag{2.1}\\ \frac{C|\mu|}{\left(\lambda \rho-\mu^{2}\right)^{\frac{k}{2}+1}}, & \text { if } \frac{\mu^{2}}{\lambda \rho-\mu^{2}}<1,\end{cases}
$$

(ii) if $k$ is even,

$$
\left|\int_{\mathbb{R}^{2}} x^{k} y^{k} e^{-\frac{1}{2}\left(\lambda x^{2}+\rho y^{2}+2 \mu x y\right)} d x d y\right| \leq \begin{cases}\frac{C|\mu|^{k}}{\left(\lambda \rho-\mu^{2}\right)^{k+\frac{1}{2}}}, & \text { if } \frac{\mu^{2}}{\lambda \rho-\mu^{2}} \geq 1,  \tag{2.2}\\ \frac{C}{\left(\lambda \rho-\mu^{2}\right)^{\frac{k+1}{2}}}, & \text { if } \frac{\mu^{2}}{\lambda \rho-\mu^{2}}<1 .\end{cases}
$$

Proof. First, we consider the integral with respect to $y$,

\int_{\mathbb{R}} y^{k} e^{-\frac{\rho}{2} y^{2}-\mu x y} d y & =e^{\frac{\mu^{2} x^{2}}{2 \rho}} \int_{\mathbb{R}} y^{k} e^{-\frac{\rho}{2}\left(y+\frac{\mu x}{\rho}\right)^{2}} d y \\
& =e^{\frac{\mu^{2} x^{2}}{2 \rho}} \int_{\mathbb{R}}\left(y-\frac{\mu x}{\rho}\right)^{k} e^{-\frac{\rho}{2} y^{2}} d y .
\end{aligned}
$$

If $k$ is odd, since

$$
\left(y-\frac{\mu x}{\rho}\right)^{k}=\sum_{i=0}^{k} C_{k}^{i} y^{i}\left(-\frac{\mu x}{\rho}\right)^{k-i},
$$

we have

$$
\begin{aligned}
\int_{\mathbb{R}} y^{k} e^{-\frac{\rho}{2} y^{2}-\mu x y} d y & =e^{\frac{\mu^{2} x^{2}}{2 \rho}} \int_{\mathbb{R}} A_{\text {odd }} e^{-\frac{\rho}{2} y^{2}} d y \\
& =C_{1} e^{\frac{\mu^{2} x^{2}}{2 \rho}} \frac{(\mu x)^{k}}{\rho^{k+\frac{1}{2}}}+C_{3} e^{\frac{\mu^{2} x^{2}}{2 \rho}} \frac{(\mu x)^{k-2}}{\rho^{k-\frac{1}{2}}}+\cdots+C_{k} e^{\frac{\mu^{2} x^{2}}{2 \rho}} \frac{(\mu x)}{\rho^{k / 2+1}} \\
& =: \tilde{A}_{\text {odd }},
\end{aligned}
$$

where $C_{1}, C_{3}, \cdots, C_{k}$ are all positive constants and

$$
A_{o d d}=C_{k}^{0}\left(-\frac{\mu x}{\rho}\right)^{k}+C_{k}^{2} y^{2}\left(-\frac{\mu x}{\rho}\right)^{k-2}+\cdots+C_{k}^{k-1} y^{k-1}\left(-\frac{\mu x}{\rho}\right) .
$$

For the $d x$ integral,

$$
\int_{\mathbb{R}} x^{k} e^{-\frac{1}{2} \lambda x^{2}}\left(\widetilde{A}_{o d d}\right) d x \leq C\left[\frac{\mu^{k}}{\left(\lambda \rho-\mu^{2}\right)^{k+\frac{1}{2}}}+\frac{\mu^{k-2}}{\left(\lambda \rho-\mu^{2}\right)^{k-\frac{1}{2}}}+\cdots+\frac{\mu}{\left(\lambda \rho-\mu^{2}\right)^{\frac{k}{2}+1}}\right],
$$

where the right hand side is the sum of equal ratio series with the common ratio $\frac{\mu^{2}}{\lambda \rho-\mu^{2}}>0$. Then, we get (2.1).

If $k$ is even,

\int_{\mathbb{R}} y^{k} e^{-\frac{\rho}{2} y^{2}-\mu x y} d y & =e^{\frac{\mu^{2} x^{2}}{2 \rho}} \int_{\mathbb{R}}\left(y-\frac{\mu x}{\rho}\right)^{k} e^{-\frac{\rho}{2} y^{2}} d y \\
& \leq C e^{\frac{\mu^{2} x^{2}}{2 \rho}}\left[\int_{\mathbb{R}} y^{k} e^{-\frac{\rho}{2} y^{2}} d y+\int_{\mathbb{R}}\left(\frac{\mu x}{\rho}\right)^{k} e^{-\frac{\rho}{2} y^{2}} d y\right] \\
& =: B_{1}+B_{2} .
\end{aligned}
$$

It is easy to see that

$$
B_{1} \leq C e^{\frac{\mu^{2} x^{2}}{2 \rho}} \rho^{-\frac{k+1}{2}}
$$

and

$$
B_{2} \leq C e^{\frac{\mu^{2} x^{2}}{2 \rho}}(\mu x)^{k} \rho^{-\frac{2 k+1}{2}} .
$$

For the integral with respect to $x$,

$$
\begin{aligned}
\frac{1}{\rho^{\frac{k+1}{2}}} \int_{\mathbb{R}} x^{k} e^{-\frac{x^{2}}{2 \rho}\left(\lambda \rho-\mu^{2}\right)} d x & \leq \frac{C}{\rho^{\frac{k+1}{2}}} \int_{\mathbb{R}} x^{k} e^{-\frac{x^{2}}{2}}\left(\frac{\lambda \rho-\mu^{2}}{\rho}\right)^{-\frac{1+k}{2}} d x \\
& \leq \frac{C}{\left(\lambda \rho-\mu^{2}\right)^{\frac{k+1}{2}}}
\end{aligned}
$$

and

$$
\begin{aligned}
\frac{\mu^{k}}{\rho^{k+\frac{1}{2}}} \int_{\mathbb{R}} x^{2 k} e^{-\frac{x^{2}}{2 \rho}\left(\lambda \rho-\mu^{2}\right)} d x & \leq C \frac{\mu^{k}}{\rho^{k+\frac{1}{2}}} \int_{\mathbb{R}} x^{2 k} e^{-\frac{x^{2}}{2}}\left(\frac{\lambda \rho-\mu^{2}}{\rho}\right)^{-\frac{1+2 k}{2}} d x \\
& \leq C \frac{\mu^{k}}{\left(\lambda \rho-\mu^{2}\right)^{k+\frac{1}{2}}} .
\end{aligned}
$$

This gives (2.2).
The next lemma gives the bounds on the quantity of $\lambda \rho-\mu^{2}$, which could be obtained from the Appendix B in [7] or the Lemma 3.1 in [3].

Lemma 2.2 Let

\lambda=|s-r|^{2 H}, \quad \rho=\left|s^{\prime}-r^{\prime}\right|^{2 H}
$$

and

\mu=\frac{1}{2}\left(\left|s^{\prime}-r\right|^{2 H}+\left|s-r^{\prime}\right|^{2 H}-\left|s^{\prime}-s\right|^{2 H}-\left|r-r^{\prime}\right|^{2 H}\right)
$$

Case (i) Suppose that $D_{1}=\left\{\left(r, r^{\prime}, s, s^{\prime}\right) \in[0, t]^{4} \mid r<r^{\prime}<s<s^{\prime}\right\}$, let $r^{\prime}-r=a, s-r^{\prime}=b$, $s^{\prime}-s=c$. Then, there exists a constant $K_{1}$ such that

$$
\lambda \rho-\mu^{2} \geq K_{1}\left((a+b)^{2 H} c^{2 H}+a^{2 H}(b+c)^{2 H}\right)
$$

and

$$
2 \mu=(a+b+c)^{2 H}+b^{2 H}-a^{2 H}-c^{2 H} .
$$

Case (ii) Suppose that $D_{2}=\left\{\left(r, r^{\prime}, s, s^{\prime}\right) \in[0, t]^{4} \mid r<r^{\prime}<s^{\prime}<s\right\}$, let $r^{\prime}-r=a, s^{\prime}-r^{\prime}=b$, $s-s^{\prime}=c$. Then, there exists a constant $K_{2}$ such that

\lambda \rho-\mu^{2} \geq K_{2} b^{2 H}\left(a^{2 H}+c^{2 H}\right)
$$

and

$$
2 \mu=(a+b)^{2 H}+(b+c)^{2 H}-a^{2 H}-c^{2 H} .
$$

Case (iii) Suppose that $D_{3}=\left\{\left(r, r^{\prime}, s, s^{\prime}\right) \in[0, t]^{4} \mid r<s<r^{\prime}<s^{\prime}\right\}$, let $s-r=a, r^{\prime}-s=b$, $s^{\prime}-r^{\prime}=c$. Then, there exists a constant $K_{3}$ such that

$$
\lambda \rho-\mu^{2} \geq K_{3}(a c)^{2 H}
$$

and

$$
2 \mu=(a+b+c)^{2 H}+b^{2 H}-(a+b)^{2 H}-(c+b)^{2 H} .
$$

## 3 Proof of the main results

In this section, the proof of Theorems 1.1, 1.2, 1.3 and 1.4 are taken into account. We will divide this section into four parts and give the proof of the corresponding theorem in each part.

### 3.1 Proof of Theorem 1.1

By (1.1) and the proof of Lemma 2.1,

\mathbb{E}\left[\widehat{\alpha}_{t, \varepsilon}^{(k)}(0) \widehat{\alpha}_{t, \eta}^{(k)}(0)\right]= & \frac{1}{(2 \pi)^{2 d}} \int_{D^{2}} \int_{\mathbb{R}^{2 d}} p_{1}^{k} p_{2}^{k} e^{\frac{-\left(\varepsilon\left|p_{1}\right|^{2}+\eta\left|p_{2}\right|^{2}\right)}{2}} \mathbb{E}\left[\prod_{j=1}^{2} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p_{1} d p_{2} d r^{\prime} d r d s^{\prime} d s \\

Fix an ordering of the set $\left\{r_{1}, s_{1}, r_{2}, s_{2}, \cdots, r_{n}, s_{n}\right\}$, and let $l_{1} \leq l_{2} \leq \cdots \leq l_{2 n}$ be a relabeling of the set $\left\{r_{1}, s_{1}, r_{2}, s_{2}, \cdots, r_{n}, s_{n}\right\}$. Let $u_{1} \ldots u_{2 n-1}$ be the proper linear combinations of the $p_{j}$ 's so that

\int_{\mathbb{R}^{n d}} & e^{-c \sum_{j=1}^{2 n-1}\left|u_{j}\right|^{2}\left(l_{j+1}-l_{j}\right)^{2 H}} \prod_{j=1}^{2 n-1}\left(\left|u_{j}^{\frac{k}{2} \alpha_{j}}\right|\right) d p \\
& \leq C \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-\frac{H\left|k \alpha_{j}\right|}{2}} \int_{\mathbb{R}^{n d}} e^{-c \sum_{j \in \mathcal{A}}\left|u_{j}\right|^{2}\left(l_{j+1}-l_{j}\right)^{2 H}} \prod_{j \in \mathcal{A}}\left(\left|u_{j}^{\frac{k}{2} \alpha_{j}}\right|\right) d p \\
& =C|J| \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-\frac{H\left|k \alpha_{j}\right|}{2}} \int_{\mathbb{R}^{n d}} e^{-c \sum_{j \in \mathcal{A}}\left|u_{j}\right|^{2}\left(l_{j+1}-l_{j}\right)^{2 H}} \prod_{j \in \mathcal{A}}\left(\left|u_{j}^{\frac{k}{2} \alpha_{j}}\right|\right) d u,
\end{aligned}
$$

where $|J|$ is the Jacobian determinant of changing variables $\left(p_{1}, p_{2}, \cdots, p_{n}\right)$ to $\left(u_{j}, j \in \mathcal{A}\right)$.
Therefore, we may reduce the convergence of $\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t, \varepsilon}^{(k)}(0)\right)^{n}\right]\right|$ to show the finiteness of

\int_{E^{n}} \int_{\mathbb{R}^{n d}} e^{-c \sum_{j \in \mathcal{A}}\left|u_{j}\right|^{2}\left(l_{j+1}-l_{j}\right)^{2 H}} \prod_{j \in \mathcal{A}}\left(\left|u_{j}^{\frac{k}{2} \alpha_{j}}\right|\right) \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-\frac{H\left|k \alpha_{j}\right|}{2}} d u d l=: \Lambda .
$$

Since

\int_{\mathbb{R}} e^{-c u_{i j}^{2}\left(l_{j+1}-l_{j}\right)^{2 H}}\left|u_{i j}\right|^{\frac{k_{i}}{2} \alpha_{i, j}} d u_{i j} \leq C\left(l_{j+1}-l_{j}\right)^{-H-\frac{H}{2} k_{i} \alpha_{i, j}},
$$

we have

\begin{aligned}
\Lambda & \leq C \int_{E^{n}} \prod_{j \in \mathcal{A}}\left(l_{j+1}-l_{j}\right)^{-H d-\frac{H}{2}\left|k \alpha_{j}\right|} \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-\frac{H\left|k \alpha_{j}\right|}{2}} d l \\
& \leq C_{n, H, t} \int_{E^{n}} \prod_{j \in \mathcal{A}}\left(l_{j+1}-l_{j}\right)^{-H d-H|k|} \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-H|k|} d l \\
& \leq C_{n, H, t} \frac{\Gamma^{n}(1-H d-H|k|) \Gamma^{n-1}(1-H|k|)}{\Gamma(n(1-H d-H|k|)+(n-1)(1-H|k|)+1)},
\end{aligned}
$$

where $C_{n, H, t}$ is a constant dependent on $n, H$ and $t$.
Thus, we can see that $\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t, \varepsilon}^{(k)}(0)\right)^{n}\right]\right|$ is finite for all $\varepsilon>0$ under condition $H(d+|k|)<1$. Then, we need to prove $\left\{\widehat{\alpha}_{t, \varepsilon}^{(k)}(0)\right\}_{\varepsilon>0}$ is a Cauchy sequence.

Notice that, for any $\varepsilon_{1}, \varepsilon_{2}>0$,

\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t, \varepsilon_{1}}^{(k)}(0)-\widehat{\alpha}_{t, \varepsilon_{2}}^{(k)}(0)\right)^{n}\right]\right| \leq C \int_{D^{n}} \int_{\mathbb{R}^{n d}} & \prod_{j=1}^{n}\left|e^{-\frac{\varepsilon_{1}}{2}\left|p_{j}\right|^{2}}-e^{-\frac{\varepsilon_{2}}{2}\left|p_{j}\right|^{2}}\right| \\
& \times \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p d r d s .
\end{aligned}
$$

By the dominated convergence theorem and

$$
\int_{D^{n}} \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p d r d s<\infty
$$

we can obtain the desired result. This completes the proof.

### 3.3 Proof of Theorem 1.3

Let us first prove (1.2). For any $\lambda \in[0,1]$, we have the following inequalities

Using the similar methods as in the proof of Theorem 1.2, we find that

\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t}^{(k)}(x)-\widehat{\alpha}_{t}^{(k)}(y)\right)^{n}\right]\right| \leq C|x-y|^{n \lambda} & \int_{D^{n}} \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right|\left(\left|p_{1 j}\right|^{\lambda}+\cdots+\left|p_{d j}\right|^{\lambda}\right) \\
& \times \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p d r d s \\
\leq & C|x-y|^{n \lambda} \sum_{l=1}^{d} \int_{D^{n}} \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k+\tilde{\lambda}_{l}}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p d r d s \\
= & C|x-y|^{n \lambda} \Lambda_{1},
\end{aligned}
$$

where $\tilde{\lambda}_{l}=\left(\lambda_{1}, \cdots, \lambda_{d}\right)$ with $\lambda_{l}=\lambda$ and all other $\lambda_{j}=0$. So $|k+\tilde{\lambda}|=|k|+\lambda$ and $\Lambda_{1}$ is less than (with $\mathcal{A}$ defined as before)

\begin{aligned}
& C \int_{E^{n}} \prod_{j \in \mathcal{A}}\left(l_{j+1}-l_{j}\right)^{-H d-\frac{H}{2}\left|\alpha_{j}(k+\tilde{\lambda})\right|} \prod_{j \in \mathcal{A}^{c}}\left(l_{j+1}-l_{j}\right)^{-\frac{H}{2}\left|\alpha_{j}(k+\tilde{\lambda})\right|} d l \\
& \quad \leq C_{n, H, t} \frac{\Gamma^{n}(1-H d-H|k+\tilde{\lambda}|) \Gamma^{n-1}(1-H|k+\tilde{\lambda}|)}{\Gamma(n(1-H d-H|k+\tilde{\lambda}|)+(n-1)(1-H|k+\tilde{\lambda}|)+1)},
\end{aligned}
$$

which is finite if $1-H d-H|k+\tilde{\lambda}|>0$.
For the proof of (1.3), let $\tilde{D}=\{(r, s): 0<r<s<\tilde{t}\}$ and without loss of generality, we assume that $t<\tilde{t}$. Then

\left|\mathbb{E}\left[\left(\widehat{\alpha}_{t}^{(k)}(y)-\widehat{\alpha}_{\tilde{t}}^{(k)}(y)\right)^{n}\right]\right| & \leq C \int_{(\tilde{D} \backslash D)^{n}} \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right.}\right] d p d r d s \\
& \leq C \int_{[t, \tilde{t}]^{n}} \int_{\left[0, s_{1}\right] \times \cdots \times\left[0, s_{n}\right]} \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right.}\right] d p d r d s \\
& \leq C \int_{\tilde{D}^{n}} \prod_{j=1}^{n} 1_{[t, t]}\left(s_{j}\right) \int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p d r d s \\
& \leq C|t-\tilde{t}|^{n \beta}\left(\int_{\tilde{D}^{n}}\left(\int_{\mathbb{R}^{n d}} \prod_{j=1}^{n}\left|p_{j}^{k}\right| \mathbb{E}\left[\prod_{j=1}^{n} e^{i\left\langle p_{j}, B_{s_{j}}^{H}-B_{r_{j}}^{H}\right\rangle}\right] d p\right)^{\frac{1}{1-\beta}} d r d s\right)^{1-\beta} \\
& =: C|t-\tilde{t}|^{n \beta} \Lambda_{2},
\end{aligned}
$$

where we use the Hölder's inequality in the last inequality with $\beta<1-H|k|-H d$.
Using the similar methods as in the proof of Theorem 1.2, $\Lambda_{2}$ is bounded by

Since $1-\beta>H(|k|+d)$, there exists a constant $C>0$, such that

In this section, we mainly use the method given in Jaramillo and Nualart [5]. We first give the chaos decomposition of the random variable $\widehat{\alpha}_{t, \varepsilon}^{(k)}(0)$ defined in (1.1) with $d=1$ and $k=1$. We write

f_{2 q-1, \varepsilon, s, r}\left(x_{1}, \cdots, x_{2 q-1}\right)=(-1)^{q} \beta_{q}\left(\varepsilon+(s-r)^{2 H}\right)^{-q-\frac{1}{2}} \prod_{j=1}^{2 q-1} \mathbb{1}_{[r, s]}\left(x_{j}\right)
$$

and

$$
\beta_{q}=\frac{1}{2^{q-\frac{1}{2}}(q-1)!\sqrt{\pi}} .
$$

Then, $\widehat{\alpha}_{t, \varepsilon}^{\prime}(0)$ has the following chaos decomposition

$$
\widehat{\alpha}_{t, \varepsilon}^{\prime}(0)=\sum_{q=1}^{\infty} I_{2 q-1}\left(f_{2 q-1, \varepsilon}\right),
$$

where

$$
f_{2 q-1, \varepsilon}\left(x_{1}, \cdots, x_{2 q-1}\right)=\int_{D} f_{2 q-1, \varepsilon, s, r}\left(x_{1}, \cdots, x_{2 q-1}\right) d r d s
$$

with $D=\{(r, s): 0<r<s<t\}$.
For $q=1$,

$$
\begin{equation*}
\mathbb{E}\left[\left|I_{1}\left(f_{1, \varepsilon}\right)\right|^{2}\right]=\int_{D^{2}}\left\langle f_{1, \varepsilon, s_{1}, r_{1}}, f_{1, \varepsilon, s_{2}, r_{2}}\right\rangle_{\mathfrak{H}} d r_{1} d r_{2} d s_{1} d s_{2} \tag{3.3}
\end{equation*}
$$

where $\mathfrak{H}$ is the Hilbert space obtained by taking the completion of the step functions endowed with the inner product

$$
\left\langle\mathbb{1}_{[a, b]}, \mathbb{1}_{[c, d]}\right\rangle_{\mathfrak{H}}:=\mathbb{E}\left[\left(B_{b}^{H}-B_{a}^{H}\right)\left(B_{d}^{H}-B_{c}^{H}\right)\right] .
$$

For $q>1$, we have to describe the terms $\left\langle f_{2 q-1, \varepsilon, s_{1}, r_{1}}, f_{2 q-1, \varepsilon, s_{2}, r_{2}}\right\rangle_{\mathfrak{H}} \otimes(2 q-1)$, where $\mathfrak{H}^{\otimes(2 q-1)}$ is the $(2 q-1)$-th tensor product of $\mathfrak{H}$. For every $x, u_{1}, u_{2}>0$, we define

\mu\left(x, u_{1}, u_{2}\right)=\mathbb{E}\left[B_{u_{1}}^{H}\left(B_{x+u_{2}}^{H}-B_{x}^{H}\right)\right] .

Then, from equation (2.19) in Jaramillo and Nualart [5],

\left\langle f_{2 q-1, \varepsilon, s_{1}, r_{1}}, f_{2 q-1, \varepsilon, s_{2}, r_{2}}\right\rangle_{\mathfrak{H} \otimes(2 q-1)}=\beta_{q}^{2} G_{\varepsilon, r_{2}-r_{1}}^{(q)}\left(s_{1}-r_{1}, s_{2}-r_{2}\right),
$$

where

$$
G_{\varepsilon, x}^{(q)}\left(u_{1}, u_{2}\right)=\left(\varepsilon+u_{1}^{2 H}\right)^{-\frac{1}{2}-q}\left(\varepsilon+u_{2}^{2 H}\right)^{-\frac{1}{2}-q} \mu\left(x, u_{1}, u_{2}\right)^{2 q-1}
$$

Before we give the proof of the main result, we give some useful lemmas below. In the sequel, we just consider the case $H=\frac{2}{3}$.

## Lemma 3.1

\lim _{\varepsilon \rightarrow 0} \mathbb{E}\left[\left|\frac{1}{\log \frac{1}{\varepsilon}} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0)\right|^{2}\right]=\sigma^{2}

Proof. From Lemma 5.1 in Jaramillo and Nualart [5], we can see

\mathbb{E}\left[\left|\frac{1}{\log \frac{1}{\varepsilon}} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0)\right|^{2}\right]=\frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}}\left(V_{1}(\varepsilon)+V_{2}(\varepsilon)+V_{3}(\varepsilon)\right)
$$

and

$$
V_{i}(\varepsilon)=\frac{1}{\pi} \int_{D_{i}}|\varepsilon I+\Sigma|^{-\frac{3}{2}} \mu d r d s d r^{\prime} d s^{\prime}
$$

where $D_{i}(\mathrm{i}=1,2,3)$ defined in Lemma 2.2 and $\Sigma$ is the covariance matrix of $\left(B_{s}^{H}-B_{r}^{H}, B_{s^{\prime}}^{H}-B_{r^{\prime}}^{H}\right)$ with $\Sigma_{1,1}=\lambda, \Sigma_{2,2}=\rho, \Sigma_{1,2}=\mu$ given in Lemma 2.2.

Next, we will split the proof into three parts to consider $V_{1}(\varepsilon), V_{2}(\varepsilon)$ and $V_{3}(\varepsilon)$, respectively.
For the $V_{1}(\varepsilon)$ term, changing the coordinates $\left(r, r^{\prime}, s, s^{\prime}\right)$ by ( $\left.r, a=r^{\prime}-r, b=s-r^{\prime}, c=s^{\prime}-s\right)$ and integrating the $r$ variable, we get

& =\frac{t}{\pi} \int_{[0, t]^{3}}|\varepsilon I+\Sigma|^{-\frac{3}{2}} \mu d a d b d c \\
& =: \widetilde{V}_{1}(\varepsilon)
\end{aligned}
$$

Since

\mu=\frac{1}{2}\left((a+b+c)^{\frac{4}{3}}+b^{\frac{4}{3}}-a^{\frac{4}{3}}-c^{\frac{4}{3}}\right) \leq \sqrt{\lambda \rho}=(a+b)^{\frac{2}{3}}(b+c)^{\frac{2}{3}}
$$

and

$$
\begin{aligned}
|\varepsilon I+\Sigma| & =\left(\varepsilon+\Sigma_{1,1}\right)\left(\varepsilon+\Sigma_{2,2}\right)-\Sigma_{1,2}^{2} \\
& \geq C\left[\varepsilon^{2}+\varepsilon\left((a+b)^{\frac{4}{3}}+(b+c)^{\frac{4}{3}}\right)+a^{\frac{4}{3}}(c+b)^{\frac{4}{3}}+c^{\frac{4}{3}}(a+b)^{\frac{4}{3}}\right] \\
& \geq C\left[\varepsilon^{2}+(a+b)^{\frac{2}{3}}(b+c)^{\frac{2}{3}}\left(\varepsilon+(a c)^{\frac{2}{3}}\right)\right] \\
& \geq C(a+b)^{\frac{2}{3}}(b+c)^{\frac{2}{3}}\left(\varepsilon+(a c)^{\frac{2}{3}}\right),
\end{aligned}
$$

where we use the Young's inequality in the second to last inequality.
Then, we have

\widetilde{V_{1}}(\varepsilon) \leq C \int_{[0, t]^{3}}(a+b)^{-\frac{1}{3}}(b+c)^{-\frac{1}{3}}\left(\varepsilon+(a c)^{\frac{2}{3}}\right)^{-\frac{3}{2}} d a d b d c
$$

We will estimate this integral over the regions $\{b \leq(a \vee c)\}$ and $\{b>(a \vee c)\}$ separately, and we will denote these two integrals by $\widetilde{V_{1,1}}$ and $\widetilde{V_{1,2}}$, respectively. If $b \leq(a \vee c)$, without loss of generality, we can assume $a \geq c$ and thus $b \leq a$. For a given small enough constant $\varepsilon_{1}>0$,

\widetilde{V_{1,1}}(\varepsilon) & \leq C \int_{[0, t]^{3}}(a+b)^{-\frac{1}{3}-\varepsilon_{1}}(b+c)^{-\frac{1}{3}} \frac{(a+b)^{\varepsilon_{1}}}{a^{\varepsilon_{1}}} a^{\varepsilon_{1}}\left(\varepsilon+(a c)^{\frac{2}{3}}\right)^{-\frac{3}{2}} d a d b d c \\
& \leq C \int_{[0, t]^{3}} b^{-\frac{2}{3}-\varepsilon_{1}} a^{\varepsilon_{1}}\left(\varepsilon+(a c)^{\frac{2}{3}}\right)^{-\frac{3}{2}} d a d b d c \\
& \leq C \int_{0}^{t} \int_{0}^{t \varepsilon^{-\frac{3}{2}}} a^{\varepsilon_{1}}\left(1+(a c)^{\frac{2}{3}}\right)^{-\frac{3}{2}} d c d a
\end{aligned}
$$

where we make the change of variable $c=c \varepsilon^{-\frac{3}{2}}$ in the last inequality.
By L'Hôspital's rule, we have

\limsup _{\varepsilon \rightarrow 0} \frac{\widetilde{V_{1,1}}(\varepsilon)}{\log \frac{1}{\varepsilon}} \leq C<\infty .
$$

If $b>(a \vee c)$, we can see that

|\varepsilon I+\Sigma| & \geq C\left[\varepsilon^{2}+\varepsilon\left((a+b)^{\frac{4}{3}}+(b+c)^{\frac{4}{3}}\right)+a^{\frac{4}{3}}(c+b)^{\frac{4}{3}}+c^{\frac{4}{3}}(a+b)^{\frac{4}{3}}\right] \\
& \geq C b^{\frac{4}{3}}\left(\varepsilon+(a \vee c)^{\frac{4}{3}}\right) .
\end{aligned}
$$

Then

$$
\begin{aligned}
\limsup _{\varepsilon \rightarrow 0} \frac{\widetilde{V_{1,2}}(\varepsilon)}{\log \frac{1}{\varepsilon}} & \leq \limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{[0, t]^{3}} b^{-\frac{2}{3}}\left(\varepsilon+(a \vee c)^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a d b d c \\
& \leq \limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{0}^{t} \int_{0}^{a}\left(\varepsilon+a^{\frac{4}{3}}\right)^{-\frac{3}{2}} d c d a \\
& =\limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{0}^{t} a\left(\varepsilon+a^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a<\infty .
\end{aligned}
$$

So, by the above result, we can obtain

\lim _{\varepsilon \rightarrow 0} \frac{V_{1}(\varepsilon)}{\left(\log \frac{1}{\varepsilon}\right)^{2}}=0 \tag{3.4}

For the $V_{2}(\varepsilon)$ term, changing the coordinates $\left(r, r^{\prime}, s, s^{\prime}\right)$ by $\left(r, a=r^{\prime}-r, b=s^{\prime}-r^{\prime}, c=s-s^{\prime}\right)$ and integrating the $r$ variable, we get

$$
V_{2}(\varepsilon) \leq \frac{t}{\pi} \int_{[0, t]^{3}}|\varepsilon I+\Sigma|^{-\frac{3}{2}} \mu d a d b d c=: \widetilde{V_{2}}(\varepsilon)
$$

By

$$
\begin{aligned}
\mu & =\frac{1}{2}\left((a+b)^{\frac{4}{3}}+(b+c)^{\frac{4}{3}}-a^{\frac{4}{3}}-c^{\frac{4}{3}}\right) \\
& =\frac{2 b}{3} \int_{0}^{1}\left((a+b v)^{\frac{1}{3}}+(c+b v)^{\frac{1}{3}}\right) d v \\
& \leq \frac{4}{3} b(a+b+c)^{\frac{1}{3}}
\end{aligned}
$$

and

$$
|\varepsilon I+\Sigma|=\left(\varepsilon+\Sigma_{1,1}\right)\left(\varepsilon+\Sigma_{2,2}\right)-\Sigma_{1,2}^{2} \geq \varepsilon^{2}+\varepsilon\left((a+b+c)^{\frac{4}{3}}+b^{\frac{4}{3}}\right)+C b^{\frac{4}{3}}\left(a^{\frac{4}{3}}+c^{\frac{4}{3}}\right),
$$

we have

$$
\widetilde{V_{2}}(\varepsilon) \leq C \int_{[0, t]^{3}} b(a+b+c)^{\frac{1}{3}}\left(\varepsilon\left((a+b+c)^{\frac{4}{3}}+b^{\frac{4}{3}}\right)+b^{\frac{4}{3}}\left(a^{\frac{4}{3}}+c^{\frac{4}{3}}\right)\right)^{-\frac{3}{2}} d a d b d c .
$$

We again estimate this integral over the regions $\{b \leq(a \vee c)\}$ and $\{b>(a \vee c)\}$ separately, and denote these two integrals by $\widetilde{V_{2,1}}$ and $\widetilde{V_{2,2}}$, respectively. If $b \leq(a \vee c)$,

$$
\begin{aligned}
\widetilde{V_{2,1}}(\varepsilon) & \leq C \int_{[0, t]^{3}} b(a \vee c)^{\frac{1}{3}}\left(\varepsilon(a \vee c)^{\frac{4}{3}}+b^{\frac{4}{3}}(a \vee c)^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a d b d c \\
& \leq C \int_{[0, t]^{3}} b(a \vee c)^{-\frac{5}{2}}\left(\varepsilon+b^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a d b d c \\
& \leq C \int_{0}^{t} b\left(\varepsilon+b^{\frac{4}{3}}\right)^{-\frac{3}{2}} d b \\
& \leq C \int_{0}^{t \varepsilon^{-\frac{3}{4}}} b\left(1+b^{\frac{4}{3}}\right)^{-\frac{3}{2}} d b .
\end{aligned}
$$

Thus,

$$
\begin{equation*}
\limsup _{\varepsilon \rightarrow 0} \frac{\widetilde{V_{2,1}}(\varepsilon)}{\log \frac{1}{\varepsilon}} \leq C \limsup \varepsilon_{\varepsilon \rightarrow 0}^{-\frac{3}{2}}\left(1+t^{\frac{4}{3}} \varepsilon^{-1}\right)^{-\frac{3}{2}}<\infty . \tag{3.5}
\end{equation*}
$$

If $b>(a \vee c)$, similarly, we have

$$
\begin{align*}
\limsup _{\varepsilon \rightarrow 0} \frac{\widetilde{V_{2,2}}(\varepsilon)}{\log \frac{1}{\varepsilon}} & \leq \limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{0}^{t} b^{-\frac{2}{3}} d b \int_{[0, t]^{2}}\left(\varepsilon+(a \vee c)^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a d c \\
& \leq \limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{0}^{t} \int_{0}^{a}\left(\varepsilon+a^{\frac{4}{3}}\right)^{-\frac{3}{2}} d c d a  \tag{3.6}\\
& =\limsup _{\varepsilon \rightarrow 0} \frac{C}{\log \frac{1}{\varepsilon}} \int_{0}^{t} a\left(\varepsilon+a^{\frac{4}{3}}\right)^{-\frac{3}{2}} d a<\infty .
\end{align*}
$$

So, by the above result, we can obtain

$$
\lim _{\varepsilon \rightarrow 0} \frac{V_{2}(\varepsilon)}{\left(\log \frac{1}{\varepsilon}\right)^{2}}=0
$$

For the $V_{3}(\varepsilon)$ term. We first change the coordinates $\left(r, r^{\prime}, s, s^{\prime}\right)$ by $\left(r, a=s-r, b=r^{\prime}-s, c=\right.$ $s^{\prime}-r^{\prime}$ ) and then by

$$
\begin{aligned}
\mu & =\frac{1}{2}\left((a+b+c)^{\frac{4}{3}}+b^{\frac{4}{3}}-(b+c)^{\frac{4}{3}}-(a+b)^{\frac{4}{3}}\right) \\
& =\frac{2}{9} a c \int_{0}^{1} \int_{0}^{1}(b+a x+c y)^{-\frac{2}{3}} d x d y \\
& =: \mu(a+b, a, c),
\end{aligned}
$$

and $|\varepsilon I+\Sigma|=\varepsilon^{2}+\varepsilon\left(a^{\frac{4}{3}}+c^{\frac{4}{3}}\right)+(a c)^{\frac{4}{3}}-\mu(a+b, a, c)^{2}$, we can find

$$
\begin{aligned}
V_{3}(\varepsilon)= & \frac{1}{\pi} \int_{[0, t]^{3}} \mathbb{1}_{(0, t)}(a+b+c)(t-a-b-c) \mu|\varepsilon I+\Sigma|^{-\frac{3}{2}} d a d b d c \\
= & \frac{1}{\pi} \int_{\left[0, t \varepsilon^{\left.-\frac{3}{4}\right]^{2} \times[0, t]}\right.} \mathbb{1}_{(0, t)}\left(b+\varepsilon^{\frac{3}{4}}(a+c)\right) \\
& \quad \times \frac{\left(t-b-\varepsilon^{\frac{3}{4}}(a+c)\right) \varepsilon^{-\frac{3}{2}} \mu\left(\varepsilon^{\frac{3}{4}} a+b, \varepsilon^{\frac{3}{4}} a, \varepsilon^{\frac{3}{4}} c\right)}{\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)-\varepsilon^{-2} \mu\left(\varepsilon^{\frac{3}{4}} a+b, \varepsilon^{\frac{3}{4}} a, \varepsilon^{\frac{3}{4}} c\right)^{2}\right]^{\frac{3}{2}}} d b d a d c,
\end{aligned}
$$

where we change the coordinates $(a, b, c)$ by $\left(\varepsilon^{-\frac{3}{4}} a, b, \varepsilon^{-\frac{3}{4}} c\right)$ in the last equality.
By the definition of $\mu(a+b, a, c)$, it is easy to find

$$
\mu\left(\varepsilon^{\frac{3}{4}} a+b, \varepsilon^{\frac{3}{4}} a, \varepsilon^{\frac{3}{4}} c\right)=\frac{2}{9} \varepsilon^{\frac{3}{2}} a c \int_{[0,1]^{2}}\left(b+\varepsilon^{\frac{3}{4}} a v_{1}+\varepsilon^{\frac{3}{4}} c v_{2}\right)^{-\frac{2}{3}} d v_{1} d v_{2}
$$

and

$$
\varepsilon^{-\frac{3}{2}} \mu\left(\varepsilon^{\frac{3}{4}} a+b, \varepsilon^{\frac{3}{4}} a, \varepsilon^{\frac{3}{4}} c\right)=\frac{2}{9} a c b^{-\frac{2}{3}}+O\left(\varepsilon^{\frac{3}{4}} a c(a+c)\right) .
$$

The other part of the integrand in $V_{3}(\varepsilon)$ is

$$
\begin{aligned}
& {\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)-\varepsilon^{-2} \mu\left(\varepsilon^{\frac{3}{4}} a+b, \varepsilon^{\frac{3}{4}} a, \varepsilon^{\frac{3}{4}} c\right)^{2}\right]^{-\frac{3}{2}}} \\
& \quad=\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}}+O\left(\varepsilon a^{2} c^{2}\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{5}{2}}\right)
\end{aligned}
$$

Since

$$
\begin{align*}
& \frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \int_{\left[0, t \varepsilon^{-\frac{3}{4}}\right]^{2}} \varepsilon^{\frac{3}{4}} a c(a+c)\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} d a d c \\
& \quad+\frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \int_{\left[0, t \varepsilon^{-\frac{3}{4}}\right]^{2}} \varepsilon a^{3} c^{3}\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{5}{2}} d a d c  \tag{3.7}\\
& \rightarrow 0
\end{align*}
$$

as $\varepsilon \rightarrow 0$. Then, by L'Hôspital's rule, we have

$$
\begin{align*}
\lim _{\varepsilon \rightarrow 0} \frac{V_{3}(\varepsilon)}{\left(\log \frac{1}{\varepsilon}\right)^{2}}= & \frac{2}{9 \pi} \int_{0}^{t}(t-b) b^{-\frac{2}{3}} d b \\
& \times \lim _{\varepsilon \rightarrow 0} \frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \int_{\left[0, t \varepsilon^{\left.-\frac{3}{4}\right]^{2}}\right.} a c\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} d a d c  \tag{3.8}\\
= & \frac{t^{\frac{4}{3}}}{8 \pi} B\left(2, \frac{1}{3}\right)
\end{align*}
$$

Together (3.4)-(3.8), we can see

$$
\lim _{\varepsilon \rightarrow 0} \mathbb{E}\left[\left|\frac{1}{\log \frac{1}{\varepsilon}} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0)\right|^{2}\right]=\frac{t^{\frac{4}{3}}}{8 \pi} B\left(2, \frac{1}{3}\right)=: \sigma^{2}
$$

Lemma 3.2 For $I_{1}\left(f_{1, \varepsilon}\right)$ given in (3.3), then

$$
\lim _{\varepsilon \rightarrow 0} \mathbb{E}\left[\left|\frac{1}{\log \frac{1}{\varepsilon}} I_{1}\left(f_{1, \varepsilon}\right)\right|^{2}\right]=\sigma^{2}
$$

Proof. Form (3.3), we can find

$$
\mathbb{E}\left[\left|\frac{1}{\log \frac{1}{\varepsilon}} I_{1}\left(f_{1, \varepsilon}\right)\right|^{2}\right]=\frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}}\left(V_{1}^{(1)}(\varepsilon)+V_{2}^{(1)}(\varepsilon)+V_{3}^{(1)}(\varepsilon)\right)
$$

where $V_{i}^{(1)}(\varepsilon)=2 \int_{D_{i}}\left\langle f_{1, \varepsilon, s_{1}, r_{1}}, f_{1, \varepsilon, s_{2}, r_{2}}\right\rangle_{\mathfrak{H}} d r_{1} d r_{2} d s_{1} d s_{2}$ for $i=1,2,3$. Then we have

$$
\begin{equation*}
0 \leq V_{i}^{(1)}(\varepsilon) \leq V_{i}(\varepsilon) \tag{3.9}
\end{equation*}
$$

since $H>\frac{1}{2}$ and $\mu$ can only take positive values.
Combining (3.9) with (3.4)-(3.6), we can see

$$
\lim _{\varepsilon \rightarrow 0} \frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}}\left(V_{1}^{(1)}(\varepsilon)+V_{2}^{(1)}(\varepsilon)\right)=0
$$

Thus, we only need to consider $\frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} V_{3}^{(1)}(\varepsilon)$ as $\varepsilon \rightarrow 0$.

By the proof of Lemma 5.7 in Jaramillo and Nualart [5], we have

$$
\begin{aligned}
V_{3}^{(1)}(\varepsilon)= & \frac{1}{\pi} \int_{S_{3}} G_{\varepsilon, r^{\prime}-r}^{(1)}\left(s-r, s^{\prime}-r^{\prime}\right) \\
= & \frac{1}{\pi} \int_{[0, t]^{3}} \int_{0}^{t-(a+b+c)} \mathbb{1}_{(0, t)}(a+b+c)\left(\varepsilon+a^{\frac{4}{3}}\right)^{-\frac{3}{2}}\left(\varepsilon+c^{\frac{4}{3}}\right)^{-\frac{3}{2}} \mu(a+b, a, c) d s_{1} d a d b d c \\
= & \frac{2}{9 \pi} \int_{0}^{t} \int_{\left[0, t \varepsilon^{-\frac{3}{4}}\right]^{2}} \int_{[0,1]^{2}} \mathbb{1}_{(0, t)}\left(\left(b+\varepsilon^{\frac{3}{4}}(a+c)\right)\left(t-b-\varepsilon^{\frac{3}{4}}(a+c)\right)\right. \\
& \quad \times\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} a c\left(b+\varepsilon^{\frac{3}{4}}\left(a v_{1}+c v_{2}\right)\right)^{-\frac{2}{3}} d v_{1} d v_{2} d a d c d b .
\end{aligned}
$$

Note that

$$
\int_{[0,1]^{2}}\left(b+\varepsilon^{\frac{3}{4}}\left(a v_{1}+c v_{2}\right)\right)^{-\frac{2}{3}} d v_{1} d v_{2}=b^{-\frac{2}{3}}+O\left(\varepsilon^{\frac{3}{4}}(a+c)\right)
$$

and

$$
\begin{aligned}
\int_{[0,1]^{2}} & \left(t-b-\varepsilon^{\frac{3}{4}}(a+c)\right)\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} a c\left(b+\varepsilon^{\frac{3}{4}}\left(a v_{1}+c v_{2}\right)\right)^{-\frac{2}{3}} d v_{1} d v_{2} \\
& =(t-b) b^{-\frac{2}{3}} a c\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}}+O\left(\varepsilon^{\frac{3}{4}}(a+c) a c\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}}\right) .
\end{aligned}
$$

Similar to (3.7) and (3.8), we can find that

$$
\lim _{\varepsilon \rightarrow 0} \frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \int_{\left[0, t \varepsilon^{-\frac{3}{4}}\right]^{2}} \varepsilon^{\frac{3}{4}}(a+c) a c\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} d a d c=0
$$

and

$$
\lim _{\varepsilon \rightarrow 0} \frac{1}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \int_{\left[0, t \varepsilon^{-\frac{3}{4}}\right]^{2}} a c\left[\left(1+a^{\frac{4}{3}}\right)\left(1+c^{\frac{4}{3}}\right)\right]^{-\frac{3}{2}} d a d c=\frac{9}{16} .
$$

Thus,

$$
\begin{aligned}
\lim _{\varepsilon \rightarrow 0} \frac{V_{3}^{(1)}(\varepsilon)}{\left(\log \frac{1}{\varepsilon}\right)^{2}} & =\frac{2}{9 \pi} \int_{0}^{t} \frac{9}{16}(t-b) b^{-\frac{2}{3}} d b \\
& =\lim _{\varepsilon \rightarrow 0} \frac{V_{3}(\varepsilon)}{\left(\log \frac{1}{\varepsilon}\right)^{2}} \\
& =\sigma^{2}
\end{aligned}
$$

## Proof of Theorem 1.4

By Lemmas 3.1-3.2 and

$$
\widehat{\alpha}_{t, \varepsilon}^{\prime}(0)=I_{1}\left(f_{1, \varepsilon}\right)+\sum_{q=2}^{\infty} I_{2 q-1}\left(f_{2 q-1, \varepsilon}\right),
$$

we can see

$$
\lim _{\varepsilon \rightarrow 0} \mathbb{E}\left[\left\lfloor\left.\frac{1}{\log \frac{1}{\varepsilon}} \sum_{q=2}^{\infty} I_{2 q-1}\left(f_{2 q-1, \varepsilon}\right)\right|^{2}\right]=0\right.
$$

Since $I_{1}\left(f_{1, \varepsilon}\right)$ is Gaussian, then we have, as $\varepsilon \rightarrow 0$,

$$
\left(\log \frac{1}{\varepsilon}\right)^{-1} I_{1}\left(f_{1, \varepsilon}\right) \xrightarrow{\text { law }} N\left(0, \sigma^{2}\right) .
$$

Thus,

$$
\left(\log \frac{1}{\varepsilon}\right)^{-1} \widehat{\alpha}_{t, \varepsilon}^{\prime}(0) \xrightarrow{\operatorname{low}} N\left(0, \sigma^{2}\right)
$$

as $\varepsilon \rightarrow 0$. This completes the proof.
