# STOCHASTIC NAVIER-STOKES EQUATIONS ON A 3D THIN DOMAIN

#### Abstract

Stochastic Navier-Stokes equations in a thin three-dimensional domain are considered, driven by additive noise. The convergence of martingale solution of the stochastic Navier-Stokes equations in a thin three-dimensional domain to the unique martingale solution of the 2D stochastic Navier-Stokes equations, as the thickness of the film vanishes, is established. Hence, we justify the approximation of 3D Navier-Stokes equations driven by random forcing by its corresponding two-dimensional setting in applications.


## 1. Introduction

For various motivations, partial differential equations in thin domains has been studied extensively in last few decades; e.g. Babin and Vishik [3], Ciarlet [15], Ghidaglia and Temam [17], Marsden et.al. [28], Kaizu and Saito [24] and references there in. The study of the Navier-Stokes equations (NSE) on thin domains originates in a series of papers by Hale and Raugel [18]-[20] concerning the reaction-diffusion and damped wave equations on thin domains. Raugel and Sell $[34,35]$ proved the global existence of strong solutions to NSE on thin domains for large initial data and forcing terms, in the case of purely periodic and periodic-Dirichlet boundary conditions. Later, by applying a contraction principle argument and carefully analysing the dependence of the solution on the first eigenvalue of the corresponding Laplace operator, Arvin [2] showed global existence of strong solutions of the Navier-Stokes equations on thin three-dimensional domains for large data. Temam and Ziane [37] generalised the results of [34, 35] to other boundary conditions. Moise et.al. [32] proved global existence of strong solutions for initial data larger than in [35]. Iftimie [21] showed the existence and uniqueness of solutions for less regular initial data which was

[^0]further improved by Iftimie and Raugel [22] by reducing the regularity and increasing the size of initial data and forcing.

More recently, stochastic 3D Navier-Stokes equations in a thin three dimensional domain $\mathbb{O}_{\varepsilon}=\mathbb{T}^{2} \times(0, \varepsilon)$, where $\mathbb{T}^{2}$ is a two-dimensional torus, was investigated by Chueshov and Kuksin in [13] in which the authors considered the 3D NSE in $\mathbb{O}_{\varepsilon}$ perturbed by a random kick-force and proved that if the force is not too big and is genuinely random then the equation has a unique stationary measure.

The main objective of our paper is to establish the convergence of the martingale solution $\widetilde{u}_{\varepsilon}$ (more specifically the averages in thin direction $\stackrel{\circ}{M}_{\varepsilon} \widetilde{u}_{\varepsilon}$, see (3.21) for the definition of $\stackrel{\circ}{M}_{\varepsilon}$ ) of the stochastic Navier-Stokes equations (SNSE) described in a thin domain $Q_{\varepsilon}$ [16, 7, 12], to the martingale solution of the 2D stochastic Navier-Stokes equations on a bounded domain $Q \subset \mathbb{R}^{2}[7]$, as thickness $\varepsilon$ of the thin domain converges to zero, Theorem 4.5.

After having finished this article, we came across the paper [14] by Chueshov and Kuksin, in which the authors proved the existence and the uniqueness of a solution $u_{\varepsilon}^{\alpha}$ to the so called Leray- $\alpha$ approximation; see [26], of the stochastic 3D Navier-Stokes equations (4.24) and in Proposition 12 [14], a result similar to ours is stated, see Remark 4.7 for more detailed discussion.

We study the stochastic Navier-Stokes equations (SNSE) for incompressible fluid

In the above, $\widetilde{u}_{\varepsilon}=\left(\widetilde{u}_{\varepsilon, 1}, \widetilde{u}_{\varepsilon, 2}, \widetilde{u}_{\varepsilon, 3}\right)$ is the fluid velocity field, $p$ is the pressure, $\nu>0$ is a (fixed) kinematic viscosity, $\widetilde{u}_{0}^{\varepsilon}$ is a divergence free vector field on $Q_{\varepsilon}$ and

$\widetilde{W}_{\varepsilon}(t), t \geq 0$ is an $\mathbb{R}^{N}$-valued Wiener process in some probability space $(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P})$ to be defined precisely later.

The main result of this paper is Theorem 4.5 where we prove the convergence of the averages in the vertical direction of the martingale solution (see Definition 4.1) of the 3D
stochastic equations (1.1)-(1.6), as the thickness $\varepsilon \rightarrow 0$, to a martingale solution $u$ (see Definition 4.3) of the following 2D stochastic Navier-Stokes equations in $Q$ :

where $u=\left(u_{1}, u_{2}\right), \Delta^{\prime}, \nabla^{\prime}$ and $\operatorname{div}^{\prime}$ are the Laplacian, gradient and divergence operators respectively defined for a $\mathbb{R}^{2}$-valued function. Assumptions on initial data and external forcing will be stated later.

An interesting observation here is that, for $\varepsilon>0$, existence of a martingale solution for the 3D SNSE (1.1)-(1.6) is known, see [16, 7], but the uniqueness of such a martingale solution is not known (as is the case for deterministic 3D NSE). Whereas, for the 2D NSE in a bounded domain (1.8)-(1.11), there exists a unique martingale solution, see [11, 13] and references therein. Thus, irrespective of which martingale solution $\widetilde{u}_{\varepsilon}$ of (1.1)-(1.6) we choose in Theorem 4.5, the limiting object $\widehat{u}$ will be the same, the unique martingale solution to (1.8)-(1.11).

The article is organised as follows. We introduce necessary functional spaces, Stokes operator and bilinear map $B$ corresponding to the nonlinearity in $\S 2$. In $\S 3$, we define some averaging operators which are essential tools required in the further analysis and give their properties. Stochastic Navier-Stokes equations on a thin domain $Q_{\varepsilon}$ are introduced in $\S 4$ and a priori estimates for the vertically averaged velocity are obtained which are later used to prove the convergence of the average of a martingale solution $\widetilde{u}_{\varepsilon}$, of stochastic NSE on a thin domain (see (4.1)-(4.5)), to a martingale solution of the 2D stochastic NSE on $Q$ (see (4.8)-(4.11)) with vanishing thickness, see Theorem 4.5.

## 2. Preliminaries

A point $\mathbf{x} \in Q_{\varepsilon}$ will be represented in the Cartesian coordinates $\mathbf{x}=\left(x_{1}, x_{2}, x_{3}\right)$ or by $\mathbf{x}=\left(\mathbf{x}^{\prime}, x_{3}\right)$ where $\mathbf{x}^{\prime}=\left(x_{1}, x_{2}\right) \in Q$ and $x_{3} \in(0, \varepsilon)$.
2.1. Function spaces. For $p \in[1, \infty)$, by $L^{p}\left(Q_{\varepsilon}\right)$, we denote the Banach space of (equivalenceclasses of) Lebesgue measurable $\mathbb{R}$-valued $p$ th power integrable functions on $Q_{\varepsilon}$. The $\mathbb{R}^{3}$ valued $p$ th power integrable vector fields will be denoted by $\mathbb{L}^{p}\left(Q_{\varepsilon}\right)$. The norm in $\mathbb{L}^{p}\left(Q_{\varepsilon}\right)$ is given by

This is a Banach space with the norm

The Lebesgue and Sobolev spaces on $Q$ for $R^{2}$-valued vector fields will be denoted by $\mathbb{L}^{p}(Q)$ and $\mathbb{W}^{m, q}(Q)$ respectively for $1 \leq p, q \leq \infty$ and $m \in \mathbb{Z}$. In particular, we will write $\mathbb{H}^{1}(Q)$ for $\mathbb{W}^{1,2}(Q)$.

Next, we recall the ususal spaces appearing in the analysis of NSE:

where $\vec{n}_{\varepsilon}$ is the external unit normal vector field to $\partial Q_{\varepsilon}$, e.g. $\vec{n}_{\varepsilon}\left(\mathbf{x}^{\prime}, x_{3}\right)=\left(\vec{n}\left(\mathbf{x}^{\prime}\right), 0\right)$ for $\left(\mathrm{x}^{\prime}, y\right) \in \Gamma_{\ell}^{\varepsilon}$. Note also that $\vec{n}_{\varepsilon}=(0,0, \pm 1)$ on $\Gamma_{h}^{\varepsilon, \pm}$.

If $u \in \mathrm{H}_{\varepsilon}$ then $u_{3}=0$ on $\Gamma_{h}^{\varepsilon}$. Thus, $\mathrm{H}_{\varepsilon}$ can be further characterised as

For later use, let us introduce the following function space:

2.2. The Stokes operator. The Stokes operator $\mathrm{A}: D(\mathrm{~A}) \rightarrow \mathrm{H}$ for $D(\mathrm{~A})=\mathrm{H} \cap$ $H_{0}^{2}\left(Q, \mathbb{R}^{2}\right)$ is given by

where $\Delta^{\prime}=\partial_{1}^{2}+\partial_{2}^{2}$ is the Laplacian on $\mathbb{R}^{2}$ and $\pi$ is the Leray-Helmholtz projection operator from $L^{2}\left(Q ; \mathbb{R}^{2}\right)$ onto H . The operator A is associated with a coercive bilinear form $a: \mathrm{V} \times \mathrm{V} \rightarrow \mathbb{R}$,

Note that for $\mathrm{H}_{\varepsilon} \ni u_{\varepsilon}=\left(u^{\prime}, u_{\varepsilon, 3}\right)$, we have the condition $u_{\varepsilon} \cdot \vec{n}_{\varepsilon}=u^{\prime} \cdot \vec{n}=0$ on $\Gamma_{\ell}^{\varepsilon}$ which is weaker than the condition $u_{\varepsilon}=0$ on $\Gamma_{\ell}^{\varepsilon}$ for $u_{\varepsilon} \in \mathrm{V}_{\varepsilon}$.

It can be proved that $A_{\varepsilon}$ is self-adjoint in $\mathrm{H}_{\varepsilon}$ and from (2.12) and the definition of the bilinear form $a_{\varepsilon}$ we conclude

$$
\begin{equation*}
\mathrm{V}_{\varepsilon}^{*}\left\langle A_{\varepsilon} u, \mathrm{v}\right\rangle_{\mathrm{V}_{\varepsilon}}=\int_{Q_{\varepsilon}}(\nabla u, \nabla \mathrm{v})_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)} d x, \quad u, \mathrm{v} \in \mathrm{~V}_{\varepsilon} \tag{2.15}
\end{equation*}
$$

2.3. The nonlinear term. Let $b_{\varepsilon}$ be the continuous trilinear from on $V_{\varepsilon}$ defined by:

$$
\begin{equation*}
b_{\varepsilon}(u, \mathrm{v}, \mathrm{w})=\int_{Q_{\varepsilon}}(u \cdot \nabla) \mathrm{v} \cdot \mathrm{w} d \mathbf{x}, \quad u, \mathrm{v}, \mathrm{w} \in \mathrm{~V}_{\varepsilon} \tag{2.16}
\end{equation*}
$$

We denote by $B_{\varepsilon}$ the bilinear mapping from $\mathrm{V}_{\varepsilon} \times \mathrm{V}_{\varepsilon}$ to $\mathrm{V}_{\varepsilon}^{*}$ by

$$
\begin{equation*}
\mathrm{V}_{\varepsilon}^{*}\left\langle B_{\varepsilon}(u, \mathrm{v}), \mathrm{w}\right\rangle_{\mathrm{V}_{\varepsilon}}=b_{\varepsilon}(u, \mathrm{v}, \mathrm{w}), \quad u, \mathrm{v}, \mathrm{w} \in \mathrm{~V}_{\varepsilon} \tag{2.17}
\end{equation*}
$$

and we set

$$
B_{\varepsilon}(u)=B_{\varepsilon}(u, u)
$$

Let us also recall the following properties of the form $b_{\varepsilon}$, which directly follows from the definition of $b_{\varepsilon}$ :

$$
\begin{equation*}
b_{\varepsilon}(u, \mathrm{v}, \mathrm{w})=-b_{\varepsilon}(u, \mathrm{w}, \mathrm{v}), \quad u, \mathrm{v}, \mathrm{w} \in \mathrm{~V}_{\varepsilon} \tag{2.18}
\end{equation*}
$$

In particular,

$$
\begin{equation*}
\mathrm{V}_{\varepsilon}^{*}\left\langle B_{\varepsilon}(u, \mathrm{v}), \mathrm{v}\right\rangle_{\mathrm{V}_{\varepsilon}}=b_{\varepsilon}(u, \mathrm{v}, \mathrm{v})=0, \quad u, \mathrm{v} \in \mathrm{~V}_{\varepsilon} \tag{2.19}
\end{equation*}
$$

Analogously, we can define trilinear form $b$ on V and bilnear map $B: \mathrm{V} \times \mathrm{V} \rightarrow \mathrm{V}^{*}$ corresponding to the nonlinearity appearing in 2D NSE, i.e.

\begin{align*}
b(u, \mathrm{v}, \mathrm{w})=\int_{Q}(u \cdot \nabla) \mathrm{v} \cdot \mathrm{w} d \mathrm{x}, & u, \mathrm{v}, \mathrm{w} \in \mathrm{~V}  \tag{2.20}\\
\mathrm{~V}^{*}\langle B(u, \mathrm{v}), \mathrm{w}\rangle_{\mathrm{V}}=b(u, \mathrm{v}, \mathrm{w}), & u, \mathrm{v}, \mathrm{w} \in \mathrm{~V} \tag{2.21}
\end{align*}
$$

The properties analogous to (2.18) and (2.19) hold for maps $b$ and $B$ too.

## 3. Averaging operators and their properties

3.1. Some definitions. In this section we recall the averaging operators which were first introduced by Raugel and Sell [34, 35] to study the well-posedness of Navier-Stokes equations on thin 3D domains and existence of global attractors for such a system. Later, Temam and Ziane [37] used these operators to establish the global existence of strong solutions for Navier-Stokes equations in thin 3D domains with various boundary conditions when initial data belongs to "large sets" (see [37] for precise definition). They also used these operators to show that the average of the above obtained strong solution in the thin direction converges to the strong solution of a 2D Navier-Stokes system of equation as thickness $\varepsilon$ goes to zero.

In this section we will recall these averaging operators according to our requirement and provide proofs of some of the results for the ease of the reader.

Let $M_{\varepsilon}: C\left(Q_{\varepsilon} ; \mathbb{R}^{3}\right) \rightarrow C\left(Q ; \mathbb{R}^{2}\right)$ be the averaging map; a map that averages the functions defined on thin domains $Q_{\varepsilon}$ in the vertical direction and projects to functions defined on $Q$, and is defined by

$$
\begin{equation*}
\left(M_{\varepsilon} \psi\right)\left(\mathbf{x}^{\prime}\right):=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}, \quad \mathbf{x}^{\prime} \in Q \tag{3.1}
\end{equation*}
$$

Lemma 3.1. The map $M_{\varepsilon}$ as defined in (3.1) is continuous (and linear) with respect to norms $L^{2}\left(Q_{\varepsilon}\right)$ and $L^{2}(Q)$. Moreover,

$$
\begin{equation*}
\left\|M_{\varepsilon} \psi\right\|_{L^{2}(Q)}^{2} \leq \frac{1}{\varepsilon}\|\psi\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}, \quad \psi \in L^{2}\left(Q_{\varepsilon}\right) \tag{3.2}
\end{equation*}
$$

Proof. Take $\psi \in C\left(Q_{\varepsilon}\right)$ then by definition of $M_{\varepsilon}$ we have

$$
M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}
$$

Thus, using the Cauchy-Schwarz inequality we have

\left\|M_{\varepsilon} \psi\right\|_{L^{2}(Q)}^{2}=\int_{Q}\left|M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right)\right|^{2} d \mathbf{x}^{\prime} & =\int_{Q}\left|\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right|^{2} d \mathbf{x}^{\prime} \\
& \leq \frac{1}{\varepsilon^{2}} \int_{Q}\left(\int_{0}^{\varepsilon}\left|\psi\left(\mathbf{x}^{\prime}, x_{3}\right)\right|^{2} d x_{3} \int_{0}^{\varepsilon} d x_{3}\right) d \mathbf{x}^{\prime} \\
& =\frac{1}{\varepsilon^{2}} \cdot \varepsilon \int_{0}^{\varepsilon} \int_{Q}\left|\psi\left(\mathbf{x}^{\prime}, x_{3}\right)\right|^{2} d x_{3} d \mathbf{x}^{\prime} \\
& =\frac{1}{\varepsilon}\|\psi\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}
\end{aligned}
$$

Therefore, we obtain

$$
\begin{equation*}
\left\|M_{\varepsilon} \psi\right\|_{L^{2}(Q)}^{2} \leq \frac{1}{\varepsilon}\|\psi\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2} \tag{3.3}
\end{equation*}
$$

showing the map $M_{\varepsilon}$ bounded and we can infer (3.2).

Corollary 3.2. The map $M_{\varepsilon}$ as defined in (3.1) has a unique extension, which without the abuse of notation will be denoted by the same symbol $M_{\varepsilon}: L^{2}\left(Q_{\varepsilon}\right) \rightarrow L^{2}(Q)$.
Proof. Since $C\left(Q_{\varepsilon}\right)$ is dense in $L^{2}\left(Q_{\varepsilon}\right)$ and $M_{\varepsilon}: L^{2}\left(Q_{\varepsilon}\right) \rightarrow L^{2}(Q)$ is a bounded map thus by the Riesz representation theorem there exists a unique extension.
Remark 3.3. It is easy to check that the dual operator $M_{\varepsilon}^{*}: L^{2}(Q) \rightarrow L^{2}\left(Q_{\varepsilon}\right)$ is given by

$$
\left(M_{\varepsilon}^{*} \psi\right)\left(\mathbf{x}^{\prime}, x_{3}\right)=\frac{1}{\varepsilon} g\left(\mathbf{x}^{\prime}\right), \quad\left(\mathbf{x}^{\prime}, x_{3}\right) \in Q_{\varepsilon} .
$$

Note that if $\psi$ is independent of $x_{3}$, i.e. $\psi\left(x^{\prime}, x_{3}\right) \equiv \xi\left(x^{\prime}\right)$ for all $x_{3} \in(0, \varepsilon)$ then $\left(M_{\varepsilon} \psi\right)\left(\mathbf{x}^{\prime}\right)=\xi\left(\mathbf{x}^{\prime}\right)$ for $x^{\prime} \in Q$.
We define another map $\widehat{\widehat{M}_{\varepsilon}}$,

$$
\begin{align*}
& \widehat{M}_{\varepsilon}: L^{2}\left(Q_{\varepsilon}\right) \rightarrow L^{2}\left(Q_{\varepsilon}\right) \\
& \widehat{M}_{\varepsilon} \psi\left(\mathbf{x}^{\prime}, y_{3}\right)=M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right), \quad\left(\mathbf{x}^{\prime}, y_{3}\right) \in Q_{\varepsilon}, \tag{3.4}
\end{align*}
$$

and for such a map we have the following scaling property:
Lemma 3.4. Let $\psi \in L^{2}\left(Q_{\varepsilon}\right)$, then

$$
\begin{equation*}
\left\|\widehat{M}_{\varepsilon} \psi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}=\varepsilon\left\|M_{\varepsilon} \psi\right\|_{L^{2}(Q)}^{2} . \tag{3.5}
\end{equation*}
$$

Proof. Let $\psi \in L^{2}\left(Q_{\varepsilon}\right)$. Then by the definition of the map $\widehat{M}_{\varepsilon}$ and the Fubini Theorem, we have

$$
\begin{aligned}
\left\|\widehat{M}_{\varepsilon} \psi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2} & =\int_{Q_{\varepsilon}}\left|\widehat{M}_{\varepsilon} \psi(\mathbf{x})\right|^{2} d \mathbf{x}=\int_{Q} \int_{0}^{\varepsilon}\left|\widehat{M}_{\varepsilon} \psi\left(\mathbf{x}^{\prime}, y_{3}\right)\right|^{2} d \mathbf{x}^{\prime} d y_{3} \\
& =\int_{Q} \int_{0}^{\varepsilon}\left|M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right)\right|^{2} d \mathbf{x}^{\prime} d y_{3}=\varepsilon\left\|M_{\varepsilon} \psi\right\|_{L^{2}(Q)}^{2} .
\end{aligned}
$$

The orthogonal component $\widehat{N}_{\varepsilon}$, of the planar projection map $\widehat{M}_{\varepsilon}$ is defined by

$$
\begin{equation*}
\widehat{N}_{\varepsilon}=\mathrm{Id}-\widehat{M}_{\varepsilon} \tag{3.6}
\end{equation*}
$$

i.e.

$$
\widehat{N}_{\varepsilon}: L^{2}\left(Q_{\varepsilon}\right) \ni \psi \mapsto \psi-\widehat{M}_{\varepsilon} \psi \in L^{2}\left(Q_{\varepsilon}\right),
$$

where Id is the identity on $L^{2}\left(Q_{\varepsilon}\right)$.
3.2. Properties of the maps. In the following lemma we establish an important property of the map $\widehat{N}_{\varepsilon}$.

Lemma 3.5. Let $\psi \in L^{2}\left(Q_{\varepsilon}\right)$, then

$$
\begin{equation*}
\int_{0}^{\varepsilon} \widehat{N}_{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}=0, \quad \text { for a.a. } \mathbf{x}^{\prime} \in Q . \tag{3.7}
\end{equation*}
$$

Proof. Let us choose and fix $\psi \in L^{2}\left(Q_{\varepsilon}\right)$. Then by the definitions of the operators involved we have the following equality in $L^{2}(Q)$ :

\int_{0}^{\varepsilon} \widehat{N}_{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}=\varepsilon\left[M_{\varepsilon} \widehat{N}_{\varepsilon} \psi\right]\left(\mathbf{x}^{\prime}\right)

Therefore , we deduce that in order to prove equality (3.7), it is sufficient to show that

Hence, by taking into account definitions (3.6) of $\widehat{N}_{\varepsilon}$, we infer that it is sufficient to prove that

$$
M_{\varepsilon} \circ \widehat{M}_{\varepsilon}=M_{\varepsilon}
$$

Let us choose $\psi \in C\left(Q_{\varepsilon}\right)$ and put $\phi=\widehat{M}_{\varepsilon} \psi$, i.e.

$$
\phi\left(\mathbf{x}^{\prime}, y_{3}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}, \quad y_{3} \in(0, \varepsilon)
$$

Thus,

$$
\begin{aligned}
{\left[M_{\varepsilon} \phi\right]\left(\mathbf{x}^{\prime}\right) } & =\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \phi\left(\mathbf{x}^{\prime}, y_{3}\right) d y_{3}=\frac{1}{\varepsilon} \int_{0}^{\varepsilon}\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) d y_{3} \\
& =\frac{1}{\varepsilon} \int_{0}^{\varepsilon} M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right) d y_{3}=M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right), \quad \mathbf{x}^{\prime} \in Q
\end{aligned}
$$

Thus, we proved $M_{\varepsilon} \circ \widehat{M}_{\varepsilon} \psi=M_{\varepsilon} \psi$ for every $\psi \in C\left(Q_{\varepsilon}\right)$. Since $C\left(Q_{\varepsilon}\right)$ is dense in $L^{2}\left(Q_{\varepsilon}\right)$ and the maps $M_{\varepsilon}$ and $M_{\varepsilon} \circ \widehat{M}_{\varepsilon}$ are bounded in $L^{2}\left(Q_{\varepsilon}\right)$, we conclude that we have proved (3.7).

In the following two lemmas we enlist some properties of operators $\widehat{M}_{\varepsilon}$ and $\widehat{N}_{\varepsilon}$ which we will use repeatedly later in this and following sections.

Lemma 3.6. Let $\varepsilon>0$ and $\widehat{M}_{\varepsilon}, \widehat{N}_{\varepsilon}$ be the maps defined as in (3.4) and (3.6) respectively. Then for $\psi \in L^{2}\left(Q_{\varepsilon}\right)$

$$
\begin{align*}
& \widehat{M}_{\varepsilon}\left(\widehat{M}_{\varepsilon} \psi\right)=\widehat{M}_{\varepsilon} \psi  \tag{3.8}\\
& \widehat{N}_{\varepsilon}\left(\widehat{N}_{\varepsilon} \psi\right)=\widehat{N}_{\varepsilon} \psi  \tag{3.9}\\
& \widehat{M}_{\varepsilon}\left(\widehat{N}_{\varepsilon} \psi\right)=0, \quad \text { and } \quad \widehat{N}_{\varepsilon}\left(\widehat{M}_{\varepsilon} \psi\right)=0 \tag{3.10}
\end{align*}
$$

Proof. Let $\psi \in C\left(Q_{\varepsilon}\right)$. Put $\phi=\widehat{M}_{\varepsilon} \psi$, i.e for every $y_{3} \in(0, \varepsilon)$

$$
\phi\left(\mathbf{x}^{\prime}, y_{3}\right)=\left[M_{\varepsilon} \psi\right]\left(\mathbf{x}^{\prime}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}
$$

Next for $z_{3} \in(0, \varepsilon)$,

$$
\left[\widehat{M}_{\varepsilon} \phi\right]\left(\mathbf{x}^{\prime}, z_{3}\right)=\left[M_{\varepsilon} \phi\right]\left(\mathbf{x}^{\prime}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \phi\left(\mathbf{x}^{\prime}, y_{3}\right) d y_{3}
$$

$$
\begin{aligned}
& =\frac{1}{\varepsilon} \int_{0}^{\varepsilon}\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) d y_{3} \\
& =\frac{1}{\varepsilon} \int_{0}^{\varepsilon} M_{\varepsilon} \psi\left(\mathbf{x}^{\prime}\right) d y_{3}=\left[\widehat{M}_{\varepsilon} \psi\right]\left(\mathbf{x}^{\prime}, z_{3}\right)
\end{aligned}
$$

Hence, we proved (3.8) for every $\psi \in C\left(Q_{\varepsilon}\right)$. Since $C\left(Q_{\varepsilon}\right)$ is dense in $L^{2}\left(Q_{\varepsilon}\right)$ and $\widehat{M}_{\varepsilon}$ is a bounded map on $L^{2}\left(Q_{\varepsilon}\right)$, the identity holds true for every $\psi \in L^{2}\left(Q_{\varepsilon}\right)$.
Proof of first part of (3.10). Let $\psi \in C\left(Q_{\varepsilon}\right)$. Put $\phi=\widehat{N}_{\varepsilon} \psi \in C\left(Q_{\varepsilon}\right)$. By Lemma 3.5

\int_{0}^{\varepsilon} \phi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}=0
$$

Therefore, we infer that

\left[\widehat{M}_{\varepsilon} \phi\right]\left(\mathbf{x}^{\prime}, y_{3}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \phi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}=0
$$

for $\mathbf{x}^{\prime} \in Q$ and every $y_{3} \in(0, \varepsilon)$. Thus, we have established $(3.10)_{1}$ for all $\psi \in C\left(Q_{\varepsilon}\right)$. Using the density argument, we can extend it to all $\psi \in L^{2}\left(Q_{\varepsilon}\right)$.

For (3.9), by definition of $\widehat{N}_{\varepsilon}$ and (3.10) ${ }_{1}$, we obtain for $\psi \in L^{2}\left(Q_{\varepsilon}\right)$

$$
\widehat{N}_{\varepsilon}\left(\widehat{N}_{\varepsilon} \psi\right)=\widehat{N}_{\varepsilon} \psi-\widehat{M}_{\varepsilon}\left(\widehat{N}_{\varepsilon} \psi\right)=\widehat{N}_{\varepsilon} \psi
$$

Now for the second part of (3.10) again by the definition of $\widehat{N}_{\varepsilon}$ and (3.8), for $\psi \in L^{2}\left(Q_{\varepsilon}\right)$ :

$$
\widehat{N}_{\varepsilon}\left(\widehat{M}_{\varepsilon} \psi\right)=\widehat{M}_{\varepsilon} \psi-\widehat{M}_{\varepsilon}\left(\widehat{M}_{\varepsilon} \psi\right)=0
$$

Lemma 3.7. Let $\varepsilon>0$ and $\psi \in H^{1}\left(Q_{\varepsilon}\right)$. Then $\widehat{M}_{\varepsilon} \psi, \widehat{N}_{\varepsilon} \psi \in H^{1}\left(Q_{\varepsilon}\right)$. Moreover

$$
\left\|\nabla \widehat{M}_{\varepsilon} \psi\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} \leq\|\nabla \psi\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}
$$

Proof. Let $\varepsilon>0$ and $\psi \in H^{1}\left(Q_{\varepsilon}\right)$. The proof is a direct consequence of the definition of $\widehat{M}_{\varepsilon}, \widehat{N}_{\varepsilon}$, the scaling property (3.5) and the estimate (3.3).
Lemma 3.8. Let $\varepsilon>0$ and $\widehat{M}_{\varepsilon}, \widehat{N}_{\varepsilon}$ be the maps defined as in (3.4) and (3.6) respectively. Then
(i) $\widehat{M}_{\varepsilon}$ is self-adjoint on $L^{2}\left(Q_{\varepsilon}\right)$, i.e.

$$
\left(\widehat{M}_{\varepsilon} \psi, \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}=\left(\psi, \widehat{M}_{\varepsilon} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}, \quad \psi, \xi \in L^{2}\left(Q_{\varepsilon}\right)
$$

(ii) The ranges of $\widehat{M}_{\varepsilon}$ and $\widehat{N}_{\varepsilon}$ are perpendicular, i.e.

$$
\left(\widehat{M}_{\varepsilon} \psi, \widehat{N}_{\varepsilon} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}=0, \quad \psi, \xi \in L^{2}\left(Q_{\varepsilon}\right)
$$

(iii) If $\psi, \xi \in H^{1}\left(Q_{\varepsilon}\right)$ then

$$
\left(\nabla \widehat{M}_{\varepsilon} \psi, \nabla \widehat{N}_{\varepsilon} \xi\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=0
$$

Proof. (i) Let $\psi, \xi \in L^{2}\left(Q_{\varepsilon}\right)$, then by the definition of $\widehat{M}_{\varepsilon}$ :

$$
\begin{aligned}
\left(\widehat{M}_{\varepsilon} \psi, \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)} & =\int_{Q_{\varepsilon}}\left[\widehat{M}_{\varepsilon} \psi\right](\mathbf{x}) \xi(\mathbf{x}) d \mathbf{x} \\
& =\int_{Q} \int_{0}^{\varepsilon}\left[M_{\varepsilon} \psi\right]\left(\mathbf{x}^{\prime}\right) \xi\left(\mathbf{x}^{\prime}, x_{3}\right) d \mathbf{x}^{\prime} d x_{3} \\
& =\int_{Q}\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right)\left(\int_{0}^{\varepsilon} \xi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) d \mathbf{x}^{\prime} \\
& =\int_{Q} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right)\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \xi\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) d \mathbf{x}^{\prime} d x_{3} \\
& =\int_{Q} \int_{0}^{\varepsilon} \psi\left(\mathbf{x}^{\prime}, x_{3}\right) M_{\varepsilon} \xi\left(x^{\prime}\right) d \mathbf{x}^{\prime} d x_{3}=\left(\psi, \widehat{M}_{\varepsilon} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}
\end{aligned}
$$

showing that $\widehat{M}_{\varepsilon}$ is self adjoint on $L^{2}\left(Q_{\varepsilon}\right)$.
(ii) Recall from (3.8) that $\widehat{M}_{\varepsilon} \circ \widehat{M}_{\varepsilon}=\widehat{M}_{\varepsilon}$ and from (i) $\widehat{M}_{\varepsilon}$ is self-adjoint. Therefore, for $\psi, \xi \in L^{2}\left(Q_{\varepsilon}\right)$, using the definition of $\widehat{N}_{\varepsilon}$ :

$$
\begin{aligned}
\left(\widehat{M}_{\varepsilon} \psi, \widehat{N}_{\varepsilon} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)} & =\left(\widehat{M}_{\varepsilon} \psi, \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}-\left(\widehat{M}_{\varepsilon} \psi, \widehat{M}_{\varepsilon} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)} \\
& =\left(\widehat{M}_{\varepsilon} \psi, \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}-\left(\widehat{M}_{\varepsilon}\left(\widehat{M}_{\varepsilon} \psi\right), \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}=0,
\end{aligned}
$$

establishing the orthogonality of the ranges of $\widehat{M}_{\varepsilon}$ and $\widehat{N}_{\varepsilon}$.
(iii) Let $\psi, \xi \in H^{1}\left(Q_{\varepsilon}\right)$. First note that, since $\widehat{M}_{\varepsilon} \psi$ is independent of $x_{3}$, we have

$$
\nabla \widehat{M}_{\varepsilon} \psi=\left(\partial_{1} \widehat{M}_{\varepsilon} \psi, \partial_{2} \widehat{M}_{\varepsilon} \psi, \partial_{3} \widehat{M}_{\varepsilon} \psi\right)=\left(\widehat{M}_{\varepsilon} \partial_{1} \psi, \widehat{M}_{\varepsilon} \partial_{2} \psi, 0\right)
$$

Similarly,

$$
\nabla \widehat{N}_{\varepsilon} \xi=\left(\widehat{N}_{\varepsilon} \partial_{1} \xi, \widehat{N}_{\varepsilon} \partial_{2} \xi, \partial_{3} g\right)
$$

Hence, from (ii) we get

$$
\left(\nabla \widehat{M}_{\varepsilon} \psi, \nabla \widehat{N}_{\varepsilon} \xi\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=\left(\widehat{M}_{\varepsilon} \partial_{1} \psi, \widehat{N}_{\varepsilon} \partial_{1} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}+\left(\widehat{M}_{\varepsilon} \partial_{2} \psi, \widehat{N}_{\varepsilon} \partial_{2} \xi\right)_{L^{2}\left(Q_{\varepsilon}\right)}+0=0
$$

A direct consequence of Lemma 3.7 and Lemma 3.8 is the following corollary.
Corollary 3.9. Let $\varepsilon>0$ and $\psi \in L^{2}\left(Q_{\varepsilon}\right), \xi \in H^{1}\left(Q_{\varepsilon}\right)$. Then

$$
\begin{align*}
\|\psi\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2} & =\left\|\widehat{M}_{\varepsilon} \psi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}+\left\|\widehat{N}_{\varepsilon} \psi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2},  \tag{3.11}\\
\|\nabla \xi\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2} & =\left\|\nabla \widehat{M}_{\varepsilon} \xi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}+\left\|\nabla \widehat{N}_{\varepsilon} \xi\right\|_{L^{2}\left(Q_{\varepsilon}\right)}^{2}
\end{align*}
$$

Next we introduce the averaging operators for $\mathbb{R}^{3}$-valued vector fields using the maps defined above (for scalar functions) as follows:

$$
\begin{align*}
\widetilde{M}_{\varepsilon}: & \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \rightarrow \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \\
& u \mapsto\left(\widehat{M}_{\varepsilon} u_{1}, \widehat{M}_{\varepsilon} u_{2}, 0\right) \tag{3.12}
\end{align*}
$$

and

$$
\begin{equation*}
\widetilde{N}_{\varepsilon}=\operatorname{Id}-\widetilde{M}_{\varepsilon} \in \mathcal{L}\left(\mathbb{L}^{2}\left(Q_{\varepsilon}\right)\right) \tag{3.13}
\end{equation*}
$$

where Id is the identity map on $\mathbb{L}^{2}\left(Q_{\varepsilon}\right)$.
If $u$ is independent of $x_{3}$ and lives on $\mathbb{R}^{2}$, i.e. $u\left(\mathbf{x}^{\prime}, x_{3}\right)=\left(u_{1}\left(\mathbf{x}^{\prime}\right), u_{2}\left(\mathbf{x}^{\prime}\right), 0\right)$ then

$$
\widetilde{M}_{\varepsilon} u\left(\mathbf{x}^{\prime}, x_{3}\right)=\left(u_{1}\left(\mathbf{x}^{\prime}\right), u_{2}\left(\mathbf{x}^{\prime}\right), 0\right)=u\left(\mathbf{x}^{\prime}, x_{3}\right) \quad \text { for } \mathbf{x}^{\prime} \in Q
$$

Lemma 3.10. If a vector field $u: Q_{\varepsilon} \rightarrow \mathbb{R}^{3}$ satisfies the boundary conditions (1.4), i.e.

$$
u_{3}=0, \partial_{3} u_{j}=0 \text { for } j=1,2 \text { on } \Gamma_{h}^{\varepsilon} \text { and } u=0 \text { on } \Gamma_{\ell}^{\varepsilon}
$$

then

$$
\begin{align*}
& M_{\varepsilon} u_{1}=M_{\varepsilon} u_{2}=0 \text { on } \partial Q  \tag{3.14}\\
& \widetilde{N}_{\varepsilon} u \cdot \vec{n}_{\varepsilon}=0 \text { on } \Gamma_{h}^{\varepsilon} \tag{3.15}
\end{align*}
$$

Proof. Since $u=0$ on $\Gamma_{\ell}^{\varepsilon}=\partial Q \times[0, \varepsilon]$, so $u_{1}=u_{2}=0$ on $\partial Q \times[0, \varepsilon]$ and hence $M_{\varepsilon} u_{1}=$ $M_{\varepsilon} u_{2}=0$ on $\partial Q$. Now for (3.15), using the definition of $\widetilde{N}_{\varepsilon}, \widetilde{M}_{\varepsilon}$ we get

$$
\widetilde{N}_{\varepsilon} u=\left(\widehat{N}_{\varepsilon} u_{1}, \widehat{N}_{\varepsilon} u_{2}, u_{3}\right),
$$

and observing that $\vec{n}_{\varepsilon}=(0,0, \pm 1)$ on $\Gamma_{h}^{\varepsilon, \pm}, u_{3}=0$ on $\Gamma_{h}^{\varepsilon}$ we conclude that $\widetilde{N}_{\varepsilon} u \cdot \vec{n}_{\varepsilon}=0$.
Lemma 3.11. Let $u \in \mathrm{H}_{\varepsilon}$, then

$$
\operatorname{div} \widetilde{M}_{\varepsilon} u=0, \quad \text { and } \quad \operatorname{div} \widetilde{N}_{\varepsilon} u=0 \quad \text { in } Q_{\varepsilon}
$$

Proof. Let

$$
\mathrm{U}_{\varepsilon}:=\left\{u \in C^{\infty}\left(Q_{\varepsilon}\right): \operatorname{div} u=0 \text { in } Q_{\varepsilon} \text { and } u \cdot \vec{n}_{\varepsilon}=0 \text { on } \partial Q_{\varepsilon}\right\},
$$

and choose $u \in \mathrm{U}_{\varepsilon}$. Then by the definition of $\widetilde{M}_{\varepsilon}$, we have for $\mathbf{x}=\left(\mathbf{x}^{\prime}, x_{3}\right) \in Q_{\varepsilon}$

$$
\begin{aligned}
\operatorname{div} \widetilde{M}_{\varepsilon} u(\mathbf{x}) & =\partial_{1} \widehat{M}_{\varepsilon} u_{1}+\partial_{2} \widehat{M}_{\varepsilon} u_{2}+\partial_{3} 0 \\
& =\widehat{M}_{\varepsilon}\left[\partial_{1} u_{1}+\partial_{2} u_{2}\right] \\
& =-\widehat{M}_{\varepsilon} \partial_{3} u_{3}=-\frac{1}{\varepsilon} \int_{0}^{\varepsilon} \partial_{3} u_{3}\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3} \\
& =-\frac{1}{\varepsilon}\left[u_{3}\left(\mathbf{x}^{\prime}, \varepsilon\right)-u_{3}\left(\mathbf{x}^{\prime}, 0\right)\right]=0,
\end{aligned}
$$

where we used that $\operatorname{div} u=0$ in $Q_{\varepsilon}$ in the second last line and $u \cdot \vec{n}_{\varepsilon}=0$ on $\partial Q_{\varepsilon}$ in the last line. Thus, we have proved that div $\widetilde{M}_{\varepsilon}=0$ in $Q_{\varepsilon}$ for $u \in \mathrm{U}_{\varepsilon}$. Since $\mathrm{U}_{\varepsilon}$ is dense in $\mathrm{H}_{\varepsilon}$,
it holds true for every $u \in H_{\varepsilon}$ too. The second part of the lemma for $\widetilde{N}_{\varepsilon}$ follows directly from the definition of $\widetilde{N}_{\varepsilon}$ and first part of the lemma.

From Lemma 3.10 and Lemma 3.11, we infer the following corollary:
Corollary 3.12. If $u \in \mathrm{H}_{\varepsilon}$, then $\widetilde{M}_{\varepsilon} u$ and $\widetilde{N}_{\varepsilon} u$ belongs to $\mathrm{H}_{\varepsilon}$.
In the following lemma we extend the results from Lemma 3.6-Lemma 3.8 to the averaging maps $\widetilde{M}_{\varepsilon}$ and $\widetilde{N}_{\varepsilon}$ defined for vector valued functions. The proofs of each of the statements in the lemma can be carried out analogously to the scalar case.

Lemma 3.13. Let $\varepsilon>0$ and $\widetilde{M}_{\varepsilon}, \widetilde{N}_{\varepsilon}$ be the maps as defined in (3.12) and (3.13) respectively. Then
(i) for $u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$

$$
\begin{align*}
& \widetilde{M}_{\varepsilon}\left(\widetilde{M}_{\varepsilon} u\right)=\widetilde{M}_{\varepsilon} u,  \tag{3.16}\\
& \widetilde{N}_{\varepsilon}\left(\widetilde{N}_{\varepsilon} u\right)=\widetilde{N}_{\varepsilon} u,  \tag{3.17}\\
& \widetilde{M}_{\varepsilon}\left(\widetilde{N}_{\varepsilon} u\right)=0, \quad \text { and } \quad \widetilde{N}_{\varepsilon}\left(\widetilde{M}_{\varepsilon} u\right)=0 . \tag{3.18}
\end{align*}
$$

(ii) for $u \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right), \widetilde{M}_{\varepsilon} u, \widetilde{N}_{\varepsilon} u \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right)$ and

$$
\left\|\nabla \widetilde{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} \leq\|\nabla u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}
$$

(iii) $\widetilde{M}_{\varepsilon}$ is self-adjoint on $\mathbb{L}^{2}\left(Q_{\varepsilon}\right)$, i.e.

$$
\left(\widetilde{M}_{\varepsilon} u, \mathrm{v}\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=\left(u, \widetilde{M}_{\varepsilon} \mathrm{v}\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}, \quad u, \mathrm{v} \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)
$$

(iv) The ranges of $\widetilde{M}_{\varepsilon}$ and $\widetilde{N}_{\varepsilon}$ are perpendicular, i.e.

$$
\left(\widetilde{M}_{\varepsilon} u, \widetilde{N}_{\varepsilon} \mathrm{v}\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=0, \quad u, \mathrm{v} \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)
$$

(v) If $u, v \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right)$ then

$$
\left(\nabla \widetilde{M}_{\varepsilon} u, \nabla \widetilde{N}_{\varepsilon} \mathrm{v}\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=0
$$

From Lemma 3.13, we can deduce the following corollary.
Corollary 3.14. If $u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$, then

$$
\begin{equation*}
\left\|\widetilde{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}+\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}=\|u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} \tag{3.19}
\end{equation*}
$$

If $u \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right)$, then

$$
\begin{equation*}
\left\|\nabla \widetilde{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}+\left\|\nabla \widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}=\|\nabla u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} \tag{3.20}
\end{equation*}
$$

Finally, we define a map that projects $\mathbb{R}^{3}$-valued vector fields defined on $Q_{\varepsilon}$ to $\mathbb{R}^{2}$-valued vector fields defined on $Q$.

$$
\begin{align*}
\stackrel{\circ}{M}_{\varepsilon}: & \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \rightarrow \mathbb{L}^{2}(Q),  \tag{3.21}\\
& u \mapsto\left(M_{\varepsilon} u_{1}, M_{\varepsilon} u_{2}\right) .
\end{align*}
$$

We remark that while the range of $\widetilde{M}_{\varepsilon}$ equals to $\mathbb{L}^{2}\left(Q_{\varepsilon}, \mathbb{R}^{2}\right)$, the range of $\stackrel{\circ}{M}_{\varepsilon}$ equals to $\mathbb{L}^{2}\left(Q, \mathbb{R}^{2}\right)$.

Analogous to the scaling property for scalar functions and corresponding averaging maps we have a scaling property for $\widetilde{M}_{\varepsilon}$ and $\stackrel{\circ}{M}_{\varepsilon}$.
Lemma 3.15. Let $\varepsilon>0$ and $u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$. Then

$$
\begin{equation*}
\left\|\widetilde{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}=\varepsilon\left\|\stackrel{\circ}{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}(Q)}^{2}, \quad u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \tag{3.22}
\end{equation*}
$$

Proof. Let $u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$, then by the definition of $\widetilde{M}_{\varepsilon}$

$$
\begin{aligned}
\left\|\widetilde{M}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} & =\int_{Q_{\varepsilon}}\left|\widetilde{M}_{\varepsilon} u(\mathbf{x})\right|^{2} d \mathbf{x}=\int_{Q_{\varepsilon}}\left(\left|\widehat{M}_{\varepsilon} u_{1}(\mathbf{x})\right|^{2}+\left|\widehat{M}_{\varepsilon} u_{2}(\mathbf{x})\right|^{2}\right) d \mathbf{x} \\
& =\int_{0}^{\varepsilon} \int_{Q}\left(\left|M_{\varepsilon} u_{1}\left(\mathbf{x}^{\prime}\right)\right|^{2}+\left|M_{\varepsilon} u_{2}\left(\mathbf{x}^{\prime}\right)\right|^{2}\right) d \mathbf{x}^{\prime} d x_{3} \\
& =\varepsilon \int_{Q}\left|\stackrel{\circ}{M}_{\varepsilon} u\left(\mathbf{x}^{\prime}\right)\right|^{2} d \mathbf{x}^{\prime}=\varepsilon\left\|\stackrel{\circ}{M_{\varepsilon}} u\right\|_{\mathbb{L}^{2}(Q)}^{2}
\end{aligned}
$$

Remark 3.16. Similar to the scalar case, one can prove that the dual operator $\stackrel{\circ}{M}_{\varepsilon}^{*}$ : $\mathbb{L}^{2}(Q) \rightarrow \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ is given by

$$
\begin{equation*}
\stackrel{\circ}{M}_{\varepsilon}^{*} \mathrm{v}\left(\mathbf{x}^{\prime}, x_{3}\right)=\left(\frac{1}{\varepsilon} \mathrm{v}_{1}\left(\mathrm{x}^{\prime}\right), \frac{1}{\varepsilon} \mathrm{v}_{2}\left(\mathrm{x}^{\prime}\right), 0\right), \quad\left(\mathbf{x}^{\prime}, x_{3}\right) \in Q_{\varepsilon} \tag{3.23}
\end{equation*}
$$

Indeed, for $u \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ and $\mathrm{v} \in \mathbb{L}^{2}(Q)$,

$$
\begin{aligned}
\left(\stackrel{\circ}{M}_{\varepsilon} u, \mathrm{v}\right)_{\mathbb{L}^{2}(Q)} & =\left(M_{\varepsilon} u_{1}, \mathrm{v}_{1}\right)_{L^{2}(Q)}+\left(M_{\varepsilon} u_{2}, \mathrm{v}_{2}\right)_{L^{2}(Q)} \\
& =\left(u_{1}, M_{\varepsilon}^{*} \mathrm{v}_{1}\right)_{L^{2}\left(Q_{\varepsilon}\right)}+\left(u_{2}, M_{\varepsilon}^{*} \mathrm{v}_{2}\right)_{L^{2}\left(Q_{\varepsilon}\right)}+\left(u_{3}, 0\right)
\end{aligned}
$$

Lemma 3.17. Let $\varepsilon>0$ and $\stackrel{\circ}{M}_{\varepsilon}$ is the map as defined in (3.21). Then
(i) if $u \in \mathrm{H}_{\varepsilon}$ then $\stackrel{\circ}{M}_{\varepsilon} u \in \mathrm{H}$, i.e. $\stackrel{\circ}{M}_{\varepsilon}: \mathrm{H}_{\varepsilon} \rightarrow \mathrm{H}$.
(ii) if $u \in \mathrm{~V}_{\varepsilon}$ then $\stackrel{\circ}{M}_{\varepsilon} u \in \mathrm{~V}$, i.e. $\stackrel{\circ}{M}_{\varepsilon}: \mathrm{V}_{\varepsilon} \rightarrow \mathrm{V}$.

Proof. (i) Let us take $u \in \mathrm{H}_{\varepsilon}$. Then $u \cdot \vec{n}_{\varepsilon}=0$ on $\partial Q_{\varepsilon}$, where $\vec{n}_{\varepsilon}\left(\mathrm{x}^{\prime}, x_{3}\right)=\left(\vec{n}\left(\mathbf{x}^{\prime}\right), 0\right)$ for $\left(\mathrm{x}^{\prime}, y\right) \in \Gamma_{\ell}^{\varepsilon}$ and $\vec{n}_{\varepsilon}=(0,0, \pm 1)$ on $\Gamma_{h}^{\varepsilon, \pm}$. Put $\mathrm{v}=\stackrel{\circ}{M}_{\varepsilon} u=\left(M_{\varepsilon} u_{1}, M_{\varepsilon} u_{2}\right)$. Thus, for almost all $x^{\prime} \in \partial Q$,

$$
\mathrm{v} \cdot \vec{n}\left(\mathrm{x}^{\prime}\right)=M_{\varepsilon} u_{1}\left(\mathrm{x}^{\prime}\right) n_{1}\left(\mathrm{x}^{\prime}\right)+M_{\varepsilon} u_{2}\left(\mathrm{x}^{\prime}\right) n_{2}\left(\mathrm{x}^{\prime}\right)
$$

$$
\begin{aligned}
& =\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} u_{1}\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) n_{1}\left(\mathbf{x}^{\prime}\right)+\left(\frac{1}{\varepsilon} \int_{0}^{\varepsilon} u_{2}\left(\mathbf{x}^{\prime}, x_{3}\right) d x_{3}\right) n_{2}\left(\mathbf{x}^{\prime}\right) \\
& =\frac{1}{\varepsilon} \int_{0}^{\varepsilon}\left(u_{1}\left(\mathbf{x}^{\prime}, x_{3}\right) n_{1}\left(\mathbf{x}^{\prime}\right)+u_{2}\left(\mathbf{x}^{\prime}, x_{3}\right) n_{2}\left(\mathbf{x}^{\prime}\right)\right) d x_{3} \\
& =\frac{1}{\varepsilon} \int_{0}^{\varepsilon} u\left(x^{\prime}, x_{3}\right) \cdot \vec{n}_{\varepsilon}\left(x^{\prime}, x_{3}\right) d x_{3}=0
\end{aligned}
$$

where $\vec{n}$ is the unit external normal vector field to $\partial Q$. The divergence free condition $\operatorname{div}^{\prime}{ }^{\prime} \mathrm{v}=0$ can be shown analogously to the proof of Lemma 3.11. Thus, we have shown that $\stackrel{\circ}{M}_{\varepsilon} u \in \mathrm{H}$.
(ii) Let us begin with $\stackrel{\circ}{M}_{\varepsilon}: \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \rightarrow \mathbb{L}^{2}(Q)$ and put

$$
\mathrm{v}=\stackrel{\circ}{M}_{\varepsilon} u=\left(M_{\varepsilon} u_{1}, M_{\varepsilon} u_{2}\right) .
$$

It is obvious that if $\partial_{j} u_{k} \in L^{2}\left(Q_{\varepsilon}\right)$ for $k=1,2,3, j=1,2$ then $M_{\varepsilon}\left(\partial_{j} u_{k}\right) \in L^{2}(Q)$ and $\partial_{j} \mathrm{v}=\stackrel{\circ}{M}_{\varepsilon}\left(\partial_{j} u\right)$ a.e. Now let $u \in \mathrm{~V}_{\varepsilon}$. Then from the above reason $\mathrm{v}=\stackrel{\circ}{M}_{\varepsilon} u \in \mathbb{H}^{1}(Q)$. Moreover, the proof of part (i) implies that $\operatorname{div}^{\prime}{ }^{\prime} \mathrm{v}=0$. Finally, we have $u_{j}\left(\mathrm{x}^{\prime}, x_{3}\right)=0$ for $\left(\mathbf{x}^{\prime}, x_{3}\right) \in \partial Q \times(0, \varepsilon), j=1,2$, therefore for $\mathbf{x}^{\prime} \in \partial Q$

$$
\mathrm{v}_{j}\left(\mathrm{x}^{\prime}\right)=M_{\varepsilon} u_{j}\left(\mathrm{x}^{\prime}\right)=\frac{1}{\varepsilon} \int_{0}^{\varepsilon} u_{j}\left(\mathrm{x}^{\prime}, x_{3}\right) d x_{3}=0 \quad j=1,2
$$

Hence, we have proved that $v \in V$.
Remark 3.18. We proved that $\stackrel{\circ}{M}_{\varepsilon}\left(\mathrm{H}_{\varepsilon}\right) \subset \mathrm{H}$. By (3.23), for $\mathrm{v} \in \mathrm{H}$, and $u=\stackrel{\circ}{M}_{\varepsilon}^{*} \mathrm{v}$, $\operatorname{div} u=0$. Moreover, $u_{3}=0$ on $\Gamma_{h}^{\varepsilon}$ and

$$
u \cdot \vec{n}_{\varepsilon}\left(\mathbf{x}^{\prime}, x_{3}\right)=\frac{1}{\varepsilon} \mathrm{v} \cdot \vec{n}\left(\mathbf{x}^{\prime}\right)=0, \quad \text { for }\left(\mathbf{x}^{\prime}, x_{3}\right) \in \Gamma_{\ell}^{\varepsilon}
$$

Thus, we infer $u \in \mathrm{H}_{\varepsilon}$ which implies $\stackrel{\circ}{M}_{\varepsilon}^{*}(\mathrm{H}) \subset \mathrm{H}_{\varepsilon}$.
Let us now recall a classical Poincaré's inequality, see e.g. [37, Proposition 2.1]
Proposition 3.19 (Poincaré inequality). If $\psi \in H^{1}\left(Q_{\varepsilon}\right)$ and either of the following conditions are satisfied

\begin{cases}\psi=0 & \text { on } \Gamma_{h}^{\varepsilon,+} \\ \psi=0 & \text { on } \Gamma_{h}^{\varepsilon,-} \\ M_{\varepsilon} \psi=0 & \text { a.e. on } Q .\end{cases}
$$

Then

$$
\begin{equation*}
\|\psi\|_{L^{2}\left(Q_{\varepsilon}\right)} \leq \varepsilon\left\|\partial_{3} \psi\right\|_{L^{2}\left(Q_{\varepsilon}\right)} \tag{3.24}
\end{equation*}
$$

We have the following immediate consequence.
Corollary 3.20. If $u \in \mathrm{~V}_{\varepsilon}$, then

$$
\begin{equation*}
\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)} \leq \varepsilon\left\|\partial_{3} \widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)} \tag{3.25}
\end{equation*}
$$

Proof. Note that for $u \in \mathrm{~V}_{\varepsilon}, \widetilde{N}_{\varepsilon} u=\left(\widehat{N}_{\varepsilon} u_{1}, \widehat{N}_{\varepsilon} u_{2}, u_{3}\right)$. Thus, it is sufficient to prove an analogous inequality for $\widehat{N}_{\varepsilon}$ and $\psi \in H^{1}\left(Q_{\varepsilon}\right)$ as we can use Proposition 3.19 directly for $u_{3}$ (since for $u \in \mathrm{~V}_{\varepsilon}, u_{3}=0$ on $\Gamma_{h}^{\varepsilon}$ ). For such $\psi$ we have, by (3.10), $\widehat{M}_{\varepsilon} \widehat{N}_{\varepsilon} \psi=0$ a.e. on $Q$ and by Lemma 3.7 $\widehat{N}_{\varepsilon} \psi \in H^{1}\left(Q_{\varepsilon}\right)$. Hence, by Proposition 3.19 the inequality holds true for the map $\widehat{N}_{\varepsilon}$ and $\psi \in H^{1}\left(Q_{\varepsilon}\right)$. Therefore, we have shown that (3.24) holds true for every component of $\widetilde{N}_{\varepsilon} u$ and in particular for $\widetilde{N}_{\varepsilon} u$.

We also have the following anisotropic Ladyzhenskaya's inequality (see [37, Remark 2.1]).
Proposition 3.21. Let $\varepsilon>0$ and $u \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right)$. Then, $\exists c_{0}=c_{0}(Q)>0$ independent of $\varepsilon$ such that

$$
\begin{equation*}
\|u\|_{\mathbb{L}^{6}\left(Q_{\varepsilon}\right)} \leq c_{0}\left(\frac{1}{\varepsilon}\|u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}+\left\|\partial_{3} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}\right)^{1 / 3}\left(\|u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}+\left\|\partial_{1} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}+\left\|\partial_{2} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}\right)^{2 / 3} \tag{3.26}
\end{equation*}
$$

From Corollary 3.20 and Proposition 3.21 we deduce the following result.
Corollary 3.22. Let $\varepsilon>0$ and $u \in \mathrm{~V}_{\varepsilon}$. Then, $\exists c_{0}>0$ independent of $\varepsilon$ such that

$$
\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{6}\left(Q_{\varepsilon}\right)} \leq c_{0}\left\|\widetilde{N}_{\varepsilon} u\right\|_{V_{\varepsilon}}
$$

where

$$
\|u\|_{\mathrm{V}_{\varepsilon}}^{2}=\|u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}+\|\nabla u\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} .
$$

Proof. Let $\varepsilon>0$ and $u \in \mathrm{~V}_{\varepsilon}$. Then by Proposition 3.21 there exists a constant $c_{0}$ independent of $\varepsilon$ such that

$$
\begin{equation*}
\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{6}\left(Q_{\varepsilon}\right)} \leq c_{0}\left(\frac{1}{\varepsilon}\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}+\left\|\partial_{3} \widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}\right)^{1 / 3}\left(\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}+\left\|\nabla^{\prime} \widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}\right)^{2 / 3} \tag{3.27}
\end{equation*}
$$

Now from Corollary 3.20 for $u \in \mathrm{~V}_{\varepsilon}$

$$
\frac{1}{\varepsilon}\left\|\widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)} \leq\left\|\partial_{3} \widetilde{N}_{\varepsilon} u\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}
$$

Using the above inequality in (3.27) and the definition of $\mathrm{V}_{\varepsilon}$-norm we obtain the required inequality.

From Corollaries 3.20, 3.22 and interpolation argument (between $\mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ and $\left.\mathbb{L}^{6}\left(Q_{\varepsilon}\right)\right)^{2}$, we obtain

\left\|\widetilde{N}_{\varepsilon} u\right\|_{L^{3}\left(Q_{\varepsilon}\right)}^{2} \leq c_{0} \varepsilon\left\|\widetilde{N}_{\varepsilon} u\right\|_{V_{\varepsilon}}^{2} \tag{3.28}
\end{equation*}
$$

We have defined a map $\stackrel{\circ}{M}_{\varepsilon}$ (see (3.21)) from the set of (square integrable) $\mathbb{R}^{3}$-valued vector fields on $Q_{\varepsilon}$ to the set of (square integrable) $\mathbb{R}^{2}$-valued vector fields on $Q$. Later in

[^2]the analysis we will require a retract of $\stackrel{\circ}{M}_{\varepsilon}$, i.e. a map $R_{\varepsilon}: \mathbb{L}^{2}(Q) \rightarrow \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ such that

A natural candidate for $R_{\varepsilon}$ is

$$
\begin{equation*}
R_{\varepsilon} u^{\prime}\left(\mathbf{x}^{\prime}, x_{3}\right)=\left(u_{1}^{\prime}\left(\mathbf{x}^{\prime}\right), u_{2}^{\prime}\left(\mathbf{x}^{\prime}\right), 0\right), \tag{3.30}
\end{equation*}
$$

where $\mathbb{L}^{2}\left(Q, \mathbb{R}^{2}\right) \ni u^{\prime}=\left(u_{1}^{\prime}, u_{2}^{\prime}\right)$. Note that $R_{\varepsilon}$ is a bounded linear map from $\mathbb{L}^{2}(Q)$ to $\mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ and $\stackrel{\circ}{M}_{\varepsilon} \circ R_{\varepsilon}=\operatorname{Id}$ on $\mathbb{L}^{2}(Q)$. Moreover, if $\operatorname{div}^{\prime} u^{\prime}=0$ then

$$
\left(\operatorname{div} R_{\varepsilon} u^{\prime}\right)\left(\mathbf{x}^{\prime}, x_{3}\right)=\partial_{1} u_{1}^{\prime}\left(\mathbf{x}^{\prime}\right)+\partial_{2} u_{2}^{\prime}\left(\mathbf{x}^{\prime}\right)+\partial_{3} 0=\operatorname{div}^{\prime} u^{\prime}=0
$$

Moreover, if $\left.u^{\prime} \cdot \vec{n}\right|_{\partial Q}=0$ then it can be verified that $R_{\varepsilon} u^{\prime} \cdot \vec{n}_{\varepsilon}=0$ on $\partial Q_{\varepsilon}$. Hence, for $u^{\prime} \in \mathrm{H}, R_{\varepsilon} u^{\prime} \in \mathrm{H}_{\varepsilon}$. Furthermore, if $u^{\prime} \in \mathbb{H}^{1}(Q)$ then $R_{\varepsilon} u^{\prime} \in \mathbb{H}^{1}\left(Q_{\varepsilon}\right)$ and similarly to the above argument we can show that $u^{\prime} \in \mathrm{V}$ implies $R_{\varepsilon} u^{\prime} \in \mathrm{V}_{\varepsilon}$.

Indeed, if $u^{\prime}=0$ on $\partial Q$ then $R_{\varepsilon} u^{\prime}=0$ on $\Gamma_{\ell}^{\varepsilon}$ and $\left(R_{\varepsilon} u^{\prime}\right)_{3}=0$ on $\Gamma_{h}^{\varepsilon}$. Finally, if $u^{\prime} \in D(\mathrm{~A})$ then $R_{\varepsilon} u^{\prime} \in D\left(A_{\varepsilon}\right)$. Indeed, if $u \in \mathbb{H}^{2}(Q)$ then $R_{\varepsilon} u \in \mathbb{H}^{2}\left(Q_{\varepsilon}\right)$ and for $j=1,2,\left(R_{\varepsilon} u^{\prime}\right)_{j}$ is constant with respect to $x_{3}$ and so $\partial_{3}\left(\left(R_{\varepsilon} u^{\prime}\right)_{j}\right)=0$ also on $\Gamma_{h}^{\varepsilon}$.

Also, note that $R_{\varepsilon}$ commutes with $\nabla^{\prime}$, i.e. for $u^{\prime} \in \mathrm{V}, \mathrm{v} \in \mathrm{V}_{\varepsilon}$,

$$
\begin{array}{cl}
\partial_{j} R_{\varepsilon} u^{\prime}=R_{\varepsilon} \partial_{j} u^{\prime}, & j=1,2, \\
\stackrel{\circ}{M_{\varepsilon}} \partial_{j} \mathrm{v}=\partial_{j} \stackrel{\circ}{\mathrm{E}}_{\mathrm{\varepsilon}} \mathrm{v}, & j=1,2 . \tag{3.31}
\end{array}
$$

Additionally, for $\mathrm{v} \in \mathbb{L}^{2}\left(Q_{\varepsilon}\right)$ and $u^{\prime} \in \mathbb{L}^{2}(Q)$

$$
\begin{equation*}
\left(R_{\varepsilon} u^{\prime}, \mathrm{v}\right)_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}=\varepsilon\left(u^{\prime}, \stackrel{\circ}{M_{\varepsilon} \mathrm{v}}\right)_{\mathbb{L}^{2}(Q)}, \tag{3.32}
\end{equation*}
$$

showing that the adjoint $R_{\varepsilon}^{*}: \mathbb{L}^{2}\left(Q_{\varepsilon}\right) \rightarrow \mathbb{L}^{2}(Q)$ of $R_{\varepsilon}$ is given by $R_{\varepsilon}^{*} \mathrm{v}=\varepsilon{ }^{\circ}{ }_{\varepsilon} \mathrm{v}$.
Lemma 3.23. Let $\varepsilon>0$ and $\mathrm{v} \in \mathbb{L}^{2}(Q)$. Then

\left\|R_{\varepsilon} \mathrm{v}\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2}=\varepsilon\|\mathrm{v}\|_{\mathbb{L}^{2}(Q)}^{2}, \quad \mathrm{v} \in \mathbb{L}^{2}(Q) \tag{3.33}
\end{equation*}
$$

Proof. Let $\varepsilon>0$ and consider $\mathbb{L}^{2}(Q) \ni \mathrm{v}=\left(\mathrm{v}_{1}, \mathrm{v}_{2}\right)$. Then, by the definition of the retract operator $R_{\varepsilon}$ and $\mathbb{L}^{2}\left(Q_{\varepsilon}\right)$-norm we have

\left\|R_{\varepsilon} \mathrm{v}\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} & =\int_{Q} \int_{0}^{\varepsilon}\left|R_{\varepsilon} \mathrm{v}\left(\mathbf{x}^{\prime}, x_{3}\right)\right|^{2} d \mathbf{x}^{\prime} d x_{3}=\int_{Q} \int_{0}^{\varepsilon}\left[\left|\mathrm{v}_{1}\left(x^{\prime}\right)\right|^{2}+\left|\mathrm{v}_{2}\left(x^{\prime}\right)\right|^{2}\right] d \mathbf{x}^{\prime} d x_{3} \\
& =\varepsilon\|\mathrm{v}\|_{\mathbb{L}^{2}(Q)}^{2} .
\end{aligned}
$$

Using the definition of the map $R_{\varepsilon}$ and its properties the above lemma can be generalised to Sobolev spaces.

Lemma 3.24. Let $\varepsilon>0, p \geq 2$ and $R_{\varepsilon}$ be the map as given by (3.29)-(3.30). Then

\left\|\Delta R_{\varepsilon} \mathrm{V}\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)} & =\varepsilon^{1 / 2}\left\|\Delta^{\prime} \mathrm{v}\right\|_{\mathbb{L}^{2}(Q)}, & & \mathrm{v} \in \mathbb{W}^{2,2}(Q) . \tag{3.34}
\end{align*}

## 4. The stochastic NSEs on a thin domain

This section deals with the proof of our main result, Theorem 4.5. First we introduce our two systems; stochastic NSE in thin domain $Q_{\varepsilon}$ and 2D stochastic NSE on $Q$, then we present the definition of martingale solutions for both systems. We also state the assumptions under which we prove our result. In $\S 4.1$, we obtain a priori estimates (formally) which we further use to establish some tightness criterion (see §4.2) which along with Jakubowski's generalisation of Skorokhod Theorem gives us a converging (in $\varepsilon$ ) subsequence. At the end of this section we show that the limiting object of the previously obtained converging subsequence is a martingale solution of 2D stochastic NSE on $Q$ (see §4.3).

In thin domains $Q_{\varepsilon}$, which was introduced in (1.3), we consider the following stochastic Navier-Stokes equations (SNSE)

\begin{align*}
d \widetilde{u}_{\varepsilon}-\left[\nu \Delta \widetilde{u}_{\varepsilon}-\left(\widetilde{u}_{\varepsilon} \cdot \nabla\right) \widetilde{u}_{\varepsilon}-\nabla \widetilde{p}_{\varepsilon}\right] d t=\widetilde{f}_{\varepsilon} d t+\widetilde{G}_{\varepsilon} d \widetilde{W}_{\varepsilon}(t) & \text { in } Q_{\varepsilon} \times(0, T),  \tag{4.1}\\
\operatorname{div} \widetilde{u}_{\varepsilon}=0 & \text { in } Q_{\varepsilon} \times(0, T),  \tag{4.2}\\
\widetilde{u}_{\varepsilon, 3}=0, \quad \partial_{3} \widetilde{u}_{\varepsilon, j}=0, \quad j=1,2 & \text { on } \Gamma_{h}^{\varepsilon} \times(0, T),  \tag{4.3}\\
\widetilde{u}_{\varepsilon}=0 & \text { on } \Gamma_{\ell}^{\varepsilon} \times(0, T),  \tag{4.4}\\
\widetilde{u}_{\varepsilon}(\cdot, 0)=\widetilde{u}_{0}^{\varepsilon} & \text { in } Q_{\varepsilon}, \tag{4.5}
\end{align*}
$$

where $\Gamma_{h}^{\varepsilon}$ and $\Gamma_{\ell}^{\varepsilon}$ were introduced in (1.7). Recall that, $\widetilde{u}_{\varepsilon}=\left(\widetilde{u}_{\varepsilon, 1}, \widetilde{u}_{\varepsilon, 2}, \widetilde{u}_{\varepsilon, 3}\right)$ is the fluid velocity field, $p$ is the pressure, $\nu>0$ is a (fixed) kinematic viscosity, $\widetilde{u}_{0}^{\varepsilon}$ is a divergence free vector field on $Q_{\varepsilon}$ and $\vec{n}$ is the unit normal outer vector to the boundary $\partial Q_{\varepsilon}$. We assume that ${ }^{3} N \in \mathbb{N}$. We consider a family of maps

$$
\widetilde{G}_{\varepsilon}: \mathbb{R}_{+} \rightarrow \mathcal{T}_{2}\left(\mathbb{R}^{N} ; \mathrm{H}_{\varepsilon}\right)
$$

such that

$$
\begin{equation*}
\widetilde{G}_{\varepsilon}(t) k:=\sum_{j=1}^{N} \widetilde{g}_{\varepsilon}^{j}(t) k_{j}, \quad k=\left(k_{j}\right)_{j=1}^{N} \in \mathbb{R}^{N} . \tag{4.6}
\end{equation*}
$$

for some $\widetilde{g}_{\varepsilon}^{j}: \mathbb{R}_{+} \rightarrow \mathrm{H}_{\varepsilon}, j=1, \cdots, N$. The Hilbert-Schmidt norm of $\widetilde{G}_{\varepsilon}$ is given by

$$
\begin{equation*}
\left\|\widetilde{G}_{\varepsilon}(s)\right\|_{\mathcal{T}_{2}\left(\mathbb{R}^{N} ; H_{\varepsilon}\right)}^{2}=\sum_{j=1}^{N}\left\|\widetilde{g}_{\varepsilon}^{j}(s)\right\|_{\mathbb{L}^{2}\left(Q_{\varepsilon}\right)}^{2} \tag{4.7}
\end{equation*}
$$

Finally we assume that $\widetilde{W}_{\varepsilon}(t), t \geq 0$ is an $\mathbb{R}^{N}$-valued Wiener process defined on the probability space $(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P})$. We assume that $\left(\beta_{j}\right)_{j=1}^{N}$ are i.i.d real valued Brownian motions such that $W(t)=\left(\beta_{j}(t)\right)_{j=1}^{N}, t \geq 0$.

[^3]In this section we shall establish convergence of the radial averages of the martingale solution of the 3 D stochastic equations (4.1)-(4.5), as the thickness of the domain $\varepsilon \rightarrow 0$, to a martingale solution $u$ of the following 2D stochastic Navier-Stokes equations on $Q$ :

d u-\left[\nu \Delta^{\prime} u-\left(u \cdot \nabla^{\prime}\right) u-\nabla^{\prime} p\right] d t=f d t+G d W(t) \quad \text { in } Q \times(0, T), ~ \begin{align*}
\operatorname{div}^{\prime} u=0 & \text { in } Q \times(0, T)  \tag{4.8}\\
u=0 & \text { on } \partial Q \times(0, T),  \tag{4.9}\\
u(0, \cdot)=u_{0} & \text { in } Q \tag{4.10}
\end{align*}
$$

where $u=\left(u_{1}, u_{2}\right)$ and $\Delta^{\prime}, \nabla^{\prime}$, div ${ }^{\prime}$ are the differential operators for $\mathbb{R}^{2}$-valued vector field. Assumptions on initial data and external forcing will be specified later (see Assumptions $1,2)$. Here, $G: \mathbb{R}_{+} \rightarrow \mathcal{T}_{2}\left(\mathbb{R}^{N} ; \mathrm{H}\right)$ and $W(t), t \geq 0$ is an $\mathbb{R}^{N}$-valued Wiener process such that

Now, we specify assumptions on the initial data $\widetilde{u}_{0}^{\varepsilon}$ and external forcing $\widetilde{f}_{\varepsilon}, \widetilde{g}_{\varepsilon}^{j}$.

Remark 4.4 (Existence of martingale solutions). For a fixed $\varepsilon>0$, the existence of a martingale solution to (4.1)-(4.2) with Dirichlet boundary conditions was shown in [16]. More recently, the first named author along with Motyl proved the existence of martingale solutions to (4.1)-(4.2) on possibly unbounded domain with transport type noise; see [7]. In [12], the first named author and Slavik have established the existence of martingale solutions for much more complex so-called primitive equations in three dimensions but with the boundary conditions (4.3)-(4.4). Thus, we believe that one can establish the existence of martingale solutions to (4.1)-(4.5) by following the standard approaches as in [16, 7, 12].

Moreover, in [7], the existence of a unique strong solution to 2D stochastic NSEs, (4.8)(4.11), was proved by showing the existence of a martingale solution and proving the pathwise uniqueness of such a martingale solution.

We end this subsection by stating the main theorem of this article.
Theorem 4.5. Let the given data $\widetilde{u}_{0}^{\varepsilon}, u_{0}, \widetilde{f}_{\varepsilon}, f, \widetilde{g}_{\varepsilon}^{j}, g^{j}, j \in\{1, \cdots, N\}$ satisfy Assumptions 1 and 2. Let $\left(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P}, \widetilde{W}_{\varepsilon}, \widetilde{u}_{\varepsilon}\right)$ be a martingale solution of (4.1)-(4.5) as defined in Definition 4.1. Then, the averages in the vertical direction of this martingale solution i.e. $\widehat{\alpha}_{\varepsilon}:=\stackrel{\circ}{M}_{\varepsilon} \widetilde{u}_{\varepsilon}$ converge to the unique martingale solution, $(\widehat{\Omega}, \widehat{\mathcal{F}}, \widehat{\mathbb{F}}, \widehat{\mathbb{P}}, \widehat{W}, \widehat{u})$, of (4.8)-(4.11) in $L^{2}(\widehat{\Omega} \times[0, T] \times Q)$.

Remark 4.6. According to Remark 4.4, for every $\varepsilon \in[0,1]$ there exists a martingale solution of (4.1)-(4.5) as defined in Definition 4.1, i.e. we will obtain a tuple $\left(\Omega_{\varepsilon}, \mathcal{F}_{\varepsilon}, \mathbb{F}_{\varepsilon}, \mathbb{P}_{\varepsilon}, \widetilde{W}_{\varepsilon}, \widetilde{u}_{\varepsilon}\right)$ as a martingale solution. It was shown in [23] that is enough to consider only one probability space, namely,

where $\mathcal{L}$ denotes the Lebesgue measure on $[0,1]$. Thus, it is justified to consider the probability space $(\Omega, \mathcal{F}, \mathbb{P})$ independent of $\varepsilon$ in Theorem 4.5.

Remark 4.7. Chueshov and Kuksin in [14] stated a result; see [14, Proposition 12], which is similar to our Theorem 4.5. These authors study the so called Leray- $\alpha$ approximation [26], of the stochastic 3D Navier-Stokes equations

where $A_{\varepsilon}, B_{\varepsilon}$ are the Stokes operator and bilinear form, as introduced in $\S 2, G_{\alpha}=$ $\left(1+\alpha A_{\varepsilon}\right)^{-1}$, and $\dot{W}_{\varepsilon}$ is the white noise. They proved the existence and the uniqueness of
a solutions $u_{\varepsilon}^{\alpha}$ to (4.24) and they established the existence of a unique stationary measure $\mu_{\varepsilon}^{\alpha}$ to (4.24) for sufficiently non-degenerate noise, and proved that every solution of (4.24) converges to it in law distribution as time goes to infinity. The main result of their work was to show the convergence of $M_{\varepsilon} \mu_{\varepsilon}^{\alpha}$ to the unique stationary measure $\mu$ of 2 D stochastic Navier-Stokes equations as $\alpha, \varepsilon \rightarrow 0$ simultaneously [14, Theorem 10], see $\S 3$ for the definition of the map $M_{\varepsilon}$ (which can be generalised for measures). In the statement of the Proposition 12, the authors state that under suitable growth and convergence assumptions on the initial data $u_{\varepsilon}^{0}$, the law of $M_{\varepsilon} u_{\varepsilon}^{\alpha}$ converges to the law of $u$ as $\varepsilon, \alpha \rightarrow 0$ simultaneously, in appropriate functional space.

In retrospect, it seems that our result has striking similarities to that of the statement in [14, Proposition 12]. At the same time there are subtle differences, which we state in the following. Firstly, we consider Dirichlet boundary conditions at the level of flat domain ( $Q$, see (1.5)) in contrast to "periodic" boundary conditions. Secondly, we consider the original 3D stochastic Navier-Stokes equations instead of the Leray- $\alpha$ approximation, and in particular, show that for every martingale solution $\widetilde{u}_{\varepsilon}$ of (1.1)-(1.6), there exists a subsequence of $\left\{\stackrel{\circ}{M}_{\varepsilon} \widetilde{u}_{\varepsilon}\right\}_{\varepsilon>0}$ which converges to a martingale solution of the 2D stochastic Navier-Stokes equations in a suitable functional space. Finally, we provide a self-contained proof with all the details of our main result along with some higher order moment estimates, see Lemma 4.11.
4.1. Estimates. From this point onward we will assume that for every $\varepsilon \in(0,1]$ there exists a martingale solution $\left(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P}, \widetilde{W}_{\varepsilon}, \widetilde{u}_{\varepsilon}\right)$ of (4.16). Please note that we do not claim neither we use the uniqueness of this solution.
The main aim of this subsection is to obtain estimates for $\alpha_{\varepsilon}$ and $\widetilde{\beta}_{\varepsilon}$ uniform in $\varepsilon$ using the estimates for the process $\widetilde{u}_{\varepsilon}$.

The energy inequality (4.25) and the higher-order estimates (4.37)-(4.38), satisfied by the process $\widetilde{u}_{\varepsilon}$, as obtained in Lemma 4.8 and Lemma 4.11 is actually a consequence (essential by-product) of the existence proof. In principle, one obtains these estimates (uniform in the approximation parameter $N$ ) for the finite-dimensional process $\widetilde{u}_{\varepsilon}^{(N)}$ (using Galerkin approximation) with the help of the Itô lemma. Then, using the lower semi-continuity of norms, convergence result $\left(\widetilde{u}_{\varepsilon}^{(N)} \rightarrow \widetilde{u}_{\varepsilon}\right.$ in some sense), one can establish the estimates for the limiting process. Such a methodology was employed in a proof of Theorem 4.8 in the recent paper [9] by the first named author, Motyl and Ondreját.

In Lemma 4.8 and Lemma 4.11 we present a formal proof where we assume that one can apply (ignoring the existence of Lebesgue and stochastic integrals) the Itô lemma to the infinite dimensional process $\widetilde{u}_{\varepsilon}$. The idea is to showcase (though standard) the techniques involved in establishing such estimates.

Lemma 4.8. 4.2. Tightness. In this subsection we will prove that the family of laws induced by the processes $\alpha_{\varepsilon}$ is tight on an appropriately chosen topological space $\mathcal{Z}_{T}$. In order to do so we will consider the following functional spaces for fixed $T>0$ :

The proof of lemma turns out to be a direct application of Corollary A.9. Indeed, by Lemma 4.9, assumptions (a) and (b) of Corollary A. 9 are satisfied and therefore, it is sufficient to show that the sequence $\left(\alpha_{\varepsilon}\right)_{\varepsilon>0}$ satisfies the Aldous condition [A], see Definition A.6, in space $\mathrm{U}^{*}$.

Let $\theta \in(0, T)$ and $\left(\tau_{\varepsilon}\right)_{\varepsilon>0}$ be a sequence of stopping times such that $0 \leq \tau_{\varepsilon} \leq \tau_{\varepsilon}+\theta \leq T$. We start by estimating each term in the right-hand-side of (4.49). We will use the Hölder inequality, the scaling property from Lemma 3.15, the Poincaré type inequality (3.25), the Ladyzhenskaya type inequality from Corollary 3.22, identities from Lemma 3.24 and the a priori estimates from Lemmas 4.9, 4.10.

In what follows, we will prove that each of the five process from equality (4.49) satisfies the Aldous condition $[\mathbf{A}]$. In order to help the reader, we will divide the following part of the proof into five parts.

Let us denote the subsequence $\left(\widehat{\alpha}_{\varepsilon_{k_{n}}}, \widehat{\beta}_{\varepsilon_{k_{n}}}, \widehat{W}_{\varepsilon_{k_{n}}}\right)$ again by $\left(\widehat{\alpha}_{\varepsilon}, \widehat{\beta}_{\varepsilon}, \widehat{W}_{\varepsilon}\right)_{\varepsilon \in(0,1]}$.
Note that since $\mathcal{B}\left(\mathcal{Z}_{T} \times \mathcal{Y}_{T} \times C\left([0, T] ; \mathbb{R}^{N}\right) \subset \mathcal{B}\left(\mathcal{Z}_{T}\right) \times \mathcal{B}\left(\mathcal{Y}_{T}\right) \times \mathcal{B}\left(C\left([0, T] ; \mathbb{R}^{N}\right)\right)\right.$, the functions $\widehat{u}, \widehat{\eta}$ are $\mathcal{Z}_{T}, \mathcal{Y}_{T}$ Borel random variables respectively.

The following auxiliary result which is needed in the proof of Theorem 4.5, cannot be deduced directly from the Kuratowski Theorem (see Theorem B.1).

Lemma 4.14. Let $T>0$ and $\mathcal{Z}_{T}$ be as defined in (4.48). Then the following sets $C([0, T] ; \mathrm{H}) \cap \mathcal{Z}_{T}, L^{2}(0, T ; \mathrm{V}) \cap \mathcal{Z}_{T}$ are Borel subsets of $\mathcal{Z}_{T}$.

By inequality (4.65) we infer that the sequence $\left(\widehat{\alpha}_{\varepsilon}\right)_{\varepsilon>0}$ contains a subsequence, still denoted by $\left(\widehat{\alpha}_{\varepsilon}\right)_{\varepsilon>0}$ convergent weakly (along the sequence $\left.\varepsilon_{k_{n}}\right)$ in the space $L^{2}(\widehat{\Omega} \times[0, T] ; \mathrm{V})$. Since $\widehat{\alpha}_{\varepsilon} \rightarrow \widehat{u}$ in $\mathcal{Z}_{T} \widehat{\mathbb{P}}$-a.s., we conclude that $\widehat{u} \in L^{2}(\widehat{\Omega} \times[0, T] ; \mathrm{V})$, i.e.

## Appendix A. Compactness

A.1. Skorohod Theorem and Aldous condition. Let $E$ be a separable Banach space with the norm $|\cdot|_{E}$ and let $\mathcal{B}(E)$ be its Borel $\sigma$-field. The family of probability measures on $(E, \mathcal{B}(E))$ will be denoted by $\Lambda$. The set of all bounded and continuous $E$-valued functions is denoted by $C_{b}(E)$.
Definition A.1. The family $\Lambda$ of probability measures on $(E, \mathcal{B}(E))$ is said to be tight if for arbitrary $\varepsilon>0$ there exists a compact set $K_{\varepsilon} \subset E$ such that

\mu\left(K_{\varepsilon}\right) \geq 1-\varepsilon, \quad \text { for all } \mu \in \Lambda
$$

We will need the following Jakubowski's generalisation of the Skorohod Theorem, in the form given by Brzeźniak and Ondreját [10, Theorem C.1], see also [23], as we deal with non-metric spaces.

Theorem A.2. Let $\mathcal{X}$ be a topological space such that there exists a sequence $\left\{f_{m}\right\}_{m \in \mathbb{N}}$ of continuous functions $f_{m}: \mathcal{X} \rightarrow \mathbb{R}$ that separates points of $\mathcal{X}$. Let us denote by $\mathcal{S}$ the $\sigma$-algebra generated by the maps $\left\{f_{m}\right\}$. Then
a) every compact subset of $\mathcal{X}$ is metrizable,
b) if $\left(\mu_{m}\right)_{m \in \mathbb{N}}$ is a tight sequence of probability measures on $(\mathcal{X}, \mathcal{S})$, then there exists a subsequence $\left(m_{k}\right)_{k \in \mathbb{N}}$, a probability space $(\Omega, \mathcal{F}, \mathbb{P})$ with $\mathcal{X}$-valued Borel measurable variables $\xi_{k}, \xi$ such that $\mu_{m_{k}}$ is the law of $\xi_{k}$ and $\xi_{k}$ converges to $\xi$ almost surely on $\Omega$.

Let $(\mathbb{S}, \varrho)$ be a separable and complete metric space.
Definition A.3. Let $u \in C([0, T] ; \mathbb{S})$. The modulus of continuity of $u$ on $[0, T]$ is defined by

m(u, \delta):=\sup _{s, t \in[0, T],|t-s| \leq \delta} \varrho(u(t), u(s)), \quad \delta>0 .
$$

Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space with filtration $\mathbb{F}:=\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ satisfying the usual conditions, see [29], and let $\left(X_{n}\right)_{n \in \mathbb{N}}$ be a sequence of continuous $\mathbb{F}$-adapted $\mathbb{S}$-valued processes.

Definition A.4. We say that the sequence $\left(X_{n}\right)_{n \in \mathbb{N}}$ of $\mathbb{S}$-valued random variables satisfies condition [ $\mathbf{T}$ ] iff $\forall \varepsilon>0, \forall \eta>0, \exists \delta>0$ :

Lemma A.7. [30, Theorem 3.2] Conditions $[\mathbf{A}]$ and $[\mathbf{T}]$ are equivalent.
A.2. Tightness criterion. Now we formulate the compactness criterion analogous to the result due to Mikulevicus and Rozowskii [31], Brzeźniak and Motyl [8] for the space $\mathcal{Z}_{T}$, see also [4, Lemma 4.2].

(a) $\sup _{u \in \mathcal{K}} \sup _{s \in[0, T]}\|u(s)\|_{\mathbb{L}^{2}(Q)}<\infty$,
(b) $\sup _{u \in \mathcal{K}} \int_{0}^{T}\|u(s)\|_{\mathrm{V}}^{2} d s<\infty$, i.e. $\mathcal{K}$ is bounded in $L^{2}(0, T ; \mathrm{V})$,
(c) $\lim _{\delta \rightarrow 0} \sup _{u \in \mathcal{K}} \sup _{\substack{s, t \in[0, T] \\|t-s| \leq \delta}}\|u(t)-u(s)\|_{\mathrm{U}^{*}}=0$.

Using § A. 1 and the compactness criterion from Lemma A. 8 we obtain the following corollary.

Corollary A. 9 (Tightness criterion). Let $\left(X_{n}\right)_{n \in \mathbb{N}}$ be a sequence of continuous $\mathbb{F}$-adapted H -valued processes such that
(a) there exists a constant $C_{1}>0$ such that

$$
\inf _{\varepsilon>0} \mathbb{E}\left[\sup _{s \in[0, T]}\left\|\alpha_{\varepsilon}(s)\right\|_{\mathbb{L}^{2}(Q)}^{2}\right] \leq C_{1}
$$

(b) there exists a constant $C_{2}>0$ such that

$$
\inf _{\varepsilon>0} \mathbb{E}\left[\int_{0}^{T}\left\|\nabla^{\prime} \alpha_{\varepsilon}(s)\right\|_{\mathbb{L}^{2}(Q)}^{2} d s\right] \leq C_{2}
$$

(c) $\left(\alpha_{\varepsilon}\right)_{\varepsilon>0}$ satisfies the Aldous condition $[\mathbf{A}]$ in $\mathrm{U}^{*}$.

Let $\widetilde{\mathbb{P}}_{\varepsilon}$ be the law of $\alpha_{\varepsilon}$ on $\mathcal{Z}_{T}$. Then for every $\delta>0$ there exists a compact subset $K_{\delta}$ of $\mathcal{Z}_{T}$ such that

$$
\inf _{\varepsilon>0} \tilde{\mathbb{P}}_{\varepsilon}\left(K_{\delta}\right) \geq 1-\delta
$$

## Appendix B. Kuratowski Theorem and proof of Lemma 4.14

This appendix is dedicated to the proof of Lemma 4.14. We will first recall the Kuratowski Theorem [25] in the next subsection and prove some related results which will be used later to prove Lemma 4.14 in § B.2.

## B.1. Kuratowski Theorem and related results.

Theorem B.1. Assume that $X_{1}, X_{2}$ are the Polish spaces with their Borel $\sigma$-fields denoted respectively by $\mathcal{B}\left(X_{1}\right), \mathcal{B}\left(X_{2}\right)$. If $\varphi: X_{1} \rightarrow X_{2}$ is an injective Borel measurable map then for any $E_{1} \in \mathcal{B}\left(X_{1}\right), E_{2}:=\varphi\left(E_{1}\right) \in \mathcal{B}\left(X_{2}\right)$.

Next two lemmas are the main results of this appendix. For the proof of Lemma B. 2 see [5, Appendix B].

Lemma B.2. Let $X_{1}, X_{2}$ and $Z$ be topological spaces such that $X_{1}$ is a Borel subset of $X_{2}$. Then $X_{1} \cap Z$ is a Borel subset of $X_{2} \cap Z$, where $X_{2} \cap Z$ is a topological space too, with the topology given by

$$
\begin{equation*}
\tau\left(X_{2} \cap Z\right)=\left\{A \cap B: A \in \tau\left(X_{2}\right), B \in \tau(Z)\right\} \tag{B.1}
\end{equation*}
$$

B.2. Proof of Lemma 4.14. In this subsection we recall Lemma 4.14 and prove it using the results from previous subsection.

Lemma B.3. [Also, Lemma 4.14] Let $T>0$ and $\mathcal{Z}_{T}$ be as defined in (4.48). Then, the following sets $C([0, T] ; \mathrm{H}) \cap \mathcal{Z}_{T}, L^{2}(0, T ; \mathrm{V}) \cap \mathcal{Z}_{T}$ are Borel subsets of $\mathcal{Z}_{T}$.
Proof. First of all $C([0, T] ; \mathrm{H}) \subset C\left([0, T] ; \mathrm{U}^{*}\right) \cap L^{2}(0, T ; \mathrm{H})$. Secondly, $C([0, T] ; \mathrm{H})$ and $C\left([0, T] ; \mathrm{U}^{*}\right) \cap L^{2}(0, T ; \mathrm{H})$ are Polish spaces. And finally, since H is continuously embedded in $\mathrm{U}^{*}$, the map

$$
i: C([0, T] ; \mathrm{H}) \rightarrow C\left([0, T] ; \mathrm{U}^{*}\right) \cap L^{2}(0, T ; \mathrm{H})
$$

is continuous and hence Borel. Thus, by application of the Kuratowski Theorem (see Theorem B.1) $C([0, T] ; \mathrm{H})$ is a Borel subset of $C\left([0, T] ; \mathrm{U}^{*}\right) \cap L^{2}(0, T ; \mathrm{H})$. Therefore, by Lemma B.2, $C([0, T] ; \mathrm{H}) \cap \mathcal{Z}_{T}$ is a Borel subset of $C\left([0, T] ; \mathrm{U}^{*}\right) \cap L^{2}(0, T ; \mathrm{H}) \cap \mathcal{Z}_{T}$ which is equal to $\mathcal{Z}_{T}$.

Similarly we can show that $L^{2}(0, T ; \mathrm{V}) \cap \mathcal{Z}_{T}$ is a Borel subset of $\mathcal{Z}_{T} . L^{2}(0, T ; \mathrm{V}) \hookrightarrow$ $L^{2}(0, T ; \mathrm{H})$ and both are Polish spaces thus by application of the Kuratowski Theorem, $L^{2}(0, T ; \mathrm{V})$ is a Borel subset of $L^{2}(0, T ; \mathrm{H})$. Finally, we can conclude the proof of lemma by Lemma B.2.
