# Doubly Reflected BSDEs With Stochastic Quadratic Growth: Around The Predictable Obstacles

#### Abstract

We prove the existence of maximal (and minimal) solution for one-dimensional generalized doubly reflected backward stochastic differential equation (RBSDE for short) with irregular barriers and stochastic quadratic growth, for which the solution $Y$ has to remain between two rcll barriers $L$ and $U$ on $\left[0, T\left[\right.\right.$, and its left limit $Y_{-}$has to stay respectively above and below two predictable barriers $l$ and $u$ on $] 0, T]$. This is done without assuming any $P$-integrability conditions and under weaker assumptions on the input data. In particular, we construct a maximal solution for such a RBSDE when the terminal condition $\xi$ is only $\mathcal{F}_{T}$-measurable and the driver $f$ is continuous with general growth with respect to the variable $y$ and stochastic quadratic growth with respect to the variable $z$.

Our result is based on a (generalized) penalization method. This method allow us find an equivalent form to our original RBSDE where its solution has to remain between two new rcll reflecting barriers $\bar{Y}$ and $\underline{Y}$ which are, roughly speaking, the limit of the penalizing equations driven by the dominating conditions assumed on the coefficients.

A standard and equivalent form to our initial RBSDE as well as a characterization of the solution $Y$ as a generalized Snell envelope of some given predictable process $l$ are also given.

## 1 Introduction

The notion of backward stochastic differential equations with two reflecting barriers has been first introduced by Civitanić and Karatzas [3].A solution for such equation, associated with a coefficient $f$, a terminal value $\xi$ and two barriers $L$ and $U$, is a quadruple of processes ( $Y, Z, K^{+}, K^{-}$) with
values in $\mathbb{R} \times \mathbb{R}^{d} \times \mathbb{R}_{+} \times \mathbb{R}_{+}$satisfying:

where $\left(B_{t}\right)_{t \leq T}$ is the standard Brownian motion. Cvitanic and Karatzas [3] have proved the existence and uniqueness of solutions if, on the one hand, the coefficient $f$ is uniformly Lipschitz and, on the other hand, the barriers $L$ and $U$ are either regular or satisfy Mokobodski's condition. This later condition essentially postulates the existence of a quasimartingale between the barriers $L$ and $U$. It has also been shown in [3] that the solution coincides with the value of a stochastic Dynkin game. The link between PDEs with obstacles and RBSDEs has been given in Hamadène and Hassani [15]. More studies on RBSDEs can be found in [1, 2, 5, 11, 13, 16, 18, 20, and the references therein.

The problem of existence of solutions for generalized doubly reflected backward stochastic differential equation (RBSDE for short), which involves an integral with respect to a continuous increasing process, under weaker assumptions on the input data has been studied in [6] (see also [19, 7] for the non-reflected case and [12] for discontinuous barriers). In [6], the authors have proved the existence of a maximal solution when the terminal condition $\xi$ is $\mathcal{F}_{T}$-measurable, the coefficient $f$ is continuous with a general growth with respect to the variable $y$ and a stochastic quadratic growth with respect to the variable $z$. The reflecting barriers $L$ and $U$ are assumed to be continuous. The result has been proved without assuming any $P$-integrability conditions on the terminal data. It should be noted that the integral with respect to the continuous increasing process appears naturally when the authors tried to eliminate the quadratic term by using an exponential transformation. An application of the above result to the Dynkin game problem as well as to the American game option is studied in 8].

The above result on RBSDE has been generalized by Essaky, Hassani and Ouknine 9 to the case of a RBSDE with two rcll barriers which involves a term of the form $\sum_{t<s \leq T} h\left(s, Y_{s-}, Y_{s}\right)$. The authors have proved the existence of solutions by establishing first a correspondence between the initial RBSDE and another RBSDE whose coefficients are more tractable. They have shown that the existence of solutions for the initial RBSDE is equivalent to the existence of solutions for the auxiliary RBSDE. Since the integrability conditions on parameters are weaker, they have made use of approximations and truncations to establish the existence result for the auxiliary RBSDE.

It should be pointed out that, in the case of continuous or rcll solutions, all the previous papers on RBSDEs were developed in the framework of continuous or rcll obstacles. It is then natural to ask the following question : is there any weaker conditions on the data under which the RBSDE has a solution?

In another context, we recall that, when the barriers is $L^{2}$-process, Peng and Xu [20] have proved the existence and uniqueness of solutions for RBSDE under Lipschitz condition on the generator and square integrable data where the following condition has been considered instead of condition (iii) in Equation (1.1):

In this paper, we are concerned with the study of the following RBSDE with irregular barriers, for which the solution $Y$ has to remain between two rcll barriers $L$ and $U$ on $[0, T[$, and its left limit
has to stay respectively above and below two predictable barriers $l$ and $u$ on $] 0, T]$, of the form

Here, $\mathcal{D}$ is the set of measurable and right continuous with left limits (rcll for short) processes with values in $\mathbb{R}$, the notation $d K^{+} \perp d K^{-}$means that $K^{+}$and $K^{-}$are singular, $\alpha, \delta$ and $A$ are predictable, right continuous and nondecreasing processes, the generators $f$ and $g$ are assumed to be continuous with general growth with respect to the variable $y$ and $f$ satisfies further the following so-called stochastic quadratic growth condition:

Without assuming any $P$-integrability conditions on the data, we prove the existence of maximal and minimal solutions to Equation (1.2) by constructing two new rcll reflecting barriers $\bar{Y}$ and $\underline{Y}$ which are in fact the limit of the penalizing equations driven by the dominating conditions assumed on the data. With these new rcll barriers a new RBSDE is considered. Our new idea consists to deduce the solvability of the original RBSDE (1.2) from the solvability of the new one.

More precisely, we construct two rcll reflecting barriers $\bar{Y}$ and $\underline{Y}$ such that: $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of the above RBSDE (1.2) if and only if it is a solution of the following RBSDE with the two reflecting rcll barriers $\underline{Y}$ and $\bar{Y}$ :

It should be noted that, since the processes $\bar{Y}$ and $\underline{Y}$ are rcll, the existence of solutions for this last equation is ensured by the work [9, Theorem 2.1.].

Our second goal is to write the RBSDE (1.2) in a standard form without introducing the test barriers $L^{*}$ and $U^{*}$. To this purpose, we construct two predictable processes $l^{*, \delta}(t)$ and $(-u)^{*, \alpha}(t)$, associated to $l$ and $u$, by the following formulas (see Section 5 and the Appendix for more details)

and then we prove that our RBSDE (1.2) can be written in a standard form as follows

This is done by proving the following characterization :

A particular form of such RBSDE is related to the notion of generalized Snell envelope of a predictable process $l:=\left(l_{t}\right)_{0 \leq t \leq T}$ introduced in [10]. Roughly speaking, let $l:=\left(l_{t}\right)_{0 \leq t \leq T}$ be an $\mathcal{F}_{t^{-}}$ adapted right continuous with left limits process with values in $\mathbb{R}$ of class $D[0, T]$, that is the family $\left(l_{\nu}\right)_{\nu \in \mathcal{T}}$ is uniformly integrable, where $\mathcal{T}$ is the set of all $\mathcal{F}_{t}$-stopping times $\nu$, such that $0 \leq \nu \leq T$. The Snell envelope $\mathcal{S}_{t}(l)$ of $l:=\left(l_{t}\right)_{0 \leq t \leq T}$ is defined as

where $\mathcal{T}_{t}$ is the set of all stopping times valued between $t$ and $T$. According to the work of Mertens (see [4]), $\mathcal{S}$ is the smallest rcll-supermartingale of class $D[0, T]$ which dominates the process $l$, i.e.,

Suppose now that the process $l$ is neither of class $D[0 ; T]$ nor a rcll process but just a predictable process. Let $L \in \mathcal{D}$ and $\delta \in \mathcal{K}$ and assume that there exists a local martingale $M_{t}=M_{0}+\int_{0}^{t} \kappa_{s} d B_{s}$ such that $P$-a.s.,

Then, we prove that the minimal solution $Y$ of the following RBSDE with lower barriers $L$ and $l$,

The process $Y$ (denoted by $\mathcal{S} .(L, l d \delta)$ ) is called the generalized Snell envelope (see Section 6 for more details). As an example, if we assume that $\delta_{t}=\lambda$ the Lebesgue measure, then $Y=\mathcal{S}_{.}\left(L_{t} 1_{\{t<T\}}+\right.$
$\left.\left.\xi 1_{\{t=T\}}, l d \lambda\right)\right)$ the solution of the following RBSDE

is the smallest local super-martingale dominating the predictable process $l$, i.e.

A second example in the case of $\delta_{t}=1_{\left\{T^{\prime} \leqslant t\right\}}$, where $T^{\prime}$ is a stopping time on $[0, T]$ is also given.
Let us describe our plan. In Section 2, we introduce the definition of our RBSDE with irregular barriers. Remarks on assumptions and main result of the paper is introduced in Section 3. In Section 4, we prove the existence of maximal (and minimal) solution of the RBSDE. Section 5 is devoted to find an equivalent and standard form to our initial RBSDE. An application to the notion of generalized Snell envelope is given in Section 6. Finally, most of the material needed in Sections 5 and 6 is given, in a more general setting, in the appendix.

## 2 Definition of a solution for RBSDEs

### 2.1 Notations

Let $\left(B_{t}\right)_{t \leq T}$ be a Brownian motion defined on some probability space $(\Omega, \mathcal{F}, P)$ and let $\left(\mathcal{F}_{t}\right)_{t \leq T}$ be the standard augmentation of the filtration generated by $\left(B_{t}\right)_{t \leq T}$.

For simplicity, we omit sometimes dependence on $\omega$ of some processes or random functions.
The following sets will be frequently used in the sequel.

- $\mathcal{P}$ is the sigma algebra of $\left(\mathcal{F}_{t}\right)_{t}$-predictable sets on $[0, T] \times \Omega$.
- $\mathcal{D}$ is the set of $\mathcal{P}$-measurable and right continuous with left limits (rcll for short) processes $\left(Y_{t}\right)_{t \leq T}$ with values in $\mathbb{R}$.
- For a given process $Y \in \mathcal{D}$, we denote : $Y_{t-}=\lim _{s \nearrow t} Y_{s}, t \leq T\left(Y_{0-}=Y_{0}\right)$, and $\Delta_{s} Y=Y_{s}-Y_{s-}$ the size of its jump at time $s$.
- $\mathcal{K}:=\left\{K \in \mathcal{D} \quad: \quad K\right.$ is nondecreasing and $\left.K_{0}=0\right\}$.

For a given process $V \in \mathcal{K}-\mathcal{K}$ and for each $\omega \in \Omega, d V_{t}(\omega)$ denotes the signed measure on ( $\left.[0, T], \mathcal{B}_{[0, T]}\right)$ associated to $V_{t}(\omega)$ where $\mathcal{B}_{[0, T]}$ is the Borel sigma-algebra on $[0, T]$ and

- $\mathcal{L}^{2, d}$ the set of $\mathbb{R}^{d}$-valued and $\mathcal{P}$-measurable processes $\left(Z_{t}\right)_{t \leq T}$ such that

The following notations are also needed :

- For a set $B, 1_{B}$ denotes the indicator of $B$.
- For each $(a, b) \in \mathbb{R}^{2}, a \wedge b=\min (a, b), a \vee b=\max (a, b), a^{+}=a \vee 0$ and $a^{-}=(-a) \vee 0$.
- For all $(a, b, c) \in \mathbb{R}^{3}$ such that $a \leq c, a \vee b \wedge c=(a \vee b) \wedge c=a \vee(b \wedge c)$.


### 2.2 The data

Throughout the paper we need the following data.

1. Terminal data : $\xi$ is a $\mathcal{F}_{T}$-measurable one dimensional random variable.

## 2. Lower Barriers :

a. $l:=\left\{l_{t}, 0 \leq t \leq T\right\}$ is a $\mathcal{P}$-measurable process.
b. $L:=\left\{L_{t}, 0 \leq t \leq T\right\}$ is a process which belong to $\mathcal{D}$.

## 3. Upper Barriers :

a. $u:=\left\{u_{t}, 0 \leq t \leq T\right\}$ is a $\mathcal{P}$-measurable processes.
b. $U:=\left\{U_{t}, 0 \leq t \leq T\right\}$ is a process which belong to $\mathcal{D}$.

## 4. Drivers (or generators) :

a. $f:[0, T] \times \Omega \times \mathbb{R} \times \mathbb{R}^{d} \longrightarrow \mathbb{R}$ is a function such that for every $(y, z) \in \mathbb{R} \times \mathbb{R}^{d}$,

5. Processes : $\alpha, \delta$ and $A$ are processes in $\mathcal{K}$.

### 2.3 Definition of a solution

Before giving the definition of our RBSDE, let us first give the following definition.
Definition 2.1. Let $K^{1}$ and $K^{2}$ be two processes in $\mathcal{K}$. We say that:

1. $K^{1}$ and $K^{2}$ are singular if and only if there exists a set $D \in \mathcal{P}$ such that

Let us now introduce the definition of our RBSDE for which the solution is constrained to stay between given rcll processes $L$ and $U$ and $\mathcal{P}$-measurable processes $l$ and $u$ (conditions (ii) and (iii)). Two nondecreasing processes $K^{+}$and $K^{-}$are introduced in order to push the solution $Y$ to stay between the barriers in a minimal way. This minimality property on $K^{+}$and $K^{-}$is ensured by the generalized Skorohod conditions (condition (iv)) together with the additional constraint $d K^{+} \perp d K^{-}$ (condition $(v i)$ ). It should be noted that this orthogonality condition is introduced for the first time in the domain of BSDE in the paper [6].

Definition 2.2. 1. A quadruple $\left(Y, Z, K^{+}, K^{-}\right) \in \mathcal{D} \times \mathcal{L}^{2, d} \times \in \mathcal{K} \times \mathcal{K}$, is a solution of the RBSDE, associated with the data $(\xi, f d t+g d A, l d \delta+L d t, u d \alpha+U d t)$, if (i), (ii), (iii), (iv) and (vi) of Equation (1.2) are satisfied.
2. We say that the RBSDE (1.2) has a maximal (resp. minimal) solution $\left(Y_{t}, Z_{t}, K_{t}^{+}, K_{t}^{-}\right)_{t \leq T}$ if for any other solution $\left(Y_{t}^{\prime}, Z_{t}^{\prime}, K_{t}^{\prime+}, K_{t}^{\prime-}\right)_{t \leq T}$ we have for all $t \leq T, Y_{t}^{\prime} \leq Y_{t}$, P-a.s. (resp. $Y_{t}^{\prime} \geq Y_{t}$, P-a.s.).

In order to rewrite equation (1.2) to a more tractable form we introduce the following set:

It should be pointed out that, for every processes $Y, Y^{\prime}$ and $Y^{\prime \prime}$ in $\mathcal{D}$, if $Y, Y^{\prime} \in D o m$ and for all $t \in\left[0, T\left[, Y_{t} \wedge Y_{t}^{\prime} \leqslant Y_{t}^{\prime \prime} \leqslant Y_{t} \vee Y_{t}^{\prime}\right.\right.$ then $Y^{\prime \prime} \in$ Dom.

Remark 2.2. Using the set Dom, the RBSDE (1.2) can be written as follows :

## 3 Main result

We shall need the following assumptions:

1. Assumption (A.1) on $f$ :

There exist two processes $\eta \in L^{0}\left(\Omega, L^{1}\left([0, T], d t, \mathbb{R}_{+}\right)\right)$and $C \in \mathcal{D}$ such that the driver $f$ satisfies the following conditions:
(a) for all $(y, z) \in \mathbb{R} \times \mathbb{R}^{d},\left|f\left(t, \omega, L_{t}(\omega) \vee y \wedge U_{t}(\omega), z\right)\right| \leq \eta_{t}(\omega)+C_{t}(\omega)|z|^{2}, \quad d t P(d \omega)-$ a.e.
(b) $d t P(d \omega)$-a.e., the function $(y, z) \longmapsto f(t, \omega, y, z)$ is continuous.
2. Assumption (A.2) on $\boldsymbol{g}$ : There exists $\beta \in L^{0}\left(\Omega, L^{1}\left([0, T], A(d t), \mathbb{R}_{+}\right)\right)$such that:
(a) $A(d t) P(d \omega)$-a.e., for every $(x, y) \in \mathbb{R} \times \mathbb{R}$,

There exists a semimartingale $S .=S_{0}+V^{-}-V_{+}^{+}+\int_{0}^{.} \gamma_{s} d B_{s}$, with $S_{0} \in \mathbb{R}, V^{ \pm} \in \mathcal{K}$ and $\gamma \in \mathcal{L}^{2, d}$, such that $S \in$ Dom.
The following theorem constitutes the main result of the paper whose proof is postponed to the next section.

Theorem 3.1. If assumptions $(\boldsymbol{A} .1)-(\boldsymbol{A} .3)$ hold then the RBSDE (2.5) has a maximal and minimal solution.

Let us give the following remarks on the assumptions.
Remark 3.1. 1. By taking $L_{t} 1_{[0, T[ }(t)+\xi 1_{\{T\}}(t), U_{t} 1_{[0, T[ }(t)+\xi 1_{\{T\}}(t)$ and $S_{t} 1_{[0, T[ }(t)+\xi 1_{\{T\}}(t)$, instead of $L_{t}, U_{t}$ and $S_{t}$ respectively, we can assume without loss of generality, that

Indeed, in conditions (A.1)(a) and (A.2)(a), we have just to take the processes $\eta, C$ and $\beta$ as follows:

This means that the functions $f$ and $g$ can have, in particular, a general growth with respect to $(x, y)$ and stochastic quadratic growth with respect to $z$. In this respect, assumptions (A.1)(a) and (A.2)(a) are not restrictive.
3. Suppose that there exist two processes $\bar{L}, \bar{U} \in \operatorname{Dom}$ completely separated, i.e. the processes $\bar{L}$ and $\bar{U}$ are such that:

## 4 Proof of the main result

This section is devoted to the proof of the existence of maximal solution to Equation (2.5) by using a penalization method. This method allows us to construct two rcll reflecting barriers which are in fact the limit of penalized equations driven by the dominating conditions assumed on $f$ and $g$. However, our approach consists to deduce the solvability of a RBSDE (2.5) from a suitable RBSDE with two rcll reflecting barriers which is equivalent to our initial RBSDE and its solvability is ensured by [9.

### 4.1 Comparison theorem for maximal solutions

Let us now give the following comparison theorem which plays a crucial rule in the proof of our main result. For this reason, suppose that assumptions (A.1)-(A.2) hold and (Y,Z, $\left.K^{+}, K^{-}\right)$is the maximal solution for the following RBSDE

Theorem 4.1. [Comparison theorem for maximal solutions] Under hypothesis (H), we get

then it follows from comparison theorem (Theorem4.1) applied to $Y$ and $\bar{Y}^{n}$, that for all $n \in \mathbb{N}$,

Y_{t} \leq \bar{Y}_{t}^{n}
$$

and then $Y_{t} \leq \bar{Y}_{t}$. Hence $U_{t}^{*}=\bar{Y}_{t}$. By a symmetric argument we get also that $L_{t}^{*}=\underline{Y}_{t}$. Therefore $\left(Y, Z, K^{+}, K^{-}\right)$is a solution to RBSDE (4.21).

Conversely, suppose now that $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of (4.21). In order to prove that ( $Y, Z, K^{+}, K^{-}$) is a solution of RBSDE (2.5) we just need to prove (iii) of RBSDE (2.5). Let $L^{*} \in D o m$ and consider $\left(Y^{*}, Z^{*}, K^{+*}, K^{-*}\right)$ the minimal solution of the following RBSDE
$\begin{cases}\text { (i) } & Y_{t}^{*}=\xi+\int_{t}^{T}\left[\left(f\left(s, Y_{s}, Z_{s}\right)-\frac{m_{s}}{2}\left|Z_{s}^{*}-Z_{s}\right|^{2}\right) d s+g\left(s, Y_{s-}, Y_{s}\right) d A_{s}+d K_{s}^{*+}-d K_{s}^{*-}-Z_{s}^{*} d B_{s}\right], \\ \text { (ii) } \quad \forall t \in\left[0, T\left[, Y_{t} \leq Y_{t}^{*} \leq L_{t}^{*} \vee Y_{t},\right.\right. \\ (\text { iii }) & \int_{0}^{T}\left(Y_{t-}^{*}-Y_{t-}\right) d K_{t}^{*+}=\int_{0}^{T}\left(\left(L_{t-}^{*} \vee Y_{t-}\right)-Y_{t-}^{*}\right) d K_{t}^{*-}=0, \text { a.s., } \\ (v) & Y^{*} \in \mathcal{D}, \quad K^{*+}, K^{*-} \in \mathcal{K}, \quad Z^{*} \in \mathcal{L}^{2, d}, \\ (v i) & d K^{*+} \perp d K^{*-} .\end{cases}$
We note here that this minimal solution exists according to [9]. On the other hand we have
(a) $Y_{s} \leq \bar{Y}_{s} \leq \bar{Y}_{s}^{n}$ and $Y_{s}^{*} \leq L_{s}^{*} \vee Y_{s} \leq L_{s}^{*} \vee \bar{Y}_{s} \leq U_{s}$,
(b) $\left[f\left(s, Y_{s}, Z_{s}\right)-\frac{m_{s}}{2}\left|Z_{s}^{*}-Z_{s}\right|^{2}\right] d s+g\left(s, Y_{s-}, Y_{s}\right) d A_{s} \leqslant\left(\eta_{s}+C_{s}\left|Z_{s}\right|^{2}-\frac{m_{s}}{2}\left|Z_{s}^{*}-Z_{s}\right|^{2}\right) d s+\beta_{s} d A_{s}$

$$
\leqslant\left(\eta_{s}+4 C_{s}\left|\gamma_{s}\right|^{2}+\frac{m_{s}}{2}\left|Z_{s}^{*}-\gamma_{s}\right|^{2}\right) d s+\beta_{s} d A_{s}+d V_{s}^{+}+d V_{s}^{-}-\underbrace{n\left(u_{s}-Y_{s-}^{*}\right)^{-} d \alpha_{s}}_{=0} .
$$

Applying the comparison theorem (Theorem 4.1) to $Y^{*}$ and $\bar{Y}^{n}$, we get $\forall n \in \mathbb{N}, Y^{*} \leq \bar{Y}^{n}$. Letting $n$ to infinity we obtain $Y^{*} \leq \bar{Y}$. Applying again comparison theorem (Theorem 4.1) to $-Y^{*}$ and $-Y$ it follows that $Y^{*} \leq Y$. Then

Y^{*}=Y, \quad Z=Z^{*} \text { and } d K^{*-}=d K^{-}
$$

Henceforth

\left(Y_{s-}-L_{s-}^{*}\right)^{-} d K_{s}^{-}=\left(L_{s-}^{*} \vee Y_{s-}-Y_{s-}\right) d K_{s}^{*-}=0
$$

By symmetric argument we get also,

\left(Y_{s-}-L_{s-}^{*}\right)^{+} d K_{s}^{+}=0
$$

Consequently $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of (2.5).
As consequence we get the following result
Corollary 4.1. ( $Y, Z, K^{+}, K^{-}$) is a maximal (resp. minimal) solution of RBSDE (2.5) if and only if $\left(Y, Z, K^{+}, K^{-}\right)$is a maximal (resp. minimal) solution of RBSDE 4.21).

Proof of Theorem 3.1 According to [Theorem 2.1., [9], there exists ( $Y, Z, K^{+}, K^{-}$) a maximal (resp. minimal) solution of RBSDE (4.21) and then by Corollary 4.1, ( $\left.Y, Z, K^{+}, K^{-}\right)$is a maximal (resp. minimal) solution of RBSDE (2.5).

## 5 Further study: standard form of RBSDE

In this section, we want to find an equivalent and standard form to our initial RBSDE (2.5) by giving another characterization of the $D o m$ without introducing the test barriers $L^{*}$ and $U^{*}$.

First, from the appendix, we have the following characterization of Dom.
Proposition 5.1. $\left.\left.D o m=\{Y \in \mathcal{D}: \quad[\forall t \in] 0, T], L_{t-} \vee l_{t}^{*, \delta} \leqslant Y_{t-} \leqslant U_{t-} \wedge\left(-(-u)_{t}^{*, \alpha}\right)\right] P-a s\right\}$, where $l^{*, \delta}(t)$ and $(-u)^{*, \alpha}(t)$ are defined respectively by (see the appendix for more details)

\begin{aligned}
l^{*, \delta}(t) & =\inf _{n}\left\{-n t+\inf \left\{a \in \mathbb{R}: \int_{0}^{t}\left[l_{s}+n s-a\right]^{+} d \delta_{s}=0\right\}\right\} \\
(-u)^{*, \alpha}(t) & =\inf _{n}\left\{-n t+\inf \left\{a \in \mathbb{R}: \int_{0}^{t}\left[-u_{s}+n s-a\right]^{+} d \alpha_{s}=0\right\}\right\}
\end{aligned}
$$

The following theorem proves that our original RBSDE can be written in a standard form.
Theorem 5.1. $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of $R B S D E$ (2.5) if and only if $\left(Y, Z, K^{+}, K^{-}\right)$satisfies
$\begin{cases}\text { (i) } & Y_{t}=\xi+\int_{t}^{T}\left[f\left(s, Y_{s}, Z_{s}\right) d s+g\left(s, Y_{s-}, Y_{s}\right) d A_{s}+d K_{s}^{+}-d K_{s}^{-}-Z_{s} d B_{s}\right], \\ \text { (ii) } & \forall t \in] 0, T], L_{t-} \vee l^{*, \delta}(t) \leqslant Y_{t-} \leqslant-(-u)^{*, \alpha}(t) \wedge U_{t-}, \\ \text { (iii) } & \int_{0}^{T}\left(Y_{t-}-\left[L_{t-} \vee l^{*, \delta}(t)\right]\right) d K_{t}^{+}=\int_{0}^{T}\left(\left[U_{t-} \wedge-(-u)^{*, \alpha}(t)\right]-Y_{t-}\right) d K_{t}^{-}=0, \text { a.s., } \\ \text { (iv }) & Y \in \mathcal{D}, \quad K^{+}, K^{-} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2}, d \\ \text { (v) } & d K^{+} \perp d K^{-} .\end{cases}$

## Proof.

Let $\left(Y, Z, K^{+}, K^{-}\right)$be a solution of RBSDE (2.5), then for all processes $L^{*}$ and $U^{*}$ in Dom such that for all $t \in\left[0, T\left[, L_{t}^{*} \leqslant Y_{t} \leqslant U_{t}^{*}\right.\right.$ we have $\left(Y, Z, K^{+}, K^{-}\right)$is also a solution of the following RBSDE

$$
\begin{cases}\text { (i) } & Y_{t}=\xi+\int_{t}^{T}\left[f\left(s, Y_{s}, Z_{s}\right) d s+g\left(s, Y_{s-}, Y_{s}\right) d A_{s}+d K_{s}^{+}-d K_{s}^{-}-Z_{s} d B_{s}\right], \\ \text { (ii) } & \forall t \in\left[0, T\left[, L_{t}^{*} \leq Y_{t} \leq U_{t}^{*}\right.\right. \\ \text { (iii) } & \int_{0}^{T}\left(Y_{t-}-L_{t-}^{*}\right) d K_{t}^{+}=\int_{0}^{T}\left(U_{t-}^{*}-Y_{t-}\right) d K_{t}^{-}=0, \text { a.s., } \\ \text { (iv) } & Y \in \mathcal{D}, K^{+}, K^{-} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2, d}, \\ \text { (v) } & d K^{+} \perp d K^{-} .\end{cases}
$$

But for each integers $n$ and $m$,

L_{t}^{n}(\omega)=L_{t}(\omega) \vee l^{n, \delta}(t+, \omega) \wedge Y_{t}(\omega) \quad \text { and } \quad U_{t}^{m}(\omega)=Y_{t}(\omega) \vee\left[-(-u)^{m, \alpha}(t+, \omega)\right] \wedge U_{t}(\omega)
$$

are in $D o m$ and $L_{t}^{n} \leqslant Y_{t} \leqslant U_{t}^{m}$, where

l^{n, \delta}(t, \omega)=-n t+\operatorname{essup}_{s \leqslant t}^{\delta}[l(s, \omega)+n s] \text { and }(-u)^{m, \alpha}(t, \omega)=-m t+\operatorname{essup}_{s \leqslant t}^{\alpha}[-u(s, \omega)+m s]
$$

We deduce that, for each integers $n$ and $m$

$$

It follows from Appendix that

$$

Then passing in limit and using monotone convergence theorem we get

This gives the necessary implication.
Let us now show the reverse. Suppose that $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of $\operatorname{RBSDE}$ (5.22). In order to prove that $\left(Y, Z, K^{+}, K^{-}\right)$is a solution of RBSDE (2.5) it remains to prove (iii) and $Y \in D o m$. Let $L^{*} \in D o m$, it follows that

Using the same method as above we have also

\left.(\forall t \in] 0, T], \quad L_{t-}^{*} \leqslant-(-u)^{*, \alpha}(t) \wedge U_{t-}\right) \quad P \text {-as }
$$

Henceforth

$$
\begin{aligned}
& \mathbb{E} \int_{0}^{T}\left(Y_{t-}-L_{t-}^{*}\right)^{+} d K_{t}^{+}+\left(Y_{t-}-L_{t-}^{*}\right)^{-} d K_{t}^{-} \\
& \leq \mathbb{E} \int_{0}^{T}\left(Y_{t-}-\left[L_{t-} \vee l^{*, \delta}(t)\right]\right) d K_{t}^{+}+\mathbb{E} \int_{0}^{T}\left(\left[U_{t-} \wedge-(-u)^{*, \alpha}(t)\right]-Y_{t-}\right) d K_{t}^{-}=0
\end{aligned}
$$

Then ( $i$ iii) is satisfied.
Let us now show that $Y \in$ Dom. It follows from (ii) and Corollary 7.1 that

which is equivalent to

\text { if } u_{t}<\left[U_{t-} \wedge-(-u)_{-}^{*, \alpha}(t)\right] \text { and } \Delta_{t} \alpha>0 \text { then } \Delta_{t} K^{-}=0 .

## 6 Particular case: Generalized Snell envelope

Let $l$ be a predictable process, $L \in \mathcal{D}$ and $\delta \in \mathcal{K}$ satisfying the following hypothesis:
(A) There exists a local martingale $M_{t}=M_{0}+\int_{0}^{t} \kappa_{s} d B_{s}$ such that $P$-a.s.,

$$
\left.\left.\left.\left.L_{t} \leq M_{t} \text { on }\right] 0, T\right] \quad \text { and } \quad l_{t} \leq M_{t} d \delta_{t} \text {-a.e. on }\right] 0, T\right] .
$$

Let $U_{t}=U_{0}-V_{t}+\int_{0}^{t} \chi_{s} d B_{s}$, where $V \in \mathcal{K}$ and $\chi \in \mathcal{L}^{2, d}$, be a rcll local supermartingale such that $P$-a.s.,

$$
\left.\left.\left.\left.L_{t} \leq U_{t} \text { on }\right] 0, T\right] \quad \text { and } \quad l_{t} \leq U_{t-} d \delta_{t} \text {-a.e. on }\right] 0, T\right]
$$

According to our main result, let $\left(Y, Z, K^{+}, K^{-}\right)$be the minimal solution of the following RBSDE

$$
\begin{cases}\text { (i) } & Y_{t}=L_{T}+\int_{t}^{T}\left[d K_{s}^{+}-d K_{s}^{-}-Z_{s} d B_{s}\right] \\ \text { (ii) } & \forall t \in] 0, T], L_{t-} \vee l^{*, \delta}(t) \leqslant Y_{t-} \leqslant U_{t-}, \\ \text { (iii) } & \int_{0}^{T}\left(Y_{t-}-\left[L_{t-} \vee l^{*, \delta}(t)\right]\right) d K_{t}^{+}=\int_{0}^{T}\left(U_{t-}-Y_{t-}\right) d K_{t}^{-}=0, \text { a.s. } \\ \text { (iv) } & Y \in \mathcal{D}, \quad K^{+}, K^{-} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2, d} \\ (v) & d K^{+} \perp d K^{-}\end{cases}
$$

Applying comparison theorem (Theorem 4.1) to the processes $U_{t}$ and $Y_{t}$, we get $d K^{-}=0$. Then $Y$ is a local supermartingale minimal solution of the following RBSDE

$$
\begin{cases}\text { (i) } & Y_{t}=L_{T}+\int_{t}^{T}\left[d K_{s}^{+}-Z_{s} d B_{s}\right]  \tag{6.23}\\ \text { (ii) } & \forall t \in] 0, T], L_{t-} \vee l^{*, \delta}(t) \leqslant Y_{t-} \\ \text { (iii) } & \int_{0}^{T}\left(Y_{t-}-\left[L_{t-} \vee l^{*, \delta}(t)\right]\right) d K_{t}^{+}=0, \text { a.s. } \\ \text { (iv) } & Y \in \mathcal{D}, \quad K^{+} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2, d}\end{cases}
$$

Henceforth, we obtain the following result.
Theorem 6.1. Suppose that (A) hold. Then the minimal solution $Y$ of (6.23) is the smallest rcll local super-martingale satisfying $P$-a.s.,

\left.\left.\left.\left.L_{t} \leq Y_{t} \quad \text { on }\right] 0, T\right] \quad \text { and } \quad l_{t} \leq Y_{t-} d \delta_{t} \text {-a.e. on }\right] 0, T\right]
$$

We say that $Y$ is the generalized Snell envelope associated to $L$ and $l d \delta$. We denote it by $\mathcal{S}$. $(L, l d \delta)$.
Remark 6.1. We know that if $L$ is of class $D$ then $L$ satisfies assumption (A) (see DellacherieMeyer [4], Theorem 24 page 419). In this case our generalized Snell envelope $\mathcal{S} .(L)=\mathcal{S} .(L, 0 d 0)$ coincides with the usual Snell envelope $\operatorname{essup}_{\tau \in \mathcal{T}_{t}} \mathbb{E}\left[L_{\tau} \mid \mathcal{F}_{t}\right]$, where $\mathcal{T}_{t}$ is the set of all stopping times valued between $t$ and $T$, as presented in [Dellacherie-Meyer [4], page 416] and studied by several authors.

Let us give the following two examples in the case where $\delta_{t}=\lambda$ the Lebesgue measure and $\delta_{t}=1_{\left\{T^{\prime} \leq t\right\}}$, where $T^{\prime}$ is a stopping time with values in $[0, T]$.
Example 6.1. Let $l$ be a predictable process and $\xi$ a $\mathcal{F}_{T}$-measurable random variable such that there exist $L \in \mathcal{D}$ and $M$ a local martingale such that $L_{t} \leq l_{t} \leq M_{t} d \lambda$-a.e and $\xi \leq M_{T}$ (where $\lambda$ denotes the Lebesgue measure). Let $\left(Y, Z, K^{+}, K^{-}\right)$be the minimal solution of the following RBSDE

$$
\begin{cases}\text { (i) } & Y_{t}=\xi+\int_{t}^{T}\left[d K_{s}^{+}-Z_{s} d B_{s}\right], t \leq T \\ \text { (ii) } \left.\left.\quad l_{t}^{*, \lambda} \leq Y_{t-} \text { on }\right] 0, T\right] \\ \text { (iii) } \mathbb{E} \int_{0}^{T}\left(Y_{t-}-l_{t}^{*, \lambda}\right) d K_{t}^{+}=0 \\ (i v) & Y \in \mathcal{D}, \quad K^{+} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2, d}\end{cases}
$$

Then $Y\left(=\mathcal{S} .\left(L_{t} 1_{\{t<T\}}+\xi 1_{\{t=T\}}\right.\right.$, ld $\left.)\right)$ is the smallest local super-martingale such that

$$
l_{t} \leq Y_{t}, d \lambda-a . e \text { and } \xi \leq Y_{T}
$$

Example 6.2. Let $T^{\prime}$ be a stopping time with values in $[0, T], \xi^{\prime}$ a $\mathcal{F}_{T^{\prime}-m e a s u r a b l e ~ r a n d o m ~ v a r i a b l e, ~}^{\text {, }}$ $\xi$ a $\mathcal{F}_{T}$-measurable random variable and $L \in \mathcal{D}$ such that there exists a local martingale $M$ such that $L_{t} \leq M_{t}$ on $\left[0, T\left[, \xi^{\prime} \leq M_{T^{\prime}}\right.\right.$ and $\xi \leq M_{T}$. Let $\left(Y, Z, K^{+}, K^{-}\right)$be the minimal solution of the following RBSDE

$$
\begin{cases}(i) & Y_{t}=\xi+\int_{t}^{T}\left[d K_{s}^{+}-Z_{s} d B_{s}\right], t \leq T, \\ (i i) & \left.\left.L_{t-} \vee l_{t}^{*, \delta} \leq Y_{t-} \text { on }\right] 0, T\right], \\ (i i i) & \mathbb{E} \int_{0}^{T}\left(Y_{t-}-L_{t-} \vee l_{t}^{*, \delta}\right) d K_{t}^{+}=0, \\ (i v) & Y \in \mathcal{D}, \quad K^{+} \in \mathcal{K}, \quad Z \in \mathcal{L}^{2, d},\end{cases}
$$

where $\delta_{t}=1_{\left\{T^{\prime} \leqslant t\right\}}$ and $l_{t}=\xi^{\prime} 1_{\left\{t=T^{\prime}\right\}}$ hence $l_{t}^{*, \delta}=-\infty \mathbf{1}_{\left\{t \neq T^{\prime}\right\}}+\xi^{\prime} \mathbf{1}_{\left\{t=T^{\prime}\right\}}$. Then $Y\left(=\mathcal{S} .\left(L_{t} 1_{\{t<T\}}+\right.\right.$ $\left.\left.\xi 1_{\{t=T\}}, l d \delta\right)\right)$ is the smallest local super-martingale such that

L_{t} \leq Y_{t}, \quad \text { on }\left[0, T\left[, \quad \xi^{\prime} \leq Y_{T^{\prime}-} \quad \text { and } \quad \xi \leq Y_{T}\right.\right.
$$

## 7 Appendix

In this appendix we give, in particular, the following characterization: for $Y \in \mathcal{D}$ we have the following

$$
\left.\left.\left(g(t, \omega) \leqslant Y_{t-}(\omega)\right) d \rho_{t}(\omega) P(d \omega) \text {-a.e } \quad \text { if and only if } \quad(\forall t \in] 0, T\right], \quad g^{*, \rho}(t, \omega) \leqslant Y_{t-}(\omega)\right) \quad P \text {-as, }
$$

where $\rho$ is a process in $\mathcal{K}$. This characterization allow us to write our RBSDE in standard form.
Let $g:] 0, T] \times \Omega \rightarrow \mathbb{R}$ be a progressively measurable function and $\rho$ be a process in $\mathcal{K}$.
Note for $(t, \omega) \in[0, T] \times \Omega$ and $n \in \mathbb{N}$

\begin{align*}
g^{n, \rho}(t, \omega) & =-n t+\operatorname{essup}_{s \leqslant t}^{\rho}[g(s, \omega)+n s] \\
& =-n t+\inf \left\{\alpha \in \mathbb{R}: \int_{0}^{t}[g(s, \omega)+n s-\alpha]^{+} d \rho_{s}(\omega)=0\right\} \tag{7.24}
\end{align*}
$$

We have the following.
Proposition 7.1. For every $n \in \mathbb{N}^{*}, g^{n, \rho}$ is a predictable process satisfying:

1. For each $\omega \in \Omega, t \mapsto n t+g^{n, \rho}(t, \omega)$ is a non-decreasing function and then $t \mapsto g^{n, \rho}(t, \omega)$ is làglàd with $g^{n, \rho}(t-, \omega) \leqslant g^{n, \rho}(t, \omega) \leqslant g^{n, \rho}(t+, \omega)$ and such that
(a) $g^{n, \rho}(t-, \omega)=-n t+\inf \left\{\alpha \in \mathbb{R}: \int_{0}^{t-}[g(s, \omega)+n s-\alpha]^{+} d \rho_{s}(\omega)=0\right\}$.
(b) If $\Delta_{t} \rho(\omega)>0$, then $g^{n, \rho}(t, \omega)=g^{n, \rho}(t-, \omega) \vee g(t, \omega)$.
(c) If $\Delta_{t} \rho(\omega)=0$, then $g^{n, \rho}(t, \omega)=g^{n, \rho}(t-, \omega)$.
2. For each $(t, \omega) \in[0, T] \times \Omega,-\infty \leq g^{n+1, \rho}(t, \omega) \leq g^{n, \rho}(t, \omega)$.
3. If $g \leqslant h d \rho_{s}(\omega) P(d \omega)$-a.e. then $P$-a.e. $\omega \in \Omega$ for every $t \in[0, T]$ and $n \in \mathbb{N}$, we have

$$
g^{n, \rho}(t, \omega) \leqslant h^{n, \rho}(t, \omega) \leqslant \sup _{s \leqslant t}[h(s, \omega)-n(t-s)] .
$$

Proof. Properties 1, 2 and 3 are obvious. The predictability follows from the fact that

$$
\left\{(t, \omega): n t+g^{n, \rho}(t, \omega) \leq a\right\}=\left\{(t, \omega): \int_{0}^{t}[g(s, \omega)+n s-a]^{+} d \rho_{s}(\omega)=0\right\}
$$

Let us now define

$$
g^{*, \rho}(t, \omega)=\inf _{n} g^{n, \rho}(t, \omega), \quad g_{-}^{*, \rho}(t, \omega)=\inf _{n} g^{n, \rho}(t-, \omega) \quad \text { and } \quad g_{+}^{*, \rho}(t, \omega)=\inf _{n} g^{n, \rho}(t+, \omega)
$$

Remark 7.1. We have the following:

1. $g_{-}^{*, \rho}(t, \omega) \leqslant g^{*, \rho}(t, \omega) \leqslant g_{+}^{*, \rho}(t, \omega)$.
2. If $\Delta_{t} \rho(\omega)>0$, then $g^{*, \rho}(t, \omega)=g_{-}^{*, \rho}(t, \omega) \vee g(t, \omega)$.
3. If $\Delta_{t} \rho(\omega)=0$ then $g^{*, \rho}(t, \omega)=g_{-}^{*, \rho}(t, \omega)$.

In particular, for every $\omega \in \Omega$

$$
\left.\left.\left.\{t \in] 0, T]: g^{*, \rho}(t, \omega)>g_{-}^{*, \rho}(t, \omega)\right\} \subset\{t \in] 0, T\right]: \Delta_{t} \rho(\omega)>0\right\}
$$

and then $\left.\{t \in] 0, T]: g^{*, \rho}(t, \omega)>g_{-}^{*, \rho}(t, \omega)\right\}$ is a countable set.
Proposition 7.2. For every $\omega \in \Omega$,

$$
\left.\left.g(t, \omega) \leq g^{*, \rho}(t, \omega) d \rho_{t}(\omega)-\text { a.e. on } \quad\right] 0, T\right] .
$$

Proof. From the definition of $g^{n, \rho}$, we have that for every $(\omega, t, n)$ in $\left.\left.\Omega \times\right] 0, T\right] \times \mathbb{N}$, there exists a negligible Borel set $N_{(\omega, t, n)}$ with respect to the measure $d \rho_{s}(\omega)$ such that for every $s \in N_{(\omega, t, n)}^{c}$

$$
1_{\{s \leq t\}} g(s, \omega) \leq\left[g^{n, \rho}(t, \omega)+n(t-s)\right] 1_{\{s \leq t\}}
$$

For $\omega \in \Omega$, let

$$
I_{\omega}=\bigcup_{n \in \mathbb{N}}\{t \in] 0, T\left[: g^{n, \rho}(t-, \omega)<g^{n, \rho}(t+, \omega)\right\} \bigcup[\mathbb{Q} \bigcap] 0, T[] \bigcup\{T\}
$$

which is countable and dense in $[0, T]$.
Define the following negligible Borel set with respect to the measure $d \rho_{s}(\omega)$

$$
N_{\omega}=\bigcup_{t \in I_{\omega}} \bigcup_{n \in \mathbb{N}} N_{(\omega, t, n)}
$$

It follows that for every $\omega \in \Omega, s \in N_{\omega}^{c}, n \in \mathbb{N}$ and $t \in I_{\omega}$, we have

$$
1_{\{s \leq t\}} g(s, \omega) \leq\left[g^{n, \rho}(t, \omega)+n(t-s)\right] 1_{\{s \leq t\}}
$$

Let $\omega \in \Omega, s \in N_{\omega}^{c}$. If $s \in I_{\omega}$, we take $t=s$ and by letting $n$ to infinity it follows that $g(s, \omega) \leq$ $g^{*, \rho}(s, \omega)$. Now, if $s \notin I_{\omega}$, then there exits a sequence $\left(t_{p}\right)_{p} \in I_{\omega}$ such that $t_{p} \downarrow s$. Then

$$
g(s, \omega) \leq\left[g^{n, \rho}\left(t_{p}, \omega\right)+n\left(t_{p}-s\right)\right]
$$

Letting $p$ to $\infty$ we have

$$
g(s, \omega) \leq g^{n, \rho}(s+, \omega)=g^{n, \rho}(s, \omega)
$$

The result follows by letting $n$ to infinity.

We have the following characterization.
Corollary 7.1. Let $Y \in \mathcal{D}$

$$
\left.\left.\left(g(t, \omega) \leqslant Y_{t-}(\omega)\right) d \rho_{t}(\omega) P(d \omega)-a . e \quad \text { if and only if } \quad(\forall t \in] 0, T\right], g^{*, \rho}(t, \omega) \leqslant Y_{t-}(\omega)\right) P-a s
$$

## Proof

We use the left continuity of $Y_{t-}$ to prove that $\sup _{s \leqslant t}\left[Y_{s-}-n(t-s)\right]$ converges to $Y_{t-}$ as $n$ goes to infinity.
