# $L^{2}$ DECAY FOR THE LINEARIZED LANDAU EQUATION WITH THE SPECULAR BOUNDARY CONDITION

#### Abstract

In this paper, we develop an alternative approach to establish the $L^{2}$ decay estimate for the linearized Landau equation in a bounded domain with specular boundary condition. The proof is based on the methodology of proof by contradiction motivated by (3) and 4].


## 1. Introduction

We consider the following linearized Landau equation

$$
\begin{equation*}
\partial_{t} f+v \cdot \nabla_{x} f+L f=\Gamma(g, f) \tag{1}
\end{equation*}
$$

The linear operator $L$ is defined as

$$
\begin{equation*}
L=-A-K \tag{2}
\end{equation*}
$$

where the linear operator $A$ consists of the terms with at least one momentum derivative on $f$ as

$$
A f \stackrel{\text { def }}{=} \mu^{-1 / 2} \partial_{i}\left\{\mu^{1 / 2} \sigma^{i j}\left[\partial_{j} f+v_{j} f\right]\right\}=\partial_{i}\left[\sigma^{i j} \partial_{j} f\right]-\sigma^{i j} v_{i} v_{j} f+\partial_{i} \sigma^{i} f
$$

and the linear operator $K$ consists of the rest of the operator $L$ which does not contain any momentum derivative of $f$ as

K f \stackrel{\text { def }}{=}-\mu^{-1 / 2} \partial_{i}\left\{\mu\left[\phi^{i j} *\left\{\mu^{1 / 2}\left[\partial_{j} f+v_{j} f\right]\right\}\right]\right\} .
$$

Note that the momentum derivative $\partial_{j} f$ inside $K f$ can always be moved to $\mu^{1 / 2}$ and outside the convolution by the chain rule and a property of a convolution operator. On the other hand, the nonlinear operator $\Gamma$ is defined as

& \Gamma[g, f] \stackrel{\text { def }}{=} \partial_{i}\left[\left\{\phi^{i j} *\left[\mu^{1 / 2} g\right]\right\} \partial_{j} f\right]-\left\{\phi^{i j} *\left[v_{i} \mu^{1 / 2} g\right]\right\} \partial_{j} f \\
&-\partial_{i}\left[\left\{\phi^{i j} *\left[\mu^{1 / 2} \partial_{j} g\right]\right\} f\right]+\left\{\phi^{i j} *\left[v_{i} \mu^{1 / 2} \partial_{j} g\right]\right\} f \tag{3}
\end{align*}
$$

where the diffusion matrix (collision frequency) $\sigma_{u}^{i j}$ is defined as

\sigma_{u}^{i j}(v) \stackrel{\text { def }}{=} \phi^{i j} * u=\int_{\mathbb{R}^{3}} \phi^{i j}\left(v-v^{\prime}\right) u\left(v^{\prime}\right) d v^{\prime}
$$

We also denote the special case when $u=\mu$ as

\sigma^{i j}=\sigma_{\mu}^{i j}, \quad \sigma^{i}=\sigma^{i j} v_{j} .
$$

1.1. The initial and boundary conditions. The initial-boundary conditions of $f$ for the specular reflection boundary that we consider are given by

f(0, x, v)=f_{0}(x, v), \text { if } x \in \Omega \text { and } v \in \mathbb{R}^{3}  \tag{4}\\
f(t, x, v)=f\left(t, x, v-2\left(v \cdot n_{x}\right) n_{x}\right), \text { if } x \in \partial \Omega \text { and } v \cdot n_{x}<0
\end{array}\right.
$$

for some $\left\|f_{0}\right\|_{\infty, \vartheta+m} \leq \epsilon$, for some small $\epsilon>0, \vartheta \geq 0$ and $m>\frac{3}{2}$. Throughout this paper, our domain $\Omega=\{x: \zeta(x)<0\}$ is connected and bounded with $\zeta(x)$ being a smooth function. We also assume that $\nabla \zeta(x) \neq 0$ at the boundary $\zeta(x)=0$. We define the outward normal vector $n_{x}$ on the boundary $\partial \Omega$ as

n_{x} \stackrel{\text { def }}{=} \frac{\nabla \zeta(x)}{|\nabla \zeta(x)|}
$$

We say that the domain $\Omega$ is rotationally symmetric if there exist vectors $x_{0}$ and $w$ such that

for all $x \in \partial \Omega$. Without loss of generality, we assume that the conservation laws of total mass and energy for $t \geq 0$ terms of the perturbation $f$ :

\int_{\Omega \times \mathbb{R}^{3}} f(t, x, v) \sqrt{\mu} d x d v=0, \quad \int_{\Omega \times \mathbb{R}^{3}}|v|^{2} f(t, x, v) \sqrt{\mu} d x d v=0 \tag{5}
\end{equation*}
$$

In addition, we assume the conservation of total angular momentum if $\Omega$ is rotationally symmetric:

Define the energy

\mathcal{E}_{\vartheta}(f(t)) \stackrel{\text { def }}{=}\|f(t)\|_{2, \vartheta}^{2}+\int_{0}^{t}\|f(s)\|_{\sigma, \vartheta}^{2} d s \tag{7}
\end{equation*}
$$

where

\|f\|_{p, \vartheta}^{p} \stackrel{\text { def }}{=} \int_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{p \vartheta}|f|^{p} d x d v
$$

and

$$
\|f\|_{\sigma, \vartheta}^{2} \stackrel{\text { def }}{=} \iint_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{2 \vartheta}\left[\sigma^{i j} \partial_{i} f \partial_{j} f+\sigma^{i j} v_{i} v_{j} f^{2}\right] d x d v
$$

1.2. Main theorem. We now introduce our main theorem on the $L^{2}$ decay estimates for the weak solutions $f$ to (11).
Theorem 1 (Theorem 13 of [5]). Let $f$ be the weak solution of (11) with initialboundary value conditions (4), which satisfies the conservation laws (5), and (6) if $\Omega$ has a rotational symmetry. Suppose that $\|g\|_{L_{m}^{\infty}}<\epsilon$ for some $\epsilon>0$ and $m>3 / 2$. For any $\vartheta \in 2^{-1} \mathbb{N} \cup\{0\}$, there exist $C$ and $\epsilon=\epsilon(\vartheta)>0$ such that

\sup _{0 \leq s<\infty} \mathcal{E}_{\vartheta}(f(s)) \leq C 2^{2 \vartheta} \mathcal{E}_{\vartheta}\left(f_{0}\right) \tag{8}
\end{equation*}
$$

and

$$
\begin{equation*}
\|f(t)\|_{2, \vartheta} \leq C_{\vartheta, k}\left(\mathcal{E}_{\vartheta+\frac{k}{2}}(0)\right)^{1 / 2}\left(1+\frac{t}{k}\right)^{-k / 2} \tag{9}
\end{equation*}
$$

for any $t>0$ and $k \in \mathbb{N}$, where $\mathcal{E}_{\vartheta}(f(t))$ is defined as (7).

In order to prove Theorem it is crucial to obtain the following positivity of $L$ :
Proposition 1. Let $f$ be a weak solution of (11)-(6) with $\mathcal{E}_{\vartheta}(f(0))$ bounded for some $\vartheta \geq 0$. Then there exists a sufficiently small positive constant $\epsilon>0$ such that if

\|g\|_{L_{m}^{\infty}} \leq \epsilon \tag{10}
\end{equation*}
$$

for some $m>\frac{3}{2}$, then we have $\delta_{\epsilon}>0$ such that

\int_{0}^{1}(L f, f) d s \geq \delta_{\epsilon} \int_{0}^{1}\|f\|_{\sigma}^{2} d s
$$

The proof for this Proposition will be given in the next section.

## 2. Positivity of $L$

In order to prove the positivity of $L$, it suffices to prove the following proposition as we have Lemma 5 of [2]:
Proposition 2. Let $f$ be a weak solution of (1) -(6) with $\mathcal{E}_{\vartheta}(f(0))$ bounded for some $\vartheta \geq 0$. Then there exists a sufficiently small $\epsilon>0$ such that if $\|g\|_{L_{m}^{\infty}} \leq \epsilon$ for some $m>\frac{3}{2}$, we have $C_{\epsilon}>0$ such that

\int_{0}^{1}\|P f(\tau)\|_{\sigma}^{2} d s \leq C_{\epsilon} \int_{0}^{1}\|(I-P) f(\tau)\|_{\sigma}^{2} d s
$$

Proof. If the proposition is not true, then there exist a sequence of family $g_{n}$ and a sequence of solutions $f_{n}$ to (11)-(16) with $g=g_{n}$ and $f=f_{n}$ such that

\left\|g_{n}\right\|_{L_{m}^{\infty}} \leq \frac{1}{n} \tag{11}
\end{equation*}
$$

for some $m>\frac{3}{2}$, but

$$
\begin{equation*}
\int_{0}^{1}\left\|(I-P) f_{n}(\tau)\right\|_{\sigma}^{2} d s \leq \frac{1}{n} \int_{0}^{1}\left\|P f_{n}(\tau)\right\|_{\sigma}^{2} d s \tag{12}
\end{equation*}
$$

for any $n$.
We first prove the weak compactness of $f_{n}$. We first reformulate the equation (1) as

& f_{t}+v \cdot \nabla_{x} f=\bar{A}_{g} f+\bar{K}_{g} f  \tag{13}\\
& \bar{A}_{g} f:= \partial_{i}\left[\left\{\phi^{i j} *\left[\mu+\mu^{1 / 2} g\right]\right\} \partial_{j} f\right] \\
&-\left\{\phi^{i j} *\left[v_{i} \mu^{1 / 2} g\right]\right\} \partial_{j} f-\left\{\phi^{i j} *\left[\mu^{1 / 2} \partial_{j} g\right]\right\} \partial_{i} f  \tag{14}\\
&=: \nabla_{v} \cdot\left(\sigma_{G} \nabla_{v} f\right)+a_{g} \cdot \nabla_{v} f \\
& \bar{K}_{g} f:= K f+\partial_{i} \sigma^{i} f-\sigma^{i j} v_{i} v_{j} f \\
&-\partial_{i}\left\{\phi^{i j} *\left[\mu^{1 / 2} \partial_{j} g\right]\right\} f+\left\{\phi^{i j} *\left[v_{i} \mu^{1 / 2} \partial_{j} g\right]\right\} f \tag{15}
\end{align*}
$$

where $G=\mu+\sqrt{\mu} g$,

$$
\begin{equation*}
K f:=-\mu^{-1 / 2} \partial_{i}\left\{\mu\left[\phi^{i j} *\left\{\mu^{1 / 2}\left[\partial_{j} f+v_{j} f\right]\right\}\right]\right\} \tag{16}
\end{equation*}
$$

and $\sigma^{i j}=\sigma_{\mu}^{i j}, \quad \sigma^{i}=\sigma^{i j} v_{j}$, with

\sigma_{u}^{i j}(v) \stackrel{\text { def }}{=} \phi^{i j} * u=\int_{\mathbb{R}^{3}} \phi^{i j}\left(v-v^{\prime}\right) u\left(v^{\prime}\right) d v^{\prime}
$$

Note that the eigenvalues $\lambda(v)$ of $\sigma(v)$ satisfy [2, Lemma 3]

(1+|v|)^{-3} \lesssim \lambda(v) \lesssim(1+|v|)^{-1} \tag{17}
\end{equation*}
$$

For any fixed $l<0$, we multiply (1) for $f=f_{n}$ and $g=g_{n}$ by $(1+|v|)^{2 l} f_{n}$ and integrate both sides of the resulting equation and obtain

& \iint_{\Omega \times \mathbb{R}^{3}} \frac{1}{2}\left((1+|v|)^{2 l} f_{n}^{2}(t, x, v)-(1+|v|)^{2 l} f_{n}^{2}\left(t_{0}, x, v\right)\right) d x d v \\
& +\int_{t_{0}}^{t} \iint_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{2 l}\left(L f_{n}\right) f_{n} d x d v d s=\int_{t_{0}}^{t} \iint_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{2 l} \Gamma\left(g, f_{n}\right) f_{n} d x d v d s \\
& \leq \int_{t_{0}}^{t}\left\|g_{n}\right\|_{\infty}\left\|f_{n}\right\|_{\sigma, l}^{2} d s
\end{aligned}
$$

by Theorem 2.8 of [6]. Also, since $l<0$, we deduce by Lemma 6 of [2] that

\int_{t_{0}}^{t} \iint_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{2 l}\left(L f_{n}\right) f_{n} d x d v d s \geq \int_{t_{0}}^{t} d s\left(\frac{1}{2}\left\|f_{n}(s)\right\|_{\sigma, l}^{2}-C_{l}\left\|(1+|v|)^{l} f_{n}(s)\right\|_{L^{2}}^{2}\right)
$$

Thus, we have

\begin{aligned}
\frac{1}{2}\left\|(1+|v|)^{l} f_{n}(t)\right\|_{L^{2}}^{2}+\int_{t_{0}}^{t} d s & \frac{1}{4}\left\|f_{n}(s)\right\|_{\sigma, l}^{2} \\
& \leq\left\|(1+|v|)^{l} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2}+C \int_{t_{0}}^{t} d s\left\|(1+|v|)^{l} f_{n}(s)\right\|_{L^{2}}^{2}
\end{aligned}
$$

Thus, by (11) and the Grönwall inequality, we obtain that

\left\|(1+|v|)^{l} f_{n}(t)\right\|_{L^{2}}^{2}+\int_{t_{0}}^{t}\left\|f_{n}(s)\right\|_{\sigma, l}^{2} d s \leq C e^{t-t_{0}}\left\|(1+|v|)^{l} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2} \tag{18}
\end{equation*}
$$

On the other hand, we note that

$$
\|f\|_{\sigma} \geq C\left\|(1+|v|)^{-1 / 2} f\right\|_{L^{2}}
$$

by (17). Thus we have

& \frac{d}{d t} \int_{t_{0}}^{t}\left\|f_{n}(s)\right\|_{\sigma}^{2} d s=\left\|f_{n}(t)\right\|_{\sigma}^{2} \geq C\left\|(1+|v|)^{-1 / 2} f_{n}(t)\right\|_{L^{2}}^{2} \\
& \geq C\left\|(1+|v|)^{-1 / 2} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2} \\
& \quad-2 C \int_{t_{0}}^{t} \iint_{\Omega \times \mathbb{R}^{3}}(1+|v|)^{-1}\left(L f_{n}\right) f_{n} d x d v d s-2 C \int_{t_{0}}^{t}\left\|g_{n}\right\|_{\infty}\left\|f_{n}\right\|_{\sigma,-1 / 2}^{2} d s \\
& \quad \geq C\left\|(1+|v|)^{-1 / 2} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2}-2 C \int_{t_{0}}^{t}\left(\frac{3}{2}\|f(s)\|_{\sigma,-1 / 2}^{2}-C\|f(s)\|_{\sigma}^{2}\right) d s \\
& -2 C \int_{t_{0}}^{t}\left\|g_{n}\right\|_{\infty}\left\|f_{n}\right\|_{\sigma,-1 / 2}^{2} d s \geq C\left\|(1+|v|)^{-1 / 2} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2}-C^{\prime} \int_{t_{0}}^{t}\|f(s)\|_{\sigma}^{2} d s
\end{aligned}
$$

for some $C^{\prime}>0$ by Lemma 2.7 of [6]. By (11) and the Grönwall inequality, we obtain that

\begin{equation*}
\int_{t_{0}}^{t}\left\|f_{n}(s)\right\|_{\sigma}^{2} d s \geq C\left(1-e^{-C^{\prime}\left(t-t_{0}\right)}\right)\left\|(1+|v|)^{-1 / 2} f_{n}\left(t_{0}\right)\right\|_{L^{2}}^{2} \tag{19}
\end{equation*}
$$

Now we define the normalized term $Z_{n}$ of $f_{n}$ as

Z_{n} \stackrel{\text { def }}{=} \frac{f_{n}}{\sqrt{\int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d s}}
$$

For $s \in[0,1]$, we have

\left\|(1+|v|)^{-1 / 2} Z_{n}(s)\right\|_{L^{2}}^{2}=\frac{\left\|(1+|v|)^{-1 / 2} f_{n}(s)\right\|_{L^{2}}^{2}}{\sqrt{\int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d \tau}} \leq \frac{C e^{s}\left\|(1+|v|)^{-1 / 2} f_{n}(0)\right\|_{L^{2}}^{2}}{\int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d \tau}
$$

by (18) for $l=-1 / 2$. On the other hand, by the assumption (12) we have

(n+1) \int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d \tau \geq n \int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d \tau+n \int_{0}^{1}\left\|(1-P) f_{n}\right\|_{\sigma}^{2} d \tau \geq n \int_{0}^{1}\left\|f_{n}\right\|_{\sigma}^{2} d \tau
$$

Thus,

$$
\begin{aligned}
\|(1+|v|)^{-1 / 2} & Z_{n}(s) \|_{L^{2}}^{2}=\frac{\left\|(1+|v|)^{-1 / 2} f_{n}(s)\right\|_{L^{2}}^{2}}{\sqrt{\int_{0}^{1}\left\|P f_{n}\right\|_{\sigma}^{2} d \tau}} \\
& \leq \frac{n+1}{n} \frac{C e^{s}\left\|(1+|v|)^{-1 / 2} f_{n}(0)\right\|_{L^{2}}^{2}}{\int_{0}^{1}\left\|f_{n}\right\|_{\sigma}^{2} d \tau} \leq 2 \frac{C\left\|(1+|v|)^{-1 / 2} f_{n}(0)\right\|_{L^{2}}^{2}}{\int_{0}^{1}\left\|f_{n}\right\|_{\sigma}^{2} d \tau},
\end{aligned}
$$

for any $n \geq 1$. Now, by (19), we have

$$
\int_{0}^{s}\left\|f_{n}(\tau)\right\|_{\sigma}^{2} d \tau \geq C\left(1-e^{-C s}\right)\left\|(1+|v|)^{-1 / 2} f_{n}(0)\right\|_{L^{2}}^{2}
$$

Thus, we obtain the uniform bound

$$
\sup _{0 \leq s \leq 1}\left\|(1+|v|)^{-1 / 2} Z_{n}(s)\right\|_{L^{2}}^{2} \leq C
$$

for some $C>0$. Also, by the normalization we already had $\int_{0}^{1}\left\|Z_{n}(s)\right\|_{\sigma}^{2} d s=1$. Note that this will also imply that there is no concentration in time. Therefore, there exists the weak limit $Z$ of $Z_{n}$ in $\int_{0}^{1}\|\cdot\|_{\sigma}^{2} d s$. Also, by (12), we have

\begin{equation*}
\int_{0}^{1}\left\|(I-P) Z_{n}\right\|_{\sigma}^{2} d s \leq \frac{1}{n} \rightarrow 0 \tag{20}
\end{equation*}
$$

By the triangle inequality, we also have that $\int_{0}^{1}\left\|P Z_{n}(s)\right\|_{\sigma}^{2} d s$ is uniformly bounded from above. In addition, the norm $\|\cdot\|_{\sigma}$ is an anisotropic Sobolev norm with respect to direction of the velocity $v$ by definition. Since the eigenvalues $\lambda(v)$ of the matrix $\sigma(v)$ satisfies the bound (17), the normed vector space with the norm $\|\cdot\|_{\sigma}$ can be understood as a weighted $L^{2}$ Sobolev space and is reflexive. Then by Alaoglu's theorem and Eberleinmulian's theorem, $P Z_{n}$ converges weakly to $P Z$ in $\int_{0}^{1}\|\cdot\|_{\sigma}^{2} d s$ up to a subsequence. Thus, we conclude that $(I-P) Z=0$ and $Z=P Z$. Thus, we can write $Z(t, x, v)$ as

Z(t, x, v)=\left(a(t, x)+b(t, x) \cdot v+c(t, x)|v|^{2}\right) \sqrt{\mu} .
$$

Also, by taking the limit $n \rightarrow \infty$, we note that the limit $Z$ satisfies

$$
\begin{equation*}
\partial_{t} Z+v \cdot \nabla_{x} Z=\Gamma\left(g_{\infty}, Z\right)=0 \tag{21}
\end{equation*}
$$

in the sense of distribution as the condition (11) makes $g_{\infty}=0$ a.e. outside a null set that results in the vanishing integral $\int \Gamma\left(g_{\infty}, Z\right) \phi$ via an integration by parts and we also have $\int L Z \phi$ vanishes as $Z=P Z$, for a test function $\phi \in C_{c}^{1}$.

Now our main strategy is to show that $Z$ has to be zero by (20), the specular reflection boundary conditions, (21), and the conservation laws (5) and (6). On the other hand, we will show the strong convergence of $Z_{n}$ to $Z$ in $\int_{0}^{1}\|\cdot\|_{\sigma}^{2} d s$ by proving the compactness. This will lead us to a contradiction.

We first introduce the following lemma which provides more information on the form of $Z$ :

Lemma 2 (Lemma 6 of [4]). There exist constants $a_{0}, c_{1}, c_{2}$, and constant vectors $b_{0}, b_{1}$ and $\bar{w}$ such that $Z(t, x, v)$ takes the form:

\left(\left(\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right)+\left(-c_{0} t x-c_{1} x+\bar{w} \times\right.\right. & \left.x+b_{0} t+b_{1}\right) \times v \\
& \left.+\left(\frac{c_{0} t^{2}}{2}+c_{1} t+c_{2}\right)|v|^{2}\right) \sqrt{\mu}
\end{aligned}
$$

Moreover, these constants are finite.
Our case also shares the same transport equation (21) for $Z$ that deduces the same macroscopic equations as (72)-(76) of [4] with $Z=P Z$ and the lemma holds. Moreover, a better bound (18) provides that the coefficients are finite.
2.1. Plan for the proof of the strong convergence. We first show the strong convergence of $Z_{n}$ to $Z$ in $\int_{0}^{1}\|\cdot\|_{\sigma}^{2} d s$. First of all, we note that we have seen already that there is no concentration in time-boundary at $s=0$ or $s=1$ by (18). Then regarding the remainder of the domain $(\varepsilon, 1-\varepsilon) \times \Omega \times \mathbb{R}^{3}$ for some $\varepsilon>0$, we split it into three parts; we define the interior $D_{i n t}^{\varepsilon}$, the non-grazing set $D_{n g}^{\varepsilon}$, and the singular grazing set $D_{s g}^{\varepsilon}$ so that

$$
(\varepsilon, 1-\varepsilon) \times \Omega \times \mathbb{R}^{3}=D_{i n t}^{\varepsilon} \cup D_{l v}^{\varepsilon} \cup D_{n g}^{\varepsilon} \cup D_{s g}^{\varepsilon} .
$$

More precisely, we define the interior $D_{i n t}^{\varepsilon}$ as

We define another smooth cutoff function $\tilde{\chi}_{1}$ such that $\tilde{\chi}_{1}=1$ on $D_{\text {int }}^{\varepsilon}$ and $\tilde{\chi}_{1}=0$ outside $D_{i n t}^{\varepsilon / 2}$. Then $\tilde{\chi}_{1}$ has a larger support than $\chi_{1}$ and $\tilde{\chi}_{1}=1$ on $D_{i n t}^{\varepsilon}$. The reason that we additionally define $\tilde{\chi}_{1}$ with a larger support than $\chi_{1}$ is in order to make $\left(1-\chi_{1}\right) Z_{n}=Z_{n}$ outside $D_{i n t}^{\varepsilon}$ and to make $\tilde{\chi}_{1} Z_{n}=Z_{n}$ on $D_{i n t}^{\varepsilon}$.

We first observe that $\tilde{\chi}_{1} Z_{n}$ satisfies the following equation

We also observe that the $L^{2}$ norms of the first and the third terms are bounded as follows. By Lemma 1 of [2], $\tilde{\chi}_{1} L Z_{n}$ can be written as

In this subsection, we will prove that there is no concentration at the boundary, so that we can conclude that $Z_{n}$ converges strongly to $Z$ in $[0,1] \times \bar{\Omega} \times \mathbb{R}^{3}$. The main strategy in this section is to show that the non-grazing set part $\chi_{ \pm} Z_{n}$ can be controlled by the inner boundary part $\left.Z_{n}\right|_{\gamma_{\varepsilon}}$, which will be further controlled by the interior compactness. Here the inner boundary is defined as $\gamma^{\varepsilon} \stackrel{\text { def }}{=}\{x: \zeta(x)=$ $\left.-\varepsilon^{4}\right\} \times \mathbb{R}^{3}$. Now we fix $(s, x, v) \in D_{n g}^{\varepsilon}$. Then we define backward/forward in time characteristic trajectories $\chi_{ \pm}$as

(2) For $s \leq t \leq s+\varepsilon^{2} \leq 1$, if $\chi_{-}(t, x, v) \neq 0$, then $n_{x} \cdot v<-\frac{\varepsilon}{2}<0$. Moreover, $\chi_{-}\left(s+\varepsilon^{2}, x, v\right)=0$, for $\zeta(x) \geq-\varepsilon^{4}$.

We now observe that $\chi_{ \pm} Z_{n}$ satisfies the following equation

\lim _{n \rightarrow \infty} \int_{s-\varepsilon^{2}}^{s}\left\|(1+|v|)^{-1 / 2}\left(Z_{n}-Z\right)\right\|_{L^{2}\left(S_{\varepsilon}\right)}^{2} d t=0
$$

Then, by (31), we have for a small $\eta \sim \sqrt{\varepsilon}$ such that $C_{\eta} \lesssim \varepsilon^{-3 / 2}$ and for a sufficiently large $n>0$,

$$
\begin{aligned}
& \left\|Z_{n}(s)\right\|_{L^{2}\left(S_{\varepsilon, 2}^{c}\right)}^{2} \lesssim\left(C_{\eta}+\varepsilon^{-3 / 2}\right) \int_{s-\varepsilon^{2}}^{s+\varepsilon^{2}}\left\|(1+|v|)^{-1 / 2} Z\right\|_{L^{2}\left(S_{\varepsilon}\right)}^{2} d t \\
& +\left(C_{\eta}+\varepsilon^{-3 / 2}\right) \int_{s-\varepsilon^{2}}^{s+\varepsilon^{2}}\left\|(1+|v|)^{-1 / 2}\left(Z_{n}-Z\right)\right\|_{L^{2}\left(S_{\varepsilon}\right)}^{2} d t+\eta \int_{s-\varepsilon^{2}}^{s+\varepsilon^{2}} d t\left\|Z_{n}\right\|_{\sigma}^{2}+\frac{C}{n} \\
& \lesssim 2\left(C_{\eta}+\varepsilon^{-3 / 2}\right) \varepsilon^{2} \sup _{t \in[0,1]}\left\|(1+|v|)^{-1 / 2} Z(t)\right\|_{L^{2}\left(S_{\varepsilon}\right)}^{2} \\
& \quad+\left(C_{\eta}+\varepsilon^{-3 / 2}\right) \varepsilon^{2}+\eta \int_{s-\varepsilon^{2}}^{s+\varepsilon^{2}} d t\left\|Z_{n}\right\|_{\sigma}^{2}+\frac{C}{n} \lesssim C^{\prime} \sqrt{\varepsilon}
\end{aligned}
$$

by (18) where $C^{\prime}>0$ depends on $a_{0}, c_{0}, c_{1}, c_{2}, b_{0}, b_{1}$, and $\bar{w}$ of Lemma 2. Therefore, for any small $\varepsilon>0$, we have

$$
\begin{equation*}
\left\|Z_{n}(s)\right\|_{L^{2}\left(S_{\varepsilon, 2}^{c}\right)}^{2} \lesssim C^{\prime} \sqrt{\varepsilon} \tag{38}
\end{equation*}
$$

for large $n$.
2.5. Strong convergence and the non-zero $P Z$. By (23), (24), (25), (18), (26), and (38), we obtain

$$
\int_{0}^{1} d s \int_{\Omega} d x\left|\left\langle Z_{n}, e_{j}\right\rangle-\left\langle Z, e_{j}\right\rangle\right|^{2} \rightarrow 0
$$

where $e_{j}$ are an orthonormal basis for $\operatorname{span}\left\{\sqrt{\mu}, v \sqrt{\mu},|v|^{2} \sqrt{\mu}\right\}$. Since $e_{j}(v)$ is smooth and the $0^{\text {th }}$ and the $1^{\text {st }}$ derivatives are exponentially decaying for large $|v|$, we obtain that

$$
\sum_{1 \leq j \leq 5} \int_{0}^{1} d s\left\|\left\langle Z_{n}, e_{j}\right\rangle e_{j}-\left\langle Z, e_{j}\right\rangle e_{j}\right\|_{\sigma}^{2} \rightarrow 0
$$

Finally, note that

$$
Z_{n}=\sum_{1 \leq j \leq 5}\left\langle Z_{n}, e_{j}\right\rangle e_{j}+(I-P) Z_{n}
$$

and we have (20). Therefore, we obtain the strong convergence of $Z_{n}$ to $Z$ in $\int_{0}^{1} d s\|\cdot\|_{\sigma}^{2}$, and we have

$$
\int_{0}^{1} d s\|P Z\|_{\sigma}^{2}=1
$$

Also, recall that the specular reflection condition for $Z_{n}$ is $Z_{n}(t, x, v)=Z_{n}\left(t, x, R_{x}(v)\right)$. By taking $n \rightarrow \infty$, we can observe that $Z$ satisfies the same condition for $\left|v \cdot n_{x}\right| \geq$ $\varepsilon / 2$. By continuity of $Z$, we obtain $Z(t, x, v)=Z\left(t, x, R_{x}(v)\right)$.
2.6. $Z$ is indeed zero. On the other hand, we show below that $P Z$ is indeed zero, which will lead us to a contradiction. The proof will be done via the use of the specular boundary conditions, (21), and the conservation laws (5) and (6). Recall that, by the conservation laws (5), we first obtain

$$
\int Z \sqrt{\mu}=\int Z|v|^{2} \sqrt{\mu}=0
$$

On the other hand, Lemma 2 implies that, for any $s \in[0,1]$, we obtain the conservation laws in the form of

$$
\begin{equation*}
\int\left(\left(\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right)+\left(\frac{c_{0} t^{2}}{2}+c_{1} s+c_{2}\right)|v|^{2}\right) \sqrt{\mu}=0 \tag{39}
\end{equation*}
$$

and

$$
\begin{equation*}
\int\left(\left(\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right)|v|^{2}+\left(\frac{c_{0} t^{2}}{2}+c_{1} s+c_{2}\right)|v|^{4}\right) \sqrt{\mu}=0 \tag{40}
\end{equation*}
$$

This implies $c_{0}=c_{1}=0$. Also, by the specular reflection condition that $Z(s, x, v)=$ $Z\left(s, x, R_{x}(v)\right)$, we have for any $x \in \partial \Omega$ that

$$
b \cdot n_{x}=0 \text { or }\left(\bar{w} \times x+b_{0} s+b_{1}\right) \cdot n_{x}=0
$$

First of all, the coefficient $b_{0}$ of the time-variable $s$ is zero, which gives

$$
\begin{equation*}
b \cdot n_{x}=0 \text { or }\left(\bar{w} \times x+b_{1}\right) \cdot n_{x}=0 \tag{41}
\end{equation*}
$$

If $\bar{w}=0$, then $b_{1} \cdot n_{x}=0$ on $\partial \Omega$. Then we can choose a point $x^{\prime} \in \partial \Omega$ such that $b_{1} \| n_{x^{\prime}}$ via taking the minimizer of $\min _{\zeta(x)} b_{1} \cdot x$. Then this gives $b_{1} \cdot n_{x^{\prime}}=0$ and $b_{1}=0$. If $\bar{w} \neq 0$, then we decompose $b_{1}$ as

$$
b_{1}=\beta_{1} \frac{\bar{w}}{|\bar{w}|}+\beta_{2} \eta
$$

where $|\eta|=1$ and $\eta \perp \bar{w}$. Then

$$
\eta=\left(\frac{\bar{w}}{|\bar{w}|} \times \eta\right) \times \frac{\bar{w}}{|\bar{w}|}
$$

Therefore, we get

$$
b_{1}=\beta_{1} \frac{\bar{w}}{|\bar{w}|}+\beta_{2}\left(\frac{\bar{w}}{|\bar{w}|} \times \eta\right) \times \frac{\bar{w}}{|\bar{w}|}=\beta_{1} \frac{\bar{w}}{|\bar{w}|}-x_{0} \times \bar{w}
$$

where $x_{0}=-\beta_{2}\left(\frac{\bar{w}}{|\bar{w}|} \times \eta\right) \frac{1}{|\bar{w}|}$. Therefore, by (41) we have

$$
\beta_{1} \frac{\bar{w}}{|\bar{w}|} n_{x}+\left(\left(x-x_{0}\right) \times \bar{w}\right) \cdot n_{x}=0
$$

Now note that we can choose a point $x^{\prime} \in \partial \Omega$ such that $\bar{w} \| n_{x^{\prime}}$. Then we deduce $\bar{w} \times\left(n_{x^{\prime}} \times\left(x^{\prime}-x_{0}\right)=0\right.$ and obtain $\beta_{1}=0$. Therefore, we obtain

$$
Z=\bar{w} \times\left(x-x_{0}\right) \cdot v \sqrt{\mu}
$$

and $\bar{w} \times\left(x-x_{0}\right) \cdot n_{x}=0$. If $\Omega$ is not rotationally symmetric, then no nonzero $\bar{w}$ and $x_{0}$ exist, which provides $Z=0$ from the former case that $\bar{w}=0$. If $\Omega$ is indeed rotationally symmetric and there are nonzero $\bar{w}$ and $x_{0}$ such that

$$
Z=\bar{w} \times\left(x-x_{0}\right) \cdot v \sqrt{\mu} \text { and } \bar{w} \times\left(x-x_{0}\right) \cdot n_{x}=0
$$

Now we use the conservation of total angular momentum (6) that

$$
\int_{\Omega \times \mathbb{R}^{3}}\left(\left(x-x_{0}\right) \times \bar{w}\right) \cdot Z v \sqrt{\mu} d x d v=0
$$

which is equivalent to say

$$
\int_{\Omega \times \mathbb{R}^{3}}\left(\bar{w} \times\left(x-x_{0}\right) \cdot v\right)^{2} \mu d x d v=0 .
$$

Therefore, $\bar{w} \times\left(x-x_{0}\right) \cdot v=0$. Thus we conclude that $Z=0$ and this leads to a contradiction.

This finishes the proof for the positivity on a fixed time interval $[0,1]$. In the next section, we prove the main $L^{2}$ decay theorem in the interval $[0, t]$.

## 3. Proof of Theorem 1

We are now ready to prove our main theorem on the $L^{2}$ decay estimates for the solutions $f$ to (11).

Proof of Theorem 1, Define

$$
\begin{equation*}
T=\sup _{t}\left(t: \sup _{0 \leq s \leq t} \mathcal{E}_{\vartheta}(f(s)) \leq 1\right)>0 \tag{42}
\end{equation*}
$$

for some $\vartheta \geq 0$. For $0 \leq t \leq T$, let $0 \leq N \leq t \leq N+1$, for some non-negative integer $N$. We split $[0, t]=\left(\cup_{j=0}^{N-1}[j, j+1]\right) \cup[N, t]$. On each interval $[j, j+1]$ for $j=0,1, \ldots, N-1$, we define $f^{j}(s, x, v) \stackrel{\text { def }}{=} f(s+j, x, v)$. Then clearly $f^{j}(s, x, v)$ is a weak solution of (1)-(6) on the time interval $s \in[0,1]$ with the new initial condition $f^{j}(0, x, v)=f(j, x, v)$. Note that since we only consider $t \in[0, T]$ for $T$ from (42), $\mathcal{E}_{\vartheta}\left(f^{j}(0)\right)$ is uniformly bounded from above. We take the $L^{2}$ energy estimate over $0 \leq s \leq N$ to obtain

$$
\|f(N)\|_{2}^{2}+\int_{0}^{N} d s(L f, f)=\|f(0)\|_{2}^{2}+\int_{0}^{N} d s(\Gamma(g, f), f)
$$

by the specular reflection boundary condition. Equivalently, we have

$$
\|f(N)\|_{2}^{2}+\sum_{j=0}^{N-1} \int_{0}^{1} d s\left(L f^{j}, f^{j}\right)=\|f(0)\|_{2}^{2}+\int_{0}^{N} d s(\Gamma(g, f), f)
$$

Then we use Proposition 1 and obtain

$$
\|f(N)\|_{2}^{2}+\sum_{j=0}^{N-1} \delta_{\epsilon, j} \int_{0}^{1} d s\left\|f^{j}\right\|_{\sigma}^{2} \leq\|f(0)\|_{2}^{2}+\int_{0}^{N} d s(\Gamma(g, f), f)
$$

Thus,

$$
\begin{equation*}
\|f(N)\|_{2}^{2}+\min _{\{j=0, \ldots, N-1\}} \delta_{\epsilon, j} \int_{0}^{N} d s\|f\|_{\sigma}^{2} \leq\|f(0)\|_{2}^{2}+\int_{0}^{N} d s(\Gamma(g, f), f) \tag{43}
\end{equation*}
$$

By Theorem 2.8 of [6], we obtain the energy inequality over $[0, N]$

$$
\begin{equation*}
\|f(N)\|_{2}^{2}+\min _{\{j=0, \ldots, N-1\}} \delta_{\epsilon, j} \int_{0}^{N} d s\|f(s)\|_{\sigma}^{2} \leq\|f(0)\|_{2}^{2}+C_{0} \int_{0}^{N} d s\|g(s)\|_{\infty}\|f(s)\|_{\sigma}^{2} \tag{44}
\end{equation*}
$$

This completes the derivation of the energy inequality for the base case $\vartheta=0$ in the interval $[0, N]$. For $\vartheta \geq 0$, we multiply $(1+|v|)^{2 \vartheta}(v) f(t, x, v)$ and take the $L^{2}$ energy estimate over $0 \leq s \leq N$ to obtain
$\|f(N)\|_{2, \vartheta}^{2}+\int_{0}^{N} d s\left((1+|v|)^{2 \vartheta} L f, f\right)=\|f(0)\|_{2, \vartheta}^{2}+\int_{0}^{N} d s\left((1+|v|)^{2 \vartheta} \Gamma(g, f), f\right)$,
by the specular reflection boundary condition. By Lemma 2.7 and Theorem 2.8 of [6], we have for some $C_{\vartheta}>0$

$$
\begin{align*}
&\|f(N)\|_{2, \vartheta}^{2}+\int_{0}^{N} d s\left(\frac{1}{2}\|f(s)\|_{\sigma, \vartheta}^{2}-C_{\vartheta}\|f(s)\|_{\sigma}^{2}\right)  \tag{45}\\
& \leq\|f(0)\|_{2, \vartheta}^{2}+C_{\vartheta} \int_{0}^{N} d s\|g(s)\|_{\infty}\|f(s)\|_{\sigma, \vartheta}^{2}
\end{align*}
$$

This completes the derivation of the energy inequality for $\vartheta \geq 0$ in the interval $[0, N]$. Therefore, by the ingredients (44) for the base case $\vartheta=0$ and (45) for a general $\vartheta \geq 0$, we obtain (4.36) of [6] by the same proof via the induction on $\vartheta$ for $\eta \equiv 0, s=0$ and $t=N$. Then by the same proof of Theorem 1.2 of [6], we obtain (8) and (9) in the time interval $s \in[0, N]$; for any $\vartheta \in 2^{-1} \mathbb{N} \cup\{0\}$ and $k \in \mathbb{N}$, there exist $C$ and $\epsilon=\epsilon(\vartheta)>0$ such that

$$
\sup _{0 \leq s \leq N} \mathcal{E}_{\vartheta}(f(s)) \leq C 2^{2 \vartheta} \mathcal{E}_{\vartheta}\left(f_{0}\right)
$$

and

$$
\|f(N)\|_{2, \vartheta} \leq C_{\vartheta, k}\left(\mathcal{E}_{\vartheta+\frac{k}{2}}(0)\right)^{1 / 2}\left(1+\frac{N}{k}\right)^{-k / 2}
$$

Now we consider the local interval $[N, t]$ where we have $0 \leq t-N \leq 1$ and $t \leq T$. We recall that if $\|g\|_{L_{m}^{\infty}} \leq \epsilon$ for a sufficiently small $\epsilon$, we have

$$
\begin{equation*}
\left\|(1+|v|)^{\vartheta} f(t)\right\|_{L^{2}}^{2}+\int_{N}^{t}\|f(s)\|_{\sigma, \vartheta}^{2} d s \leq C e^{t-N}\left\|(1+|v|)^{\vartheta} f(N)\right\|_{L^{2}}^{2} \tag{46}
\end{equation*}
$$

by (18) for $l=\vartheta$ on $[N, t]$. Note that (46) holds for a solution to (11) under (10) and (4)-(6) by the local $L^{2}$ energy inequality and the Grönwall inequality as in (18) and we do not need the additional assumption (12) for (18). Then we observe that

$$
\mathcal{E}_{\vartheta}(f(t)) \leq C e^{t-N} \mathcal{E}_{\vartheta}(f(N)) \leq C^{\prime} e^{t-N} 2^{2 \vartheta} \mathcal{E}_{\vartheta}\left(f_{0}\right) \leq C^{\prime} e 2^{2 \vartheta} \mathcal{E}_{\vartheta}\left(f_{0}\right)
$$

for some $C^{\prime}>0$ and

$$
\begin{aligned}
&\|f(t)\|_{2, \vartheta} \leq C e^{t-N}\|f(N)\|_{2, \vartheta} \leq C e^{t-N} C_{\vartheta, k}\left(\mathcal{E}_{\vartheta+\frac{k}{2}}(0)\right)^{1 / 2}\left(1+\frac{N}{k}\right)^{-k / 2} \\
& \leq C e C_{\vartheta, k}\left(\mathcal{E}_{\vartheta+\frac{k}{2}}(0)\right)^{1 / 2} 2^{k / 2}\left(1+\frac{t}{k}\right)^{-k / 2}
\end{aligned}
$$

since

$$
\left(1+\frac{N}{k}\right)^{-k / 2} \leq 2^{k / 2}\left(1+\frac{t}{k}\right)^{-k / 2}
$$

for $N \leq t \leq N+1$ and $k \geq 1$. Therefore, we obtain (8) and (9) for the time interval $[0, t]$ for any $0 \leq t \leq T$ where $T$ is defined as (42).

We finally choose initially

$$
\mathcal{E}_{\vartheta}\left(f_{0}\right) \leq \epsilon_{0} \leq \frac{1}{2 C 2^{2 \vartheta}}
$$

and we define

$$
T_{2}=\sup _{t}\left(t: \sup _{0 \leq s \leq t} \mathcal{E}_{\vartheta}(f(s)) \leq \frac{1}{2}\right)>0
$$

Since $0 \leq t \leq T_{2} \leq T$, we have from (8) that

$$
\sup _{0 \leq s \leq T} \mathcal{E}_{\vartheta}(f(s)) \leq C 2^{2 \vartheta} \mathcal{E}_{\vartheta}\left(f_{0}\right) \leq \frac{1}{2}
$$

Thus, we deduce that $T_{2}=\infty$ from the continuity of $\mathcal{E}_{\vartheta}$, and the theorem follows.
