# TOWERS OF BUBBLES FOR YAMABE-TYPE EQUATIONS AND FOR THE BRÉZIS-NIRENBERG PROBLEM IN DIMENSIONS $n \geq 7$

#### Abstract

Let $(M, g)$ be a closed locally conformally flat Riemannian manifold of dimension $n \geq 7$ and of positive Yamabe type. If $\xi_{0}$ denotes a non-degenerate critical point of the mass function we prove the existence, for any $k \geq 1$ and $\varepsilon>0$, of a positive blowing-up solution $u_{\varepsilon}$ of $$
\triangle_{g} u_{\varepsilon}+\left(c_{n} S_{g}+\varepsilon h\right) u_{\varepsilon}=u_{\varepsilon}^{2^{*}-1}
$$


that blows up like the superposition of $k$ positive bubbles concentrating at different speeds at $\xi_{0}$. The method of proof combines a finite-dimensional reduction with the sharp pointwise analysis of solutions of a linear problem. As another application of this method of proof we construct sign-changing blowing-up solutions $u_{\varepsilon}$ for the Brézis-Nirenberg problem

\triangle_{\xi} u_{\varepsilon}-\varepsilon u_{\varepsilon}=\left|u_{\varepsilon}\right|^{\frac{4}{n-2}} u_{\varepsilon} \text { in } \Omega, \quad u_{\varepsilon}=0 \text { on } \partial \Omega
$$

on a smooth bounded open set $\Omega \subset \mathbb{R}^{n}, n \geq 7$, that look like the superposition of $k$ positive bubbles of alternating sign.

## 1. Introduction and statement of the results

1.1. Positive towers of bubbles in the Riemannian case. Let ( $M, g$ ) be a closed smooth connected Riemannian manifold, that is compact without boundary, of dimension $n \geq 3$. Assume $(M, g)$ is of positive Yamabe type. The main goal of this work is to construct blowing-up families of positive solutions $\left(u_{\varepsilon}\right)_{\varepsilon}$ of critical nonlinear elliptic equations of the following form:

\triangle_{g} u_{\varepsilon}+h_{\varepsilon} u_{\varepsilon}=u_{\varepsilon}^{2^{*}-1} \tag{1.1}
\end{equation*}
$$

where $\triangle_{g}=-\operatorname{div}_{g}(\nabla \cdot), 2^{*}=\frac{2 n}{n-2}$ and where $h_{\varepsilon}$ converges in $C^{1}(M)$ as $\varepsilon \rightarrow$ 0 . We construct sequences that display towering bubbling phenomena when $h_{\varepsilon} \rightarrow c_{n} S_{g}$, where $c_{n}=\frac{n-2}{4(n-1)}$ and where $S_{g}$ is the scalar curvature of $(M, g)$.

When $h_{\varepsilon} \equiv c_{n} S_{g}$ equation (1.1) is the celebrated Yamabe equation. The existence of a positive solution in this case was proven through the work of Yamabe [42], Aubin [1], Trudinger [41] and Schoen [37]. The question of the compactness of the set of positive solutions of the Yamabe equation on manifolds of positive Yamabe type has generated a vast amount of work in the last decades. On the standard sphere $\left(\mathbb{S}^{n}, g_{0}\right), n \geq 3$, the set of positive
solutions is not compact, but if $(M, g)$ is not conformally diffeomorphic to the standard sphere, the set of positive solutions of the Yamabe equation is compact when the dimension of the manifold satisfies $3 \leq n \leq 24$, as was shown by Khuri, Marques and Schoen [18] (previous results were obtained Li and Zhu [23], Druet [9], Marques [24] and Li and Zhang [21]). In dimensions $n \geq 25$ Brendle [4] and Brendle and Marques [5] constructed examples of manifolds for which the set of positive solutions is not compact. From the PDE point of view, understanding the compactness of solutions to the Yamabe equation (and, more generally, of larger classes of nonlinear critical elliptic equations) relies on establishing sharp blow-up estimates near blow-up points. A crucial step in the proof of the compactness of the Yamabe equation consists in showing that, in dimensions $3 \leq n \leq 24$, all the possible blow-up points of a sequence of positive solutions must be isolated and simple (following the terminology of Schoen [38]) i.e. that around each blow-up point $\xi_{0}$ the solution can be approximated by a so called standard bubble

\end{equation*}

For more general equations like (1.1) one may wonder if compactness properties - or, more generally, stability properties according to the terminology in Hebey [13] - remain true for positive solutions when $h_{\varepsilon}$ in (1.1) is not everywhere equal to $c_{n} S_{g}$. There the picture becomes more complicated. If $n=3$, no positive blowing-up positive solutions exist as long as the mass of the limiting operator is positive as proved by Li-Zhu [23]. If we denote by $h_{\infty}$ the $C^{1}$ limit of $h_{\varepsilon}$ and if $(M, g)$ is not conformally diffeomorphic to the standard sphere, the mass of $\triangle_{g}+h_{\infty}$ remains positive even if $h_{\infty}>c_{3} S_{g}$ everywhere, provided $h_{\infty}$ is not too large. When $n \geq 4$, Druet [9] proved that (1.1) does not have any positive blowing-up solution when $h_{\infty}<c_{n} S_{g}$ everywhere, or when $n=4,5$ and $h_{\varepsilon} \leq c_{n} S_{g}$ for all $\varepsilon$ and the manifold is not conformally equivalent to the round sphere.

If $h_{\varepsilon}>c_{n} S_{g}$ somewhere, the situation is subtler and blow-up is likely to occur when $n \geq 4$. We focus in this paper in the following special case of (1.1):

\triangle_{g} u+\left(c_{n} S_{g}+\varepsilon h\right) u=u^{2^{*}-1} \tag{1.3}
\end{equation*}
$$

where $h \in C^{0}(M)$ and $\varepsilon>0$. If $n \geq 4$, positive single-bubble blowing-up solutions or multi-bubble solutions with isolated concentration points do exist as shown by Esposito, Pistoia and Vetois in [12. Pistoia and Vaira proved in [29], when $h \equiv 1$ and $n \geq 7$, the existence of blowing-up solutions of (1.3) possessing a so-called clustering blow-up point at a non-degenerate non-zero
minimum point of the Weyl's tensor. In these so-called clustering configurations the solutions blow-up as a finite number of peaks, of comparable heights, whose centers converge to the same point. Clustering configurations in dimensions 4 and 5 have also been constructed by Thizy and Vétois 40 and, for families of equations like (1.1), in dimensions $n \geq 6$ by Robert and Vétois [35].

We address here the question of existence of so-called towering bubbling configurations for positive solutions of (1.3). These are finite-energy blowing-up positive solutions that blow-up as a superposition of positive bubbles concentrating at different speed, and whose centers converge to the same point these configurations are also sometimes referred to as towers of bubbles. We prove that towering blow-up points for (1.3) can be constructed in dimension $n \geq 7$ on locally conformally flat manifolds. Our main result is as follows:

Theorem 1.1. Let $(M, g)$ be a closed locally conformally flat Riemannian manifold of dimension $n \geq 7$ of positive Yamabe type. Let $\xi_{0}$ denote a nondegenerate critical point of the mass function $\xi \mapsto m(\xi)$. Let $k \geq 1$. Then there exists a family $\left(u_{\varepsilon}\right)_{\varepsilon}$ of positive solutions of

\triangle_{g} u_{\varepsilon}+\left(c_{n} S_{g}+\varepsilon\right) u_{\varepsilon}=u_{\varepsilon}^{2^{*}-1}
$$

that blows-up with $k$ bubbles at $\xi_{0}$, and for which $\xi_{0}$ is a towering blow-up point.
For the definition of the Riemannian mass we refer to (2.1) below. Morabito, Pistoia and Vaira in [26] first proved the existence of positive towering bubbling configurations on non-locally conformally flat manifolds, at a point $\xi_{0}$ where the Weyl's tensor does not vanish, under the stringent assumption that the manifold is symmetric with respect to $\xi_{0}$. In the present work we treat the locally conformally flat case that was left open, and we perform the construction without any symmetry assumption on $M$ : this considerably increases the complexity of the proof and requires us to develop a new analytical approach. Towering bubble configurations for positive solutions similar to the ones constructed in this paper do not exist in dimensions $n \leq 6$, as can be seen by an adaptation of the arguments in Druet [8] (see also Hebey [13], Chapter 8). In low dimensions $n=4,5$, the closest analogue to a positive towers of bubbles is made of isolated peaks concentrating at different speeds and has been built in Premoselli-Thizy [32]. Theorem 1.1 thus completes the constructive picture of the possible blow-up scenarios for positive solutions of (1.3).

We stated Theorem 1.1 when $h \equiv 1$ for simplicity. If one allows a more general function $h \in C^{1}(M)$ (compare with (1.3)) it is still possible to prove the existence of towering blow-up points. The nondegeneracy assumption on $\xi_{0}$, in particular, can be lifted if one chooses $h$ suitably (see e.g. the end of the proof of Theorem 1.1 at the very end of Section 5 where this topic is dicussed).

### 1.2. Sign-changing towers of bubbles for the Brézis-Nirenberg prob-

 lem. The method we use to prove Theorem 1.1 also applies to the construction of sign-changing solutions to the classical Brézis-Nirenberg problem [6]$$
\begin{cases}\triangle_{\xi} u-\varepsilon u=|u|^{\frac{4}{n-2}} u & \text { in } \Omega  \tag{1.4}\\ u=0 & \text { on } \partial \Omega\end{cases}
$$

where $\xi$ is the Euclidean metric, $\triangle_{\xi}=-\sum_{i=1}^{n} \partial_{i}^{2}, \Omega \subset \mathbb{R}^{n}, n \geq 3$ is an open and bounded smooth domain. It is well known that (1.4) possesses positive blowing-up solutions, when $\epsilon>0$ is small enough and $n \geq 4$, blowingup at distinct isolated points (see Rey [33] and Musso and Pistoia [28]). In the sign-changing case and when $n \geq 7$, Iacopetti and Vaira [16] built signchanging solutions to problem (1.4) whose shape looks like the superposition of bubbles with alternating sign centered at the origin, provided the domain $\Omega$ is symmetric with respect to the origin. This is in sharp contrast with the positive case where positive towers of bubbles, at least on symmetric domains, cannot occur for $\epsilon>0$ small enough as was proven by Cerqueti [7] using ideas of Li [20, 22]. We also mention Iacopetti and Vaira [17] where sign-changing solutions with asymptotically vanishing negative part have been constructed.

The analysis that we develop in this paper to prove Theorem 1.1 adapts to the Euclidean case of the Brézis-Nirenberg problem. Without assuming any symmetry in the domain we are able to prove the existence of sign-changing towering bubbling configurations:

Theorem 1.2. Let $\Omega$ be a smooth bounded subset of $\mathbb{R}^{n}, n \geq 7$, and let $\xi_{0}$ denote a non-degenerate critical point of the Robin function $\xi \mapsto H(\xi, \xi)$. Let $k \geq 1$. There exists a family $\left(u_{\varepsilon}\right)_{\varepsilon}$ of sign-changing solutions of

\begin{equation*}
\triangle_{\xi} u_{\varepsilon}-\varepsilon u_{\varepsilon}=\left|u_{\varepsilon}\right|^{\frac{4}{n-2}} u_{\varepsilon} \tag{1.5}
\end{equation*}
$$

that blows-up as the superposition of $k$ bubbles with alternating sign at $\xi_{0}$.
The existence of radial towers of bubbles centered at the origin on the ball had been previously obtained by Esposito-Ghoussoub-Pistoia-Vaira [11] in the more general context of Hardy-Schrödinger equations. Theorem 1.2 is again a generalisation of this construction to arbitrary non-symmetric domains. For the precise definition of the Robin function we refer to (6.4). As for Theorem 1.1) the assumptions on $\xi_{0}$ can be relaxed if a general $h$ is taken into account in the operator $\triangle_{\xi}-\varepsilon h$, see the arguments at the end of Section 6. The existence of sign-changing towers of bubbles for problem (1.4) is likely to be true only in dimensions $n \geq 7$, and a proof that sign-changing towers of bubbles made of two bubbles cannot appear in dimensions 3 to 6 can be found in Ben AyedEl Medhi-Pacella [2, 3] and Iacopetti and Pacella [15]. Let us also mention
an asymptotic description of low-energy sign-changing solutions in dimensions $n \geq 7$ in Iacopetti [14].
1.3. Strategy of proof and outline of the paper. The proofs of Theorems 1.1 and 1.2 follow the strategy that was introduced in Premoselli 30, 31] and applied in Premoselli-Thizy [32]. The blowing-up family $\left(u_{\varepsilon}\right)_{\varepsilon}$ that we construct in Theorem 1.1 has the following form:

$$
u_{\varepsilon}=\sum_{i=1}^{k} W_{i, \varepsilon}+\varphi_{\varepsilon},
$$

where $W_{i, \varepsilon}$ are, at first-order, Riemannian standard bubbles of respective parameters $\mu_{k, \varepsilon} \ll \mu_{k-1, \varepsilon} \ll \cdots \ll \mu_{1, \varepsilon}$ and centered at points $\xi_{i, \varepsilon}$ and $\varphi_{\varepsilon}$ is a remainder. The points $\xi_{\ell}$ satisfy $d_{g}\left(\xi_{\ell-1}, \xi_{\ell}\right)=O\left(\mu_{\ell-1}\right)$ for $2 \leq \ell \leq k$, they all converge to the same point $\xi_{0} \in M$, and the parameters are related according to (2.8) below. The main idea of the present paper is to construct a remainder $\varphi_{\varepsilon}$ satisfiying

$$
\begin{equation*}
\left\|\frac{\varphi_{\varepsilon}}{\sum_{i=1}^{k} W_{i, \varepsilon}}\right\|_{L^{\infty}(M)}=o(1) \tag{1.6}
\end{equation*}
$$

(more precise estimates are actually required, see (4.5)). This contrasts with the approach followed in Morabito-Pistoia-Vaira [26]: in the highly symmetric setting of [26] all the bubbles were centered in the center of symmetry of the manifold and a suitable $\varphi_{\varepsilon}$ was constructed in $H^{1}$ by splitting it in $k$ distinct remainders with a triangular dependence on the bubble parameters. Since we work here on a general non-symmetric background, where the centers of the bubbles also have to be chosen, the energy estimates of [26] fail to capture precisely enough the interactions between the bubbles $W_{i, \varepsilon}$. We thus have to construct a remainder $\varphi_{\varepsilon}$ which comes with sharp global pointwise estimates such as (1.6).

Constructing $\varphi_{\varepsilon}$ that satisfies (1.6) is the main challenge of this paper. It requires to prove sharp pointwise estimates for solutions of a linear equation (see Proposition 3.2 below). These estimates are obtained by means of a bubble-tree-like analysis, which is carried on at a significant precision. Once this linear theory is available, $\varphi_{\varepsilon}$ is constructed via a standard fixed-point procedure, which now takes place in strong weighted spaces. This construction of $\varphi_{\varepsilon}$ applies both to positive and sign-changing solutions. The sharp pointwise estimates that we obtain on $\varphi_{\varepsilon}$, combined with the finite-dimensional reduction, also provide another way to obtain a priori pointwise blow-up estimates for finite-energy solutions of (1.3), similar to the ones in Druet-Hebey-Robert [10] and to the symmetry estimates of Li-Zhang [21] and Khuri-Marques-Schoen [18] (see Section (4).

The outline of the paper is as follows. In Section 2 we introduce the notations and the bubbling profiles used in the construction. In Section 3 we prove sharp pointwise estimates for solutions of the linearization of (1.3). This is achieved in Proposition 3.2 and is the core of the analysis of the paper. In section 4 we perform the nonlinear construction to solve (1.1) up to kernel elements. In section 5 we perform an asymptotic expansion of the coefficients of the kernel elements and conclude the proof of Theorem 1.1. Theorem 1.2 is then proven in 6. Finally, the Appendix gathers a few technical results used throughout the paper. Although Theorem 1.1 is proven in the locally conformally flat case, we prove the results in sections 3 and 4 in the general case, since the analysis carries on and might be applied in future works. We also take into account a general $h$ as in (1.3) since it does not create additional difficulties.

## 2. Notations and Approximate solutions

2.1. The ansatz. Let $(M, g)$ be a compact Riemannian manifold without boundary of dimension $n \geq 3$. The celebrated conformal normal coordinates result of Lee-Parker [19] states the existence of a smooth function $\Lambda: M \times M \rightarrow$ $(0,+\infty)$ suth that for any $\xi \in M$, the conformal metric $g_{\xi}=\Lambda_{\xi}^{\frac{4}{n-2}} g$ satisfies:

$$
S_{g_{\xi}}(\xi)=0, \quad \nabla S_{g_{\xi}}(\xi)=0 \quad \text { and } \triangle_{g_{\xi}} S_{g_{\xi}}(\xi)=\frac{1}{6}\left|W_{g}(\xi)\right|_{g}^{2}
$$

where we have let $\Lambda_{\xi}=\Lambda(\xi, \cdot)$ and where $S_{h}$ and $W_{h}$ denote respectively the scalar curvature and the Weyl tensor of a metric $h$. If $(M, g)$ is locally conformally flat in a neighbourhood of some $\xi \in M, g_{\xi}$ is flat in a geodesic ball centered at $\xi$. If $h$ is any metric of positive Yamabe type on $M$ we denote by $G_{h}$ the Green function of the conformal laplacian $\triangle_{h}+c_{n} S_{h}$. Let $\xi \in M$ and consider the metric $g_{\xi}=\Lambda_{\xi}^{\frac{4}{n-2}} g$. If $(M, g)$ is locally conformally flat in a neighbourhood of $\xi$ the Green function $G_{g_{\xi}}$ expands as

$$
\begin{equation*}
G_{g_{\xi}}\left(\xi, \exp _{\xi}^{g_{\xi}}(y)\right)=\frac{1}{(n-2) \omega_{n-1}}|y|^{2-n}+m(\xi)+O(|y|) \tag{2.1}
\end{equation*}
$$

for $|y|$ small, where we denoted by $\exp _{\xi}^{g_{\xi}}$ the exponential map at $\xi$ for $g_{\xi}$. The quantity $m(\xi)$, which is a smooth function of $\xi$, is called the mass at $\xi$. If $(M, g)$ is not conformally flat in a neighbourhood of $\xi \in M$ we have instead,
when $n \geq 7$ :

\begin{equation*}
G_{g_{\xi}}\left(\xi, \exp _{\xi}^{g_{\xi}}(y)\right)=\frac{1}{(n-2) \omega_{n-1}}|y|^{2-n}+O\left(|y|^{6-n}\right) \tag{2.2}
\end{equation*}
$$

We refer to Lee-Parker [19] for a proof of these facts.
The bubbling profiles we will use in this work are inspired from the profiles in Esposito-Pistoia-Vétois [12], with a suitable modification to smoothen them. Let $0<r_{0}<\frac{1}{2} i_{g}(M)$ be such that

\begin{equation*}
2 r_{0}<\frac{1}{2} i_{g_{\xi}}(M) \quad \text { for any } \xi \in M \tag{2.3}
\end{equation*}
$$

and let $\chi: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$be a smooth compactly supported function satisfying $\chi(r)=r$ for $r \leq r_{0}$ and $\chi(r)=2 r_{0}$ for $r \geq 2 r_{0}$. If $\xi \in M$ and $\mu>0$, we define the bubble $W_{\mu, \xi}$ as:

\begin{equation*}
W_{\mu, \xi}(x)=\Phi(\xi, x) \frac{\mu^{\frac{n-2}{2}}}{\left(\mu^{2}+\frac{\chi\left(d_{g_{\xi}}(\xi, x)^{2}\right)}{n(n-2)}\right)^{\frac{n-2}{2}}}, \tag{2.4}
\end{equation*}
$$

where $d_{g_{\xi}}$ is the geodesic distance for the metric $g_{\xi}$ and where we have let, for all $\xi, x \in M$ :

$$
\begin{equation*}
\Phi(\xi, x)=(n-2) \omega_{n-1} G_{g_{\xi}}(\xi, x) \Lambda_{\xi}(x) \chi\left(d_{g_{\xi}}(\xi, x)\right)^{n-2} \tag{2.5}
\end{equation*}
$$

This ansatz satisfies in particular:

$$
W_{\mu, \xi}(x)=\Phi(\xi, x) \mu^{\frac{n-2}{2}}\left(\mu^{2}+\frac{d_{g_{\xi}}(\xi, x)^{2}}{n(n-2)}\right)^{1-\frac{n}{2}} \text { if } d_{g_{\xi}}(\xi, x) \leq r_{0} .
$$

As shown in [12], $W_{\mu, \xi}$ satisfies:

$$
\triangle_{g} W_{\mu, \xi}+c_{n} S_{g} W_{\mu, \xi}-W_{\mu, \xi}^{2^{*}-1}= \begin{cases}\frac{O\left(\mu^{\frac{n+2}{2}}\right)}{\left(\mu^{2}+\frac{\left.d_{g_{\xi}(\xi, x)^{2}}^{n(n-2)}\right)^{2}}{n\left(\mu^{2}\right.}\right)} & (M, g) \text { is l.c.f }  \tag{2.6}\\ \frac{O\left(\mu^{\frac{n+2}{2}}\right)}{\left(\mu^{2}+\frac{\left.d_{g_{\xi}(\xi, x)^{2}}^{n(n-2)}\right)^{\frac{n-2}{2}}}{n(n)}\right.} & \text { otherwise }\end{cases}
$$

where "l.c.f" means here locally conformally flat in a a neighbourhood of $\xi$. We will use the same abbreviation throughout the paper, and there should be no confusion since our analysis will take place in a neighbourhood of a point $\xi_{1} \in M$. In (2.6) we also used the following notation:

$$
A=O(B) \text { or, equivalently, } A \lesssim B
$$

if there exists a constant $C>0$ independent of $\varepsilon$ such that $|A| \leq C|B|$. Similarly, we will write $A=o(B)$ if $|A||B|^{-1}$ goes to 0 as $\varepsilon \rightarrow 0$.
2.2. The parameters. We introduce the parameters of our construction. Let $A>1$ be a large positive constant, $k \geq 1$ be an integer. Let $\left(t_{i}\right)_{1 \leq i \leq k} \in$ $\left[A^{-1}, A\right]^{k}$ and $\varepsilon>0$. For any $1 \leq \ell \leq k$ define:

$$
\mu_{\ell}=\mu_{\ell, \varepsilon}\left(t_{\ell}\right)=\varepsilon^{\gamma_{\ell}} t_{\ell},
$$

where

$$
\gamma_{\ell}= \begin{cases}\frac{n-2}{2(n-4)}\left(\frac{n-2}{n-6}\right)^{\ell-1}-\frac{1}{2} & (M, g) \text { is l.c.f }  \tag{2.7}\\ \left(\frac{n-2}{n-6}\right)^{\ell-1}-\frac{1}{2} & \text { otherwise }\end{cases}
$$

With this definition it is easily seen that we have

$$
\varepsilon^{1+2 \gamma_{\ell}}=\varepsilon^{\frac{n-2}{2}\left(\gamma_{\ell}-\gamma_{\ell-1}\right)} .
$$

In particular, for fixed values of $\left(t_{i}\right)_{1 \leq i \leq k} \in\left[A^{-1}, A\right]^{k}$, the $\mu_{\ell}$ satisfy:

$$
\mu_{1} \sim\left\{\begin{array}{ll}
\varepsilon^{\frac{1}{n-4}} & (M, g) \text { l.c.f }  \tag{2.8}\\
\varepsilon^{\frac{1}{2}} & \text { otherwise }
\end{array} \quad \text { and } \quad \varepsilon \mu_{\ell+1}^{2} \sim\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}\right)^{\frac{n-2}{2}}\right.
$$

for any $1 \leq \ell \leq k-1$, where $\sim$ denotes the order of growth in $\varepsilon$ as $\varepsilon \rightarrow 0$.
Denote by $B(0,1)$ the open unit ball in $\mathbb{R}^{n}$ and define

Recall that for $\xi \in M$, $\exp _{\xi}^{g_{\xi}}$ is the exponential map at $\xi$ for the metric $g_{\xi}=\Lambda_{\xi}^{\frac{4}{n-2}}$. In (2.10) we omitted the dependence on the parameters for the sake of clarity but keep in mind that we have:

where $W_{\mu_{\ell}, \xi_{\ell}}$ is as in (2.4). By definition $W_{\ell}$ only depends on the parameters $\left(t_{\ell-1}, t_{\ell}, z_{\ell}\right)$ when $\ell \geq 2$, and only on $\left(t_{1}, \xi_{1}\right)$ when $\ell=1$. In this setting $W_{k}$ denotes the highest bubble (the one that concentrates faster) while $W_{1}$ is the lowest one. In the course of the proof we will need to analyse the mutual pointwise interactions between these bubbles. Following the notion of radius of influence introduced in Druet [8] (see also Hebey [13], Chapter 8) We define for this the following sets:

For any family $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}\right)$ of elements of $S_{k}$ it is easily checked by (2.10) that, for $\varepsilon$ small enough, the balls $B_{\ell}$ are nested:

Z_{\ell, j}(x) & =Z_{\ell, j, \mu \ell, \xi_{\ell}}(x) \\
& =\Lambda_{\xi_{\ell}}(x) \chi\left(d_{g_{\xi_{\ell}}}\left(\xi_{\ell}, x\right)\right) \\
& \times \mu_{\ell}^{\frac{n}{2}}\left\langle\left(\exp _{\xi_{\ell}}^{g_{\xi_{\ell}}}\right)^{-1}(x), e_{j}\left(\xi_{\ell}\right)\right\rangle_{g_{\xi_{\ell}}\left(\xi_{\ell}\right)}\left(\mu_{\ell}^{2}+\frac{d_{g_{\xi_{\ell}}}\left(\xi_{\ell}, x\right)^{2}}{n(n-2)}\right)^{-\frac{n}{2}} .

In the previous expression $\left(e_{j}\right)$ is a local orthonormal basis defined in $B_{g}\left(\xi_{1}, 2 r_{0}\right)$. It is always well-defined and depends smoothly on the choice of the point since we can always choose a covering of parallel-type on $M$, see [36]. Let also

Explicit computations yield, for $1 \leq i<j \leq k$ and $0 \leq p, q \leq n$ :

The proofs of (2.19) and (2.20) can be found in [12] (Lemma 6.3) while we refer to the Appendix of this paper for the proof of (2.21) and (2.22). We finally let, for $1 \leq \ell \leq k$ :

## 3. Sharp pointwise asymptotics for the linear problem

3.1. Statement of the result. Let $k \geq 1$ be an integer and, for any $0<\varepsilon \leq 1$, let $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}\right) \in S_{k}$ be a family of parameters, where $S_{k}$ is as in (2.9). For the sake of clarity we will drop the dependence in $\varepsilon$ and, until the end of the paper, we will always denote by $W_{1}, \ldots, W_{k}$ the bubbles obtained as in (2.11) with $\mu_{i}$ and $\xi_{i}$ given by (2.7) and (2.10) for this choice of the family $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon}\right),\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}$. In what follows the notation $f(u)$ will either denote $f(u)=|u|^{2^{*}-2} u$ or $f(u)=\left(u_{+}\right)^{2^{*}-1}$, where $u_{+}=\max (u, 0)$. We recall, as a starting point, the well-known linear theory in $H^{1}(M)$ for (1.3):
Proposition 3.1. Let $k \geq 1$ be an integer. We fix $\left(\kappa_{i}\right)_{1 \leq i \leq n} \in\{-1,1\}^{k}$. There exists $\varepsilon_{0}>0$ such that the following holds: for any $\varepsilon \in\left(0, \varepsilon_{0}\right)$ and $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}\right) \in S_{k}, h \in C^{0}(M)$ and for any $k_{\varepsilon} \in L^{\frac{2 n}{n+2}}(M)$, there exists a unique $\varphi_{\varepsilon} \in K_{k}^{\perp}$ satisfying:

Here $\Pi_{K_{k}^{\perp}}$ denotes the orthogonal projection on $K_{k}^{\perp}$ for (2.14), and $K_{k}$ is as in (2.23). This function satisfies in addition

Proof. This is a by now very classical result. We refer for instance to RobertVétois [36], Esposito-Pistoia-Vétois [12] or Musso-Pistoia [27] for a proof.

Equation (3.1) implies the existence of real numbers $\lambda_{i j}=\lambda_{i j, \varepsilon}$, with $1 \leq$ $i \leq k$ and $0 \leq j \leq n$, such that

where $Z_{i, j}$ is as in (2.15). By standard elliptic theory, if $k_{\varepsilon} \in C^{0}(M), \varphi_{\varepsilon} \in$ $C^{1}(M)$. Let $h \in C^{0}(M)$ be fixed and assume that $\varepsilon>0$ is small enough so that $\triangle_{g}+c_{n} S_{g}+\varepsilon h$ is coercive. For any fixed $\varepsilon$ and for any $k_{\varepsilon} \in C^{0}(M)$ we denote the unique function $\varphi_{\varepsilon}$ given by Proposition 3.1 by

We investigate in this section equation (3.3) in more detail. Assuming that a suitable pointwise control holds on $k_{\varepsilon}$ we prove refined pointwise estimates on $\varphi_{\varepsilon}$. The pointwise control we will assume on $k_{\varepsilon}$ is the following:

\vdots & \text { in } B_{i} \backslash B_{i+1}, \\
W_{i}^{2^{*}-2}\left(W_{i+1}+W_{i-1}\right) & \text { in } B_{1} \backslash B_{2}=M \backslash B_{2}
\end{array}\right\},\end{cases}
\end{align*}
$$

where in (3.5) the index $i$ in the right-hand side runs from 2 to $k-1$ and where $\theta_{i}$ is defined in (2.18). It is easily seen, using (2.6) and (2.13), that (3.5) is satisfied for the following particular choice of $k_{\varepsilon}$ :

The following proposition is the main result of this section and the core of the analysis of this paper.

Proposition 3.2. Let $k \geq 1$ be an integer, $\left(\kappa_{i}\right)_{1 \leq i \leq n} \in\{-1,1\}^{k}$ and let $\varepsilon_{0}>0$ be as in Proposition 3.1. For any $\varepsilon \in\left(0, \varepsilon_{0}\right)$ let $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}\right) \in S_{k}$, $k_{\varepsilon} \in C^{0}(M)$ and let $\varphi_{\varepsilon} \in K_{k}^{\perp}$ be the unique solution of

where the $\lambda_{i j}$ are uniquely defined by (3.1) and $f(u)=|u|^{2^{*}-2} u$ or $f(u)=$ $\left(u_{+}\right)^{2^{*}-1}$. Assume that $k_{\varepsilon}$ satisfies (3.5). Then:

- For any $1 \leq \ell \leq k$,

where the notation $\mathbb{1}_{\left\{\theta_{\ell+1}(x) \leq \mu_{\ell}\right\}}$ indicates that this term vanishes when $\theta_{\ell+1}(x)>\mu_{\ell}$, and with the convention that $B_{k+1}=\emptyset$ and $W_{k+1}=0$.

- For any $x \in B_{1} \backslash B_{2}=M \backslash B_{2}$ :

The constants appearing in (3.8), (3.9), (3.10) are independent of $\varepsilon$ and of the choices of $\left(t_{1}, \xi_{1},\left(t_{i, \varepsilon}, z_{i, \varepsilon}\right)_{2 \leq i \leq k}\right) \in S_{k}, U_{1}, \ldots, U_{k}$ and $k_{\varepsilon}$.

In Proposition 3.2, $B_{\ell}$ is as in (2.12) and $\theta_{\ell}$ as in (2.18).
Let us comment on this result. Proposition 3.2 yields a pointwise control on $\varphi_{\varepsilon}$ and on the $\lambda_{i j}$ assuming only (3.5): no previous control on $\varphi_{\varepsilon}$ or on the $\lambda_{i j}$ was assumed. The estimates (3.9) and (3.10) have a deeper meaning. Let
indeed $G_{\varepsilon}$ be the Green's function of $\triangle_{g}+c_{n} S_{g}+\varepsilon h$ in $M$. Assuming that $k_{\varepsilon}$ satisfies (3.5), straightforward computations using (A.1) and (A.2) give:

for $x \in B_{\ell} \backslash B_{\ell+1}, 2 \leq \ell \leq k$, and

\int_{M} G_{\varepsilon}(x, \cdot)\left|k_{\varepsilon}\right| d v_{g} \lesssim & \left\{\begin{array}{lr}
\frac{\mu_{1}^{\frac{n+2}{2}}}{\theta_{1}(x)^{2}} & \text { if }(M, g) \text { is l.c.f. around } \xi_{1}, \\
\frac{\mu_{1}^{\frac{n+2}{2}}}{\theta_{1}(x)^{n-4}} & \text { if }(M, g) \text { is not l.c.f. }
\end{array}\right\} \\
& +\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\left\{\theta_{2}(x) \leq \mu_{1}\right\}} .
\end{aligned}
$$

if $x \in B_{1} \backslash B_{2}=M \backslash B_{2}$. Compare the last two estimates with (3.9) and (3.10): Proposition 3.2 therefore shows that a solution $\varphi_{\varepsilon} \in K_{k}^{\perp}$ of (3.7) behaves as if it satisfied the much simpler equation

with the $\lambda_{i j}$ satisfying (3.8). Proposition 3.2 thus shows that the term $f^{\prime}\left(\sum_{i=1}^{k} \kappa_{i} U_{i}\right) \varphi_{\varepsilon}$ has no incidence on the behavior of $\varphi_{\varepsilon}$, provided $\varphi_{\varepsilon} \in K_{k}^{\perp}$ : it therefore has to be seen as a considerably more involved analogue of Proposition 3.1, one which yields sharp pointwise estimates on $\varphi_{\varepsilon}$. The usefulness of Proposition 3.2 in the proof of Theorems 1.1 and 1.2 becomes clear when anticipating on Section 4 below. In Section 4 we will perform a nonlinear fixed-point argument to solve (1.3) up to kernel elements. Thanks to Proposition 3.2 we will be able to perform the point-fixing argument in suitably weighted spaces for the $C^{0}$ norm. An accurate choice of the weight will reduce the point-fixing to an application of Proposition 3.2 with an error term given by (3.6) and by a negligible (and controlled) nonlinear correction.

The proof of Proposition 3.2 goes through an a priori bubble-tree analysis. We iteratively obtain refined pointwise estimates on $\left|\varphi_{\varepsilon}\right|$ on each annular region $B_{i} \backslash B_{i+1}$ starting from $B_{k}$ (which corresponds to the highest bubble). These estimate depend on the pointwise behaviour of $\varphi_{\varepsilon}$ on all of $M$ and on the $\lambda_{i j}$ and are heavily intertwined. We then propagate these estimates until $M \backslash B_{1}$, we perform a second-order one-bubble analysis on the lowest bubble in $M \backslash B_{1}$ to prove (3.10), and we propagate it back to the highest bubble to obtain (3.9). The $\lambda_{i j}$ themselves are iteratively estimated in the course of the proof.
3.2. A representation formula. We start by proving a short lemma that will be crucial in the proof of Proposition 3.2. It is a representation formula for the linearised operator at the standard bubble in $\mathbb{R}^{n}$ :

In the rest of the proof of Proposition 3.2 both the expressions $\varepsilon \mu_{\ell}^{2}$ and $\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}}$ shall appear throughout the computations. When $\ell \geq 2$, of course, they are of the same order in $\varepsilon$ by (2.8). They might differ when $\ell=1$, however, according to whether $(M, g)$ is locally conformally flat around $\xi_{1}$ or not. It will be understood, by the choice of our convention $\mu_{0}=\frac{1}{\mu_{1}}$, that the term $\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}}$ becomes $\mu_{1}^{n-2}$ when $\ell=1$.

The core of the proof of Proposition 3.2 consists in proving recursively that $\left(H_{\ell}\right)$ is true for any $1 \leq \ell \leq k$.
Lemma 3.4. For any $1 \leq \ell \leq k,\left(H_{\ell}\right)$ is true.
Proof. We prove Lemma 3.4 by induction. Since the proof of the initialisation and the induction part are very close we prove them together. Let $1 \leq \ell \leq k$ be an integer. If $\ell=k$, we do not assume anything. If $\ell \leq k-1$, we assume that $\left(H_{\ell+1}\right)$ holds true. The proof of $\left(H_{\ell}\right)$ goes through a series of steps.

& \lesssim\left\{\begin{array}{lr}
\left(\frac{\mu_{\ell}}{\mu_{i}}\right)^{\frac{n+2}{2}} \Lambda_{i} & \text { if } i \leq \ell-1 \\
\Lambda_{\ell}(1+|x|)^{-n-2} & \text { if } i=\ell \\
\Lambda_{i} \hat{W}_{i}(x)^{2^{*-1}} & \text { if } i \geq \ell+1

\end{aligned}

Note also that we have $\hat{Z}_{\ell, j}(x)=V_{j}(x)$ for any $x \in \hat{B}_{\ell}$, where $V_{j}$ is as in (2.17). Gathering the previous estimates in (3.22) shows that $\hat{\varphi}_{\varepsilon}$ satisfies:

& +\left\{\begin{array}{l}
\varepsilon \mu_{\ell}^{2}(1+|x|)^{n-6} \\
+\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}\right)^{\frac{n-2}{2}} \frac{(1+|x|)^{n-6}}{\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{n-2}} \\
\quad \text { in } \hat{B}_{\ell} \backslash \hat{B}_{\ell+1} \\
\sum_{i=\ell+1}^{k} \hat{W}_{i}(x)^{2^{*}-2}
\end{array}\right\} \cdot\left|\hat{\varphi}_{\varepsilon}\right| \\
& +\left\{\begin{array}{l}
\mu_{\ell}^{n-2}(1+|x|)^{n-6}\left|\hat{\varphi}_{\varepsilon}\right| \\
\mu_{\ell}^{4}\left(1+|x|^{2}\right)\left|\hat{\varphi}_{\varepsilon}\right|+\mu_{\ell}^{3}|x|^{2}\left|\nabla \hat{\varphi}_{\varepsilon}(x)\right|+\mu_{\ell}^{2}|x|^{2}\left|\nabla^{2} \hat{\varphi}_{\varepsilon}(x)\right| \quad \text { otherwise }
\end{array}\right. \\
& +\left(\begin{array}{l}
\left.\frac{\mu_{\ell}}{\mu_{\ell-1}}\left|\hat{\varphi}_{\varepsilon}\right|+\sqrt{\frac{\mu_{\ell}}{\mu_{\ell-1}}}\left|\nabla \hat{\varphi}_{\varepsilon}\right|\right) \cdot \mathbb{1}_{\frac{3}{2}} \sqrt{\frac{\mu_{\ell-1}}{\mu_{\ell}}} \leq|x| \leq 2 \sqrt{\frac{\mu_{\ell-1}}{\mu_{\ell}}} .

When $\ell \geq 2$ or when $\ell=1$ and $(M, g)$ is locally conformally flat the term $\mu_{\ell}^{n-2}(1+|x|)^{n-6}\left|\hat{\varphi}_{\varepsilon}\right|$ is absorbed into the term $\varepsilon \mu_{\ell}^{2}(1+|x|)^{n-6}\left|\hat{\varphi}_{\varepsilon}\right|$. Recall also that when $\ell=1$ the term $\varepsilon \mu_{\ell}^{2}(1+|x|)^{n-6}\left|\hat{\varphi}_{\varepsilon}\right|$, which is due to the contribution of $W_{\ell}^{2^{*}-3} W_{\ell-1}$, vanishes.

Step 2: a first pointwise estimate. In this step we prove the following rough estimate:

& +\left(1+a_{\ell}\right)\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 2\right\}}
\end{align*}
$$

where $\Pi\left(\hat{\varphi}_{\varepsilon}\right)$ is defined in Lemma 3.3. The notation $\mathbb{1}_{\text {n.l.c.f }}$ indicates that this term vanishes if $(M, g)$ is locally conformally flat.

Proof. We apply (3.12) to $\hat{\varphi}_{\varepsilon}$. As already mentioned, if $\ell=k$ we do not assume anything, but if $\ell \leq k-1$ we assume that $\left(H_{\ell+1}\right)$ holds. Let $x \in \hat{B}_{\ell} \backslash \hat{B}_{\ell+1}$ (which only implies $x \in \hat{B}_{k}$ if $\ell=k$ ).

- First, straightforward computations using (3.19) and Giraud's lemma show that

& \lesssim\left(\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j}\right) \hat{W}_{\ell+1}(x)+\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}}
\end{aligned}

where we used the induction property $\left(H 1_{\ell+1}\right)$ to obtain the last line. Gathering these two estimates yields

& \quad+\left(\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j}\right) \hat{W}_{\ell+1}(x)+\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}} \tag{3.26}
\end{align*}
$$

- Using now (3.5), (A.1) and (A.2) we obtain

& \quad+\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}}+\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1} \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 2\right\}} . \tag{3.27}

- We now compute the terms involving the $\lambda_{i j}$. On one side, Giraud's lemma together with straightforward computations yields

where the sum is empty if $\ell=1$. On the other side, straightforward computations yield

\end{align*}

- Mimicking the previous computations we also obtain, using $\left(H 1_{\ell+1}\right)$ when $\ell \leq k-1$, that when $(M, g)$ is locally conformally flat

& +\frac{\mu_{\ell}^{n-2}\left(1+a_{\ell}\right)}{(1+|x|)^{2}}
\end{align*}
$$

holds, while when $(M, g)$ is not locally conformally flat around $\xi_{1}$ we obtain:

\int_{\hat{B}_{\ell}} \mu_{\ell}^{4}\left(1+|y|^{2}\right)\left|\hat{\varphi}_{\varepsilon}(y)\right||x-y|^{2-n} d y & \lesssim \frac{\mu_{\ell}^{4}\left(1+a_{\ell}\right)}{(1+|x|)^{n-6}}+\frac{\mu_{\ell}^{4} \sum_{j \geq \ell} a_{j}}{(1+|x|)^{n-2}}  \tag{3.34}\\
& +\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j} \hat{W}_{j}(x)
\end{align*}
$$

- The only terms in (3.24) that remain to be estimated involve derivatives of $\hat{\varphi}_{\varepsilon}$. We control them with the following Claim:
Claim 3.6. Let $1 \leq i \leq k$. For any $x \in C_{i}$, where $C_{i}$ is as in (3.17), there holds

& +\sum_{p \leq i-1} \Lambda_{p} \mu_{p}^{1-\frac{n}{2}}
\end{aligned}
$$

where we have let

Proof. The proof is a simple application of elliptic regularity results. We keep the notations of (3.21). By (3.24) it is easily seen that for any $y \in \hat{B}_{i} \backslash \hat{B}_{i+1}$

& \quad+\frac{\varepsilon \mu_{i}^{2}}{(1+|y|)^{n-2}}+\left(\frac{\mu_{i+1}}{\mu_{i}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|y|)^{4}} \frac{1}{\left(\frac{\mu_{i+1}}{\mu_{i}}+\left|z_{i+1}-y\right|\right)^{n-2}} .
\end{aligned}
$$

Let $\left(y_{\varepsilon}\right)_{\varepsilon}$ be a sequence of points in $\hat{B}_{i} \backslash \hat{B}_{i+1}$.
We first assume that $\left|y_{\varepsilon}-z_{i+1}\right| \leq 2$. For any $z \in B_{0}(3 / 2) \backslash B_{0}(2 / 3)$ we let

where we have let $\alpha_{i}=\left|y_{\varepsilon}-z_{i+1}\right|$. Letting $\tilde{g}_{i}(z)=\hat{g}_{i}\left(z_{i+1}+\alpha_{i} z\right)$ and since $\alpha_{i} \lesssim \sqrt{\frac{\mu_{i-1}}{\mu_{i}}}$ by definition it is then easily seen that $\tilde{\varphi}_{\varepsilon}$ satisfies

Since $\alpha_{i} \lesssim \sqrt{\frac{\mu_{i-1}}{\mu_{i}}}, \tilde{g}_{i}$ is $C^{k}$-close to the Euclidean metric for any $k \geq 1$. Standard elliptic theory then yields

Since $y_{\varepsilon} \in \hat{B}_{i} \backslash \hat{B}_{i+1}$, by letting $\tilde{y}_{\varepsilon}=\exp _{\xi_{i}}^{g_{\xi_{i}}}\left(\mu_{i} y_{\varepsilon}\right)$ there holds $\alpha_{i} \lesssim \frac{\theta_{i+1}\left(\tilde{y}_{\varepsilon}\right)}{\mu_{i}}$ and $\frac{\theta_{i+1}\left(\tilde{y}_{\varepsilon}\right)}{\mu_{i}} \lesssim \alpha_{i}$. Scaling back (3.35) to the original variables yields, for all $x \in B_{i}$ with $\theta_{i+1}(x) \leq \mu_{i}$ :

& +\sum_{p \leq i-1} \Lambda_{p} \mu_{p}^{1-\frac{n}{2}} \\
& \lesssim\left(a_{i}+\sum_{p \geq i} \Lambda_{p}\right) W_{i}(x)+\mu_{i-1}^{1-\frac{n}{2}}\left(\frac{\mu_{i}}{\theta_{i}(x)}\right)^{2}+\frac{\theta_{i+1}(x)^{2}}{\mu_{i}^{2}} W_{i+1}(x) \mathbb{1}_{\left\{\theta_{i+1}(x) \leq \mu_{i}\right\}} \\
& +\sum_{p \leq i-1} \Lambda_{p} \mu_{p}^{1-\frac{n}{2}}
\end{aligned}
$$

which proves Claim 3.6 in the case $\theta_{i+1}(x) \leq \mu_{i}$. We used here that $\mu_{i}^{1-\frac{n}{2}} \lesssim$ $W_{i}(x)$ when $x \in B_{i}$ and $\theta_{i+1}(x) \leq \mu_{i}$.

Assume then that $\left|y_{\varepsilon}-z_{i+1}\right| \geq 2$. Let, for any $z \in B_{0}(3 / 2) \backslash B_{0}(2 / 3)$,

Letting $\tilde{g}_{i}(z)=$ $\hat{g}_{i}\left(\alpha_{i} z\right)$, and since $1+\left|z_{i+1}-\alpha_{i} z\right| \gtrsim 1+\alpha_{i} \gtrsim 1$ for any $z \in B_{0}(3 / 2) \backslash B_{0}(2 / 3)$,
it is then easily seen that $\tilde{\varphi}_{\varepsilon}$ satisfies

\left|\triangle_{\tilde{g}_{i}} \tilde{\varphi}_{\varepsilon}(z)+O\left(\mu_{i} \mu_{i-1}\left|\tilde{\varphi}_{\varepsilon}(z)\right|\right)\right| & \lesssim \frac{a_{i}}{\left(1+\alpha_{i}\right)^{n-2}}+\frac{\mu_{i}^{n-2} \mathbb{1}_{1 . c . \mathrm{f}}}{\left(1+\alpha_{i}\right)^{2}}+\frac{\varepsilon \mu_{i}^{2}}{\left(1+\alpha_{i}\right)^{n-4}} \\
& +\left(\frac{\mu_{i+1}}{\mu_{i}}\right)^{\frac{n-2}{2}} \frac{1}{\left(1+\alpha_{i}\right)^{n}} .
\end{aligned}
$$

Scaling back to the original variables as before proves the Claim when $x \in B_{i}$ and $\theta_{i+1}(x) \geq \mu_{i}$, and concludes the proof of Claim 3.6.

We now conclude the proof of (3.25).

- A straightforward application of Claim 3.6 yields, together with $\left(H 2_{\ell+1}\right)$ in the case where $\ell \leq k-1$ :

& \lesssim \varepsilon \mu_{\ell}^{2} \sum_{j \geq \ell} a_{j}+\sum_{j \leq \ell-1}\left(\frac{\mu_{\ell}}{\mu_{j}}\right)^{\frac{n-2}{2}} \Lambda_{j}+\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}}  \tag{3.36}\\
& +\frac{\varepsilon \mu_{\ell}^{2}\left(1+\sum_{j \leq \ell-1} a_{j}\right)}{(1+|x|)^{n-4}} .
\end{align*}
$$

If $(M, g)$ is locally conformally flat, estimates (3.26) - (3.33) and (3.36) together with (3.12) conclude the proof of (3.25).

- It therefore remains to conclude the proof in the non-locally conformally flat case. In that case, using (3.19), $\left(H 1_{\ell+1}\right)$ and $\left(H 2_{\ell+1}\right)$ if $\ell \leq k-1$, and Claim 3.6, we have

& +\varepsilon \mu_{\ell}^{2} \frac{\sum_{j \leq \ell-1} a_{j}}{(1+|x|)^{n-2}}+\left(\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j}\right) \hat{W}_{\ell+1}(x)  \tag{3.37}\\
& +\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 1\right\}}+\frac{\varepsilon \mu_{\ell}^{2}}{(1+|x|)^{n-4}} .
\end{align*}
$$

Combining (3.26) $-(3.34)$ with (3.37) and (3.12) then concludes the proof of (3.25) in the non-locally conformally flat case.

Step 3: Estimation of $\left|\Pi\left(\hat{\varphi}_{\varepsilon}\right)(x)\right|$. We prove in this part the following

Claim 3.7. For all $0 \leq j \leq n$,

As a consequence, for any $x \in \hat{B}_{\ell} \backslash \hat{B}_{\ell+1}$ :

By definition of $\varphi_{\varepsilon}$ in Proposition 3.1 we have $\varphi_{\varepsilon} \in K_{k}^{\perp}$, which implies that

& =\int_{B_{\ell}} \varphi_{\varepsilon}\left(\triangle_{g}+c_{n} S_{g}+\varepsilon h\right) Z_{\ell, j} d v_{g}+O\left(\sum_{j \leq \ell-1}\left(\frac{\mu_{\ell}}{\mu_{j}}\right)^{\frac{n-2}{2}} a_{j}\right)  \tag{3.39}\\
& =\int_{\hat{B}_{\ell}} \hat{\varphi}_{\varepsilon}\left(\triangle_{\hat{g}_{\ell}}(y)+\mu_{\ell}^{2} c_{n} S_{\hat{g}_{\ell}}\left(y_{\ell}\right)\right) V_{j}(y) d y+O\left(\varepsilon \mu_{\ell}^{2} \sum_{j \leq \ell} a_{j}\right)
\end{align*}
$$

where $y_{\ell}=\exp _{\xi_{\ell}}^{g_{\xi_{\ell}}}\left(\mu_{\ell} y\right)$. If $(M, g)$ is locally conformally flat we have

\end{equation*}

$$

Combining with (3.39) concludes the proof of (3.38).
Step 4: improvement of (3.25) into an optimal estimate. We prove in this step the following improvement of (3.25):
Claim 3.8. For any $x \in \hat{B}_{\ell} \backslash \hat{B}_{\ell+1}$ there holds

& +\frac{\Lambda_{\ell}}{(1+|x|)^{n-2}}+\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}}  \tag{3.41}\\
& +\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j} \hat{W}_{j}+\frac{\mu_{\ell}^{4} a_{\ell}}{(1+|x|)^{n-6}} \mathbb{1}_{\text {n.l.c.f }} \\
& +\left(1+a_{\ell}\right)\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 2\right\}} .
\end{align*}

Proof. First, in the locally conformally flat case, (3.41) follows from combining (3.25) with (3.38). We therefore assume that $(M, g)$ is not locally conformally flat. Combining (3.25) and (3.38) we have, for any $x \in \hat{B}_{\ell} \backslash \hat{B}_{\ell+1}$ :

& +\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}} \frac{1}{(1+|x|)^{2}} \\
& +\left(1+a_{\ell}\right)\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 2\right\}} .
\end{align*}
$$

With (3.42) we can now improve (3.38). Using (3.40) together with (3.42) now yields

\quad \lesssim \varepsilon \mu_{\ell}^{2} \sum_{j=1}^{k} a_{j}+\Lambda_{\ell}+\sum_{j \leq \ell-1}\left(\frac{\mu_{\ell}}{\mu_{j}}\right)^{\frac{n-2}{2}} \Lambda_{j},
\end{gathered}
$$

where we used (2.8) to claim that in the non-locally conformally flat case we have $\mu_{\ell}^{2} \lesssim \varepsilon$ and thus $\mu_{\ell}^{4} \lesssim \varepsilon \mu_{\ell}^{2}$ for all $\ell \geq 1$. The other steps in the proof of (3.38) are left unchanged and we obtain now

Going back to the proof of (3.25) it is easily seen that, when $(M, g)$ is not locally conformally flat, the term $\mu_{\ell}^{2} a_{\ell}(1+|x|)^{4-n}$ comes from the contribution of (3.37). We are now going to use (3.42) to compute (3.37) again. First, a straightforward adaptation of the proof of Claim [3.6, using now (3.42) to control $\varphi_{\varepsilon}$, yields the following improved estimate on the derivatives of $\varphi_{\varepsilon}$ : for all $x \in C_{\ell}$,

& +\left(1+a_{\ell}\right) \frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\left\{\theta_{\ell+1}(x) \leq \mu_{\ell}\right\}}+\sum_{p \leq \ell-1} \Lambda_{p} \mu_{p}^{1-\frac{n}{2}}
\end{aligned}
$$

where $C_{\ell}$ is as in (3.17) and where we have again let $\tilde{\theta}_{\ell}(x)=\min \left(\theta_{\ell+1}(x), \theta_{\ell}(x)\right)$. The latter estimate now yields, together with $\left(H 1_{\ell+1}\right)$ when $\ell \leq k-1$ :

& +\frac{\Lambda_{\ell}}{(1+|x|)^{n-2}}+\frac{\varepsilon \mu_{\ell}^{2}\left(1+\sum_{j \leq \ell} a_{j}\right)}{(1+|x|)^{n-4}}+\left(\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j}\right) \hat{W}_{\ell+1}(x)  \tag{3.44}\\
& +\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 1\right\}}+\frac{\mu_{\ell}^{4} a_{\ell}}{(1+|x|)^{n-6}} \mathbb{1}_{\text {n.l.c.f. }} .
\end{align*}
$$

Combining (3.26) - (3.34) with (3.43) and (3.44) finally proves (3.41).

Step 5: estimation of $\Lambda_{\ell}$ and conclusion. Let $j \in\{0, \ldots, n\}$ be fixed. We integrate (3.7) against $Z_{\ell, j}$ : using (2.8), (2.21), (2.22), (3.5) and (3.16) we
obtain

& =O\left(\varepsilon \mu_{\ell}^{2}\right)+O\left(\sum_{j \leq \ell-1}\left(\frac{\mu_{\ell}}{\mu_{j}}\right)^{\frac{n-2}{2}} a_{j}+\sum_{j \geq \ell+1}\left(\frac{\mu_{j}}{\mu_{\ell}}\right)^{\frac{n-2}{2}} a_{j}\right) \\
& +\int_{B_{\ell} \backslash B_{\ell+1}} \varphi_{\varepsilon}\left(\triangle_{g}+c_{n} S_{g}+\varepsilon h-f^{\prime}\left(\sum_{j=1}^{k} \kappa_{j} W_{j}\right)\right) Z_{\ell, j} d v_{g} \\
& =O\left(\varepsilon \mu_{\ell}^{2}\left(1+\sum_{j=1}^{k} a_{j}\right)\right) \\
& +\int_{B_{\ell \backslash B_{\ell+1}}} \varphi_{\varepsilon}\left(\triangle_{g}+c_{n} S_{g}+\varepsilon h-\left(2^{*}-1\right) W_{\ell}^{2^{*}-2}\right) Z_{\ell, j} d v_{g}
\end{aligned}
$$

where we used (3.23) and where we also used (2.7) to claim that $\mu_{\ell+1} / \mu_{\ell} \lesssim$ $\mu_{\ell} / \mu_{\ell-1}$ for $1 \leq \ell \leq k$. Using (2.19) and (2.20) and controlling $\hat{\varphi}_{\varepsilon}$ by (3.41) finally yields, after straightforward computations:

& +\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j} \hat{W}_{j} \\
& +\left(1+a_{\ell}\right)\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}+\left|x-z_{\ell+1}\right|\right)^{2} \hat{W}_{\ell+1}(x) \mathbb{1}_{\left\{\left|x-z_{\ell+1}\right| \leq 2\right\}} .
\end{align*}
$$

We can now conclude the proof of Lemma3.4. If $(M, g)$ is locally conformally flat, $\left(H 1_{\ell}\right)$ follows from (3.46) by scaling back in the original variables. In the
non-locally conformally flat case we use (2.8) to claim that $\mu_{\ell}^{2} \lesssim \varepsilon$ and thus

& +\sum_{j \geq \ell+1} \mu_{j-1}^{2} a_{j} W_{j}(x)+\varepsilon\left(1+\sum_{j \leq \ell} a_{j}\right) \theta_{\ell}^{2}(x) W_{\ell}(x) \\
& +\left(1+a_{\ell}\right) \frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\left\{\theta_{\ell+1}(x) \leq \mu_{\ell}\right\}},
\end{aligned}
$$

which proves that $\left(H 1_{\ell}\right)$ holds true. Since in the case $\ell=k$ we did not assume anything, this shows that $\left(H_{k}\right)$ is true. The general case for $1 \leq \ell \leq k$ follows by induction.
3.4. Proof of Proposition 3.2, Part 2: end of the proof. The last step of the proof of Proposition 3.2 is an inductive estimation of the $a_{i}$.

Claim 3.9. For any $2 \leq \ell \leq k$ we have

Proof. We prove (3.47) inductively using ( $\left.H 1_{\ell}\right)$ and $\left(H 2_{\ell}\right)$. Let $\ell \geq 2$. If $\ell=k$ we do not assume anything, while if $\ell \leq k-1$ we assume that (3.47) is true for any $p \geq \ell+1$. For $x \in M$ let $G_{\varepsilon}(x, \cdot)$ denote the Green's function for $\triangle_{g}+c_{n} S_{g}+\varepsilon h$ in $M$. Standard properties of $G_{\varepsilon}$ (Robert [34]) ensure that

We write a representation formula for $\varphi_{\varepsilon}$ in $M$ : with (3.7) it writes as

& +\int_{M \backslash B_{g_{\xi_{1}}}\left(\xi_{1}, r_{0}\right)} d_{g}(x, \cdot)^{2-n} W_{1}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g} \\
& +\int_{B_{\xi_{\xi_{1}}}\left(\xi_{1}, r_{0}\right) \backslash B_{2}} d_{g}(x, \cdot)^{2-n} W_{1}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g}
\end{align*}
$$

where $r_{0}$ is as in (2.3). Assume now that $x \in C_{\ell}$, where $C_{\ell}$ is defined in (3.17). First, straightforward computations using (2.8), (2.13), (3.5), (A.1) and (A.2) below show that

& +\frac{\mu_{\ell}}{\mu_{\ell-1}} W_{\ell}(x)+\frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\theta_{\ell+1}(x) \leq \mu_{\ell}}
\end{aligned}
$$

Independently, using the definition of $a_{1}$ in (3.19), (A.1) and since $x \in \mathcal{C}_{\ell}$, $\ell \geq 2$, we have

\int_{M \backslash B_{g_{1}}\left(\xi_{1}, r_{0}\right)} d_{g}(x, \cdot)^{2-n} W_{1}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g} \lesssim a_{1} \mu_{1}^{\frac{n+2}{2}} \lesssim a_{1} \varepsilon \mu_{1}^{3-\frac{n}{2}} .
$$

Using (2.13), (H1 $)$, (A.1) and (A.2) we similarly obtain, since $x \in C_{\ell}$ and $\ell \geq 2$, that:

& \quad \lesssim\left(1+\sum_{j \geq \ell} a_{j}\right)\left(\mu_{\ell-1}^{1-\frac{n}{2}}\left(\frac{\mu_{\ell}}{\theta_{\ell}(x)}\right)^{2}+\varepsilon \mu_{\ell-1}^{3-\frac{n}{2}}+\frac{\mu_{\ell}}{\mu_{\ell-1}} W_{\ell}(x)\right. \\
& \left.\quad+\frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\theta_{\ell+1}(x) \leq \mu_{\ell}}\right) .
\end{aligned}
$$

Using (2.13) and $\left(H 2_{\ell}\right)$ we also obtain that

\left|\sum_{\substack{i=1 . . k \\ j=0 . . n}} \lambda_{i j} Z_{i, j}(x)\right| \lesssim\left(1+\sum_{j=1}^{k} a_{j}\right)\left(\frac{\mu_{\ell}}{\mu_{\ell-1}} W_{\ell}(x)+\varepsilon \mu_{\ell-1}^{3-\frac{n}{2}}\right) .

Remark now that there holds, for any $x \in C_{\ell}$ and since $\ell \geq 2$ :

Since $W_{\ell}(x) \gtrsim \mu_{\ell-1}^{1-\frac{n}{2}}$ on $C_{\ell}$ the latter estimate gives, together with (2.8),

It remains to estimate $a_{1}$ to conclude the proof. This is the content of the following Claim:

Claim 3.10. We have

In particular, $a_{1}=o(1)$ as $\varepsilon \rightarrow 0$.
Proof. Estimate $\left(H 1_{1}\right)$ is for the moment still too rough on $M \backslash B_{2}$, because of the constant term $\varepsilon \mu_{1}^{3-\frac{n}{2}}$. As a first thing, we improve the precision of the estimate. Let $x \in M \backslash B_{2}$. We use again the representation formula (3.48) and we estimate again each term. Since $x \in M \backslash B_{2}$ we have, with (A.1) and (A.2)

\varepsilon \theta_{1}(x)^{2} W_{1}(x) & \text { otherwise }
\end{array}\right\} \\
&+\varepsilon \mu_{2}^{2} W_{1}+\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\theta_{2}(x) \leq \mu_{1}}
\end{aligned}
$$

By definition of $a_{1}$ we also have

\int_{M \backslash B_{\xi_{1}}\left(\xi_{1}, r_{0}\right)} d_{g}(x, \cdot)^{2-n} W_{1}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g} \lesssim a_{1} \mu_{1}^{\frac{n+2}{2}}
$$

Using (2.13), (H1 $)$, (3.47), (A.1) and (A.2) we similarly obtain, since $x \in$ $M \backslash B_{2}$, that:

\begin{align*}
& \sum_{i=2}^{k} \int_{B_{i} \backslash B_{i+1}} d_{g}(x, \cdot)^{2-n} W_{i}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g} \\
& +\int_{B_{g_{\xi_{1}}}\left(\xi_{1}, r_{0}\right) \backslash B_{2}} d_{g}(x, \cdot)^{2-n} W_{1}^{2^{*}-2}\left|\varphi_{\varepsilon}\right| d v_{g}  \tag{3.50}\\
& \lesssim\left(1+a_{1}\right)\left[\varepsilon \mu_{1}^{3-\frac{n}{2}}\left(\frac{\mu_{1}}{\theta_{1}(x)}\right)^{2}+\varepsilon \mu_{2}^{2} W_{1}+\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\theta_{2}(x) \leq \mu_{1}}\right]
\end{align*}
$$

By (H2 $)$, (3.47) and (2.8) we now have

\left|\sum_{\substack{i=1 . . k \\ j=0 . . n}} \lambda_{i j} Z_{i, j}(x)\right| \lesssim \varepsilon \mu_{1}^{2}\left(1+a_{1}\right) W_{1}(x) .
$$

Combining the latter estimates into (3.48) then yields

\mu_{1}^{\frac{n-2}{2}}\left(\frac{\mu_{1}}{\theta_{1}(x)}\right)^{2} & \text { if }(M, g) \text { is l.c.f } \\
\varepsilon \theta_{1}(x)^{2} W_{1}(x) & \text { otherwise }
\end{array}\right\}  \tag{3.51}\\
& +\left(1+a_{1}\right)\left[\varepsilon \mu_{1}^{3-\frac{n}{2}}\left(\frac{\mu_{1}}{\theta_{1}(x)}\right)^{2}+\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\theta_{2}(x) \leq \mu_{1}}\right] .
\end{align*}
$$

It is easily seen that the limiting term $\varepsilon \mu_{1}^{3-\frac{n}{2}}\left(\frac{\mu_{1}}{\theta_{1}(x)}\right)^{2}$ in ( $(3.50)$ is due to the second integral in the left-hand side of (3.50) (the contribution over $\left.B_{g_{\xi_{1}}}\left(\xi_{1}, r_{0}\right) \backslash B_{2}\right)$. We now use (3.51) to improve the precision of this term. After a finite number of iterations using (A.1), (3.50) becomes

\mu_{1}^{\frac{n-2}{2}}\left(\frac{\mu_{1}}{\theta_{1}(x)}\right)^{2} & \text { if }(M, g) \text { is l.c.f } \\
\varepsilon \theta_{1}(x)^{2} W_{1}(x) & \text { otherwise }
\end{array}\right\}  \tag{3.52}\\
& +\left(1+a_{1}\right) \frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\theta_{2}(x) \leq \mu_{1}} .
\end{align*}
$$

As before, since $x \in M \backslash B_{2}$, we have

\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\theta_{2}(x) \leq \mu_{1}} \lesssim \frac{\mu_{2}}{\mu_{1}} W_{1}(x)

It remains to apply (3.52) to a point $x_{1} \in M \backslash B_{2}$ where $a_{1}$ is attained. We obtain:

which concludes the proof of the Claim.

End of the proof of Proposition 3.2. We are now ready to conclude the proof of Proposition 3.2. First, Claim 3.10) shows that $a_{1}=o(1)$. Using this in (3.52) proves (3.10). Then, using Claim 3.10 together with (3.47) shows inductively that

for any $x \in B_{\ell} \backslash B_{\ell+1}$. Similarly, (3.8) now shows that

& \lesssim \mu_{\ell-1}^{1-\frac{n}{2}}\left(\frac{\mu_{\ell}}{\theta_{\ell}(x)}\right)^{2}+\frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\theta_{\ell+1} \leq \mu_{\ell}}
\end{aligned}
$$

Finally, since $\ell \geq 2$, we have

\varepsilon \theta_{\ell}^{2}(x) W_{\ell}(x) \lesssim \mu_{\ell-1}^{1-\frac{n}{2}}\left(\frac{\mu_{\ell}}{\theta_{\ell}(x)}\right)^{2}

Combining these estimates in ( $H 1_{\ell}$ ) finally prove (3.9) and concludes the proof of Proposition 3.2.

## 4. The nonlinear problem

4.1. Solving (1.3) up to kernel elements. We perform in this section a nonlinear fixed-point argument in strong spaces and solve (1.3) up to kernel elements. Let $k \geq 1$ be an integer, $\left(\kappa_{i}\right)_{1 \leq i \leq n} \in\{-1,1\}^{k}$ and let $\varepsilon_{0}>0$ be as in Proposition 3.1, Let $\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k}$, where $S_{k}$ is defined in (2.9). For $0<\varepsilon \leq \varepsilon_{0}$ we define a function $\Psi_{\varepsilon}$ in $M$ as follows:

- $\Psi_{\varepsilon}(x)=\mu_{\ell-1}^{1-\frac{n}{2}}\left(\frac{\mu_{\ell}}{\theta_{\ell}(x)}\right)^{2}+\varepsilon \mu_{\ell-1}^{3-\frac{n}{2}}+\frac{\theta_{\ell+1}(x)^{2}}{\mu_{\ell}^{2}} W_{\ell+1}(x) \mathbb{1}_{\left\{\theta_{\ell+1}(x) \leq \mu_{\ell}\right\}}$
if $x \in B_{\ell} \backslash B_{\ell+1}, \quad$ for $\ell \geq 2$,
$\bullet \Psi_{\varepsilon}(x)=\left\{\begin{array}{lr}\frac{\mu_{1}^{\frac{n+2}{2}}}{\theta_{1}(x)^{2}} & \text { if }(M, g) \text { is l.c.f. around } \xi_{1} \\ \frac{\mu_{1}^{\frac{n+2}{2}}}{\theta_{1}(x)^{n-4}} & \text { if }(M, g) \text { is not l.c.f. }\end{array}\right\}+\frac{\theta_{2}(x)^{2}}{\mu_{1}^{2}} W_{2}(x) \mathbb{1}_{\left\{\theta_{2}(x) \leq \mu_{1}\right\}}$ if $x \in M \backslash B_{2}$,
where $W_{\ell}$ is given by (2.11). Let $C>0$ to be chosen later. We define

E_{\varepsilon}^{C}=\left\{\varphi \in C^{0}(M) \text { such that }|\varphi(x)| \leq C \Psi_{\varepsilon}(x) \text { for all } x \in M\right\}
$$

endowed with the following norm:

\|\varphi\|_{*}:=\left\|\frac{\varphi}{\Psi_{\varepsilon}}\right\|_{L^{\infty}(M)} \quad \text { for } \varphi \in E^{C} . \tag{4.3}
\end{equation*}

Note that $E_{\varepsilon}^{C}$ depends on $\varepsilon$ and on $\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right)$. Since $\Psi_{\varepsilon}>0$ in $M$, it is easily seen that $\left(E_{\varepsilon}^{C},\|\cdot\|_{*}\right)$ is a Banach space. Building on the linear theory of Proposition 3.2 we perform a nonlinear fixed-point procedure in $E_{\varepsilon}^{C}$ :
Proposition 4.1. Let $k \geq 1$ be an integer, $\left(\kappa_{i}\right)_{1 \leq i \leq n} \in\{-1,1\}^{k}$ and denote $f(u)=(u+)^{2^{*}-1}$ or $f(u)=|u|^{2^{*}-2}$. There exist $\varepsilon_{1}>0$ and $C>0$ such that the following holds. For any $\varepsilon \in\left(0, \varepsilon_{1}\right)$, any $h \in C^{0}(M)$ and for any $\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k}$, there exists

$$
\varphi_{\varepsilon}:=\varphi_{\varepsilon}\left(\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in K_{k}^{\perp}\right.
$$

which is the unique solution in $K_{k}^{\perp} \cap E_{\varepsilon}^{C}$ of

$$
\begin{equation*}
\Pi_{K_{k}^{\perp}}\left(\sum_{i=1}^{k} \kappa_{i} W_{i}+\varphi_{\varepsilon}-\left(\triangle_{g}+c_{n} S_{g}+\varepsilon h\right)^{-1}\left(f\left(\sum_{i=1}^{k} \kappa_{i} W_{i}+\varphi_{\varepsilon}\right)\right)\right)=0 \tag{4.4}
\end{equation*}
$$

where $E_{\varepsilon}^{C}$ is defined in (4.2). In addition,

$$
\left(\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k} \mapsto \varphi_{\varepsilon} \in C^{0}(M)\right.
$$

is continuous for any fixed value of $\varepsilon$.
The main point of Proposition 4.1 is that $\varphi_{\varepsilon}$ is constructed in the space $E_{\varepsilon}^{C}$ - and not only in $K_{k}^{\perp}$ - and satisfies therefore

$$
\begin{equation*}
\left|\varphi_{\varepsilon}\right| \lesssim \Psi_{\varepsilon} \tag{4.5}
\end{equation*}
$$

in $M$, where $\Psi_{\varepsilon}$ is given by (4.1). In particular, $\varphi_{\varepsilon}$ still satisfies the estimates (3.9) and (3.10), which is another way of thinking of the nonlinear problem (4.4) as a perturbation of the linear equation (3.7). Proposition 4.1 therefore provides us with a canonical remainder $\varphi_{\varepsilon}$ with sharp pointwise estimate that precisely capture the pointwise interactions between the towering bubbling profiles $W_{i}$ on the whole of $M$. The information that we obtain in Proposition 4.1 is thus much more precise than a mere energy estimate and will turn out to be crucial to prove Theorem 1.1]in Section 5. Such a precision, of course, comes at the expense of proving sharp pointwise estimates for the linear equation as in Proposition 3.2. Remark that since $\varphi_{\varepsilon} \in E_{\varepsilon}^{C}$ for some $C$, integrating (4.4) against $\varphi_{\varepsilon}$ yields

as $\varepsilon \rightarrow 0$, where the $H^{1}$ norm is given by (2.14).
Proof. Let $k \geq 1,\left(\kappa_{i}\right)_{1 \leq i \leq n} \in\{-1,1\}^{k}, 0<\varepsilon \leq \varepsilon_{0}$ and let $\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in$ $S_{k}$. In the following proof we will omit, for the sake of clarity, the dependency in $\varepsilon$ and $\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k}$ in the quantities $W_{i}, Z_{i, j}, \ldots$ appearing. The proof of Proposition 4.1 follows the standard steps of a nonlinear fixed-point scheme, with the notable exception that the point-fixing is now achieved in the strong space $E_{\varepsilon}^{C}$ defined by (4.2).

Let $C>0$ be fixed (to be chosen later). For $\varphi \in E_{\varepsilon}^{C}$, as defined in (4.2), we define

The mapping $T$ is well-defined since $\varphi \in E_{\varepsilon}^{C}$ and thus $-R_{\varepsilon}+N(\varphi) \in C^{0}(M)$. By (3.4), $T(\varphi)$ solves

for some uniquely defined real numbers $\left(\lambda_{i j}\right)$. We show that $T$ is a contraction on $\left(E_{\varepsilon}^{C},\|\cdot\|_{*}\right)$ for $\varepsilon$ small enough, for a suitable fixed value of $C$.

We first prove that $T$ stabilises $E_{\varepsilon}^{C}$. By (4.1) one has

&+C^{2}\left(\frac{\mu_{i+1}}{\mu_{i}}\right)^{2} W_{i}(x)^{2^{*}-2} W_{i+1}(x) \tag{4.8}

where we used (3.49) and (2.8). Similarly for $x \in M \backslash B_{2}$, we get by (4.1)

when $(M, g)$ is locally conformally flat around $\xi_{1}$, and

\end{equation*}

when $(M, g)$ is not conformally flat. The previous estimates show that there exists a positive constant $D_{0}>0$ such that

satisfies (3.5), where $C$ is the constant in (4.2). Independently, by (3.6) we know that there exists a constant $D_{1}>0$ such that $R_{\varepsilon} / D_{1}$ also satisfies (3.5). By (4.7) we can then apply Proposition 3.2 which yields a positive constant $C_{1}>0$ independent of $\varepsilon$ such that

where the norm is defined in (4.3). Choose $C=2 C_{1}$. Since $\mu_{1}^{4}+\frac{\mu_{2}^{2}}{\mu_{1}^{2}} \rightarrow 0$ as $\varepsilon \rightarrow 0$, for $\varepsilon$ small enough we then have $T(\varphi) \in E_{\varepsilon}^{C}$.

We now prove that $T$ is a contraction on $\left(E_{\varepsilon}^{C},\|\cdot\|\right)$ for this fixed value of $C$. If $\varphi_{1}, \varphi_{2} \in E_{\varepsilon}^{C}, T\left(\varphi_{1}\right)-T\left(\varphi_{2}\right)$ satisfies by assumption:

\end{align*}

for some real numbers $\left(\nu_{i j}\right)$. By (4.2), (4.3), the mean-value theorem and since $\varphi \in E_{\varepsilon}^{C}$ we have

In (4.8), (4.9) and (4.10) we already showed that

satisfies (3.5) for some positive constant $D_{2}$ independent of $\varepsilon$. With (4.12) we can again apply Proposition 3.2 and we obtain that

Picard's fixed-point theorem then yields the existence of a unique fixed-point $\varphi_{\varepsilon}$ of $T$ in $E_{\varepsilon}^{C}$ which is by (4.7), equivalently, a solution of (4.4).

It remains to see that for a fixed $\varepsilon$ the mapping

is continuous. By construction $\varphi_{\varepsilon}$ satisfies (4.7) with $T\left(\varphi_{\varepsilon}\right)=\varphi_{\varepsilon}$. By (4.11), $N\left(\varphi_{\varepsilon}\right)$ satisfies (3.5) up to a constant, and therefore Proposition 3.2 applies again: (3.8) in particular shows that the $\lambda_{i j}$ are uniformly bounded in $\varepsilon$ and in the choice of $\left(\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k}\right.$. The continuity of $\left(t_{i}, z_{i}\right)_{1 \leq i \leq \ell} \in S_{\ell} \mapsto$ $\varphi_{\varepsilon, \ell} \in C^{0}(M)$ now easily follows from the continuity of the $W_{i}, 1 \leq i \leq k$, from (4.7) and from standard elliptic theory, and by the uniqueness property of $\varphi_{\varepsilon, \ell}$ in $K_{k}^{\perp} \cap E_{\varepsilon}^{C}$.
4.2. Application to a priori pointwise estimates. The procedure developed in Propositions 3.2 and 4.1 can be useful when looking for a priori estimates. We illustrate this on a toy-model example. Consider for instance $h \in C^{0}(M)$, a sequence $\left(\varepsilon_{k}\right)$ of positive numbers converging to 0 as $k \rightarrow+\infty$ and a sequence $\left(u_{k}\right)_{k}$ of positive functions satisfying

in $M$. We assume for simplicity that the sequence $\left(u_{k}\right)_{k}$ blows-up with finiteenergy and a zero weak-limit. By Struwe's celebrated compactness result [39] there exists $N \geq 1$ such that

as $k \rightarrow+\infty$, where $K_{n}^{-n}$ is the energy of the standard bubble in $\mathbb{R}^{n}$ and where the $H^{1}$ norm is given by (2.14). Consider the manifold of the sums of $N$ bubbles in $M$ :

where $W_{\mu_{i}, \xi_{i}}$ is given by (2.4). It is a $N(n+1)$-dimensional closed manifold of $H^{1}(M)$. For any $k \geq 1$, we can thus let $\left(\mu_{i, k}, \xi_{i, k}\right)_{1 \leq i \leq N}$ be such that

Struwe's result asserts in addition that $\left\|\varphi_{k}\right\|_{H^{1}} \rightarrow 0$ as $k \rightarrow+\infty$. We thus have

Now, the elements $\mathcal{Z}_{i, 0}$ and $\mathcal{Z}_{i, j}$ are respectively equal to $Z_{i, 0}$ and $Z_{i, j}$ in (2.15) at first order. A simple adaptation of the results in Robert-Vétois 36] therefore shows that, for $\delta>0$ small enough fixed there exists, for $k$ large enough, a unique $\psi_{k} \in \mathcal{K}_{N, k}^{\perp}$ satisfying $\left\|\psi_{k}\right\|_{H^{1}}<\delta$ and
$\Pi_{\mathcal{K}_{N, k}^{\perp}}\left(\sum_{i=1}^{N} W_{\mu_{i, k}, \xi_{i, k}}+\psi_{k}-\left(\triangle_{g}+c_{n} S_{g}+\varepsilon_{k} h\right)^{-1}\left(\left(\sum_{i=1}^{N} W_{\mu_{i, k}, \xi_{i, k}}+\psi_{k}\right)_{+}^{2^{*}-1}\right)\right)=0$.
By (4.14) we thus have $\psi_{k}=\varphi_{k}$. Assume now that $\left(\mu_{i, k}, \xi_{i, k}\right)_{1 \leq i \leq N}$ satisfies (2.8) and (2.10). It is easily seen that the results in Section 3 still apply if we replace $Z_{i, j}$ by $\mathcal{Z}_{i, j}$ and $K_{k}$ by $\mathcal{K}_{N, k}$, since only the leading-order behavior of $\mathcal{Z}_{i, j}$ comes into play in the proof of Proposition 3.2. We can therefore apply Proposition 4.1 with $\mathcal{K}_{N, k}$ (and, say, $t_{i}=1$ for all $1 \leq i \leq N$ ) which provides us, for $k$ large enough, with a uniquely defined $\tilde{\varphi}_{k} \in \mathcal{K}_{N, k}^{\perp}$ which solves the previous equation and satisfies in addition $\left\|\tilde{\varphi}_{k}\right\|_{H^{1}}=o(1)$ as $k \rightarrow+\infty$ by (4.6). We therefore have $\varphi_{k}=\psi_{k}=\tilde{\varphi}_{k}$ in the end and by (4.2) $\varphi_{k}$ satisfies

Proposition 4.1 thus turns the weak $H^{1}$ control given by (4.14) into a highly accurate pointwise control. This example is intended as a toy model to match
the analysis developed in this paper. But the method described here is likely to generalize to more general bubbling configurations (with or without a weak limit), to more general potential than $c_{n} S_{g}+\varepsilon_{k} h$ and to sign-changing solutions, provided an analogue of Proposition 3.2 is available.

This approach can be seen as an alternative to the approach in Druet-HebeyRobert [10] to obtain pointwise blow-up estimates for solutions of critical elliptic equations. Here we reduce the problem to proving sharp pointwise estimates for solutions of a linear problem. And the precision of these linear estimates can be expected to only depend on the precision of the ansatz chosen for the bubbles (see the discussion surrounding (3.11)). This approach yields an improved precision for symmetry estimates in particular configurations (such as the one described in this paper) and could prove particularly useful in the compactness analysis of highly nonlinear problems, such as critical p-Laplace equations or critical anisotropic equations.

## 5. Expansion of the kernel coefficients and proof of Theorem

## 1.1

In this section we prove Theorem 1.1. Let $(M, g)$ be a locally conformally flat manifold. Let $k \geq 1$ be an integer, $\varepsilon_{1}$ be given by Proposition 4.1, $h \in C^{1}(M)$ and $\left(\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in S_{k}\right.$, where $S_{k}$ is as in (2.9). Throughout this section we will assume that

f(u)=\left(u_{+}\right)^{2^{*}-1} \quad \text { and } \quad \kappa_{i}=1 \quad \forall i \in\{1, \ldots, k\} .
$$

Let $\varphi_{\varepsilon}$ be the unique function given by Proposition4.1. Equation (4.4) together with (4.5) shows the existence of real numbers $\left(\nu_{i, j}\right), 1 \leq i \leq k$ and $0 \leq j \leq n$ such that

The $\nu_{i, j}$ are, by Proposition 4.1, continuous functions of $\left(\left(t_{1}, \xi_{1},\left(t_{i}, z_{i}\right)_{2 \leq i \leq k}\right) \in\right.$ $S_{k}$. They a priori all depend on each variable in $S_{k}$. This is a striking difference with the symmetric situation of Morabito-Pistoia-Vaira [26], where an inductive splitting of the remainder term led to a triangular dependency of the coefficients $\nu_{i, j}$. In the present work, we overcome the difficulties due to the non-symmetric background by using the sharp estimates on $\varphi_{\varepsilon}$ given by (4.5).

We perform an asymptotic expansion of the $\nu_{i, j}$ in (5.1). We state the $\ell=1$ and $\ell \geq 2$ case separately for clarity but the following two statements are proven together.

Proposition 5.1 (Case $\ell=1$ ). We have:

as $\varepsilon \rightarrow 0$. In these expressions $m\left(\xi_{1}\right)$ denotes the mass of the Green function at $\xi_{1}$ as defined in (2.1) and $D_{1}, D_{2}$ are positive constants that only depend on $n$. Also, $V_{j}$ is as in (2.17), and $\Lambda_{j, 1}$, for $0 \leq j \leq n$, denote continuous functions defined in $S_{k}$ which converge uniformly to 0 as $\varepsilon \rightarrow 0$.

Proposition 5.2 (Case $2 \leq \ell \leq k$ ). For any $2 \leq \ell \leq k$ we have

as $\varepsilon \rightarrow 0$, where $U_{0}$ is as in (2.16) and $\gamma_{\ell}$ is as in (2.7). Here $D_{3}$ is a positive constant, $D_{1}$ is the same as in Proposition 5.1 and $\Lambda_{j, \ell}$, for $0 \leq j \leq n$ denote functions defined in $S_{k}$ which converge uniformly to 0 as $\varepsilon \rightarrow 0$.

In view of Propositions 5.1 and 5.2 and of (2.8) we have to carry on the computations at the order $\varepsilon \mu_{1}^{2}$ and $\varepsilon \mu_{1}^{3}$ respectively for $\nu_{1,0}$ and $\nu_{1, j}, 1 \leq j \leq n$, and at the order $\varepsilon \mu_{\ell}^{2}$ and $\frac{\mu_{\ell}}{\mu_{\ell-1}} \varepsilon \mu_{\ell}^{2}=\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n}{2}}$ respectively for $\nu_{\ell, 0}$ and $\nu_{\ell, j}$, for $\ell \geq 2$ and $1 \leq j \leq n$. In the following we will let:

& -\left(2^{*}-1\right)\left[\left(\sum_{i=1}^{k} W_{i}\right)^{2^{*}-2}-W_{\ell}^{2^{*}-2}\right] \varphi_{\varepsilon} \\
& -\left[\left(\sum_{i=1}^{k} W_{i}+\varphi_{\varepsilon}\right)^{2^{*}-1}-\left(\sum_{i=1}^{k} W_{i}\right)^{2^{*}-1}-\left(2^{*}-1\right)\left(\sum_{i=1}^{k} W_{i}\right)^{2^{*}-2} \varphi_{\varepsilon}\right] \\
& =I_{1}+I_{2}+I_{3}+I_{4},
\end{align*}

where each term $I_{i}, 1 \leq i \leq 4$, is given by the $i$-th line in the right-hand side of (5.8). We first claim that the sole contribution to $\nu_{\ell, j}$ is given by $I_{1}$ :

\end{aligned}

Similarly, using again (2.19) and (4.5),

& =o\left(\varepsilon \mu_{\ell}^{2}\right)
\end{aligned}

where this last integral is zero when $\ell=1$, and

for all $1 \leq \ell \leq k$, where $\Theta_{\ell, j}$ is given by (5.3) and (5.4). Straightforward computations using (4.5) to estimate the integral over $B_{\ell} \backslash B_{\ell+1}$ and $M \backslash B_{\ell}$ similarly give

where it is intended that the term $W_{\ell-1}$ vanishes when $\ell=1$ and the term $W_{\ell+1}$ vanishes when $\ell=k$. So that

& =o\left(\Theta_{1, j}\right) .

& \quad=o\left(\Theta_{\ell, j}\right)
\end{align*}

again by (2.8). Estimates (5.16) and (5.17) together prove (5.15).
We now prove the following claim:

\frac{\mu_{\ell+1}}{\mu_{\ell}}=o\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right) .
$$

Independently, if $i \leq \ell-1$, we have

$$

with the convention that $W_{0}=0$. Using that $\left|Z_{\ell, 0}\right| \lesssim W_{\ell}$ and that $\left|Z_{\ell, j}\right| \lesssim$ $\mu_{\ell}^{\frac{n}{2}} \theta_{\ell}^{1-n}$ then gives that

& =o\left(\Theta_{\ell, 0}\right)
\end{aligned}
$$

and that

\begin{aligned}
\left|\int_{M \backslash B_{\ell}}\left[\left(\sum_{i=1}^{k} W_{i}\right)^{2^{*}-1}-\sum_{i=1}^{k} W_{i}^{2^{*}-1}\right] Z_{\ell, j} d v_{g}\right| & \lesssim \sum_{i=1}^{\ell-1}\left(\left(\frac{\mu_{\ell}}{\mu_{i}}\right)^{\frac{n+1}{2}}+\frac{\mu_{\ell}^{\frac{n}{2}}}{\mu_{i-1}^{\frac{n-2}{2}} \mu_{i}}\right) \\
& =o\left(\Theta_{\ell, j}\right),
\end{aligned}
$$

with the convention that the term $\left(\frac{\mu_{\ell}}{\mu_{i-1}}\right)^{\frac{n-2}{2}}$ vanishes if $i=1$. It therefore remains to estimate the integral over $B_{\ell} \backslash B_{\ell+1}$. Using (2.13) we can write that

\end{aligned} \right\rvert\,
$$

For the last line we wrote that

\left(\frac{\mu_{\ell+1}}{\mu_{\ell}}\right)^{\frac{n-2}{2}}=\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)^{\frac{n-2}{2}}\left(\frac{\mu_{\ell+1} \mu_{\ell-1}}{\mu_{\ell}^{2}}\right)^{\frac{n-2}{2}}=o\left(\Theta_{\ell, j}\right)
$$

and used (2.8), which shows that

\left(\frac{\mu_{\ell+1} \mu_{\ell-1}}{\mu_{\ell}^{2}}\right)^{\frac{n-2}{2}}=o\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right) .

We have thus proven that

\end{aligned}
$$

Let, for any $y \in B_{0}\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)$ and any $i \leq \ell-1$ :

\hat{W}_{i}(y)=\mu_{\ell}^{\frac{n-2}{2}} W_{i}\left(\exp _{\xi_{\ell}}^{g_{\xi_{\ell}}}\left(\mu_{\ell} y\right)\right)

As is easily checked, $V_{j}$ defined in (2.17) satisfies

Let $i \leq \ell-1$. Using (2.11), changing variables and integrating by parts we have

& =n \int_{B_{0}\left(\frac{\mu_{\ell-1}}{\mu_{\ell}}\right)} U_{0}^{2^{*}-1} \partial_{j} \hat{W}_{i} d y+o\left(\Theta_{\ell, j}\right)
\end{aligned}
$$

If $i \leq \ell-2$ we have, for any $y \in B_{0}\left(\frac{\mu_{\ell}}{\mu_{\ell-1}}\right)$,

where we have let

D_{3}=\int_{\mathbb{R}^{n}} U_{0}^{2^{*}-1} d y \tag{5.18}
\end{equation*}

It remains to notice that, by definition of $\xi_{\ell}$ in (2.10), we have

where $U_{0}$ is as in (2.16). This concludes the proof of Lemma 5.4 when $\ell \geq 2$.
It remains to prove the $\ell=1$ case. We have, with (2.13) and the convention that $W_{k+1}=0$ and $W_{0}=0$, that

& \lesssim \sum_{i \geq 2}\left(\frac{\mu_{i}^{\frac{n}{2}}}{\mu_{i-1} \mu_{1}^{\frac{n-2}{2}}}+\left(\frac{\mu_{i+1}}{\mu_{1}}\right)^{\frac{n-2}{2}}\right)+\left(\frac{\mu_{2}}{\mu_{1}}\right)^{\frac{n-2}{2}} \\
& =o\left(\Theta_{1, j}\right)
\end{aligned}
$$

for any $0 \leq j \leq n$, by (5.5). This concludes the proof of Lemma 5.4.
We are now in position to conclude the proof of Propositions 5.1 and 5.2. By Lemma 5.4 and (5.15) we only need to estimate the first term in the right-hand side of (5.15). We first treat the $j=0$ case. By definition of $W_{\ell}$ in (2.11) and $Z_{\ell, 0}$ in (2.15) it is easily seen that there holds

& =\frac{2}{n-2} \mu_{\ell} \frac{\partial}{\partial \mu_{\ell}}\left[\frac{1}{2} \int_{M}\left|\nabla W_{\ell}\right|^{2}+\left(c_{n} S_{g}+\varepsilon h\right) W_{\ell}^{2} d v_{g}-\frac{1}{2^{*}} \int_{M} W_{\ell}^{2^{*}} d v_{g}\right]  \tag{5.19}\\
& +o\left(\Theta_{\ell, 0}\right)
\end{align*}
$$

For any $\ell \geq 1$, The computations in Esposito-Pistoia-Vétois [12] (Lemma 4.1) show that

& =D_{1} \varepsilon h\left(\xi_{\ell}\right) \mu_{\ell}^{2}-D_{2} \mu_{\ell}^{n-2} m\left(\xi_{\ell}\right)+o\left(\varepsilon \mu_{\ell}^{2}\right)
\end{align*}
$$

for some positive constants $D_{1}$ and $D_{2}$, where $m\left(\xi_{\ell}\right)$ is the mass as defined in (2.1), and where the $o(\cdot)$ terms are $C^{1}$ with respect to $\mu_{\ell}$ and to $\xi_{\ell}$. Plugging (5.20) into (5.19) yields

& =\frac{4 D_{1}}{n-2} \varepsilon h\left(\xi_{\ell}\right) \mu_{\ell}^{2}-2 D_{2} \mu_{\ell}^{n-2} m\left(\xi_{\ell}\right)+o\left(\Theta_{\ell, 0}\right)
\end{align*}
$$

Assume now that $1 \leq j \leq n$. Lemmas 6.2 and 6.3 in [12] similarly show that

& =n \mu_{\ell} \frac{\partial}{\partial\left(\xi_{\ell}\right)_{j}}\left[\frac{1}{2} \int_{M}\left|\nabla W_{\ell}\right|^{2}+\left(c_{n} S_{g}+\varepsilon h\right) W_{\ell}^{2} d v_{g}-\frac{1}{2^{*}} \int_{M} W_{\ell}^{2^{*}} d v_{g}\right]+o\left(\Theta_{\ell, j}\right)
\end{aligned}
$$

With (5.20) this gives:

& \int_{B_{\ell}}\left[\left(\triangle_{g}+c_{n} S_{g}+\varepsilon h\right) W_{\ell}-W_{\ell}^{2^{*}-1}\right] Z_{\ell, j} d v_{g}  \tag{5.22}\\
& =n D_{1} \varepsilon \nabla_{j} h\left(\xi_{\ell}\right) \mu_{\ell}^{3}-n D_{2} \mu_{\ell}^{n-1} \nabla_{j} m\left(\xi_{\ell}\right)+o\left(\Theta_{\ell, j}\right) \\
& =o\left(\Theta_{\ell, j}\right)
\end{align*}
$$

Coming back to (5.8) and using Lemma 5.3, (5.15), Lemma 5.4, (5.21) and (5.22) concludes the proof of Propositions 5.1 and 5.2 ,

We now conclude the proof of Theorem 1.1.
End of the proof of Theorem 1.1. Recall that $(M, g)$ is a locally conformally flat manifold of dimension $n \geq 7$. Define a function $F: S_{k} \rightarrow \mathbb{R}^{k(1+n)}$ by:

\left(n D_{1} t_{1}^{3} \nabla_{j} h\left(\xi_{1}\right)-n D_{2} t_{1}^{n-1} \nabla_{j} m\left(\xi_{1}\right)\right)_{1 \leq j \leq n} \\
\binom{\frac{4 D_{1}}{n-2} h\left(\xi_{1}\right) t_{\ell}^{2}-D_{3}\left(\frac{t_{\ell}}{t_{\ell-1}}\right)^{\frac{n-2}{2}} U_{0}\left(z_{\ell}\right)}{-n D_{3}\left(\frac{t_{\ell}}{t_{\ell-1}}\right)^{\frac{n}{2}} \partial_{j} U_{0}\left(z_{\ell}\right)}_{2 \leq \ell \leq k, 1 \leq j \leq n}
\end{array}\right\}
$$

where $S_{k}$ is as in (2.9). Assume that $(M, g)$ is not conformally diffeomorphic to the standard sphere and let $\xi_{0}$ be a critical point of the mass function $\xi \mapsto m(\xi)>0$. Choose now $h \in C^{1}(M)$ such that $h\left(\xi_{0}\right)=1$ and $\nabla h\left(\xi_{0}\right)=0$ and let

Assume also that $h$ is chosen so that $\xi_{0}$ has non-zero degree as a zero of

$$

These conditions are obviously met if $h \equiv 1$ and $\xi_{0}$ is a non-degenerate critical point of the mass function $\xi \mapsto m(\xi)$. Let finally, for $2 \leq \ell \leq k$,

It is then easily seen that $\left(t_{1,0}, \xi_{0},\left(t_{\ell, 0}, 0\right)_{2 \leq \ell \leq k}\right)$ is a zero of $F$ with non-zero degree. In particular, for any $\varepsilon$ small enough, by Propositions 5.1 and 5.2, there exists $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{\ell, \varepsilon}, z_{\ell, \varepsilon}\right)_{2 \leq \ell \leq k}\right) \in S_{k}$ that annihilates the $\nu_{i, j}$ defined
in (5.1). Denote by $\mu_{\ell, \varepsilon}$ and $\xi_{\ell, \varepsilon}, 1 \leq \ell \leq k$, the parameters associated to $\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{\ell, \varepsilon}, z_{\ell, \varepsilon}\right)_{2 \leq \ell \leq k}\right) \in S_{k}$ as in (2.7) and (2.10). By (5.1), the function

& =\sum_{i=1}^{k} W_{\mu_{\ell}, \xi_{\ell}}+\varphi_{\varepsilon}\left(\left(t_{1, \varepsilon}, \xi_{1, \varepsilon},\left(t_{\ell, \varepsilon}, z_{\ell, \varepsilon}\right)_{2 \leq \ell \leq k}\right)\right.
\end{aligned}
$$

solves (1.3). By the pointwise estimates on $\varphi_{\varepsilon}$ given by Proposition 4.1 it is easily seen that $u_{\varepsilon}$ blows-up with $k$ towering bubbles around $\xi_{0}$. This concludes the proof of Theorem 1.1.

## 6. Sign-Changing bubble towers for the Brézis-Nirenberg PROBLEM

We prove in this section Theorem 1.2, Let us consider the Brezis-Nirenberg problem

$$
\begin{equation*}
\triangle_{\xi} u-\varepsilon u=|u|^{\frac{4}{n-2}} u \text { in } \Omega, u=0 \text { on } \partial \Omega, \tag{6.1}
\end{equation*}
$$

where $\Omega$ is a bounded open domain in $\mathbb{R}^{n}, n \geq 7, \triangle_{\xi}=-\sum_{i=1}^{n} \partial_{i}^{2}$ and $\varepsilon$ is a positive small parameter. For $\mu>0$ and $\xi \in \Omega$ we introduce the standard bubble

$$
\begin{equation*}
U_{\mu, \xi}(x):=\mu^{-\frac{n-2}{2}} U_{0}\left(\frac{x-\xi}{\mu}\right) \tag{6.2}
\end{equation*}
$$

where $U_{0}$ is given by (2.16), and its projection $P_{\Omega} U_{\mu, \xi}$ on the space $H_{0}^{1}(\Omega)$, i.e. the solution to the Dirichlet boundary problem

$$
\triangle_{\xi} P_{\Omega} U_{\mu, \xi}=\triangle_{\xi} U_{\mu, \xi} \text { in } \Omega, P_{\Omega} U_{\mu, \xi}=0 \text { on } \partial \Omega
$$

It is well known that (see e.g. Proposition 1 in Rey [33]) that

P_{\Omega} U_{\mu, \xi}(x)=U_{\mu, \xi}(x)-c_{n} \mu^{\frac{n-2}{2}} H(x, \xi)+O\left(\mu^{\frac{n+2}{2}}\right) \tag{6.3}
\end{equation*}
$$

with $c_{n}:=(n(n-2))^{\frac{n-2}{2}} \omega_{n-1}$, and that this expansion holds true uniformly with respect to $x \in \bar{\Omega}$ and $\xi$ in compact sets of $\Omega$. Here $H(\cdot, \xi)$ is the regular part of the Green function $G$ of $\triangle_{\xi}$ in $\Omega$ with Dirichlet boundary condition, defined by

G(x, y)=\frac{1}{(n-2) \omega_{n-1}}|x-y|^{2-n}-H(x, y) \quad \forall x \neq y \in \Omega \tag{6.4}
\end{equation*}
$$

For an integer $k \geq 1$, we look for a sign-changing solution to (6.1) having the following form:

\end{equation*}

where the concentration parameters satisfy

\mu_{\ell}=t_{\ell} \epsilon^{\gamma_{\ell}} \text { for } t_{\ell}>0 \text { and } \gamma_{\ell}=\frac{n-2}{2(n-4)}\left(\frac{n-2}{n-6}\right)^{\ell-1}-\frac{1}{2} \tag{6.6}
\end{equation*}
$$

and the concentration points are given by

\begin{equation*}
\xi_{1} \in \Omega \text { and } \xi_{\ell}=\xi_{\ell-1}+\mu_{\ell-1} z_{\ell} \text { with } z_{\ell} \in \mathbb{R}^{n}, \text { for any } 2 \leq \ell \leq k \tag{6.7}
\end{equation*}
$$

All the arguments developed in the proof of Theorem 1.1 adapt straightforwardly in this setting with

- the bubbles $W_{\ell}$ replaced by the bubbles $P_{\Omega} U_{\mu_{\ell}, \xi_{\xi}}$,
- the elements $Z_{\ell, j}$ in (2.15) replaced by

$$
Z_{\Omega, \ell, j}:=P_{\Omega}\left(\mu_{\ell}^{-\frac{n-2}{2}} V_{j}\left(\frac{x-\xi_{\ell}}{\mu_{\ell}}\right)\right)
$$

where $V_{j}$ is defined in (2.17), and $K_{k}$ in (2.23) is replaced by

K_{\Omega, k}=\operatorname{Span}\left\{Z_{\Omega, \ell, j}, 1 \leq \ell \leq k, 0 \leq j \leq n\right\}
$$

- and the configuration space $S_{k}$ defined in (2.9) replaced by the set

$$
S_{\Omega, k}=\left\{\left(\xi, z_{2}, \ldots, z_{k}, t_{1}, \ldots, t_{k}\right): d(\xi, \partial \Omega) \geq d,\left|z_{\ell}\right| \leq 1, A^{-1} \leq t_{\ell} \leq A\right\}
$$

for some fixed constants $d>0$ and $A>1$.
More precisely, let for $\left(\xi, z_{2}, \ldots, z_{k}, t_{1}, \ldots, t_{k}\right) \in S_{\Omega}$ and for $x \in \Omega$ :

- $\Psi_{\Omega, \varepsilon}(x)=\mu_{\ell-1}^{1-\frac{n}{2}}\left(\frac{\mu_{\ell}}{\mu_{\ell}+\left|x-\xi_{\ell}\right|}\right)^{2}+\varepsilon \mu_{\ell-1}^{3-\frac{n}{2}}$

$$

A careful inspection of the proofs of Proposition 3.2 and Proposition 4.1 shows that the analysis carries on here (since the points $\xi_{1}, \ldots, \xi_{\ell}$ live in compact sets in the interior) and yields the following result:

that both belongs to $K_{\Omega, k}^{\perp}$ and satisfies $\left|\varphi_{\varepsilon}\right| \leq C \Psi_{\Omega, \varepsilon}$. In addition,

Proof of Theorem 1.2. With Proposition 6.2 the end of the proof of Theorem 1.2 follows the same lines than the one of Theorem 1.1. Let $\xi_{0}$ be a nondegenerate interior critical point of the Robin's function $\xi \mapsto H(\xi, \xi)$. Let

The Robin's function $\xi \mapsto H(\xi, \xi)$ always admits an interior critical point since $H$ is positive and $H(\xi, \xi) \rightarrow+\infty$ as $\xi \rightarrow \partial \Omega$. And for generic domains $\Omega$, all the critical points of the Robin's function are non-degenerate as proved in Micheletti-Pistoia [25]. Finally, here again, if one considers more general equations of the form

Proposition 6.1 remains indeed true and the details are identical to those developed at the very end of Section 5.

& \lesssim \mu_{j}^{\frac{n-2}{2}} \mu_{i}^{2-n} \int_{\mathbb{R}^{n} \backslash B_{0}\left(\frac{1}{2} \sqrt{\frac{\omega_{i+1}}{\mu_{i}}}\right)}(1+|\check{\xi}-y|)^{-4}|y|^{2-n}|\check{x}-y|^{2-n} d y \tag{A.3}
\end{align*}
$$

where we have let $\check{\xi}=\frac{1}{\mu_{i}}\left(\exp _{\xi_{j}}^{g_{\xi_{j}}}\right)^{-1}\left(\xi_{i}\right)$ and $\check{x}=\frac{1}{\mu_{i}}\left(\exp _{\xi_{j}}^{g_{\xi_{j}}}\right)^{-1}(x)$. Since $x \notin B_{i+1}$ we have $\theta_{j}(x) \gtrsim \sqrt{\mu_{i+1} \mu_{i}}$ and thus $|\check{x}| \gtrsim \frac{\theta_{j}(x)}{\mu_{i}}$. Assume first that $|\check{x}| \gtrsim 1$. Then we also have $\theta_{j}(x) \gtrsim \theta_{i}(x)$, so that classical integral comparison results yield

$$
\int_{B_{i} \backslash B_{i+1}} W_{i}^{2^{*}-2} W_{j} d_{g}(x, \cdot)^{2-n} d v_{g} \lesssim \mu_{j}^{\frac{n-2}{2}} \mu_{i}^{2-n}(1+|\check{x}|)^{2-n} \lesssim\left(\frac{\mu_{j}}{\mu_{i}}\right)^{\frac{n-2}{2}} W_{i}(x)
$$

Assume finally that $|\check{x}| \lesssim 1$. A standard Giraud-type argument (see e.g. lemma 7.5 in Hebey [13]) yields with (A.3)

$$
\begin{aligned}
\int_{B_{i} \backslash B_{i+1}} W_{i}^{2^{*}-2} W_{j} d_{g}(x, \cdot)^{2-n} d v_{g} & \lesssim \mu_{j}^{\frac{n-2}{2}} \mu_{i}^{2-n}|\check{x}|^{4-n} \\
& \lesssim \frac{\theta_{j}(x)^{2}}{\mu_{i}^{2}} W_{j}(x)
\end{aligned}
$$

which concludes the proof of (A.2).
