# Discrete Fourier transforms, quantum $6 j$-symbols and deeply truncated tetrahedra

#### Abstract

The asymptotic behavior of quantum $6 j$-symbols is closely related to the volume of truncated hyperideal tetrahedra [8], and plays a central role in understanding the asymptotics of the TuraevViro invariants of 3-manifolds. In this paper, we propose a conjecture relating the asymptotics of the discrete Fourier transforms of quantum $6 j$-symbols on one hand, and the volume of deeply truncated tetrahedra of various types on the other. As supporting evidence, we prove the conjecture in the case that the dihedral angles are sufficiently small, and provide numerical calculations in the case that the dihedral angles are relatively big. A key observation is a relationship between quantum $6 j$-symbols and the co-volume function of deeply truncated tetrahedra, which is of interest in its own right and has important applications [34 35]. More ambitiously, we extend the conjecture to the discrete Fourier transforms of the Yokota invariants of planar graphs and volume of deeply truncated polyhedra, and provide supporting evidence.


## 1 Introduction

Quantum $6 j$-symbols are the main building blocks of the Turaev-Viro invariants of 3-manifolds [30]; the asymptotic behavior of the former plays a central role in understanding the asymptotics of the latter [7, 2, 3]. In [8], it is proved that the exponential growth rate of the quantum $6 j$-symbols is closely related to the volume of truncated hyperideal tetrahedra. In this paper, we aim to study the discrete Fourier transforms of quantum $6 j$-symbols and the relationship between their asymptotic behavior and the volume of deeply truncated tetrahedra of various types.

To be precise, let $(I, J)$ be a partition of $\{1, \ldots, 6\}$, and let $\Delta$ be a deeply truncated tetrahedron of type $(I, J)$, ie., $\left\{e_{i}\right\}_{i \in I}$ is the set of edges of deep truncation. (See Section 2.1 for more details.)

For a 6 -tuple $\left(b_{I}, a_{J}\right)=\left(\left(b_{i}\right)_{i \in I},\left(a_{j}\right)_{j \in J}\right)$ of integers in $\{0, \ldots, r-2\}$, let $\hat{Y}_{r}\left(b_{I} ; a_{J}\right)$ be the discrete Fourier transform of the Yokota invariant of the trivalent graph $\bigotimes$ with respect to $\left(b_{I}, a_{J}\right)$, ie.,

\widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)=\sum_{\left(a_{i}\right)_{i \in I}} \prod_{i \in I} \mathrm{H}\left(a_{i}, b_{i}\right)\left|\begin{array}{lll}

a_{4} & a_{5} & a_{6}
\end{array}\right|^{2}
$$

where the sum is over all multi-integers $\left(a_{i}\right)_{i \in I}$ in $\{0, \ldots, r-2\}$ so that the triples $\left(a_{1}, a_{2}, a_{3}\right),\left(a_{1}, a_{5}, a_{6}\right)$, $\left(a_{2}, a_{4}, a_{6}\right)$ and ( $\left.a_{3}, a_{4}, a_{5}\right)$ are $r$-admissible,

\mathrm{H}\left(a_{i}, b_{i}\right)=(-1)^{a_{i}+b_{i}} \frac{q^{\left(a_{i}+1\right)\left(b_{i}+1\right)}-q^{-\left(a_{i}+1\right)\left(b_{i}+1\right)}}{q-q^{-1}},
$$

and $\left|\begin{array}{lll}a_{1} & a_{2} & a_{3} \\ a_{4} & a_{5} & a_{6}\end{array}\right|$ is the quantum $6 j$-symbol of the 6 -tuple $\left(a_{1}, \ldots, a_{6}\right)$. (See Sections 2.3 . 2.4 and 2.5 for more details.)

Conjecture 1.1. Suppose $\Delta\left(\theta_{I} ; \theta_{J}\right)$ is a deeply truncated tetrahedron of type $(I, J)$ with $\theta_{I}=\left\{\theta_{i}\right\}_{i \in I}$ the set of dihedral angles at the edges of deep truncation and $\theta_{J}=\left\{\theta_{j}\right\}_{j \in J}$ the set of dihedral angles at the regular edges. Let $\left\{\left(b_{I}^{(r)}, a_{J}^{(r)}\right)\right\}$ be a sequence of 6-tuples with

\theta_{i}=\left|\pi-\lim _{r \rightarrow \infty} \frac{2 \pi b_{i}^{(r)}}{r}\right|
$$

for $i \in I$, and

$$
\theta_{j}=\left|\pi-\lim _{r \rightarrow \infty} \frac{2 \pi a_{j}^{(r)}}{r}\right|
$$

for $j \in J$. Then evaluated at the root of unity $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$ and as $r$ varies over all positive odd integers,

\lim _{r \rightarrow \infty} \frac{2 \pi}{r} \log \widehat{\mathrm{Y}}_{r}\left(b_{I}^{(r)} ; a_{J}^{(r)}\right)=2 \operatorname{Vol}\left(\Delta\left(\theta_{\mathrm{I}} ; \theta_{\mathrm{J}}\right)\right)
$$

As a convincing supporting evidence, we prove the following main result of this paper.
Theorem 1.2. For any $(I, J)$, there exists an $\epsilon>0$ such that if all the dihedral angles of $\Delta\left(\theta_{I} ; \theta_{J}\right)$ are less than $\epsilon$, then Conjecture 1.1 is true.

Furthermore, we provide additional numerical evidence for Conjecture 1.1 with relatively big dihedral angles in Section6

An analogous Volume Conjecture for deeply truncated tetrahedra with one edge of deep truncation was suggested (and has been verified numerically in a handful of cases) in [19, Section 5, Conjecture 3]. Notice however that the quantities inside the logarithm in Conjecture 1.1 and in [19], albeit similarlooking, are different.

We also propose a more ambitious conjecture for the discrete Fourier transforms of the Yokota invariants of planar graphs which are the 1 -skeleton of deeply truncated polyhedra. (See Sections 2.2, 2.4 and 2.5 for more details.)

Conjecture 1.3. Let $\Gamma \subset S^{3}$ be a planar graph and let $P$ be a deeply truncated polyhedron with 1skeleton $\Gamma$. Let $\left\{\theta_{i}\right\}_{i \in I}$ be the angles at the edges of deep truncation and let $\left\{\theta_{j}\right\}_{j \in J}$ be the dihedral angles of $P$ at the regular edges. Let $\left\{\left(b_{I}^{(r)}, a_{J}^{(r)}\right)\right\}$ be a sequence of colorings of $\Gamma$ such that

\theta_{i}=\left|\pi-\lim _{r \rightarrow \infty} \frac{2 \pi b_{i}^{(r)}}{r}\right|
$$

for $i \in I$ and

$$
\theta_{j}=\left|\pi-\lim _{r \rightarrow \infty} \frac{2 \pi a_{j}^{(r)}}{r}\right|
$$

for $j \in J$, and let $\widehat{\mathrm{Y}}_{r}\left(\Gamma, b_{I}^{(r)} ; a_{J}^{(r)}\right)$ be the discrete Fourier transform of the Yokota invariant of $\Gamma$ with respect to $\left(b_{I}^{(r)}, a_{J}^{(r)}\right)$. Then as $r$ varies over all positive odd integers,

\lim _{r \rightarrow \infty} \frac{2 \pi}{r} \log \widehat{\mathrm{Y}}_{r}\left(\Gamma, b_{I}^{(r)} ; a_{J}^{(r)}\right)=2 \operatorname{Vol}(\mathrm{P})
$$

Remark 1.4. By using the same techniques as in the proof of Theorem 1.2, one can prove that Conjecture 1.3 is true for all the graphs obtained from $Q$ by doing a sequence of the following triangle moves $\lambda \rightarrow$ A and with sufficiently small dihedral angles, providing supporting evidences to Conjecture 1.3 .

Outline of the proof of Theorem 1.2. We follow the guideline of Ohtsuki's method. In Proposition 4.1, we compute the discrete Fourier transform of the Yokota invariants of the graph $Q^{\text {, writing them as a }}$ sum of values of a holomorphic function $f_{r}$ at integer points. The function $f_{r}$ comes from Faddeev's quantum dilogarithm function. Using Poisson Summation Formula, we in Proposition 4.3 write the invariants as a sum of the Fourier transforms of $f_{r}$ computed in Propositions 4.2. In Proposition 5.2 we show that the critical value of the functions in the leading Fourier transforms has real part the volume of the deeply truncated tetrahedron. The key observation is Theorem 3.5 relating the asymptotics of quantum $6 j$-symbols with the co-volume function of deeply truncated tetrahedra, which is of interest in its own right. Then we estimate the leading Fourier transforms in Sections 5.3 using the Saddle Point Method (Proposition 5.1). Finally, we estimate the non-leading Fourier transforms and the error term respectively in Sections 5.4 and 5.5 showing that they are neglectable, and prove Theorem 1.2 in Section 5.6. We discuss the result in as general a case as possible, and only in the last section we use the assumption that the dihedral angles are sufficiently small.

## 2 Preliminaries

### 2.1 Deeply truncated tetrahedron and co-volume function

Definition 2.1. A deeply truncated tetrahedron is a compact hyperbolic polyhedron with faces $H_{1}, H_{2}$, $H_{3}, H_{4}, T_{1}, T_{2}, T_{3}$, and $T_{4}$ such that
(1) For each $i \in\{1,2,3,4\}, T_{i} \cap H_{i}=\emptyset$.
(2) For each $\{i, j\} \subset\{1,2,3,4\}, T_{i} \cap H_{j} \neq \emptyset$, and the dihedral angle between them is always $\frac{\pi}{2}$.
(3) For each $\{i, j\} \subset\{1,2,3,4\}$, either $T_{i} \cap T_{j} \neq \emptyset$ or $H_{i} \cap H_{j} \neq \emptyset$, but not both.

From the definition, we see that each face $H_{i}$ or $T_{i}$ is one of the following four types: (1) a hyperbolic triangle, (2) a hyperbolic quadrilateral with two right angles, (3) a hyperbolic pentagon with four right angles and (4) a hyperbolic hexagon with six right angles.

We only consider the intersection of $H_{i}$ and $H_{j}$ or the intersection of $T_{i}$ and $T_{j}$ as the edge of the deeply truncated tetrahedron; therefore there are in total six edges. We call an edge between $H_{i}$ an $H_{j}$ a regular edge and an edge between $T_{i}$ and $T_{j}$ an edge of deep truncation.

A truncated hyperideal tetrahedron is one example of deeply truncated tetrahedra, where the $H_{i}$ 's are the hexagonal faces, and $T_{i}$ 's are the triangles from truncations (see Figure 11. For a truncated hyperideal tetrahedron, there are six regular edges and no edge of deep truncation. The name "edge of deep truncation" comes from the idea that if the truncations are "deep" enough, then two triangles $T_{i}$ and $T_{j}$ coming from truncations may intersect. That is also why the tetrahedron is called "deeply truncated". Deeply truncated tetrahedra were first studied by Kolpakov and Murakami in [18].

Let $(I, J)$ be a partition of $\{1, \ldots, 6\}$. A deeply truncated tetrahedron $\Delta$ is of type $(I, J)$ if $\left\{e_{i}\right\}_{i \in I}$ is the set of edges of deep truncation. Up to permutation of indices and interchange the role of $H_{i}$ 's and $T_{i}$ 's, all the types of deeply truncated tetrahedra besides the truncated hyperideal tetrahedron are listed in Figure 2 .

Let $\Delta=\Delta\left(\theta_{I}, \theta_{J}\right)$ be the deeply truncated tetrahedron of type $(I, J)$; let $\{\theta\}_{i \in I}$ be the dihedral angles at the edges of deep truncation and let $\left\{\theta_{j}\right\}_{j \in J}$ be the dihedral angles at the regular edges. Let

$\left\{l_{i}\right\}_{i \in I}$ be the lengths of the edges of deep truncation. Let $c_{i}=\cosh l_{i}$ for $i \in I$, and let $c_{j}=\cos \theta_{j}$ for $j \in J$. If without loss of generality we assume that $1 \in I$, then by the hyperbolic cosine law of polygons of various types (see [14, Appendix A]) and a direct computation, we have

\cos \theta_{1}=\frac{c_{4}+c_{2} c_{6}+c_{3} c_{5}+\left(c_{2} c_{5}+c_{3} c_{6}\right) c_{1}-c_{4} c_{1}^{2}}{\sqrt{-1+c_{1}^{2}+c_{2}^{2}+c_{3}^{2}+2 c_{1} c_{2} c_{3}} \sqrt{-1+c_{1}^{2}+c_{5}^{2}+c_{6}^{2}+2 c_{1} c_{5} c_{6}}} . \tag{2.1}
\end{equation*}
$$

If we consider the following Gram matrix

$$
G=\left[\begin{array}{cccc}
1 & -c_{1} & -c_{2} & -c_{6} \\
-c_{1} & 1 & -c_{3} & -c_{5} \\
-c_{2} & -c_{3} & 1 & -c_{4} \\
-c_{6} & -c_{5} & -c_{4} & 1
\end{array}\right],
$$

then (2.1) can be written as

\cos \theta_{1}=\frac{G_{34}}{\sqrt{G_{33} G_{44}}} \tag{2.2}
\end{equation*}

A deeply truncated tetrahedron $\Delta$ of type $(I, J)$ is up to isometry determined by $\left\{l_{i}\right\}_{i \in I}$ and $\left\{\theta_{j}\right\}_{j \in J}$. In particular, if we fix $\left\{\theta_{j}\right\}_{j \in J}$, then the dihedral angles $\left\{\theta_{i}\right\}_{i \in I}$ at the edges of deep truncation are functions of $\left\{l_{i}\right\}_{i \in I}$ and as a consequence the volume of $\Delta$ is a function of $\left\{l_{i}\right\}_{i \in I}$.

Definition 2.2 ([22, 23]|). For a fixed $\left\{\theta_{j}\right\}_{j \in J}$, let Vol and $\left\{\theta_{i}\right\}_{i \in I}$ respectively be the volume of $\Delta$ and the dihedral angles at the edges of deep truncation as functions of $l_{I}=\left(l_{i}\right)_{i \in I}$, and consider the following co-volume function $\operatorname{Cov}$ defined by

\operatorname{Cov}\left(l_{I}\right)=\mathrm{Vol}+\frac{1}{2} \sum_{i \in I} \theta_{i} \cdot l_{i} .
$$

The key property of the co-volume function is the following
Lemma 2.3. For $i \in I$,

$$
\frac{\partial \mathrm{Cov}}{\partial l_{i}}=\frac{\theta_{i}}{2} .
$$

Proof. By the Schläfli formula, we have

\frac{\partial \mathrm{Vol}}{\partial \theta_{i}}=-\frac{l_{i}}{2}
$$

Then by the chain rule and the product rule, we have

$$
\begin{aligned}
\frac{\partial \mathrm{Cov}}{\partial l_{i}} & =\sum_{k \in I} \frac{\partial \mathrm{Vol}}{\partial \theta_{k}} \cdot \frac{\partial \theta_{k}}{\partial l_{i}}+\frac{1}{2} \sum_{k \in I} \frac{\partial}{\partial l_{i}}\left(\theta_{k} \cdot l_{k}\right) \\
& =-\sum_{k \in I} \frac{l_{k}}{2} \cdot \frac{\partial \theta_{k}}{\partial l_{i}}+\frac{1}{2} \sum_{k \in I} \cdot \frac{\partial \theta_{k}}{\partial l_{i}} \cdot l_{k}+\frac{\theta_{i}}{2}=\frac{\theta_{i}}{2} .
\end{aligned}
$$

Finally we include a sufficient condition to determine whether a deeply truncated tetrahedron with specified parameters exists.

Proposition 2.4. Let $(I, J)$ be a partition of $\{1, \ldots, 6\},\left\{l_{i}\right\}_{i \in I}$ be positive real numbers and $\left\{\theta_{j}\right\}_{j \in J}$ be real numbers in $[0, \pi]$. Let $c_{i}=\cosh l_{i}$ for $i \in I$ and $c_{j}=\cos \theta_{j}$ for $j \in J$, and let

G=\left[\begin{array}{cccc}
1 & -c_{1} & -c_{2} & -c_{6} \\
-c_{1} & 1 & -c_{3} & -c_{5} \\
-c_{2} & -c_{3} & 1 & -c_{4} \\
-c_{6} & -c_{5} & -c_{4} & 1
\end{array}\right]
$$

be the Gram matrix defined as above. If
(1) $\operatorname{Sign}(G)=(3,1)$,
(2) $G_{s t}>0$ for $s \neq t$ and
(3) $G_{s s}<0$,
then there exists a deeply truncated tetrahedron of type $(I, J)$ with lengths $\left\{l_{i}\right\}_{i \in I}$ of the edges of deep truncation and dihedral angles $\left\{\theta_{j}\right\}_{j \in J}$ at the regular edges.

Proof. The first part of the proof in [31, Theorem 3.2] works verbatim in the case of deeply truncated tetrahedra. Notice that we require that a deeply truncated tetrahedron has hyperideal vertices, while [Ushijima, Theorem 3.2] does not; this accounts for the extra condition (3) (see [31, Remark 3 after Theorem 3.2]).

Remark 2.5. The conditions in [31, Theorem 3.2] are necessary and sufficient. However, if the pair $(s, t)$ gives entry of the Gram matrix corresponding to an edge of deep truncation, then the condition $G_{s t}>0$ would imply that the dihedral angle at this edge is less than $\frac{\pi}{2}$, which is not always the case. Hence the conditions in Proposition 2.4 are not necessary in general.

### 2.2 Deeply truncated polyhedra

We extend the definition of a deeply truncated tetrahedron to polyhedra of any combinatorial type, which are the objects involved in Conjecture 1.3.

Let $\Gamma \subset S^{3}$ be a polyhedral graph (that is, a graph that is the 1 -skeleton of a polyhedron), and let $V$ be its set of vertices and $F$ its set of faces.

Definition 2.6. A deeply truncated polyhedron with 1 -skeleton $\Gamma$ is a compact hyperbolic polyhedron $P \subset \mathbb{H}^{3}$ with faces $\left\{T_{v}\right\}_{v \in V} \cup\left\{H_{f}\right\}_{f \in F}$ such that:
(1) $T_{v} \cap H_{f} \neq \varnothing$ if and only if $v \in f$,
(2) if $T_{v} \cap H_{f} \neq \varnothing$, then they intersect at a right angle, and
(3) for every edge e of $\Gamma$ with endpoints $v_{1}, v_{2}$ and adjacent to faces $f_{1}, f_{2}$, exactly one of $T_{v_{1}} \cap T_{v_{2}}$ and $H_{f_{1}} \cap H_{f_{2}}$ is non-empty.

The edge e of $\Gamma$ is a regular edge if $H_{f_{1}} \cap H_{f_{2}} \neq \varnothing$; otherwise it is an edge of deep truncation. In either case, the dihedral angle of $P$ at $e$ is the angle between the two intersecting faces.

Remark 2.7. Notice that $P$ by itself is simply a compact hyperbolic polyhedron; to obtain a deeply truncated polyhedron with 1 -skeleton $\Gamma$ we need the additional information of the partition of its faces according to vertices and faces of $\Gamma$. In particular, $P$ as a simplicial complex in $\mathbb{H}^{3}$ does not have 1skeleton $\Gamma$; by definition $\Gamma$ is the 1 -skeleton of $P$ with the additional information.

Example 2.8. A truncated hyperideal polyhedron $P$ with 1-skeleton $\Gamma$ [5] is a deeply truncated polyhedron with 1-skeleton $\Gamma$. The faces of $P$ give the set $H_{F}$ while the faces dual to the vertices of $P$ give the set $T_{V}$. In this case all edges are regular.
Remark 2.9. The statement of Proposition 2.3 is true for deeply truncated polyhedra as well; the same proof applies verbatim.

### 2.3 Quantum 6j-symbols

Let $r$ be an odd integer and $q$ be an $r$-th root of unity. For the context of this paper we are only interested in the case $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$, but the definitions and results in this section work with any choice of $q$.

As is customary we define $[n]=\frac{q^{n}-q^{-n}}{q-q^{-1}},\{n\}=q^{n}-q^{-n}$ and the quantum factorial

[n]!=\prod_{k=1}^{n}[k]
$$

A triple $\left(a_{1}, a_{2}, a_{3}\right)$ of integers in $\{0, \ldots, r-2\}$ is $r$-admissible if
(1) $a_{i}+a_{j}-a_{k} \geqslant 0$ for $\{i, j, k\}=\{1,2,3\}$.
(2) $a_{1}+a_{2}+a_{3} \leqslant 2(r-2)$,
(3) $a_{1}+a_{2}+a_{3}$ is even.

For an $r$-admissible triple $\left(a_{1}, a_{2}, a_{3}\right)$, define

$$
\Delta\left(a_{1}, a_{2}, a_{3}\right)=\sqrt{\frac{\left[\frac{a_{1}+a_{2}-a_{3}}{2}\right]!\left[\frac{a_{2}+a_{3}-a_{1}}{2}\right]!\left[\frac{a_{3}+a_{1}-a_{2}}{2}\right]!}{\left[\frac{a_{1}+a_{2}+a_{3}}{2}+1\right]!}}
$$

with the convention that $\sqrt{x}=\sqrt{|x|} \sqrt{-1}$ when the real number $x$ is negative.
A 6-tuple $\left(a_{1}, \ldots, a_{6}\right)$ is $r$-admissible if the triples $\left(a_{1}, a_{2}, a_{3}\right),\left(a_{1}, a_{5}, a_{6}\right),\left(a_{2}, a_{4}, a_{6}\right)$ and $\left(a_{3}, a_{4}, a_{5}\right)$ are $r$-admissible.

Definition 2.10. The quantum $6 j$-symbol of an r-admissible 6 -tuple $\left(a_{1}, \ldots, a_{6}\right)$ is

\begin{aligned}
\left|\begin{array}{lll}
a_{1} & a_{2} & a_{3} \\
a_{4} & a_{5} & a_{6}
\end{array}\right|= & {\sqrt{-1}-\sum_{i=1}^{6} a_{i} \Delta\left(a_{1}, a_{2}, a_{3}\right) \Delta\left(a_{1}, a_{5}, a_{6}\right) \Delta\left(a_{2}, a_{4}, a_{6}\right) \Delta\left(a_{3}, a_{4}, a_{5}\right)} \begin{aligned}
& {\min \left\{Q_{1}, Q_{2}, Q_{3}\right\}} \sum^{k=\max \left\{T_{1}, T_{2}, T_{3}, T_{4}\right\}} \frac{(-1)^{k}[k+1]!}{\left[k-T_{1}\right]!\left[k-T_{2}\right]!\left[k-T_{3}\right]!\left[k-T_{4}\right]!\left[Q_{1}-k\right]!\left[Q_{2}-k\right]!\left[Q_{3}-k\right]!}
\end{aligned},
\end{aligned}

where $T_{1}=\frac{a_{1}+a_{2}+a_{3}}{2}, T_{2}=\frac{a_{1}+a_{5}+a_{6}}{2}, T_{3}=\frac{a_{2}+a_{4}+a_{6}}{2}$ and $T_{4}=\frac{a_{3}+a_{4}+a_{5}}{2}, Q_{1}=\frac{a_{1}+a_{2}+a_{4}+a_{5}}{2}$, $Q_{2}=\frac{a_{1}+a_{3}+a_{4}+a_{6}}{2}$ and $Q_{3}=\frac{a_{2}+a_{3}+a_{5}+a_{6}}{2}$.

Closely related, a triple $\left(\alpha_{1}, \alpha_{2}, \alpha_{3}\right) \in[0,2 \pi]^{3}$ is admissible if
(1) $\alpha_{i}+\alpha_{j}-\alpha_{k} \geqslant 0$ for $\{i, j, k\}=\{1,2,3\}$,
(2) $\alpha_{i}+\alpha_{j}+\alpha_{k} \leqslant 4 \pi$.

A 6 -tuple $\left(\alpha_{1}, \ldots, \alpha_{6}\right) \in[0,2 \pi]^{6}$ is admissible if the triples $\{1,2,3\},\{1,5,6\},\{2,4,6\}$ and $\{3,4,5\}$ are admissible.


Figure 3: Desingularization in a neigborhood of a vertex of valence 6

### 2.4 The Yokota invariant

In this section we recall the definition of the Yokota invariant, first introduced in [36]. It is an invariant that extends the Kauffman bracket for trivalent graphs to the case of graphs with vertices of any valence. For the sake of simplicity we only deal with the case of planar graphs with no 1 - or 2 -valent vertices; the general case of framed graphs in closed oriented manifolds is not conceptually more complex.

Let $\Gamma \subset S^{3}$ be a trivalent planar graph, $a_{I}$ be a coloring of its edges with elements in $\{0, \ldots, r-2\}$, and denote with $\left\langle\Gamma, a_{I}\right\rangle$ the Kauffman bracket evaluated at the $r$-th root of unity $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$ of the pair ( $\Gamma, a_{I}$ ) (see for example [15, Section 9] for a definition).

We say that the coloring $a_{I}$ is $r$-admissible if, whenever $i, j, k \in I$ are the indices of the edges of $\Gamma$ sharing a vertex, the triple $\left(a_{i}, a_{j}, a_{k}\right)$ is $r$-admissible.

Definition 2.11. A desingularization of a planar graph $\Gamma$ with no 1 - and 2 -valent vertices is a graph $\Gamma^{\prime}$ that coincides with $\Gamma$ outside of a neighborhood of the vertices of $\Gamma$, and in a neighborhood of each vertex is a planar trivalent tree, as in Figure 3

Definition 2.12. Let $\Gamma \subset S^{3}$ be a planar graph with no 1- and 2 -valent vertices and $\Gamma^{\prime}$ be a desingularization of $\Gamma$. Let $I$ be the set of edges of $\Gamma$ and $I^{\prime}$ be the set of edges of $\Gamma^{\prime}$ so that $I \subset I^{\prime}$ in a natural way, and let $V^{\prime}$ be the set of vertices of $\Gamma^{\prime}$. Then the $r$-th Yokota invariant of $\left(\Gamma, a_{I}\right)$ is

$$
\mathrm{Y}_{r}\left(\Gamma, a_{I}\right)=\sum_{a_{I^{\prime}}} \frac{\prod_{i \in I^{\prime} \backslash I}\left\langle\bigcirc, a_{i}\right\rangle}{\prod_{v \in V^{\prime}}\left\langle\emptyset,\left(a_{v_{1}}, a_{v_{2}}, a_{v_{3}}\right)\right\rangle}\left\langle\Gamma^{\prime}, a_{I^{\prime}}\right\rangle^{2},
$$

where the sum is over all $r$-admissible colorings $a_{I^{\prime}}$ of $I^{\prime}$ extending $a_{I}$, and $\left(v_{1}, v_{2}, v_{3}\right)$ are the indices of the edges of $\Gamma^{\prime}$ sharing $v$. In particular,

$$
\mathrm{Y}_{r}\left(囚,\left(a_{1}, \ldots, a_{6}\right)\right)=\left|\begin{array}{lll}
a_{1} & a_{2} & a_{3} \\
a_{4} & a_{5} & a_{6}
\end{array}\right|^{2}
$$

Remark 2.13. If $\Gamma$ has at least a vertex of valence greater than 3, then there are many different desingularizations; but $\mathrm{Y}_{r}\left(\Gamma, a_{I}\right)$ is independent of the choice of desingularization ([36, Proposition 4.3]).

### 2.5 Discrete Fourier transforms

The discrete Fourier transforms of the Yokota invariants were introduced in [1]; they were later shown to be a particular case of a general construction for modular tensor categories (see [20, Section 1] and references therein). They were used to prove the Turaev-Viro volume conjecture for a certain family of manifolds in [2], using a weak form of the Poisson Summation Formula; later [34] established a strong version of the Poisson Summation Formula.

For simplicity we only deal with planar graphs in $S^{3}$; and the definition could be extended to any graph in any closed, oriented 3 -manifold without any extra difficulty.

Definition 2.14. Let $\Gamma$ be a planar graph in $S^{3},(I, J)$ be a partition of the edges of $\Gamma$, and $\left(b_{I}, a_{J}\right)$ be a coloring of the edges of $\Gamma$. The discrete Fourier transform of the Yokota invariant of $\Gamma$ with respect to $\left(b_{I}, a_{J}\right)$ is defined as

$$
\widehat{\mathrm{Y}}_{r}\left(\Gamma, b_{I} ; a_{J}\right)=\sum_{\left(a_{i}\right)_{i \in I}} \prod_{i \in I} \mathrm{H}\left(a_{i}, b_{i}\right) \mathrm{Y}_{r}\left(\Gamma, a_{I}, a_{J}\right) .
$$

Proposition 2.15 (Duality of the Fourier transform of the $6 j$-symbol). Let $(I, J)$ be any partition of the edges of the tetrahedral graph. Then

$$
\widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)=\left(\frac{r}{2 \sin ^{2}\left(\frac{2 \pi}{r}\right)}\right)^{3-|I|} \widehat{\mathrm{Y}}_{r}\left(a_{J} ; b_{I}\right)
$$

Proof. The case of $J=\varnothing$ was proven in [1]. The general case can be reduced to the case of $J=\varnothing$ using the fact that

$$
\sum_{i=0}^{r-2} \sum_{j=0}^{r-2} \mathrm{H}(k, i) \mathrm{H}(j, l)=\frac{2 \sin ^{2}\left(\frac{2 \pi}{r}\right)}{r} \delta_{k l} .
$$

### 2.6 Dilogarithm and Lobachevsky functions

Let $\log : \mathbb{C} \backslash(-\infty, 0] \rightarrow \mathbb{C}$ be the standard logarithm function defined by

$$
\log z=\log |z|+\sqrt{-1} \cdot \arg z
$$

with $-\pi<\arg z<\pi$.
The dilogarithm function $\operatorname{Li}_{2}: \mathbb{C} \backslash(1, \infty) \rightarrow \mathbb{C}$ is defined by

$$
\operatorname{Li}_{2}(z)=-\int_{0}^{z} \frac{\log (1-u)}{u} d u
$$

where the integral is along any path in $\mathbb{C} \backslash(1, \infty)$ connecting 0 and $z$, which is holomorphic in $\mathbb{C} \backslash[1, \infty)$ and continuous in $\mathbb{C} \backslash(1, \infty)$.

The dilogarithm function satisfies the following properties (see eg. Zagier [37]).
(1) for any $z \in \mathbb{C} \backslash(1, \infty)$,

\operatorname{Li}_{2}\left(\frac{1}{z}\right)=-\operatorname{Li}_{2}(z)-\frac{\pi^{2}}{6}-\frac{1}{2}(\log (-z))^{2} . \tag{2.3}

(2) In the unit disk $\{z \in \mathbb{C}||z|<1\}$,

\begin{equation*}
\mathrm{Li}_{2}(z)=\sum_{n=1}^{\infty} \frac{z^{n}}{n^{2}}, \tag{2.4}
\end{equation*}
$$

(3) On the unit circle $\left\{z=e^{2 \sqrt{-1} \theta} \mid 0 \leqslant \theta \leqslant \pi\right\}$,

$$
\begin{equation*}
\mathrm{Li}_{2}\left(e^{2 \sqrt{-1} \theta}\right)=\frac{\pi^{2}}{6}+\theta(\theta-\pi)+2 \sqrt{-1} \cdot \Lambda(\theta) \tag{2.5}
\end{equation*}
$$

Here $\Lambda: \mathbb{R} \rightarrow \mathbb{R}$ is the Lobachevsky function defined by

$$
\Lambda(\theta)=-\int_{0}^{\theta} \log |2 \sin t| d t
$$

which is an odd function of period $\pi$ (see eg. Thurston's notes [29, Chapter 7]).

### 2.7 Quantum dilogarithm functions

The following variant of Faddeev's quantum dilogarithm functions [11, 12] will play a key role in the proof of the main result. Let $r \geqslant 3$ be an odd integer. Then the following contour integral

\varphi_{r}(z)=\frac{4 \pi \sqrt{-1}}{r} \int_{\Omega} \frac{e^{(2 z-\pi) x}}{4 x \sinh (\pi x) \sinh \left(\frac{2 \pi x}{r}\right)} d x \tag{2.6}
\end{equation*}
$$

defines a holomorphic function on the domain

$$
\left\{z \in \mathbb{C} \left\lvert\,-\frac{\pi}{r}<\operatorname{Re} z<\pi+\frac{\pi}{r}\right.\right\},
$$

where the contour is

$$
\Omega=(-\infty,-\epsilon] \cup\{z \in \mathbb{C}| | z \mid=\epsilon, \operatorname{Im} z>0\} \cup[\epsilon, \infty)
$$

for some $\epsilon \in(0,1)$. Note that the integrand has poles at $\sqrt{-1} n, n \in \mathbb{Z}$, and the choice of $\Omega$ is to avoid the pole at 0 .

The function $\varphi_{r}(z)$ satisfies the following fundamental properties; their proof can be found in [33, Lemma 2.1].

Lemma 2.16. (1) For $z \in \mathbb{C}$ with $0<\operatorname{Re} z<\pi$,

\begin{equation*}
1-e^{2 \sqrt{-1} z}=e^{\frac{r}{4 \pi \sqrt{-1}}}\left(\varphi_{r}\left(z-\frac{\pi}{r}\right)-\varphi_{r}\left(z+\frac{\pi}{r}\right)\right) . \tag{2.7}
\end{equation*}
$$

(2) For $z \in \mathbb{C}$ with $-\frac{\pi}{r}<\operatorname{Re} z<\frac{\pi}{r}$,

1+e^{r \sqrt{-1} z}=e^{\frac{r}{4 \pi \sqrt{-1}}}\left(\varphi_{r}(z)-\varphi_{r}(z+\pi)\right) . \tag{2.8}
\end{equation*}
$$

Using 2.7) and 2.8, for $z \in \mathbb{C}$ with $\pi+\frac{2(n-1) \pi}{r}<\operatorname{Re} z<\pi+\frac{2 n \pi}{r}$, we can define $\varphi_{r}(z)$ inductively by the relation

\begin{equation*}
\prod_{k=1}^{n}\left(1-e^{2 \sqrt{-1}\left(z-\frac{(2 k-1) \pi}{r}\right)}\right)=e^{\frac{r}{4 \pi \sqrt{-1}}\left(\varphi_{r}\left(z-\frac{2 n \pi}{r}\right)-\varphi_{r}(z)\right)}, \tag{2.9}
\end{equation*}
$$

extending $\varphi_{r}(z)$ to a meromorphic function on $\mathbb{C}$. The poles of $\varphi_{r}(z)$ have the form $(a+1) \pi+\frac{b \pi}{r}$ or $-a \pi-\frac{b \pi}{r}$ for all nonnegative integer $a$ and positive odd integer $b$.

Let $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$, and let

$$
(q)_{n}=\prod_{k=1}^{n}\left(1-q^{2 k}\right)
$$

Lemma 2.17. (1) For $0 \leqslant n \leqslant r-2$,

$$
\begin{equation*}
(q)_{n}=e^{\frac{r}{4 \pi \sqrt{ }-1}}\left(\varphi_{r}\left(\frac{\pi}{r}\right)-\varphi_{r}\left(\frac{2 \pi n}{r}+\frac{\pi}{r}\right)\right) . \tag{2.10}
\end{equation*}
$$

(2) For $\frac{r-1}{2} \leqslant n \leqslant r-2$,

$$
\begin{equation*}
(q)_{n}=2 e^{\frac{r}{4 \pi \sqrt{-1}}\left(\varphi_{r}\left(\frac{\pi}{r}\right)-\varphi_{r}\left(\frac{2 \pi n}{r}+\frac{\pi}{r}-\pi\right)\right)} . \tag{2.11}
\end{equation*}
$$

Let $\{n\}!=\prod_{k=1}^{n}\{k\}$. Then

$$
\{n\}!=(-1)^{n} q^{-\frac{n(n+1)}{2}}(q)_{n},
$$

and as a consequence of Lemma 2.17, we have
Lemma 2.18. (1) For $0 \leqslant n \leqslant r-2$,

\begin{equation*}
\{n\}!=e^{\frac{r}{4 \pi \sqrt{-1}}}\left(-2 \pi\left(\frac{2 \pi n}{r}\right)+\left(\frac{2 \pi}{r}\right)^{2}\left(n^{2}+n\right)+\varphi_{r}\left(\frac{\pi}{r}\right)-\varphi_{r}\left(\frac{2 \pi n}{r}+\frac{\pi}{r}\right)\right) . \tag{2.12}
\end{equation*}
$$

(2) For $\frac{r-1}{2} \leqslant n \leqslant r-2$,

$$
\begin{equation*}
\{n\}!=2 e^{\frac{r}{4 \pi \sqrt{-1}}}\left(-2 \pi\left(\frac{2 \pi n}{r}\right)+\left(\frac{2 \pi}{r}\right)^{2}\left(n^{2}+n\right)+\varphi_{r}\left(\frac{\pi}{r}\right)-\varphi_{r}\left(\frac{2 \pi n}{r}+\frac{\pi}{r}-\pi\right)\right) . \tag{2.13}
\end{equation*}
$$

We consider 2.13) because there are poles in $(\pi, 2 \pi)$, and to avoid the poles we move the variables to $(0, \pi)$ by subtracting $\pi$.

The function $\varphi_{r}(z)$ and the dilogarithm function are closely related as follows.
Lemma 2.19. (1) For every $z$ with $0<\operatorname{Re} z<\pi$,

\varphi_{r}(z)=\operatorname{Li}_{2}\left(e^{2 \sqrt{-1} z}\right)+\frac{2 \pi^{2} e^{2 \sqrt{-1} z}}{3\left(1-e^{2 \sqrt{-1} z}\right)} \frac{1}{r^{2}}+O\left(\frac{1}{r^{4}}\right) . \tag{2.14}
\end{equation*}
$$

(2) For every $z$ with $0<\operatorname{Re} z<\pi$,

$$
\begin{equation*}
\varphi_{r}^{\prime}(z)=-2 \sqrt{-1} \cdot \log \left(1-e^{2 \sqrt{-1} z}\right)+O\left(\frac{1}{r^{2}}\right) \tag{2.15}
\end{equation*}
$$

(3) [27] Formula (8)(9)]

$$
\varphi_{r}\left(\frac{\pi}{r}\right)=\operatorname{Li}_{2}(1)+\frac{2 \pi \sqrt{-1}}{r} \log \left(\frac{r}{2}\right)-\frac{\pi^{2}}{r}+O\left(\frac{1}{r^{2}}\right) .
$$

## 3 The geometry of quantum $6 j$-symbols

Definition 3.1. An $r$-admissible 6 -tuple $\left(a_{1}, \ldots, a_{6}\right)$ is of the hyperideal type iffor $\{i, j, k\}=\{1,2,3\}$, $\{1,5,6\},\{2,4,6\}$ and $\{3,4,5\}$,
(1) $0 \leqslant a_{i}+a_{j}-a_{k}<r-2$,
(2) $r-2<a_{i}+a_{j}+a_{k} \leqslant 2(r-2)$,
(3) $a_{i}+a_{j}+a_{k}$ is even.

As a consequence of Lemma 2.18 we have
Proposition 3.2. The quantum $6 j$-symbol at the root of unity $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$ can be computed as

\left|\begin{array}{lll}
a_{1} & a_{2} & a_{3} \\
a_{4} & a_{5} & a_{6}
\end{array}\right|=\frac{\{1\}}{2} \sum_{k=\max \left\{T_{1}, T_{2}, T_{3}, T_{4}\right\}}^{\min \left\{Q_{1}, Q_{2}, Q_{3}, r-2\right\}} e^{\frac{r}{4 \pi \sqrt{-1}} U_{r}\left(\frac{2 \pi a_{1}}{r}, \ldots, \frac{2 \pi a_{6}}{r}, \frac{2 \pi k}{r}\right)},
$$

where $U_{r}$ is defined as follows. If $\left(a_{1}, \ldots, a_{6}\right)$ is of hyperideal type, then

$$
\begin{align*}
U_{r}\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right)= & \pi^{2}-\left(\frac{2 \pi}{r}\right)^{2}+\frac{1}{2} \sum_{i=1}^{4} \sum_{j=1}^{3}\left(\eta_{j}-\tau_{i}\right)^{2}-\frac{1}{2} \sum_{i=1}^{4}\left(\tau_{i}+\frac{2 \pi}{r}-\pi\right)^{2} \\
& +\left(\xi+\frac{2 \pi}{r}-\pi\right)^{2}-\sum_{i=1}^{4}\left(\xi-\tau_{i}\right)^{2}-\sum_{j=1}^{3}\left(\eta_{j}-\xi\right)^{2} \\
& -2 \varphi_{r}\left(\frac{\pi}{r}\right)-\frac{1}{2} \sum_{i=1}^{4} \sum_{j=1}^{3} \varphi_{r}\left(\eta_{j}-\tau_{i}+\frac{\pi}{r}\right)+\frac{1}{2} \sum_{i=1}^{4} \varphi_{r}\left(\tau_{i}-\pi+\frac{3 \pi}{r}\right)  \tag{3.1}\\
& -\varphi_{r}\left(\xi-\pi+\frac{3 \pi}{r}\right)+\sum_{i=1}^{4} \varphi_{r}\left(\xi-\tau_{i}+\frac{\pi}{r}\right)+\sum_{j=1}^{3} \varphi_{r}\left(\eta_{j}-\xi+\frac{\pi}{r}\right),
\end{align*}
$$

where $\alpha_{i}=\frac{2 \pi a_{i}}{r}$ for $i=1, \ldots, 6$ and $\xi=\frac{2 \pi k}{r}, \tau_{1}=\frac{\alpha_{1}+\alpha_{2}+\alpha_{3}}{2}, \tau_{2}=\frac{\alpha_{1}+\alpha_{5}+\alpha_{6}}{2}, \tau_{3}=\frac{\alpha_{2}+\alpha_{4}+\alpha_{6}}{2}$ and $\tau_{4}=\frac{\alpha_{3}+\alpha_{4}+\alpha_{5}}{2}, \eta_{1}=\frac{\alpha_{1}+\alpha_{2}+\alpha_{4}+\alpha_{5}}{2}, \eta_{2}=\frac{\alpha_{1}+\alpha_{3}+\alpha_{4}+\alpha_{6}}{2}$ and $\eta_{3}=\frac{\alpha_{2}+\alpha_{3}+\alpha_{5}+\alpha_{6}}{2}$. If $\left(a_{1}, \ldots, a_{6}\right)$ is not of the hyperideal type, then $U_{r}$ will be changed according to Lemma 2.18 .

Definition 3.3. $A$-tuple $\left(\alpha_{1}, \ldots, \alpha_{6}\right) \in[0,2 \pi]^{6}$ is of the hyperideal type if
(1) $0 \leqslant \alpha_{i}+\alpha_{j}-\alpha_{k} \leqslant 2 \pi$,
(2) $2 \pi \leqslant \alpha_{i}+\alpha_{j}+\alpha_{k} \leqslant 4 \pi$.

We notice that the six numbers $\left|\pi-\alpha_{1}\right|, \ldots,\left|\pi-\alpha_{6}\right|$ are the dihedral angles of an ideal or a hyperideal tetrahedron if and only if $\left(\alpha_{1}, \ldots, \alpha_{6}\right)$ is of the hyperideal type.

By Lemma 2.19, $U_{r}=U-\frac{4 \pi \sqrt{-1}}{r} \log \left(\frac{r}{2}\right)+O\left(\frac{1}{r}\right)$, where $U$ is defined by

$$
\begin{align*}
U\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right)= & \pi^{2}+\frac{1}{2} \sum_{i=1}^{4} \sum_{j=1}^{3}\left(\eta_{j}-\tau_{i}\right)^{2}-\frac{1}{2} \sum_{i=1}^{4}\left(\tau_{i}-\pi\right)^{2} \\
& +(\xi-\pi)^{2}-\sum_{i=1}^{4}\left(\xi-\tau_{i}\right)^{2}-\sum_{j=1}^{3}\left(\eta_{j}-\xi\right)^{2} \\
& -2 L i_{2}(1)-\frac{1}{2} \sum_{i=1}^{4} \sum_{j=1}^{3} L i_{2}\left(e^{2 i\left(\eta_{j}-\tau_{i}\right)}\right)+\frac{1}{2} \sum_{i=1}^{4} L i_{2}\left(e^{2 i\left(\tau_{i}-\pi\right)}\right)  \tag{3.2}\\
& -L i_{2}\left(e^{2 i(\xi-\pi)}\right)+\sum_{i=1}^{4} L i_{2}\left(e^{2 i\left(\xi-\tau_{i}\right)}\right)+\sum_{j=1}^{3} L i_{2}\left(e^{2 i\left(\eta_{j}-\xi\right)}\right)
\end{align*}
$$

on the region $\mathrm{B}_{\mathrm{H}, \mathrm{C}}$ consisting of $\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right) \in \mathbb{C}^{7}$ such that $\left(\operatorname{Re}\left(\alpha_{1}\right), \ldots, \operatorname{Re}\left(\alpha_{6}\right)\right)$ is of the hyperideal type and $\max \left\{\operatorname{Re}\left(\tau_{i}\right)\right\} \leqslant \operatorname{Re}(\xi) \leqslant \min \left\{\operatorname{Re}\left(\eta_{j}\right), 2 \pi\right\}$.

Let

$$
\mathrm{B}_{\mathrm{H}}=\mathrm{B}_{\mathrm{H}, \mathrm{C}} \cap \mathbb{R}^{7} .
$$

Then by 2.5 , for $\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right) \in \mathrm{B}_{\mathrm{H}}$,

$$
\begin{equation*}
U\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right)=2 \pi^{2}+2 \sqrt{-1} \cdot V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right) \tag{3.3}
\end{equation*}
$$

for $V: \mathrm{B}_{\mathrm{H}} \rightarrow \mathbb{R}$ defined by

$$
\begin{align*}
V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right)= & \delta\left(\alpha_{1}, \alpha_{2}, \alpha_{3}\right)+\delta\left(\alpha_{1}, \alpha_{5}, \alpha_{6}\right)+\delta\left(\alpha_{2}, \alpha_{4}, \alpha_{6}\right)+\delta\left(\alpha_{3}, \alpha_{4}, \alpha_{5}\right) \\
& -\Lambda(\xi)+\sum_{i=1}^{4} \Lambda\left(\xi-\tau_{i}\right)+\sum_{j=1}^{3} \Lambda\left(\eta_{j}-\xi\right) \tag{3.4}
\end{align*}
$$

with $\delta$ defined by

$$
\delta(x, y, z)=-\frac{1}{2} \Lambda\left(\frac{x+y-z}{2}\right)-\frac{1}{2} \Lambda\left(\frac{y+z-x}{2}\right)-\frac{1}{2} \Lambda\left(\frac{z+x-y}{2}\right)+\frac{1}{2} \Lambda\left(\frac{x+y+z}{2}\right) .
$$

As a consequence, we have

\frac{\partial U}{\partial \xi}=2 \sqrt{-1} \cdot \frac{\partial V}{\partial \xi}=2 \sqrt{-1} \cdot \log \frac{\sin (-\xi) \sin \left(\eta_{1}-\xi\right) \sin \left(\eta_{2}-\xi\right) \sin \left(\eta_{3}-\xi\right)}{\sin \left(\xi-\tau_{1}\right) \sin \left(\xi-\tau_{2}\right) \sin \left(\xi-\tau_{3}\right) \sin \left(\xi-\tau_{4}\right)} \tag{3.5}
\end{equation*}
$$

and

$$
\begin{align*}
\frac{\partial U}{\partial \alpha_{1}}=2 \sqrt{-1} \cdot \frac{\partial V}{\partial \alpha_{1}}= & \frac{\sqrt{-1}}{2} \cdot \log \frac{\sin \left(\frac{\alpha_{1}+\alpha_{2}-\alpha_{3}}{2}\right) \sin \left(\frac{\alpha_{1}+\alpha_{3}-\alpha_{2}}{2}\right) \sin \left(\frac{\alpha_{1}+\alpha_{5}-\alpha_{6}}{2}\right) \sin \left(\frac{\alpha_{1}+\alpha_{6}-\alpha_{5}}{2}\right)}{\sin \left(\frac{\alpha_{2}+\alpha_{3}-\alpha_{1}}{2}\right) \sin \left(\frac{\alpha_{1}+\alpha_{2}+\alpha_{3}}{2}\right) \sin \left(\frac{\alpha_{5}+\alpha_{6}-\alpha_{1}}{2}\right) \sin \left(\frac{\alpha_{1}+\alpha_{5}+\alpha_{6}}{2}\right)} \\
& +\sqrt{-1} \cdot \log \frac{\sin \left(\xi-\tau_{1}\right) \sin \left(\xi-\tau_{2}\right)}{\sin \left(\eta_{1}-\xi\right) \sin \left(\eta_{2}-\xi\right)} \tag{3.6}

A result of Costantino [8] shows that for each $\alpha=\left(\alpha_{1}, \ldots, \alpha_{6}\right)$ of the hyperideal type, there exists a unique $\xi_{\alpha}$ so that $\left(\alpha, \xi_{\alpha}\right) \in \mathrm{B}_{\mathrm{H}}$ and

$$

Indeed, oen can prove that for each $\alpha, V$ is strictly concave down in $\xi$ with derivatives $\pm \infty$ at the boundary points of the interval of $\xi$, hence there is a unique critical point which is the absolute maximum. Moreover, he shows that by the Murakami-Yano formula [25, 31],

& +\sqrt{-1} \cdot \log \frac{u_{4}\left(1-z u_{1} u_{2} u_{3}\right)\left(1-z u_{1} u_{5} u_{6}\right)}{\left(1-z u_{1} u_{2} u_{4} u_{5}\right)\left(1-z u_{1} u_{3} u_{4} u_{6}\right)} \quad(\bmod \pi) .

For a fixed $\alpha$ so that $\operatorname{Re}(\alpha)$ is of the hyperideal type, consider the function $U_{\alpha}$ of $\xi$ defined by $U_{\alpha}(\xi)=U(\alpha, \xi)$. From (3.9), if $\xi$ is a critical point of $U_{\alpha}$, then as a necessary condition

A direct computation shows that if $\alpha_{1}=\alpha_{2}=\cdots=\alpha_{6}=\pi$, then $\xi(\alpha)=\frac{7 \pi}{4} \in\left(\frac{3 \pi}{2}, 2 \pi\right)=$ $\left(\max \left\{\tau_{i}\right\}, \min \left\{\eta_{j}, 2 \pi\right\}\right)$ and $\xi^{*}(\alpha)=\frac{5 \pi}{4} \notin\left(\frac{3 \pi}{2}, 2 \pi\right)$. Hence for $\alpha$ real and of the hyperideal type, $\xi(\alpha)$ coincides with $\xi_{\alpha}$ in Costantino's result, and by 3.8 and the continuity of $\frac{\partial U}{\partial \xi}$, we have

Remark 3.4. At this point, we do not know whether for any $\alpha$ so that $\operatorname{Re}(\alpha)$ is of the hyperideal type, $(\alpha, \xi(\alpha))$ always lies in $\mathrm{B}_{\mathrm{H}, \mathrm{C}}$. In Section 5 , we will show that it does when $\theta_{1}, \ldots, \theta_{6}$ are sufficiently small.

For $\alpha \in \mathbb{C}^{6}$ so that $(\alpha, \xi(\alpha)) \in \mathrm{B}_{\mathrm{H}, \mathrm{C}}$, we define

Proof. The proof follows the argument in [25, 31, 18]: the key step is proving that $W$ satisfies the same differential identities as those of Cov in Lemma 2.3. Without loss of generality assume that $1 \in I$. Let $W^{*}(\alpha)=U\left(\alpha, \xi^{*}(\alpha)\right)-4 k^{*} \pi \xi^{*}(\alpha)$. Then we have

Let R and S respectively be the terms in $\left(1-z_{\alpha} u_{1} u_{2} u_{3}\right)\left(1-z_{\alpha} u_{1} u_{5} u_{6}\right)\left(1-z_{\alpha}^{*} u_{1} u_{2} u_{4} u_{5}\right)(1-$ $z_{\alpha}^{*} u_{1} u_{3} u_{4} u_{6}$ ) not containing and containing $\sqrt{B^{2}-4 A C}$. Then by a direct computation (see also [25, 31]),

& \left(1-z_{\alpha} u_{1} u_{3} u_{4} u_{6}\right)\left(1-z_{\alpha}^{*} u_{1} u_{3} u_{4} u_{6}\right)=\frac{1}{A} \frac{\left(u_{1} u_{3} u_{4} u_{6}\right)^{2}}{u_{2} u_{5}}\left(1-\frac{u_{2}}{u_{4} u_{6}}\right)\left(1-\frac{u_{5}}{u_{3} u_{4}}\right)\left(1-\frac{u_{2}}{u_{1} u_{3}}\right)\left(1-\frac{u_{5}}{u_{1} u_{6}}\right), \\
& \left(1-z_{\alpha} u_{1} u_{2} u_{3}\right)\left(1-z_{\alpha}^{*} u_{1} u_{2} u_{3}\right)=\frac{1}{A} \frac{\left(u_{1} u_{2} u_{3}\right)^{2}}{u_{4} u_{5} u_{6}}\left(1-\frac{u_{4} u_{5}}{u_{3}}\right)\left(1-\frac{u_{4} u_{6}}{u_{2}}\right)\left(1-\frac{u_{5} u_{6}}{u_{1}}\right)\left(1-\frac{1}{u_{1} u_{2} u_{3}}\right),
\end{aligned}

$\left(1-z_{\alpha} u_{1} u_{5} u_{6}\right)\left(1-z_{\alpha}^{*} u_{1} u_{5} u_{6}\right)=\frac{1}{A} \frac{\left(u_{1} u_{5} u_{6}\right)^{2}}{u_{2} u_{3} u_{4}}\left(1-\frac{u_{2} u_{4}}{u_{6}}\right)\left(1-\frac{u_{3} u_{4}}{u_{5}}\right)\left(1-\frac{u_{2} u_{3}}{u_{1}}\right)\left(1-\frac{1}{u_{1} u_{5} u_{6}}\right)$.
These, together with (3.10), (3.14) and (3.15), imply (3.18).
Putting (3.16), (3.17) and (3.18) together, we have

Then by 3.6, $\frac{\partial W}{\partial l_{1}}=\sqrt{-1} \cdot \frac{\partial W}{\partial \alpha_{1}}$ is real. Also, by 2.1), if $l_{1}=0$ then $\theta_{1}=0$. This implies that $k=0$, and

Together with Lemma 2.3 and 3.20, we have the result.

Remark 3.6. Theorem 3.5 also plays an essential role in the proof of the main theorems of [34, 36].
Corollary 3.7. Let $\Delta$ be the deeply truncated tetrahedron of type $(I, J)$ with $\left\{l_{i}\right\}_{i \in I}$ the lengths of the edges of deep truncation and $\left\{\theta_{j}\right\}_{j \in J}$ the dihedral angles at the regular edges. Then

Corollary 3.7 is an immediate consequence of Theorem 3.5 and Lemma 2.3. See also [18] for a different volume formula involving both roots of the quadratic equation (3.11).

## 4 Computation of the discrete Fourier transforms

Proposition 4.1. Let $(I, J)$ be a partition of $\{1, \ldots, 6\}$. Then the discrete Fourier transform $\widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)$ at the root of unity $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$ can be computed as

where $n\left(a_{J}\right)$ is the number of 3 -admissible colorings $c$ such that $c_{j} \equiv a_{j}(\bmod 2)$ for each $j \in J$, $\epsilon_{I}=\left(\epsilon_{i}\right)_{i \in I} \in\{1,-1\}^{I}$ runs over all multi-signs, $a_{I}=\left(a_{i}\right)_{i \in I}$ runs over all multi-even integers in $\{0,2 \ldots, r-3\}$ so that the triples $\left(a_{1}, a_{2}, a_{3}\right),\left(a_{1}, a_{5}, a_{6}\right),\left(a_{2}, a_{4}, a_{6}\right)$ and $\left(a_{3}, a_{4}, a_{5}\right)$ are $r$-admissible, and $k_{1}$ and $k_{2}$ run over all the integers in between $\max \left\{T_{i}\right\}$ and $\min \left\{Q_{j}, r-2\right\}$ with

g_{r}^{\epsilon_{I}}\left(a_{I}, k_{1}, k_{2}\right)=e^{\sum_{i \in I} \epsilon_{i} \cdot \frac{2 \sqrt{-1} \pi\left(a_{i}+b_{i}+1\right)}{r}+\frac{r}{4 \pi \sqrt{-1}} \mathcal{W}_{r}^{\epsilon_{I}}\left(\frac{2 \pi a_{I}}{r}, \frac{2 \pi k_{1}}{r}, \frac{2 \pi k_{2}}{r}\right)}
$$

where $\frac{2 \pi a_{I}}{r}=\left(\frac{2 \pi a_{i}}{r}\right)_{i \in I}$ and

\mathcal{W}_{r}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=-\sum_{i \in I} 2 \epsilon_{i}\left(\alpha_{i}-\pi\right)\left(\beta_{i}-\pi\right)+U_{r}\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{6}, \xi_{1}\right)+U_{r}\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{6}, \xi_{2}\right)
$$

where $\alpha_{I}=\left(\alpha_{i}\right)_{i \in I}$.
Proof. First, we observe that if we let the summation in the definition of $\widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)$ be over all multieven integers $a_{I}$ instead of multi-integers, then the resulting quantity differs from $\widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)$ by a factor $n\left(a_{J}\right)$ by [10, Lemma A.4, Theorem 2.9 and its proof]. Next, we observe that

& =\frac{-(-1)^{\frac{r}{2}}}{q-q^{-1}}\left(q^{\left(\left(a_{i}-\frac{r}{2}\right)\left(b_{i}-\frac{r}{2}\right)+a_{i}+b_{i}+1\right)}+q^{-\left(\left(a_{i}-\frac{r}{2}\right)\left(b_{i}-\frac{r}{2}\right)+a_{i}+b_{i}+1\right)}\right) \\
& =\frac{(-1)^{\frac{r}{2}+1}}{\{1\}} \sum_{\epsilon_{i} \in\{-1,1\}} q^{\epsilon_{i}\left(\left(a_{i}-\frac{r}{2}\right)\left(b_{i}-\frac{r}{2}\right)+a_{i}+b_{i}+1\right)} \\
& =\frac{(-1)^{\frac{r}{2}+1}}{\{1\}} \sum_{\epsilon_{i} \in\{-1,1\}} e^{\epsilon_{i} \frac{2 \sqrt{-1} \pi\left(a_{i}+b_{i}+1\right)}{r}+\frac{r}{4 \pi \sqrt{-1}}\left(-2 \epsilon_{i}\left(\frac{2 \pi a_{i}}{r}-\pi\right)\left(\frac{2 \pi b_{i}}{r}-\pi\right)\right)},
\end{aligned}
$$

and hence

\prod_{i \in I} \mathrm{H}\left(a_{i}, b_{i}\right) & =\frac{(-1)^{|I|\left(\frac{r}{2}+1\right)}}{\{1\}^{|I|}} \sum_{\epsilon_{I} \in\{-1,1\}|I|} e^{\sum_{i \in I} \epsilon_{i} \frac{2 \sqrt{-1} \pi\left(a_{i}+b_{i}+1\right)}{r}+\frac{r}{4 \pi \sqrt{-1}} \sum_{i \in I}\left(-2 \epsilon_{i}\left(\frac{2 \pi a_{i}}{r}-\pi\right)\left(\frac{2 \pi b_{i}}{r}-\pi\right)\right)} \\
& =\frac{(-1)^{|I|\left(\frac{r}{2}+1\right)}}{\{1\}^{|I|}} \sum_{\epsilon_{I} \in\{-1,1\}|I|} e^{\sum_{i \in I} \epsilon_{i} \sqrt{-1}\left(\alpha_{i}+\beta_{i}+\frac{2 \pi}{r}\right)+\frac{r}{4 \pi \sqrt{-1}} \sum_{i \in I}\left(-2 \epsilon_{i}\left(\alpha_{i}-\pi\right)\left(\beta_{i}-\pi\right)\right)} .
\end{aligned}

Then the result follows from Proposition 3.2 ,
We notice that the summation in Proposition 4.1 is finite, and to use the Poisson Summation Formula, we need an infinite sum over integral points. To this end, we consider the following regions and a bump function over them.

Let $\alpha_{i}=\frac{2 \pi a_{i}}{r}$ for $i=1, \ldots, 6, \beta_{i}=\frac{2 \pi b_{i}}{r}$ for $i \in I, \xi_{s}=\frac{2 \pi k_{s}}{r}$ for $s=1,2, \tau_{i}=\frac{2 \pi T_{i}}{r}$ for $i=1, \ldots, 4$, and $\eta_{j}=\frac{2 \pi Q_{j}}{r}$ for $j=1,2,3$. For a fixed $\left(\alpha_{j}\right)_{j \in J}$, let
$\mathrm{D}_{\mathrm{A}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathbb{R}^{|I|+2} \mid\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{6}\right)\right.$ is admissible, $\left.\max \left\{\tau_{i}\right\} \leqslant \xi_{s} \leqslant \min \left\{\eta_{j}, 2 \pi\right\}, s=1,2\right\}$, and let

For a sufficiently small $\delta>0$, let

where $d$ is the Euclidean distance on $\mathbb{R}^{n}$. We let $\psi: \mathbb{R}^{|I|+2} \rightarrow \mathbb{R}$ be a $C^{\infty}$-smooth bump function supported on $\left(\mathrm{D}_{\mathrm{H}}, \mathrm{D}_{\mathrm{H}}^{\delta}\right)$, ie,

In Proposition 4.1, the sum is over multi-even integers $a_{I}$. On the other hand, to use the Poisson Summation Formula, we need a sum over all integers. For this purpose, we for each $i \in I$ let $a_{i}=2 a_{i}^{\prime}$, $a_{I}^{\prime}=\left(a_{i}^{\prime}\right)_{i \in I}$ and denote $\left(2 a_{i}^{\prime}\right)_{i \in I}$ by $2 a_{I}^{\prime}$. Then by Proposition 4.1.

$$

Since $f_{r}$ is $C^{\infty}$-smooth and equals zero out of $\mathrm{D}_{\mathrm{H}}$, it is in the Schwartz space on $\mathbb{R}^{|I|+2}$. Then by the Poisson Summation Formula (see e.g. [28, Theorem 3.1]),

where $m_{I}=\left(m_{i}\right)_{i \in I} \in \mathbb{Z}^{I}$ and $\widehat{f}_{r}\left(m_{I}, n_{1}, n_{2}\right)$ is the $\left(m_{I}, n_{1}, n_{2}\right)$-th Fourier coefficient of $f_{r}$ defined by

& \cdot e^{\frac{r}{4 \pi \sqrt{-1}}}\left(\mathcal{W}_{r}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)-\sum_{i \in I} 2 \pi m_{i} \alpha_{i}-4 \pi n_{1} \xi_{1}-4 \pi n_{2} \xi_{2}\right) \\
& d \alpha_{I} d \xi_{1} d \xi_{2},

where $d \alpha_{I}=\prod_{i \in I} d \alpha_{i}$ and

We will estimate the leading Fourier coefficients, the non-leading Fourier coefficients and the error term respectively in Sections $5.3,5.4$ and 5.5 , and prove Theorem 1.2 in Section 5.6

## 5 Asymptotics

Proposition 5.1. Let $D_{\mathbf{z}}$ be a region in $\mathbb{C}^{n}$ and let $D_{\mathbf{a}}$ be a region in $\mathbb{R}^{k}$. Let $f(\mathbf{z}, \mathbf{a})$ and $g(\mathbf{z}, \mathbf{a})$ be complex valued functions on $D_{\mathbf{z}} \times D_{\mathbf{a}}$ which are holomorphic in $\mathbf{z}$ and smooth in $\mathbf{a}$. For each positive integer $r$, let $f_{r}(\mathbf{z}, \mathbf{a})$ be a complex valued function on $D_{\mathbf{z}} \times D_{\mathbf{a}}$ holomorphic in $\mathbf{z}$ and smooth in $\mathbf{a}$. For a fixed $\mathbf{a} \in D_{\mathbf{a}}$, let $f^{\mathbf{a}}, g^{\mathbf{a}}$ and $f_{r}^{\mathbf{a}}$ be the holomorphic functions on $D_{\mathbf{z}}$ defined by $f^{\mathbf{a}}(\mathbf{z})=f(\mathbf{z}, \mathbf{a})$,
$g^{\mathbf{a}}(\mathbf{z})=g(\mathbf{z}, \mathbf{a})$ and $f_{r}^{\mathbf{a}}(\mathbf{z})=f_{r}(\mathbf{z}, \mathbf{a})$. Suppose $\left\{\mathbf{a}_{r}\right\}$ is a convergent sequence in $D_{\mathbf{a}}$ with $\lim _{r} \mathbf{a}_{r}=\mathbf{a}_{0}$, $f_{r}^{\mathbf{a}_{r}}$ is of the form

$$
f_{r}^{\mathbf{a}_{r}}(\mathbf{z})=f^{\mathbf{a}_{r}}(\mathbf{z})+\frac{v_{r}\left(\mathbf{z}, \mathbf{a}_{r}\right)}{r^{2}}
$$

$\left\{S_{r}\right\}$ is a sequence of embedded real n-dimensional closed disks in $D_{\mathrm{z}}$ sharing the same boundary, and $\mathbf{c}_{r}$ is a point on $S_{r}$ such that $\left\{\mathbf{c}_{r}\right\}$ is convergent in $D_{\mathbf{z}}$ with $\lim _{r} \mathbf{c}_{r}=\mathbf{c}_{0}$. If for each $r$
(1) $\mathbf{c}_{r}$ is a critical point of $f^{\mathbf{a}_{r}}$ in $D_{\mathbf{z}}$,
(2) $\operatorname{Re} f^{\mathbf{a}_{r}}\left(\mathbf{c}_{r}\right)>\operatorname{Re} f^{\mathbf{a}_{r}}(\mathbf{z})$ for all $\mathbf{z} \in S \backslash\left\{\mathbf{c}_{r}\right\}$,
(3) the Hessian matrix $\operatorname{Hess}\left(f^{\mathbf{a}_{r}}\right)$ of $f^{\mathbf{a}_{r}}$ at $\mathbf{c}_{r}$ is non-singular,
(4) $\left|g^{\mathbf{a}_{r}}\left(\mathbf{c}_{r}\right)\right|$ is bounded from below by a positive constant independent of $r$,
(5) $\left|v_{r}\left(\mathbf{z}, \mathbf{a}_{r}\right)\right|$ is bounded from above by a constant independent of $r$ on $D_{\mathbf{z}}$, and
(6) the Hessian matrix $\operatorname{Hess}\left(f^{\mathbf{a}_{0}}\right)$ of $f^{\mathbf{a}_{0}}$ at $\mathbf{c}_{0}$ is non-singular,
then

$$
\int_{S_{r}} g^{\mathbf{a}_{r}}(\mathbf{z}) e^{r f_{r}^{\mathbf{a}_{r}}(\mathbf{z})} d \mathbf{z}=\left(\frac{2 \pi}{r}\right)^{\frac{n}{2}} \frac{g^{\mathbf{a}_{r}\left(\mathbf{c}_{r}\right)}}{\sqrt{-\operatorname{det} \operatorname{Hess}\left(f^{\mathbf{a}_{r}}\right)\left(\mathbf{c}_{r}\right)}} e^{r f^{\mathbf{a}_{r}\left(\mathbf{c}_{r}\right)}}\left(1+O\left(\frac{1}{r}\right)\right) .
$$

A proof can be found in [34, Appendix].
For fixed $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$, let $\theta_{i}=\left|\pi-\beta_{i}\right|$ for $i \in I$ and let $\theta_{j}=\left|\pi-\alpha_{j}\right|$ for $j \in J$. The function $\mathcal{W}_{r}^{\epsilon_{I}}$ is approximated by the following function

$$
\left.\mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=-\sum_{i \in I} 2 \epsilon_{i}\left(\alpha_{i}-\pi\right)\left(\beta_{i}-\pi\right)+U\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{1}\right)\right)+U\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{2}\right)
$$

The approximation will be specified in the proof of Proposition 5.5. Notice that $\mathcal{W}^{\epsilon_{I}}$ is continuous on

\mathrm{D}_{\mathrm{H}, \mathbb{C}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathbb{C}^{|I|+2} \mid\left(\operatorname{Re}\left(\alpha_{I}\right), \operatorname{Re}\left(\xi_{1}\right), \operatorname{Re}\left(\xi_{2}\right)\right) \in \mathrm{D}_{\mathrm{H}}\right\}
$$

and for any $\delta>0$ is analytic on

\mathrm{D}_{\mathrm{H}, \mathbb{C}}^{\delta}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathbb{C}^{|I|+2} \mid\left(\operatorname{Re}\left(\alpha_{I}\right), \operatorname{Re}\left(\xi_{1}\right), \operatorname{Re}\left(\xi_{2}\right)\right) \in \mathrm{D}_{\mathrm{H}}^{\delta}\right\}
$$

where $\operatorname{Re}\left(\alpha_{I}\right)=\left(\operatorname{Re}\left(\alpha_{i}\right)\right)_{i \in I}$.
In the rest of this paper, we assume that $\theta_{1}, \ldots, \theta_{6}$ are sufficiently close to 0 , or equivalently, $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are sufficiently close to $\pi$. In the special case $\beta_{i}=\alpha_{j}=\pi$ for all $i \in I$ and $j \in J$, a direct computation shows that $\xi(\pi, \ldots, \pi)=\frac{7 \pi}{4}$. We denote by $\pi_{I}$ the point $(\pi, \ldots, \pi) \in \mathbb{C}^{I}$. For $\delta>0$, we denote by $\mathrm{D}_{\delta, \mathbb{C}}$ the $L^{1} \delta$-neighborhood of $\left(\pi_{I}, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$ in $\mathbb{C}^{|I|+2}$, that is

\mathrm{D}_{\delta, \mathbb{C}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathbb{C}^{|I|+2} \left\lvert\, d_{L^{1}}\left(\left(\alpha_{I}, \xi_{1}, \xi_{2}\right),\left(\pi_{I}, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)\right)<\delta\right.\right\}
$$

where $d_{L^{1}}$ is the real $L^{1}$ norm on $\mathbb{C}^{n}$ defined by

d_{L^{1}}(\mathbf{x}, \mathbf{y})=\max _{i \in\{1, \ldots, n\}}\left\{\left|\operatorname{Re}\left(x_{i}\right)-\operatorname{Re}\left(y_{i}\right)\right|,\left|\operatorname{Im}\left(x_{i}\right)-\operatorname{Im}\left(y_{i}\right)\right|\right\}
$$

where $\mathbf{x}=\left(x_{1}, \ldots, x_{n}\right)$ and $\mathbf{y}=\left(y_{1}, \ldots, y_{n}\right)$. We will also consider the region

\mathrm{D}_{\delta}=\mathrm{D}_{\delta, \mathbb{C}} \cap \mathbb{R}^{|I|+2}
$$

### 5.1 Critical points and critical values of $\mathcal{W}^{\epsilon_{I}}$

Let $\Delta\left(\theta_{I} ; \theta_{J}\right)$ be the deeply truncated tetrahedron of type $(I, J)$ with edges of deep truncation $\left\{e_{i}\right\}_{i \in I}$ and regular edges $\left\{e_{j}\right\}_{j \in J}$, and with $\theta_{i}$ the dihedral angle at $e_{i}$ for $i \in I$, and with $\theta_{i}$ the dihedral angle at $e_{j}$ for $j \in J$. For $i \in I$, let $l_{i}$ be the length of $e_{i}$.

Proposition 5.2. Suppose $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are sufficiently close to $\pi$. Let $\theta_{i}=\left|\pi-\beta_{i}\right|$ for $i \in I$ and let $\theta_{j}=\left|\pi-\alpha_{j}\right|$ for $j \in J$. Let $\mu_{i}=1$ if $\beta_{i} \geqslant \pi$ and let $\mu_{i}=-1$ if $\beta_{i} \leqslant \pi$ for $i \in I$. Then $\mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)$ has a critical point

$$
z^{\epsilon_{I}}=\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \xi\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right), \xi\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right)\right)
$$

in $\mathrm{D}_{\delta, \mathbb{C}}$ with critical value

$$
4 \pi^{2}+4 \sqrt{-1} \cdot \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)
$$

Proof. By (2.1), for $i \in I, l_{i}$ is sufficiently small for a sufficiently small $\theta_{i}$. Then by the continuity of $\xi\left(\alpha_{1}, \ldots, \alpha_{6}\right)$, the point $\left(\left(\pi \pm i l_{i}\right)_{i \in I}, \xi\left(\left(\pi \pm i l_{i}\right)_{i \in I}, \alpha_{J}\right), \xi\left(\left(\pi \pm i l_{i}\right)_{i \in I}, \alpha_{J}\right)\right) \in \mathrm{D}_{\delta, \mathbb{C}}$ for sufficiently small $\theta_{1}, \ldots, \theta_{6}$.

For any $\alpha_{I}=\left(\alpha_{i}\right)_{i \in I}$ so that $\left(\alpha_{I}, \xi\left(\alpha_{I}, \alpha_{J}\right), \xi\left(\alpha_{I}, \alpha_{J}\right)\right) \in \mathrm{D}_{\mathrm{H}, \mathrm{C}}$, and for $s=1,2$,

\left.\frac{\partial \mathcal{W}^{\epsilon_{I}}}{\partial \xi_{s}}\right|_{\left(\alpha_{I}, \xi\left(\alpha_{I}, \alpha_{J}\right) \xi\left(\alpha_{I}, \alpha_{J}\right)\right)}=\left.\frac{\partial U}{\partial \xi}\right|_{\left(\left(\alpha_{I}, \alpha_{J}\right), \xi\left(\alpha_{I}, \alpha_{J}\right)\right)}=\left.\frac{\partial U_{\left(\alpha_{I}, \alpha_{J}\right)}}{\partial \xi}\right|_{\xi\left(\alpha_{I}, \alpha_{J}\right)}=0 . \tag{5.1}
\end{equation*}
$$

In particular,

\left.\frac{\partial \mathcal{W}^{\epsilon_{I}}}{\partial \xi_{1}}\right|_{z^{\epsilon_{I}}}=\left.\frac{\partial \mathcal{W}^{\epsilon_{I}}}{\partial \xi_{2}}\right|_{z^{\epsilon_{I}}}=0
$$

Let $\alpha=\left(\alpha_{I}, \alpha_{J}\right)$ and let $W(\alpha)=U(\alpha, \xi(\alpha))$ be the function defined in 3.13). Then for $i \in I$

\left.\frac{\partial W}{\partial \alpha_{i}}\right|_{\alpha}=\left.\frac{\partial U}{\partial \alpha_{i}}\right|_{(\alpha, \xi(\alpha))}+\left.\left.\frac{\partial U}{\partial \xi}\right|_{(\alpha, \xi(\alpha))} \cdot \frac{\partial \xi(\alpha)}{\partial \alpha_{i}}\right|_{\alpha}=\left.\frac{\partial U}{\partial \alpha_{i}}\right|_{(\alpha, \xi(\alpha))} .
$$

Together with Theorem 3.5 and Lemma 2.3, we have

\left.\frac{\partial U}{\partial \alpha_{i}}\right|_{\left(\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right), \xi\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right)\right)} & =\left.\frac{\partial W}{\partial \alpha_{i}}\right|_{\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right)} \\
& =-\left.\epsilon_{i} \mu_{i} \sqrt{-1} \cdot \frac{\partial W}{\partial l_{i}}\right|_{\left(l_{i}\right)_{i \in I}}=\epsilon_{i} \mu_{i} \theta_{i} .
\end{aligned}
$$

Then we have for $i \in I$,

\left.\frac{\partial \mathcal{W}^{\epsilon_{I}}}{\partial \alpha_{i}}\right|_{z^{\epsilon_{I}}} & =-2 \epsilon_{i}\left(\beta_{i}-\pi\right)+\left.2 \frac{\partial U}{\partial \alpha_{i}}\right|_{\left(\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right), \xi\left(\left(\pi+\epsilon_{i} \mu_{i} \sqrt{-1} l_{i}\right)_{i \in I}, \alpha_{J}\right)\right)} \\
& =2 \epsilon_{i}\left(-\left(\beta_{i}-\pi\right)+\mu_{i} \theta_{i}\right)=0,
\end{aligned}
$$

where the last equality comes from that $\mu_{i} \theta_{i}=\beta_{i}-\pi$.
For the critical value, by Theorem 3.5 and $\mu_{i} \theta_{i}=\beta_{i}-\pi$ again, we have

& =4 \pi^{2}+4 \sqrt{-1} \cdot \operatorname{Vol}\left(\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)+\sum_{i \in I} 2 \sqrt{-1}\left(-\mu_{i}\left(\beta_{i}-\pi\right)+\theta_{i}\right) l_{i}\right. \\
& =4 \pi^{2}+4 \sqrt{-1} \cdot \operatorname{Vol}\left(\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right) .\right.
\end{aligned}
$$

### 5.2 Convexity of $\mathcal{W}^{\epsilon_{I}}$

Proposition 5.3. There exists a $\delta_{0}>0$ such that if all $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\left(\pi-\delta_{0}, \pi+\delta_{0}\right)$, then for any $\epsilon_{I}$, $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)$ is strictly concave down in $\left\{\operatorname{Re}\left(\alpha_{i}\right)\right\}_{i \in I}, \operatorname{Re}\left(\xi_{1}\right)$ and $\operatorname{Re}\left(\xi_{2}\right)$, and is strictly concave up in $\left\{\operatorname{Im}\left(\alpha_{i}\right)\right\}_{i \in I}, \operatorname{Im}\left(\xi_{1}\right)$ and $\operatorname{Im}\left(\xi_{2}\right)$ on $\mathrm{D}_{\delta_{0}, \mathbb{C}}$.

Proof. We first consider the special case $\left\{\alpha_{i}\right\}_{i \in I}, \xi_{1}$ and $\xi_{2}$ are real. In this case,

\operatorname{Im}^{\mathcal{W}_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=2 V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{1}\right)+2 V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{2}\right)
$$

with $V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi\right)$ defined in (3.4).
At $\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$, we have $\frac{\partial^{2} \operatorname{Im} \mathcal{W}^{\epsilon} I}{\partial \alpha_{i}^{2}}=-4$ for $i \in I, \frac{\partial^{2} \operatorname{Im} \mathcal{W}^{\epsilon_{I}}}{\partial \alpha_{i} \alpha_{i}^{\prime}}=-2$ for $i \neq i^{\prime} \in I, \frac{\partial^{2} \operatorname{Im} \mathcal{W}^{\epsilon}}{\partial \alpha_{i} \xi_{s}}=$ 4 for $i \in I$ and $s=1,2, \frac{\partial^{2} \operatorname{Im} \mathcal{W}^{\epsilon_{I}}}{\partial \xi_{s}^{2}}=-16$ for $s=1,2$ and $\frac{\partial^{2} \operatorname{Im} \mathcal{W}^{\epsilon}}{\partial \xi_{1} \xi_{2}}=0$. Then a direct computation shows that, at $\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$, the Hessian matrix of $\operatorname{Im}^{\mathcal{L}^{\epsilon_{I}}}$ is negative definite.

Then by the continuity, there exists a sufficiently small $\delta_{0}>0$ such that for all $\left\{\alpha_{j}\right\}_{j \in J}$ in $(\pi-$ $\left.\delta_{0}, \pi+\delta_{0}\right)$ and $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathrm{D}_{\delta_{0}, \mathbb{C}}$, the Hessian matrix of $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$ with respect to $\left\{\operatorname{Re}\left(\alpha_{i}\right)\right\}_{i \in I}, \operatorname{Re}\left(\xi_{1}\right)$ and $\operatorname{Re}\left(\xi_{2}\right)$ is still negative definite, implying that $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$ is strictly concave down in $\left\{\operatorname{Re}\left(\alpha_{i}\right)\right\}_{i \in I}$, $\operatorname{Re}\left(\xi_{1}\right)$ and $\operatorname{Re}\left(\xi_{2}\right)$ on $\mathrm{D}_{\delta_{0}, \mathbb{C}}$. Since $\mathcal{W}^{\epsilon_{I}}$ is holomorphic, $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$ is strictly concave up in $\left\{\operatorname{Im}\left(\alpha_{i}\right)\right\}_{i \in I}$, $\operatorname{Im}\left(\xi_{1}\right)$ and $\operatorname{Im}\left(\xi_{2}\right)$ on $\mathrm{D}_{\delta_{0}, \mathbb{C}}$.

Proposition 5.4. If all $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\left(\pi-\delta_{0}, \pi+\delta_{0}\right)$, then the Hessian matrix $\operatorname{Hess}^{\mathcal{W}}{ }^{\epsilon_{I}}$ of $\mathcal{W}^{\epsilon_{I}}$ with respect to $\left\{\alpha_{i}\right\}_{i \in I}, \xi_{1}$ and $\xi_{2}$ is non-singular on $\mathrm{D}_{\delta_{0}, \mathbb{C}}$.

Proof. By Proposition 5.3, the real part of the Hess $\mathcal{W}^{\epsilon_{I}}$ is negative definite. Then by [21, Lemma], it is nonsingular.

### 5.3 Asymptotics of the leading Fourier coefficients

Proposition 5.5. Suppose $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\{\pi-\epsilon, \pi+\epsilon\}$ for a sufficiently small $\epsilon>0$. For $\epsilon_{I} \in\{1,-1\}^{I}$, let $z^{\epsilon_{I}}$ be the critical point of $\mathcal{W}^{\epsilon_{I}}$ described in Proposition 5.2 Then

\left.\widehat{f_{r}^{\epsilon_{I}}}(0, \ldots, 0)=\frac{C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)}{\sqrt{-\operatorname{det} \operatorname{Hess}\left(\frac{\mathcal{W}^{\epsilon} I\left(z^{\epsilon} I\right.}{}\right.} 4 \pi \sqrt{-1}}\right) e^{\frac{r}{2 \pi} 2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)}\left(1+O\left(\frac{1}{r}\right)\right)
$$

where each $C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)$ depends continuously on $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$; and when $\beta_{i}=\alpha_{j}=\pi$,

$$
C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)=\frac{r^{\frac{|I|}{2}-1}}{2^{\frac{3|I|}{2}+1} \pi^{\frac{|I|}{2}+1}}
$$

For the proof of Proposition 5.5, we need the following
Lemma 5.6. For each $\epsilon_{I} \in\{1,-1\}^{I}$ and any fixed $\left\{\alpha_{j}\right\}_{j \in J}$,

$$
\max _{\mathrm{D}_{\mathrm{H}}} \operatorname{Im} \mathcal{W}^{\epsilon_{I}} \leqslant \operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)=4 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right)
$$

where $\Delta_{(0, \ldots, 0)}$ is the regular ideal octahedron, and the equality holds if and only if $\alpha_{1}=\cdots=\alpha_{6}=\pi$ and $\xi_{1}=\xi_{2}=\frac{7 \pi}{4}$.

Proof. On $\mathrm{D}_{\mathrm{H}}$, we have

$$
\operatorname{Im}_{\mathcal{W}^{\epsilon_{I}}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=2 V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{1}\right)+2 V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{2}\right)
$$

for $V$ defined in (3.4). Then the result is a consequence of the result of Costantino [8] and the MurakamiYano formula [25] (see Ushijima [31] for the case of hyperideal tetrahedra). Indeed, by [8], for a fixed $\alpha=\left(\alpha_{1}, \ldots, \alpha_{6}\right)$ of the hyperideal type, the function $f(\xi)$ defined by $f(\xi)=V(\alpha, \xi)$ is strictly concave down and the unique maximum point $\xi(\alpha)$ exists and lies in $\left(\max \left\{\tau_{i}\right\}, \min \left\{\eta_{j}, 2 \pi\right\}\right)$, ie, $(\alpha, \xi(\alpha)) \in$ $\mathrm{B}_{\mathrm{H}}$. Then by [31], $V(\alpha, \xi(\alpha))=\operatorname{Vol}\left(\Delta_{|\pi-\alpha|}\right)$, the volume of the hyperideal tetrahedron $\Delta_{|\pi-\alpha|}$ with dihedral angles $\left|\pi-\alpha_{1}\right|, \ldots,\left|\pi-\alpha_{6}\right|$. Since $\xi(\pi, \ldots, \pi)=\frac{7 \pi}{4}$ and $\Delta_{(0, \ldots, 0)}$ has the maximum volume among all the hyperideal tetrahedra, $V\left(\pi, \ldots, \pi, \frac{7 \pi}{4}\right)=\operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right) \geqslant \operatorname{Vol}\left(\Delta_{|\pi-\alpha|}\right)=V(\alpha, \xi(\alpha)) \geqslant$ $V(\alpha, \xi)$ for any $(\alpha, \xi) \in \mathrm{B}_{\mathrm{H}}$.

For the equality part, suppose $\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{1}, \xi_{2}\right) \neq\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$. If $\left(\alpha_{1}, \ldots, \alpha_{6}\right) \neq(\pi, \ldots, \pi)$, then $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \leqslant 4 \operatorname{Vol}\left(\Delta_{|\pi-\alpha|}\right)<4 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right)$. If $\left(\alpha_{1}, \ldots, \alpha_{6}\right)=(\pi, \ldots, \pi)$ but, say, $\xi_{1} \neq$ $\frac{7 \pi}{4}$, then the strict concavity of $f(\xi)$ implies that $\operatorname{Im\mathcal {W}}^{\epsilon_{I}}\left(\pi, \ldots, \pi, \xi_{1}, \xi_{2}\right)<\operatorname{Im\mathcal {W}}^{\epsilon_{I}}\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$.

Proof of Proposition 5.5. Let $\delta_{0}>0$ be as in Proposition 5.3. By Lemma 5.3. Proposition 5.6 and the compactness of $\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{0}}$,

$$
4 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right)>\max _{\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{0}}} \operatorname{Im} \mathcal{W}^{\epsilon_{I}}
$$

By Proposition 5.2 and continuity, if $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are sufficiently close to $\pi$, then the critical point $z^{\epsilon_{I}}$ of $\mathcal{W}^{\epsilon_{I}}$ as in Proposition 5.2 lies in $\mathrm{D}_{\delta_{0}, \mathbb{C}}$, and $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)=4 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)$ is sufficiently close to $4 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right)$ so that

\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)>\max _{\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{0}}} \operatorname{Im} \mathcal{W}^{\epsilon_{I}} .
$$

Therefore, we only need to estimate the integral on $\mathrm{D}_{\delta_{0}}$. To do this, we consider as drawn in Figure 4 the surface $S^{\epsilon_{I}}=S_{\text {top }}^{\epsilon_{I}} \cup S_{\text {side }}^{\epsilon_{I}}$ in $\overline{\mathrm{D}_{\delta_{0}, \mathrm{C}}}$, where

S_{\mathrm{top}}^{\epsilon_{I}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \mathrm{D}_{\delta_{0}, \mathbb{C}} \mid\left(\left(\operatorname{Im}\left(\alpha_{I}\right)\right), \operatorname{Im}\left(\xi_{1}\right), \operatorname{Im}\left(\xi_{2}\right)\right)=\operatorname{Im}\left(z^{\epsilon_{I}}\right)\right\}
$$

and

$$
S_{\text {side }}^{\epsilon_{I}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+t \sqrt{-1} \cdot \operatorname{Im}\left(z^{\epsilon_{I}}\right) \mid\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \partial \mathrm{D}_{\delta_{0}}, t \in[0,1]\right\}
$$

By analyticity, the integral remains the same if we deform the domain from $\mathrm{D}_{\delta_{0}}$ to $S^{\epsilon_{I}}$.
By Proposition 5.3. $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$ is concave down on $S_{\text {top }}^{\epsilon_{I}}$. Since $z^{\epsilon_{I}}$ is the critical points of $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$, it is the only absolute maximum on $S_{\text {top }}^{\epsilon_{I}}$.

On the side $S_{\text {side }}^{\epsilon_{I}}$, for each $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \partial \mathrm{D}_{\delta_{0}}$, consider the function

$$
g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(t)=\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+t \sqrt{-1} \cdot \operatorname{Im}\left(z^{\epsilon_{I}}\right)\right)
$$

on $[0,1]$. By Lemma 5.3, $g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(t)$ is concave up for any $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \partial \mathrm{D}_{\delta_{0}}$. As a consequence, $g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(t) \leqslant \max \left\{g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(0), g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(1)\right\}$. Now by the previous two steps, since $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in$ $\partial \mathrm{D}_{\delta_{0}}$,

$$
g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(0)=\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)<\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right) ;
$$

and since $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\sqrt{-1} \cdot \operatorname{Im}\left(z^{\epsilon_{I}}\right) \in S_{\text {top }}^{\epsilon_{I}}$,

$$
g_{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}^{\epsilon_{I}}(0)=\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\sqrt{-1} \cdot \operatorname{Im}\left(z^{\epsilon_{I}}\right)\right)<\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right) .
$$

Therefore, we proved that $z^{\epsilon_{I}}$ is the unique maximum point of $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}$ on $S^{\epsilon_{I}} \cup\left(\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{0}}\right)$, and $\mathcal{W}^{\epsilon_{I}}$ has critical value $4 \pi^{2}+4 \sqrt{-1} \cdot \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right.$ at $z^{\epsilon_{I}}$.

By Proposition 5.4. $\operatorname{det} \operatorname{Hess} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right) \neq 0$.
Finally, we estimate the difference between $\mathcal{W}_{r}^{\epsilon_{I}}$ and $\mathcal{W}^{\epsilon_{I}}$. By Lemma 2.19, (3), we have

Then by Lemma 2.19, in $\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \overline{\mathrm{D}_{\mathrm{H}, \mathrm{C}}^{\delta}}\left|\left|\operatorname{Im}\left(\alpha_{i}\right)\right|<L\right.\right.$ for $\left.i \in I,\left|\operatorname{Im}\left(\xi_{1}\right)\right|<L,\left|\operatorname{Im}\left(\xi_{2}\right)\right|<L\right\}$ for some $L>0$,

\mathcal{W}_{r}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=\mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)-\frac{8 \pi \sqrt{-1}}{r} \log \left(\frac{r}{2}\right)+\frac{4 \pi \sqrt{-1} \cdot \kappa\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}{r}+\frac{\nu_{r}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}{r^{2}},
$$

with

& \kappa\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \\
= & \sum_{i=1}^{4} \sqrt{-1} \tau_{i}-\sqrt{-1} \xi_{1}-\sqrt{-1} \xi_{2}-3 \sqrt{-1} \pi \\
& +\frac{1}{2} \sum_{i=1}^{4} \sum_{j=1}^{3} \log \left(1-e^{2 \sqrt{-1}\left(\eta_{j}-\tau_{i}\right)}\right)-\frac{3}{2} \sum_{i=1}^{4} \log \left(1-e^{2 \sqrt{-1}\left(\tau_{i}-\pi\right)}\right) \\
& +\frac{3}{2} \log \left(1-e^{2 \sqrt{-1}\left(\xi_{1}-\pi\right)}\right)-\frac{1}{2} \sum_{i=1}^{4} \log \left(1-e^{2 \sqrt{-1}\left(\xi_{1}-\tau_{i}\right)}\right)-\frac{1}{2} \sum_{j=1}^{3} \log \left(1-e^{2 \sqrt{-1}\left(\eta_{j}-\xi_{1}\right)}\right) \\
& +\frac{3}{2} \log \left(1-e^{2 \sqrt{-1}\left(\xi_{2}-\pi\right)}\right)-\frac{1}{2} \sum_{i=1}^{4} \log \left(1-e^{2 \sqrt{-1}\left(\xi_{2}-\tau_{i}\right)}\right)-\frac{1}{2} \sum_{j=1}^{3} \log \left(1-e^{2 \sqrt{-1}\left(\eta_{j}-\xi_{2}\right)}\right)
\end{aligned}
$$

and $\left|\nu_{r}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)\right|$ bounded from above by a constant independent of $r$. Then

= & \left(\frac{r}{2}\right)^{-2} e^{\sum_{i \in I} \epsilon_{i} \sqrt{-1}\left(\alpha_{i}+\beta_{i}\right)+\kappa\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)} \cdot e^{\frac{r}{4 \pi \sqrt{-1}}}\left(\mathcal{W}^{\epsilon_{I}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\frac{\nu_{r}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)-\sum_{i \in I} \epsilon_{i} 8 \pi^{2}}{r^{2}}}\right) .
\end{aligned}
$$

Now let $D_{\mathbf{z}}=\left\{\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \overline{\mathrm{D}_{\mathrm{H}, \mathrm{C}}^{\delta}}| | \operatorname{Im}\left(\alpha_{i}\right) \mid<L\right.$ for $\left.i \in I,\left|\operatorname{Im}\left(\xi_{1}\right)\right|<L,\left|\operatorname{Im}\left(\xi_{2}\right)\right|<L\right\}$ for some $L>0$, Let $\mathbf{a}_{r}=\left(\left(\beta_{i}\right)_{i \in I},\left(\alpha_{j}\right)_{j \in J}\right)$ (recall that $\beta_{i}=\frac{2 \pi n_{i}}{r}$ and $\alpha_{j}=\frac{2 \pi m_{j}}{r}$ depends on $r$ ), $f^{\mathbf{a}_{r}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=\frac{\mathcal{W}^{\epsilon} I\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}{4 \pi \sqrt{-1}}, g^{\mathbf{a}_{r}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=\psi\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) e^{\sum_{i \in I} \epsilon_{i} \sqrt{-1}\left(\alpha_{i}+\beta_{i}\right)+\kappa\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}, f_{r}^{\mathbf{a}_{r}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=$ $\frac{\mathcal{W}_{r}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}{4 \pi \sqrt{-1}}-\frac{2}{r} \log \left(\frac{r}{2}\right), v_{r}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)=\nu_{r}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)-\sum_{i \in I} \epsilon_{i} 8 \pi^{2}, S_{r}=S^{\epsilon_{I}} \cup\left(\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{0}}\right)$ and $z^{\epsilon_{I}}$ is the critical point of $f$ in $D_{\mathbf{z}}$. Then all the conditions of Proposition 5.1 are satisfied and the result follows.

When $\beta_{i}=\alpha_{j}=\pi$, a direct computation shows that

$$

Corollary 5.7. If $\epsilon>0$ is sufficiently small and all $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\{\pi-\epsilon, \pi+\epsilon\}$, then

Proof. If $\beta_{i}=\alpha_{j}=\pi$ for all $i \in I$ and $j \in J$, then all $z^{\epsilon_{I}}=\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)$ and all $\mathcal{W}^{\epsilon_{I}}$ are the same functions. As a consequence, all the $C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)$ 's and all Hessian determinants $\operatorname{det} \operatorname{Hess}\left(\frac{\mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon} I\right)}{4 \pi \sqrt{-1}}\right)$ 's are the same at this point, implying that the sum is not equal to zero. Then by continuity, if $\epsilon$ is small enough, then the sum remains non-zero.
Remark 5.8. We suspect that all $C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)$ 's and all det $\operatorname{Hess}\left(\frac{\mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)}{4 \pi \sqrt{-1}}\right)$ 's are always the same for any given $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$.

### 5.4 Estimate of the other Fourier coefficients

Proposition 5.9. Suppose $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\{\pi-\epsilon, \pi+\epsilon\}$ for a sufficiently small $\epsilon>0$. If $\left(m_{I}, n_{1}, n_{2}\right) \neq(0, \ldots, 0)$, then

\left|\widehat{f_{r}^{\epsilon_{I}}}\left(m_{I}, n_{1}, n_{2}\right)\right|<O\left(e^{\frac{r}{2 \pi}\left(2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)-\epsilon^{\prime}\right)}\right)
$$

for some $\epsilon^{\prime}>0$.
Proof. Recall that if $\beta_{i}=\alpha_{j}=\pi$ for all $i \in I$ and $j \in J$, then the total derivative

D \mathcal{W}^{\epsilon_{I}}\left(\pi, \ldots, \pi, \frac{7 \pi}{4}, \frac{7 \pi}{4}\right)=(0, \ldots, 0) .

Hence there exists a $\delta_{1}>0$ and an $\epsilon>0$ such that if $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\{\pi-\epsilon, \pi+\epsilon\}$, then for all $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in D_{\delta_{1}, \mathbb{C}}$ and for any unit vector $\mathbf{u}=\left(\left(u_{i}\right)_{i \in I}, w_{1}, w_{2}\right) \in \mathbb{R}^{|I|+2}$, the directional derivatives

\left|D_{\mathbf{u}} \operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)\right|=\left|\sum_{i \in I} u_{i} \frac{\partial \operatorname{Im} \mathcal{W}^{\epsilon_{I}}}{\partial \operatorname{Im}\left(\alpha_{i}\right)}+w_{1} \frac{\partial \operatorname{Im} \mathcal{W}^{\epsilon_{I}}}{\partial \operatorname{Im}\left(\xi_{1}\right)}+w_{2} \frac{\partial \operatorname{Im} \mathcal{W}^{\epsilon_{I}}}{\partial \operatorname{Im}\left(\xi_{2}\right)}\right|<\frac{2 \pi-\epsilon^{\prime \prime}}{2 \sqrt{2|I|+4}}
$$

for some $\epsilon^{\prime \prime}>0$.
On $D_{H}$, we have

Then by Lemma 5.3. Proposition 5.6 and the compactness of $\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{1}}$,

$$

for some $\epsilon^{\prime \prime \prime}>0$. By Proposition 5.2 and continuity, if $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are sufficiently close to $\pi$, then the critical point $z^{\epsilon_{I}}$ of $\mathcal{W}^{\epsilon_{I}}$ as in Proposition 5.2 lies in $\mathrm{D}_{\delta_{1}, \mathbb{C}}$, and $\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)=4 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)$ is sufficiently close to $4 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right)$ so that

Therefore, we only need to estimate the integral on $\mathrm{D}_{\delta_{1}}$.
If $\left(m_{I}, n_{1}, n_{2}\right) \neq(0, \ldots, 0)$, then there is at least one of $\left\{m_{i}\right\}_{i \in I}, n_{1}$ and $n_{2}$ that is nonzero. Without loss of generality, assume that $m_{1} \neq 0$.

If $m_{1}>0$, then consider the surface $S^{+}=S_{\text {top }}^{+} \cup S_{\text {side }}^{+}$in $\overline{\mathrm{D}_{\delta_{1}, \mathbb{C}}}$ where

On the top, for any $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in S_{\text {top }}^{+}$, by the Mean Value Theorem,

& <\frac{2 \pi-\epsilon^{\prime \prime}}{2 \sqrt{2|I|+4}} \cdot 2 \sqrt{2|I|+4} \delta_{1} \\
& =2 \pi \delta_{1}-\epsilon^{\prime \prime} \delta_{1}
\end{aligned}

where $z$ is some point on the line segment connecting $z^{\epsilon_{I}}$ and $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right), \mathbf{u}=\frac{z^{\epsilon_{I}}-\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)}{\left\|z^{\epsilon}-\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)\right\|}$ and $2 \sqrt{2|I|+4} \delta_{1}$ is the diameter of $\mathrm{D}_{\delta_{1}, \mathrm{C}}$. Then

& <\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)+2 \pi \delta_{1}-\epsilon^{\prime \prime} \delta_{1}-2 \pi \delta_{1} \\
& =\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)-\epsilon^{\prime \prime} \delta_{1} .
\end{aligned}
$$

On the side, for any point $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\left(t \sqrt{-1} \delta_{1}, 0, \ldots, 0\right) \in S_{\text {side }}^{+}$, by the Mean Value Theorem again, we have

\operatorname{Im}^{\epsilon^{\epsilon}}\left(\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\left(t \sqrt{-1} \delta_{1}, 0, \ldots, 0\right)\right)-2 \pi m_{1} t \delta_{1} & <\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)+\frac{2 \pi-\epsilon^{\prime \prime}}{2 \sqrt{2|I|+4}} t \delta_{1}-2 \pi t \delta_{1} \\
& <\operatorname{Im\mathcal {W}}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \\
& <\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)-\epsilon^{\prime \prime \prime}
\end{aligned}
$$

where the last inequality comes from the fact that $\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \partial \mathrm{D}_{\delta_{1}} \subset \mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{1}}$ and 5.2).
Now let $\epsilon^{\prime}=\min \left\{\epsilon^{\prime \prime} \delta_{1}, \epsilon^{\prime \prime \prime}\right\}$, then on $S^{+} \cup\left(\mathrm{D}_{\mathrm{H}} \backslash \mathrm{D}_{\delta_{1}}\right)$,

If $m_{1}<0$, then we consider the surface $S^{-}=S_{\text {top }}^{-} \cup S_{\text {side }}^{-}$in $\overline{\mathrm{D}_{\delta_{1}, \mathbb{C}}}$ where

\operatorname{Im}\left(\mathcal{W}^{\epsilon_{I}}\left(\alpha_{I}, \xi_{1}, \xi_{2}\right)-\sum_{i \in I} 2 \pi m_{i} \alpha_{i}-4 \pi n_{1} \xi_{1}-4 \pi n_{2} \xi_{2}\right)<\operatorname{Im} \mathcal{W}^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)-\epsilon^{\prime}
$$

from which the result follows.

### 5.5 Estimate of the error term

The goal of this section is to estimate the error term in Proposition 4.3 .
Proposition 5.10. Suppose $\left\{\alpha_{j}\right\}_{j \in J}$ are in $\{\pi-\epsilon, \pi+\epsilon\}$ for a sufficiently small $\epsilon>0$. Then the error term in Proposition 4.3 is less than $O\left(e^{\frac{r}{2 \pi}\left(2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)-\epsilon^{\prime}\right)}\right)$ for some $\epsilon^{\prime}>0$.

For the proof we need the following estimate, which first appeared in [13, Proposition 8.2] for $q=$ $e^{\frac{\pi \sqrt{ }-1}{r}}$, and for the root $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$ in [9, Proposition 4.1].
Lemma 5.11. For any integer $0<n<r$ and at $q=e^{\frac{2 \pi \sqrt{-1}}{r}}$,

$$
\log |\{n\}!|=-\frac{r}{2 \pi} \Lambda\left(\frac{2 n \pi}{r}\right)+O(\log (r))
$$

Proof of Proposition 5.10. For a fixed $\alpha_{J}=\left(\alpha_{j}\right)_{j \in J}$, let

$$
M_{\alpha_{J}}=\max \left\{V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{1}\right)+V\left(\alpha_{1}, \ldots, \alpha_{6}, \xi_{2}\right) \mid\left(\alpha_{I}, \xi_{1}, \xi_{2}\right) \in \partial \mathrm{D}_{\mathrm{H}} \cup\left(\mathrm{D}_{\mathrm{A}} \backslash \mathrm{D}_{\mathrm{H}}\right)\right\}
$$

where $V$ is as defined in (3.4). Then by [3, Sections $3 \& 4$ ],

$$
M_{\alpha_{J}}<2 v_{8}=2 \operatorname{Vol}\left(\Delta_{(0, \ldots, 0)}\right) ;
$$

and by continuity, if $\epsilon$ is sufficiently small and $\left\{\theta_{1}, \ldots, \theta_{6}\right\}$ are less than $\epsilon$, then

$$
M_{\alpha_{J}}<2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)
$$

Now by Lemma 5.11 and the continuity, for $\epsilon^{\prime}=\frac{2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)-M_{\alpha_{J}}}{2}$, we can choose a sufficiently small $\delta>0$ so that if $\left(\frac{2 \pi a_{I}}{r}, \frac{2 \pi k_{1}}{r}, \frac{2 \pi k_{2}}{r}\right) \notin \mathrm{D}_{\mathrm{H}}^{\delta}$, then

$$
\left|g_{r}^{\epsilon_{I}}\left(a_{I}, k_{1}, k_{2}\right)\right|<O\left(e^{\frac{r}{2 \pi}\left(M_{\alpha_{J}}+\epsilon^{\prime}\right)}\right)=O\left(e^{\frac{r}{2 \pi}\left(2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)-\epsilon^{\prime}\right)}\right) .
$$

Let $\psi$ be the bump function supported on $\left(\mathrm{D}_{\mathrm{H}}, \mathrm{D}_{\mathrm{H}}^{\delta}\right)$. Then the error term in Proposition 4.3 is less than $O\left(e^{\frac{r}{2 \pi}\left(2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)-\epsilon^{\prime}\right)}\right)$.

### 5.6 Proof of Theorem 1.2

Proof of Theorem [1.2. Let $\epsilon>0$ be sufficiently small so that the conditions of Propositions 5.5, 5.9 and 5.10 and of Corollary 5.7 are satisfied, and suppose $\left\{\beta_{i}\right\}_{i \in I}$ and $\left\{\alpha_{j}\right\}_{j \in J}$ are all in $(\pi-\epsilon, \pi+\epsilon)$.

By Propositions 4.2, 4.3, 5.5, 5.9 and 5.10,

$$
\begin{aligned}
& \widehat{\mathrm{Y}}_{r}\left(b_{I} ; a_{J}\right)=\frac{(-1)^{|I|\left(\frac{r}{2}+1\right)} \cdot n\left(a_{J}\right)}{4\{1\}^{|I|-2}}\left(\sum_{\epsilon_{I} \in\{1,-1\}^{I}} \widehat{f}_{r}^{\epsilon_{I}}\right. \\
&(0, \ldots, 0))\left(1+O\left(e^{\frac{r}{2 \pi}\left(-\epsilon^{\prime}\right)}\right)\right) \\
&=\frac{(-1)^{|I|\left(\frac{r}{2}+1\right)} \cdot n\left(a_{J}\right)}{4\{1\}^{|I|-2}}\left(\sum_{\epsilon_{I} \in\{1,-1\}^{I}} \frac{C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)}{\left.\sqrt{-\operatorname{det} \operatorname{Hess}\left(\frac{\mathcal{W}^{\epsilon}\left(z^{\epsilon_{I}}\right)}{4 \pi \sqrt{-1}}\right.}\right)}\right) e^{\frac{r}{2 \pi} 2 \operatorname{Vol}\left(\Delta\left(\theta_{I} ; \theta_{J}\right)\right)}\left(1+O\left(\frac{1}{r}\right)\right) ;
\end{aligned}
$$

and by Corollary 5.7 .

$$
\sum_{\epsilon_{I} \in\{1,-1\}^{I}} \frac{C^{\epsilon_{I}}\left(z^{\epsilon_{I}}\right)}{\sqrt{-\operatorname{det} \operatorname{Hess}\left(\frac{\mathcal{W}^{\epsilon_{I}\left(z^{\epsilon}\right)}}{4 \pi \sqrt{-1}}\right)} \neq 0, ~, ~ ; ~, ~}
$$

which completes the proof.

## 6 Numerical evidence for Conjecture 1.1

In this appendix we show numerical evidence supporting Conjecture 1.1 . We provide calculations for two deeply truncated tetrahedra of type $((1),(23456))$ and one deeply truncated tetrahedron of every other type in Figure 2, All the calculations are performed with the Mathematica software.

We provide plots for:
(1) Every tetrahedron with five angles equal to 0 and a deeply truncated edge with angle between 0 and $\frac{\pi}{2}$ at $r=2017$.
(2) Two tetrahedra with a single deeply truncated edge.
(3) Two tetrahedra with two deeply truncated edges (one per type).
(4) Three tetrahedra with three deeply truncated edges (one per type).

Because of Proposition 2.15 this actually accounts for all partitions $(I, J)$ up to relabeling.
In every case we show, if a tetrahedron has angle $\alpha$ at an edge, the sequence of colorings we choose for that edge is $\left\lfloor\frac{r}{4 \pi}(\pi-\alpha)\right\rfloor$.

The fact that the angles and lengths we list correspond to hyperbolic tetrahedra can be checked directly from the Gram matrix using Proposition 2.4 .
