# ANISOTROPIC EQUATIONS WITH INDEFINITE POTENTIAL AND COMPETING NONLINEARITIES 

NIKOLAOS S. PAPAGEORGIOU, VICENŢIU D. RĂDULESCU, AND DUŠAN D. REPOVŠ


#### Abstract

We consider a nonlinear Dirichlet problem driven by a variable exponent $p$ Laplacian plus an indefinite potential term. The reaction has the competing effects of a parametric concave (sublinear) term and of a convex (superlinear) perturbation (an anisotropic concave-convex problem). We prove a bifurcation-type theorem describing the changes in the set of positive solutions as the positive parameter $\lambda$ varies. Also, we prove the existence of minimal positive solutions.


## 1. Introduction

Let $\Omega \subseteq \mathbb{R}^{N}$ be a bounded domain with a $C^{2}$-boundary $\partial \Omega$. In this paper we study the following anisotropic boundary value problem

$$
\left\{\begin{array}{l}
-\Delta_{p(z)} u(z)+\xi(z) u(z)^{p(z)-1}=\lambda u(z)^{q(z)-1}+f(z, u(z)) \text { in } \Omega, \\
\left.u\right|_{\partial \Omega}=0, \lambda>0, u>0 .
\end{array}\right.
$$

In this problem, $\Delta_{p(z)}$ denotes the $p(z)$-Laplacian defined by

$$
\Delta_{p(z)} u=\operatorname{div}\left(|D u|^{p(z)-2} D u(z)\right) \text { for all } u \in W_{0}^{1, p(z)}(\Omega) .
$$

Concerning the exponents $p, q: \bar{\Omega} \rightarrow \mathbb{R}$, we assume that both are functions belonging to $C^{1}(\bar{\Omega})$ and we have

$$
1<q_{-} \leq q(z) \leq q_{+}<p_{-} \leq p(z) \leq p_{+} \text {for all } z \in \bar{\Omega} .
$$

The potential function $\xi \in L^{\infty}(\Omega)$ is sign-changing. So, the differential operator of $\left(P_{\lambda}\right)$ (left-hand side) is not coercive. In the reaction (right-hand side of $\left(P_{\lambda}\right)$ ), we have a parametric term with $\lambda>0$ being the parameter and a perturbation $f(z, x)$ which is jointly measurable and of class $C^{1}$ in the $x$-variable. We assume that $f(z, \cdot)$ exhibits $\left(p_{+}-1\right)$-superlinear growth near $+\infty$ without satisfying the usual in such cases Ambrosetti-Rabinowitz condition ( $A R$-condition for short). So, in the reaction of problem $\left(P_{\lambda}\right)$ we have the competing effects of a sublinear (concave) term and of a superlinear (convex) term. We are looking for positive solutions and our aim is to have a precise description of the changes in the set of positive solutions as the parameter $\lambda>0$ varies (a bifurcation-type result).

The study of such parametric concave-convex problems started with the seminal paper of Ambrosetti, Brezis and Cerami [1], where $p(z)=2$ for all $z \in \bar{\Omega}$ (semilinear isotropic problem). It was extended to equations driven by the $p$-Laplacian and with the reaction being $\lambda x^{q-1}+x^{r-1}$ for all $x \geq 0$ with $1<q<p<r<p^{*}$ by Garcia Azorero, Manfredi and Peral Alonso [11], and Guo and Zhang [14]. Recall that

$$
p^{*}= \begin{cases}\frac{N p}{N-p}, & \text { if } p \leq N \\ +\infty, & \text { if } N<p\end{cases}
$$

[^0]Further extensions can be found in the works of Marano and Papageorgiou [17] and Papageorgiou and Rădulescu [18]. All the aforementioned works deal with isotropic equations. To the best of our knowledge, no such results exist for anisotropic equations.

Additional parametric boundary value problems driven by operators with variable exponents and applications, can be found in the book of Rădulescu and Repovš [26]. We also refer to the recent papers [4, 5, 6, 20, 21, 22, 23, 25, 30, all dealing with isotropic or anisotropic nonlinear problems with Dirichlet boundary condition.

## 2. Mathematical background, auxiliary results and hypotheses

In this section we briefly review some basic facts about variable exponent spaces and we prove two anisotropic strong comparison theorems which we will need in our analysis of problem $\left(P_{\lambda}\right)$.

A comprehensive presentation of variable exponent Lebesgue and Sobolev spaces can be found in the book of Diening, Harjulehto, Hästo and Ruzička [7].

So, let $L_{1}^{\infty}(\Omega)=\left\{p \in L^{\infty}(\Omega): \operatorname{essinf}_{\Omega} p \geq 1\right\}$. For $p \in L_{1}^{\infty}(\Omega)$, we set

$$
p_{-}=\operatorname{essinf}_{\Omega} p \quad \text { and } \quad p_{+}=\operatorname{esssup}_{\Omega} p
$$

Also let $M(\Omega)=\{u: \Omega \rightarrow \mathbb{R}: u(\cdot)$ is measurable $\}$. As usual, we identify two such functions which differ on a set of zero measure.

Given $p \in L_{1}^{\infty}(\Omega)$, we define the following variable exponent Lebesgue space

$$
L^{p(z)}(\Omega)=\left\{u \in M(\Omega): \int_{\Omega}|u|^{p(z)} d z<+\infty\right\} .
$$

We equip $L^{p(z)}(\Omega)$ with the following norm (known as the Luxemburg norm)

$$
\|u\|_{p(z)}=\inf \left\{\lambda>0: \int_{\Omega}\left(\frac{|u|}{\lambda}\right)^{p(z)} d z \leq 1\right\}
$$

Having defined variable exponent Lebesgue spaces, we can introduce variable exponent Sobolev spaces by

$$
W^{1, p(z)}(\Omega)=\left\{u \in L^{p(z)}(\Omega):|D u| \in L^{p(z)}(\Omega)\right\} .
$$

We equip this space with the following norm

$$
\|u\|_{1, p(z)}=\|u\|_{p(z)}+\|D u\|_{p(z)} .
$$

An equivalent norm of $W^{1, p(z)}(\Omega)$ is given by

$$
\|u\|_{1, p(z)}^{\prime}=\inf \left\{\lambda>0: \int_{\Omega}\left(\left(\frac{|D u|}{\lambda}\right)^{p(z)}+\left(\frac{|u|}{\lambda}\right)^{p(z)}\right) d z \leq 1\right\}
$$

We define $W_{0}^{1, p(z)}(\Omega)$ as the closure in the $\|\cdot\|_{1, p(z)}$ of all compactly supported $W^{1, p(z)}(\Omega)$ functions.

When $p \in L_{1}^{\infty}(\Omega)$ and $p_{-}>1$, then the spaces $L^{p(z)}(\Omega), W^{1, p(z)}(\Omega)$ and $W_{0}^{1, p(z)}(\Omega)$ are all separable, reflexive and uniformly convex.

We set

$$
p^{*}(z)= \begin{cases}\frac{N p(z)}{N-p(z)}, & \text { if } p(z)<N \\ +\infty, & \text { if } p(z) \geq N\end{cases}
$$

If $p, q \in C(\bar{\Omega}), p_{+}<N$ and $1 \leq q(z) \leq p^{*}(z)$ (resp. $1 \leq q(z)<p^{*}(z)$ ) for all $z \in \bar{\Omega}$, then $W^{1, p(z)}(\Omega)$ and $W_{0}^{1, p(z)}(\Omega)$ are embedded continuously (resp. compactly) into $L^{q(z)}(\Omega)$.

If $p, p^{\prime} \in L_{1}^{\infty}(\Omega)$ and $\frac{1}{p(z)}+\frac{1}{p^{\prime}(z)}=1$, then $L^{p(z)}(\Omega)^{*}=L^{p^{\prime}(z)}(\Omega)$ and we have the following Hölder type inequality

$$
\int_{\Omega}|u v| d z \leq\left(\frac{1}{p_{-}}+\frac{1}{p_{-}^{\prime}}\right)\|u\|_{p(z)}\|v\|_{p^{\prime}(z)} \text { for all } u \in L^{p(z)}(\Omega), v \in L^{p^{\prime}(z)}(\Omega) .
$$

We say that $p \in C(\bar{\Omega})$ is logarithmic Hölder continuous (denoted by $p \in C^{0, \frac{1}{\ln t \mid}}$ ) if it satisfies

$$
\left|p(z)-p\left(z^{\prime}\right)\right| \leq \frac{c}{|\ln | z-z^{\prime}| |} \text { for some } c>0, \text { all } z, z^{\prime} \in \Omega,\left|z-z^{\prime}\right| \leq \frac{1}{2}
$$

Note that $C^{0,1}(\bar{\Omega}) \hookrightarrow C^{0, \frac{1}{\ln t \mid}}(\bar{\Omega})$. Also, when $p \in C^{0, \frac{1}{\ln t \mid}}(\bar{\Omega})$, then

$$
W_{0}^{1, p(z)}(\Omega)=\overline{C_{c}^{\infty}(\bar{\Omega})} \|^{\|\cdot\|_{1, p(z)}} .
$$

Moreover, in this case the Poincaré inequality holds and we have

$$
\|u\|_{p(z)} \leq \hat{C}\|D u\|_{p(z)} \text { for all } u \in W_{0}^{1, p(z)}(\Omega)
$$

where $\hat{C}>0$ depends only on $\left(p, N,|\Omega|_{N}\right.$, $\operatorname{diam} \Omega$ ), with $|\cdot|_{N}$ denoting the Lebesgue measure on $\mathbb{R}^{N}$. So, when $p \in C^{0, \frac{1}{\ln t \mid}(\bar{\Omega}) \text {, then on the Sobolev space } W_{0}^{1, p(z)}(\Omega) \text {, we can use the }}$ equivalent norm

$$
\|u\|=\|D u\|_{p(z)} \text { for all } u \in W_{0}^{1, p(z)}(\Omega) .
$$

We introduce the following modular functions

$$
\begin{aligned}
& \rho(u)=\int_{\Omega}|u|^{p(z)} d z \text { for all } u \in L^{p(z)}(\Omega), \\
& \hat{\rho}(D u)=\int_{\Omega}|D u|^{p(z)} d z \text { for all } u \in W_{0}^{1, p(z)}(\Omega) .
\end{aligned}
$$

We have the following property.
Proposition 2.1. (a) For $u \in L^{p(z)}(\Omega), u \neq 0$, we have

$$
\|u\|_{p(z)}=\lambda \Leftrightarrow \rho\left(\frac{u}{\lambda}\right)=1
$$

(b) $\|u\|_{p(z)}<1$ (resp. $=1,>1$ ) $\Leftrightarrow \rho(u)<1$ (resp. $=1,>1$ );
(c) $\|u\|_{p(z)}<1 \Rightarrow\|u\|_{p(z)}^{p_{+}} \leq \rho(u) \leq\|u\|_{p(z)}^{p_{-}}$and $\|u\|_{p(z)}>1 \Rightarrow\|u\|_{p(z)}^{p_{-}} \leq \rho(u) \leq\|u\|_{p(z)}^{p_{+}}$;
(d) $\left\|u_{n}\right\|_{p(z)} \rightarrow 0 \Leftrightarrow \rho\left(u_{n}\right) \rightarrow 0$;
(e) $\left\|u_{n}\right\|_{p(z)} \rightarrow+\infty \Leftrightarrow \rho\left(u_{n}\right) \rightarrow+\infty$.

Proposition 2.2. (a) For $u \in W_{0}^{1, p(z)}(\Omega), u \neq 0$, we have

$$
\|u\|=\lambda \Leftrightarrow \hat{\rho}\left(\frac{D u}{\lambda}\right)=1 ;
$$

(b) $\|u\|<1$ (resp. $=1,>1) \Leftrightarrow \hat{\rho}(D u)<1$ (resp. $=1,>1$ );
(c) $\|u\|<1 \Rightarrow\|u\|^{p_{+}} \leq \hat{\rho}(D u) \leq\|u\|^{p_{-}}$and $\|u\|>1 \Rightarrow\|u\|^{p_{-}} \leq \hat{\rho}(D u) \leq\|u\|^{p_{+}}$;
(d) $\left\|u_{n}\right\| \rightarrow 0 \Leftrightarrow \hat{\rho}\left(D u_{n}\right) \rightarrow 0$; (e) $\left\|u_{n}\right\| \rightarrow+\infty \Leftrightarrow \hat{\rho}\left(D u_{n}\right) \rightarrow+\infty$.

Let $p \in C^{0, \frac{1}{\ln t \mid}}(\bar{\Omega})$. Then

$$
W_{0}^{1, p(z)}(\Omega)^{*}=W^{-1, p^{\prime}(z)}(\Omega) \quad\left(\frac{1}{p(z)}+\frac{1}{p^{\prime}(z)}=1\right) .
$$

Consider the operator $A: W_{0}^{1, p(z)}(\Omega) \rightarrow W^{-1, p^{\prime}(z)}(\Omega)=W_{0}^{1, p(z)}(\Omega)^{*}$ defined by

$$
\langle A(u), h\rangle=\int_{\Omega}|D u|^{p(z)-2}(D u, D h)_{\mathbb{R}^{N}} d z \text { for all } u, h \in W_{0}^{1, p(z)}(\Omega)
$$

This operator has the following properties (see Gasinski and Papageorgiou [12]).
Proposition 2.3. The map $A: W_{0}^{1, p(z)}(\Omega) \rightarrow W^{-1, p^{\prime}(z)}(\Omega)$ defined above is bounded (that $i s$, maps bounded sets to bounded sets), continuous, strictly monotone (hence maximal monotone, too) and of type $(S)_{+}$, that is $u_{n} \xrightarrow{w} u$ in $W_{0}^{1, p(z)}(\Omega)$ and $\limsup _{n \rightarrow \infty}\left\langle A\left(u_{n}\right),\left(u_{n}-u\right)\right\rangle \leq 0$ $\Rightarrow u_{n} \rightarrow u$ in $W_{0}^{1, p(z)}(\Omega)$.

Next, we prove two strong comparison theorems, which will be used in the analysis of problem $\left(P_{\lambda}\right)$. The first one extends Proposition 2.6 of Arcoya and Ruiz [3] to the abstract setting of anisotropic problems .

We will use the following notation. Given $h, g \in L^{\infty}(\Omega)$, we write that $h \prec g$ if and only if for every $K \subseteq \Omega$ compact, we can find $c_{K}>0$ such that $0<c_{K} \leq g(z)-h(z)$ for a.a. $z \in K$. Evidently, if $h, g \in C(\Omega)$ and $h(z)<g(z)$ for all $z \in \Omega$, then $h \prec g$. Also, by $C_{+}$we denote the positive cone of $C_{0}^{1}(\bar{\Omega})=\left\{u \in C^{1}(\bar{\Omega}):\left.u\right|_{\partial \Omega}=0\right\}$, that is, $C_{+}=\left\{u \in C_{0}^{1}(\bar{\Omega}): u(z) \geq 0\right.$ for all $\left.z \in \bar{\Omega}\right\}$. This cone has a nonempty interior given by

$$
\operatorname{int} C_{+}=\left\{u \in C_{+}: u(z)>0 \text { for all } z \in \Omega,\left.\frac{\partial u}{\partial n}\right|_{\partial \Omega}<0\right\}
$$

with $n(\cdot)$ being the outward unit normal on $\partial \Omega$.
Proposition 2.4. If $p \in C^{1}(\bar{\Omega}), 1<p(z)$ for all $z \in \bar{\Omega}, \hat{\xi}, h, g \in L^{\infty}(\Omega), \hat{\xi}(z) \geq 0$ for a.a. $z \in \Omega, h \prec g, u \in W^{1, p(z)}(\Omega), u \neq 0, v \in \operatorname{int} C_{+}$and

$$
\begin{aligned}
& -\Delta_{p(z)} u+\hat{\xi}(z)|u|^{p(z)-2} u=h(z) \text { in } \Omega,\left.u\right|_{\partial \Omega} \leq 0, \\
& -\Delta_{p(z)} v+\hat{\xi}(z) v^{p(z)-1}=g(z) \text { in } \Omega,\left.\frac{\partial v}{\partial n}\right|_{\partial \Omega}<0,
\end{aligned}
$$

then $v-u \in \operatorname{int} C_{+}$.
Proof. From Theorem 4.1 of Fan and Zhao [9] (see also Proposition 3.1 of Gasinski and Papageorgiou [12]), we have that $u \in L^{\infty}(\Omega)$. Then invoking Theorem 1.3 of Fan [8], we infer that $u \in C^{1}(\bar{\Omega})$. Also exploiting the monotonicity of $A(\cdot)$ (see Proposition [2.3), we see that $u \leq v$. We introduce the following two sets.

$$
E=\{z \in \Omega: u(z)=v(z)\} \text { and } \hat{E}=\{z \in \Omega: D u(z)=D v(z)=0\}
$$

Claim. $E \subseteq \hat{E}$.
Let $y=u-v$. We have $y \leq 0$. Consider $z \in E$. Then $y(z)=\max _{\Omega} y=0$. So, we have $D y(z)=0$, hence $D u(z)=D v(z)$. Arguing by contradiction, suppose that $z \notin \hat{E}$. Then $D v(z) \neq 0$ and so we can find an open ball $B \subseteq \Omega$ centered at $z$ such that

$$
|D u(x)|>0,|D v(x)|>0,(D u(x), D v(x))_{\mathbb{R}^{N}}>0 \text { for all } x \in B
$$

Consider the $N \times N$ matrix $A(x)=\left(a_{i j}(x)\right)_{i, j=1}^{N}$ with entries $a_{i j}(x)$ defined by $a_{i j}(x)=\int_{0}^{1}[(1-t) D u(x)+t D v(x)]\left[\delta_{i j}+(p(x)-2) \frac{D_{i}((1-t) u+t v) D_{j}((1-t) u+t v)}{|(1-t) D u+t D v|^{2}}\right] d t$

We have $a_{i j} \in C^{0, \alpha}(\bar{B})$ for some $\alpha \in(0,1)$ (see Fan [8]) and

$$
\begin{equation*}
-\operatorname{div}(A(x) D y(x))=h(x)-g(x)-\hat{\xi}(x)\left[|u(x)|^{p(x)-2} u(x)-v(x)^{p(x)-1}\right] \text { in } B \tag{1}
\end{equation*}
$$

(see also Guedda and Véron [13]). By choosing the ball $B \subseteq \Omega$ even smaller if necessary, we obtain that in (11) the linear differential operator is strictly elliptic, while the right-hand side is strictly negative. Invoking Theorem 4 of Vázquez [28], we have

$$
\begin{aligned}
& y(x)<0 \text { for all } x \in B \\
\Rightarrow \quad & y(z)<0, \text { a contradiction. }
\end{aligned}
$$

Therefore $z \in \hat{E}$ and this proves the claim.
Recall that $v \in \operatorname{int} C_{+}$. Therefore $\hat{E}$ is compact and so we can find $U \subseteq \Omega$ such that

$$
\begin{equation*}
\hat{E} \subseteq U \subseteq \bar{U} \subseteq \Omega \tag{2}
\end{equation*}
$$

For $\varepsilon>0$ small, we have

$$
\begin{align*}
& u(z)+\varepsilon<v(z) \text { for all } z \in \partial U(\text { see (22) }),  \tag{3}\\
& h(z)+\varepsilon<g(z) \text { for a.a. } z \in U \text { (recall that } h \prec g) . \tag{4}
\end{align*}
$$

We choose $\delta>0$ small so that

$$
\begin{align*}
& \left|\hat{\xi}(z)\left(|x|^{p(z)-2} x-|w|^{p(z)-2} w\right)\right| \\
\leq & \left.\|\hat{\xi}\|_{\infty}| | x\right|^{p(z)-2} x-|w|^{p(z)-2} w \mid<\varepsilon  \tag{5}\\
& \text { if }|x-w|<\delta, z \in \bar{U}\left(\text { recall that } p \in C^{1}(\bar{\Omega})\right) .
\end{align*}
$$

Then we have for a.a. $z \in U$

$$
\begin{aligned}
& -\Delta_{p(z)}(u+\delta)+\hat{\xi}(z)|u+\delta|^{p(z)-2}(u+\delta) \\
= & -\Delta_{p(z)} u+\hat{\xi}(z)|u+\delta|^{p(z)-2}(u+\delta) \\
= & h(z)+\hat{\xi}(z)\left[|u+\delta|^{p(z)-2}(u+\delta)-|u|^{p(z)-2} u\right] \\
\leq & h(z)+\varepsilon(\text { see (何) }) \\
< & g(z)(\text { see (44) }) \\
= & -\Delta_{p(z)} v+\hat{\xi}(z) v^{p(z)-1}, \\
\Rightarrow & u(z)+\delta \leq v(z) \text { for all } z \in \bar{U} \\
& \text { (by the weak comparison principle, see (3) ) }), \\
\Rightarrow & u(z)<v(z) \text { for all } z \in \bar{U}, \\
\Rightarrow & E=\emptyset .
\end{aligned}
$$

Also, from the anisotropic maximum principle of Zhang [29], we have

$$
\begin{aligned}
& \left.\frac{\partial y}{\partial n}\right|_{\partial \Omega}>0 \\
\Rightarrow & \left.\frac{\partial(v-u)}{\partial n}\right|_{\partial \Omega}<0 .
\end{aligned}
$$

The proof is now complete.

For the second strong comparison principle, we use the following open cone in $C^{1}(\bar{\Omega})$

$$
D_{+}=\left\{u \in C^{1}(\bar{\Omega}): u(z)>0 \text { for all } z \in \Omega,\left.u\right|_{\partial \Omega \cap U^{-1}(0)}<0\right\} .
$$

Proposition 2.5. If $p \in C^{1}(\bar{\Omega}), 1<p(z)$ for all $z \in \bar{\Omega}, \hat{\xi}, h, g \in L^{\infty}(\Omega), \hat{\xi}(z) \geq 0$ for a.a. $z \in \Omega, 0<\eta \leq g(z)-h(z)$ for a.a. $z \in \Omega$ and $u, v \in C^{1}(\bar{\Omega})$ satisfy $u \leq v$ and

$$
\begin{aligned}
& -\Delta_{p(z)} u+\hat{\xi}(z)|u|^{p(z)-2} u=h(z) \text { in } \Omega \\
& -\Delta_{p(z)} v+\hat{\xi}(z)|v|^{p(z)-2} v=g(z) \text { in } \Omega
\end{aligned}
$$

then $v-u \in D_{+}$.
Proof. The reasoning is similar to that of the previous proposition.
Let $w=v-u \geq 0, w \in C^{1}(\bar{\Omega})$. As in the proof of Proposition 2.4, we have

$$
\begin{equation*}
-\operatorname{div}(A(z) D w)=g(z)-h(z)-\hat{\xi}(z)\left[|v|^{p(z)-2} v-|u|^{p(z)-2} u\right] \text { in } \Omega \tag{6}
\end{equation*}
$$

In this case we have $a_{i j} \in W^{1, \infty}(\Omega)$ for all $i, j=1, \ldots, N$.
Suppose that for some $z_{0} \in \Omega$, we have $w\left(z_{0}\right)=0$. Then $u\left(z_{0}\right)=v\left(z_{0}\right)$. The map $(z, x) \mapsto|x|^{p(z)-2} x$ is uniformly continuous on $\bar{\Omega} \times \mathbb{R}$. So, we can find $\delta>0$ small such that

$$
g(z)-h(z)-\left.\hat{\xi}(z)| | v(z)\right|^{p(z)-2} v(z)-|u(z)|^{p(z)-2} u(z) \left\lvert\, \geq \frac{\eta}{2}>0\right.
$$

for a.a. $z \in B_{\delta}\left(z_{0}\right)=\left\{z \in \Omega:\left|z-z_{0}\right|<\delta\right\}$.
From (6) we have

$$
-\operatorname{div}(A(z) D w) \geq \frac{\eta}{2}>0 \text { for a.a. } z \in B_{\delta}\left(z_{0}\right)
$$

Invoking Theorem 4 of Vázquez [28], we have

$$
w(z)>0 \text { for all } z \in B_{\delta}\left(z_{0}\right)
$$

a contradiction to the fact that $w\left(z_{0}\right)=0$. Therefore

$$
w(z)>0 \text { for all } z \in \Omega
$$

Let $E_{0}=\{z \in \partial \Omega: w(z)=0\}$. We can assume that $E_{0} \neq \emptyset$. Otherwise we already have that $v(z)>u(z)$ for all $z \in \bar{\Omega}$ and we are done. By Zhang [29] we have

$$
\begin{aligned}
& \frac{\partial w}{\partial n}\left(z_{0}\right)<0 \\
\Rightarrow & w=v-u \in D_{+}
\end{aligned}
$$

The proof is now complete.
Now we introduce our hypotheses on the data of problem $\left(P_{\lambda}\right)$.
$H_{0}: p, q \in C^{1}(\bar{\Omega})$ and $1<q_{-} \leq q(z) \leq q_{+}<p_{-} \leq p(z) \leq p_{+}$for all $z \in \bar{\Omega}, \xi \in L^{\infty}(\Omega)$.
$H_{1}: f: \Omega \times \mathbb{R} \rightarrow \mathbb{R}$ is a function which for all $x \in \mathbb{R}$, is measurable in $z \in \Omega$, for a.a. $z \in \Omega$ we have $f(z, \cdot) \in C^{1}(\mathbb{R})$ and
(i) $a \leq f(z, x) \leq a(z)\left(1+x^{r(z)-1}\right)$ for a.a. $z \in \Omega$, all $x \in \mathbb{R}$, with $a \in L^{\infty}(\Omega), r \in C(\bar{\Omega})$ and $p_{+}<r(z)<p(z)^{*}$ for all $z \in \bar{\Omega}$;
(ii) if $F(z, x)=\int_{0}^{x} f(z, s) d s$, then $\lim _{x \rightarrow+\infty} \frac{F(z, x)}{x^{p_{+}}}=+\infty$ uniformly for a.a. $z \in \Omega$;
(iii) if $e(z, x)=f(z, x) x-p_{+} F(z, x)$, then there exist $M>0$ and $\hat{C}>\|\xi\|_{\infty}\left(\frac{p_{+}}{p_{-}}-1\right)$ such that

$$
e_{x}^{\prime}(z, x) \geq \hat{C} x^{p(z)-1} \text { for a.a. } z \in \Omega, \text { all } x \geq M
$$

(iv) $\lim _{x \rightarrow 0^{+}} \frac{f(z, x)}{x^{p_{-}-1}}=0$ uniformly for a.a. $z \in \Omega$.

Remark 2.6. Since we are looking for positive solutions and all the above hypotheses concern the positive semi-axis $\mathbb{R}_{+}=[0,+\infty)$, without any loss of generality, we may assume that

$$
\begin{equation*}
f(z, x)=0 \text { for a.a. } z \in \Omega, \text { all } x \leq 0 . \tag{7}
\end{equation*}
$$

Remark 2.7. Hypothesis $H_{1}(i i)$ implies that for a.a. $z \in \Omega$, the function $F(z, \cdot)$ is $p_{+-}$ superlinear. This combined with hypothesis $H_{1}(i i i)$, says that for a.a. $z \in \Omega, f(z, \cdot)$ is ( $p_{+}-1$ )-superlinear. However, the superlinearity of $f(z, \cdot)$ is not expressed using the usual for such problems $A R$-condition (see Ambrosetti and Rabinowitz [2]). Instead we employ the less restrictive condition $H_{1}(i i i)$ that permits the consideration of $\left(p_{+}-1\right)$-superlinear functions with "slower" growth near $+\infty$, which fail to satisfy the $A R$-condition (see the examples below). Note that hypothesis $H_{1}(i i i)$ is not global and implies that for a.a. $z \in \Omega$, eventually $e(z, \cdot)$ is nondecreasing. Then Lemma 2.4(iv) of Li and Yang 16, implies that there exists $\mu \in L^{1}(\Omega)$ such that

$$
\begin{equation*}
e(z, x) \leq e(z, y)+\mu(z) \text { for a.a. } z \in \Omega, \text { all } 0 \leq x \leq y \tag{8}
\end{equation*}
$$

(a global quasi-monotonicity condition on $e(z, \cdot)$ ). Also it is equivalent to saying that there exists $\hat{M}>0$ such that for a.a. $z \in \Omega$, the function

$$
x \mapsto \frac{f(z, x)}{x^{p_{+}-1}}
$$

is nondecreasing on $[\hat{M},+\infty)$ (see Li and Yang [16]).
Example 2.8. Consider the following two functions

$$
\begin{gathered}
f_{1}(z, x)=x^{r(z)-1} \text { for all } x \geq 0, \\
f_{2}(z, x)=\left\{\begin{array}{ll}
\hat{C} x^{r(z)-1}, & \text { if } x \in[0,1] \\
\hat{C}\left(x^{p(z)-1}+x^{m(z)-1}\right), & \text { if } 1<x
\end{array} \quad\right. \text { (see (7)). }
\end{gathered}
$$

with $r, m \in C(\bar{\Omega}), p_{+}<r(z)<p(z)^{*}, m(z) \leq p(z)$ and $r(z)=p(z)+m(z)-2$.
Note that $f_{1}(z, \cdot)$ satisfies the $A R$-condition, while $f_{2}(z, \cdot)$ need not (the $A R$-condition is not satisfied if $\left\{z \in \bar{\Omega}: m(z)=p_{+}\right\}$has nonempty interior).

Finally, we mention that if $X$ is a Banach space and $\varphi \in C^{1}(X, \mathbb{R})$, then $K_{\varphi}$ denotes the critical set of $\varphi$, that is,

$$
K_{\varphi}=\left\{u \in X: \varphi^{\prime}(u)=0\right\} .
$$

Moreover, a set $S \subseteq W_{0}^{1, p(z)}(\Omega)$ is said to be "downward directed", if given $u, v \in S$, we can find $w \in S$ such that $w \leq u, w \leq v$. In addition if $u, v \in W_{0}^{1, p(z)}(\Omega)$ with $u \leq v$, then we define

$$
\begin{aligned}
& {[u, v]=\left\{y \in W_{0}^{1, p(z)}(\Omega): u(z) \leq y(z) \leq v(z) \text { for a.a. } z \in \Omega\right\}} \\
& \operatorname{int}_{C_{0}^{1}(\bar{\Omega})}[u, v]=\text { the interior in } C_{0}^{1}(\bar{\Omega}) \text { of }[u, v] \cap C_{0}^{1}(\bar{\Omega}), \\
& {[u)=\left\{y \in W_{0}^{1, p(z)}(\Omega): u(z) \leq y(z) \text { for a.a. } z \in \Omega\right\} .}
\end{aligned}
$$

## 3. Positive solutions

We introduce the following two sets:

$$
\begin{aligned}
& \mathcal{L}=\left\{\lambda>0: \text { problem }\left(P_{\lambda}\right) \text { admits a positive solution }\right\}, \\
& S_{\lambda}=\text { set of positive solutions of problem }\left(P_{\lambda}\right)
\end{aligned}
$$

Let $\vartheta>\|\xi\|_{\infty}$ (see hypothesis $H_{0}$ ), $\lambda>0$ and consider the functional $\hat{\varphi}_{\lambda}: W_{0}^{1, p(z)}(\Omega) \rightarrow \mathbb{R}$ defined by

$$
\begin{aligned}
\hat{\varphi}_{\lambda}(u) & =\int_{\Omega} \frac{1}{p(z)}|D u|^{p(z)} d z+\int_{\Omega} \frac{\xi(z)}{p(z)}|u|^{p(z)} d z+\int_{\Omega} \frac{\vartheta}{p(z)}\left(u^{-}\right)^{p(z)} d z \\
& -\lambda \int_{\Omega} \frac{1}{q(z)}\left(u^{+}\right)^{q(z)} d z-\int_{\Omega} F\left(z, u^{+}\right) d z \text { for all } u \in W_{0}^{1, p(z)}(\Omega)
\end{aligned}
$$

Recall that $u^{+}=\max \{u, 0\}, u^{-}=\max \{-u, 0\}$ and if $u \in W_{0}^{1, p(z)}(\Omega)$, then

$$
u^{+}, u^{-} \in W_{0}^{1, p(z)}(\Omega), u=u^{+}-u^{-},|u|=u^{+}+u^{-} .
$$

We have that $\hat{\varphi}_{\lambda}(\cdot) \in C^{1}\left(W_{0}^{1, p(z)}(\Omega)\right)$ (see Rădulescu and Repovš [26, p. 31]).
Proposition 3.1. If hypotheses $H_{0}, H_{1}$ hold and $\lambda>0$, then $\hat{\varphi}_{\lambda}(\cdot)$ satisfies the $C$-condition.
Proof. We consider a sequence $\left\{u_{n}\right\}_{n \geq 1} \subseteq W_{0}^{1, p(z)}(\Omega)$ such that

$$
\begin{align*}
& \left|\hat{\varphi}_{\lambda}\left(u_{n}\right)\right| \leq M_{1} \text { for some } M_{1}>0, \text { all } n \in \mathbb{N},  \tag{9}\\
& \left(1+\left\|u_{n}\right\|\right) \hat{\varphi}_{\lambda}^{\prime}\left(u_{n}\right) \rightarrow 0 \text { in } W^{-1, p^{\prime}(z)}(\Omega)=W_{0}^{1, p(z)}(\Omega)^{*} \text { as } n \rightarrow \infty . \tag{10}
\end{align*}
$$

From (10) we have

$$
\begin{align*}
\left|\left\langle\hat{\varphi}_{\lambda}^{\prime}\left(u_{n}\right), h\right\rangle\right| \leq & \frac{\varepsilon_{n}\|h\|}{1+\left\|u_{n}\right\|} \text { for all } h \in W_{0}^{1, p(z)}(\Omega), \text { all } n \in \mathbb{N}, \text { with } \varepsilon_{n} \rightarrow 0^{+} \\
\Rightarrow \mid\left\langle A\left(u_{n}\right), h\right\rangle+ & \int_{\Omega} \xi(z)\left|u_{n}\right|^{p(z)-2} u_{n} h d z-\int_{\Omega} \vartheta\left(u_{n}^{-}\right)^{p(z)-1} h d z \\
- & \lambda \int_{\Omega}\left(u_{n}^{+}\right)^{q(z)-1} h d z-\int_{\Omega} f\left(z, u_{n}^{+}\right) h d z \left\lvert\, \leq \frac{\varepsilon_{n}\|h\|}{1+\left\|u_{n}\right\|}\right.  \tag{11}\\
& \quad \text { for all } h \in W_{0}^{1, p(z)}(\Omega), n \in \mathbb{N} .
\end{align*}
$$

In (11) we choose $h=-u_{n}^{-} \in W_{0}^{1, p(z)}(\Omega)$. We have

$$
\begin{align*}
& \left|\hat{\rho}\left(D u_{n}^{-}\right)+\int_{\Omega}[\xi(z)+\vartheta]\left(u_{n}^{-}\right)^{p(z)} d z\right| \leq \varepsilon_{n} \text { for all } n \in \mathbb{N}, \\
\Rightarrow & u_{n}^{-} \rightarrow 0 \text { in } W_{0}^{1, p(z)}(\Omega) \tag{12}
\end{align*}
$$

$$
\text { (recall that } \vartheta>\|\xi\|_{\infty} \text { and see Proposition [2.2(d)). }
$$

In (11) we choose $h=u_{n}^{+} \in W_{0}^{1, p(z)}(\Omega)$. Then

$$
\begin{equation*}
\left|\hat{\rho}\left(D u_{n}^{+}\right)+\int_{\Omega} \xi(z)\left(u_{n}^{+}\right)^{p(z)} d z-\lambda \int_{\Omega}\left(u_{n}^{+}\right)^{q(z)} d z-\int_{\Omega} f\left(z, u_{n}^{+}\right) u_{n}^{+} d z\right| \leq \varepsilon_{n} \tag{13}
\end{equation*}
$$

for all $n \in \mathbb{N}$.

On the other hand, from (9) and (12), we have

$$
\begin{align*}
\left.\left|\int_{\Omega} \frac{p_{+}}{p(z)}\right| D u_{n}^{+}\right|^{p(z)} d z+\int_{\Omega} \frac{p_{+}}{p(z)} \xi(z)\left|u_{n}^{+}\right|^{p(z)} d z & -\lambda \int_{\Omega} \frac{p_{+}}{q(z)}\left(u_{n}^{+}\right)^{q(z)} d z \\
& -\int_{\Omega} p_{+} F\left(z, u_{n}^{+}\right) d z \mid \leq M_{2} \tag{14}
\end{align*}
$$

$$
\text { for some } M_{2}>0 \text {, all } n \in \mathbb{N} \text {. }
$$

From (13) and (14) it follows that

$$
\begin{align*}
& \int_{\Omega}\left[\frac{p_{+}}{p(z)}-1\right]\left|D u_{n}^{+}\right|^{p(z)} d z+\int_{\Omega}\left[\frac{p_{+}}{p(z)}-1\right] \xi(z)\left(u_{n}^{+}\right)^{p(z)} d z \\
- & \lambda \int_{\Omega}\left[\frac{p_{+}}{q(z)}-1\right]\left(u_{n}^{+}\right)^{q(z)} d z+\int_{\Omega} e\left(z, u_{n}^{+}\right) d z \leq M_{3}  \tag{15}\\
& \text { for some } M_{3}>0, \text { all } n \in \mathbb{N} .
\end{align*}
$$

Let $\beta_{\lambda}(z, x)=\lambda\left[1-\frac{p_{+}}{q(z)}\right] x^{q(z)}+e(z, x)+\xi(z)\left[\frac{p_{+}}{p(z)}-1\right] x^{p(z)}$ for all $x \geq 0$.
Then from (15) we have

$$
\begin{equation*}
\int_{\Omega} \beta_{\lambda}\left(z, u_{n}^{+}\right) d z \leq M_{3} \text { for all } n \in \mathbb{N} . \tag{16}
\end{equation*}
$$

Claim. The sequence $\left\{u_{n}^{+}\right\}_{n \geq 1} \subseteq W_{0}^{1, p(z)}(\Omega)$ is bounded.
We argue by contradiction. So, suppose that the claim is not true. Then passing to a subsequence if necessary, we may assume that

$$
\begin{equation*}
\left\|u_{n}^{+}\right\| \rightarrow \infty \text { as } n \rightarrow \infty . \tag{17}
\end{equation*}
$$

Let $y_{n}=\frac{u_{n}^{+}}{\left\|u_{n}^{+}\right\|}, n \in \mathbb{N}$. Then $\left\|y_{n}\right\|=1, y_{n} \geq 0$ for all $n \in \mathbb{N}$. So, we may assume that

$$
\begin{equation*}
y_{n} \xrightarrow{w} y \text { in } W_{0}^{1, p(z)}(\Omega) \text { and } y_{n} \rightarrow y \text { in } L^{p(z)}(\Omega), y \geq 0 . \tag{18}
\end{equation*}
$$

Let $\Omega_{+}=\{z \in \Omega: y(z)>0\}$ and $\Omega_{0}=\{z \in \Omega: y(z)=0\}$. Then $\Omega=\Omega_{+} \cup \Omega_{0}$ (see (18)).

First we assume that $\left|\Omega_{+}\right|_{N}>0$ (by $|\cdot|_{N}$ we denote the Lebesgue measure on $\mathbb{R}^{N}$ ). We have $u_{n}^{+}(z) \rightarrow+\infty$ for a.a. $z \in \Omega_{+}$and so on account of hypothesis $H_{1}(i i)$ we have

$$
\begin{align*}
& \frac{F\left(z, u_{n}^{+}(z)\right)}{u_{n}^{+}(z)^{p_{+}}} \rightarrow+\infty \text { for a.a. } z \in \Omega_{+}, \\
\Rightarrow & \frac{F\left(z, u_{n}^{+}(z)\right)}{\left\|u_{n}^{+}\right\|^{p_{+}}}=\frac{F\left(z, u_{n}^{+}(z)\right)}{u_{n}^{+}(z)^{p_{+}}} y_{n}(z)^{p_{+}} \rightarrow+\infty \text { for a.a. } z \in \Omega_{+}, \\
\Rightarrow & \int_{\Omega_{+}} \frac{F\left(z, u_{n}^{+}\right)}{\left\|u_{n}^{+}\right\|^{p_{+}}} d z \rightarrow+\infty \text { (by Fatou's lemma), } \\
\Rightarrow & \int_{\Omega} \frac{F\left(z, u_{n}^{+}\right)}{\left\|u_{n}^{+}\right\|^{p_{+}}} d z \rightarrow+\infty \text { as } n \rightarrow+\infty . \tag{19}
\end{align*}
$$

On account of (17), we may assume that $\left\|u_{n}^{+}\right\| \geq 1$ for all $n \in \mathbb{N}$. Then from (9) and (12), we have

$$
\begin{align*}
& \lambda \int_{\Omega} \frac{1}{q(z)} \frac{\left(u_{n}^{+}\right)^{q(z)}}{\left\|u_{n}^{+}\right\|^{p_{+}}} d z+\int_{\Omega} \frac{F\left(z, u_{n}^{+}\right)}{\left\|u_{n}^{+}\right\|^{p_{+}}} d z \\
\leq & \varepsilon_{n}^{\prime}+\frac{1}{p_{-}} \int_{\Omega}\left|D y_{n}\right|^{p(z)} d z+\frac{\|\xi\|_{\infty}}{p_{-}} \int_{\Omega} y_{n}^{p(z)} d z \text { with } \varepsilon_{n}^{\prime} \rightarrow 0^{+} \\
\leq & M_{4} \text { for some } M_{4}>0, \text { all } n \in \mathbb{N}(\text { see (18) }) . \tag{20}
\end{align*}
$$

Comparing (19) and (20), we have a contradiction.
So, we assume that $y \equiv 0$ (that is, $|\Omega|_{N}=\left|\Omega_{0}\right|_{N}$ ). We define

$$
\begin{equation*}
\hat{\varphi}_{\lambda}\left(t_{n} u_{n}\right)=\max \left\{\hat{\varphi}_{\lambda}\left(t u_{n}\right): 0 \leq t \leq 1\right\} \tag{21}
\end{equation*}
$$

Let $v_{n}=\eta^{\frac{1}{p_{-}}} y_{n}$ for all $n \in \mathbb{N}$, with $\eta>0$. Evidently we have

$$
\begin{equation*}
v_{n} \xrightarrow{w} 0 \text { in } W_{0}^{1, p(z)}(\Omega)(\text { see (18) }) . \tag{22}
\end{equation*}
$$

Hypothesis $H_{1}(i),(18)$ and the dominated convergence theorem imply that

$$
\begin{equation*}
\int_{\Omega} F\left(z, v_{n}\right) d z \rightarrow 0 \text { as } n \rightarrow \infty \tag{23}
\end{equation*}
$$

Also, we have

$$
\begin{equation*}
\int_{\Omega} \frac{1}{p(z)} \xi(z) v_{n}^{p(z)} d z \rightarrow 0, \int_{\Omega} \frac{1}{q(z)} v_{n}^{q(z)} d z \rightarrow 0 \tag{24}
\end{equation*}
$$

(see (22) and Proposition 2.1).
Moreover, (17) implies that we can find $n_{0} \in \mathbb{N}$ such that

$$
\begin{equation*}
\frac{\eta^{\frac{1}{p_{-}}}}{\left\|u_{n}^{+}\right\|} \in(0,1] \text { for all } n \geq n_{0} \tag{25}
\end{equation*}
$$

Then from (21) and (25), we have

$$
\begin{aligned}
\hat{\varphi}_{\lambda}\left(t_{n} u_{n}^{+}\right) & \geq \hat{\varphi}_{\lambda}\left(v_{n}\right) \\
& =\int_{\Omega} \frac{1}{p(z)}\left|D v_{n}\right|^{p(z)} d z+\int_{\Omega} \frac{1}{p(z)} \xi(z) v_{n}^{p(z)} d z \\
& -\lambda \int_{\Omega} \frac{1}{q(z)} v_{n}^{q(z)} d z-\int_{\Omega} F\left(z, v_{n}\right) d z \text { for all } n \geq n_{0} \\
& \geq \frac{1}{2 p_{+}} \eta \text { for all } n \geq n_{1} \geq n_{0}
\end{aligned}
$$

(see (23), (24) and use the Poincaré inequality).
Since $\eta>0$ is arbitrary, we infer that

$$
\begin{equation*}
\hat{\varphi}_{\lambda}\left(t_{n} u_{n}^{+}\right) \rightarrow+\infty \text { as } n \rightarrow \infty \tag{26}
\end{equation*}
$$

We know that

$$
\begin{equation*}
\hat{\varphi}_{\lambda}(0)=0 \text { and } \hat{\varphi}_{\lambda}\left(u_{n}^{+}\right) \leq M_{5} \text { for some } M_{5}>0, \text { all } n \in \mathbb{N} \tag{27}
\end{equation*}
$$

From (26) and (27) it follows that we can find $n_{2} \in \mathbb{N}$ such that

$$
\begin{equation*}
t_{n} \in(0,1) \text { for all } n \geq n_{2} \tag{28}
\end{equation*}
$$

Then from (21) and (28) we infer that

$$
\begin{align*}
\left.\quad t_{n} \frac{d}{d t} \hat{\varphi}_{\lambda}\left(t u_{n}^{+}\right)\right|_{t=t_{n}} & =0, \\
\Rightarrow \quad\left\langle\hat{\varphi}_{\lambda}^{\prime}\left(t_{n} u_{n}^{+}\right), t_{n} u_{n}^{+}\right\rangle & =0 \text { for all } n \geq n_{2} \tag{29}
\end{align*}
$$

(by the chain rule).
For all $n \geq n_{2}$ we have

$$
\begin{align*}
& \hat{\varphi}_{\lambda}\left(t_{n} u_{n}^{+}\right) \\
= & \hat{\varphi}_{\lambda}\left(t_{n} u_{n}^{+}\right)-\frac{1}{p_{+}}\left\langle\hat{\varphi}_{\lambda}^{\prime}\left(t_{n} u_{n}^{+}\right), t_{n} u_{n}^{+}\right\rangle(\text {see (29) }) \\
\leq & \int_{\Omega}\left[\frac{1}{p(z)}-\frac{1}{p_{+}}\right]\left|D\left(t_{n} u_{n}^{+}\right)\right|^{p(z)} d z+\int_{\Omega}\left[\frac{1}{p(z)}-\frac{1}{p_{+}}\right] \xi(z)\left(t_{n} u_{n}^{+}\right)^{p(z)} d z \\
- & \lambda \int_{\Omega}\left[\frac{1}{q(z)}-\frac{1}{p_{+}}\right]\left(t_{n} u_{n}^{+}\right)^{q(z)} d z+\frac{1}{p_{+}} \int_{\Omega} e\left(z, t_{n} u_{n}^{+}\right) d z \\
\leq & \int_{\Omega}\left[\frac{1}{p(z)}-\frac{1}{p_{+}}\right]\left|D u_{n}^{+}\right|^{p(z)} d z+\frac{1}{p_{+}} \int_{\Omega} \beta_{\lambda}\left(z, t_{n} u_{n}^{+}\right) d z . \tag{30}
\end{align*}
$$

For the integrand $\beta_{\lambda}(z, x)$, we have for a.a. $z \in \Omega$, all $x \geq 0$

$$
\begin{aligned}
\left(\beta_{\lambda}\right)_{x}^{\prime}(z, x) & =\lambda\left[q(z)-p_{+}\right] x^{q(z)-1}+e_{x}^{\prime}(z, x)+\xi(z)\left[p_{+}-p(z)\right] x^{p(z)-1} \\
& \geq \hat{C} x^{p(z)-1}-\lambda C_{1} x^{q(z)-1} \text { for some } C_{1}>0
\end{aligned}
$$

(see hypothesis $H_{1}(i i i)$ ).
Since $q_{+}<p_{-}$, we can find $M_{6} \geq 1$ such that

$$
\begin{aligned}
& \left(\beta_{\lambda}\right)_{x}^{\prime}(z, x) \geq 0 \text { for a.a. } z \in \Omega, \text { all } x \geq M_{6}, \\
\Rightarrow & \beta_{\lambda}(z, \cdot) \text { is nondecreasing on }\left[M_{6}, \infty\right) \text { for a.a. } z \in \Omega, \\
\Rightarrow & \beta_{\lambda}(z, x) \leq \beta_{\lambda}(z, y)+\mu_{\lambda}(z) \\
& \text { for a.a. } z \in \Omega, \text { all } 0 \leq x \leq y, \text { with } \mu_{\lambda} \in L^{1}(\Omega) .
\end{aligned}
$$

From (30) and (31) it follows that

$$
\begin{aligned}
& \hat{\varphi}_{\lambda}\left(t_{n} u_{n}^{+}\right) \\
\leq & \int_{\Omega}\left[\frac{1}{p(z)}-\frac{1}{p_{+}}\right]\left|D u_{n}^{+}\right|^{p(z)} d z+\frac{1}{p_{+}} \int_{\Omega} \beta_{\lambda}\left(z, u_{n}^{+}\right) d z+\frac{1}{p}\left\|\mu_{\lambda}\right\|_{1} \\
& \quad \text { for all } n \geq n_{2} \\
= & \hat{\varphi}_{\lambda}\left(u_{n}^{+}\right)-\frac{1}{p_{+}}\left\langle\hat{\varphi}_{\lambda}^{\prime}\left(u_{n}^{+}\right), u_{n}^{+}\right\rangle \\
\leq & \hat{\varphi}_{\lambda}\left(u_{n}^{+}\right)+\frac{\varepsilon_{n}}{p_{+}} \text {for all } n \geq n_{2}(\text { see (13) }), \\
\Rightarrow \quad & \hat{\varphi}_{\lambda}\left(u_{n}^{+}\right) \rightarrow+\infty \text { as } n \rightarrow \infty(\text { see (26) }), \\
& \quad \text { a contradiction (see (27)). }
\end{aligned}
$$

Therefore $\left\{u_{n}^{+}\right\} \subseteq W_{0}^{1, p(z)}(\Omega)$ is bounded and this proves the claim.
Then from (12) and the claim it follows that

The proof is now complete.
Proposition 3.2. If hypotheses $H_{0}, H_{1}$ hold, then $\mathcal{L} \neq \emptyset$ and we have $S_{\lambda} \subseteq \operatorname{int} C_{+}$for every $\lambda \in \mathcal{L}$.

Proof. On account of hypotheses $H_{1}(i),(i v)$, we see that given $\varepsilon>0$, we can find $C_{2}=$ $C_{2}(\varepsilon)>0$ such that

\text { for some } \left.C_{3}>0 \text { (see (33) and recall that } \vartheta>\|\xi\|_{\infty}\right) \text {. }
$$

For $\|u\|_{p(z)} \leq 1$ we have

& \quad \text { for some } C_{5}=C_{5}(\lambda)>0 \text { (recall that } q_{+}<p_{-} \leq p_{+}<r_{+} \text {). }
\end{align*}

We return to (34) and use (35). Then for $u \in W_{0}^{1, p(z)}(\Omega)$ with $\max \left\{\|u\|,\|u\|_{p(z)}\right\} \leq 1$ we have

\Rightarrow & t_{0}=\left[\frac{\lambda\left(p_{+}-q_{+}\right)}{r_{+}-p_{+}}\right]^{\frac{1}{r_{+}-q_{+}}} .
\end{aligned}
$$

Then

& k_{\lambda}\left(t_{0}\right)=\lambda^{\frac{r_{+}-p_{+}}{r_{+}-q_{+}}} \frac{\left(r_{+}-p_{+}\right)^{\frac{p_{+}-q_{+}}{r_{+}-q_{+}}}}{\left(p_{+}-q_{+}\right)^{\frac{p_{+}-q_{+}}{r_{+}-q_{+}}}}+\lambda^{\frac{r_{+}-p_{+}}{r_{+}-q_{+}}} \frac{\left(p_{+}-q_{+}\right)^{\frac{r_{-}-p_{+}}{r_{+}-q_{+}}}}{\left(r_{+}-p_{+}\right)^{\frac{r_{-} p_{+}}{r_{+}-q_{+}}}}, \\
\Rightarrow & k_{\lambda}\left(t_{0}\right) \rightarrow 0 \text { as } \lambda \rightarrow 0^{+} .
\end{aligned}
$$

Let $C_{0}>0$ be such that $\|\cdot\|_{p(z)} \leq C_{0}\|\cdot\|$. So, we can find $\lambda_{0}>0$ such that

\Rightarrow & u_{\lambda} \geq 0, u_{\lambda} \neq 0 .
\end{aligned}
$$

Then from (41) it follows that $u_{\lambda}$ is a positive solution $\left(P_{\lambda}\right)$. As before the anisotropic regularity theory (see [8], [9]) implies that

So, we have proved that $\left(0, \lambda_{0}\right) \subseteq \mathcal{L}$ and so $\mathcal{L} \neq \emptyset$. Moreover, we have $S_{\lambda} \subseteq \operatorname{int} C_{+}$for all $\lambda>0$.

Next, we show that $\mathcal{L}$ is an interval.
Proposition 3.3. If hypotheses $H_{0}, H_{1}$ hold, $\lambda \in \mathcal{L}$ and $0<\mu<\lambda$, then $u \in \mathcal{L}$ and given $u_{\lambda} \in S_{\lambda}$ we can find $u_{\mu} \in S_{\mu}$ such that $u_{\mu} \leq u_{\lambda}$.
Proof. Since $\lambda \in \mathcal{L}$, we can find $u_{\lambda} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$. With $\vartheta>\|\xi\|_{\infty}$, we introduce the Carathéodory function $g_{\mu}(z, x)$ defined by

Since $\vartheta>\|\xi\|_{\infty}$, from (42) it is clear that $\Psi_{\mu}(\cdot)$ is coercive. Also using the fact that $W_{0}^{1, p(z)}(\Omega) \hookrightarrow L^{p(z)}(\Omega)$ compactly, we see that $\Psi_{\mu}(\cdot)$ is sequentially weakly lower semicontinuous. So, by the Weierstrass-Tonelli theorem, there exists $u_{\mu} \in W_{0}^{1, p(z)}(\Omega)$ such that

& \text { for all } h \in W_{0}^{1, p(z)}(\Omega) .
\end{align*}
$$

In (44) first we choose $h=-u_{\mu}^{-} \in W_{0}^{1, p(z)}(\Omega)$. We obtain

& \hat{\rho}\left(D u_{\mu}^{-}\right)+C_{10} \rho\left(u_{\mu}^{-}\right) \leq 0 \text { for some } C_{10}>0(\text { see (42) }), \\
\Rightarrow & u_{\mu} \geq 0, u_{\mu} \neq 0 .
\end{aligned}

Next, in (44) we choose $h=\left(u_{\mu}-u_{\lambda}\right)^{+} \in W_{0}^{1, p(z)}(\Omega)$. We have

& \left\langle A\left(u_{\mu}\right),\left(u_{\mu}-u_{\lambda}\right)^{+}\right\rangle+\int_{\Omega}[\vartheta+\xi(z)] u_{\mu}^{p(z)-1}\left(u_{\mu}-u_{\lambda}\right)^{+} d z \\
= & \int_{\Omega}\left[\mu u_{\lambda}^{q(z)-1}+f\left(z, u_{\lambda}\right)+\vartheta u_{\lambda}^{p(z)-1}\right]\left(u_{\mu}-u_{\lambda}\right)^{+} d z(\text { see (422) ) } \\
\leq & \int_{\Omega}\left[\lambda u_{\lambda} u^{q(z)-1}+f\left(z, u_{\lambda}\right)+\vartheta u_{\lambda}^{p(z)-1}\right]\left(u_{\mu}-u_{\lambda}\right)^{+} d z(\text { since } \mu<\lambda) \\
= & \left\langle A\left(u_{\lambda}\right),\left(u_{\mu}-u_{\lambda}\right)^{+}\right\rangle+\int_{\Omega}[\vartheta+\xi(z)] u_{\lambda}^{p(z)-1}\left(u_{\mu}-u_{\lambda}\right)^{+} d z\left(\text { since } u_{\lambda} \in S_{\lambda}\right) .
\end{aligned}
$$

The monotonicity of $A(\cdot)$ (see Proposition [2.3) and the fact that $\vartheta>\|\xi\|_{\infty}$ imply that

& u_{\mu} \leq u_{\lambda}, \\
\Rightarrow & u_{\mu} \in\left[0, u_{\lambda}\right], u_{\mu} \neq 0, \\
\Rightarrow & u_{\mu} \in S_{\mu} \subseteq \operatorname{int} C_{+}(\text {see (42) and (44) }) .
\end{aligned}

The proof is now complete.
So, according to Proposition 3.3 the solution multifunction $\lambda \mapsto S_{\lambda}$ has a kind of weak monotonicity property. We can improve this monotonicity property by adding one more condition on the perturbation $f(z, \cdot)$.

The new hypotheses on $f(z, x)$ are the following:
$H_{2}: f: \Omega \times \mathbb{R} \rightarrow \mathbb{R}$ is a function which is measurable in $z \in \Omega$, for a.a. $z \in \Omega$ we have $f(z, \cdot) \in C^{1}(\mathbb{R})$, hypotheses $H_{2}(i) \rightarrow(i v)$ are the same as the corresponding hypotheses $H_{1}(i) \rightarrow(i v)$, and
(v) for every $\rho>0$, there exists $\hat{\xi}_{\rho}>0$ such that for a.a. $z \in \Omega$ the function

is nondecreasing on $[0, \rho]$.
Remark 3.4. This is a one-sided local Hölder condition on $f(z, \cdot)$. It is satisfied if for every $\rho>0$, we can find $\hat{C}_{\rho}>0$ such that $f_{x}^{\prime}(z, x) \geq-\hat{C}_{\rho} x^{p(z)-1}$ for a.a. $z \in \Omega$, all $0 \leq x \leq \rho$.
Proposition 3.5. If hypotheses $H_{0}, H_{2}$ hold, $\lambda \in \mathcal{L}, u_{\lambda} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$and $\mu \in(0, \lambda)$, then $\mu \in \mathcal{L}$ and we can find $u_{\mu} \in S_{\mu} \subseteq \operatorname{int} C_{+}$such that

u_{\lambda}-u_{\mu} \in \operatorname{int} C_{+} .
$$

Proof. From Proposition 3.3 we know that $\mu \in \mathcal{L}$ and there exists $u_{\mu} \in S_{\mu} \subseteq \operatorname{int} C_{+}$such that

Let $\rho=\left\|u_{\lambda}\right\|_{\infty}$ and let $\hat{\xi}_{\rho}>0$ be as postulated by hypothesis $H_{2}(v)$. We can always assume that $\hat{\xi}_{\rho}>\|\xi\|_{\infty}$. Then we have

\leq & \lambda u_{\lambda}^{q(z)-1}+f\left(z, u_{\lambda}\right)+\hat{\xi}_{\rho} u_{\lambda}^{p(z)-1}(\text { since } \mu<\lambda) \\
= & -\Delta_{p(z)} u_{\lambda}+\left[\xi(z)+\hat{\xi}_{\rho}\right] u_{\lambda}^{p(z)-1} . \tag{46}
\end{align*}

Proof. We consider the $C^{1}$-functional $\gamma_{\lambda}: W_{0}^{1, p(z)}(\Omega) \rightarrow \mathbb{R}$ defined by

for all $u \in W_{0}^{1, p(z)}(\Omega)$.
Evidently, $\gamma_{\lambda}(\cdot)$ is coercive (since $q_{+}<p_{-}$) and sequentially weakly lower semicontinuous. So, we can find $\bar{u}_{\lambda} \in W_{0}^{1, p(z)}(\Omega)$ such that

\begin{aligned}
& \gamma_{\lambda}\left(\bar{u}_{\lambda}\right)=\min \left\{\gamma_{\lambda}(u): u \in W_{0}^{1, p(z)}(\Omega)\right\}<0=\gamma_{\lambda}(0)\left(\text { since } q_{+}<p_{-}\right), \\
\Rightarrow & \bar{u}_{\lambda} \neq 0
\end{aligned}
$$

We have

$$
\begin{gather*}
\gamma_{\lambda}^{\prime}\left(\bar{u}_{\lambda}\right)=0 \\
\Rightarrow\left\langle A\left(\bar{u}_{\lambda}\right), h\right\rangle+\int_{\Omega}|\xi(z)|\left|\bar{u}_{\lambda}\right|^{p(z)-2} \bar{u}_{\lambda} h d z=\lambda \int_{\Omega}\left(\bar{u}_{\lambda}^{+}\right)^{q(z)-1} h d z \tag{49}
\end{gather*}
$$

for all $h \in W_{0}^{1, p(z)}(\Omega)$.
In (49) we choose $h=-\bar{u}_{\lambda}^{-} \in W_{0}^{1, p(z)}(\Omega)$. Then

$$
\begin{aligned}
& \hat{\rho}\left(D \bar{u}_{\lambda}^{-}\right)+\int_{\Omega}|\xi(z)|\left(\bar{u}_{\lambda}^{-}\right)^{p(z)} d z=0, \\
\Rightarrow & \bar{u}_{\lambda} \geq 0, \bar{u}_{\lambda} \neq 0, \\
\Rightarrow & \bar{u}_{\lambda} \text { is a positive solution of (48) (see (49)), } \\
\Rightarrow & \bar{u}_{\lambda} \in C_{+} \backslash\{0\} \text { (anisotropic regularity theory). }
\end{aligned}
$$

Therefore

\begin{aligned}
& \Delta_{p(z)} \bar{u}_{\lambda}(z) \leq\|\xi\|_{\infty} \bar{u}_{\lambda}(z)^{p(z)-1} \text { for a.a. } z \in \Omega, \\
\Rightarrow \quad & \bar{u}_{\lambda} \in \operatorname{int} C_{+}(\text {see Zhang [29] }) .
\end{aligned}
$$

Next, we show that this positive solution of (48) in unique.
Suppose that $\bar{v}_{\lambda}$ is another positive solution of (48). Again we have $\bar{v}_{\lambda} \in \operatorname{int} C_{+}$. On account of Proposition 4.1.22 of Papageorgiou, Rădulescu and Repovš [24, p. 274], we have $\frac{\bar{u}_{\lambda}}{\bar{v}_{\lambda}}, \frac{\bar{v}_{\lambda}}{\bar{u}_{\lambda}} \in L^{\infty}(\Omega)$. So, we can apply Theorem 2.5 of Takač and Giacomoni [27] and have

\begin{aligned}
0 & \leq \int_{\Omega}\left[\frac{-\Delta_{p(z)} \bar{u}_{\lambda}}{\bar{u}_{\lambda}^{p-1}}+\frac{-\Delta_{p(z)} \bar{v}_{\lambda}}{\bar{v}_{\lambda}^{p-1}}\right]\left(\bar{u}_{\lambda}^{p-}-\bar{v}_{\lambda}^{p_{-}}\right) d z \\
& =\int_{\Omega}\left[\lambda\left(\bar{u}_{\lambda}^{q(z)-p_{-}}-\bar{v}_{\lambda}^{q(z)-p_{-}}\right)-|\xi(z)|\left(\bar{u}_{\lambda}^{p(z)-p_{-}}-\bar{v}_{\lambda}^{p(z)-p_{-}}\right)\right]\left(\bar{u}_{\lambda}^{p_{-}}-\bar{v}_{\lambda}^{p_{-}}\right) d z, \\
\Rightarrow \bar{u}_{\lambda} & =\bar{v}_{\lambda}\left(\text { since } q_{+}<p_{-} \leq p(z)\right) .
\end{aligned}
$$

Therefore the positive solution $\bar{u}_{\lambda} \in \operatorname{int} C_{+}$of problem (48) is unique.

This solution $\bar{u}_{\lambda} \in \operatorname{int} C_{+}$provides a lower bound for the solution set $S_{\lambda}$.
Proposition 3.7. If hypotheses $H_{0}, H_{1}$ hold and $\lambda \in \mathcal{L}$, then $\bar{u}_{\lambda} \leq u$ for all $u \in S_{\lambda}$.
Proof. Let $u \in S_{\lambda} \subseteq \operatorname{int} C_{+}$and consider the Carathéodory function $\beta_{\lambda}(z, x)$ defined by

\beta_{\lambda}(z, x)= \begin{cases}\lambda\left(x^{+}\right)^{q(z)-1}, & \text { if } x \leq u(z)  \tag{50}\\ \lambda u(z)^{q(z)-1}, & \text { if } u(z)<x\end{cases}
$$

We set $B_{\lambda}(z, x)=\int_{0}^{x} \beta_{\lambda}(z, s) d s$ and consider the $C^{1}$-functional $\tau_{\lambda}: W_{0}^{1, p(z)}(\Omega) \rightarrow \mathbb{R}$ defined by

$$
\tau_{\lambda}(u)=\int_{\Omega} \frac{1}{p(z)}|D u|^{p(z)} d z+\int_{\Omega} \frac{|\xi(z)|}{p(z)}|u|^{p(z)} d z-\int_{\Omega} B_{\lambda}(z, u) d z
$$

for all $u \in W_{0}^{1, p(z)}(\Omega)$.
From (50) we see that $\tau_{\lambda}(\cdot)$ is coercive. Also, it is sequentially weakly lower semicontinuous. So, we can find $\tilde{u}_{\lambda} \in W_{0}^{1, p(z)}(\Omega)$ such that

\begin{aligned}
& \tau_{\lambda}\left(\tilde{u}_{\lambda}\right)=\min \left\{\tau_{\lambda}(u): u \in W_{0}^{1, p(z)}(\Omega)\right\}<0=\tau_{\lambda}(0)\left(\text { since } q_{+}<p_{-}\right) \\
\Rightarrow & \tilde{u}_{\lambda} \neq 0
\end{aligned}
$$

We have

$$
\begin{gather*}
\tau_{\lambda}^{\prime}(\tilde{u})=0 \\
\Rightarrow\left\langle A\left(\tilde{u}_{\lambda}\right), h\right\rangle+\int_{\Omega}|\xi(z)|\left|\tilde{u}_{\lambda}\right|^{p(z)-2} \tilde{u}_{\lambda} h d z=\int_{\Omega} \beta_{\lambda}\left(z, \tilde{u}_{\lambda}\right) h d z \tag{51}
\end{gather*}
$$

for all $h \in W_{0}^{1, p(z)}(\Omega)$.
In (51) first we choose $h=-\tilde{u}_{\lambda}^{-} \in W_{0}^{1, p(z)}(\Omega)$ and infer that

$$
\tilde{u}_{\lambda} \geq 0, \tilde{u}_{\lambda} \neq 0
$$

Next, in (51) we choose $h=\left(\tilde{u}_{\lambda}-u\right)^{+} \in W_{0}^{1, p(z)}(\Omega)$. We have

\begin{aligned}
& \left\langle A\left(\tilde{u}_{\lambda}\right),\left(\tilde{u}_{\lambda}-u\right)^{+}\right\rangle+\int_{\Omega}|\xi(z)| \tilde{u}_{\lambda}^{p(z)-1}\left(\tilde{u}_{\lambda}-u\right)^{+} d z \\
= & \int_{\Omega} \lambda u^{q(z)-1}\left(\tilde{u}_{\lambda}-u\right)^{+} d z(\text { see (50) }) \\
\leq & \int_{\Omega}\left[\lambda u^{q(z)-1}+f(z, u)\right]\left(\tilde{u}_{\lambda}-u\right)^{+} d z(\text { since } f \geq 0) \\
\leq & \left\langle A(u),\left(\tilde{u}_{\lambda}-u\right)^{+}\right\rangle+\int_{\Omega}|\xi(z)| u^{p(z)-1}\left(\tilde{u}_{\lambda}-u\right)^{+} d z\left(\text { since } u \in S_{\lambda}\right), \\
\Rightarrow \tilde{u}_{\lambda} \leq & u .
\end{aligned}
$$

So, we have proved that

\tilde{u}_{\lambda} \in[0, u] \backslash\{0\} . \tag{52}
\end{equation*}
$$

Then from (51), (52) and (50) it follows that

& \tilde{u}_{\lambda} \text { is a positive solution of (48), } \\
\Rightarrow & \tilde{u}_{\lambda}=\bar{u}_{\lambda} \in \operatorname{int} C_{+} \text {(see Proposition (3.6), } \\
\Rightarrow & \bar{u}_{\lambda} \leq u \text { for all } u \in S_{\lambda} .
\end{aligned}
$$

The proof is now complete.

Remark 3.8. Reasoning as in the above proof, we show that $\lambda \mapsto \bar{u}_{\lambda}$ is increasing that is, if $0<\mu<\lambda$, then $\bar{u}_{\lambda}-\bar{u}_{\mu} \in C_{+} \backslash\{0\}$.

We know that $S_{\lambda}$ is downward directed (see Filippakis and Papageorgiou [10] and Papageorgiou, Rădulescu and Repovš [19] and recall that $A(\cdot)$ is monotone, see Proposition (2.3).

Proposition 3.9. If hypotheses $H_{0}, H_{1}$ hold and $\lambda \in \mathcal{L}$, then there exists $u_{\lambda}^{*} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$ such that

$$
\begin{gathered}
u_{\lambda}^{*} \leq u \text { for all } u \in S_{\lambda} \\
\text { (minimal positive solution of }\left(P_{\lambda}\right) \text { ). }
\end{gathered}
$$

Proof. By Lemma 3.10 of Hu and Papageorgiou [15, p. 178], we know that we can find $\left\{u_{n}\right\}_{n \geq 1} \subseteq S_{\lambda} \subseteq \operatorname{int} C_{+}$decreasing (recall that $S_{\lambda}$ is downward directed) such that

Since $\bar{u}_{\lambda} \leq u_{n} \leq u_{1}$ for all $n \in \mathbb{N}$ (see Proposition 3.7), from hypothesis $H_{1}(i)$ it follows that

u_{n} \xrightarrow{w} u_{\lambda}^{*} \text { in } W_{0}^{1, p(z)}(\Omega) \text { and } u_{n} \rightarrow u_{\lambda}^{*} \text { in } L^{r(z)}(\Omega) \text { as } n \rightarrow \infty . \tag{53}
\end{equation*}
$$

We have

\begin{align*}
& \left\langle A\left(u_{n}\right), u_{n}-u_{\lambda}^{*}\right\rangle+\int_{\Omega} \xi(z) u_{n}^{p(z)-1}\left(u_{n}-u_{\lambda}^{*}\right) d z \\
= & \lambda \int_{\Omega} u_{n}^{q(z)-1}\left(u_{n}-u_{\lambda}^{*}\right) d z+\int_{\Omega} f\left(z, u_{n}\right)\left(u_{n}-u_{\lambda}^{*}\right) d z, \\
\Rightarrow & \lim _{n \rightarrow \infty}\left\langle A\left(u_{n}\right), u_{n}-u_{\lambda}^{*}\right\rangle=0, \\
\Rightarrow & u_{n} \rightarrow u_{\lambda}^{*} \text { in } W_{0}^{1, p(z)}(\Omega) \text { (see Proposition (2.3). } \tag{54}
\end{align*}
$$

Note that

$$
\begin{gathered}
\bar{u}_{\lambda} \leq u_{\lambda}^{*} \text { and so } u_{\lambda}^{*} \neq 0 \\
\left\langle A\left(u_{\lambda}^{*}\right), h\right\rangle+\int_{\Omega} \xi(z)\left(u_{\lambda}^{*}\right)^{p(z)-1} h d z=\lambda \int_{\Omega}\left(u_{\lambda}^{*}\right)^{q(z)-1} h d z+\int_{\Omega} f\left(z, u_{\lambda}^{*}\right) h d z
\end{gathered}
$$

$$
\text { for all } h \in W_{0}^{1, p(z)}(\Omega)(\text { see (154) }) \text {. }
$$

It follows that

$$
u_{\lambda}^{*} \in S_{\lambda} \subseteq \operatorname{int} C_{+} \text {and } u_{\lambda}^{*}=\inf S_{\lambda} .
$$

The proof is now complete.
We set $\lambda^{*}=\sup \mathcal{L}$.
Proposition 3.10. If hypotheses $H_{0}, H_{2}$ hold, then $\lambda^{*}<\infty$.
Proof. On account of hypotheses $H_{0}, H_{2}(i v)$ and since $q_{+}<p_{-}$, we see that we can find $\hat{\lambda}>0$ such that

\begin{equation*}
\hat{\lambda} x^{q(z)-1}+f(z, x)-\xi(z) x^{p(z)-1} \geq 0 \text { for a.a. } z \in \Omega \text {, all } x \geq 0 . \tag{55}
\end{equation*}
$$

Let $\lambda>\hat{\lambda}$ and suppose that $\lambda \in \mathcal{L}$. Then we can find $u_{\lambda} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$. Let $\Omega_{0} \subset \subset \Omega$ (that is, $\Omega_{0} \subseteq \bar{\Omega}_{0} \subseteq \Omega$ ) and assume that $\partial \Omega_{0}$ is a $C^{2}$-manifold. We set $m_{0}=\frac{\min }{\bar{\Omega}_{0}} u_{\lambda}>0$ (recall that $u_{\lambda} \in \operatorname{int} C_{+}$). Also, let $\hat{\xi}_{\rho}>\|\xi\|_{\infty}$. Let $m_{0}^{\delta}=m_{0}+\delta$ for $\delta>0$ small. We have

\begin{align*}
& -\Delta_{p(z)} m_{0}^{\delta}+\left[\xi(z)+\hat{\xi}_{\rho}\right]\left(m_{0}^{\delta}\right)^{p(z)-1} \\
\leq & {\left[\xi(z)+\hat{\xi}_{\rho}\right] m_{0}^{p(z)-1}+\chi(\delta) \text { with } \chi(\delta) \rightarrow 0^{+} \text {as } \delta \rightarrow 0^{+} } \\
\leq & \hat{\lambda} m_{0}^{q(z)-1}+f\left(z, m_{0}\right)+\hat{\xi}_{\rho} m_{0}^{p(z)-1}+\chi(\delta)(\text { see (55)) } \\
\leq & \hat{\lambda} u_{\lambda}^{q(z)-1}+f\left(z, u_{\lambda}\right)+\hat{\xi}_{\rho} u_{\lambda}^{p(z)-1}+\chi(\delta)\left(\text { see hypothesis } H_{2}(i v)\right) \\
\leq & \lambda u_{\lambda}^{q(z)-1}+f\left(z, u_{\lambda}\right)+\hat{\xi}_{\rho} u_{\lambda}^{p(z)-1}-[\lambda-\hat{\lambda}] m_{0}^{p(z)-1}+\chi(\delta) \\
\leq & -\Delta_{p(z)} u_{\lambda}+\left[\xi(z)+\hat{\xi}_{\rho}\right] u_{\lambda}^{p(z)-1} \text { in } \Omega_{0} \text { for } \delta \in(0,1) \text { small. } \tag{56}
\end{align*}
$$

Note that for $\delta \in(0,1)$ small, we have

(\lambda-\hat{\lambda}) m_{0}^{p(z)-1}-\chi(\delta) \geq \eta>0 .
$$

Then from (56) and Proposition [2.5, we have

a contradiction. This means that $0<\lambda^{*} \leq \hat{\lambda}<\infty$.
According to this proposition, we have

We will show that for all $\lambda \in\left(0, \lambda^{*}\right)$, we have at least two positive smooth solutions for problem $\left(P_{\lambda}\right)$. To do this we need to strengthen a little the hypotheses on $f(z, \cdot)$. The new conditions on $f(z, x)$ are the following:
$H_{3}: f: \Omega \times \mathbb{R} \rightarrow \mathbb{R}$ is a function measurable in $z \in \Omega$, for a.a. $z \in \Omega f(z, \cdot) \in C^{1}(\mathbb{R})$, hypotheses $H_{3}(i) \rightarrow(v)$ are the same as the corresponding hypotheses $H_{2}(i) \rightarrow(v)=$ $H_{1}(i) \rightarrow(v)$ and
(vi) for every $m>0$, there exists $\eta_{m}>0$ such that

f(z, x) \geq \eta_{m}>0 \text { for a.a. } z \in \Omega \text {, all } x \geq m \text {. }
$$

Proposition 3.11. If hypotheses $H_{0}, H_{3}$ hold and $\lambda \in\left(0, \lambda^{*}\right)$, then problem $\left(P_{\lambda}\right)$ admits at least two positive solutions

$$
u_{0}, \hat{u} \in \operatorname{int} C_{+}, u_{0} \neq \hat{u} .
$$

Proof. Let $\eta \in\left(\lambda, \lambda^{*}\right)$. We have $\eta \in \mathcal{L}$ (see (57)) and so we can find $u_{\eta} \in S_{\eta} \subseteq \operatorname{int} C_{+}$. Then according to Proposition 3.5, we can find $u_{0} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$such that

u_{\eta}-u_{0} \in \operatorname{int} C_{+} . \tag{58}
\end{equation*}
$$

Recall that $\bar{u}_{\lambda} \leq u_{0}$ (see Proposition 3.7). Let $\rho=\left\|u_{0}\right\|_{\infty}$ and let $\hat{\xi}_{\rho}>0$ be as postulated by hypothesis $H_{3}(v)=H_{2}(v)$. We can assume that $\hat{\xi}_{\rho}>\|\xi\|_{\infty}$. Then we have

\leq & -\Delta_{p(z)} \bar{u}_{\lambda}+\left[|\xi(z)|+\hat{\xi}_{\rho}\right]_{\lambda}^{p(z)-1} \\
= & \lambda \bar{u}_{\lambda}^{q(z)-1}+\hat{\xi}_{\rho} \bar{u}_{\lambda}^{p(z)-1}(\text { see Proposition 3.6) } \\
\leq & \left.\lambda u_{0}^{q(z)-1}+f\left(z, \bar{u}_{\lambda}\right)+\hat{\xi}_{\rho} \bar{u}_{\lambda}^{p(z)-1} \text { (recall that } f \geq 0\right) \\
\leq & \lambda u_{0}^{q(z)-1}+f\left(z, u_{0}\right)+\hat{\xi} u_{0}^{p(z)-1} \\
& \text { (see Proposition 3.7 and hypothesis } \left.H_{3}(v)=H_{2}(v)\right) \\
= & \left.-\Delta_{p(z)} u_{0}+\left[\xi(z)+\hat{\xi}_{\rho}\right] u_{0}^{p(z)-1} \text { (since } u_{0} \in S_{\lambda}\right) . \tag{59}
\end{align*}
$$

On account of hypothesis $H_{3}(v i)$ and since $\bar{u}_{\lambda} \in \operatorname{int} C_{+}$, we see that

$$
0 \prec f\left(\cdot, \bar{u}_{\lambda}(\cdot)\right) .
$$

Then (59) and Proposition 2.4 imply that

\begin{equation*}
u_{0}-\bar{u}_{\lambda} \in \operatorname{int} C_{+} . \tag{60}
\end{equation*}
$$

From (58) and (60) it follows that

$$
\begin{equation*}
u_{0} \in \operatorname{int}_{C_{0}^{1}(\bar{\Omega})}\left[\bar{u}_{\lambda}, u_{\eta}\right] . \tag{61}
\end{equation*}
$$

As before, let $\vartheta>\|\xi\|_{\infty}$ and consider the Carathéodory function $k_{\lambda}(z, x)$ defined by

$$
k_{\lambda}(z, x)= \begin{cases}\lambda \bar{u}_{\lambda}(z)^{q(z)-1}+f\left(z, \bar{u}_{\lambda}(z)\right)+\vartheta \bar{u}_{\lambda}(z)^{p(z)-1}, & \text { if } x<\bar{u}_{\lambda}(z)  \tag{62}\\ \lambda x^{q(z)-1}+f(z, x)+\vartheta x^{p(z)-1}, & \text { if } \bar{u}_{\lambda}(z) \leq x \leq u_{\eta}(z) \\ \lambda u_{\eta}(z)^{q(z)-1}+f\left(z, u_{\eta}(z)\right)+\vartheta u_{\eta}(z)^{p(z)-1}, & \text { if } u_{\eta}(z)<x\end{cases}
$$

We set $K_{\lambda}(z, x)=\int_{0}^{x} k_{\lambda}(z, s) d s$ and consider the $C^{1}$-functional $\tau_{\lambda}: W_{0}^{1, p(z)}(\Omega) \rightarrow \mathbb{R}$ defined by

$$
\tau_{\lambda}(u)=\int_{\Omega} \frac{1}{p(z)}|D u|^{p(z)} d z+\int_{\Omega} \frac{\vartheta+\xi(z)}{p(z)}|u|^{p(z)} d z-\int_{\Omega} K_{\lambda}(z, u) d z
$$

for all $u \in W_{0}^{1, p(z)}(\Omega)$.
From (62) and since $\vartheta>\|\xi\|_{\infty}$, we infer that $\tau_{\lambda}(\cdot)$ is coercive. Also it is sequentially weakly lower semicontinuous. So, we can find $\tilde{u}_{0} \in W_{0}^{1, p(z)}(\Omega)$ such that

$$
\begin{aligned}
& \tau_{\lambda}\left(\tilde{u}_{0}\right)=\min \left\{\tau_{\lambda}(u): u \in W_{0}^{1, p(z)}(\Omega)\right\}, \\
\Rightarrow & \tau_{\lambda}^{\prime}\left(\tilde{u}_{0}\right)=0, \\
\Rightarrow & \left\langle\tau_{\lambda}^{\prime}\left(\tilde{u}_{0}\right), h\right\rangle=0 \text { for all } h \in W_{0}^{1, p(z)}(\Omega) .
\end{aligned}
$$

Choosing $h=\left(\bar{u}_{\lambda}-\tilde{u}_{0}\right)^{+}$and $h=\left(\tilde{u}_{0}-u_{\eta}\right)^{+}$and using (62), we show as before that

\tilde{u}_{0} \in\left[\bar{u}_{\lambda}, u_{\eta}\right] \cap \operatorname{int} C_{+} .

Therefore we may assume that $\tilde{u}_{0}=u_{0}$ or otherwise we already have a second positive smooth solution and so we are done.

Next, we consider the Carathéodory function

\hat{k}_{\lambda}(z, x)= \begin{cases}\lambda \bar{u}_{\lambda}(z)^{q(z)-1}+f\left(z, \bar{u}_{\lambda}(z)\right)+\vartheta \bar{u}_{\lambda}(z)^{p(z)-1}, & \text { if } x \leq \bar{u}_{\lambda}(z)  \tag{63}\\ \lambda x^{q(z)-1}+f(z, x)+\vartheta x^{p(z)-1}, & \text { if } \bar{u}_{\lambda}(z)<x .\end{cases}
$$

We define $\hat{K}_{\lambda}(z, x)=\int_{0}^{x} \hat{k}_{\lambda}(z, s) d s$ and introduce the $C^{1}$-functional $\hat{\tau}_{\lambda}: W_{0}^{1, p(z)}(\Omega) \rightarrow \mathbb{R}$ defined by

$$
\hat{\tau}_{\lambda}(u)=\int_{\Omega} \frac{1}{p(z)}|D u|^{p(z)} d z+\int_{\Omega} \frac{\vartheta+\xi(z)}{p(z)}|u|^{p(z)} d z-\int_{\Omega} \hat{K}_{\lambda}(z, u) d z
$$

for all $u \in W_{0}^{1, p(z)}(\Omega)$.
From (62) and (63) it is clear that

$$
\tau_{\lambda}\left|\left[\bar{u}_{\lambda}, u_{\eta}\right]=\hat{\tau}_{\lambda}\right|\left[\bar{u}_{\lambda}, u_{\eta}\right] .
$$

On account of (61), we have that

$$
\begin{align*}
& u_{0} \text { is a local } C_{0}^{1}(\bar{\Omega}) \text {-minimizer of } \hat{\tau}_{\lambda}, \\
\Rightarrow \quad & u_{0} \text { is a local } W_{0}^{1, p(z)}(\Omega) \text {-minimizer of } \hat{\tau}_{\lambda} .  \tag{64}\\
& \text { (see Gasinski and Papageorgiou [12, Proposition 3.3]). }
\end{align*}
$$

Using (63), we can easily see that

\begin{equation*}
K_{\hat{\tau}_{\lambda}} \subseteq\left[\bar{u}_{\lambda}\right) \cap \operatorname{int} C_{+} . \tag{65}
\end{equation*}
$$

Then from (63) and (65) we infer that we may assume that $K_{\hat{\tau}_{\lambda}}$ is finite or otherwise we already have an infinity of positive smooth solutions all distinct from $u_{0}$ and so, we are done. According to Theorem 5.7.6 of Papageorgiou, Rădulescu and Repovš [24, p. 449], we can find $\rho \in(0,1)$ small such that

\hat{\tau}_{\lambda}\left(u_{0}\right)<\inf \left[\hat{\tau}_{\lambda}(u):\left\|u-u_{0}\right\|=\rho\right]=\hat{m}_{\rho} . \tag{66}

On account of hypothesis $H_{3}(i i)=H_{1}(i i)$, for $u \in \operatorname{int} C_{+}$, we have

\hat{\tau}_{\lambda}(t u) \rightarrow-\infty \text { as } t \rightarrow+\infty . \tag{67}
\end{equation*}
$$

Finally, from (63) it follows that

$$
\begin{align*}
& \left.\hat{\varphi}_{\lambda}\right|_{\left[\bar{u}_{\lambda}\right)}=\left.\hat{\tau}_{\lambda}\right|_{\left[\bar{\lambda}_{\lambda}\right)}+\hat{\eta} \text { with } \hat{\eta} \in \mathbb{R}, \\
\Rightarrow \quad & \hat{\tau}_{\lambda}(\cdot) \text { satisfies the } C \text {-condition (see Proposition 3.1). } \tag{68}
\end{align*}
$$

Then (66), (67), (68) permit the use of the mountain pass theorem. So, we can find $\hat{u} \in W_{0}^{1, p(z)}(\Omega)$ such that

$$
\begin{equation*}
\hat{u} \in K_{\hat{\tau}_{\lambda}} \subseteq\left[\bar{u}_{\lambda}\right) \cap \operatorname{int} C_{+} \text {and } \hat{m}_{\rho} \leq \hat{\tau}_{\lambda}(\hat{u}) . \tag{69}
\end{equation*}
$$

From (69) and (63) we see that $\hat{u} \in S_{\lambda} \subseteq \operatorname{int} C_{+}$, while from (69) and (66) we have that $\hat{u} \neq u_{0}$.

Finally, we show that the critical parameter value $\lambda^{*}$ is admissible, that is, $\lambda^{*} \in \mathcal{L}$.
Proposition 3.12. If hypotheses $H_{0}, H_{1}$ hold, then $\lambda^{*} \in \mathcal{L}$.
Proof. Let $\left\{\lambda_{n}\right\}_{n \geq 1} \subseteq \mathcal{L}$ such that $\lambda_{n} \uparrow \lambda^{*}$ as $n \rightarrow \infty$. From the proof of Proposition 3.3, we know that we can find $u_{n} \in S_{\lambda_{n}} \subseteq$ int $C_{+}$such that

$$
\hat{\varphi}_{\lambda_{n}}\left(u_{n}\right)<0 \text { for all } n \in \mathbb{N} .
$$

Also, we have

$$
\hat{\varphi}_{\lambda_{n}}^{\prime}\left(u_{n}\right)=0, \text { for all } n \in \mathbb{N}
$$

Then as in the proof of Proposition 3.1, we show that

$$
\left\{u_{n}\right\}_{n \geq 1} \subseteq W_{0}^{1, p(z)}(\Omega) \text { is bounded. }
$$

We may assume that

$$
\begin{equation*}
u_{n} \xrightarrow{w} u_{*} \text { in } W_{0}^{1, p(z)}(\Omega) \text { and } u_{n} \rightarrow u_{*} \text { in } L^{r(z)}(\Omega) \text { as } n \rightarrow \infty . \tag{70}
\end{equation*}
$$

We have

$$
\left\langle A\left(u_{n}\right), h\right\rangle+\int_{\Omega} \xi(z) u_{n}^{p(z)-1} h d z=\lambda_{n} \int_{\Omega} u_{n}^{q(z)-1} h d z+\int_{\Omega} f\left(z, u_{n}\right) h d z
$$

for all $h \in W_{0}^{1, p(z)}(\Omega)$, all $n \in \mathbb{N}$.
Choosing $h=u_{n}-u_{*}$, passing to the limit as $n \rightarrow \infty$ and using (70) and Proposition 2.3. we obtain

$$
u_{n} \rightarrow u_{*} \text { in } W_{0}^{1, p(z)}(\Omega) .
$$

So, in the limit as $n \rightarrow \infty$, we have

$$
\left\langle A\left(u_{*}\right), h\right\rangle+\int_{\Omega} \xi(z) u_{*}^{p(z)-1} h d z=\lambda^{*} \int_{\Omega} u_{*}^{q(z)-1} h d z+\int_{\Omega} f\left(z, u_{*}\right) h d z
$$

for all $h \in W_{0}^{1, p(z)}(\Omega)$.
We have

$$
\begin{aligned}
& \bar{u}_{\lambda_{1}} \leq u_{n} \text { for all } n \in \mathbb{N} \\
& \text { (see the Remark after Proposition (3.7), } \\
\Rightarrow & \bar{u}_{\lambda_{1}} \leq u_{*}, \\
\Rightarrow & u_{*} \in S_{\lambda^{*}} \subseteq \operatorname{int} C_{+} \text {and so } \lambda^{*} \in \mathcal{L} .
\end{aligned}
$$

The proof is now complete.
According to this proposition, we have

$$
\mathcal{L}=\left(0, \lambda^{*}\right] .
$$

Summarizing, we can state the following bifurcation-type result describing in a precise way the set of the positive solutions of problem $\left(P_{\lambda}\right)$ as the parameter $\lambda>0$ varies.

Theorem 3.13. If hypotheses $H_{0}, H_{3}$ hold, then there exists $\lambda^{*}>0$ such that
(a) for all $\lambda \in\left(0, \lambda^{*}\right)$, problem $\left(P_{\lambda}\right)$ has at least two positive solutions

$$
u_{0}, \hat{u} \in \operatorname{int} C_{+}, u_{0} \neq \hat{u} ;
$$

(b) for $\lambda=\lambda^{*}$, problem $\left(P_{\lambda}\right)$ has at least one positive solution

$$
u_{*} \in \operatorname{int} C_{+} ;
$$

(c) for $\lambda>\lambda^{*}$, problem $\left(P_{\lambda}\right)$ has no positive solutions;
(d) for every $\lambda \in \mathcal{L}=\left(0, \lambda^{*}\right]$, problem $\left(P_{\lambda}\right)$ has a smallest positive solution $u_{\lambda}^{*} \in \operatorname{int} C_{+}$ and the map $\lambda \mapsto u_{\lambda}^{*}$ from $\mathcal{L}=\left(0, \lambda^{*}\right]$ into $C_{+} \backslash\{0\}$ is increasing, that is,

$$
0<\mu \leq \lambda \in \mathcal{L} \Rightarrow u_{\lambda}^{*}-u_{\mu}^{*} \in C_{+} \backslash\{0\} .
$$
