# PARTS AND COMPOSITES OF QUANTUM SYSTEMS

#### Abstract

We consider three types of entities for quantum measurements. In order of generality, these types are: observables, instruments and measurement models. If  $\alpha$  and  $\beta$  are entities, we define what it means for  $\alpha$  to be a part of  $\beta$ . This relationship is essentially equivalent to  $\alpha$ being a function of  $\beta$  and in this case  $\beta$  can be employed to measure  $\alpha$ . We then use the concept to define coexistence of entities and study its properties. A crucial role is played by a map  $\hat{\alpha}$  which takes an entity of a certain type to one of lower type. For example, if  $\mathcal{I}$  is an instrument, then  $\widehat{\mathcal{I}}$  is the unique observable measured by  $\mathcal{I}$ . Composite systems are discussed next. These are constructed by taking the tensor product of the Hilbert spaces of the systems being combined. Composites of the three types of measurements and their parts are studied. Reductions of types to their local components are discussed. We also consider sequential products of measurements. Specific examples of Lüders, Kraus and trivial instruments are used to illustrate various concepts. We only consider finite-dimensional systems in this article.

#### 1 Introduction

Two important operations on quantum systems are the formations of parts and composites. In a rough sense, these operations are opposites to each other. The parts of a measurement  $\alpha$  are smaller components of  $\alpha$  in the sense that they can be simultaneously measured by  $\alpha$ . A composite system is a combination of two or more other systems. This combination is formed using the tensor product  $H = H_1 \otimes H_2$  where  $H_1$  and  $H_2$  are the Hilbert spaces describing two subsystems. The composite system contains more information than the individual systems because H describes how  $H_1$  and  $H_2$  interact. We can reduce measurements on H to simpler ones on  $H_1$  and  $H_2$  but information is lost in the process.

Section 2 presents the basic definitions that are needed in the sequel. Three types of quantum measurements are considered. In order of generality, these types are: observables, instruments and measurement models. At the basic level is an observable A which is a measurement whose outcome probabilities tr  $(\rho A_x)$  are determined by the state  $\rho$  of the system. At the next level is an instrument  $\mathcal{I}$ . We think of  $\mathcal{I}$  as an apparatus that can be employed to measure an observable  $\hat{\mathcal{I}}$ . Although  $\hat{\mathcal{I}}$  is unique, there are many instruments that can be used to measure an observable. Moreover,  $\mathcal{I}$  gives more information than  $\hat{\mathcal{I}}$  because, depending on the outcome  $x, \mathcal{I}$  updates the input state  $\rho$  to the output state  $\mathcal{I}_x(\rho)/\text{tr}(\rho \hat{\mathcal{I}}_x)$ . At the highest level is a measurement model  $\mathcal{M}$  that measures a unique instrument  $\widehat{\mathcal{M}}$ . Again, there are many measurement models that measure an instrument and  $\mathcal{M}$ contains more detailed information. For conciseness, we call these types of instruments *entities*. We should mention that all the quantum systems in this article are assumed to be finite-dimensional.

Section 3 considers system parts. If  $\alpha$  and  $\beta$  are entities, we define what it means for  $\alpha$  to be a *part* of  $\beta$  and when this is the case, we write  $\alpha \to \beta$ . If  $\alpha \to \beta$  and  $\beta \to \alpha$ , we say that  $\alpha$  and  $\beta$  are *equivalent*. We show that  $\alpha \to \beta$  implies  $\hat{\alpha} \to \hat{\beta}$  and that  $\to$  is a partial order to within equivalence. The relation  $\alpha \to \beta$  is the same as  $\alpha$  being a function of  $\beta$  or  $\hat{\beta}$  and in this case,  $\beta$  can be employed to measure  $\alpha$ . We then use this concept to define coexistence of entities and study its properties. We show that joint measurability is equivalent to coexistence. We then introduce sequential products of observables and use this concept to illustrate parts of entities. Section 4 discusses composite systems. These are constructed by taking the tensor product  $H = H_1 \otimes H_2$  where  $H_1, H_2$  are the Hilbert spaces of the systems being combined. Composites of the three types of measurements and parts of these composites are studied. Reductions of types into their local components are discussed. Specific examples of Lüders, Kraus and trivial instruments are employed to illustrate various concepts.

### 2 Basic Definitions

This section discusses the basic concepts and definitions that are needed in the sequel. Since these ideas are well developed in the literature [1, 2, 8, 11, 14], we shall proceed quickly and leave details and motivation to the reader's discretion. In this article we shall only consider finite-dimensional complex Hilbert spaces H. Let  $\mathcal{L}(H)$  be the set of linear operators on H. For  $S, T \in \mathcal{L}(H)$  we write  $S \leq T$  if  $\langle \phi, S\phi \rangle \leq \langle \phi, T\phi \rangle$  for all  $\phi \in H$ . We define the set of *effects* by

$$\mathcal{E}(H) = \{ a \in \mathcal{L}(H) \colon 0 \le a \le 1 \}$$

where 0, 1 are the zero and identity operators, respectively. Effects correspond to yes-no measurements and when the result of measuring a is yes, we say that a occurs. The complement of  $a \in \mathcal{E}(H)$  is a' = 1 - a and a' occurs if and only if a does not occur. A one-dimensional projection  $P_{\phi} = |\phi\rangle\langle\phi|$ , where  $||\phi|| = 1$  is an effect called an *atom*. We call  $\rho \in \mathcal{E}(H)$  a *partial state* if tr  $(\rho) \leq 1$  and  $\rho$  is a *state* if tr  $(\rho) = 1$ . We denote the set of partial states by  $\mathcal{S}_p(H)$  and the set of states by  $\mathcal{S}(H)$ . If  $\rho \in \mathcal{S}(H)$ ,  $a \in \mathcal{E}(H)$ , we call  $\mathcal{P}_{\rho}(a) = \operatorname{tr}(\rho a)$  the probability that a occurs in the state  $\rho$  [1, 8, 14]. For  $a, b \in \mathcal{E}(H)$ , their sequential product is the effect  $a \circ b = a^{1/2}ba^{1/2}$  where  $a^{1/2}$  is the unique square root of a [3, 4, 5]. We interpret  $a \circ b$  as the effect that results from first measuring a and then measuring b. We also call  $a \circ b$ the effect b conditioned on the effect a and write  $(b \mid a) = a \circ b$ .

Let  $\Omega_A$  be a finite set. A (finite) observable with outcome-space  $\Omega_A$  is a subset

$$A = \{A_x \colon x \in \Omega_A\} \subseteq \mathcal{E}(H)$$

satisfying  $\sum_{x \in \Omega_A} A_x = 1$ . We denote the set of observables on H by  $\mathcal{O}(H)$ . If  $B = \{B_y : y \in \Omega_B\}$  is another observable, we define the *sequential product* 

 $A \circ B \in \mathcal{O}(H)$  [5, 6, 7] to be the observable with outcome-space  $\Omega_A \times \Omega_B$  given by

$$A \circ B = \{A_x \circ B_y \colon (x, y) \in \Omega_A \times \Omega_B\}$$

We also define the observable B conditioned by A as

$$(B \mid A) = \{(B \mid A)_y \colon y \in \Omega_B\} \subseteq \mathcal{E}(H)$$

where  $(B \mid A)_y = \sum_{x \in \Omega_A} (A_x \circ B_y)$ . If  $A \in \mathcal{O}(H)$  we define the *effect-valued* measure (or POVM)  $X \to A_X$  from  $2^{\Omega_A}$  to  $\mathcal{E}(H)$  by  $A_X = \sum_{x \in X} A_x$  and we also call  $X \mapsto A_X$  an observable [5, 8, 14]. Moreover, we have the observables

$$(A \circ B)_{\Delta} = \sum_{(x,y) \in \Delta} (A_x \circ B_y)$$

and

$$(B \mid A)_Y = \sum_{x \in \Omega_A} (A_x \circ B_Y)$$

If  $\rho \in \mathcal{S}(H)$  and  $A \in \mathcal{O}(H)$ , the probability that A has an outcome in  $X \subseteq \Omega_A$  when the system is in state  $\rho$  is  $\mathcal{P}_{\rho}(A_X) = \operatorname{tr}(\rho A_X)$ . Notice that  $X \mapsto \mathcal{P}_{\rho}(A_X)$  is a probability measure on  $\Omega_A$ . We call

$$\mathcal{P}_{\rho}(A_X \text{ then } B_Y) = \text{tr } [\rho(A \circ B)_{X \times Y}]$$

the joint probability of  $A_X$  then  $B_Y$  [5, 6, 7].

An operation is a completely positive map  $\mathcal{A} \colon \mathcal{S}_p(H) \to \mathcal{S}_p(H)$  [1, 8, 14]. Any operation has a Kraus decomposition

$$\mathcal{A}(\rho) = \sum_{i=1}^{n} S_i \rho S_i^*$$

where  $S_i \in \mathcal{L}(H)$  with  $\sum_{i=1}^n S_i^* S_i \leq 1$ . An operation  $\mathcal{A}$  is a *channel* if  $\mathcal{A}(\rho) \in \mathcal{S}(H)$  for all  $\rho \in \mathcal{S}(H)$ . In this case  $\sum_{i=1}^n S_i^* S_i = 1$  and we denote the set of channels on H by  $\mathcal{C}(H)$ . Notice that if  $a \in \mathcal{E}(H)$ , then  $\rho \mapsto (\rho \mid a) = a \circ \rho$  is an operation and if  $A \in \mathcal{O}(H)$ , then  $\rho \mapsto (\rho \mid A) = \sum_{x \in \Omega_A} (A_x \circ \rho)$  is a

channel. For a finite set  $\Omega_{\mathcal{I}}$ , a (finite) *instrument* with outcome-space  $\Omega_{\mathcal{I}}$ is a set of operations  $\mathcal{I} = \{\mathcal{I}_x : x \in \Omega_{\mathcal{I}}\}$  satisfying  $\mathcal{C}_{\mathcal{I}} = \sum_{x \in \Omega_{\mathcal{I}}} \mathcal{I}_x \in \mathcal{C}(H)$ [1, 8, 14, 15]. Defining  $\mathcal{I}_X = \sum_{x \in X} \mathcal{I}_x$  for  $X \subseteq \Omega_{\mathcal{I}}$ , we see that  $X \mapsto \mathcal{I}_X$  is an operation-valued measure on H that we also call an *instrument*. We denote the set of instruments on H by  $\operatorname{In}(H)$ . We say that  $\mathcal{I} \in \operatorname{In}(H)$  measures  $A \in \mathcal{O}(H)$  if  $\Omega_A = \Omega_{\mathcal{I}}$  and

$$\mathcal{P}_{\rho}(A_X) = \operatorname{tr} \left[ \mathcal{I}_X(\rho) \right] \tag{2.1}$$

for every  $\rho \in \mathcal{S}(H), X \subseteq \Omega_A$ . There is a unique  $A \in \mathcal{O}(H)$  that  $\mathcal{I}$  measures and we write  $A = \hat{\mathcal{I}}$  [1, 8, 15]. For  $\mathcal{I}, \mathcal{J} \in \text{In}(H)$ , we define the *product instrument* with outcome space  $\Omega_{\mathcal{I}} \times \Omega_{\mathcal{J}}$  by

$$(\mathcal{I} \circ \mathcal{J})_{(x,y)}(\rho) = \mathcal{J}_y [\mathcal{I}_x(\rho)]$$

for every  $\rho \in \mathcal{S}(H)$ . We also define the *conditioned instrument* with outcomespace  $\Omega_{\mathcal{J}}$  by

$$(\mathcal{J} \mid \mathcal{I})_y = \sum_{x \in \Omega_{\mathcal{I}}} (\mathcal{I} \circ \mathcal{J})_{(x,y)} = \mathcal{J}_y \left[ \mathcal{C}_{\mathcal{I}}(\rho) \right]$$

We conclude that

$$(\mathcal{I} \circ \mathcal{J})_{\Delta}(\rho) = \sum_{(x,y)\in\Delta} \mathcal{J}_y \left(\mathcal{I}_x(\rho)\right)$$

for all  $\Delta \subseteq \Omega_{\mathcal{I}} \times \Omega_{\mathcal{J}}$  and

$$(\mathcal{J} \mid \mathcal{I})_Y = \sum_{y \in Y} \mathcal{J}_y \left( \mathcal{C}_{\mathcal{I}}(\rho) \right)$$

for all  $Y \subseteq \Omega_{\mathcal{J}}$  [5, 6, 7].

A finite measurement model (MM) is a 5-tuple  $\mathcal{M} = (H, K, \eta, \nu, F)$ where H, K are finite-dimensional Hilbert spaces called the base and probe systems, respectively,  $\eta \in \mathcal{S}(K)$  is an initial probe state,  $\nu \in \mathcal{C}(H \otimes K)$  is a channel describing the measurement interaction between the base and probe systems and  $F \in \mathcal{O}(K)$  is the probe (or meter) observable [1, 8, 9], We say that  $\mathcal{M}$  measures the model instrument  $\widehat{\mathcal{M}} \in \text{In}(H)$  where  $\widehat{\mathcal{M}}$  is the unique instrument satisfying

$$\widehat{\mathcal{M}}_X(\rho) = \operatorname{tr}_K \left[ \nu(\rho \otimes \eta) (I \otimes F_X) \right]$$
(2.2)

for all  $\rho \in \mathcal{S}(H)$ ,  $X \subseteq \Omega_F$ . In (2.2), tr<sub>K</sub> is the partial trace over K [8, 14]. We also say that  $\mathcal{M}$  measures the model observable  $\mathcal{M}^{\wedge\wedge}$ .

We thus have three levels of abstraction. At the basic level is an observable A which is a measurement whose outcome probabilities  $\operatorname{tr}(\rho A_x)$  are determined by the state  $\rho$  of the system. At the next level is an instrument  $\mathcal{I}$ . We think of  $\mathcal{I}$  as an apparatus that can be employed to measure an observable  $\hat{\mathcal{I}}$ . Although  $\hat{\mathcal{I}}$  is unique, there are many instruments that can be used to measure an observable. Moreover,  $\mathcal{I}$  gives more information than  $\hat{\mathcal{I}}$  because, depending on the outcome x (or event X),  $\mathcal{I}$  updates the input state  $\rho$  to the output partial state  $\mathcal{I}_x(\rho)$  (or  $\mathcal{I}_X(\rho)$ ). At the highest level is a measurement model  $\mathcal{M}$  that measures a unique model instrument  $\widehat{\mathcal{M}}$  and a unique model observable  $\mathcal{M}^{\wedge\wedge}$ . Again, there are many MMs that measure any instrument or observable and  $\mathcal{M}$  contains more detailed information on how the measurement is performed.

### 3 System Parts

We begin by discussing parts of systems at the three levels considered in Section 2. We then show how parts can be used to define coexistence at these levels and even between levels. We also show that coexistence is equivalent to simultaneous measurability.

An element at one of the three levels discussed in Section 2 is called an entity. The three levels are said to be the types 1, 2 and 3, respectively. The concept of an entity being part of another entity was originally introduced in [9, 10]. If  $A, B \in \mathcal{O}(H)$ , we say that A is part of B (and write  $A \to B$ ) if there exists a surjection  $f: \Omega_B \to \Omega_A$  such that  $A_x = B_{f^{-1}(x)}$  for all  $x \in \Omega_A$ . We then write A = f(B). It follows that  $A_X = B_{f^{-1}(X)}$  for all  $X \in \Omega_A$  and that

$$A_X = \sum \{B_y \colon f(y) \in X\}$$
(3.1)

If  $\mathcal{I}, \mathcal{J} \in \text{In}(H)$ , we say that  $\mathcal{I}$  is part of  $\mathcal{J}$  (and write  $\mathcal{I} \to \mathcal{J}$ ) if there exists a surjection  $f: \Omega_{\mathcal{J}} \to \Omega_{\mathcal{I}}$  such that  $\mathcal{I}_x = \mathcal{J}_{f^{-1}(x)}$  for all  $x \in \Omega_{\mathcal{J}}$ . We then write  $\mathcal{I} = f(\mathcal{J})$  and an equation analogous to (3.1) holds. For MMs $\mathcal{M}_1 = (H, K, \eta, \nu, F_1)$  and  $\mathcal{M}_2 = (H, K, \eta, \nu, F_2)$  we say that  $\mathcal{M}_1$  is part of  $\mathcal{M}_2$  (and write  $\mathcal{M}_1 \to \mathcal{M}_2$ ) if  $F_1 \to F_2$ . It follows that  $F_1 = f(F_2)$  and we write  $\mathcal{M}_1 = f(\mathcal{M}_2)$ . We can also define "part of" for entities of different types. An observable  $A \in \mathcal{O}(H)$  is part of  $\mathcal{I} \in \text{In}(H)$  (written  $A \to \mathcal{I}$ ) if  $A \to \widehat{\mathcal{I}}$  and A is part of  $\mathcal{M}$  (written  $A \to \mathcal{M}$ ) if  $A \to \widehat{\mathcal{M}}$  which is equivalent to  $A \to \mathcal{M}^{\wedge \wedge}$ . Finally, we say that  $\mathcal{I}$  is part of  $\mathcal{M}$  (written  $\mathcal{I} \to \mathcal{M}$ ) if  $\mathcal{I} \to \widehat{\mathcal{M}}$ . Two entities  $\alpha$  and  $\beta$  are equivalent (written  $\alpha \cong \beta$ ) if  $\alpha \to \beta$  and  $\beta \to \alpha$ . It is easy to check that  $\cong$  is an equivalence relation and that  $\alpha \cong \beta$  if and only if  $\alpha = f(\beta)$  for f a bijection. Our first result summarizes properties possessed by "part of". Some of these properties have been verified in [10], but we give the full proof for completeness.

**Theorem 3.1.** (a) If  $\alpha, \beta$  are of types 2 or 3 and  $\alpha \to \beta$ , then  $\widehat{\alpha} \to \widehat{\beta}$ . (b)  $f(\widehat{\mathcal{I}}) = f(\mathcal{I})^{\wedge}$  and  $f(\widehat{\mathcal{M}}) = f(\mathcal{M})^{\wedge}$ . (c) If  $\alpha, \beta, \gamma$  are of the same type and  $\alpha = g(\beta), \beta = f(\gamma)$ , then  $\alpha = (g \circ f)(\gamma)$ . (d) The relation  $\to$  is a partial order to within equivalence. (e) If  $\alpha$  and  $\beta$  are of different types and  $\alpha \to \beta$ , then  $\alpha = \widehat{\beta}_1$  where  $\beta_1 \to \beta$ .

Proof. (a) Let  $\mathcal{I}, \mathcal{J} \in \text{In}(H)$  with  $\mathcal{I} \to \mathcal{J}$ . Then there exists a surjection  $f: \Omega_{\mathcal{J}} \to \Omega_{\mathcal{I}}$  such that  $\mathcal{I} = f(\mathcal{J})$ . We now show that  $\widehat{\mathcal{I}} = f(\widehat{\mathcal{J}})$ . Indeed, for any  $\rho \in \mathcal{S}(H), x \in \Omega_{\mathcal{I}}$  we have that

$$\operatorname{tr}\left(\rho\widehat{\mathcal{I}}_{x}\right) = \operatorname{tr}\left[\mathcal{I}_{x}(\rho)\right] = \operatorname{tr}\left[\mathcal{J}_{f^{-1}(x)}(\rho)\right] = \operatorname{tr}\left[\rho\mathcal{J}_{f^{-1}(x)}\right] = \operatorname{tr}\left[\rho f(\mathcal{J})_{x}\right]$$

Hence,  $\mathcal{I} = f(\widehat{\mathcal{J}})$  so  $\widehat{\mathcal{I}} \to \widehat{\mathcal{J}}$ . Let  $\mathcal{M}_1 = (H, K, \eta, \nu, F_1)$ ,  $\mathcal{M}_2(H, K, \eta, \nu, F_2)$ be MMs where  $F_1 = f(F_2)$ . Then for any  $\rho \in \mathcal{S}(H)$ ,  $x \in \Omega_{F_1}$  we have that

$$\begin{aligned} \widehat{\mathcal{M}}_{1,x}(\rho) &= \operatorname{tr}_{K} \left[ \nu(\rho \otimes \eta) (I \otimes F_{1,x}) \right] = \operatorname{tr}_{K} \left[ \nu(\rho \otimes \eta) (I \otimes F_{2,f^{-1}(x)}) \right] \\ &= \widehat{\mathcal{M}}_{2,f^{-1}(x)}(\rho) = f(\widehat{\mathcal{M}}_{2}) \end{aligned}$$

Hence,  $\widehat{\mathcal{M}}_1 = f(\widehat{\mathcal{M}}_2)$  so  $\widehat{\mathcal{M}}_1 \to \widehat{\mathcal{M}}_2$ . If  $\mathcal{I} \to \mathcal{M}$ , then  $\mathcal{I} \to \widehat{\mathcal{M}}$ . As before,  $\widehat{\mathcal{I}} \to \mathcal{M}^{\wedge \wedge}$  so  $\widehat{\mathcal{I}} \to \widehat{\mathcal{M}}$ .

(b) This was proved in (a). (c) We prove the result for observables A, B, Cand the result for instruments and MMs is similar. We have that  $A_x = B_{g^{-1}(x)}$  and  $B_y = C_{f^{-1}(y)}$ . Since  $g: \Omega_B \to \Omega_A$  and  $f: \Omega_C \to \Omega_B$ , we have that  $g \circ f: \Omega_C \to \Omega_A$ . Hence,

$$A_x = B_{g^{-1}(x)} = C_{f^{-1}(g^{-1}(x))} = C_{(g \circ f)^{-1}(x)}$$

Hence,  $A = (g \circ f)(C)$ . (d) We only need to prove that if  $\alpha \to \beta$  and  $\beta \to \gamma$ , then  $\alpha \to \gamma$ . If  $\alpha, \beta, \gamma$  are of the same type, the  $\alpha \to \gamma$  follows from (c). Suppose  $A, B \in \mathcal{O}(H), \mathcal{I} \in \text{In}(H)$  and  $A \to B, B \to \mathcal{I}$ . Then  $A \to B \to \widehat{\mathcal{I}}$  and these are the same type so  $A \to \widehat{\mathcal{I}}$  and hence,  $A \to \mathcal{I}$ .

Suppose  $A \in \mathcal{O}(H)$   $\mathcal{I}, \mathcal{J} \in \text{In}(H)$  and  $A \to \mathcal{I}, \mathcal{I} \to \mathcal{J}$ . Then  $A \to \widehat{\mathcal{I}}$  and  $\mathcal{I} \to \mathcal{J}$ . By (a) we have  $\widehat{\mathcal{I}} \to \widehat{\mathcal{J}}$ . Since  $A, \widehat{\mathcal{I}}, \widehat{\mathcal{J}}$  have the same type,  $A \to \widehat{\mathcal{J}}$  and hence,  $A \to \mathcal{J}$ . Suppose that  $A \to \mathcal{I}$  and  $\mathcal{I} \to \mathcal{M}$ . Then  $A \to \widehat{\mathcal{I}}$  and  $\mathcal{I} \to \widehat{\mathcal{M}}$ . By (a)  $\widehat{\mathcal{I}} \to \mathcal{M}^{\wedge \wedge}$  so  $A \to \widehat{\mathcal{I}}$  and  $\widehat{\mathcal{I}} \to \mathcal{M}^{\wedge \wedge}$ . Since these are the same type, we have that  $A \to \mathcal{M}^{\wedge \wedge}$  so  $A \to \mathcal{M}$ . Similar reasoning holds for the cases  $\mathcal{I} \to \mathcal{J} \to \mathcal{M}$  and  $\mathcal{I} \to \mathcal{M}_1 \to \mathcal{M}_2$ .

(e) If  $A \in \mathcal{O}(H)$ ,  $\mathcal{I} \in \text{In}(H)$  and  $A \to \mathcal{I}$ , then  $A \to \widehat{\mathcal{I}}$  so  $A = f(\widehat{\mathcal{I}})$  for some surjection  $f: \Omega_{\widehat{\mathcal{J}}} \to \Omega_A$ . By (b) we have that  $f(\widehat{\mathcal{I}}) = f(\mathcal{I})^{\wedge}$  so letting  $\mathcal{I}_1 = f(\mathcal{I})$  we have that  $A = f(\mathcal{I})^{\wedge} = \widehat{\mathcal{I}}_1$ . Hence,  $\mathcal{I}_1 \to \mathcal{I}$ . If  $A \to \mathcal{M}$ , then  $A \to \mathcal{M}^{\wedge \wedge}$ . By (b),  $A = f(\mathcal{M}^{\wedge \wedge}) = \left[f(\widehat{\mathcal{M}})\right]^{\wedge}$ . Letting  $\mathcal{I} = f(\widehat{\mathcal{M}})$ we have that  $A = \widehat{\mathcal{I}}, \ \mathcal{I} \to \widehat{\mathcal{M}} \to \mathcal{M}$ . If  $\mathcal{I} \to \mathcal{M}$ , then  $\mathcal{I} \to \widehat{\mathcal{M}}$ . By (b)  $\mathcal{I} = f(\mathcal{M}^{\wedge}) = f(\mathcal{M})^{\wedge}$ . Letting  $\mathcal{I}_1 = f(\mathcal{M})$ , we have that  $\mathcal{I} = \widehat{\mathcal{I}}_1$  and  $\mathcal{I}_1 \to \mathcal{M}$ .

For an entity  $\alpha$ , we denote its set of parts by  $\tilde{a} = \{\beta : \beta \to \alpha\}$ . We say that a set  $\mathcal{A}$  of entities *coexist* if  $\mathcal{A} \subseteq \tilde{a}$  for some entity  $\alpha$ . A coexistent set  $\mathcal{A} \subseteq \tilde{a}$  is thought of as being simultaneously measured by  $\alpha$ . A related concept is that of joint measurability. We say that observables  $A^i \in \mathcal{O}(H)$  with outcome sets  $\Omega_i$ ,  $i = 1, 2, \ldots, n$  are *jointly measurable* with *joint observable*  $B \in \mathcal{O}(H)$  if  $\Omega_B = \Omega_1 \times \cdots \times \Omega_n$  and for all  $x_i \in \Omega_i$  we have

$$A_{x_{i}}^{i} = \sum \left\{ B_{(x_{1},\dots,x_{i},\dots,x_{n})} \colon x_{j} \in \Omega_{j}, j \neq i \right\}$$
(3.2)

We interpret  $A^i$  as being the *i*th marginal of B as in classical probability theory [5, 6, 9]. Similar definitions can be made for joint measurability of instruments and MMs.

**Theorem 3.2.** A set of observables  $A^i \in \mathcal{O}(H)$ , i = 1, 2, ..., n is jointly measurable if and only if the  $A^i$  coexist.

*Proof.* If  $\{A_i: i = 1, 2, ..., n\}$  are jointly measurable, there exists a joint observable  $B \in \mathcal{O}(H)$  satisfying (3.2). Defining  $f_i: \Omega_B \to \Omega_A i$  by

$$f_i(x_1,\ldots,x_i,\ldots,x_n)=x_i$$

for i = 1, 2, ..., n, then by (3.2) we have that  $A_{x_i}^i = B_{f_i^{-1}(x_i)}$  for all  $x_i \in \Omega_i$ . Hence,  $A^i = f_i(B), i = 1, 2, ..., n$ , so  $\{A^i\}$  coexist. Conversely, suppose that  $\{A^i: i = 1, 2, ..., n\}$  coexist so there exists an observable  $C \in \mathcal{O}(H)$  such that  $A^i \in \widetilde{C}$ , i = 1, 2, ..., n. We then have surjections  $f_i \colon \Omega_C \to \Omega_{A_i}$ such that  $A^i = f_i(C)$ , i = 1, 2, ..., n. Define  $\Omega_B = \Omega_1 \times \cdots \times \Omega_n$ , a surjection  $h \colon \Omega_C \to \Omega_B$  by  $h(y) = (f_1(y), \ldots, f_n(y))$  and let B = h(C). For i = 1, 2, ..., n, we obtain

$$\begin{split} A_{x_i}^i &= C_{f_i^{-1}(x_i)} = \sum \left\{ C_y \colon f_i(y) = x_i \right\} \\ &= \sum \left\{ C_y \colon (f_1(y), \dots, f_n(y)) = \left\{ x_1, \dots, x_i, \dots, x_n \right\}, x_j \in \Omega_j, j \neq i \right\} \\ &= \sum \left\{ C_y \colon h(y) = (x_1, \dots, x_i, \dots, x_n) \colon x_j \in \Omega_j, j \neq i \right\} \\ &= \sum \left\{ C_{h^{-1}(x_1, \dots, x_i, \dots, x_n)} \colon x_j \in \Omega_j, j \neq i \right\} \\ &= \sum \left\{ h(C)_{(x_1, \dots, x_i, \dots, x_n)} \colon x_j \in \Omega_j, j \neq i \right\} \\ &= \sum \left\{ B_{(x_1, \dots, x_i, \dots, x_n)} \colon x_j \in \Omega_j, j \neq i \right\} \end{split}$$

Thus, (3.2) holds so  $\{A^i\}$  are jointly measurable.

Theorem 3.2 also holds for instruments and MMs. An important property of coexistent entities is that they have joint probability distributions  $\Phi_{\rho}$  for all  $\rho \in \mathcal{S}(H)$ . For example, if  $A, B \in \mathcal{O}(H)$  coexist, then A = f(C), B = g(C) for some  $C \in \mathcal{O}(H)$ . Then for any  $X \subseteq \Omega_A$ ,  $Y \subseteq \Omega_B$ , the joint probability becomes

$$\Phi_{\rho}(A_X, B_Y) = \operatorname{tr}\left[\rho \sum \left\{ C_z \colon z \in f^{-1}(X) \cap g^{-1}(Y) \right\} \right] = \operatorname{tr}\left[\rho C_{f^{-1}(X) \cap g^{-1}(Y)}\right]$$

As another example, if  $A, B \in \mathcal{I}$ , then  $A, B \to \widehat{\mathcal{I}}$  so  $A = f(\widehat{\mathcal{I}}), B = g(\widehat{\mathcal{I}})$  for surjections f, g. We then obtain

$$\Phi_{\rho}(A_X, B_Y) = \operatorname{tr} \left[ \rho \widehat{\mathcal{I}}_{f^{-1}(X) \cap g^{-1}(Y)} \right] = \operatorname{tr} \left[ \mathcal{I}_{f^{-1}(X) \cap g^{-1}(Y)}(\rho) \right]$$

We can continue this for many coexistent entities. Moreover, the entities do not need to be of the same type. For instance, suppose  $A, \mathcal{I} \to \mathcal{J}$  where  $A = f(\hat{\mathcal{J}})$  and  $\mathcal{I} = g(\mathcal{J})$ . Then we have that

$$\Phi_{\rho}(A_X, \mathcal{I}_Y) = \Phi_{\rho}\left[f(\widehat{\mathcal{J}})_X, g(\mathcal{J})_Y\right] = \Phi_{\rho}\left[\widehat{\mathcal{J}}_{f^{-1}(X)}, \mathcal{J}_{g^{-1}(Y)}\right]$$
$$= \operatorname{tr}\left[\mathcal{J}_{f^{-1}(X)\cap g^{-1}(Y)}(\rho)\right]$$

For  $A \in \mathcal{O}(H)$  we define the probability distribution  $\Phi_{\rho}^{A}(X) = \operatorname{tr}(\rho A_{X})$ for all  $X \subseteq \Omega_{A}, \ \rho \in \mathcal{S}(H)$ . In a similar way, if  $\mathcal{I} \in \operatorname{In}(H)$  we define  $\Phi_{\rho}^{\mathcal{I}}(X) = \operatorname{tr}[\mathcal{I}_{X}(\rho)]$  and if  $\mathcal{M}$  is a MM, then  $\Phi_{\rho}^{\mathcal{M}}(X) = \Phi_{\rho}^{\widehat{\mathcal{M}}}(X)$ . **Lemma 3.3.** If  $\alpha$  is an entity and  $f: \Omega_{\alpha} \to \Omega$  is a surjection, then  $\Phi^{f(\alpha)} = \Phi^{\alpha} \circ f^{-1}$ .

*Proof.* We give the proof for  $A \in \mathcal{O}(H)$  and the proof for other entities is similar. For  $x \in \Omega_A$ ,  $\rho \in \mathcal{S}(H)$  we obtain

$$\Phi_{\rho}^{f(A)} = \operatorname{tr} \left[\rho f(A)_{x}\right] = \operatorname{tr} \left[\rho A_{f^{-1}(x)}\right] = \operatorname{tr} \left[\rho \sum \left\{A_{y} \colon f(y) = x\right\}\right]$$
$$= \sum \left\{\operatorname{tr} \left(\rho A_{y}\right) \colon f(y) = x\right\} = \sum \left\{\Phi_{\rho}^{A}(y) \colon f(y) = x\right\}$$
$$= \Phi_{\rho}^{A} \left[f^{-1}(x)\right] = \Phi_{\rho}^{A} \circ f^{-1}(x)$$

The result now follows.

We now consider sequential products of observables.

**Theorem 3.4.** If  $A, B \in \mathcal{O}(H)$  and  $h: \Omega_B \to \Omega$  is a surjection, then A,  $(B \mid A)$  and  $A \circ h(B)$  are parts of  $A \circ B$ .

*Proof.* Defining  $f: \Omega_A \times \Omega_B \to \Omega_A$  by f(x, y) = x we have that

$$f(A \circ B)_x = (A \circ B)_{f^{-1}(x)} = \sum \{ (A \circ B)_{(y,z)} \colon f(y,z) = x \} = \sum_{z \in \Omega_B} (A \circ B)_{(x,z)}$$
$$= \sum_{z \in \Omega_B} A_x \circ B_z = A_x \circ 1 = A_x$$

Thus,  $A = f(A \circ B)$  so  $A \to A \circ B$ . Defining  $g \colon \Omega_A \times \Omega_B \to \Omega_B$  by g(x, y) = y we obtain

$$g(A \circ B)_y = (A \circ B)_{g^{-1}(y)} = \sum \{ (A \circ B)_{(x,z)} \colon g(x,z) = y \} = \sum_{x \in \Omega_A} (A \circ B)_{(x,y)}$$
$$= \sum_{x \in \Omega_A} A_x \circ B_y = (B \mid A)_y$$

Hence,  $(B \mid A) = g(A \circ B)$  so  $(B \mid A) \to A \circ B$ . Defining  $u: \Omega_A \times \Omega_B \to \Omega_A \times \Omega$  by u(x, y) = (x, h(y)) we have that

$$[u(A \circ B)]_{(x,y)} = (A \circ B)_{u^{-1}(x,y)} = (A \circ B)_{(x,h^{-1}(y))} = A_x \circ B_{h^{-1}(y)}$$
$$= A_x \circ h(B)_y = [A \circ h(B)]_{(x,y)}$$

It follows that  $A \circ h(B) = u(A \circ B)$ . Hence,  $A \circ h(B) \to A \circ B$ .

Some results analogous to Theorem 3.4 hold for other entities.

**Example 1.** We consider the simplest nontrivial example of a sequential product  $A \circ B$  of observables. Let  $A = \{a_0, a_1\}, B = \{b_0, b_1\}$  be binary (diatomic) observables. Then  $\Omega_{A \circ B} = \{0, 1\} \times \{0, 1\}$  and

$$A \circ B = \{a_0 \circ b_0, a_1 \circ b_0, a_0 \circ b_1, a_1 \circ b_1\}$$

Except in trivial cases,  $A \circ B$  has precisely the following nine parts to within equivalence:

$$A \circ B, \{a_0 \circ b_0, a_1 + a_0 \circ b_1\}, \{a_1 \circ b_0, a_0 + a_1 \circ b_1\}, \{a_0 \circ b_1, a_1 + a_0 \circ b_0\}$$
$$\{a_1 \circ b_1, a_0 + a_1 \circ b_0\}, \{a_0 \circ b_0 + a_1 \circ b_0, a_0 \circ b_1 + a_1 \circ b_1\}, \{a_0, a_1\}$$
$$\{a_0 \circ b_0 + a_1 \circ b_1, a_1 \circ b_0 + a_0 \circ b_1\}, \{1\}$$

Notice that the sixth of the parts is  $(B \mid A)$  and the seventh is A as required by Theorem 3.4. Each of the parts is a function of  $A \circ B$ . The parts listed correspond to the following functions  $f_i: \{0,1\} \times \{0,1\} \rightarrow \{1,2,3,4\}, i = 1, 2, \dots, 9.$

**Example 2.** Similar to Example 1, for the two binary instruments  $\mathcal{I} = {\mathcal{I}_0, \mathcal{I}_1}, \mathcal{J} = {\mathcal{J}_0, \mathcal{J}_1}$  we have the instrument  $\mathcal{I} \circ \mathcal{J}$  with

 $\Omega_{\mathcal{I}\circ\mathcal{J}}=\{0,1\}\times\{0,1\}$  and

$$\mathcal{I} \circ \mathcal{J} = \{\mathcal{I}_0 \circ \mathcal{J}_0, \mathcal{I}_1 \circ \mathcal{J}_0, \mathcal{I}_0 \circ \mathcal{J}_1, \mathcal{I}_1 \circ \mathcal{J}_1\}$$

The nine parts of  $\mathcal{I} \circ \mathcal{J}$  to within equivalence are:

$$\begin{split} \mathcal{I} &\circ \mathcal{J}, \left\{ \mathcal{I}_0 \circ \mathcal{J}_0, \mathcal{I}_0 \circ \mathcal{J}_1 + \mathcal{I}_1 \circ \mathcal{C}_{\mathcal{J}} \right\}, \left\{ \mathcal{I}_1 \circ \mathcal{J}_0, \mathcal{I}_1 \circ \mathcal{J}_1 + \mathcal{I}_0 \circ \mathcal{C}_{\mathcal{J}} \right\} \\ &\left\{ \mathcal{I}_0 \circ \mathcal{J}_1, \mathcal{I}_0 \circ \mathcal{J}_0 + \mathcal{I}_1 \circ \mathcal{C}_{\mathcal{J}} \right\}, \left\{ \mathcal{I}_1 \circ \mathcal{J}_1, \mathcal{I}_1 \circ \mathcal{J}_0 + \mathcal{I}_0 \circ \mathcal{C}_{\mathcal{J}} \right\}, \left\{ \mathcal{C}_{\mathcal{I}} \circ \mathcal{J}_0, \mathcal{C}_{\mathcal{I}} \circ \mathcal{J}_1 \right\} \\ &\left\{ \mathcal{I}_0 \circ \mathcal{C}_{\mathcal{J}}, \mathcal{I}_1 \circ \mathcal{C}_{\mathcal{J}} \right\}, \left\{ \mathcal{I}_0 \circ \mathcal{J}_0 + \mathcal{I}_1 \circ \mathcal{J}_1, \mathcal{I}_1 \circ \mathcal{J}_0 + \mathcal{I}_0 \circ \mathcal{J}_1 \right\}, \left\{ \mathcal{C}_{\mathcal{I} \circ \mathcal{J}} \right\} \end{split}$$

As in Example 1, the sixth part is  $(\mathcal{J} \mid \mathcal{I})$ , however, unlike the observable case, the seventh part is not  $\mathcal{I}$ . In fact, unlike that case,  $\mathcal{I}$  is not a part of  $(\mathcal{I} \circ \mathcal{J})$ .

If  $A \in \mathcal{O}(H)$  the corresponding Lüders instrument  $\mathcal{L}^A \in \mathrm{In}(H)$  is defined by  $\Omega_{\mathcal{L}^A} = \Omega_A$  and  $\mathcal{L}^A_x(\rho) = A_x^{1/2} \rho A_x^{1/2}$  for all  $\rho \in \mathcal{S}(H)$ . It follows that [13]

$$\mathcal{L}_X^A(\rho) = \sum_{x \in X} A_x^{1/2} \rho A_x^{1/2}$$

for all  $\rho \in \mathcal{S}(H)$ ,  $X \subseteq \Omega_A$ . It is easy to check that  $(\mathcal{L}^A)^{\wedge} = A$ . Hence, for  $B \in \mathcal{O}(H)$  we have that  $B \to \mathcal{L}^A$  if and only if  $B \to A$ .

**Theorem 3.5.** (a)  $\mathcal{L}^{A \circ B} = \mathcal{L}^A \circ \mathcal{L}^B$  if and only if  $A_x B_y = B_y A_x$  for all  $x \in \Omega_A$ ,  $y \in \Omega_B$ . (b)  $(\mathcal{L}^{A \circ B})^{\wedge} = (\mathcal{L}^A \circ \mathcal{L}^B)^{\wedge} = A \circ B$ . (c) An observable C satisfies  $C \to \mathcal{L}^A \circ \mathcal{L}^B$  if and only if  $C \to A \circ B$ .

*Proof.* (a) For all  $\rho \in \mathcal{S}(H)$ ,  $(x, y) \in \Omega_A \times \Omega_B$  we have that

$$(\mathcal{L}^{A} \circ \mathcal{L}^{B})_{(x,y)}(\rho) = \mathcal{L}_{y}^{B} \left( \mathcal{L}_{x}^{A}(\rho) \right) = \mathcal{L}_{y}^{B} (A_{x}^{1/2} \rho A_{x}^{1/2}) = B_{y}^{1/2} A_{x}^{1/2} \rho A_{x}^{1/2} B_{y}^{1/2}$$

$$(3.3)$$

On the other hand,

$$(\mathcal{L}^{A \circ B})_{(x,y)}(\rho) = (A \circ B)^{1/2}_{(x,y)}\rho(A \circ B)^{1/2}_{(x,y)} = (A_x \circ B_y)^{1/2}\rho(A_x \circ B_y)^{1/2} = (A_x^{1/2}B_yA_x^{1/2})^{1/2}\rho(A_x^{1/2}B_yA_x^{1/2})^{1/2}$$
(3.4)

If  $A_x B_y = B_y A_x$ , we obtain

$$\begin{aligned} (\mathcal{L}^{A_{\circ}B})_{(x,y)}(\rho) &= (A_x B_y)^{1/2} \rho (A_x B_y)^{1/2} = B_y^{1/2} A_x^{1/2} \rho A_x^{1/2} B_y^{1/2} \\ &= (\mathcal{L}^A \circ \mathcal{L}^B)_{(x,y)}(\rho) \end{aligned}$$

so that  $\mathcal{L}^{A \circ B} = \mathcal{L}^A \circ \mathcal{L}^B$ . Conversely, if  $\mathcal{L}^{A \circ B} = \mathcal{L}^A \circ \mathcal{L}^B$ , letting  $\rho = \frac{1}{n} \mathbf{1}$  where  $n = \dim H$ , we obtain from (3.3) and (3.4) that

$$B_y \circ A_x = B_y^{1/2} A_x B_y^{1/2} = A_x^{1/2} B_y A_x^{1/2} = A_x \circ B_y$$

It follows that  $B_y A_x = A_x B_y$  for all  $x \in \Omega_A$ ,  $y \in \Omega_B$  [4]. (b) We have already pointed out that  $(\mathcal{L}^{A \circ B})^{\wedge} = A \circ B$ . To show that  $(\mathcal{L}^A \circ \mathcal{L}^B)^{\wedge} = A \circ B$ , applying (3.3) gives

$$\operatorname{tr}\left[\rho(\mathcal{L}^{A}\circ\mathcal{L}^{B})^{\wedge}_{(x,y)}\right] = \operatorname{tr}\left[(\mathcal{L}^{A}\circ\mathcal{L}^{B})_{(x,y)}(\rho)\right] = \operatorname{tr}\left(\rho A_{x}^{1/2}B_{y}A_{x}^{1/2}\right)$$
$$\operatorname{tr}\left(\rho A_{x}\circ B_{y}\right) = \operatorname{tr}\left[\rho(A\circ B)_{(x,y)}\right]$$

Hence,  $(\mathcal{L}^A \circ \mathcal{L}^B)^{\wedge} = A \circ B$ . (c) This follows from (b) and Theorem 3.1(a).

**Example 3.** We have seen from Theorem 3.5(b) that  $(\mathcal{L}^A \circ \mathcal{L}^B)^{\wedge} = (\mathcal{L}^A)^{\wedge} \circ (\mathcal{L}^B)^{\wedge}$ . We now show that  $(\mathcal{I} \circ \mathcal{J})^{\wedge} \neq \widehat{\mathcal{I}} \circ \widehat{\mathcal{J}}$  in general. Let  $\delta, \gamma \in \mathcal{S}(H)$  and  $A, B \in \mathcal{O}(H)$ . The instruments  $\mathcal{I}_x(\rho) = \operatorname{tr}(\rho A_x)\delta$  and  $\mathcal{J}_y(\rho) = \operatorname{tr}(\rho B_y)\gamma$  are called *trivial instruments* with observables A, B and states  $\delta, \gamma$ , respectively [8]. We have that

$$\operatorname{tr}\left(\rho\widehat{\mathcal{I}}_{x}\right) = \operatorname{tr}\left[\mathcal{I}_{x}(\rho)\right] = \operatorname{tr}\left[\operatorname{tr}\left(\rho A_{x}\right)\delta\right] = \operatorname{tr}\left(\rho A_{x}\right)$$

Hence,  $\widehat{\mathcal{I}} = A$  and similarly  $\widehat{\mathcal{J}} = B$ . For all  $\rho \in \mathcal{S}(H)$  we obtain

$$\operatorname{tr}\left[\rho(\mathcal{I}\circ\mathcal{J})^{\wedge}_{(x,y)}\right] = \operatorname{tr}\left[(\mathcal{I}\circ\mathcal{J})_{(x,y)}(\rho)\right] = \operatorname{tr}\left[\mathcal{J}_{y}\left(\mathcal{I}_{x}(\rho)\right)\right] = \operatorname{tr}\left[\mathcal{J}_{y}\left(\operatorname{tr}\left(\rho A_{x}\right)\delta\right)\right]$$
$$= \operatorname{tr}\left(\rho A_{x}\right)\operatorname{tr}\left[\mathcal{J}_{y}(\delta)\right] = \operatorname{tr}\left(\rho A_{x}\right)\operatorname{tr}\left[\operatorname{tr}\left(\delta B_{y}\right)\gamma\right]$$
$$= \operatorname{tr}\left(\rho A_{x}\right)\operatorname{tr}\left(\delta B_{y}\right)$$
(3.5)

On the other hand,

$$\operatorname{tr}\left[\rho\widehat{\mathcal{I}}_{x}\circ\widehat{\mathcal{J}}_{y}\right] = \operatorname{tr}\left(\rho A_{x}\circ B_{y}\right)$$
(3.6)

Since the right hand sides of (3.5) and (3.6) are different in general, we conclude that  $(\mathcal{I} \circ \mathcal{J})^{\wedge} \neq \widehat{\mathcal{I}} \circ \widehat{\mathcal{J}}$ .

We saw in Theorem 3.5(a) that  $\mathcal{L}^{A \circ B} \neq \mathcal{L}^A \circ \mathcal{L}^B$ , in general. The following lemma shows they can differ in a striking way.

**Lemma 3.6.** If  $A_x = |\phi_x\rangle\langle\phi_x|$  and  $B_y = |\psi_y\rangle\langle\psi_y|$  are atomic observables on H, then for all  $\rho \in \mathcal{S}(H)$ , there exist numbers  $\lambda_{xy}(\rho) \in [0,1]$ with  $\sum_{x,y} \lambda_{xy}(\rho) = 1$  such that  $\mathcal{L}_{(x,y)}^{A \circ B}(\rho) = \lambda_{xy}(\rho)A_x$  and  $(\mathcal{L}^A \circ \mathcal{L}^B)_{(x,y)}(\rho) = \lambda_{xy}(\rho)B_y$  for all  $(x, y) \in \Omega_A \times \Omega_B$ .

*Proof.* For all  $\rho \in \mathcal{S}(H)$  we have that

$$(\mathcal{L}^{A} \circ \mathcal{L}^{B})_{(x,y)}(\rho) = \mathcal{L}_{y}^{B} \left( \mathcal{L}_{x}^{A}(\rho) \right) = B_{y} A_{x} \rho A_{x} B_{y}$$
$$= |\psi_{x}\rangle \langle \psi_{y}| |\phi_{x}\rangle \langle \phi_{x}|\rho|\phi_{x}\rangle \langle \phi_{x}| |\psi_{y}\rangle \langle \psi_{y}$$
$$= |\langle \phi_{x}, \psi_{y}\rangle|^{2} \langle \phi_{x}, \rho\phi_{x}\rangle B_{y}$$

Since

$$A_x B_y A_x = |\phi_x\rangle \langle \phi_x | |\psi_y\rangle \langle \psi_y | |\phi_x\rangle \langle \phi_x | = |\langle \phi_x, \psi_y\rangle|^2 A_x$$

we obtain

$$(A_x B_y A_x)^{1/2} = |\langle \phi_x, \psi_y \rangle| A_x$$

Hence,

$$(\mathcal{L}^{A \circ B})_{(x,y)}(\rho) = (A_x B_y A_x)^{1/2} \rho (A_x B_y A_x)^{1/2} = |\langle \phi_x, \psi_y \rangle|^2 \langle \phi_x, \rho \phi_x \rangle A_x$$

Letting  $\lambda_{xy}(\rho) = |\langle \phi_x, \psi_y \rangle|^2 \langle \phi_x, \rho \phi_x \rangle$ , the result follows

# 4 Composite Systems

Let  $H_1$  and  $H_2$  be Hilbert spaces with dim  $H_1 = n_1$  and dim  $H_2 = n_2$ . If  $H_1, H_2$  represent quantum systems, we call  $H = H_1 \otimes H_2$  a composite quantum system. For  $a \in \mathcal{E}(H)$ , we define the reduced effects  $a^1 \in \mathcal{E}(H_1)$ ,  $a^2 \in \mathcal{E}(H_2)$  by  $a^1 = \frac{1}{n_2} \operatorname{tr}_2(a)$ ,  $a^2 = \frac{1}{n_1} \operatorname{tr}_1(a)$ . We view  $a^i$  to be the effect a as measured in system i = 1, 2. The map  $a \mapsto a^1$  is a surjective effect algebra morphism from  $\mathcal{E}(H)$  onto  $\mathcal{E}(H_1)$  and similarly for  $a \mapsto a^2$  [3, 4]. Conversely, if  $a \in \mathcal{E}(H_1)$ ,  $b \in \mathcal{E}(H_2)$ , then  $a \otimes b \in \mathcal{E}(H)$  and

$$(a \otimes b)^1 = \frac{1}{n_2} \operatorname{tr}_2(a \otimes b) = \frac{1}{n_2} \operatorname{tr}(b)a$$

Similarly,  $(a \otimes b)^2 = \frac{1}{n_1} \operatorname{tr}(a)b$ . It follows that

$$(a^1 \otimes a^2)^1 = \frac{1}{n_2} \operatorname{tr} (a^2) a^1$$

$$(a^1 \otimes a^2)^2 = \frac{1}{n_1} \operatorname{tr} (a^1) a^2$$

An effect  $a \in \mathcal{E}(H)$  is factorized if  $a = b \otimes c$  for  $b \in \mathcal{E}(H_1), c \in \mathcal{E}(H_2)$  [8].

**Lemma 4.1.** If  $a \in \mathcal{E}(H)$  with  $a \neq 0$ , then a is factorized if and only if

$$a = \frac{n_1 n_2}{\operatorname{tr}\left(a\right)} a^1 \otimes a^2 \tag{4.1}$$

*Proof.* If (4.1) holds, then *a* is factorized. Conversely, suppose *a* is factorized with  $a = b \otimes c$ ,  $b \in \mathcal{E}(H_1)$ ,  $c \in \mathcal{E}(H_2)$ . Then  $a^1 = \frac{1}{n_2} \operatorname{tr}(c)b$  and  $a^2 = \frac{1}{n_1} \operatorname{tr}(b)c$ . Hence,  $b = \frac{n_2}{\operatorname{tr}(c)} a^1$  and  $c = \frac{n_1}{\operatorname{tr}(b)} a^2$ . We conclude that

$$a = \frac{n_1 n_2}{\operatorname{tr}(b) \operatorname{tr}(c)} a^1 \otimes a^2 = \frac{n_1 n_2}{\operatorname{tr}(a)} a^1 \otimes a^2 \qquad \Box$$

**Corollary 4.2.** If  $a \in \mathcal{E}(H)$ , then  $a = a^1 \otimes a^2$  if and only if a = 0 or a = 1.

*Proof.* If a = 0 or a = 1, then clearly  $a = a^1 \otimes a^2$ . Conversely, if  $a = a^1 \otimes a^2$ , then by Lemma 4.1, a = 0 or tr  $(a) = n_1 n_2$ . In the latter case, a = 1.

An effect is *indecomposable* if it has the form  $a = \lambda b$  where  $0 \le \lambda \le 1$  and b is an atom.

**Theorem 4.3.** Let  $a \in \mathcal{E}(H)$  be an atom  $a = P_{\psi}$  where  $H = H_1 \otimes H_2$ . (a) a is factorized if and only if  $a^1$  and  $a^2$  are indecomposable. (b) We can arrange the nonzero eigenvalues  $\alpha_1, \alpha_2, \ldots, \alpha_n$  of  $a^1$  and the nonzero eigenvalues  $\beta_1, \beta_2, \ldots, \beta_n$  of  $a^2$  so that  $\alpha_i = \frac{n_1}{n_2}\beta_i$ ,  $i = 1, 2, \ldots, n$ . Hence, if  $n_1 = n_2$ , then the eigenvalues of  $a^1$  and  $a^2$  are identical.

*Proof.* The unit vector  $\psi \in H$  has a Schmidt decomposition  $\psi = \sum_{i=1}^{m} \lambda_i \psi_i \otimes \phi_i$ ,  $\lambda_i \geq 0$ ,  $\sum \lambda_i^2 = 1$ . We have that

$$\begin{aligned} a &= |\psi\rangle\langle\psi| = \left|\sum\lambda_i\psi_i\otimes\phi_i\right\rangle\left\langle\sum\lambda_j\psi_j\otimes\phi_j\right| = \sum_{i,j}\lambda_i\lambda_j|\psi_i\otimes\phi_i\rangle\langle\psi_j\otimes\phi_j\\ &= \sum_{i,j}\lambda_i\lambda_j|\psi_i\rangle\langle\psi_j|\otimes|\phi_i\rangle\langle\phi_j| \end{aligned}$$

and

Hence,

$$a^{1} = \frac{1}{n_{2}} \operatorname{tr}_{2}(a) = \frac{1}{n_{2}} \sum_{i,j} \lambda_{i} \lambda_{j} \operatorname{tr}_{2} \left( |\psi_{i}\rangle \langle \psi_{j}| \otimes |\phi_{i}\rangle \langle \phi_{j}| \right)$$
$$= \frac{1}{n_{2}} \sum_{i,j} \lambda_{i} \lambda_{j} \delta_{ij} |\psi_{i}\rangle \langle \psi_{j}| = \frac{1}{n_{2}} \sum_{i,j} \lambda_{i}^{2} P_{\psi_{i}}$$
(4.2)

and similarly

$$a^2 = \frac{1}{n_1} \sum \lambda_i^2 P_{\phi_i} \tag{4.3}$$

Now *a* is factorized if and only if  $\psi$  is factorized which is equivalent to m = 1and  $\psi = \psi_1 \otimes \phi_1$ . Applying (4.2) and (4.3) we conclude that *a* is factorized if and only if  $a^1 = \frac{1}{n_2} \lambda_1^2 P_{\psi_1}$  and  $a^2 = \frac{1}{n_1} \lambda_1^2 P_{\phi_1}$  in which case  $a^1$  and  $a^2$  are indecomposable. This completes the proof of (a). To prove (b), we see from (4.2), (4.3) that the eigenvalues of  $a^1, a^2$  are  $\alpha_i = \frac{1}{n_2} \lambda_i^2$  and  $\beta_i = \frac{1}{n_1} \lambda_i^2$ . It follows that  $\alpha_i = \frac{n_1}{n_2} \beta_i$ .

If  $A \in \mathcal{O}(H_1 \otimes H_2)$  we define the reduced observables  $A^1 \in \mathcal{O}(H_1)$ ,  $A^2 \in \mathcal{O}(H_2)$  by  $A^1 = \{A_x^1 : x \in \Omega_A\}$  and  $A^2 = \{A_x^2 : x \in \Omega_A\}$ . Note that  $A^1(A^2)$  is indeed an observable because

$$\sum_{x \in \Omega_A} A_x^1 = \sum_{x \in \Omega_A} \frac{1}{n_2} \operatorname{tr}_2(A_x) = \frac{1}{n_2} \operatorname{tr}_2\left(\sum_{x \in \Omega_A} A_x\right) = \frac{1}{n_2} \operatorname{tr}_2(1_1 \otimes 1_2) = 1_1$$

**Lemma 4.4.** If  $A \in \mathcal{O}(H_1 \otimes H_2)$  and  $\rho_1 \in \mathcal{S}(H_1)$ , then

$$\Phi_{\rho_1}^{A^1} = \Phi_{\rho_1 \otimes 1_2/n_2}^A$$

*Proof.* For  $X \subseteq \Omega_A$  we have that

$$\Phi_{\rho_1}^{A^1}(X) = \operatorname{tr}(\rho_1 A_x^1) = \operatorname{tr}\left[\rho_1 \frac{1}{n_2} \operatorname{tr}_2(A_X)\right] = \frac{1}{n_2} \operatorname{tr}[\rho_1 \operatorname{tr}_2(A_X)]$$
$$= \frac{1}{n_2} \operatorname{tr}[A_X(\rho_1 \otimes 1_2)] = \operatorname{tr}\left[\left(\rho_1 \otimes \frac{1}{n_2} 1_2\right) A_X\right] = \Phi_{\rho_1 \otimes 1_2/n_2}(X)$$

The result now follows.

In a similar way

$$\Phi_{\rho_2}^{A^2} = \Phi_{1_1/n_1 \otimes \rho_2}^A$$

For  $A \in \mathcal{O}(H_1)$  we define the A-random measure on  $\Omega_A$  by

$$\mu^{A}(X) = \frac{1}{n_{1}} \operatorname{tr} (A_{X}) = \operatorname{tr} \left(\frac{1}{n_{1}} A_{X}\right) = \Phi^{A}_{1_{1}/n_{1}}(X)$$

for all  $X \subseteq \Omega_A$ . Thus,  $\mu^A$  is the distribution of A in the random state  $1_1/n_1$ . If  $A_1 \in \mathcal{O}(H_1), A_2 \in \mathcal{O}(H_2)$ , we define the *composite observable* 

$$B_{(x,y)} = A_{1,x} \otimes A_{2,y} \in \mathcal{O}(H_1 \otimes H_2)$$

In this case,  $\Omega_B = \Omega_{A_1} \times \Omega_{A_2}$  and for  $Z \subseteq \Omega_B$  we have that

$$B_Z = \sum_{(x,y)\in Z} B_{(x,y)}$$

Hence,  $B_{X \times Y} = A_{1,X} \otimes A_{2,Y}$ .

**Lemma 4.5.**  $B^1_{X \times Y} = \mu^{A^2}(Y)A_{1,X}$  and  $B^2_{X \times Y} = \mu^{A_1}(X)A_{2,Y}$ .

*Proof.* For  $x \in \Omega_{A_1}$ ,  $y \in \Omega_{A_2}$  we obtain

$$B_{(x,y)}^{1} = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ B_{(x,y)} \right] = \frac{1}{n_{2}} \operatorname{tr} \left( A_{1,x} \otimes A_{2,y} \right) = \frac{1}{n_{2}} \operatorname{tr} \left( A_{2,y} \right) A_{1,x}$$

Hence,

$$B_{X \times Y}^{1} = \frac{1}{n_{2}} \operatorname{tr} (A_{2,Y}) A_{1,X} = \mu^{A_{2}}(Y) A_{1,X}$$

The second equation is similar.

A transition probability from  $\Omega_1$  to  $\Omega_2$  is a map  $\nu \colon \Omega_1 \times \Omega_2 \to [0,1]$ satisfying  $\sum_{y \in \Omega_2} \nu_{xy} = 1$  for all  $x \in \Omega_1$ . (The matrix  $[\nu_{xy}]$  is called a *stochastic* matrix.) Let  $A \in \mathcal{O}(H_1)$  with outcome-space  $\Omega_1$  and let  $\nu$  be a transition probability from  $\Omega_1$  to  $\Omega_2$ . Then  $(\nu \cdot A)_y = \sum_{x \in \Omega_1} \nu_{xy} A_x$  is an observable on  $H_1$  with outcome-space  $\Omega_2$  called a *post-processing* of A from  $\Omega_1$  to  $\Omega_2$ [9]. If we also have  $B \in \mathcal{O}(H_2)$  with outcome-space  $\Omega_3$  and  $\mu$  a transition probability from  $\Omega_3$  to  $\Omega_4$ , we can form the post-processing  $\mu \cdot B$ .

**Theorem 4.6.** (a)  $(\nu \bullet A) \otimes (\mu \bullet B) \in \mathcal{O}(H_1 \otimes H_2)$  with outcome-space  $\Omega_2 \times \Omega_4$  and is a post-processing  $\alpha \bullet (A \otimes B)$  from  $\Omega_1 \times \Omega_3$  to  $\Omega_2 \times \Omega_4$  where  $\alpha ((x, r), (y, s)) = \nu_{xy} \mu_{rs}$ . (b) If  $A \in \mathcal{O}(H_1 \otimes H_2)$ , then  $(\nu \bullet A)^1 = \nu \bullet A^1$  and  $(\nu \bullet A)^2 = \nu \bullet A^2$ .

*Proof.* (a) The map  $\alpha \colon \Omega_1 \times \Omega_3 \to \Omega_2 \times \Omega_4$  is a transition probability because  $\alpha_{((x,r),(y,s))} \ge 0$  and

$$\sum_{(y,s)\in\Omega_2\times\Omega_4}\alpha_{((x,r),(y,s))} = \sum_{y,s}\nu_{xy}\mu_{rs} = 1$$

Moreover,  $\nu \bullet A \otimes (\mu \bullet B) \in \mathcal{O}(H_1 \otimes H_2)$  with outcome-space  $\Omega_2 \times \Omega_4$  and we have that

$$[(\nu \cdot A) \otimes (\mu \cdot B)]_{(y,s)} = (\nu \cdot A)_y \otimes (\mu \cdot B)_s$$
$$= \left(\sum_{x \in \Omega_1} \nu_{xy} A_x\right) \otimes \left(\sum_{r \in \Omega_3} \mu_{rs} B_r\right)$$
$$= \sum_{x \in \Omega_1} \sum_{r \in \Omega_3} \nu_{xy} \mu_{rs} A_x \otimes B_r$$
$$= \sum_{x,r} \alpha_{((x,r),(y,s))} A_x \otimes B_r = [\alpha \cdot (A \otimes B)]_{(y,s)}$$

Hence,  $(\nu \bullet A) \otimes (\mu \bullet B) = \alpha \bullet (A \otimes B)$ . (b) This follows from

$$(\nu \bullet A)_{y}^{1} = \left(\sum_{x} \nu_{xy} A_{x}\right)^{1} = \frac{1}{n_{2}} \operatorname{tr}_{2} \left(\sum_{x} \nu_{xy} A_{x}\right) = \frac{1}{n_{2}} \sum_{x} \nu_{xy} \operatorname{tr}_{2}(A_{x})$$
$$= \sum_{x} \nu_{xy} A_{x}^{1} = (\nu \bullet A^{1})_{y}$$

That  $(\nu \bullet A)^2 = \nu \bullet A^2$  is similar.

We have seen in Theorem 3.2 that coexistence is equivalent to joint measurability. This is used in the next theorem [10].

**Theorem 4.7.** (a) If  $A_1, B_1 \in \mathcal{O}(H_1)$  coexist with joint observable  $C_2$ , then  $A_1 \otimes A_2$ ,  $B_1 \otimes B_2$  coexist with joint observable  $C = C_1 \otimes C_2$ . (b) If  $A, B \in \mathcal{O}(H_1 \otimes H_2)$  coexist with joint observable C, then  $A^1, B^1$  coexist with joint observable  $C^1$  and  $A^2, B^2$  coexist with joint observable  $C^2$ .

*Proof.* (a) We write  $C_{1,(x,y)}$  for  $(x,y) \in \Omega_{A_1} \times \Omega_{B_1}$  and  $C_{2,(x',y')}$  for  $(x',y') \in \Omega_{A_2} \times \Omega_{B_2}$ . Then

$$C_{(x,y,x',y')} = C_{1,(x,y)} \otimes C_{2,(x',y')}$$

and we have that

$$\sum_{(y,y')} C_{(x,y,x',y')} = \sum_{y} C_{1,(x,y)} \otimes \sum_{y'} C_{2,(x',y')} = A_{1,x} \otimes A_{2,x'} = (A_1 \otimes A_2)_{(x,x')}$$

Moreover,

$$\sum_{(x,x')} C_{(x,y,x',y')} = \sum_{x} C_{1,(x,y)} \otimes \sum_{x'} C_{2,(x',y')} = B_{1,y} \otimes B_{2,y'} = (B_1 \otimes B_2)_{(y,y')}$$

and the result follows. (b) For all  $(x, y) \in \Omega_A \times \Omega_B$  we obtain

$$A_x^1 = \left[\sum_y C_{(x,y)}\right]^1 = \frac{1}{n_2} \operatorname{tr}_2 \left[\sum_y C_{(x,y)}\right] = \sum_y \left[\frac{1}{n_2} \operatorname{tr} (C_{(x,y)})\right]$$
$$= \sum_y C_{(x,y)}^1$$

Similarly,  $B_y^1 = \sum_x C_{(x,y)}^1$  so  $A^1, B^1$  coexist with joint observable  $C^1$ . The result for  $A^2, B^2$  is similar.

For an instrument  $\mathcal{I} \in \text{In}(H_1 \otimes H_2)$  on the composite system, the *reduced* instrument on system 1 is defined by [6, 7]

$$\mathcal{I}_x^1(\rho_1) = \frac{1}{n_2} \operatorname{tr}_2 \left[ \mathcal{I}_x(\rho_1 \otimes \mathbb{1}_2) \right]$$

for all  $\rho_1 \in \mathcal{S}(H_1), x \in \Omega_{\mathcal{I}}$ . Similarly,

$$\mathcal{I}_x^2(\rho_1) = \frac{1}{n_1} \operatorname{tr}_1 \left[ \mathcal{I}_x(1_1 \otimes \rho_2) \right]$$

for all  $\rho_2 \in \mathcal{S}(H_2), x \in \Omega_{\mathcal{I}}$ .

**Theorem 4.8.**  $(\mathcal{I}^1)^{\wedge} = (\widehat{\mathcal{I}})^1$  and  $(\mathcal{I}^2)^{\wedge} = (\widehat{\mathcal{I}})^2$ .

*Proof.* For all  $\rho_1 \in \mathcal{S}(H_1)$  we have that

$$\operatorname{tr} \left[ \rho_1(\widehat{\mathcal{I}})_x^1 \right] = \frac{1}{n_2} \operatorname{tr} \left[ \rho_1 \operatorname{tr}_2(\widehat{\mathcal{I}})_x \right] = \frac{1}{n_2} \operatorname{tr} \left[ (\rho_1 \otimes 1_2) \widehat{\mathcal{I}}_x \right]$$
$$= \frac{1}{n_2} \operatorname{tr} \left[ \mathcal{I}_x(\rho_1 \otimes 1_2) \right] = \operatorname{tr} \left[ \mathcal{I}_x^1(\rho_1) \right] = \operatorname{tr} \left[ \rho_1(\mathcal{I}^1)_x^{\wedge} \right]$$

We conclude that  $(\mathcal{I}^1)^{\wedge} = (\widehat{\mathcal{I}})^1$  and similarly,  $(\mathcal{I}^2)^{\wedge} = (\widehat{\mathcal{I}})^2$ .

For  $\mathcal{I} \in \text{In}(H_1)$  we define the  $\mathcal{I}$ -random measure on  $\Omega_{\mathcal{I}}$  by

$$\mu^{\mathcal{I}}(X) = \frac{1}{n_1} \operatorname{tr} \left[ \mathcal{I}_X(1_1) \right]$$

For  $\mathcal{I}_1 \in \text{In}(H_1)$ ,  $\mathcal{I}_2 \in \text{In}(H_2)$  we define  $\mathcal{J} = \mathcal{I}_1 \otimes \mathcal{I}_2 \in \text{In}(H_1 \otimes H_2)$  with outcome-space  $\Omega_{\mathcal{I}_1} \times \Omega_{\mathcal{I}_2}$  by  $\mathcal{J}_{(x,y)} = \mathcal{I}_{1,x} \otimes \mathcal{I}_{2,y}$ . It is easy to check that  $\mathcal{J}$ is indeed an instrument.

**Theorem 4.9.** Let  $\mathcal{J} = \mathcal{I}_1 \otimes \mathcal{I}_2 \in \text{In}(H_1 \otimes H_2)$ . (a)  $\mathcal{J}^1_{(x,y)}(\rho_1) = \mu^{\mathcal{I}_2}(y)\mathcal{I}_{1,x}(\rho_1)$ for all  $\rho_1 \in \mathcal{S}(H_1)$  and  $\mathcal{J}^2_{(x,y)}(\rho_2) = \mu^{\mathcal{I}_1}(x)\mathcal{I}_{2,y}(\rho_2)$  for all  $\rho_2 \in \mathcal{S}(H_2)$ . (b)  $(\mathcal{I}_1 \otimes \mathcal{I}_2)^{\wedge} = \widehat{\mathcal{I}}_1 \otimes \widehat{\mathcal{I}}_2$ . *Proof.* (a) For all  $\rho_1 \in \mathcal{S}(H_1)$  we have that

$$\begin{aligned} \mathcal{J}_{(x,y)}^{1}(\rho_{1}) &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \mathcal{J}_{(x,y)}(\rho_{1} \otimes 1_{2}) \right] = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \mathcal{I}_{1,x} \otimes \mathcal{I}_{2,y}(\rho \otimes 1_{2}) \right] \\ &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \mathcal{I}_{1,x}(\rho_{1}) \otimes \mathcal{I}_{2,y}(1_{2}) \right] = \frac{1}{n_{2}} \operatorname{tr}_{2,y}(1_{2}) \left[ \mathcal{I}_{1,x}(\rho_{1}) \right] \\ &= \mu^{\mathcal{I}_{2}}(y) \mathcal{I}_{1,x}(\rho_{1}) \end{aligned}$$

Similarly,  $\mathcal{J}^2_{(x,y)}(\rho_2) = \mu^{\mathcal{I}_1}(x)\mathcal{I}_{2,y}(\rho_2)$  for all  $\rho_2 \in \mathcal{S}(H_2)$ . (b) For all  $\rho_1 \in \mathcal{S}(H_1), \rho_2 \in \mathcal{S}(H_2)$  we have that

$$\operatorname{tr} \left[ \rho_1 \otimes \rho_2 (\mathcal{I}_1 \otimes \mathcal{I}_2)^{\wedge}_{(x,y)} \right] = \operatorname{tr} \left[ \mathcal{I}_{1,x} \otimes \mathcal{I}_{2,y}(\rho_1 \otimes \rho_2) \right] = \operatorname{tr} \left[ \mathcal{I}_{1,x}(\rho_1) \otimes \mathcal{I}_{2,y}(\rho_2) \right]$$
$$= \operatorname{tr} \left[ \mathcal{I}_{1,x}(\rho_1) \right] \operatorname{tr} \left[ \mathcal{I}_{2,y}(\rho_2) \right] = \operatorname{tr} \left[ \rho_1 \widehat{\mathcal{I}}_{1,x} \right] \operatorname{tr} \left[ \rho_2 \widehat{\mathcal{I}}_{2,y} \right]$$
$$= \operatorname{tr} \left[ \rho_1 \otimes \rho_2 (\widehat{\mathcal{I}}_{1,x} \otimes \widehat{\mathcal{I}}_{2,y}) \right]$$

and the result follows.

A Kraus instrument is an instrument of the form  $\mathcal{I}_x(\rho) = S_x \rho S_x^*$  where  $\sum_x S_x^* S_x = 1, x \in \Omega_{\mathcal{I}}$ . The operators  $S_x$  are called *Kraus operators* for  $\mathcal{I}$ [11].

**Lemma 4.10.** Let  $\mathcal{I}_1 \in \text{In}(H_1)$ ,  $\mathcal{I}_2 \in \text{In}(H_2)$  be Kraus instruments with operators  $S_{1,x}$ ,  $S_{2,y}$ , respectively. (a)  $\mathcal{J} = \mathcal{I}_1 \otimes \mathcal{I}_2$  is a Kraus instrument with operators  $S_{1,x} \otimes S_{2,y}$ . (b)  $\mathcal{J}^1, \mathcal{J}^2$  are Kraus instruments with operators

$$T_{(x,y)} = \left[\frac{1}{n_2} \operatorname{tr} \left(S_{2,y} S_{2,y}^*\right)\right]^{1/2} S_{1,x}$$
$$R_{(x,y)} = \left[\frac{1}{n_1} \operatorname{tr} \left(S_{1,x} S_{1,x}^*\right)\right]^{1/2} S_{2,y}$$

*Proof.* (a) For all  $\rho_1 \in \mathcal{S}(H_1)$ ,  $\rho_2 \in \mathcal{S}(H_2)$  we have that

$$\begin{aligned} \mathcal{J}_{(x,y)}(\rho_1 \otimes \rho_2) &= (\mathcal{I}_{1,x} \times \mathcal{I}_{2,y})(\rho_1 \otimes \rho_2) = \mathcal{I}_{1,x}(\rho_1) \otimes \mathcal{I}_{2,y}(\rho_2) \\ &= S_{1,x}\rho_1 S_{1,x}^* \otimes S_{2,y}\rho_2 S_{2,y}^* \\ &= S_{1,x} \otimes S_{2,y}(\rho_1 \otimes \rho_2) S_{1,x}^* \otimes S_{2,y}^* \end{aligned}$$

and the result follows. (b) For  $\rho \in \mathcal{S}(H_1)$  we obtain

$$\mathcal{J}_{(x,y)}^{1}(\rho_{1}) = \frac{1}{n_{2}} \operatorname{tr} \left[ \mathcal{I}_{2,y}(1_{2}) \right] \mathcal{I}_{1,x}(\rho_{1}) = \frac{1}{n_{2}} \operatorname{tr} \left( S_{2,y} S_{2,y}^{*} \right) S_{1,x} \rho_{1} S_{1,x}^{*}$$

This can be considered to be a Kraus instrument with operators  $T_{(x,y)}$  given above. The result for  $\mathcal{J}^2$  is similar.

Notice that a Lüders instrument defined by  $\mathcal{L}_x^A(\rho_1) = A_x^{1/2} \rho_1 A_x^{1/2}$  for all  $\rho_1 \in \mathcal{S}(H_1)$  is a particular case of a Kraus instrument with operators  $A_x^{1/2}$  [13].

**Corollary 4.11.** Let  $A \in \mathcal{O}(H_1)$ ,  $B \in \mathcal{O}(H_2)$ . (a)  $\mathcal{L}_x^A \otimes \mathcal{L}_y^B = \mathcal{L}_{(x,y)}^{A \otimes B}$ . (b)  $(\mathcal{L}_x^A \otimes \mathcal{L}_y^B)^1 = \mathcal{L}_{(x,y)}^C$  where  $C = \frac{1}{n_2} \operatorname{tr} (B_y) A_x$  and  $(\mathcal{L}_x^A \otimes \mathcal{L}_y^B)^2 = \mathcal{L}_{(x,y)}^D$ where  $D = \frac{1}{n_2} \operatorname{tr} (A_x) B_y$ .

We say that a Kraus instrument  $\mathcal{I} \in \text{In}(H_1 \otimes H_2)$  with operators  $R_x$ is *factorized* if  $R_x = S_x \otimes T_x$  for all  $x \in \Omega_{\mathcal{I}}$ . We conjecture that if  $\mathcal{I} \in$ In  $(H_1 \otimes H_2)$  is Kraus, then  $\mathcal{I}^1$  and  $\mathcal{I}^2$  need not be Kraus. However, we do have the following result.

**Lemma 4.12.** If  $\mathcal{I} \in \text{In}(H_1 \otimes H_2)$  is Kraus and factorized, then  $\mathcal{I}^1$  and  $\mathcal{I}^2$  are Kraus.

*Proof.* If the operators  $R_x$  for  $\mathcal{I}$  satisfy  $R_x = S_x \otimes T_x$ , then for all  $\rho_1 \in \mathcal{S}(H_1)$  we have that

$$\begin{aligned} \mathcal{I}_{x}^{1}(\rho_{1}) &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \mathcal{I}_{x}(\rho_{1} \otimes 1_{2}) \right] = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ R_{x}(\rho_{1} \otimes 1_{2}) R_{x}^{*} \right] \\ &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ S_{x} \otimes T_{x}(\rho_{1} \otimes 1_{2}) S_{x}^{*} \otimes T_{x}^{*} \right] \\ &= \frac{1}{n_{2}} \operatorname{tr}_{2} (S_{x}\rho_{1}S_{x}^{*} \otimes T_{x}T_{x}^{*}) = \frac{1}{n_{2}} \operatorname{tr} (T_{x}T_{x}^{*}) S_{x}\rho_{1}S_{x}^{*} \end{aligned}$$

Hence,  $\mathcal{I}^1$  is Kraus with operators  $\left[\frac{1}{n_2} \operatorname{tr} (T_x T_x^*)\right]^{1/2} S_x$ . Similarly,  $\mathcal{I}^2$  is Kraus with operators  $\left[\frac{1}{n_1} \operatorname{tr} (S_x S_x^*)\right]^{1/2} T_x$ .

We do not know if the converse of Lemma 4.12 holds. We now consider trivial instruments (see Example 3).

**Lemma 4.13.** Let  $\mathcal{I}_1 \in \text{In}(H_1)$ ,  $\mathcal{I}_2 \in \text{In}(H_2)$  be trivial instruments with

$$\mathcal{I}_{1,x}(\rho_1) = \operatorname{tr}(\rho_1 A_x)\alpha, \quad \mathcal{I}_{2,y}(\rho_2) = \operatorname{tr}(\rho_2 B_y)\beta$$

(a)  $\mathcal{I}_1 \otimes \mathcal{I}_2 \in \text{In} (H_1 \otimes H_2)$  is trivial with observable  $A \otimes B$  and state  $\alpha \otimes \beta$ (b)  $(\mathcal{I}_1 \otimes \mathcal{I}_2)^1$ ,  $(\mathcal{I}_1 \otimes \mathcal{I}_2)^2$  are trivial with observables  $\mu^B(y)A_x$ ,  $\mu^A(x)B_y$  and states  $\alpha, \beta$ , respectively. *Proof.* (a) For all  $(x, y) \in \Omega_{\mathcal{I}_1} \times \Omega_{\mathcal{I}_2}$ ,  $\rho_1 \in \mathcal{S}(H_1)$ ,  $\rho_2 \in \mathcal{S}(H_2)$  we have that

$$\begin{aligned} (\mathcal{I}_1 \otimes \mathcal{I}_2)_{(x,y)}(\rho_1 \otimes \rho_2) &= \mathcal{I}_{1,x}(\rho_1) \otimes \mathcal{I}_{2,y}(\rho_2) = \operatorname{tr}(\rho_1 A_x) \alpha \otimes \operatorname{tr}(\rho_2 B_y) \beta \\ &= \operatorname{tr}(\rho_1 A_x) \operatorname{tr}(\rho_2 B_y) \alpha \otimes \beta = \operatorname{tr}(\rho_1 A_x \otimes \rho_2 B_y) \alpha \otimes \beta \\ &= \operatorname{tr}(\rho_1 \otimes \rho_2 A \otimes B_{(x,y)}) \alpha \otimes \beta \end{aligned}$$

The result now follows. (b) This follows from

$$\begin{aligned} (\mathcal{I}_1 \otimes \mathcal{I}_2)^1_{(x,y)}(\rho_1) &= \frac{1}{n_2} \operatorname{tr}_2 \left[ \mathcal{I}_{1,x} \otimes \mathcal{I}_{2,y}(\rho_1 \otimes 1_2) \right] = \frac{1}{n_2} \operatorname{tr}_2 \left[ \mathcal{I}_{1,x}(\rho_1) \otimes \mathcal{I}_{2,y}(1_2) \right] \\ &= \frac{1}{n_2} \operatorname{tr} \left[ \mathcal{I}_{2,y}(1_2) \right] \mathcal{I}_{1,x}(\rho_1) = \frac{1}{n_2} \operatorname{tr} \left[ \operatorname{tr} (1_2 B_y) \beta \right] \operatorname{tr} (\rho_1 A_x) \alpha \\ &= \frac{1}{n_2} \operatorname{tr} (B_y) \operatorname{tr} (\rho_1 A_x) \alpha = \operatorname{tr} \left[ \rho_1 \mu^B(y) A_x \right] \alpha \end{aligned}$$

and similarly

$$(\mathcal{I}_1 \otimes \mathcal{I}_2)^2_{(x,y)}(\rho_2) = \operatorname{tr}\left[\rho_2 \mu^A(x) B_y\right] eta$$

**Lemma 4.14.** Let  $\mathcal{I} \in \text{In}(H_1 \otimes H_2)$  be trivial with  $\mathcal{I}_x(\rho) = \text{tr}(\rho A_x)\alpha$ . (a)  $\mathcal{I}^1, \mathcal{I}^2$  are trivial with observables  $A_x^1, A_x^2$  and states  $\text{tr}_2(\alpha), \text{tr}_1(\alpha)$ , respectively. (b) Letting  $\mathcal{J} = \mathcal{I}^1 \otimes \mathcal{I}^2$  we have that  $\mathcal{J}$  is trivial with observable  $A^1 \otimes A^2$  and state  $\text{tr}_2(\alpha) \otimes \text{tr}_1(\alpha)$ . Moreover,  $\mathcal{J}_{(x,y)}^1 = \mathcal{I}_x^1$  and  $\mathcal{J}_{(x,y)}^2 = \mathcal{I}_y^2$  for all  $(x, y) \in \Omega_{\mathcal{J}}$ .

*Proof.* (a) For all  $\rho_1 \in \mathcal{S}(H_1)$  and  $x \in \Omega_{\mathcal{I}}$  we have that

$$\begin{aligned} \mathcal{I}_{x}^{1}(\rho_{1}) &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \mathcal{I}_{x}(\rho_{1} \otimes 1_{2}) \right] = \frac{1}{n_{2}} \operatorname{tr}_{2} \left\{ \operatorname{tr}_{2} \left[ (\rho_{1} \otimes 1_{2}) A_{x} \right] \alpha \right\} \\ &= \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ (\rho_{1} \otimes 1_{2}) A_{x} \right] \operatorname{tr}_{1}(\alpha) = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \operatorname{tr}_{2}(A_{x}) \rho_{1} \right] \operatorname{tr}_{2}(\alpha) \\ &= \operatorname{tr}_{2} \left[ \rho_{1} \frac{1}{n_{2}} \operatorname{tr}_{2}(A_{x}) \right] \operatorname{tr}_{2}(\alpha) = \operatorname{tr}_{2} \left( \rho_{1} A_{x}^{1} \right) \operatorname{tr}_{2}(\alpha) \end{aligned}$$

Similarly,  $\mathcal{I}_x^2(\rho_2) = \operatorname{tr}(\rho_2 A_x^2) \operatorname{tr}_1(\alpha)$  so the result follows. (b) This result follows from Lemma 4.13(b).

We now consider MMs for composite systems. A single probe MM on  $H = H_1 \otimes H_2$  has the form  $\mathcal{M} = (H, K, \eta, \nu, F)$  as defined before. As discussed earlier,  $\widehat{\mathcal{M}} \in \text{In}(H)$  is the instrument measured by  $\mathcal{M}$ . Then  $\widehat{\mathcal{M}}^1 \in \text{In}(H_1)$  and for  $\rho_1 \in \mathcal{S}(H_1)$  we obtain

$$\widehat{\mathcal{M}}_{x}^{1}(\rho_{1}) = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \widehat{\mathcal{M}}_{x}(\rho_{1} \otimes 1_{2}) \right]$$
$$= \frac{1}{n_{2}} \operatorname{tr}_{2} \left\{ \operatorname{tr}_{K} \left[ \nu(\rho_{1} \otimes 1_{2} \otimes \eta)(1_{1} \otimes 1_{2} \otimes F_{x}) \right] \right\}$$
(4.4)

We have a similar expression for  $\widehat{\mathcal{M}}^2 \in \operatorname{In}(H_2)$ .

Corresponding to  $\mathcal{M}$  we define the *reduced* MM  $\mathcal{M}_1 = (H_1, K, \eta, \nu_1, F)$ where  $\nu_1 \in \mathcal{S}(H_1 \otimes K)$  is given by

$$u_1(\rho_1 \otimes \eta) = \frac{1}{n_2} \operatorname{tr}_2 \left[ \nu(\rho_1 \otimes \mathbb{1}_2 \otimes \eta) \right]$$

We then have for  $\rho_1 \in \mathcal{S}(H_1)$  that

$$\widehat{\mathcal{M}}_{1,x}(\rho_1) = \operatorname{tr}_K \left[ \nu_1(\rho_1 \otimes \eta)(1_1 \otimes F_x) \right] = \frac{1}{n_2} \operatorname{tr}_K \left\{ \operatorname{tr}_2 \left[ \nu(\rho_1 \otimes 1_2 \otimes \eta) \right] (1_1 \otimes F_x) \right\}$$
(4.5)

Similarly, we define  $\mathcal{M}_2 = (H_2, K, \eta, \nu_2, F)$  and an analogous formula for  $\widehat{\mathcal{M}}_2$ . Notice that (4.4) and (4.5) are quite similar and they are essentially an interchange of the two partial traces. We now show that they coincide.

**Theorem 4.15.** (a) Let  $H_1, H_2, H_3$  be finite-dimensional Hilbert spaces and let  $A \in \mathcal{L}(H_1 \otimes H_2 \otimes H_3), B \in \mathcal{L}(H_3)$ . Then

$$\operatorname{tr}_{2}\left[\operatorname{tr}_{3}\left(A(1_{1}\otimes 1_{2}\otimes B)\right)\right] = \operatorname{tr}_{3}\left[\left(\operatorname{tr}_{2}(A)\right)(1_{1}\otimes B)\right]$$
(4.6)

(b)  $\widehat{\mathcal{M}}^1 = \widehat{\mathcal{M}}_1 \text{ and } \widehat{\mathcal{M}}^2 = \widehat{\mathcal{M}}_2.$ 

*Proof.* (a) First suppose that  $A = A_1 \otimes A_2 \otimes A_3$  is factorized. We then obtain

$$\begin{aligned} \operatorname{tr}_{2}\left[\operatorname{tr}_{3}\left(A(1_{1}\otimes 1_{2}\otimes B)\right)\right] &= \operatorname{tr}_{2}\left[\operatorname{tr}_{3}\left(A_{1}\otimes A_{2}\otimes A_{3}(1_{1}\otimes 1_{2}\otimes B)\right)\right] \\ &= \operatorname{tr}_{2}\left[\operatorname{tr}_{3}(A_{1}\otimes A_{2}\otimes A_{3}B)\right] \\ &= \operatorname{tr}_{2}\left[A_{1}\otimes A_{2}\operatorname{tr}\left(A_{3}B\right)\right] = \operatorname{tr}\left(A_{3}B\right)\operatorname{tr}_{2}(A_{1}\otimes A_{2}) \\ &= \operatorname{tr}\left(A_{3}B\right)\operatorname{tr}\left(A_{2}\right)A_{1} = \operatorname{tr}\left(A_{2}\right)\operatorname{tr}_{3}(A_{1}\otimes A_{3}B) \\ &= \operatorname{tr}_{3}\left[\operatorname{tr}\left(A_{2}\right)(A_{1}\otimes A_{3})(1_{1}\otimes B)\right] \\ &= \operatorname{tr}_{3}\left[\left(\operatorname{tr}_{2}(A_{1}\otimes A_{2}\otimes A_{3})\right)(1_{1}\otimes B)\right] \\ &= \operatorname{tr}_{3}\left[\left(\operatorname{tr}_{2}(A)\right)(1_{1}\otimes B)\right] \end{aligned}$$

Hence, (4.6) holds when A is factorized. Since any  $A \in \mathcal{L}(H_1 \otimes H_2 \otimes H_3)$  is a linear combination of factorized operators, (4.6) holds in general. (b) Letting  $A = \nu(\rho_1 \otimes \mathbb{1}_2 \otimes \eta)$ ,  $B = F_x$  and  $K = H_3$  in (4.6), we conclude that (4.4) and (4.5) coincide. Hence,  $\widehat{\mathcal{M}}^1 = \widehat{\mathcal{M}}_1$  and similarly,  $\widehat{\mathcal{M}}^2 = \widehat{\mathcal{M}}_2$ .

We have considered single probe composite MMs. We now briefly discuss general composite MMs. Let  $\mathcal{M}_i = (H_i, K_i, \eta_i, \nu_i, F_i), i = 1, 2$  be two MMs. Define the unitary swap operator [8]

$$U \colon H_1 \otimes H_2 \otimes K_1 \otimes K_2 \to H_1 \otimes K_1 \otimes H_2 \otimes K_2$$

by

$$U(\phi_1 \otimes \phi_2 \otimes \psi_1 \otimes \psi_2) = \phi_1 \otimes \psi_1 \otimes \phi_2 \otimes \psi_2$$

We now define the channel  $\nu_1 \otimes \nu_2 \in \mathcal{C}(H_1 \otimes H_2 \otimes K_1 \otimes K_2)$  by

$$\nu_1 \otimes \nu_2(\rho_1 \otimes \rho_2 \otimes \eta_1 \otimes \eta_2) = U^* \left[\nu_1(\rho_1 \otimes \eta_2) \otimes \nu_2(\rho_2 \otimes \eta_2)\right] U$$
(4.7)

The *composite* of  $\mathcal{M}_1$  and  $\mathcal{M}_2$  is declared to be

$$\mathcal{M} = \mathcal{M}_1 \otimes \mathcal{M}_2 = (H_1 \otimes H_2, K_1 \otimes K_2, \eta_1 \otimes \eta_2, \nu_1 \otimes \nu_2, F_1 \otimes F_2)$$

For  $\rho \in \mathcal{S}(H_1 \otimes H_2)$  we have that

$$\widehat{\mathcal{M}}_{(x,y)}(\rho) = \operatorname{tr}_{K_1 \otimes K_2} \left[ \nu_1 \otimes \nu_2(\rho \otimes \eta_1 \otimes \eta_2) (1_1 \otimes 1_2 \otimes F_{1,x} \otimes F_{2,y}) \right]$$
(4.8)

The next result shows that  $\mathcal{M}$  has desirable properties.

**Theorem 4.16.** (a) For  $\rho = \rho_1 \otimes \rho_2 \in \mathcal{S}(H_1 \otimes H_2)$  we have

$$\widehat{\mathcal{M}}_{(x,y)}(\rho) = \widehat{\mathcal{M}}_{1,x}(\rho_1) \otimes \widehat{\mathcal{M}}_{2,y}(\rho_2)$$

(b) Defining  $\widehat{\mathcal{M}}^1$  and  $\widehat{\mathcal{M}}^2$  in the usual way we obtain

$$\widehat{\mathcal{M}}_{(x,y)}^{1}(\rho_{1}) = \frac{1}{n_{2}} \operatorname{tr} \left[\widehat{\mathcal{M}}_{2,y}(1_{2})\right] \widehat{\mathcal{M}}_{1,x}(\rho_{1})$$

and

$$\widehat{\mathcal{M}}^2_{(x,y)}(\rho_2) = \frac{1}{n_1} \operatorname{tr} \left[\widehat{\mathcal{M}}_{1,x}(1_1)\right] \widehat{\mathcal{M}}_{2,y}(\rho_2)$$

for all  $\rho_1 \in \mathcal{S}(H_1), \ \rho_2 \in \mathcal{S}(H_2).$ 

*Proof.* (a) Applying (4.7) and (4.8) we obtain

$$\widehat{\mathcal{M}}_{(x,y)}(\rho)$$

$$= \operatorname{tr}_{K_1 \otimes K_2} \left[ U^* \nu_1(\rho_1 \otimes \eta_1) \otimes \nu_2(\rho_2 \times \eta_2) \ U(1_1 \otimes 1_2 \otimes F_{1,x} \otimes F_{2,y}) \right]$$
  
$$= \operatorname{tr}_{K_1 \otimes K_2} \left[ \nu_1(\rho_1 \otimes \eta_1) \otimes \nu_2(\rho_2 \otimes \eta_2) \ U(1_1 \otimes 1_2 \otimes F_{1,x} \otimes F_{2,y}) U^* \right]$$
  
$$= \operatorname{tr}_{K_1} \operatorname{tr}_{K_2} \left[ \nu_1(\rho_1 \otimes \eta_1) \otimes \nu_2(\rho_2 \otimes \eta_2) \ (1_1 \otimes F_{1,x} \otimes 1_2 \otimes F_{2,y}) \right]$$
  
$$= \operatorname{tr}_{K_1} \operatorname{tr}_{K_2} \left[ \nu_1(\rho_1 \otimes \eta_1)(1_1 \otimes F_{1,x}) \otimes \nu_2(\rho_2 \otimes \eta_2)(1_2 \otimes F_{2,y}) \right]$$
  
$$= \widehat{\mathcal{M}}_{1,x}(\rho_1) \otimes \widehat{\mathcal{M}}_{2,y}(\rho_2)$$

(b) For  $\rho_1 \in \mathcal{S}(H_1)$  we have that

$$\mathcal{M}^{1}_{(x,y)}(\rho_{1}) = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \widehat{\mathcal{M}}_{(x,y)}(\rho_{1} \otimes 1_{2}) \right] = \frac{1}{n_{2}} \operatorname{tr}_{2} \left[ \widehat{\mathcal{M}}_{1,x}(\rho_{1}) \otimes \widehat{\mathcal{M}}_{2,y}(1_{2}) \right]$$
$$= \frac{1}{n_{2}} \operatorname{tr} \left[ \widehat{\mathcal{M}}_{2,y}(1_{2}) \right] \widehat{\mathcal{M}}_{1,x}(\rho_{1})$$

The expression for  $\widehat{\mathcal{M}}^2$  is similar.
