Mean-Variance Analysis in Bayesian Optimization under Uncertainty

ABSTRACT

We consider active learning (AL) in an uncertain environment in which trade-off between multiple risk measures need to be considered. As an AL problem in such an uncertain environment, we study Mean-Variance Analysis in Bayesian Optimization (MVA-BO) setting. Mean-variance analysis was developed in the field of financial engineering and has been used to make decisions that take into account the trade-off between the average and variance of investment uncertainty. In this paper, we specifically focus on BO setting with an uncertain component and consider multi-task, multi-objective, and constrained optimization scenarios for the mean-variance trade-off of the uncertain component. When the target blackbox function is modeled by Gaussian Process (GP), we derive the bounds of the two risk measures and propose AL algorithm for each of the above three problems based on the risk measure bounds. We show the effectiveness of the proposed AL algorithms through theoretical analysis and numerical experiments.

Introduction

Decision making in an uncertain environment has been studied in various domains. For example, in financial engineering, the mean-variance analysis [1, 2, 3] has been introduced as a framework for making investment decisions, taking into account the trade-off between the return (mean) and the risk (variance) of the investment. In this paper we study active learning (AL) in an uncertain environment. In many practical AL problems, there are two types of parameters called *design parameters* and *environmental parameters*. For example, in a product design, while the design parameters are fully controllable, the environmental parameters vary depending on the environment in which the product is used. In this paper, we examine AL problems under such an uncertain environment, where the goal is to efficiently find the optimal design parameters by properly taking into account the uncertainty of the environmental parameters.

Concretely, let $f(\boldsymbol{x}, \boldsymbol{w})$ be a blackbox function indicating the performance of a product, where $\boldsymbol{x} \in \mathcal{X}$ is the set of controllable design parameters and $\boldsymbol{w} \in \Omega$ is the set of uncontrollable environmental parameters whose uncertainty is characterized by a probability distribution $p(\boldsymbol{w})$. We particularly focus on the AL problem where the mean and the variance of the environmental parameters,

$$\mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] = \int_{\Omega} f(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}, \tag{1a}$$




Figure 1: 2D synthetic example under a multi-task scenario. The horizontal and vertical axes represent the design and environmental parameters \boldsymbol{x} and \boldsymbol{w} , respectively. Blue and yellow dotted lines indicate the points where expected value $F_1(\boldsymbol{x})$ and negative standard deviation $F_2(\boldsymbol{x})$ of $f(\boldsymbol{x}, \boldsymbol{w})$ are maximum. Our goal is to identify the point on the red line that simultaneously maximize both of F_1 and F_2 .

$$\mathbb{V}_{\boldsymbol{w}}[f(\boldsymbol{x},\boldsymbol{w})] = \int_{\Omega} \left(f(\boldsymbol{x},\boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x},\boldsymbol{w})] \right)^2 p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}, \tag{1b}$$

respectively, are taken into account. Specifically, we work on these two uncertainty measures in three different scenarios: multi-task learning scenario, multi-objective optimization scenario, and constrained optimization scenario. In the first scenario, we study AL for optimizing a weighted sum of these two measures. In the second scenario, we discuss how to obtain the Pareto frontier of these two measures in an AL setting. In the third scenario, we consider optimizing one of the two measures under some constraint on the other measure. We refer to these problems and the proposed framework for solving them as *Mean-Variance Analysis in Bayesian Optimization (MVA-BO)*. Figure 1 shows an illustration of a multi-task learning scenario.

In this study, we employ a Gaussian process (GP) to model the uncertainty of the blackbox function $f(\boldsymbol{x}, \boldsymbol{w})$. In a conventional GP-based AL problem (without uncontrollable environmental parameters \boldsymbol{w}), the acquisition function (AF) is designed based on how the uncertainty of the blackbox function changes when an input point is selected and the blackbox function is evaluated at the input point. On the other hand, in MVA-BO, we need to know how the uncertainties of the mean function (1a) and the variance function (1b) change by evaluating the blackbox function at the selected input point. Note that we face the difficulty of not being able to directly evaluate the target functions

(1a) and (1b). It has been shown in a previous study [4] that, when $f(\boldsymbol{x}, \boldsymbol{w})$ follows a GP, the mean function (1a) also follows a GP. Unfortunately, however, the variance function (1b) does not follow a GP, indicating that we need to develop a new method to quantify how the uncertainty of the variance function changes by evaluating the blackbox function at the selected input point. In this study, we extend the GP-UCB algorithm [5] to realize MVA-BO in the above mentioned three scenarios by overcoming these technical difficulties. We demonstrate the effectiveness of the proposed MVA-BO framework through theoretical analyses and numerical experiments.

Related Work Various problem setups and methods have been studied for AL and Bayesian optimization (BO) problems when there are multiple target functions. One of such problem setup is multi-task BO [6]. In this problem setup, the AF is designed to select input points that commonly contribute to optimizing multiple target functions. Another popular problem setup is multi-objective BO [7, 8, 9]. The goal of a multi-objective optimization is to obtain so-called *Pareto-optimal* solutions. The AF in this problem setup is designed to efficiently identify solutions on the Pareto frontier. Another common problem setup is constrained BO [10, 11, 12]. The goal of this problem setup is to find the optimal solution to a constrained optimization problem in a situation where both the objective function and constraint function are blackbox functions that are costly to evaluate. The AF in this problem setup is designed to select input points that are useful not only for maximizing the objective function but also for identifying the feasible region. In this paper, we study these three scenarios as concrete examples of MVA-BO. Unlike conventional multi-task, multi-objective and constrained BOs, the main technical challenges of MVA-BO are that the two target functions (1a) and (1b) cannot be directly evaluated and that the latter does not follow a GP.

Various studies have been published on BO under various types of uncertainty. The most relevant one to our study is on *Bayesian quadrature optimization (BQO)* [13], the goal of which is to optimize the mean function (1a). When the blackbox function follows a GP, the mean function (1a) also follows a GP, suggesting that one can efficiently solve BQO problems by properly modifying the AFs in conventional BO. By replacing the integrand in (1a) with different uncertainty measures, one can consider various types of AL problems under uncertainty [14, 15]. Another line of research dealing with uncontrollable and uncertain factors in BO is known as *robust BO*. The goal of robust BO is to make robust decisions that appropriately take into account the uncertainty of the BO process and the GP model. For example, input uncertainty in BO has been studied, in which probabilistic noise is inevitably added to the input points when evaluating the target blackbox function. Although research on BO in an uncertain environment has steadily progressed over the past few years, to our knowledge, there are no AL nor BO studies that take into account the trade-offs between multiple uncertainty measures such as mean-variance analysis.

Decision making under uncertainty is being examined in the field of robust optimization [16, 17, 18], with especially applications to financial engineering in mind [19, 20, 21]. It has been pointed out that when making decisions under uncertainty, it is important to balance multiple uncertainty measures appropriately, as represented by the Nobel prizewinning mean-variance analysis in portfolio theory [1, 2, 3]. Various risk measures, such as Value at Risk (VaR), have been proposed in financial engineering, and these multiple risk measures are used in combination, depending on the purpose of the decision making. However, to our knowledge, there have been AL or BO studies that have appropriately taken into account multiple uncertainty measures.

2 Preliminaries

2.1 Problem Setup

Let $f: \mathcal{X} \times \Omega \to \mathbb{R}$ be a blackbox function which is expensive to evaluate, where $\mathcal{X} \subset \mathbb{R}^{d_1}$ and $\Omega \subset \mathbb{R}^{d_2}$ are a finite set ¹ and a compact convex set, respectively. In our setting, a variable $\boldsymbol{w} \in \Omega$ is probabilistically fluctuated by the given density function $p(\boldsymbol{w})^2$. At every step t, a user chooses the next observation point $\boldsymbol{x}_t \in \mathcal{X}$, whereas $\boldsymbol{w}_t \in \Omega$ will be given as a realization of the random variable, which follows the distribution $p(\boldsymbol{w})$. Next, the user gets the noisy observation $y_t = f(\boldsymbol{x}_t, \boldsymbol{w}_t) + \eta_t$, where η_t is independent Gaussian noise following $\mathcal{N}(0, \sigma^2)$.

Furthermore, as a regularity assumption, we assume that f is an element of reproducing kernel Hilbert space (RKHS) and has a bounded norm, which is also assumed in the standard BO literature [5]. Let k be a positive definite kernel over $(\mathcal{X} \times \Omega) \times (\mathcal{X} \times \Omega)$ and \mathcal{H}_k be an RKHS corresponding to k. In this paper, for some positive constant B, we assume $f \in \mathcal{H}_k$ with $\|f\|_{\mathcal{H}_k} \leq B$, where $\|\cdot\|_{\mathcal{H}_k}$ denotes the Hilbert norm defined on \mathcal{H}_k .

Models Our algorithm uses the GP method [22] to navigate the optimization process. First, we assume $\mathcal{GP}(0, k)$ as a prior of f, where $\mathcal{GP}(\mu, k)$ is a GP that is characterized by a mean function μ and a kernel function k. Given the

sequence of data $\{((\boldsymbol{x}_i, \boldsymbol{w}_i), y_i)\}_{i=1}^t$, the posterior distribution of $f(\boldsymbol{x}, \boldsymbol{w})$ is the Gaussian distribution that has mean $\mu_t(\boldsymbol{x}, \boldsymbol{w})$ and variance $\sigma_t^2(\boldsymbol{x}, \boldsymbol{w})$ defined as follows:

$$\mu_t(\boldsymbol{x}, \boldsymbol{w}) = \boldsymbol{k}_t(\boldsymbol{x}, \boldsymbol{w})^\top \left(\boldsymbol{K}_t + \sigma^2 \boldsymbol{I}_t \right)^{-1} \boldsymbol{y}_t,$$

$$\sigma_t^2(\boldsymbol{x}, \boldsymbol{w}) = k \left((\boldsymbol{x}, \boldsymbol{w}), (\boldsymbol{x}, \boldsymbol{w}) \right) - \boldsymbol{k}_t(\boldsymbol{x}, \boldsymbol{w})^\top \left(\boldsymbol{K}_t + \sigma^2 \boldsymbol{I}_t \right)^{-1} \boldsymbol{k}_t(\boldsymbol{x}, \boldsymbol{w}),$$

where $\boldsymbol{k}_t(\boldsymbol{x}, \boldsymbol{w}) = (k((\boldsymbol{x}, \boldsymbol{w}), (\boldsymbol{x}_1, \boldsymbol{w}_1)), \dots, k((\boldsymbol{x}, \boldsymbol{w}), (\boldsymbol{x}_t, \boldsymbol{w}_t)))^\top$, $\boldsymbol{y}_t = (y_1, \dots, y_t)$, \boldsymbol{I}_t is the identity matrix of size t, and \boldsymbol{K}_t is the $t \times t$ kernel matrix whose (i, j)th element is $k((\boldsymbol{x}_i, \boldsymbol{w}_i), (\boldsymbol{x}_j, \boldsymbol{w}_j))$.

We will make use of the following lemma, to construct the confidence bound of f by using the posterior mean μ_t and the variance σ_t^2 .

Lemma 2.1 (Theorem 3.11 in [23]). Fix $f \in \mathcal{H}_k$ with $||f||_{\mathcal{H}_k} \leq B$. Given $\delta \in (0,1)$, let define

$$\beta_t = \left(\sqrt{\ln \det(\boldsymbol{I}_t + \sigma^{-2}\boldsymbol{K}_t) + 2\ln(1/\delta)} + B\right)^2.$$

Then, the following holds with probability at least $1 - \delta$:

$$|f(\boldsymbol{x},\boldsymbol{w}) - \mu_{t-1}(\boldsymbol{x},\boldsymbol{w})| \le \beta_t^{1/2} \sigma_{t-1}(\boldsymbol{x},\boldsymbol{w}), \ \forall \boldsymbol{x} \in \mathcal{X}, \ \forall \boldsymbol{w} \in \Omega, \ \forall t \ge 1.$$
(2)

Based on the above lemma, the confidence bound $Q_t(\boldsymbol{x}, \boldsymbol{w}) \coloneqq [l_t(\boldsymbol{x}, \boldsymbol{w}), u_t(\boldsymbol{x}, \boldsymbol{w})]$ of $f(\boldsymbol{x}, \boldsymbol{w})$ can be computed by

$$l_t(\boldsymbol{x}, \boldsymbol{w}) = \mu_{t-1}(\boldsymbol{x}, \boldsymbol{w}) - \beta_t^{1/2} \sigma_{t-1}(\boldsymbol{x}, \boldsymbol{w}),$$

$$u_t(\boldsymbol{x}, \boldsymbol{w}) = \mu_{t-1}(\boldsymbol{x}, \boldsymbol{w}) + \beta_t^{1/2} \sigma_{t-1}(\boldsymbol{x}, \boldsymbol{w}).$$

2.2 Objective Functions and Optimization Goal

Here, we consider the expectation and variance of f(x, w) under the uncertainty of p(w) as follows:

$$\mathbb{E}_{\boldsymbol{w}}\left[f(\boldsymbol{x}, \boldsymbol{w})\right] = \int_{\Omega} f(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}, \tag{3}$$

$$\mathbb{V}_{\boldsymbol{w}}\left[f(\boldsymbol{x}, \boldsymbol{w})\right] = \int_{\Omega} \left\{f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}\left[f(\boldsymbol{x}, \boldsymbol{w})\right]\right\}^2 p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}.$$
(4)

Using these $\mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]$ and $\mathbb{V}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]$, we define the objective functions F_1 and F_2 as follows:

$$F_1(\boldsymbol{x}) = \mathbb{E}_{\boldsymbol{w}}\left[f(\boldsymbol{x}, \boldsymbol{w})\right], \ F_2(\boldsymbol{x}) = -\sqrt{\mathbb{V}_{\boldsymbol{w}}\left[f(\boldsymbol{x}, \boldsymbol{w})\right]}.$$
(5)

Our goal is to maximize F_1 and F_2 simultaneously with as few function evaluations as possible. To this end, we handle these objective functions in multi-task and multi-objective optimization frameworks.³

Multi-task Optimization Scenario First, we formulate the problem as a single-objective optimization problem whose objective function is defined as a weighted sum of F_1 and F_2 . Given a user-specified weight $\alpha \in [0, 1]$, let G be a new objective function defined as follows:

$$G(\boldsymbol{x}) = \alpha F_1(\boldsymbol{x}) + (1 - \alpha)F_2(\boldsymbol{x}).$$

In this formulation, our goal is to find $x^* \coloneqq \operatorname{argmax}_{x \in \mathcal{X}} G(x)$ efficiently. To rigorously determine the theoretical properties, we introduce the notion of an ϵ -accurate solution. Let \hat{x}_t be an estimated solution which is defined by the algorithm at step t. Given a fixed constant $\epsilon \ge 0$, we say that \hat{x}_t is ϵ -accurate if the following inequality holds:

$$G(\hat{\boldsymbol{x}}_t) \ge G(\boldsymbol{x}^*) - \epsilon$$

In section 4, for an arbitrarily small ϵ , we show that our algorithm can find the ϵ -accurate solution with high probability after finite step T.

Multi-objective Optimization Scenario In the multi-task scenario, we assume that the user can specify the weight α before the optimization; however this is sometimes unrealistic. We also consider the more general formulation based on the Pareto optimality criterion. Hereafter, we use the vector representation of the objective functions like $F(x) = (F_1(x), F_2(x))$. First, let \leq be a relational operator defined over $\mathcal{X} \times \mathcal{X}$ or $\mathbb{R}^2 \times \mathbb{R}^2$. Given $x, x' \in \mathcal{X}$, we write $x \leq x'$ or $F(x) \leq F(x')$ provided that $F_1(x) \leq F_1(x')$ and $F_2(x) \leq F_2(x')$ hold simultaneously. We say that x' dominates x if $x \leq x'$. Furthermore, we write $x \prec x'$ or $F(x) \prec F(x')$ provided that either $F_1(x) < F_1(x')$ or $F_2(x) < F_2(x')$ holds.

The goal of this scenario is to identify the following *Pareto set* Π efficiently:

$$\Pi = \{ \boldsymbol{x} \in \mathcal{X} \mid \forall \boldsymbol{x}' \in E_{\boldsymbol{x}}, \boldsymbol{F}(\boldsymbol{x}) \not\preceq \boldsymbol{F}(\boldsymbol{x}') \}, \text{ where } E_{\boldsymbol{x}} = \{ \boldsymbol{x}' \in \mathcal{X} \mid \boldsymbol{F}(\boldsymbol{x}) \neq \boldsymbol{F}(\boldsymbol{x}') \}.$$

Moreover, *Pareto front* Z is defined by

$$Z = \partial \{ \boldsymbol{y} \in \mathbb{R}^2 \mid \exists \boldsymbol{x} \in \mathcal{X}, \boldsymbol{y} \preceq \boldsymbol{F}(\boldsymbol{x}) \}.$$

Next, we introduce the notion of an ϵ -accurate Pareto set [8], which is an idea similar to the ϵ -accurate solution in the multi-task scenario. Given a non-negative vector $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)$, we define the relational operator $\leq_{\boldsymbol{\epsilon}}$, which is the relaxed version of \leq . For $\boldsymbol{x}, \boldsymbol{x}' \in \mathcal{X}$, we write $\boldsymbol{x} \leq_{\boldsymbol{\epsilon}} \boldsymbol{x}'$ or $\boldsymbol{F}(\boldsymbol{x}) \leq_{\boldsymbol{\epsilon}} \boldsymbol{F}(\boldsymbol{x}')$ if $F_1(\boldsymbol{x}) \leq F_1(\boldsymbol{x}') + \epsilon_1$ and $F_2(\boldsymbol{x}) \leq F_2(\boldsymbol{x}') + \epsilon_2$ hold simultaneously. Then, the $\boldsymbol{\epsilon}$ -Pareto front is defined as:

$$Z_{\boldsymbol{\epsilon}} = \{ \boldsymbol{y} \in \mathbb{R}^2 \mid \exists \boldsymbol{y}' \in Z, \ \boldsymbol{y} \preceq \boldsymbol{y}' \text{ and } \exists \boldsymbol{y}'' \in Z, \ \boldsymbol{y}'' \preceq_{\boldsymbol{\epsilon}} \boldsymbol{y} \}.$$

We say that estimated Pareto set $\hat{\Pi}_t$ of the algorithm is an ϵ -accurate Pareto set if the following two conditions are satisfied:

- 1. $\boldsymbol{F}(\hat{\Pi}_t) \subset Z_{\boldsymbol{\epsilon}}$, where $\boldsymbol{F}(\hat{\Pi}_t) \coloneqq \Big\{ \boldsymbol{F}(\boldsymbol{x}) \mid \boldsymbol{x} \in \hat{\Pi}_t \Big\}$.
- 2. For any $x \in \Pi$, there is at least one point $x' \in \hat{\Pi}_t$ such that $x \preceq_{\epsilon} x'$.

Intuitively, condition 1 guarantees that the estimated solutions are worse than the true Pareto front by at most ϵ . Condition 2 indicates that $\hat{\Pi}$ can cover all points in the true Pareto set Π .

We emphasize that although many studies about multi-task or multi-objective optimization based on a GP have been reported, their methods cannot be directly applied to our setting because the objective functions F_1 and F_2 are not observed directly.

3 Proposed Method

First, we explain the basic idea of our proposed algorithms. To maximize F_1 and F_2 efficiently, one simple way is to consider the predicted distributions of F_1 and F_2 , and apply existing methods (e.g. expected improvement, entropy search). However, it is difficult to handle the predicted distribution of F_2 although f is modeled by a GP. In this paper, we first derive the intervals in which F_1 and F_2 exist with high probability from the confidence bound of f, and construct the algorithm based on these derived intervals. Hereafter, with a slight abuse of notation, we refer to these derived intervals as the confidence bounds of F_1 and F_2 .

3.1 Confidence Bounds of Objective Functions

First, we consider the confidence bound $Q_t^{(F_1)}(\boldsymbol{x}) = [l_t^{(F_1)}(\boldsymbol{x}), u_t^{(F_1)}(\boldsymbol{x})]$ of $F_1(\boldsymbol{x})$. When (2) holds, the following inequity holds for any $\boldsymbol{x} \in \mathcal{X}, t \ge 1$:

$$\int_{\Omega} l_t(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \leq \int_{\Omega} f(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \leq \int_{\Omega} u_t(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}.$$

This implies that $F_1(\boldsymbol{x}) \in Q_t^{(F_1)}(\boldsymbol{x})$ for any $\boldsymbol{x} \in \mathcal{X}, t \ge 1$ with probability at least $1 - \delta$ for $l_t^{(F_1)}$ and $u_t^{(F_1)}$ defined as

$$l_t^{(F_1)}(\boldsymbol{x}) = \int_{\Omega} l_t(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{x}) \mathrm{d}\boldsymbol{w}, \ u_t^{(F_1)}(\boldsymbol{x}) = \int_{\Omega} u_t(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{x}) \mathrm{d}\boldsymbol{w}.$$

We construct the confidence bound $Q_t^{(F_2)}(\boldsymbol{x}) = [l_t^{(F_2)}(\boldsymbol{x}), u_t^{(F_2)}(\boldsymbol{x})]$ of $F_2(\boldsymbol{x})$ in a similar way. First, we consider the quantity $f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]$, which appears in the integrand of $\mathbb{V}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]$. Under condition (2), the following inequity holds:

$$\tilde{l}_t(\boldsymbol{x}, \boldsymbol{w}) \le f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \le \tilde{u}_t(\boldsymbol{x}, \boldsymbol{w}),$$
(6)

where $\tilde{l}_t(\boldsymbol{x}, \boldsymbol{w}) = l_t(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[u_t(\boldsymbol{x}, \boldsymbol{w})]$ and $\tilde{u}_t(\boldsymbol{x}, \boldsymbol{w}) = u_t(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[l_t(\boldsymbol{x}, \boldsymbol{w})]$. Next, the integrand of $\mathbb{V}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]$ can be evaluated based on (6) as follows:

$$\tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x}, \boldsymbol{w}) \leq \left\{ f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \right\}^2 \leq \tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x}, \boldsymbol{w}),$$

where

$$\begin{split} \tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x}, \boldsymbol{w}) &= \begin{cases} 0 & \text{if } \tilde{l}_t(\boldsymbol{x}, \boldsymbol{w}) \leq 0 \leq \tilde{u}_t(\boldsymbol{x}, \boldsymbol{w}), \\ \min\left\{\tilde{l}_t^2(\boldsymbol{x}, \boldsymbol{w}), \tilde{u}_t^2(\boldsymbol{x}, \boldsymbol{w})\right\} & \text{otherwise} \end{cases} \\ \tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x}, \boldsymbol{w}) &= \max\left\{\tilde{l}_t^2(\boldsymbol{x}, \boldsymbol{w}), \tilde{u}_t^2(\boldsymbol{x}, \boldsymbol{w})\right\}. \end{split}$$

Finally, from the monotonicity of square root, the confidence bound $Q_t^{(F_2)}(\boldsymbol{x}) = [l_t^{(F_2)}(\boldsymbol{x}), u_t^{(F_2)}(\boldsymbol{x})]$ of $F_2(\boldsymbol{x})$ is computed using the following equations for $l_t^{(F_2)}$ and $u_t^{(F_2)}$:

$$l_t^{(F_2)}(\boldsymbol{x}) = -\sqrt{\int_{\Omega} \tilde{u}_t^{(\text{sq})}(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{x}) \mathrm{d}\boldsymbol{w}}, \ u_t^{(F_2)}(\boldsymbol{x}) = -\sqrt{\int_{\Omega} \tilde{l}_t^{(\text{sq})}(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{x}) \mathrm{d}\boldsymbol{w}}.$$

3.2 Algorithms

Multi-task Scenario In the multi-task scenario, our algorithm chooses the next observation point \boldsymbol{x}_t based on the upper confidence bound (UCB) of the function G. From $Q_t^{(F_1)}(\boldsymbol{x})$ and $Q_t^{(F_2)}(\boldsymbol{x})$, the confidence bound $Q_t^{(G)}(\boldsymbol{x}) \coloneqq [l_t^{(G)}(\boldsymbol{x}), u_t^{(G)}(\boldsymbol{x})]$ of $G(\boldsymbol{x})$ can be constructed by defining

$$l_t^{(G)}(\boldsymbol{x}) = \alpha l_t^{(F_1)}(\boldsymbol{x}) + (1-\alpha) l_t^{(F_2)}(\boldsymbol{x}), \ u_t^{(G)}(\boldsymbol{x}) = \alpha u_t^{(F_1)}(\boldsymbol{x}) + (1-\alpha) u_t^{(F_2)}(\boldsymbol{x}).$$

At every step t, the next observation point \boldsymbol{x}_t of our algorithm is defined by $\boldsymbol{x}_t = \operatorname{argmax}_{\boldsymbol{x} \in \mathcal{X}} u_t^{(G)}(\boldsymbol{x})$. Hereafter, we call this strategy Multi-Task (MT)-MVA-BO. The pseudo-code of MT-MVA-BO is shown as Algorithm 1.

Multi-objective Scenario Next, we explain the proposed algorithm for finding the Pareto set efficiently. From the confidence bounds of F_1 and F_2 , we define $F_t^{(opt)}$ and $F_t^{(pes)}$ by $F_t^{(opt)}(\boldsymbol{x}) = \left(u_t^{(F_1)}(\boldsymbol{x}), u_t^{(F_2)}(\boldsymbol{x})\right)$ and $F_t^{(pes)}(\boldsymbol{x}) = \left(l_t^{(F_1)}(\boldsymbol{x}), l_t^{(F_2)}(\boldsymbol{x})\right)$, which respectively represent the optimistic and pessimistic predictions of the objective functions at step t. First, we define the estimated Pareto set $\hat{\Pi}_t$ at step t by

$$\hat{\Pi}_{t} = \left\{ \boldsymbol{x} \in \mathcal{X} \mid \forall \boldsymbol{x}' \in E_{t,\boldsymbol{x}}^{(\text{pes})}, \ \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}) \not\preceq \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}') \right\}, \text{ where } E_{t,\boldsymbol{x}}^{(\text{pes})} = \left\{ \boldsymbol{x}' \in \mathcal{X} \mid \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}) \neq \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}') \right\}.$$
(7)

For theoretical reasons, we define $\hat{\Pi}_t$ based on pessimistic predictions and the same idea is used in the existing GP-based optimization literatures [24, 8, 25, 26]. Furthermore, using $\hat{\Pi}_t$, the potential Pareto set M_t is defined by

$$M_t = \left\{ \boldsymbol{x} \in \mathcal{X} \setminus \hat{\Pi}_t \mid \forall \boldsymbol{x}' \in \hat{\Pi}_t, \ \boldsymbol{F}_t^{(\text{opt})}(\boldsymbol{x}) \not\preceq_{\boldsymbol{\epsilon}} \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}') \right\}$$

An intuitive interpretation of M_t is the set which excludes the points that are ϵ -dominated by other points with high probability. At every step t, our algorithm chooses \boldsymbol{x}_t based on the uncertainty defined by the confidence bounds of F_1 and F_2 . In this paper, we adopt the diameter $\lambda_t(\boldsymbol{x})$ of rectangle $\operatorname{Rect}_t(\boldsymbol{x}) = \left[l_t^{(F_1)}(\boldsymbol{x}), u_t^{(F_1)}(\boldsymbol{x})\right] \times \left[l_t^{(F_2)}(\boldsymbol{x}), u_t^{(F_2)}(\boldsymbol{x})\right]$ as the uncertainty of \boldsymbol{x} :

$$\lambda_t(\boldsymbol{x}) = \max_{\boldsymbol{y}, \boldsymbol{y}' \in \operatorname{Rect}_t(\boldsymbol{x})} \|\boldsymbol{y} - \boldsymbol{y}'\|_2.$$
(8)

Namely, the next observation point \boldsymbol{x}_t is defined by $\boldsymbol{x}_t = \operatorname{argmax}_{\boldsymbol{x} \in M_t \cup \hat{\Pi}_t} \lambda_t(\boldsymbol{x})$ at every step t.

Our proposed algorithm terminates when estimated Pareto set $\hat{\Pi}_t$ is guaranteed to be an ϵ -Pareto set with high probability. To this end, our algorithm checks the uncertainty set U_t that is defined by

$$U_t = \left\{ \boldsymbol{x} \in \hat{\Pi}_t \mid \exists \boldsymbol{x}' \in \hat{\Pi}_t \setminus \{\boldsymbol{x}\}, \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}) + \boldsymbol{\epsilon} \prec \boldsymbol{F}_t^{(\text{opt})}(\boldsymbol{x}') \right\}.$$

Intuitively, U_t is the set of points where it is not possible to decide whether it is an ϵ -Pareto solution based on the current confidence bounds. Our algorithm terminates at a step t where both $M_t = \emptyset$ and $U_t = \emptyset$ hold.

Hereafter, we call this algorithm Multi-Objective (MO)-MVA-BO. The pseudo-code of MO-MVA-BO is shown as Algorithm 2.

3.3 Extensions and Practical Considerations

In this section, we consider several extensions of the proposed method to deal with situations which arise in some practical applications, leaving the details for appendix C.

3.3.1 Unknown Distribution

Thus far, we have assumed that $p(\boldsymbol{w})$ is known; however, this assumption is sometimes unrealistic. Considering how to deal with the case where $p(\boldsymbol{w})$ is unknown, one simple way is to estimate $p(\boldsymbol{w})$ during the optimization process. For example, if we estimate $p(\boldsymbol{w})$ by using an empirical distribution, we can apply our algorithm by replacing $p(\boldsymbol{w})$ with the following $\tilde{p}_t(\boldsymbol{w})$ when computing the confidence bounds:

$$\tilde{p}_t(\boldsymbol{w}) = \frac{1}{t} \sum_{t'=1}^t \mathbb{1}[\boldsymbol{w}_{t'} = \boldsymbol{w}].$$

As a more advanced method, it may be possible to consider extension to the distributionally robust setting [26, 27]; however, we leave this as future work.

3.3.2 Extension to Noisy Input

One setting similar to that in this paper is the noisy input setting [14, 28]. In this setting, observation point x_t is fluctuated by noise $\xi \in \Delta$ which follows the known density $p(\xi)$ defined over Δ . At every step t, the user chooses x_t

and obtains observation y_t as $y_t = f(\boldsymbol{x}_t + \boldsymbol{\xi}) + \eta_t$, $\boldsymbol{\xi} \sim p(\boldsymbol{\xi})$. Our problem can be extended to the noisy input setting by defining F_1 and F_2 through expectation $\mathbb{E}_{\boldsymbol{\xi}}[f(\boldsymbol{x} + \boldsymbol{\xi})]$ and variance $\mathbb{V}_{\boldsymbol{\xi}}[f(\boldsymbol{x} + \boldsymbol{\xi})]$ defined as follows:

$$\mathbb{E}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})] = \int_{\Delta} f(\boldsymbol{x}+\boldsymbol{\xi})p(\boldsymbol{\xi})\mathrm{d}\boldsymbol{\xi},\tag{9}$$

$$\mathbb{V}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})] = \int_{\Delta} \{f(\boldsymbol{x}+\boldsymbol{\xi}) - \mathbb{E}_{\hat{\boldsymbol{\xi}}}[f(\boldsymbol{x}+\hat{\boldsymbol{\xi}})]\}^2 p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}.$$
 (10)

We can apply the same algorithms as those in section 3.2 by constructing the confidence bounds via a way similar to that in section 3.1.

3.3.3 Simulator-Based Experiment

Some applications can be allowed to control the variable \boldsymbol{w} in the optimization. For example, the case that the user run the optimization process by evaluating $f(\boldsymbol{x}, \boldsymbol{w})$ with the computer simulation. Such scenarios have often been considered in similar studies reported in the BO literature that assumed the existence of an uncontrollable variable \boldsymbol{w} [13, 26, 27]. Our method can be extended to such a scenario by choosing \boldsymbol{w}_t according to $\boldsymbol{w}_t = \operatorname{argmax}_{\boldsymbol{w}\in\Omega}\sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w})$ after the selection of \boldsymbol{x}_t .

4 Theoretical Results

In this section, we show the theoretical results of the proposed algorithms. The details of the proofs are in appendix A.

First, we introduce the maximum information gain [5] as a sample complexity parameter of a GP. Now, Let $A = \{a_1, \ldots, a_T\}$ be a finite subset of $\mathcal{X} \times \Omega$, and \mathbf{y}_A be a vector whose *i*th element is $y_{\mathbf{a}_i} = f(\mathbf{a}_i) + \varepsilon_{\mathbf{a}_i}$. Maximum information gain γ_T at step T is defined by

$$\gamma_T = \max_{A \subset \mathcal{X} \times \Omega; |A| = T} I(\boldsymbol{y}_A; f),$$

where $I(\boldsymbol{y}_A; f)$ denotes the mutual information between \boldsymbol{y}_A and f. Maximum information gain γ_T is often used in BO, and its analytical form of the upper bound is derived in commonly used kernels [5].

The following two theorems show the convergence properties of the proposed algorithms for the multi-task and multi-objective scenarios, respectively.

Theorem 4.1. Fix positive definite kernel k, and assume $f \in \mathcal{H}_k$ with $||f||_{\mathcal{H}_k} \leq B$. Let $\delta \in (0,1)$ and $\epsilon > 0$, and set β_t according to $\beta_t = \left(\sqrt{\operatorname{Indet}(\mathbf{I}_t + \sigma^{-2}\mathbf{K}_t) + 2\ln\frac{3}{\delta}} + B\right)^2$ at every step t. Furthermore, for any $t \geq 1$, define $\hat{\mathbf{x}}_t$ by $\hat{\mathbf{x}}_t = \operatorname{argmax}_{\mathbf{x}_{t'} \in \{\mathbf{x}_1, \dots, \mathbf{x}_t\}} l_{t'}^{(G)}(\mathbf{x}_{t'})$. When applying MT-MVA-BO under the above conditions, with probability at least $1 - \delta$, $\hat{\mathbf{x}}_T$ is an ϵ -accurate solution, where T is the smallest positive integer which satisfies the following inequity:

$$\alpha T^{-1} \beta_T^{1/2} \left(\sqrt{2TC_1 \gamma_T} + C_2 \right) + (1 - \alpha) T^{-1} \sqrt{2T \tilde{B} \beta_T^{1/2} \left(\sqrt{8TC_1 \gamma_T} + 2C_2 \right)} + 5T \beta_T \left(C_1 \gamma_T + 2C_2 \right) \le \epsilon.$$
(11)

Here, $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|$ and $C_1 = \frac{16}{\log(1+\sigma^{-2})}, C_2 = 16\log\frac{18}{\delta}.$

Theorem 4.2. Fix positive definite kernel k, and assume $f \in \mathcal{H}_k$ with $||f||_{\mathcal{H}_k} \leq B$. Let $\delta \in (0,1)$ and $\epsilon > 0$, and set β_t according to $\beta_t = \left(\sqrt{\ln \det(\mathbf{I}_t + \sigma^{-2}\mathbf{K}_t) + 2\ln\frac{3}{\delta}} + B\right)^2$ at every step t. When applying MO-MVA-BO under the above conditions, the following 1. and 2. hold with probability at least $1 - \delta$:

1. The algorithm terminates at most step T where T is the smallest positive integer that satisfies the following inequity:

$$T^{-1}\beta_T^{1/2} \left(\sqrt{2TC_1\gamma_T} + C_2 \right) + T^{-1} \sqrt{2T\tilde{B}\beta_T^{1/2} \left(\sqrt{8TC_1\gamma_T} + 2C_2 \right)} + 5T\beta_T \left(C_1\gamma_T + 2C_2 \right) \le \min\{\epsilon_1, \epsilon_2\}.$$
(12)
Here, $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|, C_1 = \frac{16}{\log(1 + \sigma^{-2})}, C_2 = 16\log\frac{18}{\delta}.$

2. When the algorithm terminates, estimated Pareto set $\hat{\Pi}_t$ is an ϵ -accurate Pareto set.

The first term $\beta_T^{1/2} \left(\sqrt{TC_1\gamma_T} + C_2 \right)$ of the left hand side in (11) and (12) also appears in the theoretical result of the existing algorithm, which only considers the expectation F_1 (e.g. Theorem 2 in [26]). The second term $\sqrt{2T\tilde{B}\beta_T^{1/2} \left(\sqrt{8TC_1\gamma_T} + 2C_2 \right) + 5T\beta_T (C_1\gamma_T + 2C_2)}$ is specific to our problem. This term depends on the complexity parameter \tilde{B} , which quantifies the variation of function $f(\boldsymbol{x}, \boldsymbol{w})$ around its expectation.

5 Numerical Experiments

In this section, we show the performance of the proposed methods through numerical experiments. As the baseline methods in both the multi-task and multi-objective scenarios, we adopted random sampling (RS) and uncertainty sampling (US). RS choose \boldsymbol{x}_t from \mathcal{X} uniformly at random, and US choose \boldsymbol{x}_t such that \boldsymbol{x}_t achieve the largest average posterior variance $\boldsymbol{x}_t = \operatorname{argmax}_{\boldsymbol{x} \in \mathcal{X}} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w}$. To measure the performance, in the multi-task scenario, we computed the regret, $G(\boldsymbol{x}^*) - G(\hat{\boldsymbol{x}}_t)$, at every step t, where \boldsymbol{x}_t is the estimated solution defined by the algorithms. We defined $\hat{\boldsymbol{x}}_t$ as $\hat{\boldsymbol{x}}_t = \operatorname{argmax}_{t'=1,\dots,t} l_t^{(G)}(\boldsymbol{x}_{t'})$ in RS, US, and proposed method (MT-MVA-BO). Furthermore, we set $\alpha = 0.5$. Also, in the multi-objective scenario, we computed the gap of hyper-volume [7], HV – HV_t to measure the performance, where HV and HV_t denote the hyper volumes computed based on the true Pareto set II and the estimated Pareto set $\hat{\Pi}_t$, respectively. The hyper volume gap measures how close the estimated Pareto front is to the true Pareto front. We defined $\hat{\Pi}_t$ by (7) in RS, US and the proposed method (MO-MVA-BO). Furthermore, in the multi-task scenario, to show the effect of difference of objective functions, we also adopt the two methods BQOUCB [26, 27] and BO-VO. BQOUCB is the existing method which aims to maximize F_1 , and BO-VO is the variant of our method which corresponds to the case $\alpha = 0$. These methods choose \boldsymbol{x}_t as the maximizing point of $u_t^{(F_1)}(\boldsymbol{x})$ and $u_t^{(F_2)}(\boldsymbol{x})$ respectively. In addition, estimated solution $\hat{\boldsymbol{x}}_t$ is defined by $\hat{\boldsymbol{x}}_t = \operatorname{argmax}_{t'=1,\dots,t} l_t^{(F_1)}(\boldsymbol{x}_{t'})$ and $\hat{\boldsymbol{x}}_t = \operatorname{argmax}_{t'=1,\dots,t} l_t^{(F_2)}(\boldsymbol{x}_{t'})$. Respectively and ADA-BO-VO. ADA-BQOUCB and a BQOUCB and BO-VO, but the estimated solutions are

5.1 Artificial Data Experiments

In this subsection, we show the results of the artificial-data experiments.

GP Test Functions We experimented with the true oracle functions f that are generated from the 2D GP prior. First, we divided $[-1,1]^2$ into 25 uniformly spaced grid points in each dimension and generated the sample path from the GP prior. Next, we created the GP model with these grid points and set the true oracle function as its GP posterior mean. In this experiment, we created 50 sample paths from different seeds, and conducted 10 experiments for each function. Thus, we report the average performance of a total of 500 experiments. To create a GP sample path, we use the Gaussian kernel $k((\boldsymbol{x}, \boldsymbol{w}), (\boldsymbol{x}', \boldsymbol{w}')) = \sigma_{\text{ker}}^2 \exp(\frac{\|\boldsymbol{x}-\boldsymbol{x}'\|_2^2 + \|\boldsymbol{w}-\boldsymbol{w}'\|_2^2}{2l^2})$ with $\sigma_{\text{ker}} = 1, l = 0.25$, as well as to construct the confidence bound in the algorithms. Furthermore, we set noise variance as $\sigma^2 = 10^{-4}$. In addition, we divided [-1,1] into 100 grid points uniformly, and set \mathcal{X} and Ω as these grid points. Moreover, we define p(w) by $p(w) = \sum_{w \in \Omega} \phi(w)/Z, Z = \sum_{w \in \Omega} \phi(w)$ where ϕ is the density function of the standard normal distribution.

Benchmark Functions of Optimization We also experimented with the Bird function (2D) and Rosenbrock function (3D), which are often used as the benchmark function in the field of the optimization. First, we scaled the input domain to [-1, 1] divided into 100 grid points in each dimension. In Bird function, we set \mathcal{X} and Ω as the grid points of the first and the second dimensions, respectively. In the Rosenbrock function, we set Ω as the grid points of the third dimension and the remaining points as \mathcal{X} . Furthermore, we set p(w) as in the same way as the experiment of the CD to the third dimension $|\nabla f(x_i - \mathbf{x}'_i)|^2 = |\nabla f(x_i - \mathbf{x}'_i)|^2$.

GP test functions. We use ARD Gaussian kernel $k((\boldsymbol{x}, \boldsymbol{w}), (\boldsymbol{x}', \boldsymbol{w}')) = \sigma_{\text{ker}}^2 \exp\left\{\sum_{i=1}^{d_1} \frac{(\boldsymbol{x}_i - \boldsymbol{x}'_i)^2}{2l_i^{(x)2}} + \sum_{j=1}^{d_2} \frac{(\boldsymbol{w}_j - \boldsymbol{w}'_j)^2}{2l_j^{(w)2}}\right\}$, and tune these hyperparameters by maximizing the marginal likelihood at every 10 step in the algorithms. Furthermore, we set the noise variance as $\sigma^2 = 10^{-4}$ and report the average performance of 100 simulations with different seeds.




Figure 2: Average performances in artificial data experiments. The error bars represent $2 \times [\text{standard error}]$. The top and bottom figures show the results of the multi-task ($\alpha = 0.5$) and multi-objective scenarios respectively.

Figure 2 shows the results of the artificial data experiments. We confirmed that the proposed methods achieve better performances than the other methods. In the experiments of the multi-task scenario, we also confirmed that the regrets of BQOUCB, BO-VO, ADA-BQOUCB, and ADA-BO-VO stop decreasing at an early stage. Note that these are reasonable results because objective functions of these methods are inconsistent with our settings.

5.2 Real-data Experiment




Figure 3: The results of experiments in Newsvendor problem. The left and right figures present the results of the multi-task ($\alpha = 0.5$) and multi-objective scenarios, respectively.

We applied the proposed methods to Newsvendor problem under dynamic consumer substitution [29], whose goal is to optimize the initial inventory levels under uncertainty of customer behaviors. The parameter \boldsymbol{x} and \boldsymbol{w} respectively correspond to the initial inventory level of products and the uncertain purchasing behaviors of customers, which follow mutually independent Gamma distributions. The goal of this problem is to find the \boldsymbol{x} which optimizes the profit $f(\boldsymbol{x}, \boldsymbol{w})$ under the uncertainty of \boldsymbol{w} . For this problem, we conducted the experiments in the simulator-based setting described in section 3.3.3 because profit $f(\boldsymbol{x}, \boldsymbol{w})$ can be evaluated based on a computer simulation. Figure 3 shows the average performances of 100 simulations with different seeds.

6 Conclusion

We introduced the novel Bayesian optimization framework: MVA-BO, which simultaneously considers two objective functions: expectation and variance under an uncertainty environment. In this framework, we considered the three scenarios; multi-task, multi-objective and constraint optimization scenarios, which often appear in real-world applications. We studied the rigorous convergence properties of our MVA-BO algorithms and demonstrated the effectiveness of them through both artificial and real-data experiments.

A Proofs

A.1 Proof of Theorem 4.1

From the definition of β_t and Lemma 2.1, the following holds with probability at least $1 - \delta/3$:

$$\forall \boldsymbol{x} \in \mathcal{X}, \ \forall \boldsymbol{w} \in \Omega, \ \forall t \ge 1, \ |f(\boldsymbol{x}, \boldsymbol{w}) - \mu_{t-1}(\boldsymbol{x}, \boldsymbol{w})| \le \beta_t^{1/2} \sigma_{t-1}(\boldsymbol{x}, \boldsymbol{w}).$$
(13)

Moreover, we give the following lemma about the confidence bound $Q_t^{(G)}(\boldsymbol{x}_t)$:

Lemma A.1. Assume that (13) holds. Then, for any $T \ge 1$, it holds that

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 2\alpha \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w} + (1-\alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w} + 20T \beta_T \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w}},$$

where $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\boldsymbol{\mathcal{X}} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|.$

Proof. From the definition of $u_t^{(G)}$ and $l_t^{(G)},$ we have

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} = \alpha \sum_{t=1}^{T} \left\{ u_t^{(F_1)}(\boldsymbol{x}_t) - l_t^{(F_1)}(\boldsymbol{x}_t) \right\} + (1-\alpha) \sum_{t=1}^{T} \left\{ u_t^{(F_2)}(\boldsymbol{x}_t) - l_t^{(F_2)}(\boldsymbol{x}_t) \right\}.$$
(14)

Similarly, from the definition of $u_t^{(F_1)}$ and $l_t^{(F_1)}$, we get the following inequality:

$$\sum_{t=1}^{T} \left\{ u_t^{(F_1)}(\boldsymbol{x}_t) - l_t^{(F_1)}(\boldsymbol{x}_t) \right\} = \sum_{t=1}^{T} \int_{\Omega} \left\{ u_t(\boldsymbol{x}_t, \boldsymbol{w}) - l_t(\boldsymbol{x}_t, \boldsymbol{w}) \right\} p(\boldsymbol{w}) d\boldsymbol{w}$$
$$= 2 \sum_{t=1}^{T} \beta_t^{1/2} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w}$$
$$\leq 2 \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w}.$$
(15)

Here, the last inequality is given by monotonicity of β_t . In addition, noting that the definition of $u_t^{(F_2)}$ and $l_t^{(F_2)}$ we obtain

$$u_t^{(F_2)}(\boldsymbol{x}_t) - l_t^{(F_2)}(\boldsymbol{x}_t) = \sqrt{\int_{\Omega} \tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} - \sqrt{\int_{\Omega} \tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}}$$
$$\leq \sqrt{\int_{\Omega} \left\{ \tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) - \tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) \right\} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}}, \tag{16}$$

where the last inequality is obtained by using the fact that $\sqrt{a} - \sqrt{b} \leq \sqrt{a-b}$ for any $a \geq b \geq 0$. Furthermore, we have

$$\tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) - \tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) = \max\left\{\tilde{l}_t^2(\boldsymbol{x}_t, \boldsymbol{w}), \tilde{u}_t^2(\boldsymbol{x}_t, \boldsymbol{w})\right\} - \min\left\{\tilde{l}_t^2(\boldsymbol{x}_t, \boldsymbol{w}), \tilde{u}_t^2(\boldsymbol{x}_t, \boldsymbol{w})\right\} + \mathrm{STR}_{0,t}^2(\boldsymbol{x}_t, \boldsymbol{w}), \quad (17)$$

where $\operatorname{STR}_{0,t}(\boldsymbol{x}_t, \boldsymbol{w}) = \max\left\{0, \min\left(\tilde{u}_t(\boldsymbol{x}_t, \boldsymbol{w}), -\tilde{l}_t(\boldsymbol{x}_t, \boldsymbol{w})\right)\right\}$. Moreover, we define $\tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w})$ and $\tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w})$ as

$$egin{aligned} & ilde{\mu}_{t-1}(oldsymbol{x},oldsymbol{w}) = \mu_{t-1}(oldsymbol{x},oldsymbol{w}) - \mathbb{E}_{oldsymbol{w}}[\mu_{t-1}(oldsymbol{x},oldsymbol{w})], \ & ilde{\sigma}_{t-1}(oldsymbol{x},oldsymbol{w}) = \sigma_{t-1}(oldsymbol{x},oldsymbol{w}) + \mathbb{E}_{oldsymbol{w}}[\sigma_{t-1}(oldsymbol{x},oldsymbol{w})]. \end{aligned}$$

Then, $\tilde{l}_t(\boldsymbol{x}, \boldsymbol{w})$ and $\tilde{u}_t(\boldsymbol{x}, \boldsymbol{w})$ can be expressed as follows:

$$\begin{split} \tilde{l}_t(\boldsymbol{x}, \boldsymbol{w}) &= \tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w}) - \beta_t^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w}), \\ \tilde{u}_t(\boldsymbol{x}, \boldsymbol{w}) &= \tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w}) + \beta_t^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w}). \end{split}$$

Here, if $\tilde{l}_t^2(\boldsymbol{x}_t, \boldsymbol{w}) \leq \tilde{u}_t^2(\boldsymbol{x}_t, \boldsymbol{w})$, then we have $\tilde{\mu}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) \geq 0$ and

$$\max\left\{\tilde{l}_{t}^{2}(\boldsymbol{x}_{t},\boldsymbol{w}), \tilde{u}_{t}^{2}(\boldsymbol{x}_{t},\boldsymbol{w})\right\} - \min\left\{\tilde{l}_{t}^{2}(\boldsymbol{x}_{t},\boldsymbol{w}), \tilde{u}_{t}^{2}(\boldsymbol{x}_{t},\boldsymbol{w})\right\} \\ = \left\{\tilde{\mu}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w}) + \beta_{t}^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})\right\}^{2} - \left\{\tilde{\mu}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w}) - \beta_{t}^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})\right\}^{2} \\ = 4\beta_{t}^{1/2}\tilde{\mu}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w}) \\ = 4\beta_{t}^{1/2}|\tilde{\mu}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})|\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w}).$$

On the other hand, if $\tilde{l}_t^2(\boldsymbol{x}_t, \boldsymbol{w}) > \tilde{u}_t^2(\boldsymbol{x}_t, \boldsymbol{w})$, then we get $\tilde{\mu}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) < 0$ and

$$\max \left\{ \tilde{l}_{t}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}), \tilde{u}_{t}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) \right\} - \min \left\{ \tilde{l}_{t}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}), \tilde{u}_{t}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) \right\}$$

$$= \left\{ \tilde{\mu}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) - \beta_{t}^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) \right\}^{2} - \left\{ \tilde{\mu}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) + \beta_{t}^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) \right\}^{2}$$

$$= -4\beta_{t}^{1/2} \tilde{\mu}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) \tilde{\sigma}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w})$$

$$= 4\beta_{t}^{1/2} |\tilde{\mu}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w})| \tilde{\sigma}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}).$$

Therefore, in all cases the following equality holds:

$$\max\left\{\tilde{l}_t^2(\boldsymbol{x}_t,\boldsymbol{w}),\tilde{u}_t^2(\boldsymbol{x}_t,\boldsymbol{w})\right\} - \min\left\{\tilde{l}_t^2(\boldsymbol{x}_t,\boldsymbol{w}),\tilde{u}_t^2(\boldsymbol{x}_t,\boldsymbol{w})\right\} = 4\beta_t^{1/2}|\tilde{\mu}_{t-1}(\boldsymbol{x}_t,\boldsymbol{w})|\tilde{\sigma}_{t-1}(\boldsymbol{x}_t,\boldsymbol{w}).$$

Next, since (13) holds, we get $f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}_t, \boldsymbol{w})] \in [\tilde{l}_t(\boldsymbol{x}, \boldsymbol{w}), \tilde{u}_t(\boldsymbol{x}, \boldsymbol{w})]$. This implies that

$$|f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}_t, \boldsymbol{w})] - \tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w})| \le \beta_t^{1/2} \tilde{\sigma}(\boldsymbol{x}, \boldsymbol{w}).$$

$$\begin{aligned} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}_{t}, \boldsymbol{w})] - \tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w})| &\leq \beta_{t}^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w}) \\ \Rightarrow |\tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w})| &\leq |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}_{t}, \boldsymbol{w})]| + \beta_{t}^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w}) \\ \Rightarrow |\tilde{\mu}_{t-1}(\boldsymbol{x}, \boldsymbol{w})| &\leq \tilde{B} + \beta_{t}^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}, \boldsymbol{w}). \end{aligned}$$

Thus, the following inequality holds:

$$\leq 4\beta_{t}^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})\left\{\tilde{B}+\beta_{t}^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})\right\}$$

$$= 4\tilde{B}\beta_{t}^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_{t},\boldsymbol{w})+4\beta_{t}\tilde{\sigma}_{t-1}^{2}(\boldsymbol{x}_{t},\boldsymbol{w}).$$
(18)

Moreover, $STR_{0,t}(\boldsymbol{x}_t, \boldsymbol{w})$ can be bounded as

$$\operatorname{STR}_{0,t}(\boldsymbol{x}_t, \boldsymbol{w}) \leq \frac{\tilde{u}_t(\boldsymbol{x}_t, \boldsymbol{w}) - \tilde{l}_t(\boldsymbol{x}_t, \boldsymbol{w})}{2}$$
$$= \beta_t^{1/2} \tilde{\sigma}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}).$$
(19)

Hence, from (17), (18) and (19), we obtain

$$u_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) - l_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) \le 4\tilde{B}\beta_t^{1/2}\tilde{\sigma}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) + 5\beta_t\tilde{\sigma}_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w})$$

and

$$\int_{\Omega} \left\{ u_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) - l_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) \right\} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}$$
$$\leq 4\tilde{B}\beta_t^{1/2} \int_{\Omega} \tilde{\sigma}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 5\beta_t \int_{\Omega} \tilde{\sigma}_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}.$$

In addition, from the definition of $\tilde{\sigma}_{t-1}(\boldsymbol{x}_t, \boldsymbol{w})$, the following holds:

$$\begin{split} \int_{\Omega} \tilde{\sigma}_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} &= \mathbb{E}_{\boldsymbol{w}}[\sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w})] + \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \\ &= 2 \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}, \\ \int_{\Omega} \tilde{\sigma}_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} &= \int_{\Omega} \sigma_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 2\mathbb{E}_{\boldsymbol{w}}[\sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w})] \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + \{\mathbb{E}_{\boldsymbol{w}}[\sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w})]\}^{2} \\ &= \int_{\Omega} \sigma_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 3 \left\{ \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \right\}^{2} \\ &\leq 4 \int_{\Omega} \sigma_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}. \end{split}$$

Here, the last inequality is obtained by using Jensen's inequality and convexity of $g(x) = x^2$. Therefore, we have

$$\int_{\Omega} \left\{ u_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) - l_t^{(\mathrm{sq})}(\boldsymbol{x}_t, \boldsymbol{w}) \right\} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}$$

$$\leq 8\tilde{B} \beta_t^{1/2} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 20\beta_t \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}.$$
(20)

Thus, by using (20) and Schwartz's inequality for (16), we get

$$\sum_{t=1}^{T} \left\{ u_t^{(F_2)}(\boldsymbol{x}_t) - l_t^{(F_2)}(\boldsymbol{x}_t) \right\}$$

$$\leq \sqrt{8T\tilde{B}\beta_T^{1/2}\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 20T\beta_T \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}}.$$
(21)

Therefore, from (14), (15) and (21), we have the desired inequality.

Next, in order to evaluate $\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) d\boldsymbol{w}$ and $\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) d\boldsymbol{w}$ in the right hand side of the inequality of Lemma A.1, we introduce the following lemma given by [30]:

Lemma A.2. Let S_t be any non-negative stochastic process adapted to a filtration $\{\mathcal{F}_t\}$, and define $m_t = E[S_t \mid \mathcal{F}_{t-1}]$. Assume that $S_t \leq K$ for $K \geq 1$. Then, for any $T \geq 1$, the following holds with probability at least $1 - \delta$:

$$\sum_{t=1}^{T} m_t \le 2 \sum_{t=1}^{T} S_t + 8K \ln \frac{6K}{\delta}.$$

Furthermore, from the assumption about the kernel function, we get $k((\boldsymbol{x}_t, \boldsymbol{w}), (\boldsymbol{x}_t, \boldsymbol{w})) \leq 1$ and $\sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) \leq k((\boldsymbol{x}_t, \boldsymbol{w}), (\boldsymbol{x}_t, \boldsymbol{w})) \leq 1$. Hence, from Lemma A.2, with probability at least $1 - \delta/3$, it holds that

$$\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \le 2 \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 8 \ln \frac{18}{\delta}.$$
(22)

Similarly, the following inequality holds with probability at least $1 - \delta/3$:

$$\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} \leq 2 \sum_{t=1}^{T} \sigma_{t-1}^{2}(\boldsymbol{x}_{t}, \boldsymbol{w}_{t}) + 8 \ln \frac{18}{\delta}.$$
(23)

In addition, we introduce the following lemma given by [5] about the maximum information gain γ_T : Lemma A.3. Fix $T \ge 1$. Then, the following inequality holds:

$$\sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}_t) \le \frac{2}{\ln(1+\sigma^{-2})} \gamma_T.$$
(24)

Moreover, from Schwarz's inequality and Lemma A.3, we get the following inequality:

$$\sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) \le \sqrt{\frac{2T}{\ln(1+\sigma^{-2})}\gamma_T}.$$
(25)

Thus, from (22), (23), (24) and (25) we obtain the following corollary:

Corollary A.1. Assume that (13), (22) and (23) hold. Then, for any $T \ge 1$, it holds that

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le \alpha \beta_T^{1/2} \left\{ \sqrt{2TC_1 \gamma_T} + C_2 \right\} + (1-\alpha) \sqrt{2T\tilde{B}\beta_T^{1/2} \left\{ \sqrt{8TC_1 \gamma_T} + 2C_2 \right\} + 5T\beta_T \left\{ C_1 \gamma_T + 2C_2 \right\}},$$

where $C_1 = \frac{16}{\ln(1+\sigma^{-2})}$ and $C_2 = 16 \ln \frac{18}{\delta}$.

Proof. From Lemma A.1, (22) and (23), it holds that

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 4\alpha \beta_T^{1/2} \left\{ \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\} + (1-\alpha) \sqrt{16T\tilde{B}\beta_T^{1/2} \left\{ \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\} + 40T\beta_T \left\{ \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\}}.$$
(26)

Therefore, by combining (24), (25) and (26), we get the desired inequality.

Finally, we prove Theorem 4.1. Let $T \ge 1$, and define $\hat{T} = \operatorname{argmax}_{t=1,\ldots,T} l_t^{(G)}(\boldsymbol{x}_t)$. Assume that (13) holds. Then, for any $\boldsymbol{x} \in \mathcal{X}$, it holds that $G(\boldsymbol{x}) \in [l_t^{(G)}(\boldsymbol{x}), u_t^{(G)}(\boldsymbol{x})]$. Thus, for any $t' = 1, \ldots, T$, we get

$$G(\boldsymbol{x}^{*}) - G(\hat{\boldsymbol{x}}_{T}) \leq u_{t'}^{(G)}(\boldsymbol{x}_{t'}) - l_{\hat{T}}^{(G)}(\hat{\boldsymbol{x}}_{T})$$

$$= u_{t'}^{(G)}(\boldsymbol{x}_{t'}) - \max_{t=1,...,T} l_{t}^{(G)}(\hat{\boldsymbol{x}}_{t})$$

$$\leq u_{t'}^{(G)}(\boldsymbol{x}_{t'}) - l_{t'}^{(G)}(\boldsymbol{x}_{t'}).$$

This implies that

$$G(\boldsymbol{x}^*) - G(\hat{\boldsymbol{x}}_T) \le \frac{1}{T} \sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\}.$$
(27)

Here, note that with probability at least $1 - \delta$, (13), (22) and (23) hold. Therefore, by combining Corollary A.1, the following holds with probability at least $1 - \delta$:

$$G(\boldsymbol{x}^*) - G(\hat{\boldsymbol{x}}_T) \le \alpha T^{-1} \beta_T^{1/2} \left(\sqrt{2TC_1 \gamma_T} + C_2 \right) + (1 - \alpha) T^{-1} \sqrt{2T \tilde{B} \beta_T^{1/2} \left(\sqrt{8TC_1 \gamma_T} + 2C_2 \right) + 5T \beta_T \left(C_1 \gamma_T + 2C_2 \right)}.$$

Hence, if T satisfies (11), with probability at least $1 - \delta$, it holds that $G(\mathbf{x}^*) - G(\hat{\mathbf{x}}_T) \leq \epsilon$. Therefore, $\hat{\mathbf{x}}_T$ is the ϵ -accurate solution.

A.2 Proof of Theorem 4.2

In this subsection, we prove Theorem 4.2. First, we show several lemmas.

Lemma A.4. For any $t \ge 1$, $\hat{\Pi}_t$ has at least one element (i.e., $\hat{\Pi}_t \neq \emptyset$).

Proof. Let $t \geq 1$. We define $\tilde{\boldsymbol{x}}_t$ and $\boldsymbol{x}_t^{\dagger}$ as

$$egin{aligned} & ilde{oldsymbol{x}}_t = rg\max_{oldsymbol{x}\in\mathcal{X}} l_t^{(F_2)}(oldsymbol{x}), \ &oldsymbol{x}_t^\dagger = rg\max_{oldsymbol{x}\in\mathcal{X}; l_t^{(F_2)}(oldsymbol{x}) = l_t^{(F_2)}(oldsymbol{x}_t)} l_t^{(F_1)}(oldsymbol{x}). \end{aligned}$$

Assume that $E_{t, \boldsymbol{x}_t^{\dagger}}^{(\text{pes})} = \emptyset$. Then, it holds that

$$\forall \boldsymbol{x}' \in \boldsymbol{\emptyset} = E_{t, \boldsymbol{x}_t^{\dagger}}^{(\text{pes})}, \ \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}_t^{\dagger}) \npreceq \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}').$$

This implies that $\boldsymbol{x}_t^{\dagger} \in \hat{\Pi}_t$. On the other hand, if $E_{t,\boldsymbol{x}_t^{\dagger}}^{(\text{pes})} \neq \emptyset$, then the following holds for any $\boldsymbol{x}' \in E_{t,\boldsymbol{x}_t^{\dagger}}^{(\text{pes})}$:

$$l_t^{(F_2)}(\boldsymbol{x}_t^{\dagger}) = l_t^{(F_2)}(\tilde{\boldsymbol{x}}_t) \ge l_t^{(F_2)}(\boldsymbol{x}')$$

Here, if $l_t^{(F_2)}(\boldsymbol{x}_t^{\dagger}) > l_t^{(F_2)}(\boldsymbol{x}')$, it holds that $\boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}_t^{\dagger}) \not\preceq \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}')$. Similarly, if $l_t^{(F_2)}(\boldsymbol{x}_t^{\dagger}) = l_t^{(F_2)}(\boldsymbol{x}')$, it holds that

 $l_t^{(F_1)}(\boldsymbol{x}_t^{\dagger}) \ge l_t^{(F_1)}(\boldsymbol{x}').$

Noting that $F_t^{(\text{pes})}(\boldsymbol{x}_t^{\dagger}) \neq F_t^{(\text{pes})}(\boldsymbol{x}')$ and $l_t^{(F_2)}(\boldsymbol{x}_t^{\dagger}) = l_t^{(F_2)}(\boldsymbol{x}')$, we have $l_t^{(F_1)}(\boldsymbol{x}_t^{\dagger}) > l_t^{(F_1)}(\boldsymbol{x}')$. Thus, we have $F_t^{(\text{pes})}(\boldsymbol{x}_t^{\dagger}) \not\leq F_t^{(\text{pes})}(\boldsymbol{x}')$. Form the definition of $\hat{\Pi}_t$, we get $\boldsymbol{x}_t^{\dagger} \in \hat{\Pi}_t$.

Lemma A.5. Let $t \ge 1$, and assume that $M_t \ne \emptyset$. Also let $x^{(1)}$ be an element of M_t . Then, there exists an element $x' \in \hat{\Pi}_t$ such that

$$oldsymbol{F}_t^{(pes)}(oldsymbol{x}^{(1)}) \preceq oldsymbol{F}_t^{(pes)}(oldsymbol{x}').$$

Proof. Let $t \ge 1$, $M_t \ne \emptyset$ and $\boldsymbol{x}^{(1)} \in M_t$. Assume that the following holds:

$$\boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}^{(1)}) \not\preceq \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}'), \; \forall \boldsymbol{x}' \in \hat{\Pi}_{t}.$$

$$(28)$$

From the definition of M_t , we have $\boldsymbol{x}^{(1)} \notin \hat{\Pi}_t$. Here, since $\boldsymbol{x}^{(1)} \notin \hat{\Pi}_t$, there exists $\boldsymbol{x}^{(2)} \in E_{t,\boldsymbol{x}^{(1)}}^{(\text{pes})}$ such that

$$\boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}^{(1)}) \preceq \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}^{(2)}).$$

Therefore, there exists $\pmb{x}^{(3)} \in E_{t,\pmb{x}^{(2)}}^{(\mathrm{pes})}$ such that

$$\boldsymbol{F}_t^{(\mathrm{pes})}(\boldsymbol{x}^{(2)}) \preceq \boldsymbol{F}_t^{(\mathrm{pes})}(\boldsymbol{x}^{(3)}).$$

Furthermore, by combining

$$F_t^{(ext{pes})}(x^{(1)}) \preceq F_t^{(ext{pes})}(x^{(2)}), \ F_t^{(ext{pes})}(x^{(2)}) \preceq F_t^{(ext{pes})}(x^{(3)})$$

we get $\mathbf{F}_{t}^{(\text{pes})}(\mathbf{x}^{(1)}) \preceq \mathbf{F}_{t}^{(\text{pes})}(\mathbf{x}^{(3)})$. Thus, from (28) we obtain $\mathbf{x}^{(3)} \notin \hat{\Pi}_{t}$. By repeating the same argument, we have $\mathbf{x}^{(1)}, \ldots, \mathbf{x}^{(|\mathcal{X}|)}$, where $\mathbf{x}^{(k)} \notin \hat{\Pi}_{t}$, $k = 1, \ldots, |\mathcal{X}|$. Next, we show that $\mathbf{x}^{(i)} \neq \mathbf{x}^{(j)}$ for any i and j with $i \neq j$. In fact, if there exist i and j with i < j such that $\mathbf{x}^{(i)} = \mathbf{x}^{(j)}$, we get $\mathbf{F}_{t}^{(\text{pes})}(\mathbf{x}^{(i)}) = \mathbf{F}_{t}^{(\text{pes})}(\mathbf{x}^{(j)})$. Here, from $i \leq j - 1$, noting that the definition of $\mathbf{x}^{(i)}$ and $\mathbf{x}^{(j-1)}$ we get

$$F_t^{(ext{pes})}(m{x}^{(j)}) = F_t^{(ext{pes})}(m{x}^{(i)}) \le F_t^{(ext{pes})}(m{x}^{(j-1)}).$$

Similarly, from the definition of $x^{(j-1)}$ and $x^{(j)}$, we obtain

$$oldsymbol{F}_t^{(ext{pes})}(oldsymbol{x}^{(j-1)}) \leq oldsymbol{F}_t^{(ext{pes})}(oldsymbol{x}^{(j)}).$$

Thus, we get $\boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}^{(j-1)}) = \boldsymbol{F}_{t}^{(\text{pes})}(\boldsymbol{x}^{(j)})$. However, it contradicts $\boldsymbol{x}^{(j)} \in E_{t,\boldsymbol{x}^{(j-1)}}^{(\text{pes})}$. Hence, it holds that $\boldsymbol{x}^{(i)} \neq \boldsymbol{x}^{(j)}$ for any *i* and *j* with $i \neq j$. Therefore, the set $\{\boldsymbol{x}^{(1)}, \ldots, \boldsymbol{x}^{(|\mathcal{X}|)}\}$ is equal to \mathcal{X} . Recall that $\boldsymbol{x}^{(k)} \notin \hat{\Pi}_t$ for any $k = 1, \ldots, |\mathcal{X}|$. By combining this and $\{\boldsymbol{x}^{(1)}, \ldots, \boldsymbol{x}^{(|\mathcal{X}|)}\} = \mathcal{X}$, we have $\hat{\Pi}_t = \emptyset$. However, it contradicts Lemma A.4. Hence, the assumption (28) is incorrect.

Lemma A.6. Let x be an element of \mathcal{X} , and let $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)$ be a positive vector. Assume that at least one of the following inequalities holds for any $x' \in \mathcal{X}$:

$$F_1(\boldsymbol{x}) + \epsilon_1 \ge F_1(\boldsymbol{x}'), \ F_2(\boldsymbol{x}) + \epsilon_2 \ge F_2(\boldsymbol{x}').$$

Then, it holds that $F(x) \in Z_{\epsilon}$.

Proof. In order to prove Lemma A.6, we consider the following two cases:

- (1) For any $\boldsymbol{x}, \boldsymbol{x}' \in \Pi$, $\boldsymbol{F}(\boldsymbol{x}) = \boldsymbol{F}(\boldsymbol{x}')$.
- (2) There exist $x, x' \in \Pi$ such that $F(x) \neq F(x')$.

First, we consider (1). We define $x^{(1)}$ and $x^{(2)}$ as

$$\begin{split} \tilde{\boldsymbol{x}} &= \operatorname*{arg\,max}_{\boldsymbol{x}\in\mathcal{X}} F_1(\boldsymbol{x}), \ \boldsymbol{x}^{(1)} &= \operatorname*{arg\,max}_{\boldsymbol{x};F_1(\boldsymbol{x})=F_1(\tilde{\boldsymbol{x}})} F_2(\boldsymbol{x}), \\ \boldsymbol{x}^{\dagger} &= \operatorname*{arg\,max}_{\boldsymbol{x}\in\mathcal{X}} F_2(\boldsymbol{x}), \ \boldsymbol{x}^{(2)} &= \operatorname*{arg\,max}_{\boldsymbol{x};F_2(\boldsymbol{x})=F_2(\boldsymbol{x}^{\dagger})} F_1(\boldsymbol{x}). \end{split}$$

From the definition of $\boldsymbol{x}^{(1)}$ and $\boldsymbol{x}^{(2)}$, it holds that $\boldsymbol{x}^{(1)}, \boldsymbol{x}^{(2)} \in \Pi$. Thus, from (1), we get $\boldsymbol{F}(\boldsymbol{x}^{(1)}) = \boldsymbol{F}(\boldsymbol{x}^{(2)})$. Hence, the following holds for any $\boldsymbol{x}' \in \mathcal{X}$:

$$F_1(\boldsymbol{x}') \leq F_1(\boldsymbol{x}^{(1)}), \ F_2(\boldsymbol{x}') \leq F_2(\boldsymbol{x}^{(2)}) = F_2(\boldsymbol{x}^{(1)}).$$

Therefore, we get $F(\mathbf{x}') \leq F(\mathbf{x}^{(1)})$. Note that $F(\mathbf{x}^{(1)}) \in \mathbb{Z}$. Here, let $\mathbf{x} \in \mathcal{X}$. Then, from the lemma's assumption, at least one of the following inequalities holds:

$$F_1(\boldsymbol{x}) + \epsilon_1 \ge F_1(\boldsymbol{x}^{(1)}), \ F_2(\boldsymbol{x}) + \epsilon_2 \ge F_2(\boldsymbol{x}^{(1)}).$$

If $F_1(\boldsymbol{x}) + \epsilon_1 \geq F_1(\boldsymbol{x}^{(1)})$, we set $\boldsymbol{a} = (F_1(\boldsymbol{x}^{(1)}), F_2(\boldsymbol{x}))^\top$. Noting that $F_2(\boldsymbol{x}') \leq F_2(\boldsymbol{x}^{(1)})$ for any $\boldsymbol{x}' \in \mathcal{X}$, we have $\boldsymbol{a} \leq \boldsymbol{F}(\boldsymbol{x}^{(1)})$. This implies that $\boldsymbol{a} \in Z$. Thus, the following holds:

$$\boldsymbol{a} = (F_1(\boldsymbol{x}^{(1)}), F_2(\boldsymbol{x}))^\top \preceq (F_1(\boldsymbol{x}) + \epsilon_1, F_2(\boldsymbol{x}) + \epsilon_2)^\top = \boldsymbol{F}(\boldsymbol{x}) + \boldsymbol{\epsilon}.$$

Furthermore, since $F(\mathbf{x}) \preceq F(\mathbf{x}^{(1)})$ and $F(\mathbf{x}^{(1)}) \in \mathbb{Z}$, we obtain $F(\mathbf{x}) \in \mathbb{Z}_{\epsilon}$. Similarly, if $F_2(\mathbf{x}) + \epsilon_2 \ge F_2(\mathbf{x}^{(1)})$, we set $\mathbf{b} = (F_1(\mathbf{x}), F_2(\mathbf{x}^{(1)}))^{\top}$. Also in this case, by using the same argument, we get $\mathbf{b} \in \mathbb{Z}$ and

$$\boldsymbol{b} \preceq \boldsymbol{F}(\boldsymbol{x}) + \boldsymbol{\epsilon}$$

By combining this and $F(x) \leq F(x^{(1)})$ (and $F(x^{(1)}) \in Z$), we obtain $F(x) \in Z_{\epsilon}$.

Next, we consider (2). From (2), there exist $\boldsymbol{x}^{(1)}, \ldots, \boldsymbol{x}^{(l)}$ such that

$$F(\Pi) = \{F(x) \mid x \in \Pi\} = \{F(x^{(i)}) \mid i = 1, ..., l\}, \quad F(x^{(i)}) \neq F(x^{(j)}), i \neq j.$$

Here, without loss of generality, we may assume the following:

$$F_1(\boldsymbol{x}^{(1)}) < \cdots < F_1(\boldsymbol{x}^{(l)}), \quad F_2(\boldsymbol{x}^{(1)}) > \cdots > F_2(\boldsymbol{x}^{(l)}).$$

Let \boldsymbol{x} be an element of \mathcal{X} . Assume that there exists j such that

$$F_1(\boldsymbol{x}) + \epsilon_1 \ge F_1(\boldsymbol{x}^{(j)}), \ F_2(\boldsymbol{x}) + \epsilon_2 \ge F_2(\boldsymbol{x}^{(j+1)}).$$

Note that $(F_1(\boldsymbol{x}^{(j)}), F_2(\boldsymbol{x}^{(j+1)})^\top \in \mathbb{Z}$. In addition, there exists $i \in \{1, \ldots, l\}$ such that $\boldsymbol{F}(\boldsymbol{x}) \preceq \boldsymbol{F}(\boldsymbol{x}^{(i)}) \in \mathbb{Z}$. Therefore, $\boldsymbol{F}(\boldsymbol{x}) \in \mathbb{Z}_{\boldsymbol{\epsilon}}$.

Similarly, assume that at least one of the following inequalities holds for any j:

$$F_1(\boldsymbol{x}) + \epsilon_1 < F_1(\boldsymbol{x}^{(j)}), \ F_2(\boldsymbol{x}) + \epsilon_2 < F_2(\boldsymbol{x}^{(j+1)}).$$
 (29)

Here, if $F_1(\boldsymbol{x}) + \epsilon_1 < F_1(\boldsymbol{x}^{(1)})$, from lemma's assumption it holds that $F_2(\boldsymbol{x}) + \epsilon_2 \ge F_2(\boldsymbol{x}^{(1)})$. Moreover, we define $\boldsymbol{c} = (F_1(\boldsymbol{x}), F_2(\boldsymbol{x}^{(1)}))^\top \in \mathbb{Z}$. Then, the following holds:

$$\boldsymbol{F}(\boldsymbol{x}) + \boldsymbol{\epsilon} = (F_1(\boldsymbol{x}) + \epsilon_1, F_2(\boldsymbol{x}) + \epsilon_2)^\top \succeq (F_1(\boldsymbol{x}), F_2(\boldsymbol{x}^{(1)}))^\top = \boldsymbol{c} \in Z.$$

Furthermore, from the definition of $\mathbf{x}^{(1)}$, it holds that $F_2(\mathbf{x}^{(1)}) \geq F_2(\mathbf{x})$. Thus, noting that $F_1(\mathbf{x}) + \epsilon_1 < F_1(\mathbf{x}^{(1)})$, we get $F_1(\mathbf{x}) \leq F_1(\mathbf{x}^{(1)})$. By combining these, we have $\mathbf{F}(\mathbf{x}) \preceq \mathbf{F}(\mathbf{x}^{(1)}) \in \mathbb{Z}$. This implies that $\mathbf{F}(\mathbf{x}) \in \mathbb{Z}_{\epsilon}$. On the other hand, if $F_1(\mathbf{x}) + \epsilon_1 \geq F_1(\mathbf{x}^{(1)})$, from (29) we get $F_2(\mathbf{x}) + \epsilon_2 < F_2(\mathbf{x}^{(2)})$. Therefore, from lemma's assumption, we obtain $F_1(\mathbf{x}) + \epsilon_1 \geq F_1(\mathbf{x}^{(2)})$. By using (29) again, we have $F_2(\mathbf{x}) + \epsilon_2 < F_2(\mathbf{x}^{(3)})$. Hence, by repeating these procedures, we get $F_1(\mathbf{x}) + \epsilon_1 \geq F_1(\mathbf{x}^{(l)})$ and $F_2(\mathbf{x}) + \epsilon_2 < F_2(\mathbf{x}^{(l)})$. Finally, noting that

$$\boldsymbol{F}(\boldsymbol{x}) \preceq (F_1(\boldsymbol{x}^{(l)}), F_2(\boldsymbol{x}) + \epsilon_2)^\top \preceq (F_1(\boldsymbol{x}^{(l)}), F_2(\boldsymbol{x}^{(l)}))^\top = \boldsymbol{F}(\boldsymbol{x}^{(l)}) \in Z$$
$$\boldsymbol{F}(\boldsymbol{x}) + \boldsymbol{\epsilon} \succeq (F_1(\boldsymbol{x}^{(l)}), F_2(\boldsymbol{x}))^\top \in Z,$$

we get $\boldsymbol{F}(\boldsymbol{x}) \in Z_{\boldsymbol{\epsilon}}$.

By using these lemmas, we prove Theorem 4.2.

Proof. First, we prove that the algorithm terminates after at most t' iterations where t' is the positive integer satisfying $\max_{\boldsymbol{x} \in M_{t'} \cup \hat{\Pi}_{t'}} \lambda_{t'}(\boldsymbol{x}) = \lambda_{t'}(\boldsymbol{x}_{t'}) \leq \min \{\epsilon_1, \epsilon_2\}$. From the definition of λ_t , noting that $u_t^{(F_1)}(\boldsymbol{x}) - l_t^{(F_1)}(\boldsymbol{x}) \leq \lambda_t(\boldsymbol{x})$ and $u_t^{(F_2)}(\boldsymbol{x}) - l_t^{(F_2)}(\boldsymbol{x}) \leq \lambda_t(\boldsymbol{x})$, we have

$$\max_{\boldsymbol{x}\in M_{t'}\cup\hat{\Pi}_{t'}}\left\{u_{t'}^{(F_1)}(\boldsymbol{x})-l_{t'}^{(F_1)}(\boldsymbol{x})\right\}\leq\epsilon_1$$

and

$$\max_{\boldsymbol{x}\in M_{t'}\cup\hat{\Pi}_{t'}}\left\{u_{t'}^{(F_2)}(\boldsymbol{x})-l_{t'}^{(F_2)}(\boldsymbol{x})\right\}\leq\epsilon_2.$$

Then, for any $\boldsymbol{x}' \in \hat{\Pi}_t$, it holds that

$$u_{t'}^{(F_1)}(\mathbf{x}') \le l_{t'}^{(F_1)}(\mathbf{x}') + \epsilon_1 \tag{30}$$

and

$$u_{t'}^{(F_2)}(\mathbf{x}') \le l_{t'}^{(F_2)}(\mathbf{x}') + \epsilon_2.$$
(31)

Here, let \boldsymbol{x} be an element of $\hat{\Pi}_{t'}$. Then, from the definition of $\hat{\Pi}_t$, for any $\boldsymbol{x}' \in \hat{\Pi}_{t'}$, at least one of the following inequalities holds:

$$l_{t'}^{(F_1)}({m x}') \leq l_{t'}^{(F_1)}({m x}), \ l_{t'}^{(F_2)}({m x}') \leq l_{t'}^{(F_2)}({m x}).$$

Thus, from (30) and (31), for any $\mathbf{x}' \in \hat{\Pi}_{t'}$, it holds that $\mathbf{F}_{t}^{(\text{pes})}(\mathbf{x}) + \boldsymbol{\epsilon} \not\prec \mathbf{F}_{t'}^{(\text{opt})}(\mathbf{x}')$. This implies that $U_{t'} = \emptyset$. Similarly, if $M_{t'} \neq \emptyset$, there exists $\mathbf{x} \in M_{t'}$ such that $\mathbf{F}_{t'}^{(\text{opt})}(\mathbf{x}) \not\preceq_{\boldsymbol{\epsilon}} \mathbf{F}_{t'}^{(\text{pes})}(\mathbf{x}')$ for any $\mathbf{x}' \in \hat{\Pi}_t$. On the other hand, from Lemma A.5, there exists $\mathbf{x}'' \in \hat{\Pi}_{t'}$ such that $\mathbf{F}_{t'}^{(\text{pes})}(\mathbf{x}) \preceq \mathbf{F}_{t'}^{(\text{pes})}(\mathbf{x}')$. Moreover, from (30) and (31), \mathbf{x}'' satisfies $\mathbf{F}_{t'}^{(\text{opt})}(\mathbf{x}) \preceq_{\boldsymbol{\epsilon}} \mathbf{F}_{t'}^{(\text{pes})}(\mathbf{x}'')$. However, it contradicts the definition of M_t . Hence, we get $M_{t'} = \emptyset$.

Hereafter, we assume that (13), (22) and (23) hold. From the definition of λ_t , we obtain

$$\lambda_t(\boldsymbol{x}) \leq \left\{ u_t^{(F_1)}(\boldsymbol{x}) - l_t^{(F_1)}(\boldsymbol{x}) \right\} + \left\{ u_t^{(F_2)}(\boldsymbol{x}) - l_t^{(F_2)}(\boldsymbol{x}) \right\}.$$

This implies that

$$\sum_{t=1}^{T} \lambda_t(\boldsymbol{x}_t) \le \sum_{t=1}^{T} \left\{ u_t^{(F_1)}(\boldsymbol{x}_t) - l_t^{(F_1)}(\boldsymbol{x}_t) \right\} + \sum_{t=1}^{T} \left\{ u_t^{(F_2)}(\boldsymbol{x}_t) - l_t^{(F_2)}(\boldsymbol{x}_t) \right\}.$$

Therefore, from (15), (21), (22) and (23), we get

$$\sum_{t=1}^{T} \lambda_t(\boldsymbol{x}_t) \le 4\beta_T^{1/2} \left\{ \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\} + \sqrt{16T\tilde{B}\beta_T^{1/2} \left\{ \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\} + 40T\beta_T \left\{ \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}_t) + 4\ln\frac{18}{\delta} \right\}}$$

Hence, from (24) and (25), it holds that

$$\frac{1}{T}\sum_{t=1}^{T}\lambda_t(\boldsymbol{x}_t) \le T^{-1}\beta_T^{1/2} \left\{ \sqrt{2TC_1\gamma_T} + C_2 \right\} + T^{-1}\sqrt{2T\tilde{B}\beta_T^{1/2} \left\{ \sqrt{8TC_1\gamma_T} + 2C_2 \right\} + 5T\beta_T \left\{ C_1\gamma_T + 2C_2 \right\}}.$$
 (32)

Here, let T be a positive integer such that the right hand side in (32) is less than or equal to $\min\{\epsilon_1, \epsilon_2\}$. Then, there exists a positive integer t' such that $t' \leq T$ and $\lambda_{t'}(\boldsymbol{x}_{t'}) \leq \min\{\epsilon_1, \epsilon_2\}$. Therefore, we have $M_{t'} = \emptyset$ and $U_{t'} = \emptyset$. This means that the algorithm terminates after at most t' iterations.

Next, under (13) we show that $\hat{\Pi}_t$ is the ϵ -accurate Pareto set when $M_t = \emptyset$ and $U_t = \emptyset$. First, we prove $F(\hat{\Pi}_t) \subset Z_{\epsilon}$. Let \boldsymbol{x} be an element of $\hat{\Pi}_t$. For any $\boldsymbol{x}' \in \hat{\Pi}_t \setminus \{\boldsymbol{x}\}$, it holds that $F_t^{(\text{pes})}(\boldsymbol{x}) + \boldsymbol{\epsilon} \not\prec F_t^{(\text{opt})}(\boldsymbol{x}')$ because $U_t = \emptyset$. Furthermore, noting that $M_t = \emptyset$, for any $\boldsymbol{x}' \in \mathcal{X} \setminus \hat{\Pi}_t$, there exists $\boldsymbol{x}'' \in \hat{\Pi}_t$ such that $F_t^{(\text{opt})}(\boldsymbol{x}') \preceq_{\boldsymbol{\epsilon}} F_t^{(\text{pes})}(\boldsymbol{x}')$. In addition, since $\boldsymbol{x} \in \hat{\Pi}_t$, from the definition of $\hat{\Pi}_t$, at least one of the following inequalities holds:

$$l_t^{(F_1)}(\boldsymbol{x}'') \leq l_t^{(F_1)}(\boldsymbol{x}), l_t^{(F_2)}(\boldsymbol{x}'') \leq l_t^{(F_2)}(\boldsymbol{x}).$$

By combining this and $F_t^{(\text{opt})}(\mathbf{x}') \preceq_{\epsilon} F_t^{(\text{pes})}(\mathbf{x}'')$, we get $F_t^{(\text{pes})}(\mathbf{x}) + \epsilon \not\prec F_t^{(\text{opt})}(\mathbf{x}')$. Therefore, under (13) at least one of the following inequalities holds for any $\mathbf{x}' \in \mathcal{X} \setminus \{\mathbf{x}\}$:

$$F_1(\boldsymbol{x}) + \epsilon_1 \ge F_1(\boldsymbol{x}'), \ F_2(\boldsymbol{x}) + \epsilon_2 \ge F_2(\boldsymbol{x}').$$

Moreover, it is clear that $F_1(\boldsymbol{x}) + \epsilon_1 \geq F_1(\boldsymbol{x})$. Hence, from Lemma A.6, we get $\boldsymbol{F}(\hat{\Pi}_t) \subset Z_{\boldsymbol{\epsilon}}$. Finally, we show that for any $\boldsymbol{x}' \in \Pi$, there exists $\boldsymbol{x} \in \hat{\Pi}_t$ such that $\boldsymbol{x}' \preceq_{\boldsymbol{\epsilon}} \boldsymbol{x}$. When $\boldsymbol{x}' \in \hat{\Pi}_t$, the existence of \boldsymbol{x} is obvious because $\boldsymbol{x}' \preceq_{\boldsymbol{\epsilon}} \boldsymbol{x}'$. On the other hand, when $\boldsymbol{x}' \in \mathcal{X} \setminus \hat{\Pi}_t$, since $M_t = \emptyset$ there exists $\boldsymbol{x} \in \hat{\Pi}_t$ such that $F_t^{(\text{opt})}(\boldsymbol{x}') \preceq_{\boldsymbol{\epsilon}} F_t^{(\text{pes})}(\boldsymbol{x})$. Thus, under (13), this implies that $\boldsymbol{x}' \preceq_{\boldsymbol{\epsilon}} \boldsymbol{x}$. Hence, for any $\boldsymbol{x}' \in \Pi$, there exists $\boldsymbol{x} \in \hat{\Pi}_t$ such that $\boldsymbol{x}' \preceq_{\boldsymbol{\epsilon}} \boldsymbol{x}$. From this and $F(\hat{\Pi}_t) \subset Z_{\boldsymbol{\epsilon}}$, we have that $\hat{\Pi}_t$ is the $\boldsymbol{\epsilon}$ -accurate Pareto set. Here, note that (13), (22) and (23) hold with probability at least $1 - \delta$. Therefore, we get the desired result.

Β Extension to Constraint Optimization Problem

In real applications, there exists a situation where the known tolerance level for the value of the function F_2 is defined. For example, in the parameter tuning of an engineering system, this situation corresponds to the case where the variance of the performance must be below a certain level. In such a situation, it is necessary to treat the functions F_1 and F_2 as in the following constrained optimization problem:

$$\boldsymbol{x}^* = \operatorname*{arg max}_{\boldsymbol{x} \in \mathcal{X}} F_1(\boldsymbol{x}) \text{ s.t. } F_2(\boldsymbol{x}) \geq h,$$

where h < 0 is a user-specified known threshold parameter. Moreover, in order to show theoretical guarantees, for a non-negative vector $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)$, we define an $\boldsymbol{\epsilon}$ -accurate solution as a solution $\hat{\boldsymbol{x}}$ satisfying

$$F_1(\hat{\boldsymbol{x}}) \ge F_1(\boldsymbol{x}^*) - \epsilon_1, \ F_2(\hat{\boldsymbol{x}}) \ge h - \epsilon_2.$$

Proposed Algorithm First, we define $M_t^{(\text{cons})}, S_t$ and $M_t^{(\text{obj})}$ as

$$\begin{split} M_t^{(\text{cons})} &= \left\{ \boldsymbol{x} \in \mathcal{X} \mid u_t^{(F_2)}(\boldsymbol{x}) \ge h - \epsilon_2 \right\},\\ S_t &= \left\{ \boldsymbol{x} \in \mathcal{X} \mid l_t^{(F_2)}(\boldsymbol{x}) \ge h - \epsilon_2 \right\},\\ M_t^{(\text{obj})} &= \left\{ \boldsymbol{x} \in \mathcal{X} \mid u_t^{(F_1)}(\boldsymbol{x}) \ge \max_{\boldsymbol{x}' \in S_t} l_t^{(F_1)}(\boldsymbol{x}') - \epsilon_1 \right\}. \end{split}$$

Here, we define $M_t^{(\text{obj})} = \mathcal{X}$ if $S_t = \emptyset$. Note that an element in the complement of $M_t^{(\text{cons})}$ or $M_t^{(\text{obj})}$ is not an ϵ -accurate solution with high probability. In addition, S_t is a set that is determined to be a feasible region with high probability. Based on these definitions, we define a latent optimal solution set M_t at the tth step as follows:

$$M_t = M_t^{(\text{cons})} \cap M_t^{(\text{obj})}.$$

In our proposed algorithm, we select the most uncertain point in the latent optimal solution set M_t . In other words, the observation point x_t at the tth step is selected by using λ_t as defined by Equation (8) as follows:

$$\boldsymbol{x}_t = \underset{\boldsymbol{x} \in M_t}{\arg \max \lambda_t(\boldsymbol{x})}.$$
(33)

Furthermore, if $S_t \neq \emptyset$ at the *t*th step, then we define the estimated optimal solution \hat{x}_t by $\hat{x}_t = \operatorname{argmax}_{x \in S_t} l_t^{(F_1)}(x)$. In order to ensure that \hat{x}_t is an ϵ -accurate solution, the uncertainties of the function values F_1 and F_2 for the latent optimal solution should be sufficiently small. In the proposed method, the algorithm terminates at the tth step which satisfies the following:

$$\max_{\boldsymbol{x}\in M_t}\lambda_t(\boldsymbol{x})\leq\min\{\epsilon_1,\epsilon_2\}.$$

The pseudo code of the proposed method is shown as Algorithm 3.

Theoretical Analysis For Algorithm 3, the following theorem holds:

Theorem B.1. Let k be a positive-definite kernel, and let $f \in \mathcal{H}_k$ with $||f||_{\mathcal{H}_k} \leq B$. Also let $\delta \in (0,1)$ and $\epsilon_1 > 0$, $\epsilon_2 > 0$, and define $\beta_t = \left(\sqrt{\ln \det(\mathbf{I}_t + \sigma^{-2}\mathbf{K}_t) + 2\ln\frac{3}{\delta}} + B\right)^2$. Then, with probability at least $1 - \delta$, the following 1. and 2. hold:

1. Algorithm 3 terminates after at most T iterations, where T is the smallest positive integer satisfying

$$T^{-1}\beta_T^{1/2} \left\{ \sqrt{2TC_1\gamma_T} + C_2 \right\} + T^{-1} \sqrt{2T\tilde{B}\beta_T^{1/2}} \left\{ \sqrt{8TC_1\gamma_T} + 2C_2 \right\} + 5T\beta_T \left\{ C_1\gamma_T + 2C_2 \right\} \le \min\{\epsilon_1, \epsilon_2\}.$$

Here, $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|, C_1 = \frac{16}{\ln(1+\sigma^{-2})} \text{ and } C_2 = 16\ln\frac{18}{\delta}.$

Algorithm 3 Proposed Algorithm for Constrained Optimization

Input: GP prior $\mathcal{GP}(0, k)$, $\{\beta_t\}_{t\in\mathbb{N}}$, Threshold h, Non-negative vector $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)$. $M_0 \leftarrow \mathcal{X}, S_0 \leftarrow \emptyset, t \leftarrow 0$. Compute $\lambda_0(\boldsymbol{x})$ for any $\boldsymbol{x} \in M_0$ while $\max_{\boldsymbol{x} \in M_t} \lambda_t(\boldsymbol{x}) \nleq \min\{\epsilon_1, \epsilon_2\}$ do Choose $\boldsymbol{x}_t = \operatorname{argmax}_{\boldsymbol{x} \in M_t} \lambda_t(\boldsymbol{x})$. 2. If \mathbf{x}^* exists, then $S_{t'} \neq \emptyset$ at the termination step $t' \leq T$. Moreover, $\hat{\mathbf{x}}_{t'} = \operatorname{argmax}_{\mathbf{x} \in S_{t'}} l_t^{(F_1)}(\mathbf{x})$ is an ϵ -accurate solution.

Proof. Assume that (13), (22) and (23) hold. Then, by using the same argument as in the proof of Theorem 4.2, we get

$$\frac{1}{T}\sum_{t=1}^{T}\lambda_t(\boldsymbol{x}_t) \le T^{-1}\beta_T^{1/2} \left\{ \sqrt{2TC_1\gamma_T} + C_2 \right\} + T^{-1}\sqrt{2T\tilde{B}\beta_T^{1/2} \left\{ \sqrt{8TC_1\gamma_T} + 2C_2 \right\} + 5T\beta_T \left\{ C_1\gamma_T + 2C_2 \right\}}.$$
 (34)

Here, from the definition of T, the right-hand side of (34) is less than or equal to $\min\{\epsilon_1, \epsilon_2\}$. Hence, there exists a positive integer $t' \leq T$ such that $\max_{\boldsymbol{x} \in M_{t'}} \lambda_{t'}(\boldsymbol{x}) = \lambda_{t'}(\boldsymbol{x}_{t'}) \leq \min\{\epsilon_1, \epsilon_2\}$. This implies that the algorithm terminates after at most T iterations.

Next, we prove claim 2 of the theorem. Assume that \boldsymbol{x}^* exists. Here, we consider the two cases $\boldsymbol{x}^* \in M_{t'}^{(\text{obj})}$ and $\boldsymbol{x}^* \notin M_{t'}^{(\text{obj})}$. For case $\boldsymbol{x}^* \in M_{t'}^{(\text{obj})}$, since (13) holds, the following inequality holds:

$$h - \epsilon_2 \le h \le F_2(\boldsymbol{x}^*) \le u_{t'}^{(F_2)}(\boldsymbol{x}^*).$$

This means that $\boldsymbol{x}^* \in M_{t'}^{(\text{cons})}$. Therefore, we have $\boldsymbol{x}^* \in M_{t'}$. Furthermore, noting that $u_t^{(F_1)}(\boldsymbol{x}) - l_t^{(F_1)}(\boldsymbol{x}) \leq \lambda_t(\boldsymbol{x})$ and $u_t^{(F_2)}(\boldsymbol{x}) - l_t^{(F_2)}(\boldsymbol{x}) \leq \lambda_t(\boldsymbol{x})$, it holds that

$$\max_{\boldsymbol{x}\in M_{t'}} \left\{ u_{t'}^{(F_1)}(\boldsymbol{x}) - l_{t'}^{(F_1)}(\boldsymbol{x}) \right\} \le \epsilon_1,$$
(35)

$$\max_{\boldsymbol{x}\in M_{t'}} \left\{ u_{t'}^{(F_2)}(\boldsymbol{x}) - l_{t'}^{(F_2)}(\boldsymbol{x}) \right\} \le \epsilon_2.$$
(36)

Here, if $l_{t'}^{(F_2)}(\boldsymbol{x}^*) < h - \epsilon_2$, then from (36), we get $u_{t'}^{(F_2)}(\boldsymbol{x}^*) < h$. Thus, from (13), we obtain $F_2(\boldsymbol{x}^*) < h$. However, this contradicts the definition of \boldsymbol{x}^* , implying that $l_{t'}^{(F_2)}(\boldsymbol{x}^*) \ge h - \epsilon_2$ and $\boldsymbol{x}^* \in S_{t'} \neq \emptyset$. Moreover, from (35) the following holds:

$$\max_{\boldsymbol{x} \in M_{t'}} \left\{ u_{t'}^{(F_1)}(\boldsymbol{x}) - l_{t'}^{(F_1)}(\boldsymbol{x}) \right\} \leq \epsilon_1$$

$$\Rightarrow u_{t'}^{(F_1)}(\boldsymbol{x}^*) - l_{t'}^{(F_1)}(\boldsymbol{x}^*) \leq \epsilon_1$$

$$\Rightarrow u_{t'}^{(F_1)}(\boldsymbol{x}^*) - \max_{\boldsymbol{x} \in S_{t'}} l_{t'}^{(F_1)}(\boldsymbol{x}) \leq \epsilon_1$$

$$\Rightarrow u_{t'}^{(F_1)}(\boldsymbol{x}^*) - l_{t'}^{(F_1)}(\hat{\boldsymbol{x}}_{t'}) \leq \epsilon_1$$

$$\Rightarrow l_{t'}^{(F_1)}(\hat{\boldsymbol{x}}_{t'}) \geq u_{t'}^{(F_1)}(\boldsymbol{x}^*) - \epsilon_1.$$

In addition, from the definition of $S_{t'}$, we have

 $l_{t'}(\hat{\boldsymbol{x}}_{t'}) \ge h - \epsilon_2.$

On the other hand, if $\boldsymbol{x}^* \notin M_{t'}^{(\text{obj})}$, then $M_{t'}^{(\text{obj})} \neq \mathcal{X}$. Thus, from the definition of $M_{t'}^{(\text{obj})}$, it holds that $S_{t'} \neq \emptyset$. Therefore, we get

$$l_{t'}(\hat{\boldsymbol{x}}_{t'}) = \max_{\boldsymbol{x} \in S_{t'}} l_{t'}(\boldsymbol{x}) \ge h - \epsilon_2.$$

Furthermore, since $\boldsymbol{x}^* \notin M_{t'}^{(\text{obj})}$, it holds that

$$u_{t'}^{(F_1)}(\boldsymbol{x}^*) - \epsilon_1 \le u_{t'}^{(F_1)}(\boldsymbol{x}^*) < l_{t'}^{(F_1)}(\hat{\boldsymbol{x}}_{t'}) - \epsilon_1 \le l_{t'}^{(F_1)}(\hat{\boldsymbol{x}}_{t'}).$$

Therefore, if \boldsymbol{x}^* exists, then we have $S_{t'} \neq \emptyset$ and

$$l_{t'}^{(F_1)}(\hat{\boldsymbol{x}}_{t'}) \ge u_{t'}^{(F_1)}(\boldsymbol{x}^*) - \epsilon_1,$$
(37)

$$l_{t'}(\hat{\boldsymbol{x}}_{t'}) \ge h - \epsilon_2. \tag{38}$$

Note that (37) and (38) imply that $\hat{x}_{t'}$ is an ϵ -accurate solution when (13) holds. Finally, since (13), (22) and (23) hold with probability at least $1 - \delta$, we have Theorem B.1.

C Details of Section 3.3

C.1 Noisy Input Setting

In this subsection, we consider the setting where the input \boldsymbol{x} contains a noise $\boldsymbol{\xi} \in \Delta$. Let $\mathcal{X} \subset \mathbb{R}^d$ be an input space for optimization. In addition, assume that \mathcal{X} is a finite set. Furthermore, let $\Delta \subset \mathbb{R}^d$ be a compact and convex set, and let $\boldsymbol{\xi}$ be a random noise satisfying $\boldsymbol{\xi} \in \Delta$. Moreover, let f be a black-box function on $\mathcal{D} := \{\boldsymbol{x} + \boldsymbol{\xi} \mid \boldsymbol{x} \in \mathcal{X}, \boldsymbol{\xi} \in \Delta\}$, and let $k : \mathcal{D} \times \mathcal{D} \to \mathbb{R}$ be a positive-definite kernel with $f \in \mathcal{H}_k$ and $\|f\|_{\mathcal{H}_k} \leq B$.

For each step t, we select an observation point $\boldsymbol{x}_t \in \mathcal{X}$, and the observed value is obtained as $y_t = f(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + \eta_t$. Here, η_t is the independent normal distribution $\eta_t \sim \mathcal{N}(0, \sigma^2)$, and $\boldsymbol{\xi}_t$ is the observed value of $\boldsymbol{\xi}$.

In this setting, the expected value and variance of f(x) with respect to $\boldsymbol{\xi}$ are given by

$$\mathbb{E}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})] = \int_{\Delta} f(\boldsymbol{x}+\boldsymbol{\xi})p(\boldsymbol{\xi})\mathrm{d}\boldsymbol{\xi},\tag{39}$$

$$\mathbb{V}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})] = \int_{\Delta} \{f(\boldsymbol{x}+\boldsymbol{\xi}) - \mathbb{E}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})]\}^2 p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi},$$
(40)

where $p(\boldsymbol{\xi})$ is a known probability density function of $\boldsymbol{\xi}$. Similarly as in (5), using (39) and (40) we define the optimization objective functions F_1 and F_2 . In addition, let $\mu_t(\boldsymbol{x})$, $\sigma_t^2(\boldsymbol{x})$ and $Q_t(\boldsymbol{x}) \coloneqq [l_t(\boldsymbol{x}), u_t(\boldsymbol{x})]$ denote the posterior mean, posterior variance and confidence bound of $f(\boldsymbol{x})$ at the step t, respectively.

Confidence Bound Confidence bounds of objective functions F_1 and F_2 defined by using (39) and (40) can also be constructed by using the same procedure as in 3.1. First, assume that $f(\tilde{x}) \in Q_t(\tilde{x})$ for any $\tilde{x} \in \mathcal{D}$. Then, the following holds for any $x \in \mathcal{X}$:

$$\int_{\Delta} l_t(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi} \le \int_{\Delta} f(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi} \le \int_{\Delta} u_t(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}.$$

Therefore, the confidence bound $Q_t^{(F_1)}(\boldsymbol{x})$ of $F_1(\boldsymbol{x})$ can be constructed as $Q_t^{(F_1)}(\boldsymbol{x}) \coloneqq [l_t^{(F_1)}(\boldsymbol{x}), u_t^{(F_1)}(\boldsymbol{x})]$ using

$$l_t^{(F_1)}(\boldsymbol{x}) = \int_{\Delta} l_t(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}, \ u_t^{(F_1)}(\boldsymbol{x}) = \int_{\Delta} u_t(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}$$

Similarly, the confidence bound $Q_t^{(F_2)}(\boldsymbol{x})$ of $F_2(\boldsymbol{x})$ can be expressed as $Q_t^{(F_2)}(\boldsymbol{x}) \coloneqq [l_t^{(F_2)}(\boldsymbol{x}), u_t^{(F_2)}(\boldsymbol{x})]$ using

$$l_t^{(F_2)}(\boldsymbol{x}) = -\sqrt{\int_{\Delta} \tilde{u}_t^{(\mathrm{sq})}(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}}, \ l_t^{(F_2)}(\boldsymbol{x}) = -\sqrt{\int_{\Delta} \tilde{l}_t^{(\mathrm{sq})}(\boldsymbol{x} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}},$$

where $\tilde{l}_t^{(\text{sq})}(\boldsymbol{x} + \boldsymbol{\xi})$ and $\tilde{u}_t^{(\text{sq})}(\boldsymbol{x} + \boldsymbol{\xi})$ are given by

$$\begin{split} \tilde{l}_t(\boldsymbol{x} + \boldsymbol{\xi}) &= l_t(\boldsymbol{x} + \boldsymbol{\xi}) - \mathbb{E}_{\boldsymbol{\xi}}[u_t(\boldsymbol{x} + \boldsymbol{\xi})], \\ \tilde{u}_t(\boldsymbol{x} + \boldsymbol{\xi}) &= u_t(\boldsymbol{x} + \boldsymbol{\xi}) - \mathbb{E}_{\boldsymbol{\xi}}[l_t(\boldsymbol{x} + \boldsymbol{\xi})], \\ \tilde{l}_t^{(\text{sq})}(\boldsymbol{x} + \boldsymbol{\xi}) &= \begin{cases} 0 & \text{if } \tilde{l}_t(\boldsymbol{x} + \boldsymbol{\xi}) \leq 0 \leq \tilde{u}_t(\boldsymbol{x} + \boldsymbol{\xi}), \\ \min\left\{\tilde{l}_t^2(\boldsymbol{x} + \boldsymbol{\xi}), \tilde{u}_t^2(\boldsymbol{x} + \boldsymbol{\xi})\right\} & \text{otherwise} \end{cases} \\ \tilde{u}_t^{(\text{sq})}(\boldsymbol{x} + \boldsymbol{\xi}) &= \max\left\{\tilde{l}_t^2(\boldsymbol{x} + \boldsymbol{\xi}), \tilde{u}_t^2(\boldsymbol{x} + \boldsymbol{\xi})\right\}. \end{split}$$

Using $Q_t^{(F_1)}$ and $Q_t^{(F_2)}$ above, we can construct the proposed algorithm in the same procedure.

C.2 Simulator Based Experiment

In this subsection, we consider the setting that w_t can be selected in the optimization phase at each step. Furthermore, we show theoretical guarantees in this setting. Hereafter, we only discuss the multi-task scenario, but the same argument can be made for multi-objective and constraint optimization scenarios by selecting w_t and ξ_t in the same procedure.

In our proposed algorithm, $(\boldsymbol{x}_t, \boldsymbol{w}_t)$ at the step t is selected by

$$egin{aligned} m{x}_t &= rg\max_{m{x}\in\mathcal{X}} u_t^{(G)}(m{x}), \ m{w}_t &= rg\max_{m{w}\in\Omega} \sigma_{t-1}(m{x}_t,m{w}). \end{aligned}$$

In this algorithm, the following theorem holds:

Theorem C.1. Let k be a positive-definite kernel, and let $f \in \mathcal{H}_k$ with $||f||_{\mathcal{H}_k} \leq B$. Also let $\delta \in (0,1)$, $\epsilon > 0$, and define $\beta_t = \left(\sqrt{\ln \det(\mathbf{I}_t + \sigma^{-2}\mathbf{K}_t) + 2\ln \frac{1}{\delta}} + B\right)^2$. Moreover, for any t, define $\hat{\mathbf{x}}_t = \operatorname{argmax}_{\mathbf{x}_{t'} \in \{\mathbf{x}_1, \dots, \mathbf{x}_t\}} l_{t'}^{(G)}(\mathbf{x}_{t'})$. Then, when the proposed algorithm in the simulator based setting is performed, $\hat{\mathbf{x}}_T$ is the ϵ -accurate solution with probability at least $1 - \delta$, where T is the smallest positive integer satisfying

$$\alpha T^{-1} \beta_T^{1/2} \sqrt{TC_1 \gamma_T} + (1-\alpha) T^{-1} \sqrt{4T \tilde{B} \beta_T^{1/2} \sqrt{TC_1 \gamma_T} + 5T \beta_T C_1 \gamma_T} \le \epsilon.$$

Here, \tilde{B} and C_1 are given by $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} \{f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]\}$ and $C_1 = \frac{8}{\ln(1 + \sigma^{-2})}$.

Proof. Assume that (13) holds. Then, from Lemma A.1 we have

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 2\alpha \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + (1-\alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w} + 20T \beta_T \sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}}$$

In addition, from the definition of \boldsymbol{w}_t , it holds that

$$\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w} \leq \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t),$$
$$\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}) p(\boldsymbol{w}) d\boldsymbol{w} \leq \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}_t).$$

Hence, we get

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 2\alpha \beta_T^{1/2} \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + (1-\alpha) \sqrt{8T\tilde{B}\beta_T^{1/2} \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t, \boldsymbol{w}_t) + 20T\beta_T \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t, \boldsymbol{w}_t)}$$

Furthermore, from (24) and (25), we obtain

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le \alpha \beta_T^{1/2} \sqrt{C_1 T \gamma_T} + (1 - \alpha) \sqrt{4T \tilde{B} \beta_T^{1/2} \sqrt{C_1 T \gamma_T} + 5T \beta_T C_1 \gamma_T}$$

Finally, by using the same argument as in the proof of Theorem 4.1, the following inequality holds:

$$G(\boldsymbol{x}^*) - G(\hat{\boldsymbol{x}}_T) \le \sum_{t=1}^T \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} / T.$$

Therefore, noting that the definition of T, we get the desired result.

Noisy Input Extension Here, we extend the setting defined in subsection 3.3.2 to the simulator based setting. Since there is the noise $\boldsymbol{\xi} \in \Delta$ instead of \boldsymbol{w} , we consider the observation point \boldsymbol{x}_t at the step t as $\boldsymbol{x}_t \coloneqq \tilde{\boldsymbol{x}}_t + \boldsymbol{\xi}_t$, where $(\tilde{\boldsymbol{x}}_t, \boldsymbol{\xi}_t)$ is given by

$$egin{aligned} & ilde{m{x}}_t = rg\max_{m{x}\in\mathcal{X}} u_t^{(G)}(m{x}), \ & extstyle m{\xi}_t = rg\max_{m{\xi}\in\Delta} \sigma_{t-1}(ilde{m{x}}_t+m{\xi}). \end{aligned}$$

Then, similar theorems as in Theorem C.1 hold. However, the practical performance of this algorithm is not much different from that of Uncertainty Sampling, which was used as the base method in numerical experiments. For this reason, in the simulator based noisy input setting, we propose a method for selecting (\tilde{x}_t, ξ_t) as follows:

$$\begin{split} \tilde{\boldsymbol{x}}_t &= \arg\max_{\boldsymbol{x}\in\mathcal{X}} u_t^{(G)}(\boldsymbol{x}), \\ \boldsymbol{\xi}_t &= \arg\max_{\boldsymbol{\xi}\in\Delta} \sigma_{t-1}(\tilde{\boldsymbol{x}}_t + \boldsymbol{\xi}) p(\boldsymbol{\xi}). \end{split}$$

In order to derive similar convergence results as in Theorem C.1, we assume that the probability density function $p(\boldsymbol{\xi})$ of $\boldsymbol{\xi}$ is a bounded function on Δ , i.e., $\sup_{\boldsymbol{\xi}\in\mathcal{D}}p(\boldsymbol{\xi})<\infty$.

Theorem C.2. Let $\delta \in (0,1)$, $\epsilon > 0$, and set $\beta_t = \left(\sqrt{\ln \det(I_t + \sigma^{-2}K_t) + 2\ln \frac{1}{\delta}} + B\right)^2$. For any t, define $\hat{x}_t = \arg \max_{x_{t'} \in \{x_1, \dots, x_t\}} l_{t'}^{(G)}(x_{t'})$. Moreover, assume that $\sup_{\boldsymbol{\xi} \in \Delta} p(\boldsymbol{\xi}) \leq R < \infty$. Then, when the proposed algorithm in

 $\operatorname{argmax}_{\boldsymbol{x}_{t'} \in \{\boldsymbol{x}_1, \dots, \boldsymbol{x}_t\}} l_{t'}^{(G)}(\boldsymbol{x}_{t'})$. Moreover, assume that $\sup_{\boldsymbol{\xi} \in \Delta} p(\boldsymbol{\xi}) \leq R < \infty$. Then, when the proposed algorithm in the simulator based noisy input setting is performed, $\hat{\boldsymbol{x}}_T$ is the ϵ -accurate solution with probability at least $1 - \delta$, where T is the smallest positive integer satisfying

$$\alpha T^{-1} \beta_T^{1/2} R \sqrt{TC_1 \gamma_T} + (1-\alpha) T^{-1} \sqrt{4T \tilde{B} R \beta_T^{1/2} \sqrt{TC_1 \gamma_T}} + 5T R \beta_T C_1 \gamma_T \le \epsilon.$$

Here, \tilde{B} and C_1 are given by $\tilde{B} = \max_{(\boldsymbol{x},\boldsymbol{\xi})\in(\mathcal{X}\times\Delta)} \{f(\boldsymbol{x}+\boldsymbol{\xi}) - \mathbb{E}_{\boldsymbol{\xi}}[f(\boldsymbol{x}+\boldsymbol{\xi})]\}$ and $C_1 = \frac{8}{\ln(1+\sigma^{-2})}$.

Proof. Similarly as in Lemma A.1, with probability at least $1 - \delta$, it holds that

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 2\alpha \beta_T^{1/2} \sum_{t=1}^{T} \int_{\Delta} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi} + (1-\alpha) \sqrt{8T\tilde{B}\beta_T^{1/2} \sum_{t=1}^{T} \int_{\Delta} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}) p(\boldsymbol{w}) \mathrm{d}\boldsymbol{\xi} + 20T\beta_T \sum_{t=1}^{T} \int_{\Delta} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}) p(\boldsymbol{\xi}) \mathrm{d}\boldsymbol{\xi}}$$

Moreover, from the definition of $\boldsymbol{\xi}_t$, we have

$$\sum_{t=1}^{T} \int_{\Delta} \sigma_{t-1}(\boldsymbol{x}_{t} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) d\boldsymbol{\xi} \leq \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_{t} + \boldsymbol{\xi}_{t}) p(\boldsymbol{\xi}_{t}) \leq R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_{t} + \boldsymbol{\xi}_{t}),$$
$$\sum_{t=1}^{T} \int_{\Omega} \sigma_{t-1}^{2}(\boldsymbol{x}_{t} + \boldsymbol{\xi}) p(\boldsymbol{\xi}) d\boldsymbol{\xi} \leq \sum_{t=1}^{T} \sigma_{t-1}^{2}(\boldsymbol{x}_{t} + \boldsymbol{\xi}_{t}) p(\boldsymbol{\xi}_{t}) \leq R \sum_{t=1}^{T} \sigma_{t-1}^{2}(\boldsymbol{x}_{t} + \boldsymbol{\xi}_{t}).$$

Thus, we get

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le 2\alpha \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + (1 - \alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + (1 - \alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + (1 - \alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + (1 - \alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + (1 - \alpha) \sqrt{8T \tilde{B} \beta_T^{1/2} R \sum_{t=1}^{T} \sigma_{t-1}(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 20T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2(\boldsymbol{x}_t + \boldsymbol{\xi}_t) + 2T \beta_T R \sum_{t=1}^{T} \sigma_{t-1}^2($$

and

$$\sum_{t=1}^{T} \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} \le \alpha \beta_T^{1/2} R \sqrt{C_1 T \gamma_T} + (1 - \alpha) \sqrt{4T \tilde{B} R \beta_T^{1/2} \sqrt{C_1 T \gamma_T} + 5T \beta_T R C_1 \gamma_T}$$

By using the same argument as in the proof of 4.1, we obtain the following inequality:

$$G(\boldsymbol{x}^*) - G(\hat{\boldsymbol{x}}_T) \le \sum_{t=1}^T \left\{ u_t^{(G)}(\boldsymbol{x}_t) - l_t^{(G)}(\boldsymbol{x}_t) \right\} / T.$$

Therefore, we get the desired result.

D Extension to Continuous Set

In this section, we consider the setting where \mathcal{X} is a continuous set. First, in MT-MVA-BO, $\boldsymbol{x}_t = \operatorname{argmax}_{\boldsymbol{x} \in \mathcal{X}} \boldsymbol{u}_t^{(G)}(\boldsymbol{x})$ can be calculated by using a continuous optimization solver. However, in MO-MVA-BO, it is difficult to calculate the estimated Pareto set $\hat{\Pi}_t$ and set of latent optimal solutions M_t . In this paper, based on [5] we extend the proposed algorithm by using a discretization set $\tilde{\mathcal{X}}$ of \mathcal{X} .

Hereafter, let $\mathcal{X} = [0,1]^{d_1}$. Furthermore, assume that f is an L-Lipschitz continuous function, i.e., there exists L > 0 such that

$$|f(x, w) - f(x', w)| \le L ||x - x'||_1,$$

for any $x, x' \in \mathcal{X}$. Note that Lipschitz continuity holds if standard kernels are used [24, 31].

From Lipschitz continuity of f, the following lemmas about F_1 and F_2 hold:

Lemma D.1. Let f be an L-Lipschitz continuous function. Then, it holds that

$$|F_1(x) - F_1(x')| \le L ||x - x'||_1, \ \forall x, x' \in \mathcal{X}_s$$

where F_1 is given by (5).

Proof. From the definition of F_1 and Lipschitz continuity of f, the following inequality holds:

$$egin{aligned} |F_1(oldsymbol{x}) - F_1(oldsymbol{x}')| &= \left| \int_\Omega \left\{ f(oldsymbol{x},oldsymbol{w}) - f(oldsymbol{x}',oldsymbol{w})
ight\} p(oldsymbol{w}) \mathrm{d}oldsymbol{w} \ &\leq \int_\Omega |f(oldsymbol{x},oldsymbol{w}) - f(oldsymbol{x}',oldsymbol{w})| p(oldsymbol{w}) \mathrm{d}oldsymbol{w} \ &\leq L \|oldsymbol{x} - oldsymbol{x}'\|_1. \end{aligned}$$

Lemma D.2. Let f be an L-Lipschitz continuous function, $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|$, and define F_2 as in (5). Then, the following inequality holds for any $\boldsymbol{x}, \boldsymbol{x}' \in \mathcal{X}$:

$$|F_2(\boldsymbol{x}) - F_2(\boldsymbol{x}')| \le \sqrt{4\tilde{B}L\|\boldsymbol{x} - \boldsymbol{x}'\|_1}.$$

Proof. From Lipschitz continuity of f, for any $\boldsymbol{x}, \boldsymbol{x}' \in \mathcal{X}, \boldsymbol{w} \in \Omega$, it holds that

 $\begin{aligned} \left| \{f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \}^{2} - \{f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \}^{2} \right| \\ &= \left| \{f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \} - \{f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \} \right| \times \left| \{f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \} + \{f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \} \right| \\ &\leq \left(|f(\boldsymbol{x}, \boldsymbol{w}) - f(\boldsymbol{x}', \boldsymbol{w})| + |\mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \right| \right) \times \left(|f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] + |f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \right| \right) \\ &\leq 2L \|\boldsymbol{x} - \boldsymbol{x}'\|_{1} \times 2\tilde{B} \\ &= 4\tilde{B}L\|\boldsymbol{x} - \boldsymbol{x}'\|_{1}. \end{aligned}$

Here, if $F_2(\boldsymbol{x}) \geq F_2(\boldsymbol{x}')$, then

$$\begin{aligned} &|F_{2}(\boldsymbol{x}) - F_{2}(\boldsymbol{x}')| \\ = F_{2}(\boldsymbol{x}) - F_{2}(\boldsymbol{x}') \\ = \sqrt{\int_{\Omega} \left\{ f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \right\}^{2} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} - \sqrt{\int_{\Omega} \left\{ f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \right\}^{2} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} \\ \leq \sqrt{\int_{\Omega} \left\{ f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \right\}^{2} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} - \int_{\Omega} \left\{ f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \right\}^{2} p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} \\ \leq \sqrt{\int_{\Omega} \left| \left\{ f(\boldsymbol{x}', \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}', \boldsymbol{w})] \right\}^{2} - \left\{ f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})] \right\}^{2} \left| p(\boldsymbol{w}) \mathrm{d}\boldsymbol{w}} \\ \leq \sqrt{4\tilde{B}L \|\boldsymbol{x} - \boldsymbol{x}'\|_{1}}. \end{aligned}$$

On the other hand, if $F_2(\boldsymbol{x}) < F_2(\boldsymbol{x}')$, it holds that $|F_2(\boldsymbol{x}) - F_2(\boldsymbol{x}')| \le \sqrt{4\tilde{B}L\|\boldsymbol{x} - \boldsymbol{x}'\|_1}$. Therefore, for any $\boldsymbol{x}, \boldsymbol{x}' \in \mathcal{X}$, the desired inequality holds.

Moreover, the following lemma holds:

Lemma D.3. Let Z be the Pareto front for \mathcal{X} , and let $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)^{\top}$ be a positive vector. Define

$$Z^{+} = \bigcup_{(y_1, y_2) \in Z} (-\infty, y_1] \times (-\infty, y_2], \ Z^{-}(\boldsymbol{\epsilon}) = \bigcup_{(y_1, y_2) \in Z} (-\infty, y_1 - \epsilon_1) \times (-\infty, y_2 - \epsilon_2),$$
$$Z^{*}(\boldsymbol{\epsilon}) = \{(y_1 - \epsilon'_1, y_2 - \epsilon'_2) \mid (y_1, y_2) \in Z, \ 0 \le \epsilon'_1 \le \epsilon_1, 0 \le \epsilon'_2 \le \epsilon_2\}.$$

Then, it holds that

$$Z^+ = Z^-(\epsilon) \cup Z^*(\epsilon), \ Z^-(\epsilon) \cap Z^*(\epsilon) = \emptyset.$$

Proof. First, we show $Z^{-}(\epsilon) \cap Z^{*}(\epsilon) = \emptyset$. Let \boldsymbol{y} be an element of $Z^{-}(\epsilon)$. Then, there exists $(y'_{1}, y'_{2}) \in Z$ such that

$$y_1 < y'_1 - \epsilon_1, \ y_2 < y'_2 - \epsilon_2.$$

Here, for any $(y_1'', y_2'') \in \mathbb{Z}, y_1''$ satisfies $y_1' \leq y_1''$ or $y_1' > y_1''$. If $y_1' \leq y_1''$, from $y_1 < y_1' - \epsilon_1$ we get

$$\boldsymbol{y} \notin \{ (y_1'' - \epsilon_1', y_2'' - \epsilon_2') \mid 0 \le \epsilon_1' \le \epsilon_1, 0 \le \epsilon_2' \le \epsilon_2 \}.$$

On the other hand, if $y'_1 > y''_1$, then y''_2 satisfies $y'_2 \le y''_2$ because the inequality $y'_2 > y''_2$ implies that $(y''_1, y''_2) \in (-\infty, y'_1) \times (-\infty, y'_2)$. However, it contradicts that $(y''_1, y''_2) \in Z$. From $y'_2 \le y''_2$ and $y_2 < y'_2 - \epsilon_2$, we have

$$\boldsymbol{y} \notin \{ (y_1'' - \epsilon_1', y_2'' - \epsilon_2') \mid 0 \le \epsilon_1' \le \epsilon_1, 0 \le \epsilon_2' \le \epsilon_2 \}.$$

Therefore, it holds that $y \notin Z^*(\epsilon)$. This implies that $Z^-(\epsilon) \cap Z^*(\epsilon) = \emptyset$.

Next, we show $Z^+ = Z^-(\epsilon) \cup Z^*(\epsilon)$. It is clear that $Z^+ \supset Z^-(\epsilon) \cup Z^*(\epsilon)$. Thus, we only show that $Z^+ \subset Z^-(\epsilon) \cup Z^*(\epsilon)$. Let \boldsymbol{y} be an element of Z^+ . If $\boldsymbol{y} \in Z^-(\epsilon)$, it holds that $\boldsymbol{y} \in Z^-(\epsilon) \cup Z^*(\epsilon)$. On the other hand, if $\boldsymbol{y} \notin Z^-(\epsilon)$, at least one of the following inequalities holds for any $(y'_1, y'_2) \in Z$:

$$y_1 \ge y_1' - \epsilon_1, \ y_2 \ge y_2' - \epsilon_2.$$

If there exists $\epsilon'_1 \in [0, \epsilon_1]$ such that $(y_1 + \epsilon'_1, y_2) \in Z$, then $\mathbf{y} \in Z^*(\boldsymbol{\epsilon})$. Next, we consider the case that $(y_1 + \epsilon'_1, y_2) \notin Z$ for any $\epsilon'_1 \in [0, \epsilon_1]$. Let $Z' = \{\mathbf{a} = (a_1, a_2) \in Z \mid y_1 \leq a_1 \leq y + \epsilon_1\}$. Here, assume that $y_2 < a_2 - \epsilon_2$ for any $\mathbf{a} \in Z'$. Then, from continuity of Z, there exists $\hat{\mathbf{y}} = (\hat{y}_1, \hat{y}_2) \in Z$ such that $y_1 < \hat{y}_1 - \epsilon_1$ and $y_2 < \hat{y}_2 - \epsilon_2$. However, it contradicts $\mathbf{y} \notin Z^-(\boldsymbol{\epsilon})$. Hence, there exists an element $\mathbf{a} = (a_1, a_2) \in Z'$ such that $y_2 \geq a_2 - \epsilon_2$. Moreover, there exists $b \geq y_2$ such that $(y_1, b) \in Z$. This implies that there exist $\tilde{\epsilon}_1$ and $\tilde{\epsilon}_2$ such that $0 \leq \tilde{\epsilon}_1 \leq \epsilon_1, 0 \leq \tilde{\epsilon}_2 \leq \epsilon_2$ and $(y_1 + \tilde{\epsilon}_1, y_2 + \tilde{\epsilon}_2) \in Z$. Therefore, it holds that $\mathbf{y} \in Z^*(\boldsymbol{\epsilon})$.

Next, we explain the method of constructing $\tilde{\mathcal{X}}$. Let $\tilde{\mathcal{X}}$ be a set of grid points when each dimension of $\mathcal{X} = [0, 1]^{d_1}$ is divided into τ evenly spaced segments. Also let $[x] \in \tilde{\mathcal{X}}$ be a point closest to $x \in \mathcal{X}$ with respect to the L1-distance. Then, it holds that

$$\|\boldsymbol{x} - [\boldsymbol{x}]\|_1 \le \frac{d_1}{\tau}, \ \forall \boldsymbol{x} \in \mathcal{X}.$$
(41)

In the proposed algorithm for the continuous set setting, Algorithm 2 is performed by using $\hat{\mathcal{X}}$ instead of \mathcal{X} . Then, we define the estimated Pareto set $\hat{\Pi}_t$, latent Pareto set M_t and uncertain set U_t in Algorithm 2 as

$$\begin{split} \hat{\Pi}_t &= \left\{ \boldsymbol{x} \in \tilde{\mathcal{X}} \mid \forall \boldsymbol{x}' \in \tilde{E}_{t,\boldsymbol{x}}^{(\text{pes})}, \ \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}) \not\preceq \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}') \right\}, \ \tilde{E}_{t,\boldsymbol{x}}^{(\text{pes})} &= \{ \boldsymbol{x}' \in \tilde{\mathcal{X}} \mid \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}) \neq \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}') \}, \\ M_t &= \left\{ \boldsymbol{x} \in \tilde{\mathcal{X}} \setminus \hat{\Pi}_t \mid \forall \boldsymbol{x}' \in \hat{\Pi}_t, \ \boldsymbol{F}_t^{(\text{opt})}(\boldsymbol{x}) \not\preceq_{\boldsymbol{\epsilon}/2} \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}') \right\}, \\ U_t &= \left\{ \boldsymbol{x} \in \hat{\Pi}_t \mid \exists \boldsymbol{x}' \in \hat{\Pi}_t \setminus \{\boldsymbol{x}\}, \boldsymbol{F}_t^{(\text{pes})}(\boldsymbol{x}) + \boldsymbol{\epsilon}/2 \prec \boldsymbol{F}_t^{(\text{opt})}(\boldsymbol{x}') \right\}. \end{split}$$

Note that $\epsilon/2$, not ϵ is used to calculate \tilde{M}_t and \tilde{U}_t .

In the algorithm using \mathcal{X} , the following theorem holds:

Theorem D.1. Let $\tilde{B} = \max_{(\boldsymbol{x}, \boldsymbol{w}) \in (\mathcal{X} \times \Omega)} |f(\boldsymbol{x}, \boldsymbol{w}) - \mathbb{E}_{\boldsymbol{w}}[f(\boldsymbol{x}, \boldsymbol{w})]|$, and let $\delta \in (0, 1)$, $\boldsymbol{\epsilon} = (\epsilon_1, \epsilon_2)$ where $\epsilon_1 > 0$ and $\epsilon_2 > 0$. Define $\beta_t = \left(\sqrt{\ln \det(\boldsymbol{I}_t + \sigma^{-2}\boldsymbol{K}_t) + 2\ln\frac{3}{\delta}} + B\right)^2$ and $\tau = \max\left\{\frac{2Ld_1}{\epsilon_1}, \frac{16\tilde{B}Ld_1}{\epsilon_2^2}\right\}$. Then, the following (1) and (2) hold with probability at least $1 - \delta$:

(1) The algorithm terminates after at most T iterations, where T is the smallest positive integer satisfying

$$T^{-1}\beta_T^{1/2} \left(\sqrt{2TC_1\gamma_T} + C_2 \right) + T^{-1} \sqrt{2T\tilde{B}\beta_T^{1/2} \left(\sqrt{8TC_1\gamma_T} + 2C_2 \right)} + 5T\beta_T \left(C_1\gamma_T + 2C_2 \right) \le \min\{\epsilon_1, \epsilon_2\}/2.$$

Here, C_1 and C_2 are given by $C_1 = \frac{16}{\ln(1+\sigma^{-2})}$ and $C_2 = 16 \ln \frac{18}{\delta}$.

Proof. We omit the proof of (1) because its proof is the same as in the proof of Theorem 4.2. We only prove (2). From (41) and Lemma D.1–D.2, the following holds for any $x \in \mathcal{X}$:

$$|F_1(\boldsymbol{x}) - F_1([\boldsymbol{x}])| \le L \|\boldsymbol{x} - [\boldsymbol{x}]\|_1 = \frac{\epsilon_1}{2},$$
(42)

$$|F_{2}(\boldsymbol{x}) - F_{2}([\boldsymbol{x}])| \leq \sqrt{4\tilde{B}L\|\boldsymbol{x} - [\boldsymbol{x}]\|_{1}} \\ = \frac{\epsilon_{2}}{2}.$$
(43)

Assume that (13) holds. Let \tilde{Z} be a Pareto front for $\tilde{\mathcal{X}}$. Then, for any $\boldsymbol{y} \in \tilde{Z}$, it holds that

$$\boldsymbol{y} \in \bigcup_{(y_1', y_2') \in Z} (-\infty, y_1'] \times (-\infty, y_2'], \tag{44}$$

where Z is the Pareto front for \mathcal{X} . Similarly, let

$$Z^{-}(\boldsymbol{\epsilon}/2) = \bigcup_{(y_1',y_2')\in Z} (-\infty, y_1' - \epsilon_1/2) \times (-\infty, y_2' - \epsilon_2/2).$$

Then, for any $\mathbf{y}'' \in Z^{-}(\boldsymbol{\epsilon}/2)$, there exists $\mathbf{x} \in \mathcal{X}$ such that

$$y_1'' < F_1(\boldsymbol{x}) - \epsilon_1/2, \ y_2'' < F_2(\boldsymbol{x}) - \epsilon_2/2.$$

Here, from (42) and (43) we have

$$F_1(\mathbf{x}) \le F_1([\mathbf{x}]) + \epsilon_1/2, F_2(\mathbf{x}) \le F_2([\mathbf{x}]) + \epsilon_2/2.$$

Thus, it holds that $y_1'' < F_1([\boldsymbol{x}])$ and $y_2'' < F_2([\boldsymbol{x}])$. This implies that

$$Z^{-}(\epsilon/2) \subset \{ \boldsymbol{y} \in \mathbb{R} \mid \exists \boldsymbol{x} \in \tilde{\mathcal{X}}, \ \boldsymbol{y} \preceq \boldsymbol{F}(\boldsymbol{x}) \} \equiv A.$$

Here, since $Z^{-}(\epsilon/2)$ is the open set, noting that $Z^{-}(\epsilon/2) \subset A$ we get $Z^{-}(\epsilon/2) \subset \operatorname{int}(A)$, where $\operatorname{int}(A)$ is the interior of A. In addition, from the definition of the interior and boundary (frontier), we obtain $\operatorname{int}(A) \cap \partial A = \emptyset$. Therefore, from $\partial A = \tilde{Z}$ and $Z^{-}(\epsilon/2) \subset \operatorname{int}(A)$, it holds that $Z^{-}(\epsilon/2) \cap \tilde{Z} = \emptyset$. Hence, for any $\mathbf{y} \in \tilde{Z}$, $\mathbf{y} \notin Z^{-}(\epsilon/2)$. Thus, by using this and (44), from Lemma D.3, it holds that

$$\tilde{Z} \subset Z^*(\epsilon/2).$$

Hence, for any $\boldsymbol{y} \in \tilde{Z}$, there exists $\boldsymbol{a} \in Z$ such that

$$y_1 = a_1 - \epsilon'_1, y_2 = a_2 - \epsilon'_2, \quad 0 \le \epsilon'_1 \le \epsilon_1/2, \ 0 \le \epsilon'_2 \le \epsilon_2/2.$$
 (45)

Furthermore, from Theorem 4.2, for any $\boldsymbol{x} \in \hat{\Pi}_t$, there exists $\boldsymbol{y}^{\dagger} \in \tilde{Z}$ such that

$$y_1^{\dagger} \leq F_1(\boldsymbol{x}) + \epsilon_1/2, \ y_2^{\dagger} \leq F_2(\boldsymbol{x}) + \epsilon_2/2.$$

By combining this and (45), we get

$$a_1 = y_1^{\dagger} + \epsilon_1' \le F_1(\boldsymbol{x}) + \epsilon_1/2 + \epsilon_1' \le F_1(\boldsymbol{x}) + \epsilon_1,$$

$$a_2 = y_2^{\dagger} + \epsilon_2' \le F_2(\boldsymbol{x}) + \epsilon_2/2 + \epsilon_2' \le F_2(\boldsymbol{x}) + \epsilon_2.$$

Therefore, we have $\boldsymbol{F}(\hat{\Pi}_t) \subset Z_{\boldsymbol{\epsilon}}$.

Furthermore, let $\boldsymbol{x} \in \Pi$. For $[\boldsymbol{x}] \in \tilde{\mathcal{X}}$, since $\hat{\Pi}_t$ is the $(\epsilon/2)$ -accurate Pareto set for $\tilde{\mathcal{X}}$, there exists $\boldsymbol{x}' \in \hat{\Pi}_t$ such that $\boldsymbol{F}([\boldsymbol{x}]) \preceq_{\epsilon/2} \boldsymbol{F}(\boldsymbol{x}')$. Moreover, form (42) and (43), it holds that $\boldsymbol{F}(\boldsymbol{x}) \leq \boldsymbol{F}([\boldsymbol{x}]) + \epsilon/2$. This implies that $\boldsymbol{F}(\boldsymbol{x}) \preceq \boldsymbol{F}([\boldsymbol{x}]) + \epsilon/2 \preceq \boldsymbol{F}(\boldsymbol{x}') + \epsilon$. Therefore, for any $\boldsymbol{x} \in \Pi$, there exits $\boldsymbol{x}' \in \hat{\Pi}_t$ such that $\boldsymbol{x} \preceq_{\epsilon} \boldsymbol{x}'$. Thus, $\hat{\Pi}_t$ is the ϵ -accurate Pareto set for \mathcal{X} .
