# Internal dynamics of multibody systems ${ }^{\star}$

#### Abstract

We consider nonlinear multibody systems and present a suitable set of coordinates for the internal dynamics which allow to decouple the internal dynamics without the need to compute the Byrnes-Isidori form. Furthermore, we derive sufficient conditions for the system parameters such that the internal dynamics of a class of systems with constant mass matrix are bounded-input, bounded-output stable.


Keywords: internal dynamics; multibody systems; bounded-input, bounded-output stability

## 1. Introduction

In the last two decades it turned out that for the purpose of high-gain based output tracking the so called funnel controller developed in [1] and generalized to nonlinear systems with arbitrary relative degree in [2] is a powerful tool. However, both necessitate stability of the internal dynamics in a certain sense. Although there is progress in tracking control of systems with unstable internal dynamics, see e.g. [3, 4, 5, 6], most controllers require the internal dynamics to be bounded-input, bounded-output stable (minimum phase property), c.f. [7, 8, 9, 10, 1, 11, 2, 12, 13] and see also the survey [14], and for a detailed introduction to the concept of minimum phase [15], and the references therein, resp. Therefore, in order to verify applicability of a certain controller it is necessary to decouple the internal dynamics, e.g. via the Byrnes-Isidori form as in [16], and investigate its stability. However, the computation of the Byrnes-Isidori form of a nonlinear multibody system is often a challenging task. In the present work we combine the idea of the Byrnes-Isidori form with a novel approach to decouple the internal dynamics without the need to compute the Byrnes-Isidori form explicitly. This results in a representation of the internal dynamics in terms of the internal variables and the system's output.
Moreover, we present sufficient conditions on the system parameters such that the internal dynamics are boundedinput, bounded-output stable. These conditions are independent of the representation of the internal dynamics and can be verified without their explicit decoupling. Hence, applicability of a controller e.g as in [17, 12, 2] can be determined without decomposing the system but by investigation of the system's equations only.
This paper is organized as follows. We briefly recall the

[^0]concepts of Lie derivatives, relative degree and the representation of a dynamical system in Byrnes-Isidori form in Section 2. In Section 3 we derive the representation of the internal dynamics in terms of the internal variables and the system's output. Furthermore, we give lemmata of existence and uniqueness, resp., concerning the novel structural ansatz for the internal dynamics. In Section 4 we give an abstract stability result exploiting LaSalle's invariance principle presented in [18]. Furthermore, we consider nonlinear multibody systems without kinematic loop and provide sufficient conditions on the system parameters such that the internal dynamics are bounded-input, bounded-output stable. We finish this paper with two illustrative examples in Section 5

### 1.1. Nomenclature

## 2. System class, relative degree and Byrnes-Isidori form

In this section we briefly recall some basic concepts such as relative degree and the representation of a system in Byrnes-Isidori form. We consider nonlinear multibody systems without kinematic loops which are modeled using
generalized coordinates and are of the form

where $M \in \mathcal{C}\left(\mathbb{R}^{n} \rightarrow \mathbf{G l}_{n}(\mathbb{R})\right)$ is the generalized mass matrix, $f \in \mathcal{C}\left(\mathbb{R}^{n} \times \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}\right)$ are the generalized forces, $B \in \mathcal{C}\left(\mathbb{R}^{n} \rightarrow \mathbb{R}^{n \times m}\right)$ is the distribution of the input and $h \in \mathcal{C}^{1}\left(\mathbb{R}^{n} \rightarrow \mathbb{R}^{m}\right)$ is the measurement. The functions $u: \mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{m}$ are the inputs that exert an influence to system (1), and $y: \mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{m}$ are the outputs that typically represent physically meaningful measurements of system (1). Note, that the dimensions of the input and output coincide but we do not assume collocation, i.e., we do not assume $h^{\prime}(q)=B(q)^{\top}$. For system (1) we introduce the state variables $x_{1}:=q, x_{2}:=v$, setting $x:=\left(x_{1}^{\top}, x_{2}^{\top}\right)^{\top}$, and transform (1) into the system of first order ordinary differential equations

where $\tilde{h}: \mathbb{R}^{2 n} \rightarrow \mathbb{R}^{m}$ with $\tilde{h}\left(x_{1}, x_{2}\right)=h\left(x_{1}\right)$. In order to decouple the internal dynamics we invoke the ByrnesIsidori form for (2). To this end, recall the definition of the Lie derivative of a function $h$ along a vector field $F$ at a point $z \in U \subseteq \mathbb{R}^{2 n}, U$ open

where $\tilde{h}^{\prime}$ is the Jacobian of $\tilde{h}$. We may successively define $L_{F}^{k} \tilde{h}=L_{F}\left(L_{F}^{k-1} \tilde{h}\right)$ with $L_{F}^{0} \tilde{h}=\tilde{h}$. We denote with $g_{i}(z)$ the columns of $G(z)$ for $i=1, \ldots, m$ and define

In accordance with [16, Sec. 5.1] we recall the concept of (strict) relative degree for multi-input, multi-output systems.
Definition 2.1. System (2) has relative degree $r \in \mathbb{N}$ on $U \subseteq \mathbb{R}^{2 n}$ open, if for all $z \in U$ we have

where $\tilde{\Gamma}: U \rightarrow \mathbf{G l}_{m}(\mathbb{R})$ is the high-gain matrix.
Now, if system (2) has relative degree $r$ on an open set $U \subseteq \mathbb{R}^{2 n}$, then there exists a (local) diffeomorphism $\Phi: U \rightarrow W \subseteq \mathbb{R}^{2 n}, W$ open, such that

with $\xi(t) \in \mathbb{R}^{r m}, \eta(t) \in \mathbb{R}^{2 n-r m}$ transforms system 2 nonlinearly into Byrnes-Isidori form

The last equation in (4) represents the internal dynamics of system (2). Note, that for $r \cdot m<2 n$ system (2) has nontrivial interal dynamics.

With the aid of Lie derivatives the diffeomorphism $\Phi$ can be represented as

where $\tilde{\phi}_{i}: U \rightarrow \mathbb{R}, i=1, \ldots, 2 n-r m$, are such that $\Phi^{\prime}(x)$ is invertible for all $x \in U$. We recall $x=\left(x_{1}^{\top}, x_{2}^{\top}\right)^{\top} \in \mathbb{R}^{2 n}$ and make the following assumption.
(A1) Given some open set $U_{1} \subseteq \mathbb{R}^{n}$ and $H\left(x_{1}\right):=h^{\prime}\left(x_{1}\right)$, we have $\Gamma\left(x_{1}\right):=H\left(x_{1}\right) M\left(x_{1}\right)^{-1} B\left(x_{1}\right) \in \mathbf{G l}_{m}(\mathbb{R})$ for all $x_{1} \in U_{1}$.

Lemma 2.2. Consider system (2) and assume (A1). Then system (2) has relative degree $r=2$ on $U:=U_{1} \times \mathbb{R}^{n}$.

Proof. Let $x=\left(x_{1}^{\top}, x_{2}^{\top}\right)^{\top} \in U$. Set $H\left(x_{1}\right):=h^{\prime}\left(x_{1}\right)$ and $\tilde{H}(x):=\tilde{h}^{\prime}(x)$, then $H(x)=\left[\begin{array}{ll}H\left(x_{1}\right) & 0\end{array}\right]$. Now, compute the Lie derivatives of 2 for $x \in U$

where $\Gamma\left(x_{1}\right)=H\left(x_{1}\right) M\left(x_{1}\right)^{-1} B\left(x_{1}\right)$ is invertible by assumption (A1) Therefore, according to (3) system (2) has relative degree $r=2$ on $U$.

## 3. Representation of the internal dynamics

In this section we introduce a novel structural ansatz for the internal dynamics and present a set of feasible coordinates to represent the internal dynamics of (2) without the need to compute the Byrnes-Isidori form explicitly. We show the existence and feasibility of functions forming the novel representation of the internal dynamics in Lemma 3.1, and provide a particular choice and show its uniqueness in Lemma 3.2 . At the end of this section we present a representation of the internal dynamics which is completely determined by the system parameters.

Via (5) with $r=2$ we obtain the following representation of the diffeomorphism $\Phi$

where $\tilde{\phi}_{i}: U \rightarrow \mathbb{R}, i=1, \ldots, 2 n-2 m$ and, as in Lemma 2.2 , $U_{1} \subseteq \mathbb{R}^{n}$ is an open set and $U=U_{1} \times \mathbb{R}^{n}$.
We make the following structural ansatz for the internal state $\eta=\left(\tilde{\phi}_{1}(x), \ldots, \tilde{\phi}_{2 n-2 m}(x)\right)^{\top}$

where $\phi_{1} \in \mathcal{C}^{1}\left(U_{1} \rightarrow \mathbb{R}^{n-m}\right)$ and $\phi_{2} \in \mathcal{C}\left(U_{1} \rightarrow \mathbb{R}^{(n-m) \times n}\right)$. We highlight, that

and (6) have similar structure, i.e., the internal dynamics are in the form of a mechanical system as well. Now, since $\Phi$ is a diffeomorphism we require its Jacobian to be invertible on $U$

where $*$ is of the form $\frac{\partial}{\partial x_{1}}\left[\zeta\left(x_{1}\right) \cdot x_{2}\right], \zeta: U_{1} \rightarrow \mathbb{R}^{q \times n}$ with $q \in \mathbb{N}$ appropriate, resp.
We aim to investigate the internal dynamics of (2) without explicit appearance of the input $u$. To this end, we seek for functions $\tilde{\phi}_{1}(x), \ldots, \tilde{\phi}_{2 n-2 m}(x)$ such that $p(\cdot)=0$ in equation (4), i.e., $\left[L_{G} \tilde{\phi}_{i}\right](x)=0$ for all $x \in U, i=1, \ldots, 2 n-2 m$. In view of (6) this means to find functions $\phi_{1}, \phi_{2}$ such that

In the following lemma we show the existence of functions $\phi_{1}, \phi_{2}$ satisfying the aforesaid.

Lemma 3.1. Consider the $O D E$ (2) and assume (A1). For any $x_{1}^{0} \in U_{1}$ there exist an open neighbourhood $U_{1}^{0} \subseteq$ $U_{1}$ of $x_{1}^{0}$ and $\phi_{1} \in \mathcal{C}^{1}\left(U_{1}^{0} \rightarrow \mathbb{R}^{n-m}\right), \phi_{2} \in \mathcal{C}\left(U_{1}^{0} \rightarrow\right.$ $\mathbb{R}^{(n-m) \times n}$ ) such that (8) and (9) hold locally on $U_{1}^{0}$.
Proof. We fix $x_{1}^{0} \in U_{1}$ and make use of [19, Lem. 4.1.5] which states the following. Consider $W \in \mathcal{C}\left(U_{1} \rightarrow \mathbb{R}^{w \times n}\right)$ with $\operatorname{rk} W\left(x_{1}\right)=w$ for all $x_{1} \in U_{1}$. Then there exist an open neighbourhood $V_{1} \subseteq U_{1}$ of $x_{1}^{0}$ and $T \in \mathcal{C}\left(V_{1} \rightarrow\right.$ $\left.\mathbf{G l}_{n}(\mathbb{R})\right)$ such that

We use this to show the existence of $\phi_{1} \in \mathcal{C}^{1}\left(U_{1}^{0} \rightarrow \mathbb{R}^{n-m}\right)$. Since by assumption (A1) we have $\operatorname{rk} H\left(x_{1}\right)=m$ for all $x_{1} \in U_{1}$ there exist an open neighbourhood $V_{1} \subseteq U_{1}$ of $x_{1}^{0}$ and $T=\left[T_{1}, T_{2}\right] \in \mathcal{C}\left(V_{1} \rightarrow \mathbf{G l}_{n}(\mathbb{R})\right)$ such that

Let $E=\left[e_{i_{1}}^{\top}, \ldots, e_{i_{n-m}}^{\top}\right]^{\top} \in \mathbb{R}^{(n-m) \times n}$ with $e_{i_{j}} \in \mathbb{R}^{1 \times n}$ a unit row-vector for $i_{j} \in\{1, \ldots, n\}$. Then

Since $\operatorname{rk} T_{2}\left(x_{1}^{0}\right)=n-m$ it is possible to choose $i_{1}, \ldots, i_{n-m}$ such that $E T_{2}\left(x_{1}^{0}\right) \in \mathbf{G} \mathbf{l}_{n-m}(\mathbb{R})$. As $T_{2} \in \mathcal{C}\left(V_{1} \rightarrow \mathbb{R}^{n \times(n-m)}\right)$ the mapping $x_{1} \mapsto \operatorname{det}\left(E T_{2}\left(x_{1}\right)\right)$ is continuous on $V_{1}$, hence there exists an open neighbourhood $\bar{V}_{1} \subseteq V_{1}$ of $x_{1}^{0}$ such that $\operatorname{det}\left(E T_{2}\left(\bar{x}_{1}\right)\right) \neq 0$ for all $\bar{x}_{1} \in \bar{V}_{1}$. Thus,

Now, we show the existence of $\phi_{2} \in \mathcal{C}\left(U_{1}^{0} \rightarrow \mathbb{R}^{n-m}\right)$. Observe that by assumption (A1) we have rk $B\left(x_{1}\right)=m$ and rk $M\left(x_{1}\right)=n$ for all $x_{1} \in U_{1}$. Therefore, again via 19 , Lem. 4.1.5], there exist an open neighbourhood $\tilde{V}_{1} \subseteq U_{1}$ of $x_{1}^{0}$ and $T=\left[T_{1}, T_{2}\right] \in \mathcal{C}\left(\tilde{V}_{1} \rightarrow \mathbf{G l}_{n}(\mathbb{R})\right)$ such that

\end{array}\right] \in \mathbb{R}^{n \times n}, x_{1} \in \tilde{V}_{1}
\end{aligned}

which is invertible on $\tilde{V}_{1}$ since by assumption (A1) the high-gain matrix $\Gamma\left(x_{1}\right)$ is invertible on $U_{1}$, and $\operatorname{rk} T_{2}\left(x_{1}\right)=$ $n-m$ for all $x_{1} \in \tilde{V}_{1}$. Hence the second condition in (8) is satisfied on $\tilde{V}_{1}$. Moreover, equation (9) is true on $\tilde{V}_{1}$ by construction of $\phi_{2}$. We set $U_{1}^{0}:=\bar{V}_{1} \cap V_{1}$ which completes the proof.

The proof of the previous lemma justifies the structural ansatz for the internal state $\eta$ in (6). Hereinafter let $U_{1}=U_{1}^{0}$ with $U_{1}^{0}$ as in Lemma 3.1.
While $\phi_{1}$ can basically be chosen freely up to (8), $\phi_{2}$ is uniquely determined up to an invertible left transformation. To find all possible representations, let $P: U_{1} \rightarrow$ $\mathbb{R}^{n \times m}$ and $V: U_{1} \rightarrow \mathbb{R}^{n \times(n-m)}$ be such that

which exist by (8). Then $P, V$ have pointwise full column rank, by which the pseudoinverse of $V$ is given by $V^{\dagger}\left(x_{1}\right)=$ $\left(V\left(x_{1}\right)^{\top} V\left(x_{1}\right)\right)^{-1} V\left(x_{1}\right)^{\top}, x_{1} \in U_{1}$. For $x_{1} \in U_{1}$ we define
$\phi_{2}\left(x_{1}\right):=V^{\dagger}\left(x_{1}\right)\left(I_{n}-M\left(x_{1}\right)^{-1} B\left(x_{1}\right) \Gamma\left(x_{1}\right)^{-1} H\left(x_{1}\right)\right)$.

Lemma 3.2. We use the notation and assumptions from Lemma 3.1. Then the function $\phi_{2}: U_{1} \rightarrow \mathbb{R}^{(n-m) \times n}$ is uniquely determined by (8) and (9) up to an invertible left transformation. All possible functions are given by 11) for feasible choices of $V$ satisfying 10.
Proof. Assume that (8) and (9) hold, and hence we have 10 for some corresponding $P$ and $V$. We multiply (10) from the left by $V\left(x_{1}\right)^{\dagger}$ and subtract $V\left(x_{1}\right)^{\dagger} P\left(x_{1}\right) H\left(x_{1}\right)$ from both sides, and obtain

Hence, the representation of $\phi_{2}$ in (11) only depends on the choice of the basis of ker $H\left(x_{1}\right)$. Now, let $\tilde{V}\left(x_{1}\right):=V\left(x_{1}\right) R\left(x_{1}\right), x_{1} \in U_{1}$, for some $R: U_{1} \rightarrow \mathbf{G l}_{n-m}$ and consider

Now, we continue deriving a representation of the internal dynamics. We choose $V \in \mathcal{C}\left(U_{1} \rightarrow \mathbb{R}^{n-m}\right)$ with orthonormal columns such that $\operatorname{im} V\left(x_{1}\right)=\operatorname{ker} H\left(x_{1}\right)$ for all $x_{1} \in U_{1}$. Then via (A1) and (11) the inverse of $\left[\begin{array}{l}H\left(x_{1}\right) \\ \phi_{2}\left(x_{1}\right)\end{array}\right]$ is given by

Then for $\varphi: U_{1} \rightarrow \mathbb{R}^{n}$ defined as in we find that

To combine $\sqrt{15}$ with $\sqrt{14}$ we define the following functions on $W_{1}:=\varphi\left(U_{1}\right)$ as concatenations

Therefore, identifying $\xi_{1}=y$ we obtain a representation of (14) as the first equation in (17). Now, we explore the dynamics of $\eta_{2}$. Define $\phi_{2}^{\prime}\left[x_{1}, x_{2}\right]:=\frac{\partial}{\partial x_{1}}\left[\phi_{2}\left(x_{1}\right) \cdot x_{2}\right] \in$ $\mathbb{R}^{(n-m) \times n}$ for $x=\left(x_{1}^{\top}, x_{2}^{\top}\right)^{\top} \in U_{1} \times \mathbb{R}^{n}=U$. Then from (2) and (6) we obtain for $x \in U$

Then, as the first main result of the present article, the internal dynamics of (2) are given in 17).

Remark 3.4. The set of variables presented in this section to decouple the internal dynamics of (2) offers an alternative to the Byrnes-Isidori form as in ( $\overline{4}$ ), whose computation often requires a lot of effort. The advantage of the representation of the internal dynamics in $\sqrt[17 \text { ) is, that it }]{ }$ involves only system parameters. Lemma 3.2 shows, that a suitable choice of V is given by $\operatorname{im} V\left(x_{1}\right)=\operatorname{ker} H\left(x_{1}\right)$, and solving (16) for $x_{1}$ only involves $h\left(x_{1}\right)$, where the choice $\phi_{1}\left(x_{1}\right)=E x_{1}$ as in the proof of Lemma 3.1 may simplify the computation further. We stress, that once $\phi_{1}$ is chosen, e.g. $\phi_{1}\left(x_{1}\right)=E x_{1}$, the computation of the internal dynamics of a system (2) can be carried out completely algorithmically without the need to choose further functions.

Remark 3.5. We may obtain further structure for the internal dynamics (17). Recall the concept of a conservative vector field. We call a vector field $J: U \rightarrow \mathbb{R}^{n}$, $U \subseteq \mathbb{R}^{n}$ open, conservative, if there exists a scalar field $j: \bar{U} \rightarrow \mathbb{R}$ such that $j^{\prime}(x)=J(x)^{\top}$ for all $x \in U$. Now, if there exist $j_{i} \in \mathcal{C}^{1}\left(U_{1} \rightarrow \mathbb{R}\right)$ such that $j_{i}^{\prime}\left(x_{1}\right)=\phi_{2, i}\left(x_{1}\right)^{\top}$ for all $x_{1} \in U_{1}, i=1, \ldots, n-m$, then it is possible to choose $\phi_{1}=\left(\lambda_{1} j_{1}, \ldots, \lambda_{n-m} j_{n-m}\right)^{\top}$ for some $\lambda_{i} \in \mathbb{R} \backslash\{0\}$, $i=1, \ldots, n-m$, and thus $\phi_{1}^{\prime}\left(x_{1}\right)=\Lambda \phi_{2}\left(x_{1}\right)$ for $\Lambda=$ $\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{n-m}\right)$. Therefore, using (9) and Lemma 3.2 the dynamics of $\eta_{1}$ in 17 reduce to

Note, that the entries of $\Lambda$ can be chosen at will. We will make use of this later in Section 4.2.

## 4. Stability of the internal dynamics

In this section we derive sufficient conditions on the system parameters of a certain class of systems with constant mass matrix, such that the internal dynamics are bounded-input, bounded-output stable. These conditions can be verified in advance and hence an explicit decoupling and stability analysis of the internal dynamics is not necessary; in particular, it is not necessary to derive 17.

### 4.1. Abstract stability result

Before we give conditions on $f$ in (2) to ensure a boundedinput, bounded-output stability of the internal dynamics (17) we present an abstract stability result. To this end, we make the following definitions.
Definition 4.1. Consider a dynamical control system

where $f \in \mathcal{C}\left(X \times \mathbb{R}^{m} \rightarrow \mathbb{R}^{n}\right), X \subseteq \mathbb{R}^{n}$ open, and $u \in$ $\mathcal{L}^{\infty}\left(\mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{m}\right)$. A local solution of 18) is a function $x \in \mathcal{C}^{1}\left([0, \omega) \rightarrow \mathbb{R}^{n}\right), \omega \in \mathbb{R}_{\geq 0}$ such that it satisfies on $[0, \omega)$ with $x(0)=x^{0} \in \overline{\mathbb{R}}^{n}$. If $\omega=\infty$ we call $x \in$ $\mathcal{C}^{1}\left(\mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{n}\right)$ a global solution.
Definition 4.2. We call a function $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ radially unbounded, if $f(x) \rightarrow \infty$ for $\|x\| \rightarrow \infty$.

Now, following [18, Thm. 4], we may formulate the second main result of the present paper as the following theorem.

Theorem 4.3. Let $U \subseteq \mathbb{R}^{n-m}$ be open and consider

where $\Psi \in \mathcal{C}\left(U \times \mathbb{R}^{m} \times \mathbb{R}^{m} \rightarrow \mathbb{R}^{n-m}\right)$. Assume there exist $r_{1}, r_{2}, r_{3}>0$ and a radially unbounded $\mathcal{V} \in \mathcal{C}^{1}(U \rightarrow \mathbb{R})$ such that for all $y_{1} \in B_{r_{1}}(0), y_{2} \in B_{r_{2}}(0)$ and for all $\zeta \in\left\{\zeta \in U \mid\|\zeta\|>r_{3}\right\}$ we have

Then for all $y_{1}, y_{2} \in \mathcal{L}^{\infty}\left(\mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{m}\right)$ with $\left\|y_{1}\right\|_{\infty} \leq r_{1}$ and $\left\|y_{2}\right\|_{\infty} \leq r_{2}$ and all global solutions $\zeta: \mathbb{R}_{\geq 0} \rightarrow U$ of 19) there exists $\varepsilon>0$ such that

$$

Proof. The following proof is inspired by the proof made in [18, Thm. 4], and some ideas are adopted from the proof in [19, Lem. 5.7.8]. Let $\tilde{r}:=\max \left\{\left\|\zeta^{0}\right\|, r_{3}\right\}$ and $\nu_{0}:=\max \{\mathcal{V}(\zeta) \mid\|\zeta\|=\tilde{r}\}$. Since $\mathcal{V}$ is radially unbounded there exists $\varepsilon>0$ such that $\mathcal{V}(\zeta)>\nu_{0}$ for all $\zeta \in\{\zeta \in$ $U \mid\|\zeta\| \geq \tilde{r}+\varepsilon\}$. Seeking a contradiction, we assume there exists $t_{1}$ such that $\left\|\zeta\left(t_{1}\right)\right\|>\tilde{r}+\varepsilon$. Let $t_{0}=\max \{t \in$ $\left.\left[0, t_{1}\right) \mid\|\zeta(t)\|=\tilde{r}\right\}$. Then we have $\mathcal{V}(\zeta(t))>\nu_{0}$ for all $t \in\left(t_{0}, t_{1}\right]$. Since by 20$) \mathcal{V}$ is nonincreasing along solution trajectories of 19 for all $y_{1}, y_{2} \in \mathcal{L}^{\infty}\left(\mathbb{R}_{\geq 0} \rightarrow \mathbb{R}^{m}\right)$ with $\left\|y_{1}\right\|_{\infty} \leq r_{1},\left\|y_{2}\right\|_{\infty} \leq r_{2}$ and $\|\zeta\|>r_{3}$ we have $\nu_{0}<\mathcal{V}\left(\zeta\left(t_{1}\right)\right) \leq \mathcal{V}\left(\zeta\left(t_{0}\right)\right) \leq \nu_{0}$. A contradiction. Therefore, we conclude $\|\zeta(t)\| \leq \tilde{r}+\varepsilon$ for all $t \geq 0$ and hence $\|\zeta\|_{\infty} \leq \tilde{r}+\varepsilon$.

### 4.2. Sufficient conditions for stability

In this section we consider a special class of nonlinear multibody systems, namely such systems with constant mass matrix, constant input distribution and a linear system output, and present sufficient conditions on the system parameters, i.e., on $f$ in (2), such that the internal dynamics are bounded-input, bounded-output stable.

Definition 4.4. Consider a control system (18) with output $y(t)=h(x(t))$, where $h \in \mathcal{C}^{1}\left(\mathbb{R}^{n} \rightarrow \mathbb{R}^{m}\right)$. We call a system 18 bounded-input, bounded-output stable, if there exist $C_{1}, C_{2} \geq 0$ such that

\|u\|_{\infty} \leq C_{1} \Rightarrow\|y\|_{\infty} \leq C_{2}
$$

Remark 4.5. In the context of the internal dynamics 17 of system (22) we actually consider bounded-input, boundedstate stability. As we add the output $z(t)=\eta(t)$ to system (17) we may refer to it as bounded-input, boundedoutput stable, where the output of system (22), namely $y(\cdot)$, and its derivative $\dot{y}(\cdot)$ play the role of the input of system 17.

Now, we consider a system (2) with constant mass ma$\operatorname{trix} M \in \mathbf{G l}_{n}(\mathbb{R})$ and constant input distribution $B \in$ $\mathbb{R}^{n \times m}$. Since in many applications the output function $y(\cdot)$ is linear, we assume $h$ to be linear, i.e., $h\left(x_{1}\right)=H \cdot x_{1}$ for all $x_{1} \in U_{1}$ with $H \in \mathbb{R}^{m \times n}$. Under these assumptions we have $U_{1}=\mathbb{R}^{n}$ and (A1) becomes $H M^{-1} B \in \mathbf{G l}_{m}(\mathbb{R})$, i.e., $\Gamma \in \mathbf{G l}_{m}(\mathbb{R})$. We revisit system (17) to obtain a simpler representation of the internal dynamics. First, we observe that since $H, M, B$ are constant matrices we have that

Furthermore, $\phi_{2}$ defines a conservative vector field and thus via Remark 3.5 we may choose $\phi_{1}\left(x_{1}\right)=\lambda \phi_{2} \cdot x_{1}, x_{1} \in \mathbb{R}^{n}$ and $\lambda \in \mathbb{R} \backslash\{0\}$. Moreover, since $h$ is linear we have $V \in \mathbb{R}^{n \times(n-m)}$ such that

With this we revisit system (2) and obtain the following control system

From this it is clear that conditions (27a)-27k) mean that the acting forces are assumed to be basically linear in a certain region, far away from the origin. Hence these are merely weak assumptions.
We set $\tau:=\|\Theta\|$ and for some $r_{1}, r_{2} \geq 0, q>0$ we define the following constants

As the third main result we present an explicit Lyapunov function for system 26 in the following theorem.
Theorem 4.6. Consider system (26) and fix $r_{1}, r_{2} \geq 0$, $0<\lambda<2 \kappa / \tau^{2}$ and $0<q<2 \delta /\left(d^{2}+2 \lambda\right)$. Assume conditions (27a) $-27 \mathrm{k})$ hold true for all $z_{i} \in Z_{i}, i=1,2$. Then for $\mathcal{V}: \mathbb{R}^{n-m} \times \mathbb{R}^{n-m} \rightarrow \mathbb{R}$ defined by

The proof is relegated to Appendix A.
Remark 4.7. The sets $Z_{i}$ in Theorem 4.6 are determined by the system parameters only and hence conditions (27a) (27k) can be verified without decoupling the internal dynamics.

Finally, we combine Theorem 4.3 and Theorem 4.6 to obtain a stability result for the internal dynamics 26 of system (24).

Theorem 4.8. Consider system (24) and use the assumptions from Theorem 4.6. Then the internal dynamics (26) of system (24) are bounded-input, bounded-output stable.

Proof. Clear.
Remark 4.9. Note, that since $\eta_{i} \notin Z_{i} \cap \tilde{Z}_{i}$ means $\left\|\eta_{i}\right\| \leq$ $\max \left\{z_{i}^{+}, E_{i} / \varepsilon_{i}, \gamma_{i}^{+}\right\}$, it is clear that the choice of $\lambda$ and $q$ in Theorem 4.6 does not effect the stability statement in Theorem 4.8 but only determines the region where (30) is true.

Remark 4.10. Since we require quite restrictive conditions for systems of the form (24) to provide sufficient condition on the system parameters to ensure boundedinput, bounded-output stability, we stress that a stability analysis of a given system can be performed analysing equations (17). In Example 5.1 we will decouple the internal dynamics of a nonlinear system, which does not belong to the class of systems (24). The resulting equations (34) are open to stability analysis, cf. [4, Sec. 4.3].

## 5. Examples

In this section we present two examples to illustrate the results of the present article. First, we consider a robotic manipulator arm with non-constant mass matrix and nonlinear equations of motion, in order to demonstrate the decoupling of the internal dynamics. Second, we consider an extension of the standard mass on a car system to illustrate how to check bounded-input, bounded-output stability of the internal dynamics without the need to decouple the internal dynamics explicitly.

### 5.1. Example: Robotic manipulator

In order to demonstrate the decoupling of the internal dynamics using the results from Secion 3, we consider a robotic manipulator arm as in [11, Sec. 4.2]. The rotational manipulator arm consists of two links with homogeneous mass distribution and mass $m$ with length $l$. A passive joint consisting of a linear spring-damper combination couples the two links to each other. Passive in this context means, that there is no input force at this point. We stress, that the linearity of the passive joint does not result in linear equations of motion, see (31). As an output we measure the position of point $S$ on the second link. Using a body fixed coordinate system the point $S$ on the passive link is described by $0 \leq s \leq l$. The situation is depicted in Figure 1.


Figure 1: Rotational mapilator arm consisting of two links and a passive joint. The figure is taken from from [11].

We present the manipulator's equations of motion. As we will see in a second, it is reasonable to consider the dynamics of the manipulator for $\beta \in \mathcal{B}:=\left\{\beta \in \mathbb{R} \left\lvert\, \cos (\beta) \neq \frac{2 l}{3 s}\right.\right\}$. Henceforth, we assume $\beta \in \mathcal{B}$ and perform the computations. We define $U_{\beta}:=\mathbb{R} \times \mathcal{B} \times \mathbb{R}^{2}$, and set

which is invertible on $U_{\beta}$. Since $\Gamma \neq 0$ for $x \in U_{\beta}$, Assumption (A1) is satisfied and hence Lemma 2.2 yields that system (31) has relative degree $r=2$ on $U_{\beta}$. Note, that for $\beta \in\left\{\beta \in \mathbb{R} \left\lvert\, \cos (\beta)=\frac{2 l}{3 s}\right.\right\}$ we have $\Gamma=0$, from which it is clear why to consider the dynamics for $\beta \in \mathcal{B}$ only. Now, we decouple the internal dynamics of system (31). We start with the computation of $\phi_{1}, \phi_{2}$ satisfying (8), (9). First, we calculate $V: \mathbb{R} \times \mathcal{B} \rightarrow \mathbb{R}^{2}$ such that $\operatorname{im} V\left(x_{1}, x_{2}\right)=\operatorname{ker} h^{\prime}\left(x_{1}, x_{2}\right)$ and obtain $V=\left[-\frac{s}{s+l} 1\right]^{\top}$. According to Lemma 3.1 we may choose for $\phi_{1}$ in (6) $\phi_{1}\left(x_{1}, x_{2}\right)=E\binom{x_{1}}{x_{2}}=:[0,1]\binom{x_{1}}{x_{2}}$, and using Corollary 3.3 we obtain the expression as in 16)

where $\tilde{V}^{\dagger}$ denotes the pseudoinverse of $\tilde{V}$, and we chose $\tilde{V}\left(x_{2}\right)=V R\left(x_{2}\right)$ with $R\left(x_{2}\right)=-\frac{3 s \cos \left(x_{2}\right)-2 l}{6(s+l)}$ as a left transformation. We stress, that $R: \mathcal{B} \rightarrow \mathbb{R}$ is invertible on $\mathcal{B}$ and we use it only for the sake of better legibility. Thence, we obtain an expression as in 13 .

Now, we substitute the expressions from $(32),(33)$ into the respective functions and obtain via (17) the internal dynamics of system (31). The internal dynamics of (31) are given in (34).
Remark 5.1. We highlight, that the computation of the internal dynamics is completely determined by system parameters and the application of Lemma 3.1, Lemma 3.2 and Corollary 3.3, and equations (11), (13) and (16). Once chosen $\phi_{1}$, e.g. $\phi_{1}\left(x_{1}\right)=E x_{1}$ as in the proof of Lemma 3.1. the decoupling of the internal dynamics can be performed computationally by an algorithm.

### 5.2. Example: Mass on car

We illustrate the stability result presented in Section 4 To this end, we consider the mass on a car system presented in [20, Sec. 4.2]; this is an extension of the classical mass on a car system under consideration in [11, Sec. 4.1]. The system consists of two cars with mass $m_{1}$ and $m_{2}$, resp. The two cars are coupled via a spring-damper combination with characteristics $K_{2}$ and $D_{2}$, resp. On the second car a ramp with constant angle $0<\alpha<\pi / 2$ is mounted, on which a third mass $m_{3}$ is lying and is coupled to the second car via a spring with characteristic $K_{3}$, and a damping with characteristic $D_{3}$. The first car is driven by a force $u_{1}$, and the second car individually is driven by a force $u_{2}$. We measure the horizontal position of the first and the second car. The situation is depicted in Figure 2


Figure 2: Extended mass on a car system. The original figure is taken from [20] and edited for the purpose of the present article.

For convenience we assume the constant force on $m_{3}$ due to gravity, namely $m_{3} g \sin (\alpha)$, where $g$ is the gravitational constant, to be compensated via a linear coordinate transformation, such that $K_{3}(0)=0$. Then, according to [20, Sec. 4.2] with $s:=\left(s_{1}, s_{2}, s_{3}\right)^{\top} \in \mathbb{R}^{3}$ the equations of motion for that system are given by

In this particular example we have $n=3$ and $m=2$, hence we are in the situation of multi-input, multi-output. Note, that the input and the output are not colocated, i.e., $H \neq B^{\top}$. According to the equations given in [20] we assume $K_{2}(s)=k s_{2}$ and $D_{2}\left(\dot{s}_{2}\right)=d \dot{s}_{2}$, where $k, d>0$. In order to include nonlinear terms, we assume that $K_{3}$ and $D_{3}$ have the following characteristics, where $\sigma$ denotes the sign function

Further, let $\tilde{H}:=[H, 0]$ and $\tilde{M}:=\operatorname{diag}\left(I_{3}, M\right)$. Then system 35 reads

## 6. Conclusion

In the present article we elaborated two main results. First, we presented a suitable set of coordinates to represent the internal dynamics of a nonlinear multibody system. This representation is completely determined by the system parameters and therefore the internal dynamics can be decoupled algorithmically and are open to e.g. stability analysis. In particular, it is not necessary to compute the Byrnes-Isidori form to obtain an explicit representation of the internal dynamics. Second, we gave an abstract stability result for control systems and derived sufficient conditions on the system parameters of a multibody system such that its internal dynamics are bounded-input, bounded-output stable. We highlight that the conditions can be verified in advance and hence it is not necessary to derive the internal dynamics in the first place.

Now, further research aims to find similar representations of the internal dynamics of multibody systems with vector relative degree and differential algebraic systems. Moreover, we aim to achieve similar stability results for nonlinear multibody systems with a more complex function $f$, a state dependent mass matrix, such as e.g. the robotic manipulator arm with a passive joint, and systems with algebraic constraints such as e.g. systems with a kinematic loop.

\leq & \left(\tau\left(\tilde{C}_{4}+\mu r_{2}\right)-\left\|\eta_{2}\right\|\right)\left\|\eta_{2}\right\|^{2} a_{4}\left(\mathcal{M} y_{1}+\lambda^{-1} V \eta_{1}\right)
\end{aligned}

where we used $\|V z\|=\|z\|$ for all $z \in \mathbb{R}^{n-m}$ in the second last estimation. We summarize the calculations above to estimate $\mathcal{V}^{\prime}\left(\eta_{1}, \eta_{2}\right) \cdot \mathcal{F}\left(\eta_{1}, \eta_{2}, y_{1}, y_{2}\right)$ for $\eta_{i} \in Z_{i}$ and $y_{i} \in$ $B_{r_{i}}(0), i=1,2$

& -q \frac{\kappa}{\lambda}\left\|\eta_{1}\right\|^{2}+q \tau d \mu r_{2}\left\|\eta_{1}\right\|+q \frac{\tau^{2}}{2}\left\|\eta_{1}\right\|^{2}+q \frac{d^{2}}{2}\left\|\eta_{2}\right\|^{2} \\
& +\frac{q}{\lambda}\left(\lambda \tau \tilde{C}_{3}-\left\|\eta_{1}\right\|\right)\left\|\eta_{1}\right\| a_{3}\left(\mathcal{M} y_{2}+V \eta_{2}\right) \\
& +\left(\tau\left(\tilde{C}_{4}+\mu r_{2}\right)-\left\|\eta_{2}\right\|\right)\left\|\eta_{2}\right\|^{2} a_{4}\left(\mathcal{M} y_{1}+\lambda^{-1} V \eta_{1}\right) .

Sorting these expressions and inserting the constants from 28) yields

& \leq-\varepsilon_{1}\left\|\eta_{1}\right\|^{2}+E_{1}\left\|\eta_{1}\right\|-\varepsilon_{2}\left\|\eta_{2}\right\|^{2}+E_{2}\left\|\eta_{2}\right\| \\
& \quad-\frac{q}{\lambda}\left(\left\|\eta_{1}\right\|-\gamma_{1}\right)\left\|\eta_{1}\right\| a_{3}\left(\mathcal{M} y_{2}+V \eta_{2}\right)  \tag{A.2}\\
& \quad-\left(\left\|\eta_{2}\right\|-\gamma_{2}\right)\left\|\eta_{2}\right\|^{2} a_{4}\left(\mathcal{M} y_{1}+\lambda^{-1} V \eta_{1}\right),

where $\varepsilon_{1}, \varepsilon_{2}>0$ and $E_{1}, E_{2} \geq 0$ via the choice of $q$ and $\lambda$, and $\gamma_{1}, \gamma_{2} \geq 0$. Now, we consider the function

\left(w_{1}, w_{2}\right) & \mapsto-\varepsilon_{1}\left\|w_{1}\right\|^{2}+E_{1}\left\|w_{1}\right\|-\varepsilon_{2}\left\|w_{2}\right\|^{2}+E_{2}\left\|w_{2}\right\|
\end{aligned}
$$

with $\varepsilon_{i}>0, E_{i} \geq 0$ for $i=1,2$ as above. A short calculation yields that for $w_{i} \in \tilde{Z}_{i}$ we have $W\left(w_{1}, w_{2}\right) \leq 0$, and $-\left(\left\|w_{1}\right\|-\gamma_{1}\right)<0$ and $-\left(\left\|w_{2}\right\|-\gamma_{2}\right)<0$. Comparing A.2 and A.3) yields assertion (30)

for all $\eta_{i} \in Z_{i} \cap \tilde{Z}_{i}, i=1,2$, and $y_{1} \in B_{r_{1}}(0), y_{2} \in B_{r_{2}}(0)$.
