# VARIANCE OF LATTICE POINT COUNTING IN SOME SPECIAL SHELLS IN $\mathbb{R}^{d}$ 

TAO JIANG


#### Abstract

We study the variance of the random variable that counts the number of lattice points in some shells generated by a special class of finite type domains in $\mathbb{R}^{d}$. The proof relies on estimates of the Fourier transform of indicator functions of convex domains.


## 1. Introduction

The classical lattice point problem associated with a compact convex domain $\mathcal{B} \subseteq \mathbb{R}^{d}$ is about counting the number of lattice points $\mathbb{Z}^{d}$ in the enlarged domain $r \mathcal{B}$ and the main problem is to study the remainder

$$
R_{\mathcal{B}}(r)=\#\left(r \mathcal{B} \cap \mathbb{Z}^{d}\right)-\operatorname{vol}(\mathcal{B}) r^{d}
$$

for $r \geq 1$. If $\mathcal{B}$ is the unit disk centered at the origin, it is the well-known Gauss circle problem and it is conjectured that $R_{\mathcal{B}}(r)=O_{\epsilon}\left(r^{1 / 2+\epsilon}\right)$ for any $\epsilon>0$. For the Gauss circle problem, Huxley 9 in 2003 proved that $R_{\mathcal{B}}(r)=O\left(r^{131 / 208+\epsilon}\right)$ and Bourgain and Watt [1] obtained $R_{\mathcal{B}}(r)=$ $O\left(r^{517 / 824+\epsilon}\right)$ in 2017. Many authors made efforts to study general domains under different curvature assumptions of the boundary $\partial \mathcal{B}$. We refer interested readers to Ivić, Krätzel, Kühleitner and Nowak [10] and Nowak [15] which gave excellent overview of the development of this problem.

Assume $\mathcal{B} \subseteq \mathbb{R}^{d}$ is a convex domain which contains in its interior the origin and has smooth boundary with nonzero Gaussian curvature. Denote by

\mathcal{B}(r, t)=(r+t / 2) \mathcal{B} \backslash(r-t / 2) \mathcal{B}
$$

the shell generated by the domain $\mathcal{B}$ and

$$
N_{\mathcal{B}(r, t)}(u)=\#\left\{n \in \mathbb{Z}^{d}: n \in(\mathcal{B}(r, t)-u)\right\}
$$

the random variable that counts the number of lattice points in the shifted shell $\mathcal{B}(r, t)-u$. Then Colzani, Gariboldi and Gigante 5 ] proved that the variance of $N_{\mathcal{B}(r, t)}(u)$ is asymptotic to $\operatorname{vol}(\mathcal{B}(r, t))$ as $r$ goes to

[^0]infinity. Here $0<t \leq r^{-\alpha}$ for every $\alpha>(d-1) /(d+1)$ and $u$ is uniformly distributed in $\mathbb{T}^{d}$.

In this paper, we study the variance of the random variable

$$
N_{\mathcal{D}(r, t)}(u)=\#\left\{n \in \mathbb{Z}^{d}: n \in(\mathcal{D}(r, t)-u)\right\},
$$

where the shell

$$
\begin{equation*}
\mathcal{D}(r, t)=(r+t / 2) \mathcal{D} \backslash(r-t / 2) \mathcal{D} \tag{1.1}
\end{equation*}
$$

is generated by convex domain

$$
\begin{equation*}
\mathcal{D}=\left\{x \in \mathbb{R}^{d}: \sum_{p=0}^{n-1}\left(\sum_{l=1+d_{p}}^{d_{p+1}} x_{l}^{\omega_{l}}\right)^{m_{p+1}} \leq 1\right\} . \tag{1.2}
\end{equation*}
$$

Here $n, p, m_{p+1}, d_{p+1} \in \mathbb{N} \cup\{0\} \notin, 0=d_{0}<d_{1}<\cdots<d_{n-1}<$ $d_{n}=d, d \geq 3$ and $4 \leq \omega_{l} \in 2 \mathbb{N}$. The authors in 5] pointed out that the curvature assumption is important and gave some examples to show that if the curvature of some points on $\partial \mathcal{B}$ vanishes, the variance may be much larger than the volume of the shell. Notice that the examples they gave are some shells generated by polyhedra. We are interested in the situation between these two cases where the shells are generated by finite type domains. Since it is difficult to study the most general finite type domain, we start with some special cases. Notice that the following special cases are considered in the classical lattice point problem. The super spheres

were considered in Randol [16] for even $\omega \geq 3$ and Krätzel [11] for odd $\omega \geq 3$. Krätzel [12] and Krätzel and Nowak [13, 14] studied the convex domain

$$
\begin{equation*}
\left\{x \in \mathbb{R}^{3}:\left|x_{1}\right|^{m k}+\left(\left|x_{2}\right|^{k}+\left|x_{3}\right|^{k}\right)^{m} \leq 1\right\} \tag{1.4}
\end{equation*}
$$

with certain assumptions on the reals $k$ and $m$. Motivated by these examples, we consider the shells generated by the domain $\mathcal{D}$ defined by (1.2). The domain $\mathcal{D}$ is formally an extension of (1.3) and (1.4) and the Gaussian curvature of the intersection of $\partial \mathcal{D}$ and the coordinate planes is zero.

In order to state our main theorem, we first define some notations. For the constants $d_{i}$ 's and $m_{j}$ 's appearing in (1.2), given any $1 \leq l \leq d$,

[^1]there exists a unique $0 \leq p(l) \leq n-1$ such that $1+d_{p(l)} \leq l \leq d_{p(l)+1}$. For $1 \leq q \leq d$, define
\[

\begin{cases}1 & \text { if } 1 \leq l \leq d \text { and } p(l)=p(q)  \tag{1.5}\\ m_{p(l)+1} & \text { if } 1 \leq l \leq d \text { and } p(l) \neq p(q)\end{cases}

For $1 \leq q \leq d$ and $1 \leq j \leq d-1$, let
$\alpha_{q, j}=\max _{\substack{S \in P_{j}\{1,2, \ldots, d\} \\ S \ni q}}\left\{d-j-\sum_{l=1, l \notin S}^{d} \frac{2}{m_{q, l} \omega_{l}}, \frac{d-j-\sum_{l=1, l \notin S}^{d} 2 /\left(m_{q, l} \omega_{l}\right)}{\sum_{l=1, l \notin S}^{d} 2 /\left(m_{q, l} \omega_{l}\right)}\right\}$
and

$$
\begin{equation*}
\alpha_{j}=\max \left\{\alpha_{1, j}, \alpha_{2, j}, \ldots, \alpha_{d, j}\right\} \tag{1.7}
\end{equation*}
$$

Here $P_{j}\{1,2, \ldots, d\}$ denotes the collection of all subsets of $\{1,2, \ldots, d\}$ having $j$ elements. It seems that $\alpha_{q, j}$ 's are complicated. These constants appear in the proof of Lemma 3.1 below. To help readers understand them better, Remark 1.2 gives some examples of the domain $\mathcal{D}$ and the corresponding constants $m_{q, l}$ 's and $\alpha_{q, j}$ 's.

It is easy to verify that the expectation of $N_{\mathcal{D}(r, t)}(u)$ is the volume of $\mathcal{D}(r, t)$. For the variance we have
Theorem 1.1. For the domain $\mathcal{D}(r, t)$ defined by (1.1), if $1<r<+\infty$, $0<t \leq C r^{-\alpha}$ for some constant $C>0$ and $\alpha>\max \left\{\alpha_{1}, \alpha_{2}, \ldots, \alpha_{d-1}\right\}$, then there is a constant $\beta>0$ such that

\int_{\mathbb{T}^{d}}\left|N_{\mathcal{D}(r, t)}(u)-\operatorname{vol}(\mathcal{D}(r, t))\right|^{2} \mathrm{~d} u=\operatorname{vol}(\mathcal{D}(r, t))\left(1+O\left(t^{\beta}\right)\right) \tag{1.8}
\end{equation*}
$$

where the implicit constant is independent of $r$ and $t$.
Remark 1.2. For the domain $\mathcal{D}$ defined by (1.2),
(1) if $\omega_{1}=\cdots=\omega_{d}$ and $m_{1}=\cdots=m_{n}=1$, then

\begin{equation*}
\mathcal{D}=\left\{x \in \mathbb{R}^{d}: x_{1}^{\omega_{1}}+\cdots+x_{d}^{\omega_{1}} \leq 1\right\} . \tag{1.9}
\end{equation*}
$$

Given any $1 \leq q, l \leq d$ and $1 \leq j \leq d-1$, we have $m_{q, l}=1$ and

$$
\alpha_{q, j}=\frac{(d-j)\left(1-2 / \omega_{1}\right)}{\min \left\{1,2(d-j) / \omega_{1}\right\}} .
$$

(2) if $d=3, n=2, d_{1}=2, \omega_{1}=4, \omega_{2}=6, \omega_{3}=8$ and $m_{1}=5, m_{2}=1$, then

\mathcal{D}=\left\{x \in \mathbb{R}^{3}:\left(x_{1}^{4}+x_{2}^{6}\right)^{5}+x_{3}^{8} \leq 1\right\}
$$

Given any $q=1,2$ and $1 \leq l \leq 3$, we have $m_{q, l}=1$,

$$
m_{3, l}= \begin{cases}5 & \text { if } l=1,2 \\ 1 & \text { if } l=3\end{cases}
$$

$$
\alpha_{1,1}=17 / 7, \alpha_{1,2}=3, \alpha_{2,1}=5 / 3, \alpha_{2,2}=3, \alpha_{3,1}=11 \text { and } \alpha_{3,2}=14
$$

Remark 1.3. We can choose $t=C r^{-(d-1)}$ for some constant $C>0$ if

\begin{equation*}
\max \left\{\alpha_{1}, \ldots, \alpha_{d-1}\right\}<d-1 \text { 建. } \tag{1.10}
\end{equation*}

Then we have the property that the variance converges to the bounded nonzero constant $\operatorname{vol}(\mathcal{D}) d C$ as $r$ goes to infinity. This is consistent with the result in Cheng, Lebowitz, Major [4] in $\mathbb{R}^{2}$. There they take $t=2 c / r$ and the variance tends to $4 c$ times the area of the domain.

Remark 1.4. It is necessary to assume a range of $\alpha$ in the theorem. An example is given in the last part of Appendix to show that if $\alpha$ takes some value less than $\max \left\{\alpha_{1}, \ldots, \alpha_{d-1}\right\}$, the variance is much larger than the volume of $\mathcal{D}(r, t)$ when $r$ is large enough. But the range of $\alpha$ in Theorem 1.1 may not be sharp.

Remark 1.5. This paper extends the result in [5] from the case of nonvanishing Gaussian curvature to the case where there are boundary points with zero Gaussian curvature. The difficulty resolved in this paper is how to handle these points. Since the problem will be reduced to estimating a sum involving the Fourier transform of the indicator function of $\mathcal{D}(r, t)$, we shall divide $\partial \mathcal{D}$ into different parts according to the Gaussian curvature. For the part with zero Gaussian curvature, we apply Theorem 2.2 in [7, p. 74] to sum the series and this requires more computation.

Notations: For any convex domain $\mathcal{B}$, let $n(x)$ be the unit outer normal of the point $x$ on $\partial \mathcal{B}$ and $x(\xi)$ be the point on $\partial \mathcal{B}$ with nonzero outer normal $\xi$. Denote by $K(x)$ the Gaussian curvature of $x$ on $\partial \mathcal{B}$. Let $\nabla f$ be the gradient and $\nabla^{2} f$ be the Hessian matrix of function $f$. $\mathbf{A}^{T}$ is the transpose of matrix $\mathbf{A} . C^{\infty}(U)$ is the space of all smooth functions on the open set $U$. For functions $f$ and $g$, the notation $f \lesssim g$ or $f=O(g)$ means $|f| \leq C g$ for some constant $C>0$ and $f \gtrsim g$ equals $g \lesssim f$. If $f$ and $g$ are non-negative functions, $f \asymp g$ means there are some positive constants $c^{\prime}$ and $C^{\prime}$ such that $c^{\prime} f \leq g \leq C^{\prime} f$. Let $\mathbb{T}^{d}$ be the unit cube $\left\{x \in \mathbb{R}^{d}:-1 / 2 \leq x_{i}<1 / 2\right.$ for $\left.1 \leq i \leq d\right\}$.

Throughout this paper the notation $\mathcal{D}$ and $\mathcal{D}(r, t)$ are the domains defined by (1.1) and (1.2) and $m_{q, l}$ is the constant defined by (1.5). Denote by $\varepsilon_{0}$ a small constant such that for any nonzero $\xi \in \mathbb{R}^{d}$, there is a $1 \leq q \leq d$ satisfying $\left|\xi_{q}\right| /|\xi| \geq \varepsilon_{0}$.

## 2. SOME ESTIMATES

Before we prove Theorem 1.1, we give some results that will be used later: Lemma 2.1 and 2.2 are some simple results on the Gaussian curvature. The proofs are basic calculations under the local coordinates so we put them in Appendix. Lemma 2.3-2.5 are some asymptotic expansions and estimates related to the Fourier transform of the indicator functions of convex domain and $\mathcal{D}(r, t)$. Lemma 2.6 is an estimate of an oscillatory integral. Given any $x \in \mathbb{R}^{d}$, denote by $\hat{x}_{q} \in \mathbb{R}^{d-1}$ the ( $d-1$ )-dimensional vector obtained by deleting the $q^{\text {th }}$ component from $x$. For example, $\hat{x}_{1}=\left(x_{2}, \ldots, x_{d}\right)$. Then we have

Lemma 2.1. Let $\mathcal{B} \subseteq \mathbb{R}^{d}(d \geq 3)$ be a compact convex domain. Assume that given any $x \in \partial \mathcal{B}, x$ has a small neighborhood on $\partial \mathcal{B}$ that can be given as a graph $x_{q}=f\left(\hat{x}_{q}\right)$ with $f \in C^{\infty}\left(\mathbb{R}^{d-1}\right)$ for some $1 \leq q \leq d$. Then we have the following results.
(1) The Gaussian curvature of $\partial \mathcal{B}$ at $x$ is

$$
\begin{equation*}
K(x)=\frac{\left|\operatorname{det}\left(\nabla^{2} f\left(\hat{x}_{q}\right)\right)\right|}{\left(1+\left|\nabla f\left(\hat{x}_{q}\right)\right|^{2}\right)^{(d+1) / 2}} \tag{2.1}
\end{equation*}
$$

(2) If $K(x) \neq 0$, the Gauss map $n$ has a smooth inverse in a small neighborhood of $n(x)$, namely, given any $\xi /|\xi|$ in this neighborhood, there is a unique point $x(\xi) \in \partial \mathcal{B}$ such that $n(x(\xi))=\xi /|\xi|$. Moreover,

$$
\begin{equation*}
\frac{\partial x_{i}(\xi)}{\partial \xi_{j}}=-\frac{A_{j i}}{\xi_{q} \operatorname{det}\left(\nabla^{2} f\left(\hat{x}_{q}\right)\right)}, \tag{2.2}
\end{equation*}
$$

where $A_{j i}$ is the cofactor of $\nabla^{2} f\left(\hat{x}_{q}\right)$ of the entry $\frac{\partial^{2} f\left(\hat{x}_{q}\right)}{\partial x_{i} \partial x_{j}}$ for $1 \leq$ $i, j \leq d$ and $i, j \neq q$.

$$
\begin{equation*}
\frac{\partial x_{i}(\xi)}{\partial \xi_{q}}=-\frac{\operatorname{det}\left(\boldsymbol{A}_{q i}\right)}{\xi_{q} \operatorname{det}\left(\nabla^{2} f\left(\hat{x}_{q}\right)\right)}, \tag{2.3}
\end{equation*}
$$

where $1 \leq i \neq q \leq d$ and if $i<q, \boldsymbol{A}_{q i}$ denotes the matrix obtained by replacing the $i^{\text {th }}$ column of $\nabla^{2} f\left(\hat{x}_{q}\right)$ with $\left(\nabla f\left(\hat{x}_{q}\right)\right)^{T}$; if $i>q$, $\boldsymbol{A}_{q i}$ denotes the matrix obtained by replacing the $(i-1)^{\text {th }}$ column of $\nabla^{2} f\left(\hat{x}_{q}\right)$ with $\left(\nabla f\left(\hat{x}_{q}\right)\right)^{T}$.

Proof. See Appendix 1.
If $\left|\xi_{q}\right| \asymp|\xi|$, from (2.2) and (2.3) we have

\frac{\partial x_{i}(\xi)}{\partial \xi_{j}} \lesssim|\xi|^{-1}(K(x(\xi)))^{-1}
$$

Moreover, let $\nu=\left(\nu_{1}, \ldots, \nu_{d}\right)$ be a multi-index. Then

$$
\begin{equation*}
\frac{\partial^{|\nu|} x_{i}(\xi)}{\partial \xi^{\nu}} \lesssim|\xi|^{-|\nu|}(K(x(\xi)))^{-1-2(|\nu|-1)} \tag{2.4}
\end{equation*}
$$

Combing (2.1) and (2.4) yields

$$
\begin{equation*}
\frac{\partial^{|\nu|}(K(x(\xi)))^{-\gamma}}{\partial \xi^{\nu}} \lesssim|\xi|^{-|\nu|}(K(x(\xi)))^{-\gamma-2|\nu|} \tag{2.5}
\end{equation*}
$$

for some $\gamma>0$.
Lemma 2.2. Let $1 \leq q \leq d$ be an integer. For the domain $\mathcal{D}$, given any nonzero $\xi \in \mathbb{R}^{d}$ with $\left|\xi_{q}\right| /|\xi| \geq \varepsilon_{0}$, we have

\begin{equation*}
\prod_{i=1, i \neq q}^{d}\left(\left|\xi_{i}\right| /|\xi|\right)^{\frac{m_{q, i} \omega_{i}-2}{m_{q, i} \omega_{i}-1}} \lesssim K(x(\xi)) \lesssim \prod_{i=1, i \neq q}^{d}\left(\left|\xi_{i}\right| /|\xi|\right)^{\frac{\omega_{i}-2}{\omega_{i}-1}}, \tag{2.6}
\end{equation*}
$$

where the implicit constants only depend on the domain $\mathcal{D}$ and $\varepsilon_{0}$.
Proof. See Appendix 2.
If there is an integer $1 \leq i \leq d$ such that $\xi_{i} /|\xi|=0$, from (2.6) we know $K(x(\xi))=0$. For $1 \leq j \leq d$, define

$$
\begin{equation*}
\mathbb{Z}^{d}(j)=\cup_{S \in P_{j}\{1,2, \ldots, d\}}\left\{n \in \mathbb{Z}^{d}: n_{i} \neq 0 \text { if } i \in S, \text { otherwise } n_{i}=0\right\}, \tag{2.7}
\end{equation*}
$$

where $P_{j}\{1,2, \ldots, d\}$ denotes the collection of all subsets of $\{1,2, \ldots, d\}$ having $j$ elements. Given any $n \in \mathbb{Z}^{d}(j)$, it is easy to verify that $K(x(n))=0$ if $1 \leq j \leq d-1$ and $K(x(n)) \neq 0$ if $j=d$.

Lemma 2.3. Assume $\mathcal{B} \subseteq \mathbb{R}^{d}(d \geq 3)$ is a compact convex domain and its boundary is a smooth hypersurface. Then given any $N \in \mathbb{N}$ and nonzero $\xi \in \mathbb{R}^{d}$ with $K(x( \pm \xi)) \neq 0$, we have

$$
\begin{equation*}
\widehat{\chi}_{\mathcal{B}}(\xi)=a(\xi)|\xi|^{-(d+1) / 2}+E(\xi) \tag{2.8}
\end{equation*}
$$

where

$$
\begin{aligned}
a(\xi)= & (2 \pi i)^{-1} e^{-2 \pi i x(-\xi) \cdot \xi-\pi i(d-1) / 4}(K(x(-\xi)))^{-1 / 2} \\
& -(2 \pi i)^{-1} e^{-2 \pi i x(\xi) \cdot \xi+\pi i(d-1) / 4}(K(x(\xi)))^{-1 / 2}
\end{aligned}
$$

and

$$
\begin{equation*}
|E(\xi)|+|\nabla E(\xi)| \lesssim|\xi|^{-(d+3) / 2} \delta^{-(d+5) / 2}+|\xi|^{-N-1} \delta^{-4 N} \tag{2.9}
\end{equation*}
$$

Here $\delta=\min \{K(x(\xi)), K(x(-\xi))\}$ and the implicit constant only depends on $\mathcal{B}$ and $N$.

Proof. We only prove the estimate of $\nabla E(\xi)$, see Corollary 4.3 in Guo [8, p. 423] for the first part of this lemma. Combining (2.5), (2.8) and the fact $\nabla(x(\xi) \cdot \xi)=x(\xi)$ (see Corollary 1.7.3 in [17, p. 47]) yields

\begin{align*}
\nabla E(\xi)= & \nabla \widehat{\chi}_{\mathcal{B}}(\xi)+2^{-1}(d+1)|\xi|^{-(d+5) / 2} \xi a(\xi)-|\xi|^{-(d+1) / 2} \nabla a(\xi)  \tag{2.10}\\
= & \nabla \widehat{\chi}_{\mathcal{B}}(\xi)-|\xi|^{-(d+1) / 2} \nabla a(\xi)+O\left(|\xi|^{-(d+3) / 2} \delta^{-1 / 2}\right) \\
= & \nabla \widehat{\chi}_{\mathcal{B}}(\xi)+|\xi|^{-(d+1) / 2} e^{-2 \pi i x(-\xi) \cdot \xi-\pi i(d-1) / 4} x(-\xi)(K(x(-\xi)))^{-1 / 2} \\
& -|\xi|^{-(d+1) / 2} e^{-2 \pi i x(\xi) \cdot \xi+\pi i(d-1) / 4} x(\xi)(K(x(\xi)))^{-1 / 2} \\
& +O\left(|\xi|^{-(d+3) / 2} \delta^{-5 / 2}\right) .
\end{align*}
$$

By the divergence theorem we have

$$
\begin{align*}
\nabla \widehat{\chi}_{\mathcal{B}}(\xi)= & |\xi|^{-2} \int_{\partial \mathcal{B}} x e^{-2 \pi i \xi \cdot x} \xi \cdot n(x) \mathrm{d} \sigma(x)-|\xi|^{-2} \xi \int_{\mathcal{B}} e^{-2 \pi i \xi \cdot x} \mathrm{~d} x  \tag{2.11}\\
= & |\xi|^{-2} \int_{\partial \mathcal{B}} x e^{-2 \pi i \xi \cdot x} \xi \cdot n(x) \mathrm{d} \sigma(x)+O\left(|\xi|^{-1}\left|\widehat{\chi}_{\mathcal{B}}(\xi)\right|\right) \\
= & |\xi|^{-(d+1) / 2} e^{-2 \pi i x(\xi) \cdot \xi+\pi i(d-1) / 4} x(\xi)(K(x(\xi)))^{-1 / 2} \\
& -|\xi|^{-(d+1) / 2} e^{-2 \pi i x(-\xi) \cdot \xi-\pi i(d-1) / 4} x(-\xi)(K(x(-\xi)))^{-1 / 2} \\
& +O\left(|\xi|^{-(d+3) / 2} \delta^{-(d+5) / 2}+|\xi|^{-N-1} \delta^{-4 N}\right),
\end{align*}
$$

where $\mathrm{d} \sigma$ is the induced surface measure on the boundary and the last equality follows from the proof of Theorem 4.2 in [8, p. 422-423]. Combining (2.10) and (2.11) yields the desired bounds of $\nabla E(\xi)$. This finishes the proof.

Notice that the symmetry of $\mathcal{D}$ implies $x(-\xi)=-x(\xi)$ and $K(x(\xi))=$ $K(x(-\xi))$. Hence if $K(x(\xi)) \neq 0$, applying Lemma 2.3 yields

\widehat{\chi}_{\mathcal{D}}(\xi)=a(\xi)|\xi|^{-(d+1) / 2}+E(\xi),
$$

where

$$
\begin{equation*}
a(\xi)=\pi^{-1}(K(x(\xi)))^{-1 / 2} \sin (2 \pi x(\xi) \cdot \xi-(d-1) \pi / 4) \tag{2.12}
\end{equation*}
$$

Meanwhile, by the result in Svensson [18, p. 19] we have

\begin{equation*}
\widehat{\chi}_{\mathcal{D}}(\xi) \lesssim|\xi|^{-(d+1) / 2}(K(x(\xi)))^{-1 / 2} \tag{2.13}
\end{equation*}
$$

Let $T_{x}$ be the tangent plane of $\partial \mathcal{D}$ at $x$,

\tilde{B}(x, \lambda)=\left\{y \in \partial \mathcal{D}: \operatorname{dist}\left(y, T_{x}\right)<\lambda\right\}
$$

be a "cap" cut off from $\partial \mathcal{D}$ by a plane parallel to $T_{x}$ at distance $\lambda$, and $\sigma(\tilde{B}(x, \lambda))$ be the surface measure of $\tilde{B}(x, \lambda)$. Then

Lemma 2.4. Let $1 \leq q \leq d$ be an integer. For the domain $\mathcal{D}$, given any nonzero $\xi \in \mathbb{R}^{d}$ with $\left|\xi_{q}\right| /|\xi| \geq \varepsilon_{0}$, we have

\sigma\left(\tilde{B}\left(x(\xi),|\xi|^{-1}\right)\right) \lesssim \prod_{i=1, i \neq q}^{d} \min \left\{|\xi|^{-\frac{1}{m_{q, i} \omega_{i}}},|\xi|^{-\frac{1}{2}}\left(\frac{\left|\xi_{i}\right|}{|\xi|}\right)^{-\frac{m_{q, i} \omega_{i}-2}{2\left(m_{q}, \omega_{i}-1\right)}}\right\}
$$

where the implicit constant only depends on $\mathcal{D}$ and $\varepsilon_{0}$.
Proof. See Lemma 2.1 in [7, p. 70].
Lemma 2.5. Let $1 \leq j \leq d-1$ be an integer. For the shell $\mathcal{D}(r, t)$, given any nonzero $n \in \mathbb{Z}^{d}$, we have
$\widehat{\chi}_{\mathcal{D}(r, t)}(n) \lesssim\left\{\begin{array}{l}r^{d-1}|n|^{-1} \sigma\left(\tilde{B}\left(x(n),(r|n|)^{-1}\right)\right) \min \{t|n|, 1\} \text { if } n \in \mathbb{Z}^{d}(j), \\ r^{(d-1) / 2}|n|^{-(d+1) / 2}(K(x(n)))^{-1 / 2} \min \{t|n|, 1\} \text { if } n \in \mathbb{Z}^{d}(d),\end{array}\right.$
where $\mathbb{Z}^{d}(j)$ and $\mathbb{Z}^{d}(d)$ are defined by (2.7) and the implicit constants are independent of $r, t$ and $n$. Furthermore, if $n \in \mathbb{Z}^{d}(d)$, we have

& \cos (2 \pi r x(n) \cdot n-\pi(d-1) / 4) \sin (\pi t x(n) \cdot n)
\end{align*}
$$

and

\begin{gather*}
B(r, t, n) \lesssim \min \left\{r^{(d-1) / 2}|n|^{-(d+1) / 2}(K(x(n)))^{-1 / 2} \min \{t|n|, 1\},\right.  \tag{2.16}\\
\left.r^{d-1-\tilde{N}} t|n|^{-\tilde{N}}(K(x(n)))^{-4 \tilde{N}}\right\} .
\end{gather*}
$$

Here $\tilde{N}$ denotes the integer part of $(d+1) / 2$ for simplicity and the implicit constant is independent of $r, t$ and $n$.

Proof. Since
(2.17) $\widehat{\chi}_{\mathcal{D}(r, t)}(n)=(r+t / 2)^{d} \widehat{\chi}_{\mathcal{D}}((r+t / 2) n)-(r-t / 2)^{d} \widehat{\chi}_{\mathcal{D}}((r-t / 2) n)$,
combining the divergence theorem, Theorem B in [2, p. 335] and (2.13) yields

where $1 \leq j \leq d-1$. On the other hand,

\widehat{\chi}_{\mathcal{D}(r, t)}(n)= & \left((r+t / 2)^{d}-r^{d}\right) \widehat{\chi}_{\mathcal{D}}((r+t / 2) n)+r^{d}\left(\widehat{\chi}_{\mathcal{D}}((r+t / 2) n)\right.  \tag{2.19}\\
& \left.-\widehat{\chi}_{\mathcal{D}}((r-t / 2) n)\right)+\left(r^{d}-(r-t / 2)^{d}\right) \widehat{\chi}_{\mathcal{D}}((r-t / 2) n) .
\end{align*}

Note that $\nabla \widehat{\chi}_{\mathcal{D}}(n)=-2 \pi i \int_{\mathcal{D}} x e^{-2 \pi i n \cdot x} \mathrm{~d} x$, we can handle this integral like $\widehat{\chi}_{\mathcal{D}}(n)$ to get

Then (2.18) and (2.21) enable us to get (2.14).
Furthermore, if $n \in \mathbb{Z}^{d}(d)$, by using (2.8) and (2.17) we rewrite

& +\left(r^{(d-1) / 2}-(r-t / 2)^{(d-1) / 2}\right)|n|^{-(d+1) / 2} a((r-t / 2) n) \\
& +\left((r+t / 2)^{d}-(r-t / 2)^{d}\right) E((r+t / 2) n) \\
& +(r-t / 2)^{d}(E((r+t / 2) n)-E((r-t / 2) n)) .
\end{align*}
$$

It follows from (2.12) that

& \int_{\mathbb{R}^{d}} \psi(\xi) e^{2 \pi i \lambda(2 x(\xi) \cdot \xi-\zeta \cdot \xi)} \mathrm{d} \xi  \tag{2.23}\\
& \lesssim \epsilon^{-\gamma_{k}} \min \left\{(\lambda|\zeta|)^{-(d-1) / 2},(\lambda \operatorname{dist}\{\zeta, \partial(2 \mathcal{D})\})^{-k}\right\},
\end{align*}
$$

where the implicit constant is independent of $\lambda$ and $\zeta$.
Proof. Since

|\nabla(2 x(\xi) \cdot \xi-\zeta \cdot \xi)|=|2 x(\xi)-\zeta| \geq \operatorname{dist}\{\zeta, 2 \partial \mathcal{D}\}
$$

by integration by parts there is an integer $\gamma_{1}(k)>0$ such that

\left|\int_{\mathbb{R}^{d}} \psi(\xi) e^{2 \pi i \lambda(2 x(\xi) \cdot \xi-\zeta \cdot \xi)} \mathrm{d} \xi\right| \lesssim \epsilon^{-\gamma_{1}(k)}(\lambda \operatorname{dist}\{\zeta, 2 \partial \mathcal{D}\})^{-k} \tag{2.24}
\end{equation*}
$$

On the other hand,

\begin{aligned}
\int_{\mathbb{R}^{d}} \psi(\xi) e^{2 \pi i \lambda(2 x(\xi) \cdot \xi-\zeta \cdot \xi)} \mathrm{d} \xi & =\int_{0}^{+\infty} e^{4 \pi i \lambda h} \int_{x(\xi) \cdot \xi=h} \frac{\psi(\xi) e^{-2 \pi i \lambda \zeta \cdot \xi}}{|x(\xi)|} \mathrm{dH}_{d-1}(\xi) \mathrm{d} h \\
& \lesssim \int_{\epsilon}^{1 / \epsilon}\left|\int_{x(\xi) \cdot \xi=h} \frac{\psi(\xi) e^{-2 \pi i \lambda \zeta \cdot \xi}}{|x(\xi)|} \mathrm{dH}_{d-1}(\xi)\right| \mathrm{d} h
\end{aligned}
$$

where $\mathrm{H}_{d-1}$ is the $(d-1)$-dimensional Hausdorff measure and Theorem 3.13 in [6, p. 140] gives the first equality above since $f(\xi):=x(\xi) \cdot \xi$ is Lipschitz continuous and the Jacobian $|D f(\xi)|=|x(\xi)|>0$. The support of $\psi$ implies $\epsilon \lesssim h \lesssim 1 / \epsilon$ and $K(x(\xi)) \gtrsim \epsilon^{d-1}$ by Lemma 2.2. Therefore given any multi-index $\nu$ with $|\nu|=j$, by Lemma 2.1 there is an integer $\gamma_{2}(j)>0$ such that

Let $\widetilde{K}(\xi)$ denote the Gaussian curvature of hypersurface $x(\xi) \cdot \xi=h$ at the point $\xi$. If $K(x(\xi)) \neq 0$, we have

If there is a $\xi_{0} \in \operatorname{supp} \psi \cap\left\{\xi \in \mathbb{R}^{d} \backslash\{\overrightarrow{0}\}: x(\xi) \cdot \xi=h\right\}$ such that the outer normal of the hypersurface $x(\xi) \cdot \xi=h$ at $\xi_{0}$ is parallel to $\pm \zeta$, then there is an integer $\tilde{\gamma}_{3}>0$ such that

\begin{align*}
\int_{x(\xi) \cdot \xi=h} \frac{\psi(\xi) e^{-2 \pi i \lambda \zeta \cdot \xi}}{|x(\xi)|} \mathrm{dH}_{d-1}(\xi) & \lesssim \epsilon^{-\tilde{\gamma}_{3}}\left(\widetilde{K}\left(\xi_{0}\right)\right)^{-\frac{1}{2}}(\lambda|\zeta|)^{-\frac{d-1}{2}}  \tag{2.25}\\
& \lesssim \epsilon^{-\tilde{\gamma}_{3}} h^{(d-1) / 2}(\lambda|\zeta|)^{-(d-1) / 2}
\end{align*}
$$

where the implicit constant is independent of $\lambda$ and $\zeta$. If there is no such a point $\xi_{0}$, applying integration by parts gives that for any $k \in \mathbb{N}$, there is an integer $\gamma_{4}(k)>0$ such that

## 3. Proof of theorem 1.1

As we said in the introduction that this paper extends the result in [5], the structure and many ideas in this part follow that paper.

By Parseval's identity or Lemma 2.1 in [5] we have

where $\mathbb{Z}^{d}(j)$ is defined by (2.7).
Lemma 3.1. If $1<r<\infty, 0<t \leq C r^{-\alpha}$ for some constant $C>0$ and $\alpha>\max _{1 \leq i \leq d-1}\left\{\alpha_{i}\right\}$ with $\alpha_{i}$ defined by (1.7), then given any $1 \leq$ $j \leq d-1$, there is a constant $\beta_{j}>0$ such that

\sum_{n \in \mathbb{Z}^{d}(j)}\left|\widehat{\chi}_{\mathcal{D}(r, t)}(n)\right|^{2} \lesssim r^{d-1} t^{1+\beta_{j}} \tag{3.2}

where the implicit constant is independent of $r$ and $t$.

r^{2 d-1-j-C_{j, 1}} \sum_{n \in S_{j, 1}}|n|^{-1-j-C_{j, 1}} \prod_{l=2}^{j}\left(\frac{n_{l}}{|n|}\right)^{-\frac{m_{1, l}, \omega_{l}-2}{m_{1, l} \omega_{l}-1}} \min \left\{t^{2}|n|^{2}, 1\right\} & \text { if } j \geq 2 .\end{cases}
\end{aligned}
$$

If $j=1$, note that

& \lesssim \begin{cases}t^{1+C_{1,1}} & \text { if } C_{1,1}<1 \\
t^{2} \log \left(t^{-1}\right) & \text { if } C_{1,1}=1 \\
t^{2} & \text { if } C_{1,1}>1\end{cases} \tag{3.3}
\end{align*}
$$

Then if $\alpha>\alpha_{1}$ and $t \lesssim r^{-\alpha}$, there is a constant $\beta_{1}>0$ such that

If $2 \leq j \leq d-1$, comparing the summation to integral yields

I_{0}=\int_{1}^{+\infty} s^{-2-C_{j, 1}} \min \left\{t^{2} s^{2}, 1\right\} \mathrm{d} s
$$

has the similar bounds in (3.3),

I_{1}=\int_{0}^{\pi / 2}\left(\sin \phi_{1}\right)^{-\sum_{l=2}^{j} \frac{m_{1, l} \omega_{l}-2}{m_{1, l} \omega_{l}-1}+j-2} \mathrm{~d} \phi_{1} \lesssim 1 \tag{3.4}
\end{equation*}
$$

and

\begin{equation*}
I_{i}=\int_{0}^{\pi / 2}\left(\sin \phi_{i}\right)^{-\sum_{l=i+1}^{j} \frac{m_{1, l} \omega_{l}-2}{m_{1, l} \omega_{l}-1}+j-i-1}\left(\cos \phi_{i}\right)^{-\frac{m_{1, i} \omega_{i}-2}{m_{1, i} \omega_{i}-1}} \mathrm{~d} \phi_{i} \lesssim 1 \tag{3.5}
\end{equation*}

for $2 \leq i \leq j-1$. So if $\alpha>\alpha_{j}$ and $t \lesssim r^{-\alpha}$, we have

\cos (4 \pi r x(n) \cdot n-(d-1) \pi / 2)
\end{gather*}

Here the implicit constant is independent of $r$ and $t$.
Proof. By using Lemma 2.5, we have

I I & =r^{-\tilde{N}+3(d-1) / 2} \sum_{n \in S_{d, 1}, K(x(n)) \geq \epsilon}|n|^{-\tilde{N}-(d+1) / 2} t(K(x(n)))^{-4 \tilde{N}-1 / 2} \min \{t|n|, 1\}
\end{aligned}
$$

and $\epsilon>0$ is determined below. It is easy to get that

where $c_{i_{0}}=\frac{c^{\prime}\left(m_{1, i_{i}} \omega_{i_{0}}-1\right)}{(d-1)\left(m_{1, i_{0}} \omega_{i_{0}}-2\right)}$. Similar to (3.4) and (3.5), we have

I_{2}=\sum_{n \in \mathbb{Z}^{d}(d)} \int_{\mathbb{T}^{d}}|\xi+n|^{-d-1}\left((K(x(\xi+n)))^{-1}-(K(x(n)))^{-1}\right) \\
\sin ^{2}(\pi t x(\xi+n) \cdot(\xi+n)) \mathrm{d} \xi \\
I_{3}=\sum_{n \in \mathbb{Z}^{d}(d)}(K(x(n)))^{-1} \int_{\mathbb{T}^{d}}|\xi+n|^{-d-1}\left(\sin ^{2}(\pi t x(\xi+n) \cdot(\xi+n))\right. \\

where in the last two equalities we use the facts that if $K(x(\nu)) \neq 0$, there is a small neighborhood of $\nu$ such that $(K(x(\nu)))^{-1} \mathrm{~d} S(\nu)=\mathrm{d} \sigma(x)$ and $x(v) \cdot v=x \cdot n(x)$ is the height of the cone with vertex the origin and base $\mathrm{d} \sigma$.

We only estimate $I_{1}$ when the summation is over all $n \in S_{j, 1}$ with $1 \leq j \leq d-1$ and other cases can be handled similarly. Given any $n \in S_{j, 1}$ and $\xi \in\left(n+\mathbb{T}^{d}\right) \backslash T$, we have $0<\left|\xi_{d}\right| \leq 1 / 2$ and

& \lesssim t^{1+c^{\prime}} .
\end{aligned}

If $\xi \in \mathbb{T}^{d}$ and $n \in \mathbb{Z}^{d}(d)$, then $\left|n_{l}\right| \asymp\left|n_{l}+\xi_{l}\right|$ for $1 \leq l \leq d$. We only estimate $I_{2}$ when the summation is over all $n \in S_{d, 1}$ and other cases can be handled similarly. Given any $n \in S_{d, 1}$, by Lemma 2.1 and lemma 2.2 we have

where $K_{L}(n)=\prod_{l=2}^{d}\left(n_{l} /|n|\right)^{\frac{m_{1, l}, l \omega_{l}-2}{m_{1}, \omega_{l}-1}}$ and using the subscript "L" is because that $K_{L}(n)$ is a "lower" bound of $K(x(n))$ in (2.6) if $n \in S_{d, 1}$. Hence

Similar to estimating the upper bound of $\sum_{n \in S_{d, 1}}|B(r, t, n)|^{2}$ in Lemma 3.2, there is a $0<\delta_{2}^{\prime}<1$ such that the summations above are bounded by $O\left(t(t \log (1 / t))^{\delta_{2}^{\prime}}\right)$.

For $I_{3}$, given any $s_{1}, s_{2} \in \mathbb{R}$ and nonzero $\xi_{1}, \xi_{2} \in \mathbb{R}^{d}$, a simple computation shows that

\operatorname{supp} \phi_{2}^{\epsilon}=\{s \in \mathbb{R}: \epsilon / 4 \leq s \leq 3 /(4 \epsilon)\},
\end{gathered}

and $\phi_{2}^{\epsilon}(s)=1$ if $3 \epsilon / 4 \leq s \leq 1 /(4 \epsilon)$.

\cos (4 \pi r x(n) \cdot n-(d-1) \pi / 2),
\end{gathered}

where $\epsilon>0$ is determined below.
If $n \in \mathbb{Z}^{d}(d) \cap \operatorname{supp}\left(1-\phi_{1}^{\epsilon}(n)\right)$, we have $\left|n_{j}\right| /|n| \leq 3 \epsilon / 4$ for some $1 \leq j \leq d$. Similar to the case of estimating $\sum_{n \in S_{d, 1}}|B(r, t, n)|^{2}$ under the condition (3.12) in Lemma 3.2, there is a $0<\Lambda<1$ such that

We only need to estimate the summation $\sum_{n \in \mathbb{Z}^{d}} \hat{f}(n / t)$. Let

& +\sum_{l=1}^{+\infty} \sum_{\left\{2^{l-1} \leq \mathrm{d}(n)<2^{l}\right\}} \epsilon^{-\tilde{\gamma}_{k}}\left(2^{l-1} t^{-1}\right)^{-k}
\end{aligned}

Note that Lemma 29 in [3, p. 195] implies that if $n \in\{0 \leq \mathrm{d}(n)<s\}$, then $|n| \geq r$. Hence

\lesssim & r^{(d-1)\left(1-1 / \omega^{\prime}\right)}+r^{d-1} s \\
\lesssim & r^{(d-1)\left(1-1 / \omega^{\prime}\right)} .

\epsilon^{-\tilde{\gamma}_{k}} s^{-k} t^{k} \sum_{\{s \leq \mathrm{d}(n)<1\}} 1 \lesssim \epsilon^{-\tilde{\gamma}_{k}} t^{k} r^{(d-1)\left(1+k / \omega^{\prime}\right)} \tag{3.22}
\end{equation*}
$$

with the choice $s=r^{-(d-1) / \omega^{\prime}}$ and

$$
\begin{equation*}
\sum_{l=1}^{+\infty} 2^{-l k} \sum_{\left\{2^{l-1} \leq \mathrm{d}(n)<2^{l}\right\}} 1=\sum_{l=1,2^{l} \leq 2 r}^{+\infty} 2^{-l k} r^{d-1} 2^{l}+\sum_{l=1,2^{l} \geq 2 r}^{+\infty} 2^{-l k} 2^{l d} \lesssim r^{d-1} \tag{3.23}
\end{equation*}
$$

Therefore, combing (3.20)-(3.23) yields

$$
\begin{aligned}
\sum_{n \in \mathbb{Z}^{d}} \hat{f}(n / t) & \lesssim \epsilon^{-\tilde{\gamma}_{k}} t^{\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)}\left(1+t^{k-\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}+\frac{k+1}{\omega^{\prime}}\right)}\right) \\
& \lesssim \epsilon^{-\tilde{\gamma}_{k}} t^{\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)}\left(1+r^{-\alpha k+\alpha \frac{d-1}{2}+(d-1)\left(\frac{1}{2}+\frac{1}{\omega^{\prime}}\right)+\frac{d-1}{\omega^{\prime}} k}\right) \\
& \lesssim \epsilon^{-\tilde{\gamma}_{k}} t^{\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)}
\end{aligned}
$$

where the second inequality holds because of $t \lesssim r^{-\alpha}$. So we get

$$
\begin{equation*}
I_{1}=r^{d-1} t \sum_{n \in \mathbb{Z}^{d}} \hat{f}(n / t) \lesssim r^{d-1} t \epsilon^{-\tilde{\gamma}_{k}} t^{\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)} . \tag{3.24}
\end{equation*}
$$

Hence if we take

$$
\epsilon=\left(t^{\frac{d-1}{2}} r^{(d-1)\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)}\right)^{1 /\left(\Lambda+\tilde{\gamma}_{k}\right)}
$$

combining (3.17), (3.18) and (3.24) yields

$$
Y(r, t) \lesssim I_{1}+I_{2}+I I \lesssim r^{d-1} t^{1+(d-1)\left(\frac{1}{2}-\frac{1}{\alpha}\left(\frac{1}{2}-\frac{1}{\omega^{\prime}}\right)\right) \Lambda /\left(\Lambda+\tilde{\gamma}_{k}\right)},
$$

where the implicit constant is independent of $r$ and $t$. This finishes the proof.

## 4. Appendix

## 1. Proof of Lemma 2.1.

Given any $x^{\prime} \in \partial \mathcal{B}$, we may assume $x^{\prime}$ has a small neighborhood denoted by $U_{x^{\prime}}$ on $\partial \mathcal{B}$ that can be given as a graph $x_{d}=f\left(x_{1}, \ldots, x_{d-1}\right)$ and the $d^{t h}$ component of $n\left(x^{\prime}\right)$ is positive, as all other cases can be proved similarly. Then

$$
\begin{equation*}
n(x)=\frac{\left(-\nabla f\left(x_{1}, \ldots, x_{d-1}\right), 1\right)}{\left(1+\left|\nabla f\left(x_{1}, \ldots, x_{d-1}\right)\right|^{2}\right)^{1 / 2}} \tag{4.1}
\end{equation*}
$$

For any $x \in U_{x^{\prime}}$, we can parameterize $x$ as

$$
x=x^{\prime}+\sum_{j=1}^{d} X_{j} \overrightarrow{\mathbf{t}^{j}},
$$

where $\overrightarrow{\mathbf{t}^{d}}=n\left(x^{\prime}\right)$ and

$$
\left\{\overrightarrow{\mathbf{t}}^{1}, \ldots, \overrightarrow{\mathbf{t}}^{d-1}\right\}=\left\{\left(t_{1}^{1}, \ldots, t_{d}^{1}\right), \ldots,\left(t_{1}^{d-1}, \ldots, t_{d}^{d-1}\right)\right\}
$$

is an orthonormal basis of the tangent plane of $\partial \mathcal{B}$ at $x^{\prime}$ such that the basis $\left\{\overrightarrow{\mathbf{t}}^{1}, \ldots, \overrightarrow{\mathbf{t}}^{d}\right\}$ has the same orientation as $\left\{\mathbf{e}_{\mathbf{1}}, \ldots, \mathbf{e}_{\mathbf{d}}\right\}$. It is easy to get that

$$
\begin{equation*}
\operatorname{det}\left(\left(t_{j}^{i}\right)_{i, j=1}^{d-1}\right)=\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{-1 / 2} \tag{4.2}
\end{equation*}
$$

Let

$$
F(X)=x_{d}^{\prime}+\sum_{j=1}^{d} X_{j} t_{d}^{j}-f\left(x_{1}^{\prime}+\sum_{j=1}^{d} X_{j} t_{1}^{j}, \ldots, x_{d-1}^{\prime}+\sum_{j=1}^{d} X_{j} t_{d-1}^{j}\right)
$$

Then for any $1 \leq i \leq d$,

$$
\partial_{X_{i}} F(\overrightarrow{0})= \begin{cases}\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{1 / 2} \overrightarrow{\mathbf{t}}^{d} \cdot \overrightarrow{\mathbf{t}}^{i}=0 & \text { if } i<d  \tag{4.3}\\ \left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{1 / 2} \neq 0 & \text { if } i=d\end{cases}
$$

Note that $x_{d}=f\left(x_{1}, \ldots, x_{d-1}\right)$ implies $F(X)=0$ and (4.3) ensures that there is a small neighborhood of $\overrightarrow{0}$ and a function $g$ defined in this neighborhood such that $g(\overrightarrow{0})=0, \nabla g(\overrightarrow{0})=\overrightarrow{0}$ and

$$
F\left(X_{1}, \ldots, X_{d-1}, g\left(X_{1}, \ldots, X_{d-1}\right)\right)=0
$$

Combining (4.2) and (4.3) yields

$$
\begin{aligned}
\operatorname{det}\left(\nabla^{2} g(\overrightarrow{0})\right) & =\frac{\left(\operatorname{det}\left(\left(t_{j}^{i}\right)_{i, j=1}^{d-1}\right)\right)^{2} \operatorname{det}\left(\nabla^{2} f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right)}{\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{(d-1) / 2}} \\
& =\frac{\operatorname{det}\left(\nabla^{2} f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right)}{\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{(d+1) / 2}} .
\end{aligned}
$$

Hence

$$
K\left(x^{\prime}\right)=\frac{\left|\operatorname{det}\left(\nabla^{2} f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right)\right|}{\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{(d+1) / 2}}
$$

If $K\left(x^{\prime}\right) \neq 0$. Let $\xi /|\xi|=n(x)$ and $\xi^{\prime} /\left|\xi^{\prime}\right|=n\left(x^{\prime}\right)$. Define

$$
\begin{aligned}
& \mathrm{G}\left(\xi_{1}, \ldots, \xi_{d}, x_{1}, \ldots, x_{d-1}\right) \\
& =\left(\xi_{1}+\xi_{d} \partial_{x_{1}} f\left(x_{1}, \ldots, x_{d-1}\right), \ldots, \xi_{d-1}+\xi_{d} \partial_{x_{d-1}} f\left(x_{1}, \ldots, x_{d-1}\right)\right)
\end{aligned}
$$

Then

$$
\begin{align*}
& \left|\operatorname{det}\left(D_{x} \mathbf{G}\left(\xi_{1}^{\prime}, \ldots, \xi_{d}^{\prime}, x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right)\right| \\
& =\xi_{d}^{\prime d-1}\left|\operatorname{det}\left(\nabla^{2} f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right)\right| \\
& =\xi_{d}^{\prime d-1} K\left(x^{\prime}\right)\left(1+\left|\nabla f\left(x_{1}^{\prime}, \ldots, x_{d-1}^{\prime}\right)\right|^{2}\right)^{(d+1) / 2}  \tag{4.4}\\
& \neq 0
\end{align*}
$$

Note that equation (4.1) implies

$$
\mathbf{G}\left(\xi_{1}, \ldots, \xi_{d}, x_{1}, \ldots, x_{d-1}\right)=\overrightarrow{0}
$$

The implicit function theorem and (4.4) ensure that there is a small neighborhood of $\xi^{\prime} /\left|\xi^{\prime}\right|$ on $S^{d-1}$ denoted by $V_{\xi^{\prime} /\left|\xi^{\prime}\right|}$ and functions $h_{1}, \ldots, h_{d-1}$ defined in $V_{\xi^{\prime} /\left|\xi^{\prime}\right|}$ such that for any $\xi /|\xi| \in V_{\xi^{\prime} /\left|\xi^{\prime}\right|}$,

$$
\mathbf{G}\left(\xi_{1}, \ldots, \xi_{d}, h_{1}\left(\xi_{1}, \ldots, \xi_{d}\right), \ldots, h_{d-1}\left(\xi_{1}, \ldots, \xi_{d}\right)\right)=\overrightarrow{0}
$$

and (2.2) and (2.3) can be obtained directly by calculation. This finishes the proof.

## 2. Proof of Lemma 2.2.

For the domain $\mathcal{D}$, given any nonzero $\xi \in \mathbb{R}^{d}$, we may assume $\xi_{i} \geq 0$ for $1 \leq i \leq d$ and $\xi_{d} /|\xi| \geq \varepsilon_{0}$, as all other cases can be proved similarly. Then there is a small neighbourhood of $x(\xi)$ on $\partial \mathcal{D}$ such that for any point $x$ in this neighborhood, the $d^{\text {th }}$ component

$$
\begin{aligned}
x_{d} & =\left(\left(1-\sum_{p=0}^{n-2}\left(\sum_{l=1+d_{p}}^{d_{p+1}} x_{l}^{\omega_{l}}\right)^{m_{p+1}}\right)^{1 / m_{n}}-\sum_{l=1+d_{n-1}}^{d-1} x_{l}^{\omega_{l}}\right)^{1 / \omega_{d}} \\
& =: f\left(x_{1}, x_{2}, \cdots, x_{d-1}\right)
\end{aligned}
$$

and $x_{d} \asymp 1$. Since $\xi /|\xi| \asymp\left(-\nabla f\left(x_{1}, \cdots, x_{d-1}\right), 1\right)$, we obtain

$$
\begin{equation*}
\xi_{i} /|\xi| \asymp\left(\sum_{l=1+d_{p(i)}}^{d_{p(i)+1}} x_{l}^{\omega_{l}}\right)^{m_{d, i}-1} x_{i}^{\omega_{i}-1} \tag{4.5}
\end{equation*}
$$

for $1 \leq i \leq d-1$, which implies

$$
\begin{equation*}
\left(\xi_{i} /|\xi|\right)^{1 /\left(\omega_{i}-1\right)} \lesssim x_{i} \lesssim\left(\xi_{i} /|\xi|\right)^{1 /\left(m_{d, i} \omega_{i}-1\right)} \tag{4.6}
\end{equation*}
$$

where the implicit constants depend on the domain $\mathcal{D}$ and $\varepsilon_{0}$.
By a straightforward calculation we have

$$
\begin{equation*}
\left|\operatorname{det}\left(\nabla^{2} f\right)\right| \asymp \prod_{i=1}^{d-1}\left(\sum_{l=1+d_{p(i)}}^{d_{p(i)+1}} x_{l}^{\omega_{l}}\right)^{m_{d, i}-1} x_{i}^{\omega_{i}-2} \tag{4.7}
\end{equation*}
$$

where the implicit constants depend on the domain $\mathcal{D}$ and $\varepsilon_{0}$. Combining (2.1), (4.5)-(4.7) yields

$$
\prod_{i=1}^{d-1}\left(\xi_{i} /|\xi|\right)^{\frac{m_{d, i} \omega_{i}-2}{m_{d, i} \omega_{i}-1}} \leq K(x(\xi)) \lesssim \prod_{i=1}^{d-1}\left(\xi_{i} /|\xi|\right)^{\frac{\omega_{i}-2}{\omega_{i}-1}}
$$

This finishes the proof.
3. Gaussian curvature of hypersurface $x(\xi) \cdot \xi=h$.

Given any $\xi \in\left\{\xi \in \mathbb{R}^{d} \backslash\{\overrightarrow{0}\}: x(\xi) \cdot \xi=h\right\}$, we may assume the $d^{t h}$ component $x_{d}(\xi) \geq \varepsilon_{0}$, as all other cases can be proved similarly. Let $F(\xi)=x(\xi) \cdot \xi-h$. Then $\nabla F(\xi)=x(\xi)$ implies that there is a neighborhood of $\xi$ such that $x(\xi) \cdot \xi=h$ can be written as $\xi_{d}=$ $g\left(\xi_{1}, \ldots, \xi_{d-1}\right)$ by the implicit function theorem. Moreover,

$$
\nabla g\left(\xi_{1}, \ldots, \xi_{d-1}\right)=\left(-x_{1}(\xi) / x_{d}(\xi), \ldots,-x_{d-1}(\xi) / x_{d}(\xi)\right)
$$

and

$$
\begin{align*}
& \operatorname{det}\left(\nabla^{2} g\left(\xi_{1}, \ldots, \xi_{d-1}\right)\right) \\
& =\left(x_{d}(\xi)\right)^{-2(d-1)} \operatorname{det}\left(\left(-x_{d}(\xi) \partial_{\xi_{j}} x_{i}(\xi)+x_{i}(\xi) \partial \xi_{j} x_{d}(\xi)\right)_{i, j=1}^{d-1}\right) . \tag{4.8}
\end{align*}
$$

Starting from the second row, add the $i^{\text {th }}$ row multiplied by $-x_{i-1} / x_{i}$ to the $(i-1)^{\text {th }}$ row for $i=2, \ldots, d-1$. Then

$$
\begin{align*}
& \operatorname{det}\left(\nabla^{2} g\left(\xi_{1}, \ldots, \xi_{d-1}\right)\right) \\
& =\left(x_{d}(\xi)\right)^{-(d-1)} \operatorname{det}\left(\left(-\frac{\partial x_{i}(\xi)}{\partial \xi_{j}}+\frac{x_{i}}{x_{i+1}} \frac{\partial x_{i+1}(\xi)}{\partial \xi_{j}}\right)_{i, j=1}^{d-1}\right) . \tag{4.9}
\end{align*}
$$

Since $x_{d}(\xi) \geq \varepsilon_{0}$, the boundary $\partial \mathcal{D}$ in a small neighborhood of $x(\xi)$ can be given as a graph $x_{d}=f\left(x_{1}, \ldots, x_{d-1}\right)$ and by (4.1)

$$
\frac{\partial x_{d}}{\partial \xi_{j}}=\sum_{l=1}^{d-1}-\xi_{l} \xi_{d}^{-1} \frac{\partial x_{l}}{\partial \xi_{j}}
$$

for $1 \leq j \leq d-1$. Plugging this equality into the $(d-1)^{t h}$ row in (4.9) and adding the $i^{\text {th }}$ row multiplied by

$$
\begin{cases}-\frac{x_{d-1} \xi_{1}}{x_{d} \xi_{d}} & \text { if } i=1 \\ -\sum_{l=1}^{i-1} \frac{x_{d-1} \xi_{l} x_{l}}{x_{d} \xi_{d} x_{i}}-\frac{x_{d-1} \xi_{i}}{x_{d} \xi_{d}} & \text { if } 2 \leq i \leq d-2\end{cases}
$$

to the $(d-1)^{\text {th }}$ row yields that the element in $(d-1)^{\text {th }}$ row and $j^{\text {th }}$ column becomes

$$
\left(-1-\sum_{l=1}^{d-1} \frac{\xi_{l} x_{l}}{x_{d} \xi_{d}}\right) \frac{\partial x_{d-1}(\xi)}{\partial \xi_{j}}=-\frac{h}{x_{d} \xi_{d}} \frac{\partial x_{d-1}(\xi)}{\partial \xi_{j}}
$$

where we use $x(\xi) \cdot \xi=h$. So the right side of (4.9) can be reduced to

$$
\frac{(-1)^{d-1} h}{\xi_{d} x_{d}^{d}} \operatorname{det}\left(\left(\frac{\partial x_{i}}{\partial \xi_{j}}\right)_{i, j=1}^{d-1}\right)=\frac{x_{d}^{-d} h \operatorname{det}\left(\left(A_{j i}\right)_{i, j=1}^{d-1}\right)}{\xi_{d}^{d}\left(\operatorname{det}\left(\nabla^{2} f\right)\right)^{d-1}}=\frac{x_{d}^{-d} h}{\xi_{d}^{d} \operatorname{det}\left(\nabla^{2} f\right)}
$$

where the first equality is because of (2.2) and

$$
\operatorname{det}\left(\left(A_{j i}\right)_{i, j=1}^{d-1}\right)=\left(\operatorname{det}\left(\nabla^{2} f\right)\right)^{d-2}
$$

since $\left(A_{j i}\right)_{i, j=1}^{d-1}$ is the adjoint matrix of $\nabla^{2} f$. Then

$$
\begin{aligned}
\widetilde{K}(\xi) & =\left(1+|\nabla g|^{2}\right)^{-(d+1) / 2}\left|\operatorname{det}\left(\nabla^{2} g\right)\right| \\
& =|x(\xi)|^{-(d+1)} \frac{x_{d} h}{\xi_{d}^{d} K(x(\xi))\left(1+|\nabla f|^{2}\right)^{(d+1) / 2}}
\end{aligned}
$$

Since $x_{d} \asymp 1$ and $h=x(\xi) \cdot \xi \asymp|\xi| \asymp \xi_{d}$, we have

$$
\widetilde{K}(\xi) \asymp(K(x(\xi)))^{-1} h^{-(d-1)} .
$$

This finishes the proof.
4. Counterexample.

In this part, we give an example to show that the assumption of the range of $\alpha$ in Theorem 1.1 cannot be removed. Let

$$
\mathcal{D}=\left\{x \in \mathbb{R}^{3}: x_{1}^{6}+x_{2}^{6}+x_{3}^{10} \leq 1\right\}
$$

and $\mathcal{D}(r, t)=(r+t / 2) \mathcal{D} \backslash(r-t / 2) \mathcal{D}$ with $r=k \in \mathbb{N}$ and $t=C r^{-2}$. In this case $\alpha=2<\max \left\{\alpha_{1}, \alpha_{2}, \alpha_{3}\right\}=4$ and

$$
\operatorname{vol}(\mathcal{D}(r, t))=\operatorname{vol}(\mathcal{D})\left(3 C+2(t / 2)^{3}\right)
$$

If $\left(0, k, x_{3}\right),\left(x_{1}, k, 0\right) \in \partial((k+t / 2) \mathcal{D})$ then

$$
x_{3}=\left(\left((k+t / 2)^{6}-k^{6}\right)(k+t / 2)^{4}\right)^{1 / 10} \geq\left(k^{9} t\right)^{1 / 10}
$$

and

$$
x_{1}=\left((k+t / 2)^{6}-k^{6}\right)^{1 / 6} \geq\left(k^{5} t\right)^{1 / 6} .
$$

For any $u \in[-1 / 2,1 / 2) \times[-t / 2,0] \times[-1 / 2,1 / 2)$, if $k$ is large enough,

$$
N_{\mathcal{D}(r, t)}(u)-\operatorname{vol}(\mathcal{D}(r, t)) \gtrsim\left(k^{9} t\right)^{1 / 10}\left(k^{5} t\right)^{1 / 6}-\operatorname{vol}(\mathcal{D}(r, t)) \gtrsim k^{6 / 5}
$$

Then

$$
\int_{\mathbb{T}^{3}}\left|N_{\mathcal{D}(r, t)}(u)-\operatorname{vol}(\mathcal{D}(r, t))\right|^{2} \mathrm{~d} u \gtrsim k^{12 / 5} t / 2 \gtrsim k^{2 / 5},
$$

which means the variance is much larger than $\operatorname{vol}(\mathcal{D}(r, t))$.
