# PARTIAL COACTIONS OF WEAK HOPF ALGEBRAS ON COALGEBRAS

#### Abstract

It will be seen that if $H$ is a weak Hopf algebra in the definition of coaction of weak bialgebras on coalgebras [15], then a definition property is suppressed giving rise to the (global) coactions of weak Hopf algebras on coalgebras. The next step will be introduce the more general notion of partial coactions of weak Hopf algebras on coalgebras as well as a family of examples via a fixed element on the weak Hopf algebra, illustrating both definitions: global and partial. Moreover, it will also be presented how to obtain a partial comodule coalgebra from a global one via projections, giving another way to find examples of partial coactions of weak Hopf algebras on coalgebras. In addition, the weak smash coproduct [15] will be studied and it will be seen under what conditions it is possible to generate a weak Hopf algebra structure from the coproduct and the counit defined on it. Finally, a dual relationship between the structures of partial action and partial coaction of a weak Hopf algebra on a coalgebra will be established.

## 1. Introduction

Partial action theory appeared firstly in 11 in the context of operator algebra. Later, in 10, M. Dokuchaev and R. Exel brought partial actions to a purely algebraic context contributing to the development of classical results, such as Galois theory, in the case of partial actions of groups on rings.

Following this line of research, S. Caenepeel and K. Janssen introduced the notions of partial actions and coactions of Hopf algebras on algebras in [6. The main idea of studying partial actions for the context of Hopf algebras is to generalize the results obtained for partial group actions to this broader context. The notions of partial actions and coactions of Hopf algebras on coalgebras appeared for the first time in [9], dualizing the structures introduced in [6].

As a natural task, in [8], was introduced the notion of partial actions of weak Hopf algebras on algebras. In this work, the authors extended many results of the classic theory for this setting.

We introduced in [7] the theory of partial actions of weak Hopf algebras on coalgebras, inspired by the notion of partial action of a Hopf algebra on a coalgebra, presented in 9. Basically, it was constructed in 7 a correspondence between a partial action of a groupoid $\mathcal{G}$ on a coalgebra $C$ and a partial action of the groupoid algebra $\mathbb{k} \mathcal{G}$ on the coalgebra $C$.

In the present work, we give successions to the theory of partial actions. The notion of partial and global coactions of weak Hopf algebras on coalgebras is introduced as well as some important properties and examples. In the sequel, we will study the weak smash coproduct presented in [15] in order to see under what conditions this structure is a weak Hopf algebra. We divide this paper as follows:

The second section is devoted to the study of weak Hopf algebras, their properties and some examples that will be commonly used throughout the text. A weak bialgebra is a vector space that has a structure of algebra and coalgebra simultaneously, with a compatibility property between these structures. The axioms of weak bialgebra appear for the first time in [4. If a weak bialgebra is provided with an anti-homomorphism of algebras and coalgebras, them we say that is a weak Hopf algebra. The main difference between a weak Hopf algebra and a Hopf algebra is that in the case of a Hopf algebra the counit is an algebra homomorphism.

[^0]The concept of coaction of a weak bialgebra on a coalgebra was introduced in [15]. In section 3, the coaction of a weak Hopf algebra on a coalgebra is presented. Generalizing this concept, the definition of partial coaction of a weak Hopf algebra on a coalgebra is exhibited with its properties and a family of examples. It is also ascertained what conditions are necessary and sufficient for a partial comodule coalgebra to be generated from a global comodule coalgebra via a projection.

Section 4 is intended to investigate the weak smash coproduct presented in 15 . The idea is to construct a weak Hopf algebra from the existing coalgebra structure in the weak smash coproduct. Historically, the construction of Hopf algebras and weak Hopf algebras from global and partial (co)actions has been studied by several authors. This can be seen in texts such as [1, [13] and [14. This shows a great concern in presenting new examples of such structures. Our contribution is to make the weak smash coproduct into a weak Hopf algebra under certain conditions.

From now, some notations will be fixed. It will be denoted by $\mathbb{k}$ a generic field, unless some additional specification is made about such structure. Moreover, every tensorial product will be considered over the field $\mathbb{k}$, then, it will be used the notation $\otimes$ instead of $\otimes_{\mathbb{k}}$. $A$ will always denote an algebra, $C$ a coalgebra and $H$ a weak Hopf algebra. Throughout the text other properties may be required over the structures $A, C$ e $H$, but they will be duly mentioned. Besides that, every map will be considered $\mathbb{k}$-linear and the vector spaces will be considered over the field $\mathbb{k}$. Finally, the isomorphism $V \otimes \mathbb{k} \simeq V \simeq \mathbb{k} \otimes V$ will be used automatically for every vector space $V$.

## 2. Preliminaries

In this section, we present few results of weak Hopf algebras. For more details we refer [2], 3] and 4].
A weak bialgebra $(H, m, u, \Delta, \varepsilon)$ (or simply $H$ ) is a vector space such that $(H, m, u)$ is an algebra, $(H, \Delta, \varepsilon)$ is a coalgebra, and, in addition, the following conditions are satisfied for all $h, k \in H$ :
(i) $\Delta(h k)=\Delta(h) \Delta(k)$;
(ii) $\varepsilon(h k \ell)=\varepsilon\left(h k_{1}\right) \varepsilon\left(k_{2} \ell\right)=\varepsilon\left(h k_{2}\right) \varepsilon\left(k_{1} \ell\right)$;
(iii) $\left(1_{H} \otimes \Delta\left(1_{H}\right)\right)\left(\Delta\left(1_{H}\right) \otimes 1_{H}\right)=\left(\Delta\left(1_{H}\right) \otimes 1_{H}\right)\left(1_{H} \otimes \Delta\left(1_{H}\right)\right)=\Delta^{2}\left(1_{H}\right)$.

Since $\Delta$ is multiplicative, we conclude that $\Delta(h)=\Delta\left(h 1_{H}\right)=\Delta\left(1_{H} h\right)$, then

It is possible to use $\varepsilon$ to define the following linear maps

Then, it can be defined the vector spaces $H_{t}=\varepsilon_{t}(H)$ and $H_{s}=\varepsilon_{s}(H)$. Thus, for any weak bialgebra $H$, every element $h \in H$ can be written as

Proposition 2.1. Let $H$ be a weak bialgebra. Then, the following properties hold for all $h, k \in H$

Therefore, $H_{t}$ and $H_{s}$ are subalgebras of $H$ such that contain $1_{H}$ and

Finally, it is still possible to show that

for all $h, k \in H$.
Let $H$ be a weak bialgebra. We say that $H$ is a weak Hopf algebra if there is a linear map $S: H \longrightarrow H$, called antipode, which satisfies:
(i) $h_{1} S\left(h_{2}\right)=\varepsilon_{t}(h)$;
(ii) $S\left(h_{1}\right) h_{2}=\varepsilon_{s}(h)$;
(iii) $S\left(h_{1}\right) h_{2} S\left(h_{3}\right)=S(h)$,
for all $h \in H$. The antipode of a weak Hopf algebra is anti-multiplicative, that is, $S(h k)=S(k) S(h)$, and anti-comultiplicative, which means $S(h)_{1} \otimes S(h)_{2}=S\left(h_{2}\right) \otimes S\left(h_{1}\right)$.

Proposition 2.2. Let $H$ be a weak Hopf algebra. Then, the following identities hold for all $h \in H$

Hence, if $H$ is a weak Hopf algebra, $S\left(1_{H}\right)=1_{H}, \varepsilon \circ S=\varepsilon, S\left(H_{t}\right)=H_{s}, S\left(H_{s}\right)=H_{t}$ and $S(H)$ is also a weak Hopf algebra, with the same counit and antipode. It is easy to see that every Hopf algebra is a weak Hopf algebra. Conversely we have the following result.

Proposition 2.3. A weak Hopf algebra is a Hopf algebra if one of the following equivalent conditions is satisfied:
(i) $\Delta\left(1_{H}\right)=1_{H} \otimes 1_{H}$;
(ii) $\varepsilon(h k)=\varepsilon(h) \varepsilon(k)$;
(iii) $h_{1} S\left(h_{2}\right)=\varepsilon(h) 1_{H}$;
(iv) $S\left(h_{1}\right) h_{2}=\varepsilon(h) 1_{H}$;
(v) $H_{t}=H_{s}=\mathbb{k} 1_{H}$;
for all $h, k \in H$.
In order to construct an example of weak Hopf algebra, we present the following definition.
Definition 2.4 (Groupoid). Consider $\mathcal{G}$ a non-empty set with a binary operation partially defined which is denoted by concatenation. This operation is called product. Given $g, h \in \mathcal{G}$, we write $\exists g h$ whenever the product $g h$ is set (similarly we use $\nexists g h$ whenever the product is not defined). Thus, $\mathcal{G}$ is called groupoid if:
(i) For all $g, h, l \in \mathcal{G}, \exists(g h) l$ if and only if $\exists g(h l)$, and, in this case, $(g h) l=g(h l)$;
(ii) For all $g, h, l \in \mathcal{G}, \exists(g h) l$ if and only if $\exists g h$ and $\exists h l$;
(iii) For each $g \in \mathcal{G}$ there are unique elements $d(g), r(g) \in \mathcal{G}$ such that $\exists g d(g), \exists r(g) g$ and $g d(g)=g=r(g) g$;
(iv) For each $g \in \mathcal{G}$ there exists an element such that $d(g)=g^{-1} g$ and $r(g)=g g^{-1}$.

Moreover, the element $g^{-1}$ is the only one that satisfies such property and, in addition, $\left(g^{-1}\right)^{-1}=g$, for all $g \in \mathcal{G}$. An element $e$ is said identity in $\mathcal{G}$ if for some $g \in \mathcal{G}, e=d(g)=r\left(g^{-1}\right)$. Therefore, $e^{2}=e$, which implies that $d(e)=e=r(e)$ and $e=e^{-1}$. We denote $\mathcal{G}_{0}$ the set of all identities elements of $\mathcal{G}$. Besides that, one can define the set $\mathcal{G}^{2}=\{(g, h) \in \mathcal{G} \times \mathcal{G} \mid \exists g h\}$ of all pairs of elements composable in $\mathcal{G}$.

Proposition 2.5. Let $\mathcal{G}$ be a groupoid. Then, for all $g, h \in \mathcal{G}$ :
(i) $\exists g h$ if and only if $d(g)=r(h)$ and, in this case, $d(g h)=d(h)$ and $r(g h)=r(g)$;
(ii) $\exists g h$ if and only if $\exists h^{-1} g^{-1}$ and, in this case, $(g h)^{-1}=h^{-1} g^{-1}$.

Example 2.6 (Groupoid Algebra). Let $\mathcal{G}$ be a groupoid such that the cardinality of $\mathcal{G}_{0}$ is finite and $\mathbb{k} \mathcal{G}$ the vector space with basis indexed by the elements of $\mathcal{G}$ given by $\left\{\delta_{g}\right\}_{g \in \mathcal{G}}$. Then, $\mathbb{k} \mathcal{G}$ is a weak Hopf algebra with the following structures

Remark that when it is assumed that the dimension of a weak Hopf algebra $H$ is finite, it is obtained that the dual structure $H^{*}=\operatorname{Hom}(H, \mathbb{k})$ is a weak Hopf algebra with the convolution product $(f * g)(h)=$ $m(f \otimes g)(h)=f\left(h_{1}\right) g\left(h_{2}\right)$ for all $h \in H$, the unit $u_{H^{*}}\left(1_{\mathrm{k}}\right)=1_{H^{*}}=\varepsilon_{H}$, the coprodut defined by the relation $\Delta_{H^{*}}(f)=f_{1} \otimes f_{2} \Leftrightarrow f(h k)=f_{1}(h) f_{2}(k)$ for all $h, k \in H$, and the counit $\varepsilon_{H^{*}}(f)=f\left(1_{H}\right)$. Besides that, we have $\left(\varepsilon_{t}\right)_{H^{*}}(f)=f \circ \varepsilon_{t}$ and $\left(\varepsilon_{s}\right)_{H^{*}}(f)=f \circ \varepsilon_{s}$.
Example 2.7 (Dual Groupoid Algebra). Let $\mathcal{G}$ be a finite groupoid and $(\mathbb{k} \mathcal{G})^{*}$ the vector space with basis indexed by the elements of $\mathcal{G}$ given by $\left\{p_{g}\right\}_{g \in \mathcal{G}}$, where

Then, $(\mathbb{k} \mathcal{G})^{*}$ is a weak Hopf algebra with the following structures

The following example of weak Hopf algebra was presented by G. Böhm and J. Gómes-Torrecillas in [3].
Example 2.8. Consider $G$ a finite abelian group with cardinality $|G|$, where $|G|$ is not a multiple of the characteristic of $\mathbb{k}$. If we consider $\mathbb{k} G$ the algebra with basis indexed by the elements of $G$ and with coalgebra structure given by

Then, $\mathbb{k} G$ is a weak Hopf algebra with antipode defined by $S(g)=g$. Besides that, $\varepsilon_{s}(g)=\varepsilon_{t}(g)=g$, for all $g \in G$, what implies that $H_{s}=H_{t}=\mathbb{k} G$.

## 3. Comodule Coalgebra

Consider $H$ a weak bialgebra. In [15, Yu. Wang and L. Zhang defined $C$ a (left) $H$-comodule coalgebra when there exits a linear map

such that for all $c \in C$

In this case, it is said that $H$ coacts on the coalgebra $C$.
Proposition 3.1. Let $H$ be a weak Hopf algebra. If there exists a linear map

that satisfies (CC1)-(CC3), then the condition (CC4) is satisfied.
Proof. Suppose that there is a linear map $\rho$ that satisfies the conditions (CC1)-(CC3), then for every $c \in C$

Example 3.2. [15] Consider $H$ a weak Hopf algebra finite dimensional. Then, $H$ is a $H^{*}$-comodule coalgebra defined by

where $\left\{h_{i}\right\}_{i=1}^{n}$ is a basis for $H$ and $\left\{h_{i}{ }^{*}\right\}_{i=1}^{n}$ is the dual basis for $H^{*}$.
3.1. Partial Comodule Coalgebra. In this section, the main purpose is to introduce the concept of a partial coaction of a weak Hopf algebra $H$ on a coalgebra. It is also introduced some examples that support the theory exposed here and some properties.

Definition 3.3. We say that $C$ is a (left) partial $H$-comodule coalgebra (or that $H$ coacts partially on $C$ ) if there exists a linear map

such that for all $c \in C$
(CCP1) $\left(\varepsilon_{H} \otimes I_{C}\right) \bar{\rho}(c)=c$
$(\mathrm{CCP} 2)\left(I_{H} \otimes \Delta_{C}\right) \bar{\rho}(c)=\left(m_{H} \otimes I_{C} \otimes I_{C}\right)\left(I_{H} \otimes \tau_{C, H} \otimes I_{C}\right)(\bar{\rho} \otimes \bar{\rho}) \Delta_{C}(c)$
(CCP3) $\left(I_{H} \otimes \bar{\rho}\right) \bar{\rho}(c)=\left(m_{H} \otimes I_{H} \otimes I_{C}\right)\left[\left(I_{H} \otimes \varepsilon_{C}\right)\left(\bar{\rho}\left(c_{1}\right)\right) \otimes\left(\Delta_{H} \otimes I_{C}\right)\left(\bar{\rho}\left(c_{2}\right)\right)\right]$.
Moreover, $C$ is said a (left) symmetric partial $H$-comodule coalgebra if, in addition, satisfies

$$
\left(I_{H} \otimes \bar{\rho}\right) \bar{\rho}(c)=\left(m_{H} \otimes I_{H} \otimes I_{C}\right)\left(I_{H} \otimes \tau_{H \otimes C, H}\right)\left[\left(\Delta_{H} \otimes I_{C}\right)\left(\bar{\rho}\left(c_{1}\right)\right) \otimes\left(I_{H} \otimes \varepsilon_{C}\right)\left(\bar{\rho}\left(c_{2}\right)\right)\right]
$$

Remark 3.4. Every $H$-comodule coalgebra is a partial $H$-comodule coalgebra. Indeed for every $c \in C$

\left(I_{H} \otimes \rho\right) \rho(c) & \stackrel{(C C 3)}{=} & c^{-1} \otimes c^{0-1} \otimes c^{00} \\
\stackrel{(C-1}{=} & c^{-1}{ }_{1} \otimes c^{-1}{ }_{2} \otimes c^{0} \\
\stackrel{(C C 2)}{=} & c_{1}{ }^{-1}{ }_{1} c_{2}{ }^{-1}{ }_{1} \otimes c_{1}{ }^{-1}{ }_{2} c_{2}{ }^{-1}{ }_{2} \otimes c_{2}{ }^{0} \varepsilon_{C}\left(c_{1}{ }^{0}\right) \\
\stackrel{3.1}{=} & \varepsilon_{t}\left(c_{1}{ }^{-1}\right)_{1} c_{2}{ }^{-1}{ }_{1} \otimes \varepsilon_{t}\left(c_{1}{ }^{-1}\right)_{2} c_{2}{ }^{-1}{ }_{2} \otimes c_{2}{ }^{0} \varepsilon_{C}\left(c_{1}{ }^{0}\right) \\

Proposition 3.5. Let $C$ be a partial $H$-comodule coalgebra. Then, $C$ is a $H$-comodule coalgebra if and only if $c^{\overline{-1}} \varepsilon_{C}\left(c^{\overline{0}}\right)=\varepsilon_{t}\left(c^{\overline{-1}}\right) \varepsilon_{C}\left(c^{\overline{0}}\right)$ for all $c \in C$.
Proof. Suppose that $C$ is a partial $H$-comodule coalgebra that satisfies $c^{\overline{-1}} \varepsilon_{C}\left(c^{\overline{0}}\right)=\varepsilon_{t}\left(c^{-1}\right) \varepsilon_{C}\left(c^{\overline{0}}\right)$, then it is enough to show that $\left(I_{H} \otimes \bar{\rho}\right) \bar{\rho}(c)=\left(\Delta_{H} \otimes I_{C}\right) \bar{\rho}(c)$ :

& \stackrel{11}{=} \varepsilon_{t}\left(c^{\overline{-1}}\right)_{1} \varepsilon_{C}\left(c_{1}{ }^{\overline{0}}\right) c_{2} \overline{-1}{ }_{1} \otimes \varepsilon_{t}\left(c^{\overline{-1}}\right)_{2} c_{2} \overline{-1}{ }_{2} \otimes c_{2}{ }^{\overline{0}} \\
& \stackrel{(C C P 2)}{=} c^{\overline{-1}}{ }_{1} \varepsilon_{C}\left(c^{\overline{0}}{ }_{1}\right) \otimes c^{-1}{ }_{2} \otimes c^{\overline{0}_{2}} \\
& =\quad\left(\Delta_{H} \otimes I_{C}\right) \bar{\rho}(c) .
\end{aligned}

Example 3.6. Consider $\mathbb{k} \mathcal{G}$ a groupoid algebra, where $\mathcal{G}$ is generated by the disjoint union of the finite groups $G_{1}$ and $G_{2}$. Therefore, the group algebra $\mathbb{k} G_{1}$ is a partial $(\mathbb{k} \mathcal{G})^{*}$-comodule coalgebra via

$$
\begin{aligned}
\rho: \mathbb{k} G_{1} & \rightarrow(\mathbb{k} \mathcal{G})^{*} \otimes \mathbb{k} G_{1} \\
h & \mapsto p_{e_{1}} \otimes h,
\end{aligned}
$$

where $e_{1}$ is the identity element of $G_{1}$.
3.2. Coactions via $\rho_{h}$. In this section it is explored a specific family of examples of partial comodule coalgebra. We say that $C$ is a (left) $H$-comodule coalgebra via $\rho_{h}$ if, for some $h \in H$ fixed, the linear map

$$
\begin{aligned}
\rho_{h}: C & \longrightarrow H \otimes C \\
c & \longmapsto h \otimes c
\end{aligned}
$$

defines a structure of comodule coalgebra on $C$. Note that since $H$ is a weak Hopf algebra, the above application does not always defines a structure of $H$-comodule coalgebra on $C$. To see this, it is enough to observe that $\rho_{1_{H}}(c)=1_{H} \otimes c$ turns out $C$ on a comodule coalgebra if and only if $H$ is a Hopf algebra. The following result has the intention to characterize the properties that an element $h \in H$ must to satisfy in order that $\rho_{h}$ be a coaction of $H$ on a coalgebra $C$.

Proposition 3.7. We say that $C$ is a (left) $H$-comodule coalgebra via $\rho_{h}$ if and only if
(i) $\varepsilon_{H}(h)=1_{\mathrm{k}}$
(ii) $h^{2}=h$
(iii) $\Delta_{H}(h)=h \otimes h$.

Proof. The proof follows immediately from the definition comodule coalgebra via $\rho_{h}$.
Besides that, if $h \in H$ satisfies the properties of Proposition 3.7, then $h=\varepsilon_{t}(h)$.
Example 3.8. Consider $\mathbb{k} \mathcal{G}$ the groupoid algebra generated by a groupoid $\mathcal{G}$. Thus, fixing an element $e \in \mathcal{G}_{0}$, $\rho_{\delta_{e}}$ ensure a structure of $\mathbb{k} \mathcal{G}$-comodule coalgebra on any coalgebra $C$ by Proposition 3.7,

Moreover, it is easy to see that $\rho_{\delta_{g}}$ gives a structure of $H$-comodule coalgebra on a coalgebra $C$ if and only if $g \in \mathcal{G}_{0}$.

Example 3.9. Consider $\mathfrak{k} G$ the weak Hopf algebra given in Example 2.8, $h$ an element in $G$ and $C$ a coalgebra. $C$ is a $\mathbb{k} G$-comodule coalgebra via $\rho_{h}$ if and only if $G=\left\{1_{G}\right\}$.

Thinking on the partial case, we say that $C$ is a (left) partial $H$-comodule coalgebra via $\overline{\rho_{h}}$, for some fixed $h \in H$, if the linear map

$$
\begin{aligned}
\overline{\rho_{h}}: C & \longrightarrow H \otimes C \\
c & \longmapsto h \otimes c
\end{aligned}
$$

determines a structure of partial $H$-comodule coalgebra on $C$.
Proposition 3.10. $C$ is a (left) partial $H$-comodule coalgebra via $\overline{\rho_{h}}$ if and only if
(i) $\varepsilon_{H}(h)=1_{\mathbb{k}}$
(ii) $\left(h \otimes 1_{H}\right) \Delta_{H}(h)=h \otimes h$.

Observe that if $h \in H$ satisfies the properties (i) and (ii), then $h^{2}=h$.
Proof. The proof follows immediately from the definition of partial $H$-comodule coalgebra via $\overline{\rho_{h}}$.
Note that $C$ is a symmetric partial $H$-comodule coalgebra via $\overline{\rho_{h}}$ if and only if
(i) $\varepsilon_{H}(h)=1_{\mathbb{k}}$
(ii) $\left(h \otimes 1_{H}\right) \Delta_{H}(h)=h \otimes h$
(iii) $\Delta_{H}(h)\left(h \otimes 1_{H}\right)=h \otimes h$.

Remark 3.11. If in addition $h \in H$ satisfies $h=\varepsilon_{t}(h)$, then $C$ is a $H$-comodule coalgebra.
If $\mathbb{k} G$ is the weak Hopf algebra given in Example 2.8 and $h$ is an element in $G$, then every parcial $\mathbb{k} G$-comodule coalgebra via $\rho_{h}$ is actually a (global) $\mathbb{k} G$-comodule coalgebra via $\rho_{h}$ thanks to Remark 3.11. The following example was inspired by Example 3.2 .3 of [12], where $\mathbb{k}$ is seen as a partial $\mathbb{k} \mathcal{G}$-comodule algebra.

Example 3.12. Consider $\mathbb{k} \mathcal{G}$ the groupoid algebra where the groupoid $\mathcal{G}$ is the disjoint union of the finites groups $G_{1}$ and $G_{2}$. Under these conditions, any coalgebra $C$ is a partial $\mathbb{k} \mathcal{G}$-comodule coalgebra via $\overline{\rho_{h}}$ where $h=\sum_{g \in G_{1}} \frac{1}{\left|G_{1}\right|} \delta_{g}$.

We can also characterize the coaction of the weak Hopf algebra $\mathbb{k} \mathcal{G}$ on $\mathbb{k}$ when $\mathcal{G}$ a finite groupoid.
Example 3.13. $\mathbb{k}$ is a partial $\mathbb{k} \mathcal{G}$-comodule coalgebra via $\overline{\rho_{h}}$ if and only if $h=\sum_{g \in N} \frac{1}{|N|} \delta_{g}$, for $N$ some group in $\mathcal{G}$.
Example 3.14. $\mathbb{k}$ is a partial $(\mathbb{k} \mathcal{G})^{*}$-comodule coalgebra via $\overline{\rho_{f}}$ if and only if $f=\sum_{g \in N} p_{g}$, where $N$ is a group in $\mathcal{G}$.
3.3. Induced Coaction. Let $H$ be a weak Hopf algebra and $C$ a coalgebra. Suppose that $C$ is a $H$-comodule coalgebra via

$$
\begin{array}{rll}
\rho: C & \longrightarrow H \otimes C \\
c & \longmapsto c^{-1} \otimes c^{0}
\end{array}
$$

Our goal in this section is to construct a symmetric partial $H$-comodule coalgebra from a $H$-comodule coalgebra. For this, consider $D \subseteq C$ a subcoalgebra of $C$ such that there exists a projection $\pi: C \rightarrow C$ onto $D$, i.e., $\pi(\pi(c))=\pi(c)$ for all $c \in C$, and $\operatorname{Im} \pi=D$. Under these conditions, it can be obtained the following result.

Proposition 3.15. $D$ is a symmetric partial $H$-comodule coalgebra via

$$
\begin{aligned}
\bar{\rho}: D & \longrightarrow H \otimes D \\
d & \longmapsto\left(I_{H} \otimes \pi\right) \rho(d)=d^{-1} \otimes \pi\left(d^{0}\right)
\end{aligned}
$$

if and only if the projection $\pi$ satisfies:
(i) $d^{-1} \otimes \Delta_{D}\left(\pi\left(d^{0}\right)\right)=d^{-1} \otimes(\pi \otimes \pi)\left(\Delta_{D}\left(d^{0}\right)\right)$;
(ii) $d^{-1} \otimes \pi\left(d^{0}\right)^{-1} \otimes \pi\left(\pi\left(d^{0}\right)^{0}\right)=d_{1}{ }^{-1} \varepsilon_{D}\left(\pi\left(d_{1}{ }^{0}\right)\right) d_{2}{ }^{-1}{ }_{1} \otimes d_{2}{ }^{-1}{ }_{2} \otimes \pi\left(d_{2}{ }^{0}\right)$

$$
=d_{1}{ }^{-1}{ }_{1} d_{2}{ }^{-1} \varepsilon_{D}\left(\pi\left(d_{2}{ }^{0}\right)\right) \otimes d_{1}{ }^{-1}{ }_{2} \otimes \pi\left(d_{1}{ }^{0}\right)
$$

for all $d \in D$. In this case we say that $\bar{\rho}$ is an induced coaction.
Proof. Suppose that $D$ is a symmetric partial $H$-comodule coalgebra via

$$
\bar{\rho}(c)=\left(I_{H} \otimes \pi\right) \rho(d)=d^{-1} \otimes \pi\left(d^{0}\right)
$$

Therefore,

$$
\begin{array}{ccl}
d^{-1} \otimes \Delta_{D}\left(\pi\left(d^{0}\right)\right) & = & \left(I_{H} \otimes \Delta_{D}\right)(\bar{\rho}(d)) \\
& \stackrel{(C C P 2)}{=} & \left(m_{H} \otimes I_{D} \otimes I_{D}\right)\left(I_{H} \otimes \tau_{H, D} \otimes I_{D}\right)(\bar{\rho} \otimes \bar{\rho}) \Delta_{D}(d) \\
& \stackrel{(C C 2)}{=} & d^{-1} \otimes(\pi \otimes \pi)\left(\Delta_{D}\left(d^{0}\right)\right) .
\end{array}
$$

Besides that,

$$
\begin{array}{rll}
d^{-1} \otimes \pi\left(d^{0}\right)^{-1} \otimes \pi\left(\pi\left(d^{0}\right)^{0}\right) & \stackrel{(C C P 3)}{=} & \left(I_{H} \otimes \bar{\rho}\right) \bar{\rho}(d) \\
& \stackrel{\left(m_{H} \otimes I_{H} \otimes I_{D}\right)\left[\left(I_{H} \otimes \varepsilon_{D}\right)\left(\bar{\rho}\left(d_{1}\right)\right) \otimes\left(\Delta_{H} \otimes I_{D}\right)\left(\bar{\rho}\left(d_{2}\right)\right)\right]}{=} & d_{1}{ }^{-1} \varepsilon_{D}\left(\pi\left(d_{1}{ }^{0}\right)\right) d_{2}{ }^{-1}{ }_{1} \otimes d_{2}{ }^{-1}{ }_{2} \otimes \pi\left(d_{2}{ }^{0}\right) .
\end{array}
$$

Analogously, using the symmetry condition,

$$
d^{-1} \otimes \pi\left(d^{0}\right)^{-1} \otimes \pi\left(\pi\left(d^{0}\right)^{0}\right) \quad=\quad\left(I_{H} \otimes \bar{\rho}\right) \bar{\rho}(d)
$$

$$
=d_{1}{ }^{-1}{ }_{1} d_{2}{ }^{-1} \varepsilon_{D}\left(\pi\left(d_{2}{ }^{0}\right)\right) \otimes d_{1}{ }^{-1}{ }_{2} \otimes \pi\left(d_{1}{ }^{0}\right)
$$

The converse is immediate.
Note that the induced coaction is a $H$-comodule coalgebra if and only if $\varepsilon_{t}\left(d^{-1}\right) \varepsilon_{D}\left(\pi\left(d^{0}\right)\right)=d^{-1} \varepsilon_{D}\left(\pi\left(d^{0}\right)\right)$ for all $d \in D$.

Example 3.16. Consider $G_{1}$ and $G_{2}$ finite groups, $\mathcal{G}$ the groupoid generated by the disjoint union of these groups and $\mathbb{k} \mathcal{G}$ its groupoid algebra. Define

$$
\begin{aligned}
\rho: \mathbb{k} G_{1} & \longrightarrow(\mathbb{k} \mathcal{G})^{*} \otimes \mathbb{k} G_{1} \\
h & \longmapsto \sum_{g \in G_{1}} p_{g} \otimes h g
\end{aligned}
$$

with $\{g\}_{g \in G_{1}}$ basis for the Hopf algebra $\mathbb{k} G_{1}$ and $\left\{p_{g}\right\}_{g \in \mathcal{G}}$ the dual basis for the weak Hopf algebra $(\mathbb{k} \mathcal{G})^{*}$. Thus, $\mathbb{k} G_{1}$ is a $(\mathbb{k} \mathcal{G})^{*}$-comodule coalgebra. Define

$$
\begin{aligned}
\pi: \mathbb{k} G_{1} & \rightarrow \mathbb{k} G_{1} \\
g & \mapsto \begin{cases}g, & \text { if } g \in D \\
0, & \text { otherwise },\end{cases}
\end{aligned}
$$

where $D=<l>_{\mathbb{k}}$, for some $l$ fixed in $G_{1}$. Then, $D$ is a symmetric partial $(\mathbb{k} \mathcal{G})^{*}$-comodule coalgebra by Proposition 3.15. Moreover, the induced coaction constructed is not global. Indeed, on the one hand,

$$
\begin{aligned}
& h^{-1} \varepsilon_{D}\left(\pi\left(h^{0}\right)\right)=\sum_{g \in G_{1}} p_{g} \varepsilon_{D}(\pi(h g)) \\
& \stackrel{h g=l}{=} p_{h^{-1} l} .
\end{aligned}
$$

On the other hand,

$$
\begin{aligned}
\varepsilon_{t_{(k \mathcal{G})^{*}}}\left(h^{-1}\right) \varepsilon_{D}\left(\pi\left(h^{0}\right)\right) & =\sum_{g \in G_{1}} \varepsilon_{t_{\mathfrak{k G}}{ }^{*}}\left(p_{g}\right) \varepsilon_{D}(\pi(h g)) \\
& \stackrel{h \underline{g=l}}{=} \varepsilon_{t_{(k \mathcal{G})^{*}}}\left(p_{h^{-1} l}\right) .
\end{aligned}
$$

Note that $p_{h^{-1} l} \neq \varepsilon_{(\mathbb{k G})^{*}}\left(p_{h^{-1} l}\right)$. Therefore, $D$ is not a global $(\mathbb{k} \mathcal{G})^{*}$-comodule coalgebra.

## 4. Weak Smash Coproduct

Yu. Wang and L. Yu. Zhang, in [15], introduced a new structure generated from a $H$ - comodule coalgebra, the weak smash coproduct. Therefore, a natural question arises: "Under what conditions the weak smash coproduct becomes a weak Hopf algebra?"

This section is destined to answer this question and to make a contribution to the existing theory. The weak smash coproduct was defined being the vector space $C \times H=<c^{0} \otimes h_{2} \varepsilon_{H}\left(c^{-1} h_{1}\right)>_{\mathfrak{k}}$ that has a specific structure of coalgebra. Initially we start showing that this structure of coalgebra is inherited from some properties of the vector space $C \otimes H$.

Proposition 4.1. The vector space $C \otimes H$ has a coassociative coproduct

$$
\Delta(c \otimes h)=c_{1} \otimes c_{2}^{-1} h_{1} \otimes c_{2}^{0} \otimes h_{2}
$$

Moreover, if $C$ is an algebra, then $C \otimes H$ is an algebra with product given by

$$
(c \otimes h)(d \otimes k)=(c d \otimes h k)
$$

and unit $1_{(C \otimes H)}=1_{C} \otimes 1_{H}$.

Proof. Indeed for all $c \in C$ and $h \in H$

\begin{aligned}
(I \otimes \Delta) \Delta(c \otimes h) & \stackrel{c_{1} \otimes c_{2}-1}{ } h_{1} \otimes c_{2}{ }^{0}{ }_{1} \otimes c_{2}{ }^{0}{ }_{2}{ }^{-1} h_{2} \otimes c_{2}{ }^{0}{ }_{2}{ }^{0} \otimes h_{3} \\
& \stackrel{(C C 2)}{=} \\
& c_{1} \otimes c_{2}{ }^{-1} c_{3}{ }^{-1} h_{1} \otimes c_{2}{ }^{0} \otimes c_{3}{ }^{0-1} h_{2} \otimes c_{3}{ }^{00} \otimes h_{3} \\
& \stackrel{(C C 3)}{=} \\
& c_{1} \otimes c_{2}{ }^{-1} c_{3}{ }^{-1}{ }_{1} h_{1} \otimes c_{2}{ }^{0} \otimes c_{3}{ }^{-1}{ }_{2} h_{2} \otimes c_{3}{ }^{0} \otimes h_{3} \\
& (\Delta \otimes I) \Delta(c \otimes h) .
\end{aligned}
$$

The properties of associativity and unit follow naturally.
Proposition 4.2. Let $H$ a weak Hopf algebra and $C$ a $H$-comodule coalgebra. Then, the vector space $C \times H=$ $<c^{0} \otimes h_{2} \varepsilon_{H}\left(c^{-1} h_{1}\right)>_{\mathbb{k}}$ is a coalgebra with counit $\varepsilon(c \times h)=\varepsilon_{C}\left(c^{0}\right) \varepsilon_{H}\left(c^{-1} h\right)$.

Proof. Indeed for all $c \in C$ and $h \in H$

\begin{aligned}
& \Delta(c \times h)=\Delta\left(c^{0} \otimes h_{2} \varepsilon_{H}\left(c^{-1} h_{1}\right)\right) \\
&=c^{0}{ }_{1} \otimes c^{0}{ }_{2}{ }^{-1} h_{2} \varepsilon_{H}\left(c^{-1} h_{1}\right) \otimes c^{0}{ }_{2}{ }^{0} \otimes h_{3} \\
&(\stackrel{C C}{=}) \\
& \stackrel{(C C 3)}{=} c_{1}{ }^{0} \otimes c_{2}{ }^{0-1} h_{2} \varepsilon_{H}\left(c_{1}{ }^{-1} c_{2}{ }^{-1} h_{1}\right) \otimes c_{2}{ }^{00} \otimes h_{3} \\
& c_{1}{ }^{=} \otimes c_{2}{ }^{-1}{ }_{2} h_{2} \varepsilon_{H}\left(c_{1}{ }^{-1} c_{2}{ }^{-1}{ }_{1} h_{1}\right) \otimes c_{2}{ }^{0} \otimes h_{3} \\
& c_{1}{ }^{0} \otimes\left(c_{2}{ }^{-1}{ }_{1}\right)_{2} h_{2} \varepsilon_{H}\left(c_{1}{ }^{-1}\left(c_{2}{ }^{-1}{ }_{1}\right)_{1} h_{1}\right) \otimes c_{2}{ }^{0} \otimes h_{4} \varepsilon_{H}\left(c_{2}{ }^{-1}{ }_{2} h_{3}\right) \\

Definition 4.3. Let $C$ a weak bialgebra and $H$ a weak Hopf algebra. We say that $C$ is a (left) $H$-comodule bialgebra if there exists a linear map $\rho: C \rightarrow H \otimes C$ such that $\rho$ defines simultaneously a structure of (left) $H$-comodule coalgebra and (left) $H$-comodule algebra in $C$.

From now, suppose that $C$ is a $H$-comodule bialgebra (then $C$ is a weak bialgebra) where $H$ is a commutative weak Hopf algebra. It follows from the commutativity of $H$ that $\varepsilon_{t}$ and $\varepsilon_{s}$ are multiplicatives. Moreover, S . Caenepeel and E. De Groot showed in [5] that

Therefore, we obtain the following result.
Proposition 4.8. Let $C$ be a weak bialgebra and $H$ a commutative weak Hopf algebra such that $C$ is a $H$ comodule bialgebra. Then, $C \times H$ is a weak bialgebra.

The next step is to know if we can give a weak Hopf algebra structure to $C \times H$. However, it is necessary to impose a natural condition on $C$, as it can be seen in Theorem 4.9.

Teorema 4.9. Let $C$ and $H$ be two weak Hopf algebras such that $C$ is a $H$-comodule bialgebra and $H$ is commutative. Then, $C \times H$ is a weak Hopf algebra.

Proof. By Proposition 4.8 we know that $C \times H$ is a weak bialgebra, so, it is enough to define a map $S_{C \times H}$ in $C \times H$ and show that $S_{C \times H}$ satisfies the properties of antipode of a weak Hopf algebra. Define $S_{C \times H}$ by

(III) $S\left((c \times h)_{1}\right)(c \times h)_{2} S\left((c \times h)_{3}\right)=S(c \times h)$, indeed for all $c \in C$ and $h \in H$

Therefore $C \times H$ is a weak Hopf algebra.

## 5. Dualization

In order to show that a partial coaction on a coalgebra can generate a partial action on a coalgebra, and vice versa, we need to assume the additional hypothesis that the weak Hopf algebra $H$ is finite dimensional. Thus, we know that the dual $H^{*}$ of $H$ is also a weak Hopf algebra.

Teorema 5.1. Let $C$ be a coalgebra and $H$ be a weak Hopf algebra finite dimensional. Then, the following affirmations are equivalent:
(i) $C$ is a left partial $H$-comodule coalgebra;
(ii) $C$ is a right partial $H^{*}$-module coalgebra.

Moreover, to say that $C$ is a left symmetric partial $H$-comodule coalgebra is equivalent to say that $C$ is a right symmetric partial $H^{*}$-module coalgebra.

Proof. Suppose that $C$ is a left symmetric partial $H$-comodule coalgebra via

$$
\begin{aligned}
\rho: C & \rightarrow H \otimes C \\
c & \mapsto c^{-1} \otimes c^{0}
\end{aligned}
$$

Then, $C$ is a right symmetric partial $H^{*}$-module coalgebra via

$$
\begin{aligned}
\leftharpoonup: C \otimes H^{*} & \rightarrow C \\
c \otimes f & \mapsto c \leftharpoonup f=f\left(c^{-1}\right) c^{0} .
\end{aligned}
$$

Conversely, suppose that $C$ is a right symmetric partial $H^{*}$-module coalgebra via

$$
\begin{aligned}
\leftharpoonup: C \otimes H^{*} & \rightarrow C \\
c \otimes f & \mapsto c \leftharpoonup f .
\end{aligned}
$$

Then, $C$ is a left symmetric partial $H$-comodule coalgebra via

$$
\begin{aligned}
\rho: C & \rightarrow H \otimes C \\
c & \mapsto \sum_{i=1}^{n}\left(h_{i} \otimes c \leftharpoonup h_{i}^{*}\right)
\end{aligned}
$$

where, $\left\{h_{i}\right\}_{i=1}^{n}$ is a basis of $H$ and $\left\{h_{i}\right\}_{i=1}^{n}$ is the dual basis of $H^{*}$.

Let $\lambda$ be an element in $H^{*}$. We say that $C$ is a (right) partial $H$-module coalgebra via $\lambda$ if $c \leftharpoonup h=c \lambda(h)$ defines a partial action of $H$ on the coalgebra $C$ for all $h \in H$ and $c \in C$. Moreover, in [7] it was proved that $C$ is a partial $H$-module coalgebra via $\lambda$ if and only if for all $h, k \in H$
(i) $\lambda\left(1_{H}\right)=1_{\mathbb{k}}$
(ii) $\lambda(h) \lambda(k)=\lambda\left(h_{1}\right) \lambda\left(h_{2} k\right)$.

Another result of dualization obtained is the one that says that the element $\lambda$ defined from the partial action via $\lambda$ is equal to the element defined from the partial coaction $\overline{\rho_{\lambda}}$ presented in Proposition 3.10 as can be seen as follows.

Corollary 5.2. $C$ is a right partial $H$-module coalgebra via $c \leftharpoonup h=c \lambda(h)$ if and only if $C$ is a left partial $H^{*}$-comodule coalgebra via $\overline{\rho_{\lambda}}(c)=\lambda \otimes c$.
Proof. It is enough to show that
(i) $\varepsilon_{H^{*}}(\lambda)=1_{\mathbb{k}}$, since $\varepsilon_{H^{*}}(\lambda)=\lambda\left(1_{H}\right) .=1_{\mathbb{k}}$
(ii) $\left(\lambda \otimes 1_{H^{*}}\right) \Delta(\lambda)=\lambda \otimes \lambda$, since for all $h, k \in H$

$$
\begin{aligned}
\left(\lambda \otimes 1_{H^{*}}\right) \Delta(\lambda)(h \otimes k) & =\left(\lambda \lambda_{1}\right)(h)\left(\lambda_{2}\right)(k) \\
& =\lambda\left(h_{1}\right) \lambda_{1}\left(h_{2}\right) \lambda_{2}(k) \\
& =\lambda\left(h_{1}\right) \lambda\left(h_{2} k\right) \\
& =\lambda(h) \lambda(k) \\
& =(\lambda \otimes \lambda)(h \otimes k) .
\end{aligned}
$$

The converse is immediate.
