# Blowup dynamics for Mass Critical Half-wave equation in 3D

#### Abstract

We consider the half-wave equation $i u_{t}=D u-|u|^{\frac{2}{3}} u$ in three dimension and in the mass critical. For initial data $u\left(t_{0}, x\right)=u_{0}(x) \in H_{r a d}^{1 / 2}\left(\mathbb{R}^{3}\right)$ with radial symmetry, we construct a new class of minimal mass blowup solutions with the blow up rate $\left\|D^{\frac{1}{2}} u(t)\right\|_{2} \sim \frac{C\left(u_{0}\right)}{|t|^{\frac{1}{4}}}$ as $t \rightarrow 0^{-}$.

## 1 Introduction and Main Results

In this paper, we consider the half-wave equation in three dimension

$$
\left\{\begin{array}{l}
i \partial_{t} u=D u-|u|^{\frac{2}{3}} u,  \tag{1.1}\\
u\left(t_{0}, x\right)=u_{0}(x), u: I \times \mathbb{R}^{3} \rightarrow \mathbb{C} .
\end{array}\right.
$$

Here, $I \subset \mathbb{R}$ is an interval containing the initial time $t_{0} \in \mathbb{R}$, and

$$
\widehat{(D f)}(\xi)=|\xi| \hat{f}(\xi)
$$

denotes the first-order nonlocal fractional derivative.
Let us mention that nonlinear half-wave equation has recently attracted some attention in the area of dispersive nonlinear PDE. Evolution problems like (1.1) arise in various physical settings, which include equations range from turbulence phenomena, wave propagation, continuum limits of lattice system and models for gravitational collapse in astrophysics $[6,10,12,18,19,24,29]$. We also refer to $[8,11$, $14,20]$ and the references therein for the background of the fractional Schrödinger model in mathematics and physics.

For equation (1.1), the quantities of charge $M(u)$ and energy $E(u)$ given by

\text { Mass } M(u) & =\int_{\mathbb{R}^{3}}|u(t, x)|^{2} d x,  \tag{1.2}\\
\text { Momentum } P(u) & =\int-i \nabla u(t, x) \bar{u}(t, x) d x,  \tag{1.3}\\
\text { Energy } E(u) & =\frac{1}{2} \int_{\mathbb{R}^{3}} \bar{u}(t, x) D u(t, x) d x-\frac{3}{8} \int_{\mathbb{R}^{3}}|u(t, x)|^{\frac{8}{3}} d x \tag{1.4}
\end{align*}
$$

are conserved. The equation (1.1) also has the following symmetry:

$$
u(t, x) \rightarrow \lambda_{0}^{\frac{3}{2}} u\left(\lambda_{0} t-t_{0}, \lambda_{0} x-x_{0}\right) e^{i \theta}
$$

for $\lambda_{0}>0, t_{0} \in \mathbb{R}, \theta \in \mathbb{R}$ and $x_{0} \in \mathbb{R}^{3}$.
The Cauchy problem (1.1) is $L^{2}$-critical since the $L^{2}$-norm is invariant under the scaling rule $u_{\lambda}(x)=\lambda^{3 / 2} u(\lambda x)$ :

$$
\left\|u_{\lambda}\right\|_{2}=\|u\|_{2}, \text { for all } \lambda>0
$$

From [2] we known that the Cauchy problem (1.1) is locally well-posed in energy space $H^{1 / 2}\left(\mathbb{R}^{3}\right)$. More precisely, for all $u_{0} \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$, there exists a unique solution $u(t) \in C\left([0, T) ; H^{1 / 2}\left(\mathbb{R}^{3}\right)\right)$ to (1.1). Moreover, we have the blowup alternative that if $u(t)$ is the unique solution with its maximal time of existence $t_{0}<T \leq \infty$, then

$$
\begin{equation*}
T<+\infty \text { implies } \lim _{t \rightarrow T^{-}}\|u(t)\|_{H^{1 / 2}}=+\infty \tag{1.5}
\end{equation*}
$$

A classical criterion of global-in-time existence for $H^{1 / 2}\left(\mathbb{R}^{3}\right)$ initial data is derived by using the Gagliardo-Nirenberg inequality with best constant

$$
\|u\|_{L^{5 / 3}}^{\frac{5}{3}} \leq C_{\text {opt }}\left\|D^{\frac{1}{2}} u\right\|_{2}^{2}\|u\|_{2}^{\frac{2}{3}}, \text { for } u \in H^{1 / 2}\left(\mathbb{R}^{3}\right)
$$

where $C_{\text {opt }}=\frac{4}{3}\|Q\|_{2}^{-\frac{2}{3}}$ and $Q$ is the unique ground state solution to

$$
\begin{equation*}
D Q+Q=|Q|^{\frac{2}{3}} Q, Q(x)>0, Q(x) \in H^{1 / 2}\left(\mathbb{R}^{3}\right) \tag{1.6}
\end{equation*}
$$

Note that the existence of this equation follows from standard variational techniques, but the uniqueness of $Q$, which was obtained by Frank, Lenzmann and Silvestre in [13]. The mass and energy conservation and the blowup criterion (1.5) implies that initial data $u_{0} \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$ with $\left\|u_{0}\right\|_{2}<\|Q\|_{2}$ generate global-in-time solution. In addition, the study of general half-wave equation attracted a great quantity of attentions; the topics cover over well-posedness, ill-posedness, traveling solitary waves, soliton waves, see $[2-4,7,16,17,23,27]$ and the references therein.

In this paper, we focus on the existence of nondispersive dynamics, we will describe example of such dynamics:

Minimal mass blowup solution. There is no general criterion for blowup solutions for $L^{2}$-critical or $L^{2}$-supercritical half-wave equation in $\mathbb{R}^{N}$. This is still an open problem, which we can see [5]. However, Krieger, Lenzmann and Raphaël [22] constructed a minimal mass blow-up solutions to the mass critical half-wave equation in one dimension. We also obtained the two-dimensional result, see [15]. Now we state our main result.

Theorem 1.1 (Existence of minimal mass blowup elements) For all $\left(E_{0}, P_{0}\right) \in$ $\mathbb{R}_{+}^{*} \times \mathbb{R}^{3}$, there exists $t^{*}<0$ independent of $E_{0}, P_{0}$, and a radial minimal mass solution $u \in C^{0}\left(\left[t^{*}, 0\right) ; H^{1 / 2}\left(\mathbb{R}^{3}\right)\right)$ of equation (1.1) with

$$
\|u(t)\|_{2}=\|Q\|_{2}, E(u(t))=E_{0}, \quad P(u(t))=P_{0},
$$

which blow up at time $T=0$. More precisely, it holds that

$$
u(t, x)-\frac{1}{\lambda(t)^{\frac{3}{2}}} Q\left(\frac{x-\alpha(t)}{\lambda(t)}\right) e^{i \gamma(t)} \rightarrow 0 \text { in } L^{2}\left(\mathbb{R}^{3}\right) \text { as } t \rightarrow 0^{-},
$$

where

$$
\lambda(t)=\lambda^{*} t^{2}+\mathcal{O}\left(t^{3}\right), \alpha(t)=x_{0}+\mathcal{O}\left(t^{3}\right), \gamma(t)=\frac{1}{\lambda^{*}|t|}+\mathcal{O}(t)
$$

with some constant $\lambda^{*}>0$, and the blowup speed is given by:

$$
\left\|D^{\frac{1}{2}} u(t)\right\|_{2} \sim \frac{C\left(u_{0}\right)}{|t|^{\frac{1}{4}}}
$$

where $C\left(u_{0}\right)>0$ only depend on the initial data $u_{0}$.

Remark 1.2 1. Unlike one or two dimensional case, we need to find some new technicalities to estimate the nonlinear term. In particular, the following estimate plays an important role in our discuss

$$
\begin{equation*}
\left\||x|^{-\frac{1}{q_{1}}} \int_{0}^{t} e^{i(t-s) D} F(s) d s\right\|_{L^{q_{1}}(\mathbb{R}) ; L^{2}\left(\mathbb{R}^{N}\right)} \leq C\left\||x|^{\frac{1}{q_{2}}} F\right\|_{L^{q_{2}(\mathbb{R}) ; L^{2}\left(\mathbb{R}^{N}\right)}}, \tag{1.7}
\end{equation*}
$$

where $q_{1} \in[2,+\infty]$ and $q_{2} \in(2,+\infty]$.
2. In our discussion, the radial assumption of $u$ is necessary. For any $u \in H^{1} \mathbb{R}^{3}$, we do not know how to deal with the nonlinear term in section 4.
3. In this article, we only give the blowup speed, but this rate is not sharp.

This paper is organized as follows: in section 2, we construct the approximate blowup profile; in section 3, we estimate the parameter is small enough; in section 4, we define the new energy functional and obtain the bound estimate; in section 5, we
apply the energy estimate to establish a bootstrap argument; in section 6 we prove the existence of minimal mass blowup solutions; the finally section is Appendix.

## Notations and definitions

- $(f, g)=\int \bar{f} g$ as the inner product on $L^{2}\left(\mathbb{R}^{3}\right)$.
- $\|\cdot\|_{L^{p}}$ denotes the $L^{p}\left(\mathbb{R}^{3}\right)$ norm for $p \geq 1$.
- $\widehat{f}$ denotes the Fourier transform of function $f$.
- We shall use $X \lesssim Y$ to denote that $X \leq C Y$ holds, where the constant $C>0$ may change from line to line, but $C$ is allowed to depend on universally fixed quantities only.
- Likewise, we use $X \sim Y$ to denote that both $X \lesssim Y$ and $Y \lesssim X$ hold.

For a sufficiently regular function $f: \mathbb{R}^{3} \rightarrow \mathbb{C}$, we define the generator of $L^{2}$ scaling given by

\Lambda f:=\frac{3}{2} f+x \cdot \nabla f
$$

Note that the operator $\Lambda$ is skew-adjoint on $L^{2}\left(\mathbb{R}^{3}\right)$, that is, we have

$$
(\Lambda f, g)=-(f, \Lambda g)
$$

We write $\Lambda^{k} f$, with $k \in \mathbb{N}$, for the iterates of $\Lambda$ with the convention that $\Lambda^{0} f \equiv f$.
In some parts of this paper, it will be convenient to identity any complex-valued function $f: \mathbb{R}^{3} \rightarrow \mathbb{C}$ with the function $\mathbf{f}: \mathbb{R}^{3} \rightarrow \mathbb{R}^{2}$ by setting

$$
\mathbf{f}=\left[\begin{array}{l}
f_{1} \\
f_{2}
\end{array}\right]=\left[\begin{array}{c}
\Re f \\
\Im f
\end{array}\right]
$$

Corresponding, we will identity the multiplication by $i$ in $\mathbb{C}$ with the multiplication by the real $2 \times 2$-matrix defined as

$$
J=\left[\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right] .
$$

## 2 Approximate Blowup Profile

This section is devoted to the construction of the approximate blowup profile. We start with a general observation: If $u=u(t, x)$ solves (1.1), then we define the
function $v=v(s, y)$ by setting

$$
u(t, x)=\frac{1}{\lambda^{\frac{3}{2}}(t)} v\left(t, \frac{x-\alpha(t)}{\lambda(t)}\right) e^{i \gamma(t)}, \quad \frac{d s}{d t}=\frac{1}{\lambda(t)}
$$

It is easy to check that $v=v(s, y)$ with $y=\frac{x-\alpha}{\lambda}$ satisfies

$$
i \partial_{s} v-D v-v+|v|^{\frac{2}{3}} v=i \frac{\lambda_{s}}{\lambda} \Lambda v+i \frac{\alpha_{s}}{\lambda} \cdot \nabla v+\tilde{\gamma}_{s} v
$$

where we set $\tilde{\gamma}_{s}=\gamma_{s}-1$. Here the operators $D$ and $\nabla$ are understood as $D=D_{y}$ and $\nabla=\nabla_{y}$, respectively. Following the slow modulated ansatz strategy developed in $[21,22,28]$. We freeze the modulation

$$
-\frac{\lambda_{s}}{\lambda}=b, \quad \frac{\alpha_{s}}{\lambda}=\beta
$$

Here $\beta$ is a vector. And we look for the approximate solution of the form

$$
v(s, y)=Q_{\mathcal{P}(s)}(y), \mathcal{P}(s)=(b(s), \beta(s))
$$

with an expansion

$$
Q_{\mathcal{P}}=Q(y)+\sum_{k \geq 1} b^{k} R_{k, 0}(y)+\sum_{k+l \geq 1} b^{k} \sum_{j=1}^{3} \beta_{j}^{l} R_{k, l, j},
$$

where $\mathcal{P}=(b, \beta) \in \mathbb{R} \times \mathbb{R}^{3}$. The terms $R_{k, 0}(y), R_{k, l, j}(y)$ are decomposed in real and imaginary parts as follows

$$
R_{k, 0}(y)=T_{k, 0}+i S_{k, 0} \text { and } R_{k, l, j}(y)=T_{k, l, j}+i S_{k, l, j} .
$$

We also use the notation

$$
T_{k, l}=\left(T_{k, l, 1}, T_{k, l, 2}, T_{k, l, 3}\right) \text { and } S_{k, l}=\left(S_{k, l, 1}, S_{k, l, 2}, S_{k, l, 3}\right)
$$

We will define ODE for $b(s)$ and $\beta(s)$ of type

$$
b_{s}=P_{1}(b, \beta), \quad \beta_{s}=P_{2}(b, \beta),
$$

where $P_{1}$ and $P_{2}$ are approximate polynomials in $b$ and $\beta$. We adjust the modulation equation for $\left(b_{s}, \beta_{s}\right)$ to ensure the solvability of the obtained system, and a specific algebra leads to the laws to leading order:

$$
b_{s}=-\frac{1}{2} b^{2}, \beta_{s}=-b \beta
$$

This allows us to construct a high order approximation $Q_{\mathcal{P}}$ solution to
$-i \frac{b^{2}}{2} \partial_{b} Q_{\mathcal{P}}-i b \sum_{j=1}^{3} \beta_{j} \partial_{\beta_{j}} Q_{\mathcal{P}}-D Q_{\mathcal{P}}-Q_{\mathcal{P}}+i b \Lambda Q_{\mathcal{P}}-i \beta \cdot \nabla Q_{\mathcal{P}}+\left|Q_{\mathcal{P}}\right|^{\frac{2}{3}} Q_{\mathcal{P}}=-\Phi_{\mathcal{P}}$,
where $\Phi_{\mathcal{P}}$ is some small and well-localized error term.
We have the following result about an approximate blowup profile $\mathbf{Q}_{\mathcal{P}}$, parameterized by $\mathcal{P}=(b, \beta)$, around the ground state $\mathbf{Q}=[Q, 0]^{\top}$.

Lemma 2.1 (Approximate Blowup Profile) Let $\mathcal{P}=(b, \beta) \in \mathbb{R} \times \mathbb{R}^{3}$. There exists a smooth function $\mathbf{Q}_{\mathcal{P}}=\mathbf{Q}_{\mathcal{P}}(x)$ of the form

$$
\begin{align*}
\mathbf{Q}_{\mathcal{P}}= & \mathbf{Q}+b \mathbf{R}_{1,0}+\beta \cdot \mathbf{R}_{0,1}+a \sum_{j=1}^{3} b_{j} \mathbf{R}_{1,1, j}+b^{2} \mathbf{R}_{2,0} \\
& +\sum_{j=1}^{3} \beta_{j}^{2} \mathbf{R}_{0,2, j}+b^{3} \mathbf{R}_{3,0}+b^{2} \beta \cdot \mathbf{R}_{2,1}+b^{4} \mathbf{R}_{4,0} \tag{2.1}
\end{align*}
$$

that satisfies the equation

$$
\begin{array}{r}
-J \frac{1}{2} b^{2} \partial_{b} \mathbf{Q}_{\mathcal{P}}-J b \sum_{j=1}^{3} \beta_{j} \partial_{\beta_{j}} \mathbf{Q}_{\mathcal{P}}-D \mathbf{Q}_{\mathcal{P}}-\mathbf{Q}_{\mathcal{P}}+J b \Lambda \mathbf{Q}_{\mathcal{P}} \\
-J \sum_{j=1}^{3} \beta_{j} \partial_{\beta_{j}} \mathbf{Q}_{\mathcal{P}}+\left|\mathbf{Q}_{\mathcal{P}}\right|^{\frac{2}{3}} \mathbf{Q}_{\mathcal{P}}=-\boldsymbol{\Phi}_{\mathcal{P}} \tag{2.2}
\end{array}
$$

Here the functions $\left\{\mathbf{R}_{k, l}\right\}_{0 \leq k \leq 3,0 \leq l \leq 1}$ satisfy the following regularity and decay bounds:

$$
\begin{array}{r}
\left\|\mathbf{R}_{k, l}\right\|_{H^{m}}+\left\|\Lambda \mathbf{R}_{k, l}\right\|_{H^{m}}+\left\|\Lambda^{2} \mathbf{R}_{k, l}\right\|_{H^{m}} \leq 1, \text { for } m \in \mathbb{N} \\
\left|\mathbf{R}_{k, l}\right|+\left|\Lambda \mathbf{R}_{k, l}\right|+\left|\Lambda^{2} \mathbf{R}_{k, l}\right| \leq\langle x\rangle^{-4}, \text { for } x \in \mathbb{R}^{3} . \tag{2.4}
\end{array}
$$

Moreover, the term on the right-hand side of (2.2) satisfies

$$
\begin{equation*}
\left\|\boldsymbol{\Phi}_{\mathcal{P}}\right\|_{H^{m}} \leq \mathcal{O}\left(b^{5}+\beta^{2} \mathcal{P}\right),\left|\nabla \boldsymbol{\Phi}_{\mathcal{P}}\right| \leq \mathcal{O}\left(b^{5}+\beta^{2} \mathcal{P}\right)\langle x\rangle^{-4} \tag{2.5}
\end{equation*}
$$

for $m \in \mathbb{N}$ and $x \in \mathbb{R}^{3}$.
In addition, the mass, the energy and the linear momentum of $\mathbf{Q}_{\mathcal{P}}$ satisfy

$$
\begin{aligned}
\int\left|\mathbf{Q}_{\mathcal{P}}\right|^{2} & =\int Q^{2}+\mathcal{O}\left(b^{4}+\beta^{2}+\beta \mathcal{P}^{2}\right) \\
E\left(\mathbf{Q}_{\mathcal{P}}\right) & =e_{1} b^{2}+\mathcal{O}\left(b^{4}+\beta^{2}+\beta \mathcal{P}^{2}\right) \\
P\left(\mathbf{Q}_{\mathcal{P}}\right) & =p_{1} \beta+\mathcal{O}\left(b^{4}+\beta^{2}+\beta \mathcal{P}^{2}\right)
\end{aligned}
$$

Here $\beta^{2}=\sum_{j, k=1}^{3} \beta_{j} \beta_{k}$ and $e_{1}>0$ and $p_{1}>0$ are the positive constants given by

$$
e_{1}=\frac{1}{2}\left(L_{-} S_{1,0}, S_{1,0}\right), \quad p_{1}=2 \int_{\mathbb{R}^{3}} L_{-} S_{0,1} \cdot S_{0,1},
$$

where $S_{1,0}$ and $S_{0,1}$ satisfy $L_{-} S_{1,0}=\Lambda Q$ and $L_{-} S_{0,1}=-\nabla Q$, respectively.
Proof. We recall that the definition of linear operator

$$
L_{+}=D+1-\frac{5}{3} Q^{2 / 3}, L_{-}=D+1-Q^{2 / 3}
$$

From [13] we have the key property that the kernel of $L_{+}$and $L_{-}$is given by

$$
\operatorname{ker} L_{+}=\left\{\partial_{x_{1}} Q, \partial_{x_{3}} Q, \partial_{x_{3}} Q\right\} \text { and } \operatorname{ker} L_{-}=\{Q\} .
$$

It follows from the above properties (see [1] for the properties of Helmholtz kernel and [9, Appendix A] or proof of [26, Lemma 3.2] for similar arguments) that

\begin{array}{r}
\forall g \in L^{2},(g, \nabla Q)=0, \exists f_{+} \in L^{2}, L_{+} f_{+}=g \\
\forall g \in L^{2},(g, Q)=0, \exists f_{-} \in L^{2}, L_{-} f_{-}=g \tag{2.6}
\end{array}
$$

Using the above property (2.6), we discuss our ansatz for $Q_{\mathcal{P}}$ to solve (4.1) order by order. Following the similar argument, see [15, 22], we can prove this lemma, and here we omit the details.

Remark 2.2 1. We know that $Q_{\mathcal{P}}$ has the following form

Q_{\mathcal{P}}=Q+i b S_{1,0}+i \beta \cdot S_{0,1}+b \beta \cdot T_{1,1}+b^{2} T_{2,0}+\sum_{j=1}^{3} \beta_{j}^{2} T_{0,2, j}
$$

$$
+b^{3} T_{3,0}+i b^{2} \beta \cdot S_{2,1}+b^{4} T_{4,0} .
$$

2. We have the following identity:

$$
\begin{equation*}
\left(S_{1,0}, S_{1,0}\right)=-2\left(T_{2,0}, Q\right) \tag{2.7}
\end{equation*}
$$

3. $T_{k, l}$ and $S_{k, l}$ have the following symmetry properties:

$$
\begin{array}{r}
S_{1,0}, T_{2,0}, T_{0,2}, S_{3,0}, S_{4,0} \text { are radial symmetry }, \\
S_{0,1}, T_{1,1}, S_{2,1} \text { are antisymmetry. }
\end{array}
$$

## 3 Geometrical Decomposition and Modulation Equation

Let $u \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$ be a radial solution of (1.1) on some time interval $\left[t_{0}, t_{1}\right]$ with $t_{1}<0$. Assume that $u(t)$ admits a geometrical decomposition of the form

$$
\begin{equation*}
u(t, x)=\frac{1}{\lambda^{\frac{3}{2}}(t)}\left[Q_{\mathcal{P}(t)}+\epsilon\right]\left(s, \frac{x-\alpha(t)}{\lambda(t)}\right) e^{i \gamma(t)}, \quad \frac{d s}{d t}=\frac{1}{\lambda(t)}, \tag{3.1}
\end{equation*}
$$

with $\mathcal{P}(t)=(b(t), \beta(t))$, and we impose the uniform smallness bound

$$
b^{2}(t)+|\beta(t)|+\|\epsilon\|_{H^{1 / 2}}^{2} \ll 1
$$

Furthermore, we assume that $u(t)$ has almost critical mass in the sense that

$$
\begin{equation*}
\left.\left|\int\right| u(t)\right|^{2}-\int Q^{2} \mid \lesssim \lambda^{2}(t), \quad \forall t \in\left[t_{0}, t_{1}\right] \tag{3.2}
\end{equation*}
$$

To fix the modulation parameters $\{b(t), \beta(t), \lambda(t), \alpha(t), \gamma(t)\}$ uniquely, we impose the following orthogonality conditions on $\epsilon=\epsilon_{1}+i \epsilon_{2}$ as follows:

\left(\epsilon_{2}, \Lambda Q_{1 \mathcal{P}}\right)-\left(\epsilon_{1}, \Lambda Q_{2 \mathcal{P}}\right)=0 \\
\left(\epsilon_{2}, \partial_{b} Q_{1 \mathcal{P}}\right)-\left(\epsilon_{1}, \partial_{b} Q_{2 \mathcal{P}}\right)=0 \\
\left(\epsilon_{2}, \partial_{\beta_{j}} Q_{1 \mathcal{P}}\right)-\left(\epsilon_{1}, \partial_{\beta_{j}} Q_{2 \mathcal{P}}\right)=0
\end{array}
$$

$$
\begin{array}{r}

the function $\rho=\rho_{1}+i \rho_{2}$ is defined by

Moreover, it is easy to see that the right-hand side in the equation for $\rho_{2}$ is orthogonality to $Q$. Indeed

Moreover, we clearly see that $\frac{2}{3} Q^{-\frac{1}{3}} \beta \cdot S_{0,1} \rho_{1}-\beta \cdot \nabla \rho_{1}-\beta \cdot T_{1,1} \perp Q$, since $S_{0,1, j}$ and $T_{1,1, j}$ are the antisymmetry functions, whereas $\rho_{1}$ and $Q$ are radial symmetry functions. Hence $\rho_{2}$ is well-defined.

In the conditions (3.3), we use the notation

Here $A=O(1)$ is invertible $9 \times 9$-matrix, and $B=\mathcal{O}(\mathcal{P})$ is some $9 \times 9$-matrix that is polynomial in $\mathcal{P}=(b, \beta)$. For $|\mathcal{P}| \ll 1$, we can thus invert $A+B$ by Taylor expansion and derive the estimate for $\operatorname{Mod}(t)$ stated in this lemma.

## 4 Refined Energy bounds

In this section, we establish a refined energy estimate, which will be a key ingredient in the compactness argument to construct minimal mass blowup solutions. Let $u=u(t, x)$ be a radial solution (1.1) on the time interval $\left[t_{0}, 0\right)$ and suppose that $w$ is a radial approximate solution to (1.1) such that

## 5 Backwards Propagation of small

We now apply the energy estimate of the previous section in order to establish a bootstrap argument that will be needed in the construction of minimal mass blowup solution. Let $u=u(t, x)$ be a radial solution to (1.1) defined in $\left[t_{0}, 0\right)$. Assume that $t_{0}<t_{1}<0$ and suppose that $u$ admits on $\left[t_{0}, t_{1}\right]$ a geometrical decomposition of the form

& \leq K^{2} \lambda^{\frac{1}{2}}\|\epsilon\|_{2}+\frac{K^{2} \lambda\|\epsilon\|_{2}+\lambda^{\frac{5}{2}}}{\lambda^{2}}\left(K \lambda^{\frac{1}{2}}\|\epsilon\|_{2}+K^{2} \lambda^{2}\right) \\
& \leq o\left(\frac{\|\epsilon\|_{2}^{2}}{\lambda^{\frac{3}{2}}}\right)+K^{4} \lambda^{\frac{5}{2}}
\end{align*}
$$

Moreover, we also used that $L_{+} \nabla Q=0$ and $L_{+} \Lambda Q=-Q$ together with the improved bound in Lemma 3.2, combined with the fact that $\left|\left(\epsilon_{1}, Q\right)\right| \leq \lambda^{\frac{1}{2}}\|\epsilon\|_{2}+K^{2} \lambda^{2}$, which follows from $\|\epsilon\|_{2} \leq \lambda$ and the conservation of $L^{2}$-norm. And the proof of this lemma is complete.

## 6 Existence of minimal mass blowup solutions

In this section, we prove the following result.
Theorem 6.1 Let $\gamma_{0} \in \mathbb{R}, x_{0} \in \mathbb{R}^{3}, P_{0} \in \mathbb{R}^{3}$ and $E_{0}>0$ be given. Then there exist a time $t_{0}<0$ and a radial solution $u \in C^{0}\left(\left[t_{0}, 0\right) ; H^{\frac{1}{2}}\left(\mathbb{R}^{3}\right)\right)$ of (1.1) such that $u$ blowup at time $T=0$ with

$$
E(u(t))=E_{0}, P(u(t))=P_{0}, \text { and }\|u(t)\|_{2}^{2}=\|Q\|_{2}^{2}
$$

Furthermore, we have $\left\|D^{\frac{1}{2}} u(t)\right\|_{2} \sim t^{-\frac{1}{4}}$ as $t \rightarrow 0^{-}$, and $u$ is of the form

$$
u(t, x)=\frac{1}{\lambda^{\frac{3}{2}}(t)}\left[Q_{\mathcal{P}(t)}+\epsilon\right]\left(t, \frac{x-\alpha}{\lambda}\right) e^{i \gamma(t)}=\tilde{Q}+\tilde{u}
$$

where $\mathcal{P}(t)=(b(t), \beta(t))$, and $\epsilon$ satisfies the orthogonality condition (3.3). Finally, the following estimate hold:

$$
\begin{aligned}
& \|\tilde{u}\|_{2} \lesssim \lambda,\|\tilde{u}\|_{H^{1 / 2}} \lesssim \lambda^{\frac{1}{2}} \\
& \lambda(t)-\frac{t^{2}}{4 A_{0}^{2}}=\mathcal{O}\left(\lambda^{2}\right), \frac{b}{\lambda^{\frac{1}{2}}}-\frac{1}{A_{0}}=\mathcal{O}(\lambda), \frac{\beta}{\lambda}(t)-B_{0}=\mathcal{O}(\lambda) \\
& \gamma(t)=-\frac{4 A_{0}^{2}}{t}+\gamma_{0}+\mathcal{O}\left(\lambda^{\frac{1}{2}}\right), \alpha(t)=x_{0}+\mathcal{O}\left(\lambda^{\frac{3}{2}}\right)
\end{aligned}
$$

Here $A_{0}>0$ is the constant defined in (5.3) and $B_{0}$ defined in (5.4).
Proof. Following ideas in $[15,22]$, we can easily obtain this result. Here we omit details.

## A Appendix

In this section, we will give some lemmas, which are very important but the proof is relatively simple. By standard arguments as $[15,22]$, we can obtain the following results. Here we omit the details.

In the following, we assume that $A>0$ is a sufficiently large constant. Let $\phi: \mathbb{R} \rightarrow \mathbb{R}$ be the smooth cutoff function introduced in Section 4. For $\epsilon=\epsilon_{1}+i \epsilon_{2} \in$ $H^{1 / 2}\left(\mathbb{R}^{3}\right)$, we consider the quadratic forms

$$
\begin{align*}
L_{+, A}\left(\epsilon_{1}\right) & :=\int_{s=0}^{\infty} \sqrt{s} \int \Delta \phi_{A}\left|\nabla\left(\epsilon_{1}\right)_{s}\right|^{2} d x d s+\int\left|\epsilon_{1}\right|^{2}-\frac{3}{8} \int Q^{\frac{2}{3}}\left|\epsilon_{1}\right|^{2}  \tag{A.1}\\
L_{-, A}\left(\epsilon_{2}\right) & :=\int_{s=0}^{\infty} \sqrt{s} \int \Delta \phi_{A}\left|\nabla\left(\epsilon_{2}\right)_{s}\right|^{2} d x d s+\int\left|\epsilon_{2}\right|^{2}-\int Q^{\frac{2}{3}}\left|\epsilon_{2}\right|^{2} \tag{A.2}
\end{align*}
$$

where $\Delta \phi_{A}=\Delta\left(\phi\left(\frac{x}{A}\right)\right)$. As in lemma 4.1, we denote

$$
\begin{equation*}
u_{s}=\sqrt{\frac{2}{\pi}} \frac{1}{-\Delta+s} u, \text { for } s>0 \tag{A.3}
\end{equation*}
$$

We start with the following simple identity.
For $u \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$, we have

$$
\begin{equation*}
\int_{0}^{\infty} \sqrt{s} \int_{\mathbb{R}^{3}}\left|\nabla u_{s}\right|^{2} d x d s=\left\|D^{1 / 2} u\right\|_{2}^{2} \tag{A.4}
\end{equation*}
$$

Indeed, by applying Fubini's theorem and using Fourier transform, we find that

$$
\int_{0}^{\infty} \sqrt{s} \int_{\mathbb{R}^{3}}\left|\nabla u_{s}\right|^{2} d x d s=\frac{2}{\pi} \int_{\mathbb{R}^{3}} \int_{0}^{\infty} \frac{\sqrt{s}}{\left(\xi^{2}+s\right)^{2}}|\xi|^{2}|\hat{u}(\xi)|^{2} d \xi=\left\|D^{1 / 2} u\right\|_{2}^{2}
$$

In particular, we have

$$
\begin{equation*}
\frac{2}{\pi} \int_{0}^{\infty} \sqrt{s} \int_{\mathbb{R}^{3}}\left|D^{\alpha} u_{s}\right|^{2} d x d s=\left\|D^{\alpha-\frac{1}{2}} u\right\|_{2}^{2} \tag{A.5}
\end{equation*}
$$

Next, we establish a technical result, which show that, when taking the limit $A \rightarrow$ $+\infty$, the quadratic form $\int_{0}^{\infty} \sqrt{s} \int \Delta \phi_{A}\left|\nabla u_{s}\right|^{2} d x d s+\|u\|_{2}^{2}$ defines a weak topology that serves as a useful substitute for weak convergence in $H^{1 / 2}\left(\mathbb{R}^{3}\right)$. The precise statement reads as follows.

Lemma A. 1 Let $A_{n} \rightarrow \infty$ and suppose that $\left\{u_{n}\right\}_{n=1}^{\infty}$ is a sequence in $H^{1 / 2}\left(\mathbb{R}^{3}\right)$ such that

$$
\int_{0}^{\infty} \sqrt{s} \int \Delta \phi_{A_{n}}\left|\nabla\left(u_{n}\right)_{s}\right|^{2} d x d s+\left\|u_{n}\right\|_{2}^{2} \leq C
$$

for some constant $C>0$ independent of $n$. Then, after possibly passing to a subsequence of $\left\{u_{n}\right\}_{n=1}^{\infty}$, we have that

$$
u_{n} \rightharpoonup u \text { weakly in } L^{2}\left(\mathbb{R}^{3}\right) \text { and } u_{n} \rightarrow u \text { strongly in } L_{l o c}^{2}\left(\mathbb{R}^{3}\right),
$$

and $u \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$. Moreover, we have the bound

$$
\left\|D^{1 / 2} u\right\|_{2}^{2} \leq \liminf _{n \rightarrow \infty} \int_{0}^{\infty} \sqrt{s} \int \Delta \phi_{A_{n}}\left|\nabla\left(u_{n}\right)_{s}\right|^{2} d x d s
$$

Lemma A. 2 Let $L_{+, A}\left(\epsilon_{1}\right)$ and $L_{-, A}\left(\epsilon_{2}\right)$ be the quadratic forms defined in (A.1) and (A.2), respectively. Then there exist a constant $C_{0}>0$ and $A_{0}>0$ such that, for all $A \geq A_{0}$ and all $\epsilon=\epsilon_{1}+i \epsilon_{2} \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$, we have the coercivity estimate

$$
\left(L_{+, A} \epsilon_{1}, \epsilon_{1}\right)+\left(L_{-, A} \epsilon_{2}, \epsilon_{2}\right) \geq C_{0} \int|\epsilon|^{2}-\frac{1}{C_{0}}\left\{\left(\epsilon_{1}, Q\right)^{2}\right.
$$

$$
\begin{equation*}
\left.+\left(\epsilon_{1}, S_{1,0}\right)^{2}+\left|\left(\epsilon_{1}, S_{0,1}\right)\right|^{2}+\left|\left(\epsilon_{2}, \rho_{1}\right)\right|^{2}\right\} \tag{A.6}
\end{equation*}
$$

Here $S_{1,0}$ and $S_{0,1}$ are the unique functions such that $L_{-} S_{1,0}=\Lambda Q$ with $\left(S_{1,0}, Q\right)=0$ and $L_{-} S_{0,1}=-\nabla Q$ with $\left(S_{0,1}, Q\right)=0$, respectively, and the function $\rho_{1}$ is defined in (3.4).

Lemma A. 3 For any $u \in L^{2}\left(\mathbb{R}^{3}\right)$, we have the bound

$$
\left.\left|\int_{s=0}^{+\infty} \sqrt{s} \int \Delta^{2} \phi_{A}\right| u_{s}\right|^{2} d x d s \left\lvert\, \leq \frac{1}{A}\|u\|_{2}^{2}\right.
$$

Lemma A. 4 Let $L_{+} \epsilon_{1}$ and $L_{-} \epsilon_{2}$ be the defined as section 2, respectively. Then there exist a constant $C_{0}>0$ and $A_{0}>0$ such that, for all $A \geq A_{0}$ and all $\epsilon=$ $\epsilon_{1}+i \epsilon_{2} \in H^{1 / 2}\left(\mathbb{R}^{3}\right)$, we have the coercivity estimate

$$
\begin{align*}
\left(L_{+} \epsilon_{1}, \epsilon_{1}\right)+\left(L_{-} \epsilon_{2}, \epsilon_{2}\right) \geq & C_{0} \int|\epsilon|^{2}-\frac{1}{C_{0}}\left\{\left(\epsilon_{1}, Q\right)^{2}\right. \\
& \left.+\left(\epsilon_{1}, S_{1,0}\right)^{2}+\left|\left(\epsilon_{1}, S_{0,1}\right)\right|^{2}+\left|\left(\epsilon_{2}, \rho_{1}\right)\right|^{2}\right\} . \tag{A.7}
\end{align*}
$$

Here $S_{1,0}$ and $S_{0,1}$ are the unique functions such that $L_{-} S_{1,0}=\Lambda Q$ with $\left(S_{1,0}, Q\right)=0$ and $L_{-} S_{0,1}=-\nabla Q$ with $\left(S_{0,1}, Q\right)=0$, respectively, and the function $\rho_{1}$ is defined in (3.4).
