Linear-Sample Learning of Low-Rank Distributions

Abstract

Many latent-variable applications, including community detection, collaborative filtering, genomic analysis, and NLP, model data as generated by low-rank matrices. Yet despite considerable research, except for very special cases, the number of samples required to efficiently recover the underlying matrices has not been known. We determine the onset of learning in several common latent-variable settings. For all of them, we show that learning $k \times k$, rank-r, matrices to normalized L_1 distance ϵ requires $\Omega(\frac{kr}{\epsilon^2})$ samples, and propose an algorithm that uses $\mathcal{O}(\frac{kr}{\epsilon^2}\log^2\frac{r}{\epsilon})$ samples, a number linear in the high dimension, and nearly linear in the, typically low, rank. The algorithm improves on existing spectral techniques and runs in polynomial time. The proofs establish new results on the rapid convergence of the spectral distance between the model and observation matrices, and may be of independent interest.

1 Introduction

1.1 Motivation

A great many scientific and technological applications concern relations between two objects that range over large domains, yet are linked via a low-dimensional *latent* space. Often this relation is precisely, or nearly, linear, hence can be modeled by a low-rank matrix. The problem of recovering low-rank model matrices from observations they generate has therefore been studied extensively. Following are five of the most common settings considered, each introduced via a typical application.

Distribution matrices In *Probabilistic latent semantic analysis* samples are co-occurrences (w,d) of words and documents, assumed independent given one of r latent topic classes t [Hof99]. The joint probability matrix $[p_{w,d}]$ is therefore a mixture of at most r product matrices $p(d|t) \cdot p(w|t)$, and has rank $\leq r$. This setting also arises in many hidden Markov applications, e.g., [MR05, HKZ12].

For this setting, the model matrix is a distribution, hence its elements are non-negative and sum to 1. The model is sampled independently n times, and $X_{i,j}$ is the number of times pair (i,j) was observed. In other settings, the model matrix consists of arbitrary parameters, it is sampled just once, and each parameter is reflected in an independent observation $X_{i,j}$.

Poisson Parameters Recommendation systems infer consumer preferences from their consumption patterns. The number of times customer i purchases product j is typically modeled as an independent Poisson random variable $X_{i,j} \sim \operatorname{Poi}(\lambda_{i,j})$. Often $\lambda_{i,j}$ is the inner product the consumer's disposition and product's expression of r latent features [SKKR00], so the parameter matrix $[\lambda_{i,j}]$ has rank $\leq r$.

Bernoulli Parameters In *inhomogeneous Erdös-Rényi graphs*, the edge between nodes i and j is an independent random variable $X_{i,j} \sim \text{Ber}(p_{i,j})$. In *Community-detection*, the Stochastic Block Model (SBM), e.g., [Abb17, MNS18, ABH15, BLM15], assumes that graph nodes fall in few communities C_1, \ldots, C_r such that the $p_{i,j}$'s are one constant if i and j are in the same community, and a different constant if i and j are in two distinct communities. Clearly, the parameter matrix $[p_{i,j}]$ has rank $\leq r$.

Binomial Parameters The probability that gene pair (i, j) will express as a phenotype is often viewed the result of a few factors, resulting in an expression probability matrix $[p_{i,j}]$ of low rank at most r [KMA16]. In a study of t phenotypic patients, the number $X_{i,j}$ of patients with gene pair (i, j) will therefore be distributed binomially $\text{Bin}(t, p_{i,j})$.

Collaborative filtering Let $Y_{i,j} \in [0,1]$ be the random rating user i assigns to movie j. Assuming a small number r of intrinsic film features, the matrix $[F_{i,j}]$, where $F_{i,j} = \mathbb{E}[Y_{i,j}]$, would have rank at most r. Since only some ratings are reported, the matrix-completion and collaborative-filtering literature, e.g., [BCLS17], assumes that $\mathbb{1}_{i,j} \sim \operatorname{Ber}(p)$ are independent indicator random variables, and upon observing $X_{i,j} = \mathbb{1}_{i,j} \cdot Y_{i,j}$ for all (i,j) we wish to recover the mean matrix $[F_{i,j}]$.

Each of these five settings has been studied in many additional contexts, including word embedding [SCH15], Genomic Analysis [ZLWY14, ZHPA13], and more [AGH+14].

1.2 Unified formulation

We first unify the five settings, facilitating the interpretation of their matrix norm as the number of observations, and allowing us to subsequently show that all models have essentially the same answer.

Both our lower and upper bounds for recovering $k \times m$ matrices depend only on the larger of k and m. Hence without loss of generality we assume square model matrices. Let $\mathbb{R}^{k \times k}$ be the collection of $k \times k$ real matrices, and let $\mathbb{R}^{k \times k}_r$ be its subset of matrices with rank at most r.

Note that in the first four models, $X_{i,j}$ is the number of times pair (i,j) was observed. For example, for the Poisson model, it is the number of times customer i bought product j. Hence $||X||_1 = \sum_{i,j} X_{i,j}$ is the total number of observations. In collaborative filtering, $X_{i,j} = \mathbbm{1}_{i,j} \cdot Y_{i,j}$ does not carry the same interpretation, still $||X||_1 = \sum_{i,j} X_{i,j}$ will concentrate around $p \cdot k^2 \cdot F_{i,j}^{\text{avg}}$, hence will be proportional to the expected number of observations, pk^2 .

We therefore scale the matrix M so that $M_{i,j} = E(X_{i,j})$ reflects the expected number of observations of $X_{i,j}$. We let M be $n \cdot [p_{i,j}]$ for distribution matrices, $[\lambda_{i,j}]$ for Poisson parameters, $[p_{i,j}]$ for Bernoulli parameters, $[t \cdot p_{i,j}]$ for Binomial parameters, and $[p \cdot F_{i,j}]$ for collaborative filtering. Consequently, for all models $M = \mathbb{E}[X]$, hence $||M||_1 = ||\mathbb{E}[X]||_1$ is the expected number of observations.

Let M be an unknown model matrix for one of the five settings, and let $X \sim M$ be a resulting observation matrix. We would like to recover M from X. A model estimator is a mapping M^{est} : $\mathbb{R}^{k \times k} \to \mathbb{R}^{k \times k}$ that associates with an observation X an estimated model matrix $M^{\text{est}} := M^{\text{est}}(X)$.

Different communities have used different measures for how well $M^{\rm est}$ approximates M. For example community detection concerns the recovery of labels, a criterion quite specific to this particular application. Many other works considered recovery in squared-error, or Forbenius, norm, but as argued in Section 1.4, this measure is less meaningful for the applications we consider.

Perhaps the most apt estimation measure, and the one we adopt, is L_1 distance, the standard Machine-Learning accuracy measure. L_1 arises naturally in numerous applications and is the main criterion used for learning distributions. Since M has non-unitary norm, we normalize the L_1 distance between M and its estimate $M^{\rm est}$,

$$L(M^{\text{est}}) := L_M(M^{\text{est}}) := ||M^{\text{est}} - M||_1 / ||M||_1.$$

Note that for distribution matrices, this reduces to the standard L_1 norm. Also, similar to total variation distance, $L(M^{\text{est}})$ upper bounds the absolute difference between the expected and predicted number of occurrences of pairs (i,j) in any subset $S \subseteq [k] \times [k]$, normalized by the total observations.

While the multitude of applications has drawn considerable amount of work on these latent variable model, a lot more work assumes that the number of samples are plenty, way beyond the information theoretic limit, or assumes more stronger assumptions on the model matrix then just low rank, and limiting its applicability. We show recovery is possible with only linear number of samples in all these models and with no other assumptions on low rank matrix M.

1.3 Overview of the background, main results and techniques

Recovery of distribution-matrices (the first model) in L_1 distance was first addressed in [HKKV18]. They considered matrices M that can be factored as UWU^{T} where W is $r \times r$ and positive semi-definite, and U is non-negative. They derived a polynomial-time algorithm that requires $\mathcal{O}(w_M k r^2 / \epsilon^5)$

samples, where $w_{\scriptscriptstyle M} \geq r^2$, hence at best guaranteeing sample complexity $\mathcal{O}(kr^4/\epsilon^5)$, and potentially much higher. Note however that their definition applies only to positive semi-definite, and not general matrices M, and even then, r is at least the rank of M, and can be significantly higher.

We first lower bound the accuracy of any estimator. An array of kr elements can be viewed as a special case of a $k \times k$ matrix of rank r. Simply place the array's kr elements in the matrix's first r rows, and set the remaining rows to zero. A well-known lower bound for learning discrete distributions, or arrays of Poisson parameters, in L_1 distance [KOPS15, HJW15] therefore implies:

Theorem 1. For any k, r, $\epsilon < 1$, and $M \in \mathbb{R}^{k \times k}_r$, let $X \sim M$ via the Poisson parameters or distribution matrix model. Then for any, possibly random, estimator M^{est} ,

$$\sup_{M \in \mathbb{R}^{k \times k}_r : ||M||_1 \le kr/\epsilon^2} \mathbb{E}_{X \sim M}[L(M^{est}(X))] = \Omega(\epsilon).$$

The bound implies that achieving expected normalized L_1 error $< \epsilon$ requires expected number of observations $||M||_1 = \Omega(kr/\epsilon^2)$. Equivalently, any estimator incurs an expected normalized L_1 error at least $\Omega(\min\{\sqrt{kr/||M||_1},1\})$.

Our main result is a polynomial-time algorithm *curated SVD* that returns an estimate $M^{\text{cur}} := M^{\text{cur}}(X)$ that essentially achieves the lower bound for all five models and all matrices M.

Theorem 2. Curated SVD runs in polynomial time, and for every $k, r, \epsilon > 0$, and $M \in \mathbb{R}_r^{k \times k}$ with $||M||_1 \ge \frac{kr}{\epsilon^2} \cdot \log^2 \frac{r}{\epsilon}$, if $X \sim M$, then with probability $\ge 1 - k^{-2}$,

$$L(M^{cur}(X)) = \mathcal{O}(\epsilon).$$

A few observations are in order. While [HKKV18] provides weaker guarantees and only for a special subclass of matrices, Curated SVD achieves essentially the lower bound for all matrices. It also holds for all five models. It recovers M with $O(kr\log^2 r)$ observations. This number is linear in the large matrix dimension k, and near linear in the typically small rank r. This is the first such result for general matrices.

In many applications, only a small number of observations is available per row and column. For example on average each viewer may rate only few movies, and a person typically has few friends. Hence the number of observations is near linear in the dimension k. Our results are the first to enable general learning these regimes.

With n samples, general discrete distributions over k elements can be learned to L_1 distance $\Theta(\sqrt{k/n})$. Theorems 1 and 2 show that essentially the same result holds for L_1 learning of low-rank matrices. The number of parameters is kr, the number of observations is $||M||_1$, and the normalized L_1 error is between $\sqrt{kr/||M||_1}$ and $\sqrt{kr/||M||_1} \log(r||M||_1/k)$.

To obtain these results we generalize a recent work [LLV17] that bounds the spectral distance between M and X. This bound requires the strong condition that each entry of the corresponding Bernoulli parameter matrix M should be within a constant factor from the average. The paper asked whether such results can be achieved for more general sparse graphs, possibly with the aid of regularization. We provide a counter example showing that such strong guarantees cannot hold for sparse graphs.

Instead, we derive a new spectral result (Theorem 3) that helps recover M even when few observations are available, and may be of independent interest. The result applies to all models, not just Bernoulli, and shows that even when the number of observations is only linear in k, zeroing out a small submatrix in M and X, and then regularizing the two matrices, results in a small spectral distance between them. We believe this new result could potentially imply learning in the sparse sample regime for other settings that are not explicitly considered here.

Theorem 3 (Informal, full version in Section 3) There is a small unknown set of rows that when zeroed out from regularized versions of X and M results in small spectral distance between them.

Although this set of rows is unknown, we derive an algorithm that recovers M to a small L_1 distance.

Curated SVD (Informal, full version in Section 4) Successively zeroes out few suspicious rows, ensuring that any small set of rows of X don't have too large an influence on the recovered matrix.

We show that Theorem 3 implies that curated SVD achieves the recovery guaranties in Theorem 2.

1.4 Implications of the results and related work

As mentioned in the introduction, many communities have considered recovering model matrices from samples. Here we describe a few of the results and their relation to those presented in this paper.

Community detection infers communal structure from few pairwise interactions between individuals. Much work has focused on the Stochastic Block models (SBM) where individuals fall in few communities C_1, \ldots, C_r and the interaction probabilities $p_{i,j}$ are one constant if i and j are in the same community, and a different constant if i and j are in two distinct communities. Precise guarantees were provided for both exact recovery and detection [Abb17, AS15, ABH15, BLM15].

Mixed membership SBM associates each individual with an unknown r-dimensional vector reflecting weighted membership in each of r communities, and the pairwise interaction probability is determined by inner product of the respective membership vectors. The resulting interaction probability matrix is a rank-r Bernoulli parameter matrix. Recently, [HS17] considered a Bayesian setting where the resulting membership weights are both sparse and evenly distributed, and achieved weak detection with only $\mathcal{O}(kr^2)$ samples.

Note that all these settings imply special model matrices. Even for the more general mixed-membership model in [HS17] the assumptions imply that all entries in the resulting model matrix are within a constant factor from their average. By contrast our analysis applies to all low rank matrices M, and for L_1 recovery using $\mathcal{O}(kr\log^2 r)$ samples. We note that the goal in community detection setting is somewhat more specific than ours, and the two guarantees may not be directly comparable.

Another recent work [MD19] considered recovering Poisson and distribution matrices under the Frobenius norm. They showed that matrices M with moderately-sized entries, can be recovered with $O(k\log^{3/2}k)$ samples, but the error depended on M's maximum row and column sum. However, they note that the Frobenius norm "might not always be the most appropriate error metric" and point out that the L_1 norm is "much stronger" for these settings. A similar sentiment about L_1 is echoed by [HKKV18] in relation to the spectral norms. By contrast, our results apply to the L_1 norm, grow only linearly with k, and the error depends on M's average, not the maximum, row and column sum.

Our collaborative filtering setting uses the same general bounded noise model as [BCLS17]. However they assume that the mean matrix F is generated by a Lipschitz latent variable model. They recover F to mean square error $\sum_{i,j} (F_{i,j} - \hat{F}_{i,j})^2/k^2 = \mathcal{O}(r^2/(pk)^{2/5})$, implying that recovering F requires $pk^2 = \mathcal{O}(r^5k)$ samples. They also provides a nice survey of related matrix completion and show that their result is the first to achieve linear in k recovery for the general bounded noise model.

By contrast, we make no additional assumptions, and recover F to L_1 distance with $\mathcal{O}(kr\log^2 r)$ samples. Note also that $0 \leq F_{i,j} \leq 1$, hence $|F_{i,j} - \hat{F}_{i,j}| \geq |F_{i,j} - \hat{F}_{i,j}|^2$. Therefore normalized L_1 error upper bounds mean squared error. In Appendix D we show that our estimator achieves a better error bound, $\sum_{i,j} |F_{i,j} - \hat{F}_{i,j}|/k^2 = \mathcal{O}(\sqrt{r/pk} \cdot \log(rpk))$, even for the stronger L_1 norm.

Learning latent variables models has been addressed in several other communities that typically focused on computational efficiency when the data is in abundance, includes work on Topic Modelling [AGH⁺13, KW17, BBW18], and Hidden Markov Models [HKZ12, MR05, AGH⁺14], word embedding [SCH15], and Gaussian mixture models [Das99, GHK15, VW04].

1.5 Arrangement of the paper

The reminder of the paper is organised as follows. Section 2 defines some useful notations and recalls some useful properties for these models. Section 3 defines the regularization and establish bounds on the the regularized spectral distance between X and M. Section 4 describes the Curated-SVD algorithm to recover M and gives an overview of its analysis.

2 Preliminaries

2.1 Notation

We will use the following formulation of rank, singular values, and decompositions. Let $\mathbb{R}^{k \times m}$ be the collection of k by m real matrices. Every matrix $A \in \mathbb{R}^{k \times m}$ can be expressed in terms of its *singular*-

value decomposition (SVD), $A = \sum_{i=1}^{\min\{k,m\}} \sigma_i u_i v_i^\intercal$, where the singular values $\sigma_i := \sigma_i(A)$ are non-increasing and non-negative, and the right singular vectors $v_i := v_i(A)$ are orthogonal, as are the left singular vectors $u_i := u_i(A)$. A matrix has rank r iff its first r singular values are positive, and the rest are zero. A t-truncated SVD of a matrix is one where only the first t singular values in the SVD are retained and the rest are discarded. It is easy to see that its rank is $\min(t,r)$. For $t \le \min\{k,m\}$, let $A^{(t)}$ denote the t-truncated SVD of a matrix $A \in \mathbb{R}^{k \times m}$.

The L_1 "entry-wise" norm, or L_1 norm, of a matrix A is $||A||_1:=\sum_{i,j}|A_{ij}|$. Let $||A_{i,*}||_1:=\sum_j|A_{i,j}|$ and $||A_{*,j}||_1:=\sum_i|A_{i,j}|$ denote the L_1 norm of i^{th} row and j^{th} column of A, respectively.

The L_2 norm of a vector $v=(v(1),\ldots,v(m))\in\mathbb{R}^m$ is $||v||:=\sqrt{\sum_{i=1}^mv(i)^2}$. The spectral norm, or norm for short, of a matrix $A\in\mathbb{R}^{k\times m}$ is $||A||:=\max_{v\in\mathbb{R}^m:||v||=1}||Av||=\max_{u\in\mathbb{R}^k:||u||=1}||A^\intercal u||$.

2.2 A unified framework

We first describe a unified common framework for all five problems.

To unify distribution-matrices with Poisson-parameter matrices, we apply the well-known *Poisson trick* [Szp01], where instead of a fixed sample size n, we take Poi(n) samples. The resulting random variables $X_{i,j}$ will be Poisson and independent. Furthermore, since with probability $\geq 1 - 1/n^3$, the difference between n and Poi(n) is $O(\sqrt{n \log n})$, this modification contributes only smaller order terms, and the algorithm and guarantees for Poisson parameters carry over to distribution matrices.

Having unified distribution- and Poisson-parameter- matrices, we focus on the remaining four settings. In all of them, the observations $X_{i,j}$ are independent non-negative random variables with $\mathbb{E}[X_{i,j}] = M_{i,j}$ and $\mathrm{Var}(X_{i,j}) \leq M_{i,j}$. The last inequality clearly holds for the Poisson, Bernoulli, and Binomial matrices. For collaborative filtering it follows as

$$Var(X_{i,j}) \le E((X_{i,j})^2) \le E(X_{i,j}) = M_{i,j}.$$

Define the *noise matrix* N := X - M as the difference between X and its expectation M. Note that the spectral distance between X and M is the same as the the spectral norm of the noise matrix N.

Let $n_{\text{avg}} := ||M||_1/k$ denote the average expected number of observations in each row and column. For simplicity, we assume $||M||_1$, the total number of expected observation, is known. Otherwise, since $\mathbb{E}[||X||_1] = ||M||_1$, it can be estimated very accurately.

3 Spectral norm of the regularized noise matrix

Recall that the noise matrix N=X-M, and its spectral norm ||N|| is the spectral distance between observation matrix X and M. When $||N||=\mathcal{O}(\sqrt{n_{\mathrm{avg}}})$, a simple truncated-SVD of X can be shown to recover M. Unfortunately, when some row- or column-sums of M far exceed the average, ||N|| can be quite large. This is because the expected squared norm of row i of N is $\sum_j \mathrm{Var}(X_{i,j})$ which is roughly $||M_{i,*}||_1$, and when the row sum of matrix M is non-uniform $||M_{i,*}||_1$ can be much larger than the average value n_{avg} across the rows. Similarly for the columns.

The difficulty caused by the heavy rows and columns of M can be mitigated by regularization that reduces their weight. Let $w=(w^f,w^b)$ where $w^f=((w^f(1),..,w^f(k))$ and $w^b=(w^b(1),..,w^b(k))$ are the row and columns regularization weights, all at least 1. And let D(u) be the diagonal matrix with entries u(i). The w-regularized $A \in \mathbb{R}^{k \times k}$ is

$$R(A,w) := D^{-\frac{1}{2}}(w^f) \cdot A \cdot D^{-\frac{1}{2}}(w^b).$$

Upon multiplying the i^{th} row of matrix A by $(w^f(i))^{-1/2}$, its expected squared norm reduces by a factor $1/w^f(i)$, and similarly for the columns. Therefore, selecting regularization weights $\tilde{w}=(\tilde{w}^f,\tilde{w}^b)$, where $\tilde{w}^f(i)=\max\{1,||M_{i,*}||_1/n_{\rm avg}\}$ and $\tilde{w}^b(j)=\max\{1,||M_{*,j}||_1/n_{\rm avg}\}$ would reduce the expected squared norm of heavy rows and columns of $R(N,\tilde{w})$ to $n_{\rm avg}$.

Unfortunately, the $||M_{i,*}||_1$ and $||M_{*,j}||_1$'s are not known, hence neither is \tilde{w} . However, $\mathbb{E}[\sum_i X_{i,j}] = ||M_{i,*}||_1$, hence we approximate \tilde{w} by $\bar{w} = (\bar{w}^f, \bar{w}^b)$, where

$$\bar{w}^f(i) := \max\{1, \frac{||X_{i,*}||_1}{n_{\mathrm{avg}}}\} \quad \text{and} \quad \bar{w}^b(j) := \max\{1, \frac{||X_{*,j}||_1}{n_{\mathrm{avg}}}\}.$$

Unless specified otherwise we use weights \bar{w} , and refer to them as weights. This is one of the several commonly used regularizations in spectral methods for community detection [CCT12, QR13, JY13].

When $n_{\text{avg}} = o(\log k)$, some rows and columns may have regularization weights that are below the ideal weights, $\bar{w}^f(i) \ll \tilde{w}^f(i)$ and $\bar{w}^b(j) \ll \tilde{w}^b(j)$, and will not be regularized properly. Yet as shown in Theorem 3, our technique can handle these problematic rows and columns as well.

The regularized spectral distance between two matrices A and B is ||R(A-B,w)||, the spectral norm of their regularized spectral difference. Lemma 4 in the next section relates $||R(N,\bar{w})||$ to L_1 recovery guarantees, and implies that when $||R(N,\bar{w})|| \leq \mathcal{O}(\sqrt{n_{\text{avg}}})$ a simple variation of truncated SVD can recover M from X to the minmax lower bound on L_1 recovery in Theorem 1.

When the number of samples is at least a few $\log k$ factors more than k, this spectral concentration could probably be achieved with the help of the regularization. The more interesting, challenging, and prevalent setting, is when few observations are available, and this is the main focus of the paper.

For Bernoulli Parameter matrices, [LLV17] obtained the tight bound $||R(N,\bar{w})|| = \mathcal{O}(\sqrt{n_{\mathrm{avg}}})$ that holds even for sparse graphs, or equivalently few observations. However it requires that every $M_{i,j} = \mathcal{O}(||M||_1/k^2)$, hence holds only for a very limited and often impractical subclasses of parameter matrices M. They posed the question whether this bound also holds for general M. In Appendix F, we provide a counterexample that answers the question in the negative. We construct an explicit Bernoulli parameter matrix M, s.t. w.h.p. $||R(N,\bar{w})|| = \Omega(n_{\mathrm{avg}})$, much larger than $\mathcal{O}(\sqrt{n_{\mathrm{avg}}})$.

Yet upper bounding $||R(N, \bar{w})||$ is just one approach to achieving optimal sample complexity. One of this paper's contribution is an alternative approach that decomposes the noise matrix N into two parts. A large part with small spectral norm, and a small part, in fact a submatrix, that may have a large spectral norm. While we cannot identify the "noisy" part, as shown in Section 4, we can ensure that no small part has a large influence on the estimate.

The next theorem establishes the above partition for all parameter matrices, and for all settings. To specify the matrix decomposition, both here and later, for $A \in \mathbb{R}^{k \times m}$ and subset $S \subseteq [k] \times [m]$, let A_S be the projection of matrix A over S that agrees with A for indices in S and is zero elsewhere. Further let $A_I := A_{I \times [m]}$ and $A_{I^c} := A_{[k] \setminus I \times [m]}$ be the matrices derived from A by zeroing out all rows outside, and inside, set I, respectively.

For the weights $\bar{w}=(\bar{w}^f,\bar{w}^b)$ above, let $\bar{w}^f(I):=\sum_{i\in I}\bar{w}^f(i)$ denote the weight of row subset I.

Theorem 3. For $X \sim M$, any $\epsilon \geq \frac{1}{n_{avg}} \max\left(\frac{\log^4 k}{k}, \exp^{-\frac{n_{avg}}{8}}\right)$, with probability $\geq 1 - 6k^{-3}$, there is a row subset $I_{cn} \subseteq [k]$ of possibly contaminated rows with weight $\bar{w}^f(I_{cn}) \leq \epsilon k$ and

$$||R(N, \bar{w})_{I_{\operatorname{cn}}^{\mathsf{c}}}|| \leq \mathcal{O}(\sqrt{n_{\operatorname{avg}}} \cdot \log \frac{2}{\epsilon}).$$

Since $\bar{w}^f(i)$ is the maximum of 1 and the number of observations in row i, the theorem shows that for some $I_{\rm cn}\subseteq [k]$ with only a few rows, $X_{I_{\rm cn}}$ contains only few observations, and zeroing out rows $I_{\rm cn}$ from the regularized noise matrix $R(N,\bar{w})$ would result in small spectral norm. We derive an algorithm that uses this result and to provably recovers low rank parameter matrices, even when the number of samples are only $\mathcal{O}(k)$.

To prove Theorem 3, we extend a technique used in [LLV17] for specialized Bernoulli matrices with entries all below $\mathcal{O}(||M||_1/k^2)$, to bound the spectral noise norm of general models and Matrices. In Appendix E, we use standard probabilistic methods and concentration inequalities, to establish concentration in $\ell_\infty \to \ell_2$ norm for all sub-matrices of $R(N,\bar{w})$. We then recursively apply a form of Grothendieck-Pietsch Factorization [LT13] and incorporate these bounds to partition $R(N,\bar{w})$ into successively smaller submatrices and upper bound their spectral norms, until the resulting submatrix is very small. Finally we show that the squared spectral norm of any matrix is at most the sum of the squared spectral norms of its decomposition parts, and thus upper bound the spectral norm of $R(N,\bar{w})$, except for the small submatrix, that is excluded.

4 Recovery Algorithms

Recall that R(A, w) is the regularized matrix A, and that $R(A, w)^{(r)}$ is its rank-r truncated SVD. For any r > 0, regularization weights w, and matrix A, let the (r, w)-SVD of A be the de-regularized, rank-r-truncated SVD of regularized matrix A,

$$A^{(r,w)} := D^{\frac{1}{2}}(w^f) \cdot R(A,w)^{(r)} \cdot D^{\frac{1}{2}}(w^b).$$

Let A be rank-r and B be any matrix. The next lemma bounds the L_1 distance between A and $B^{(r,w)}$ in terms of the regularized spectral distance between A and B. Appendix G provides a simple proof.

Lemma 4. For any rank-r matrix $A \in \mathbb{R}^{k \times k}$, matrix $B \in \mathbb{R}^{k \times k}$, and weights w,

$$||A-B^{(r,w)}||_1 \leq \sqrt{r \cdot (\sum_i w^f(i))(\sum_j w^b(j))} \cdot ||R(A-B,w)||.$$

Recall that N=X-M. The lemma implies that when $||R(N,\bar{w})||$ is small, $X^{(r,\bar{w})}$, the (r,\bar{w}) -SVD of X, would recover M. However, $||R(N,\bar{w})||$ could be large. Instead, Theorem 3 in the last section implies that w.h.p., the following *essential property* holds.

Essential property There is an unknown *contaminated* set, $I_{cn} \subset [k]$, such that after zeroing all I_{cn} rows in X and M, their regularized spectral distance is at most,

$$||R(N, \bar{w})_{I_{cn}^{c}}|| \le \tau := \mathcal{O}(\sqrt{n_{avg}} \log(rn_{avg})), \tag{1}$$

and the weight of the set $I_{\rm cn}$ is at most, $\bar{w}^f(I_{\rm cn}) \leq W_{\rm cn} := \mathcal{O}(k/(rn_{\rm avg})^2)$. The above property holds with probability $\geq 1-6k^{-3}$, by choosing $\epsilon = 1/(rn_{\rm avg})^2$ in Theorem 3.

This property implies a small regularized spectral distance between $X_{I_{\rm cn}^c}$ and $M_{I_{\rm cn}^c}$, and since $\bar{w}^f(I_{\rm cn}) \leq W_{\rm cn}$, the "noisier" part of observation matrix $X_{I_{\rm cn}}$ is limited to just a few rows and observations.

Recall that the (r,w)-SVD of any matrix A is the de-regularized rank-r-truncated SVD of regularized matrix R(A,w). If the set $I_{\rm cn}$ of contaminated rows was known, a simple (r,\bar{w}) -SVD of $X_{I_{\rm cn}^c}$ would recover $M_{I_{\rm cn}^c}$, and since the rows $I_{\rm cn}$ of X have only a few observations, recover M as well. Lemma 4 provides the normalized L_1 error of this idealized estimator.

Building on this simple (r, \bar{w}) -SVD, we derive our main algorithm, Curated SVD, that achieves the same performance guarantee up to a constant factor, even when the set I_{cn} is unknown. As Property (1) holds with high probability, the reminder of this section assumes that it holds.

In Curated SVD, for every row subset $I \subset [k]$ with weight $\bar{w}^f(I) \leq W_{\rm cn}$, we limit the maximum impact the submatrix $R(X,\bar{w})_I$ can have on the truncated SVD of regularized observation matrix $R(X,\bar{w})$. In particular, this limits the impact of the unknown "noisier" submatrix $R(X,\bar{w})_{I_{\rm cn}}$.

To describe the algorithm, we first formally define the impact of a row subset on SVD components. For a general matrix $A \in \mathbb{R}^{k \times k}$, let $A = \sum_{j=1}^k \sigma_j u_j v_j^\intercal$ be its SVD. Then for any $i, j \in [k]$, let the impact of row i of A, on the j^{th} component in SVD of A, be $\mathcal{H}(A,i,j) := \sigma_j^2 u_j(i)^2$. Similarly, for a row subset I, the impact of A_I , or simply impact of I, on j^{th} component in SVD of A be $\mathcal{H}(A,I,j) := \sum_{i \in I} \mathcal{H}(A,i,j)$, the sum of the impact of each row. From the standard properties of SVD, it is easy to see that $\mathcal{H}(A,I,j) = \sigma_j^2 \sum_{i \in I} u_j(i)^2 = ||A_I \cdot v_j||^2$.

Next, we present an overview of the algorithm and its analysis. Essentially, Curated SVD finds a set $I_{zr} \subseteq [k]$ of row indices, such that the following *objectives* are fulfilled:

- (i) Let $(R(X,\bar{w})_{I^{\mathbf{c}}_{\mathbf{Zr}}})^{(2r)} = \sum_{j=1}^{2r} \sigma_j u_j v_j^{\mathsf{T}}$, be the rank 2r-truncated SVD of regularized observation matrix upon zeroing out rows $I_{\mathbf{Zr}}$. For every row subset I of weight $\bar{w}^f(I) \leq W_{\mathrm{cn}}$ and $\forall j \in [2r]$, the impact of I on the j^{th} component is $\mathcal{H}(R(X,\bar{w})_{I^{\mathbf{c}}_{\mathbf{Zr}}},I,j) = \sigma_j^2 \sum_{i \in I} u_j(i)^2 \leq 16\tau^2$.
- (ii) The total weight of the set I_{zr} is small, $\bar{w}^f(I_{zr}) = \sum_{i \in I_{zr}} \bar{w}^f(i) \le \mathcal{O}(k/n_{avg})$.

After finding such a row subset $I_{\rm zr}$, Curated SVD zeroes out rows $I_{\rm zr}$ from X and simply returns the $(2r,\bar{w})$ -SVD of $X_{I_{\rm zr}^{\rm c}}$ as the estimate of M.

Objective (i), ensures that for every collection of rows I of weight $\bar{w}^f(I) \leq W_{\rm cn}$, the impact of $R(X,\bar{w})_I$ on each of the first 2r components of SVD is small. As weight of $I_{\rm cn}$ is at most $W_{\rm cn}$, in particular it limits the impact of the noisier submatrix $R(X,\bar{w})_{I{\rm cn}}$.

Objective (ii) ensures that the weight of I_{zr} , and hence the number of observations in $X_{I_{zr}}$, that get ignored in final truncated regularized SVD is small. This limits the loss due to the ignored rows I_{zr} .

Lemma 13 in the appendix uses these two observations to show that, the $(2r, \bar{w})$ -SVD of $X_{I_{\rm ZT}^c}$ recovers M

Next, we describe the algorithm Curated-SVD and show that it finds a set I_{zr} that achieves Objective (i) and (ii). The pseudo-code of the algorithm is in Appendix B.

4.1 Description of the Curated SVD

Curated-SVD starts with $I_{zr} = \phi$. In each iteration it calculates $\left(R(X, \bar{w})_{I_{zr}^c}\right)^{(2r)} = \sum_{j=1}^{2r} \sigma_j u_j v_j^\intercal$, the rank-2r truncated SVD of $R(X, \bar{w})_{I_{zr}^c}$. Then it calls subroutine *Row-Deletion* for each $j \in [2r]$.

Row deletion checks for the row subsets I with small weight and high impact that violate Objective (i). It then adds rows from such subsets I to $I_{\rm zr}$ to reach Objective (i) in a way that $I_{\rm zr}$ does not end up too heavy. To do this, Row-Deletion tries to find a row subset $I \subseteq I_{\rm zr}^{\rm c}$ with weight $\bar{w}^f(I) \leq W_{\rm cn}$ and maximum impact $\mathcal{H}(R(X,\bar{w})_{I_{\rm zr}^{\rm c}},I,j)=\sigma_j^2\sum_{i\in I}u_j(i)^2$. This however is essentially the well-known NP-hard 0-1-knapsack problem. Instead, we use a greedy 0.5-approximation algorithm [SCGDS92] for 0-1 knapsack, to obtain a row subset I with weight $\leq W_{\rm cn}$, such that its impact is at least half of the maximum possible, namely

$$\mathcal{H}(R(X,\bar{w})_{I^{\mathbf{c}}_{\mathsf{Zr}}},i,j) \geq 0.5 \max\{\mathcal{H}(R(X,\bar{w})_{I^{\mathbf{c}}_{\mathsf{Zr}}},I',j): I' \subseteq I^{\mathbf{c}}_{\mathsf{Zr}}, \textstyle \sum_{i \in I'} \bar{w}^f(i) \leq W_{\mathsf{cn}}\}.$$

If the impact of row collection I, found using the greedy algorithm, is $\mathcal{H}(R(X,\bar{w})_{I^{\mathtt{c}}_{\mathtt{Z}\mathtt{f}}},I,j)<8\tau^2$, sub-procedure Row-Deletion terminates. Else it adds a row $i\in I$ to $I_{\mathtt{Z}\mathtt{f}}$, with probability of row $i\in I$ proportional to its impact to the weight ratio, $\mathcal{H}(R(X,\bar{w})_{I^{\mathtt{c}}_{\mathtt{Z}\mathtt{f}}},i,j)/\bar{w}^f(i)$. Row-Deletion repeats this procedure on the remaining rows in $I^{\mathtt{c}}_{\mathtt{Z}\mathtt{f}}$, until it terminates.

After calling Row-Deletion for each $j \in [2r]$, Curated-SVD checks if the new rows were added to $I_{\rm zr}$ in this iteration, in which case it repeats the same procedure in the next iteration with updated $I_{\rm zr}$, else it returns $(2r, \bar{w})$ -SVD of $X_{I_{xr}^c}$ as the estimate of M.

Curated SVD achieves Objective (i). Iterations in Curated-SVD stop when for the current choice of $I_{\rm zr}$, for all $j \in [2r]$, Row-Deletion fails to add any row to $I_{\rm zr}$. This happens when for each $j \in [2r]$, the greedy-approximation algorithm in Row-Deletion finds the row subset I that has impact $< 8\tau^2$, which implies that the impact of every row subsets $I' \subseteq I_{\rm zr}^{\rm c}$ of weight $\bar{w}^f(I') \le W_{\rm cn}$, is at most $16\tau^2$. Therefore, iterations in the algorithm stops only when $I_{\rm zr}$ meets Objective (i).

Curated SVD achieves Objective (ii) w.p. $1 - \mathcal{O}(k^{-2})$. This is more challenging of the two objectives. The proof is based on the following key observation proved in the Appendix C.1.

There exist a row subset I_{hv} s.t. for every subset $I \subseteq I_{\text{hv}}^{\text{c}}$ of weight $\bar{w}^f(I) \leq W_{\text{cn}}$, the following holds $||R(X_I,\bar{w})|| \leq 2\tau$. And moreover, the weight of I_{hv} is $\bar{w}^f(I_{\text{hv}}) \leq \mathcal{O}(k/n_{\text{avg}})$.

It is easy to see that $||R(X_I, \bar{w})||^2$ upper bounds the impact submatrix $R(X_I, \bar{w})$ can have on the components of SVD. Therefore, from the previous observation, any row subset I of weight $\bar{w}^f(I) \leq W_{\rm cn}$ with impact $\geq 8\tau^2$, must have more than half of its impact due to the rows $I \cap I_{\rm hv}$. Recall that Row-Deletion adds a row from I to $I_{\rm zr}$ only when I has impact $\geq 8\tau^2$. We show that in each step in expectation it adds more weight from $I \cap I_{\rm hv}$ to $I_{\rm zr}$, then from $I \cap I_{\rm hv}^c$.

Using this we show that, w.h.p. the total weight of rows added to I_{zr} is only a constant times the weight of I_{hv} , that is $\mathcal{O}(k/n_{avg})$, and Objective (ii) is achieved with constant probability. Repeating the procedure $\mathcal{O}(\log k)$ times on the same data, Objective (ii) holds with probability $1 - \mathcal{O}(k^{-2})$.

Finally, by combining Lemma 13 and the fact that the Curated SVD achieves both objectives, we prove Theorem 2 in Appendix D.

Broader impact

This work does not present any foreseeable societal consequence.

A Preliminaries

This section contains some standard linear-algebra results used in the proofs. It shares terminology with Section 2. The *Frobenius*, or *entry-wise* L_2 , *norm* of a matrix A is

$$||A||_F := \sqrt{\sum_{i,j} |A_{ij}|^2}.$$

Theorem 5. (Singular value decomposition [Bha13]) For all $A \in \mathbb{R}^{k \times m}$,

- 1. $Av_i(A) = \sigma_i(A)u_i(A)$ and $A^{\mathsf{T}}u_i(A) = \sigma_i(A)v_i(A), \ \forall i$.
- 2. $||A|| = \sigma_1(A)$.
- 3. (Courant-Fischer Theorem for Singular Values):

$$\sigma_i(A) = \min_{S: dim(S) = m - i + 1} \max_{v \in S: ||v|| = 1} ||Av|| = \max_{S: dim(S) = i} \min_{v \in S: ||v|| = 1} ||Av||.$$

The singular values of a submatrix are smaller than those of the original matrix. In particular, the same holds for their spectral norms.

Theorem 6. (Interlacing property of Singular Values [Que87]) For $A \in \mathbb{R}^{k \times m}$, $I \subseteq [k]$, $J \subseteq [m]$ let $A' = A_{I \times J}$ be a submatrix of A, then $\forall i$,

$$\sigma_i(A') \leq \sigma_i(A)$$
.

Singular values are subadditive.

Theorem 7. (Weyl's Inequality for Singular Values [Bha13]) For all $A, A' \in \mathbb{R}^{k \times m}$ and $i, j \geq 1$ s.t. $i + j - 1 \leq \min(m, n)$,

$$\sigma_{i+i-1}(A+A') \leq \sigma_i(A) + \sigma_i(A').$$

C Analysis of Curated SVD algorithm

Subsection C.1 shows that w.h.p. Curated SVD achieves Objective (ii). Subsection C.2 shows that if I_{zr} achieves both objectives then regularized Curated SVD recovers $M_{I_{co}^{co}}$.

C.1 Curated SVD achieves Objective (ii)

We first show that both the objectives can be achieved simultaneously.

Lemma 8. Assume that the essential property 1 holds. There is a row-collection I_{hv} of weight $\sum_{i \in I_{\text{hv}}} \bar{w} \leq \mathcal{O}(k/n_{\text{avg}})$, such that for any subset $I \subseteq I_{\text{hv}}^c$ of weight $\sum_{i \in I} \bar{w}^f(i) \leq W_{\text{cn}}$,

$$||R(X_I, \bar{w})|| \leq 2\tau.$$

Implication of the above Lemma It is easy to see that for any subset $I \subseteq [k], ||R(X_I, \bar{w})||^2$ upper bounds the impact $R(X_I, \bar{w})$ can have on the SVD. Hence, if we let $I_{zr} = I_{hv}$ then both the objectives will be satisfied. Although, the above lemma shows the existence of I_{hv} with small weight, it doesn't give a computationally efficient way to find I_{hv} . We later show that Curated-SVD finds I_{zr} efficiently, with expected weight only twice that of I_{hv} .

In proving the above lemma, we use the following two auxiliary lemmas, which are stated for general matrices, and the proofs of both the auxiliary lemmas appear in the Appendix G, with the proof of many other Linear algebra results used in the paper.

Lemma 9. For any matrix A and weight vectors w^f and w^b with positive entries

$$||D^{-\frac{1}{2}}(w^f) \cdot A \cdot D^{-\frac{1}{2}}(w^b)|| \le \sqrt{\max_i \frac{||A_{i,*}||_1}{w^f(i)} \times \max_j \frac{||A_{*,j}||_1}{w^b(j)}}.$$

We use the above lemma to bound the spectral norm of the regularized observation matrix $R(X, \bar{w})$. Applying the lemma for matrix A = X and weights $w^f = \bar{w}^f$ and $w^b = \bar{w}^b$ we get:

$$||R(X, \bar{w})|| \le \sqrt{\max_{i} \frac{||X_{i,*}||_1}{\bar{w}^f(i)} \times \max_{j} \frac{||X_{*,j}||_1}{\bar{w}^b(j)}} \le n_{\text{avg}}.$$
 (2)

Next, we state the second auxiliary lemma required in proving Lemma 8

Lemma 10. Let A be an $k \times m$ matrix such that $\sigma_1(A) \leq \alpha$ and $\sigma_{r+1}(A) \leq \beta$. Then the number of disjoint row subsets $I \subset [k]$ such that $||A_I|| > 2\beta$ is at most $\left(\frac{r\alpha}{\beta}\right)^2$.

Using the above two auxiliary lemmas, we prove Lemma 8.

Proof of Lemma 8. Using Weyl's inequality 7

$$\sigma_{r+1}(R(X,\bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}}) \leq \sigma_{r+1}(R(M,\bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}}) + \sigma_{1}(R(X-M,\bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}})$$

$$\stackrel{\text{(a)}}{\leq} \sigma_1(R(N,\bar{w})_{I_{\text{cn}}^c}) = ||R(N,\bar{w})_{I_{\text{cn}}^c}|| \leq \tau, \tag{3}$$

here (a) uses X - M = N, and the fact that $M_{I_{cn}^c}$ has rank r.

From equation (2) and Theorem 6,

$$\sigma_1(R(X,\bar{w})_{I_{\rm cn}^c}) \le n_{\rm avg}.\tag{4}$$

Applying Lemma 10 for $A = R(X, \bar{w})_{I_{\text{cn}}^c}$, and using (3) and (4) shows that the number of disjoint subsets $I \subset I_{\text{cn}}^c$ such that $||R(X_I, \bar{w})|| > 2\tau$ is at most $\left(\frac{rn_{\text{avg}}}{\tau}\right)^2$.

Therefore, the number of disjoint subsets $I \subset I_{\mathrm{cn}}^{\mathrm{c}}$, such that $||R(X_I, \bar{w})|| > 2\tau$ and weight $\bar{w}^f(I) \leq W_{\mathrm{cn}}$, is also at most $\left(\frac{rn_{\mathrm{avg}}}{\tau}\right)^2$. Since every such subset I has weight $\bar{w}^f(I) \leq W_{\mathrm{cn}}$, the combined total weight of all such disjoint subsets is $\leq W_{\mathrm{cn}} \cdot \left(\frac{rn_{\mathrm{avg}}}{\tau}\right)^2$.

Let $I_{\text{hv}} \subseteq [k]$ be the subset formed by combining all these disjoint subsets, and I_{cn} . It is clear from the construction of I_{hv} that, for every subset $I \subset I_{\text{hv}}^{\text{c}}$ with weight $\bar{w}^f(I) \leq W_{\text{cn}}$,

$$||R(X_I, \bar{w})|| \le 2\tau.$$

Finally, noting that the total weight of subset $I_{\rm hv}$ is at most $W_{\rm cn} \cdot \left(\frac{rn_{\rm avg}}{\tau}\right)^2 + \sum_{i \in I_{\rm cn}} \bar{w}^f(i) \le W_{\rm cn} \cdot \left(\frac{rn_{\rm avg}}{\tau}\right)^2 + W_{\rm cn}$, and using $W_{\rm cn} = \mathcal{O}(k/(rn_{\rm avg})^2)$, $\tau = \mathcal{O}(\sqrt{n_{\rm avg}}\log(rn_{\rm avg}))$ completes the proof.

The next lemma bounds the expected weight of set I_{zr} zeroed out by Curated SVD, by showing that it is at most twice the weight of I_{hv} .

Lemma 11. Assume that essential property 1 holds. When Curated SVD terminates, the total weight of the final set of rows I_{zx} satisfy,

$$\mathbb{E}\!\left[ar{w}^f(I_{\mathsf{zr}})
ight] \leq \mathcal{O}(k/n_{avg}).$$

Proof. Recall that the rows get added to $I_{\rm zr}$ one by one. Let Z_t denotes the weight of the t^{th} row that gets added to $I_{\rm zr}$. Let indicator random variable $\mathbbm{1}_t(I_{\rm hv})=1$, if the t^{th} that gets added in $I_{\rm zr}$ belongs to $I_{\rm hv}$ and similarly indicator random variable $\mathbbm{1}_t(I_{\rm hv}^c)=1$, if the t^{th} that gets added in $I_{\rm zr}$ doesn't belongs to $I_{\rm hv}$. Clearly $Z_t=Z_t\cdot \mathbbm{1}_t(I_{\rm hv})+Z_t\mathbbm{1}_t(I_{\rm hv}^c)$. We first show that for any t,

$$\mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\text{bv}}^{\text{c}})] < \mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\text{bv}})].$$

Suppose that the t^{th} row added to I_{zr} was chosen probabilistically from the row subset $I \subseteq I_{zr}^c$ in Row deletion in step (6). Recall that Row-Deletion adds rows only from the row subsets I that have weight $\leq W_{\rm cn}$ and impact at least $8\tau^2$, on one of the components of SVD. Then $\bar{w}^f(I) \leq W_{\rm cn}$ and some $j \in [2r]$, and its impact

$$\mathcal{H}(I, j) > 8\tau^2$$
.

We decompose $\mathcal{H}(I,j)$ in two parts as

$$\mathcal{H}(I,j) = \mathcal{H}(I \cap I_{\text{hv}}, j) + \mathcal{H}(I \setminus I_{\text{hv}}).$$

Since, the weight of I is $\leq W_{\rm cn}$, the weight of $I' = I \setminus I_{\rm hv}$ is also $\leq W_{\rm cn}$. Applying Lemma 8 on I' implies that

$$\mathcal{H}(I \setminus I_{\text{hv}}, j) \leq 4\tau^2$$
.

Combining the last three equation gives,

$$\mathcal{H}(I \cap I_{\text{hv}}, j) \geq 4\tau^2$$
.

Next, note that

$$\mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\mathsf{hv}})] = \sum_{i \in I \cap I_{\mathsf{hv}}} \Pr[i^{th} \text{ row is picked }] \cdot \bar{w}^f(i) \propto \sum_{i \in I \cap I_{\mathsf{hv}}} \frac{\mathcal{H}(i,j)}{\bar{w}^f(i)} \cdot \bar{w}^f(i) = \mathcal{H}(I \cap I_{\mathsf{hv}}, j),$$

where we used the fact that the probability of adding row i to $I_{\rm zr}$ in Row-Deletion procedure is proportional to $\frac{\sigma_j^2 u_j^2(i)}{\bar{w}^f(i)} = \frac{\mathcal{H}(i,j)}{\bar{w}^f(i)}$

A similar calculation implies that

$$\mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\text{hv}}^{\text{c}})] \propto \mathcal{H}(I \setminus I_{\text{hv}}, j).$$

Combining the last four equations show,

$$\mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\text{hv}}^c)] \leq \mathbb{E}[Z_t \cdot \mathbb{1}_t(I_{\text{hv}})].$$

Let random variable ℓ denote the total number of rows that are added to $I_{\rm zr}$ before algorithm stops. Then using the optional stopping theorem for supermartingale $\left(Z_t \cdot \mathbb{1}_t(I_{\rm hv}^c) - Z_t \cdot \mathbb{1}_t(I_{\rm hv})\right)$ implies that when algorithm stops after putting ℓ rows in $I_{\rm zr}$,

$$\mathbb{E}[\sum_{t=1}^{\ell} \left(Z_t \cdot \mathbb{1}_t(I_{\text{hv}}^{\text{c}}) - Z_t \cdot \mathbb{1}_t(I_{\text{hv}}) \right)] \leq 0.$$

And since, the total weight of the rows in I_{hv} that gets added to I_{zr} is at-most the total weight of rows in I_{hv} , using Lemma 8, we get

$$\sum_{t=1}^{\ell} Z_t \cdot \mathbb{1}_t(I_{\text{hv}}) \le \mathcal{O}(k/n_{\text{avg}}).$$

Combining the above two equations bounds the expected total weight that gets added to I_{zz}

$$\mathbb{E}[\sum_{t=1}^{\ell} Z_t] = \mathbb{E}[\sum_{t=1}^{\ell} Z_t \cdot \mathbb{1}_t(I_{\text{hv}}^c)] + \mathbb{E}[\sum_{t=1}^{\ell} Z_t \cdot \mathbb{1}_t(I_{\text{hv}})] \leq 2\mathbb{E}[\sum_{t=1}^{\ell} Z_t \cdot \mathbb{1}_t(I_{\text{hv}})] \leq 2\mathcal{O}(k/n_{\text{avg}}). \quad \blacksquare$$

Lemma 12. Assume that essential property 1 holds. If Curated SVD is run $O(\log k)$ times, then w.p. $> 1 - k^{-O(1)}$, at-least one of the runs finds I_{xx} s.t.,

$$\bar{w}^f(I_{\rm zr}) \leq \mathcal{O}(k/n_{avg}).$$

Proof. From Markov's inequality and the previous lemma, we get

$$\Pr[\bar{w}^f(I_{\text{zr}}) \geq 5 \times \mathcal{O}(k/n_{\text{avg}}))] \leq \frac{\mathcal{O}(k/n_{\text{avg}})}{5 \times \mathcal{O}(k/n_{\text{avg}})} \leq 1/5.$$

Therefore, w.p. $\geq 4/5$, Curated SVD finds I_{zr} such that,

$$\bar{w}^f(I_{zr}) \leq 5 \times \mathcal{O}(k/n_{avg}).$$

Hence, if we run Curated SVD for $\mathcal{O}(\log k)$ times, with probability $1 - k^{-O(1)}$, at-least one of the runs will find I_{zr} that satisfy the above equation and Objective (ii).

C.2 Objectives (i) and (ii) implies recovery

Lemma 13. Assume that essential property (1) holds and let I_{zx} be any row subset satisfying objectives (i) and (ii) and let \widehat{M} be $(2r, \overline{w})$ -SVD of $X_{I_{zx}^{\infty}}$, then

$$||M_{I_{\operatorname{cn}}^c} - \widehat{M}||_1 \le \mathcal{O}(k\sqrt{rn_{\operatorname{avg}}}\log(rn_{\operatorname{avg}})).$$

The rest of this subsection proves the lemma.

Let $Z := R(X_{I_{zr}^c}, \bar{w})^{(2r)}$, be rank 2r truncated SVD of regularized matrix $R(X_{I_{zr}^c}, \bar{w})$. Then, from the definition of $(2r, \bar{w})$ -SVD,

$$\widehat{M} = D^{\frac{1}{2}}(\bar{w}^f) \cdot Z \cdot D^{\frac{1}{2}}(\bar{w}^b).$$

Clearly, both Z and \widehat{M} have rank $\leq 2r$ and their rows I_{zr} are all zero.

To bound the total loss in Lemma 13, using the triangle inequality, we first decompose the loss incurred in estimating matrix M by \widehat{M} into three parts as follows.

$$||M_{I_{cn}^c} - \widehat{M}||_1 = ||M_{I_{cn}^c} - \widehat{M}_{I_{zr}^c}||_1$$

$$\leq ||(M - \widehat{M})_{(I_{cn} \cup I_{zr})^c}||_1 + ||M_{I_{zr} \setminus I_{cn}}||_1 + ||\widehat{M}_{I_{cn} \setminus I_{zr}}||_1.$$
(5)

Lemma 14 bounds the contribution of the first term above on the right. Intuitively, the contribution of the other two terms is small, since the weight of row subsets $I_{\rm zr}$ and $I_{\rm cn}$ are small. And using this observation we later bound the contribution of the last two terms.

Lemma 14.

$$||(M-\widehat{M})_{(I_{\operatorname{cn}}\cup I_{\operatorname{zr}})^{\mathsf{c}}}||_{1} \leq \mathcal{O}(k\sqrt{rn_{\operatorname{avg}}}\log(rn_{\operatorname{avg}})).$$

To prove Lemma 14, we use the following lemma which bounds the spectral distance between $Z_{(I_{cn} \cup I_{zr})^c}$ and $R(M, \bar{w})_{(I_{cn} \cup I_{zr})^c}$ is small.

Lemma 15. Let $I_{zr} \subseteq [k]$ be a row subset that satisfy Objective-1, then

$$||Z_{(I_{cn}\cup I_{zr})^c} - R(M, \bar{w})_{(I_{cn}\cup I_{zr})^c}|| \le 9\tau.$$

In proving the above Lemma, we need the following auxiliary lemmas, which is stated for general matrices, and its proof appears in the Appendix G

Lemma 16. Let A = B + C and $A = \sum_{i} \sigma_{i}(A)u_{i}v_{i}^{\mathsf{T}}$ be the SVD decomposition of A. And $\sigma_{r+1}(B) \leq \beta$ and $||Cv_{i}|| \leq 2\beta$ for $i \in [2r]$. Then $\sigma_{2r}(A) \leq 4\beta$.

Proof of Lemma 15. Using equation (3) and Theorem 6, we get,

$$\sigma_{r+1}(R(X,\bar{w})_{(I_{\operatorname{cn}}\cup I_{\operatorname{Zr}})^{\mathsf{c}}}) \le \sigma_{r+1}(R(X,\bar{w})_{I_{\operatorname{cn}}^{\mathsf{c}}}) \le \tau. \tag{6}$$

Observe that,

$$R(X, \bar{w})_{I_{\mathrm{ZT}}^{\mathsf{c}}} = R(X, \bar{w})_{(I_{\mathrm{Cn}} \cup I_{\mathrm{Zr}})^{\mathsf{c}}} + R(X, \bar{w})_{I_{\mathrm{Cn}} \setminus I_{\mathrm{Zr}}}.$$

Let $(R(X, \bar{w})_{I_{zr}^c})^{(2r)} = \sum_{j=1}^{2r} \sigma_j u_j v_j^{\mathsf{T}}$. Since I_{zr} satisfy Objective (i) and the weight of I_{cn} is at-most $\bar{w}^f(I_{cn}) \leq \epsilon k$, therefore, the condition in Objective (i) implies that

$$||R(X, \bar{w})_{I_{\operatorname{cn}}\setminus I_{\operatorname{zr}}} \cdot v_i|| \le 4\tau.$$

Then applying Lemma 16, for $A=R(X,\bar{w})_{I^c_{rr}}$ and using the above three equations gives

$$\sigma_{2r}(R(X,\bar{w})_{I_{2r}^{c}}) \leq 8\tau.$$

Since, for Z is rank-2r truncated SVD of $R(X, \bar{w})_{I_{rr}^{c}}$, we have

$$||R(X,\bar{w})_{I_{rr}^{c}} - Z|| = ||(R(X,\bar{w}) - Z)_{I_{rr}^{c}}|| \le 8\tau.$$
(7)

Then,

$$\begin{split} &||(Z-R(M,\bar{w}))_{(I_{\text{cn}}\cup I_{\text{Zr}})^{\text{c}}}||\\ &\overset{\text{(a)}}{\leq}||(Z-R(X,\bar{w}))_{(I_{\text{cn}}\cup I_{\text{Zr}})^{\text{c}}}||+||(R(X,\bar{w})-R(M,\bar{w}))_{(I_{\text{cn}}\cup I_{\text{Zr}})^{\text{c}}}||\\ &\overset{\text{(b)}}{\leq}||(Z-R(X,\bar{w}))_{I_{\text{Zr}}^{\text{c}}}||+||(R(N,\bar{w}))_{I_{\text{cn}}^{\text{c}}}||\\ &\overset{\text{(c)}}{\leq}8\tau+\tau=9\tau, \end{split}$$

here (a) uses triangle inequality, (b) uses Theorem 6 and X - M = N, and finally (c) uses equation (7) and essential condition 1.

The next auxiliary lemma relates the L_1 norm and spectral norm. Its proof appears in the Appendix G. Lemma 17. For any rank-r matrix $A \in \mathbb{R}^{k \times m}$ and weight vectors w^f and w^b with non-negative entries

$$||D^{\frac{1}{2}}(w^f) \cdot A \cdot D^{\frac{1}{2}}(w^b)||_1 \leq \sqrt{r(\sum_i w^f(i))(\sum_j w^b(j))} \cdot ||A||.$$

We will also need the following result.

Lemma 18. The total weight of all rows is at most $\sum_{i \in [k]} \bar{w}^f(i) \leq 2k$ and similarly the total weight of all columns is at most $\sum_{i \in [k]} \bar{w}^b(j) \leq 2k$.

Proof.

$$\bar{w}^f([k]) = \sum_{i \in [k]} \bar{w}^f(i) \le \sum_{i \in [k]} 1 + \frac{||X_{i,*}||_1}{n_{\text{avg}}} \le k + \frac{||X||_1}{n_{\text{avg}}} \le 2k,$$

since n_{avg} is the average number of samples in each row. Similarly it can be shown for columns.

Next, combining the above result we prove Lemma 14

Proof of Lemma 14. First note that,

$$||(M-\widehat{M})||_1 = ||M-D^{\frac{1}{2}}(\bar{w}^f) \cdot Z \cdot D^{\frac{1}{2}}(\bar{w}^b)||_1 = ||D^{\frac{1}{2}}(\bar{w}^f)(Z-R(M,\bar{w}))D^{\frac{1}{2}}(\bar{w}^b)||_1,$$

here we used $R(M,\bar{w})=D^{-\frac{1}{2}}(\bar{w}^f)\cdot M\cdot D^{-\frac{1}{2}}(\bar{w}^b).$ As noted earlier Z has the rank $\leq 2r$ and M has the rank $\leq r$, therefore the rank of $(Z-R(M,\bar{w}))$ is at most 3r. Then, using Lemma 17 and Lemma 15,

$$\begin{split} ||D^{\frac{1}{2}}(\bar{w}^f)(Z - R(M, \bar{w}))_{(I_{\text{cn}} \cup I_{\text{zr}})^c} D^{\frac{1}{2}}(\bar{w}^b)||_1 \\ &\leq \sqrt{3r} \sqrt{(\sum_{j \in [k]} \bar{w}^b(j))(\sum_{i \in (I_{\text{cn}} \cup I_{\text{zr}})^c} \bar{w}^b(j))} \cdot 9\tau \\ &\leq \sqrt{3r} \sqrt{(\sum_{j \in [k]} \bar{w}^b(j))(\sum_{i \in [k]} \bar{w}^b(j))} \cdot 9\tau \leq \sqrt{3r} \cdot 2k \cdot 9\tau, \end{split}$$

here the last step uses Lemma 18. Combining the last two equations and using $\tau = \mathcal{O}(\sqrt{n_{\rm avg}}\log(rn_{\rm avg}))$ complete the proof.

To bound the second term in (5), note that

$$M_{I_{ZI} \setminus I_{Cn}} = D^{\frac{1}{2}}(\bar{w}^f) \cdot R(M, \bar{w})_{I_{ZI} \setminus I_{Cn}} \cdot D^{\frac{1}{2}}(\bar{w}^b)$$
 (8)

Applying Lemma 17,

$$||M_{I_{Z\Gamma}\backslash I_{Cn}}||_{1} = ||D^{\frac{1}{2}}(\bar{w}^{f}) \cdot R(M, \bar{w})_{I_{Z\Gamma}\backslash I_{Cn}} \cdot D^{\frac{1}{2}}(\bar{w}^{b})||_{1}$$

$$\leq \sqrt{r} \sqrt{(\sum_{j \in [k]} \bar{w}^{b}(j))(\sum_{i \in I_{Z\Gamma}\backslash I_{Cn}} \bar{w}^{f}(i))} \cdot ||R(M, \bar{w})_{I_{Z\Gamma}\backslash I_{Cn}}||$$

$$\leq \sqrt{r} \sqrt{(\sum_{j \in [k]} \bar{w}^{b}(j))(\sum_{i \in I_{Z\Gamma}} \bar{w}^{f}(i))} \cdot ||R(M, \bar{w})_{I_{Cn}^{c}}||$$

$$\leq \sqrt{2rk} \sqrt{\bar{w}^{f}(I_{Z\Gamma})} \cdot ||R(M, \bar{w})_{I_{Cn}^{c}}||.$$
(9)

Next,

$$||R(M, \bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}}|| \leq ||R(N, \bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}}|| + ||R(X, \bar{w})_{I_{\mathsf{cn}}^{\mathsf{c}}}||$$

$$\leq \tau + ||R(X, \bar{w})|| \leq \tau + n_{\mathsf{avg}},$$

here we used essential property (1) and equation (4). Combining the last two equations we get

$$||M_{I_{\mathsf{Zr}}\setminus I_{\mathsf{Cn}}}||_1 \le \mathcal{O}(\sqrt{rk\cdot \bar{w}^f(I_{\mathsf{Zr}})}\cdot (\tau + n_{\mathsf{avg}})) \le \mathcal{O}(\sqrt{rk}\cdot (\log(rn_{\mathsf{avg}}) + \sqrt{n_{\mathsf{avg}}})) \tag{10}$$

Finally, we bound the last term in (5). Recall that $\widehat{M}=D^{\frac{1}{2}}(\bar{w}^f)\cdot Z\cdot D^{\frac{1}{2}}(\bar{w}^b).$ Then

$$||\widehat{M}_{I_{\operatorname{Cn}}\backslash I_{\operatorname{Zr}}}||_1 = ||(D^{\frac{1}{2}}(\bar{w}^f) \cdot Z_{I_{\operatorname{Cn}}\backslash I_{\operatorname{Zr}}} \cdot D^{\frac{1}{2}}(\bar{w}^b)||_1.$$

Using the fact that Z is truncated SVD of $R(X_{I_{cc}^c}, \bar{w})$ and equation (4) we get

$$||Z_{I_{zr}^{\mathbf{c}}}|| \le ||Z|| \le ||R(X_{I_{zr}^{\mathbf{c}}}, \bar{w})|| \le n_{\text{avg}}.$$

Therefore,

$$||Z_{I_{cn}\setminus I_{zr}}|| \leq n_{avg}$$
.

Then applying Lemma 17,

$$\begin{split} ||D^{\frac{1}{2}}(\bar{w}^f) \cdot Z_{I_{\mathsf{Cn}} \backslash I_{\mathsf{Zr}}} \cdot D^{\frac{1}{2}}(\bar{w}^b)||_1 &\leq \sqrt{2r} \sqrt{(\sum_{j \in [k]} \bar{w}^b(j))(\sum_{i \in I_{\mathsf{Cn}} \backslash I_{\mathsf{Zr}}} \bar{w}^f(i))} \cdot n_{\mathsf{avg}} \\ &\leq \sqrt{2r} \sqrt{2k(\sum_{i \in I_{\mathsf{Cn}}} \bar{w}^f(i))} \cdot n_{\mathsf{avg}} \\ &\leq 2\sqrt{rkW_{\mathsf{cn}}} \cdot n_{\mathsf{avg}} = \mathcal{O}(k/\sqrt{r}), \end{split}$$

here in the last step we used $W_{\rm cn} = \mathcal{O}(k/(rn_{\rm avg})^2)$.

By combining equation (5), Lemma 14, equation (10) and the above equations we get

$$||M_{I_{cn}} - \widehat{M}||_1 \le \mathcal{O}(k\sqrt{rn_{avg}}\log(rn_{avg})) + \mathcal{O}(k\sqrt{r} \cdot (\log(rn_{avg}) + \sqrt{n_{avg}})) + \mathcal{O}(k/\sqrt{r})$$

$$\le \mathcal{O}(k\sqrt{rn_{avg}}\log(rn_{avg})).$$

This completes the proof of the lemma.

D Proof of Theorem 2

Theorem 2 follows immediately from the following theorem.

Theorem 19. Curated SVD runs in polynomial time, and for every k, r, $\epsilon > 0$, $M \in \mathbb{R}_r^{k \times k}$, and $X \sim M$, returns an estimate $M^{cur}(X)$ s.t. with probability $\geq 1 - k^{-2}$,

$$L(M^{cur}(X)) = \frac{||M - M^{cur}(X)||_1}{||M||_1} \le \mathcal{O}(\sqrt{\frac{kr}{||M||_1}} \log(\frac{r||M||_1}{k})).$$

Proof. Section 4 showed that Curated-SVD always achieves Objective (i). Using the spectral concentration bound in Theorem 3 it also showed that the essential property required for Curated SVD holds with probability $\geq 1 - 6/k^3$.

Lemma 12 showed that if essential property hold and Curated SVD is repeated $\mathcal{O}(\log k)$ times, on the same samples, then w.p. $> 1 - k^{-O(1)}$, at-least one of the runs find I_{zr} that achieves Objective (ii).

Finally, when essential property holds and Curated SVD achieves both the objectives then Lemma 13 showed

$$||M_{I_{\operatorname{cn}}^c} - \widehat{M}||_1 \le \mathcal{O}(k\sqrt{rn_{\operatorname{avg}}}\log(rn_{\operatorname{avg}})). \tag{11}$$

Note that

$$||M - \widehat{M}||_1 \le ||M_{I_{\operatorname{cn}}^c} - \widehat{M}||_1 + ||M_{I_{\operatorname{cn}}}||_1.$$

Therefore, to prove the theorem the only thing remains is to bound the last term.

To bound the last term we use the following lemma. The proof of the Lemma appears in Section E.1.

The lemma upper bounds the sum of the absolute difference between the expected and observed samples in each row of X.

Lemma 20. With probability $\geq 1 - 3k^{-3}$,

$$\sum_{i} |\sum_{j} N_{i,j}| = \mathcal{O}(k\sqrt{n_{avg}}).$$

Then

$$\begin{split} ||M_{I_{\text{cn}}}||_1 &= \sum_{i \in I_{\text{cn}}} \sum_{j \in [k]} M_{i,j} \\ &\leq \sum_{i \in I_{\text{cn}}} \sum_{j \in [k]} X_{i,j} + \left| \sum_{i \in I_{\text{cn}}} \sum_{j \in [k]} (M_{i,j} - X_{i,j}) \right| \\ &\leq \sum_{i \in I_{\text{cn}}} ||X_{i,*}|| + \sum_{i \in I_{\text{cn}}} \left| \sum_{j \in [k]} N_{i,j} \right| \\ &\leq \sum_{i \in I_{\text{cn}}} n_{\text{avg}} \cdot \bar{w}^f(i) + \mathcal{O}(k\sqrt{n_{\text{avg}}}) \\ &\leq \mathcal{O}(k\sqrt{n_{\text{avg}}}), \end{split}$$

here the second last step uses $||X_{i,*}|| \le n_{\text{avg}} \cdot \bar{w}^f(i)$ and the previous Lemma and the last step uses $\sum_{i \in I_{\text{cn}}} \bar{w}^f(i) \le W_{\text{cn}}$. Combining this with (11) and letting $M^{\text{cur}}(X) = \widehat{M}$ gives

$$||M - M^{\text{cur}}(X)||_1 \le \mathcal{O}(k\sqrt{rn_{\text{avg}}}\log(rn_{\text{avg}})).$$

Finally, dividing the both sides by $||M||_1$ and using $n_{\text{avg}} = ||M||_1/k$ in the above equation completes the proof.

Using $||M||_1 = \frac{kr}{\epsilon^2} \cdot \log^2 \frac{r}{\epsilon}$ in the above theorem gives Theorem 2.

The next subsection gives the implication of the above result for collaborative filtering.

D.1 Collaborative filtering

For the same general bounded noise model [BCLS17] derived the mean square error $\sum_{i,j} (F_{i,j} - \hat{F}_{i,j})^2/k^2 = \mathcal{O}(r^2/(pk)^{2/5})$. They assume that the mean matrix F is generated by a Lipschitz latent variable model. Here we show that Curated SVD achieves a better accuracy, in a stronger norm, and without the additional Lipschitz assumption on F.

Note that since $0 \le F_{i,j} \le 1$, $|F_{i,j} - \hat{F}_{i,j}| \ge |F_{i,j} - \hat{F}_{i,j}|^2$. Therefore, L_1 error $\sum_{i,j} |F_{i,j} - \hat{F}_{i,j}|/k^2$ upper bounds mean squared error.

Recall that in collaborative filtering model $M_{i,j}=pF_{i,j}$. Since the sampling probability p can be estimated to very good accuracy hence without loose of generality assume that p is known. Note that $||M||_1=p||F||_1=pk^2F_{i,j}^{\rm avg}$, where $F_{i,j}^{\rm avg}=||F||_1/k^2\leq 1$ as $\forall i,j,\,F_{i,j}\leq 1$. We let $F^{\rm cur}(X)=M^{\rm cur}(X)/p$.

Then using Theorem 19 for this model implies:

$$\frac{||M - M^{\mathrm{cur}}(X)||_1}{||M||_1} = \frac{p||F - F^{\mathrm{cur}}(X)||_1}{pk^2 F_{i,j}^{\mathrm{avg}}} \leq \mathcal{O}\bigg(\sqrt{\frac{kr}{pk^2 F_{i,j}^{\mathrm{avg}}}}\log(\frac{r}{k}pk^2 F_{i,j}^{\mathrm{avg}})\bigg).$$

Therefore,

$$\frac{||F - F^{\text{cur}}(X)||_1}{k^2} \leq \mathcal{O}\bigg(\sqrt{\frac{rF_{i,j}^{\text{avg}}}{pk}}\log(r \cdot pkF_{i,j}^{\text{avg}})\bigg) \leq \mathcal{O}\bigg(\sqrt{\frac{r}{pk}}\log(rpk)\bigg).$$

We get the following Corollary.

Corollary 21. Curated SVD runs in polynomial time, and for every $k, r, \epsilon > 0$, sampling probability $p, F \in \mathbb{R}^{k \times k}_r, F_{i,j} \in [0,1]$ and $X \sim pF$, returns an estimate $F^{cur}(X)$ s.t. with probability $\geq 1 - k^{-2}$,

$$\frac{||F - F^{cur}(X)||_1}{k^2} \le \mathcal{O}\left(\sqrt{\frac{r}{pk}}\log(rpk)\right).$$

Note that the above bound on the L_1 error norm is strictly better than the previous bound on the mean square error, and, as we showed, MSE is also a weaker error norm than L_1 for this setting.

E Properties of the Noise matrix

Here we give the proof of Theorem 3. We in fact prove a somewhat more general version of the theorem. Accordingly, we define the generalisation of the weights \tilde{w} and \bar{w} defined in the paper. For any $\Lambda > 0$, define weights $\tilde{w}_{\Lambda} := (\tilde{w}_{\Lambda}^f, \tilde{w}_{\Lambda}^b)$ such that,

$$\tilde{w}^f_{\Lambda}(i):=\max\{1,\frac{||M_{i,*}||_1}{\Lambda}\} \text{ and } \tilde{w}^b_{\Lambda}(j):=\max\{1,\frac{||M_{*,j}||_1}{\Lambda}\}.$$

And similarly define $\bar{w}_{\Lambda} = (\bar{w}_{\Lambda}^f, \bar{w}_{\Lambda}^b)$ such that,

$$\bar{w}^f_{\Lambda}(i):=\max\{1,\frac{||X_{i,*}||_1}{\Lambda}\} \text{ and } \bar{w}^b_{\Lambda}(j):=\max\{1,\frac{||X_{*,j}||_1}{\Lambda}\}.$$

We obtain the results for the regularization weights $\tilde{w}_{\Lambda}^f(i)$ and $\bar{w}_{\Lambda}^f(i)$. Note that the regularization weights \tilde{w} and \bar{w} , used in the main paper, are a special case of these regularization weights $\tilde{w}_{\Lambda}^f(i)$ and $\bar{w}_{\Lambda}^f(i)$ for $\Lambda = n_{\rm avg}$.

The next theorem is a generalisation of Theorem 3. This theorem bounds the spectral norm of the noise matrix regularized by weights \bar{w}_{Λ} , and Theorem 3 can be obtained as a special case of this theorem for $\Lambda = n_{\rm avg}$.

Theorem 22. For $X \sim M$, any $\Lambda > 0$, $\epsilon \ge \frac{1}{\Lambda} \max\left(\frac{\log^4 k}{k}, \exp^{-\frac{\Lambda}{8}}\right)$, with probability $\ge 1 - 6k^{-3}$, there is a row subset $I_{\text{cn}} \subseteq [k]$ of possibly contaminated rows such that $\sum_{i \in I} \bar{w}_{\Lambda}^f(i) \le \epsilon k$ and

$$||R(N, \bar{w}_{\Lambda})_{I_{\operatorname{cn}}^{\mathsf{c}}}|| \leq \mathcal{O}(\sqrt{\Lambda} \cdot \log \frac{2}{\epsilon}).$$

To prove the above theorem we first establish the bound on $\ell_\infty \to \ell_2$ norm of submatrices of the regularized noise matrix and use a known result, referred as Grothendieck-Pietsch factorization, to relate this norm to spectral norm. Next we define $\ell_\infty \to \ell_2$ norm and state Grothendieck-Pietsch factorization.

The $\ell_{\infty} \to \ell_2$ norm of a matrix $A \in \mathbb{R}^{k \times m}$ is

$$||A||_{\infty \to 2} := \max_{||v||_{\infty} = 1} ||Av||_2 = \max_{v \in \{-1,1\}^m} ||Av||_2.$$

Since the vector v in this definition takes value in the finite set $(\{-1,1\}^m)$, standard probabilistic techniques are better suited for bounding the $\ell_\infty \to \ell_2$ norm than for bounding the spectral norm directly. In turn, Grothendieck-Pietsch factorization helps us relate $\ell_\infty \to \ell_2$ and spectral norm.

Theorem 23. (Grothendieck-Pietsch factorization)

For any $A \in \mathbb{R}^{k \times m}$ there is a vector $\mu = (\mu(1),...,\mu(m))$ with $\mu(j) \geq 0$ and $\sum_j \mu(j) = 1$ such that

$$||A \cdot D^{-\frac{1}{2}}(\mu)|| \le \sqrt{\frac{\pi}{2}} \cdot ||A||_{\infty \to 2}.$$

The above result can be obtained by combining Little Grothendieck Theorem and Pietsch Factorization, and has appeared in [LT13] (Proposition 15.11) and [LLV17] (Theorem 3.1).

To prove the above theorem, therefore, we first bound the $\ell_\infty \to \ell_2$ norm of submatrices of $D^{-\frac{1}{2}}(\bar{w}_\Lambda^f)$. N. The proof of the lemma is based on standard use of the probabilistic methods. Due to the symmetry, a similar bound will hold on $\ell_\infty \to \ell_2$ norm of submatrices of $(N \cdot D^{-\frac{1}{2}}(\bar{w}_\Lambda^b))^\intercal = D^{-\frac{1}{2}}(\bar{w}_\Lambda^b) \cdot N^\intercal$.

Lemma 24. $(\ell_{\infty} \to \ell_2 \ concentration)$ With probability $\geq 1 - 3k^{-3}$, for every $\max(\frac{\log^4 k}{\Lambda}, \frac{k \exp^{-\frac{\Lambda}{8}}}{\Lambda}) \leq \ell \leq k$, and every $I, J \subseteq [k]$ of size ℓ ,

$$||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f)\cdot N)_{I\times J}||_{\infty\to 2}\leq \mathcal{O}(\sqrt{\Lambda\ell\log(ek/\ell)}).$$

Proof.

$$\begin{split} ||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N)_{I \times J}||_{\infty \to 2}^2 &= \max_{v \in \{-1,1\}^{\ell}} ||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N)_{I \times J} \cdot v||^2 \\ &= \max_{v \in \{-1,1\}^{\ell}} \sum_{i \in I} \left(\sum_{j \in J} \frac{N_{i,j}}{\sqrt{\bar{w}_{\Lambda}^f(i)}} v(j)\right)^2 \\ &= \max_{v \in \{-1,1\}^{\ell}} \sum_{i \in I} \frac{Z_i(v)^2}{\bar{w}_{\Lambda}^f(i)} = \max_{v \in \{-1,1\}^{\ell}} \sum_{i \in I} \widehat{Z}_i(v)^2, \end{split}$$

where

$$Z_i(v) = \sum_{j \in J} N_{i,j} v(j) \quad \text{and} \quad \widehat{Z}_i(v) = \frac{Z_i(v)}{\sqrt{\bar{w}_{\Lambda}^f(i)}}.$$

For a fix v, $Z_i(v)$ is the sum of independent zero-mean random variables, the following bound follows from Bernstein's inequality, for any t > 0

$$\Pr(|Z_i(v)| > t) \le 2 \exp\left(\frac{-t^2/2}{||M_{i,*}||_1 + t/3}\right) \le 2 \exp\left(\frac{-t^2/2}{\Lambda \tilde{w}_{\Lambda}^f(i) + t/3}\right). \tag{12}$$

Observe that

$$|Z_{i}(v)| \leq \sum_{i \in J} |N_{i,j}| \leq ||N_{i,*}||_{1} \leq ||X_{i,*}||_{1} + ||M_{i,*}||_{1} \leq (\bar{w}_{\Lambda}^{f}(i) + \tilde{w}_{\Lambda}^{f}(i))\Lambda.$$
(13)

Based on the values of $\tilde{w}_{\Lambda}^f(i)$ and $\bar{w}_{\Lambda}^f(i)$ we divide the rows into two categories, and let random variable T_i denote the category of row i,

$$T_i := \begin{cases} 1 & \text{if } \bar{w}_{\Lambda}^f(i) \geq \frac{\tilde{w}_{\Lambda}^f(i)}{2}, \\ 2 & \text{else} \ . \end{cases}$$

Let $\xi_i := \mathbb{1}_{\{T_i = 1\}}$ be the indicator random variable corresponding to the event that row i is in the first category. Hence, $\bar{\xi}_i := 1 - \xi_i = \mathbb{1}_{\{T_i = 2\}}$. Then

$$\sum_{i \in I} \widehat{Z}_i(v)^2 = \sum_{i \in I} (\xi_i + \bar{\xi}_i) \widehat{Z}_i(v)^2.$$

Next, we bound the contribution of the rows in each categories to the above term.

1. $T_i = 1 : \bar{w}_{\Lambda}^f(i) \ge \frac{\tilde{w}_{\Lambda}^f(i)}{2}$.

To bound the contribution of the rows in category 1, we show for any given v, $\xi_i \widehat{Z}_i(v)$ are sub-Gaussian random variables with sub-Gaussian norm $\mathcal{O}(\sqrt{\Lambda})$. Then we bound sum of their squares, which are sub-exponential random variable, by applying Bernstien's concentration bound. We first prove that $\xi_i \widehat{Z}_i(v)$ are sub-Gaussian.

From equation (13) and the definition of category 1, we get

$$|\xi_i Z_i(v)| \leq |Z_i(v)| \leq (\bar{w}_{\Lambda}^f(i) + \tilde{w}_{\Lambda}^f(i))\Lambda \leq (\bar{w}_{\Lambda}^f(i) + 2\bar{w}_{\Lambda}^f(i))\Lambda = 3\bar{w}_{\Lambda}^f(i)\Lambda,$$

hence

$$\bar{w}_{\Lambda}^f(i) \ge \frac{|\xi_i Z_i(v)|}{\Lambda}.$$

Then

$$|\xi_i\widehat{Z}_i(v)| = \frac{|\xi_iZ_i(v)|}{\sqrt{\bar{w}_{\Lambda}^f(i)}} \leq \min\Big\{|\sqrt{\Lambda Z_i(v)}|, \frac{|Z_i(v)|}{\sqrt{\tilde{w}_{\Lambda}^f(i)/2}}\Big\},$$

here we used the previous equation, the fact that $\xi_i \leq 1$, and $\bar{w}_{\Lambda}^f(i) \geq \tilde{w}_{\Lambda}^f(i)/2$, which follows from the definition of the category 1. Using equation (12) we get

$$\Pr(\frac{|Z_i(v)|}{\sqrt{\tilde{w}_{\Lambda}^f(i)/2}} > t) = \Pr(|Z_i(v)| > t\sqrt{\frac{\tilde{w}_{\Lambda}^f(i)}{2}}) \le 2\exp\bigg(\frac{-t^2\tilde{w}_{\Lambda}^f(i)/4}{\Lambda\tilde{w}_{\Lambda}^f(i) + \frac{t}{3}\cdot\sqrt{\frac{\tilde{w}_{\Lambda}^f(i)}{2}}}\bigg).$$

For $t \leq 3\Lambda\sqrt{\frac{\tilde{w}_{\Lambda}^f(i)}{2}}$, the above equation gives the following bound

$$\Pr\left(\frac{|Z_i(v)|}{\sqrt{\tilde{w}_{\Lambda}^f(i)/2}} > t\right) \le 2\exp\left(\frac{-t^2\tilde{w}_{\Lambda}^f(i)/4}{\Lambda\tilde{w}_{\Lambda}^f(i) + \Lambda \cdot \frac{\tilde{w}_{\Lambda}^f(i)}{2}}\right) = 2\exp\left(\frac{-t^2}{6\Lambda}\right). \tag{14}$$

And, similarly

$$\Pr(|\sqrt{Z_i(v)\Lambda}| > t) = \Pr(|Z_i(v)| > \frac{t^2}{\Lambda}) \le 2\exp\left(\frac{-\frac{t^4}{2\Lambda^2}}{\Lambda \tilde{w}_{\Lambda}^f(i) + \frac{t^2}{2\Lambda}}\right).$$

For $t \geq 3\Lambda\sqrt{\frac{\tilde{w}_{\Lambda}^f(i)}{2}}$, the above equation give the following bound

$$\Pr(|\sqrt{Z_i(v)\Lambda}| > t) \le 2 \exp\left(\frac{-\frac{t^4}{2\Lambda^2}}{\frac{2t^2}{9\Lambda} + \frac{t^2}{3\Lambda}}\right) = 2 \exp\left(\frac{-t^2}{10\Lambda/9}\right).$$

Combining equation (14) and the above equation we get

$$\Pr(|\xi_i \widehat{Z}_i(v)| > t) \le 2 \exp\left(\frac{-t^2}{6\Lambda}\right).$$

This shows that $\xi_i \widehat{Z}_i(v)$ is sub-Gaussian with sub-Gaussian norm $\leq \sqrt{3\Lambda}$. Therefore, $\xi_i \widehat{Z}_i^2(v)$ is sub-exponential with sub-exponential norm $\leq 3\Lambda$. From Bernstein's inequality, for all $\varepsilon \geq 1$,

$$\Pr\left(\sum_{i \in I} \xi_i \widehat{Z}_i^2(v) > \varepsilon \ell \Lambda\right) \le 2 \exp^{-c\varepsilon \ell}.$$

Choosing $\varepsilon=(14/c)\log(ek/\ell)$, bounds the above probability by $(ek/\ell)^{-7\ell}$. Taking the union bound over all possible ℓ,v,I , and J, in above equation we get $\sum_{i\in I}\xi_i\widehat{Z}_i^2(v)\leq \varepsilon\ell\Lambda$ with probability at least

$$1 - \sum_{\ell=1}^{k} 2^{\ell} {k \choose \ell}^2 \left(\frac{ek}{\ell}\right)^{-7\ell} \ge 1 - k^{-3}. \tag{15}$$

2. $T_i=2: \ \bar{w}_{\Lambda}^f(i) < rac{ ilde{w}_{\Lambda}^f(i)}{2}.$ Note that,

$$|\bar{\xi}_i \widehat{Z}_i(v)| \le |\bar{\xi}_i Z_i(v)| \stackrel{\text{(a)}}{\le} \frac{3}{2} \widetilde{w}_{\Lambda}^f(i) \Lambda,$$

where (a) uses equation (13). Then,

$$\sum_{i \in I} \bar{\xi}_i \widehat{Z}_i(v)^2 \le \sum_{i \in [k]} \bar{\xi}_i \widehat{Z}_i(v)^2 \le \left(\frac{3}{2}\right)^2 \sum_{i \in [k]} \bar{\xi}_i \left(\tilde{w}_{\Lambda}^f(i)\Lambda\right)^2. \tag{16}$$

We bound the above term by showing:

Claim: With probability $\geq 1 - 2/k^3$,

$$\sum_{i \in I} \bar{\xi}_i \left(\tilde{w}_{\Lambda}^f(i) \right)^2 \le \mathcal{O}\left(\frac{\log^4 k + ke^{-\frac{\Lambda}{8}}}{\Lambda^2} \right).$$

Proof of the claim: Next, once again divide the rows into categories based on the expected count, and let S_i denote the category of row i,

$$S_i := \begin{cases} 0 & \text{if } \tilde{w}_{\Lambda}^f(i) \leq 2\\ j & \text{for } j \geq 1, & \text{if } \tilde{w}_{\Lambda}^f(i) \in (2^j, 2^{j+1}]. \end{cases}$$

For a given M, category S_i of row i is determined and is not a random variable unlike T_i .

Note that

$$\begin{split} \{\tilde{w}^f_{\Lambda}(i) > 2\bar{w}^f_{\Lambda}(i)\} &\equiv \{\max\{1, \frac{||M_{i,*}||_1}{\Lambda}\} > \max\{2, \frac{2||X_{i,*}||_1}{\Lambda}\}\} \equiv \{||M_{i,*}||_1 > \max\{2\Lambda, 2||X_{i,*}||_1\}\}. \end{split}$$
 Next,

$$\Pr\left(2||X_{i,*}||_1 \le ||M_{i,*}||_1\right) = \Pr\left(||X_{i,*}||_1 - ||M_{i,*}||_1 \le -\frac{||M_{i,*}||_1}{2}\right)$$
$$= \Pr\left(\sum_{j \in [n]} (X_{i,j} - M_{i,j}) \le -\frac{\sum_{j \in [n]} M_{i,j}}{2}\right) \le e^{-\frac{||M_{i,*}||_1}{8}},$$

here we used $\mathbb{E}[X_{i,j}] = M_{i,j}$ and Chernoff bound. Therefore,

$$\Pr[\tilde{w}_{\Lambda}^{f}(i) > 2\bar{w}_{\Lambda}^{f}(i)] \leq \begin{cases} 0, & \text{if } ||M_{i,*}||_{1} \leq 2\Lambda, \\ e^{-\frac{||M_{i,*}||_{1}}{8}} = e^{-\frac{\Lambda \bar{w}_{\Lambda}^{f}(i)}{8}}, & \text{if } ||M_{i,*}||_{1} > 2\Lambda. \end{cases}$$

Then from the definitions of S_i and $\tilde{w}_{\Lambda}^f(i)$, it follows that

$$\Pr[\bar{\xi}_i = 1] = \Pr[\tilde{w}_{\Lambda}^f(i) > 2\bar{w}_{\Lambda}^f(i)] \le \begin{cases} 0, & \text{if } S_i = 0, \\ e^{-\frac{\Lambda \bar{w}_{\Lambda}^f(i)}{8}} \le e^{-\frac{2^{S_i}\Lambda}{8}}, & \text{if } S_i \ge 1. \end{cases}$$
(17)

Using the Chernoff bound, for any i > 1,

$$\Pr\left(\sum_{i:S_i=j} \bar{\xi}_i \ge 15\log k + 2\sum_{i:S_i=j} \mathbb{E}[\bar{\xi}_i]\right) \le k^{-5}.$$
 (18)

Let $\tau = \lfloor \log_2 \frac{16 \ln k}{\Lambda} \rfloor$. For a row *i* such that $S_i > \tau$, using (17) we get

$$\Pr[\bar{\xi}_i = 1] \le k^{-4}.$$

Therefore, with probability $\geq 1 - \frac{\{i:S_i > \tau\}}{k^5} \geq 1 - \frac{1}{k^3}$

$$\sum_{i:S_i > \tau} \bar{\xi}_i = 0. \tag{19}$$

Then

$$\begin{split} &\sum_{i \in [k]} \bar{\xi}_i \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \stackrel{\text{(a)}}{=} \sum_{j \geq 1} \sum_{i:S_i = j} \bar{\xi}_i \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \\ &\stackrel{\text{(b)}}{=} \sum_{j = 1}^{\tau} \sum_{i:S_i = j} \mathbbm{1}_{\{T_i = 2\}} \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \leq \sum_{j = 1}^{\tau} \max_{i:S_i = j} \big\{ \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \big\} \sum_{i:S_i = j} \bar{\xi}_i \\ &\stackrel{\text{(c)}}{\leq} \sum_{j = 1}^{\tau} \max_{i:S_i = j} \big\{ \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \big\} \Big(15 \log k + 2 \sum_{i:S_i = j} \mathbb{E}[\bar{\xi}_i] \Big) \\ &\leq 15\tau \log k \max_{i:S_i \leq \tau} \big\{ \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \big\} + \sum_{j = 1}^{\tau} \max_{i:S_i = j} \big\{ \big(\tilde{w}_{\Lambda}^f(i) \big)^2 \big\} \max_{i:S_i = j} \big\{ \mathbb{E}[\bar{\xi}_i] \big\} \Big(2 |\{i:S_i = j\}| \Big) \\ &\stackrel{\text{(d)}}{\leq} 15\tau \log k \Big(2^{\tau+1} \Big)^2 + \sum_{j = 1}^{\tau} \Big(|\{i:S_i = j\}| \Big) \times \Big(2^{2j+2} \cdot e^{-\frac{2^j \Lambda}{8}} \Big) \\ &\leq \mathcal{O}(\frac{\log^4 k}{\Lambda^2}) + \mathcal{O}\Big(\max_{j \geq 1} \Big\{ \Big(2^j \Lambda \Big)^2 e^{-\frac{2^j \Lambda}{8}} \Big\} \cdot \Lambda^{-2} \cdot \sum_{j = 1}^{\tau} |\{i:S_i = j\}| \Big) \\ &\stackrel{\text{(e)}}{\leq} \mathcal{O}(\frac{\log^4 k}{\Lambda^2}) + \mathcal{O}\Big(\max_{j \geq 1} \Big\{ e^{-\frac{2^j \Lambda}{16}} \Big\} \cdot \frac{k}{\Lambda^2} \Big) \\ &\leq \mathcal{O}\Big(\frac{\log^4 k + k e^{-\frac{\Lambda}{8}}}{\Lambda^2} \Big), \end{split}$$

with probability $1-1/k^3-\tau/k^5\geq 1-2/k^3$. Here (a) follows since $S_i=1$ implies $\bar{\xi}_i=0$, (b) follows from equation (19), (c) uses equation (18), (d) follows from the definition of S_i and equation (17), and (e) follows as total number of rows are k and $\frac{x^2\exp{(-x/8)}}{\exp{(-x/16)}}$ is bounded for x>0. This completes the proof of the claim.

Combining the Claim and (16) gives the following bound on the contribution of rows in $T_i = 2$,

$$\sum_{i \in I} \bar{\xi}_i \widehat{Z}_i^2 \le \mathcal{O}(\log^4 k + ke^{-\frac{\Lambda}{8}}),$$

with probability $\geq 1 - 2/k^3$.

Combining this bound and the bound in (15),

$$\sum_{i \in I} \widehat{Z}_i^2 = \sum_{i \in I} \bar{\xi}_i \widehat{Z}_i^2 + \sum_{i \in I} \xi_i \widehat{Z}_i^2 \le \mathcal{O}(\log(ek/\ell)\ell\Lambda + \log^4 k + k \exp^{-\frac{\Lambda}{8}}),$$

with probability $\geq 1 - 3k^{-3}$. Noting that $\ell \Lambda \geq \max(\log^4 k, k \exp^{-\frac{\Lambda}{8}})$, completes the proof.

The next lemma combines the bound obtained on $\ell_\infty \to \ell_2$ norm in the above lemma and Grothendieck-Piesch factorization to obtain bound on the spectral norm.

Lemma 25. With probability $\geq 1 - 3k^{-3}$, for any $\max(\frac{\log^4 k}{\Lambda}, \frac{k \exp^{-\frac{\Lambda}{8}}}{\Lambda}) \leq \ell \leq k$, and any $I, J \subseteq [k]$ of size $|I|, |J| = \ell$, there exists a subset $J' \subseteq J$ such that $\sum_{j \in J'} \bar{w}_{\Lambda}^b(j) \leq \ell/2$ and

$$||(R(N, \bar{w}_{\Lambda}))_{I \times J'}|| \le c\sqrt{\Lambda \log(ek/\ell)}$$

Proof. Applying Grothendieck-Piesch factorization in Theorem 23 on matrix $(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f)N)_{I\times J}$, implies that there is a vector $\mu=(\mu(1),...,\mu(m))$ with $\mu(j)\geq 0$ and $\sum_j \mu(j)=1$ such that

$$||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f)\cdot N)_{I\times J}\cdot D^{-1/2}(\mu)|| \leq \sqrt{\frac{\pi}{2}}||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f)\cdot N)_{I\times J}||_{\infty\to 2}$$

Then,

$$\begin{split} || \left(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N \right)_{I \times J} \cdot D^{-\frac{1}{2}}(\mu) || &= || \left(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N \right)_{I \times J} \cdot D^{-\frac{1}{2}}(\mu) \cdot D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^b) \cdot D^{\frac{1}{2}}(\bar{w}_{\Lambda}^b) || \\ &= || \left(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N \cdot D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^b) \cdot D^{\frac{1}{2}} \left(\bar{w}_{\Lambda}^b \circ \frac{1}{\mu} \right) \right)_{I \times J} || \\ &= || \left(R(N, \bar{w}_{\Lambda}) \cdot D^{\frac{1}{2}} \left(\bar{w}_{\Lambda}^b \circ \frac{1}{\mu} \right) \right)_{I \times J} ||, \end{split}$$

here $\bar{w}^b_{\Lambda}\circ \frac{1}{\mu}:=(\frac{\bar{w}^b_{\Lambda}(1)}{\mu(1)},...,\frac{\bar{w}^b_{\Lambda}(m)}{\mu(m)}).$ Let

$$J' := \{ j \in J : \frac{\bar{w}_{\Lambda}^b(j)}{\mu(j)} \ge \frac{\ell}{2} \}$$

and $\bar{J} = J \setminus J'$. Then

$$||\big(R(N,\bar{w}_\Lambda)\cdot D^{\frac{1}{2}}\Big(\bar{w}_\Lambda^b\circ\frac{1}{\mu}\Big)\big)_{I\times J}||\geq ||\big(R(N,\bar{w}_\Lambda)\cdot D^{\frac{1}{2}}\Big(\bar{w}_\Lambda^b\circ\frac{1}{\mu}\Big)\big)_{I\times J'}||\geq \sqrt{\frac{\ell}{2}}||\big(R(N,\bar{w}_\Lambda)\big)_{I\times J'},||$$

here the last step follows from the definition of J'. Therefore,

$$||(R(N, \bar{w}_{\Lambda}))_{I \times J'}|| \leq \sqrt{\frac{\pi}{\ell}}||(D^{-\frac{1}{2}}(\bar{w}_{\Lambda}^f) \cdot N)_{I \times J}||_{\infty \to 2} \leq c\sqrt{\Lambda \log(ek/\ell)}.$$

Next, we bound the weight of the columns that are excluded from J'.

$$\sum_{j \in J} \bar{w}_{\Lambda}^b(j) \le \frac{\ell}{2} \sum_{j \in J} \mu(j) \le \frac{\ell}{2} \sum_{j \in [k]} \mu(j) = \frac{\ell}{2}.$$

Applying the above lemma on $(R(N, \bar{w}_{\Lambda}))^{\mathsf{T}}$, in place of $(R(N, \bar{w}_{\Lambda}))$, from the symmetry we get:

Lemma 26. With probability $\geq 1 - 3k^{-3}$, for any $\max(\frac{\log^4 k}{\Lambda}, \frac{k \exp^{-\frac{\Lambda}{8}}}{\Lambda}) \leq \ell \leq k$, and any $I, J \subseteq [k]$ of size $|I|, |J| = \ell$, there exists a subset $I' \subseteq I$ such that $\sum_{i \in I'} \bar{w}_{\Lambda}^f(i) \leq \ell/2$ and

$$||(R(N, \bar{w}_{\Lambda}))_{I' \times J}|| \le c\sqrt{\Lambda \log(ek/\ell)}.$$

The next lemma bounds the norm of a matrix using the norm of its sub-matrices. Incorporating the above bound on the norm of submatrices, this will complete the proof of theorem 3.

Lemma 27. Let $A \in \mathbb{R}^{k \times m}$ and $I_1, I_2, I_3, ..., I_t$ be t disjoint subsets of [k] such that $\bigcup_{j=1}^t I_j = [k]$. Then $||A|| \leq \sqrt{\sum_{j=1}^t ||A_{I_j}||^2}$.

Proof of the above lemma is given in Appendix G.

Proof of theorem 22: Main component in the proof is Lemma 25 and Lemma 26. We need to apply these lemmas in multiple rounds.

For round j, we apply these Lemmas for some, $\ell=\ell_j$ and $I=I_j$, and $J=J_j$ such that $|I_j|, |J_j| \leq k/2^{j-1}$, where ℓ_j, I_j and J_j are defined later.

First applying Lemma 26 we get, a subset $I'_i \subseteq I_j$ such that,

$$||(R(N, \bar{w}_{\Lambda}))_{I_{i}' \times J_{j}}|| \le \mathcal{O}(\sqrt{j \cdot \Lambda}), \tag{20}$$

and the weight of the excluded rows $I_j \setminus I_j'$ is at most $\sum_{i \in I_j \setminus I_j'} \overline{w}_{\Lambda}^f(i) \leq k/2^j$. Since weight of each row is at-least 1, this implies that the number of rows excluded in round j are also at most $|I_j \setminus I_j'| \leq k/2^j$.

Similarly, applying Lemma 25 we get, a subset $J'_j \subseteq J_j$ such that $\sum_{i \in J_i \setminus J'_i} \bar{w}^b_{\Lambda}(i) \le k/2^j$,

$$||(R(N, \bar{w}_{\Lambda}))_{I_j \times J_i'}|| \le \mathcal{O}(\sqrt{j \cdot \Lambda}).$$
 (21)

and $\sum_{i \in J_j \setminus J'_j} \bar{w}_{\Lambda}^b(i) \le k/2^j$ and $|J_j \setminus J'_j| \le k/2^j$. Since zeroing out rows from a matrix reduces the spectral norm, the above equation gives

$$||(R(N, \bar{w}_{\Lambda}))_{(I_{j} \setminus I'_{j}) \times J'_{j}}|| \leq \mathcal{O}(\sqrt{j \cdot \Lambda}).$$
(22)

In round j=1, we start with $\ell_1=k$ and $I_1=J_1=[k]$. For round j>1 we chose, $\ell_j:=\frac{\ell_{j-1}}{2}$, $I_j:=I_{j-1}\setminus I'_{j-1}$ and $J_j:=J_{j-1}\setminus J'_{j-1}$. Note that I_j and J_j are the excluded rows and columns in the concentration bounds of the previous round.

We use this procedure for $t = \lceil \log(k/\epsilon k) \rceil$ rounds, so that the weight and the number of excluded rows, and columns, in the end is at-most ϵk .




Figure 1: Construction of submatrices in proof of theorem 3.

Let $\mathcal{M}_j := I_j \times J_j$, which is of size $k/2^{j-1} \times k/2^{j-1}$, $\mathcal{R}_j := I_j' \times J_j$ and $\mathcal{C}_j := I_j \setminus I_j' \times J_j' = I_{j+1} \times J_j'$. Note that equation 20 and 22 gives the concentration bound for sub-matrices corresponding to \mathcal{R}_j and \mathcal{C}_j , respectively. Figure 1 shows this construction.

This construction decomposes the submatrix indexed by \mathcal{M}_j into three submatrices

$$\left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{M}_{i}} = \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{R}_{i}} + \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{C}_{i}} + \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{M}_{i+1}}.$$

Applying the above equation recursively,

$$\begin{split} &\left(R(N,\bar{w}_{\Lambda})\right) = \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{M}_{1}} \\ &= \sum_{j=1}^{t} \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{R}_{j}} + \sum_{j=1}^{t} \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{C}_{j}} + \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{M}_{t+1}} \\ &= \left(R(N,\bar{w}_{\Lambda})\right)_{\cup_{j=1}^{t} \mathcal{R}_{j}} + \left(R(N,\bar{w}_{\Lambda})\right)_{\cup_{j=1}^{t} \mathcal{C}_{j}} + \left(R(N,\bar{w}_{\Lambda})\right)_{\mathcal{M}_{t+1}}, \end{split}$$

where the last equality follows as \mathcal{R}_j 's and \mathcal{C}_j 's are disjoint. Then

$$\begin{split} || \left(R(N, \bar{w}_{\Lambda}) \right)_{([k] \times [k]) \setminus \mathcal{M}_{t+1}} || &= || R(N, \bar{w}_{\Lambda}) - \left(R(N, \bar{w}_{\Lambda}) \right)_{\mathcal{M}_{t+1}} || \\ &= || \left(R(N, \bar{w}_{\Lambda}) \right)_{\cup_{j=1}^{t} \mathcal{R}_{j}} + \left(R(N, \bar{w}_{\Lambda}) \right)_{\cup_{j=1}^{t} \mathcal{C}_{j}} || \\ &\stackrel{\text{(a)}}{\leq} || \left(R(N, \bar{w}_{\Lambda}) \right)_{\cup_{j=1}^{t} \mathcal{R}_{j}} || + || \left(R(N, \bar{w}_{\Lambda}) \right)_{\cup_{j=1}^{t} \mathcal{C}_{j}} || \\ &\stackrel{\text{(b)}}{\leq} \sqrt{\sum_{j=1}^{t} \left(R(N, \bar{w}_{\Lambda}) \right)_{\mathcal{R}_{j}}} + \sqrt{\sum_{j=1}^{t} \left(R(N, \bar{w}_{\Lambda}) \right)_{\mathcal{C}_{j}}} \\ &\stackrel{\text{(c)}}{\leq} 2 \cdot \mathcal{O}(\sqrt{\sum_{j=1}^{t} j \cdot \Lambda}) \leq \mathcal{O}(t\sqrt{\Lambda}) = \mathcal{O}(\log(k/\epsilon k)\sqrt{\Lambda}), \end{split}$$

where (a) follows from triangle inequality, (b) follows from Lemma 27, and (c) follows from inequalities (20) and (22). Note that $\sum_{i \in I_{t+1}} \bar{w}_{\Lambda}^f(i) = \sum_{i \in I_t \setminus I_t'} \bar{w}_{\Lambda}^f(i) \le k/2^t \le \epsilon k$ and, similarly, $\sum_{i \in I_{t+1}} \bar{w}_{\Lambda}^b(i) \le \epsilon k$.

Recall that $\mathcal{M}_{t+1} = I_{t+1} \times J_{t+1}$, therefore zeroing out rows I_{t+1} from $([k] \times [k]) \setminus \mathcal{M}_{t+1}$ results in $([k] \setminus I_{t+1} \times [k])$. And since zeroing out rows reduces of a matrix reduces the spectral norm, from the above equation we get

$$||(R(N, \bar{w}_{\Lambda}))_{([k]\setminus I_{t+1}\times[k])}|| \leq ||(R(N, \bar{w}_{\Lambda}))_{([k]\times[k])\setminus \mathcal{M}_{t+1}}|| \leq \mathcal{O}(\log(k/\epsilon k)\sqrt{\Lambda}),$$

where $\sum_{i \in I_{t+1}} \bar{w}_{\Lambda}^f(i) = \sum_{i \in I_t \setminus I_t'} \bar{w}_{\Lambda}^f(i) \le k/2^t \le \epsilon k$. Letting I_{t+1} to be the set of contaminated rows completes the proof of the theorem.

In the next subsection, we derive a useful implication of Lemma 24.

E.1 Proof of Lemma 20

The lemma upper bounds the sum of the absolute difference between the expected and observed samples in each row of X. We restate the lemma.

Lemma. With probability $\geq 1 - 3k^{-3}$,

$$\sum_{i} |\sum_{j} N_{i,j}| = \mathcal{O}(k\sqrt{n_{avg}}).$$

Proof. To prove the above Lemma we use Lemma 24, for $\Lambda = n_{\text{avg}}$, $\ell = k$ and I = J = [k]. The lemma implies that w.p. $\geq 1 - 3/k^3$,

$$\max_{v \in \{-1,1\}^k} ||D^{-\frac{1}{2}}(\bar{w}^f) \cdot N \cdot v|| = ||D^{-\frac{1}{2}}(\bar{w}^f) \cdot N||_{\infty \to 2} \le \mathcal{O}(\sqrt{n_{\text{avg}}k}).$$

From the definition of $\ell_{\infty} \to \ell_2$ norm,

$$\max_{v \in \{-1,1\}^k} ||D^{-\frac{1}{2}}(\bar{w}^f) \cdot N \cdot v|| = ||D^{-\frac{1}{2}}(\bar{w}^f) \cdot N||_{\infty \to 2}.$$

In the above equation choosing v=(1,1,...,1) and taking the square on the both side, we get

$$\sum_{i} \left(\sum_{j} \frac{N_{i,j}}{\sqrt{\bar{w}^f(i)}} \right)^2 \le ||D^{-\frac{1}{2}}(\bar{w}^f) \cdot N||_{\infty \to 2}^2 \le \mathcal{O}(n_{\text{avg}}k).$$

The above equation can be rewritten as,

$$\sum_{i} \frac{|\sum_{j} N_{i,j}|^2}{\bar{w}^f(i)} \le \mathcal{O}(n_{\text{avg}}k).$$

Then

$$\sum_i |\sum_j N_{i,j}| = \sum_i \frac{|\sum_j N_{i,j}|}{\sqrt{\bar{w}^f(i)}} \cdot \sqrt{\bar{w}^f(i)} \leq \Big(\sum_i \frac{|\sum_j N_{i,j}|^2}{\bar{w}^f(i)}\Big)^{\frac{1}{2}} \cdot \Big(\sum_i \bar{w}^f(i)\Big)^{\frac{1}{2}} = \mathcal{O}(k\sqrt{n_{\mathsf{avg}}}).$$

here we used the Cauchy-Schwarz inequality, the previous equation, and Lemma 18 that states $\sum_i \bar{w}^f(i) \leq 2k$.

F Counterexample

The authors of [LLV17] posed the following question, whose affirmative answer may have simplified low-rank matrix recovery. They posed the question for Bernoulli-parameter matrix.

Let $M \in \mathbb{R}^{k \times k}$ be a Bernoulli-parameter matrix where $\forall i, j \in [k], ||M||_{i,*}, ||M||_{*,j} \leq n_{\max}$, for some n_{\max} .

Let $X = [X_{i,j}]$, where $X_{i,j} \sim \operatorname{Ber}(M_{i,j})$, be the observation matrix of M, and let X_0 be the matrix obtained by zeroing-out the rows and columns of X whose total count is $> 2n_{\max}$. Does X_0 converges to M w.h.p. as

$$||X_0 - M|| = \mathcal{O}(\sqrt{n_{\text{max}}})$$
?

Unfortunately, the following counterexample answers this question in negative. Therefore additional work, such as presented in this paper, is needed to recover low-rank matrices.

For any k, choose any $n_{\text{max}} \leq \sqrt{\log k}/8$ that grows with k, and consider the block diagonal matrix

$$M = \left(egin{array}{cccc} B_1 & & & & & & & \\ & B_2 & & & & & & \\ & & \ddots & & & & & \\ & & & B_{(rac{k}{2n_{ ext{max}}}-1)} & & & & \\ & & & B_{rac{k}{2n_{ ext{max}}}} \end{array}
ight)$$

consisting of $k/(2n_{\max})$ (for simplicity assume it is an integer) identical blocks $B_i = B$, each a submatrix of size $2n_{\max} \times 2n_{\max}$ whose entries are all 1/2. Except for the blocks B_i 's, all the other entries of M are zero. Then M satisfies $\forall i,j \in [n], ||M||_{i,*} = ||M||_{*,j} = n_{\max}$.

Note that, for the above matrix $n_{\text{avg}} = ||M||_1/k = n_{\text{max}}$.

The observation matrix of M is

$$X = \begin{pmatrix} \hat{B}_1 & & & & & \\ & \hat{B}_2 & & & & & \\ & & \ddots & & & & \\ & & & \hat{B}_{(\frac{k}{2n_{\max}} - 1)} & & & & \\ & & & & \hat{B}_{\frac{k}{2n_{\max}}} \end{pmatrix}.$$

Note that X has non-zero entries only in locations corresponding to the diagonal blocks B. Also, $\forall i,j \in [k], \ ||X||_{i,*}, ||X||_{*,j} < 2n_{\max}$. Therefore zeroing out rows and columns of X with more than n_{\max} ones would not affect it and $X_0 = X$. From Theorem 6,

$$||X - M|| \ge \max_{i} ||\hat{B}_i - B_i||.$$

Since \hat{B}_i is the observation matrix for the $2n_{\max} \times 2n_{\max}$ block B_i whose entries are all 1/2, and $n_{\max} = o(\sqrt{\log k})$,

$$\Pr\left(\hat{B}_i = 0\right) = (1/2)^{4n_{\text{max}}^2} > 1/\sqrt{k}.$$

The probability that the whole $2n_{\max} \times 2n_{\max}$ block \hat{B}_i is 0, is $(1/2)^{4n_{\max}^2}$, which since $n_{\max} = o(\sqrt{\log k})$, is $> 1/\sqrt{k}$. Hence w.h.p., at least one of the block $j \in [\frac{k}{2n_{\max}}]$ in X is zero. Hence w.h.p.,

$$||X - M|| \ge ||B_j|| = n_{\text{max}} \gg \Omega(\sqrt{n_{\text{max}}}).$$

This counterexample answers the question raised by the authors of [LLV17] in negative.

We note that the same counterexample works for the regularization $R(X-M,\bar{w})$ used in this paper. Because if block \hat{B}_j of X is zero, from the definition of \bar{w} , it is easy to see that for the rows and columns corresponding to the block \hat{B}_j , the regularization weights are 1, which implies that

$$||R(X - M, \bar{w})|| \ge ||B_j|| = n_{\text{max}},$$

extending the counterexample for the regularization $R(X-M,\bar{w})$ as well.

G Linear Algebra Proofs

G.1 Proof of Lemma 4

Lemma. For any rank-r matrix $A \in \mathbb{R}^{k \times k}$, matrix $B \in \mathbb{R}^{k \times k}$, and weights w,

$$||A - B^{(r,w)}||_1 \le \sqrt{r \cdot (\sum_i w^f(i))(\sum_j w^b(j))} \cdot ||R(A - B, w)||.$$

Proof. Recall that

$$B^{(r,w)} := D^{\frac{1}{2}}(w^f) \cdot R(B,w)^{(r)} \cdot D^{\frac{1}{2}}(w^b),$$

where $R(B,w) = D^{-\frac{1}{2}}(w^f) \cdot B \cdot D^{-\frac{1}{2}}(w^b)$ is regularized matrix B and $R(B,w)^{(r)}$ is its rank r-truncated SVD.

We first upper bound the spectral norm of $R(A, w) - R(B, w)^{(r)}$ in terms of the spectral norm of R(A - B, w). By Weyl's Inequality 7, and the rank r of A,

$$\sigma_{r+1}(R(B,w)) \le \sigma_{r+1}(R(A,w)) + ||R(A,w) - R(B,w)|| = ||R(A-B,w)||.$$

Hence by the triangle inequality and the salient property of truncated SVD's,

$$||R(A, w) - R(B, w)^{(r)}|| \le ||R(B, w)^{(r)} - R(B, w)|| + ||R(A, w) - R(B, w)||$$

= $\sigma_{r+1}(R(B, w)) + ||R(A - B, w)|| \le 2||R(A - B, w)||.$

Since $A-B_r^{\text{SVD}}$ is the difference of two rank-r matrices, it has rank $\leq 2r$. Then applying Lemma 17 for matrix $(R(A,w)-R(B,w)^{(r)})$, and noting that $A=D^{\frac{1}{2}}(w^f)\cdot R(A,w)\cdot D^{\frac{1}{2}}(w^b)$ completes the proof.

G.2 Proof of Lemma 9

Lemma. For any matrix A and weight vectors w^f and w^b with positive entries

$$||D^{-\frac{1}{2}}(w^f) \cdot A \cdot D^{-\frac{1}{2}}(w^b)|| \le \sqrt{\max_i \frac{||A_{i,*}||_1}{w^f(i)} \times \max_j \frac{||A_{*,j}||_1}{w^b(j)}}$$

Proof. For a unit vector $v = (v(1), \dots, v(m)) \in \mathbb{R}^m$,

$$\begin{split} &||D^{-\frac{1}{2}}(w^f)\cdot A\cdot D^{-\frac{1}{2}}(w^b)\cdot v||^2 = \sum_i \Big(\sum_j \frac{A_{i,j}v(j)}{\sqrt{w^f(i)\cdot w^b(j)}}\Big)^2 \\ &\leq \sum_i \Big(\sum_j \frac{|A_{i,j}||v(j)|}{\sqrt{w^f(i)\cdot w^b(j)}}\Big)^2 \\ &= \sum_i \Big(\sum_j \sqrt{\frac{|A_{i,j}|}{w^f(i)}} \sqrt{\frac{|A_{i,j}|}{w^b(j)}}|v(j)|\Big)^2 \\ &\stackrel{\text{(a)}}{\leq} \sum_i \Bigg(\Big(\sum_j \frac{|A_{i,j}|}{w^f(i)}\Big)\Big(\sum_j \frac{|A_{i,j}|}{w^b(j)}v(j)^2\Big)\Big) \leq \max_{i'} \frac{||A_{i',*}||_1}{w^f(i')} \sum_i \sum_j \Big(\frac{|A_{i,j}|}{w^b(j)}v(j)^2\Big) \\ &= \max_{i'} \frac{||A_{i',*}||_1}{w^f(i')} \sum_j \Big(v(j)^2 \sum_i \frac{|A_{i,j}|}{w^b(j)}\Big) \leq \max_{i'} \frac{||A_{i',*}||_1}{w^f(i')} \sum_j v(j)^2 \frac{||A_{*,j}||_1}{w^b(j)} \\ &\leq \max_{i'} \frac{||A_{i',*}||_1}{w^f(i')} \times \max_{j'} \frac{||A_{*,j'}||_1}{w^b(j')} \sum_i v(j)^2 = \max_{i'} \frac{||A_{i',*}||_1}{w^f(i')} \times \max_{j'} \frac{||A_{*,j'}||_1}{w^b(j')}, \end{split}$$

where (a) uses the Cauchy-Schwarz inequality. Observing that above is true for arbitrary unit vector v completes the proof.

G.3 Proof of Lemma 10

Lemma. Let A be an $k \times m$ matrix such that $\sigma_1(A) \leq \alpha$ and $\sigma_{r+1}(A) \leq \beta$. Then the number of disjoint row subsets $I \subset [k]$ such that $||A_I|| > 2\beta$ is at most $\left(\frac{r\alpha}{\beta}\right)^2$.

Proof. Let $A = \sum_{i=1}^{\min\{k,m\}} \sigma_i(A) u_i v_i^{\mathsf{T}}$ be the SVD decomposition of A. Recall that $A^{(r)} = \sum_{i=1}^r \sigma_i(A) u_i v_i^{\mathsf{T}}$ and let $B = A - A^{(r)}$.

Note that $||A^{(r)}|| = \sigma_1(A) \le \alpha$ and the matrix $A^{(r)}$ has rank r i.e. $\sigma_{r+1}(A^{(r)}) = 0$. And $||B|| = \sigma_1(B) = \sigma_{r+1}(A) \le \beta$.

To prove the lemma we upper bound the number of disjoint subsets $I \subset [k]$ such that $||A_I|| > 2\beta$. Let $I \subset [k]$ be one such subset such that $||A_I|| > 2\beta$. Then

$$||A_I|| \stackrel{\text{(a)}}{\leq} ||A_I^{(r)}|| + ||B_I|| \stackrel{\text{(b)}}{\leq} ||A_I^{(r)}|| + ||B|| \leq ||A_I^{(r)}|| + \beta,$$

where inequality (a) follows from the triangle inequality and (b) follows from Theorem 6. Hence,

$$||A_I^{(r)}|| \ge \beta.$$

Note that since row span of $A^{(r)}$, and hence $A_I^{(r)}$ is $span\{v_1,v_2,...,v_r\}$, therefore there exists a unit vector, $v=\sum_{i=1}^r a_iv_i$ (here $\sum_{i=1}^r a_i^2=1$, since v is a unit vector), such that $||A_I^{(r)}v||\geq \beta$. Therefore,

$$\beta \le ||A_I^{(r)}v|| = ||A_I^{(r)} \sum_{i=1}^r a_i v_i|| \le \sum_{i=1}^r |a_i| \, ||A_I^{(r)} v_i|| \le \sum_{i=1}^r ||A_I^{(r)} v_i||. \tag{23}$$

Let $I_1, I_2, ..., I_t$ be the t disjoint blocks such that $||A_{I_i}|| > 2\beta, \forall j \in [t]$. Next,

$$\begin{split} \sum_{i=1}^{r} ||A^{(r)}v_i|| &\geq \sum_{i=1}^{r} ||A^{(r)}_{\cup_{j=1}^{t} I_j} v_i|| = \sum_{i=1}^{r} ||\sum_{j=1}^{t} A^{(r)}_{I_j} v_i|| \\ &\stackrel{\text{(a)}}{=} \sum_{i=1}^{r} \sqrt{\sum_{j=1}^{t} ||A^{(r)}_{I_j} v_i||^2} \stackrel{\text{(b)}}{\geq} \sum_{i=1}^{r} \frac{\sum_{j=1}^{t} ||A^{(r)}_{I_j} v_i||}{\sqrt{t}} \stackrel{\text{(c)}}{\geq} \sqrt{t}\beta. \end{split}$$

Here equality (a) follows since $A_{I_j}^{(r)}v_i$'s for $j \in [t]$ and fixed i are orthogonal. Inequality (b) follows from the AM-GM inequality (c) follows from (23).

We also have
$$\sum_{i=1}^r ||A^{(r)}v_i|| = \sum_{i=1}^r \sigma_i(A) \le r\sigma_1(A) \le r\alpha$$
. Therefore we get, $t \le \left(\frac{r\alpha}{\beta}\right)^2$.

G.4 Proof of Lemma 16

Lemma. Let A=B+C and $A=\sum_i \sigma_i(A)u_iv_i^\intercal$ be the SVD decomposition of A. And $\sigma_{r+1}(B) \leq \beta$ and $||Cv_i|| \leq 2\beta$ for $i \in [2r]$. Then $\sigma_{2r}(A) \leq 4\beta$.

Proof. Let $A^{(2r)} = \sum_{i=1}^{2r} \sigma_i(A) u_i v_i^{\mathsf{T}}$ be rank 2r truncated SVD of A, then

$$\sigma_i(A^{(2r)}) = \sigma_i(A), \ \forall \ i \le 2r \tag{24}$$

and

$$A^{(2r)} = \sum_{i=1}^{2r} A v_i v_i^{\mathsf{T}} = \sum_{i=1}^{2r} (B+C) v_i v_i^{\mathsf{T}} = \hat{B} + \hat{C}.$$
 (25)

Here $\hat{B} = \sum_{i=1}^{2r} Bv_i v_i^{\mathsf{T}}$ and $\hat{C} = \sum_{i=1}^{2r} Cv_i v_i^{\mathsf{T}}$.

Since v_i 's are orthogonal unit vector, $\sum_{i=1}^{2r} v_i v_i^\intercal$ is a projection matrix for subspace $S = span\{v_1, v_2, ..., v_{2r}\}$. And for any Projection matrix P we have, $||Pu|| \leq ||u||$. Therefore,

$$||\hat{B}^{\mathsf{T}}u|| = ||(\sum_{i=1}^{2r} v_i v_i^{\mathsf{T}}) B^{\mathsf{T}}u|| \le ||B^{\mathsf{T}}u||.$$
 (26)

Next, using Courant-Fischer theorem, $\forall i \leq \min\{k, m\}$, there exists a subspace S_i^* with dimension $dim(S_i^*) = i$, such that

$$\begin{split} \sigma_i(\hat{B}^\intercal) &= \min_{u \in S_i^*, ||u||=1} ||\hat{B}^\intercal u|| \\ &\stackrel{\text{(a)}}{\leq} \min_{u \in S_i^*, ||u||=1} ||B^\intercal u|| \\ &\leq \max_{S: dim(S)=i} \min_{u \in S, ||u||=1} ||B^\intercal u|| \\ &\stackrel{\text{(b)}}{=} \sigma_i(B^\intercal) = \sigma_i(B), \end{split}$$

where inequality (a) uses (26) and (b) again from Courant-Fischer theorem. Therefore,

$$\sigma_i(B) \ge \sigma_i(\hat{B}), \ \forall \ i \le \min\{k, m\}.$$
 (27)

Using (24), (25), Weyl's inequality 7 and (27):

$$\sigma_{2r}(A) = \sigma_{2r}(A^{(2r)}) \le \sigma_{r+1}(\hat{B}) + \sigma_r(\hat{C}) \le \sigma_{r+1}(B) + \sigma_r(\hat{C}) \le \beta + \sigma_r(\hat{C}).$$
 (28)

Now

$$\hat{C}\hat{C}^{\mathsf{T}} = \sum_{i=1}^{2r} (Cv_i)(Cv_i)^{\mathsf{T}} = \sum_{i=1}^{2r} \hat{u_j} \hat{u_j}^{\mathsf{T}}.$$

Here $\hat{u_j} = Cv_i$, hence $||\hat{u_j}|| \le 2\beta$. Note that $\hat{C}\hat{C}^{\mathsf{T}}$ and $\hat{u_j}\hat{u_j}^{\mathsf{T}}$'s are Hermitian matrices. Let $\lambda_i(.)$ denotes the i^{th} largest eigenvalue of the matrix. Then

$$\lambda_i(\hat{C}\hat{C}^{\mathsf{T}}) = \sigma_i^2(\hat{C}).$$

For rank-1 matrices $\hat{u_j}\hat{u_j}^{\mathsf{T}}$,

$$\lambda_1(\hat{u_j}\hat{u_j}^{\mathsf{T}}) = ||\hat{u_j}||^2 \le 4\beta^2 \quad \text{and} \quad \lambda_i(\hat{u_j}\hat{u_j}^{\mathsf{T}}) = 0, \ \forall j \in [2r], \quad i \ge 2.$$

Then using Lidskii's theorem [Bha13], leads to

$$\sum_{i=1}^{r} \lambda_{i} \left(\sum_{i=1}^{2r} \hat{u_{j}} \hat{u_{j}}^{\mathsf{T}} \right) \leq \sum_{i=1}^{r} \lambda_{i} \left(\sum_{i=1}^{2r-1} \hat{u_{j}} \hat{u_{j}}^{\mathsf{T}} \right) + \sum_{i}^{r} \lambda_{i} \left(\hat{u_{2r}} \hat{u_{2r}}^{\mathsf{T}} \right)$$

$$\leq \sum_{i=1}^{r} \lambda_{i} \left(\sum_{i=1}^{2r-1} \hat{u_{j}} \hat{u_{j}}^{\mathsf{T}} \right) + 4\beta^{2}.$$

By repeated application of Lidskii's theorem, we get

$$\sum_{i=1}^{r} \lambda_i \Big(\sum_{i=1}^{2r} \hat{u_j} \hat{u_j}^{\mathsf{T}} \Big) \le 8r\beta^2.$$

Since λ_i 's are decreasing, it follows

$$r\lambda_r \left(\sum_{i=1}^{2r} \hat{u_j} \hat{u_j}^{\mathsf{T}}\right) \le 8r\beta^2 \implies \lambda_r (\hat{C}\hat{C}^{\mathsf{T}}) = \sigma_r^2(\hat{C}) \le 8\beta^2. \tag{29}$$

Combining (28) and (29) we get the statement of the lemma.

G.5 Proof of Lemma 17

Lemma. For any rank-r matrix $A \in \mathbb{R}^{k \times m}$ and weight vectors w^f and w^b with non-negative entries

$$||D^{\frac{1}{2}}(w^f) \cdot A \cdot D^{\frac{1}{2}}(w^b)||_1 \le \sqrt{r(\sum_i w^f(i))(\sum_j w^b(j))} \cdot ||A||.$$

Proof.

$$\begin{split} ||A||_1 &= \sum_i \sum_j \sqrt{w^f(i) \cdot w^b(j)} |A_{ij}| \\ &\stackrel{\text{(a)}}{\leq} \sum_i \sqrt{w^f(i)} \sqrt{(\sum_j A_{ij}^2)(\sum_j w^b(j))} \\ &= \sqrt{\sum_j w^b(j)} \sum_i |\sqrt{w^f(i)}| \sqrt{(\sum_j A_{ij}^2)} \\ &\stackrel{\text{(b)}}{\leq} \sqrt{\sum_j w^b(j)} \sqrt{(\sum_i w^f(i))(\sum_i \sum_j A_{ij}^2)}, \\ &\stackrel{\text{(c)}}{=} \sqrt{\sum_j w^b(j)} \sqrt{(\sum_i w^f(i))} ||A_{I\times J}||_F \\ &\stackrel{\text{(d)}}{\leq} \sqrt{r(\sum_j w^b(j))(\sum_{i\in I} w^f(i))} \cdot ||A_{I\times J}||, \end{split}$$

where (a) and (b) follow from the Cauchy-Schwarz Inequality, (c) from the definition of the Frobenius norm

$$||A||_F := \sqrt{\sum_{i,j} A_{ij}^2},$$

and (d) as

$$||A||_F \le \sqrt{\operatorname{rank}(A)}||A||.$$

G.6 Proof of Lemma 27

Lemma. Let $A \in \mathbb{R}^{k \times m}$ and $I_1, I_2, I_3, ..., I_t$ be t disjoint subsets of [k] such that $\bigcup_{j=1}^t I_j = [k]$. Then $||A|| \leq \sqrt{\sum_{j=1}^t ||A_{I_j}||^2}$.

Proof. Let $v \in \mathbb{R}^m$ be a unit vector. Then,

$$Av = \sum_{j=1}^{t} A_{I_j} v = \sum_{j=1}^{t} w_j.$$

Here $w_j = A_{I_j}v$. Since I_j 's are disjoint, w_j 's are orthogonal.

$$||Av|| = \sqrt{\sum_{j=1}^t ||w_j||^2} \leq \sqrt{\sum_{j=1}^t \max_{||v^*||=1} ||A_{I_j}v^*||^2} = \sqrt{\sum_{j=1}^t ||A_{I_j}||^2}.$$

Noting that the above bound holds for any unit vector $v \in \mathbb{R}^m$ completes the proof.
