# TWISTED AND SINGULAR GRAVITATING VORTICES 

CHENGJIAN YAO


#### Abstract

We introduce the notion of twisted gravitating vortex on a compact Riemann surface. If the genus of the Riemann surface is greater than 1 and the twisting forms have suitable signs, we prove an existence and uniqueness result for suitable range of the coupling constant generalizing the result of [3] in the non twisted setting. It is proved via solving a continuity path deforming the coupling constant from 0 for which the system decouples as twisted Kähler-Einstein metric and twisted vortices. Moreover, specializing to a family of twisting forms smoothing delta distribution terms, we prove the existence of singular gravitating vortices whose Kähler metric has conical singularities and Hermitian metric has parabolic singularities. In the Bogomol'nyi phase, we establish an existence result for singular EinsteinBogomol'nyi equations, which represents cosmic strings with singularities.


## 1. Introduction

The Abelian Higgs model coupled with gravity/or equivalently the Einstein-Maxwell-Higgs theory in four dimension is the simplest theory when matter interacts with spacetime according to Einstein's Field Equation and the matter field is described by a gauge theory on this spacetime simultaneously. Let $g$ be a Lorenztian metric with signature $(-,+,+,+)$ on a four-manifold $X$. The Einstein equation coupled with the Abelian Higgs model [23] are

where the energy-momentum tensor $T$ is given by

and $\mathcal{L}$ is the Abelian Higgs action density

In this model, the matter and energy encoded in the energy-momentum tensor are generated by an $U(1)$ connection together with a cross-section $\phi$ of this $U(1)$-bundle breaking the symmetry.
Following the work of [8, 23, the system is equivalent to the following Einstein-Bogomol'nyi equations (also known as self-dual Einstein-Maxwell-Higgs equations in the literature [6, 12, 13], the solutions are known as cosmic strings):

in the case when $X=\mathbb{R}^{1,1} \times \Sigma$ and $g$ is a product of the flat metric on $\mathbb{R}^{1,1}$ with a metric $g$ on a surface $\Sigma$ and $L, A, \phi$ are pulled back from the factor $\Sigma$. Viewing $g$ as a Kähler metric with respect to the complex structure determined by $g$, the second equation is translated as a holomorphicity condition on $\phi$ and the system fits into the following more general system, i.e. the gravitating vortex equations:

introduced in [2] which is a dimensional reduction of the Kähler-Yang-Mills equation defined in 1]. Here, the unknowns are the pair of Kähler metric $\omega$ on $\Sigma$ and Hermitian metric $h$ on the holomorphic line bundle $L$, where $L$ is equipped with a holomorphic section $\phi$.

The existence of smooth solution with $c=0$ on a compact surface was obtained by Yisong Yang [23] under an assumption of the multiplicities of the zeros of $\phi$, which was later interpreted as a classical GIT (geometric invariant theory) stability condition for the $P S L(2, \mathbb{C})$ action on $S^{N} \mathbb{P}^{1}$ and proved to be necessary including the case $c>0$. This stability condition was recently proved to be sufficient for the existence of smooth solution in the case $c>0$ in [11]. The case of negative $c$ on compact Riemann surfaces of genus $g \geq 1$ for a suitable range of the coupling constant was studied by [3]. The Euclidean Einstein-Maxwell equation with positive cosmological constant also exhibits interesting relations with Kähler geometry in real dimension four [19].

The aim of this article is to solve the following coupled system

about $(\omega, h)$ which simply introduces several delta distribution terms to the system (1.1). Here $\omega$ is a Kähler metric on the Riemann surface $\Sigma$ and $h$ is a Hermitian metric on the holomorphic line bundle $L$, and both metrics are allowed to have singularities possibly at $\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$. The coefficients in front of the distribution terms, i.e. the corresponding weight vectors, are assumed to satisfy $\boldsymbol{\beta}=$ $\left(\beta_{1}, \cdots, \beta_{M}\right) \in(0,1)^{M}$ and $\boldsymbol{\alpha}=\left(\alpha_{1}, \cdots, \alpha_{S}\right) \in\left(\mathbb{R}_{\geq 0}\right)^{S}$. The points $r_{1}, \cdots, r_{S}$ need not be different from $q_{1}, \cdots, q_{M}$. A solution to this system is called singular gravitating vortices (see Definition 2.2 for precise definition).
From the mathematical side, Biswas and Baptista in 4] proposed one motivation for the study of vortices with degenerated singularities generalizing the study of smooth vortices by Noguchi, Bradlow, and GarcíaPrada [5, 17, 16. We recall it here. Given a fixed background Kähler metric $\omega$ with conical and degenerated singularities on $\Sigma$, the existence of vortex solution to the first equation of (1.2) was studied in [4]. Hermitian metric with degeneracies is called parabolic structure there. If $h$ is a vortex solution on $(\Sigma, L, \omega, \phi)$ with parabolic singularities $r_{k}(k=1,2, \cdots, S)$ of order $\alpha_{k}=m_{k} \in \mathbb{N}_{+}$, i.e.

We could define a singular Hermitian metric $h_{k}$ on $L_{\left[r_{k}\right]}$ such that $\left|\boldsymbol{t}_{k}\right|_{h_{k}}^{2} \equiv 1$ (i.e. we take the Hermitian metric with curvature $F_{h_{k}}$ satisfies $i F_{h_{k}}=2 \pi\left[r_{k}\right]$ ). Then $h^{\prime}=h \otimes \prod_{k} h_{k}^{\otimes m_{k}}$ defines a (bounded) Hermitian metric on $L^{\prime}=L \otimes \prod_{k} L_{\left[r_{k}\right]}^{\otimes m_{k}}$, and $\phi^{\prime}=\phi \otimes \prod_{k} t_{k}^{\otimes m_{k}}$ is a holomorphic section of $L^{\prime}$ with $\left|\phi^{\prime}\right|_{h^{\prime}}^{2}=$ $|\boldsymbol{\phi}|_{h}^{2} \prod_{k}\left|\boldsymbol{t}_{k}\right|_{h_{k}}^{2 m_{k}}=|\boldsymbol{\phi}|_{h}^{2}$, and therefore

i.e. we get a solution $h^{\prime}$ to the vortex equation on $\left(\Sigma, L^{\prime}, \omega, \phi^{\prime}\right)$. Conversely, any smooth vortices give rise to a vortex solution with parabolic singularities when the Higgs field splits off some holomorphic factors. Now, suppose $\beta_{j}=\frac{1}{n_{j}}$, and $\alpha_{k}=m_{k}$ for positive integers $m_{1}, \cdots, m_{S}$ and $n_{1}, \cdots, n_{M}$, then Proposition 4.4 reveals an intimate link between singular gravitating vortices and smooth gravitating vortex through branched cover of Riemann surfaces.

The following is the outline of this article. In order to solve the existence of singular gravitating vortices, we introduce a natural smoothing of the system, where the distribution terms are replaced by a family of approximating $(1,1)$-forms (2.4) . These are called twisted vortices and twisted gravitating vortex (see Definition 2.3 and 3.1). The existence and uniqueness (Theorem 2.7) of twisted vortices is established in section 2, generalizing the existence and uniqueness of vortices [5, 17, 16. Inspired by the continuity method used in [3, 11], we study a continuity path deforming the coupling constant $\alpha$ while fixing the twisting forms in section 3. The openness is established when $g(\Sigma) \geq 2$ and the twisting forms have suitable signs; the closedness is proved by generalizing the a priori estimates in [3] and therefore the existence of twisted gravitating vortex is established in this setting. The uniqueness of twisted gravitating vortex follows from the uniqueness of twisted vortices established in Theorem [2.7 and the known uniqueness of
twisted Kähler-Einstein metric, for instance cf. [24]. In the final section, we show uniform $C^{\gamma}$ estimates on the Riemann surfaces and uniform higher order estimates away from the singularities for this family of continuity paths (2.4) . By taking subsequential limit (in the same spirit as [24, 25]) when the smoothing parameter $\varepsilon \rightarrow 0$, we obtain existence of singular gravitating vortices (Theorem 4.3).
In analogy to the smooth case, singular gravitating vortices with $\tilde{c}=0$ gives rise to solution of Abelian Higgs model coupled with gravity such that the four-dimensional spacetime metric has conical singularities along copies of $\mathbb{R}^{1,1}$ and the energy-momentum tensor represents delta distribution along those surfaces. Light rays could split when passing across those world-sheets, and generate double images from the observers' point of view. As a potential model of spacetime formed according to spontaneous symmetry breaking during the rapid cooling process after the big bang, cosmic string with conical singular spacetime attracts a lot interests [8, 12, 13, 20. This particularly interesting case is studied in the last section and we obtain existence of solutions to singular Einstein-Bogomol'nyi equations under assumption (A) (see Theorem5.2). The uniqueness of solutions and the interesting case of positive $\tilde{c}$ are left to future study.

## 2. Approximating Continuity Paths \& Twisted vortices

Definition 2.1 (Hermitian metric with parabolic singularities). Let $\Sigma$ be a Riemann surface and $\left\{r_{1}, \cdots, r_{S}\right\}$ be a set of points on $\Sigma$. Let $\boldsymbol{\alpha}=\left(\alpha_{1}, \cdots, \alpha_{S}\right)$ be a tuple of positive real numbers. The Hermitian metric $h$ on $L$ is said to have parabolic singularity of order $2 \alpha_{k}$ at $r_{k}$ if $h=|z|^{2 \alpha_{k}} e^{2 \varphi}$ for some Hölder continuous function $\varphi$ on $\Sigma$, and holomorphic coordinate $z$ centered at $r_{k}$.

Let $\omega$ be a Kähler metric on $\Sigma$ and $\left\{q_{1}, \cdots, a_{M}\right\}$ be a set of points on $\Sigma$. Let $\beta_{j} \in(0,1), j=1, \cdots, M$ be real numbers. The metric $\omega$ is said to have conical singularity with angle $2 \pi \beta_{j}$ at $q_{j}$ if locally near $q_{j}$ we have $\left|s_{j}\right|^{2-2 \beta_{j}} \omega=\digamma \omega_{0}$ with $\digamma$ being positive and Hölder continuous and $\omega_{0}$ smooth. There are extensive studies on constant curvature metric with conical singularities on Riemann surfaces in the past decades, cf. [15, 22, 14].

Denote $\boldsymbol{t}_{k}$ a defining section of the divisor $\left[r_{k}\right]$ for $k=1, \cdots, S$. Let $h_{0}$ be a smooth Hermitian metric on $L$, if the Hermitian metric $h$ on $L$ has parabolic singularity of order $2 \alpha_{k}$ at $r_{k}$ for $k=1,2, \cdots, S$, then $h=h_{0} \prod_{k}\left|\boldsymbol{t}_{k}\right|^{2 \alpha_{k}} e^{2 \tilde{f}}$ for some smooth Hermitian metric $h_{0}$ and Hölder continuous function $\tilde{f}$ globally defined on $\Sigma$, where $\left|\boldsymbol{t}_{k}\right|$ is the norm of the defining section for $L_{\left[r_{k}\right]}$ under some smooth Hermitian metric. Denote $f=\tilde{f}+\frac{1}{2} \sum_{k} \alpha_{k} \log \left|\boldsymbol{t}_{k}\right|^{2}$. In this way, the potential $f$ has logarithmic pole at $r_{k}$ while the reduced potential $\tilde{f}$ does not. For any holomorphic section $\phi$ of $L,|\boldsymbol{\phi}|_{h}^{2}=|\boldsymbol{\phi}|^{2} e^{2 f}=|\boldsymbol{\phi}|^{2} \prod_{k}\left|\boldsymbol{t}_{k}\right|^{2 \alpha_{k}} e^{2 \tilde{f}}$. The number

is called the parabolic degree in the literature 4].
Fix $\omega_{0}$ a constant curvature metric on $\Sigma$ and assume the unknown Kähler metric $\omega=\omega_{0}+2 i \partial \bar{\partial} u \in\left[\omega_{0}\right]$. Let $\tilde{\chi}(\Sigma)=\chi(\Sigma)-\sum_{j}\left(1-\beta_{j}\right)$ and

Let $h_{0}$ be a constant curvature metric on $L$ and $h_{k}$ to be a constant curvature metric on $L_{\left[r_{k}\right]}$, i.e.

Let $\boldsymbol{s}_{j}$ be a defining section of the divisor $\left[q_{j}\right]$ and fix a Hermitian metric on this line bundle with constant curvature, denote $\left|s_{j}\right|$ the norm under this metric. Using $\Delta$ to represent the Laplacian operator of the metric $\omega_{0}$. The Poincaré-Lelong formula $i \partial \bar{\partial} \log \left|\boldsymbol{t}_{k}\right|^{2}=-\frac{2 \pi}{\operatorname{Vol}_{\omega_{0}}} \omega_{0}+2 \pi\left[r_{k}\right], i \partial \bar{\partial} \log \left|s_{j}\right|^{2}=-\frac{2 \pi}{\text { Vol }_{\omega_{0}}} \omega_{0}+2 \pi\left[q_{j}\right]$
together with Ric $\omega=\operatorname{Ric} \omega_{0}-i \partial \bar{\partial} \log (1-\Delta u)$ transforms the singular gravitating vortices equation (1.2) about $(\omega, h)$ into the a PDE system for $u$ and $\tilde{f}$ :

where $\lambda>0$ is a real constant. Notice that in case $\tilde{c} \neq 0$, the constant $\lambda$ could be absorbed into the term $e^{-2 \tilde{c} u}$, therefore there is no loss in assuming $\lambda=1$; while in the case $\tilde{c}=0$, varying $\lambda$ gives rise to different solutions. These two cases will be treated differently in the following materials.
Definition 2.2 (singular gravitating vortices). Let $\omega$ be a Kähler metric with conical singularities of angle $2 \pi \beta_{j}$ at $q_{j}$ and $h$ be a Hermitian metric with parabolic singularity of order $2 \alpha_{k}$ at $r_{k}$. If $(\omega, h)$ satisfies Equation (1.2) or equivalent (2.3), it is called singular gravitating vortices.
2.1. Smoothing of the current equations. Let $L_{\left[q_{j}\right]}, L_{\left[r_{k}\right]}$ and $\boldsymbol{s}_{j}, \boldsymbol{t}_{k}$ be with the same meaning as before. In order to solve (1.2) we consider a family of approximating equations. Let $\varepsilon>0$, write

then $\chi_{j}^{\varepsilon}$ is a smoothing of the integration current $2 \pi\left[q_{j}\right]$, and $\chi_{k}^{\prime \varepsilon}$ is a smoothing of $2 \pi\left[r_{k}\right]$. Moreover, $\chi_{j}^{\varepsilon}$ and $\chi_{k}^{\prime \varepsilon}$ are positive (1, 1)-forms [7, 24, 25]. We are going to firstly solve a pair of smooth metrics $\left(\omega_{\varepsilon, \alpha}, h_{\varepsilon, \alpha}\right)$ satisfying

Here $\omega_{\varepsilon, \alpha}=\omega_{0}+2 i \partial \bar{\partial} u_{\varepsilon, \alpha}$ and $h_{\varepsilon, \alpha}=h_{0} e^{2 f_{\varepsilon, \alpha}}=: h_{0} \prod_{k}\left(\left|\boldsymbol{t}_{k}\right|^{2}+\varepsilon\right)^{\alpha_{k}} e^{2 \tilde{f}_{\varepsilon, \alpha}}$. We denote this system by (2.4) $\varepsilon, \alpha$ to emphasize the dependence on the coupling constant $\alpha$ and the smoothing parameter $\varepsilon$. As above, writing $\Phi_{\varepsilon, \alpha}=|\phi|_{h_{\varepsilon, \alpha}}^{2}$, then the system is transformed to the equivalent system about the potential functions $\left(u_{\varepsilon, \alpha}, \tilde{f}_{\varepsilon, \alpha}\right)$ :

This system of semilinear elliptic PDEs, denoted by (2.5) $)_{\varepsilon, \alpha}^{s m}$, will be crucially used in the a priori estimates and regularity study. From now on, we assume $\operatorname{Vol}_{\omega_{0}}=2 \pi$ for notation simplicity. However, we should notice that the system (1.2) does not enjoy a scaling symmetry on $\omega$ when $\alpha, \tau$ are fixed, i.e. solutions inside the Kähler class $\left[\omega_{0}\right]$ does not scale to a solution inside the Kähler class $2\left[\omega_{0}\right.$ ] for istance.
2.2. Twisted vortices. When the coupling constant $\alpha=0$, the system (2.4) $\varepsilon_{\varepsilon, \alpha}$ decouples into

The second equation with $\sum_{j}\left(1-\beta_{j}\right) \chi_{j}^{\varepsilon}$ replaced by a general closed $(1,1)$-form is called twisted KählerEinstein equation whose solution is called a twisted Kähler-Einstein metric. This was studied by Aubin and Yau in their classical continuity path to solve Kähler-Einstein problem, and this also appears in various other geometric situations, [7, 21]. The specialization to this particular kind of "twisting forms" smoothing an integration current was used in the study of the existence and regularity of conical Kähler-Einstein metrics, for instance see [10, 14, 24].

Given $\omega_{0}$ being the constant curvature metric on $\Sigma$, i.e. Ric $\omega_{0}=\frac{2 \pi}{V_{0} \omega_{0}} \chi \omega_{0}$ with $\chi=\chi(\Sigma)=2-2 g(\Sigma)$. For any other constant $\tilde{\chi}$, the way of obtaining twisted Kähler-Einstein metric with twisting form $\xi=$ $\frac{2 \pi}{\operatorname{Vol}_{\omega_{0}}}(\chi-\tilde{\chi}) \omega_{0}+i \partial \bar{\partial} F \in(\chi-\tilde{\chi})\left[\omega_{0}\right]$, i.e. solution of

is via solving the continuity path

which is equivalent to the PDE:

It is proved by Aubin and Yau that for any $\tilde{\chi} \leq 0$ and $\xi$ of the above, the equation admits a unique solution. Let us denote the twisted Kähler-Einstein metric by $\omega_{\varepsilon, 0}$ when $\xi=\sum_{j}\left(1-\beta_{j}\right) \chi_{j}^{\varepsilon}$.
The first equation of the system (2.5) $)_{\varepsilon, \alpha}^{s m}$ (when fixing the underlying Kähler metric $\omega_{\varepsilon, 0}$ ) is a vortex type equation, with a smooth twisting term. In general, given a Riemann surface $\Sigma$ equipped with a Kähler metric $\omega$, letting $\eta$ be any smooth (1,1)-form on $\Sigma$ with $\int_{\Sigma} \eta=2 \pi b$. Since any ( 1,1 )-form on a Riemann surface is necessarily closed, we could write $\eta=\frac{2 \pi}{\operatorname{Vol}_{\omega}} b \omega+i \partial \bar{\partial} F$ for some smooth function $F$, then we can consider the equation:

Definition 2.3 (twisted vortices). If $h$ satisfies the Equation (2.10), then it is called a twisted vortices with twist form $\eta$.

The following is a necessary condition (obtained by integrating the equation over $\Sigma$ ) for the existence of twisted vortices with twist form $\eta$ :

studied by Noguchi, Bradlow and García-Prada, whose existence and uniqueness was established exactly under the numerical assumption (2.11). Let us denote the unique solution by $h_{0}$, i.e.

Therefore $\left.\delta \mathcal{V}\right|_{\left(f_{t}, t\right)}$ is an invertible bounded linear operator from $C^{2, \alpha}(\Sigma)$ to $C^{\alpha}(\Sigma)$, and the openness follows from standard implicit function theorem in Banach spaces.
To get closedness, we need some a priori estimates. The first one is the upper bound of the Hermitian metrics $h_{t}$ which can be achieved by maximum principle, applied to $\Phi_{t}=|\phi|_{h_{t}}^{2}$ satisfying the equation

The standard $W^{2, p}$ estimate applied to Equation (2.14) implies $\left\|f_{t}\right\|_{W^{2, p}(\Sigma)}$ is uniformly bounded and Sobolev's embedding then implies $\left\|f_{t}\right\|_{C^{1, \alpha}(\Sigma)}$ is uniformly bounded. A bootstrapping argument to (2.14) thus implies
Proposition 2.6. For any integer $k \geq 0$, there exists constant $C_{k}>0$ independent of $t \in[0,1]$ such that

In conclusion, we establish a generalization of the theorem of Noguchi, Bradlow and García-Prada [16, [5, ,18, to the case of twisted vortices equation.
Theorem 2.7 (Existence and Uniqueness of twisted vortices). Let $\eta$ be a smooth ( 1,1 )-form on the compact Riemann surface $\Sigma$ with $\frac{1}{2 \pi} \int_{\Sigma} \eta=b$, and $\phi$ be a holomorphic section of the holomorphic line bundle $L$ with $c_{1}(L)=N$. Then, the twisted vortices equation (2.10) admits a solution iff the numerical assumption $\tau \cdot \frac{V_{0} l_{\omega}}{2 \pi}>2(N-b)$ is satisfied. Moreover, in this case, the solution is unique.

Proof. Let $h$ and $h^{\prime}=h e^{2 f}$ be two solutions to (2.10). Then by subtracting the two equations, we get

The maximum principle does not directly apply since the maximum of $f$ might appear at the vanishing point of $\phi$. However, we could still prove $f \equiv 0$ by using an easy perturbation argument.

We set up the map:

Since $\left.\delta \mathcal{P}\right|_{(f, 0)}(\dot{f})=\Delta \dot{f}+|\phi|_{h}^{2} e^{2 f} \dot{f}$ is an invertible operator from $C^{2, \alpha}$ to $C^{\alpha}$, implicit function theorem tells us that for $\delta \in\left(0, \delta_{0}\right)$, there exists a unique $f_{\delta}$ such that $\mathcal{P}\left(f_{\delta}, \delta\right)=0$ and $\left\|f_{\delta}-f\right\|_{C^{2, \alpha}} \rightarrow 0$ as $\delta \rightarrow 0$. Applying maximum principle to

Remark 2.8. This theorem does not put restriction on the genus of the Riemann surface.
Going back to Equation (2.6), if the parameters satisfies the numerical assumption

we obtain a solution $h_{\varepsilon, 0}$. The data ( $\omega_{\varepsilon, 0}, h_{\varepsilon, 0}$ ) will serve as the starting point for the main continuity path (2.4) $\varepsilon, \alpha$, deforming the coupling constant $\alpha$.

## 3. Twisted gravitating vortex

In this section, we study system when the RHS twisting forms are replaced by general closed (1,1)-forms $\eta$ and $\xi$. Concretely speaking, we consider the coupled equations:

for real 2-forms $\eta=\sqrt{-1} \eta_{k \bar{l}} \mathrm{~d} z^{k} \wedge \mathrm{~d} \bar{z}^{l}=\sqrt{-1} \eta_{1 \overline{1}} \mathrm{~d} z \wedge \mathrm{~d} \bar{z}$, and $\xi=\sqrt{-1} \xi_{k \bar{l}} \mathrm{~d} z^{k} \wedge \mathrm{~d} \bar{z}^{l}=\sqrt{-1} \xi_{1 \overline{1}} \mathrm{~d} z \wedge \mathrm{~d} \bar{z}$.
Definition 3.1 (twisted gravitating vortex). A pair $(\omega, h)$ satisfying the system (3.1) ${ }_{\alpha}$ is called twisted gravitating vortex with twisting forms $\eta$ and $\xi$.

Without loss of generality, we only focus on the Kähler class of volume $2 \pi$, the other Kähler class parallels the arguments in this section. Still denote $\omega_{0}$ to be the constant curvature metric in this fixed Kähler class and $h_{0}$ to be the Hermitian metric of constant curvature on $L$. If $\eta \in b_{\eta}\left[\omega_{0}\right]$ and $\xi \in b_{\xi}\left[\omega_{0}\right]$ for real constant $b_{\eta}$ and $b_{\xi}$, then we could write

Write $\omega=\omega_{0}+2 i \partial \bar{\partial} u$ and $h=h_{0} e^{2 f}=h_{0} e^{-F_{\eta}} e^{2 \tilde{f}}$. The twisted gravitating vortex equations is equivalent to the semilinear elliptic PDE system:

where $\Phi=|\phi|_{h}^{2}=|\phi|^{2} e^{-F_{\eta}} e^{2 \tilde{f}}$. From now on, we assume $\eta \leq 0$ and $\xi \geq 0$, i.e. $\eta_{1 \overline{1}} \leq 0, \xi_{1 \overline{1}} \geq 0$. Write $\tilde{\chi}=\chi-b_{\xi}, \tilde{N}=N-b_{\eta}$ and $\tilde{c}=\tilde{\chi}-2 \alpha \tau \tilde{N}$. We also assume $g(\Sigma) \geq 2$. It will be clear the role played by these assumptions in the openness and closedness argument.
3.1. Openness. We are taking a more direct way here rather than the momentum map interpretation of [3] studying the non twisted gravitating vortex equation. For this part, we use the system (3.1) instead of the PDE system (3.2).
Fixing $k \geq 2$ be an integer. Let $L_{p}^{2}(\Sigma)$ be the space of functions on $\Sigma$ whose distributional derivatives up to order $p$ are square integrable. Denote $\widehat{\mathcal{U}} \subset L_{k+4}^{2}(\Sigma) / \mathbb{R}$ to be the open neighborhood of 0 consisting of $v$ such that $\omega=\omega_{0}+2 i \partial \bar{\partial} v$ is a Kähler metric. Define a nonlinear differential operator

& \wp_{2}(\alpha, f, v)=-S_{\omega}-\alpha \Delta_{\omega}|\phi|_{h}^{2}+2 \alpha \tau \Lambda_{\omega}\left(i F_{h}-\eta\right)+\tilde{c}+\Lambda_{\omega} \xi
\end{aligned}

for $\omega=\omega_{0}+2 i \partial \bar{\partial} v$ and $h=h_{0} e^{2 f}$. It is easily seen that $\wp$ is well-defined since $L_{k+4}^{2}(\Sigma) \subset C^{0}(\Sigma)$ by Sobolev embedding on $\Sigma$. This operator is order 2 in $f$ and order 4 in $v$.

Proof. Direct calculation (for the clarity and consistency of notations we adopt the familiar conventions in Kähler geometry) shows that

The formula in the proposition follows from the definition of $\wp_{1}, \wp_{2}$ then. Looking at the coefficients of the linear differential operators $\delta \wp_{1}, \delta \wp_{2}$ and their dependence on $(\alpha, f, v)$, it is clear they are continuous with respect to the variables $(\alpha, f, v)$ in $\operatorname{Hom}\left(L_{k+4}^{2} \times L_{k+4}^{2} / \mathbb{R}, L_{k+2}^{2} \times L_{k}^{2}\right)$ under the operator norm. The directional derivative of $\wp$ in the direction of $\alpha \in \mathbb{R}$ is even more clearly to be continuous with respect to $(\alpha, f, v)$. We conclude that $\wp$ is $C^{1}$ and its Fréchet derivative is as claimed.
Suppose now $\wp(\hat{\alpha}, \hat{f}, \hat{v})=0$. Write $\hat{\omega}=\omega_{0}+2 i \partial \bar{\partial} \hat{v}, \hat{h}=h_{0} e^{2 \hat{f}}$, the two directional derivatives are simplified as

Assuming $\xi$ and $-\eta$ are both nonnegative (1,1)-forms, then $\left.D \wp\right|_{(\hat{\alpha}, \hat{f}, \hat{v})}(\dot{f}, \dot{v})=(0,0)$ implies $\nabla^{1,0} \dot{v}$ is a holomorphic vector field on $\Sigma$ and thus $\dot{v}=$ const by the assumption $g(\Sigma) \geq 2$. In the case $\hat{\alpha}>0$, the vanishing of the second term of the right hand side of Equation (3.12) implies $\left.J \eta_{\dot{v}}\right\lrcorner \mathrm{d}_{A} \phi-\dot{f} \phi=0$ which then forces $\dot{f} \equiv 0$. In the case $\hat{\alpha}=0$, the second equation of (3.5) shows $\Delta_{\hat{\omega}} \dot{v} \equiv 0$, and the first equation reduces to the case of twisted vortices, it follows from equation (2.17) that $\dot{f} \equiv 0$.

Remark 3.3. More generally, at a general pair $(f, v)$, by replacing the left hand side of Equation (3.6) with

The map $\Upsilon=\left(\Upsilon_{1}, \Upsilon_{2}\right): L_{k+4}^{2} \times L_{k+4}^{2} \longrightarrow L_{k+2}^{2} \times L_{k+2}^{2}$ is a linear elliptic differential operator of order 2, with $\operatorname{ker} \Upsilon=\{(0,0)\}$ according to Proposition 3.2 By varying $\alpha \in[0, \hat{\alpha}]$, we can view $\Upsilon$ as a continuous family of Fredholm operators. At $\alpha=0$, the operator $\Upsilon$ is both injective and surjective (since $\Upsilon_{1}$ and $\Upsilon_{2}$ decouples thus could be solved independently because our assumption is $\tilde{c}<0$ ) and thus has index 0 . By
the homotopy invariance of index, we conclude that Equation (3.14) is uniquely solvable. The solution $(\dot{f}, \dot{v})$ satisfies the elliptic estimate

Suppose the twisted gravitating vortex equations (3.1) admits a solution $(\hat{\omega}, \hat{h})=\left(\omega_{0}+2 i \partial \bar{\partial} \hat{v}, h_{0} e^{2 \hat{f}}\right)$ with $\hat{\alpha} \geq 0$, then there exists $\varepsilon>0$ such that for all $\alpha \in(\hat{\alpha}-\varepsilon, \hat{\alpha}+\varepsilon)$, there exists a unique pair $\left(f_{\alpha}, v_{\alpha}\right) \in L_{k+4}^{2}(\Sigma) \times \widehat{\mathcal{U}}$ such that $\left(\omega_{\alpha}, h_{\alpha}\right)=\left(\omega_{0}+2 i \partial \bar{\partial} v_{\alpha}, h_{0} e^{2 f_{\alpha}}\right)$ satisfies the Equation (3.1), $\left(f_{\alpha}, v_{\alpha}\right)$ is $C^{1}$ in $\alpha$ with $\left(f_{\hat{\alpha}}, h_{\hat{\alpha}}\right)=(\hat{f}, \hat{v})$.

is $C^{1}$ with the same Fréchet derivative (with respect to $(f, v)$ ) at ( $\hat{\alpha}, \hat{f}, \hat{v}$ ) as $\wp$ since $\int_{\Sigma} \delta \wp_{2} \hat{\omega}=0$. By Proposition 3.2 and 3.4, $\left.D \tilde{\wp}\right|_{(\hat{\alpha}, \hat{f}, \hat{v})}$ is an isomorphism between the Sobolev spaces $L_{k+4}^{2}(\Sigma) \times \dot{L}_{k+4}^{2}(\Sigma, \hat{\omega})$ and $L_{k+2}^{2}(\Sigma) \times \stackrel{\circ}{k}_{k}^{2}(\Sigma, \hat{\omega})$. Then, the implicit function theorem in Banach spaces [9, Appendix] shows that there exists $\varepsilon>0$ and a $C^{1}$ path $\left\{\left(f_{\alpha}, v_{\alpha}\right) \in L_{k+4}^{2}(\Sigma) \times \grave{L}_{k+4}^{2}(\Sigma, \hat{\omega}) \mid \alpha \in(\hat{\alpha}-\varepsilon, \hat{\alpha}+\varepsilon)\right\}$ such that $\tilde{\wp}\left(\alpha, f_{\alpha}, v_{\alpha}\right)=(0,0)$. This further implies $\wp_{1}\left(\alpha, f_{\alpha}, v_{\alpha}\right)=0$ and $\wp_{2}\left(\alpha, f_{\alpha}, v_{\alpha}\right)=$ const. It follows then $\wp_{2}\left(\alpha, f_{\alpha}, v_{\alpha}\right)=0$ with $\tilde{c}=\tilde{c}(\alpha)=2-2 g(\Sigma)-2 \alpha \tau c_{1}(L) \cdot[\Sigma]-\frac{1}{2 \pi}([\xi]-2 \alpha \tau[\eta]) \cdot[\Sigma]$.

### 3.2. A priori estimates and Closedness.

To derive useful a priori estimates, we mainly use the PDE system (3.2) in this section. Let $\Phi=|\phi|_{h}^{2}$ as above, then there is a $C^{0}$ bound on $\Phi$ as in [11, Lemma 4.1].

## Proposition 3.7.

Let $\Sigma$ be any compact Riemann surface with $g(\Sigma) \geq 2, \omega_{0}$ is a constant curvature Kähler metric on $\Sigma$. Let $L$ be a holomorphic line bundle equipped with a nonzero holomorphic section $\phi$, and $-\eta, \xi$ be real nonnegative closed ( 1,1 )-form with $\int_{\Sigma} \eta=\frac{2 \pi}{V_{0} l_{\omega_{0}}} b_{\eta}$ and $\int_{\Sigma} \xi=\frac{2 \pi}{V_{o l} \omega_{\omega_{0}}} b_{\xi}$. Suppose $\tau \cdot \frac{V_{o l} \omega_{\omega_{0}}}{2 \pi}>2 \tilde{N}$, and denote $\alpha_{*}=\frac{-\tilde{\chi}}{\tau(\tau-2 \tilde{N})}$. Then, for any coupling constant $\alpha \in\left[0, \alpha_{*}\right]$ there exists a unique solution $(\omega, h)$ to the twisted gravitating vortex equations (3.1) with $\omega \in\left[\omega_{0}\right]$.

Proof. Now $\xi, \eta$ are fixed and only $\alpha$ varies in $\left[0, \alpha_{*}\right]$. The standard Schauder estimate implies the $C^{2, \gamma}$ norm of $u$ and $\tilde{f}$ are bounded by $C_{9}$ independent of $\alpha \in\left[0, \alpha_{*}\right]$. Then, the bootstrapping argument shows that all higher order norm of $u$ and $\tilde{f}$ are uniformly bounded (independent of $\left.\alpha \in\left[0, \alpha_{*}\right]\right)$. We thus get the closedness and then the existence of solution to Equation (2.4).

The uniqueness follows by connecting any twisted gravitating vortex with coupling constant $\alpha$ to the case when the coupling constant $\alpha=0$ via the continuity path studied, i.e. the system decouples as a twisted Kähler-Einstein metric and twisted vortices both proved to be unique.

## 4. Singular gravitating vortices

We are ready to establish the existence of singular gravitating vortices introduced in section 2 using the previously proved a priori estimates.
4.1. Existence. In this section, we specialize to a family of continuity paths $(\overline{2.4})_{\varepsilon, \alpha}$ with $\eta_{\varepsilon}=-\sum_{k} \alpha_{k} \chi_{\varepsilon}^{\prime k}$ and $\chi_{\varepsilon}=\sum_{j}\left(1-\beta_{j}\right) \chi_{\varepsilon}^{j}$ for $\varepsilon \in(0,1]$. For each $\varepsilon \in(0,1]$, the path could be solved for $\alpha \in\left[0, \alpha_{*}\right]$ by Theorem 3.10, whose solution is denoted by $\left(\omega_{\varepsilon, \alpha}, h_{\varepsilon, \alpha}\right)$. As $\varepsilon \rightarrow 0$, since the twisting forms $\eta_{\varepsilon} \rightarrow-2 \pi \sum_{k} \alpha_{k}\left[r_{k}\right]$ and $\chi_{\varepsilon} \rightarrow 2 \pi \sum_{j}\left(1-\beta_{j}\right)\left[q_{j}\right]$, we expect the twisted gravitating vortex ( $\omega_{\varepsilon, \alpha}, h_{\varepsilon, \alpha}$ ) converges to "solution" of Equation (1.2) ${ }_{\alpha}$.
Since $F_{\eta_{\varepsilon}}=-\sum_{k} \alpha_{k} \log \left(\left|\boldsymbol{t}_{k}\right|^{2}+\varepsilon\right), F_{\xi_{\varepsilon}}=\sum_{j}\left(1-\beta_{j}\right) \log \left(\left|\boldsymbol{s}_{j}\right|^{2}+\varepsilon\right)$, it is clearly there exists $p>1$ depending only on $\beta_{j}$ 's $\left(p\right.$ can be taken as $\frac{1}{2}\left(1+\min \left\{\frac{1}{1-\beta_{1}}, \cdots, \frac{1}{1-\beta_{M}}\right\}\right)$ and $C>0$ independent of $\varepsilon \in(0,1]$ such that

We notice that $\Phi_{\varepsilon, \alpha}=|\boldsymbol{\phi}|^{2} \prod_{k}\left(\left|\boldsymbol{t}_{k}\right|^{2}+\varepsilon\right)^{\alpha_{k}} e^{2 \tilde{f}_{\varepsilon, \alpha}}$ has a uniform $C^{\gamma}$ bound on $\Sigma$ (possibly by redefining $\gamma$ to be $\left.\min \left\{\gamma, 2 \alpha_{1}, \cdots, 2 \alpha_{S}\right\}\right)$. For any $K \subset \subset \Sigma \backslash\left\{q_{1}, \cdots, q_{M}\right\}$, the term $\frac{e^{4 \alpha \tau \tilde{f} \varepsilon, \alpha-2 \alpha \Phi_{\varepsilon, \alpha}-2 \tilde{c_{u}} u_{\varepsilon, \alpha}}}{\prod_{j}\left(\left|s_{j}\right|^{2}+\varepsilon\right)^{1-\beta_{j}}}$ has a uniform $C^{\gamma}$ bound depending only on $K$ (independent of $\varepsilon$ and $\alpha \in\left[0, \alpha_{*}\right]$ ), and then the proposition follows from the standard Schauder's estimates. Precisely speaking, the second equation of the system (2.5) implies $u_{\varepsilon, \alpha}$ has uniform $C^{2, \gamma}$ bound on $K$. Back to the first equation, we conclude $\tilde{f}_{\varepsilon, \alpha}$ has uniform $C^{2, \gamma}$ bound on $K$.

For higher order estimates, we have
Proposition 4.2. For any $K \subset \subset \Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$ and integer $s \geq 3$, there exists $C_{K, s}>0$ independent of $\varepsilon \in(0,1]$ and $\alpha \in\left[0, \alpha_{*}\right]$ such that

This fact together with the above proposition yield the proposition by a standard bootstrapping argument of Schauder's estimate.

Fixing any $\alpha \in\left(0, \alpha_{*}\right]$, we take a sequence $K_{m} \subset \subset \Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$ with $K_{m} \subset K_{m+1}$ and $\cup_{m=1}^{+\infty} K_{m}=\Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$. Applying Arzela-Ascoli's theorem successively on $K_{m}$, we get a subsequence $\varepsilon_{m} \rightarrow 0$ such that $\left(\omega_{\varepsilon_{m}, \alpha}, h_{\varepsilon_{m}, \alpha}\right)$ converges to a limit ( $\omega_{0, \alpha}, h_{0, \alpha}$ ) solving Equation (1.2) on $\Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$, with the potential functions $\tilde{f}_{0, \alpha}, u_{0, \alpha} \in C^{\gamma}(\Sigma) \cap C^{\infty}\left(\Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}\right)$. The pair satisfies

Therefore, $h_{0, \alpha}=h_{0} \prod_{k}\left|\boldsymbol{t}_{k}\right|^{2 \alpha_{k}} e^{2 \tilde{f}_{0, \alpha}}$ is a Hölder continuous Hermitian metric on $L$ with parabolic singularity of order $2 \alpha_{k}$ at $r_{k}$ for $k=1,2, \cdots, S$; and $\omega_{0, \alpha}=\left(1-\Delta u_{0, \alpha}\right) \omega_{0}=\prod_{j}\left|s_{j}\right|^{2\left(\beta_{j}-1\right)} \digamma \omega_{0}$ is a Hölder continuous Kähler metric with conical singularity of angle $2 \pi \beta_{j}$ at $q_{j}$ for $j=1,2, \cdots, M$. Moreover, $\omega_{0, \alpha}$ and $h_{0, \alpha}$ are smooth on $\Sigma \backslash\left\{q_{1}, \cdots, q_{M} ; r_{1}, \cdots, r_{S}\right\}$.
In conclusion, regarding the solvability of (1.2), we finally reach the following existence theorem.
Theorem 4.3 (Existence of singular gravitating vortices). Let $\Sigma$ be any compact Riemann surface with $g(\Sigma) \geq 2, \omega_{0}$ is a constant curvature Kähler metric on $\Sigma$. Let $L$ be a holomorphic line bundle equipped with a nonzero holomorphic section $\phi$. Let $\beta_{j} \in(0,1)$ for $j=1, \cdots, M$ and $\alpha_{k}>0$ for $k=1, \cdots, S$ such that $\tilde{\chi}=\chi(\Sigma)-\sum_{j}\left(1-\beta_{j}\right)<0$, and $\tau \cdot \frac{V o l_{\omega_{0}}}{2 \pi}>2 \tilde{N}=2\left(N+\sum_{k} \alpha_{k}\right)$ and denote $\alpha_{*}=\frac{-\tilde{\chi}}{\tau(\tau-2 \tilde{N})}$. For any coupling constant $\alpha \in\left[0, \alpha_{*}\right]$, there exists a solution $(\omega, h)$ to Equation (1.2) with $\omega \in\left[\omega_{0}\right]$. Moreover, $\omega$ has conical singularity with angle $2 \pi \beta_{j}$ at $q_{j}$ for $j=1,2, \cdots, M$ and $h$ is a Hermitian metric having parabolic singularities of order $2 \alpha_{k}$ at $r_{k}$ for $k=1,2, \cdots, S$.
4.2. Regularity. Continuing the notations introduced in the introduction, the following proposition shows how to build smooth gravitating vortices from singular gravitating vortices when the orders $\boldsymbol{\alpha}=$ $\left(\alpha_{1}, \cdots, \alpha_{S}\right)$ and $\boldsymbol{\beta}=\left(\beta_{1}, \beta_{2}, \cdots, \beta_{M}\right)$ take some special values.

Proposition 4.4. Let $\pi: \Sigma^{\prime} \rightarrow \Sigma$ be a branched cover with degree $n_{j}$ around $q_{j}$, let $(\omega, h)$ be a singular gravitating vortices on $(\Sigma, L)$ with conical singularity with angle $2 \pi \frac{1}{n_{j}}$ at $q_{j}(j=1,2, \cdots, M)$ for $\omega$ and parabolic singularity of order $2 m_{k}$ at $r_{k}(k=1,2, \cdots, S)$ for $h$, with the Higgs field $\phi$. Then $\left(\pi^{*} \omega, \pi^{*}\left(h \otimes \prod_{k} h_{k}^{m_{k}}\right)\right)$ is a smooth gravitating vortex solution on $\left(\Sigma^{\prime}, \pi^{*}\left(L \otimes \prod_{k} L_{\left[r_{k}\right]}^{\otimes m_{k}}\right)\right)$, with the Higgs field $\pi^{*}\left(\boldsymbol{\phi} \otimes \prod_{k} \boldsymbol{t}_{k}^{m_{k}}\right)$.

Proof. Obviously, for each $q_{j}$ where $\omega \sim \sqrt{-1}|z|^{2 \beta_{j}-2} \mathrm{~d} z \wedge \mathrm{~d} \bar{z}$ and the branch map $\pi$ is modeled on the map $\pi(w)=w^{n_{j}}$, we have $\pi^{*} \omega \sim \sqrt{-1} \mathrm{~d} w \wedge \mathrm{~d} \bar{w}$. Thus, $\omega^{\prime}=\pi^{*} \omega$ is a Hölder continuous Kähler metric on $\Sigma^{\prime}$ which is bounded above and below by a background smooth Kähler metric $\tilde{\omega}_{0}$. The Hermitian metric $h^{\prime}$ upstairs is a Hölder continuous non-degenerated Hermitian metric on $L^{\prime}$. Moreover, ( $\omega^{\prime}, h^{\prime}$ ) satisfy the equation

\left\{\begin{align*}
i F_{h^{\prime}}+\frac{1}{2}\left(\left|\phi^{\prime}\right|_{h^{\prime}}^{2}-\tau\right) \omega^{\prime} & =0  \tag{4.4}\\
\text { Ric } \omega^{\prime}-2 \alpha i \partial \bar{\partial}\left|\phi^{\prime}\right|_{h^{\prime}}^{2}+\alpha \tau\left(\left|\phi^{\prime}\right|_{h^{\prime}}^{2}-\tau\right) \omega^{\prime} & =\tilde{c} \omega^{\prime}
\end{align*}\right.
$$

on $\Sigma^{\prime}$. If we write $\omega^{\prime}=\omega_{0}^{\prime}+2 i \partial \bar{\partial} u^{\prime}$ and $h^{\prime}=h_{0}^{\prime} e^{2 f^{\prime}}$ with $\omega_{0}^{\prime}$ and $h_{0}^{\prime}$ the background smooth constant curvature metrics, then $\left(u^{\prime}, f^{\prime}\right)$ satisfy the PDE system:

\begin{align*}
\Delta_{\omega_{0}^{\prime}} f^{\prime}+\frac{1}{2}\left(\left|\phi^{\prime}\right|_{h^{\prime}}^{2}-\tau\right)\left(1-\Delta_{\omega_{0}^{\prime}} u^{\prime}\right) & =-\tilde{N}  \tag{4.5}\\
\Delta_{\omega_{0}^{\prime}} u^{\prime}+e^{4 \alpha \tau f^{\prime}-2 \alpha\left|\phi^{\prime}\right|_{h^{\prime}}^{2}-2 \tilde{c} u^{\prime}} & =1
\end{align*}
$$

on $\Sigma^{\prime} \backslash \pi^{-1}\left(\left\{q_{1}, \cdots, q_{M}, r_{1}, \cdots, r_{S}\right\}\right)$. Standard elliptic regularity and bootstrapping arguments show that $u^{\prime}$ and $f^{\prime}$ are actually smooth on $\Sigma^{\prime}$.

## 5. Singular Einstein-Bogomol'nyi equations

The case $\tilde{c}=0$, equivalently when the symmetry breaking parameter $\tau=\frac{\tilde{\chi}}{2 \alpha \tilde{N}}$, which is called Bogomol'nyi phase, has particular interests in physics since it leads to non-vacuum spacetime satisfying Einstein Field Equation with singularity and with pure magnetic field. We call this system singular Einstein-Bogomol'nyi equations. This case is treated separately since the continuity method deforming coupling constant $\alpha$ does not work, the openness fails due to the nontrivial kernal of $D \wp$ at $\hat{\alpha}=0$ and the $C^{0}$ estimate is not clear along the path.

The two equations in (1.2) can be combied into one elliptic PDE with a peculiar-looking nonlinear term:

\begin{equation*}
\Delta \tilde{f}+\frac{1}{2} \lambda\left(e^{2 \tilde{f}+\log |\phi|^{2}+\sum_{k} \alpha_{k} \log \left|\boldsymbol{t}_{k}\right|^{2}}-\tau\right) e^{4 \alpha \tau \tilde{f}-2 \alpha e^{2 \tilde{f}+\log |\phi|^{2}+\sum_{k} \alpha_{k} \log \left|t_{k}\right|^{2}}-\sum_{j}\left(1-\beta_{j}\right) \log \left|\boldsymbol{s}_{j}\right|^{2}}=-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \tag{5.1}
\end{equation*}
$$

in which $\lambda$ is an indefinite positive constant. Notice that our $\Delta=\Delta_{g_{0}}$ is precisely the negative of the Laplacian used by Yang [23, 13].
When the singularities are absent, Yang used sup/subsolution method to find solution of this equation, cf. [23, Equation (36)] (see also [13]). We will show that Yang's method directly carries over to the current singular setting. The sets

$$
\begin{align*}
\mathcal{Z} & =\left\{\left(p_{i}, n_{i}\right) \mid p_{i} \text { is a zero of } \phi \text { with multiplicity } n_{i}, i=1,2, \cdots, Z\right\}  \tag{5.2}\\
\mathcal{C} & =\left\{\left(q_{j}, 1-\beta_{j}\right) \mid j=1,2, \cdots, M\right\}  \tag{5.3}\\
\mathcal{P} & =\left\{\left(r_{k}, \alpha_{k}\right) \mid k=1,2, \cdots, S\right\} \tag{5.4}
\end{align*}
$$

are intended to represent the zeros of the Higgs field with corresponding multiplicities, the conical points of the Kähler metric with corresponding angle defects and the parabolic points of the Hermitian metric with corresponding degrees respectively.

Write

$$
u_{0}=\log |\phi|^{2}+\sum_{k} \alpha_{k} \log \left|\boldsymbol{t}_{k}\right|^{2}
$$

then the equation is written as

$$
\begin{equation*}
\Delta \tilde{f}+\frac{1}{2} \lambda e^{-\left(2 \alpha \tau u_{0}+\sum_{j}\left(1-\beta_{j}\right) \log \left|s_{j}\right|^{2}\right)} F\left(2 \tilde{f}+u_{0}\right)=-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \tag{5.5}
\end{equation*}
$$

where $F(t)=e^{2 \alpha \tau t-2 \alpha e^{t}}\left(e^{t}-\tau\right)$. Suppose we can find a solution to (5.5) for some $\lambda>0$, then the conformal metric

$$
\begin{equation*}
g=\lambda \frac{e^{4 \alpha \tau \tilde{f}-2 \alpha|\phi|_{h}^{2}}}{\prod_{j}\left|\boldsymbol{s}_{j}\right|^{2\left(1-\beta_{j}\right)}} g_{0} \tag{5.6}
\end{equation*}
$$

where $|\boldsymbol{\phi}|_{h}^{2}=e^{2 \tilde{f}+u_{0}}$ together with the Hermitian metric

$$
\begin{equation*}
h=h_{0} \prod_{k}\left|\boldsymbol{t}_{k}\right|^{2 \alpha_{k}} e^{2 \tilde{f}} \tag{5.7}
\end{equation*}
$$

satisfy the singular Einstein-Bogomol'nyi equations:

$$
\begin{align*}
i F_{h}+\frac{1}{2}\left(|\boldsymbol{\phi}|_{h}^{2}-\tau\right) \mathrm{dvol}_{g} & =-2 \pi \sum_{k} \alpha_{k}\left[r_{k}\right]  \tag{5.8}\\
S_{g}+\alpha\left(\Delta_{g}+\tau\right)\left(|\boldsymbol{\phi}|_{h}^{2}-\tau\right) & =2 \pi \sum_{j}\left(1-\beta_{j}\right) \delta_{q_{j}}
\end{align*}
$$

Let us try to solve a regularization of Equation (5.5) first. Let $u_{0}^{\delta}=\log \left(|\phi|^{2}+\delta\right)+\sum_{k} \alpha_{k} \log \left(\left|\boldsymbol{t}_{k}\right|^{2}+\delta\right)$, then the aim is to find solution $\tilde{f}$ to

$$
\begin{equation*}
\Delta \tilde{f}+\frac{1}{2} \lambda e^{-\left(2 \alpha \tau u_{0}^{\delta}+\sum_{j}\left(1-\beta_{j}\right) \log \left(\left|s_{j}\right|^{2}+\delta\right)\right)} F\left(2 \tilde{f}+u_{0}^{\delta}\right)=-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \tag{5.9}
\end{equation*}
$$

for all $\delta \in(0,1)$ for some fixed $\lambda>0$.

Let $v_{0}^{\delta}=2 \alpha \tau u_{0}^{\delta}+\sum_{j}\left(1-\beta_{j}\right) \log \left(\left|s_{j}\right|^{2}+\delta\right)$ be a regularization of $v_{0}=2 \alpha \tau u_{0}+\sum_{j}\left(1-\beta_{j}\right) \log \left|s_{j}\right|^{2}$ and $C_{\delta}:=1+\lambda \sup _{x \in \Sigma}\left\{e^{-v_{0}^{\delta}(x)}\right\} \sup _{t \in \mathbb{R}} F^{\prime}(t)$, and define a sequence of functions $\left\{\tilde{f}_{n}\right\}_{n=1,2, \ldots}$ iteratively by

\left(\Delta+C_{\delta}\right) \tilde{f}_{n} & =-\frac{1}{2} \lambda e^{-v_{0}^{\delta}} F\left(2 \tilde{f}_{n-1}+u_{0}^{\delta}\right)+C_{\delta} \tilde{f}_{n-1}-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}}  \tag{5.10}\\
2 \tilde{f}_{1} & :=-u_{0}^{\delta}+\log \tau .
\end{align*}
$$

Notice that $\tilde{f}_{n}$ could be solved uniquely since $\Delta+C_{\delta}$ is a positive operator, and $\tilde{f}_{n}$ are all smooth on $\Sigma$ by elliptic regularity. Let $\Psi_{\sigma}$ be a $C^{\infty}$ cut-off function supported in $\cup_{x \in \mathcal{S}} B_{g_{0}}(x, 2 \sigma)$ and equals to 1 on $\cup_{x \in \mathcal{S}} B_{g_{0}}(x, \sigma)$ where $\mathcal{S}=\mathcal{Z} \cup \mathcal{C} \cup \mathcal{P}$. Let $w$ solve

$$
\Delta w=-\frac{4 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \Psi_{\sigma}+C(\sigma)
$$

where $C(\sigma)=\frac{4 \pi \tilde{N}}{\mathrm{Vol}_{g_{0}}} \int_{\Sigma} \Psi_{\sigma} \mathrm{dvol}_{g_{0}}$. If $\sigma$ is chosen sufficiently small, then $C(\sigma)>0$ is sufficiently small and (by subtracting a big constant from $w$ to make $2 w+u_{0}^{\delta}<\log \tau$ for all $\delta \in(0,1)$ ) there holds on $\cup_{x \in S} B_{g_{0}}(x, \sigma)$

$$
\begin{equation*}
\Delta w<-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}}-\frac{1}{2} \lambda e^{-v_{0}^{\delta}} F\left(2 w+u_{0}^{\delta}\right) \tag{5.11}
\end{equation*}
$$

for any $\lambda>0$ and $\delta \in(0,1)$. With $w$ and $\sigma$ chosen as above, we choose $\lambda>0$ sufficiently large such that

-\frac{1}{2} \lambda e^{-v_{0}^{\delta}} F\left(2 w+u_{0}^{\delta}\right)=\frac{1}{2} \lambda\left(\tau-e^{2 w+u_{0}^{\delta}}\right) e^{-v_{0}^{\delta}} \geq \frac{1}{2} \lambda\left(\tau-e^{2 w+u_{0}^{\delta}}\right) e^{-v_{0}^{1}}>\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}}+\Delta w
$$

on $\Sigma \backslash \cup_{x \in \mathcal{S}} B_{g_{0}}(x, \sigma)$ for all $\delta \in(0,1)$. Therefore, the inequality (5.11) is satisfied on whole $\Sigma$, meaning that we have constructed a supsolution $w$ to Equation (5.9).
Proposition 5.1. For any $\delta \in(0,1)$, the sequence of functions $\tilde{f}_{n}$ satisfies

\tilde{f}_{1}>\tilde{f}_{2}>\cdots>\tilde{f}_{n}>\cdots>w
$$

Proof. By a direct calcuation
$\left.\Delta \tilde{f}_{1}=-\frac{2 \pi N}{\operatorname{Vol}_{g_{0}}} \frac{|\boldsymbol{\phi}|^{2}}{|\boldsymbol{\phi}|^{2}+\delta}-\sum_{k} \frac{2 \pi \alpha_{k}}{\operatorname{Vol}_{g_{0}}} \frac{\left|\boldsymbol{t}_{k}\right|^{2}}{\left|\boldsymbol{t}_{k}\right|^{2}+\delta}+\left.\frac{\delta|\boldsymbol{\phi}|^{2}}{\left(|\boldsymbol{\phi}|^{2}+\delta\right)^{2}}\left|\nabla^{1,0} \log \right| \boldsymbol{\phi}\right|^{2}\left|+\sum_{k} \alpha_{k} \frac{\delta\left|\boldsymbol{t}_{k}\right|^{2}}{\left(\left|\boldsymbol{t}_{k}\right|^{2}+\delta\right)^{2}}\right| \nabla^{1,0} \log \left|\boldsymbol{t}_{k}\right|^{2} \right\rvert\,$
The function $\tilde{f}_{2}-\tilde{f}_{1}$ satisfies

$$
\begin{align*}
\left(\Delta+C_{\delta}\right)\left(\tilde{f}_{2}-\tilde{f}_{1}\right)=- & \frac{2 \pi N}{\operatorname{Vol}_{g_{0}}} \frac{\delta}{|\boldsymbol{\phi}|^{2}+\delta}-\sum_{k} \frac{2 \pi \alpha_{k}}{\mathrm{Vol}_{g_{0}}} \frac{\delta}{\left|\boldsymbol{t}_{k}\right|^{2}+\delta} \\
& \left.-\left.\frac{\delta|\boldsymbol{\phi}|^{2}}{\left(|\boldsymbol{\phi}|^{2}+\delta\right)^{2}}\left|\nabla^{1,0} \log \right| \boldsymbol{\phi}\right|^{2}\left|-\sum_{k} \alpha_{k} \frac{\delta\left|\boldsymbol{t}_{k}\right|^{2}}{\left(\left|\boldsymbol{t}_{k}\right|^{2}+\delta\right)^{2}}\right| \nabla^{1,0} \log \left|\boldsymbol{t}_{k}\right|^{2} \right\rvert\, \tag{5.12}
\end{align*}
$$

The maximum principle concludes that $\tilde{f}_{2}-\tilde{f}_{1}<0$ on $\Sigma$. On the other hand, there holds away from $\mathcal{Z} \cup \mathcal{P}$ that

$$
\begin{align*}
\left(\Delta+C_{\delta}\right)\left(w-\tilde{f}_{2}\right) & <C_{\delta}\left(w-\tilde{f}_{1}\right)-\frac{1}{2} \lambda e^{-v_{0}^{\delta}}\left(F\left(2 w+u_{0}^{\delta}\right)-F\left(2 \tilde{f}_{1}+u_{0}^{\delta}\right)\right) \\
& =\left(C_{\delta}-\lambda e^{-v_{0}^{\delta}} F^{\prime}\left(u_{0}^{\delta}+\xi\right)\right)\left(w-\tilde{f}_{1}\right)  \tag{5.13}\\
& <0
\end{align*}
$$

where $\xi$ is a function on $\Sigma$. The maximum principle implies that

$$
w<\tilde{f}_{2}
$$

The claimed inequality follows inductively. Precisely speaking, the maximum principle applied to

\left(\Delta+C_{\delta}\right)\left(\tilde{f}_{n+1}-\tilde{f}_{n}\right) & =\left(C_{\delta}-\lambda e^{-v_{0}^{\delta}} F^{\prime}\left(u_{0}+\kappa_{n}\right)\right)\left(\tilde{f}_{n}-\tilde{f}_{n-1}\right) \\
\left(\Delta+C_{\delta}\right)\left(w-\tilde{f}_{n+1}\right) & <\left(C_{\delta}-\lambda e^{-v_{0}^{\delta}} F^{\prime}\left(u_{0}+\xi_{n}\right)\right)\left(w-\tilde{f}_{n}\right) \tag{5.14}
\end{align*}
$$

where $\kappa_{n}$ and $\xi_{n}$ are functions on $\Sigma$ gives $\tilde{f}_{1}>\tilde{f}_{2}>\cdots>\tilde{f}_{n}>\cdots>w$ on $\Sigma$.
This proposition implies $\left\|\tilde{f}_{n-1}\right\|_{L^{\infty}(\Sigma)}$ are uniformly bounded (when $\delta \in(0,1)$ is fixed) and thus by Equation (5.10) the $C^{1, \gamma}$ norm of $\tilde{f}_{n}$ are uniformly bounded for any $\gamma \in(0,1)$. The RHS of the equation has a uniform $C^{\gamma}$ bound and therefore the $C^{2, \gamma}$ norm of $\tilde{f}_{n}$ are uniformly bounded for any $\gamma \in(0,1)$. As a consequence, the sequence uniformly converges as $n \rightarrow+\infty$ to a $C^{2, \gamma}$ function $\tilde{f}^{\delta}$ solving the equation (5.9) on $\Sigma$. Notice that $\tilde{f}^{\delta}$ a priori depends on $\Psi_{\sigma}, w$ and $\lambda$.

Looking back to the equation

$$
\begin{equation*}
\Delta \tilde{f}^{\delta}+\frac{1}{2} \lambda e^{-v_{0}^{\delta}} F\left(2 \tilde{f}^{\delta}+u_{0}^{\delta}\right)=-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \tag{5.15}
\end{equation*}
$$

and the above construction shows that

w \leq \tilde{f}^{\delta}<\tilde{f}_{1}=-\frac{1}{2} u_{0}^{\delta}+\frac{1}{2} \log \tau, \quad \forall \delta \in(0,1) \tag{5.16}
\end{equation*}

which in particular implies that for any $q>1$,

for some $C$ independent of $\delta \in(0,1)$. Denote (A) for the analytical assumption:

Since $F$ is uniformly bounded on $\mathbb{R}$, (5.19) implies there is a uniform constant $C$ independent of $\delta \in(0,1)$ such that

\end{equation*}

by Equation (5.15). The Sobolev embedding then implies that

\left\|\tilde{f}^{\delta}\right\|_{C^{\gamma}} \leq C \tag{5.21}
\end{equation*}
$$

for a $\delta$-independent constant $C$ and $\gamma \in(0,1)$. The Equation (5.15) is then rewritten as

$$
\begin{equation*}
\Delta \tilde{f}^{\delta}=-\frac{\lambda}{2} \frac{1}{\prod_{j}\left(\left|s_{j}\right|^{2}+\delta\right)^{1-\beta_{j}}} e^{4 \alpha \tau \tilde{f}^{\delta}-2 \alpha e^{2 \tilde{f}^{\delta}+u_{0}^{\delta}}}\left(e^{2 \tilde{f}^{\delta}+u_{0}^{\delta}}-\tau\right)-\frac{2 \pi \tilde{N}}{\operatorname{Vol}_{g_{0}}} \tag{5.22}
\end{equation*}
$$

whose RHS is easily seen to be uniformly bounded in $L^{p^{\prime}}$ for some $p^{\prime}>1$. The consequence is that

$$
\begin{equation*}
\left\|\tilde{f}^{\delta}\right\|_{C^{1, \gamma^{\prime}}(\Sigma)} \leq C \tag{5.23}
\end{equation*}
$$

for some $C$ independent of $\delta \in(0,1)$. On any compact subset $K$ away from $\mathcal{S}$ we have $\Delta \tilde{f}^{\delta}$ is uniformly bounded in $C^{\gamma^{\prime}}(K)$ and therefore $\tilde{f}^{\delta}$ is bounded in $C^{2, \gamma^{\prime}}(K)$. By taking an exhaustion of $\Sigma \backslash \mathcal{S}$ and taking a diagonal subsequence as $\delta \rightarrow 0$, we have a limit function $\tilde{f}$ in $C_{l o c}^{2}(\Sigma \backslash \mathcal{S}) \cap C^{1, \gamma^{\prime}}(\Sigma)$ solving the Equation (5.5).

We divide the singularity set $\mathcal{S}$ into seven groups according to the Venn diagram of the three sets $A=\mathcal{Z}$, $B=\mathcal{C}$ and $C=\mathcal{P}$. The analytical assumption $(\mathbf{A})$ is satisfied if and only if the the numerical assumption $(\mathbf{N})$ about any singular point $x$ is satisfied for $x$ in the corresponding part of the Venn diagram (Figure $1)$, for instance if $x \in(\mathcal{Z} \cap \mathcal{C}) \backslash \mathcal{P}$ saying $x=p_{k}=q_{k}$ then we should have $4 \alpha \tau n_{k}+2\left(1-\beta_{k}\right)<2$. We expect there is a stability explanation to these numerical assumptions as what happens in the smooth case [3, 11.

Theorem 5.2 (Existence of singular cosmic strings). Let $L$ be a holomorphic line bundle on $\mathbb{P}^{1}$, suppose $c_{1}(L)=N$ and $\phi$ is a holomorphic section of $L$ with the zero set $\mathcal{Z}$. Let $\mathcal{C}, \mathcal{P}$ be two subsets with degrees, such that the numerical assumption ( $\mathbf{N}$ ) is satisfied, then there exists singular gravitating vortex solution to the Equation (1.2) when the coupling constant and symmetry breaking parameter satisfies $\alpha \tau=\frac{\tilde{\chi}}{2 N}=\frac{2-\sum_{j}\left(1-\beta_{j}\right)}{2\left(N+\sum_{k} \alpha_{k}\right)}$.


Figure 1. Numerical assumption for various group of singularities

Remark 5.3. Even though the solution $g$ to singular Einstein-Bogomol'nyi equations is conformal to the starting smooth metric $g_{0}$, they are not necessarily with the same volume. The metric resulted from the above construction seems to depend on $\lambda$. Actually, the uniqueness of solution is a subtle issue as indicated by [13], and is naturally a quite interesting question thinking of the infinite dimensional moment map picture [1, 2] and the physical background regarding cosmic strings.
