# On an extension of the generalized BGW tau-function

#### Abstract

For an arbitrary solution to the Burgers-KdV hierarchy, we define the tau-vector $\left(\tau_{1}, \tau_{2}\right)$ of the solution. We then introduce certain linear maps and derive an explicit formula for the product $\tau_{1} \tau_{2}$. Applications to an extension of the generalized BGW tau-function and to the open partition function are given.


## 1 Introduction

The Brézin-Grosss-Witten (BGW) partition function was introduced in [9, 19. Recently, Norbury [27] constructed a new cohomology class on the moduli space of closed Riemann surfaces. It has been proved [27] that the partition function of the intersection numbers of the Norbury class coupling $\psi$-classes coincides with the BGW partition function. Recalling another recent construction about the moduli space of open Riemann surfaces [28] (cf. also [11]), we consider in this article an extension of the BGW partition function, that should serve as the partition function of intersection numbers of certain extended version of the Norbury class coupling the descendants on the open and closed Riemann surfaces. Considering that there is a one-parameter generalization of the BGW partition function given in [1], we will perform the extension for an arbitrary value of the parameter.

Denote by $\mathcal{A}_{(w, \rho)}$ the ring of polynomials of $w_{x}, \rho_{x}, w_{x x}, \rho_{x x}, \ldots$ with coefficients being smooth functions of $w, \rho$. The Burgers-KdV integrable hierarchy [10] is defined as the following pairwise commuting system of non-linear PDEs:

& \frac{\partial w}{\partial q_{2 n-1}}=\partial_{x} K_{2 n-1}, \quad \frac{\partial w}{\partial q_{2 n}}=0, \quad n \geq 1  \tag{1.1}\\
& \frac{\partial \rho}{\partial q_{2 n-1}}=\partial_{x} R_{2 n-1}, \quad \frac{\partial \rho}{\partial q_{2 n}}=\partial_{x} R_{2 n}, \quad n \geq 1, \tag{1.2}
\end{align*}
$$

where $K_{n}, R_{n} \in A_{(w, \rho)}$ are defined recursively by

\begin{align*}
& K_{1}=w, \quad K_{2}=0, \quad R_{1}=\rho, \quad R_{2}=\rho^{2}+\rho_{x}+2 w,  \tag{1.3}\\
& \partial_{x} K_{2 n+1}=\left(2 w \partial_{x}+w_{x}+\frac{1}{4} \partial_{x}^{3}\right) K_{2 n-1},  \tag{1.4}\\
& R_{2 n+1}=\left(\partial_{x}^{2}+2 \rho \partial_{x}+\rho^{2}+\rho_{x}+2 w\right) R_{2 n-1}+\left(\rho+\frac{3}{2} \partial_{x}\right) K_{2 n-1},  \tag{1.5}\\
& R_{2 n+2}=\left(\partial_{x}^{2}+2 \rho \partial_{x}+\rho^{2}+\rho_{x}+2 w\right) R_{2 n}, \quad n \geq 0 . \tag{1.6}
\end{align*}
$$

The $n=1$ flow reads

$$
\frac{\partial w}{\partial q_{1}}=w_{x} \quad \frac{\partial \rho}{\partial q_{1}}=\rho_{x}
$$

Therefore, we can identify the variable $q_{1}$ with $x$. Note that equations (1.1) are the KdV integrable hierarchy. Hence, the Burgers-KdV hierarchy can be viewed as an integrable extension of (1.1); for more details about the Burgers-KdV hierarchy see [10.

Recall that the canonical tau structure [17, [16] of the KdV hierarchy is defined as the unique family of elements $\left(\Omega_{i, j}\right)_{i, j \geq 1} \in \mathcal{A}_{w}$ satisfying

\Omega_{1,1}=w, \quad \Omega_{i, j}=\Omega_{j, i}, \quad \frac{\partial \Omega_{i, j}}{\partial q_{2 k-1}}=\frac{\partial \Omega_{i, k}}{\partial q_{2 j-1}}, \quad \forall i, j, k \geq 1 \tag{1.7}
\end{equation*}
$$

along with the normalization condition $\left.\Omega_{i, j}\right|_{w_{k x}=0, k \geq 0}=0$. Here, $\mathcal{A}_{w} \subset \mathcal{A}_{(w, \rho)}$ denotes the ring of polynomials of $w_{x}, w_{x x}, \ldots$ with coefficients being smooth functions in $w$. For the existence of $\Omega_{i, j}$ see e.g. [17, 16]. Inspired by the open and closed intersection numbers [7, 10, 11, 28] and by the tau-structure of the Burgers hierarchy [15], we will define the tau-vector structure for the Burgers-KdV hierarchy. Indeed, observe that

\frac{\partial R_{i}}{\partial q_{j}}=\frac{\partial R_{j}}{\partial q_{i}}, \quad \forall i, j \geq 1 \tag{1.8}
\end{equation*}
$$

Combining with (1.7) we arrive at the following lemma.
Lemma 1.1 For an arbitrary solution $(w, \rho)$ in $\mathbb{C}[[\mathbf{q}]]^{2}$ to the Burgers-KdV hierarchy, there exists $\left(\tau_{1}, \tau_{2}\right) \in \mathbb{C}[[\mathbf{q}]]^{2}$, such that

\begin{align*}
& \frac{\partial^{2} \log \tau_{1}}{\partial q_{2 i-1} \partial q_{2 j-1}}=\Omega_{i, j}, \quad \frac{\partial^{2} \log \tau_{1}}{\partial q_{2 i} \partial q_{j}}=0, \quad \forall i, j \geq 1,  \tag{1.9}\\
& \frac{\partial \log \tau_{2}}{\partial q_{i}}=R_{i}, \quad \forall i \geq 1 . \tag{1.10}
\end{align*}
$$

Moreover, the vector $\left(\tau_{1}, \tau_{2}\right)$ is uniquely determined by $(w, \rho)$ up to the freedom described by

$$
\begin{equation*}
\left(\tau_{1}, \tau_{2}\right) \mapsto\left(\tau_{1} e^{\beta_{0}+\sum_{n \geq 1} \beta_{n} q_{n}}, \tau_{2} e^{\alpha_{0}}\right) \tag{1.11}
\end{equation*}
$$

where $\beta_{n}, n \geq 0$ and $\alpha_{0}$ are an arbitrary constant.
We call $\left(\tau_{1}, \tau_{2}\right)$ the tau-vector of the solution $(w, \rho)$ to the Burgers-KdV hierarchy, and call the product $\tau_{1} \cdot \tau_{2}=: \tau_{\mathrm{E}}$ the tau-function for the Burgers-KdV hierarchy. Equations (1.9)-(1.10) for $i=j=1$ read

w=\partial_{x}^{2} \log \tau_{1}, \quad \rho=\partial_{x} \log \tau_{2} . \tag{1.12}
\end{equation*}
$$

As it was proven in [5], the Dubrovin-Zhang type tau-function $\tau_{1}$ for the KdV hierarchy is also a Sato type tau-function; vice versa. To proceed we first recall some notations. Denote by $\mathbb{Y}$ the set of all the partitions. For each partition $\lambda \in \mathbb{Y}$, denote by $\ell(\lambda)$ the length of $\lambda$, by $|\lambda|$ the weight, and by $\left(m_{1}, \ldots, m_{r} \mid n_{1}, \ldots, n_{r}\right)$ the Frobenius notation (cf. [25]). The Schur polynomial associated to $\lambda$ is defined as follows:

s_{\lambda}:=\operatorname{det}\left(h_{\lambda_{i}-i+j}\right)_{1 \leq i, j \leq \ell(\lambda)}, \tag{1.13}
\end{equation*}
$$

where $\left\{h_{k}\right\}_{k \geq 0}$ are polynomials in $\mathbb{C}[\mathbf{q}]$ defined by the generating function

\begin{equation*}
\sum_{k \geq 0} h_{k} z^{k}=\exp \left(\sum_{n \geq 1} q_{n} z^{n}\right) \tag{1.14}
\end{equation*}
$$

According to the Sato theory, the component $\tau_{1}$, can be expressed as the linear combination of the Schur polynomials with coefficients being the Plücker coordinates, i.e.,

$$
\begin{equation*}
\tau_{1}=c_{0} \sum_{\lambda \in \mathbb{Y}} \pi_{\lambda} s_{\lambda} . \tag{1.15}
\end{equation*}
$$

Here, $c_{0}$ is a nonzero constant that is irrelevant of the study and is often taken as 1 , and

$$
\begin{equation*}
\pi_{\lambda}:=(-1)^{\sum_{i=1}^{r} n_{i}} \operatorname{det}\left(A_{m_{i}, n_{j}}\right)_{1 \leq i, j \leq r} \tag{1.16}
\end{equation*}
$$

with $A_{m, n}, m, n \geq 0$ being the affine coordinates [18, 32, 7, 33] for the point of Sato Grassmannian corresponding to $\tau_{1}$. In this paper, we will derive explicit expressions for $\tau_{1} \tau_{2}$.

Before presenting the results, we introduce further some notations. Note that the Schur polynomials form a basis of $\mathbb{C}[[\mathbf{q}]]$, and define a sequence of linear operators $T_{n}: \mathbb{C}[[\mathbf{q}]] \rightarrow \mathbb{C}[[\mathbf{q}]]$ in the following way:

T_{n}\left(s_{\lambda}\right)=\left\{\begin{array}{cc}
(-1)^{i} s_{\left(\lambda_{1}-1, \ldots, \lambda_{i}-1, n+i, \lambda_{i+1}, \ldots, \lambda_{\ell(\lambda)}\right)}, & \text { if } \lambda_{i}>n+i \geq \lambda_{i+1}, \text { for some } i,  \tag{1.17}\\
0, & \text { otherwise } .
\end{array}\right.
$$

Here we set $\lambda_{0}=+\infty$ and $\lambda_{\ell(\lambda)+1}=0$. The operator $T_{0}$ has the alternative expression:

$$
T_{0}\left(s_{\left(m_{1}, \ldots, m_{r} \mid n_{1}, \ldots, n_{r}\right)}\right)=\left\{\begin{array}{cl}
(-1)^{r} s_{\left(m_{1}-1, \ldots, m_{r}-1 \mid n_{1}+1, \ldots, n_{r}+1\right)} & m_{r} \geq 1  \tag{1.18}\\
0 & m_{r}=0
\end{array}\right.
$$

Note that for each $n \geq 0$, the linear operator $T_{n}$ induces the linear transformation on $\operatorname{Span}_{\mathbb{C}}(\mathbb{Y})$, denoted again by $T_{n}$. The first result of the paper is given by the following proposition.

Proposition 1.2 Let $(w, \rho)$ be an arbitrary solution in $\mathbb{C}[[\mathbf{q}]]^{2}$ to the Burgers-KdV hierarchy (1.1) $-(1.2)$, and $\left(\tau_{1}, \tau_{2}\right) \in \mathbb{C}[[\mathbf{q}]]^{2}$ its tau-vector with $\tau_{2}(\mathbf{0})$ chosen as 1 . There exists a unique sequence of numbers $b_{1}, b_{2}, b_{3}, \ldots$, such that

\begin{equation*}
\tau_{1} \cdot \tau_{2}=Q \circ T_{0} \circ Q^{-1}\left(\tau_{1}\right), \tag{1.19}
\end{equation*}
$$

where $Q=e^{\sum_{k \geq 1} k b_{k} q_{k}}$ denotes the multiplication operator on $\mathbb{C}[[\mathbf{q}]]$.
The proof is in Section 3.
Noticing that $Q \circ T_{0} \circ Q^{-1}$ is a linear operator and using (1.15), we will simplify (1.19) via computing the action of $Q \circ T_{0} \circ Q^{-1}$ on each single Schur polynomial. Let us present the results here, and leave the details of calculations to Section 3, For $\lambda \in \mathbb{Y}$, define $\pi_{-\lambda}=-\pi_{\lambda}$. Let $c_{\lambda \mu}^{\nu}, \lambda, \mu, \nu \in \mathbb{Y}$ denote the Littlewood-Richardson coefficients [24]:

s_{\lambda} \cdot s_{\mu}=: \sum_{\nu \in \mathbb{Y}} c_{\lambda \mu}^{\nu} s_{\nu} \tag{1.20}
\end{equation*}

For $\lambda, \mu, \nu \in \mathbb{Y}$, we set $c_{\lambda,-\mu}^{\nu}:=-c_{\lambda, \mu}^{\nu}$. Define a sequence of numbers $g_{0}, g_{1}, g_{2}, g_{3}, \ldots$ by

\begin{equation*}
\sum_{n \geq 0} g_{n} z^{-n}:=e^{\sum_{k \geq 1} b_{k} z^{-k}} \tag{1.21}
\end{equation*}
$$

Proposition 1.3 The tau-function $\tau_{\mathrm{E}}$ has the expression

$$
\begin{equation*}
\tau_{\mathrm{E}}=\sum_{\lambda \in \mathbb{Y}} s_{\lambda} \sum_{\substack{0 \leq k \leq|\lambda| \\ \mu \in T_{k}^{-1}(\lambda)}} g_{k} \pi_{\mu} \tag{1.22}
\end{equation*}
$$

Alternatively, denoting $\mathbf{b}:=\left(b_{1}, b_{2}, b_{3}, \ldots\right)$, we have

$$
\begin{equation*}
\tau_{\mathrm{E}}=\sum_{\lambda \in \mathbb{Y}} s_{\lambda} \sum_{\substack{\alpha, \mu, \nu \in \mathbb{Y} \\ \beta \in \mathbb{Y} \backslash \operatorname{Ker}\left(T_{0}\right)}} \pi_{\alpha} c_{\mu \alpha}^{\beta} c_{\nu, T_{0}(\beta)}^{\lambda} s_{\mu}(-\mathbf{b}) s_{\nu}(\mathbf{b}) \tag{1.23}
\end{equation*}
$$

Observe that for a hook partition $\lambda$ with the Frobenius notation $(m \mid n)$,

$$
T_{k}^{-1}(\lambda)=\left\{\begin{array}{cc}
\{\varnothing\}, & n=0, k=m+1  \tag{1.24}\\
\{(0 \mid n-1)\}, & n \geq 1, k=m+1 \\
\{-(m+1 \mid n-1)\}, & n \geq 1, k=0 \\
\varnothing, & \text { otherwise }
\end{array}\right.
$$

Then from (1.22) we see that the coefficient of $s_{(m \mid n)}$ in $\tau_{\mathrm{E}}$, denoted by $c_{m, n}$, has the more explicit expression:

c_{m, n}=\left\{\begin{array}{cc}
g_{m+1}, & n=0  \tag{1.25}\\
(-1)^{n}\left(g_{m+1} A_{0, n-1}-A_{m+1, n-1}\right), & n \geq 1
\end{array}\right.
$$

Together with Theorem B. 1 and the formula similar to (1.15) for the KP hierarchy, we have
Corollary 1.4 The tau-function $\tau_{\mathrm{E}}$ has the following explicit expression:

$$
\begin{equation*}
\tau_{\mathrm{E}}=\sum_{\lambda \in \mathbb{Y}} \pi_{\lambda}^{\prime} s_{\lambda} \tag{1.26}
\end{equation*}
$$

Here for a partition $\lambda=\left(m_{1}, \ldots, m_{r} \mid n_{1}, \ldots, n_{r}\right), \pi_{\lambda}^{\prime}=\operatorname{det}\left(c_{m_{i}, n_{j}}\right)_{1 \leq i, j \leq r}$.
We proceed with defining the extension of the generalized BGW tau-function. Consider the solution to the Burgers-KdV hierarchy (1.1)-(1.2) specified by the initial condition

$$
\begin{equation*}
\left.w\right|_{q_{2}=q_{3}=\cdots=0}=\frac{C}{(1-x)^{2}},\left.\quad \rho\right|_{q_{2}=q_{3}=\cdots=0}=0 \tag{1.27}
\end{equation*}
$$

where $C$ is an arbitrarily given constant $\left(N=\sqrt{\frac{1}{4}-2 C}\right.$ corresponds to the parameter in [3]). We call this solution the generalized BGW solution to the Burgers-KdV hierarchy, denoted by $\left(w^{\Theta(C)}, \rho^{\Theta(C)}\right)$. Let $\left(\tau_{1}^{\Theta(C)}, \tau_{2}^{\Theta(C)}\right)$ be the tau-vector of $\left(w^{\Theta(C)}, \rho^{\Theta(C)}\right)$. As in [3, 6, 14, 16] we normalize the first component $\tau_{1}^{\Theta(C)}$ by

\sum_{k \geq 0}(2 k+1)\left(q_{2 k+1}-\delta_{k, 0}\right) \frac{\partial \tau_{1}^{\Theta(C)}}{\partial q_{2 k+1}}+C \tau_{1}^{\Theta(C)}=0 \tag{1.28}
\end{equation*}
$$

and by requiring $\partial \tau_{1}^{\Theta(C)} / \partial q_{2 n}=0$, call it the generalized BGW tau-function. We normalize the second component $\tau_{2}^{\Theta(C)}$ by requiring

$$
\begin{equation*}
\tau_{2}^{\Theta(C)}(\mathbf{0})=1 \tag{1.29}
\end{equation*}
$$

We note that when the parameter $C$ is taken to be $1 / 8$, the first component $\tau_{1}^{\Theta(C)}$ becomes the BGW tau-function. Norbury [27] proves the following identity:

\begin{equation*}
\tau_{1}^{\Theta\left(\frac{1}{8}\right)}=\exp \left(\sum_{n \geq 1} \sum_{i_{1}, \ldots, i_{n} \geq 0} \frac{1}{n!} \prod_{k=1}^{n}\left(2 i_{k}+1\right)!!q_{2 i_{k}+1} \int_{\overline{\mathcal{M}}_{g, n}} \Theta_{g, n} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}}\right) \tag{1.30}
\end{equation*}
$$

Here $\Theta_{g, n}$ are certain cohomology classes [27]. Our next result is given by the following theorem.
Theorem 1.5 Define a sequence of numbers $g_{n}^{\Theta(C)}$ by

$$
\begin{equation*}
g_{0}^{\Theta(C)}=1, \quad g_{n}^{\Theta(C)}=(n-1)!\sum_{k=1}^{n} \frac{1}{k!(k-1)!} \prod_{i=1}^{k}\left(C+\frac{i(i-1)}{2}\right), \quad n \geq 1 . \tag{1.31}
\end{equation*}
$$

Define $b_{1}, b_{2}, b_{3}, \ldots$ via $\sum_{k \geq 1} b_{k} z^{-k}=\log \sum_{n \geq 0} g_{n}^{\Theta(C)} z^{-n}$, and denote by $Q=e^{\sum_{k \geq 1} k b_{k} q_{k}}$ the multiplication operator. The following identity holds true:

\begin{equation*}
\tau_{2}^{\Theta(C)}=\frac{1}{\tau_{1}^{\Theta(C)}} Q \circ T_{0} \circ Q^{-1}\left(\tau_{1}^{\Theta(C)}\right) . \tag{1.32}
\end{equation*}
$$

Moreover, $\tau_{\mathrm{E}}^{\Theta(C)}:=\tau_{1}^{\Theta(C)} \tau_{2}^{\Theta(C)}$ satisfies the following linear equation:

$$
\begin{equation*}
\sum_{n \geq 1} n \tilde{q}_{n} \frac{\partial \tau_{\mathrm{E}}^{\Theta(C)}}{\partial q_{n}}+C \tau_{\mathrm{E}}^{\Theta(C)}=0, \quad \tilde{q}_{n}=q_{n}-\delta_{n, 1} \tag{1.33}
\end{equation*}
$$

Recall that the explicit expression for the affine coordinates $A_{m, n}^{\Theta(C)}$ of the point of the Sato Grassmannian corresponding to $\tau_{1}^{\Theta(C)}$ was obtained in [16]:

\begin{equation*}
A_{m, n}^{\Theta(C)}=(-1)^{m} \sum_{\substack{r \geq m+1, s \geq 0 \\ r+s=m+n+1}} \frac{r-s}{r+s} a_{r} a_{s}, \quad a_{k}:=\frac{(-1)^{k}}{k!} \prod_{i=1}^{k}\left(C+\binom{i}{2}\right) . \tag{1.34}
\end{equation*}
$$

Define $\pi_{\lambda}^{\Theta(C)}$ via (1.16) with $A_{m, n}$ replaced by $A_{m, n}^{\Theta(C)}$. Combining with (1.22) we arrive at
Corollary 1.6 The tau-function $\tau_{\mathrm{E}}^{\Theta(C)}$ has the form

$$
\begin{equation*}
\tau_{\mathrm{E}}^{\Theta(C)}=\sum_{\lambda \in \mathbb{Y}} s_{\lambda} \sum_{\substack{0 \leq k \leq|\lambda| \\ \mu \in T_{k}^{-1}(\lambda)}} g_{k}^{\Theta(C)} \pi_{\mu}^{\Theta(C)} . \tag{1.35}
\end{equation*}
$$

For the reader's convenience we list the first few coefficients of $\tau_{\mathrm{E}}^{\Theta(C)}$ in Appendix A.
Propositions 1.2 and 1.3 also apply to the topological solution to the Burgers-KdV hierarchy, denoted by ( $w^{\mathrm{wK}}, \rho^{\mathrm{wK}}$ ), which is specified by the initial condition

\begin{equation*}
\left.w^{\mathrm{wK}}\right|_{q_{2}=q_{3}=\cdots=0}=x,\left.\quad \rho^{\mathrm{WK}}\right|_{q_{2}=q_{3}=\cdots=0}=0 . \tag{1.36}
\end{equation*}
$$

This solution governs the open and closed intersection numbers [28, 10, 11]. Let $\tau_{1}^{\mathrm{wK}}$ be the tau-function of the solution $w^{\mathrm{WK}}$ to the KdV hierarchy, normalized by the string equation:

\begin{equation*}
\sum_{n \geq 0}(2 n+1)\left(q_{2 n+1}-\delta_{n, 1}\right) \frac{\partial \tau_{1}^{\mathrm{WK}}}{\partial q_{2 n+1}}+\frac{x^{2}}{2} \tau_{1}^{\mathrm{WK}}=0 \tag{1.37}
\end{equation*}
$$

The explicit expression for the affine coordinates $A_{m, n}^{\mathrm{wK}}$ for the point of the Sato Grassmannian corresponding to $\tau_{1}^{\mathrm{WK}}$ was first obtained in [32] and later re-proved in [4]:

\begin{align*}
& A_{3 m-1,3 n}^{\mathrm{wK}}=A_{3 m-3,3 n+2}^{\mathrm{wK}} \\
= & \frac{(-1)^{n}}{36^{m+n}} \frac{(6 m+1)!!}{(2 m+2 n)!} \prod_{j=0}^{n-1}(m+j) \prod_{j=1}^{n}(2 m+2 j-1)\left(B(n, m)+\frac{2^{n}(6 n+1)!!}{(6 m+1)(2 n)!}\right),  \tag{1.38}\\
& A_{3 m-2,3 n+1}^{\mathrm{WK}} \\
= & \frac{(-1)^{n+1}}{36^{m+n}} \frac{(6 m+1)!!}{(2 m+2 n)!} \prod_{j=0}^{n-1}(m+j) \prod_{j=1}^{n}(2 m+2 j-1)\left(B(n, m)+\frac{2^{n}(6 n+1)!!}{(6 m-1)(2 n)!}\right), \tag{1.39}
\end{align*}
$$

where $n \geq 0, m \geq 1$ and $B(n, m)$ are defined as

$$
\begin{equation*}
B(n, m):=\frac{1}{6} \sum_{j=1}^{n} 108^{j} \frac{2^{n-j}(6 n-6 j+1)!!}{(2 n-2 j)!} \frac{\Gamma(m+n+1)}{\Gamma(m+n+2-j)} . \tag{1.40}
\end{equation*}
$$

Recall from [11] that the values $g_{n}$ for the topological solution are given by

g_{n}^{\mathrm{WK}}=\left\{\begin{array}{cl}
\sum_{i=0}^{m} \frac{3^{i}(6 m-6 i)!}{288^{m-i}(2 m-2 i)!(3 m-3 i)!} \prod_{j=1}^{i}\left(m+\frac{1}{2}-j\right), & n=3 m  \tag{1.41}\\
0, & \text { otherwise }
\end{array}\right.
$$

Define $\pi_{\lambda}^{\mathrm{wK}}$ via (1.16) with $A_{m, n}$ replaced by $A_{m, n}^{\mathrm{wK}}$. Using (1.22) we then arrive at
Corollary 1.7 The power series $\tau_{\mathrm{E}}^{\mathrm{wK}}$ has the following expression:

\tau_{\mathrm{E}}^{\mathrm{WK}}=\sum_{\lambda \in \mathbb{Y}} s_{\lambda} \sum_{\substack{0 \leq k \leq|\lambda| \\ \mu \in T_{k}^{-1}(\lambda)}} g_{k}^{\mathrm{WK}} \pi_{\mu}^{\mathrm{WK}} . \tag{1.42}
\end{equation*}
$$

Organization of the paper In Section 2, we will recall about some basics about the KdV hierarchy. In Section 3, we prove Propositions 1.2 and 1.3. In Section 4, we prove Theorem 1.5, Besides, we give a new proof of a result of Alexandrov in Appendix B

## 2 A brief review of the KdV hierarchy

In this section, we recall some basics about the KdV hierarchy (1.1). It is well known that this hierarchy can be written into the Lax form

\end{equation*}

where $L:=\partial_{x}^{2}+2 w(x)$. Here, for the meaning of $L^{n / 2}$ see e.g. [13]. For any solution $w \in \mathbb{C}[[\mathbf{q}]]$ to the KdV hierarchy 1 , there exists [13, 16] a pseudo-differential operator $P=\sum_{i \geq 0} \phi_{i} \partial_{x}^{-i} \in$

[^0]$\mathbb{C}[[\mathbf{q}]]\left[\left[\partial_{x}^{-1}\right]\right], \phi_{0}:=1$ satisfying the followings:

The formal adjoint operator of $P$ is defined by

For each solution $w$, define the wave function $\psi$ and its dual by

& \psi^{*}:=\psi^{*}(\mathbf{q} ; z)=\sum_{i \geq 0} \phi_{i}^{*} z^{-i} e^{-\sum_{n \geq 1} q_{n} z^{n}} \tag{2.6}
\end{align*}

Then $\psi$ and $\psi^{*}$ satisfy the following linear equations:

\frac{\partial \psi}{\partial q_{n}} & =\left(\mathcal{L}^{\frac{n}{2}}\right)_{+} \psi, \quad \frac{\partial \psi^{*}}{\partial q_{n}}=\left(\left(\mathcal{L}^{*}\right)^{\frac{n}{2}}\right)_{+} \psi^{*}, \quad \forall n \geq 1 \tag{2.8}
\end{align*}
$$

The following lemma was proven in e.g. [12].
Lemma 2.1 ([12]) The following bilinear identity holds true:

According to the Sato theory [29, 12, 13], there exists a (unique up to a multiplicative constant) formal series $\tau(\mathbf{q})$ satisfying

\psi(\mathbf{q} ; z)=\frac{\tau\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\tau(\mathbf{q})} e^{\sum_{n \geq 1} q_{n} z^{n}}, \quad \psi^{*}(\mathbf{q} ; z)=\frac{\tau\left(\mathbf{q}+\left[z^{-1}\right]\right)}{\tau(\mathbf{q})} e^{-\sum_{n \geq 1} q_{n} z^{n}} \tag{2.10}
\end{equation*}
$$

where $\left[z^{-1}\right]:=\left(\frac{1}{z}, \frac{1}{2 z^{2}}, \frac{1}{3 z^{3}}, \ldots\right)$. The series $\tau(\mathbf{q})$ is called the Sato type tau-function of the solution $w$ for the KdV hierarchy, which will play an important role in the later sections. Observe that the above $\phi_{i}$ and $\phi_{i}^{*}, i \geq 0$ do not depend on $q_{2}, q_{4}, q_{6}, \ldots$ Therefore, if we view $q_{2}, q_{4}, q_{6}, \ldots$ as constants, then as it was proved in [16] the $\psi$ and $\psi^{*}$ defined by (2.5)-(2.6) satisfy the pair condition of [16]. This statement is applied in several places of this paper.

## 3 Proofs of Propositions 1.2 and 1.3

The goal of this section is to prove Propositions 1.2 and 1.3 ,
The following lemma, that will play a fundamental rule, generalizes a result of Buryak [11].

Lemma 3.1 Let $(w, \rho) \in \mathbb{C}[[\mathbf{q}]]^{2}$ be an arbitrary solution to the Burgers-KdV hierarchy, and let $\left(\tau_{1}, \tau_{2}\right) \in \mathbb{C}[[\mathbf{q}]]^{2}$ be its tau-vector with a fixed choice (1.11). There exists a unique series

g(z)=\sum_{n \geq 0} g_{n} z^{-n} \in \mathbb{C}\left[\left[z^{-1}\right]\right], \quad g_{n} \in \mathbb{C}, g_{0} \neq 0 \tag{3.1}

such that the component $\tau_{2}$ has the expression

\tau_{2}=-\operatorname{res}_{z=\infty} g(z) \frac{\tau_{1}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\tau_{1}(\mathbf{q})} e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} . \tag{3.2}
\end{equation*}
$$

Proof According to [5], the Dubrovin-Zhang type tau-function $\tau_{1}$ of the solution $w$ for the KdV hierarchy defined by (1.9) is also a Sato type tau-function of $w$, i.e., the $\psi$ defined by

\psi(\mathbf{q} ; z):=\frac{\tau_{1}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\tau_{1}(\mathbf{q})} e^{\sum_{n \geq 1} q_{n} z^{n}}
$$

is a wave function (2.8) of the KP hierarchy. Let us define a sequence of number $g_{n}, n \geq 0$

& g_{0}=\tau_{2}(\mathbf{0}),  \tag{3.3}\\
& g_{n}=\left(\partial_{x}^{n} \tau_{2}\right)(\mathbf{0})+\left.\sum_{k=0}^{n} \sum_{i=0}^{\min \{k, n-1\}} \operatorname{res}_{z=\infty} \frac{g_{i} d z}{z^{k-i+1}} \partial_{x}^{n-k} \frac{\tau_{1}\left(x-\frac{1}{z},-\frac{1}{2 z^{2}}, \ldots\right)}{\tau_{1}(x, 0, \ldots)}\right|_{x=0}, \quad n \geq 1 . \tag{3.4}
\end{align*}
$$

Define $g(z)=\sum_{n \geq 0} g_{n} z^{-n}$, and define $\tilde{\tau}_{2} \in \mathbb{C}[[\mathbf{q}]]$ by $\tilde{\tau}_{2}=-\operatorname{res}_{z=\infty} g(z) \psi(\mathbf{q} ; z) \frac{d z}{z}$. From the definition of $g_{n}$ we have

\tilde{\tau}_{2}(x, 0, \ldots)=\tau_{2}(x, 0, \ldots) \tag{3.5}
\end{equation*}
$$

Using (2.8) we know that $\forall n \geq 1$,

\frac{\partial \tilde{\tau}_{2}}{\partial q_{n}}=\left(L^{\frac{n}{2}}\right)_{+}\left(\tilde{\tau}_{2}\right) \tag{3.6}
\end{equation*}
$$

where $L=\partial_{x}^{2}+w$. According (1.10) and [10], the second component $\tau_{2}$ satisfies

\frac{\partial \tau_{2}}{\partial q_{n}}=\left(L^{\frac{n}{2}}\right)_{+}\left(\tau_{2}\right), \quad \forall n \geq 1 \tag{3.7}
\end{equation*}
$$

Combining the formulae (3.5)-(3.7), we obtain $\tau_{2}=\tilde{\tau}_{2}$. The uniqueness follows from the requirement of (3.2) at $q_{2}=q_{3}=\cdots$ identically in $q_{1}$. The lemma is proved.

Lemma 3.2 For each $n \geq 1$ and $\lambda \in \mathbb{Y}$, we have

T_{n}\left(s_{\lambda}\right)=\operatorname{det} M_{n, \lambda_{1}, \ldots, \lambda_{\ell(\lambda)}} . \tag{3.8}

where $M_{k_{1}, \ldots, k_{m}}$ denotes the matrix $\left(h_{k_{i}-i+j}\right)_{1 \leq i, j \leq m}$ for $m \geq 1, k_{1}, \ldots, k_{m} \in \mathbb{Z}$.
The proof of this lemma is elementary and we omit its details.
Lemma 3.3 The transformation $T_{0}$ defined by (1.18) satisfies

T_{0}(f)=-\operatorname{res}_{z=\infty} f\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z}, \quad \forall f \in \mathbb{C}[[\mathbf{q}]] . \tag{3.9}
\end{equation*}

Proof Due to the linearity and the fact that Schur polynomials form a basis of $\mathbb{C}[[\mathbf{q}]]$, it suffices to show (3.9) for $f=s_{\lambda}, \lambda \in \mathbb{Y}$. By Lemma 3.2 we have

h_{k}\left(\mathbf{q}-\left[z^{-1}\right]\right)=h_{k}(\mathbf{q})-\frac{1}{z} h_{k-1}(\mathbf{q}), \quad \forall k \geq 1 \tag{3.12}
\end{equation*}

Therefore

s_{\lambda}\left(\mathbf{q}-\left[z^{-1}\right]\right)=\operatorname{det}\left(h_{\lambda_{i}-i+j}-\frac{1}{z} h_{\lambda_{i}-i+j-1}\right)_{1 \leq i, j \leq \ell(\lambda)}=: \sum_{k=0}^{\ell(\lambda)} M^{[k]} z^{-k}, \tag{3.13}
\end{equation*}
$$

where $M^{[k]}:=M^{[k]}(\mathbf{q})$ is just the $(1, k+1)$-th cofactor of the matrix $M_{0, \lambda_{1}, \ldots, \lambda_{\ell(\lambda)}}$. Now the right-hand side of (3.9) can be simplified to

-\operatorname{res}_{z=\infty}\left(\sum_{k=0}^{\ell(\lambda)} M^{[k]} z^{-k}\right)\left(\sum_{k \geq 0} h_{k} z^{k}\right) \frac{d z}{z}=\sum_{k=0}^{\ell(\lambda)} h_{k} M^{[k]}=\operatorname{det} M_{0, \lambda_{1}, \ldots, \lambda_{\ell(\lambda)}} . \tag{3.14}
\end{equation*}

The lemma is proved.
We notice that similarly with (3.9), we have the following formula:

&-\operatorname{res}_{z=\infty} s_{\left(m_{1}, \ldots, m_{r} \mid n_{1}, \ldots, n_{r}\right)}\left(\mathbf{q}+\left[z^{-1}\right]\right) e^{-\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} \\
&=(-1)^{r} s_{\left(m_{1}+1, \ldots, m_{r}+1 \mid n_{1}-1, \ldots, n_{r}-1\right)}(\mathbf{q}) \tag{3.15}
\end{align*}
$$

if $n_{r} \geq 1$; and the left-hand side vanishes, if $n_{r}=0$.
Now we are ready to prove Proposition 1.2 given in the introduction.
Proof of Proposition 1.2 By using Lemma 3.1, we can find a series $g(z) \in \mathbb{C}\left[\left[z^{-1}\right]\right]$ such that

\tau_{1} \tau_{2}=-\operatorname{res}_{z=\infty} g(z) \tau_{1}\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} \tag{3.16}
\end{equation*}
$$

Consider the expansion

\log g(z)=: b_{0}+\sum_{k \geq 1} b_{k} z^{-k} \tag{3.17}
\end{equation*}
$$

and denote $Q:=e^{\sum_{k \geq 1} k b_{k} q_{k}}$. By using the identity (3.16) and Lemma 3.3, we have

Q^{-1}\left(\tau_{1}\right) \cdot \tau_{2}=-\operatorname{res}_{z=\infty}\left(Q^{-1} \tau_{1}\right)\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z}=T_{0} \circ Q^{-1}\left(\tau_{1}\right)
$$

The proposition is proved.

Lemma 3.4 Let $Q:=e^{\sum_{k \geq 1} k b_{k} q_{k}}$ denote the multiplication operator. We have

Q \circ T_{0} \circ Q^{-1}\left(s_{\lambda}\right)=\sum_{n \geq 0} h_{n}(\mathbf{b}) T_{n}\left(s_{\lambda}\right) . \tag{3.18}
\end{equation*}
$$

Proof By using Lemma 3.3 and Lemma 3.2 we have

\begin{aligned}
Q \circ T_{0} \circ Q^{-1}\left(s_{\lambda}\right) & =-\operatorname{res}_{z=\infty} e^{\sum_{k \geq 1} b_{k} z^{-k}} s_{\lambda}\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} \\
& =\sum_{n, m \geq 0} h_{n}(\mathbf{b}) h_{m}(\mathbf{q}) z^{m-n} \sum_{k=0}^{\ell(\lambda)} M^{[k]} z^{-k} \\
& =\sum_{n \geq 0} h_{n}(\mathbf{b}) \operatorname{det} M_{n, \lambda_{1}, \ldots, \lambda_{\ell(\lambda)}} .
\end{aligned}
$$

The lemma is proved.
We are now ready to prove Proposition 1.3 ,
Proof of Proposition 1.3 By using Proposition 1.2 and Lemma 3.4, it is easy to see that

\tau_{\mathrm{E}}=\sum_{\lambda \in \mathbb{Y}} \pi_{\lambda} \cdot Q \circ T \circ Q^{-1}\left(s_{\lambda}\right)=\sum_{\lambda \in \mathbb{Y}} \pi_{\lambda} \sum_{n \geq 0} h_{n}(\mathbf{b}) T_{n}\left(s_{\lambda}\right), \tag{3.19}
\end{equation*}
$$

which is nothing but an equivalent form of (1.22). Next we are to show (1.23). It is known [25] that the following identity holds true:

Then we have

Q \circ T_{0} \circ Q^{-1}\left(s_{\lambda}\right) & =\sum_{\nu \in \mathbb{Y}} s_{\nu}(\mathbf{b}) s_{\nu}(\mathbf{q}) T_{0}\left(\sum_{\mu \in \mathbb{Y}} c_{\alpha \mu}^{\beta} s_{\mu}(-\mathbf{b}) s_{\beta}(\mathbf{q})\right) \\
& =\sum_{\substack{\lambda, \mu \in \mathbb{Y} \\
\beta \in \mathbb{Y} \backslash \operatorname{Ker}\left(T_{0}\right)}} c_{\alpha \mu}^{\beta} c_{\nu, T_{0}(\beta)}^{\lambda} s_{\mu}(-\mathbf{b}) s_{\nu}(\mathbf{b}) s_{\lambda}(\mathbf{q}) .
\end{aligned}
$$

Formula (1.23) is then obtained in a similar way with (3.19). The proposition is proved.
For the reader's convenience we provide in below a few Littlewood-Richardson coefficients $c_{\alpha \mu}^{\beta}$ that appear in the above proof:

& s_{(3)} s_{(1,1,1)}=s_{(4,1,1)}+s_{(3,1,1,1)} \\
& s_{(2,1)} s_{(2,1)}=s_{(4,2)}+s_{(4,1,1)}+s_{(3,3)}+2 s_{(3,2,1)}+s_{(3,1,1,1)}+s_{(2,2,2)}+s_{(2,2,1,1)} \\
& s_{(2,1)} s_{(1,1,1)}=s_{(3,2,1)}+s_{(3,1,1,1)}+s_{(2,2,1,1)}+s_{(2,1,1,1,1)} \\
& s_{(1,1,1)} s_{(1,1,1)}=s_{(2,2,2)}+s_{(2,2,1,1)}+s_{(2,1,1,1,1)}+s_{(1,1,1,1,1,1)}
\end{aligned}
$$

For the case of the topological solution to the Burgers-KdV hierarchy, it was conjectured by Witten 31] and proved by Kontsevich the following identity [23]:

\tau_{1}^{\mathrm{WK}}=\exp \left(\sum_{n \geq 1} \sum_{i_{1}, \ldots, i_{n} \geq 0} \frac{1}{n!!} \prod_{k=1}^{n}\left(2 i_{k}+1\right)!!q_{2 i_{k}+1} \int_{\overline{\mathcal{M}}_{g, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}}\right) \tag{3.21}
\end{equation*}
$$

where $\tau_{1}^{\mathrm{WK}}$ is defined by (1.36)-(1.37). The second component $\tau_{2}^{\mathrm{WK}}$ in the tau-vector of the topological solution plays the role of the partition function for the open intersection numbers [28, 10, 11]. From Corollary 1.7 and a straightforward computation, we obtain the first few terms of $\tau_{\mathrm{E}}^{\mathrm{WK}}$ as follows:

& \tau_{\mathrm{E}}^{\mathrm{WK}}=1+\frac{41}{24} s_{(3)}-\frac{5}{24} s_{(2,1)}-\frac{7}{24} s_{(1,1,1)}+\frac{9241}{1152} s_{(6)}-\frac{385}{1152} s_{(5,1)}-\frac{455}{1152} s_{(4,1,1)}+\frac{205}{576} s_{(3,3)} \\
& \quad+\frac{287}{576} s_{(3,2,1)}+\frac{25}{1152} s_{(3,1,1,1)}-\frac{35}{576} s_{(2,2,2)}-\frac{385}{1152} s_{(2,1,1,1,1)}-\frac{455}{1152} s_{(1,1,1,1,1,1)}+\cdots, \tag{3.22}
\end{align*}
$$

which agree with the computations in [22]. We hope that Corollary 1.7 could be helpful in understanding open and closed intersection numbers.

## 4 The extended generalized BGW tau-function

In this section, following [11] and [7] we prove Theorem 1.5. We also prove that the extended generalized BGW tau-function with some particularly chosen value of $C$ is a polynomial.

Let $\left(w^{\Theta(C)}, \rho^{\Theta(C)}\right)$ and $\left(\tau_{1}^{\Theta(C)}, \tau_{2}^{\Theta(C)}\right)$ be defined in Introduction (cf. (1.27)-(1.29)). According to [5], the series $\tau_{1}^{\Theta(C)}$ is also the Sato type tau-function of the solution $\left(w^{\Theta(C)}, \rho^{\Theta(C)}\right)$ for the KdV hierarchy. Therefore, as mentioned in Section 2, the $\psi_{\Theta(C)}:=\psi_{\Theta(C)}(\mathbf{q} ; z)$ and $\psi_{\Theta(C)}^{*}:=$ $\psi_{\Theta(C)}^{*}(\mathbf{q} ; z)$ defined by

$$
\begin{equation*}
\psi_{\Theta(C)}=\frac{\tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\tau_{1}^{\Theta(C)}(\mathbf{q})} e^{\sum_{n \geq 1} q_{n} z^{n}}, \quad \psi_{\Theta(C)}^{*}=\frac{\tau_{1}^{\Theta(C)}\left(\mathbf{q}+\left[z^{-1}\right]\right)}{\tau_{1}^{\Theta(C)}(\mathbf{q})} e^{-\sum_{n \geq 1} q_{n} z^{n}} \tag{4.1}
\end{equation*}
$$

form a pair of wave and dual wave functions of $w^{\Theta(C)}$ for the KdV hierarchy. To proceed we introduce the notations:

$$
\begin{align*}
& K_{\Theta(C)}:=\tau_{1}^{\Theta(C)} \psi_{\Theta(C)}, \quad f_{\Theta(C)}(x, z):=\left.\psi_{\Theta(C)}\right|_{q_{2}=q_{3}=\cdots=0}  \tag{4.2}\\
& K_{\Theta(C)}^{*}:=\tau_{1}^{\Theta(C)} \psi_{\Theta(C)}^{*}, \quad f_{\Theta(C)}^{*}(x, z):=\left.\psi_{\Theta(C)}^{*}\right|_{q_{2}=q_{3}=\cdots=0}  \tag{4.3}\\
& L_{0}^{\mathrm{Ext}}:=\sum_{n \geq 1} n \tilde{q}_{n} \frac{\partial}{\partial q_{n}}+C, \quad \tilde{q}_{n}:=q_{n}-\delta_{n, 1} . \tag{4.4}
\end{align*}
$$

Lemma 4.1 The following formulae hold true:

$$
\begin{align*}
L_{0}^{\mathrm{Ext}} K_{\Theta(C)} & =\left(z \partial_{z}-z\right) K_{\Theta(C)}  \tag{4.5}\\
L_{0}^{\mathrm{Ext}} K_{\Theta(C)}^{*} & =\left(z \partial_{z}+z\right) K_{\Theta(C)}^{*} \tag{4.6}
\end{align*}
$$

Proof Performing a shift $\mathbf{q} \mapsto\left(\mathbf{q}-\left[z^{-1}\right]\right)$ to the identity (1.28), we obtain

$$
\begin{equation*}
\sum_{k \geq 0}\left((2 k+1) \tilde{q}_{2 k+1}-\frac{1}{z^{2 k+1}}\right) \frac{\partial \tau_{1}^{\Theta(C)}}{\partial q_{2 k+1}}\left(\mathbf{q}-\left[z^{-1}\right]\right)+C \tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)=0 . \tag{4.7}
\end{equation*}
$$

Then the left-hand side of (4.5) is equal to

$$
\begin{align*}
& e^{\sum_{n \geq 1} q_{n} z^{n}}\left(\sum_{k \geq 0}(2 k+1) \tilde{q}_{2 k+1} \frac{\partial \tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\partial q_{2 k+1}}+\tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)\left(\sum_{n \geq 1} n \tilde{q}_{n} z^{n}+C\right)\right) \\
& \quad=e^{\sum_{n \geq 1} q_{n} z^{n}} \sum_{k \geq 0} z^{-2 k-1} \frac{\partial \tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\partial q_{2 k+1}}+K_{\Theta(C)} \sum_{n \geq 1} n \tilde{q}_{n} z^{n} \\
& \quad=\left(z \partial_{z}-z\right) K_{\Theta(C)} . \tag{4.8}
\end{align*}
$$

The proof for (4.6) is similar. The lemma is proved.
The next lemma was obtained in [16], and we will provide a new proof of it using the method given in [11].

Lemma 4.2 ([16]) The following formulae are true:

$$
\begin{equation*}
f_{\Theta(C)}=e^{-x z} \sum_{n \geq 0} \frac{\theta_{n}}{z^{n}(1-x)^{n}}, \quad f_{\Theta(C)}^{*}=e^{x z} \sum_{n \geq 0} \frac{(-1)^{n} \theta_{n}}{z^{n}(1-x)^{n}}, \tag{4.9}
\end{equation*}
$$

where $\theta_{n}:=(-1)^{n} \prod_{i=0}^{n-1}\left(C+\frac{i(i+1)}{2}\right) / n!, n \geq 0$.
Proof Setting $q_{2}=q_{3}=\cdots=0$ in (4.5) we have

$$
\begin{equation*}
(x-1) \partial_{x} f_{\Theta(C)}=\left(z \partial_{z}-z\right) f_{\Theta(C)} . \tag{4.10}
\end{equation*}
$$

Then there exists a formal series $\theta(z) \in \mathbb{C}\left[\left[z^{-1}\right]\right]$ such that $f_{\Theta(C)}=e^{-x z} \theta(z(1-x))$. Setting $q_{2}=q_{3}=\cdots=0$ in formula (2.7) we have

$$
\begin{equation*}
\partial_{x}^{2} f_{\Theta(C)}+\left(2 C-z^{2}\right) f_{\Theta(C)}=0 \tag{4.11}
\end{equation*}
$$

It follows that $\theta(z)$ satisfies the ODE:

$$
\begin{equation*}
\left(z^{2} \partial_{z}^{2}-2 z^{2} \partial_{z}+2 C\right) \theta(z)=0 . \tag{4.12}
\end{equation*}
$$

The rest of the proof can be found in [16]. The proof of the second equality is similar.
We are ready to prove Theorem [1.5 using the method of [11] improved in [7.
Proof of Theorem 1.5 Due to Lemma 3.1, there exists a series $g(z)$ of the form (3.1) satisfying

$$
\begin{equation*}
\tau_{2}^{\Theta(C)}=-\operatorname{res}_{z=\infty} g(z) \frac{\tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right)}{\tau_{1}^{\Theta(C)}(\mathbf{q})} e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} . \tag{4.13}
\end{equation*}
$$

Using (1.29) we find $g_{0}=1$. Using Lemma 4.1 we have

$$
\begin{equation*}
L_{0}^{\mathrm{Ext}}\left(\tau_{\mathrm{E}}^{\Theta(C)}\right)=\tau_{1}^{\Theta(C)} \operatorname{res}_{z=\infty}\left(g^{\prime}(z)+g(z)\right) \psi_{\Theta(C)} d z . \tag{4.14}
\end{equation*}
$$

It follows from (1.28), (1.12) and (1.27) that

$$
\begin{equation*}
\left.L_{0}^{\mathrm{Ext}}\left(\tau_{\mathrm{E}}^{\Theta(C)}\right)\right|_{q_{2}=q_{3}=\cdots=0} \equiv 0 \tag{4.15}
\end{equation*}
$$

Thus taking $q_{2}=q_{3}=\cdots=0$ on the both sides of (4.14) we find

$$
\begin{equation*}
\operatorname{res}_{z=\infty}\left(g^{\prime}(z)+g(z)\right) f_{\Theta(C)}(x, z) d z \equiv 0 \tag{4.16}
\end{equation*}
$$

Since $\psi_{\theta(C)}$ satisfies equations (2.8), it follows from (4.18) that

$$
\begin{equation*}
\operatorname{res}_{z=\infty}\left(g^{\prime}(z)+g(z)\right) \psi_{\Theta(C)}(\mathbf{q} ; z) d z \equiv 0 \tag{4.17}
\end{equation*}
$$

Following [7] we employ the bilinear identity (2.9) with $\mathbf{q}=(x, \mathbf{0}), \mathbf{q}^{\prime}=\left(x^{\prime}, \mathbf{0}\right)$, and we find

$$
\begin{equation*}
\operatorname{res}_{z=\infty} f_{\Theta(C)}^{*}\left(x^{\prime}, z\right) f_{\Theta(C)}(x, z) d z \equiv 0 \tag{4.18}
\end{equation*}
$$

Further taking $x^{\prime}=0$ and using Lemma 4.2 we find that

$$
\begin{equation*}
\operatorname{res}_{z=\infty} \theta(-z) f_{\Theta(C)}(x, z) d z \equiv 0 \tag{4.19}
\end{equation*}
$$

Comparing (4.16) and (4.19), and using the uniqueness nature we find that $g(z)$ must satisfy

$$
\begin{equation*}
g^{\prime}(z)+g(z)=\theta(-z) . \tag{4.20}
\end{equation*}
$$

Obviously, solution to (4.20) of the form (3.1) is unique. By solving (4.20) we finally obtain that $g(z)=1+\sum_{n>1} g_{n}^{\Theta(C)} z^{-n}$ with $g_{n}^{\Theta(C)}$ being given by (1.31). The identities (1.32) and (1.33) are proved.

It was shown in [3] that if $C=-m(m+1) / 2$ for some non-negative integer $m$, the generalized BGW tau-function $\tau_{1}^{\Theta(C)}$ is a polynomial. We find in the next proposition that when $m$ is even, the tau-function $\tau_{\mathrm{E}}^{\Theta(C)}$ is also a polynomial.
Proposition 4.3 For $C=-m(m+1) / 2, m \in \mathbb{Z}_{\geq 0}$, if $m$ is even, then $\tau_{\mathrm{E}}^{\Theta(C)}$ is a polynomial. Proof Define $g(z)=\sum_{k \geq 0} g_{k}^{\Theta(C)} z^{-k}$. Using Theorem 1.5 we find

$$
\begin{equation*}
g(z)=\sum_{k=0}^{m-1} \frac{g_{k}^{\Theta(C)}}{z^{k}}+a_{m} \sum_{k \geq m} \frac{(k-1)!}{z^{k}} \tag{4.21}
\end{equation*}
$$

where

$$
\begin{equation*}
a_{m}=\sum_{k=1}^{m} \frac{\prod_{i=0}^{k-1}\left(-\frac{m(m+1)}{2}+\frac{i(i+1)}{2}\right)}{k!(k-1)!} . \tag{4.22}
\end{equation*}
$$

One can show that the numbers $a_{m}$ satisfy

$$
\begin{equation*}
a_{m}=\frac{1}{m!} f^{(m)}(0), \quad f(z):=-z\left(1+z^{2}\right)^{-\frac{3}{2}} . \tag{4.23}
\end{equation*}
$$

Since $m$ is even, we find $a_{m}$ is zero. Then from (4.21) it follows that $g(z)$ is a polynomial in $1 / z$. Combining this with the polynomiality property of the component $\tau_{1}^{\Theta(C)}$, one can see

$$
\begin{equation*}
g(z) \tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right) \in \mathbb{C}[\mathbf{q}]\left[z^{-1}\right] . \tag{4.24}
\end{equation*}
$$

Recall the formula (1.32) and rewrite it into

$$
\begin{equation*}
\tau_{\mathrm{E}}^{\Theta(C)}=-\operatorname{res}_{z=\infty} g(z) \tau_{1}^{\Theta(C)}\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} \tag{4.25}
\end{equation*}
$$

We conclude from (4.24) and (4.25) that $\tau_{\mathrm{E}}^{\Theta(C)}$ is a polynomial.

## A The first few coefficients of $\tau_{\mathrm{E}}^{\Theta(C)}$

$\left.\begin{array}{cc}\hline \lambda & \text { Coefficient of } s_{\lambda} \\ \hline(1) & C \\ (2) & C(C+3) / 2 \\ (1,1) & C(C-1) / 2 \\ (3) & C(C+3)(C+7) / 6 \\ (2,1) & C(C+1)(C-3) / 6 \\ (1,1,1) & C(C+3)(C+9)(C+10) / 24 \\ (4) & C(C+3)\left(C^{2}+7 C-2\right) / 8 \\ (3,1) & C(C+1)(C+3)(C-2) / 8 \\ (2,2) & C(C+1)(C+3)(C-6) / 24 \\ (2,1,1) & C(C+3)(C+10)\left(C^{2}+27 C+186\right) / 120 \\ (1,1,1,1) & C(C+3)(C+10)\left(2 C^{2}-3 C-30\right) / 60 \\ (5) & C^{2}(C+1)(C+3)(C+8) / 24 \\ (4,1) & C(C+1)(C+3)\left(C^{2}+6 C-10\right) / 20 \\ (3,2) & C^{3}(C+1)(C+3) / 24 \\ (3,1,1) & C(C+1)(C+3)\left(2 C^{2}-3 C-30\right) / 60 \\ (2,2,1) & C(C+1)(C+3)(C+6)(C-10) / 120 \\ (2,1,1,1) & C(C+3)(C+10)(C+21)\left(C^{2}+31 C+270\right) / 720 \\ (1,1,1,1,1) & C+3)(C+10)\left(C^{3}+28 C^{2}+201 C-18\right) / 144 \\ (6) & C^{2}(C+1)(C+3)(C+10)(C+11) / 80 \\ (5,1) & C(C+1)(C+3)(C+10)\left(C^{2}+9 C-9\right) / 72 \\ (4,2) & C^{2}(C+1)(C+3)^{2} C(C+10) / 144 \\ (4,1,1) & C^{2}(C+1)(C+3)\left(4 C^{2}+34 C+15\right) / 180 \\ (3,3) & C(C+1)(C+3)\left(C^{3}+7 C^{2}-15 C-90\right) / 72 \\ (3,2,1) & C^{2}(C+1)(C+3)\left(C^{2}+C+6\right) / 144 \\ (3,1,1,1) & C(C+1)(C+3)(C+6)(C+10)(C-15) / 720 \\ (2,2,2) & C+3)\left(C^{2}+C-10\right) / 144 \\ (2,2,1,1) & (2,1,1,1,1)\end{array}(C+6)\left(C^{2}-5 C-30\right) / 144\right)$

## B A novel proof of a result of Alexandrov

In this section, we give a new proof of a result of Alexandrov [2].
Let $\mathbb{C}\left(\left(z^{-1}\right)\right)$ be the linear space of formal series with finitely many terms of positive powers, and consider the Sato Grassmannian $G M$ as defined originally in [29]. A point $W \in G M$ is
a subspace of $\mathbb{C}\left(\left(z^{-1}\right)\right)$ which can be written as a linear span of a set of basis vectors. A particular useful choice of basis of $W$ is of the following form:

$$
\begin{equation*}
W=\operatorname{Span}_{\mathbb{C}}\left\{z^{l}+\sum_{k \geq 0} A_{k, l} z^{-k-1}\right\}_{l \geq 0} \tag{B.1}
\end{equation*}
$$

Here the collection $\left(A_{k, l}\right)_{k, l \geq 0}$ is called the affine coordinate of $W$. Note that such a choice is not always possible: existence of basis of form (B.1) characterizes the big cell (See 30 for the details). Given a point $W \in G M$, the affine coordinate, if exist, must be unique.

Define a family of numbers as follows:

$$
\begin{equation*}
\pi_{\left(m_{1}, \ldots, m_{r} \mid n_{1}, \ldots, n_{r}\right)}(W):=(-1)^{\sum_{i=1}^{r} n_{i}} \operatorname{det}\left(A_{m_{i}, n_{j}}\right)_{1 \leq i, j \leq r} \tag{B.2}
\end{equation*}
$$

Then according to [18, 4], the formal series defined by

$$
\begin{equation*}
\tau_{\mathrm{w}}:=\sum_{\lambda \in \mathbb{Y}} \pi_{\lambda}(W) s_{\lambda} \tag{B.3}
\end{equation*}
$$

is a Sato type tau-function of the KP hierarchy, i.e., it satisfies the following bilinear identity:

$$
\begin{equation*}
\operatorname{res}_{z=\infty} \tau_{\mathrm{w}}\left(\mathbf{q}-\left[z^{-1}\right]\right) \tau_{\mathrm{w}}\left(\mathbf{q}^{\prime}+\left[z^{-1}\right]\right) e^{\sum_{n \geq 1}\left(q_{n}-q_{n}^{\prime}\right) z^{n}} d z=0 \tag{B.4}
\end{equation*}
$$

Theorem B. 1 ([2]) If $\tau$ is a Sato type tau-function of the KP hierarchy, so is

$$
\begin{equation*}
\tau^{\prime}:=-\operatorname{res}_{z=\infty} f(z) \tau\left(\mathbf{q}-\left[z^{-1}\right]\right) e^{\sum_{n \geq 1} q_{n} z^{n}} \frac{d z}{z} \tag{B.5}
\end{equation*}
$$

where $f(z)=1+\sum_{n \geq 1} f_{i} z^{-n} \in \mathbb{C}\left[\left[z^{-1}\right]\right]$.
Proof By using Lemma 3.3, we can rewrite (B.5) as

$$
\begin{equation*}
\tau^{\prime}=Q \circ T_{0} \circ Q^{-1}(\tau), \tag{B.6}
\end{equation*}
$$

where $Q=e^{-\sum_{k \geq 1} k b_{k} q_{k}}$ denotes the multiplication operator with $b_{1}, b_{2}, \ldots$ being numbers such that $\log f(z)=\sum_{k \geq 1} b_{k} z^{-k}$.

Let $\tau$ be the Sato type tau-function given by ( (B.3). We first show $T_{0}(\tau)$ is a Sato type tau-function. Define a point in $G M$ as

$$
\begin{equation*}
W^{\prime}:=\operatorname{Span}_{\mathbb{C}}\left\{z^{l}-\sum_{k \geq 0} A_{k+1, l-1} z^{-k-1}\right\}_{l \geq 1} \tag{B.7}
\end{equation*}
$$

It is obvious that the affine coordinates $\left(A_{k, l}^{\prime}\right)_{k, l \geq 0}$ of $W^{\prime}$ are given by

$$
\left(A_{k, l}^{\prime}\right)_{k, l \geq 0}=\left(\begin{array}{cccc}
\vdots & \vdots & \vdots & \vdots  \tag{B.8}\\
0 & -A_{20} & -A_{21} & \cdots \\
0 & -A_{10} & -A_{11} & \cdots
\end{array}\right)
$$

Recall the expression (1.18) of $T_{0}$. Then by using (B.3) and observing that

$$
\operatorname{det}\left(A_{m_{i}, n_{j}}^{\prime}\right)_{1 \leq i, j \leq r}=\left\{\begin{array}{cl}
(-1)^{r} \operatorname{det}\left(A_{m_{i}+1, n_{j}-1}\right)_{1 \leq i, j \leq r}, & n_{r} \geq 1,  \tag{B.9}\\
0, & n_{r}=0,
\end{array}\right.
$$

one can obtain that

$$
T_{0}(\tau)=\tau_{\mathrm{w}^{\prime}} .
$$

Hence $T_{0}(\tau)$ is Sato type tau-function of the KP hierarchy. In other words, the transformation $T_{0}$ has the property that it maps an arbitrary Sato type tau-function of the KP hierarchy to another one. Obviously, the operator $Q$ also has this property. Combining with (B.6), we therefore conclude that the formal series $\tau^{\prime}$ is also a Sato type tau-function. The theorem is proved.

Let us give a direct consequence of Proposition 1.3 and Corollary 1.4. For arbitrary numbers $A_{m, n}, m, n \geq 0$ and $g_{k}, k \geq 0$ with $g_{0}=1$, define $c_{m, n}$ by (1.25) and $\pi_{\lambda}$ by (1.16). Then for any partition $\lambda=\left(m_{1}, \ldots m_{r} \mid n_{1}, \ldots, n_{r}\right)$, the following identity holds true:

$$
\begin{equation*}
\operatorname{det}\left(c_{m_{i}, n_{j}}\right)_{1 \leq i, j \leq r}=\sum_{\substack{0 \leq k \leq|\lambda| \\ \mu \in T_{k}^{-1}(\lambda)}} g_{k} \pi_{\mu}=\sum_{\substack{\alpha, \mu, \nu \in \mathbb{Y} \\ \beta \in \mathbb{Y} \backslash \operatorname{Ker}\left(T_{0}\right)}} \pi_{\alpha} c_{\mu \alpha}^{\beta} c_{\nu, T_{0}(\beta)}^{\lambda} s_{\mu}(-\mathbf{b}) s_{\nu}(\mathbf{b}), \tag{B.10}
\end{equation*}
$$

where $\mathbf{b}:=\left(b_{1}, b_{2}, \ldots\right)$ are defined via $e^{\sum_{k \geq 1} b_{k} z^{-k}}=\sum_{n \geq 0} g_{n} z^{-n}$.
