# ALGEBRAIC CURVES ADMITTING INNER AND OUTER GALOIS POINTS

#### Abstract

There are two purposes in this article. One is to present a criterion for the existence of a birational embedding into a projective plane with inner and outer Galois points for algebraic curves. Another is to classify plane curves of degree $d$ admitting an inner Galois point $P$ and an outer Galois point $Q$ with $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$ or $G_{P} \ltimes G_{Q}$, under the assumption that the characteristic $p$ is zero or $p$ does not divide $d-1$.


## 1. Introduction

In 1996, Hisao Yoshihara introduced the notion of a Galois point for a plane curve $C \subset \mathbb{P}^{2}$ over an algebraically closed field $k$ of characteristic $p \geq 0$ (11, 11, 13]): a point $P \in \mathbb{P}^{2}$ is called a Galois point, if the extension $k(C) / \pi_{P}^{*} k\left(\mathbb{P}^{1}\right)$ of function fields induced by the projection $\pi_{P}$ from $P$ is a Galois extension. The associated Galois group is denoted by $G_{P}$. Furthermore, a Galois point $P$ is said to be inner (resp. outer), if $P \in C \backslash \operatorname{Sing}(C)$ (resp. if $P \in \mathbb{P}^{2} \backslash C$ ). In this article, we investigate (possibly singular) plane curves $C$ in the case where there exist an inner Galois point $P$ and an outer Galois point $Q$.

Since we do not assume that the smoothness of $C$, sometimes we start with a (reduced, irreducible) smooth projective curve $X$. In this case, $C$ is the image of some morphism $\varphi: X \rightarrow \mathbb{P}^{2}$, which is birational onto its image.

In [3] the present author presented a criterion for the existence of a birational embedding with two Galois points $P$ and $Q$. In this criterion, it is assumed that both points $P$ and $Q$ are inner, or outer. In this article, we consider the case where $P$ is inner and $Q$ is outer.

Theorem 1. Let $G_{1}$ and $G_{2}$ be finite subgroups of $\operatorname{Aut}(X)$, and let $P \in X$. Then the two conditions

(a) $X / G_{1} \cong \mathbb{P}^{1}$ and $X / G_{2} \cong \mathbb{P}^{1}$, and
(b) there exists $\eta \in G_{2}$ such that $P+\sum_{\sigma \in G_{1}} \sigma(\eta(P))=\sum_{\tau \in G_{2}} \tau(P)$
are satisfied, if and only if there exists a birational embedding $\varphi: X \rightarrow \mathbb{P}^{2}$ of degree $\left|G_{2}\right|$ and an outer Galois point $Q \in \mathbb{P}^{2} \backslash \varphi(X)$ exists for $\varphi(X)$ such that $\varphi(P)$ is an inner Galois point, and $G_{\varphi(P)}=G_{1}$ and $G_{Q}=G_{2}$.

In [6], the present author and Speziali classified plane curves admitting two outer Galois points $P_{1}$ and $P_{2}$ with $G_{P_{1}} G_{P_{2}}=G_{P_{1}} \rtimes G_{P_{2}}$. The second purpose in this article is to classify $C$ admitting an inner Galois point $P$ and an outer Galois point $Q$ with $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$ or $G_{P} \ltimes G_{Q}$. The case where $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$ is determined as follows.

Theorem 2. Let $C$ be a plane curve of degree $d \geq 3$. Assume that $p=0$ or $d-1$ is prime to $p$. Then the following conditions are equivalent.
(a) There exist an inner Galois point $P$ and an outer Galois point $Q$ such that $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$;
(b) There exist an inner Galois point $P$ and an outer Galois point $Q$ such that $G_{P} G_{Q}=G_{P} \times G_{Q}$;
(c) $C$ is in one of the following cases:
$-p=0$ or $d$ is prime to $p$, and $C$ is projectively equivalent to the plane curve defined by $x^{d-1}+y^{d}+c=0$, where $c=0$ or 1 ;
$-p>0, d$ is divisible by $p$, and $C$ is projectively equivalent to the plane curve defined by $x^{d-1}+\left(\sum_{m \mid p^{i}-1} \alpha_{i} y^{p^{i}}\right)^{m}+c=0$, where $d=p^{e} m$, $m$ is not divisible by $p, \alpha_{e} \alpha_{0} \neq 0$, and $c=0$ or 1 .

On the other hand, there exist examples of plane curves such that $G_{P} G_{Q}=$ $G_{P} \ltimes G_{Q}$ and $G_{P} G_{Q} \neq G_{P} \times G_{Q}$. In this case, such curves are classified as follows.

Theorem 3. Let $C$ be a plane curve of degree $d \geq 3$. Assume that $p=0$ or $d(d-1)$ is prime to $p$. Then there exist an inner Galois point $P$ and an outer Galois point $Q$ such that $G_{P} G_{Q}=G_{P} \ltimes G_{Q}$ and $G_{P} G_{Q} \neq G_{P} \times G_{Q}$, if and only if $C$ is in one of the following cases:
(a) $p \neq 2,3, d=3$ and $C$ is projectively equivalent to the curve defined by

$$
y^{2} x+(x+1)^{2}(x-8)=0 .
$$

(b) $p \neq 2,3, d=4$ and $C$ is projectively equivalent to the curve defined by

$$
y^{3} x+(x+1)^{3}(x+9)=0
$$

For the proof of the if-part of Theorem 3, we prove the existence of triples $\left(G_{1}, G_{2}, P\right)$ with conditions (a) and (b) in Theorem 11 such that $G_{1} G_{2} \cong S_{3}$ or $A_{4}$, where $S_{3}$ (resp. $A_{4}$ ) is the symmetric (resp. alternative) group of degree three (resp. of degree four). For the case where $d$ is divisible by $p$, the following holds.

Proposition 1. Let $p>0$ and let $d$ be divisible by $p$. Then there exist an inner Galois point $P$ and an outer Galois point $Q$ such that $G_{P} G_{Q}=G_{P} \ltimes G_{Q}, G_{P} G_{Q} \neq$ $G_{P} \times G_{Q}$ and $\overline{P Q}$ is not the tangent line at $P$, if and only if $d$ is a power of $p$, and $C$ is projectively equivalent to the curve defined by

$$
y^{d-1} x+(x+1)^{d}=0
$$

## 2. Proof of Theorem 1

Proof of Theorem 1. We consider the if-part. Since $\varphi(P)$ and $Q$ are Galois points with $G_{\varphi(P)}=G_{1}$ and $G_{Q}=G_{2}$, it follows that fixed fields $k(X)^{G_{\varphi(P)}}=k(X)^{G_{1}}$ and $k(X)^{G_{Q}}=k(X)^{G_{2}}$ are rational. Condition (a) is satisfied. Let $\ell$ be the line passing through points $\varphi(P)$ and $Q$, and let $D=\varphi^{*} \ell$. Since $Q$ is an outer Galois point and $G_{Q}=G_{2}$,

$$
D=\left(\pi_{Q} \circ \varphi\right)^{*}\left(\pi_{Q}(\varphi(P))\right)=\sum_{\tau \in G_{2}} \tau(P)
$$

(see [12, III.7.1, III.7.2, III.8.2]). Let $\eta \in G_{2} \backslash\{1\}$. Then $\varphi(\eta(P)) \in \ell$. To prove that condition (b) is satisfied, we would like to prove that

$$
D-P=\sum_{\sigma \in G_{1}} \sigma(\eta(P))
$$

Assume that $\eta(P) \neq P$. Then $\varphi(\eta(P)) \in \ell \backslash\{\varphi(P)\}$. Since $\varphi(P)$ is an inner Galois point and $G_{\varphi(P)}=G_{1}$, it follows that

$$
D-P=\left(\pi_{\varphi(P)} \circ \varphi\right)^{*}\left(\pi_{\varphi(P)} \circ \varphi(\eta(P))\right)=\sum_{\sigma \in G_{1}} \sigma(\eta(P))
$$

The claim follows. Assume that $\eta(P)=P$. Then $\ell$ is the tangent line at $\varphi(P)$. Since $\varphi(P)$ is an inner Galois point, it follows that $P \in \operatorname{supp}\left(\pi_{\varphi(P)} \circ \varphi\right)^{*}\left(\pi_{\varphi(P)} \circ \varphi(P)\right)$ and

$$
D-P=\left(\pi_{\varphi(P)} \circ \varphi\right)^{*}\left(\pi_{\varphi(P)} \circ \varphi(P)\right)=\sum_{\sigma \in G_{1}} \sigma(P) .
$$

It follows from the condition $P=\eta(P)$ that the claim follows.

We consider the only-if part. Let $\eta \in G_{2}$ be an automorphism as in condition (b). By condition (a), there exists a function $f \in k(X)$ such that

$$
k(X)^{G_{1}}=k(f),(f)_{\infty}=\sum_{\sigma \in G_{1}} \sigma(\eta(P))
$$

(see [12, III.7.1, III.7.2, III.8.2]). Similarly, there exists $g \in k(X)$ such that

$$
k(X)^{G_{2}}=k(g),(g)_{\infty}=\sum_{\tau \in G_{2}} \tau(P) .
$$

Considering condition (b), we take a divisor

$$
D:=P+\sum_{\sigma \in G_{1}} \sigma(\eta(P))=\sum_{\tau \in G_{2}} \tau(P) .
$$

Then $f, g \in \mathcal{L}(D)$ and the sublinear system of $|D|$ corresponding to a linear space $\langle f, g, 1\rangle$ is base-point-free. Since orders $\left|G_{1}\right|$ and $\left|G_{2}\right|$ are coprime, it follows that $G_{1} \cap G_{2}=\{1\}$. By this condition, the induced morphism

$$
\varphi: X \rightarrow \mathbb{P}^{2} ;(f: g: 1)
$$

is birational onto its image (see [3, Proposition 1]), and of degree $\left|G_{2}\right|$. Then the projection from the point $\varphi(P)=(0: 1: 0)$ coincides with the morphism $(f: 1)$ and the projection from the point $Q:=(1: 0: 0)$ coincides with the morphism $(g: 1)$. Therefore, $\varphi(P)$ is an inner Galois point with $G_{\varphi(P)}=G_{1}$ and $Q$ is an outer Galois point with $G_{Q}=G_{2}$.

## 3. Proof of Theorem 2

Let $C \subset \mathbb{P}^{2}$ be an irreducible curve of degree $d \geq 3$, and let $\varphi: X \rightarrow C$ be the normalization.

Lemma 1. Let $P \in C$ be an inner Galois point, let $Q \in \mathbb{P}^{2} \backslash C$ be an outer Galois point and let $\ell$ be the line passing through $P$ and $Q$. Then the following hold.
(a) The number of points of $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is 1 or $d$.
(b) If $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$ or $G_{P} \ltimes G_{Q}$, then $G_{P}$ fixes $P$. In particular, if $\sigma \in$ $G_{P} \backslash\{1\}$ fixes a point $R \in \operatorname{supp}\left(\varphi^{*} \ell\right)$, then $R=P$.
(c) If $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$, then $\varphi^{*} \ell=d P$.

Proof. We consider assertion (a). Let

$$
\varphi^{*} \ell=\sum_{R \in \operatorname{supp}\left(\varphi^{*} \ell\right)} n(R) R
$$

Since $Q$ is an outer Galois point and $\ell \ni R$, it follows from [12, III.7.2] that $n(R)=$ $n\left(R^{\prime}\right)$ for any $R, R^{\prime} \in \operatorname{supp}\left(\varphi^{*} \ell\right)$. If $\ell$ is not a tangent line at $P$, then $n(R)=n(P)=$ 1. This implies that the number of points of $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is equal to $d$. Assume that $\ell$ is the tangent line at $P$. Then the divisor

$$
\varphi^{*} \ell-P=(n(P)-1) P+\sum_{R \in \operatorname{supp}\left(\varphi^{*} \ell\right), \varphi(R) \neq P} n(R) R
$$

coincides with $\left(\pi_{P} \circ \varphi\right)^{*}\left(\pi_{P}(P)\right)$. Assume that $R \in \operatorname{supp}\left(\varphi^{*} \ell\right)$ with $\varphi(R) \neq P$ exists. Since $P$ is a Galois point, it follows that $n(R)=n(P)-1$. This is a contradiction. Therefore, in this case, $\varphi^{*} \ell=d P$.

We consider (b). By (a), the number of points of $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is 1 or $d$. For the former case, it follows from [12, III.8.2] that the assertion holds. We can assume that $\operatorname{supp}\left(\varphi^{*} \ell\right)$ consists of $d$ points. Let $\sigma \in G_{P} \backslash\{1\}$. By the assumption, there exist $\sigma^{\prime} \in$ $G_{P} \backslash\{1\}$ and $\tau, \tau^{\prime} \in G_{Q} \backslash\{1\}$ such that $\tau \sigma=\sigma^{\prime} \tau^{\prime}$. Then $\tau \sigma(P)=\sigma^{\prime} \tau^{\prime}(P) \in \varphi^{-1}(\ell)$. Since $\tau^{-1}\left(\varphi^{-1}(\ell)\right) \subset \varphi^{-1}(\ell)$, it follows that $\sigma(P) \in T_{P} C \cap \ell=\{P\}$. Therefore, $\sigma(P)=P$ follows.

We consider (c). Let $\tau \in G_{Q}$ and let $\sigma \in G_{P} \backslash\{1\}$. By (b), $\tau \sigma \tau^{-1}$ fixes $\tau(P)$. Since $G_{P} G_{Q}=G_{P} \rtimes G_{Q}, \tau \sigma \tau^{-1} \in G_{P} \backslash\{1\}$. By $(\mathrm{b}), \tau(P)=P$. It follows from [12, III.8.2] that the ramification index at $P$ for $\pi_{Q}$ is $d$. The assertion follows.

Proof of Theorem [2. We prove $(\mathrm{a}) \Rightarrow(\mathrm{b})$. By condition (a) and Lemma 1, the group $G_{P} \rtimes G_{Q}$ fixes $P$. It follows from [9, Lemma 11.44] that if $p=0$ or $d(d-1)$ is prime to $p$, then $G_{P} \rtimes G_{Q}$ is a cyclic group. Therefore, $G_{P} \rtimes G_{Q}=G_{P} \times G_{Q}$. Assume that $p>0$ and $p$ divides $d$. Let $d=p^{e} m$, where $m$ is not divisible by $p$. It follows from [9, Lemma 11.44] that $G_{P} \cong \mathbb{Z} /(d-1) \mathbb{Z}$ and there exist subgroups $N, H$ such that $G_{Q}=N \rtimes H,|N|=p^{e}$ and $H \cong(\mathbb{Z} / m \mathbb{Z})$. Since $\left|G_{P} \rtimes G_{Q}\right|=(d-1) p^{e} m$, the subgroup $N$ is a normal subgroup of $G_{P} \rtimes G_{Q}$, and hence $G_{P} \rtimes N=G_{P} \times N$. Since $\left|G_{P} \rtimes H\right|=(d-1) m$ is not divisible by $p$, the group $G_{P} \rtimes H$ is a cyclic group. Therefore, $G_{P} \rtimes H=G_{P} \times H$. As a consequence, $G_{P} G_{Q}=G_{P} \times G_{Q}$ follows.

We prove (b) $\Rightarrow$ (c). By assertion (b) in Lemma 1, $\varphi^{*} T_{P} C=d P$. By the assumption, $G_{Q}$ acts on the subfield $k(X)^{G_{P}}$, which is rational. Assume that $p=0$ or $d(d-1)$ is prime to $p$. Since $G_{Q}$ is totally ramified at $\pi_{P}(P)$ and $d$ is prime to $p$, it follows that $G_{Q}$ is a cyclic group and there exists a ramification point $R \in X / G_{P}$ different from $\pi_{P}(P)$ (see, for example, [9, Theorem 11.91]). The line corresponding to $R$ is denoted by $\ell_{Q}$. By the assumption that $p=0$ or $d-1$ is prime to $p$, a similar argument can be applied to the morphism $X \rightarrow X / G_{Q}$. It is inferred that $G_{P}$ is a
cyclic group and there exists a ramification point $S \in X / G_{Q}$ different from $\pi_{Q}(P)$. The line corresponding to $S$ is denoted by $\ell_{P}$. The linear system corresponding to $\varphi: X \rightarrow C \subset \mathbb{P}^{2}$ is determined by three lines $\ell, \ell_{Q}$ and $\ell_{P}$. For a suitable system of coordinates, we can assume that such lines are defined by $Z=0, Y=0$ and $X=0$, respectively. Then the covering maps $X \rightarrow X / G_{P}$ and $X / G_{P} \rightarrow X /\left\langle G_{P}, G_{Q}\right\rangle$ are represented by $(X: Y: Z) \mapsto(Y: Z)$ and $(Y: Z) \mapsto\left(Y^{d}: Z^{d}\right)$. When we represent the covering map $X \rightarrow X / G_{Q}$ by $(X: Y: Z) \mapsto(X: Z)$, we infer that the covering $\operatorname{map} X / G_{Q} \rightarrow X /\left\langle G_{Q}, G_{P}\right\rangle$ is represented by $(X: Z) \mapsto\left(a X^{d-1}+b Z^{d-1}: Z^{d-1}\right)$ for some $a, b \in k$, by considering the branch points of the covering map $X \rightarrow$ $X /\left\langle G_{P}, G_{Q}\right\rangle$. Therefore, $y^{d}=a x^{d-1}+b$ holds in $k(X)$. This gives the defining equation of $C$. For a suitable system of coordinates, we can assume that $a=-1$ and $b \in\{-1,0\}$.

Assume that $p>0$ and $d$ is divisible by $p$. Let $d=p^{e} m$, where $m$ is not divisible by $p$. Since $G_{Q}$ is totally ramified at $\pi_{P}(P)$, it follows that $m$ divides $p^{e}-1$ and there exist subgroups $N, H$ such that $G_{Q}=N \rtimes H, N \cong(\mathbb{Z} / p \mathbb{Z})^{\oplus e}$ and $H \cong \mathbb{Z} / m \mathbb{Z}$ (see, for example, [9, Theorem 11.91]). Then there exists a ramification point $R \in X / G_{P}$ different from $\pi_{P}(P)$. The line corresponding to $R$ is denoted by $\ell_{Q}$. Considering the assumption that $d-1$ is prime to $p$, we infer that $G_{P}$ is a cyclic group and there exists a ramification point $S \in X / G_{Q}$ different from $\pi_{Q}(P)$. The line corresponding to $S$ is denoted by $\ell_{P}$. The linear system corresponding to $\varphi: X \rightarrow C \subset \mathbb{P}^{2}$ is determined by three lines $\ell, \ell_{Q}$ and $\ell_{P}$. For a suitable system of coordinates, we can assume that such lines are defined by $Z=0, Y=0$ and $X=0$, respectively. According to Lemma 2 below, the covering maps $X \rightarrow X / G_{P}$ and $X / G_{P} \rightarrow X /\left\langle G_{P}, G_{Q}\right\rangle$ are represented by $(X: Y: Z) \mapsto(Y: Z)$ and $(Y: Z) \mapsto\left(f(Y / Z) Z^{d}: Z^{d}\right)$ for a polynomial

$$
f(y)=\left(\sum_{m \mid p^{i}-1} \alpha_{i} y^{p^{i}}\right)^{m}
$$

where $\alpha_{e} \ldots, \alpha_{0} \in k$ and $\alpha_{e} \alpha_{0} \neq 0$. When we represent the covering map $X \rightarrow$ $X / G_{Q}$ by $(X: Y: Z) \mapsto(X: Z)$, we infer that the covering map $X / G_{Q} \rightarrow$ $X /\left\langle G_{Q}, G_{P}\right\rangle$ is represented by $(X: Z) \mapsto\left(a X^{d-1}+b Z^{d-1}: Z^{d-1}\right)$ for some $a, b \in k$, by considering the branch points of the covering map $X \rightarrow X /\left\langle G_{P}, G_{Q}\right\rangle$. Therefore, $\left(\sum_{m \mid p^{i}-1} \alpha_{i} y^{p^{i}}\right)^{m}=a x^{d-1}+b$ holds in $k(X)$. This gives the defining equation of $C$. For a suitable system of coordinates, we can assume that $a=-1$ and $b \in$ $\{-1,0\}$.

Lemma 2. Let $p>0$, $e>0, m \mid p^{e}-1$ and let $\psi: \mathbb{P}^{1} \rightarrow \mathbb{P}^{1}$ be a Galois covering of degree $d$ such that the Galois group $G$ is described as $G=N \rtimes H$ for a p-subgroup $N$ of order $p^{e}$ and a cyclic group $H$ of order $m$. Assume that $\psi(1: 0)=(1: 0)$ and $\psi(0: 1)=(0: 1)$. If $G$ fixes $(1: 0)$ and $H$ fixes $(0: 1)$, then $\psi(Y: Z)=$ $\left(f(Y / Z) Y^{d}: Z^{d}\right)$ for some polynomial

$$
f(y)=c\left(\sum_{m \mid p^{i}-1} \alpha_{i} y^{p^{i}}\right)^{m}
$$

where $\alpha_{e}, \ldots, \alpha_{0}, c \in k$ with $\alpha_{e} \alpha_{0} \neq 0$.
Proof. The covering $\psi$ is the composite map of the Galois coverings $\psi_{1}: \mathbb{P}^{1} \rightarrow \mathbb{P}^{1} / N$ and $\psi_{2}: \mathbb{P}^{1} / N \rightarrow \mathbb{P}^{1} /(G / N)$, where $G / N \cong H$. We can assume that $\psi_{1}(1: 0)=$ $(1: 0)$ and $\psi_{1}(0: 1)=(0: 1)$. Since $N$ fixes $(1: 0)$ and is of degree $p^{e}, \psi_{1}=$ $\left(g(Y / Z) Z^{p^{e}}: Z^{p^{e}}\right)$ for some polynomial $g(y)$ and there exists an additive subgroup $S \subset k$ such that $N=\{(Y: Z) \mapsto(Y+\alpha Z: Z) \mid \alpha \in S\}$. It follows from the assumption $\psi_{1}(0: 1)=(0: 1)$ that $g(0)=0$. Since $g(y)$ is invariant under the action of $N$, it follows from [8, Proposition 1.1.5 and Theorem 1.2.1] that

$$
g(y)=\alpha_{e} y^{p^{e}}+\cdots+\alpha_{1} y^{p}+\alpha_{0} y
$$

for some $\alpha_{e}, \ldots, \alpha_{0} \in k$ with $\alpha_{e} \alpha_{0} \neq 0$. Since the cyclic covering $\psi_{2}$ is ramified at points $(1: 0)$ and $(0: 1), \psi_{2}(Y: Z)=\left(c Y^{m}: Z^{m}\right)$ for some $c \in k$. Then $\psi=\left(c(g(y))^{m}: 1\right)$. Let $\zeta$ be a primitive $m$-th root of unity. Since $m \mid p^{e}-1$, it follows that $g(\zeta y)=\zeta g(y)$. Then $\alpha_{i} \neq 0$ implies that $(\zeta)^{p^{i}}=\zeta$. We obtain the required form.

Remark 1. The curves defined by $x^{d-1}+y^{d}+1=0$ or $x^{d-1}+\left(\sum_{m \mid p^{i}-1} \alpha_{i} y^{p^{i}}\right)^{m}+1=$ 0 are smooth. For these curves, points $(1: 0: 0)$ and $(0: 1: 0)$ are all Galois points. This was proved in [2, Theorem 3].

For the curve $x^{d-1}+y^{d}=0$, the same holds. It is not difficult to prove it, since $(0: 0: 1)$ is a cusp and $(1: 0: 0)$ is a unique total inflection point.

Remark 2. (1) When $p>0$ and $d-1$ is a power of $p, G_{P} G_{Q}=G_{P} \rtimes G_{Q}$ does not imply $G_{P} G_{Q}=G_{P} \times G_{Q}$. For (the plane model of) the GiuliettiKorchmáros curve

$$
x^{q^{3}}+x-\left(x^{q}+x\right)^{q^{2}-q+1}-y^{q^{3}+1}=0
$$

(see [7]), where $q$ is a power of $p, P=(1: 0: 0)$ is an inner Galois point and $Q=(0: 1: 0)$ is an outer Galois point (5]). However, $G_{Q}$ is not a normal subgroup of $G_{P} G_{Q}=G_{P} \rtimes G_{Q}$.
(2) Assume that $p>0$ and $p$ divides $d-1$. In this case also, we can prove that $G_{Q} \cong \mathbb{Z} / d \mathbb{Z}$ and the defining equation of $C$ is of the form $y^{d}+h(x)=0$, where $h(x)$ is a polynomial of degree at most $d$, up to a projective equivalence.

## 4. Proof of Theorem 3

In this section, we consider plane curves admitting an inner Galois point $P$ and an outer Galois point $Q$ with $G_{P} G_{Q}=G_{P} \ltimes G_{Q}$ and $G_{P} G_{Q} \neq G_{P} \times G_{Q}$.

Lemma 3. If $d(d-1)$ is prime to $p$, then the number of points of $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is $d$.
Proof. By Lemma 1 (a), the number of points of $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is 1 or $d$. Assume the former. Note that $G_{P} \ltimes G_{Q}$ fixes $P$. It follows from the assumption on the degree and [9, Lemma 11.44] that $G_{P} \ltimes G_{Q}$ is a cyclic group. This implies that $G_{P} G_{Q}=G_{P} \times G_{Q}$. This is a contradiction.

Hereafter, we assume that $\operatorname{supp}\left(\varphi^{*} \ell\right)$ consists of $d$ points.
Lemma 4. For any $\sigma \in G_{P} \backslash\{1\}$ and $\tau \in G_{Q} \backslash\{1\}$, $\sigma \tau \neq \tau \sigma$.
Proof. Assume that $\sigma \tau=\tau \sigma$. By Lemma (b), it follows that

$$
\sigma \tau(P)=\tau \sigma(P)=\tau(P)
$$

If $\tau(P) \neq P$, then by Lemma ${ }^{1}(\mathrm{~b}), \sigma(\tau(P)) \neq \tau(P)$. Therefore, $\tau(P)=P$. Since $\operatorname{supp}\left(\varphi^{*} \ell\right)$ consists of $d$ points, it follows that $\tau=1$. This is a contradiction.

We assume that $d-1$ is prime to $p$. In this case, the covering map $X / G_{Q} \rightarrow$ $X / G_{P} G_{Q}$ is tame and totally ramified at $\pi_{Q}(P)$. Similarly to the proof of Theorem 2, it follows that $G_{P}$ has an iclusion $G_{P} \hookrightarrow P G L(3, k), G_{P}$ is a cyclic group of order $d-1$, and there exists a line $\ell_{P} \subset \mathbb{P}^{2} \backslash\{P\}$ with $\ell_{P} \ni Q$ such that

$$
\ell_{P} \cup\{P\}=\left\{R \in \mathbb{P}^{2} \mid \sigma(R)=R \text { for all } \sigma \in G_{P}\right\} .
$$

For a suitable system of coordinates, $P=(0: 1: 0), Q=(1: 0: 0)$, lines $\ell_{P}$ and $T_{P} C$ are defined by $Y=0$ and $X=0$ respectively, and $C$ is defined by

$$
y^{d-1} x+g(x)=0,
$$

where $g(x)$ is a polynomial of degree $d$.

Lemma 5. The number of points of $(C \backslash \operatorname{Sing}(C)) \cap \ell_{P}$ is zero or one.
Proof. Assume that there exist two different smooth points $R_{1}$ and $R_{2} \in \ell_{P}$. Then there exists $\tau \in G_{Q} \backslash\{1\}$ such that $\tau\left(R_{1}\right)=R_{2}$. Let $\sigma \in G_{P} \backslash\{1\}$. Then

$$
\tau^{-1} \sigma^{-1} \tau \sigma\left(R_{1}\right)=\tau^{-1} \sigma^{-1} \tau\left(R_{1}\right)=\tau^{-1} \sigma^{-1}\left(R_{2}\right)=\tau^{-1}\left(R_{2}\right)=R_{1}
$$

Note that $\sigma^{-1} \tau \sigma \in G_{Q}$, since $G_{P} G_{Q}=G_{P} \ltimes G_{Q}$. Since $\pi_{Q}$ is not ramified at $R_{1}$, $\tau^{-1} \sigma^{-1} \tau \sigma=1$. Therefore, $\tau \sigma=\sigma \tau$. This is a contradiction to Lemma 4.

Lemma 6. Assume that $d \geq 4$ and there exists a ramification point $S \in C \backslash \ell_{P}$ of index $m \geq 2$ for $\pi_{Q}$. Let $n$ be the number of points of $C \cap \ell_{P}$. Then the following holds.
(a) If $d \geq 5$, then $n \geq \frac{m-1}{m} d$.
(b) $m=2$.
(c) There does not exist a point $R \in C \cap \ell_{P}$ such that the multiplicity of $R$ is two.

Proof. We consider (a). On the line $\overline{Q S}$, there exist $d / m$ ramification points of index $m$. Since any automorphism in $G_{P}$ is a linear transformation, fixes $Q$ and does not fix any point of $C \cap \overline{Q S}$, it follows that there exist $(d-1) \times(d / m)$ ramification points of index $m$. It follows from the Riemann-Hurwitz formula that for $\pi_{Q}$,

$$
2 g-2 \geq-2 d+(d-1) \times \frac{d}{m}(m-1)
$$

For $\pi_{P}$,

$$
2 g-2 \leq-2(d-1)+(d-2)+(d-2) n
$$

With these inequalities used, it follows that

$$
n \geq \frac{m-1}{m} d-\frac{1}{m}\left(1+\frac{2}{d-2}\right) .
$$

If $d \geq 5$, then $\frac{1}{m}\left(1+\frac{2}{d-2}\right)<1$. Therefore,

$$
n \geq \frac{m-1}{m} d
$$

We consider (b). Assume that $d \geq 5$ and $m \geq 3$. Since the number of singular points on $\ell_{P}$ is at most $d / 2$, by (a), the number of smooth points on $\ell_{P}$ is at least

$$
\frac{m-1}{m} d-\frac{d}{2} .
$$

If $d \geq 7$ or $m \geq 4$, then this value is strictly more than 1 . This is a contradiction to Lemma 5. Assume that $d=6$ and $m=3$. In this case, $n \geq 4$ and there exists a smooth point on $\ell_{P}$. Therefore, the number of singular points on $\ell_{P}$ is at most two, and hence, there exist two smooth points on $\ell_{P}$. This is a contradiction to Lemma 5. Assume that $d=4$. Then $m=2$ or 4 . Assume that $m=4$. Then by the proof of (a),

$$
n \geq \frac{3}{4} d-\frac{1}{4}\left(1+\frac{2}{d-2}\right)=\frac{5}{2}
$$

Therefore, $n \geq 3$. Then there exist two smooth points on $\ell_{P}$. This is a contradiction to Lemma 5 .

We consider (c). By (b), $d$ is even. Assume that $R \in \ell_{P}$ is a point of multiplicity two. Note that $\overline{R P} \cap C=\{R, P\}$, by considering the defining equation. If $\varphi^{-1}(R)$ consists of two points, then the degree of $\pi_{P}$ is divisible by two. Since $d$ is even and $d-1$ is odd, this is a contradiction. Therefore, $\varphi^{-1}(R)$ consists of a unique point. Such a point also is denoted by $R$. Then the ramification index of $R$ for $\pi_{P}$ is $d-1$, and that of $R$ for $\pi_{Q}$ is two. The stabilizer subgroup $G_{Q}(R)$ for $G_{Q}$ consists of a unique involution $\tau$. Let $\sigma \in G_{P} \backslash\{1\}$. Since $\tau$ and $\sigma$ fix $R, \sigma^{-1} \tau \sigma$ fixes $R$. It follows from the condition $G_{P} G_{Q}=G_{P} \ltimes G_{Q}$ that $\sigma^{-1} \tau \sigma \in G_{Q}(R)$. Since $\left|G_{Q}(R)\right|=2$, $\sigma^{-1} \tau \sigma=\tau$. This is a contradiction to Lemma 4.

Lemma 7. Assume that all ramification points for $\pi_{Q}$ are contained in the line $\ell_{P}$. Then the following holds.
(a) $p>0$.
(b) The order of each element of $G_{Q} \backslash\{1\}$ is equal to $p$. In particular, $d=p^{e}$ for some $e>0$.

Proof. It follows from the Riemann-Hurwitz formula that there exist a wild ramification. Therefore, $p>0$. In this case, there exists an element $\tau \in G_{Q}$ of order $p$. By Lemma 4, it follows that

$$
G_{Q}=\left\{\sigma^{-1} \tau \sigma \mid \sigma \in G_{P}\right\} \cup\{1\} .
$$

It follows from Sylow's theorem that $d=p^{e}$ for some $e>0$.
Proof of Theorem 3. We consider the only-if part. By Lemma 7, there exists a ramification point $S \in C \backslash \ell_{P}$ for $\pi_{Q}$. We prove that $d \leq 4$. Assume that $d \geq 5$. By Lemma 6 (a) and (b), $n \geq d / 2$. The number of smooth points on $\ell_{P}$ is zero or one, by Lemma 5. If the number is zero, then, by Lemma 6 (c), there exist $d / 2$ points of
multiplicity at least three on $\ell_{P}$. This is obviously a contradiction. Therefore, the number of smooth points on $\ell_{P}$ is one. By Lemma 6 (c), there exist ( $d / 2$ ) - 1 points of multiplicity at least three on $\ell_{P}$. Then we have an inequality

$$
1+3 \times\left(\frac{d}{2}-1\right) \leq d
$$

This implies that $d \leq 4$.
Let $d=4$. By the assumption on the degree, it follows that $p \neq 2,3$. By Lemmas 5 and 6, there exists a singular point of multiplicity 3 on $\ell_{P}$. In particular, $C$ is rational. We can assume that for a suitable system of coordinates, $P=(0: 1: 0)$, $Q=(1: 0: 0)$ and $C$ is defined by

$$
y^{3} x+(x+1)^{3}(x+a)=0
$$

where $a \in k \backslash\{0\}$. Let $y=\beta$ be a branch point of $\pi_{Q}$, where $\beta \in k \backslash\{0\}$. Then there exist $c, d \in k$ such that

$$
\beta^{3} x+(x+1)^{3}(x+a)=\left(x^{2}+c x+d\right)^{2} .
$$

Comparing the coefficients of both sides, we have relations

$$
a+3=2 c, 3 a+3=c^{2}+2 d, 3 a+\beta^{3}+1=2 c d, a=d^{2} .
$$

By these equations, we have

$$
d^{4}-6 d^{2}+8 d-3=(d-1)^{3}(d+3)=0
$$

If $d=1$, then $\beta=0$. This is a contradiction. It follows that $d=-3, a=9, c=6$ and $\beta^{3}=-64$. Then the curve $C$ is defined by

$$
y^{3} x+(x+1)^{3}(x+9)=y^{3} x+64 x+\left(x^{2}+6 x-3\right)^{2}=0
$$

Let $d=3$. By the assumption on the degree, it follows that $p \neq 2,3$. By Lemma 55. there exists a singular point on $\ell_{P}$. Then $C$ is rational. Note that the index of all ramification points contained in $C \backslash \ell_{P}$ for $\pi_{Q}$ is three. We can assume that for a suitable system of coordinates, $P=(0: 1: 0), Q=(1: 0: 0)$ and $C$ is defined by

$$
y^{2} x+(x+1)^{2}(x+a)=0
$$

where $a \in k \backslash\{0\}$. Let $y=\beta$ be a branch point of $\pi_{Q}$, where $\beta \in k \backslash\{0\}$. Then there exists $c \in k$ such that

$$
\beta^{2} x+(x+1)^{2}(x+a)=(x+c)^{3}
$$

Comparing the coefficients of both sides, we have relations

$$
a+2=3 c, 2 a+\beta^{2}+1=3 c^{2}, a=c^{3} .
$$

By these equations, we have

$$
c^{3}-3 c+2=(c-1)^{2}(c+2)=0
$$

If $c=1$, then $\beta=0$. This is a contradiction. It follows that $c=-2, a=-8$ and $\beta^{2}=27$. Then the curve $C$ is defined by

$$
y^{2} x+(x+1)^{2}(x-8)=y^{2} x-27 x+(x-2)^{3}=0
$$

To prove the if-part, using Theorem 1, we prove the existence of plane rational curves of $d=3$ or 4 with required properties. We consider subgroups of $\operatorname{Aut}\left(\mathbb{P}^{1}\right) \cong$ $\operatorname{PGL}(2, k)$. It is well known that $A_{4}$ is a subgroup of $\operatorname{PGL}(2, k)$ (see, for example, [9, Theorem 11.91]). It is also well known that there exist subgroups $G_{1}, G_{2}$ of $A_{4}$ such that $G_{1}$ is a cyclic group of order three, $G_{2}$ is a normal subgroup of $A_{4}$ with $G_{2} \cong(\mathbb{Z} / 2 \mathbb{Z})^{\oplus 2}$, and $G_{1} G_{2}=G_{1} \ltimes G_{2}=A_{4}$. Let $P \in \mathbb{P}^{1}$ be a point such that $G_{1}$ fixes $P$. We prove that conditions (a) and (b) in Theorem 1 are satisfied for the triple $\left(G_{1}, G_{2}, P\right)$. By Lüroth's theorem, condition (a) is satisfied. With the action of $A_{4}$ considered, there exist three points $P_{2}, P_{3}, P_{4}$ such that $A_{4} P=\left\{P, P_{2}, P_{3}, P_{4}\right\}$. Let $\eta \in G_{2} \backslash\{1\}$. Then,

$$
P+\sum_{\sigma \in G_{1}} \sigma(\eta(P))=P+P_{2}+P_{3}+P_{4}=\sum_{\tau \in G_{2}} \tau(P)
$$

This implies condition (b) in Theorem 1. By Theorem 1, the required rational plane curve of $d=4$ is obtained. For $d=3$, a similar argument can be applied.

Proof of Proposition 1. We consider the only-if part. We prove that all ramification points for $\pi_{Q}$ are contained in $\ell_{P}$. When $d \geq 5$, according to the first paragraph of the proof of the only-if part of Theorem 3, the claim follows. Assume by contradiction that there exists a ramification point in $S \backslash \ell_{P}$ for $\pi_{Q}$. By Lemmas 5 and 6, if $d \leq 4$, then $C$ is rational. If $d=4$, then $p=2$ and $\pi_{Q}$ is wildly ramified at 6 ramification points contained in $C \backslash \ell_{P}$, by Lemma 6 (b). According to the Riemann-Hurwitz formula for $\pi_{Q}$, this is a contradiction. If $d=3$, then $p=3$ and $\pi_{Q}$ is wildly ramified at 2 ramification points. This is a contradiction. Therefore, the claim follows for all $d \geq 3$.

By Lemma 7 (a) and (b), $p>0$ and $d=p^{e}$ for some integer $e>0$. Let $R \in \varphi^{-1}\left(\ell_{P}\right)$ and let $G_{Q}(R)$ be the stabilizer subgroup of $G_{Q}$ of order $p^{k}$. By the assumption, $k>0$. Let $G_{P}(R)$ be the stabilizer subgroup of $G_{P}$. For any $\sigma \in G_{P}(R)$, $\sigma^{-1} G_{Q}(R) \sigma=G_{Q}(R)$. It follows from Lemma 4 that $\left|G_{P}(R)\right|+1 \leq\left|G_{Q}(R)\right|$. With the action of $G_{P}$ on $\varphi^{-1}\left(\ell_{P}\right)$ considered, the set $\varphi^{-1}\left(\ell_{P}\right)$ contains

$$
\frac{\left|G_{P}\right|}{\left|G_{P}(R)\right|} \geq \frac{p^{e}-1}{p^{k}-1}
$$

points. With the action of $G_{Q}$ considered, it follows that

$$
p^{e}=\left|G_{Q}\right| \geq\left|G_{Q}(R)\right| \times \frac{p^{e}-1}{p^{k}-1}=p^{k} \times \frac{p^{e}-1}{p^{k}-1} .
$$

It follows that

$$
p^{e-k} \leq 1
$$

Therefore, $k=e$, that is, $G_{Q}(R)=G_{Q}$. This implies that $C \cap \ell_{P}=\{\varphi(R)\}$. For a suitable system of coordinates, we can assume that $\varphi(R)=(-1: 0: 1)$. Then $C$ is defined by

$$
y^{d-1} x+(x+1)^{d}=0
$$

We consider the if-part. The curve $C$ is projectively equivalent to the curve defined by

$$
x-y^{q}=0
$$

where $p>0$ and $q$ is a power of $p$. Let $P=(0: 0: 1)$ and let $Q \in\{Z=0\} \backslash\{(1: 0$ : $0),(0: 1: 0)\}$. According to [4], $P$ is an inner Galois point and $Q$ is an outer Galois point. Note that there exists an inclusion $G_{P} \hookrightarrow P G L(3, k)$ and $G_{P}$ fixes $Q$. It is inferred that $G_{P} G_{Q}=G_{P} \ltimes G_{Q}$. Since the line passing through $P$ and $Q$ intersects $C$ at $q$ points, it follows that $G_{P} G_{Q} \neq G_{P} \rtimes G_{Q}$, by Lemma 1 .

Remark 3. For the curve of degree 4 in Theorem 3, the point $P$ is a unique inner Galois point. This is proved easily, because two flexes are needed for each inner Galois points and there exists $G_{P} \hookrightarrow P G L(3, k)$. For the curve described in Proposition 11, the set of Galois points is determined in [4].

Remark 4. According to a classification of finite subgroups $G$ of $P G L(2, k)$ (see, for example, [9, Theorem 11.91]), a finite non-abelian subgroup $G$ containing subgroups $H_{1}, H_{2} \subset G$ such that $G=H_{1} \ltimes H_{2},\left|H_{2}\right|=\left|H_{1}\right|+1 \geq 4$ and $G$ has a short orbit of length $\left|H_{2}\right|$ must be one of the following:
(a) $A_{4}$ with $p \neq 2,3$;
(b) the semidirect product of an elementary abelian $p$-group of order $q$ with a cyclic group of order $q-1$.

The cases (a) and (b) are described in Theorem 3 (b) and Proposition 1.
Remark 5. If $\operatorname{supp}\left(\varphi^{*} \ell\right)$ consists of $d$ points, then the action of the group $G_{P} \ltimes G_{Q}$ on $\operatorname{supp}\left(\varphi^{*} \ell\right)$ is doubly transitive.

Remark 6. Assume that $\operatorname{supp}\left(\varphi^{*} \ell\right)$ consists of $d$ points. Let $P_{1}=P$, let $P_{2}=$ $\tau(P)$ and let $G_{2}=\tau G_{P} \tau^{-1}$, where $\tau \in G_{Q} \backslash\{1\}$. It is inferred that conditions in [3, Theorem 1] are satisfied for the 4-tuple $\left(G_{1}, G_{2}, P_{1}, P_{2}\right)$. Therefore, $X$ has a birational embedding with two inner Galois points. Note that $G_{1}$ fixes $P_{1}$ and $G_{2}$ fixes $P_{2}$. In this case, the group $G=\left\langle G_{P_{1}}, G_{P_{2}}\right\rangle\left(=G_{P} \ltimes G_{Q}\right)$ has been classified by Korchmáros, Lia, and Timpanella [10. It is noted that this birational embedding is different from the one given by the triple $\left(G_{P}, G_{Q}, P\right)$ in the case of Theorem 3 (b). In fact, the embedding of $d=4$ described in Theorem 3 does not admit two inner Galois points.

Remark 7. Assume that $p>0$ and $p$ divides $d-1$. In this case also, we can prove that the defining equation of $C$ is of the form $\left(\sum_{m \mid p^{i}-1} \alpha_{i} x^{p^{i}}\right)^{m}+h(y)=0$, where $d-1=p^{e} m, m$ is not divisible by $p, \alpha_{e} \alpha_{0} \neq 0$, and $h(y)$ is a polynomial of degree $d$, up to a projective equivalence.
