# Punctures and $p$-spin curves from matrix models II

#### Abstract

We report here an extension of a previous work in which we have shown that matrix models provide a tool to compute the intersection numbers of $p$-spin curves. We discuss further an extension to half-integer $p$, and in more details for $p=\frac{1}{2}$ and $p=\frac{3}{2}$. In those new cases one finds contributions from the Ramond sector, which were not present for positive integer $p$. The existence of Virasoro constraints, in particular a string equation, is considered also for half-integral spins. The contribution of the boundary of a Riemann surface, is investigated through a logarithmic matrix model. The supersymmetric random matrices provide extensions to mixed positive and negative $p$ punctures.


## 1 Introduction

We present here a continuation of a previous article [1], where the extension to half-integer $p$ spins was introduced on the basis of explicit expressions for random matrix correlation functions [2]. The marked points on Riemann surfaces of $p$-spin curves are classified into two types, Neveu-Schwarz (NS) and Ramond (R). In this paper, we investigate the correlation functions up to three marked points.

The integer $p$-spin curves are the moduli spaces of Riemann surface with spin structures and they are described by matrix models, in which $p$ appears as a power of the random matrices. In a previous article [3], the values of $p$ were continued to negative values such as $p=-1,-2$, where $p=-1$ corresponds to Euler characteristics. The $p=-2$ spin case corresponds to a unitary matrix model, which is simply the one-plaquette model of a lattice gauge theory. This well-known model exhibits an interesting phase transition between the weak and strong coupling regimes $[4,5]$.

It is natural to examine the continuation to half-integer $p$. Starting from the integer spin expressions, in a previous article [1], we have introduced a continuation to half- integer spin cases, focusing on the typical case $p=\frac{1}{2}$. The continuation to $p=\frac{1}{2}$ involves the removal of an infinite renormalization factor $\Gamma(0)$. A remarkably simple and exact result for the one point function, for general genus $g$, is obtained for $p=\frac{1}{2}$ within this renormalization.

In the case of integer $p$-spin, the spin components take $p$ possible values; the $(p-1)$ values $l=0,1,2, \ldots, p-2$, correspond to Neveu-Schwarz(NS) marked points ; for $l=p-1$ or $l=-1(\bmod p)$, the marked point on the Riemann surface is of Ramond (R)- type. In this article, we use those definitions of NS and R type, classified by the value of $l[6]$. In the case of positive integer $p$, we know that to $p=2$ corresponds a KdV hierarchy, and a generalized KdV for $p \geq 3$. For $p=\frac{1}{2}$, the existence of a related integrable structure is not known.

A selection rule implies that the R-type punctures should appear in pairs for $p=-2$, and we show explicitly the occurrence of pair-wise punctures for the three-point function.

The organization of this article is the following: The section two is devoted to spin $p=\frac{1}{2}$ and its one-point correlation function. We verify the continuation of the expression for $p$-spin curves to the $p=\frac{1}{2}$ case. The section three deals with the two-point function for $p=\frac{1}{2}$. A possible string equation is discussed. The section four gives the three-point functions for $p=\frac{1}{2}$. The spin $p=\frac{3}{2}$ is studied in the section five. In section six, the negative integer cases $p=-2$ and $p=-3$ are investigated. We discuss the paired R -type punctures for $p=-2$. In section seven, we discuss supermatrices and their correlation functions. The strong coupling expansions are considered.

We discuss the open boundary and marked points on the boundary within a logarithmic matrix model. Through this open boundary analysis, we find the continuation from integer $p$ to the $p=\frac{1}{2}$ case. The section eight contains a summary and a discussion.

## 2 Spin $p=\frac{1}{2}$ correlation functions

There are two types of marked points on Riemann surfaces: Neveu-Schwarz(NS) and Ramond (R). In the spin $p=\frac{1}{2}$ case, the marked points on the Riemann surface belong to the Ramond type with $l=p-1=-\frac{1}{2}$, or $l=0,-1$ (modulo $p$, these three cases are in fact all the same one). The choice of $l$ among these three cases depends upon the continuation from integer $p$ to half-integer $p$ (see the discussion below).

The intersection numbers for positive integer $p$ are given by the integral of the compact moduli space $\bar{M}_{g, s}$,

where $c_{1}\left(\mathcal{L}_{j}\right)$ is the first Chern class and $C_{D}(V)$ is a top Chern class with dimension $D=(g-1)\left(1-\frac{2}{p}\right)+\frac{1}{p} \sum l_{i}$.

In this work we continue those formulae to half-integer $p$. In previous articles, we have found that the correlation functions of a random-matrix theory provide intersection numbers for the moduli of curves on a Riemann surface. More precisely, the intersection numbers (1) are deduced from the correlation functions $U\left(\sigma_{1}, \ldots, \sigma_{s}\right)[3,9,11]$,

where $M$ is a Gaussian random matrix coupled to an appropriately tuned matrix source $A$. Those correlation functions are known to satisfy explicit integral representations [2]. For the spin $p$ case, after tuning of the external source $A$, it reduces to

The intersection numbers (1) are obtained as the coefficients of the expansion in powers of the $\sigma_{i}$ 's in this matrix model approach, with appropriate normalizations [2],

The non-vanishing the intersection numbers are restricted by a selection rule for the parameters $\left(n_{i}, l_{i}\right)$

The second and third term is denoted as $D$, which is derived from RiemannRoch formula [6]. This formula can be written as

where the left hand side is minus Euler characteristics $-\chi$.
When $p=\frac{1}{2}$, where all $l_{i}=l$, and above equation is written as

where $n_{i}$ is the exponent of ${\sigma_{i}}^{n_{i}+2\left(1+l_{i}\right)}$ for $U\left(\sigma_{1}, \ldots, \sigma_{s}\right) \sim \prod_{i=1}^{s} \sigma^{n_{i}+2\left(1+l_{i}\right)}$.
We consider the one-point function $<\operatorname{tr} e^{\sigma M}>$ in the scaling limit [1] :

U(\sigma) & =\frac{1}{\sigma} \oint \frac{d u}{2 i \pi} e^{\frac{\xi}{p+1}\left(\left(u+\frac{1}{2} \sigma\right)^{p+1}-\left(u-\frac{1}{2} \sigma\right)^{p+1}\right)} \\
& =\oint \frac{d u}{2 i \pi} e^{c \sigma^{p+1}\left(\left(u+\frac{1}{2}\right)^{p+1}-\left(u-\frac{1}{2}\right)^{p+1}\right)} \tag{8}

where we have rescaled $u \rightarrow \sigma u$, and $c=\xi /(p+1)$. We now change $u$ to a variable $y$ better suited to discuss half-integer $p$ [1]

The one point function $U(\sigma)$ of (8) becomes

U(\sigma)=\frac{i}{2} \oint \frac{d y}{2 i \pi}\left(y+\frac{1}{y^{3}}\right) e^{c\left(\frac{i \sigma}{4}\right)^{p+1} \frac{1}{y^{2 p+2}}\left[\left(y^{2}-i\right)^{2 p+2}-\left(y^{2}+i\right)^{2 p+2}\right]} \tag{10}
\end{equation*}

This integrand, which has singularities at $y=0$ and $y=\infty$, leads to useful contour integrals. It is invariant under the transformation $y \rightarrow-\frac{1}{y}$.

For instance, we obtain the one-point function,

where for $p=\frac{1}{2}, g(y)$ is given as

g(y)=e^{c^{\prime} \sigma\left(3 y-\frac{\sigma^{2}}{y^{3}}\right)} \tag{12}

Since the exponent is linear in $y$ in the large $y$ limit, we can deform the contour in (11) to a large circle. If we expand for small $\sigma$, a singularity appears at the origin $y=0$ or at $y=\infty$. From the residues at $y=0$, the one point function is given by

& =\frac{i}{2} \sum_{g=1}^{\infty} c^{4 g-2} \frac{3^{3 g-1}}{(g-1)!(3 g)!}(-1)^{g-1} \sigma^{6 g-3} \tag{13}
\end{align*}

Using the Gauss-Legendre formula for $\Gamma(3 z), \Gamma(3 z)=\frac{3^{3 z}}{(2 \pi) \sqrt{3}} \Gamma(z) \Gamma\left(z+\frac{1}{3}\right) \Gamma(z+$ $\left.\frac{2}{3}\right)$, the expression (13) becomes $U(\sigma)=\frac{i \pi \sqrt{3}}{9} \Gamma\left(\frac{4}{3}\right) \Gamma\left(\frac{5}{3}\right)_{0} F_{3}\left(\frac{4}{3}, \frac{5}{3}, 2 ;-c^{4} \sigma^{6}\right)$ where ${ }_{0} F_{3}\left(\beta_{1}, \beta_{2}, \beta_{3} ; z\right)$ is a standard generalized hypergeometric function.

Integer powers of (13) are indeed expected, since for the general $p$-spin curve, we argued that the powers are of the form $\sigma^{n+\frac{1}{p}(1+l)}$ which is an integer for $p=\frac{1}{2}$. Using the dependence in $n$ and $l$ in the general form $\sigma^{n+2(1+l)}$, we find an integral power of $\sigma$ for $l=0,-\frac{1}{2},-1$ with the selection rule $n=6 g-5-2 l$ in (7). The coefficient of $\sigma^{n+2(1+l)}=\sigma^{6 g-3}$ is denoted by $<\tau_{6 g-3}>$ (it is independent of the choice of $l$ ).

To verify the consistency with the known expressions for integer $p$, we return to previous results [2]. The one-point function was computed up to $g=9$ for general integer $p$ in [2]. Let us quote here the results up to $g=3$,

& =\frac{1}{\sigma p \pi} \cdot \frac{1}{(c p)^{1 / p}} \int_{0}^{\infty} d t t^{\frac{1}{p}-1} e^{-t} e^{-\frac{p(p-1)}{3!4} \sigma^{2+\frac{2}{p}} c^{\frac{2}{p}} t^{1-\frac{1}{p}}-\frac{p(p-1)(p-2)(p-3)}{5!4^{2}} \sigma^{4+\frac{4}{p}} c^{\frac{4}{p}} t^{1-\frac{4}{p}}+\cdots} \\
& =\frac{1}{\sigma \pi} \cdot \frac{1}{(c \sigma)^{1 / p}}\left(\Gamma\left(1+\frac{1}{p}\right)-\frac{p-1}{24} z \Gamma\left(1-\frac{1}{p}\right)\right. \\
& +\frac{(p-1)(p-3)(1+2 p)}{5!\cdot 4^{2} \cdot 3} z^{2} \Gamma\left(1-\frac{3}{p}\right) \\
& -\frac{(p-1)(p-5)(1+2 p)\left(8 p^{2}-13 p-13\right)}{7!4^{3} 3^{2}} z^{3} \Gamma\left(1-\frac{5}{p}\right) \\
& +\frac{(p-1)(p-7)(1+2 p)\left(72 p^{4}-298 p^{3}-17 p^{2}+562 p+281\right)}{9!4^{4} 15} z^{4} \Gamma\left(1-\frac{7}{p}\right) \\
& \left.+O\left(z^{4}\right)\right) \tag{14}
\end{align*}
$$

where $z=c^{\frac{2}{p}} \sigma^{2+\frac{2}{p}}$. Performing the continuation to $p=\frac{1}{2}$ in the above formula, we obtain divergent results with coefficients $\Gamma(-n)$. The limit $p \rightarrow$
$1 / 2$ should thus be taken with care. If we replace $\Gamma(-n+\epsilon)$ by $(-1)^{n} \frac{1}{n!} \Gamma(\epsilon)$, where $\epsilon$ is proportional to $p-1 / 2$ we obtain the divergent expression

\end{equation*}

Nevertheless this expression may be compared to $U(\sigma)$ of $p=\frac{1}{2}$ with $c^{\prime}=\frac{1}{6} c$ in (13),

\end{equation*}

Thus except for a factor $i \Gamma(0)$, both expressions coincide. The divergent factor $\Gamma(0)$ is due to the integral (14), whereas for $p=\frac{1}{2}$, we had used the contour integral for $y$ of (11). Thus, modulo this infinite renormalization, we have found a remarkable extension to $p=\frac{1}{2}$. Note that in (14) the the gamma factors are also divergent for integer $p$, but these divergences are cancelled by the associated pre-factors.

To clarifiy the question of divergences related to R-punctures, we return here to earlier results for $U(\sigma)$. As shown in [2], the generating function of the one-point intersection numbers $U(\sigma)$ is known in closed form for $p=2,3,4$. For $p=2$, it is given by

which shows that there is no integer power in the expansion in powers of $\sigma$. For $p=3$, we have [10]

U(\sigma) & =\frac{1}{N \sigma(3 N \sigma)^{1 / 3}} A_{i}\left(-\frac{N^{2 / 3}}{4 \cdot 3^{1 / 3}} \sigma^{8 / 3}\right) \\
& =\frac{1}{N \sigma(3 N \sigma)^{1 / 3}}\left[A_{i}(0)\left(1+\frac{1}{3!} \zeta^{3}+\frac{4}{6!} \zeta^{6}+\cdots\right)+A_{i}^{\prime}(0)\left(\zeta+\frac{2}{4!} \zeta^{4} \cdots\right)\right] \tag{18}
\end{align*}
$$

where $\zeta=-N^{2 / 3}\left(4 \cdot 3^{1 / 3}\right)^{-1} \sigma^{8 / 3}$, and $A_{i}(0)=3^{-2 / 3} / \Gamma(2 / 3), A_{i}^{\prime}(0)=-3^{-1 / 3} / \Gamma\left(\frac{2}{3}\right)$. The asymptotic expansion of the Airy function consists of two series. The first series is related to $l=1$ and the second series related to $l=0$; they provide

<\tau_{1,0}>_{g=1}=\frac{1}{12}, \quad<\tau_{6,1}>_{g=3}=\frac{1}{3 \cdot 3!(12)^{3}}, \quad<\tau_{9,0}>_{g=4}=\frac{1}{(12)^{4} 4!} \cdot \frac{2}{3}, \ldots \tag{19}
\end{equation*}
$$

There is no R-type term of the type $\left.<\tau_{n, 2}\right\rangle$ or $\left\langle\tau_{n,-1}\right\rangle$, which would appear as integer powers of $\sigma$ in the expansion of $U(\sigma)$ (note $l=2$ and $l=-1$ are identical $\bmod p=3)$.

For $p=4$, the one point function reads [2]

U(\sigma) & =\frac{1}{2 \sqrt{8}} e^{\frac{3}{160} \sigma^{5}} \frac{1}{2 \sin \left(\frac{\pi}{4}\right)}\left(I_{-\frac{1}{4}}\left(\frac{1}{32} \sigma^{5}\right)+I_{\frac{1}{4}}\left(\frac{1}{32} \sigma^{5}\right)\right) \\
& =\frac{1}{8} \sum_{m, n=0}^{\infty} \frac{1}{m!n!\Gamma\left(n+\frac{5}{4}\right)}\left(\frac{3}{160}\right)^{m}\left(\frac{1}{64}\right)^{2 n+\frac{1}{4}} \sigma^{5 m+10 n+\frac{1}{4}} \tag{20}
\end{align*}
$$

which shows that all terms are of NS-type (the power of $\sigma$ is not an integer) and none of R-type. Returning to (14) we see that the coefficients present divergent gamma-functions of negative integers, but these divergences disappear if one takes into account the pre-factors, as for instance with $(p-3) \Gamma(1-3 / p)$ which goes to 3 for $p \rightarrow 3$. This procedure does not provide any non-vanishing R term.

To incorporate R type intersection numbers, we return to the relationship between the intersection numbers $\left\langle\tau_{n, l}>\right.$ and the generating function $U(\sigma)$

where $(p+1)(2 g-1)=p n+l+1$. The intersection number $<\tau_{n, l}>_{g}$ has to vanish to cancel the divergent factor $\Gamma\left(1-\frac{1+l}{p}\right)$ for $l=p-1$ ( R type). For $p=3$, the intersection numbers are known in closed form [11],

<\tau_{n, l}>_{g}=\frac{1}{(12)^{g} g!} \frac{\Gamma\left(\frac{1+g}{3}\right)}{\Gamma\left(1-\frac{1+l}{3}\right)} \tag{22}
\end{equation*}
$$

with the selection rule $\frac{8}{3}(g-1)+1=n+\frac{l}{3}$. Thus the infinite denominator implies vanishing intersection numbers of the would be R-type for $g=2+3 m$ ( $m=0,1,2, \ldots$ ).

Therefore, if we make a continuation to half-integer $p$, the divergence of $U(\sigma)$ in (15), is matched by the divergence of the gamma function $\Gamma\left(1-\frac{1+l}{p}\right)$ in (21), when we take $l=p-1$. This allows for finite non-vanishing limits of $<$ $\tau_{n, l}>_{g}$ for $l=p-1$. The definition (21) for the intersection numbers provides the normalization for the factorization of the divergence even for half-integer p. Namely one should consider the limit $p \rightarrow 1 / 2$ of $U(\sigma) / \Gamma\left(1-\frac{1+l}{p}\right)$ for $l=p-1$ when $p$ is equal to $1 / 2$ and more generally is a half-integer.

We have chosen a value for $l$ in the set $l=-1,-\frac{1}{2}, 0$, which are all the same $\bmod p$. Indeed to match the divergence of $U(\sigma)$, we have to take $l=-\frac{1}{2}$ which is equal to $p-1$, and $\Gamma\left(1-\frac{1+l}{p}\right)=\Gamma(0)$. Taking this value $l=-\frac{1}{2}$, the continuation from integer $p$ to $p=\frac{1}{2}$ becomes smooth with finite intersection
numbers. Note also that (13) is an exact form expression, while (15) is an expansion. This leads to the verification of the expansion (14) by the exact $U(\sigma)$ for $p=\frac{1}{2}$.

The result for $p=\frac{1}{2}$ in (13) may also be written as

U(\sigma)=\sum_{g} \frac{c^{4 g-2} 3^{4 g-2} \sigma^{6 g-3}}{(4 g-2)!} \oint \frac{d z}{2 i \pi}(1+z)\left(1-\frac{z}{3}\right)^{4 g-2} \frac{1}{z^{g+1}} \tag{23}
\end{equation*}

where the contour integral, denoted by $C_{g}^{(0)}$, is

C_{g}^{(0)}=\oint \frac{d z}{2 i \pi}(1+z)\left(1-\frac{z}{3}\right)^{4 g-2} \frac{1}{z^{g+1}}=\frac{(4 g-2)!}{g!(3 g-1)!} \tag{24}
\end{equation*}

There are signs such as $(-1)^{g}$ in the expression. We absorb those minus signs by a redefinition of positive intersection numbers.

The differences of three choices of $l=-1,-\frac{1}{2}, 0$ make just the shift of the notation of suffix of $\tau$, i.e. $6 g-5-2 l$, since they are same as $\bmod p$. In the following, we take $l=-1$ value for R type punctures for $p=\frac{1}{2}$.

## 3 The two-point function for $p=\frac{1}{2}$

For the two-point connected function $U\left(\sigma_{1}, \sigma_{2}\right)$, the integral representation (3) reads, after tuning of the source matrix,

& \times \frac{1}{\left(y_{1}^{2}-\frac{\sigma_{1}^{2}}{y_{1}^{2}}-y_{2}^{2}+\frac{\sigma_{2}^{2}}{y_{2}^{2}}\right)^{2}+4\left(\sigma_{1}+\sigma_{2}\right)^{2}} \tag{26}
\end{align*}

We use the change of variables (9) for the two-point function (26). We then rescale $y_{i}$ by $y_{i} / \sigma_{i}$ and obtain

& \times \frac{1}{\left(y_{1}^{2}-\frac{\sigma_{1}^{6}}{y_{1}^{2}}-\frac{\sigma_{1}^{2}}{\sigma_{2}^{2}} y_{2}^{2}+\frac{\sigma_{1}^{2} \sigma_{2}^{4}}{y_{2}^{2}}\right)^{2}+4 \sigma_{1}^{4}\left(\sigma_{1}+\sigma_{2}\right)^{2}} \tag{27}
\end{align*}

Expanding the above equation in powers of $\sigma_{1}^{n_{1}} \sigma_{2}^{n_{2}}$, we obtain as coefficients the intersection numbers $<\tau_{n_{1}} \tau_{n_{2}}>_{g}$ for genus $g$. The selection rule for $n_{1}$ and $n_{2}$ follows (5). For the two-point function $n_{1}+n_{2}=6 \mathrm{~g}$.

3-1 Equation for $\sigma_{1} \sigma_{2}^{6 g-1}, \sigma_{1}^{3} \sigma_{2}^{6 g-3}$ and $\sigma_{1}^{5} \sigma_{2}^{6 g-5}$
From (27), it follows immediately that there is no linear term in $\sigma_{1}$ such as $\sigma_{1} \sigma_{2}^{6 g-1}$. Thus we have $<\tau_{1} \tau_{6 g-1}>_{g}=0$. We also find that $\sigma_{1}^{3} \sigma_{2}^{6 g-3}$ and $\sigma_{1}^{5} \sigma_{2}^{6 g-5}$ are absent from (27) and thus $<\tau_{1} \tau_{6 g-3}>_{g}$ and $<\tau_{5} \tau_{6 g-5}>_{g}$ also vanish.

## 3-2 Coefficient of $\sigma_{1}^{2} \sigma_{2}^{6 g-2}$

A term of order $\sigma_{1}^{2}$ is present as a coefficient in a front of the integral (27). All other $\sigma_{1}$ being set to zero, the integral for the term of order $\sigma_{1}^{2}$ reduces to

The residue at the pole $y_{1}=0$ is computed after expanding $e^{3 c_{1} y_{1}}$, and the integral over $y_{2}$ is found to be the same as for the one point function $<\tau_{6 g-3}>$. This leads to an equation, which is similar to the integer- $p$ string equation, and thus we give it here the same name.

String equation, The coefficient of $\sigma_{1}^{2}$ leads to the relation

This is similar to the string equation for integer $p,(6 g-2 \rightarrow 6 g-3)$. For the correspondence to the usual Kontsevich model, we have the selection rule $6 g-6+6=n_{1}+n_{2}$ while $3 g-3+2 n_{1}^{\prime}+n_{2}^{\prime}$, thus for $n_{1}+n_{2}=2\left(n_{1}^{\prime}+n_{2}^{\prime}\right)+2$. By setting $n_{1}=2, n_{1}^{\prime}=0$, we obtain $n_{2}=2 n_{2}^{\prime}$. Thus the above equation may be interpreted as $<\tau_{0}^{\prime} \tau_{3 g-1}^{\prime}>$ giving the string equation of Kontsevich model $<\tau_{0}^{\prime} \tau_{3 g-1}^{\prime}>=<\tau_{3 g-2}^{\prime}>$.

## 3-4 Coefficient of $\sigma_{1}^{n} \sigma_{2}^{6 g-n}$

- $<\tau_{4} \tau_{8}>$

For $<\tau_{4} \tau_{8}>$ one considers the terms of scale $c^{8} \sigma^{12}$ (in general $c^{4 g} \sigma^{6 g}$, here with $g=2$ ). The power $c^{8}$ consists of the non-vanishing terms $c_{1}^{2} c_{2}^{6}$ and $c_{1}^{4} c_{2}^{4}$.

From (27), neglecting higher powers in $\sigma_{1}$ than $\sigma_{1}^{4}$, the integral reduces to

The term $\sigma_{1}^{4} \sigma_{2}^{8}$ is obtained as the residue at the $y_{1}=0$ pole, through the expansion of the denominator,

& =\frac{3^{5}}{16} c_{1}^{4} c_{2}^{4} \sigma_{1}^{4} \sigma_{2}^{8} \tag{31}
\end{align*}

- $<\tau_{4} \tau_{14}>$

The term $\sigma_{1}^{4}$ is the same in this case, so we use (30), and up to order $\sigma_{2}^{14}$ we may write this as

From this, we obtain the coefficient of $\sigma_{1}^{4} \sigma_{2}^{14}$,

This formula results from from (26) ; taking the pole at $y_{1}=\infty$ for $c_{1}^{2} \sigma_{1}^{4}$, the term of order $c_{2}^{4 g-2} \sigma_{2}^{6 g-4}$ is expressed as

The intersection number $<\tau_{4} \tau_{6 g-4}>$ corresponds to the $<\tau_{1}^{\prime} \tau_{3 g-2}^{\prime}>$ of Kontsevich model, which suggests that it is related to a dilaton equation.

The coefficient of $\sigma_{1}^{6}$ is obtained by neglecting higher order terms in (27),

& \times\left(1+\frac{2 \sigma_{1}^{2} y_{2}^{2}}{\sigma_{2}^{2} y_{1}^{2}}-\frac{2 \sigma_{1}^{2} \sigma_{2}^{4}}{y_{1}^{2} y_{2}^{2}}-\frac{6 \sigma_{1}^{4} \sigma_{2}^{2}}{y_{1}^{4}}-\frac{\sigma_{1}^{4} y_{2}^{4}}{\sigma_{2}^{4} y_{1}^{4}}-\frac{\sigma_{1}^{4} \sigma_{2}^{8}}{y_{1}^{4} y_{2}^{4}}\right) \tag{37}

## 4 Three-point function function for $p=\frac{1}{2}$

The three-point function $U\left(\sigma_{1}, \sigma_{2}, \sigma_{3}\right)$ is given by a triple integral involving a $3 \times 3$ determinant. The connected part is given by the longest cycles of the determinant, and it is given by an integral over $y_{1}, y_{2}$ and $y_{3}$ :

& \times \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{2}\right)-\frac{\sigma_{1}^{2}}{y_{1}^{2}}+y_{1}^{2}+\frac{\sigma_{2}^{2}}{y_{2}^{2}}-y_{2}^{2}\right)\left(2 i\left(\sigma_{2}+\sigma_{3}\right)-\frac{\sigma_{2}^{2}}{y_{2}^{2}}+y_{2}^{2}+\frac{\sigma_{3}^{2}}{y_{3}^{2}}-y_{3}^{2}\right)} \\
& \times \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{3}\right)+\frac{\sigma_{1}^{2}}{y_{1}^{2}}-y_{1}^{2}-\frac{\sigma_{3}^{2}}{y_{3}^{2}}+y_{3}^{2}\right)} e^{\sum_{i=1}^{3} c_{i} \sigma_{i}\left(3 y_{i}-\frac{\sigma_{i}^{2}}{y_{i}^{3}}\right)} \tag{40}
\end{align*}
$$

or, after the rescaling $y_{i} \rightarrow y_{i} / \sigma_{i}$, by

& U\left(\sigma_{1}, \sigma_{2}, \sigma_{3}\right)=\frac{1}{\left(\sigma_{1} \sigma_{2} \sigma_{3}\right)^{2}} \oint \frac{d y_{1} d y_{2} d y_{3}}{(2 i \pi)^{3}}\left(\frac{\sigma_{1}^{6}}{y_{1}^{3}}+y_{1}\right)\left(\frac{\sigma_{2}^{6}}{y_{2}^{3}}+y_{2}\right)\left(\frac{\sigma_{3}^{6}}{y_{3}^{3}}+y_{3}\right) \\
& \times \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{2}\right)-\frac{\sigma_{1}^{4}}{y_{1}^{2}}+\frac{y_{1}^{2}}{\sigma_{1}^{2}}+\frac{\sigma_{2}^{4}}{y_{2}^{2}}-\frac{y_{2}^{2}}{\sigma_{2}^{2}}\right)} \frac{1}{\left(2 i\left(\sigma_{2}+\sigma_{3}\right)-\frac{\sigma_{2}^{4}}{y_{2}^{2}}+\frac{y_{2}^{2}}{\sigma_{2}^{2}}+\frac{\sigma_{3}^{4}}{y_{3}^{2}}-\frac{y_{3}^{2}}{\sigma_{3}^{2}}\right)} \\
& \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{3}\right)+\frac{\sigma_{1}^{4}}{y_{1}^{2}}-\frac{y_{1}^{2}}{\sigma_{1}^{2}}-\frac{\sigma_{3}^{4}}{y_{3}^{2}}+\frac{y_{3}^{2}}{\sigma_{3}^{2}}\right)} e^{c_{1}\left(3 y_{1}-\frac{\sigma_{1}^{6}}{y_{1}^{3}}\right)+c_{2}\left(3 y_{2}-\frac{\sigma_{2}^{6}}{y_{2}^{3}}\right)+c_{3}\left(3 y_{3}-\frac{\sigma_{3}^{6}}{y_{3}^{3}}\right)} \tag{41}
\end{align*}

In the three-point case, the condition (5) reads

& \times \frac{1}{\left(2 i\left(\sigma_{2}+\sigma_{3}\right)-\frac{\sigma_{2}^{4}}{y_{2}^{2}}+\frac{y_{2}^{2}}{\sigma_{2}^{2}}+\frac{\sigma_{3}^{4}}{y_{3}^{2}}-\frac{y_{3}^{2}}{\sigma_{3}^{2}}\right)} \tag{44}

The first term, i.e. $\frac{\sigma_{2}^{2}}{y_{2}^{2}}$, gives a non-vanishing residue in $\oint \frac{d y_{2}}{2 i \pi} \frac{1}{y_{2}}=1$, and the dependence in $\sigma_{2}$ is canceled by the factor in the front of (44). The integral over $y_{3}$ gives (13), i.e. $<\tau_{6 g-3}>\sigma_{3}^{6 g-2}$. Thus from the first term, we obtain $<\tau_{2} \tau_{0} \tau_{4}>=\frac{\left(3 c_{1}\right)^{2}}{2}<\tau_{6 g-3}>\sigma_{1}^{2} \sigma_{3}^{6 g-2}$, which reduces to the two-point function $U\left(\sigma_{1}, \sigma_{3}\right)$, with the selection rule of $6 g=n_{1}+n_{3}$. This $\tau_{0}$ plays the role of what was the dilaton equation in the case of integer $p$.

The second term gives the coefficient of $\sigma_{2}^{2}$,

& -\frac{2 i \sigma_{1}^{2} \sigma_{2}^{2}}{\sigma_{3}} \oint \frac{d y_{2}}{2 i \pi} \frac{e^{3 c_{2} y_{2}}}{y_{2}^{3}} \oint \frac{d y_{3}}{2 i \pi}\left(y_{3}+\frac{\sigma_{3}^{6}}{y_{3}}\right) e^{c_{3}\left(3 y_{3}-\frac{\sigma_{3}^{6}}{y_{3}^{3}}\right)} \tag{46}

There is no $\left(\sigma_{1} \sigma_{2} \sigma_{3}\right)^{2}$ term, which is consistent with the selection rule $6 g+3=$ $n_{1}+n_{2}+n_{3}$. The second term of the above equation gives $\sigma_{1}^{2} \sigma_{2}^{2} \sigma_{3}^{5}$, i.e, $<\tau_{2} \tau_{2} \tau_{5}>_{g=1}$.

= & \frac{i}{\sigma_{2}^{2} \sigma_{3}^{2}\left(\sigma_{2}+\sigma_{3}\right)} \oint \frac{d y_{2} d y_{3}}{(2 \pi i)^{2}}\left(y_{2}+\frac{\sigma_{1}^{6}}{y_{2}^{3}}\right)\left(y_{3}+\frac{\sigma_{2}^{6}}{y_{3}^{3}}\right) e^{c_{2}\left(3 y_{2}-\frac{\sigma_{1}^{6}}{y_{2}^{3}}\right)+c_{3}\left(3 y_{3}-\frac{\sigma_{2}^{6}}{y_{3}^{3}}\right)} \\
& \left(\frac{1}{\frac{y_{2}^{2}}{\sigma_{2}^{2}}-\frac{\sigma_{2}^{4}}{y_{2}^{2}}-\frac{y_{3}^{2}}{\sigma_{3}^{2}}+\frac{\sigma_{3}^{4}}{y_{3}^{2}}-2 i\left(\sigma_{2}+\sigma_{3}\right)}-\frac{1}{\frac{y_{2}^{2}}{\sigma_{2}^{2}}-\frac{\sigma_{2}^{4}}{y_{2}^{2}}-\frac{y_{3}^{2}}{\sigma_{3}^{2}}+\frac{\sigma_{3}^{4}}{y_{3}^{2}}+2 i\left(\sigma_{2}+\sigma_{3}\right)}\right) \tag{48}
\end{align*}
$$

and comparing with (44), we obtain the relation

The above equation may be interpreted as a puncture (string) equation. For $g=1$, we have $<\tau_{2} \tau_{3} \tau_{4}>$ from (44), and it also satisfies the string equation.

## 5 Correlation functions for $p=\frac{3}{2}$

The spin $p=\frac{3}{2}$ has marked points of both NS $\left(l=0,-\frac{1}{2}\right)$ and $\mathrm{R}(l=-1)$ types. Or we take $l=0,-\frac{1}{2}, \frac{1}{2}$ due to $\bmod p$. The case $l=\frac{1}{2}$ is equivalent to $l=-1(\bmod p)$. As shown in [1], the relevant integrand for $p=\frac{3}{2}$ has the factor

after the rescaling $y_{i} \rightarrow y_{i} / \sqrt{\sigma_{i}}$. The selection rule for an $s$-point function of R -type is here ( $p=\frac{3}{2}$ ),

& =5 c^{\prime 2} \sigma^{5}-\frac{7 \cdot 5^{4}}{48} c^{\prime 6} \sigma^{15}+\frac{79 \cdot 11 \cdot 5^{5}}{7 \cdot 2^{7} \cdot 3^{2}} c^{110} \sigma^{25}+\cdots \tag{54}
\end{align*}

From these coefficients, we have $<\tau_{n}>=<\tau_{\frac{10 g-5}{3}}>,(g=2,5,8, \ldots)$.

Since there is a rescaling between $y$ and $\sigma$, these integrals are reduced to the contour integral over $z=\sigma^{2}$,

which gives for $g=8, I=\frac{79 \cdot 11 \cdot 5^{5}}{7 \cdot 2^{7} \cdot 3^{2}}$, and for $g=11, I=-\frac{191 \cdot 5^{7} \cdot 13^{2}}{11 \cdot 7 \cdot 3^{4} \cdot 2^{10}}$.
To verify that the continuation to $p=\frac{3}{2}$ makes sense, we compare the results (55) with the previous integer- $p$ intersection numbers. The results for the coefficients of $\sigma^{15}$ and $\sigma^{25}$ correspond to $g=5$ and $g=8$. These cases were computed in [2] for general $p$. For $g=5$, it reads

To compare with the second term of (55), we multiply it by $1 /\left(4 p^{5}\right)=\left(\frac{2}{3}\right)^{5} / 4$. We take $c^{\prime}=c / 40$. This agrees with (57) if one takes into account the factor $1 / 5$ !, which comes from the regularization of the infinite factor $\Gamma(1-$ $\left.\frac{9}{p}\right)=\frac{1}{5!} \Gamma(0)$ for $p=3 / 2$. Note that the divergence $\Gamma(0)$ is cancelled by the denominator gamma factor $\Gamma\left(1-\frac{1+l}{p}\right)$ if we take $l=p-1=\frac{1}{2}$, which originated from (21). (Note this cancellation is $\Gamma(0) / \Gamma(0)=1$, and it is not the cancellation in the limit of $\epsilon \rightarrow 0$ for $p=\frac{3}{2}+\epsilon$ since $\epsilon \rightarrow 0$ gives some additional numerical facor.)

For the third term of (54) of order $\sigma^{25}$, we confirm the continuation to half-integer $p$ with the expression for the intersection number $<\tau_{n, m}>_{g=8}$
in [2]. Thus the continuation to $p=\frac{3}{2}$ for the computation of intersection numbers of $p$-spin curves, is valid as for $p=\frac{1}{2}$, through the contour integral calculation.

For $p=\frac{3}{2}$, there are also intersection numbers from NS punctures $(l \neq$ -1 ). Putting $p=\frac{3}{2}$ in (54), we obtain the intersection numbers for NS punctures. The components of the spin $p=\frac{3}{2}$ are $l=-1,-\frac{1}{2}$ and 0 . The intersection number $<\tau_{n, l}>$ is given by the coefficient of $\sigma^{n+\frac{2}{3}(1+l)}$. We have the intersection numbers $<\tau_{1,0}>_{g=1},<\tau_{8,-\frac{1}{2}}>_{g=3},<\tau_{11,0}>_{g=4}$. Therefore they belong to the NS type punctures $(l \neq-1)$.

These results may also be derived from (9). We have

This result is consistent with the last term of (14). Thus for NS punctures, we confirm the continuation from integer $p$ to the half-integral case, within again an infinite renormalization proportional to $\Gamma(0)$. The expansion of (61), yields a series of terms $\sigma^{5 / 3}, \sigma^{5}, \sigma^{25 / 3}$ of the form $\sigma^{n+\frac{2}{3}(1+l)}$, with $l=0$, $l=-1\left(\right.$ or $\left.1 / 2 \bmod p=\frac{3}{2}\right)$, and $l=-\frac{1}{2}$. Thus these terms provide the results for $\left.<\tau_{1,0}\right\rangle,<\tau_{4, \frac{1}{2}}>$ and $<\tau_{8,-\frac{1}{2}}>$, respectively.

- Two-point function for $p=\frac{3}{2}$

For the two-point function $U\left(\sigma_{1}, \sigma_{2}\right)$ of $p=\frac{3}{2}$, we have

& \times e^{c_{1} \sigma_{1}\left(5 y_{1}^{3}-\frac{10 \sigma_{1}^{2}}{y_{1}}+\frac{\sigma_{1}^{4}}{y_{1}^{5}}\right)+c_{1} \sigma_{2}\left(5 y_{2}^{3}-\frac{10 \sigma_{2}^{2}}{y_{2}}+\frac{\sigma_{2}^{4}}{y_{2}^{5}}\right)} \tag{63}
\end{align*}
$$

After rescaling, we obtain

& \times \frac{1}{\left(y_{1}^{2} \sigma_{1}^{-2 / 3}-\frac{\sigma_{1}^{8 / 3}}{y_{1}^{2}}-y_{2}^{2} \sigma_{2}^{-2 / 3}+\frac{\sigma_{2}^{8 / 3}}{y_{2}^{2}}\right)^{2}+4\left(\sigma_{1}+\sigma_{2}\right)^{2}} \\
& \times e^{c_{1}\left(5 y_{1}^{3}-\frac{10 \sigma_{1}^{10 / 3}}{y_{1}}+\frac{\sigma_{1}^{20 / 3}}{y_{1}^{5}}\right)+c_{2}\left(5 y_{2}^{3}-\frac{10 \sigma_{2}^{10 / 3}}{y_{2}}+\frac{\sigma_{2}^{20 / 3}}{y_{2}^{5}}\right)} \tag{64}

From this expression, we obtain the terms which contribute to $<\tau_{n_{1}, l_{1}} \tau_{n_{2}, l_{2}}>$ $\sigma_{1}^{n_{1}+\frac{2}{3}\left(1+l_{1}\right)} \sigma_{2}^{n_{2}+\frac{2}{3}\left(1+l_{2}\right)}$.

For the two-point function, we have $n_{1}+n_{2}=\frac{10}{3} g$, and the R-type is easily evaluated

The integrals over $y_{1}$ and $y_{2}$ factorize. The coefficient of $\sigma^{\frac{2}{3}}\left(=\sigma^{n+\frac{2}{3}(1+l)}\right)$ is $<\tau_{0,0}>$. The integral over $y_{1}$ gives a factor $\Gamma\left(-\frac{2}{3}\right)$. The integral over $y_{2}$, differs from (54) by a factor $\frac{1}{\sigma_{2}}$. Thus we have a string equation in the $p=\frac{3}{2}$ case for an NS-type puncture, similar to what we found for integer- $p$,

The term $\tau_{6,-1}$ is obtained from the coefficient of $\sigma_{2}^{6}$ as a contour integral around $y_{2}=0$.

Next we obtain the $\sigma_{1}^{4 / 3}$-term, which corresponds to $\left\langle\tau_{1,-\frac{1}{2}}\right\rangle$.

Thie coefficient of $\sigma_{1}^{4 / 3}$ gives $<\tau_{1,-\frac{1}{2}}>$ since $\sigma_{1}^{4 / 3}=\sigma_{1}^{n_{1}+\frac{2}{3}\left(1+l_{1}\right)}$ with $n_{1}=1$ and $l_{1}=-\frac{1}{2}$, and above $I$ gives $<\tau_{1,-\frac{1}{2}} \tau_{n_{2}, l_{2}}>$. In this case the selection rule reads $(g-1) \frac{10}{3}+\frac{4}{3}=n_{2}+\frac{2}{3} l_{2}$.

We have seen the string equation $\left(L_{-1}\right)$ related to $<\tau_{0,0}>$ in (67). The dilaton equation $\left(L_{0}\right)$ is related to $\left\langle\tau_{1,0}\right\rangle$. The coefficient here-above $<\tau_{1,-\frac{1}{2}>}$ is related to $L_{-\frac{1}{2}}$, where $L_{n}=z^{n} \partial_{z}$.

## - Three-point function for $p=\frac{3}{2}$

The factor $\sigma_{3}^{1 / 3}$ comes from the expansion of $\left(\sigma_{2}+\sigma_{3}\right)$ in the denominator. It satisfies the selection rule of $p=\frac{3}{2}$ for $<\tau_{n_{1}, l_{1}} \tau_{n_{2}, l_{2}} \tau_{n_{3}, l_{3}}>$,

This correlation is $\sigma_{1}^{\frac{4}{3}} \sigma_{2}^{\frac{1}{3}} \sigma_{3}^{0}$. This $\tau_{0,-1}$ plays the role of a dilaton equation, as was the case for $p=\frac{1}{2}$. This may be expressed conveniently by the introduction of a field $\phi_{i}$, conjugate to $\sigma^{\frac{i}{3}}$, i.e. $<\tau_{n+\frac{2}{3}(1+l)}>=<\phi_{3 n+2(1+l)}>$. Then this correlation is expressed from the primary field $\phi_{i}$ as $<\phi_{0} \phi_{1} \phi_{4}>$. The correlation $<\tau_{0,0} \tau_{0,0} \tau_{0,-\frac{1}{2}}>$ in (71) is expressed as $<\phi_{1} \phi_{2} \phi_{2}>$. Thus we found that there are two non-vanishing correlations for $<\phi_{1} \phi_{1} \phi_{2}>$ and $<\phi_{4} \phi_{1} \phi_{0}>$.

The fields $\phi_{0}$ and $\phi_{3}$ re related to R-type punctures. These terms give the structure factor $C_{i j k}$ as $\phi_{i} \phi_{j}=\sum C_{i j}{ }^{k} \phi_{k}$. The structure constant $C_{i j k}$ satisfies WDVV equation $[7,8]$,

where $\phi_{i} \phi_{j}=\sum C_{i j}{ }^{k} \phi_{k}$. The fields $\phi_{i}(i=0,1, . ., 4)$ are primary fields $(g=0)$ conjugate to $\sigma^{n+\frac{2}{3}(1+l)}\left(\phi_{i}=\sigma^{\frac{i}{3}}\right)$ and they own a ring structure. We have $C_{014}$ and $C_{112}$ from the three-point functions. $C_{014}=<\phi_{0} \phi_{1} \phi_{4}>=<$ $\tau_{0,-1} \tau_{0,-\frac{1}{2}} \tau_{1,-\frac{1}{2}}>_{g=0}$.

## - Four-point function for $p=\frac{3}{2}$

A representation of the four-point functions for $p$ spin curves follows from the same random matrix theory [3]. For genus $g=0$, we have three different cases, which satisfy the selection rule for $p=\frac{3}{2}, \frac{2}{3}=\sum_{i=1}^{4} n_{i}+\frac{2}{3} \sum_{i=1}^{4} l_{i}$;

& <\tau_{1,-1} \tau_{0,0} \tau_{0,0} \tau_{1,-1}>_{g=0} \sigma_{1} \sigma_{2}^{\frac{2}{3}} \sigma_{3}^{\frac{2}{3}} \sigma_{4} \tag{75}
\end{align*}

These are decomposed as three-point functions $<\tau_{1,-1} \tau_{0,0} \tau_{0,-1}>$ and $<$ $\tau_{1,-\frac{1}{2}} \tau_{0,-\frac{1}{2}} \tau_{0,-1}>$, in a conformal block decomposition.

The four-point function is obtained from the longest cycles in the determinant which occurs in the integral representation [3]. Neglecting terms of higher genus, we write one of the cycles (another longest cycle is obtained by permutation) as

& \times \frac{1}{\left(\frac{y_{1}^{2}}{\sigma_{1}^{2 / 3}}-\frac{y_{2}^{2}}{\sigma_{2}^{2 / 3}}+2 i\left(\sigma_{1}+\sigma_{2}\right)\right)} \frac{1}{\left(\frac{y_{2}^{2}}{\sigma_{2}^{2 / 3}}-\frac{y_{3}^{2}}{\sigma_{3}^{2 / 3}}+2 i\left(\sigma_{2}+\sigma_{3}\right)\right)} \\
& \times \frac{1}{\left(\frac{y_{3}^{2}}{\sigma_{3}^{2 / 3}}-\frac{y_{4}^{2}}{\sigma_{4}^{2 / 3}}+2 i\left(\sigma_{3}+\sigma_{4}\right)\right)} \frac{1}{\left(\frac{y_{4}^{2}}{\sigma_{4}^{2 / 3}}-\frac{y_{1}^{2}}{\sigma_{1}^{2 / 3}}+2 i\left(\sigma_{1}+\sigma_{4}\right)\right)} \tag{76}

From this expression, we obtain $\sigma_{1}^{4 / 3} \sigma_{2}^{1 / 3} \sigma_{3}^{4 / 3} \sigma_{4}^{1 / 3}$ term by expansion, which gives $<\tau_{1,-\frac{1}{2}} \tau_{0,-\frac{1}{2}} \tau_{0,-\frac{1}{2}} \tau_{1,-\frac{1}{2}}>$ in (75). The other two terms in (75) are not derived from (76).

The structure constant $C_{i j k}$ satisfies WDVV equation [7, 8],

where $\phi_{i} \phi_{j}=\sum C_{i j}{ }^{k} \phi_{k}$. The fields $\phi_{i}(i=0,1, . .4)$ are primary fields $(g=0)$ conjugate to $\sigma^{n+\frac{2}{3}(1+l)}\left(\phi_{i}=\sigma^{\frac{i}{3}}\right)$ and they make a ring structure. We have $C_{014}$ from the three-point functions $C_{014}=<\phi_{0} \phi_{1} \phi_{4}>=<\tau_{0,-1} \tau_{0,-\frac{1}{2}} \tau_{1,-\frac{1}{2}}>_{g=0}$. The four point function of $g=0(75)$ are $C_{14}{ }^{0} C_{014}$. The field $\phi_{0}$ connects the two conformal blocks $C_{i j 0}$, and $\phi_{0}$ is an R type puncture. So, ifor genus 0 , two R type punctures $\phi_{0}$ are contracted in pair in a four-point functions for $p=\frac{3}{2}$. This paired contraction seems to be a characteristic property of R-type punctures $\phi_{0}$.

From the relation to the generating function $F$ as $C_{i j k}=\frac{\partial^{3} F}{\partial t_{i} \partial t_{j} \partial t_{k}}[6,8,3]$, we have for $p=\frac{3}{2}$,

The first term is NS, and the second term involves an R-type puncture. For integer $p$, the corresponding $F$ is $p=3$, as shown in [3]. The first term is the same as for $p=3$, but $p=3$ does not have the R-type as the second term of (78).

## 6 Negative integer spins : $p=-2$ and $p=-3$

Whereas for positive integer $p$, there are no R-punctures, they do appear when $p$ is continued to negative integer values. Such R-punctures must then occur pairwise as implied by the selection rule (5) for $p=-2$.

- $p=-2$

When $p=-2$, the one-point correlation function reads

After the rescaling $y \rightarrow \sigma^{\frac{1}{4}} y$,

The expansion in powers of $\sigma$ is the same as the expansion found in the unitary matrix model. In [14], we have computed $U(\sigma)$ from the integral of (8), and confirmed the equivalence with a unitary matrix model. The expansion in powers of $y$ from (80) gives the same result. The integral reduces to a Gaussian integral, with a power series in $\sigma$ with coefficients involving $\Gamma\left(\frac{1}{2}\right)$. Expanding for small $\sigma$, we find terms $\sigma^{n-\frac{1}{2}}$, which are of the form $\sigma^{n+\frac{1}{p}(1+l)}$ with $l=0$. Those terms belong thus to the NS-type [1].

From (80), we have also lower genus terms. The term of order $\sigma^{-\frac{1}{2}}$ is $\sigma^{n-\frac{1}{2}(1+l)}$ with $n=0, l=0$, which is the genus 0 term $<\tau_{0,0}>_{g=0}$. The next order is $\sigma^{\frac{1}{2}}$, which is $n=1, l=0$. This term is genus 1 , and gives $<\tau_{1,0}>_{g=1}$. Note that in the expression of $U(\sigma)$ in (14), there is no divergent gamma factors for $p=-2$.

- Two-point function for $p=-2$

For the two-point function $U\left(\sigma_{1}, \sigma_{2}\right)$ for $p=-2$, we have after scaling,

& \frac{1}{\left(\sigma_{1}^{1 / 2} y_{1}^{2}-\frac{1}{\sigma_{1}^{1 / 2} y_{1}^{2}}-\sigma_{2}^{1 / 2} y_{2}^{2}+\frac{1}{\sigma_{2}^{1 / 2} y_{2}^{2}}\right)^{2}+4\left(\sigma_{1}+\sigma_{2}\right)^{2}} \tag{81}
\end{align*}
$$

Selecting the term proportional to $\sigma_{1}^{1 / 2}$, one gets

\end{equation*}

This term provides the result for $<\tau_{1,0} \tau_{n_{2}, 0}>\sigma_{1}^{1 / 2} \sigma_{2}^{n_{2}-\frac{1}{2}}$. Since the above integral is factorized, one finds that $<\tau_{1,0} \tau_{n_{2}, 0}>\sim<\tau_{n_{2}, 0}>$. This corresponds to a dilaton equation. In the unitary matrix model, it is known that there is no string equation but there is a dilaton equation [15].

There is also a term proportional to $\sigma_{1} \sigma_{2}$ in $U\left(\sigma_{1}, \sigma_{2}\right)$, which corresponds to $\sigma_{1}^{n_{1}-\frac{1}{2}\left(1+l_{1}\right)} \sigma_{2}^{n_{2}-\frac{1}{2}\left(1+l_{2}\right)}$ with $l_{1}=-1, l_{2}=-1$. This is a pair of R-type marked points $\left(l_{i}=-1\right)$. This paired R-type is expressed as $\left\langle\tau_{1,-1} \tau_{1,-1}\right\rangle$ $\sigma_{1} \sigma_{2}$, which corresponds to a genus $g=2$ term.

- Three-point function for $p=-2$

U\left(\sigma_{1}, \sigma_{2}, \sigma_{3}\right)= & \left(\sigma_{1} \sigma_{2} \sigma_{3}\right)^{1 / 2} \oint \frac{d y_{1} d y_{2} d y_{3}}{(2 i \pi)^{3}}\left(\frac{1}{\sigma_{1} y_{1}^{3}}+y_{1}\right)\left(\frac{1}{\sigma_{2} y_{2}^{3}}+y_{2}\right)\left(\frac{1}{\sigma_{3} y_{3}^{3}}+y_{3}\right) \\
& \times \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{2}\right)-\frac{1}{\sigma_{1}^{1 / 2} y_{1}^{2}}+\sigma_{1}^{1 / 2} y_{1}^{2}+\frac{1}{\sigma_{2}^{1 / 2} y_{2}^{2}}-\sigma_{2}^{1 / 2} y_{2}^{2}\right)} \\
& \times \frac{1}{\left(2 i\left(\sigma_{2}+\sigma_{3}\right)-\frac{1}{\sigma_{2}^{1 / 2} y_{2}^{2}}+\sigma_{2}^{1 / 2} y_{2}^{2}+\frac{1}{\sigma_{3}^{1 / 2} y_{3}^{2}}-\sigma_{3}^{1 / 2} y_{3}^{2}\right)} \\
& \times \frac{1}{\left(2 i\left(\sigma_{1}+\sigma_{3}\right)-\frac{1}{\sigma_{3}^{1 / 2} y_{3}^{2}}+\sigma_{3}^{1 / 2} y_{3}^{2}+\frac{1}{\sigma_{1}^{1 / 2} y_{1}^{2}}-\sigma_{1}^{1 / 2} y_{1}^{2}\right)} \\
\times & e^{c_{1} y_{1}^{4} \frac{1}{\left(1+\sigma_{1} y_{1}^{4}\right)^{2}}+c_{2} y_{2}^{4} \frac{1}{\left(1+\sigma_{2} y_{2}^{4}\right)^{2}}+c_{3} y_{3}^{4} \frac{1}{\left(1+\sigma_{3} y_{3}^{4}\right)^{2}}} \tag{83}

Let us note that there is a term of the form $<\tau_{1,0} \tau_{0,-1} \tau_{0,-1}>\sigma_{1}^{\frac{1}{2}} \sigma_{2}^{0} \sigma_{3}^{0}$. This is two R-type marked points and one NS-type, which is genus $g=0$.

There is also a term $\sigma_{1}^{3 / 2} \sigma_{2} \sigma_{3}$, after expansion of the denominator of (83), similar to the two-point function, and the coefficient is $\left\langle\tau_{2,0} \tau_{1,-1} \tau_{1,-1}\right\rangle$, which is a paired of R-type marked points plus one NS-type with $g=3$.

## - Pairwise punctures of R-type

The selection rule for negative $p$ is

For $p=-2$, the spin components $l_{i}$ take the values $l_{i}=0$ or $l_{i}=-1$. The number $s$ of marked points is divided as $s=m_{R}+m_{N S}$, where $m_{R}$ is the number with $l_{i}=-1$ (R type), and $m_{N S}$ is the number with $l_{i}=0$ (NS type). We set the number of boundary holes to zero. From (84), we have for $p=-2$

Since $g, m_{N S}, n_{i}$ are all integers, we have the condition that

where $N$ is a natural number, namely $m_{R}$ is even. Thus Ramond punctures should be paired, if $m_{R} \neq 0$.

- strong coupling expansion for $p=-2$

It is known that there is a phase transition in the unitary matrix model between weak coupling (small $\sigma$ ) and strong coupling (large $\sigma$ ) regions $[4,5]$. From (79), we expand the one-point function $U(\sigma)$ for large $\sigma$, after the replacement $y=x^{1 / 2}$,

& =\frac{1}{2} \sum \frac{1}{n!}\left(\frac{c^{\prime}}{\sigma}\right)^{n} \frac{\Gamma\left(n-\frac{1}{2}\right) \Gamma\left(n+\frac{1}{2}\right)}{\Gamma(2 n)} \tag{87}
\end{align*}

This expansion agrees with the known expansion for large $\sigma$, i.e. the strong coupling expansion [14] and with the unitary matrix model [4, 5]. The expression of the one-point function of (87) in the strong coupling region provides a confirmation that the $p=-2$ model is equivalent to the unitary matrix model.

We did not include here the logarithmic term, considered earlier in [14]. If included, the expression would be modified by an additional coefficient $N$ of the logarithmic term. The above expression provides the result for $N=0$.

This model of $p=-2$ has an interesting transition between the weak coupling regime and the strong coupling regime, as in lattice QCD at large N [5].

- $p=-3$

For $p=-3$, the one-point function reads

& =\frac{i}{2} \sigma^{2 / 3} \oint \frac{d y}{2 i \pi}\left(y+\frac{1}{\sigma^{4 / 3} y^{3}}\right) e^{c^{\prime}\left(y^{6}-\sigma^{4 / 3} y^{10}\right) /\left(\left(1+\sigma^{4 / 3} y^{4}\right)^{4}\right.} \tag{88}
\end{align*}
$$

where we have used the scaling $y \rightarrow \sigma^{1 / 3} y$. We have terms of order $\sigma^{n-\frac{1}{3}(1+l)}$ with $l=-1,0,1$.

For the two point function $U\left(\sigma_{1}, \sigma_{2}\right)$ of $p=-3$, we have, after similar re-scaling,

U\left(\sigma_{1}, \sigma_{2}\right)=\left(\sigma_{1} \sigma_{2}\right)^{\frac{2}{3}} \oint \frac{d y_{1} d y_{2}}{(2 \pi i)^{2}}\left(y_{1}+\frac{1}{\sigma_{1}^{4 / 3} y_{1}^{3}}\right)\left(y_{2}+\frac{1}{\sigma_{2}^{4 / 3} y_{2}^{3}}\right)
$$

$$
\begin{align*}
& e^{c^{\prime}\left(y_{1}^{6}-\sigma_{1}^{4 / 3} y_{1}^{10}\right) /\left(\left(1+\sigma_{1}^{4 / 3} y_{1}^{4}\right)^{4}+c^{\prime}\left(y_{2}^{6}-\sigma_{2}^{4 / 3} y_{2}^{10}\right) /\left(\left(1+\sigma_{2}^{4 / 3} y_{2}^{4}\right)^{4}\right.\right.} \\
& \frac{1}{\left(\sigma_{1}^{2 / 3} y_{1}^{2}-\frac{1}{\sigma_{1}^{2 / 3} y_{1}^{2}}-\sigma_{2}^{2 / 3} y_{2}^{2}+\frac{1}{\sigma_{2}^{2 / 3} y_{2}^{2}}\right)^{2}+4\left(\sigma_{1}+\sigma_{2}\right)^{2}} \tag{89}
\end{align*}
$$

The expansion of $U\left(\sigma_{1}, \sigma_{2}\right)$ gives for instance a $\left(\sigma_{1} \sigma_{2}\right)^{2}$ term which is a pair of R-type $<\tau_{2,-1} \tau_{2,-1}>_{g=3}$.

- strong coupling expansion for $p=-3$

There is a phase transition between a weak coupling and a strong coupling region, similar to $p=-2$. The strong coupling power series in $1 / \sigma$ expansion is obtained from the first equation of (88).

& =\frac{1}{16 \pi} \sum\left(\frac{c^{\prime}}{\sigma^{2}}\right)^{n} \frac{1}{n!} \int_{0}^{\infty} d t t^{\frac{3}{2} n-1} \frac{(t-1)^{n}}{(1+t)^{4 n-1}} \\
& =\frac{1}{16 \pi} \sum_{n=1}^{\infty}\left(\frac{c^{\prime}}{\sigma^{2}}\right)^{n} \sum_{m=0}^{n} \frac{1}{m!(n-m)!}(-1)^{m} \frac{\Gamma\left(\frac{5}{2} n-m\right) \Gamma\left(\frac{3}{2} n+m-1\right)}{\Gamma(4 n-1)} \tag{90}
\end{align*}
$$

In the case $p=-2$, we find that the strong coupling expansion agrees with character expansions [14]. For $p=-3$, we don't know the corresponding character expansions.

## 7 Random supermatrices

In [1], we have discussed a supermatrix formulation, which gives the correlation functions for two $p$ and $p^{\prime}$ mixed spin-curves. Both spin values of $p$ and $p^{\prime}$ are tuned by the two external sources which represent the bosonic and fermionic parts. We use the explicit representation Eq.(113) of [1], which reads

\times & \operatorname{det} \frac{1}{u_{i}-u_{j}+\frac{1}{2}\left(\sigma_{i}+\sigma_{j}\right)} \tag{91}
\end{align*}

with $c_{1}=\frac{n}{p^{2}-1} \sum_{i=1}^{p-1} \frac{1}{r_{i}^{p+1}}$, and $c_{2}=\frac{m}{p^{\prime 2}-1} \sum_{i=1}^{p^{\prime}-1} \frac{1}{\rho_{i}^{p^{\prime}+1}}$. In this formula, we have a freedom to chose a set of values for $p$ and $p^{\prime}$.

## - $D_{n}$ singularity

The choice of $p=n+1$ and $p^{\prime}=-2$ is related to a singularity of $D_{n}$ type, with a Landau-Ginzburg (LG) potential $W=x^{n-1}+x z^{2}-2 \lambda z$. There are generalizations to KP hierarchies, including positive and negative power series in the Landau-Ginzburg potential [8, 16]. This LG potential becomes $W=x^{n-1}-\lambda^{2} / x$ after integration over $z$. Other choices of $p$ and $p^{\prime}$ may give other singularities and topologies for Riemann surfaces. In the previous sections, we have discussed half-integer and negative integer $p$-spin cases. The supermatrix formulation [1], makes it possible to extend the spin moduli space to a space with two different spins $p$ and $p^{\prime}$.

If we specialize (91) to $p^{\prime}=-2$, arbitrary $p$, it yields a $D_{p+1}$ singularity, $\left(x^{2}+y^{2} z+z^{p}=0, p \geq 3\right)$. We then use the variable $y$ of (9), to write

$$
\begin{equation*}
g(y)=e^{c_{1}^{\prime} \sigma^{p+1}} \frac{1}{y^{2 p+2}}\left(\left(y^{2}-i\right)^{2 p+2}-\left(y^{2}-i\right)^{2 p+2}\right)+c_{2}^{\prime} \frac{1}{\sigma} \frac{y^{4}}{\left(1+y^{4}\right)^{2}} \tag{92}
\end{equation*}
$$

For the case $p=3\left(D_{4}\right)$, this gives

$$
\begin{equation*}
g(y)=e^{c_{1}^{\prime} \sigma^{4}(-16 i)\left(y^{6}-7 y^{2}+7 \frac{1}{y^{2}}-\frac{1}{y^{6}}\right)+c_{2}^{\prime} \frac{1}{\sigma} \frac{y^{4}}{\left(1+y^{4}\right)^{2}}} \tag{93}
\end{equation*}
$$

After rescaling $y \rightarrow \sigma^{-2 / 3} y$, and absorbing a factor $(-16 i)$ into $c_{1}^{\prime}$, we obtain

$$
\begin{equation*}
g(y)=e^{c_{1}^{\prime}\left(y^{6}-7 \sigma^{8 / 3} y^{2}+7 \sigma^{16 / 3} y^{-2}-\sigma^{8} y^{-6}\right)+c_{2}^{\prime} \sigma^{5 / 3} y^{-4}\left(1+\sigma^{8 / 3} / y^{4}\right)^{-2}} \tag{94}
\end{equation*}
$$

The one-point function becomes
$U(\sigma)=\frac{1}{\sigma^{4 / 3}} \int \frac{d y}{2 i \pi}\left(y+\frac{\sigma^{8 / 3}}{y^{3}}\right) e^{c_{1}^{\prime}\left(y^{6}-7 \sigma^{8 / 3} y^{2}+7 \sigma^{16 / 3} y^{-2}-\sigma^{8} y^{-6}\right)+c_{2}^{\prime} \sigma^{5 / 3} y^{-4}\left(1+\sigma^{8 / 3} / y^{4}\right)^{-2}}$
If $c_{2}^{\prime}=0$, there is no R-term. The contour integrals around $y=0$ for the terms $\sigma^{n}$ ( $n$ is integer) vanish. But if $c_{1}^{\prime}, c_{2} \neq 0$, there are terms of R-type, at order $\sigma^{n}$. For instance, expanding the exponent for small $\sigma$, we obtain at lowest order,

$$
\begin{equation*}
I=\left(c_{1}^{\prime}\left(c_{2}^{\prime}\right)^{2} \frac{1}{2} \sigma^{2}-6 c_{1}^{\prime} c_{2}^{\prime} \sigma^{3}\right) \oint \frac{d y}{2 i \pi}\left(\frac{1}{y}\right) \tag{96}
\end{equation*}
$$

These integer powers of $\sigma$ come from $\sigma^{n+\frac{1}{3}(1+l)}$ with $l=-1$.
As discussed in [1], for the supermatrices with $p^{\prime}<0$, logarithmic terms appear, which correspond to open boundaries of Riemann surfaces. For the unitary matrix case ( $p^{\prime}=-2$ ), this logarithmic term appears with a coefficient $N$, which is the number of D-branes [14].

- continuation to half-integers with boundaries, as in $p=\frac{1}{2}$

We consider $p=\frac{1}{2}$ with a logarithmic potential, since for $p=\frac{1}{2}$ there are only R- punctures in the bulk. The addition of boundaries by a logarithmic potential may provide additional R-punctures on the boundary.

We thus consider the correlation function $U\left(\sigma_{1}, \ldots \sigma_{s}\right)$ for $p=\frac{1}{2}$ and $p^{\prime}=$ -1 in (91). The one-point function reads

$$
\begin{equation*}
U(\sigma)=\frac{1}{2} \oint \frac{d u}{2 i \pi} e^{c_{1}\left(\frac{\sigma}{2}\right)^{3 / 2}\left[(u+1)^{3 / 2}-(u-1)^{3 / 2}\right]+N \log [(u+1) /(u-1)]} \tag{97}
\end{equation*}
$$

From (9), $u=\frac{i}{2}\left(y^{2}-\frac{1}{y^{2}}\right)$,

$$
\begin{align*}
& U(\sigma)=\frac{i}{2} \oint \frac{d y}{2 i \pi}\left(y+\frac{1}{y^{3}}\right) e^{c_{1}\left(\frac{\sigma}{2}\right)^{3 / 2}\left(\frac{i}{2}\right)^{1 / 2}\left(3 y-\frac{1}{y^{3}}\right)+2 N \log \left[\left(y^{2}-i\right) /\left(y^{2}+i\right)\right]} \\
& =\frac{i}{2 \sigma} \oint \frac{d y}{2 i \pi}\left(y+\frac{\sigma^{2}}{y^{3}}\right) e^{c_{1}^{\prime} \sigma\left(3 y-\frac{\sigma^{2}}{y^{3}}\right)+2 N \log \left[\left(1-i \sigma / y^{2}\right) /\left(1+i \sigma / y^{2}\right)\right]} \\
& =\frac{i}{2 \sigma} \oint \frac{d y}{2 i \pi}\left(y+\frac{\sigma^{2}}{y^{3}}\right)\left(1-\frac{4 i N \sigma}{y^{2}}-\frac{8 N^{2} \sigma^{2}}{y^{4}}+\frac{4 i}{3}\left(N+8 N^{3}\right) \frac{\sigma^{3}}{y^{6}}\right. \\
& \left.+\frac{16}{3}\left(N^{2}+2 N^{4}\right) \frac{\sigma^{4}}{y^{8}}-\frac{i}{5}\left(12 N+160 N^{3}+128 N^{5}\right) \frac{\sigma^{5}}{y^{10}}+\cdots\right) e^{c_{1}^{\prime} \sigma\left(3 y-\frac{\sigma^{2}}{y^{3}}\right)} \tag{98}
\end{align*}
$$

where the second line is obtained after scaling $y \rightarrow \sigma^{-1 / 2} y$, and the last line comes from the expansion in powers of the logarithmic term.

The expansion for small $\sigma$ provides the power series,

$$
\begin{align*}
U(\sigma)= & \frac{i}{2}\left[-4 i N-\frac{3}{2}\left(1-24 N^{2}\right) c_{1}^{\prime 2} \sigma^{3}+9 i\left(N+4 N^{3}\right) c_{1}^{\prime 4} \sigma^{6}\right. \\
& \left.-\frac{27}{80}\left(1-40 N^{2}-32 N^{4}\right) c_{1}^{\prime 6} \sigma^{9}+\cdots\right] \tag{99}
\end{align*}
$$

Thus we have found that the logarithmic term yields additional factors in the expression (13) of $U(\sigma)$.

Let us quote the result for the one-point function of integer $p$-th curve from [9].

$$
\begin{equation*}
U(\sigma)=\frac{1}{\sigma} \oint \frac{d u}{2 i \pi} e^{-\frac{1}{p+1}\left[\left(u+\frac{\sigma}{2}\right)^{p+1}-\left(u-\frac{\sigma}{2}\right)^{p+1}\right]+N \log \left(u+\frac{\sigma}{2}\right) /\left(u-\frac{\sigma}{2}\right)} \tag{100}
\end{equation*}
$$

By choosing the integration path around the cut, with $x=\sigma u^{p}$, it becomes

$$
\begin{align*}
& U(\sigma)=\frac{1}{p \sigma^{1+1 / p} \pi} \int_{0}^{\infty} d x x^{1 / p-1} e^{-x} e^{-\frac{p(p-1)}{3!4} \sigma^{2+2 / p} x^{1-2 / p}+\cdots} \\
& \times\left[1+N\left(\sigma^{1+1 / p} x^{-1 / p}+\frac{1}{12} \sigma^{3+3 / p} x^{-3 / p}+\cdots\right)\right]+\cdots \\
& =-\left(\frac{p-1}{24}+\frac{N^{2}}{2}\right) \frac{1}{\pi} \sigma^{1+\frac{1}{p}} \Gamma\left(1-\frac{1}{p}\right)+-\left(\frac{p}{24} N+\frac{1}{12} N^{3}\right) \frac{1}{\pi} \sigma^{2+\frac{2}{p}} \Gamma\left(1-\frac{2}{p}\right) \\
& -\frac{1}{144}\left[\frac{(p-1)(p-3)(1+2 p)}{40}+(3 p+1) N^{2}+2 N^{4}\right] \frac{1}{\pi} \sigma^{3+\frac{3}{p}} \Gamma\left(1-\frac{3}{p}\right)+\cdots \tag{101}
\end{align*}
$$

This expression is a modification of (14) with the boundary logarithmic potential.

It is remarkable that (99) agrees with the above expression (101) except for the gamma-function factor, which is divergent for $p=\frac{1}{2}$. This agreement of continuation to $p=\frac{1}{2}$ has been discussed in section 2 without logarithmic term. Here we check the continuation to half integer $p$ from integer $p$ in the presence of the logarithmic potential, except $\Gamma(0)$. Note that the powers of $\sigma$ and polynomials in $N$ agree between (99) and (101) with $p=\frac{1}{2}$.

In [9], we have obtained the intersection numbers

$$
\begin{equation*}
<\tau_{1,0}>=\frac{p-1+12 N^{2}}{24}, \quad<\tau_{2,1}>=\frac{1}{24}\left(p N+2 N^{3}\right) \tag{102}
\end{equation*}
$$

Thus $<\tau_{3}>$ of $p=\frac{1}{2}$ in the second term of (99) corresponds to $<\tau_{1,0}>$ in (102).

## 8 Summary and discussion

In this article, we have investigated the correlation functions of half-integral and negative integer-spins marked points by a random matrix formulation. We have shown how to evaluate the correlation functions in power series of $\sigma$ for R-type punctures, which provide integer powers of $\sigma$. The halfintegral spin $p$ cases include Ramond marked point $(l=-1) \bmod p$. We have confirmed the selection rule (5) for half integer spin $p$ in $s$ point functions. It is remarkable that the selection rule established for positive integer $p$ (5) remains valid for half integer and for negative integers.

For the negative $p=-2$, we found that R type punctures should be paired in (86). We have shown pair-wise punctures in the three=point functions in (83). We have investigated the correlation functions of such R-type marked points in details for the case of $p=\frac{1}{2}$. We have found that the structures between these intersection numbers are described by the equations, which have a similarity with the Virasoro algebra of integer $p$.

For genus zero and $p=\frac{3}{2}$, we have calculated the three-point function, which gives the structure constants $C_{i j k}$ for the algebra of the primary fields $\phi_{i}$. The characteristic new feature is the existence of $\tau_{0,-1}$ of R-type in a three-point function. This R-type puncture is similar to the twisted field $\phi_{*}$, which appears in $D_{n}$ singularity theory [8]. We have explicitly evaluated the three point correlation function and the structure constant $C_{i j k}$ for the primary field (genus 0). This structure extends to other half-integral spin cases such as $p=\frac{5}{2}$. In section seven, through a supermatrix formulation, we have discussed a $D_{4}$ singularity, which is related to R-type punctures [18].

The half-integral spin $p$ may have interesting applications to WZW models, which could be related to the fractional quantum Hall effect with half integral level $k=p-2$. Ramond marked points may have some application to the novel topological insulators and superconductors with Majorana fermion excitations at the boundaries, since both $R$ punctures and Majorana fermion appear pair-wise.
