# A Short Proof of the Localization Formula for the Loop Space Chern Character of Spin Manifolds

#### Abstract

In this note, we give a short proof of the localization formula for the loop space Chern character of a compact Riemannian spin manifold $M$, using the rescaled spinor bundle on the tangent groupoid associated to $M$.


## Introduction

In supersymmetric quantum mechanics, one is interested in the path integral corresponding to the $N=1 / 2$ supersymmetric $\sigma$-model, which mathematically can be viewed as an integration functional for differential forms $\xi$ on the loop space LM of a compact Riemannian spin manifold $M$. Formally, this should be given by the expression

$$
\begin{equation*}
\mathrm{I}[\xi]=\int_{L M} e^{-S+\omega} \wedge \xi \tag{0.1}
\end{equation*}
$$

where $S$ is the classical energy and $\omega$ is a certain canonical 2-form on the loop space. This formula and its close relation to the Atiyah-Singer index theorem has sparked interest for more than 30 years (see [Ati85, AG85] and the introduction of [GL19] for further references).

The path integral formula (0.1) has been finally given a rigorous interpretation for a certain class of differential forms $\theta$ in [HL17, GL19]; see also [Lud20]. Essentially, this is the class of iterated integrals, first considered by Chen [Che73] and later extended by Getzler, Jones and Petrack [GJP91] in order to contain the Bismut-Chern character forms first introduced by Bismut [Bis85]. Iterated integrals are the image of the iterated integral map, which maps the cyclic chain complex associated to the algebra $\Omega(M)$ of differential forms to the algebra $\Omega(L M)$ of differential forms on the loop space.

Pulling back the integration functional I of [HL17] with the iterated integral map, one obtains a coclosed functional on the cyclic chain complex of $\Omega(M)$, which we denote by $\mathrm{Ch}_{\mathrm{D}}$; namely, it has then been observed in [GL19] that this functional can be viewed as a non-commutative Chern character associated to a Fredholm module over $\Omega(M)$ determined by the Dirac operator $D$ on $M$, with a combinatorial formula similar to the JLO cocycle [JLO88].

[^0]The most remarkable feature of the loop space path integral I and its combinatorial counterpart $\mathrm{Ch}_{\mathrm{D}}$ is that they satisfy a localization formula of Duistermaat-Heckmann type, as though the loop space LM was a finite-dimensional manifold; see [HL17, Thm. 3.19] and [GL19, Thm. E]. This in particular facilitates the proof of the Atiyah Singer index theorem using loop space localization envisioned by Atiyah [Ati85].
Theorem. Let M be a compact Riemannian spin manifold of even dimension d and let c be an entire cyclic chain over $\Omega(M)$. If c is closed, then

$$
\begin{equation*}
\mathrm{Ch}_{\mathrm{D}}(\mathrm{c})=\frac{1}{(2 \pi \mathfrak{i})^{\mathrm{d} / 2}} \int_{M} \hat{A}(M) \wedge \mathfrak{i}(\mathrm{c}) \tag{0.2}
\end{equation*}
$$

Here $\hat{A}(M)$ denotes the $\hat{A}$-genus-form, and $i$ is the combinatorial analog of the map that restricts a differential form on the loop space to the fixed point set $M \subset L M$ (see (1.12) below). In fact, we prove formula (0.2) more generally for entire cyclic chains over the acyclic extension $\Omega_{\mathbb{T}}(M)$ of $\Omega(M)$ (see $\S 1.1$ below), which is necessary in order to encompass the Bismut-Chern characters.

The purpose of this note is to give a short proof of the above theorem using Connes' tangent groupoid and its extension to the spinor bundle introduced by Higson and the second-named author [HY19, Yi19]. The strategy is as follows: Rescaling of the Fredholm module yields a one-parameter family of Chern-characters $\left\{\mathrm{Ch}_{t}\right\}_{t>0}$, which are all cohomologous on suitable complexes by the the homotopy invariance of the Chern character. For closed chains, formula (0.2) therefore follows from calculating the limit of $\mathrm{Ch}_{\mathrm{t}}$, as $\mathrm{t} \rightarrow 0$; the result is Thm. 1.9 below, which can be understood as a "loop space version" of a corresponding result of Block-Fox on the JLO cocycle [BF90, Thm. 4.1].

It is the calculation of this limit for which the machinery of the tangent groupoid is particularly useful. In brief, the Chern character is defined as the supertrace of a certain family of operators, the kernels of which turn out to patch together to define a smooth section of the rescaled spinor bundle $\mathbb{S}$ over the tangent groupoid $\mathbb{T M}$ that can be extended down to zero. Here one then has a one-parameter family of supertraces at disposal (defined in [HY19]), which allow to easily calculate the value at zero.

Below, we briefly explain the construction of the Chern characters $\mathrm{Ch}_{\mathrm{t}}$ and reduce the proof of formula (0.2) to the calculation of the short time limit of $\mathrm{Ch}_{\mathrm{t}}$. This is essentially algebraic. In the second part of this note, we briefly recount the theory of the rescaled spinor bundle and prove the relevant Thm. 1.9 below.

## 1 The Chern character

In this section, we give a short review of the construction of the Chern character associated to the Fredholm module over $\Omega(M)$ determined by the Dirac operator over a compact Riemannian spin manifold. We focus on the algebraic construction, leaving out many analytical details; for these, we refer to [GL19].

### 1.1 The bar complex

Let $M$ be a manifold and let $\Omega(M)$ its complex of (complex-valued) differential forms. The acyclic extension of $\Omega(M)$ is the algebra $\Omega_{\mathbb{T}}(M):=\Omega(M)[\sigma]$, where $\sigma$ is a formal variable of degree -1 satisfying $\sigma^{2}=0$. Elements of $\Omega_{\mathbb{T}}(M)$ will be written as $\theta=$ $\theta^{\prime}+\sigma \theta^{\prime \prime}$ with $\theta^{\prime}, \theta^{\prime \prime} \in \Omega(M) . \Omega_{\mathbb{T}}(M)$ has a differential $d_{\mathbb{T}}=d-\iota$, where $d$ is the deRham differential and $\iota$ is defined by $\iota\left(\theta^{\prime}+\sigma \theta^{\prime \prime}\right)=\theta^{\prime \prime}$. Since $d_{\mathbb{T}}$ is not homogeneous, $\Omega_{\mathbb{T}}(M)$ is only $\mathbb{Z}_{2}$-graded.
1.1 Remark. In [GJP91], the algebra $\Omega(M \times \mathbb{T})^{\mathbb{T}}$ of $\mathbb{T}$-invariant differential forms on $M \times \mathbb{T}$ is used (where $\mathbb{T}=S^{1}$ ). This corresponds to our setup through setting $\sigma=\mathbf{t}^{2} d \varphi$, where $\varphi$ is the coordinate of $\mathbb{T}$ and $\boldsymbol{t}$ is a formal variable of degree -1 . Carrying around the formal variable $\mathbf{t}$ would allow us to stay $\mathbb{Z}$-graded throughout, but we feel that for this presentation, it is simpler to leave this variable out and to just take the grading $\bmod 2$.

The bar complex of $\Omega_{\mathbb{T}}(M)$ is

$$
\mathrm{B}\left(\Omega_{\mathbb{T}}(M)\right)=\bigoplus_{N=0}^{\infty} \Omega_{\mathbb{T}}(M)\langle 1\rangle^{\otimes N},
$$

where $\Omega_{\mathbb{T}}(M)\langle 1\rangle$ denotes a grading shift, i.e. $\left(\Omega_{\mathbb{T}}(M)\langle 1\rangle\right)^{\ell}=\Omega_{\mathbb{T}}^{\ell+1}(M)$. There are two differentials on $B\left(\Omega_{\mathbb{T}}(M)\right)$, given on homogeneous elements by

$$
\begin{aligned}
& b_{0}\left(\theta_{1}, \ldots, \theta_{N}\right)=\sum_{k=1}^{N}(-1)^{n_{k-1}}\left(\theta_{1}, \ldots, \theta_{k-1}, d_{\mathbb{T}} \theta_{k}, \ldots, \theta_{N}\right) \\
& b_{1}\left(\theta_{1}, \ldots, \theta_{N}\right)=-\sum_{k=1}^{N-1}(-1)^{n_{k}}\left(\theta_{1}, \ldots, \theta_{k-1}, \theta_{k} \wedge \theta_{k+1}, \theta_{k+2}, \ldots, \theta_{N}\right),
\end{aligned}
$$

where $n_{k}=\left|\theta_{1}\right|+\cdots+\left|\theta_{k}\right|-k$. Here elements of $B\left(\Omega_{\mathbb{T}}(M)\right)$ are written as $\left(\theta_{1}, \ldots, \theta_{N}\right)$, omitting the tensor signs for brevity. The above differentials satisfy $b_{0} b_{1}+b_{1} b_{0}=0$, hence turn $B\left(\Omega_{\mathbb{T}}(M)\right)$ into a ( $\mathbb{Z}_{2}$-graded) bi-complex with total differential $b:=b_{0}+b_{1}$. The differentials descend to the subspace

$$
\begin{equation*}
B^{\natural}\left(\Omega_{\mathbb{T}}(M)\right)=\operatorname{span}\left\{\sum_{k=0}^{N}(-1)^{n_{k}\left(n_{N}-n_{k}\right)}\left(\theta_{k+1}, \ldots, \theta_{N}, \theta_{1}, \ldots, \theta_{k}\right)\right\} \tag{1.1}
\end{equation*}
$$

of cyclic chains, making it a subcomplex.
1.2 Remark. The significance of the space $B\left(\Omega_{\mathbb{T}}(M)\right)$ for loop space geometry is that via Chen's iterated integral map, it provides a combinatorial model for the space of equivariant differential forms on the loop space of $M$ via the (extended) iterated integral map $\rho$ [Che73, GJP91]. Explicitly, it is given by the formula

$$
\begin{equation*}
\rho\left(\theta_{1}, \ldots, \theta_{N}\right)=\int_{\Delta_{N}}\left(\iota_{k} \theta_{1}^{\prime}\left(\tau_{1}\right)+\theta^{\prime \prime}\left(\tau_{1}\right)\right) \wedge \cdots \wedge\left(\iota_{k} \theta_{N}^{\prime}\left(\tau_{N}\right)+\theta^{\prime \prime}\left(\tau_{N}\right)\right) d \tau \tag{1.2}
\end{equation*}
$$

where we wrote $\theta(\tau)$ for the pullback of $\theta \in \Omega(M)$ by the evaluation-at- $\tau$-map $\operatorname{ev}_{\tau}$ : $L M \rightarrow M, \gamma \mapsto \gamma(\tau)$ and $\iota_{K}$ denotes insertion of the velocity vector field $K(\gamma)=\dot{\gamma}$ on LM. The iterated integral map can be viewed as a differential form counterpart of the Jones isomorphism [Jon87], which connects the bar complex of the dg algebra of singular chains on $M$ to chains on the loop space.

A straightforward calculation shows that the iterated integral map sends the subspace $B^{\natural}\left(\Omega_{\mathbb{T}}(M)\right)$ of cyclic chains to the space $\Omega(L M)^{\mathbb{T}} \subset \Omega(L M)$ of equivariant differential forms (where $\mathbb{T}$ acts by rotation) and on this domain intertwines the differential $b=b_{0}+b_{1}$ with the equivariant differential $d+t_{k}$ on $L M$.

The Bismut-Chern characters alluded to above in fact do not live in $B\left(\Omega_{\mathbb{T}}(M)\right)$ but in the larger complex of entire chains $B_{\epsilon}\left(\Omega_{\mathbb{T}}(M)\right)$, which allows certain infinite sums of chains. It is defined as the closure of $B\left(\Omega_{\mathbb{T}}(M)\right)$ with respect to the seminorms

$$
\begin{equation*}
\epsilon_{k}(c):=\sum_{N=0}^{\infty} \frac{\left\|c_{N}\right\|_{k, N}}{\lfloor N / 2\rfloor!} \quad \text { for } \quad c=\sum_{N=0}^{\infty} c_{N} \tag{1.3}
\end{equation*}
$$

Here $c_{N} \in \Omega_{\mathbb{T}}(M)\langle 1\rangle^{\otimes N} \subset \Omega\left(M^{N}\right)\left[\sigma_{1}, \ldots, \sigma_{N}\right]\langle N\rangle$ and $\|-\|_{k, N}$ denotes the $C^{k}$ norm on $\Omega\left(M^{N}\right)$; see [GL19, §3.3] for details. The differential $b$ extends to the entire complex and in total, we have the hierarchy of chain complexes


The Bismut-Chern character $\mathrm{Ch}(\mathrm{p})$ defined below are entire cyclic chains, while the Chern character $\mathrm{Ch}_{\mathrm{D}}$ (to be defined in the next section) is a linear functional, which is a priori defined on $B\left(\Omega_{\mathbb{T}}(M)\right)$ but turns out to satisfy the necessary estimates to extend to the space of entire chains. In particular, $\mathrm{Ch}_{\mathrm{D}}$ can be evaluated on $\mathrm{Ch}(\mathrm{p})$.
1.3 Example. The Bismut-Chern characters forms on the loop space $L M$ were first defined in [Bis85], while there combinatorial versions, to be reviewed now, were introduced by Getzler-Jones Petrack [GJP91, §6]. Let $p$ be a smooth function on $M$ with values in $M_{n}(\mathbb{C})$ such that $p^{2}=p$ and let $p^{\perp}=1-p$. Then $E:=\operatorname{im}(p)$ is a vector bundle on $M$, which inherits a natural metric and connection from the trivial $\mathbb{C}^{n}$ bundle over $M$ (in fact, any vector bundle with connection on $M$ can be realized this way [NR61, Thm. 1]). We set

$$
\begin{equation*}
\mathcal{R}:=(2 p-1) d p+\sigma(d p)^{2} \tag{1.4}
\end{equation*}
$$

which is an odd element of $\Omega_{\mathbb{T}}(M)$. The (cyclic) Bismut Chern character of p is then defined by

$$
\begin{equation*}
\operatorname{Ch}(p):=\sum_{\mathrm{N}=0}^{\infty}(-1)^{\mathrm{N}} \sum_{\mathrm{k}=0}^{\mathrm{N}} \operatorname{tr}(\underbrace{\mathcal{R}, \ldots, \mathcal{R}}_{\mathrm{k}}, \sigma p, \underbrace{\mathcal{R}, \ldots, \mathcal{R}}_{\mathrm{N}-\mathrm{k}}) \tag{1.5}
\end{equation*}
$$

where $\operatorname{tr}$ is the functional defined for elements $\Theta_{1}, \ldots, \Theta_{N} \in \Omega_{\mathbb{T}}(M) \otimes M_{n}(\mathbb{C})$ by

$$
\operatorname{tr}\left(\Theta_{1}, \ldots, \Theta_{N}\right)=\sum_{a_{1}, \ldots, a_{N}=1}^{n}\left(\Theta_{1} a_{a_{N}}^{a_{1}}, \Theta_{2}^{a_{1}}, \ldots, \Theta_{N_{a_{N-1}}}^{a_{N}}\right) .
$$

Due to the grading shift in the definition of $B\left(\Omega_{\mathbb{T}}(M)\right)$, it is an even chain, which is clearly cyclic, i.e. contained in the subcomplex (1.1). It was shown by [GJP91, §6] that the iterated integral map (1.2) sends $\mathrm{Ch}(\mathrm{p})$ to the Bismut-Chern character form on $\Omega(\mathrm{LM})$, defined in [Bis85]. A complication of the theory is that $\mathrm{Ch}(\mathrm{p})$ is not closed with respect to the differential $b$; instead $b(\mathrm{Ch}(\mathrm{p}))$ is contained in a certain subcomplex of $B_{\epsilon}^{\natural}\left(\Omega_{\mathbb{T}}(M)\right)$. One says that $C h(p)$ is closed as a Chen normalized cochain, see [GL19, §7].

### 1.2 Cochains and the Chern character

Given a $\mathbb{Z}_{2}$-graded algebra ${ }^{1} \mathcal{L}$, an $\mathcal{L}$-valued bar cochain over $\Omega_{\mathbb{T}}(M)$ is a linear map $\ell: B\left(\Omega_{\mathbb{T}}(M)\right) \rightarrow \mathcal{L}$. Such a cochain can be viewed as a sequence of multilinear maps

$$
\ell: \underbrace{\Omega_{\mathbb{T}}(M) \times \cdots \times \Omega_{\mathbb{T}}(M)}_{N} \rightarrow \mathcal{L},
$$

again denoted by the same letter. In particular, for $N=0$, this is just an element of $\mathcal{L}$, which we denote by $\ell(\emptyset)$, by abuse of notation. We say that $\ell$ is even if it preserves parity and odd if it reverses parity. The standard coalgebra structure on the tensor algebra $B\left(\Omega_{\mathbb{T}}(M)\right)$ induces a product on bar cochains, given by

$$
\begin{equation*}
\left(\ell_{1} \ell_{2}\right)\left(\theta_{1}, \ldots, \theta_{N}\right)=\sum_{k=0}^{N}(-1)^{n_{k}\left|\ell_{2}\right|} \ell_{1}\left(\theta_{1}, \ldots, \theta_{k}\right) \ell_{2}\left(\theta_{k+1}, \ldots, \theta_{N}\right), \tag{1.6}
\end{equation*}
$$

where $n_{k}=\left|\theta_{1}\right|+\cdots+\left|\theta_{k}\right|-k$. This product is compatible with the codifferential $\beta$ on cochains defined by

$$
(\beta \ell)\left(\theta_{1}, \ldots, \theta_{N}\right)=-(-1)^{|\ell|} \ell\left(b\left(\theta_{1}, \ldots, \theta_{N}\right),\right.
$$

in the sense that $\beta\left(\ell_{1} \ell_{2}\right)=\beta\left(\ell_{1}\right) \ell_{2}+(-1)^{\left|\ell_{1}\right|} \ell_{1} \beta\left(\ell_{2}\right)$ for all homogeneous cochains $\ell_{1}, \ell_{2}$; in other words, $\beta$ is a derivation on the cochain algebra.

To obtain interesting cochains on $B\left(\Omega_{\mathbb{T}}(M)\right.$ ), one starts with a Fredholm module over $\Omega(M)$, which is a triple ( $\mathrm{H}, \mathrm{Q}, \mathrm{c}$ ), consisting of a $\mathbb{Z}_{2}$-graded Hilbert space H , an odd operator $Q$ on $H$ and an even linear map $c: \Omega(M) \rightarrow B(H)$, which are assumed to satisfy

$$
\begin{equation*}
[Q, c(f)]=c(d f)], \quad \text { and } \quad c(f \theta)=c(f) c(\theta) \tag{1.7}
\end{equation*}
$$

for $f \in \Omega^{0}(M)$ and $\theta \in \Omega(M)$, together with some further analytic conditions; see [GL19, §2] for details.

[^1]1.4 Example. Our main example here is defined in case that $M$ is an even-dimensional compact spin manifold with spinor bundle $S$; in that case, $H=L^{2}(M, S), Q=D$, the Dirac operator, and $c$ is the quantization map (see $\$ 2.1$ below).

Inspired by Quillen [Qui88], a Fredholm module induces a connection $\omega$, which is a cochain on $B\left(\Omega_{\mathbb{T}}(M)\right)$ with values in linear operators on $H$, given by

$$
\omega(\emptyset)=-Q, \quad \omega(\theta)=c\left(\theta^{\prime}\right), \quad \omega\left(\theta_{1}, \ldots, \theta_{k}\right)=0(k \geq 2) .
$$

Due to the grading shift in the definition of $\mathrm{B}\left(\Omega_{\mathbb{T}}(M)\right)$, this is an odd cochain. Its curvature is defined by the formula $F:=\beta \omega+\omega^{2}$. Explicitly, its components can be easily calculated to be $F(\emptyset)=Q^{2}$,

$$
\begin{align*}
F(\theta) & =c\left(d \theta^{\prime}\right)-\left[Q, c\left(\theta^{\prime}\right)\right]-c\left(\theta^{\prime \prime}\right),  \tag{1.8}\\
F\left(\theta_{1}, \theta_{2}\right) & =(-1)^{\left|\theta_{1}\right|}\left(c\left(\theta_{1}^{\prime}\right) c\left(\theta_{2}^{\prime}\right)-c\left(\theta_{1}^{\prime} \wedge \theta_{2}^{\prime}\right)\right)
\end{align*}
$$

and $F\left(\theta_{1}, \ldots, \theta_{k}\right)=0$ for $k \geq 3$; here $\left[Q, c\left(\theta^{\prime}\right)\right]$ denotes the graded commutator. Motivated by the definition of the Chern-character from Chern-Weil theory, one now makes the following definition.
1.5 Definition. The Chern character of a Fredholm module (H, Q, c) is the bar cochain

$$
\begin{equation*}
\mathrm{Ch}_{\mathrm{Q}}=\operatorname{Str}\left(e^{-F}\right) . \tag{1.9}
\end{equation*}
$$

Here, because F takes values in unbounded operators on H and some care is needed to make sense of the exponential. This is dealt with by writing $F=Q^{2}+F^{\prime}$ and expanding $e^{-F}=e^{-Q^{2}-F^{\prime}}$ as a perturbation series. This results in the formula

$$
\begin{equation*}
C h_{Q}=\sum_{N=0}^{\infty}(-1)^{N} \int_{\Delta_{N}} \operatorname{Str}\left(e^{-\tau_{1} Q^{2}} \prod_{p=1}^{N} F^{\prime} e^{-\left(\tau_{p+1}-\tau_{p}\right) Q^{2}}\right) d \tau \tag{1.10}
\end{equation*}
$$

where $\Delta_{N}=\left\{0 \leq \tau_{1} \leq \cdots \leq \tau_{N} \leq \tau_{N+1}:=1\right\}$ is the $N$-simplex, giving an explanation to the right hand side of (1.9).
1.6 Proposition. Restricted to the space of cyclic chains, we have $\beta\left(\mathrm{Ch}_{\mathrm{Q}}\right)=0$.

Proof (Sketch). Since $\beta$ is a derivation with respect to the product (1.6), the curvature $F$ satisfies the Bianchi identity

$$
\beta F=\beta^{2} \omega+\beta\left(\omega^{2}\right)=(\beta \omega) \omega-\omega(\beta \omega)=F \omega-\omega F=[F, \omega] .
$$

Hence

$$
\beta(C h)=\operatorname{Str}\left(\beta\left(e^{-F}\right)\right)=-\operatorname{Str}\left(e^{-F} \beta F\right)=-\operatorname{Str}\left(e^{-F}[F, \omega]\right)=-\operatorname{Str}\left(\left[e^{-F}, \omega\right]\right) .
$$

One now verifies that the right hand side is zero when restricted to cyclic chains to finish the proof. The above calculations are somewhat formal and the proof remains a sketch here due to the analytical difficulties involved in defining $e^{-F}$; a complete treatment is given in [GL19, §4].

In order to evaluate $\mathrm{Ch}_{\mathrm{Q}}$ at the Bismut-Chern characters (1.5), one needs the following proposition; see [GL19, Thm. B].
1.7 Proposition. The Chern character is analytic, i.e. continuous with respect to the seminorms (1.3) and hence extends to a cochain on the entire complex $B_{\epsilon}\left(\Omega_{\mathbb{T}}(M)\right)$.

Before we give an explicit formula for the components of $\mathrm{Ch}_{\mathrm{D}}$, we slightly generalize our Example 1.4. Namely, given a parameter $t>0$, one can define a new Fredholm module $\left(H, Q_{t}, c_{t}\right)$ by setting $Q_{t}=t D$ and $c_{t}(\theta)=t^{|\theta|} c(\theta)$. Observing that the relations (1.7) still hold, one obtains a one-parameter family $\left\{\mathrm{Ch}_{t}\right\}$ of Chern characters. Plugging the product formula (1.6) into the perturbation series (1.10), one obtains the explicit but somewhat cumbersome combinatorial formula

$$
\begin{align*}
& \mathrm{Ch}_{\mathfrak{t}}\left(\theta_{1}, \ldots, \theta_{\mathrm{N}}\right)= \\
& \quad \sum_{\substack{k=1 \\
1 \leq \mathfrak{i}_{1}<\cdots<i_{k} \leq N}}^{N} \mathrm{t}^{|\theta|-N+2 k} \int_{\Delta_{k}} \operatorname{Str}\left(e^{-\mathrm{t}^{2} \tau_{1} D^{2}} \prod_{\mathfrak{p}=1}^{k} F\left(\theta_{i_{p-1}+1}, \ldots, \theta_{i_{p}}\right) e^{-t^{2}\left(\tau_{\mathfrak{p}+1}-\tau_{\mathfrak{p}}\right) D^{2}}\right) d \tau, \tag{1.11}
\end{align*}
$$

for homogeneous elements $\theta_{1}, \ldots, \theta_{N} \in \Omega_{\mathbb{T}}(M)$, where and $|\theta|=\left|\theta_{0}\right|+\cdots+\left|\theta_{N}\right|$ is the total degree. This formula can be understood as a certain time-ordered expectation value, where, since the operators $F$ vanish when more than two entries are filled, only neighboring $\theta_{i}$ "interact".

### 1.3 The localization formula

We now aim to prove the localization formula (0.2) for closed entire cyclic chains c, where the restriction map is the map $i: B\left(\Omega_{\mathbb{T}}(M)\right) \rightarrow \Omega(M)$ given by

$$
\begin{equation*}
\mathfrak{i}\left(\theta_{1}, \ldots, \theta_{N}\right)=\frac{1}{\mathrm{~N}!} \theta_{1}^{\prime \prime} \wedge \ldots \wedge \theta_{N}^{\prime \prime} ; \tag{1.12}
\end{equation*}
$$

here, as always, $\theta_{i}=\theta_{i}^{\prime}+\sigma \theta_{i}^{\prime \prime} \in \Omega_{\mathbb{T}}(M)$.
1.8 Remark. The above map satisfies $\mathfrak{i}\left(\theta_{1}, \ldots, \theta_{N}\right)=\mathfrak{j}^{*} \rho\left(\theta_{1}, \ldots, \theta_{N}\right)$, where $\rho$ is the iterated integral map (1.2) and $\mathfrak{j}^{*}$ denotes the pullback with respect to the inclusion $j: M \rightarrow L M$ as the subset of constant loops (notice here that since the image of $\mathfrak{j}$ is the set of constant loops, the integral over $\Delta_{\mathrm{N}}$ in (1.2) is constant and integration contributes a factor of $\operatorname{vol}\left(\Delta_{N}\right)=1 / N!$ ). In this sense, $i$ is a combinatorial version of the pullback map $j^{*}$.

Let $M$ be a compact Riemannian spin manifold of even dimension $d$, so that the family $\left\{\left(\mathrm{H}, \mathrm{Q}_{\mathrm{t}}, \mathrm{c}_{\mathrm{t}}\right)\right\}_{\mathrm{t}>0}$ of Fredholm modules together with the corresponding family of Chern characters $\left\{\mathrm{Ch}_{\mathrm{t}}\right\}_{t>0}$ introduced in $\S 1.2$ is defined. By Homotopy invariance of the Chern character [GL19, Thm. 6.2], for any $s, t>0$, there exists an analytic bar cochain $\mathrm{CS}_{s, t}$ such that, when restricted to $B_{\epsilon}^{\natural}\left(\Omega_{\mathbb{T}}(M)\right)$,

$$
\begin{equation*}
\mathrm{Ch}_{s}-\mathrm{Ch}_{\mathrm{t}}=\beta \mathrm{CS}_{s, t} ; \tag{1.13}
\end{equation*}
$$

in other words $\mathrm{Ch}_{\mathrm{s}}, \mathrm{Ch}_{\mathrm{t}}$ are cohomologous as cyclic chains. Explicitly, this means that for all entire cyclic chains $c \in B_{\epsilon}^{\natural}\left(\Omega_{\mathbb{T}}(M)\right)$, we have

$$
\mathrm{Ch}_{\mathrm{D}}(\mathrm{c})-\mathrm{Ch}_{\mathrm{t}}(\mathrm{c})=\beta \mathrm{CS}_{1, \mathrm{t}}(\mathrm{c})=-\mathrm{CS}_{1, \mathrm{t}}(\mathrm{~b}(\mathrm{c})) .
$$

Therefore, if c is additionally closed, i.e. $\mathrm{b}(\mathrm{c})=0$, then $\mathrm{Ch}(\mathrm{c})=\mathrm{Ch}_{\mathrm{t}}(\mathrm{c})$ for all $\mathrm{t}>0$.
The above discussion shows that we can compute the value of $\mathrm{Ch}(\mathrm{c})$ by taking the limit of $\mathrm{Ch}_{\mathrm{t}}(\mathrm{c})$, as $\mathrm{t} \rightarrow 0$. The localization formula ( 0.2 ) therefore follows from the following theorem, which is proved in $\S 2$.
1.9 Theorem. For all $\theta_{1}, \ldots, \theta_{N} \in \Omega_{\mathbb{T}}(M)$, we have

$$
\begin{equation*}
\lim _{\mathfrak{t} \rightarrow 0} \mathrm{Ch}_{\mathfrak{t}}\left(\theta_{1}, \ldots, \theta_{\mathrm{N}}\right)=\frac{1}{(2 \pi \mathfrak{i})^{\mathrm{d} / 2} \mathrm{~N}!} \int_{M} \hat{A}(M) \wedge \theta_{1}^{\prime \prime} \wedge \ldots \wedge \theta_{N}^{\prime \prime} \tag{1.14}
\end{equation*}
$$

where the characteristic form $\hat{A}(M)$ is given by

$$
\begin{equation*}
\hat{A}(M)=\operatorname{det}^{1 / 2}\left(\frac{R / 2}{\sinh (R / 2)}\right) \tag{1.15}
\end{equation*}
$$

We finish this section with an application of the localization formula, which features the Bismut-Chern characters from Example 1.3; compare [GL19, §8].
1.10 Proposition. Let $p \in \Omega(M) \otimes M_{n}(\mathbb{C})$ with $p^{2}=p$ and define

$$
D_{p}=p D p+(1-p) D(1-p)
$$

where by abuse of notation, D denotes the Dirac operator on $\mathrm{S} \otimes \underline{\mathbb{C}}^{\mathrm{n}}$. Then

$$
\mathrm{Ch}_{\mathrm{D}}(\mathrm{Ch}(\mathrm{p}))=\operatorname{Str}\left(\mathrm{p} e^{-\mathrm{D}_{\mathrm{p}}}\right) .
$$

By the McKean-Singer formula, the supertrace $\operatorname{Str}\left(\mathrm{p}^{-D_{p}}\right)$ is just the index of the Dirac operator twisted with the vector bundle $E=\operatorname{im}(p)$. Since $\mathfrak{i}(\operatorname{Ch}(p))$ is easily worked out to be the Chern character of the bundle E, this combines with the localization formula (0.2) to yield the Atiyah-Singer index theorem.

We remark that in the above argument, we have cheated a little bit, since $\operatorname{Ch}(p)$ is not closed strictly, but only closed modulo a certain subcomplex. However, since $\mathrm{Ch}_{\mathrm{t}}$ and $\mathrm{CS}_{\mathrm{t}, \mathrm{s}}$ vanish on this subcomplex (see Thm. 5.5 of [GL19]), the localization formula also holds for the Bismut-Chern-characters.

Proof of Prop. 1.10. Observe that $\mathrm{D}_{\mathrm{p}}=\mathrm{D}+\mathrm{c}((2 \mathrm{p}-1) \mathrm{dp})$ and with $\mathcal{R}$ defined as in (1.4),

$$
\begin{aligned}
\mathrm{F}(\mathcal{R}) & =\mathrm{c}\left((\mathrm{dp})^{2}\right)-[\mathrm{D}, \mathrm{c}((2 p-1) \mathrm{dp})] \\
\mathrm{F}(\mathcal{R}, \mathcal{R}) & =\mathrm{c}((2 p-1) \mathrm{dp})^{2}+\mathrm{c}\left((\mathrm{dp})^{2}\right) .
\end{aligned}
$$

Put together,

$$
D_{p}^{2}=D^{2}+[D, c((2 p-1) d p)]+c((2 p-1) d p)^{2}=D^{2}-F(\mathcal{R})+F(\mathcal{R}, \mathcal{R})
$$

Writing $e^{-D_{p}}$ as a perturbation series, we therefore obtain

$$
e^{-D_{p}^{2}}=\sum_{N=0}^{\infty}(-1)^{N} \int_{\Delta_{N}} e^{-\tau_{1} D^{2}} \prod_{k=1}^{N}(F(\mathcal{R}, \mathcal{R})-F(\mathcal{R})) e^{-\left(\tau_{k+1}-\tau_{k}\right) D^{2}} d \tau
$$

By the cyclic permutation property of the supertrace, multiplying this by $p$ and taking the supertrace yields $\mathrm{Ch}_{\mathrm{D}}(\mathrm{Ch}(\mathrm{p}))$.

## 2 The tangent groupoid and the localization formula

In this section, we first give a brief introduction to the tangent groupoid and the rescaled spinor bundle and then use the techniques introduced to prove Thm. 1.9.

### 2.1 The scaling order

Let $M$ be an even-dimensional spin manifold with spinor bundle $S$. In this section, we briefly review the notion of scaling order for sections of the bundle $S \boxtimes S^{*}$ over $M \times M$, the fiber of which over $\left(m_{1}, m_{2}\right)$ is $S_{\mathfrak{m}_{1}} \otimes S_{\mathfrak{m}_{2}}^{*}$. For a more detailed treatment, we refer to [HY19, §3.3].

To begin with, denote by $\operatorname{Cliff}\left(T_{m} M\right)$ the Clifford algebra of $T_{m} M$ and let

$$
\mathrm{c}: \Lambda^{*} \mathrm{~T}_{\mathrm{m}} M \longrightarrow \operatorname{Cliff}\left(\mathrm{~T}_{\mathrm{m}} M\right)
$$

be the quantization map, defined by $e_{i_{1}} \wedge \ldots \wedge e_{i_{k}} \mapsto e_{i_{1}} \cdots e_{i_{k}}$ in terms of an orthonormal basis $e_{1}, \ldots, e_{n} \in T_{m} M$; see [BGV92, §3.1] for details. $c$ is not an algebra homomorphism, but defining $\operatorname{Cliff}_{k}\left(T_{m} M\right)$ to be the image of $\Lambda^{\leq k} T_{m} M$ under $c$ defines a filtration on the Clifford algebra. An element a of the Clifford algebra is said to have Clifford order $k$ or less if it is contained in $\operatorname{Cliff}_{k}\left(\mathrm{~T}_{\mathrm{m}} M\right)$. For $a \in \operatorname{Cliff}\left(\mathrm{~T}_{\mathrm{m}} M\right)$, we denote by $[\mathrm{a}] \in \Lambda^{*} \mathrm{~T}_{\mathrm{m}} \mathrm{M}$ its inverse image under the quantization map (often called the Clifford symbol) and if $a \in \operatorname{Cliff}_{k}\left(T_{m} M\right)$, we let $[a]_{k}$ be the $k$-form component of $[a] \in \Lambda^{\leq k} T_{m} M$.

A differential operator $P$ has Getzler order $p$ or less if locally, it can be written as

$$
P=\mathrm{fD}_{1} \cdots \mathrm{D}_{\mathrm{p}},
$$

where $f$ is a smooth function, and each $D_{i}$ is either a covariant derivative $\nabla_{X}$, a Clifford multiplication $c(X)$, or the identity operator. The definition of scaling order now uses the fact that on the diagonal of $M \times M$, we have the identification

$$
\left(S \boxtimes S^{*}\right)_{(m, m)} \cong S_{m} \otimes S_{m}^{*} \cong \operatorname{End}\left(S_{\mathfrak{m}}\right) \cong \operatorname{Cliff}\left(T_{m} M\right)
$$

2.1 Definition. [HY19, §3.4] - Let $p \in \mathbb{Z}$. We say that a section $s$ of $S \boxtimes S^{*}$ has scaling order $p$ or more if for every $m \in M$,

$$
\text { Clifford-order }\left(\left.\operatorname{Ds}(-, m)\right|_{m}\right) \leq q-p
$$

for every differential operator D of Getzler order q or less, acting on the first component of $s$.

### 2.2 The tangent groupoid and the rescaled spinor bundle

The tangent groupoid was introduced by Alain Connes to give a simple and elegant proof of the Atiyah-Singer index theorem [Con94, Chapter 2, Section 5]. Given smooth manifold $M$, the tangent groupoid $\mathbb{T M}$ is a smooth manifold whose underlying set is

$$
\mathbb{T M}=(\mathbb{T M} \times\{0\}) \sqcup\left(M \times M \times \mathbb{R}^{\times}\right)
$$

If $M \supset \mathrm{U} \xrightarrow{\varphi} \mathbb{R}^{n}$ is a local coordinate chart, then $\mathbb{T U} \subset \mathbb{T} M$ is an open subset and there is a local coordinate chart

$$
\mathbb{T U} \xrightarrow{\Phi} \mathbb{R}^{2 n+1}
$$

given by

$$
\left\{\begin{array}{l}
(x, m, t) \rightarrow\left(\frac{\varphi(x)-\varphi(m)}{t}, \varphi(m), t\right)  \tag{2.1}\\
(X, m, 0) \rightarrow\left(\varphi_{*} X, \varphi(m), 0\right) .
\end{array}\right.
$$

In [HSSH18], the authors adopt a more algebraic way towards the tangent groupoid, namely it is built as spectrum of the following algebra.
2.2 Definition. Denote by $A(\mathbb{T} M) \subseteq C^{\infty}(M \times M)\left[t^{-1}, t\right]$ the $\mathbb{R}$-algebra of those Laurent polynomials

$$
\begin{equation*}
\sum_{p \in \mathbb{Z}} f_{p} t^{-p} \tag{2.2}
\end{equation*}
$$

for which each coefficient $f_{p}$ is a smooth, real-valued function on $M \times M$ that vanishes to order $\geq p$ on $M$ (and all but finitely many $f_{p}$ are zero).

In general, the spectrum of an algebra comes naturally with a topology, the Zariski topology. In this particular case, the spectrum of $\mathcal{A}(\mathbb{T M})$ turns out to have a smooth manifold structure which coincides with the manifold structure on $\mathbb{T M}$ defined above. A Laurent polynomial of the form (2.2) naturally defines a smooth function on the tangent groupoid $\mathbb{T M}$, and the evaluation maps are given by

$$
\begin{aligned}
& \varepsilon_{(x, m, \lambda)}: \sum_{\mathfrak{p} \in \mathbb{Z}} f_{p} t^{-\mathfrak{p}} \longmapsto \sum_{\mathfrak{p} \in \mathbb{Z}} f_{p}(x, m) \lambda^{-p} \\
& \varepsilon_{(X, m)}: \sum_{p \in \mathbb{Z}} f_{p} t^{-p} \longmapsto \sum_{p \in \mathbb{Z}} \frac{1}{p!} x^{p}\left(f_{p}\right) .
\end{aligned}
$$

The set of smooth functions on $\mathbb{T M}$ is locally smoothly generated by these functions (see [HSSH18, Lemma 2.4]).

Let $M$ be an even dimensional spinor manifold with spinor bundle $S \rightarrow M$. In order to introduce Getzler's rescaling technique in the context of the tangent groupoid, by deforming $S$, we build a vector bundle $\mathbb{S} \rightarrow \mathbb{T} M$ over the tangent groupoid, following the construction in [HY19]. This bundle is called the rescaled bundle and it is built from the following $A(M)$-module.
2.3 Definition. Denote by $S(\mathbb{T M})$ the complex vector space of Laurent polynomials

$$
\begin{equation*}
\sum_{p \in \mathbb{Z}} s_{p} t^{-p} \tag{2.3}
\end{equation*}
$$

where each $s_{p}$ is a smooth section of $S \boxtimes S^{*}$ of scaling order at least $p$.
The complex vector space $S(\mathbb{T} M)$ so constructed is indeed a $A(M)$-module, the module structure is given by the Laurent polynomial multiplication. It turns out the module $S(\mathbb{T M})$ can be made into a sheaf of locally free modules over the sheaf of smooth functions on $\mathbb{T M}$, thus giving rise to the rescaled bundle $\mathbb{S} \rightarrow \mathbb{T} M$.

A Laurent polynomial of the form (2.3) naturally defines a smooth section of $\mathbb{S}$ whose evaluation map is given by

$$
\begin{align*}
\varepsilon_{(x, \mathfrak{m}, \lambda)} & : \sum_{\mathfrak{p} \in \mathbb{Z}} s_{\mathfrak{Z}} t^{-\mathfrak{p}} \longmapsto \sum_{\mathfrak{p} \in \mathbb{Z}} s_{\mathfrak{p}}(x, \mathfrak{m}) \lambda^{-\mathfrak{p}}  \tag{2.4}\\
\varepsilon_{(X, \mathfrak{m})} & : \sum_{\mathfrak{p} \in \mathbb{Z}} s_{\mathfrak{Z}} t^{-\mathfrak{p}} \longmapsto \sum_{\mathfrak{q}, \mathfrak{p}} \frac{1}{\mathfrak{q}!}\left[\left.\nabla_{X}^{\mathfrak{q}} s_{p}(-, \mathfrak{m})\right|_{\mathfrak{m}}\right]_{\mathfrak{q}-\mathfrak{p}} \tag{2.5}
\end{align*}
$$

where $\nabla_{X}$ is the covariant derivative acting on the first variable of $S \boxtimes S^{*}$ and $[\cdot]_{k}$. Observe here that since $s_{p}$ has scaling order at least $p,\left.\nabla_{X}^{q} s_{p}(-, m)\right|_{m} \in \operatorname{Cliff}\left(T_{m} M\right)$ has Clifford order at most $q-p$ at each $m \in M$, hence its ( $q-p$ )-th Clifford symbol is well-defined. A general smooth section $f$ of $\mathbb{S}$ can locally be written as a finite sum

$$
\begin{equation*}
f=\sum_{j} f_{j} \cdot s_{j} \tag{2.6}
\end{equation*}
$$

where $f_{j} \in C^{\infty}(\mathbb{T} M)$ and the $s_{j}$ are Laurent polynomials of the form (2.3), which determine smooth sections of $\mathbb{S}$ denoted by the same symbol.

Set theoretically, over $M \times M \times\{\mathrm{t}\}$, the rescaled bundle is the tensor product bundle $S \boxtimes S^{*}$ and the fibers over $T M \times\{0\}$ is the pullback of the exterior bundle $\wedge^{*} T^{*} M \rightarrow M$ along $\pi: \mathrm{TM} \rightarrow \mathrm{M}$.


The space of compactly supported smooth sections of the rescaled bundle has an algebra structure in the following way: For $f, g \in C_{c}^{\infty}(\mathbb{T M}, \mathbb{S}), f * g \in C_{c}^{\infty}(\mathbb{T M}, \mathbb{S})$ is defined by

$$
\begin{align*}
& (f * g)(x, m, t)=\int_{M} f(x, y, t) g(y, m, t) t^{-n} d y \\
& (f * g)(X, m, 0)=\int_{T_{m} M} f(X-Y, m, 0) g(Y, m, 0) e^{-\frac{1}{2}[k(X, Y)]} d Y \tag{2.7}
\end{align*}
$$

where $(x, m, t) \in M \times M \times \mathbb{R}^{\times}$and $(X, m, 0) \in \mathbb{T M} \times\{0\}$ and where $k$ is the curvature tensor of the spinor bundle (so that $\kappa(X, Y) \in C \operatorname{liff}\left(T_{m} M\right)$ for $X, Y \in T_{m} M$ ) and $[\kappa(X, Y)] \in \Lambda T_{m} M$ is the inverse image of the Clifford algebra element $\kappa(X, Y)$ under the quantization map (see [HY19, Section 5.2]). Crucially, we will use the following result.
2.4 Theorem. [HY19, Theorem 5.4.2] - For each $t \in \mathbb{R}$, the formula

$$
\begin{align*}
& \operatorname{Str}_{t}(f)=\int_{M} \operatorname{str}(f(m, m, t)) t^{-n} d m \quad \text { for } t \neq 0 \\
& \operatorname{Str}_{0}(f)=\left(\frac{2}{i}\right)^{d / 2} \int_{M} f(0,-, 0) \tag{2.8}
\end{align*}
$$

defines a supertrace on $\mathrm{C}_{\mathrm{c}}^{\infty}(\mathbb{T M}, \mathbb{S})$; here in the second integral, $\mathrm{f}(0,-, 0)$ is a differential form on $M$, which is integrated using the orientation on $M$. Moreover, the map $t \mapsto \operatorname{Str}_{t}(f)$ is smooth.
2.5 Remark. For $t \neq 0$, the traces $\operatorname{Str}_{t}$ can be viewed as an integral over the $t$-fiber of $\mathbb{T M}$, when the fibers are equipped with the rescaled metric $\mathrm{t}^{-2} \mathrm{~g}$. The theorem then asserts that the formula for $\mathrm{Str}_{0}$ is the continuous (even smooth) extension of this family to the fiber over $t=0$.

### 2.3 Rapidly decaying sections

Let $M$ be a compact Riemannian spin manifold of even dimension d. A disadvantage of the algebra $\mathrm{C}_{\mathrm{c}}^{\infty}(\mathbb{T M}, \mathbb{S})$ considered above is that it is too small to contain the "heat kernel element" $e^{-\mathrm{t}^{2} \mathrm{D}^{2}}$. In this section, we shall construct an enlargement $\mathcal{S}(\mathbb{T} M, \mathbb{S})$ of this algebra consisting of sections of rapid decay, in particular $e^{-t^{2} D^{2}}$, and this still supports the family of supertraces (2.8).
2.6 Definition. Let $f$ be a compactly supported smooth section of the rescaled bundle. Define a family of norms $\left\{\mathrm{N}_{\mathrm{k}}\right\}, \mathrm{k} \in \mathbb{N}$, on $\mathrm{C}_{\mathrm{c}}^{\infty}(\mathbb{T M}, \mathbb{S})$ by

$$
\begin{equation*}
N_{k}(f)=\sup _{(x, m, t) \in M \times M \times \mathbb{R}^{x}}\left(1+\frac{d(x, m)^{2}}{t^{2}}\right)^{k / 2}|f(x, m, t)| \tag{2.9}
\end{equation*}
$$

where $d(x, m)$ is the Riemannian distance between $x$ and $m$ and let

$$
\mathcal{S}(\mathbb{T} M, \mathbb{S}):=\left\{\mathrm{f} \in \mathrm{C}(\mathbb{T} M, \mathbb{S}) \mid \forall \mathrm{k} \in \mathbb{N}: \mathrm{N}_{\mathrm{k}}(\mathrm{f})<\infty\right\}
$$

2.7 Lemma. The following holds:
(1) $\mathcal{S}(\mathbb{T M}, \mathbb{S})$ is complete and $\mathrm{C}_{\mathrm{c}}^{\infty}(\mathbb{T M}, \mathbb{S}) \subset \mathcal{S}(\mathbb{T} M, \mathbb{S})$ is dense.
(2) The convolution product extends continuously to a product on $\mathcal{S}(\mathbb{T M}, \mathbb{S})$.
(3) Each of the supertraces (2.8) extends continuously to $\mathcal{S}(\mathbb{T M}, \mathbb{S})$ and for each $f \in \mathcal{S}(\mathbb{T M}, \mathbb{S})$, $\mathrm{Str}_{\mathrm{t}}(\mathrm{f})$ is continuous in t .

Proof. (1) Let $\left\{\varphi_{\alpha}: M \supset \mathrm{U}_{\alpha} \rightarrow \mathbb{R}^{n}\right\}$ be a collection of coordinate charts on $M$ and let $\left\{\phi_{\alpha}: \mathbb{T} U_{\alpha} \rightarrow \mathbb{R}^{2 n+1}\right\}$ be the induced coordinate charts on $\mathbb{T} M$, as given in (2.1). One then easily shows that restricted to $\mathbb{T} \mathrm{U}_{\alpha}$, the seminorm $\mathrm{N}_{\mathrm{k}}$ is equivalent to the seminorm

$$
\sup _{(a, b, t) \in \phi_{\alpha}\left(\mathbb{T} \mathrm{U}_{\alpha}\right)}\left(1+|a|^{2}\right)^{k / 2}\left|f \circ \phi_{\alpha}^{-1}(a, b, t)\right| .
$$

The rest follows from routine arguments.
(2) We calculate

$$
\begin{aligned}
N_{k}(f * g)= & \sup _{(x, m, t)}\left(1+\frac{d(x, m)^{2}}{t^{2}}\right)^{k / 2}\left|\int_{M} f(x, y, t) g(y, m, t) t^{-n} d y\right| \\
\leq & C_{k} \sup _{(x, m, t)}\left|\int_{M}\left(1+\frac{d(x, y)^{2}}{t^{2}}\right)^{k / 2} f(x, y, t) g(y, m, t) t^{-n} d y\right| \\
& +C_{k} \sup _{(x, m, t)}\left|\int_{M} f(x, y, t)\left(1+\frac{d(y, m)^{2}}{t^{2}}\right)^{k / 2} g(y, m, t) t^{-n} d y\right|
\end{aligned}
$$

$$
\begin{aligned}
\leq & C_{k} N_{k+n+1}(f) N_{0}(g) \sup _{(x, t)} \int_{M}\left(1+\frac{d(x, y)^{2}}{t^{2}}\right)^{-(n+1) / 2} t^{-n} d y \\
& +C_{k} N_{n+1}(f) N_{k}(g) \sup _{(x, t)} \int_{M}\left(1+\frac{d(x, y)^{2}}{t^{2}}\right)^{-(n+1) / 2} t^{-n} d y
\end{aligned}
$$

where $C_{k}$ is a constant such that for all $a, b \geq 0$,

$$
(1+a+b)^{k / 2} \leq C_{k}(1+a)^{k / 2}+C_{k}(1+b)^{k / 2} .
$$

It remains to show that the integral

$$
\begin{equation*}
\int_{M}\left(1+\frac{d(x, y)^{2}}{t^{2}}\right)^{-(n+1) / 2} t^{-n} d y \tag{2.10}
\end{equation*}
$$

is uniformly bounded with respect to $t \in \mathbb{R}^{\times}$. For $\varepsilon>0$, split the integral up in one integral over $M \backslash B_{\varepsilon}(x)$ and one over $B_{\varepsilon}(x)$. The first of these is clearly bounded, and the second one can be estimated by the integral

$$
\int_{\mathrm{B}_{\varepsilon}(0)}\left(1+\frac{|\nu|^{2}}{\mathrm{t}^{2}}\right)^{-(n+1) / 2} \mathrm{t}^{-\mathrm{n}} \mathrm{~d} \nu=\int_{\mathrm{B}_{\varepsilon / t}(0)}\left(1+|\xi|^{2}\right)^{-(n+1) / 2} \mathrm{~d} \xi
$$

over Euclidean space. In the second step we replaced $\xi=v / \mathrm{t}$ to obtain an expression which is clearly bounded.
(3) For $t \neq 0$, the formula (2.8) clearly extends to a continuous linear functional on $\mathcal{S}(\mathbb{T M}, \mathbb{S})$. In the case $t=0$, we observe that by (1) above, elements $f \in \mathcal{S}(\mathbb{T M}, \mathbb{S})$ satisfy $|f(X, m, 0)| \leq C_{k}\left(1+|X|^{2}\right)^{k / 2}$ for any $k \in \mathbb{N}$. Hence also the second formula in (2.8) extends to a continuous linear functional on $\mathcal{S}(\mathbb{T M}, \mathbb{S})$. To show continuity at $t=0$, let $f_{i} \in C_{c}(\mathbb{T M}, \mathbb{S})$ be compactly support sections with $f_{i} \rightarrow f$ in $\mathcal{S}(\mathbb{T M}, \mathbb{S})$. Then

$$
\left|\operatorname{Str}_{t}(f)-\operatorname{Str}_{0}(f)\right| \leq\left|\operatorname{Str}_{t}(f)-\operatorname{Str}_{t}\left(f_{i}\right)\right|+\left|\operatorname{Str}_{t}\left(f_{i}\right)-\operatorname{Str}_{0}\left(f_{i}\right)\right|+\left|\operatorname{Str}_{0}\left(f_{i}\right)-\operatorname{Str}_{0}(f)\right| .
$$

The second term converges to zero by Thm. 2.4, and the first and the third by continuity of $\operatorname{Str}_{\mathrm{t}}$. This finishes the proof.

### 2.4 The heat kernel element

We now show that the space $\mathcal{S}(\mathbb{T M}, \mathbb{S})$ of rapidly decaying sections of $\mathbb{S}$ contains the "heat kernel element" $e^{-t^{2} D^{2}}$.
2.8 Lemma. Let f be a smooth section of $\mathrm{S} \boxtimes S^{*} \rightarrow \mathrm{M} \times \mathrm{M} \times \mathbb{R}$. Then $\mathrm{t}^{\mathrm{n+1}} \mathrm{f}$ defines a smooth section of the rescaled bundle $\mathbb{S} \rightarrow \mathbb{T M}$ such that

$$
\left(t^{n+1} f\right)(\gamma)= \begin{cases}t^{n+1} f(x, y, t) & \gamma=(x, y, t) \\ 0 & \gamma=(x, m, 0)\end{cases}
$$

Proof. As a $C^{\infty}(M \times M \times \mathbb{R})$ module, $C^{\infty}\left(M \times M \times \mathbb{R}, S \boxtimes S^{*}\right)$ is locally finitely generated and free. We could choose $s_{1}, s_{2}, \cdots, s_{p}$ a sequence of local sections of $S \boxtimes S^{*} \rightarrow M \times M$ such that $f$ can be locally written as combination of $s_{1}, \cdots, s_{p}$. That is

$$
t^{n+1} f(x, y, t)=f_{1}(x, y, t) t^{n+1} s_{1}(x, y)+\cdots+f_{p}(x, y, t) t^{n+1} s_{p}(x, y)
$$

locally, for some smooth functions $f_{1}, f_{2}, \cdots, f_{p}$ on $M \times M \times \mathbb{R}$. Here $t^{n+1} s_{i}$ defines local section of the rescaled bundle and its value at ( $X, m, 0$ ) which can be evaluated by (2.5) is clearly zero.
2.9 Proposition. For each $\tau>0$, there is $\mathrm{H}_{\tau} \in \mathcal{S}(\mathbb{T M}, \mathbb{S})$ such that for $\mathrm{t}>0$,

$$
\begin{equation*}
\mathrm{H}_{\tau}(\mathrm{x}, \mathrm{~m}, \mathrm{t})=\mathrm{t}^{\mathrm{n}} e^{-\mathrm{t}^{2} \tau \mathrm{D}^{2}}(\mathrm{x}, \mathrm{~m}) \tag{2.11}
\end{equation*}
$$

where $\mathrm{e}^{-\mathrm{t}^{2} \tau \mathrm{D}^{2}}(\mathrm{x}, \mathrm{m})$ is the heat kernel of D . Moreover, this element satisfies

$$
\begin{equation*}
H_{\tau}(X, m, 0)=\frac{1}{(4 \pi \tau)^{n / 2}} \operatorname{det}^{1 / 2}\left(\frac{\tau R / 2}{\sinh (\tau R / 2)}\right) \exp \left(-\frac{1}{4 \tau}\left\langle x, \frac{\tau R}{2} \operatorname{coth}\left(\frac{\tau R}{2}\right) x\right\rangle\right) \tag{2.12}
\end{equation*}
$$

where R is the Riemannian curvature tensor, interpreted as a skew-adjoint matrix of differential 2-forms in a local frame.

Proof. We need a slight refinement of Thm. 4.1 of [BGV92]. By the asymptotic expansion of the heat kernel, near the diagonal in $M \times M$, we have

$$
\begin{equation*}
t^{\mathrm{d}} \cdot e^{-\mathrm{t}^{2} \tau \mathrm{D}^{2}}(x, m)=\frac{1}{(4 \pi \tau)^{\mathrm{d} / 2}} e^{\frac{-\mathrm{d}(x, \mathfrak{m})^{2}}{4 t^{2} \tau}} \sum_{i=0}^{d / 2} t^{2 i} \tau^{i} \Theta_{i}(x, m)+\mathcal{O}\left(t^{\mathfrak{n + 1}}\right) \tag{2.13}
\end{equation*}
$$

where the $\Theta_{\mathfrak{i}}(-, m)$ are determined by system of differential equations

$$
\left\{\begin{array}{l}
\nabla_{\mathfrak{R}} \Theta_{0}(-, m)=0 \\
\left(\nabla_{\mathcal{R}}+\mathfrak{i}\right) \Theta_{\mathfrak{i}}(-, m)=-\mathrm{B} \Theta_{\mathfrak{i}-1}(-, \mathfrak{m})
\end{array}\right.
$$

with initial condition $\Theta_{0}(m, m)=1$, where $\mathcal{R}$ is the radial vector field associated with a Riemannian normal coordinate system around $m, B$ is a differential operators on $S$ of Getzler order 2 (see [BGV92, §2.5] for details). We claim that $\Theta_{i}$ has scaling order 2i. The first equation $\nabla_{\mathcal{R}} \Theta_{0}=0$ says that $\Theta_{0}(x, m)=P(x, m)$, the parallel translation operator which has scaling order 0 according to [HY19, Prop. 3.3.10]. The rest can be shown by an induction argument: Assume that $\Theta_{i-1}$ has scaling order $2 i-2$; then $B \Theta_{i-1}$ has scaling order 2 i . Since $\mathcal{R}$ vanishes at $m, \nabla_{\mathcal{R}}$ does not change the scaling order so that by the differential equation, $\Theta_{i}$ also has scaling order $2 i$. According to (2.6), the sum of the first $n$ terms in the asymptotic expansion defines a smooth section of $\mathbb{S}$. The remainder term $\mathcal{O}\left(\mathfrak{t}^{n+1}\right)$ is a section of $S \boxtimes S^{*} \rightarrow M \times M \times \mathbb{R}$ which satisfies the condition of Lemma 2.8. Overall, $H_{\tau}$ defines an element in $\mathrm{C}^{\infty}(\mathbb{T M}, \mathbb{S})$.

Next we shall show $N_{k}\left(H_{\tau}\right)<\infty$ for all $k$. If $x \neq y$, it is well known that the heat kernel rapidly decreasing as $t \rightarrow 0$. We only have to consider the case when $(x, y)$ is very close to the diagonal. In that case, the estimate is done by using the asymptotic expansion (2.13). Indeed, $\Theta_{i}(x, y)$ are all bounded near the diagonal, and

$$
\left(1+\frac{\mathrm{d}(x, m)^{2}}{\mathrm{t}^{2}}\right)^{\mathrm{k} / 2} e^{\frac{-\mathrm{d}(x, m)^{2}}{4 \mathrm{t}^{2} \tau}}
$$

is uniformly bounded in $(x, m, t)$ for any given $k$ and $\tau>0$. Therefore, $H_{\tau} \in \mathcal{S}(\mathbb{T} M, \mathbb{S})$.

The value of $\mathrm{H}_{\tau}(\mathrm{X}, \mathrm{m}, 0)$ is calculated for example in [BGV92, Thm 4.20] or [Roe88, Prop. 12.25] with other means. However, (2.12) can also be obtained within the framework of [HY19], as we explain now. Because D ${ }^{2}$ has Getzler order two, the results of $\S 3.6$ in [HY19] imply that $\mathrm{t}^{2} \mathrm{D}^{2}$ extends to an operator $\mathrm{D}^{2}$ on $\mathbb{T M}$, acting on sections of $\mathbb{S}$; over $\mathrm{t}=0$, it is given by is Getzler symbol, as computed e.g. in [Roe88, Prop. 12.17]. For $X \in T_{m} M \subset \mathbb{T} M$, the formula is

$$
\begin{equation*}
\varepsilon_{X}\left(\mathbf{D}^{2} s\right)=\text { L. } \varepsilon_{X}(s) \quad \text { with } \quad L=\sum_{i=1}^{d}\left(\frac{\partial}{\partial X_{i}}-\frac{1}{4} \sum_{j=1}^{d} R_{i j} X_{j}\right)^{2} . \tag{2.14}
\end{equation*}
$$

Here $\varepsilon_{X}=\varepsilon_{(X, m)}$ is the point evaluation map (2.5) and the components $X_{i}$ of $X$ and the $R_{i j} \in \Lambda^{2} T_{m} M$ are the components of the curvature tensor of $M$ defined with respect to some orthonormal basis of $T_{m} M$.

We want to show that for any $\tau>0$, we have

$$
\begin{equation*}
\varepsilon_{X}\left(\exp \left(-\tau \mathbf{D}^{2}\right) s\right)=\exp (-\tau L) \cdot \varepsilon_{X}(s) \tag{2.15}
\end{equation*}
$$

It suffices to verify this for all $s$ in the $\mathcal{A}(M)$-module $S(\mathbb{T M})$ (remember Def. 2.3), as the general section is a linear combination over $C^{\infty}(\mathbb{T M})$ of elements of $S(\mathbb{T M})$ and one easily checks that the formula (2.15) still holds when replacing s by $f \cdot s$ for $f \in C^{\infty}(\mathbb{T M})$. On $S(\mathbb{T M}), D^{2}$ acts as

$$
D^{2}: \sum_{p} s_{p} t^{-\mathfrak{p}} \mapsto \sum_{p} D^{2}\left(s_{p}\right) t^{-p+2} .
$$

Let $S_{0}(\mathbb{T M})$ be the quotient of $S(\mathbb{T M})$ by the subspace $t \cdot S(\mathbb{T M})$. Since the point evaluations $\varepsilon_{X}$ are zero on $t \cdot S(\mathbb{T M})$, they descend to $S_{0}(\mathbb{T M})$ and it suffices to verify (2.15) for $s \in S_{0}(\mathbb{T} M)$. However, since any section of $S \boxtimes S^{*}$ has scaling order at least -d, we see that the action of $\left(\tau D^{2}\right)^{N}$ is zero on $S_{0}(\mathbb{T M})$ for $N$ sufficiently large. Hence both sides of (2.15) are actually given by an exponential series truncated at some finite $N$, so that (2.15) follows from (2.14).

On the other hand, by (2.7),

$$
\begin{equation*}
\varepsilon_{X}\left(\exp \left(-\tau \mathbf{D}^{2}\right) s\right)=\int_{T_{m} M} \varepsilon_{X-Y}\left(H_{\tau}\right) e^{-\frac{1}{2}[\kappa(X, Y)]} \varepsilon_{Y}(s) d Y . \tag{2.16}
\end{equation*}
$$

Equations (2.15) and (2.16) together imply

$$
\begin{equation*}
\exp (-\tau L)(X, Y)=\varepsilon_{X-Y}\left(H_{\tau}\right) e^{-\frac{1}{2} \kappa(X, Y)} \tag{2.17}
\end{equation*}
$$

in particular, $\exp (-\tau L)(X, 0)=\varepsilon_{X}\left(H_{\tau}\right)$ which combined with Mehler's formula (see e.g. [BGV92, §4.2]) verifies (2.12).
2.10 Remark. Fix $m \in M$. The full integral kernel $\tilde{H}_{\tau}(X, Y):=e^{-\tau L}(X, Y)$ of the heat operator $e^{-\tau \mathrm{L}}$ on $\mathrm{T}_{\mathrm{m}} \mathrm{M}$ is given by Mehler's formula,

$$
\tilde{\mathrm{H}}_{\tau}(\mathrm{X}, \mathrm{Y})=(4 \pi)^{-n / 2} \cdot \operatorname{det}\left(\frac{\tau R / 2}{\sinh (\tau R / 2)}\right)^{1 / 2} \times
$$

$$
\times \exp \left(-\left\langle X, \frac{R}{8} \operatorname{coth}\left(\frac{\tau R}{2}\right) X\right\rangle+\left\langle X, e^{\tau R / 2} \frac{R}{4} \operatorname{cosech}\left(\frac{\tau R}{2}\right) Y\right\rangle-\left\langle Y, \frac{R}{8} \operatorname{coth}\left(\frac{\tau R}{2}\right) Y\right\rangle\right),
$$

see [BGV92, §4.2], which satisfies the convolution identity

$$
\tilde{H}_{\tau+\tau^{\prime}}(X, Z)=\int_{T_{m} M} \tilde{H}_{\tau}(X, Y) \tilde{H}_{\tau^{\prime}}(Y, Z) d Y
$$

Now one can check that $\tilde{H}_{\tau}(X, Y)=H_{\tau}(X-Y, m, 0) e^{-\frac{1}{2}[\kappa(X, Y)]}$, hence the element $H_{\tau}$ from above satisfies the twisted convolution identity

$$
H_{\tau+\tau^{\prime}}(X, m, 0)=\left(H_{\tau} * H_{\tau^{\prime}}(X, m, 0)=\int_{T_{m} M} H_{\tau}(X-Y, m, 0) H_{\tau^{\prime}}(Y, m, 0) e^{-\frac{1}{2}[\kappa(X, Y)]} d Y .\right.
$$

Of course, this twisted convolution identity $\mathrm{H}_{\tau+\tau^{\prime}}=\mathrm{H}_{\tau} * \mathrm{H}_{\tau^{\prime}}$ also follows from the semigroup property of $e^{-t^{2} \tau D^{2}}$, which holds for $t \neq 0$ and by continuity must continue to hold at zero. However, the above calculations show that the factor of $e^{-\frac{1}{2}[k(X, Y)]}$ appearing in the formula (2.7) for the twisted convolution precisely accounts for the failure of the Mehler kernel to be translation invariant.

### 2.5 Proof of Theorem 1.9

Let $M$ be a compact Riemannian spin manifold of even dimension $d$ and $t>0$. Given $\theta_{1}, \ldots, \theta_{N}$, the explicit formula (1.11) reveals that the corresponding Chern character $\mathrm{Ch}_{\mathrm{t}}\left(\theta_{1}, \ldots, \theta_{\mathrm{N}}\right)$ is a sum of terms of the form

$$
\begin{equation*}
t^{|\theta|+N-2 k} \int_{\Delta_{k}} \operatorname{Str}\left(e^{-t^{2} \tau_{1} D^{2}} \prod_{p=1}^{k} F\left(\theta_{i_{p-1}+1}, \ldots, \theta_{\mathfrak{i}_{p}}\right) e^{-t^{2}\left(\tau_{\mathfrak{p}+1}-\tau_{p}\right) D^{2}}\right) d \tau \tag{2.18}
\end{equation*}
$$

where $k \leq N$ and a $1 \leq i_{1}<\ldots i_{k} \leq N$ are given, and where $|\theta|=\left|\theta_{0}\right|+\cdots+\left|\theta_{N}\right|$; we assume each $\theta_{i}$ to be homogeneous throughout. Recall moreover that

$$
\begin{aligned}
\mathrm{F}(\theta) & =\mathrm{c}\left(\mathrm{~d} \theta^{\prime}\right)-\left[\mathrm{D}, \mathrm{c}\left(\theta^{\prime}\right)\right]-\mathrm{c}\left(\theta^{\prime \prime}\right), \\
\mathrm{F}\left(\theta_{1}, \theta_{2}\right) & =(-1)^{\left|\theta_{1}\right|}\left(\mathrm{c}\left(\theta_{1}^{\prime}\right) \mathrm{c}\left(\theta_{2}^{\prime}\right)-c\left(\theta_{1}^{\prime} \wedge \theta_{2}^{\prime}\right)\right) .
\end{aligned}
$$

The goal is now to calculate the limit as $t \rightarrow 0$ of the expression, which will occupy the rest of the section.
2.11 Lemma. Let $\theta, \theta_{1}, \theta_{2} \in \Omega_{\mathbb{T}}(M)$ be homogeneous. Then each of the operators

$$
t^{|\theta|+1} F(\theta), \quad t^{\left|\theta_{1}\right|+\left|\theta_{2}\right|} F\left(\theta_{1}, \theta_{2}\right)
$$

acting on sections of $S \boxtimes S^{*}$ over $M \times M \times \mathbb{R}^{\times}$with respect to the first variable, extends smoothly to an operator acting on sections of $\mathbb{S}$ over $\mathbb{T M}$. Moreover, over $\mathbb{T M} \times\{0\} \subset \mathbb{T M}$, these extensions are given by

$$
\theta^{\prime \prime} \wedge \mathrm{f}, \quad \text { respectively } \quad 0 .
$$

Proof. Each of the operators $\mathrm{F}(\theta), \mathrm{F}\left(\theta_{1}, \theta_{2}\right)$ can (locally) be written as a composition of Clifford multiplication and covariant derivatives, therefore it follows from Lemmas 3.6.2 \& 3.6.3 of [HY19] that when multiplied by $t^{\ell}$ for $\ell$ less than or equal to their Getzler order, they extend smoothly to all of $\mathbb{T M}$ and their action over the $t=0$ slice is given by their Getzler symbol. We deal with them in turn.
(a) Regarding the operator $F(\theta)$, suppose that $\theta=\theta^{\prime}+\sigma \theta^{\prime \prime}$ has total degree $|\theta|=\ell$, meaning that $\theta^{\prime} \in \Omega^{\ell}(M)$ and $\theta^{\prime \prime} \in \Omega^{\ell+1}(M)$. A local calculation shows that in terms of a local orthonormal basis $e_{1}, \ldots, e_{n}$, one has the formula

$$
\left.c\left(d \theta^{\prime}\right)-\left[D, c\left(\theta^{\prime}\right)\right]=-2 \sum_{i=1}^{n} c\left(e_{i}\right\lrcorner \theta\right) \nabla_{e_{i}}-c(\delta \theta)
$$

where $\lrcorner$ denotes insertion of vectors into differential forms and $\delta$ is the codifferential. Since for each $\left.i, c\left(e_{i}\right\lrcorner \theta\right)$ can be written as a sum of composites of $\ell-1$ Clifford multiplications, the right hand has Getzler order at most $\ell$. We obtain that $c\left(d \theta^{\prime}\right)-\left[D, c\left(\theta^{\prime}\right)\right]$ is of lower order compared to $c\left(\theta^{\prime \prime}\right)$, which has Getzler order $\ell+1$ (as $c\left(\theta^{\prime \prime}\right)$ can be written as a sum of composites of $\ell+1$ Clifford multiplications). Hence $t^{\ell+1} F(\theta)$ extends smoothly to all of $\mathbb{T} M$, and over $t=0$, we have $t^{\ell+1} F(\theta)=t^{\ell+1} c\left(\theta^{\prime \prime}\right)$. It then follows from Lemma 3.6.2 in [HY19] that over $t=0, t^{\ell+1} \mathfrak{c}\left(\theta^{\prime \prime}\right)$ is given by wedging with $\theta^{\prime \prime}$.
(b) Looking at the formula for $F\left(\theta_{1}, \theta_{2}\right)$, it is clear that it has Getzler order at most $\ell_{1}+\ell_{2}$ (where $\ell_{i}=\left|\theta_{i}\right|$ ), hence $t^{\ell_{1}+\ell_{2}}$ extends continuously to all of $\mathbb{T} M$, and over $t=0$, it is given by

$$
(-1)^{\ell_{1}}\left(\left[c\left(\theta_{1}^{\prime}\right)\right]_{\ell_{1}} \wedge\left[c\left(\theta_{2}^{\prime}\right)\right]_{\ell_{2}} \wedge f-\left[c\left(\theta_{1}^{\prime} \wedge \theta_{2}^{\prime}\right)\right]_{\ell_{1}+\ell_{2}} \wedge f\right)=0
$$

where $[-]_{\ell_{\mathrm{i}}}$ denotes the Clifford symbol (see $\S 2.1$ ).
We are now in the position to prove the following result, which implies Thm. 1.9 and hence finishes the proof of the localization formula.
2.12 Proposition. If $\mathrm{k}<\mathrm{N}$, the expression (2.18) converges to zero, as $\mathrm{t} \rightarrow 0$. In the case $\mathrm{k}=\mathrm{N}$, the limit is given by the right hand side of (1.14).

Proof. Observe that since $F$ whenever if more than two $\theta_{i}$ are inserted, the expression (2.18) can be non-zero only if $\mathfrak{i}_{p}-\mathfrak{i}_{p-1} \leq 2$ for all $p=1, \ldots, k$; we assume throughout that this is the case. We set

$$
\ell_{p}= \begin{cases}\left|\theta_{i_{p}}\right|+1 & \text { if } \mathfrak{i}_{p}-\mathfrak{i}_{p-1}=1 \\ \left|\theta_{i_{p}-1}\right|+\left|\theta_{i_{p}}\right| & \text { if } \mathfrak{i}_{p}-\mathfrak{i}_{p-1}=2\end{cases}
$$

Observe that $\ell_{\mathrm{p}}$ is precisely the Getzler order of $F\left(\theta_{\mathfrak{i}_{p-1}+1}, \ldots, \theta_{i_{p}}\right)$, as seen in the proof of Lemma 2.11. Hence if we set

$$
K_{\tau}^{p}=t^{n+\ell_{p}} F\left(\theta_{i_{p-1}+1}, \ldots, \theta_{i_{p}}\right) e^{-t^{2} \tau D^{2}}
$$

then by Lemma 2.11 and Prop. 2.9, each $K_{\tau}^{p}$ (a priori defined only over $M \times M \times \mathbb{R}^{\times}$) extends smoothly to a section of the bundle $\mathbb{S} \rightarrow \mathbb{T}$; in fact an element of $\mathcal{S}(\mathbb{T M}, \mathbb{S})$.

Because necessarily $\mathfrak{i}_{p}-\mathfrak{i}_{p-1}=1$ for $2 k-N$ many $p$ and $\mathfrak{i}_{p}-\mathfrak{i}_{p-1}=2$ for $N-k$ many $p(p \geq 1)$, we have

$$
\ell_{0}+\cdots+\ell_{k}=|\theta|+2 k-N .
$$

Therefore, using the factors of $t$ in formula (2.18) together with the additional factors of $t$ present in the formulas (2.7) for the twisted convolution and definition (2.8) for the $t$-supertrace, the expression from formula (2.18) can be written as

$$
\begin{equation*}
\int_{\Delta_{k}} \operatorname{Str}_{t}\left(\mathrm{H}_{\tau_{1}} * \mathrm{~K}_{\tau_{2}-\tau_{1}}^{1} * \cdots * \mathrm{~K}_{1-\tau_{\mathrm{N}}}^{\mathrm{N}}\right) \mathrm{d} \tau \tag{2.19}
\end{equation*}
$$

where $*$ denotes the twisted convolution. By Lemma 2.7 (2), the integrand $\mathrm{H}_{\tau_{1}} * \mathrm{~K}_{\tau_{2}-\tau_{1}}^{1} *$ $\cdots * K_{1-\tau_{N}}^{N}$ is now an element of $\mathcal{S}(\mathbb{T M}, \mathbb{S})$, hence it can be evaluated at $t=0$. But if $k<N$, then necessarily one of the $K_{\tau}^{p}$ contains a factor of $F\left(\theta_{i_{p}-1}, \theta_{i_{p}}\right)$, which evaluates to zero over $\mathrm{TM} \times\{0\}$, by Lemma 2.11. This shows the claim for $k<N$.

It is left to consider the case $k=N$. In this case, it follows from Lemma 2.11 and Prop. 2.9 that over $t=0$,

$$
\begin{aligned}
\mathrm{H}_{\tau_{1}} * \mathrm{~K}_{\tau_{2}-\tau_{1}}^{1} * \cdots * \mathrm{~K}_{1-\tau_{\mathrm{N}}}^{\mathrm{N}} & =\mathrm{H}_{\tau_{1}} \wedge\left(\theta_{1}^{\prime \prime} \wedge \mathrm{H}_{\tau_{2}-\tau_{1}}\right) * \cdots *\left(\theta_{\mathrm{N}}^{\prime \prime} \wedge \mathrm{H}_{1-\tau_{\mathrm{N}}}\right) \\
& =\theta_{1}^{\prime \prime} \wedge \cdots \wedge \theta_{\mathrm{N}}^{\prime \prime} \wedge\left(\mathrm{H}_{\tau_{1}} * \mathrm{H}_{\tau_{2}-\tau_{1}} * \cdots * \mathrm{H}_{1-\tau_{\mathrm{N}}}\right) .
\end{aligned}
$$

Here in the second step we used that the $\theta_{i}$ can be pulled out since they are constant as functions on $T_{m} M$ and the $H_{\tau}$ are even. The twisted convolution identity of $H_{\tau}$ (see Remark 2.10) now implies that

$$
\mathrm{H}_{\tau_{1}} * \mathrm{H}_{\tau_{2}-\tau_{1}} * \cdots * \mathrm{H}_{1-\tau_{\mathrm{N}}}=\mathrm{H}_{1} .
$$

By continuity of the $t$-supertraces (compare Lemma 2.7 (3)), the expression (2.19) is continuous in $t$. With a view on (2.8), evaluating at $t=0$ yields

$$
\left(\frac{2}{i}\right)^{d / 2} \int_{\Delta_{N}}\left(\int_{M} \theta_{0}^{\prime} \wedge \theta_{1}^{\prime \prime} \wedge \cdots \wedge \theta_{N}^{\prime \prime} \wedge H_{1}(0,-, 0)\right) d \tau
$$

The integrand of the integral over $\Delta_{N}$ is independent of $\tau$, hence it just contributes a factor of $\operatorname{vol}\left(\Delta_{\mathrm{N}}\right)=1 / \mathrm{N}$ !. Finally, comparing formula (2.12) with (1.15), one observes that $\mathrm{H}_{1}(0,-, 0)$ is precisely $(4 \pi)^{-\mathrm{d} / 2}$ times the $\hat{A}$-form on $M$. In total, we obtain precisely the right hand side of (1.14).
