# Boundary Conditions for Hyperbolic Relaxation Systems with Characteristic Boundaries of Type I

#### Abstract

This work is concerned with boundary conditions for one-dimensional hyperbolic relaxation systems with characteristic boundaries. We assume that the relaxation system satisfies the structural stability condition proposed by the second author previously and the boundary is characteristic of type I (characteristic for the relaxation system but non-characteristic for the corresponding equilibrium system). For this kind of characteristic initial-boundary-value problems, we propose a modified Generalized Kreiss condition (GKC). This extends the GKC proposed by W.-A. Yong (1999, Indiana Univ. Math. J. 48(1), 115-137) for the non-characteristic boundaries to the present characteristic case. Under this modified GKC, we derive the reduced boundary condition and verify its validity by combining an energy estimate with the Laplace transform. Moreover, we show the existence of boundary-layers for nonlinear problems.


Keywords: hyperbolic relaxation systems, boundary conditions, characteristic boundaries, generalized Kreiss condition, energy estimate, Laplace transform

## 1 Introduction

This work is concerned with boundary conditions for hyperbolic relaxation systems

$$

U_{t}+\sum_{j=1}^{d} A_{j}(U) U_{x_{j}}=\frac{Q(U)}{\epsilon} \tag{1.1}
\end{equation*}

defined for $(x, t)=\left(x_{1}, x_{2}, \ldots, x_{d}, t\right) \in \Omega \times[0, T)$. Here $\Omega$ is a proper subset of $R^{d}, U=U(x, t) \in$ $R^{n}$ is unknown, $A_{j}(U) \in R^{n \times n}(j=1,2, \ldots, d)$ and $Q(U) \in R^{n}$ are given smooth functions of $U \in G$ (an open subset of $R^{n}$ called state space), and $\epsilon$ is a small positive parameter. This kind of equations with the small parameter describes various non-equilibrium phenomena. Important examples occur in the kinetic theory [10, 17, 4, 19], thermal non-equilibrium flows [32, chemically reactive flows [11], compressible viscoelastic flows [28, 6], nonlinear optics [13], non-equilibrium thermodynamics [34], traffic flows [2, 3], and so on.

For such a small parameter problem, a main interest is to understand the limit as $\epsilon$ goes to zero - the so-called zero relaxation limit [7, [26]. For initial-value problems of (1.1), there have been a lot of studies and the interested reader can refer to [9, 20, 31] and the references cited therein. Particularly, it was proved in [26] that, as $\epsilon$ goes to zero, the solution $U^{\epsilon}$ converges to that of the corresponding equilibrium system under the structural stability condition proposed therein. Here the equilibrium system is a hyperbolic system of first-order partial differential equations and governs the limit.

On initial-boundary-value problems (IBVPs) of (1.1), the literature seems quite rare. The first systematical work is [27] where the main issues were well elaborated. In [27], it was observed that the structural stability condition is not enough to ensure the existence of the zero relaxation limit. To attack this problem, the second author of this paper proposed the Generalized Kreiss Condition (GKC) imposed on the boundary conditions for relaxation systems, while the Kreiss condition is for (multi-dimensional) hyperbolic systems without considering the relaxation effects [16, 12]. Under the GKC and the hypothesis that the boundary is non-characteristic for both the relaxation system and its equilibrium system, the reduced boundary condition satisfied by the limit was found and was proved to be well-posed together with the equilibrium system. However, the non-characteristic hypothesis required in [27] is too restrictive to include many important physical cases [18, 29].

The purpose of this project is to remove or weaken the non-characteristic hypothesis. Namely, the boundaries may be characteristic for the relaxation system or for its equilibrium system. Thus there are at least the following possibilities:
(I) The boundary is characteristic for the relaxation system but is non-characteristic for the equilibrium system;
(II) The boundary is non-characteristic for the relaxation system but is characteristic for the equilibrium system.

It turns out that the above two cases have different features and difficulties. Here we only consider the characteristic boundaries of type (I) and a subsequent work will be devoted to the type (II).

This paper focuses on the one-dimensional version of (1.1) in the half-space $x=x_{1}>0$. By the boundary $x=0$ to be characteristic for the relaxation system (1.1), we mean that
the coefficient matrix $A_{1}(U)$ is not invertible. It is worth to mention that the one-dimensional relaxation problem possesses some key features of usual two-dimensional hyperbolic equations, particularly for the boundary conditions. Such features do not allow to simply decouple the characteristic IBVP into a non-characteristic problem and ordinary differential equations.

We try to study the above characteristic IBVPs by following the framework in 27]. Since the invertibility of $A_{1}(U)$ plays the role of the starting point in [27], we have to overcome various technical difficulties at the outset and throughout the whole procedure. In particular, the crucial GKC needs to be re-defined. The main contributions of this work can be stated as follows. We propose a modified Generalized Kreiss Condition for the characteristic boundaries of type I. Under this modified condition, we derive the reduced boundary condition for the corresponding equilibrium system and prove that the resultant IBVP is well-posed. For the linear problem with constant coefficients, we adapt the decomposition method in [12 to show the validity of the reduced boundary condition. The method is a combination of the energy estimate and the Laplace transform, which are based on the structural stability condition and the (modified) GKC, respectively. For nonlinear equations we show the existence of boundary-layers under the modified GKC.

The above results are based on the following assumptions. The system (1.1) is required to satisfy the structural stability condition in [26]. Moreover, we assume that the symmetrizer $A_{0}(U)$ in the structural stability condition and the source term $Q(U)$ satisfy

Here $Q_{U}(U)$ is the Jacobian matrix of the source term $Q(U)$, the superscript * denotes the transpose of matrices or vectors, and $\mathcal{E}$ stands for the equilibrium manifold $\mathcal{E}=\{U \in G: Q(U)=0\}$. The stability condition and the assumption (1.2) are quite reasonable and cover many important relaxation models [30]. In addition, we follow [18] to assume that the boundary condition does not involve the characteristic modes corresponding to the zero eigenvalue and the boundaries are uniformly characteristic for nonlinear problems. These additional assumptions were shown in [18] to be crucial for the well-posedness of general hyperbolic IBVPs with characteristic boundaries.

At this point, let us mention that except for [27], the other works about the IBVPs of the relaxation systems seem all for specific models. For example, the one-dimensional linear Jin-Xin model was considered in [22]. By using the Laplace transform and a matched asymptotic analysis, the authors analyzed the relaxation limit and boundary-layer behaviors. In [5], the authors studied a specific IBVP for the one-dimensional Kerr-Debye model in nonlinear optics. They justified the zero relaxation limit by exploiting the energy method and the entropy structure of the model. Recently, a nonlinear discrete-velocity model for traffic flows was investigated in [2] and the reduced boundary condition was obtained by solving a boundary Riemann problem. The interested reader is referred to [21, 23, 24, 25, 33] for further works in this direction.

The rest of this paper is organized as follows. The next section is devoted to linear problems and contains four subsections. All assumptions are given in the short Subsection 2.1. In Subsection 2.2, we investigate the possible non-existence of the zero relaxation limit and propose a modified GKC for the characteristic boundaries of type I; The reduced boundary condition is derived in Subsection 2.3; Subsection 2.4 is devoted to proving the validity of the reduced boundary condition. In Section 3, we show the existence of boundary-layers for one-dimensional nonlinear problems. Some details of Section 2 are given in Appendix.

For the convenience of the reader, we end this introduction with the aforementioned structural stability condition [26] for (1.1):
(i) There is an invertible $n \times n$-matrix $P(U)$ and an invertible $r \times r$-matrix $S(U)(0<r \leq n)$, defined on the equilibrium manifold $\mathcal{E}=\{U \in G: Q(U)=0\}$, such that

(ii) As a hyperbolic system, (1.1) is symmetrizable, that is, there is a positive definite symmetric matrix $A_{0}(U)$ such that

(iii) The hyperbolic part and the source term are coupled in the following sense

\end{array}\right) P(U) \quad \text { for } U \in \mathcal{E}

Here and below $I_{k}$ denotes the unit matrix of order $k$.

## 2 Linear Problems

### 2.1 Assumptions

We start with one-dimensional linear systems with constant coefficients. Under the structural stability condition, we may as well assume that the linear system has the following form

A_{0} U_{t}+A_{1} U_{x}=\frac{Q U}{\epsilon}, \quad x>0, t>0 . \tag{2.1}
\end{equation*}
$$

Here $A_{0}$ is a symmetric positive definite matrix, $A_{1}$ is a symmetric matrix, and $Q=\operatorname{diag}(0, S)$ with $S$ an $r \times r(0 \leq r \leq n)$ stable matrix. Moreover, $S$ is a symmetric negative definite matrix under the assumption (1.2). By Theorem 2.2 in [26], the structural stability condition implies that $A_{0}$ is a block-diagonal matrix of the form

with the same partition as that of $Q$. Correspondingly, we often write

$$
U=\binom{u}{v}, \quad A_{1}=\left(\begin{array}{cc}
A_{11} & A_{12} \\
A_{12}^{*} & A_{22}
\end{array}\right) .
$$

Besides the structural stability condition and (1.2), the next assumption for (2.1) is

Assumption 2.1. The boundary $x=0$ is characteristic for the relaxation system (2.1) but is non-characteristic for its equilibrium system

A_{01} u_{t}+A_{11} u_{x}=0
$$

Namely, $A_{11}$ is invertible but $A_{1}$ has zero eigenvalues.
With this assumption, we introduce the following three numbers

\begin{aligned}
& n_{1}^{+}=\text {the number of positive eigenvalues of } A_{11}, \\
& n^{+}=\text {the number of positive eigenvalues of } A_{1}, \\
& n^{o}=\text { the number of zero eigenvalues of } A_{1} .
\end{aligned}

According to the classical theory [1, 12] for IBVPs of first-order hyperbolic systems, $n^{+}$ boundary conditions

$$

B U(0, t) \equiv\left(B_{u}, B_{v}\right) U(0, t)=b(t) \tag{2.2}
\end{equation*}

should be given at the boundary $x=0$ for (2.1) and the $n^{+} \times n$ boundary matrix $B$ should satisfy

\operatorname{det}\left\{B R_{A}^{U}\right\} \neq 0 \tag{2.3}
\end{equation*}
$$

Here $R_{A}^{U}$ is an $n \times n^{+}$matrix whose columns are the eigenvectors of $A_{0}^{-1} A_{1}$ associated with the positive eigenvalues. Our last assumption reads as

B R_{A}^{0}=0 \tag{2.4}
\end{equation*}

for each eigenvector $R_{A}^{0}$ of $A_{0}^{-1} A_{1}$ associated with the zero eigenvalue. The relation (2.4) means that no characteristic mode corresponding to the zero eigenvalue is involved in the boundary condition above. The necessity of (2.4) was illustrated in [18] for the characteristic IBVPs.

In summary, our starting assumptions for the linear relaxation system (2.1) are the structural stability condition, Assumption (2.1, and those in (1.2) and (2.4).

### 2.2 Modified Generalized Kreiss Condition

In this subsection, we adapt the standard argument in [14, 16, 27] to our characteristic IBVPs and show that the homogeneous problem

with bounded initial data may have exponentially increasing solution for $t>0$ as $\epsilon$ goes to zero. Based on this argument, we propose a modified GKC for the characteristic boundaries of type I.

Following Lemma 3.1 in [27], we consider the following problem

$$

\xi A_{0} \hat{U}+A_{1} \hat{U}_{x}=\eta Q \hat{U}, \quad x>0  \tag{2.6}\\
B \hat{U}(0)=0
\end{array}\right.
$$

where $\eta \geq 0$ and $\xi$ is a complex number with $\operatorname{Re} \xi>0$. With $\eta=0$, this reduces to that for IBVPs of conventional hyperbolic equations [14]. If (2.6) has a bounded solution $\hat{U}(x)$ for a certain $\eta>0$, then

U^{\epsilon}=\exp \left(\frac{\xi t}{\eta \epsilon}\right) \hat{U}\left(\frac{x}{\eta \epsilon}\right)
$$

is the solution to the problem (2.5) with a bounded initial value. Since $\operatorname{Re} \xi>0$ and $\eta>0$, this solution $U^{\epsilon}$ exponentially increases for $t>0$ as $\epsilon$ goes to zero.

In order to avoid such exponentially increasing solutions, our first task is to find conditions under what the problem (2.6) has bounded solutions. Before proceeding, we notice that for the characteristic boundary where $A_{1}$ is not invertible, the differential equation in (2.6) can not be rewritten as

\hat{U}_{x}=A_{1}^{-1}\left(\eta Q-\xi A_{0}\right) \hat{U} .
$$

This is quite different from the non-characteristic case. To deal with this difficulty, we formulate the following lemma.

Lemma 2.1. Under the assumptions in Subsection 2.1, there exists an $\left(n-n^{o}\right) \times\left(n-n^{o}\right)$-matrix $M(\xi, \eta)$ and an $n^{o} \times\left(n-n^{o}\right)$-matrix $E(\xi, \eta)$ such that the equation in (2.6) can be rewritten as

\hat{V}^{I I}=E(\xi, \eta) \hat{V}^{I}
\end{array}\right.
$$

Here $\hat{V}=\Phi \hat{U}$ with $\Phi$ an orthonormal matrix given below, $\hat{V}^{I}$ represents the first $\left(n-n^{o}\right)$ components of $\hat{V}$ and $\hat{V}^{I I}$ is the rest components.

This lemma allows a very short and simple proof. But here we present a different and tedious proof, in order to study the limit as $\eta$ goes to infinity in the next subsection.

Proof. First of all, we recall $Q=\operatorname{diag}(0, S)$ and $A_{1}=\left(\begin{array}{cc}A_{11} & A_{12} \\ A_{12}^{*} & A_{22}\end{array}\right)$. Set $\hat{U}=\binom{\hat{u}}{\hat{v}}$ and rewrite the equation in (2.6) as

\end{align*}

Since $A_{11}$ is invertible, from (2.7) it follows that

\hat{u}_{x}=-A_{11}^{-1} A_{12} \hat{v}_{x}-\xi A_{11}^{-1} A_{01} \hat{u} . \tag{2.9}
\end{equation*}
$$

Substituting this relation into (2.8), we get

On the the hand, from the congruent transformation

\end{array}\right)=\left(\begin{array}{cc}
A_{11} & 0 \\
0 & A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}
\end{array}\right)

for $A_{1}$, we see that the $r \times r$-matrix $\left(A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}\right)$ is symmetric with $n^{o}$ zero eigenvalues. Then there exists an $r \times r$ orthonormal matrix $\tilde{P}$ satisfying

\tilde{P}^{*}\left(A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}\right) \tilde{P}=\left(\begin{array}{cc}
\Lambda_{2} & 0  \tag{2.12}\\
0 & 0
\end{array}\right) .
$$

Here $\Lambda_{2}$ is a real $\left(r-n^{o}\right) \times\left(r-n^{o}\right)$ diagonal matrix whose diagonal elements are nonzero eigenvalues of $\left(A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}\right)$. With the partition of $\operatorname{diag}\left(\Lambda_{2}, 0\right)$, we write $\tilde{P}=\left(P_{2}, P_{0}\right)$ with $P_{2}$ an $r \times\left(r-n^{o}\right)$-matrix and $P_{0}$ an $r \times n^{o}$-matrix. Then the last equation can be expressed as

Moreover, since $\tilde{P}=\left(P_{2}, P_{0}\right)$ is an orthonormal matrix, we have the decomposition

With these preparations, the equation (2.10) can be rewritten as

Multiplying this equation with $P_{0}^{*}$ and $P_{2}^{*}$ from the left and using (2.13) with (2.14), we obtain

Set

\end{equation*}

The last two equations can be rewritten as

It is shown in Appendix A.1 that the matrix $S_{00}$ is invertible. Then from (2.17) we can express $\hat{w}_{0}$ in terms of $\hat{u}$ and $\hat{w}_{2}$ as

Furthermore, with the decomposition in (2.15), the equation (2.9) can be expressed as

N_{2}(\xi, \eta)=A_{11}^{-1} A_{12}\left(P_{2}-P_{0} S_{00}^{-1} S_{02}\right) \\
N_{3}(\xi, \eta)=\xi \Lambda_{2}^{-1}\left(P_{2}^{*}-S_{20} S_{00}^{-1} P_{0}^{*}\right) A_{12}^{*} A_{11}^{-1} A_{01} \\

The matrix $I_{n-r}+N_{1}(\xi, \eta)$ is proven to be invertible in Appendix A.1.
Now we define

We postpone the proof of this lemma in Appendix A.2. With this lemma, we can prove
Lemma 2.3. For any $\eta \geq 0$ and $\xi$ with Re $\xi>0$, the matrix $M(\xi, \eta)$ has precisely $n^{+}$stable eigenvalues and thereby $\left(n-n^{o}-n^{+}\right)$unstable eigenvalues.

Proof. By Lemma 2.2 and the continuity of eigenvalues with respect to the parameters, the numbers of stable and unstable eigenvalues of $M(\xi, \eta)$ are invariant for any $\eta \geq 0$ and $\xi$ with $R e \xi>0$. Thus it suffices to show that the matrix $M(\xi, 0)$ has $n^{+}$stable eigenvalues.

When $\eta=0$, it follows from (2.16) that $S_{i j}=-\xi P_{i}^{*} A_{02} P_{j}$ for $i, j=0,2$. Thus we refer to (2.22) and have

Let $R_{M}^{S}(\xi, \eta)$ denote the right-stable matrix of $M(\xi, \eta)$ (see [27] for the definition of rightstable matrices). Lemma 2.3 indicates that $R_{M}^{S}(\xi, \eta)$ is an $\left(n-n^{o}\right) \times n^{+}$-matrix. If the following $n^{+} \times n^{+}$-matrix

as initial value, the ordinary differential equation $\hat{V}_{x}^{I}=M(\xi, \eta) \hat{V}^{I}$ has a bounded solution for $x>0$. In view of Lemma 2.1, the problem (2.6) has a bounded solution $\hat{U}$.

In conclusion, we have finished the task to find the condition for the problem (2.6) to have a bounded solution. It is that the matrix in (2.31) is not invertible.

Motivated by the last conclusion, we propose the following
Modified Generalized Kreiss Condition. There exists a constant $c_{K}>0$ such that

About this modified GKC, we have the following interesting remark.
Remark 2.1. In the absence of $S$ or $\eta$, this modified GKC recovers the standard Kreiss condition (2.3). When $n^{o}=0$, we recover the GKC in [27] for non-characteristic IBVPs. We omit the proofs of these conclusions and leave them for the interested reader.

### 2.3 Reduced Boundary Condition

Under the modified GKC, we derive the reduced boundary condition for the equilibrium system

According to the classical theory [1, 12] for hyperbolic IBVPs, $n_{1}^{+}$linear independent boundary conditions should be prescribed at the boundary $x=0$ for the equilibrium system.

For this purpose, we follow [27] and construct an approximate solution of the form

If the above coefficient matrix is invertible, we can express $\alpha$ and $w_{2}(0)$ in terms of $\beta$. In this way, we obtain the reduced boundary condition for the equilibrium system in (2.32) and the initial value $w_{2}(0)$ for the boundary-layer equation (2.43). With these, we can uniquely determine $w_{2}$ by solving (2.43) and $\bar{u}$ by solving (2.32) with proper initial data. Consequently, the boundary-layer correction $(\mu, \nu)$ and thereby the approximate solution $U_{\epsilon}$ are constructed uniquely.

To clarify the invertibility, we establish the following analogue of Lemma 3.4 in [27]:

O\left(\eta^{0}\right) & O\left(\eta^{0}\right)
\end{array}\right)+O\left(\frac{1}{\eta}\right) \\
\equiv & \eta \bar{M}(1 / \eta) . \tag{2.47}

Since $\bar{M}(\sigma)$ is analytic and $\Lambda_{2}^{-1} G_{2}$ is invertible, we know from 15 that there is an invertible matrix $T(\sigma)$, defined in the neighborhood of $\sigma=0$, such that $T(\sigma)$ and $T^{-1}(\sigma)$ are analytic at $\sigma=0, T(0)=I_{n-n^{\circ}}$, and

From the argument following (2.44) we know that the $\left(r-n^{o}\right) \times\left(r-n^{o}\right)$-matrix $\bar{M}_{2}(0)$ has $\left(n^{+}-n_{1}^{+}\right)$stable eigenvalues and $\left(r-n^{o}-n^{+}+n_{1}^{+}\right)$unstable eigenvalues. Therefore, for all sufficiently large $\eta, \bar{M}_{2}(1 / \eta)$ has the same numbers of stable and unstable eigenvalues as $\bar{M}_{2}(0)$. Similarly, $\eta \bar{M}_{1}(1 / \eta)$ has $n_{1}^{+}$stable eigenvalues and $\left(n-r-n_{1}^{+}\right)$unstable eigenvalues.

Denote by $\bar{R}_{1}^{S}(1 / \eta)$ and $\bar{R}_{2}^{S}(1 / \eta)$ the respective right-stable matrices of $\eta \bar{M}_{1}(1 / \eta)$ and $\bar{M}_{2}(1 / \eta)$. According to the previous discussion, they are of orders $(n-r) \times n_{1}^{+}$and $\left(r-n^{o}\right) \times n_{2}^{+}$. By using (2.47) and (2.48), we can directly verify that

Here $\bar{R}_{1}^{S}(0)$ is a right-stable matrix of $-\xi A_{11}^{-1} A_{01}$ and $\bar{R}_{2}^{S}(0)$ is a right-stable matrix of $\Lambda_{2}^{-1} G_{2}$. Additionally, as $\eta \rightarrow \infty$, the matrices $N_{5}(\xi, \eta)$ and $N_{6}(\xi, \eta)$ in (2.30) have the limits

Remark 2.2. The boundary condition (2.49) is derived from (2.45) by multiplying $B_{p}$ from the left and by using (2.50). Here we also use (2.44) which implies that $w_{2}(0) \in \operatorname{span}\left\{R_{2}^{S}\right\}$.

In the next subsection, we will show that the boundary condition (2.49) is satisfied by the relaxation limit. In this sense, it is referred to as the reduced boundary condition.

### 2.4 Validity of the reduced boundary condition

In this subsection, we show that the relaxation limit of smooth solution $U^{\epsilon}$ to the relaxation system (2.1) with boundary condition (2.2) satisfies the boundary condition (2.49) as well as the equilibrium system (2.32). This will be done by estimating $\left(U^{\epsilon}-U_{\epsilon}\right)$ with the decomposition method [12 mainly based on the modified GKC. Here $U_{\epsilon}$ is the approximate solution constructed in the previous subsection.

Firstly, we make some assumptions on the initial and boundary data to avoid unnecessary technical difficulties. The initial value $U_{0}(x)$ for the relaxation system (2.1) is assumed to be in equilibrium:

In (2.57), $L_{+}$is an $n^{+} \times n$-matrix consisting of the $n^{+}$left-eigenvectors of matrix $A_{0}^{-1 / 2} A_{1} A_{0}^{-1 / 2}$ associated with its positive eigenvalues. Note that $A_{0}^{-1 / 2} A_{1} A_{0}^{-1 / 2}$ is symmetric. Then $L_{+}$can be the first $n^{+}$rows of the following orthonormal matrix $L$ satisfying

According to the classical theory for hyperbolic IBVPs (see, e.g., [1), the well-posed IBVP has a unique solution $\bar{u} \in C\left([0, T] ; H^{1}\left(R^{+}\right)\right)$. Then we have

\int_{0}^{T}\left|L_{-} A_{0}^{1 / 2} W_{1}(0, t)\right|^{2} d t \leq C(T)\left(\epsilon\left\|F_{1}\right\|_{L^{2}\left([0, T] \times R^{+}\right)}^{2}+\left\|F_{2}\right\|_{L^{2}\left([0, T] \times R^{+}\right)}^{2}\right) .
$$

The last two inequalities together give (2.60) and the proof is complete.
Finally, we present a proof of Lemma 2.8.

Proof. (Lemma (2.8) Since the modified GKC implies the standard Kreiss condition (see Remark (2.1), the IBVP (2.58) has a unique $L^{2}\left([0, T] \times R^{+}\right)$-solution $W_{2}=W_{2}(x, t)$ by the aforementioned existence theory in [18].

The estimate (2.61) can be derived with the following three steps.
Step 1: Multiplying the equation in (2.58) with $W_{2}^{*}$ from the left yields

Notice that the initial value of $W_{2}$ is zero. We integrate the last inequality over $x \in[0,+\infty)$ and $t \in[0, T]$ to obtain

$$

Since $A_{0}$ is a positive definite matrix, we have

With this, it remains to bound $\int_{0}^{T}\left|W_{2}(0, t)\right|^{2} d t$ in terms of $\int_{0}^{T}\left|L_{-} A_{0}^{1 / 2} W_{1}(0, t)\right|^{2} d t$.
Step 2: As a preparation for Step 3, we show that $g(t):=-B W_{1}(0, t)$ can be expressed in terms of $L_{-} A_{0}^{1 / 2} W_{1}(0, t)$. Recall that $L$ is an orthonormal matrix in (2.59). Then we have

& =A_{0}^{-1 / 2} L_{+}^{*} L_{+} A_{0}^{1 / 2}+A_{0}^{-1 / 2} L_{-}^{*} L_{-} A_{0}^{1 / 2}+A_{0}^{-1 / 2} L_{0}^{*} L_{0} A_{0}^{1 / 2} .
\end{aligned}
$$

Using this and the boundary condition in (2.57), we rewrite $g(t)$ as

g(t) & =-B A_{0}^{-1 / 2} L_{+}^{*} L_{+} A_{0}^{1 / 2} W_{1}(0, t)-B A_{0}^{-1 / 2} L_{-}^{*} L_{-} A_{0}^{1 / 2} W_{1}(0, t)-B A_{0}^{-1 / 2} L_{0}^{*} L_{0} A_{0}^{1 / 2} W_{1}(0, t) \\
& =-B A_{0}^{-1 / 2} L_{-}^{*} L_{-} A_{0}^{1 / 2} W_{1}(0, t)-B A_{0}^{-1 / 2} L_{0}^{*} L_{0} A_{0}^{1 / 2} W_{1}(0, t)
\end{aligned}
$$

On the other hand, from (2.59) we see that $A_{0}^{-1 / 2} A_{1} A_{0}^{-1 / 2} L_{0}^{*}=0$. This means that each column of $A_{0}^{-1 / 2} L_{0}^{*}$ is an eigenvector of $A_{0}^{-1} A_{1}$ associate with the zero eigenvalue. By the assumption (2.4), we have

Step 3: For the $L^{2}$-solution $W_{2}=W_{2}(x, t)$, define its Laplace transform with respect to $t$ :

Then we deduce from the IBVP (2.58) that

\left\|\hat{W}_{2}(\cdot, \xi)\right\|_{L^{2}}<\infty \text { for a.e. } \xi
\end{array}\right.
$$

Here we use the notation $\eta=1 / \epsilon$.
Observe that the first line in (2.65) is just the equation in (2.6). Then Lemma 2.1 applies and gives

\end{array}\right.
$$

Here $s=\sqrt{\eta^{2}+|\xi|^{2}}, \xi^{\prime}=\xi / s$ and $\eta^{\prime}=\eta / s, \hat{V}_{2}^{I}$ denotes the first $\left(n-n^{o}\right)$ components of $\Phi \hat{W}_{2}$, and $\hat{V}_{2}^{I}$ denotes the other $n^{o}$ components of $\Phi \hat{W}_{2}$. In terms of $\hat{V}_{2}=\Phi \hat{W}_{2}$, the boundary condition in (2.65) becomes (see (2.28)-(2.30))

I_{n-r} & 0  \tag{2.67}\\
N_{6}\left(\xi^{\prime}, \eta^{\prime}\right) & N_{5}\left(\xi^{\prime}, \eta^{\prime}\right)
\end{array}\right) \hat{V}_{2}^{I}(0, \xi)=\hat{g}(\xi) .
$$

Let $R_{M}^{S}=R_{M}^{S}\left(\xi^{\prime}, \eta^{\prime}\right)$ and $R_{M}^{U}=R_{M}^{U}\left(\xi^{\prime}, \eta^{\prime}\right)$ be the right-stable and right-unstable matrices of $M=M\left(\xi^{\prime}, \eta^{\prime}\right)$ :

with $M^{S}$ a stable-matrix and $M^{U}$ an unstable-matrix. In view of the Schur decomposition, we may assume

\left(R_{M}^{S}, R_{M}^{U}\right)\binom{R_{M}^{S *}}{R_{M}^{U *}}=\binom{R_{M}^{S *}}{R_{M}^{U *}}\left(R_{M}^{S}, R_{M}^{U}\right)=I_{n-n^{o} .} .

Thus, we deduce from (2.66) that

\end{array}\right)\binom{R_{M}^{S *}}{R_{M}^{U *}} \hat{V}_{2}^{I} .
$$

Since $\left\|\hat{V}_{2}(\cdot, \xi)\right\|_{L^{2}}=\left\|\Phi \hat{W}_{2}(\cdot, \xi)\right\|_{L^{2}}<\infty$ for a.e. $\xi$ and $M^{U}$ is an unstable-matrix, it must be

$$
\begin{equation*}
R_{M}^{U *} \hat{V}_{2}^{I}=0 \tag{2.68}
\end{equation*}
$$

Therefore, the boundary condition (2.67) becomes

$$
\left(B_{u}, B_{v}\right)\left(\begin{array}{cc}
I_{n-r} & 0 \\
N_{6}\left(\xi^{\prime}, \eta^{\prime}\right) & N_{5}\left(\xi^{\prime}, \eta^{\prime}\right)
\end{array}\right) R_{M}^{S} R_{M}^{S *} \hat{V}_{2}^{I}(0, \xi)=\hat{g}(\xi) .
$$

The last equation leads to

\begin{equation*}
\left|R_{M}^{S *} \hat{V}_{2}^{I}(0, \xi)\right|^{2} \leq C|\hat{g}(\xi)|^{2}, \tag{2.69}
\end{equation*}
$$

since the matrix

$$
\left[\left(B_{u}, B_{v}\right)\left(\begin{array}{cc}
I_{n-r} & 0 \\
N_{6}\left(\xi^{\prime}, \eta^{\prime}\right) & N_{5}\left(\xi^{\prime}, \eta^{\prime}\right)
\end{array}\right) R_{M}^{S}\right]^{-1}
$$

is uniformly bounded due to the modified GKC.
It is shown in Appendix A.3 that $E\left(\xi^{\prime}, \eta^{\prime}\right)$ and $R_{M}^{S}\left(\xi^{\prime}, \eta^{\prime}\right)$ are uniformly bounded for $\left|\xi^{\prime}\right| \leq 1$ and $0 \leq \eta^{\prime} \leq 1$. Then we deduce from (2.66), (2.68) and (2.69) that

Applying Parseval's identity to this inequality yields

\end{equation*}

Because the right-hand side is independent of $R e \xi$, we have

By using the trick from [12], the integral interval $[0, \infty)$ in the last inequality can be easily changed to $[0, T]$. Indeed, according to the classical theory of first-order hyperbolic system, the solution at any finite time $t=T$ does not depend on the boundary data $g(t)$ for $t>T$. Therefore, with the following boundary data

the new solution $\tilde{W}_{2}=\tilde{W}_{2}(x, t)$ satisfies

Since $W_{2}=\tilde{W}_{2}$ for $t \leq T$, we have

\int_{0}^{T}\left|W_{2}(0, t)\right|^{2} d t \leq \int_{0}^{\infty}\left|\tilde{W}_{2}(0, t)\right|^{2} d t \leq C \int_{0}^{\infty}|\tilde{g}(t)|^{2} d t=C \int_{0}^{T}|g(t)|^{2} d t
$$

This together with (2.64) gives

\int_{0}^{T}\left|W_{2}(0, t)\right|^{2} d t \leq C \int_{0}^{T}|g(t)|^{2} d t \leq C \int_{0}^{T}\left|L_{-} A_{0}^{1 / 2} W_{1}(0, t)\right|^{2} d t
$$

and hence the proof is complete.

## 3 One-dimensional nonlinear problems

### 3.1 Assumptions

Now we consider the one-dimensional nonlinear system

$$
\begin{equation*}
U_{t}+F(U)_{x}=Q(U) / \epsilon \tag{3.1}
\end{equation*}
$$

in $0 \leq x, t<\infty$ with the boundary condition

$$
\begin{equation*}
B(U(0, t) ; t)=0 . \tag{3.2}
\end{equation*}
$$

Here

$$
U=\binom{u}{v}, \quad F(U)=\binom{f(u, v)}{g(u, v)}, \quad Q(U)=\binom{0}{q(u, v)}
$$

where $u \in R^{n-r}$ and $v \in R^{r}$ are unknowns, $f=f(u, v) \in R^{n-r}, g=g(u, v) \in R^{r}$ and $q=q(u, v) \in R^{r}$ are given smooth solutions of $(u, v) \in G$. Under the modified GKC, we show the existence of boundary-layers for this nonlinear system and derive its reduced boundary condition. We will only consider smooth solutions near the corner $(x, t)=(0,0)$.

For the nonlinear problem above, the first set of assumptions is the following analogue of those in Subsection 2.1 for linear problems.

## Assumption 3.1.

(I) The equation (3.1) satisfies the structural stability condition in the end of Introduction and the relation (1.2) holds. Moreover, $q_{v}=q_{v}(u, v)$ is invertible for $(u, v) \in G$ and $q(u, v)=0$ uniquely determines $v$ in term of $u$, say $v=h(u)$.
(II) The initial data lie in equilibrium and are consistent with the boundary condition:

$$
Q(U(x, 0))=0 \quad \text { and } \quad B(U(0,0) ; 0)=0 .
$$

(III) The boundary $x=0$ is non-characteristic for the equilibrium system (3.8) below and is characteristic for the relaxation system. Namely, the matrix $f_{u}+f_{v} h_{u}$ is invertible and $F_{U}(U)$ has zero eigenvalues. The multiplicity $n^{o}$ of the zero eigenvalue is assumed to be independent of $U \in G$.

On Assumption (I) above, we comment as follows. Since $q_{v}$ is invertible, the matrix $P(U)$ in the structural stability condition can be defined for $U$ in the whole $G$, instead of only in the equilibrium manifold $\mathcal{E}$ :

\end{array}\right)=\left(\begin{array}{cc}

$$

A simple computation shows

P(U) Q_{U}(U) P^{-1}(U)=P(U)\left(\begin{array}{cc}
0 & 0 \\
q_{u} & q_{v}
\end{array}\right) P^{-1}(U)=\left(\begin{array}{cc}
0 & 0 \\
0 & q_{v}
\end{array}\right) \quad \text { for } U \in G .
$$

The structural stability condition implies that there exists a positive definite matrix $A_{0}(U)$ such that

$$
A_{0}(U) F_{U}(U)=F_{U}^{*}(U) A_{0}(U) \quad \text { for } U \in G
$$

Thus we can define, for $U \in G$,

$$
\left\{\begin{array}{l}
\tilde{A}_{0}(U) \equiv\left(\begin{array}{cc}
A_{01} & A_{012} \\
A_{012}^{*} & A_{02}
\end{array}\right)(U):=P^{-*}(U) A_{0}(U) P^{-1}(U),  \tag{3.4}\\
A_{1}(U) \equiv\left(\begin{array}{ll}
A_{11} & A_{12} \\
A_{12}^{*} & A_{22}
\end{array}\right)(U):=P^{-*}(U) A_{0}(U) F_{U}(U) P^{-1}(U)
\end{array}\right.
$$

On the other hand, now the equilibrium manifold can be expressed as $\mathcal{E}=\{U \in G: v=h(u)\}$. By Theorem 2.2 in [26], the block-matrix $A_{012}(U)$ vanishes at $U \in \mathcal{E}$. Furthermore, it follows from the stability condition (iii) and the relation (1.2) that the following matrix is symmetric negative definite for $U \in \mathcal{E}$ :

Next, we turn to the modified GKC by considering

U_{t}+F_{U}\left(U_{0}\right) U_{x}=Q_{U}\left(U_{0}\right) U / \epsilon  \tag{3.5}\\
B U=b(t)
\end{array}\right.
$$

This can be viewed as a linearization of (3.1) with (3.2) at the corner $(U, t)=\left(U_{0}, 0\right)$ when $U_{0}=U(0,0), B=B_{U}\left(U_{0} ; 0\right)$, and $b(t)=B_{U}\left(U_{0} ; 0\right) U_{0}-t \partial_{t} B\left(U_{0} ; 0\right)$. Multiplying (3.5) with $P^{-*}\left(U_{0}\right) A_{0}\left(U_{0}\right)$ from the left and setting $V=P\left(U_{0}\right) U$, we obtain

\left\{\begin{array}{l}
\left(\begin{array}{ll}
A_{01}\left(U_{0}\right) & \\
& A_{02}\left(U_{0}\right)
\end{array}\right) V_{t}+A_{1}\left(U_{0}\right) V_{x}=\frac{1}{\epsilon}\left(\begin{array}{cc}
0 & \\
& A_{02} q_{v}\left(U_{0}\right)
\end{array}\right) V  \tag{3.6}\\
B P^{-1}\left(U_{0}\right) V(0, t)=b(t)
\end{array}\right.
$$

This has the form of problem (2.1) in Section 2. Our last assumption reads as
Assumption 3.2. The modified GKC holds for the linearized problem (3.6).
Under this assumption, Lemma 2.4 holds. Since now the boundary matrix in (3.6) is $B P^{-1}\left(U_{0}\right)=\left(B_{u}+B_{v} h_{u}, B_{v}\right)\left(U_{0}\right)$, the lemma can be stated as that the matrix

$$
\left(\begin{array}{cc}
\left(B_{u}+B_{v} h_{u}\right) R_{1}^{U} & \left(B_{v}-\left(B_{u}+B_{v} h_{u}\right) A_{11}^{-1} A_{12}\right) G_{1}  \tag{3.7}\\

\end{array}\right)\left(U_{0}\right)
$$

is invertible. Here $R_{1}^{U}$ is a right-unstable matrix of $A_{01}^{-1} A_{11}\left(U_{0}\right), L_{2}^{U}$ is a left-unstable matrix of $\Lambda_{2}^{-1} G_{2}$ with $\Lambda_{2}$ representing the nonzero eigenvalues of $\left(A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}\right)\left(U_{0}\right)$. The matrices $G_{1}$ and $G_{2}$ are defined by (2.38) and (2.39) with $S=A_{02} q_{v}\left(U_{0}\right)$.

### 3.2 Existence of boundary-layers

Following [27], we consider the Ansatz

$$
\binom{u_{\epsilon}}{v_{\epsilon}}(x, t)=\binom{\bar{u}}{\bar{v}}(x, t)+\binom{\tilde{u}}{\tilde{v}}(\xi, t)-\binom{\bar{u}}{\bar{v}}(0, t)
$$

with $\xi=x / \epsilon$. The outer solution $(\bar{u}, \bar{v})$ satisfies the equilibrium system

$$
\left\{\begin{array}{l}
\bar{u}_{t}+f(\bar{u}, h(\bar{u}))_{x}=0,  \tag{3.8}\\
\bar{v}=h(\bar{u}),
\end{array}\right.
$$

while the inner solution $(\tilde{u}, \tilde{v})$ solves

f(\tilde{u}, \tilde{v})_{\xi}=0  \tag{3.9}\\
g(\tilde{u}, \tilde{v})_{\xi}=q(\tilde{u}, \tilde{v}) .
\end{array}\right.
$$

Based on the matching principle, it was assumed that $(\bar{u}(0, t), \bar{v}(0, t))=(\tilde{u}(\infty, t), \tilde{v}(\infty, t))$.
From the first equation in (3.9) it follows that

f(\tilde{u}(\xi, t), \tilde{v}(\xi, t))=f(\tilde{u}(\infty, t), \tilde{v}(\infty, t)), \quad \forall \xi .
$$

Set $\tilde{u}_{\infty}=\tilde{u}(\infty, t), \mu:=\tilde{u}(\xi, t)-\tilde{u}_{\infty}$ and $\nu:=\tilde{v}(\xi, t)-h\left(\mu+\tilde{u}_{\infty}\right)$. Then we have

\varphi_{1}\left(\mu, \nu, \tilde{u}_{\infty}\right):=f\left(\mu+\tilde{u}_{\infty}, \nu+h\left(\mu+\tilde{u}_{\infty}\right)\right)-f\left(\tilde{u}_{\infty}, h\left(\tilde{u}_{\infty}\right)\right) \equiv 0 \tag{3.10}
\end{equation*}
$$

due to the relation $q(\tilde{u}(\infty, t), \tilde{v}(\infty, t))=0$. About this equation, we have
Proposition 3.1. There exists a unique function $\psi_{1}=\psi_{1}\left(\nu, \tilde{u}_{\infty}\right)$ defined in a neighborhood of $\left(0, u_{o}\right) \equiv(0, u(0,0))$, such that $\mu=\psi_{1}\left(\nu, \tilde{u}_{\infty}\right)$ solves (3.10) and satisfies

\begin{equation*}
\left.\frac{\partial \psi_{1}}{\partial \nu}\right|_{\left(0, u_{o}\right)}=-\left[\left(f_{u}+f_{v} h_{u}\right)^{-1} f_{v}\right]\left(u_{o}, h\left(u_{o}\right)\right),\left.\quad \frac{\partial \psi_{1}}{\partial \tilde{u}_{\infty}}\right|_{\left(0, u_{o}\right)}=0 \tag{3.11}
\end{equation*}
$$

Proof. A simple computation shows

$$
\left.\frac{\partial \varphi_{1}}{\partial \tilde{u}_{\infty}}\right|_{\left(0,0, u_{o}\right)}=0,\left.\quad \frac{\partial \varphi_{1}}{\partial \nu}\right|_{\left(0,0, u_{o}\right)}=f_{v}\left(u_{o}, h\left(u_{o}\right)\right),\left.\quad \frac{\partial \varphi_{1}}{\partial \mu}\right|_{\left(0,0, u_{o}\right)}=\left[f_{u}+f_{v} h_{u}\right]\left(u_{o}, h\left(u_{o}\right)\right) .
$$

Since $\left[f_{u}+f_{v} h_{u}\right]\left(u_{o}, h\left(u_{o}\right)\right)$ is invertible, we can apply the implicit function theorem to $\varphi_{1}=$ $\varphi_{1}\left(\mu, \nu, \tilde{u}_{\infty}\right)$ at $\left(0,0, u_{o}\right)$ to get the function $\psi_{1}\left(\nu, \tilde{u}_{\infty}\right)$ such that $\mu=\psi_{1}\left(\nu, \tilde{u}_{\infty}\right)$. Thus the relations in (3.11) immediately follow.

On the other hand, in terms of the new variables $\mu$ and $\nu$, the equation (3.9) can be rewritten as

\left(f_{u}+f_{v} h_{u}\right) \mu^{\prime}+f_{v} \nu^{\prime}=0,  \tag{3.12}\\
\left(g_{u}+g_{v} h_{u}\right) \mu^{\prime}+g_{v} \nu^{\prime}=\hat{S} \nu,
\end{array}\right.
$$

## A Appendix

## A. 1 Some details in the proof of Lemma 2.1

In this appendix, we show that the matrices $S_{00}(\xi, \eta)$ and $I_{n-r}+N_{1}(\xi, \eta)$ are invertible for any $\eta \geq 0$ and any $\xi$ with $R e \xi>0$, which are used in the proof of Lemma 2.1.

Notice that $-S_{00}=-P_{0}^{*}\left(\eta S-\xi A_{02}\right) P_{0}$ can be expressed in the form $A+i B$ with $A$ a symmetric positive definite matrix and $B$ a symmetric matrix. In order to show that $S_{00}$ is invertible, it suffices to prove

Proposition A.1. Let $A$ be a symmetric positive definite matrix and $B$ be a symmetric matrix. Then the complex matrix $A+i B$ is invertible.

\end{array}\right)\right|
$$

from the right, we obtain

$$
0=\left|\lambda\left(\begin{array}{ccc}
I & & \\
& I & \\
& & 0
\end{array}\right)-\left(\begin{array}{ccc}
-\xi A_{11}^{-1} A_{01} & \xi A_{11}^{-1} A_{01} N_{2} & \xi A_{11}^{-1} A_{01} \tilde{P}_{0} \\
N_{3} & N_{4}-N_{3} N_{2} & -N_{3} \tilde{P}_{0} \\
\xi \tilde{P}_{0}^{*} A_{01} & -\xi \tilde{P}_{0}^{*} A_{01} N_{2} & S_{00}-\xi \tilde{P}_{0}^{*} A_{01} \tilde{P}_{0}
\end{array}\right)\right|
$$

Recall from (2.22) that

$$
N_{2}=\tilde{P}_{2}-\tilde{P}_{0} S_{00}^{-1} S_{02}, \quad N_{3}=\xi \Lambda_{2}^{-1}\left(\tilde{P}_{2}^{*}-S_{20} S_{00}^{-1} \tilde{P}_{0}^{*}\right) A_{01}
$$

where $\tilde{P}_{2}:=A_{11}^{-1} A_{12} P_{2}$. Then we multiply the last determinant with

$$
\left|\left(\begin{array}{ccc}
A_{11} & & \\
& \Lambda_{2} & \\
& & I
\end{array}\right)\right|
$$

from the left to get

$$
\begin{aligned}
0= & \left\lvert\, \lambda\left(\begin{array}{ccc}
A_{11} & & \\
& \Lambda_{2} & \\
& & 0
\end{array}\right)-\left(\begin{array}{ccc}
0 & & \\
& \Lambda_{2} N_{4} & 0 \\
& 0 & S_{00}
\end{array}\right)\right. \\
& \left.-\xi\left(\begin{array}{ccc}
-A_{01} & A_{01} N_{2} & A_{01} \tilde{P}_{0} \\
\left(\tilde{P}_{2}^{*}-S_{20} S_{00}^{-1} \tilde{P}_{0}^{*}\right) A_{01} & -\left(\tilde{P}_{2}^{*}-S_{20} S_{00}^{-1} \tilde{P}_{0}^{*}\right) A_{01} N_{2} & -\left(\tilde{P}_{2}^{*}-S_{20} S_{00}^{-1} \tilde{P}_{0}^{*}\right) A_{01} \tilde{P}_{0} \\
\tilde{P}_{0}^{*} A_{01} & -\tilde{P}_{0}^{*} A_{01} N_{2} & -\tilde{P}_{0}^{*} A_{01} \tilde{P}_{0}
\end{array}\right) \right\rvert\,
\end{aligned}
$$

Moreover, by multiplying this determinant with

$$
\left|\left(\begin{array}{ccc}
I & 0 & 0 \\
0 & I & S_{20} S_{00}^{-1} \\
0 & 0 & I
\end{array}\right)\right| \text { and }\left|\left(\begin{array}{ccc}
I & 0 & 0 \\
0 & I & 0 \\
0 & S_{00}^{-1} S_{02} & I
\end{array}\right)\right|
$$

from the left and from the right respectively, we get

$$
0=\left|\lambda\left(\begin{array}{ccc}
A_{11} & & \\
& \Lambda_{2} & \\
& & 0
\end{array}\right)-\left(\begin{array}{ccc}
0 & & \\
& S_{22} & S_{20} \\
& S_{02} & S_{00}
\end{array}\right)-\xi\left(\begin{array}{ccc}
-A_{01} & A_{01} \tilde{P}_{2} & A_{01} \tilde{P}_{0} \\
\tilde{P}_{2}^{*} A_{01} & -\tilde{P}_{2}^{*} A_{01} \tilde{P}_{2} & -\tilde{P}_{2}^{*} A_{01} \tilde{P}_{0} \\
\tilde{P}_{0}^{*} A_{01} & -\tilde{P}_{0}^{*} A_{01} \tilde{P}_{2} & -\tilde{P}_{0}^{*} A_{01} \tilde{P}_{0}
\end{array}\right)\right| .
$$

Finally, we multiply the last determinant with

$$
\left|\left(\begin{array}{ccc}
I & 0 & 0 \\
0 & P_{2} & P_{0}
\end{array}\right)\right| \text { and }\left|\left(\begin{array}{cc}
I & 0 \\
0 & P_{2}^{*} \\
0 & P_{0}^{*}
\end{array}\right)\right|
$$

from the left and from the right to obtain

$$
\begin{aligned}
0= & \left\lvert\, \lambda\left(\begin{array}{cc}
A_{11} & 0 \\
0 & A_{22}-A_{12}^{*} A_{11}^{-1} A_{12}
\end{array}\right)-\eta\left(\begin{array}{ll}
0 & 0 \\
0 & S
\end{array}\right)+\xi\left(\begin{array}{cc}
0 & 0 \\
0 & A_{02}
\end{array}\right)\right. \\
& \left.+\xi\left(\begin{array}{cc}
A_{01} & -A_{01} A_{11}^{-1} A_{12} \\
-A_{12}^{*} A_{11}^{-1} A_{01} & A_{12}^{*} A_{11}^{-1} A_{01} A_{11}^{-1} A_{12}
\end{array}\right) \right\rvert\, \\
= & \left|\left(\begin{array}{cc}
I & 0 \\
-A_{12}^{*} A_{11}^{-1} & I
\end{array}\right)\left[\xi\left(\begin{array}{cc}
A_{01} & 0 \\
0 & A_{02}
\end{array}\right)+\lambda\left(\begin{array}{cc}
A_{11} & A_{12} \\
A_{12}^{*} & A_{22}
\end{array}\right)-\eta\left(\begin{array}{ll}
0 & 0 \\
0 & S
\end{array}\right)\right]\left(\begin{array}{cc}
I & -A_{11}^{-1} A_{12} \\
0 & I
\end{array}\right)\right|
\end{aligned}
$$

Consequently, we have

$$
\left|\xi\left(\begin{array}{cc}
A_{01} & 0 \\
0 & A_{02}
\end{array}\right)+\lambda\left(\begin{array}{cc}
A_{11} & A_{12} \\
A_{12}^{*} & A_{22}
\end{array}\right)-\eta\left(\begin{array}{ll}
0 & 0 \\
0 & S
\end{array}\right)\right|=0
$$

Now if the eigenvalue $\lambda$ is purely imaginary, the last matrix can be written in form of $A+i B$ with $A$ a symmetric positive definite matrix and $B$ a symmetric matrix. Then the last equation contradicts Proposition A.1. This completes the proof of Lemma 2.2.

## A. 3 A detail in Subsection 2.4

In this appendix, we show the fact used in Subsection 2.4 that the matrix $E\left(\xi^{\prime}, \eta^{\prime}\right)$ is uniformly bounded for any $\eta^{\prime} \geq 0$ and $\xi^{\prime}$ with $R e \xi^{\prime}>0$. Recall

$$
E\left(\xi^{\prime}, \eta^{\prime}\right)=\left(E_{1}\left(\xi^{\prime}, \eta^{\prime}\right), E_{2}\left(\xi^{\prime}, \eta^{\prime}\right)\right)=\left(-\xi^{\prime} S_{00}^{-1} P_{0}^{*} A_{12}^{*} A_{11}^{-1} A_{01}, \quad-S_{00}^{-1} S_{02}\right)
$$

defined in (2.25), where

$$
S_{00}\left(\xi^{\prime}, \eta^{\prime}\right)=\eta^{\prime}\left(P_{0}^{*} S P_{0}\right)-\xi^{\prime}\left(P_{0}^{*} A_{02} P_{0}\right), \quad S_{02}\left(\xi^{\prime}, \eta^{\prime}\right)=\eta^{\prime}\left(P_{0}^{*} S P_{2}\right)-\xi^{\prime}\left(P_{0}^{*} A_{02} P_{2}\right)
$$

are given in (2.16). Because $P_{0}^{*} A_{12}^{*} A_{11}^{-1} A_{01}$ is constant, we only need to show that $\xi^{\prime} S_{00}^{-1}$ and $S_{00}^{-1} S_{02}$ are uniformly bounded. When $\eta^{\prime}=0$, these two matrices are independent of $\xi^{\prime}$ and thereby uniformly bounded.

For $\eta^{\prime} \neq 0$, we have

$$
\begin{aligned}
\xi^{\prime} S_{00}^{-1} & =\left(\frac{\eta^{\prime}}{\xi^{\prime}}\left(P_{0}^{*} S P_{0}\right)-\left(P_{0}^{*} A_{02} P_{0}\right)\right)^{-1} \\
S_{00}^{-1} S_{02} & =\left(\left(P_{0}^{*} S P_{0}\right)-\frac{\xi^{\prime}}{\eta^{\prime}}\left(P_{0}^{*} A_{02} P_{0}\right)\right)^{-1} P_{0}^{*} S P_{2}-\left(\frac{\eta^{\prime}}{\xi^{\prime}}\left(P_{0}^{*} S P_{0}\right)-\left(P_{0}^{*} A_{02} P_{0}\right)\right)^{-1} P_{0}^{*} A_{02} P_{2} .
\end{aligned}
$$

Notice that $-P_{0}^{*} S P_{0}$ and $P_{0}^{*} A_{02} P_{0}$ are two symmetric positive definite matrices. Thus, it suffices to prove

Proposition A.2. Suppose $A$ and $B$ are symmetric positive definite matrices with constant coefficients, $a$ and $b$ are real numbers. Then the matrix

$$
(A+a B+i b B)^{-1}
$$

is uniformly bounded with respect to any $a \geq 0$ and $b \in(-\infty,+\infty)$.
Proof. Because of the relation

$$
A+a B+i b B=A^{1 / 2}\left(I+a\left(A^{-1 / 2} B A^{-1 / 2}\right)+i b\left(A^{-1 / 2} B A^{-1 / 2}\right)\right) A^{1 / 2}
$$

we may assume $A=I$. Since $I+a B$ is symmetric positive definite for $a>0$, we have

$$
\begin{aligned}
(I+a B+i b B)^{-1} & =(I+a B)^{-1 / 2}\left[I+i b(I+a B)^{-1 / 2} B(I+a B)^{-1 / 2}\right]^{-1}(I+a B)^{-1 / 2} \\
& \equiv(I+a B)^{-1 / 2}(I+i \tilde{B})^{-1}(I+a B)^{-1 / 2}
\end{aligned}
$$

where $\tilde{B}$ is again symmetric. Let $O$ be an orthonormal matrix such that $O^{*} \tilde{B} O=\tilde{\Lambda}_{B}$ with $\tilde{\Lambda}_{B}$ a real diagonal matrix. Then we have

$$
I+i \tilde{B}=O\left(I+i \tilde{\Lambda}_{B}\right) O^{*}
$$

and thereby the matrix $(I+i \tilde{B})^{-1}$ is uniformly bounded. Similarly, the matrix $(I+a B)^{-1 / 2}$ is uniformly bounded and hence the proof is complete.
